Sharp L^1 -convergence rates to the Barenblatt solutions for the compressible Euler equations with time-varying damping ^{*}

Abstract: We study the asymptotic behavior of compressible isentropic flow when the initial mass is finite and the friction varies with time, which is modeled by the compressible Euler equation with time-dependent damping. In this paper, we obtain the best L¹-convergence rates to date, for any $\gamma \in (1, +\infty)$ and $\nu \in [0, 1)$. Here, γ is the adiabatic gas exponent, and ν is the physical parameter in the damping term. The key to the analysis lies in a new perspective on the relationship between the density function and the Barenblatt solution of the porous medium equation, and finding the relevant lower bound for the case of γ < 2 is a tricky problem. Specialized to $\nu = 0$, these convergence rates also show an essential improvement over the original rates. Moreover, for all $\gamma \in (1, +\infty)$, the results in this work are the first to present a unified form of L^1 -convergence rates. Indeed, even for $\nu = 0$, as noted in 2011, "the current rate is difficult to improve with the current method". Our results are therefore an encouraging advancement.

Keywords: Convergence rates; Compressible Euler equations; Barenblatt solutions; Time-dependent damping.

1 Introduction

In this paper, we are concerned with the compressible Euler equations with frictional time-dependent damping in Euler coordinates as follows

$$
\begin{cases}\n\rho_t + (\rho u)_x = 0, \\
(\rho u)_t + (\rho u^2 + p(\rho))_x = -\frac{\alpha}{(1+t)^{\nu}}\rho u,\n\end{cases}
$$
\n(1.1)

with finite initial mass

$$
(\rho, u)(x, 0) = (\rho_0, u_0)(x), \quad \rho_0(x) \ge 0, \quad \int_{-\infty}^{+\infty} \rho_0(x) dx = M > 0,
$$
 (1.2)

where ρ, u , and p, denote the density, velocity, and pressure respectively. Since we study a polytropic perfect gas, the state equation of the fluid is given by

$$
p(\rho) = \kappa \rho^{\gamma},
$$

with $\kappa = \frac{(\gamma - 1)^2}{4\gamma}$, and $\gamma > 1$ is the adiabatic gas exponent. The damping term $-\frac{\alpha}{(1+i)}$ $\frac{\alpha}{(1+t)^{\nu}}\rho u$ with physical parameter $0 \leq \nu < 1$ has the time-dependent frictional effect, and $\alpha = \kappa =$ $\frac{(\gamma-1)^2}{4\gamma}$, which will simplify the form of the entropy functions used below (cf. [\[14,](#page-31-0) [17](#page-31-1)]). Also, we use momentum $m =: \rho u$ in what follows for simplicity.

When $\nu = 0$, the system [\(1.1\)](#page-1-0) is equivalent to the following decoupled system if taking time asymptotically,

\begin{cases}\n\bar{\rho}_t = (\bar{\rho}^\gamma)_{xx}, \\
\bar{m} = -(\bar{\rho}^\gamma)_x,\n\end{cases}
$$
\n(1.3)

where $(1.3)₁$ is the famous porous medium equation(PME), and $(1.3)₂$ is the Darcy's law, that is, the inertial terms in the momentum equation decay to zero faster than the other terms caused by the damping effect of the frictional force term (see Hsiao and Liu [\[10](#page-30-0)]). Later, in the pioneering work of [\[21\]](#page-31-2), Nishihara improved the decay rates by utilizing detailed energy estimates when the initial data are small perturbation around $\bar{\rho}$ and thus away from vacuum. For more works with small initial data, we refer to [\[22,](#page-31-3) [25,](#page-31-4) [31\]](#page-32-0). By using the vanishing viscosity method, Zhu [\[32\]](#page-32-1) studied the asymptotic behavior of weak entropy solution. As for the properties of the solutions near the vacuum, we refer the reader to [\[15](#page-31-5), [18](#page-31-6), [19](#page-31-7)]. Then, Huang, Marcati and Pan [\[13](#page-31-8)] obtained the decay rates of the weak entropy solutions of the system [\(1.1\)](#page-1-0) to the corresponding Barenblatt solutions [\(1.3\)](#page-1-1) in L^2 or L^{γ} space for any $\gamma > 1$. Later, in [\[14](#page-31-0)], Huang, Pan and Wang studied the asymptotic behavior in L^1 space with $1 < \gamma < 3$ and obtained

$$
\|(\rho-\bar{\rho})(\cdot,t)\|_{L^1}\leq C(1+t)^{-\frac{1}{4(\gamma+1)}+\varepsilon}.
$$

Then, the convergence rates were improved to

$$
\|(\rho-\bar{\rho})(\cdot,t)\|_{L^1}\leq C(1+t)^{-\frac{1}{(\gamma+1)^2}+\varepsilon},
$$

for $\gamma \geq 2$ in [\[8](#page-30-1)]. For Euler equation or Euler-Poisson equation with friction, we refer to [\[1,](#page-30-2) [7](#page-30-3)]. For compressible Euler equations with physical vacuum free boundaries, see [\[29,](#page-31-9) [30](#page-32-2)],

When $0 < \nu < 1$, the system [\(1.1\)](#page-1-0) becomes the compressible Euler equations with degenerate linear time-dependent damping. In view of Darcy's law, the solutions of [\(1.1\)](#page-1-0) should be time-asymptotically equivalent to the Barenblatt solutions of the following system

$$
\begin{cases}\n\bar{\rho}_t = (1+t)^{\nu} (\bar{\rho}^{\gamma})_{xx}, \\
\bar{m} = -(1+t)^{\nu} (\bar{\rho}^{\gamma})_x,\n\end{cases}
$$
\n(1.4)

where $(1.4)₁$ is the PME with time-dependent diffusion and $(1.4)₂$ is the Dracy's law. Recently, there have been various works for the compressible Euler equations with time-dependent damping in the literature; see [\[5,](#page-30-4) [12](#page-30-5), [27,](#page-31-10) [33](#page-32-3)]. Pan [\[23](#page-31-11), [24\]](#page-31-12) proved that $\nu =$ $1, \alpha = 2$ is the critical threshold to separate the global existence and non-existence of $C¹$ solutions in one dimension. For more blow-up phenomena, we refer to [\[3,](#page-30-6) [11](#page-30-7), [26\]](#page-31-13). Also, Cui-Yin-Zhang-Zhu [\[4](#page-30-8)] and Li-Li-Mei-Zhang [\[16](#page-31-14)] considered independently the convergence of smooth solutions with $0 \leq \nu < 1$ and $\alpha > 0$.

In [\[9](#page-30-9)], for $1 < \gamma < 3$, the authors proved that any L^{∞} weak entropy solution of problem $(1.1)-(1.2)$ $(1.1)-(1.2)$ $(1.1)-(1.2)$ converges to the Barenblatt's solution of equation (1.4) with the same mass in L^1 , and at the rate

||(\rho - \bar{\rho}(\cdot, t))||_{L^1} \le C(1+t)^{-\alpha(\varepsilon)},
$$

with

$$
\alpha(\varepsilon) = \begin{cases} \frac{\nu+1}{4(\gamma+1)} - \varepsilon, & \nu \in \left(0, \frac{\gamma}{\gamma+2}\right], \\ \frac{1-\nu}{4} - \varepsilon, & \nu \in \left[\frac{\gamma}{\gamma+2}, 1\right). \end{cases}
$$

At the same time, the authors in [\[6\]](#page-30-10) obtained

$$
||(\rho - \bar{\rho}(\cdot, t))||_{L^{1}} \leq C(1+t)^{k(\epsilon)},
$$

with

$$
k(\epsilon) = \begin{cases} -\frac{\gamma^2 - \gamma - 1 - \nu(\gamma^2 + \gamma - 1)}{(\gamma + 1)(2\gamma - 1)} + \epsilon, & \text{if } \frac{1 + \sqrt{5}}{2} < \gamma \le 2, \quad 0 \le \nu < \frac{\gamma^2 - \gamma - 1}{\gamma^2 + \gamma - 1}, \\ -\frac{1 - \nu(2\gamma + 1)}{(\gamma + 1)^2} + \epsilon, & \text{if } \gamma \ge 2, \qquad 0 \le \nu < \frac{1}{2\gamma + 1}. \end{cases}
$$

In this paper, we intend to study the asymptotic behavior of L^{∞} weak entropy solutions for the compressible Euler equations with time-dependent damping. By using elaborate energy estimates and relative weak entropies, we will obtain better convergence results for weak entropy solutions of [\(1.1\)](#page-1-0) to the corresponding Barenblatt solutions of [\(1.4\)](#page-2-0) with the same finite initial mass. We will establish L^{γ} estimate for any $\gamma \geq 2$ and $0 \leq \nu < 1$ and L^1 estimate for any $\gamma > 1$ and $0 \leq \nu < 1$, which are better compared with those in [\[6,](#page-30-10) [8](#page-30-1), [9,](#page-30-9) [14\]](#page-31-0). Furthermore, it is worth noting that our results present for the first time a uniform form of L^1 estimate over the entire $(1, +\infty)$ range of γ . Indeed, even for $\nu = 0$ it is not easy to make some improvements, and as pointed out in [\[14](#page-31-0)], "the current rate is difficult to improve with the current method". Our results are therefore an encouraging advancement.

The outline of the paper is as follows. In section 2, we give a quick review of some information on Barenblatt's solution, and state our main result, explaining the basic proof ideas. Then, in section 3, we recall or derive some important lemmas. Section 4 is devoted to extending the related results of [\[9\]](#page-30-9) about some key intermediate estimates. Finally, we prove our main result in section 5.

2 Preliminaries and main result

Throughout this paper, $||\cdot||_{L^p}$ stands for $L^p(\mathbf{R}) \ (1 \leq p \leq +\infty)$. In particular, we use $||\cdot||$ instead of $\|\cdot\|_2$ and denote $\int_{-\infty}^{+\infty} f(x,t)dx = \int f(x,t)dx$.

Since we study the large time behavior of global solutions to the system [\(1.1\)](#page-1-0) with vacuum, it is suitable to consider L^{∞} weak entropy solutions. Next, we state the definition of L^{∞} weak entropy solutions for the system $(1.1)-(1.2)$ $(1.1)-(1.2)$ (cf. [\[6,](#page-30-10) [9](#page-30-9)]).

Definition 2.1. The functions $(\rho, m)(x, t) \in L^{\infty}$ are called an entropy solution of [\(1.1\)](#page-1-0)-[\(1.2\)](#page-1-2), if for any nonnegative test function $\phi \in \mathcal{D}(\mathbf{R} \times \mathbf{R}_{+})$, it holds that

$$
\begin{cases}\n\int_0^t \int_{-\infty}^{+\infty} (\rho \phi_t + m \phi_x) dx ds + \int_{-\infty}^{+\infty} \rho_0(x) \phi(x, 0) dx = 0, \\
\int_0^t \int_{-\infty}^{+\infty} \left\{ m \phi_t + \left(\frac{m^2}{\rho} + \rho^{\gamma} \right) \phi_x - \frac{m}{(1+s)^{\lambda}} \phi \right\} dx ds + \int_{-\infty}^{+\infty} m_0(x) \phi(x, 0) dx = 0, \\
\int_0^t \int_{-\infty}^{+\infty} \left(\eta \phi_t + q \phi_x - \frac{m}{(1+s)^{\lambda}} \eta \phi \right) dx ds + \int_{-\infty}^{+\infty} \eta(x, 0) \phi(x, 0) dx \ge 0,\n\end{cases}
$$

where (η, q) is any weak convex entropy-flux pair $(\eta(\rho, m), q(\rho, m))$ satisfying

$$
\nabla q = \nabla \eta \nabla f, \ f = \left(m, \frac{m^2}{\rho} + \kappa \rho^{\gamma}\right)^t, \ \eta(0, 0) = 0.
$$

Next, we recall some results on the entropies available for [\(1.1\)](#page-1-0). According to [\[17](#page-31-1)], all

weak entropies of [\(1.1\)](#page-1-0) are given by the following formula

$$
\eta(\rho, m) = \int g(\xi) \chi(\xi; \rho, u) d\xi = \rho \int_{-1}^{1} g \left(u + z \rho^{\theta} \right) \left(1 - z^2 \right)^{\lambda} dz,
$$

$$
q(\rho, m) = \int g(\xi) (\theta \xi + (1 - \theta) u) \chi(\xi; \rho, u) d\xi
$$

$$
= \rho \int_{-1}^{1} g \left(u + z \rho^{\theta} \right) \left(u + \theta z \rho^{\theta} \right) \left(1 - z^2 \right)^{\lambda} dz,
$$
 (2.1)

where $m = \rho u, \theta = \frac{\gamma - 1}{2}, \lambda = \frac{3 - \gamma}{2(\gamma - 1)}, g(\xi)$ is any smooth function of ξ , and

$$
\chi(\xi; \rho, u) = (\rho^{\gamma - 1} - (\xi - u)^2)_+^{\lambda}.
$$

The two common choices of $g(\xi)$ are $g(\xi) = \frac{1}{2} |\xi|^2$ and $g(\xi) = |\xi|^{\frac{2\gamma}{\gamma - 1}}$.

Then, we give some background information on the Barenblatt solutions and consider

$$
\begin{cases} \bar{\rho}_t = (1+t)^{\nu} (\bar{\rho}^{\gamma})_{xx}, \\ \bar{\rho}(x,-1) = M\delta(x), \quad M > 0, \end{cases}
$$
 (2.2)

with $0 \leq \nu < 1$ and $\gamma > 1$. It is shown in [\[6,](#page-30-10) [9\]](#page-30-9) that [\(2.2\)](#page-4-0) admits a unique solution given by

$$
\bar{\rho}(x,t) = (1+t)^{-\frac{1+\nu}{\gamma+1}} \left(A_0 - B_0 x^2 (1+t)^{-\frac{2(1+\nu)}{\gamma+1}} \right)_+^{\frac{1}{\gamma-1}},\tag{2.3}
$$

where $(f)_{+} = \max\{0, f\},\,$

$$
B_0 = \frac{(\gamma - 1)(1 + \nu)}{2\gamma(\gamma + 1)}, \quad \text{and} \quad A_0^{\frac{\gamma + 1}{2(\gamma - 1)}} = M\sqrt{B_0} \left(\int_{-1}^1 (1 - y^2)^{1/(\gamma - 1)} dy\right)^{-1}.
$$

As a result, the velocity is given by

$$
\bar{u}(x,t) = \frac{1+\nu}{(\gamma+1)(1+t)}x, \, |x| < \sqrt{\frac{A_0}{B_0}}(1+t)^{\frac{1+\nu}{\gamma+1}}.\tag{2.4}
$$

Now, we state our main result.

Theorem 2.2. Suppose that $\rho_0(x) \in L^1(\mathbf{R}) \cap L^{\infty}(\mathbf{R}), u_0(x) \in L^{\infty}(\mathbf{R})$ and

$$
M = \int_{-\infty}^{+\infty} \rho_0(x) dx > 0, \quad \rho_0(x) \ge 0.
$$

Let $1 < \gamma < +\infty$, $0 \le \nu < 1$, and (ρ, m) be an L^{∞} entropy solution of the Cauchy problem [\(1.1\)](#page-1-0)-[\(1.2\)](#page-1-2). Let $\bar{\rho}$ be the Barenblatt's solution of porous medium equation [\(1.3\)](#page-1-1) with mass M and $\bar{m} = -(\bar{\rho}^{\gamma})_x$. Define

$$
y(x,t) = -\int_{-\infty}^{x} (\rho - \bar{\rho})(r,t) dr,
$$

and let $y(x, 0) \in L^2(\mathbf{R})$. If $2 \le \gamma < +\infty$, then for any $\varepsilon > 0$ and $t > 0$,

$$
\|(\rho - \bar{\rho})(\cdot, t)\|_{L^{\gamma}}^{\gamma} \le C_{\varepsilon} (1+t)^{-\mu(\varepsilon)},\tag{2.5}
$$

where

$$
\mu(\varepsilon) := \begin{cases}\n\frac{\gamma^2 + \gamma - 1}{(\gamma + 1)^2} (1 + \nu) + \varepsilon, & \nu \in \left[0, \frac{\gamma}{\gamma + 2}\right], \\
\frac{2\gamma - 1 - \nu}{\gamma + 1} + \varepsilon, & \nu \in \left[\frac{\gamma}{\gamma + 2}, 1\right).\n\end{cases}
$$
\n(2.6)

Furthermore, for any $\gamma > 1$, it holds that

$$
\|(\rho - \bar{\rho})(\cdot, t)\|_{L^1} \le C_{\varepsilon}(1+t)^{-k(\varepsilon)},\tag{2.7}
$$

with

$$
k(\varepsilon) := \begin{cases} \frac{\gamma}{2(\gamma+1)^2} (1+\nu) - \varepsilon, & \nu \in \left[0, \frac{\gamma}{\gamma+2}\right],\\ \frac{\gamma}{2(\gamma+1)} (1-\nu) - \varepsilon, & \nu \in \left[\frac{\gamma}{\gamma+2}, 1\right). \end{cases}
$$
(2.8)

Remark 2.3. It is shown in [\[6](#page-30-10)] that

$$
||(\rho - \bar{\rho}(\cdot, t))||_{L^1} \le C(1+t)^{k_1(\epsilon)},
$$

with

$$
k_1(\epsilon) := \begin{cases} -\frac{\gamma^2 - \gamma - 1 - \nu(\gamma^2 + \gamma - 1)}{(\gamma + 1)(2\gamma - 1)} + \epsilon, & \text{if } \frac{1 + \sqrt{5}}{2} < \gamma \le 2, \quad 0 \le \nu < \frac{\gamma^2 - \gamma - 1}{\gamma^2 + \gamma - 1}, \\ -\frac{1 - \nu(2\gamma + 1)}{(\gamma + 1)^2} + \epsilon, & \text{if } \gamma \ge 2, \qquad 0 \le \nu < \frac{1}{2\gamma + 1}, \end{cases}
$$

and in [\[9\]](#page-30-9) for $1 < \gamma < 3$ that

$$
||(\rho - \bar{\rho}(\cdot, t))||_{L^1} \le C(1+t)^{-\alpha_1(\varepsilon)},
$$

with

$$
\alpha_1(\varepsilon) = \begin{cases} \frac{\nu+1}{4(\gamma+1)} - \varepsilon, & \nu \in \left(0, \frac{\gamma}{\gamma+2}\right], \\ \frac{1-\nu}{4} - \varepsilon, & \nu \in \left[\frac{\gamma}{\gamma+2}, 1\right). \end{cases}
$$

It is easy to check that $\alpha_1(\varepsilon) < k_1(\varepsilon)$,

$$
\frac{\gamma^2 - \gamma - 1}{\gamma^2 + \gamma - 1} < \frac{\gamma}{\gamma + 2}, \text{ and } \frac{1}{2\gamma + 1} < \frac{\gamma}{\gamma + 2},
$$

which gives

$$
k_1(\epsilon) < \frac{\gamma}{2(\gamma+1)^2}(1+\nu) + \varepsilon.
$$

This means that the L^1 convergence rates in Theorem [2.2](#page-4-1) are better. Furthermore, it is worth mentioning that the L^1 convergence estimate in Theorem [2.2](#page-4-1) is valid for any $1 < \gamma < +\infty$.

Remark 2.4. When $\nu = 0$, it is shown in [\[8\]](#page-30-1) for $\gamma \geq 2$ and [\[14](#page-31-0)] for $1 < \gamma < 3$ that $\|(\rho - \overline{\rho})(\cdot, t)\|_{L^1} \leq C(1+t)^{-\frac{1}{(\gamma+1)^2}+\varepsilon}$ and $\|(\rho - \overline{\rho})(\cdot, t)\|_{L^1} \leq C(1+t)^{-\frac{1}{4(\gamma+1)}+\varepsilon}$ respectively. It is easy to check that $\frac{\gamma}{2(\gamma+1)^2} > \frac{1}{4(\gamma+1)}$ when $\gamma > 1$ and $\frac{\gamma}{2(\gamma+1)^2} > \frac{1}{(\gamma+1)^2}$ when $\gamma \geq 2$, which means that the decay rates in Theorem [2.2](#page-4-1) are better than the previous ones.

Now, we explain the basic proof ideas. We will follow the strategy in $[6, 9]$ $[6, 9]$, employing the entropy inequalities and time-weighted entropy estimates with specific index. An important part of the proof process is to extend key intermediate estimates from [\[9,](#page-30-9) Lemmas 3.8 and 3.9 (with $1 < \gamma < 3$) to $1 < \gamma < +\infty$ (Theorem [4.6\)](#page-18-0). This will be realized by Taylor's formula, the energy inequality and in-depth analysis of η (defined in Lemma [4.1\)](#page-14-0).

For $\gamma \geq 2$, we choose the mechanical energy(see [\[6,](#page-30-10) [9\]](#page-30-9)),

$$
\eta = \frac{1}{2} \frac{m^2}{\rho} + \frac{\kappa}{\gamma - 1} \rho^{\gamma},
$$

which measures the L^{γ} norm while the entropy inequality measures the $L^{\gamma+1}$ norm in density. To overcome the mismatch between the exponents, we find the relationship between

$$
\rho^{\gamma+1} - \bar{\rho}^{\gamma+1} - (\gamma+1)\bar{\rho}^{\gamma}(\rho-\bar{\rho}) \text{ and } \rho^{\gamma} - \bar{\rho}^{\gamma} - \gamma\bar{\rho}^{\gamma-1}(\rho-\bar{\rho});
$$

see Lemma [3.1.](#page-7-0) As a result, we can obtain the decay rates of the relative weak entropy η_* (Theorem [5.2\)](#page-21-0), by making use of the relative entropy inequality and time-weighted entropy estimates.

For the L^1 estimate with $1 < \gamma < +\infty$, the case $\gamma \geq 2$ can be handled by Lemma [3.2.](#page-9-0) However, for $1 < \gamma < 2$,

$$
C|\rho - \bar{\rho}|^2 \leq \rho^\gamma - \bar{\rho}^\gamma - \gamma \bar{\rho}^{\gamma - 1}(\rho - \bar{\rho}) \leq C'|\rho - \bar{\rho}|^\gamma,
$$

which means that Lemma [3.2](#page-9-0) is not valid, and the index 2 of $|\rho - \bar{\rho}|^2$ is not suitable. Hence, we should seek suitable lower bound of

$$
\rho^{\gamma} - \bar{\rho}^{\gamma} - \gamma \bar{\rho}^{\gamma - 1} (\rho - \bar{\rho}),
$$

which is quite difficult. By a careful decomposition of the region, we are able to overcome this difficulty; see Lemma [3.3](#page-9-1) below.

3 Some lemmas and priori estimates

In this section, we state or prove some auxiliary results, which are important for proving our main result.

Lemma 3.1. Let $1 < \gamma < +\infty$, and $0 \le \rho$, $\bar{\rho} \le C$. Then, there exists a constant $c > 0$, such that

$$
\rho^{\gamma+1} - \bar{\rho}^{\gamma+1} - (\gamma+1)\bar{\rho}^{\gamma}(\rho-\bar{\rho}) \ge c(\rho^{\gamma} - \bar{\rho}^{\gamma} - \gamma\bar{\rho}^{\gamma-1}(\rho-\bar{\rho}))^{\frac{\gamma+1}{\gamma}}.
$$
 (3.1)

Proof. When $\bar{\rho} = 0$, [\(3.1\)](#page-7-1) is true for any $0 < c \le 1$. For $\rho = 0$, (3.1) becomes $\gamma \bar{\rho}^{\gamma+1} \ge$ $c(\gamma - 1)^{\frac{\gamma + 1}{\gamma}} \bar{\rho}^{\gamma + 1}$, and it is equivalent to proving that $\frac{\gamma}{\gamma}$ $\frac{\gamma}{(\gamma-1)^{\frac{\gamma+1}{\gamma}}}$, has a positive lower bound, which is guaranteed by $\gamma < +\infty$.

Now, assume $\bar{\rho} \neq 0, \rho \neq 0$. Then $\bar{\rho} > 0$. Notice that [\(3.1\)](#page-7-1) is equivalent to

$$
\left(\frac{\rho}{\bar{\rho}}\right)^{\gamma+1} - 1 - (\gamma + 1)\left(\frac{\rho}{\bar{\rho}} - 1\right) \ge c \left[\left(\frac{\rho}{\bar{\rho}}\right)^{\gamma} - 1 - \gamma \left(\frac{\rho}{\bar{\rho}} - 1\right) \right]^{\frac{\gamma+1}{\gamma}}.
$$

Set $\frac{\rho}{\overline{\rho}} = x$ and

$$
f(x) = x^{\gamma+1} - 1 - (\gamma + 1)(x - 1) - c[x^{\gamma} - 1 - \gamma(x - 1)]^{\frac{\gamma+1}{\gamma}};
$$

it is obvious that $f(1) = 0$ and

$$
\frac{f'(x)}{\gamma+1} = x^{\gamma} - 1 - \frac{c}{\gamma} \left[x^{\gamma} - 1 - \gamma(x-1) \right]^{\frac{1}{\gamma}} (\gamma x^{\gamma-1} - \gamma)
$$

$$
= x^{\gamma} - 1 - c \left[x^{\gamma} - 1 - \gamma(x-1) \right]^{\frac{1}{\gamma}} (x^{\gamma-1} - 1).
$$

Next, we claim that there exists $0 < c \leq 1$, such that $f'(x) \leq 0, \forall x \in (0,1)$, and $f'(x) \geq 0, \forall x \in (1, +\infty)$. That is,

f(x) \ge f(1) = 0, \quad \forall x \in [0, +\infty),
$$

which will conclude the proof. To this end, we set

\lim_{x \to 1^{+}} \frac{x^{\gamma} - 1}{[x^{\gamma} - 1 - \gamma(x - 1)]^{\frac{1}{\gamma}} (x^{\gamma - 1} - 1)} = \lim_{x \to 1^{+}} \frac{\gamma x}{[x^{\gamma} - 1 - \gamma(x - 1)]^{\frac{1}{\gamma}} (\gamma - 1)x} = +\infty,
$$

due to

$$
[x^{\gamma} - 1 - \gamma(x - 1)]^{\frac{1}{\gamma}} \to 0
$$
, as $x \to 1^+$.

In addition,

$$
\lim_{x \to +\infty} h(x) = \lim_{x \to +\infty} \frac{1 - \frac{1}{x^{\gamma}}}{\left[1 - \frac{1}{x^{\gamma}} - \gamma \left(\frac{1}{x^{\gamma - 1}} - \frac{1}{x^{\gamma}}\right)\right]^{\frac{1}{\gamma}} \left(1 - \frac{1}{x^{\gamma - 1}}\right)} = 1.
$$

Hence, there exist $0 < \delta < 1$ and $X > 2$ such that, when $x \in (1, 1 + \delta)$ or $x > X$,

h(x) \ge \frac{1}{2}.
$$

When $x \in [1 + \delta, X]$, $\min_{x \in [1 + \delta, X]} h(x) = h(x_0) > 0$, since $h(x)$ is a continuous function. In conclusion, for any $x \in (1, +\infty)$, $h(x) \ge \min\{h(x_0), \frac{1}{2}\}$ $\frac{1}{2}$.

Case $B: x \in (0,1)$.

In this case, $x^{\gamma-1} - 1 < 0$,

\lim_{x \to 1^{-}} \frac{x^{\gamma} - 1}{[x^{\gamma} - 1 - \gamma(x - 1)]^{\frac{1}{\gamma}} (x^{\gamma - 1} - 1)} = \lim_{x \to 1^{-}} \frac{\gamma x}{[x^{\gamma} - 1 - \gamma(x - 1)]^{\frac{1}{\gamma}} (\gamma - 1) x} = +\infty,
$$

and

\lim_{x \to 0^+} \frac{x^{\gamma} - 1}{[x^{\gamma} - 1 - \gamma(x - 1)]^{\frac{1}{\gamma}} (x^{\gamma - 1} - 1)} = (\gamma - 1)^{-\frac{1}{\gamma}}.
$$

Hence, there exists $0 < \delta_1 < \frac{1}{4}$, such that when $x \in (1 - \delta_1, 1)$ or $x \in (0, \delta_1)$,

h(x) \ge \frac{1}{2}(\gamma - 1)^{-\frac{1}{\gamma}}.

If $x \in [\delta_1, 1 - \delta_1]$, we have, similarly to *Case A*,

Lemma 3.2. [\[13](#page-31-8), [14](#page-31-0)] Assume $0 \le \rho, \bar{\rho} \le C$ and $\gamma > 1$. Then there exist two positive $constants\ d_1\ and\ d_2\ such\ that$

Hence, we give a lemma to roughly describe the lower bound of $\rho^{\gamma} - \bar{\rho}^{\gamma} - \gamma \bar{\rho}^{\gamma-1}(\rho - \bar{\rho})$ for $\gamma \in (1, 2)$, which is essentially important in the proof of [\(2.7\)](#page-5-0). **Lemma 3.3.** Let $1 < \gamma < 2$, and $0 \le \rho$, $\bar{\rho} \le C$. Then, there exist two positive constants c_1 and c_2 , such that

(1). If $\rho = 0$, or $\bar{\rho} = 0$, or $|\rho - \bar{\rho}| \ge \frac{1}{2}\bar{\rho}$, then

c_1|\rho - \bar{\rho}|^{\gamma} \le \rho^{\gamma} - \bar{\rho}^{\gamma} - \gamma \bar{\rho}^{\gamma - 1}(\rho - \bar{\rho}).\tag{3.2}
$$

(2). If $\rho \neq 0$, $\bar{\rho} \neq 0$ and $|\rho - \bar{\rho}| < \frac{1}{2}$ $rac{1}{2}\bar{\rho}$, then

c_2\bar{\rho}^{\gamma-2}|\rho-\bar{\rho}|^{\gamma} \leq \rho^{\gamma}-\bar{\rho}^{\gamma}-\gamma\bar{\rho}^{\gamma-1}(\rho-\bar{\rho}). \tag{3.3}

Proof. To begin with, we prove [\(3.2\)](#page-9-2). When $\rho = 0$, (3.2) is true for any $0 < c_1 \leq \gamma - 1$. When $\bar{\rho} = 0$, [\(3.2\)](#page-9-2) is true for any $0 < c_1 \leq 1$. Now, assume $\rho \neq 0$, $\bar{\rho} \neq 0$. Hence, $\bar{\rho} > 0$. Notice [\(3.2\)](#page-9-2) is equivalent to

It is obvious that $x \geq \frac{3}{2}$ $\frac{3}{2}$ or $0 < x \leq \frac{1}{2}$ $\frac{1}{2}$ by $|\rho - \bar{\rho}| \ge \frac{1}{2}\bar{\rho}$ and $\rho \ne 0$, $\bar{\rho} \ne 0$. Then, we divide into two cases.

Case I : $x \geq \frac{3}{2}$. Since

Case $II: 0 < x \leq \frac{1}{2}$ $\frac{1}{2}$. In this case,

\geq \frac{\gamma(\gamma - 1)}{2} \left(\frac{3}{2}\bar{\rho} + \bar{\rho}\right)^{\gamma - 2} |\rho - \bar{\rho}|^2.
$$

Hence, [\(3.3\)](#page-9-3) holds with

c_2 = \frac{\gamma(\gamma - 1)}{2} \left(\frac{2}{5}\right)^{2-\gamma} > 0.
$$

Next, we recall the invariant region theory for L^{∞} weak entropy solution to system $(1.1)-(1.2)$ $(1.1)-(1.2)$ $(1.1)-(1.2)$, which was proved in [\[9](#page-30-9)].

\leq C \int_{-\sqrt{\frac{A_0}{B_0}}}^{\sqrt{\frac{A_0}{B_0}}} (1+t)^{-\frac{1+\nu}{\gamma+1}\beta_1 p} (1+t)^{-\frac{\gamma-\nu}{\gamma+1}p\beta_2} \left[\left(A_0 - B_0 \xi^2 \right)_+ \right]^{\frac{\beta_1 p}{\gamma-1}} \xi^{p\beta_2} (1+t)^{\frac{1+\nu}{\gamma+1}} d\xi
$$
\n
$$
\leq C (1+t)^{-\frac{p[(1+\nu)\beta_1 + (\gamma-\nu)\beta_2] - (1+\nu)}{r+1}},
$$

where the last inequality is from

$$
\int_{-\sqrt{\frac{A_0}{B_0}}}^{\sqrt{\frac{A_0}{B_0}}} \left[(A_0 - B_0 \xi^2)_+ \right]^{\frac{\beta_1 p}{\gamma - 1}} \xi^{p\beta_2} d\xi \le C \int_{-1}^1 \left[(A_0 - A_0 \tau^2)_+ \right]^{\frac{\beta_1 p}{\gamma - 1}} \sqrt{\frac{A_0}{B_0}} d\tau
$$

= $C \int_0^1 (1 - \tau)^{\frac{\beta_1 p}{\gamma - 1}} (1 + \tau)^{\frac{\beta_1 p}{\gamma - 1}} d\tau$
 $\le C \int_0^1 (1 - \tau)^{\frac{\beta_1 p}{\gamma - 1}} d\tau \le C,$

by $p\beta_2 \geq 0$, $\sqrt{\frac{A_0}{B_0}}\tau = \xi$, and [\(3.8\)](#page-12-0). Hence, we can obtain [\(3.9\)](#page-12-1). Particularly,

&\leq C \int_{-\sqrt{\frac{A_{0}}{B_{0}}}}^{\sqrt{\frac{A_{0}}{B_{0}}}}(1+t)^{-\frac{(1+\nu)\delta p}{\gamma+1}}(1+t)^{-\frac{p(2\gamma+1-\nu)}{\gamma+1}} \left[(A_{0}-B_{0}\xi)_{+}\right]^{\frac{\delta p}{\gamma-1}} \xi^{p}(1+t)^{\frac{1+\nu}{\gamma+1}} d\xi \\
&\leq C(1+t)^{-\frac{p[\delta(1+\nu)+2\gamma+1-\nu]-(1+\nu)}{\gamma+1}},\n\end{split}

from which we complete the proof of [\(3.11\)](#page-12-3).

4 Extension of key intermediate estimates

In this section, we are going to extend the results in [\[9](#page-30-9), Lemmas 3.8 and 3.9] (with $\gamma \in (1,3)$) to $\gamma \in (1,+\infty)$. In [\[9](#page-30-9)], the authors used the theory of divergence-measure fields (see Chen and Frid [\[2\]](#page-30-11)), [\(3.7\)](#page-11-3) and the following two entropy inequalities

where

\eta_e = \frac{\rho}{2} \int_{-1}^1 \left| u + z \rho^{\theta} \right|^2 \left(1 - z^2 \right)^{\lambda} dz = \frac{1}{2} \frac{m^2}{\rho} + \frac{\kappa}{\gamma - 1} \rho^{\gamma},
$$

and

$$

and

A_m m \ge 3A(\rho, m) \ge 0. \tag{4.4}

In addition, they make use of

and obtain

where C_1 and C_2 are defined in [\(4.3\)](#page-13-0), and $\{\cdots\}_x$ denotes terms which vanish after integrating over R.

According to the theory of divergence-measure fields, [\(3.7\)](#page-11-3) and [\(4.1\)](#page-13-1) are the same in both cases, and hence we only need to consider (4.2) , (4.4) and (4.5) . For this, we state and give two lemmas. The first one is the classical Taylor's formula.

= C_{1} \rho^{\gamma+1} + \frac{2\gamma(\gamma+1)}{(\gamma-1)^{2}} \rho^{2} u^{2} \int_{-1}^{1} \int_{0}^{1} (1 - s) \left| s \frac{u}{\rho^{\theta}} + z \right|^{\frac{2}{\gamma-1}} (1 - z^{2})^{\lambda} ds dz,

= \frac{2s}{\gamma - 1} \left[\int_{sa - 1}^{0} \frac{|v|^{\frac{2}{\gamma - 1}}}{v} (1 - (v - sa)^2)^{\lambda} dv + \int_{0}^{1 + sa} v^{\frac{3 - \gamma}{\gamma - 1}} (1 - (v - sa)^2)^{\lambda} dv \right]
$$
\n

= \frac{2s}{\gamma - 1} \left[- \int_{0}^{1 - sa} v^{\frac{3 - \gamma}{\gamma - 1}} (1 - (v + sa)^2)^{\lambda} dv + \int_{0}^{1 + sa} v^{\frac{3 - \gamma}{\gamma - 1}} (1 - (v - sa)^2)^{\lambda} dv \right]

\geq 0,

where the last inequality is from

1 - (v - sa)^2 \ge 1 - (v + sa)^2,

for any $v \in [0, 1 - sa]$ and $s \ge 0$. Hence, $h(a) \ge h(0) = \frac{(\gamma - 1)^2}{\gamma(\gamma + 1)}C_2$.

\frac{4\gamma(\gamma+1)}{(\gamma-1)^{3}} u^{2}m \int_{-1}^{1} \int_{0}^{1} (1-s)s \frac{|su+z\rho^{\theta}|^{\frac{2}{\gamma-1}}}{su+z\rho^{\theta}} (1-z^{2})^{\lambda} ds dz.

Comparing this with [\(4.8\)](#page-16-0) gives $B_m m \geq 2B(\rho, m)$. Hence, we only need to show the nonnegativity of the last term on the right-side of [\(4.9\)](#page-16-1).

Remark 4.3. In Lemma [4.2,](#page-14-4) we only obtain $B_m m \geq 2B(\rho, m) \geq 0$. Actually, it does not matter whether the coefficient is 2 or 3. It just needs to be larger than 1. In addition, we can obtain [\(4.5\)](#page-14-2) with $A_m m$ replaced by $B_m m$, since C_1 and C_2 are the same in both cases.

Before making the extension, we recall Lemma 3.7 of [\[9](#page-30-9)].

Next, we recall Lemmas 3.6,3.8 and 3.9 of [\[9\]](#page-30-9) as follows.

\mu_{k+1}(\varepsilon) = \tilde{\mu}_{k+1} - \varepsilon = \min\left\{1 + \tilde{\theta}_k, 1 + \frac{\nu}{2} - \frac{\nu + 1}{2(\gamma + 1)} + \frac{\tilde{\theta}_k}{2}\right\} - \varepsilon, \quad \forall k \in \mathbb{N},\qquad(4.13)

$$
(4.16)

and

\theta^* := \begin{cases} \nu, & \nu \in \left[0, \frac{\gamma}{\gamma + 2}\right], \\ \frac{\gamma - \nu}{\gamma + 1}, & \nu \in \left[\frac{\gamma}{\gamma + 2}, 1\right). \end{cases}

Proof. We pay attention to the case $\nu \in \left[\frac{\gamma}{\gamma+2}, 1\right)$. The other case $\nu \in \left(0, \frac{\gamma}{\gamma+2}\right]$ has been dealt with in [\[9\]](#page-30-9); For case $\nu = 0$, see [\[14](#page-31-0)](with $1 < \gamma < 3$) and [\[8](#page-30-1)](with $\gamma \ge 2$).

It follows from [\(4.13\)](#page-18-1) and [\(4.14\)](#page-18-2) that

since $\nu \geq \frac{\gamma - \nu}{\gamma + 1}$ provided that $\nu \in \left[\frac{\gamma}{\gamma + 2}, 1\right)$.

= \left(1 + \frac{1}{2} + \dots + \frac{1}{2^{k-k_1}}\right) \left(1 + \frac{\nu}{2} - \frac{\nu + 1}{2(\gamma + 1)} - \nu\right) + \frac{1}{2^{k+1-k_1}} (\tilde{\mu}_{k_1} - \nu)
$$

\ge \left(1 + \frac{1}{2} + \dots + \frac{1}{2^{k-k_1}}\right) \left(1 - \frac{\nu}{2} - \frac{\nu + 1}{2(\gamma + 1)}\right).

5 Proof of the main result

First, we estimate \hat{I}_{41} and \hat{I}_{42} . It follows from $\nu \in \left[\frac{\gamma}{\gamma+2}, 1\right)$, [\(4.24\)](#page-20-1) and [\(4.26\)](#page-20-2) that

where the last inequality is from

Now, we estimate \hat{I}_{43} and \hat{I}_{44} . Similar to [\(5.14\)](#page-25-1) and [\(5.15\)](#page-25-0), we deduce that

\hat{I}_{44} = \int_{0}^{t} \int (1+\tau)^{\hat{\mu}(\varepsilon)-1} \frac{2\bar{m}}{\bar{\rho}} (m-\bar{m}) dx d\tau \n\leq C \int_{0}^{t} \int (1+\tau)^{\hat{\mu}(\varepsilon)-1-\frac{2\gamma-1-3\nu}{2(\gamma+1)}} ||y_{\tau}|| dx d\tau \n\leq \int_{0}^{t} (1+\tau)^{2\left[\hat{\mu}(\varepsilon)-\frac{4\gamma+1-3\nu}{2(\gamma+1)}-\frac{\mu^{*}(\varepsilon)-\nu}{2}\right]} d\tau \n+ C \int_{0}^{t} \int (1+\tau)^{\mu^{*}(\varepsilon)-\nu} y_{\tau}^{2} dx d\tau \n\leq C,

by [\(4.15\)](#page-18-4), [\(5.18\)](#page-26-0) and [\(5.19\)](#page-26-1).

Substituting [\(5.22\)](#page-27-0)-[\(5.25\)](#page-28-0) into [\(5.21\)](#page-27-1), we have $\hat{I}_4 \leq C$, which together with [\(5.17\)](#page-26-2)-[\(5.20\)](#page-26-3) yields that

Now, we are ready to prove Theorem [2.2](#page-4-1). From [\(5.1\)](#page-21-1), [\(5.2\)](#page-21-2) and Theorem [5.2,](#page-21-0) we have

As for (2.7) and (2.8) , we distinguish two cases.

Case $A : \gamma \geq 2$.

Using Lemma [3.2,](#page-9-0) [\(3.9\)](#page-12-1) and [\(2.5\)](#page-5-1), we obtain the $L¹$ convergence rate on density as follows

This and [\(5.5\)](#page-21-5) together justify [\(2.7\)](#page-5-0) for $\gamma \geq 2$.

Case $B: 1 < \gamma < 2$.

In this case, let

\Omega_1 = \left\{ x : \rho = 0, \, \bar{\rho} = 0, \, |\rho - \bar{\rho}| \ge \frac{1}{2}\bar{\rho} \right\},\,

\Omega_2 = \left\{ x : \rho \neq 0, \, \bar{\rho} \neq 0, \, |\rho - \bar{\rho}| < \frac{1}{2}\bar{\rho} \right\}.
$$

In Ω_1 , from Lemma [3.5,](#page-12-4) [\(3.2\)](#page-9-2), [\(5.1\)](#page-21-1), Theorem [5.2](#page-21-0) and the Hölder inequality, we see that for any $\delta < \frac{(\gamma - 1)^2}{2\gamma}$,

\int_{\Omega_{1}} |\rho - \bar{\rho}| dx \leq \left(\int_{\Omega_{1}} |\rho - \bar{\rho}|^{\gamma} dx \right)^{\frac{1}{\gamma}} \left| |\bar{\rho}^{\delta}| \right|_{L^{\frac{2\gamma}{\gamma-1}}(\Omega_{1})} \left| |\bar{\rho}^{-\delta}| \right|_{L^{\frac{2\gamma}{\gamma-1}}(\Omega_{1})} \leq C \left(\int_{\Omega_{1}} \rho^{\gamma} - \bar{\rho}^{\gamma} - \gamma \bar{\rho}^{\gamma-1} (\rho - \bar{\rho}) dx \right)^{\frac{1}{\gamma}} \left| |\bar{\rho}^{\delta}| \right|_{L^{\frac{2\gamma}{\gamma-1}}} \left| |\bar{\rho}^{-\delta}| \right|_{L^{\frac{2\gamma}{\gamma-1}}} \leq C \left(\int \eta_{*} dx \right)^{\frac{1}{\gamma}} (1+t)^{\frac{\gamma-1}{\gamma(\gamma+1)}(1+\nu)} \leq C (1+t)^{-\frac{\phi(\varepsilon)}{\gamma} (1+t)^{\frac{\gamma-1}{\gamma(\gamma+1)}(1+\nu)}.

On the other hand, in Ω_2 , from Lemma [3.5,](#page-12-4) [\(3.3\)](#page-9-3), [\(5.1\)](#page-21-1), Theorem [5.2](#page-21-0) and the Hölder inequality, we deduce that

\le C \left(\int_{\Omega_2} \rho^{\gamma} - \bar{\rho}^{\gamma} - \gamma \bar{\rho}^{\gamma - 1} (\rho - \bar{\rho}) dx \right)^{\frac{1}{2}} \left(\int \bar{\rho}^{2 - \gamma} dx \right)^{\frac{1}{2}}

\leq C(1+t)^{-\frac{1}{\gamma} \left[\phi(\varepsilon) - \frac{\gamma - 1}{\gamma + 1} (1+\nu) \right]} + C(1+t)^{-\frac{1}{2} \left[\phi(\varepsilon) - \frac{\gamma - 1}{\gamma + 1} (1+\nu) \right]}
$$

\leq C(1+t)^{-\frac{1}{2} \left[\phi(\varepsilon) - \frac{\gamma - 1}{\gamma + 1} (1+\nu) \right]},
$$

where the last inequality is from $1 < \gamma < 2$ and $\phi(\varepsilon) - \frac{\gamma - 1}{\gamma + 1}(1 + \nu) > 0$. Thus, combining the above inequality and [\(5.5\)](#page-21-5), we obtain [\(2.7\)](#page-5-0) with $1<\gamma<2.$

Hence, we complete the proof of Theorem [2.2.](#page-4-1)
