Existence and asymptotic properties of standing waves for dipolar Bose-Einstein condensate with rotation[∗]

Abstract: In this article, we study the existence and asymptotic properties of prescribed mass standing waves for the rotating dipolar Gross-Pitaevskii equation with a harmonic potential in the unstable regime. This equation arises as an effective model describing Bose-Einstein condensate of trapped dipolar quantum gases rotating at the speed Ω . To be precise, we mainly focus on the two cases: the rotational speed $0 < \Omega < \Omega^*$ and $\Omega = \Omega^*$, where Ω^* is called a critical rotational speed. For the first case, we obtain two different standing waves, one of which is a local minimizer and can be determined as the ground state, and the other is mountain pass type. For the critical case, we rewrite the original problem as a dipole Gross-Pitaevskii equation with a constant magnetic field and partial harmonic confinement. Under this setting, a local minimizer can also be obtained, which seems to be the optimal result. Particularly, in both cases, we establish the mass collapse behavior of the local minimizers. Our results extend the work of Dinh (Lett. Math. Phys., 2022) and Luo et al. (J. Differ. Equ., 2021) to the non-axially symmetric harmonic potential, and answer the open question proposed by Dinh.

Keywords: Dipolar Bose-Einstein condensate; Rotation; Standing waves; Asymptotic behavior

1 Introduction

In recent years, the dipolar Bose-Einstein condensate (BEC) in a rotating frame have been investigated in several studies by Physicists $[1,25,32]$ $[1,25,32]$ $[1,25,32]$. At temperature much smaller than the critical temperature, the three-dimensional (3D) rotating dipolar BEC can be well described by the Gross-Pitaevskii equation (GPE) with dipolar interaction [\[13,](#page-32-0) [30\]](#page-33-2) as follows:

$$
i\hbar \frac{\partial\psi(x,t)}{\partial t} = -\frac{\hbar^2}{2m}\nabla^2\psi + V(x)\psi + U_0|\psi|^2\psi + (V_{dip} * |\psi|^2)\psi - \Omega L_z \psi, \quad x \in \mathbb{R}^3, \quad t > 0, \tag{1.1}
$$

where $x = (x_1, x_2, x_3)^T \in \mathbb{R}^3$ is the Cartesian coordinates, t is the time variable, * denotes the convolution operator with respect to the spatial variable, \hbar is the Planck constant, m is the mass of a dipolar particle, $\Omega \geq 0$ is the angular velocity of the laser beam and L_z is the third component of angular momentum operator $\mathbb{L} := -i\hbar x \wedge \nabla$ i.e., $L_z := i\hbar (x_2 \partial_{x_1} - x_1 \partial_{x_2})$. Moreover, $V(x)$ is the harmonic trapping potential described as $V(x) := \frac{m}{2}(\gamma_1^2 x_1^2 + \gamma_2^2 x_2^2 +$ $(\gamma_3^2 x_3^2)$, where γ_1 , γ_2 and γ_3 being the trap frequencies in each spatial direction. The parameter $U_0 = \frac{4\pi\hbar^2 a_s}{m}$ represents the short-range interaction between dipoles in the condensate with a_s the s-wave scattering length (positive for repulsive interaction and negative for attractive interaction). The long-range dipolar interaction potential between two dipoles is defined by

$$
V_{dip}(x) = \frac{\mu_0 \mu_{dip}^2}{4\pi} \frac{1 - 3\cos^2(\theta)}{|x|^3}, \ \ x \in \mathbb{R}^3,
$$

where μ_0 is the vacuum magnetic permeability, μ_{dip} is the permanent magnetic dipole moment and θ is the angle between the vector x and the unitary dipole axis n. In view of the mass conservation, the wave function $\psi(x,t)$ is always normalized such that $\int_{\mathbb{R}^3} |\psi(x,t)|^2 dx = N$, where N is the total number of dipolar particles in the rotating dipolar BEC.

To our knowledge, the rigourous mathematical study of (1.1) is only given in [\[10,](#page-32-1) Chapter 4]. Under suitable restriction on the rotational speed, they studied the existence and nonexistence of ground states of the 3D rotational Gross-Pitaevskii-Poisson system (GPPS) and the quasi-2D rotational dipolar GPE (which are the some dimensionless forms of [\(1.1\)](#page-0-0)), and computed the ground states for the quasi-2D rotational dipolar GPE by using a numerical method.

In order to investigate the more mathematical features of the rotating dipolar BEC, we give the dimensionless form of (1.1) by introducing the dimensionless variables as in [\[5\]](#page-31-1), that is,

$$
i\partial_t \psi = -\frac{1}{2}\Delta \psi + V(x)\psi + \lambda_1 |\psi|^2 \psi + \lambda_2 (K \ast |\psi|^2) \psi - \Omega L_z \psi, \quad (t, x) \in \mathbb{R}^+ \times \mathbb{R}^3, \tag{1.2}
$$

where $\Omega \geq 0$ is the rotational speed, the parameters $\lambda_i \in \mathbb{R}$ ($i = 1, 2$) describe the strength of the two nonlinearities (i.e. the local and the non-local one), the quantum mechanical angular momentum operator

$$
L_z = i(x_2\partial_{x_1} - x_1\partial_{x_2})
$$

and

$$
V(x) = \frac{1}{2} \sum_{j=1}^{3} \gamma_j^2 x_j^2 \text{ with } \gamma_j > 0
$$
 (1.3)

is the dimensionless harmonic trapping potential. In addition, the dimensionless long-range dipolar interaction potential is given by

$$
K(x) = \frac{1 - 3\cos^2(\theta)}{|x|^3}, \ x \in \mathbb{R}^3,
$$

where $\theta = \theta(x)$ being the angle between the dipole axis n and the vector x. Here to simplify notation, we fix, without restriction of generality, the dipole axis $n = (0, 0, 1)$. For the general dipole axis, we refer to $[8, 9]$ $[8, 9]$. The corresponding normalization is now

$$
\int_{\mathbb{R}^3} |\psi(x,t)|^2 dx = \int_{\mathbb{R}^3} |\psi(x,0)|^2 dx = c > 0.
$$

Based on the dimensionless form (1.2) , in this paper, we are mainly interesting in the stationary states/standing waves of problem (1.1) , that is,

$$
\psi(x,t) = e^{i\mu t} u(x), \quad x \in \mathbb{R}^3,
$$

where $\mu \in \mathbb{R}$ and $u(x)$ is a time-independent function. As we will see, we present new contributions respecting the existence of standing waves for (1.1) with $0 < \Omega < \Omega^*$ or $\Omega = \Omega^*$, as well as their multiplicity, ground states and asymptotic properties. Here $\Omega^* > 0$ is the critical rotational speed defined in (1.10) below. Plugging (1.4) into (1.2) , it is natural to consider the following stationary equation

$$
-\frac{1}{2}\Delta u + V(x)u + \lambda_1|u|^2u + \lambda_2(K * |u|^2)u - \Omega L_z u + \mu u = 0 \text{ in } \mathbb{R}^3,
$$
 (1.5)

having the prescribed mass

$$
\int_{\mathbb{R}^3} |u|^2 dx = c > 0,
$$
\n(1.6)

where $\mu \in \mathbb{R}$ is the Lagrange multiplier. In particular, we constrain the coordinate plane (λ_1, λ_2) to the so-called unstable regime

$$
D_{ur} := \left\{ (\lambda_1, \lambda_2) \in \mathbb{R}^2 : \lambda_1 - \frac{4\pi}{3} \lambda_2 < 0, \lambda_2 > 0 \text{ or } \lambda_1 + \frac{8\pi}{3} \lambda_2 < 0, \lambda_2 < 0 \right\},\tag{1.7}
$$

which is introduced in [\[12,](#page-32-4) Remark 4.5] as a complement of the stable regime

$$
D_{sr} := \left\{ (\lambda_1, \lambda_2) \in \mathbb{R}^2 : \lambda_1 - \frac{4\pi}{3} \lambda_2 \ge 0, \lambda_2 \ge 0 \text{ or } \lambda_1 + \frac{8\pi}{3} \lambda_2 \ge 0, \lambda_2 \le 0 \right\}.
$$
 (1.8)

Here we remark that Carles, Markowich and Sparber in [\[12\]](#page-32-4) considered the existence and uniqueness of ground states as well as the blowup theory for (1.2) with $\Omega = 0$. Moreover, some crucial results for the dipolar term were established, such as the Fourier transform of $K(x)$ in \mathbb{R}^3 under the condition of $n = (0,0,1)$. For more related results of (1.2) and its the stationary form [\(1.5\)](#page-2-1) with $\Omega = 0$, we refer to [\[14,](#page-32-5) [17,](#page-32-6) [21,](#page-32-7) [23,](#page-33-3) [24\]](#page-33-4) for the unstable regime, and [\[11\]](#page-32-8) for the stable regime.

In the following, we always assume the rotational speed $\Omega > 0$. In order to expound our main results, we define the working space Σ for (1.5) as follows

\Sigma := \left\{ u \in H^1(\mathbb{R}^3, \mathbb{C}) : \int_{\mathbb{R}^3} |x|^2 |u|^2 dx < +\infty \right\},\,
$$

which is a Hilbert space with the inner product and norm

$$
(u, v)_{\Sigma} := \text{Re} \int_{\mathbb{R}^3} (\nabla u \cdot \nabla \overline{v} + |x|^2 u \overline{v} + u \overline{v}) dx,
$$

$$
||u||_{\Sigma} := \left(\int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 + |u|^2 dx \right)^{\frac{1}{2}}.
$$

Here "Re" stays for the real part and \overline{v} denotes the conjugate of v. Moreover, we define

$$
||u||_{\dot{\Sigma}} := \left(\int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx\right)^{\frac{1}{2}},
$$

which is a equivalent norm of Σ . To obtain the existence of solutions (also known as normalized solutions) for [\(1.5\)](#page-2-1), we need to seek critical points of the energy functional

$$
E_{\Omega}(u) := \frac{1}{2} \int_{\mathbb{R}^3} |\nabla u|^2 + V(x)|u|^2 dx + \frac{1}{2} \int_{\mathbb{R}^3} \lambda_1 |u|^4 + \lambda_2 (K \ast |u|^2) |u|^2 dx - \Omega \int_{\mathbb{R}^3} \overline{u} L_z u dx \tag{1.9}
$$

under the mass constraint

$$
S(c) := \{ u \in \Sigma : |u|_2^2 = c \}.
$$

By the standard argument, we know that $E_{\Omega}(u)$ is well-defined on Σ (see [\(2.6\)](#page-8-0)). Furthermore, it is well-known that for the harmonic trapping potential in (1.3) , there is a critical rotational speed

$$
\Omega^* := \min\{\gamma_1, \gamma_2\}.\tag{1.10}
$$

If $\Omega < \Omega^*$, we can get the equivalence of a new norm involving the rotational term, that is,

$$
\int_{\mathbb{R}^3} |\nabla u|^2 + 2V(x)|u|^2 - 2\Omega \overline{u}L_z u dx \cong \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx,
$$

see Lemma [2.4.](#page-8-1) In this sense, one can overcome the difficulty (i.e. how to recover the compactness) brought by the rotational term. Indeed, this equivalence has been observed in $[4, 15, 19, 22]$ $[4, 15, 19, 22]$ $[4, 15, 19, 22]$ $[4, 15, 19, 22]$ $[4, 15, 19, 22]$ $[4, 15, 19, 22]$, where the authors considered the classical rotating BEC in the mean-field regime described by the nonlinear GPE with pure power nonlinearities. Compared to the classical rotating BEC, our problem involves the nonlinear potential energy

$$
N(u) := \int_{\mathbb{R}^3} \lambda_1 |u|^4 + \lambda_2 (K * |u|^2) |u|^2 dx, \tag{1.11}
$$

which is sign indefinite if $(\lambda_1, \lambda_2) \in D_{ur}$ but there is a $u \in S(c) \cap C_0^{\infty}(\mathbb{R}^3)$ such that $N(u) < 0$ (see [\[5\]](#page-31-1)). From this perspective, the unstable regime is very interesting. In particular, for the stable regime [\(1.8\)](#page-2-2), we know that $N(u) > 0$. In this case, we refer to [\[26,](#page-33-5) Theorem 1] about the existence of ground states of (1.5) if $\Omega < \Omega^*$.

Now we give the first main result for the existence of normalized solutions to problem [\(1.5\)](#page-2-1) if $\Omega < \Omega^*$ and $(\lambda_1, \lambda_2) \in D_{ur}$. This result implies that problem [\(1.5\)](#page-2-1) has at least two solutions, which correspond to a local minimizer and a mountain pass critical point of $E_{\Omega}|_{S(c)},$ respectively.

Theorem 1.1. Let V be as in [\(1.3\)](#page-1-1), $0 < \Omega < \Omega^* = \min\{\gamma_1, \gamma_2\}$ and $(\lambda_1, \lambda_2) \in D_{ur}$. Then

(i) for any fixed $r > 0$, there exists $c_0 := c_0(r, \Omega) > 0$ (see [\(3.7\)](#page-12-0)) such that for any $0 < c < c_0$, there is an interior local minimizer u_c of $E_{\Omega}(u)$ on the set $S(c) \cap B(r)$, where $B(r) := \{u \in \Sigma : ||u||_{\Sigma}^2 \leq r\}$. Moreover, u_c is a weak solution of problem [\(1.5\)](#page-2-1) with the Lagrange multiplier $\mu_c < 0$ and

$$
\mu_c \in \left[-\zeta^0 - \delta(r)c, 3\left(-\frac{C_*}{2} + \Lambda C_4^4 r^{\frac{1}{2}} c^{\frac{1}{2}} \right) \right],\tag{1.12}
$$

where $\zeta^0 := \frac{1}{2} \sum_{n=1}^3$ $j=1$ $\gamma_j, \, \delta(r) := \sqrt{2} \Lambda \mathcal{C}_4^4 (\zeta^0)^{\frac{3}{2}} + \frac{\Lambda}{2}$ $\frac{\Lambda}{2} \mathcal{C}_4^4 r^{\frac{3}{2}}, C_* := \min\{\frac{(\Omega^*)^2 - \Omega^2}{(\Omega^*)^2 + \Omega^2}, \frac{(\Omega^*)^2 - \Omega^2}{2}, \gamma_3^2\},$ and C_4 , Λ are positive constants.

(ii) If $0 < \Omega < \frac{\sqrt{5}}{3} \Omega^*$, then for any $0 < c < c_0$, $E_{\Omega}|_{S(c)}$ has a second critical point of mountain pass type v_c at the level $\gamma(c) > E_{\Omega}(u_c)$. Moreover, v_c is also a weak solution of problem [\(1.5\)](#page-2-1) with the Lagrange multiplier $\hat{\mu}_c \in \mathbb{R}$.

Remark 1.2. Note that we restrict $0 < \Omega < \frac{\sqrt{5}}{3} \Omega^*$ when finding the mountain pass solution. We mention that the condition is pivotal for proving the boundedness of a specific Palai-Smale sequence $\{v_n\}$ constructed by a variant of the min-max theorem in [\[18\]](#page-32-12). Indeed, it follows from $[22]$ that the Pohozaev identity (2.5) does not involve the rotation term. Thus, due to the fact that the rotation term $\int_{\mathbb{R}^3} \Omega \overline{v}_n L_z v_n dx$ within $E_{\Omega}(v_n)$ is sign indefinite, we introduce this stronger condition to ensure the boundedness of $\{v_n\}$ in Σ , see [\(3.16\)](#page-17-0). Once the boundedness is established, the compactness is natural since $\Sigma \hookrightarrow L^p(\mathbb{R}^3)$ is compact for $p \in [2, 6)$.

Next we provide some asymptotic properties of the local minimizer u_c obtained by Theorem [1.1](#page-3-1) as $c \to 0^+$. To this end, we define

$$
\mathcal{M}_c^r := \{ u \in S(c) \cap B(r) : E_{\Omega}(u) = m(c, r) \},
$$

where $m(c, r) = \inf_{u \in S(c) \cap B(r)} E_{\Omega}(u)$ is the minimal energy. Based on Theorem [1.1,](#page-3-1) we know that $\mathcal{M}_c^r \neq \emptyset$. In particular, we will prove that u_c is a ground state if $0 < \Omega < \frac{\sqrt{5}}{3}\Omega^*$ and $c > 0$ sufficiently small. The definition of ground states can be seen in [\[5,](#page-31-1) Definition 1.1].

Theorem 1.3. Under the setting of Theorem [1.1](#page-3-1), there holds

$$
\sup_{u \in \mathcal{M}_c^r} \|u - \varrho_0 \psi_0\|_{\dot{\Sigma}}^2 = O(c + c^2),\tag{1.13}
$$

where ψ_0 is the unique normalized positive eigenfunction of harmonic oscillator $-\frac{1}{2}\Delta + \frac{|x|^2}{2}$ and $\varrho_0 := \int_{\mathbb{R}^3} u\psi_0 dx$. In particular, if $\zeta^0 = \frac{3C_{\ast}}{2}$, then $\frac{C_*}{2}$, then

$$
\sup_{u \in \mathcal{M}_c^r} \|u - \varrho_0 \psi_0\|_{\dot{\Sigma}}^2 = O(c^2). \tag{1.14}
$$

Remark 1.4. The above result implies that the local minimizers in \mathcal{M}_c^r behave like the first eigenfunction of the harmonic oscillator for small $c > 0$. Moreover, [\(1.14\)](#page-4-0) gives the more refined estimate, which strictly depends on $\zeta^0 = \frac{3C_*}{2}$ $\frac{C_*}{2}$. Recall that $\zeta^0 = \frac{1}{2}$ $\frac{1}{2}$ \sum $j=1$ γ_j and $C_* = \min\{\frac{(\Omega^*)^2 - \Omega^2}{(\Omega^*)^2 + \Omega^2}, \frac{(\Omega^*)^2 - \Omega^2}{2}, \gamma_3^2\}$. If $\gamma_1 = \gamma_2$, we can see that $\zeta^0 < \frac{3C_*}{2}$ $\frac{C_{*}}{2}$. For $\gamma_1 \neq \gamma_2$, it is easy to check that the assumption $\zeta^0 = \frac{3C_*}{2}$ $\frac{C_*}{2}$ is well-defined when $\Omega > 0$ approaches 0 and $C_* = \frac{(\Omega^*)^2 - \Omega^2}{2}$. Thus, in this sense, this estimate extends the result in [\[22,](#page-32-11) Theorem 1.1].

Theorem 1.5. Let $(u_c, \mu_c) \in \mathcal{M}_c^r \times \mathbb{R}$ be given by Theorem [1.1](#page-3-1). Then $u_c \to 0$ in Σ as $c \to 0^+$,

$$
\lim_{c \to 0^+} \frac{m(c, r)}{c} = \lim_{c \to 0^+} -\mu_c = -\mu_0
$$

for some $\mu_0 \in [-\zeta^0, -\frac{3C_*}{2}]$ $\frac{C_*}{2}$, and

$$
\lim_{c \to 0^+} \frac{\int_{\mathbb{R}^3} |\nabla u_c|^2 dx - \Omega \int_{\mathbb{R}^3} \overline{u}_c L_z u_c dx}{c} = \lim_{c \to 0^+} \frac{\int_{\mathbb{R}^3} 2V(x) |u_c|^2 - \Omega \int_{\mathbb{R}^3} \overline{u}_c L_z u_c dx}{c} = -\mu_0.
$$

Moreover, if $0 < \Omega < \frac{\sqrt{5}}{3}\Omega^*$, u_c is a normalized ground state to [\(1.5\)](#page-2-1)-[\(1.6\)](#page-2-3) when $c > 0$ is sufficiently small.

Remark 1.6. Theorem [1.5](#page-4-1) describes a mass collapse behavior of the local minimizers. Moreover, it can be seen that the local minimizer u_c is a ground state when c approaches 0 and $\Omega > 0$ is small. Indeed, in order to determine this fact, a direct way is to prove that all solutions with energy strictly less than $m(c,r)$ are in $S(c) \cap B(r)$ provided that $c \to 0^+$. Based on this, the Pohozaev identity will also play a crucial role, but similar phenomenon as in Remark [1.2](#page-4-2) will arise. Therefore, we also restrict that $0 < \Omega < \frac{\sqrt{5}}{3}\Omega^*$.

As mentioned earlier, there is a critical rotational speed Ω^* and we establish the existence and asymptotic properties of standing waves if $\Omega < \Omega^*$ (i.e. the low rotational speed). Hence, a natural question is whether we can obtain similar results if $\Omega = \Omega^*$ (i.e. the critical rotational speed). Indeed, the situation is even more subtle. Since the norm equivalence is no longer available, the working space Σ is not helpful in finding normalized solutions to problem [\(1.5\)](#page-2-1) with $\Omega = \Omega^*$. It leads us to seek new method to deal with the case $0 < \Omega = \Omega^*$. Motivated by $[15]$, we rewrite (1.5) as the following dipolar GPE with magnetic field

$$
-\frac{1}{2}(\nabla - iA)^2 u + V_{\Omega^*}(x)u + \lambda_1 |u|^2 u + \lambda_2 (K * |u|^2)u + \mu u = 0 \text{ in } \mathbb{R}^3, \qquad (1.15)
$$

where $A = A(x) := \Omega^*(-x_2, x_1, 0), V_{\Omega^*}(x) := V(x) - \frac{1}{2}|A|^2$ and the magnetic Schrödinger operator (see $[16]$) is defined by

$$
-(\nabla - iA)^2 u := -\Delta u + 2iA \cdot \nabla u - iudivA + |A|^2 u = -\Delta u + 2iA \cdot \nabla u + |A|^2 u.
$$

Recall that $\Omega^* = \min\{\gamma_1, \gamma_2\}$. Without loss of generality, we assume that

$$
\min\{\gamma_1,\gamma_2\}=\gamma_2.
$$

Then $\Omega^* = \gamma_2$ and

$$
V_{\Omega^*}(x) = \frac{1}{2}(\gamma_1^2 - \gamma_2^2)x_1^2 + \frac{1}{2}\gamma_3^2 x_3^2.
$$

From this perspective, [\(1.15\)](#page-5-0) can be viewed as the dipolar GPE with a constant magnetic field and a partial harmonic confinement in x_1, x_3 directions. Moreover, the corresponding energy functional $E_{\Omega^*}(u)$ can be rewritten as

$$
E_{\Omega^*}(u) = \frac{1}{2} \int_{\mathbb{R}^3} |(\nabla - iA)u|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|u|^2 dx + \frac{1}{2}N(u), \tag{1.16}
$$

where $N(u)$ is shown in (1.11) .

In particular, the working space is naturally replaced with Σ_{Ω^*} , where

$$
\Sigma_{\Omega^*} := \{ u \in H_A^1(\mathbb{R}^3, \mathbb{C}) : \int_{\mathbb{R}^3} V_{\Omega^*}(x) |u|^2 dx < \infty \}
$$
\n(1.17)

is equipped with the norm

$$
||u||_{\Sigma_{\Omega^*}}^2 := \int_{\mathbb{R}^3} |(\nabla - iA)u|^2 + 2V_{\Omega^*}(x)|u|^2 + |u|^2 dx \tag{1.18}
$$

and $H^1_A(\mathbb{R}^3, \mathbb{C})$ is the usual magnetic Sobolev space defined by

$$
H_A^1(\mathbb{R}^3, \mathbb{C}) := \{ u \in L^2(\mathbb{R}^3) : |(\nabla - iA)u| \in L^2(\mathbb{R}^3) \}.
$$

Obviously, the energy functional E_{Ω^*} is well-defined on Σ_{Ω^*} . Some basic properties of the magnetic Sobolev space $H_A^1(\mathbb{R}^3, \mathbb{C})$ are collected in [\[15,](#page-32-9) Lemma 2.3]. Here we only mention the diamagnetic inequality

$$
|\nabla |u(x)|| \le |(\nabla - iA)u(x)|, \quad a.e. \quad x \in \mathbb{R}^3,
$$
\n
$$
(1.19)
$$

see [\[20\]](#page-32-14). On the other hand, unlike $\Omega < \Omega^*$, we further constrain (λ_1, λ_2) to belong to a special unstable region \bar{D}_{ur} , where

$$
\bar{D}_{ur} := \left\{ (\lambda_1, \lambda_2) \in \mathbb{R}^2 : \lambda_1 + \frac{8\pi}{3} \lambda_2 < 0, \lambda_2 > 0, \text{ or } \lambda_1 - \frac{4\pi}{3} \lambda_2 < 0, \lambda_2 < 0 \right\}. \tag{1.20}
$$

If $(\lambda_1, \lambda_2) \in \overline{D}_{ur}$, it is esay to check that $N(u) < 0$ for all $u \in \Sigma_{\Omega^*}$. As we will see, this property plays some important roles, such as excluding the vanishing case for the minimizing sequences of the local minimization problem

$$
m_{\Omega^*}(c,\rho) = \inf \{ E_{\Omega^*}(u) : u \in S(c) \cap B_{\Omega^*}(\rho) \},
$$

where $B_{\Omega^*}(\rho)$ defined in [\(4.2\)](#page-22-0) and $S(c) = \{u \in \Sigma_{\Omega^*} : |u|_2^2 = c\}$. Furthermore, we point out that for $\Omega = \Omega^*$, inspired by the idea of [\[6\]](#page-31-3), an interior local minimizer can be obtained for the minimization problem [\(4.1\)](#page-22-1). However, since $\Omega = \Omega^*$ is considered, we cannot restrict Ω to be small and then the Pohozaev identity does not seem to provide us any assistance. Thus, the existence of ground states or mountain pass solutions cannot be determined. In this sense, our result seems to be optimal. Especially, we mention that the authors in [\[6\]](#page-31-3) studied the nonlinear Schrödinger equation with a partial confinement, the ground state can be acquired, which is different from our problem.

According to the above framework, we now present the results for the existence and some asymptotic properties of normalized solutions for (1.5) with $0 < \Omega = \Omega^*$.

Theorem 1.7. Let V be as in [\(1.3\)](#page-1-1) satisfying $\gamma_2 \leq \gamma_1 < \sqrt{\frac{2M(\gamma_2,\gamma_3)\gamma_2}{c} + \gamma_2^2}$, $(\lambda_1,\lambda_2) \in \bar{D}_{ur}$ and $0 < \Omega = \Omega^*$ with $\Omega^* = \gamma_2$, where $M(\gamma_2, \gamma_3)$ is a constant depending on γ_2 , γ_3 . Then

(i) for any fixed $\rho > 0$, there exists $\bar{c}(\rho) > 0$ (see [\(4.23\)](#page-30-0)) such that for all $0 < c < \bar{c}(\rho)$, $E_{\Omega^*}(u)$ has an interior local minimizer \widetilde{u}_c such that

$$
E_{\Omega^*}(\widetilde{u}_c) = m_{\Omega^*}(c,\rho) < \gamma c.
$$

Moreover, \tilde{u}_c is a weak solution of problem [\(1.5\)](#page-2-1) with the Lagrange multiplier $\tilde{\mu}_c < 0$ and

$$
\widetilde{\mu}_c \in \left(-\gamma, \left(-\frac{1}{2} + \Lambda \mathcal{C}_4^4 \rho^{\frac{1}{2}} c^{\frac{1}{2}} \right) \gamma \right],\tag{1.21}
$$

where $\Lambda > 0$ is a constant and $\gamma := \gamma_2 + \frac{\gamma_3}{2}$ $\frac{\gamma_3}{2}$.

(*ii*) $\widetilde{u}_c \to 0$ in Σ_{Ω^*} as $c \to 0^+$, and

$$
\lim_{c \to 0^+} \frac{m_{\Omega^*}(c,\rho)}{c} = \lim_{c \to 0^+} -\widetilde{\mu}_c = -\widetilde{\mu}_0
$$

for some $\widetilde{\mu}_0 \in [-\gamma, -\frac{1}{2}]$ $\frac{1}{2}\gamma$. Remark 1.8. Compared with [\[15,](#page-32-9) Theorem 1.4], Theorem [1.7](#page-6-0) shows the existence of normal-ized solutions for [\(1.5\)](#page-2-1) with $\Omega = \Omega^*$ when the harmonic potential is not axially symmetric, i.e., $\gamma_1 \neq \gamma_2$. This solves the open problem proposed in [\[15,](#page-32-9) Remark 1.7].

Remark 1.9. To sum up, we obtain the existence of prescribed mass/normalized standing waves for [\(1.2\)](#page-1-0) with $0 < \Omega \leq \Omega^*$. For the stability, we believe that corresponding result can be established based on the arguments in [\[5,](#page-31-1)[15\]](#page-32-9), and this will be treated as an open question. Finally, we remark that for $\Omega > \Omega^*$, some non-existence results can be seen in [\[7,](#page-31-4)[10\]](#page-32-1) and the numerical method was used.

The paper is organized as follows. In Section [2,](#page-7-0) some preliminary results are given. Section [3](#page-9-0) is devoted to investigating the case of $0 < \Omega < \Omega^*$, and accomplishing the proof of Theorems [1.1-](#page-3-1)[1.5.](#page-4-1) In Section [4,](#page-22-2) we consider the case of $\Omega = \Omega^*$ and prove Theorem [1.7.](#page-6-0)

2 Preliminaries

In this section, we give some preliminary results. In the process of proof, we need to use the following notation. For $1 \leq p < \infty$ and $u \in L^p(\mathbb{R}^3, \mathbb{C})$, the norm is denoted by $|u|_p := (\int_{\mathbb{R}^3} |u|^p dx)^{\frac{1}{p}}$. The Hilbert spaces $H^1(\mathbb{R}^3, \mathbb{C})$ is defined as

$$
H^{1}(\mathbb{R}^{3}, \mathbb{C}) := \left\{ u \in L^{2}(\mathbb{R}^{3}, \mathbb{C}) : \nabla u \in L^{2}(\mathbb{R}^{3}, \mathbb{C}) \right\},
$$

with the inner product $(u, v) := \text{Re} \left[\int_{\mathbb{R}^3} \nabla u \cdot \nabla \overline{v} + u \overline{v} dx \right]$ and norm $||u|| := (|\nabla u|_2^2 + |u|_2^2)^{\frac{1}{2}}$. We simply write $H^1(\mathbb{R}^3)$ for $H^1(\mathbb{R}^3,\mathbb{C})$, and $L^p(\mathbb{R}^3)$ for $L^p(\mathbb{R}^3,\mathbb{C})$. $H^{-1}(\mathbb{R}^3)$ is the dual space of $H^1(\mathbb{R}^3)$. C and $C_i(i = 1, 2, ...)$ represent different positive constants. $o_n(1)$ denotes a quantity which goes to zero. "Re" stays for the real part and \overline{v} denotes the conjugate of v.

For any $u \in H^1(\mathbb{R}^3)$ and $q \in (2,6)$, the Gagliardo-Nirenberg inequality [\[27\]](#page-33-6) as follows: there is a constant $\mathcal{C}_q > 0$ such that

$$
|u|_q \leq C_q |\nabla u|_2^{\delta_q} |u|_2^{(1-\delta_q)},\tag{2.1}
$$

where δ_q is defined by $\delta_q := \frac{3(q-2)}{2q}$.

In particular, the proof of the main results need to use some spectral theory. Here we introduce

$$
\zeta^{0} := \inf \left\{ \frac{1}{2} \int_{\mathbb{R}^{3}} |\nabla u|^{2} dx + \int_{\mathbb{R}^{3}} V(x)|u|^{2} dx : u \in \Sigma, \ |u|_{2}^{2} = 1 \right\}
$$
 (2.2)

as the simple first eigenvalue of the multi-dimensional harmonic oscillator $-\frac{1}{2}\Delta + V$, where

$$
V(x) = \frac{1}{2} \sum_{j=1}^{3} \gamma_j^2 x_j^2.
$$

Let $\Phi_0(x) \in S(1) := \{u \in \Sigma : |u|_2^2 = 1\}$ be an eigenfunction with respect to the first eigenvalue ζ^0 . It is well-known that $\zeta^0 = \frac{1}{2} \sum_{n=1}^3$ $j=1$ γ_j , $\Phi_0(x)$ is real-valued and

$$
\Phi_0(x) := \pi^{-\frac{3}{4}} \left(\prod_{j=1}^3 \sqrt{\gamma_j} \right)^{\frac{1}{2}} e^{-\frac{1}{2} \sum_{j=1}^3 \gamma_j x_j^2}.
$$
\n(2.3)

Let the Fourier transform on the Schwartz space of u by $\hat{u}(\xi) := \mathcal{F}u(\xi) = \int_{\mathbb{R}^3} e^{-ix\cdot\xi} u(x) dx$. Then by [\[12,](#page-32-4) Lemma 2.3], we have the following result about the term $N(u)$ given in [\(1.11\)](#page-3-2).

Lemma 2.1. Let $u \in H^1(\mathbb{R}^3)$, then

$$
N(u) = \frac{1}{(2\pi)^3} \int_{\mathbb{R}^3} \left[\lambda_1 + \lambda_2 \widehat{K}(\xi)\right] |\widehat{u^2}|^2 d\xi
$$

and $|N(u)| \leq \Lambda |u|_4^4$, where $\Lambda := \max \left\{ |\lambda_1 - \frac{4\pi}{3} \right\}$ $\frac{4\pi}{3}\lambda_2$, $|\lambda_1 + \frac{8\pi}{3}$ $\frac{3\pi}{3}\lambda_2\vert$.

Due to the definition of the potential $V(x)$ in (1.3) , we have the following compactness result, which is verified in [\[31,](#page-33-7) Lemma 3.1].

Lemma 2.2. The embedding $\Sigma \hookrightarrow L^p(\mathbb{R}^3)$ is compact for $p \in [2, 6)$.

To discuss the existence of mountain pass solutions to $(1.5)-(1.6)$ $(1.5)-(1.6)$, we give the following Pohozaev identity, which can be obtained by the similar arguments in [\[22,](#page-32-11) Proposition 3.2] and [\[3,](#page-31-5) Lemma 2.2]. So we omit it.

Lemma 2.3. Let $(\lambda_1, \lambda_2) \in D_{ur}$, $\mu \in \mathbb{R}$, and $0 < \Omega < \Omega^*$. If $u \in \Sigma$ is a weak solution for the equation

$$
-\frac{1}{2}\Delta u + V(x)u + \lambda_1|u|^2u + \lambda_2(K * |u|^2)u - \Omega L_z u + \mu u = 0 \text{ in } \mathbb{R}^3,
$$
 (2.4)

where $V(x)$ be as in [\(1.3\)](#page-1-1), then the corresponding Pohozaev identity as follows:

$$
Q(u) := \frac{1}{2} \int_{\mathbb{R}^3} |\nabla u|^2 dx - \int_{\mathbb{R}^3} V(x) |u|^2 dx + \frac{3}{4} \int_{\mathbb{R}^3} \lambda_1 |u|^4 + \lambda_2 (K \ast |u|^2) |u|^2 dx = 0. \tag{2.5}
$$

Moreover, as stated in introduction, we establish the following equivalent norm for $\Omega < \Omega^*$.

Lemma 2.4. If $0 < \Omega < \Omega^*$, then for any $u \in \Sigma$,

$$
\int_{\mathbb{R}^3} |\nabla u|^2 + 2V(x)|u|^2 - 2\Omega \overline{u} L_z u dx \cong \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx,
$$

where $V(x)$ be as in (1.3) .

Proof. It follows from Hölder's, Cauchy-Schwarz's and Young's inequalities that

$$
\begin{split}\n&\left| \int_{\mathbb{R}^{3}} \Omega \overline{u} L_{z} u dx \right| \\
&= \left| \Omega \int_{\mathbb{R}^{3}} i \overline{u} (x_{2} \partial_{x_{1}} u - x_{1} \partial_{x_{2}} u) dx \right| \\
&\leq \Omega \left[\left(\int_{\mathbb{R}^{3}} x_{2}^{2} |u|^{2} dx \right)^{\frac{1}{2}} \left(\int_{\mathbb{R}^{3}} |\partial_{x_{1}} u|^{2} dx \right)^{\frac{1}{2}} + \left(\int_{\mathbb{R}^{3}} x_{1}^{2} |u|^{2} dx \right)^{\frac{1}{2}} \left(\int_{\mathbb{R}^{3}} |\partial_{x_{2}} u|^{2} dx \right)^{\frac{1}{2}} \right] \\
&\leq \left(\int_{\mathbb{R}^{3}} |\nabla u|^{2} dx \right)^{\frac{1}{2}} \left(\int_{\mathbb{R}^{3}} \Omega^{2} (x_{1}^{2} + x_{2}^{2}) |u|^{2} dx \right)^{\frac{1}{2}} \\
&\leq \varepsilon \int_{\mathbb{R}^{3}} |\nabla u|^{2} dx + \frac{\Omega^{2}}{4\varepsilon} \int_{\mathbb{R}^{3}} (x_{1}^{2} + x_{2}^{2}) |u|^{2} dx \n\end{split} \tag{2.6}
$$

for any $\varepsilon > 0$. By (2.6) , we have

$$
\int_{\mathbb{R}^3} |\nabla u|^2 + 2V(x)|u|^2 - 2\Omega \overline{u} L_z u dx
$$
\n
$$
\leq (1+2\varepsilon) \int_{\mathbb{R}^3} |\nabla u|^2 dx + \int_{\mathbb{R}^3} 2V(x)|u|^2 dx + \frac{\Omega^2}{2\varepsilon} \int_{\mathbb{R}^3} (x_1^2 + x_2^2)|u|^2 dx
$$
\n
$$
\leq \max\{1+2\varepsilon, \gamma_1^2 + \frac{\Omega^2}{2\varepsilon}, \gamma_2^2 + \frac{\Omega^2}{2\varepsilon}, \gamma_3^2\} \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx
$$
\n
$$
\stackrel{\Delta}{=} C^* \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx.
$$

To claim the reverse inequality, we apply (2.6) again to deal with the rotation term. So

$$
\int_{\mathbb{R}^3} |\nabla u|^2 + 2V(x)|u|^2 - 2\Omega \overline{u}L_z u dx
$$
\n
$$
\geq (1 - 2\varepsilon) \int_{\mathbb{R}^3} |\nabla u|^2 dx + \int_{\mathbb{R}^3} 2V(x)|u|^2 dx - \frac{\Omega^2}{2\varepsilon} \int_{\mathbb{R}^3} (x_1^2 + x_2^2)|u|^2 dx
$$
\n
$$
= (1 - 2\varepsilon) \int_{\mathbb{R}^3} |\nabla u|^2 dx + \int_{\mathbb{R}^3} ((\gamma_1^2 - \frac{\Omega^2}{2\varepsilon})x_1^2 + (\gamma_2^2 - \frac{\Omega^2}{2\varepsilon})x_2^2 + \gamma_3^2 x_3^2)|u|^2 dx.
$$

In view of $0 < \Omega < \Omega^* = \min\{\gamma_1, \gamma_2\}$ and the arbitrariness of ε , we choose $\varepsilon = \frac{\Omega^2}{(\Omega^*)^2 + \Omega^2}$ such that

$$
1 - 2\varepsilon = \frac{(\Omega^*)^2 - \Omega^2}{(\Omega^*)^2 + \Omega^2} > 0 \quad \text{and } \gamma_j^2 - \frac{\Omega^2}{2\varepsilon} \ge (\Omega^*)^2 - \frac{\Omega^2}{2\varepsilon} = \frac{(\Omega^*)^2 - \Omega^2}{2} > 0, \ \ j = 1, 2.
$$

Thus,

$$
\int_{\mathbb{R}^3} |\nabla u|^2 + 2V(x)|u|^2 - 2\Omega \overline{u} L_z u dx \ge C_* \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx,
$$

where $C_* := \min\{\frac{(\Omega^*)^2 - \Omega^2}{(\Omega^*)^2 + \Omega^2}, \frac{(\Omega^*)^2 - \Omega^2}{2}, \gamma_3^2\}$. Consequently,

Z $\int_{\mathbb{R}^3} |\nabla u|^2 + 2V(x)|u|^2 - 2\Omega \overline{u} L_z u dx \leq C^*$ $\int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx \leq$ $\int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx.$ C_* This completes the proof. \Box

3 The low rotational speed

In this section, we consider the case of $0 < \Omega < \Omega^*$ (the low rotational speed), and give the proof of Theorems [1.1,](#page-3-1) [1.3](#page-4-3) and [1.5.](#page-4-1)

Note that $(\lambda_1, \lambda_2) \in D_{ur}$, then there exists $u \in S(c) \cap C_0^{\infty}(\mathbb{R}^3)$ such that $N(u) < 0$, see [\[5\]](#page-31-1). Moreover, we have $u_t(x) := t^{\frac{3}{2}}u(tx) \in S(c)$ for any $t > 0$ and

$$
E_{\Omega}(u_t) = \frac{t^2}{2} \int_{\mathbb{R}^3} |\nabla u|^2 dx + \frac{1}{t^2} \int_{\mathbb{R}^3} V(x)|u|^2 dx + \frac{t^3}{2} N(u) - \Omega \int_{\mathbb{R}^3} \overline{u} L_z u dx \to -\infty
$$

as $t \to +\infty$, which imply that the usual global minimization method does not work. But due to the appearance of the harmonic potential $V(x)$, it seems to find a critical point of $E_{\Omega}|_{S(c)}$ by minimizing on a constructed sub-manifold of $S(c)$. In addition, a mountain pass type critical point will appear.

3.1 Existence of local minimizers

In this subsection, inspired by $[5, 22]$ $[5, 22]$, we introduce a local minimization problem, that is, for any given $r > 0$,

$$
m(c,r) := \inf_{u \in S(c) \cap B(r)} E_{\Omega}(u),\tag{3.1}
$$

where

$$
B(r) := \{ u \in \Sigma : \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx \le r \}.
$$

For any fixed $r > 0$, it is clear that $m(c, r) > -\infty$ if $S(c) \cap B(r) \neq \emptyset$. Then we will prove that $S(c) \cap B(r) \neq \emptyset$ (see Lemma [3.1\)](#page-10-0) and $m(c, r)$ is achieved by applying the compactness property (Lemma [2.2\)](#page-8-3). To conclude that this minimizer is indeed a critical point of $E_{\Omega}|_{S(c)}$, it suffices to exclude the possibility that this minimizer belong to the boundary of $S(c) \cap B(r)$. The corresponding procedures are stated as follows.

First, the proof of the set $S(c) \cap B(r)$ is not empty is given, which also implies that $m(c, r)$ is well-defined.

Lemma 3.1. Let $0 < \Omega < \Omega^*$. Then for any $r > 0$, there exists $r_1 > 0$ such that for all $0 < c < \frac{r}{r_1},$

$$
S(c) \cap B(r) \neq \emptyset.
$$

Proof. By [\(2.3\)](#page-7-1), we define $\Phi_c(x) := \sqrt{c} \Phi_0(x) \in S(c)$ and $r_1 := \int_{\mathbb{R}^3} |\nabla \Phi_0|^2 + |x|^2 |\Phi_0|^2 dx$. It is obvious that $\int_{\mathbb{R}^3} |\nabla \Phi_c|^2 + |x|^2 |\Phi_c|^2 dx = cr_1 < r$ for all $0 < c < \frac{r}{r_1}$. Thus, we have $\Phi_c(x) \in S(c) \cap B(r)$, and this completes the proof. \Box

Now, we prove the existence of local minimizers for $m(c, r)$ and obtain Theorem [1.1-](#page-3-1)(*i*). Proof of Theorem [1.1](#page-3-1) (existence of local minimizers). By Lemma [3.1,](#page-10-0) we know that for any given $r > 0$, $m(c, r) > -\infty$ for all $0 < c < \frac{r}{r_1}$. Let $\{u_n\} \subseteq S(c) \cap B(r)$ be a minimizing sequence for $m(c, r)$ satisfying $\lim_{n \to \infty} E_{\Omega}(u_n) = m(c, r)$, then $\{u_n\}$ is bounded in Σ . By Lemma [2.2,](#page-8-3) there exists $u_c \in \Sigma$ such that $u_n \rightharpoonup u_c$ in Σ , and $u_n \rightarrow u_c$ in L^p for $p \in [2, 6)$. Combining with the weakly lower semi-continuous of norm, one has $u_c \in S(c) \cap B(r)$. Moreover, by Lemma [2.4](#page-8-1) and the weakly lower semi-continuous of equivalent norm, we obtain that

$$
E_{\Omega}(u_c) \le \liminf_{n \to \infty} E_{\Omega}(u_n) = m(c, r) \le E_{\Omega}(u_c),
$$

which yields

$$
E_{\Omega}(u_c) = m(c, r)
$$

and $u_n \to u_c$ in Σ . Thus, u_c is a minimizer of $m(c, r)$ and any minimizing sequence of $m(c, r)$ is precompact. Next, in order to claim that u_c is a critical point of $E_{\Omega}|_{S(c)}$. We need to show that u_c is not on the boundary of $S(c) \cap B(r)$. Indeed, if $S(c) \cap (B(r) \backslash B(cr)) = \emptyset$ with $c < 1$, it is easy to see that $\mathcal{M}_c^r \subseteq B(cr)$, so $u_c \notin S(c) \cap \partial B(r)$, where

$$
\partial B(r) := \{ u \in \Sigma : |\nabla u|_2^2 + |x u|_2^2 = r \}.
$$

On the other hand, if $S(c) \cap (B(r) \backslash B(cr)) \neq \emptyset$ with $c < 1$, we claim that there exists some constant $\tilde{c}(r) > 0$ such that for any $0 < c < c_0 := \min\{1, \frac{r}{r_1}\}$ $\frac{r}{r_1}, \widetilde{c}(r)\},\$

$$
\inf_{u \in S(c) \cap B(\frac{C*}{5C^*}cr)} E_{\Omega}(u) < \inf_{u \in S(c) \cap (B(r) \setminus B(cr))} E_{\Omega}(u),\tag{3.2}
$$

where C_*, C^* are defined in Lemma [2.4.](#page-8-1) In fact, by Lemmas [2.1,](#page-8-4) [2.4,](#page-8-1) and (2.1) , one has

$$
E_{\Omega}(u) = \frac{1}{2} \int_{\mathbb{R}^3} |\nabla u|^2 dx + \int_{\mathbb{R}^3} V(x)|u|^2 dx + \frac{1}{2} N(u) - \Omega \int_{\mathbb{R}^3} \overline{u} L_z u dx
$$

\n
$$
\geq \frac{C_*}{2} \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx - \frac{\Lambda}{2} \int_{\mathbb{R}^3} |u|^4 dx
$$

\n
$$
\geq \frac{C_*}{2} \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx - \frac{\Lambda}{2} C_4^4 \left(\int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx \right)^{\frac{3}{2}} c^{\frac{1}{2}} \qquad (3.3)
$$

for any $u \in S(c)$. Further, by Lemmas [2.1,](#page-8-4) [2.4,](#page-8-1) and Sobolev embedding inequality, we also have

$$
E_{\Omega}(u) = \frac{1}{2} \int_{\mathbb{R}^3} |\nabla u|^2 dx + \int_{\mathbb{R}^3} V(x)|u|^2 dx + \frac{1}{2} N(u) - \Omega \int_{\mathbb{R}^3} \overline{u} L_z u dx
$$

\n
$$
\leq \frac{C^*}{2} \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx + \frac{\Lambda}{2} \int_{\mathbb{R}^3} |u|^4 dx
$$

\n
$$
\leq \frac{C^*}{2} \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx + \frac{\Lambda C}{2} \left(\int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx \right)^2.
$$
 (3.4)

Let

$$
f_c(\eta) := \frac{C_*}{2}\eta - \frac{\Lambda}{2}\mathcal{C}_4^4 c^{\frac{1}{2}}\eta^{\frac{3}{2}}
$$

and

$$
g_c(\eta) := \frac{C^*}{2}\eta + \frac{\Lambda C}{2}\eta^2,
$$

where $\eta := \int_{\mathbb{R}^3} |\nabla u|^2 + |x|^2 |u|^2 dx$ and C_*, C^* are defined in Lemma [2.4.](#page-8-1) Thus, for any $\eta \in (0, r)$, we obtain that

$$
f_c(\eta) \le E_{\Omega}(u) \le g_c(\eta).
$$

By the definition of $g_c(\eta)$, we know that $g_c(\eta)$ is monotonically increasing about $\eta \in (0, r)$. Thus, it is sufficient to prove that there exists $\tilde{c}(r) > 0$ such that for any $0 < c < \tilde{c}(r)$,

$$
g_c\left(\frac{C_*}{5C^*}cr\right) < \inf_{\eta \in (cr,r)} f_c(\eta). \tag{3.5}
$$

Noticing that for any $\eta \in (cr, r)$, one has

f_c(\eta) = \frac{C_*}{2}\eta - \frac{\Lambda}{2}C_4^4 c^{\frac{1}{2}}\eta^{\frac{3}{2}}

\geq \frac{C_*}{2}\eta \left(1 - \frac{\Lambda}{C_*}C_4^4 c^{\frac{1}{2}}r^{\frac{1}{2}}\right)
$$

\n
$$
> \frac{C_*}{4}\eta > \frac{C_*}{4}cr > 0
$$
\n(3.6)

provided that $c < c_1(r) := \frac{C_*^2}{4\Lambda^2 C_4^8 r}$. We further obtain that

$$
g_c\left(\frac{C_*}{5C^*}cr\right) = \frac{C_*cr}{10} + \frac{\Lambda C}{50}\left(\frac{C_*}{C^*}\right)^2 c^2 r^2 < \frac{C_*cr}{8} + \frac{C_*cr}{8} = \frac{C_*}{4}cr,
$$

if $c < c_2(r) := \frac{25(C^*)^2}{4\Lambda CC_{*}r}$ $\frac{23(C)}{4ACC*r}$. Thus we conclude that (3.5) holds for $c < \tilde{c}(r) = \min\{c_1(r), c_2(r)\}.$ Consequently, choosing

$$
c_0 := \min\{1, \frac{r}{r_1}, \tilde{c}(r)\},\tag{3.7}
$$

we can infer that [\(3.2\)](#page-10-1) holds for all $0 < c < c_0$. Now, in order to guarantee $u_c \notin S(c) \cap \partial B(r)$, we also prove that $\mathcal{M}_c^r \subseteq B(cr)$ with $c < c_0$. Assume by contradiction that there is a $\varphi \in \mathcal{M}_c^r$ but $\varphi \notin B(cr)$. It follows from [\(3.2\)](#page-10-1) that for any $c < c_0$,

$$
m(c,r) \leq \inf_{u \in S(c) \cap B(\frac{C*}{5C*}cr)} E_{\Omega}(u)
$$

$$
< \inf_{u \in S(c) \cap (B(r) \setminus B(cr))} E_{\Omega}(u)
$$

$$
\leq E_{\Omega}(\varphi) = m(c,r),
$$

which yields a contradiction. Thus, we have $\mathcal{M}_c^r \subseteq B(cr)$, and u_c is an interior local minimizer for $m(c, r)$. Namely, u_c is a critical point of $E_{\Omega}|_{S(c)}$ and there exists a corresponding Lagrange multiplier $\mu_c \in \mathbb{R}$.

In what follows, we estimate the bound of the multiplier μ_c , that is, [\(1.12\)](#page-3-3). We first give an upper bound of $m(c, r)$ from the spectral theory. Recall that $\Phi_c(x) = \sqrt{c} \Phi_0(x) \in S(c)$ and $\Phi_c \in S(c) \cap B(r)$ for $0 < c < \frac{r}{r_1}$. Moreover, one has $\int_{\mathbb{R}^3} \Omega \overline{\Phi_c} L_z \Phi_c dx = 0$ as Φ_c is real valued. By Lemma $2.1, (2.1)$ $2.1, (2.1)$ and (2.2) , we deduce that

$$
m(c,r) \le E_{\Omega}(\Phi_c) = \frac{1}{2} \int_{\mathbb{R}^3} |\nabla \Phi_c|^2 dx + \int_{\mathbb{R}^3} V(x) |\Phi_c|^2 dx + N(\Phi_c) - \Omega \int_{\mathbb{R}^3} \overline{\Phi_c} L_z \Phi_c dx
$$

\n
$$
\le c \left[\frac{1}{2} \int_{\mathbb{R}^3} |\nabla \Phi_0|^2 dx + \int_{\mathbb{R}^3} V(x) |\Phi_0|^2 dx \right] + \frac{\Lambda}{2} \int_{\mathbb{R}^3} |\Phi_c|^4 dx
$$

\n
$$
\le \zeta^0 c + \sqrt{2} \Lambda C_4^4 \left(\frac{1}{2} \int_{\mathbb{R}^3} |\nabla \Phi_0|^2 dx \right)^{\frac{3}{2}} c^2
$$

\n
$$
\le \zeta^0 c + \sqrt{2} \Lambda C_4^4 (\zeta^0)^{\frac{3}{2}} c^2,
$$
\n(3.8)

where $\zeta^0 = \frac{1}{2}$ $\frac{1}{2}$ \sum_{1}^{3} $\sum_{j=1}^{n} \gamma_j$. Note that $(u_c, \mu_c) \in \mathcal{M}_c^r \times \mathbb{R}$ weakly solves problem [\(1.5\)](#page-2-1). From Lemma [2.1,](#page-8-4) (2.1) and (3.8) , we derive that

$$
\mu_c |u_c|^2 = -\frac{1}{2} \int_{\mathbb{R}^3} |\nabla u_c|^2 dx - \int_{\mathbb{R}^3} V(x) |u_c|^2 dx - N(u_c) + \Omega \int_{\mathbb{R}^3} \overline{u}_c L_z u_c dx
$$

\n
$$
= -E_{\Omega}(u_c) - \frac{1}{2} N(u_c)
$$

\n
$$
\geq -m(c, r) - \frac{\Lambda}{2} \int_{\mathbb{R}^3} |u_c|^4 dx
$$

\n
$$
\geq -m(c, r) - \frac{\Lambda}{2} C_4^4 \left(\int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u_c|^2 dx \right)^{\frac{3}{2}} c^{\frac{1}{2}}
$$

\n
$$
\geq -\zeta^0 c - \sqrt{2} \Lambda C_4^4 (\zeta^0)^{\frac{3}{2}} c^2 - \frac{\Lambda}{2} C_4^4 r^{\frac{3}{2}} c^2
$$
\n(3.9)

due to $u_c \in \mathcal{M}_c^r \subseteq B(cr)$.

On the other hand, by Lemmas 2.1 , 2.4 and (2.1) , we have

$$
\mu_c |u_c|^2 = -\frac{1}{2} \int_{\mathbb{R}^3} |\nabla u_c|^2 dx - \int_{\mathbb{R}^3} V(x) |u_c|^2 dx - N(u_c) + \Omega \int_{\mathbb{R}^3} \overline{u}_c L_z u_c dx
$$

\n
$$
\leq -\frac{C_*}{2} \int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u_c|^2 dx + \Lambda \int_{\mathbb{R}^3} |u_c|^4 dx
$$

\n
$$
\leq -\frac{C_*}{2} \int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u_c|^2 dx + \Lambda C_4^4 \left(\int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u_c|^2 dx \right)^{\frac{3}{2}} c^{\frac{1}{2}}
$$

\n
$$
= \int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u_c|^2 dx \left[-\frac{C_*}{2} + \Lambda C_4^4 \left(\int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u_c|^2 dx \right)^{\frac{1}{2}} c^{\frac{1}{2}} \right]
$$

\n
$$
\leq \left[-\frac{C_*}{2} + \Lambda C_4^4 r^{\frac{1}{2}} c^{\frac{1}{2}} \right] \int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u_c|^2 dx,
$$

where $C_* = \min\{\frac{(\Omega^*)^2 - \Omega^2}{(\Omega^*)^2 + \Omega^2}, \frac{(\Omega^*)^2 - \Omega^2}{2}, \gamma_3^2\}$ defined in Lemma [2.4.](#page-8-1) Noticing that $0 < c < c_0$ (see [\(3.7\)](#page-12-0)), we obtain that $-\frac{C_*}{2} + \Lambda C_4^4 r^{\frac{1}{2}} c^{\frac{1}{2}} < 0$. Then we obtain from [\(2.2\)](#page-7-3) that

$$
\mu_c|u_c|^2 \le 3\left[-\frac{C_*}{2} + \Lambda \mathcal{C}_4^4 r^{\frac{1}{2}} c^{\frac{1}{2}}\right]c < 0
$$

for $0 < c < c_0$. Combining this with (3.9) , we conclude that for any $0 < c < c_0$,

-\zeta^{0} - \delta(r)c \le \mu_{c} \le 3\left[-\frac{C_{*}}{2} + \Lambda C_{4}^{4}r^{\frac{1}{2}}c^{\frac{1}{2}}\right],
$$

where $\delta(r) := \sqrt{2} \Lambda C_4^4 (\zeta^0)^{\frac{3}{2}} + \frac{\Lambda}{2}$ $\frac{\Lambda}{2} \mathcal{C}_4^4 r^{\frac{3}{2}}$. This completes the proof.

3.2 Existence of a second critical point of mountain pass type

Motivated by [\[18,](#page-32-12) [22\]](#page-32-11), in this subsection, we prove that the existence of a mountain pass solution to (1.5) . The proof is divided into several steps:

Step 1: $E_{\Omega}(u)$ has a local mountain pass geometry on $S(c)$.

By Theorem [1.1,](#page-3-1) there exists $u_c \in \mathcal{M}_c^r$ such that $E(u_c) = m(c, r)$. We consider the scaling given by

$$
u_t(x) = t^{\frac{5}{4}} u_c(tx_1, tx_2, t^{\frac{1}{2}}x_3), \quad t > 0,
$$

which implies that $u_t \in S(c)$ for all $t > 0$. Then, by a change of variable and $u_t^2 = \mathcal{F}(u_t)^2(\xi) =$ $\mathcal{F}u^{2}(\frac{\xi_{1}}{t}% ,\xi_{2})=-\frac{1}{\sqrt{2\pi}}\sum_{k=0}^{N}(\eta_{k}^{2}-\eta_{k}^{2})^{2}$ $\frac{\xi_1}{t}, \frac{\xi_2}{t}$ $\frac{\xi_2}{t}, \frac{\xi_3}{t}$ $\frac{13}{t}$, the energy functional rescales as

$$
E_{\Omega}(u_{t}) = \frac{t^{2}}{2} \int_{\mathbb{R}^{3}} |\nabla_{x_{1},x_{2}} u_{c}|^{2} dx + \frac{t}{2} \int_{\mathbb{R}^{3}} |\nabla_{x_{3}} u_{c}|^{2} dx + \frac{1}{2} \int_{\mathbb{R}^{3}} \left(\gamma_{1}^{2} \frac{x_{1}^{2}}{t^{2}} + \gamma_{2}^{2} \frac{x_{2}^{2}}{t^{2}} + \gamma_{3}^{2} \frac{x_{3}^{2}}{t} \right) |u_{c}|^{2} dx + \frac{t^{\frac{5}{2}}}{2} \frac{1}{(2\pi)^{3}} \int_{\mathbb{R}^{3}} \left(\lambda_{1} + \frac{4\pi}{3} \lambda_{2} \frac{2t\xi_{3}^{2} - t^{2}\xi_{1}^{2} - t^{2}\xi_{2}^{2}}{t^{2}\xi_{1}^{2} + t^{2}\xi_{2}^{2} + t\xi_{3}^{2}} \right) |\widehat{u_{c}}|^{2} d\xi - \int_{\mathbb{R}^{3}} \Omega \overline{u_{c}} L_{z} u_{c} dx.
$$

Recall that $(\lambda_1, \lambda_2) \in D_{ur}$, then if $\lambda_2 > 0$, we have

$$
\lim_{t \to \infty} \lambda_1 + \frac{4\pi}{3} \lambda_2 \frac{2t\xi_3^2 - t^2\xi_1^2 - t^2\xi_2^2}{t^2\xi_1^2 + t^2\xi_2^2 + t\xi_3^2} = \lambda_1 - \frac{4\pi}{3} \lambda_2 < 0.
$$

 \Box

It yields that $\lim_{t\to\infty} E_{\Omega}(u_t) = -\infty$ thanks to the Lebesgue's theorem. On the other hand, when λ_2 < 0, the same conclusion is obtained by choosing the scaling

$$
\widetilde{u}_t(x) = t^{\frac{5}{4}} u_c(t^{\frac{3}{4}} x_1, t^{\frac{3}{4}} x_2, tx_3), \quad t > 0.
$$

Thus, in both cases, the class of paths $\Gamma(c)$ can be defined as follows

$$
\Gamma(c) := \{ g \in C([0, 1], S(c)) : g(0) = u_c, E_{\Omega}(g(1)) < 0 \}.
$$
\n(3.10)

Note that $g(s) = (1 + (t-1)s)^{\frac{5}{4}}u_c((1 + (t-1)s)x_1, (1 + (t-1)s)x_2, (1 + (t-1)s^{\frac{1}{2}})x_3) \in \Gamma(c)$ with $t \gg 1$ if $\lambda_2 > 0$ and the case of $\lambda_2 < 0$ is similar. Then $\Gamma(c) \neq \emptyset$ and we can introduce a min-max value

$$
\gamma(c) := \inf_{g \in \Gamma(c)} \max_{0 \le s \le 1} E_{\Omega}(g(s)). \tag{3.11}
$$

Next, by (3.6) and $(3.10)-(3.11)$ $(3.10)-(3.11)$, we deduce that

$$
\gamma(c) > \max\{E_{\Omega}(u_c), E_{\Omega}(g(1))\} > 0. \tag{3.12}
$$

Step 2: Existence of bounded special Palais-Smale sequences.

In order to obtain a special Palais-Smale sequence, we introduce the auxiliary functional

$$
\widetilde{E}_{\Omega}: S(c) \times \mathbb{R} \to \mathbb{R} \quad (u, t) \to E_{\Omega}(\kappa(u, t)),
$$

where $\kappa(u,t) := e^{\frac{3}{2}t} u(e^t x)$. More precisely, we have

$$
\widetilde{E}_{\Omega}(u,t) = E_{\Omega}(\kappa(u,t)) = E_{\Omega}(e^{\frac{3}{2}t}u(e^tx)) \n= \frac{e^{2t}}{2} \int_{\mathbb{R}^3} |\nabla u|^2 dx + \frac{1}{e^{2t}} \int_{\mathbb{R}^3} V(x)|u|^2 dx + \frac{e^{3t}}{2} N(u) - \Omega \int_{\mathbb{R}^3} \overline{u} L_z u dx.
$$

Define the set of paths

$$
\widetilde{\Gamma}(c) := \{ \widetilde{g} \in C([0,1] \to S(c) \times \mathbb{R}) : \widetilde{g}(0) = (u_c, 0), \widetilde{g}(1) = (g(1), 0) \},
$$

and the corresponding of minimax value

$$
\widetilde{\gamma}(c) := \inf_{\widetilde{g} \in \widetilde{\Gamma}(c)} \max_{s \in [0,1]} \widetilde{E}_{\Omega}(\widetilde{g}(s)).
$$

We can infer that $\tilde{\gamma}(c) = \gamma(c)$. Indeed, since $\Gamma(c) \subseteq \tilde{\Gamma}(c)$, it directly yields that $\tilde{\gamma}(c) \leq \gamma(c)$. Then we only need to prove that $\tilde{\gamma}(c) \geq \gamma(c)$. This follows from the claim: for any $\tilde{g} \in \tilde{\Gamma}(c)$, there is a $q \in \Gamma(c)$ such that

$$
\max_{s \in [0,1]} \widetilde{E}_{\Omega}(\widetilde{g}(s)) = \max_{s \in [0,1]} E_{\Omega}(g(s)). \tag{3.13}
$$

Setting $\widetilde{g}(s) := (g_1(s), t) \in S(c) \times \mathbb{R}$, we get

$$
\widetilde{E}_{\Omega}(\widetilde{g}(s)) = \widetilde{E}_{\Omega}(g_1(s), t) = E_{\Omega}(\kappa(g_1(s), t))
$$

for all $s \in [0,1]$, which yields that $g(s) := \kappa(g_1(s), t) \in \Gamma(c)$. Namely, [\(3.13\)](#page-14-2) holds and then $\widetilde{\gamma}(c) = \gamma(c).$

Next, we give the following useful Lemma, which is crucial for obtaining the existence of bounded Palais-Smale sequence of E_{Ω} restricted to $S(c)$ at the level $\gamma(c)$, In particular, it can be obtained by [\[18,](#page-32-12) Lemma 2.3].

Denote $X := \Sigma \times \mathbb{R}$ endowed with the norm $\|\cdot\|_X^2 = \|\cdot\|_{\Sigma}^2 + |\cdot|_{\mathbb{R}}^2$ where $|r|_{\mathbb{R}} = |r|$ for $r \in \mathbb{R}$, and X^{-1} the dual space of X.

Lemma 3.2. Suppose that $(\lambda_1, \lambda_2) \in D_{ur}$ and let $\varepsilon > 0$ and $\widetilde{g}_0 \in \widetilde{\Gamma}(c)$ be such that

$$
\max_{s \in [0,1]} \widetilde{E}_{\Omega}(\widetilde{g}_0(s)) \le \widetilde{\gamma}(c) + \varepsilon.
$$

Then there exists a pair of $(u_0, t_0) \in S(c) \times \mathbb{R}$ such that

- $\widetilde{E}_{\Omega}(u_0,t_0) \in [\widetilde{\gamma}(c) \varepsilon, \widetilde{\gamma}(c) + \varepsilon];$
- \bullet min $\min_{s \in [0,1]} ||(u_0, t_0) - \widetilde{g}_0(s)||_X \leq \sqrt{\varepsilon};$
- $\|(\widetilde{E}_{\Omega}|_{S(c)\times\mathbb{R}})'(u_0,t_0)\|_{X^{-1}} \leq 2\sqrt{\varepsilon}$, that is

$$
|\langle \widetilde{E}'_\Omega(u_0,t_0),z\rangle_{X^{-1}\times X}|\leq 2\sqrt{\varepsilon}\|z\|_X
$$

for all
$$
z \in \widetilde{T}_{(u_0,t_0)} := \{(z_1,z_2) \in X : \langle u_0, z_1 \rangle = 0\}.
$$

Based on the above result, we can obtain the special Palais-Smale sequence for $\gamma(c)$.

Lemma 3.3. Suppose that $(\lambda_1, \lambda_2) \in D_{ur}$, $0 < \Omega < \Omega^*$, and $0 < c < c_0$ for c_0 defined in Theorem [1.1](#page-3-1). Then there exists a sequence $\{v_n\} \subseteq S(c)$ such that

$$
\begin{cases}\nE_{\Omega}(v_n) \to \gamma(c), \\
(E_{\Omega}|_{S(c)})'(v_n) \to 0, \\
Q(v_n) \to 0,\n\end{cases}
$$
\n(3.14)

as $n \to \infty$.

Proof. By the definition of $\gamma(c)$, there exists a $g_n \in \Gamma(c)$ such that

$$
\max_{s \in [0,1]} E_{\Omega}(g_n(s)) \le \gamma(c) + \frac{1}{n}.
$$

Note that $\widetilde{\gamma}(c) = \gamma(c)$. Letting $\widetilde{g}_n(s) = (g_n(s), 0) \in \widetilde{\Gamma}(c)$, one has $\max_{s \in [0,1]} \widetilde{E}_{\Omega}(\widetilde{g}_n(s)) \leq \widetilde{\gamma}(c) + \frac{1}{n}$. Then, by applying Lemma [3.2,](#page-15-0) we deduce that there exists a sequence $\{(u_n, t_n)\}\subseteq S(c) \times \mathbb{R}$ such that

- (i) $\widetilde{E}_{\Omega}(u_n, t_n) \in [\widetilde{\gamma}(c) - \frac{1}{n}, \widetilde{\gamma}(c) + \frac{1}{n}];$
- (ii) min $\min_{s \in [0,1]} || (u_n, t_n) - \tilde{g}_n(s) ||_X \le \sqrt{\frac{1}{n}};$
- (iii) $\|(\widetilde{E}_{\Omega} |_{S(c)\times \mathbb{R}})'(u_n, t_n)\|_{X^{-1}} \leq 2\sqrt{\frac{1}{n}},$ that is

$$
|\langle \widetilde{E}'_{\Omega}(u_n, t_n), z \rangle_{X^{-1} \times X}| \le 2\sqrt{\frac{1}{n}} \|z\|_X
$$

for all $z \in T_{(u_n,t_n)} := \{(z_1, z_2) \in X : \langle u_n, z_1 \rangle = 0\}.$

Denote $v_n = \kappa(u_n, t_n)$, then we claim that $\{v_n\} \subseteq S(c)$ satisfies [\(3.14\)](#page-15-1). In fact, since $E_{\Omega}(v_n) =$ $E_{\Omega}(\kappa(u_n,t_n)) = \widetilde{E}_{\Omega}(u_n,t_n)$ $E_{\Omega}(\kappa(u_n,t_n)) = \widetilde{E}_{\Omega}(u_n,t_n)$ $E_{\Omega}(\kappa(u_n,t_n)) = \widetilde{E}_{\Omega}(u_n,t_n)$, it follows from (i) that $E_{\Omega}(v_n) \to \gamma(c)$ as $n \to \infty$. By direct calculations, we have

$$
\frac{\partial E_{\Omega}(u_n, t_n)}{\partial t_n} = 2Q(v_n).
$$

Let $\frac{\partial E_{\Omega}(u_n,t_n)}{\partial t_n} = \langle \widetilde{E}'_{\Omega}(u_n,t_n),(0,1) \rangle_{X^{-1} \times X}$. Since $(0,1) \in \widetilde{T}_{(u_n,t_n)}$, then (iii) (iii) (iii) implies that $Q(v_n) \to 0$ as $n \to \infty$. Moreover, in order to verify that $(E_{\Omega}|_{S(c)})'(v_n) \to 0$ as $n \to \infty$, it suffices to claim that for $n \in \mathbb{N}$ sufficiently large that

$$
|\langle E_{\Omega}'(v_n), \varphi \rangle| \le \frac{2\sqrt{2}}{\sqrt{n}} \|\varphi\|_{\Sigma} \text{ for all } \varphi \in T_{v_n}, \tag{3.15}
$$

where $T_{v_n} := \{\varphi \in \Sigma : \langle v_n, \varphi \rangle = 0\}$. Now we prove the above claim. Set $\widetilde{\varphi} = \kappa(\varphi, -t_n)$ for any $\varphi \in T_{v_n} = {\varphi \in \Sigma : \langle v_n, \varphi \rangle = 0}$, then one has

$$
\langle E_{\Omega}'(v_n), \varphi \rangle = \langle \widetilde{E}_{\Omega}'(u_n, t_n), (\widetilde{\varphi}, 0) \rangle.
$$

Since $\int_{\mathbb{R}^3} u_n \widetilde{\varphi} dx = \int_{\mathbb{R}^3} v_n \varphi dx$, we obtain that $(\widetilde{\varphi}, 0) \in \widetilde{T}_{(u_n,t_n)} \Leftrightarrow \varphi \in T_{v_n}$. It follows from (iii) (iii) (iii) that

$$
|\langle E'_{\Omega}(v_n), \varphi \rangle| = |\langle \widetilde{E}'_{\Omega}(u_n, t_n), (\widetilde{\varphi}, 0) \rangle| \leq 2 \sqrt{\frac{1}{n}} ||(\widetilde{\varphi}, 0)||_X.
$$

Consequently, it is equivalent to prove that

$$
\|(\widetilde{\varphi},0)\|_X\leq \sqrt{2}\|\varphi\|_\Sigma
$$

for $n \in \mathbb{N}$ sufficiently large. From (ii) (ii) (ii) , one has

$$
|t_n| = |t_n - 0| \le \min_{s \in [0,1]} \|(u_n, t_n) - (g_n(s), 0)\|_X \le \sqrt{\frac{1}{n}},
$$

which yields that

$$
\begin{aligned} ||(\widetilde{\varphi},0)||_X^2 &= ||\widetilde{\varphi}||_{\Sigma}^2 = \int_{\mathbb{R}^3} |\nabla \widetilde{\varphi}|^2 + |x|^2 |\widetilde{\varphi}|^2 + |\widetilde{\varphi}|^2 dx \\ &= e^{-2t_n} \int_{\mathbb{R}^3} |\nabla \varphi|^2 dx + e^{2t_n} \int_{\mathbb{R}^3} |x|^2 |\varphi|^2 dx + \int_{\mathbb{R}^3} |\varphi|^2 dx \\ &\le 2 ||\varphi||_{\Sigma}^2 \end{aligned}
$$

for $n \in \mathbb{N}$ sufficiently large. This completes the proof.

Step 3: Existence of a mountain pass solution.

Now, we give the compactness of the Palais-Smale sequence obtained in Lemma [3.3.](#page-15-5)

Lemma 3.4. Suppose that $(\lambda_1, \lambda_2) \in D_{ur}$, $0 < \Omega < \frac{\sqrt{5}}{3} \Omega^*$, and $0 < c < c_0$ for c_0 defined in Theorem [1.1](#page-3-1). Let $\{v_n\} \subseteq S(c)$ obtained in Lemma [3.3](#page-15-5). Then, up to a subsequence,

- (i) there is $v \in \Sigma$ such that $v_n \rightharpoonup v$ weakly in Σ ;
- (ii) there is $\{\mu_n\} \subseteq \mathbb{R}$ such that $\text{Re}\left[E'_\Omega(v_n) + \mu_n v_n\right] \to 0$ in Σ^{-1} as $n \to \infty$;

 \Box

(iii) there is a constant $\hat{\mu} \in \mathbb{R}$ such that $\mu_n \to \hat{\mu}$ in \mathbb{R} and $\text{Re}\left[E'_{\Omega}(v) + \hat{\mu}v\right] = 0$ in Σ^{-1} as $n \to \infty$.

Proof. To claim that (i) holds, we first prove that $\{v_n\}$ is bounded in Σ . Note that $Q(v_n) \to 0$ as $n \to \infty$ and $0 < \Omega < \frac{\sqrt{5}}{3} \Omega^*$, then it follows from [\(2.6\)](#page-8-0) that

\gamma(c) + o_n(1)
$$

= $E_{\Omega}(v_n) - \frac{2}{3}Q(v_n) + o_n(1)$
= $\frac{1}{6} \int_{\mathbb{R}^3} |\nabla v_n|^2 dx + \frac{5}{6} \int_{\mathbb{R}^3} \sum_{j=1}^3 \gamma_j^2 x_j^2 |v_n|^2 dx - \int_{\mathbb{R}^3} \Omega \overline{v_n} L_z v_n dx + o_n(1)$

$$
\geq (\frac{1}{6} - \varepsilon) \int_{\mathbb{R}^3} |\nabla v_n|^2 dx + \int_{\mathbb{R}^3} \left[(\frac{5}{6}\gamma_1^2 - \frac{\Omega^2}{4\varepsilon})x_1^2 + (\frac{5}{6}\gamma_2^2 - \frac{\Omega^2}{4\varepsilon})x_2^2 + \frac{5}{6}\gamma_3^2 x_3^2 \right] |v_n|^2 dx + o_n(1).
$$

In view of the proof Lemma [2.4,](#page-8-1) we can choose $\varepsilon = \varepsilon_1 \in (\frac{3\Omega^2}{10(\Omega^*)^2}, \frac{1}{6})$ $\frac{1}{6}$) as $0 < \Omega < \frac{\sqrt{5}}{3} \Omega^*$ and then

$$
\widetilde{C}_1 := \frac{1}{6} - \varepsilon_1 > 0, \quad \widetilde{C}_2 := \frac{5}{6} (\Omega^*)^2 - \frac{\Omega^2}{4\varepsilon_1} > 0.
$$

Letting

$$
\widetilde{C} := \min\{\widetilde{C}_1, \widetilde{C}_2, \frac{5}{6}\gamma_3^2\},\
$$

we can obtain that

$$
\gamma(c) + o_n(1) \ge \tilde{C} \int_{\mathbb{R}^3} |\nabla v_n|^2 + |x|^2 |v_n|^2 dx.
$$
 (3.16)

Thus, $\{v_n\}$ is bounded in Σ . Then, up to a subsequence, (i) holds. Next, to obtain (ii), it suffices to claim that there exists $C > 0$ independent of $n \in \mathbb{N}$ such that

$$
|\text{Re}\langle E'_{\Omega}(v_n) - \frac{1}{c} \langle E'_{\Omega}(v_n), v_n \rangle v_n, z \rangle_{\Sigma^{-1} \times \Sigma}| \leq \frac{C}{\sqrt{n}} ||z||_{\Sigma}
$$
 (3.17)

for any $z \in \Sigma$. More specifically, we know that

$$
\operatorname{Re}\langle E'_{\Omega}(v_n) - \frac{1}{c} \langle E'_{\Omega}(v_n), v_n \rangle v_n, z \rangle_{\Sigma^{-1} \times \Sigma} = \operatorname{Re}\langle E'_{\Omega}(v_n), \widetilde{z}_n \rangle_{\Sigma^{-1} \times \Sigma}
$$
(3.18)

for any $z \in \Sigma$, where $\tilde{z}_n := z - \frac{1}{c} \langle v_n, z \rangle_{L^2(\mathbb{R}^3)} v_n$. It is easy to see that $\tilde{z}_n \in T_{v_n}$. Since $(E_{\Omega}|_{S(c)})'(v_n) \to 0$ as $n \to \infty$, it follows from (3.18) that

$$
|\text{Re}\langle E'_\Omega(v_n)-\frac{1}{c}\langle E'_\Omega(v_n),v_n\rangle v_n,z\rangle_{\Sigma^{-1}\times \Sigma}|\leq \frac{2\sqrt{2}}{\sqrt{n}}\|\widetilde{z}_n\|_{\Sigma}.
$$

By simple calculations, one has

\|\widetilde{z}_n\|_{\Sigma} = \|z - \frac{1}{c} \langle v_n, z \rangle_{L^2(\mathbb{R}^3)} v_n\|_{\Sigma}
$$

$$
\leq \|z\|_{\Sigma} + \frac{1}{c} |\langle v_n, z \rangle_{L^2(\mathbb{R}^3)}| \|v_n\|_{\Sigma}
$$

$$
\leq ||z||_{\Sigma} + \frac{|v_n|_2}{c} |z|_2 ||v_n||_{\Sigma}
$$

$$
\leq ||z||_{\Sigma} \left(1 + \frac{|v_n|_2}{c} ||v_n||_{\Sigma}\right).
$$

By applying the fact that $|v_n|^2 = c$ and $\{v_n\}$ is bounded in Σ , we deduce that (3.17) holds. Namely,

$$
\operatorname{Re}\left[\frac{1}{2}\int_{\mathbb{R}^3} \nabla v_n \cdot \nabla \overline{\varphi} + \int_{\mathbb{R}^3} V(x)v_n \overline{\varphi} dx + \frac{1}{2}\int_{\mathbb{R}^3} \lambda_1 |v_n|^2 v_n \overline{\varphi} + \lambda_2 (K * |v_n|^2) v_n \overline{\varphi} dx - \int_{\mathbb{R}^3} \Omega \overline{\varphi} L_z v_n dx + \mu_n \int_{\mathbb{R}^3} v_n \overline{\varphi} dx\right] \to 0
$$

as $n \to \infty$, where

$$
\mu_n = -\frac{1}{c} \langle E'_\Omega(v_n), v_n \rangle
$$

=
$$
-\frac{1}{c} \left[\frac{1}{2} \int_{\mathbb{R}^3} |\nabla v_n|^2 dx + \int_{\mathbb{R}^3} V(x) |v_n|^2 dx + \frac{1}{2} N(v_n) - \int_{\mathbb{R}^3} \Omega \overline{v_n} L_z v_n dx \right].
$$

Thus, (ii) holds. To the end, we prove that there is $\hat{\mu} \in \mathbb{R}$ such that, up to a subsequence, $\mu_n \to \hat{\mu}$ in R. By Lemmas [2.1](#page-8-4) and [2.4,](#page-8-1) we deduce that

$$
\mu_n c = -\left(\frac{1}{2}\int_{\mathbb{R}^3} |\nabla v_n|^2 dx + \int_{\mathbb{R}^3} V(x)|v_n|^2 dx + \frac{1}{2}N(v_n) - \int_{\mathbb{R}^3} \Omega \overline{v_n} L_z v_n dx\right),
$$

and then there is $\hat{\mu} \in \mathbb{R}$ such that, up to a subsequence, $\mu_n \to \hat{\mu}$ in R. Combining this with (ii) , it yields that Re $[E'_0(v) + \hat{\mu}v] = 0$ in Σ^{-1} as $n \to \infty$. This completes the proof. (*ii*), it yields that Re $[E'_{\Omega}(v) + \hat{\mu}v] = 0$ in Σ^{-1} as $n \to \infty$. This completes the proof. Proof of Theorem [1.1](#page-3-1) (existence of a second critical point). By the proof of Lemmas [3.3-](#page-15-5)[3.4,](#page-16-0) we obtain that a specific sequence $\{v_n\} \subseteq S(c)$ and $v_n \to v$ in Σ . Then, by Lemma [2.2,](#page-8-3) we have that

$$
v_n \to v \text{ in } L^p(\mathbb{R}^3), \ 2 \le p < 6. \tag{3.19}
$$

Further, by Lemma $3.4-(ii)$ $3.4-(ii)$ and (iii) , we deduce that

$$
\operatorname{Re}\langle E'(v_n) + \widehat{\mu}v_n, v_n - v \rangle = o_n(1), \quad \operatorname{Re}\langle E'(v) + \widehat{\mu}v, v_n - v \rangle = 0. \tag{3.20}
$$

By $[28, \text{Lemma } 8.1]$ and (3.19) as well as Lemma [2.4,](#page-8-1) we can deduce from (3.20) that

$$
o_n(1) = \frac{1}{2} \int_{\mathbb{R}^3} |\nabla (v_n - v)|^2 dx + \int_{\mathbb{R}^3} V(x) |v_n - v|^2 dx - \int_{\mathbb{R}^3} \Omega(\overline{v_n - v}) L_z(v_n - v) dx
$$

$$
\geq \frac{C_*}{2} \int_{\mathbb{R}^3} |\nabla (v_n - v)|^2 + |x|^2 |v_n - v|^2 dx,
$$

which implies that $v_n \to v$ in Σ . Therefore, we obtain a mountain pass solution $(v, \hat{\mu}) \in \Sigma \times \mathbb{R}$ to problem [\(1.5\)](#page-2-1) with $|v|^2 = c$. Taking into account [\(3.12\)](#page-14-3), one has

$$
E_{\Omega}(v) = \gamma(c) > E(u_c) = m(c, r).
$$

This completes the proof.

 \Box

3.3 Asymptotic properties and ground states

In this subsection, we give proof of Theorems [1.3](#page-4-3) and [1.5.](#page-4-1)

Proof of Theorem [1.3](#page-4-3). From Theorem [1.1,](#page-3-1) we know that for any fixed $r > 0$ and every $0 < c < c_0$,

$$
\mathcal{M}_c^r = \{ u \in S(c) \cap B(r) : E_{\Omega}(u) = m(c, r) \} \neq \emptyset.
$$

Letting $u \in \mathcal{M}_c^r$, we rewrite $u = u_1 + iu_2$, where u_1 is the real part and u_2 is the imaginary part of u. Motivated by [\[6,](#page-31-3) Theorem 2], we introduce the pure point spectrum λ_j of the harmonic oscillator $-\frac{1}{2}\Delta + \frac{|x|^2}{2}$ $\frac{c_1}{2}$ and the corresponding eigenfunction given by Hermite function ψ_j such that

$$
-\frac{1}{2}\Delta\psi_j + \frac{|x|^2}{2}\psi_j = \lambda_j\psi_j, \quad \int_{\mathbb{R}^3} |\psi_j|^2 dx = 1,
$$

$$
\lambda_j \le \lambda_{j+1}, \quad j = 0, 1, 2, \cdots.
$$

As is known to all, $\{\psi_j\}$ is a Hilbert basis for $L^2(\mathbb{R}^3, \mathbb{R})$ and $\lambda_j = \frac{3}{2} + j$ (see [\[2\]](#page-31-6)). By applying Fourier decomposition, one has

$$
u = \sum_{j\geq 0} \left(\int_{\mathbb{R}^3} u_1 \psi_j dx \right) \psi_j + i \sum_{j\geq 0} \left(\int_{\mathbb{R}^3} u_2 \psi_j dx \right) \psi_j = \sum_{j\geq 0} \varrho_j \psi_j \tag{3.21}
$$

with $\varrho_j = \int_{\mathbb{R}^3} u \psi_j dx$. So

$$
c = |u|_2^2 = \sum_{j\geq 0} \varrho_j \overline{\varrho}_j \int_{\mathbb{R}^3} |\psi_j|^2 dx = \sum_{j\geq 0} |\varrho_j|^2,
$$
 (3.22)

where $\overline{\varrho}_j$ is the conjugate of ϱ_j . In view of (3.8) , we obtain that

$$
E_{\Omega}(u) = m(c, r) \le \zeta^{0} c + \sqrt{2} \Lambda C_{4}^{4} (\zeta^{0})^{\frac{3}{2}} c^{2},
$$
\n(3.23)

where $\zeta^0 = \frac{1}{2}$ $\frac{1}{2}$ \sum_{1}^{3} $\sum_{j=1} \gamma_j$. Since $u \in \mathcal{M}_c^r \subseteq B(cr)$, it follows from [\(3.3\)](#page-11-2) that

$$
\zeta^{0}c + \sqrt{2}\Lambda \mathcal{C}_{4}^{4}(\zeta^{0})^{\frac{3}{2}}c^{2} \geq E_{\Omega}(u)
$$

\n
$$
\geq \frac{C_{*}}{2} \int_{\mathbb{R}^{3}} |\nabla u|^{2} + |x|^{2}|u|^{2} dx - \frac{\Lambda}{2} \mathcal{C}_{4}^{4} c^{2} r^{\frac{3}{2}}
$$

\n
$$
= C_{*} \sum_{j \geq 0} \lambda_{j} |\varrho_{j}|^{2} - \frac{\Lambda}{2} \mathcal{C}_{4}^{4} r^{\frac{3}{2}} c^{2},
$$

which yields that

$$
\sum_{j\geq 0} \lambda_j |\varrho_j|^2 \leq \frac{1}{C_*} \left(\zeta^0 c + \delta(r) c^2 \right). \tag{3.24}
$$

Here $\delta(r) := \sqrt{2\Lambda} C_4^4 (\zeta^0)^{\frac{3}{2}} + \frac{\Lambda}{2}$ $\frac{\Lambda}{2}C_4^4r^{\frac{3}{2}}$ and $C_* = \min\{\frac{(\Omega^*)^2 - \Omega^2}{(\Omega^*)^2 + \Omega^2}, \frac{(\Omega^*)^2 - \Omega^2}{2}, \gamma_3^2\}$ defined in Lemma [2.4.](#page-8-1) By the definition of $\|\cdot\|_{\Sigma}$ and (3.21) , (3.24) , we conclude that

$$
\frac{1}{2}||u - \varrho_0 \psi_0||_{\Sigma}^2 = \sum_{j \ge 1} \lambda_j |\varrho_j|^2 \le \frac{1}{C_*} \left(\zeta^0 c + \delta(r) c^2 \right),
$$

which implies that

$$
\sup_{u \in \mathcal{M}_c^r} \|u - \varrho_0 \psi_0\|_{\Sigma}^2 \le \frac{2}{C_*} \left[\zeta^0 c + \left(\sqrt{2} \Lambda \mathcal{C}_4^4 (\zeta^0)^{\frac{3}{2}} + \frac{\Lambda}{2} \mathcal{C}_4^4 r^{\frac{3}{2}} \right) c^2 \right].
$$

Thus

$$
\sup_{u \in \mathcal{M}_c^r} \|u - \varrho_0 \psi_0\|_{\dot{\Sigma}}^2 = O(c + c^2).
$$

Further, we deduce from (3.22) and (3.24) that

$$
\inf_{j\geq 1} \lambda_j \left(1 - \frac{|\varrho_0|^2}{c}\right) \leq \lambda_0 \left(\frac{\zeta^0}{C_*\lambda_0} - \frac{|\varrho_0|^2}{c}\right) + \frac{1}{C_*}\delta(r)c.
$$

Setting $\zeta^0 = C_* \lambda_0$, i.e., $\zeta^0 = \frac{3C_*}{2}$ $\frac{C_*}{2}$, we have

$$
\inf_{j\geq 1} (\lambda_j - \lambda_0) \left(\frac{\zeta^0}{C_* \lambda_0} - \frac{|\varrho_0|^2}{c} \right) \leq \frac{1}{C_*} \delta(r) c. \tag{3.25}
$$

 \Box

Using [\(3.24\)](#page-19-1) again, we conclude that

$$
\frac{\frac{1}{2}||u - \varrho_0 \psi_0||_{\Sigma}^2}{c} = \sum_{j \ge 1} \lambda_j \frac{|\varrho_j|^2}{c}
$$

$$
= \sum_{j \ge 0} \lambda_j \frac{|\varrho_j|^2}{c} - \lambda_0 \frac{|\varrho_0|^2}{c}
$$

$$
\le \frac{1}{C_*} \zeta^0 + \frac{1}{C_*} \delta(r) c - \lambda_0 \frac{|\varrho_0|^2}{c}
$$

$$
\le \lambda_0 \left(\frac{\zeta^0}{C_* \lambda_0} - \frac{|\varrho_0|^2}{c}\right) + \frac{1}{C_*} \delta(r) c.
$$

It follows that

$$
\sup_{u \in \mathcal{M}_c^r} \frac{\|u - \varrho_0 \psi_0\|_{\Sigma}^2}{c} \le \left(\frac{\lambda_0}{\inf_{j \ge 1} (\lambda_j - \lambda_0)} + 1\right) \frac{2}{C_*} \delta(r) c,
$$

that is, [\(1.14\)](#page-4-0) holds. This completes the proof.

In the following, we prove Theorem [1.5.](#page-4-1)

Proof of Theorem [1.5.](#page-4-1) We first claim that $u_c \to 0$ in Σ as $c \to 0^+$. Since $(u_c, \mu_c) \in \mathcal{M}_c^r \times \mathbb{R}^{-}$ is a couple solution to (1.5) , we have

$$
\frac{1}{2} \int_{\mathbb{R}^3} |\nabla u_c|^2 dx + \int_{\mathbb{R}^3} V(x) |u_c|^2 dx + N(u_c) - \Omega \int_{\mathbb{R}^3} \overline{u}_c L_z u_c dx + \mu_c \int_{\mathbb{R}^3} |u_c|^2 dx = 0. \tag{3.26}
$$

By Lemma [2.4](#page-8-1) and $\mu_c < 0$ with $0 < c < c_0$, the energy functional $E_{\Omega}(u)$ can be rewritten as

$$
E_{\Omega}(u_c) = \frac{1}{4} \int_{\mathbb{R}^3} |\nabla u_c|^2 dx + \frac{1}{2} \int_{\mathbb{R}^3} V(x) |u_c|^2 dx - \frac{1}{2} \Omega \int_{\mathbb{R}^3} \overline{u}_c L_z u_c dx - \frac{\mu_c}{2} \int_{\mathbb{R}^3} |u_c|^2 dx
$$

$$
\geq \frac{C_*}{4} \int_{\mathbb{R}^3} |\nabla u_c|^2 + |x|^2 |u|^2 dx.
$$

It follows from [\(3.8\)](#page-12-1) that

$$
E_{\Omega}(u_c) = m(c, r) \le \zeta^0 c + \sqrt{2}\Lambda \mathcal{C}_4^4 (\zeta^0)^{\frac{3}{2}} c^2,
$$

where $\zeta^0 = \frac{1}{2} \sum_{i=1}^3$ $j=1$ γ_j . It yields that

$$
\frac{C_{*}}{4} \int_{\mathbb{R}^{3}} |\nabla u_{c}|^{2} + |x|^{2} |u_{c}|^{2} dx \leq \zeta^{0} c + \sqrt{2} \Lambda \mathcal{C}_{4}^{4} (\zeta^{0})^{\frac{3}{2}} c^{2} \to 0
$$

as $c \to 0^+$. Namely, $u_c \to 0$ in Σ as $c \to 0^+$.

According to [\(1.12\)](#page-3-3), we know that

$$
-\zeta^{0} - \delta(r)c \le \mu_{c} \le 3\left[-\frac{C_{*}}{2} + \Lambda C_{4}^{4}r^{\frac{1}{2}}c^{\frac{1}{2}}\right]
$$

for $0 < c < c_0$, where $\zeta^0 = \frac{1}{2}$ $\frac{1}{2}$ \sum_{1}^{3} $j=1$ γ_j and $\delta(r) = \sqrt{2\Lambda} C_4^4 (\zeta^0)^{\frac{3}{2}} + \frac{\Lambda}{2}$ $\frac{\Lambda}{2} \mathcal{C}_4^4 r^{\frac{3}{2}}$. Then there exists a constant $\mu_0 \in [-\zeta^0, -\frac{3C_*}{2}]$ $\frac{C_*}{2}$ such that $\mu_c \to \mu_0$ as $c \to 0^+$. By Lemma [2.1,](#page-8-4) [\(2.1\)](#page-7-2) and the fact that $u_c \in B(cr)$, we have

$$
0 < \frac{|N(u_c)|}{|u_c|_2^2} \le \frac{\Lambda |u_c|_4^4}{|u_c|_2^2} \le \frac{\Lambda C_4^4 |\nabla u_c|_2^3}{|u_c|_2} \le \Lambda C_4^4 r^{\frac{3}{2}} c \to 0 \tag{3.27}
$$

as $c \to 0^+$. Note that u_c satisfies the Pohozaev identity [\(2.5\)](#page-8-2), i.e., $Q(u_c) = 0$. Set $w_c := \frac{u_c}{|u_c|_2}$, then we can deduce that

$$
0 = \frac{Q(u_c)}{|u_c|_2^2} = \frac{1}{2} \int_{\mathbb{R}^3} |\nabla w_c|^2 dx - \int_{\mathbb{R}^3} V(x) |w_c|^2 dx + \frac{3}{4} \frac{N(u_c)}{|u_c|_2^2},
$$

which yields that lim $c\rightarrow 0^+$ $\int_{\mathbb{R}^3} |\nabla w_c|^2 dx = \lim_{\epsilon \to 0^-}$ $c\rightarrow 0^+$ $\int_{\mathbb{R}^3} 2V(x)|w_c|^2 dx$. From [\(3.26\)](#page-20-0) and [\(3.27\)](#page-21-0), we infer that

$$
\lim_{c \to 0^{+}} \mu_{c} = \lim_{c \to 0^{+}} \left[-\frac{1}{2} \int_{\mathbb{R}^{3}} |\nabla w_{c}|^{2} + 2V(x)|w_{c}|^{2} dx + \int_{\mathbb{R}^{3}} \Omega \overline{w}_{c} L_{z} w_{c} dx - \frac{N(u_{c})}{|u_{c}|_{2}^{2}} \right]
$$
\n
$$
= \lim_{c \to 0^{+}} \left[-\frac{1}{2} \int_{\mathbb{R}^{3}} |\nabla w_{c}|^{2} + 2V(x)|w_{c}|^{2} dx + \int_{\mathbb{R}^{3}} \Omega \overline{w}_{c} L_{z} w_{c} dx \right].
$$

Similarly, by [\(3.27\)](#page-21-0), one has

$$
\lim_{c \to 0^+} \frac{m(c, r)}{c} = \lim_{c \to 0^+} \left[\frac{1}{2} \int_{\mathbb{R}^3} |\nabla w_c|^2 + 2V(x)|w_c|^2 dx - \int_{\mathbb{R}^3} \Omega \overline{w}_c L_z w_c dx - \frac{1}{2} \frac{N(u_c)}{|u_c|_2^2} \right]
$$

=
$$
\lim_{c \to 0^+} \left[\frac{1}{2} \int_{\mathbb{R}^3} |\nabla w_c|^2 + 2V(x)|w_c|^2 dx - \int_{\mathbb{R}^3} \Omega \overline{w}_c L_z w_c dx \right].
$$

Therefore, we conclude that

$$
\lim_{c \to 0^+} \frac{m(c, r)}{c} = \lim_{c \to 0^+} -\mu_c = -\mu_0
$$

and

$$
\lim_{c\to 0^+} \frac{\int_{\mathbb{R}^3} |\nabla u_c|^2 dx - \int_{\mathbb{R}^3} \Omega \overline{u}_c L_z u_c dx}{c} = \lim_{c\to 0^+} \frac{\int_{\mathbb{R}^3} 2V(x) |u_c|^2 dx - \int_{\mathbb{R}^3} \Omega \overline{u}_c L_z u_c dx}{c} = -\mu_0.
$$

Finally, it remains to prove the local minimizer u_c is a ground state if $0 < \Omega < \frac{\sqrt{5}}{3} \min\{\gamma_1,\gamma_2\}$ and $c > 0$ sufficiently small. Suppose by contradiction that there exists $v \in S(c)$ such that

$$
(E_{\Omega}|_{S(c)})'(v) = 0 \text{ and } E_{\Omega}(v) < m(c, r).
$$

Then we can infer that $Q(v) = 0$, where

$$
Q(v) = \frac{1}{2} \int_{\mathbb{R}^3} |\nabla v|^2 dx - \int_{\mathbb{R}^3} V(x)|v|^2 dx + \frac{3}{4} \int_{\mathbb{R}^3} \lambda_1 |v|^4 + \lambda_2 (K * |v|^2)|v|^2 dx.
$$

Similar to the proof of (3.16) , we conclude that

$$
E_{\Omega}(v) \ge \tilde{C} \int_{\mathbb{R}^3} |\nabla v|^2 + |x|^2 |v|^2 dx.
$$
\n(3.28)

Combining this with [\(3.8\)](#page-12-1), we obtain that

$$
\widetilde{C} \int_{\mathbb{R}^3} |\nabla v|^2 + |x|^2 |v|^2 dx \le E_{\Omega}(v) < m(c, r) \le \xi^0 c + \sqrt{2} \Lambda \mathcal{C}_4^4 (\xi^0)^{\frac{3}{2}} c^2 \to 0,
$$

as $c \to 0$. This yields that $v \in B(r)$ for c small enough. By the definition of $m(c, r)$, we have $E_0(v) \geq m(c, r)$, which contradicts $E_0(v) \leq m(c, r)$. This completes the proof. $E_{\Omega}(v) \geq m(c,r)$, which contradicts $E_{\Omega}(v) < m(c,r)$. This completes the proof.

4 The critical rotational speed

In this section, we mainly consider the case of $0 < \Omega = \Omega^*$ (the critical rotational speed) and investigate the existence of normalized solutions for [\(1.5\)](#page-2-1). Namely, the proof of Theorem [1.7](#page-6-0) is given.

Since $(\lambda_1, \lambda_2) \in \mathbb{R}^2$ satisfies (1.20) , the dipolar term $N(u) < 0$, which is L^2 -supercritical. A standard scaling argument implies that the energy functional $E_{\Omega^*}(u)$ is no longer bounded from below on $S(c)$. Motivated by [\[6\]](#page-31-3), we study the following local minimization problem: for any given $\rho > 0$,

$$
m_{\Omega^*}(c,\rho) := \inf \{ E_{\Omega^*}(u) : u \in S(c) \cap B_{\Omega^*}(\rho) \}, \quad c > 0,
$$
\n(4.1)

where $S(c) = \{u \in \Sigma_{\Omega^*} : |u|_2^2 = c\}$ and

$$
B_{\Omega^*}(\rho) := \left\{ u \in \Sigma_{\Omega^*} : \int_{\mathbb{R}^3} |(\nabla - iA)u|^2 + 2V_{\Omega^*}(x)|u|^2 dx \le \rho \right\}.
$$
 (4.2)

As we will see, the existence of minimizers of $m_{\Omega^*}(c,\rho)$ can be established by applying the concentration-compactness principle. We first introduce the following lemma, which plays a important role in excluding the vanishing scenario.

Lemma 4.1. Let $\{u_n\}$ be a sequence of E_{Ω^*} in Σ_{Ω^*} . Suppose that

$$
\sup_{n\geq 1} \|u_n\|_{\Sigma_{\Omega^*}} < \infty,\tag{4.3}
$$

and there is $\varepsilon_0 > 0$ such that

$$
\inf_{n\geq 1} \int_{\mathbb{R}^3} |u_n|^4 dx \geq \varepsilon_0 > 0. \tag{4.4}
$$

Then there exist $u \in \Sigma_{\Omega^*}\setminus\{0\}$ and $\{z_n\} \subseteq \mathbb{R}^3$ with $z_n = (0, z_n^2, 0)$ such that, up to a subsequence,

$$
w_n(x) := e^{iA(z_n)\cdot x} u_n(x+z_n) \rightharpoonup u \quad \text{in} \quad \Sigma_{\Omega^*}.
$$

Proof. By the Hölder's inequality and Sobolev embedding theorem, we obtain that

$$
\int_{T_k} |u_n|^4 dx \le \left(\int_{T_k} |u_n|^2 dx \right)^{\frac{1}{2}} \left(\int_{T_k} |u_n|^6 dx \right)^{\frac{1}{2}}
$$

$$
\le C |u_n|_{L^2(T_k)} \left(\int_{T_k} |\nabla |u_n||^2 + |u_n|^2 dx \right)^{\frac{3}{2}},
$$

where

$$
T_k := \mathbb{R} \times (k, k+1) \times \mathbb{R}, \ \ k \in \mathbb{Z}.
$$

Taking a sum over $k \in \mathbb{Z}$, it follows from the diamagnetic inequality [\(1.19\)](#page-6-2) that

$$
\int_{\mathbb{R}^3} |u_n|^4 dx \le C \left(\sup_{k \in \mathbb{Z}} |u_n|_{L^2(T_k)} \right) \left(\int_{\mathbb{R}^3} |\nabla |u_n||^2 + |u_n|^2 dx \right)^{\frac{3}{2}} \n\le C \left(\sup_{k \in \mathbb{Z}} |u_n|_{L^2(T_k)} \right) \left(\int_{\mathbb{R}^3} |(\nabla - iA)u_n|^2 + |u_n|^2 dx \right)^{\frac{3}{2}}.
$$
\n(4.5)

Taking account of [\(4.3\)](#page-22-3)-[\(4.4\)](#page-22-4), we derive from [\(4.5\)](#page-23-0) that there is $\{k_n\} \subseteq \mathbb{Z}$ such that

$$
\inf_{n\geq 1} \int_{T_{k_n}} |u_n|^2 dx \geq C > 0
$$
\n(4.6)

for some constant $C > 0$. Next, we can prove that up to a subsequence if necessary, there exist $u \in \Sigma_{\Omega^*} \backslash \{0\}$ and $\xi_n := (0, k_n, 0)$ with $k_n \in \mathbb{Z}$ such that

$$
e^{iA(\xi_n)\cdot x}u_n(x+\xi_n)\rightharpoonup u \quad \text{in} \quad \Sigma_{\Omega^*},\tag{4.7}
$$

where $A(\xi_n) = \Omega^*(-k_n, 0, 0)$. In fact, by [\(4.3\)](#page-22-3) and [\(4.6\)](#page-23-1), we deduce that

$$
\int_{T_0} |e^{iA(\xi_n)\cdot x} u_n(x+\xi_n)|^2 dx = \int_{T_{k_n}} |u_n|^2 dx \ge C > 0,
$$
\n(4.8)

and

$$
\sup_{n\geq 1} \int_{T_0} |(\nabla - iA)u_n(x + \xi_n)e^{iA(\xi_n)\cdot x}|^2 + 2V_{\Omega^*}(x)|u_n(x + \xi_n)e^{iA(\xi_n)\cdot x}|^2 + |u_n(x + \xi_n)e^{iA(\xi_n)\cdot x}|^2 dx
$$

=
$$
\sup_{n\geq 1} \int_{T_{k_n}} |(\nabla - iA)u_n|^2 + 2V_{\Omega^*}(x)|u_n(x)|^2 + |u_n(x)|^2 dx < +\infty,
$$

where $T_{k_n} = \mathbb{R} \times (k_n, k_n + 1) \times \mathbb{R}$, $k_n \in \mathbb{Z}$ and $T_0 = \mathbb{R} \times (0, 1) \times \mathbb{R}$. Hence up to a subsequence if necessary, there exists a $u \in \Sigma_{\Omega^*}$ such that

$$
e^{iA(\xi_n)\cdot x}u_n(x+\xi_n)\rightharpoonup u
$$
 in Σ_{Ω^*} as $n\to\infty$.

By the Sobolev compact embedding theorem, we have that

$$
e^{iA(\xi_n)\cdot x}u_n(x+\xi_n)\to u\quadtext{in }L^2_{loc}(T_0)\text{ as }n\to\infty,
$$
\n(4.9)

where $T_0 = \mathbb{R} \times (0, 1) \times \mathbb{R}$. Note that for any $\varepsilon > 0$, there exists a constant $R > 0$ such that

$$
\frac{1}{|x|^2} \le \varepsilon \text{ for } |x| \ge R. \tag{4.10}
$$

From [\(4.9\)](#page-23-2), we obtain that for the fixed $R > 0$,

$$
e^{iA(\xi_n)\cdot x}u_n(x+\xi_n)\to u
$$
 in $L^2(T_0\cap B_R(0))$ as $n\to\infty$.

It yields that there is a positive integer N such that

$$
\int_{T_0 \cap B_R(0)} |e^{iA(\xi_n) \cdot x} u_n(x + \xi_n) - u|^2 dx \leq \varepsilon \text{ for } n \geq N.
$$

Combining [\(4.3\)](#page-22-3) and [\(4.10\)](#page-23-3), we conclude that for $n \geq N$,

\int_{T_0} |e^{iA(\xi_n)\cdot x}u_n(x+\xi_n) - u|^2 dx = \int_{T_0 \cap B_R(0)} |e^{iA(\xi_n)\cdot x}u_n(x+\xi_n) - u|^2 dx

+
$$
\int_{T_0 \setminus (T_0 \cap B_R(0))} |e^{iA(\xi_n)\cdot x}u_n(x+\xi_n) - u|^2 dx
$$

$$
\leq \varepsilon + \varepsilon \int_{T_0 \setminus (T_0 \cap B_R(0))} |x|^2 |e^{iA(\xi_n)\cdot x}u_n(x+\xi_n) - u|^2 dx
$$

$$
\leq \varepsilon + \varepsilon \int_{T_0 \setminus (T_0 \cap B_R(0))} (x_1^2 + 1 + x_3^3) |e^{iA(\xi_n)\cdot x}u_n(x+\xi_n) - u|^2 dx
$$

$$
\leq C\varepsilon,
$$

which implies that $e^{iA(\xi_n)\cdot x}u_n(x+\xi_n)\to u$ in $L^2(T_0)$. In view of [\(4.8\)](#page-23-4), one has $u\neq 0$, which implies that the claim [\(4.7\)](#page-23-5) holds. This completes the proof. \Box

In the following, we introduce the L^2 -bound of the magnetic Sobolev norm, which comes from [\[16,](#page-32-13) Proposition 2.2 and Remark 2.5].

Proposition 4.2. Let $A = (A_1, ..., A_N) \in W_{loc}^{1,\infty}(\mathbb{R}^N, \mathbb{R}^N)$ and $j, k \in \{1, ..., N\}$. Then for any $u \in C_0^{\infty}(\mathbb{R}^N)$, we have

$$
\left| \int_{\mathbb{R}^N} (\partial_j A_k - \partial_k A_j) u \overline{u} dx \right| \leq |(\partial_j - i A_j)u|_2^2 + |(\partial_k - i A_k)u|_2^2.
$$

In particular, if $N = 3$ and $A(x) = \Omega^*(-x_2, x_1, 0)$, then for any $u \in C_0^{\infty}(\mathbb{R}^3)$, we have

$$
2\Omega^* |u|_2^2 \le |(\partial_1 - iA_1)u|_2^2 + |(\partial_2 - iA_2)u|_2^2.
$$
\n(4.11)

Moreover, if $N = 2$, then [\(4.11\)](#page-24-0) is achieved by $u(x) = \sqrt{\frac{\Omega^*}{\pi}} e^{-\frac{\Omega^*}{2}|x|^2}$.

In order to apply the Lemma [4.1](#page-22-5) to guarantee the non-vanishing of the minimizing sequences up to translation, we need to prove the following result.

Lemma 4.3. Let $\{u_n\}$ be a minimizing sequence for $m_{\Omega^*}(c, \rho)$. Then for any given $\rho > 0$, there exist constants $\delta > 0$ and $c_0(\rho) > 0$ depending on ρ such that

$$
\liminf_{n \to \infty} |N(u_n)| > \delta > 0 \text{ for all } 0 < c < c_0(\rho).
$$

Proof. We assume by contradiction that the minimizing sequence $\{u_n\}$, up to a subsequence, satisfies that $\lim_{n\to\infty} |N(u_n)| = 0$. Denote $x = (x_1, x_2, x_3) \in \mathbb{R}^3$ and $A(x) = (A_1, A_2, A_3)$. By the definition of $A(x)$, we know that $A_1 = -\Omega^* x_2$, $A_2 = \Omega^* x_1$ and $A_3 = 0$. Set

$$
\zeta_{\Omega^*}^0 := \inf \left\{ \frac{1}{2} \int_{\mathbb{R}^3} |(\nabla - iA)u|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|u|^2 dx : u \in \Sigma_{\Omega^*}, |u|_2^2 = 1 \right\},\tag{4.12}
$$

where $V_{\Omega^*}(x) = \frac{1}{2}(\gamma_1^2 - \gamma_2^2)x_1^2 + \frac{1}{2}$ $\frac{1}{2}\gamma_3^2 x_3^2$ with $\Omega^* = \gamma_2$. Inspired by [\[6,](#page-31-3) Lemma 2.1], we first claim that

$$
\zeta_{\Omega^*}^0 \ge \gamma_2 + \frac{\gamma_3}{2}.\tag{4.13}
$$

To this end, we introduce a Hilbert basis $\Phi_k(x_3)$ of $L^2(\mathbb{R})$ and λ_k for $k \geq 0$ such that

-\frac{1}{2}\Delta_{x_3}\Phi_k + \frac{1}{2}\gamma_3^2x_3^2\Phi_k = \lambda_k\Phi_k, \quad \int_{\mathbb{R}} |\Phi_k|^2 dx_3 = 1,

\lambda_k \le \lambda_{k+1}, \quad k = 0, 1, 2, \cdots.
$$

It follows from [\(2.2\)](#page-7-3) that $\lambda_0 = \frac{\gamma_3}{2}$ $\frac{1}{2}$. By the Fourier decomposition, we have

v(x) = \sum_{k \ge 0} v_k(x_1, x_2) \Phi_k(x_3).
$$
 (4.14)

Let $|v|^2 = 1$, then

$$
1 = \int_{\mathbb{R}^3} |v(x)|^2 dx = \sum_{k \ge 0} \left(\int_{\mathbb{R}^2} |v_k|^2 dx_1 dx_2 \right) \left(\int_{\mathbb{R}} |\Phi_k|^2 dx_3 \right)
$$

$$
= \sum_{k \ge 0} \int_{\mathbb{R}^2} |v_k|^2 dx_1 dx_2.
$$
(4.15)

From [\(4.14\)](#page-25-0), [\(4.15\)](#page-25-1) and Proposition [4.2,](#page-24-1) we deduce that

$$
\frac{1}{2} \int_{\mathbb{R}^3} |(\nabla - iA)v|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|v|^2 dx \n= \frac{1}{2} \sum_{j=1}^2 \int_{\mathbb{R}^3} \left| \left(\frac{\partial}{\partial x_j} - iA_j \right) v \right|^2 dx + \frac{1}{2} \int_{\mathbb{R}^3} \left| \frac{\partial v}{\partial x_3} \right|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}|v|^2 dx \n= \frac{1}{2} \sum_{k \ge 0} \sum_{j=1}^2 \int_{\mathbb{R}^2} \left| \left(\frac{\partial}{\partial x_j} - iA_j \right) v_k \right|^2 dx_1 dx_2 + \frac{1}{2} \sum_{k \ge 0} \int_{\mathbb{R}} \left| \frac{\partial \Phi_k}{\partial x_3} \right|^2 + \gamma_3^2 x_3^2 |\Phi_k|^2 dx_3 \n+ \frac{1}{2} \int_{\mathbb{R}^3} (\gamma_1^2 - \gamma_2^2) x_1^2 |v|^2 dx \n\ge \Omega^* + \frac{1}{2} \sum_{k \ge 0} \int_{\mathbb{R}} \lambda_k |\Phi_k|^2 dx_3 \n\ge \Omega^* + \frac{1}{2} \lambda_0 \sum_{k \ge 0} \int_{\mathbb{R}} |\Phi_k|^2 dx_3 = \gamma_2 + \frac{\gamma_3}{2},
$$

which yields that [\(4.13\)](#page-25-2) holds. It follows that

= $\frac{1}{2} \int_{\mathbb{R}^3} |(\nabla - iA)u_n|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|u_n|^2 dx + o_n(1)$
 $\ge \zeta_{\Omega^*}^0 |u_n|^2 + o_n(1) \ge (\gamma_2 + \frac{\gamma_3}{2})c.$ (4.16)

Next, in order to establish a contradiction, we take $u_0(x_1, x_2) := \sqrt{\frac{\Omega^*}{\pi}} e^{-\frac{\Omega^*}{2}(x_1^2 + x_2^2)}$. Clearly, $|u_0(x_1, x_2)|_2^2 = 1$ and

due to Proposition [4.2.](#page-24-1) Set $\varphi_c(x_3) := \sqrt{c} \Phi_0(x_3)$, where $\Phi_0(x_3) \in \Sigma(\mathbb{R})$ is as in [\(2.3\)](#page-7-1), that is, $\Phi_0(x_3) = \left(\frac{\gamma_3}{\pi}\right)$ $(\frac{\pi}{2})^{\frac{1}{4}}e^{-\frac{\gamma_3}{2}x_3^2}$. Then the direct calculation implies that

$$
+ \int_{\mathbb{R}^3} V_{\Omega^*}(x)|v_c|^2 dx + \frac{1}{2}N(v_c)
$$

\n
$$
= \frac{1}{2} \int_{\mathbb{R}^2} \left| \left(\frac{\partial}{\partial x_1} - iA_1 \right) u_0(x_1, x_2) \right|^2 dx_1 dx_2 \int_{\mathbb{R}} |\varphi_c(x_3)|^2 dx_3
$$

\n
$$
+ \frac{1}{2} \int_{\mathbb{R}^2} \left| \left(\frac{\partial}{\partial x_2} - iA_2 \right) u_0(x_1, x_2) \right|^2 dx_1 dx_2 \int_{\mathbb{R}} |\varphi_c(x_3)|^2 dx_3
$$

\n
$$
+ \frac{1}{2} \int_{\mathbb{R}} \left| \frac{\partial \varphi_c(x_3)}{\partial x_3} \right|^2 dx_3 \int_{\mathbb{R}^2} |u_0(x_1, x_2)|^2 dx_1 dx_2
$$

\n
$$
+ \frac{1}{2} \int_{\mathbb{R}^3} \int_{\mathbb{R}^3} \frac{\partial c(x_3)}{\partial x_3} |v_c|^2 dx_3 \int_{\mathbb{R}^2} |u_0(x_1, x_2)|^2 dx_1 dx_2
$$

\n
$$
+ \int_{\mathbb{R}^3} (V_{\Omega^*}(x) - \frac{1}{2} \gamma_3^2 x_3^2) |v_c|^2 dx + \frac{1}{2} N(v_c)
$$

\n
$$
= \gamma_2 c + \frac{c}{
$$

By applying the Fourier transform for $N(v_c)$ with (λ_1, λ_2) satisfying [\(1.20\)](#page-6-1), we obtain that

N(v_c) = \int_{\mathbb{R}^3} \lambda_1 |v_c|^4 + \lambda_2 (K * |v_c|^2) |v_c|^2 dx

\frac{1}{(2\pi)^3} \int_{\mathbb{R}^3} [\lambda_1 + \lambda_2 \hat{K}(\xi)] |\hat{v_c}|^2 d\xi

\frac{1}{(2\pi)^3} \int_{\mathbb{R}^3} \left[\lambda_1 + \frac{4\pi}{3} \lambda_2 \left(\frac{3\xi_3^2}{|\xi|^2} - 1 \right) \right] |\hat{v_c}|^2 d\xi
$$

= \frac{1}{(2\pi)^3} \int_{\mathbb{R}^3} \left[\lambda_1 + \frac{4\pi}{3} \lambda_2 \left(\frac{3\xi_3^2}{|\xi|^2} - 1 \right) \right] \left| \int_{\mathbb{R}^3} e^{-i\cdot\xi} v_c^2(x) dx \right|^2 d\xi

= \frac{1}{(2\pi)^3} \int_{\mathbb{R}^3} \left[\lambda_1 + \frac{4\pi}{3} \lambda_2 \left(\frac{3\xi_3^2}{|\xi|^2} - 1 \right) \right] \left| \frac{\gamma_2 \gamma_3^{\frac{1}{2}} c}{\pi^{\frac{3}{2}}} \int_{\mathbb{R}^3} e^{-i\cdot\xi} \cdot e^{-\gamma_2 (x_1^2 + x_2^2) - \gamma_3 x_3^2} dx \right|^2 d\xi

= -\frac{\gamma_2^2 \gamma_3 c^2}{8\pi^6} \int_{\mathbb{R}^3} \left| \lambda_1 + \frac{4\pi}{3} \lambda_2 \left(\frac{3\xi_3^2}{|\xi|^2} - 1 \right) \right| \left| \int_{\mathbb{R}^3} e^{-i\cdot\xi} \cdot e^{-\gamma_2 (x_1^2 + x_2^2) - \gamma_3 x_3^2} dx \right|^2 d\xi

\stackrel{\triangle}{=} -M(\gamma_2, \gamma_3),

where $\hat{u}(\xi) := \mathcal{F}u(\xi) = \int_{\mathbb{R}^3} e^{-ix\cdot\xi} u(x) dx$ and $M(\gamma_2, \gamma_3)$ is a constant depending on γ_2 , γ_3 . Choosing $\gamma_2 \leq \gamma_1 < \sqrt{\frac{2M(\gamma_2,\gamma_3)\gamma_2}{c} + \gamma_2^2}$, we can deduce that $\frac{(\gamma_1^2 - \gamma_2^2)c}{4\gamma_2}$ $\frac{(-\gamma_2^2)c}{4\gamma_2} + \frac{1}{2}N(v_c) < 0$, and then

$$
m_{\Omega^*}(c,\rho) < (\gamma_2 + \frac{\gamma_3}{2})c,
$$

which contradicts (4.16) . This completes the proof.

Proof of Theorem [1.7](#page-6-0). (i) Since $N(u) < 0$, similar to the proof of [\[6,](#page-31-3) Lemma 3.1], we conclude that for any given $\rho > 0$ there is $0 < c_1(\rho) < 1$ such that

$$
S(c) \cap B_{\Omega^*}(\rho) \neq \emptyset, \tag{4.19}
$$

 \Box

$$
\inf_{u \in S(c) \cap B_{\Omega^*}(\rho_2^c)} E_{\Omega^*}(u) < \inf_{u \in S(c) \cap (B_{\Omega^*}(\rho) \backslash B_{\Omega^*}(\rho c))} E_{\Omega^*}(u),\tag{4.20}
$$

for any $0 < c < c_1(\rho)$. Thus, $m_{\Omega^*}(\rho, c)$ is well-defined for $0 < c < c_1(\rho)$. Let $\{u_n\} \subseteq$ $S(c) \cap B_{\Omega^*}(\rho)$ be a minimizing sequence for $m_{\Omega^*}(\rho, c)$ satisfying $\lim_{n \to \infty} E_{\Omega^*}(u_n) = m_{\Omega^*}(\rho, c)$. It is clear that $\{u_n\}$ is bounded in Σ_{Ω^*} . By Lemma [4.3,](#page-24-2) we take a subsequence still denote by $\{u_n\}$ such that

$$
\liminf_{n \to \infty} |N(u_n)| > \delta > 0
$$

for some constant $\delta > 0$. Combining this with Lemma [4.1,](#page-22-5) there exist $\tilde{u}_c \in \Sigma_{\Omega^*} \setminus \{0\}$ and $\{z_n\} \subseteq \mathbb{R}^3$ with $z_n = (0, z_n^2, 0)$ such that, up to a subsequence,

$$
w_n(x) := e^{iA(z_n)\cdot x} u_n(x+z_n) \rightharpoonup \widetilde{u}_c \quad \text{in} \quad \Sigma_{\Omega^*}.
$$

It is obvious that

$$
\int_{\mathbb{R}^3} |w_n(x)|^2 dx = \int_{\mathbb{R}^3} |u_n|^2 dx
$$
 and $N(w_n) = N(u_n)$.

Moreover, we know that

$$
\int_{\mathbb{R}^3} |(\nabla - iA)w_n|^2 + V_{\Omega^*}(x)|w_n|^2 dx = \int_{\mathbb{R}^3} |(\nabla - iA)u_n|^2 + V_{\Omega^*}(x)|u_n|^2 dx,
$$

see [\[16,](#page-32-13) Eq.(3.16)]. Thus, $E_{\Omega^*}(w_n) = E_{\Omega^*}(u_n)$. That is to say, $\{w_n\}$ is also a minimizing sequence of $m_{\Omega^*}(c, \rho)$. By the weakly lower semi-continuous of norm, we get that

$$
0 < \int_{\mathbb{R}^3} |\widetilde{u}_c|^2 dx \le \liminf_{n \to \infty} \int_{\mathbb{R}^3} |w_n|^2 dx = \liminf_{n \to \infty} \int_{\mathbb{R}^3} |u_n|^2 dx = c
$$

and

$$
\int_{\mathbb{R}^3} |(\nabla - iA)\tilde{u}_c|^2 + 2V_{\Omega^*}(x)|\tilde{u}_c|^2 dx \le \int_{\mathbb{R}^3} |(\nabla - iA)w_n|^2 + 2V_{\Omega^*}(x)|w_n|^2 dx
$$

=
$$
\int_{\mathbb{R}^3} |(\nabla - iA)u_n|^2 + V_{\Omega^*}(x)|u_n|^2 dx
$$

\$\leq \rho\$,

which imply that $\tilde{u}_c \in B_{\Omega^*}(\rho)$. To claim that \tilde{u}_c is a minimizer for $m_{\Omega^*}(c, \rho)$. We first show that $|\tilde{u}_c|^2 = c$. Assume that $0 < |\tilde{u}_c|^2 = r < c$. By [\[29,](#page-33-9) Lemma 2.2], one has

$$
N(w_n) = N(\widetilde{u}_c) + N(w_n - \widetilde{u}_c) + o_n(1).
$$

By the weak convergence of w_n in Σ_{Ω^*} , we deduce that

$$
\int_{\mathbb{R}^3} |(\nabla - iA)w_n|^2 dx = \int_{\mathbb{R}^3} |(\nabla - iA)\tilde{u}_c|^2 dx + \int_{\mathbb{R}^3} |(\nabla - iA)(w_n - \tilde{u}_c)|^2 dx + o_n(1),
$$

$$
\int_{\mathbb{R}^3} V_{\Omega^*}(x)|w_n|^2 dx = \int_{\mathbb{R}^3} V_{\Omega^*}(x)|\tilde{u}_c|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|w_n - \tilde{u}_c|^2 dx + o_n(1),
$$

which directly follows $[15, (3.8)$ and (3.9)]. Hence,

$$
E_{\Omega^*}(w_n) = E_{\Omega^*}(\widetilde{u}_c) + E_{\Omega^*}(w_n - \widetilde{u}_c) + o_n(1). \tag{4.21}
$$

Next, we can show that for any $0 < c < \kappa < \min\{c_0(\rho), c_1(\rho)\}\,$,

$$
\kappa m_{\Omega^*}(c,\rho) > c m_{\Omega^*}(\kappa,\rho),\tag{4.22}
$$

where $m_{\Omega^*}(c, \rho)$ is defined in [\(4.1\)](#page-22-1). In fact, let $\{v_n\} \subseteq S(c) \cap B_{\Omega^*}(\rho)$ be such that $\lim_{n \to \infty} E_{\Omega^*}(v_n) =$ $m_{\Omega^*}(c, \rho)$. From [\(4.19\)](#page-27-0) and [\(4.20\)](#page-27-1), we can assume $v_n \in B_{\Omega^*}(c\rho)$ for any n large enough when $c < c_1(\rho)$. We further deduce that

$$
\sqrt{\frac{\kappa}{c}}v_n \in S(\kappa) \cap B_{\Omega^*}(\kappa \rho) \subseteq S(\kappa) \cap B_{\Omega^*}(\rho),
$$

where $\kappa < 1$. By Lemma [4.3](#page-24-2) and $N(v_n) < 0$, we derive that

$$
m_{\Omega^*}(\kappa,\rho) \le E_{\Omega^*}(\sqrt{\frac{\kappa}{c}}v_n)
$$

= $\frac{\kappa}{2c} \int_{\mathbb{R}^3} |(\nabla - iA)v_n|^2 + \frac{\kappa}{c} \int_{\mathbb{R}^3} V_{\Omega^*} |v_n|^2 dx + \frac{\kappa^2}{2c^2} N(v_n)$
= $\frac{\kappa}{c} E_{\Omega^*}(v_n) - \frac{\frac{\kappa}{c}(1 - \frac{\kappa}{c})}{2} N(v_n)$
= $\frac{\kappa}{c} E_{\Omega^*}(v_n) + \frac{\frac{\kappa}{c}(1 - \frac{\kappa}{c})}{2} |N(v_n)|$
< $\frac{\kappa}{c} m_{\Omega^*}(c, \rho),$

which yields that [\(4.22\)](#page-28-0) holds. Moreover, setting $r_n := |w_n - \tilde{u}_c|_2^2$, we know that $r_n + r =$ $c + o_n(1)$. Then we can assume that $r_n \to l$ as $n \to \infty$, which states that $l + r = c$. Thus, in view of (4.21) and (4.22) , we conclude that

$$
m_{\Omega^*}(c,\rho) = E_{\Omega^*}(w_n) = E_{\Omega^*}(\widetilde{u}_c) + E_{\Omega^*}(w_n - \widetilde{u}_c) + o_n(1)
$$

$$
\geq m_{\Omega^*}(l,\rho) + m_{\Omega^*}(r,\rho)
$$

>
$$
\frac{l}{c}m_{\Omega^*}(c,\rho) + \frac{r}{c}m_{\Omega^*}(c,\rho)
$$

=
$$
m_{\Omega^*}(c,\rho),
$$

a contradiction. Thus, $|\tilde{u}_c|^2 = c$ and $w_n \to \tilde{u}_c$ in $L^2(\mathbb{R}^3)$. We further infer that $w_n \to \tilde{u}_c$ in $L^4(\mathbb{R}^3)$ by the interpolation inequality. By Lemma [2.1,](#page-8-4) one has $N(w_n) = N(\tilde{u}_c) + o_n(1)$. It follows from the weak lower semi-continuity of norm that

$$
m_{\Omega^*}(c,\rho) = \liminf_{n \to \infty} E_{\Omega^*}(w_n)
$$

=
$$
\liminf_{n \to \infty} \left[\int_{\mathbb{R}^3} |(\nabla - iA)w_n|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|w_n|^2 dx + \frac{1}{2}N(w_n) \right]
$$

$$
\geq \int_{\mathbb{R}^3} |(\nabla - iA)\widetilde{u}_c|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|\widetilde{u}_c|^2 dx + \frac{1}{2}N(\widetilde{u}_c)
$$

= $E_{\Omega^*}(\widetilde{u}_c) \geq m_{\Omega^*}(c,\rho).$

It yields that $E_{\Omega^*}(\tilde{u}_c) = m_{\Omega^*}(c, \rho)$. Therefore, \tilde{u}_c is a minimizer for $m_{\Omega^*}(c, \rho)$ and $w_n \to \tilde{u}_c$ in Σ_{Ω^*} .

In what follows, we prove that $\tilde{u}_c \notin \partial B_{\Omega^*}(\rho)$. Obviously, it suffices to verify that

$$
\mathcal{M}^{\rho}_{\Omega^*}(c) \subseteq B_{\Omega^*}(\rho c),
$$

where

$$
\mathcal{M}_{\Omega^*}^{\rho}(c) := \{ u \in S(c) \cap B_{\Omega^*}(\rho) : E_{\Omega^*}(u) = m_{\Omega^*}(c, \rho) \}.
$$

Assume by contradiction that there exists $\psi \notin B_{\Omega^*}(\rho c)$ but $\psi \in M_{\Omega^*}^{\rho}(c)$. It follows from [\(4.20\)](#page-27-1) that

$$
m_{\Omega^*}(c,\rho) \leq \inf_{u \in S(c) \cap B_{\Omega^*}(\rho_2^c)} E_{\Omega^*}(u)
$$

$$
< \inf_{u \in S(c) \cap (B_{\Omega^*}(\rho) \setminus B_{\Omega^*}(\rho c))} E_{\Omega^*}(u)
$$

$$
\leq E_{\Omega^*}(\psi) = m_{\Omega^*}(c,\rho),
$$

which is a contradiction. Thus, \widetilde{u}_c is a critical point of $E_{\Omega^*}|_{S(c)}$, and there is a corresponding Lagrange multiplier $\tilde{\mu}_c \in \mathbb{R}$ such that $E'_{\Omega^*}(\tilde{u}_c) + \tilde{\mu}_c \tilde{u}_c = 0$ in $(\Sigma_{\Omega^*})^{-1}$. Then, by Lemma [2.1](#page-8-4) and (1.19) as well as (2.1) , we deduce that

$$
\tilde{\mu}_{c}|\tilde{u}_{c}|_{2}^{2} = -\frac{1}{2} \int_{\mathbb{R}^{3}} |(\nabla - iA)\tilde{u}_{c}|^{2} dx - \int_{\mathbb{R}^{3}} V_{\Omega^{*}}(x)|\tilde{u}_{c}|^{2} dx - N(\tilde{u}_{c})
$$
\n
$$
\leq -\frac{1}{2} \int_{\mathbb{R}^{3}} |(\nabla - iA)\tilde{u}_{c}|^{2} dx - \int_{\mathbb{R}^{3}} V_{\Omega^{*}}(x)|\tilde{u}_{c}|^{2} dx + \Lambda \int_{\mathbb{R}^{3}} |\tilde{u}_{c}|^{4} dx
$$
\n
$$
\leq -\frac{1}{2} \int_{\mathbb{R}^{3}} |(\nabla - iA)\tilde{u}_{c}|^{2} dx - \int_{\mathbb{R}^{3}} V_{\Omega^{*}}(x)|\tilde{u}_{c}|^{2} dx + \Lambda C_{4}^{4} \left(\int_{\mathbb{R}^{3}} |\nabla |\tilde{u}_{c}|^{2} dx\right)^{\frac{3}{2}} c^{\frac{1}{2}}
$$
\n
$$
\leq -\frac{1}{2} \int_{\mathbb{R}^{3}} |(\nabla - iA)\tilde{u}_{c}|^{2} dx - \int_{\mathbb{R}^{3}} V_{\Omega^{*}}(x)|\tilde{u}_{c}|^{2} dx + \Lambda C_{4}^{4} \left(\int_{\mathbb{R}^{3}} |(\nabla - iA)\tilde{u}_{c}|^{2} dx\right)^{\frac{3}{2}} c^{\frac{1}{2}}
$$
\n
$$
\leq ||\tilde{u}_{c}||_{\Sigma_{\Omega^{*}}}^{2} \left(-\frac{1}{2} + \Lambda C_{4}^{4} \rho^{\frac{1}{2}} c^{\frac{1}{2}}\right).
$$

Further, we choose $0 < c < \bar{c}(\rho)$, where

$$
\bar{c}(\rho) := \min\{c_0(\rho), c_1(\rho), \frac{1}{4\Lambda^2 C_4^8 \rho}\}.
$$
\n(4.23)

Then

$$
-\frac{1}{2} + \Lambda \mathcal{C}_4^4 \rho^{\frac{1}{2}} c^{\frac{1}{2}} < 0,
$$

which yields that $\tilde{\mu}_c < 0$. By [\(4.12\)](#page-24-3) and [\(4.13\)](#page-25-2), we obtain that

$$
\widetilde{\mu}_c \le \zeta_{\Omega^*}^0 \left(-\frac{1}{2} + \Lambda C_4^4 \rho^{\frac{1}{2}} c^{\frac{1}{2}} \right) \le \left(\gamma_2 + \frac{\gamma_3}{2} \right) \left(-\frac{1}{2} + \Lambda C_4^4 \rho^{\frac{1}{2}} c^{\frac{1}{2}} \right). \tag{4.24}
$$

On the other hand, since $(\lambda_1, \lambda_2) \in \mathbb{R}^2$ satisfies (1.20) , we have

$$
\widetilde{\mu}_c|\widetilde{u}_c|_2^2 = -\frac{1}{2} \int_{\mathbb{R}^3} |(\nabla - iA)\widetilde{u}_c|^2 dx - \int_{\mathbb{R}^3} V_{\Omega^*}(x)|\widetilde{u}_c|^2 dx - N(\widetilde{u}_c)
$$

$$
= -E_{\Omega^*}(\widetilde{u}_c) - \frac{1}{2}N(\widetilde{u}_c) > -E_{\Omega^*}(\widetilde{u}_c) = -m_{\Omega^*}(c,\rho).
$$

From Lemma [4.3,](#page-24-2) one has

$$
\widetilde{\mu}_c > -\frac{m_{\Omega^*}(c,\rho)}{c} \ge -\left(\gamma_2 + \frac{\gamma_3}{2}\right). \tag{4.25}
$$

Combining (4.24) and (4.25) , we obtain (1.21) .

(ii) Let $\widetilde{u}_c \in \mathcal{M}_{\Omega^*}^{\rho}(c)$ is a minimizer for $m_{\Omega^*}(c, \rho)$ obtained by (i). From Lemma [2.1,](#page-8-4) [\(2.1\)](#page-7-2) and [\(1.19\)](#page-6-2), we infer that

$$
\int_{\mathbb{R}^3} |(\nabla - iA)\tilde{u}_c|^2 + 2V_{\Omega^*}(x)|\tilde{u}_c|^2 dx
$$
\n
$$
= 2E_{\Omega^*}(\tilde{u}_c) - N(\tilde{u}_c)
$$
\n
$$
\leq 2m_{\Omega^*}(c,\rho) + \Lambda \int_{\mathbb{R}^3} |\tilde{u}_c|^4 dx
$$
\n
$$
\leq 2m_{\Omega^*}(c,\rho) + \Lambda C_4^4 \left(\int_{\mathbb{R}^3} |\nabla |\tilde{u}_c||^2 dx \right)^{\frac{3}{2}} c^{\frac{1}{2}}
$$
\n
$$
\leq 2m_{\Omega^*}(c,\rho) + \Lambda C_4^4 \left(\int_{\mathbb{R}^3} |(\nabla - iA)\tilde{u}_c|^2 dx \right)^{\frac{3}{2}} c^{\frac{1}{2}}
$$
\n
$$
< 2(\gamma_2 + \frac{\gamma_3}{2})c + \Lambda C_4^4 \rho^{\frac{3}{2}} c^{\frac{1}{2}},
$$

which means that

$$
\|\widetilde{u}_c\|_{\Sigma_{\Omega^*}}^2 < 2(\gamma_2 + \frac{\gamma_3}{2} + \frac{1}{2})c + \Lambda \mathcal{C}_4^4 \rho^{\frac{1}{2}} c^{\frac{1}{2}}.
$$

Thus $\tilde{u}_c \to 0$ in Σ_{Ω^*} as $c \to 0^+$. Next we recall from [\(1.21\)](#page-6-3) that

$$
-(\gamma_2 + \frac{\gamma_3}{2}) < \widetilde{\mu}_c \le (\gamma_2 + \frac{\gamma_3}{2}) \left(-\frac{1}{2} + \Lambda \mathcal{C}_4^4 \rho^{\frac{1}{2}} c^{\frac{1}{2}} \right)
$$

for all $0 < c < \bar{c}(\rho)$. Then there exists a constant $\tilde{\mu}_0 \in [-(\gamma_2 + \frac{\gamma_3}{2})]$ $\frac{\gamma_3}{2}), -\frac{1}{2}$ $\frac{1}{2}(\gamma_2 + \frac{\gamma_3}{2})$ $\frac{\gamma_3}{2}]$ such that $\tilde{\mu}_c \to \tilde{\mu}_0$ as $c \to 0^+$. By Lemma [2.1,](#page-8-4) [\(2.1\)](#page-7-2), [\(1.19\)](#page-6-2) and the fact $\tilde{u}_c \in B_{\Omega^*}(c\rho)$, we can get that

$$
0 < \frac{|N(\widetilde{u}_c)|}{|\widetilde{u}_c|_2^2} \le \frac{\Lambda |\widetilde{u}_c|_4^4}{|\widetilde{u}_c|_2^2} \le \frac{\Lambda \mathcal{C}_4^4 |\nabla |\widetilde{u}_c|_2^3}{|\widetilde{u}_c|_2} \le \frac{\Lambda \mathcal{C}_4^4 |(\nabla - iA)\widetilde{u}_c|_2^3}{|\widetilde{u}_c|_2} \le \Lambda \mathcal{C}_4^4 \rho^{\frac{3}{2}} c \to 0
$$

as $c \to 0^+$. It results that

$$
\lim_{c \to 0^+} \frac{m_{\Omega^*}(c,\rho)}{c} = \lim_{c \to 0^+} \left[\frac{1}{|\widetilde{u}_c|_2^2} \int_{\mathbb{R}^3} |(\nabla - iA)\widetilde{u}_c|^2 dx + \frac{1}{|\widetilde{u}_c|_2^2} \int_{\mathbb{R}^3} V_{\Omega^*}(x)\widetilde{u}_c|^2 dx + \frac{1}{2} \frac{N(\widetilde{u}_c)}{|\widetilde{u}_c|_2^2} \right]
$$

=
$$
\lim_{c \to 0^+} \frac{1}{|\widetilde{u}_c|_2^2} \left[\frac{1}{2} \int_{\mathbb{R}^3} |(\nabla - iA)\widetilde{u}_c|^2 dx + \int_{\mathbb{R}^3} V_{\Omega^*}(x)|\widetilde{u}_c|^2 dx \right].
$$

Similarly, we have

$$
\lim_{c \to 0^+} \widetilde{\mu}_c = \lim_{c \to 0^+} \left[-\frac{1}{2|\widetilde{u}_c|_2^2} \int_{\mathbb{R}^3} |(\nabla - iA)\widetilde{u}_c|^2 dx - \frac{1}{|\widetilde{u}_c|_2^2} \int_{\mathbb{R}^3} V_{\Omega^*}(x) |\widetilde{u}_c|^2 dx - \frac{N(\widetilde{u}_c)}{|\widetilde{u}_c|_2^2} \right]
$$
\n
$$
= \lim_{c \to 0^+} \frac{1}{|\widetilde{u}_c|_2^2} \left[-\frac{1}{2} \int_{\mathbb{R}^3} |(\nabla - iA)\widetilde{u}_c|^2 dx - \int_{\mathbb{R}^3} V_{\Omega^*}(x) |\widetilde{u}_c|^2 dx \right].
$$

Thus,

$$
\lim_{c \to 0^+} \frac{m_{\Omega^*}(c,\rho)}{c} = \lim_{c \to 0^+} -\widetilde{\mu}_c = -\widetilde{\mu}_0.
$$
