Uniform Anisotropic Regularity and Low Mach Number Limit of Non-isentropic Ideal MHD Equations with a Perfectly Conducting Boundary

Abstract

We prove the low Mach number limit of non-isentropic ideal magnetohydrodynamic (MHD) equations with *general initial data* in the half-space whose boundary satisfies the perfectly conducting wall condition. By observing a special structure contributed by Lorentz force in vorticity analysis, we establish uniform estimates in suitable anisotropic Sobolev spaces with weights of Mach number determined by the number of material derivatives. We also observe that the entropy has the enhanced regularity in the direction of the magnetic field. These two observations help us get rid of the loss of derivatives and weights of Mach number in vorticity analysis caused by the simultaneous appearance of entropy, general initial data and the magnetic field, which is one of the major difficulties that do not appear in Euler equations or the isentropic problems. By utilizing the technique of Alinhac good unknowns, the anti-symmetric structure is preserved in the tangential estimates for the system differentiated by high-order material derivatives.

Introduction

In this paper, we consider the scaled non-isentropic compressible ideal magnetohydrodynamic (MHD) equa-

describing the motion of a compressible conducting fluid in an electro-magnetic field. Here we set Ω = $\mathbb{R}^d_+ := \{x \in \mathbb{R}^d : x_d > 0\}$ for d = 2, 3 with boundary $\Sigma := \{x_d = 0\}$. $\nabla := (\partial_1, \dots, \partial_d)^T$ is the standard spatial derivative. $D_t := \partial_t + u \cdot \nabla$ is the material derivative. The fluid velocity, the magnetic field, the fluid density, the fluid pressure and the entropy are denoted by $u = (u_1, \dots, u_d)^T$, $B = (B_1, \dots, B_d)^T$, ρ , p and S respectively. Note that the last equation of (1.1) is derived from the equation of total energy and Gibbs relation. Defined as the ratio of characteristic fluid velocity to the sound speed, the Mach number ε is a dimensionless parameter that measures the compressibility of the fluid. Throughout this manuscript, Einstein's summation convention is adopted and repeated indices range from 1 to d.

We assume the fluid density $\rho = \rho(p, S) > 0$ to be a given smooth function of p and S which satisfies

$$\rho \ge \bar{\rho_0} > 0, \quad \frac{\partial \rho}{\partial \rho} > 0, \quad \text{in } \bar{\Omega},$$

for some positive constant $\bar{\rho}_0$. For instance, we have ideal fluids $\rho(p,S) = p^{1/\gamma}e^{-S/\gamma}$ with $\gamma > 1$ for a polytropic gas. These two conditions also guarantee the hyperbolicity of system (1.1).

The initial and boundary conditions of system (1.1) are

where the boundary condition for u_d is the slip boundary condition, and the boundary condition for B_d shows that Σ is a perfectly conducting wall. The meaning of the second condition is that the plasma is closed off from the outside world by a perfectly conducting wall. As stated in [8, Chapter 4.6], this model is appropriate for the study of equilibrium, waves and instabilities of confined plasma as used in thermonuclear research and is also served as the simplest, the most relevant model to describe confined plasmas. Such configurations refer to tokamaks.

Remark 1.1. The conditions $\nabla \cdot B = 0$ in Ω and $B_d = 0$ on Σ are both constraints for initial data so that the MHD system is not over-determined. One can show that they propagate within the lifespan of the solution. Using the theory of hyperbolic system with characteristic boundary conditions [26], one can show that the correct number of boundary conditions is 1. So, $B_d|_{\Sigma} = 0$ has to be an initial constraint.

To make the initial-boundary-value problem (1.1)-(1.4) solvable, we need to require the initial data satisfying the compatibility conditions up to certain order. For $m \in \mathbb{N}$, we define the m-th order compatibility conditions to be

$$B_d|_{t=0} = 0 \text{ and } \partial_t^j u_d|_{t=0} = 0 \quad \text{ on } \Sigma, \ 0 \le j \le m.$$

It should be noted that (1.5) indicates $\partial_t^j B_d|_{t=0}$ on Σ for $0 \le j \le m$ and we refer to Trakhinin [36, Section 4.1]

Let $a := \frac{1}{\rho} \frac{\partial \rho}{\partial p}$. Since $\frac{\partial \rho}{\partial p} > 0$ implies a(p, S) > 0, in view of $D_t S = 0$, the first equation of (1.1) is equivalent to

Thus the compressible MHD system is now reformulated as follows

When considering the incompressible limit, that is, when $\varepsilon > 0$ is sufficiently small, it is more convenient to symmetrize the compressible MHD system by using the transformation $p = 1 + \varepsilon q$, yielding

1.1 An overview of previous results

As is well-known in fluid dynamics, see for example in Majda's book [22, Chapter 2.4], we can formally derive the incompressible fluid equations from the compressible ones, which corresponds to passing to the limit in certain dimensionless form as the Mach number goes to zero. In particular, for inviscid fluids, taking low Mach number limit is a singular limit process of a hyperbolic system with large parameter, for example the coefficients ε^{-1} in (1.8). To study such singular limit, we shall classify the initial data to be two types.

- Well-prepared initial data: $\nabla \cdot u_0 = O(\varepsilon^k)$, $\nabla q_0 = O(\varepsilon^k)$ for $k \ge 1$. In such case, the compressible data is exactly a slight perturbation of a given incompressible data. Uniform estimates in low Mach regime immedately give the strong convergence thanks to the uniform boundedness of first-order time derivatives.
- General initial data: $\nabla \cdot u_0 = O(1)$, $\nabla q_0 = O(1)$. In such case, the compressible data includes a large perturbation which is actually a highly oscillatory acoustic wave that propagates with a speed of $O(1/\varepsilon)$. One has to filter such acoustic wave and find suitable function spaces for the *strong* convergence.

The low Mach number limit of Euler equations in \mathbb{R}^d , \mathbb{T}^d or a fixed domain has been studied extensively.

The study of singular limits in MHD are much less developed than that of Euler equations due to the strong coupling among the fluids, sound waves and magnetic fields, and there are still many unsolved problems since Majda raised open problems in this area in [22, pp. 71-72]. For ideal MHD in the whole space, the study of low Mach number limit was established by Jiang, the first author and Li [13] and we also refer to Cheng, the first author and Schochet [5, 6] for the multi-scale singular limits in low Mach number and Alfvén number regime.

However, the singular limits of ideal MHD system in a domain with boundaries become much more subtle. Under the perfectly conducting wall condition ($B \cdot N = 0$ on the boundary), Ohno-Shirota [25] proved that the linearized problem near a non-zero magnetic field is ill-posed in standard Sobolev spaces. The well-posedness results are referred to Yanagisawa-Matsumura [41] and Secchi [30, 31, 32, 34] under the setting of anisotropic Sobolev spaces, which were first introduced by Chen [4]. In contrast, the corresponding incompressible problem is still well-posed in standard Sobolev spaces, see for example [9]. The low Mach number limit for this problem was first proved by the first and the second authors [16] in the case of isentropic general data and non-isentropic well-prepared data. In [16], a suitable closed subspace of standard Sobolev space, introduced by Secchi [31], is used, but more restrictive constraints for the boundary value of initial data are required

whose physical interpretation is still unclear. We also refer to a very recent result by Secchi [35] in which he proved the incompressible limit for the isentropic problem with general initial data by using another anisotropic Sobolev spaces defined in [34]. By observing a key structure, the second and the third authors [37] prove the incompressible limit for the non-isentropic problem with well-prepared initial data, and the function spaces that we used are exactly the same as the ones for their well-posedness, that is, the anisotropic Sobolev norms converge to an energy functional defined in standard Sobolev spaces. The framework of [37] is also generalized to the study of free-boundary problems [43, 44] by the third author. But none of the existing works applies to the case of non-isentropic problems with general initial data.

We also remark that the direction of the magnetic field is crucially important for the study of ideal MHD in a domain with boundaries even if one only studies the local existence. For example, when the magnetic field is not tangential to the boundary, one can use the transversality of the magnetic field to compensate the loss of normal derivative and we refer to [40] for the local existence in standard Sobolev spaces. See also the results about the singular limits in [15] by the first author, Schochet, Xu and [14] by Jiang, the first author and Xu.

The aim of this paper is to rigorously justify the singular limit in low Mach number regime for ideal MHD with the perfectly conducting wall condition in the non-isentropic case with general initial data. The framework in this paper can cover the existing works and does not require extra boundary constraints as in [16]. The proof is based on the combination of several key observations and techniques: a special structure in vorticity analysis that illustrates the "mismatch" between the anisotropic norms and the standard Sobolev norms, enhanced regularity of the entropy in the direction of the magnetic field, the usage of material derivative D_t instead of ∂_t when defining the energy functional and the application of "modified Alinhac good unknowns" to overcome the difficulty brought by the anisotropy of the function spaces.

1.2 Anisotropic Sobolev spaces

Before stating our results, we should first define the anisotropic Sobolev space $H^m_*(\Omega)$ for $m \in \mathbb{N}$ and $\Omega = \mathbb{R}^d_+ = \{x \in \mathbb{R}^d : x_d > 0\}$, which was first introduced by Shuxing Chen [4]. Let $\omega = \omega(x_d)$ be a cutoff function on $[0, +\infty)$ defined by $\omega(x_d) = \frac{x_d}{1+x_d}$. Then we define $H^m_*(\Omega)$ for $m \in \mathbb{N}^*$ as follows

$$H_*^m(\Omega) := \left\{ f \in L^2(\Omega) \middle| (\omega \partial_d)^{\alpha_{d+1}} \partial_1^{\alpha_1} \cdots \partial_d^{\alpha_d} f \in L^2(\Omega), \ \forall \alpha \text{ with } \sum_{j=1}^{d-1} \alpha_j + 2\alpha_d + \alpha_{d+1} \le m \right\},$$

equipped with the norm

$$||f||_{H_*^{-}(\Omega)}^2 := \sum_{\sum_{i=1}^{d-1} \alpha_i + 2\alpha_d + \alpha_{d+1} \le m} ||(\omega \partial_d)^{\alpha_{d+1}} \partial_1^{\alpha_1} \cdots \partial_d^{\alpha_d} f||_{L^2(\Omega)}^2.$$

For any multi-index $\alpha := (\alpha_0, \alpha_1, \dots, \alpha_d, \alpha_{d+1}) \in \mathbb{N}^{d+2}$, we define

$$\partial_*^{\alpha} := \partial_t^{\alpha_0} (\omega \partial_3)^{\alpha_{d+1}} \partial_1^{\alpha_1} \cdots \partial_d^{\alpha_d}, \ \langle \alpha \rangle := \sum_{j=0}^{d-1} \alpha_j + 2\alpha_d + \alpha_{d+1},$$

¹The choice of $ω(x_d)$ is not unique. We just need $ω(x_d)$ vanishes on Σ, comparable to the distance function near Σ and comparable to 1 far away from Σ.

and define the space-time anisotropic Sobolev norm $\|\cdot\|_{m,*}$ to be

$$||f||_{m,*}^2 := \sum_{\langle \alpha \rangle \le m} ||\partial_*^{\alpha} f||_{L^2(\Omega)}^2 = \sum_{\alpha_0 \le m} ||\partial_t^{\alpha_0} f||_{H_*^{m-\alpha_0}(\Omega)}^2.$$
 (1.10)

We also denote the interior Sobolev norm to be $||f||_s := ||f(t, \cdot)||_{H^s(\Omega)}$ for any function f(t, x) on $[0, T] \times \Omega$ and denote the boundary Sobolev norm to be $|f|_s := |f(t, \cdot)|_{H^s(\Sigma)}$ for any function f(t, x) on $[0, T] \times \Sigma$.

From now on, we assume the dimension to be d=3, that is, $\Omega=\mathbb{R}^3_+=\{x\in\mathbb{R}^3:x_3>0\}$ and $\Sigma=\{x_3=0\}$. The 2D case follow in the same manner as the 3D case up to a slight modification in vorticity analysis and we refer the details to [37, Section 3.5] and no longer discuss it in this paper.

1.3 Main results

Now, we establish a local-in-time estimate that is uniform in Mach number ε for general initial data.

Theorem 1.1 (Uniform-in- ε estimate). Let $\varepsilon > 0$ be fixed. Let $(q_0, u_0, B_0, S_0) \in H^8(\Omega) \times H^8(\Omega) \times H^8(\Omega) \times H^9(\Omega)$ be the initial data of (1.8) satisfying the compatibility conditions (1.5) up to 7-th order and

$$E(0) \le M \tag{1.11}$$

for some M > 0 independent of ε . Then there exists T > 0 depending only on M, such that the solution to (1.8) satisfies the energy estimate

$$\sup_{t \in [0,T]} E(t) \le P(E(0)),\tag{1.12}$$

where $P(\cdots)$ is a generic polynomial in its arguments, and the energy E(t) is defined to be

$$E(t) = \sum_{l=0}^{4} E_{4+l}(t),$$

$$E_{4+l}(t) = \sum_{k=0}^{4-l} \left\| (\varepsilon D_t)^{k+2l} (q, u, B, S, \rho^{-1} B \cdot \nabla S) \right\|_{4-k-l}^{2}.$$

Remark 1.2 (Relations with anisotropic Sobolev space). The energy functional E(t) above is considered as a variant of $\|\cdot\|_{8,*}$ norm at time t>0. In fact, the slip boundary condition implies that D_t must be a tangential derivative on the boundary Σ , and so the "anisotropic order" of $\|D_t^{k+2l}f\|_{4-k-l}$ is at most $(k+2l)+2\times(4-k-l)=8-k\leq 8$. The Mach number weights are determined according to the number of material derivatives such that the energy estimate for the above "modified $\|\cdot\|_{8,*}$ norm" is uniform in $\varepsilon>0$. In particular, the first-order time derivatives of u, q are not bounded uniformly in ε , which corresponds to the case of general initial data.

Remark 1.3 (Well-posedness and regularity). For the initial data given in Theorem 1.1, the local well-posedness of (1.8) in $H_*^8(\Omega)$ for a fixed $\varepsilon > 0$ has been proven in [32, Theorem 2.1'] or [37, Theorem 1.1], where the latter one also gives the uniform-in- ε estimates for well-prepared initial data. We assume the initial data belong to $H^8(\Omega)$ instead of $H_*^8(\Omega)$ only because we must guarantee the initial energy $E(0) < \infty$. There is no loss of regularity in the energy estimates. We choose $H_*^8(\Omega) \hookrightarrow H^4(\Omega)$ (instead of $H^3(\Omega)$ as in Euler equations or elastodynamics [38]) because there are lots of terms in vorticity analysis of compressible ideal MHD that requires the L^∞ boundedness of the second-order derivatives.

Remark 1.4 (Enhanced regularity of the entropy). We assume $S_0 \in H^9(\Omega)$ (actually $H^9_*(\Omega)$) because we need the $H^8_*(\Omega)$ -regularity of the directional derivative $(\rho^{-1}B \cdot \nabla)S$ to control the vorticity instead of the full $H^9_*(\Omega)$ regularity. In fact, this enhanced "directional" regularity of S can be propagated from its initial data as we observe that D_t commutes with $(\rho^{-1}B \cdot \nabla)$. We refer to Section 3.2 for the proof.

The next main theorem concerns the low Mach number limit. We consider the inhomogeneous MHD equations together with a transport equation satisfied by (u^0, B^0, π, S^0) :

Theorem 1.2 (The low Mach number limit). Under the hypothesis of Theorem 1.1, we assume that $(u_0, B_0, S_0) \rightarrow (u_0^0, B_0^0, S_0^0)$ in $H^4(\Omega)$ as $\varepsilon \rightarrow 0$ with $\nabla \cdot B_0^0 = 0$ in Ω and $u_{0d}^0 = B_{0d}^0 = 0$ on Σ , and that there exist positive constants N_0 and σ such that S_0 satisfies

$$|S_0(x)| \le N_0 |x|^{-1-\sigma}, \quad |\nabla S_0(x)| \le N_0 |x|^{-2-\sigma}.$$
 (1.15)

Then it holds that

$$(q, u, B, S) \to (0, u^0, B^0, S^0)$$
 weakly-* in $L^{\infty}([0, T]; H^4(\Omega))$ and strongly in $L^2([0, T]; H^{4-\delta}_{loc}(\Omega))$

for $\delta > 0$. $(u^0, B^0, S^0) \in C([0, T]; H^4(\Omega))$ solves (1.14) with initial data $(u^0, B^0, S^0)|_{t=0} = (w_0, B_0^0, S_0^0)$, that is, the incompressible MHD system together with a transport equation of S^0 , where $w_0 \in H^4(\Omega)$ is determined by

$$w_{0d}|_{\Sigma} = 0, \quad \nabla \cdot w_0 = 0, \quad \nabla \times (\rho(0, S_0^0) w_0) = \nabla \times (\rho(0, S_0^0) u_0^0).$$

Here ϱ satisfies the transport equation

$$\partial_t \rho + u^0 \cdot \nabla \rho = 0, \ \rho|_{t=0} = \rho(0, S_0^0).$$

The function π satisfying $\nabla \pi \in C([0,T]; H^3(\Omega))$ represents the fluid pressure for incompressible MHD system (1.14). In the case of d=2, $\nabla \times (\rho(0,S_0^0)w_0)=\nabla \times (\rho(0,S_0^0)u_0^0)$ should be replaced by $\nabla^\perp \cdot (\rho(0,S_0^0)w_0)=\nabla^\perp \cdot (\rho(0,S_0^0)u_0^0)$ with $\nabla^\perp = (-\partial_2,\partial_1)^T$.

Remark 1.5 (Boundedness issue of the domain). In the proof of the Theorem 1.1, the uniform estimates can be established regardless of the boundedness of the domain. However, in the proof of the Theorem 1.2, the unboundedness of the domain, for example assuming Ω to be the half-space or the exterior of a compact smooth domain in \mathbb{R}^d , is necessary due to the (global) dispersion property for the wave equation. The strong convergence in time can be obtained by proving local energy decay via the defect measure technique [23, 1]. The entropy decay condition (1.15) is also needed due to Hörmander [10, Theorem 17.2.8] used in the proof of strong convergence.

1.4 Organization of the paper

This paper is organized as follows. In Section 2, we discuss the main difficulties and briefly introduce our strategies to tackle the problem. Then Section 3 is devoted to the proof of uniform estimates in Mach number. The strong convergence to the inhomogeneous MHD system is established in Section 4 by using the technique of microlocal defect measure as in [23, 1].

- (Polynomials) $P(\cdots)$ denotes a generic polynomial in its arguments with non-negative coefficients.
- (Commutators) [T, f]g = T(fg) f(Tg), [f, T]g = -[T, f]g where T is a differential operator and f, g are functions.
- (Equality modulo lower order terms) $A \stackrel{L}{=} B$ means A = B modulo lower order terms.

2 Difficulties and strategies

Before going to the detailed proofs, we briefly discuss the main difficulties in this problem and our strategies to overcome these difficulties. In particular, we focus on the difficulties that do not appear in neither of Euler equations, isentropic MHD equations or the case of well-prepared initial data.

The system of compressible ideal MHD with the perfectly conducting wall conditions is a first-order hyperbolic system with characteristic boundary conditions of constant multiplicity, for which there is a potential of normal derivative loss. This also happens for Euler equations and elastodynamics inside a rigid wall with

the slip boundary condition, but the vorticity for those two equations can be controlled in standard Sobolev spaces (see Schochet [28] and the third author [42]), which could compensate the loss of normal derivative. However, for compressible ideal MHD, one encounters a loss of normal derivative in vorticity analysis caused by the simultaneous appearance of compressibility and the magnetic field. That is exactly one has to use the anisotropic Sobolev spaces to prove the local existence.

2.1 Motivation to define E(t): a special structure in vorticity analysis

We are inspired by a special structure of Lorentz force in vorticity analysis to define the energy functional E(t) as in (1.13). Let us take the estimate of $\|\nabla \times u\|_3^2$ in the control of $\|u\|_4^2$ for example.

2.1.1 Substitution of the coefficient

In the case of non-isentropic problem with general initial data, one has to replace the coefficient $\rho(\varepsilon q, S)$ by $\rho_0 := \rho(0, S)$ to derive the evolution equation of the vorticity and the current, namely,

$$D_t(\rho_0 u) - \rho_0(\rho^{-1} B \cdot \nabla) B = -\underbrace{\nabla(\varepsilon^{-1} q + \frac{1}{2} |B|^2)}_{\text{curl-free}} + \underbrace{\frac{\rho - \rho_0}{\rho}}_{=O(\varepsilon)} \nabla(\varepsilon^{-1} q + \frac{1}{2} |B|^2),$$

as stated in Métivier-Schochet [23]. Or else, there must be terms like $\partial^{\alpha} \rho(\nabla \times D_t u)$ whose coefficient $\partial^{\alpha} \rho = O(\varepsilon)\partial^{\alpha} q + O(1)\partial^{\alpha} S$ is O(1) size and so this term is not uniformly bounded. The advantage of such substituiton is that the unbounded terms are avoided and the extra-generated term has small coefficient and its leading-order part is curl-free. Then it is easy to reproduce the control of $\nabla \times (u, B)$ from that of $\nabla \times (\rho_0 u, \rho_0 B)$ because ρ_0 only depends on S whose estimate is straightforward.

2.1.2 A weighted anisotropic structure contributed by the Lorentz force

In the analysis of $\|\nabla \times (\rho_0 u)\|_3^2$, we must encounter a fifth-order term

$$\mathcal{K} := -\int_{\Omega} \partial^{3} \nabla \times (\rho_{0} B) \cdot \partial^{3} \nabla \times (\rho_{0} \rho^{-1} B \nabla \cdot u) \, \mathrm{d}x,$$

which is uncontrollable in the setting of H^4 . But if we insert the continuity equation $\nabla \cdot u = -\varepsilon a D_t q$, commute $\nabla \times$ with D_t and insert the momentum equation $-\nabla q = \varepsilon(\rho D_t u + B \times (\nabla \times B))$, we can see that

$$\partial^3 \nabla \times (\rho_0 \rho^{-1} B \nabla \cdot u) = -\varepsilon^2 a \rho^{-1} B \times \left[B \times D_t (\partial^3 \nabla \times (\rho_0 B)) \right] + \varepsilon^2 \rho_0 a B \times (\partial^3 D_t^2 u) + \text{low-order terms.}$$

On the right side, the first term contributes to an energy term $-\frac{1}{2}\frac{\mathrm{d}}{\mathrm{d}t}\int_{\Omega}a\rho^{-1}|\varepsilon B\times(\partial^3\nabla\times(\rho_0B))|^2\,\mathrm{d}x$ that gives the regularity of the Lorentz force, while the second term exhibits a "weighted" anisotropic structure that indicates us to trade one normal derivative (in the curl operator $\nabla\times$) for the second-order tangential derivative $\varepsilon^2D_t^2$. As $\varepsilon\to0$, this anisotropic part converges to 0, and so the incompressible problem can be studied in standard Sobolev spaces. For details, we refer to Section 3.4.1.

2.1.3 The whole reduction procedures

Apart from the vorticity estimates, we also need to consider the divergence estimates. The continuity equation indicates us to trade one normal derivative in $\nabla \cdot u$ for one tangential derivative $\varepsilon D_t q$. Then for the pressure q, we can always invoke the momentum equation $-\nabla q = \varepsilon(\rho D_t u + B \times (\nabla \times B))$ to convert a spatial derivative to $\varepsilon D_t u$ and the estimate of current $\nabla \times B$ until there is no spatial derivative falling on q and no spatial derivative falling on q. The full details are referred to Section 3.4.2.

It should be remarked that all tangential derivatives generated in the above reduction procedures are material derivatives, and that explains why we write D_t instead of ∂_t when defining E(t). In Section 2.3, we will see using D_t instead of ∂_t is necessary for the non-isentropic problem with general initial data, as opposed to the case of well-prepared data or the isentropic problem in [16, 37, 35].

We conclude the reduction scheme in the following two diagrams




Diagram 1: the reduction scheme for the curl part.

In the above diagram, the "div reduction" refers to the reduction procedure for divergence and pressure in the previous paragraph. It can also be presented as the diagram below (we take l = 0 for example).




Diagram 2: the reduction scheme for the divergence part in $E_4(t)$.

Here "eq" means invoking the momentum equation and "div" means invoking the continuity equation. Now, we can explain why we define E(t) to be

$$\sum_{l=0}^{4} \sum_{k=0}^{4-l} \left\| (\varepsilon D_t)^{k+2l} (q, u, B, S, \rho^{-1} B \cdot \nabla S) \right\|_{4-k-l}^{2}$$

Let $l \in \{0, 1, 2, 3\}$ be the number of times that we do the vorticity estimates. After such l times of reduction for $||u, B||_4$, we have at most 4 - l normal derivatives left, but we also obtain $(\varepsilon D_t)^{2l}$ falling on each variable. This step corresponds to the first row of Diagram 1 and the $(\varepsilon D_t)^{2l}$ -part in the energy functional. Then for each fixed $l \in \{0, 1, 2, 3\}$, Diagram 2 is parallel to the study of Euler equations, that is, one trades one spatial derivative for one εD_t in the divergence part. Finally, we only need to control the estimates of full material derivatives which are purely tangential derivatives and this step is analyzed in Section 3.3.

2.2 Enhanced "directional" regularity of the entropy

One may notice that we require the directional derivative $(\rho^{-1}B \cdot \nabla)S$ has the same regularity as the other variables. This is in general incorrect for a first-order hyperbolic system, but it can really be achieved for compressible ideal MHD as long as we assume the initial data of $(\rho^{-1}B \cdot \nabla)S$ has the corresponding regularity. This fact is easy to prove, as we observe that D_t commutes with $(\rho^{-1}B \cdot \nabla)S$ which then leads to $D_t((\rho^{-1}B \cdot \nabla)S) = 0$ and the desired enhanced regularity. In fact, this is even easier to be observed if we study the free-boundary MHD in Lagrangian coordinates, e.g., [19], in which the material derivative becomes ∂_t and $(\rho^{-1}B \cdot \nabla)$ becomes time-independent!

Such enhanced directional regularity is necessary to control the vorticity and the current. For example, in the analysis of $\|\nabla \times (\rho_0 u)\|_3$, we must encounter the following two terms

$$-\int_{\Omega} \partial^{3} \nabla \times \left(\underline{(\rho^{-1}B \cdot \nabla \rho_{0})} B \right) \cdot \partial^{3} \nabla \times (\rho_{0}u) \, dx - \int_{\Omega} \partial^{3} \nabla \times \left(\underline{(\rho^{-1}B \cdot \nabla \rho_{0})} u \right) \cdot \partial^{3} \nabla \times (\rho_{0}B) \, dx,$$

in which the underlined terms essentially require the H^4 regularity of $(\rho^{-1}B \cdot \nabla)S$. Such difficulty never appears in the study of Euler equations, isentropic problems, or non-isentropic problems with well-prepared initial data. On the other hand, our observation exactly resolves this issue. Similar argument also applies to the recent work by the second author and the third author [38] about neo-Hookean elastodynamics.

2.3 Usage of material derivatives and "modified" Alinhac good unknowns

Now, we turn to explain why we shall use the variable-coefficient derivative D_t instead of the simpler one ∂_t to define E(t). In fact, this is due to the unboundedness of the first-order time derivatives in the case of general initial data. If we decompose the material derivative D_t into ∂_t , tangential spatial derivative $\overline{\partial} = \partial_1$ or ∂_2 and the co-normal part $\omega(x_3)\partial_3$, then we must separately do the tangential estimates for $\mathcal{T} = \partial_t$, $\overline{\partial}$, $\omega(x_3)\partial_3$ as in the case of well-prepared data [37]. However, this will again produce singular terms such as $((\varepsilon \overline{\partial})^8 \rho)(D_t u)$ and we cannot substitute ρ by ρ_0 as in the vorticity control. To overcome this difficulty, we must ensure every tangential derivative to be the material derivative D_t such that we could completely eliminate the O(1)-size terms $\mathcal{T}^{\alpha} \rho \approx O(\varepsilon) \mathcal{T}^{\alpha} q + O(1) \mathcal{T}^{\alpha} S$ by using $D_t S = 0$.

Under our setting, a new difficulty appears, that is, D_t does not commute with the ∇ . In Lemma A.3, we compute the concrete form of $[\partial, D_t^k]f$ and find that each term in this commutator must be a monomial of $(\partial D_t^j f)$ and $(\partial D_t^m u)$ for some $j, m \in \mathbb{Z}$. What's more difficult is that the top-order commutator, namely $[\partial, D_t^k]f$, contains $(\partial D_t^7 u)(\partial f)$ and $8(\partial u)(\partial D_t^7 f)$ whose $L^2(\Omega)$ norms cannot be directly controlled when $\partial = \partial_3$. To overcome this difficulty, we adopt the idea of Alinhac good unknowns [2], which reveals that the essential leading-order part in $D_t^8 \partial_i f$ is not simply $\partial_i D_t^8 f$ but actually the ∂_i derivative of the Alinhac good unknowns (denoted by \mathbf{F}^8)

$$D_t^8 \partial_i f \neq \partial_i D_t^8 f + L^2(\Omega)$$
-controllable terms $\Longrightarrow D_t^8 \partial_i f = \partial_i \mathbf{F}^8 + L^2(\Omega)$ -controllable terms.

In other words, the core idea of using Alinhac good unknowns is to rewrite the uncontrollable terms to be the form $\partial_i(L^2$ -controllable) terms and merge the terms in the parenthesis into the leading-order term, such that the covariance of the system is still preserved after being differentiated by variable-coefficient derivatives. In view of the singular limit problems, this step is used to preserve the anti-symmetric structure $E_0(U)\partial_t U + \varepsilon^{-1}\nabla U = f$ for the differentiated system.

Under the setting of standard Sobolev spaces, \mathbf{F}^8 is defined to be $D_t^8 f - D_t^7 u \cdot \nabla f$, see for example [9]. Under the setting of anisotropic Sobolev spaces, the third author [19] observed that the merged terms must be modified according as the variable f. After careful and delicate calculations, the "modified" Alinhac good unknowns used in this paper are (see also [19, Section 5.5])

$$\mathbf{U}_i^8 := D_t^8 u_i - 9D_t^7 u \cdot \nabla u_i, \qquad \mathbf{Q}^8 := D_t^8 \check{q} - D_t^7 u \cdot \nabla \check{q}, \quad \check{q} := q + \frac{\varepsilon}{2} |B|^2.$$

Such difference is due to the fact that we must preserve the divergence structure for the velocity but there is no such structure for the pressure. We refer the details to Section 3.3.

3 Uniform energy estimates

This section is devoted to the proof of Theorem 1.1, which will be split into several parts: L^2 estimates, entropy estimates, tangential estimates for material derivatives and the reduction of normal derivatives via div-curl analysis.

3.1 L^2 estimate

First, we establish L^2 -energy estimate for (1.8).

Proposition 3.1. We define the L^2 energy $E_0(t)$ by

$$E_0(t) := \frac{1}{2} \int_{\Omega} aq^2 + \rho |u|^2 + |B|^2 + S^2 dx.$$

Then it satisfies

$$\frac{\mathrm{d}E_0(t)}{\mathrm{d}t} \le P(E_4(t)). \tag{3.1}$$

Invoking the momentum equation and integrate by parts, we have:

$$\frac{1}{2} \frac{\mathrm{d}}{\mathrm{d}t} \int_{\Omega} aq^{2} + \rho |u|^{2} + |B|^{2} + S^{2} \, \mathrm{d}x$$

$$= \frac{1}{2} \int_{\Omega} (\partial_{t} a + \nabla \cdot (au))q^{2} + \nabla \cdot u(|B|^{2} + S^{2}) \, \mathrm{d}x - \varepsilon^{-1} \int_{\Omega} \nabla \cdot (qu) \, \mathrm{d}x$$

$$+ \int_{\Omega} (B \cdot \nabla B) \cdot u + (B \cdot \nabla u) \cdot B \, \mathrm{d}x - \int_{\Omega} \frac{1}{2} \nabla |B|^{2} \cdot u + (B \cdot B) \nabla \cdot u \, \mathrm{d}x$$

$$= \frac{1}{2} \int_{\Omega} (\varepsilon \partial_{q} a D_{t} q + a \nabla \cdot u)q^{2} + \nabla \cdot u(|B|^{2} + S^{2}) \, \mathrm{d}x, \tag{3.2}$$

which give the desired energy estimate. This also implies that

$$\|(q, u, B, S)\|_0^2 \lesssim E_4(0) + \int_0^t P(E_4(\tau)) d\tau.$$
 (3.3)

3.2 Enhanced regularity of the entropy

We now verify that the directional derivative $\rho^{-1}B \cdot \nabla$ commutes with the material derivative D_t . This property leads to the enhanced regularity of the entropy in the direction of the magnetic field.

Proposition 3.2. Let (q, u, B, S) be a solution to system (1.8), then the following equality holds:

$$[\rho^{-1}B \cdot \nabla, D_t] = 0. \tag{3.4}$$

Proof. By using equations of ρ and B, we have that

$$D_{t}(\rho^{-1}B_{i}) = \rho^{-1}D_{t}B_{i} + B_{i}D_{t}\rho^{-1}$$

$$= \rho^{-1}(B \cdot \nabla u_{i} - B_{i}\nabla \cdot u) - \rho^{-2}B_{i}D_{t}\rho$$

$$= \rho^{-1}(B \cdot \nabla u_{i} - B_{i}\nabla \cdot u) + \rho^{-1}B_{i}\nabla \cdot u$$

$$= \rho^{-1}B \cdot \nabla u_{i}, \quad i = 1, \dots, d.$$
(3.5)

For any function $f \in C([0,T];H^2) \cap C^1([0,T];H^1)$, we have that

$$D_{t}(\rho^{-1}B \cdot \nabla f) = \sum_{k,j=1}^{d} \left(\partial_{t}(\rho^{-1}B_{k}\partial_{k}f) + u_{j}\partial_{j}(\rho^{-1}B_{k}\partial_{k}f) \right)$$

$$= \sum_{k,j=1}^{d} \left(\rho^{-1}B_{k}\partial_{k}(\partial_{t}f + u_{j}\partial_{j}f) + \partial_{t}(\rho^{-1}B_{k})\partial_{k}f - \rho^{-1}B_{k}\partial_{k}u_{j}\partial_{j}f + u_{j}\partial_{j}(\rho^{-1}B_{k})\partial_{k}f \right)$$

$$= (\rho^{-1}B \cdot \nabla)D_{t}f + \sum_{k=1}^{d} (D_{t}(\rho^{-1}B_{k}) - \rho^{-1}B \cdot \nabla u_{k})\partial_{k}f = (\rho^{-1}B \cdot \nabla)D_{t}f. \tag{3.6}$$

Since $D_tS = 0$ and $D_t(\rho^{-1}B \cdot \nabla S) = 0$, we can easily prove the estimates for $(S, \rho^{-1}B \cdot \nabla S)$. The proof does not involve any boundary term because we do not integrate by parts, so we omit the details.

Corollary 3.3. The entropy S in (1.8) satisfies the following estimates:

$$\frac{\mathrm{d}}{\mathrm{d}t} \sum_{l=0}^{4} \sum_{k=0}^{4-l} \left\| (\varepsilon D_t)^{k+2l} (S, \rho^{-1} B \cdot \nabla S) \right\|_{4-k-l}^2 \le P(E(t)). \tag{3.7}$$

3.3 Tangential energy estimates

In this section, we will derive the energy estimates for tangential derivatives of solutions. It is more convenient to use the following equations derived from (1.8):

$$\begin{cases}
aD_{t}\check{q} - \varepsilon aB \cdot D_{t}B + \varepsilon^{-1}\nabla \cdot u = 0 & \text{in } [0, T] \times \Omega, \\
\rho D_{t}u + \varepsilon^{-1}\nabla\check{q} - B \cdot \nabla B = 0 & \text{in } [0, T] \times \Omega, \\
D_{t}B - B \cdot \nabla u - \varepsilon aB(D_{t}\check{q} - \varepsilon B \cdot D_{t}B) = 0 & \text{in } [0, T] \times \Omega, \\
\nabla \cdot B = 0 & \text{in } [0, T] \times \Omega, \\
D_{t}S = 0 & \text{in } [0, T] \times \Omega, \\
a = a(\varepsilon \check{q} - \varepsilon^{2}|B|^{2}/2, S) > 0, \quad \rho = \rho(\varepsilon \check{q} - \varepsilon^{2}|B|^{2}/2, S) > 0 & \text{in } [0, T] \times \bar{\Omega},
\end{cases}$$
(3.8)

where $\check{q} = q + \varepsilon |B|^2 / 2$ is the total pressure.

Proposition 3.4. It holds that

$$\sum_{k=1}^{8} \sup_{\tau \in [0,t]} \left\| (\varepsilon D_t)^k (q, u, B) \right\|_0^2 \le P(E(0)) + E(t) \int_0^t P(E(\tau)) d\tau.$$
 (3.9)

The proof of this proposition is divided into two parts: When $1 \le k \le 7$, one can prove the tangential estimates by straightforward calculations; when k = 8, the anisotropy of the function spaces leads to potential loss of regularity in the commutator $[\nabla, D_t^8]$ as the terms having the form $\nabla D_t^7 f$ (f = u, q) must appear.

3.3.1 Low-order estimates for ≤ 7 material derivatives

For $1 \le k \le 7$, we take D_t^k to the equations (3.8) to obtain that

$$aD_{t}^{k+1}\check{q} - \varepsilon aB \cdot D_{t}^{k+1}B + \varepsilon^{-1}\nabla \cdot D_{t}^{k}u = \mathcal{R}_{q}^{k},$$

$$\rho D_{t}^{k+1}u + \varepsilon^{-1}\nabla D_{t}^{k}q - B \cdot \nabla D_{t}^{k}B = \mathcal{R}_{u}^{k},$$

$$D_{t}^{k+1}B - B \cdot \nabla D_{t}^{k}u - \varepsilon aB(D_{t}^{k+1}\check{q} - \varepsilon B \cdot D_{t}^{k+1}B) = \mathcal{R}_{R}^{k},$$
(3.10)

where

$$\begin{split} \mathcal{R}_q^k &= [a, D_t^k] D_t \check{q} - \varepsilon [aB, D_t^k] \cdot D_t B + \varepsilon^{-1} [\partial_j, D_t^k] u_j, \\ \mathcal{R}_u^k &= [\rho, D_t^k] D_t u + \varepsilon^{-1} [\nabla, D_t^k] q - [B \cdot \nabla, D_t^k] B, \\ \mathcal{R}_R^k &= -[B \cdot \nabla, D_t^k] u - \varepsilon [aB, D_t^k] D_t \check{q} + \varepsilon^2 [aBB_j, D_t^k] D_t B_j. \end{split}$$

Multiplying (3.10) by $\varepsilon^{2k}D_t^k(\check{q}, u, B)$, integrating over Ω and integrating by parts, one sees that

$$\frac{\varepsilon^{2k}}{2} \frac{\mathrm{d}}{\mathrm{d}t} \int_{\Omega} \left(a|D_t^k \check{q} - B \cdot D_t^k B|^2 + \rho |D_t^k u|^2 + |D_t^k B|^2 \right) \mathrm{d}x$$

$$= \frac{\varepsilon^{2k}}{2} \int_{\Omega} \left((\partial_t a + \nabla \cdot (au))|D_t^k \check{q} - B \cdot D_t^k B|^2 + \nabla \cdot u|D_t^k B|^2 \right) \mathrm{d}x$$

$$- \varepsilon^{2k} \int_{\Omega} a(\varepsilon D_t B \cdot D_t^k B)(D_t^k \check{q} - B \cdot D_t^k B) \mathrm{d}x$$

$$+ \varepsilon^{2k} \int_{\Omega} ((B \cdot \nabla)D_t^k B) \cdot D_t^k u + ((B \cdot \nabla)D_t^k u) \cdot D_t^k B \, \mathrm{d}x$$

$$+ \varepsilon^{2k} \int_{\Omega} \left(D_t^k \check{q} \mathcal{R}_q^k + D_t^k u \cdot \mathcal{R}_u^k + D_t^k B \cdot \mathcal{R}_B^k \right) \mathrm{d}x$$

$$:= \mathcal{G}_1 + \mathcal{G}_2 + \mathcal{G}_3 + \mathcal{G}_4, \tag{3.11}$$

where the equation $\partial_t \rho + \nabla \cdot (\rho u) = 0$ and the boundary condition $u_3 = B_3 = 0$ on Σ are used. We now have to control each term on the right-hand side of (3.11). Since a is smooth funtions of εq and S, we employ the Sobolev inequality to deduce that

$$\|\partial_t a\|_{\infty} = \|\varepsilon \partial_q \rho \partial_t q - \partial_S \rho(u \cdot \nabla) S\|_{\infty} \le P(E(t)),$$

$$\|\nabla \cdot (au)\|_{\infty} + \|\nabla \cdot u\|_{\infty} \le P(E(t)).$$

Thus, it is easy to find that G_1 can be bounded from above by

$$|\mathcal{G}_1| \lesssim ||\partial_t a + \nabla \cdot (au)||_{\infty} ||\varepsilon^k(D_t^k \check{q} - B \cdot D_t^k B)||_0^2 + ||\nabla \cdot u||_{\infty} ||\varepsilon^k D_t^k B||_0^2 \leq P(E(t)). \tag{3.12}$$

Similarly, we control G_2 as follows:

$$|\mathcal{G}_2| \lesssim \|\varepsilon D_t B\|_{\infty} \|\varepsilon^k D_t^k B\|_0 \|\varepsilon^k (D_t^k \check{q} - B \cdot D_t^k B)\|_0 \le P(E(t)). \tag{3.13}$$

For \mathcal{G}_3 , integrating by parts and using the boundary conditions $u_3 = B_3 = 0$ on Σ and $\nabla \cdot B = 0$, one obtains that

$$\mathcal{G}_3 = \varepsilon^{2k} \int_{\Omega} -((B \cdot \nabla)D_t^k u) \cdot D_t^k B + ((B \cdot \nabla)D_t^k u) \cdot D_t^k B \, \mathrm{d}x = 0. \tag{3.14}$$

Recall that Lemma A.3 indicates that the highest-order terms in the commutator $\varepsilon^k[\nabla, D_t^k]f$ have the form of either $(\varepsilon^{k-1}\partial D_t^{k-1}u)(\varepsilon\partial f)$ or $(\varepsilon\partial u)(\varepsilon^{k-1}\partial D_t^{k-1}f)$ whose $L^2(\Omega)$ norms can be directly controlled by P(E(t)) thanks to $k \leq 7$. By standard product estimates, it is straightforward to see that the L^2 -norm of terms in \mathcal{G}_4 can be controlled by P(E(t)), i.e.

$$\mathcal{G}_4 \le P(E(t)). \tag{3.15}$$

Substituting the estimates for G_1 - G_4 into (3.11), we obtain that

$$\frac{\mathrm{d}}{\mathrm{d}t} \left\| \varepsilon^k D_t^k(\check{q}, u, B) \right\|_0^2 \le P(E(t)), \quad 1 \le k \le 7.$$
(3.16)

In such case, the commutator $\varepsilon^8[\nabla,D_t^8]f$ contains the terms $(\varepsilon^7\partial D_t^7u)(\varepsilon\partial f)$ and $(\varepsilon\partial u)(\varepsilon^7\partial D_t^7f)$ in which the $\partial D_t^7(\cdot)$ part is not controllable in $L^2(\Omega)$. Such possible loss of regularity is completely caused by the anisotropy of the function spaces, as the ∂ may be a normal derivative which is considered to be second-order. To overcome this difficulty, we shall introduce the "modified Alinhac good unknowns" in [19, Section 5.5] by the third author. To be more precise, let

In view of the above inequalities, the L^2 norms $\|(\varepsilon D_t)^{k+2l}u\|_0^2$ have been controlled in Proposition 3.4. In what follows, we control the divergence part together with the pressure q in Section 3.4.2, the estimates of voriticty and current in Section 3.4.1. The commutators in (3.35)-(3.38) can be directly controlled and their estimates are recorded at the end of this section and are proved in Lemma A.4. Do note that these commutators are not under any time integrals, and so we cannot merely control them by P(E(t)) as in Section 3.3.

3.4.1 Estimates of vorticity and current

We start with the control of vorticity $\|(\varepsilon D_t)^{k+2l}\nabla \times u\|_{3-k-l}^2$ and current $\|(\varepsilon D_t)^{k+2l}\nabla \times B\|_{3-k-l}^2$ for $0 \le l \le 3$ and $0 \le k \le 3-l$. We first prove the following estimates.

In Lemma 3.9, we reproduce the estimates for $\nabla \times u$ and $\nabla \times B$ by combining the above equality and Lemma 3.5. The advantange of this substitution is that ρ_0 commutes with D_t and so we no longer have the singular term. In fact, the momentum equation $\rho D_t u + \varepsilon^{-1} \nabla q + B \times (\nabla \times B) = 0$ can be written as

Inserting the evolution equation of B to substitute $B \cdot \nabla u$, we get

$$= \varepsilon^{2}\rho_{0}aB \times (\partial^{3}D_{t}^{2}u) + \underbrace{\varepsilon^{2}\rho^{-1}aB \times D_{t}(B \times \partial^{3}(\nabla \times (\rho_{0}B)))}_{=\mathcal{K}_{1}}$$

$$+\varepsilon^{2}\rho_{0}\rho^{-1}aB \times \left([\partial^{3}D_{t},\rho]D_{t}u + [\partial^{3},D_{t}](\nabla \times B) + D_{t}\left([\partial^{3},B] \times (\nabla \times B)\right) + D_{t}\left([\rho_{0},\partial^{3}\nabla] \times B\right)\right) + \mathcal{R}_{3}, \quad (3.53)$$

where $\|\mathcal{R}_3 + \mathcal{R}_4\|_0 \le P(E_4(t))$ can be proved by using the concrete forms of commutators because the order of derivatives does not exceed 4. It should be noted that the time derivative in $D_t([\hat{\sigma}^3, B \times](\nabla \times B))$ does not lead to any loss of ε weights because there is already an ε factor in \mathcal{R}_3 . Similar argument also applies to the control of \mathcal{R}_4 . Now, we analyze the contribution of \mathcal{K}_1 in the integral \mathcal{K} , presented as below

Remark 3.2. The estimate (3.71) in this proposition is not the final version that we use to close the uniform energy estimates for E(t) because $\|\cdot\|_{3-k-l}$ norm still contains normal derivatives of u and B. The good thing is that the remaining terms to be controlled, namely the last term in (3.71), only belong to $H^*_{*}(\Omega)$ and the number of ε weights remains the same as before. At the end of this section, we will repeatedly apply the div-curl analysis to these terms such that they can finally be controlled by $P(E(0)) + \int_0^t P(E(\tau)) d\tau$.

3.4.2 Reduction of pressure and divergence

We show how to reduce the control of the pressure to that of the velocity and magnetic field when there is at least one spatial derivative on the fluid pressure q. This follows from using the momentum equation

$$\begin{aligned} &\|[(\varepsilon D_{t})^{k+2l}, a]\varepsilon D_{t}q\|_{3-k-l}^{2} + \|[(\varepsilon D_{t})^{k+2l}, \rho](\varepsilon D_{t}u)\|_{3-k-l}^{2} + \|[(\varepsilon D_{t})^{k+2l}, \varepsilon B \times](\nabla \times B)\|_{3-k-l}^{2} \\ &\lesssim P(E(0)) + P(E(t)) \int_{0}^{t} P(E(\tau)) \, d\tau. \end{aligned} \tag{3.83}$$

Therefore, we conclude that the reduction of pressure and divergence actually converts a spatial derivative to a material derivative (εD_t) and lower-order curl estimate that has been analyzed in Section 3.4.1. We get

$$\begin{split} \|(\varepsilon D_{t})^{k+2l}q\|_{4-k-l}^{2} & \leq \|\rho(\varepsilon D_{t})^{k+2l+1}u\|_{3-k-l}^{2} + \|\varepsilon B \times (\varepsilon D_{t})^{k+2l}(\nabla \times B)\|_{3-k-l}^{2} \\ & + P(E(0)) + P(E(t)) \int_{0}^{t} P(E(\tau)) \, \mathrm{d}\tau, \\ \|\nabla \cdot (\varepsilon D_{t})^{k+2l}u\|_{3-k-l}^{2} & \leq \|a(\varepsilon D_{t})^{k+2l+1}q\|_{3-k-l}^{2} + P(E(0)) + P(E(t)) \int_{0}^{t} P(E(\tau)) \, \mathrm{d}\tau, \\ \|\nabla \cdot (\varepsilon D_{t})^{k+2l}B\|_{3-k-l}^{2} & \leq P(E(0)) + P(E(t)) \int_{0}^{t} P(E(\tau)) \, \mathrm{d}\tau. \end{split} \tag{3.85}$$

The proof is completed.

Remark 3.3. Lemma 3.10 shows that we can reduce a spatial derivative on q to $(\varepsilon D_t u)$ and $\nabla \times B$ (which is analyzed in Lemma 3.9) plus controllable terms; and reduce the divergence part to $(\varepsilon D_t q)$ plus controllable terms. Therefore, every time we do such reduction, we actually trade one spatial derivative for one material derivative together with an ε weight. Repeatedly, we end this reduction procedure until there is no spatial derivatives falling on u, B, q, in which case we finally needs to the estimates of full material derivatives which have been analyzed in Proposition 3.4.

3.4.3 Estimates of commutators

The end of this part is devoted to the control of commutator terms arising from (3.35)-(3.38). We record the results here and refer to the proofs in Lemma A.4 and A.5.

Lemma 3.11. Let k, l be integers satisfying $0 \le l \le 3$ and $0 \le k \le 3 - l$. Then the following estimates hold

Control of the entropy. The control of entropy and its directional derivative $(\rho^{-1}B \cdot \nabla)S$ are established in Corollary 3.3, that is,

$$\frac{\mathrm{d}}{\mathrm{d}t} \left\| (\varepsilon D_t)^{k+2l} (S, (\rho^{-1} B \cdot \nabla) S) \right\|_{4-k-l}^2 \le P(E(t)). \tag{3.88}$$

Control of the velocity u, the magnetic field B and the pressure q. This part is divided into several steps.

- 1. When k + l = 4, there is no normal derivative in $||\cdot||_{4-k-l}$ norm. The control of this part is recorded in Proposition 3.4 by using the technique of modified Alinhac good unknowns.
- 2. When $k+l \le 3$, recall that (3.35)-(3.38) show that the norms $\|(\varepsilon D_t)^{k+2l}(u,B)\|_{4-k-l}^2$ are reduced to the control of $\|(\varepsilon D_t)^{k+2l}(\nabla \times u, \nabla \times B)\|_{3-k-l}^2$ and $\|(\varepsilon D_t)^{k+2l}(\nabla \cdot u)\|_{3-k-l}^2$. The commutators generated in this process can be directly controlled as shown in Lemma 3.11.
- 3. For the curl part, we first show in Lemma 3.5 that

$$\frac{\mathrm{d}}{\mathrm{d}t} \left(\left\| (\varepsilon D_t)^{k+2l} \nabla \times (\rho_0 u) \right\|_{3-k-l}^2 + \left\| (\varepsilon D_t)^{k+2l} \nabla \times (\rho_0 B) \right\|_{3-k-l}^2 + \left\| \varepsilon B \times \left((\varepsilon D_t)^{k+2l} \nabla \times (\rho_0 B) \right) \right\|_{3-k-l}^2 \right) \le P(E(t)). \tag{3.89}$$

Then we remove the coefficient ρ_0 to reproduce the desired curl estimates

$$\begin{split} & \left\| (\varepsilon D_{t})^{k+2l} \nabla \times u \right\|_{3-k-l}^{2} + \left\| (\varepsilon D_{t})^{k+2l} \nabla \times B \right\|_{3-k-l}^{2} \\ & \lesssim P\left(E(0) \right) + P(E(t)) \int_{0}^{t} P(E(\tau)) \, \mathrm{d}\tau + \sum_{k_{0} \leq k \atop l_{0} < l} \left(\left\| (\varepsilon D_{t})^{k_{0}+2l_{0}} u \right\|_{3-k_{0}-l_{0}}^{2} + \left\| (\varepsilon D_{t})^{k_{0}+2l_{0}} B \right\|_{3-k_{0}-l_{0}}^{2} \right), \end{split} \tag{3.90}$$

which are recorded in Lemma 3.9.

4. For the divergence part, we combine the momentum equation and the continuity equation to reduce ∇q to $\varepsilon D_t u$ and $\varepsilon \nabla \times B$ and reduce $\nabla \cdot u$ to $\varepsilon D_t q$:

$$||(\varepsilon D_{t})^{k+2l}q||_{4-k-l}^{2} \lesssim ||\rho(\varepsilon D_{t})^{k+2l+1}u||_{3-k-l}^{2} + ||\varepsilon B \times (\varepsilon D_{t})^{k+2l}(\nabla \times B)||_{3-k-l}^{2}$$

$$+ P(E(0)) + P(E(t)) \int_{0}^{t} P(E(\tau)) d\tau,$$
(3.91)

$$\|\nabla \cdot (\varepsilon D_t)^{k+2l} u\|_{3-k-l}^2 \lesssim \|a(\varepsilon D_t)^{k+2l+1} q\|_{3-k-l}^2 + P(E(0)) + P(E(t)) \int_0^t P(E(\tau)) d\tau,$$

$$\|\nabla \cdot (\varepsilon D_t)^{k+2l} B\|_{3-k-l}^2 \lesssim P(E(0)) + P(E(t)) \int_0^t P(E(\tau)) d\tau. \tag{3.92}$$

as recorded in Lemma 3.10.

- 5. It should be noted that the extra terms generated on the right side of curl estimates are of lower order. If $k_0 + l_0 = 3$, then again we can control such terms by the tangential estimates in Proposition 3.4. If $k_0 + l_0 < 3$, then we again apply the above div-curl analysis to such terms to reduce one more spatial derivative.
- 6. We repeat step 3 and 4 until there is no spatial derivatives falling on u, B, q, and all remaining terms are u, B, q differentiated by $(\varepsilon D_t)^j$ for some j which are again controlled in Proposition 3.4:

$$\sum_{j=1}^{8} \sup_{\tau \in [0,t]} \left\| (\varepsilon D_t)^j (q, u, B) \right\|_0^2 \le P(E(0)) + E(t) \int_0^t P(E(\tau)) d\tau.$$
 (3.93)

The above argument gives the following uniform-in- ε estimates:

$$E(t) \lesssim P(E(0)) + P(E(t)) \int_0^t P(E(\tau)) d\tau$$
 (3.94)

where E(t) is defined by (1.13). Since the right side of the energy inequality does not rely on ε , we can use Grönwall-type argument to prove that there exists some T > 0 independent of ε such that

$$\sup_{t \in [0,T]} E(t) \le P(E(0)). \tag{3.95}$$

Theorem 1.1 is proven.

4 The limit to the incompressible inhomogeneous MHD system

The last section is devoted to the proof of *strong convergence* to the incompressible inhomogeneous MHD system (1.14).

4.1 The strong convergence of vorticity, magnetic field and entropy

The uniform bounds imply that, up to a subsequence, we have

$$(q, u, B, S) \to (q^0, u^0, B^0, S^0)$$
 weakly-* in $L^{\infty}([0, T]; H^4(\Omega)),$ (4.1)

$$(B,S) \to (B^0,S^0)$$
 strongly in $C([0,T];H^{4-\delta}_{loc}(\Omega)),$ (4.2)

$$\nabla \times (\rho_0(S)u) \to \nabla \times (\rho_0(S^0)u^0) \text{ strongly in } C([0,T]; H^{3-\delta}_{loc}(\Omega)), \tag{4.3}$$

with $\rho_0(S) = \rho(0, S)$. Similarly, we use $a_0(S)$ to denote a(0, S). Here we note that the strong convergence of the vorticity is due to the uniform boundness of $D_t \nabla \times (\rho_0 u)$ which satisfies

$$D_t(\nabla \times (\rho_0 u)) = \nabla \times (\rho_0 \rho^{-1} B \cdot \nabla B) + [u \cdot \nabla, \nabla \times](\rho_0 u) + \nabla g \times \nabla (q + \varepsilon |B|^2 / 2),$$

where $g(\varepsilon q, S) = (\varepsilon \rho)^{-1} (\rho - \rho_0)$ is bounded uniformly in ε .

4.2 The strong convergence of pressure and divergence

We first prove that the expected limit functions satisfy $q^0 = 0$ and $\nabla \cdot u^0 = 0$. The first and second equation of (1.8) are written to be

$$E(\varepsilon q, S)D_t U + \varepsilon^{-1} L U = J, \tag{4.4}$$

with

$$E(\varepsilon q, S) = \begin{pmatrix} a(\varepsilon q, S) & 0 \\ 0 & \rho(\varepsilon q, S)I_3 \end{pmatrix}, \quad L = \begin{pmatrix} 0 & \nabla \cdot \\ \nabla & 0 \end{pmatrix}, \quad U = \begin{pmatrix} q \\ u \end{pmatrix}, \quad J = \begin{pmatrix} 0 \\ B \times (\nabla \times B) \end{pmatrix}.$$

First notice that

$$\varepsilon E(\varepsilon q, S)\partial_t U + LU = \varepsilon E(\varepsilon q, S)u \cdot \nabla U - \varepsilon J. \tag{4.5}$$

Using the uniform bounds and $E(\varepsilon q, S) - E_0(S) = O(\varepsilon)$, we obtain

$$\varepsilon E_0(S)\partial_t U + LU = \varepsilon f,\tag{4.6}$$

where $E_0(S) = E(0, S)$ and $\{f\}_{\varepsilon>0}$ is a bounded family in $C([0, T]; H^3(\Omega))$. Passing to the weak limit shows that $\nabla q^0 = 0$ and $\nabla \cdot u^0 = 0$. Since $q^0 \in L^{\infty}([0, T]; H^4(\Omega))$ and $\Omega = \mathbb{R}^d_+$, we infer $q^0 = 0$.

Proposition 4.1. It holds that

$$q \to 0$$
 strongly in $L^2([0,T]; H^{4-\delta}_{loc}(\Omega)),$ (4.7)

$$\nabla \cdot u \to 0$$
 strongly in $L^2([0,T]; H^{3-\delta}_{loc}(\Omega))$. (4.8)

This theorem is a slight variant of [1, Prop. 3.1]. For the reader's convenience, we outline the proof detailed in [1] and skip some technical details that are identical to [1, Prop. 3.1].

Proof. **Step 1: Wave-packet transform of the variable-coefficient system.** One first extends the functions to $t \in \mathbb{R}$ by

$$\tilde{U} = \begin{pmatrix} \tilde{q} \\ \tilde{u} \end{pmatrix} = \chi_{\varepsilon} U = \begin{pmatrix} \chi_{\varepsilon} q \\ \chi_{\varepsilon} u \end{pmatrix}, \tag{4.9}$$

where $\chi_{\varepsilon} \in C_0^{\infty}((0,T))$ be a family of functions such that $\chi_{\varepsilon}(t) = 1$ for $t \in [\varepsilon^{1/2}, T - \varepsilon^{1/2}]$ and $\|\varepsilon \partial_t \chi_{\varepsilon}\|_{\infty} \le 2\varepsilon^{1/2}$, and choose extensions \tilde{S} of S, supported in $t \in [-1, T+1]$, uniformly bounded in $C(\mathbb{R}; H^4(\Omega))$, and converging to \tilde{S}^0 in $C(\mathbb{R}; H^{4-\delta}_{loc}(\Omega))$. According to (4.6), \tilde{U} satisfies

$$\varepsilon E_0(\tilde{S})\partial_t \tilde{U} + L\tilde{U} = \varepsilon \tilde{f}, \tag{4.10}$$

where $\{\tilde{f}\}_{\varepsilon>0}$ is a bounded family in $C(\mathbb{R}; H^3(\Omega))$.

The above extension to $t \in \mathbb{R}$ is necessary, as we want to apply the wave-packet transform to the variable t. Given $\varepsilon > 0$, we define the following wave packet transform:

$$W^{\varepsilon}v(t,\tau,x) = (2\pi^{3})^{-1/4}\varepsilon^{-3/4} \int_{\mathbb{R}} e^{(i(t-s)\tau - (t-s)^{2})/\varepsilon}v(s,x)ds,$$
(4.11)

where $v \in C^1(\mathbb{R} \times \bar{\Omega}) \cap L^2(\mathbb{R} \times \Omega)$, $W^{\varepsilon}v \in C^1(\mathbb{R}^2_{t,\tau} \times \bar{\Omega}) \cap L^2(\mathbb{R}^2_{t,\tau} \times \Omega)$ and W^{ε} extends as an isometry from $L^2(\mathbb{R} \times \Omega)$ to $L^2(\mathbb{R}^2_{t,\tau} \times \Omega)$.

Now, system (4.10) can be written in $\mathbb{R}^2_{t,\tau} \times \Omega$ as

$$i\tau E_0(\tilde{S})(W^{\varepsilon}\tilde{U}) + L(W^{\varepsilon}\tilde{U}) = F^{\varepsilon},$$
 (4.12)

where

$$\begin{split} \boldsymbol{F}^{\varepsilon} &= \varepsilon W^{\varepsilon} \tilde{f} + [E_{0}(\tilde{S}), W^{\varepsilon}](\varepsilon \partial_{t}) \tilde{U} + E_{0}(\tilde{S}) (\mathrm{i} \tau W^{\varepsilon} \tilde{U} - W^{\varepsilon} (\varepsilon \partial_{t} \tilde{U})) \\ &:= (F_{1}^{\varepsilon}, F_{2}^{\varepsilon}) \in L^{2}(\mathbb{R}^{2}_{t,\tau}; H^{1}(\Omega)) \times L^{2}(\mathbb{R}^{2}_{t,\tau}; (H^{1}(\Omega))^{d}). \end{split}$$

Following the arguments in [1, Lemma 3.3], one shows that

$$F^{\varepsilon} \to 0 \text{ in } L^2(\mathbb{R}^2_{+\tau}; H^1(\Omega)) \text{ as } \varepsilon \to 0.$$
 (4.13)

Step 2: Strong convergence of q via the techniques of microlocal defect measures. Now we turn to prove the convergence of q. Since W^{ε} is an isometry, it suffices to prove the strong convergence of $W^{\varepsilon}\tilde{q}$ in certain function spaces on $\mathbb{R}^2_{t,\tau} \times \Omega$. We define

$$P^{\varepsilon}(t,\tau,\nabla)(\cdot) := a_0(\tilde{S})\tau^2(\cdot) + \nabla \cdot (\rho_0^{-1}(\tilde{S})\nabla(\cdot)), \tag{4.14}$$

$$P^{0}(t,\tau,\nabla)(\cdot) := a_{0}(\tilde{S}^{0})\tau^{2}(\cdot) + \nabla \cdot (\rho_{0}^{-1}(\tilde{S}^{0})\nabla(\cdot)), \tag{4.15}$$

$$\Theta^{\varepsilon} := (1 - \Delta)(W^{\varepsilon}\tilde{q}) \in L^{2}(\mathbb{R}^{2}_{t,\tau} \times \Omega). \tag{4.16}$$

It should be noted that P^{ε} is actually the wave-packet transform of the wave operator $a_0 \varepsilon^2 \partial_t^2(\cdot) + \nabla \cdot (\rho_0^{-1}(S) \nabla(\cdot))$. From (4.12), we can compute that

$$P^{\varepsilon}(t,\tau,\nabla)(W^{\varepsilon}\tilde{q}) = -i\tau F_1^{\varepsilon} + \nabla \cdot (\rho_0^{-1}(\tilde{S})F_2^{\varepsilon}). \tag{4.17}$$

Since this is a boundary-value problem, we shall decompose $W^{\varepsilon}\tilde{q}$ into its interior part and boundary part. Following [1], we define

$$W^{\varepsilon}\tilde{q} = (1 - \Delta_N)^{-1}\Theta^{\varepsilon} + \Re(\mathbf{F}_2^{\varepsilon} \cdot N), \tag{4.18}$$

where $\Theta := (1 - \Delta)(W^{\varepsilon}\tilde{q})$ and $(1 - \Delta_N)^{-1}$ is defined by

$$f = (1 - \Delta_N)^{-1}g$$
 if and only if $(1 - \Delta)f = g$ in Ω , and $\partial_N f = 0$ on Σ ;

and M is defined by

$$h = \Re(g)$$
 if and only if $(1 - \Delta)h = 0$ in Ω , and $\partial_N h = g$ on Σ .

It should be noted that $(1 - \Delta_N)^{-1}$ is a bounded linear operator from $L^2(\Omega)$ to $H^2(\Omega)$ and \Re is a bounded linear operator from $H^{\frac{1}{2}}(\Sigma)$ to $H^2(\Omega)$.

To prove the strong convergence of Θ , which is now only a uniformly bounded family in $L^2(\mathbb{R}^2 \times \Omega)$, we need the following two lemmas.

Lemma 4.2 (Métivier-Schochet [23, Lemma 4.3]). For all uniformly bounded family $\{\Theta^{\varepsilon}\}\subset L^2(\mathbb{R}^{2+d})$, there is a subsequence such that there exists a finite non-negative Borel measure μ on \mathbb{R}^2 and $M\in L^1(\mathbb{R}^2,\mathcal{L}_+,\mu)$ such that for all $\Phi\in C_0(\mathbb{R}^2;\mathcal{K})$,

$$\int_{\mathbb{R}^2} (\Phi \Theta^{\varepsilon}, \Theta^{\varepsilon})_{L^2} dt d\tau \xrightarrow{\varepsilon \to 0} \int_{\mathbb{R}^2} \text{Tr}(\Phi(t, \tau) M(t, \tau)) \mu(dt, d\tau).$$

Here $\mathcal{K}(\mathcal{L}_+, \text{ resp.})$ denotes the set of compact operators (non-negative self-adjoint trace class operators, resp.) on $L^2(\Omega)$.

Lemma 4.3 (Métivier-Schochet [23, Lemma 5.1]). The operator $P^0(t, \tau, \nabla)(1 - \Delta_N)^{-1} = 0$ is a 1-1 mapping for any $(t, \tau) \in \mathbb{R}^2$, that is,

$$\ker_{L^2(\Omega)}(P^0(t,\tau,\nabla)(1-\Delta_N)^{-1}) = 0, \quad \forall (t,\tau) \in \mathbb{R}^2$$
 (4.19)

Remark 4.1. We note that the first lemma give the description of "the lacking of compactness in L^2 ". For the second lemma, its proof (see [23, Lemma 5.1]) requires the entropy decay condition (1.15) and the unboundedness of the domain Ω .

Let $M(t, \tau)$ be the trace-class operator and μ be the microlocal defect measure obtained in Lemma 4.2 by inserting Θ^{ε} defined in (4.18). Then we can prove

$$M(t,\tau) = 0$$
 μ -a.e., (4.20)

whose details can be found in [38, Corollary 4.4]. Therefore, for the uniformly bounded family $\{\Theta^{\varepsilon}\}$ defined in (4.18), we actually prove that

$$\int_{\mathbb{R}^2} (\Phi \Theta^{\varepsilon}, \Theta^{\varepsilon})_{L^2} dt d\tau \xrightarrow{\varepsilon \to 0} 0$$

holds for any $\Phi \in C_0(\mathbb{R}^2; \mathcal{K})$ where \mathcal{K} denotes the set of compact operators on $L^2(\Omega)$.

We now set $\Phi(t,\tau) = \varphi(t,\tau)K^*K$ for $\varphi \in C_0(\mathbb{R}^2)$ and $K \in \mathcal{K}$ in the above convergence result to get

$$\varphi K\Theta^{\varepsilon} \to 0 \text{ in } L^2(\mathbb{R}^2_{t,\tau} \times \Omega)$$
 (4.21)

holds for any $K \in \mathcal{K}$ and $\varphi \in C_0(\mathbb{R}^2)$. Following the arguments in [1, (3.23)-(3.24)], we prove this convergence holds for $\varphi(t,\tau) = 1$, i.e. for any $K \in \mathcal{K}$,

$$K\Theta^{\varepsilon} \to 0 \text{ in } L^2(\mathbb{R}^2_{t,\tau} \times \Omega).$$
 (4.22)

Recall that, by the definition of $\Theta = (1 - \Delta)(W^{\varepsilon}\tilde{q})$, W^{ε} is an isometry from $L^{2}(\mathbb{R}_{t} \times \Omega)$ to $L^{2}(\mathbb{R}_{t,\tau}^{2} \times \Omega)$, and W^{ε} commutes with $K(1 - \Delta)$. So (4.22) implies that for any $K \in \mathcal{K}$,

$$K(1-\Delta)\tilde{q} \to 0 \text{ in } L^2(\mathbb{R} \times \Omega).$$
 (4.23)

Given that \tilde{q} is bounded in $L^2(\mathbb{R}; H^4(\Omega))$, the convergence (4.23) implies

$$\tilde{q} \to 0 \text{ in } L^2(\mathbb{R}; H^{4-\delta}_{loc}(\Omega)).$$
 (4.24)

Since the limit is 0, the convergence holds without passing a subsequence. We end up with

$$q \to 0 \text{ in } L^2([0,T]; H^{4-\delta}_{loc}(\Omega)).$$
 (4.25)

Similarly, from (4.12), we can prove

$$\varepsilon \partial_t q \to 0 \text{ in } L^2([0,T]; H^{3-\delta}_{\text{loc}}(\Omega)),$$
 (4.26)

which leads to

$$\nabla \cdot u = -aD_t q \to 0 \text{ in } L^2([0, T]; H^{3-\delta}_{\text{loc}}(\Omega)). \tag{4.27}$$

4.3 The strong convergence to the limit system

We continue our proof of Theorem 1.2. Recall that \mathcal{P} be the projection onto H_{σ} and $Q = I_3 - \mathcal{P}$, where $H_{\sigma} = \{u \in L^2(\Omega) : \int_{\Omega} u \cdot \nabla \phi, \ \forall \phi \in H^1(\Omega)\}$ and $G_{\sigma} = \{\nabla \psi : \psi \in H^1(\Omega)\}$ give the orthogonal decomposition $L^2(\Omega) = H_{\sigma} \oplus G_{\sigma}$.

From the strong convergence results (4.3) and (4.8), we know that

$$\mathcal{P}(\rho_0(S)u) \to \mathcal{P}(\rho_0(S^0)u^0) \text{ in } L^2([0,T]; H^{4-\delta}_{loc}(\Omega)),$$
 (4.28)

$$Qu \to Qu^0 = 0 \text{ in } L^2([0, T]; H_{loc}^{4-\delta}(\Omega)).$$
 (4.29)

The previous two properties yields further that:

$$\mathcal{P}(\rho_0(S)\mathcal{P}u) \to \mathcal{P}(\rho_0(S^0)\mathcal{P}u^0) \text{ in } L^2([0,T]; H^{4-\delta}_{loc}(\Omega)), \tag{4.30}$$

$$\mathcal{P}(\rho_0(S)Qu) \to \mathcal{P}(\rho_0(S^0)Qu^0) = 0 \text{ in } L^2([0,T]; H_{loc}^{4-\delta}(\Omega)),$$
 (4.31)

which, combined with the fact $S \to S^0$ in $C([0, T]; H^{4-\delta}_{loc}(\Omega))$, imply that:

$$\begin{split} \mathcal{P}(\rho_0(S^0)\mathcal{P}(u-u^0)) &= \mathcal{P}(\rho_0(S^0)[(u-u^0)-Qu]) \\ &= \mathcal{P}\left(\rho_0(S)(u-u^0) + (\rho_0(S^0)-\rho_0(S))(u-u^0) - \rho_0(S)Qu + (\rho_0(S^0)-\rho_0(S))Qu\right) \\ &\to 0 \text{ in } L^2([0,T]; H^{4-\delta}_{\text{loc}}(\Omega)). \end{split}$$

Consequently, we find that, by noticing $\rho_0(S^0)$ positive in $[0,T] \times \Omega$, $\mathcal{P}u \to \mathcal{P}u^0 = u^0$ in $L^2([0,T]; H^{4-\delta}_{loc}(\Omega))$, which, combined with (4.29), implies that

$$u \to u^0 \text{ in } L^2([0,T]; H^{4-\delta}_{loc}(\Omega)).$$
 (4.32)

By (4.2) and (4.32), we obtain

$$\rho(\varepsilon q, S) \to \rho_0(S^0) \text{ in } C([0, T]; H^{4-\delta}_{loc}(\Omega)),$$

$$\nabla u \to \nabla u^0 \text{ in } L^2([0, T]; H^{3-\delta}_{loc}(\Omega)),$$

$$\nabla B \to \nabla B^0 \text{ in } L^2([0, T]; H^{3-\delta}_{loc}(\Omega)).$$

Passing to the limit in the equations for S and B, we see that the limits S^0 and B^0 satisfy

$$(\partial_t + u^0 \cdot \nabla)S^0 = 0$$
, $(\partial_t + u^0 \cdot \nabla)B^0 = B^0 \cdot \nabla u^0$, $\nabla \cdot B^0 = 0$

in the sense of distributions. Since $\rho(\varepsilon q, S) - \rho_0(S) = O(\varepsilon)$, we have

$$\rho(\varepsilon q, S)D_t u = (\rho(\varepsilon q, S) - \rho_0(S))D_t u + \partial_t(\rho_0(S)u) + (u \cdot \nabla)(\rho_0(S)u)$$
$$\to \rho_0(S^0)((\partial_t + u^0 \cdot \nabla)u^0)$$

in the sense of distributions. Applying the operator \mathcal{P} to the momentum equations $\rho D_t u + \varepsilon^{-1} \nabla q + B \times (\nabla \times B) = 0$ and then taking to the limit, we conclude that

$$\mathcal{P}\left[\rho_0(S^0)((\partial_t+u^0\cdot\nabla)u^0+B^0\times(\nabla\times B^0))\right]=0.$$

Therefore, $(u^0, B^0, S^0) \in C([0, T]; H^4(\Omega))$ solves the incompressible MHD equations together with a transport equation

$$\begin{cases} \varrho(\partial_{t}u^{0} + u^{0} \cdot \nabla u^{0}) - B^{0} \cdot \nabla B^{0} + \nabla(\pi + \frac{1}{2}|B^{0}|^{2}) = 0 & \text{in } [0, T] \times \Omega, \\ \partial_{t}B^{0} + u^{0} \cdot \nabla B^{0} - B^{0} \cdot \nabla u^{0} = 0 & \text{in } [0, T] \times \Omega, \\ \nabla \cdot u^{0} = \nabla \cdot B^{0} = 0 & \text{in } [0, T] \times \Omega, \\ \partial_{t}S^{0} + u^{0} \cdot \nabla S^{0} = 0 & \text{in } [0, T] \times \Omega, \\ u^{0}_{d} = B^{0}_{d} = 0 & \text{on } [0, T] \times \Sigma, \end{cases}$$

$$(4.33)$$

for a suitable fluid pressure function π satisfying $\nabla \pi \in C([0, T]; H^3(\Omega))$. Here ϱ satisfies $\partial_t \varrho + u^0 \cdot \nabla \varrho = 0$, with initial data $\varrho_0 := \rho(0, S_0^0)$. Using the same arguments as in the proof of [23, Theorem 1.5], we find that

$$(u^0, B^0, S^0)|_{t=0} = (w_0, B_0^0, S_0^0),$$

where $w_0 \in H^4(\Omega)$ is determined by

$$w_{0d}|_{\Sigma} = 0$$
, $\nabla \cdot w_0 = 0$, $\nabla \times (\rho_0(S_0^0)w_0) = \nabla \times (\rho_0(S_0^0)u_0^0)$.

Moreover, the uniqueness of the limit function implies that the convergence holds as $\varepsilon \to 0$ without restricting to a subsequence. Theorem 1.2 is then proven.

A Preliminary lemmas and commutator estimates

In this section, we recall some basic identities and estimates. First, we record the Hodge-type elliptic estimates that are used in the div-curl analysis.

Lemma A.1 (Hodge elliptic estimates). For any sufficiently smooth vector field $X \in \mathbb{R}^3$ and any real number $s \ge 1$, one has

$$||X||_{s}^{2} \lesssim ||X||_{0}^{2} + ||\nabla \cdot X||_{s-1}^{2} + ||\nabla \times X||_{s-1}^{2} + |X \cdot N|_{s-1/2}^{2}. \tag{A.1}$$

When $X \in \mathbb{R}^2$, we shall replace $\nabla \times X$ by $\nabla^{\perp} \cdot X$ with $\nabla^{\perp} := (-\partial_2, \partial_1)^{\mathrm{T}}$.

Lemma A.2 (Reynolds transport formula). Under the setting of Theorem 1.1, for each f(t, x) satisfying $f \in L^2(\Omega)$ and $D_t f \in L^2(\Omega)$, the Reynolds transport formula holds

$$\frac{1}{2}\frac{\mathrm{d}}{\mathrm{d}t}\int_{\Omega}\rho|f|^2\,\mathrm{d}x = \int_{\Omega}\rho(D_t f)f\,\mathrm{d}x.\tag{A.2}$$

Proof. The Reynolds transport formula is proved by direct calculation and using the continuity equation $D_t \rho + \rho \nabla \cdot u = 0$. For the second formula, we use the non-degeneracy of ρ (1 $\leq \rho \leq 1$) to compute that

$$||f(t,\cdot)||_{0}^{2} \lesssim \int_{\Omega} \rho |f(t,x)|^{2} dx = \int_{\Omega} \rho |f(0,x)|^{2} dx + \int_{0}^{t} \int_{\Omega} 2\rho (D_{t}f(\tau,x))f(\tau,x) dx d\tau$$

$$\leq ||f(0,\cdot)||_{0}^{2} + \int_{0}^{t} ||D_{t}f(\tau,\cdot)||_{0} ||f(\tau,\cdot)||_{0} ||\rho||_{\infty} d\tau$$

$$\lesssim ||f(0,\cdot)||_{0}^{2} + \int_{0}^{t} ||D_{t}f(\tau,\cdot)||_{0} ||f(\tau,\cdot)||_{0} d\tau$$

Using Young's inequality, $||D_t f(\tau, \cdot)||_0 ||f(\tau, \cdot)||_0 \le \delta ||f(\tau, \cdot)||_0^2 + (4\delta)^{-1} ||D_t f(\tau, \cdot)||_0^2$. Therefore, we get for

$$\sup_{0 \le t \le T} \|f(t,\cdot)\|_0^2 \lesssim \delta \sup_{0 \le t \le T} \|f(t,\cdot)\|_0^2 + \|f(0,\cdot)\|_0^2 + \int_0^t \|D_t f(\tau,\cdot)\|_0^2 \, \mathrm{d}\tau.$$

Pick $\delta > 0$ suitably small such that the δ -term is absorbed by the left side. Then we get

$$||f(t,\cdot)||_0^2 \le \sup_{0 \le t \le T} ||f(t,\cdot)||_0^2 \le ||f(0,\cdot)||_0^2 + \int_0^t ||D_t f(\tau,\cdot)||_0^2 d\tau.$$

The next lemma reveals the structure of the commutator between higher-order material derivatives and spatial derivatives.

Lemma A.3 ([20, Section 4]). Let $[\partial, D_t] = (\partial u)\tilde{\partial}$, where the symmetric dot product $(\partial u)\tilde{\partial}$ is define component-wisely by $((\partial u)\tilde{\partial})_i = \partial_i u_k \partial_k$. In general, we have

$$= (\partial D_{t}^{k-1} u) \tilde{\cdot} \partial + k(\partial u) \tilde{\cdot} (\partial D_{t}^{k-1})$$

$$+ \sum_{\substack{l_{1}+l_{2}=k-1\\l_{1},l_{2}>0}} c_{l_{1},l_{2}} (\partial D_{t}^{l_{1}} u) \tilde{\cdot} (\partial D_{t}^{l_{2}}) + \sum_{\substack{l_{1}+\dots+l_{n}=k-n+1\\n\geq3}} d_{l_{1},\dots,l_{n}} (\partial D_{t}^{l_{1}} u) \cdots (\partial D_{t}^{l_{n-1}} u) (\partial D_{t}^{l_{n}})$$

$$= \partial (D_{t}^{k-1} u_{i} \partial_{i}(\cdot)) + k \partial u_{i} \partial_{i} D_{t}^{k-1}(\cdot)$$

$$- D_{t}^{k-1} u_{i} \partial_{i} \partial + \sum_{\substack{l_{1}+l_{2}=k-1\\l_{1},l_{2}>0}} c_{l_{1},l_{2}} (\partial D_{t}^{l_{1}} u) \tilde{\cdot} (\partial D_{t}^{l_{2}}) + \sum_{\substack{l_{1}+\dots+l_{n}=k-n+1\\n\geq3}} d_{l_{1},\dots,l_{n}} (\partial D_{t}^{l_{1}} u) \cdots (\partial D_{t}^{l_{n-1}} u) (\partial D_{t}^{l_{n}}), \quad (A.4)$$

where $Z^k = (Z_1^k, Z_2^k, Z_3^k)^T$. Moreover, we have

$$\begin{split} [\partial, (\varepsilon D_{t})^{k}] &= \sum_{l_{1}+l_{2}=k-1} c_{l_{1},l_{2}} (\varepsilon \partial (\varepsilon D_{t})^{l_{1}} u) \tilde{\gamma}(\partial (\varepsilon D_{t})^{l_{2}}) + \sum_{l_{1}+\dots+l_{n}=k-n+1} d_{l_{1},\dots,l_{n}} (\varepsilon \partial (\varepsilon D_{t})^{l_{1}} u) \cdots (\varepsilon \partial (\varepsilon D_{t})^{l_{n-1}} u)(\partial (\varepsilon D_{t})^{l_{n}}) \\ &= (\varepsilon \partial (\varepsilon D_{t})^{k-1} u) \tilde{\gamma} \partial + k(\partial u) \tilde{\gamma}(\varepsilon \partial (\varepsilon D_{t})^{k-1}) \\ &+ \sum_{l_{1}+l_{2}=k-1 \atop l_{1},l_{2}>0} c_{l_{1},l_{2}} (\varepsilon \partial (\varepsilon D_{t})^{l_{1}} u) \tilde{\gamma}(\partial (\varepsilon D_{t})^{l_{2}}) + \sum_{l_{1}+\dots+l_{n}=k-n+1 \atop n\geq 3} d_{l_{1},\dots,l_{n}} (\varepsilon \partial (\varepsilon D_{t})^{l_{1}} u) \cdots (\varepsilon \partial (\varepsilon D_{t})^{l_{n-1}} u)(\partial (\varepsilon D_{t})^{l_{n}}). \end{split}$$

Lemma A.4. Given integers k, l satisfying $0 \le l \le 3$ and $0 \le k \le 3 - l$, under the setting of Theorem 1.1, we have that

$$\left\| \left[\partial, (\varepsilon D_t)^{k+2l} \right] f \right\|_{3-k-l}^2 \le P(E(0)) + P(E(t)) \int_0^t P(E(\tau)) \, \mathrm{d}\tau, \tag{A.6}$$

for f = u, B, q, S.

Proof. Here we only present the proof for the most difficult case: l = 3, k = 0 because the number of total terms in this commutator is greater than any others. Also, we assume f = u without loss of generality. In view of Lemma A.3, we can see that $[\partial, (\varepsilon D_t)^6] f$ contains the following terms with certain coefficients

- Quadratic: $(\varepsilon \partial (\varepsilon D_t)^5 u)(\partial u)$, $(\varepsilon \partial (\varepsilon D_t)^4 u)(\partial (\varepsilon D_t) u)$, $(\varepsilon \partial (\varepsilon D_t)^3 u)(\partial (\varepsilon D_t)^2 u)$.
- Cubic: $(\varepsilon \partial (\varepsilon D_t)^4 u)(\varepsilon \partial u)(\partial u), (\varepsilon \partial (\varepsilon D_t)^3 u)(\varepsilon \partial (\varepsilon D_t) u)(\partial u), (\varepsilon \partial (\varepsilon D_t)^2 u)(\varepsilon \partial (\varepsilon D_t)^2 u)(\partial u), (\varepsilon \partial (\varepsilon D_t)^2 u)(\varepsilon \partial (\varepsilon D_t) u)(\partial (\varepsilon D_t) u).$
- Quartic and more low-order terms.

We notice that, in each monomial, there is exactly one term that does not have an extra ε weight, and we always set the lowest-order factor to be this term. Now we do the product estimates.

The leading-order part is $(\varepsilon \partial (\varepsilon D_t)^5 u)(\partial u)$. Using Lemma A.2, we get

$$\begin{split} &\|(\varepsilon\partial(\varepsilon D_t)^5 u)(\partial u)\|_0^2 \leq \|\varepsilon^6 D_t^5 u\|_1^2 \|\partial u\|_\infty^2 \\ &\lesssim \varepsilon^2 \|(\varepsilon D_t)^5 u(0,\cdot)\|_1^2 \|\partial u\|_2^2 + \|\partial u\|_2^2 \int_0^t \|(\varepsilon D_t)^6 u(\tau,\cdot)\|_1^2 \,\mathrm{d}\tau, \\ &\underbrace{\qquad \qquad \leq E_4(t) \int_0^t P(E_7(\tau)) \,\mathrm{d}\tau}_{} \\ &\lesssim \|\varepsilon\partial u\|_2^4 + \|(\varepsilon D_t)^5 u(0,\cdot)\|_1^4 + E_4(t) \int_0^t P(E_7(\tau)) \,\mathrm{d}\tau \end{split}$$

Next, we apply Lemma A.2 again to get

$$\|\varepsilon \partial u(t,\cdot)\|_2^4 \leq \|\varepsilon u(t,\cdot)\|_3^4 \lesssim \left(\|\varepsilon u_0\|_3^2 + \int_0^t \|\varepsilon D_t u(\tau,\cdot)\|_3^2 \,\mathrm{d}\tau\right)^2$$

Then using Jensen's inequality, we have

$$\|\varepsilon \partial u(t,\cdot)\|_2^4 \le P(E_4(0)) + \int_0^t P(E_4(\tau)) \,\mathrm{d}\tau.$$

The other terms can also be controlled in the same way, as the control of $(\varepsilon \partial (\varepsilon D_t)^m u)$ for $m \ge 3$ must generate an ε^2 weight and we can put this weight into the term that does not have extra ε weight. What becomes different is that, the lowest-order term in the monomials might be $(\partial (\varepsilon D_t)^j u)$ for j = 0, 1, 2. When j = 1, 2, we shall replace L^{∞} norm by L^6 norm and use $H^1 \hookrightarrow L^6$. We take $(\varepsilon \partial (\varepsilon D_t)^3 u)(\partial (\varepsilon D_t)^2 u)$ for an example. We have

$$\begin{split} &\|(\varepsilon\partial(\varepsilon D_t)^3 u)(\partial(\varepsilon D_t)^2 u)\|_0^2 \leq \|\varepsilon^4 \partial D_t^3 u\|_{L^3}^2 \|\partial(\varepsilon D_t)^2 u\|_{L^6}^2 \leq \|\varepsilon^4 D_t^3 u\|_2^2 \|(\varepsilon D_t)^2 u\|_2^2 \\ &\lesssim \varepsilon^2 \|(\varepsilon D_t)^3 u(0,\cdot)\|_2^2 \|(\varepsilon D_t)^2 u\|_2^2 + \underbrace{\|(\varepsilon D_t)^2 u\|_2^2 \int_0^t \|(\varepsilon D_t)^4 u(\tau,\cdot)\|_2^2 \,\mathrm{d}\tau}_{\leq E_4(t) \int_0^t P(E_6(\tau)) \,\mathrm{d}\tau} \\ &\lesssim \|\varepsilon(\varepsilon D_t)^2 u\|_2^4 + \|(\varepsilon D_t)^3 u(0,\cdot)\|_0^4 + E_4(t) \int_0^t P(E_6(\tau)) \,\mathrm{d}\tau \end{split}$$

and then apply the same argument to get

$$\|\varepsilon(\varepsilon D_t)^2 u\|_2^4 \le P(E_4(0)) + \int_0^t P(E_5(\tau)) \,\mathrm{d}\tau.$$

We can also apply such method to all the other terms in the commutators. Therefore, we conclude that

$$\left\| \left[\partial, (\varepsilon D_t)^{k+2l} \right] f \right\|_{3-k-l}^2 \le P(E(0)) + P(E(t)) \int_0^t P(E(\tau)) \, \mathrm{d}\tau, \tag{A.7}$$

for
$$f = u, B, q, S$$
.

Lemma A.5. Given integers k, l satisfying $0 \le l \le 3$ and $0 \le k \le 3 - l$, under the setting of Theorem 1.1, we have that

$$\left\| \left[(\varepsilon D_t)^{k+2l}, g \right] f \right\|_{3-k-l}^2 \le P(E(0)) + P(E(t)) \int_0^t P(E(\tau)) \, \mathrm{d}\tau, \tag{A.8}$$

for $(f,g) = (\varepsilon D_t q, a), (\varepsilon D_t u, \rho), (\varepsilon (\nabla \times B), B).$

Proof. We only consider the estimates for $\|[(\varepsilon D_t)^{k+2l}, \varepsilon B \times](\nabla \times B)\|_{3-k-l}^2$ with k=0, l=3, which is also the most difficult case, in which it contains the highest number of material derivatives and $\nabla \times B$ is a normal derivative instead of a tangential derivative.

In $[(\varepsilon D_t)^6, \varepsilon B \times](\nabla \times B)$, the leading-order part gives us two terms (with certain coefficients)

$$(\varepsilon^6 D_t^6 B) \times (\varepsilon \nabla \times B)$$
 and $(\varepsilon D_t B) \times (\varepsilon^6 D_t^5 \nabla \times B)$.

These terms are controlled in the same way as in Lemma A.4. For example, the first term is controlled by

$$\|(\varepsilon^6 D_t^6 B) \times (\varepsilon \nabla \times B)\|_0^2 \lesssim \|\varepsilon^6 D_t^6 B\|_0^2 \|\varepsilon B\|_3^2$$

where $\|\varepsilon^6 D_t^6 B\|_0^2$ has been controlled in Proposition 3.4 and Lemma A.2 gives

$$\|\varepsilon B\|_3^2 \lesssim \|\varepsilon B_0\|_3^2 + \int_0^t \|\varepsilon D_t B(\tau, \cdot)\|_3^2 d\tau.$$

The second term is controlled in a similar manner

$$\left\| (\varepsilon D_t B) \times (\varepsilon^6 D_t^5 \nabla \times B) \right\|_0^2 \lesssim \|\varepsilon D_t B\|_2^2 \|\varepsilon^6 D_t^5 \nabla \times B\|_0^2$$

$$\lesssim \|\varepsilon D_t B\|_2^2 \left(\varepsilon^2 \|\varepsilon^5 D_t^5 \nabla \times B(0, \cdot)\|_0^2 + \int_0^t \|(\varepsilon D_t)^6 \nabla \times B(\tau, \cdot)\|_0^2 d\tau \right)$$

$$\lesssim \|\varepsilon^2 D_t B\|_2^4 + \|\varepsilon^5 D_t^5 \nabla \times B(0, \cdot)\|_0^4 + \underbrace{\|\varepsilon D_t B\|_2^2 \int_0^t \|(\varepsilon D_t)^6 \nabla \times B(\tau, \cdot)\|_0^2 d\tau}_{\leq E_4(t) \int_0^t P(E_7(\tau)) d\tau}$$

$$\lesssim P(E_4(0)) + \int_0^t P(E_4(\tau)) d\tau + P(E_6(0)) + E_4(t) \int_0^t P(E_7(\tau)) d\tau.$$

The other terms can be controlled in the same way and we skip the details.
