

MACHINE PROOFS FOR ADAMS DIFFERENTIALS AND EXTENSION PROBLEMS AMONG CW SPECTRA

ABSTRACT. In this document, we describe the process of obtaining numerous Adams differentials and extensions using computational methods, as well as how to interpret the dataset uploaded to Zenodo [7]. Detailed proofs of the machine-generated results are also provided. The dataset includes information on 210 CW spectra, 624 maps, and 98 cofiber sequences. Leveraging these results, and with the addition of some ad hoc arguments derived through human insight, we successfully resolved the Last Kervaire Invariant Problem in dimension 126 [8].

1. INTRODUCTION

In this project, we first compute the Adams E_2 -pages and maps for many CW spectra using the computer program `./Adams`, developed by the first author [5]. All relevant spectra and maps have been uploaded to the Zenodo repository [7] and are described in detail in Section 2. Additionally, another program, `./ss`, also developed by the first author [5], computes Adams differentials and extensions. The resulting data are included in the Zenodo repository and described in Section 3.

The program `./ss` also generates proofs for all computed results, which are organized into a comprehensive resource we refer to as the Table of Proofs. This program partially employs the Generalized Leibniz Rule and the Generalized Mahowald Trick—two theorems established in the paper [8] addressing the Last Kervaire Invariant Problem. These theorems enable the program to derive new differentials and extensions from previously computed ones. Detailed instructions on how to interpret and navigate the Table of Proofs are provided in Section 4.

In Section 5, we present several charts and tables of machine-generated Adams differentials that are particularly relevant to the solution of the Last Kervaire Invariant Problem.

2. ADAMS E_2 DATA

2.1. Adams E_2 -pages. Tables 1–2 provide a list of the CW spectra considered in this work, along with the maximum internal degrees computed for the Adams E_2 -pages of the corresponding spectra.

For a CW spectrum X , the Adams E_2 -page data for X is available in the database file `X_AdamsSS.db` within `kervaire_database.zip`. Alternatively, the data can be accessed as three plain-text table files:

- `X_AdamsE2_generators.csv` (for generators),
- `X_AdamsE2_relations.csv` (for relations),
- `X_AdamsE2_basis.csv` (for \mathbb{F}_2 -basis).

These files are included in `kervaire_csv.rar`, available in the Zenodo repository. We illustrate these tables with examples. Tables 3–5 present the first few rows of the corresponding files for the spectrum C2 (the naming convention will be explained later).

Notation 2.1. In the table of generators, a row with $id = i$ is the i 'th generator of the E_2 -page of \mathbf{X} . In this section we will denote this generator by x_i if \mathbf{X} is a ring spectrum or v_i if \mathbf{X} is a module over some ring spectrum (in our dataset there are only two ring spectra `S0` and `tmf`). The columns `stem`, `s` are the degrees of the generators. The column `name` is the latex name we give to the i 'th generator. However, currently not all generators have latex names. The column `name` might be sometimes vacant (filled with `[NULL]`).

Notation 2.2. In the table of relations, consider the column `rel` for relations. If \mathbf{X} is a ring spectrum, then `0,1;1,2,5,4` denotes the relation

$$x_0^1 + x_1^2 x_5^4 = 0.$$

If \mathbf{X} is a module over the ring spectra \mathbf{R} , then `0,1,3;1,2,5,4,7` denotes the relation

$$x_0^1 v_3 + x_1^2 x_5^4 v_7 = 0$$

where v_i is the i 'th generator of \mathbf{X} and x_j is the j 'th generator of the ring spectrum \mathbf{R} . In summary, the semicolon can be parsed as the plus sign and the monomials are sequences of sub- and upper-scripts whose lengths are even if \mathbf{X} is a ring or odd if \mathbf{X} is a module. The columns `stem,s` are the degrees of the relations which can be determined by the degrees of the generators.

Notation 2.3. In the table of basis, the column `mon` is parsed in the same way as we parse `rel` for relations. The only difference is that each `mon` is a monomial so there should be no semicolon in the column `mon`. The columns `stem,s` are the degrees of the monomials. The column `index` is **important**. When there are multiple monomial basis elements in the same bidegree, they will be indexed by $0, 1, \dots, k$. We write

$$[i] \in \text{Ext}^{\mathbf{s}, \mathbf{stem}+\mathbf{s}}(\mathbf{X})$$

to denote the monomial basis element with index i in $\text{Ext}^{\mathbf{s}, \mathbf{stem}+\mathbf{s}}(\mathbf{X})$. In the Table of Proofs (see Section 4), the element will be written as

$$\boxed{\mathbf{X} \ (\mathbf{stem}, \ \mathbf{s}) \ [i]}$$

in the `info` column. We can also write $[i_1, i_2, \dots]$ to denote the linear combination of monomials with indices i_1, i_2, \dots and $[\]$ to denote the zero element. The `d2` column represents the d_2 differentials of the basis elements in the format $[i_1, i_2, \dots]$ we just described but in degree $(\mathbf{stem}-1, \mathbf{s}+2)$. If it is empty, it means that the d_2 differential is trivial. If it is filled with `[NULL]`, it means that the d_2 differential is not calculated yet by the program `./Adams` using the secondary Steenrod operations.

Next we explain our naming scheme for the above CW spectra. We chose to use plain text names for these objects because we want to use consistent names for computer codes, command-line arguments for `./Adams` and `./ss`, the website links of plots and the plain text machine proofs. Table 6 is a list of keywords we use in the name and the corresponding elements in $\pi_*(S^0)$ the stable homotopy groups of spheres.

Notation 2.4. Let `a,b,c,...` be keywords, a, b, c, \dots be the corresponding elements in $\pi_*(S^0)$ and $|a|, |b|, |c|$ be the topological degrees of a, b, c, \dots . The following examples demonstrate our naming for the CW spectra.

- `S0` is the sphere spectrum S^0 . `tmf` is the topological modular form tmf .
- `Ca` is the cofiber of a .
- `CW_a_b` is a three-cell complex such that the following two cofiber sequences exist.

$$\begin{aligned} \text{Ca} &\rightarrow \text{CW_a_b} \rightarrow \Sigma^{|a|+|b|+2}\text{S0} \\ \text{S0} &\rightarrow \text{CW_a_b} \rightarrow \Sigma^{|a|+1}\text{Cb} \end{aligned}$$

The existence of such complex corresponds to $a \cdot b = 0$ in $\pi_*(S^0)$.

- `CW_a_b_c` is a four-cell complex such that the following two cofiber sequences exist.

$$\begin{aligned} \text{CW_a_b} &\rightarrow \text{CW_a_b_c} \rightarrow \Sigma^{|a|+|b|+|c|+3}\text{S0} \\ \text{Ca} &\rightarrow \text{CW_a_b_c} \rightarrow \Sigma^{|a|+|b|+2}\text{Cc} \end{aligned}$$

The existence of such complex corresponds to $0 \in \langle a, b, c \rangle$ in $\pi_*(S^0)$.

- Inductively we can define `CW_a..._z` as long as it exists.

- Ca_Cb is the smash product of Ca and Cb . tmf_X is the smash product of tmf and X .
- CW_a_V_b is a three-cell complex such that the following two cofiber sequences exist.

$$\text{Ca} \rightarrow \text{CW_a_V_b} \xrightarrow{\text{top cell \#1}} \Sigma^{|b|+1}\mathbf{S}0$$

$$\text{Cb} \rightarrow \text{CW_a_V_b} \xrightarrow{\text{top cell \#2}} \Sigma^{|a|+1}\mathbf{S}0$$

- DX is a k -fold suspension of the Spanier–Whitehead dual of X such that the lowest dimension of the cells is 0.
- CW_a_A_b is equivalent to DCW_a_V_b .
- C2h4 is the same as CW_2_sigmasq . C2h5 is the same as CW_2_theta4 . C2h6 is the same as CW_2_theta5 .
- CW_a_b_V_c is a four-cell complex such that the following two cofiber sequences exist.

$$\text{CW_a_b} \rightarrow \text{CW_a_b_V_c} \rightarrow \Sigma^{|c|+1}\mathbf{S}0$$

$$\text{Cc} \rightarrow \text{CW_a_b_V_c} \rightarrow \Sigma^{|a|+1}\mathbf{C}b$$

- CW_a_b_c_Eq_d_e is a five-cell complex such that the following two cofiber sequences exist.

$$\text{CW_a_b_V_d} \rightarrow \text{CW_a_b_c_Eq_d_e} \rightarrow \Sigma^{|a|+|b|+|c|+3}\mathbf{S}0$$

$$\text{Ca} \rightarrow \text{CW_a_b_c_Eq_d_e} \rightarrow \Sigma^{\min\{|a|+|b|+2, |d|+1\}}\mathbf{C}W_c_A_e$$

The existence of such complex corresponds to $d \cdot e \in \langle a, b, c \rangle$ in $\pi_*(S^0)$.

- Joker is equivalent to $\text{CW_2_eta_2_Eq_eta_eta}$.
- RPm_n is equivalent to the stunted real projective space $\mathbb{R}P_m^n$ for positive integers m, n .

- `CPm_n` is equivalent to the stunted complex projective space CP_m^n for positive integers m, n .
- `Fphi` is the suspension of $F\phi$ the fiber of the Kahn-Priddy map $\phi : \mathbb{R}P_1^\infty \rightarrow S^0$ (or the cofiber of ϕ).
- `Fphik` is the suspension of the k -skeleton of $F\phi$ for an integers k .

Remark 2.5. All the CW spectra we considered are connective spectra. The current programs only work well with connective spectra.

Remark 2.6. If there are two or more CW spectra with different homotopy types that satisfy the same naming condition, then the name represents all choices and we do not assume which one we pick. The current important input of the program is the existence of these cofiber sequences and the ones derived from these using the properties of triangulated categories. We will make assumptions on homotopy classes in the future when a new feature of the program is complete and it will enable the `./ss` program to rigorously determine if there exists at least one homotopy class that satisfies multiple constraints.

Most of the CW spectra we consider are known to exist in the literature. For example, `CW_theta5sq_eta_2` is a subcomplex of the quadratic construction of `CW_theta5_2 = DC2h6` constructed in [1] [3]. The only exception is

`CW_sigma_nu_eta_2_etastigma`

together with its dual and subquotients. This CW complex is a six-cell complex with one cell in each dimension $d \in \{0, 8, 12, 14, 15, 24\}$ and in cohomology the 8-cell supports an Sq^{16} -operation to the top cell. The following is the proof of its existence.

We start with its 15-skeleton

`CW_sigma_nu_eta_2`.

In fact, the 4-fold Toda bracket $\langle \sigma, \nu, \eta, 2 \rangle \subset \pi_{13} = 0$ is strictly defined and has zero indeterminacy – it is simply zero.

First for degree reason if

$$h_4[8] \in E_2^{1,15+1}(\text{CW_sigma_nu_eta_2})$$

is not a permanent cycle it must support a d_7 -differential hitting $Pd_0[0]$. However, `CW_sigma_nu_eta_2` is a skeleton of `tmf` and the image of $Pd_0[0]$ in `tmf` is w_1d_0 which is a nontrivial permanent cycle. Hence $Pd_0[0]$ should not be hit by d_7 and $h_4[8]$ must be permanent. Consider the extension spectral sequence of the following cofiber sequence

$$\text{CW_sigma_nu_eta} \rightarrow \text{CW_sigma_nu_eta_2} \rightarrow \Sigma^{15}S^0.$$

For degree reason $h_1h_3 \in E_2^{1,8+1}(S^0)$ must be hit by an extension from $h_4[8]$. Hence we conclude that the top two cells of the cofiber of $h_4[8]$ is either $C(\eta\sigma)$ or $C(\eta\sigma + \epsilon)$. To rule out $C(\eta\sigma + \epsilon)$ it is sufficient to prove that in sphere

$$\kappa = \langle \nu, \eta, 2, \epsilon \rangle$$

while

$$0 = \langle \nu, \eta, 2, \eta\sigma \rangle.$$

Both 4-fold Toda brackets have zero indeterminacy.

The first one is well-known and can also be read off directly from the module structure of the E_2 -page of `CW_nu_eta` because it comes from a Massey product

$$\langle h_2, h_1, h_0, c_0 \rangle = d_0.$$

For the second one, we only need to rule out κ for filtration reasons. We have

$$\eta \langle \nu, \eta, 2, \eta\sigma \rangle \subset \langle \langle \eta, \nu, \eta \rangle, 2, \eta\sigma \rangle = \langle \nu^2, 2, \eta\sigma \rangle \supset \langle \nu^2, 2, \eta \rangle \sigma = 0.$$

It then follows from the fact that the middle 3-fold Toda bracket has zero indeterminacy.

Remark 2.7. Alternatively, given that both 4-fold Toda brackets

$$\langle \sigma, \nu, \eta, 2 \rangle, \langle \nu, \eta, 2, \eta\sigma \rangle$$

are strictly zero, the existence of `CW_sigma_nu_eta_2_etasigma` is equivalent to the fact that the 5-fold Toda bracket

$$\langle \sigma, \nu, \eta, 2, \eta\sigma \rangle$$

in π_{22} contains zero. We check that this is the case.

Observe that $\pi_{22} \cong \mathbb{Z}/2 \otimes \mathbb{Z}/2$, generated by $[h_2c_1]$ and $[Pd_0]$. We first note that the element h_2c_1 detects a homotopy class that lies in the indeterminacy of this 5-fold Toda bracket.

In fact, we have a Massey product on the E_2 -page

$$h_2c_1 = \langle h_3, h_2, h_1, h_2^3 \rangle,$$

which follows from $c_0 = \langle h_2, h_1, h_0, h_1^2 \rangle$ by applying Sq^0 and multiplying by h_2 . This implies that h_2c_1 detects a homotopy class in the 4-fold Toda bracket $\langle \sigma, \nu, \eta, \nu^3 \rangle$, which lies in the indeterminacy.

It remains to check that $[Pd_0]$ is not contained in this 5-fold Toda bracket. Since $[Pd_0]$ is detected by `tmf`, we map this 5-fold Toda bracket to `tmf`. We know $\sigma = 0$ in `tmf`, therefore this 5-fold Toda bracket becomes $\langle 0, \nu, \eta, 2, 0 \rangle$ in `tmf`, which is contained in

$$\pi_{11} \cdot \pi_{11} + \pi_{13} \cdot \pi_9 + \langle \pi_{11}, \eta, \pi_9 \rangle,$$

and can be checked to be zero.

2.2. Maps between Adams E_2 -pages. Tables 7–17 give the list of maps between CW spectra we have considered and the maximum computed internal degrees of these maps. The maximum computed internal degree of a map $f : X \rightarrow \Sigma^k Y$ refers to the maximum T such that the induced map

$$f : E_2^{s,t}(X) \rightarrow E_2^{s+\text{AF}(f), t-k+\text{AF}(f)}(Y)$$

is computed in the range $t \leq T$.

For a map `X_Y` (we will explain the naming later), the data can be found in the database file `map_AdamsSS_X_to_Y.db` in `kervaire_database.zip` or in the plain-text table file `map_X_to_Y.csv`. (A few filenames created by a newer version of `./Adams remove to` from the names.) Table 18 lists some rows from `map_C2_to_C2h4.csv` to illustrate the following notation.

Notation 2.8. In the table of maps, there are only two columns `id,map`. The `map` column gives us the image of the `id`'th generator from $E_2^{*,*}(X)$ to $E_2^{*,*}(Y)$, which

We explain our naming scheme for these maps.

Notation 2.9. Let X, Y, Z be names of CW spectra. The following examples demonstrate our naming for the maps between CW spectra.

- If X has strictly fewer cells than Y and there exists a unique k and a unique inclusion such that X is a subcomplex of $\Sigma^k Y$, then X_Y denotes this subcomplex map $X \hookrightarrow \Sigma^k Y$.
- If X has strictly more cells than Y and there exists a unique k and a unique quotient such that $\Sigma^k Y$ is a quotient complex of X , then X_Y denotes this quotient map $X \rightarrow \Sigma^k Y$.
- If we have a cofiber sequence

$$X \rightarrow \Sigma^m Y \rightarrow \Sigma^n Z \rightarrow \Sigma X$$

whose first map is a subcomplex inclusion denoted by X_Y and whose second map is a quotient map denoted by Y_Z , then the third boundary map is denoted by Z_Q_Y .

- For key words a, b, c, d, e , the map $CW_d_e_CW_a_b_by_c$ is equivalent to

$$CW_d_e_Q_CW_a_b_c_d_e.$$

Similarly, if we have a map with name $X_Y_by_c$ it means that X has a unique bottom cell and Y has a unique top cell and the map attaches the bottom cell of X to the top cell of Y by c . In other words, these two cells form a subquotient of the cofiber of the map which is equivalent to Cc .

- For numbers n, l, p, q where $p < q = n - 1 < n < l$, the map $RPn_l_RPp_q$ is equivalent to $RPn_l_Q_RPp_l$. In other words, the following three maps form a cofiber sequence.

$$(RPp_q_RPp_l, RPp_l_RPn_l, RPn_l_RPp_q)$$

- In plain-text names, we use the letter m to denote the negative sign. For example, $RP1_256_RPm7_0$ corresponds to the map

$$\mathbb{R}P_1^{256} \rightarrow \Sigma \mathbb{R}P_{-7}^0.$$

- Note that $\mathbb{R}P_0^n \equiv S^0 \vee \mathbb{R}P_1^n$. We use $RP1_256_S0$ to denote the truncated Kahn-Priddy map, which is a composition of the following maps.

$$\mathbb{R}P_1^{256} \rightarrow \mathbb{R}P_0^{256} \rightarrow \Sigma \mathbb{R}P_{-1}^{-1} = S^0.$$

Similarly, We use $CP1_128_S0$ to denote the composition of the following maps.

$$\mathbb{C}P_1^{128} \rightarrow \mathbb{C}P_0^{128} \rightarrow \Sigma \mathbb{C}P_{-1}^{-1} = S^{-1}.$$

- $S0_tmf$ and X_tmf_X are the Hurewicz maps.

All the maps except the Hurewicz maps $S0_tmf$ and X_tmf_X we considered are maps in the cofiber sequences generated by inclusions $X \subset Y$ of CW complexes, i.e., the homology maps they induce are injective, surjective or trivial.

2.3. Adams d_2 differentials. Table 19 demonstrates the range of d_2 differentials we have computed and used in the computer programs. The maximum internal degree refers to the maximum T such that all the d_2 differentials of $x \in E_2^{s,t \leq T}$ are known for the corresponding CW spectra.

We refer the reader to [4] and [9] for the algorithm that computes d_2 differentials using the secondary Steenrod operations encoded in a differential graded algebra. The first author also implement this algorithm in the program `./Adams`. The d_2 data we computed is already contained the table of basis (see Notation 2.3).

3. ADAMS SPECTRAL SEQUENCES AND EXTENSION SPECTRAL SEQUENCES

In this section we describe how the computer program `./ss` organizes the data of the Adams spectral sequence and the extension spectral sequence and how to read the differentials and extensions generated by the computer program.

The program `./ss` organizes the Adams spectral sequence by the following.

$$0 = B_1^{s,t} \subseteq B_2^{s,t} \subseteq B_3^{s,t} \subseteq \cdots \subseteq Z_3^{s,t} \subseteq Z_2^{s,t} \subseteq E_2^{s,t}$$

where B_r is the subgroup of the image of d_r differentials and Z_r is the subgroup of d_r -cycles. We can interpret Adams differentials as isomorphisms

$$(3.1) \quad d_r : Z_{r-1}^{s,t}/Z_r^{s,t} \xrightarrow{\cong} B_r^{s+r,t+r-1}/B_{r-1}^{s+r,t+r-1}$$

and therefore we can also consider the inverse

$$(3.2) \quad d_r^{-1} : B_r^{s,t}/B_{r-1}^{s,t} \xrightarrow{\cong} Z_{r-1}^{s-r,t-r+1}/Z_r^{s-r,t-r+1}.$$

Table 20 is an illustration of how we store the spectral sequence in memory. In Table 20 we can directly see that $B_2^{11,123+11}(S^0) = B_3 = B_4$ is generated by $h_0^2x_{123,9}$, $B_5^{11,123+11}(S^0) = B_6$ is generated by $h_0^2x_{123,9}$ and $h_5x_{92,10}$, and $Z_6^{11,123+11}(S^0) = Z_5 = Z_4 = Z_3$ is generated by $h_0^2x_{123,9}$, $h_5x_{92,10}$ and $x_{123,11,2} + x_{123,11} + h_0h_6[B_4]$, etc.

We write differentials in terms of elements in $E_2^{*,*}$. The value of $d_r^{\pm 1}$ should be viewed as a coset. By (3.1) and (3.2) we see that

- if we get $d_r(x) = y_1$ and $d_r(x) = y_2$ for two different reasons, then we have $y_1 - y_2 \in B_{r-1}$;
- if we get $d_r^{-1}(x) = z_1$ and $d_r^{-1}(x) = z_2$ for two different reasons, then we have $z_1 - z_2 \in Z_r$.

Consider a cofiber sequence

$$X \xrightarrow{f} Y \xrightarrow{g} Z.$$

The program `./ss` organizes the extension spectral sequence (see [8]) by the following.

$$B_\infty^{s,t} \subseteq fB_0^{s,t} \subseteq fB_1^{s,t} \subseteq \dots \subseteq gZ_1^{s,t} \subseteq gZ_0^{s,t} \subseteq Z_\infty^{s,t}.$$

where B_r is the subgroup of the image of d_r differentials and Z_r is the subgroup of d_r -cycles. We can interpret extensions as isomorphisms

$$(3.3) \quad d_r^f : fZ_{r-1}^{s,t}(X)/fZ_r^{s,t}(X) \xrightarrow{\cong} fB_r^{s+r,t+r}(Y)/fB_{r-1}^{s+r,t+r}(Y)$$

when $r > 0$ and

$$(3.4) \quad d_0^f : Z_\infty^{s,t}(X)/fZ_0^{s,t}(X) \xrightarrow{\cong} fB_0^{s+r,t+r}(Y)/B_\infty^{s+r,t+r}(Y)$$

when $r = 0$.

We write differentials in terms of elements in $E_2^{*,*}$. The value of $(d_r^f)^{\pm 1}$ should be viewed as a coset. By (3.3) and (3.4) we see that

- if $r > 0$ and we get $d_r^f(x) = y_1$ and $d_r^f(x) = y_2$ for two different reasons, then we have $y_1 - y_2 \in {}^fB_{r-1}(Y)$;
- if $r = 0$ and we get $d_0^f(x) = y_1$ and $d_0^f(x) = y_2$ for two different reasons, then we have $y_1 - y_2 \in B_\infty(Y)$.
- we leave it to the reader to think about what happens to $(d_r^f)^{-1}$ in similar situations.

The program `./ss` can compute a lot differentials and extensions based on the data structure we describe above and various structures such as the Leibniz rule and naturality. The proofs are given in the Table of Proofs (Section 4). There are three manually added differentials: $d_5 h_0^{24} h_6 = h_0^2 P^6 d_0$ and $d_6 h_0^{55} h_7 = h_0^2 x_{126,60}$ in the Adams spectral sequence of S^0 (from the image of J), and $d_3 v_2^{16} = \beta^5 g$ in the Adams spectral sequence of tmf , derived from power operations (Bruner–Rognes [2]).

The Adams differentials for a spectrum X produced by the machine are available in the database `X_AdamsSS.db` within `kervaire_database.zip`. Alternatively, the data can be accessed in the plain-text table file `X_AdamsE2_ss.csv` within `kervaire_csv.rar`.

The extensions in a cofiber sequence `X__Y__Z` are available in the database `cofseq_X__Y__Z.db` within `kervaire_database.zip`. Alternatively, the data can be accessed in the plain-text table file `cofseq_X__Y__Z.csv` within `kervaire_csv.rar`.

For illustration, Table 21 is a table of some rows from the table of Adams spectral sequence `S0_AdamsE2_ss.csv` while Table 22 is a table of some rows from the table of extension spectral sequence `cofseq_S0_C2_S0.csv`.

Notation 3.5. In the table of Adams spectral sequence, columns `stem,s` refers to the degrees of the elements in the `base` column. The columns `base,diff` should be parsed as linear combinations of the monomial basis in the corresponding bidegree. If `level=r<5000`, the `base` column is hit by a d_r -differential from `diff`. If `level=10000-r>5000`, the `base` column supports a d_r -differential hitting `diff`. If

`level=9000`, it means that `base` is a permanent cycle. If `diff` is filled with `[NULL]`, it means that the value of `diff` is undetermined. The reader can see that we assume that all visible nontrivial differentials in the data are of length shorter than 1000.

Notation 3.6. In the table of extension spectral sequence corresponding to a cofiber sequence

$$X \xrightarrow{f} Y \xrightarrow{g} Z,$$

the column `iC=0,1,2` refers to `X,Y,Z` where `base` lives respectively. The other columns are similar to those in Notation 3.5. If `iC=1` and `level=r<5000`, then `base` is hit by an f -extension which jumps filtration by r . If `iC=1` and `level=10000-r>5000`, then `base` supports an g -extension which jumps filtration by r .

Remark 3.7. All the Adams differentials and extensions can be also visually accessed from the website [6].

4. PROOFS

In this section we explain the structure and notations in our machine generated proofs. We call it the Table of Proofs. The Table of Proofs is provided in two different forms in the Zenodo repo: a single sqlite3 database file `proofs.db` and 22 plain-text tables `proofs-part1.csv`–`proofs-part22.csv`. The plain-text table is divided into 22 table files because there are more than 21 million rows in the table and some table viewers like Microsoft Excel has a row limit of one million. We encourage the reader to use the open source software DB Browser for SQLite to access the table in `proofs.db`. This tool can help you quickly search for what you want in big tables. You can also execute advanced SQL queries in the software.

The following are two typical rows in the Table of Proofs.

The first column `id` refers to the line number in the table. The columns `depth` and `reason` refer to the structure of the proof which we will explain in more details later. The column `name` refers to the name of a CW spectra or a map in a cofiber sequence.

- If `name` is the name of a CW spectrum like the first row, then the columns `stem,s,r,x,dx` refer to an Adams differential of the spectrum. In our example, this is

$$d_3([0, 2]) = [0, 1]$$

for

$$[0, 2] \in E_2^{16,107+16}(\mathbf{Ceta})$$

where $[0, 2]$ denotes the linear combination of the 0th and 2nd basis elements in $E_2^{16,107+16}$ in the basis table of `Ceta` and $[0, 1]$ denotes the linear combination in the bidegree that this differential hits.

- If `name` is the name of a map in a cofiber sequence, it is of the form `X__Y__Z:n` where

$$X \xrightarrow{f} \Sigma^n Y \xrightarrow{g} \Sigma^n Z \xrightarrow{h} \Sigma X$$

is a cofiber sequence and $n = 0, 1, 2$ correspond to f, g, h respectively. The columns `stem, s, r, x, dx` refer to an extension of the map. In our example (second row of Table 23), consider the cofiber sequence

$$Cnu \xrightarrow{f} CW_nu_eta_2 \xrightarrow{g} \Sigma^6 C2 \xrightarrow{h} \Sigma Cnu.$$

The second row of the table indicates that there is a g -extension from the permanent cycle

$$[0] \in E_2^{2,15+2}(CW_nu_eta_2)$$

to the permanent cycle

$$[0] \in E_2^{4,15+4-6}(C2)$$

which jumps filtration by $r = 2$.

Next we explain the structure of the Table of Proofs. A typical proof of an Adams differential has the following form.

Proof Structure 4.1. Assume that the value of an Adams differential $d_r(x)$ has four candidates y_1, y_2, y_3, y_4 . (Usually the number of candidates is a power of two.)

- If $d_r(x) = y_1$, propagate (by the Leibniz rule, naturality, ...). Get a contradiction.
- If $d_r(x) = y_2$, propagate. Get a contradiction.
- If $d_r(x) = y_3$, propagate. Get a contradiction.

Then we can conclude that $d_r(x) = y_4$.

The following 4 rows from the Table of Proofs is a concrete form of Proof Structure 4.1.

Here the `depth` column can be thought as the nesting level of the latex `itemize` environment. Rows with `reason='T'` correspond to assumptions ('T' is a symbol for 'Try'). Each assumption row has a multi-line proof in the `info` column which explains why the assumption leads to a contradiction. For example, the actual content of `proof1` is the following.

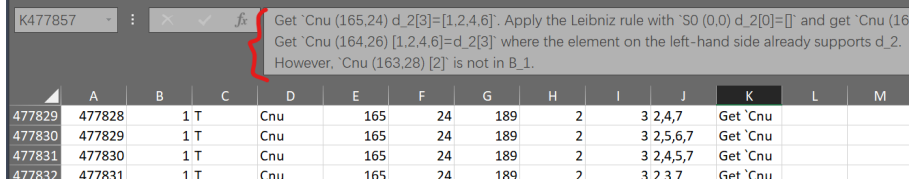
Get Csigma (116,13) d_4[1]=[3]. Apply the Leibniz rule with
S0 (20,4) d_4[0]=[] and get Csigma (136,17) d_4[]=[3].
However, Csigma (135,21) [3] is not in B_3.
```

In `proof1` the element `Csigma (135,21) [3]` refers to the element

$$[3] \in E_2^{21,135+21}(Csigma).$$

Rows with `reason='D'` correspond to the conclusions after we rule out enough candidates ('T' rows) of the value of Adams differentials or extensions ('D' is a symbol for 'Deduction').

Microsoft Excel tip: Since the text in the `info` column usually contains multiple lines, users who view the `csv` files with Excel should adjust the height of the edit box indicated by the following screenshot in order to view the whole content of the text.



Next we give examples of more complex proofs of Adams differentials.

Proof Structure 4.2. Assume that the value of an Adams differential $d_r(x)$ has four candidates $0, y_1, y_2, y_3$.

- If $d_r(x) = 0$, propagate. Assume that $d_{r+1}(x)$ has four possible values z_1, z_2, z_3, z_4 .
 - Assume $d_{r+1}(x) = z_1$. Propagate. Get a contradiction.
 - Assume $d_{r+1}(x) = z_2$. Propagate. Get a contradiction.
 - Assume $d_{r+1}(x) = z_3$. Propagate. Get a contradiction.
 - Assume $d_{r+1}(x) = z_4$. Propagate. Get a contradiction.
- If $d_r(x) = y_1$, propagate. Get a contradiction.
- If $d_r(x) = y_2$, propagate. Get a contradiction.

Then we can conclude that $d_r(x) = y_3$.

The following 8 rows from the Table of Proofs is an example of Proof Structure 4.2.

The reader can imagine that there could be proofs with even more complex structure. Consider the following.

Proof Structure 4.3. Assume that the value of an Adams differential $d_r(x)$ has four candidates $0, y_1, y_2, y_3$.

- If $d_r(x) = 0$, propagate. Assume that $d_{r+1}(x)$ has two possible values $z, 0$.
 - Assume $d_{r+1}(x) = z$. Propagate. Get a contradiction.
 We get $d_{r+1}(x) = 0$. Assume that $d_{r+2}(x)$ has two possible values w_1, w_2 .
 - Assume $d_{r+2}(x) = w_1$. Propagate. Get a contradiction.

- Assume $d_{r+2}(x) = w_2$. Propagate. Get a contradiction.
- If $d_r(x) = y_1$, propagate. Get a contradiction.
- If $d_r(x) = y_2$, propagate. Get a contradiction.

Then we can conclude that $d_r(x) = y_3$.

A proof with the above structure would be 8 rows from the Table of Proofs with (depth, reason)=(1,T), (2,T), (1,D), (2,T), (2,T), (1,T), (1,T), (0,D). If at some point in the proof we got a permanent cycle, we can even make assumptions about the value of extensions. The reader can find such examples in the Table of Proofs.

Next we describe other types of rows that can be derived from former differentials directly for different reasons.

- Rows with **reason**='d2'. This means that the d_2 differential is calculated by `./Adams` using secondary Steenrod operation algorithm.
- Rows with **reason**='N'. This means that we get a differential from a previous one by naturality.
- Rows with **reason**='G'. This means that we get a trivial differential for degree reason.
- Rows with **reason**='XX'. This corresponds to the case that if we have $d_{r-1}(x) = 0$ then we automatically get $d_r(x^2) = 0$.
- Rows with **reason**='XY'. This corresponds to the case that if we have $d_{r-1}(x) = 0$ then no matter what $d_r(x)$ is (when there are two candidates or more), we always get the same value for $d_r(xy)$ by Leibniz rule or $d_r(f(x))$ by naturality.
- Rows with **reason**='ToCs'. This means that in the extension spectral sequence, we have tried all possible values of an extension (linear combinations of elements in the E_2 -page) and the outcome is that certain element in the Adams spectral sequence should survive to the E_∞ -page and it becomes a summand of the value of the extension.
- Rows with **reason**='OutCsI'. This means that in the extensions spectral sequence, two permanent cycles should be the same on the E_∞ -page. Hence the difference **dx** should be hit by an Adams differential. In those rows the columns **stem,s,t** refer to the degree of **dx** in stead of **x**.
- Rows with **reason**='CsCm'. These are extensions obtained from some simple homotopy relations. For example, if $x \in E_\infty(S^0)$ is the target of an η -extension, then it should detect a ν -torsion ($d_n^\nu(\eta) = 0$ for all n) because we know that $\eta \cdot \nu = 0 \in \pi_*(S^0)$. The reader can find more property of extensions in [8].
- Rows with **reason**='Syn'. This means that the differential is obtained by the Generalized Leibniz Rule from the former row. The map used in the Generalized Leibniz Rule and the conditions that the machine checked is written in the **info** column.
- Rows with **reason**='SynCs'. This means that the row is an extension and is obtained by the Generalized Mahowald Trick. The cofiber sequence used in the Generalized Mahowald Trick and the conditions that the machine checked is written in the **info** column.
- Rows with **reason**='SynIn'. This means that by the Generalized Mahowald Trick we determine that an element in the Adams spectral sequence should be a permanent cycle and become a summand of an extension.

- Rows with `reason='TI'`, `'DI'`, `'GI'`. These are essentially the same as rows with `reason='T'`, `'D'`, `'G'` except that the columns `stem,s,t` refer to the degree of dx instead of x . For consecutive rows with `reason='TI'` the machine are enumerating possible sources of some differential (when we know dx is hit by some d_r differential beforehand) instead of the possible targets and the conclusion row is one with `reason='DI'`.

Remark 4.4. If the reader wants to search for a proof of certain differential, then usually you need to search for the bidegree of the source of the differential with `reason='D'` or `reason='T'`. Occasionally the machine knows the target should be hit by a certain differential first and in this case you need to search for the bidegree of the target of the differential with `reason='DI'` or `reason='TI'`.

5. CHARTS AND TABLES

In this section we list the Adams differentials of S^0 in the range $122 \leq stem \leq 127$, $0 \leq s \leq 25$ and Adams differentials of $C\nu$ in the range $stem = 126$, $9 \leq s \leq 14$. These differentials would play an important role in our solution of the Last Kervaire Invariant Problem [8].
