Rotating random trees with SKOROKHOD's M_1 topology

Abstract

We extend the classical coding of measured R-trees by continuous excursion-type functions to càdlàg excursion-type functions through the notion of parametric representations. The main feature of this extension is its continuity properties with respect to the GROMOV-HAUSDORFF-PROKHOROV topology for R-trees and SKOROKHOD's M_1 topology for càdlàg functions. As a first application, we study the R-trees $\mathscr{T}_{\mathbf{x}(\alpha)}$ encoded by excursions of spectrally positive α-stable Lέvy processes for $\alpha \in (1, 2]$. In a second time, we use this setting to study the large-scale effects of a well-known bijection between plane trees and binary trees, the so-called rotation. Marckert has proved that the rotation acts as a dilation on large uniform trees, and we show that this remains true when the rotation is applied to large critical Bienaymé trees with offspring distribution attracted to a Gaussian distribution. However, this does not hold anymore when the offspring distribution falls in the domain of attraction of an α-stable law with $\alpha \in (1, 2)$, and instead we prove that the scaling limit of the rotated trees is $\mathscr{T}_{\mathscr{K}}(\alpha)$.

1 Introduction

In studies on random trees, a classical approach is to encode trees by real-valued functions. It can be used to establish scaling limits of trees and to derive some of their geometric properties (see e.g. [\[LG05,](#page-44-0) [DLG05\]](#page-43-0)) but also to define and understand related objects such as random snakes [\[DLG02,](#page-43-1) [Mar20\]](#page-44-1) and looptrees [\[CK14,](#page-43-2) [Kha22\]](#page-44-2). In the present paper, we broaden this approach by defining measured R-trees encoded by a *càdlàg* (*i.e.* right-continuous with left limits) excursiontype function in a way that is continuous with respect to SKOROKHOD's M_1 topology on the space of càdlàg functions $D([0, 1])$. This construction generalizes the encoding of R-trees by a continuous contour function in a way that preserves some tools already used to study the geometric properties of the encoded R-trees. Moreover, since SKOROKHOD's M_1 topology is weaker than the uniform topology and SKOROKHOD's J_1 topology which are usually used in the studies on random trees, this extension also enables to get scaling limits of trees by means of a weak functional convergence of their encoding processes.

Based on this, we are able to study the large-scale effects of the so-called rotation correspondence on random trees. This has already been investigated in [\[Mar04\]](#page-44-3) in the case of uniform trees, but here we consider the wider setting of large size-conditioned BIENAYMÉ-GALTON-WATSON trees (which will simply be called Bienaymé trees in the following) with a critical offspring distribution that lies in the domain of attraction of a stable distribution with index $\alpha \in (1, 2]$. It appears that radically different behaviours occur depending on α . In the Gaussian case $\alpha = 2$, the rotation asymptotically acts as a dilation, which means that up to a dilation of distances the rotation does not affect the scaling limits of these BIENAYMÉ trees. This contrasts with the case $\alpha \in (1, 2)$, where the scaling limits of rotated trees form a new family of random R-trees which are encoded by excursions of spectrally positive α -stable Lévy processes. We also investigate some geometric properties of these trees, such as their HAUSDORFF dimension, and establish a link with the stable looptrees introduced in [\[CK14\]](#page-43-2).

Let us present our main results. We assume some familiarity with plane trees and their encoding processes (contour process, height process and Łukasiewicz walk), with scaling limits of trees and with critical Bienaymé trees whose offspring distribution lies in the domain of attraction of a stable distribution. These notions will be detailed in Sections [2,](#page-5-0) [3](#page-7-0) and [5.](#page-20-0)

SKOROKHOD's M_1 topology and (measured) R-trees. Our idea underlying the encoding of R-trees by a càdlàg function x is heavily based on a core notion of SKOROKHOD's M_1 topology,

namely the notion of parametric representations of x. In short, a parametric representation consists of an increasing and continuous parametrization of the graph of x where the discontinuities are filled in by segments. Informally, this notion provides continuous functions that are stretched versions of x. Combining this with the usual encoding of R-trees by functions in $C_0([0, 1], \mathbb{R}_+)$, which is invariant by stretching, gives a uniquely defined R-tree \mathscr{T}_x associated with $x \in D_0([0,1], \mathbb{R}_+)$ (see Definition [3.5\)](#page-12-0). Here C_0 (resp. D_0) refers to the space of continuous (resp. càdlàg) functions that vanish at 0 and 1. The tree \mathscr{T}_x may also be endowed in a natural way with a measure μ_x encoded by x (Definition [3.7\)](#page-12-1). We will give some basic properties of this construction, but its main point is that it also extends the continuity properties of $f \in C_0([0,1], \mathbb{R}_+) \mapsto \mathscr{T}_f$ and $f \in C_0([0,1], \mathbb{R}_+) \mapsto (\mathscr{T}_f, \mu_f)$ to the setting of $D_0([0,1], \mathbb{R}_+)$ endowed with the M_1 distance. More precisely, in the context of the GROMOV-HAUSDORFF topology where we deal with R-trees without considering measures, the Lipschitz property of the usual setting immediately extends as follows

Proposition 1.1. For all $x, y \in D_0([0, 1], \mathbb{R}_+),$

$$
d_{\mathrm{GH}}(\mathcal{T}_x, \mathcal{T}_y) \le 2d_{M_1}(x, y).
$$

In the context of measured R-trees, Proposition [1.2](#page-1-0) gives a slightly weaker form of continuity with respect to the GROMOV-HAUSDORFF-PROKHOROV topology.

Proposition 1.2. The map $x \in D_0([0,1], \mathbb{R}_+) \mapsto (\mathscr{T}_x, \mu_x)$ is continuous for d_{M_1} and d_{GHP} .

Large-scale effects of the rotation on BIENAYMÉ trees. Our main application of the previous extension to càdlàg functions is the study of the rotation correspondence, denoted by Rot in the following, applied to large critical Bienaymé trees. The rotation is a bijection between plane trees with n vertices and binary plane trees with n leaves which may be understood in a recursive way:

Base case: Rot $\{\emptyset\} = \{\emptyset\}$, where $\{\emptyset\}$ is the plane tree with a single vertex.

Inductive step: Consider a plane tree T with $n \geq 2$ vertices. Denote by T_1, \ldots, T_k the $k \geq 1$ subtree(s) grafted on the root. Then Rot T consists of a spine of $k + 1$ vertices with Rot T_1 grafted on the left of the 1st one, ..., Rot T_k grafted on the left of the kth one (see Figure [1\)](#page-1-1).

To understand how the rotation affects a critical BIENAYMÉ tree conditioned to have n vertices, say \mathcal{T}_n , for large n, we determine the joint scaling limit (in distribution) of $(\mathcal{T}_n, \text{Rot } \mathcal{T}_n)$, in the setting of the GROMOV-HAUSDORFF topology. This question has already been studied by MAR-CKERT [\[Mar04\]](#page-44-3) in the special case of T_n a uniform plane tree with n vertices, which corresponds to a Bienaymé tree with critical geometric offspring distribution. Marckert's result, recast in the setting of the GROMOV-HAUSDORFF topology, is

$$
\left(\frac{1}{\sqrt{n}}T_n,\frac{1}{\sqrt{n}}\operatorname{Rot} T_n\right)\xrightarrow[n\to+\infty]{(d)} \left(\sqrt{2}\mathscr{T}_e,2\sqrt{2}\mathscr{T}_e\right),\,
$$

where $\mathscr{T}_{\mathfrak{G}}$ is a Brownian Continuum Random Tree (in short, Brownian CRT), that is an R-tree encoded by normalized Brownian excursion e. Note that it is known since the pioneering work of ALDOUS [\[Ald91a,](#page-43-3) [Ald93\]](#page-43-4) that the scaling limit of \mathcal{T}_n alone, when its critical offspring distribution ALDOUS MIGHT, ARREST that the scaling finite of ℓ_n alone, when its critical onspring distribution μ has a finite variance σ^2 and we rescale its graph distance by \sqrt{n} , is a Brownian CRT dilated by

 $2/\sigma$. Thus, the main part of MARCKERT's result is the fact that T_n and Rot T_n jointly converge toward the *same* Brownian CRT, up to a dilation by a factor 2. Given this context, it is natural to ask whether a similar result holds for all Bienaymé trees whose critical offspring distribution has a finite variance. Moreover, ALDOUS' Theorem has been extended by DUQUESNE [\[Duq03\]](#page-43-5) to a wider class of critical Bienaymé trees whose scaling limits form a family of R-trees (the so-called stable trees) which contains the Brownian CRT as a special case, so the same question may be asked in this more general context. In order to answer this question, we first give more details on Duquesne's Theorem: when μ is attracted to a stable distribution with index $\alpha \in (1,2]$, the (rescaled) encoding processes of \mathcal{T}_n jointly converge towards a normalized excursion $\mathbf{x} = \mathbf{x}^{(\alpha)}$ of a spectrally positive α -stable Lévy process together with the continuous-time height excursion h associated with x, and the scaling limit of \mathcal{T}_n itself is \mathcal{T}_n *i.e.* the R-tree encoded by this continuous excursion h. Based on these results and our extension exposed in the previous part, we prove that the distributional scaling limit of Rot \mathcal{T}_n is \mathcal{T}_x , the R-tree encoded by the càdlàg excursion x.

Theorem 1.3. Let \mathcal{T}_n be distributed as $BGW_\mu(\cdot | \# \text{vertices} = n)$ where the offspring distribution µ is critical.

• Assume that μ has variance $\sigma^2 < +\infty$. We have the convergence in distribution

$$
\left(\frac{1}{\sqrt{n}}\mathcal{T}_n, \frac{1}{\sqrt{n}}\operatorname{Rot}\mathcal{T}_n\right)\xrightarrow[n\to+\infty]{(d)}\left(\frac{2}{\sigma}\mathcal{T}_e, \frac{2+\sigma^2}{\sigma}\mathcal{T}_e\right),\,
$$

with respect to the GROMOV-HAUSDORFF topology.

• Assume that μ has variance $\sigma^2 = +\infty$, and is attracted to a stable distribution of index $\alpha \in (1,2]$ $\alpha \in (1,2]$ $\alpha \in (1,2]$. There is an increasing slowly varying function¹ ℓ such that

$$
\left(\frac{\ell(n)}{n^{1-1/\alpha}}\mathcal{T}_n, \frac{1}{\ell(n)n^{1/\alpha}}\operatorname{Rot}\mathcal{T}_n\right) \xrightarrow[n \to +\infty]{(d)} (\mathcal{T}_n, \mathcal{T}_x),
$$

with respect to the GROMOV-HAUSDORFF topology.

In the Gaussian case $\alpha = 2$, we actually have that $\ln = \infty$ with this process distributed as $\sqrt{2}e$, and additionally when $\sigma^2 = +\infty$ then $\ell(n) \to +\infty$. To unify the two subcases $\sigma^2 < +\infty$ and and additionally when $\sigma^2 = +\infty$ then $\ell(n) \to +\infty$. To unity the two subcases $\sigma^2 < +\infty$ and $\sigma^2 = +\infty$, set $\ell(n) = \sigma/\sqrt{2}$ when $\sigma^2 < +\infty$, then we may rewrite the result in the Gaussian case as

$$
d_{\mathrm{GH}}\left(\frac{1}{\ell(n)\sqrt{n}}\operatorname{Rot}\mathcal{T}_n,(1+\ell(n)^2)\frac{1}{\ell(n)\sqrt{n}}\mathcal{T}_n\right)\xrightarrow[n\to+\infty]{(\mathbb{P})}0.
$$

In particular, whenever $\sigma^2 < +\infty$ the rotation acts as a dilation by a constant factor $1 + \sigma^2/2$.

In the case $\alpha \in (1, 2)$, not only does the rotation change the scale of the tree, but it also affects its geometry since we will prove that the scaling limit of rotated trees, \mathscr{T}_{x} , has geometric properties different from those of the stable tree \mathscr{T}_{h} .

Main ideas of the proof. Thanks to the continuity results (Propositions [1.1](#page-1-2) and [1.2\)](#page-1-0), we prove Theorem [1.3](#page-2-1) as a corollary of the joint convergence of the encoding processes of \mathcal{T}_n and Rot \mathcal{T}_n , as Marckert did in the case of uniform trees. The complete statement for the joint scaling limits of encoding processes is a bit more technical, it is given in Theorem [5.4,](#page-24-0) we only stress that it directly implies a refinement of Theorem [1.3](#page-2-1) with d_{GHP} instead of d_{GH} , and it relies on a comparison of the encoding processes of Rot \mathcal{T}_n with those of \mathcal{T}_n . This comparison is also based on the handy identification introduced by MARCKERT between the non-root vertices of a tree T and the internal vertices of Rot T . However, we use quite different methods to prove that the relevant encoding processes are asymptotically close to each other. Indeed, MARCKERT heavily relies on the fact that in his case Rot \mathcal{T}_n is a uniform binary tree and thus may be seen as a size-conditioned BIENAYMÉ tree whose structure is already well understood (see the comment ending Section [5.3](#page-23-0) for a more detailed discussion of MARCKERT's approach). As this property is specific to the uniform case, we use a different, more general approach here:

1. First we express the height of internal vertices of Rot \mathcal{T}_n by means of the encoding processes of \mathcal{T}_n . This requires considering the mirrored version of \mathcal{T}_n and its mirrored enumeration.

- 2. Then we introduce an intermediate process, consisting of the height of those internal vertices of Rot \mathcal{T}_n enumerated in a way corresponding to the mirrored enumeration of \mathcal{T}_n . The study of the underlying enumeration shows that there is a simple combinatorial relation between this process and the contour process of the internal vertices of Rot \mathcal{T}_n . As there are also combinatorial relations between this last process and the contour process of Rot \mathcal{T}_n , we get a link between this contour process of Rot \mathcal{T}_n and the encoding processes of \mathcal{T}_n .
- 3. Finally, we combine this with known results on encoding processes of \mathcal{T}_n to get the desired joint scaling limits with respect to some adequate topology, here we need SKOROKHOD's M_1 topology.

In short, our approach is to express as many quantities of interest as possible by means of the encoding processes of \mathcal{T}_n (rather than Rot \mathcal{T}_n), and then to establish combinatorial links between the processes easily expressed and the desired encoding processes in order to compare those processes with respect to the M_1 distance. Note that these combinatorial relations hold for all plane trees, we only make use of the fact that \mathcal{T}_n is a BIENAYMÉ tree when we use the joint convergence of its encoding processes.

Properties of \mathscr{T}_{x} and links with transformations related to the rotation. The tree \mathscr{T}_{x} obtained as a scaling limit of rotated trees can also be studied in the setting of R-trees encoded by càdlàg functions. In particular, standard arguments existing for the usual coding will be adapted and applied here in order to deduce, from properties of x, that \mathscr{T}_{x} is binary and that $(\mathscr{T}_{x}, \mu_{x})$ is a continuum random tree as defined in [\[Ald93\]](#page-43-4).

Proposition 1.4. Assume that $\alpha \in (1, 2)$. Almost surely,

- $\mathscr{T}_{\mathbf{x}}$ is binary i.e. $\forall v \in \mathscr{T}_{\mathbf{x}}$, deg $(v) \in \{1, 2, 3\}$;
- Let $\mathcal{L}(\mathscr{T}_{\mathbf{x}})$ denotes the set of leaves $\{v \in \mathscr{T}_{\mathbf{x}} : \deg(v) = 1\}$, then $\overline{\mathcal{L}(\mathscr{T}_{\mathbf{x}})} = \mathscr{T}_{\mathbf{x}}$;
- $\mu_{\rm x}$ is non-atomic and charges the leaves of $\mathscr{T}_{\rm x}$, i.e. $\mu_{\rm x}(\mathcal{L}(\mathscr{T}_{\rm x})) = 1$.

Recalling that \mathcal{T}_{h} has almost surely some vertices with infinite degree (see [\[DLG05\]](#page-43-0)), we immediately get that \mathscr{T}_{x} cannot be distributed as \mathscr{T}_{h} . Another striking difference between these trees is their HAUSDORFF dimensions, as we will prove that $\dim_H (\mathcal{T}_x) = \alpha$ while it is known that $\dim_H (\mathcal{T}_h) = \alpha/(\alpha - 1)$ (see [\[DLG05,](#page-43-0) [HM04\]](#page-44-4)). This also shows that \mathcal{T}_x is not a Brownian CRT as soon as $\alpha < 2$.

Our study of dim_H (\mathcal{T}_x) relies on an interesting link between this tree and another metric space encoded by x, the stable looptree \mathscr{L}_{x} introduced by CURIEN & KORTCHEMSKI in [\[CK14\]](#page-43-2). In short, $\mathscr{L}_{\mathbf{x}}$ appears as the scaling limit of $\text{Loop}(\mathcal{T}_n)$, where $\text{Loop}(\mathcal{T})$ is the medial graph of the plane tree T and is called the looptree associated with T . In the discrete setting, for every plane tree T we will explain that Rot T (without its leaves) can actually be seen as a specific spanning tree of Loop(T). We will then argue that in the setting of metric spaces, $\mathscr{T}_{\mathbf{x}}$ may also be seen as a spanning R-tree of \mathcal{L}_{x} . Note that KHANFIR [\[Kha22\]](#page-44-2) also studied some relations between a tree encoded by a discontinuous contour function and the looptree encoded by the same function, but his notion of R-tree encoded by a discontinuous excursion is different from ours. Here the relation between $\mathscr{T}_{\mathbf{x}}$ and $\mathscr{L}_{\mathbf{x}}$ is the following:

Proposition 1.5. Assume that $\alpha \in (1,2)$. Consider the canonical projections $\pi_{\mathbf{x}}^{tree} : [0,1] \mapsto \mathscr{T}_{\mathbf{x}}$ and $\pi_{\mathbf{x}}^{loop} : [0,1] \mapsto \mathcal{L}_{\mathbf{x}}$. There exists a unique map $p : \mathcal{T}_{\mathbf{x}} \mapsto \mathcal{L}_{\mathbf{x}}$ which satisfies

$$
p \circ \pi_{\mathbf{x}}^{tree} = \pi_{\mathbf{x}}^{loop}.
$$

Moreover, p is 1-LIPSCHITZ and p restricted to $\mathcal{T}_{\mathbf{x}}^* = \mathcal{T}_{\mathbf{x}} \setminus {\lbrace \pi_{\mathbf{x}}^{tree}(s) \text{ for } s \in \text{Disc}(\mathbf{x}) \rbrace}$ is one-to-one and onto.

Finally, these metric spaces have the same H AUSDORFF dimension:

$$
\dim_H(\mathscr{T}_\mathbf{x}) = \dim_H(\mathscr{L}_\mathbf{x}) = \alpha.
$$

Remarks.

• We believe that the first assertion also holds in a sense for a general càdlàg excursion x. To be more precise, we do not have in general that \mathcal{T}_x (as defined in this paper) and \mathcal{L}_x (as defined in $[Kha22]$ in the case where x has no negative jump) are related in a similar way, but \mathcal{T}_x might be a spanning R-tree of \mathcal{V}_x the vernation tree encoded by x. This metric space is defined by KHANFIR in [\[Kha22\]](#page-44-2) to unify looptrees and their limits. However, we have not investigated this point further.

- In the case $\alpha = 2$, the scaling limit of $\frac{\ell(n)}{\sqrt{n}}\text{Loop}(\mathcal{T}_n)$ is $C(\mu)\mathscr{T}_{\sqrt{2}e}$ where $C(\mu)$ is a constant depending on μ (see [\[CHK15,](#page-43-7) [KR20\]](#page-44-5)). Note that this limit is not a looptree, but as an R-tree it is a vernation tree, and one could clearly consider this tree a spanning R-tree of itself. Thus in this particular case we do have that the scaling limit of Rot \mathcal{T}_n is distributed as a spanning R-tree of the scaling limit of $\text{Loop}(\mathcal{T}_n)$, but surprisingly when $\sigma^2 < +\infty$ the constant $C(\mu)$ depends on μ in a more complicated fashion than the constant $1 + \sigma^2/2$ arising for Rot \mathcal{T}_n .
- This simple relation between $\mathscr{T}_{\mathbf{x}}$ and $\mathscr{L}_{\mathbf{x}}$ contrasts with the fact that we do not know if $\mathscr{T}_{\mathbf{x}}$ may be expressed as a simple measurable function of \mathcal{T}_{h} and vice versa.

The setting of R-trees encoded by càdlàg functions is also convenient to study the limits in distribution of $\alpha \mapsto \mathscr{T}_{\mathbf{x}(\alpha)}$ and its measured version. Indeed, by our results of continuity, Proposition[s1.1](#page-1-2) and [1.2,](#page-1-0) convergences for $\alpha \mapsto \mathbf{x}^{(\alpha)}$ directly implies the corresponding convergences for trees and measured trees. For instance, the continuity in distribution of $\alpha \in (1,2) \mapsto \mathbf{x}^{(\alpha)}$ (discussed, with the stronger J_1 topology, in [\[KM24,](#page-44-6) Lemma 5.1]) is transferred to their measured trees. The most interesting fact obtained this way is that $\alpha \mapsto \mathscr{T}_{\mathbf{x}(\alpha)}$ interpolates between the line segment and the Brownian CRT (see Figure [2\)](#page-4-0) and this also holds for their measured version.

Proposition 1.6. We have the following convergences in distribution with respect to the GROMOV-HAUSDORFF-PROKHOROV topology

Let us finally discuss some properties related to $\mathscr{T}_{\mathbf{x}}$ seen as a limit. We introduced $\mathscr{T}_{\mathbf{x}}$ as the distributional scaling limit of Rot \mathcal{T}_n , but it is also the scaling limit of another sequence of trees. Indeed, the rotation comes with a symmetric counterpart, the co-rotation, denoted here by Tor. It also maps a plane tree T into a binary tree which is another spanning tree of $\text{Loop}(T)$, and it appears that the scaling limit of Tor \mathcal{T}_n is again \mathcal{T}_x (see Corollary [5.8\)](#page-28-0). We have chosen to say a few words about the large-scale effects of Tor on Bienaymé trees compared to the effects of Rot, because the encoding processes of Tor \mathcal{T}_n surprisingly behave in a simpler way than those of Rot \mathcal{T}_n . This also provides interesting examples concerning the relation between the scaling limits of some trees and their ŁUKASIEWICZ walks: the ŁUKASIEWICZ walks of Rot \mathcal{T}_n and Tor \mathcal{T}_n have radically different scaling limits despite the fact that the trees themselves shared the same distributional scaling limit (see Theorem [5.10](#page-29-0) and its comments). On the contrary, the ŁUKASIEWICZ walk of Tor \mathcal{T}_n has the same distributional scaling limit as the ŁUKASIEWICZ walk of \mathcal{T}_n even though these trees have different scaling limits.

Outline. First we present our notation for finite plane trees and their encoding processes in Section [2.](#page-5-0) In Section [3](#page-7-0) we introduce all the usual notions needed to consider scaling limits of trees and measured trees, and then we briefly present the notion of parametric representations underlying SKOROKHOD's M_1 topology in order to define and study measured R-trees encoded by discontinuous excursions. We end this section by investigating the particular case of R-trees encoded by an α-stable excursion. The rest of the paper is dedicated to the study of the rotation correspondence: Section [4](#page-16-0) contains definitions of this correspondence and related objects, then in Section [5](#page-20-0) we give some existing results of Duquesne for Bienaymé trees before establishing the scaling limits of all encoding processes of rotated Bienaymé trees as well as those of corotated Bienaymé trees. This section contains both statements and proofs of these results, except four lemmas which compare some encoding processes with respect to the M_1 distance. We prove these lemmas in Section [6,](#page-30-0) which is dedicated to the use of combinatorial relations to control M_1 distances. Finally, Appendix [A](#page-40-1) is devoted to the proof of a minor extension of Duquesne's result needed here.

2 Basics on finite plane trees

Ulam-Harris-Neveu formalism. All trees here will be plane trees, and we will use standard notation for these trees (see e.g. [\[LG05\]](#page-44-0)): plane trees will be subtrees of ULAM's tree $\mathcal{U} =$ $\bigcup_{n\in\mathbb{N}}(\mathbb{N}^*)^n$. Here, $(\mathbb{N}^*)^0 = \{\varnothing\}$. \varnothing is the root of U, and for any $u = u_1 \dots u_n \in \mathcal{U}$ and $j \in \mathbb{N}^*$ we say that $uj = u_1 \ldots u_n j$ is the jth child of u. We thus define parent $(i,j) = u$, and we denote by $|u| = n$ the *height* (or generation) of u in the tree U. The notion of parent is well-defined for every u such that $|u| \geq 1$, as well as the notion of ancestors.

A finite plane tree T is a finite subset of U such that:

- (a) $\varnothing \in T$.
- (b) For $u \neq \emptyset$, $u \in T$ implies parent $(u) \in T$.
- (c) For every $u \in T$, there is $d_u(T) \in \mathbb{N}^*$ such that for any $j \in \mathbb{N}^*$, $uj \in T$ if and only if $1 \leq j \leq d_u(T)$.

We interpret $d_u(T)$ as the number of children of u in T. When $d_u(T) = 0$ we say that u is a leaf of T , else it is an internal vertex of T . We equip every plane tree T with the lexicographical order \preccurlyeq (induced on it by the lexicographical order of U), and the sequence $u_0 = \emptyset, \ldots, u_{\#T-1}$ of the vertices of T in lexicographical order will be called the lexicographical enumeration of T (see Figure [3\)](#page-5-1).

Figure 3: A plane tree (as a subtree of \mathcal{U}). Its lexicographical enumeration is $u_0 = \emptyset, u_1 = 1, u_2 = 11, u_3 = 12, u_4 = 2, u_5 = 3, u_6 = 31.$

Large critical BIENAYMÉ trees. We focus on some specific probability measures on the set of finite plane trees. To define them, let μ be a probability measure on N, called the offspring distribution, and assume that μ is *critical*, which means it has mean 1 but is not the DIRAC mass δ₁. Let $(k_u)_{u \in \mathcal{U}}$ be i.i.d. random variables with distribution μ , then almost surely there exists a unique finite plane tree T such that $\emptyset \in \mathcal{T}$ and $\forall u \in \mathcal{T}$, $d_u(\mathcal{T}) = k_u$. It corresponds to a family tree where each individual reproduces (on its own) independently of the rest and its offspring is distributed according to μ . We denote by BGW_u its distribution, and any random tree with this

distribution is called a BIENAYMÉ tree with offspring distribution μ . We will work with such trees but conditioned to have exactly n vertices. Obviously, we implicitly restrict our attention to those integers n such that $BGW_{\mu}(\# \text{vertices} = n) > 0$. Note that there are infinitely many such n, hence we can choose n arbitrarily large.

Encoding processes. A standard way to study plane trees is to use one-to-one correspondences with some integer-valued processes, called encoding processes in the following. Here we will mostly use those presented in [\[LG05\]](#page-44-0), namely the (lexicographic) height process, the contour process, and the (lexicographic) Łukasiewicz walk, and we will use them in two forms: discrete sequences and their associated time-scaled functions (see Figure [4\)](#page-6-0). To introduce our notation, let $u_0 =$ $\varnothing, \ldots, u_{\#T-1}$ be the lexicographical enumeration of T.

- The height process $H_T = (H_T(k))_{0 \le k \le \#T}$ is defined by $H_T(k) = |u_k|$ for $k < \#T$ and $H_T(\#T) = 0$ by convention.
- The contour process $C_T = (C_T(k))_{0 \le k \le 2(\#T-1)}$ is informally constructed as follow: Imagine a particle living on the tree T and initially located at the root. This particle can move in a discrete fashion, its elementary move simply is to go from its current vertex to one of its neighbours in T. Let $x_0 = \emptyset, x_1, \ldots, x_{2(\#T-1)} = \emptyset$ be the sequence of vertices visited (in this order) by the particle when it goes straight from $u_0 = \emptyset$ to u_1 , then from u_1 to u_2, \ldots , then from $u_{\#T-1}$ to ∅ (*i.e.* the particle follows the contour of T from the left to the right). The contour process records the height of the particle at each step: $\forall 0 \le k \le 2(\#T - 1), C_T(k) = |x_k|$.
- The ŁUKASIEWICZ walk $S_T = (S_T(k))_{0 \le k \le \#T}$ is defined by:

$$
S_T(0) = 0
$$
 and $\forall k < \#T$, $S_T(k+1) - S_T(k) = d_{u_k}(T) - 1$.

One can see the Łukasiewicz walk as a record of the out-degrees (in lexicographical order), but there is another way to understand it. For any $u \in T$, we denote by $\llbracket \varnothing, u \rrbracket$ the set of its ancestors (which does not contain u). Observe that for $k < \#T$

$$
S_T(k) = \sum_{\ell < k} d_{u_\ell}(T) - k
$$
\n
$$
= \# \{ v \in T \setminus \{ \varnothing \} \mid \text{parent}(v) \prec u_k \} - \# \{ v \in T \setminus \{ \varnothing \} \mid v \preccurlyeq u_k \}
$$
\n
$$
= \# \{ v \in T \setminus \{ \varnothing \} \mid \text{parent}(v) \in [\varnothing, u_k[[\text{ and } v \succ u_k]].
$$

Visually, $[\[\mathcal{O}, u]]$ forms a spine in T and $\#\{v \in T \setminus \{\emptyset\} \mid \text{parent}(v) \in [\[\mathcal{O}, u]] \text{ and } v \succ u\}$ is the number of edges grafted on $\llbracket \emptyset, u \rrbracket$ on its *right* side. We call this quantity $R(u)$, which implicitly depends on T, and we also define its left equivalent $L(u) = #{w \in T \setminus \{\varnothing\}}$ parent $(w) \in [\![\varnothing, u]\!], w \notin [\![\varnothing, u]\!]$ and $w \prec u$, *i.e.* the number of edges grafted on $[\![\varnothing, u]\!]$ on its left side. We thus get the useful alternative definition:

$$
\forall k < \#T \ S_T(k) = R(u_k), \text{ and } S_T(\#T) = -1.
$$

Figure 4: Height, contour and ŁUKASIEWICZ processes of the tree depicted in Figure [3.](#page-5-1) Each of them fully characterizes this tree.

With any sequence $A = (A(k))_{0 \le k \le p}$ we associate a continuous function $a \in C([0, 1])$ that will be called its time-scaled function: a is the unique function affine on each segment $\left[k/p,(k+1)/p\right]$ and such that $\forall k \in [0, p]$ $a(k/p) = A(k)$. Let us stress that we only rescale time while space is unaffected.

As we will make an extensive use of them, we make an explicit definition of the time-scaled height, contour, and ŁUKASIEWICZ functions of T obtained with this procedure:

• The time-scaled height function is $h_T \in C([0, 1])$ associated with H_T , hence

$$
\forall k \in [0, \#T - 1], h_T\left(\frac{k}{\#T}\right) = H_T(k) = |u_k| \text{ and } h_T(1) = H_T(\#T) = 0.
$$

• The time-scaled contour function is $c_T \in C([0,1])$ associated with C_T , hence

$$
\forall k \in [0, 2(\#T - 1)], \ c_T\left(\frac{k}{2(\#T - 1)}\right) = C_T(k) = |x_k|.
$$

• The time-scaled ŁUKASIEWICZ function is $s_T \in C([0, 1])$ associated with S_T , hence

$$
\forall k \in [0, \#T - 1], s_T\left(\frac{k}{\#T}\right) = S_T(k) = R(u_k)
$$
 and $s_T(1) = S_T(\#T) = -1$.

Note that we will also consider time-scaled functions associated with other sequences.

3 R-trees and contour functions

In this section, we first explain the standard setting for studying scaling limits of random plane trees, in particular we emphasize how to understand trees, R-trees and their convergence through their *contour functions*. Then we introduce our extension and prove that a contour function remains a useful tool in this new setting, and finally we apply our results to study the R-trees encoded by spectrally positive α -stable excursions.

3.1 Standard setting for scaling limits of trees

In the context of scaling limits, a plane tree T is seen as a rooted compact metric space: we identify it with the finite set of its vertices equipped with the graph distance in T , and the root is a distinguished point of this space. Note that it is not a one-to-one identification as we forget the planar order of T. The point of this setting is that we can rescale trees, *i.e.* we can consider λT obtained from T by multiplying its metric by λ , in order to study the asymptotic geometry of some suitably rescaled trees by means of the GROMOV-HAUSDORFF distance d_{GH} . Based on [\[LG05,](#page-44-0) [Mie09\]](#page-44-7), we will give a quick presentation of this distance d_{GH} , but also of the GROMOV-HAUSDORFF-PROKHOROV distance d_{GHP} . The interest of this distance on rooted compact metric spaces endowed with BOREL probability measure is that it enables us to describe both the asymptotic geometry of some large finite trees and the asymptotic distribution of vertices picked uniformly at random in these trees. We will then introduce the metric spaces obtained as scaling limits of large finite trees, namely R-trees, and explain the standard tools and techniques (such as contour functions) used here to deal with both R-trees and measured R-trees.

The GROMOV-HAUSDORFF and GROMOV-HAUSDORFF-PROKHOROV distances. At first, let us consider K_1, K_2 two compact subsets of some metric space (E, d) . One can compare them with the classical HAUSDORFF distance relative to (E, d) : for $A \subset E$ and $r > 0$, let A^r be the r-neighbourhood of A, i.e. $A^r = \{x \in E \text{ such that } d(x, A) < r\}$. The distance between K_1 and K_2 is

 $d_{\text{haus}}(K_1, K_2) = \inf\{r > 0 \text{ such that } K_1 \subset K_2^r \text{ and } K_2 \subset K_1^r\}.$

To compare two general compact metric spaces (K_1, d_1) and (K_2, d_2) with distinguished vertices $x_1 \in K_1$ and $x_2 \in K_2$, the idea behind the GROMOV-HAUSDORFF distance simply is to embed them in a common metric space in order to make them as close as possible in the sense of the previous distance. Here we deal with rooted metric spaces, so we also take the distinguished point into account and the distance takes the following form:

$$
d_{GH}((K_1, d_1, x_1), (K_2, d_2, x_2)) = \inf_{\phi_1, \phi_2} \{ d_{\text{haus}}(\phi_1(K_1), \phi_2(K_2)) \vee d(\phi_1(x_1), \phi_2(x_2)) \} \tag{1}
$$

where (ϕ_1, ϕ_2) can be any pair of isometric embeddings of K_1 and K_2 into a common metric space and, for simplicity, d always denotes the distance on this associated common space.

For practical use, we can rely on an alternative definition that does not require embedding K_1 and K_2 . First, a correspondence between K_1 and K_2 is a measurable subset C of $K_1 \times K_2$ such that for every $y_1 \in K_1$ there is $y_2 \in K_2$ with $(y_1, y_2) \in \mathcal{C}$ and conversely for every $y_2 \in K_2$ there is $y_1 \in K_1$ with $(y_1, y_2) \in \mathcal{C}$. The *distortion* of the correspondence \mathcal{C} is defined by

$$
dis(\mathcal{C}) = \sup_{(y_1, y_2), (z_1, z_2) \in \mathcal{C}} |d_1(y_1, z_1) - d_2(y_2, z_2)|
$$

As mentioned in [\[LG05\]](#page-44-0), the GROMOV-HAUSDORFF distance d_{GH} between K_1 and K_2 can be reformulated as half the infimum of distortion of correspondences that contain the pair of distinguished vertices (x_1, x_2) :

$$
d_{\mathrm{GH}}\big((K_1, d_1, x_1), (K_2, d_2, x_2)\big) = \frac{1}{2} \inf_{\mathcal{C} \ni (x_1, x_2)} \mathrm{dis}(\mathcal{C}).\tag{2}
$$

Now let us endow K_1 and K_2 with some BOREL probability measures μ_1 and μ_2 . The idea behind the GROMOV-HAUSDORFF-PROKHOROV distance d_{GHP} is quite similar to the one that led to [\(1\)](#page-7-1) to define d_{GH} : one embeds K_1 and K_2 in a common metric space in order to make them as close as possible in the sense of the HAUSDORFF distance (and the distance between the distinguished vertices) but also in the sense of the Lévy-prokhorov distance between the Borel probability measures obtained by pushing forward μ_1 and μ_2 . However, there is again an equivalent definition based on the notion of correspondence and more convenient to work with:

$$
d_{\text{GHP}}\big((K_1, d_1, x_1, \mu_1), (K_2, d_2, x_2, \mu_2)\big) = \inf_{\mathcal{C},\nu} \frac{1}{2} \text{dis}(\mathcal{C}) \vee (1 - \nu(\mathcal{C}))
$$
\n(3)

where the infimum is taken over all correspondences C between K_1 and K_2 containing the pair of distinguished vertices (x_1, x_2) and all probability measures ν on $K_1 \times K_2$ that form a coupling of μ_1 and μ_2 . Note that $d_{GH}((K_1, d_1, x_1), (K_2, d_2, x_2)) \leq d_{GHP}((K_1, d_1, x_1, \mu_1), (K_2, d_2, x_2, \mu_2)),$ whatever μ_1 and μ_2 are.

In these settings, a map $f: K_1 \mapsto K_2$ is called an *isometry* when it is one-to-one and preserves the distances and distinguished points in the case of rooted compact metric spaces, and additionally the measures when the spaces are endowed with measures. The notion of *isometry* must not be confused with the notion of isometric map, which denotes a map that preserves the distances (without any other requirement, in particular it does not have to be onto). We finally say that K_1 and K_2 are isometric when there is an isometry $f: K_1 \mapsto K_2$.

Actually, d_{GH} and d_{GHP} are pseudo-distances: two spaces are at distance 0 if and only if they are isometric, and d_{GH} (resp. d_{GHP}) truly defines a distance between *isometry classes* of (resp. measured) rooted compact metric spaces. In both cases, this set of isometry classes equipped with the corresponding distance turns out to be complete and separable (see [\[Mie09,](#page-44-7) [Pet16\]](#page-44-8) for proofs).

R-trees. The compact metric spaces obtained as scaling limits of large but finite plane trees always have some specific properties: they are geodesic metric spaces that are acyclic in a sense. A compact metric space with these properties is called an R-tree (or a real tree). However we will not give any further details here on these metric properties, and instead of this we define R-trees with their representations through contour functions. We refer to [\[LG05\]](#page-44-0) for a more complete introduction.

Consider $f \in C_0([0, 1], \mathbb{R}_+)$, *i.e.* a positive continuous function such that $f(0) = f(1) = 0$. By mimicking the way that the contour process of a plane tree can be used to compute distances in this tree, we define a pseudo-distance d_f on [0, 1]: The most recent common ancestor of two points s, t would be a point $a \in [s \wedge t, s \vee t]$ such that $f(a) = \inf_{[s \wedge t, s \vee t]} f$ and thus we set

$$
d_f(s,t) = f(s) + f(t) - 2 \inf_{[s \wedge t, s \vee t]} f.
$$
 (4)

It satisfies the triangular inequality, but $d_f(s, t) = 0$ can occur even though $s \neq t$. However, once we define an equivalence relation by $s \sim_f t$ if and only if $d_f(s,t) = 0$, we get that d_f becomes a distance on the quotient set $[0,1]/\sim_f$. We let \mathscr{T}_f denote the resulting metric space $([0,1]/\sim_f,d_f)$ and π_f denote the canonical projection from [0, 1] onto \mathscr{T}_f . This projection is continuous and onto, hence \mathscr{T}_f is compact, and we consider this metric space as rooted at $\pi_f(0)$.

The metric spaces called R-trees are those which can be represented as \mathscr{T}_q for some g:

Definition 3.1. A rooted compact metric space K is an R-tree if and only if it is isometric to \mathcal{F}_f for some $f \in C_0([0,1], \mathbb{R}_+)$, which is then called a contour of this \mathbb{R} -tree.

Remark. This definition is equivalent to [\[LG05,](#page-44-0) Definition 2.1] since \mathcal{I}_f always satisfies the requirements of [\[LG05,](#page-44-0) Definition 2.1] and conversely all R-trees (in the sense of [\[LG05,](#page-44-0) Definition 2.1]) can be represented by a contour function (see $[LG05,$ Theorem 2.2] and $[Duq06,$ Corollary 1.2]).

Remark. In this definition, f is far from unique. In particular we stress that any monotone and onto map $\phi : [0, 1] \mapsto [0, 1]$ induces an isometry $\tilde{\phi} : \mathscr{T}_{f \circ \phi} \mapsto \mathscr{T}_f$ such that $\tilde{\phi} \circ \pi_{f \circ \phi} = \pi_f \circ \phi$. We also mention that a dilation of f implies a dilation of the corresponding tree, i.e. $\forall \lambda > 0$, $\mathscr{T}_{\lambda f} = \lambda \mathscr{T}_{f}$.

Finally, an R-tree is said to be *measured* when it is endowed with a BOREL probability measure. A convenient way to define such a measure on an R-tree is again to use a contour function: for $f \in C_0([0,1], \mathbb{R}_+)$, we let μ_f be the pushforward of Leb by the projection $\pi_f : [0,1] \mapsto \mathscr{T}_f$, i.e.

 μ_f is the law of $\pi_f(U)$ where U is uniformly distributed over [0, 1].

Note that for some contour functions f, g, we have that \mathscr{T}_f and \mathscr{T}_g are isometric while (\mathscr{T}_f, μ_f) and (\mathscr{T}_q, μ_q) are not.

A crucial example is given by c_T the time-scaled contour function of some finite plane tree T . The connected metric space \mathcal{T}_{cT} cannot be the discrete metric space T (except for $T = \{\varnothing\}$), but it is closely related to it: it is (isometric to) the metric space obtained from T by considering edges as segments with unit length and vertices as the endpoints of these segments. To be precise, for each vertex, all the incident edges are unit segments that merge at their endpoint corresponding to this vertex. Moreover this space is rooted at the endpoint corresponding to \varnothing . The measure μ_{c_T} corresponds to the uniform measure on the union of the unit-length segments. Observe further that T is isometric to the subset of endpoints of edges of \mathscr{T}_{c_T} and that each $x \in \mathscr{T}_{c_T}$ belongs to an edge thus is at distance at most 1 from its farthest away endpoint from the root. Consequently,

$$
\forall \lambda > 0, \ d_{\text{GH}}(\lambda T, \mathcal{T}_{\lambda c_T}) \le d_{\text{GHP}}((\lambda T, \text{UNIF}_T), (\mathcal{T}_{\lambda c_T}, \mu_{\lambda c_T})) \le \lambda \vee \frac{1}{\#T}.
$$
 (5)

As we think of an R-tree $\mathscr T$ as a tree, we say that $x \in \mathscr T$ is a vertex of $\mathscr T$ and its degree $\deg(x)$ is the number of connected components of $\mathcal{F}\backslash\{x\}$. A vertex x is said to be a leaf when deg(x) = 1, and a branch-point when $deg(x) \geq 3$.

Convergence through contour functions. We have chosen to discuss R-trees directly through their representation by contour functions since our goal is to extend this representation to càdlàg functions, but also because this is all we need here to study scaling limits of random trees. Indeed, convergence of contour functions directly implies convergence of trees for d_{GH} and d_{GHP} . See e.g. [\[LG05\]](#page-44-0) for a proof of the fact that $f \mapsto \mathscr{T}_f$ is lipschitz for d_{GH} , and it is not difficult to adapt this proof to see that the same result holds for d_{GHP} :

Lemma 3.2 ([\[LG05,](#page-44-0) Lemma 2.4]). For $f, g \in C_0([0, 1], \mathbb{R}_+),$

$$
d_{\mathrm{GHP}}\big((\mathscr{T}_f,\mu_f),(\mathscr{T}_g,\mu_g)\big)\leq 2\,\|f-g\|_\infty\,.
$$

This gives a convenient way to get scaling limits for trees by means of functional scaling limits. As an illustration, let us briefly discuss the first historical example of scaling limit result for trees, namely ALDOUS' theorem (although ALDOUS stated and proved it in a different way in his original articles [\[Ald91b,](#page-43-9) [Ald93\]](#page-43-4)). Fix a critical offspring distribution μ with finite variance σ^2 and for all adequate $n \in \mathbb{N}^*$ let \mathcal{T}_n be a random tree with law $BGW_\mu(\cdot | \# \text{vertices} = n)$. It has been shown that $\left(\frac{\sigma}{2\sqrt{n}}c_{\mathcal{T}_n}\right)_n$ converges in distribution (with respect to $\left\|\cdot\right\|_{\infty}$) to a normalized Brownian excursion e, see *e.g.* [\[LG05\]](#page-44-0). This entails that $\left(\frac{\sigma}{2\sqrt{n}}\mathcal{Z}_{\sigma_{\tau_n}}\right)_n$ converges in distribution (with respect to d_{GH}) towards $\mathscr{T}_{\mathcal{E}}$, which is called a Brownian Continuum Random Tree (or Brownian CRT). Moreover [\(5\)](#page-9-0) yields

$$
d_{\mathrm{GH}}\left(\frac{\sigma}{2\sqrt{n}}\mathcal{T}_n,\frac{\sigma}{2\sqrt{n}}\mathcal{Z}_{\sigma_{\mathcal{T}_n}}\right)\leq \frac{\sigma}{2\sqrt{n}}\vee \frac{1}{n}\xrightarrow[n\to+\infty]{}0.
$$

Hence we actually have that $\left(\frac{\sigma}{2\sqrt{n}}\mathcal{T}_n\right)_n$ converges in distribution towards a Brownian CRT. Moreover this argument works fine with d_{GHP} too, so we also have the stronger convergence of these trees endowed with their uniform probability measure toward $(\mathscr{T}_{e}, \mu_{e})$.

This illustration is important here for two reasons:

• This range of application of this method will be broadened by our extension of the coding of R-trees by contour functions, and thus we will be able to apply this method to obtain the convergence of rotated trees (Theorem [1.3\)](#page-2-1).

• Our main tool to study the encoding processes of rotated trees will be a generalization of ALDOUS' theorem which establishes scaling limits of all encoding functions of \mathcal{T}_n under weaker assumptions (see Section [5.2\)](#page-21-0).

Finally, let us stress that the encoding processes of \mathcal{T}_n not only encode the metric space \mathcal{T}_n endowed with a measure but also contain additional structure such as the order on this tree, hence the convergence of these processes could be used to obtain reinforcement of the convergence of trees as measured metric spaces (see e.g. $[Duq06]$ where a contour function f also induces a linear order on the corresponding R-tree).

3.2 Skorokhod's M_1 topology and discontinuous contour functions

We now turn to an extension of the standard setting exposed above. We are going to explain how to define an R-tree, possibly endowed with a measure, from a càdlàg contour function $x \in$ $D_0([0,1], \mathbb{R}_+)$ (*i.e.* a positive càdlàg function vanishing at 0 and 1). This extension is based on the notion of parametric representations underlying SKOROKHOD's M_1 topology on $D([0, 1])$, hence we will begin with this notion before discussing the encoding of R-trees. Then we will end this section by deriving from this construction some properties of continuity with respect to this topology. As a consequence, we will get the convergence of trees as a direct corollary of the convergence of contour functions with respect to the M_1 topology. This will be particularly useful to study the rotation correspondence in the second part of this paper, because some encoding processes of rotated trees cannot be handled with the classical SKOROKHOD's J_1 topology on $D([0, 1])$ while the M_1 topology provides an adequate framework to obtain their scaling limits (see the first comment in Section [5.5](#page-29-1) for more details).

Note that the presentation of parametric representations and SKOROKHOD's M_1 topology given in this section is mostly based on [\[Whi02,](#page-44-9) section 3.3, section 11.5.2, section 12.3], which we refer to for more details.

Parametric representations of a discontinuous function. For $x \in D([0,1])$, we first introduce its *completed graph* Γ_x :

$$
\Gamma_x = \left\{ \left(\lambda x(t-) + (1-\lambda)x(t), t \right) \in \mathbb{R} \times [0,1], \text{ for } (t,\lambda) \in [0,1]^2 \right\}.
$$

In words, Γ_x is the graph of x completed with vertical segments to fill in the discontinuities of x so that it becomes close and connected. We endow it with a linear order based on how to draw Γ_x from left to right in a continuous way: $(z_1, t_1) \leq (z_2, t_2)$ if either $t_1 < t_2$ or $t_1 = t_2$ and $|z_1 - x(t_1-)| \leq |z_2 - x(t_2-)|.$

Definition 3.3. A parametric representation of x is a non-decreasing (in the sense of the order on Γ_x) continuous and onto function $(\chi, \tau) : [0, 1] \to \Gamma_x \subset \mathbb{R} \times [0, 1]$. Its first component $\chi : [0, 1] \to \mathbb{R}$ is its spatial component while $\tau : [0, 1] \rightarrow [0, 1]$ is its temporal component.

Figure 5: The completed graph of $x = \mathbb{1}_{[1/2,1]}$ on the left, and one of its parametric representations on the right.

Given a parametric representation (χ, τ) of x, one can see that its temporal component τ is continuous non-decreasing (for the usual order on [0,1]) and $x = \chi \circ \tau^{-1}$ with τ^{-1} the rightcontinuous inverse of τ . The main technical difficulty with parametric representations is to prove their existence. [\[Whi02,](#page-44-9) section 12.3.3] indicates a way to construct a parametric representation (with the additional property of being one-to-one from [0, 1] to Γ_x) for any $x \in D([0, 1])$, but a requirement is missing there to guarantee that this construction is well-defined. To explain this more precisely, let us assume the existence of a one-to-one parametric representation (χ, τ) of x and describe its properties:

- At extremal points we have $(\chi(0), \tau(0)) = (x(0), 0)$ and $(\chi(1), \tau(1)) = (x(1), 1)$.
- At $u \in (0, 1)$, if we have $\tau(u) \notin \text{Disc}(x) = \{t \in [0, 1] \text{ such that } x(t-) \neq x(t)\}$ then we must have $\chi(u) = x(\tau(u))$, hence as (χ, τ) is one-to-one we see that τ must be strictly increasing at u: for all sufficiently small $\varepsilon > 0$, $\tau(u - \varepsilon) < \tau(u) < \tau(u + \varepsilon)$.
- Conversely, for all $s \in Disc(x)$ there is a segment $[a_s, b_s] \subset [0,1]$ with $a_s < b_s$ such that $\tau(u) = s$ if and only if $u \in [a_s, b_s]$, and χ induces a continuous one-to-one function $[a_s, b_s] \to$ $\{\lambda x(s-) + (1-\lambda)x(s), \text{ for } \lambda \in [0,1]\}\$ with $\chi(a_s) = x(s-)$ and $\chi(b_s) = x(s)$.

The construction proposed by [\[Whi02,](#page-44-9) section 12.3.3] is based on a collection of disjoint segments $[a_s, b_s]$ for $s \in Disc(x)$ that preserves order i.e. for $s < s' \in Disc(x)$, $b_s < a_{s'}$. From this, one would define a parametric representation on each of these intervals and in between so that it matches with the above description. However, one needs an additional property to ensure that this construction is well-defined and one-to-one at accumulation points of discontinuities: we must also require that for $s < s' \in Disc(x)$, there exists an open interval $I \subset (s, s')$ with $I \cap Disc(x) = \emptyset$ if and only if there exists an open interval $J \subset (b_s, a_{s'})$ with $J \cap [a_t, b_t] = \emptyset$ for all $t \in \text{Disc}(x)$. To avoid a detailed discussion about this requirement, we provide an alternative proof of existence in the next Lemma [3.4.](#page-11-0) We also prove that all parametric representations of x are the same up to changes of time (which may not be one-to-one).

Lemma 3.4. Let $\mathcal{P}(x)$ be the set of all parametric representations of $x \in D([0,1])$. There exists $(\chi, \tau) \in \mathscr{P}(x)$ that is one-to-one, and for all such one-to-one $(\chi, \tau) \in \mathscr{P}(x)$ we have

$$
\mathscr{P}(x) = \{ (\chi \circ \phi, \tau \circ \phi), \text{ for } \phi : [0,1] \mapsto [0,1] \text{ non-decreasing and onto} \}.
$$

Proof. Let us define a one-to-one parametric representation of x based on the above description. A trick is to consider a probability measure on [0,1] of the form $\text{Leb}/2 + \sum_{s \in \text{Disc}(x)} m_s \delta_s$ (we just have to choose a family of strictly positive reals $(m_s)_{s \in \text{Disc}(x)}$ with sum 1/2). Its cumulative distribution function F is strictly increasing, with $F(0) = 0, F(1) = 1$ and $Disc(F) = Disc(x)$. Now we define $\tau : [0, 1] \to [0, 1]$ as its right-continuous inverse, which is non-decreasing but also continuous (because F is strictly increasing) hence it is onto. For all $s \in Disc(x)$ there is a segment $[a_s, b_s] \subset [0, 1]$ with $a_s = F(s-) \lt b_s = F(s)$ such that $\tau(u) = s$ if and only if $u \in [a_s, b_s]$, while for all $t \in [0,1] \backslash \text{Disc}(x)$ we have $\tau(u) = t$ if and only if $u = F(t)$. Next, we define χ by setting $\chi(u) = \frac{b_s - u}{b_s - a_s} x(s) + \frac{u - a_s}{b_s - a_s} x(s)$ if $u \in [a_s, b_s]$ for some $s \in \text{Disc}(x)$ and $\chi(u) = x(\tau(u))$ otherwise. By construction, (χ, τ) is a strictly increasing map from [0, 1] onto Γ_x . In addition, χ is continuous on any a_s, b_s by definition, but also at a_s and b_s and at any u such that $\tau(u) \notin \text{Disc}(x)$ thanks to the regularity of x. As a consequence, (χ, τ) is a one-to-one parametric representation of x.

We now prove the second assertion. Consider $(\chi, \tau) \in \mathscr{P}(x)$ which is one-to-one, then for any non-decreasing onto (hence continuous) map $\phi : [0,1] \to [0,1]$, it is clear that $(\chi \circ \phi, \tau \circ \phi) \in \mathscr{P}(x)$. Conversely, for any $(\chi', \tau') \in \mathscr{P}(x), \phi = (\chi, \tau)^{-1} \circ (\chi', \tau') : [0, 1] \to [0, 1]$ is onto and non-decreasing, and $(\chi', \tau') = (\chi \circ \phi, \tau \circ \phi).$ \Box

Measured R-tree encoded by a discontinuous contour function. To motivate the use of parametric representations, we first discuss why the ideas that led to the definition of \mathcal{T}_f for a continuous excursion f (in Section [3.1\)](#page-7-2) cannot be directly extended to a càdlàg excursion x .

For a given $x \in D_0([0,1], \mathbb{R}_+)$, it still makes sense to define the pseudo-metric induced by x on [0, 1] as in [\(4\)](#page-8-0) and thus we can still consider the metric space $([0,1]/\sim_x, d_x)$ defined as in Section [3.1.](#page-7-2) However, the canonical projection $\pi_x : [0,1] \mapsto [0,1] / \sim_x$ is continuous if and only if x is continuous, hence there is no guarantee that $([0, 1/\sim_x, d_x)$ is connected and compact. These properties are actually satisfied for some càdlàg excursions but not for all of them, for instance with $x = 1/1/3,2/3$ we simply get a discrete space consisting of two points. This means that $([0,1]/\sim_x, d_x)$ is not necessarily an R-tree, and we will call it the quotient space associated with x. In some cases this quotient space is actually an R-tree, but proving it requires some additional work.

Parametric representations provide a simpler and more general way to define the R-tree encoded by a càdlàg excursion: for any parametric representations (χ_1, τ_1) and (χ_2, τ_2) of $x \in D_0([0, 1], \mathbb{R}_+),$ according to Lemma [3.4](#page-11-0) and the remark after Definition [3.1](#page-8-1) we have that \mathscr{T}_{χ_1} is isometric to \mathscr{T}_{χ_2} , hence we may define \mathscr{T}_x as this R-tree (seen up to isometry) and this definition is consistent with the case of a continuous function.

Definition 3.5. For all $x \in D_0([0,1], \mathbb{R}_+)$, the R-tree associated with x is (the isometry class of) $\mathscr{T}_{\mathcal{Y}}$, where χ is the spatial component of any parametric representation (χ, τ) of x.

Before endowing this tree with a measure, we compare this construction with the quotient space defined above. It appears that the quotient space $([0, 1/\sim_x, d_x)$ can always be seen as a subspace of the R-tree \mathscr{T}_x . Indeed, consider a parametric representation (χ, τ) of x, then we have

$$
\forall s, t \in [0,1] \ d_{\chi}(\tau^{-1}(s), \tau^{-1}(t)) = d_x(s,t).
$$

As a consequence τ^{-1} induces an isometric map $\tau^*: ([0,1]/\sim_x, d_x) \mapsto (\mathscr{T}_{\chi}, d_{\chi})$ which may or may not be onto but satisfies $\tau^* \circ \pi_x = \pi_\chi \circ \tau^{-1}$. Since \mathscr{T}_x is defined as the isometry class of $(\mathscr{T}_\chi, d_\chi)$, up to some identifications we may write that $([0,1]/\sim_x,d_x) \subset \mathscr{T}_x$, with equality if and only if τ^* is onto. Thanks to this, the canonical projection π_x on the quotient space may always be considered as taking value in the larger space \mathscr{T}_x . There are several sufficient conditions that ensure equality, for instance we have equality when $([x(s-) \wedge x(s), x(s-) \vee x(s)])_{s \in \text{Disc}(x)}$ are pairwise disjoint segments, but in this paper we will only make use of the following criterion:

Lemma 3.6. If $x \in D_0([0,1], \mathbb{R}_+)$ does not have any negative jump, then $([0,1]/\sim_x, d_x)$ is (a representative of the isometry class of) the R-tree \mathscr{T}_x .

Proof. Consider any parametric representation (χ, τ) of x. We prove that for all $u \in [0, 1]$ there is $s \in [0,1]$ such that $\pi_\chi(u) = \pi_\chi(\tau^{-1}(s))$. As π_χ is onto and $\tau^* \circ \pi_x = \pi_\chi \circ \tau^{-1}$, it implies that τ^* is onto and the desired result follows.

For all $u \in [0,1]$ either $\tau(u) \notin \text{Disc}(x)$ in which case $\pi_\chi(u) = \pi_\chi(\tau^{-1}(\tau(u))),$ or $\tau(u) \in \text{Disc}(x)$. In this latter case consider $s = \inf\{t > \tau(u) : x(t) < \chi(u)\}\)$, with $\inf \emptyset = 1$. If $s > \tau(u)$ then $x(s-) \ge \chi(u)$ and $x(s) \le \chi(u)$ so by positivity of the jumps $x(s-) = x(s) = \chi(u)$ and $\pi_{\chi}(u) =$ $\pi_\chi(\tau^{-1}(s))$, else if $s = \tau(u)$ we have that $u \leq \tau^{-1}(s)$ and by positivity of the jumps χ is nondecreasing on $[u, \tau^{-1}(s)]$ but at the same time $\chi(\tau^{-1}(s)) = x(s) \leq \chi(u)$ so $\pi_{\chi}(u) = \pi_{\chi}(\tau^{-1}(s))$ again. \Box

Let us now add a measure μ_x on the R-tree \mathscr{T}_x . As for \mathscr{T}_x , the idea is to use a parametric representation to define a measured R-tree which does not depend on our choice of parametric representation. We fix $x \in D_0([0,1], \mathbb{R}_+)$ and $(\chi, \tau), (\chi', \tau') \in \mathscr{P}(x)$. We do not have in general that $(\mathscr{T}_{\chi}, \mu_{\chi})$ is isometric to $(\mathscr{T}_{\chi'}, \mu_{\chi'})$, so instead of μ_{χ} we consider the measure $\mu_{(\chi,\tau)}$ on \mathscr{T}_{χ} defined as the distribution of $\pi_{\chi}(\tau^{-1}(U))$ where U is uniform over [0, 1]. Now we have that $(\mathscr{T}_{\chi}, \mu_{(\chi,\tau)})$ is isometric to $(\mathcal{T}_{\chi'}, \mu_{(\chi', \tau')})$. Indeed we may assume that (χ, τ) is a one-to-one parametric represen-tation of x, so by Lemma [3.4](#page-11-0) there exists a non-decreasing onto map $\phi : [0, 1] \mapsto [0, 1]$ such that $(\chi', \tau') = (\chi, \tau) \circ \phi$ and we claim that the induced isometry $\tilde{\phi} : \mathscr{T}_{\chi} \to \mathscr{T}_{\chi}$ is actually an isometry between $(\mathscr{T}_{\chi'}, \mu_{(\chi', \tau')})$ and $(\mathscr{T}_{\chi}, \mu_{(\chi, \tau)})$: by construction $\tilde{\phi} \circ \pi_{\chi'} = \pi_{\chi} \circ \phi$ and $\phi \circ (\tau')^{-1} = \tau^{-1}$, so we have $\tilde{\phi} \circ \pi_{\chi'} \circ (\tau')^{-1} = \pi_{\chi} \circ \tau^{-1}$ and the push-forward of $\mu_{(\chi', \tau')}$ by $\tilde{\phi}$ is $\mu_{(\chi, \tau)}$. This leads to the following definition:

Definition 3.7. For all $x \in D_0([0,1], \mathbb{R}_+)$, the measured \mathbb{R} -tree (\mathscr{T}_x, μ_x) associated with x is the isometry class of $(\mathcal{T}_\chi, \mu_{(\chi,\tau)})$, where (χ,τ) is any parametric representation of x and $\mu_{(\chi,\tau)}$ is the law of $\pi_{\chi}(\tau^{-1}(U))$ with U uniform over [0, 1].

Remark. As every continuous function f can be represented by $(f,Id_{[0,1]})$, this definition agrees with the previous construction of (\mathcal{T}_f, μ_f) where μ_f is the law of $\pi_f(U)$ (with U uniform over [0, 1]). Moreover, for all $x \in D_0([0,1], \mathbb{R}_+)$ we can also use the quotient space $([0,1]/\sim_x, d_x)$ and its identification as a subspace of \mathscr{T}_x to understand the measure μ_x as the law of $\pi_x(U)$. Indeed recall that for every parametric representation (χ, τ) of x we have that τ^{-1} induces an isometric map $\tau^*: ([0,1]/\sim_x, d_x) \mapsto (\mathscr{T}_\chi, d_\chi)$ which may or may not be onto but satisfies $\tau^* \circ \pi_x = \pi_\chi \circ \tau^{-1}$. Up to the identifications τ^* = inclusion and $(\mathscr{T}_{\chi}, \mu_{(\chi,\tau)}) = (\mathscr{T}_{x}, \mu_{x})$, we thus have that μ_x is the law of $\pi_x(U)$ where U is uniform over [0, 1]. As a consequence of this and the right-continuity of π_x , we also get that

$$
supp(\mu_x) = \overline{\left([0,1]/\sim_x, d_x\right)}^{\mathscr{T}_x}.
$$
\n
$$
(6)
$$

We end this part with a simple example of a measured R-tree encoded by a càdlàg excursion illustrating the previous definitions. Interestingly, the measured R-tree in this example has a measure supported on a strict closed subset of the tree and thus cannot be encoded by a continuous excursion.

Consider T a finite plane tree and c'_T its *discontinuous* time-scaled contour function, given by

$$
\forall t \in [0,1], \ c_T'(t) = C_T(\lfloor 2(\#T-1)t \rfloor).
$$

It appears that c'_T and the time-scaled contour function c_T have some parametric representations with the same spatial component (we detail this in Section [5.1,](#page-20-1) see Figures [11](#page-21-1) and [12\)](#page-22-0), hence $\mathscr{T}_{c_T} = \mathscr{T}_{c_T}$ *i.e.* it is the R-tree obtained from T by considering edges as segments with unit length and vertices as the endpoints of these segments. But the subspace $([0,1] / \sim_{c'_T}, d_{c'_T})$ corresponds to the set of these endpoints, which means that it really is isometric to T with the graph distance and that $\mu_{c'_T}$ can be seen as a measure on T. Since for each vertex in T the contour process comes back to this vertex a number of times proportional to its number of incident edges, it appears that $\mu_{c'_T}$ is not uniform over T but is the degree-biased distribution over T (with the full degree, not the out-degree used in the definition of plane trees).

Continuity with respect to SKOROKHOD's M_1 topology. Our main interest for the construction based on parametric representations is not its generality (in particular the only discontinuous contour functions we will use in this paper are α -stable excursions with no negative jump hence according to Lemma 3.6 the corresponding R-trees may be defined as quotient spaces), it is its compatibility with SKOROKHOD's M_1 topology, as it really broadens the ways to get convergence of trees through convergence of contour functions.

To understand this compatibility, one simply has to keep in mind a simple definition of Sko-ROKHOD's M_1 topology. This topology on $D([0,1])$ is generated by the distance d_{M_1} defined as follows: for any $x_1, x_2 \in D([0, 1]),$

$$
d_{M_1}(x_1,x_2) = \inf_{(\chi_i,\tau_i) \in \mathcal{P}(x_i)} ||\chi_1 - \chi_2||_{\infty} \vee ||\tau_1 - \tau_2||_{\infty}.
$$

The underlying idea is to control the convergence of *completed* graphs in a *functional* sense (see [\[Whi02,](#page-44-9) section 3.3, section 11.5.2, section 12.3] for more details on this distance).

From this simple definition and the properties of R-trees exposed above, we immediately deduce Proposition [1.1](#page-1-2) which gives the continuity of $x \in D_0([0,1], \mathbb{R}_+) \mapsto \mathscr{T}_x$ for d_{M_1} and d_{GH} .

Proof of Proposition [1.1.](#page-1-2) By Definition [3.5](#page-12-0) and Lemma [3.2](#page-9-1) we have that

$$
d_{\mathrm{GH}}(\mathscr{T}_x, \mathscr{T}_y) \le 2 \inf_{(\chi_i, \tau_i) \in \mathscr{P}(x_i)} ||\chi_1 - \chi_2||_{\infty} \le 2d_{M_1}(x, y).
$$

In the broader setting of measured R-trees, it seems that the LIPSCHITZ property does not hold anymore but, as stated in Proposition [1.2,](#page-1-0) we still have the continuity of $x \mapsto (\mathscr{T}_x, \mu_x)$. Our proof relies on the definitions of d_{GHP} (Equation [\(3\)](#page-8-2)) and of (\mathscr{T}_x, μ_x) (Definition [3.7\)](#page-12-1) and also requires a slightly different characterization of the convergence with respect to d_{M_1} : according to [\[Whi02,](#page-44-9) Theorem 12.5.1], a sequence $(x_n)_n$ converges to x with respect to d_{M_1} if and only if for all $(\chi, \tau) \in \mathscr{P}(x)$ we have $(\chi_n, \tau_n) \in \mathscr{P}(x_n)$ such that $(\chi_n, \tau_n) \to (\chi, \tau)$ with respect to $\lVert \cdot \rVert_{\infty}$ as $n \to +\infty$.

Proof of Proposition [1.2.](#page-1-0) The continuity is a consequence of the following fact: for any $x_1, x_2 \in$ $D_0([0,1], \mathbb{R}_+)$ and any $(\chi_1, \tau_1) \in \mathscr{P}(x_1), (\chi_2, \tau_2) \in \mathscr{P}(x_2)$ we have

$$
d_{\text{GHP}}\big((\mathscr{T}_{x_1},\mu_{x_1}),(\mathscr{T}_{x_2},\mu_{x_2})\big)\leq \inf_{\delta>0} 2\big(\|\chi_1-\chi_2\|_{\infty}+\omega(\chi_1;\delta)\big)\vee\frac{\|\tau_1-\tau_2\|_{\infty}}{\delta},\tag{7}
$$

where $\omega(f; \delta) = \sup_{|x-y| < \delta} |f(x) - f(y)|$ is the modulus of continuity of a function f. Indeed, consider a sequence $(x_n)_n$ converging to x with respect to d_{M_1} . By [\[Whi02,](#page-44-9) Theorem 12.5.1], we have some parametric representations (χ_n, τ_n) of x_n and (χ, τ) of x such that $(\chi_n, \tau_n) \to (\chi, \tau)$ with respect to $\|\cdot\|_{\infty}$. Set $\delta_n = \sqrt{\|\tau - \tau_n\|_{\infty}}$ and apply [\(7\)](#page-13-0) to get

$$
d_{\text{GHP}}\big((\mathscr{T}_x,\mu_x),(\mathscr{T}_{x_n},\mu_{x_n})\big)\leq 2\big(\|\chi-\chi_n\|_{\infty}+\omega(\chi;\delta_n)\big)\vee \sqrt{\|\tau-\tau_n\|_{\infty}}\underset{n\to+\infty}{\longrightarrow}0.
$$

Thus it only remains to prove [\(7\)](#page-13-0). We fix $\delta > 0$ and define a correspondence between \mathcal{T}_{χ_1} and \mathscr{T}_{χ_2} by setting

$$
C_{\delta} = \{ (\pi_{\chi_1}(u), \pi_{\chi_2}(v)) : u, v \in [0, 1] \text{ such that } |u - v| \le \delta \}.
$$

 $\text{For } (\pi_{\chi_1}(u), \pi_{\chi_2}(v)), (\pi_{\chi_1}(u'), \pi_{\chi_2}(v')) \in C_\delta, \text{ we have } |d_{\chi_1}(v, v') - d_{\chi_2}(v, v')| \leq 4 ||\chi_1 - \chi_2||_{\infty},$ and we also have $d_{\text{haus}}([u, u'], [v, v']) \leq \delta$ which implies $|d_{\chi_1}(u, u') - d_{\chi_1}(v, v')| \leq 4\omega(\chi_1; \delta)$. By summing these two parts we get

$$
\operatorname{dis}(C_{\delta}) \le 4\big(\|\chi_1 - \chi_2\|_{\infty} + \omega(\chi_1; \delta)\big). \tag{8}
$$

Next, let ν be the simple coupling between $\mu_{(\chi_1,\tau_1)}$ and $\mu_{(\chi_2,\tau_2)}$ obtained as the law of the couple $(V_1, V_2) = (\pi_{\chi_1}(\tau_1^{-1}(U)), \pi_{\chi_2}(\tau_2^{-1}(U)))$ where U is uniform over [0, 1]. By construction we have

$$
((V_1, V_2) \notin C_{\delta}) = (U \in B_{\delta})
$$

where B_{δ} is the set of *bad points* $\{t \in [0,1]$ such that $|\tau_1^{-1}(t) - \tau_2^{-1}(t)| > \delta\}$. We now control Leb(B_{δ}) with the area between τ_1 and τ_2 . First observe that by general properties of the inverse of an increasing function, we have

$$
\{(u,t) \text{ such that } \tau_1(u) \le t \le \tau_2(u)\} = \{(u,t) \text{ such that } \tau_2^{-1}(t-) \le u \le \tau_1^{-1}(t)\}.
$$

As the left-continuous and right-continuous inverses are equal except on a countable set, it implies that $\int_0^1 (\tau_1^{-1}(t) - \tau_2^{-1}(t))_+ dt = \int_0^1 (\tau_1(u) - \tau_2(u))_- du$, and this also holds when one exchanges τ_1 and τ_2 . We thus have two ways to compute the area between τ_1 and τ_2 which provide

$$
1 - \nu(C_{\delta}) = \text{Leb}(B_{\delta}) \le \frac{1}{\delta} \int_0^1 |\tau_1^{-1}(t) - \tau_2^{-1}(t)| dt = \frac{1}{\delta} \int_0^1 |\tau_1(u) - \tau_2(u)| du \le \frac{\|\tau_1 - \tau_2\|_{\infty}}{\delta}.
$$

Combining this with [\(8\)](#page-14-0) and [\(3\)](#page-8-2) and the fact that δ has been chosen arbitrarily proves [\(7\)](#page-13-0).

 \Box

Remark. It will be useful later to know some relations between SKOROKHOD's M_1 topology and more standard topologies:

- $x_n \xrightarrow[n \to +\infty]{J_1} x \text{ implies } x_n \xrightarrow[n \to +\infty]{M_1} x ;$
- if $x_n \xrightarrow[n \to +\infty]{M_1} x$ with x continuous then actually $x_n \xrightarrow[n \to +\infty]{\| \cdot \|_{\infty}} x$.

In particular, Propositions [1.1](#page-1-2) and [1.2](#page-1-0) give also the continuity with respect to the usual Sko-ROKHOD's J_1 topology.

3.3 Properties of $\mathscr{T}_{\mathscr{R}}$

We end this section on the encoding of R-trees by studying those encoded by a normalized excursion $x \in D_0([0,1], \mathbb{R}_+)$ of a spectrally positive α-stable Lévy process with $\alpha \in (1,2)$. Let us first describe x. Formally, consider a Lévy process X whose LAPLACE transform is given, for all $t, \lambda > 0$, by $\mathbb{E}(\exp[-\lambda X_t]) = e^{t\lambda^{\alpha}}$, then x is defined as an excursion away from 0 of X conditioned to have a unit length (we can make sense of this conditioning by applying excursion theory or simply by the scaling property of X, see e.g. [\[Cha94\]](#page-43-10)). This definition leads to the following path-properties holding almost surely for x:

- 1. The set of discontinuities $Disc(x)$ is countable and dense in $(0, 1)$;
- 2. The jumps of x are positive, *i.e.* $\forall s \in [0,1]$ $\mathbf{x}(s) \geq \mathbf{x}(s-)$;
- 3. For all $s \in Disc(\mathbf{x})$, for all ε small enough we have $\inf_{[s-\varepsilon,s]} \mathbf{x} < \mathbf{x}(s-)$ and $\inf_{[s,s+\varepsilon]} \mathbf{x} < \mathbf{x}(s)$.
- 4. For all $0 < s < t < 1$, there is at most one $r \in (s,t)$ such that $\mathbf{x}(r) = \inf_{[s,t]} \mathbf{x}$;
- 5. For Leb-a.e. $t \in (0,1)$, there is no one-sided local minimum for x at t, i.e. for $\varepsilon > 0$ small enough, $\inf_{0 \leq s \leq \varepsilon} x(t-s) < x(t)$ and $\inf_{0 \leq s \leq \varepsilon} x(t+s) < x(t)$;
- 6. For all I non-trivial interval of $[0, 1]$, x is not monotone on I.

Remark. These path-properties follow from the MARKOV property, the form of the Lévy measures associated with spectrally positive α -stable Lévy processes and the duality property of these processes (see [\[Kor14,](#page-44-10) Proposition 2.10] for some proofs).

First properties and interpolation. We prove Proposition [1.4,](#page-3-0) which gives that \mathscr{T}_{x} is a binary continuous random tree, by means of a classical argument linking local minima in a contour function and degrees of the underlying tree. In short, given a continuous contour f and a vertex $v \in \mathscr{T}_f$, the set $\pi_f^{-1}(\{v\})$ splits f into deg(v) – 1 consecutive excursions above height $d_f(\pi_f(0), v)$, plus a remaining part. We refer to [\[LG05,](#page-44-0) p.30] for a detailed discussion of this link.

Proof of Proposition [1.4.](#page-3-0) For the first claim, observe that thanks to properties 3 and 4 of \bar{x} we also have that for all one-to-one parametric representation (χ, τ) of x and for all $0 < s < t < 1$, there is at most one $r \in (s, t)$ such that $\chi(r) = \inf_{[s,t]} \chi$. Based on [\[LG05,](#page-44-0) p.30] which links degree and contour function, we deduce that the degree of any vertex $v \in \mathscr{T}_\chi$ is less than 3, hence \mathscr{T}_χ is binary.

For the properties of μ_x and the set of leaves $\mathcal{L}(\mathscr{T}_x)$, we use the fact that for Leb-a.e. $t \in (0,1)$, $x(t-) = x(t)$ and there is no one-sided local minimum for x at t. It implies that for any one-to-one parametric representation (χ, τ) of x, for Leb-a.e. $t \in (0, 1)$ there is no one-sided local minimum for χ at $\tau^{-1}(t)$, hence $\pi_\chi \circ \tau^{-1}(t)$ is a leaf in \mathscr{T}_χ (again, see [\[LG05,](#page-44-0) p.30]). Since $(\mathscr{T}_{\mathbf{x}}, \mu_{\mathbf{x}})$ is isometric to $(\mathscr{T}_{\chi}, \mu_{(\chi,\tau)})$, we directly get $\mu_{\chi}(\mathcal{L}(\mathscr{T}_{\chi})) = 1$. Moreover, by Lemma [3.6](#page-12-2) and [\(6\)](#page-12-3) we get supp $(\mu_{\mathbf{x}}) = \mathscr{T}_{\mathbf{x}}$ and $\mathcal{L}(\mathscr{T}_{\mathbf{x}})$ must be dense. Finally, we assume that $\mu_{\mathbf{x}}$ has an atom a to get a contradiction. The atom a must be a leaf and it means that either $\pi_{\mathbf{x}}^{-1}(\{a\}) = \mathbf{x}^{-1}(\{0\})$ or $\pi_{\mathbf{x}}^{-1}(\{a\}) = [s, t]$ with x constant on this segment. But x vanishes only at 0 and 1 and cannot be monotone on a non-trivial interval, hence almost surely $\pi_*^{-1}(\{a\})$ is reduced to a singleton or $\{0, 1\}$, which contradicts Leb $(\pi_{\mathbf{x}}^{-1}(\{a\})) = \mu_{\mathbf{x}}(\{a\}) > 0$. \Box

The continuity of the encoding by a contour function also enables to transfer some properties of contour functions to their encoded trees. We use this to prove Proposition [1.6,](#page-4-1) which states that $\alpha \mapsto (\mathscr{T}_{\mathbf{x}(\alpha)}, \mu_{\mathbf{x}(\alpha)})$ interpolates between the unit segment (endowed with Leb) and the Brownian CRT. Note that it is based on a similar result about looptrees ([\[CK14,](#page-43-2) Theorem 1.2]) but here the continuity given by Proposition [1.2](#page-1-0) enables a simpler proof.

Proof of Proposition [1.6.](#page-4-1) Thanks to the continuity of $x \mapsto (\mathscr{T}_x, \mu_x)$ established in Proposition [1.2,](#page-1-0) this is a direct consequence of the following facts:

- $(\mathbf{x}^{(\alpha)})_{1 \leq \alpha \leq 2}$ converges in distribution toward $\mathbf{x}^{(2)} = \sqrt{\mathbf{x}^{(2)}}$ 2e when $\alpha \to 2$ (see [\[CK14,](#page-43-2) Proposition 3.5]);
- $(\mathbf{x}^{(\alpha)})_{1 \leq \alpha \leq 2}$ converges in distribution toward $t \mapsto (1-t)1_{0 \leq t \leq 1}$ when $\alpha \to 1$, or more accurately their time-reversed versions converge toward the càdlàg function $t \mapsto t1_{0 \leq t \leq 1}$ (see [\[CK14,](#page-43-2) Proposition 3.6]). According to Definition [3.7,](#page-12-1) the corresponding R-tree is $(([0, 1], | \cdot |), \text{Leb}).$ \Box

Stable looptrees and HAUSDORFF dimension. As mentioned in the introduction, another important property of \mathscr{T}_{x} is that it may be seen as a *spanning* R-tree of the stable looptree \mathscr{L}_{x} . The intuition motivating this formulation comes in part from the relation between a rotated plane tree Rot T and the looptree Loop(T) corresponding to T, which will be explored at the end of Section [4.](#page-16-0) Nevertheless, we try to motivate the idea of spanning R-tree to interpret Proposition [1.5](#page-3-1) before proving this proposition in the rest of this section. Recall that $\mathscr{L}_{\mathbf{x}}$ is a random compact metric space introduced in [\[CK14\]](#page-43-2) as the distributional scaling limit of $Loop(\mathcal{T}_n)$. This space consists of $continuous\ loops, i.e. \ subspaces isometric\ to\ circles, glued\ together\ by\ some\ additional\ limit\ points,$ but to simplify, we first give examples of R-trees that could be seen as spanning R-trees of some simpler metric spaces made of loops:

- The unit segment is a spanning R-tree of the unit circle;
- Consider T a finite plane tree, and let \mathscr{T} (resp. \mathscr{L}) be the metric space obtained from Rot T (resp. $Loop(T)$) when edges are seen as unit-length segments. Based on the forthcoming Lemma [4.1](#page-19-0) and Figure [10,](#page-20-2) we will argue in Section [4](#page-16-0) that $\mathscr T$ is a spanning R-tree of $\mathscr L$.

In both examples, a formal statement is that we have a mapping p from an R-tree $\mathscr T$ to a metric space L which is onto and LIPSCHITZ, and there is a subset \mathscr{T}^* of \mathscr{T} such that $\mathscr{T} \setminus \mathcal{L}(\mathscr{T}) \subset \mathscr{T}^*$ and p restricted to \mathscr{T}^* is one-to-one. Proposition [1.5](#page-3-1) gives the same statement for the R-tree $\mathscr{T}_{\mathbf{x}}$ and the metric space $\mathscr{L}_{\mathbf{x}}$, with the additional result that they have the same HAUSDORFF dimension. To prove this proposition, we use the construction of $\mathscr{L}_{\mathbf{x}}$ as a quotient space (see [\[CK14,](#page-43-2) Section 2]) obtained by considering another pseudo-distance on [0, 1] denoted here by $d_{\rm x}^{\rm loop}$ (defined by [\[CK14,](#page-43-2) Equation 2.5]), and we rely on the existing proof of the fact that dim_H (\mathscr{L}_x) = α

(see $[CK14, Section 3.3]$ $[CK14, Section 3.3]$). Consequently we will refer to $[CK14]$ for more details on some definitions and arguments.

Proof of Proposition [1.5.](#page-3-1) We first prove the existence and properties of the map p. Note that by Lemma [3.6,](#page-12-2) $\mathscr{T}_{\mathbf{x}} = ([0,1]/\sim_{\mathbf{x}}, d_{\mathbf{x}})$ as isometry classes, thus we may and will work with the quotient space $([0,1]/\sim_{\mathbb{X}},d_{\mathbb{X}})$ instead of the isometry class $\mathscr{T}_{\mathbb{X}}$.

An immediate consequence of [\[CK14,](#page-43-2) Lemma 2.1] is that $d_{\rm x}^{\rm loop} \leq d_{\rm x}$, thus the canonical projection $\pi_{\mathbf{x}}^{\text{loop}} : [0,1] \mapsto \mathscr{L}_{\mathbf{x}}$ (defined after [\[CK14,](#page-43-2) Definition 2.3]) is such that for $s, t \in [0,1]$

$$
d_{\mathrm{x}}^{\mathrm{loop}}\big(\pi_{\mathrm{x}}^{\mathrm{loop}}(s),\pi_{\mathrm{x}}^{\mathrm{loop}}(t)\big) \leq d_{\mathrm{x}}(s,t).
$$

Thanks to this, $\pi_{\mathbf{x}}^{\text{loop}}$ induces a map p from the quotient space $([0,1]/\sim_{\mathbf{x}},d_{\mathbf{x}})$ onto $\mathscr{L}_{\mathbf{x}}$ such that $p \circ \pi_{\mathbf{x}}^{\text{tree}} = \pi_{\mathbf{x}}^{\text{loop}}$, and moreover p is 1-LIPSCHITZ. Now we prove that in addition, for all $u \in {\pi_{\mathbf{x}}^{\text{tree}}(s)}$, for $s \in \text{Disc}(\mathbf{x})$ we have $v \notin {\pi_{\mathbf{x}}^{\text{tree}}(s)}$, for $s \in \text{Disc}(\mathbf{x})$ such that $p(u) = p(v)$. For $t \in [0,1]$, we set $e(t) = \inf\{t' \ge t : x(t') < x(t-)\}\$. By the path-properties of x we always have that $e(t) \notin \text{Disc}(\mathbf{x})$ and $d_{\mathbf{x}}^{\text{loop}}(t, e(t)) = 0$. Moreover, for $t \in \text{Disc}(\mathbf{x})$ such that $u = \pi_{\mathbf{x}}^{\text{tree}}(t)$ we must have that u is a leaf while $e(t) > t$ hence $e(t)$ is a one-sided local minimum and $v =$ $\pi_x^{\text{tree}}(e(t))$ is not a leaf. This prevents v from being in $\{\pi_x^{\text{tree}}(s), \text{ for } s \in \text{Disc}(x)\}\)$, and v is such that $p(v) = \pi_{\mathbf{x}}^{\text{loop}}(e(t)) = \pi_{\mathbf{x}}^{\text{loop}}(t) = p(u)$. We finally prove that p is one-to-one once it is restricted to the complementary of $\{\pi_x^{\text{tree}}(s), \text{ for } s \in \text{Disc}(x)\}\$. We first combine the path-properties of x and [\[CK14,](#page-43-2) Equations 2.4, 2.5] to get that for $s < t \in [0, 1]$,

if
$$
d_{\mathbf{x}}^{\text{loop}}(s,t) = 0
$$
, then $t = e(s)$ and $d_{\mathbf{x}}(s,t) = \mathbf{x}(s) - \mathbf{x}(s-)$.

For $u \neq v \in [0,1] / \sim_x$, consider $s, t \in [0,1]$ such that $u = \pi_x^{\text{tree}}(s)$ and $v = \pi_x^{\text{tree}}(t)$, then $p(u) = p(v)$ means that $d_{\mathbf{x}}^{\text{loop}}(s,t) = 0$ and $d_{\mathbf{x}}^{\text{tree}}(s,t) > 0$. According to the previous display it implies that one of s, t belongs to $Disc(x)$, thus one of u, v belongs to $\{\pi_x^{\text{tree}}(s), \text{ for } s \in Disc(x)\}.$

We now turn to the HAUSDORFF dimension. Since $p : \mathscr{T}_x \to \mathscr{L}_x$ is 1-LIPSCHITZ and onto, we have

$$
\dim_H(\mathscr{L}_\mathbf{x}) \leq \dim_H(\mathscr{T}_\mathbf{x}).
$$

By [\[CK14,](#page-43-2) Theorem 1.1], $\dim_H (\mathcal{L}_x) = \alpha$ so it only remains to upper-bound $\dim_H (\mathcal{I}_x)$ by α to get the desired conclusion. This upper-bound can be proved with the very same argument used for the upper-bound dim_H (\mathscr{L}_x) $\leq \alpha$ in [\[CK14,](#page-43-2) Section 3.3.1]: one may consider the same partition of $[0, 1]$ to build a partition of $\mathscr{T}_{\mathbf{x}}$, and we have the same upper-bound on the diameter of those parts as [\[CK14,](#page-43-2) Equation 3.26]. Consequently we get the same conclusion, namely dim_H ($\mathscr{T}_{\mathbf{x}}$) $\leq \alpha$. \square

4 The rotation correspondence

The rest of this paper, including this section, is now devoted to the study of the rotation Rot, which has been defined in the introduction. In this section, we first give an alternative description of Rot T for a plane tree T . We also define some transformations related to the rotation, the co-rotation and the looptree transformation. They are not used to prove Theorem [1.3,](#page-2-1) but they will give further insight on the large-scale effects of the rotation studied in the following sections.

A geometric description. In Section [1,](#page-0-0) we gave a recursive definition of the rotation correspondence Rot illustrated by Figure [1.](#page-1-1) As mentioned earlier, it is clear that it defines a bijection between plane trees with n vertices and binary plane trees with n leaves (hence $2n-1$ vertices), for all $n \in \mathbb{N}$. However, this recursive definition will only be useful when it comes to induction. An important property that can be obtained this way is that for any plane tree T , we always have

$$
S_{\text{Rot }T} = C_T \oplus (-1) ,
$$

where \oplus is concatenation, *i.e.* the ŁUKASIEWICZ walk of Rot T is the contour process of T plus a final step down (MARCKERT also refers to FLAJOLET, SEDGEWICK ([\[FS96,](#page-43-11) exercise 5.42 p.262]) about this fact). For almost everything else, we will rather work with another definition provided by MARCKERT which involves a true rotation (in the geometric sense). Consider a plane tree T embedded in the upper-half plane with the edges parent $-$ first child being vertical and siblings being on the same horizontal lines. To draw Rot T , one only needs 3 steps (illustrated by Figure [6\)](#page-17-0):

step 1: Remove the root and all edges of T , except the vertical edges parent – first child. Then for each vertex which initially had a younger sibling, add a horizontal edge between this vertex and its first sibling on its right (*i.e.* the oldest among its younger siblings).

step 2: Make a rotation of $\pi/4$, so that the first child of the initial root clearly appears as the new root and each edge, when directed to go away from the new root, goes upward. Note that the former parent – first child edges go upward-left (we call them left edges) while the added edges go upward-right (we call them right edges).

step 3: Add 1 or 2 leaves to each vertex in order to get a binary tree (if there is no vertex, just add one in order to get the binary tree $\{\varnothing\}$. When we add only 1 leaf at a vertex, its position (first or second child) is determined by the following rule: each left edge must correspond to a first (*i.e.* left) child and each *right edge* must correspond to a second (*i.e.* right) child.

This transformation is indeed the same as the rotation described above since it satisfies the same induction.

Figure 6: A visual way to construct Rot T from T. The root of T is marked as the black vertex while the added leaves are crossed.

The internal subtree. The geometric description illustrated by Figure [6](#page-17-0) enables the definition of a closely related tree that will be crucial to link Rot T and T: Starting from $T \neq \{ \emptyset \}$, apply step 1 and step 2 and then stop. The resulting plane tree may and will be identified to the subtree of the internal vertices of Rot T. We denote it by $(\text{Rot } T)$ °. Note that we will use both its plane tree structure and its subtree structure (in the graph-theoretic sense) of Rot T without further explicit mention. For instance, a lexicographical enumeration of $(Rot T)°$ will also be seen as a lexicographical enumeration of the internal vertices of $Rot T$ (observe that this enumeration is also increasing for the lexicographical order of $Rot T$, so there is no ambiguity).

The subtree $(Rot T)$ [°] is useful to handle the rotation since the geometric description illustrated by Figure [6](#page-17-0) enables a clear identification between vertices of $T \setminus \{\emptyset\}$ and vertices of $(\text{Rot } T)^\circ$ (as the former ones become the latter ones in this construction). For $u \in T \setminus \{ \varnothing \}$, we denote by $\widetilde{u} \in (\text{Rot } T)^{\circ}$ the associated internal vertex of Rot T and call it the *rotated version of u*. A simple
but gruess observation about this identification is that we can express the height of a rotated but crucial observation about this identification is that we can express the height of a rotated vertex:

$$
\forall u \in T \setminus \{ \varnothing \}, \ |\widetilde{u}| = |u| - 1 + L(u), \tag{9}
$$

where $L(u)$ is the number of vertices grafted on $[\![\varnothing, u[\!]$ on its left side, as defined in Section [2.](#page-5-0) Indeed, one can see in Figure [6](#page-17-0) that the height of \tilde{u} is the number of edges in the path from \varnothing to this vertex after step 1. Vertical edges amount to the height of u , minus 1 as we have deleted the root, and horizontal edges amount to $L(u)$, hence we have [\(9\)](#page-17-1).

A last important remark about the identification between vertices of $T \setminus \{\varnothing\}$ and vertices of $(\text{Rot } T)^\circ$ is that it preserves the lexicographical order: $u \prec u'$ in $T \setminus \{\varnothing\}$ implies $\widetilde{u} \prec \widetilde{u}'$ in $(\text{Rot } T)^\circ$ (see [\[Mar04,](#page-44-3) Lemma 1]). Hence this identification boils down to:

 $\widetilde{u}_1, \ldots, \widetilde{u}_{\#T-1}$ is the lexicographical enumeration of $(\text{Rot } T)^\circ$, *i.e.* for every $i \in [\![1, \#T-1]\!]$, \widetilde{u}_i is the *i*th internal vertex of Bot T in lexicographical order the *i*th internal vertex of $Rot T$ in lexicographical order.

Note that extracting the internal subtree of a plane tree is not a one-to-one function. Thus, despite the previous handy identification, working with $(Rot T)°$ only as a plane tree means losing information. One can see at step 3 that the missing pieces of information given by the leaves are the following: a left leaf in Rot T means that its parent (an internal vertex) corresponds to a leaf in T , while a right leaf means that its parent corresponds to a vertex in T which is the last child of its own parent.

A symmetric counterpart: the co-rotation. We now briefly introduce another closely related transformation, but this one is not needed to understand and prove Theorem [1.3.](#page-2-1) The reason to mention this transformation is rather to stress that the rotation is not a canonical correspondence between plane trees and binary trees since the ideas underlying the definitions of Rot are the same, up to some symmetries, as the ones underlying this new transformation called here the co-rotation and denoted by Tor. As this description suggests, these two transformations share many properties and thus most results about the rotation can be transferred to the co-rotation. However when it comes to the lexicographical order, using the rotation is not equivalent to using the co-rotation as the rotation is the only one to preserve this order (in the sense explained above). Because of this, the encoding processes of Tor T for T a large BIENAYMÉ tree have an interesting property that does not hold in the case of the rotation: they jointly converge toward the same process (see Theorem [5.10\)](#page-29-0).

Let us properly define the co-rotation. As for the rotation, we have a recursive definition:

Base case: $\text{Tor}\{\emptyset\} = \{\emptyset\}.$

Inductive step: Consider a plane tree T with $n \geq 2$ vertices. Denote by T_1, \ldots, T_k the $k \geq 1$ subtree(s) grafted on the root. Then Tor T consists of a spine of $k + 1$ vertices with Tor T_k grafted on the right of the 1st one, ..., Tor T_1 grafted on the right of the kth one (see Figure [7\)](#page-18-0).

There is also a geometric description similar to the one illustrated by Figure [6](#page-17-0) in the case of the rotation, but one must keep the edges parent – last child instead of parent – first child at step 1 and then apply a rotation of $-\pi/4$ instead of $\pi/4$ at step 2. We can thus define the internal subtree $(Tor T)^\circ$ in the same way we defined $(Rot T)^\circ$, and again there is an identification between vertices of $T\setminus\{\emptyset\}$ and vertices of $(Tor T)^{\circ}$. However this identification with $(Tor T)^{\circ}$ does not preserve the lexicographical order.

Tor lacks another property of Rot: there is no simple relation between $S_{\text{Tor}T}$ and C_T . Actually, we can express $S_{\text{Tor}T}$ from S_T without much difficulty (we will give some details in Section [6.4\)](#page-38-0) but this relation is less direct than the one between S_{Rot} and C_T .

We conclude this part with an explicit and simple relation between Rot and Tor. First, for every plane tree T we introduce its mirror tree T^{\div} . It is obtained by embedding T in the upper-half plane, rooted at the origin, and by taking its image by $(x, y) \mapsto (-x, y)$ *i.e.* the reflection symmetry with respect to the vertical line (see Figure [8\)](#page-19-1). Equivalently, T^{\div} can be defined by considering T and, for each vertex with some children, by reversing the birth order of its children. The mirror transformation $T \mapsto T^{\div}$ clearly is an involution, and for every plane tree T we have

$$
Tor T = \left(\text{Rot}(T^{\div})\right)^{\div}.
$$
\n(10)

Spanning trees of looptrees. The two correspondences Rot and Tor are also related to the looptree transformation: they produce spanning trees of looptrees. The looptree transformation has been introduced in $[CK14]$ in order to understand the associated limiting objects called *stable* looptrees, and we have explained in Section [3.3](#page-14-1) that the scaling limits of rotated Bienaymé trees may also be seen as spanning trees of stable looptrees. We have chosen to present clearly this relation between discrete rotated trees and discrete looptrees, but we will not use it formally, it

will only serve as inspiration to understand the link between scaling limits of rotated trees and looptrees.

We first define the looptree $\text{Loop}(T)$ associated to a plane tree T: $\text{Loop}(T)$ is the medial graph of T , *i.e.* the graph obtained by gluing cycles according to the tree structure of T . More precisely, for each edge in T there is a vertex in $\text{Loop}(T)$, and for each couple of edges (e, e') in T incident to a common vertex $v \in T$ such that e' directly comes after e in clockwise order around v, there is an edge in $\text{Loop}(T)$ between the vertices corresponding to e and e' (see Figure [9\)](#page-19-2). In the following, such a couple of edges (e, e') is called a *corner* of T, so we simply say that an edge in $\text{Loop}(T)$ corresponds to a corner in T. Moreover, we distinguish the corner of T going from the edge root – last child of the root to the edge root – first child of the root, we call it the root-corner of T and the corresponding edge in $\text{Loop}(T)$ is the root-edge of $\text{Loop}(T)$. We also endow $\text{Loop}(T)$ with the cyclic order on its edges inherited from the cyclic order on the corners of T . This cyclic order on corners is formally defined as follows: (e, e') is the successor of (f, f') if and only if $f' = e$ and f and the vertex of incidence of (f, f') is different from the vertex of incidence of (e, e') . A more visual way to define this order is to say that the enumeration of the corners which starts at the root-corner and follows this cyclic order must correspond to the sequence of vertices defining the contour process of T.

The cyclic order on edges matches the clockwise order.

Note that we can identify the vertices of $T \setminus \{\varnothing\}$ with the edges of T (an edge corresponds to its farthest endpoint from the root) hence we can identify the vertices of $T \setminus \{\emptyset\}$ with those of Loop(T). We may now write the relation between Rot T and Loop(T) as follows:

Lemma 4.1. Consider the sequence $(c_0, \ldots, c_{2\#T-2})$ of edges of Loop(T) which start from the root-edge c_0 of $\text{Loop}(T)$ and then follows the cyclic order until it reaches again the root-edge (so that $c_{2\#T-2} = c_0$). We define three subsets of edges with a recursive algorithm. First set $\mathcal{E} = \mathcal{R} =$ $\mathcal{L} = \emptyset$, then for each k between 1 and $2 \# T - 2$,

- if c_k is a self-loop then add c_k to \mathcal{L} ;
- else, if $\mathcal{E} \cup \{c_k\}$ contains a cycle then add c_k to \mathcal{R} ;
- otherwise add c_k to $\mathcal{E}.$

Then the set of edges $\mathcal E$ forms a spanning tree of $\text{Loop}(T)$. Moreover, $(\text{Rot } T)^\circ$ is equal to this tree once it is rooted at the vertex of incidence of c_0 and c_1 and ordered by the cyclic order of Loop(T) (with the convention that the first child of the root is the endpoint of c_1). Finally, if $T \neq \{\emptyset\}$ then $\mathcal L$ is in bijection with the set of left leaves of Rot T and R is in bijection with the set of right leaves of Rot T.

As one may expect, $(Tor T)^\circ$ can be seen as another spanning tree of $Loop(T)$, constructed with the same algorithm up to some modifications: one must reverse the enumeration of edges of Loop(T) (*i.e.* consider the sequence $c_0, c_{2#T-3}, \ldots, c_1, c_0$), declare that the corresponding tree is rooted at the vertex of incidence of c_0 and $c_{2#T-3}$ and declare that $c_{2#T-3}$ is the *last* edge out of the root. Moreover $\mathcal L$ and $\mathcal R$ exchange their role in the case of the co-rotation. See Figure [10](#page-20-2) for a drawing of these two specific spanning trees of a looptree.

Lemma [4.1](#page-19-0) may be proved either by induction or by means of the geometric definition of Rot illustrated at Figure [6.](#page-17-0) We sketch this latter version. We have seen that there is a correspondence between vertices of $(Rot T)°$ and edges of T, and step 1 in the geometric construction of the rotation reveals that the edges of $(\text{Rot } T)^\circ$ correspond to some corners of T. This make $(\text{Rot } T)^\circ$ a spanning tree of $\text{Loop}(T)$, and then it suffices to check that the missing corners of T are those corners corresponding to the leaves of T (which give self-loops in Loop(T) and left leaves in Rot T) plus those corners linking the last edge of a vertex of T to its parent edge -or first edge in the case of the root- (which give edges ending cycle in $\text{Loop}(T)$ and right leaves in Rot T).

To conclude, Lemma [4.1](#page-19-0) says a bit more than the fact that $(\text{Rot } T)$ ^o is a spanning tree of $Loop(T)$, as it gives that each edge of Rot T corresponds to an edge of $Loop(T)$ and vice versa. Actually, we can construct $\text{Loop}(T)$ simply by considering Rot T and by merging each leaf with an internal vertex. With this observation, we explain the simple example of a spanning R-tree given in Section [3.3.](#page-14-1) Consider \mathscr{T} (resp. \mathscr{L}) the metric space obtained from Rot T (resp. Loop(T)) when edges are seen as unit-length segments, then we can also construct $\mathscr L$ as a quotient from $\mathscr T$ by identifying each leaf (except the root) with a branching point. In particular the canonical projection $p: \mathscr{T} \mapsto \mathscr{L}$ is onto and LIPSCHITZ, with a subset \mathscr{T}^* of \mathscr{T} such that $\mathscr{T} \setminus \mathcal{L}(\mathscr{T}) \subset \mathscr{T}^*$ and p restricted to \mathscr{T}^* is one-to-one.

5 Scaling limits of encoding processes

Thanks to the extension of the encoding of R-trees to càdlàg contour functions, and in particular its continuity property given by Propositions [1.1](#page-1-2) and [1.2,](#page-1-0) we can obtain Theorem [1.3](#page-2-1) by studying the joint scaling limits of some encoding process of \mathcal{T}_n and Rot \mathcal{T}_n in the setting of SKOROKHOD's M_1 topology. This section is devoted to this study, we first detail the framework and give some known results about the encoding processes of \mathcal{T}_n and then combine these results with the properties of Rot given in Section [4](#page-16-0) to determine the desired scaling limits. We also study the co-rotation and show that its encoding processes asymptotically behave in a nicer way than those of the rotation, namely they jointly converge toward the same excursion.

5.1 Details of the framework

Hypothesis on BIENAYMÉ trees. For all adequate $n \in \mathbb{N}^*$, \mathcal{T}_n still denotes a random tree with law BGW_µ(\cdot |#vertices = n), where μ is a fixed critical offspring distribution, and we suppose that μ is attracted to a spectrally positive α -stable distribution, with $\alpha \in (1, 2]$. This means that there exist real sequences $(a_n)_{n\geq 1}$, $(b_n)_{n\geq 1}$ such that if $(Z_n)_{n\geq 1}$ is a sequence of i.i.d. variables with distribution μ then we have

$$
\frac{\sum_{i=1}^{n} Z_i - b_n}{a_n} \xrightarrow[n \to +\infty]{(d)} Z,
$$
\n(11)

where Z is a real variable with finite LAPLACE transform satisfying $\mathbb{E}(\exp[-\lambda Z]) = e^{\lambda^{\alpha}}$, for all $\lambda > 0$. The variable Z is a Gaussian in the case $\alpha = 2$, otherwise it is a spectrally positive α -stable variable. Let us also mention that $(a_n)_{n\geq 1}$ is necessarily of the form $a_n = n^{1/\alpha} \ell(n)$ with ℓ a slowly varying function^{[2](#page-21-2)}. We refer to Jan11 for a review of stable distributions as well as necessary and sufficient conditions on μ that ensure that it is attracted to an α -stable distribution.

Choice of topology. A distribution attracted to a spectrally positive α -stable distribution also satisfies a functional version of [\(11\)](#page-21-3), but the limiting process is a Brownian motion in the case $\alpha = 2$ only, otherwise it is a spectrally positive α -stable Lévy process which is càdlàg but not continuous. For this reason, some encoding processes of \mathcal{T}_n actually have discontinuous scaling limits and we must work in the space of càdlàg function $D([0,1])$. In the studies on random trees, the topology used on this space is usually SKOROKHOD's J_1 topology, however we will see that some encoding processes of rotated trees converge with respect to the weaker SKOROKHOD's M_1 topology but not with respect to the J_1 topology, and in light of Proposition [1.2](#page-1-0) this weaker convergence is enough to get the desired result. We thus choose the following convention:

In this paper (except in the appendix A), all convergences of processes are with respect to SKOROKHOD's M_1 topology.

One only needs the definition (3.2) and the few properties of the M_1 topology given in section [3.2](#page-10-0) to understand the rest of this paper (see [\[Whi02\]](#page-44-9) for a more general account). We just stress that the convergences already established with respect to J_1 imply the same convergences with respect to M_1 but they will be written in a slightly different way, because under J_1 it is often required to work with the *discontinuous* interpolation of a sequence to establish its scaling limit while there is no need for this under M_1 . More precisely, consider $A = (A(k))_{0 \le k \le p}$ a real sequence. We have defined its time-scaled function $a \in C([0,1])$ by linear interpolation in order to make it continuous, but we could have chosen to embed A in $D([0,1])$ by defining the piecewise constant function $a': t \mapsto A(|pt])$ (see Figure [11\)](#page-21-1). This can make a huge difference for the J_1 topology as $d_{J_1}(a, a') \geq \max_{1 \leq k \leq p} |A(k) - A(k-1)|/2$, but one can find parametric representations of a and a' with the same spatial component and close temporal components as depicted in Figure [12,](#page-22-0) which entails that $d_{M_1}(\lambda a, \lambda a') \leq 1/p$ for any $\lambda \in \mathbb{R}$. As p always goes to $+\infty$ here, working with a or a' makes no difference for scaling limits with respect to the M_1 topology, thus we may and will choose to always use the linear interpolation, *i.e.* the time-scaled function defined in Section [2.](#page-5-0)

5.2 Known scaling limits for Bienaymé trees

Duquesne's Theorem. First we introduce a theorem of Duquesne [\[Duq03\]](#page-43-5) which generalizes ALDOUS' theorem by giving the joint scaling limits of all encoding functions of \mathcal{T}_n in this general framework. The limiting processes can be defined from a spectrally positive α -stable Lévy process in the following way: consider a Lévy process X whose LAPLACE transform is given by $\mathbb{E}(\exp[-\lambda X_t]) = e^{t\lambda^{\alpha}},$ for all $t, \lambda > 0$. The continuous-time height process H associated to X is

informally defined from X by means of the relation expressing the height process of a tree from its ŁUKASIEWICZ walk. More formally, H is the continuous modification of the process H' such that H'_t is the local time, at instant t, of $X^{(t)}$ at its supremum, where $X^{(t)}$ is the dual Lévy process of $(X_s)_{0\leq s\leq t}$. The scaling limits obtained by DUQUESNE are a normalized excursion x of a spectrally positive α -stable Lévy process together with its associated height excursion h, which can be thought of as a positive excursion x of X away from 0 conditioned to have a unit length together with the corresponding excursion h of H. We refer to $Duq03$, Section 3.1-2 for proper definitions and details, the only thing to keep in mind here is that x is continuous if and only if $\alpha = 2$ while h is always continuous.

We can now give a formal statement of DUQUESNE's theorem, where we recall that s_T , h_T and c_T refer to the time-scaled function of the ŁUKASIEWICZ walk, height process and contour process of a tree T as defined in Section [2.](#page-5-0)

Theorem 5.1 (DUQUESNE [DUQ03]). Let \mathcal{T}_n be distributed as BGW_µ(\cdot |#vertices = n) where the offspring distribution μ is critical and has variance σ^2 possibly infinite. Assuming that μ is attracted to a stable distribution of index $\alpha \in (1,2]$, there is an increasing slowly varying function ℓ that depends on μ such that

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n}, \frac{\ell(n)}{n^{1-1/\alpha}}h_{\mathcal{T}_n}, \frac{\ell(n)}{n^{1-1/\alpha}}c_{\mathcal{T}_n}\right) \xrightarrow[n \to +\infty]{(d)} (\mathbf{x}, \mathbf{h}, \mathbf{h}).
$$

Furthermore when $\alpha = 2$ then $\mathbf{x} = \ln$ and $\ell(n) \longrightarrow_{n \to +\infty} \frac{\sigma}{\sqrt{2}}$ (if $\sigma^2 = +\infty$ this means $\ell(n) \longrightarrow_{n \to +\infty} +\infty$).

Remark. Theorem [5.1](#page-22-1) is a reinforcement of [\[Duq03,](#page-43-5) Theorem 3.1] that is not explicitly written but results from the same arguments (see in particular [\[Duq03,](#page-43-5) Remark 3.2, Proposition 4.3, Equation (30)]).

We stress that the case σ^2 < $+\infty$ has some specific features. In this case we must have $\alpha = 2$ and all three limiting processes are equal, but we also see that ℓ has a finite limit hence $\alpha = 2$ and an time infiniting processes are equal, but we also see that t has a liftle film field
the three encoding functions of \mathcal{T}_n are rescaled by the *same* factor \sqrt{n} (up to a constant). This case has actually been proved first by MARCKERT & MOKKADEM [MM03A] under an additional assumption of finite exponential moment for μ , and its features will make a real difference for the scaling limit of Rot \mathcal{T}_n , thus we choose to restate this result on its own. In this particular case, we use e a normalized excursion of a *standard* Brownian motion B, but we have to consider $X = \sqrt{2B}$ in order to have a LÉVY process with LAPLACE transform $\mathbb{E}(\exp[-\lambda X_t]) = e^{t\lambda^2}$, so one must keep in mind that e has the law of $x/\sqrt{2}$ in this situation.

Theorem 5.2 (MARCKERT & MOKKADEM [MM03A], DUQUESNE [DUQ03]). Let \mathcal{T}_n be distributed as $BGW_{\mu}(\cdot | \# \text{vertices} = n)$ where the offspring distribution μ is critical. Assuming that μ has variance $\sigma^2 < +\infty$, we have the convergence in distribution

$$
\frac{1}{\sqrt{n}}\left(s_{\mathcal{T}_n}, h_{\mathcal{T}_n}, c_{\mathcal{T}_n}\right) \xrightarrow[n \to +\infty]{(d)} \left(\sigma \mathbf{e}, \frac{2}{\sigma} \mathbf{e}, \frac{2}{\sigma} \mathbf{e}\right).
$$

Remark. There are actually similar scaling limit results for other types of conditioned BIENAYMÉ trees, such as those conditioned to have at least n vertices and those conditioned to have height greater than n. We refer to $[LG10, \text{section 5}]$ $[LG10, \text{section 5}]$ for the joint convergence of all three encoding functions greater than *n*: we refer to **position**, section by for the joint convergence of an time encoung functions rescaled by \sqrt{n} towards the same Brownian excursion under a general *regular conditioning* in the case $\sigma^2 < +\infty$, and we refer to [\[DLG02,](#page-43-1) section 2.5] for the joint convergence of all three encoding functions under some specific conditioning in the general stable case. In the following we will not be concerned with those other conditioned Bienaymé trees but most arguments and results here can be adapted as soon as we have a scaling limit result analogous to Theorem [5.1.](#page-22-1)

Extension based on the mirror transformation. We now turn to an extension of the previous result needed to study the rotation. Recall the mirror transformation $T \mapsto T^{\div}$ introduced in Section [4.](#page-16-0) We use the previous result of DUQUESNE to describe the joint convergence of encoding processes of both \mathcal{T}_n and \mathcal{T}_n^{\div} .

Observe that $C_{\mathcal{T}_n^+}$ simply is the reversed contour process of \mathcal{T}_n , obtained by following the contour of the tree from right to left instead of left to right. This means that $c_{\mathcal{T}_n^{\pm}} = \hat{c}_{\mathcal{T}_n}$, where for all $x \in D([0,1])$, \hat{x} is defined by $\hat{x}: t \mapsto x((1-t)-)$. Since $x \mapsto \hat{x}$ is continuous with respect to the M_t topology the asymptotic behaviours of C_t and C_{τ} are related in a simple way. However M_1 topology, the asymptotic behaviours of $C_{\mathcal{T}_n^+}$ and $C_{\mathcal{T}_n}$ are related in a simple way. However, we will rather be interested in $S_{\mathcal{T}_n^{\div}}$ and $H_{\mathcal{T}_n^{\div}}$ as it will allow us to extract some information about Rot \mathcal{T}_n . As height processes are asymptotically equal to contour processes for these trees, we can relate the asymptotic behaviours of $H_{\mathcal{T}_n^{\pm}}$ and $H_{\mathcal{T}_n}$ without much difficulty, but the links between $S_{\mathcal{T}_n^{\div}}$ and $S_{\mathcal{T}_n}$ are more intricate. Nevertheless, one may deduce the following result.

Proposition 5.3. Let \mathcal{T}_n be distributed as $BGW_\mu(\cdot | \# \text{vertices} = n)$ where the offspring distribution μ is critical. Assuming that μ is attracted to a stable distribution of index $\alpha \in (1,2]$, there is a measurable function $F^{\div}: D([0,1]) \to D([0,1])$ such that

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n}, \frac{\ell(n)}{n^{1-1/\alpha}}h_{\mathcal{T}_n}, \frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n^{\div}}, \frac{\ell(n)}{n^{1-1/\alpha}}h_{\mathcal{T}_n^{\div}}\right) \xrightarrow[n \to +\infty]{(d)} \left(\mathbf{x}, \mathbf{h}, F^{\div}(\mathbf{x}), \widehat{\mathbf{h}}\right).
$$

Moreover, when $\alpha = 2$ the normalized excursion x and F^{\pm} are such that $F^{\pm}(x) = \hat{x}$ almost surely.

Remark. Assuming μ has variance $\sigma^2 < +\infty$, we may reformulate Proposition [5.3](#page-23-1) as

$$
\frac{1}{\sqrt{n}}\left(s_{\mathcal{T}_n},h_{\mathcal{T}_n},s_{\mathcal{T}_n^{\div}},h_{\mathcal{T}_n^{\div}}\right)\xrightarrow[n\to+\infty]{(d)}\left(\sigma\mathbb{e},\frac{2}{\sigma}\mathbb{e},\sigma\widehat{\mathbb{e}},\frac{2}{\sigma}\widehat{\mathbb{e}}\right).
$$

We prove Proposition [5.3](#page-23-1) in Appendix [A.](#page-40-1) Let us just stress here that \mathcal{T}_n^{\div} is also distributed according to $BGW_\mu(\cdot | \# \text{vertices} = n)$, since the mirror transformation clearly preserves the distribution BGW_μ as well as the set of trees with n vertices. As a consequence $(s_{\mathcal{T}_n^{\div}}, h_{\mathcal{T}_n^{\div}})$ is distributed as $(s_{\mathcal{T}_n}, h_{\mathcal{T}_n})$, whose convergence is given by Theorem [5.1,](#page-22-1) and thus the proof of Proposition [5.3](#page-23-1) is just a question of understanding the intricate dependence between the limiting processes.

We do not have a fully explicit expression for $F^{\div}(\mathbf{x})$ (see the last remark of [A](#page-40-1)ppendix A for details) but an important property follows from Proposition [5.3:](#page-23-1) since $(s_{\mathcal{T}_n^+}, h_{\mathcal{T}_n^+})$ is distributed as $(s_{\mathcal{T}_n}, h_{\mathcal{T}_n})$, their limits $(F^{\div}(\mathbf{x}), \hat{\mathbf{h}})$ and (\mathbf{x}, \mathbf{h}) have the same distribution. In particular, $F^{\div}(\mathbf{x})$ is an excursion of a spectrally positive α -stable Lévy process, and its associated height excursion is $\widehat{\mathbb{h}}$. Moreover as $T \mapsto T^{\div}$ is an involution we clearly have

$$
F^{\div}(F^{\div}(\mathbf{x})) = \mathbf{x} \text{ a.s.}
$$

The main reason that leads us to state Proposition [5.3](#page-23-1) is that the connection between the scaling limits of $s_{\mathcal{T}_n}$ and $s_{\mathcal{T}_n}$; given by F^{\div} , will be used to understand the connection between $s_{\mathcal{T}_n}$ and the encoding functions of Rot \mathcal{T}_n . It will also be useful to understand the connection between the scaling limits of Rot \mathcal{T}_n and Tor \mathcal{T}_n .

5.3 Encoding processes of a large Bienaymé tree and its rotation

We are now all set to study the encoding processes of Rot \mathcal{T}_n and compare them to those of \mathcal{T}_n . We provide Table [1](#page-24-1) to summarize the notation introduced in the previous section and needed in the following.

Statement and consequences. Our most complete result about the rotation is the following joint convergence of all encoding functions of \mathcal{T}_n and of Rot \mathcal{T}_n .

Theorem 5.4. Let \mathcal{T}_n be distributed as $BGW_\mu(\cdot | \# \text{vertices} = n)$ where the offspring distribution μ is critical, has variance $\sigma^2 \leq +\infty$ and is attracted to a stable distribution with index $\alpha \in (1,2]$.

• Assuming $\sigma^2 < +\infty$, we have

$$
\frac{1}{\sqrt{n}}\left(s_{\mathcal{T}_n}, c_{\mathcal{T}_n}, s_{\text{Rot}\mathcal{T}_n}, c_{\text{Rot}\mathcal{T}_n}\right) \xrightarrow[n \to +\infty]{(d)} \left(\sigma \mathbf{e}, \frac{2}{\sigma} \mathbf{e}, \frac{2}{\sigma} \mathbf{e}, \frac{2+\sigma^2}{\sigma} \mathbf{e}\right).
$$

• Assuming $\sigma^2 = +\infty$, we have

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n}, \frac{\ell(n)}{n^{1-1/\alpha}}c_{\mathcal{T}_n}, \frac{\ell(n)}{n^{1-1/\alpha}}s_{\text{Rot}}\tau_n, \frac{1}{\ell(n)n^{1/\alpha}}c_{\text{Rot}}\tau_n\right) \xrightarrow[n \to +\infty]{(d)} (\mathbf{x}, \mathbf{h}, \mathbf{h}, \hat{\mathbf{y}})
$$

where $y = F^{\div}(x)$.

In addition, in both cases height functions are asymptotically the same as contour functions:

$$
\frac{\ell(n)}{n^{1-1/\alpha}}\|c_{\mathcal{T}_n}-h_{\mathcal{T}_n}\|_{\infty} \xrightarrow[n\to+\infty]{(\mathbb{P})} 0 \text{ and } d_{M_1}\left(\frac{1}{\ell(n)n^{1/\alpha}}c_{\text{Rot}}\tau_n,\frac{1}{\ell(n)n^{1/\alpha}}h_{\text{Rot}}\tau_n\right) \xrightarrow[n\to+\infty]{(\mathbb{P})} 0.
$$

Remark. Observe that when $\alpha = 2$, $\hat{y} = x = h$ a.s. and all six encoding processes jointly converge *Remark*. Observe that when $\alpha = 2$, $y = x = n$ a.s. and all six encoding processes jointly converge towards the same excursion x, which is distributed as $\sqrt{2}e$. Moreover, since a Brownian excursion is continuous, the convergence in distribution can also be seen with respect to $\|\cdot\|_{\infty}$ and we actually have:

$$
\frac{1}{\ell(n)\sqrt{n}}\left\|c_{\text{Rot}}\tau_n - h_{\text{Rot}}\tau_n\right\|_{\infty} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

factors have order \sqrt{n} , but most importantly in this case the rescaling factor of $c_{\text{Rot}}\tau_n$ is not asymptotically equivalent to the rescaling factor of $s_{\mathcal{T}_n}$. This contrasts with the symmetry of the scaling factors in the case $\sigma^2 = +\infty$.

Thanks to Proposition [1.1,](#page-1-2) Theorem [1.3](#page-2-1) appears as a consequence of Theorem [5.4.](#page-24-0)

Proof of Theorem [1.3.](#page-2-1) We first restrict our attention to the components corresponding to the contour processes to get a simpler statement.

• When $\sigma^2 < +\infty$

$$
\frac{1}{\sqrt{n}} \left(c_{\mathcal{T}_n}, c_{\text{Rot}} \mathcal{T}_n \right) \xrightarrow[n \to +\infty]{(d)} \left(\frac{2}{\sigma} \mathbf{e}, \frac{2 + \sigma^2}{\sigma} \mathbf{e} \right). \tag{12}
$$

• When $\sigma^2 = +\infty$ $\left(\frac{\ell(n)}{n^{1-1/\alpha}}c_{\mathcal{T}_n},\frac{1}{\ell(n)n^{1/\alpha}}c_{\mathrm{Rot}}\tau_n\right)\xrightarrow[n\to+\infty]{(d)} (\widehat{\mathbb{h}},\widehat{\mathbb{x}})$ (13)

Note that in the second case, we use that $(F^{\div}(\mathbf{x}), \hat{\mathbf{h}})$ is distributed as (\mathbf{x}, \mathbf{h}) in order to write a limit that does not involve F^{\pm} . Then we apply the continuous mapping $(x, y) \mapsto (\mathscr{T}_x, \mathscr{T}_y)$ (Proposition [1.1\)](#page-1-2) and we use [\(5\)](#page-9-0) to get Theorem [1.3.](#page-2-1) We can use h and x instead of $\hat{\mathbb{h}}$ and $\hat{\mathbb{x}}$ since for all $x \in D_0([0, 1], \mathbb{R}_+)$. $\mathcal{F}_{\hat{\mathbb{e}}}$ is isometric to $\mathcal{F}_{\hat{\mathbb{e}}}$. for all $x \in D_0([0,1], \mathbb{R}_+), \mathscr{T}_{\widehat{x}}$ is isometric to \mathscr{T}_x .

Remark. The exact same proof with Proposition [1.2](#page-1-0) instead of Proposition [1.1](#page-1-2) gives a convergence with respect to d_{GHP} .

Proof strategy for Theorem [5.4.](#page-24-0) We now discuss the main steps of the proof of Theorem [5.4](#page-24-0) in an informal way. As a preliminary remark, recall that up to a last step down $C_{\mathcal{T}_n}$ and $S_{\text{Rot}\mathcal{T}_n}$ are the same process, hence $S_{\text{Rot}}\tau_n$ is already fully understood and we must focus on the study of $H_{\text{Rot}}\tau_n$ and $C_{\text{Rot}}\tau_n$. To do so, our main tool is the internal subtree $(\text{Rot }T)^\circ$ defined in Section [4.](#page-16-0)

First, we express the height of vertices in $(\text{Rot}\,\mathcal{T}_n)^\circ$ with known processes, thanks to [\(9\)](#page-17-1) and the mirror transformation. However, this requires considering an enumeration $(\tilde{w}_k)_{1 \leq k \leq n-1}$ of $(\text{Det } \mathcal{T})^{\circ}$ different from the legiscomposition one. We will fermally define this enumeration later $(\text{Rot}\,\mathcal{T}_n)^\circ$ different from the lexicographical one. We will formally define this enumeration later in the proof, in short we will first introduce $(w_k)_{0 \leq k \leq n-1}$ the *mirrored enumeration* of \mathcal{T}_n (see Figure [13](#page-26-0) below) and then we will use the correspondence $u \in \mathcal{T}_n \setminus \{\varnothing\} \mapsto \widetilde{u} \in (\text{Rot} \mathcal{T}_n)^\circ$ defined in
Section 4 to obtain (\widetilde{w}_1) . This enumeration (\widetilde{w}_1) is such that the non-standard Section [4](#page-16-0) to obtain $(\widetilde{w}_k)_{1 \leq k \leq n-1}$. This enumeration $(\widetilde{w}_k)_{1 \leq k \leq n-1}$ is such that the non-standard
hoight process H^* based on it, which is defined by $H^*(k) = |\widetilde{w}_k|$ for $1 \leq k \leq n-1$ and $H^*(0)$ height process H_n^* based on it, which is defined by $H_n^*(k) = |\widetilde{\tilde{w}}_k|$ for $1 \le k \le n-1$ and $H_n^*(0) =$
 $H^*(n) = 0$ has a scaling limit ossily deduced from Theorem 5.1. This convergence of H^* is actually $H_n^*(n) = 0$, has a scaling limit easily deduced from Theorem [5.1.](#page-22-1) This convergence of H_n^* is actually a joint convergence involving H_n^* and the encoding processes of \mathcal{T}_n , see [\(16\)](#page-26-1) and [\(17\)](#page-26-2) below.

Then, we relate this process H_n^* to the height and contour processes of both $(\text{Rot } \mathcal{T}_n)^\circ$ and Rot \mathcal{T}_n . For this last part, we actually relate these processes through three independent lemmas. They all rely on the same method, namely establishing combinatorial links between the discrete processes and then use them to control the M_1 distance between their rescaled functions, and we have chosen to postpone their proofs to Section [6](#page-30-0) which will be dedicated to this method.

In Section [6.1,](#page-31-0) we adapt a classical argument to the M_1 setting: if a sequence of trees $(T_n)_n$ is such that $\#T_n \to +\infty$ and $\max H_{T_n} = o(\#T_n)$ as n goes to $+\infty$, then when n is large the rescaled height process of T_n is roughly the same as its rescaled contour process. We formalize this in the next lemma.

Lemma 5.5. Let $(T_n)_n$ be a sequence of (possibly random) finite plane trees. Assume that

$$
\#T_n\xrightarrow[n\to+\infty]{(\mathbb{P})}+\infty\ and\ \frac{\max H_{T_n}}{\#T_n}\xrightarrow[n\to+\infty]{(\mathbb{P})}0.
$$

Then for any real sequence $(\lambda(n))_n$ such that $\lambda(n) \to 0$, we have

$$
d_{M_1}(\lambda(n)h_{T_n}, \lambda(n)c_{T_n}) \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

Let us mention that the scaling limit result for H_n^* will yield that we can apply Lemma [5.5](#page-25-0) to Rot \mathcal{T}_n and $(\text{Rot }\mathcal{T}_n)^\circ$.

In Section [6.2,](#page-33-0) we then study the enumeration $(\widetilde{w}_k)_{1\leq k\leq n-1}$ and we obtain the following result linking the time-scaled functions of H_n^* and $C_{(Rot\mathcal{T}_n)^{\circ}}$.

Lemma 5.6. For any real sequence $(\lambda(n))_n$, we have

$$
d_{M_1}(\lambda(n)\widehat{c}_{(\mathrm{Rot}\mathcal{T}_n)^{\circ}}, \lambda(n)h_n^*)\xrightarrow[n\to+\infty]{(\mathbb{P})} 0,
$$

where $\hat{c}_{(\text{Rot}\mathcal{T}_n)^\circ}$ is the reversed time-scaled contour function of $(\text{Rot}\mathcal{T}_n)^\circ$, obtained by applying $x \mapsto \widehat{x}$ to $c_{(\text{Rot}\mathcal{T}_n)^\circ}$.

Finally, in Section [6.3](#page-35-0) we study how the leaves are distributed in Rot \mathcal{T}_n in order to relate the height processes $H_{(Rot\mathcal{T}_n)}$ [°] and $H_{Rot\mathcal{T}_n}$. Again, we deduce that their rescaled functions are roughly the same.

Lemma 5.7. For any real sequence $(\lambda(n))_n$ such that $\lambda(n) \to 0$, we have

$$
d_{M_{1}}\big(\lambda(n)h_{(\mathrm{Rot}\mathcal{T}_n)^{\circ}}, \lambda(n)h_{\mathrm{Rot}\mathcal{T}_n}\big) \xrightarrow[n\to+\infty]{(\mathbb{P})} 0.
$$

Theorem [5.4](#page-24-0) directly follows from these three lemmas combined with the joint convergence of H_n^* , the three encoding processes of \mathcal{T}_n , and $S_{\text{Rot}}\mathcal{T}_n$.

We now make formal the above proof strategy, with the assumption that Lemmas [5.5,](#page-25-0) [5.6](#page-25-1) and [5.7](#page-25-2) hold, and we refer to Section [6](#page-30-0) for their proofs. We provide Tables [1](#page-24-1) and [2](#page-26-3) to recall some useful notation.

Table 2: Reminders on plane trees and the rotation.

Proof of Theorem [5.4.](#page-24-0) Recall [\(9\)](#page-17-1) which states that the height of a rotated vertex $\tilde{u} \in (\text{Rot } \mathcal{T}_n)$ ^o is mode of two contributions, pamely [4] and $I(u)$ and also recall that the *kUKASIEWIGZ* walls is made of two contributions, namely |u| and $L(u)$, and also recall that the ŁUKASIEWICZ walk $S_{\mathcal{T}_n}$ of \mathcal{T}_n is such that $S_{\mathcal{T}_n}(k) = R(u_k)$ for all $k < n$, where $u_0, \ldots u_{n-1}$ is the lexicographical enumeration of \mathcal{T}_n . In order to exchange *right* and *left*, we consider a new enumeration of \mathcal{T}_n based on its mirror version \mathcal{T}_n^{\div} . We identify each vertex of \mathcal{T}_n with its mirror image in \mathcal{T}_n^{\div} (*i.e.* its image by the reflection symmetry, see Figure [13\)](#page-26-0). Thanks to this identification, a lexicographical enumeration of \mathcal{T}_n^{\div} gives a *mirrored enumeration* of \mathcal{T}_n , which will be systematically denoted by $w_0 = \emptyset, w_1, \ldots, w_{n-1}$ to avoid confusion with the lexicographic enumeration (again, see Figure [13\)](#page-26-0). As the right of the mirror image of some vertex u corresponds to the left of u in the initial tree, while the height is preserved, we get that

for
$$
0 \le k \le n-1
$$
, $L(w_k) = S_{\mathcal{T}_n^{\div}}(k)$ and $|w_k| = H_{\mathcal{T}_n^{\div}}(k)$. (14)

Figure 13: A tree (left) and its mirror tree (right). The lexicographical enumeration of the mirror tree is denoted by $u_0^{\pm}, \ldots, u_6^{\pm}$. The double circles indicate a marked vertex and its mirror image. The mirrored enumeration of the initial tree is denoted by w_0, \ldots, w_6 .

Let us now consider the enumeration of $(\text{Rot } \mathcal{T}_n)^\circ$ obtained by applying the correspondence $u \mapsto \tilde{u}$ to $(w_k)_{1 \leq k \leq n-1}$, and let H_n^* be such that $H_n^*(k) = |\tilde{w}_k|$ for $1 \leq k \leq n-1$ and $H_n^*(0) =$
 $H^*(\infty) = 0$. As well k^* denotes the associated time scaled function. By (0) and (14), we have $H_n^*(n) = 0$. As usual h_n^* denotes the associated time-scaled function. By [\(9\)](#page-17-1) and [\(14\)](#page-26-4), we have that for all $1 \leq k \leq n-1$

$$
H_n^*(k) = H_{\mathcal{T}_n^{\div}}(k) + S_{\mathcal{T}_n^{\div}}(k) - 1.
$$
 (15)

As a consequence, $||h_n^* - h_{\mathcal{T}_n^{\pm}} - s_{\mathcal{T}_n^{\pm}}||_{\infty} \leq 2$ and we deduce a scaling limit for h_n^* (jointly with the encoding processes of \mathcal{T}_n) thanks to Proposition [5.3:](#page-23-1)

• When $\sigma^2 = +\infty$, $h_{\mathcal{T}_n^{\pm}}$ becomes negligible in front of $s_{\mathcal{T}_n^{\pm}}$ since $n^{1-1/\alpha}/\ell(n) = o(n^{1/\alpha}\ell(n))$ as $n \to +\infty$, hence we have

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}s\tau_n, \frac{\ell(n)}{n^{1-1/\alpha}}c\tau_n, \frac{1}{\ell(n)n^{1/\alpha}}h_n^*\right) \xrightarrow[n \to +\infty]{(d)} (\mathbf{x}, \mathbf{h}, \mathbf{y}),\tag{16}
$$

where $y = F^{\div}(\mathbf{x})$.

• When $\sigma^2 < +\infty$, $h_{\mathcal{T}_n^{\div}}$ becomes proportional to $s_{\mathcal{T}_n^{\div}}$, hence we have

$$
\frac{1}{\sqrt{n}}\left(s_{\mathcal{T}_n}, c_{\mathcal{T}_n}, h_n^*\right) \xrightarrow[n \to +\infty]{(d)} (\sigma \mathbf{e}, \frac{2}{\sigma} \mathbf{e}, \frac{2+\sigma^2}{\sigma} \widehat{\mathbf{e}}). \tag{17}
$$

Note that we use the following facts: $\ell(n)/n^{1-1/\alpha} \times ||c_{\mathcal{T}_n} - h_{\mathcal{T}_n}||_{\infty} \to 0$ in probability (Theorem [5.1\)](#page-22-1), and the addition of functions is not continuous in general for d_{M_1} but is continuous at any point (x, y) such that x or y is in $C([0, 1]).$

We now relate h_n^* to the contour function of Rot \mathcal{T}_n . First, Lemma [5.6](#page-25-1) gives that once rescaled \widehat{h}_n^* is roughly the same as $c_{\text{(Rot}\mathcal{T}_n)^{\circ}}$. But according to Lemma [5.5,](#page-25-0) since $\max H_{\text{(Rot}\mathcal{T}_n)^{\circ}} = \max H_n^*$ is negligible in front of n, we have that $c_{(Rot\mathcal{T}_n)^{\circ}}$ is almost the same as $h_{(Rot\mathcal{T}_n)^{\circ}}$. By Lemma [5.7](#page-25-2) this last process is also roughly the same as $h_{Rot} \tau_n$, so it is roughly the same as $c_{Rot} \tau_n$ by Lemma [5.5](#page-25-0) again. We finally get

$$
d_{M_1}\left(\frac{1}{\ell(n)n^{1/\alpha}}c_{\text{Rot}}\tau_n,\frac{1}{\ell(n)n^{1/\alpha}}\widehat{h_n^*}\right) \xrightarrow[n\to+\infty]{(\mathbb{P})} 0.
$$

Thus [\(16\)](#page-26-1) and [\(17\)](#page-26-2) still hold if we replace h_n^* with $c_{\text{Rot}}\tau_n$, as long as we apply $x \mapsto \hat{x}$ to the representing limit. Finally, we also know that up to a last stap down C_{τ} and S_{τ} τ soingide. corresponding limit. Finally, we also know that, up to a last step down, $C_{\mathcal{T}_n}$ and $S_{\text{Rot}}_{\mathcal{T}_n}$ coincide, so by convergence of $c_{\mathcal{T}_n}$ we get

$$
\frac{\ell(n)}{n^{1-1/\alpha}} \|c_{\mathcal{T}_n} - s_{\text{Rot}}\tau_n\|_{\infty} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

As a consequence we get from [\(16\)](#page-26-1) and [\(17\)](#page-26-2) the joint convergence of $s_{\mathcal{T}_n}, c_{\mathcal{T}_n}, s_{\text{Rot}}_{\mathcal{T}_n}$ (rescaled as above). Lemma [5.5](#page-25-0) already gives that their height and contour processes are roughly the same, so Theorem [5.4](#page-24-0) is proved. \Box

Comments on the proof.

- If one is not interested in the dependence between the encoding processes of Rot \mathcal{T}_n and $s_{\mathcal{T}_n}$ (for instance, if one simply wants to get (12) and (13) to establish Theorem [1.3\)](#page-2-1), then there is no need to use F^{\div} as [\(16\)](#page-26-1) and [\(17\)](#page-26-2) without $s_{\mathcal{T}_n}$ may be deduced from Theorem [5.1](#page-22-1) applied to $(\mathcal{T}_n^{\div})_n$ instead of its extension Proposition [5.3.](#page-23-1)
- In the special case $\mu = \text{GEOM}_\mathbb{N}(1/2)$, a form of Theorem [5.4](#page-24-0) has already been proved by MARCKERT in [\[Mar04\]](#page-44-3). Let us stress the similarities and differences between his proof and ours. Marckert presents in his paper the geometric construction of Rot which gives the handy identification between $T \setminus \{ \varnothing \}$ and the internal subtree $(Rot T)^\circ$, and he also introduces the key idea of using $h_{(Rot\mathcal{T}_n)^{\circ}}$ as an intermediate process to link $h_{\mathcal{T}_n}$ and $h_{Rot\mathcal{T}_n}$. Our strategy for a general proof of Theorem [5.4](#page-24-0) is based on this idea, with some adaptations such as replacing $h_{(\text{Rot}\mathcal{T}_n)^\circ}$ by h_n^* as we actually have to link $h_{\text{Rot}\mathcal{T}_n}$ with $s_{\mathcal{T}_n^{\div}}$ as soon as $\sigma^2 = +\infty$. However, we use quite different methods to prove that the several processes are asymptotically close to each other. Indeed, in this special case Rot \mathcal{T}_n is uniform over binary trees with n leaves and thus is distributed as a conditioned BIENAYMÉ tree with offspring distribution $(\delta_0 + \delta_2)/2$. This enables MARCKERT to use some previous results from [\[MM03a,](#page-44-12) [MM03b\]](#page-44-14) which describe in details the internal structure of conditioned critical Bienaymé trees (with some exponential moment assumption), and it immediately gives that the internal height process of Rot \mathcal{T}_n , namely $h_{(\text{Rot}\mathcal{T}_n)^{\circ}}$, is close to the global height process $h_{\text{Rot}}\tau_n$, as well as the fact that the "right part" of $h_{(\text{Rot}\tau_n)^{\circ}}$ is close to its "left part" which is $h_{\mathcal{T}_n}$. Unfortunately, $\mu = \text{Geom}_N(1/2)$ is the only case where Rot \mathcal{T}_n is distributed as a conditioned Bienaymé tree. We thus use another approach, as explained in Section [1.](#page-0-0) Its main specific features are that we express all quantities of interest with encoding processes of \mathcal{T}_n (since the behaviour of this tree only is well known) and then we look for combinatorial relations between processes that hold for every plane tree in order to link the asymptotic behaviours, with respect to d_{M_1} , of those processes.

5.4 Comparison with the co-rotation

Recall the companion correspondence of the rotation, Tor, introduced in Section [4.](#page-16-0) We explore briefly the similarities and mostly the differences between Rot and Tor applied on large Bienaymé trees in this section, and in particular we prove that the encoding processes of Tor \mathcal{T}_n asymptotically behave in a nicer way.

By [\(10\)](#page-18-1), which gives that Tor is linked to Rot through the mirror transformation, we see that Tor \mathcal{T}_n is distributed as $(\text{Rot } \mathcal{T}_n)^{\div}$, hence it has the same distributional scaling limit. Thanks to Proposition [5.3,](#page-23-1) we can even use [\(10\)](#page-18-1) to get a joint convergence as a corollary of Theorem [5.4.](#page-24-0) We state this result as convergence of contour functions but it directly translates into convergence of trees. Recall the notation of Table [1.](#page-24-1)

Corollary 5.8. Let \mathcal{T}_n be distributed as $BGW_u(\cdot | \# \text{vertices} = n)$ where the offspring distribution μ is critical and attracted to a stable distribution of index $\alpha \in (1, 2]$.

• When $\alpha = 2$,

$$
\frac{1}{\ell(n)\sqrt{n}}||c_{\text{Rot}}\tau_n - c_{\text{Tor}}\tau_n||_{\infty} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

• When $\alpha < 2$, we have the convergence in distribution

$$
\left(\frac{\ell(n)}{n^{1-1/\alpha}}c_{\mathcal{T}_n}, \frac{1}{\ell(n)n^{1/\alpha}}c_{\text{Rot}}\tau_n, \frac{1}{\ell(n)n^{1/\alpha}}c_{\text{Tor}}\tau_n\right) \xrightarrow[n \to +\infty]{(d)} (\mathbb{h}, \widehat{\mathbb{y}}, \mathbb{x})
$$

with $y = F^{\div}(\mathbf{x}).$

Proof. First, we assume that $\alpha = 2$. We first get from Theorem [5.4](#page-24-0) that

$$
\frac{1}{\ell(n)\sqrt{n}}\|c_{\text{Rot}}\tau_n - (1+\frac{2}{\sigma^2})s_{\mathcal{T}_n}\|_{\infty} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0,
$$

with $2/(+\infty) = 0$ by convention. The same holds when one replaces \mathcal{T}_n by \mathcal{T}_n^{\div} , and by [\(10\)](#page-18-1) we have $c_{\text{Rot}(\mathcal{T}_n^+)} = \hat{c}_{\text{Tor}\mathcal{T}_n}$. The result thus follows from Proposition [5.3](#page-23-1) as it gives

$$
\frac{1}{\ell(n)\sqrt{n}}\big\| \widehat{s}_{\mathcal{T}_n^{\div}} - s_{\mathcal{T}_n} \big\|_{\infty} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

We now deal with the case $\alpha < 2$. The argument is rather similar: it is sufficient to prove that

$$
d_{M_1}\left(\frac{1}{\ell(n)n^{1/\alpha}}\widehat{c}_{\text{Rot}}\tau_n, \frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n^{\div}}\right) \xrightarrow[n \to +\infty]{(\mathbb{P})} 0. \tag{18}
$$

Indeed, [\(18\)](#page-28-1) applied to \mathcal{T}_n^{\div} instead of \mathcal{T}_n gives

$$
d_{M_1}\left(\frac{1}{\ell(n)n^{1/\alpha}}c_{\text{Tor}}\tau_n,\frac{1}{\ell(n)n^{1/\alpha}}s_{\tau_n}\right)\xrightarrow[n\to+\infty]{(\mathbb{P})}0. \tag{19}
$$

By combining Proposition [5.3](#page-23-1) with [\(18\)](#page-28-1), [\(19\)](#page-28-2) and the fact that $\ell(n)/n^{1-1/\alpha} \times ||c_{\mathcal{T}_n} - h_{\mathcal{T}_n}||_{\infty} \xrightarrow{(\mathbb{P})} 0$, we get the desired result.

Notice that [\(18\)](#page-28-1) has already been implicitly proved during the proof of Theorem [5.4](#page-24-0) (both terms in [\(18\)](#page-28-1) have been compared to h_n^*). We may also deduce it directly from Theorem [5.4](#page-24-0) and Proposition [5.3:](#page-23-1) According to these results, the sequence

$$
\left(\frac{\ell(n)}{n^{1-1/\alpha}}c_{\mathcal{T}_n}, \frac{1}{\ell(n)n^{1/\alpha}}\widehat{c}_{\text{Rot}}\tau_n, \frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n^+}\right)_n
$$

is tight and any subsequential distributional limit must be distributed as $(\mathbf{x}, F^{\div}(\mathbf{x}), F^{\div}(\mathbf{x}))$. This concludes the proof. \Box

Remark. Simulations seem to indicate that the corresponding joint scaling limits for rotated and co-rotated trees, namely $(\mathscr{T}_{F^{\div}(\mathbf{x})}, \mathscr{T}_{\mathbf{x}})$, is such that almost surely $\mathscr{T}_{F^{\div}(\mathbf{x})} \neq \mathscr{T}_{\mathbf{x}}$ when $\alpha < 2$, but we do not have a proof for this claim. In any case, these two trees are still closely related, as $\mathscr{L}_{F^{\div}(\mathbf{x})} = \mathscr{L}_{\mathbf{x}}$ because of [\[CK14,](#page-43-2) Theorem 4.1] and the fact that $\text{Loop}(T) = \text{Loop}(T^{\div})$ once we see them as metric spaces (that is, once we forget about the ordered structure of these graphs). According to the discussion in Section [3.3,](#page-14-1) $\mathscr{T}_{\mathbf{x}}$ and $\mathscr{T}_{F^+(\mathbf{x})}$ are two spanning R-trees of $\mathscr{L}_{\mathbf{x}}$. We may think of this as a continuous analogue of Figure [10.](#page-20-2)

So far, Rot \mathcal{T}_n and Tor \mathcal{T}_n have a symmetric behaviour at large scale, as their contour processes satisfy a kind of duality relation at the limit. But this symmetry breaks down once we take into account their ŁUKASIEWICZ walks. Indeed, there is a combinatorial relation between $S_{\text{Tor}} \tau_n$ and $S_{\mathcal{T}_n}$ that will be studied and used in Section [6.4,](#page-38-0) with the same method previously used to compare some encoding processes, and it appears that these processes are asymptotically the same for d_{M_1} .

Lemma 5.9. For any real sequence $(\lambda(n))_n$ such that $\lambda(n) \to 0$, we have

$$
d_{M_1}(\lambda(n)s_{\text{Tor}}\tau_n, \lambda(n)s_{\mathcal{T}_n}) \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

As a consequence, we are able to give an analogue of Theorem [5.4](#page-24-0) *i.e.* a joint convergence result of all encoding processes of \mathcal{T}_n and Tor \mathcal{T}_n , but in this situation all encoding processes of Tor \mathcal{T}_n have the same order and converge towards the same limit, namely the limit of the ŁUKASIEWICZ walk of \mathcal{T}_n .

Theorem 5.10. Let \mathcal{T}_n be distributed as $BGW_u(\cdot | \# \text{vertices} = n)$ where the offspring distribution μ is critical, has variance $\sigma^2 \leq +\infty$ and is attracted to a stable distribution with index $\alpha \in (1,2]$.

• Assuming $\sigma^2 < +\infty$, we have

$$
\frac{1}{\sqrt{n}}\left(s_{\mathcal{T}_n}, c_{\mathcal{T}_n}, s_{\text{Tor}\mathcal{T}_n}, c_{\text{Tor}\mathcal{T}_n}\right) \xrightarrow[n \to +\infty]{(d)} \left(\sigma \mathbf{e}, \frac{2}{\sigma} \mathbf{e}, \sigma \mathbf{e}, \frac{2+\sigma^2}{\sigma} \mathbf{e}\right).
$$

• Assuming $\sigma^2 = +\infty$, we have

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n}, \frac{\ell(n)}{n^{1-1/\alpha}}c_{\mathcal{T}_n}, \frac{1}{\ell(n)n^{1/\alpha}}s_{\text{Tor}\mathcal{T}_n}, \frac{1}{\ell(n)n^{1/\alpha}}c_{\text{Tor}\mathcal{T}_n}\right) \xrightarrow[n \to +\infty]{(d)} (\mathbf{x}, \mathbf{h}, \mathbf{x}, \mathbf{x}).
$$

In addition, in both cases height functions are asymptotically the same as contour functions.

Proof. In the case $\sigma^2 = +\infty$, the result follows from Theorem [5.1](#page-22-1) together with Lemma [5.9](#page-28-3) and [\(19\)](#page-28-2) (which is valid as soon as $\sigma^2 = +\infty$).

In the case $\sigma^2 < +\infty$, the argument is the same but [\(19\)](#page-28-2) does not hold anymore. We use instead Corollary [5.8](#page-28-0) and Theorem [5.4](#page-24-0) to get

$$
\frac{1}{\sqrt{n}}\left\|c_{\text{Tor}}\tau_n - (1+\frac{2}{\sigma^2})s_{\mathcal{T}_n}\right\|_{\infty} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

Finally, height and contour processes are asymptotically close according to Lemma [5.5.](#page-25-0)

 \Box

Remark. Theorem [5.10](#page-29-0) gives an example where two families of trees, $(\mathcal{T}_n)_n$ and $(\text{Tor }\mathcal{T}_n)_n$, have asymptotically the same ŁUKASIEWICZ walk (for d_{M_1}) but significantly different scaling lim-its. On the other hand, Theorems [5.4](#page-24-0) and [5.10](#page-29-0) give a family of trees, $(\text{Rot }\mathcal{T}_n)_n$, whose lexicographic Łukasiewicz walk and mirrored Łukasiewicz walk have dramatically different behaviours: $S_{\text{Rot}}\tau_n$ is of order $n^{1-1/\alpha}/\ell(n)$ and converges in distribution towards the continuous function h while $S_{(Rot\mathcal{T}_n)^+} = S_{Tor(\mathcal{T}_n^+)}$ is of order $\ell(n)n^{1/\alpha}$ and converges towards the discontinuous function $F^{\div}(\mathbf{x})$. This comes from the presence of spines with a specific orientation (with respect to the planar order) in Rot \mathcal{T}_n .

5.5 Comments on the method used in this paper

On the use of SKOROKHOD's M_1 topology. As soon as we consider the case $\alpha < 2$, the use of SKOROKHOD's M_1 topology is crucial for several steps. In particular, in Lemmas [5.6](#page-25-1) and [5.9,](#page-28-3) we compare the processes H_n^* and $S_{\mathcal{T}_n}$ to the processes $C_{(Rot\mathcal{T}_n)^{\circ}}$ and $S_{Tor\mathcal{T}_n}$, and this shows that they have the same limits with respect to the M_1 topology. However the former processes have macroscopic jumps *(i.e.* jumps comparable to the scale of the whole process) while the latter only have increments ± 1 , thus we cannot match their jumps and those processes cannot converge toward the same limits with respect to the J_1 topology. In short, the M_1 topology gives sense to convergences with unmatched jumps, such as in Theorem [5.4](#page-24-0) where the convergence of $c_{\text{Rot}\mathcal{T}_n}$ (whose increments are ± 1) toward a discontinuous function comes from series of microscopic jumps that merge together to form macroscopic jumps at the limit.

On the contrary, when $\alpha = 2$ we can stick with the uniform convergence in $C([0, 1])$, and in the case $\sigma^2 < +\infty$ it is possible to simplify further the proof of Theorem [5.4.](#page-24-0) The key observation is that in this setting $L(u)$ (as well as $R(u)$) is asymptotically proportional to |u|, uniformly in $u \in \mathcal{T}_n$, hence the height of a rotated vertex is also proportional to the height of the corresponding initial vertex.

Proposition 5.11. Suppose $\sigma^2 < +\infty$, then

$$
\frac{1}{\sqrt{n}} \max_{u \in \mathcal{T}_n} \left| L(u) - \frac{\sigma^2}{2} |u| \right| \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

Proof. Recall that we can exchange right and left by considering the mirror tree. It gives that

$$
\max_{u \in \mathcal{T}_n} \left| L(u) - \frac{\sigma^2}{2} |u| \right| = \max_{u' \in \mathcal{T}_n^{\div}} \left| R(u') - \frac{\sigma^2}{2} |u'| \right| \leq ||s_{\mathcal{T}_n^{\div}} - \frac{\sigma^2}{2} h_{\mathcal{T}_n^{\div}} ||_{\infty}.
$$

Then we apply Theorem [5.2](#page-22-2) to $(\mathcal{T}_n^{\div})_n$ to get the desired result.

As a consequence of Proposition [5.11,](#page-29-2) [\(9\)](#page-17-1) and the fact that Rot preserves the lexicographical order, we get

$$
\frac{1}{\sqrt{n}} \left\| h_{\left(\text{Rot}\mathcal{T}_n \right)^{\circ}} - (1 + \frac{\sigma^2}{2}) h_{\mathcal{T}_n} \right\|_{\infty} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0. \tag{20}
$$

Let us stress that one has to use the convergence in distribution of $(h_{\mathcal{T}_n})_n$ towards a *continuous* function to get the above display with respect to $\|\cdot\|_{\infty}$, and a proof that does not involve d_{M_1} also requires the use of the modulus of continuity of this limit to control some perturbations induced by a change of time. Comparing processes with respect to d_{M_1} enables one to get rid of those considerations, but requires parametric representations.

Theorem [5.2](#page-22-2) combined with [\(20\)](#page-30-1) and Lemmas [5.5](#page-25-0) and [5.7](#page-25-2) (which can also be proved without d_{M_1} in this particular setting, with the technicalities mentioned above) lead to the joint convergence of $S_{\mathcal{T}_n}, H_{\mathcal{T}_n}, C_{\mathcal{T}_n}, H_{\text{Rot}}_{\mathcal{T}_n}, C_{\text{Rot}}_{\mathcal{T}_n}$. Since $S_{\text{Rot}}_{\mathcal{T}_n}$ is (almost) $C_{\mathcal{T}_n}$ we get Theorem [5.4](#page-24-0) in the case σ^2 < $+\infty$.

One can also prove Lemma [5.9](#page-28-3) without d_{M_1} in this particular case and thus get a proof of Theorem [5.10,](#page-29-0) case $\sigma^2 < +\infty$, that does not use d_{M_1} .

On possible generalizations. The approach used here is not restricted to Bienaymé trees. We essentially need a family of random trees $(T_n)_n$ such that we have a joint scaling limit for (s_{T_n}, h_{T_n}) _n and in addition

$$
\frac{\max H_{T_n} + \max S_{T_n} + 1}{\#T_n} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

To be precise, these assumptions are sufficient to study the joint behaviour of T_n and Tor T_n and get an analogue of Theorem [5.10.](#page-29-0) In the case of the rotation, we rather need that $(T_n^{\div})_n$ satisfies these assumptions to study $(\text{Rot }T_n)_n$ and we must additionally understand the joint behaviour of the Łukasiewicz walks of T_n and T_n^{\div} to get an analogue of Theorem [5.4.](#page-24-0) In this paper, we relied on T_n^{\div} for both the rotation and the co-rotation, hence we briefly sketch here how to study the joint behaviour of T_n and Tor T_n without any assumption on T_n^{\div} .

First, $(Tor T)^{\circ}$ and $T\setminus\{\emptyset\}$ are linked by an analogue of [\(9\)](#page-17-1) involving $R(u)$ instead of $L(u)$, thus in the very same way used to prove Theorem [5.4](#page-24-0) we may define a non-standard height sequence H_n^{**} for $(\text{Tor } T_n)^\circ$, based on the order corresponding to the lexicographical one of $T_n \setminus \{ \varnothing \}$, such that $H_n^{**} = S_{T_n} + H_{T_n}$. It implies a joint scaling limit for h_n^{**} and all encoding processes of T_n , without any consideration about T_n^{\div} . Moreover this order on $(Tor T_n)^{\circ}$ is the *left* equivalent of the rightmost order defined for $(\text{Rot } T_n)^\circ$, thus Lemma [5.6](#page-25-1) can be directly adapted to get that h_n^{**} and $c_{(\text{Tor}T_n)}$ are roughly the same. Lemmas [5.5](#page-25-0) and [5.9](#page-28-3) do not require any assumption about T_n^{\div} , the only part that must be adapted is the link between $(Tor T_n)^\circ$ and $Tor T_n$. Indeed, Lemma [5.7](#page-25-2) relies on the fact that Rot preserves the lexicographical order, but Tor only preserves the mirrored lexicographical order. However, since $\max H_{T_n^{\div}} = \max H_{T_n}$, we may apply Lemma [5.7](#page-25-2) (without modification) to T_n^{\div} , and thanks to [\(10\)](#page-18-1) and Lemma [5.5](#page-25-0) we get that $c_{(\text{Tor}T_n)^{\circ}}$ and $c_{\text{Tor}T_n}$ are roughly the same.

We may deduce, for instance, that the rotation acts as a dilation again on rotated BIENAYMÉ trees: when $\sigma^2 = +\infty$ we get

$$
d_{\mathrm{GH}}\left(\frac{1}{\ell(n)n^{1/\alpha}}\operatorname{Rot}^{\circ k}\mathcal{T}_n,\frac{k}{\ell(n)n^{1/\alpha}}\operatorname{Rot}\mathcal{T}_n\right)\xrightarrow[n\to+\infty]{(\mathbb{P})}0.
$$

6 From combinatorics to comparisons under M_1

In this section, we prove the several lemmas stating that some encoding processes, once rescaled, are close according to d_{M_1} . They all rely on the same method. We will first establish some combinatorial relations between those processes and then use this to build some convenient parametric representations that enable us to control the d_{M_1} distance between them. Sections [6.1](#page-31-0) and [6.4](#page-38-0) are the simplest illustrations of this method, while Sections [6.2](#page-33-0) and [6.3](#page-35-0) require some additional work.

 \Box

As the combinatorial relations will require manipulating different trees at the same time, we fix some notation: $u_0 = \emptyset, u_1, \ldots, u_{n-1}$ will always denote the lexicographical enumeration of \mathcal{T}_n while we will use $v_0 = \emptyset, v_1, \ldots, v_{2n-2}$ for the lexicographical enumeration of Rot \mathcal{T}_n . Thus $\widetilde{u}_1, \ldots, \widetilde{u}_{n-1}$ is the lexicographical enumeration of $(\text{Rot } \mathcal{T}_n)^\circ$.
We provide Table 3 to complete Table 1 with a recap of the

6.1 Lemma [5.5:](#page-25-0) height and contour processes are roughly the same

We prove here Lemma [5.5,](#page-25-0) which will illustrate our method to control the M_1 distance between several encoding functions.

Recall that Lemma [5.5](#page-25-0) translates the following general argument into the framework of Sko-ROKHOD's M_1 topology: for any sequence of trees $(T_n)_n$ such that $\#T_n \to +\infty$ and max H_{T_n} is negligible in front of $\#T_n$ as n goes to $+\infty$, and for any renormalization $(\lambda(n))_n$ such that $\lambda(n) \to 0$, the rescaled height process $\lambda(n)h_{T_n}$ is roughly the same as the rescaled contour process $\lambda(n)c_{T_n}$ when n is large.

Proof of Lemma [5.5.](#page-25-0) We fix $(\lambda(n))_n$ such that $\lambda(n) \to 0$. First, we state a simple combinatorial relation between these processes. For $0 \leq k \leq \#T_n$, let $j_n(k)$ be the time needed to reach v_k for the first time while following the contour of T_n at unit speed. By counting edges used twice or once we see that

for
$$
0 \le k < \#T_n
$$
, $j_n(k) = 2k - H_{T_n}(k)$. (21)

We also set $j_n(\#T_n) = 2\#T_n - 2$ the total time needed to perform the contour (note that j_n remains strictly increasing). By construction we have $C_{T_n}(j_n(k)) = H_{T_n}(k)$ for all $0 \leq k \leq \#T_n$, and the contour process C_{T_n} is easily described in between those times as depicted by Figure [14.](#page-32-0) More precisely, for $0 \le k \le \#T_n - 2$ either $H_{T_n}(k+1) = H_{T_n}(k) + 1$ or $H_{T_n}(k+1) \le H_{T_n}(k)$ and we have:

- In the first case, $j_n(k+1) = j_n(k)+1$ hence C_{T_n} is already fully described on $[[j_n(k), j_n(k+1)]]$.
- In the second case, $j_n(k+1) > j_n(k) + 1$ and C_{T_n} is affine on $[[j_n(k), j_n(k+1) 1]]$ with $C_{T_n}(i_n(k)) = H_{T_n}(k)$ and slope, 1. This entails that $C_{T_n}(i_n(k+1)) = H_{T_n}(k+1) 1$ $C_{T_n}(j_n(k)) = H_{T_n}(k)$ and slope -1. This entails that $C_{T_n}(j_n(k+1)-1) = H_{T_n}(k+1)-1$, so after this C_{T_n} makes one step +1 to satisfy $C_{T_n}(j_n(k+1)) = H_{T_n}(k+1)$.
- Finally, C_{T_n} is affine on $[\![j_n(\#T_n-1), j_n(\#T_n)]\!]$ with slope -1.

Based on this, we now introduce two parametric representations of h_{T_n} and c_{T_n} that can be compared easily. For c_{T_n} we simply take $(c_{T_n}, \text{Id}_{[0,1]})$. For h_{T_n} , we introduce two auxiliary sequences $(A_n(m))_{0 \le m \le 2 \# T_n - 2}$ and $(B_n(m))_{0 \le m \le 2 \# T_n - 2}$ by defining them on each interval $[j_n(k), j_n(k+1)]$:

• For $0 \le k \le \#T_n - 2$ such that $H_{T_n}(k+1) \ge H_{T_n}(k)$, A_n and B_n are affine on $[[j_n(k), j_n(k+1)]]$
with: with:

$$
A_n(j_n(k)) = H_{T_n}(k); \t B_n(j_n(k)) = \frac{k}{\#T_n};
$$

$$
A_n(j_n(k+1)) = H_{T_n}(k+1); \t B_n(j_n(k+1)) = \frac{k+1}{\#T_n}.
$$

• For $0 \le k \le \#T_n - 2$ such that $H_{T_n}(k+1) < H_{T_n}(k)$, A_n and B_n are affine on $[\![j_n(k), j_n(k+1) - 2]\!]$ with:

$$
A_n(j_n(k)) = H_{T_n}(k); \qquad B_n(j_n(k)) = \frac{k}{\#T_n};
$$

$$
A_n(j_n(k+1) - 2) = H_{T_n}(k+1); \qquad B_n(j_n(k+1) - 2) = \frac{k+1}{\#T_n};
$$

and A_n and B_n are constant on $\llbracket j_n(k+1) - 2, j_n(k+1) \rrbracket$.

• On $\left[j_n(\#T_n-1), j_n(\#T_n) \right]$, A_n and B_n are affine with:

$$
A_n(j_n(\#T_n - 1)) = H_{T_n}(\#T_n - 1); \qquad B_n(j_n(\#T_n - 1)) = \frac{\#T_n - 1}{\#T_n};
$$

$$
A_n(j_n(\#T_n)) = H_{T_n}(\#T_n) = 0; \qquad B_n(j_n(\#T_n)) = 1.
$$

By construction of A_n and B_n , their time-scaled functions a_n, b_n are such that (a_n, b_n) is a parametric representation of h_{T_n} (Figure [15](#page-32-1) illustrates the fact that a_n is a valid spatial component). Moreover, $A_n(m) \neq C_{T_n}(m)$ if and only if $m = j_n(k + 1) - 1$ for some $k \leq \#T_n - 2$ such that $j_n(k+1) > j_n(k) + 1$, and in this situation $A_n(m) = C_{T_n}(m) + 1$ (compare Figures [14](#page-32-0) and [15](#page-32-1) to see this). Thus $||a_n - c_{\mathcal{T}_n}||_{\infty} \leq 1$ and we get

$$
d_{M_1}(\lambda(n)h_{T_n}, \lambda(n)c_{T_n}) \leq \lambda(n) \vee ||\mathrm{Id}_{[0,1]} - b_n||_{\infty}.
$$

Now we control the temporal components thanks to the construction of B_n and [\(21\)](#page-31-2):

$$
\left\|\mathrm{Id}_{[0,1]}-b_n\right\|_{\infty} \leq \max_{1 \leq k \leq \#T_n-1} \left|\frac{k}{\#T_n}-\frac{j_n(k)}{2\#T_n-2}\right| \vee \left|\frac{k}{\#T_n}-\frac{j_n(k)-2}{2\#T_n-2}\right| \leq \frac{\max H_{T_n}+O(1)}{\#T_n}.
$$

By assumption, this last term goes to 0 with high probability as n goes to $+\infty$, so the result holds. \Box

6.2 Lemma [5.6](#page-25-1) and the rightmost enumeration

In this section, we turn to the study of the order on $(\text{Rot } \mathcal{T}_n)^\circ$ given by $\widetilde{w}_1, \ldots, \widetilde{w}_{n-1}$ that arises in the proof of Theorem 5.4. Our main goal is to establish Lamma 5.6 in order to extract information the proof of Theorem [5.4.](#page-24-0) Our main goal is to establish Lemma [5.6](#page-25-1) in order to extract information from the scaling limit of h_n^* .

As in the previous section, we start with some combinatorial relations between H_n^* and some encoding function of $(\text{Rot}\,\mathcal{T}_n)^\circ$. Unfortunately, the rotation does not preserve the mirrored order and we do not have any direct description of $H_{(\text{Rot}\mathcal{T}_n)^\circ}$ based on H_n^* . But we can still describe this new order given by $\widetilde{w}_1, \ldots, \widetilde{w}_{n-1}$ and use it to link H_n^* with the contour process of $(\text{Rot } \mathcal{T}_n)^\circ$.
More process to the process contour process of $(\text{Pot } \mathcal{T}_n)^\circ$ obtained by following More precisely, let $\widehat{C}_{(Rot\mathcal{T}_n)^{\circ}}$ be the *reversed contour process* of $(Rot\mathcal{T}_n)^{\circ}$, obtained by following its contour from right to left instead of left to right $(i.e. k \rightarrow C_{(\text{Rot}\mathcal{T}_n)^{\circ}}(2n-4-k)$ is its classical contour process). Lemma [6.1](#page-33-1) gives a full description of $\hat{C}_{(Rot\mathcal{T}_n)^{\circ}}$ based on H_n^* , illustrated by Figure [16.](#page-33-2)

Lemma 6.1. For all $0 \leq k \leq n$, set

$$
j_n(k) = \sum_{i=1}^k |H_n^*(i) - H_n^*(i-1)|.
$$

First, j_n is increasing from $j_n(0) = 0$ to $j_n(n) = 2n - 4$. Moreover, for all (k, m) such that $0 \leq k \leq n-1$ and $j_n(k) \leq m \leq j_n(k+1)$, we have

 $\widehat{C}_{(Rot\mathcal{T}_n)^{\circ}}(m) = H_n^*(k) + (m - j_n(k)) \operatorname{sign}(H_n^*(k+1) - H_n^*(k)).$

In particular $H_n^*(k) = \widehat{C}_{(Rot\mathcal{T}_n)^\circ}(j_n(k))$ for all $0 \le k \le n$.

To prove Lemma [5.6,](#page-25-1) we still have to control the change of time j_n introduced in Lemma [6.1](#page-33-1) to control the M_1 distance between h_n^* and $\hat{c}_{(Rot\mathcal{T}_n)^{\circ}}$. Lemma [6.2](#page-33-3) provides a more amenable expression for this change of time, based on further combinatorial considerations. for this change of time, based on further combinatorial considerations.

Lemma 6.2. For all $1 \leq k \leq n-1$, we have

$$
\sum_{i=1}^{k} |H_n^*(i) - H_n^*(i-1)| = 2k - 1 + S_{\mathcal{T}_n^{\div}}(k) - H_{\mathcal{T}_n^{\div}}(k).
$$

With Lemmas [6.1](#page-33-1) and [6.2,](#page-33-3) we are ready to prove the main result of this section, Lemma [5.6.](#page-25-1)

Proof of Lemma [5.6.](#page-25-1) We use the simple parametric representation $(h_n^*, \text{Id}_{[0,1]})$ for h_n^* . Recall the sequence $(j_n(k))_{0 \leq k \leq n}$ from Lemma [6.1](#page-33-1) and let $\phi_n \in C([0,1])$ be such that

$$
\phi_n\left(\frac{k}{n}\right) = \frac{j_n(k)}{2n-4} \text{ for } 0 \le k \le n \text{ and } \phi_n \text{ affine on each segment } \left[\frac{k}{n}, \frac{k+1}{n}\right].
$$

According to Lemma [6.1,](#page-33-1) ϕ_n is non-decreasing and onto, and $\hat{c}_{(RotT_n)^{\circ}}$ is affine on each segment $[j_n(k)/(2n-4), j_n(k+1)/(2n-4)]$ with $\hat{c}_{(\text{Rot}\mathcal{L}_n)^{\circ}}(j_n(k)/(2n-4)) = h_n^*(k/n)$ for $0 \le k \le n$, hence the (completed) graph of $\hat{c}_{(\text{Rot}\tau_n)^{\circ}}$ is the union of the segments in \mathbb{R}^2 linking $(h_n^*(k/n), j_n(k)/(2n-4))$
to $(h^*(k+1)/\mathbb{R})$, $(h+1)/(2n-4)$. Even though game of these generate mean be reduced to $(h_n^*((k+1)/n), j_n(k+1)/(2n-4))$. Even though some of these segments may be reduced to a single point, it entails that (h_n^*, ϕ_n) is a parametric representation of $\hat{c}_{(\text{Rot}\mathcal{T}_n)^{\circ}}$. For any real sequence $(\lambda(n))_n$, we can thus control $d_{M_1}(\lambda(n)\hat{c}_{(\text{Rot}\mathcal{T}_n)^{\circ}}, \lambda(n)h_n^*)$ by controlling the temporal
component ϕ as we have could spatial components. This hoils down to control is and in light of component ϕ_n , as we have equal spatial components. This boils down to control j_n and in light of Lemma [6.2](#page-33-3) we get

$$
d_{M_1}(\lambda(n)\widehat{c}_{(\mathrm{Rot}\mathcal{T}_n)^{\circ}}, \lambda(n)h_n^*) \leq ||\mathrm{Id}_{[0,1]} - \phi_n||_{\infty} \leq \max_{1 \leq k \leq n-1} \left|\frac{k}{n} - \frac{j_n(k)}{2n-4}\right|
$$

$$
\leq \frac{\max S_{\mathcal{T}_n^{\div}} + \max H_{\mathcal{T}_n^{\div}} + O(1)}{n}.
$$

Since $n^{1-1/\alpha}/\ell(n)$ and $\ell(n)n^{1/\alpha}$ are negligible in front of n, Theorem [5.1](#page-22-1) applied to $(\mathcal{T}_n^{\div})_n$ gives that the last term goes to 0 in probability as n goes to $+\infty$, so the result holds.

We now establish the combinatorial relations given by Lemmas [6.1](#page-33-1) and [6.2.](#page-33-3) Before giving any proof, let us introduce the adequate order on $(\text{Rot}\,\mathcal{T}_n)^\circ$. First, we equip the unary-binary tree $(\text{Rot } \mathcal{T}_n)^\circ$ with an additional structure inherited from its definition as a subtree of Rot \mathcal{T}_n : each edge will be either a *left edge* or a *right edge*. As seen in the geometric definition of Rot \mathcal{T}_n (see Figure [6\)](#page-17-0), $(\text{Rot } \mathcal{T}_n)^\circ$ is naturally equipped with such a structure. More explicitly, identify $(\text{Rot } \mathcal{T}_n)^\circ$ with the internal vertices of the (full) binary tree Rot \mathcal{T}_n and say that an edge is a *left edge* if it points towards a first child in Rot \mathcal{T}_n and a *right edge* if it points towards a second child.

We now define the *rightmost enumeration* r_1, \ldots, r_{n-1} of $(\text{Rot } \mathcal{T}_n)^\circ$ in a recursive way, with a particle following the reversed contour of $(\text{Rot }\mathcal{T}_n)^\circ$ (see Figure [17\)](#page-34-0):

- Step 1: The particle starts at the root and travels every right edge it encounters (but no left edge). The last vertex reached is r_1 .
- • Step k + 1 (where $k \leq n-2$): Suppose that we have defined r_i for all $i \leq k$ using the particle which now sits at r_k . If r_k has a left child, then the particle goes through this left edge then travels every right edge it encounters (but no more left edge), and the last vertex reached is r_{k+1} . Otherwise, the particle goes back up the ancestral line of r_k until it finds a vertex that does not belong to $\{r_1, \ldots, r_k\}$, and this vertex becomes r_{k+1} .

Figure 17: The rightmost enumeration of the internal subtree from Figure [6.](#page-17-0) The dashed arrows indicate the several steps for the particle used in the definition, and the dotted one is the additional step needed to complete the reversed contour.

One can prove, by induction on the height of the tree, that the particle indeed follows the reversed contour of $(\text{Rot } \mathcal{T}_n)^\circ$ when those steps are realized (with an additional step to come back

to the root) as depicted in Figure [17.](#page-34-0) The same induction could prove that r_1, \ldots, r_{n-1} truly is an enumeration of $(Rot T_n)[°]$, but this fact also follows from our main observation:

Lemma 6.3. For all $1 \leq i \leq n-1$, $\widetilde{w}_i = r_i$.

Proof. Lemma [6.3](#page-35-1) can be proved by induction on i. Indeed, when one applies $u \mapsto \tilde{u}$, "go from w_i to its last child (if there is any)" translates into "starting from \tilde{w}_i , go through its left edge (if
there is any) then cross overy right edge onecuntered (but no more left edge)" in the retated troe there is any) then cross every right edge encountered (but no more left edge)" in the rotated tree while "go from w_i to its closest elder sibling if it exists, else go to its parent" translates into "go from \tilde{w}_i to its parent". Formal details are left to the reader. \Box

We can now use this link between the rightmost enumeration of $(\text{Rot }\mathcal{T}_n)^\circ$ and its reversed contour process $C_{(Rot\mathcal{T}_n)^{\circ}}$ to prove Lemma [6.1.](#page-33-1)

Proof of Lemma [6.1.](#page-33-1) Let $x_0 = \emptyset, x_1, \ldots, x_{2n-4} = \emptyset$ be the sequence of adjacent vertices obtained by following the reversed contour. In the definition of the rightmost enumeration, for all $1 \leq k \leq$ $n-1$ the particle either goes straight up or straight down at step k, hence it crosses $||r_k| - |r_{k-1}||$ edges during this step (with $r_0 = \emptyset$ to include the case $k = 1$). Consider that each edge is split into two directed edges (one upward and one downward). By the previous Lemma [6.3,](#page-35-1) $j_n(k)$ simply is the number of directed edges crossed by the particle after performing Steps 1 to k. Since the particle follows the reversed contour, we get that $r_k = x_{j_n(k)}$ hence $H_n^*(k) = \hat{C}_{(Rot \mathcal{T}_n)^{\circ}}(j_n(k))$ for all $1 \leq k \leq n-1$. This also holds for $k = 0$ as $j_n(0) = 0$. By considering the additional step that goes from r_{n-1} to \emptyset , the particle crosses $|r_{n-1}| = |H_n^*(n) - H_n^*(n-1)|$ edges to complete the contour thus $j_n(n)$ is indeed $2n-4$ *i.e.* the total number of edges crossed by the particle and $H_n^*(n) = 0 = \hat{C}_{(Rot\mathcal{T}_n) \circ}(j_n(n))$. The proposed expression for $\hat{C}_{(Rot\mathcal{T}_n) \circ}(m)$ follows from the observation that $C_{(Rot\mathcal{T}_n)}$ is monotone on each interval $[\![j_n(k), j_n(k+1)]\!]$ (because it corresponds
to $Sten (k+1)$ and on this interval it goes from $H^*(k)$ to $H^*(k+1)$ with increments of constant to Step $k + 1$, and on this interval it goes from $H_n^*(k)$ to $H_n^*(k+1)$ with increments of constant absolute size 1. Note that this holds even if $[j_n(k), j_n(k+1)]$ is degenerate *i.e.* $j_n(k) = j_n(k+1)$, since this happens if and only if $H_n^*(k+1) = H_n^*(k)$ (and it may only happen for $k = 0$ or $k = n - 1$. \Box

A refinement of the same argument, based on counting the number of edges crossed in the upward direction by two different means, also yields Lemma [6.2:](#page-33-3)

Proof of Lemma [6.2.](#page-33-3) As explained above, $j_n(k) = \sum_{i=1}^k |H_n^*(i) - H_n^*(i-1)|$ is the number of directed edges crossed by the particle after $Steps 1$ to k of the construction of the rightmost enumeration of $(\text{Rot}\,\mathcal{T}_n)^\circ$. Let us focus on the edges crossed in the upward direction (*i.e.* in the direction going away from the root). Since the particle either goes straight up or straight down at each step, the number of edges crossed in the upward direction after step k is $\sum_{i=1}^{k} (H_n^*(i) - H_n^*(i -$ 1) $_{+}$. However we also notice that at step $k + 1$ with $k \ge 1$, the particle goes up if and only if its initial vertex $r_k = \tilde{w}_k$ has a left child, which is equivalent to $d_{w_k}(\mathcal{T}_n) = S_{\mathcal{T}_n^{\pm}}(k+1) - S_{\mathcal{T}_n^{\pm}}(k) + 1 \geq 1$, and then it crosses 1 left edge and $S_{\mathcal{T}_n^+}(k+1) - S_{\mathcal{T}_n^+}(k)$ right edges. At the first step, the particle just crosses $S_{\mathcal{T}_n^{-1}}(1)$ right edges. When the particle goes straight down, it still crosses $0 = S_{\mathcal{T}_n^{\pm}}(k+1) - S_{\mathcal{T}_n^{\pm}}(\tilde{k}) + 1$ edges in the upward direction, hence we get the following for $k \ge 1$

$$
\sum_{i=1}^{k} (H_n^*(i) - H_n^*(i-1))_+ = k + S_{\mathcal{T}_n^{\div}}(k) - 1.
$$

We can now derive our simpler expression for $j_n(k)$ for $1 \leq k \leq n-1$ thanks to [\(15\)](#page-26-5):

$$
\sum_{i=1}^{k} |H_n^*(i) - H_n^*(i-1)| = 2 \sum_{i=1}^{k} (H_n^*(i) - H_n^*(i-1))_+ - H_n^*(k)
$$

= 2k - 1 + S _{\mathcal{T}_n^{\div}} (k) - H _{\mathcal{T}_n^{\div}} (k).

6.3 Lemma [5.7:](#page-25-2) adding the leaves

The purpose of this section is to prove Lemma [5.7,](#page-25-2) which states that the height processes of Rot \mathcal{T}_n and $(\text{Rot } \mathcal{T}_n)^\circ$, once rescaled, are also roughly the same. As before, we first need a combinatorial lemma to relate these processes, illustrated by Figure [18.](#page-36-0)

Lemma 6.4. For all $0 \le k \le n-1$, set $j_n(k) = 2k - H_{\mathcal{T}_n}(k+1) + 1$. It is strictly increasing from $j_n(0) = 0$ to $j_n(n-1) = 2n-1$, and for all $0 \le k \le n-2$, $H_{\text{Rot}}\tau_n$ satisfies on $[\![j_n(k), j_n(k+1)]\!]$.

•When $j_n(k + 1) = j_n(k) + 1$: $H_{\text{Rot}}\mathcal{T}_n(j_n(k)) = H_{(\text{Rot}}\mathcal{T}_n) \circ (k) \text{ and } H_{\text{Rot}}\mathcal{T}_n(j_n(k) + 1) = H_{(\text{Rot}}\mathcal{T}_n) \circ (k + 1);$ •When $i_n(k+1) = i_n(k) + 2$: $H_{\text{Rot}}\mathcal{T}_n(j_n(k)) = H_{(\text{Rot}}\mathcal{T}_n) \circ (k) \text{ and } H_{\text{Rot}}\mathcal{T}_n(j_n(k) + 1) = H_{\text{Rot}}\mathcal{T}_n(j_n(k) + 2) = H_{(\text{Rot}}\mathcal{T}_n) \circ (k+1);$ •When $j_n(k+1) > j_n(k) + 2$:

 $H_{\mathrm{Rot}}\tau_n(j_n(k)) = H_{(\mathrm{Rot}\tau_n) \circ}(k), \ H_{\mathrm{Rot}\tau_n}(j_n(k) + 1) = H_{\mathrm{Rot}\tau_n}(j_n(k) + 2) = H_{(\mathrm{Rot}\tau_n) \circ}(k) + 1,$ then $H_{\text{Rot}}\tau_n$ strictly decreases on $\llbracket j_n(k) + 2, j_n(k+1) \rrbracket$ with $H_{\text{Rot}}\tau_n(j_n(k+1)) = H_{(\text{Rot}}\tau_n) \circ (k+1)$.

Figure 18: Description of $H_{\text{Rot}}\tau_n$ (on the right) based on $H_{(\text{Rot}\tau_n)^{\circ}}$ (on the left) and the times $(j_n(k), 0 \le k \le n-1)$, in the particular case of the tree from Figure [6.](#page-17-0) Several parts of the two processes have been identified by matching colours to illustrate the case $j_n(k+1) = j_n(k) + 1$ (green part), the case $j_n(k+1) = j_n(k) + 2$ (magenta part) and finally the case $j_n(k+1) > j_n(k) + 2$ (orange part).

Proof. Recall from Section [4](#page-16-0) that $u \mapsto \tilde{u}$ preserves the lexicographical order and that we have the following property for the leaves in Rot \mathcal{T}_n : a vertex is a left leaf in Rot \mathcal{T}_n if and only if its parent is \tilde{u} for u a leaf in \mathcal{T}_n , while it is a right leaf if and only if its parent is \tilde{u} for u in \mathcal{T}_n which is the last child of its own parent. We now prove that

For
$$
0 \le k \le n - 2, \widetilde{u}_{1+k} = v_{j_n(k)},
$$
\n
$$
(22)
$$

by analysing the number of leaves in Rot \mathcal{T}_n between two consecutive internal vertices, say \widetilde{u}_m and \widetilde{u}_{m+1} :

- When $H_{\mathcal{T}_n}(m+1) = H_{\mathcal{T}_n}(m) + 1$, u_{m+1} is the first child of u_m in \mathcal{T}_n , so \widetilde{u}_{m+1} is also the first child of \widetilde{u}_m in Ret \mathcal{T}_n and there is no leaf in between first child of \tilde{u}_m in Rot \mathcal{T}_n and there is no leaf in between.
- When $H_{\mathcal{T}_n}(m+1) \leq H_{\mathcal{T}_n}(m)$, u_m is a leaf and there are $H_{\mathcal{T}_n}(m) H_{\mathcal{T}_n}(m+1)$ last children among u_m and its ancestors that are not ancestors of u_{m+1} , so there is one left leaf and then $H_{\mathcal{T}_n}(m) - H_{\mathcal{T}_n}(m+1)$ right leaves between \tilde{u}_m and \tilde{u}_{m+1} .

As a consequence, there are always $1 + H_{\mathcal{T}_n}(m) - H_{\mathcal{T}_n}(m+1) \geq 0$ leaves between \widetilde{u}_m and \widetilde{u}_{m+1} .
Co $\widetilde{u}_n = u_0 = u_0$ and for all $0 \leq k \leq n-2$ is $(k+1) = i$, $(k) = 2 + H_{\mathcal{T}_n}(k+1) - H_{\mathcal{T}_n}(k+2)$. Since $\widetilde{u}_1 = v_0 = v_{j_n(0)}$ and for all $0 \le k \le n-2$, $j_n(k+1) - j_n(k) = 2 + H_{\mathcal{T}_n}(k+1) - H_{\mathcal{T}_n}(k+2)$,
i. is strictly increasing and (22) holds. This article that $H_{\mathcal{T}_n}(k)$, $H_{\mathcal{T}_n}(k)$ for these j_n is strictly increasing and [\(22\)](#page-36-1) holds. This entails that $H_{\text{Rot}}\tau_n(j_n(k)) = H_{(\text{Rot}\tau_n)^{\circ}}(k)$ for those k, and it also holds for $k = n - 1$.

Moreover, $j_n(k+1) = j_n(k) + 2$ if and only if $H_{\mathcal{T}_n}(k+1) = H_{\mathcal{T}_n}(k+2)$, which means that in this situation the left child of \tilde{u}_{1+k} is a leaf while its right child is \tilde{u}_{2+k} . In particular we have $H_{\text{Rot}}\tau_n(j_n(k) + 1) = H_{\text{Rot}}\tau_n(j_n(k) + 2) = H_{(\text{Rot}}\tau_n) \circ (k+1).$

Finally, $j_n(k+1) > j_n(k) + 2$ if and only if $H_{\mathcal{T}_n}(k+1) > H_{\mathcal{T}_n}(k+2)$. In this case, both children of \tilde{u}_{1+k} are leaves, hence $H_{\text{Rot}}\tau_n(j_n(k) + 1) = H_{\text{Rot}}\tau_n(j_n(k) + 2) = H_{(\text{Rot}}\tau_n) \circ (k) + 1$, and \tilde{u}_{2+k}
must be the right child of an appearance of \tilde{u}_{k+1} (except in the case $k = n-2$ where \tilde{u}_{k+1} is the must be the right child of an ancestor of \tilde{u}_{1+k} (except in the case $k = n-2$ where \tilde{u}_{1+k} is the last internal vertex). The $H_{\mathcal{T}_n}(k+1) - H_{\mathcal{T}_n}(k+2) - 1$ remaining right leaves must be grafted on vertices among {ancestors of $\tilde{u}_{1+k}\}\$ {ancestors of \tilde{u}_{2+k} } (or simply among {ancestors of \tilde{u}_{1+k} } in the special case $k = n - 2$, so they have distinct height and since they are consecutive leaves

the lexicographical order sort them in decreasing order for their height. In addition, in the case $k < n-2$, \tilde{u}_{2+k} is the right child of a vertex $v \in \{\text{ancestors of } \tilde{u}_{1+k}\}\$ while those leaves have the left child of v as an ancestor, hence their height must be larger than $|v| + 1 = H_{(Rot\mathcal{T}_n)^{\circ}}(k+1)$. This is also satisfied for $k = n - 2$ as $H_{(\text{Rot}\mathcal{T}_n)^\circ}(k+1) = 0$ in this situation. \Box

We now prove Lemma [5.7](#page-25-2) with the usual method: we build closely related parametric representations based on the combinatorial description given by Lemma [6.4.](#page-36-2)

Proof of Lemma [5.7.](#page-25-2) Fix a sequence $(\lambda(n))_n$ such that $\lambda(n) \to 0$. First, recall the sequence j_n of Lemma [6.4](#page-36-2) and for simplicity let $g_n(k) = j_n(k)/(2n-1)$. We work with the parametric representation $(h_{\text{Rot}}\tau_n, \text{Id}_{[0,1]})$ for $h_{\text{Rot}}\tau_n$, and we build a piecewise affine parametric representation (χ_n, τ_n) for $h_{(\text{Rot}\mathcal{T}_n)^\circ}$. More precisely, on each segment $[g_n(k), g_n(k+1)]$:

• For k such that $j_n(k+1) = j_n(k) + 1$, (χ_n, τ_n) is affine on $[g_n(k), g_n(k+1)]$ with

$$
\chi_n(g_n(k)) = H_{(\text{Rot}\mathcal{T}_n)^{\circ}}(k); \qquad \tau_n(g_n(k)) = \frac{k}{n-1};
$$

$$
\chi_n(g_n(k+1)) = H_{(\text{Rot}\mathcal{T}_n)^{\circ}}(k+1); \qquad \tau_n(g_n(k+1)) = \frac{k+1}{n-1}.
$$

• For k such that $j_n(k+1) = j_n(k) + 2$, (χ_n, τ_n) is affine on $[g_n(k), (j_n(k) + 1)/(2n-1)]$ with

$$
\chi_n(g_n(k)) = H_{(\text{Rot}\mathcal{T}_n)^{\circ}}(k); \qquad \tau_n(g_n(k)) = \frac{k}{n-1};
$$

$$
\chi_n\left(\frac{j_n(k)+1}{2n-1}\right) = H_{(\text{Rot}\mathcal{T}_n)^{\circ}}(k+1); \qquad \tau_n\left(\frac{j_n(k)+1}{2n-1}\right) = \frac{k+1}{n-1},
$$

and (χ_n, τ_n) is constant on $[(j_n(k) + 1)/(2n - 1), g_n(k + 1)].$

• For k such that $j_n(k+1) > j_n(k) + 2$, let $t^* \in (g_n(k), g_n(k+1))$ be the unique solution of $h_{\text{Rot}}\tau_n(t^*) = H_{(\text{Rot}}\tau_n) \circ (k), (\chi_n, \tau_n)$ is constant on $[g_n(k), t^*]$ with

$$
\chi_n\big(g_n(k)\big) = H_{(\text{Rot}\mathcal{T}_n)^\circ}(k); \qquad \qquad \tau_n\big(g_n(k)\big) = \frac{k}{n-1}.
$$

Now observe that $h_{\text{Rot}}\tau_n$ induces a decreasing one-to-one map from $[t^*, g_n(k+1)]$ to $[H_{(\text{Rot}}\tau_n) \circ (k+1)]$ 1), $H_{(\text{Rot}\mathcal{T}_n)^\circ}(k)$. On $[t^*, g_n(k+1)], (\chi_n, \tau_n)$ is given by:

$$
\chi_n(t) = h_{\text{Rot}} \tau_n(t); \qquad \tau_n(t) = \frac{k}{n-1} + \frac{1}{n-1} \frac{H_{(\text{Rot}\mathcal{T}_n)^{\circ}}(k) - h_{\text{Rot}\mathcal{T}_n}(t)}{H_{(\text{Rot}\mathcal{T}_n)^{\circ}}(k) - H_{(\text{Rot}\mathcal{T}_n)^{\circ}}(k+1)}.
$$

Clearly, τ_n is continuous non-decreasing and one can check that $\chi_n = h_{(Rot\mathcal{T}_n) \circ \mathcal{T}_n}$ on each segment $[g_n(k), g_n(k+1)]$, hence (χ_n, τ_n) is a parametric representation of $h_{(\text{Rot}\mathcal{T}_n)^\circ}$. Moreover, in light of Lemma [6.4](#page-36-2) we see that χ_n and $h_{\text{Rot}}\tau_n$ may only differ on intervals of the form $(g_n(k), t^*)$. Consequently $\|\chi_n - h_{\text{Rot}}\tau_n\|_{\infty} \leq 1$ and we get

$$
d_{M_1}(\lambda_n h_{(\mathrm{Rot}\mathcal{T}_n)^\circ}, \lambda(n)h_{\mathrm{Rot}\mathcal{T}_n}) \leq \lambda(n) \vee ||\mathcal{T}_n - \mathrm{Id}_{[0,1]}||_{\infty}.
$$

But on each segment $[g_n(k), g_n(k+1)]$ we have

$$
|\tau_n(t)-t|\leq \frac{1}{n-1}+|\frac{j_n(k)}{2n-1}-\frac{k}{n-1}|\vee|\frac{j_n(k+1)}{2n-1}-\frac{k}{n-1}|.
$$

We can thus control the temporal component thanks to the expression of j_n given in Lemma [6.4.](#page-36-2)

$$
\left\|\mathrm{Id}_{[0,1]} - \tau_n\right\|_{\infty} \le \max_{1 \le k \le n-2} \left|\frac{k}{n-1} - \frac{j_n(k)}{2n-1}\right| + O\left(\frac{1}{n}\right) \le \frac{\max H_{\mathcal{T}_n} + O(1)}{n}.
$$

By Theorem [5.1,](#page-22-1) this last term goes to 0 as n goes to $+\infty$, so the result is proved.

 \Box

6.4 Lemma [5.9:](#page-28-3) the ŁUKASIEWICZ path of Tor \mathcal{T}_n

We deal in this section with the last combinatorial lemma, Lemma [5.9,](#page-28-3) which compares $S_{\mathcal{T}_n}$ and $S_{\text{Tor}} \tau_n$. The same method applies without difficulty, we first give a combinatorial relation between these processes (illustrated by Figure [19\)](#page-38-1) and then translate it into the desired control for the M_1 distance between them.

Lemma 6.5. For all $0 \leq k \leq n$, set $j_n(k) = 2k + S_{\mathcal{T}_n}(k)$. Then j_n is strictly increasing from $j_n(0) = 0$ to $j_n(n) = 2n - 1$, and for all $0 \le k \le n - 1$, $S_{\text{Tor}} \tau_n$ satisfies on $[[j_n(k), j_n(k+1)]]$:

• if $j_n(k+1) = j_n(k) + 1$,

$$
S_{\text{Tor}} \tau_n(j_n(k)) = S_{\mathcal{T}_n}(k) \quad \text{and} \quad S_{\text{Tor}} \tau_n(j_n(k+1)) = S_{\mathcal{T}_n}(k+1);
$$

• else, $S_{\text{Tor}} \tau_n$ is affine on $[\![j_n(k), j_n(k+1) - 1]\!]$ with

$$
S_{\text{Tor}} \tau_n(j_n(k)) = S_{\mathcal{T}_n}(k) \text{ and } S_{\text{Tor}} \tau_n(j_n(k+1)-1) = S_{\mathcal{T}_n}(k+1)+1,
$$

and then $S_{\text{Tor}} \mathcal{T}_n(j_n(k+1)) = S_{\mathcal{T}_n}(k+1)$.

Figure 19: Description of $S_{\text{Tor}}\tau_n$ (on the right) based on S_{τ_n} (on the left) and the times $(j_n(k), 0 \le k \le n)$, where \mathcal{T}_n is the tree from Figure [3.](#page-5-1) Several parts of the two processes have been identified by matching colours to illustrate the case $j_n(k+1) = j_n(k) + 1$ (yellow part) and the case $j_n(k+1) \geq j_n(k) + 2$ (green and blue parts)

Proof. We prove this lemma for every finite plane tree T, instead of \mathcal{T}_n . We thus consider $j_T(k)$ = $2k + S_T(k)$ for $0 \leq k \leq \#T$.

We argue by induction on the height of T. First, for $T = \{ \emptyset \}$, both processes are just one step down and the result is valid. Next, consider T a non-trivial tree and let T_1, \ldots, T_p denote the $p \geq 1$ subtrees grafted on the root of T. Notice that by construction of the ŁUKASIEWICZ walk,

$$
S_T = (0, p-1) \boxplus (p-1+S_{T_1}) \boxplus (p-2+S_{T_2}) \boxplus \ldots \boxplus S_{T_p},
$$

where \boxplus means concatenation with fusion i.e. $(x_1, \ldots, x_m, a) \boxplus (a, y_1, \ldots, y_q) = (x_1, \ldots, x_m, a, y_1, \ldots, y_q).$ Since $j_T(k) = \sum_{i=1}^{k} 2 + S_T(i) - S_T(i-1)$, it implies that

$$
j_T = (0, p + 1) \boxplus (p + 1 + j_{T_1}) \boxplus (p + 2 \# T_1 + j_{T_2}) \boxplus \dots \boxplus (2 + 2 \# T_1 + \dots + 2 \# T_{p-1} + j_{T_p}).
$$

Finally, by mean of the recursive definition of Tor T (Figure [7\)](#page-18-0) we also have

$$
S_{\text{Tor }T} = (0,1,2,\ldots,p-2,p-1,p,p-1) \boxplus (p-1+S_{\text{Tor}(T_1)}) \boxplus (p-2+S_{\text{Tor}(T_2)}) \boxplus \ldots \boxplus S_{\text{Tor}(T_p)}.
$$

As a consequence, $S_{\text{Tor}T}$ satisfies the lemma on $\llbracket j_T(0), j_T(1) \rrbracket = \llbracket 0, p + 1 \rrbracket$, and it also satisfies the lemma on the next segments since by the induction hypothesis $S_{\text{Tor }T_1}, \ldots, S_{\text{Tor }T_p}$ already fully satisfy the lemma. \Box

Thanks to this relation, we can easily mimic Section [6.1](#page-31-0) and introduce some convenient parametric representations of $s_{\mathcal{T}_n}$ and $s_{\text{Tor}}_{\mathcal{T}_n}$ to prove Lemma [5.9.](#page-28-3)

Proof of Lemma [5.9.](#page-28-3) We fix $(\lambda(n))_n$ such that $\lambda(n) \to 0$.

We simply take $(s_{\text{Tor}} \tau_n, \text{Id}_{[0,1]})$ as a parametric representation of $s_{\text{Tor}} \tau_n$, and we introduce two auxiliary sequences $(A_n(m))_{0 \le m \le 2n-1}$ (depicted in Figure [20\)](#page-39-0) and $(B_n(m))_{0 \le m \le 2n-1}$ to define a parametric representation of $s_{\mathcal{T}_n}$.

Recall the change of time j_n introduced in Lemma [6.5.](#page-38-2) On each interval $[\![j_n(k), j_n(k+1)]\!]$,

• When $j_n(k+1) \leq j_n(k) + 2$, A_n and B_n are affine on $[\![j_n(k), j_n(k+1)]\!]$ with:

$$
A_n(j_n(k)) = S_{T_n}(k); \qquad B_n(j_n(k)) = \frac{k}{n};
$$

\n
$$
A_n(j_n(k+1)) = S_{T_n}(k+1); \qquad B_n(j_n(k+1)) = \frac{k+1}{n}.
$$

• When $j_n(k+1) > j_n(k) + 2$, A_n and B_n are affine on $[j_n(k), j_n(k+1) - 2]$ with:

$$
A_n(j_n(k)) = S_{T_n}(k); \qquad B_n(j_n(k)) = \frac{k}{n};
$$

\n
$$
A_n(j_n(k+1) - 2) = S_{T_n}(k+1); \qquad B_n(j_n(k+1) - 2) = \frac{k+1}{n};
$$

and then A_n and B_n are constant on $\llbracket j_n(k+1) - 2, j_n(k+1) \rrbracket$.

By construction, their time-scaled functions (a_n, b_n) form a parametric representation of $s_{\mathcal{T}_n}$. Moreover, it is clear from Lemma [6.5](#page-38-2) that $||a_n - s_{\text{Tor}} \tau_n||_{\infty} \leq 1$ (compare Figures [19](#page-38-1) and [20](#page-39-0) to see this). Thus we get

$$
d_{M_1}(\lambda(n)s_{\text{Tor}}\tau_n, \lambda(n)s_{\tau_n}) \leq \lambda(n) \vee ||\text{Id}_{[0,1]} - b_n||_{\infty}.
$$

Now we control the temporal components thanks to the construction of B_n and Lemma [6.5:](#page-38-2)

$$
\left\|\mathrm{Id}_{[0,1]} - b_n\right\|_{\infty} \le \max_{1 \le k \le n-1} \left|\frac{k}{n} - \frac{j_n(k)}{2n-1}\right| \vee \left|\frac{k}{n} - \frac{j_n(k)-2}{2n-1}\right| \le \frac{\max S_{\mathcal{T}_n} + O(1)}{n}.
$$

By Theorem [5.1,](#page-22-1) this last term goes to 0 with high probability as n goes to $+\infty$, so the result holds. \Box

Remark. We have chosen to state Lemma [5.9](#page-28-3) with \mathcal{T}_n but it actually holds for every sequence of random trees $(T_n)_n$ such that

$$
\#T_n \xrightarrow[n \to +\infty]{(\mathbb{P})} +\infty \text{ and } \frac{\max S_{T_n}}{\#T_n} \xrightarrow[n \to +\infty]{(\mathbb{P})} 0.
$$

A The Łukasiewicz walk and the mirror transformation

In this appendix, we give the full details of the joint convergence stated in Proposition [5.3.](#page-23-1) It is a simple consequence of Theorem [5.1](#page-22-1) in the special case $\alpha = 2$, but additional arguments are needed when $\alpha < 2$. Indeed, in the case $\alpha = 2$ we have that all encoding processes of \mathcal{T}_n converge towards the same Brownian excursion, and the same is true for \mathcal{T}_n^{\div} . Since the contour process behaves nicely when we apply the mirror transformation, we easily get a joint convergence result for $(\ell(n)/\sqrt{n} \times (c_{\mathcal{T}_n}, c_{\mathcal{T}_n^+}))_n$ and then deduce the desired result. When $\alpha < 2$, the ŁUKASIEWICZ walks and contour processes no longer converge towards the same excursion and we must study the Łukasiewicz walks on their own. The comparison of these two Łukasiewicz walks will require keeping track of their jumps in a precise way, which can be done thanks to some specific properties of the SKOROKHOD's J_1 topology, hence we state the next result with this topology.

Proposition A.1. Let \mathcal{T}_n be distributed as $BGW_\mu(\cdot | \# \text{vertices} = n)$ where the offspring distribution μ is critical. Assuming that μ is attracted to a stable distribution of index $\alpha \in (1,2]$, there is a measurable function $F^{\div}: D([0,1]) \to D([0,1])$ such that

$$
\frac{1}{\ell(n)n^{1/\alpha}} \big(S_{\mathcal{T}_n}(\lfloor nt \rfloor), S_{\mathcal{T}_n^{\div}}(\lfloor nt \rfloor)\big)_{t \in [0,1]} \xrightarrow[n \to +\infty]{(d)} \big(\mathbf{x}, F^{\div}(\mathbf{x})\big)
$$

with respect to SKOROKHOD's J_1 topology.

Note that it implies a similar result for the weaker M_1 topology and the corresponding continuous time-scaled function $s_{\mathcal{T}_n}$ and $s_{\mathcal{T}_n}$. Moreover, as we still have that the height process is asymptotically the same as the contour process and this last process behaves nicely when we apply the mirror transformation, we eventually get Proposition [5.3](#page-23-1) as a consequence of Proposition [A.1.](#page-40-0)

Proof of Proposition [5.3.](#page-23-1) We apply Theorem [5.1](#page-22-1) to $(\mathcal{T}_n)_n$ and $(\mathcal{T}_n^+)_n$ to immediately get tightness of the sequence

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n}, \frac{\ell(n)}{n^{1-1/\alpha}}h_{\mathcal{T}_n}, \frac{1}{\ell(n)n^{1/\alpha}}s_{\mathcal{T}_n^{\pm}}, \frac{\ell(n)}{n^{1-1/\alpha}}h_{\mathcal{T}_n^{\pm}}\right)_n.
$$

Now, let (x_1, x_2, x_3, x_4) denote a subsequential distributional limit. By Proposition [A.1,](#page-40-0) (x_1, x_3) has the law of $(\mathbf{x}, F^{\div}(\mathbf{x}))$ hence $x_3 = F^{\div}(x_1)$ almost surely. In the same way, Theorem [5.1](#page-22-1) gives that (x_1, x_2, x_4) has the law of $(\mathbf{x}, \mathbf{h}, \mathbf{h})$. As there is a measurable function $G : D([0, 1]) \to D([0, 1])$ such that $h = G(x)$ a.s. we must have $x_2 = G(x_1)$ and $x_4 = \hat{x}_2$ almost surely. Since x_1 is distributed as x, we can conclude that (x_1, x_2, x_3, x_4) is distributed as $(x, h, F^{\div}(x), \hat{h})$ and by uniqueness of the limiting distribution we get the desired convergence. \Box

Let us now discuss the proof of Proposition [A.1](#page-40-0) in the case $\alpha < 2$. By Theorem [5.1](#page-22-1) (actually we use its version with respect to the J_1 topology, see e.g. [\[Mar20,](#page-44-1) Equation 1] for a precise statement), the sequence at stake is tight and it is enough to study the uniqueness in distribution of its subsequential limits. Based on the relation of the two Łukasiewicz walks in the discrete setting and properties of the J_1 topology, a subsequential limit is a pair of discontinuous functions with some constraints on their discontinuities. To make this formal, for $x \in D([0,1])$ we set $\Delta x(t) = x(t) - x(t-), \text{Disc}(x) = \{t \in [0,1] \text{ such that } x(t-) \neq x(t)\}\)$ and $Disc_{\varepsilon}(x) = \{t \in [0, 1] \text{ such that } |\Delta x(t)| > \varepsilon\}.$ We have the following lemma.

Lemma A.2. Let (X, Y) be a subsequential limit in distribution (with respect to J_1) of

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}\big(S_{\mathcal{T}_n}(\lfloor nt \rfloor),S_{\mathcal{T}_n^{\div}}(\lfloor nt \rfloor)\big)_{t\in[0,1]}\right)_n.
$$

For all $s \le t \in [0,1]$, let $e(t) = \inf\{t' \ge t : X_{t'} < X_{t-}\}\$ (with $\inf \emptyset = 1$) and $I_{s,t} = \inf_{[s,t]} X$. Finally, introduce $(W_t)_{t\in[0,1]}$ such that

$$
W_t = \sum_{0 \le s < t: X_{s-} < I_{s,t}} X_s - I_{s,t},
$$

where the sum is countable since $(X_s - I_{s,t}) \mathbb{1}_{X_{s-} \leq I_{s,t}} = 0$ for $s \notin \text{Disc}(X)$. Note that W, simply seen as a collection of positive variables, is measurable with respect to X.

Then almost surely:

• $Disc(X)$ and $Disc(Y)$ are dense in [0, 1];

- Disc(Y) = {1 e(t), $\forall t \in \text{Disc}(X)$ } and $\forall t \in \text{Disc}(X)$, $\Delta Y_{1-e(t)} = \Delta X_t$;
- $\forall t \in [0,1] \cap \mathbb{Q}, Y_{1-t} = W_t.$

Proof. First we know by Theorem [5.1](#page-22-1) that both X and Y are distributed as an excursion of an α stable Lévy process hence we have that $Disc(X)$ and $Disc(Y)$ are dense in [0, 1] almost surely (see [\[Kor14,](#page-44-10) Proposition 2.10]). The other assertions are inherited from relations between the discrete processes $S_{\mathcal{T}_n}$ and $S_{\mathcal{T}_n}$ that we describe now.

Consider u_0, \ldots, u_{n-1} the lexicographical enumeration of \mathcal{T}_n as well as w_0, \ldots, w_{n-1} its mirrored enumeration. For $0 \le k < n$, set $E_n(k) = \min\{m \ge k : S_{\mathcal{T}_n}(m) < S_{\mathcal{T}_n}(k)\}\)$, so that $E_n(k) - k$ is the size of the subtree of descendants of u_k in \mathcal{T}_n . The set of vertices that are greater than or equal to u_k for the mirrored lexicographical order contains those descendants as well as the $k - H_{\mathcal{T}_n}(k)$ vertices with an ancestor which is a younger sibling of an ancestor of u_k , hence we have $u_k = w_{n-E_n(k)+H_{\mathcal{T}_n}(k)}$. As a consequence, $k \mapsto n - E_n(k) + H_{\mathcal{T}_n}(k)$ is a permutation of $[\![0, n-1]\!]$
that exchanges the jumps ΔS and ΔS (where $\Delta A(k) = A(k+1) - A(k)$). that exchanges the jumps $\Delta S_{\mathcal{T}_n}$ and $\Delta S_{\mathcal{T}_n}$ (where $\Delta A(k) = A(k+1) - A(k)$):

$$
\Delta S_{\mathcal{T}_n^{\div}}\left(n - E_n(k) + H_{\mathcal{T}_n}(k)\right) = \Delta S_{\mathcal{T}_n}(k). \tag{23}
$$

Moreover, for a fixed k and $k' = n - E_n(k) + H_{\mathcal{T}_n}(k)$, we get that $S_{\mathcal{T}_n^{\pm}}(k') = L(u_k)$ (recall that L, R are defined in Section [2\)](#page-5-0), and this may be expressed with $S_{\mathcal{T}_n}$ as follows:

$$
S_{\mathcal{T}_n^{\pm}}(k') = \sum_{j: u_j \in [\![\beta, u_k]\!]} L(u_j) - L(\text{parent}(u_j)) = \sum_{j < k: S_{\mathcal{T}_n}(j) = \min_{[\![j,k]\!]} S_{\mathcal{T}_n}} S_{\mathcal{T}_n}(j+1) - \min_{[\![j+1,k]\!]} S_{\mathcal{T}_n}.\tag{24}
$$

Notice that we could argue directly in \mathcal{T}_n^{\div} , since the mirror transformation preserves the ancestral line and simply exchanges L and R , to get another expression of the same sum:

$$
S_{\mathcal{T}_n^{\pm}}(k') = \sum_{j < k': S_{\mathcal{T}_n^{\pm}}(j) = \min_{\llbracket j, k' \rrbracket} S_{\mathcal{T}_n^{\pm}} \left(\min_{\llbracket j+1, k' \rrbracket} S_{\mathcal{T}_n^{\pm}} - S_{\mathcal{T}_n^{\pm}}(j) \right) \tag{25}
$$

where additionally, each term in the right sum of (24) corresponds to and is equal to a term in the right sum of (25) .

Sending n to $+\infty$ will yield the desired assertions. To see this, first notice that the lemma only concerns the law of (X, Y) (indeed all three assertions correspond to a measurable events), thus by Skorokhod's representation theorem we may further assume that we have an almost sure convergence towards (X, Y) with respect to SKOROKHOD J_1 topology. It means that for all n we have some processes X^n, Y^n and some increasing bijections $\phi_n, \psi_n : [0, 1] \mapsto [0, 1]$ such that

$$
\forall u \in [0,1], \ X^n \circ \phi_n(u) = \frac{1}{\ell(n)n^{1/\alpha}} S_{\mathcal{T}_n}(\lfloor nu \rfloor), \ Y^n \circ \psi_n(u) = \frac{1}{\ell(n)n^{1/\alpha}} S_{\mathcal{T}_n^{\pm}}(\lfloor nu \rfloor),
$$

and

$$
(X^n, Y^n) \xrightarrow[n \to +\infty]{\| \cdot \|_{\infty}} (X, Y); \ (\phi_n, \psi_n) \xrightarrow[n \to +\infty]{\| \cdot \|_{\infty}} (\mathrm{Id}, \mathrm{Id}).
$$

Since we have $\{t \in [0,1]$ such that $\Delta X(t) > \varepsilon\} = \{t \in [0,1]$ such that $\Delta X(t) \geq \varepsilon\}$ for all $\varepsilon > 0$ almost surely, this convergence implies that for any given $\varepsilon > 0$, when n is large enough the change of time ϕ_n maps the jumps of size $\geq \varepsilon$ of X onto those of $S_{\mathcal{T}_n}/\ell(n)n^{1/\alpha}$:

$$
\text{Disc}_{\varepsilon}(X) = \left\{ \phi_n\left(\frac{k+1}{n}\right), \text{for } k < n \text{ such that } \Delta S_{\mathcal{T}_n}(k) > \varepsilon \ell(n) n^{1/\alpha} \right\} \text{for } n \text{ large enough.}
$$

An analogue statement holds for Y and $S_{\mathcal{T}_n^{\div}}$, which may be combined to [\(23\)](#page-41-2) to give

$$
\text{Disc}_{\varepsilon}(Y) = \left\{ \psi_n\left(\frac{n - E_n(k) + H_{\mathcal{T}_n}(k) + 1}{n} \right), \text{for } k < n \text{ such that } \Delta S_{\mathcal{T}_n}(k) > \varepsilon \ell(n) n^{1/\alpha} \right\}.
$$

Let us study the asymptotic of the right-hand side terms to obtain the desired link between $Disc(X)$ and Disc(Y). For all $t \in (0,1)$ and for all n, let $k_n(t)$ be such that $t \in (\phi_n(k_n(t)/n), \phi_n((k_n(t) +$ $1/(n)$ and set $m_n(t) = n - E_n(k_n(t)) + H_{\mathcal{T}_n}(k_n(t))$. Note that if $t \in \text{Disc}(X)$ then we must have $t = \phi_n((k_n(t) + 1)/n)$ for n large. We first prove that almost surely, for all $t \in [0, 1], \psi_n((m_n(t) +$ 1)/n) → 1 – e(t) as n goes to +∞. It is clear that $k_n(t) \sim tn$ and $H_{\mathcal{T}_n}(k_n(t)) = o(n)$, so it is sufficient to prove that $E_n(k_n(t)) \sim e(t)n$. To see this, observe that by construction we have

$$
\phi_n\left(\frac{E_n(k_n(t))}{n}\right) = \inf\{t' \ge t \text{ such that } X_{t'}^n < X_{t-}^n\}.
$$

For all t such that $e(t) = t$, this quantity clearly converges towards t. Moreover, properties of α -stable excursions implies that, almost surely, for all t such that $e(t) > t$ and for all $\delta > 0$ small enough we have

$$
\inf_{[t,e(t)-\delta]} X > X_{t-}
$$
 and
$$
\inf_{[t,e(t)+\delta]} X < X_{t-}.
$$

(see [\[Kor14,](#page-44-10) Proposition 2.10] again). Thus we always have $\phi_n(E_n(k_n(t))/n) \to e(t)$ and it gives that $\forall t \ E_n(k_n(t)) \sim e(t) n$.

As an almost sure consequence, for all $\varepsilon > 0$, we see that $\forall t \in \text{Disc}_{\varepsilon}(X)$, $\psi_n((m_n(t) + 1)/n) \to$ $1-e(t)$ and eventually every point of this sequence is in the finite set $Disc_{\varepsilon}(Y)$, hence $1-e(t) \in$ $Disc_{\varepsilon}(Y)$. Conversely, for $s \in Disc_{\varepsilon}(Y)$, for n large enough we have k_n such that $s = \psi_n((n E_n(k_n) + H_{\mathcal{T}_n}(k_n) + 1/n$, and since $Disc_{\varepsilon}(X)$ is finite we may assume (by extraction) that there is $t \in \text{Disc}_{\varepsilon}(X)$ such that $k_n = k_n(t)$ for large n. The previous argument directly gives that $s = 1 - e(t)$ (and $1 - e(t) = \psi_n((m_n(t) + 1)/n)$ for n large) thus we have

$$
\operatorname{Disc}_{\varepsilon}(Y) = \{1 - e(t), \forall t \in \operatorname{Disc}_{\varepsilon}(X)\}.
$$

As this holds for all $\varepsilon > 0$, we get that $Disc(Y) = \{1 - e(t), \forall t \in Disc(X)\}\)$ and that $\forall t \in Disc(X)$, $\Delta Y_{1-e(t)} = \Delta X_t$, almost surely.

Finally, we prove that almost surely $\forall t \in [0,1] \cap \mathbb{Q}$, $Y_{1-t} = W_t$. First, we fix $t \in (0,1)$. By properties of α -stable excursions, almost surely $1 - t \notin \text{Disc}(Y)$, $t \notin \text{Disc}(X)$ and the equation $e(y) = t$ has only one solution, namely $y = t$, because for all $\varepsilon > 0$ small enough we have $\inf_{[t,t\pm\varepsilon]} X < X_t$. Consequently $Y_{1-t} = Y_{1-e(t)}$ almost surely, and by the previous discussion this term can be approximated by $S_{\mathcal{T}_n^{\pm}}(m_n(t))/\ell(n)n^{1/\alpha}$. We will introduce closely related quantities and prove that they converge both toward $Y_{1-e(t)}$ and W_t to conclude.

We start by rewriting (24) as

$$
S_{\mathcal{T}_n^{\div}}(m_n(t)) = \sum_{j < k_n(t): S_{\mathcal{T}_n}(j) = \min_{[j,k_n(t)]} S_{\mathcal{T}_n}} \left(S_{\mathcal{T}_n}(j+1) - \min_{[j+1,k_n(t)]} S_{\mathcal{T}_n} \right) = \ell(n) n^{1/\alpha} \sum_{0 \le s < t: X^n_{s-} \le I^n_{s,t}} (X^n_s - I^n_{s,t}),
$$

where $I_{u,v}^n = \inf_{[u,v]} X^n$. We also introduce $\delta_{s,t}(x) = (x(s) - \inf_{[s,t]} x) \wedge (\inf_{[s,t]} x - x(s-))$ for $x \in D([0,1])$ and $s < t$, and for all $\varepsilon > 0$, we define

$$
r_n(\varepsilon) = \sum_{0 \le s < t: X^n_{s-1} \le I^n_{s,t}} (X^n_s - I^n_{s,t}) \mathbb{1}_{\delta_{s,t}(X^n) > \varepsilon} \; .
$$

Since we only take into account a finite number of jumps, we can deduce that

$$
r_n(\varepsilon) \underset{n \to +\infty}{\longrightarrow} r_\infty(\varepsilon) := \sum_{0 \le s < t: X_{s-} \le I_{s,t}} (X_s - I_{s,t}) \mathbb{1}_{\delta_{s,t}(X) > \varepsilon}.
$$

Moreover $r_{\infty}(\varepsilon)$ converges towards $\sum_{0\leq s < t: X_{s-} < I_{s,t}} X_s - I_{s,t} = W_t$ as ε goes to 0. But we can also express $r_n(\varepsilon)$ thanks to [\(25\)](#page-41-1) and its link with [\(24\)](#page-41-0) as it enables us to write

$$
\ell(n)n^{1/\alpha}r_n(\varepsilon) = \sum_{j \leq m_n(t):S_{\mathcal{T}_n^{\div}}(j) = \min_{[j,m_n(t)]} S_{\mathcal{T}_n^{\div}}} \left(\min_{[j+1,m_n(t)]} S_{\mathcal{T}_n^{\div}} - S_{\mathcal{T}_n^{\div}}(j) \right) \mathbb{1}_{\Delta_{j,m_n(t)} > \varepsilon \ell(n)n^{1/\alpha}},
$$

where $\Delta_{j,m} = \left(\min_{[j+1,m]} S_{\mathcal{T}_n^{\pm}} - S_{\mathcal{T}_n^{\pm}}(j) \right) \wedge \left(S_{\mathcal{T}_n^{\pm}}(j+1) - \min_{[j+1,m]} S_{\mathcal{T}_n^{\pm}} \right)$. By expressing the right-hand side term with Y^n , which converges toward Y with respect to J_1 , we deduce another expression of the limit $r_{\infty}(\varepsilon)$.

$$
r_\infty(\varepsilon)=\sum_{0\leq s<1-e(t):Y_{s-}\leq\inf_{[s,1-e(t)]}Y}\left(\inf_{[s,1-e(t)]}Y-Y_{s-}\right)\mathbbm{1}_{\delta_{s,t}(Y)>\varepsilon}.
$$

We conclude thanks to the following property of the α -stable excursion Y, established in [\[CK14,](#page-43-2) Corollary 3.4]:

$$
Y_{1-e(t)} = \sum_{0 \le s \le 1-e(t): Y_{s-} \le \inf_{[s,1-e(t)]} Y} \left(\inf_{[s,1-e(t)]} Y - Y_{s-} \right).
$$

Since $1 - t = 1 - e(t) \notin \text{Disc}(Y)$, we deduce from this that $r_{\infty}(\varepsilon)$ converges toward Y_{1-t} as ε goes to 0, hence $Y_{1-t} = W_t$. \Box

We now end this section with a proof Proposition [A.1](#page-40-0) based on the explicit description of a subsequential limit given by Lemma [A.2.](#page-40-2)

Proof. Let (X, Y) be a subsequential limit in distribution (with respect to J_1) of

$$
\left(\frac{1}{\ell(n)n^{1/\alpha}}\big(S_{\mathcal{T}_n}(\lfloor nt \rfloor),S_{\mathcal{T}_n^+}(\lfloor nt \rfloor)\big)_{t\in[0,1]}\right)_n.
$$

Recall from Lemma [A.2](#page-40-2) that almost surely $\forall t \in [0,1] \cap \mathbb{Q}, Y_{1-t} = W_t$. This shows that $\sigma(Y) = \sigma(Y_s, s \in [0, 1] \cap \mathbb{Q}) \subset \sigma(W) \vee \sigma(\mathcal{N}) \subset \sigma(X) \vee \sigma(\mathcal{N})$ where N is the set of P-negligible events. Since $D([0,1])$ is a polish space, DOOB-DYNKIN lemma guarantees the existence of a measurable function F^{\div} such that $Y = F^{\div}(X)$ almost surely. In particular, almost surely $F^{\div}(X)$ is the unique element in $D([0,1])$ such that $\forall t \in [0,1] \cap \mathbb{Q}$, $F^{\div}(X)_{1-t} = W_t$. Let us now consider another subsequential limit in distribution (X', Y') . Then X and X' both are α -stable excursions, hence almost surely $F^{\div}(X')$ is the unique element in $D([0,1])$ such that $\forall t \in [0,1] \cap \mathbb{Q}, F^{\div}(X')_{1-t} = W'_t$. Moreover, the consequence of Lemma [A.2](#page-40-2) also apply to (X', Y') , hence we have $Y' = F^{\div}(X')$ almost surely. This shows that (X', Y') is always distributed as $(X, F^{\div}(X))$, and the desired convergence follows. \Box

Remark. There may be a more explicit expression for F^{\div} : Define $(\widetilde{W}_t)_{t \in [0,1]}$ by

$$
\widetilde{W}_t = \sum_{0 \le s < t: X_{s-} \le I_{s,t}} X_s - I_{s,t}.
$$

The only difference with W_t is that we also consider the jumps such that $X_{s-} = I_{s,t}$. For a given $t \in [0, 1]$, almost surely $\widetilde{W}_t = W_t$. However, it is conjectured that $t \mapsto \widetilde{W}_t$ is left-continuous. If this is true then almost surely $F^{\div}(X) = t \mapsto W_{1-t}$, but we have not been able to prove this claim.
