A partial proof of the Brouwer's conjecture

Abstract

Let G be a simple graph with n vertices and m edges and let k be a natural number such that $k \leq n$. Brouwer conjectured that the sum of the k largest Laplacian eigenvalues of G is at most $m + \binom{k+1}{2}$ $\binom{+1}{2}$. In this paper we prove that this conjecture is true for simple (m, n) -graphs where $n \leq m \leq \frac{\sqrt{3}-1}{4}(n-1)n$ and $k \in \left[\sqrt[3]{\frac{8m^2}{n-1} + 4mn + n^2}, n\right]$. Moreover, we prove that the conjecture is true for all simple (m, n) -graphs where $k(\leq n)$ is a natural number from the interval $\left[\sqrt{2n-2m+2\sqrt{2m^2+mn(n-1)}},1+\frac{8m^2}{n^2(n-1)}+\frac{4m}{n}\right]$.

1 Introduction

Let G be a simple graph with vertex set $V(G)$ and edge set $E(G)$ and let $|V(G)| = n$ and $|E(G)| = m$. The degree of a vertex $v \in V(G)$ denoted by $d(v)$, is the number of neighbours of v. The Laplacian matrix of G is the $n \times n$ matrix $L(G) = [l_{ij}]$ defined as $L(G) = D(G) - A(G)$, where $D(G)$ is the diagonal matrix of vertex degrees of the graph G, and $A(G)$ is the adjacency matrix of G. It is well known that $L(G)$ is a positive semidefinite matrix, consequently its eigenvalues are nonnegative real numbers. The eigenvalues of $L(G)$ are called the Laplacian eigenvalues of G and are denoted by $\mu_1(G) \geq \mu_2(G) \geq \ldots \geq \mu_n(G)$. Since each row sum of $L(G)$ is 0, it holds $\mu_n(G) = 0$. In this paper, we study the sum $S_k(G) = \sum_{i=1}^k \mu_i(G)$ for $1 \leq k \leq n$. Brouwer [\[1\]](#page-6-0) has conjectured the following upper bound for the sum $S_k(G)$.

Conjecture 1. [\[1\]](#page-6-0) Let G be a graph with vertices n and edges m. Then

$$
S_k(G) \le m + \binom{k+1}{2}
$$

for $k = 1, 2, ..., n$.

Based on a computer check, Brouwer [\[1\]](#page-6-0) showed that the Conjecture 1 is true for all graphs with at most 10 vertices. There have been many partial proofs of this conjecture using specific methods from spectral graph theory. For $k = 1$, the conjecture follows from the well-known inequality $\mu_1(G) \leq |V(G)| = n$, see in [\[7\]](#page-6-1). The conjecture has been proved to be true for any graphs with $k = 2, n - 2, n - 3$, see [\[5,](#page-6-2) [8\]](#page-6-3), trees [\[8\]](#page-6-3), threshold graphs [\[9\]](#page-6-4), unicyclic graphs [\[6\]](#page-6-5), bicyclic graphs [\[6,](#page-6-5) [12\]](#page-7-0), tricyclic graphs having no pendant vertices [\[10,](#page-6-6) [12\]](#page-7-0), regular graphs [\[2,](#page-6-7) [11\]](#page-6-8), split graphs [\[11\]](#page-6-8), cographs [\[2,](#page-6-7) [11\]](#page-6-8), planar graphs when $k \ge 11$ and bipartite graphs when $k \ge \sqrt{32n}$ [\[4\]](#page-6-9). Also the cases $k = n$ and $k = n - 1$ are straightforward. Another related upper bound was given by Zhou in [\[14\]](#page-7-1):

$$
S_k(G) \le \frac{2mk + \sqrt{mk(n-k-1)(n^2 - n - 2m)}}{n-1}
$$

where $1 \leq k \leq n-2$ and $m = |E(G)|$.

In this paper we prove that the Brouwer's conjecture is true for all simple (m, n) graphs where $n \leq m \leq \frac{\sqrt{3}-1}{4}(n-1)n$ and $k \in \left[\sqrt[3]{\frac{8m^2}{n-1}+4mn+n^2},n\right]$. Moreover, we prove that this conjecture is true for all simple (m, n) -graphs where $k \leq n$ is a natural number from the interval $\left[\sqrt{2n - 2m + 2\sqrt{2m^2 + mn(n-1)}}, 1 + \frac{8m^2}{n^2(n-1)} + \frac{4m}{n}\right]$ n .

2 A partial proof of the conjecture

Let J be all-ones matrix of size n and let $L' = J - L$. Since $(L')^T = J^T - L^T =$ $J - L = L'$, we obtain that L' is a symmetric matrix. Let $\mu_1 \ge \mu_2 \ge \ldots \ge \mu_n$ be the eigenvalues of L, and let $\mu'_1 \ge \mu'_2 \ge \ldots \ge \mu'_n$ be the eigenvalues of L, in the decreasing order. Moreover, let $\lambda_1 \geq \lambda_2 \geq \ldots \geq \lambda_n$ be the eigenvalues of J. It is well-known that $\lambda_1(J) = n$ and $\lambda_i(J) = 0$, for $i = 2, 3, ..., n$. Applying the Weyl's inequality [\[13\]](#page-7-2) we get the following result.

Lemma 2. *a)* $\mu_i + \mu'_{n-i+2} \leq 0$ for $i = 2, 3, ..., n$.

$$
b) \mu_1 + \mu'_1 \geq n.
$$

Proof. a) From Weyl's inequality we get:

$$
\mu_i(L) + \mu'_j(L') \le \lambda_{i+j-n}(L + L') = \lambda_{i+j-n}(J). \tag{1}
$$

Setting $j = n - i + 2$ in [\(1\)](#page-1-0) we get the inequality:

$$
\mu_i + \mu'_{n-i+2} \leq \lambda_2(J) = 0
$$
, for $i = 2, 3, ..., n$. (2)

b) Since $\text{trace}(L) = \sum_{i=1}^n \mu_i$, $\text{trace}(L') = \sum_{i=1}^n \mu'_i$ i_{i} and trace(L) + trace(L') = $trace(J) = n$ we have

$$
\mu_1 + \mu_1' + \sum_{i=2}^n (\mu_i + \mu_{n-i+2}') = n.
$$

From a) we get $\mu_1 + \mu_1' \geq n$.

The *first Zagreb index* for a graph with a vertex set $\{v_1, v_2, \ldots, v_n\}$ and vertex degrees $d_i = \deg(v_i)$ for $i = 1, \ldots, n$ is defined by

$$
M_1(G) = \sum_{i=1}^n d_i^2.
$$

The following upper bound for M_1 , obtained by de Caen in [\[3\]](#page-6-10), will be used in our proof.

Lemma 3. [\[3\]](#page-6-10) Let $G = (V, E)$ be a graph with n vertices and m edges. Then

$$
M_1(G) = \sum_{i=1}^n d_i^2 \le \frac{2m^2}{n-1} + mn - 2m.
$$

Moreover, if G is connected, then equality holds if and only if G is either a star $K_{1,n-1}$ or a complete graph K_n .

In the next theorem we give an upper bound for $S_k(G)$ in terms of m, n and k.

Theorem 4. Let G be a simple graph on n vertices and m edges. Then

$$
S_k(G) = \sum_{i=1}^k \mu_k \le n + \sqrt{(k-1)\left(\frac{2m^2}{n-1} + mn + \frac{n^2}{4}\right)}.
$$

Proof. From $\text{trace}(L \cdot L^{\mathsf{T}}) = \sum_{i=1}^{n} \sum_{j=1}^{n} l_{ij}^{2}$ and $L = L^{\mathsf{T}}$ we obtain

$$
\sum_{i=1}^{n} \mu_i^2 = \text{trace}(L^2) = \text{trace}(L \cdot L^{\mathsf{T}}) = \sum_{i=1}^{n} \sum_{j=1}^{n} l_{ij}^2.
$$
 (3)

Analogously we get

$$
\sum_{i=1}^{n} (\mu_i')^2 = \text{trace}((L')^2) = \text{trace}(L' \cdot (L')^T) = \sum_{i=1}^{n} \sum_{j=1}^{n} (l'_{ij})^2.
$$
 (4)

Combining [\(3\)](#page-2-0) and [\(4\)](#page-2-1) we get:

$$
\sum_{i=1}^{n} \mu_i^2 + \sum_{i=1}^{n} (\mu_i')^2 = \sum_{i=1}^{n} \sum_{j=1}^{n} l_{ij}^2 + \sum_{i=1}^{n} \sum_{j=1}^{n} (l_{ij}')^2 = \sum_{i=1}^{n} \sum_{j=1}^{n} (l_{ij}^2 + (1 - l_{ij})^2)
$$

$$
= \sum_{i=1}^{n} \sum_{j=1}^{n} (2l_{ij}^2 - 2l_{ij} + 1) = \left(\sum_{i=1}^{n} 2d_i^2 - \sum_{i=1}^{n} 2d_i + n\right) + \left(\sum_{i=1}^{n} \sum_{j=1, j \neq i}^{n} (2l_{ij}^2 - 2l_{ij} + 1)\right)
$$

$$
= (2M_1 - 4m + n) + ((4 + 4 + ... + 4) + n^2 - n)
$$

 \Box

$$
= 2M_1 - 4m + n + 2m \cdot 4 + n^2 - n = 2M_1 + 4m + n^2.
$$

Let $t = \frac{\mu_1}{n}$ $\frac{\mu_1}{n}$. Since $\mu_1 \leq n$ we get $0 < t \leq 1$. The inequality $\mu_1 + \mu_1' \geq n$ implies

$$
\mu_1^2 + (\mu_1')^2 \ge n^2 t^2 + n^2 (1 - t)^2 = n^2 (2t^2 - 2t + 1). \tag{5}
$$

Moreover, from $\mu_i + \mu'_{n-i+2} \leq 0$, for $i = 2, 3, ..., n$, and from $\mu_i \geq 0$ we easily conclude that $\mu_i^2 \leq (\mu_{n-i+2})^2$. Therefore we have

$$
2M_1 + 4m + n^2 = \sum_{i=1}^n \mu_i^2 + \sum_{i=1}^n (\mu_i')^2 = (\mu_1^2 + (\mu_1')^2) + \sum_{i=2}^n (\mu_i^2 + (\mu_{n-i+2}')^2)
$$

$$
\geq (1 - 2t(1 - t))n^2 + 2\sum_{i=2}^n \mu_i^2.
$$

From the last inequality we get

$$
\sum_{i=2}^{k} \mu_i^2 \le \sum_{i=2}^{n} \mu_i^2 \le \frac{2M_1 + 4m + n^2}{2} - \frac{(1 - 2t(1 - t))n^2}{2}.
$$
 (6)

.

 \Box

Now, based on the inequality [\(6\)](#page-3-0) and applying the inequality between the arithmetic and quadratic means for the nonnegative eigenvalues $\mu_2, \mu_3, \ldots, \mu_n$ we get

$$
\sum_{i=2}^{k} \mu_i \le \sqrt{(k-1)(\mu_2^2 + \ldots + \mu_k^2)} \le \sqrt{(k-1)\left(\frac{2M_1 + 4m + n^2}{2} - \frac{(1 - 2t(1-t))n^2}{2}\right)}
$$
(7)

Hence we get

$$
S_k(G) = \sum_{i=1}^k \mu_i = \mu_1 + \sum_{i=2}^n \mu_i \le nt + \sqrt{(k-1)(M_1 + 2m + n^2t(1-t))}. \tag{8}
$$

Setting $M_1 \leq \frac{2m^2}{n-1} - 2m + mn$ in [\(8\)](#page-3-1) we obtain the following inequality

$$
\sum_{i=1}^{k} \mu_i \le nt + \sqrt{(k-1)\left(\frac{2m^2}{n-1} + mn + n^2 t(1-t)\right)}.
$$
 (9)

In the end, from $t \leq 1$ and $t(1-t) \leq \frac{1}{4}$ we have

$$
S_k(G) = \sum_{i=1}^k \mu_i \le n + \sqrt{(k-1)\left(\frac{2m^2}{n-1} + mn + \frac{n^2}{4}\right)}.
$$

Theorem 5. Let G be a simple graph on n vertices and m edges such that $n \leq m \leq \frac{\sqrt{3}-1}{4}(n-1)n$. The Brouwer's conjecture holds for all natural numbers k from the interval $\left[\sqrt[3]{\frac{8m^2}{n-1} + 4mn + n^2}, n\right]$.

Proof. The bound in Theorem 4 and the assumption $n \leq m$ yield

$$
S_k(G) \le n + \sqrt{(k-1)\left(\frac{2m^2}{n-1} + mn + \frac{n^2}{4}\right)} < m + \sqrt{k\left(\frac{2m^2}{n-1} + mn + \frac{n^2}{4}\right)}.
$$
 (10)

Now, we are going to show that for $k \in \left[\sqrt[3]{\frac{8m^2}{n-1} + 4mn + n^2}, n\right]$, it holds

$$
m + \sqrt{k\left(\frac{2m^2}{n-1} + mn + \frac{n^2}{4}\right)} \le m + {k+1 \choose 2}.
$$

Since $\frac{k^2}{2} < {k+1 \choose 2}$ $\binom{+1}{2}$, it suffices to prove that

$$
k\left(\frac{2m^2}{n-1} + mn + \frac{n^2}{4}\right) \le \frac{k^4}{4},
$$

which obviously holds for $k \geq \sqrt[3]{\frac{8m^2}{n-1} + 4mn + n^2}$. In the end, we verify that for $m \leq \frac{\sqrt{3}-1}{4}(n-1)n$ it occurs $\sqrt[3]{\frac{8m^2}{n-1} + 4mn + n^2} < n$. The inequality $\sqrt[3]{\frac{8m^2}{n-1} + 4mn + n^2} < n$ is equivalent to the quadratic inequality (in $m)$

$$
8m^2 + 4mn(n-1) - n^2(n-1)^2 < 0. \tag{11}
$$

 \Box

Solving the inequality [\(11\)](#page-4-0) we get $m \in \left(\frac{(-\sqrt{3}-1)}{4}n(n-1), \frac{(\sqrt{3}-1)}{4}n(n-1)\right)$.

Remark 6. We illustrate the above theorem for simple graphs on 100 vertices. From the condition $n \leq m \leq \frac{\sqrt{3}-1}{4}n(n-1)$ we have $100 \leq m \leq 1811$. Based on the restrictions for k, that is, $k \in \left[\sqrt[3]{\frac{8m^2}{n-1} + 4mn + n^2}, n\right]$, in the table below we consider particular examples and give the corresponding values of k for which the Brouwer's conjecture is true.

Note that the Theorem 5 concerns the simple graphs with n vertices and with at most $\frac{(\sqrt{3}-1)}{4}n(n-1)$ edges. This is approximately $\frac{2}{5}$ of all connected graphs on n vertices. The next theorem extends the set of graphs for which the Brouwer's conjecture is true.

Theorem 7. $\frac{1}{2}$ Let G be a simple graph on n vertices and m edges such that $2n - 2m + 2\sqrt{2m^2 + mn(n-1)} < 1 + \frac{8m^2}{n^2(n-1)} + \frac{4m}{n}$ $\frac{m}{n}$. The Brouwer's conjecture is true for any natural number $k \leq n$ from the interval

$$
\[\sqrt{2n - 2m + 2\sqrt{2m^2 + mn(n-1)}}, 1 + \frac{8m^2}{n^2(n-1)} + \frac{4m}{n}\]
$$

Proof. Let $g(t) = nt + \sqrt{(k-1)(\frac{2m^2}{n-1} + mn + n^2t(1-t))}$ where $0 \le t \le 1$. Then $g'(t) = n + \frac{n^2(k-1)(1-2t)}{\sqrt{n^2+k^2}}$ $\frac{n^2(k-1)(1-2t)}{2\sqrt{(k-1)\left(\frac{2m^2}{n-1}+mn+n^2t(1-t)\right)}}$. If $0 \leq t \leq \frac{1}{2}$ $\frac{1}{2}$, then it is clear that $g'(t) > 0$. Now, let $t > \frac{1}{2}$. We obtain

$$
g'(t) > 0 \Leftrightarrow n > \frac{n^2(k-1)(2t-1)}{2\sqrt{(k-1)\left(\frac{2m^2}{n-1} + mn + n^2t(1-t)\right)}}.
$$
\n(12)

.

.

The inequality [\(12\)](#page-5-0) is equivalent to

$$
\frac{8m^2}{n-1} + 4mn + 4n^2t(1-t) \ge n^2(k-1)(2t-1)^2.
$$
 (13)

We easily observe that the inequality in [\(13\)](#page-5-1) holds since $2t - 1 \leq 1$, $n^2t(1-t) \geq 0$ and $k \leq 1 + \frac{8m^2}{n^2(n-1)} + \frac{4m}{n}$ $\frac{m}{n}$.

Since $g'(t) > 0$, we get that $g(t)$ is an increasing function on the interval [0, 1]. Recalling the inequality [\(9\)](#page-3-2) we have

$$
S_k(G) \le g(t) \le g(1) = n + \sqrt{(k-1)\left(\frac{2m^2}{n-1} + mn\right)}
$$

Let us suppose that $k \geq \sqrt{2n - 2m + 2\sqrt{2m^2 + mn(n-1)}}$. We get $2m + k^2 \geq$ $2n + 2\sqrt{2m^2 + mn(n-1)}$. Hence

$$
m + {k+1 \choose 2} > m + \frac{k^2}{2} \ge n + \sqrt{2m^2 + mn(n-1)} = n + \sqrt{(n-1)\left(\frac{2m^2}{n-1} + mn\right)}
$$

$$
\ge n + \sqrt{(k-1)\left(\frac{2m^2}{n-1} + mn\right)} = g(1) \ge S_k(G).
$$

Remark 8. We illustrate the above theorem for simple graphs on 100 vertices. From the condition $\sqrt{2n - 2m + 2\sqrt{2m^2 + mn(n-1)}} < 1 + \frac{8m^2}{n^2(n-1)} + \frac{4m}{n}$ $\frac{dm}{n}$ we get $m \ge 1468$. Based on the restrictions for k , in the table below we consider particular examples and give the corresponding values of k for which the Brouwer's conjecture is true.
