SPECTRAL COMPARISON RESULTS FOR THE N-BAKRY-EMERY RICCI TENSOR

ABSTRACT. We establish the diameter and global weighted volume comparison when the N-Bakry-Emery Ricci tensor has a positive lower bound in the spectrum sense.

1. Introduction

Let (M,g) be a complete n-dimensional Riemannian manifold and dvol_g be the volume element of (M,g). For $f \in C^{\infty}(M)$, the triple $(M,g,e^{-f}\operatorname{dvol}_g)$ is called a weighted manifold (or manifold with density), which was introduced by Lichnerowicz [10, 11]. As a natural generalization of the Laplacian operator, the f-Laplacian operator is defined by

$$\Delta_f u := e^f \operatorname{div}(e^{-f} \nabla u) = \Delta u - \langle \nabla u, \nabla f \rangle.$$

It is clear that Δ_f is self-adjoint with respect to the weighted measure $e^{-f} dvol_g$. As a natural generalization of the Ricci tensor, Lichnerowicz [10] and Bakry-Emery [4] introduced the tensor

$$\operatorname{Ric}_f := \operatorname{Ric} + \operatorname{Hess} f$$
,

and extensively investigated the connection between Ric_f and properties of the underlying weighted manifold. This tensor is usually referred to as the Bakry-Emery Ricci tensor in the literature. More generally, the N-Bakry-Emery Ricci tensor is defined by

$$\operatorname{Ric}_f^N := \operatorname{Ric} + \operatorname{Hess} f - \frac{1}{N} df \otimes df.$$

We will discuss some comparison results for the N-Bakry-Emery Ricci tensor below. For more related works, we refer the reader to [5, 17, 13, 9, 16] and the references therein.

In the comparison geometry of Ricci curvature, the Bochner formula is very important, which gives the relationship between the Δ and Ric:

(1.1)
$$\frac{1}{2}\Delta|\nabla u|^2 = |\text{Hess}u|^2 + \langle \nabla u, \nabla \Delta u \rangle + \text{Ric}(\nabla u, \nabla u)$$
$$\geqslant \frac{(\Delta u)^2}{n} + \langle \nabla u, \nabla \Delta u \rangle + \text{Ric}(\nabla u, \nabla u).$$

For the N-Bakry-Emery Ricci tensor, there is a counterpart:

(1.2)
$$\frac{1}{2}\Delta_f |\nabla u|^2 = |\text{Hess}u|^2 + \langle \nabla u, \nabla \Delta_f u \rangle + \text{Ric}_f(\nabla u, \nabla u) \\ \geqslant \frac{(\Delta_f u)^2}{N+n} + \langle \nabla u, \nabla \Delta_f u \rangle + \text{Ric}_f^N(\nabla u, \nabla u).$$

Comparing (1.1) and (1.2), one may regard the Bochner formula for Ric_f^N of n-dimensional manifold as that for Ric of (N+n)-dimensional manifold.

When $\operatorname{Ric} \geq (n-1)\lambda > 0$, the Bonnet-Myers theorem shows that

$$\operatorname{diam}(M,g) \leqslant \frac{\pi}{\sqrt{\lambda}},$$

while the Bishop-Gromov volume comparison states that for $p \in M$, the volume ratio function

$$r \mapsto \frac{\operatorname{Vol}(B(p,r))}{\operatorname{Vol}_{\lambda}^{\gamma}(r)}$$
 is decreasing on $r \in (0, \pi/\sqrt{\lambda}],$

where $\operatorname{Vol}_{\lambda}^{n}(\cdot)$ denotes the volume of geodesic ball in the *n*-dimensional sphere with radius $\lambda^{-\frac{1}{2}}$. In particular, the above implies the global volume comparison

(1.3)
$$\operatorname{Vol}(M,g) \leqslant \operatorname{Vol}_{\lambda}^{n}(\pi/\sqrt{\lambda}) \cdot \lim_{r \to 0} \frac{\operatorname{Vol}(B(p,r))}{\operatorname{Vol}_{\lambda}^{n}(r)} = \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^{n}).$$

There has been great interest in extending the above comparison results to N-Bakry-Emery Ricci tensor setting. As in the above discussion of Bochner formula, when N is finite, the n-dimensional weighted manifold with positive N-Bakry-Emery Ricci tensor looks like the (N+n)-dimensional manifold with positive Ricci tensor. However, when $N=\infty$, the situation becomes subtle. When f is unbounded, the condition $\mathrm{Ric}_f \geqslant (n-1)\lambda$ does not even guarantee the compactness of M (see [20, Example 2.1 and 2.2]). These examples shows that the boundedness assumption of f (i.e. $F:=\|f\|_{L^\infty(M)}<\infty$) is necessary when $N=\infty$.

When $\operatorname{Ric}_f^N \geqslant (n-1)\lambda > 0$ and $N \in (0, \infty)$, Qian [18] showed that

$$\operatorname{diam}(M,g) \leqslant \sqrt{\frac{N+n-1}{n-1}} \cdot \frac{\pi}{\sqrt{\lambda}}.$$

When $N = \infty$, diameter comparison results are listed below:

- Wei-Wylie [20]: diam $(M,g) \leqslant \left(1 + \frac{4}{(n-1)\pi}F\right) \cdot \frac{\pi}{\sqrt{\lambda}}$;
- Limoncu [12]: diam $(M) \leqslant \sqrt{1 + \frac{2\sqrt{2}}{n-1}F} \cdot \frac{\pi}{\sqrt{\lambda}}$;
- Tadano [19]: $\operatorname{diam}(M) \leqslant \sqrt{1 + \frac{8}{(n-1)\pi}F} \cdot \frac{\pi}{\sqrt{\lambda}}$.

On the other hand, Bakry-Qian [6] proved that when $\operatorname{Ric}_f^N \ge (n-1)\lambda > 0$, then for $p \in M$, the weighted volume ratio function

(1.4)
$$r \mapsto \frac{\operatorname{Vol}_f(B(p,r))}{\operatorname{Vol}_{\lambda}^{N+n}(r)}$$
 is decreasing on $r \in \left(0, \sqrt{\frac{N+n-1}{n-1}} \cdot \frac{\pi}{\sqrt{\lambda}}\right]$.

When $N = \infty$, Wei-Wylie [20] proved that for $p \in M$,

(1.5)
$$r \mapsto \frac{\operatorname{Vol}_f(B(p,r))}{\operatorname{Vol}_{\lambda}^{n+4F}(r)}$$
 is decreasing on $r \in (0, \pi/4\sqrt{\lambda}].$

Note that one does not obtain the global weighted volume comparison (i.e. the weighted version of (1.3)) since the limit in (1.4) or (1.5) blows up when $r \to 0$. To the best of our knowledge, such global weighted volume comparison is still lacking.

Now let us go back to the n-dimenisnal Riemannian manifolds with Ric $\geq (n-1)\lambda > 0$. Following the isoperimetric profile method from Bray [2], Bray-Gui-Liu-Zhang [3] gave an alternative proof of the global volume comparison $\operatorname{Vol}(M,g) \leq \lambda^{-n/2}\operatorname{Vol}(\mathbb{S}^n)$. Following the ideas developed in [2, 3] and μ -bubble method from Gromov [8], Antonelli-Xu [1] proved the global volume comparison and diameter comparison in the spectrum sense (see also [21, 7]).

Theorem 1.1 (Theorem 1 and Lemma 1 of [1]). Let (M, g) be a complete n-dimensional Riemannian manifold with $n \ge 3$, and γ be a constant such that

$$0 \leqslant \gamma \leqslant \frac{n-1}{n-2}.$$

Suppose that there exists a positive function $u \in C^{\infty}(M)$ such that

$$u \operatorname{Ric}(x) - \gamma \Delta u \geqslant (n-1)\lambda u$$

for some $\lambda > 0$. Here

$$\operatorname{Ric}(x) := \inf_{v \in T_x M, |v| = 1} \operatorname{Ric}(v, v)$$

denotes the smallest eigenvalue of the Ricci tensor at x. If

$$0 < \inf_{M} u \leqslant \sup_{M} u < \infty,$$

then the following comparison results hold:

(1) Diameter comparison:

$$\operatorname{diam}(M,g) \leqslant \left(\frac{\sup_{M} u}{\inf_{M} u}\right)^{\frac{n-3}{n-1}\gamma} \cdot \frac{\pi}{\sqrt{\lambda}}.$$

(2) Global volume comparison:

$$\operatorname{Vol}(M, g) \leqslant \lambda^{-n/2} \operatorname{Vol}(\mathbb{S}^n).$$

Motivated by Theorem 1.1, we aim to establish analogous results for the N-Bakry-Emery Ricci tensor by adapting the approach of Antonelli-Xu [1].

Theorem 1.2. Let (M, g) be a complete n-dimensional Riemannian manifold with $n \ge 3$, and N, γ be two constants such that

$$N \in (-\infty, -(n-1)) \cup (0, +\infty), \quad 0 \leqslant \gamma \leqslant \frac{N+n-1}{N+n-2}$$

Suppose that there exists a positive function $u \in C^{\infty}(M)$ such that

$$u \operatorname{Ric}_f^N(x) - \gamma \Delta_f u \geqslant (n-1)\lambda u$$

for some $f \in C^{\infty}(M)$ and $\lambda > 0$. Here

$$\operatorname{Ric}_f^N(x) := \inf_{v \in T_x M, \, |v| = 1} \operatorname{Ric}_f^N(v, v)$$

denotes the smallest eigenvalue of the N-Bakry-Emery Ricci tensor at x. If

$$0 < \inf_{M} u \leqslant \sup_{M} u < \infty, \quad F = ||f||_{C^{0}(M)} < \infty,$$

then the following comparison results hold:

(1) Diameter comparison:

$$\operatorname{diam}(M,g) \leqslant \begin{cases} \left(\frac{\sup_{M} u}{\inf_{M} u}\right)^{\frac{N+n-3}{N+n-1}\gamma} \cdot \sqrt{\frac{N+n-1}{n-1}} \cdot \frac{\pi}{\sqrt{\lambda}} & when \ N > 0, \\ \left(\frac{\sup_{M} u}{\inf_{M} u}\right)^{\frac{n-3}{n-1}\gamma} \cdot e^{\frac{2}{n-1}F} \cdot \frac{\pi}{\sqrt{\lambda}} & when \ N < -(n-1). \end{cases}$$

(2) Global weighted volume comparison:

$$\operatorname{Vol}_f(M,g) \leqslant e^{\frac{(n+1)(3n-1)}{n(n-1)}F} \cdot \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n).$$

Remark 1.3. To the best of our knowledge, even when $u \equiv 1$, (2) of Theorem 1.2 seems to be new, which gives a global weighted volume comparison for $(M, g, e^{-f} \operatorname{dvol}_g)$ with $\operatorname{Ric}_f^N \geq (n-1)\lambda > 0$.

2. Proof of Diameter Comparison

Suppose that $\Omega_- \subset \Omega_+ \subset M$ be two domains such that $\partial \Omega_- \neq \emptyset$, $\partial \Omega_+ \neq \emptyset$ and $\overline{\Omega_+} \setminus \Omega_-$ is compact. Let $h \in C^{\infty}(\Omega_+ \setminus \overline{\Omega_-})$ be a function satisfying

$$\lim_{x \to \partial \Omega_{-}} h(x) = +\infty$$
, $\lim_{x \to \partial \Omega_{+}} h(x) = -\infty$ uniformly.

Fix a constant k and a domain Ω_0 such that $\Omega_- \in \Omega_0 \in \Omega_+$. For a set Ω with finite perimeter, we consider the functional

$$E(\Omega) = \int_{\partial^* \Omega} u^{\gamma} e^{-f} - \int (\chi_{\Omega} - \chi_{\Omega_0}) h u^{\alpha} e^{-(k+1)f},$$

where $\partial^*\Omega$ denotes the reduced boundary of Ω . By the similar argument of [22, Proposition 2.1], the functional E must have a minimizer Ω such that $\Omega_- \in \Omega \in \Omega_+$. The classical geometric measure theory (see e.g. [14, Theorem 27.5, Theorem 28.1]) shows that $\partial\Omega$ is smooth when $n \leq 7$ while the singular part of $\partial\Omega$ has Hausdorff dimension no more than n-8.

- 2.1. The case $3 \leqslant n \leqslant 7$. For any $\varphi \in C^{\infty}(M)$, let $\{\Omega_t\}_{t \in (-\varepsilon,\varepsilon)}$ be a smooth family of sets satisfying
 - $\Omega_0 = \Omega$;
 - $\frac{\partial \Omega_t}{\partial t} = \varphi \nu$, where ν denotes the outer unit normal of $\partial \Omega_t$.

We compute the first variation:

$$0 = \frac{\mathrm{d}}{\mathrm{d}t} E(\Omega_t) \Big|_{t=0} = \int_{\partial \Omega} (H + \gamma u^{-1} u_{\nu} - f_{\nu} - h u^{\alpha - \gamma} e^{-kf}) u^{\gamma} e^{-f} \varphi.$$

Since φ is arbitrary, then we obtain

$$(2.1) H = f_{\nu} + hu^{\alpha - \gamma} e^{-kf} - \gamma u^{-1} u_{\nu}.$$

We next compute the second variation:

$$0 \leqslant \frac{\mathrm{d}^{2}}{\mathrm{d}t^{2}} E(\Omega_{t}) \Big|_{t=0}$$

$$= \int_{\partial\Omega} \left(-\Delta_{\partial\Omega} \varphi - |\mathrm{II}|^{2} \varphi - \mathrm{Ric}(\nu, \nu) \varphi - \gamma u^{-2} u_{\nu}^{2} \varphi \right.$$

$$+ \gamma u^{-1} \varphi (\Delta u - \Delta_{\partial\Omega} u - H u_{\nu}) - \gamma u^{-1} \langle \nabla_{\partial\Omega} u, \nabla_{\partial\Omega} \varphi \rangle$$

$$- \mathrm{Hess} f(\nu, \nu) \varphi + \langle \nabla_{\partial\Omega} f, \nabla_{\partial\Omega} \varphi \rangle - h_{\nu} u^{\alpha - \gamma} e^{-kf} \varphi$$

$$- (\alpha - \gamma) h u^{\alpha - \gamma - 1} u_{\nu} e^{-kf} \varphi + k h u^{\alpha - \gamma} e^{-kf} f_{\nu} \varphi \right) u^{\gamma} e^{-f} \varphi.$$

By the definition of Δ_f and Ric_f^N ,

$$-\operatorname{Ric}(\nu,\nu)\varphi + \gamma u^{-1}\varphi\Delta u - \operatorname{Hess} f(\nu,\nu)\varphi$$

$$= -\left(\operatorname{Ric}_{f}^{N}(\nu,\nu) + \frac{1}{N}f_{\nu}^{2}\right)\varphi + \gamma u^{-1}\varphi\left(\Delta_{f}u + \langle\nabla u,\nabla f\rangle\right)$$

$$= \left(\gamma\Delta_{f}u - u\operatorname{Ric}_{f}^{N}(\nu,\nu)\right)u^{-1}\varphi - \frac{1}{N}f_{\nu}^{2}\varphi + \gamma u^{-1}\varphi\langle\nabla u,\nabla f\rangle.$$

It then follows that

$$0 \leqslant \int_{\partial\Omega} \left(-\Delta_{\partial\Omega} \varphi - |\mathrm{II}|^2 \varphi + \left(\gamma \Delta_f u - u \mathrm{Ric}_f^N(\nu, \nu) \right) u^{-1} \varphi - \frac{1}{N} f_{\nu}^2 \varphi \right)$$

$$+ \gamma u^{-1} \varphi \langle \nabla u, \nabla f \rangle - \gamma u^{-2} u_{\nu}^2 \varphi + \gamma u^{-1} \varphi (-\Delta_{\partial\Omega} u - H u_{\nu})$$

$$- \gamma u^{-1} \langle \nabla_{\partial\Omega} u, \nabla_{\partial\Omega} \varphi \rangle + \langle \nabla_{\partial\Omega} f, \nabla_{\partial\Omega} \varphi \rangle - h_{\nu} u^{\alpha - \gamma} e^{-kf} \varphi$$

$$- (\alpha - \gamma) h u^{\alpha - \gamma - 1} u_{\nu} e^{-kf} \varphi + k h u^{\alpha - \gamma} e^{-kf} f_{\nu} \varphi \right) u^{\gamma} e^{-f} \varphi.$$

Lemma 2.1. When $\varphi = u^{-\gamma}$ and $\alpha = \frac{kN+2}{N+n-1}\gamma$, we have

$$0 \leqslant \int_{\partial\Omega} \left(-\frac{\left(4k - (n-1)k^2\right)N + 4}{4(N+n-1)} u^{2\alpha - 2\gamma} e^{-kf} h^2 + |\nabla h| u^{\alpha - \gamma} - (n-1)\lambda e^{kf} \right) u^{-\gamma} e^{-(k+1)f}.$$

Proof. By $\varphi = u^{-\gamma}$ and $\gamma \geqslant 0$, we see that

$$(2.3) -\Delta_{\partial\Omega}\varphi - \gamma u^{-1}\varphi \Delta_{\partial\Omega}u - \gamma u^{-1}\langle \nabla_{\partial\Omega}u, \nabla_{\partial\Omega}\varphi \rangle = -\gamma u^{-\gamma-2}|\nabla_{\partial\Omega}u|^2 \leqslant 0$$
 and

(2.4)
$$\gamma u^{-1} \varphi \langle \nabla u, \nabla f \rangle + \langle \nabla_{\partial \Omega} f, \nabla_{\partial \Omega} \varphi \rangle$$

$$= \gamma u^{-\gamma - 1} (\langle \nabla u, \nabla f \rangle - \langle \nabla_{\partial \Omega} u, \nabla_{\partial \Omega} f \rangle) = \gamma u^{-\gamma - 1} u_{\nu} f_{\nu}.$$

Combining the above with $|II|^2 \geqslant \frac{H^2}{n-1}$ and $\gamma \Delta_f u - u \operatorname{Ric}_f^N \leqslant -(n-1)\lambda u$,

$$0 \leqslant \int_{\partial\Omega} \left(-\frac{H^{2}}{n-1} u^{-\gamma} - (n-1)\lambda u^{-\gamma} - \frac{1}{N} f_{\nu}^{2} u^{-\gamma} + \gamma u^{-\gamma-1} u_{\nu} f_{\nu} \right.$$

$$\left. - \gamma u^{-\gamma-2} u_{\nu}^{2} - \gamma u^{-\gamma-1} H u_{\nu} - h_{\nu} u^{\alpha-\gamma} e^{-kf} u^{-\gamma} \right.$$

$$\left. - (\alpha - \gamma) h u^{\alpha-\gamma-1} u_{\nu} e^{-kf} u^{-\gamma} + k h u^{\alpha-\gamma} e^{-kf} f_{\nu} u^{-\gamma} \right) e^{-f}$$

$$\leqslant \int_{\partial\Omega} \left(-\frac{H^{2}}{n-1} - (n-1)\lambda - \frac{1}{N} f_{\nu}^{2} + \gamma u^{-1} u_{\nu} f_{\nu} \right.$$

$$\left. - \gamma u^{-2} u_{\nu}^{2} - \gamma u^{-1} H u_{\nu} + |\nabla h| u^{\alpha-\gamma} e^{-kf} \right.$$

$$\left. - (\alpha - \gamma) h u^{\alpha-\gamma-1} u_{\nu} e^{-kf} + k h u^{\alpha-\gamma} e^{-kf} f_{\nu} \right) u^{-\gamma} e^{-f}.$$

Set $X = hu^{\alpha-\gamma}e^{-kf}$ and $Y = u^{-1}u_{\nu}$. By (2.1), we have $H = f_{\nu} + X - \gamma Y$. Direct calculation shows

$$0 \leqslant \int_{\partial\Omega} \left[-\frac{(f_{\nu} + X - \gamma Y)^2}{n - 1} - (n - 1)\lambda - \frac{1}{N} f_{\nu}^2 + \gamma Y f_{\nu} - \gamma Y^2 - \gamma Y (f_{\nu} + X - \gamma Y) + |\nabla h| u^{\alpha - \gamma} e^{-kf} + (\gamma - \alpha) X Y + k X f_{\nu} \right] u^{-\gamma} e^{-f}$$

$$= \int_{\partial\Omega} \left[-\left(\frac{1}{n - 1} + \frac{1}{N}\right) f_{\nu}^2 + \left(k - \frac{2}{n - 1}\right) X f_{\nu} + \frac{2\gamma}{n - 1} Y f_{\nu} - \frac{X^2}{n - 1} + \left(\frac{2\gamma}{n - 1} - \alpha\right) X Y + \left(\frac{n - 2}{n - 1}\gamma^2 - \gamma\right) Y^2 + |\nabla h| u^{\alpha - \gamma} e^{-kf} - (n - 1)\lambda \right] u^{-\gamma} e^{-f}.$$

It is clear that

$$-\left(\frac{1}{n-1} + \frac{1}{N}\right)f_{\nu}^{2} + \left(k - \frac{2}{n-1}\right)Xf_{\nu} + \frac{2\gamma}{n-1}Yf_{\nu}$$

$$\leq \frac{1}{4} \cdot \left(\frac{1}{n-1} + \frac{1}{N}\right)^{-1} \left[\left(k - \frac{2}{n-1}\right)X + \frac{2\gamma}{n-1}Y\right]^{2}$$

$$= \frac{N\left((n-1)k - 2\right)^{2}}{4(N+n-1)(n-1)}X^{2} + \frac{N\left((n-1)k - 2\right)\gamma}{(N+n-1)(n-1)}XY$$

$$+ \frac{N\gamma^{2}}{(N+n-1)(n-1)}Y^{2}$$

and so

$$0 \leqslant \int_{\partial\Omega} \left[\frac{\left((n-1)k^2 - 4k \right)N - 4}{4(N+n-1)} X^2 + \left(\frac{kN+2}{N+n-1} \gamma - \alpha \right) XY + \left(\frac{N+n-2}{N+n-1} \gamma^2 - \gamma \right) Y^2 + |\nabla h| u^{\alpha-\gamma} e^{-kf} - (n-1)\lambda \right] u^{-\gamma} e^{-f}.$$

Since $\alpha = \frac{kN+2}{N+n-1}\gamma$ and $0 \leqslant \gamma \leqslant \frac{N+n-1}{N+n-2}$, then

$$0 \le \int_{\partial \Omega} \left[-\frac{\left(4k - (n-1)k^2\right)N + 4}{4(N+n-1)} X^2 + |\nabla h| u^{\alpha-\gamma} e^{-kf} - (n-1)\lambda \right] u^{-\gamma} e^{-f}.$$

Recalling $X = hu^{\alpha - \gamma}e^{-kf}$, we obtain

$$0 \leqslant \int_{\partial\Omega} \left(-\frac{\left(4k - (n-1)k^2\right)N + 4}{4(N+n-1)} u^{2\alpha - 2\gamma} e^{-2kf} h^2 + |\nabla h| u^{\alpha - \gamma} e^{-kf} - (n-1)\lambda \right) u^{-\gamma} e^{-f}$$

$$= \int_{\partial\Omega} \left(-\frac{\left(4k - (n-1)k^2\right)N + 4}{4(N+n-1)} u^{2\alpha - 2\gamma} e^{-kf} h^2 + |\nabla h| u^{\alpha - \gamma} - (n-1)\lambda e^{kf} \right) u^{-\gamma} e^{-(k+1)f},$$

as required.

Lemma 2.2. Let (M,g) be a complete Riemannian manifold and C, D be two positive constants. If $\operatorname{diam}(M,g) > \frac{\pi}{\sqrt{CD}}$, then there exist two domains $\Omega_- \subset \Omega_+ \subset M$ and function $h \in C^{\infty}(\Omega_+ \setminus \overline{\Omega_-})$ such that

- $\partial \Omega_{-} \neq \emptyset$, $\partial \Omega_{+} \neq \emptyset$ and $\overline{\Omega_{+}} \setminus \Omega_{-}$ is compact;
- $\lim_{x\to\partial\Omega_{-}} h(x) = +\infty$ and $\lim_{x\to\partial\Omega_{+}} h(x) = -\infty$ uniformly;
- $\bullet |\nabla h| < Ch^2 + D.$

Proof. This lemma is proved in the argument of [1, Lemma 1].

Now we are in a position to prove diameter comparison when $3 \leq n \leq 7$.

Proof of (1) in Theorem 1.2 when $3 \le n \le 7$. When the constant k satisfies

$$\frac{kN+2}{N+n-1} \le 1$$
 and $\frac{(4k-(n-1)k^2)N+4}{4(N+n-1)} > 0$,

we have $\alpha = \frac{kN+2}{N+n-1}\gamma \leqslant \gamma$ and define two positive constants by

$$C = \frac{(4k - (n-1)k^2)N + 4}{4(N+n-1)} \cdot \frac{(\sup_M u)^{2\alpha - 2\gamma}}{(\inf_M u)^{\alpha - \gamma}} \cdot e^{-|k|F}$$

and

$$D = (n-1)\lambda \left(\inf_{M} u\right)^{\gamma-\alpha} e^{-|k|F}.$$

Then Lemma 2.1 shows

$$0 \leqslant \int_{\partial\Omega} \left(|\nabla h| u^{\alpha-\gamma} - C \left(\inf_{M} u \right)^{\alpha-\gamma} h^{2} - D \left(\inf_{M} u \right)^{\alpha-\gamma} \right) u^{-\gamma} e^{-(k+1)f}$$

$$\leqslant \int_{\partial\Omega} \left(|\nabla h| - Ch^{2} - D \right) u^{-\alpha-2\gamma} e^{-(k+1)f}.$$

If $\operatorname{diam}(M,g) > \frac{\pi}{\sqrt{CD}}$, then we choose h as in Lemma 2.2 and obtain a contradiction. Thus $\operatorname{diam}(M,g) \leqslant \frac{\pi}{\sqrt{CD}}$ and so

$$\operatorname{diam}(M,g) \leqslant \left(\frac{\sup_M u}{\inf_M u}\right)^{\gamma-\alpha} \cdot \sqrt{\frac{4(N+n-1)}{\left(4k-(n-1)k^2\right)N+4}} \cdot \sqrt{\frac{e^{2|k|F}}{n-1}} \cdot \frac{\pi}{\sqrt{\lambda}}.$$

When N > 0, we choose k = 0. Then $\alpha = \frac{2\gamma}{N+n-1}$ and

$$\operatorname{diam}(M,g) \leqslant \left(\frac{\sup_{M} u}{\inf_{M} u}\right)^{\frac{N+n-3}{N+n-1}\gamma} \cdot \sqrt{\frac{N+n-1}{n-1}} \cdot \frac{\pi}{\sqrt{\lambda}}.$$

When N < -(n-1), we choose $k = \frac{2}{n-1}$. Then $\alpha = \frac{2\gamma}{n-1}$ and

$$\operatorname{diam}(M,g) \leqslant \left(\frac{\sup_{M} u}{\inf_{M} u}\right)^{\frac{n-3}{n-1}\gamma} \cdot e^{\frac{2}{n-1}F} \cdot \frac{\pi}{\sqrt{\lambda}}.$$

2.2. The case $n \ge 8$. In this case, $\partial\Omega$ may have singularities. The diameter comparison can be proved by modifying the argument (of the case $3 \le n \le 7$) verbatim as in [1, Proof of Lemma 1 $(n \ge 8)$ in Appendix A].

3. Global weighted volume comparison

To establish the global weighted volume comparison, we first recall the following ODE comparison (see e.g. [1, Lemma 4]).

Lemma 3.1. Let $V_1 \in (0, +\infty)$ be a constant and $J : [0, V_1) \to \mathbb{R}$ be a continuous function such that

- (a) J(0) = 0 and J(v) > 0 for $v \in (0, V_1)$;
- (b) $\limsup_{v \to 0^+} v^{-\frac{n-1}{n}} J(v) \leqslant n \operatorname{Vol}(\mathbb{B}^n)^{\frac{1}{n}}$.

(c) $J''J \leq -\frac{(J')^2}{n-1} - (n-1)\Lambda$ in the viscosity sense on $(0, V_1)$ for some positive constant Λ ;

Then $V_1 \leqslant \Lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n)$.

We assume without loss of generality that $\inf_M u = 1$. Set

$$\alpha = \frac{2\gamma}{n-1}, \quad k = \frac{2}{n-1}.$$

By (1) of Theorem 1.2, M is compact and so $V_0 := \int_M u^{\alpha} e^{-(k+1)f}$ is finite. Define the weighted isoperimetric profile:

$$I(v) = \inf \left\{ \int_{\partial^* E} u^{\gamma} e^{-f} : E \Subset M \text{ has finite perimeter, and } \int_E u^{\alpha} e^{-(k+1)f} = v \right\}$$

for all $v \in [0, V_0)$, where $\partial^* E$ denotes the reduced boundary of E. It is clear that

(3.1)
$$I(0) = 0 \text{ and } I(v) > 0 \text{ for } v \in (0, V_0).$$

Using an argument similar to [7, Proposition 5.3], I is a continuous function on $[0, V_0)$.

Since $\inf_M u = 1$ and M is compact, then there exists a point $x_0 \in M$ such that $u(x_0) = 1$. When $r \ll 1$, we have the asymptotical expansion:

$$\int_{B_r(x_0)} e^{-(k+1)f} = \operatorname{Vol}(\mathbb{B}^n) r^n e^{-(k+1)f(x_0)} + O(r^{n+1})$$

and

$$\int_{\partial B_r(x_0)} e^{-f} = n \operatorname{Vol}(\mathbb{B}^n) r^{n-1} e^{-f(x_0)} + O(r^n).$$

By the definition of I, when $v \ll 1$, we have

$$I(v) \leqslant n \operatorname{Vol}(\mathbb{B}^{n})^{\frac{1}{n}} v^{\frac{n-1}{n}} e^{\frac{(n-1)(k+1)-n}{n} f(x_{0})} + o(v^{\frac{n-1}{n}})$$

$$= n \operatorname{Vol}(\mathbb{B}^{n})^{\frac{1}{n}} v^{\frac{n-1}{n}} e^{\frac{1}{n} f(x_{0})} + o(v^{\frac{n-1}{n}})$$

$$\leqslant n \operatorname{Vol}(\mathbb{B}^{n})^{\frac{1}{n}} v^{\frac{n-1}{n}} e^{\frac{1}{n} F} + o(v^{\frac{n-1}{n}}),$$

where we used $k = \frac{2}{n-1}$ in the second line. This shows

(3.2)
$$\limsup_{v \to 0^+} v^{-\frac{n-1}{n}} I(v) \leqslant n \operatorname{Vol}(\mathbb{B}^n)^{\frac{1}{n}} e^{\frac{1}{n}F}.$$

For each $v_0 \in (0, V_0)$ and let E be the volume-constrained minimizer of v_0 , i.e.

$$\int_{E} u^{\alpha} e^{-(k+1)f} = v_{0}, \quad \int_{\partial^{*}E} u^{\gamma} e^{-f} = I(v_{0}).$$

The classical geometric measure theory (see e.g. [15, Section 3.10]) shows that ∂E is smooth when $n \leq 7$ while the singular part of ∂E has Hausdorff dimension no more than n-8.

3.1. The case $3 \le n \le 7$.

Lemma 3.2. The function I satisfies

$$I''I \leqslant -\frac{(I')^2}{n-1} - (n-1)\lambda e^{-2kF}$$
 in the viscosity sense on $(0, V_0)$.

Proof. Fix $v_0 \in (0, V_0)$ and let E be the above volume-constrained minimizer of v_0 . For any $\varphi \in C^{\infty}(M)$, let $\{E_t\}_{t \in (-\varepsilon, \varepsilon)}$ be a smooth family of sets satisfying

- $E_0 = E$;
- $\frac{\partial E_t}{\partial t} = \varphi \nu$, where ν denotes the outer unit normal of ∂E_t .

Write

$$V(t) = \int_{E_t} u^{\alpha} e^{-(k+1)f}, \quad A(t) = \int_{\partial E_t} u^{\gamma} e^{-f}.$$

Direct calculation shows

$$V'(0) = \int_{\partial E} u^{\alpha} e^{-(k+1)f} \varphi,$$

$$V''(0) = \int_{\partial F} \left(H + \alpha u^{-1} u_{\nu} - (k+1) f_{\nu} \right) u^{\alpha} e^{-(k+1)f} \varphi^{2} + u^{\alpha} e^{-(k+1)f} \varphi \varphi_{\nu}$$

and

$$A'(0) = \int_{\partial E} (H - f_{\nu} + \gamma u^{-1} u_{\nu}) u^{\gamma} e^{-f} \varphi,$$

$$A''(0) = \int_{\partial E} \left(-\Delta_{\partial E} \varphi - \operatorname{Ric}(\nu, \nu) \varphi - |\operatorname{II}|^{2} \varphi - \operatorname{Hess} f(\nu, \nu) \varphi \right.$$
$$+ \left. \left\langle \nabla_{\partial E} f, \nabla_{\partial E} \varphi \right\rangle + \gamma u^{-1} \varphi (\Delta u - \Delta_{\partial E} u - H u_{\nu}) \right.$$
$$- \gamma u^{-2} u_{\nu}^{2} \varphi - \gamma u^{-1} \left\langle \nabla_{\partial \Omega} u, \nabla_{\partial \Omega} \varphi \right\rangle \right) u^{\gamma} e^{-f} \varphi$$
$$+ \left. \left(H - f_{\nu} + \gamma u^{-1} u_{\nu} \right) \left(\gamma u^{-1} u_{\nu} \varphi - f_{\nu} \varphi + \varphi_{\nu} + H \varphi \right) u^{\gamma} e^{-f} \varphi.$$

For later use, we simplify the expression of A''(0). By the same calculation of (2.2), we have

$$-\operatorname{Ric}(\nu,\nu)\varphi + \gamma u^{-1}\varphi\Delta u - \operatorname{Hess} f(\nu,\nu)\varphi$$
$$= (\gamma \Delta_f u - u\operatorname{Ric}_f^N(\nu,\nu))u^{-1}\varphi - \frac{1}{N}f_\nu^2\varphi + \gamma u^{-1}\varphi\langle\nabla u,\nabla f\rangle.$$

Then

$$A''(0) = \int_{\partial E} \left(-\Delta_{\partial E} \varphi - |\mathrm{II}|^2 \varphi + \left(\gamma \Delta_f u - u \mathrm{Ric}_f^N(\nu, \nu) \right) u^{-1} \varphi - \frac{1}{N} f_{\nu}^2 \varphi \right.$$
$$\left. + \gamma u^{-1} \varphi \langle \nabla u, \nabla f \rangle + \langle \nabla_{\partial E} f, \nabla_{\partial E} \varphi \rangle - \gamma u^{-2} u_{\nu}^2 \varphi \right.$$
$$\left. + \gamma u^{-1} \varphi (-\Delta_{\partial E} u - H u_{\nu}) - \gamma u^{-1} \langle \nabla_{\partial \Omega} u, \nabla_{\partial \Omega} \varphi \rangle \right.$$
$$\left. + \left(H - f_{\nu} + \gamma u^{-1} u_{\nu} \right) \left(\gamma u^{-1} u_{\nu} \varphi - f_{\nu} \varphi + \varphi_{\nu} + H \varphi \right) \right) u^{\gamma} e^{-f} \varphi.$$

Since E is a volume-constrained minimizer, we know that if

$$V'(0) = \int_{\partial E} u^{\alpha} e^{-(k+1)f} \varphi = 0,$$

then

$$A'(0) = \int_{\partial E} (H - f_{\nu} + \gamma u^{-1} u_{\nu}) u^{\gamma - \alpha} e^{kf} \cdot u^{\alpha} e^{-(k+1)f} \varphi = 0.$$

This shows

$$(H - f_{\nu} + \gamma u^{-1}u_{\nu})u^{\gamma-\alpha}e^{kf} = \text{constant on } E.$$

Next, we choose $\varphi = u^{-\gamma}$ and so

$$V'(0) = \int_{\partial E} u^{\alpha - \gamma} e^{-(k+1)f} > 0.$$

Then near 0, V(t) has the inverse function and we define $G(v) = A(V^{-1}(v))$. Observe that

$$G(v_0) = I(v_0)$$
 and $G(v) \ge I(v)$ near v_0 .

Thus G is a upper barrier of I at v_0 . To prove Lemma 3.2, it then suffices to show

(3.3)
$$G(v_0)G''(v_0) \leqslant -\frac{G'^2(v_0)}{n-1} - (n-1)\lambda e^{-2kF}.$$

Using the chain rule and the formula for the derivative of inverse function, we compute

(3.4)
$$G'(v_0) = A'(0)(V^{-1})'(v_0) = \frac{A'(0)}{V'(0)} = (H - f_{\nu} + \gamma u^{-1}u_{\nu})u^{\gamma - \alpha}e^{kf}$$

and

$$G''(v_0) = \frac{A''(0)}{V'^2(0)} - \frac{A'(0)V''(0)}{V'^3(0)} = \frac{A''(0) - G'(v_0)V''(0)}{V'^2(0)}.$$

We split the argument of (3.3) into two steps:

Step 1. Compute V''(0) and A''(0).

It is clear that

$$V''(0) = \int_{\partial E} \left(H - (k+1)f_{\nu} + (\alpha - \gamma)u^{-1}u_{\nu} \right) u^{\alpha - 2\gamma} e^{-(k+1)f}.$$

For A''(0), the same calculations of (2.3) and (2.4) show

$$-\Delta_{\partial E}\varphi - \gamma u^{-1}\varphi \Delta_{\partial E}u - \gamma u^{-1}\langle \nabla_{\partial E}u, \nabla_{\partial E}\varphi \rangle = -\gamma u^{-\gamma - 2}|\nabla_{\partial E}u|^2 \leqslant 0$$

and

$$\gamma u^{-1} \varphi \langle \nabla u, \nabla f \rangle + \langle \nabla_{\partial E} f, \nabla_{\partial E} \varphi \rangle = \gamma u^{-\gamma - 1} u_{\nu} f_{\nu}.$$

Combining the above with $|\mathrm{II}|^2 \geqslant \frac{H^2}{n-1}$ and $\gamma \Delta_f u - u \mathrm{Ric}_f^N \leqslant -(n-1)\lambda u$, we obtain

$$A''(0) \leqslant \int_{\partial E} \left(-\frac{H^2}{n-1} u^{-\gamma} - (n-1)\lambda u^{-\gamma} - \frac{1}{N} f_{\nu}^2 u^{-\gamma} + \gamma u^{-\gamma-1} u_{\nu} f_{\nu} - \gamma u^{-\gamma-2} u_{\nu}^2 - \gamma u^{-\gamma-1} H u_{\nu} + (H - f_{\nu} + \gamma u^{-1} u_{\nu}) (-f_{\nu} u^{-\gamma} + H u^{-\gamma}) \right) e^{-f}$$

$$= \int_{\partial E} \left(-\frac{H^2}{n-1} - (n-1)\lambda - \frac{1}{N} f_{\nu}^2 + \gamma u^{-1} u_{\nu} f_{\nu} - \gamma u^{-2} u_{\nu}^2 - \gamma u^{-1} H u_{\nu} + (H - f_{\nu} + \gamma u^{-1} u_{\nu}) (-f_{\nu} + H) \right) u^{-\gamma} e^{-f}.$$

Step 2. Verify (3.3).

For convenience, we introduce $X = G'(v_0)u^{\alpha-\gamma}e^{-kf}$ and $Y = u^{-1}u_{\nu}$. Then (3.4) shows

$$H = f_{\nu} + X - \gamma Y$$
.

We compute

$$G'(v_0)V''(0) = \int_{\partial E} u^{\gamma - \alpha} e^{kf} X \cdot \left(X - kf_{\nu} + (\alpha - 2\gamma)Y \right) u^{\alpha - 2\gamma} e^{-(k+1)f}$$
$$= \int_{\partial E} \left(X^2 - kXf_{\nu} + (\alpha - 2\gamma)XY \right) u^{-\gamma} e^{-f}$$

and

$$A''(0) \leqslant \int_{\partial E} \left[-\frac{(f_{\nu} + X - \gamma Y)^{2}}{n - 1} - (n - 1)\lambda - \frac{1}{N} f_{\nu}^{2} + \gamma Y f_{\nu} \right.$$
$$- \gamma Y^{2} - \gamma Y (f_{\nu} + X - \gamma Y) + X (X - \gamma Y) \right] u^{-\gamma} e^{-f}$$
$$= \int_{\partial E} \left[-(n - 1)\lambda - \left(\frac{1}{n - 1} + \frac{1}{N}\right) f_{\nu}^{2} - \frac{2}{n - 1} X f_{\nu} \right.$$
$$+ \frac{2\gamma}{n - 1} Y f_{\nu} + \left(1 - \frac{1}{n - 1}\right) X^{2} + \left(\frac{2\gamma}{n - 1} - 2\gamma\right) X Y$$
$$+ \left(\frac{n - 2}{n - 1} \gamma^{2} - \gamma\right) Y^{2} \right] u^{-\gamma} e^{-f}.$$

It then follows that

$$A''(0) - G'(v_0)V''(0)$$

$$\leq \int_{\partial E} \left[-(n-1)\lambda - \frac{N+n-1}{N(n-1)} f_{\nu}^2 + \left(k - \frac{2}{n-1}\right) X f_{\nu} + \frac{2\gamma}{n-1} Y f_{\nu} \right.$$

$$\left. - \frac{1}{n-1} X^2 + \left(\frac{2\gamma}{n-1} - \alpha\right) X Y + \left(\frac{n-2}{n-1} \gamma^2 - \gamma\right) Y^2 \right] u^{-\gamma} e^{-f}.$$

Recalling
$$k = \frac{2}{n-1}$$
 and $\alpha = \frac{2\gamma}{n-1}$,
 $A''(0) - G'(v_0)V''(0)$
 $\leq \int_{\partial E} \left[-(n-1)\lambda - \frac{1}{n-1}X^2 - \frac{N+n-1}{N(n-1)}f_{\nu}^2 + \frac{2\gamma}{n-1}Yf_{\nu} + \left(\frac{n-2}{n-1}\gamma^2 - \gamma\right)Y^2\right]u^{-\gamma}e^{-f}.$

Using

$$-\frac{N+n-1}{N(n-1)}f_{\nu}^{2} + \frac{2\gamma}{n-1}Yf_{\nu} \leqslant \frac{N\gamma^{2}}{(N+n-1)(n-1)}Y^{2}$$

and $0 \leqslant \gamma \leqslant \frac{N+n-1}{N+n-2}$, we obtain

$$A''(0) - G'(v_0)V''(0)$$

$$\leq \int_{\partial E} \left[-(n-1)\lambda - \frac{1}{n-1}X^2 + \left(\frac{N+n-2}{N+n-1}\gamma^2 - \gamma\right)Y^2\right] u^{-\gamma}e^{-f}$$

$$\leq \int_{\partial E} \left(-(n-1)\lambda - \frac{1}{n-1}X^2\right)u^{-\gamma}e^{-f}.$$

Combining this with $V'(0) = \int_{\partial E} u^{\alpha - \gamma} e^{-(k+1)f}$ and $X = G'(v_0)u^{\alpha - \gamma} e^{-kf}$,

$$G''(v_0) = \frac{A''(0) - G'(v_0)V''(0)}{V'^2(0)}$$

$$\leqslant -(n-1)\lambda \cdot \frac{\int_{\partial E} u^{-\gamma} e^{-f}}{\left(\int_{\partial E} u^{\alpha-\gamma} e^{-(k+1)f}\right)^2} - \frac{G'^2(v_0)}{n-1} \cdot \frac{\int_{\partial E} u^{2\alpha-3\gamma} e^{-(2k+1)f}}{\left(\int_{\partial E} u^{\alpha-\gamma} e^{-(k+1)f}\right)^2}.$$

Recalling $\inf_M u = 1$ and $\gamma \geqslant \alpha$,

$$\begin{split} \int_{\partial E} u^{-\gamma} e^{-f} &= \int_{\partial E} u^{2\gamma - 2\alpha} e^{2kf} \cdot u^{2\alpha - 3\gamma} e^{-(2k+1)f} \\ &\geqslant e^{-2kF} \int_{\partial E} u^{2\alpha - 3\gamma} e^{-(2k+1)f}. \end{split}$$

It then follows that

$$G''(v_0) \leqslant \left(-(n-1)\lambda e^{-2kF} - \frac{G'^2(v_0)}{n-1} \right) \cdot \frac{\int_{\partial E} u^{2\alpha - 3\gamma} e^{-(2k+1)f}}{\left(\int_{\partial E} u^{\alpha - \gamma} e^{-(k+1)f} \right)^2}.$$

Using the Cauchy-Schwarz inequality

$$\begin{split} \left(\int_{\partial E} u^{\alpha-\gamma} e^{-(k+1)f}\right)^2 &= \left(\int_{\partial E} u^{\alpha-\frac{3}{2}\gamma} e^{-k-\frac{1}{2}f} \cdot u^{\frac{1}{2}\gamma} e^{-\frac{1}{2}f}\right)^2 \\ &\leqslant \left(\int_{\partial E} u^{2\alpha-3\gamma} e^{-(2k+1)f}\right) \left(\int_{\partial E} u^{\gamma} e^{-f}\right), \end{split}$$

we see that

$$G''(v_0) \le \left(-(n-1)\lambda e^{-2kF} - \frac{G'^2(v_0)}{n-1} \right) \cdot \frac{1}{\int_{\partial E} u^{\gamma} e^{-f}}.$$

Recalling
$$G(v_0) = I(v_0) = \int_{\partial E} u^{\gamma} e^{-f}$$
, we obtain (3.3).

Proof of (2) in Theorem 1.2 when $3 \le n \le 7$. Combining Lemma 3.1, (3.1), (3.2) and Lemma 3.2, the function $J := e^{-\frac{F}{n}}I$ is a continuous function on $[0, V_1)$ satisfies the assumptions (a)-(c) in Lemma 3.1 with $V_1 = e^{-\frac{F}{n}}V_0$ and $\Lambda = \lambda e^{-(2k + \frac{2}{n})F}$. Then

$$e^{-\frac{F}{n}}V_0 \leqslant \left(\lambda e^{-\left(2k+\frac{2}{n}\right)F}\right)^{-\frac{n}{2}}\operatorname{Vol}(\mathbb{S}^n)$$

and so

$$V_0 \leqslant e^{\left(kn+1+\frac{1}{n}\right)F} \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n).$$

By $\inf_M u = 1$ and $\alpha \geqslant 0$, we have

$$V_0 = \int_M u^{\alpha} e^{-(k+1)f} \geqslant e^{-kF} \int_M e^{-f} = e^{-kF} \text{Vol}_f(M, g).$$

Combining the above and recalling $k = \frac{2}{n-1}$,

$$\operatorname{Vol}_f(M,g)\leqslant e^{\frac{(n+1)(3n-1)}{n(n-1)}F}\cdot \lambda^{-\frac{n}{2}}\operatorname{Vol}(\mathbb{S}^n).$$

3.2. The case $n \ge 8$. In this case, ∂E may have singularities. The global volume comparison can be proved by modifying the argument (of the case $3 \le n \le 7$) verbatim as in [1, Proof of Lemma 2 $(n \ge 8)$ in Appendix A].
