# Effective Medium Theory for Time-modulated Subwavelength Resonators

#### Abstract

This paper provides a general framework for deriving effective material properties of time-modulated systems of subwavelength resonators. It applies to subwavelength resonator systems with a general form of time-dependent parameters. We show that the resonators can be accurately described by a point-scattering formulation when the width of the resonators is small. In contrast to the static setting, where this point interaction approximation yields a Lippmann-Schwinger equation for the effective material properties, the mode coupling in the time-modulated case instead yields an infinite linear system of Lippmann-Schwingertype equations. The effective equations can equivalently be written as a system of integrodifferential equations. Moreover, we introduce a numerical scheme to approximately solve the system of coupled equations and illustrate the validity of the effective equation.

## 1 Introduction

This paper is devoted to deriving the homogenised equation of one-dimensional time-dependent metamaterials. The theory of homogenisation is central to a plethora of physical and engineering applications [\[17\]](#page-17-0). Homogenisation provides a way to transition from the detailed, small-scale description to an effective large-scale description, simplifying analysis and computation while preserving essential features. The homogenisation of a metamaterial with time-dependent parameters contributes significantly to the exploration of time-dependent materials. We specifically opt to study one-dimensional materials since they allow a more detailed exploration of the effect of time modulations. Several results have been shown in the one-dimensional time-dependent setting, such as the existence of space-time localised modes [\[4\]](#page-17-1), the capacitance matrix approximation [\[1\]](#page-16-0) and the rigorous definition of the scattered wave field based on a given incident wave field [\[2\]](#page-16-1).

Our theory in this paper provides a general framework for the effective medium theory of time-modulated subwavelength metamaterials. It applies to subwavelength resonator systems where the modulation frequency is of the same order as the subwavelength quasifrequencies and

the operating frequency  $(i.e.,$  the frequency of the incident wave) is in the low-frequency regime. It also generalises to higher space dimensions. In contrast to this paper, previous works have successfully established an effective medium theory for the low-frequency regime, in which the operating frequency is significantly smaller than the resonant frequency and the material parameters are static in time [\[6,](#page-17-2) [7,](#page-17-3) [15\]](#page-17-4). Furthermore, it is worth emphasising that the time-modulations considered in this paper are very different from the travelling wave-form modulations discussed in [\[14,](#page-17-5) [16,](#page-17-6) [18,](#page-17-7) [19\]](#page-17-8) and in the references therein. By exploiting the subwavelength resonances of the system, they lead to fundamentally different wave propagation and scattering phenomena [\[2\]](#page-16-1). Moreover, their mathematical treatment is more involved. On the other hand, numerous papers have established an effective medium theory for subwavelength resonator systems based on the point interaction approximation [\[10,](#page-17-9) [11\]](#page-17-10) resulting in the Lippmann-Schwinger equation [\[3,](#page-16-2) [5,](#page-17-11) [8,](#page-17-12) [9,](#page-17-13) [12\]](#page-17-14). In contrast to the static setting, we are faced with a coupled problem in the timemodulated case, which yields an infinite linear system of Lippmann-Schwinger-type equations instead. Moreover, implementing the point interaction approximation under the assumption of time-dependent material parameters is highly non-trivial, as there are two subwavelength quasifrequencies for a single time-modulated resonator. We shall see that, under suitable assumptions on volume fraction, configuration and incident frequency, we can adapt the results valid in the static case [\[5\]](#page-17-11) to hold true in the time-modulated case.

In this paper, we follow an approach involving the scattering matrix, which we shall define from first principles for both static and time-dependent metamaterials. We show that the scattering matrix has a characteristic structure in the leading-order terms as the resonators become small, which furnishes the point interaction approximation. We recall that the idea of a point interaction approximation goes back to Foldy's paper [\[12\]](#page-17-14). It is a natural tool to analyse a variety of interesting problems in the continuum limit.

Our point-scattering formulation is highly relevant in its own right, as the scattering matrix describes the coupling of different frequency harmonics and quantifies the frequency conversion due to the time-modulated parameters. Moreover, by taking the continuum limit, we derive the homogenised governing ordinary differential equation, which models the effective macroscopic behaviour while averaging out the fine-scale variations. This allows the introduction of a timedependent one-dimensional effective medium theory, i.e., a theoretical framework to describe the macroscopic properties of heterogeneous time-dependent one-dimensional metamaterials in terms of their microscopic structure. The assumption of time-modulated material parameters in the derivation of an effective medium theory marks a new milestone in the mathematical exploration of metamaterials. Unlike the static case, we obtain a system of coupled Lippmann-Schwinger equations instead of a single equation [\[5\]](#page-17-11). This is due to the mode coupling that occurs as a consequence of time modulation.

We start by providing an overview of the mathematical and physical setting of the problem considered herein in Section [2.](#page-2-0) In Section [3](#page-4-0) we focus on one-dimensional metamaterials with static properties and derive the homogenised equation by introducing a scattering matrix and exploiting its structure. Although our main focus is on the time-modulated case, the static metamaterials serve as a concise introduction to our methods and ideas. This method is used to obtain an effective medium theory in Section [4](#page-7-0) for time-modulated metamaterials. To achieve this, we explicitly compute the scattering matrix as the resonators become smaller. Finally, we solve the effective equation numerically in Section [5](#page-14-0) with a uniquely tailored numerical scheme. We summarise our results and conclusions in Section [6.](#page-16-3)

## <span id="page-2-0"></span>2 Problem Setting

<span id="page-2-1"></span>We consider a finite medium  $\mathcal{U} \subset \mathbb{R}$ , which contains N disjoint high-contrast subwavelength resonators  $(D_i)_{i=1,\dots,N}$ . Each resonator is defined as an open interval  $D_i := (x_i^-, x_i^+)$  of length  $\ell_i := x_i^+ - x_i^-$  with a separation distance  $\ell_{i(i+1)} := x_{i+1}^- - x_i^+$ , for all  $i = 1, \ldots, N$ . We denote the centre of each resonator by  $z_i = (x_i^+ + x_i^+)/2$ . In the remainder of this paper we shall assume that each resonator is of length  $\ell$  and that they are evenly spaced. We refer to Figure [2.1](#page-2-1) for an illustration of the geometrical setup of the material.



Figure 2.1: An illustration of the domain  $U$  with N resonators.

We denote the material parameters inside the resonator  $D_i$  by  $\kappa_r \kappa_i(t)$  and  $\rho_r$ . We write:

$$
\rho(x) = \begin{cases} \rho_0, & x \notin D, \\ \rho_r, & x \in D_i, \end{cases} \qquad \kappa(x, t) = \begin{cases} \kappa_0, & x \notin D, \\ \kappa_r \kappa_i(t), & x \in D_i. \end{cases} \tag{2.1}
$$

In the acoustic setting we refer to  $\rho$  as the material's density and to  $\kappa$  as the material's bulk modulus. For our numerical simulations we shall consider

$$
\kappa_i(t) := \frac{1}{1 + \varepsilon_{\kappa,i} \cos\left(\Omega t + \phi_{\kappa,i}\right)},\tag{2.2}
$$

for all  $1 \le i \le N$ , where  $\varepsilon_{\kappa,i} \in [0,1)$  are the amplitudes of the time-modulations and  $\phi_{\kappa,i} \in [0,2\pi)$ the phase shifts.

Identically as in [\[2\]](#page-16-1), we introduce the contrast parameter and the wave speeds

$$
\delta := \frac{\rho_r}{\rho_0}, \quad v_0 := \sqrt{\frac{\kappa_0}{\rho_0}}, \quad v_r := \sqrt{\frac{\kappa_r}{\rho_r}}, \tag{2.3}
$$

respectively. We consider a wave field  $u(x, t)$  given by

$$
u(x,t) = \sum_{n=-\infty}^{\infty} v_n(x) e^{-i(\omega + n\Omega)t},
$$

which is furnished by the assumption that  $u(x, t)e^{i\omega t}$  is periodic with respect to t with period T, where  $\omega$  is the frequency of the incident wave. Note that the total wave field u consists the scattered wave field and the incident wave field, in particular,

$$

and the modes of  $u^{sc}(x, t)$  and  $u^{in}(x, t)$  are given given by  $v_n^{sc}(x)$  and  $v_n^{in}(x)$ , respectively. We shall give a closed form definition of the incident wave field in Section [3.](#page-4-0)

The governing equations posed on the modes  $v_n$ , can be derived to be the following [\[2\]](#page-16-1):

We refer to  $[2,$  Appendix A for a detailed derivation of  $(2.6)$ . The wave number corresponding to the n-th mode inside and outside of the resonators is defined by

$$
k_{\mathbf{r}}^{(n)} := \frac{\omega + n\Omega}{v_{\mathbf{r}}}, \quad k^{(n)} := \frac{\omega + n\Omega}{v_0},
$$

respectively. The functions  $v_{i,n}^{**}(x)$  are defined through the convolution

$$
v_{i,n}^{**}(x) = \frac{1}{\omega + n\Omega} \sum_{m=-\infty}^{\infty} k_{i,m}(\omega + (n-m)\Omega)v_{n-m}(x), \quad \forall x \in D_i,

where  $k_{i,m}$  are the Fourier series coefficients of  $1/\kappa_i(t)$ :

$$

The following proposition summarises the results derived in previous papers [\[1,](#page-16-0) [2\]](#page-16-1):

<span id="page-3-2"></span>**Proposition 2.1.** The Fourier modes  $v_n(x)$  of the wave field  $u(x,t)$  solving [\(2.6\)](#page-3-0) are given by

$$

where the coefficients  $\alpha_n^i$ ,  $\beta_n^i$ ,  $\alpha_j^i$ ,  $b_j^i$  need to be determined for all  $i = 1, ..., N$ ,  $j, n \in \mathbb{Z}$ . The eigenpairs  $(\lambda^i_j, \mathbf{f}^{j,i})$  $\sum\limits_{i \in \mathbb{Z}} \, \, \text{corresponding to the $i$-th resonator can be obtained as stated in [2, Lemma}$  $\sum\limits_{i \in \mathbb{Z}} \, \, \text{corresponding to the $i$-th resonator can be obtained as stated in [2, Lemma}$  $\sum\limits_{i \in \mathbb{Z}} \, \, \text{corresponding to the $i$-th resonator can be obtained as stated in [2, Lemma}$  $2.1$ ].

<span id="page-3-1"></span>**Remark 2.2.** The wave field  $u(x, t)$  has infinitely many modes  $v_n(x)$ , which is problematic for the numerical implementation of the equations. Thus, we truncate the Fourier series by a truncation parameter  $K \in \mathbb{N}$ :

$$
u(x,t) = \sum_{n=-K}^{K} v_n(x)e^{-i(\omega+n\Omega)t}.

## <span id="page-4-0"></span>3 Static Metamaterial

In this section, we shall focus on metamaterials with static material parameters. We aim to obtain the homogenised governing equation in a manner equivalent to [\[5\]](#page-17-11), but for a one-dimensional material. The method we introduce will be later generalised to the time-modulated case in Section [4.](#page-7-0)

### 3.1 Transfer and Scattering Matrices

First we introduce the one-dimensional transfer matrix and the scattering matrix.

**Proposition 3.1.** Consider the resonator  $D_i$ , and let the wave field on the left- and right-hand sides of  $D_i$  be given by  $v(x) = \alpha^i e^{ikx} + \beta^i e^{-ikx}$  and  $v(x) = \alpha^{i+1} e^{ikx} + \beta^{i+1} e^{-ikx}$ , respectively. Then the transfer matrix  $\tilde{S}_i$  corresponding to  $D_i$  is given by

$$

with coefficients given by

Furthermore, the scattering matrix  $S_i$  is defined by

*Proof.* If we let the interior wave field be given by  $v(x) = ae^{ik_rx} + be^{-ik_rx}$ ,  $x \in D_i$ , the continuity and transmission conditions give us

and rewriting and grouping the equations [\(3.5\)](#page-4-1) and [\(3.6\)](#page-4-2), we obtain

which is exactly  $(3.2)$ . Lastly, it is a straightforward task to obtain the expression of  $S_i$  in terms of  $\tilde{S}_i$ .  $\Box$ 

With the explicit formula for  $S_i$  at hand, we will derive a point-scattering approximation in the limit when the resonator length  $\ell$  tends to zero. To fix the asymptotic regime, we will consider the subwavelength regime where  $\omega = O(\ell)$  and  $\delta = O(\ell)$  as  $\ell \to 0$ . In the remainder of this paper, we will denote the  $n \times n$  identity matrix by  $I_n$ .

<span id="page-5-2"></span>**Lemma 3.2.** Let the N resonators each be of length  $\ell$  and centred around  $z_i$ , and set  $\delta = \gamma \ell$ and  $\omega = \mu \ell$ , for fixed  $\gamma$ ,  $\mu > 0$  independent of  $\ell$ . As  $\ell \to 0$ , the following holds:

*Proof.* The above form of  $S_i$  can be obtained by expanding the coefficients  $a_i$ ,  $b_i$ ,  $c_i$ ,  $d_i$  in  $\ell$  and omitting higher-order terms.  $\Box$ 

**Remark 3.3.** By plugging in  $(3.8)$  into  $(3.3)$ , we obtain

Let the total wave field  $u(x,t) = e^{-i\omega t}v(x)$  be given by

where  $v^{\text{in}}(x) := \alpha^1 e^{ikx} + \beta^{N+1} e^{-ikx}$  is the overall incident wave on the system of N resonators. Moreover, we denote the incident wave field on  $D_i$  by  $v_i^{\text{in}}(x)$  and the scattered wave field of  $D_i$ by  $v_i^{\rm sc}(x)$ . The incident and scattered wave field of  $D_i$  are given by

$$

Using the definition of the Green's function [\(3.11\)](#page-5-1) one obtains the following characterisation:

<span id="page-6-0"></span>
$$
v_i^{\rm sc}(x) = \tilde{g}G^k(x - z_i)v_i^{\rm in}(z_i),\tag{3.14}
$$

where  $\tilde{q} := 2ikq$ , with g as defined in Lemma [3.2.](#page-5-2) Equation [\(3.14\)](#page-6-0) is a point-scattering approximation for a static resonator, which characterises the scattered wave from  $D_i$  in terms of the Green's function. This formula sets the ground to derive the homogenised equation equivalently as in [\[5\]](#page-17-11).

#### 3.2 Homogenised Equation

In this section, we shall obtain the homogenised equation using our previous results. First, we substitute the scattered wave field of  $D_i$  [\(3.14\)](#page-6-0) into the incident wave field [\(3.13\)](#page-5-3) of  $D_i$  and evaluate at  $z_i$ :

$$
v_i^{\text{in}}(z_i) = v^{\text{in}}(z_i) + \sum_{j \neq i} \tilde{g} G^k(z_i - z_j) v_j^{\text{in}}(z_j). \tag{3.15}
$$

Equation [\(3.15\)](#page-6-1) is a linear system of equations: define the vectors  $\mathbf{x}, \mathbf{b} \in \mathbb{C}^N$  and the matrix  $T \in \mathbb{C}^{N \times N}$  with entries

$$
x_i := v_i^{\text{in}}(z_i), \quad b_i := v^{\text{in}}(z_i), \quad T_{ij} := \begin{cases} \tilde{g} G^k(z_i - z_j), & i \neq j, \\ 0, & i = j, \end{cases}
$$
(3.16)

then [\(3.15\)](#page-6-1) leads to the following:

<span id="page-6-5"></span><span id="page-6-2"></span><span id="page-6-1"></span>
$$
\mathbf{x} - T\mathbf{x} = \mathbf{b}.\tag{3.17}
$$

In order to homogenise our system, we must assume that while the number of resonators grows, they are still well-separated, which means that their size simultaneously decreases. In other words, we consider an asymptotic regime where the volume fraction of resonators is fixed.

<span id="page-6-3"></span>**Assumption 3.4.** Assume that there exists a constant  $\Lambda > 0$  such that  $N\ell = \Lambda$ , for all  $N, \ell > 0$ .

Next, we have

$$
\tilde{g} = \frac{i\ell\mu v}{2\gamma v_{\rm r}^2} \frac{2i\mu\ell}{v} = -\frac{1}{N} \frac{\mu^2 \ell}{\gamma v_{\rm r}^2} \Lambda =: \frac{1}{N} \beta \Lambda.
$$
\n(3.18)

Hence, we can conclude that

$$
v_i^{\text{in}}(z_i) = v^{\text{in}}(z_i) + \frac{1}{N} \sum_{j \neq i} \beta \Lambda G^k(z_i - z_j) v_j^{\text{in}}(z_j). \tag{3.19}
$$

Following [\[5\]](#page-17-11), we introduce the limiting density  $\tilde{V}(x)$  of resonators.

<span id="page-6-4"></span>Assumption 3.5. Let  $A \subset \mathbb{R}$  be a measurable set, we define

$$
\Theta^N(A) := \frac{1}{N} \times \{number \ of \ points \ z_i \in A\}.
$$
\n(3.20)

Assume that there exists  $\tilde{V} \in L^{\infty}(\mathcal{U})$  such that

<span id="page-6-6"></span>
$$
\Theta^N(A) \to \int_A \tilde{V}(x) dx \quad as \ N \to \infty. \tag{3.21}
$$

We define the  $L^{\infty}$ -function  $V(x) := \beta \Lambda \tilde{V}(x)$ . The following assumption is feasible based on [\[5,](#page-17-11) Lemma 4.1].

<span id="page-7-3"></span>**Assumption 3.6.** We assume that for any  $f \in C^{0,\alpha}(\mathcal{U})$ 

$$
\max_{1 \le i \le N} \left| \frac{1}{N} \sum_{j \ne i} \beta \Lambda G^k (z_i - z_j) f(z_j) - \int_{\mathcal{U}} G^k (z_i - y) V(y) f(y) \, dy \right| \le \frac{C}{N^{\alpha/3}} ||f||_{C^{0,\alpha}(\mathcal{U})},\tag{3.22}
$$

for some constants  $0 < \alpha < 1$  and  $C > 0$ .

We now define the operator  $\mathcal{T}: C^{0,\alpha}(\mathcal{U}) \to C^{0,\alpha}(\mathcal{U})$  by

$$
\mathcal{T}f(x) := \int_{\mathcal{U}} G^k(x - y) V(y) f(y) \, \mathrm{d}y. \tag{3.23}
$$

Analogously as in [\[5\]](#page-17-11), this operator can be seen as the continuum limit of the matrix operator T. Since we define  $\mathcal T$  in an equivalent manner as in the higher-dimensional case, the properties proven in [\[5,](#page-17-11) Lemma 4.2] still hold true in one dimension.

Let  $v^i \in C^{0,\alpha}(\mathcal{U})$ , if  $\psi$  is the unique solution of  $\psi - \mathcal{T}\psi = v^i$ , then

<span id="page-7-4"></span><span id="page-7-1"></span>
$$
\left(\frac{\mathrm{d}^2}{\mathrm{d}x^2} + k^2\right)\psi - V\psi = 0 \quad \text{in } \mathbb{R},\tag{3.24}
$$

which is exactly the homogenised equation. Similarly as in [\[5\]](#page-17-11), it can be proven that  $\psi$  is the continuum limit of the solution  $x$  to  $(3.17)$ .

## <span id="page-7-0"></span>4 Time-dependent Metamaterial

 $\epsilon$ 

In this section, we focus on time-dependent materials and obtain a homogenised equation. For that, we follow an equivalent approach as in Section [3.](#page-4-0) Note that, as explained in Remark [2.2,](#page-3-1) we work with a truncated system with Fourier series of length K.

Our aim is first to define the transfer and scattering matrix for time-dependent materials. To do so, we write out the continuity conditions and transmission conditions:

$$
\begin{cases}\n\alpha_n^i e^{ik^{(n)}x_i^-} + \beta_n^i e^{-ik^{(n)}x_i^-} = \sum_{j=-K}^K \left( a_j^i e^{i\lambda_j^i x_i^-} + b_j^1 e^{-i\lambda_j^i x_i^-} \right) f_n^{j,i}, \\
\alpha_n^{i+1} e^{ik^{(n)}x_i^+} + \beta_n^{i+1} e^{-ik^{(n)}x_i^+} = \sum_{j=-K}^K \left( a_j^i e^{i\lambda_j^i x_i^+} + b_j^1 e^{-i\lambda_j^i x_i^+} \right) f_n^{j,i}, \\
\alpha_n^{i+1} e^{ik^{(n)}x_i^-} + \beta_n^{i+1} e^{-ik^{(n)}x_i^+} = \sum_{j=-K}^K \left( a_j^i e^{i\lambda_j^i x_i^+} + b_j^1 e^{-i\lambda_j^i x_i^+} \right) f_n^{j,i},\n\end{cases} \tag{4.1}
$$

$$
\begin{cases}\n\delta k^{(n)} \left( \alpha_n^i e^{ik^{(n)}x_i^-} - \beta_n^i e^{-ik^{(n)}x_i^-} \right) = \sum_{j=-K}^K \left( a_j^i e^{i\lambda_j^i x_i^-} - b_j^1 e^{-i\lambda_j^i x_i^-} \right) \lambda_j^i f_n^{j,i}, \\
\delta k^{(n)} \left( \alpha_n^{i+1} e^{ik^{(n)}x_i^+} - \beta_n^{i+1} e^{-ik^{(n)}x_i^+} \right) = \sum_{j=-K}^K \left( a_j^i e^{i\lambda_j^i x_i^+} - b_j^1 e^{-i\lambda_j^i x_i^+} \right) \lambda_j^i f_n^{j,i},\n\end{cases} \tag{4.2}
$$

for all  $n = -K, \ldots, K$ . Next, we define a matrix  $F_i := (f_n^{j,i})_n^K$  $n_{n,j=-K}^{\prime}$  and its inverse  $G_i := F_i^{-1}$ . We will rewrite the above four equations, which hold for all  $n = -K, \ldots, K$ , into a single matrix equation. We introduce the following notation for the unknown coefficients:

$$
\boldsymbol{\alpha}^{i} := \begin{bmatrix} \alpha_{-K}^{i} \\ \vdots \\ \alpha_{K}^{i} \end{bmatrix}, \quad \boldsymbol{\beta}^{i} := \begin{bmatrix} \beta_{-K}^{i} \\ \vdots \\ \beta_{K}^{i} \end{bmatrix}, \quad \mathbf{w}^{i} := \begin{bmatrix} \boldsymbol{\alpha}^{i} \\ \boldsymbol{\beta}^{i} \end{bmatrix}, \quad \mathbf{v}_{j}^{i} := \begin{bmatrix} u_{j}^{i} \\ b_{j}^{i} \end{bmatrix}, \quad \mathbf{v}^{i} := \begin{bmatrix} \mathbf{v}_{-K}^{i} \\ \vdots \\ \mathbf{v}_{K}^{i} \end{bmatrix}.
$$
 (4.3)

For the sake of simplicity, we omit the indices  $i$  in the following notation. Then we introduce the matrices

$$
E_{\pm} := \text{diag}\left(e^{\pm ik^{(n)}x^{+}}\right)_{n=-K}^{K}, \quad K := \text{diag}\left(k^{(n)}\right)_{n=-K}^{K},\tag{4.4}
$$

$$
T^{\pm} := \text{diag}\left(\left[e^{i\lambda_j^i x^{\pm}}, e^{-i\lambda_j^i x^{\pm}}\right]\right)_{j=-K}^K, \quad T_{\lambda}^{\pm} := \text{diag}\left(\left[\lambda_j^i e^{i\lambda_j^i x^{\pm}}, -\lambda_j^i e^{-i\lambda_j^i x^{\pm}}\right]\right)_{j=-K}^K, \tag{4.5}
$$

$$
\mathcal{M}^- := \begin{bmatrix} GE_- & GE_+ \\ \delta GKE_- & -\delta GKE_+ \end{bmatrix}, \quad \mathcal{T}^- := \begin{bmatrix} T^- \\ T_\lambda^- \end{bmatrix}, \quad \mathcal{M}^+ := \begin{bmatrix} E_+ & E_- \\ \delta KE_+ & -\delta KE_- \end{bmatrix}, \quad \mathcal{T}^+ := \begin{bmatrix} FT^+ \\ FT^+_\lambda \end{bmatrix}.
$$
\n(4.6)

With this notation it can be proven that  $(4.1)$  and  $(4.2)$  are equivalent to

<span id="page-8-0"></span>
$$
\mathcal{M}^-\mathbf{w}^i = \mathcal{T}\mathbf{v}^i, \quad \mathcal{M}^+\mathbf{w}^{i+1} = \mathcal{T}^+\mathbf{v}^i.
$$
 (4.7)

We have now transformed the four equations  $(4.1)$  and  $(4.2)$  that are true for each n into two linear systems of equations, which contain all the modes  $n$ . By combining the two equations into a single one, we arrive at the following proposition, which defines the time-dependent scattering matrix. We assume that  $\omega$  is not a multiple of  $\Omega$ , whereby a direct calculation shows that  $\mathcal{M}^+$ and  $\mathcal{T}^-$  are invertible.

**Proposition 4.1.** Consider the resonator  $D_i$ , and assume that  $\omega \neq m\Omega$  for all  $m \in \mathbb{Z}$ . Let the wave field on the left side of  $D_i$  be given by the modes  $v_n(x) = \alpha_n^i e^{ik^{(n)}x} + \beta_n^i e^{-ik^{(n)}x}$  and the wave field on the right side of  $D_i$  be given by the modes  $v_n(x) = \alpha_n^{i+1} e^{ik^{(n)}x} + \beta_n^{i+1} e^{-ik^{(n)}x}$ . Then the corresponding transfer matrix is given by

$$
\mathbf{w}^{i+1} = \tilde{S}_i \mathbf{w}^i, \quad \tilde{S}_i := (\mathcal{M}^+)^{-1} \mathcal{T}^+ (\mathcal{T}^-)^{-1} \mathcal{M}^- =: \begin{bmatrix} \tilde{S}_{11} & \tilde{S}_{12} \\ \tilde{S}_{21} & \tilde{S}_{22} \end{bmatrix} \in \mathbb{C}^{2(2K+1) \times 2(2K+1)}, \quad (4.8)
$$

where these matrices are defined in  $(4.6)$ . Furthermore, the scattering matrix is defined by

$$
S_i := \begin{bmatrix} S_{11} & S_{12} \\ S_{21} & S_{22} \end{bmatrix}, \quad\n\begin{cases} S_{11} := \tilde{S}_{11} - \tilde{S}_{12} \tilde{S}_{22}^{-1} \tilde{S}_{21}, \\ S_{12} := \tilde{S}_{12} \tilde{S}_{22}^{-1}, \\ S_{21} := -\tilde{S}_{22}^{-1} \tilde{S}_{21}, \\ S_{22} := \tilde{S}_{22}^{-1}, \end{cases}\n\tag{4.9}
$$

and it satisfies

<span id="page-8-2"></span>
$$
\begin{bmatrix} \boldsymbol{\alpha}^{i+1} \\ \boldsymbol{\beta}^i \end{bmatrix} = S_i \begin{bmatrix} \boldsymbol{\alpha}^i \\ \boldsymbol{\beta}^{i+1} \end{bmatrix} . \tag{4.10}
$$

<span id="page-8-1"></span>As in the previous section, we proceed by taking the limit  $\ell \to 0$  and derive a point-scattering approximation equivalent to Lemma [3.2.](#page-5-2) We take the same asymptotic scaling as before, whereby  $\delta = \gamma \ell, \ \omega = \mu \ell, \ \Omega = \xi \ell, \ \text{and} \ \lambda_j^i = c_j^i \ell, \ \text{for fixed} \ \gamma, \ \mu, \ \xi > 0 \ \text{independent of} \ \ell. \text{ Here, recall that } \lambda_j^i$ are the wave numbers in the  $i^{\text{th}}$  resonator, as in Proposition [2.1.](#page-3-2) Note that the exact definition of  $c_j^i$  depends on  $\mu$  and  $\Omega$ . Although there is no closed-form expression for these coefficients, they can be efficiently computed as the eigenvalues of the temporal Sturm-Liouville problem in the interior of  $D_i$  (see, for example, [\[1,](#page-16-0) Lemma III.3] or [\[13,](#page-17-15) Section V]).

**Lemma 4.2.** Let the N resonators each be of length  $\ell$  and centred around  $z_i$ , and set  $\delta = \gamma \ell$ ,  $\omega =$  $\mu\ell, \Omega = \xi\ell, \lambda^i_j = c^i_j\ell, \text{ for fixed } \gamma, \mu, \xi > 0 \text{ independent of } \ell.$  Assume that  $\omega \neq m\Omega \text{ for all } m \in \mathbb{Z}.$ Then, as  $\ell \rightarrow 0$ , the following holds:

$$
S_{i} = \begin{bmatrix} I_{2K+1} & 0 \\ 0 & I_{2K+1} \end{bmatrix} + \begin{bmatrix} g^{i} & 0 \\ 0 & g^{i} \end{bmatrix} \begin{bmatrix} I_{2K+1} & \text{diag} \left( e^{-2ik^{(n)}z_{i}} \right)_{n=-K}^{K} \\ \text{diag} \left( e^{2ik^{(n)}z_{i}} \right)_{n=-K}^{K} & I_{2K+1} \end{bmatrix} + O(\ell^{2}), \tag{4.11}
$$

where  $g^i \in \mathbb{C}^{(2K+1)\times (2K+1)}$  is given by

$$
g^i := (I_{2K+1} - \mathcal{A}_i)^{-1} \mathcal{A}_i, \quad \mathcal{A}_i := \frac{\ell}{2\gamma} \text{diag}\left(\frac{v}{\mu + n\xi}\right)_{n=-K}^K F \text{diag}\left(\text{i}(c_j^i)^2\right)_{j=-K}^K G. \tag{4.12}
$$

For the proof of Lemma [4.2](#page-8-1) we shall use the following well-known result from linear algebra:

<span id="page-9-0"></span>**Lemma 4.3.** The inverse of an invertible  $2m \times 2m$  matrix

<span id="page-9-2"></span><span id="page-9-1"></span>
$$
M = \begin{bmatrix} A & B \\ C & D \end{bmatrix},\tag{4.13}
$$

with blocks A, B, C,  $D \in \mathbb{C}^{m \times m}$  is given by

$$
M^{-1} = \begin{bmatrix} A^{-1} + A^{-1}BS^{-1}CA^{-1} & -A^{-1}BS^{-1} \\ -S^{-1}CA^{-1} & S^{-1} \end{bmatrix}, \quad S := D - CA^{-1}B, \tag{4.14}
$$

provided that A and S are invertible. Note that S is called the Schur complement of A.

With the result of Lemma [4.3,](#page-9-0) we can now prove Lemma [4.2.](#page-8-1)

Proof of Lemma [4.2.](#page-8-1) Recall that the transfer matrix is given by  $\tilde{S}_i := (\mathcal{M}^+)^{-1} \mathcal{T}^+ (\mathcal{T}^-)^{-1} \mathcal{M}^-$ , as defined in [\(4.6\)](#page-8-0). The proof will consist of simplifying each term appearing in  $\tilde{S}_i$  and then taking the limit  $\ell \to 0$ .

Invert  $\mathcal{M}^+$ :

The Schur complement of the first block of  $\mathcal{M}^+$  is given by

$$
S_{\mathcal{M}^+} = -\delta KE_- - (\delta KE_+) (E_+)^{-1} E_- = -2\delta KE_- \quad \Longrightarrow \quad S_{\mathcal{M}^+}^{-1} = -\frac{1}{2\delta} E_+ K^{-1}.
$$
 (4.15)

Then, by Lemma [4.3,](#page-9-0) the inverse of  $\mathcal{M}^+$  is given by

$$
\left(\mathcal{M}^+\right)^{-1} = \frac{1}{2} \begin{bmatrix} E_- & \frac{1}{\delta} E_- K^{-1} \\ E_+ & -\frac{1}{\delta} E_+ K^{-1} \end{bmatrix} . \tag{4.16}
$$

Invert  $\mathcal{T}^-$ :

The inverse of  $\mathcal{T}^-$  can be computed to be given by

$$
\left(\mathcal{T}^{-}\right)^{-1} = \begin{bmatrix} \hat{T} & \hat{T}_{\lambda} \end{bmatrix}, \quad \hat{T} := \text{diag}\left(\frac{1}{2} \begin{bmatrix} e^{-i\lambda_{j}^{i}x^{-}} \\ e^{i\lambda_{j}^{i}x^{-}} \end{bmatrix}\right)_{j=-K}^{K}, \quad \hat{T}_{\lambda} := \text{diag}\left(\frac{1}{2\lambda_{j}^{i}} \begin{bmatrix} e^{-i\lambda_{j}^{i}x^{-}} \\ -e^{i\lambda_{j}^{i}x^{-}} \end{bmatrix}\right)_{j=-K}^{K}.
$$
\n(4.17)

Multiply  $\mathcal{T}^+$  by  $(\mathcal{T}^-)^{-1}$ : Recall that  $\mathcal{T}^+$  is given by

$$
\mathcal{T}^{+} = \begin{bmatrix} FT^{+} \\ FT^{+}_{\lambda} \end{bmatrix} = \underbrace{\begin{bmatrix} F & 0 \\ 0 & F \end{bmatrix}}_{=:F} \begin{bmatrix} T^{+} \\ T^{+}_{\lambda} \end{bmatrix} . \tag{4.18}
$$

Then one obtains

$$
\mathcal{T}^+\left(\mathcal{T}^-\right)^{-1} = \mathcal{F}\begin{bmatrix} T^+\hat{T} & T^+\hat{T}_{\lambda} \\ T^+_{\lambda}\hat{T} & T^+_{\lambda}\hat{T}_{\lambda} \end{bmatrix}.
$$
\n(4.19)

Simplify  $\mathcal{M}^-$ :

The matrix  $\overline{\mathcal{M}}$ <sup>-</sup> can be written as

$$
\mathcal{M}^{-} = \underbrace{\begin{bmatrix} G & 0 \\ 0 & G \end{bmatrix}}_{=: \mathcal{G}} \begin{bmatrix} E_{-} & E_{+} \\ \delta KE_{-} & -\delta KE_{+} \end{bmatrix} . \tag{4.20}
$$

Compute  $\tilde{S}_i$ :

Finally, the transfer matrix can be written out as

$$
\tilde{S}_i = \frac{1}{2} \begin{bmatrix} E_- & \frac{1}{\delta} E_- K^{-1} \\ E_+ & -\frac{1}{\delta} E_+ K^{-1} \end{bmatrix} \mathcal{F} \begin{bmatrix} T^+ \hat{T} & T^+ \hat{T}_{\lambda} \\ T^+_{\lambda} \hat{T} & T^+_{\lambda} \hat{T}_{\lambda} \end{bmatrix} \mathcal{G} \begin{bmatrix} E_- & E_+ \\ \delta K E_- & -\delta K E_+ \end{bmatrix},
$$
\n(4.21)

and through some calculations one can achieve the following explicit definitions of the four submatrices of  $\tilde{S}_i$ :

$$
\tilde{S}_{11} = \frac{1}{2} \left( \left( E_{-}F(T^{+}\hat{T}) + \frac{1}{\delta} E_{-}K^{-1}F(T_{\lambda}^{+}\hat{T}) \right) GE_{-} + \left( \delta E_{-}F(T^{+}\hat{T}_{\lambda}) + E_{-}K^{-1}F(T_{\lambda}^{+}\hat{T}_{\lambda}) \right) GKE_{-} \right),
$$
\n
$$
\tilde{S}_{12} = \frac{1}{2} \left( \left( E_{-}F(T^{+}\hat{T}) + \frac{1}{\delta} E_{-}K^{-1}F(T_{\lambda}^{+}\hat{T}) \right) GE_{+} - \left( \delta E_{-}F(T^{+}\hat{T}_{\lambda}) + E_{-}K^{-1}F(T_{\lambda}^{+}\hat{T}_{\lambda}) \right) GKE_{+} \right),
$$
\n
$$
\tilde{S}_{21} = \frac{1}{2} \left( \left( E_{+}F(T^{+}\hat{T}) - \frac{1}{\delta} E_{+}K^{-1}F(T_{\lambda}^{+}\hat{T}) \right) GE_{-} + \left( \delta E_{+}F(T^{+}\hat{T}_{\lambda}) - E_{+}K^{-1}F(T_{\lambda}^{+}\hat{T}_{\lambda}) \right) GKE_{-} \right),
$$
\n
$$
\tilde{S}_{22} = \frac{1}{2} \left( \left( E_{+}F(T^{+}\hat{T}) - \frac{1}{\delta} E_{+}K^{-1}F(T_{\lambda}^{+}\hat{T}) \right) GE_{+} - \left( \delta E_{+}F(T^{+}\hat{T}_{\lambda}) - E_{+}K^{-1}F(T_{\lambda}^{+}\hat{T}_{\lambda}) \right) GKE_{+} \right).
$$

Let  $\ell \to 0$ :

We now want to compute the leading order terms of  $\tilde{S}_{ij}$ , as  $\ell \to 0$ . One can prove

$$
T^{+}\hat{T} = I_{2K+1} + O(\ell^{4}), \quad T_{\lambda}^{+}\hat{T} = \text{diag}\left(i(c_{j}^{i})^{2}\right)_{j=-K}^{K} \ell^{3} + O(\ell^{4}), \quad T_{\lambda}^{+}\hat{T}_{\lambda} = I_{2K+1} + O(\ell^{4}),
$$

and that  $E_{\pm} = I_{2K+1} + O(\ell)$ . Plugging these asymptotic formulas into  $\tilde{S}_{ij}$  and neglecting higher order terms, we obtain

$$
\begin{cases}\n\tilde{S}_{11} = I_{2K+1} + \mathcal{A}_i + O(\ell^2), \n\tilde{S}_{12} = \mathcal{A}_i + O(\ell^2), \n\tilde{S}_{21} = -\mathcal{A}_i + O(\ell^2), \n\tilde{S}_{22} = I_{2K+1} - \mathcal{A}_i + O(\ell^2),\n\end{cases}
$$
\n(4.22)

with  $\mathcal{A}_i$  defined by [\(4.12\)](#page-9-1). If we then define  $g^i = (I_{2K+1} - \mathcal{A}_i)^{-1} \mathcal{A}_i$  and use the formulas [\(4.9\)](#page-8-2), we obtain the desired result [\(4.11\)](#page-9-2).  $\Box$ 

We now want to use the asymptotic result of Lemma [4.2](#page-8-1) in order to characterise the total wave field as  $\ell \to 0$ . Let us separate the total wave field as a sum of incident and scattered fields

<span id="page-11-3"></span>
$$
v_n(x) = \begin{cases} v_n^{\text{sc}}(x) + v_n^{\text{in}}(x), & x \notin D, \\ v_n^{\text{sc}}(x), & x \in D, \end{cases}
$$
(4.23)

where  $v_n^{\text{in}}(x) := \alpha_n^1 e^{ik^{(n)}x} + \beta_n^{N+1} e^{-ik^{(n)}x}$ . The scattered wave field emerging from  $D_i$  is given by

$$
v_{i,n}^{\rm sc}(x) = G^{k^{(n)}}(x - z_i) \sum_{m=-K}^{K} \tilde{g}_{nm}^i v_{i,m}^{\rm in}(z_i), \qquad (4.24)
$$

where  $\tilde{g}_{nm}^i := 2ik^{(n)}g_{nm}^i$  and we use the notation  $g^i := (g_{nm}^i)_{m,n=-K}^K$ . Here,  $v_{i,m}^{\text{in}}$  is the field which is incident to  $D_i$ , and the scattered field is defined piecewise by

<span id="page-11-1"></span><span id="page-11-0"></span>
$$
v_n^{\rm sc}(x) := \sum_{i=1}^N v_{i,n}^{\rm sc}(x). \tag{4.25}
$$

Furthermore, the wave field impinging on  $D_i$  is given by

$$
v_{i,n}^{\text{in}}(x) = v_n^{\text{in}}(x) + \sum_{j \neq i} v_{j,n}^{\text{sc}}(x) = v_n^{\text{in}}(x) + \sum_{j \neq i} \sum_{m=-K}^{K} \tilde{g}_{nm}^j v_{j,m}^{\text{in}}(z_j) G^{k^{(n)}}(x - z_j). \tag{4.26}
$$

Note that the characterisations [\(4.24\)](#page-11-0) and [\(4.26\)](#page-11-1) hold true only as  $\ell \to 0$  and can be derived using the results proven in Lemma [4.2.](#page-8-1)

#### 4.1 Homogenised Equation

To obtain the time-dependent homogenised equation, we first evaluate [\(4.26\)](#page-11-1) at each resonator  $z_i$ :

$$
v_{i,n}^{\text{in}}(z_i) = v_n^{\text{in}}(z_i) + \sum_{j \neq i} v_{j,n}^{\text{sc}}(z_i) = v_n^{\text{in}}(z_i) + \sum_{j \neq i} \sum_{m=-K}^{K} \tilde{g}_{nm}^j v_{j,m}^{\text{in}}(z_j) G^{k^{(n)}}(z_i - z_j), \tag{4.27}
$$

for all  $i = 1, ..., N$  and  $n = -K, ..., K$ . Now we define the vectors  $\mathbf{x}, \mathbf{b} \in \mathbb{C}^{N(2K+1)}$  with entries

<span id="page-11-2"></span>
$$
\mathbf{x} = \begin{bmatrix} v_{1,-K}^{\text{in}}(z_1) \\ \vdots \\ v_{1,K}^{\text{in}}(z_1) \\ \vdots \\ v_{N,-K}^{\text{in}}(z_N) \\ \vdots \\ v_{N,K}^{\text{in}}(z_N) \end{bmatrix}, \quad \mathbf{b} = \begin{bmatrix} v_{-K}^{\text{in}}(z_1) \\ \vdots \\ v_{K}^{\text{in}}(z_1) \\ \vdots \\ v_{-K}^{\text{in}}(z_N) \\ \vdots \\ v_{K}^{\text{in}}(z_N) \end{bmatrix}
$$
(4.28)

and let the matrix  $T \in \mathbb{C}^{N(2K+1) \times N(2K+1)}$  be defined by

$$
T_{nm}^{ij} := \begin{cases} \tilde{g}_{mn}^{j} G^{k^{(m)}}(z_i - z_j), & i \neq j, \\ 0, & i = j, \end{cases} \qquad T := \left[ \left[ T_{nm}^{ij} \right]_{n,m=-K}^{K} \right]_{i,j=1}^{N} . \tag{4.29}
$$

This notation allow us to rewrite [\(4.27\)](#page-11-2) as

<span id="page-12-1"></span>
$$
\mathbf{x} - T\mathbf{x} = \mathbf{b},\tag{4.30}
$$

which is of the same form as in the static case  $(3.17)$ , but where the linear system has a block structure. As in the static case, we must pose some assumptions in order to derive the homogenised equation.

**Assumption 4.4.** Assume that  $\kappa_i(t) \equiv \kappa(t)$  is identical across all resonators. Therefore,  $\lambda_j^i =$  $c_j^i \ell \equiv c_j \ell$  and as a consequence,  $g_{mn}^i \equiv g_{mn}$ .

We also impose the assumptions of the previous section: Assumption [3.4](#page-6-3) (constant volume fraction), Assumption [3.5](#page-6-4) (limiting density  $\tilde{V}(x)$ ), and Assumption [3.6](#page-7-3) (continuum limit approximation). This allow us to write

$$
\tilde{g}_{nm} = 2ik^{(n)}g_{nm} = \frac{2i}{N}\frac{\mu + n\xi}{v}\Lambda g_{nm} =: \frac{1}{N}\beta_{nm}\Lambda.
$$
\n(4.31)

The definition of  $\beta_{nm}$  was obtained in the same way as in the static case [\(3.18\)](#page-6-5). Recall that  $g_{nm}^i$ defined by [\(4.12\)](#page-9-1) does not depend on  $\ell$  and therefore,  $\beta_{nm}^i$  does not depend on  $\ell$  nor N. Hence,

$$
v_{i,n}^{\text{in}}(z_i) = v_n^{\text{in}}(z_i) + \frac{1}{N} \sum_{j \neq i} \sum_{m=-K}^{K} \beta_{nm} \Lambda v_{i,n}^{\text{in}}(z_j) G^{k^{(n)}}(z_i - z_j). \tag{4.32}
$$

<span id="page-12-0"></span>**Lemma 4.5.** For any  $f_m \in C^{0,\alpha}(\mathcal{U})$  with  $0 < \alpha \leq 1$ ,

$$
\max_{1 \le i \le N} \left| \frac{1}{N} \sum_{j \ne i} \sum_{m=-K}^{K} \beta_{nm} \Lambda G^{k^{(n)}}(z_i - z_j) f_m(z_j) - \int_{\mathcal{U}} \sum_{m=-K}^{K} G^{k^{(n)}}(z_i - y) V_{nm}(y) f_m(y) dy \right|
$$
  

$$
\le \sum_{m=-K}^{K} \frac{C_{nm}}{N^{\alpha/3}} ||f_m||_{C^{0,\alpha}(\mathcal{U})}, \tag{4.33}
$$

for all  $n = -K, \ldots, K$ .

*Proof.* First, define  $V_{nm}(x) := \beta_{nm} \Lambda \tilde{V}(x)$ , for  $\tilde{V}$  defined through [\(3.21\)](#page-6-6). We use Assumption [3.6](#page-7-3) to obtain the desired result.  $\Box$ 

Next, define the operators  $\mathcal{T}^{nm}: C^{0,\alpha}(\mathcal{U}) \to C^{0,\alpha}(\mathcal{U})$  by

$$
\mathcal{T}^{nm} f(x) = \int_{\mathcal{U}} G^{k^{(n)}}(x - y) V_{nm}(y) f(y) \, dy, \quad \forall \, m, n = -K, \dots, K. \tag{4.34}
$$

By substituting the above defined integral operator  $\mathcal{T}^{nm}$  into Lemma [4.5,](#page-12-0) applying it to [\(4.32\)](#page-12-1), and neglecting the remainder term, we obtain a system of coupled Lippmann-Schwinger equations

<span id="page-12-3"></span><span id="page-12-2"></span>
$$
\psi_n + \sum_{m=-K}^{K} \mathcal{T}^{nm} \psi_m = \psi^{\text{in}}, \quad \forall n = -K, \dots, K. \tag{4.35}
$$

Then, applying the operator  $\left(\frac{d^2}{dx^2} + (k^{(n)})^2\right)$  leads to the homogenised equations

<span id="page-12-4"></span>
$$
\left(\frac{d^2}{dx^2} + (k^{(n)})^2\right)\psi_n(x) - V_{nn}(x)\psi_n(x) - \sum_{m=-K}^{K} \left( \left(k^{(m)}\right)^2 - \left(k^{(n)}\right)^2 \right) \int_{\mathcal{U}} G^{k^{(n)}}(x-y) V_{nm}(y) \psi_m(y) \, dy = 0. \tag{4.36}
$$

**Remark 4.6.** Note that  $\psi_n(z_i)$  is the continuum limit of  $v_{i,n}^{\text{in}}$  as  $N \to \infty$ , which is proved in detail for the higher-dimensional static case in [\[5\]](#page-17-11). Looking at [\(4.23\)](#page-11-3) and [\(4.27\)](#page-11-2), the total field is given by  $v_{i,n}^{\text{in}} + v_{i,n}^{\text{sc}} = v_n$  for all  $i = 1, \ldots, N$ . However, as  $N \to \infty$ , the scattered field of a single resonator  $v_{i,n}^{\text{sc}}$  becomes negligible. Thus,  $\psi_n$  is the continuum limit of the total wave field  $v_n$ .

<span id="page-13-0"></span>**Corollary 4.7.** The system of homogenised equations  $(4.36)$  can be rewritten into a single vectorvalued equation given by

$$
\operatorname{diag}\left(\frac{d^{2}}{dx^{2}} + (k^{(n)})^{2}\right)_{n=-K}^{K} \psi(x) - \operatorname{diag}\left(V_{nn}(x)\right)_{n=-K}^{K} \psi(x) - \int_{\mathcal{U}} \mathcal{A}(x, y)\psi(y) dy = \mathbf{0}, \quad (4.37)
$$

for the vector  $\boldsymbol{\psi} := (\psi_n)_{n=-K}^K$  and the matrix  $\mathcal{A}(x, y) := (\mathcal{A}_{nm}(x, y))_{m,n=-K}^K$  with entries

$$
\mathcal{A}_{nm}(x,y) := \begin{cases} 0, & n = m, \\ \left( \left( k^{(m)} \right)^2 - \left( k^{(n)} \right)^2 \right) G^{k^{(n)}}(x-y) V_{nm}(y), & n \neq m. \end{cases} \tag{4.38}
$$

<span id="page-13-1"></span>Corollary 4.8. The system of coupled equations  $(4.35)$  can be rewritten into a single vector Lippmann-Schwinger equation given by

<span id="page-13-3"></span><span id="page-13-2"></span>
$$
\psi(x) = \mathbf{v}^{\text{in}}(x) + \int_{\mathcal{U}} \mathcal{V}(x, y)\psi(y) \,dy,\tag{4.39}
$$

where

$$
\mathcal{V}(x,y) := (\mathcal{V}_{nm}(x,y))_{n,m=-K}^K, \quad \mathcal{V}_{nm}(x,y) := G^{k^{(n)}}(x-y)V_{nm}(y). \tag{4.40}
$$

Corollary [4.7](#page-13-0) and Corollary [4.8](#page-13-1) are the main results of the homogenisation. They provide two equivalent formulations of the effective field  $\psi$  emerging from a homogenised time-dependent material. Comparing the homogenised equation  $(4.37)$  to the static case in  $(3.24)$ , we observe that the time-modulated case is described by an integro-differential homogenised equation, rather than a differential equation.

Remark 4.9. As pointed out in [\[5\]](#page-17-11), we note that it is not possible to obtain an effective medium theory for frequencies that are too close to the resonant frequency of a high-contrast resonator. In this case, the scattering matrix g is of order one as  $\ell \to 0$ . Each additional resonator therefore yields a strong contribution to the total field. The limit as  $N \to \infty$  does not exist and homogenisation is not possible.

To justify the asymptotic regime used in Section [4,](#page-7-0) we use the formulas for the resonant frequencies of a single resonator proved in [\[2\]](#page-16-1):

$$
\omega_0 = 0, \quad \omega_1 \approx -\frac{2i(v_r)^2 \delta}{\ell v_0 T} \int_0^T \kappa(t) dt,
$$
\n(4.41)

as  $\delta \to 0$ . If  $\delta = \gamma \ell^p$ , for some  $p \in \mathbb{N}_{>1}$ , having an incident wave at resonance would mean that  $\omega = \mu \ell^{p-1}$ . However, under this assumption, the term  $\beta_{mn} \Lambda v_{i,n}^{in}(z_j) G^{k^{(n)}}(z_i - z_j)$  inside [\(4.32\)](#page-12-1) is of order one as  $\ell \to 0$ . As  $N \to \infty$ , this sum will tend to infinity. Therefore, to obtain an effective medium theory, we must work in a regime for which  $g = O(\ell)$ . The only possible regime is  $\omega = O(\delta)$  and  $\delta = O(\ell^q)$  for some  $q > 0$ . For simplicity, we choose  $q = 1$ .

## <span id="page-14-0"></span>5 Numerical Results

We now present a modified Nyström numerical scheme (similar to [\[8\]](#page-17-12)) to solve the system of Lippmann-Schwinger equations [\(4.39\)](#page-13-3). Let  $(y_i)_{i=1}^M$  be a set of M uniformly distributed points in  $U$ . Discretising the Lippmann-Schwinger equation yields

$$
\boldsymbol{\psi}(y_i) = \mathbf{v}^{\text{in}}(y_i) + \frac{|\mathcal{U}|}{M} \sum_{j=1}^{M} \mathcal{V}(y_i, y_j) \boldsymbol{\psi}(y_j), \qquad (5.1)
$$

where  $|U|$  is the length of the interval U. For the numerical solution presented in this section, we set  $\tilde{V}(x) := 1/|\mathcal{U}|$ . Based on this equation, we define the following:

$$
\boldsymbol{\psi}^{M} := \begin{bmatrix} \boldsymbol{\psi}(y_1) \\ \vdots \\ \boldsymbol{\psi}(y_M) \end{bmatrix}, \quad \mathbf{v}^{\text{in},M} := \begin{bmatrix} \mathbf{v}^{\text{in}}(y_1) \\ \vdots \\ \mathbf{v}^{\text{in}}(y_M) \end{bmatrix}, \quad \mathbb{V} := (\mathcal{V}(y_i, y_j))_{i,j=1}^{M}.
$$
 (5.2)

These definitions allow us to write

<span id="page-14-1"></span>
$$
\left(I_{M(2K+1)} - \frac{|\mathcal{U}|}{M}\mathbb{V}\right)\psi^M = \mathbf{v}^{\text{in},M}.\tag{5.3}
$$

As pointed out in Remark [4.6,](#page-12-4)  $\psi^M$  is the total wave field in the continuum limit.

We set  $\gamma = 0.05$ ,  $\mu = 0.11$ ,  $\xi = 0.2$ ,  $K =$ 4,  $\varepsilon_{\kappa} = 0.4$ . We evaluate the solution at ten time-steps in [0, T], for  $T = 2\pi/\Omega = 3141.59$ . For the definition of [\(5.3\)](#page-14-1) we choose a mesh of size  $M = 200$ .

Figure 5.2: The  $\ell^2$ -norm of the error between the effective field  $\psi^M$  and the total field u at time  $t = 0$ . For the numerical solution we set  $M = N$  and  $y_i = z_i$ , for convenience. The resonators are evenly distributed inside  $\mathcal{U} = [0, 4000]$  and each of length  $\ell = 1/N$ . We set  $\gamma = 0.05$ ,  $\mu = 0.11$ ,  $\xi = 0.2$ ,  $K = 4$ ,  $\varepsilon_{\kappa} = 0.4$ .

The bold line in Figure [5.1](#page-14-2) shows the effective field  $\psi^M$  as a function of x evaluated at different time-steps inside the interval  $[0, T]$ . For comparison, we plot the evaluation of the total wave field obtained using the scheme obtained in [\[2\]](#page-16-1), marked by stars inside the plot. As analytically proved, the effective field and the total field agree for  $\ell \ll 1$  and large N. The numerical results in Figure [5.1](#page-14-2) show that the effective field is still quasi-periodic with quasi-periodicity  $\omega$ .

Figure [5.2](#page-15-0) shows the  $\ell^2$ -norm of the error between the effective field  $\psi$  and the true solution u at each resonator  $z_i$  as a function of N. It becomes apparent from our numerical result that the error behaves algebraically in  $N$ . This result is not surprising, as the effective medium theory only holds in the limit  $\ell \to 0$  and  $N \to \infty$ .

The results in Figure [5.3](#page-15-1) show how the computation run time of  $u$  is significantly larger than the computation of the effective field  $\psi$ . This further underlines the relevance of the herein derived effective medium theory.

## <span id="page-16-3"></span>6 Concluding Remarks

We have rigorously derived an effective medium theory for one-dimensional time-modulated metamaterials in the low-frequency regime. We started by providing the  $2 \times 2$  scattering matrix for static metamaterials and this led to the point interaction approximation. This set the ground for following a similar approach as in [\[5\]](#page-17-11). With suitable assumptions [3.4](#page-6-3) - [3.6](#page-7-3) we derived the homogenised equation  $(3.24)$ .

We then proceeded with the case of the time-dependent material parameter  $\kappa$ . In this paper, we assumed the parameter  $\rho$  to be static, since in [\[1\]](#page-16-0) we proved that the resulting wave field does not depend on  $\rho$  at leading order. As in the static case, we first derived the scattering matrix. However, for a time-modulated material parameter, this is a  $2(2K + 1) \times 2(2K + 1)$ matrix. This is a direct consequence of the mode coupling that arises from the modulation in time. Analogously to the static case we then derived a point interaction approximation, which ultimately led to a characterisation of the effective field through a system of coupled Lippmann-Schwinger equations [\(4.35\)](#page-12-3). These integral equations furnished the homogenised equations given by [\(4.36\)](#page-12-2). In contrast to the static case, the homogenised equations modelling a time-modulated metamaterial are a system of coupled integro-differential equations.

A crucial assumption to obtain a time-modulated effective medium theory is that the incident frequency  $\omega$  is slightly away from the resonant frequency of the components. For a frequency at resonance, the scattering coefficients q are of order one. Even for a large number  $N$  of resonators, individual resonator gives a strong contribution to the total field, and the limit does not exist.

Finally, we introduced a numerical scheme to solve the Lippmann-Schwinger equation for the effective field. Our numerical solution supports our analytical results by showing that the numerical solution of  $(5.3)$  tends to the numerical solution of  $(2.6)$ . In fact, Figure [5.2](#page-15-0) shows that the error is algebraic in N.

We consider the results proven in this paper to be the basis for many new breakthroughs in the exploration of time-modulated metamaterials. Since our results can be easily generalised to higher dimensions, the results herein proved are also of great significance to two- and threedimensional spacetime metamaterials. Moreover, we showed that time-dependent metamaterials at a resonant frequency cannot be treated as an effective medium.
