## Milnor-Witt motivic decomposition of Stiefel varieties

### **1 Introduction**

This paper extends the research presented in [\[4\]](#page-6-0), which investigated the cohomology groups  $H^*_{\eta}(V_k(\mathbb{A}^n))$  with  $\eta$ inverted coefficients by employing the A 1 -Leray spectral sequence [\[1\]](#page-6-1). For foundational results and notations relevant to this study, we refer the reader to [\[4\]](#page-6-0).

In this work, we will initially compute the integral MW-motivic cohomology groups  $H_{MW}^{p,q}(V_k(\mathbb{A}^n))$  associated with Stiefel varieties.

**Theorem 1.1** (Theorem [3.4\)](#page-3-0). Let  $i \in N_{n,k}$ . The generators  $\alpha_i$  are elements of  $H_{MW}^{2i+1,i+1}(V_k(\mathbb{A}^n))$ , and for  $J \in F_{n,k}$ , *the generators*  $\beta_J$  *belong to*  $H_{MW}^{d(J)}(V_k(\mathbb{A}^n))$ *. For any subset*  $I \subset N_{n,k}$ *, define* 

$$
b_I = \prod_{J \in F_{n,k}, J \subset I} \beta_J \prod_{i \in I_T} \alpha_i \in H_{\text{MW}}^{d(I)}(V_k(\mathbb{A}^n)).
$$

*Then, we establish the following isomorphism of graded*  $H^{*,*}_{\text{MW}}(K)$ *-modules:* 

$$
H_{\text{MW}}^{*,*}(V_k(\mathbb{A}^n)) \cong \bigoplus_{I \subset N_{n,k}} (H_{\text{MW}})_I b_I,
$$

*where*

$$
(\mathbf{H}_{\mathrm{MW}})_I = \begin{cases} \mathbf{H}_{\mathrm{MW}}^{*,*}(K), & \text{if } I = I_F, \\ \mathbf{H}_{\mathrm{M}}^{*,*}(K), & \text{if } \mathrm{Max}(I_T) \text{ is even,} \\ {}^{\eta} \mathbf{H}_{\mathrm{M}}^{*,*}(K), & \text{if } \mathrm{Max}(I_T) \text{ is odd.} \end{cases}
$$

It is important to note that our computations focus solely on the additive structures; the ring structures are considerably more complex.

Building upon these computations, we will proceed to establish the following MW-motive decomposition:

**Theorem 1.2** (Theorem [4.2\)](#page-5-0). Let  $C_{\eta}(S)$  denote the cone of  $\widetilde{M}(S) \stackrel{\eta}{\rightarrow} \widetilde{M}(S)(1)[1]$  and define the following:

$$
\widetilde{\mathbf{HS}}_{2k} := \widetilde{\mathbf{M}}(\mathbb{A}^{2k} \setminus \{0\}) \cong \widetilde{\mathbf{M}}(S) \oplus \widetilde{\mathbf{M}}(S)(2k)[4k-1],
$$
  

$$
\widetilde{\mathbf{HS}}_{2k+1} := \widetilde{\mathbf{M}}(S) \oplus C_{\eta}(S)(2k)[4k] \oplus \widetilde{\mathbf{M}}(S)(4k+1)[8k].
$$

*Then, for any i, j* ∈ N*, we obtain an MW-motivic decomposition of the following forms:*

$$
\widetilde{M}(V_{2j}(\mathbb{A}^{2i})) \cong \widetilde{\mathbf{HS}}_{2i} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \widetilde{\mathbf{HS}}_{2i-3} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i-1-2(j-2)} \otimes \widetilde{M}(\mathbb{A}^{2i+1-2j} \setminus \{0\}),
$$
  

$$
\widetilde{M}(V_{2j+1}(\mathbb{A}^{2i})) \cong \widetilde{\mathbf{HS}}_{2i} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \widetilde{\mathbf{HS}}_{2i-3} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i-1-2(j-1)},
$$
  

$$
\widetilde{M}(V_{2j}(\mathbb{A}^{2i+1})) \cong \widetilde{\mathbf{HS}}_{2i+1} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i+1-2(j-1)},
$$
  

$$
\widetilde{M}(V_{2j+1}(\mathbb{A}^{2i+1})) \cong \widetilde{\mathbf{HS}}_{2i+1} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i+1-2(j-1)} \otimes \widetilde{M}(\mathbb{A}^{2i+1-2j} \setminus \{0\}).
$$

#### **Notation**

Let  $C_{\eta}(S)$  denote the cone of  $\widetilde{M}(S) \stackrel{\eta}{\rightarrow} \widetilde{M}(S)(1)[1]$ . We sometimes use the index of degree  $(p, \{q\}) := (p + q, q)$ . A cohomology theory  $\mathbb{E} \in \mathcal{SH}(K)$  is termed **coconnected** if  $\mathbb{E}^{p,\{q\}}(K) = 0$  for  $p > 0$ .

## 2 The  $\mathbb{A}^1$ -Thom-Gysin Sequence

We will follow the computation from [\[2\]](#page-6-2) to determine the total cohomology group  $H_{MW}^{*,*}(V_k(\mathbb{A}^n),\mathbb{Z})$  with integral coefficients as a module. The key element in this determination is the  $\mathbb{A}^1$ -Thom-Gysin sequence, which directly results from the  $\mathbb{A}^1$ -Leray spectral sequence.

**Theorem 2.1** ([\[1,](#page-6-1) Thm 5.2.8]). Let  $f: X \to B$  be a Zariski locally trivial smooth fibration over a field K, where  $\mathcal{L}$  *the fiber F* of *f* is an  $\mathbb{A}^1$ -homology sphere (i.e.,  $\Sigma^r F \cong \Sigma^p \mathbb{G}_m^{\wedge q}$ ). Let M be a homotopy module with a ring structure over K, and assume that  $H^i_{\delta}(f_* M_X)$  is K-simple over B. Then there exists an Euler class  $e(f) \in H^{p-r+1}(B, M_q)$ , *such that the Thom-Gysin sequence is given by:*

$$
\cdots \to H^i(B, M_j) \to H^i(X, M_j) \to H^{i+r-p}(B, M_{j-q}) \xrightarrow{\cup e(f)} H^{i+1}(B, M_j) \to \cdots
$$

*where the connecting morphism is given by the product with*  $e(f)$ .

In fact, we can generalize this to an Atiyah-Hirzebruch type spectral sequence by replacing *M* with a spectrum  $E \in \mathcal{SH}(S)$ , where *S* is a Noetherian base scheme over the field *K*.

**Proposition 2.2** ( $\mathbb{A}^1$ -Thom-Gysin sequence). Let  $\mathbb{E} \in \mathcal{SH}(S)$  be a ring spectrum, and let  $f: V \to B$  be a rank-n *vector bundle that is*  $\mathbb{E}$ -oriented. Let  $X := V \setminus B$  denote the complement of the zero section, which constitutes a *sphere bundle. Then, we acquire the Thom-Gysin exact sequence:*

$$
\cdots \to \mathbb{E}^{i,j}(B) \to \mathbb{E}^{i,j}(X) \xrightarrow{r} \mathbb{E}^{i-(2n-1),j-n}(B) \xrightarrow{\cup e(f)} \mathbb{E}^{i+1,j}(B) \to \cdots
$$

*where*  $e(f) \in \mathbb{E}^{2n,n}(B)$  *represents the Euler class of the vector bundle.* 

*Proof.* Since  $f: V \to B$  is oriented with respect to  $\mathbb{E}$ , we have the Thom isomorphism  $\phi: \mathbb{E}^{i-2n,j-n}(B) \stackrel{\cong}{\to}$  $\mathbb{E}^{i,j}(\text{Th}(V))$ , where  $\text{Th}(V) := V/X$  is the Thom space. Let  $\tau = \phi(1) \in \mathbb{E}^{2n,n}(\text{Th}(V))$  denote the Thom class.  $\text{Furthermore, there exists a homotopy equivalence } f^* : \mathbb{E}^{i,j}(B) \stackrel{\cong}{\to} \mathbb{E}^{i,j}(V)$ . Let the morphism  $\text{Th}(f)^* : \mathbb{E}^{i,j}(B) \stackrel{\cong}{\to}$  $\mathbb{E}^{i,j}(\text{Th}(V))$  be induced by the projection. We note that for the Thom isomorphism,  $\phi(a) = \text{Th}(f)^*(a) \cup \tau$ .

Now, consider the Gysin sequences associated with the cofiber sequence  $X \to V \stackrel{q}{\to} Th(V)$ :

$$
\mathbb{E}^{i,j}(V) \longrightarrow \mathbb{E}^{i,j}(X) \longrightarrow \mathbb{E}^{i+1,j}(\text{Th}(V)) \xrightarrow{q^*} \mathbb{E}^{i+1,j}(V)
$$
\n
$$
\uparrow f^*
$$
\n
$$
\mathbb{E}^{i,j}(B) \longrightarrow \mathbb{E}^{i,j}(X) \longrightarrow \mathbb{E}^{i-(2n-1),j-n}(B) \xrightarrow{\partial} \mathbb{E}^{i+1,j}(B)
$$

We only need to determine the morphism  $\partial := (f^*)^{-1} q^* \phi$ . By the properties of the Thom isomorphism, we have

$$
\partial(a) = (f^*)^{-1} q^* (\text{Th}(f)^*(a) \cup \tau) = (f^*)^{-1} (f^*(a) \cup q^*(\tau)) = a \cup (f^*)^{-1} q^*(\tau).
$$

By the definition of the Euler class,  $e(f) := (f^*)^{-1} q^*(\tau)$ , we can conclude our proof.

Pursuing the diagram further, we can derive the following corollary:

<span id="page-1-0"></span>**Corollary 2.3.** We maintain the previously established notation. Let  $g : \mathbb{A}^n \setminus \{0\} \to X$  be a fiber embedding induced *by the base point*  $b: pt \to B$ . Then the pullback  $g^*: \mathbb{E}^{i,j}(X) \to \mathbb{E}^{i,j}(\mathbb{A}^n \setminus \{0\})$  *is defined as follows:* 

$$
\mathbb{E}^{i,j}(X) \xrightarrow{r} \mathbb{E}^{i-(2n-1),j-n}(B) \xrightarrow{b^*} \mathbb{E}^{i-(2n-1),j-n}(pt) \xrightarrow{\cup \theta} \mathbb{E}^{i,j}(\mathbb{A}^n \setminus \{0\}),
$$

*where*  $\theta \in \mathbb{E}^{2n-1,n}(\mathbb{A}^n \setminus \{0\})$  *serves as a generator.* 

# **3** MW-Motivic Cohomology Groups of  $V_k(\mathbb{A}^n)$

We apply this theorem to the fiber sequences of Stiefel varieties over the field *K*:

$$
\mathbb{A}^{n-k} \setminus \{0\} \to V_{k+1}(\mathbb{A}^n) \xrightarrow{f_{n,k}} V_k(\mathbb{A}^n).
$$



The fiber  $\mathbb{A}^{n-k} \setminus \{0\} \cong \Sigma^{n-k-1} \mathbb{G}_m^{\wedge n-k}$  is precisely an  $\mathbb{A}^1$ -sphere and corresponds to a  $H_{MW}$ -oriented bundle, which is, in fact, GL-oriented as shown in [\[4,](#page-6-0) §3.6, §3.7]. The Thom-Gysin sequence for MW motivic cohomology  $H^{i,j}_{\text{MW}}(-) := H^{i,j}_{\text{MW}}(-, \mathbb{Z})$  is expressed as follows:

$$
\cdots \xrightarrow{\cup e(f_{n,k})} H_{\text{MW}}^{i,j}(V_k(\mathbb{A}^n)) \to H_{\text{MW}}^{i,j}(V_{k+1}(\mathbb{A}^n)) \to H_{\text{MW}}^{i-(2(n-k)-1),j-(n-k)}(V_k(\mathbb{A}^n)) \xrightarrow{\cup e(f_{n,k})} H_{\text{MW}}^{i+1,j}(V_k(\mathbb{A}^n)) \to \cdots
$$

Consequently, we derive the short exact sequence:

$$
0 \to \text{Coker}(\cup e(f_{n,k})) \to \text{H}_{\text{MW}}^{i,j} \to \text{Ker}(\cup e(f_{n,k})) \to 0. \tag{1}
$$

To carry out calculations, it suffices to understand the Euler class  $e(f_{n,k}) \in H_{MW}^{2(n-k),n-k}(V_k(\mathbb{A}^n)).$ 

We begin by reviewing some facts about the cone  $C_n(K) \in \overline{\mathrm{DM}}(K)$ , which is associated with the morphism  $\widetilde{\mathrm{M}}(K)(1)[1] \xrightarrow{\eta} \widetilde{\mathrm{M}}(K) \to C_{\eta}(K).$ 

**Proposition 3.1** ([\[6,](#page-6-3) Prop 2.2])**.** *The following exact sequence splits:*

$$
H_{MW}^{i-2,j-1}(K) \to H_{MW}^{i,j}(C_{\eta}(K)) \to H_{MW}^{i,j}(K) \xrightarrow{\eta} H_{MW}^{i,j}(C_{\eta}(K)) = \begin{cases} H_{MW}^{i-2,j-1}(K) \oplus H_{MW}^{i,j}(K), & \text{if } i \neq j \text{ or } i = j < 0, \\ H_{MW}^{j-2,j-1}(K) \oplus 2K_{j}^{M}(K), & \text{if } i = j \geq 0 \end{cases}
$$

 $Here, H^{i,j}_M(-) := H^{i,j}_M(-, \mathbb{Z})$  *denotes the motivic cohomology as defined by Voevodsky* [\[3\]](#page-6-4)*.* 

We also note the following exact sequence of abelian groups:

$$
0 \to 2\mathrm{K}_{j}^\mathrm{M}(K) \cong {^\eta \mathrm{K}_{j}^\mathrm{MW}(K)} \to \mathrm{K}_{j}^\mathrm{MW}(K) \xrightarrow{\eta} \mathrm{K}_{j-1}^\mathrm{MW}(K) \to \mathrm{K}_{j-1}^\mathrm{M}(K) \to 0.
$$

This motivates us to define a modified cohomology group:

$$
{}^{\eta} \mathcal{H}_{\mathcal{M}}{}^{i,j}(K) = \begin{cases} \mathcal{H}_{\mathcal{M}}^{i,j}(K), & \text{if } i \neq j, \\ 2\mathcal{K}_{j}^{\mathcal{M}}(K), & \text{if } i = j. \end{cases}
$$

Consequently, we have the following exact sequence of the graded cohomology group  $H^{*,*}_{\text{MW}}(K) = \bigoplus_{i,j} H^{*,*}_{\text{MW}}(K)$ :

$$
0 \to {}^{\eta}H_M{}^{*,*}(K) \to \mathrm{H}^{*,*}_{\mathrm{MW}}(K) \xrightarrow{\eta} \mathrm{H}^{*-1,*-1}_{\mathrm{MW}}(K) \to \mathrm{H}^{*-1,*-1}_{\mathrm{M}}(K) \to 0.
$$

Additionally, we have  $H_{\text{MW}}^{*,*}(C_{\eta}(K)) = H_{\text{M}}^{*,*}(K) \theta_{2,1} \oplus \eta H_{\text{M}}^{*,*}(K)$ . To compute the cohomology of  $V_2(\mathbb{A}^n)$ , we utilize the following theorem:

**Proposition 3.2** ([\[4,](#page-6-0) Cor 3.9]). The following motivic decompositions are valid in  $DM(S)$ :

$$
\widetilde{\mathcal{M}}(V_2(\mathbb{A}^n)) \cong \widetilde{\mathcal{M}}(\mathbb{A}^n \setminus \{0\}) \otimes \widetilde{\mathcal{M}}(\mathbb{A}^{n-1} \setminus \{0\})
$$

*for n even, and*

$$
\widetilde{\mathbf{M}}(V_2(\mathbb{A}^n)) \cong \widetilde{\mathbf{HS}}_n
$$

*for n odd.*

**Corollary 3.3.** We have an isomorphism of graded  $H_{\text{MW}}^{*,*}(K)$ -modules:

$$
H_{MW}^{*,*}(V_2(\mathbb{A}^n)) = \begin{cases} H_{MW}^{*,*}(K)[\beta_{n-1}, \beta_{n-2}] / (\beta_{n-1}^2, \beta_{n-2}^2), & \text{if } n \text{ is even,} \\ H_{MW}^{*,*}(K)\beta_{n-1,n-2} \oplus H_{M}^{*,*}(K)\alpha_{n-1} \oplus \eta H_{M}^{*,*}(K)\alpha_{n-2} \oplus H_{MW}^{*,*}(K), & \text{if } n \text{ is odd,} \end{cases}
$$

where  $\deg(\beta_i) = \deg(\alpha_i) = (2i + 1, i + 1) = (i, {i + 1})$ , meaning that  $\alpha_i \in H_{MW}^{2i+1,i+1}(V_2(\mathbb{A}^n))$ , and  $\deg(\beta_{n-1,n-2}) =$  $(4n-4, 2n-1) = (2n-3, \{2n-1\}).$ 

Now, we can state our main result for  $V_k(\mathbb{A}^n)$ . Let  $N_{n,k} = \{t \in \mathbb{Z} \mid n - k \le t \le n - 1\}$ . We define the *free pairs* as follows:

$$
F_{n,k} = \{ \{n-1\} \mid \text{if } n \text{ is even} \} \sqcup \{ \{i, i-1\} \subset N_{n,k} \mid \text{if } i \text{ is even} \} \sqcup \{ \{n-k\} \mid \text{if } n-k \text{ is even} \}.
$$

Additionally, we define the *free part* and the *torsion part* of a subset  $I \subset N_{n,k}$  as follows:

$$
I_F = \bigsqcup_{J \in F_{n,k}, J \subset I} J, \quad I_T = I \setminus I_F.
$$

<span id="page-3-0"></span>Furthermore, we define the degree for a subset *I* as  $d(I) = (\sum_{i \in I} (2i + 1), \sum_{i \in I} (i + 1)).$ 

**Theorem 3.4.** Let  $i \in N_{n,k}$ . The generators  $\alpha_i$  are elements of  $H_{MW}^{2i+1,i+1}(V_k(\mathbb{A}^n))$ , and for  $J \in F_{n,k}$ , the generators  $\beta$ *J belong to*  $H_{MW}^{d(J)}(V_k(\mathbb{A}^n))$ *. For any subset*  $I \subset N_{n,k}$ *, define* 

$$
b_I = \prod_{J \in F_{n,k}, J \subset I} \beta_J \prod_{i \in I_T} \alpha_i \in H_{\text{MW}}^{d(I)}(V_k(\mathbb{A}^n)).
$$

*Then, we establish the following isomorphism of graded*  $H^{*,*}_{\text{MW}}(K)$ *-modules:* 

$$
H_{\text{MW}}^{*,*}(V_k(\mathbb{A}^n)) \cong \bigoplus_{I \subset N_{n,k}} (H_{\text{MW}})_I b_I,
$$

*where*

$$
(\mathbf{H}_{\mathrm{MW}})_I = \begin{cases} \mathbf{H}_{\mathrm{MW}}^{*,*}(K), & \text{if } I = I_F, \\ \mathbf{H}_{\mathrm{M}}^{*,*}(K), & \text{if } \mathrm{Max}(I_T) \text{ is even,} \\ {}^{\eta}\mathbf{H}_{\mathrm{M}}^{*,*}(K), & \text{if } \mathrm{Max}(I_T) \text{ is odd.} \end{cases}
$$

We can compute the Euler class as a corollary:

<span id="page-3-1"></span>**Corollary 3.5.** *For*  $k \geq 2$ *, we have* 

$$
H_{\text{MW}}^{2(n-k),n-k}(V_k(\mathbb{A}^n)) = \begin{cases} K_{-1}^{\text{MW}}\beta_{n-k}, & \text{if } n-k \text{ is even,} \\ 0, & \text{if } n-k \text{ is odd.} \end{cases}
$$

Consequently, the Euler class satisfies  $e(f_{n,k}) = \eta \beta_{n-k}$  if  $n-k$  is even, and  $e(f_{n,k}) = 0$  if  $n-k$  is odd.

*Proof.* The first part of the statement follows from comparing the degrees of generators in Theorem [3.4.](#page-3-0) Specifically, since  $b_{n-k}$  has the lowest degree  $(n-k, \{n-k+1\})$  and  $H_{MW}$  is coconnected (i.e.,  $H_{MW}^{p,\{q\}}(K) = 0$  for  $p > 0$ ), we conclude that

$$
H_{MW}^{2(n-k),n-k}(V_k(\mathbb{A}^n)) = (H_{MW})_{n-k}^{-1,-1}b_{n-k}.
$$

For  $n - k$  even, we have  $b_{n-k} = \beta_{n-k}$  and  $(H_{MW})_{n-k}^{-1, -1} = K_{-1}^{MW}$ . Conversely, for  $n - k$  odd, it follows that  $(H_{\text{MW}})^{-1,-1}_{n-k} = \eta H_{\text{M}}^{-1,-1}(K) = 0.$ 

The known values for the Euler classes in the case  $k = 1$  are provided by [\[4,](#page-6-0) Prop 3.8]. Specifically, in these situations, it is stated that  $e(f_{n,1}) = n_{\epsilon} \eta \beta_{n-1} \in \mathbb{H}_{\text{MW}}^{2(n-1),n-1}(\mathbb{A}^n \setminus \{0\})$ . This implies that  $e(f_{n,1}) = 0$  if *n* is even, and  $e(f_{n,1}) = \eta \beta_{n-1}$  if *n* is odd, where  $\beta_{n-1} \in H_{MW}^{2n-1,n}(\mathbb{A}^n \setminus \{0\})$  is a generator.

We can consider the following diagram:

$$
\mathbb{A}^{n-k} \setminus \{0\} \longrightarrow V_2(\mathbb{A}^{n-k+1}) \xrightarrow{f_{n-k+1,1}} \mathbb{A}^{n-k+1} \setminus \{0\}
$$
\n
$$
\parallel \qquad \qquad \downarrow \qquad \qquad \downarrow g
$$
\n
$$
\mathbb{A}^{n-k} \setminus \{0\} \longrightarrow V_{k+1}(\mathbb{A}^n) \xrightarrow{f_{n,k}} V_k(\mathbb{A}^n)
$$
\n
$$
\downarrow \qquad \qquad \downarrow
$$
\n
$$
V_{k-1}(\mathbb{A}^n) \longrightarrow V_{k-1}(\mathbb{A}^n)
$$

Utilizing Corollary [2.3,](#page-1-0) we observe that when  $n - k$  is even, the pullback

$$
g^*: \mathrm{H}^{2(n-k),n-k}_{\mathrm{MW}}(V_k(\mathbb{A}^n)) \to \mathrm{H}^{2(n-k),n-k}_{\mathrm{MW}}(\mathbb{A}^{n-k+1} \setminus \{0\})
$$

is an isomorphism. Furthermore, the Euler class is compatible with the pullback, expressed as  $g^*(e(f_{n,k}))$  =  $e(f_{n-k+1,1})$ . Consequently, we derive that  $e(f_{n,k}) = \eta \beta_{n-k}$ .  $\Box$ 

Although we do not provide the multiplicative structure of the graded cohomology group, we can state a useful fact about it.

<span id="page-4-0"></span>**Corollary 3.6.** *Assume*  $n - k$  *is even, and let*  $\beta_{n-k} \in H_{MW}^{*,*}(V_k(\mathbb{A}^n))$  *be a generator with*  $n > k$ *. Then we have* 

$$
\eta \beta_{n-k}^2 = 0.
$$

*Proof.* By induction and by comparing the degree, we find that the degree of  $\beta_{n-k}^2$  is given by  $\deg(\beta_{n-k}^2) = (2(n-k) \cdot k)$  $(k)$ ,  $\{2(n-k+1)\}\$ . Again, exploiting the coconnectedness of  $H_{MW}$ , we conclude that  $\beta_{n-k}^2 \in (H_{MW})_{2(n-k+1)}^{1,1}$  $\frac{1}{2(n-k)}b_{2(n-k)} =$  $K_1^M \alpha_{2(n-k)}$  if  $2(n-k) < n$ , or that  $\beta_{n-k}^2 = 0$  if  $2(n-k) \geq n$ . In both scenarios, we establish that  $\eta \beta_{n-k}^2 = 0$ .  $\Box$ 

**Remark 1.** *According to the computations in motivic cohomology [\[5\]](#page-6-5), we obtain the following result:*

$$
\beta_{n-k}^2 = \begin{cases} 0, & \text{if } 2(n-k) \ge n, \\ [-1]_{K^{\mathbf{M}}} \alpha_{2(n-k)}, & \text{if } 2(n-k) < n. \end{cases}
$$

We prove our main theorem by induction.

**Proposition 3.7.** Assuming that Theorem [3.4](#page-3-0) holds for  $V_k(\mathbb{A}^n)$ , then the exact sequence [\(1\)](#page-2-0) splits. Furthermore, *we have the following isomorphism of*  $H_{\text{MW}}^{*,*}(K)$ -modules:

$$
H_{\text{MW}}^{*,*}(V_{k+1}(\mathbb{A}^n)) \cong \begin{cases} H_{\text{MW}}^{*,*}(V_k(\mathbb{A}^n)) \oplus H_{\text{MW}}^{*,*}(V_k(\mathbb{A}^n))\beta_{n-k-1}, & \text{if } n-k \text{ is odd,} \\ H_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n)) \oplus \text{Coker}_{\eta}(H_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n)))\alpha_{n-k} \\ \oplus \text{Ker}_{\eta}(H_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n)))\alpha_{n-k-1} \oplus H_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n))\beta_{n-k,n-k-1}, & \text{if } n-k \text{ is even.} \end{cases}
$$

*Here,* Coker<sub>η</sub> $(H_{MW}^{*,*}(V_{k-1}(\mathbb{A}^n)))$  and  $Ker_n(H_{MW}^{*,*}(V_{k-1}(\mathbb{A}^n)))$  denote the cokernel and kernel of  $\eta$ *, respectively:* 

$$
0 \to \mathrm{Ker}_{\eta}(\mathrm{H}^{*,*}_{\mathrm{MW}}(V_{k-1}(\mathbb{A}^n))) \to \mathrm{H}^{*,*}_{\mathrm{MW}}(V_{k-1}(\mathbb{A}^n)) \xrightarrow{\eta} \mathrm{H}^{*,*}_{\mathrm{MW}}(V_{k-1}(\mathbb{A}^n)) \to \mathrm{Coker}_{\eta}(\mathrm{H}^{*,*}_{\mathrm{MW}}(V_{k-1}(\mathbb{A}^n))) \to 0.
$$

*Proof.* Since the boundary morphism is evident from Corollaries [3.5](#page-3-1) and [3.6,](#page-4-0) it suffices to demonstrate that the exact sequence [\(1\)](#page-2-0) splits.

When  $n-k$  is odd, the result is straightforward. In this case,  $H^{*,*}_{MW}(V_{k+1}(\mathbb{A}^n))$  serves as a  $H^{*,*}_{MW}(V_k(\mathbb{A}^n))$ -module, and  $H_{\text{MW}}^{*,*}(V_k(\mathbb{A}^n))$  itself is a free  $H_{\text{MW}}^{*,*}(V_k(\mathbb{A}^n))$ -module. We denote the generators by 1 and  $\beta_{n-k-1}$ .

When  $n - k$  is even, under our assumption, we have the isomorphism

$$
H_{\text{MW}}^{*,*}(V_k(\mathbb{A}^n)) \cong H_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n)) \oplus H_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n))\beta_{n-k}.
$$

From Corollary [3.5,](#page-3-1) we can identify the Euler class as  $e(f_{n,k}) = \eta \beta_{n-k}$ . Moreover, invoking Corollary [3.6,](#page-4-0) we can rewrite the exact sequence [\(1\)](#page-2-0) as:

$$
0 \to H_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n)) \oplus \text{Coker}_{\eta}(\text{H}_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n)))\alpha_{n-k}
$$
  

$$
\to H_{\text{MW}}^{*,*}(V_{k+1}(\mathbb{A}^n))
$$
  

$$
\to \text{Ker}_{\eta}(\text{H}_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n)))\alpha_{n-k-1} \oplus \text{H}_{\text{MW}}^{*,*}(V_{k-1}(\mathbb{A}^n))\beta_{n-k,n-k-1} \to 0.
$$

To demonstrate that this sequence splits, it is sufficient to consider the *η*-torsion part. This is evident when comparing it with the exact sequence of  $H_M^{*,*}(V_{k+1}(\mathbb{A}^n))$  presented in [\[5\]](#page-6-5).  $\Box$ 

*Proof of Theorem [3.4.](#page-3-0)* We observe that the following relations hold:

$$
Coker_{\eta}(\mathcal{H}_{\text{MW}}^{*,*}(K)) = \mathcal{H}_{\text{M}}^{*,*}(K), \quad \text{Ker}_{\eta}(\mathcal{H}_{\text{MW}}^{*,*}(K)) = {}^{\eta}\mathcal{H}_{\text{M}}^{*,*}(K),
$$
  
\n
$$
\text{Coker}_{\eta}(\mathcal{H}_{\text{M}}^{*,*}(K)) = \text{Ker}_{\eta}(\mathcal{H}_{\text{M}}^{*,*}(K)) = \mathcal{H}_{\text{M}}^{*,*}(K),
$$
  
\n
$$
\text{Coker}_{\eta}({}^{\eta}\mathcal{H}_{\text{M}}^{*,*}(K)) = \text{Ker}_{\eta}({}^{\eta}\mathcal{H}_{\text{M}}^{*,*}(K)) = {}^{\eta}\mathcal{H}_{\text{M}}^{*,*}(K).
$$

These observations provide the necessary conditions to establish the existence of a direct summand in Theorem [3.4.](#page-3-0)  $\Box$ 

# **4** Decomposition of MW-motive of  $V_k(\mathbb{A}^n)$

It is noteworthy that throughout the proof, we relied solely on the coconnectedness of  $H_{MW}$  as described in Corol-laries [3.5](#page-3-1) and [3.6.](#page-4-0) Consequently, the same computation applies to all coconnected MW-motives  $\mathbb{E} \in DM(K)$ . In particular, this assertion holds for  $C_{\eta} = C_{\eta}(K)$ .

<span id="page-5-1"></span>**Theorem 4.1.** Let  $\mathbb{E} \in \widetilde{DM}(K)$  be a coconnected MW-motive, and let  $\eta \mathbb{E}$  and  $\mathbb{E}/\eta$  denote the kernel and cokernel *of the morphism η. The sequence is defined as follows:*

$$
0 \to {\rm W}^{\ast,\ast}(K) \to \mathbb{E}^{\ast,\ast}(K) \xrightarrow{\eta} \mathbb{E}^{\ast,\ast}(K) \to (\mathbb{E}/\eta)^{\ast,\ast}(K) \to 0
$$

*We use the same notation as in Theorem [3.4.](#page-3-0) Then, we establish an isomorphism of graded*  $\mathbb{E}^{*,*}(K)$ *-modules:* 

$$
\mathbb{E}^{*,*}(V_k(\mathbb{A}^n)) = \bigoplus_{I \subset N_{n,k}} \mathbb{E}_I b_I
$$

*where*

$$
\mathbb{E}_I = \begin{cases} \mathbb{E}^{*,*}(K), & \text{if } I = I_F, \\ (\mathbb{E}/\eta)^{*,*}(K), & \text{if } \text{Max}(I_T) \text{ is even,} \\ \eta \mathbb{E}^{*,*}(K), & \text{if } \text{Max}(I_T) \text{ is odd.} \end{cases}
$$

We now proceed to prove the conjecture stated in [\[4,](#page-6-0) Conj 1.4]. Recall that  $C<sub>\eta</sub>(S)$  represent the cone of the morphism  $\widetilde{\mathcal{M}}(S) \stackrel{\eta}{\rightarrow} \widetilde{\mathcal{M}}(S)(1)[1]$ , and

$$
\widetilde{\mathbf{HS}}_{2k} := \widetilde{\mathbf{M}}(\mathbb{A}^{2k} \setminus \{0\}) \cong \widetilde{\mathbf{M}}(S) \oplus \widetilde{\mathbf{M}}(S)(2k)[4k-1],
$$
  

$$
\widetilde{\mathbf{HS}}_{2k+1} := \widetilde{\mathbf{M}}(S) \oplus C_{\eta}(S)(2k)[4k] \oplus \widetilde{\mathbf{M}}(S)(4k+1)[8k].
$$

<span id="page-5-0"></span>**Theorem 4.2.** For any  $i, j \in \mathbb{N}$ , we obtain an MW-motivic decomposition of the following forms:

$$
\widetilde{\mathbf{M}}(V_{2j}(\mathbb{A}^{2i})) \cong \widetilde{\mathbf{HS}}_{2i} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \widetilde{\mathbf{HS}}_{2i-3} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i-1-2(j-2)} \otimes \widetilde{\mathbf{M}}(\mathbb{A}^{2i+1-2j} \setminus \{0\})
$$
\n
$$
\widetilde{\mathbf{M}}(V_{2j+1}(\mathbb{A}^{2i})) \cong \widetilde{\mathbf{HS}}_{2i} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \widetilde{\mathbf{HS}}_{2i-3} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i-1-2(j-1)}
$$
\n
$$
\widetilde{\mathbf{M}}(V_{2j}(\mathbb{A}^{2i+1})) \cong \widetilde{\mathbf{HS}}_{2i+1} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i+1-2(j-1)}
$$
\n
$$
\widetilde{\mathbf{M}}(V_{2j+1}(\mathbb{A}^{2i+1})) \cong \widetilde{\mathbf{HS}}_{2i+1} \otimes \widetilde{\mathbf{HS}}_{2i-1} \otimes \ldots \otimes \widetilde{\mathbf{HS}}_{2i+1-2(j-1)} \otimes \widetilde{\mathbf{M}}(\mathbb{A}^{2i+1-2j} \setminus \{0\}).
$$

*Proof.* We will only prove the case when *S* = Spec *K*.

Let  $Y_{k,n}$  denote the right-hand side of the isomorphism in the theorem. By definition, we have the following cofiber sequences for *Yk,n*:

$$
Y_{k-1,n-1} \to Y_{k,n} \to \tilde{\mathbb{Z}}(n)[2n-1] \otimes Y_{k-1,n-1} \xrightarrow{0}
$$

for *n* even, and

$$
Y_{k-1,n-1} \to Y_{k,n} \to \widetilde{\mathbb{Z}}(n)[2n-1] \otimes Y_{k-1,n-1} \xrightarrow{\beta}
$$

for *n* odd, where  $\beta$  is defined as follows:

$$
\widetilde{\mathbb{Z}}(n)[2n-1] \otimes (Y_{k-2,n-2} \oplus Y_{k-2,n-2}(n-1)[2n-3]) \xrightarrow{\begin{bmatrix} 0 & \eta \\ 0 & 0 \end{bmatrix}} Y_{k-2,n-2}[1] \oplus Y_{k-2,n-2}(n-1)[2n-2].
$$

From Theorem [4.1,](#page-5-1) we observe that for coconnected  $\mathbb{E}$ , the following holds:

$$
\mathrm{Hom}_{\widetilde{\mathrm{DM}}(K)}(\widetilde{\mathrm{M}}(V_k(\mathbb{A}^n)), \mathbb{E}(q)[p]) \cong \mathrm{Hom}_{\widetilde{\mathrm{DM}}(K)}(Y_{k,n}, \mathbb{E}(q)[p]).
$$

It is noteworthy that  $Y_{k,n}$  is a direct sum of  $\mathbb{Z}(q)[p]$  and  $C_{\eta}(q)[p]$ . In particular, we have

$$
\operatorname{Hom}_{\widetilde{\operatorname{DM}}(K)}(\widetilde{\operatorname{M}}(V_k(\mathbb{A}^n)), Y_{k,n}) \cong \operatorname{Hom}_{\widetilde{\operatorname{DM}}(K)}(Y_{k,n}, Y_{k,n}).
$$

Let  $\iota_{k,n} : \widetilde{\mathcal{M}}(V_k(\mathbb{A}^n)) \to Y_{k,n}$  denote the morphism corresponding to the identity of  $Y_{k,n}$ . We now need to prove inductively that  $\iota_{k,n}$  is an isomorphism. For  $k = 1$ , this is evident, and for  $k = 2$ , the result follows from [\[4,](#page-6-0) Cor 3.9].

For  $V_k(\mathbb{A}^n)$ , we have the following cofiber sequence in  $\mathcal{H}(K)$  (see [\[4,](#page-6-0) §3.2]):

$$
V_{k-1}(\mathbb{A}^{n-1})_+ \to V_k(\mathbb{A}^n)_+ \to \mathbb{A}^n \setminus \{0\} \wedge V_{k-1}(\mathbb{A}^{n-1})_+.
$$

When *n* is even, one can construct the splitting projection using that of  $Y_{k,n}$ :

$$
\operatorname{Hom}_{\widetilde{\operatorname{DM}}(K)}(\widetilde{\operatorname{M}}(V_k(\mathbb{A}^n)),\widetilde{\operatorname{M}}(V_{k-1}(\mathbb{A}^{n-1})))\cong \operatorname{Hom}_{\widetilde{\operatorname{DM}}(K)}(\widetilde{\operatorname{M}}(V_k(\mathbb{A}^n)),Y_{k-1,n-1})\cong \operatorname{Hom}_{\widetilde{\operatorname{DM}}(K)}(Y_{k,n},Y_{k-1,n-1}).
$$

Thus, it follows that

$$
\widetilde{\mathcal{M}}(V_k(\mathbb{A}^n)) \cong \widetilde{\mathcal{M}}(V_{k-1}(\mathbb{A}^{n-1})) \oplus \widetilde{\mathcal{M}}(V_{k-1}(\mathbb{A}^{n-1}))(n)[2n-1] \cong Y_{k-1,n-1} \oplus Y_{k-1,n-1}(n)[2n-1] \cong Y_{k,n}.
$$

For *n* odd, by employing the same argument used in the proof of [\[4,](#page-6-0) Prop 3.13], we arrive at the following cofiber sequences in  $DM(K)$ :

The equations presented elucidate the relationships between various mathematical structures in the study. Specifically, we have the following mappings:

$$
\widetilde{\mathcal{M}}(V_{k-2}(\mathbb{A}^{n-2})) \to \widetilde{\mathcal{M}}(V_k(\mathbb{A}^n)) \to Q_{k,n}
$$

and

$$
C_{\eta} \otimes \widetilde{\mathcal{M}}(V_{k-2}(\mathbb{A}^{n-2}))(n-1)[2n-2] \to Q_{k,n} \to \widetilde{\mathbb{Z}}(n)[2n-1] \otimes \widetilde{\mathcal{M}}(V_{k-2}(\mathbb{A}^{n-2}))(n-1)[2n-3]
$$

In a similar vein, we can construct the splitting projections, leading us ultimately to the isomorphisms:

$$
\widetilde{\mathcal{M}}(V_k(\mathbb{A}^n)) \cong \widetilde{\mathcal{M}}(V_{k-2}(\mathbb{A}^{n-2})) \oplus \left(C_\eta \otimes \widetilde{\mathcal{M}}(V_{k-2}(\mathbb{A}^{n-2}))(n-1)[2n-2]\right) \oplus \widetilde{\mathcal{M}}(V_{k-2}(\mathbb{A}^{n-2}))(2n-1)[4n-4] \cong Y_{k-2,n-2} \oplus (C_\eta \otimes Y_{k-2,n-2}(n-1)[2n-2]) \oplus Y_{k-2,n-2}(2n-1)[4n-4] \cong Y_{k,n}
$$
