## A Comprehensive Review on Traffic Datasets and Simulators for Autonomous Vehicles

Abstract—Autonomous driving has rapidly developed and shown promising performance due to recent advances in hardware and deep learning techniques. High-quality datasets are fundamental for developing reliable autonomous driving algorithms. Previous dataset surveys either focused on a limited number or lacked detailed investigation of dataset characteristics. Besides, we analyze the annotation processes, existing labeling tools, and the annotation quality of datasets, showing the importance of establishing a standard annotation pipeline. On the other hand, we thoroughly analyze the impact of geographical and adversarial environmental conditions on the performance of autonomous driving systems. Moreover, we exhibit the data distribution of several vital datasets and discuss their pros and cons accordingly.

Additionally, this paper provides a comprehensive analysis of publicly available traffic simulators. In addition to informing about traffic datasets, it is also the goal of this paper to provide context and information on the current capabilities of traffic simulators for their specific contributions to autonomous vehicle simulation and development. Furthermore, this paper discusses future directions and the increasing importance of synthetic data generation in simulators to enhance the training and creation of effective simulations. Finally, we discuss the current challenges and the development trend of future autonomous driving datasets.

#### I. INTRODUCTION

The field of transportation is experiencing a profound transformation, largely driven by the advent of self-driving vehicles. This revolution extends beyond mere technological innovation; it promises to redefine the entire landscape of mobility, safety, and urban planning. These rapid advancements in autonomous driving rely heavily on extensive datasets, which help autonomous driving systems be robust and reliable in complex driving environments [1]. Autonomous vehicles (AV) are equipped with sophisticated sensors and powered by artificial intelligence (AI) and machine learning algorithms. These systems are designed to replace human drivers and enhance overall efficiency. However, despite these advancements, autonomous vehicles are not yet fully capable of eliminating accidents associated with human error. Incidents involving major companies like Tesla, Uber, and Waymo have underscored the persistent challenges and limitations of AI technologies, particularly in complex, real-world driving scenarios. The architecture of autonomous driving technology typically encompasses three main modules: environmental perception, decision making,

and motion control [2], [3]. The decision-making module, in particular, plays a crucial role, akin to a driver's brain, and its effectiveness is vital for safe vehicle operation [4].

In recent years, there has been a significant increase in the quality and variety of autonomous driving datasets. The motivation for this enhancement is twofold. Firstly, improved datasets facilitate the development of more accurate and sophisticated algorithms capable of handling a wider range of driving scenarios. Secondly, these datasets serve as a foundational component for researchers and engineers to innovate and refine autonomous driving technologies. By expanding the scope and diversity of these datasets, the field can accelerate the advancement of autonomous vehicle capabilities, ultimately leading to safer and more reliable systems.

Traffic datasets and simulators are interrelated in several crucial ways that significantly impact the advancement of autonomous driving technologies. Traffic simulators rely on real-world datasets to accurately model driving environments, incorporating diverse road conditions, traffic patterns, and driver behaviors. This integration ensures that the simulated scenarios closely mimic real-life situations, providing a realistic platform for testing and development. Conversely, simulators can generate synthetic datasets by creating virtual scenarios that are rare or difficult to capture in reality. These synthetic datasets augment existing real-world data, offering a more comprehensive set of scenarios for training and evaluating AV systems. Real-world data enhances simulation accuracy, and simulation-generated data enriches real-world datasets. By intertwining datasets and simulators, researchers can accelerate the development and validation of autonomous driving algorithms, leading to more robust, safe, and reliable AV systems that effectively bridge the gap between virtual simulations and real-world driving conditions.

The main goal of this work is to investigate the development of traffic datasets and simulators in the field of autonomous driving. By providing a more comprehensive and nuanced understanding of the dynamics of autonomous systems, researchers can address current limitations and push the boundaries of what these technologies can achieve.

The remaining paper is organized as follows. In section II, a taxonomy of AV traffic dataset regarding its main modules - perception, localization, prediction, planning and control is proposed. The state-of-the-art datasets in these areas are discussed in sections III-A, III-B, and III-C, respectively. We discussed traffic simulators in section V. Open research challenges and future directions are discussed in section VI. Finally, section VII concludes the paper.




Fig. 1: Year-wise Distribution of Reviewed Papers




Fig. 2: Domain-wise Distribution of AV Datasets




Fig. 3: Distribution of Used Methods in Simulators

## II. TAXONOMY OF TRAFFIC DATASET AND SIMULATOR

The overall working framework of autonomous vehicles (AV) can be grouped into five modules. Fig. 6 demonstrates the framework of AV. We grouped the AV traffic dataset based on each module shown in AV framework. Some datasets fall into multiple groups, so for ease of discussion, we distributed the papers into three groups based on the tasks performed- (i) perception and localization, (ii) prediction, and (iii) plan and control. In Table I and Table II, a year-wise paper distribution is listed for perception and localization described in section III-A, prediction in section III-B, plan and control described in section III-C, respectively. A list of additional traffic datasets has been listed in Table III, IV and V. The year-wise frequency of papers is demonstrated in Fig. 1.




Fig. 4: 1993-2024 Year-wise Distribution of Reviewed Simulators




Fig. 5: Framework of Simulators

The traffic simulators used for AV research are categorized based on three main categories: (i) perception and sensor-focused simulators, (ii) scenario-based simulators, and (iii) traffic and mobility simulators. By organizing the simulators in this way, we aim to clarify the specific contributions of each type to AV simulation and development. Each simulator has multiple functionalities spanning from MARL, real data imports, and other specialized features such as LIDAR support and 2D/3D rendering. Fig. 3 shows the range of capabilities that the simulators have to offer. All simulators mentioned are data reliant, whether that be because of being pretrained on datasets or allowing for the inclusion of new data in its simulation. Additionally, Fig. 5 outlines the typical framework for building traffic simulators and the importance that data plays within them.

Additionally, the year-by-year breakdown of released traffic simulators is shown in Fig. 4. A list of all relevant simulators is shown on Table VI and VII.

## III. AUTONOMOUS DRIVING DATASET

## A. Perception and Localization

Perception focuses on understanding the environment based on the sensory data, while localization determines the autonomous vehicle's position within that environment. object detection aims to identify the locations and classification of other entities within the driving environment. Although the detection technologies have significantly advanced, several challenges remain, such as object occlusions, varying light conditions, and diverse object appearances.

#### 1) Onboard:

• KITTI [5] dataset is one of the most significant datasets for decision-making in urban driving scenarios, offering extensive data for 3D reconstruction, detection, tracking, and visual odometry. It includes videos capturing the movements of pedestrians, vehicles, and cyclists alongside the car. Since its release in 2012, KITTI has played a key role in advancing the field of autonomous driving. It gathers data from various sensors like cameras, LiDAR, and GPS/IMU, which helps in developing algorithms for object detection, tracking, and depth estimation. However, the data from KITTI was primarily collected under ideal weather conditions




Fig. 6: Framework of Autonomous Vehicles

in German cities. This limitation in geographic and environmental diversity may restrict its applicability in real-world settings across different regions.

BDD100K [6] known for its considerable size and diversity, contains 100,000 city driving scene videos, each approximately 40 seconds long. This dataset encompasses a broad spectrum of geographic, environmental, and weather conditions, including different times of the day, significantly enhancing its utility for testing and refining the robustness of image recognition algorithms in autonomous driving. BDD100K was meticulously assembled to support advancements in image recognition technologies. It includes GPS/IMU recordings to accurately track driving trajectories and offers a multiple object tracking (MOT) dataset comprising 2,000 videos with around 400,000 frames in total. The dataset facilitates comprehensive autonomous driving research with benchmarks across ten tasks: image tagging, lane detection, drivable area segmentation, road object detection, semantic segmentation, instance segmentation, multi-object detection tracking, multi-object segmentation tracking, domain adaptation, and imitation learning. Moreover, the dataset was trained using Dilated Residual Networks (DRN) and evaluated against other benchmarks like Cityscapes and Faster-RCNN based on ResNet-50, with results assessed using the COCO API. Despite its strengths, BDD100K faces challenges related to the varying quality of video annotations, which can affect the dataset's applicability in real-world scenarios. This highlights the ongoing need for consistent, highquality annotations to ensure the effectiveness of algorithms under all operational conditions.

#### Argoverse

Building on its predecessor, Argoverse 1 [7], Argoverse 2 [8] offers a more diversified and complex array of driving scenarios, making it one of the most comprehensive autonomous driving taxonomies currently available. This enhanced version captures a variety of real-world driving situations across six cities under different conditions, greatly expanding its utility and scope. Argoverse 2 supports a broad array of crucial tasks, including 3D object detection, semantic segmentation, and tracking. Addressing these constraints by including more adversarial conditions and edge cases could further broaden its practical applications in the field.

• Waymo [9] dataset, introduced in 2019, has significantly advanced research in autonomous driving by offering a new large-scale, high-quality, and diverse dataset. This dataset encompasses 1150 scenes, each spanning 20 seconds and featuring well-synchronized and calibrated high-quality LiDAR and camera data from various urban and suburban settings. Waymo's dataset includes extensive multimodal sensory data with high-quality annotations, setting strong baselines for both 2D and 3D detection and tracking tasks. The data is thoroughly annotated with 2D (camera images) and 3D (LiDAR) bounding boxes, maintaining consistent identifiers across frames. This comprehensive coverage of diverse driving conditions and geographies is crucial for the robustness and generalizability of different tasks.

- SemanticKITTI [10] comprises over 43,000 LiDAR point cloud frames, positioning it as one of the most comprehensive datasets for 3D semantic segmentation in outdoor environments. The dataset includes precise labels for 28 categories, such as cars, roads, and buildings, establishing a robust benchmark for semantic segmentation. However, similar to other datasets, SemanticKITTI encounters limitations in real-world applicability due to its restricted environmental diversity and geographical scope. The authors annotated all sequences of the KITTI Vision Odometry Benchmark, providing dense point-wise annotations for the complete 360degree field-of-view of the automotive LiDAR used. They propose three benchmark tasks based on this dataset: (i) semantic segmentation of point clouds using a single scan, (ii) semantic segmentation using multiple past scans, and (iii) semantic scene completion, which involves anticipating the semantic scene in the future. Baseline experiments are provided, demonstrating the need for more sophisticated models to efficiently tackle these tasks. This dataset not only fosters the development of more advanced methods but also offers ample data to explore new research directions.
- nuScenes [11] stands out as a pivotal contribution to the field of autonomous driving by offering a comprehensive multimodal sensor setup that includes LiDAR, radars, and cameras. This setup is particularly effective in capturing the diversity of urban scenes and varying environmental conditions. It is the first dataset to incorporate the full sensor suite essential for autonomous vehicles, which includes six cameras, five radars, and one LiDAR, all providing a 360-degree field of view, nuScenes includes 1000 scenes, each lasting 20 seconds and thoroughly annotated with 3D bounding boxes for 23 classes and 8 attributes. The dataset contains seven times as many annotations and one hundred times as many images as the earlier KITTI dataset, marking a significant expansion in data richness. The researchers have introduced novel 3D detection and tracking metrics, provided detailed dataset analyses, and established baselines for LiDAR and image-based detection and tracking tasks.
- Cityscapes [12] consists of a vast collection of images captured in complex urban environments and has established itself as a standard benchmark for semantic segmentation. It provides pixel-level segmentation with detailed labeling for 30 object classes, including various vehicle types, pedestrians, roads, and traffic signs. However, Cityscapes primarily focuses on German cities and lacks diverse weather conditions, which limits its utility for developing robust and generalized solutions for autonomous driving. The Cityscapes dataset serves as a benchmark suite designed to train and test both pixel-level and instance-level semantic labeling approaches. The dataset features a large and diverse set of stereo video sequences recorded on the streets of 50 different cities. Of these, 5000 images have high-quality pixel-

- level annotations, while an additional 20,000 images feature coarse annotations, which are useful for methods that leverage large volumes of weakly-labeled data. This effort surpasses previous attempts in terms of dataset size, annotation richness, scene variability, and complexity. An accompanying empirical study offers an in-depth analysis of the dataset characteristics and evaluates the performance of several state-of-the-art approaches based on this benchmark.
- VIPER [13] is a synthetic dataset gathered from driving, riding, and walking perspectives within a realistic virtual world. It comprises over 250,000 video frames, all annotated with ground-truth data suitable for a variety of low- and high-level vision tasks. This dataset captures diverse weather conditions, lighting scenarios, and complex urban landscapes, rendering it an essential tool for evaluating the robustness of autonomous driving algorithms. However, the transition from synthetic data to real-world application poses significant challenges, as algorithms need to overcome the domain gap to remain effective in actual environments. The VIPER benchmark includes more than 250,000 high-resolution video frames, meticulously annotated for both lowlevel and high-level vision tasks. These tasks include optical flow, semantic instance segmentation, object detection and tracking, object-level 3D scene layout, and visual odometry. Comprehensive ground-truth data is available for every frame, collected across a total of 184 kilometers driven, ridden, and walked under varied ambient conditions in a realistic virtual setting. This extensive and detailed dataset aids in developing and testing algorithms across multiple vision tasks in simulated environments.

#### 2) V2X:

- TUMTraf [14] integrates multiple data modalities such as RGB cameras, event-based cameras, LiDAR, GPS, and IMU, offering unique perspectives from both infrastructure and vehicles. This setup facilitates research in cooperative perception. Notably, TUMTraf includes critical edge cases such as accidents, near-miss events, and traffic violations, making it an invaluable resource for enhancing perception systems. TUMTraf-V2X is a perception dataset designed for cooperative 3D object detection and tracking tasks. It encompasses 2,000 labeled point clouds and 5,000 labeled images collected from five roadside and four onboard sensors. The dataset features 30,000 3D boxes with track IDs and includes precise GPS and IMU data. It also covers a range of challenging driving scenarios, including traffic violations, near-miss events, overtaking, and U-turns, all labeled across nine categories to address occlusions and complex maneuvers.
- DAIR-V2X Dataset [15] has been released, marking the first large-scale, multi-modality, multi-view dataset from real scenarios for Vehicle-Infrastructure Cooperative Autonomous Driving (VICAD). Comprising 71,254

LiDAR frames and 71,254 camera frames, DAIR-V2X captures all frames from real-world scenes with 3D annotations. DAIR-V2X stands as a pioneering resource in Vehicle-Infrastructure Cooperative Autonomous Driving, offering extensive, multi-modality, real-world data. The dataset is specifically designed to address challenges such as the temporal asynchrony between vehicle and infrastructure sensors, and the data transmission costs inherent in cooperative systems. DAIR-V2X has been crucial in advancing vehicle-infrastructure cooperation, establishing benchmarks for tackling V2X perception tasks.

## 3) UAV:

- UAVDT [16] A new UAV benchmark has been developed, focusing on complex urban scenarios with unique challenges. From 10 hours of raw video footage, about 80,000 frames have been selected and fully annotated with bounding boxes and up to 14 kinds of attributes, such as weather conditions, flying altitude, camera views, vehicle categories, and levels of occlusion. This dataset supports three fundamental computer vision tasks: object detection, single object tracking, and multiple object tracking. The UAVDT benchmark is tailored for UAV-based object detection and tracking, featuring high-density urban scenes with small objects and significant camera motion. These conditions pose substantial challenges to current state-of-the-art methods in computer vision.
- DroneVehicle [17] dataset, a significant advancement in drone-based technologies, comprises 28,439 RGB-Infrared image pairs. This large-scale dataset is specifically designed for object detection, particularly under low-illumination conditions. It encompasses a diverse array of scenarios, including urban roads, residential areas, and parking lots, from day to night. The crossmodal images in this dataset provide complementary information that enhances vehicle detection, although they also include some redundant data. DroneVehicle's unique drone perspective and comprehensive coverage across varied conditions mark a notable development in the field of autonomous driving technologies.

#### B. Prediction

Prediction refers to forecasting the future states or actions of surrounding agents. This capacity ensures safer navigation in dynamic environments.

1) Trajectory Prediction: Predicting the trajectories of other participants in transportation is a critical component of autonomous driving technology, leading to the development of several relevant datasets. Based on time-series data from sensors like cameras and LiDARs, trajectory prediction pertains to anticipating the future paths or movement patterns of other entities [58], such as pedestrians, cyclists, or other vehicles. The Argoverse dataset is particularly useful for 3D tracking and motion forecasting in complex driving scenarios such as intersections, turns, and lane changes in heavy traffic.

Expanding on this, the Argoverse 2 dataset includes a broader range of objects, increasing from 17 to 30 categories, and adds objects like strollers and wheelchairs to provide a more diverse set of data for developing trajectory prediction algorithms. Additionally, the PREVENTION dataset utilizes multiple sensor modalities to capture redundant and complementary data, labeling all actions observed in scenes. This dataset is instrumental in advancing research on trajectory prediction, especially in situations where there is significant interaction among vehicles and other road users.

2) Behavior Prediction: Behavior prediction anticipates the potential actions of other road users [59], e.g., whether a vehicle will change the lane. Training behavior prediction models rely on extensive annotated data due to entities' vast range of potential actions within various scenarios. In data-driven approaches to autonomous driving, behavioral strategy learning is typically achieved using classification machine learning methods. These methods categorize vehicle actions into discrete behaviors such as turns, lane shifts, and deceleration, rather than mapping out continuous movements. Learning to make driving decisions is heavily reliant on how these behaviors are annotated in datasets. For instance, the D2CAV dataset [42] labels various driving actions into distinct behaviors and ensures a balanced representation of these behaviors to reflect real-world driving scenarios accurately. On the other hand, the HDD dataset [32] introduces a fourlayer annotation structure, and the ROAD dataset [60] uses a triplet structure for road events, which provide detailed context in terms of antecedents and consequences. This additional detail helps models learn more precise behavioral strategies and enhances their ability to interpret data. Additionally, the Brain4Cars dataset [28] integrates data on the driver's condition along with information about the road environment, facilitating the development of models that can make informed behavior decisions by considering multiple factors simultaneously.

For behavioral strategy learning to be effective, it's crucial that datasets not only mirror real-world conditions closely but also include detailed annotations and data processing. This enhances the interpretability of the algorithms, enabling them to make more accurate and reliable decisions based on the observed data.

3) Intention Prediction: Intention prediction focuses on inferring the higher-level goals behind the actions of objects, involving a deeper semantic comprehension of the physical or mental activities of humans [61]. Because of the task's complexity, it requires data from perception sensors like cameras, traffic signals, and hand gestures. Understanding the intentions of traffic participants is crucial for decision-making in autonomous and assistive driving systems. Several datasets have been developed to identify or predict these intentions, particularly those of pedestrians and vehicles. One such dataset, the PIE dataset [33], includes extensive video resources and models specifically aimed at estimating pedestrian intentions and predicting their trajectories. It focuses on pedestrians who are likely to interact with the vehicle (ego vehicle), with their behaviors and intentions

annotated by human experts. Advancements in natural language processing have also led to the creation of the PSI dataset [62]. This dataset records text-based explanations of drivers' understanding of scenes and their reasoning processes. These explanations connect important visual scene features with human decision-making, supporting the development of algorithms that can explain and mimic humanlike pedestrian intention analysis and prediction. In contrast to focusing solely on pedestrians, the JAAD dataset [63] includes data for analyzing the behaviors of all road users around the vehicle. Additionally, the HDD dataset [32], with its four-layer annotation structure, facilitates the exploration of interactions between drivers and other traffic participants, using cause-and-effect labels. These datasets collectively enhance our ability to develop more sophisticated and intuitive driving assistance technologies.

#### C. Planning and Control

Planning and control datasets are fundamental in advancing the development of driving systems. These datasets are crucial for predicting traffic dynamics, pedestrian behavior, and other key factors that affect driving decisions. We provide detailed analyses of several high-impact datasets relevant to these tasks, evaluating them based on data size, modalities, and the number of citations. We have organized these datasets into categories that are task-specific and those

that are suitable for multiple tasks.

## 1) Task-Specific Datasets:

## • highD [30]

Scenario-based testing is recognized as an effective method for the safety validation of highly automated vehicles, a technique that is under active investigation by both research and industry sectors. This approach significantly depends on real-world data to extract essential scenario information needed for testing. Traditional measurement techniques often fall short in capturing authentic road user behaviors or providing comprehensive, high-quality data. To address these gaps, a novel method employing aerial perspective measurements has been developed to enhance scenario-based validation, ensuring the capture of naturalistic behavior and all relevant data in adequate quality. The highD dataset, gathered via drone-based observations on German highways, exemplifies this new method. It comprises a substantial collection of naturalistic vehicle trajectories, featuring post-processed data from 110,000 cars and trucks. This dataset spans 16.5 hours of measurements from six different locations, documenting a total of 45,000 kilometers driven and 5,600 complete lane changes. The highD dataset is meticulously evaluated for its quantity, variety, and the scenarios it contains, designed to overcome the limitations of previous measurement

techniques. However, it is important to note that the highD recordings were made under ideal weather conditions. This limitation restricts its applicability in adverse weather scenarios, highlighting an area for potential enhancement in future data collection efforts.

#### • PIE [33]

Anticipating pedestrian behavior is a critical challenge in developing assistive and autonomous driving systems tailored for urban settings. Such systems must be capable of understanding the intentions or motives of pedestrians and predicting their forthcoming actions. Until recently, only a limited number of public datasets were available for studying pedestrian behavior prediction within the context of intelligent driving systems. The introduction of the Pedestrian Intention Estimation (PIE) dataset marks a substantial advancement in this field. This novel, large-scale dataset is specifically designed for the estimation of pedestrian intentions and

prediction of their future trajectories. It was developed based on extensive human experiments conducted to gather reference data on pedestrian intentions in traffic scenarios. Models developed from the PIE dataset can estimate pedestrian crossing intentions with an accuracy of 79%, and the trajectory prediction algorithm surpasses existing methods by 26%. The PIE dataset includes over six hours of driving footage recorded in downtown Toronto, captured under various lighting conditions. It features detailed annotations necessary for perception and visual reasoning tasks, such as bounding boxes with occlusion flags, confidence levels of crossing intentions, and text labels describing pedestrian actions. This rich dataset not only improves understanding of pedestrian behavior but also enhances the ability of systems to combine observed motion with intention estimation, leading to better trajectory predictions.

#### Argoverse [7]

The Argoverse dataset has been developed to enhance autonomous vehicle perception tasks such as 3D tracking and motion forecasting. This dataset incorporates sensor data from a fleet of autonomous vehicles operating in Pittsburgh and Miami, featuring comprehensive 3D tracking annotations, approximately 300,000 extracted vehicle trajectories, and detailed semantic maps. The sensor suite includes 360-degree imagery from seven cameras with overlapping fields of view, forward-facing stereo imagery, and 3D point clouds from long-range LiDAR, supported by 6-DOF pose data. Argoverse covers 290 kilometers of mapped lanes enriched with geometric and semantic metadata, such as lane direction, drivable areas, and ground height, which enhance the accuracy of 3D object tracking. This rich mapping data is instrumental in mining for extensive vehicle trajectories, establishing a robust benchmark for trajectory forecasting. The dataset's utility in 3D object tracking and motion forecasting extends to realworld applications, proving effective in urban settings. However, its performance across different geographical regions might vary, indicating a potential area for further exploration and adaptation. This dataset not only supports the current research and development in predictive systems but also invites further studies to explore the full potential of integrating rich maps into robotic perception. The effectiveness of Argoverse in various urban environments underscores its pivotal role in advancing autonomous vehicle technologies.

#### • nuPlan [47]

A comprehensive dataset, nuPlan, has been introduced as the world's first closed-loop machine learning-based planning benchmark in autonomous driving. This multimodal dataset encompasses approximately 1,500 hours of human driving data collected from four cities across the US and Asia—Boston, Pittsburgh, Las Vegas, and Singapore. The dataset captures diverse traffic scenarios, including merges, lane changes, interactions with cyclists and pedestrians, and navigation through construction zones. The dynamic and interactive nature of the data in the nuPlan dataset allows for a more realistic evaluation of autonomous driving systems, supporting the development of adaptive and context-aware planning technologies.

#### • exiD [53]

The exiD dataset leverages camera-equipped drones to efficiently record traffic on the German Autobahn without vehicle-to-vehicle occlusion and without influencing the traffic flow. This method has proven to be efficient in terms of cumulative kilometers covered, establishing the dataset as a benchmark for addressing various research questions in autonomous driving. Specifically recorded at highway entries and exits, exiD captures a wide variety of interactions, especially those involving lane changes—a scenario notably absent in previous datasets but crucial for testing highly automated vehicles. The dataset encompasses data from 69,172 road users, cat-

egorized as cars, trucks, and vans, totaling more than 16 hours of high-quality traffic footage. Despite its comprehensive coverage of interactive highway scenarios, potential improvements for exiD could include extending the dataset to incorporate varying weather conditions and nighttime recordings, thereby enhancing its application and realism in autonomous vehicle development.

## • MONA [54]

The Munich Motion Dataset of Natural Driving (MONA) encompasses an extensive collection of data, featuring 702,000 trajectories derived from 130 hours of video recordings. This dataset captures diverse traffic dynamics on urban multi-lane roads, an inner-city highway, and their transitional areas. MONA is noted for its high position accuracy, averaging 0.51 meters, which underscores the quality of data obtained using precise localization and LiDAR sensors. Despite its comprehensiveness, the dataset's collection from a singular city could pose limitations on its generalizability to different geographic contexts.

#### 2) Multi-Task Datasets:

#### • INTERACTION [64]

Adversarial and Cooperative moTION dataset (INTER-ACTION dataset) is a comprehensive resource designed to support behavior-related research in fields such as motion prediction, planning, imitation learning, behavior modeling, and algorithm testing. This dataset provides a rich variety of interactive driving scenarios that include urban, highway, and ramp settings, as well as complex environments like roundabouts, signalized intersections, and multi-stop intersections. It captures motion data from various countries and continents, reflecting diverse driving styles and cultural behaviors, and includes highly interactive and complex driving behaviors ranging from aggressive and irrational decisions to cooperative and cautious maneuvers. The dataset also spans a wide range of criticality in driving operations, from safe practices to dangerous, near-collision maneuvers, and even includes slight real collisions. Accompanied by detailed semantic maps that provide comprehensive information on physical layers, reference lines, lane connections, and traffic rules, the INTERACTION dataset is invaluable for developing and validating traffic-related algorithms. However, its comprehensive scope is slightly limited by a lack of explicit consideration for varying environmental conditions, which could influence its effectiveness in diverse real-world applications.

#### rounD [36]

The rounD dataset, which was collected using a drone equipped with a 4K resolution camera, captures extensive road user trajectories at three different roundabouts in Germany. This dataset is particularly valuable for behavior planning in automated vehicles due to the high density of interactions between various road users such

as cars, vans, trucks, buses, pedestrians, bicycles, and motorcycles. Over six hours of video were recorded, documenting more than 13,746 road users. The data includes detailed information on positions, headings, speeds, accelerations, and classifications of objects, all extracted using deep neural networks. This makes the rounD dataset crucial for scenario classification, road user behavior prediction, and driver modeling within the field of autonomous driving. It facilitates the study of naturalistic driving behaviors in public traffic, although the dataset's exclusive collection under clear weather conditions may limit the development of models that perform well in more challenging environmental situations.

## • Lyft Level 5

Inspired by the transformative impact of large-scale datasets on machine learning systems, the Lyft Level 5 dataset has been introduced as one of the most comprehensive autonomous driving datasets for motion prediction available today. Accumulating over 1,000 hours of data, this dataset was gathered by a fleet of 20 autonomous vehicles operating on a fixed route in Palo Alto, California, over a span of four months. It comprises 170,000 scenes, each lasting 25 seconds, capturing detailed perception outputs of the self-driving system. These outputs precisely encode the positions and motions of nearby vehicles, cyclists, and pedestrians. Additionally, the dataset includes a high-definition semantic map featuring 15,242 labeled elements, along with a high-resolution aerial view of the area. This extensive collection supports multiple tasks essential to autonomous driving, such as motion forecasting, planning, and simulation. With its multimodal data and detailed annotations, the Lyft Level 5 dataset serves as a critical benchmark for prediction and planning in autonomous vehicle development. However, despite its breadth, the dataset has limitations in accurately representing scenarios involving uncommon traffic conditions or rare pedestrian behaviors, which may affect its application in less typical driving situations.

## • LOKI [48]

Recent advances have underscored the importance of explicitly considering agents' intentions for accurately forecasting their movements in trajectory prediction studies. However, the applicability of current research to intelligent and safety-critical systems is limited, largely due to the scarcity of public datasets that typically focus only on pedestrian-specific intents within a short time frame and from a restricted egocentric perspective. In response to this, the LOKI dataset, which stands for Long Term and Key Intentions, has been developed as a large-scale resource aimed at addressing these shortcomings. LOKI is designed for joint trajectory and intention prediction involving heterogeneous traffic agents, such as pedestrians and vehicles, in an autonomous driving context. LOKI seeks to explore several factors that influence intention, including the agent's own will, social interactions, environmental constraints, and contextual information. It provides a multidimensional view of traffic scenarios, incorporating camera images alongside corresponding LiDAR point clouds. This makes LOKI a highly versatile dataset that fills a crucial gap in multi-agent trajectory and intention prediction, offering a rich and diverse data resource that is vital for the development of intelligent and safety-critical systems in the community.

#### • DeepAccident [55]

The DeepAccident dataset, generated through a realistic simulator, offers a large-scale resource containing diverse accident scenarios commonly encountered in real-world driving. This synthetic dataset, which is the first of its kind to provide direct and explainable safety evaluation metrics for autonomous vehicles, includes 57,000 annotated frames and 285,000 annotated samples. This is approximately seven times the volume of the nuScenes dataset, which contains 40,000 annotated samples. DeepAccident supports end-to-end motion and accident prediction, crucial for collision avoidance and enhancing vehicular safety. Additionally, its multimodal nature makes it adaptable for various Vehicle-to-Everything (V2X) perception tasks, including 3D object detection, tracking, and Bird's Eye View (BEV) semantic segmentation. The dataset's incorporation of various environmental conditions also improves its generalizability. However, the performance of models trained on DeepAccident in actual driving scenarios requires further investigation due to potential domain adaptation issues.

The advent of autonomous vehicles presents new opportunities for traffic control and optimization. The data sets mentioned above could be leveraged to enhance the learning, planning, and robustness capabilities of robotic vehicles [216]–[221]. In addition, in the foreseeable future, mixed traffic where human-driven vehicles (HVs) and robot vehicles (RVs) coexist would be the dominant transportation mode. Recent studies have shown that RVs have the potential to significantly improve the efficiency of the traffic system [222]–[229]. The data sets discussed could be further explored to advance state-of-the-art mixed traffic research.

# IV. Annotations of Autonomous Vehicles Traffic dataset

The effectiveness and dependability of autonomous driving algorithms depend significantly on not just the quantity of data, but also the quality of annotations. In this section, the method used for data annotation is initially discussed. Furthermore, key factors critical to ensuring the quality of annotations are analyzed. Various autonomous driving tasks necessitate distinct types of annotations. For instance, object detection tasks utilize bounding box labels for each instance, while segmentation relies on annotations at the pixel or point level. Meanwhile, trajectory prediction demands continuously labeled trajectories. Additionally, the annotation

process can be divided into three categories: manual, semiautomatic, and fully automatic annotation. This section will provide an in-depth exploration of the different labeling strategies for these types of annotations.

#### A. Annotate Bounding Boxes

The accuracy of bounding box annotations critically influences the performance and reliability of perception systems, such as object detection in autonomous vehicles operating in real-world conditions. The annotation task typically involves marking images with rectangular boxes or delineating point clouds with cuboids to precisely identify objects of interest.

Labelme [230] is an earlier tool designed for image labeling specific to object detection. Yet, creating bounding boxes through professional annotators presents similar challenges to manual segmentation annotation. To address these issues, Wang et al. [231] introduced a semi-automatic video labeling tool building on the VATIC [232] video annotation system. Additionally, Manikandan et al. [233] developed another automatic video annotation tool tailored for autonomous driving scenes. Notably, annotating bounding boxes at night poses greater difficulties than during the day, a challenge Schorkhuber et al. [234] tackled using a semi-automatic method that incorporates trajectory data.

Moving beyond 2D annotations, 3D bounding boxes provide more detailed spatial information, including the object's precise location, width, length, height, and orientation. Labeling with such detailed 3D annotations demands a more complex framework. Meng et al. [235] employed a two-stage weakly supervised learning approach, incorporating humanin-the-loop to label LiDAR point clouds. ViT-WSS3D [236] created pseudo-bounding boxes by modeling the global interactions between LiDAR points and their corresponding weak labels. Apolloscape [237] utilized a labeling pipeline that includes separate branches for 3D and 2D annotations, addressing both static and moving objects. Furthermore, 3D BAT [238] developed a toolbox to support the generation of 2D and 3D labels in a semi-automatic fashion.

## B. Annotate Segmentation Data

The goal of annotating segmentation data is to assign a label to each pixel in an image or each point in a LiDAR frame, identifying the object or region to which it belongs. In this process, all pixels or points associated with a particular object are labeled with the same class. Typically, in manual annotation, the annotator outlines the object and then fills or paints over the enclosed area. However, this method of creating pixel or point-level annotations is both costly and time-consuming.

To enhance the efficiency of the annotation process, numerous studies have developed methods that are fully or semi-automatic. Barnes et al. [239] introduced a fully automatic approach using weakly supervised learning to segment drivable paths in images. Another semi-automatic method [240] uses objectness priors to create segmentation masks, and further developments have extended this

approach to include 20 different classes in [241]. Polygon-RNN++ [242] has developed an interactive segmentation tool that builds upon earlier concepts of [243]. Rather than relying solely on image data, one study [244] explores the use of 3D information to assist in generating 2D image domain semantic segmentation annotations. For 3D data, a proposed image-assisted annotation pipeline facilitates the labeling process [245]. Luo et al. [246] have adopted active learning techniques to select minimal points for creating a small training set, thereby reducing the need to label entire point cloud scenes comprehensively. Meanwhile, Liu et al. [247] have crafted an efficient framework using semi and weakly supervised learning methods to label outdoor point clouds, streamlining the annotation process significantly.

#### C. Annotate Trajectories

A trajectory is a sequence of points that outlines the movement of an object over time, encapsulating both spatial and temporal dimensions. In autonomous driving, labeling trajectory data involves marking the movement patterns of various entities within the driving environment, such as vehicles, pedestrians, and cyclists. This annotation process generally depends on results from object detection and tracking.

Historically, one of the earlier methods in trajectory annotation [248] involved online generation of actions for maneuvers, which were then incorporated into the trajectory data. Another approach [249] included a crowd-sourcing phase that was refined through a detailed expert aggregation process. Jarl et al. [250] developed an active learning framework specifically for annotating driving trajectories, emphasizing the importance of accurately predicting pedestrian movements to enhance driving safety. Furthermore, Styles et al. [251] introduced a scalable machine-driven annotation scheme that allows for the annotation of pedestrian trajectories without requiring human intervention.

#### D. Annotate on Synthetic Data

Due to the costly and time-consuming nature of manual annotations on real-world data, synthetic data created through computer graphics and simulators offer a viable alternative. Synthetic data benefits from a controlled generation process, where the attributes of each object in the scene, such as position, size, and movement, are precisely known, allowing for automatic and accurate annotations.

Synthetic scenarios are crafted to replicate real-world conditions, including diverse objects, various landscapes, weather, and lighting variations. Choosing an appropriate simulation tool is essential to achieving realistic simulation outcomes. Earlier efforts like Torcs [252] and DeepDriving [253] focused on simulating autonomous vehicles but did not incorporate multi-modality information or other dynamic objects like pedestrians. In contrast, open-source simulators like CARLA [254], SUMO [255], and AirSim [256] have gained popularity for their transparency and flexibility, allowing users to modify the source code to meet specific research needs. Commercial tools such as NVIDIA's Drive

Constellation [257], although powerful, may restrict user customization due to their closed-source nature.

Additionally, game engines like Grand Theft Auto 5 (GTA5) and Unity [258] have also been employed to create synthetic autonomous driving data. Researchers have used the GTA5 engine to construct datasets [13], [259], and Krahenbuhl et al. [260] introduced a real-time system utilizing multiple games for generating annotations for various AD tasks. Projects like SHIFT [261], CAOS [262], FedBEVT [263], and V2XSet [264] have been developed using the CARLA simulator, while V2X-Sim [265] explores the use of multiple simulators such as [254], [255] to create datasets for V2X perception tasks. Further, CODD [185] leverages CARLA to generate 3D LiDAR point clouds for cooperative driving scenarios. Other research such as [266], [267], [268], [104] utilizing the Unity platform has effectively produced synthetic datasets, showcasing the platform's utility in this field.

#### V. TRAFFIC SIMULATOR FOR AUTONOMOUS VEHICLES

The development of AV reinforcement learning research has relied heavily on extensive real-world datasets to address practical scenarios. However, it is neither feasible nor efficient to capture data for every possible real-world situation. To bridge this gap, researchers have increasingly turned to simulators as essential tools for expanding beyond the limitations of real-world data. These simulators enable the creation of synthetic scenarios that complement real-world data, facilitating deeper exploration and testing in both multiagent and single-agent environments.

The simulators presented here can be grouped into three main categories: perception and sensor-focused simulators, which replicate AV sensory systems; scenario and multiagent simulators, which emphasize interactions between multiple agents and dynamic environments; and traffic and mobility simulators, which address large-scale transportation systems and intelligent traffic management strategies.

Additionally, many simulators prioritize MARL to capture complex, interactive environments. While some also include elements of SARL, most do not address it at all. This has been an interesting trend, and thus it is worth noting that more work could be done to creating simulators that focus solely on SARL.

#### A. Perception and Sensor-Focused Simulators

These simulators emphasize sensory input, perception systems, and multimodal data collection for AV policy learning and control.

• MetaDrive [269] is a versatile simulation platform designed to facilitate research in generalizable RL for AD. It generates diverse driving scenarios using both procedural generation and real data import for training and testing. MetaDrive can train and test agents using physics-based simulations with multiple sensory inputs, such as Lidar, RGB images, top-down semantic maps, and first-person view images. Additionally, it supports a wide range of SARL and MARL tasks, safe exploration,

- and complex multi-agent traffic simulations. The simulator utilizes an Agent Manager to control vehicles in SARL and MARL tasks, where it conveys information from the environment to be used in training outside of the scenario. It also supports multi-agent environments, including roundabouts, procedurally-generated maps, bottlenecks, and intersections. Scenarios can be generated via PG generation or utilize the available realworld datasets: Argoverse, Waymo, OpenStreetMap, nuScenes and nuPlan, Lyft Level 5, and CARLA Town.
- **CARLA** [270] is an open-source simulator that supports both SARL and MARL. It includes urban layouts, physic dynamics, and support for multiple AD approaches, such as modular pipelines, imitation learning, and reinforcement learning. These features can be extracted via CARLA's API, which allows users to control all aspects of the simulation. This includes traffic generation, pedestrian behaviors, weather conditions, sensor configurations, and more. CARLA provides users with the ability to generate and execute scenarios based on the ScenarioRunner engine, which leverages the OpenDRIVE standard to define roads and urban settings. Additionally, CARLA integrates the Responsibility Sensitive Safety (RSS) system, which is a key feature for enhancing the safety of autonomous driving simulations. The RSS library utilizes sensor data to generate appropriate restrictions on vehicle controls. This integration allows users to investigate safety behaviors without needing to implement them from scratch, as CARLA manages the input and output application dynamically.
- VISTA 2.0 [271] is a simulator that provides such utility. Its policies trained on the data generated by VISTA 2.0 can be directly deployed in real-world autonomous vehicles, showcasing that the simulator's synthetic data is sufficiently realistic for practical use. It synthesizes data using high-fidelity real-world datasets to represent and simulate RGB cameras, 3D LiDAR, and event-based cameras.

#### B. Scenario-based Simulators

These simulators model interactions between multiple agents (cars, pedestrians, and other vehicles) in complex traffic scenarios to evaluate strategies and decision-making in dynamic environments.

- Autoware [272], [273] is an open-source software that utilizes a modular architecture for its software stack consisting of sensing, planning, localization, and control. It is currently employed in a suite of AVs and applications. AWSIM is a 3D simulator built for Autoware that allows users to test AD implementations. It uses LiDAR and other types of sensor data to simulate AV environmental interactions. The simulator includes dynamic traffic scenarios utilizing pedestrian, vehicles, and more to test AV decision making scenarios.
- Simcenter Prescan [274] offers the utility to simulate realistic road conditions for MARL and SARL.

These simulations include various AVs and actors across different roads and environments to validate system performance and safety. Prescan provides the opportunity to recreate accident scenarios to understand the causes and improve AV systems utilizing user-provided accident databases. For MARL, Simcenter Prescan can simulate environments with multiple interacting agents, such as other vehicles, pedestrians, and infrastructure elements. It enables the study of coordination strategies among multiple AVs, such as platooning, intersection management, and cooperative lane changing. Additionally, Prescan provides the user the opportunity to integrate directly with Simcenter Amesim<sup>TM</sup> and MATLAB/Simulink to understand system response before hardware is available.

- Waymax [275] is an open-source SARL/MARL set of libraries that allow the user to load data, compute and simulate for AD research. It utilizes the Waymo Open Dataset [9] to simulate diverse driving scenarios. Waymax supports modeling complex interactions between vehicles, pedestrians, and traffic lights and allows users to define and control various dynamic agents within the simulation. Additionally, the simulator offers hardware acceleration and distributed training to improve machine learning model development. Waymax's MARL capabilities include an interface that allows the user to choose what aspects of the scenario need controlling. As for its SARL capabilities, it introduces a "PlanningAgentEnvironment" to control the ego machine within the scenario. The all-encompassing capabilities that Waymax provides is powerful and encourages users to take control of all simulated scenarios.
- SMARTS [276] is an industrial-strength platform that takes an innovative approach to MARL research. SMARTS separates its resources to manage different "bubbles," dedicating specific resources to social agents and the background traffic provider, ensuring a scalable and focused simulation environment. These bubbles allow for dynamic association of social vehicles with social agents, which vary in vehicle model, observation, action spaces, and computing needs, enhancing the realism and diversity of the interactions.

The core architecture of SMARTS includes various providers such as the background traffic provider, which uses SUMO to simulate realistic traffic flows, the vehicle physics provider utilizing the Bullet physics engine, and the motion plan provider for implementing complex maneuvers. By leveraging its Social Agent Zoo, which collects behavior models from simulated and real-world data, SMARTS continually grows its repository of social agents, enabling more realistic and complex multi-agent interactions.

## C. Traffic and Mobility Simulators

These simulators focus on large-scale traffic management, urban mobility, and transportation systems, offering the ability to optimize strategies and control algorithms for

intelligent transport systems.

- SUMMIT [277] The SUMMIT simulator, with its implementation based on CARLA, generates high-fidelity, interactive data for unregulated, dense urban traffic on complex real-world maps. By using real-world maps. The simulator automatically creates crowds of heterogeneous traffic agents with sophisticated, unregulated behaviors, SUMMIT uses the context-aware crowd behavior model Context-GAMMA to create advanced interactions between traffic agents. Additionally, SUMMIT defines road structures and agent behaviors using lane and sidewalk networks from SUMO-converted OpenStreetMaps, provides an occupancy map interface for drive-able regions, and utilizes landmark data for realistic visuals.
- PTV Vissim Automotive [278] is a licensed microscopic traffic simulator that allows users to simulate traffic patterns for all types of vehicles. In addition to its baseline functionality, the PTV Vissim Automotive allows for further simulation with autonomous vehicles. The simulator offers a dynamic closed-loop test environment that allows for behavior-based surrounding traffic. This provides users with the opportunity to test an AVs ability in aggressive driver scenarios. It also allows users to simulate varying traffic scenarios such as city rush hours and other highway interactions.
- SimMobility [279] The SimMobility simulator is an activity-based model that contains a short-term (ST), mid-term (MT), and long-term (LT) simulator within it that provides the user variability for agent choice. These simulator varieties also enable the opportunity to perform microscopic simulations. ST enables the user to track route choice with and vehicle actions on subsecond time-steps. As for MT, the time-steps will now be within the seconds to minutes range, and will allow the user to not only track from route choice, mode choice, and activity patterns. The LT option provides users with unique choice options not seen in other simulators, such as house location and job location, with time-steps ranging from days to years. A key feature of all the simulator components is the eventbased demand and time-step supply mechanism, which allows for interactions between supply and demand across different simulation levels, ensuring that agents' decisions and environmental responses are accurately synchronized in real-time.

## D. Comparison among different simulators

When comparing various traffic simulators for autonomous vehicles, each offers unique strengths tailored to different aspects of AV research. VISTA 2.0 excels in synthesizing high-fidelity sensor data and supports real-world deployability of trained policies, making it ideal for many tasks. Autoware also allows the deployability of its models into real AVs as VISTA 2.0, but it allows users to simulate in many effective, user-generated 3D scenarios.

MetaDrive is versatile as well for both SARL and MARL, providing diverse scenario generation through procedural methods and real data imports, although it is limited to presupported datasets. CARLA has comprehensive simulation capabilities, including accurate physics, urban layouts, and extensive API control, making it suitable for both SARL and MARL. Additionally, Waymax also provides the ability to simulate in SARL and MARL scenarios while offering hardware acceleration capabilities that enable large-scale machine learning processes.

Simcenter Prescan excels in simulating realistic road conditions and multi-agent environments, integrating well with tools like Simcenter Amesim<sup>TM</sup> for performance validation. SUMMIT, based on CARLA, provides high-fidelity simulations of dense urban traffic with advanced interaction modeling using Context-GAMMA, making it ideal for complex urban scenarios. Additionally, PTV Vissim Automotive allows for further analysis of complex urban scenarios, but it focused more on traffic simulation rather than vehicle-to-vehicle interactions. As for SMARTS, it offers an innovative approach to MARL research with its scalable and realistic multi-agent interactions, though it requires detailed configuration to fully utilize its capabilities.

The traffic simulations found so far are listed in Table VI. These traffic simulators can be explored together with existing large-scale traffic simulation, reconstruction, and prediction methods [280], [281], [281]–[288], to support various applications of intelligent transportation systems.

#### VI. DISCUSSION AND FUTURE RECOMMENDATION

Amidst swift technological advancements, robust computational resources, and sophisticated artificial intelligence algorithms, numerous innovative trends have emerged in next-generation autonomous driving datasets, introducing fresh challenges and demands.

- In contrast to the modular design of autonomous driving pipelines, the end-to-end architecture streamlines the design process and lessens integration difficulties. The effectiveness of UniAD [335] confirms the capability of end-to-end models. Nevertheless, there is a scarcity of datasets specifically for end-to-end autonomous driving [336]. Thus, the creation of datasets dedicated to end-to-end driving is essential for the progress of autonomous vehicles. Additionally, incorporating an automatic labeling pipeline within a data engine can greatly enhance the development of end-to-end driving frameworks and datasets [337].
- Upcoming autonomous driving datasets need to encompass comprehensive data on real-world environments and traffic conditions to support various applications beyond just the primary vehicle and simple vehicle-infrastructure interactions. For example, data on the interactions between autonomous vehicles and smart infrastructure elements could propel the development of Internet-of-Things (IoT)-enabled devices, such as intelligent traffic signals. Furthermore, granular analyses of traffic patterns, congestion, and vehicle dynamics

- under various conditions and times could aid in urban planning, improve traffic flow, and bolster traffic management tactics overall.
- Recently, vision language models (VLMs) have seen significant progress across various domains. Their unique benefit of integrating language data into vision-related tasks enhances the explainability and reliability of autonomous driving systems. A recent survey [338] underscores the critical importance of Multimodal Large Language Models in diverse autonomous driving tasks, including perception [339], [340], motion planning [341], and motion control [342].
- The remarkable abilities of vision language models (VLMs) have been leveraged to produce data [343]-[346]. For instance, DriveGAN [347] has successfully generated high-quality autonomous driving data by autonomously disentangling various components. Furthermore, given their proficiency in understanding driving environments, several studies [348]-[350] have utilized world models to create high-quality driving videos. DriveDreamer [349], a pioneering project originating from real-world scenarios, overcomes the constraints found in gaming or simulated environments. Recent breakthroughs in text-to-video generation, notably Sora [351], have paved a new path for creating autonomous driving data. Sora is capable of generating high-quality synthetic data that closely mimics reallife scenes with just a brief description. This capability greatly boosts dataset augmentation, particularly for rare occurrences such as traffic accidents. The expanded data availability from VLMs is set to improve the training and assessment of autonomous driving systems, enhancing their safety and dependability.
- Domain adaptation presents a significant hurdle in the development of autonomous vehicles [352], highlighting the need for a model trained on one dataset (the source domain) to reliably function on another (the target domain). This challenge arises in various areas, such as variations in driving conditions [352], sensor configurations [353], or synthetic-to-real conversions [354]. As a response, a trend in creating next-generation datasets involves integrating data from diverse sources. Firstly, datasets should encompass a broad spectrum of environmental scenarios, including different weather conditions and varying day-night lighting, as well as multiple geographical locations. Secondly, it is crucial to merge data from different types of sensors to address the domain adaptation challenge effectively. Another approach involves strategically mixing high-quality synthetic data with real-world data to enhance model generalization.
- In the realm of machine learning, uncertainty is typically characterized in probabilistic terms. For autonomous driving, a primary source of uncertainty is the incompleteness of training data [355]. When training data fails to fully capture the complexities of the driving environment, autonomous vehicles may struggle with rare scenarios during operation. Consequently,

enhancing the diversity of datasets used for training autonomous driving systems is essential. Additionally, including rare events and edge cases in these datasets enables models to more effectively recognize and manage the uncertainty in unforeseen situations, thus ensuring safer operation.

The future of traffic simulators and their endless possible integration's with AV datasets has created a wealth of opportunities for testing and developing AV implementations.

- Traffic simulators play an important role in reducing the risk associated with incompleteness of AV datasets. Datasets like Waymo [9] and nuScenes [11] provide extensive real-world data on driving conditions, weather variations, and traffic patterns for AV models. However, these datasets are insufficient to cover the vast range of scenarios AVs may encounter in real-world scenarios. Simulators bridge this gap by generating synthetic data, allowing researchers to recreate diverse driving environments and edge cases that are difficult or costly to capture in real life. They help enhance AV models by providing a controlled, safe space for testing without the risks associated with physical tests. Simulators like MetaDrive [269] can simulate scenarios based on realworld datasets while also generating new conditions, ensuring that AV models generalize well across different situations. While datasets offer a real-world basis, simulators can extend the training environment by creating synthetic scenarios for more robust AV performance and cover distinct edge cases.
- Traffic simulators are critical to AV research as they provide environments to test and refine models that are difficult to create from real-world data. The future of traffic simulators lies in bridging the gap between the virtual and real worlds, which currently poses a significant challenge. Simulations often fall short in terms of scenario diversity and environmental complexity, leading to differences in how well models trained in virtual environments perform in real-world settings. Efforts to quantify this gap and mitigate it are needed to scale up testing processes and ensure that models developed in simulation environments can be successfully transferred to real-world applications. To address these challenges, developing methods that enhance data diversity will be essential. This includes creating models that can effectively translate between simulated and real data, ensuring that AVs perform optimally in diverse, realworld scenarios.
- The future of traffic simulators lies in synthetic data.

With an increasing need to diversify data, synthetic data is a viable solution. Not only does it provide scalable solution for addressing data scarcity in realworld testing, it also enhances the breadth of training data available, especially for edge cases. By providing synthesized data, it allows researchers to explore numerous datasets that simulate real-world conditions and expand upon it. As simulators continue to be improved, the ability to generate accurate, high-quality synthetic data that mimics real-world scenarios will help close the simulation-to-reality gap. However, ensuring that synthetic data sufficiently captures the diversity and complexity of real-world environments remains a challenge. Researchers must develop methods to quantify and mitigate the differences between synthetic and real data, ensuring that models trained in simulators can generalize well in actual AV deployments. The use of synthetic data also opens up new opportunities for improving data fairness, allowing for the creation of more representative and unbiased datasets that can be used to train AV systems in a wider variety of traffic environments and demographic settings.

#### VII. CONCLUSION

This paper presented a survey of datasets and simulators related to AV traffic. For high-quality paper collection, we searched in IEEE digital library, ACM digital library, SpringerLink, Elsevier, Multidisciplinary Digital Publishing Institute (MDPI), Google Scholar, Willey, etc. and we filtered only good quality relevant AV traffic dataset and simulator papers for review. We proposed a taxonomy of applications of traffic datasets for the perception, localization, prediction, planning and control of AV. Along with this, we presented the year-wise distribution and frequency of traffic dataset papers, and the domain used to acquire and process AV traffic dataset. Then, we discussed highly significant datasets and simulators that have been used in several AV technologies.

We have investigated the existing AV datasets' gaps and tried to bridge the gaps by recommending suggestions for data-driven approaches. Framework for collection of end-to-end datasets can significantly improve AV research incorporating ML/DL methods and Internet-of-Thing (IoT)-enabled devices. Besides, proper involvement of the language model can significantly turn AV research into a potential new direction.
