TIME-CHANGED MARKOV PROCESSES AND COUPLED NON-LOCAL EQUATIONS

ABSTRACT. Motivated by a financial valuation problem on an asset-pricing model with dependent trade duration and returns, in this paper we study coupled fully non-local equations, where a linear non-local operator jointly acts on the time and space variables. We prove existence and uniqueness of the solution. Existence is established by providing a stochastic representation based on anomalous processes constructed as a time change via the undershooting of an independent subordinator. This leads to general non-stepped processes with intervals of constancy representing a sticky or trapping effect (i.e., constant price in financial applications). Our theory allows these intervals to be dependent on the immediately subsequent jump. A maximum principle is then proved and used to derive uniqueness. Based on these general results, we consider a particular case: a non-local analog of the Black and Scholes equation, addressing the problem of determining the seasoned price of a derivative security.

1. INTRODUCTION

A popular paradigm connecting fluid-dynamics and financial economics is the observation that financialasset-price moves resemble those of the particles in a fluid. This observation has been key to the discipline of financial mathematics since its infancy over a century ago ([8]), and has been instrumental to the introduction of the geometric Brownian motion first [56], and of more general continuous or discontinuous Markov processes later ([26; 43; 20]). In terms of valuation of derivative securities, already with the emergence of the martingale pricing theory ([37; 25]) the central role of backward Kolmogorov terminal value problems was clear. Stochastic solutions of these problems precisely determine option values after the contract's inception. Such solutions can be written as conditional expectations corresponding to some Markov generator characterizing the underlying dynamics.

A distinct line of research, focused on market statistical analyses rather than valuation, instead considered tick-by-tick continuous time random walks (CTRWs) and the corresponding fluid-dynamic limits in order to gain insight on economic measures such as the return distributions, see e.g. [60; 59; 45] and recently [64]. Such limits typically produce stable-like processes (and thus discontinuous continuous-time trajectories) and variations thereof. A particularly consequential aspect of CTRWs modelling of financial markets prices is that it paved the way for the introduction of non-local operators in both space and time as determining the governing equations of their scaling limits. As it turns out, the presence of a fractional derivative in the time variable is of particular importance, which is reflected in a stochastic time change in the stochastic solution of the equation associated with the Markov generator in the space variable. The process thus obtained is non-Markovian and exhibits periods of constant prices, whose duration is independent of the price moves. However, Markovianity can be often recovered by augmenting the state space with the time variable keeping count of the time elapsed since the particle last move (the "sojourn time" or "age"), which is one of the possible definitions of semi-Markovianity, and the one which is most relevant here. In general, being able to establish some form of higher-dimensional Markovianity is especially useful in the mathematical modeling of random phenomena; concretely, in a financial valuation context, it can be interpreted as the possibility to establish the theoretical fair value of a contract based only on a finite set of market-observable data.

Two recent papers have tried to bring together some of these aspects. In [61] the authors chose a semi-Markov multiplicative CTRW model based on a sequence of independent and identically distributed lognormal random variables and an independent renewal counting process. The limit process turns out to be semi-Markov with continuous trajectories. Although the governing equation of the limit process is studied, the independence between the spatial lognormal innovations and the renewal process, implies that the magnitude of the price moves remain independent from the trade duration, that is, the sojourn time of the price process. A similar, but more general, model with independence is presented in [39], generalizing the earlier suggestion [44] and [21]. Crucially, in such work a time-changed model with dependence between temporal and spatial variables is also introduced. The authors use spectral methods to derive the option price for such models, and comment on a weak form of semi-Markov property (Markov embedding) of the process as a whole, but do not study the corresponding governing Black and Scholes type equation. Beside the purely theoretical interest, this paper essentially finds motivation as it unifies the contribution of [61] and [39], by answering the problem of pricing for, and determining the seasoned value of, an intraday call option written on an asset with dependent duration and returns as in [39], using the techniques inspired from the semi-Markov analysis of the limiting process in [61].

As epitomized by the mentioned applications in financial mathematics, the interplay between time-changed Markov processes (ofter arising as scaling limit of CTRWs) and non-local operators is a very active area in probability theory that gained considerable popularity in the last decades. This is certainly connected to its applicability in several contexts, even beyond financial mathematics, especially: Hamiltonian chaos [67; 68; 69], Hamiltonian systems describing cellular flows [34; 35], trapping models [2; 58], anomalous heat conduction [28; 52] neuronal modeling [4], and many others, see e.g. [10; 11; 29; 30; 31; 33; 47; 48; 49], and references therein for several possible applications and modeling aspects of the theory.

The foundation of such theory lies in the connection between Markov processes and the parabolic Kolmogorov equations that are related to their semigroups. More specifically, Markov processes with jumps are generated by linear operators that are non-local. Bochner subordination is a crucial tool in this context. Given some Markov process and a subordinator, i.e., a non-decreasing Lévy process, the bedrock of the classic subordination theory is a result due to Phillips, see [63, Theorem 13.6] and [62]), which completely characterizes the generator of the time-changed (subordinate) process in terms of that of the generator of the original Markov process and the Lévy triplet of the subordination: if G generates the semigroup of the Markov processes M then the subordinate semigroup is generated by $-\phi(-G)$, where ϕ is the Laplace exponent of the subordinator involved.

When non-local time operators appear in Kolmogorov's evolution equations, the interplay with random processes is more subtle, and as it appears, not yet fully understood. Recent results inspired by time-change techniques suggest the following picture. Consider a Markov process M(t) generated by G, an independent subordinator S with Laplace exponent ϕ , define $L(t) = \inf \{s \ge 0 : S(s) > t\}$ the first exit time of S from a level t, and choose an initial condition u. Then the x, t conditional expectation q(x, t) of u(M(L(t)) satisfies, in a suitable sense, the following non-local equation

$$(\phi(\partial_t) - G) q(x, t) = \bar{\nu}(t)q(x, 0), \qquad q(x, 0) = u(x), \qquad u(x) \in \text{Dom}(G),$$
 (1.1)

where the non-local operator $\phi(\partial_t)$ can be defined in different ways, a typical one being as in [22]

$$\phi(\partial_t)q(x,t) \coloneqq b\partial_t q(x,t) + \partial_t \int_0^t q(x,s)\,\bar{\nu}(t-s)\,ds \tag{1.2}$$

where $\bar{\nu}(t) \coloneqq a + \nu(t, +\infty)$ and $b \ge 0$ and $\nu(\cdot)$ are, respectively, the drift and the Lévy measure of the process S, associated with ϕ . Several other representations of $\phi(\partial_t)$ can be given, see, e.g., [19; 38; 41; 42]. Hence, the time-change with independent inverse subordinators has been understood and, also, regularity of the involved probabilities is quite clear (see [5]). It turns out, however, that more general families of time changes can be considered and associated with non-local operators. For example one can assume that (M, S) is a Markov additive process (see [58]), or that S is an independent self-similar Markov process [51], and even different ones (see, for example [9; 38; 54]).

In this paper, we consider coupled fully non-local operators. More precisely, given a Bernstein function ϕ , we consider the equation

$$\phi\left(\partial_t - G\right)q(x,t) = \bar{\nu}(t)q(x,0), \qquad q(x,0) = u(x), \qquad u(x) \in \text{Dom}(G); \tag{1.3}$$

we provide a rigorous definition for the operator $\phi(\partial_t - G)$ appearing on the left-hand side and then we study the well-posedness of the problem. The expressions *fully non-local* or *fully fractional* are often used for non-local (or just fractional) equations in both time and space variables, but usually with uncoupled operators, acting separately on time and space variables. It turns out that the stochastic solution q(x, t) for (1.3) is given by the x, t conditional expectation of u(M(S(L(t)-))) i.e., the process governed by (1.3) is the time-change of the Markov process M, generated by G, by means of the process H(t) = S(L(t)-), a.k.a. the *undershooting* of the subordinator (see [13, chapter 1.4]). It turns out that this process M(S(L(t)-))has also a kind of (weak) semi-Markov property, i.e., it can be embedded in a higher dimensional Markov process.

From the purely analytical point of view, equations like (1.3) have been considered in some specific cases, for instance when $\phi(\lambda) = \lambda^{\alpha}$, $G = \Delta$ (see [7; 32]). In contrast we develop our theory in a quite general context, more general than what is required to deal with time-changed Markov processes via semigroup theory. In order to pursue our motivating financial problem, we need to include the following equation within our theory

$$\left(\partial_t - \frac{x^2}{2}\partial_x^2\right)^{\alpha} q(x,t) = \frac{t^{-\alpha}}{\Gamma(1-\alpha)}u(x), \qquad u(x) = (x-K)_+.$$
(1.4)

Such equation is the call-option valuation formula, under zero-interest rates (an innocuous simplifying assumption when observing intraday prices, which is reflected in the absence of a forcing term in (1.4)), of an underlying whose logarithm under a pricing measure is described by the process M(S(L(t)-)). Upon time-reversal, (1.4) looks like a particular case of (1.3), but it really is not, because the final condition, i.e. the pay-off of a European call option, is not in the domain of the operator $G = \frac{1}{2}x^2\partial_x^2$. For this reason, we approach the problem of well-posedness using uniqueness classes for PDEs and semigroup actions on it. The theory of Markov (and Feller) semigroups of operators and Markov processes is a particular case of this more general theory.

The process with dependent returns and trade duration considered in [39] can be now inserted in our abstract theory, at least when M is a Brownian motion, and for some parameters of the (stable) subordinator. For financial applications, the valuation equation (1.4) is a first step, ideally to be extended in further work to one corresponding to more realistic models, entailing distributionally-asymmetric Feller processes for returns, as well as undershooting processes of subordinators other than the stable one (e.g. with finite moments).

Structure of the article and summary of the results. Following is a summary of the main results and topics that are dealt with in each section.

- In Section 2 we introduce basic notions on uniqueness classes, semigroup actions and Bernstein functions. All that will be relevant in the subsequent sections;
- In Section 3 we define the coupled non-local operator $\phi(\partial_t G)$, we study its domain and regularity properties. Moreover, we provide a notion for the solution of the related Cauchy problem.
- In Section 4 we review the theory of time change according to subordinators and their inverses, introduce the time-changed Feller process related to the Cauchy problem of Section 3, and establish the Markov-additivity of the pair process-subordinator;
- In Section 5 the first main Theorem 5.2, is presented and proved. This states that the conditional expectation of the process defined in Section 4 is the stochastic solution, in the sense of Definition 3.6, of the Cauchy problem, subject to a further local uniform boundary condition. To prove the theorem, firstly we focus on regularity properties for the conditional expectation, described in Subsection 5.1. Furthermore, in Subsection 5.2 we give the details of the proof.
- In Section 6 we move to the applications in finance of the theory discussed in the previous sections. We define a process for pricing an intraday call option written on an asset with dependent duration and returns, whose log-price follows a time-changed Feller process as the one of Section 4. This leads to the second main result, Theorem 6.10, which is the applied counterpart of Theorem 5.2. A second result, proved separately is necessary because the call option initial (terminal) datum does not satisfy the regularity required in Theorem 5.2. The proof of this theorem is split into several

auxiliary results, firstly proving regularity of the solution, then establishing existence, uniqueness and, finally, the renewal equation in separate subsections.

• In the appendices some auxiliary results are proved.

2. Preliminaries

We let E be a locally compact separable Hausdorff space and we set $\mathcal{E} = \mathcal{B}(E)$, the Borel σ -algebra on E. We equip any interval $[0,T] \subseteq \mathbb{R}_0^+ =: [0, +\infty)$ and the half-axis \mathbb{R}_0^+ with the Borel σ -algebra. We also denote $\mathbb{R}^+ := (0, +\infty)$. With an abuse of language, we say that a function $f : E \to \mathbb{R}$ belongs to \mathcal{E} if it is Borel-measurable, so that \mathcal{E} will denote the linear space of Borel-measurable real valued functions on E. Furthermore, we denote by C(E) the space of continuous functions $f : E \to \mathbb{R}$ and by $C_{\mathrm{b}}(E)$ the space of bounded continuous functions $f : E \to \mathbb{R}$. The space $C_{\mathrm{b}}(E)$ is a Banach space once it is equipped with the uniform norm

$$||f||_{C(E)} := \sup_{x \in E} |f(x)|.$$

Furthermore, we denote by $C_0(E)$ the space of continuous functions $f: E \to \mathbb{R}$ vanishing at infinity, i.e. such that for all $\varepsilon > 0$ there exists a compact $K \subset E$ such that

$$\sup_{x \notin K} |f(x)| < \varepsilon_1$$

which is still a Banach space when equipped with the uniform norm.

2.1. Uniqueness classes and semigroup actions. Consider a linear operator $G : C \subseteq \mathcal{E} \to \mathcal{E}$, where \mathcal{C} is a suitable subspace of \mathcal{E} . For such an operator, we consider the following differential equation

$$\begin{cases} \partial_t q(t,x) = Gq(t,x), & t > 0, x \in E, \\ q(0,x) = u(x), & x \in E, \end{cases}$$
(2.1)

where $u \in \mathcal{E}$ is suitable initial data. To introduce a notion of solution, we take inspiration from the theory of ordinary differential equations (see [24, Chapter 2]).

Definition 2.1. We say that a function $q : [0,T] \times E \to \mathbb{R}$ is a local Carathéodory solution of (2.1) if and only if

- (i) $q \in \mathcal{B}([0,T] \times E), q(\cdot, x) \in C[0,T]$ for any $x \in E$ and $q(t, \cdot) \in \mathcal{C}$ for any $t \in (0,T]$;
- (ii) q(0,x) = u(x) for any $x \in E$;
- (iii) $Gq(\cdot, x) \in L^1(0, T)$ for any $x \in E$;
- (iv) For any $x \in E$ and $t \ge 0$

$$q(t,x) = u(x) + \int_0^t Gq(s,x)ds.$$
 (2.2)

We say that $q : \mathbb{R}_0^+ \times E \to \mathbb{R}$ is a global Carathéodory solution of (2.1) if its restriction to [0,T] is a local Carathéodory solution for any T > 0.

Remark 2.2. This definition is related to the so-called mild solution of an abstract Cauchy problem (see [1, Definition 3.1.1]). For instance, suppose that G is a closed linear operator on $C \subset C_0(E)$. Assume that q is a global Carathéodory solution of (2.1) such that $Gq(t, \cdot) \in C_0(E)$ and $t \in [0,T] \mapsto ||Gq(t, \cdot)||_{C_0(E)} \in \mathbb{R}$ belongs to $L^1[0,T]$ for all T > 0. Notice also that, by definition of Carathéodory solution, $q(t, \cdot) \in C$. Hence, with an abuse of notation, we can set $q(t) = q(t, \cdot)$ so that $q : \mathbb{R}^+_0 \to C_0(E)$. Then, in particular, by [1, Proposition 1.1.7], we have

$$\int_0^t Gq(s)ds \ = \ G\int_0^t q(s)ds.$$

If also $u \in C_0(E)$, we can rewrite (2.2) in terms of Bochner integrals as

$$q(t) = u + G \int_0^t q(s) ds$$

i.e., q is a mild solution of the abstract Cauchy problem in $C_0(E)$

$$\begin{cases} \partial_t q(t) = Gq(t), & t > 0, \\ q(0) = u. \end{cases}$$

Now we want to consider some classes of functions $C_0 \subseteq \mathcal{E}$ and $C_{sol} \subseteq \mathcal{B}(\mathbb{R}^+_0 \times E)$ that will play the following role: C_0 will be the set of initial data so that the problem (2.1) admits a unique solution belonging the class C_{sol} . Let us formalize this (see, for instance, [50, page 204] in the case of the heat equation).

Definition 2.3. We say that the couple (C_0, C_{sol}) , where $C_0 \subseteq \mathcal{E}$ and $C_{sol} \subseteq \mathcal{B}(\mathbb{R}^+_0 \times E)$ is a uniqueness class for G if and only if

- (i) For any $q \in \mathcal{C}_{sol}$ and any t > 0 it holds $q(t, \cdot) \in \mathcal{C}_0 \cap \mathcal{C}$;
- (ii) For any $u \in C_0$ there exists a unique global Carathéodory solution $q \in C_{sol}$ to (2.1).

Let us give some examples.

Example 2.4. Consider $E = \mathbb{R}$, $C = C^2(\mathbb{R})$ and $G = \partial_x^2$. If we set $C_0 = C_0(\mathbb{R})$ and

$$\mathcal{C}_{\rm sol} = \{ q \in C(\mathbb{R}_0^+ \times \mathbb{R}) \cap C^1(\mathbb{R}^+ \times \mathbb{R}) : \ q(t, \cdot) \in C_0^2(\mathbb{R}), \ \forall t > 0, \ and \ q(0, \cdot) \in C_0(\mathbb{R}) \},$$

then $(\mathcal{C}_0, \mathcal{C}_{sol})$ is a uniqueness class for G, as it is well-known that the heat equation

$$\begin{cases} \partial_t q(t,x) = \partial_x^2 q(t,x), & t > 0, x \in \mathbb{R}, \\ q(0,x) = u(x), & x \in \mathbb{R}, \end{cases}$$
(2.3)

admits a unique solution in $C_0^2(\mathbb{R})$ if $u \in C_0(\mathbb{R})$. It is important to notice that such a solution is not unique among all the measurable functions on \mathbb{R} , as we could find other unbounded solutions of the same equation, that are usually called non-physical solutions (see [18, Theorem 2.3.1]).

Example 2.5. Again, consider $E = \mathbb{R}$, $\mathcal{C} = C^2(\mathbb{R})$ and $G = \partial_x^2$. Now set

$$\mathcal{C}_0 = \{ u \in C(\mathbb{R}) : \exists c_1, c_2 > 0, \exists \gamma \in [0, 2), |u(x)| \le c_1 e^{c_2 |x|^{\gamma}}, \forall x \in \mathbb{R} \}$$

and

$$\begin{aligned} \mathcal{C}_{\rm sol} &= \{ q \in C(\mathbb{R}^+_0 \times \mathbb{R}) \cap C^1(\mathbb{R}^+ \times \mathbb{R}) : \ q(t, \cdot) \in C^2(\mathbb{R}), \ \forall t > 0, \\ and \ \forall T > 0, \exists c_1, c_2 > 0, \exists \gamma \in [0, 2), \ |q(t, x)| \le c_1 e^{c_2 |x|^{\gamma}}, \\ \forall x \in \mathbb{R}, \ \forall t \in [0, T] \}. \end{aligned}$$

Then $(\mathcal{C}_0, \mathcal{C}_{sol})$ is a uniqueness class for G as (2.3) admits a unique solution $q \in \mathcal{C}_{sol}$ whenever $u \in \mathcal{C}_0$ (see [18, Theorem 3.6.1]). Let us stress that we could also consider G as the generator of the Brownian motion. In such a case, however, since $\mathcal{C}_0 \not\subset \mathcal{C}_0(\mathbb{R})$, the usual theory of Feller semigroups (see [55, Definition III.6.5]) does not apply.

Example 2.6. Now let $E = [a, b] \subset \mathbb{R}$ for some a < b. As before, set $G = \partial_x^2$ with $\mathcal{C} = C^2(a, b)$. Set

$$\mathcal{C}_{0} = \{ u \in C[a, b] : \ u(a) = u(b) = 0 \}$$

$$\mathcal{C}_{\text{sol}} = \{ q \in C(\mathbb{R}_{0}^{+} \times [a, b]) \cap C^{2}(\mathbb{R}^{+} \times (a, b)) : \ q(t, a) = q(t, b) = 0, \ \forall t > 0 \}$$

Then (C_0, C_{sol}) is a uniqueness class for G. Indeed, in such a case, $q \in C_{sol}$ is a solution of (2.1) if and only if it solves

$$\begin{cases} \partial_t q(t,x) = \partial_x^2 q(t,x), & t > 0, \ x \in (a,b] \\ q(0,x) = u(x) & x \in [a,b] \\ q(t,a) = q(t,b) = 0 & t > 0, \end{cases}$$

that is a Dirichlet-Cauchy problem and then admits a unique solution.

Example 2.7. Let now $(P_t)_{t\geq 0}$ be a Feller semigroup on $C_0(E)$ with generator (G, Dom(G)). Then we can set $C_0 = C_0(E)$ and $C_{\text{sol}} = C(\mathbb{R}^+_0; C_0(E))$. By standard Feller semigroups theory (see [1, Chapter 3]), we know that (C_0, C_{sol}) is a uniqueness class for G. This implies that the abstract setting we are considering can be applied in general to Feller semigroups and their generators. We can also consider strong solutions in this framework by setting $C_0 = \text{Dom}(G)$ and $C_{\text{sol}} = C^1(\mathbb{R}^+_0; \text{Dom}(G))$.

Definition 2.8. For a linear operator $G : C \subseteq \mathcal{E} \to \mathcal{E}$ and a uniqueness class $(\mathcal{C}_0, \mathcal{C}_{sol})$ for G, we define the family of linear operators $(P_t)_{t>0}$ acting on \mathcal{C}_0 as follows:

- (i) $P_0 = I$, where I is the identity on C_0 ;
- (ii) For any t > 0, $f \in C_0$ and $x \in \mathcal{E}$, $P_t u(x) = q(t, x)$, where q is the unique Carathéodory solution of (2.1) in C_{sol} .

We call the family $(P_t)_{t\geq 0}$ the semigroup action induced by G on $(\mathcal{C}_0, \mathcal{C}_{sol})$.

As the name suggests, $(P_t)_{t\geq 0}$ is indeed an action of the additive semigroup $(\mathbb{R}^+_0, +)$ on the linear space \mathcal{C}_0 . Indeed, fix any $u \in \mathcal{C}_0$ and t, s > 0 and consider $q(t, \cdot) = P_t u$. Now let $\bar{q}(s, \cdot) = P_s q(t, \cdot)$ and observe that \bar{q} is the unique function in \mathcal{C}_{sol} such that for any $s \geq 0$ and any $x \in E$

$$\bar{q}(s,x) = q(t,x) + \int_0^s G\bar{q}(\tau,x)d\tau.$$
 (2.4)

However, by definition,

$$q(t+s,x) = u(x) + \int_0^{t+s} Gq(\tau,x)d\tau$$

$$= q(t,x) + \int_{t}^{t+s} Gq(\tau,x)d\tau = q(t,x) + \int_{0}^{s} Gq(t+\tau,x)d\tau,$$

that is to say that the function $q(t + \cdot, \cdot) \in \mathcal{C}_{sol}$ satisfies (2.4) and then

$$P_{t+s}u(x) = q(t+s,x) = \bar{q}(s,x) = P_sq(t,x) = P_sP_tu(x)$$

for any s > 0 and any $x \in E$. We use the name *semigroup action* in place of *semigroup* to avoid any possible confusion with Feller semigroups on Banach spaces, that are a particular case in this theory.

2.2. Bernstein functions. We here recall some basic definitions and properties concerning Bernstein functions that will be used throughout the paper. We mainly refer to [63] where proofs of the theorems stated below can be found.

Definition 2.9. A function $\phi : \mathbb{R}^+ \to \mathbb{R}^+_0$ is said to be a Bernstein function if, $\phi(\lambda) \ge 0$, $\phi \in C^{\infty}(\mathbb{R}^+)$ and for any $n \in \mathbb{N}$

$$(-1)^{n-1}\phi^{(n)}(\lambda) \ge 0 \quad \forall \lambda \in \mathbb{R}^+.$$

We denote by \mathfrak{B} the convex cone of Bernstein functions.

Any function $\phi \in \mathfrak{B}$ admits a special representation.

Theorem 2.10. For any $\phi \in \mathfrak{B}$ there exists a unique triplet $(a_{\phi}, b_{\phi}, \nu_{\phi})$, where $a_{\phi}, b_{\phi} \in \mathbb{R}^+$ and ν_{ϕ} is a Borel measure on $(0, +\infty)$ with the property

$$\int_{(0,\infty)} (1 \wedge t) \,\nu_{\phi}(dt) < \infty, \tag{2.5}$$

such that

$$\phi(\lambda) = a_{\phi} + b_{\phi}\lambda + \int_{(0,\infty)} (1 - e^{-\lambda t})\nu_{\phi}(dt).$$
(2.6)

Vice versa, any triplet $(a_{\phi}, b_{\phi}, \nu_{\phi})$ with $a_{\phi}, b_{\phi} > 0$ and ν_{Φ} a Borel measure on $(0, +\infty)$ satisfying (2.5) defines a Bernstein function ϕ by means of (2.6).

Definition 2.11. The triplet $(a_{\phi}, b_{\phi}, \nu_{\phi})$ is called the Lévy triplet of ϕ and, in particular, ν_{ϕ} is called the Lévy measure of ϕ . We denote by \mathfrak{B}_0 the subset of \mathfrak{B} composed of Bernstein functions with triplet $(0, 0, \nu_{\phi})$ and such that $\nu_{\phi}(0, \infty) = \infty$.

Any Bernstein function defines the law of a subordinator in a unique way. Namely, for any $\phi \in \mathfrak{B}$ there exists a (canonical) probability space and a (possibly killed) subordinator $\sigma := \{\sigma(t), t \ge 0\}$, i.e. an increasing Lévy process, such that

$$\mathbb{E}[e^{-\lambda\sigma(t)}] = e^{-t\phi(\lambda)}, \ \forall t \ge 0, \ \forall \lambda \ge 0,$$

where \mathbb{E} is the expected value on the aforementioned probability space. Vice versa, if σ is a subordinator on a suitable probability space, then the function

$$\phi(\lambda) = -\log(\mathbb{E}[e^{-\lambda\sigma(1)}])$$

belongs to \mathfrak{B} . For further details we refer to [63, Chapter 5], [12, Chapter III] and [13]. For the ease of the reader, for any $0 \le t_1 < t_2 < \infty$ and any Borel-measurable $f : \mathbb{R}^+ \to \mathbb{R}$, we shall denote

$$\int_{t_1}^{t_2} f(s)\nu_{\phi}(ds) := \int_{(t_1, t_2]} f(s)\nu_{\phi}(ds) \quad \text{and} \quad \int_{t_1}^{\infty} f(s)\nu_{\phi}(ds) := \int_{(t_1, \infty)} f(s)\nu_{\phi}(ds) = \int$$

In the next sections we shall use the following notation

$$\overline{\nu}_{\phi}(t) := \nu_{\phi}(t, \infty), \quad \mathcal{I}_{\phi}(t) := \int_{0}^{t} \overline{\nu}_{\phi}(s) ds, \quad \mathcal{J}_{\phi}(t) := \int_{0}^{t} s \nu_{\phi}(ds).$$

A simple integration by parts argument leads to the relation

$$\mathcal{J}_{\phi}(t) = t\overline{\nu}_{\phi}(t) - \mathcal{I}_{\phi}(t). \tag{2.7}$$

A Bernstein function $\phi \in \mathfrak{B}$ is said to be special if the function

$$\phi^{\star}(\lambda) = \frac{\lambda}{\phi(\lambda)}$$

still belongs to \mathfrak{B} . We call \mathfrak{SB}_0 the set $\mathfrak{SB}_0 := \mathfrak{SB} \cap \mathfrak{B}_0$, where \mathfrak{SB} is the set of special Bernstein functions.

3. The non-local operator

We here define the coupled non-local operator that will be used in the next sections.

Definition 3.1. Consider a linear operator $G : C \subseteq \mathcal{E} \to \mathcal{E}$, a uniqueness class $(\mathcal{C}_0, \mathcal{C}_{sol})$ for G and its induced semigroup action $(P_t)_{t\geq 0}$ on \mathcal{C}_0 . Let $\phi \in \mathfrak{B}_0$ and $f \in \mathcal{B}(\mathbb{R}^+_0 \times E)$ such that, for any $t \geq 0$, $f(t, \cdot) \in \mathcal{C}_0$. For t > 0 and $x \in E$ we define

$$-\phi(\partial_t - G) f(t, x) = \int_0^{+\infty} (P_s f(t - s, x) \mathbb{1}_{[0,t]}(s) - f(t, x)) \nu_\phi(ds),$$

where, for any t < 0, we set $f(t, x) \equiv 0$, provided the integral is well-defined.

Now we would like to find some conditions on f so that $-\phi(\partial_t - G) f(t, x)$ is well-defined at least for some $(t, x) \in \mathbb{R}^+_0 \times E$. This is true as a consequence of the following theorem.

Theorem 3.2. Let $G : C \subseteq \mathcal{E} \to \mathcal{E}$ be a linear operator, $(\mathcal{C}_0, \mathcal{C}_{sol})$ be a uniqueness class for G and $(P_t)_{t\geq 0}$ be the semigroup action induced by G on \mathcal{C}_0 . Let also $\phi \in \mathfrak{B}_0$. Consider a function $f \in \mathcal{B}(\mathbb{R}^+_0 \times E)$ such that $f(t, \cdot) \in \mathcal{C}_0$. Fix $(t, x) \in \mathbb{R}^+_0 \times E$ and assume further that:

(i) It holds

$$\int_0^t |P_s f(t-s,x) - P_s f(t,x)| \nu_\phi(ds) < \infty;$$

(ii) It holds

$$\int_0^t |P_s f(t,x) - f(t,x)| \nu_\phi(ds) < \infty$$

Then $-\phi(\partial_t - G)f(t, x)$ is well-defined.

Proof. It is sufficient to split the integral defining $-\phi(\partial_t - G)f(t, x)$ as follows:

$$\begin{aligned} -\phi(\partial_t - G)f(t,x) &= \int_0^t (P_s f(t-s,x) - P_s f(t,x))\nu_\phi(ds) \\ &+ \int_0^t (P_s f(t,x) - f(t,x))\nu_\phi(ds) - \overline{\nu}_\phi(t)f(t,x), \end{aligned}$$

where the two integrals are absolutely convergent by (i) and (ii).

In the following, we shall make explicit use of the Laplace transform. The following theorem provides sufficient conditions to guarantee that $-\phi(\partial_t - G)f(\cdot, x)$ is Laplace transformable for fixed $x \in E$. The proof of this theorem is an immediate consequence of the existence conditions for Laplace transforms (see [1, Section 1.4]).

Theorem 3.3. Let $G : C \subseteq \mathcal{E} \to \mathcal{E}$ be a linear operator, $(\mathcal{C}_0, \mathcal{C}_{sol})$ be a uniqueness class for G and $(P_t)_{t\geq 0}$ be the semigroup action induced by G on \mathcal{C}_0 . Let also $\phi \in \mathfrak{B}_0$. Consider a function $f \in \mathcal{B}(\mathbb{R}^+_0 \times E)$ such that $f(t, \cdot) \in \mathcal{C}_0$. Fix $x \in E$ and suppose that the assumptions of Theorem 3.2 hold on (t, x) for a.a. $t \in \mathbb{R}^+_0$. Assume further that

(i) There exists $\lambda_0 > 0$ such that for all $\lambda > \lambda_0$

$$\int_0^\infty e^{-\lambda t} \int_0^t |P_s f(t-s,x) - P_s f(t,x)| \,\nu_\phi(ds) \, dt < \infty;$$

(ii) There exists $\lambda_1 > 0$ such that for all $\lambda > \lambda_1$

$$\int_0^\infty e^{-\lambda t} \int_0^t |P_s f(t,x) - f(t,x)| \,\nu_\phi(ds) \, dt < \infty;$$

(iii) There exists $\lambda_2 > 0$ such that for all $\lambda > \lambda_2$

$$\int_0^\infty e^{-\lambda t} \overline{\nu}_\phi(t) |f(t,x)| \, dt < \infty.$$

Then, setting $\lambda_{\star} := \max\{\lambda_0, \lambda_1, \lambda_2\}$, for all $\lambda > \lambda_{\star}$ it holds

$$\int_0^\infty e^{-\lambda t} |(-\phi(\partial_t - G)f(t, x))| dt < \infty$$
(3.1)

and

$$\int_{0}^{\infty} e^{-\lambda t} (-\phi(\partial_t - G)f(t, x))dt = \int_{0}^{\infty} \int_{0}^{\infty} e^{-\lambda t} (P_s f(t - s, x)\mathbb{1}_{[0,t]}(s) - f(t, x))dt \,\nu_\phi(ds).$$
(3.2)

The assumptions of both Theorems 3.2 and 3.3 are quite general and must be verified separately depending on the properties of the operator G and the semigroup action $(P_t)_{t>0}$.

Furthermore, if we equip the state space E with a measure μ_E , then we could ask for some sufficient conditions on f so that $-\phi(\partial_t - G)f(t, x)$ is well-defined for a.a. $t \ge 0$ and μ_E -a.a. $x \in E$. This can be done by developing, for instance, a L^1_{loc} -theory. Since, however, in our cases of interest it will be not necessary, we do not report these details.

On the other hand, we shall make use of a maximum principle, that holds under some additional assumptions on the semigroup action $(P_t)_{t\geq 0}$. We recall here some specific properties.

Definition 3.4. We say that the semigroup action $(P_t)_{t\geq 0}$ is positivity preserving if for all $f \in C_0$ with $f(x) \geq 0$ for all $x \in E$ it holds $P_t f(x) \geq 0$ for all $x \in E$ and $t \geq 0$.

We say that the semigroup action $(P_t)_{t\geq 0}$ is sub-Markov if there exists a one-parameter semigroup of operators $(P_t^{\rm b})_{t\geq 0}$ acting on $C_{\rm b}(E)$ and coinciding with $(P_t)_{t\geq 0}$ on $\mathcal{C}_0 \cap C_{\rm b}(E)$ such that $P_t^{\rm b} 1 \leq 1$.

Throughout the paper we shall omit the superscript b on the additional semigroup $(P_t^b)_{t\geq 0}$. With these definitions, we are ready to prove the following Positive Maximum Principle (PMP).

Proposition 3.5. Assume that the semigroup action $(P_t)_{t\geq 0}$ is positivity preserving and sub-Markov.

(i) Assume there exists $(t_{\star}, x_{\star}) \in \mathbb{R}^+ \times E$ such that $f(t_{\star}, x_{\star}) \ge f(t, x)$ for all $(t, x) \in (0, t_{\star}] \times E$ and $f(t_{\star}, x_{\star}) > f(0, x)$, for all $x \in E$ and $-\phi(\partial_t - G)f(t_{\star}, x_{\star})$ is well-defined. Then

$$-\phi(\partial_t - G)f(t_\star, x_\star) + \overline{\nu}_\phi(t_\star)f(0, x_\star) < 0.$$

(ii) Assume there exists $(t_{\star}, x_{\star}) \in \mathbb{R}^+ \times E$ such that $f(t_{\star}, x_{\star}) \leq f(t, x)$ for all $(t, x) \in (0, t_{\star}] \times E$, $f(t_{\star}, x_{\star}) < f(0, x)$ for all $x \in E$ and $-\phi(\partial_t - G)f(t_{\star}, x_{\star})$ is well-defined. Then

$$-\phi(\partial_t - G)f(t_\star, x_\star) + \overline{\nu}_\phi(t_\star)f(0, x_\star) > 0$$

Proof. We just prove (i), since the proof of (ii) is analogous. For $t \in [0, t_*]$ and $x \in E$ define $\overline{f}(t, x) = f(t_*, x_*) - f(t, x) \ge 0$. Since P_t is positivity preserving, we have $P_s \overline{f}(t_* - s, x) \ge 0$ for all $s \in [0, t_*]$ and $x \in E$, that in turn implies $P_s f(t_* - s, x) \le (P_s f(t_*, x_*))(x)$ for all $s \in [0, t_*]$ and $x \in E$. Furthermore, since P_s is sub-Markov and linear, we have

$$P_s f(t_\star - s, x) \le f(t_\star, x_\star), \ \forall s \in [0, t_\star] \ \forall x \in E.$$

Hence, it is sufficient to observe that

$$\begin{split} \phi(\partial_t - G)f(t_\star, x_\star) + \overline{\nu}_{\Phi}(t_\star)f(0, x_\star) \\ &= \int_0^{t_\star} (P_s f(t_\star - s, x_\star) - f(t_\star, x_\star))\nu_{\phi}(ds) \end{split}$$

$$+ \overline{\nu}_{\phi}(t_{\star})(f(0, x_{\star}) - f(t_{\star}, x_{\star})) < 0.$$

In the next section, we shall focus on the following equation:

$$\begin{cases} \phi(\partial_t - G)q(t, x) = \overline{\nu}_{\phi}(t)q(0, x) & t > 0, \ x \in E\\ q(0, x) = u(x) & x \in E, \end{cases}$$

$$(3.3)$$

where u is suitable initial data. Let us give the definition of solution.

Definition 3.6. We say that $q : \mathbb{R}_0^+ \times E \to \mathbb{R}$ is a solution of (3.3) if q is continuous, $\phi(\partial_t - G)q(t, x)$ is well-defined for all $(t, x) \in \mathbb{R}^+ \times E$ and the equality in (3.3) hold.

We remark that operators in the form of $\phi(\partial_t - G)$ have already been considered in the literature. In [32] the authors considered the equation $(\partial_t - \Delta)^{\alpha} q = q^p$, $\alpha \in (0, 1)$, p > 0, for $x \in \mathbb{R}^d$, $t \in (0, T)$, and studied the existence and behaviour of blow-up. In [7] the authors considered the equation $(\partial_t - \Delta)^{\alpha} q = 0$, $\alpha \in (0, 1)$, in connection with the obstacle problem for the fractional Laplacian. Furthermore, in [17] the authors considered coupled operators of this kind: $\phi(\partial_t - G)$, under suitable assumptions, and they provided Hölder estimates for integro-differential equations involving those operators.

In this paper, we are interested in proving the existence and uniqueness of the solutions to (3.3) and relating them to some appropriate non-Markov processes. We shall consider two specific cases of interest:

- In the first case, we shall assume that G is the generator of a Feller semigroup on $C_0(E)$. In such a case (3.3) is shown to be the governing equation of a large family of time-changed Feller processes.
- In the second case, we shall focus on a sub-diffusive Black-Scholes equation in the context of a sub-diffusive market. Notice that, in such a situation, we could consider G to be the generator of a geometric Brownian motion, however the initial (or final) data we consider does not belong to $C_0(\mathbb{R}^+)$. For such a reason, a deep investigation of the uniqueness classes related to the problem is needed. Even in this case, however, the solution can be related to a suitably time-changed geometric Brownian motion.

In both cases, the existence of the solution can be proved using a stochastic representation, namely a suitable time-change of a Markov process generated by G. This idea will be described in the next section.

4. The undershooting of a subordinator and related time-changed processes

Fix a filtered probability space $(\Omega, \mathcal{F}_{\infty}, \{\mathcal{F}_t\}_{t\geq 0}, \mathbb{P})$. Throughout the paper, we will denote filtrations with a calligraphic letter without subscript, as, for instance, $\mathcal{F} := \{\mathcal{F}_t\}_{t\geq 0}$. Let $S = \{S(t), t \geq 0\}$ be a real-valued, strictly increasing càdlàg process with independent and stationary increments. In particular, we have that $S_0 = \{S_0(t), t \geq 0\}$ defined as $S_0(t) = S(t) - S(0)$ is a subordinator. We define the first-passage processes

$$L(t) := \inf\{u \ge 0 : S(u) > t\}$$

$$L_0(t) := \inf\{u \ge 0 : S_0(u) > t\},$$

where for all $t \ge 0$ it holds $L(t) = L_0(t - S(0))$. Since S is assumed to be strictly increasing, L is continuous and increasing. Denote by $D(\mathbb{R}^+_0)$ the space of real-valued càdlàg functions and for any $f \in D(\mathbb{R}^+_0)$ and t > 0let $f(t-) = \lim_{\delta \uparrow 0} f(t+\delta)$, while we set f(0-) := f(0). We define

$$H(t) := S_0(L(t)-) \qquad H_0(t) := S_0(L_0(t)-).$$
(4.1)

In particular, H_0 is called the undershooting of the subordinator S_0 , see [13, Section 1.4]. Concerning H, we have, for all $t \ge 0$

$$H(t) = S(L(t)-) - S(0) = H_0(t - S(0)).$$

Throughout the paper, we assume that $\mathbb{E}[e^{-\lambda S_0(t)}] = e^{-t\phi(\lambda)}$, where $\phi \in \mathfrak{B}_0$. The potential measure of the subordinator S_0 is defined as

$$U^{\phi}(t) = \mathbb{E}[L_0(t)].$$

It is well-known (see [63, Theorem 10.3 and Equation (10.9)]) that if $\phi \in \mathfrak{SB}_0$ then there exists a nonincreasing function $u^{\phi} : \mathbb{R}^+ \to \mathbb{R}^+$ (called the potential density) such that $\int_0^1 u^{\phi}(t) dt < \infty$ and

$$U^{\phi}(dt) = u^{\phi}(t)dt.$$

Since u^{ϕ} is non-increasing and non-negative, U^{ϕ} is concave. We recall (see [63, Theorem 10.9]) that $(u^{\phi}, \bar{\nu}_{\phi})$ constitute a Sonine pair, meaning that

$$\int_0^t u^\phi(\tau)\bar{\nu}_\phi(t-\tau)d\tau = 1$$

Such a condition, called Sonine condition, has been first introduced in [65]. In general, for all Borel sets $A \subseteq [0, t]$ (see [13, Lemma 1.10]),

$$\mathbb{P}(H_0(t) \in A) = \int_A \overline{\nu}_\phi(t-y) U^\phi(dy).$$

Furthermore, if $\phi \in \mathfrak{SB}_0$, it holds

$$\mathbb{P}(H_0(t) \in A) = \int_A \overline{\nu}_\phi(t-y) u^\phi(y) \, dy.$$
(4.2)

Since it is a suitable time translation of the undershooting H_0 of S_0 , we refer to H as the undershooting of S. Since it is the composition of the càglàd function $S_0(\cdot -)$ with the continuous function $L(\cdot)$, it is true that also H is càglàd. Now, we want to use H as a time-change. The fact that it is not right-continuous implies that this is not a time-change in the usual sense, e.g. [53, Definition V.1.2]. However, a suitable theory of left-continuous time-changes has been developed in the context of subordinators and their inverses (see [46]).

To define our time-changed process, let $M = \{M(t), t \geq 0\}$ be a Feller process independent of S. We define $M^{\phi}(t) = M(S_0(t))$ and $\tau(t) = t + S(0)$ for all $t \geq 0$. Since (M, τ) is a Feller process, by Phillips' Theorem (see [57, Theorem 32.1]) we know that (M^{ϕ}, S) , that is obtained by subordination via S_0 , is still a Feller process with respect to its natural filtration. In the following, it will be useful to consider the canonical construction of (M, S), as in [53, Chapter III.1], with the only exception that we are using the most general form of the Kolmogorov extension theorem, as in [66, Theorem 2.4.3], so that we do not need E to be a Polish space. We recall here the canonical construction. We have $\Omega = D(\mathbb{R}^+_0; E \times \mathbb{R})$, i.e., the space of càdlàg functions with values in $E \times \mathbb{R}$, and we set for any $\omega \in \Omega$, denoting $\omega(t) = (\omega_1(t), \omega_2(t)) \in E \times \mathbb{R}$ for $t \geq 0$, $(M(t)(\omega), S(t)(\omega)) = \omega(t)$. For $t \geq 0$, we let $\mathcal{F}^0_t = \sigma((M(s), S(s)), s \leq t)$ and $\mathcal{F}^0_{\infty} = \sigma\left(\bigcup_{t\geq 0} \mathcal{F}^0_t\right)$. Then, for any $(x, v) \in E \times \mathbb{R}$, we construct, by using Kolmogorov extension theorem, the unique probability measure $\mathbb{P}^{(x,v)}$ on $(\Omega, \mathcal{F}^0_\infty)$ such that (M, S) admits the desired transition probability function and $\mathbb{P}^{(x,v)}(M(0) = x, S(0) = v) = 1$. Once this is done, we consider the completion \mathcal{F}_{∞} and \mathcal{F}_t , for $t \geq 0$, of \mathcal{F}^0_{∞} and \mathcal{F}^0_t , for $t \geq 0$, with respect to the measure $\mathbb{P}^{(x,v)}$ and we use as (family of) filtered probability spaces $(\Omega, \mathcal{F}_\infty, \{\mathcal{F}_t\}_{t\geq 0}, \mathbb{P}^{(x,v)})$. In such a case, (M, S) is called a canonical Feller process. Now denote $\mathcal{G}^0_t = \sigma((M^{\phi}(s), S(s)), s \leq t), \mathcal{G}^0_\infty := \sigma\left(\bigcup_{t\geq 0} \mathcal{G}^0_t\right)$ and with \mathcal{G}_t and \mathcal{G}_∞ their completion with respect to $\mathbb{P}^{(x,v)}$. Since the composition is a measurable operator (see [14]), we know that $\mathcal{G}_\infty \subset \mathcal{F}_\infty$. Furthermore, by Phillip's theorem, (M^{ϕ}, S) is a Feller process with respect to the filtration $\mathcal{G} := \{\mathcal{G}_t\}_{t\geq 0}$. Before proceeding

Definition 4.1. Consider a probability space $(\Omega, \mathcal{F}_{\infty}, \mathbb{P})$ and a filtration $\mathcal{F} := \{\mathcal{F}_t\}_{t\geq 0}$ on it. An $E \times \mathbb{R}^m$ -valued stochastic process (X, Y) is said to be Markov additive with respect to \mathcal{F} if it is \mathcal{F} -Markov and for all $A \in \mathcal{E}, B \in \mathcal{B}(\mathbb{R}^m)$ and $0 \leq s \leq t$

$$P_{s,t}\mathbb{1}_{A\times B}(x,y) = P_{s,t}\mathbb{1}_{A\times (B-y)}(x,0),$$

where $B - y = \{z \in \mathbb{R}^m : z + y \in B\}$ and $P_{s,t}$ is the two-parameters transition semigroup of (X, Y). Notice that the latter is equivalent to

$$\mathbb{P}((X(t), Y(t) - Y(s)) \in A \times B \mid X(s), Y(s))$$

= $\mathbb{P}((X(t), Y(t) - Y(s)) \in A \times B \mid X(s)).$ (4.3)

We can prove the following result.

Lemma 4.2. The process (M^{ϕ}, S) is Markov additive with respect to its augmented natural filtration \mathcal{G} .

Proof. We already know that (M^{ϕ}, S) is a Feller process with respect to \mathcal{G} , hence we just need to show (4.3). Let s < t, $A \in \mathcal{E}$ and $B \in \mathcal{B}(\mathbb{R})$, let $M^{\phi}(t)$ play the role of X(t) and S(t) play the role of Y(t) and observe that, setting $\Delta S = S(t) - S(s)$,

$$\mathbb{P}^{(x,v)}\left(\left(M^{\phi}(t),\Delta S\right)\in A\times B\mid M^{\phi}(s),S(s)\right)$$

= $\mathbb{E}^{(x,v)}\left[\mathbb{I}_{A}\left(M^{\phi}(t)\right)\mathbb{1}_{B}\left(\Delta S\right)\mid M^{\phi}(s),S(s),\Delta S\right]\mid M^{\phi}(s),S(s)\right]$
= $\mathbb{E}^{(x,v)}\left[\mathbb{1}_{B}\left(\Delta S\right)\mathbb{E}^{(x,v)}\left[\mathbb{1}_{A}\left(M^{\phi}(t)\right)\mid M^{\phi}(s),S(s),\Delta S\right]\mid M^{\phi}(s),S(s)\right]$

Now recall that $M^{\phi}(t) = M(S(t) - v) = M(\Delta S + S(s) - v)$ and $M^{\phi}(s) = M(S(s) - v)$, where S(s) < S(t). Now consider three Borel sets $B_1 \in \mathcal{E}$, $B_2, B_3 \subset \mathbb{R}$ and the event

$$B^{\star} = \{ M^{\phi}(s) \in B_1 \} \cap \{ S(s) \in B_2 \} \cap \{ \Delta S \in B_3 \} \in \sigma(M^{\phi}(s), S(s), \Delta S)$$

It holds

$$\begin{split} & \mathbb{E}^{(x,v)}[\mathbb{1}_{B^{\star}}\mathbb{1}_{A}(M^{\phi}(t))] \\ &= \mathbb{E}^{(x,v)}[\mathbb{1}_{B_{1}}(M^{\phi}(s))\mathbb{1}_{B_{2}}(S(s))\mathbb{1}_{B_{3}}(\Delta S)\mathbb{1}_{A}(M(\Delta S + S(s) - v))] \\ &= \mathbb{E}^{(x,v)}\left[\mathbb{1}_{B_{3}}(\Delta S) \mathbb{E}^{(x,v)}\left[\mathbb{1}_{B_{1}}(M^{\phi}(s))\mathbb{1}_{B_{2}}(S(s))\mathbb{1}_{A}(M(\Delta S + S(s) - v)) \mid \Delta S\right]\right]. \end{split}$$

Once we notice that $\{M(t), t \ge 0\}$ and S(s) are independent of ΔS , if we set

$$F_1(y) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_1}(M^{\phi}(s)) \mathbb{1}_{B_2}(S(s)) \mathbb{1}_A(M(y+S(s)-v)) \right],$$

it holds

$$\mathbb{E}^{(x,v)}[\mathbb{1}_{B^{\star}}\mathbb{1}_A(M^{\phi}(t))] = \mathbb{E}^{(x,v)}\left[\mathbb{1}_{B_3}(\Delta S)F_1(\Delta S)\right].$$

However, we can also write

$$F_1(y) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_1}(M^{\phi}(s)) \mathbb{1}_{B_2}(S(s)) \mathbb{E}^{(x,v)} \left[\mathbb{1}_A(M(y+S(s)-v)) \mid M^{\phi}(s), S(s) \right] \right].$$
(4.4)

Let us focus on the inner conditional expectation. Consider again two sets $B_4 \in \mathcal{E}$ and $B_5 \in \mathcal{E}$ and the event $B_{\star\star} = \{M^{\phi}(s) \in B_4\} \cap \{S(s) \in B_5\}.$

Then

$$\mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_{\star\star}} \mathbb{1}_A (M(y+S(s)-v)) \right] = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_4} (M^{\phi}(s)) \mathbb{1}_{B_5} (S(s)) \mathbb{1}_A (M(y+S(s)-v)) \right]$$

= $\mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_5} (S(s)) \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_4} (M^{\phi}(s)) \mathbb{1}_A (M(y+S(s)-v) \mid S(s)) \right] \right].$

Since M and S are independent, if we set, for $z\geq v,$

$$F_2(z) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_4} (M(z-v)) \mathbb{1}_A (M(y+z-v)) \right],$$

it holds

$$\mathbb{E}^{(x,v)}\left[\mathbb{1}_{B_{\star\star}}\mathbb{1}_A(M(y+S(s)-v))\right] = \mathbb{E}^{(x,v)}\left[\mathbb{1}_{B_5}(S(s))F_2(S(s))\right]$$

However, since $\{M(z-v) \in B_4\} \in \sigma(M(z-v))$, we have $F_2(z) = \mathbb{E}^{(x,v)} \left[\mathbbm{1}_{B_4}(M(z-v)) \mathbb{E}^{(x,v)}\right]$

$$F_{2}(z) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_{4}}(M(z-v)) \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A}(M(y+z-v) \mid M(z-v)) \right] \right]$$

= $\mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_{4}}(M(z-v)) \mathbb{E}^{(M(z-v),v)} \left[\mathbb{1}_{A}(M(y)) \right] \right].$

Hence

$$\begin{split} \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_{\star\star}} \mathbb{1}_A(M(y+S(s)-v)) \right] \\ &= \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_5}(S(s)) \mathbb{1}_{B_4}(M^{\phi}(s)) \mathbb{E}^{(M^{\phi}(s),v)} \left[\mathbb{1}_A(M(y)) \right] \right] \\ &= \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_{\star\star}} \mathbb{E}^{(M^{\phi}(s),v)} \left[\mathbb{1}_A(M(y)) \right] \right]. \end{split}$$

Since the events of the form $B_{\star\star}$ constitute a π -system generating $\sigma(M^{\phi}(s), S(s))$, this shows that

$$\mathbb{E}^{(x,v)} \left[\mathbb{1}_A (M(y + S(s) - v)) \mid M^{\phi}(s), S(s) \right] = \mathbb{E}^{(M^{\phi}(s),v)} \left[\mathbb{1}_A (M(y)) \right]$$

Define

$$F_3(x,y) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_A(M(y)) \right]$$

so that going back to (4.4) we get

$$F_1(y) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B_1}(M^{\phi}(s)) \mathbb{1}_{B_2}(S(s)) F_3(M^{\phi}(s), \Delta S) \right]$$

and then

$$\mathbb{E}^{(x,v)}[\mathbb{1}_{B^{\star}}\mathbb{1}_A(M^{\phi}(t))] = \mathbb{E}^{(x,v)}\left[\mathbb{1}_{B^{\star}}F_3(M^{\phi}(s),\Delta S)\right],$$

i.e., since the events of the form B^{\star} constitute a π -system generating $\sigma(M^{\phi}(s), S(s), \Delta S)$,

$$\mathbb{E}^{(x,v)}[\mathbb{1}_{A}(M^{\phi}(t)) \mid M^{\phi}(s), S(s), \Delta S] = F_{3}(M^{\phi}(s), \Delta S).$$

Since ΔS is independent of both $M^{\phi}(s)$ and S(s), we get (see Lemma A.1)

$$\mathbb{P}^{(x,v)}((M^{\phi}(t),\Delta S) \in A \times B \mid M^{\phi}(s), S(s)) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_B(\Delta S) F_3(M^{\phi}(s),\Delta S) \mid M^{\phi}(s) \right].$$
(4.5)

Use now (4.5) to see that

$$\begin{split} \mathbb{P}^{(x,v)}((M^{\phi}(t),\Delta S) \in A \times B \mid M^{\phi}(s)) \\ &= \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B}(\Delta S) \mathbb{1}_{A}(M^{\phi}(t)) \mid M^{\phi}(s) \right] \\ &= \mathbb{E}^{(x,v)} \left[\mathbb{E}^{(x,v)} \left[\mathbb{1}_{B}(\Delta S) \mathbb{1}_{A}(M^{\phi}(t)) \mid M^{\phi}(s), S(s) \right] \mid M^{\phi}(s) \right] \\ &= \mathbb{E}^{(x,v)} \left[\mathbb{P}^{(x,v)}((M^{\phi}(t),\Delta S) \in A \times B \mid M^{\phi}(s), S(s)) \mid M^{\phi}(s) \right] \\ &= \mathbb{E}^{(x,v)} \left[\mathbb{E}^{(x,v)} \left[\mathbb{1}_{B}(\Delta S) F_{3}(M^{\phi}(s),\Delta S) \mid M^{\phi}(s) \right] \mid M^{\phi}(s) \right] \\ &= \mathbb{E}^{(x,v)} \left[\mathbb{1}_{B}(\Delta S) F_{3}(M^{\phi}(s),\Delta S) \mid M^{\phi}(s) \right] \\ &= \mathbb{P}^{(x,v)}((M^{\phi}(t),\Delta S) \in A \times B \mid M^{\phi}(s), S(s)). \end{split}$$

Now we can define the process $X = \{X(t), t \ge 0\}$ where $X(t) = M^{\phi}(L(t))$ that is, if we remember that $H(t) = S_0(L(t))$, we have that X(t) = M(H(t)). Notice, in particular, that X is a càglàd process. We can highlight quite a special case. Indeed, if $E = \mathbb{R}^d$ and M is a jump-diffusion (as in [46]), then also M^{ϕ} is a jump-diffusion by [57, Theorem 32.1]. Hence, by combining Lemma 4.2 and [46, Theorem 4.1], we know that the process $\{(X(t), \gamma(t)), t \ge 0\}$ is a time-homogeneous simple Markov process, where $\gamma(t) = \max\{t - S(0) - H(t), 0\}$. The process γ is usually referred to as the *age* process, while its right-limits, under v = 0, coincide with the sojourn time of X in the current position, i.e., the r.v. $J_X(t) := t - (0 \lor \sup\{s \le t : X(s) \ne X(t)\})$, whenever M (and thus M^{ϕ}) does not admit holding points (i.e., points on which M is stuck for an exponentially distributed random time). Such processes are related, as observed in [46], on the one hand, to the limits of continuous time random walks and, on the other hand, to the theory of semi-Markov processes (see [36]). It is, however, worth noticing that the fact that the semi-Markov property holds for X has not been shown even for $E = \mathbb{R}^d$, but the simple Markov property of (X, γ) is already enough to provide interesting stochastic models. We conjecture that the process X is actually semi-Markov even in the general case in which E is a locally compact separable Hausdorff space: this problem is deferred to future research.

5. A COUPLED FULLY NON-LOCAL EQUATION FOR TIME-CHANGED FELLER PROCESSES

In this section, we want to determine the governing evolution equation of the process X(t) under the condition S(0) = 0, relating it with (3.3). To do this, we shall consider the case in which G is a generator of a Feller semigroup. Let us now dive into the details.

Let M be defined as in the previous section and consider its Feller semigroup $\{P_t\}_{t\geq 0}$ on $C_0(E)$. Denote by G its generator, with domain $\mathsf{Dom}(G)$. As in Example 2.7, $(C_0(E), C(\mathbb{R}_0^+; C_0(E)))$ is a uniqueness class for G. To get uniqueness for our non-local equation (3.3), the condition $q(t, \cdot) \in C_0(E)$ will not be sufficient: we need this to hold locally uniformly in time.

Definition 5.1. Let
$$u : \mathbb{R}_0^+ \times E \to \mathbb{R}$$
 and $T > 0$. We say that

 $\lim_{x \to \infty} u(t, x) = 0 \quad uniformly with respect to t \in [0, T]$

if for all $\varepsilon > 0$ there exists a compact set $K \subset E$ such that

$$\sup_{x \notin K} |u(t,x)| < \varepsilon, \quad \forall t \in [0,T].$$

We say that

$$\lim_{x \to \infty} u(t, x) = 0 \quad \text{ locally uniformly with respect to } t \ge 0$$

if the same property holds uniformly with respect to $t \in [0, T]$ for all T > 0.

Theorem 5.2. Let $\phi \in \mathfrak{SB}_0$ such that $\|\log(\cdot)u^{\phi}(\cdot)\|_{L^1[0,1]} < \infty$ and M be a E-valued Feller process with semigroup $\{P_t\}_{t\geq 0}$ and generator $(G, \mathsf{Dom}(G))$. Let also S be a real-valued, strictly increasing càdlàg process with independent and stationary increments. Assume further that S is independent of M and that the subordinator $S_0(t) = S(t) - S(0)$ is such that $\phi(\lambda) = \log \mathbb{E}^{(x,0)}[e^{-\lambda S_0(1)}]$. Let H be the undershooting of S and X(t) = M(H(t)). Finally, suppose that $S_0(t)$ admits a density $g_{S_0}(\cdot;t)$ under $\mathbb{P}^{(x,0)}$. Then, for all $u \in \mathsf{Dom}(G)$, the function

$$q(t,x) = \mathbb{E}^{(x,0)} [u(X(t))]$$

is the unique solution of

$$\begin{cases} \phi(\partial_t - G)q(t, x) = \overline{\nu}_{\phi}(t)q(0, x), & t > 0, \ x \in E, \\ q(0, x) = u(x), & x \in E \\ \lim_{x \to \infty} q(t, x) = 0 & locally uniformly with respect to \ t \ge 0, \end{cases}$$
(5.1)

i.e., it is the unique function $q : \mathbb{R}_0^+ \times E \mapsto \mathbb{R}$ that satisfies Definition 3.6 and the limit condition $\lim_{x \to +\infty} q(t, x) = 0$ locally uniformly with respect to $t \ge 0$.

Remark 5.3. Notice that if $E \subset \mathbb{R}^d$ is a bounded open set with a suitably regular boundary, $f \in C_0(E)$ if and only if $f \in C(\overline{E})$ with f(x) = 0 on ∂E . Furthermore,

$$\lim_{x \to \infty} q(t, x) = 0 \quad \text{ locally uniformly with respect to } t \ge 0$$

if and only if $q \in C(\mathbb{R}^+_0 \times \overline{E})$ with q(t, x) = 0 for all $x \in \partial E$. In particular (5.1) becomes

$$\begin{cases} \phi(\partial_t - G)q(t, x) = \overline{\nu}_{\phi}(t)q(0, x), & t > 0, \ x \in E, \\ q(0, x) = u(x), & x \in E, \\ q(t, x) = 0 & x \in \partial E, \end{cases}$$
(5.2)

i.e., it is a non-local Cauchy-Dirichlet problem. From a purely analytical point of view and in the special case $\phi(\lambda) = \lambda^{\alpha}$ and $G = \Delta$ these problems have been studied in [7] in connection with the obstacle problem for the fractional Laplacian and in [32] with a non-linear term. Also in [17], equations of these forms are considered and Hölder estimates are provided.

In order to prove Theorem 5.2, we need some preliminary regularity estimates on the function q to verify the hypotheses of Theorems 3.2 and 3.3.

5.1. Regularity of q. First of all, in order to guarantee that we can apply Theorems 3.2 and 3.3 to the function q, we show that it satisfies the assumptions of both theorems. This requires some smoothness properties. We start by proving that, for fixed $x \in E$, $q(\cdot, x)$ is absolutely continuous.

Proposition 5.4. Under the hypotheses of Theorem 5.2, for all $x \in E$ the function $q(\cdot, x)$ belongs to $AC(\mathbb{R}^+_0)$ with a.e. derivative $\partial_t q(\cdot, x)$ satisfying, for almost all $t \in [0, T]$,

$$\partial_t q(t,x) \le C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) u^{\phi}(t)$$
(5.3)

for a suitable constant C > 0 (which is independent on $x \in E$). Remember that $u^{\phi}(t)$ denotes the potential density.

Proof. Consider the Feller semigroup $(P_t)_{t>0}$ acting on any function $w \in C_0(E \times \mathbb{R})$ as

$$\widetilde{P}_t w(x,s) = \mathbb{E}^{(x,0)}[w(M(t),t+s)].$$

Let \widetilde{A} be the generator of $(\widetilde{P}_t)_{t\geq 0}$. By Phillips theorem (see [63, Theorem 12.6]), we obtain that the generator of (M^{ϕ}, S) (which is obtained by subordinating \widetilde{P} by means of the subordinator S_0) is given, on functions $w \in \mathsf{Dom}(\widetilde{A})$, by

$$\widetilde{A}^{\phi}w = \int_0^\infty (\widetilde{P}_s w - w)\nu_{\phi}(ds);$$

The reader should keep in mind that the integral in the above equation is in the sense of Bochner. Now let $u \in \text{Dom}(G)$ and consider, for any $N \in \mathbb{N}$, a cut-off function of [-N, N], i.e. $\eta_N \in C_c^{\infty}(\mathbb{R})$ such that $\eta_N(t) = 1$ for $t \in [-N, N]$, $\eta_N(t) = 0$ for $t \in [-N - 1, N + 1]$ and $\eta_N(t) \in [0, 1]$ for all $t \in \mathbb{R}$. Without loss of generality, we can assume that $\left\| \frac{d}{dt} \eta_N \right\|_{L^{\infty}(\mathbb{R})} \leq C_{\eta}$, where C_{η} is independent of N. We define $u_N(x, t) = u(x)\eta_N(t)$. Let us show that $u_N \in \text{Dom}(\widetilde{A})$. Indeed,

$$\lim_{h \to 0} \frac{\dot{P}_h u_N(x,t) - u_N(x,t)}{h}$$

$$= \lim_{h \to 0} \frac{\mathbb{E}^{(x,0)}[u(M(h)) \mid M(0) = x]\eta_N(t+h) - u(x)\eta_N(t)}{h}$$

=
$$\lim_{h \to 0} \frac{\mathbb{E}^{(x,0)}[u(M(h)) \mid M(0) = x] - u(x)}{h}\eta_N(t+h) + u(x)\lim_{h \to 0} \frac{\eta_N(t+h) - \eta_N(t)}{h}$$

=
$$Gu(x)\eta_N(t) + u(x)\frac{d}{dt}\eta_N(t).$$

Since the pointwise generator coincides with the classical one (see [15, Theorem 1.33]), then this proves that $u_N \in \mathsf{Dom}(\widetilde{A})$ and

$$\widetilde{A}u_N(x,t) = Gu(x)\eta_N(t) + u(x)\frac{d}{dt}\eta_N(t) \ \forall x \in E, \ \forall t \in \mathbb{R}.$$
(5.4)

By Phillips theorem, we know that $u_N \in \mathsf{Dom}(\widetilde{A}^{\phi})$ and in particular

$$\begin{split} \widetilde{A}^{\phi} u_N &= \int_0^\infty (\widetilde{P}_s u_N - u_N) \nu_{\phi}(ds) \\ &= \int_0^1 \int_0^s \widetilde{P}_{\tau} \widetilde{A} u_N d\tau \, \nu_{\phi}(ds) + \int_1^\infty (\widetilde{P}_s u_N - u_N) \nu_{\phi}(ds). \end{split}$$

By Bochner theorem, see [1, Theorem 1.1.4], we have

$$\begin{split} \left\| \widetilde{A}^{\phi} u_{N} \right\|_{C(E \times \mathbb{R})} &\leq \int_{0}^{1} \int_{0}^{s} \left\| \widetilde{P}_{\tau} \widetilde{A} u_{N} \right\|_{C(E \times \mathbb{R})} d\tau \, \nu_{\phi}(ds) \\ &+ \int_{1}^{\infty} \left\| \widetilde{P}_{s} u_{N} - u_{N} \right\|_{C(E \times \mathbb{R})} \nu_{\phi}(ds) \\ &\leq \left\| \widetilde{A} u_{N} \right\|_{C(E \times \mathbb{R})} \mathcal{J}_{\phi}(1) + 2 \left\| u_{N} \right\|_{C(E \times \mathbb{R})} \overline{\nu}_{\phi}(1), \end{split}$$

where $\mathcal{J}_{\phi}(1) = \int_0^1 s \nu_{\phi}(ds)$. Using (5.4) and recalling that $\|\eta_N\|_{L^{\infty}(\mathbb{R})} = 1$, we have

$$\begin{split} \left\| \widetilde{A}^{\phi} u_N \right\|_{C(E \times \mathbb{R})} &\leq (\|Gu\|_{C(E)} + \|u\|_{C(E)} C_{\eta}) \mathcal{J}_{\phi}(1) + 2 \|u\|_{C(E)} \overline{\nu}_{\phi}(1) \\ &\leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}), \end{split}$$

for some suitable constant C that is independent of N. Now let

$$q_N(t,x,s) = \mathbb{E}^{(x,s)}[u_N(X(t), S(L(t)-))] = \mathbb{E}^{(x,s)}[u_N(M^{\phi}(L(t)-), S(L(t)-))],$$
(5.5)

observe that L(t) is a stopping time with respect to the natural filtration of $(M^{\phi}(\cdot -), S(\cdot -))$ and use Dynkin's formula [15, Equation (1.55)] to write

$$q_N(t,x,s) = u_N(x,s) + \mathbb{E}^{(x,s)} \left[\int_0^{L(t)} \widetilde{A}^{\phi} u_N(M^{\Phi}(\tau), S(\tau)) d\tau \right],$$

where we also used the fact that S is stochastically continuous. Now fix T > 0 and consider $t \in [0, \frac{3}{2}T]$. We extend $q_N(t, x, s)$ to $t \in [-\frac{T}{2}, 0]$ by setting $q_N(t, x, s) = u_N(x, s)$. Let $h \in \mathbb{R}$ with $0 < |h| < \frac{T}{2}$ and define for any $\varphi : [-\frac{T}{2}, \frac{3}{2}T] \to \mathbb{R}$ the quantity

$$D^h \varphi(t) := \frac{\varphi(t+h) - \varphi(t)}{h}.$$

We argue first for h > 0. Observe that, by (5.5), for almost all $t \in [0, T]$.

$$\begin{split} \left| D^{h} q_{N}(t, x, 0) \right| &\leq h^{-1} \mathbb{E}^{(x, 0)} \left[\int_{L(t)}^{L(t+h)} |\tilde{A}^{\phi} u_{N}(M^{\phi}(\tau), S(\tau))| d\tau \right] \\ &\leq \left\| \tilde{A}^{\phi} u_{N} \right\|_{C(E \times \mathbb{R})} h^{-1} \mathbb{E}^{(x, 0)} [L(t+h) - L(t)] \\ &\leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) h^{-1} (U^{\phi}(t+h) - U^{\phi}(t)) \\ &\leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) u^{\phi}(t). \end{split}$$

If h < 0 instead, let us distinguish among two cases. If $|h| \leq \frac{t}{2}$ then we have

$$\left| D^{h} q_{N}(t,x,0) \right| \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) \frac{U^{\phi}(t) - U^{\phi}(t+h)}{|h|} \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) u^{\Phi}\left(\frac{t}{2}\right).$$

If, instead, $|h| \in \left[\frac{t}{2}, t\right)$, then

$$\left|D^{h}q_{N}(t,x,0)\right| \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)})\frac{U^{\phi}(t) - U^{\phi}(t+h)}{|h|} \leq 2C(\|Gu\|_{C(E)} + \|u\|_{C(E)})\frac{U^{\phi}(t)}{t}.$$

Finally, if |h| > t, we get

$$\left|D^{h}q_{N}(t,x,0)\right| \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)})\frac{U^{\phi}(t)}{|h|} \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)})\frac{U^{\phi}(t)}{t}$$

Hence, we have in general (for any $h \in \mathbb{R}$)

$$\left| D^{h} q_{N}(t,x,0) \right| \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) \left(u^{\phi}(t) + u^{\phi}\left(\frac{t}{2}\right) + \frac{U^{\phi}(t)}{t} \right).$$

Now, since $u \in C_0(E)$ and $\|\eta_N\|_{L^{\infty}(\mathbb{R})} = 1$, we can use the dominated convergence theorem to take the limit as $N \to \infty$ and get

$$\left|D^{h}q(t,x)\right| \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)})\left(u^{\phi}(t) + u^{\phi}\left(\frac{t}{2}\right) + \frac{U^{\phi}(t)}{t}\right).$$
(5.6)

We now use a suitable modification of [27, Theorem 5.8.3] in the case of L^1 functions. For completeness we give here all the details of the proof. Consider any sequence $h_n \to 0$, fix $x \in E$ and set, for simplicity, $g_n(t) = D^{h_n}q(t,x)$ for $t \in [0,T]$. Before proceeding, notice that for any T > 0 it holds

$$\int_0^T \frac{U^{\phi}(t)}{t} dt = \int_0^T \int_0^t \frac{u^{\phi}(s)}{t} ds dt = \int_0^T \int_s^T \frac{u^{\phi}(s)}{t} dt ds = \log(T) U^{\phi}(T) - \int_0^T \log(s) u^{\phi}(s) ds < \infty,$$

where the last inequality follows by assumption. Set then $g^{\phi}(t) = u^{\phi}(t) + u^{\phi}\left(\frac{t}{2}\right) + \frac{U^{\phi}(t)}{t}$ and notice that $g^{\phi} \in L^{1}_{loc}(\mathbb{R}^{+}_{0})$ and $g_{n}(t) \leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)})g^{\phi}(t)$ for all $t \geq 0$. We have then

$$||g_n||_{L^1[0,T]} \le C(||Gu||_{C(E)} + ||u||_{C(E)}) ||g^{\phi}||_{L^1[0,T]}, \ \forall n \in \mathbb{N}.$$

Furthermore, since $g^{\phi} \in L^1[0,T]$, we know that for any $\varepsilon > 0$ there exists $\delta > 0$ such that for all measurable $A \subset [0,T]$ such that $|A| < \delta$ it holds

$$\int_{A} g_n(t) dt \le C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) \int_{A} g^{\phi}(t) dt < \varepsilon, \ \forall n \in \mathbb{N},$$

$$\int_{0}^{T} D^{h}q(t,x)\varphi(t)dt = \int_{0}^{\frac{3}{2}T} D^{h}q(t,x)\varphi(t)dt = -\int_{0}^{\frac{3}{2}T} q(t,x)D^{-h}\varphi(t)dt$$

and, in particular,

$$\int_0^T g_n(t)\varphi(t)dt = -\int_0^{\frac{3}{2}T} q(t,x)D^{-h_n}\varphi(t)dt.$$

Taking the limit as $n \to +\infty$ we have

$$\int_{0}^{T} g(t)\varphi(t)dt = -\int_{0}^{\frac{3}{2}T} q(t,x)\varphi'(t)dt = -\int_{0}^{T} q(t,x)\varphi'(t)dt.$$

It follows that $q(\cdot, x) \in W^{1,1}[0, T]$, where $W^{1,1}[0, T]$ is the usual Sobolev space, with weak derivative $\partial_t q(t, x) = g(t)$. In particular, we recall that any function $W^{1,1}[0, T]$ admits an absolutely continuous version. Since $q(\cdot, x)$ is continuous, then it is absolutely continuous with a.e. derivative $\partial_t q(\cdot, x)$. Finally, notice that for h > 0 we actually have

$$|D^{h}q(t,x)| \le C(||Gu||_{C(E)} + ||u||_{C(E)})u^{\phi}(t)$$

and taking the limit as $h \to 0^+$ we get the statement.

Thanks to the previous result, now we can prove that q satisfies Items (i) of Theorem 3.2 and (i) of Theorem 3.3.

Corollary 5.5. Under the assumptions of Theorem 5.2 we have that for all $(t, x) \in \mathbb{R}_0^+ \times E$,

$$\int_{0}^{t} \|P_{s}q(t-s,\cdot) - P_{s}q(t,\cdot)\|_{C(E)} \ \nu_{\phi}(ds) \le C(\|Gu\|_{C(E)} + \|u\|_{C(E)})$$

and

$$\int_{0}^{\infty} e^{-\lambda t} \int_{0}^{t} \|P_{s}q(t-s,\cdot) - P_{s}q(t,\cdot)\|_{C(E)} \ \nu_{\phi}(ds) \, dt \le \frac{C(\|Gu\|_{C(E)} + \|u\|_{C(E)})}{\lambda}$$
for all $x \in E$ and $\lambda > 0$.

Proof. Let us fix $x \in E$ and observe that by (5.3) we have

$$|q(t-s,x) - q(t,x)| \leq \int_0^s |\partial_t q(t-\tau,x)| d\tau$$

$$\leq C(||Gu||_{C(E)} + ||u||_{C(E)}) \int_0^s u^{\phi}(t-\tau) d\tau.$$
(5.7)

Since P_s is non-expansive, positive preserving and sub-Markov we have for all $x \in E$

$$|P_{s}q(t-s,x) - P_{s}q(t,x)| \leq P_{s} |q(t-s,\cdot) - q(t,\cdot)| (x)$$

$$\leq C(||Gu||_{C(E)} + ||u||_{C(E)}) \int_{0}^{s} u^{\phi}(t-\tau)d\tau$$
(5.8)

hence, taking the supremum, then integrating and using Fubini,

$$\int_0^t \|P_s q(t-s,\cdot) - P_s q(t,\cdot)\|_{C(E)} \ \nu_\phi(ds)$$

$$\begin{split} &\leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) \int_0^t \int_0^s u^{\phi}(t-\tau) \, d\tau \, \nu_{\phi}(ds) \\ &= C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) \int_0^t u^{\phi}(t-\tau) \int_{\tau}^t \nu_{\phi}(ds) \, d\tau \\ &\leq C(\|Gu\|_{C(E)} + \|u\|_{C(E)}) \int_0^t u^{\phi}(t-\tau) \overline{\nu}_{\phi}(\tau) \, d\tau \\ &= C(\|Gu\|_{C(E)} + \|u\|_{C(E)}), \end{split}$$

where the first equality is due to the fact that $(\tau, s) \in [0, s] \times [0, t]$ is equivalent to $(\tau, s) \in [0, t] \times [\tau, t]$. Furthermore, we have

$$\int_{0}^{+\infty} e^{-\lambda t} \int_{0}^{t} \|P_{s}q(t-s,\cdot) - P_{s}q(t,\cdot)\|_{C(E)} \ \nu_{\phi}(ds) \, dt \le \frac{C(\|Gu\|_{C(E)} + \|u\|_{C(E)})}{\lambda}$$

for all $\lambda > 0$.

Next, we show that $q(t, \cdot)$ belongs to $\mathsf{Dom}(G)$ and we control its uniform norm.

Proposition 5.6. Under the hypotheses of Theorem 5.2, for all $t \ge 0$ the function $q(t, \cdot)$ belongs to $\mathsf{Dom}(G)$ and

$$\|Gq(t,\cdot)\|_{C(E)} \le \|Gu\|_{C(E)}.$$
(5.9)

Furthermore $\lim_{x\to\infty} q(t,x) = 0$ locally uniformly with respect to $t \ge 0$.

Proof. Observe that, since H(t) defined in equation (4.1) is independent of M, we have

$$q(t,x) = \mathbb{E}^{(x,0)}[u(X(t))] = \mathbb{E}^{(x,0)}[\mathbb{E}^{(x,0)}[u(X(t)) \mid H(t)]] = \mathbb{E}^{(x,0)}[P_{H(t)}u(x)]$$
$$= \int_0^t P_\tau u(x)\bar{\nu}_\phi(t-\tau)u^\phi(\tau)d\tau,$$
(5.10)

where we used the fact that H(t) admits density $\bar{\nu}_{\phi}(t-\tau)u^{\phi}(\tau)$ for $\tau \in (0,t)$, see [13, Lemma 1.10]. Let us stress that

$$\int_0^t \|P_\tau u\|_{C(E)} \, \bar{\nu}_\phi(t-\tau) u^\phi(\tau) d\tau \le \|u\|_{C(E)} \,,$$

hence, a simple application of the dominated convergence theorem shows that $q(t, \cdot) \in C(E)$. Next, we prove that

 $\lim_{x \to \infty} q(t, x) = 0 \quad \text{locally uniformly with respect to } t \ge 0,$ (5.11)

which in turn implies that $q(t, \cdot) \in C_0(E)$. To do this, fix T > 0 and observe that $P_t u \in C_0(E)$ for all $t \ge 0$ and $(P_t)_{t\ge 0}$ is strongly continuous. Let us extend the semigroup by setting $P_t = I$ for all $t \le 0$, in such a way that $(P_t)_{t\in\mathbb{R}}$ is still a strongly continuous family of operators such that $P_t u \in C_0(E)$ for all $t \in \mathbb{R}$. Fix $\varepsilon > 0$. For all $t \in [0,T]$ let K(t) be a compact set such that $\sup_{x \notin K(t)} |P_t u(x)| < \frac{\varepsilon}{2}$. Since $P_{t+h}u$ uniformly converges towards $P_t u$ as $h \to 0$, we know that there exists $\delta(t) > 0$ such that for any $s \in (t - \delta(t), t + \delta(t)) =: I(t)$ it holds $\sup_{x \notin K(t)} |P_s u(x) - P_t u(x)| < \frac{\varepsilon}{2}$. As a consequence, in particular, $\sup_{x \notin K(t)} |P_s u(x)| < \varepsilon$. Now notice that $\bigcup_{t \in [0,T]} I(t) \supset [0,T]$, where the latter is a compact subset of \mathbb{R} , thus $\{I(t)\}_{t \in [0,T]}$ is an open covering of [0,T]. Hence, we can extract a finite number of such open sets $I(t_1), \ldots, I(t_N)$ such that $[0,T] \subset \bigcup_{i=1}^N I(t_i)$.

Let $K = \bigcup_{i=1}^{N} K(t_i)$, which is a compact set since it is a finite union of compact sets. Let $s \in [0, T]$. Then there exists i = 1, ..., N such that $s \in I(t_i)$ and then

$$\sup_{x \notin K} |P_s u(x)| \le \sup_{x \notin K(t_i)} |P_s u(x)| < \varepsilon.$$

We have shown that, for all $s \in [0, T]$,

$$\sup_{x \notin K} |P_s u(x)| < \varepsilon$$

Hence, by (5.20) we get

$$\sup_{x \notin K} |q(t,x)| \le \int_0^t \overline{\nu}_\phi(t-s) u^\phi(s) \sup_{x \notin K} |P_s u(x)| \, ds < \varepsilon \int_0^t \overline{\nu}_\phi(t-s) u^\phi(s) \, ds = \varepsilon.$$

Since $\varepsilon > 0$ and T > 0 are arbitrary, we proved that $\lim_{x\to\infty} q(t,x) = 0$ locally uniformly with respect to $t \ge 0$. Now we need to prove that $q(t, \cdot) \in \mathsf{Dom}(G)$ and that (5.9) holds. Define

$$G_s=\frac{P_s-\mathbb{I}}{s},\ s>0,$$

where \mathbb{I} is the identity operator on $C_0(E)$. Setting $Q: \mathbb{R}_0^+ \to C_0(E)$ as $Q(t) = q(t, \cdot)$ for $t \in \mathbb{R}_0^+$, we have

$$Q(t) = \int_0^t P_\tau u \bar{\nu}_\phi(t-\tau) u^\phi(\tau) d\tau$$

Thus,

$$G_{s}Q(t) = G_{s} \int_{0}^{t} P_{\tau} u \,\bar{\nu}_{\phi}(t-\tau) u^{\phi}(\tau) d\tau = \int_{0}^{t} G_{s} P_{\tau} u \,\bar{\nu}_{\phi}(t-\tau) u^{\phi}(\tau) d\tau = \int_{0}^{t} P_{\tau} G_{s} u \,\bar{\nu}_{\phi}(t-\tau) u^{\phi}(\tau) d\tau,$$
(5.12)

where we used [1, Proposition 1.1.6] and the fact that G_s and P_{τ} commute on $\mathsf{Dom}(G)$. Now, since $u \in \mathsf{Dom}(G)$, we have (see definition 2.8)

$$G_s u = \frac{1}{s} \int_0^s P_w G u dw$$

and in particular $||G_s u||_{C(E)} \leq ||Gu||_{C(E)}$. Furthermore, since P_{τ} is contractive, we have

$$\|P_{\tau}G_{s}u\,\bar{\nu}_{\phi}(t-\tau)u^{\phi}(\tau)\|_{C(E)} \leq \bar{\nu}_{\phi}(t-\tau)u^{\phi}(\tau)\,\|Gu\|_{C(E)}$$

where the right-hand side is integrable in [0, t] and independent of s. Hence, taking the limit as $s \to 0$ in (5.12), using the dominated convergence theorem for Bochner integrals [1, Theorem 1.1.8] and the fact that P_{τ} is continuous, we get

$$\lim_{s \to 0} G_s Q(t) = \int_0^t P_\tau G u \,\bar{\nu}_\phi(t-\tau) u^\phi(\tau) d\tau,$$

i.e. $q(t, \cdot) \in \mathsf{Dom}(G)$ for all $t \ge 0$ and

$$Gq(t,\cdot) = \int_0^t P_\tau Gu(\cdot) \,\bar{\nu}_\phi(t-\tau) u^\phi(\tau) d\tau$$

Finally, again by Bochner theorem, the contractivity of P_{τ} and the fact that $(\bar{\nu}_{\phi}, u^{\phi})$ is a Sonine pair, we have

$$|Gq(t, \cdot)||_{C(E)} \le ||Gu||_{C(E)}.$$

Since $q(t, \cdot) \in \mathsf{Dom}(G)$, one has $Gq(t, \cdot) \in C_0(E)$. Hence, we get the following corollary, which guarantees that Items (ii) of Theorem 3.2 and (ii) of Theorem 3.3 hold.

Corollary 5.7. Under the assumptions of Theorem 5.2 we have, for all $(t, x) \in \mathbb{R}^+ \times E$

$$\int_{0}^{t} \|P_{s}q(t,\cdot) - q(t,\cdot)\|_{C(E)} \ \nu_{\phi}(ds) \leq \|Gu\|_{C(E)} \ \mathcal{J}_{\phi}(t)$$

where $\mathcal{J}_{\phi}(t) = \int_{0}^{t} s \nu_{\phi}(ds)$ and, for all $\lambda > 0$ and $x \in E$,

$$\int_{0}^{+\infty} e^{-\lambda t} \int_{0}^{t} \|P_{s}q(t,\cdot) - q(t,\cdot)\|_{C(E)} \ \nu_{\phi}(ds) \, dt < \infty$$

Proof. Since $q(t, \cdot) \in \mathsf{Dom}(G) \subset C_0(E)$, we have

$$P_{s}q(t,x) - q(t,x) = \int_{0}^{s} GP_{\tau}q(t,x) \, d\tau = \int_{0}^{s} P_{\tau}Gq(t,x) \, d\tau.$$

Taking the absolute value, using again the fact that P_{τ} is non-expansive, positivity preserving and sub-Markov,

$$|P_{s}q(t,x) - q(t,x)| \leq \int_{0}^{s} |P_{\tau}Gq(t,x)| d\tau \leq \int_{0}^{s} P_{\tau} |Gq(t,x)| d\tau \leq ||Gq(t,\cdot)||_{C(E)} s \leq ||Gu||_{C(E)} s.$$
(5.13)

Hence, taking the supremum and then integrating,

$$\int_0^t \|P_s q(t, \cdot) - q(t, \cdot)\|_{C(E)} \ \nu_\phi(ds) \le \|Gu\|_{C(E)} \ \mathcal{J}_\phi(t)$$

and it follows by (2.7), that $\int_0^{+\infty} e^{-\lambda t} \mathcal{J}_{\phi}(t) dt < \infty$ for all $\lambda > 0$.

Next, we need to show that Item (iii) of Theorem 3.3 holds. Next proposition follows once we observe that $|q(t,x)| \le ||u||_{C(E)}$ for all $t \ge 0$ and $x \in E$.

Proposition 5.8. Under the hypotheses of Theorem 5.2 the following inequality holds, for all $\lambda > 0$ and $x \in E$

$$\int_{0}^{+\infty} e^{-\lambda t} \overline{\nu}_{\phi}(t) q(t, x) dt \leq \frac{\phi(\lambda)}{\lambda} \|u\|_{C(E)}.$$

5.2. Proof of Theorem 5.2.

Proof. First, notice that, by the discussion in Subsection 5.1, we know that we are under the hypotheses of Theorems 3.2 and 3.3. Hence, observe that by Theorem 3.2, $\phi(\partial_t - G)q(t, x)$ is well-defined for all $x \in E$ and t > 0. Furthermore, by Theorem 3.3, we know that for all $x \in E$ the function $\phi(\partial_t - G)q(\cdot, x)$ is Laplace transformable for any $\lambda > 0$. Consider that q(0, x) = u(x) by definition. Next, observe that, for $\lambda > 0$

$$\int_0^\infty e^{-\lambda t} \overline{\nu}_\phi(t) q(0, x) dt = \frac{\phi(\lambda)}{\lambda} q(0, x).$$

We want to prove that for all $x \in E$

$$\int_0^\infty e^{-\lambda t} \phi(\partial_t - G) q(t, x) dt = \frac{\phi(\lambda)}{\lambda} q(0, x)$$

For this, first observe that by Theorem 3.3 we have

$$\int_{0}^{\infty} e^{-\lambda t} \phi(\partial_{t} - G) q(t, x) dt = -\int_{0}^{\infty} \int_{0}^{\infty} e^{-\lambda t} (P_{s}q(t - s, x) \mathbb{1}_{[0,t]}(s) - q(t, x)) dt \,\nu_{\phi}(ds).$$

23

Set Q as in the proof of Proposition 5.6. Then we have

$$\begin{split} \int_0^\infty e^{-\lambda t} P_s Q(t-s) \mathbbm{1}_{[0,t]}(s) dt &= P_s \int_0^\infty e^{-\lambda t} Q(t-s) \mathbbm{1}_{[s,+\infty)}(t) dt \\ &= P_s \int_s^\infty e^{-\lambda t} Q(t-s) dt \\ &= e^{-\lambda s} P_s \int_0^\infty e^{-\lambda t} Q(t) dt := e^{-\lambda s} P_s \widetilde{Q}(\lambda), \end{split}$$

where the first equality is due to the fact that P_s does not depend on t and that $s \in [0, t]$ is equivalent to $t \in [s, \infty)$ and where all the integrals are Bochner integrals on $C_0(E)$. Hence, in particular, the equality holds for all $x \in E$ and then we get

$$\int_0^\infty e^{-\lambda t} P_s q(t-s,x) \mathbb{1}_{[0,t]}(s) dt = e^{-\lambda s} P_s \widetilde{q}(\lambda,x),$$

where $\widetilde{q}(\lambda,x)=\int_{0}^{\infty}e^{-\lambda t}q(t,x)dt.$ This implies

$$\int_{0}^{\infty} e^{-\lambda t} \phi(\partial_t - G)q(t, x)dt = -\int_{0}^{\infty} \left(e^{-\lambda s} P_s \widetilde{q}(\lambda, x) - \widetilde{q}(\lambda, x) \right) \nu_{\phi}(ds).$$
(5.14)

Now we need to evaluate $\tilde{q}(\lambda, x)$. First, we use Fubini's theorem to write

$$\widetilde{q}(\lambda, x) = \mathbb{E}^{(x,0)} \left[\int_0^{+\infty} e^{-\lambda t} u(X(t)) dt \right].$$

Then, we recall that S performs at most countably many jumps that are a.s. dense in $[0, +\infty)$ and it increases continuously on a set with Lebesgue measure zero (see [57, Chapter 4, Section 21]) and also that H(t) = S(y-) for any $t \in (S(y-), S(y)]$, so that

$$\begin{split} \widetilde{q}(\lambda, x) &= \mathbb{E}^{(x,0)} \left[\sum_{y \ge 0} \int_{S(y-)}^{S(y)} e^{-\lambda t} u(M(S(y-))) dt \right] \\ &= \mathbb{E}^{(x,0)} \left[\sum_{y \ge 0} \frac{e^{-\lambda S(y-)} - e^{-\lambda S(y)}}{\lambda} u(M(S(y-))) \right] \\ &= \frac{1}{\lambda} \mathbb{E}^{(x,0)} \left[\sum_{y \ge 0} e^{-\lambda S(y-)} (1 - e^{-\lambda (S(y) - S(y-))}) u(M(S(y-))) \right] \end{split}$$

Now observe that all the previous argument can be applied to $u_{\pm}(x) = \max\{0, \pm u(x)\}$, so that

$$\frac{1}{\lambda} \mathbb{E}^{(x,0)} \left[\sum_{y \ge 0} e^{-\lambda S(y-)} (1 - e^{-\lambda (S(y) - S(y-))}) u_{\pm}(M(S(y-))) \right]$$
$$= \int_{0}^{+\infty} e^{-\lambda t} \mathbb{E}^{x} [u_{\pm}(X(t))] dt < \infty.$$
(5.15)

Consider the $C_{\rm b}(\mathbb{R}^+_0)$ -valued stochastic processes: $Z_{\pm} := \{Z_{\pm}(y), y \ge 0\}$ defined, for all $y, z \ge 0$, as

$$Z_{\pm}(y)(z) = u_{\pm}(M(S(y-)))e^{-\lambda S(y-)}(1-e^{-\lambda z})$$

Notice that Z_{\pm} is left-continuous, i.e. for all y > 0 and $y_n \uparrow y$ it holds

$$||Z_{\pm}(y_n) - Z_{\pm}(y)||_{C(E)} \le |u_{\pm}(M(S(y_{-})))e^{-\lambda S(y_{-})} - u_{\pm}(M(S(y_n_{-})))e^{-\lambda S(y_{n-})}| \to 0$$

as $n \to \infty$, hence it is a predictable process Furthermore, observe that $\mathfrak{p} = {\mathfrak{p}(y), y \ge 0}$ with $\mathfrak{p}(y) = S(y) - S(y-)$ is a Poisson point process of intensity ν_{ϕ} . Hence, by the compensation formula (see [12, Page 7]), we get

$$\begin{split} &\frac{1}{\lambda} \mathbb{E}^{(x,0)} \left[\sum_{y \ge 0} e^{-\lambda S(y-)} (1 - e^{-\lambda (S(y) - S(y-))}) u_{\pm}(M(S(y-))) \right] \\ &= \frac{1}{\lambda} \mathbb{E}^{(x,0)} \left[\int_{0}^{+\infty} \left(\int_{0}^{+\infty} (1 - e^{-\lambda w}) \nu_{\phi}(dw) \right) u_{\pm}(M(S(y-))) e^{-\lambda S(y-)} dy \right] \\ &= \frac{\phi(\lambda)}{\lambda} \mathbb{E}^{(x,0)} \left[\int_{0}^{+\infty} u_{\pm}(M(S(y-))) e^{-\lambda S(y-)} dy \right] \\ &= \frac{\phi(\lambda)}{\lambda} \int_{0}^{+\infty} \mathbb{E}^{(x,0)} \left[u_{\pm}(M(S(y-))) e^{-\lambda S(y-)} \right] dy \\ &= \frac{\phi(\lambda)}{\lambda} \int_{0}^{+\infty} \mathbb{E}^{(x,0)} \left[u_{\pm}(M(S(y))) e^{-\lambda S(y)} \right] dy, \end{split}$$

where in the last equality we used the fact that S is stochastically continuous and independent of M. Since the left-hand side of the previous equality is finite, so it is the right-hand side. Hence, subtracting term to term and recalling that $u(x) = u_+(x) - u_-(x)$, we get

$$\widetilde{q}(\lambda, x) = \frac{1}{\lambda} \mathbb{E}^{(x,0)} \left[\sum_{y \ge 0} e^{-\lambda S(y-)} (1 - e^{-\lambda (S(y) - S(y-))}) u(M(S(y-))) \right]$$
$$= \frac{\phi(\lambda)}{\lambda} \int_0^{+\infty} \mathbb{E}^{(x,0)} \left[u(M(S(y))) e^{-\lambda S(y)} \right] dy$$
$$= \frac{\phi(\lambda)}{\lambda} \int_0^{+\infty} \int_0^{+\infty} e^{-\lambda \tau} \mathbb{E}^{(x,0)} \left[u(M(\tau)) \right] g_S(\tau; y) d\tau \, dy,$$

where $g_S(\tau; y) d\tau$ is the law of S(y) under $\mathbb{P}^{(x,0)}$ and we used the independence of M and S. Substituting this equality into (5.14) we get

$$\int_0^\infty e^{-\lambda t} \phi(\partial_t - G) q(t, x) dt$$

= $-\frac{\phi(\lambda)}{\lambda} \int_0^\infty \left[e^{-\lambda s} P_s \left(\int_0^{+\infty} \int_0^{+\infty} e^{-\lambda \tau} \mathbb{E}^{(\cdot, 0)} \left[u(M(\tau)) \right] g_S(\tau; y) d\tau \, dy \right) (x)$
- $\int_0^{+\infty} \int_0^{+\infty} e^{-\lambda \tau} \mathbb{E}^{(x, 0)} \left[u(M(\tau)) \right] g_S(\tau; y) d\tau \, dy \right] \nu_\phi(ds).$

Now observe that

$$\int_0^{+\infty} \int_0^{+\infty} e^{-\lambda\tau} \left\| \mathbb{E}^{(\cdot,0)}[u(M(\tau))] \right\|_{C(E)} g_S(\tau;y) d\tau \, dy$$

$$\leq \|u\|_{C(E)} \int_{0}^{+\infty} \int_{0}^{+\infty} e^{-\lambda\tau} g_{S}(\tau; y) d\tau \, dy = \|u\|_{C(E)} \int_{0}^{+\infty} e^{-y\phi(\lambda)} dy = \frac{\|u\|_{C(E)}}{\phi(\lambda)} < \infty,$$

hence, by [1, Proposition 1.1.6] and recalling that Bochner integrability in $C_0(E)$ implies Lebesgue integrability for fixed $x \in E$, we have

$$\int_{0}^{\infty} e^{-\lambda t} \phi(\partial_{t} - G)q(t, x)dt$$

$$= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \left(e^{-\lambda(s+\tau)} P_{s} \mathbb{E}^{(\cdot,0)} \left[u(M(\tau)) \right] \right) (x)$$

$$- e^{-\lambda \tau} \mathbb{E}^{(x,0)} \left[u(M(\tau)) \right] g_{S}(\tau; y)d\tau \, dy\nu_{\phi}(ds).$$
(5.16)

Next, we want to use Fubini theorem. To do this, we first observe that $\mathbb{E}^{(\cdot,0)}[u(M(\tau))] \in \mathsf{Dom}(G)$. Furthermore, the semigroup $\{\tilde{P}_s\}_{s\geq 0}$ where $\tilde{P}_s = e^{-\lambda s}P_s$ admits $G - \lambda I$ as generator, with domain $\mathsf{Dom}(G)$. Hence,

$$\begin{split} &\int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \left| e^{-\lambda(s+\tau)} P_{s} \mathbb{E}^{(\cdot,0)} \left[u(M(\tau)) \right](x) - e^{-\lambda\tau} \mathbb{E}^{(x,0)} \left[u(M(\tau)) \right] \right| g_{S}(\tau; y) d\tau \, dy \nu_{\phi}(ds) \\ &= \int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} e^{-\lambda\tau} \left| \int_{0}^{s} \tilde{P}_{w}(G - \lambda I) \mathbb{E}^{(\cdot,0)} \left[u(M(\tau)) \right](x) dw \right| g_{S}(\tau; y) d\tau \, dy \nu_{\phi}(ds) \\ &\leq \int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} e^{-\lambda\tau} \left| \tilde{P}_{w}(G - \lambda I) \mathbb{E}^{(\cdot,0)} \left[u(M(\tau)) \right] \right| dw \, g_{S}(\tau; y) d\tau \, dy \, \nu_{\phi}(ds) \\ &\leq \int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} e^{-\lambda\tau} \left\| \tilde{P}_{w}(G - \lambda I) \mathbb{E}^{(\cdot,0)} \left[u(M(\tau)) \right] \right\|_{C(E)} dw \, g_{S}(\tau; y) d\tau \, dy \, \nu_{\phi}(ds) \\ &\leq \int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} e^{-\lambda\tau} \left\| (G - \lambda I) \mathbb{E}^{(\cdot,0)} \left[u(M(\tau)) \right] \right\|_{C(E)} \left(\int_{0}^{s} e^{-\lambda w} dw \right) g_{S}(\tau; y) d\tau \, dy \, \nu_{\phi}(ds) \\ &\leq \frac{\|Gu\|_{C(E)} + \lambda \|u\|_{C(E)}}{\lambda} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} e^{-\lambda\tau} (1 - e^{-\lambda s}) g_{S}(\tau; y) d\tau \, dy \, \nu_{\phi}(ds) \\ &= \frac{\|Gu\|_{C(E)} + \lambda \|u\|_{C(E)}}{\lambda} < \infty. \end{split}$$

Hence, by Fubini theorem, changing the order of the integrals in (5.16), we have

$$\begin{split} \int_{0}^{\infty} e^{-\lambda t} \phi(\partial_{t} - G)q(t, x)dt \\ &= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} \int_{0}^{+\infty} \left(e^{-\lambda(s+\tau)} P_{s} \operatorname{\mathbb{E}}^{(\cdot,0)} \left[u(M(\tau)) \right] \right)(x) \\ &\quad - e^{-\lambda \tau} \operatorname{\mathbb{E}}^{(x,0)} \left[u(M(\tau)) \right] \right) \left(\int_{0}^{+\infty} g_{S}(\tau; y)dy \right) d\tau \nu_{\phi}(ds) \\ &= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} \int_{0}^{+\infty} \left(e^{-\lambda(s+\tau)} P_{s} \operatorname{\mathbb{E}}^{(\cdot,0)} \left[u(M(\tau)) \right] \right)(x) \\ &\quad - e^{-\lambda \tau} \operatorname{\mathbb{E}}^{(x,0)} \left[u(M(\tau)) \right] \right) u^{\phi}(\tau) d\tau \nu_{\phi}(ds), \end{split}$$

where we used the relation $u^{\phi}(\tau) = \int_{0}^{+\infty} g_{S}(\tau; y) dy$. Again, since $\mathbb{E}^{(\cdot, 0)}[u(M(\tau))] \in \mathsf{Dom}(G)$, we can write

$$\int_0^\infty e^{-\lambda t} \phi(\partial_t - G) q(t, x) dt$$
$$= -\frac{\phi(\lambda)}{\lambda} \int_0^\infty \int_0^{+\infty} \int_0^s e^{-\lambda(\tau+w)} (G-\lambda) P_w \mathbb{E}^{(\cdot,0)} \left[u(M(\tau)) \right](x) u^{\phi}(\tau) dw \, d\tau \nu_{\phi}(ds).$$

Next, we use again Fubini theorem and we get, by observing that s > w,

$$\int_{0}^{\infty} e^{-\lambda t} \phi(\partial_{t} - G)q(t, x)dt$$

$$= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} \int_{0}^{+\infty} \int_{w}^{\infty} e^{-\lambda(\tau+w)}(G-\lambda)P_{w} \mathbb{E}^{(\cdot,0)} \left[u(M(\tau))\right](x)u^{\phi}(\tau)\nu_{\phi}(ds) dw d\tau$$

$$= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} \int_{0}^{+\infty} e^{-\lambda(\tau+w)}(G-\lambda)P_{w} \mathbb{E}^{(\cdot,0)} \left[u(M(\tau))\right](x)u^{\phi}(\tau)\overline{\nu}_{\phi}(w) dw d\tau$$

$$= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} \int_{0}^{+\infty} e^{-\lambda(\tau+w)}(G-\lambda)P_{w+\tau}u(x) u^{\phi}(\tau)\overline{\nu}_{\phi}(w) dw d\tau.$$
(5.17)

Now we set $w + \tau = v$ in the inner integral so that (5.17) gives us (again, remember that $\tau \in [0, v]$)

$$\int_{0}^{\infty} e^{-\lambda t} \phi(\partial_{t} - G)q(t, x)dt$$

$$= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} \int_{\tau}^{+\infty} e^{-\lambda v} (G - \lambda) P_{v}u(x) u^{\phi}(\tau)\overline{\nu}_{\phi}(v - \tau) dv d\tau$$

$$= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} e^{-\lambda v} (G - \lambda) P_{v}u(x) \left(\int_{0}^{v} u^{\phi}(\tau)\overline{\nu}_{\phi}(v - \tau) d\tau\right) dv$$

$$= -\frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} e^{-\lambda v} (G - \lambda) P_{v}u(x) dv$$

$$= \frac{\phi(\lambda)}{\lambda} \int_{0}^{\infty} e^{-\lambda v} P_{v}(\lambda - G)u(x) dv$$

$$= \frac{\phi(\lambda)}{\lambda} u(x), \qquad (5.18)$$

where we used the fact that u^{ϕ} and $\overline{\nu}_{\phi}$ constitute a Sonine pair, P_v and G commute on $\mathsf{Dom}(G)$ and

$$\int_0^\infty e^{-\lambda v} P_v dv = (\lambda I - G)^{-1}.$$

Taking the inverse Laplace transform we get that, for all $x \in E$, there exists $I_x \subset \mathbb{R}^+$, with Lebesgue measure zero, such that for $t \notin I_x$ it holds

$$\phi(\partial_t - G)q(t, x) = \overline{\nu}_\phi(t)u(x).$$

Now we need to show that $I_x = \emptyset$ for all $x \in E$. To this purpose, first denote by $\mathcal{R} = \overline{\{S(t), t \ge 0\}}$ the topological closure of the range of S. Since H can only jump when $t \in \mathcal{R}$ and it is isolated on the left,

$$\mathbb{P}^{(x,0)}(H(t) \neq H(t+)) \le \mathbb{P}^{(x,0)}(t \in \mathcal{R}) = 0$$
(5.19)

by [13, Proposition 1.9], since $\phi \in \mathfrak{SB}_0$. Once this has been established, notice that one can rewrite, given that H and M are independent,

$$\begin{split} q(t,x) &= \mathbb{E}^{(x,0)}[u(M(H(t))] = \mathbb{E}^{(x,0)} \left[\mathbb{E}^{(x,0)} \left[u(M(H(t)) \mid H(t)] \right] \\ &= \mathbb{E}^{(x,0)} \left[P_{H(t)} u(x) \right] = \int_0^t P_s u(x) \overline{\nu}_{\phi}(t-s) u^{\phi}(s) \, ds. \end{split}$$

Notice, however, that for any two fixed $x_0, x \in E$ it holds

$$q(t,x) = \int_0^t P_s u(x) \overline{\nu}_\phi(t-s) u^\phi(s) \, ds = \mathbb{E}^{(x_0,0)} \left[P_{H(t)} u(x) \right].$$
(5.20)

Fix $t \in \mathbb{R}_0^+$ and let $t_n \to t$. Then it holds

$$\|q(t_n, \cdot) - q(t, \cdot)\|_{C(E)} \le \mathbb{E}^{(x_0, 0)} \left[\|P_{H(t_n)}u - P_{H(t)}u\|_{C(E)} \right]$$

Notice that $\lim_{n\to\infty} \|P_{H(t_n)}u - P_{H(t)}u\|_{C(E)} = 0$ almost surely by (5.19) and the strong continuity of $(P_t)_{t\geq 0}$. Furthermore, $\|P_{H(t_n)}u - P_{H(t)}u\|_{C(E)} \leq 2 \|u\|_{C(E)}$. Hence, by the dominated convergence theorem,

$$\lim_{n \to \infty} \|q(t_n, \cdot) - q(t, \cdot)\|_{C(E)} = 0.$$
(5.21)

In particular, this shows that q is continuous in both variables. Next, fix $t \in \mathbb{R}^+$ and consider a sequence $t_n \downarrow t$. Then we have for all $x \in E$

$$\begin{aligned} |\phi(\partial_t - G)q(t_n, x) - \phi(\partial_t - G)q(t, x)| \\ &\leq \int_0^t |P_s q(t - s, x) - q(t, x) - P_s q(t_n - s, x)) + q(t_n, x)|\nu_\phi(ds) \\ &+ \int_t^{t_n} |P_s q(t_n - s, x) - q(t_n, x)|\nu_\phi(ds) \\ &+ |q(t, x)|(\overline{\nu}_\phi(t) - \overline{\nu}_\phi(t_n)) + |q(t, x) - q(t_n, x)|\overline{\nu}_\phi(t_n). \end{aligned}$$

Taking the supremum over $x \in E$, this leads to

$$\begin{split} \|\phi(\partial_t - G)q(t_n, \cdot) - \phi(\partial_t - G)q(t, \cdot)\|_{C(E)} \\ &\leq \int_0^t \|P_s q(t - s, \cdot) - q(t, \cdot) - P_s q(t_n - s, \cdot)) + q(t_n, \cdot)\|_{C(E)} \nu_\phi(ds) \\ &\quad + \int_t^{t_n} \|P_s q(t_n - s, \cdot) - q(t_n, \cdot)\|_{C(E)} \nu_\phi(ds) \\ &\quad + \|q(t, \cdot)\|_{C(E)} \left(\overline{\nu}_\phi(t) - \overline{\nu}_\phi(t_n)\right) + \|q(t, \cdot) - q(t_n, \cdot)\|_{C(E)} \overline{\nu}_\phi(t_n) \\ &:= I_n + J_n + \|q(t, \cdot)\|_{C(E)} \left(\overline{\nu}_\phi(t) - \overline{\nu}_\phi(t_n)\right) + \|q(t, \cdot) - q(t_n, \cdot)\|_{C(E)} \overline{\nu}_\phi(t_n). \end{split}$$

Concerning I_n , first notice that

$$\begin{aligned} \|P_s q(t-s,\cdot) - q(t,\cdot) - P_s q(t_n-s,\cdot)) + q(t_n,\cdot)\|_{C(E)} \\ &\leq \|P_s(q(t-s,\cdot) - q(t_n-s,\cdot))\|_{C(E)} + \|q(t,\cdot) - q(t_n,\cdot)\|_{C(E)} \\ &\leq \|q(t-s,\cdot) - q(t_n-s,\cdot)\|_{C(E)} + \|q(t,\cdot) - q(t_n,\cdot)\|_{C(E)} \,, \end{aligned}$$

since P_s is non-expansive. Hence, taking the limit as $n \to \infty$ and using (5.21) we have

$$\lim_{n \to \infty} \|P_s q(t-s, \cdot) - q(t, \cdot) - P_s q(t_n - s, \cdot)) + q(t_n, \cdot)\|_{C(E)} = 0.$$

Furthermore,

$$\begin{aligned} \|P_{s}q(t-s,\cdot)-q(t,\cdot)-P_{s}q(t_{n}-s,\cdot)+q(t_{n},\cdot)\|_{C(E)} \\ &\leq \|P_{s}q(t-s,\cdot)-P_{s}q(t,\cdot)\|_{C(E)}+\|P_{s}q(t,\cdot)-q(t,\cdot)\|_{C(E)} \\ &+\|P_{s}q(t_{n}-s,\cdot)-P_{s}q(t_{n},\cdot)\|_{C(E)}+\|P_{s}q(t_{n},\cdot)-q(t_{n},\cdot)\|_{C(E)} \\ &\leq 2C\left(\|Gu\|_{C(E)}+\|u\|_{C(E)}\right)\int_{0}^{s}u^{\phi}(t-\tau)d\tau+2\|Gu\|_{C(E)}s,\end{aligned}$$

where we used (5.8), (5.13) and the fact that $u^{\phi}(t_n - \tau) \leq u^{\phi}(t - \tau)$ since u^{ϕ} is non-increasing. The righthand side of the previous inequality is integrable against $\nu_{\phi}(ds)$, hence we can use the dominated convergence theorem to achieve

$$\lim_{n \to \infty} I_n = 0$$

Concerning J_n instead, we have

$$\begin{aligned} \|P_s q(t_n - s, \cdot) - q(t_n, \cdot)\|_{C(E)} \\ &\leq \|P_s q(t_n - s, \cdot) - P_s q(t_n, \cdot)\|_{C(E)} + \|P_s q(t_n, \cdot) - q(t_n, \cdot)\|_{C(E)} \\ &\leq C \left(\|Gu\|_{C(E)} + \|u\|_{C(E)} \right) \int_0^s u^{\phi}(t^n - \tau) d\tau + \|Gu\|_{C(E)} s, \end{aligned}$$

where we used again (5.8) and (5.13). Hence

$$J_{n} \leq C \left(\|Gu\|_{C(E)} + \|u\|_{C(E)} \right) \int_{t}^{t_{n}} \int_{0}^{s} u^{\phi}(t^{n} - \tau) d\tau \nu_{\phi}(ds) + \|Gu\|_{C(E)} \int_{t}^{t_{n}} s\nu_{\phi}(ds)$$
$$= C \left(\|Gu\|_{C(E)} + \|u\|_{C(E)} \right) J_{n}^{1} + \|Gu\|_{C(E)} \left(\mathcal{J}_{\phi}(t_{n}) - \mathcal{J}_{\phi}(t) \right).$$

By (2.7), it turns out that \mathcal{J}_{ϕ} is right-continuous. Furthermore

$$\begin{split} J_n^1 &= \int_t^{t_n} \int_0^t u^{\phi}(t^n - \tau) d\tau \nu_{\phi}(ds) + \int_t^{t_n} \int_t^s u^{\phi}(t^n - \tau) d\tau \nu_{\phi}(ds) \\ &= (\overline{\nu}_{\phi}(t) - \overline{\nu}_{\phi}(t_n)) \left(U^{\phi}(t_n) - U^{\phi}(t_n - t) \right) \\ &+ \int_t^{t_n} u^{\phi}(t_n - \tau) (\overline{\nu}_{\phi}(\tau) - \overline{\nu}_{\phi}(t_n)) d\tau \\ &= (\overline{\nu}_{\phi}(t) - \overline{\nu}_{\phi}(t_n)) \left(U^{\phi}(t_n) - U^{\phi}(t_n - t) \right) \\ &+ \int_t^{t_n} u^{\phi}(t_n - \tau) \overline{\nu}_{\phi}(\tau) d\tau - \overline{\nu}_{\phi}(t_n) U^{\phi}(t_n - t) \\ &\leq (\overline{\nu}_{\phi}(t) - \overline{\nu}_{\phi}(t_n)) \left(U^{\phi}(t_n) - U^{\phi}(t_n - t) \right) \\ &+ \overline{\nu}_{\phi}(t) U^{\phi}(t_n - t) - \overline{\nu}_{\phi}(t_n) U^{\phi}(t_n - t) \\ &= (\overline{\nu}_{\phi}(t) - \overline{\nu}_{\phi}(t_n)) U^{\phi}(t_n), \end{split}$$

hence, since $\overline{\nu}_{\phi}$ is also right-continuous, $\lim_{n\to\infty} J_n^1 = 0$, thus $\lim_{n\to\infty} J_n = 0$. This proves that

$$\lim_{n \to \infty} \|\phi(\partial_t - G)q(t_n, \cdot) - \phi(\partial_t - G)q(t, \cdot)\|_{C(E)} = 0.$$
(5.22)

Now fix $x \in E$ and assume, by contradiction, that $I_x \neq \emptyset$. Let $t \in I_x$ and consider any interval of the form $[t, t+\delta]$ for some $\delta > 0$. Let $I_x^{\delta} = I_x \cap [t, t+\delta]$ and observe that $|I_x^{\delta}| = 0$, hence $|[t, t+\delta] \setminus I_x^{\delta}| = \delta = |[t, t+\delta]|$. Since the Lebesgue measure has full topological support (i.e., any non-empty open set has positive measure),

then $[t, t + \delta] \setminus I_x^{\delta}$ is dense in $[t, t + \delta]$ and there exists a sequence $t_n \downarrow t$ such that $t_n \notin I_x$ for all $n \in \mathbb{N}$. For such a sequence

$$\phi(\partial_t - G)q(t_n, x) = \overline{\nu}_\phi(t_n)q(t_n, x).$$

However, taking the limit as $n \to \infty$, using (5.21), (5.22) and the fact that $\overline{\nu}_{\phi}$ is right-continuous, we get

$$\phi(\partial_t - G)q(t, x) = \overline{\nu}_\phi(t)q(t, x),$$

that is absurd since $t \in I_x$. Hence $I_x = \emptyset$ and, since $x \in E$ is arbitrary, this shows that

$$\phi(\partial_t - G)q(t, x) = \overline{\nu}_\phi(t)q(t, x), \quad \forall (t, x) \in \mathbb{R}^+ \times E.$$
(5.23)

Combining the latter with the fact that $\lim_{x\to\infty} q(t,x) = 0$ locally uniformly with respect to $t \ge 0$ as shown in Proposition 5.6, we finally have that q is solution of (5.1).

It remains to show that this is the unique solution. Indeed, let q_1 be another solution of (5.1). Then $w = q - q_1$ solves (5.1) with $u \equiv 0$. Now let T > 0 and assume, by contradiction, that $\varepsilon = \sup_{(t,x) \in [0,T] \times E} |w(t,x)| > 0$. Let $K \subset E$ be such that

$$\sup_{x \notin K} |w(t,x)| < \varepsilon, \ \forall t \in [0,T].$$

Then, since w is continuous,

$$\varepsilon = \max_{(t,x) \in [0,T] \times K} |w(t,x)|.$$

Let $(t_{\star}, x_{\star}) \in [0, T] \times K$ be such that $|w(t_{\star}, x_{\star})| = \varepsilon$. If $w(t_{\star}, x_{\star}) = \varepsilon$, then $w(t_{\star}, x_{\star}) \ge w(t, x)$ for all $(t, x) \in (0, t_{\star}] \times E$ and $w(t_{\star}, x_{\star}) = \varepsilon > 0 = w(0, x)$ for all $x \in E$. Hence, by Proposition 3.5 we have

$$0 = -\phi(\partial_t - G)w(t_\star, x_\star) < 0$$

which is a contradiction. The same holds if $w(t_{\star}, x_{\star}) = -\varepsilon$. Hence $w \equiv 0$ and this ends the proof.

5.3. Another uniqueness criterion. Before moving to option pricing, we give a further result concerning the uniqueness of the solution to our non-local problem.

Proposition 5.9. Let $q : \mathbb{R}_0^+ \times E \to \mathbb{R}$ be a function such that $q(t, \cdot) \in \text{Dom}(G)$ for all $t \ge 0$ and $t \in \mathbb{R}_0^+ \mapsto q(t, \cdot) \in C_0(E)$ is measurable. Assume further that there exists $\lambda_* > 0$ such that:

• The function

$$\widetilde{q}(\lambda,x) = \int_0^\infty e^{-\lambda t} q(t,x) dt$$

is well-defined for all $x \in E$ and $\lambda > \lambda_{\star}$

• It holds

$$\|\widetilde{q}\|_{C(E)} \leq \int_0^\infty e^{-\lambda_\star t} \|q(t,\cdot)\|_{C(E)} \, dt < \infty.$$

- For all $x \in E$ there exists $\mathcal{I}_x \subset \mathbb{R}_0^+$ such that $|\mathcal{I}_x| = 0$ and $\phi(\partial_t G)q(t, x)$ is well-defined for all $t \in \mathbb{R}_0^+ \setminus \mathcal{I}_x$.
- For all $x \in E$ and $\lambda > \lambda_{\star}$ it holds

$$\int_{0}^{\infty} e^{-\lambda t} \phi(\partial_{t} - G)q(t, x)dt = -\int_{0}^{\infty} \int_{0}^{\infty} e^{-\lambda t} (P_{s}q(t - s, x)\mathbb{1}_{(0, t]}(s) - q(t, x))dt \,\nu_{\phi}(ds)$$
(5.24)

• For all $x \in E$ and $t \in \mathbb{R}_0^+ \setminus \mathcal{I}_x$ it holds

$$\phi(\partial_t - G)q(t, x) = \overline{\nu}_{\phi}(t)q(0, x), \quad \text{for almost all } t > 0.$$
(5.25)

Then, for almost all $t \in \mathbb{R}_0^+$ it holds

$$\left\|q(t,\cdot) - \mathbb{E}^{(\cdot,0)}[q(0,X(t))]\right\|_{C(E)} = 0$$

Proof. Since $q(0, \cdot) \in \mathsf{Dom}(\mathsf{G})$, arguing as in the proof of Theorem 5.2, we know that the function $q_{\star}(t,x) = \mathbb{E}^{(x,0)}[q(0,X(t))]$ satisfies all the assumptions in the statement. As a consequence, also the function $q - q_{\star}$ satisfies all the assumptions in the statement. Hence, without loss of generality, we can assume that $q(0, \cdot) \equiv 0$. Integrating (5.25) against $e^{-\lambda t}$ for $\lambda > \lambda_{\star}$ and using (5.24) we get

$$\int_0^\infty \int_0^\infty e^{-\lambda t} (P_s q(t-s, x_\star) \mathbb{1}_{(0,t]}(s) - q(t, x)) dt \,\nu_\phi(ds) = 0.$$
(5.26)

Next, notice that

$$\int_{0}^{\infty} e^{-\lambda t} P_{s} q(t-s,x) \mathbb{1}_{(0,t]}(s) dt = e^{-\lambda s} \int_{0}^{\infty} P_{s} \left(e^{-\lambda(t-s)} q(t-s,\cdot) \mathbb{1}_{(0,t]}(s) \right)(x) dt.$$
(5.27)

Now observe that

$$\int_{0}^{\infty} \left\| e^{-\lambda(t-s)} q(t-s,\cdot) \mathbb{1}_{(0,t]}(s) \right\|_{C(E)} dt = \int_{0}^{\infty} \left\| e^{-\lambda(t-s)} q(t-s,\cdot) \mathbb{1}_{\mathbb{R}_{0}^{+}}(t-s) \right\|_{C(E)} dt$$
$$= \int_{-s}^{\infty} \left\| e^{-\lambda\tau} q(\tau,\cdot) \mathbb{1}_{\mathbb{R}_{0}^{+}}(\tau) \right\|_{C(E)} d\tau$$
$$= \int_{0}^{\infty} e^{-\lambda\tau} \left\| q(\tau,\cdot) \right\|_{C(E)} d\tau < \infty.$$
(5.28)

Observing that, for fixed s > 0, also $t \in \mathbb{R}_0^+ \mapsto e^{-\lambda(t-s)}q(t-s,\cdot)\mathbb{1}_{(0,t]}(s) \in C_0(E)$ is measurable, we know by (5.28) and Bochner's theorem (see [1, Theorem 1.1.4]) that the latter is Bochner-integrable and then, by [1, Proposition 1.1.6] and (5.27), we have

$$\int_0^\infty e^{-\lambda t} P_s q(t-s,x) \mathbb{1}_{(0,t]}(s) dt$$
$$= e^{-\lambda s} P_s \left(\int_0^\infty e^{-\lambda(t-s)} q(t-s,\cdot) \mathbb{1}_{(0,t]}(s)(x) dt \right) = e^{-\lambda s} P_s \widetilde{q}(x) \quad (5.29)$$

and then (5.26) becomes

$$\int_0^\infty \left(e^{-\lambda s} P_s \widetilde{q}(x) - \widetilde{q}(x) \right) \nu_\phi(ds) = 0.$$
(5.30)

Now let $\widetilde{P}_s = e^{-\lambda s} P_s$ and notice that this is still a Feller semigroup with generator $G - \lambda I$, where I is the identity operator. In particular, by [1, Proposition 1.1.7], $\widetilde{q} \in \text{Dom}(G) \subset \text{Dom}(G - \lambda I)$. In particular, this implies that

$$e^{-\lambda s} P_s \widetilde{q}(x) - \widetilde{q}(x) = \int_0^s \widetilde{P}_\tau(G - \lambda I) \widetilde{q}(x) d\tau$$

Taking the norm we get

$$\begin{split} \left\| e^{-\lambda s} P_s \widetilde{q} - \widetilde{q} \right\|_{C(E)} &\leq \int_0^s \left\| \widetilde{P}_\tau (G - \lambda I) \widetilde{q} \right\|_{C(E)} d\tau \\ &\leq \frac{\| (G - \lambda I) \widetilde{q} \|_{C(E)}}{\lambda} (1 - e^{-\lambda s}). \end{split}$$

Integrating the right-hand side against $\nu_{\phi}(ds)$ we get

$$\int_0^\infty \left\| e^{-\lambda s} P_s \widetilde{q} - \widetilde{q} \right\|_{C(E)} \nu_\phi(ds) \le \frac{\| (G - \lambda I) \widetilde{q} \|_{C(E)}}{\lambda} \phi(\lambda)$$

Thus, we can rewrite (5.30) in terms of Bochner integrals as

$$\int_0^\infty \left(e^{-\lambda s} P_s \widetilde{q} - \widetilde{q} \right) \nu_\phi(ds) = 0.$$
(5.31)

Now consider the Feller semigroup $(P_s^{\phi})_{s\geq 0}$ acting on $f \in C_0(E)$ as

$$\widetilde{P}_s^{\phi} f = \int_0^{+\infty} \widetilde{P}_{\tau} f g_S(\tau; s) \, d\tau$$

and denote by $(-\phi(-(G - \lambda I)), \mathsf{Dom}(\phi(-(G - \lambda I))))$ its generator. By Phillips formula (see [63, Theorem 12.6]) we know that $\mathsf{Dom}(G - \lambda I) \subset \mathsf{Dom}(\phi(-(G - \lambda I)))$ and on $f \in \mathsf{Dom}(G - \lambda I)$ it holds

$$-\phi(-(G-\lambda I))f = -\int_0^\infty \left(e^{-\lambda_\star s} P_s f - f\right) \nu_\phi(ds).$$

Since $\widetilde{q} \in \mathsf{Dom}(G - \lambda I)$, we get by (5.31)

$$-\phi(-(G-\lambda I))\widetilde{q} = 0.$$
(5.32)

Finally, notice that for all $f \in \mathsf{Dom}(G - \lambda I)$ it holds

$$\left\|\widetilde{P}_{s}^{\phi}f\right\|_{C(E)} \leq \int_{0}^{+\infty} \left\|\widetilde{P}_{\tau}f\right\|_{C(E)} g_{S}(\tau;s) \, d\tau \leq e^{-s\phi(\lambda)} \left\|f\right\|_{C(E)},$$

where $\phi(\lambda) > 0$. Hence, by the Hille-Yosida Theorem (see [1, Theorems 3.3.2 and 3.3.4]) we know that 0 belongs to the resolvent set of $-\phi(\lambda I - G)$ and thus the operator is invertible. As a consequence, (5.32) implies

$$\widetilde{q}(\lambda, \cdot) \equiv 0.$$

By injectivity of the Laplace transform (see [1, Theorem 1.7.3]), this ends the proof.

Remark 5.10. Notice that the function q in Proposition 5.9 is not a solution of (3.3) in the sense of Definition 3.6. Indeed, on the one hand we are not requiring that q is a continuous function of (t, x), on the other hand q solves (3.3) not for all $(t, x) \in \mathbb{R}_0^+ \times E$ but only on a subset $\tilde{E} \subset \mathbb{R}_0^+ \times E$ such that for all $x \in E$ the set $\tilde{I}_x = \{t \in \mathbb{R}_0^+ : (t, x) \notin \tilde{E}\}$ satisfies $|\tilde{I}_x| = 0$. With an abuse of notation, we could refer to such a function q as an almost-everywhere (a.e.) solution of (3.3). From this point of view, Proposition 5.9 tells us that the solution provided in Theorem 5.2 is also the unique a.e. solution satisfying some additional conditions on the Laplace transform. Finally, notice that we are not requiring that $\lim_{x\to\infty} q(t, x) = 0$ locally uniformly with respect to $t \ge 0$.

6. Option pricing with the undershooting of the α -stable subordinator

In this section we deal with the model with dependent returns and trade durations (DRD) introduced in [39]. In [39, Theorem 6.2], an option pricing formula is obtained for such a model using Fourier methods. Here, we shall instead use the results of the previous sections, in particular Theorem 5.2, to derive a suitable final problem for a non-local pseudo-differential equation, in the same spirit as for the local Black and Scholes differential equation.

6.1. The price process. To describe the price process underlying our option-pricing method, we shall make use of the time-changed processes introduced in Section 4. Let *B* be a 1-dimensional Brownian motion and consider the process $M(t) = e^{B(t)}$. Consider *S* as in Section 4 and assume (B, S) is a canonical Feller process, on the canonical filtered probability space $(\Omega, \mathcal{F}_{\infty}, \{\mathcal{F}_t\}_{t\geq 0}, \mathbb{P}^{(x,v)})$. By Lemma 4.2 we know that (B^{ϕ}, S) is a Markov additive Feller process with respect to its augmented natural filtration $\mathcal{G} := \{\mathcal{G}_t\}_{t\geq 0}$. Now let $X_e(t) = B^{\phi}(L(t)-) = B(H(t))$ and consider the age process

$$\gamma(t) := t - S(0) - H(t). \tag{6.1}$$

Then, (X_e, γ) is a càglàd process. Furthermore, notice that by Phillip's theorem, since $C_c^{\infty}(\mathbb{R})$ is contained in the domain of the generator of (B, S), we know that $C_c^{\infty}(\mathbb{R})$ is a subset of the domain of the generator of (B^{ϕ}, S) . Hence, we can use the Courrége-Waldenfels theorem (see [15, Theorem 2.21]) to establish the jump-diffusion form of the generator of (B^{ϕ}, S) . Thus, we have the following result.

Theorem 6.1. For $t \ge 0$ set $\mathcal{H}_t = \mathcal{G}_{L(t)-}$. Then the process (X_e, γ) is a time-homogeneous Markov process with respect to the filtration $\mathcal{H} := \{\mathcal{H}_t\}_{t\ge 0}$.

Proof. The proof is exactly the same of the ones of [46, Theorems 3.2 and 4.1], with the only exception that since (B^{ϕ}, S) is not a canonical Feller process in our setting, one has to modify the translation operator accordingly. Precisely, in our case we just need to set $\theta_t \omega(s) = (\omega_1(s), \omega_2(s+t))$ for all $t, s \ge 0$. Indeed, for $s, t \ge 0$ and $\omega \in \Omega$

$$(B^{\phi}(\theta_{t}\omega,s),S(\theta_{t}\omega,s)) = ((B(\theta_{t}\omega),S(\theta_{t}\omega,s)),S(\theta_{t}\omega,s))$$
$$= (\omega_{1}(\omega_{2}(t+s)),\omega_{2}(t+s)) = (B^{\phi}(\omega,t+s),S(\omega,t+s)).$$

Now we set

$$X(t) = e^{X_{e}(t)} = M(H(t)) = M^{\phi}(L(t)).$$
(6.2)

 (X, γ) is still a time-homogeneous Markov process with respect to \mathcal{H} . Now define $\mathcal{N}_t^0 = \sigma((X_e(s), \gamma(s)), s \leq t)$ and \mathcal{N}_t its completion with respect to $\mathbb{P}^{(x,v)}$. $\mathcal{N} := \{\mathcal{N}_t^0\}_{t\geq 0}$ is the natural filtration of (X, γ) , as the latter is related to (X_e, γ) by means of a homeomorphism. Furthermore, since (X, γ) is \mathcal{H} -Markov, then $\mathcal{N}_t \subseteq \mathcal{H}_t$ for all $t \geq 0$ and both (X_e, γ) and (X, γ) are \mathcal{N} -Markov and time-homogeneous. Since we are going to work with càglàd processes, let us introduce now, for any T > 0, the space $D_-[0,T]$ of càglàd functions $f:[0,T] \to \mathbb{R}$ and $\Lambda_-[0,T]$ its subspace of non-decreasing and non-negative functions. As usual in this context, we need to introduce a new (family of) probability measures under which the process X is actually a \mathcal{N} -martingale. From now on, whenever it is not ambiguous, we shall denote by $X|_{[0,T]}$, $X_e|_{[0,T]}$, $\gamma|_{[0,T]}$ and $\mathcal{N}|_{[0,T]}$ the restriction of the considered quantities on the interval [0, T]. We need the following lemma.

Lemma 6.2. For any $m \in \mathbb{R}$ and $x, v \in \mathbb{R}$, the process

$$Z^{m}(t) := e^{mX_{e}(t) - \frac{m^{2}H(t)}{2}}$$

is a \mathcal{N} -martingale under $\mathbb{P}^{(x,v)}$.

Proof. Z^m is \mathcal{N} -adapted by definition. To show that $Z^m(t) \in L^1(\Omega; \mathbb{P}^{(x,v)})$ for all $t \geq 0$, just notice that

$$\mathbb{E}^{(x,v)}[Z^m(t)] = \mathbb{E}^{(x,v)}\left[\mathbb{E}^{(x,v)}\left[\mathcal{E}(mB)(H(t)) \mid H(t)\right]\right]$$

where

$$\mathcal{E}(mB)(\tau) = e^{mB(\tau) - \frac{m^2\tau}{2}}$$

is the Doleans-Dade exponential of mB. Since B and H are independent, we have

$$\mathbb{E}^{(x,v)}\left[\mathcal{E}(mB)(H(t)) \mid H(t)\right] = F_1(H(t)),$$

where

$$F_1(\tau) := \mathbb{E}^{(x,v)} \left[\mathcal{E}(mB)(\tau) \right] = \mathbb{E}^{(x,0)} \left[\mathcal{E}(mB)(\tau) \right] = e^x$$

Hence

$$\mathbb{E}^{(x,v)}[Z^m(t)] = e^x \int_0^{t-v} \overline{\nu}_{\Phi}(t-v-s)u^{\Phi}(s) \, ds = e^x < \infty.$$

To show the martingale property, fix $0 \le s \le t$ and consider two Borel sets $A_1, A_2 \subset D_{-}[0, s]$. Consider the event

$$A_{\star} := \{ X_{\mathbf{e}} \big|_{[0,s]} \in A_1 \} \cap \{ \gamma \big|_{[0,s]} \in A_2 \}.$$

Since B and H are independent and $\gamma(t) = t - v - H(t)$ for all $t \ge 0$, it holds

$$\mathbb{E}^{(x,v)}[Z^m(t)\mathbb{1}_{A_*}] = \mathbb{E}^{(x,v)}[\mathbb{1}_{A_2}(\gamma)F_2(H\big|_{[0,t]})],$$
(6.3)

where, for all $g \in \Lambda_{-}[0, t]$, we set

$$F_2(g) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_1}(B(g(\cdot))) \Big|_{[0,s]} \right) \mathcal{E}(mB)(g(t)) \right] \text{ and }$$

and we notice that

$$F_2(H|_{[0,t]}) = \mathbb{E}^{(x,v)}[Z^m(t)\mathbb{1}_{A_1}(X_e) \mid H(\tau), \ \tau \ge 0].$$

Notice in particular that $\mathcal{E}(mB)$ is the Doleans-Dade exponential of mB. Since $A_1 \subset D_{-}[0,s]$, the event $\{B(g(\cdot))|_{[0,s]} \in A_1\}$ belongs to $\sigma(B(w), w \leq g(s))$. Furthermore, once we recall that $\mathcal{E}(mB)$ is a martingale and $g(s) \leq g(t)$, we have

$$F_2(g) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_1}(B(g(\cdot))) \mathcal{E}(mB)(g(s)) \right] =: \widetilde{F}(g\big|_{[0,s]}).$$

However, we have that, still by independence between B and H

$$\widetilde{F}_{2}(H|_{[0,s]}) = \mathbb{E}^{(x,v)}[Z^{m}(s)\mathbb{1}_{A_{1}}(X_{e}) \mid H(\tau), \ \tau \geq 0].$$

Substituting it back into (6.3), we get

$$\mathbb{E}^{(x,v)}[Z^m(t)\mathbb{1}_{A_\star}] = \mathbb{E}^{(x,v)}[\mathbb{1}_{A_2}(\gamma)\widetilde{F}_2(H\big|_{[0,s]})] = \mathbb{E}^{(x,v)}[Z^m(s)\mathbb{1}_{A_\star}].$$
(6.4)
he form A_\star constitute a π -system generating \mathcal{N}_s , this ends the proof.

Since the events of the form A_{\star} constitute a π -system generating \mathcal{N}_s , this ends the proof.

From now on we set m = -1/2 and we write $Z := Z^{-\frac{1}{2}}$. Therefore we have

$$Z(t) = e^{-\frac{X_{e}(t)}{2} - \frac{H(t)}{8}}$$

For any T > 0 define the probability measure

$$\mathcal{N}_T \ni A \mapsto \widetilde{\mathbb{P}}_T^{(x,v)}(A) = e^{\frac{x}{2}} \mathbb{E}^{(x,v)} \left[Z(T) \mathbb{1}_A \right],$$

i.e., in terms of the Radon-Nykodim derivative:

$$\frac{d\widetilde{\mathbb{P}}_{T}^{(x,v)}}{d\mathbb{P}^{(x,v)}\big|_{\mathcal{N}_{T}}} = Z(T)$$

Since Z(T) is an \mathcal{N} -martingale, we have that $\widetilde{\mathbb{P}}_t^{(x,v)} = \widetilde{\mathbb{P}}_T^{(x,v)}\Big|_{\mathcal{N}_t}$ for all $T \ge 0$ and $t \in [0,T]$. This guarantees that we can use the Kolmogorov extension theorem to construct a probability measure $\widetilde{\mathbb{P}}^{(x,v)}$ on $(\Omega, \mathcal{N}_{\infty})$,

where $\mathcal{N}_{\infty} := \sigma \left(\bigcup_{t \ge 0} \mathcal{N}_t \right)$ such that $\tilde{\mathbb{P}}^{(x,v)} \Big|_{\mathcal{N}_t} = \tilde{\mathbb{P}}_t^{(x,v)}$ for all $t \ge 0$. The method of construction of such a measure is classical and we refer to [40, Page 192]. Furthermore, notice that since the Radon-Nykodim derivative is strictly positive, the measure $\tilde{\mathbb{P}}^{(x,v)}$ is equivalent to $\mathbb{P}^{(x,v)}$ when restricted on \mathcal{N}_t for any $t \ge 0$.

Now let us show that X defined in (6.2) is an \mathcal{N} -martingale under such a measure.

Proposition 6.3. For any $(x, v) \in \mathbb{R}^2$, the process X is an \mathcal{N} -martingale under $\widetilde{\mathbb{P}}^{(x,v)}$.

Proof. By definition X is \mathcal{N} -adapted. Now we show that for all $t \in [0, T]$ it is true that $X(t) \in L^1(\Omega; \widetilde{\mathbb{P}}^{(x,v)})$. To do this, first notice that

$$\widetilde{\mathbb{E}}^{(x,v)}[X(t)] = e^{\frac{x}{2}} \mathbb{E}^{(x,v)} \left[e^{X_{e}(t) - \frac{X_{e}(T)}{2} - \frac{H(T)}{8}} \right] = \mathbb{E}^{(x,v)} \left[\mathbb{E}^{(x,v)} \left[e^{\frac{x}{2} + X_{e}(t) - \frac{X_{e}(T)}{2} - \frac{H(T)}{8}} \mid H(t), H(T) \right] \right].$$

Since $H(t) \leq H(T)$ are independent of the Brownian motion B, if we set, for $s_1 \leq s_2$,

$$F_1(s_1, s_2) = \mathbb{E}^{(x,v)} \left[e^{B(s_1) - \frac{B(s_2)}{2} + \frac{x}{2} - \frac{s_2}{8}} \right]$$

we get

$$\widetilde{\mathbb{E}}^{(x,v)}[X(t)] = \mathbb{E}^{(x,v)}\left[F_1(H(t), H(T))\right].$$

However, by Girsanov's theorem (see [40, Theorem 5.1]), we know that $\{B(s) + \frac{s}{2}, s \in [0, s_2]\}$ is a Brownian motion under the measure

$$A \in \mathcal{F}_{s_2} \mapsto \mathbb{E}^{(x,v)} \left[\mathbb{1}_A e^{-\frac{B(s_2)}{2} + \frac{x}{2} - \frac{s_2}{8}} \right],$$

hence in particular $e^{B(s)} = e^{B(s) + \frac{s}{2} - \frac{s}{2}}$ is the Doleans-Dade exponential of $B(s) + \frac{s}{2}$ and thus a martingale under the same measure. As a consequence, we have that

$$F_1(s_1, s_2) = \mathbb{E}^{(x,v)} \left[e^{B(s_1) - \frac{B(s_2)}{2} + \frac{x}{2} - \frac{s_2}{8}} \right] = e^x$$

and then

$$\widetilde{\mathbb{E}}^{(x,v)}[X(t)] = \mathbb{E}^{(x,v)}\left[F_1(H(t), H(T))\right] = e^x < \infty.$$

Now we need to prove the martingale property. To do this, fix s and t such that $0 \le s \le t$ and let $A_1, A_2 \in D_{-}[0, s]$ be Borel sets. Define the event

$$A_{\star} := \{ X_{\mathbf{e}} \big|_{[0,s]} \in A_1 \} \cap \{ \gamma \big|_{[0,s]} \in A_2 \}.$$

Then we have, for any T > t,

$$\widetilde{\mathbb{E}}^{(x,v)} \left[X(t) \mathbb{1}_{A_{\star}} \right] = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_{1}} (X_{e} \big|_{[0,s]}) \mathbb{1}_{A_{2}} (\gamma \big|_{[0,s]}) e^{\frac{x}{2} + X_{e}(t) - \frac{X_{e}(T)}{2} - \frac{H(T)}{8}} \right] \\ = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_{2}} (\gamma \big|_{[0,s]}) F_{2}(H \big|_{[0,T]}) \right],$$
(6.5)

where for any $g \in \Lambda_{-}[0,T]$ we set

$$F_2(g) := \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_1}(B(g(\cdot))\big|_{[0,s]}) e^{\frac{x}{2} + B(g(t)) - \frac{B(g(T))}{2} - \frac{g(T)}{8}} \right]$$

and we notice that

$$F_2(H|_{[0,T]}) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_1}(X_e|_{[0,s]}) e^{\frac{x}{2} + X_e(t) - \frac{X_e(T)}{2} - \frac{H(T)}{8}} | H|_{[0,T]} \right].$$

Since $A_1 \subset D_{-}[0, s]$, the event $\{B(g(\cdot))|_{[0,s]} \in A_1\}$ belongs to $\sigma(B(w), w \leq g(s))$. Therefore we use again Girsanov's theorem and use the martingale property of Brownian (conditionally on the independent $H|_{[0,T]}$) to get now

$$F_2(g) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_1}(B(g(\cdot))|_{[0,s]}) e^{\frac{x}{2} + B(g(s)) - \frac{B(g(T))}{2} - \frac{g(T)}{8}} \right]$$

In particular, we have that

$$F_{2}(H|_{[0,T]}) = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_{1}}(X_{e}|_{[0,s]}) e^{\frac{x}{2} + X_{e}(s) - \frac{X_{e}(T)}{2} - \frac{H(T)}{8}} | H|_{[0,T]} \right].$$

When we replace the latter equality back into (6.5), we obtain

$$\widetilde{\mathbb{E}}^{(x,v)} \left[X(t) \mathbb{1}_{A_{\star}} \right] = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_{1}} (X_{e} \big|_{[0,s]}) \mathbb{1}_{A_{2}} (\gamma \big|_{[0,s]}) e^{\frac{x}{2} + X_{e}(t) - \frac{X_{e}(T)}{2} - \frac{H(T)}{2}} \right] \\ = \mathbb{E}^{(x,v)} \left[\mathbb{1}_{A_{1}} (X_{e} \big|_{[0,s]}) \mathbb{1}_{A_{2}} (\gamma \big|_{[0,s]}) e^{\frac{x}{2} + X_{e}(s) - \frac{X_{e}(T)}{2} - \frac{H(T)}{8}} \right] = \widetilde{\mathbb{E}}^{(x,v)} \left[X(s) \mathbb{1}_{A_{\star}} \right].$$
(6.6)

Given that events of the form of A_{\star} are a π -system generating \mathcal{N}_s , this completes the proof.

We need, however, to guarantee that the change of measure does not affect the Markov property and the time-homogeneity of the process (X, γ) . As for the Markov property, this is considered in the following result, while the preservation of the time-homogeneity will be proved later.

Proposition 6.4. The process (X, γ) is \mathcal{N} -Markov under $\widetilde{\mathbb{P}}^{(x,v)}$.

Proof. Consider any function $f \in L^{\infty}(\mathbb{R}^2)$ and let $0 \leq s \leq t$. We have, for any T > t,

$$\begin{split} \widetilde{\mathbb{E}}^{(x,v)} \left[f(X(t),\gamma(t)) \mid \mathcal{N}_s \right] &= \frac{\mathbb{E}^{(x,v)} \left[f(X(t),\gamma(t)) e^{-\frac{X_e(T)}{2} - \frac{H(T)}{8}} \mid \mathcal{N}_s \right]}{\mathbb{E}^{(x,v)} \left[e^{-\frac{X_e(T)}{2} - \frac{H(T)}{8}} \mid \mathcal{N}_s \right]} \\ &= \frac{\mathbb{E}^{(x,v)} \left[f(X(t),\gamma(t)) e^{-\frac{\log(X(T))}{2} - \frac{T-v-\gamma(T)}{8}} \mid \mathcal{N}_s \right]}{\mathbb{E}^{(x,v)} \left[e^{-\frac{\log(X(T))}{2} - \frac{T-v-\gamma(T)}{8}} \mid \mathcal{N}_s \right]} \\ &= \frac{\mathbb{E}^{(x,v)} \left[f(X(t),\gamma(t)) e^{-\frac{\log(X(T))}{2} - \frac{T-v-\gamma(T)}{8}} \mid X(s),\gamma(s) \right]}{\mathbb{E}^{(x,v)} \left[e^{-\frac{\log(X(T))}{2} - \frac{T-v-\gamma(T)}{8}} \mid X(s),\gamma(s) \right]} \\ &= \widetilde{\mathbb{E}}^{(x,v)} \left[f(X(t),\gamma(t)) \mid X(s),\gamma(s) \right], \end{split}$$

where we used the fact that $H(T) = T - v - \gamma(T)$ and $X_e(T) = \log(X(T))$ under $\mathbb{E}^{(x,v)}$ and the \mathcal{N} -Markov property of (X, γ) with respect to $\mathbb{P}^{(x,v)}$.

Before proving that (X, γ) is also *time-homogeneous*, we need to investigate another property. Indeed, notice that both X and γ depend on B and S and in particular X(0) and $\gamma(0)$ are *constrained* by the values (x, v). Observe that under $\mathbb{P}^{(x,v)}$, one has that if $\sigma(0) = v$ and thus L(t) is defined for $t \geq v$, as well as $\gamma(t)$. In practice, under $\mathbb{P}^{(x,v)}$, $v \leq 0$, the position of process $(X, \gamma) = (X(w), \gamma(w))$, $w \geq 0$, at time t, conditionally to $X(s), \gamma(s)$, does note see the choice of x and v. Hence, as a first step, we need to show that, under $\mathbb{E}^{(x,v)}$, the distribution of $(X(t), \gamma(t))$ given $(X(s), \gamma(s))$ is independent of the choice of (B(0), S(0)), given that $S(0) \leq s$ at least. This is done in the next proposition, in which we also prove that the process (X, γ) is time-homogeneous with respect to the measure $\mathbb{P}^{(x,v)}$. **Proposition 6.5.** Let $0 \le s \le t$. Then, for all $x, x' \in \mathbb{R}$ and $v, v' \le s$ it holds

$$\widetilde{\mathbb{E}}^{(x,v)}\left[f(X(t),\gamma(t)) \mid X(s), \ \gamma(s)\right] = \widetilde{\mathbb{E}}^{(x',v')}\left[f(X(t),\gamma(t)) \mid X(s), \ \gamma(s)\right].$$
(6.7)

In particular, one can define, for $0 \leq s \leq t$, the transition semigroup $\widetilde{Q}_{s,t}$ of (X,γ) under $\widetilde{\mathbb{P}}^{(x,v)}$ acting on bounded measurable functions $f: \mathbb{R}^+ \times \mathbb{R}^+_0 \to \mathbb{R}$ in such a way that

$$\widetilde{Q}_{s,t}f(X(s),\gamma(s)) = \widetilde{\mathbb{E}}^{(x,v)} \left[f(X(t),\gamma(t)) \mid X(s),\gamma(s) \right],$$
(6.8)

for any $x \in \mathbb{R}$ and $v \leq s$. Furthermore, $\widetilde{Q}_{s,t}$ only depends on t-s and then (X,γ) is time-homogeneous.

Proof. Let $(Q_t)_{t\geq 0}$ be the transition semigroup under $\mathbb{P}^{(x,v)}$ of the time-homogeneous process (X,γ) , i.e. for all bounded measurable functions $f: \mathbb{R}^+ \times \mathbb{R}^+_0 \to \mathbb{R}$ and for all $t \geq 0$, $Q_t f: \mathbb{R}^+ \times \mathbb{R}^+_0 \to \mathbb{R}$ is the bounded measurable function such that for any $s \geq 0$, $x \in \mathbb{R}^+$ and $v \in [0, s]$

$$Q_t f(X(s), \gamma(s)) = \mathbb{E}^{(x,v)} [f(X(t+s), \gamma(t+s)) \mid X(s), \gamma(s)].$$
(6.9)

The independence on (x, v) is justified by observing that the transition semigroup of (X_e, γ) is already independent of (x, v) by [46, Theorems 3.2 and 4.1].

Notice that (6.9) holds whenever $f : \mathbb{R}^+ \times \mathbb{R}^+_0 \to \mathbb{R}$ is a measurable function such that

$$\mathbb{E}^{(x,v)}\left[\left|f(X(t),\gamma(t))\right|\right] < \infty$$

for all $t \ge 0$ and $x, v \in \mathbb{R}$. Now fix $0 \le s \le t, x, x' \in \mathbb{R}^+$ and $v, v' \le s$. Then, as a consequence of Proposition 6.4, for any T > t, we have

$$\widetilde{\mathbb{E}}^{(x,v)}\left[f(X(t),\gamma(t)) \mid X(s),\gamma(s)\right] = \frac{\mathbb{E}^{(x,v)}\left[f(X(t),\gamma(t))e^{-\frac{\log(X(T))}{2} - \frac{T-v-\gamma(T)}{8}} \mid X(s),\gamma(s)\right]}{\mathbb{E}^{(x,v)}\left[e^{-\frac{\log(X(T))}{2} - \frac{T-v-\gamma(T)}{8}} \mid X(s),\gamma(s)\right]}.$$
(6.10)

To deal with the numerator note that, by Lemma 6.2, we can use the martingale property to get, for any y, w and T > t, that for the Markov semigroup Q_t , $t \ge 0$, it is true that

$$Q_{T-t}f(y,w) = f(y,w).$$
(6.11)

Hence, for the numerator in (6.10), we have

$$\mathbb{E}^{(x,v)}\left[f(X(t),\gamma(t))e^{-\frac{\log(X(T))}{2}-\frac{T-v-\gamma(T)}{8}} \mid X(s),\gamma(s)\right] = \mathbb{E}^{(x,v)}\left[f(X(t),\gamma(t))Q_{T-t}g(X(t),\gamma(t)) \mid X(s),\gamma(s)\right],$$
(6.12)

where

$$g(y,w) = e^{-\frac{\log(y)}{2} - \frac{T - S(0) - w}{8}}.$$

Next, let

$$h(y,w) = f(y,w)Q_{T-t}g(y,w).$$

Given that f is bounded, we can write

$$\mathbb{E}^{(x,v)}\left[\left|h(X(t),\gamma(t))\right|\right] \le \left(\sup_{(y,w)\in\mathbb{R}^+\times\mathbb{R}^+_0}\left|f(y,w)\right|\right)\mathbb{E}^{(x,v)}\left[g(X(T),\gamma(T))\right]$$
$$= e^x \left(\sup_{(y,w)\in\mathbb{R}^+\times\mathbb{R}^+_0}\left|f(y,w)\right|\right) < \infty.$$

Hence (6.12) can be rewritten as

$$\mathbb{E}^{(x,v)}\left[f(X(t),\gamma(t))e^{-\frac{\log(X(T))}{2}-\frac{T-v-\gamma(T)}{8}} \mid X(s),\gamma(s)\right] = Q_{t-s}h(X(s),\gamma(s)).$$
(6.13)

For the denominator of (6.10), we have

$$\mathbb{E}^{(x,v)}\left[e^{-\frac{\log(X(T))}{2} - \frac{T-v-\gamma(T)}{8}} \mid X(s), \gamma(s)\right] = Q_{T-s}g(X(s), \gamma(s)).$$

Hence, (6.10) can be rewritten as

$$\widetilde{\mathbb{E}}^{(x,v)}\left[f(X(t),\gamma(t)) \mid X(s),\gamma(s)\right] = \frac{Q_{t-s}h(X(s),\gamma(s))}{Q_{T-s}g(X(s),\gamma(s))}.$$
(6.14)

The right-hand side is independent of the choice of (x, v), therefore we get (6.7). Now, let us select T = t + 1, so that $h(y, w) = f(y, w)Q_1g(t, w)$, and let us set

$$\widetilde{Q}_{s,t}f(y,w) = \frac{Q_{t-s}\left(f(\cdot,\cdot)Q_1g(\cdot,\cdot)\right)\left(y,w\right)}{Q_{t-s+1}g(y,w)}.$$

Then we see that $\tilde{Q}_{s,t}$ only depends on t-s and (6.8) holds by virtue of (6.14).

With the previous proposition in mind, we can directly define $\tilde{Q}_{t-s} := \tilde{Q}_{s,t}$. Finally, we show the equivalent of the Cameron-Martin formula in this context.

Proposition 6.6 (Cameron-Martin formula). For any $(x,v) \in \mathbb{R}^2$ and any T > 0, the distribution of $(X_e + \frac{H}{2}, \gamma)|_{[0,T]}$ under $\widetilde{\mathbb{P}}^{(x,v)}$ coincides with the one of $(X_e, \gamma)|_{[0,T]}$ under $\mathbb{P}^{(x,v)}$. As a consequence, the distribution of (X, γ) under $\widetilde{\mathbb{P}}^{(x,v)}$ coincides with the one of $(Xe^{-\frac{H}{2}}, \gamma)$ under $\mathbb{P}^{(x,v)}$.

Proof. Fix T > 0 and consider a bounded and measurable function $f : D_{-}[0,T] \times \Lambda_{-}[0,T] \to \mathbb{R}$. Then we have

$$\widetilde{\mathbb{E}}^{(x,v)} \left[f\left(\left(X_{e} + \frac{H}{2} \right) \Big|_{[0,T]}, \gamma \Big|_{[0,T]} \right) \right]$$

$$= \mathbb{E}^{(x,v)} \left[f\left(\left(X_{e} + \frac{H}{2} \right) \Big|_{[0,T]}, \gamma \Big|_{[0,T]} \right) e^{-\frac{X_{e}(T)}{2} - \frac{H(T)}{8}} \right]$$

$$= \mathbb{E}^{(x,v)} \left[F(H|_{[0,T]}) \right],$$
(6.15)

where we set, for any $g \in \Lambda_{-}[0, T]$,

$$\widetilde{\gamma}(g)(t) := t - v - g(t) \text{ and } F(g) = \mathbb{E}^{(x,v)} \left[f\left(\left(B(g(\cdot)) + \frac{g(\cdot)}{2} \right) \Big|_{[0,T]}, \widetilde{\gamma}(g) \Big|_{[0,T]} \right) e^{-\frac{B(g(T))}{2} - \frac{g(T)}{8}} \right]$$

and we notice that

$$F(H|_{[0,T]}) = \mathbb{E}^{(x,v)} \left[f\left(\left(X_{e} + \frac{H}{2} \right) \Big|_{[0,T]}, \gamma \Big|_{[0,T]} \right) e^{-\frac{X_{e}(T)}{2} - \frac{H(T)}{8}} |H|_{[0,T]} \right].$$

By Girsanov theorem, however, we know that under the measure

$$A \in \mathcal{F}_{g(T)} \mapsto \mathbb{E}^{(x,v)} \left[\mathbb{1}_A e^{-\frac{B(g(T))}{2} - \frac{g(T)}{8}} \right]$$

the process $t \in [0, g(T)] \mapsto B(t) + \frac{t}{2}$ is a Brownian motion. Hence, the distribution of $\left(B(g(\cdot)) + \frac{g(\cdot)}{2}\right)\Big|_{[0,T]}$ under the aforementioned measure coincides with the distribution of $B(g(\cdot))\Big|_{[0,T]}$ under $\mathbb{P}^{(x,v)}$ and then

$$F(g) = \mathbb{E}^{(x,v)} \left[f(B(g(\cdot))\big|_{[0,T]}, \widetilde{\gamma}(g)\big|_{[0,T]}) \right].$$

In particular, we notice that, by independence of B and H,

$$F(H|_{[0,T]}) = \mathbb{E}^{(x,v)} \left[f(X_{e}|_{[0,T]}, \gamma|_{[0,T]}) \mid H|_{[0,T]} \right].$$

Substituting this into (6.16) we have

$$\widetilde{\mathbb{E}}^{(x,v)}\left[f\left(\left(X_{e} + \frac{H}{2}\right)\Big|_{[0,T]}, \gamma\Big|_{[0,T]}\right)\right] = \mathbb{E}^{(x,v)}\left[f(X_{e}\Big|_{[0,T]}, \gamma\Big|_{[0,T]})\right].$$
(6.17)

Since f is arbitrary, we have the equality in distribution.

Next, notice that with the same argument as in Proposition 6.4, one can prove that $(X_e + \frac{H}{2}, \gamma)$ is a \mathcal{N} -Markov process under $\widetilde{\mathbb{P}}^{(x,v)}$. Recalling also that (X_e, γ) is \mathcal{N} -Markov with respect to the measure $\mathbb{E}^{(x,v)}$, we have that since the distribution of $(X_e + \frac{H}{2}, \gamma)|_{[0,T]}$ under $\widetilde{\mathbb{P}}^{(x,v)}$ and $(X_e, \gamma)|_{[0,T]}$ under $\mathbb{P}^{(x,v)}$ coincide for all T > 0, then the distribution of the whole trajectories must coincide. Finally, the distribution of (X, γ) under $\widetilde{\mathbb{P}}^{(x,v)}$ coincides with the one of $(Xe^{-\frac{H}{2}}, \gamma)$ under $\mathbb{P}^{(x,v)}$ since both of them are expressed as deterministic functions of $(X_e + \frac{H}{2}, \gamma)$ and (X_e, γ) .

6.2. The coupled non-local Black-Scholes equation. We can now introduce the option price process. Fix a maturity T > 0 and a strike price K > 0. We want to focus on the case of a call option, hence we define the option price process by

$$\mathcal{X}(t) := \widetilde{\mathbb{E}}^{(x,v)} \left[(X(T) - K)_+ \mid \mathcal{N}_t \right], \qquad t \in [0,T]$$

where $(x)_{+} = \max(x, 0)$. By Proposition 6.4, X(t) is given by

$$\mathcal{X}(t) = \widetilde{\mathbb{E}}^{(x,v)} \left[(\mathcal{X}(T) - K)_+ \mid X(t), \ \gamma(t) \right] = \widetilde{Q}_{T-t} u(X(t), \gamma(t)),$$

where

$$u(y,w) = (y-K)_+.$$

Hence, let us set

$$q_{\star}(t, y, w) \coloneqq \widetilde{Q}_{T-t}u(y, w).$$

For a call option with maturity T > 0, strike price K > 0, when the interest rate is 0, the classical Black and Scholes equation is

$$\partial_t q_{\rm BS}(T-t,x) = -\frac{1}{2} x^2 \partial_x^2 q_{\rm BS}(T-t,x), \qquad t \in [0,T), \ x \in \mathbb{R}^+, \tag{6.18}$$

under the (final) condition $q_{BS}(T-t,x) \mid_{t=T} = (x-K)_+$. In practice, denoting

$$q(t,x) = q_{\star}(T-t,x,0) = \widetilde{Q}_t u(x,0)$$
(6.19)

and, for w > 0,

$$q(t, x, w) = q_{\star}(T - t, x, w) = Q_t u(x, w),$$
(6.20)

in this section we show that the function (6.19) is the solution of a Black-and-Scholes type (non-local) equation containing the coupled operator introduced in Section 3; moreover, we provide a renewal-type equation that gives the price (for any w > 0) in (6.20). However, we do this only in the special case $\phi(\lambda) = \lambda^{\alpha}$ for $\alpha > \frac{1}{2}$. Let us begin with some preliminary considerations. Denote the density of the undershooting H_0 by

$$g_{H_0}(s;t) = \frac{s^{\alpha-1}(t-s)^{-\alpha} \mathbb{1}_{(0,t)}(s)}{\Gamma(\alpha)\Gamma(1-\alpha)}.$$
(6.21)

Now we recall that, since when v = 0 it must hold $X_{e}(0) = B(0)$,

$$q(t,x) = \widetilde{\mathbb{E}}^{(\log(x),0)} \left[(X(t) - K)_+ \right].$$

By the time-changed Cameron-Martin formula given in Proposition 6.6, recalling that, under v = 0, H and H_0 coincide, we do have

$$q(t,x) = \mathbb{E}^{(\log(x),0)} \left[(X(t)e^{-\frac{H(t)}{2}} - K)_{+} \right] = \int_{0}^{+\infty} q_{\mathrm{BS}}(s,x)g_{H}(s;t)ds,$$
(6.22)

where

$$q_{\rm BS}(s,x) = \mathbb{E}^{(\log(x),0)} \left[\left(B(s)e^{-\frac{s}{2}} - K \right)_+ \right] \\ = x\Phi \left(\frac{2\log(x) - 2\log(K) + s}{2\sqrt{s}} \right) - K\Phi \left(\frac{2\log(x) - 2\log(K) - s}{2\sqrt{s}} \right)$$

and

$$\Phi(z):=\frac{1}{\sqrt{2\pi}}\int_{-\infty}^z e^{-\frac{x^2}{2}}dx.$$

The function $q_{\rm BS}$ is the solution of the classical Black and Scholes equation (6.18) with respect to the variable s = T - t, i.e., the quantity $q_{\rm BS}(s, x)$, for fixed (s, x), represents the price, at time zero, of a plain-vanilla call option with maturity s > 0 and the corresponding function satisfies the Black and Scholes equation with the operator $2^{-1}x^2\partial_x^2$ (with positive sign). The positive sign in front of the space operator is due to the fact that we are taking the derivative with respect to variable s > 0 that, in this context, is the maturity. Precisely, let, for any $\beta \ge 0$

$$\mathcal{C}_0(\beta) := \{ u \in C(\mathbb{R}^+) : \exists C > 0, \ |u(x)| \le Ce^{\beta |\log(x)|} \}$$

and define

$$\mathcal{C}_0 = \bigcup_{\beta \ge 0} \mathcal{C}_0(\beta).$$

Furthermore, we say that a function $f \in \mathcal{C}_{sol}$ if and only if

- (i) $f \in C(\mathbb{R}^+_0 \times \mathbb{R}^+) \cap C^1(\mathbb{R}^+ \times \mathbb{R}^+)$
- (ii) $f(t, \cdot) \in C^2(\mathbb{R}^+)$ for all t > 0

(*iii*) For all T > 0 there exist $\beta_T, C_T > 0$ such that $|f(t, x)| \leq C_T e^{\beta_T |\log(x)|}$ for all $t \in [0, T]$ and $x \in \mathbb{R}^+$. For $u \in \mathcal{C}_0(\beta)$, we define the quantity

$$[u]_{\beta} := \sup_{x \in \mathbb{R}^+} |u(x)| e^{-\beta |\log(x)|}.$$

Finally, let us introduce $\mathcal{C}_{0, \text{ loc}}(\mathbb{R}_0^+)$ as the set of functions $f \in C(\mathbb{R}_0^+ \times \mathbb{R}^+)$ such that for all T > 0 there exist $\beta_T, C_T > 0$ with the property that $|f(t, x)| \leq C_T e^{\beta_T |\log(x)|}$ for all $t \in [0, T]$ and $x \in \mathbb{R}^+$. Notice that $\mathcal{C}_{\text{sol}} \subset \mathcal{C}_{0, \text{ loc}}(\mathbb{R}_0^+)$.

Before proceeding to introduce the Black-Scholes equation, let us give a simple lemma, which will be useful in the following.

Lemma 6.7. It holds

$$\mathbb{E}^{(x,v)}[e^{\lambda_1|B(t)|+\lambda_2B(t)}] = e^{(\lambda_1+\lambda_2)x + \frac{(\lambda_1+\lambda_2)^2}{2}t} \Phi\left(-\frac{(\lambda_1+\lambda_2)t+x}{\sqrt{t}}\right) \\ + e^{-(\lambda_1-\lambda_2)x + \frac{(\lambda_1-\lambda_2)^2}{2}t} \Phi\left(-\frac{(\lambda_1-\lambda_2)t-x}{\sqrt{t}}\right)$$

The proof of such a lemma is given in Appendix B. Now we can introduce the operator $G := \frac{x^2}{2} \partial_x^2$ and provide some well-known properties of such an operator.

Lemma 6.8. For all $f \in C_0$ there exists a unique classical solution $u_f \in C_{sol}$ of

$$\begin{cases} \partial_t u(t,x) = Gu(t,x), & t > 0, \ x \in \mathbb{R}^+ \\ u(0,x) = f(x), & x > 0, \end{cases}$$
(6.23)

i.e., (C_0, C_{sol}) is a uniqueness class for G. If we denote by $(P_t)_{t\geq 0}$ the associated semigroup action, then the following properties hold true.

(1) For all $f \in C_0$ we have that

$$P_t f(x) = \int_0^{+\infty} f(y) p_{\text{GBM}}(t, y; x) dy$$
 (6.24)

where GBM stands for geometric Brownian motion and

$$p_{\text{GBM}}(t,y;x) := x^{\frac{1}{2}} e^{-\frac{t}{8}} \frac{p(t,\log(y) - \log(x))}{y^{\frac{3}{2}}} \quad and \quad p(t,w) = \frac{1}{\sqrt{2\pi t}} e^{-\frac{w^2}{2t}}.$$
(6.25)

As a consequence, the semigroup $(P_t)_{t\geq 0}$ is Markovian and positivity preserving.

(2) Let $\beta \geq 0$ and assume $f \in \mathcal{C}_0(\beta)$. Then $\partial_x P_t f \in \mathcal{C}_0(\beta+1)$ and

$$[\partial_x P_t f(x)]_{\beta+1} \le 4[f]_\beta \exp\left(\beta \frac{t}{2} + \frac{\beta^2 t^2}{2}\right)$$

(3) For all $f \in \mathcal{C}_0 \cap \mathcal{C}$ such that $\partial_x f \in \mathcal{C}_0$ and $Gf \in \mathcal{C}_0$ it holds

$$P_t G f = G P_t f$$

(4) Fix $\beta_1, \beta_2 \in \mathbb{R}$ and let $f_{\beta_1,\beta_2}(x) = e^{\beta_1 |\log(x)| + \beta_2 \log(x)}$. Then

$$P_t f_{\beta_1,\beta_2}(x) = e^{(\beta_1 + \beta_2)\log(x) + \frac{(\beta_1 + \beta_2)(\beta_1 + \beta_2 - 1)}{2}t} \Phi\left(-\left(\beta_1 + \beta_2 - \frac{1}{2}\right)\sqrt{t} - \frac{\log(x)}{\sqrt{t}}\right) \\ + e^{-(\beta_1 - \beta_2)\log(x) + \frac{(\beta_1 - \beta_2)(\beta_1 - \beta_2 + 1)}{2}t} \Phi\left(-\left(\beta_1 - \beta_2 + \frac{1}{2}\right)\sqrt{t} + \frac{\log(x)}{\sqrt{t}}\right).$$

(5) If $f \in C_0(\beta)$, then $P_t f \in C_0(\beta)$ with

$$[P_t f]_{\beta} \le 2[f]_{\beta} e^{\frac{\beta(\beta+1)}{2}t}.$$

We give, for completeness, the proof of the previous lemma in Appendix C.

Concerning the function $q_{\rm BS}$, we recall the following properties, that can be verified by direct evaluation.

Lemma 6.9. For all t, x > 0 it holds

$$\partial_x q_{\rm BS}(t,x) = \Phi\left(\frac{2\log(x/K) + t}{2\sqrt{t}}\right),\tag{6.26}$$

41

$$\partial_x^2 q_{\rm BS}(t,x) = \sqrt{\frac{K}{2\pi t x^3}} \exp\left(-\frac{4\log^2\left(x/K\right) + t^2}{8t}\right),\tag{6.27}$$

$$\partial_t q_{\rm BS}(t,x) = G q_{\rm BS}(t,x) = \sqrt{\frac{Kx}{8\pi t}} \exp\left(-\frac{4\log^2\left(x/K\right) + t^2}{8t}\right).$$
 (6.28)

In particular,

$$|q_{\rm BS}(t,x)| \le e^{|\log(x)|} \tag{6.29}$$

$$|\partial_x q_{\rm BS}(t,x)| \le 1,\tag{6.30}$$

$$\left|\partial_t q_{\rm BS}(t,x)\right| = \left|Gq_{\rm BS}(t,x)\right| \le \sqrt{\frac{Kx}{8\pi t}}.$$
(6.31)

Furthermore, for all a > 0 and $x \ge a$ we have

$$\left|\partial_x^2 q_{\rm BS}(t,x)\right| \le \sqrt{\frac{K}{8\pi a^3 t}}.\tag{6.32}$$

In particular q_{BS} is the unique solution of

$$\begin{cases} \partial_t q_{\rm BS}(t,x) = G q_{\rm BS}(t,x), & t > 0, \ x \in \mathbb{R}^+ \\ q_{\rm BS}(0,x) = (x - K)_+, & x > 0, \\ q_{\rm BS} \in \mathcal{C}_{0,\rm loc}(\mathbb{R}^+_0). \end{cases}$$
(6.33)

The remainder of this section is devoted to the proof of the following theorem, i.e., the main result of this part. Notice that we focus on the case $\Phi(\lambda) = \lambda^{\alpha}$ with $\alpha > \frac{1}{2}$. While it will be clear that some arguments apply to a generic Φ , most of the proof relies on the specific form of Φ , in particular on the self-similarity of H_0 under this choice. Furthermore, as it will be clear in the following, the condition $\alpha > \frac{1}{2}$ is dictated by regularity issues.

Theorem 6.10. Let $\phi(\lambda) = \lambda^{\alpha}$ for $\alpha \in \left(\frac{1}{2}, 1\right)$. Let also, for any $h \in \mathbb{R}$, $A \in \mathcal{B}(\mathbb{R})$ and $w \ge 0$

$$\widetilde{\mathcal{K}}(A,h) = \int_0^{+\infty} \mathbb{1}_A(s)p(s,h)\frac{\alpha s^{-\alpha-1}}{\Gamma(1-\alpha)}ds \qquad \mathcal{K}(d\tau,dh) = \widetilde{\mathcal{K}}(d\tau,h)dh$$
(6.34)

and

$$\mathcal{K}_w(A) = \begin{cases} \frac{\mathcal{K}(A \cap (\mathbb{R} \times [w, +\infty)))}{\mathcal{K}(\mathbb{R} \times [w, +\infty))} & w > 0\\ \delta_{(0,0)}(A) & w = 0. \end{cases}$$

Then

$$q_{\star}(t, x, 0) = q(T - t, x)$$

and, for w > 0 and any v < t - w,

$$q_{\star}(t,x,w) = \left(xe^{-\frac{t-v-w}{2}} - K\right)_{+} \mathcal{K}_{w}(x; \mathbb{R}^{d} \times [w+T-t,\infty)) + \int_{\mathbb{R} \times [w,w+T-t)} q(T-t+w-\tau, \log(x)+y+t-w+\tau-v) \mathcal{K}_{w}(d\tau, dy), \quad (6.35)$$

where q is the unique solution of

$$\begin{cases} (\partial_t - G)^{\alpha} q(t, x) = \frac{t^{-\alpha}}{\Gamma(1-\alpha)} q(0, x) \\ q(0, x) = (x - K)_+ \\ q \in \mathcal{C}_{0, \text{loc}}(\mathbb{R}_0^+). \end{cases}$$
(6.36)

This will be proved using several preliminary results:

- (1) First we study the regularity of the function q in (6.22);
- (2) next, we prove that q is solution of (6.36);
- (3) we then prove that the solution to (6.36) is unique for initial data in a suitable class (to which $(x K)_+$ belongs);
- (4) finally, we prove Theorem 6.10.

Remark 6.11. Notice that (6.35) is a formula that determines the value of q_{\star} uniquely for positive sojourn time. Indeed, the only quantity that is involved is the function q which is related to the value of q_{\star} on renewal states, i.e. for zero sojourn time, which is the unique solution with at most power growth at 0 and ∞ of the fully nonlocal Black-Scholes equation (6.36). This is also underlined by the fact that (6.35) can be rewritten as

$$q_{\star}(t,x,w) = \left(xe^{-\frac{t-v-w}{2}} - K\right)_{+} \mathcal{K}_{w}(x; \mathbb{R}^{d} \times [w+T-t,\infty)) + \int_{\mathbb{R} \times [w,w+T-t)} q_{\star}(t-w+\tau, \log(x) + y + t - w + \tau - v, 0) \mathcal{K}_{w}(d\tau, dy), \quad (6.37)$$

that only involves the function $q_{\star}(t, x, 0)$, which is given by the solution of (6.36). We remark that $(x - K)_+$ appears as an initial condition in (6.36) but, given that the fair price of our call option at time t > 0 is $q_{\star}(t, x, w)$, then

$$(x - K)_{+} = q(0, x) = q_{\star}(T, x, 0)$$
(6.38)

and thus $(x - K)_+$ is the usual final condition for $q_*(\cdot, \cdot, 0)$. It follows that, according to our model, the fair price at time t > 0 of a(n) (intraday) plain vanilla call option (with zero interest rate, strike price K and maturity T > t) can be determined by solving the initial value problem (6.36) then changing the variable $t \rightsquigarrow T - t$ and finally using (6.37).

6.2.1. Regularity of q. In this section, we provide some regularity results on the function q that will be needed to apply Theorems 3.2 and 3.3. Before proceeding, let us recall that for any $f \in L^{\infty}(\mathbb{R})$, by (6.21), it holds

$$\mathbb{E}^{(x,0)}[f(H(t))] = \int_0^t f(y) \frac{(t-y)^{-\alpha} y^{\alpha-1}}{\Gamma(1-\alpha)\Gamma(\alpha)} \, dy = \int_0^1 f(ts) \frac{(1-s)^{-\alpha} s^{\alpha-1}}{\Gamma(1-\alpha)\Gamma(\alpha)} \, ds = \mathbb{E}^{(x,0)}[f(tH(1))], \tag{6.39}$$

i.e., $H(t) \stackrel{d}{=} tH(1)$. We shall use this self-similarity property throughout the proof.

Now, we prove that for all x > 0 the function $q(\cdot, x)$ belongs to $AC(\mathbb{R}^+_0)$ and we provide a suitable upper bound on its a.e. derivative.

Proposition 6.12. Under the hypotheses of Theorem 6.10, for all x > 0 the function $q(\cdot, x) \in AC(\mathbb{R}^+_0)$ and its a.e. derivative $\partial_t q(\cdot, x)$ satisfies, for a.a. $t \ge 0$,

$$\left|\partial_t q(t,x)\right| \le \frac{\Gamma\left(\alpha + \frac{1}{2}\right)}{\pi \Gamma(\alpha)} \sqrt{\frac{Kx}{t}}.$$
(6.40)

Proof. For any t > 0, let $h \in \left(-\frac{t}{2}, 1\right)$ and consider $D^h q(t, x) = \frac{q(t+h,x)-q(t,x)}{h}$. Then we have, by (6.39),

$$|D^{h}q(t,x)| \leq \int_{0}^{1} \left| \frac{q_{\mathrm{BS}}(ts+hs,x) - q_{\mathrm{BS}}(ts,x)}{hs} \right| \frac{s^{\alpha}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} ds$$

By Lagrange theorem, we know that there exists $\xi \in [\min\{ts, ts + hs\}, \max\{ts, ts + hs\}]$ such that

$$\left|\frac{q_{\rm BS}(ts+hs,x)-q_{\rm BS}(ts,x)}{hs}\right| = \left|\partial_t q_{\rm BS}(x,\xi)\right| \le \sqrt{\frac{Kx}{8\pi\xi}} \le \sqrt{\frac{Kx}{4\pi ts}}$$

where we also used (6.31). Hence

$$|D^hq(t,x)| \le \sqrt{\frac{Kx}{4\pi t}} \int_0^1 \frac{s^{\alpha-\frac{1}{2}}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} ds = \frac{\Gamma\left(\alpha+\frac{1}{2}\right)}{\pi\Gamma(\alpha)} \sqrt{\frac{Kx}{t}}.$$

The right-hand side is independent of h and belongs to $L^1(0,T)$ for all T > 0, thus we can argue as in Proposition 5.4 and get the result.

As claimed, the previous proposition implies that q satisfies Item (i) of both Theorems 3.2 and 3.3. We show this in the next result.

Corollary 6.13. Under the assumptions of Theorem 6.10 we have that for all t, x > 0

$$\int_0^t |P_s q(t-s,x) - P_s q(t,x)| \frac{\alpha s^{-\alpha-1}}{\Gamma(1-\alpha)} ds < \infty$$

and, for all $\lambda > \frac{3}{8}$ and x > 0,

$$\int_0^\infty \int_0^t e^{-\lambda t} |P_s q(t-s,x) - P_s q(t,x)| \frac{\alpha s^{-\alpha-1}}{\Gamma(1-\alpha)} ds \, dt < \infty.$$

Proof. Fix x > 0, and note that for 0 < s < t,

$$\begin{aligned} |q(t-s,x) - q(t,x)| &\leq \int_0^s |\partial_t q(t-\tau,x)| \, d\tau \\ &\leq \frac{\Gamma\left(\alpha + \frac{1}{2}\right)}{\pi\Gamma(\alpha)} \sqrt{Kx} \int_0^s (t-\tau)^{-1/2} d\tau = \frac{\Gamma\left(\alpha + \frac{1}{2}\right)s}{\pi\Gamma(\alpha)} \sqrt{\frac{Kx}{t-s}}. \end{aligned}$$
(6.41)

This proves that $|q(t-s,\cdot)-q(t,\cdot)| \in C_0(1/2)$. We get, by also employing Items (1) and (5) of Lemma 6.8,

$$\begin{split} \int_0^t |P_s q(t-s,x) - P_s q(t,x)| \frac{\alpha s^{-\alpha-1}}{\Gamma(1-\alpha)} ds \\ &\leq \int_0^t P_s |q(t-s,\cdot) - q(t,\cdot)|(x) \frac{\alpha s^{-\alpha-1}}{\Gamma(1-\alpha)} ds \\ &\leq \frac{2\alpha \Gamma\left(\alpha + \frac{1}{2}\right) \sqrt{K}}{\pi \Gamma(\alpha) \Gamma(1-\alpha)} e^{\frac{1}{2}|\log(x)| + \frac{3}{8}t} \int_0^t s^{-\alpha} (t-s)^{-\frac{1}{2}} ds \\ &= \frac{2\alpha \Gamma\left(\alpha + \frac{1}{2}\right) \sqrt{K}}{\Gamma(\alpha) \Gamma\left(\frac{3}{2} - \alpha\right) \sqrt{\pi}} t^{\frac{1}{2} - \alpha} e^{\frac{1}{2}|\log(x)| + \frac{3}{8}t}, \end{split}$$

where we also used [3, Lemma 1.11]. Furthermore, for any $\lambda > \frac{3}{8}$ it holds

$$\int_0^\infty \int_0^t e^{-\lambda t} |P_s q(t-s,x) - P_s q(t,x)| \frac{\alpha s^{-\alpha-1}}{\Gamma(1-\alpha)} ds dt$$

$$\leq \frac{2\alpha\Gamma\left(\alpha+\frac{1}{2}\right)\sqrt{K}}{\Gamma(\alpha)\Gamma\left(\frac{3}{2}-\alpha\right)\sqrt{\pi}}t^{\frac{1}{2}-\alpha}e^{\frac{1}{2}|\log(x)|}\int_{0}^{\infty}t^{\frac{1}{2}-\alpha}e^{-\left(\lambda-\frac{3}{8}\right)t}\,dt \\ = \frac{2\alpha\Gamma\left(\alpha+\frac{1}{2}\right)\sqrt{K}}{\Gamma(\alpha)\sqrt{\pi}}t^{\frac{1}{2}-\alpha}e^{\frac{1}{2}|\log(x)|}\left(\lambda-\frac{3}{8}\right)^{\alpha-\frac{3}{2}}.$$

Now we discuss the regularity of q in x. This is done by means of the following proposition.

Proposition 6.14. Under the assumptions of Theorem 6.10, the following equalities hold for all t, x > 0:

$$\partial_x q(t,x) = \frac{1}{\Gamma(\alpha)\Gamma(1-\alpha)} \int_0^1 \partial_x q_{\rm BS}(\tau t,x) \,\tau^{\alpha-1} (1-\tau)^{-\alpha} d\tau, \tag{6.42}$$

$$\partial_x^2 q(t,x) = \frac{1}{\Gamma(\alpha)\Gamma(1-\alpha)} \int_0^1 \partial_x^2 q_{\rm BS}(\tau t,x) \,\tau^{\alpha-1} (1-\tau)^{-\alpha} d\tau, \tag{6.43}$$

$$Gq(t,x) = \frac{1}{\Gamma(\alpha)\Gamma(1-\alpha)} \int_0^1 Gq_{\rm BS}(\tau t,x) \,\tau^{\alpha-1} (1-\tau)^{-\alpha} d\tau.$$
(6.44)

Furthermore $q(t, \cdot) \in \mathcal{C}_0(1)$, $\partial_x q(t, \cdot) \in \mathcal{C}_0(0)$ and $Gq(t, \cdot) \in \mathcal{C}_0(1/2)$ for all t > 0, where

$$|q(t,x)| \le e^{|\log(x)|} \tag{6.45}$$

$$|\partial_x q(t,x)| \le 1 \tag{6.46}$$

$$|Gq(t,x)| \le \sqrt{\frac{Kx}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)}.$$
(6.47)

In particular, $q \in \mathcal{C}_{0,\text{loc}}(\mathbb{R}^+_0)$.

Proof. By (6.22) and (6.29) we already know that $q \in C_0(1)$ with $[q]_1 \leq 1$. Moreover, by (6.30), we know that we can apply the dominated convergence theorem to take the derivative inside the integral sign in (6.22) and then using (6.39), getting (6.42). Furthermore, (6.30) also implies that $\partial_x q(t, \cdot) \in C_0(0)$ with $[\partial_x q(t, \cdot)]_0 \leq 1$.

To argue with the second derivative, fix
$$a > 0$$
 and notice that for all $x \ge a$ it holds, by (6.32),

$$\begin{split} \int_0^1 \left| \partial_x^2 q_{\rm BS}(ts,x) \right| \frac{s^{\alpha-1}(1-s)^{-\alpha}}{\Gamma(1-\alpha)\Gamma(\alpha)} ds &\leq \sqrt{\frac{K}{8\pi a^3 t}} \int_0^1 \frac{s^{\alpha-\frac{3}{2}}(1-s)^{-\alpha}}{\Gamma(1-\alpha)\Gamma(\alpha)} ds \\ &= \frac{1}{2\pi} \sqrt{\frac{K}{2a^3 t}} \frac{\Gamma\left(\alpha-\frac{1}{2}\right)}{\Gamma(\alpha)} < \infty, \end{split}$$

since $\alpha > \frac{1}{2}$. Hence, by dominated convergence, we get (6.43) and finally, multiplying both sides of (6.43) by $\frac{x^2}{2}$, we also get (6.44). Finally, notice that (6.44) and (6.31) imply that $Gq(t, \cdot) \in C_0(1/2)$ for all t > 0 and in particular

$$|Gq(t,x)| \le \sqrt{\frac{Kx}{8\pi t}} \int_0^1 \frac{s^{\alpha-\frac{3}{2}}(1-s)^{-\alpha}}{\Gamma(1-\alpha)\Gamma(\alpha)} ds = \sqrt{\frac{Kx}{2t}} \frac{\Gamma\left(\alpha-\frac{1}{2}\right)}{2\pi\Gamma(\alpha)}.$$

Remark 6.15. Notice that Proposition 6.12, Corollary 6.13, (6.42), (6.45) and (6.46) hold for any $\alpha \in (0, 1)$. The condition $\alpha > 1/2$ comes into play only for (6.43), (6.44) and (6.47). However, it is worth highlighting

$$\begin{aligned} \frac{\partial_x q_{\rm BS}(ts,K+h) - \partial_x q_{\rm BS}(ts,K)}{h} &= \partial_x^2 q_{\rm BS}(ts,\xi) \\ &= \sqrt{\frac{K}{2\pi ts\xi^3}} \exp\left(-\frac{4\log^2(\xi/K) + t^2s^2}{8ts}\right) \\ &\ge \sqrt{\frac{K}{2\pi ts(K+1)^3}} \exp\left(-\frac{4\log^2\left(1 + \frac{h}{K}\right) + t^2s^2}{8ts}\right) \end{aligned}$$

where $\xi \in [K, K+h]$. Hence, by (6.42), we have

$$\begin{aligned} \frac{\partial_x q(t,K+h) - \partial_x q(t,K)}{h} \\ &= \int_0^1 \frac{\partial_x q_{\rm BS}(ts,K+h) - \partial_x q_{\rm BS}(ts,K)}{h} \frac{s^{\alpha-1}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \, ds \\ &\geq \frac{\sqrt{K}}{\sqrt{2\pi t(K+1)^3}} \int_0^1 \exp\left(-\frac{4\log^2\left(1+\frac{h}{K}\right) + t^2s^2}{8ts}\right) \frac{s^{\alpha-\frac{3}{2}}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \, ds. \end{aligned}$$

Taking the limit as $h \to 0^+$ we have, as a consequence of the monotone convergence theorem,

$$\lim_{h \to 0^+} \frac{\partial_x q(t, K+h) - \partial_x q(t, K)}{h} \geq \frac{\sqrt{K}}{\Gamma(\alpha)\Gamma(1-\alpha)\sqrt{2\pi t(K+1)^3}} \int_0^1 \exp\left(-\frac{ts}{8}\right) s^{\alpha-\frac{3}{2}} (1-s)^{-\alpha} \, ds = \infty,$$

if $\alpha \leq \frac{1}{2}$. Hence, in such a case, $q(t, \cdot)$ cannot admit a second order derivative in x = K. Suppose that we have already shown that q is solution of (6.36), then this lack of parabolic smoothing is also common in time-nonlocal equations, see for instance [6, Proposition 3.3].

Now we prove that q satisfies Item (ii) of both Theorems 3.2 and 3.3.

Proposition 6.16. Under the assumptions of Theorem 6.10 it holds, for all t, x > 0,

$$\int_0^t |P_s q(t,x) - q(t,x)| \,\nu_\alpha(ds) < \infty,$$

and, for all x > 0 and $\lambda > \frac{3}{8}$,

$$\int_0^\infty \int_0^t e^{-\lambda t} |P_s q(t,x) - q(t,x)| \,\nu_\alpha(ds) \, dt < \infty$$

where $\nu_{\alpha}(ds)$ is the Lévy measure corresponding to $\phi(\lambda) = \lambda^{\alpha}$, $\alpha \in (1/2, 1)$, i.e.,

$$\nu_{\alpha}(ds) = \alpha s^{-\alpha - 1} / \Gamma(1 - \alpha) ds.$$
(6.48)

Proof. By Proposition 6.14 we know that $q(t, \cdot) \in \mathcal{C}_0$ hence we can write

$$P_sq(t,x) - q(t,x) = \int_0^s GP_\tau q(t,x)d\tau$$

Recalling that, still by Proposition 6.14, $\partial_x q(t, \cdot), Gq(t, \cdot) \in \mathcal{C}_0$, by Item (3) of Lemma 6.8 we have

$$P_{s}q(t,x) - q(t,x) = \int_{0}^{s} P_{\tau}Gq(t,x)d\tau.$$
(6.49)

In particular, $Gq(t, \cdot) \in \mathcal{C}_0(1/2)$ and, by (6.47)

$$[Gq(t,\cdot)]_{1/2} \le \sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)}$$

Hence, by Item (5) of Lemma 6.8 we get that $P_{\tau}Gq(t, \cdot) \in \mathcal{C}_0(1/2)$ with

$$[P_{\tau}Gq(t,\cdot)]_{1/2} \le \sqrt{\frac{2K}{t}} e^{\frac{3}{8}\tau} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)}$$

Using this into (6.49) we have

$$\begin{aligned} |P_s q(t,x) - q(t,x)| &\leq \int_0^s |P_\tau G v q(t,x)| \, d\tau \leq \sqrt{\frac{2K}{t}} e^{\frac{1}{2}|\log(x)|} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} \int_0^s e^{\frac{3}{8}\tau} \, d\tau \\ &\leq \sqrt{\frac{2K}{t}} e^{\frac{1}{2}|\log(x)|} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} e^{\frac{3}{8}s} s. \end{aligned}$$

Integrating the latter against ν_{ϕ} , we have

$$\begin{split} \int_0^t |P_s q(t,x) - q(t,x)| \, \frac{\alpha s^{-\alpha - 1}}{\Gamma(1 - \alpha)} ds &\leq \sqrt{\frac{2K}{t}} e^{\frac{1}{2}|\log(x)|} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} \int_0^t e^{\frac{3}{8}s} \frac{\alpha s^{-\alpha}}{\Gamma(1 - \alpha)} \, ds \\ &\leq e^{\frac{1}{2}|\log(x)|} \frac{\alpha\Gamma\left(\alpha - \frac{1}{2}\right)\sqrt{2K}}{2\pi\Gamma(\alpha)\Gamma(2 - \alpha)} e^{\frac{3}{8}t} t^{\frac{1}{2} - \alpha}. \end{split}$$

Finally, integrating the latter against $e^{-\lambda t}$ for $\lambda > \frac{3}{8}$ we get

$$\begin{split} \int_0^\infty \int_0^t e^{-\lambda t} \left| P_s q(t,x) - q(t,x) \right| \frac{\alpha s^{-\alpha - 1}}{\Gamma(1 - \alpha)} \, ds \, dt \\ &\leq e^{\frac{1}{2} |\log(x)|} \frac{\alpha \Gamma\left(\alpha - \frac{1}{2}\right) \sqrt{2K}}{2\pi \Gamma(\alpha) \Gamma(2 - \alpha)} \int_0^\infty e^{-\left(\lambda - \frac{3}{8}\right) t} t^{\frac{1}{2} - \alpha} \, dt \\ &= e^{\frac{1}{2} |\log(x)|} \frac{\alpha \Gamma\left(\alpha - \frac{1}{2}\right) \sqrt{2K}}{2\pi \Gamma(\alpha) \Gamma(2 - \alpha)} \left(\lambda - \frac{3}{8}\right)^{\alpha - \frac{3}{2}} \Gamma\left(\frac{3}{2} - \alpha\right). \end{split}$$

The last thing we need to check is Item (iii) of Theorem 3.3.

Proposition 6.17. Under the assumptions of Theorem 6.10 for all $x, \lambda > 0$ it holds

$$\int_0^\infty e^{-\lambda t} \overline{\nu}_\alpha(t) |q(t,x)| \, dt < \infty,$$

where $\bar{\nu}_{\alpha}(t)$ is the tail of (6.48).

Proof. Since
$$\overline{\nu}_{\phi}(t) = \frac{t^{-\alpha}}{\Gamma(1-\alpha)}$$
, we just use the inequality (6.45) to get
$$\int_{0}^{\infty} e^{-\lambda t} \frac{t^{-\alpha}}{\Gamma(1-\alpha)} |q(t,x)| \, dt \leq \frac{e^{|\log(x)|}}{\Gamma(1-\alpha)} \int_{0}^{\infty} t^{-\alpha} e^{-\lambda t} dt = \frac{e^{|\log(x)|}}{\lambda^{1-\alpha}}.$$

6.2.2. Existence of the solution. We are now ready to prove a first bit of Theorem 6.10, which is summarized in the next proposition.

Proposition 6.18. Under the assumptions of Theorem 6.10, q is a solution of (6.36).

Proof. In view of the results in Subsection 6.2.1, we know by Theorem 3.2 that $(\partial_t - G)^{\alpha}q(t,x)$ is well-defined for all x, t > 0. Moreover, for any x > 0 we know by Theorem 3.3 that $(\partial_t - G)^{\alpha}q(\cdot,x)$ admits Laplace transform for any $\lambda > \frac{3}{8}$. We divide the proof into two parts. First we check that for all x > 0 and $\lambda > \frac{3}{8}$ we have

$$\int_0^\infty e^{-\lambda t} (\partial_t - G)^\alpha q(t, x) dt = \lambda^{\alpha - 1} (x - K)_+, \qquad (6.50)$$

which is the first equation in (6.36) after taking the Laplace transform in the t variable on both sides. Then we use this to prove that

$$(\partial_t - G)^{\alpha} q(t, x) = \frac{t^{-\alpha}}{\Gamma(1 - \alpha)} q(0, x).$$
(6.51)

We begin with (6.50). Consider x > 0, $\lambda > \frac{3}{8}$ and denote

$$\widetilde{q}(\lambda, x) = \int_0^\infty e^{-\lambda t} q(t, x) \, dt.$$

Let us first evaluate an alternative formula for \tilde{q} . Set $u_K(x) = (x - K)_+$ and notice that, by (6.22), we get

$$\widetilde{q}(\lambda, x) = \frac{1}{\Gamma(\alpha)\Gamma(1-\alpha)} \int_0^\infty e^{-\lambda t} \int_0^t s^{\alpha-1} (t-s)^{-\alpha} q_{\rm BS}(s, x) \, ds \, dt$$
$$= \frac{\lambda^{\alpha-1}}{\Gamma(\alpha)} \int_0^{+\infty} e^{-\lambda s} s^{\alpha-1} q_{\rm BS}(s, x) \, ds$$
$$= \frac{\lambda^{\alpha-1}}{\Gamma(\alpha)} \int_0^{+\infty} e^{-\lambda s} s^{\alpha-1} P_s u_K(x) \, ds,$$
(6.52)

where, in the first step, we used the convolution Theorem for Laplace transform (e.g., [1, Proposition 1.6.4]) and then we applied Tonelli's theorem since q_{BS} is non-negative. As a consequence of (3.2), we have that

$$\begin{split} \int_0^\infty e^{-\lambda t} \left(\partial_t - G\right)^\alpha q(x,t) \, dt \\ &= -\int_0^\infty \int_0^\infty e^{-\lambda t} (P_s q(t-s,x) \mathbb{1}_{(0,t]}(s) - q(t,x)) \, dt \, \nu_\alpha(ds) \\ &= -\int_0^\infty \left(\int_s^\infty \int_0^\infty e^{-\lambda t} q(t-s,y) p_{\text{GBM}}(s,y;x) \, dy \, dt - \tilde{q}(\lambda,x)\right) \, \nu_\alpha(ds) \\ &= -\int_0^\infty \left(e^{-\lambda s} \int_0^\infty \tilde{q}(\lambda,y) p_{\text{GBM}}(s,y;x) \, dy - \tilde{q}(\lambda,x)\right) \, \nu_\alpha(ds) \\ &= -\int_0^\infty \left(e^{-\lambda s} P_s(\tilde{q}(\lambda,\cdot))(x) - \tilde{q}(\lambda,x)\right) \, \nu_\alpha(ds), \end{split}$$

where in the third equality we used again Tonelli's theorem to exchange the order of the integrals (since q and p_{GBM} are non-negative) after having made explicit the action of the operator P_s in the second step. Now we can replace \tilde{q} in the previous identity by making use of (6.52). To do this, we first observe that

$$P_s\left(\widetilde{q}(\lambda,\cdot)\right)(x) = \frac{\lambda^{\alpha-1}}{\Gamma(\alpha)} \int_0^{+\infty} \int_0^{+\infty} e^{-\lambda\tau} \tau^{\alpha-1} P_\tau u_K(y) p_{\text{GBM}}(s,y;x) d\tau \, dy$$

$$=\frac{\lambda^{\alpha-1}}{\Gamma(\alpha)}\int_{0}^{+\infty}e^{-\lambda\tau}\tau^{\alpha-1}P_{s+\tau}u_{K}(x)\,d\tau\tag{6.53}$$

and then we have

$$\int_{0}^{\infty} e^{-\lambda t} \left(\partial_{t} - G\right)^{\alpha} q(x, t) dt$$

$$= -\frac{\alpha \lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \int_{0}^{+\infty} \tau^{\alpha - 1} s^{-\alpha - 1} \left(e^{-\lambda(s + \tau)} P_{s + \tau} u_{K}(x) - e^{-\lambda \tau} P_{\tau} u_{K}(x)\right) d\tau ds$$

$$= -\frac{\alpha \lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \int_{0}^{+\infty} \tau^{\alpha - 1} s^{-\alpha - 1} e^{-\lambda \tau} P_{\tau} \left(e^{-\lambda s} q_{\mathrm{BS}}(s, x) - u_{K}(x)\right) d\tau ds, \qquad (6.54)$$

where we used the fact that P_{τ} is a semigroup action and the explicit form of $\nu_{\alpha}(\cdot)$ given in (6.48). However, if we observe that

$$e^{-\lambda s}q_{\rm BS}(s,x) - u_K(x) = \int_0^s \partial_w e^{-\lambda w} q_{\rm BS}(w,x) \, dw$$
$$\int_0^s e^{-\lambda w} \left(\partial_w q_{\rm BS}(w,x) - \lambda q_{\rm BS}(w,x)\right) \, dw$$
$$= \int_0^s e^{-\lambda w} \left(G - \lambda\right) \, q_{\rm BS}(w,x) \, dw \tag{6.55}$$

and we explicitly write the integral in P_{τ} , we get

$$\int_{0}^{\infty} e^{-\lambda t} \left(\partial_{t} - G\right)^{\alpha} q(x, t) dt$$

$$= -\frac{\alpha \lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha - 1} s^{-\alpha - 1} e^{-\lambda(\tau + w)} \left(G - \lambda\right) q_{\rm BS}(w, y) p_{\rm GBM}(\tau, y; x) dw dy d\tau ds.$$
(6.56)

We want to use Fubini's theorem to change the order of the integrals. To do this, we notice that (6.28) implies $Gq_{BS} \ge 0$ and then

$$\int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} \left| (G-\lambda) q_{\rm BS}(w,y) \right| p_{\rm GBM}(\tau,y;x) \, dw \, dy \, d\tau \, ds$$

$$\leq \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} (G+\lambda) q_{\rm BS}(w,y) p_{\rm GBM}(\tau,y;x) \, dy \, dw \, d\tau \, ds \tag{6.57}$$

$$\int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \sigma^{-1} \sigma^{-1} e^{-\lambda(\tau+w)} P_{\sigma}(G+\lambda) q_{\rm BS}(w,y) p_{\rm GBM}(\tau,y;x) \, dy \, dw \, d\tau \, ds \tag{6.57}$$

$$= \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha - 1} s^{-\alpha - 1} e^{-\lambda(\tau + w)} P_{\tau}(G + \lambda) q_{\rm BS}(w, x) \, dw \, d\tau \, ds \tag{6.58}$$

Since $q_{BS}(t, \cdot) \in \mathcal{C}_0$, $\partial_x q_{BS} \in \mathcal{C}_0$ and $Gq_{BS} \in \mathcal{C}_0$, we can exchange the operator $(G + \lambda)$ with P_{τ} , getting

$$\int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} \left| (G-\lambda) q_{\rm BS}(w,y) \right| p_{\rm GBM}(\tau,y;x) \, dw \, dy \, d\tau \, ds
\leq \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} (G+\lambda) P_{\tau} q_{\rm BS}(w,x) \, dw \, d\tau \, ds \qquad (6.59)
= \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} (G+\lambda) q_{\rm BS}(\tau+w,x) \, dw \, d\tau \, ds, \qquad (6.60)$$

where we also used the fact that $P_{\tau}q_{\rm BS}(w,x) = P_{\tau}P_w u_K(x) = P_{\tau+w}u_K(x) = q_{\rm BS}(w+\tau,x)$. By (6.28) we have

$$Gq_{\rm BS}(\tau+w,x) \le \sqrt{\frac{Kx}{8\pi(\tau+w)}} \exp\left(-\frac{\log^2\left(\frac{x}{K}\right)}{2(\tau+w)}\right). \tag{6.61}$$

Consider the function $r \in \mathbb{R}^+ \mapsto \sqrt{r} \exp\left(-r \frac{\log^2\left(\frac{x}{K}\right)}{2}\right) \in \mathbb{R}$. It is possible to check that such a function has a maximum at $r_\star = \log^{-2}\left(\frac{x}{K}\right)$ and then

$$\sqrt{r} \exp\left(-r \frac{\log^2\left(\frac{x}{K}\right)}{2}\right) \le \frac{1}{\sqrt{e}} \left|\log^{-1}\left(\frac{x}{K}\right)\right|.$$

Plugging the latter into (6.61), adding $\lambda q_{\rm BS}(\tau + w, x)$ and also using (6.29) we get

$$(G+\lambda)q_{\rm BS}(\tau+w,x) \le \sqrt{\frac{Kx}{8\pi e}} \left|\log^{-1}\left(\frac{x}{K}\right)\right| + \lambda e^{|\log(x)|}.$$

Plugging this inequality into (6.60) we obtain

$$\begin{split} &\int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} \left| (G-\lambda) q_{\mathrm{BS}}(w,y) \right| p_{\mathrm{GBM}}(\tau,y;x) \, dw \, dy \, d\tau \, ds \\ &\leq \frac{1}{\lambda} \left(\sqrt{\frac{Kx}{8\pi e}} \left| \log^{-1} \left(\frac{x}{K} \right) \right| + \lambda e^{|\log(x)|} \right) \int_{0}^{+\infty} \int_{0}^{+\infty} \tau^{\alpha-1} (1-e^{-\lambda s}) s^{-\alpha-1} e^{-\lambda \tau} \, d\tau \, ds \\ &= \frac{1}{\lambda} \left(\sqrt{\frac{Kx}{8\pi e}} \left| \log^{-1} \left(\frac{x}{K} \right) \right| + \lambda e^{|\log(x)|} \right) \left(\int_{0}^{+\infty} \tau^{\alpha-1} e^{-\lambda \tau} \, d\tau \right) \left(\int_{0}^{+\infty} s^{-\alpha-1} (1-e^{-\lambda s}) \, ds \right) \\ &= \frac{1}{\lambda} \left(\sqrt{\frac{Kx}{8\pi e}} \left| \log^{-1} \left(\frac{x}{K} \right) \right| + \lambda e^{|\log(x)|} \right) \frac{\Gamma(\alpha)\Gamma(1-\alpha)}{\alpha} < \infty \end{split}$$

where, in the last step, we used the integral representation of the Gamma function that

$$\int_0^{+\infty} s^{-\alpha-1} (1-e^{-\lambda s}) \, ds = \frac{\Gamma(1-\alpha)}{\alpha} \lambda^{\alpha}.$$

We can now safely use Fubini's theorem in (6.56), obtaining

$$\begin{split} &\int_{0}^{\infty} e^{-\lambda t} \left(\partial_{t} - G\right)^{\alpha} q(x, t) dt \\ &= -\frac{\alpha \lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{w}^{+\infty} \tau^{\alpha - 1} s^{-\alpha - 1} e^{-\lambda(\tau + w)} \left(G - \lambda\right) q_{\rm BS}(w, y) p_{\rm GBM}(\tau, y; x) ds dy d\tau dw \\ &= -\frac{\lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \int_{0}^{+\infty} \tau^{\alpha - 1} w^{-\alpha} e^{-\lambda(\tau + w)} P_{\tau} \left(G - \lambda\right) q_{\rm BS}(w, x) d\tau dw \\ &= -\frac{\lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \int_{0}^{+\infty} \tau^{\alpha - 1} w^{-\alpha} e^{-\lambda(\tau + w)} \left(G - \lambda\right) q_{\rm BS}(\tau + w, x) d\tau dw \\ &= -\frac{\lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \int_{w}^{+\infty} (z - w)^{\alpha - 1} w^{-\alpha} \left(G - \lambda\right) e^{-\lambda z} q_{\rm BS}(z, x) dz dw \\ &= -\frac{\lambda^{\alpha - 1}}{\Gamma(\alpha) \Gamma(1 - \alpha)} \int_{0}^{\infty} \left(G - \lambda\right) e^{-\lambda z} q_{\rm BS}(z, x) \left(\int_{0}^{z} (z - w)^{\alpha - 1} w^{-\alpha} dw\right) dz \end{split}$$

$$= -\lambda^{\alpha - 1} \int_0^\infty \left(G - \lambda \right) \, e^{-\lambda z} q_{\rm BS}(z, x) dz,\tag{6.62}$$

where in the third equality we used that $P_{\tau}q_{\rm BS}(w,y) = P_{\tau}P_w u_K(x) = P_{\tau+w}u_K(x) = q_{\rm BS}(\tau+w,x)$, in the fourth equality we used the change of variables $\tau = z - w$, in the fifth equality we used again Fubini's theorem and in the last equality we used the integral representation of the Beta function. Now notice that (6.29), (6.30) and (6.31) guarantee that we can take the Laplace transform in the variable t on both sides of the first equation of (6.33), leading to

$$\lambda \int_0^{+\infty} e^{-\lambda z} q_{\rm BS}(z, x) dz - u_K(x) = \int_0^{+\infty} e^{-\lambda z} G q_{\rm BS}(z, x) dz$$

This equality can be rearranged to obtain

$$\int_0^{+\infty} (\lambda - G)e^{-\lambda z} q_{\rm BS}(z, x) dz = u_K(x)$$

which, replaced into (6.62) gives (6.50).

By injectivity of the Laplace transform, we know that for all x > 0 there exists a measurable set $\mathcal{I}_x \subset \mathbb{R}^+$ such that $|\mathcal{I}_x| = 0$ and for all $t \in \mathbb{R}^+ \setminus \mathcal{I}_x$ one has

$$(\partial_t - G)^{\alpha} q(t, x) = \frac{t^{-\alpha}}{\Gamma(1 - \alpha)} q(0, x)$$

We want to prove that $\mathcal{I}_x = \emptyset$ for all x > 0. To do this, we first show that q is continuous. Indeed, let t, x > 0 and consider a sequence $(t_n, x_n) \to (t, x)$. By (6.22) and (6.39) we have

$$q(t_n, x_n) = \int_0^1 q_{\rm BS}(t_n s, x_n) \frac{(1-s)^{-\alpha} s^{\alpha-1}}{\Gamma(1-\alpha)\Gamma(\alpha)} ds.$$

Since $x_n \to x$, there exist 0 < a < b such that $x_n \in [a, b]$ for all $n \in \mathbb{N}$ and then $|q_{BS}(t_n s, x_n)| \leq e^{\max\{|\log(a)|, |\log(b)|\}}$. Hence, we can use the dominated convergence theorem to get

$$\lim_{n \to +\infty} q(t_n, x_n) = \int_0^1 q_{\rm BS}(ts, x) \frac{(1-s)^{-\alpha} s^{\alpha-1}}{\Gamma(1-\alpha)\Gamma(\alpha)} ds = q(t, x)$$

Now we prove that for fixed x > 0 the function $(\partial_t - G)^{\alpha}q(\cdot, x)$ is right-continuous. Indeed, let $t_n \downarrow t$ for some t > 0 and observe that

$$\begin{split} &|(\partial_t - G)^{\alpha}q(t_n, x) - (\partial_t - G)^{\alpha}q(t, x)| \\ &\leq \frac{\alpha}{\Gamma(1 - \alpha)} \int_0^t |P_s q(t - s, x) - q(t, x) - P_s q(t_n - s, x) + q(t_n, x)|s^{-1 - \alpha} ds \\ &+ \frac{\alpha}{\Gamma(1 - \alpha)} \int_t^{t_n} |P_s q(t_n - s, x) - q(t_n, x)|s^{-1 - \alpha} ds \\ &+ \frac{t^{-\alpha} - t_n^{-\alpha}}{\Gamma(1 - \alpha)} |q(t, x)| + |q(t, x) - q(t_n, x)| \frac{t_n^{-\alpha}}{\Gamma(1 - \alpha)} \\ &:= \frac{\alpha}{\Gamma(1 - \alpha)} \left(I_n(x) + J_n(x) + \frac{t^{-\alpha} - t_n^{-\alpha}}{\alpha} |q(t, x)| + |q(t, x) - q(t_n, x)| \frac{t_n^{-\alpha}}{\alpha} \right) \end{split}$$

Let us first consider $I_n(x)$. We have

$$|P_sq(t-s,x) - q(t,x) - P_sq(t_n - s,x) + q(t_n,x)| \le |P_sq(t-s,x) - P_sq(t_n - s,x)| + |q(t,x) - q(t_n,x)|$$

$$\leq P_{s}|q(t_{n}-s,\cdot) - q(t-s,\cdot)|(x) + |q(t,x) - q(t_{n},x)|$$

Arguing as in the proof of Corollary 6.13, we have that $|q(t-s,\cdot) - q(t_n-s,\cdot)| \in \mathcal{C}_0(1/2)$ with $t_n - s - (t_n - t)$

$$[|q(t-s,\cdot) - q(t_n-s,\cdot)|]_{1/2} \le \frac{\Gamma\left(\alpha + \frac{1}{2}\right)(t_n-t)}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t-s}}.$$

Hence, by Item (5) of Lemma 6.8 we have

$$P_{s}|q(t_{n}-s,\cdot)-q(t-s,\cdot)|(x) \leq 2\frac{\Gamma\left(\alpha+\frac{1}{2}\right)(t_{n}-t)}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t-s}}e^{\frac{3}{8}s+\frac{|\log(x)|}{2}}$$

Combining this inequality with the fact that q is continuous, for fixed $s \in [0, t)$, we find

$$\lim_{n \to \infty} |P_s q(t - s, x) - q(t, x) - P_s q(t_n - s, x) + q(t_n, x)| = 0.$$

Hence, it is sufficient to show that we can use the dominated convergence theorem to take the limit inside the integral sign in $I_n(x)$. To do this, observe that

$$|P_{s}q(t-s,x) - q(t,x) - P_{s}q(t_{n}-s,x) + q(t_{n},x)| \leq |P_{s}q(t-s,x) - P_{s}q(t,x)| + |P_{s}q(t,x) - q(t,x)| + |P_{s}q(t_{n}-s,x) - P_{s}q(t_{n},x)| + |P_{s}q(t_{n},x) - q(t_{n},x)| \leq P_{s}|q(t-s,\cdot) - q(t,\cdot)|(x) + |P_{s}q(t,x) - q(t,x)| + P_{s}|q(t_{n}-s,\cdot) - q(t_{n},\cdot)|(x) + |P_{s}q(t_{n},x) - q(t_{n},x)|.$$
(6.63)

Again recall that $|q(t-s, \cdot) - q(t, \cdot)| \in \mathcal{C}_0(1/2)$ with

$$[|q(t-s,\cdot) - q(t,\cdot)|]_{1/2} \le \frac{\Gamma\left(\alpha + \frac{1}{2}\right)s}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t-s}}$$

hence, by Item (5) of Lemma 6.8,

$$P_{s}|q(t-s,\cdot)-q(t,\cdot)|(x) \leq \frac{2\Gamma\left(\alpha+\frac{1}{2}\right)s}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t-s}}e^{\frac{3}{8}t+\frac{|\log(x)|}{2}}$$

$$\leq \frac{2\Gamma\left(\alpha+\frac{1}{2}\right)s}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t-s}}e^{\frac{3}{8}t_{1}+\frac{|\log(x)|}{2}}$$

$$P_{s}|q(t_{n}-s,\cdot)-q(t_{n},\cdot)|(x) \leq \frac{2\Gamma\left(\alpha+\frac{1}{2}\right)s}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t_{n}-s}}e^{\frac{3}{8}t_{n}+\frac{|\log(x)|}{2}}$$

$$\leq \frac{2\Gamma\left(\alpha+\frac{1}{2}\right)s}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t-s}}e^{\frac{3}{8}t_{1}+\frac{|\log(x)|}{2}}.$$
(6.64)

Furthermore, notice that

$$P_{s}q(t,x) - q(t,x) = \int_{0}^{s} GP_{\tau}q(t,x) \, d\tau = \int_{0}^{s} P_{\tau}Gq(t,x) \, d\tau$$

where we used Item (3) of Lemma 6.8 since $q(t, \cdot), \partial_x q(t, \cdot)$ and $Gq(t, \cdot)$ belong to \mathcal{C}_0 . In particular, recall that, by (6.47), that $Gq(t, \cdot) \in \mathcal{C}_0(1/2)$ and

$$[Gq(t,\cdot)]_{\frac{1}{2}} \le \sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)}.$$

Hence, by Item (5) of Lemma 6.8 we get, since $\tau \leq s \leq t$

$$\begin{aligned} |P_{\tau}Gq(t,x)| &\leq 2\sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} e^{\frac{3}{8}\tau + \frac{|\log(x)|}{2}} \\ &\leq 2\sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}} \end{aligned}$$

and then

$$|P_sq(t,x) - q(t,x)| \le 2\sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}}s$$
(6.66)

Analogously,

$$|P_sq(t_n,x) - q(t_n,x)| \le 2\sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}}s.$$
(6.67)

Combining (6.64), (6.65), (6.66) and (6.67) with (6.63) we have

$$\begin{aligned} |P_{s}q(t-s,x) - q(t,x) - P_{s}q(t_{n}-s,x) + q(t_{n},x)| \\ &\leq \frac{4\Gamma\left(\alpha + \frac{1}{2}\right)s}{\pi\Gamma(\alpha)}\sqrt{\frac{K}{t-s}}e^{\frac{3}{8}t_{1} + \frac{|\log(x)|}{2}} + 4\sqrt{\frac{K}{2t}}\frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)}e^{\frac{3}{8}t_{1} + \frac{|\log(x)|}{2}}s. \end{aligned}$$

Integrating the latter against $s^{-1-\alpha}$ we get

$$\begin{split} \int_{0}^{t} |P_{s}q(t-s,x) - q(t,x) - P_{s}q(t_{n}-s,x) + q(t_{n},x)|s^{-1-\alpha} \, ds \\ &\leq \frac{4\Gamma\left(\alpha + \frac{1}{2}\right)}{\pi\Gamma(\alpha)} \sqrt{K}e^{\frac{3}{8}t_{1} + \frac{|\log(x)|}{2}} \int_{0}^{t} (t-s)^{-\frac{1}{2}}s^{-\alpha} \, ds \\ &\quad + 4\sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)}e^{\frac{3}{8}t_{1} + \frac{|\log(x)|}{2}} \int_{0}^{t} s^{-\alpha} \, ds \\ &= \frac{4\Gamma\left(\alpha + \frac{1}{2}\right)\Gamma(1-\alpha)}{\Gamma(\alpha)\Gamma\left(\frac{3}{2} - \alpha\right)} \sqrt{\frac{K}{\pi}}e^{\frac{3}{8}t_{1} + \frac{|\log(x)|}{2}}t^{\frac{1}{2}-\alpha} \\ &\quad + 4\sqrt{\frac{K}{2}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi(1-\alpha)\Gamma(\alpha)}e^{\frac{3}{8}t_{1} + \frac{|\log(x)|}{2}}t^{\frac{1}{2}-\alpha} \end{split}$$

where we also used [3, Lemma 1.11]. Hence, we can use the dominated convergence theorem to guarantee that

$$\lim_{n \to \infty} I_n(x) = 0.$$

Next, we move to $J_n(x)$. We have, arguing as before and recalling that this time $s \in [t_n, t]$,

$$\begin{aligned} |P_s q(t_n - s, x) - q(t_n, x)| &\leq |P_s q(t_n - s, x) - P_s q(t_n, x)| + |P_s q(t_n, x) - q(t_n, x)| \\ &\leq P_s |q(t_n - s, \cdot) - q(t_n, \cdot)| + |P_s q(t_n, x) - q(t_n, x)| \\ &\leq \frac{2\Gamma\left(\alpha + \frac{1}{2}\right)s}{\pi\Gamma(\alpha)} \sqrt{\frac{K}{t_n - s}} e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}} + 2\sqrt{\frac{K}{2t}} \frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)} e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}}s. \end{aligned}$$

Hence,

 $J_n(x)$

$$\leq \frac{2\Gamma\left(\alpha + \frac{1}{2}\right)}{\pi\Gamma(\alpha)}\sqrt{K}e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}} \int_t^{t_n} (t_n - s)^{-\frac{1}{2}}s^{-\alpha} \, ds + 2\sqrt{\frac{K}{2t}}\frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi\Gamma(\alpha)}e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}} \int_t^{t_n} s^{-\alpha} ds \\ = \frac{2\Gamma\left(\alpha + \frac{1}{2}\right)}{\pi\Gamma(\alpha)}\sqrt{K}e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}} \int_0^{t_n - t} w^{-\frac{1}{2}}(t_n - w)^{-\alpha} \, dw + 2\sqrt{\frac{K}{2t}}\frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi(1 - \alpha)\Gamma(\alpha)}e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}}(t_n^{1 - \alpha} - t^{1 - \alpha}) \\ = \frac{2\Gamma\left(\alpha + \frac{1}{2}\right)}{\pi\Gamma(\alpha)}\sqrt{K}e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}}t_n^{\frac{1}{2} - \alpha} \int_0^{1 - \frac{t}{t_n}} z^{-\frac{1}{2}}(1 - z)^{-\alpha} \, dz + 2\sqrt{\frac{K}{2t}}\frac{\Gamma\left(\alpha - \frac{1}{2}\right)}{2\pi(1 - \alpha)\Gamma(\alpha)}e^{\frac{3}{8}t_1 + \frac{|\log(x)|}{2}}(t_n^{1 - \alpha} - t^{1 - \alpha}).$$

Hence, taking the limit as $n \to \infty$, we get

$$\lim_{n \to \infty} J_n(x) = 0.$$

Combined with the fact that also the remaining terms converge to 0 as $n \to \infty$, this finally shows that

$$\lim_{n \to \infty} (\partial_t - G)^{\alpha} q(t_n, x) = (\partial_t - G)^{\alpha} q(t, x).$$

Now we prove that $\mathcal{I}_x = \emptyset$ for all x > 0. Indeed, fix x > 0 and assume that $\mathcal{I}_x \neq \emptyset$. Let $t \in \mathcal{I}_x$ and consider an interval of the form $[t, t+\delta]$ for some $\delta > 0$. Since $|\mathcal{I}_x \cap [t, t+\delta]| = 0$, we know that there exists a sequence $t_n \downarrow t$ such that $t_n \notin \mathcal{I}_x$ for all $n \in \mathbb{N}$. For such a sequence, we know that

$$(\partial_t - G)^{\alpha} q(t_n, x) = \frac{t_n^{-\alpha}}{\Gamma(1 - \alpha)} q(0, x).$$

Taking the limit as $n \to \infty$ we get

$$(\partial_t - G)^{\alpha} q(t, x) = \frac{t^{-\alpha}}{\Gamma(1 - \alpha)} q(0, x)$$

that is absurd. Hence $\mathcal{I}_x = \emptyset$ and thus we get that

$$(\partial_t - G)^{\alpha} q(t, x) = \frac{t^{-\alpha}}{\Gamma(1 - \alpha)} q(0, x), \qquad \forall t, x > 0.$$
(6.68)

Finally, we notice that $q \in \mathcal{C}_{0,\text{loc}}(\mathbb{R}^+_0)$ by Proposition 6.14.

Remark 6.19. Actually, the first equality in (6.36) guarantees that $(\partial_t - G)^{\alpha}q$ is continuous in both variables. 6.2.3. Uniqueness of the solution. In order to prove that (6.36) has a unique solution, we need to consider an auxiliary problem. For $\beta \ge 0$ consider the function $f_{\beta}(x) = e^{\beta |\log(x)|}$ and, by Item (4) of Lemma 6.8,

$$\begin{split} u_{\beta}(t,x) &= P_t f_{\beta}(x) = e^{\beta \log(x) + \frac{\beta(\beta-1)}{2}t} \Phi\left(-\left(\beta - \frac{1}{2}\right)\sqrt{t} - \frac{\log(x)}{\sqrt{t}}\right) \\ &+ e^{-\beta \log(x) + \frac{\beta(\beta+1)}{2}t} \Phi\left(-\left(\beta + \frac{1}{2}\right)\sqrt{t} + \frac{\log(x)}{\sqrt{t}}\right). \end{split}$$

Let us give some preliminary estimates on u_{β} , that can be verified by direct evaluation.

Lemma 6.20. For all $\beta \ge 0$ and t, x > 0 we have:

$$\partial_x u_\beta(t,x) = \beta e^{\frac{\beta(\beta-1)}{2}t + (\beta-1)\log(x)} \Phi\left(-\left(\beta - \frac{1}{2}\right)\sqrt{t} - \frac{\log(x)}{\sqrt{t}}\right) - \beta e^{\frac{\beta(\beta+1)}{2}t - (\beta+1)\log(x)} \Phi\left(-\left(\beta + \frac{1}{2}\right)\sqrt{t} + \frac{\log(x)}{\sqrt{t}}\right) \partial_x^2 u_\beta(t,x) = \beta(\beta-1) e^{\frac{\beta(\beta-1)}{2}t + (\beta-2)\log(x)} \Phi\left(-\left(\beta - \frac{1}{2}\right)\sqrt{t} - \frac{\log(x)}{\sqrt{t}}\right)$$
(6.69)

$$+ \beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}t - (\beta+2)\log(x)} \Phi\left(-\left(\beta+\frac{1}{2}\right)\sqrt{t} + \frac{\log(x)}{\sqrt{t}}\right) \\ - \sqrt{\frac{2\beta^2}{\pi t}}e^{-\frac{t}{8} - \frac{3}{2}\log(x) - \frac{\log^2(x)}{2t}}$$
(6.70)

$$\partial_{t}u_{\beta}(t,x) = Gu_{\beta}(t,x) = \frac{\beta(\beta-1)}{2}e^{\frac{\beta(\beta-1)}{2}t+\beta\log(x)}\Phi\left(-\left(\beta-\frac{1}{2}\right)\sqrt{t}-\frac{\log(x)}{\sqrt{t}}\right) +\frac{\beta(\beta+1)}{2}e^{\frac{\beta(\beta+1)}{2}t-\beta\log(x)}\Phi\left(-\left(\beta+\frac{1}{2}\right)\sqrt{t}+\frac{\log(x)}{\sqrt{t}}\right) -\frac{\beta}{\sqrt{2\pi t}}e^{-\frac{t}{8}+\frac{\log(x)}{2}-\frac{\log^{2}(x)}{2t}}.$$
(6.71)

In particular,

$$|u_{\beta}(t,x)| \le 2e^{\frac{\beta(\beta+1)}{2}t+\beta|\log(x)|}$$
(6.72)

$$\left|\partial_x u_\beta(t,x)\right| \le 2\beta e^{\frac{\beta(\beta+1)}{2}t + (\beta+1)|\log(x)|} \tag{6.73}$$

$$|\partial_x^2 u_\beta(t,x)| \le 2\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}t + (\beta+2)|\log(x)|} + \frac{\beta\sqrt{2}}{\sqrt{\pi t}}e^{\frac{3}{2}|\log(x)|}$$
(6.74)

$$|\partial_t u_\beta(t,x)| = |Gu_\beta(t,x)| \le \beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}t+\beta|\log(x)|} + \frac{\beta}{\sqrt{2\pi t}}e^{\frac{|\log(x)|}{2}}.$$
(6.75)

Now consider the function

$$q_{\beta}(t,x) = \int_{0}^{t} u_{\beta}(s,x) g_{H}(s;t) \, ds = \int_{0}^{t} u_{\beta}(s,x) \frac{s^{\alpha-1}(t-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \, ds = \int_{0}^{1} u_{\beta}(st,x) \frac{s^{\alpha-1}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \, ds. \tag{6.76}$$

Similarly to what we did for q, we need to prove some regularity results for q_{β} . We start with the following proposition, concerning the regularity in the t variable.

Proposition 6.21. Let $\Phi(\lambda) = \lambda^{\alpha}$ for some $\alpha \in (0,1)$ and $\beta \geq 0$. Then for all x > 0 the function $q_{\beta}(\cdot, x)$ belongs to $AC(\mathbb{R}^+_0)$ and its a.e. derivative $\partial_t q_{\beta}(\cdot, x)$ satisfies

$$\left|\partial_t q_\beta(t,x)\right| \le \alpha\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}(t+1)+\beta|\log(x)|} + \frac{2\beta\Gamma\left(\frac{1}{2}+\alpha\right)}{\pi\sqrt{t}\Gamma(\alpha)}e^{\frac{|\log(x)|}{2}}.$$
(6.77)

In particular, for all t, x > 0

$$\frac{\alpha}{\Gamma(1-\alpha)} \int_0^t |P_s q_\beta(t-s,x) - P_s q_\beta(t,x)| s^{-1-\alpha} \, ds < \infty$$

and for all x > 0 and $\lambda > \max\left\{\beta(\beta+1), \frac{3}{4}\right\}$

$$\frac{\alpha}{\Gamma(1-\alpha)} \int_0^{+\infty} \int_0^t e^{-\lambda t} |P_s q_\beta(t-s,x) - P_s q_\beta(t,x)| s^{-1-\alpha} \, ds \, dt < \infty.$$
(6.78)

Proof. Arguing as in Proposition 6.12, let t > 0 and $h \in \left(-\frac{t}{2}, 1\right)$. We have

$$\left|\frac{q_{\beta}(t+h,x)-q_{\beta}(t,x)}{h}\right| \le \int_{0}^{1} \left|\frac{u_{\beta}(st+sh,x)-u_{\beta}(st,x)}{sh}\right| \frac{s^{\alpha}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \, ds.$$
(6.79)

By Lagrange's theorem we know that there exists $\xi \in [\min\{ts, ts + hs\}, \max\{ts, ts + hs\}] \subseteq [\frac{ts}{2}, (t+1)s]$ such that

$$\begin{aligned} \left| \frac{u_{\beta}(st+sh,x) - u_{\beta}(st,x)}{sh} \right| &= \left| \partial_{t} u_{\beta}(\xi,x) \right| \\ &\leq \beta(\beta+1) e^{\frac{\beta(\beta+1)}{2}\xi+\beta|\log(x)|} + \frac{\beta}{\sqrt{2\pi\xi}} e^{\frac{|\log(x)|}{2}} \\ &\leq \beta(\beta+1) e^{\frac{\beta(\beta+1)}{2}(t+1)s+\beta|\log(x)|} + \frac{\beta}{\sqrt{\pi ts}} e^{\frac{|\log(x)|}{2}}, \end{aligned}$$

where we used (6.75). Using this bound into (6.79) we get

$$\begin{split} \left| \frac{q_{\beta}(t+h,x) - q_{\beta}(t,x)}{h} \right| \\ &\leq \beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}(t+1) + \beta|\log(x)|} \int_{0}^{1} \frac{s^{\alpha}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \, ds \\ &\quad + \frac{\beta}{\sqrt{\pi t}} e^{\frac{|\log(x)|}{2}} \int_{0}^{1} \frac{s^{\alpha-\frac{1}{2}}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \, ds \\ &= \alpha\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}(t+1) + \beta|\log(x)|} + \frac{2\beta\Gamma\left(\frac{1}{2}+\alpha\right)}{\pi\sqrt{t}\Gamma(\alpha)}e^{\frac{|\log(x)|}{2}}. \end{split}$$

Arguing as in Proposition 5.4, this implies that $q_{\beta}(\cdot, x)$ belongs to $AC(\mathbb{R}^+_0)$ and that its a.e. derivative $\partial_t q_{\beta}(t, x)$ satisfies (6.77).

Next, observe that

$$\begin{aligned} |q_{\beta}(t-s,x) - q_{\beta}(t,x)| &\leq \int_{0}^{s} \left|\partial_{t}q(t-\tau,x)\right| d\tau \\ &\leq \alpha\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}(t+1)+\beta|\log(x)|}s + \frac{2s\beta\Gamma\left(\frac{1}{2}+\alpha\right)}{\pi\sqrt{t-s}\Gamma(\alpha)}e^{\frac{|\log(x)|}{2}}. \end{aligned}$$

Setting $\widetilde{\beta} = \max\left\{\frac{1}{2}, \beta\right\}$, we have that $|q_{\beta}(t-s, \cdot) - q_{\beta}(t, \cdot)| \in \mathcal{C}_{0}(\widetilde{\beta})$ with

$$[q_{\beta}(t-s,\cdot)-q_{\beta}(t,\cdot)]_{\widetilde{\beta}} \leq \alpha\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}(t+1)s} + \frac{2s\beta\Gamma\left(\frac{1}{2}+\alpha\right)}{\pi\sqrt{t-s}\Gamma(\alpha)}$$

and then, by Item (5) of Lemma 6.8

$$P_{s}|q_{\beta}(t-s,\cdot)-q_{\beta}(t,\cdot)| \leq \left(2\alpha\beta(\beta+1)e^{\widetilde{\beta}(\widetilde{\beta}+1)(t+1)}s+\frac{4s\beta\Gamma\left(\frac{1}{2}+\alpha\right)}{\pi\sqrt{t-s}\Gamma(\alpha)}e^{\frac{\widetilde{\beta}(\widetilde{\beta}+1)}{2}t}\right)e^{\widetilde{\beta}|\log(x)|}.$$
 (6.80)

Thus we have

$$\frac{\alpha}{\Gamma(1-\alpha)} \int_0^t |P_s q_\beta(t-s,x) - P_s q_\beta(t,x)| s^{-1-\alpha} \, ds$$

$$\leq \left(\frac{2\alpha^2 \beta(\beta+1)}{\Gamma(2-\alpha)} e^{\widetilde{\beta}(\widetilde{\beta}+1)(t+1)} t^{1-\alpha} + \frac{4\alpha\beta\Gamma\left(\frac{1}{2}+\alpha\right)}{\sqrt{\pi}\Gamma(\alpha)\Gamma\left(\frac{3}{2}-\alpha\right)} e^{\frac{\widetilde{\beta}(\widetilde{\beta}+1)}{2}t} t^{\frac{1}{2}-\alpha} \right) e^{\widetilde{\beta}|\log(x)|}$$

that also implies (6.78) with $\lambda > \widetilde{\beta}(\widetilde{\beta} + 1)$.

Next, we need to study the regularity of q_{β} in the x variable. Let us first focus on the first derivative.

Proposition 6.22. For all t, x > 0, we have

$$\partial_x q_\beta(t,x) = \frac{1}{\Gamma(\alpha)\Gamma(1-\alpha)} \int_0^1 \partial_x u_\beta(t\tau,x) \tau^{\alpha-1} (1-\tau)^{-\alpha} d\tau.$$
(6.81)

Furthermore, $q_{\beta} \in C_0(\beta)$ and $\partial_x q_{\beta} \in C_0(\beta+1)$, with

$$[q_{\beta}(t,\cdot)]_{\beta} \le 2e^{\frac{\beta(\beta+1)}{2}t} \tag{6.82}$$

$$[\partial_x q_\beta(t,\cdot)]_\beta \le 2\beta e^{\frac{\beta(\beta+1)}{2}t}.$$
(6.83)

Proof. The identity (6.81) follows by (6.76) by a simple application of the dominated convergence theorem, which is justified by (6.73). Furthermore, (6.72) and (6.73) imply respectively (6.82) and (6.83).

For the second derivative, we need a further assumption.

Proposition 6.23. Let $\alpha \in (\frac{1}{2}, 1)$ and $\beta \geq 0$. Then, for all t, x > 0, we have

$$\partial_x^2 q_\beta(t,x) = \frac{1}{\Gamma(\alpha)\Gamma(1-\alpha)} \int_0^1 \partial_x^2 u_\beta(t\tau,x)\tau^{\alpha-1}(1-\tau)^{-\alpha}d\tau.$$
(6.84)

$$Gq_{\beta}(t,x) = \frac{1}{\Gamma(\alpha)\Gamma(1-\alpha)} \int_0^1 Gu_{\beta}(t\tau,x)\tau^{\alpha-1}(1-\tau)^{-\alpha}d\tau.$$
(6.85)

Moreover, $Gq_{\beta} \in \mathcal{C}_0(\widetilde{\beta})$ with $\widetilde{\beta} = \max\left\{\beta, \frac{1}{2}\right\}$ and

$$[Gq_{\beta}(t,\cdot)]_{\widetilde{\beta}} \leq \beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}t} + \frac{\beta\Gamma\left(\alpha - \frac{1}{2}\right)\Gamma(1-\alpha)}{\pi\sqrt{2t}}.$$
(6.86)

As a consequence, for all t, x > 0,

$$\frac{\alpha}{\Gamma(1-\alpha)} \int_0^t |P_s q(t,x) - q(t,x)| s^{-1-\alpha} \, ds < \infty,$$

and for all x > 0 and $\lambda > \widetilde{\beta}(\widetilde{\beta} + 1)$,

$$\frac{\alpha}{\Gamma(1-\alpha)} \int_0^\infty \int_0^t e^{-\lambda t} |P_s q(t,x) - q(t,x)| s^{-1-\alpha} \, ds \, dt < \infty.$$
(6.87)

Proof. Fix x, t > 0 and let 0 < a < x < b. For $y \in [a, b]$ and $\tau \in [0, 1]$, by (6.74), we have

$$|\partial_x^2 u_\beta(t\tau, y)| \le 2\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}t + (\beta+2)M} + \frac{\beta\sqrt{2}}{\sqrt{\pi t\tau}}e^{\frac{3M}{2}},$$

where $M = \max\{|\log(a)|, |\log(b)|\}$. Notice that the right-hand side is integrable against $g_H(\tau, 1)$. Indeed,

$$\int_{0}^{1} \left(2\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}t + (\beta+2)M} + \frac{\beta}{\sqrt{2\pi t\tau}}e^{\frac{M}{2}} \right) \tau^{\alpha-1}(1-\tau)^{-\alpha} d\tau$$
$$= 2\beta(\beta+1)e^{\frac{\beta(\beta+1)}{2}t + (\beta+2)M} + \frac{\beta\Gamma\left(\alpha - \frac{1}{2}\right)\Gamma(1-\alpha)\sqrt{2}}{\pi\sqrt{t}}e^{\frac{3M}{2}}.$$

Hence, an application of the dominated convergence theorem to (6.81) leads to (6.84). Furthermore, multiplying both sides of (6.84) by $\frac{x^2}{2}$ we get (6.85) and (6.86) follows by (6.85) and (6.75).

Now observe that by Proposition 6.23 we know that $q_{\beta}(t, \cdot), \partial_x q_{\beta}(t, \cdot) \in \mathcal{C}_0$, while we also proved that $Gq_{\beta}(t, \cdot) \in \mathcal{C}_0$. Hence we can write

$$P_s q_\beta(t,x) - q_\beta(t,x) = \int_0^s G P_\tau q_\beta(t,x) \, d\tau = \int_0^s P_\tau G q_\beta(t,x) \, d\tau$$

Furthermore, by (6.86) and Item (5) of Lemma 6.8 we get for $\tau \in [0, s] \subseteq [0, t]$

$$P_{\tau}|Gq_{\beta}(t,\cdot)| \leq \left(\beta(\beta+1)e^{\widetilde{\beta}(\widetilde{\beta}+1)t} + \frac{\beta\Gamma\left(\alpha - \frac{1}{2}\right)\Gamma(1-\alpha)}{\pi\sqrt{2t}}e^{\frac{\widetilde{\beta}(\widetilde{\beta}+1)}{2}t}\right)e^{\widetilde{\beta}|\log(x)|}.$$
(6.88)

Thus, we have

$$|P_{s}q_{\beta}(t,x) - q(t,x)| \leq \left(\beta(\beta+1)e^{\widetilde{\beta}(\widetilde{\beta}+1)t} + \frac{\beta\Gamma\left(\alpha - \frac{1}{2}\right)\Gamma(1-\alpha)}{\pi\sqrt{2t}}e^{\frac{\widetilde{\beta}(\widetilde{\beta}+1)}{2}t}\right)se^{\widetilde{\beta}|\log(x)|}.$$
 (6.89)

and then

$$\frac{\alpha}{\Gamma(1-\alpha)} \int_0^t |P_s q_\beta(t,x) - q(t,x)| s^{-1-\alpha} \, ds$$

$$\leq \frac{\alpha}{\Gamma(2-\alpha)} \left(\beta(\beta+1) e^{\widetilde{\beta}(\widetilde{\beta}+1)t} + \frac{\beta\Gamma\left(\alpha - \frac{1}{2}\right)\Gamma(1-\alpha)}{\pi\sqrt{2t}} e^{\frac{\widetilde{\beta}(\widetilde{\beta}+1)}{2}t} \right) t^{1-\alpha} e^{\widetilde{\beta}|\log(x)|}.$$

Eventually, the latter inequality implies (6.87) for $\lambda > \tilde{\beta}(\tilde{\beta} + 1)$.

Now we check that q_{β} satisfies Item (iii) of Theorem 3.3.

Proposition 6.24. Let $\alpha \in (0,1)$ and $\beta \geq 0$. Then, for all $\lambda > \frac{\beta(\beta+1)}{2}$ and x > 0 we have

$$\frac{1}{\Gamma(1-\alpha)}\int_0^\infty t^{-\alpha}e^{-\lambda t}|q_\beta(t,x)|\,dt<\infty.$$

Proof. By (6.82) we have

$$\frac{1}{\Gamma(1-\alpha)} \int_0^\infty t^{-\alpha} e^{-\lambda t} |q_\beta(t,x)| \, dt \le \frac{2e^{\beta|\log(x)|}}{\Gamma(1-\alpha)} \int_0^\infty t^{-\alpha} e^{-\left(\lambda - \frac{\beta(\beta+1)}{2}\right)t} \, dt$$
$$= 2e^{\beta|\log(x)|} \left(\lambda - \frac{\beta(\beta+1)}{2}\right)^{\alpha-1}.$$

We can now prove that q_{β} is a solution of a special fully nonlocal equation.

Proposition 6.25. Let $\alpha \in (\frac{1}{2}, 1)$ and $\beta \geq 0$. Then q_{β} is a solution of

$$\begin{cases} (\partial_t - G)^{\alpha} q_{\beta}(t, x) = \frac{t^{-\alpha}}{\Gamma(1-\alpha)} q_{\beta}(0, x) & t, x > 0\\ q_{\beta}(0, x) = e^{\beta |\log(x)|} & x > 0. \end{cases}$$

$$(6.90)$$

Proof. First notice that $q_{\beta}(0,x) = u_{\beta}(0,x) = e^{\beta |\log(x)|}$. By Propositions 6.21, 6.23 and 6.24 we know that $(\partial_t - G)^{\alpha}q_{\beta}(t,x)$ is well-defined for all t, x > 0 and for fixed x > 0 the function $(\partial_t - G)^{\alpha}q_{\beta}(\cdot,x)$ is Laplace transformable for $\lambda > \tilde{\beta}(\tilde{\beta}+1)$, where $\tilde{\beta} = \max \{\beta, \frac{1}{2}\}$. Now we show that

$$\int_0^\infty e^{-\lambda t} (\partial_t - G)^\alpha q_\beta(t, x) \, dt = \lambda^{\alpha - 1} e^{\beta |\log(x)|} \tag{6.91}$$

for $\lambda > \frac{1}{16} \left(\frac{1}{4} + \widetilde{\beta}(\widetilde{\beta} + 1) \right)$. This is done exactly as in Proposition 6.18, the only difference being the bound we prove to use Fubini's theorem in (6.56). Precisely, recall that $f_{\beta}(x) = e^{\beta |\log(x)|}$ and set

$$\overline{u}(t,x) = e^{-\frac{\log^2(x)}{2t}} f_{\widetilde{\beta}}(x)$$

and notice that, by (6.72) and (6.75)

$$|(G-\lambda)u_{\beta}(w,y)| \leq \left((\beta(\beta+1)+2\lambda)e^{\frac{\beta(\beta+1)}{2}w}f_{\widetilde{\beta}}(y) + \frac{\beta}{\sqrt{2\pi w}}\overline{u}(w,y) \right).$$

Hence, we have

$$\int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} \left| (G-\lambda) u_{\beta}(w,y) \right| p_{\text{GBM}}(\tau,y;x) \, dw \, dy \, d\tau \, ds$$

$$\leq \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} (\beta(\beta+1)+2\lambda) e^{\frac{\beta(\beta+1)}{2}w} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} u_{\widetilde{\beta}}(\tau,x) \, dw \, d\tau \, ds$$

$$+ \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \frac{\beta}{\sqrt{2\pi w}} \tau^{\alpha-1} s^{-\alpha-1} e^{-\lambda(\tau+w)} P_{\tau} \overline{u}(w,x) \, dw \, d\tau \, ds$$

$$= I_{1} + I_{2}. \tag{6.92}$$

Concerning I_1 , we have, by Item (5) of Lemma 6.8

$$I_{1} \leq 2(\beta(\beta+1)+2\lambda) \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} e^{-\left(\lambda - \frac{\tilde{\beta}(\tilde{\beta}+1)}{2}\right)(\tau+w)} \tau^{\alpha-1} s^{-\alpha-1} dw d\tau ds$$
$$= \frac{4(\beta(\beta+1)+2\lambda)}{2\lambda - \tilde{\beta}(\tilde{\beta}+1)} \left(\int_{0}^{+\infty} \left(1 - e^{-\left(\lambda - \frac{\tilde{\beta}(\tilde{\beta}+1)}{2}\right)s}\right) s^{-\alpha-1} ds\right)$$
$$\times \left(\int_{0}^{+\infty} e^{-\left(\lambda - \frac{\tilde{\beta}(\tilde{\beta}+1)}{2}\right)\tau} \tau^{\alpha-1} d\tau\right)$$
$$= \frac{4(\beta(\beta+1)+2\lambda)\Gamma(1-\alpha)\Gamma(\alpha)}{2\lambda - \tilde{\beta}(\tilde{\beta}+1)}.$$

For I_2 , we first need to evaluate $P_{\tau}\overline{u}(w,x)$. We have

$$P_{\tau}\overline{u}(w,x) = \int_{0}^{+\infty} e^{-\frac{\log^{2}(y)}{2w} + \widetilde{\beta}|\log(y)| - \frac{\tau}{8} - \frac{(\log(y) - \log(x))^{2}}{2\tau}} \sqrt{\frac{x}{y^{3}2\pi\tau}} \, dy$$
$$= \sqrt{x}e^{-\frac{\tau}{8} - \frac{\log^{2}(x)}{2\tau}} \int_{0}^{+\infty} e^{-\frac{\log^{2}(y)}{2w} - \frac{\log^{2}(y)}{2\tau} + \frac{\log(y)\log(x)}{\tau} + \widetilde{\beta}|\log(y)|} \frac{1}{\sqrt{y^{3}2\pi\tau}} \, dy.$$

Now let $z = \log(y)$ to achieve

$$P_{\tau}\overline{u}(w,x) = \sqrt{\frac{x}{2\pi\tau}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2\tau}} \int_{-\infty}^{+\infty} e^{-\frac{z^2}{2w} - \frac{z^2}{2\tau} + \frac{\log(x)}{\tau}z - \frac{z}{2} + \tilde{\beta}|z|} dz.$$

Define

$$\mathcal{H}(\tau, w) = \left(\frac{1}{w} + \frac{1}{\tau}\right)^{-1} \tag{6.93}$$

so that

$$\begin{split} P_{\tau}\overline{u}(w,x) &= \sqrt{\frac{x\mathcal{H}(\tau,w)}{\tau}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2\tau}} \int_{-\infty}^{+\infty} \frac{1}{\sqrt{2\pi\mathcal{H}(\tau,w)}} e^{-\frac{z^2}{2\mathcal{H}(\tau,w)} + \left(\frac{\log(x)}{\tau} - \frac{1}{2}\right)z + \widetilde{\beta}|z|} \, dz \\ &= \sqrt{\frac{x\mathcal{H}(\tau,w)}{\tau}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2\tau}} \, \mathbb{E}^{(0,0)} [e^{\widetilde{\beta}|B(\mathcal{H}(\tau,w))| + \left(\frac{\log(x)}{\tau} - \frac{1}{2}\right)B(\mathcal{H}(\tau,w))}] \\ &= \sqrt{\frac{x\mathcal{H}(\tau,w)}{\tau}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2\tau}} e^{\frac{1}{2}\left(\widetilde{\beta} + \frac{\log(x)}{\tau} - \frac{1}{2}\right)^2 \mathcal{H}(\tau,w)} \Phi\left(-\left(\widetilde{\beta} + \frac{\log(x)}{\tau} - \frac{1}{2}\right)\sqrt{t}\right) \\ &+ \sqrt{\frac{x\mathcal{H}(\tau,w)}{\tau}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2\tau}} e^{\frac{1}{2}\left(\widetilde{\beta} - \frac{\log(x)}{\tau} + \frac{1}{2}\right)^2 \mathcal{H}(\tau,w)} \Phi\left(-\left(\widetilde{\beta} - \frac{\log(x)}{\tau} + \frac{1}{2}\right)\sqrt{t}\right) \\ &= \sqrt{\frac{x\mathcal{H}(\tau,w)}{\tau}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2(\tau+w)} + A_1\mathcal{H}(\tau,w) + \left(\widetilde{\beta} - \frac{1}{2}\right)\frac{w}{\tau+w}\log(x)}} \Phi\left(-A_2\sqrt{t}\right) \\ &+ \sqrt{\frac{x\mathcal{H}(\tau,w)}{\tau}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2(\tau+w)} + B_1\mathcal{H}(\tau,w) - \left(\widetilde{\beta} + \frac{1}{2}\right)\frac{w}{\tau+w}\log(x)}} \Phi\left(-B_2\sqrt{t}\right), \end{split}$$

where

$$A_{1} = \frac{\tilde{\beta}^{2}}{2} + \frac{1}{8} - \frac{\tilde{\beta}}{2} B_{1} = \frac{\tilde{\beta}^{2}}{2} + \frac{1}{8} + \frac{\tilde{\beta}}{2}$$
$$A_{2} = \tilde{\beta} + \frac{\log(x)}{\tau} - \frac{1}{2} B_{2} = \beta - \frac{\log(x)}{\tau} + \frac{1}{2}$$

and we used Lemma 6.7. Furthermore, we have

$$\frac{\beta}{\sqrt{2\pi w}} P_{\tau} \overline{u}(w, x) = \beta \sqrt{\frac{x}{2\pi(\tau+w)}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2(\tau+w)} + A_1 \mathcal{H}(\tau, w) + \left(\tilde{\beta} - \frac{1}{2}\right) \frac{w}{\tau+w} \log(x)} \Phi\left(-A_2 \sqrt{t}\right)$$
$$+ 2\beta \sqrt{\frac{x}{2\pi(\tau+w)}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2(\tau+w)} + B_1 \mathcal{H}(\tau, w) - \left(\tilde{\beta} + \frac{1}{2}\right) \frac{w}{\tau+w} \log(x)} \Phi\left(-B_2 \sqrt{t}\right)$$
$$\leq \frac{\beta}{\sqrt{2\pi(\tau+w)}} e^{-\frac{\tau}{8} - \frac{\log^2(x)}{2(\tau+w)} + B_1 \mathcal{H}(\tau, w) + \left(\tilde{\beta} + 1\right) |\log(x)|},$$

where we used $B_1 > A_1$ and $\frac{w}{\tau+w} \leq 1$. Now recall that the function $r \in \mathbb{R}^+ \mapsto \sqrt{r}e^{-\frac{\log^2(x)}{2r}} \in \mathbb{R}^+$ admits as maximum point $r_\star = \log^{-2}(x)$, so that

$$\frac{\beta}{\sqrt{2\pi w}} P_{\tau} \overline{u}(w, x) \le \frac{\beta}{\sqrt{2\pi e}} |\log^{-1}(x)| e^{-\frac{\tau}{8} + B_1 \mathcal{H}(\tau, w) + (\widetilde{\beta} + 1)|\log(x)|}.$$

Next, we observe that $2\mathcal{H}(\tau, w)$ is the harmonic mean of τ and w, hence, we can use the fact that the harmonic mean is smaller than or equal to the arithmetic mean to write

$$\mathcal{H}(\tau, w) \leq \frac{\tau + w}{4}$$

and thus we get

$$\frac{\beta}{\sqrt{2\pi w}} P_{\tau} \overline{u}(w, x) \le \frac{\beta}{\sqrt{2\pi e}} |\log^{-1}(x)| e^{\frac{B_1}{4}(\tau+w) + (\widetilde{\beta}+1)|\log(x)|}.$$

Now we can go back to I_2 to get

$$I_{2} \leq \frac{\beta}{\sqrt{2\pi e}} |\log^{-1}(x)| e^{(\tilde{\beta}+1)|\log(x)|} \int_{0}^{+\infty} \int_{0}^{+\infty} \int_{0}^{s} \tau^{\alpha-1} s^{-\alpha-1} e^{-(\lambda-\frac{B_{1}}{4})(\tau+w)} dw d\tau ds$$
$$= \frac{\beta}{(\lambda-\frac{B_{1}}{4})\sqrt{2\pi e}} |\log^{-1}(x)| e^{(\tilde{\beta}+1)|\log(x)|} \left(\int_{0}^{+\infty} s^{-\alpha-1} \left(1-e^{-(\lambda-\frac{B_{1}}{4})s}\right) ds\right)$$
$$\times \left(\int_{0}^{+\infty} \tau^{\alpha-1} e^{-(\lambda-\frac{B_{1}}{4})\tau} d\tau\right)$$
$$= \frac{\beta\Gamma(1-\alpha)\Gamma(\alpha)}{(\lambda-\frac{B_{1}}{4})\sqrt{2\pi e}} |\log^{-1}(x)| e^{(\tilde{\beta}+1)|\log(x)|}.$$

Once we have (6.91), we know that for all x > 0 there exists $\mathcal{I}_x \subset \mathbb{R}^+$ such that $|\mathcal{I}_x| = 0$ and for all $t \in \mathbb{R}^+ \setminus \mathcal{I}_x$ we have

$$(\partial_t - G)^{\alpha} q_{\beta}(t, x) = \frac{t^{-\alpha}}{\Gamma(1-\alpha)} q_{\beta}(0, x).$$
(6.94)

Analogously to what we did in Proposition 6.18, we need to prove that $\mathcal{I}_x = \emptyset$. First, notice that a simple application of the dominated convergence theorem to (6.76), justified by (6.72), shows that q_β is continuous. Furthermore, arguing exactly as in Proposition 6.18, by means of the estimates (6.80) and (6.89), one can show that if $t_n \downarrow t$, then $(\partial_t - G)^{\alpha}q_{\beta}(t_n, x) \rightarrow (\partial_t - G)^{\alpha}q_{\beta}(t, x)$. This shows, with the same argument as in Proposition 6.18, that $\mathcal{I}_x = \emptyset$ for all x > 0 and then q_β is solution of (6.90).

Now we want to use the auxiliary function q_{β} to show that (6.36) has a unique solution. To do this, we need also the following lower bound.

Proposition 6.26. Let $\alpha \in (0,1)$ and $\beta \geq 0$. Then there exists a non-increasing function $C_{\beta} : \mathbb{R}^+ \to \mathbb{R}$ with $C_{\beta}(t) > 0$ for all t > 0 and such that

$$q_{\beta}(t,x) \ge C_{\beta}(t)e^{\beta|\log(x)|}.$$

Proof. First of all, let us observe that if $x \ge 1$ then $\log(x) \ge 0$ and we have

$$u_{\beta}(t,x) \ge e^{\beta \log(x) + \frac{\beta(\beta+1)}{2}t} \Phi\left(-\left(\beta + \frac{1}{2}\right)\sqrt{t}\right) \ge e^{\beta \log(x) + \frac{\beta(\beta-1)}{2}t} \Phi\left(-\left(\beta - \frac{1}{2}\right)\sqrt{t}\right).$$

If instead $x \in (0, 1]$, then $\log(x) \le 0$ and

$$u_{\beta}(t,x) \ge e^{-\beta \log(x) + \frac{\beta(\beta-1)}{2}t} \Phi\left(-\left(\beta - \frac{1}{2}\right)\sqrt{t}\right)$$

Hence, in general, we have

$$u_{\beta}(t,x) \ge e^{\beta |\log(x)| + \frac{\beta(\beta-1)}{2}t} \Phi\left(-\left(\beta - \frac{1}{2}\right)\sqrt{t}\right)$$

Next, by (6.76), we get

$$\begin{aligned} q_{\beta}(t,x) &\geq e^{\beta|\log(x)|} \int_{0}^{1} e^{\frac{\beta(\beta-1)}{2}ts} \Phi\left(-\left(\beta-\frac{1}{2}\right)\sqrt{ts}\right) \frac{s^{\alpha-1}(1-s)^{-\alpha}}{\Gamma(\alpha)\Gamma(1-\alpha)} \\ &\geq \begin{cases} \frac{e^{\beta|\log(x)|+\frac{\beta(\beta-1)}{2}t}}{2} & \beta \leq \frac{1}{2} \\ e^{\beta|\log(x)|+\frac{\beta(\beta-1)}{2}t} \Phi\left(-\left(\beta-\frac{1}{2}\right)\sqrt{t}\right) & \beta \in \left(\frac{1}{2},1\right] \\ e^{\beta|\log(x)|} \Phi\left(-\left(\beta-\frac{1}{2}\right)\sqrt{t}\right) & \beta > 1, \end{cases} \end{aligned}$$

that ends the proof.

Now we shall show that the solutions of the fully nonlocal Black-Scholes equation belonging to $\mathcal{C}_{0,\text{loc}}(\mathbb{R}^+_0)$ are unique.

Proposition 6.27. Let $\alpha \in (\frac{1}{2}, 1)$ and $f \in C_0$. Then, the equation

$$\begin{cases} (\partial_t - G)^{\alpha} q_f(t, x) = \frac{t^{-\alpha}}{\Gamma(1-\alpha)} q_f(0, x) & t, x > 0\\ q_f(0, x) = f(x) & x > 0\\ q_f \in \mathcal{C}_{0, \text{loc}}(\mathbb{R}^+_0) \end{cases}$$
(6.95)

at most has one solution.

Proof. Since the equation is linear, it is sufficient to verify that if $f \equiv 0$ then the solution $q_f \equiv 0$. Fix T > 0 and recall that since $q_f \in \mathcal{C}_{0,\text{loc}}(\mathbb{R}^+_0)$ then

$$|q_f(t,x)| \le C_T e^{\beta_T |\log(x)|}$$

For simplicity, set $C_T = C$ and $\beta_T := \beta_0$. Now, for any $A \ge 1$ and $\beta > \beta_0$, consider the function

$$w_{\beta}(t,x;A) := \frac{C}{C_{\beta}(T)} e^{(\beta_0 - \beta)|\log(A)|} q_{\beta}(t,x).$$

Notice that $w_{\beta}(0, x; A) > 0 = q_f(0, x)$ for all x > 0. Next, by Proposition 6.26 we have that, for $t \in (0, T]$,

$$w_{\beta}(t,x;A) \ge \frac{C_{\beta}(t)}{C_{\beta}(T)} C e^{(\beta_0 - \beta)|\log(A)| + \beta|\log(x)|} \ge C e^{(\beta_0 - \beta)|\log(A)| + \beta|\log(x)|}.$$

If $x \notin [A^{-1}, A]$ then $|\log(x)| \ge |\log(A)|$ and we have

$$w_{\beta}(t,x;A) \ge Ce^{\beta_0 |\log(A)|} \ge |q_f(t,x)|$$

This shows that for all $x\not\in \left[A^{-1},A\right]$ and $t\in [0,T]$

$$w_{\beta}(t,x;A) + q_f(t,x) \le 0 \le w_{\beta}(t,x;A) - q_f(t,x).$$
(6.96)

We want to show that this inequality holds for all x > 0. To do this, assume by contradiction that there exists a point $(t_{\star}, x_{\star}) \in [0, T] \times \mathbb{R}^+$ such that

$$w_{\beta}(t_{\star}, x_{\star}; A) - q_{\beta}(t_{\star}, x_{\star}) < 0$$

It must hold $x_{\star} \in [A^{-1}, A]$. Furthermore, since all the involved functions are continuous, we can assume without loss of generality that

$$w_{\beta}(t_{\star}, x_{\star}; A) - q_f(t_{\star}, x_{\star}) = \min_{(t, x) \in [0, T] \times [A^{-1}, A]} (w_{\beta}(t, x; A) - q_f(t, x)).$$

First of all, notice that for all $x \in \mathbb{R}^+$

$$w_{\beta}(t_{\star}, x_{\star}; A) - q_f(t_{\star}, x_{\star}) < 0 < w_{\beta}(0, x; A) - q_f(0, x)$$

Moreover, using (6.96) for $x \notin [A^{-1}, A]$ and the definition of (t_{\star}, x_{\star}) , if $x \in [A^{-1}, A]$, we get

$$w_{\beta}(t_{\star}, x_{\star}; A) - q_f(t_{\star}, x_{\star}) \le w_{\beta}(t, x; A) - q_f(t, x)$$

for all $t \in [0, T]$ and x > 0. By Proposition 3.5 we must have

$$-(\partial_t - G)^{\alpha}(w_{\beta}(\cdot, \cdot; A) - q_f(\cdot, \cdot))(x_\star, t_\star) + \frac{t_\star^{-\alpha}}{\Gamma(1-\alpha)}w_{\beta}(0, x_\star; A) > 0.$$

However, by Proposition 6.25 we know that, up to a multiplicative constant, $w_{\beta}(\cdot, \cdot; A)$ solves (6.90), while q_f solves (6.95), hence

$$-(\partial_t - G)^{\alpha}(w_{\beta}(\cdot, \cdot; A) - q_f(\cdot, \cdot))(x_{\star}, t_{\star}) + \frac{t_{\star}^{-\alpha}}{\Gamma(1 - \alpha)}w_{\beta}(0, x_{\star}; A) = 0,$$

which is a contradiction. Thus, we find

 $w_{\beta}(t,x;A) - q_f(t,x) \ge 0, \ \forall x > 0, \ t \in [0,T]$

With a similar argument one can prove that

 $w_{\beta}(t,x;A) + q_f(t,x) \le 0, \ \forall x > 0, \ t \in [0,T]$

and then, since (6.96) holds for all x > 0 and $t \in [0, T]$, we have

$$|q_f(t,x)| \le w_\beta(t,x;A) = \frac{C}{C_\beta(T)} e^{(\beta_0 - \beta)|\log(A)|} q_\beta(t,x)$$

taking the limit as $A \to \infty$ we get that $|q_f(t, x)| = 0$ for all x > 0 and $t \in [0, T]$. Since T > 0 is arbitrary, we end the proof.

6.3. **Proof of Theorem 6.10.** Before proving the main theorem of the section, we must state the last preliminary result whose proof is in Appendix D.

Proposition 6.28. Let $\phi(\lambda) = \lambda^{\alpha}$ for some $\alpha \in (0,1)$. Then, on $f \in C_c^{\infty}(\mathbb{R} \times \mathbb{R}^+)$ the generator A^{ϕ} of (B^{ϕ}, S) acts as follows:

$$A^{\phi}f(x,v) = \int_{\mathbb{R}} \int_{\mathbb{R}} (f(x+h,s+v) - f(x,v) - h\partial_x f(x,v)\mathbb{1}_{[-1,1]}(h))\mathcal{K}(dh;ds) dh$$

where \mathcal{K} is defined in (6.34).

Now we are finally ready to prove Theorem 6.10.

Proof of Theorem 6.10. We already know by (6.19) that $q_*(T-t, x, 0) = q(t, x)$. Furthermore, by Proposition 6.18 we know that the function q solves (6.36) and by Proposition 6.27 that it is actually the unique solution. We only need to prove (6.35). To do this, denote by $(\mathcal{Q}_t)_{t\geq 0}$ the transition semigroup of $(X_e(t), \gamma(t))$ and observe that

$$q_{\star}(t, X(t), \gamma(t)) = \tilde{Q}_{T-t}u(X(t), \gamma(t))$$

= $\tilde{\mathbb{E}}^{(x,v)}[(X(T) - K)_{+} | X(t), \gamma(t)]$
= $\mathbb{E}^{(x,v)}[(e^{X_{e}(T) - \frac{T-v-\gamma(T)}{2}} - K)_{+} | X(t), \gamma(t)]$
= $\mathcal{Q}_{T-t}g_{T,v}(X_{e}(t), \gamma(t)) = \mathcal{Q}_{T-t}g_{T,v}(\log(X(t)), \gamma(t))$

where

$$g_{T,v}(x,w) = (e^{x - \frac{T-v-w}{2}} - K)_+.$$

By Proposition 6.28 and [46, Theorem 4.1], we have, for w > 0

$$\mathcal{Q}_t g(x,w) = g(x,w+t)\mathcal{K}_w(x;\mathbb{R}^d \times [w+t,\infty)) + \int_{\mathbb{R} \times [w,w+t)} \mathcal{Q}_{t+w-\tau} g(x+y,0)\mathcal{K}_w(d\tau,dy),$$

In our case, this becomes

$$q_{\star}(t,x,w) = \mathcal{Q}_{T-t}g_{T,v}(\log(x),w) = g_{T,v}(\log(x),w+T-t)\mathcal{K}_w(x;\mathbb{R}^d \times [w+T-t,\infty))$$

$$+ \int_{\mathbb{R}\times[w,w+T-t)} \mathcal{Q}_{T-t+w-\tau} g_{T,v}(\log(x)+y,0) \mathcal{K}_w(d\tau,dy). \quad (6.97)$$

Now, we just have to evaluate the inner term. We have, setting for brevity $\tilde{x} = \log(x) + y + t - w + \tau - v$ and $\tilde{t} = T - t + w - \tau$,

$$\mathcal{Q}_{T-t+w-\tau}g_{T,v}(\log(x)+y,0)$$

$$= \mathbb{E}^{(\log(x)+y,0)} \left[\left(\exp\left(X_{e}(\tilde{t}) - \frac{T-v-\gamma(\tilde{t})}{2}\right) - K \right)_{+} \right]$$

$$= \mathbb{E}^{(\tilde{x},0)} \left[\left(\exp\left(X_{e}(\tilde{t}) - \frac{\tilde{t}-\gamma(\tilde{t})}{2}\right) - K \right)_{+} \right]$$

$$= \mathbb{E}^{(\tilde{x},0)} [(X(\tilde{t})e^{-\frac{\tilde{t}-\gamma(\tilde{t})}{2}} - K)_{+}] = q(\tilde{t},\tilde{x}).$$

Substituting the latter expression into (6.97) we get (6.35).

APPENDIX A. A SIMPLE PROPERTY OF CONDITIONAL EXPECTATIONS

Lemma A.1. Let X, Y, Z be three random variables with values respectively in E_X, E_Y, E_Z . Assume that Z is independent of both X and Y. Then, for any bounded measurable function $F : E_X \times E_Z \to \mathbb{R}$

$$\mathbb{E}[F(X,Z) \mid X,Y] = \mathbb{E}[F(X,Z) \mid X]$$

Proof. First consider two sets $B_X \in \mathcal{E}_X$ and $B_Z \in \mathcal{E}_Z$. Then

$$\mathbb{E}\left[\mathbb{1}_{B_X}(X)\mathbb{1}_{B_Z}(Z) \mid X, Y\right] = \mathbb{1}_{B_X}(X) \mathbb{E}\left[\mathbb{1}_{B_Z}(Z) \mid X, Y\right]$$
$$= \mathbb{1}_{B_X}(X) \mathbb{E}\left[\mathbb{1}_{B_Z}(Z)\right]$$
$$= \mathbb{1}_{B_X}(X) \mathbb{E}\left[\mathbb{1}_{B_Z}(Z) \mid X\right]$$
$$= \mathbb{E}\left[\mathbb{1}_{B_X}(X)\mathbb{1}_{B_Z}(Z) \mid X\right].$$

Now fix $F \in \sigma(X, Y)$ and define for any $B \in \mathcal{E}_X \otimes \mathcal{E}_Z$

$$\mu_F(B) = \mathbb{E}\left[\mathbb{1}_F \mathbb{E}\left[\mathbb{1}_B(X, Z) \mid X, Y\right]\right]$$

and

$$\nu_F(B) = \mathbb{E}\left[\mathbb{1}_F \mathbb{E}\left[\mathbb{1}_B(X, Z) \mid X\right]\right].$$

Notice that on $B = B_X \times B_Z$ for some $B_X \in \mathcal{E}_X$ and $B_Z \in \mathcal{E}_Z$ it holds $\mu_F(B_X \times B_Z) = \nu_F(B_X \times B_Z)$. Since the sets of the form $B_X \times B_Z$ constitute a π -system generating $\mathcal{E}_X \otimes \mathcal{E}_Z$, this is enough to guarantee that $\mu_F = \nu_F$. Furthermore, since $F \in \sigma(X, Y)$ is arbitrary, this leads to

$$\mathbb{E}\left[\mathbb{1}_B(X,Z) \mid X,Y\right] = \mathbb{E}\left[\mathbb{1}_B(X,Z) \mid X\right]$$

for all $B \in \mathcal{E}_X \times \mathcal{E}_Z$. Once this has been shown for indicator functions, a standard argument leads to the statement.

Appendix B. Proof of Lemma 6.7

The proof is by direct calculation. Just notice that

$$\int_{-\infty}^{+\infty} e^{\lambda_1 |y| + \lambda_2 y} p(t, x - y) dy = \frac{1}{\sqrt{2\pi t}} \int_{-\infty}^{+\infty} e^{\lambda_1 |y| + \lambda_2 y - \frac{y^2}{2t} - \frac{x^2}{2t} + \frac{xy}{t}} dy$$
$$= \frac{1}{\sqrt{2\pi t}} \int_{0}^{+\infty} e^{\lambda_1 y + \lambda_2 y - \frac{y^2}{2t} - \frac{x^2}{2t} + \frac{xy}{t}} dy$$
$$+ \frac{1}{\sqrt{2\pi t}} \int_{-\infty}^{0} e^{-\lambda_1 y + \lambda_2 y - \frac{y^2}{2t} - \frac{x^2}{2t} + \frac{xy}{t}} dy$$
$$= F(t, x; \lambda_1 + \lambda_2) + F(t, -x; \lambda_1 - \lambda_2)$$

where

$$F(t,x;\lambda) = \frac{1}{\sqrt{2\pi t}} \int_{0}^{+\infty} e^{\lambda y - \frac{y^2}{2t} - \frac{x^2}{2t} + \frac{xy}{t}} dy$$

We only need to evaluate F. To do this, notice that

$$\lambda y - \frac{y^2}{2t} - \frac{x^2}{2t} + \frac{xy}{t} = -\frac{(y - (\lambda t + x))^2}{2t} + \frac{\lambda(\lambda t + 2x)}{2}$$

hence

$$F(t,x;\lambda) = \frac{1}{\sqrt{2\pi t}} e^{\frac{\lambda(\lambda t + 2x)}{2}} \int_0^{+\infty} e^{-\frac{(y - (\lambda t + x))^2}{2t}} dy.$$

Using the change of variables $v = \frac{y - (\lambda t + x)}{\sqrt{t}}$, we have

$$F(t,x;\lambda) = \frac{1}{\sqrt{2\pi}} e^{\frac{\lambda(\lambda t+2x)}{2}} \int_{-\frac{\lambda t+x}{\sqrt{t}}}^{+\infty} e^{-v^2} 2dv = e^{\frac{\lambda(\lambda t+2x)}{2}} \Phi\left(-\frac{\lambda t+x}{\sqrt{t}}\right).$$

This ends the proof.

APPENDIX C. PROOF OF LEMMA 6.8

We first recall that, by [50, Theorems 6.20 and 8.6], the equation

$$\begin{cases} \partial_t v(t,y) = \frac{1}{2} \partial_y^2 v(t,y), & t > 0, \ x \in \mathbb{R} \\ v(0,y) = g(y), & x \in \mathbb{R} \end{cases}$$
(C.1)

admits a solution v_g whenever $g \in C(\mathbb{R})$ satisfies $|g(y)| \leq Ce^{\beta|y|}$ for suitable constants $C, \beta > 0$ and such a solution is unique among functions v(t, y) satisfying, for all T > 0, $|v(t, y)| \leq C_1 e^{C_2 y^2}$ for some constants $C_1, C_2 > 0$ and $t \in [0, T]$. Furthermore, still by [50, Theorem 8.6], we know that,

$$v_g(t,y) = \mathbb{E}^{(y,0)}[g(B(t))]$$

Hence, for any T > 0 and $t \in [0, T]$,

$$|v_g(t,y)| \le \mathbb{E}^{(y,0)}[|g(B(t))|] \le C \mathbb{E}^{(y,0)} \left[e^{\beta |B(t)|} \right] \le 2C e^{\beta |y| + \frac{\beta^2 t}{2}},$$

where we also used Lemma 6.7. Now consider the equation

$$\begin{cases} \partial_t u(t,x) = Gu(t,x), & t > 0, \ x \in \mathbb{R}^+ \\ u(0,x) = f(x) & x \in \mathbb{R}^+, \end{cases}$$
(C.2)

where $f \in \mathcal{C}_0$ and let $\beta > 0$ be such that $f \in \mathcal{C}_0(\beta)$. Then if we set

$$g(y) = e^{-\frac{y}{2}} f(e^y), \ x \in \mathbb{R}$$

we do have $|g(y)| \leq [f]_{\beta} e^{\left(\beta + \frac{1}{2}\right)|y|}$ and $g \in C(\mathbb{R})$, hence we can solve the heat equation (C.1), providing the unique solution $v_q(t, y)$ that satisfies

$$|v_g(t,y)| \le 2[f]_{\beta} e^{\frac{1}{2}(\beta + \frac{1}{2})^2 t + (\beta + \frac{1}{2})|y|}$$

According to [50, Proposition 7.9], we know that

$$u_f(t,x) = e^{\frac{\log(x)}{2} - \frac{t}{8}} v_g(t,\log(x))$$

is a classical solution of (C.2). Hence, in particular, $u_f \in C(\mathbb{R}^+_0 \times \mathbb{R}^+) \cap C^1(\mathbb{R}^+ \times \mathbb{R}^+)$ and for all t > 0 it holds $u_f(t, \cdot) \in C^2(\mathbb{R}^+)$. Moreover, for x > 0 we get

$$|u_f(t,x)| \le e^{\frac{|\log(x)|}{2}} |v_g(t,\log(x))| \le 2[f]_\beta e^{(\beta+1)|\log(x)| + \frac{\beta(\beta+1)}{2}t}$$
(C.3)

hence $u_f \in \mathcal{C}_{sol}$. To show uniqueness, notice that if we consider any other solution of (C.2) in \mathcal{C}_{sol} , then we have, still by [50, Proposition 7.9], that $v'_q(t,x) = e^{-\frac{x}{2} + \frac{t}{8}}u(t,e^x)$ satisfies (C.1) with

$$|v_a'(t,x)| \le \widetilde{C}_T e^{\frac{T}{8}} e^{\left(\widetilde{\beta}_T + \frac{1}{2}\right)|x|}$$

for all $T > 0, t \in [0, T], x \in \mathbb{R}$. By [50, Theorem 6.20], we know that $v'_g = v_g$ hence $u'_f = u_f$. Denote by $(P_s)_{s \ge 0}$ the semigroup action on \mathcal{C}_0 such that for all $f \in \mathcal{C}_0$ the function $u_f(s, x) = P_s f(x)$ is the unique solution of (6.33) in $C_{\rm sol}$.

Notice that for the special initial data $f_{\beta_1,\beta_2}(x) = e^{\beta_1 |\log(x)| + \beta_2 \log(x)}$, that belongs to $\mathcal{C}_0(|\beta_1| + |\beta_2|)$, we have $q(y) = e^{\left(\beta_2 - \frac{1}{2}\right)y + \beta_1|y|}$, hence, by Lemma 6.7, it holds

$$v_g(t,y) = \mathbb{E}^{(y,0)}[g(B(t))] = e^{\left(\beta_1 + \beta_2 - \frac{1}{2}\right)y + \frac{1}{2}\left(\beta_1 + \beta_2 - \frac{1}{2}\right)^2 t} \Phi\left(-\left(\beta_1 + \beta_2 - \frac{1}{2}\right)\sqrt{t} - \frac{y}{\sqrt{t}}\right) \\ + e^{-\left(\beta_1 - \beta_2 + \frac{1}{2}\right)y + \frac{1}{2}\left(\beta_1 - \beta_2 + \frac{1}{2}\right)^2 t} \Phi\left(-\left(\beta_1 - \beta_2 + \frac{1}{2}\right)\sqrt{t} + \frac{y}{\sqrt{t}}\right).$$

As a consequence, we get, in such a case

$$P_t f_{\beta_1,\beta_2}(x) = e^{(\beta_1 + \beta_2)\log(x) + \frac{(\beta_1 + \beta_2)(\beta_1 + \beta_2 - 1)}{2}t} \Phi\left(-\left(\beta_1 + \beta_2 - \frac{1}{2}\right)\sqrt{t} - \frac{\log(x)}{\sqrt{t}}\right) \\ + e^{-(\beta_1 - \beta_2)\log(x) + \frac{(\beta_1 - \beta_2)(\beta_1 - \beta_2 + 1)}{2}t} \Phi\left(-\left(\beta_1 - \beta_2 + \frac{1}{2}\right)\sqrt{t} + \frac{\log(x)}{\sqrt{t}}\right).$$

This shows Item (4).

Now we prove Item (1). Recall that for $f \in C_0$ it holds $P_t f(x) = e^{\frac{\log(x)}{2} - \frac{t}{8}} v_g(t, \log(x))$, where v_g satisfies (C.1) with $g(y) = e^{-\frac{y}{2}} f(e^y)$. As before, we also recall that

$$v_g(t,y) = \int_{\mathbb{R}} g(z)p(t,z-y)dz = \int_{\mathbb{R}} e^{-\frac{z}{2}}f(e^z)p(t,z-y)dz,$$

where

$$p(t, z - y) = \frac{1}{\sqrt{2\pi t}} e^{-\frac{(z-y)^2}{2t}}$$

is the heat kernel, as in (6.25). Hence,

$$P_t f(x) = e^{\frac{\log(x)}{2} - \frac{t}{8}} \int_{\mathbb{R}} e^{-\frac{z}{2}} f(e^z) p(t, z - \log(x)) dz$$

Using the change of variables $z = \log(w)$, we achieve

$$P_t f(x) = e^{\frac{\log(x)}{2} - \frac{t}{8}} \int_0^{+\infty} \frac{e^{-\frac{\log(w)}{2}}}{w} f(w) p(t, \log(w) - \log(x)) dw$$
$$= \int_0^{+\infty} f(w) p_{\text{GBM}}(t, w; x) dw.$$

Since $p_{\text{GBM}}(t, \cdot; x)$ is a probability density function, this also guarantees that P_t is positivity preserving and sub-Markov. In particular, if $f \in C_0(\beta)$, then $|f| \leq f_{\beta,0} =: f_\beta$ and then

$$\begin{aligned} |P_t f(x)| &\leq P_t |f|(x) \leq [f]_{\beta} P_t f_{\beta,0}(x) \leq [f]_{\beta} e^{\beta \log(x) + \frac{\beta(\beta-1)}{2}t} \Phi\left(-\left(\beta - \frac{1}{2}\right)\sqrt{t} - \frac{\log(x)}{\sqrt{t}}\right) \\ &+ [f]_{\beta} e^{-\beta \log(x) + \frac{\beta(\beta+1)}{2}t} \Phi\left(-\left(\beta + \frac{1}{2}\right)\sqrt{t} + \frac{\log(x)}{\sqrt{t}}\right) \leq 2[f]_{\beta} e^{\frac{\beta(\beta+1)}{2}t + \beta |\log(x)|}, \end{aligned}$$

that shows Item (5).

To prove Item (2) observe that

$$p_{\text{GBM}}(t, w; x) = \frac{1}{w\sqrt{2\pi}} \exp\left(-\frac{(2\log(w) - 2\log(x) + t)^2}{8t}\right)$$

and then

$$\partial_x p_{\text{GBM}}(t, w; x) = \frac{2\log(w) - 2\log(x) + t}{2txw\sqrt{2\pi}} \exp\left(-\frac{(2\log(w) - 2\log(x) + t)^2}{8t}\right).$$

Fix 0 < a < b and let $x \in [a, b]$. Let also $\beta \ge 0$ be such that $f \in C_0(\beta)$ and set $M = \max\{|\log(a)|, |\log(b)|\}$. Then we have

$$\begin{split} |f(w)\partial_x p_{\text{GBM}}(t,w;x)| \\ &\leq [f]_{\beta} \frac{|2\log(w) - 2\log(x) + t|}{2txw\sqrt{2\pi}} \exp\left(\beta|\log(w)| - \frac{(2\log(w) - 2\log(x) + t)^2}{8t}\right) \\ &\leq \frac{[f]_{\beta}}{2at\sqrt{2\pi}}g_t(\log(w)) \exp\left(-\log(w) - \frac{\log^2(w)}{16t}\right) \exp\left(-\frac{\log^2(w)}{32t}\right) \\ &\qquad \times \exp\left(\beta|\log(w)| - \frac{\log^2(w)}{8t}\right) \exp\left(\frac{-\log^2(w) + 2\log(w)(2\log(x) - t)}{4t}\right), \end{split}$$

where

$$g_t(z) = (2|z| + 2M + t)e^{-\frac{z^2}{32t}}.$$

First, notice that $g_t \in C(\mathbb{R}), g_t(z) \ge 0$ for all $z \in \mathbb{R}$ and $\lim_{z \to \pm \infty} g_t(z) = 0$. Hence, there exists $M_1(t) = \max_{z \in \mathbb{R}} g_t(z)$. Next, consider the parabola $r \in \mathbb{R} \mapsto -\frac{r^2}{8t} + \beta r \in \mathbb{R}$ and we notice that its vertex, which is its maximum, lies in the point $(4\beta t, 2\beta^2 t)$. Similarly, the vertex of the parabola $r \in \mathbb{R} \mapsto -\frac{r^2}{4t} + \frac{r(2\log(x)-t)}{2t} \in \mathbb{R}$ lies in the point $\left(2\log(x) - t, \frac{(2\log(x)-t)^2}{4t}\right)$, which is its maximum. Finally, consider the parabola $r \in \mathbb{R} \mapsto -\frac{r^2}{16t} - r \in \mathbb{R}$ and notice that its vertex, that is its maximum, lies in the point (-8t, 4t). Hence, if we set

$$C_t := \frac{[f]_{\beta} M_1(t)}{2at\sqrt{2\pi}} \exp\left(2(\beta^2 + 2)t\right) \max_{x \in [a,b]} \exp\left(\frac{(2\log(x) - t)^2}{4t}\right)$$

we get

$$|f(w)\partial_x p_{\text{GBM}}(t,w;x)| \le C_t \exp\left(-\frac{\log^2(w)}{32t}\right)$$

where the right-hand side is integrable and independent of x. Hence, by dominated convergence,

$$\partial_x P_t f(x) = \int_0^{+\infty} f(w) \partial_x p_{\text{GBM}}(t, w; x) \, dw.$$

To prove the bound, we argue as follows: first we notice that

Next, we apply the change of variables $z = \frac{2 \log(w) - 2 \log(x) + t}{2\sqrt{t}}$, obtaining

$$\begin{split} |\partial_x P_t f(x)| &\leq \frac{[f]_\beta}{x\sqrt{2\pi}} \int_{-\infty}^{+\infty} |z| \exp\left(\beta \left| z\sqrt{t} + \log(x) - \frac{t}{2} \right| - \frac{z^2}{2} \right) dz \\ &\leq \frac{[f]_\beta}{2x\sqrt{2\pi}} \exp\left(\beta \left| \log(x) \right| + \beta \frac{t}{2} \right) \int_0^{+\infty} z \exp\left(\beta \sqrt{t}z - \frac{z^2}{2} \right) dz \\ &= \frac{[f]_\beta}{2x\sqrt{2\pi}} \exp\left(\beta \left| \log(x) \right| + \beta \frac{t}{2} \right) \int_0^{+\infty} (z - \beta\sqrt{t}) \exp\left(\beta \sqrt{t}z - \frac{z^2}{2} \right) dz \\ &+ \frac{[f]_\beta \beta \sqrt{t}}{2x\sqrt{2\pi}} \exp\left(\beta \left| \log(x) \right| + \beta \frac{t}{2} \right) \int_0^{+\infty} \exp\left(\beta \sqrt{t}z - \frac{z^2}{2} \right) dz \\ &:= \frac{2[f]_\beta}{x\sqrt{2\pi}} \exp\left(\beta \left| \log(x) \right| + \beta \frac{t}{2} \right) (I_1 + I_2). \end{split}$$

Concerning I_1 , it is easy to check that $I_1 = 1$. For I_2 , we rewrite it as

$$I_{2} = \sqrt{\frac{\pi}{2}} \mathbb{E}^{(0,0)} \left[e^{\beta \sqrt{t} |B(1)|} \right] = \sqrt{2\pi} e^{\frac{\beta^{2} t^{2}}{2}} \Phi \left(-\beta \sqrt{t} \right).$$

$$\begin{aligned} |\partial_x P_t f(x)| &\leq \frac{2[f]_\beta}{x\sqrt{2\pi}} \exp\left(\beta \left|\log(x)\right| + \beta \frac{t}{2}\right) \left(1 + \sqrt{2\pi}e^{\frac{\beta^2 t^2}{2}} \Phi\left(-\beta\sqrt{t}\right)\right) \\ &\leq 4[f]_\beta \exp\left((\beta+1)\left|\log(x)\right| + \beta \frac{t}{2} + \frac{\beta^2 t^2}{2}\right), \end{aligned}$$

that proves Item (2).

Finally, we prove Item (3). Let f as required, in particular with $f \in C_0(\beta)$, $\partial_x f \in C_0(\beta')$ and $Gf \in C_0(\beta'')$. Recall that

$$\partial_x P_t f(x) = \int_0^\infty f(w) \,\partial_x p_{\text{GBM}}(t, w; x) \,dw.$$
(C.4)

We want to prove a similar property for the second derivative. To do this, first notice that

$$\partial_x^2 p_{\text{GBM}}(t, w; x) = \frac{(-8t + (2\log(w) - 2\log(x) + t)^2 - 4t(2\log(w) - 2\log(x) + t)))}{8t^2 w \sqrt{2\pi} x^2} \times \exp\left(-\frac{(2\log(w) - 2\log(x) + t)^2}{8t}\right). \quad (C.5)$$

By a similar argument as the one adopted in Item (2), we obtain, for fixed $x \in [a, b], 0 < a < b$, and t > 0,

$$|f(x)\partial_y^2 p(t,x;x)| \le C_t \exp\left(-\frac{\log^2(w)}{32t}\right)$$
(C.6)

for some constant C_t depending on t, a, b, β and $[f]_{\beta}$. Again, by dominated convergence, we have

$$\partial_x^2 P_t f(x) = \int_0^\infty f(w) \,\partial_x^2 p_{\text{GBM}}(t, w; x) \,dw.$$
(C.7)

Next, notice that

$$\frac{x^2}{2}\partial_x^2 p_{\rm GBM}(t,w;x) = \partial_w^2 \left(\frac{w^2}{2}p_{\rm GBM}(t,w;x)\right).$$
(C.8)

Hence we get

$$GP_t f(x) = \int_0^\infty f(w) \,\partial_w^2 \left(\frac{w^2}{2} p_{\text{GBM}}(t, w; x)\right) \,dw.$$
(C.9)

Now we want to integrate by parts. To do this, we first notice that, again with the same exact argument, we have

$$\left| f(w) \,\partial_w \left(\frac{w^2}{2} p_{\text{GBM}}(t, w; x) \right) \right| \le C \exp\left(-\frac{\log^2(w)}{32t} \right)$$

for some constant C depending on t, x, β and $[f]_{\beta}$. Hence, in particular,

$$\lim_{w \to 0} \left| f(w) \,\partial_w \left(\frac{w^2}{2} p_{\text{GBM}}(t, w; x) \right) \right| = \lim_{w \to +\infty} \left| f(w) \,\partial_w \left(\frac{w^2}{2} p_{\text{GBM}}(t, w; x) \right) \right| = 0$$

and then, integrating by parts in (C.9),

$$GP_t f(x) = -\int_0^\infty \partial_w f(w) \,\partial_w \left(\frac{w^2}{2} p_{\text{GBM}}(t, w; x)\right) \,dw.$$
(C.10)

To integrate by parts a second time, we notice again that

$$\frac{w^2}{2} \left| \partial_w f(w) \, p_{\text{GBM}}(t, w; x) \right| \le C \exp\left(-\frac{\log^2(w)}{32t}\right) \tag{C.11}$$

for some constant C depending on t, x, β' and $[\partial_x f]_{\beta'}$. Thus, again

$$\lim_{w \to 0} \frac{w^2}{2} |\partial_w f(w) \, p_{\text{GBM}}(t, w; x)| = \lim_{w \to +\infty} \frac{w^2}{2} |\partial_w f(w) \, p_{\text{GBM}}(t, w; x)| = 0$$

and then, integrating by parts in (C.10),

$$GP_t f(x) = -\int_0^\infty Gf(w) p_{\text{GBM}}(t, w; x) \, dw = P_t Gf(x), \tag{C.12}$$

ight-hand side is finite since $Gf \in \mathcal{C}_0.$

where the integral on the right-hand side is finite since $Gf \in \mathcal{C}_0$.

APPENDIX D. PROOF OF PROPOSITION 6.28

Let us consider the process $(B(t), \tau(t))$, where B(t) is a Brownian motion such that $\mathbb{P}^{(x,v)}(B(0) = x) = 1$ and $\mathbb{P}^{(x,v)}(\tau(t) = t + v) = 1$. Notice that (B^{ϕ}, S) is obtained from (B, τ) by means of subordination. Furthermore, the semigroup $(\mathcal{T}_t)_{t\geq 0}$ of $(B(t), \tau(t))$ is given by

$$\mathcal{T}_t f(x,v) = \int_{-\infty}^{+\infty} f(y,t+v) p(t,x-y) dy, \forall f \in C_b(\mathbb{R} \times \mathbb{R}_0^+).$$

where p is given by (6.25). By Phillips' Theorem, we know that at least on $C_c^{\infty}(\mathbb{R} \times \mathbb{R}^+)$ the generator A^{ϕ} of (B^{ϕ}, σ) is given by

$$\begin{split} A^{\phi}f(x,v) &= \frac{\alpha}{\Gamma(1-\alpha)} \int_{0}^{+\infty} (\mathcal{T}_{t}f(x,v) - f(x,v))t^{-1-\alpha} dt \\ &= \frac{\alpha}{\Gamma(1-\alpha)} \int_{0}^{+\infty} \int_{-\infty}^{+\infty} (f(y,t+v) - f(x,v))p(t,x-y)t^{-1-\alpha} dy dt \\ &= \frac{\alpha}{\Gamma(1-\alpha)} \int_{0}^{+\infty} \int_{-\infty}^{+\infty} (f(x+h,t+v) - f(x,v))p(t,h)t^{-1-\alpha} dh dt, \end{split}$$

where we applied the change of variables x - y = h. Now notice that by symmetry

$$\int_{-1}^{1} h \partial_x f(x, v) p(t, h) \, dh = 0$$

hence we can rewrite

$$A^{\phi}f(x,v) = \frac{\alpha}{\Gamma(1-\alpha)} \int_{0}^{+\infty} \int_{-\infty}^{+\infty} (f(x+h,t+v) - f(x,v) - h\partial_x f(x,v)\mathbb{1}_{[-1,1]}(h))p(t,h)t^{-1-\alpha} dh dt.$$
(D.1)

Now let us first show that the integral is absolutely convergent. Indeed, we have

$$\int_{0}^{+\infty} \int_{-\infty}^{+\infty} |f(x+h,t+v) - f(x,v) - h\partial_{x}f(x,v)|p(t,h)t^{-1-\alpha} dh dt$$

$$\leq \int_{0}^{+\infty} \int_{-\infty}^{+\infty} |f(x+h,t+v) - f(x+h,v)|p(t,h)t^{-1-\alpha} dh dt$$

$$+ \int_{0}^{+\infty} \int_{-\infty}^{+\infty} |f(x+h,v) - f(x,v) - h\partial_{x}f(x,v)\mathbb{1}_{[-1,1]}(h)|p(t,h)t^{-1-\alpha} dh dt$$

$$=I_1+I_2.$$

As for I_1 , we split the integral in two parts:

$$I_{1} = \int_{0}^{1} \int_{-\infty}^{+\infty} |f(x+h,t+v) - f(x+h,v)| p(t,h) t^{-1-\alpha} dh dt$$

+
$$\int_{1}^{+\infty} \int_{-\infty}^{+\infty} |f(x+h,t+v) - f(x+h,v)| p(t,h) t^{-1-\alpha} dh dt = I_{3} + I_{4}.$$

Since $f \in C_c^{\infty}(\mathbb{R} \times \mathbb{R}^+)$ and $\int_{-\infty}^{+\infty} p(t,h)dh = 1$ we have

$$I_3 \le \max_{(x,v)\in\mathbb{R}\times\mathbb{R}^+} |\partial_v f(x,v)| \int_0^1 t^{-\alpha} dt = \frac{\max_{(x,v)\in\mathbb{R}\times\mathbb{R}^+} |\partial_v f(x,v)|}{1-\alpha}$$

while

$$I_4 \le 2 \max_{(x,v) \in \mathbb{R} \times \mathbb{R}^+} |f(x,v)| \int_1^{+\infty} t^{-1-\alpha} dt = \frac{\max_{(x,v) \in \mathbb{R} \times \mathbb{R}^+} |f(x,v)|}{\alpha}.$$

To handle I_2 , we first change the order of the integral, defining

$$j(h) := \int_0^{+\infty} p(t,h) t^{-1-\alpha} dt = C_{\alpha} |h|^{1+2\alpha}$$

for some normalizing constant $C_{\alpha} > 0$. Then we split the integral in two parts:

$$I_{2} = \int_{h \notin [-1,1]} |f(x+h,v) - f(x,v)| j(h) \, dh \, dt + \int_{h \in [-1,1]} |f(x+h,v) - f(x,v) - h \partial_{x} f(x,v)| j(h) \, dh \, dt = I_{5} + I_{6}.$$

For I_5 , we have

$$I_5 \le 4 \max_{(x,v)\in\mathbb{R}\times\mathbb{R}^+} |f(x,v)| \int_1^{+\infty} h^{-1-2\alpha} dh = \frac{4 \max_{(x,v)\in\mathbb{R}\times\mathbb{R}^+}}{2\alpha},$$

while to handle I_6 we observe that

$$I_{6} \leq \max_{(x,v) \in \mathbb{R} \times \mathbb{R}^{+}} |\partial_{x}^{2} f(x,v)| \int_{0}^{1} h^{1-2\alpha} dh = \frac{\max_{(x,v) \in \mathbb{R} \times \mathbb{R}^{+}} |\partial_{x}^{2} f(x,v)|}{2(1-\alpha)}.$$

Now we want to find an alternative way of writing (D.1). To do this, we define the following family of measures on \mathbb{R} :

$$A \in \mathcal{B}(\mathbb{R}) \mapsto \widetilde{\mathcal{K}}(A,h) = \int_0^{+\infty} \mathbb{1}_A(t) p(t,h) \frac{\alpha t^{-1-\alpha}}{\Gamma(1-\alpha)} dt.$$

We can then define a further measure on \mathbb{R}^2 by setting for any $A_1, A_2 \in \mathcal{B}(\mathbb{R})$

$$\mathcal{K}(A_1 \times A_2) = \int_{-\infty}^{+\infty} \mathbb{1}_{A_1}(h) \widetilde{\mathcal{K}}(A_2, h) \, dh.$$

On the other hand, notice that (D.1) can be rewritten as

$$A^{\phi}f(x,v) = \int_{-\infty}^{+\infty} \int_{0}^{+\infty} \int_{\mathbb{R}} \frac{\alpha t^{-1-\alpha}}{\Gamma(1-\alpha)} (f(x+h,s+v) - f(x,v) - h\partial_{x}f(x,v)\mathbb{1}_{[-1,1]}(h))p(t,h)\,\delta_{t}(ds)\,dt\,dh$$

However, observe that for any $A \in \mathcal{B}(\mathbb{R})$ it holds

$$\begin{split} \widetilde{\mathcal{K}}(A,h) &= \int_0^{+\infty} \mathbbm{1}_A(t) p(t,h) \frac{\alpha t^{-1-\alpha}}{\Gamma(1-\alpha)} \, dt = \int_0^{+\infty} \delta_t(A) p(t,h) \frac{\alpha t^{-1-\alpha}}{\Gamma(1-\alpha)} \, dt \\ &= \int_0^{+\infty} \int_{\mathbb{R}} \mathbbm{1}_A(s) p(t,h) \frac{\alpha t^{-1-\alpha}}{\Gamma(1-\alpha)} \, \delta_t(ds) \, dt. \end{split}$$

By a standard measure theory argument we can conclude that

$$\begin{split} A^{\phi}f(x,v) &= \int_{-\infty}^{+\infty} \int_{\mathbb{R}} (f(x+h,s+v) - f(x,v) - h\partial_x f(x,v) \mathbb{1}_{[-1,1]}(h)) \widetilde{\mathcal{K}}(ds;h) \, dh \\ &= \int_{\mathbb{R}} \int_{\mathbb{R}} (f(x+h,s+v) - f(x,v) - h\partial_x f(x,v) \mathbb{1}_{[-1,1]}(h)) \mathcal{K}(dh;ds) \, dh, \end{split}$$

where the latter follows by definition of the measure K.
