Stealth black holes in Aether Scalar Tensor theory

Abstract. The Aether Scalar Tensor (AeST) theory is an extension of general relativity (GR) successful at reproducing galactic rotational curves, gravitational lensing, linear large scale structure and cosmic microwave background power spectrum observations. We solve the most general static spherically symmetric vacuum equations in the strong-field regime of AeST and find two classes of stealth black hole solutions – those with exact GR geometries – containing non-trivial secondary hair. In particular, one of these can be continuously joined to the cosmological solution of AeST. We also derive a non-black hole solution with zero spatial component in the vector field. This result proves the existence of mathematically and observationally consistent candidates for black holes in AeST, and creates a basis for testing the theory in the strong-field regime.

Keywords: Extensions of GR, modified gravity, black holes, stealth black holes, modified newtonian dynamics

1 Introduction

General Relativity (GR) has been widely successful in explaining and predicting many gravitational phenomena. It has so far passed several precise observational tests [\[1\]](#page-24-1) ranging from table-top experiments [\[2](#page-24-2)], our solar system [\[3](#page-24-3)] and other astrophysical systems [\[4](#page-25-0)], to the detection of gravitational waves from mergers of compact objects [\[5\]](#page-25-1). Nevertheless, there are reasons for us to consider extensions to GR [\[6\]](#page-25-2). The most well-motivated extension is that of added higher curvature terms which come as quantum corrections to GR [\[7](#page-25-3)[–9\]](#page-25-4) and treated in the language of effective field theory. Another possibility which has been in vogue in the last twenty years or so, is to extend GR with new gravitational degrees of freedom playing the role of dark energy, in an attempt to alleviate some of the issues associated with the cosmological constant $[6, 10, 11]$ $[6, 10, 11]$ $[6, 10, 11]$ $[6, 10, 11]$ $[6, 10, 11]$. The less investigated case, which is more the concern of this article, is to do with the missing mass commonly attributed to dark matter.

GR is the cornerstone of our current cosmological model – the cold dark matter model with a cosmological constant (ΛCDM). These two ingredients are necessary, within GR, to explain the observed mismatch between the observed dynamics of luminous matter and its gravitational influence. Of these, dark matter is commonly believed to be in the form of particles which are not part of the standard model of particle physics, however, such particles have so far been elusive to particle searches. As such, the possibility that an extension of GR may explain this mismatch without the presence of dark matter, remains open.

Perhaps the most widely investigated scenario is that of Modified Newtonian Dynamics (MOND) [\[12](#page-25-7)[–14](#page-25-8)] which was prescribed as a phenomenological model introducing an acceleration scale $a_0 = 1.2 \cdot 10^{-10} \text{m/s}^2$ under which the law of Newtonian gravity is altered; see [\[15](#page-25-9)] for a review. MOND was quickly cast as an extension of Newtonian gravity [\[16\]](#page-25-10) which was also shown to emerge in the weak-field limit of a scalar-tensor extension of GR in the same work. That early model was shown to be incompatible with observations of gravitational lensing from bounded baryonic structures and the extensions that followed [\[17\]](#page-25-11) did not improve on this. The use of a scalar-field based disformal relation between two metrics was proposed [\[18\]](#page-25-12) but without overcoming the problem with gravitational lensing [\[19\]](#page-25-13). The latter was resolved by Sanders using a unit-timelike vector field in the disformal relation [\[20\]](#page-25-14) and the resulting model was later developed by Bekenstein into a covariant theory, the Tensor-Vector-Scalar (TeVeS) theory [\[21](#page-25-15)]. The formulation of TeVeS initiated a stronger interest in the possibility of extensions of GR as alternatives to the particle dark matter hypothesis, as it became possible to study other phenomena resulting from such extensions, particularly cosmology [\[22](#page-25-16)[–24](#page-25-17)], black holes [\[25](#page-26-0)[–27](#page-26-1)], neutron stars [\[28\]](#page-26-2), solar system tests [\[29](#page-26-3), [30](#page-26-4)], Hamiltonian analysis [\[31](#page-26-5)], and gravitational waves [\[30](#page-26-4), [32](#page-26-6), [33\]](#page-26-7). Further extensions or generalizations of TeVeS followed [\[34](#page-26-8)[–37\]](#page-26-9), as well as other GR extensions not related to TeVeS but with similar purpose $[38-52]$. See $[53]$ for an early review of field-theoretical formulations of MOD^1 MOD^1 .

The usual obstacle that GR extensions have to face is to reproduce the success of large scale cosmology and ΛCDM phenomenology in the absence of a dark matter particle. Moreover, extending GR with the introduction of new gravitational degrees of freedom quite often leads to a propagation speed for the tensor-mode gravitational wave different than the speed of light. However, this has been severely constrained [\[61](#page-27-2)[–63](#page-27-3)]. In cases where classic cosmological observables have been computed – the matter power spectrum and the cosmic microwave background angular power spectra – none of the above theories have been shown to fit all of the cosmological data while preserving MOND phenomenology in galaxies. The first model where this was shown to be possible, using the same fields both for cosmology and for MOND, is the Aether Scalar Tensor theory (AeST) [\[64](#page-27-4)].

The AeST theory uses the same fields as the old TeVeS proposal, the metric, a scalar and a unit-timelike vector field, however, it removes the necessity of a disformal transformation in its formulation. It was conceived to lead to MOND phenomenology in its weak field limit

and correct gravitational lensing as in TeVeS theory. However, unlike TeVeS, it can fit the large scale cosmological spectra similarly as ΛCDM, while the tensor modes of the theory propagate at the speed of light. Several articles study this theory in a variety of observational or theoretical setups [\[65](#page-27-8)[–78](#page-28-0)].

An important feature of every viable theory is the presence of black hole solutions, or at least compact objects, near those described by GR, as there is strong observational evidence for their existence [\[5](#page-25-1), [79](#page-28-1)]. These objects and their departures from pure GR can serve as an important probe for distinguishing the presence of additional fields and various extensions of GR [\[80](#page-28-2)]. These departures can be both in the geometry of such objects and in the presence of hair [\[81](#page-28-3)], meaning the presence of stable additional fields with non-trivial information content. Hair is further classified into primary and secondary, where primary add a new charge characterizing the solutions, whereas secondary do not. Some theories can contain stealth black holes - black holes whose geometries are solutions to the vacuum Einstein equations - but for which the additional fields have non-trivial solutions (hair) [\[82](#page-28-4)]. The exact definition slightly varies in the literature and we choose a more liberal approach ^{[2](#page-3-0)} of defining stealth black holes as BHs with geometries of solutions to GR coupled with standard matter fields as in [\[86](#page-28-5)]. This makes stealth BHs geometrically indistinguishable from GR black holes, and one must consider other signatures such as quasinormal modes [\[87](#page-28-6)] and other perturbative signatures [\[88](#page-29-0)], or thermodynamics [\[89\]](#page-29-1) as relevant distinguishing probes. Stealth black holes have been found in theories with similar components as AeST shift-symmetric scalar fields [\[90](#page-29-2)[–92\]](#page-29-3) and vector-tensor theories [\[86,](#page-28-5) [93](#page-29-4), [94](#page-29-5)].

Compact spherically symmetric objects have been studied in the context of the old TeVeS theory. Giannios found the first TeVeS static spherically symmetric solutions and a subset of these describe stealth BH solutions [\[25\]](#page-26-0) which, however, led to superluminal propagation of scalar perturbations. Bekenstein and Sagi found stealth Reissner-Nordstrom (RN) type solutions [\[26\]](#page-26-11) where the RN charge was provided by the vector field present in TeVeS, which contained the Giannios solution but also a different branch which did not have the superluminality problem. Neutron star solutions were studied in [\[28\]](#page-26-2) while quasinormal modes were studied in [\[27](#page-26-1)]. A comprehensive summary of these solutions can be found in [\[95](#page-29-6)].

Given the few compact object solutions already found in TeVeS, some of which are of the stealth BH type, it is relevant to investigate the existence of compact object solutions in AeST. A first investigation of BH solutions in AeST can be found in [\[70](#page-28-7)]. There, the authors present a general construction approach drawn from Horndeski models for finding solutions without specifying the full Lagrangian in this theory. Using their procedure, they found two concrete solutions with very specific parameters which, however, lie outside the regime of stability of the theory [\[65](#page-27-8)]: a non-black hole solution and a very specific case of a hairy Schwarzschild black hole. Specific cases of neutron star solutions was concluded in [\[77](#page-28-8)] alongside the derivation of a TOV-like equation for this theory.

In this article we consider the general strong-field regime of the AeST theory that fully fixes the free function present in its Lagrangian and closes the system of the Einstein, scalar and vector field equations. We solve this system in the most general spherically symmetric static vacuum configuration leading to all possible classes of solutions under these assumptions. The paper is organized as follows: section [2](#page-4-0) presents the AeST theory and its vacuum equations in the strong field regime, alongside details about our ansatz. In section

[3,](#page-8-0) we solve these equations in a general setup under the assumption that the vector field has a spatial component which is non-zero but determined by the field equations. We follow in section [4](#page-14-0) with the case where the spatial component of the vector field is zero everywhere, filling the gap in the derivation of the solutions of section [3.](#page-8-0) In section [5](#page-16-1) we make some more comments on the consistency of found solutions, including their weak-field limits. Section [6](#page-17-0) concludes the findings of this paper and discusses further considerations. We use Greek letters to denote spacetime indices taking values in $0 \dots 3$, capital latin letter to denote angular indices taking values in $2 \ldots 3$, and use a $-+++$ signature and the curvature conventions of Wald [\[96](#page-29-7)]. We also define the usual (anti)symmetrization convensions $2X_{(\mu\nu)} \equiv X_{\mu\nu} + X_{\nu\mu}$ and $2X_{\mu\nu} \equiv X_{\mu\nu} - X_{\nu\mu}$.

2 Theory and field equations

The AeST theory contains a metric $g_{\mu\nu}$, a scalar field ϕ , and a unit time-like vector field A^{μ} . The action of the theory is

where ∇_{μ} is the covariant derivative, λ the Lagrange multiplier normalizing the vector field, G the bare gravitational strength, K_B a constant parameter of the theory similar to TeVeS theory, R is the Ricci scalar and $F_{\mu\nu} \equiv \nabla_{\mu}A_{\nu} - \nabla_{\nu}A_{\mu}$. We define the metric on orthogonal subspaces to A_μ as $q_{\mu\nu} = g_{\mu\nu} + A_\mu A_\nu$ and denote the associated covariant derivative as $D_{\mu} \equiv q_{\mu}^{\ \nu} \nabla_{\nu}$. Scalars in the Lagrangian are defined as $\mathcal{Q} \equiv A^{\mu} \nabla_{\mu} \phi$ and $\mathcal{Y} \equiv D^{\mu} \phi D_{\nu} \phi$ and the vector quantity $J_{\nu} \equiv A^{\mu} \nabla_{\mu} A_{\nu}$. The function $\mathcal F$ is generally left as a free function in the Lagrangian, however, it must obey specific constraints in order to have correct cosmological evolution and Newtonian and MOND limits. Note that the Lagrangian does not explicitly depend on ϕ ; the theory is shift symmetric in this scalar field.

2.1 Strong-field regime with correct cosmology

We set the theory to be in the strong-field regime by letting the free function of the theory F take on the form

where λ_s and \mathcal{K}_2 are constants. The first term in [\(2.2\)](#page-4-2) is necessary for having a consistent strong-field regime while the second term is the lowest order in an expansion in $Q-Q_0$ which leads to Friedman-Lemaître-Robertson-Walker (FLRW) evolution for the energy density of the scalar to be that of dust as is necessary for fitting CMB observations [\[64](#page-27-4)]. We do not include MOND terms of the form $\mathcal{Y}^{3/2}$, since we are interested in compact solutions with scales much smaller than the MOND radius. It was shown in [\[65](#page-27-8)] that stability of linear perturbations on Minkowski spacetime requires the conditions $0 < K_{\rm B} < 2, K_2 > 0$ and $\lambda_s \geq 0$ which we assume in the remaining of the article. With these in mind we define $\mu^2 \equiv 2\mathcal{K}_2 \mathcal{Q}_0^2/(2 - K_B)$ which is related to the scale of validity of Minkowski spacetime [\[65](#page-27-8)] as well as the quantities

and

obeying $0 < \tilde{n} \leq 1$ and $0 < \tilde{m} < 1$ which appear frequently in what follows.

Setting $\mathcal F$ to [\(2.2\)](#page-4-2) and varying the action with respect to the scalar field yields

where S^{μ} is the Noether current of the shift symmetry, while the vector field equation is found as

where we have defined $J \equiv \nabla_{\mu} A^{\mu}$. Finally, the vacuum Einstein equations take the form

where we have defined

$$
C^{(g)} \equiv -\frac{K_{\rm B}}{2} F_{\alpha\beta} F^{\alpha\beta} + (2 - K_{\rm B}) \left[2J^{\rho} D_{\rho} \phi - (1 + \lambda_s) \mathcal{Y} \right] + 2\mathcal{K}_2 \left(\mathcal{Q} - \mathcal{Q}_0 \right)^2, \tag{2.8}

to collect together these terms. Varying with respect to the Lagrange multiplier keeps the vector field normalized, that is, $A_{\mu}A^{\mu} + 1 = 0$.

2.2 Spherically symmetric static solutions

We impose spherical symmetry and staticity for the metric using the Schwarzschild-like coordinates t and r where the metric takes the form

where $\Phi = \Phi(r)$, $\Psi = \Psi(r)$ and $d\Omega^2$ is the metric of a 2-sphere. We denote differentiation with respect to the radial coordinate using the *'* symbol, i.e. $A' \equiv dA/dr$.

The notion of staticity for the fields is slightly more nuanced for the fields than the metric. Since the Lagrangian of the theory is only proportional to gradients of the scalar field and the theory is shift-symmetric, a linear term t in the scalar field is still a static configuration, as t would not appear anywhere in the field equations or the action. This means that foliations of the metric with constant t and surfaces of constant scalar field do not necessarily coincide, but the gradient of the scalar field is conserved on curves of constant r. Put it differently, the scalar field can sometimes be used as a time coordinate, which is called the unitary gauge. With these considerations we have that

$$
\phi = Q_0 R_1(r) t + R_2(r). \tag{2.11}
$$

This is the most general static spherically symmetric scalar field. Terms mixing t and r would not correspond to a static configuration, and dependence on t must be linear. However, this is not sufficient as with this ansatz, important scalars of the Lagrangian, such as Q, would be time-dependent. Therefore, our final ansatz reduces to

where $R = R(r)$ only and q is a constant integer which we use to distinguish *solution* classes and only takes the values $q = 0$ or $q = 1$. We briefly discuss the possibility $q = -1$ below. The ansatz [\(2.12\)](#page-6-2) is commonly used in other shift-symmetric theories, for further justification and references see [\[97](#page-29-8)[–99](#page-29-9)].

In order for the scalar to be continuously matched to the cosmological FLRW solution, its gradient must be timelike. In the converse case, that is, if its gradient were spacelike, there would be a surface of discontinuity in the gradient, or a type of acoustic horizon, surrounding bounded structures such as black holes or stars, if they are embedded in an FLRW cosmological background. Such a situation does not seem physical. Thus, the only physical solutions are those with $q = 1$, however, we find also the solution class $q = 0$ for completeness, as it could find use elsewhere.

We now turn to the vector field. Its components in the angular directions vanish as a result of the spherical symmetry, that is $A_2 = A_3 = 0$. Moreover, the unit-timelike constraint relates its A_0 component with its A_1 component and so only one independent function $A(r)$ remains which we choose to be the component $A_1 = A(r)$. Solving the unit-timelike constraint leads to $A_0 = -e^{\Phi}\chi$ where

In what follows, we will consider χ to carry the sign due to taking the square root above.^{[3](#page-6-3)}

2.2.1 Discrete symmetry

Setting the function F aside, the action has the discrete symmetry $A_{\mu} \to -A_{\mu}$. Correct cosmological behaviour can be expressed with F having the expansion $\mathcal{F} = -2\mathcal{K}_2(\mathcal{Q} - \mathcal{Q}_0)^2 +$ \dots where this symmetry seems to be generally broken, although functional forms of $\mathcal F$ where the symmetry is intact, and correct cosmological behaviour still emerges can be constructed, for instance, $\mathcal{F} \propto (Q^2 - Q_0^2)^2$. Nevertheless, as we will discuss later, in the small scale limit $\mu \rightarrow 0$ the symmetry holds and we use it to simplify the classification of solutions.

2.2.2 Asymptotic frame freedom

A general Lorentz transformation $\Lambda^{\mu}_{\mu'}$ preserves the Minkowski metric $\eta_{\mu\nu}$. Starting from the spherical system $\{t, r, \theta, \phi\}$ with a vector field in the form of $A_{\mu} = (-(1 + \bar{A}^2)^{1/2}, \bar{A}, 0, 0)$ with A a constant, we can then choose a Cartesian system aligned with the A_i axis so that the above form may be thought to hold in that system. We can then Lorentz-boost away the A_i component and bring A_μ into the form $A_\mu = (-1, 0, 0, 0)$. A second vector field, for instance, $\nabla_{\mu}\phi$, need not in general be in the same frame as A_{μ} . If we look at asymptotically flat solutions, we have the freedom perform Lorentz transformations to the two fields A_{μ} and $\nabla_{\mu} \phi$ at $r \to \infty$ without affecting the asymptotic metric. Specifically, in spherical symmetry there is only one spatial axis available which is the axis aligned with r , thus, as expected (and as we show below), the two asymptotic frames coincide, leading to simplifications of the solution. The reader is referred to appendix[-A](#page-19-0) for more details.

³It might seem that variables such as χ and e^{Φ} are not always well-defined, for instance, under horizons. However, components of the fields of the theory are always well-defined. As an example, we can see that in $A_0 = \pm \sqrt{\chi^2 e^{2\Phi}}$, taking the square root of either variable would be pathological, as both are negative, but taking the root of the combination $\chi^2 e^{2\Phi}$ yields a consistent result.

2.3 The field equations

We now present the field equations adapted to our ansatz. To aid the reader, we present some of the calculational steps in appendix [B.](#page-20-0)

2.3.1 The scalar and vector field equations

Rather than computing second derivatives of A , it is more useful to define the quantity $E \equiv e^{-\Phi} F_{01}$ which evaluates to

$$

We also define the frequently used variable $C^{(Q)}$ as

where the last equality has been evaluated using our static, spherical symmetric ansatz (2.10) and (2.12) . Since the theory is shift-symmetric, the scalar equation (2.5) is of the form $\nabla_{\mu}S^{\mu}=0$ for a current S^{μ} and can be integrated to obtain a Noether charge corresponding to the shift symmetry. In the SSS case we find that upon this integration the scalar equation gives

where ϕ_0 is an integration constant.

Due to the unit-norm constraint on the vector field, the $\mu = 0$ and $\mu = 1$ components of the vector equation (2.6) are linear combinations of each other and reduce to

\frac{K_{\rm B}}{2 - K_{\rm B}} e^{\Phi - 2\Psi} A \left[E' + \left(-\Psi' + \frac{2}{r} \right) E \right] - \mathcal{Q}_0 q \Phi' - 2q \mathcal{Q}_0 e^{-2\Psi} A^2 \left(\Phi' - \frac{1}{r} \right) \n+ \left[(1 + \lambda_s) \mathcal{Q}_0^2 \left(e^{-\Phi} \chi q + e^{-2\Psi} A R' \right) - \mu^2 C^{(2)} \right] \left(Aq + e^{\Phi} \chi R' \right) \n+ \mathcal{Q}_0 e^{\Phi - 2\Psi} \chi A \left\{ R'' + \left[-(\Phi' + \Psi') + \frac{2}{r} \right] R' \right\} = 0,
$$
\n(2.17)

which is equal to the $\mu = 1$ component of [\(2.6\)](#page-5-3) multiplied by $-\frac{e^{\Phi}}{(2-K)}$ $\frac{e^x}{(2-K_B)\chi}$. The angular components are identically zero, as expected.

2.3.2 The Einstein equations

The G_{01} component of the Einstein equation [\(2.7\)](#page-5-4) divided by 2 − K_B, leads to the relation

$$
0 = -\frac{K_{\rm B}}{2 - K_{\rm B}} e^{\Phi - 2\Psi} \chi^2 A \left[E' + \left(-\Psi' + \frac{2}{r} \right) E \right] - q \mathcal{Q}_0 \chi \left[E - \chi \Phi' - 2e^{-2\Psi} A^2 \chi \left(\Phi' - \frac{1}{r} \right) \right]
$$

-(1 + \lambda_s) \mathcal{Q}_0^2 e^{\Phi - 2\Psi} A \chi \left(e^{-\Phi} A q + \chi R' \right)^2 - \mathcal{Q}_0 e^{\Phi - 2\Psi} \chi^3 A \left[R'' + \left(-\Psi' - \Phi' + \frac{2}{r} \right) R' \right]
+ \mu^2 C^{(Q)} \left(e^{-2\Psi} A^3 q + e^{\Phi} \chi^3 R' \right). \tag{2.18}

We add the above equation [\(2.18\)](#page-7-3) to χ^2 times [\(2.17\)](#page-7-4) and then add [\(2.16\)](#page-7-5) to find the constraint on the scalar charge:

$$
\frac{\phi_0 e^{-\Phi + \Psi}}{r^2} = (1 - q) \left[\mathcal{Q}_0 \chi E - (1 + \lambda_s) \mathcal{Q}_0^2 \chi \left(e^{-\Phi} A q + \chi R' \right) + \mu^2 A C^{(Q)} \right]. \tag{2.19}
$$

Thus, in the case $q = 1$ we find $\phi_0 = 0$, while in the case $q = 0$, (2.16) holds without any constraint on ϕ_0 . These two cases are combined in the constraint

$$
q\phi_0 = 0.\tag{2.20}
$$

We now turn to the other Einstein equations. The G_{00} component of the Einstein equation [\(2.7\)](#page-5-4) multiplied by $e^{2(\Psi-\Phi)}$ gives

$$
\frac{2}{r}\Psi' + \frac{e^{2\Psi} - 1}{r^2} = e^{2\Psi}\chi^2 C^{(A)} - \frac{1}{2}e^{2\Psi}C^{(g)} + K_{\rm B}E^2 + (2 - K_{\rm B})\left(e^{-\Phi}Aq + \chi R'\right)\left[2\mathcal{Q}_0E + (1 + \lambda_s)\mathcal{Q}_0^2e^{-2\Psi}A^2\left(e^{-\Phi}Aq + \chi R'\right) - 2\mu^2A\chi C^{(Q)}\right].\tag{2.21}
$$

The G_{11} component of the Einstein equation (2.7) reduces to

$$
\frac{2}{r}\Phi' - \frac{e^{2\Psi} - 1}{r^2} = A^2 C^{(A)} + \frac{1}{2}e^{2\Psi}C^{(g)} - K_B E^2 + (2 - K_B)\left(e^{-\Phi}Aq + \chi R'\right)\left[-2Q_0E + (1 + \lambda_s)Q_0^2\chi^2\left(e^{-\Phi}Aq + \chi R'\right) - 2\mu^2A\chi C^{(Q)}\right],\tag{2.22}
$$

and finally, the G_{AB} Einstein equation [\(2.7\)](#page-5-4) multiplied by $e^{2\Psi}/r^2$ leads to

$$
\Phi'' + (\Phi' - \Psi') \left(\Phi' + \frac{1}{r} \right) = (2 - K_B) \left(e^{-\Phi} A q + \chi R' \right) \left[\mathcal{Q}_0 E - \frac{1}{2} (1 + \lambda_s) \mathcal{Q}_0^2 \left(e^{-\Phi} A q + \chi R' \right) \right] + \frac{K_B}{2} E^2 + \frac{1}{2} (2 - K_B) \mu^2 e^{2\Psi} \left(C^{(Q)} \right)^2.
$$
 (2.23)

To summarize, we have reduced the relevant equations to (2.14) , (2.16) , (2.20) , (2.21) , (2.22) and (2.23) , all of which hold for any A , even if it is zero everywhere. Below we find solutions to these equations. As we show, we do not need anymore (2.17) and (2.18) which can be used, however, to test consistency of the final solutions.

3 General solutions with $A \neq 0$

We now consider the main cases of this article. We assume that $A \neq 0$ except at a set of measure zero, so that we can freely divide by A. We proceed first by adding (2.21) and (2.22) and using (2.17) to eliminate E' and (2.16) to eliminate E, and also taking into consideration (2.19) , leads to

$$
\frac{2}{r} \left(\Phi' + \Psi' \right) = (2 - K_B) \mu^2 e^{2\Psi} \left(e^{-\Phi} \chi q + e^{-2\Psi} A R' - 1 \right) \left(q \frac{e^{-\Phi}}{\chi} + \frac{R'}{A} \right). \tag{3.1}
$$

Notice in the above equation A appears in the denominator, thus, our solutions which follow cannot have $A = 0$ over the whole of spacetime. However, we do find such special solutions where $A = 0$ and these are treated separately in section [4.](#page-14-0)

In this work we consider scales that are much smaller than the MOND radius, and therefore, much smaller than μ^{-1} . This then implies that the RHS of [\(3.1\)](#page-8-5) is negligible due to the μ^2 dependence, and we can safely assume

$$
\Psi = -\Phi,\tag{3.2}
$$

since we can set the constant of integration to zero by a temporal coordinate transformation. We consider the two distinct cases separately: $q = 1$ and $q = 0$.

3.1 Case $q = 1$

We first set $q = 1$ into (2.16) to find

$$
E = (1 + \lambda_s) \mathcal{Q}_0 \left(e^{-\Phi} A + \chi R' \right), \tag{3.3}
$$

and then add (2.22) and (2.23) to obtain an equation for the potential Φ as the only variable, which is

$$
\Phi'' + 2\Phi'\left(\Phi' + \frac{2}{r}\right) + \frac{1}{r^2} \left(1 - e^{-2\Phi}\right) = 0.
$$
\n(3.4)

The unique solution to the above equation is the RN metric, that is,

$$
e^{2\Phi} = 1 - \frac{2G_{\rm N}M}{r} + \frac{q_{BH}^2}{r^2},\tag{3.5}
$$

where we have defined the integration constants in analogy with the Einstein-Maxwell RN solution. Specifically, M is the black hole mass and q_{BH} its charge. The RN black hole has inner and outer horizons given by

$$
r_{\pm} = G_{\rm N} M \left(1 \pm \sqrt{1 - \sigma^2} \right) \tag{3.6}
$$

where $\sigma \equiv q_{BH}/(G_N M)$ is the normalized RN charge, and thus for a BH to exist we need $-1 \leq \sigma \leq 1$ with $|\sigma| = 1$ being the extremal case.

With this solution, taking the square root of both sides of (2.21) or (2.22) relates E to the metric

$$
\frac{q_{BH}}{r^2}e^{-\Phi} = \pm\sqrt{\tilde{n}}E,\tag{3.7}
$$

where it is understood that q_{BH} can take both positive and negative values. Notice that regardless of the sign of q_{BH} , there remains an ambiguity as to how the sign of E is associated with the sign of q_{BH} . Indeed, this is a matter of convention. To make a choice we use the electrodynamics analogy to define the vector field charge q_A as

$$
q_A \equiv \lim_{r \to \infty} \frac{1}{4\pi} \int_{S^2} F^{tr} r^2 \sin\theta d\theta d\phi = -\lim_{r \to \infty} e^{\Phi} E r^2 = \mp \frac{q_{BH}}{\sqrt{\tilde{n}}},\tag{3.8}
$$

where the last equality is after using [\(3.7\)](#page-9-1). Thus, we choose the convention that q_A and q_{BH} have the same sign, such that,

$$
q_A \equiv \frac{q_{BH}}{\sqrt{\tilde{n}}}, \quad \text{and} \quad E = -\frac{q_A e^{-\Phi}}{r^2}.
$$
 (3.9)

At this point, we may determine the solution for the fields A and ϕ . Formally integrating (2.14) we find $\chi = e^{-\Phi} \left(\chi_0 + \frac{q_A}{r} \right)$ $\binom{M}{r}$ where χ_0 is an integration constant. The integration constant χ_0 can be fixed by the frame freedom mentioned in section [2.2.2](#page-6-1) and expanded on in Appendix[-A.](#page-19-0) Taking the $r \to \infty$ limit, we have that $\chi \to \chi_0$, from which $A_{\mu}^{(\infty)} =$ $(-\chi_0, s_A\sqrt{\chi_0^2-1}, 0, 0)$, where $s_A = \pm 1$ is the sign of the spatial component of the vector field. Furthermore, from [\(3.9\)](#page-9-2) we have that $E \rightarrow 0$ and then [\(3.3\)](#page-9-3) implies that $R' \rightarrow$ $-s_A\sqrt{1-1/\chi_0^2}$, so that $\nabla_\mu\phi|^{(\infty)} = (Q_0, -s_AQ_0\sqrt{\chi_0^2-1/\chi_0}, 0, 0)$. This has the same form as [\(A.14\)](#page-20-1) and thus, the two frames specified by A_μ and $\nabla_\mu \phi$ are coincident. Therefore, the integration constant χ_0 has no physical meaning and we may set $\chi_0 = \pm 1$. Given this last condition, we must also ensure that χ is never zero at any finite distance r, otherwise a pathology would occur. This is readily done by associating the constant χ_0 with the sign of q_A , that is $\chi_0 = 1$ corresponds to $q_A > 0$ and $\chi_0 = -1$ to $q_A < 0$. Thus, in all generality we have that

$$
\chi = \chi_0 e^{-\Phi} \left(1 + \frac{|q_A|}{r} \right),\tag{3.10}
$$

Backgracing the steps until [\(3.7\)](#page-9-1), the convention is that positive q_A associates to a future directed A^{μ} and negative to past-directed A^{μ} .

From (3.10) and (2.13) we solve for A to find

$$
A = s_A e^{-2\Phi} \sqrt{\frac{2(|q_A| + G_N M)}{r} + \frac{(1 - \tilde{n})q_A^2}{r^2}},
$$
\n(3.11)

where $s_A = \pm 1$ is the sign of A, resulting from taking the square root. The vector field A is well defined for all values of r and has singularities exactly at the BH horizon at r_{+} due to the $e^{-2\Phi}$ factor. Just as in the case of the RN metric written in these coordinates, this is a coordinate and not a physical singularity, as we show more explicitly in subsection [3.1.2.](#page-12-0)

Remember that $A_{\mu} \to -A_{\mu}$ is a symmetry of the action in the case that $\mu = 0$, a condition which we have already imposed, see section[-2.2.1.](#page-6-0) In component form, this amounts to the symmetry under the simultaneous transformation $\chi_0 \to -\chi_0$ and $s_A \to -s_A$, in other words, $\{\chi_0 = 1(q_A > 0), s_A = -1\}$ and $\{\chi_0 = -1(q_A < 0), s_A = 1\}$ correspond to the same physical solution. Likewise, $\{\chi_0 = 1(q_A > 0), s_A = 1\}$ and $\{\chi_0 = -1(q_A < 0), s_A = -1\}$ is another set of equivalent solutions. Thus, we have two types of solutions and without loss of generality, we fix $\chi_0 = 1$, and let s_A take both positive and negative values. To make things more precise, we set $s_A = -\epsilon_A \text{Sign}(q_A)$, and let $\epsilon_A = \pm 1$ be a parameter which specifies the type of solution.

Having found the form of A, we then determine R' using [\(3.3\)](#page-9-3) and [\(3.11\)](#page-10-1) to get 4

$$
R' = -\frac{1}{1 + \frac{|q_A|}{r}} \left[\frac{1}{(1 + \lambda_s) Q_0} \frac{q_A}{r^2} + \epsilon_A e^{-2\Phi} \sqrt{\frac{2(|q_A| + G_N M)}{r} + \frac{(1 - \tilde{n}) q_A^2}{r^2}} \right].
$$
 (3.12)

One can further integrate the above equation to get $R(r)$, however, the result is rather complicated and not particularly illuminating and so we refrain of showing it except in the special case of $q_{BH} = 0$ below. We have thus found the full solution which depends on three parameters, being the mass $M \geq 0$, charge q_A and discrete parameter $\epsilon_A = \pm 1$.

We finally discuss the scalar Q which should neither diverge nor vanish within the regime of validity of the solution, that is, for $r \geq r_{+}$. We find

$$
\mathcal{Q} = \frac{\mathcal{Q}_0}{1 + \frac{|q_A|}{r}} \left[1 + \frac{\epsilon_A |q_A|}{(1 + \lambda_s) \mathcal{Q}_0 r^2} \sqrt{\frac{2(|q_A| + G_N M)}{r} + \frac{(1 - \tilde{n}) q_A^2}{r^2}} \right].
$$
 (3.13)

We see that Q is never divergent for any $\epsilon_A = \pm 1$, and moreover, in the case of the solution branch $\epsilon_A = 1$ it never vanishes. However, it can vanish at a non-zero r in the case $\epsilon_A = -1$,

⁴Notice that $R = 0$ is not a consistent solution because in that case we find that $A = -\frac{q_A}{(1+\lambda_s)Q_0r^2}$ which results in $\chi = \chi_0 \sqrt{1 + e^{2\Phi} \frac{q_A^2}{(1 + \lambda_s)^2 Q_0^2 r^4}}$. However, this χ solution cannot be consistent with [\(3.10\)](#page-10-0).

and this can be avoided provided this point occurs at a point below the horizon. Indeed, starting from a set of parameters for the theory $\{\lambda_s, \mathcal{Q}_0, K_B\}$ as well as (normalized) charge σ , there is a lower bound on possible masses of black holes with this particular solution branch given by

$$
G_N^2 M^2 > \frac{\sigma^2 \left[2\left(\frac{|\sigma|}{\sqrt{\tilde{n}}} + 1\right)\left(1 \pm \sqrt{1 - \sigma^2}\right) + \sigma^2 \left(\frac{1}{\tilde{n}} - 1\right)\right]}{\tilde{n}(1 + \lambda_s)^2 \mathcal{Q}_0^2 \left[1 \pm \sqrt{1 - \sigma^2}\right]^6}.
$$
(3.14)

Notice that this bound does not include the $M = 0$ case. This may be an indication that these solutions can only form with masses higher than this minimum mass bound. Ultimately, it is a question of BH formation rather than constraints on the theory parameters. The full viability of these solutions could be differentiated by a robust treatment of stability via perturbations, which we leave for further work.

3.1.1 Schwarzschild case in suitable coordinates

In the Schwarzschild case $q_{BH} = 0$, the fields simplify significantly. Specifically we have that $\chi = e^{-\Phi}$ and $E = 0$, while

$$
A = s_A e^{-2\Phi} \sqrt{\frac{2G_N M}{r}}, \qquad R' = -A, \qquad (3.15)
$$

and the scalar field can be integrated to

$$
\phi = Q_0 t - 2s_A Q_0 \left[\sqrt{2G_N Mr} - G_N M \ln \left| \frac{1 + \sqrt{\frac{2G_N M}{r}}}{1 - \sqrt{\frac{2G_N M}{r}}} \right| \right].
$$
\n(3.16)

More interestingly $\mathcal{Q} = \mathcal{Q}_0$ exactly, which is a finite constant. This means that we retain the sign freedom in choosing s_A in this case. This is because, in the Schwarzschild case a new symmetry emerges due to the fact that $E = 0$. This allows transformations of the form $A \rightarrow -A$ and $R' \rightarrow -R'$ while keeping $\chi > 0$ which leave the spherically symmetric field equations invariant, letting the vector field switch between ingoing and outgoing configurations irrespective of the original A_μ symmetry. This means that we can simply chose $s_A = 1$ by convention in the Schwarzschild case.

It is evident that both the vector field and the scalar field are divergent at the horizon. However, this is not a physical divergence. Observe that [\(3.16\)](#page-11-1) allows us to define a new time coordinate $\tau(t,r)$ via $\phi = \mathcal{Q}_0 \tau$. More detailed, we may transform to coordinates τ and

$$
\rho
$$
 via the coordinate transformation $t(\tau, \rho) = \tau + 2s_A \left[\sqrt{2G_NMr} + G_N M \ln \frac{1 - \sqrt{\frac{2G_N M}{r}}}{1 + \sqrt{\frac{2G_N M}{r}}} \right]$ and

 $r(\tau,\rho)=(2G_{\rm N}M)^{1/3}\left(\frac{3}{2}\right)$ $\frac{3}{2}|\tau - \rho|$)^{2/3}, which brings the metric in the Lemaître-Novikov form

$$
ds^{2} = -d\tau^{2} + \frac{2G_{\rm N}M}{r}d\rho^{2} + r^{2}d\Omega
$$
\n(3.17)

while the vector field aligns with the τ direction exactly, that is, $A_{\mu'} = (-1, 0, 0, 0)$. ^{[5](#page-11-2)} These coordinates acquire a physical meaning, as the rest-frame coordinates of a radially ingoing $(s_A = 1)$ or radially outgoing $(s_A = -1)$ geodesic observer freely falling towards to (or outwards from) the BH.

⁵This form of the Schwarzschild solution in AeST theory has been independently discovered by T. Zlosnik as an educated guess that the BH should be continuously joined to FLRW solution for which $\phi = \mathcal{Q}_0 \tau$.

3.1.2 Eddington-Finkelstein coordinates and regularization of RN case

The singularity of the RN metric occuring at $r = r_{\pm}$ is commonly removed by transforming to Eddington-Finkelstein (EF) coordinates. We show in this section that transforming to EF coordinates also removes the singularities of the vector and scalar field.

As in GR, we define the tortoise radial coordinate r^* using $\frac{dr^*}{dr} \equiv e^{-2\Phi} = \frac{1}{(1-\frac{r}{r})^2}$ $\frac{(1-\frac{r_+}{r})(1-\frac{r_-}{r})}{r}$ leading to

$$
r^* = r + \frac{r_+^2}{r_+ - r_-} \ln \left| \frac{r}{r_+} - 1 \right| + \frac{r_-^2}{r_- - r_+} \ln \left| \frac{r}{r_-} - 1 \right| \tag{3.18}
$$

which is then used to define the ingoing u_+ and outgoing u_+ EF coordinates via $u_{\pm} = t \pm r^*$. In these coordinates the metric takes the well known form $ds^2 = -e^{2\Phi} du_+ du_- + r^2 d\Omega^2$. But the above metric, while non-singular at the horizon, is actually degenerate: it's determinant vanishes at the horizon, and in fact its inverse becomes singular there. In GR this is usually resolved be further transforming to Kruskal coordinates, however, another possibility is to keep within either the ingoing or outgoing branch of the EF coordinates. In that case, we transform t to either u_+ or u_- but keep r as a coordinate so that $ds^2 = -e^{2\Phi} du_{\pm}^2 \pm 2du_{\pm} dr +$ $r^2d\Omega^2$ which is non-singular at the horizon and not degenerate. We now demonstrate that the vector and scalar fields are also non-singular at the horizon when expressed in this coordinate system.

Using $2G_N M = r_+ + r_-$ and $q_A^2 \tilde{n} = r_+ r_-$ we can express the vector field as

$$
\underline{A} = -\left(1 + \frac{\sqrt{r_+ r_-}}{\sqrt{\tilde{n}} r}\right) du_{\pm} + \frac{s_{EF}\left(1 + \frac{\sqrt{r_+ r_-}}{\sqrt{\tilde{n}} r}\right) + s_A \sqrt{\frac{r_+ + r_-}{r}} + \frac{2\sqrt{r_+ r_-}}{\sqrt{\tilde{n}} r} + \frac{1 - \tilde{n}}{\tilde{n}} \frac{r_+ r_-}{r^2}}{(1 - \frac{r_+}{r})\left(1 - \frac{r_-}{r}\right)} dr,\tag{3.19}
$$

where $s_{EF} = 1$ if we choose the outgoing coordinate u_+ and $s_{EF} = -1$ for the ingoing $u_$ case. We proceed by expanding the radius r near the horizon(s). We first set $r = r_{+}(1 + \epsilon)$ and consider the limit $\epsilon \to 0$. Provided that $s_A = -s_{EF}$, we find

$$
\underline{A} = -\left(1 + \sqrt{\frac{r_{-}}{\tilde{n}r_{+}}}\right)du_{\pm} + s_{EF}\frac{dr}{2\left(1 + \sqrt{\frac{r_{-}}{\tilde{n}r_{+}}}\right)} + O(\epsilon),\tag{3.20}
$$

which is finite, while a divergence occurs as $\epsilon \to 0$ if $s_A = s_{EF}$. We analogously investigate the inner horizon and set $r = r_-(1+\epsilon)$, leading to a similar non-divergent result as in [\(3.20\)](#page-12-2), except that $r_-\leftrightarrow r_+$ in how they occur in [\(3.20\)](#page-12-2), and for the same correspondence between s_{EF} and s_A . We conclude that the field divergences in A_μ and ϕ at the RN horizons are a coordinate effect, just as in the case of the metric, and can be removed with a suitable coordinate transformation.

3.2 Case $q = 0$

In this case, (2.20) does not necessarily imply that $\phi_0 = 0$, which means that ϕ_0 can in principle take any value. Specifically, in this case we have that

$$
E = (1 + \lambda_s) \mathcal{Q}_0 \chi R' + \frac{\tilde{\phi}_0 e^{-2\Phi}}{\chi r^2},\tag{3.21}
$$

where $\tilde{\phi}_0 \equiv \phi_0/Q_0$, and which is to be contrasted with [\(3.3\)](#page-9-3) from the $q = 1$ case. Setting $q = 0 = \mu$ and $\Psi = -\Phi$ into [\(2.21\)](#page-8-2) and [\(2.23\)](#page-8-4), and eliminating R' in terms of E and ϕ_0 using (3.21) , leads to

$$
\frac{2}{r}\Phi' + \frac{1 - e^{-2\Phi}}{r^2} = -\tilde{n}E^2 + \frac{2 - K_B}{2(1 + \lambda_s)}\frac{\tilde{\phi}_0^2 e^{-4\Phi}}{\chi^2 r^4},\tag{3.22}
$$

$$
\Phi'' + 2\Phi'\left(\Phi' + \frac{1}{r}\right) = \tilde{n}E^2 - \frac{(2 - K_B)}{2(1 + \lambda_s)}\frac{\tilde{\phi}_0^2 e^{-4\Phi}}{\chi^2 r^4},\tag{3.23}
$$

for (2.21) and (2.23) respectively. Therefore, adding the last two equations, leads once more to (3.4) as in the $q = 1$ case, and so once again the RN metric (3.5) is the most general solution.

Given the metric solution (3.5) , we insert it back into (3.22) to find the relation

$$
E = s_E \frac{e^{-\Phi}}{r^2} \sqrt{\frac{q_{BH}^2}{\tilde{n}} + \frac{\tilde{m}^2 \tilde{\phi}_0^2 e^{-2\Phi}}{\chi^2}},
$$
\n(3.24)

where $s_E = \pm 1$. Then, directly integrating [\(2.14\)](#page-7-6) and eliminating E using this last relation, leads to $e^{2\Phi}\chi^2 = \frac{\tilde{n}\tilde{m}^2}{Q^2 a^2}$ $\frac{\tilde{n}\tilde{m}^2}{\mathcal{Q}_0^2 q_{BH}^2} \left[\left(u_0 - s_E \frac{\mathcal{Q}_0 q_{BH}^2}{\tilde{m}\tilde{n}} \right) \right]$ 1 $\left(\frac{1}{r}\right)^2 - \phi_0^2$, where u_0 is an integration constant. Once more we apply the frame freedom which fixes $u_0^2 = \varphi_0^2 + \frac{\mathcal{Q}_0^2 q_{BH}^2}{\tilde{n}\tilde{m}^2}$, and so the solution χ turns into

$$
\chi = s_{\chi_0} e^{-\Phi} \sqrt{1 + \frac{2s_{u_0} \tilde{m} |u_0|}{\mathcal{Q}_0} \frac{1}{r} + \frac{q_{BH}^2}{\tilde{n}} \frac{1}{r^2}},\tag{3.25}
$$

where $s_{\chi_0} = \pm 1$ and we have set $u_0 = -s_{u_0} s_E |u_0|$, where $s_{u_0} = \pm 1$ as the two possibilities relating to the sign (but not equal) of u_0 . The first case, $s_{u_0} = +1$, implies that χ is well defined for all values of r and diverges only at the two horizons and at the singularity $r = 0$. The second case, $s_{u_0} = -1$, can lead to χ vanishing at a finite distance $r > r_{\pm}$. A necessary and sufficient condition for avoiding this is

$$
G_{\rm N}M \ge \frac{\tilde{m}|u_0|}{\mathcal{Q}_0},\tag{3.26}
$$

which is to be applied only to the $s_{u_0} = -1$ case and not to $s_{u_0} = 1$. This last relation is to be contrasted with (3.14) in the case of the $q = 1$ solution, only in the latter case, the bound comes from requiring the non-vanishing of Q.

We now give a physical meaning to the constant u_0 appearing above. Using (3.25) into (3.24) leads to

$$
E = s_E s_{\chi_0} \frac{e^{-\Phi}}{r^2} \frac{-s_E \frac{\tilde{m}u_0}{\tilde{\mathcal{Q}}_0} + \frac{q_{BH}^2}{\tilde{n}r}}{\sqrt{1 + \frac{2s_{u_0} \tilde{m}|u_0|}{\tilde{\mathcal{Q}}_0} \frac{1}{r} + \frac{q_{BH}^2}{\tilde{n}} \frac{1}{r^2}}},
$$
(3.27)

and analogously to the $q = 1$ case, we define an A-charge q_A as

$$
q_A \equiv \lim_{r \to \infty} \frac{1}{4\pi} \int_{S^2} F^{tr} r^2 \sin\theta d\theta d\phi = -\lim_{r \to \infty} e^{\Phi} E r^2 = s_{\chi_0} \frac{\tilde{m} u_0}{\mathcal{Q}_0}.
$$
 (3.28)

Notice that just as in the $q = 1$ case, there is an ambiguity as to how we associate charge to u_0 . Taking the limit $\phi_0 \to 0$ we find $q_A \to -s_{\chi_0} s_E \frac{q_{BH}}{\sqrt{\tilde{n}}}$, and so, we choose the convention that in this limit $q_A \rightarrow \frac{q_{BH}}{\sqrt{\hat{n}}}$ as in [\(3.9\)](#page-9-2) from the $q = 1$ case. This fixes $s_{\chi_0} = 1$, while $s_E = -1$ so that $u_0 = s_{u_0}|u_0|$. Then

$$
q_A = \frac{\tilde{m}u_0}{Q_0},\tag{3.29}
$$

which implies the following relation between the A-charge, scalar charge ϕ_0 and BH charge q_{BH}

$$
q_A^2 = \frac{\tilde{m}^2}{\mathcal{Q}_0^2} \varphi_0^2 + \frac{q_{BH}^2}{\tilde{n}}.\tag{3.30}
$$

With the above considerations and conventions we form the final solution for χ and E as

$$
\chi = e^{-\Phi} \sqrt{1 + \frac{2q_A}{r} + \frac{q_{BH}^2}{\tilde{n}} \frac{1}{r^2}}, \qquad E = -\frac{e^{-\Phi}}{r^2} \frac{q_A + \frac{q_{BH}^2}{\tilde{n}r}}{\sqrt{1 + \frac{2q_A}{r} + \frac{q_{BH}^2}{\tilde{n}} \frac{1}{r^2}}}, \qquad (3.31)
$$

while from χ , using (2.13) we immediately obtain A as

$$
A = s_A e^{-2\Phi} \sqrt{\frac{2(G_\text{N}M + q_A)}{r} + \frac{q_{BH}^2(1 - \tilde{n})}{\tilde{n}} \frac{1}{r^2}}.
$$
\n(3.32)

This is in fact identical to (3.11) , even though the solution for χ is different (as well as the relation between q_A and q_{BH}). Likewise, using [\(3.31\)](#page-14-1) into [\(3.21\)](#page-12-3) and integrating, give the solution for the scalar as

$$
(1+\lambda_s)\phi = \ln\sqrt{1+\frac{2q_A}{r}+\frac{q_{BH}^2}{\tilde{n}}\frac{1}{r^2}}+\frac{s_{\phi_0}}{2\tilde{m}}\ln\frac{1+\frac{q_A+\tilde{m}|\tilde{\phi}_0|}{r}}{1+\frac{q_A-\tilde{m}|\tilde{\phi}_0|}{r}},
$$
(3.33)

where s_{ϕ_0} is the sign of ϕ_0 .

Before concluding this section, note that important scalar $\mathcal{Q} = \mathcal{Q}_0 e^{2\Phi} A R'$ behaves correctly for all branches. Moreover, we note that all the above expressions are valid also in the cases of $q_{BH} = 0$, or if $\phi_0 = 0$ as we have explicitly verified, and so these special cases connect smoothly to the general case. In appendix [D](#page-24-0) we show the special Schwarzschild case where $q_{BH} = 0$.

4 Algebraically special solutions with $A = 0$

In section [3](#page-8-0) we have assumed that $A \neq 0$ which is important in reaching [\(3.1\)](#page-8-5). Let us now consider algebrically special cases, which amount to setting $A = 0$ everywhere in (2.14) , (2.16) , (2.20) , (2.21) , (2.22) and (2.23) . This is a case partially motivated by similar type of solutions found in the case of TeVeS theory [\[25](#page-26-0), [26](#page-26-11)]. Note that this implies that $\chi = \pm 1$ and so [\(2.14\)](#page-7-6) becomes $E = \chi \Phi' = \pm \Phi'$. We consider both $q = 1$ and $q = 0$ separately.

4.1 Case $q = 1$

Here (2.20) implies that $\phi_0 = 0$, thus, setting $A = 0$ and $q = 1$ in (2.16) , (2.21) , (2.22) and (2.23) , and leaving the details for appendix[-C](#page-21-0) we find the scalar field as

$$
\phi = Q_0 t + \frac{1}{2n(1+\lambda_s)} \ln \frac{|u - u_2|}{|u - u_1|} \tag{4.1}
$$

and the metric as

$$
ds^{2} = -\frac{|u - u_{2}|^{\frac{1}{n}}}{|u - u_{1}|^{\frac{1}{n}}}dt^{2} + \frac{r_{0}^{2}}{u^{2}}\frac{|u - u_{1}|^{\frac{1+n}{n}}}{|u - u_{2}|^{\frac{1-n}{n}}}\left[\frac{du^{2}}{\tilde{n}(u - u_{1})(u - u_{2})u^{2}} + d\Omega^{2}\right].
$$
 (4.2)

The new coordinate u is implicitly given through the coordinate transformation

$$
r(u) = \frac{r_0}{|u|} \frac{|u - u_1|^{\frac{1+n}{2n}}}{|u - u_2|^{\frac{1-n}{2n}}},
$$
\n(4.3)

where r_0 is an arbitrary scale, $n \equiv \sqrt{1 - \tilde{n}}$ and $u_1 = -1/(1 + n)$ and $u_2 = -1/(1 - n)$ are the two roots of the polynomial $p(x) = 1 + 2x + \tilde{n}x^2$, and since $0 \le n < 1$ then $u_2 < u_1 < 0$. The scalar curvature of this solution is

$$
\mathcal{R} = -\frac{2u^4}{r_0^2(u - u_1)(u - u_2)} \frac{|u - u_2|^{\frac{1 - n}{n}}}{|u - u_1|^{\frac{1 + n}{n}}}
$$
(4.4)

From (4.3) we see that there are four disconnected solution branches:

• Branch I: $u \geq 0$. This branch covers the manifold from a minimum radius $r = r_0$ corresponding to $u \to \infty$, to spatial infinity $r \to \infty$ corresponding to $u = 0$. The scalar curvature is finite and negative during the entire range, corresponding to $\mathcal{R} = 0$ as $r \to \infty$ and $\mathcal{R} \to -2/r_0^2$ as $r \to r_0$. Moreover, as $r \to \infty$ we have that $\phi' \to 0$, and so the frame of A_μ and $\nabla_\mu \phi$ coincide. This interesting behaviour deserves further investigation elsewhere.

We may also define an A-charge for this solution analogously to section [3](#page-8-0) by setting $q_A \equiv \lim_{r \to \infty} \frac{1}{4r}$ $\frac{1}{4\pi} \int_{S^2} F^{tr} r^2 \sin \theta d\theta d\phi = \pm \lim_{u \to 0^+} e^{\Phi} ur$. This leads to $q_A = \mp r_0 / \sqrt{\pi}$.

- Branch II: $u_1 < u \leq 0$. For this branch, the upper limit corresponds to spatial infinity $r \to \infty$, while the lower limit corresponds to $r = 0$, however, there the scalar curvature diverges. Thus this branch has a naked singularity and is not expected to be physical.
- Branch III : $u_2 < u < u_1$. This branch has a metric signature $+ +$ and is therefore not physical.
- Branch IV: $u < u_2$. This last branch has some similarities with branch I, that is, as $u \to -\infty$, then $r \to r_0$ while as $u \to u_2$ then $r \to \infty$. The former limit also has the property that the scalar curvature $\mathcal{R} \to -2/r_0^2$, however, the latter limit leads to three subcases concerning the behaviour of R. If $0 \le n < 1/2$ (branch IV_a) then, $\mathcal{R} \to 0$ as $r \to \infty$, and this behaviour is similar to branch I. If $1/2 < n < 1$ (branch IV_c) then R diverges as $r \to \infty$, and so this subcase is pathological. If $n = 1/2$ exactly (branch IV_b), then, R interpolates between its value at $r = r_0$ and $R = -\frac{81}{8r_0^2}$ $\frac{81}{8r_0^2}$ at $r \to \infty$.

Nevertheless, as $u \to u_2$ ($r \to \infty$), we have that $\nabla_\mu \phi \nabla^\mu \phi$ diverges and so this branch is not expected to be physical.

To summarize, out of the four identified branches, only branch I is expected to be physical.

4.2 Case $q = 0$

We briefly comment on the subcase $q = 0$, and again leaving the details for Appendix[-C,](#page-21-0) we get a condition $\mu R' = 0$ from combining the [\(2.16\)](#page-7-5), [\(2.17\)](#page-7-4) and [\(2.18\)](#page-7-3) equations. It turns out that the $R' = 0$ possibility reduces to the $A = 0, q = 1$ case considered above, with the identification $\tilde{n} \to K_B/2$. However, here we also have a non-zero ϕ_0 and this leads to the relation $\mathcal{Q}_0r_0=|\phi_0|\sqrt{\frac{K_{\rm B}}{2}}$ while $\text{Sign}(u)=\text{Sign}(\phi_0)$, that is, the branch is chosen by the sign of ϕ_0 .

Letting $\mu = 0$ without a priori setting R' to anything leads to a single equation for the metric potential

$$
\Psi'' + \frac{1}{r} \left(3e^{2\Psi} + 1 \right) \Psi' + \frac{1}{r^2} e^{2\Psi} \left(e^{2\Psi} - 1 \right) = 0, \tag{4.5}
$$

which admits a Schwarzschild solution for the metric, and scalar hair

$$
\phi = \frac{1 \pm \sqrt{\frac{2 + K_{\rm B} \lambda_s}{2 - K_{\rm B}}}}{2(1 + \lambda_s)} \ln\left(1 - \frac{2G_{\rm N}M}{r}\right). \tag{4.6}
$$

Unfortunately we have not found more general solutions, and given the low interest in this particular case, we leave it for another investigation.

5 Discussion

We have already validated that the scalar Q is regular at the BH horizons in section[-3.](#page-8-0) Moreover, since the metric solution is of the RN type, then all curvature invariants are also well-behaved. In the case $q = 1$ we have that $\mathcal{Y} = -e^{\Phi} E/(1 + \lambda_s) = -\frac{1}{1+\lambda_s}$ $1+\lambda_s$ q_A $\frac{q_A}{r^2}$ which is therefore regular at the horizon and the same can be shown to true in the $q = 0$ case, where $\mathcal{Y} = \mathcal{Q}_0^2 e^{2\Phi} \chi^2 R^2$, using [\(3.31\)](#page-14-1) and [\(3.21\)](#page-12-3). Hence, the scalar kinetic term is also regular there.

Another important scalar that frequently appears in shift-symmetric theories is the term $S^{\mu}S_{\mu}$ formed out of the shift symmetry Noether current [\(2.5\)](#page-5-2). If $\Phi = -\Psi$, then a commonly used argument (see [\[100\]](#page-29-10) as a coherent example) states that the horizon should be a regular locus and any scalar quantity $\mathcal O$ should not diverge there. Otherwise, given $\mathcal O$ which diverges at the horizon, adding a term $\epsilon_h \mathcal{O}$ for a constant ϵ_h to the Lagrangian would change the solution to the field equations for any ϵ_h , regardless of how small ϵ_h is made. For the $q = 1$ branch, this term is identically zero, while for the $q = 0$ branch, it evaluates to $S^{\mu}S_{\mu} = \frac{\tilde{\phi}_0^2(2-K_{\rm B})^2}{e^{2\Phi_{\rm V}2}r^4}$ $\frac{e^{2\Phi}(\lambda^2 - \Lambda_B)}{e^{2\Phi} \lambda^2 r^4}$, which for the [\(3.31\)](#page-14-1) solution it is regular at all points $r > 0$, including the horizons $\tilde{r} = r_{\pm}$.

Checking the divergence of scalar quantities at horizons becomes even more involved if we require that the BH should be continuously joined to a cosmological spacetime. The $q = 1$ case of section [3](#page-8-0) has the right properties for doing so, however, as we have explicitly removed the cosmological dependence (the solutions are asymptotically flat), more checking is necessary for ensuring this is the case. One could try to find solutions which are asymptotically de Sitter, see [\[101\]](#page-29-11) where this was addressed in the case of scalar Gauss-Bonnet theory, and check that they do remain regular at both the BH and at the de Sitter horizon. We conjecture that this does not pose a problem, and leave it for a future investigation.

Finally, let us consider what could happen if the full $\mathcal{J}(\mathcal{Y}) = \mathcal{F}(\mathcal{Y}, \mathcal{Q}_0)/(2-K_B)$ function is included, so that the solution smoothly joins to the MOND regime. Upon inspection of the

Einstein equations, it seems that in the limit $\mu \to 0$, that is, considering scales smaller than $r_C \sim (G_{\rm N}M/a_0)^{1/6}\mu^{-2/3}$ (see [\[72](#page-28-12)]), then the condition $\Psi = -\Phi$ is retained. However, the RHS of [\(3.4\)](#page-9-4) is no longer expected to be zero, but rather proportional to $\mathcal{YJ}_{\mathcal{V}} - \mathcal{J}$, hence, the full solution will no longer be the RN solution, once scales close to the MOND radius become important. Interestingly, since $E = 0$ in the $(q = 1)$ Schwarzschild case, then also $\mathcal{Y} = 0$, and hence, we do not expect the Schwarzschild solution of section [3.1](#page-9-0) to be smoothly joinable to the MOND regime. These issues could be addressed elsewhere.

6 Conclusion

We have found the most general classes of static spherically symmetric solutions in the AeST theory assuming the strong field regime which amounts to looking at scales smaller than the characteristic radius where MOND effects would appear. We found two classes of stealth black holes – black holes with geometries identical to GR black holes – with non-trivial secondary hair. Specifically, the BH geometry is that of the Reissner-Nordstrom spacetime. The first class, $q = 1$, was presented in section[-3.1](#page-9-0) and consists of consistent black hole candidates with zero shift-charge, which can in principle be smoothly connected to the cosmological regime. This is possible because the gradient of the scalar field for this class is by construction timelike. Some further important considerations before the smooth extension of this class to cosmology can be established are found in the discussion section[-5.](#page-16-1) The second class, $q = 0$, was presented in section[-3.2](#page-12-1) and consists of consistent black hole candidates with non-zero shift-charge and spacelike scalar field gradient. As such, it is unlikely that this class can be smoothly connected to cosmology. Apart from the RN black holes, we also found algebraically special solutions where the vector field is aligned with the time direction, see section[-4.](#page-14-0) These solutions have no horizon and can be extended only down to a finite distance $r₀$. The solution space of these algebraically special class also contains non-physical branches which contain naked singularities. Our solutions are summarized in table[-1.](#page-18-0)

Since we have found the most general static spherically symmetric vacuum solutions, these can also be considered as possible exterior stellar solutions, for example the neutron star solutions found in [\[77](#page-28-8)]. Importantly, it would be interesting to study the stability of these solutions to small time-dependent fluctuations. Ultimately, only the stable branches should be considered as physically viable solutions. Studying such fluctuations and resulting quasinormal modes and gravitational radiation, as well as resulting observational constraints on parameters of the theory is left for future work. Finally, it would be very interesting to investigate the thermodynamics of our new solutions, another subject to be studied in further work.

A Lorentz transformations and flat spacetime symmetries

A general Lorentz transformation $\Lambda^{\mu}_{\mu'}$ preserves the Minkowski metric, that is, if we assume a cartesian system such that $\eta_{\mu\nu} = \hat{d}iag(-1,1,1,1)$ then $\eta_{\mu'\nu'} = \Lambda^{\mu}_{\mu'}\Lambda^{\nu}_{\nu'}\eta_{\mu\nu}$ is also of the form $\eta_{\mu'\nu'} = diag(-1, 1, 1, 1)$. The vector field A_{μ} and the scalar field gradient $\nabla_{\mu}\phi$ will also transform. We can boost into the frame of either one to simplify expressions, however, in general, these two frames do not necesserily have to coincide.

Consider general Lorentz boosts in a direction β

where χ_0 and ϕ_f are arbitrary constants, with the latter obeying $\phi_f < 1$. We then perform a Lorentz transformation into a special frame chosen by $\beta = s_A \sqrt{1 - 1/\chi_0^2}$ which is none other than the vector frame, that is, $A'_{\mu} = (-1, 0, 0, 0)$. With this choice of β , the scalar transforms to

Redefining \mathcal{Q}_0 and ϕ_f to $\hat{\mathcal{Q}}_0$ and $\hat{\phi}_0$ we get the vector frame (performing also rotations to bring the \hat{z} axis into a general direction), as

\phi = \frac{\hat{Q}_0}{\sqrt{1 - \hat{\phi}_0^2}} \left[t + \hat{\phi}_0 r \right],\tag{A.11}
$$

with $\hat{\phi}_0 < 1$, s.t. $\nabla_{\mu} \phi \nabla^{\mu} \phi = -\hat{\mathcal{Q}}_0^2 < 0$, and where $r = \sqrt{x^2 + y^2 + z^2}$, is the distance along \hat{n} . Likewise, in the scalar frame, we have

$$
\vec{A} = -\gamma \tag{A.12}
$$
\n
$$
\vec{A} = \gamma \hat{\phi}_0 \hat{n} \tag{A.12}
$$

$$
\dot{\phi} = \mathcal{Q}_0 \qquad \qquad \vec{\nabla}\phi = 0 \qquad (A.13)
$$

Thus, in general an additional parameter appears, $\hat{\phi}_0$, which expresses the tilt of the two frames: scalar vs vector.

Suppose, however, that we have a situation where $\phi_f + \beta = 0$, in $(A.8)$, so that

$$
\dot{\phi} = Q_0 \qquad \qquad \vec{\nabla}_i \phi = -Q_0 s_A \frac{\sqrt{\chi_0^2 - 1}}{\chi_0} \hat{z}.
$$
 (A.14)

Then the two frames coincide, such that

$$
\frac{\partial \phi}{\partial t'} = Q_0 / \chi_0 \qquad \qquad \vec{\nabla}_{i'} \phi = 0 \qquad (A.15)
$$

This is indeed the case of our solutions found in section[-3.](#page-8-0)

B Important middle calculation steps

Using the metric (2.10) , where to remind the reader, capital Latin letters denote angular indices which take values in 2 . . . 3 we find the non-zero components of the vector field covariant derivatives to be

\nabla_0 A_0 = - e^{2(\Phi - \Psi)} A \Phi', \qquad (B.1)
$$

\nabla_0 A_1 = e^{\Phi} \chi \Phi', \qquad (B.2)

J = e^{-2\Psi} \left[A' + A \left(\Phi' - \Psi' + \frac{2}{r} \right) \right]
$$
 (B.9)

and

$$
F_{\mu\nu}F^{\mu\nu} = -2e^{-2\Psi}E^2
$$
\n(B.10)

$$
\nabla_{\mu} F^{\mu}_{0} = -e^{\Phi - 2\Psi} \left[E' + \left(-\Psi' + \frac{2}{r} \right) E \right]
$$
\n(B.11)

while $\nabla_{\mu} F^{\mu}_{i} = 0.$

Useful components of Einstein and field equations in our coordinates include:

$$
q^{\lambda}_{\rho}\nabla_{\lambda}\nabla^{\rho}\phi = Q_0 e^{-2\Psi} \left[\chi^2 R'' - 2e^{-\Phi} \chi A q \Phi' + \left(\frac{2}{r} - \chi^2 \Psi' - e^{-2\Psi} A^2 \Phi' \right) R' \right]
$$
(B.12)

$$
J^{\rho}D_{\rho}\phi = Q_0 e^{-2\Psi} E \left(e^{-\Phi} q A + \chi R' \right)
$$

\n
$$
\frac{C^{(g)}}{2 - K_B} = \frac{K_B}{2 - K_B} e^{-2\Psi} E^2 + 2Q_0 e^{-2\Psi} E \left(e^{-\Phi} q A + \chi R' \right)
$$
\n(B.13)

$$
-(1+\lambda_s)Q_0^2e^{-2\Psi} (e^{-\Phi}qA + \chi R')^2 + \mu^2 (C^{(Q)})^2
$$
\n(B.14)

$$
\frac{C^{(A)}}{2 - K_{\rm B}} = \frac{K_{\rm B}}{2 - K_{\rm B}} e^{-2\Psi} \chi \left[E' + \left(-\Psi' + \frac{2}{r} \right) E \right] - \mathcal{Q}_0 e^{-2\Psi} E \left(e^{-\Phi} q A + \chi R' \right) \n+ \mathcal{Q}_0 e^{-2\Psi} \left[A' + A \left(\Phi' - \Psi' + \frac{2}{r} \right) \right] \left(e^{-\Phi} \chi q + e^{-2\Psi} AR' \right) \n+ \mathcal{Q}_0 e^{-2\Psi} \left[\chi^2 R'' - 2e^{-\Phi} \chi A q \Phi' + \left(\frac{2}{r} - \chi^2 \Psi' - e^{-2\Psi} A^2 \Phi' \right) R' \right] \n+ \mu^2 C^{(Q)} \left(e^{-\Phi} \chi q + e^{-2\Psi} AR' \right)

C Derivation of algebraically special solutions

C.1 Case $q = 1$

With $q = 1$, [\(2.20\)](#page-8-1) implies $\phi_0 = 0$ and so with $A = 0$ [\(2.16\)](#page-7-5) leads to

$$
(1 + \lambda_s) \mathcal{Q}_0 R' = \chi E = \Phi'. \tag{C.1}
$$

The Einstein equation [\(2.18\)](#page-7-3) leads to $\mu^2 R'$, which when combined with [\(C.1\)](#page-21-2) is consistent with the vector equation [\(2.17\)](#page-7-4). Thus either $R' = 0$ or $\mu = 0$.

In the case $R' = 0$, [\(C.1\)](#page-21-2) leads to $\Phi' = 0 = E$, and so we may set $\Phi = 0$. Then the remaining of the Einstein equations give, in the case $\chi = 1$, that $\Psi = 0$, and hence, the resulting spacetime is Minkowski. In the case $\chi = -1$, the Einstein equations give full consistency only iff $\mu = 0 = \Psi$, and thus the resulting spacetime is once more Minkowski.

Let us now move to the non-trivial case for which $R' \neq 0$, and thus by our considerations above, $\mu = 0$. Then using [\(C.1\)](#page-21-2) into [\(B.14\)](#page-21-3) and [\(B.15\)](#page-21-4) and then into the Einstein equations $(2.21), (2.22)$ $(2.21), (2.22)$ $(2.21), (2.22)$ and (2.23) leads, after some computation, to

$$
e^{2\Psi} = 1 + 2r\Phi' + \tilde{n}r^2(\Phi')^2,
$$
\n(C.2)

$$
\Phi'' + \left[\frac{2}{r} + 2\Phi' + \tilde{n}r\left(\Phi'\right)^2\right]\Phi' = 0,\tag{C.3}
$$

where \tilde{n} is given by [\(2.3\)](#page-4-3). To solve the above equations, we change variables to $x \equiv \ln(r/r_0)$ for some arbitrary scale r_0 , and further define the variable

$$
u \equiv \frac{d\Phi}{dx}.\tag{C.4}
$$

Thus, $(C.2)$ is rewritten as

$$
e^{2\Psi} = 1 + 2u + \tilde{n}u^2 = \tilde{n}(u - u_1)(u - u_2),
$$
\n(C.5)

where the second equality is possible because $0 < \tilde{n} \leq 1$, so that the quadratic $1/\tilde{n} + 2u/\tilde{n} + u^2$ has two real roots u_1 and u_2 . These two roots are both negative, that is,

$$
u_1 = -\frac{1}{1+n}, \qquad u_2 = -\frac{1}{1-n}, \qquad (C.6)
$$

with $u_2 < u_1 < 0$, where $n \equiv \sqrt{1 - \tilde{n}}$, such that, $0 < n < 1$.

With this in mind, we write $(C.3)$ as

$$
\frac{dx}{du} = -\frac{1}{\tilde{n}(u - u_1)(u - u_2)u},\tag{C.7}
$$

which may be split using partial fractions, considering also that $u_1 - u_2 = 2n/\tilde{n} > 0$, and then integrated to get

$$
r(u) = \frac{r_0}{|u|} \frac{|u - u_1|^{\frac{1+n}{2n}}}{|u - u_2|^{\frac{1-n}{2n}}},
$$
\n(C.8)

which is [\(4.3\)](#page-15-1). This, in fact means that there are four solution branches: $\{u \lt u_2, u_2 \lt u \lt \}$ $u_1, u_1 < u < 0, u > 0$ } with $r = \infty$ corresponding to $u = 0$ or to $u = u_2$.

Finally, we find $\Phi(u)$ by combining [\(C.4\)](#page-21-7) and [\(C.7\)](#page-22-1) to get

$$
\Phi = -\int \frac{du}{\tilde{n}(u - u_1)(u - u_2)} = \frac{1}{2n} \ln \frac{|u - u_2|}{|u - u_1|}.
$$
 (C.9)

Thus with $(C.5)$, $(C.8)$ and $(C.9)$, we reconstruct the metric (4.2) and so (4.1) also follows.

C.2 Case $q = 0$

In this case ϕ_0 may take in principle any real value, and does not have to be zero. Then, with $A = q = 0$, which imply $C^{(Q)} = -1$, [\(2.16\)](#page-7-5) gives

$$
\Phi' - (1 + \lambda_s) \mathcal{Q}_0 R' = \frac{\tilde{\phi}_0 e^{-\Phi + \Psi}}{r^2},\tag{C.10}
$$

where $\phi_0 = \tilde{\phi}_0 Q_0$, while both [\(2.17\)](#page-7-4) and [\(2.18\)](#page-7-3) lead to $\mu^2 R' = 0$. Meanwhile the [\(2.21\)](#page-8-2) Einstein equations results in

$$
\frac{2}{r}\Psi' + \frac{e^{2\Psi} - 1}{r^2} = K_B \left[\Phi'' + \left(\frac{1}{2} \Phi' - \Psi' + \frac{2}{r} \right) \Phi' \right] - \frac{1}{2} (2 - K_B) \mu^2 e^{2\Psi} \n+ (2 - K_B) \mathcal{Q}_0 \left[R'' + \left(\frac{2}{r} - \Psi' + \frac{1}{2} (1 + \lambda_s) \mathcal{Q}_0 R' \right) R' \right],
$$
\n(C.11)

[\(2.22\)](#page-8-3) reduces to

$$
\frac{2}{r}\Phi' - \frac{e^{2\Psi} - 1}{r^2} = -\frac{1}{2}K_{\rm B}\Phi'^2 + (2 - K_{\rm B})\left[-\mathcal{Q}_0\Phi'R' + \frac{1}{2}(1 + \lambda_s)\mathcal{Q}_0^2R'^2 + \frac{1}{2}\mu^2e^{2\Psi} \right], \quad (C.12)
$$

and (2.23) to

$$
\Phi'' + (\Phi' - \Psi')\left(\Phi' + \frac{1}{r}\right) = (2 - K_B)\mathcal{Q}_0 R'\left[\Phi' - \frac{1}{2}(1 + \lambda_s)\mathcal{Q}_0 R'\right] + \frac{K_B}{2}\Phi'^2 + \frac{1}{2}(2 - K_B)\mu^2 e^{2\Psi}.
$$
\n(C.13)

We now consider the two possible subcases: $R' = 0$ and $\mu = 0$ separately.

C.2.1 Case $R' = 0$

Taking the derivative of [\(C.10\)](#page-22-4) gives

$$
\Phi'' + (\Phi' - \Psi')\Phi' + \frac{2}{r}\Phi' = 0,
$$
\n(C.14)

and adding $(C.12)$ and $(C.11)$ leads to

$$
\frac{2}{r}(\Phi' + \Psi') = K_{\text{B}} \left[\Phi'' + \left(-\Psi' + \frac{2}{r} \right) \Phi' \right]. \tag{C.15}
$$

Then, using [\(C.14\)](#page-23-2) to eliminate Φ'' allows us to express Ψ' in terms of Φ' as

$$
\Psi' = -\frac{1}{2} K_{\rm B} r {\Phi'}^2 - {\Phi'}, \tag{C.16}
$$

while [\(C.14\)](#page-23-2) subbed into [\(C.13\)](#page-22-7) gives after using (C.14), the additional condition $\mu^2 = 0$.

Substituting into $(C.11)$ leads to

$$
e^{2\Psi} = 1 + 2r\Phi' + \frac{K_{\rm B}}{2}r^2(\Phi')^2, \tag{C.17}
$$

and differentiating the above equation we eliminate Ψ' with $(C.16)$ to get

$$
\Phi'' + \frac{2}{r}\Phi' + 2(\Phi')^2 + \frac{K_B}{2}r(\Phi')^3 = 0.
$$
 (C.18)

The above equation admits a $\Phi' = \Psi' = 0$ Minkowski solution (obtainable also directly by $\tilde{\phi}_0 = 0$).

The system [\(C.17\)](#page-23-4) and [\(C.18\)](#page-23-5) is analogous to [\(C.2\)](#page-21-5) and [\(C.3\)](#page-21-6) with $\tilde{n} \to K_{\rm B}/2$ whose solution we have already found. Thus, this system reduces to the $A = 0, q = 1$ case studied in Subsection [C.1,](#page-21-1) that is, $(C.5)$ and $(C.9)$, with $r = r(u)$ given by $(C.8)$. However, there are some additional constraints that make it different from the full solution of Subsection [C.1,](#page-21-1) the first being that since $R' = 0$ then $\phi = 0$ throughout. The second constraint that needs to be satisfied is in fact $(C.10)$, that is,

$$
\Phi' = \frac{\tilde{\phi}_0 e^{-\Phi + \Psi}}{r^2},\tag{C.19}
$$

and this leads to identifying $Q_0r_0 = |\phi_0|\sqrt{\frac{K_B}{2}}$ and $\text{Sign}(u) = \text{Sign}(\phi_0)$.

C.2.2 Case $\mu = 0$

In this case adding $(C.12)$ and $(C.13)$ we get

$$
\Phi'' + (\Phi' - \Psi')\left(\Phi' + \frac{1}{r}\right) + \frac{2}{r}\Phi' + \frac{1 - e^{2\Psi}}{r^2} = 0,
$$
\n(C.20)

while $(C.10)$ is used to solve for R' as

$$
(1 + \lambda_s) \mathcal{Q}_0 R' = \Phi' - \frac{\tilde{\phi}_0 e^{-\Phi + \Psi}}{r^2}.
$$
 (C.21)

We use the above equation to eliminate R' so that $(C.11)$ leads to

$$
\frac{2}{r}\Psi' + \frac{e^{2\Psi} - 1}{r^2} = 2\tilde{n} \left[\Phi'' + \left(\frac{2}{r} - \Psi' + \frac{1}{2}\Phi' \right) \Phi' \right] + \frac{2 - K_B}{2(1 + \lambda_s)} \frac{\tilde{\phi}_0^2 e^{-2\Phi + 2\Psi}}{r^4},\tag{C.22}
$$

and $(C.12)$ to

$$
\frac{2}{r}\Phi' - \frac{e^{2\Psi} - 1}{r^2} = -\tilde{n}\Phi'^2 + \frac{2 - K_B}{2(1 + \lambda_s)}\frac{\tilde{\phi}_0^2 e^{-2\Phi + 2\Psi}}{r^4},\tag{C.23}
$$

so that subtracting one from the other to cancel out the term proportional to $\tilde{\phi}_0^2$ we find

$$
\frac{1}{r}(\Psi' - \Phi') + \frac{e^{2\Psi} - 1}{r^2} = \tilde{n} \left[\Phi'' + \left(\Phi' - \Psi' + \frac{2}{r} \right) \Phi' \right].
$$
\n(C.24)

Thus using $(C.20)$ to eliminate the Φ'' term we find

$$
\Phi' = \Psi' + \frac{e^{2\Psi} - 1}{r},\tag{C.25}
$$

which allows us to eliminate Φ' from $(C.20)$ to get

$$
\Psi'' + \frac{1}{r} \left(3e^{2\Psi} + 1 \right) \Psi' + \frac{1}{r^2} e^{2\Psi} \left(e^{2\Psi} - 1 \right) = 0. \tag{C.26}
$$

D The $q = 0$ Schwarzschild case

Taking the $q = 0$ solutions and setting $q_{BH} = 0$ leads to the Schwarzschild for the metric, while χ and E in [\(3.31\)](#page-14-1) reduce to

$$
\chi = e^{-\Phi} \sqrt{1 + \frac{2q_A}{r}}, \qquad E = -\frac{e^{-\Phi}}{r^2} \frac{q_A}{\sqrt{1 + \frac{2q_A}{r}}}. \qquad (D.1)
$$

Likewise, [\(3.32\)](#page-14-2) and [\(3.33\)](#page-14-3) reduce respectively to

$$
A = s_A e^{-2\Phi} \sqrt{\frac{2(G_N M + q_A)}{r}}, \qquad (1 + \lambda_s)\phi = \ln \sqrt{1 + \frac{2q_A}{r}} + \frac{s_{\phi_0}}{2\tilde{m}} \ln \frac{1 + \frac{q_A + \tilde{m}|\tilde{\phi}_0|}{r}}{1 + \frac{q_A - \tilde{m}|\tilde{\phi}_0|}{r}}, \quad (D.2)
$$

while further setting $\tilde{\phi}_0 = 0$, leads to $\phi = 0$, i.e. the scalar hair vanishes and we are left with only the vector hair.
