On the $K^+ \to \pi^0 \pi^0 \pi^0 e^+ \nu$ decay.

In the recent paper [\[1\]](#page-3-0) the experimental bound $Br(K^+\to\pi^0\pi^0\pi^0e^+\nu) < 5.4\times10^{-8}$ at the 90% confidence level was obtained, that is 65 times lower than the value currently listed by [\[2\]](#page-3-1). However the estimate $Br(K^+ \to \pi^0 \pi^0 \pi^0 e^+ \nu)$ 2.5×10^{-12} [\[3\]](#page-3-2) obtained within the chiral perturbation theory is too small for the experimental observation of this decay. As it is emphasized in [\[3\]](#page-3-2) the small value of the decay probability under consideration with respect to the probability of the experimentally observed decay $K^+ \to \pi^0 \pi^0 e^+ \nu$ is due to the five-particle phase volume suppression.

Let us compare four- and five-particle phase volumes starting with the calculation of the four-particle phase volume characterizing $K^+ \to \pi^0 \pi^0 e^+ \nu$ decay. To perform the calculation the recurrent formula allowing to reduce the *n*-particle phase volume to the product of i- and j-particle ones $(n = i + j)$ [\[4\]](#page-3-3) is used (see Fig[.1\)](#page-0-0):

$$
dV_n(s; m_1^2, m_2^2, \dots, m_n^2) = \int \frac{dQ_1^2}{2\pi} \frac{dQ_2^2}{2\pi} dV_2(s; Q_1^2, Q_2^2) \times dV_i(Q_1^2; m_1^2, \dots, m_i^2) \times dV_j(Q_2^2; m_{i+1}^2, \dots, m_{i+j}^2).

Denoting the sum of e^+ and ν momenta as Q_1 , and the sum of two π^0 mesons momenta as Q_2 , neglecting the

positron and neutrino masses and using the expression for the two-particle phase volume (see Fig[.2\)](#page-1-0), we obtain:

$$
V_4(s = m_K^2; 0, 0, m_{\pi^0}^2, m_{\pi^0}^2) = \int \frac{dQ_1^2}{2\pi} \frac{dQ_2^2}{2\pi} \frac{\sqrt{\left[s - \left(\sqrt{Q_1^2} - \sqrt{Q_2^2}\right)^2\right] \left[s - \left(\sqrt{Q_1^2} + \sqrt{Q_2^2}\right)^2\right]}}{8\pi s} \times \frac{1}{8\pi} \times \frac{\sqrt{Q_2^2(Q_2^2 - 4m_{\pi}^2)}}{8\pi Q_2^2}.
$$

The integration should be performed in the following domain: $(m_K - 2m_{\pi^0})^2 > Q_1^2 > 0$, $\left(m_K - \sqrt{Q_1^2}\right)^2 > Q_2^2 > 0$ $4m_{\pi^0}^2$. Substituting dimensionless variables $x = Q_1^2/m_K^2$, $y = Q_2^2/m_K^2$ we get:

$$
V_4 = \frac{m_K^4}{2^{11}\pi^5} \int\limits_0^{(1-2m_{\pi^0}/m_K)^2} dx \int\limits_{(2m_{\pi^0}/m_K)^2}^{(1-\sqrt{x})^2} dy \sqrt{\left[1-\left(\sqrt{x}-\sqrt{y}\right)^2\right] \left[1-\left(\sqrt{x}+\sqrt{y}\right)^2\right]} \sqrt{1-\frac{\left(4m_{\pi^0}/m_K\right)^2}{y}} = 7.1 \times 10^{-3} \frac{m_K^4}{2^{11}\pi^5} \tag{3}
$$

For the calculation of the five-particle phase volume, describing the $K^+ \to \pi^0 \pi^0 \pi^0 e^+ \nu$ decay, we need the expression for the phase volume of three π^0 mesons. Taking into consideration the kinematics the non-relativistic approximation $\sqrt{s} = 3m_{\pi^0} + \Delta$, $\Delta \ll m_{\pi^0}$ can be used. Using the recurrent formula [\[4\]](#page-3-3) (see Fig[.3\)](#page-1-2)

$$
dV_n(s; m_1^2, m_2^2, \dots, m_n^2) = \int \frac{dQ^2}{2\pi} dV_{n-1}(Q^2; m_1^2, \dots, m_{n-1}^2) \times dV_2(s; Q^2, m_n^2)
$$

for the three-particle phase volume we obtain:

$$
V_3 = \int_{(m_1 + m_2)^2}^{(\sqrt{s} - m_3)^2} \frac{dQ^2}{2\pi} \frac{\sqrt{\left[Q^2 - (m_1 - m_2)^2\right] \left[Q^2 - (m_1 + m_2)^2\right]}}{8\pi Q^2} \frac{\sqrt{\left[s - \left(\sqrt{Q^2} - m_3\right)^2\right] \left[s - \left(\sqrt{Q^2} + m_3\right)^2\right]}}}{8\pi s}.
$$

Assuming $m_1 = m_2 = m_3 = m_{\pi^0}$ we get:

$$
V_3 = \frac{(\sqrt{s} - 3m_{\pi^0})^2}{2^6 3\sqrt{3}\pi^2}.
$$

For the five-particle phase volume using [\(1\)](#page-0-1) we obtain (see Fig[.4\)](#page-2-1):

$$
dV_5(m_K^2; 0, 0, m_{\pi^0}^2, m_{\pi^0}^2, m_{\pi^0}^2) = \int \frac{dQ_1^2}{2\pi} \frac{dQ_2^2}{2\pi} \frac{\sqrt{\left[s - \left(\sqrt{Q_1^2} - \sqrt{Q_2^2}\right)^2\right] \left[s - \left(\sqrt{Q_1^2} + \sqrt{Q_2^2}\right)^2\right]}}{8\pi s} \times \frac{1}{8\pi} \times \frac{\left(\sqrt{Q_2^2} - 3m_{\pi^0}\right)^2}{2^6 3\sqrt{3}\pi^2}.
$$
\n(7)

In this case the integration should be performed in the domain $(m_K - 3m_{\pi^0})^2 > Q_1^2 > 0$, $(m_K - \sqrt{Q_1^2})^2 > Q_2^2 > 9m_{\pi^0}^2$. In terms of dimensionless variables we obtain:

$$
V_5 = \frac{m_K^6}{2^{14} 3\sqrt{3}\pi^6} \int_0^{(1-3m_{\pi^0}/m_K)^2} dx \int_{(3m_{\pi^0}/m_K)^2}^{(1-\sqrt{x})^2} dy \left(\sqrt{y} - \frac{3m_{\pi^0}}{m_K}\right)^2 \sqrt{\left[1 - \left(\sqrt{x} - \sqrt{y}\right)^2\right] \left[1 - \left(\sqrt{x} + \sqrt{y}\right)^2\right]} = (8)
$$

$$
= 1.37 \times 10^{-6} \frac{m_K^6}{2^{14} 3\sqrt{3}\pi^6}.
$$

Finally for the ratio of the phase volumes taking into account that π^0 mesons are identical we get:

$$
\frac{m_K^2 V_4/2!}{V_5/3!} = 2.1 \times 10^6. \tag{9}
$$

Within the chiral perturbation theory for the widths ratio it was obtained in [\[3\]](#page-3-2):

$$
\frac{\Gamma(K^+ \to \pi^0 \pi^0 e^+ \nu)}{\Gamma(K^+ \to \pi^0 \pi^0 \pi^0 e^+ \nu)} \approx 3.4 \times 10^6.
$$
\n(10)

Thereby the relative suppression of the K_{e5} decay widths originates from the smallness of the five-particle phase volume.

Thus in the paper [\[1\]](#page-3-0) it was suggested, that pionium $A_{2\pi}^{-1}$ $A_{2\pi}^{-1}$ $A_{2\pi}^{-1}$ production in the $K^+ \to \pi^0 A_{2\pi} e^+ \nu$ decay with the subsequent decay $A_{2\pi} \to \pi^0 \pi^0$ will lead to the considerable increase of the $K^+ \to \pi^0 \pi^0 \pi^0 e^+ \nu$ decay probability, since the five-particle phase volume is replaced by four-particle one in this case.

Let us calculate the phase volume of the $\pi^0 A_{2\pi} e^+ \nu$ state, formed in the K^+ meson decay. The formula [\(2\)](#page-1-1) is replaced by the following one (see Fig[.5\)](#page-3-4):

$$
V_{A} = \int \frac{dQ_{1}^{2}}{2\pi} \frac{dQ_{2}^{2}}{2\pi} \frac{\sqrt{\left[s - \left(\sqrt{Q_{1}^{2}} - \sqrt{Q_{2}^{2}}\right)^{2}\right] \left[s - \left(\sqrt{Q_{1}^{2}} + \sqrt{Q_{2}^{2}}\right)^{2}\right]}}{8\pi s} \times \frac{\sqrt{\left[Q_{2}^{2} - \left(\sqrt{4m_{\pi^{+}}^{2}} - \sqrt{m_{\pi^{0}}^{2}}\right)^{2}\right] \left[Q_{2}^{2} - \left(\sqrt{4m_{\pi^{+}}^{2}} + \sqrt{m_{\pi^{0}}^{2}}\right)^{2}\right]}}{8\pi Q_{2}^{2}},
$$

where we took into account that the pionium mass is close to the sum of the two charged pions masses. In the dimensionless variables we obtain:

$$
V_{A} = \frac{m_{K}^{4}}{2^{11}\pi^{5}} \int_{0}^{(1-(2m_{\pi}++m_{\pi^{0}})/m_{K})^{2}} dx \int_{((2m_{\pi}++m_{\pi^{0}})/m_{K})^{2}}^{(1-\sqrt{x})^{2}} dy \sqrt{\left[1-(\sqrt{x}-\sqrt{y})^{2}\right] \left[1-(\sqrt{x}+\sqrt{y})^{2}\right]} \times \sqrt{\left[1-\frac{(2m_{\pi}+m_{\pi^{0}})^{2}}{ym_{K}^{2}}\right] \left[1-\frac{(2m_{\pi}++m_{\pi^{0}})^{2}}{ym_{K}^{2}}\right]} = 0.83 \times 10^{-4} \frac{m_{K}^{4}}{2^{11}\pi^{5}}.
$$
\n(12)

It leads to the increase of the decay probability by a factor

$$
\frac{m_K^2 V_A}{V_5/3!} \approx 5 \times 10^4,\tag{13}
$$

which is in agreement with the hypothesis of the work [\[1\]](#page-3-0). Multiplying the theoretical result by this factor we get the probability of the decay exceeding about two times the upper limit obtained in the experiment [\[1\]](#page-3-0)(!). However the amplitude of the pionium production is proportional to its wave function at zero π mesons separation $\psi(0) =$ $1/\sqrt{\pi a_B^3} \sim \alpha^{3/2}/(2\sqrt{2\pi})$. It leads to the multiplication of this decay probability by a factor $\alpha^3/(8\pi) \approx 1.5 \times 10^{-8}$, making it suppressed with respect to the $K^+ \to \pi^0 \pi^0 \pi^0 e^+ \nu$ decay probability.
