THE CONTINUITY OF *p*-RATIONALITY OF CHARACTERS AND THE PRINCIPAL BLOCK

Abstract. We study rationality properties of irreducible characters of finite groups. We show that the continuity of 2-rationality is a phenomenon that can be detected in the principal 2-block, thus refining a recent result of N. N. Hung. We also propose a conjectural group theoretical criterion for the continuity gap at level 1 for all primes.

1. INTRODUCTION

For K an abelian number field, its *conductor* $c(K)$ is defined as the smallest positive integer n such that $K \subseteq \mathbb{Q}_n$, where \mathbb{Q}_n denotes the extension of $\mathbb Q$ generated by a primitive nth root of unity. Given a finite group G and a complex irreducible character $\chi \in \text{Irr}(G)$, the *conductor of* χ , denoted $c(\chi)$, is defined as $c(\mathbb{Q}(\chi))$, the conductor of the field generated by the values of χ . For a prime p, the p-rationality level of $\chi \in \text{Irr}(G)$ is the non-negative integer α such that $c(\chi)_p = p^{\alpha}$. (Here, we write n_p for the exact power of p dividing an integer n.) Characters with specific p-rationality level have been extensively studied in the literature. For example, the p -rational characters are the characters with p -rationality level 0 and the *almost* p*-rational characters* are the ones with p-rationality level ≤ 1. Both of these families have been shown to influence the (local) structure of G (see, for instance $[12, 18, 10, 14]$ $[12, 18, 10, 14]$ $[12, 18, 10, 14]$ $[12, 18, 10, 14]$.

In [\[9\]](#page-11-4), Hung conjectured that if a finite group G has some irreducible character χ of degree coprime to p with p-rationality level $\alpha \geq 2$, then Irr(G) contains characters of degree coprime to p with p-rationality level β for any $2 \leq \beta \leq \alpha$. We will refer to this phenomenon as the *continuity of* p*-rationality*. In the same paper, he has proven the above conjecture for $p = 2$. In the final section of [\[9\]](#page-11-4), Hung suggests the existence of a principal block version of [\[9,](#page-11-4) Conj. 1.1]:

Conjecture 1.1 (Hung). *Let* G *be a finite group and* p *be a prime. If the principal* p*-block* $B_0(G)$ *of* G *contains an irreducible character of degree coprime to* p with $c(\chi)_p = p^{\alpha}$ then *it contains irreducible characters of degree coprime to* p and $c(\psi)_p = p^{\beta}$ for all $2 \le \beta \le \alpha$.

In our first main result, we confirm Hung's prediction for the prime $p = 2$.

Theorem A. *Conjecture* [1.1](#page-1-0) *holds for* $p = 2$ *.*

Hung's Conjecture is implied by the celebrated Alperin–McKay–Navarro conjecture [\[16,](#page-11-5) Conj. B]. In particular, our Theorem A provides further evidence for the validity of the Alperin–McKay–Navarro conjecture (at least for principal blocks and the prime $p = 2$), one of the few global-local conjectures that remain unreduced at the time of this writing.

Assuming [\[20,](#page-11-6) Conj. A], if $\alpha > 2$ is the largest p-rationality level of characters of degree coprime to p of a finite group G then it is attained at an element of $\text{Irr}(B_0(G))$. Given that [\[20,](#page-11-6) Conj. A] has been proven for $p = 2$ in [\[13\]](#page-11-7), Theorem A above refines the main result of [\[9\]](#page-11-4). Furthermore, using the fact that [\[20,](#page-11-6) Conj. A] has been reduced to a problem on simple groups, we are also able to reduce Conjecture [1.1](#page-1-0) to a problem on simple groups (see Theorem [3.3\)](#page-4-0) for all primes p .

Interestingly, the continuity of p-rationality stops at level 2. This is because there are groups that have an irreducible character of degree coprime to p and p-rationality level 2 but none of p -rationality level 1. That is to say, in these cases all the irreducible characters of degree coprime to p that are almost p-rational are in fact p-rational. An example was already given in [\[9,](#page-11-4) Rem. 1.6]. We offer here an explanation of this gap by conjecturally characterizing the finite groups all of whose almost p-rational characters of degree coprime to p are p-rational.

Conjecture B. Let G be a finite group, p be a prime and $P \in \mathrm{Syl}_p(G)$. Write $K =$ $\mathbf{N}_G(P)/\Phi(P)$ *and* $Q = P/\Phi(P)$ *. Then the following are equivalent:*

- (i) *No irreducible character of* G *of degree coprime to* p *has* p*-rationality level* 1*.*
- (ii) *For every* $1 \neq y \in Q$ *we have:*
	- (a) $\mathbf{N}_K(\langle y \rangle)/\mathbf{C}_K(\langle y \rangle) \cong \text{Aut}(\langle y \rangle)$ *, and*
		- (b) $N_K(\langle y \rangle)/Q$ *acts trivially on the set of conjugacy classes of* $C_K(y)/Q$ *.*

Notice that for $p = 2$ all three conditions above are trivially satisfied as, by definition, the conductor of a character cannot have 2-part equal to 2. In Theorem [5.5,](#page-8-0) we prove that Conjecture B holds for groups with a normal Sylow p-subgroup. As we will explain in Sections [2](#page-2-0) and [5,](#page-7-0) Theorem [5.5](#page-8-0) implies that Conjecture B would be a consequence of the McKay–Navarro conjecture [\[16,](#page-11-5) Conj. A]. In particular, we derive that Conjecture B holds for *p*-solvable, sporadic, symmetric and alternating groups, and simple groups of Lie type in defining characteristic by [\[25,](#page-11-8) [16,](#page-11-5) [2,](#page-10-0) [23\]](#page-11-9).

It is worth mentioning that Hung speculates that the gap on the continuity of p rationality might depend on the action of $N_G(P)$ on P/P' but does not know *the precise connection* [\[9,](#page-11-4) Rem. 1.6]. However, both local conditions in Conjecture B above are necessary to explain the gap, since the groups C_3 and SmallGroup(216,128) ≅ $(C_3 \times C_3 \times C_3) \rtimes D_8$ possess irreducible characters of degree coprime to 3 and 3-rationality level 1.

Conjecture B can be seen as a new way of relating the local structure of a group with its character values. Unlike the phenomena observed in [\[20,](#page-11-6) Conj. A] and [\[9,](#page-11-4) Conj. 1.1], we note that the absence of irreducible characters of degree coprime to p of p -rationality level 1 in a group G is not a property that can be detected in the principal block (see the end of Section [5\)](#page-7-0). We also offer a version for principal blocks of Conjecture B in Conjecture [5.7.](#page-10-1)

Our paper is organized as follows: In Section [2,](#page-2-0) we collect some preliminary results on the p-part of character conductors. In Section [3,](#page-3-0) we reduce Conjecture [1.1](#page-1-0) to a problem on finite simple groups. This problem is settled for the prime 2 in Section [4,](#page-5-0) thus completing the proof of Theorem A. Section [5](#page-7-0) contains the proof of Conjecture B (and its principal block version) for groups with a normal Sylow p-subgroup.

2. On the p-part of character conductors

For $\alpha \in \mathbb{N}$ we denote by $\sigma_{\alpha} \in \text{Gal}(\mathbb{Q}^{ab}/\mathbb{Q})$ the Galois automorphism that fixes p-power order roots of unity and sends p'-roots of unity to their $1+p^{\alpha}$ th power. By a slight abuse of notation, we still denote by σ_{α} its restriction to the cyclotomic field \mathbb{Q}_n for any positive integer n. It is not difficult to see that $\langle \sigma_{\alpha} \rangle \leq \text{Gal}(\mathbb{Q}_n/\mathbb{Q})$ is a finite p-group for any α and any n. Moreover, if χ is not p-rational, then the p-rationality level of χ is precisely the smallest $\alpha \geq 1$ such that χ is σ_{α} -invariant (see [\[21,](#page-11-10) Lemma 4.1], for instance). While for $p = 2$ the odd-degree 2-rational characters of G are exactly those fixed by σ_1 by [\[26,](#page-11-11) Thm 2.5], for odd primes we cannot characterise the p-rational characters in terms of the σ_{α} simply because Gal($\mathbb{Q}_{mn^a}/\mathbb{Q}_m$) is not a p-group.

The celebrated McKay–Navarro conjecture [\[16,](#page-11-5) Conj. A] implies that there should exist McKay bijections that preserve the p-part of character conductors. The following is a consequence (of the maximal defect case) of [\[16,](#page-11-5) Conj. B]. We state it in the weakest form that suffices for our purposes. Here, we denote by $\text{Irr}_{p'}(G)$ the set of irreducible characters of G whose degree is not divisible by p and by $\text{Irr}(B_0(G))$ the set of irreducible characters that belong to the principal p -block of G .

Conjecture 2.1 (Navarro). Let G be a finite group, p be a prime and $P \in \mathrm{Syl}_p(G)$. There *is a bijection*

$$
^*:\operatorname{Irr}_{p'}(G)\to\operatorname{Irr}_{p'}(\mathbf{N}_G(P))
$$

such that for all $\chi \in \text{Irr}_{p'}(G)$ we have

(1)
$$
c(\chi)_p = c(\chi^*)_p, \text{ and}
$$

 (2) $\chi \in \text{Irr}(B_0(G))$ *if and only if* $\chi^* \in \text{Irr}(B_0(\mathbf{N}_G(P))).$

It is not difficult to see that Conjecture [1.1](#page-1-0) is a consequence of Conjecture [2.1](#page-2-1) (and hence of [\[16,](#page-11-5) Conj. B]). We do so in Lemma [2.7](#page-3-1) below. We will prove in Section [5](#page-7-0) that Conjecture B (as well as its principal block version) also follows from Conjecture [2.1;](#page-2-1) however, this will require significantly more effort.

We next collect some useful results on the p -part of character conductors. Throughout, G denotes a finite group.

Lemma 2.2. Let $P \in \text{Syl}_p(G)$, $H \leq G$ with $p \nmid |G:H|$ and $\mathbf{C}_G(P) \subseteq H$, and let $\alpha \geq 1$. If $\psi \in \text{Irr}_0(B_0(H))$ is fixed by σ_α then there is a σ_α -invariant constituent of ψ^G *in* $\text{Irr}_{p'}(B_0(G))$ *. In other words, if* $c(\psi)_p \geq p$ *then there is a constituent* χ *of* ψ^G *with* $c(\chi)_p \leq c(\psi)_p.$

Proof. Mimic the proof of [\[14,](#page-11-3) Lemma 3.7] for σ_{α} instead of σ , using that σ_{α} also has p -power order.

Lemma 2.3. Let $N \trianglelefteq G$ and $P \in \mathrm{Syl}_p(G)$. Let $\theta \in \mathrm{Irr}_{p'}(B_0(N))$ be P-invariant and with $c(\theta)_p \geq p^2$, and let $\chi \in \text{Irr}_{p'}(B_0(G))$ lie over θ . Then $c(\chi)_p \geq p^2$.

Proof. Assume that $c(\chi)_p \leq p$ so that χ is fixed by σ_1 . Then χ_N is fixed by σ_1 . This implies that σ_1 permutes the set of G-conjugates of θ , which has size not divisible by p. In particular, σ_1 fixes some G-conjugate of θ so it fixes θ , and $c(\theta)_p \leq p$, a contradiction. \Box

Theorem 2.4 (Alperin–Dade). Let $N \triangleleft G$ with $|G : N|$ not divisible by p. Assume *that* $G = NC_G(P)$ *for* $P \in Syl_p(G)$ *. Then restriction defines a bijection* $\text{Irr}(B_0(G)) \rightarrow$ $\text{Irr}(B_0(N))$ *. In particular,* $c(\chi)_p = c(\chi_N)_p$ *for every* $\chi \in \text{Irr}(B_0(G))$ *.*

Proof. The first part was proved by Alperin [\[1\]](#page-10-2) when G/N is solvable, and by Dade [\[4\]](#page-11-12) without the solvability assumption. Since restriction commutes with Galois action, it follows that χ is fixed by σ_{α} if and only if χ_N is fixed by σ_{α} for any α .

Lemma 2.5. Let $N \leq G$ with $|G : N|$ not divisible by p. Let $\theta \in \text{Irr}(N)$, $\chi \in \text{Irr}(G|\theta)$ *and assume* $c(\chi)_p \geq p$. Then $c(\theta)_p \leq c(\chi)_p$. If, moreover, $c(\chi)_p$ or $c(\theta)_p$ are $\geq p^2$, then $c(\chi)_p = c(\theta)_p.$

Proof. See [\[9,](#page-11-4) Lemma 2.4(i) and (iii)].

Lemma 2.6. *Let* $\varphi, \psi \in \text{Irr}(G)$ *. Assume* $\chi := \varphi \psi \in \text{Irr}(G)$ *and* $c(\varphi)_p \leq c(\chi)_p$ *. Assume further that* $G/\ker \psi$ *is a p-group. Then*

(a) $c(\psi)_p \leq c(\chi)_p$ *, and*

(b) either
$$
c(\varphi)_p = c(\chi)_p
$$
 or $c(\psi)_p = c(\chi)_p$.

Proof. See [\[9,](#page-11-4) Lemma 3.3]. □

If G is a p-group and $\lambda \in \mathrm{Irr}_{p'}(G)$, then $G/\ker \lambda$ is cyclic and $c(\lambda)_p = |G/\ker \lambda|$. In particular, Conjecture [1.1](#page-1-0) trivially holds for p -groups as these have a unique p -block, namely the principal one. We prove below that Conjecture [1.1](#page-1-0) follows from Conjecture [2.1.](#page-2-1)

Lemma 2.7. *Suppose that* G *satisfies the conclusion of Conjecture [2.1](#page-2-1) for* p*. Then if the principal* p-block $B_0(G)$ of G contains irreducible characters of degree coprime to p with $c(\chi)_p = p^{\alpha}$ then it contains irreducible characters of degree coprime to p and $c(\psi)_p = p^{\beta}$ *for all* $2 < \beta < \alpha$ *.*

Proof. Let $P \in \mathrm{Syl}_p(G)$. By hypothesis, we can assume that $P \trianglelefteq G$. Let $\chi \in \mathrm{Irr}_{p'}(B_0(G))$ with $c(\chi)_p = p^{\alpha}$, and let $\lambda \in \text{Irr}(P)$ be under χ . Since $\alpha \geq 2$, by Lemma [2.5,](#page-3-2) we have that $c(\lambda) = c(\chi)_p$. Now, P has a linear character λ_β of conductor p^β for every $2 \le \beta \le \alpha$, as noticed just before the statement of this lemma. We can take $\chi_{\beta} \in \text{Irr}(B_0(G))$ over λ_{β} by [\[15,](#page-11-13) Thm 9.4]. Then χ_{β} has degree coprime to p and $c(\chi_{\beta}) = p^{\beta}$ using again Lemma [2.5.](#page-3-2) \Box

3. A reduction theorem for Hung's conjecture

The purpose of this section is to show that if certain conditions hold for almost/quasisimple groups and a prime p , then Conjecture [1.1](#page-1-0) holds for all finite groups with respect to the prime p . More specifically, our reduction theorem depends on the following conjecture concerning the representation theory of the finite non-abelian simple groups.

Conjecture 3.1. *Let* p *be a prime and let* S *be a finite non-abelian simple group of order divisible by* p*. Then the following hold:*

- (a) Let X be a quasi-simple group with $X/Z(X) \cong S$ and $Z(X)$ of order coprime to p. Let Y be almost quasi-simple with component $F^*(Y) = X$ and Y/X a p-group. If $Q \in \mathrm{Syl}_p(Y)$ and $\exp(Q/Q') = p^e$, then every character in $\mathrm{Irr}_{p'}(Y)$ is σ_e -invariant *(or equivalently, it has* p*-rationality level at most* e*).*
- (b) Let A be an almost simple group with socle $F^*(A) = S$ such that A/S is a p-group. *Assume* $\text{Irr}_{p'}(B_0(S))$ *contains A*-*invariant characters with p*-rationality level α . *Then* $\text{Irr}_{p'}(B_0(S))$ *contains* A-*invariant characters with p-rationality level* β *for every* $2 \leq \beta \leq \alpha$.

We recall that a group S is said to be involved in a group G if there exist $N, K \leq G$ with $N \leq K$ and $K/N \cong S$.

Remark 3.2. Let G be a finite group, $P \in \mathrm{Syl}_p(G)$ and assume $\exp(P/P') \geq p^2$. By work of Navarro and Tiep in [\[20,](#page-11-6) Thms B and 5.7], if Conjecture [3.1\(](#page-4-1)a) holds for every finite simple group involved in G, then $exp(P/P')$ is the largest p-rationality level in $\text{Irr}_{p'}(G)$, and such largest p-rationality level is attained at $\mathrm{Irr}(B_0(G))$. Note that Conjecture [3.1\(](#page-4-1)a) easily implies [\[20,](#page-11-6) Conj. 5.4]. In particular, this has been shown to hold for $p = 2$ by the main result of [\[13\]](#page-11-7).

Theorem 3.3. *Let* G *be a finite group,* p *a prime. Assume that Conjecture [3.1](#page-4-1) holds* $for\ every\ non-abelian\ simple\ group\ involved\ in\ G.\ If\ \mathrm{Irr}_{p'}(B_0(G))\ contains\ a\ character\ of$ p-rationality level $\alpha \geq 2$, then $\text{Irr}_{p'}(B_0(G))$ contains characters of p-rationality level β for *every* $2 < \beta < \alpha$ *.*

Proof. We argue by induction on |G|. We may assume α is the largest p-rationality level among the p' -degree characters in the principal block. The rest of the proof is divided into steps.

Step 1: We may assume that any minimal normal subgroup of G *is semisimple of order divisible by* p*.*

We may assume that $\mathbf{O}_{p'}(G) = 1$ by induction since $\text{Irr}(B_0(G/\mathbf{O}_{p'}(G))) \subseteq \text{Irr}(B_0(G))$. Let $P \in \mathrm{Syl}_p(G)$ and let N be a minimal normal subgroup of G. Assume that N is a p-group, so $N \leq P$. By Remark [3.2](#page-4-2) and since we are assuming Conjecture [3.1](#page-4-1) we have $\exp(P/P') = p^{\alpha}$. Since $\exp(N) = p$ we have

$$
\exp(P/P') = \exp((P/N)/(P/N)') \quad \text{or} \quad \exp(P/P') = p \cdot \exp((P/N)/(P/N)').
$$

In either case, we are done because $\text{Irr}_{p'}(B_0(G/N))$ contains characters of every p-rationality level $2 \le \beta \le \alpha - 1$ by induction. The claim follows.

Step 2: Let N *be a minimal normal subgroup of* G*. We may assume* G/N *is a* p*-group. In particular,* $B_0(G)$ *is the unique block covering* $B_0(N)$ *.*

Since we are assuming Conjecture $3.1(a)$, the largest p-parts of the character conductors in $\text{Irr}_{p'}(B_0(G))$ and $\text{Irr}_{p'}(B_0(PN))$ coincide (see Remark [3.2\)](#page-4-2). Therefore it suffices to prove that if $\text{Irr}_{p'}(B_0(PN))$ contains a character of p-rationality level $\beta \geq 2$ then so does $\operatorname{Irr}_{p'}(B_0(G)).$

For this, let $\psi \in \text{Irr}_{p'}(B_0(PN))$ with $c(\psi)_p = p^{\beta}$ and write $H = PNC_G(P)$. By Theorem [2.4,](#page-3-3) ψ extends to a character $\hat{\psi} \in \text{Irr}_{p'}(B_0(H))$ with $c(\hat{\psi})_p = p^{\beta}$. By Lemma [2.2](#page-2-2)

there is some $\chi \in \text{Irr}_{p'}(B_0(G))$ lying over $\hat{\psi}$ with $c(\chi)_p \leq p^{\beta}$. Notice that χ lies over $\theta := \psi_N \in \text{Irr}_{p'}(B_0(N)).$ Also notice that $\psi = \rho \hat{\theta}$ for some $\rho \in \text{Irr}_{p'}(PN/N)$ by Gallagher's theorem, where $\hat{\theta} \in \text{Irr}(PN)$ is the canonical extension of θ given by [\[17,](#page-11-14) Cor. 6.2 and 6.4], with $c(\theta) = c(\hat{\theta})$. By Lemma [2.6,](#page-3-4) we have $c(\rho)_p \leq c(\psi)_p = p^{\beta}$ and either (1) $c(\hat{\theta})_p = c(\psi)_p$ or (2) $c(\rho)_p = c(\psi)_p$.

In case (1) we have that $c(\theta)_p = p^{\beta} \ge p^2$. By Lemma [2.3](#page-3-5) this yields that $c(\chi)_p \ge p^2$ and by using Lemma [2.5](#page-3-2) we conclude $c(\chi)_p = p^{\beta}$, as desired.

In case (2), we have that $c(\rho)_p = p^{\beta}$, so $\exp(PN/(PN)') \ge p^{\beta}$ because $PN/\ker \rho$ is cyclic and $(PN)' = P'N \subseteq \text{ker } \rho$ (recall that N is perfect by Step 1). If all characters in $\text{Irr}_{p'}(B_0(G/N))$ have p-rationality level strictly smaller than β then Remark [3.2](#page-4-2) implies $\exp(PN/(PN)') < p^{\beta}$, which is a contradiction. Hence some character in $\text{Irr}_{p'}(B_0(G/N))$ has p-rationality level at least β and the inductive hypothesis guarantees the existence of a character in $\text{Irr}_{p'}(B_0(G/N)) \subseteq \text{Irr}_{p'}(B_0(G))$ of p-rationality level exactly β .

The last claim follows from [\[15,](#page-11-13) Cor. 9.6].

Final step: Let $\chi \in \text{Irr}_{p'}(B_0(G))$ with $c(\chi)_p = p^{\alpha} \geq p^2$. Let N be a minimal normal subgroup of G. By Step 1, we can write $N = S_1 \times \cdots \times S_t$ where the S_i are isomorphic nonabelian simple groups of order divisible by p permuted transitively by G . By Step 2, G/N is a p-group. In particular, $\chi_N = \theta \in \text{Irr}_{p'}(B_0(N))$ is irreducible with $c(\theta)_p = p^{\gamma} \leq p^{\alpha}$.

Arguing as in the second paragraph of Step 2, we can write $\chi = \hat{\theta} \rho$ where $\hat{\theta}$ is the canonical extension of θ to G and $\rho \in \text{Irr}(G/N)$ with $p^{\alpha} = c(\rho)_{p}$ or $p^{\alpha} = c(\theta)_{p}$. If $p^{\alpha} = c(\rho)_{p}$ then, using that the result is true for p-groups we are done. Otherwise, $p^{\alpha} = c(\theta)_{p}$. Let $\{x_1, \ldots, x_t\}$ be a transversal of $\mathbb{N}_G(S_1)$ in G, chosen so that $S_i = (S_1)^{x_i}$. Then we can write $\theta = \theta_1^{x_1} \times \cdots \times \theta_t^{x_t}$, where $\theta_i \in \text{Irr}_{p'}(B_0(S_1))$. Since θ is G-invariant, θ_i and θ_1 are Aut(S₁)-conjugate, for every $i \in \{1, \ldots, t\}$. In particular, $c(\theta_i)_p = c(\theta_1)_p$ for every $i \in \{1, ..., t\}$ and actually $c(\theta_1) = c(\theta)_p = p^{\alpha}$.

As θ is G-invariant, θ_1 is $\mathbf{N}_G(S_1)$ -invariant. Since we may view $\mathbf{N}_G(S_1)/\mathbf{C}_G(S_1) \leq$ Aut (S_1) and $\mathbf{N}_G(S_1)/S_1\mathbf{C}_G(S_1)$ is a p-group, it follows from Conjecture [3.1\(](#page-4-1)b) that S_1 has $\mathbf{N}_G(S_1)$ -invariant characters $\eta_\beta \in \text{Irr}_{p'}(B_0(S_1))$ with $c(\eta_\beta)_p = p^\beta$ for every $2 \le \beta \le \alpha$. It is straightforward to check that

$$
\theta_{\beta}:=\eta_{\beta}^{x_1}\times\cdots\times\eta_{\beta}^{x_t}
$$

is G-invariant and has degree coprime to p. Further, θ_{β} lies in $B_0(N)$ by [\[22,](#page-11-15) Lemma 2.1(b)]. Notice also that $c(\theta_{\beta})_p = c(\eta_{\beta})_p = p^{\beta}$. By [\[17,](#page-11-14) Cor. 6.2 and 6.4] there is a canonical extension $\hat{\theta}_{\beta} \in \text{Irr}(G)$ of θ_{β} with $c(\hat{\theta}_{\beta}) = c(\theta_{\beta})$, so $c(\hat{\theta}_{\beta})_p = p^{\beta}$. Since G/N is a p-group, using [\[15,](#page-11-13) Cor. 9.6] we conclude that $\hat{\theta}_{\beta}$ lies in the principal p-block, as desired. \square

4. On almost simple groups and Theorem A

The purpose of this Section is to show that Conjecture [3.1\(](#page-4-1)b) holds for every finite simple group when $p = 2$. Our first observation is for arbitrary primes p.

Proposition 4.1. *Conjecture [3.1\(](#page-4-1)b) holds for any prime* p *whenever* S *is a sporadic simple group, the Tits group, an alternating group* \mathfrak{A}_n *with* $n \geq 5$ *, or a simple group of Lie type in characteristic* p*.*

Proof. As argued in the proof of [\[9,](#page-11-4) Prop. 5.1], alternating groups, sporadic simple groups and groups of Lie type in characteristic p have $c(\chi)_p \leq p^2$ for all of their irreducible characters χ .

To deal with the groups of Lie type in non-defining characteristic we use the following setup. Let G be a simple algebraic group of simply connected type over an algebraically closed field of characteristic r and $F : G \to G$ a Steinberg endomorphism, with finite group of fixed points $G = \mathbf{G}^F$. By Proposition [4.1,](#page-5-1) to show Conjecture [3.1\(](#page-4-1)b) it remains to consider the non-abelian simple quotients S of groups G as just described, for primes $p \neq r$. Assume $S = G/\mathbf{Z}(G)$. Now the irreducible characters $\chi \in \text{Irr}_{p'}(B_0(S))$ are the deflations of characters $\tilde{\chi} \in \text{Irr}_{p'}(B_0(G))$ containing $\mathbf{Z}(G)$ in their kernel, and all automorphisms of S are induced by automorphisms of G , so to prove the validity of Conjecture [3.1\(](#page-4-1)b) we can argue using characters of G. We refer to [\[6\]](#page-11-16) for notation and background on characters of finite reductive groups.

The following observation might be of independent interest:

Proposition 4.2. *Let* G *be as above. Then any unipotent character of* G *of odd degree is rational valued.*

Proof. By [\[6,](#page-11-16) Prop. 4.5.5] the character fields of unipotent characters are generated by their Frobenius eigenvalues, except for the principal series characters of E_7 and E_8 lying in exceptional families. Now for classical types all Frobenius eigenvalues are ± 1 , and for the exceptional types a quick inspection shows that all irrational unipotent characters have even degree.

Theorem 4.3. *Conjecture* [3.1](#page-4-1) *holds for* $p = 2$ *.*

Proof. As pointed out in Remark [3.2,](#page-4-2) Part (a) has been shown in [\[13\]](#page-11-7). For Part (b), by Proposition [4.1](#page-5-1) we only need to consider S a simple group of Lie type in odd characteristic r. Let G, F and $G = G^F$ be as above such that $S = G/\mathbf{Z}(G)$, and let $P \in \mathrm{Syl}_2(G)$. By [\[20,](#page-11-6) Prop. 3.9], P/P' has exponent 2 and thus by [\[13,](#page-11-7) Thm 1] all $\chi \in \text{Irr}(B_0(S))$ have 2-rationality level $\alpha \leq 2$ and there is nothing to prove, unless G is either $E_6(\epsilon q)_{\rm sc}$ or $SL_{2n}(\epsilon q)$ with $q \equiv \epsilon \pmod{4}$ and n not a 2-power. It remains to discuss the latter two families of groups.

We first make some general observations. By Broué–Michel $[3, Thm 9.12]$, the principal 2-block of G lies in the union of Lusztig series

$$
\operatorname{Irr}(B_0(G))\subseteq \bigsqcup_t \mathcal{E}(G,t)
$$

where t runs over 2-elements in a group G^* dual to G. Furthermore, by Lusztig's character degree formula (Jordan decomposition, [\[6,](#page-11-16) Thm 2.6.22]), for $\chi \in \mathcal{E}(G, t)$ to have odd degree, t has to be 2-central in G^* , that is to say, it must lie in the centre of some Sylow 2-subgroup of G^* . By Proposition [4.2](#page-6-0) the claim is vacuous for unipotent characters. Let A be such that $G \triangleleft A$.

Now first assume $G = E_6(\epsilon q)_{\rm sc}$ with $4|(q - \epsilon)$. By [\[13,](#page-11-7) Tab. 1] the centre Z of a Sylow 2-subgroup of G is a cyclic group of order $(q - \epsilon)_2$ and is centralised by a (Levi) subgroup $D_5(\epsilon q)(q-\epsilon)$. Now note that all non-trivial elements $1 \neq t \in \mathbb{Z}$ have connected centraliser (of type D_5). Thus, by [\[9,](#page-11-4) Thm 5.6] the 2-rationality level α_t of all $\chi \in \mathcal{E}(G, t)$ is the

same and given by $|t| = 2^{\alpha_t}$. Now, as $\mathbf{C}_{\mathbf{G}^*}(t)$ is connected, for each t there is a unique semisimple character $\chi_t \in \mathcal{E}(G, t)$ [\[6,](#page-11-16) Def. 2.6.9, Cor. 2.6.18]. By [\[5,](#page-11-18) Thm B] all χ_t lie in the principal 2-block of G. If $\mathcal{E}(G, t)$ contains an A-invariant character, then in particular $\mathcal{E}(G,t)$ is A-stable, and hence χ_t is A-invariant. But then also all $\mathcal{E}(G, t^k)$ are A-stable for any $k \ge 1$ by [\[24,](#page-11-19) Prop. 7.2]. Since χ_{t^k} is the unique semisimple character in $\mathcal{E}(G, t^k)$ this forces χ_{t^k} to be A-invariant. Thus any $2 \leq \beta \leq \alpha_t$ occurs as 2-rationality level of some $\chi \in \text{Irr}_{2'}(B_0(S))$, as desired.

Finally, assume $G = SL_{2n}(\epsilon q)$ with $4|(q - \epsilon)$ and n not a 2-power. In this case, by [\[8,](#page-11-20) Tab. 4.5.1], all centralisers of 2-central 2-elements of $G^* \cong {\rm PGL}_{2n}(\epsilon q)$ are connected, and they are Levi subgroups. Moreover, by [\[3,](#page-11-17) Thm 21.14] all Lusztig series $\mathcal{E}(G, t)$, for 2-elements $t \in G^*$ lie in the principal 2-block. But then we can argue exactly as in the previous case.

5. ON THE *p*-RATIONALITY GAP

The purpose of this section is to show that Conjecture B of the introduction holds for groups with a normal Sylow p-subgroup. In order to do so we need to recall the concept of semi-inertia subgroup and some of its properties.

Let $N \leq G$. The *semi-inertia subgroup of* $\theta \in \text{Irr}(N)$ is defined as

$$
G_{\theta}^* := \{ g \in G \mid \theta^g = \theta^{\tau} \text{ for some } \tau \in \text{Gal}(\mathbb{Q}(\theta)/\mathbb{Q}) \}.
$$

Notice that $G_{\theta} \leq G_{\theta}^*$.

Lemma 5.1. Let $N \leq G$ and $\theta \in \text{Irr}(N)$. Let G^*_{θ} be the semi-inertia subgroup of θ in G .

- (a) If $\psi \in \text{Irr}(G_{\theta}|\theta)$ then $\mathbb{Q}(\psi^{G_{\theta}^*}) = \mathbb{Q}(\psi^G)$.
- (b) The map $g \mapsto \tau$ where $\theta^g = \theta^{\tau}$ is a well-defined group homomorphism

$$
G_\theta^*\to \mathrm{Gal}(\mathbb{Q}(\theta)/\mathbb{Q}(\theta^G))
$$

with kernel G_{θ} *, so*

$$
G_{\theta}^*/G_{\theta} \cong \text{Gal}(\mathbb{Q}(\theta)/\mathbb{Q}(\theta^G)).
$$

Proof. See [\[19,](#page-11-21) Lemmas 2.2 and 2.3]. Note that if $g \mapsto \tau$, then $(\theta^G)^\tau = (\theta^\tau)^G = (\theta^g)^G =$ θ^G , so τ fixes θ^G , and it follows that the map is well-defined.

We fix a prime p and set $\mathcal{G} := \text{Gal}(\mathbb{Q}_p/\mathbb{Q}) = \{\tau_1, \ldots, \tau_{p-1}\}\$ where τ_j takes a fixed primitive pth root of unity to its jth power. If P is an elementary abelian p -group, then G acts on P by automorphisms as $\tau_j(y) = y^j$ for every $y \in P$ and $\tau_j \in \mathcal{G}$.

Lemma 5.2. *Let* P *be an elementary abelian* p*-group. Suppose that* X *acts coprimely by automorphisms on* P*.* Let $\mathcal{G} = \text{Gal}(\mathbb{Q}_p/\mathbb{Q})$ and write $A = X \times \mathcal{G}$ *. Then* A acts by *automorphisms and coprimely on* P *(where the action of* G *is as in the previous paragraph) and the actions of* A *on* P *and* $\text{Irr}(P)$ *are permutation isomorphic. Set* $G = P \rtimes X$ *. If* $y \mapsto \lambda_y$ *is an* A-equivariant bijection $P \to \text{Irr}(P)$ *, then*

$$
\mathbf{N}_G(\langle y \rangle) / \mathbf{C}_G(y) = G_{\lambda_y}^* / G_{\lambda_y} \quad \text{for all } y \in P.
$$

Proof. The group A acts by automorphisms on P because the actions of X and $\mathcal G$ commute. The actions of A on P and $\text{Irr}(P)$ are permutation isomorphic by [\[11,](#page-11-22) Thm 18.10]. Let $\alpha: P \to \text{Irr}(P)$ be an A-equivariant bijection. Write $\alpha(y) = \lambda$. Notice that $G_{\lambda} = P \rtimes X_{\lambda}$. Now $x \in X_\lambda$ if, and only if, $\alpha(y)^x = \alpha(y)$ if, and only if, $x \in \mathbf{C}_X(y)$. Also, $G^*_\lambda = P \rtimes X^*_\lambda$ and $x \in X^*_{\lambda}$ if, and only if, there is some $\tau \in \mathcal{G}$ for which $\alpha(y)^x = \alpha(y)^{\tau}$ if, and only if, $y^x = y^\tau = y^j$ for some $j \in \{1, \ldots, p-1\}$ if, and only if, $x \in \mathbb{N}_X(\langle y \rangle)$.

We denote by $\text{Irr}_{p',\sigma_1}(G)$ the subset of characters in $\text{Irr}_{p'}(G)$ fixed by the Galois automorphism σ_1 , that is, the set of almost p-rational characters of degree coprime to p. We mention that there is no standard notation yet for this set in the literature (see [\[22,](#page-11-15) [10\]](#page-11-2)), we use the notation from [\[18\]](#page-11-1).

Lemma 5.3. Let G be a finite group, $P \in \mathrm{Syl}_p(G)$ and assume $P \trianglelefteq G$. Then $\mathrm{Irr}_{p',\sigma_1}(G)$ = $\mathrm{Irr}(G/\Phi(P)).$

Proof. Let $\chi \in \text{Irr}_{p',\sigma_1}(G)$. Then by Clifford's theorem $\chi_P = e(\lambda_1 + \cdots + \lambda_t)$ for some $e \geq 1$, where $\{\lambda_1, \ldots, \lambda_t\}$ is the set of G-conjugates of some linear $\lambda \in \text{Irr}(P/P')$. Since $\chi^{\sigma_1} = \chi$ the p-group $\langle \sigma_1 \rangle$ acts on $\{\lambda_1, \ldots, \lambda_t\}$, but $t = |G : G_\lambda|$ divides $|G : P|$ and thus is prime to p. This shows σ_1 fixes some λ_i and therefore it fixes all of them. Thus $\lambda^{\sigma_1} =$ $\lambda^{p+1} = \lambda$ so λ has order p as an element of Irr(P/P'). We conclude that $\Phi(P) \subseteq \text{ker }\lambda$ so $\text{Irr}_{p',\sigma_1}(G) \subseteq \text{Irr}(G/\Phi(P))$. For the reverse inclusion, notice that $\lambda \in \text{Irr}(P/\Phi(P))$ is σ_1 -fixed, and so is every $\chi \in \text{Irr}(G|\lambda)$ by [\[20,](#page-11-6) Lemma 5.1].

We recall the statement of Conjecture B below for the reader's convenience.

Conjecture 5.4. Let G be a finite group, p be a prime and $P \in \mathrm{Syl}_p(G)$. Write $K =$ $\mathbf{N}_G(P)/\Phi(P)$ and $Q = P/\Phi(P)$. Then the following are equivalent:

- (i) *Every almost p-rational* $\chi \in \text{Irr}_{p'}(G)$ *is p-rational.*
- (ii) *The following hold for all* $1 \neq y \in Q$:
	- (a) $N_K(\langle y \rangle)/C_K(y) \cong Aut(\langle y \rangle)$ *, and*
	- (b) $N_K(\langle y \rangle)/Q$ *acts trivially on the set of conjugacy classes of* $C_K(y)/Q$ *.*

Recall that if $p = 2$, the conditions in Conjecture [5.4](#page-8-1) are vacuous. If p is odd, then a character χ is almost p-rational if, and only if, χ is σ_1 -fixed.

Theorem 5.5. Let G be a finite group, p be a prime and $P \in \mathrm{Syl}_p(G)$. Suppose that $P \triangleleft G$ *. Then Conjecture* [5.4](#page-8-1) *holds for* G *and* p.

Proof. Conjecture [5.4](#page-8-1) trivially holds when $p = 2$, so we may assume that p is odd. We begin the proof with a few observations. Let $Q = P/\Phi(P)$ and write $\mathcal{G} = \text{Gal}(\mathbb{Q}_p/\mathbb{Q})$. If $m = |G|_{p'}$ then restriction yields an isomorphism $Gal(\mathbb{Q}_{mp}/\mathbb{Q}_m) \to \mathcal{G}$ and by abuse of notation, we identify the elements $\tau \in Gal(\mathbb{Q}_{mp}/\mathbb{Q}_m)$ with their restriction $\tau \in \mathcal{G}$. Consider the action by automorphisms of G on Q described before Lemma [5.2.](#page-7-1) Write $K = Q \rtimes X$ for some complement X of Q in $G/\Phi(P)$. By Lemma [5.3](#page-8-2) we have $\text{Irr}_{p',\sigma_1}(G)$ = Irr(K). Write also $A = X \times \mathcal{G}$. Notice that every $\lambda \in \text{Irr}(Q)$ extends to a canonical $\hat{\lambda} \in \text{Irr}(K_{\lambda})$ by [\[17,](#page-11-14) Cor. 6.2 and 6.4], and $\mathbb{Q}(\hat{\lambda}) = \mathbb{Q}(\lambda) = \mathbb{Q}_p$. If $H = K_{\lambda}^*$ then it follows that $H_{\hat{\lambda}} = H_{\lambda} = K_{\lambda}$ and that $H_{\hat{\lambda}}^* = H$. By combining Clifford's and Gallagher's theorem we have

$$
\operatorname{Irr}(K|\lambda) = \{ (\rho \hat{\lambda})^K \mid \rho \in \operatorname{Irr}(K_{\lambda}/Q) \}.
$$

Furthermore if $\chi \in \text{Irr}(K|\lambda)$ has Clifford correspondent $\psi \in \text{Irr}(K_\lambda|\lambda)$ then we denote by $\psi^* = \psi^{K^*_{\lambda}} \in \text{Irr}(K^*_{\lambda}|\lambda)$ so that $\mathbb{Q}(\psi^*) = \mathbb{Q}(\chi)$, where $\chi = (\psi^*)^G$, by Lemma [5.1.](#page-7-2)

We begin by proving that (i) implies (ii.a), so we are assuming that every element of Irr(K) is p-rational. Suppose that for some $1 \neq y \in Q$ we have that $N_K(\langle y \rangle)/C_K(y)$ is not isomorphic to \mathcal{G} ; in other words, that

$$
|\mathbf{N}_K(\langle y \rangle) / \mathbf{C}_K(y)| < p - 1.
$$

Let $1_Q \neq \lambda \in \text{Irr}(Q)$ correspond to y under an A-equivariant bijection as in Lemma [5.2,](#page-7-1) so that $K_{\lambda}^*/K_{\lambda} = \mathbf{N}_K(\langle y \rangle) / \mathbf{C}_K(y)$. Let $\chi \in \text{Irr}(K)$ be over λ . By hypothesis χ is *p*-rational. Let $\psi \in \text{Irr}(K_\lambda|\lambda)$ be the Clifford correspondent of χ . As explained in the first paragraph, then $\psi^* = \psi^{K^*_{\lambda}}$ is also *p*-rational. In particular we have

$$
\psi^*(g) = \psi(1) \sum_{k \in [K^*_\lambda/K_\lambda]} \lambda^k(g) \in \mathbb{Q} \quad \text{for every } g \in Q,
$$

where $[K^*_\lambda/K_\lambda]$ is a complete set of representatives of the K_λ -cosets in K^*_λ . Let $\mathcal{K} \leq \mathcal{G}$ be the image of $K_{\lambda}^*/K_{\lambda}$ under the homomorphism from Lemma [5.1,](#page-7-2) and notice that $\mathcal{K} < \mathcal{G}$. λ Then \sum τ∈K λ^{τ} is rational. But for $\sigma \in \mathcal{G} \setminus \mathcal{K}$, the equality \sum $\tau \in \mathcal{K}$ $\lambda^{\tau} = \sum$ $\tau \in \mathcal{K}$ $\lambda^{\tau\sigma}$ contradicts the

linear independence of characters of Q. This proves that (i) implies (ii.a).

Now we prove (i) implies (ii.b). Let $1_Q \neq \lambda \in \text{Irr}(Q)$. Notice that the previous proof shows $K^*_\lambda/K_\lambda \cong \mathcal{G}$. Now Irr $(K|\lambda)$ are all p-rational by hypothesis. Let $\chi \in \text{Irr}(K|\lambda)$, let $\psi \in \text{Irr}(\widetilde{K}_{\lambda}|\lambda)$ be its Clifford correspondent and let $\psi^* = \psi^{K^*_{\lambda}}$ be its correspondent in K^*_{λ} and write $\psi = \rho \lambda$ as in the first paragraph of this proof. Now, ψ has values contained in \mathbb{Q}_{pm} where $m = |G|_{p'}$. Since χ is p-rational, if $\tau \in \text{Gal}(\mathbb{Q}_{pm}/\mathbb{Q}_m) \cong \mathcal{G}$ we have $\chi^{\tau} = \chi$ so $(\psi^*)^{\tau} = \psi^*$. Further, by the first comment of this paragraph, there is $x \in K_{\lambda}^*/K_{\lambda}$ with $\lambda^{\tau} = \lambda^x$. This implies that both ψ^{τ} and ψ^x are the Clifford correspondents of ψ^* in K_{λ} over λ^{τ} , and therefore $\psi^{\tau} = \psi^x$. Using that $\rho^{\tau} = \rho$,

$$
\rho \hat{\lambda}^{\tau} = \rho^{\tau} \hat{\lambda}^{\tau} = \psi^{\tau} = \psi^x = \rho^x \hat{\lambda}^x = \rho^x \hat{\lambda}^{\tau}
$$

which implies $\rho = \rho^x$. Since this holds for any $\chi \in \text{Irr}(K_\lambda|\lambda)$ and any $\tau \in \mathcal{G}$, we conclude that $\rho^x = \rho$ for any $\rho \in \text{Irr}(K_\lambda/Q)$ and any $x \in K_\lambda^*$. By Brauer's Lemma on character tables (see [\[17,](#page-11-14) Thm 2.3]) we have that K_{λ}^{*}/Q acts trivially on the set of conjugacy classes of K_{λ}/Q , and this concludes the proof of (ii.b) assuming (i).

We finally prove that (ii) implies (i). By Lemma [5.3](#page-8-2) we need to show that every character of K is p-rational. Let $\chi \in \text{Irr}(K)$ and let $\lambda \in \text{Irr}(Q)$ be under χ . If λ is trivial, then χ can be seen as a character of the p'-group K/Q and hence χ is p-rational, as wanted. We can therefore assume that λ is nontrivial. By Lemma [5.2](#page-7-1) there is some $1 \neq y \in Q$ such that $K^*_{\lambda}/K_{\lambda} = \mathbf{N}_K(\langle y \rangle)/\mathbf{C}_K(y)$. By hypothesis and Lemma [5.1\(](#page-7-2)b), we have $K_{\lambda}^*/K_{\lambda} \cong \mathcal{G}$. Let $\psi \in \text{Irr}(K_{\lambda}|\lambda)$ be the Clifford correspondent of χ and write $\psi^* = \psi^{K^*_{\lambda}}$. We have that $\mathbb{Q}(\chi) = \mathbb{Q}(\psi^*)$ by Lemma [5.1\(](#page-7-2)a), so we want to show that ψ^* is p-rational.

By definition, for all $x \in K^*_{\lambda}$ there is $\tau \in \mathcal{G}$ with $\lambda^{\tau} = \lambda^x$. Since $|K^*_{\lambda}/K_{\lambda}| = |\mathcal{G}|$, the converse is also true. So, fixing some $\tau \in \mathcal{G}$ we have $\lambda^{\tau} = \lambda^{x}$ for $x \in K_{\lambda}^{*}$. Now, using the notation established at the beginning of this proof, we have $\hat{\lambda}^x = \hat{\lambda}^{\tau}$, where $\hat{\lambda}$ is the canonical extension of λ to K_{λ} . Thus

$$
\psi^{\tau} = \rho^{\tau} \hat{\lambda}^{\tau} = \rho \hat{\lambda}^x = \rho^x \hat{\lambda}^x = \psi^x
$$

where we have used in the second to last equality that $\rho^x = \rho$ by (ii.b) and Brauer's permutation lemma. Thus $\psi^{\tau} = \psi^x$ and therefore

$$
(\psi^*)^\tau = (\psi^\tau)^{K^*_{\lambda}} = (\psi^x)^{K^*_{\lambda}} = \psi^*
$$

and we conclude that ψ^* is τ -invariant for any $\tau \in \mathcal{G}$. Thus ψ^* is p-rational and we are done. \Box

Corollary 5.6. *Let* G *be a finite group,* p *a prime. If* G *satisfies the McKay–Navarro conjecture for the prime* p *then Conjecture [5.4](#page-8-1) holds for* G *and* p*.*

Proof. Let $P \in \mathrm{Syl}_p(G)$. As explained at the beginning of Section [2,](#page-2-0) if [\[16,](#page-11-5) Conj. A] holds for G and p then there is a bijection *: $\text{Irr}_{p'}(G) \to \text{Irr}_{p'}(\mathbf{N}_G(P))$ with $c(\chi)_{p} = c(\chi^*)_{p}$ for all $\chi \in \text{Irr}_{p'}(G)$. It follows that the numbers of p-rational and almost p-rational characters in both G and $N_G(P)$ coincide. Therefore we may work in $N_G(P)$ and then we can apply Theorem [5.5.](#page-8-0) \Box

As already mentioned in the Introduction, thanks to Corollary [5.6](#page-10-3) and [\[2,](#page-10-0) [16,](#page-11-5) [23,](#page-11-9) [25\]](#page-11-8), Conjecture [5.4](#page-8-1) (Conjecture B from the Introduction) holds for G and p whenever G is p -solvable group, a group of Lie type in characteristic p , a sporadic, a symmetric or and alternating group.

There is a natural version of Conjecture [5.4](#page-8-1) for principal blocks.

Conjecture 5.7. Let G be a finite group, p be a prime and $P \in \mathrm{Syl}_p(G)$. Write $K =$ $\mathbf{N}_G(P)/\mathbf{O}_{p'}(\mathbf{N}_G(P))\Phi(P)$ and $Q \in \mathrm{Syl}_p(K)$. Then the following are equivalent:

- (i) *Every almost p-rational* $\chi \in \text{Irr}_{p'}(B_0(G))$ *is p-rational.*
- (ii) *The following hold for all* $1 \neq y \in Q$:
	- (a) $\mathbf{N}_K(\langle y \rangle)/\mathbf{C}_K(y) \cong \mathrm{Aut}(\langle y \rangle)$ *, and*
	- (b) $N_K(\langle y \rangle)/Q$ acts trivially on the set of conjugacy classes of $C_K(y)/Q$.

As explained at the beginning of Section [2,](#page-2-0) the Alperin–McKay–Navarro Conjecture [\[16,](#page-11-5) Conj. B] implies Conjecture [2.1.](#page-2-1)

Corollary 5.8. *Let* G *be a finite group and* p *a prime. If* G *satisfies Conjecture [2.1](#page-2-1) for* p *then Conjecture [5.7](#page-10-1) holds for* G *and* p*.*

Proof. By Conjecture [2.1](#page-2-1) we may assume $P \leq G$. By [\[15,](#page-11-13) Thm 10.20], in this case $\text{Irr}(B_0(G)) = \text{Irr}(G/\mathbf{O}_{p'}(G))$. We apply Theorem [5.5](#page-8-0) to $G/\mathbf{O}_{p'}(G)$ to conclude.

By Corollary [5.8](#page-10-4) and [\[16,](#page-11-5) [25,](#page-11-8) [7,](#page-11-23) [2\]](#page-10-0), Conjecture [5.7](#page-10-1) holds for G and p whenever G is p-solvable, sporadic, a symmetric or an alternating group.

We close by mentioning that the dihedral group $G = D_{24}$ possesses irreducible characters of degree coprime to 3 and of 3-rationality level 1, but none of them lie in the principal 3-block. Notice that in fact $G/O_{3'}(G) \cong \mathfrak{S}_3$ so the conclusion of Conjecture [5.7\(](#page-10-1)ii.b) is satisfied, but not the one of Conjecture [5.4\(](#page-8-1)ii.b).
