THE GEOMETRY OF LOOP SPACES IV: CLOSED SASAKIAN MANIFOLDS

1. INTRODUCTION

It is well known that the dimension of the isometry group $\text{Isom}(M^n, g)$ of a closed Riemannian manifold (M^n, g) is at most n(n+1)/2, with the maximum achieved for the standard metric on S^n . Nevertheless, this large isometry group has small fundamental group: $\pi_1(\text{Isom}(S^{n+1}, g_{\text{std}})) = \mathbb{Z}_2$. (Throughout, all fundamental groups are based at the identity map.) In contrast, for a generic (M, g), we expect that Isom(M, g) is trivial. Thus it seems interesting to produce examples, other than flat tori, where $\pi_1(\text{Isom}(M, g))$ is infinite.

In this paper, we construct a one-parameter family of distinct metrics h_{ρ} on any closed Sasakian manifold M^{4k+1} such that $\pi_1(\text{Isom}(M, h_{\rho}))$ is infinite.

Theorem 5.1. Let (M, g, ϕ, ξ, η) be a (4k+1)-dimensional closed regular Sasakian manifold, where $k \geq 1$. The metric $h_{\rho} = g + \rho^2 \eta \otimes \eta$ has $|\pi_1(\text{Isom}(M, h_{\rho})| = \infty$ for $\rho \in \mathbb{R}^+, \rho \gg 0$. For $\rho \neq \rho', h_{\rho}$ and $h_{\rho'}$ are not isometric.

Theorem 5.1 will be proved in §5. We note that the proof does not work for $\dim(M) = 4k + 3$.

For the case of S^{4k+1} , we refine Theorem 5.1:

Theorem 6.1. Let $k \geq 1$. Let g_{std} be the standard metric on S^{4k+1} , with η the contact form on S^{4k+1} associated with the Hopf fibration. For the metric $h_{\rho} = g_{std} + \rho^2 \eta \otimes \eta$, $|\pi_1(\text{Isom}(S^{4k+1}, h_{\rho}))| = \infty$ for $\rho^2 \neq 0$.

Thus the standard metric with small π_1 is the endpoint of a family with infinite π_1 . Using these techniques, in §7 we obtain a similar result for an infinite dimensional group.

Theorem 7.1. Let $\text{Diff}_{\eta,str}(S^{4k+1})$ be the group of strict contact diffeomorphisms of S^{4k+1} . Then $|\pi_1(\text{Diff}_{\eta,str}(S^{4k+1}))| = \infty$.

In fact, a stronger result has been given in [3]; we reproduce this result in [6].

As an outline of the paper, in §2, we recall the setup of Sasakian manifolds. In §3, we outline the proof of Thm. 5.1, which is based on the Wodzicki-Chern-Simons classes on the loop space LM used in [7, 8]. In §4, we introduce h_{ρ} and compute its curvature. In §5 we prove that the pullback of the Wodzicki-Chern-Simons class on LM to a top class on M is nonvanishing for $\rho \gg 0$. This involves detailed calculations. By the results of §3, we obtain Thm. 5.1. In §6, we prove Thm. 6.1, using the special nature of the standard metric on the sphere. We obtain similar results for other Sasakian space forms. In §7, we prove Thm. 7.1.

2. Sasakian manifolds

We first recall the definition of a Sasakian manifold. We work in local coordinates in preparation for later calculations; coordinate-free versions of the definitions are in [2].

A (2k + 1)-dimensional manifold M is called an *almost contact manifold* if there is an almost contact structure (ϕ, ξ, η) consisting of a (1, 1)-tensor field ϕ , a *characteristic vector* field ξ , and a 1-form η satisfying

(1)
$$(\phi^2)_i{}^j = \phi_i{}^k \phi_k{}^j = -\delta_i{}^j + \eta_i \xi^j, \quad \eta_k \xi^k = 1, \quad \phi_j{}^k \xi^j = 0, \quad \phi_j{}^k \eta_k = 0.$$

 $((M,\eta)$ is a contact manifold if $\eta \wedge (d\eta)^k \neq 0$ pointwise.) Let g be a Riemannian metric on M associated with the almost contact structure (ϕ, ξ, η) , *i.e.*,

(2)
$$g_{ij} = g_{k\ell} \phi_i^{\ k} \phi_j^{\ \ell} + \eta_i \eta_j.$$

Such a metric always exists. Then (g, ϕ, ξ, η) is called an almost contact metric structure for the almost contact structure (ϕ, ξ, η) . We set

(3)
$$\phi_{ij} = \phi_i^{\ k} g_{kj}, \qquad \phi^h_{\ j} = g^{h\ell} \phi_\ell^{\ k} g_{kj}$$

We note that (2) implies

(4)
$$g_{ij}\xi^j = \eta_i$$

so ξ and η are dual. Similarly, ϕ is skew-symmetric, since

$$\phi_{ji} = \phi_j{}^s g_{si} = \phi_j{}^s (g_{k\ell} \phi_s{}^k \phi_i{}^\ell + \eta_s \eta_i) = g_{k\ell} (-\delta_j{}^k + \eta_j \xi^k) \phi_i{}^k = -g_\ell \phi_i{}^\ell + \eta_j \eta_\ell \phi_i{}^\ell = -\phi_{ij}.$$

An almost contact metric structure is a contact metric structure (and (M, g, ϕ, ξ, η) is a contact metric manifold) if $\phi = -d\eta$, or equivalently,

(5)
$$\phi_{ij} = -\frac{1}{2}(\nabla_i \eta_j - \nabla_j \eta_i) := -\frac{1}{2}((\nabla_i \eta)_j - (\nabla_j \eta)_i),$$

where ∇ is the Levi-Civita connection for g. Finally, a contact metric manifold (M, g, ϕ, ξ, η) is Sasakian (or normal) if

(6)
$$\nabla_i \phi_j^{\ k} = g_{ij} \xi^k - \eta_j \delta_i^{\ k}.$$

As in [2, p. 87], writing (6) as $(\nabla_X \phi)(Y) = g(X, Y)\xi - \eta(Y)(X)$ and setting $Y = \xi$ gives $-\phi(\nabla_X \xi) = (\nabla_X \phi)(\xi) = \eta(X)\xi - X$. Apply ϕ to both sides, where $\phi^2(X) = -X + \eta(X)\xi$, and use $0 = g(\nabla_X \xi, \xi) = \eta(\nabla_X \xi)$ to obtain $\nabla_X \xi = -\phi(X)$. In coordinates, this becomes $\nabla_i \xi^j = -\phi_i^j$, or equivalently

(7)
$$-\phi_{ij} = \nabla_i \eta_j.$$

This refines (5) for Sasakian manifolds.

Since ϕ_{ij} is skew-symmetric, (7) implies

(8)
$$\nabla_i \eta_j + \nabla_j \eta_i = 0.$$

Therefore, $\xi^i = g^{ik}\eta_k$ is a unit Killing vector field on M which generates a one-parameter group of isometries.

The following result is standard.

Lemma 2.1. If
$$(M, g, \phi, \xi, \eta)$$
 is a $(2k + 1)$ -dimensional contact metric manifold, then
(9) $\eta \wedge (d\eta)^k = (-1)^k \eta \wedge \phi^k \neq 0.$

 $\eta \wedge (d\eta)^k$ is the volume form on M, so $\int_M \eta \wedge (d\eta)^k \neq 0$. Thus M is a contact manifold.

Proof. By (1) and (2), for $m \in M$ there is an orthonormal basis $\{e_1, \dots, e_{2k+1}\}$ on $T_m M$ such that $e_1 = \xi$, $\phi e_{1+\alpha} = e_{k+1+\alpha}$, $\phi e_{k+1+\alpha} = -e_{1+\alpha}$, for $\alpha = 1, \dots, k$. Thus,

$$\eta \wedge (d\eta)^k (e_1, e_2 \cdots, e_{k+1}, e_{k+2}, \cdots, e_{2k+1}) = \eta(e_1)g(\phi e_2, e_{k+1}) \cdots g(\phi e_{k+2}, e_{2k+1}) = 1 \neq 0.$$

A basic example of a Sasakian manifold is as follows.

Example 2.1. If $M = S^{2k+1}$, the (2k+1)-dimensional standard sphere of radius 1, then M is a Sasakian manifold with respect to the Hopf fibration

(10)
$$\pi: S^{2k+1} \to \mathbb{CP}^k,$$

where the characteristic vector field ξ is the unit vector along the fiber, and $\eta(\xi) = 1$ by (1).

In this paper, we assume that M is closed and *regular*, *i.e.*, the integral curves characteristic vector field ξ starting at any point $m \in M$ are periodic. By [2, p. 37], the period of the integral curves is independent of m. In this case, we have the circle fibration $S^1 \to M \to$ M/S^1 , and M/S^1 is a 2k-dimensional symplectic manifold. The example of the Hopf fibration is a special case. If ξ is regular, then there is a circle action

(11)
$$a: S^1 \times M \to M, \ a(\theta, m) = R_{\theta}(m),$$

given by rotation by angle θ in the circle fiber. This action is via isometries for the metrics h_{ρ} below (see Cor. 4.1).

The Theorems in the Introduction entail proving that the loop of isometries $a^I : S^1 \to \text{Isom}(M, h_{\rho}), a^I(\theta)(m) = a(\theta, m)$, has nontrivial class $[a^I] \in \pi_1(\text{Isom}(M, h_{\rho}))$ and that the powers $[a^I]^n$ are all distinct.

3. Outline of the proofs

As explained in [8, §2.2], a Riemannian metric g on M determines the Wodzicki-Chern-Simons form $CS_q^W \in \Lambda^{2k-1}(LM)$ given by

(12)
$$CS_{2k-1}^{W}(g)(X_{1},...,X_{2k-1}) = \frac{k}{2^{k-2}} \sum_{\sigma} \operatorname{sgn}(\sigma) \int_{S^{1}} \operatorname{tr}[(R(X_{\sigma(1)},\cdot)\dot{\gamma})(\Omega^{M})^{k-1}(X_{\sigma(2)},\ldots,X_{\sigma(2k-1)})],$$

at the loop $\gamma \in LM$. Here $\sigma \in (1, \ldots, 2k - 1)$, the permutation group on $\{1, \ldots, 2k - 1\}$, R is the curvature tensor of g, Ω is the curvature two-form of g, and the $X_i \in T_{\gamma}LM$ are vector fields $X_{i,\theta} \in T_{\gamma(\theta)}M$ defined along γ . This form comes from replacing the usual trace in the definition of Chern-Simons classes with the Wodzicki residue, which is a trace on the Lie algebra of the structure group for natural metric connections on TLM.

Associated to the action a is the map $a^L : M \to LM$ from M to the free loop space $LM = C^{\infty}(S^1, M)$ given by $a^L(m)(\theta) = a(\theta, m)$. This produces a top form $a^{L,*}CS^W \in \Lambda^{2k-1}(M)$. In [4, Appendix A], we prove

Proposition 3.1.

(13)
$$\int_{M} a^{L,*} CS^{W}_{2k-1}(g) \neq 0 \Rightarrow 0 \neq [a^{I}] \in \pi_{1}(\operatorname{Isom}(M,g)) \text{ and } [a^{I}]^{n} \neq [a^{I}]^{m} \text{ for } m \neq n.$$

for $g = h_{\rho}$.

The proof explicitly uses that the action is via isometries.

By the long calculation in §5, $a^{L,*}CS^W_{2k-1}(h_{\rho})$ is a form-valued polynomial in ρ whose leading coefficient is a nonzero multiple of $\eta \wedge (d\eta)^k$ (see (19) and Prop. 5.1). Thus $\int_M a^{L,*}CS^W_{2k-1}(h_{\rho})$ is a polynomial in ρ whose leading coefficient is a nonzero multiple of the h_{ρ} -volume of M. Therefore, $\int_M a^{L,*}CS^W_{2k-1}(h_{\rho}) \neq 0$ for $\rho \gg 0$, so Thm. 5.1 follows from (13). For the standard metric on S^{4k+1} , the form-valued polynomial consists of only one term, so $\int_M a^{L,*}CS^W_{2k-1}(h_{\rho}) \neq 0$ for all $\rho \neq 0$, which implies Thm. 5.1.

The tensorial calculation in §5 analyzes the integrand in (12), using the curvature calculations for h_{ρ} in §4. The integrand initially consists of an overwhelming number of terms, but the Bianchi identity and other symmetries are used repeatedly to eliminate most terms.

4. CURVATURE FORMULAS FOR THE METRIC h_{ρ}

Let (M, g, ϕ, η, ξ) be a regular Sasakian manifold. Define the new metric $h = h_{\rho}$ by

$$h_{ij} = g_{ij} + \rho^2 \eta_i \eta_j$$

To motivate this metric, we recall from [8, §3.2] that a regular contact manifold M is the total space of an S^1 -bundle $L_k \xrightarrow{\pi} N$ over a Riemannian symplectic manifold (N, ω, g_N) with $[\omega] \in H^2(N, \mathbb{Z})$ and $c_1(L) = k\omega$ for our choice of $k \in \mathbb{Z}$. L_k has the contact metric $g_k = \pi^* g_N + \eta_k \otimes \eta_k$, where η_k is dual to ξ_k , the unit tangent vector field to the fibers. $L_1 \xrightarrow{\alpha} L_k$ is a k-fold cover, so g_k pulls back to a locally isometric metric on L_1 .

Noting that $\eta_1 = k\alpha^* \eta_k$, we have a \mathbb{Z} -family of metrics on L_1 of the form $\alpha^* g_k + k^2 \eta_1 \otimes \eta_1$. This is a special case of h_{ρ} .

We will compute the Levi-Civita connection and the Riemannian curvature for h.

Lemma 4.1. Let h^{ij} be the inverse of the metric h_{ij} . Then

$$h^{ij} = g^{ij} + \alpha \xi^i \xi^j$$
 for $\alpha = -\frac{\rho^2}{1+\rho^2}$

Proof.

$$h_{ik}h^{kj} = (g_{ik} + \rho^2 \eta_i \eta_k)(g^{kj} + \alpha \xi^k \xi^j) = \delta_i^j + (\rho^2 + \alpha + \rho^2 \alpha)\eta_i \xi^j = \delta_i^j$$

for $\alpha = -\frac{\rho^2}{1+\rho^2}$.

Let Γ_{ij}^k and $\overline{\Gamma}_{ij}^k$ be the Christoffell symbols of g and h respectively:

$$\Gamma_{ij}^{k} = \frac{1}{2}g^{k\ell}(\partial_{i}g_{j\ell} + \partial_{j}g_{i\ell} - \partial_{\ell}g_{ij}), \ \bar{\Gamma}_{ij}^{k} = \frac{1}{2}h^{k\ell}(\partial_{i}h_{\ell j} + \partial_{j}h_{i\ell} - \partial_{\ell}h_{ij}).$$

Lemma 4.2.

$$\bar{\Gamma}_{ij}^k = \Gamma_{ij}^k - \rho^2 (\phi_i^k \eta_j + \phi_j^k \eta_i).$$

Proof.

$$\begin{split} \bar{\Gamma}_{ij}^{k} &= \frac{1}{2} h^{k\ell} (\partial_{i} g_{\ell j} + \partial_{j} g_{i\ell} - \partial_{\ell} g_{ij}) + \frac{1}{2} \rho^{2} h^{k\ell} (\partial_{i} (\eta_{\ell} \eta_{j}) + \partial_{j} (\eta_{i} \eta_{\ell}) - \partial_{\ell} (\eta_{i} \eta_{j})) \\ &= \frac{1}{2} g^{k\ell} (\partial_{i} g_{\ell j} + \partial_{j} g_{i\ell} - \partial_{\ell} g_{ij}) + \frac{1}{2} \alpha \xi^{k} \xi^{\ell} (\partial_{i} g_{\ell j} + \partial_{j} g_{i\ell} - \partial_{\ell} g_{ij}) \\ &\quad + \frac{1}{2} g^{k\ell} \rho^{2} (\partial_{i} (\eta_{\ell} \eta_{j}) + \partial_{j} (\eta_{i} \eta_{\ell}) - \partial_{\ell} (\eta_{i} \eta_{j})) + \frac{1}{2} \alpha \rho^{2} \xi^{k} \xi^{\ell} (\partial_{i} (\eta_{\ell} \eta_{j}) + \partial_{j} (\eta_{i} \eta_{\ell}) - \partial_{\ell} (\eta_{i} \eta_{j})) \\ &:= \Gamma_{ij}^{k} + (b) + (c) + (d). \end{split}$$

Note that

$$\partial_i g_{\ell j} = \partial_i \langle \partial_\ell, \partial_j \rangle = \langle \nabla_i \partial_\ell, \partial_j \rangle + \langle \partial_\ell, \nabla_i \partial_j \rangle = \Gamma^m_{i\ell} g_{mj} + \Gamma^m_{ij} g_{\ell m}.$$

Using $\Gamma_{ij}^k = \Gamma_{ji}^k$, we have

$$(b) = \frac{1}{2} \alpha \xi^k \xi^\ell (\partial_i g_{\ell j} + \partial_j g_{i\ell} - \partial_\ell g_{ij})$$

= $\frac{1}{2} \alpha \xi^k \xi^\ell (\Gamma^m_{i\ell} g_{mj} + \Gamma^m_{ij} g_{\ell m} + \Gamma^m_{ji} g_{m\ell} + \Gamma^m_{j\ell} g_{im} - \Gamma^m_{\ell i} g_{mj} - \Gamma^m_{\ell j} g_{im})$
= $\alpha \xi^k \xi^\ell \Gamma^m_{ij} g_{\ell m} = \alpha \Gamma^m_{ij} \eta_m \xi^k,$

since $\xi^{\ell} g_{\ell m} = \eta_m$. Using (5) and $\partial_i \eta_j = \nabla_i \eta_j + \Gamma_{ij}^k \eta_k$, we get

$$\begin{aligned} (c) &= \frac{\rho^2}{2} g^{k\ell} (\partial_i \eta_\ell \cdot \eta_j + \eta_\ell \cdot \partial_i \eta_j + \partial_j \eta_i \cdot \eta_\ell + \eta_i \cdot \partial_j \eta_\ell - \partial_\ell \eta_i \cdot \eta_j - \eta_i \cdot \partial_\ell \eta_j) \\ &= \frac{\rho^2}{2} g^{k\ell} (\nabla_i \eta_\ell \cdot \eta_j + \eta_\ell \cdot \nabla_i \eta_j + \nabla_j \eta_i \cdot \eta_\ell + \eta_i \cdot \nabla_j \eta_\ell - \nabla_\ell \eta_i \cdot \eta_j - \eta_i \cdot \nabla_\ell \eta_j \\ &\quad + \Gamma^m_{il} \eta_m \eta_j + \eta_\ell \Gamma^m_{ij} \eta_m + \Gamma^m_{ji} \eta_m \eta_\ell + \eta_i \Gamma^m_{j\ell} \eta_m - \Gamma^m_{\ell i} \eta_m \eta_j - \eta_i \Gamma^m_{\ell j} \eta_m) \\ &= \frac{\rho^2}{2} g^{k\ell} (\nabla_i \eta_\ell \cdot \eta_j - \nabla_\ell \eta_i \cdot \eta_j + \eta_i \cdot \nabla_j \eta_\ell - \eta_i \cdot \nabla_\ell \eta_j + 2\Gamma^m_{ij} \eta_\ell \cdot \eta_m) \\ &= -\rho^2 (\phi_i^{\ k} \eta_j + \phi_j^{\ k} \eta_i) + \rho^2 \Gamma^m_{ij} \xi^k \eta_m, \end{aligned}$$

where (7) is used in the last line.

Similarly,

$$(d) = \frac{1}{2}\alpha\rho^{2}\xi^{k}\xi^{\ell}(\partial_{i}(\eta_{\ell}\eta_{j}) + \partial_{j}(\eta_{i}\eta_{\ell}) - \partial_{\ell}(\eta_{i}\eta_{j})) = -\frac{\alpha}{2}\xi^{k}\xi^{\ell}\rho^{2}(2\phi_{i\ell}\eta_{j} + 2\phi_{j\ell}\eta_{i} - 2\Gamma_{ij}^{m}\eta_{\ell}\eta_{m})$$
$$= \alpha\rho^{2}\Gamma_{ij}^{m}\xi^{k}\eta_{m},$$

by (1).

Thus,

$$(b) + (c) + (d) = -\rho^2(\phi_i^k \eta_j + \phi_j^k \eta_i) + (\alpha + \rho^2 + \alpha \rho^2)\Gamma_{ij}^m \xi^k \eta_m = -\rho^2(\phi_i^k \eta_j + \phi_j^k \eta_i).$$

This gives the Lemma.

We want the action (11) to be an action by isometries for h_{ρ} . Since $\|\xi\|_{h_{\rho}}^2 = 1 + \rho^2$ by (1), (2) and the definition of h_{ρ} , $\bar{\xi} := (1 + \rho^2)^{-1/2} \xi$ has $\|\bar{\xi}\|_{h_{\rho}}^2 = 1$. We can consider (11) to be an action with $(d/d\theta)a(\theta,m) = \bar{\xi}$ by modifying the g-length of the orbits. If orbits have g-length λ , then these orbits now have h_{ρ} -length also equal to λ .

Corollary 4.1. The S¹-action $\{R_{\theta}\}$ in (11) is an action via isometries for h_{ρ} .

Proof. We have $\bar{\eta} = \bar{\eta}_i dx^i$ is given by

$$\bar{\eta}_i = (h_\rho)_{ij} \bar{\xi}^j = (g_{ij} + \rho^2 \eta_i \eta_j) ((1 + \rho^2)^{-1/2} \xi^j) = (1 + \rho^2)^{1/2} \eta_i.$$

Let $\overline{\nabla}$ be the Levi-Civita connection for h_{ρ} . By Lem. 4.2,

$$\bar{\nabla}_i \bar{\eta}_j := (\bar{\nabla}\bar{\eta})_i = (1+\rho^2)^{1/2} [\nabla_i \eta_j + \rho^2 (\phi_i^s \eta_j + \phi_j^s \eta_i) \eta_s] = (1+\rho^2)^{1/2} (\nabla_i \eta_j),$$

so

$$\bar{\nabla}_i \bar{\eta}_j + \bar{\nabla}_j \bar{\eta}_i = (1 + \rho^2)^{1/2} (\nabla_i \eta_j + \nabla_j \eta_i) = 0$$

Therefore, $\bar{\xi}$ is an h_{ρ} -unit Killing vector field and the rotation action is via isometry. \Box We now compute the curvature tensor for the metric h_{ρ} .

Lemma 4.3. Let $\bar{R}_{kji}{}^{h}$ and $R_{kji}{}^{h}$ be the curvature tensor of the Riemannian metrics h_{ρ} and g respectively. Then

$$\bar{R}_{kji}{}^{h} = R_{kji}{}^{h} - \rho^{2}(\phi_{ki}\phi_{j}{}^{h} - \phi_{k}{}^{h}\phi_{ji} + 2\phi_{kj}\phi_{i}{}^{h} + 2\eta_{k}\eta_{i}\delta_{j}{}^{h} - 2\eta_{j}\eta_{i}\delta_{k}{}^{h} + g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h})$$
(14) $-\rho^{4}(\eta_{k}\eta_{i}\delta_{j}{}^{h} - \eta_{j}\eta_{i}\delta_{k}{}^{h}).$

Proof.

$$\begin{split} \bar{R}_{kji}{}^{h} &= \partial_{k}\bar{\Gamma}^{h}_{ji} - \partial_{j}\bar{\Gamma}^{h}_{ki} + \bar{\Gamma}^{h}_{k\ell}\bar{\Gamma}^{\ell}_{ji} - \bar{\Gamma}^{h}_{j\ell}\bar{\Gamma}^{\ell}_{ki} \\ &= \partial_{k}(\Gamma^{h}_{ji} - \rho^{2}(\phi_{j}{}^{h}\eta_{i} + \phi_{i}{}^{h}\eta_{j})) - \partial_{j}(\Gamma^{h}_{ki} - \rho^{2}(\phi_{k}{}^{h}\eta_{i} + \phi_{i}{}^{h}\eta_{k})) \\ &+ (\Gamma^{h}_{k\ell} - \rho^{2}(\phi_{k}{}^{h}\eta_{\ell} + \phi_{\ell}{}^{h}\eta_{k}))(\Gamma^{\ell}_{ji} - \rho^{2}(\phi_{j}{}^{\ell}\eta_{i} + \phi_{i}{}^{\ell}\eta_{j})) \\ &- (\Gamma^{h}_{j\ell} - \rho^{2}(\phi_{j}{}^{h}\eta_{\ell} + \phi_{\ell}{}^{h}\eta_{j}))(\Gamma^{\ell}_{ki} - \rho^{2}(\phi_{k}{}^{\ell}\eta_{i} + \phi_{i}{}^{\ell}\eta_{k})) \end{split}$$

Therefore,

$$\bar{R}_{kji}{}^{h} = R_{kji}{}^{h} - \rho^{2} (\partial_{k}(\phi_{j}{}^{h}\eta_{i} + \phi_{i}{}^{h}\eta_{j}) - \partial_{j}(\phi_{k}{}^{h}\eta_{i} + \phi_{i}{}^{h}\eta_{k})) + \rho^{2} (\Gamma_{k\ell}^{h}(\phi_{j}^{\ell}\eta_{i} + \phi_{i}{}^{\ell}\eta_{j}) + \Gamma_{ji}^{\ell}(\phi_{k}{}^{h}\eta_{\ell} + \phi_{\ell}{}^{h}\eta_{k})) - \rho^{2} (\Gamma_{j\ell}^{h}(\phi_{k}^{\ell}\eta_{i} + \phi_{i}{}^{\ell}\eta_{k}) + \Gamma_{ki}^{\ell}(\phi_{j}{}^{h}\eta_{\ell} + \phi_{\ell}{}^{h}\eta_{j})) + \rho^{4}(\phi_{k}{}^{h}\eta_{\ell} + \phi_{\ell}{}^{h}\eta_{k})(\phi_{j}{}^{\ell}\eta_{i} + \phi_{i}{}^{\ell}\eta_{j}) - \rho^{4}(\phi_{j}{}^{h}\eta_{\ell} + \phi_{\ell}{}^{h}\eta_{j})(\phi_{k}{}^{\ell}\eta_{i} + \phi_{i}{}^{\ell}\eta_{k}) = R_{kji}{}^{h} + (\rho_{2}) + (\rho_{4})$$

where (ρ_a) is the ρ^a -term of \bar{R}_{kji}^h . We have

$$\begin{aligned} (\rho_2) &= -[\rho^2(\partial_k(\phi_j{}^h\eta_i + \phi_i{}^h\eta_j) - \partial_j(\phi_k{}^h\eta_i + \phi_i{}^h\eta_k)) \\ &+ \rho^2(\Gamma^h_{k\ell}(\phi_j{}^\ell\eta_i + \phi_i{}^\ell\eta_j) + \Gamma^\ell_{ji}(\phi_k{}^h\eta_\ell + \phi_\ell{}^h\eta_k)) \\ &- \rho^2(\Gamma^h_{j\ell}(\phi_k{}^\ell\eta_i + \phi_i{}^\ell\eta_k) + \Gamma^\ell_{ki}(\phi_j{}^h\eta_\ell + \phi_\ell{}^h\eta_j))] \\ &= -\rho^2[(\nabla_k\phi_j{}^h\cdot\eta_i + \phi_j{}^h\cdot\nabla_k\eta_i + \nabla_k\phi_i{}^h\cdot\eta_j + \phi_i{}^h\cdot\nabla_k\eta_j) \\ &- \rho^2(\nabla_j\phi_k{}^h\cdot\eta_i + \phi_k{}^h\cdot\nabla_j\eta_i + \nabla_j\phi_i{}^h\cdot\eta_k + \phi_i{}^h\cdot\nabla_j\eta_k)], \end{aligned}$$

where we use

$$\nabla_k \eta_i := (\nabla_k \eta)_i = \partial_k \eta_i - \Gamma_{ki}^{\ell} \eta_{\ell}, \ \nabla_k \phi_j^{\ h} := (\nabla_k \phi)_j^{\ h} = \partial_k \phi_j^{\ h} + \phi_j^{\ \ell} \Gamma_{k\ell}^{\ h} - \phi_\ell^{\ h} \Gamma_{kj}^{\ell}.$$

Using (6), (7), we have

$$(\rho_2) = -\rho^2 \left(g_{ki}\eta_j \xi^h - g_{ji}\eta_k \xi^h - 2\delta_k{}^h\eta_j\eta_i + 2\delta_j{}^h\eta_k\eta_i + \phi_j{}^h\phi_{ki} + 2\phi_i{}^h\phi_{kj} - \phi_k{}^h\phi_{ji} \right).$$

For the ρ_4 -term, using (1), we easily get

$$(\rho_4) = \rho^4 (\phi_k{}^h \eta_\ell + \phi_\ell{}^h \eta_k) (\phi_j{}^\ell \eta_i + \phi_i{}^\ell \eta_j) - \rho^4 (\phi_j{}^h \eta_\ell + \phi_\ell{}^h \eta_j) (\phi_k{}^\ell \eta_i + \phi_i{}^\ell \eta_k) = \rho^4 (-\delta_j{}^h \eta_k \eta_i + \delta_k{}^h \eta_j \eta_i).$$

Thus, we have the lemma.

5. Computation of CS^W

In this section, we compute the Wodzicki-Chern-Simons form for (M, h_{ρ}) , or more precisely its pullback $(a^L)^*CS^W$ (19). As explained in Prop. 3.1, the nonvanishing of $(a^L)^*CS^W$ (Cor. 5.1) is the key step in the proofs of the main Thms. 5.1, 6.1.

Notation: We introduce some local coordinates notation. Let $\mathfrak{T}_P^Q(M)$ and $\Lambda^P(M)$ be the space of tensor fields of type (Q, P) and P-froms on M respectively. For an (0, P)-tensor $S_{i_1...i_P}$ and (0, P')-tensor $S'_{i_1...i_P}$, its tensor product is

$$(S \otimes S')_{i_1 \cdots i_{P+P'}} := S_{i_1 \cdots i_P} \cdot S'_{i_P \cdots i_{P+P'}} \in \mathfrak{T}^0_{P+P'}(M)$$

For an (0, P)-tensor $S_{i_1...i_P}$, its skew-symmetrization with respect to the indices i_1, \ldots, i_P is denoted by

$$S_{[i_1\cdots i_P]} := \frac{1}{P!} \sum_{\sigma \in (1,2,\dots,P)} \operatorname{sgn}(\sigma) S_{i_{\sigma(1)}\cdots i_{\sigma(P)}} \in \Lambda^P(M).$$

For $A \in \Lambda^{P}(M)$ and $A' \in \Lambda^{P'}(M)$, the exterior product is

(15)
$$(A \wedge A')_{i_1 \cdots i_{P+P'}} = A_{[i_1 \cdots i_P} A'_{i_{P+1} \cdots i_{P+P'}]} \\ := \frac{1}{(P+P')!} \sum_{\sigma \in (1, \cdots, P+P')} \operatorname{sgn}(\sigma) A_{i_{\sigma(1)} \cdots i_{\sigma(P)}} A'_{i_{\sigma(P+1)} \cdots i_{\sigma(P+P')}}.$$

tr means the contraction of the superscript index and the subscript index of the \mathfrak{T}_1^1 part of a tensor. For example, for $S = S_{i_1 \cdots i_P k}{}^{\ell} \in \mathfrak{T}_P^0(M) \otimes \mathfrak{T}_1^1(M)$,

(16)
$$\operatorname{tr}(S)_{i_1\cdots i_P} = S_{i_1\cdots i_Pk}{}^k.$$

This notation extends to a "tensor and contract" operation on $\mathfrak{T}_P^0 \otimes \mathfrak{T}_1^1$. Namely, for $S_{i_1 \cdots i_P \ell'}{}^{\ell_{\alpha}} \in \mathfrak{T}_P^0 \otimes \mathfrak{T}_1^1$ and $S'_{i_1 \cdots i_{P'} \ell_{\beta}}{}^{\ell'} \in \mathfrak{T}_{P'}^0 \otimes \mathfrak{T}_1^1$, set

$$(S \otimes S')_{i_1 \cdots i_{P+P'}\ell_\beta}{}^{\ell_\alpha} = S_{i_1 \cdots i_P\ell'}{}^{\ell_\alpha}S'_{i_1 \cdots i_{P'}\ell_\beta}{}^{\ell'} \in \mathfrak{T}_{P+P'} \otimes \mathfrak{T}_1^1.$$

This similarly extends to a "wedge and contract" operation on $\Lambda^P(M) \otimes \mathfrak{T}_1^1$: For $A = A_{i_1 \cdots i_P \ell'} \in \Lambda^P(M) \otimes \mathfrak{T}_1^1(M)$, and $B_{i_1 \cdots i_{P'} \ell_\beta} \ell' \in \Lambda^{P'}(M) \otimes \mathfrak{T}_1^1(M)$, set

$$(A \wedge B)_{i_1 \cdots i_{P+P'}\ell_\beta}{}^{\ell_\alpha} = (A \otimes B)_{[i_1 \cdots i_{P+P'}]\ell_\beta}{}^{\ell_\alpha}$$

=
$$\frac{1}{(P+P')!} \sum_{\sigma \in (1, \cdots, P+P')} \operatorname{sgn}(\sigma) A_{i_{\sigma(1)} \cdots i_{\sigma}(P)\ell'}{}^{\ell_\alpha} B_{i_{\sigma(P+1)} \cdots i_{\sigma(P+P')}\ell_\beta}{}^{\ell'}$$

 $\in \Lambda^{P+P'}(M) \otimes \mathfrak{T}^1_1.$

For $S_{i_1\cdots i_P}, S'_{i_1\cdots i_P} \in \mathfrak{T}^0_P$, define an equivalence relation by

$$S_{i_1\cdots i_P} \sim S'_{i_1\cdots i_P} \mod(i_1\cdots i_P) \Leftrightarrow S_{[i_1\cdots i_P]} = S'_{[i_1\cdots i_P]},$$

and for $S_{i_1\cdots i_P}{\ell_0 \atop \ell_0}, S'_{i_1\cdots i_P}{\ell_0 \atop \ell_0} \in \mathfrak{T}^0_P \otimes \mathfrak{T}^1_1$, similarly write $S_{i_1\cdots i_P\ell_0}{\ell_1} \sim S'_{i_1\cdots i_P\ell_0}{\ell_1} \mod(i_1\cdots i_P) \Leftrightarrow S_{[i_1\cdots i_P]\ell_0}{\ell_1} = S'_{[i_1\cdots i_P]\ell_0}{\ell_1}.$

Let $LM = \{\gamma : S^1 \to M\}$ be the space of smooth loops on M. $T_{\gamma}LM = \{X_{\gamma} \in C^{\infty}(S^1, TM) : X_{\gamma}(\theta) \in T_{\gamma(\theta)}M\}$ is the set of smooth vector fields along γ .

We recall the definition of the Wodzicki-Chern-Simons class on LM [8]. For the metric h_{ρ} , set

$$K_{\nu\lambda_{1}\cdots\lambda_{2k+1}\kappa_{0}}^{\kappa_{0}'} = \bar{R}_{\lambda_{1}\kappa_{1}\nu}^{\kappa_{0}'}\bar{R}_{\lambda_{2}\lambda_{3}\kappa_{2}}^{\kappa_{1}}\bar{R}_{\lambda_{4}\lambda_{5}\kappa_{3}}^{\kappa_{2}}\cdots\bar{R}_{\lambda_{2k}\lambda_{2k+1}\kappa_{0}}^{\kappa_{k}} \in \Lambda^{2k+2}(M) \otimes \mathfrak{T}_{1}^{1}(M),$$

$$(17) \qquad K_{\nu\lambda_{1}\cdots\lambda_{2k+1}} = \operatorname{tr}(K_{\nu\lambda_{1}\cdots\lambda_{2k+1}\kappa_{0}}^{\kappa_{0}'}) = K_{\nu\lambda_{1}\cdots\lambda_{2k+1}\kappa_{0}}^{\kappa_{0}},$$

$$K_{\nu[\lambda_{1}\cdots\lambda_{2k+1}]} \in \Lambda^{1}(M) \otimes \Lambda^{2k+2}(M).$$

We define $CS^W \in \Omega^{2k+1}(LM)$ at the loop $\gamma \in LM$ by

(18)
$$CS^{W}(\gamma)(X_{\gamma,1},\cdots,X_{\gamma,2k+1}) = \int_{0}^{2\pi} K_{\nu[\lambda_{1}\cdots\lambda_{2k+1}]}(\gamma(\theta))\dot{\gamma}^{\nu}(\theta)X_{\gamma,1}^{\lambda_{1}}(\theta)\cdots X_{\gamma,2k+1}^{\lambda_{2k+1}}(\theta) \ d\theta.$$

Associated to a C^{∞} map $a: S^1 \times M \to M$ are: (i) $a^D: S^1 \to \operatorname{Maps}(M, M), a^D(\theta)(m) := a(\theta, m)$; (ii) $a^L: M \to LM, a^L(m)(\theta) := a(\theta, m)$. If ξ is regular, the action (11) has $a^L(m)$ equal to the loop γ_m which is the circle fiber containing m and starting at m. From now on, we use this action.

We want to compute $(a^L)^* CS^W \in \Omega^{2k+1}(M)$. We have

$$((a^L)^*CS^W)_m = (a^L)^*CS^W(\partial_{x^{i_1}}, \cdots, \partial_{x^{i_{2k+1}}})_m dx^{i_1} \wedge \cdots \wedge dx^{i_{2k+1}}.$$

In our case, a is rotation in the S^1 fiber, and

$$(a^{L})^{*}CS^{W}(\partial_{x^{i_{1}}},\cdots,\partial_{x^{i_{2k+1}}})_{m}$$

$$=\int_{0}^{2\pi}K_{\nu[\lambda_{1}\cdots\lambda_{2k+1}]}(a(\theta,m))\frac{d}{d\theta}\Big|_{\theta}a^{\nu}(\theta,m)(a^{L}_{*}(\partial_{x^{i_{1}}}|_{m}))^{\lambda_{1}}\cdots(a^{L}_{*}(\partial_{x^{i_{2k+1}}}|_{m}))^{\lambda_{2k+1}}d\theta$$

$$=\int_{0}^{2\pi}K_{\nu[\lambda_{1}\cdots\lambda_{2k+1}]}(a(\theta,m))\frac{\partial a^{\nu}}{\partial x^{j}}\Big|_{(\theta,m)}\xi^{j}|_{m}\frac{\partial a^{\lambda_{1}}}{\partial x^{i_{1}}}\Big|_{(\theta,m)}\cdots\frac{\partial a^{\lambda_{i_{2k+1}}}}{\partial x^{i_{2k+1}}}\Big|_{(\theta,m)}d\theta,$$

where $m = (x^1, \dots, x^{2k+1})$. In the last line, we use that a is an action, *i.e.*, $a(\theta + \psi, m) = a(\theta, a(\psi, m))$, to compute $(d/d\theta)a^{\nu}$.

For the action (11), $a^D: S^1 \to \text{Isom}(M, h)$, so by the tensorial nature of the curvature tensor, we have

$$K_{\nu\lambda_1\cdots\lambda_{2k+1}}(a(\theta,m))\frac{\partial a^{\nu}}{\partial x^j}|_{(\theta,m)}\xi^j|_m\frac{\partial a^{\lambda_1}}{\partial x^{i_1}}\Big|_{(m,\theta)}\cdots\frac{\partial a^{\lambda_{2k+1}}}{\partial x^{i_{2k+1}}}\Big|_{(m,\theta)}=K_{ji_1\cdots i_{2k+1}}\xi^j(m),$$

for all θ . Thus, we have

(19)
$$((a^L)^* CS^W)(m) = \left(\int_0^{2\pi} K_{j[i_1\cdots i_{2k+1}]}(m)\xi^j(m)d\theta\right) dx^{i_1} \wedge \cdots \wedge dx^{i_{2k+1}} \\ = K_{j[i_1\cdots i_{2k+1}]}(m)\xi^j(m)dx^{i_1} \wedge \cdots \wedge dx^{i_{2k+1}}.$$

As explained at the beginning of this section, our goal is to show that $((a^L)^*CS^W)(m) \neq 0$ for h_{ρ} . This follows from the following Proposition, where it is more convenient to use indices i_1, \dots, i_{4k+1} .

Proposition 5.1. Let
$$dim(M) = 4k + 1$$
. For $K_{j[i_1\cdots i_{4k+1}]}$ given by (17), we have
 $K_{j[i_1\cdots i_{4k+1}]}\xi^j = -(1+\rho^2)^2(a_{4k}\rho^{4k} + a_{4k-2}\rho^{4k-2}\cdots + a_0),$

for

$$a_{4k} = (-1)^k 4^k (4k+2) \cdot \eta_{[i_1} \phi_{i_2 i_3} \cdots \phi_{i_{4k} i_{4k+1}]}$$

= $(-1)^k 4^k (4k+2) \left(\eta \wedge (d\eta)^k\right)_{i_1 \cdots i_{4k+1}},$

in the notation of (15).

We postpone the proof for the moment. From now on, we write $\eta \wedge (d\eta)^k$ just as $\eta \wedge d\eta^k$.

Corollary 5.1. Let dim(M) = 4k + 1. For $m \in M$ and $\rho \gg 0$, $((a^L)^*CS^W)(m) \neq 0$ for the metric h_{ρ} .

Proof of Corollary 5.1. By Lem. 2.1, $a_{4k} \neq 0$. For $\rho \gg 0$, $K_{j[1\cdots 4k+1]}\xi^j \neq 0$ by Prop 5.1. It follows from (19) that $((a^L)^*CSW)(m) \neq 0$.

Using the Corollary, we can prove the main theorem:

Theorem 5.1. Let (M, g, ϕ, ξ, η) be (4k + 1)-dimensional closed regular Sasakian manifold, where $k \ge 1$. Then, there is a metric of the form $h_{\rho} = g + \rho^2 \eta \otimes \eta$ such that $|\pi_1(\text{Isom}(M, h_{\rho})| = \infty$ for $\rho \in \mathbb{R}, \rho \gg 0$. For $\rho \ne \rho', h_{\rho}$ and $h_{\rho'}$ are not isometric.

Proof of Theorem 5.1. By Cor. 5.1, $(a^L)^*CS^W$ for h_ρ is pointwise nonzero for $\rho \gg 0$. Since the rotation action (11) is an action by isometries for h_ρ (Cor. 4.1), then [8, Prop. 5.2] (as corrected in [7, Prop. 2.2]) implies that $\pi_1(\text{Isom}(M, h_\rho))$ is infinite for $\rho \gg 0$.

The curvature formula in Lem. 4.3 shows that h_{ρ} and $h_{\rho'}$ are not isometric for $\rho \gg 0$. \Box

The rest of the section is devoted to the proof of Prop. 5.1. As an outline, by (24), $K_{j[i_1\cdots i_{4k+1}]}\xi^j = -(1+\rho^2)\eta_{[i_1}(\operatorname{tr}(\operatorname{K1}))_{i_2\cdots i_{2k+1}]}$, where (K1) is defined in (22). By the notation defined in (25), (26), it suffices to prove (27). This is proven in Corollary 5.2(ii).

Proof of Proposition 5.1. We first work in an arbitrary odd dimension 2k + 1. Recall that

(20)
$$K_{ji_1\cdots i_{2k+1}\ell'_0}{}^{\ell_0}\xi^j = \bar{R}_{i_1\ell_1j}{}^{\ell_0}\bar{R}_{i_2i_3\ell_2}{}^{\ell_1}\bar{R}_{i_4i_5\ell_3}{}^{\ell_2}\cdots \bar{R}_{i_{2k}i_{2k+1}\ell'_0}{}^{\ell_k}\xi^j$$

(6) implies $\nabla_j \xi^k = \phi_j^k$ [2, p. 87], so

(21)
$$R_{kji}{}^{h}\xi^{i} = \nabla_{k}\nabla_{j}\xi^{h} - \nabla_{j}\nabla_{k}\xi^{h} = -(\nabla_{k}\phi_{j}{}^{h} - \nabla_{j}\phi_{k}{}^{h})$$
$$= -[(g_{kj}\xi^{h} - \eta_{j}\delta_{k}{}^{h}) - (g_{jk}\xi^{h} - \eta_{k}\delta_{j}{}^{h})]$$
$$= -(\eta_{k}\delta_{j}{}^{h} - \eta_{j}\delta_{k}{}^{h}).$$

By Lem. 4.3, we get

$$\bar{R}_{kji}{}^{h}\xi^{i} = R_{kji}{}^{h}\xi^{i} - \rho^{2}(\phi_{ki}\phi_{j}{}^{h} - \phi_{k}{}^{h}\phi_{ji} + 2\phi_{kj}\phi_{i}{}^{h} + 2\eta_{k}\eta_{i}\delta_{j}{}^{h} - 2\eta_{j}\eta_{i}\delta_{k}{}^{h} + g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h})\xi^{i} - \rho^{4}(\eta_{k}\eta_{i}\delta_{j}{}^{h} - \eta_{j}\eta_{i}\delta_{k}{}^{h})\xi^{i} = -(\eta_{k}\delta_{j}{}^{h} - \eta_{j}\delta_{k}{}^{h}) - 2\rho^{2}(\eta_{k}\delta_{j}{}^{h} - \eta_{j}\delta_{k}{}^{h}) - \rho^{4}(\eta_{k}\delta_{j}{}^{h} - \eta_{j}\delta_{k}{}^{h}) = -(1 + \rho^{2})^{2}(\eta_{k}\delta_{j}{}^{h} - \eta_{j}\delta_{k}{}^{h}),$$

where we use (21) for the ρ^0 term, (1) and (2) for the ρ^2 term, and (1) for the ρ^4 term. Then

$$K_{ji_{1}\cdots i_{2k+1}\ell'_{0}}{}^{\ell_{0}} = \xi^{j}R_{i_{1}\ell_{1}j}{}^{\ell_{0}}R_{i_{2}i_{3}\ell_{2}}{}^{\ell_{1}}R_{i_{4}i_{5}\ell_{3}}{}^{\ell_{2}}\cdots R_{i_{2k}i_{2k+1}\ell'_{0}}{}^{\ell_{k}}\xi^{j}$$

$$= -(1+\rho^{2})^{2}(\eta_{i_{1}}\delta_{\ell_{1}}{}^{\ell_{0}} - \eta_{\ell_{1}}\delta_{i_{1}}{}^{\ell_{0}})\bar{R}_{i_{2}i_{3}\ell_{2}}{}^{\ell_{1}}\bar{R}_{i_{4}i_{5}\ell_{3}}{}^{\ell_{2}}\cdots \bar{R}_{i_{2k}i_{2k+1}\ell'_{0}}{}^{\ell_{k}}$$

$$:= (K1)_{i_{1}\cdots i_{2k+1}\ell'_{0}}{}^{\ell_{0}} + (K2)_{i_{1}\cdots i_{2k+1}\ell'_{0}}{}^{\ell_{0}},$$

where

(22)
$$(K1)_{i_1\cdots i_{2k+1}\ell'_0}{}^{\ell_0} = -(1+\rho^2)^2 (\eta_{i_1}\delta_{\ell_1}{}^{\ell_0}) \bar{R}_{i_2i_3\ell_2}{}^{\ell_1} \bar{R}_{i_4i_5\ell_3}{}^{\ell_2}\cdots \bar{R}_{i_{2k}i_{2k+1}\ell'_0}{}^{\ell_k},$$

$$(K2)_{i_1\cdots i_{2k+1}\ell'_0}{}^{\ell_0} = (1+\rho^2)^2 (\eta_{\ell_1}\delta_{i_1}{}^{\ell_0}) \bar{R}_{i_2i_3\ell_2}{}^{\ell_1} \bar{R}_{i_4i_5\ell_3}{}^{\ell_2}\cdots \bar{R}_{i_{2k}i_{2k+1}\ell'_0}{}^{\ell_k}.$$

As in (16), we have

$$\operatorname{tr}(\mathrm{K1})_{i_{1}\cdots i_{2k+1}} = -(1+\rho^{2})^{2}\eta_{i_{1}}\bar{R}_{i_{2}i_{3}\ell_{2}}^{\ell_{1}}\bar{R}_{i_{4}i_{5}\ell_{3}}^{\ell_{2}}\cdots\bar{R}_{i_{2k}i_{2k+1}\ell_{1}}^{\ell_{k}}$$
$$\operatorname{tr}(\mathrm{K2})_{i_{1}\cdots i_{2k+1}} = (1+\rho^{2})^{2}(\eta_{\ell_{1}})\bar{R}_{i_{2}i_{3}\ell_{2}}^{\ell_{1}}\bar{R}_{i_{4}i_{5}\ell_{3}}^{\ell_{2}}\cdots\bar{R}_{i_{2k}i_{2k+1}i_{1}}^{\ell_{k}}$$

We continue the proof of Prop. 5.1 with a series of lemmas. Since the Proposition is concerned with the skew-symmetrization of $K \cdot \xi$, we consider the skew-symmetric parts of $tr(K1)_{i_1\cdots i_{2k+1}}$ and $tr(K2)_{i_1\cdots i_{2k+1}}$. The following proof is the first instance of our repeated use of the Bianchi identity.

Lemma 5.1.

$$(\mathrm{K1})_{j[i_{1}i_{2}\cdots i_{4k+1}]}\xi^{j} = -(1+\rho^{2})^{2}(\mathrm{K1})_{[i_{1}i_{2}\cdots i_{4k+1}]}\ell^{\ell} = -(1+\rho^{2})^{2}\eta_{[i_{1}}N_{i_{2}\cdots \cdots i_{4k+1}]}\ell^{\ell}$$
$$= -(1+\rho^{2})^{2}\sum_{a=1}^{4k+1}(-1)^{a}\eta_{i_{a}}N_{[i_{1}\cdots \hat{i}_{a}\cdots i_{4k+1}]}\ell^{\ell},$$

where \hat{i}_a means i_a is omitted. To get Proposition 5.1, it suffices to prove (27) $\operatorname{tr}(N)_{[i_2\cdots i_{4k+1}]} = N_{[i_2\cdots i_{4k+1}]\ell}{}^{\ell} = b_{4k}\rho^{4k} + \cdots + b_0,$

for
$$b_{4k} = (-1)^k 4^k (4k+2) (d\eta \wedge d\eta^k)_{i_2 \cdots i_{4k+1}}$$

We regroup $N_{i_2i_3\cdots i_{4k}i_{4k+1}\ell_0}^{\ell_1}$ as

where

(29) $A_{i_{4a-2}i_{4a-1}i_{4a}i_{4a+1}\ell_{2a+1}} \stackrel{\ell_{2a-1}}{:=} \bar{R}_{i_{4a-2}i_{4a-1}\ell_{2a}} \cdot \bar{R}_{i_{4a}i_{4a+1}\ell_{2a+1}} \stackrel{\ell_{2a}}{:}, a = 1, \dots, k,$ (with ℓ_{2k+1} replaced by ℓ_1 on the left hand side of (29) if a = k.)

We emphasize that this regrouping is not possible if dim(M) = 4k + 3.

By Lem. 4.3, we have

$$(30) \quad (R2)_{kji}{}^{h} = -\rho^{2}(\phi_{ki}\phi_{j}{}^{h} - \phi_{k}{}^{h}\phi_{ji} + 2\phi_{kj}\phi_{i}{}^{h} + 2\eta_{k}\eta_{i}\delta_{j}{}^{h} - 2\eta_{j}\eta_{i}\delta_{k}{}^{h} + g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h}),$$

$$(R3)_{kji}{}^{h} = \rho^{4}(\delta_{k}{}^{h}\eta_{j}\eta_{i} - \delta_{j}{}^{h}\eta_{i}\eta_{k}).$$

In the notation of (30) (and relaxing the sub/superscripts on A), we have

(31)
$$A_{i_{a}i_{a+1}i_{a+2}i_{a+3}\ell_{\beta}}{}^{\ell_{\alpha}} = \left[(\mathrm{R1})_{i_{a}i_{a+1}\ell_{\gamma}}{}^{\ell_{\alpha}} + (\mathrm{R2})_{i_{a}i_{a+1}\ell_{\gamma}}{}^{\ell_{\alpha}} + (\mathrm{R3})_{i_{a}i_{a+1}\ell_{\gamma}}{}^{\ell_{\alpha}} \right] \\ \cdot \left[(\mathrm{R1})_{i_{a+2}i_{a+3}\ell_{\beta}}{}^{\ell_{\gamma}} + (\mathrm{R2})_{i_{a+2}i_{a+3}\ell_{\beta}}{}^{\ell_{\gamma}} + (\mathrm{R3})_{i_{a+2}i_{a+3}\ell_{\beta}}{}^{\ell_{\gamma}} \right].$$

Thus, we will compute $(\text{RE})_{i_a i_{a+1} \ell_{\gamma}}^{\ell_{\alpha}} \otimes (\text{RF})_{i_{a+2} i_{a+3} \ell_{\beta}}^{\ell_{\gamma}}$ for E, F = 1, 2, 3. For ease of notation, we will just compute $(\text{RE})_{i_2 i_3 \ell_2}^{\ell_1} \otimes (\text{RF})_{i_4 i_5 \ell_3}^{\ell_2}$, as this easily extends to the general case.

The Bianchi identity extends to each component of the curvature tensor.

where *l.o.* denotes the lower order terms in ρ^{2a} , $2a \leq 4k-2$.

Lemma 5.4.

$$((R2-2) \otimes (R2-2))_{[i_{2}i_{3}i_{4}i_{5}]\ell_{3}}^{\ell_{1}} = 0.$$

Proof. A direct check gives

$$= 2(\eta_{i_{4}}(R2-1)_{i_{2}i_{3}i_{5}}{}^{\ell_{1}} - \eta_{i_{5}}(R2-1)_{i_{2}i_{3}i_{4}}{}^{\ell_{1}})\eta_{\ell_{3}},$$

 \mathbf{SO}

The term $\eta_{i_2}\eta_{i_5}\delta_{i_3}^{\ell_1}g_{i_4\ell_3}$ in (37) is symmetric in i_2, i_5 , so

$$= 4(\phi_{i_{2}\ell_{2}}\phi_{i_{3}}^{\ell_{1}} + \phi_{i_{2}i_{3}}\phi_{\ell_{2}}^{\ell_{1}}) \times (\phi_{i_{4}\ell_{3}}\phi_{i_{5}}^{\ell_{2}} + \phi_{i_{4}i_{5}}\phi_{\ell_{3}}^{\ell_{2}})$$

$$= 4(\phi_{i_{2}\ell_{2}}\phi_{i_{3}}^{\ell_{1}}\phi_{i_{4}\ell_{3}}\phi_{i_{5}}^{\ell_{2}} + \phi_{i_{2}\ell_{2}}\phi_{i_{3}}^{\ell_{1}}\phi_{i_{4}i_{5}}\phi_{\ell_{3}}^{\ell_{2}}$$

$$+ \phi_{i_{2}i_{3}}\phi_{\ell_{2}}^{\ell_{1}}\phi_{i_{4}\ell_{3}}\phi_{i_{5}}^{\ell_{2}} + \phi_{i_{2}i_{3}}\phi_{\ell_{2}}^{\ell_{1}}\phi_{i_{4}i_{5}}\phi_{\ell_{3}}^{\ell_{2}})$$

Since $\phi_{i_2\ell_2}\phi_{i_5}^{\ \ \ell_2}$ is symmetric in i_2, i_5 ,

which we will use to compute $(A' \wedge \ldots \wedge A')_{i_2 i_3 \cdots i_{4k} i_{4k+1}} \ell^{\ell}$ in (39). Since the wedge product involves skew-symmetrization, or modding out in our notation, we can relabel A' as

 $(40) \quad (A')_{i_2i_3i_4i_5\ell_3}{}^{\ell_1} := 4\phi_{i_2i_3}(B^*)_{i_4i_5\ell_3}{}^{\ell_1} := 4\phi_{i_2i_3}((B1)_{i_4i_5\ell_3}{}^{\ell_1} + (B2)_{i_4i_5\ell_3}{}^{\ell_1} + (B3)_{i_4i_5\ell_3}{}^{\ell_1}),$ where

$$(41) \quad (B^*)_{i_4i_5\ell_3}{}^{\ell_1} = (B1)_{i_4i_5\ell_3}{}^{\ell_1} + (B2)_{i_4i_5\ell_3}{}^{\ell_1} + (B3)_{i_4i_5\ell_3}{}^{\ell_1}, (B1)_{i_4i_5\ell_3}{}^{\ell_1} = -(\phi^{(2)})_{i_4\ell_3}\phi_{i_5}{}^{\ell_1}, \ (B2)_{i_4i_5\ell_3}{}^{\ell_1} = \phi_{i_4\ell_3}(\phi^{(2)})_{i_5}{}^{\ell_1}, \ (B3)_{i_4i_5\ell_3}{}^{\ell_1} = \phi_{i_4i_5}(\phi^{(2)})^{\ell_1}{}_{\ell_3}.$$

Here we introduce the notation

$$\begin{aligned} (\phi^{(2)})_k{}^h &:= \phi_k{}^{j_1}\phi_{j_1}{}^h = -\delta_k{}^h + \eta_k\xi^h, \ (\phi^{(3)})_k{}^h &:= \phi_k{}^{j_1}\phi_{j_1}{}^{j_2}\phi_{j_2}{}^h = -\phi_k{}^h, \\ (\phi^{(4)})_k{}^h &:= \phi_k{}^{j_1}\phi_{j_1}{}^{j_2}\phi_{j_2}{}^{j_3}\phi_{j_3}{}^h = \delta_k{}^h - \eta_k\xi^h = -(\phi^{(2)})_k{}^h. \end{aligned}$$

For

 $(42) \qquad (A')_{i_2\cdots i_9\ell_4}^{(2)}{}^{\ell_1} := (A')_{i_2i_3i_4i_5\ell_3}{}^{\ell_1} \times (A')_{i_6i_7i_8i_9\ell_4}{}^{\ell_3} = 4^2 \phi_{i_2i_3} \phi_{i_6i_7}(B^*)_{i_4i_5\ell_3}{}^{\ell_1} \times (B^*)_{i_8i_9\ell_4}{}^{\ell_3}$ we have:

Lemma 5.5.

$$(A')_{i_2\cdots i_9\ell_4}^{(2)}{}^{\ell_1} \sim -(4^2)\phi_{i_2i_3}\phi_{i_4i_5}\phi_{i_6i_7}B^*_{i_8i_9\ell_4}{}^{\ell_1} \mod(i_2\dots i_9)$$

Proof. We compute

$$(B1)_{i_4i_5\ell_3}{}^{\ell_1} \times (B1)_{i_8i_9\ell_4}{}^{\ell_3} = (\phi^{(2)})_{i_4\ell_3}\phi_{i_9}{}^{\ell_3}(\phi^{(2)})_{i_8\ell_4}\phi_{i_5}{}^{\ell_1} = -(\phi^{(3)})_{i_4i_9}(\phi^{(2)})_{i_8\ell_4}\phi_{i_5}{}^{\ell_1} \\ \sim \phi^{(3)}_{i_4i_5}\phi^{(2)}_{i_8\ell_4}\phi_{i_9}{}^{\ell_1} \sim -\phi_{i_4i_5}\phi^{(2)}_{i_8\ell_4}\phi_{i_9}{}^{\ell_1} \mod(i_4i_5i_8i_9), \\ (B1)_{i_4i_5\ell_3}{}^{\ell_1} \times (B2)_{i_8i_9\ell_4}{}^{\ell_2} = -(\phi^{(2)})_{i_4\ell_3}\phi_{i_5}{}^{\ell_1}\phi_{i_8\ell_4}(\phi^{(2)})_{i_9}{}^{\ell_3} = -(\phi^{(4)})_{i_4i_9}\phi_{i_5}{}^{\ell_1}\phi_{i_8\ell_4} \\ \sim 0 \mod(i_4i_5i_8i_9), \\ (B1)_{i_4i_5\ell_3}{}^{\ell_1} \times (B3)_{i_8i_9\ell_4}{}^{\ell_2} = -(\phi^{(2)})_{i_4\ell_3}\phi_{i_5}{}^{\ell_1}(\phi^{(2)}){}^{\ell_3}_{\ell_4}\phi_{i_8i_9} = -(\phi^{(4)})_{i_4\ell_4}\phi_{i_5}{}^{\ell_1}\phi_{i_8i_9} \\ \sim -(\phi^{(4)})_{i_8\ell_4}\phi_{i_9}{}^{\ell_1}\phi_{i_4i_5} \sim (\phi^{(2)})_{i_8\ell_4}\phi_{i_9}{}^{\ell_1}\phi_{i_4i_5} \mod(i_4i_5i_8i_9).$$

(For the second equation, note that $\phi_{i_4i_9}^{(4)} = g_{i_4i_9} - \eta_{i_4}\eta_{i_9}$ is symmetric in i_4, i_9 .) Thus, we have

Again using the symmetry of $(\phi^{(2)})_{i_a i_b}$, we have

$$(B2)_{i_4i_5\ell_3}{}^{\ell_1} \times (B1)_{i_8i_9\ell_4}{}^{\ell_2} = -\phi_{i_4\ell_3}(\phi^{(2)})_{i_5}{}^{\ell_1}(\phi^{(2)})_{i_8\ell_4}\phi_{i_9}{}^{\ell_3} = (\phi^{(2)})_{i_8\ell_4}(\phi^{(2)})_{i_4i_9}(\phi^{(2)})_{i_5}{}^{\ell_1} \\ \sim 0 \mod(i_4i_5i_8i_9),$$

$$(B2)_{i_4i_5\ell_3}{}^{\ell_1} \times (B2)_{i_8i_9\ell_4}{}^{\ell_2} = \phi_{i_4\ell_3}(\phi^{(2)})_{i_5}{}^{\ell_1}\phi_{i_8\ell_4}(\phi^{(2)})_{i_9}{}^{\ell_3} = -(\phi^{(3)})_{i_9i_4}(\phi^{(2)})_{i_5}{}^{\ell_1}\phi_{i_8\ell_4} = \phi_{i_9i_4}(\phi^{(2)})_{i_5}{}^{\ell_1}\phi_{i_8\ell_4} \\ \sim -\phi_{i_5i_4}(\phi^{(2)})_{i_9}{}^{\ell_1}\phi_{i_8\ell_4} \sim \phi_{i_4i_5}(\phi^{(2)})_{i_9}{}^{\ell_1}\phi_{i_8\ell_4} \mod(i_4i_5i_8i_9), \\ (B2)_{i_4i_5\ell_3}{}^{\ell_1} \times (B3)_{i_8i_9\ell_4}{}^{\ell_2} = \phi_{i_4\ell_3}(\phi^{(2)})_{i_5}{}^{\ell_1}\phi_{i_8i_9}(\phi^{(2)}){}^{\ell_3}_{\ell_4} = \phi_{i_8i_9}\phi_{i_4\ell_3}(\phi^{(2)}){}^{\ell_3}_{\ell_4}(\phi^{(2)})_{i_5}{}^{\ell_1} \\ = \phi_{i_8i_9}(\phi^{(3)})_{i_4\ell_4}(\phi^{(2)})_{i_5}{}^{\ell_1} \\ \sim \phi_{i_4i_5}(\phi^{(3)})_{i_8\ell_4}(\phi^{(2)})_{i_9}{}^{\ell_1} \sim -\phi_{i_4i_5}\phi_{i_8\ell_4}(\phi^{(2)})_{i_9}{}^{\ell_1} \mod(i_4i_5i_8i_9).$$

Therefore,

(44)
$$\sum_{E=1}^{3} (B2)_{i_4 i_5 \ell_3}^{\ell_1} \times (BE)_{i_8 i_9 \ell_4}^{\ell_3} \sim 0 \mod(i_4 i_5 i_8 i_9)$$

Finally, we compute

$$(B3)_{i_4i_5\ell_3}{}^{\ell_1} \times (B1)_{i_8i_9\ell_4}{}^{\ell_3} = \phi_{i_4i_5}(\phi^{(2)})^{\ell_1}{}_{\ell_3}(-(\phi^{(2)})_{i_8\ell_4})\phi_{i_9}{}^{\ell_3} = \phi_{i_4i_5}(\phi^{(3)})^{\ell_1}{}_{i_9}(\phi^{(2)})_{i_8\ell_4}$$
$$= \phi_{i_4i_5}(-\phi^{\ell_1}{}_{i_9})(\phi^{(2)})_{i_8\ell_4} = \phi_{i_4i_5}\phi_{i_9}{}^{\ell_1}(\phi^{(2)})_{i_8\ell_4}$$
$$\sim -\phi_{i_4i_5}\phi_{i_8}{}^{\ell_1}(\phi^{(2)})_{i_9\ell_4} \mod(i_4i_5i_8i_9),$$
$$(45) \quad (B3)_{i_4i_5\ell_3}{}^{\ell_1} \times (B2)_{i_8i_9\ell_4}{}^{\ell_3} = \phi_{i_4i_5}(\phi^{(2)})^{\ell_1}{}_{\ell_3}\phi_{i_8\ell_4}(\phi^{(2)})_{i_9}{}^{\ell_3} = \phi_{i_4i_5}\phi_{i_8\ell_4}(\phi^{(4)})^{\ell_1}{}_{i_9}$$
$$= -\phi_{i_4i_5}\phi_{i_8\ell_4}(\phi^{(2)})_{i_9}{}^{\ell_1},$$
$$(B3)_{i_4i_5\ell_3}{}^{\ell_1} \times (B3)_{i_8i_9\ell_4}{}^{\ell_3} = \phi_{i_4i_5}\phi_{i_8i_9}(\phi^{(2)})^{\ell_1}{}_{\ell_3}(\phi^{(2)})^{\ell_3}{}_{\ell_4} = \phi_{i_4i_5}\phi_{i_8i_9}(\phi^{(4)})^{\ell_1}{}_{\ell_4}$$
$$= -\phi_{i_4i_5}\phi_{i_8i_9}(\phi^{(2)})^{\ell_1}{}_{\ell_4}.$$

By (43), (44), (45), we have

$$(A')_{i_{2}\cdots i_{9}\ell_{4}}^{(2)}{}^{\ell_{1}} \sim \phi_{i_{2}i_{3}}\phi_{i_{6}i_{7}}\sum_{E=1}^{3} (B3)_{i_{4}i_{5}\ell_{3}}{}^{\ell_{1}} \times (BE)_{i_{8}i_{9}\ell_{4}}{}^{\ell_{3}} \mod(i_{2}\dots i_{9})$$
$$\sim -(4^{2})\phi_{i_{2}i_{3}}\phi_{i_{4}i_{5}}\phi_{i_{6}i_{7}}B^{*}_{i_{8}i_{9}\ell_{4}}{}^{\ell_{1}} \mod(i_{2}\dots i_{9}),$$

which proves Lemma 5.5.

Corollary 5.2. For $(A')_{i_2i_3i_4i_5\ell_3}{}^{\ell_1}$ in (40) and $(A')_{i_2\cdots i_9\ell_4}{}^{(2)}^{\ell_1}$ in (42), set $(A')_{i_2\cdots i_{4r+1}\ell_{r+2}}{}^{(r)}^{\ell_1} = (A')_{i_2\cdots i_{4r-3}\ell_{r+1}}{}^{(r-1)}^{\ell_1} (A')_{i_{4r-2}i_{4r-1}i_{4r}i_{4r+1}\ell_{r+2}}{}^{\ell_{k+1}},$

$$r = 2, \dots, k. \text{ Then } (i)$$

$$(A')_{i_{2}\dots i_{4r+1}\ell_{r+2}}^{(r)} \ell_{1} \sim (-1)^{r-1} 4^{r} \phi_{i_{2}i_{3}} \phi_{i_{4}i_{5}} \dots \phi_{i_{4r-2}i_{4r-1}} B^{*}_{i_{4r}i_{4r+1}\ell_{r+2}} \ell_{1} \mod(i_{2}\dots i_{4r+1})$$

$$; \quad (ii) \text{ In the notation of } (27),$$

$$\operatorname{tr}(N)_{[i_2\cdots i_{4k+1}]} = N_{[i_2\cdots i_{4k+1}]} \ell^{\ell} = (-1)^{k-1} 4^k (4k+2) \rho^{4k} (\phi \wedge \ldots \wedge \phi)_{i_2\cdots i_{4k+1}} + l.o.$$

Proof. (i) By Lemma 5.5, this follows by induction on r up to r = k, where dim(M) = 4k+1. (ii) By (27), (28), (39), (40),

(46)
$$\operatorname{tr}(N)_{[i_2\cdots i_{4k+1}]} = \rho^{4k} \operatorname{tr}(A')_{[i_2\cdots i_{4k+1}]}^{(k)} = \rho^{4k} (A')_{[i_2\cdots i_{4k+1}]\ell}^{(k)} \ell \\ \sim (-1)^{k-1} 4^k \rho^{4k} \phi_{[i_2i_3} \phi_{i_4i_5} \cdots \phi_{i_{4k-2}i_{4k-1}} B^*_{i_4k} i_{4k+1}]\ell \mod(i_2 \cdots i_{4k+1}).$$

By (41),

$$B_{ab\ell}^{*}{}^{\ell} = -(\phi^{(2)})_{a\ell}\phi_{b}{}^{\ell} + \phi_{a\ell}(\phi^{(2)})_{b}{}^{\ell} + \phi_{ab}(\phi^{(2)})_{\ell}{}^{\ell} = \phi_{ab} + \phi_{ab} + \phi_{ab}(\delta^{\ell}{}_{\ell} - \eta_{\ell}\xi^{\ell})$$

= $2\phi_{ab} + \phi_{ab}((4k+1)-1) = (4k+2)\phi_{ab},$

and plugging this into (46) finishes the proof.

This proves (27), and so finishes the proof of Prop. 5.1 and of Thm. 5.1

6. SASAKIAN SPACE FORMS

For the Sasakian space forms defined below, the computations are more explicit. We start with the case of the sphere S^{4k+1} with the standard metric g_{std} , and then treat the other Sasakian space forms.

As in Ex. 2.1, S^{4k+1} has the Hopf fibration

(47)
$$S^1 \to S^{4k+1} \to \mathbb{CP}^{2k}.$$

Let ξ be the unit vector field on S^{4k+1} tangent to the S^1 fiber, and let η be its dual 1-form. Then $(S^{4k+1}, g_{std}, \phi = \nabla \xi, \xi, \eta)$ is a Sasakian structure on S^{4k+1} .

We can refine Prop. 5.1 for S^{4k+1}

Proposition 6.1. Let $(S^{4k+1}, g_{std}, \phi, \xi, \eta)$ be as above. Then in the notation of Prop. 5.1 (48) $K_{i[i_1\cdots i_{4k+1}]}\xi^j = (1+\rho^2)^2 a_{4k}\rho^{4k},$

with

$$a_{4k} = (-1)^k 4^k (4k+2) (\eta \wedge d\eta^{2k})_{i_1 \cdots i_{4k+1}}$$

Assuming the Proposition, we obtain:

Theorem 6.1. Let S^{4k+1} be (4k+1)-dimensional sphere with the standard metric g_{std} . Then, we have

(49)
$$|\pi_1(\text{Isom}(S^{4k+1}, h_\rho))| = \infty$$

for the metric $h_{\rho} = g_{std} + \rho^2 \eta \otimes \eta, \ \rho \neq 0.$

Note the contrast to the standard metric at $\rho = 0$, where $\pi_1(\text{Isom}(S^{4k+1}, g_{std})) = \mathbb{Z}_2$.

The proof of the Theorem is almost the same as for Thm. 5.1: since $K_{j[i_1\cdots i_{4k+1}]}\xi^j \neq 0$ in (48) and the coefficients a_r of ρ^r in Prop. 5.1 vanish, $(a^L)^*CS^W \neq 0$ for any $\rho \neq 0$. Then we follow the proof of Thm. 5.1.

Prop. 6.1 will follow from the next Lemma.

Lemma 6.1. For (S^{4k+1}, h_{ρ}) , in the notation of (30) we have

(*i*)
$$((R1) \otimes (RE))_{[i_2 i_3 i_4 i_5]\ell_3} \ell_1 = 0;$$

(*ii*) $((RE) \otimes (R1))_{[i_2 i_3 i_4 i_5]\ell_3} \ell_1 = 0;$

for E = 1, 2, 3.

Proof. (i) (S^{4k+1}, g_{std}) has positive constant sectional curvature g(R(X, Y)Y, X) = 1, for $|X| = |Y| = 1, X \perp Y$, and curvature tensor

(50)
$$R_{kji}{}^{h} = \frac{c+3}{4} (g_{ki}\delta_{j}{}^{h} - g_{ji}\delta_{k}{}^{h}),$$

with c = 1 [5, I.V.2].

Noting that $(R1)_{kji}^{h} = R_{kji}^{h}$, we have

$$(\mathrm{R1})_{i_{2}i_{3}\ell_{2}}{}^{\ell_{1}} \times (\mathrm{RE})_{i_{4}i_{5}\ell_{3}}{}^{\ell_{2}} = \frac{c+3}{4} (g_{i_{2}\ell_{2}}\delta_{i_{3}}{}^{\ell_{1}} - g_{i_{3}\ell_{2}}\delta_{i_{2}}{}^{\ell_{1}}) \times (\mathrm{RE})_{i_{4}i_{5}\ell_{3}}{}^{\ell_{2}}$$
$$= \frac{c+3}{4} (\delta_{i_{3}}{}^{\ell_{1}}(\mathrm{RE})_{i_{4}i_{5}\ell_{3}i_{2}} - \delta_{i_{2}}{}^{\ell_{1}}(\mathrm{RE})_{i_{4}i_{5}\ell_{3}i_{3}}),$$

where $(\text{RE})_{kjih} = g_{\ell h} (\text{RE})_{kji}^{\ell}$.

Note that $(\text{RE})_{kjih} = -(\text{RE})_{kjhi}$: for $\bar{R}_{kjih} = -\bar{R}_{kjhi}$ for any ρ , and (R1), (R2), (R3) come with different powers of ρ , so each (RE) is skew-symmetric in i, h. Thus,

$$((\text{R1}) \otimes (\text{RE}))_{[i_2 i_3 i_4 i_5]\ell_3}{}^{\ell_1} = \frac{c+3}{4} (-\delta_{[i_3}{}^{\ell_1}(\text{RE})_{i_4 i_5 i_2]\ell_3} - \delta_{[i_2}{}^{\ell_1}(\text{RE})_{i_4 i_5 i_3]\ell_3})$$

where we skew-symmetrize over the *i* indices. Since $(\text{RE})_{[kii]}^{h} = 0$ by the Bianchi identity,

$$((R1) \otimes (RE))_{[i_2 i_3 i_4 i_5]\ell_3}{}^{\ell_1} = 0.$$

(ii) This is similar:

$$(\text{RE})_{i_{2}i_{3}\ell_{2}}{}^{\ell_{1}} \times (\text{R1})_{i_{4}i_{5}\ell_{3}}{}^{\ell_{2}} = (\text{RE})_{i_{2}i_{3}\ell_{2}}{}^{\ell_{1}} \times \frac{c+3}{4} (g_{i_{4}\ell_{3}}\delta_{i_{5}}{}^{\ell_{2}} - g_{i_{5}\ell_{3}}\delta_{i_{4}}{}^{\ell_{2}})$$
$$= \frac{c+3}{4} ((\text{RE})_{i_{2}i_{3}i_{5}}{}^{\ell_{1}}g_{i_{4}\ell_{3}} - (\text{RE})_{i_{2}i_{3}i_{4}}{}^{\ell_{1}}g_{i_{5}\ell_{3}}),$$

so again,

$$((\text{RE}) \otimes (\text{R1}))_{[i_2 i_3 i_4 i_5]\ell_3}{}^{\ell_1} = 0.$$

Proof of Prop. 6.1. By Lem. 5.3, (34), and Lem. 6.1, the lowest power of ρ in $K_{j[i_1\cdots i_{4k+1}]}\xi^j$ is ρ^{4k} .

We can generalize this result to Sasakian space forms. Recall that a Sasakian manifold (M, ϕ, ξ, η) is called a *Sasakian space form* if all the ϕ -sectional curvatures $K(X \wedge \phi X)$ are equal to a constant c, where X is a unit vector field orthogonal to ξ , $\{X, \phi X\}$ span a twoplane section of TM, and $K(X \wedge \phi X)$ denotes the sectional curvature. In this case, the Riemanian curvature tensor of M is given by

(51)
$$R_{kji}{}^{h} = \frac{c+3}{4} (g_{ji}\delta_{k}{}^{h} - g_{ki}\delta_{j}{}^{h}) + \frac{c-1}{4} (\eta_{i}\eta_{k}\delta_{j}{}^{h} - \eta_{j}\eta_{i}\delta_{k}{}^{h} + g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h} + \phi_{ji}\phi_{k}{}^{h} - \phi_{ki}\phi_{j}{}^{h} - 2\phi_{kj}\phi_{i}{}^{h})$$

[2, Thm. 7.19].

As with ordinary space forms, Sasakian space forms fall into three classes [2, Thm. 7.20], [9] depending on whether c > -3, c = -3, or c < -3. For dim(M) = 4k + 1, we have the following after scaling:

- c+3=4. M is locally isometric to (4k+1)-dimensional sphere of constant sectional curvature 1.
- c+3 = 0. *M* is locally isometric to the Heisenberg nilpotent Lie group $N = \mathbb{R}^{4k} \times \mathbb{R}$, with $g = \frac{1}{4} \sum_{i=1}^{2k} \left((dx^i)^2 + (dy^i)^2 \right) + \eta \otimes \eta$, with $\eta = \frac{1}{2} \left(dx^{4k+1} \sum_{i=1}^{2k} y^i dx^i \right)$.
- c+3 = -1. *M* is locally isometric to $\overline{B} = B \times \mathbb{R}$, where (B, J, G) is a simply connected bounded domain in \mathbb{C}^n with Kähler structure *J* and metric *G*, the curvature of *G* equals $\Omega = d\omega$, and $\eta = \pi^* \omega + dt$, $g = \pi^* G + \eta \otimes \eta$ on \overline{B} for the projection $\pi : \overline{B} \to B$.

Let (M, g, ϕ, ξ, η) be a (4k+1)-dimensional Sasakian space form. Its curvature tensor (51) can be rewritten as

$$R_{kji}{}^{h} = \frac{c+3}{4} (g_{ji}\delta_{k}{}^{h} - g_{ki}\delta_{j}{}^{h}) - \frac{c-1}{4} (\phi_{ki}\phi_{j}{}^{h} - \phi_{ji}\phi_{k}{}^{h} + 2\phi_{kj}\phi_{i}{}^{h} + 2\eta_{i}\eta_{k}\delta_{j}{}^{h} - 2\eta_{j}\eta_{i}\delta_{k}{}^{h} + g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h}) + \frac{c-1}{4} (3\eta_{i}\eta_{k}\delta_{j}{}^{h} - 3\eta_{j}\eta_{i}\delta_{k}{}^{h} + 2g_{ki}\eta_{j}\xi^{h} - 2g_{ij}\eta_{k}\xi^{h}) = (S1)_{kji}{}^{h} + (S2)_{kji}{}^{h} + (S3)_{kji}{}^{h},$$

where

$$(S1)_{kji}{}^{h} = \frac{c+3}{4} (g_{ji}\delta_{k}{}^{h} - g_{ki}\delta_{j}{}^{h}),$$

$$(S2)_{kji}{}^{h} = -\frac{c-1}{4} (\phi_{ki}\phi_{j}{}^{h} - \phi_{ji}\phi_{k}{}^{h} + 2\phi_{kj}\phi_{i}{}^{h} + 2\eta_{i}\eta_{k}\delta_{j}{}^{h} - 2\eta_{j}\eta_{i}\delta_{k}{}^{h} + g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h}),$$

$$(S3)_{kji}{}^{h} = \frac{c-1}{4} (3\eta_{i}\eta_{k}\delta_{j}{}^{h} - 3\eta_{j}\eta_{i}\delta_{k}{}^{h} + 2g_{ki}\eta_{j}\xi^{h} - 2g_{ij}\eta_{k}\xi^{h}).$$

Lemma 6.2.

$$(S\alpha)_{i_{2}i_{3}\ell_{2}}{}^{\ell_{1}} \times (RE)_{i_{4}i_{5}\ell_{3}}{}^{\ell_{2}} \sim 0, \quad (RE)_{i_{2}i_{3}\ell_{2}}{}^{\ell_{1}} \times (S\alpha)_{i_{4}i_{5}\ell_{3}}{}^{\ell_{2}} \sim 0,$$

for $\alpha = 1, E = 1, 2, 3, and for E = 3, \alpha = 1, 2, 3.$

Proof. For $\alpha = 1$, (S1) = (R1), so the proof of Lem. 6.1 carries over. For E = 3, each term in $(S3)_{kji}{}^{h}$ contains either two η 's or an $\eta\xi$ pair, so these terms are similar to 0.

We note that

$$\bar{R}_{kji}{}^{h}(\mathrm{R1})_{kji}{}^{h} + (\mathrm{S2'})_{kji}{}^{h} + (\mathrm{S3})_{kji}{}^{h} + (\mathrm{R3})_{kji}{}^{h},$$

where

$$(S2')_{kji}{}^{h} = -\left(\frac{c-1}{4} + \rho^{2}\right)\left(\phi_{ki}\phi_{j}{}^{h} - \phi_{ji}\phi_{k}{}^{h} + 2\phi_{kj}\phi_{i}{}^{h} + 2\eta_{i}\eta_{k}\delta_{j}^{h} - 2\eta_{j}\eta_{i}\delta_{k}{}^{h} + g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h}\right).$$

Thus up to a scale factor $(S2')_{kji}{}^{h} = (R2)_{kji}{}^{h}$ by (30). We can repeat the proof of Prop. 5.1 by replacing the power $\rho^{4k} = (\rho^2)^{2k}$ in Prop. 5.1 with $\frac{c-1}{4} + \rho^2$. We obtain:

Proposition 6.2. Let $(M, g_0, \phi, \xi, \eta)$ be a Sasakian space form as above. Then in the notation of Prop. 5.1

$$K_{j[i_1\cdots i_{4k+1}]}\xi^j = (1+\rho^2)^2 a_{4k} \left(\frac{c-1}{4}+\rho^2\right)^{2k},$$

with

$$a_{4k} = (-1)^k 4k(4k+2)(\eta \wedge d\eta^{2k})_{i_1 \cdots i_{4k+1}}$$

As before, we conclude the following:

Theorem 6.2. Let (M, g, ϕ, ξ, η) be (4k + 1)-dimensional closed orientable Sasakian space form. Then $|\pi_1(\text{Isom}(M, g_\rho))| = \infty$ for (i) $c + 3 > 4, \rho \neq 0$, (ii) $c + 3 = 0, \rho \neq \pm 1$, or (iii) $c + 3 < 0, \rho^2 \neq -\frac{c-1}{4}$.

Remark 6.1. It follows from [1, Note 7.5] that $|\pi(\text{Isom}(M, g_0))| = \infty$ for the Heisenberg infra-nilmanifold $M = N/\Gamma$ (*i.e.*, a Sasakian space form with c + 3 = 0). This follows also from our result.

7. Strict contact diffeomorhisms of S^{4k+1}

We consider again the sphere S^{4k+1} with the standard metric g_{std} , and Sasakian structure $(g_{st}, \phi, \eta, \xi)$. The Reeb vector field ξ of the Hopf fibering

$$\pi: S^1 \to S^{4k+1} \to \mathbb{CP}^{2k}$$

is the unit tangent vector field along the S^1 fiber. It generates not only an S^1 -action via isometries of g_{std} , but also an S^1 -action of strict contact diffeomorphisms of S^{4k+1} as a contact manifold. Here, we recall that a diffeormorphism ϕ of S^{4k+1} is strictly contact if $\phi^*\eta = \eta$. We denote the group of strict contact diffeomorphisms of (S^{4k+1}, η) by $\text{Diff}_{\eta,str}(S^{4k+1}, \eta)$. We note that this group is infinite dimensional.

Then we have the following:

Theorem 7.1.

$$|\pi_1(\operatorname{Diff}_{\eta,str}(S^{4k+1},\eta))| = \infty.$$

The proof is similar to those in other sections, and will be given below. As in §4, we take the family of metrics $h = g_{\rho}$ defined by $h_{ij} = g_{ij} + \rho^2 \eta_i \eta_j$ for $g = g_{std}$. We can explicitly compute the integrand $K_{\nu[\lambda_1 \lambda_2 \dots \lambda_{4k+1}]}$ in the definition of CS^W (18).

Proposition 7.1.

$$K_{\nu[\lambda_1\lambda_2\cdots\lambda_{4k+1}]} = C\rho^{4k}g_{\nu[\lambda_1}((d\eta)^{2k})_{\lambda_1\lambda_2\cdots\lambda_{4k+1}]},$$

for some nonzero constant C.

The proof of Prop. 7.1 is given after the next two Lemmas.

Recall that

$$K_{\nu\lambda_1\lambda_2\cdots\lambda_{4k+1}} = \bar{R}_{\lambda_1\kappa_1\nu}{}^{\kappa_0}\bar{R}_{\lambda_2\lambda_3\kappa_2}{}^{\kappa_1}\cdots\bar{R}_{\lambda_{4k}\lambda_{4k+1}\kappa_0}{}^{\kappa_{2k}}$$

Using (14) and (50), we have n

$$\bar{R}^{h}_{kji} = (\text{CR1})_{kji}{}^{h} - \rho^{2}(\text{CR2})_{kji}{}^{h} - \rho^{2}(\text{CR3})_{kji}{}^{h} - (\rho^{2} + \rho^{4})(\text{CR4})_{kji}{}^{h},$$

where

$$(CR1)_{kji}{}^{h} = g_{ji}\delta^{h}_{k} - g_{ki}\delta^{h}_{j}, \ (CR2)_{kji}{}^{h} = \phi_{ki}\phi_{j}{}^{h} - \phi_{k}{}^{h} + 2\phi_{ki}\phi_{i}{}^{h}, (CR3)_{kji}{}^{h} = g_{ki}\eta_{j}\xi^{h} - g_{ji}\eta_{k}\xi^{h}, \ (CR4)_{kji}{}^{h} = \eta_{k}\eta_{j}\delta_{j}{}^{h} - \eta_{j}\eta_{i}\delta_{k}{}^{h}.$$

Lemma 7.1.

$$(CR1)_{i_1\kappa_{1j}}{}^{\kappa_0} \times \bar{R}_{i_2i_3\kappa_2}{}^{\kappa_1} \cdots \bar{R}_{i_{4k}i_{4k+1}\kappa_0}{}^{\kappa_{2k}} \sim -g_{i_1j}\bar{R}_{i_2i_3\kappa_1}{}^{\kappa_0} \cdots \bar{R}_{i_{4k}i_{4k+1}\kappa_0}{}^{\kappa_{2k}} \mod(i_1i_2i_3).$$

Proof.

$$(\operatorname{CR1})_{i_{1}\kappa_{1j}}{}^{\kappa_{0}} \times \bar{R}_{i_{2}i_{3}\kappa_{2}}{}^{\kappa_{1}} \cdots \bar{R}_{i_{4k}i_{4k+1}\kappa_{0}}{}^{\kappa_{2k}} = (g_{\kappa_{1j}}\delta_{i_{1}}{}^{\kappa_{0}} - g_{i_{1j}}\delta_{\kappa_{1}}{}^{\kappa_{0}})\bar{R}_{i_{2}i_{3}\kappa_{2}}{}^{\kappa_{1}} \cdots \bar{R}_{i_{4k}i_{4k+1}\kappa_{0}}{}^{\kappa_{2k}} = \bar{R}_{i_{2}i_{3}\kappa_{2}}{}^{\kappa_{1}} \cdots \bar{R}_{i_{4k}i_{4k+1}i_{1}}{}^{\kappa_{2k}} - g_{i_{1j}}\bar{R}_{i_{2}i_{3}\kappa_{2}}{}^{\kappa_{0}} \cdots \bar{R}_{i_{4k}i_{4k+1}\kappa_{0}}{}^{\kappa_{2k}} \sim -g_{i_{1j}}\bar{R}_{i_{2}i_{3}\kappa_{2}}{}^{\kappa_{0}} \cdots \bar{R}_{i_{4k}i_{4k+1}\kappa_{0}}{}^{\kappa_{2k}},$$

because $\bar{R}_{[i_{4k}i_{4k+1}i_1]}{}^{\kappa_{2k}} = 0.$

Set

$$T_{ji_1i_2\cdots i_{4k+1}} = \bar{R}_{i_2i_3\kappa_2}{}^{\kappa_0} \bar{R}_{i_4i_5\kappa_3}{}^{\kappa_2} \cdots \bar{R}_{i_{4k}i_{4k+1}\kappa_0}{}^{\kappa_{2k}}$$

By Lemma 7.1, we have

$$K_{j[i_1i_2\cdots i_{4k+1}]} = -g_{j[i_1}T_{i_2i_3\cdots i_{4k+1}]}$$

Many terms in $T_{ji_1i_2\cdots i_{4k+1}}$ vanish by direct computations as in Lemmas 5.4, 6.2.

Lemma 7.2.

 $(CRE)_{i_2i_3j_1}^{j_0'} \times (CRF)_{i_4i_5j_2}^{j_1} \sim 0 \quad mod(i_1i_2i_3i_4),$ for $E, F \in \{1, 2, 3, 4\}, (E, F) \neq (2, 2).$

Proof of Prop. 7.1. We have

$$T_{ji_{1}i_{2}\cdots i_{4k+1}} \sim \rho^{4k} (\text{CR2})_{i_{2}i_{3}j_{2}}{}^{j_{0}} (\text{CR2})_{i_{2}i_{3}j_{2}}{}^{j_{0}} \cdots (\text{CR2})_{i_{4k}i_{4k+1}j_{0}}{}^{j_{2k}} \mod(i_{1}\cdots i_{4k+1}).$$

As in §5, there is a nonzero constant C such that
$$T_{j[i_{1}i_{2}\cdots i_{4k+1}]} = C\rho^{4k} ((d\eta)^{2k})_{i_{2}i_{3}\cdots i_{4k+1}}$$

$$\Gamma_{j[i_1i_2\cdots i_{4k+1}]} = C\rho^{4k}((d\eta)^{2k})_{i_2i_3\cdots i_{4k+1}}$$

Proof of Thm. 7.1. By Proposition 7.1, $K_{j[i_1i_2\cdots i_{4k+1}]}\xi^j$ is given explicitly in terms of η and $d\eta$ (see Prop. 5.1). Thus, $K_{j[i_1i_2\cdots i_{4k+1}]}\xi^j$ is invariant under strict contact diffeomorphisms. For the S¹-action of the Reeb vector field ξ , the proof of Thm. 5.1 can be directly adapted to $\operatorname{Diff}_{n.str}(S^{4k+1})$.

Remark 7.1. (i) By a slight modification of these computations, Thm. 7.1 can be easily extended to the Sasakian space forms of §6.

(ii) Thm. 7.1 has been obtained in [3, Cor. 7], with for S^{4k+1} generalized to a closed contact manifold M with closed Reeb orbits. While both approaches prove the same element $[a^D] \in \pi_1(\text{Diff}_{\eta,str}(M))$ has infinite order, [3] uses the map $a^D : S^1 \to \text{Diff}_{\eta,str}(M)$ to pull back characteristic classes from $B\text{Diff}_{\eta,str}(M)$ to BS^1 . In contrast, we use the equivalent map $a^L: M \to LM, a^L(m)(\theta) = a^D(\theta)(m)$, to pull back a (nonclosed) Chern-Simons form from LM to M. It would be interesting to understand the relationship between these approaches better. In [6], we reprove [3, Cor. 7] using our approach.
