High-Rank Irreducible Cartesian Tensor Decomposition and Bases of Equivariant Spaces

Abstract

Irreducible Cartesian tensors (ICTs) play a crucial role in the design of equivariant graph neural networks, as well as in theoretical chemistry and chemical physics. Meanwhile, the design space of available linear operations on tensors that preserve symmetry presents a significant challenge. The ICT decomposition and a basis of this equivariant space are difficult to obtain for high-order tensors. After decades of research, we recently achieve an explicit ICT decomposition for n = 5 (Bonvicini, 2024) with factorial time/space complexity. This work, for the first time, obtains decomposition matrices for ICTs up to rank n=9 with reduced and affordable complexity, by constructing what we call path matrices. The path matrices are obtained via performing chain-like contraction with Clebsch-Gordan matrices following the parentage scheme. We prove and leverage that the concatenation of path matrices is an orthonormal change-of-basis matrix between the Cartesian tensor product space and the spherical direct sum spaces. Furthermore, we identify a complete orthogonal basis for the equivariant space, rather than a spanning set (Pearce-Crump, 2023b), through this path matrices technique. We further extend our result to the arbitrary tensor product and direct sum spaces, enabling free design between different spaces while keeping symmetry. The Python code is available in https://github.com/ShihaoShao-GH/ICT-decompositionand-equivariant-bases where the $n = 6, \ldots, 9$ ICT decomposition matrices are obtained in 1s, 3s, 11s, and 4m32s, respectively.

1 Introduction

The deployment of equivariant neural networks in physics, chemistry, and robotics often requires certain equivariance or invariance to effectively incorporate inductive bias. Equivariant Graph Neural Networks (EGNNs) are well-suited for this purpose, as they can maintain equivariance while processing features within the graph (Zaverkin et al., 2024; Simeon and De Fabritiis, 2024; Batzner et al., 2022). One of the most promising approach to constructing equivariant layers involves leveraging irreducible representations. Depending on the basis of the space, two distinct types of irreducible representations are utilized in different EGNNs: spherical (spherical tensors) (Musaelian et al., 2023; Batatia et al., 2022) and Cartesian irreducible representations (Irreducible Cartesian Tensors, ICTs) (Zaverkin et al., 2024; Schütt et al., 2021) for O(3). Spherical tensors serve as the starting point for EGNN based on irreducible representations. However, they require Clebsch-Gordan transforms with significant computational overhead to derive desired irreducible representations from existing ones during each inference, making them computationally intensive. In contrast, ICTs are more efficient, as high-order representations can be easily computed using tensor products (specifically, outer products in EGNNs), making them more computationally friendly for most deep learning frameworks. The ICTs are obtained through the ICT decomposition matrices H,

$$\operatorname{vec}\left(T^{(n;j;q)}\right) = H^{(n;j;q)}\operatorname{vec}\left(T^{(n)}\right),\tag{1}$$

where $T^{(n;j;q)}$ is an ICT, vec is the vectorization operation via flattening the tensor, $T^{(n)}$ is a given tensor, n represents the rank of the tensor, and j is called the weight (the order of irreducible representations, which is distinct from the learnable weights in neural networks) of the irreducible representation, and q denotes the label (since the multiplicity for given n and j is sometimes greater than 1). The decomposition matrices $H^{(n;j;q)}$ should be constructed such that $T^{(n;j;q)}$ are irreducible. A formal definition is introduced in Section 3.1. The challenge lies in the fact that H of rank n > 5 are unknown. The recent development of EGNNs research benefits from the irreducible decomposition matrices H obtained from the physics and chemistry communities. The decomposition matrices for n = 4 have been established by Andrews and Ghoul (1982). However, only very recently have we obtained the decomposition matrices for n = 5 (Bonvicini, 2024). Due to these limitations, state-of-the-art EGNNs cannot freely manipulate high-order ICTs or can only manipulate those whose weight equals their rank (Zaverkin et al., 2024).

It has been shown that l=8 irreducible representations can greatly benefit the model, but under the spherical basis (Liao et al., 2023). Therefore, the matrices for high-order orthogonal ICT decomposition are of great importance. Meanwhile, another crucial question is which linear operations applied to the Cartesian tensors are equivariant, as these operations constitute the design space of EGNNs, in other words, what is the vector space of linear mappings f such that

$$\rho(g)f(\text{vec}(T)) = f(\rho(g)\text{vec}(T)) \tag{2}$$

where $g \in G$, and ρ is the matrix representation. This vector space is called an equivariant space, also denoted as $\operatorname{End}_G\left(\left(\mathbb{R}^3\right)^{\otimes n}\right)$. More generally, for different input and output

spaces, this equivariant space can be denoted as $\operatorname{Hom}_G\left(\left(\mathbb{R}^3\right)^{\otimes l},\left(\mathbb{R}^3\right)^{\otimes k}\right)$. Pearce-Crump (2023b) leverages Brauer (1937)'s theorem to find the spanning set of the equivariant space. However, as the rank increases, the number of elements in the spanning set becomes greater than the dimension of the space. Thus, it is also essential to identify a basis to reduce the number of parameters required.

In this work, one of our contributions is to efficiently obtain ICT decomposition matrices for 6 < n < 9. Several previous methods (Andrews and Ghoul, 1982; Dinckal, 2013; Bonvicini, 2024) rely on evaluating the full permutation of n (e.g., fundamental isotropic Cartesian tensors) and 2n (e.g., natural projection tensors) indices, which requires factorial complexity, making it impractical for application to high-rank tensors. Bonvicini (2024) proposes a novel method to automate the procedure but does not reduce the complexity. The Reduced Row Echelon Form (RREF) algorithm is also required to run on an $n! \times n!$ matrix. Instead, we leverage the fact that the Cartesian tensor product space is equivalent to a direct product of spherical spaces, up to a change of basis. In spherical space, it is straightforward to identify the desired irreducible representations, as they are diagonalized; then, the inverted change of basis can bring us back to Cartesian space. The challenge lies in finding such a change-of-basis matrix. We prove that one can construct this matrix by concatenating the results of sequential contractions and the outer products of Clebsch-Gordan matrices (CG matrices) according to the parentage scheme (Coope et al., 1965), which we refer to as path matrices. The change-of-basis matrix converts Cartesian tensors to the direct sum of spherical tensors.

If we treat tensors as vectors, we find that different spherical vectors are separated as distinct elements of the full-length vector. Thus, we can multiply it by a diagonalized matrix with only zeros and ones on the diagonals. This operation eliminates the other spherical vectors and retains only the desired one. The inverted change of basis can then convert the spherical direct product space back to the Cartesian tensor product space. The product of these three matrices forms the decomposition matrix, which decomposes the Cartesian tensor into the desired ICTs. This approach takes less than one second on CPUs to compute cases for n=6, which is already faster than the current decomposition for n=5. We also show that this process can be further accelerated. Specifically, we prove that path matrices have orthonormal columns up to multiplicative factors, which we leverage to demonstrate that a specific decomposition matrix can be generated via the product of the path matrix and its transpose.

Another challenge this work addresses is the construction of bases for the equivariant spaces. With the support of Schur's lemma, we prove that the bases are formed by matrices that: 1) decompose a vector into its ICT, and 2) map an ICT to another ICT in an isomorphic space (i.e., with the same weight). These matrices are easy to construct in the spherical direct sum space, as their elements lie on the diagonal. Then, our path matrices can change the basis from the spherical space to the Cartesian tensor product space. We further extend our conclusions to linear equivariant operations between different direct sum and tensor product spaces. Additionally, we demonstrate the capability to construct bases for such general equivariant spaces, including spherical tensor product spaces with different parities. This enables the efficient construction of equivariant layers between different spaces, thereby expanding the design space of EGNNs.

Table 1: Comparison with previous works. The complexity is discussed in terms of rank. The complexity of this work will be polynomial if we focus on the dimensions.

This work has four main contributions:

- We propose a method to efficiently calculate high-rank ICT decomposition matrices and, for the first time, obtain the decomposition matrices for $6 \le n \le 9$, compared to predecessors, as shown in Table 1.
- We propose a general parentage scheme to extend ICT decomposition into a generalized ICT decomposition applicable to arbitrary tensor product spaces.
- We characterize the bases of equivariant spaces and propose a method to efficiently obtain these bases, overcoming the redundancy in Pearce-Crump (2023b)'s method.
- We extend our approach to efficiently obtain bases for equivariant spaces operating between different spaces.

These contributions enable EGNNs to process high-rank ICTs and flexibly design equivariant layers between desired spaces. Furthermore, this work benefits the physics and chemistry communities by facilitating theoretical analysis based on high-rank ICTs.




Figure 1: The mind map of our method. The blocks in orange color are aligned with the three contributions of this work.

The following contents are organized as follows. In Section 1, we recall some basic ideas of representation theory, spherical harmonics, tensors, tensor product spaces, and we also introduce the Clebsch-Gordan coefficients and the parentage scheme. In Section 3, we formulate our problems: obtaining high-order ICT decomposition matrices and bases for arbitrary tensor product spaces. In Section 4, we introduce our theory and method to obtain high-order ICT decomposition matrices. In Section 5, we present the theory and method to obtain bases of equivariant spaces where the input and output spaces are the same. In Section 6, we extend the theory to the equivariant design spaces where the input and output spaces are different, and show the method to obtain bases for such general spaces. In Section 7, we review related works on designing EGNNs and calculating ICT decomposition matrices. In Section 8, we discuss the relation between Pearce-Crump (2023b) and this work, as well as the theory for SO(n), O(n), and SU(n). We provide concluding remarks in Section 9, and discuss the potential social impact in Section 10. We introduce the reproducibility details in Section 11. The acknowledgments are presented after the main text. The visualizations are

shown in the appendix. A list of mathematical symbols is provided in Table 2, and a mind map of this work is shown in Figure 1.

2 Preliminaries

2.1 Clebsch-Gordan coefficients

A review on irreducible representations and spherical spaces is in the appendix. The term weights in this paper refer to the order of irreducible representations. An important tool utilized in our work is the Clebsch-Gordan coefficients (CG coefficients). They are real numbers, and describe how to couple vectors from two spherical spaces into a new one. There are some rules for this coupling. First, given two vectors in weights l_1 and l_2 spherical spaces, the weights of the resulting vectors can only lie in $|l_1 - l_2| \leq l_o \leq l_1 + l_2$. For each index m_o of the obtained vector $v_{l_o} \in (l = l_o)$, it is calculated by homogeneous quadratic polynomials. Specifically, we have

$$v_{m_o}^{(l_o)} = \sum_{m_o = m_1 + m_2} C_{m_1 m_2 m_o}^{l_1 l_2 l_o} v_{m_1}^{(l_1)} v_{m_2}^{(l_2)}, \tag{3}$$

and if we consider O(n) instead of SO(n), parity p should also be considered. The parity is a property additional to the rank and weight, being 1 or -1. Having -1 parity means that the representation will be inverse when the space is inverse, and *vice versa*. For example, the natural representations of O(n) always have p = -1. We will introduce the case that p = 1 in the next section. Taking the parity into consideration, we can guarantee O(n) equivariance, and equation (3) becomes

$$v_{m_o}^{(l_o;p_o)} = \mathbb{1}_{(p_o = p_1 p_2)} \sum_{m_o = m_1 + m_2} C_{m_1 m_2 m_o}^{l_1 l_2 l_o} v_{m_1}^{(l_1;p_1)} v_{m_2}^{(l_2;p_2)},$$

where $\mathbb{1}_{(exp)}$ is the indicator function, outputting 1 if exp holds true, or 0 otherwise. Our discussion will be the same no matter we consider O(n) or SO(n). But since Section 6, we need to take care of the parity which will play some roles in the further discussion. The CG coefficients are highly sparse, since $C_{m_1m_2m_o}^{l_1l_2l_o} = 0$ if $m_o \neq m_1 + m_2$. The coefficients are identical to Wigner-3j symbols up to multiplicative factors, so we will adopt Wigner-3j for the implementation. The evaluation of CG coefficients is nearly $\mathcal{O}(1)$ (if we do not consider the few calculations for the closed-form formula, which is cheap enough). To obtain the coefficients of O(3)/SO(3), one often leverages the relation between SU(2) and SO(3): SU(2) is a double cover of SO(3), so the CG matrices of SU(2) and SO(3) are same up to a change-of-basis, from complex to real. The closed-form formulae for SU(2) CG coefficients are already known. Thus, this process can be efficiently evaluated without obvious overhead.

2.2 Tensors and tensor product spaces

To formally define a tensor, we need to consider vector space V and covector space V^* . A tensor product is a bilinear map $\otimes : \mathcal{S} \times \mathcal{S}' \to \mathcal{S} \otimes \mathcal{S}'$. The basis of $\mathcal{S} \otimes \mathcal{S}'$ is the set of $\hat{x}_i \otimes \hat{y}_j \in \mathcal{S} \otimes \mathcal{S}'$, where \hat{x}_i and \hat{y}_j are basis vectors of \mathcal{S} and \mathcal{S}' , respectively. That is why one implements outer product as tensor product, as it meets the definition of tensor product. A tensor $T: V^{\otimes r} \otimes V^{*\otimes s} \to F$, where F is some field, is a mathematical object that converts things between different tensor product spaces. For example, the representation $\rho(g)$ is a (r = 1, s = 1)-tensor that receives a vector v which is a (r = 1, s = 0)-tensor, and output another (r = 1, s = 0)-tensor $\rho(g)v$, as r and s vanish correspondingly. Tensor

product can help us build up the ranks of tensors, e.g., $V \otimes V \otimes V$ is a (r=3,s=0) space. The representation space is accordingly (r=3,s=3). Conversely, contraction can reduce the ranks of tensors. We express these operations via some index notations. For example, $T_{i_1i_2} = T'_{i_1}T''_{i_2}$ is a tensor product, and $T_{i_1} = \sum_{j_1} T'_{i_1j_1}T''_{j_1}$ is a contraction. Obviously, such operations can be mixed together, and we often omit the index of the output tensors and agree i_k will be placed at the kth index of the output tensor by default. We also agree that j_1 and j_2 will vanish due to the contraction. We will not use Einstein summation convention in this work to keep the conventions of machine learning community, and to avoid ambiguous during derivations. One should note that contractions can be expressed in term of matrix representation. Consider $T = \sum_{j_1,j_2} T'_{i_1j_1j_2} T''_{j_1j_2}$, we have

$$\begin{bmatrix} T_1 \\ T_2 \end{bmatrix} = \begin{bmatrix} T'_{111} & T'_{112} & T'_{121} & T'_{122} \\ T'_{211} & T'_{212} & T'_{221} & T'_{222} \end{bmatrix} \begin{bmatrix} T''_{11} \\ T''_{12} \\ T''_{21} \\ T''_{22} \end{bmatrix}.$$

It is useful when we need to obtain the inverse of some linear operations. Also, contractions and tensor products are both O(n)-equivariant.

2.3 CG matrices and the parentage scheme

The O(3) group has its representations in tensor product space $(\mathbb{R}^3)^{\otimes n}$, which are some $3^n \times 3^n$ matrices, or tensor product of n (r=1,s=1)-tensors, which depends on one's view. If we interpret them as matrices, then the objects they act on are simply 3^n -dimensional




Figure 2: The parentage scheme. The numbers in the circle represent multiplicity. The sum of each column equals equation (4).

vectors. The tensor product spaces $(\mathbb{R}^3)^{\otimes n}$ for n > 1 are generally reducible. Recall CG coefficients, two irreducible spherical vectors v and v' coupling can also be viewed as that they first form a rank 2 tensor, and then decompose into different new spherical vectors. These operations can also be viewed as a product of matrices and vectors. In this context, the CG coefficients $\hat{C}^{l_1 l_2 l_o}$ form a $(2l_1 + 1)(2l_2 + 1) \times (2l_o + 1)$ matrix, which we call a CG matrix. If we reshape it to a $(2l_1 + 1) \times (2l_2 + 1) \times (2l_o + 1)$ tensor, then we instead call it an (l_1, l_2, l_o) -tensor $C^{l_1 l_2 l_o}$. Here are some important properties,

Lemma 1 (Orthogonality) Given an (l_1, l_2, l_o) -CG tensor $C^{l_1 l_2 l_o}$, we have

$$\sum_{j_1,j_2} C^{l_1 l_2 l_o}_{j_1 j_2 k} C^{l_1 l_2 l_o}_{j_1 j_2 k'} = \sum_{j_1,j_2} C^{l_1 l_2 l_o}_{j_1 k j_2} C^{l_1 l_2 l_o}_{j_1 k' j_2} = \sum_{j_1,j_2} C^{l_1 l_2 l_o}_{k j_1 j_2} C^{l_1 l_2 l_o}_{k' j_1 j_2} = 0$$

for $k \neq k'$. More generally, different CG tensors with the same l_1 and l_2 , l_1 and l_3 , or l_2 and l_3 are also orthogonal in this way.

Lemma 2 (Norm) Given an (l_1, l_2, l_o) -CG tensor $C^{l_1 l_2 l_o}$, we have

$$\sum_{j_1,j_2} (C^{l_1 l_2 l_o}_{j_1 j_2 k})^2 = \sum_{j_1,j_2} (C^{l_1 l_2 l_o}_{j_1 j_2 k'})^2; \quad \sum_{j_1,j_2} (C^{l_1 l_2 l_o}_{j_1 k j_2})^2 = \sum_{j_1,j_2} (C^{l_1 l_2 l_o}_{j_1 k' j_2})^2; \quad \sum_{j_1,j_2} (C^{l_1 l_2 l_o}_{k j_1 j_2})^2 = \sum_{j_1,j_2} (C^{l_1 l_2 l_o}_{k' j_1 j_2})^2$$

for any pair of k and k'.

Lemma 3 (Equivariance) An (l_1, l_2, l_o) -CG tensor $C^{l_1 l_2 l_o}$ maintains the following equivariances,

$$\rho_{l_1 \otimes l_2}(g) \odot C^{l_1 l_2 l_o}$$

$$= \sum_{j_1, j_2} R^{l_1}_{i_1 j_1} R^{l_2}_{i_2 j_2} C^{l_1 l_2 l_o}_{j_1 j_2 i_3}$$

$$= \sum_{j_1} C^{l_1 l_2 l_o}_{i_1 i_2 j_1} R^{l_3}_{j_1 i_3}$$

$$= C^{l_1 l_2 l_o} \odot \rho_{l_o}(g),$$

where \odot denotes the tensor contraction, R^l is the matrix representation in l space. This equation holds for other permutations as Lemmas 1 and 2.

The above lemmas cover the CG matrices case. Since the columns of CG matrices have the same L_2 norm, we denote as $\|\cdot\|_{col}$ for shorthand, and we sometimes call the last index of the CG tensors as the index of their columns. Recall that CG matrices are non-zero if and only if $|l_1 - l_2| \leq l_o \leq l_1 + l_2$. If we start from an l=1 vector and couple an additional l=1 once a time, then this process has been drawn as a parentage scheme by Coope et al. (1965), as shown in Figure 2. Each time we move from left to closed right column we couple an additional l=1 vector. The parentage scheme also tells us which irreducible representations can a rank n tensor be decomposed into. Note that a rank n tensor can be decomposed into multiple spherical vectors, and the multiplicity for each weight given the rank is written in the scheme. Equivalently, it can also be decomposed into same numbers of ICTs, but in the Cartesian spaces. We also have a closed-form formula for the multiplicity,

Proposition 4 The multiplicaties of the weight j ICTs of a rank n tensor is

$$N^{(n;j)} = \sum_{i}^{\lfloor (n-j)/3 \rfloor} (-1)^{i} \frac{n!(2n-3i-j-2)!}{i!(n-i)!(n-2)!(n-3i-j)!}.$$
 (4)

Note that the equation scales slower or equal to exponential, as it is smaller than 3^n , the dimension of the tensor product space.

3 Problem formulation

We first formulate the task of obtaining ICT decomposition matrices. The properties derived during the process of obtaining these decomposition matrices are further leveraged to construct the bases for equivariant linear mappings between tensor product spaces.

3.1 ICT decomposition

In this paper, one of our goal is to find an efficient way to obtain a set of matrices H to decompose a rank n tensor into ICTs with different weight l and index q, as shown in

equation (1). The resulting ICTs are in the Cartesian tensor product spaces, not in the spherical ones. Here, we precisely define what an ICT decomposition is. In other words, we specify the properties that the matrices H must satisfy:

Definition 5 (ICT decomposition) Given a Cartesian tensor product space $(\mathbb{R}^3)^{\otimes n}$ formed by tensor product of Cartesian spaces \mathbb{R}^3 , an ICT decomposition is a set of decomposition matrices $H^{(n;l;q)} \in \mathbb{R}^{3^n \times 3^n}$, where l is the weight of ICTs, and q is the index of the multiplicities, such that:

- 1) $H^{(n;l;q)}$ are O(3)- $((\mathbb{R}^3)^{\otimes n}, (\mathbb{R}^3)^{\otimes n})$ -equivariant.
- 2) The summation of the decomposition matrices is an identity matrix, i.e., $\sum_{l,q} H^{(n;l;q)} = I$.
 - 3) $\{H^{(n;l;q)}\}$ is linearly independent.

Furthermore, if we have

$$\left(H^{(n;l;q)}v\right)\cdot\left(H^{(n;l';q')}v\right) = 0\tag{5}$$

for any $v \in (\mathbb{R}^3)^{\otimes n}$, and $l \neq l'$ or $q \neq q'$, then we further call it an orthogonal ICT decomposition, and the matrices orthogonal decomposition matrices. $H^{(n;l;q)}v$ is called an ICT with rank n, weight l, and index q.

Note that ICT decomposition is not necessary to be orthogonal, but being orthogonal is the ultimate goal for ICT decomposition. To prove the orthogonality, we have

Lemma 6 Given matrices $M: \mathcal{S} \to \mathcal{S}'$ and $M': \mathcal{S} \to \mathcal{S}'$ of the same shape, if $M^TM' = 0$, then

$$(Mv) \cdot (M'v) = 0 \tag{6}$$

for any $v \in \mathcal{S}$.

Proof It holds true that

$$(Mv) \cdot (M'v)$$

$$= \sum_{i} \left(\sum_{j} M_{ij} v_{j} \right) \left(\sum_{j'} M'_{ij'} v_{j'} \right)$$

$$= \sum_{j,j'} v_{j} v_{j'} \left(\sum_{i} M_{ij} M'_{ij'} \right).$$

$$(7)$$

Assume we have $M^TM = 0$, then for any j and j', we have

$$\sum_{i} M_{ij} M'_{ij'} = 0. (8)$$

Plug it back to equation (7), we obtain

$$(Mv) \cdot (M'v) = \sum_{j,j'} v_j v_{j'} \left(\sum_i M_{ij} M'_{ij'} \right) = 0.$$
 (9)

This concludes the proof.

This work obtains orthogonal ICT decomposition matrices for tensor product spaces with rank $6 \le n \le 9$. A comparison with predecessors is shown in Table 1.

3.2 Basis of the equivariant design space

Given a tensor $T \in (\mathbb{R}^3)^{\otimes n}$, a critical challenge in the design of EGNNs is determining which linear operations acting on the tensor are equivariant, i.e., find the set of f in equation (2), denoted as $\operatorname{End}_{O(3)}((\mathbb{R}^3)^{\otimes n})$. In real implementation, we flatten T to vectors v, and the linear mappings f are therefore matrices. Pearce-Crump (2023b) leverages Brauer (1937)'s theorem to obtain spanning sets for homomorphism spaces. However, the spanning set becomes increasingly redundant as the rank of tensors rises. In this work, we aim to efficiently find bases, instead of spanning sets, for equivariant spaces.

Additionally, we seek to find bases for the equivariant spaces $\operatorname{End}_{O(3)}(\mathcal{S}, \mathcal{S}')$, where \mathcal{S} is not necessarily equal to \mathcal{S}' . Here, \mathcal{S} and \mathcal{S}' can be arbitrary direct sums of tensor product spherical spaces (which also include Cartesian spaces, recall Lemma 22). This approach enables us to design EGNNs more freely by making the domain and co-domain of equivariant layers steerable. In other words, given arbitrary domain and its co-domain, one can efficiently construct equivariant layers without redundant parameters. A discussion of the relationship between Pearce-Crump (2023b) and this work is provided in Section 8.1.

4 High-order orthogonal ICT decomposition

Our key to obtaining the orthogonal decomposition matrix is to find a change-of-basis matrix between irreducible spherical spaces and tensor product spaces. The first step is to construct what we call path matrices. We have first obtained the following lemmata:

Lemma 7 Given an $(l_x \otimes l_y, l_2)$ -CG matrix $\hat{C}^{l_x l_y l_2}$ and an (l_1, l_2, l_3) -CG tensor, $C^{l_1 l_2 l_3}$, if we let

$$T = \sum_{j_1} \hat{C}_{i_2j_1}^{l_x l_y l_2} C_{i_1j_1i_3}^{l_1 l_2 l_3} \tag{10}$$

and we flatten T into a $(2l_1 + 1)(2l_x + 1)(2l_y + 1) \times (2l_3 + 1)$ matrix, then the following statements hold true:

- 1) T is O(3)- $(l_1 \otimes l_x \otimes l_y, l_3)$ -equivariant.
- 2) The columns of T are orthogonal.
- 3) The columns have the same L_2 -norms.

Proof We first prove 1), given an arbitrary group element $g \in O(3)$,

$$\rho_{l_{1}\otimes l_{x}\otimes l_{y}}(g) \odot T
= \rho_{l_{1}\otimes l_{x}\otimes l_{y}}(g) \odot \left(\sum_{j_{1}} \hat{C}_{i_{2}j_{1}}^{l_{x}l_{y}l_{2}} C_{i_{1}j_{1}i_{3}}^{l_{1}l_{2}l_{3}}\right)
= \sum_{i'_{1},i'_{2}} R_{i_{1}i'_{1}}^{l_{1}} R_{i_{2}i'_{2}}^{l_{x}\otimes l_{y}} \left(\sum_{j_{1}} \hat{C}_{i'_{2}j_{1}}^{l_{x}l_{y}l_{2}} C_{i'_{1}j_{1}i_{3}}^{l_{1}l_{2}l_{3}}\right)
= \sum_{j_{1}} \left(\sum_{i'_{2}} R_{i_{2}i'_{2}}^{l_{x}\otimes l_{y}} \hat{C}_{i'_{2}j_{1}}^{l_{x}l_{y}l_{2}}\right) \left(\sum_{i'_{1}} R_{i_{1}i'_{1}}^{l_{1}} C_{i'_{1}j_{1}i_{3}}^{l_{1}l_{2}l_{3}}\right)
\stackrel{(a)}{=} \sum_{j_{1}} \left(\sum_{j'_{1}} \hat{C}_{i_{2}j'_{1}}^{l_{x}l_{y}l_{2}} R_{j'_{1}j_{1}}^{l_{2}}\right) \left(\sum_{i'_{1}} R_{i_{1}i'_{1}}^{l_{1}} C_{i'_{1}j_{1}i_{3}}^{l_{1}l_{2}l_{3}}\right)
= \sum_{j_{1}} \hat{C}_{i_{2}j_{1}}^{l_{x}l_{y}l_{2}} \left(\sum_{i'_{1},j'_{1}} R_{j'_{1}j_{1}}^{l_{2}} R_{i_{1}i'_{1}}^{l_{1}} C_{i'_{1}j'_{1}i_{3}}^{l_{1}l_{2}l_{3}}\right)
\stackrel{(b)}{=} \sum_{j_{1},i'_{3}} \hat{C}_{i_{2}j_{1}}^{l_{x}l_{y}l_{2}} C_{i_{1}l_{2}l_{3}}^{l_{x}l_{3}} R_{i'_{3}i_{3}}^{l_{3}}
= T \odot \rho_{l_{3}}(g),$$
(11)

so T is O(3)- $(l_1 \otimes l_x \otimes l_y, l_3)$ -equivariant, where R^l is the matrix representation in l space, equalities (a) and (b) hold true because of Lemma 3.

Next we prove 2), for an arbitrary pair of the indexes of two columns $k \neq k'$, we have

$$\sum_{j_{1}} T_{j_{1}k} T_{j_{1}k'} \\
= \sum_{j_{1},j_{3}} \left(\sum_{j_{2}} \hat{C}_{j_{1}j_{2}}^{l_{x}l_{y}l_{2}} C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}} \right) \left(\sum_{j_{2}'} \hat{C}_{j_{1}j_{2}'}^{l_{x}l_{y}l_{2}} C_{j_{3}j_{2}k'}^{l_{1}l_{2}l_{3}} \right) \\
= \sum_{j_{2},j_{2}'} \left(\sum_{j_{1}} \hat{C}_{j_{1}j_{2}}^{l_{x}l_{y}l_{2}} \hat{C}_{j_{1}j_{2}'}^{l_{x}l_{y}l_{2}} \right) \left(\sum_{j_{3}} C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}} C_{j_{3}j_{2}k'}^{l_{1}l_{2}l_{3}} \right) \\
\stackrel{(a)}{=} \sum_{j_{1},j_{2}} \left(\hat{C}_{j_{1}j_{2}}^{l_{x}l_{y}l_{2}} \right)^{2} \left(\sum_{j_{3}} C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}} C_{j_{3}j_{2}k'}^{l_{1}l_{2}l_{3}} \right) \\
= \|\hat{C}^{l_{x}l_{y}l_{2}}\|_{col}^{2} \left(\sum_{j_{2},j_{3}} C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}} C_{j_{3}j_{2}k'}^{l_{1}l_{2}l_{3}} \right) \\
\stackrel{(b)}{=} 0, \tag{12}$$

and thus the columns of T are orthogonal. Equalities (a) and (b) follow from Lemma 1 that $\sum_{j_1} \hat{C}_{j_1 j_2}^{l_x l_y l_2} \hat{C}_{j_1 j_2'}^{l_x l_y l_2} = 0$ for $j_2 \neq j_2'$, and $\sum_{j_2, j_3} C_{j_3 j_2 k}^{l_1 l_2 l_3} C_{j_3 j_2 k'}^{l_1 l_2 l_3} = 0$.

Finally, we prove 3), for an arbitrary column with index k,

$$\sqrt{\sum_{j_{1}} T_{j_{1}k} T_{j_{1}k}}} = \sqrt{\sum_{j_{1},j_{3}} \left(\sum_{j_{2}} \hat{C}_{j_{1}j_{2}}^{l_{x}l_{y}l_{2}} C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}}\right) \left(\sum_{j_{2}'} \hat{C}_{j_{1}j_{2}'}^{l_{x}l_{y}l_{2}} C_{j_{3}j_{2}'k}^{l_{1}l_{2}l_{3}}\right)} \\
= \sqrt{\sum_{j_{2},j_{2}'} \left(\sum_{j_{1}} \hat{C}_{j_{1}j_{2}}^{l_{x}l_{y}l_{2}} \hat{C}_{j_{1}j_{2}'}^{l_{x}l_{y}l_{2}}\right) \left(\sum_{j_{3}} C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}} C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}}\right)} \\
= \sqrt{\sum_{j_{2}} \left(\sum_{j_{1}} \left(\hat{C}_{j_{1}j_{2}}^{l_{x}l_{y}l_{2}}\right)^{2} \sum_{j_{3}} \left(C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}}\right)^{2}\right)} \\
= \|\hat{C}^{l_{x}l_{y}l_{2}}\|_{\text{col}} \sqrt{\sum_{j_{2},j_{3}} \left(C_{j_{3}j_{2}k}^{l_{1}l_{2}l_{3}}\right)^{2}} \\
= \|\hat{C}^{l_{x}l_{y}l_{2}}\|_{\text{col}} \|C^{l_{1}l_{2}l_{3}}\|_{\text{col}}. \tag{13}$$

From Lemma 2, we know that it takes the same value for different k, which satisfies 3).




Figure 3: Construction of decomposition matrix. **Top:** The path matrices are formed via sequential contraction according to the path in the parentage scheme. **Bottom:** The decomposition matrix is obtained as the product of the path matrix and its transpose.

Here is the strategy, we first let a $(0 \otimes 0, 0)$ -CG matrix to contract with an (1, 0, 1)-CG tensor to obtain an $(0 \otimes 1, 1)$ -matrix. This matrix can further contract with (1, 1, 2), (1, 1, 1), and (1, 1, 0)-CG tensors to obtain the associated matrix. For example, we call the obtained $(0 \otimes 1 \otimes 1, 2)$ a $(0 \to 1 \to 2)$ -path matrix. The path matrices are constructed via the parentage scheme, which will decide what is the next CG tensor we are going to contract with, as shown in Figure 3. This gives us:

Corollary 8 Given a path matrix $P^{(0\to\cdots\to l_2)}$ and a CG tensor C^{1,l_2l_3} , if we let $P^{(0\to\cdots\to l_2\to l_3)} = \sum_{j_1} P^{(0\to\cdots\to l_2)}_{i_2j_1} C^{1,l_2l_3}_{i_1j_1i_3}$, and we flatten $P^{(0\to\cdots\to l_2\to l_3)}$ as we did in Lemma 7, then we have the same statements hold as Lemma 7.

Proof The path matrices have all the properties we used in Lemma 7. We prove this by a simple deduction. From the above lemma we know that $(0 \to 1)$ -path matrix holds all the properties. This gives us the initial condition. Assume that a matrix holds the properties, then Lemma 7 tells us the next obtained path matrix also share them.

Next, we prove that

Lemma 9 The columns of different path matrices of the same path length are orthogonal.

Proof We prove by deduction. The first to third columns of the parentage scheme generate $(0 \to 1 \to 2)$, $(0 \to 1 \to 1)$, and $(0 \to 1 \to 0)$ -path matrices. We first prove that the columns of these matrices are orthogonal. Since they come from the contraction of $(0 \to 1)$ -path matrices and different CG matrices, we can prove a more general conclusion. That is, for any path matrix P and two different CG tensors C and C', given two different column indexes

of there two tensors k and k', consider the dot product of these two columns, we have

$$\sum_{j_{1},j_{3}} \left(\sum_{j_{2}} P_{j_{1}j_{2}} C_{j_{3}j_{2}k} \right) \left(\sum_{j'_{2}} P_{j_{1}j'_{2}} C'_{j_{3}j'_{2}k'} \right) \\
= \sum_{j_{2},j'_{2}} \left(\sum_{j_{1}} P_{j_{1}j_{2}} P_{j_{1}j'_{2}} \right) \left(\sum_{j_{3}} C_{j_{3}j_{2}k} C'_{j_{3}j'_{2}k'} \right) \\
\stackrel{a}{=} \|P\|_{col}^{2} \underbrace{\left(\sum_{j_{2},j_{3}} C_{j_{3}j_{2}k} C'_{j_{3}j_{2}k'} \right)}_{0} \right) \tag{14}$$

$$\stackrel{b}{=} 0.$$

Equalities (a) and (b) follow from Lemma 1, the general cases. This general condition works for the columns of the length 3 path matrices as the initial condition. It also holds true for path matrices with arbitrary length (since the CG tensors must have orthogonal columns according to Lemma 1), even without the requirement for the assumption that the previous path matrices hold the orthogonality.

Till now, it is adequate to show our solution to the problem:

Theorem 10 Given the set of all the paths of the same length $n \{p_i\}$ with $\#\{p_i\} = K$ and path matrices $\{P^{(p_i)}\}$, the set of $\{(\|P\|^{(p_i)})_{col}^{-2} P^{(p_i)} (P^{(p_i)})^T\}$ is a rank n-1 orthogonal ICT decomposition. The obtainment of this set is of exponential time and space complexity, in terms of rank n.

Proof From Corollary 8, we know that each $P^{(p_i)}$ has full rank (but not a square matrix), and has the same L_2 norm of each column, $\|P^{(p_i)}\|_{col}$. Subsequently, $\hat{P}^{(p_i)} = (\|P^{(p_i)}\|_{col})^{-1} P^{(p_i)}$ will make it with an unit L_2 norm, as $\|(\|P^{(p_i)}\|_{col})^{-1} P^{(p_i)}\|_{col} = 1$. This does not affect the equivariance of the path matrices, as the L_2 -norm is invariant. If we concatenate all the path matrices P along the last dimension,

$$D^{(\mathbb{R}^3)^{\otimes n-1} \to \operatorname{irr}((\mathbb{R}^3)^{\otimes n-1})} = \left[\left(\|P^{(p_1)}\|_{col} \right)^{-1} P^{(p_1)} \dots \left(\|P^{(p_K)}\|_{col} \right)^{-1} P^{(p_K)} \right]$$
(15)

where irr outputs the all possible irreducible representation spaces. The above equation forms a $3^{n-1} \times 3^{n-1}$ matrix. In this proof, we will use D to represent $D^{(\mathbb{R}^3)^{\otimes n-1} \to \operatorname{irr}((l=1)^{\otimes n-1})}$ to save place. This is an orthogonal matrix, $D^TD = DD^T = I$, as the columns of it are all orthogonal and normalized to unit L_2 norm as we discussed above, and K is the total multiplicity of the nth column of the parentage scheme. From Corollary 8, we know that D^T is O(3)- $((l=1)^{\otimes n-1}, \bigoplus_i^K (l^{(i)}))$ -equivariant, where $l^{(i)} \in \operatorname{irr}((l=1)^{\otimes n-1})$. If we left multiply it with a selection matrix (a diagonal matrix with ones and zeros on the diagonal) $I^{(j)}$ to select out the jth irreducible spherical representation, the resulting $I^{(j)}P^T$ is O(3)- $((l=1)^{\otimes n-1}, l^{(j)})$ -equivariant. Similarly, the inverse P is O(3)- $(\bigoplus_i^K (l^{(i)}), (l=1)^{\otimes n-1})$ -equivariant. With the

right multiplied $I^{(j)}$, it becomes O(3)- $(l^{(j)}, (l=1)^{\otimes n-1})$ -equivariant. Together, $PI^{(j)}P^T$ is O(3)- $((l=1)^{\otimes n-1}, (l=1)^{\otimes n-1})$ -equivariant. From Lemma 22, this relation is equivalent to O(3)- $((\mathbb{R}^3)^{\otimes n-1}, (\mathbb{R}^3)^{\otimes n-1})$ -equivariance in the n-1 rank Cartesian tensor product space. Meanwhile,

$$DI^{(j)}D^{T} = \hat{P}^{(p_j)}(\hat{P}^{(p_j)})^{T}, \tag{16}$$

which follows from the fact that D is an orthogonal matrix, and the concatenation of \hat{P} forms D. It therefore meets condition 1) of Definition 5.

Next we prove 2), it holds true because

$$\sum_{j} \hat{P}^{(p_j)} \left(\hat{P}^{(p_j)} \right)^T = \sum_{j} DI^{(j)} D^T = DD^T \sum_{j} I^{(j)} = I.$$
 (17)

Finally, we prove the orthogonality, given $\hat{P}^{(p_k)}(\hat{P}^{(p_k)})^T$ and $\hat{P}^{(p_{k'})}(\hat{P}^{(p_{k'})})^T$ with different $k \neq k'$, consider dot product of an arbitrary pair of their columns $c \neq c'$, we have

$$\left(\hat{P}^{(p_k)} \left(\hat{P}^{(p_k)}\right)^T\right)_{*,c} \cdot \left(\hat{P}^{(p_{k'})} \left(\hat{P}^{(p_{k'})}\right)^T\right)_{*,c'}$$

$$= \sum_{j_1} \left(\sum_{j_2} \hat{P}^{(p_k)}_{j_1 j_2} \hat{P}^{(p_k)}_{c j_2}\right) \left(\sum_{j_2'} \hat{P}^{(p_{k'})}_{j_1 j_2'} \hat{P}^{(p_{k'})}_{c' j_2'}\right)$$

$$= \sum_{j_2, j_2'} \hat{P}^{(p_k)}_{c j_2} \hat{P}^{(p_{k'})}_{c' j_2'} \underbrace{\left(\sum_{j_1} \hat{P}^{(p_k)}_{j_1 j_2} \hat{P}^{(p_{k'})}_{j_1 j_2'}\right)}_{0}$$

$$= 0. \tag{18}$$

The last equality follows from Lemma 9. From Lemma 6, it satisfies the orthogonality requirement of Definition 5, which is stronger than condition 3), so 3) is implicitly guaranteed.

Time Complexity:

Note that Parentage Scheme is faster than completely traversing a ternary tree, which holds an exponential complexity. For algebraic complexity, there are several studies aiming to discover the complexity of tensor product and contraction (Kisil et al., 2021; Capelli et al., 2016). It can be concluded that our tensor operations will not be worse than exponential complexity. Finally, the dot product of path matrices $\hat{P}^{(p_j)}\left(\hat{P}^{(p_j)}\right)^T$ are also with exponential complexity.

Space Complexity:

The largest matrices we maintain are the set of $\hat{P}^{(p_i)}$ and the change-of-basis matrix D, of which the total size is $3^{n-1} \times 3^{n-1}$.

It is also noteworthy that the complexity cannot be lower than exponential in terms of rank n, as the ICT decomposition matrices themselves have an inherently exponential structure. Here we describe the process of constructing decomposition matrices using the parentage scheme. A path in the scheme uniquely corresponds to a path matrix. We start by creating a temporary path matrix, denoted as $(0 \otimes 0, 0)$, which will be updated in each round. This matrix is reshaped from a (0,0,0) CG tensor (merging the first two dimensions). The starting point is (0,0) in the parentage scheme, where the first coordinate represents the rank, and the second represents the weight.

Next, we move from rank 0 to rank 1, i.e., from the first column to the second column. Observe that the only line connecting (0,0) and (1,*) is the one between (0,0) and (1,1). Therefore, the CG tensor to be contracted is (1,0,1). The third 1 is determined by the second 1 in (1,1) in the scheme. The second 0 is determined by the fact that our currently maintained temporary path matrix has 0 in the last position of $(0 \otimes 0,0)$. The first 1 is fixed and remains unchanged regardless of which lines we are moving along (this behavior will change for the general parentage scheme, as introduced in Section 6).

The contraction is performed between the last dimension of the temporary path matrix and the second dimension of the CG tensor, as shown in Equation (10). By merging the first two dimensions of the resulting path matrices, we obtain $(0 \to 1)$ path matrices, which can be represented as $(0 \otimes 0 \otimes 1, 1)$ (we sometimes omit the $0 \otimes 0$ for simplicity).

At this point, we are positioned at (1,1). The connected points in the next column are (2,0), (2,1), and (2,2). Consequently, the CG tensors to be contracted are (1,1,0), (1,1,1), and (1,1,2), respectively. These contractions yield initial path matrices $(0 \to 1 \to 2)$, $(0 \to 1 \to 1)$, and $(0 \to 1 \to 0)$ with shapes $(1 \otimes 1,2)$, $(1 \otimes 1,1)$, and $(1 \otimes 1,0)$.

This process is repeated iteratively until we reach rank n. The process and an example are illustrated in Figure 3.

We also present the pseudocode in Algorithm 1. We also benchmark the speed of our algorithm for obtaining the set of all decomposition matrices for different ranks, as shown in Table 3. We run the experiments on 28-cores Intel[®] Xeon Gold 6330 CPU @ 2.00GHz.

5 Basis of the equivariant design space

Recall Section 3.2 that one of our goal is to find the basis of the equivariant design space $\{M \in \mathbb{R}^{3^n} \times \mathbb{R}^{3^n} \mid \rho(g)M = M\rho(g)\}$. Here, we leverage Schur's lemma:

Lemma 11 (Schur's lemma, special case) Given ρ a finite-dimensional irreducible representation of group G, and a matrix M. Then

$$\rho(g)M = M\rho(g) \tag{19}$$

holds for any $g \in G$, if and only if M = cI, where c is a scalar.

Thus, for an endomorphism space from a single irreducible representation space to itself, the basis is simply an identity matrix I and it is a single dimension space. On the contrary, a rank-n Cartesian tensor is a direct sum of several such irreducible representation spaces. In such situation, we obtain the following lemma:

Lemma 12 Given a representation $S = \bigoplus_{i=1}^{n} S^{(i)}$ that can be written as the direct sum of several finite-dimensional irreducible representations $S^{(i)}$. If they are isomorphic to each other $S^{(0)} \cong \ldots \cong S^{(n)}$, then the number of dimensions of the equivariant design space is n^2 , and the basis consists of one-dimensional linear projections with a scaling factor from $S^{(i)}$ to $S^{(j)}$ for any i and j.

Proof First note that

$$(\mathcal{S}^{(i)} \oplus \mathcal{S}^{(j)}) \to \mathcal{S}' \cong (\mathcal{S}^{(i)} \to \mathcal{S}') + (\mathcal{S}^{(j)} \to \mathcal{S}'), \tag{20}$$

where + represents linear combinations, and conversely

$$\mathcal{S}' \to (\mathcal{S}^{(i)} \oplus \mathcal{S}^{(j)}) \cong (K' \to \mathcal{S}^{(i)}) \oplus (\mathcal{S}' \to \mathcal{S}^{(j)}).$$
 (21)

Given a linear projection $f: \bigoplus_{i=1}^{n} \mathcal{S}^{(i)} \to \bigoplus_{i=1}^{n} \mathcal{S}^{(i)}$, we have

$$\bigoplus_{i}^{n} \mathcal{S}^{(i)} \to \bigoplus_{i}^{n} \mathcal{S}^{(i)}
\cong \bigoplus_{j}^{n} \left(\bigoplus_{i}^{n} \mathcal{S}^{(i)} \to \mathcal{S}^{(j)} \right)
\cong \bigoplus_{j}^{n} \left(+_{i}^{n} \left(\mathcal{S}^{(i)} \to \mathcal{S}^{(j)} \right) \right).$$
(22)

Note that $(\mathcal{S}^{(i_1)} \to \mathcal{S}^{(j)})$ and $(\mathcal{S}^{(i_2)} \to \mathcal{S}^{(j)})$ form a basis of $(\mathcal{S}^{(i_1)} \to \mathcal{S}^{(j)}) + (\mathcal{S}^{(i_2)} \to \mathcal{S}^{(j)})$ if $i_1 = i_2$. Meanwhile, $(\mathcal{S}^{(i_1)} \to \mathcal{S}^{(j_1)})$ and $(\mathcal{S}^{(i_2)} \to \mathcal{S}^{(j_2)})$ must form a basis of $(\mathcal{S}^{(i_1)} \to \mathcal{S}^{(j_1)}) \oplus (\mathcal{S}^{(i_2)} \to \mathcal{S}^{(j_2)})$ according to the definition of direct sum. Each mapping is of dimension one by Lemma 11. Thus, $\bigoplus_{i=1}^{n} \mathcal{S}^{(i)} \to \bigoplus_{i=1}^{n} \mathcal{S}^{(i)}$ has totally n^2 basis $\mathcal{S}^{(i)} \to \mathcal{S}^{(j)}$.

From the perspective of matrices, it is equivalent to say that the matrices which can scale an irreducible representation and add it to another (including itself) form a basis for the equivariant design space. Here, we provide an example,

$$\begin{bmatrix} \ddots & \vdots & \ddots \\ \dots & 0 & 0 & 0 & k & 0 & 0 & \dots \\ \dots & 0 & 0 & 0 & 0 & k & 0 & \dots \\ \dots & 0 & 0 & 0 & 0 & 0 & k & \dots \\ \dots & 0 & 0 & 0 & 0 & 0 & 0 & \dots \\ \dots & 0 & 0 & 0 & 0 & 0 & 0 & \dots \\ \dots & 0 & 0 & 0 & 0 & 0 & 0 & \dots \\ \dots & 0 & 0 & 0 & 0 & 0 & 0 & \dots \\ \dots & \vdots & \vdots & \vdots & \vdots & \vdots & \vdots & \ddots \end{bmatrix} \begin{bmatrix} \vdots \\ v_{1;q}^{(1;q)} \\ v_{1}^{(1;q)} \\ v_{1}^{(1;q')} \\ v_{1}^{(1;q')} \\ v_{1}^{(1;q')} \\ v_{1}^{(1;q')} \\ \vdots \end{bmatrix} = \begin{bmatrix} \vdots \\ kv_{-1}^{(1;q')} \\ kv_{-1}^{(1;q')} \\ kv_{1}^{(1;q')} \\ 0 \\ 0 \\ \vdots \end{bmatrix},$$

$$(23)$$

where $A^{(1;q;q')}$ adds $kv^{(1;q')}$ to the position of $v^{(1;q)}$, where $v^{(1;q)}$ belongs to the (l=1) spherical space, with index q corresponding to the multiplicity of the same weight, and k is a scalar. Note that $A^{(1;q;q')}$ resides in the spherical space and is a (r=1,s=1)-tensor,

so we need to convert it back to Cartesian space via the change-of-basis matrices D and $D^{-1} = D^T$. We have that

Thus, we can reduce the three square matrices multiplications to a series of products of sub-matrices. To conclude, we have

Proposition 13 Given a rank n Cartesian tensor product space. $\hat{P}^{(p_i)}\left(\hat{P}^{(p_j)}\right)^T$ for all pair of paths p_i and p_j of which the last weights are the same, form an orthogonal basis of the equivariant design space with respect to the Cartesian space. The dimension of the equivariant space equals

$$\sum_{n,0 \le j \le n} \left(\sum_{i}^{\lfloor (n-j)/3 \rfloor} (-1)^{i} \frac{n!(2n-3i-j-2)!}{i!(n-i)!(n-2)!(n-3i-j)!} \right)^{2}.$$
 (25)

Proof We first prove the equivariance. For arbitrary $\hat{P}^{(p_i)}\left(\hat{P}^{(p_j)}\right)^T$, and group element g, we have

$$\hat{P}^{(p_i)} \left(\hat{P}^{(p_j)} \right)^T \rho_{Cart}(g) = \hat{P}^{(p_i)} \left(\hat{P}^{(p_j)} \right)^{-1} \rho_{Cart}(g)
= \hat{P}^{(p_i)} \rho_{(l)}(g) \left(\hat{P}^{(p_j)} \right)^{-1} = \rho_{Cart}(g) \hat{P}^{(p_i)} \left(\hat{P}^{(p_j)} \right)^T.$$
(26)

For the orthogonality, we have

$$\left(\hat{P}^{(p_i)} \left(\hat{P}^{(p_j)}\right)^T\right)^T \left(\hat{P}^{(p_{i'})} \left(\hat{P}^{(p_{j'})}\right)^T\right)
= D \left(A^{(l;q;q')}\right)^T D^T D A^{(l;q'';q''')} D^T
= D \left(\left(A^{(l;q;q')}\right)^T A^{(l;q'';q''')}\right) D^T
= 0,$$
(27)

for arbitrary $p_i \neq p_{i'}$ or $p_j \neq p_{j'}$, i.e., $q \neq q''$ or $q' \neq q'''$. The last equality follows from the fact that either $A_{ij}^{(l;q;q')} = 0$ or $A_{ji}^{(l;q';q'')} = 0$ for $q \neq q''$ or $q' \neq q'''$. This can form k^2 orthogonal matrices for the irreducible spherical spaces with multiplicity k, so Lemma 12 guarantees they form a basis. Note that there is no linear mapping between the spaces that are not isomorphic. The dimension calculation is based on Proposition 4.

Notice that the ICT decomposition matrices are also part of the basis of the equivariant space.

6 Extension to general spaces

6.1 General ICT decomposition

It is appealing to build equivariant layers between different desired spaces. The spherical tensor product spaces enable us to utilize high-order many-body information while remaining flexible in terms of memory cost and inference speed. However, it is difficult to construct such a layer. For example, if the input space is $(l=4\otimes l=5)$ and the output space is $(l=2\otimes l=6)$, how can we parameterize the equivariant layer? More specifically, what is the basis of this layer? It is even not possible to find a spanning set by Pearce-Crump (2023b). Before answering this question, we first introduce the general problem of ICT decomposition and how to efficiently perform a general ICT decomposition on arbitrary input spaces.

Definition 14 Given a space $S = (l_{11} \otimes \cdots \otimes l_{1i_1}) \oplus \cdots \oplus (l_{k1} \otimes \cdots \otimes l_{ki_k})$ with d dimension, a general irreducible decomposition is a series of matrices $\hat{H}^{(S;l;q)} \in \mathbb{R}^{d \times d}$, such that:

- 1) $\hat{H}^{(S;l;q)}$ is O(3)-(S,S)-equivariant.
- 2) The summation of the decomposition equals to identity matrix, $\sum_i \hat{H}^{(S;l;q)} = I$.
- 3) $\{\hat{H}^{(S;l;q)}\}$ are linearly independent.

If $H^{(i)}$ are orthogonal to each other, as defined in Definition 5, we further call it an orthogonal general irreducible decomposition.

Intuitively, an orthogonal general ICT decomposition can be obtained using a strategy similar to that of the classic ICT decomposition. However, we cannot use the parentage




Figure 4: Two methods for performing a general ICT decomposition.

scheme directly, as it only accepts a tensor product with an (l = 1) one step at a time, proceeding from left to right. Here, we introduce a general parentage scheme. Unlike the classic scheme, this is not a fixed procedure.

For example, given a space $(3 \otimes 4 \otimes 2) \oplus (2 \otimes 3)$, we first separate the terms by the direct sum \oplus , resulting in $(3 \otimes 4 \otimes 2)$ and $(2 \otimes 3)$. First, we use the general parentage scheme to decompose $(3 \otimes 4 \otimes 2)$ into irreducible spherical spaces and construct the path matrices. We begin by writing a multiplicity of one in the weight-3 row, in the leftmost column. Then, we take the tensor product with (l=4), which results in multiplicities of one in $(l=7),\ldots,(l=1)$. We also construct the path matrices $(3 \stackrel{4}{\to} 7),\ldots,(3 \stackrel{4}{\to} 1)$. Note that we mark 4 on top of the arrow, which we refer to as the bridge number. Then, 2 is taken as the bridge number, and we accordingly write the multiplicities in the next column. Consequently, we apply the same procedure for $(2 \otimes 3)$. An important property is

Corollary 15 (from Lemma 7) Given a tensor product space, the path matrices for the same general parentage scheme have orthogonal columns, and the L_2 norms of columns of each path matrix are the same.

Proof The proof for the is mostly identical to that of Lemma 7.

Here the words **the same** suggest us we need to fix our bridge number to obtain orthogonal path matrices. As our previous example, $(3 \stackrel{4}{\rightarrow} 7 \stackrel{2}{\rightarrow} 6)$ and $(4 \stackrel{3}{\rightarrow} 7 \stackrel{2}{\rightarrow} 6)$ will generate two different path matrices. But they are actually identical up to an index permutation. The result will be the same if we accordingly permute the index of our input vector. We can multiply the path matrices with their inverse to obtain decomposition matrices, as the classic ICT decomposition. Here we should note that the decomposition matrices of different sub schemes separated by the direct sum can not generally concatenated. We can, in general, concatenate some zeros to the path matrices and their transpose with short row and column, respectively. Or we can just leave the decomposition matrices of different shapes as they are, and multiply the matrices with different segments of the input vector. The two methods are shown in Figure 4.

6.2 Equivariant bases of arbitrary spaces

The general ICT decomposition gives us some hints. The constructed change-of-basis matrix D^T changes the basis from $(3 \otimes 4 \otimes 2) \oplus (2 \otimes 3)$ to its decomposed irreducible spherical spaces, denoted as irr $((3 \otimes 4 \otimes 2) \oplus (2 \otimes 3))$, and its inverse D changes back the basis. An orthogonal basis from spaces S_1 to S_2 can be obtained via the change-of-basis matrices constructed based on the general ICT decompositions of these two spaces. But we need to take care of more when considering O(3). The above discussion is identical for SO(3) and O(3). Instead, here, the parity must get involved when we consider arbitrary spaces. First, one should note that a tensor product space, as irreducible spherical spaces, have parity 1 or -1. We have kept in mind that Cartesian space is of parity -1, which means that if we do the reflection, then the space will be reflected accordingly. It is equivalent to an (l=1, p=-1) spherical space, from Lemma 22. Meanwhile, we should remember that there is also (l=1, p=1) spherical space, as a cannot-be-reflected version of the Cartesian space. The parity of the tensor product space is only decided by the number of the componential spaces with odd parities. If the number is odd, then the tensor product space has odd parity, and vice versa. Meanwhile,

Proposition 16 Given a tensor product space of rank n, the resulting spaces of the ICT decomposition are with the same parity as the tensor product space.

Proof Suppose we have a rank n tensor T in the tensor product space, and assume that the parities of the ICTs and the original rank n tensor T are not the same. If a tensor T has an even parity, then reflection will not change T. Let $\hat{T}_1^{(p=-1)}, \ldots, \hat{T}_k^{(p=-1)}$ be the ICTs with odd parity. According to Definition 14, we should have

$$T = \sum_{i} \hat{T}^{(p=-1)} + \sum_{i'} \hat{T}^{(p=1)}$$

$$= -\sum_{i} \hat{T}^{(p=-1)} + \sum_{i'} \hat{T}^{(p=1)},$$
(28)

which gives us

$$\sum_{i} \hat{T}_{i}^{(p=-1)} = 0. {29}$$

This contradicts with the definition that $\hat{T}_i^{(p=-1)}$ are linearly independent. The same arguments can be given for the case that T has odd parity.

Now we are ready to introduce the procedure for a obtaining an orthogonal basis for different spaces. Given spaces \mathcal{S}^{in} and \mathcal{S}^{out} , we want to find a basis for the equivariant design space from \mathcal{S}^{in} to \mathcal{S}^{out} . We first find the irreducible spherical spaces of \mathcal{S}^{in} and \mathcal{S}^{out} via the general parentage scheme, denoted as $\operatorname{irr}(\mathcal{S}^{in})$ and $\operatorname{irr}(\mathcal{S}^{out})$, and write down the paths. Then, the paths are grouped according to the last weight in them, as well as the parities of the original tensor product spaces, denoted as $Q_{\mathcal{S}^{in}}^{(l;p)}$ and $Q_{\mathcal{S}^{out}}^{(l;p)}$. Let our equivariant space be $\operatorname{Hom}_{O(3)}(\mathcal{S}^{in},\mathcal{S}^{out})$, we have

where #· represents the number of elements in the set, which follows from Lemma 11 (Schur's lemma). We drop those paths sets that the last weight and the same parities do not show in both spaces. Then, we can generate path matrices based on those remained sets. Finally, we can conclude that

Proposition 17 Given spaces
$$S^{in} = ((l_1^1, p_1^1) \otimes \cdots \otimes (l_{k_1}^1, p_{k_1}^1)) \oplus \cdots \oplus ((l_1^t, p_1^t) \otimes \cdots \otimes (l_{k_t}^t, p_{k_t}^t))$$
, and $S^{out} = ((l_1'^1, p_1'^1) \otimes \cdots \otimes (l_{k_1'}'^1, p_{k_1'}'^1)) \oplus \cdots \oplus ((l_1'^t, p_1'^t) \otimes \cdots \otimes (l_{k_t'}'^{t'}, p_{k_t'}'^{t'}))$,

forms an orthogonal basis of $\text{Hom}_{O(3)}(\mathcal{S}^{in}, \mathcal{S}^{out})$.

Proof Since $\hat{P}^{(p^{(out;l;p;q')})} \left(\hat{P}^{(p^{(in;l;p;q)})} \right)^T$ are mappings between \mathcal{S}^{in} and \mathcal{S}^{out} , They can be represented as a $\sum_{j=1}^t \left(\prod_i^{k_j} 2l_i^j + 1 \right) \times \sum_{j=1}^{t'} \left(\prod_i^{k'_j} 2l_i^j + 1 \right)$ matrix. From the mapping relations, we know that it is a block matrix as

$$\begin{bmatrix} M_{11} & \cdots & \cdots & M_{1t} \\ \vdots & \ddots & & \vdots \\ \vdots & & \ddots & \vdots \\ M_{t'1} & \cdots & \cdots & M_{t't} \end{bmatrix} . \tag{31}$$

The sub-matrices are of shape $\left(\Pi_i^{k'_{j'}}2l_i^{j'}+1\right)\times\left(\Pi_i^{k_j}2l_i^j+1\right)$ for some j and j'. $\hat{P}^{(p^{(out;l;p;q')})}$ $\left(\hat{P}^{(p^{(in;l;p;q)})}\right)^T$ will be in the same column for those (l;p;q') belonging to the same direct




Figure 5: The general parentage scheme with the example of finding basis for $((2 \otimes 2 \otimes 2), p = -1) \oplus ((1 \otimes 3), p = -1) \rightarrow ((3 \otimes 4), p = -1)$. Compared to the classic parentage scheme, we need to additionally mark the bridge number in the scheme.

sum component of \mathcal{S}^{out} , and the same row for those (l; p; q) belonging to the same direct sum component of \mathcal{S}^{in} . When the non-zero values of $\hat{P}^{(p^{(out;l;p;q')})} \left(\hat{P}^{(p^{(in;l;p;q)})}\right)^T$ appears in a block M, the rest of the sub-matrices will be zeros. Thus, given two elements in the basis, their corresponding block matrices must be orthogonal if the non-zero values do not

show in the same block M. If they appear in the same M, then the question is equivalent to Proposition 13.

The algorithm for generating equivariant bases is presented in Algorithm 2. Here, CG_decomp_generator receives the current weight and the bridge number as input and outputs the possible weights according to the selection rules of CG coefficients. These rules depend on the group type. For instance, in the case of O(3), l_1 and l_2 generate possible weights ranging from $|l_1 - l_2|$ to $l_1 + l_2$. For SU(2), an additional condition is imposed: the output weight must have the same parity (odd or even, though not the parity in O(3)used to determine whether it can be reflected) as the sum of the two input weights. The function path_matrices_qenerator in this algorithm is described in Algorithm 3, which also depends on the group type. It is elegant to generate equivariant bases as matrices, as they also enable efficient computations. The bases can also be efficiently obtained. However, as we test the spanning set method proposed by Pearce-Crump (2023b), when we assign a scalar parameter to each basis and combine these bases to form a single matrix, real-world neural network frameworks (e.g., PyTorch) may encounter memory issues. This is because a large computation graph needs to be maintained when the rank is very high. To address this issue in high-rank cases, it is preferable to first convert the tensor into the direct sum of different irreducible spherical tensors. Then, linear combinations of tensors with the same weight can be applied. Finally, the direct sum space is converted back into the original space. This approach also follows from the previous proofs and aligns with the core idea of this paper: performing operations in spherical spaces is simpler and more efficient. This process is detailed in Algorithm 4.

6.3 Multi-channel features, activation functions, normalizations, and biases

We have already introduced how to construct equivariant linear operations between some \mathcal{S}^{in} and \mathcal{S}^{out} . In a real implementation, additional considerations are required to make it an equivariant layer in a modern neural network. First, if we take vectors in \mathcal{S}^{in} and \mathcal{S}^{out} as features, it is both standard and beneficial for a neural network to have multi-channel features. Fortunately, this is straightforward in our framework. We can simply let $(\mathcal{S}^{in})^{\oplus K^{in}}$ and $(\mathcal{S}^{out})^{\oplus K^{out}}$ serve as our input and output spaces. In this case, the conclusion in Section 6.2 can seamlessly be applied. Notably, Proposition 17 already addresses the scenarios described here. Thus, for a space

$$\underbrace{\left((l_1^1, p_1^1) \otimes \cdots \otimes (l_{k_1}^1, p_{k_1}^1)\right)}_{\mathcal{S}_{\oplus}^1} \oplus \cdots \oplus \underbrace{\left((l_1^t, p_1^t) \otimes \cdots \otimes (l_{k_t}^t, p_{k_t}^t)\right)}_{\mathcal{S}_{\oplus}^t}, \tag{32}$$

each direct sum component \mathcal{S}_{\oplus}^{i} is a single-channel feature in a multi-channel view, which can be different depending on the positions. This is more general than the regular multi-channel features.

On the other hand, activation functions introduce non-linearity to neural networks. As non-linear functions, their design space is very limited in order to preserve symmetry. However, it is completely safe if we can construct invariant linear mappings of the form $f^{inv}: v^{out} \in \mathcal{S}^{out} \mapsto c \in \mathbb{R}$. Then, we can apply an activation function to c, obtaining $\phi(c)$, and multiply $\phi(c)$ with v^{out} to produce the activated result, $\phi(f^{inv}(v^{out}))v^{out}$. This process is equivariant, as

$$\phi\left(f^{inv}\left(\rho_{\mathcal{S}^{out}}(g)\odot v^{out}\right)\right)\rho_{\mathcal{S}^{out}}(g)\odot v^{out}$$

$$=\phi\left(\underbrace{\rho_{\mathbb{R}}(g)}_{I}\odot f^{inv}\left(v^{out}\right)\right)\rho_{\mathcal{S}^{out}}(g)\odot v^{out}$$

$$=\rho_{\mathcal{S}^{out}}(g)\odot\left(\phi\left(f^{inv}\left(v^{out}\right)\right)\odot v^{out}\right).$$
(33)

This process is similar to that of the spherical space-based methods (Batzner et al., 2022; Musaelian et al., 2023), but here the strategy is available for more general spaces.

For the normalizations, one can leverage the fact that the L_2 -norm of the vectors are invariant to the rotation groups, in general spaces. This is because the matrix representations of O(n) always have an absolute determinant equal to one. Thus, for a vector $v \in \mathcal{S}$, we can simply calculate $||v||_2$ to construct an equivariant normalization layer. The discussion on biases is mainly identical to Pearce-Crump (2023b). We can construct equivariant basis from \mathbb{R} to arbitrary \mathcal{S}^{out} . In our work, we can find an orthogonal basis through Proposition 17 instead of the spanning set. Here we should note that there are some situations that we cannot find such a mapping to \mathcal{S}^{out} . For example, \mathbb{R} with odd parity cannot map to \mathcal{S}^{out} with even parity, and vice versa. Also, (l=0,p=1) cannot map to $(l=3,p=1)\otimes(l=2,p=1)$ either, as (l=0,p=1) is not in their irreducible decomposition set $\operatorname{irr}((l=3,p=1)\otimes(l=2,p=1))=\{(l=5,p=1),(l=4,p=1),(l=3,p=1),(l=2,p=1),(l=2,p=1)\}$. One can manually make the biases work by imaging the output space is $((l=3,p=1)\otimes(l=2,p=1))\oplus(l=0,p=1)$, but with (l=0,p=1) being zero. The features can be well mixed in the next layer.

7 Related works

Research on equivariant neural networks is rooted in an abstract concept raised by Cohen and Welling (2016), where they extend the translation invariance of CNNs (LeCun et al., 1989) to a wide range of groups. Meanwhile, graph neural networks (Gori et al., 2005) are proven to be suitable tools for handling tasks involving point clouds. Their coupling, Equivariant Graph Neural Networks (EGNNs) has initiated an emerging area with very important applications to physics-informed tasks. Among the implementation, Message Passing Neural Networks (MPNNs) (Gilmer et al., 2017) are the most popular, where the constructed message is propagated to the neighboring points. Before that, Schütt et al. (2017) observed that group CNN frameworks require the points to lie on some grids and propose SchNet to flexibly handle atoms that randomly appear in space. (Gasteiger et al., 2020) further leveraged directional information to enhance the model expressivity. At this point, the features utilized were just scalars and vectors, and subsequent works began to use high-order irreducible representations to effectively encode many-body interactions. Thomas et al. (2018) proposed an abstract framework, the Tensor Field Network, to incorporate spherical irreducible representations into MPNNs. This abstract framework has been implemented with different designs to achieve SOTA performances on multiple popular benchmarks (Chmiela et al., 2017; Ruddigkeit et al., 2012; Fu et al., 2022). Gasteiger et al. (2021) demonstrated the universality of using such spherical irreducible representations. Batzner et al. (2022) implemented the Tensor Field Network with high order irreducible representations, showing strong performance. On the other hand, Drautz (2019) proposed a local descriptor-based method, Atomic Cluster Exansion (ACE), to encode the atomic information via polynomial basis functions. Batatia et al. (2022) further used high-order message-passing techniques to reduce the required number of layers utilizing spherical irreducible representations. Musaelian et al. (2023) proposes a strictly local EGNN, constructing high order spherical irreducible representations among edges. Recently, several studies have leveraged the fact that Cartesian tensor is more computationally efficient. Simeon and De Fabritiis (2024) first propose to use Cartesian tensor but only with rank-2 ICT decomposition, and they further apply it to charged molecules and spin states (Simeon et al., 2024). Cheng (2024) used high-rank Cartesian tensors but did not manipulate the irreducible components. Zaverkin et al. (2024) successfully incorporated high-weight ICT to MPNNs but only addressed the highest weight of a given Cartesian tensor, lacking a full treatment of all ICTs for a given Cartesian tensor.

Research on ICT decomposition has a long history and remains a highly active area in theoretical chemistry and chemistry physics communities, in addition to the recent strong interest from the machine learning community. The second-rank ICT decomposition is well known. Since mid-20th century, Coope et al. (1965) provided the explicit ICT decomposition for rank-3 Cartesian tensors. Seventeen years later, Andrews and Ghoul (1982) derived the rank-4 formula for this problem. Dinçkal (2013) further refined Coope et al. (1965)'s results to make them orthogonal. Very recently, Bonvicini (2024) used the reduced row echelon algorithm to handle the core part of finding linearly independent components in Andrews and Ghoul (1982)'s method, to successfully find rank-5 decomposition matrices. Zou et al. (2001) also proposed a general method to perform the decomposition in a recursive style. However, this approach requires recursively decomposing each tensor, rather than having a decomposition tensor that can be directly applied to arbitrary tensors. Moreover, previous

works have relied on finding the linearly independent components of isotropic tensors, which scales in a factorial level, limiting the efficiency. Snider (2017) summarized the development for ICT in his book.

Meanwhile, we aim to understand what operations can be performed on a Cartesian tensor to maintain equivariance. That is one of the reasons ICTs are significant, as linear combinations of them are naturally equivariant. Pearce-Crump (2023b) leveraged Brauer (1937)'s theorem to obtain a spanning set for the equivariant design space. Based on this, Pearce-Crump (2023a) further proposes an algorithm to generate the equivariant-preserving operation on the tensor product space. However, a direct construction of an orthogonal equivariant basis remains unknown. This work proposes a method to efficiently obtain orthogonal bases of equivariant design spaces.

8 Discussion

8.1 Relation to other works

The remarkable work done by Pearce-Crump (2023b) has successfully found spanning sets for the equivariant design spaces for various groups. Here, we discuss the relation to this work. First, we recall the theorem for O(n):

Theorem 18 (Pearce-Crump (2023b)) $U_{i_1,j_1}U_{i_2,j_2}\dots U_{i_{\frac{l+k}{2}}j_{\frac{l+k}{2}}}$ form a spanning set for $\operatorname{Hom}_{O(n)}\left((\mathbb{R}^n)^{\otimes l},(\mathbb{R}^n)^{\otimes k}\right)$, where U are an unit matrices (also rank-2 tensors), i_i and j_i are different permutations of integer $1,\dots,\frac{l+k}{2}$. $\operatorname{Hom}_{O(n)}\left((\mathbb{R}^n)^{\otimes l},(\mathbb{R}^n)^{\otimes k}\right)=\varnothing$ when l+k is odd, so the above $\frac{l+k}{2}$ is well defined.

Compared to his theorem, we identify orthogonal bases between arbitrary spaces where the input and output spaces can be any spherical tensor product spaces, not limited to the Cartesian tensor product spaces. For example, Pearce-Crump (2023b)'s theorem cannot handle $((l=3\otimes l=4), p=-1) \rightarrow ((l=2\otimes l=2), p=-1)$, but our method can well address it, with an orthogonal basis instead of the spanning set. As he has noted, there is no equivariant operation between Cartesian spaces of odd and even ranks, respectively, while through our method we can find an orthogonal basis if their parities are the same.

There is also a striking advance made by Finzi et al. (2021), who aim to find the basis of equivariant spaces. However, they adopt a numerical algorithm, EMLP, instead of our algorithm, which provides an analytical solution. As noted by Pearce-Crump (2023b), Finzi et al. (2021) cannot generate bases for continuous group tensor product spaces with higher ranks due to memory constraints and speed limitations. To further evaluate the performance of basis generation, we compare our method with that of Finzi et al. (2021) using their open-sourced library. The results are presented in Table 4, where EMLP is able to compute the basis of $\operatorname{End}_{O(3)}\left((\mathbb{R}^{\otimes 5})\right)$ in 26 minutes. In contrast, our method computes the same basis in less than one second and is capable of obtaining the basis of $\operatorname{End}_{O(3)}\left((\mathbb{R}^{\otimes 8})\right)$.

It is worth noting that Finzi et al. (2021) claim polynomial complexity based on dimensions, whereas our complexity is determined by the ranks of the tensor product spaces.




Figure 6: The parentage scheme of decomposition of $(l = 0.5)^{\otimes n}$ for SU(2), where n is the rank. The numbers in the circle represent multiplicity.

8.2 Other groups

Although O(3) is the most popular and useful group considered in equivariant neural networks, our conclusion can also be extended to O(n), SO(n), and SU(n). The tensor product spaces can always be decomposed to smaller irreducible representation spaces, and we can always construct CG coefficients with orthogonality and normalization. The main challenge lies in obtaining the CG coefficients. Once they are obtained, the procedures outlined in this work can be repeated for those groups, and Proposition 17 will gives us the equivariant basis. Fortunately, we already have a robust method for computing CG coefficients for SU(n), proposed by Alex et al. (2011), who also provides an online service to freely compute the CG coefficients for SU(n). One can generally follow the procedure of our work to extend the method to SU(n). There are several relations between SU(n) and certain SO(n). For example, SO(3) is double covered by SU(2), which allows us to directly obtain CG coefficients for SO(3) from those for SU(2). The relationship stems from the fact that SPIN(n) double covers SO(n), and SU(2) is isomorphic to SPIN(3). Further, $SU(2) \otimes SU(2)$ is isomorphic to SPIN(4), which double covers SO(4). Similarly, SU(4) is isomorphic to SPIN(6), and thus it double covers SO(6). Consequently, the conclusion can also be extended to those SO(n) that are covered by SU(n') for high n. Further research into the Lie algebra of SO(n) has the potential to directly discover the CG coefficients of SO(n), rather than relying on the relationship with SU(n). Additionally, SO(n) can be easily converting to O(n) by considering the parity. We additionally provide code for obtaining basis for equivariant spaces under U(2)/SU(2) in our code base. The parentage scheme is different from that of O(3)/SO(3), as shown in Figure 6.

9 Conclusion

In this work, we leverage the relationship between spherical spaces and their tensor product spaces, constructing path matrices to propose methods to: 1) find high-order ICT decomposition matrices for $6 \le n \le 9$, 2) find orthogonal bases for equivariant layers where the input and output spaces are identical, and 3) generalize the conclusions to arbitrary pairs of spaces. The conclusions made in this work hold true for O(n), SO(n), and SU(n). However, currently, we can only efficiently calculate SU(n), O(3), and SO(3) due to the availability of known CG coefficients. This also highlights our future work, which will focus on achieving efficient calculations or closed-form formulae for O(n) and SO(n). The contributions of this work can be directly applied to EGNN designs as well as areas related to chemistry and physics.

10 Boarder social impact

There are several scenarios to which our theory can be applied. One of the most promising directions is the flexible design of EGNNs, which has already been shown to facilitate numerous applications in physics, chemistry, and broader biomedical fields. Examples include machine learning for force fields, drug design, blind docking, molecule generation, and many others. Additionally, there is a growing demand for equivariant methods in robotics (Wang et al., 2024). Thus, our work has the potential to positively impact these related fields. However, it is essential to establish strict regulations for methods that could potentially harm the health of people and animals.

11 Reproducibility statement

The code to efficiently implement the theory is provided in https://github.com/ShihaoShao-GH/ICT-decomposition-and-equivariant-bases. The only external dependency packages are PyTorch and e3nn. The e3nn package can be easily installed using the command pip install --upgrade e3nn. The code can run on any computer with Python version > 3.0.0 and PyTorch version > 1.0. The code for generating the basis for SU(2) does not require the e3nn package. However, the code for generating Clebsch-Gordan (CG) coefficients is borrowed from http://qutip.org/docs/3.1.0/modules/qutip/utilities.html. The CG coefficients for SU(n) can be obtained from

https://homepages.physik.uni-muenchen.de/~vondelft/Papers/ClebschGordan/, as provided by Alex et al. (2011). The code for generating these coefficients is detailed on pages 19–34 of their paper. The comparison with EMLP is based on their code base

Appendix A. Irreducible representations and spherical spaces

We first recall some basic facts. A thorough introduction to group theory can be found in Inui et al. (2012) and Bröcker and Tom Dieck (2013). We first focus on the O(3) group (3D rotation and reflection), but we also extend our conclusions to O(n), SO(n), and SU(n) in Section 8. Consider a vector $v \in V$. The rotation and reflection operations should be able to act on it. Representation theory shows that O(3) can be represented by some real matrices in the Cartesian space via a group homomorphism $\rho: G \to \mathbb{R}^{3\times 3}$, which is called the natural representation. It holds that

$$\rho(g_1 * g_2) = \rho(g_1) \cdot \rho(g_2)$$

for any $g_1, g_2 \in G$. The group element g acting on the vector v can therefore be represented as a matrix multiplication $\rho(g) \cdot v$. Sometimes, one may also refer to the space of v as a representation space. If the results of the group action remain in the same space, i.e., $\rho(g)v \in V$. In this sense, this place is also called a G-invariant space or subspace. To represent O(3), the matrix $\rho(g)$ is constrained to be orthogonal. It is important to note that the co-domain of ρ can differ, meaning it can also be represented by matrices of other dimensions. In this paper, we denote the co-domain of ρ using a subscript when it should be made explicit, e.g., $\rho_{\mathbb{R}^3}$. Now, it suffices to define equivariance. We claim that a function $f: X \to Y$ is equivariant if and only if

$$\rho_Y f(x) = f(\rho_X(x)).$$

We first focus on the simpler case where X = Y. We will later generalize this to the case where $X \neq Y$, but Y is known and remains consistent across different M. When it is necessary to emphasize the change in space, we refer to a linear mapping M as G-(X,Y)-equivariant.

We then introduce the definition of reducible and irreducible representation, in a matrix view:

Definition 19 A group homomorphism $\rho \in \text{Hom}_G(\mathbb{R}^k)$ is said to be reducible, if there is an invertible matrix M, such that for every $g \in G$, we have

$$M\rho(g)M^{-1} = \operatorname{diag}(\rho_1(g), \rho_2(g))$$

for some non-trivial ρ_1 and ρ_2 .

The 3×3 rotation and reflection matrices are irreducible. More generally,

Proposition 20 The natural representation $\{M \in GL(n, \mathbb{R}) \mid MM^T = M^TM = I\}$ of O(n) is irreducible.

If a representation is irreducible, then the vectors from the space it acts on is also said to be irreducible. Irreducible representations play a very important role in theoretical chemistry and physics, as they represent different symmetries. It is also one of the major building blocks for EGNNs in recent years. There are more irreducible representations than the natural one. Each irreducible representations space is spanned by the **real** spherical harmonics Y_{lm} as a basis of different degree l and order m. The complex spherical harmonics $Y_l^m: S^2 \to \mathbb{C}$ are the solutions of Laplace's equation, which are in the form of associated Legendre polynomials P_l^m taking spherical coordinates (θ, φ) as variables. l can take values from $(\frac{1}{2}, 1, \frac{3}{2}, \ldots)$. They are highly related to SU(2) group, which is of great importance for quantum physics. Leveraging the fact that SU(2) is a double-cover of SO(3), analysis implies that the real form of spherical harmonics Y_{lm} of integer l form a basis for weight l O(3) irreducible representation. In this case, $l \in \{1, 2, \ldots\}$, and $m \in \{-l, \ldots, l\}$. Thus O(3) has 3×3 , 5×5 ,... matrices as representations. We sometimes use (l = k) to denote a weight k spherical space. As said before, an important property of spherical harmonics is:

Proposition 21 The representation v in weight l spherical space with real spherical harmonics Y_{lm} as the basis, $v \in \operatorname{span}_{\mathbb{R}}(Y_{l,-l}, \ldots, Y_{l,l})$, is irreducible.

There is also a connection between spherical and Cartesian spaces, which is a building block of our arguments:

Lemma 22 The weight one real spherical space is exactly the 3-d Cartesian space up to an orthogonal change-of-basis.

This lemma is often utilized in engineering implementation (Thomas et al., 2018; Weiler et al., 2018; Kondor et al., 2018). In this work, it is a key connecting the spherical and Cartesian space. Also, we have the following properties:

Proposition 23 Real spherical harmonics are homogeneous polynomials, $Y_{lm} \in P_l(x, y, z)$, where l is the degree of the polynomials, and $Y_{lm} \perp Y_{l'm'}$ for $l' \neq l$ or $m' \neq m$. $\{Y_{lm}\}$ span $\binom{l+2}{2}$ -dimensional vector spaces, with unit L_2 -norms.




Figure 7: ICT decomposition matrix with path $(1 \rightarrow 1 \rightarrow 2 \rightarrow 3)$.




Figure 8: ICT decomposition matrix with path (1 \rightarrow 1 \rightarrow 2 \rightarrow 3 \rightarrow 3).




Figure 9: ICT decomposition matrix with path $(1 \to 1 \to 0 \to 1 \to 2 \to 1)$.




Figure 10: ICT decomposition matrix with path $(1 \rightarrow 2 \rightarrow 3 \rightarrow 2 \rightarrow 2 \rightarrow 1 \rightarrow 1)$.




Figure 11: ICT decomposition matrix with path $(1 \rightarrow 1 \rightarrow 1 \rightarrow 2 \rightarrow 1 \rightarrow 2 \rightarrow 2)$.




Figure 12: Equivariant basis matrix of $\operatorname{End}_{O(3)}\left(\left(\mathbb{R}^3\right)^{\otimes 6}\right)$ with paths $(1 \to 2 \to 2 \to 3 \to 3 \to 3)$ and $(1 \to 1 \to 2 \to 3 \to 4 \to 3)$.




Figure 13: Equivariant basis matrix of $\operatorname{Hom}_{O(3)}\left((l=1\otimes l=2),(l=1\otimes l=3)\right)$ with paths $(1\stackrel{2}{\to}2)$ and $(1\stackrel{3}{\to}2)$.




Figure 14: Equivariant basis matrix of $\operatorname{Hom}_{SU(2)}\left(\left(0.5\otimes0.5\otimes1.5\right),\left(0.5\otimes0.5\otimes0.5\right)\right)$ with paths $\left(0.5\stackrel{0.5}{\to}0\stackrel{1.5}{\to}1.5\right)$ and $\left(0.5\stackrel{0.5}{\to}1\stackrel{0.5}{\to}1.5\right)$.
