# THE DISTRIBUTION OF POWERS OF PRIMES RELATED TO THE FROBENIUS PROBLEM

ABSTRACT. Let  $1 < c < d$  be two relatively prime integers,  $g_{c,d} = cd - c - d$  and  $\mathbb P$  is the set of primes. For any given integer  $k \geq 1$ , we prove that

$$
\#\left\{p^k \le g_{c,d} : p \in \mathbb{P}, \ p^k = cx + dy, \ x, y \in \mathbb{Z}_{\geqslant 0}\right\} \sim \frac{k}{k+1} \frac{g^{1/k}}{\log g} \quad (\text{as } c \to \infty),
$$

which gives an extension of a recent result of Ding, Zhai and Zhao.

### 1. INTRODUCTION

Given two coprime integers  $1 < c < d$ , Sylvester [\[Syl82\]](#page-13-0) discovered in 1882 that  $cd - c - d$ represents the largest number, denoted as  $g_{c,d}$ , which cannot be expressed as  $cx+dy$   $(x, y \in \mathbb{Z}_{\geqslant 0}).$ Subsequently, the author demonstrated that for any  $0 \leq m \leq g_{c,d}$ , exactly one of m and  $g_{c,d} - m$ can be expressed in the form  $cx + dy$   $(x, y \in \mathbb{Z}_{\geqslant 0})$ . Consequently, it can be concluded that precisely half of the integers within the range  $[0, g_{c,d}]$  can be represented in this desired form.

Indeed, Sylvester's findings represent a significant breakthrough in the field of the diophantine Frobenius problem, marking the first instance of nontrivial solutions [\[RA05\]](#page-13-1). This problem seeks to find the largest integer  $g_{c_1,\dots,c_n}$  not that can be expressed as

$$
c_1x_1 + \cdots + c_nx_n
$$
  $(x_1, ..., x_n \in \mathbb{Z}_{\geq 0}),$ 

given that  $c_1, ..., c_n$  are positive integers with  $gcd(c_1, ..., c_n) = 1$ . There exists an extensive body of literature dedicated to studying the diophantine Frobenius problem. For comprehensive insights and findings on this topic, please refer to Ramírez Alfonsin's exceptional monograph [\[RA05\]](#page-13-1). Motivated by Sylvester's theorems, Ramírez Alfonsín and Skalba [\[RAS20\]](#page-13-2) investigated the Diophantine Frobenius problem restricted to prime numbers. Specifically, let  $\pi_{c,d,k}$  denote the number of k-th powers of primes not exceeding  $g_{c,d}$  with the form  $cx + dy$   $(x, y \in \mathbb{Z}_{\geq 0}).$ Through a highly enlightening argument put forth by Ramírez Alfonsín and Skalba, it has been demonstrated that for any  $\varepsilon > 0$ , there exists a constant  $k_{\varepsilon} > 0$  such that

$$
\pi_{c,d,1} \geqslant k_\varepsilon \frac{g_{c,d}}{(\log g_{c,d})^{2+\varepsilon}}.
$$

After observing the antisymmetry property of integers in the form of  $cx + dy$   $(x, y \in \mathbb{Z}_{\geq 0})$ discovered by Sylvester, they naturally formulated the following conjecture.

<span id="page-0-0"></span>**Conjecture 1.1** (Ramírez Alfonsín and Skalba). Let  $1 < c < d$  be two relatively prime integers, then

$$
\pi_{c,d,1} \sim \frac{\pi(g_{c,d})}{2} \quad (as \ c \to \infty),
$$

where  $\pi(t)$  is the number of primes up to t.

The recent proof of Conjecture [1.1](#page-0-0) by Ding, Zhai, and Zhao in [\[DZZ\]](#page-13-3) has established its validity. Prior to this, Ding [\[Din23\]](#page-13-4) demonstrated that Conjecture [1.1](#page-0-0) holds true for almost all values of c and d. Remarkably, the complete verification of Conjecture [1.1](#page-0-0) relies on the application of the classical Hardy-Littlewood method.

The main result is presented below. Throughout the remainder of this paper, let  $k \geqslant 1$  be an integer. For convenience, we write g as  $g_{c,d}$  and  $\pi_{c,d}$  as  $\pi_{c,d,k}$ . Now, we shall establish the following theorem to document our findings.

<span id="page-1-0"></span>**Theorem 1.1.** Suppose that  $d > c$  are two relatively prime integers with c sufficiently large, then we have

$$
\pi_{c,d} \sim \frac{k}{k+1} \frac{g^{1/k}}{\log g}, \quad \text{as } c \to \infty.
$$

Theorem [1.1](#page-1-0) presented herein extends the findings in [\[DZZ\]](#page-13-3) to encompass arbitrary positive integers k. The proof methodology employed in this study aligns with a recent publication by Ding, Zhai, and Zhao [\[DZZ\]](#page-13-3).

<span id="page-1-1"></span>The key input for the proof of Theorem [1.1](#page-1-0) is the following result.

**Theorem 1.2.** Let  $c, d$  be as in Theorem [1.1.](#page-1-0) Denote

$$
\mathcal{N} := \# \{ n^k \leq g_{c,d} : n^k = cx + dy, \ x, y \in \mathbb{Z}_{\geq 0} \},
$$

then we have

$$
\mathcal{N} \sim \frac{g^{1/k}}{k+1}, \quad \text{as } c \to \infty.
$$

The initial investigation will follow the customary and focus on the weighted form associated with Theorem [1.1,](#page-1-0) specifically

$$
\psi_{c,d} = \sum_{\substack{n^k \le g \\ n^k = cx + dy \\ x, y \in \mathbb{Z}_{\ge 0}}} \Lambda(n),
$$

where  $\Lambda(n)$  denotes the von Mangoldt function defined as

$$
\Lambda(n) = \begin{cases} \log p, & \text{if } n = p^{\alpha} \ (\alpha > 0); \\ 0, & \text{otherwise.} \end{cases}
$$

The proof of Theore[m1.1](#page-1-0) will be established using the following weighted formula through a standard transition method.

<span id="page-1-2"></span>**Theorem 1.3.** Let c,  $d$  be as in Theorem [1.1,](#page-1-0) then we have

$$
\psi_{c,d} \sim \frac{g^{1/k}}{k+1}, \quad \text{as } c \to \infty.
$$

The proofs heavily rely on the exponential sum estimates in  $\text{Kum06}$ , the prime number theorem, and the Siegel–Welfisz theorem.

#### 2. First transformations

We first fix some basic notations to be used frequently. From now on, we write  $g$  instead of  $g_{c,d}$  for brevity and c is supposed to be sufficiently large. Let Q denote a positive integer depending only on  $q$  which shall be decided later. Define the major arcs to be

(2.1) 
$$
\mathfrak{M}(Q) = \bigcup_{1 \leq q \leq Q} \bigcup_{\substack{1 \leq a \leq q \\ (a,q)=1}} \left\{ \alpha : \left| \alpha - \frac{a}{q} \right| \leqslant \frac{Q}{qg} \right\}.
$$

We make a further provision that  $Q < (g/2)^{1/3}$  so that the above subsets are pairwise disjoint. In fact, suppose that

$$
\left\{ \alpha : \left| \alpha - \frac{a}{q} \right| \leqslant \frac{Q}{qg} \right\} \bigcap \left\{ \alpha : \left| \alpha - \frac{a'}{q'} \right| \leqslant \frac{Q}{qg} \right\} \neq \emptyset
$$

for some  $\frac{a}{q} \neq \frac{a'}{q'}$  $\frac{a'}{q'}$ , then

$$
\frac{2Q}{g} \geqslant \frac{2Q}{qg} \geqslant \left| \frac{a}{q} - \frac{a'}{q'} \right| \geqslant \frac{1}{Q^2},
$$

which is certainly a contradiction with the provision that  $Q < (g/2)^{1/3}$ . In addition, we note that

$$
\mathfrak{M}(Q) \subseteq \left[\frac{1}{Q} - \frac{Q}{qg}, 1 + \frac{Q}{qg}\right] \subseteq \left[\frac{Q}{g}, 1 + \frac{Q}{g}\right].
$$

We can now define the minor arcs to be

(2.2) 
$$
\mathfrak{m}(Q) = \left[\frac{Q+1}{g}, 1 + \frac{Q+1}{g}\right] \setminus \mathfrak{M}(Q).
$$

For any  $\alpha \in \mathbb{R}$ , let

$$
f(\alpha) = \sum_{0 \le n^k \le g} \Lambda(n) e(\alpha n^k) \quad \text{and} \quad h(\alpha) = \sum_{\substack{0 \le x \le d \\ 0 \le y \le c}} e(\alpha(cx + dy)).
$$

By the orthogonality relation, it is clear that

<span id="page-2-2"></span>(2.3) 
$$
\psi_{c,d} = \int_0^1 f(\alpha)h(-\alpha)d\alpha = \int_{\mathfrak{M}(Q)} f(\alpha)h(-\alpha)d\alpha + \int_{\mathfrak{m}(Q)} f(\alpha)h(-\alpha)d\alpha.
$$

## 3. Estimates of the minor arcs

<span id="page-2-1"></span>The aim of this section is to prove the following proposition.

Proposition 3.1. For estimates of the minor arcs, we have

$$
\int_{\mathfrak{m}(Q)} f(\alpha)h(-\alpha)d\alpha \ll g^{(1-\rho(k))/k+\varepsilon} \log^4 g + g^{1/k} (\log g)^{\delta+4} Q^{-\frac{1}{2}+\varepsilon},
$$

where  $\varepsilon > 0$  is arbitrarily small.

<span id="page-2-0"></span>We need two lemmas listed below.

**Lemma 3.1.** Let  $k \geq 2$ , and  $\rho(k)$  defined as follows,

$$
\rho(k) = \begin{cases} \frac{1}{8}, & \text{if } k = 2; \\ \frac{1}{14}, & \text{if } k = 3; \\ \frac{2}{3} \times 2^{-k}, & \text{if } k \ge 4. \end{cases}
$$

Then for any fixed  $\varepsilon > 0$ , we have

$$
\sup_{\alpha \in \mathfrak{m}(Q)} |f(\alpha)| \ll \log^2 g \big( g^{(1-\rho(k))/k+\varepsilon} + g^{1/k} (\log g)^{\delta} Q^{-\frac{1}{2}+\varepsilon} \big),
$$

where  $\delta > 0$  is an absolute constant and the implied constant depends at most on k and  $\varepsilon$ .

*Proof.* Plugging in the definition of  $\Lambda(n)$ , we have

$$
f(\alpha) = \sum_{m=1}^{\infty} \sum_{p^m \leqslant g^{1/k}} \Lambda(p^m) e(\alpha p^{mk}) = \sum_{m \leqslant \frac{\log g}{k \log 2}} \sum_{p \leqslant g^{1/mk}} \log p e(\alpha p^{mk}).
$$

For  $m \geqslant 2$ , it is clear that

<span id="page-3-4"></span>
$$
\sum_{2 \leqslant m \leqslant \frac{\log g}{k \log 2}} \sum_{p \leqslant g^{1/mk}} \log p \, e(\alpha p^{mk}) \ll g^{1/2k} \log^2 g.
$$

Thus

(3.1) 
$$
f(\alpha) = \sum_{p \leqslant g^{1/k}} \log g \, e(\alpha p^k) + O(g^{1/2k} \log^2 g).
$$

On applying the partial summation formula, we have

(3.2) 
$$
\sum_{p \leqslant g^{1/k}} \log p e(\alpha p^k) = \frac{\log g}{k} \sum_{p \leqslant g^{1/k}} e(\alpha p^k) - \int_2^{g^{1/k}} \sum_{p \leqslant \gamma} e(\alpha p^k) \frac{d\gamma}{\gamma}.
$$

By the Dirichlet approximation theorem, there exist  $b \in \mathbb{Z}$  and  $r \in \mathbb{N}$  such that

<span id="page-3-5"></span>
$$
(b,r) = 1
$$
,  $1 \le r \le R$  and  $\left| \alpha - \frac{b}{r} \right| \le \frac{1}{rR}$ ,

where

<span id="page-3-3"></span>
$$
R = \begin{cases} g^{3/2k}, & \text{if } k = 2; \\ g^{(k-2\rho(k))/(2k-1)}, & \text{if } k \ge 3. \end{cases}
$$

Then by Theorem 3 in [\[Kum06\]](#page-13-5), for any fixed  $\varepsilon > 0$ , we conclude

(3.3) 
$$
\sum_{g^{1/k} \leq p \leq 2g^{1/k}} e(\alpha p^k) \ll g^{(1-\rho(k))/k+\varepsilon} + \frac{r^{\varepsilon} g^{1/k} (\log g)^{\delta}}{(r+g|r\alpha-b|)^{1/2}},
$$

where  $\delta > 0$  is an absolute constant. If  $r > Q$ , then

<span id="page-3-0"></span>(3.4) 
$$
\sum_{g^{1/k} \leq p \leq 2g^{1/k}} e(\alpha p^k) \ll g^{(1-\rho(k))/k+\varepsilon} + g^{1/k} (\log g)^{\delta} Q^{-\frac{1}{2}+\varepsilon}
$$

Similarly, if  $1 \leq r \leq Q$  and  $|\alpha - b/r| > \frac{Q}{r_c}$  $\frac{Q}{rg}$ , then [\(3.4\)](#page-3-0) hold as well. From now on, we assume that

.

.

(3.5) 
$$
1 \leq r \leq Q
$$
 and  $\left| \alpha - \frac{b}{r} \right| \leq \frac{Q}{rg}$ 

By the Dirichlet approximation theorem, there exist  $a \in \mathbb{Z}$  and  $q \in \mathbb{N}$  such that

(3.6) 
$$
(a, q) = 1, \quad 1 \leq q \leq g^{1/2} \text{ and } \left| \alpha - \frac{a}{q} \right| \leq \frac{1}{q g^{1/2}}.
$$

We deduce from  $(3.5)$  and  $(3.6)$  that

<span id="page-3-2"></span><span id="page-3-1"></span>
$$
\left|\frac{b}{r} - \frac{a}{q}\right| \leq \left|\alpha - \frac{b}{r}\right| + \left|\alpha - \frac{a}{q}\right|
$$
  

$$
\leq \frac{Q}{rg} + \frac{1}{qg^{1/2}} = \frac{1}{rq} \left(\frac{qQ}{g} + \frac{r}{g^{1/2}}\right)
$$
  

$$
\leq \frac{Q}{rqg^{1/2}} < \frac{1}{rq}.
$$

It follows that

<span id="page-4-0"></span>
$$
(3.7) \t\t a = b \t and \t r = q
$$

We obtain from  $(3.3)$  and  $(3.7)$  that

(3.8) 
$$
\sum_{g^{1/k} \leq p \leq 2g^{1/k}} e(\alpha p^k) \ll g^{(1-\rho(k))/k+\varepsilon} + \frac{r^{\varepsilon} g^{1/k} (\log g)^{\delta}}{(q+g|q\alpha-a|)^{1/2}},
$$

Since  $\alpha \in \mathfrak{m}(Q)$ , we further obtain

$$
\sum_{g^{1/k} \leqslant p \leqslant 2g^{1/k}} e(\alpha p^k) \ll g^{(1-\rho(k))/k + \varepsilon} + g^{1/k} (\log g)^{\delta} Q^{-\frac{1}{2} + \varepsilon}.
$$

Then we deduce that

$$
\sum_{p \leq g^{1/k}} e(\alpha p^k) = \sum_{1 \leq p \leq g^{1/k}/Q} e(\alpha p^k) + \sum_{g^{1/k}/Q < p \leq g^{1/k}} e(\alpha p^k)
$$
\n
$$
\ll \frac{g^{1/k}}{Q} + \sum_{1 \leq \kappa \leq \frac{\log Q}{\log 2}} \left| \sum_{\frac{g^{1/k}}{2^{\kappa-1}} < p \leq \frac{g^{1/k}}{2^{\kappa}}} e(\alpha p^k) \right|
$$
\n
$$
\ll g^{(1-\rho(k))/k + \varepsilon} + g^{1/k} (\log g)^{\delta} Q^{-\frac{1}{2} + \varepsilon}.
$$

Employing this estimate, we deduce by  $(3.1)$  and  $(3.2)$  that

$$
\sup_{\alpha \in \mathfrak{m}(Q)} |f(\alpha)| \ll g^{(1-\rho(k))/k + \varepsilon} \log^2 g + g^{\frac{1}{k}} (\log g)^{\delta+2} Q^{-\frac{1}{2}+\varepsilon}.
$$

<span id="page-4-1"></span>This completes the proof of Lemma [3.1.](#page-2-0)

Lemma 3.2. We have

$$
\int_0^1 |h(-\alpha)| d\alpha \ll \log^2 g.
$$

*Proof.* This is Lemma 3.2 in [\[DZZ\]](#page-13-3).

Proof of Proposition [3.1.](#page-2-1) The treatment of the minor arcs benefits from the following trivial estimates

$$
\left| \int_{\mathfrak{m}(Q)} f(\alpha)h(-\alpha) d\alpha \right| \leq \sup_{\alpha \in \mathfrak{m}(Q)} |f(\alpha)| \int_0^1 |h(-\alpha)| d\alpha
$$

together with Lemma [3.1](#page-2-0) and Lemma [3.2.](#page-4-1)

## 4. Calculations of the major arcs

We now calculate the integral on the major arcs.

<span id="page-4-2"></span>**Proposition 4.1.** For  $Q < c^{1/3}$ , we have

$$
\int_{\mathfrak{M}(Q)} f(\alpha)h(-\alpha)d\alpha = \mathcal{N} + O\Big(g^{1/k}Q^2 \exp\big(-\kappa_1\sqrt{\log g}\big) + g^{1/k}(\log g)^3 Q^{-2^{1-k}+\varepsilon} + dQ^3\Big),
$$

where  $\kappa_1 > 0$  is an absolute constant.

For any  $\alpha \in \mathbb{R}$ , we define

$$
F(\alpha) := \sum_{0 \leqslant n^k \leqslant g} e(\alpha n^k).
$$

<span id="page-5-0"></span>**Lemma 4.1.** For any real number  $\beta$ , we have

$$
\int_{-\frac{Q}{g}}^{\frac{Q}{g}} f(\beta)h(-\beta) d\beta = \int_{-\frac{Q}{g}}^{\frac{Q}{g}} F(\beta)h(-\beta) d\beta + O\left(g^{1/k}Q^2 \exp\left(-\kappa_1\sqrt{\log g}\right)\right),
$$

where  $\kappa_1 > 0$  is an absolute constant.

*Proof.* Let  $a_n = \Lambda(n) - 1$ . Then for any real number  $\beta$ , we have

$$
f(\beta) - F(\beta) = \sum_{0 \le n^k \le g} a_n e(\beta n^k).
$$

By partial summation, we have

$$
\sum_{0 \le n^k \le g} a_n e(\beta n^k) = \sum_{0 \le n \le g^{1/k}} a_n e(\beta n^k)
$$
  
=  $e(\beta g^k) \sum_{0 \le n \le g^{1/k}} a_n - 2\pi i k \beta \int_0^{g^{1/k}} \left(\sum_{0 \le n \le t} a_n\right) e(\beta t^k) t^{k-1} dt.$ 

Using the prime number theorem, there exists some absolute constant  $\kappa_1 > 0$  so that

$$
\sum_{0 \le n \le t} a_n = \psi(t) - t \ll t \exp\left(-\kappa_1 \sqrt{\log t}\right).
$$

We deduce that

$$
f(\beta) = F(\beta) + O\left(g^{1/k}(1 + k|\beta|g) \exp\left(-\kappa_1 \sqrt{\log g}\right)\right).
$$

Then we arrive at

$$
\int_{-\frac{Q}{g}}^{\frac{Q}{g}} f(\beta)h(-\beta) d\beta = \int_{-\frac{Q}{g}}^{\frac{Q}{g}} F(\beta)h(-\beta) d\beta + \mathcal{R}(\beta),
$$

where the error term  $\mathcal{R}(\beta)$  can be bounded easily by the trivial estimates as

$$
\mathcal{R}(\beta) \ll \int_{-\frac{Q}{g}}^{\frac{Q}{g}} g^{1/k} (1 + k|\beta|g) \exp\left(-\kappa_1 \sqrt{\log g}\right) |h(-\beta)| d\beta
$$
  
\$\ll \int\_{-\frac{Q}{g}}^{\frac{Q}{g}} g^{1/k} (1 + k|\beta|g) \exp\left(-\kappa\_1 \sqrt{\log g}\right) g d\beta\$  
\$\ll g^{1+1/k} Q \exp\left(-\kappa\_1 \sqrt{\log g}\right) \int\_{-\frac{Q}{g}}^{\frac{Q}{g}} 1 d\beta\$  
\$\ll g^{1/k} Q^2 \exp\left(-\kappa\_1 \sqrt{\log g}\right).

<span id="page-5-1"></span>This completes the proof of Lemma [4.1.](#page-5-0)  $\Box$ 

**Lemma 4.2.** Let  $2 \leq q \leq Q$ ,  $(a,q) = 1$  and  $|\beta| \leq Q/(qg)$ . For  $Q < c^{1/3}$ , we have

$$
h\left(-\frac{a}{q} - \beta\right) \ll qd.
$$

Proof. Recall that

$$
h(-\alpha) = \sum_{x \le d} e(-\alpha cx) \sum_{y \le c} e(-\alpha dy) \ll \min\{d, ||c\alpha||^{-1}\} \min\{c, ||d\alpha||^{-1}\},\
$$

hence we have

$$
h\left(-\frac{a}{q}-\beta\right) \ll \min\left\{d, \left\|c\left(-\frac{a}{q}-\beta\right)\right\|^{-1}\right\} \min\left\{c, \left\|d\left(-\frac{a}{q}-\beta\right)\right\|^{-1}\right\}.
$$

Since  $(a, q) = 1$ , we would have

$$
\left\| c \left( -\frac{a}{q} - \beta \right) \right\| \geqslant \frac{1}{2q} \quad \text{if} \quad q \nmid c
$$

and

$$
\left\| d \left( -\frac{a}{q} - \beta \right) \right\| \geqslant \frac{1}{2q} \quad \text{if} \quad q \nmid d
$$

for  $q \ge 2$  and  $|\beta| \le Q/(qg)$ , provided that  $Q \le c^{1/3}$ . Recall that  $(c,d) = 1$ , thus at least one of the above inequalities is admissible. Therefore, for all  $2 \leq q \leq Q$ ,  $(a, q) = 1$  and  $|\beta| \leq Q/(qg)$ we have

$$
h\left(-\frac{a}{q} - \beta\right) \ll qd.
$$

<span id="page-6-1"></span>This completes the proof of Lemma [4.2.](#page-5-1)

**Lemma 4.3.** For any real number  $\beta$ , we have

$$
\mathcal{N} = \int_{-\frac{Q}{g}}^{\frac{Q}{g}} F(\beta)h(-\beta) d\beta + O(g^{1/k}(\log g)^3 Q^{-2^{1-k}+\varepsilon} + dQ^3).
$$

Proof. By the orthogonality relation, it is clear that

$$
\mathcal{N} = \int_{-1/2}^{1/2} F(\alpha)h(-\alpha)d\alpha = \int_{\mathfrak{M}(Q)} F(\alpha)h(-\alpha)d\alpha + \int_{\mathfrak{m}(Q)} F(\alpha)h(-\alpha)d\alpha.
$$

We firstly consider the major arc

$$
\int_{\mathfrak{M}(Q)} F(\alpha)h(-\alpha)d\alpha = \sum_{1 \leq q \leq Q} \sum_{\substack{1 \leq a \leq q \\ (a,q)=1}} \int_{-\frac{Q}{qg}}^{\frac{Q}{qg}} F\left(\frac{a}{q} + \beta\right)h\left(-\frac{a}{q} - \beta\right)d\beta.
$$

The term of the above sum for  $a = q = 1$  equals

$$
\int_{-\frac{Q}{g}}^{\frac{Q}{g}} F(1+\beta) h(-1-\beta) d\beta = \int_{-\frac{Q}{g}}^{\frac{Q}{g}} F(\beta) h(-\beta) d\beta.
$$

The sums for  $2 \leqslant q \leqslant Q$  contributes error terms. By Lemma [4.2,](#page-5-1) we can conclude that

$$
\sum_{2 \leqslant q \leqslant Q} \sum_{\substack{1 \leqslant a \leqslant q \\ (a,q)=1}} \int_{-\frac{Q}{qg}}^{\frac{Q}{qg}} F\left(\frac{a}{q} + \beta\right) h\left(-\frac{a}{q} - \beta\right) d\beta \ll \sum_{2 \leqslant q \leqslant Q} \sum_{\substack{1 \leqslant a \leqslant q \\ (a,q)=1}} \int_{-\frac{Q}{qg}}^{\frac{Q}{qg}} g dq \ d\beta \ll dQ^3.
$$

It is now time to estimate the minor arc. Let  $T = g^{1/k}$ . By the Dirichlet approximation theorem, there exist  $s \in \mathbb{Z}$  and  $t \in \mathbb{N}$  such that

<span id="page-6-0"></span>
$$
(s,t) = 1
$$
,  $1 \le t \le 2T^{k-1}$  and  $\left| \alpha - \frac{s}{t} \right| \le \frac{1}{2tT^{k-1}}$ .

Then by Lemma 6.4 in [\[LZ23\]](#page-13-6), for any fixed  $\varepsilon > 0$  we conclude

(4.1) 
$$
F(\alpha) \ll g^{(1-2^{1-k})/k+\varepsilon} + \frac{t^{\varepsilon} g^{1/k} (\log g)}{(t+g|t\alpha-s|)^{2^{1-k}}}.
$$

If  $t > Q$ , then

(4.2) 
$$
F(\alpha) \ll g^{1/k} (\log g) Q^{-2^{1-k}+\varepsilon}.
$$

Similarly, if  $1 \leq t \leq Q$  and  $|\alpha - s/t| > \frac{Q}{tT}$  $\frac{Q}{tT^k}$ , then [\(4.2\)](#page-7-0) hold as well. Therefore, we next assume

.

.

(4.3) 
$$
1 \leq t \leq Q
$$
 and  $\left|\alpha - \frac{s}{t}\right| \leq \frac{Q}{tT^k}$ 

By the Dirichlet approximation theorem, there exist  $a \in \mathbb{Z}$  and  $q \in \mathbb{N}$  such that

(4.4) 
$$
(a,q) = 1, \quad 1 \leqslant q \leqslant T^{k/2} \quad \text{and} \quad \left|\alpha - \frac{a}{q}\right| \leq \frac{1}{qT^{k/2}}.
$$

We deduce from  $(4.3)$  and  $(4.4)$  that

<span id="page-7-2"></span><span id="page-7-1"></span><span id="page-7-0"></span>
$$
\begin{aligned} \left| \frac{s}{t} - \frac{a}{q} \right| &\leq \left| \alpha - \frac{s}{t} \right| + \left| \alpha - \frac{a}{q} \right| \\ &\leq \frac{Q}{tT^k} + \frac{1}{qT^{k/2}} = \frac{1}{tq} \left( \frac{qQ}{T^k} + \frac{t}{T^{k/2}} \right) \\ &\leq \frac{Q}{tqT^{k/2}} < \frac{1}{tq}. \end{aligned}
$$

It follows that

<span id="page-7-3"></span> $(s=1, 5)$  s = a and  $t = q$ 

We obtain from  $(4.1)$  and  $(4.5)$  that

(4.6) 
$$
F(\alpha) \ll g^{(1-2^{1-k})/k+\varepsilon} + \frac{t^{\varepsilon}g^{1/k}(\log g)}{(q+g|q\alpha-a|)^{2^{1-k}}}
$$

Since  $\alpha \in \mathfrak{m}(Q)$ , we further obtain

$$
F(\alpha) \ll g^{1/k} (\log g) Q^{-2^{1-k} + \varepsilon}.
$$

By Lemma [3.2,](#page-4-1) we have

$$
\int_0^1 |h(-\alpha)| d\alpha \ll (\log g)^2.
$$

The treatment of the minor arcs benefits from the following trivial estimates

$$
\left| \int_{\mathfrak{m}(Q)} F(\alpha) h(-\alpha) d\alpha \right| \ll \sup_{\alpha \in \mathfrak{m}(Q)} |F(\alpha)| \int_0^1 |h(-\alpha)| d\alpha
$$
  

$$
\ll g^{1/k} (\log g)^3 Q^{-2^{1-k} + \varepsilon}.
$$

<span id="page-7-4"></span>This completes the proof of Lemma [4.3.](#page-6-1)

**Lemma 4.4.** For any  $\ell \leq g$ , let  $\mathcal{K}_{\ell}$  be the number of integers of  $0 \leq n \leq \ell$  which can be represented as  $cx + dy$  with  $x, y \in \mathbb{Z}_{\geqslant 0}$ . Then

$$
\mathcal{K}_{\ell} = \sum_{i=1}^{\lfloor \ell/d \rfloor} \left( \left\lfloor \frac{\ell - id}{c} \right\rfloor + 1 \right).
$$

*Proof.* For any  $i \leq \lfloor \ell/d \rfloor$ , the number of  $j \in \mathbb{Z}_{\geqslant 0}$ , so that

$$
jc + id \leqslant \ell
$$

is exactly

$$
\left\lfloor \frac{\ell - id}{c} \right\rfloor + 1.
$$

The lemma now follows immediately by a sum of j from 0 to  $\lfloor \ell/d \rfloor$ .

Then we deduce that the asymptotic formula of  $N$ .

Proof of Theorem [1.2.](#page-1-1) By the orthogonality relation, we get

$$
\mathcal{N} = \int_{-1/2}^{1/2} F(\alpha)h(-\alpha)d\alpha = \int_{\mathfrak{M}(Q)} F(\alpha)h(-\alpha)d\alpha + \int_{\mathfrak{m}(Q)} F(\alpha)h(-\alpha)d\alpha.
$$

We firstly consider the major arc

$$
\int_{\mathfrak{M}(Q)} F(\alpha)h(-\alpha)d\alpha = \sum_{1 \leq q \leq Q} \sum_{\substack{1 \leq a \leq q \\ (a,q)=1}} \int_{-\frac{Q}{qg}}^{\frac{Q}{qg}} F\left(\frac{a}{q} + \beta\right) h\left(-\frac{a}{q} - \beta\right)d\beta.
$$

By Theorem 4.1 of [\[Vau97\]](#page-13-7) we have

$$
F(\alpha) = S(q, a)v(\beta) + O(q^{1/2 + \varepsilon}(1 + g|\beta|)^{1/2}),
$$

where

$$
S(q, a) = \frac{1}{q} \sum_{n=1}^{q} e\left(\frac{an^k}{q}\right) \quad \text{and} \quad v(\beta) = \frac{1}{k} \sum_{n \leq g} n^{1/k - 1} e(\beta n).
$$

Thus

$$
\int_{\mathfrak{M}(Q)} F(\alpha)h(-\alpha)\mathrm{d}\alpha = \sum_{1\leqslant q\leqslant Q}\sum_{\substack{1\leqslant a\leqslant q\\ (a,q)=1}} S(q,a)\int_{-\frac{Q}{qg}}^{\frac{Q}{qg}}v(\beta)h\left(-\frac{a}{q}-\beta\right)\mathrm{d}\beta + \Re(\beta).
$$

where the error term  $\mathfrak{R}(\beta)$  can be bounded as

$$
\Re(\beta) \ll \int_{-\frac{Q}{q_g}}^{\frac{Q}{q_g}} q^{1/2+\varepsilon} (1+g|\beta|)^{1/2} \left| h\left(-\frac{a}{q} - \beta\right) \right| d\beta
$$
  
\$\ll \int\_{-\frac{Q}{q\_g}}^{\frac{Q}{q\_g}} q^{1/2+\varepsilon} (1+g|\beta|)^{1/2} g d\beta\$  
\$\ll \frac{Q^{3/2}}{q^{1-\varepsilon}}.\$

By using Lemma [4.2,](#page-5-1) we can conclude that

$$
\sum_{2 \leq q \leq Q} \sum_{\substack{1 \leq a \leq q \\ (a,q)=1}} S(q,a) \int_{-\frac{Q}{qg}}^{\frac{Q}{qg}} v(\beta) h\left(-\frac{a}{q} - \beta\right) d\beta
$$
  
\$\ll \sum\_{2 \leq q \leq Q} \sum\_{\substack{1 \leq a \leq q \\ (a,q)=1}} \int\_{-\frac{Q}{qg}}^{\frac{Q}{qg}} g^{1/k} dq \ d\beta \ll dQ^3 g^{1/k-1}.

Let  $a = q = 1$ , we have

<span id="page-8-0"></span>(4.7) 
$$
\int_{-1/2}^{1/2} F(\alpha)h(-\alpha)d\alpha = \int_{-\frac{Q}{g}}^{\frac{Q}{g}} v(\beta)h(-\beta)d\beta + O\left(dQ^3g^{1/k-1} + \frac{Q^{3/2}}{q^{1-\epsilon}}\right).
$$

By writing

(4.8) 
$$
\int_{-\frac{Q}{g}}^{\frac{Q}{g}} v(\beta)h(-\beta) d\beta = \int_{-1/2}^{1/2} v(\beta)h(-\beta) d\beta + \Re_1(\beta) + \Re_2(\beta),
$$

where

<span id="page-9-0"></span>
$$
\mathfrak{R}_1(\beta) = \int_{\frac{Q}{g}}^{1/2} v(\beta)h(-\beta) d\beta \quad \text{and} \quad \mathfrak{R}_2(\beta) = \int_{-1/2}^{-\frac{Q}{g}} v(\beta)h(-\beta) d\beta.
$$

Note that

$$
\int_{-1/2}^{1/2} v(\beta)h(-\beta) d\beta = \sum_{\substack{0 \le n \le g \\ 0 \le x \le d, \ 0 \le y \le c}} \frac{n^{1/k-1}}{k} \int_0^1 e\Big(\beta\big(n - cx - dy\big)\Big) d\beta.
$$

By the orthogonality relation, the above integral equals 1 if  $n = cx + dy$  and 0 otherwise. Hence, by the result of Sylverter [\[Syl82\]](#page-13-0) as we mentioned at the beginning of the introduction, we get

$$
\sum_{\substack{0 \le n \le g \\ 0 \le x \le d, \ 0 \le y \le c}} \int_0^1 e\Big(\beta\big(n - cx - dy\big)\Big) d\beta = \frac{g+1}{2}.
$$

By Lemma [4.4](#page-7-4) and partial summations, we have

$$
\sum_{0 \le n \le g} \frac{n^{1/k-1}}{k} \int_0^1 e(\beta(n - cx - dy)) d\beta
$$
\n
$$
= \frac{1}{k} \int_0^g t^{1/k-1} dK_t
$$
\n
$$
= \frac{g^{1/k-1}}{k} K_g - \frac{1}{k} \int_0^g K_t dt^{1/k-1}
$$
\n
$$
= \frac{g^{1/k-1}}{k} \frac{g+1}{2} - \frac{1}{k} \left(1 - \frac{1}{k}\right) \int_0^g \sum_{i=1}^{\lfloor t/d \rfloor} \left(\left\lfloor \frac{t - id}{c} \right\rfloor + 1\right) t^{1/k-2} dt
$$
\n
$$
= \frac{1}{k+1} \frac{g^{1/k-1}}{cd} + O_k \left(\frac{g^{1/k}}{c} + \frac{g^{1/k}}{d}\right)
$$
\n
$$
= \frac{1}{k+1} \frac{g^{1/k-1}}{cd} + O_k \left(\frac{g^{1/k}}{c} + \frac{g^{1/k}}{d}\right)
$$
\n
$$
\sim \frac{g^{1/k}}{k+1}, \text{ as } c \to \infty.
$$

Suppose that  $|\beta| \leq 1/2$ . By Lemma 2.8 of [\[Vau97\]](#page-13-7) we have

$$
v(\beta) \ll \min\{g^{1/k}, |\beta|^{-1/k}\}.
$$

For  $\frac{Q}{g} \leqslant \beta \leqslant \frac{1}{2}$  $\frac{1}{2}$ , using the Lemma [3.2,](#page-4-1) we deduce that

<span id="page-9-1"></span>(4.9) 
$$
\Re_1(\beta) \ll \int_{\frac{Q}{g}}^{1/2} \beta^{-1/k} |h(-\beta)| d\beta \leqslant \left(\frac{g}{Q}\right)^{1/k} \int_0^1 |h(-\beta)| d\beta \leqslant \left(\frac{g}{Q}\right)^{1/k} (\log g)^2,
$$

The same treatment would also lead to the estimate  $\Re_2(\beta) \leq (g/Q)^{1/k} (\log g)^2$ . And then the combination of  $4.7$ ,  $4.8$  and  $4.9$  along with the selected  $Q$  from section  $5$  yields

$$
\mathcal{N} \sim \frac{g^{1/k}}{k+1}
$$
, as  $c \to \infty$ .

This completes the proof of Theorem [1.2.](#page-1-1)  $\Box$ 

Proof of Proposition [4.1.](#page-4-2) Recall that

$$
\int_{\mathfrak{M}(Q)} f(\alpha)h(-\alpha)d\alpha = \sum_{1 \leq q \leq Q} \sum_{\substack{1 \leq a \leq q \\ (a,q)=1}} \int_{\frac{a}{q} - \frac{Q}{qg}}^{\frac{a}{q} + \frac{Q}{qg}} f(\alpha)h(-\alpha)d\alpha
$$

$$
= \sum_{\substack{1 \leq q \leq Q \\ (a,q)=1}} \sum_{\substack{1 \leq a \leq q \\ (a,q)=1}} \int_{-\frac{Q}{qg}}^{\frac{Q}{qg}} f\left(\frac{a}{q} + \beta\right)h\left(-\frac{a}{q} - \beta\right)d\beta.
$$

In the above expression, the main contribution of the above sum comes form  $a = q = 1$ 

$$
\int_{-\frac{Q}{g}}^{\frac{Q}{g}} f(1+\beta) h(-1-\beta) d\beta = \int_{-\frac{Q}{g}}^{\frac{Q}{g}} f(\beta) h(-\beta) d\beta.
$$

By Lemmas [4.1](#page-5-0)[–4.3,](#page-6-1) we have

$$
\int_{\mathfrak{M}(Q)} f(\alpha)h(-\alpha)d\alpha = \int_{-1/2}^{1/2} F(\alpha)h(-\alpha)d\alpha + O\Big(g^{1/k}Q^2 \exp\big(-\kappa_1\sqrt{\log g}\big) + g^{1/k}(\log g)^3 Q^{-2^{1-k}+\varepsilon} + dQ^3\Big).
$$

This completes the proof.  $\Box$ 

### 5. Proofs of Theorem [1.1](#page-1-0) and Theorem [1.3](#page-1-2)

<span id="page-10-1"></span><span id="page-10-0"></span>**Lemma 5.1.** For positive integers  $c$ , we have

$$
\sum_{\substack{1 \le y \le c \\ (y,c)=1}} \frac{y^{1/k}}{\varphi(c)} = \frac{k}{k+1} c^{1/k} + O(1).
$$

Proof. By Euler-Maclaurin formula, we obtain that

$$
\sum_{0 < k \le l} m^{1/k} = \int_0^l x^{1/k} dx + \int_0^l (x - [x] - \frac{1}{2}) \frac{1}{k} x^{1/k - 1} dx - (l - [l] - \frac{1}{2}) f(l)
$$
\n
$$
= \frac{k}{k+1} l^{1+1/k} + O(l^{1/k}).
$$

Therefore using the well-known identity of Möbius' function, we have

$$
\sum_{\substack{1 \le y \le c \\ (y,c)=1}} \frac{y^{1/k}}{\varphi(c)} = \frac{1}{\varphi(c)} \sum_{y \le c} y^{1/k} \sum_{\substack{d|y \\ d|c}} \mu(d)
$$
\n
$$
= \frac{1}{\varphi(c)} \sum_{d|c} \mu(d) \sum_{\substack{y \le c \\ d|y}} y^{1/k}
$$
\n
$$
= \frac{1}{\varphi(c)} \sum_{d|c} \mu(d) \left(\frac{k}{k+1} l^{1+1/k} + O(l^{1/k})\right) d^{1/k}
$$
\n
$$
= \frac{k}{k+1} \frac{c^{1+1/k}}{\varphi(c)} \sum_{d|c} \frac{\mu(d)}{d} + \frac{1}{\varphi(c)} \sum_{d|c} \mu(d) O(c^{1/k})
$$
\n
$$
= \frac{k}{1+k} c^{1/k} + O(1).
$$

 $\Box$ 

*Proof of Theorem [1.3.](#page-1-2)* By  $(2.3)$ , Proposition [3.1](#page-2-1) and Proposition [4.1,](#page-4-2) we have

$$
\psi_{c,d} = \mathcal{N} + O\Big(g^{1/k} Q^2 \exp\Big(-\kappa_1 \sqrt{\log g}\Big) + g^{1/k} (\log g)^3 Q^{-2^{1-k} + \varepsilon} + dQ^3 + g^{(1-\rho(k))/k + \varepsilon} (\log g)^4 + g^{1/k} (\log g)^{\delta+4} Q^{-1/2 + \varepsilon}\Big),
$$

where  $Q \leq c^{1/3}$ . Let  $m = \max\{3 \cdot 2^{k-1}, [2\delta + 8] \} + 1$  and choose  $Q = (\log g)^m$ . Then

<span id="page-11-1"></span>(5.1) 
$$
\psi_{c,d} = \mathcal{N} + O\left(\frac{g^{1/k}}{\log g}\right),\,
$$

provided that  $c \geq (\log g)^{m+1}$ .

For the complement of our proof, it remains to consider the case that  $c \leq (\log g)^{m+1}$ . Using Lemma  $5.1$ , we have

<span id="page-11-0"></span>
$$
\psi_{c,d} = \sum_{\substack{n^k = cx + dy \\ n^k \le g \\ x, y \in \mathbb{Z}_{\ge 0}}} \Lambda(n)
$$
\n
$$
= \sum_{\substack{1 \le y \le c \\ (y,c) = 1}} \sum_{\substack{n^k = dy \\ dy \le n^k \le g}} \Lambda(n) + O(1)
$$
\n
$$
= \sum_{\substack{1 \le y \le c \\ (y,c) = 1}} \left( \psi(g^{1/k}; c, dy) - \psi((dy)^{1/k}; c, dy) \right) + O(1)
$$
\n
$$
= \psi(g^{1/k}) - \sum_{\substack{1 \le y \le c \\ (y,c) = 1}} \psi((dy)^{1/k}; c, dy) + O(1).
$$

Now, for  $c \leq (\log g)^{m+1} \ll (\log d)^{m+1}$ , by the Siegel–Walfisz theorem we have

$$
\sum_{\substack{1 \le y \le c \\ (y,c)=1}} \psi((dy)^{1/k}; c, dy) = \sum_{\substack{1 \le y \le c \\ (y,c)=1}} \left( \frac{(dy)^{1/k}}{\varphi(c)} + O\left((dy)^{1/k} \exp(-\kappa_2 \sqrt{\log g})\right) \right)
$$

$$
= \frac{k}{k+1} g^{1/k} + O\left(\frac{g^{1/k}}{c^{1/k}} + g^{1/k} \exp\left(-\kappa_3 \sqrt{\log g}\right)\right),
$$

where  $\kappa_2$  and  $\kappa_3$  are two positive integers with  $\kappa_3 < \kappa_2$ . Since

$$
\psi(g^{1/k}) = g^{1/k} + O\left(g^{1/k} \exp\left(-\kappa_4 \sqrt{\log g}\right)\right)
$$

by the prime number theorem, we finally conclude from [\(5.2\)](#page-11-0) that

<span id="page-12-0"></span>(5.3) 
$$
\psi_{c,d} = \frac{1}{k+1} g^{1/k} + O\left(\frac{g^{1/k}}{c^{1/k}} + g^{1/k} \exp\left(-\kappa_5 \sqrt{\log g}\right)\right)
$$

for  $c \leq (\log g)^{m+1}$ , where  $\kappa_5 = \min{\kappa_3, \kappa_4}.$ 

From  $(5.1)$  and  $(5.3)$ , we proved that

$$
\psi_{c,d} \sim \mathcal{N}
$$
, as  $c \to \infty$ .

This completes the proof of Theorem [1.3.](#page-1-2)

*Proof of Theorem [1.1.](#page-1-0)* For  $t \leq g$ , let

$$
\vartheta_{a,b}(t) = \sum_{\substack{p^k = ax + by \\ p^k \le t \\ x, y \in \mathbb{Z}_{\ge 0}}} \log p \text{ and } \vartheta_{a,b} = \vartheta_{a,b}(g).
$$

Integrating by parts, we obtain that

<span id="page-12-1"></span>(5.4) 
$$
\pi_{a,b} = \sum_{\substack{p^k = ax + by \\ p^k \leq g \\ x, y \in \mathbb{Z}_{\geq 0}}} 1 = \frac{\vartheta_{a,b}}{\log g^{1/k}} + \int_2^{g^{1/k}} \frac{\vartheta_{a,b}(t)}{t \log^2 t} dt.
$$

By the Chebyshev estimate, we have

$$
\vartheta_{a,b}(t)\leqslant \sum_{p^{1/k}\leqslant t} \log p\ll t^{1/k},
$$

from which it follows that

(5.5) 
$$
\int_{2}^{g^{1/k}} \frac{\vartheta_{a,b}(t)}{t \log^{2} t} dt \ll \int_{2}^{g^{1/k}} \frac{t^{1/k}}{t \log^{2} t} dt \ll \int_{2}^{g^{1/k}} \frac{1}{\log^{2} t} dt \ll \frac{g^{1/k}}{\log^{2} g}.
$$

Again, using the Chebyshev estimate, we have

(5.6) 
$$
\vartheta_{a,b} = \psi_{a,b} + O\left(\sqrt{g^{1/k}}\right)
$$

Thus, by Theorem  $1.2$  and  $(5.4)$ – $(5.6)$ , we conclude that

<span id="page-12-2"></span>
$$
\pi_{a,b} = \frac{\psi_{a,b}}{\log g^{1/k}} + O\left(\frac{\sqrt{g^{1/k}}}{\log g^{1/k}} + \frac{g^{1/k}}{\log^2 g}\right) \sim \frac{\mathcal{N}}{\log g^{1/k}},
$$

.

as  $c \to \infty$ . This completes the proof of Theorem [1.1.](#page-1-0)
