THE COZERO PART OF THE POINTFREE VERSION OF *Cc*(*X*)

ABSTRACT. Let $C_c(L) := \{ \alpha \in \mathcal{R}(L) \mid R_\alpha \text{ is a countable subset of } \mathbb{R} \}$, where R_{α} := { $r \in \mathbb{R}$ | coz($\alpha - r$) $\neq \top$ } for every $\alpha \in \mathcal{R}(L)$. By using idempotent elements, it is going to prove that $Coz_c[L] := \{cot(\alpha) \mid \alpha \in C_c(L) \}$ is a σ -frame for every completely regular frame *L*, and from this, we conclude that it is regular, paracompact, perfectly normal and an Alexandroff algebra frame such that each cover of it is shrinkable. Also, we show that *L* is a zero-dimensional frame if and only if *L* is a *c*-completely regular frame.

1. Introduction

Some authors, such as Ball and Hager [\[2\]](#page-12-0), studied the ring R(*L*) of real-valued continuous functions on a frame, namely the pointfree version of the ring $C(X)$, prior to 1996. Banaschewski [\[5\]](#page-12-1) did a systematic study of the ring of real-valued continuous functions in pointfree topology in 1996. Also, to read more about R(*L*), you can see [\[3,](#page-12-2) [4,](#page-12-3) [8,](#page-13-0) [17,](#page-13-1) [19\]](#page-13-2).

The largest subring of $C(X)$, whose elements are countable images, is $C_c(X)$, which leads to research on the pointfree version of its, that is, $\mathcal{R}_c(L)$, by Estaji et al. [\[12,](#page-13-3) [18,](#page-13-4) [20,](#page-13-5) [10\]](#page-13-6). Estaji at al. [\[13\]](#page-13-7) defined $R_{\alpha} := \{r \in \mathbb{R} \mid \cos(\alpha - r) \neq \top\}$ for every $\alpha \in \mathcal{R}(L)$. The frame of open sets of a space *X* is called $O(X)$. Aliabadi and Mahmodi [\[1\]](#page-12-4) studied $\text{pim}(\alpha) := \bigcap \{\omega \in O(\mathbb{R}) \mid \alpha(\omega) = \top\}$ for every $\alpha \in \mathcal{R}(L)$, and proved that $\text{pim}(\alpha) = R_{\alpha}$.

By using the definition of R_α , authors of [\[21\]](#page-13-8) introduced another pointfree version of $C_c(X)$ via the range of functions and denoted it by $C_c(L)$, which is more compatible with the functions of countable range. Also, in [\[22\]](#page-13-9), it was proved that every radical ideal in it is an absolutely convex ideal. Characterization of the clean elements of $\mathcal{R}(L)$ has been done and proved when $C_c(L)$ is clean (see [\[14\]](#page-13-10)).

The cozero map plays a key role in a way not usually encountered in ordinary topology; in fact, its main essence is that it provides a pointfree way of dealing with important point-dependent classical arguments. The collection of all cozero elements of *L* is called the *cozero part* and is usually denoted by Coz[*L*]. General properties of cozero elements and Coz[*L*] can be found in [\[6,](#page-12-5) [8\]](#page-13-0). Cozero elements play a particular role in $\mathcal{R}(L)$, $\mathcal{R}_c(L)$, and $\mathcal{C}_c(L)$. The cozero part of a frame *L* is seen to be a sublattice of *L*, and also, $Coz[L]$ is a σ -frame.

The main purpose of this article is to show that $Coz_c[L]$ is a σ -frame for every completely regular frame *L* and that *L* is a zero-dimensional frame if and only if *L* is a *c*-completely regular frame.

2. Preliminaries

A complete lattice *L* is said to be a *frame* if $a \wedge \vee B = \vee_{b \in B} (a \wedge b)$, for any $a \in L$ and *B* ⊆ *L*. We denote the *top* element and the *bottom* element of a frame *L* by ⊤ and \perp , respectively. For every element *a* of a frame *L*, set $\uparrow a := \{b \in L \mid a \leq b\}$ and $a \rightarrow b := \{x \in L \mid a \wedge x \leq b\}$ for every $a, b \in L$. The *pseudocomplement* of $a \in L$ is the element $a^* := a \to \bot = \setminus \{x \in L \mid x \wedge a = \bot\}$. If $a \vee a^* = \top$, then *a* is said to be *complemented* and the complement of *a* denoted by *a* ′ .

Recall from $[5]$ that the *frame of reals* is the frame $\mathcal{L}(\mathbb{R})$ generated by all ordered pairs (p, q) with $p, q \in \mathbb{Q}$, subject to the following relations:

(R1) (*p*, *q*) ∧ (*r*, *s*) = (*p* ∨ *r*, *q* ∧ *s*), (R2) $(p, q) \vee (r, s) = (p, s)$, whenever $p \le r < q \le s$, (R3) $(p, q) = \sqrt{(r, s) | p < r < s < q}$, $(R4)$ T = $\sqrt{(p,q) | p,q}$ ∈ ℚ}.

A *continuous real function* on a frame is a frame homomorphism $\mathcal{L}(\mathbb{R}) \to L$. The set of all continuous real functions on a frame *L* is denoted by R(*L*). We recall from [\[5\]](#page-12-1) that the set $\mathcal{R}(L)$ with the operator $\diamond \in \{+, \cdot, \land, \lor\}$ defined by

$$
(\alpha \diamond \beta)(p,q) = \bigvee \{ \alpha(r,s) \land \beta(u,v) \mid r,s > \diamond < u, v > \subseteq < p, q > \} \, (\forall \alpha, \beta \in \mathcal{R}(L))
$$

is an *f*-ring. Here, $\langle p, q \rangle := \{r \in \mathbb{R} \mid p \langle r \langle q \rangle\}$ for every $p, q \in \mathbb{Q}$, and

 $\langle r, s \rangle \langle s \rangle \langle u, v \rangle = \{ y \langle z | y \in \langle r, s \rangle, z \in \langle u, v \rangle \}.$

To facilitate the work, for every $p, q \in \mathbb{Q}$, we put

$$
(p,-) := \bigvee_{\substack{r,s>p,\\r,s\in\mathbb{Q}}} (r,s) \text{ and } (-,q) := \bigvee_{\substack{r,s
$$

For $\alpha \in \mathcal{R}(L)$, $\alpha(-,0) \vee \alpha(0,-)$ is called *cozero element* of L and denoted by $\cos(\alpha)$. In [\[5,](#page-12-1) [19\]](#page-13-2), a frame is completely regular if and only if it is generated by its cozero elements, that is, for every $x \in L$, there exists $\{\alpha_i\}_{i \in I} \subseteq \mathcal{R}(L)$ such that

$$
x = \bigvee_{\operatorname{coz}(\alpha_i) \leq x} \operatorname{coz}(\alpha_i).
$$

Apart from frames, we shall also consider σ -frames, defined as below. A σ*-frame* is a distributive lattice *L* in which any countable subset has a join such that

$$
a \wedge \bigvee S = \bigvee_{s \in S} (a \wedge s),
$$

for all $a \in L$ and any countable subset $S \subseteq L$. For example,

$$
Coz[L] := \{ \text{coz}(\alpha) \mid \alpha \in \mathcal{R}(L) \}
$$

is a sub- σ -frame of *L* (see [\[8,](#page-13-0) Corollary 2]).

We recall from [\[13\]](#page-13-7) that for each $\alpha \in \mathcal{R}(L)$, $R_{\alpha} := \{r \in \mathbb{R} \mid \text{coz}(\alpha - r) \neq \top\}$ and also,

$$
C_c(L) := \{ \alpha \in \mathcal{R}(L) \mid R_{\alpha} \text{ is a countable subset of } \mathbb{R} \}
$$

as the pointfree topology version of the ring $C_c(X)$ (for more details see [\[21,](#page-13-8) [22,](#page-13-9) [14\]](#page-13-10)) and we set

$$
\mathrm{Coz}_c[L] := \{\mathrm{coz}(\alpha) \mid \alpha \in C_c(L)\}.
$$

3. ALGEBRAIC OPERATIONS OF THE IDENTENT ELEMENTS OF
$$
\mathcal{R}(L)
$$

It is written *B*(*A*) for the set of all the idempotent elements of a given ring *A*. If *e* ∈ *B*($\mathcal{R}(L)$), then coz(*e*) is complemented. For *e*₁, *e*₂ ∈ *B*($\mathcal{R}(L)$) in this section, we check $(e_1 \diamond e_2)(-, x)$ and $(e_1 \diamond e_2)(x, -)$ for every $x \in \mathbb{Q}$, where $\diamond \in \{+, -, \cdot, \vee, \wedge\}$.

Remark 3.1*.* Let *e* be an idempotent element of R(*L*). Then the following statements are true:

(1) For every $x \in \mathbb{Q}$,

$$
e(x, -) = \begin{cases} \top, & x < 0, \\ \cos(e), & 0 \le x < 1, \\ \bot, & x \ge 1, \end{cases} \text{ and } e(-, x) = \begin{cases} \bot, & x \le 0, \\ (\cos(e))', & 0 < x \le 1, \\ \top, & x > 1. \end{cases}
$$

(2) If $x, k \in \mathbb{Q}$ with $k > 0$, then

$$
ke(x,-) = \begin{cases} \top, & x < 0, \\ \cos(e), & 0 \le x < k, \\ \bot, & x \ge k, \end{cases} \quad \text{and} \quad ke(-,x) = \begin{cases} \bot, & x \le 0, \\ (\cos(e))', & 0 < x \le k, \\ \top, & x > k. \end{cases}
$$

(3) If $x, k \in \mathbb{Q}$ with $k < 0$, then

$$
ke(x, -) = \begin{cases} \bot, & x \ge 0, \\ (\cos(e))', & k \le x < 0, \\ \top, & x < k, \end{cases} \text{ and } ke(-, x) = \begin{cases} \top, & x > 0, \\ \cos(e), & k < x \le 0, \\ \bot, & x \le k. \end{cases}
$$

Lemma 3.2. *If* $e_1, e_2 \in B(R(L))$ *, then for every* $x \in \mathbb{Q}$ *, we have*

$$
(e_1 + e_2)(x, -) = \begin{cases} \n\top & x < 0, \\ \n\cos(e_1 + e_2), & 0 \le x < 1, \\ \n\cos(e_1) \wedge \cos(e_2), & 1 \le x < 2, \\ \n\perp, & x \ge 2, \n\end{cases}
$$

and

$$
(e_1 + e_2)(-, x) = \begin{cases} \bot, & x \le 0, \\ (\cos(e_1))' \land (\cos(e_2))', & 0 < x \le 1, \\ (\cos(e_1))' \lor (\cos(e_2))', & 1 < x \le 2, \\ \bot, & x > 2. \end{cases}
$$

Proof. For every $x \in \mathbb{Q}$, if $x < 0$, then $(e_1 + e_2)(x, -) = \top$, since $e_1 + e_2 \ge 0$. It is evident that $\cos(e_1 + e_2) = (e_1 + e_2)(0, -)$. For every $x, r \in \mathbb{Q}$, we define *H*(*x*,*r*) = $e_1(r, -)$ ∧ $e_2(x - r, -)$. Let $x \in \mathbb{Q}$ with $0 < x < 1$ be given. Then there exist *r*, $s \in \mathbb{Q}$ such that $0 < r < x < s < 1$, which implies that $H_{(x,x-s)} = \cos(e_2)$, $H_{(x,s)} = \cos(e_1)$, and $H_{(x,r)} = \cos(e_1) \wedge \cos(e_2)$. Therefore,

$$
(e_1 + e_2)(x, -) = \cos(e_2) \vee \cos(e_1) \vee (\cos(e_1) \wedge \cos(e_2))
$$

$$
= \cos(e_1) \vee \cos(e_2)
$$

$$
= \cos(e_1 + e_2)
$$

for every $x \in \mathbb{Q}$ with $0 \le x < 1$. Let $x \in \mathbb{Q}$ with $1 \le x < 2$ be given. Then for every *r* ∈ Q,

$$
x - r < 0 \Rightarrow 1 \le x < r \Rightarrow H_{(x,r)} = \bot,
$$
\n
$$
0 \le x - r < 1 \Rightarrow (0 \le r < 1 \text{ and } 0 \le x - r < 1) \Rightarrow H_{(x,r)} = \text{coz}(e_1) \land \text{coz}(e_2), \text{ and}
$$
\n
$$
x - r \ge 1 \Rightarrow H_{(x,r)} = \bot.
$$

Hence,

$$
(e_1 + e_2)(x, -) = \cos(e_1) \wedge \cos(e_2)
$$

for every $x \in \mathbb{Q}$ with $1 \le x < 2$. Let $x \in \mathbb{Q}$ with $x \ge 2$ be given. Then for every *r* ∈ ℚ, if $0 \le x - r < 1$ or $x - r < 0$, then $r > 1$ or $2 \le x < r$, which implies that *H*_(*x*,*r*) = ⊥. Therefore, for every *x* ∈ ℚ with $2 \le x$, we have $(e_1 + e_2)(x, -) = \bot$. □

Lemma 3.3. *If* $e_1, e_2 \in B(R(L))$ *, then for every* $x \in \mathbb{Q}$ *, it holds that*

$$
(e_1e_2)(x, -) = \begin{cases} \top, & x < 0, \\ \cos(e_1) \wedge \cos(e_2), & 0 \le x < 1, \\ \bot, & x \ge 1, \end{cases}
$$

and

$$
(e_1e_2)(-,x) = \begin{cases} \bot, & x \le 0, \\ (\cos(e_1))' \lor (\cos(e_2))', & 0 < x \le 1, \\ \top, & x > 1. \end{cases}
$$

Proof. For every $x \in \mathbb{Q}$, if $x < 0$, then $(e_1e_2)(x, -) = \top$, since $e_1e_2 \ge 0$. For every $x, s \in \mathbb{Q}$, we define $H(x, s) = e_1(s, -) \wedge e_2(\frac{x}{s})$ *s*^{*s*}, −). Let $0 < s \in \mathbb{Q}$. Then for $x = 0$, we have

 $0 < s < 1 \Rightarrow H_{(x,s)} = \cos(e_1) \wedge \cos(e_2),$ $s \geq 1 \Rightarrow H_{(x,s)} = \perp$.

Therefore, $(e_1e_2)(0, -) = (coz(e_1) ∧ coz(e_2)) ∨ ⊥ = coz(e_1) ∧ coz(e_2)$.

Let $0 < x < 1$. Then

$$
x < s < 1 \Rightarrow H_{(x,s)} = \text{coz}(e_1) \land \text{coz}(e_2),
$$
\n
$$
s < x \text{ and } s > 1 \Rightarrow H_{(x,s)} = \bot.
$$

Hence, $(e_1e_2)(x, -) = (coz(e_1) ∧ coz(e_2)) ∨ ⊥ = coz(e_1) ∧ coz(e_2)$. Let $x \geq 1$. Then

$$
x \ge s \Rightarrow H_{(x,s)} = \bot,
$$

$$
s > x \Rightarrow H_{(x,s)} = \bot.
$$

Thus, $(e_1e_2)(x, -) = \perp$.

For every $x \in \mathbb{Q}$, if $x < 0$, then $(e_1e_2)(x, -) = \bot$. For every $x, s \in \mathbb{Q}$, we define $H_{(s,x)} = e_1(-, s) \wedge e_2(-, \frac{x}{s})$ *s*). Let $0 < s \in \mathbb{Q}$. For $x = 0$, we have

$$
0 < s \le 1 \Rightarrow H_{(x,s)} = (\cos(e_1))' \land \bot = \bot,
$$
\n
$$
s > 1 \Rightarrow H_{(x,s)} = \top \land \bot = \bot.
$$

Therefore, $(e_1e_2)(-, x) = \perp$.

Let $0 < x \leq 1$. Then

$$
0 < s \le x \Rightarrow H_{(s,x)} = (\cos(e_1))' \land \top = (\cos(e_1))',
$$
\n
$$
x < s \le 1 \Rightarrow H_{(s,x)} = (\cos(e_1))' \land (\cos(e_2))',
$$
\n
$$
s > 1 \Rightarrow H_{(s,x)} = \top \land (\cos(e_2))' = (\cos(e_2))'.
$$

Thus,

$$
(e_1e_2)(-,x) = (coz(e_1))' \vee ((coz(e_1))' \wedge (coz(e_2))') \vee (coz(e_2))'
$$

=
$$
(coz(e_1))' \vee (coz(e_2))'.
$$

Let $x > 1$. Then

$$
s \le 1 \Rightarrow H_{(s,x)} = (\cos(e_1))' \land \top = (\cos(e_1))',
$$

\n
$$
x < s \Rightarrow H_{(s,x)} = \top \land (\cos(e_2))' = (\cos(e_2))',
$$

\n
$$
1 < s < x \Rightarrow H_{(s,x)} = \top.
$$

Therefore, $(e_1e_2)(-, x) = (coz(e_1))' \lor (coz(e_2))' \lor \top = \top$.

Similar to the process of proving the above lemma, the next lemma was proved. **Lemma 3.4.** *If* $e_1, e_2 \in B(R(L))$ *, then for every* $x \in \mathbb{Q}$ *, we have*

$$
(e_1 \vee e_2)(x, -) = \begin{cases} \top, & x < 0, \\ \cos(e_1 + e_2), & 0 \le x < 1, \\ \bot, & x \ge 1, \end{cases}
$$

$$
(e_1 \vee e_2)(-, x) = \begin{cases} \bot, & x \le 0, \\ (\cos(e_1))' \wedge (\cos(e_2))', & 0 < x \le 1, \\ \top, & x > 1, \end{cases}
$$

$$
(e_1 \wedge e_2)(x, -) = \begin{cases} \top, & x < 0, \\ \cos(e_1 \wedge e_2), & 0 \le x < 1, \\ \bot, & x \ge 1, \end{cases}
$$

and

$$
(e_1 \wedge e_2)(-, x) = \begin{cases} \bot, & x \leq 0, \\ (\cos(e_1))' \vee (\cos(e_2))', & 0 < x \leq 1, \\ \top, & x > 1. \end{cases}
$$

4. DEDEKIND CUTS FOR $\mathbb R$ by idempotent elements and prime ideals

In article [\[1\]](#page-12-4), $A_p(\alpha)$ and $B_p(\alpha)$ were introduced. We found that it is better to use $P_u(\alpha)$ and $P_l(\alpha)$ symbols instead of them, which would be easier for the reader to understand the concepts. They are given below. For every $\alpha \in \mathcal{R}(L)$ and every prime ideal *P* in *L*, let

$$
P_u(\alpha) := \{ x \in \mathbb{Q} \mid \alpha(x, -) \in P \} \quad \text{and} \quad P_l(\alpha) := \{ x \in \mathbb{Q} \mid \alpha(-, x) \in P \}.
$$

To express our arguments, we need the following lemma and result from [\[1\]](#page-12-4).

Lemma 4.1. [\[1\]](#page-12-4) *For every* $\alpha \in \mathcal{R}(L)$ *and every prime ideal P in L, the following statements are true:*

- (1) $P_u(\alpha) \cup P_l(\alpha) = \mathbb{Q}$.
- (2) *Any element of P_u*(α) *is an upper bound of P_l*(α) *and any element of P_l*(α) *is a lower bound of* $P_u(\alpha)$ *.*
- (3) $\uparrow P_u(\alpha) = P_u(\alpha)$ and $\downarrow P_l(\alpha) = P_l(\alpha)$.

Corollary 4.2. [\[1\]](#page-12-4) *Let* P *be a prime ideal of L and let* $\alpha \in \mathcal{R}(L)$ *be given. Then the following statements are equivalent:*

- (1) inf $P_u(\alpha) \in \mathbb{R}$.
- (2) $P_l(\alpha) \neq \emptyset \neq P_u(\alpha)$.
- (3) sup $P_l(\alpha) \in \mathbb{R}$.
- (4) inf $P_u(\alpha) = \sup P_l(\alpha) \in \mathbb{R}$.

Corollary 4.3. Let P be a prime ideal of L and let $\alpha \in \mathcal{R}(L)$ be given. Then inf $P_u(\alpha) \in \mathbb{Q}$ *if and only if* inf $P_u(\alpha) \in P_u(\alpha)$ *if and only if* $|P_u(\alpha) \cap P_l(\alpha)| = 1$.

Proof. By Corollary [4.2,](#page-5-0) it is evident. □

Lemma 4.4. *Let P be a prime ideal of L. If e be an idempotent element of* R(*L*)*, then the following statements are true:*

(1) inf $P_u(e) = \sup P_l(e) \in P_u(e) \cap P_l(e)$ *and*

$$
\inf P_u(e) = \begin{cases} 0, & \text{coz}(e) \in P, \\ 1, & \text{coz}(e) \notin P. \end{cases}
$$

(2) *For every* $k \in \mathbb{Q}$, inf $P_u(ke) = k \inf P_u(e)$.

Proof. (1). It is evident that $\cos(e) \in P$ or $(\cos(e))' \in P$. If $\cos(e) \in P$, then

$$
P_u(e) = \{x \in \mathbb{Q} \mid x \ge 0\}
$$
 and $P_l(e) = \{x \in \mathbb{Q} \mid x \le 0\}.$

Therefore,

$$
\inf P_u(e) = \sup P_l(e) = 0 \in P_u(e) \cap P_l(e).
$$

If $(\cos(e))' \in P$, then

$$
P_u(e) = \{x \in \mathbb{Q} \mid x \ge 1\}
$$
 and $P_l(e) = \{x \in \mathbb{Q} \mid x \le 1\}.$

Hence,

$$
\inf P_u(e) = \sup P_l(e) = 1 \in P_u(e) \cap P_l(e).
$$

(2). Let $k \in \mathbb{Q}$ with $k > 0$ be given. Then

$$
x \in P_u(ke) \Leftrightarrow ke(x, -) \in P \Leftrightarrow e(\frac{x}{k}, -) \in P \Leftrightarrow x \in kP_u(e),
$$

which implies that inf $P_u(ke) = k \inf P_u(e)$.

Let $k \in \mathbb{Q}$ with $k < 0$ be given. Then

$$
x \in P_u(ke) \Leftrightarrow ke(x, -) \in P \Leftrightarrow e(-, \frac{x}{k}) \in P \Leftrightarrow x \in kP_l(e),
$$

which implies that

$$
\inf P_u(ke) = \inf k P_l(e) = k \sup P_l(e) = k \inf P_u(e).
$$

In [\[1,](#page-12-4) Theorem 2.23], the prime ideal P is considered as countably \vee -complete, which here, since our discussion is about idempotent elements, we are able to remove this condition and express it as follows.

Proposition 4.5. *Let P be a prime ideal of L. If* $e_1, e_2 \in B(R(L))$ *, then* inf $P_u(e_1 \diamond$ e_2) = sup $P_l(e_1 \diamond e_2) \in P_u(e_1 \diamond e_2) \cap P_l(e_1 \diamond e_2)$ and inf $P_u(e_1 \diamond e_2)$ = inf $P_u(e_1) \diamond$ $\inf P_u(e_2)$ *for every* $\diamond \in \{+, \vee, \wedge, \cdot\}.$

Proof. We only prove it for $\diamond = +$; the rest will be proved similarly. It is evident that

 $P_u(e_1 + e_2) \cap (-\infty, 0) = \emptyset$ and $P_l(e_1 + e_2) \cap (0, +\infty) = \emptyset$.

Case (1): If $\cos(e_1) \in P$ and $\cos(e_2) \in P$, then $\cos(e_1 + e_2) = \cos(e_1) \vee \cos(e_2) \in P$ *P*, which implies that $P_u(e_1 + e_2) = \{x \in \mathbb{Q} \mid x \ge 0\}$ and $P_l(e_1 + e_2) = \{x \in \mathbb{Q} \mid x \le 0\}.$ Therefore,

$$
\inf P_u(e_1 + e_2) = \sup P_l(e_1 + e_2) = 0 \in P_u(e_1 + e_2) \cap P_l(e_1 + e_2)
$$

and inf $P_u(e_1 + e_2) = \inf P_u(e_1) + \inf P_u(e_2)$.

Case (2): If coz(*e*₁) ∈ *P* and $(\cot(e_2))^{\prime}$ ∈ *P*, then $\cot(e_1 + e_2) \vee (\cot(e_2))^{\prime} = \top$, which implies that $\cos(e_1 + e_2) \notin P$. Hence, $P_u(e_1 + e_2) \cap [0, 1) \cap \mathbb{Q} = \emptyset$. Since $\cos(e_1) \wedge \cos(e_2) \leq \cos(e_1) \in P$, we conclude that $[1, 2) \cap \mathbb{Q} \subseteq P_u(e_1 + e_2)$. It is evident that $[2, +\infty) \subseteq P_u(e_1 + e_2)$ and implies that $P_u(e_1 + e_2) = [1, +\infty) \cap \mathbb{Q}$. A similar proof shows that $P_l(e_1 + e_2) = (-\infty, 1] \cap \mathbb{Q}$. Therefore,

$$
\inf P_u(e_1 + e_2) = \sup P_l(e_1 + e_2) = 1 \in P_u(e_1 + e_2) \cap P_l(e_1 + e_2)
$$

and inf $P_u(e_1 + e_2) = \inf P_u(e_1) + \inf P_u(e_2)$.

Case (3): Let $(coz(e_1))' \in P$ and let $coz(e_2) \in P$. Similar to the proof of Case (2), we have

$$
\inf P_u(e_1 + e_2) = \sup P_l(e_1 + e_2) = 1 \in P_u(e_1 + e_2) \cap P_l(e_1 + e_2)
$$

and inf $P_u(e_1 + e_2) = \inf P_u(e_1) + \inf P_u(e_2)$.

Case (4): Let $(\cos(e_1))' \in P$ and let $(\cos(e_2))' \in P$. We have

$$
(\operatorname{coz}(e_1 + e_2))' = (\operatorname{coz}(e_1))' \land (\operatorname{coz}(e_2))' \in P \Rightarrow \operatorname{coz}(e_1 + e_2) \notin P
$$

$$
\Rightarrow P_u(e_1 + e_2) \cap [0, 1) \cap \mathbb{Q} = \emptyset.
$$

 \Box

If coz(e_1) ∧ coz(e_2) ∈ *P*, then coz(e_1) ∈ *P* or coz(e_2) ∈ *P*, which implies that $\tau = \cos(e_1) \vee (\cos(e_1))' \in P$ or $\tau = \cos(e_2) \vee (\cos(e_2))' \in P$, a contradiction. Hence, $P_u(e_1 + e_2) \cap [1, 2) \cap \mathbb{Q} = \emptyset$, which follows that $P_u(e_1 + e_2) = [2, +\infty) \cap \mathbb{Q}$. A similar proof shows that $P_l(e_1 + e_2) = (-\infty, 2] \cap \mathbb{Q}$. Therefore,

$$
\inf P_u(e_1 + e_2) = \sup P_l(e_1 + e_2) = 2 \in P_u(e_1 + e_2) \cap P_l(e_1 + e_2)
$$

and inf $P_u(e_1 + e_2) = \inf P_u(e_1) + \inf P_u(e_2)$.

Corollary 4.6. *Let P be a prime ideal of L. Suppose that* $e_1, e_2 \in B(R(L))$ *. If* $x = \inf P_u(e_1 \diamond e_2)$, then $x \in R_{e_1 \diamond e_2}$ for every $\diamond \in \{\cdot, \vee, \wedge\}.$

Proof. By Proposition [4.5,](#page-6-0) it is obvious. □

We recall that for every $p \in \mathbb{R}$,

$$
\mathbf{p}(-,r) = \begin{cases} \bot, & r \le p, \\ \top, & r > p, \end{cases} \text{ and } \mathbf{p}(r,-) = \begin{cases} \top, & r < p, \\ \bot, & r \ge p. \end{cases}
$$

A function $f(x)$ is said to be bounded on a given interval if there exist two numbers *M* and *N* such that: $M \le f(x) \le N$. Also, $\mathcal{R}^*(L)$ is the set of bounded elements of $R(L)$.

Lemma 4.7. Let P be a prime ideal of L. If $\alpha \in \mathbb{R}^*(L)$, then $\inf P_u(\alpha) = \sup P_l(\alpha)$.

Proof. There exists $n \in \mathbb{N}$ such that $-n \leq \alpha \leq n$, which implies that

$$
\top = \mathbf{n}(-, x) \le \alpha(-, x) \text{ for every } x > n \text{ and}
$$

$$
\top = -\mathbf{n}(y, -) \le \alpha(y, -) \text{ for every } y < -n.
$$

Hence, $(n, +\infty) \cap \mathbb{Q} \subseteq P_u(\alpha)$ and $(-\infty, -n) \cap \mathbb{Q} \subseteq P_l(\alpha)$. It follows from Corollary [4.2](#page-5-0) that inf $P_u(\alpha) = \sup P_l(\alpha)$.

Proposition 4.8. *Let P be a prime ideal of L and let n* $\in \mathbb{N}$ *. If e*₁*, . . . , e*_{*n*} \in *B*(*R*(*L*))*, then*

$$
\inf P_u(\mathbf{r}_1e_1 + \dots + \mathbf{r}_n e_n) = \sup P_l(\mathbf{r}_1e_1 + \dots + \mathbf{r}_n e_n)
$$

belongs to

$$
P_u(\mathbf{r}_1e_1 + \cdots + \mathbf{r}_n e_n) \cap P_l(\mathbf{r}_1e_1 + \cdots + \mathbf{r}_n e_n)
$$

and

$$
\inf P_u(\mathbf{r}_1e_1 + \dots + \mathbf{r}_n e_n) = r_1 \inf P_u(e_1) + \dots + r_n \inf P_u(e_n)
$$

for every $r_1, \ldots, r_n \in \mathbb{Q}$.

Proof. We prove it by induction on $n \in \mathbb{N}$. For $n = 1$, the result is trivial. Let *r*₁, ..., *r_n* $\in \mathbb{Q}$ be given and let $n \geq 2$. We put $\alpha = \mathbf{r}_1 e_1 + \cdots + \mathbf{r}_{n-1} e_{n-1}$. Let $x \in P_u(\alpha + \mathbf{r}_n e_n)$ be given. Then

$$
\bigvee_{a\in\mathbb{Q}}\alpha(a,-)\wedge\mathbf{r}_{\mathbf{n}}e_n(x-a,-)=(\alpha+\mathbf{r}_{\mathbf{n}}e_n)(x,-)\in P,
$$

which implies that $\alpha(a, -) \wedge \mathbf{r}_n e_n(x - a, -) \in P$ for every $a \in \mathbb{Q}$, and so $\alpha(a, -) \in P$ or $\mathbf{r}_n e_n(x - a, -) \in P$ for every $a \in \mathbb{Q}$. If $a < \inf P_u(\alpha)$, then $\alpha(a, -) \notin P$, which implies from Remark [3.1](#page-2-0) that

$$
\perp = \mathbf{r_n} e_n(x - a, -) \in P \text{ or } \operatorname{coz}(e_n)' = \mathbf{r_n} e_n(x - a, -) \in P.
$$

From

$$
\nu := \mathbf{r_n} e_n(x - \inf P_u(\alpha), -) = \bigvee_{\substack{a \in \mathbb{Q} \\ a < \inf P_u(\alpha)}} r_n e_n(x - a, -),
$$

we conclude that $v = \perp \in P$ or $v = \cos(e_n)' \in P$, which implies that inf P ^{*u*}($\mathbf{r}_n e_n$) ≤ *x* − inf P ^{*u*}(α) and hence,

$$
\inf P_u(\alpha) + \inf P_u(\mathbf{r}_n e_n) \le \inf P_u(\alpha + \mathbf{r}_n e_n).
$$

Let $x \in P_l(\alpha + \mathbf{r}_n e_n)$ be given. We set

$$
w := \mathbf{r_n} e_n(-, x - \sup P_l(\alpha)) = \bigvee_{\substack{s \in \mathbb{Q} \\ s > \sup P_l(\alpha)}} r_n e_n(-, x - s).
$$

Therefore, similar to the above, it conclude that for every $s > \sup P_l(\alpha)$, which we conclude from Remark [3.1](#page-2-0) that $w = \bot \in P$ or $w = \text{coz}(e_n) \in P$. Thus we have $x - \sup P_l(\alpha) \leq \sup P_l(\mathbf{r_n}e_n)$ and hence,

$$
\sup P_l(\alpha + \mathbf{r_n}e_n) \le \sup P_l(\alpha) + \sup P_l(\mathbf{r_n}e_n),
$$

and finally, by Lemma [4.7,](#page-7-0)

$$
\inf P_u(\alpha) + \inf P_u(\mathbf{r}_n e_n) = \inf P_u(\alpha + \mathbf{r}_n e_n).
$$

The rest follows with Lemma [4.4.](#page-5-1)

Coz(B(C_c(L)))
$$
 as a base for $Coz_c[L]$

In [\[22\]](#page-13-9), for every $r \in \mathbb{R}$, it was defined that $u_r := \bigvee_{n \in \mathbb{N}} (-, a_n)$ and $l_r :=$ $\bigvee_{n\in\mathbb{N}}(b_n, -)$, where $a_n, b_n \subseteq \mathbb{Q}$ are sequences such that $a_n, b_n \to r$ and for every $n \in \mathbb{N}$,

$$
a_n < a_{n+1} < r < b_{n+1} < b_n.
$$

It was also shown that $\alpha(u_r)$ and $\alpha(l_r)$ are complemented in *L* and that the complement of $\alpha(l_r)$ is $\alpha(u_r)$. Also, see Lemma 4.1 in [\[13\]](#page-13-7).

The following results are counterpart of $[13,$ Proposition 5.1].

Proposition 5.1. *If* $\alpha \in C_c(L)$, *then* coz (α) *is a countable join of complemented elements of L.*

Proof. For any $n \in \mathbb{N}$, by [\[22,](#page-13-9) Remark 7.2], there exist r_n , $s_n \in \mathbb{R} \setminus R_\alpha$ satisfying all of the following conditions:

 $(1) \frac{-1}{n} < r_n < 0 < s_n < \frac{1}{n}$, (2) $u_{r_n}, u_{s_n}, l_{r_n}$ and l_{s_n} are complemented, *(3)* $\alpha(\frac{1}{n}, -) \le \alpha(l_{s_n}) \le \cos(\alpha)$ and $\alpha(-, \frac{-1}{n}) \le \alpha(u_{r_n}) \le \cos(\alpha)$, *(4)* $\alpha(u_{r_n} \vee l_{s_n})$ is complemented.

Therefore,

$$
\mathrm{coz}(\alpha)=\bigvee_{n\in\mathbb{N}}\alpha(-,\frac{-1}{n})\vee\alpha(\frac{1}{n},-)\leq \alpha(u_{r_n})\vee\alpha(l_{s_n})\leq \mathrm{coz}(\alpha),
$$

which shows that $\cos(\alpha) = \bigvee_{n \in \mathbb{N}} \alpha(u_{r_n} \vee l_{s_n})$ \Box

Remark 5.2. It is easy to see that if *a* is complemented in *L* and $\alpha \in \mathcal{R}(L)$, then $\beta : \mathcal{L}(\mathbb{R}) \longrightarrow L$ given by

$$
\beta(p,q) = \begin{cases} \alpha(p,q) \vee a' & \text{if } 0 \in \tau(p,q), \\ \alpha(p,q) \wedge a & \text{if } 0 \notin \tau(p,q), \end{cases}
$$

is a continuous real-valued function. Since β is a continuous real-valued function, and by [\[11,](#page-13-11) Proposition 4.1], $e_a^2 = e_a$ and $\cos(e_a) = a$. It is easily seen that *e* is an idempotent element of $R(L)$ is and only if $e = e_{\text{coZ}(a)}$.

The following results are counterpart of $[13,$ Theorem 5.2].

Proposition 5.3. *For every* $\alpha \in C_c(L)$, *there exists a sequence* $\{\alpha_n\}_{n\in\mathbb{N}} \subseteq B(C_c(L))$ *with* $\cos(\alpha) = \bigvee_{n \in \mathbb{N}} \cos(\alpha_n)$ *.*

Proof. By Proposition [5.1](#page-8-0) and Remark [5.2,](#page-9-0) it is obvious. □

Definition 5.4. A frame *L* is a *c-completely regular frame* if and only if Coz*c*[*L*] is a base for *L*.

The following results are counterpart of [\[15,](#page-13-12) Proposition 4.4].

Proposition 5.5. *Let L be a frame. Then L is a zero-dimensional frame if and only if L is a c-completely regular frame.*

Proof. Necessity. Let $a \in L$. Then there exists a sequence $\{a_{\lambda}\}_{{\lambda}\in{\Lambda}}$ of complemented elements of *L* such that $a = \bigvee_{\lambda \in \Lambda} a_{\lambda}$. Also, we know $\cos(e_{a_{\lambda}}) = a_{\lambda}$, which implies that $a = \bigvee_{\lambda \in \Lambda} \text{coz}(e_{a_{\lambda}})$. Since for every $\lambda \in \Lambda$, $e_{a_{\lambda}}$ is an idempotent element and all the idempotent elements belong to $C_c(L)$, the proof is complete.

Sufficiency. By Definition [5.4,](#page-9-1) $\text{Coz}_{c}[L]$ is a base for *L*, and by Proposition [5.1,](#page-8-0) for every $\alpha \in C_c(L)$, $\cos(\alpha)$ is a countable join of complemented elements of L. Then *L* is a zero-dimensional frame. □

 as a σ -frame

In this section, the main purpose of writing this article is going to be proved, that is, $\text{Coz}_c[L]$ is a σ -frame for every completely regular frame *L*. To achieve this purpose, we need some lemmas and propositions, which we will express and prove them at the beginning.

Lemma 6.1. Let α be an element of $\mathcal{R}(L)$ and let $x \in \mathbb{R}$. Then the following *statements are true:*

- (1) *If* $x \in R_\alpha$, then there exists a prime ideal P in L such that $x = \inf P_u(\alpha)$.
- (2) *If there exists a countably* ∨*-complete prime ideal P in L such that* $x = \inf P_u(\alpha)$ *, then* $x \in R_\alpha$ *.*
- (3) Let P be a prime ideal of L and let $n \in \mathbb{N}$ be given. Suppose that $e_1, \ldots, e_n \in$ *B*($\mathcal{R}(L)$)*. If* $r_1, \ldots, r_n \in \mathbb{Q}$ *and* $x = \inf P_u(\mathbf{r}_1e_1 + \cdots + \mathbf{r}_n e_n)$ *, then* $x \in R_{\mathbf{r}_1 e_1 + \cdots + \mathbf{r}_n e_n}$.

Proof. (1). By the hypothesis we have $\cos(\alpha - x) \neq \top$. Then there exists a prime ideal *P* in *L* such that $\cos(\alpha - \mathbf{x}) \in P$, which implies that

$$
\bigvee_{\substack{r\in\mathbb{Q}\\rx}}\alpha(r,-)\in P.
$$

Therefore,

$$
\forall r \in \mathbb{Q} \ \ (r < x \Rightarrow \alpha(-, r) \in P \Rightarrow r \in P_l(\alpha)) \Rightarrow x \le \sup P_l(\alpha),
$$

and

$$
\forall r \in \mathbb{Q} \ (r > x \Rightarrow \alpha(-, r) \in P \Rightarrow r \in P_u(\alpha) \Rightarrow x \ge \inf P_u(\alpha).
$$

Since, by Corollary [4.2,](#page-5-0) $\sup P_l(\alpha) = \inf P_u(\alpha)$, we conclude that $x = \inf P_u(\alpha)$.

(2). Let *P* be a prime ideal of *L* such that $x = \inf P_u(\alpha)$. Then, by Lemma [4.1,](#page-5-2)

$$
\forall r \in \mathbb{Q} \ \ (r < x \Rightarrow r \in P_l(\alpha) \Rightarrow \alpha(-, r) \in P)
$$

and

$$
\forall r \in \mathbb{Q} \ (r > x \Rightarrow r \in P_u(\alpha) \Rightarrow \alpha(r, -) \in P)
$$

.

By the hypothesis we have

$$
\operatorname{coz}(\alpha - \mathbf{x}) = \bigvee_{\substack{r \in \mathbb{Q} \\ r < x}} \alpha(-, r) \vee \bigvee_{\substack{r \in \mathbb{Q} \\ r > x}} \alpha(r, -) \in P,
$$

and so $x \in R_\alpha$.

(3). By Lemma [6.1,](#page-9-2)

$$
x \in P_u(\mathbf{r}_1e_1 + \cdots + \mathbf{r}_n e_n) \cap P_l(\mathbf{r}_1e_1 + \cdots + \mathbf{r}_n e_n).
$$

Then

 $\text{coz}(\mathbf{r}_1e_1 + \dots + \mathbf{r}_n e_n - x) = (\mathbf{r}_1e_1 + \dots + \mathbf{r}_n e_n)(-, x) \vee (\mathbf{r}_1e_1 + \dots + \mathbf{r}_n e_n)(x, -) \in P$ which implies that $\text{coz}(\mathbf{r}_1e_1 + \cdots + \mathbf{r}_n e_n - \mathbf{x}) \neq \top$. Therefore, $x \in R_{\mathbf{r}_1e_1 + \cdots + \mathbf{r}_n e_n}$. \Box

For every $A, B \subseteq \mathbb{R}$, we put $A \diamond B := \{a \diamond b \mid a \in A \text{ and } b \in B\}$ for every $\diamond \in \{+, \cdot, \wedge, \vee\}.$

Proposition 6.2. *Let n be an element of* $\mathbb N$ *. Suppose that* $e_1, \ldots, e_n \in B(\mathcal{R}(L))$ *. If* $r_1, \ldots, r_n \in \mathbb{Q}$, then

$$
R_{\mathbf{r}_1e_1+\cdots+\mathbf{r}_n e_n} \subseteq R_{\mathbf{r}_1e_1}+\cdots+R_{\mathbf{r}_n e_n}.
$$

Proof. Suppose that $x \in R_{r_1e_1+\cdots+r_ne_n}$. Thus, by Lemma [6.1\(](#page-9-2)1), there exists a prime ideal *P* in *L* such that $x = \inf P_u(\mathbf{r}_1 e_1 + \cdots + \mathbf{r}_n e_n)$. Hence, by Proposition [4.8,](#page-7-1) $x = x_1 + \cdots + x_n$, where $x_i = \inf P_u(\mathbf{r}_i e_i)$ for every $1 \le i \le n$. Then, by Lemma [6.1\(](#page-9-2)3), $x_i \in R_{\mathbf{r}_i e_i}$. Therefore,

$$
R_{\mathbf{r}_1e_1+\cdots+\mathbf{r}_n e_n} \subseteq R_{\mathbf{r}_1e_1}+\cdots+R_{\mathbf{r}_n e_n}.
$$

 \Box

Proposition 6.3. Suppose that $e_1, e_2 \in B(R(L))$. Then, $R_{e_1 \circ e_2} \subseteq R_{e_1} \circ R_{e_2}$ for every $\diamond \in \{\cdot, \vee, \wedge\}.$

Proof. By Proposition [4.5,](#page-6-0) Corollary [4.6,](#page-7-2) and Lemma [6.1,](#page-9-2) this proposition will be easily proved. \square

Remark 6.4*.* If α and β are elements of $\mathcal{R}(L)$ with $\alpha \leq \beta$, then $P_u(\beta) \subseteq P_u(\alpha)$ and $P_l(\alpha) \subseteq P_l(\beta)$.

Let $(c_n)_{n=0}^{\infty} \in \text{Coz}[L]$ and $(\alpha_n)_{n=0}^{\infty} \in \text{Coz}[L]$ with $0 \le \alpha_n \le 1$ and $\text{coz}(\alpha_n) = c_n$ for every *n*, be given. Banaschewski [\[6\]](#page-12-5) showed that $\alpha := \sum_{i=0}^{\infty} \frac{\alpha_i}{2^i}$ $\frac{\alpha_i}{2^i} \in \mathcal{R}(L),$ $\cos(\alpha) = \bigvee_{i=0}^{\infty} c_n$ and $\alpha \le \sum_{i=0}^{n} \frac{\alpha_i}{2^i}$ $\frac{\alpha_i}{2^i} + \frac{1}{2^n}$ $\frac{1}{2^n}$ for every *n*.

Given any countable family $(e_n)_{n=0}^{\infty}$ in $B(R(L))$, consider $\alpha = \sum_{n=0}^{\infty} \frac{e_n}{2^n}$. Then for every $n \in \mathbb{N}$, we have

$$
\alpha \leq \sum_{i=0}^n \frac{e_i}{2^i} + \frac{1}{2^n} \Rightarrow P_u(\sum_{i=0}^n \frac{e_i}{2^i} + \frac{1}{2^n}) \subseteq P_u(\alpha) \Rightarrow \inf P_u(\alpha) \leq \sum_{i=0}^n \inf P_u(\frac{e_i}{2^i}) + \frac{1}{2^n},
$$

which implies that inf $P_u(\alpha) \le \sum_{i=0}^{\infty} \inf P_u(\frac{e_i}{2})$ $\frac{e_i}{2^i}$). On the other hand, for every $n \in \mathbb{N}$, it follows that

$$
\sum_{i=0}^n \frac{e_i}{2^i} \le \alpha \Rightarrow P_u(\alpha) \subseteq P_u(\sum_{i=0}^n \frac{e_i}{2^i}) \Rightarrow \sum_{i=0}^n \inf P_u(\frac{e_i}{2^i}) \le \inf P_u(\alpha),
$$

which implies that $\sum_{i=0}^{\infty}$ inf $P_u(\frac{e_i}{2^i})$ $\frac{e_i}{2^i}$) \leq inf $P_u(\alpha)$. Hence, inf $P_u(\alpha) = \sum_{i=0}^{\infty}$ inf $P_u(\frac{e_i}{2^i})$ $\frac{e_i}{2^i}$). **Proposition 6.5.** *Let* $(e_n)_{n=0}^{\infty}$ *be a countable family of B*($\mathcal{R}(L)$). *If* $\alpha = \sum_{n=0}^{\infty} \frac{e_n}{2^n}$,

then $R_{\alpha} \subseteq \sum_{n=0}^{\infty} R_{\frac{en}{2^n}}$ *.*

Proof. Suppose that $x \in R_\alpha$. Thus, by Lemma [6.1\(](#page-9-2)1), there exists a prime ideal P in *L* such that $x = \inf P_u(\alpha)$. Hence, it follows from Remark [6.4](#page-11-0) that $x = \sum_{n=0}^{\infty} x_i$, where

 $x_i = \inf P_u(\frac{e_i}{2^i})$ *e*^{*i*}</sup> for every *i* ∈ ℕ ∪ {0}. Then, by Lemma [6.1\(](#page-9-2)3), we have x_i ∈ $R_{\frac{e_i}{2^i}}$. Therefore, $R_{\alpha} \subseteq \sum_{n=0}^{\infty} R_{\frac{e_n}{2^n}}$. The contract of the contract of $\overline{\mathcal{L}}$

Theorem 6.6. *For every completely regular frame L,* $\text{Coz}_c[L]$ *is a* σ *-frame.*

Proof. By Proposition [5.3,](#page-9-3) it suffices to show that if $(e_n)_{n=0}^{\infty}$ is a countable family of $B(R(L))$, then $\bigvee_{n=0}^{\infty} \text{coz}(e_n) \in \text{Coz}_c[L]$. We put $\alpha = \sum_{n=0}^{\infty} \frac{e_n}{2^n}$. It is well known that $\cos(\alpha) = \sqrt{\sum_{n=0}^{\infty} \cos(e_n)}$. Since $\sum_{n=0}^{\infty} R_{\frac{e_n}{2^n}}$ is a countable set, we con-clude from Proposition [6.5](#page-11-1) that R_α is too, which implies that $\alpha \in C_c(L)$. Therefore, $\bigvee_{n=0}^{\infty}$ coz $(e_n) \in \text{Coz}_c[L]$.

An element *a* of frame *L* is said to *rather below* an element *b* or *a* is *well inside b*, written as $a \lt b$, if there is an element *x* such that $a \wedge x = \bot$ and $x \vee b = \top$. In [\[9\]](#page-13-13), a σ -frame *L* is *regular* if for every $a \in L$, there exist $(a_n)_{n=1}^{\infty}$ such that $a_n < a$ and $a = \bigvee_{n=1}^{\infty} a_n$ for every *n*.

Corollary 6.7. *For every completely regular frame L,* Coz*c*[*L*] *is regular.*

A bounded lattice *L* is *normal* if given $a \lor b = \top$ that $a, b \in L$, there exist $u, v \in L$ such that $a \lor u = \top = v \lor b$ and $u \land v = \bot$. Also, a normal σ -frame *L* is *perfectly normal* if for each $a \in L$ there exist $(a_n)_{n=1}^{\infty}$ such that $a \wedge b = a \wedge c$ if and only $a_n \vee b = a_n \vee c$ for every $a, b \in L$ (see [\[9\]](#page-13-13)).

By [\[16,](#page-13-14) Proposition 1-1], it is obvious that $CoZ_c[L]$ is normal and perfectly normal for every completely regular frame *L*.

An *Alexandroff algebra* is a normal σ -lattice *L* that for every $a \in L$, there exist $(a_n, b_n)_{n=1}^{\infty}$ such that $b_n \vee a = \top$, $b_n \wedge a_n = \bot$ and $\bigvee_{n=1}^{\infty} a_n = a$.

Corollary 6.8. *For every completely regular frame L,* Coz*c*[*L*] *is an Alexandro*ff *algebra frame.*

Proof. Let $a \in L$ be given. By Proposition [5.3,](#page-9-3) there exists $(e_n)_{n=1}^{\infty} \subseteq B(\mathcal{R}(L))$ such that $a = \bigvee_{\lambda \in \Lambda} \text{coz}(e_{a_{\lambda}})$. We put $(a_n, b_n)_{n=1}^{\infty} = (\text{coz}(e_n), \text{coz}(e_n)')_{n=1}^{\infty}$, then we have

- (1) $\bigvee_{n=1}^{\infty} a_n = a$,
- (2) $b_n \wedge a_n = \perp$ for every $n \in \mathbb{N}$, and
- (3) $b_m \vee a = \cos(e_m)' \vee \bigvee_{n=1}^{\infty} \cos(e_n) = \top$ for every $m \in \mathbb{N}$.

Therefore, the proof is complete.

A *cover* of σ -frame *L* is a family $(a_n)_{n=1}^{\infty} \subseteq L$ such that $\bigvee_{n=1}^{\infty} a_n = \top$. A cover $(b_n)_{n=1}^{\infty}$ of σ -frame *L* is *locally finite* if there is a cover $(c_n)_{n=1}^{\infty}$ of *L* and, for each *m*, a finite subset $p(m)$ of N such that $c_m \wedge b_n = \perp$ if $n \notin p(m)$. A σ -frame is *paracompact* if for each countable cover $\mathcal{A} = (a_n)_{n=1}^{\infty}$ of *L* there is a locally finite cover $\mathcal{B} = (b_m)_{m=1}^{\infty}$ of *L* such that for each *m* there is some *n* with $b_m \le a_n$. A cover $(a_n)_{n=1}^{\infty}$ of σ -frame *L* is *shrinkable* if there is a cover $(d_n)_{n=1}^{\infty}$ of *L* with $d_n \le a_n$ for every *n*.

Proposition 6.9. *For every completely regular frame L, the following statements are true:*

- (1) Coz*c*[*L*] *is paracompact.*
- (2) *Each cover of* $\text{Coz}_{c}[L]$ *is shrinkable.*

Proof. By [\[7,](#page-12-6) Proposition 4] and Corollary [6.7,](#page-11-2) it is obvious. □
