Minimax-Optimal Multi-Agent Robust Reinforcement Learning

Abstract

Multi-agent robust reinforcement learning, also known as multi-player robust Markov games (RMGs), is a crucial framework for modeling competitive interactions under environmental uncertainties, with wide applications in multi-agent systems. However, existing results on sample complexity in RMGs suffer from at least one of three obstacles: restrictive range of uncertainty level or accuracy, the curse of multiple agents, and the barrier of long horizons, all of which cause existing results to significantly exceed the information-theoretic lower bound. To close this gap, we extend the Q-FTRL algorithm [\(Li et al.,](#page-35-0) [2022](#page-35-0)) to the RMGs in finite-horizon setting, assuming access to a generative model. We prove that the proposed algorithm achieves an ε -robust coarse correlated equilibrium (CCE) with a sample complexity (up to log factors) of $\widetilde{O}(H^3S\sum_{i=1}^m A_i \min\{H, 1/R\}/\varepsilon^2)$, where S denotes the number of states, A_i is the number of actions of the *i*-th agent, H is the finite horizon length, and R is uncertainty level. We also show that this sample compelxity is minimax optimal by combining an information-theoretic lower bound. Additionally, in the special case of two-player zero-sum RMGs, the algorithm achieves an ε -robust Nash equilibrium (NE) with the same sample complexity.

1 Introduction

The rapidly evolving field of multi-agent reinforcement learning (MARL), also referred to as Markov games (MGs) [\(Littman](#page-35-1), [1994;](#page-35-1) [Shapley,](#page-36-0) [1953\)](#page-36-0), explores how a group of agents interacts in a shared, dynamic environment to maximize their individual expected cumulative rewards [\(Zhang et al.](#page-37-0), [2020a;](#page-37-0) [Lanctot et al.](#page-35-2), [2019](#page-35-2); [Silver et al.,](#page-36-1) [2017;](#page-36-1) [Vinyals et al.,](#page-36-2) [2019\)](#page-36-2). This area has found wide applications in fields such as ecosystem management [\(Fang et al.](#page-34-0), [2015\)](#page-34-0), strategic decision-making in board games [\(Silver et al.,](#page-36-1) [2017\)](#page-36-1), management science [\(Saloner,](#page-36-3) [1991\)](#page-36-3), and autonomous driving [\(Zhou et al.](#page-37-1), [2020\)](#page-37-1). However, in real-world applications, environmental uncertainties—stemming from factors such as system noise, model misalignment, and the sim-to-real gap—can significantly alter both the qualitative outcomes of the game and the cumulatiev rewards that agents receive [\(Slumbers et al.](#page-36-4), [2023](#page-36-4)). It has been demonstrated that when solutions learned in a simulated environment are applied, even a small deviation in the deployed environment from the expected model can result in catastrophic performance drops for one or more agents [\(Shi et al.,](#page-36-5) [2024c;](#page-36-5) [Balaji et al.](#page-34-1), [2019;](#page-34-1) [Yeh et al.](#page-37-2), [2021](#page-37-2); [Zeng et al.,](#page-37-3) [2022;](#page-37-3) [Zhang et al.](#page-37-4), [2020b\)](#page-37-4).

These challenges motivate the study of robust Markov games (RMGs), which assume that each agent aims to maximize its worst-case cumulative reward in an environment where the transition model is constrained by an uncertainty set centered around an unknown nominal model. Given the competitive nature of the game, the objective of RMGs is to reach an equilibrium where no agent has an incentive to unilaterally change its policy to increase its own payoff. A classical type of equilibrium is the robust Nash equilibrium (NE) [\(Nash Jr](#page-35-3), [1950\)](#page-35-3), where each agent's policy is independent, and no agent can improve its worst-case performance by deviating from its current strategy. Due to the high computational cost of solving robust NEs, especially in games with more than two agents, this concept is often relaxed to the robust coarse correlated equilibrium (CCE), where agents' policies may be correlated [\(Moulin & Vial,](#page-35-4) [1978\)](#page-35-4).

In the context of RMGs, achieving equilibrium with minimal samples is of particular interest, as data is often limited in practical applications. While there has been extensive research on the sample complexity

of MGs, studies on RMGs remain limited [\(Kardeş et al.,](#page-35-5) [2011\)](#page-35-5), including the asymptotic convergence analysis [\(Zhang et al.](#page-37-4), [2020b](#page-37-4)) and the finite-sample analysis for RMGs [\(Blanchet et al.](#page-34-2), [2024;](#page-34-2) [Ma et al.,](#page-35-6) [2023](#page-35-6); [Shi et al.](#page-36-6), [2024b](#page-36-6)[,a](#page-36-7)). Specifically, [Ma et al.](#page-35-6) [\(2023](#page-35-6)) showed that robust Correlated Equilibrium (CE) can be achieved with $\tilde{O}(H^5 S \max_{1 \leq i \leq m} A_i^2/\varepsilon^2)$ samples when the uncertainty level R is sufficiently small, i.e., $R \leq \varepsilon/(SH^2)$, where S denotes the number of states, A_i denotes the number of actions for the *i*-th agent, and H denotes the finite horizon length. Additionally, [Blanchet et al.](#page-34-2) [\(2024](#page-34-2)) and [Shi et al.](#page-36-5) [\(2024c\)](#page-36-5) proved that robust NEs (and CCEs) can be achieved for all uncertainty levels within [0, 1] using $\tilde{O}(H^4S^3 \prod_{i=1}^m A_i^2/\varepsilon^2)$ and $\widetilde{O}(H^3 S \prod_{i=1}^m A_i \min\{H, 1/R\} / \varepsilon^2)$ samples, respectively, assuming access to offline dataset or a generative model, where m is the number of agents. Recently, [Shi et al.](#page-36-7) [\(2024a\)](#page-36-7) achieved robust CCEs with sample complexity $\widetilde{O}(H^6S \sum_{i=1}^m A_i \min\{H, 1/R\}/\varepsilon^4)$, under a policy-induced uncertainty set definition. However, all prior results suffer from at least one of three obstacles: restrictive range of uncertainty level R or accuracy ε , the curse of multiple agents, and the barrier of long horizons H. As a result, they fall short of achieving minimax-optimal sample complexity.

1.1 Our contributions

In this paper, we study the problem of RMGs in the finite-horizon setting with an R-contamination model [\(Huber,](#page-35-7) [1965](#page-35-7)) as uncertainty set. This model has been widely adopted in previous works on robust single-agent reinforcement learning [\(Ma et al.](#page-35-6), [2023;](#page-35-6) Wang $\&$ Zou, [2021](#page-37-5)) due to its computational efficiency. For the first time, we achieve minimax-optimal sample complexity for RMGs through establishing matching upper and lower bounds. Specifically, let S and m denote the number of states and agents, respectively, A_i represent the number of actions available to the *i*-th agent, and H denote the horizon length. We focus on analyzing the minimal number of samples required to reach an ε -robust NE or CCE, where no agent has an incentive to unilaterally change its policy to improve its worst-case payoff, given that the transition model is constrained within an R-contamination set, with R representing the uncertainty level. Our contributions are as follows:

• We extend the Q-FTRL algorithm for standard MGs to RMGs and establish its sample complexity. Specifically, the proposed algorithm achieves an ε -robust CCE with the following sample complexity (up to logarithmic factors):

$$
\widetilde{O}\left(\frac{H^3 S \sum_{i=1}^m A_i}{\varepsilon^2} \min\left\{H, \frac{1}{R}\right\}\right)
$$

for a full range of $\varepsilon \in (0, H]$ and uncertainty level $R \in [0, 1]$. In the special case of two-player zero-sum RMGs, the algorithm also achieves an ε -robust NE with the same sample complexity. Compared to previous results [\(Shi et al.,](#page-36-7) [2024a](#page-36-7)[,c;](#page-36-5) [Ma et al.](#page-35-6), [2023\)](#page-35-6), our approach effectively addresses the challenges posed by multiple agents and long horizon lengths. Furthermore, our result holds for the entire range of ε and R, implying that the algorithm requires no burn-in cost, and allows for sufficient robustness. Detailed comparisons are in Table [1.](#page-2-0)

• For the R-contamination set considered in this work, we derive an information-theoretic lower bound on the sample complexity of RMGs with a generative model. Specifically, we show that to achieve an ε -robust CCE, the minimum required number of samples is at least of the order (up to logarithmic factors):

$$
\widetilde{O}\left(\frac{H^3 S \max_{1 \le i \le m} A_i}{\varepsilon^2} \min\left\{H, \frac{1}{R}\right\}\right).
$$

Combining this lower bound with our algorithm's sample complexity, we conclude that the proposed algorithm achieves minimax-optimal sample complexity when the number of agents is fixed.

1.2 Related works

In this section, we shall briefly review some works related to robust Markov games.

Standard Markov games. Early research on Markov games, also known as Multi-agent reinforcement learning (MARL) [\(Shapley,](#page-36-0) [1953;](#page-36-0) [Oroojlooy & Hajinezhad](#page-36-8), [2023;](#page-36-8) [Zhang et al.](#page-37-6), [2021\)](#page-37-6), primarily focused on asymptotic analysis [\(Littman & Szepesvári,](#page-35-8) [1996;](#page-35-8) [Littman et al.](#page-35-9), [2001\)](#page-35-9), but recent theoretical efforts have increasingly concentrated on finite-sample analysis. A significant portion of the literature has focused on the special case of two-player zero-sum Markov games, examples include [Bai et al.](#page-34-3) [\(2020](#page-34-3)); [Bai & Jin](#page-34-4) [\(2020\)](#page-34-4); [Zhong et al.](#page-37-7) [\(2022\)](#page-37-7); [Chen et al.](#page-34-5) [\(2022\)](#page-34-5); [Cui & Du](#page-34-6) [\(2022\)](#page-34-6); [Chen et al.](#page-34-7) [\(2019\)](#page-34-7); [Dou et al.](#page-34-8) [\(2022\)](#page-34-8); [Jia et al.](#page-35-10) [\(2019\)](#page-35-10); [Mao & Başar](#page-35-11) [\(2023](#page-35-11)); [Tian et al.](#page-36-9) [\(2021](#page-36-9)); [Wei et al.](#page-37-8) [\(2017\)](#page-37-8); [Yan et al.](#page-37-9) [\(2022\)](#page-37-9); [Yang & Ma](#page-37-10) [\(2022\)](#page-37-10). Other studies have aimed to develop computationally efficient algorithms for multi-agent general-sum MGs, including [Daskalakis et al.](#page-34-9) [\(2023](#page-34-9)); [Jin et al.](#page-35-12) [\(2021\)](#page-35-12); [Liu et al.](#page-35-13) [\(2021\)](#page-35-13); [Mao & Başar](#page-35-11) [\(2023](#page-35-11)); [Song et al.](#page-36-10) [\(2021\)](#page-36-10). The minimax-optimal sample complexity for finite-horizon settings has been established as $\widetilde{O}\left(\frac{H^4 S \sum_{i=1}^m A_i}{\epsilon^2}\right)$ [\(Li et al.](#page-35-0), [2022\)](#page-35-0), and has been achieved by [Li et al.](#page-35-0) [\(2022\)](#page-35-0) under the same generative model assumption employed in this work.

Robust reinforcement learning. In the context of single-agent reinforcement learning (RL), the study of model robustness through distributionally robust dynamic programming and robust Markov Decision Processes (MDPs) has garnered significant attention, both empirically and theoretically [\(Badrinath & Kalathil](#page-34-10), [2021;](#page-34-10) [Goyal & Grand-Clement](#page-34-11), [2023](#page-34-11); [Ho et al.](#page-34-12), [2018,](#page-34-12) [2021;](#page-34-13) [Iyengar](#page-35-14), [2005](#page-35-14); [Roy et al.](#page-36-11), [2017](#page-36-11); [Tamar et al.](#page-36-12), [2014;](#page-36-12) [Xu & Mannor](#page-37-11), [2010\)](#page-37-11). A growing body of work has focused on the finite-sample analysis for robust RL, where the agent aims to optimize its worst-case performance under a transition model constrained by an uncertainty set [\(Panaganti & Kalathil](#page-36-13), [2022;](#page-36-13) [Yang et al.,](#page-37-12) [2022;](#page-37-12) [Zhou et al.,](#page-37-13) [2021](#page-37-13); [Wang et al.](#page-36-14), [2023,](#page-36-14) [2024](#page-37-14); [Yang et al.,](#page-37-15) [2023\)](#page-37-15). Among these studies, [Wang & Zou](#page-37-5) [\(2021\)](#page-37-5) explored the robust variant of Q-learning algorithm under the R-contamination set and derived a sample complexity of $\widetilde{O}\left(\frac{SA}{(1-\gamma)^5\varepsilon^2}\right)$ in the discounted infinite-horizon setting, where γ represents the discount factor. However, this work does not explicitly provide the impact of robustness on the sample complexity.

Robust Markov games. Research on RMGs has explored robustness across various dimensions, including states [\(Han et al.,](#page-34-14) [2022](#page-34-14)), environment (probabilistic transition kernels) [\(Shi et al.,](#page-36-5) [2024c](#page-36-5)[,a](#page-36-7)), and policies [\(Kannan et al.,](#page-35-15) [2023\)](#page-35-15). This work focuses on the robustness in environment.

The most relevant works to this study include [Kardeş et al.](#page-35-5) [\(2011\)](#page-35-5); [Zhang et al.](#page-37-4) [\(2020b\)](#page-37-4); [Blanchet et al.](#page-34-2) (2024) ; [Ma et al.](#page-35-6) (2023) (2023) ; [Shi et al.](#page-36-5) $(2024c,a)$ $(2024c,a)$ $(2024c,a)$. In particular, Kardes et al. (2011) established the existence of NE in RMGs under mild conditions on the uncertainty set. [Zhang et al.](#page-37-0) [\(2020a\)](#page-37-0) demonstrated the asymptotic convergence of a Q-learning type algorithm under certain assumptions. [Ma et al.](#page-35-6) [\(2023\)](#page-35-6) proposed an algorithm for RMGs with a sample complexity of $\tilde{O}(H^6S \max_{1 \leq i \leq m} A_i^2/\varepsilon^2)$ when the uncertainty level $R \leq \varepsilon/(SH^2)$. This result implies that very little robustness can be tolerated when either H or S is

large. In cases of $\varepsilon/(SH^2) < R \leq p_{\min}/H$, where p_{\min} represents the minimal nominal transition probability, the sample complexity is proved to be $\tilde{O}(H^6S \max_{1 \leq i \leq m} A_i^2/(\varepsilon^2 p_{\min}^2))$. The algorithm proposed in [Blanchet et al.](#page-34-2) [\(2024\)](#page-34-2) can reach robust NE with sample complexity $\widetilde{O}(H^4S^3\prod_{i=1}^m A_i^2/\varepsilon^2)$. Later, [Shi et al.](#page-36-5) [\(2024c](#page-36-5)) achieved a better sample complexity of $\widetilde{O}(H^3S\prod_{i=1}^m A_i\min\{H,1/R\}/\varepsilon^2)$ for reaching a robust NE when $\varepsilon \in (0, \sqrt{\min\{H, 1/R\}}],$ which implies a $\widetilde{O}(H^3 S \prod_{i=1}^m A_i)$ burn-in cost. Recent work [Shi et al.](#page-36-7) [\(2024a\)](#page-36-7) achieved a sample complexity of $\widetilde{O}(H^6S\sum_{i=1}^m A_i\min\{H, 1/R\}/\varepsilon^4)$ for any $\varepsilon \in (0, \sqrt{\min\{H, 1/R\}}],$ which implies a $\widetilde{O}(H^5 S \sum_{i=1}^m A_i \max\{1, HR\})$ burn-in cost.

Notations and organization. The notation $x = [x(s, a_i)]_{(s, a_i) \in S \times A_i} \in \mathbb{R}^{SA_i}$ (resp. $x = [x(s)]_{s \in S} \in \mathbb{R}^{S}$)) denotes a vector assigning values to each state-action pair for the i-th agent (resp. each state). The Hadamard product of two vectors x and y is denoted as $x \circ y = [x(s) \cdot y(s)]_{s \in S}$ or as $x \circ y = [x(s, a_i) \cdot y(s)]_{s \in S}$ $y(s,a_i)]_{(s,a_i)\in\mathcal{S}\times\mathcal{A}_i}$. Notation $\textsf{Var}_P(V) = P(V \circ V) - (PV) \circ (PV)$ denotes the variance of V following the distribution of P. Notation $\Delta(S)$ represents the probability simplex over the set S. Moreover, with $\mathcal{X} := \{S, \{A_i\}_{i=1}^m, H, R, 1/\delta, 1/\varepsilon\}$, we also use $f(\mathcal{X}) = O(g(\mathcal{X}))$ or $f(\mathcal{X}) \lesssim g(\mathcal{X})$ to indicate that there exists a universal constant $C > 0$ such that $f(\mathcal{X}) \leq Cg(\mathcal{X})$. Similarly $f(\mathcal{X}) \geq g(\mathcal{X})$ indicates $g(\mathcal{X}) = O(f(\mathcal{X}))$. Additionally, the notation $\tilde{O}(\cdot)$ is defined in the same way as $O(\cdot)$ except that it hides logarithmic factors.

The remainder of this paper is organized as follows. Section [2](#page-3-0) reviews some basic concepts about the standard and robust MGs in finite-horizon setting. In Section [3,](#page-6-0) we propose an algorithm for RMGs with a generative model. Moreover, we present our main results, including the smaple complexity analysis of the proposed algorithm, and an information-theoretic lower bound for RMGs. Section [4](#page-9-0) outlines the key steps of our theoretical analysis, and the other proof details are deferred to Appendix. Finally, Section [5](#page-13-0) concludes the main paper with additional discussions.

2 Background

In this section, we first introduce some basics for standard MGs in a finite-horizon setting, which facilitates the understanding of RMGs. Then we formulate the RMGs and describe our goal.

2.1 Standard Markov games

A finite-horizon, non-stationary multi-player general-sum Markov game (MG) with m players competing against each other is represented by $\mathcal{MG} = \{S, \{A_i\}_{1 \leq i \leq m}, H, P, r\}$, where $S = \{1, \dots, S\}$ represents the state space of the shared environment, $A_i = \{1, \dots, A_i\}$ is the action space for the *i*-th player, *H* denotes the horizon of the Markov game, $P = \{P_h\}_{1 \leq h \leq H}$ with $P_h : S \times A \to \Delta(S)$ describes the transition probability kernel for $\mathcal{MG},$ and $r = \{r_{i,h}\}_{1 \leq h \leq H, 1 \leq i \leq m}$ with $r_{i,h} : \mathcal{S} \times \mathcal{A} \to [0,1]$ denotes the reward received by the *i*-th player. Here, A is defined as the Cartesian product $A := A_1 \times \cdots \times A_m$. Furthermore, for each $i \in [m]$, we denote $\mathcal{A}_{-i} := \prod_{j \neq i} \mathcal{A}_j$, which represents the action space of all players except the *i*-th one. We use notation $a \in A$ and $a_{-i} \in A_{-i}$ to denote a joint action of all players (or a joint action excluding the *i*-th player's action). For any $(s, a, h, s') \in \mathcal{S} \times \mathcal{A} \times [H] \times \mathcal{S}$, we let $P_h(s'|s, a)$ represent the transition probability from state s to state s' at step h, given that the joint action a is taken by the players. Additionally, $r_{i,h}(s, a) \in [0, 1]$ indicates the (deterministic) immediate normalized reward that the i-th player receives at state s and step h after taking the joint action a .

Markov policies. This paper focuses on Markov policies, which select actions based solely on the current state s and step h, independent of previous trajectories. Specifically, denote policy of the i -th player as $\pi_i = \{\pi_{i,h}\}_{1\leq k\leq H}$, where $\pi_{i,h}(\cdot|s) \in \Delta(\mathcal{A}_i)$ denotes the probability distribution of the *i*-th player's action over space $\overline{\mathcal{A}_i}$ for state s at step h. The joint Markov policy of all players is defined as $\pi = (\pi_1, \dots, \pi_m)$ ${\lbrace \pi_h \rbrace_{1 \leq h \leq H} : S \times [H] \to \Delta(\mathcal{A})$, where ${\pi_h(\cdot|s) = (\pi_{1,h}, \cdots, \pi_{m,h})(\cdot|s) \in \Delta(\mathcal{A})}$ specifies the joint action distribution for all players at state s and step h. For any joint policy π , we use π_{-i} to denote the policies of all players except the *i*-th player, and use $\pi_{-i,h}$ to represent the policies of all but the *i*-th player at step h. Value functions and Q functions. For a given joint policy π and transition kernel P, the long-term cumulative reward of agent i in MG is quantified through the value function $V_{i,h}^{\pi,P} : \mathcal{S} \to \mathbb{R}$ and Q-function $Q_{i,h}^{\pi,P}$: $S \times A \rightarrow \mathbb{R}$ for the *i*-th agent, defined as follows:

$$
V_{i,h}^{\pi,P}(s) := \mathbb{E}_{\pi,P} \left[\sum_{t=h}^{H} r_{i,t}(s_t, a_t) \mid s_h = s \right], \quad \forall (i,h,s) \in [m] \times [H] \times S,
$$

$$
Q_{i,h}^{\pi,P}(s,a) := \mathbb{E}_{\pi,P} \left[\sum_{t=h}^{H} r_{i,t}(s_t, a_t) \mid s_h = s, a_h = a \right], \quad \forall (i,h,s,a) \in [m] \times [H] \times S \times A.
$$

where the expectation is taken over the distribution $a_t \sim \pi_t(\cdot \mid s_t), s_{t+1} \sim P_t(\cdot \mid s_t, a_t), t \geq h$ for $V_{i,h}^{\pi,P}(s)$, and $a_{t+1} \sim \pi_{t+1}(\cdot \mid s_{t+1}), s_{t+1} \sim P_t(\cdot \mid s_t, a_t), t \geq h \text{ for } Q_{i,h}^{\pi,P}(s,a)$.

2.2 Robust Markov games

A multi-agent general-sum robust Markov game (RMG) in the finite-horizon setting is represented by

$$
\mathcal{MG}_{\text{rob}} = \left\{ \mathcal{S}, \{ \mathcal{A}_i \}_{1 \leq i \leq m}, \mathcal{U}^R(P^0), r, H \right\},\
$$

where $S, \{A_i\}, r, H$ and policies are defined as in standard MGs (cf. Section [2.1\)](#page-3-1). The key distinction from standard MGs is that: instead of transitioning according to a fixed probability kernel, players in an RMG aim to maximize their worst-case cumulative reward, assuming the probability kernel resides within an uncertainty set $\mathcal{U}^R(P^0)$ centered around the nominal probability kernel P^0 . This modification leads to differences in the definitions of the value and Q-functions, which will be detailed later.

In the case of two-player zero-sum RMGs, we have $m = 2$ and $r_{2,h} = -r_{1,h}$. All other definitions remain consistent with those in the multi-agent general-sum RMGs.

Uncertainty set with agent-wise (s, a) -rectangularity. Now we intend to introduce the uncertainty sets $\mathcal{U}^R(P^0)$ for RMGs. In this work, the uncertainty set is constructed using the R-contamination model [\(Huber,](#page-35-7) [1965\)](#page-35-7), which has been extensively used in the context of robust statistics [\(Huber](#page-35-16), [1973;](#page-35-16) [Huber & Ronchetti](#page-35-17), [2011\)](#page-35-17), economics [\(Nishimura & Ozaki](#page-36-15), [2004,](#page-36-15) [2006\)](#page-36-16), statistical learning [\(Duchi et al.,](#page-34-15) [2019\)](#page-34-15), and robust reinforcement learning [\(Wang & Zou,](#page-37-5) [2021](#page-37-5)). Following [Shi et al.](#page-36-5) [\(2024c](#page-36-5)), we consider a multi-agent variant of rectangularity in RMGs — agent-wise (s, a) -rectangularity, which enables the robust counterpart of Bellman equations and computational tractability of the problems [\(Iyengar,](#page-35-14) [2005](#page-35-14); [Shi et al.,](#page-36-6) [2024b;](#page-36-6) [Wiesemann et al.](#page-37-16), [2013;](#page-37-16) [Zhou et al.,](#page-37-13) [2021\)](#page-37-13).

Specifically, denote nominal probability kernel $P^0 = \{P_h^0\}_{h=1}^H$ with $P_h^0 : \mathcal{S} \times \mathcal{A} \to \Delta(\mathcal{S})$. The uncertainty set $\mathcal{U}^R(P^0)$, based on R-contamination model and satisfying agent-wise (s, a) -rectangularity, is mathematically defined as:

$$
\mathcal{U}^{R}(P^{0}) = \otimes \mathcal{U}^{R}(P^{0}_{h,s,a}), \quad \text{with} \quad \mathcal{U}^{R}(P^{0}_{h,s,a}) = \left\{ (1 - R)P^{0}_{h,s,a} + RP'|P' \in \Delta(\mathcal{S}) \right\},\tag{1}
$$

where \otimes represents the Cartesian product, and $P_{h,s,a}^0$ denotes the transition probability at state-action pair $(s, a) \in S \times A$, that is

$$
P_{h,s,\boldsymbol{a}}^0 := P_h^0(\cdot \mid s, \boldsymbol{a}) \in \mathbb{R}^S.
$$

Here $R \in [0, 1]$ denotes the size of the uncertainty set and is referred to as the uncertainty level.

Robust value functions and robust Bellman equations. For any given joint policy π , the worst-case performance of the i -th agent at time step h, over all possible transition kernels within uncertainty set $U^R(P^0)$, is quantified by the robust value function $V_{i,h}^{\pi,R}$ and the robust Q-function $Q_{i,h}^{\pi,R}$, which are defined as follows:

$$
V_{i,h}^{\pi,R}(s) = \inf_{P \in \mathcal{U}^{R}(P^0)} V_{i,h}^{\pi,P}(s) = \inf_{P \in \mathcal{U}^{R}(P^0)} \mathbb{E}_{\pi,P} \left[\sum_{t=h}^{H} r_{i,t}(s_t, a_t) | s_h = s \right],
$$

$$
Q_{i,h}^{\pi,R}(s, a) = \inf_{P \in \mathcal{U}^{R}(P^{0})} Q_{i,h}^{\pi,P}(s, a) = \inf_{P \in \mathcal{U}^{R}(P^{0})} \mathbb{E}_{\pi,P} \left[\sum_{t=h}^{H} r_{i,t}(s_{t}, a_{t}) | s_{h} = s, a_{h} = a \right],
$$

for all $(i, h, s, a) \in [m] \times [H] \times S \times A$.

In the context of RMGs, each agent aims to compete with other agents and maximize its worst-case performance. To characterize this, given the joint policy π_{-i} of all players except the *i*-th one, we use $V_{i,h}^{*,\pi_{i},R}$ to represent the optimal robust value function of the *i*-th agent by playing an independent policy π'_i , which is defined as:

$$
V_{i,h}^{*,\pi_{-i},R}(s) := \max_{\pi'_i: \mathcal{S} \times [H] \to \Delta(\mathcal{A}_i)} V_{i,h}^{\pi'_i \times \pi_{-i},R}(s) = \max_{\pi'_i: \mathcal{S} \times [H] \to \Delta(\mathcal{A}_i)} \inf_{P \in \mathcal{U}^R(P^0)} V_{i,h}^{\pi'_i \times \pi_{-i},P}(s).
$$

As in standard MGs, it can be shown that there exists at least one policy — referred to as the robust bestresponse policy for the *i*-th agent—that achieves $V_{i,1}^{*,\pi_{-i},R}(s)$ for all $s \in S$ and $h \in [H]$ (see [Blanchet et al.](#page-34-2) [\(2024\)](#page-34-2), Section A.2).

The robust value functions $\{V_{i,h}^{\pi,R}\}$ of RMGs with any joint policy π satisfy the following robust Bellman consistency equation: for all $(i, h, s) \in [m] \times [H] \times S$,

$$
V_{i,h}^{\pi,R}(s) = \mathbb{E}_{\mathbf{a}\sim\pi_h(\cdot|s)} \left[r_{i,h}(s,\mathbf{a}) + \inf_{P_{h,s,\mathbf{a}} \in \mathcal{U}^R(P_{h,s,\mathbf{a}}^0)} P_{h,s,\mathbf{a}} V_{i,h+1}^{\pi,R} \right]
$$

= $\mathbb{E}_{\mathbf{a}\sim\pi_h(\cdot|s)} \left[r_{i,h}(s,\mathbf{a}) + (1-R) P_{h,s,\mathbf{a}}^0 V_{i,h+1}^{\pi,R} + R \min V_{i,h+1}^{\pi,R} \right].$

This robust Bellman equation is inherently tied to the agent-wise (s, a) -rectangularity condition and the R-contamination model (cf. (1)).

Equilibria in robust Markov games. In RMGs, each player seeks to maximize its own value function under the worst-case transition scenarios. Due to the competing objectives of players, finding an equilibrium is central to the study of RMGs. Below, we introduce two robust variants of common solution concepts robust Nash Equilibrium (NE) and robust Coarse Correlated Equilibrium (CCE).

• Robust NE. A product policy $\pi = \pi_1 \times \pi_2 \times \cdots \times \pi_m$ is a robust NE if

$$
\forall (i,s) \in [m] \times \mathcal{S}: \quad V_{i,1}^{\pi,R}(s) = V_{i,1}^{\star,\pi_{-i},R}(s). \tag{2}
$$

A robust NE implies that, given the strategies of the other players π_{-i} , no player can improve its worst-case performance over the uncertainty set $\mathcal{U}^R(P^0)$ by unilaterally deviating from its current strategy.

• Robust CCE. A (possibly correlated) joint policy $\pi \in \mathcal{S} \times [H] \to \Delta(\mathcal{A})$ is a robust CCE if

$$
\forall (i,s) \in [m] \times \mathcal{S}: \quad V_{i,1}^{\pi,R}(s) \ge V_{i,1}^{\star,\pi_{-i},R}(s). \tag{3}
$$

Robust CCE can be regarded as relaxation of robust NE. It also guarantees that no player benefits from unilaterally deviating its current strategy, but it allows for the possibility that the players' policies may be correlated.

It is well-known that computing exact robust equilibria is a challenging task and may not always be necessary. Therefore, approximate equilibria are often sought which introduces the concept of an ε -robust NE. A product policy $\pi = \pi_1 \times \cdots \times \pi_m$ is said to be an ε -robust NE if

$$
\text{gap}_{\text{NE}}(\pi) = \max_{s \in \mathcal{S}} \text{gap}(\pi; s) \le \varepsilon, \quad \text{with} \quad \text{gap}(\pi; s) := \max_{1 \le i \le m} \left\{ V_{i,1}^{\star, \pi_{-i}, R}(s) - V_{i,1}^{\pi, R}(s) \right\}. \tag{4}
$$

Similarly, a slight relaxation of the definition in [\(3\)](#page-5-0) introduces the concept of ε -robust CCE. A possibly correlated joint policy $\pi \in \mathcal{S} \times [H] \to \Delta(\mathcal{A})$ is said to be an ε -robust CCE if

$$
\text{gap}_{\text{CCE}}(\pi) = \max_{s \in \mathcal{S}} \text{gap}(\pi; s) \le \varepsilon, \quad \text{with} \quad \text{gap}(\pi; s) := \max_{1 \le i \le m} \left\{ V_{i,1}^{\star, \pi_{-i}, R}(s) - V_{i,1}^{\pi, R}(s) \right\}. \tag{5}
$$

The existence of robust NEs has been proved under general conditions for the uncertainty set [\(Blanchet et al.](#page-34-2), [2024\)](#page-34-2), and it directly implies the existence of robust CCEs [\(Shi et al.,](#page-36-5) [2024c](#page-36-5)).

Sampling mechanism: a generative model. In this paper, we adopt a commonly used sampling mechanism in standard MARL [\(Li et al.,](#page-35-0) [2022;](#page-35-0) [Zhang et al.,](#page-37-4) [2020b\)](#page-37-4). Specifically, we assume access to a generative model (simulator) [\(Kearns & Singh](#page-35-18), [1998\)](#page-35-18), which returns an independent sample of state s' based on the nominal transition kernel P^0 , as follows:

$$
s' \sim P_h^0(\cdot|s, \boldsymbol{a}),
$$

for any pair $(s, a, h) \in S \times A \times [H]$ selected by the learners. The objective of this paper is to compute an ε -robust equilibrium for the game $\mathcal{MG}_{\text{rob}}$ with as few samples as possible.

3 Sample-efficient robust Markov games

In this section, we extend the Q-FTRL algorithm proposed by [Li et al.](#page-35-0) [\(2022\)](#page-35-0) to the context of RMG, and show that it retains the minimax sample complexity in this setting.

3.1 Algorithm description

The proposed algorithm leverages the principles of optimism and the Follow-the-Regularized-Leader (FTRL) framework. It operates by working backwards from the terminal step H to the initial step $h = 1$. At each step h, each agent i samples K times from nominal transition probability for each state-action pair $(s, a_i) \in S \times A$, and estimates the worst-case Q-function under the current policy after each sampling. Subsequently, each agent utilizes the FTRL method to update its policy $\hat{\pi}_{i,h}^{k+1}$, such that the resulting joint correlated policy approximates a robust CCE at step h . Once the estimation at step h is completed, the algorithm computes the value function under the optimized policy and proceeds to the next step $h-1$.

We now present the mathematical formulation of the proposed algorithm. The algorithm begins by initializing value functions as $\hat{V}_{i,H+1} = 0 \in \mathbb{R}^S$ for all agents $1 \leq i \leq m$. It then iterates over each step h, utilizing the value function estimates $\{\hat{V}_{i,h+1}\}_{i=1}^m$ from the previous step. Specifically, at each step h, the procedure proceeds in two phases: policy updates and value function estimation.

Algorithm 1: Sample-efficient Robust Q-FTRL

Sampling and policy updates At each step, the algorithm draws K samples from the generative model for each state-action pair $(s, a_i) \in S \times A_i$ for all $i \in [m]$, using these samples to update policies. Specifically, in

the k-th round of sampling, a tuple of samples $\{a_h^k(s, a_i) = \{a_{j,h}^k(s, a_i)\}_{j=1}^m$, $r_{i,h}^k(s, a_i)$, $s_{i,h+1}^k(s, a_i)\}_{(s, a_i) \in S \times A_i}$ is drawn for each agent i according to the following rules:

$$
a_{j,h}^k(s, a_i) \sim \pi_{j,h}^k(\cdot|s), \ (j \neq i) \quad \text{and} \quad a_{i,h}^k(s, a_i) = a_i;
$$
 (6)

$$
r_{i,h}^k(s, a_i) = r_{i,h}(s, a_h^k(s, a_i)); \qquad s_{i,h+1}^k(s, a_i) \sim P_h^0(\cdot | s, a_h^k(s, a_i)), \tag{7}
$$

where $\pi_{j,h}^k(\cdot|s)$ is initialized as $\pi_{j,h}^1(a_j|s) = 1/A_j$ for all $(s, a_j, j) \in S \times A_j \times [m]$. For convenience, we collect samples for all state-action pairs into a reward vector $r_{i,h}^k \in \mathbb{R}^{SA_i}$ and an empirical transition probability matrix $P_{i,h}^k \in \mathbb{R}^{SA_i \times S}$, given by

$$
r_{i,h}^k = [r_{i,h}^k(s, a_i)]_{(s,a_i)\in\mathcal{S}\times\mathcal{A}_i} \in \mathbb{R}^{SA_i},\tag{8}
$$

$$
P_{i,h}^k(s'|s, a_i) = 1, \text{ for } s' = s_{h+1}^k(s, a_i), \text{ and } P_{i,h}^k(s'|s, a_i) = 0, \text{ otherwise.}
$$
 (9)

Next, we update the Q-function using robust Q-learning follows:

$$
Q_{i,h}^k = (1 - \alpha_k) Q_{i,h}^{k-1} + \alpha_k q_{i,h}^k,
$$
\n(10)

where $0 < \alpha_k < 1$ is the learning rate, $Q_{i,h}^k \in \mathbb{R}^{SA_i}$ is initialized as $Q_{i,h}^0 = 0$, and $q_{i,h}^k$ is computed as

$$
q_{i,h}^k = r_{i,h}^k + (1 - R)P_{i,h}^k \widehat{V}_{i,h+1} + R \min_{s} \widehat{V}_{i,h+1}.
$$

After updating the Q-function estimates, the algorithm uses the FTRL strategy [\(Shalev-Shwartz,](#page-36-17) [2012\)](#page-36-17) to update the policy of the i -th agent as follows:

$$
\pi_{i,h}^{k+1}(\cdot|s) = \frac{\exp\left(\eta_{k+1}Q_{i,h}^k(s,\cdot)\right)}{\sum_{a\in\mathcal{A}_i}\exp\left(\eta_{k+1}Q_{i,h}^k(s,a)\right)}, \quad \forall s \in \mathcal{S},\tag{11}
$$

where $\eta_{k+1} > 0$ is another learning rate associated with the policy updates.

Value function estimation After K rounds of the above procedure, we construct the final policy estimate $\widehat{\pi}_h : \mathcal{S} \to \Delta(\mathcal{A})$ as

$$
\widehat{\pi}_h(\mathbf{a}|s) = \sum_{k=1}^K \alpha_k^K \prod_{i=1}^m \pi_{i,h}^k(a_i|s), \quad \forall (s,\mathbf{a}) \in \mathcal{S} \times \mathcal{A},
$$

where

$$
\alpha_k^K = \alpha_k \prod_{j=k+1}^K (1 - \alpha_j), \quad 1 \le k \le K.
$$

Moreover, we estimate the value function $\widehat{V}_{i,h} \in \mathbb{R}^S$ for step h under $\widehat{\pi}_h$. To obtain an optimistic estimation, we introduce a bonus term $\beta_{i,h} \in \mathbb{R}^S$ with the s-th entry given by

$$
\beta_{i,h}(s) = c_{\mathsf{b}} \sqrt{\frac{\log^3 \frac{KS \sum_{i=1}^m A_i}{\delta}}{K \min \{H, \frac{1}{R}\}} \sum_{k=1}^K \alpha_k^K} \left\{ \mathsf{Var}_{\pi_{i,h,s}^k}(q_{i,h,s}^k) + \min \left\{H, \frac{1}{R}\right\} \right\},\tag{12}
$$

where $q_{i,h,s}^k = q_{i,h}^k(\cdot|s) \in \mathbb{R}^{A_i}$, and $\pi_{i,h,s}^k = \pi_{i,h}^k(\cdot|s) \in \Delta(\mathcal{A}_i)$. The value function $\widehat{V}_{i,h}$ is then estimated as

$$
\widehat{V}_{i,h}(s) = \min\left\{\sum_{k=1}^{K} \alpha_k^K \mathbb{E}_{a_i \sim \pi_{i,h,s}^k} q_{i,h,s}^k + \beta_{i,h}(s), H - h + 1\right\}, \quad \forall s \in \mathcal{S}.
$$
\n(13)

Equipped with $\hat{\pi}_h$ and $\hat{V}_{i,h}$, the algorithm proceeds to step $h-1$ and repeats the aforementioned operations.

Finally, we remark that the output policy $\hat{\pi}$ is a correlated instead of product policy. In the special case of two-player zero-sum robust Markov games, we could alternatively output a product policy as $\hat{\pi} = \hat{\pi}_1 \times \hat{\pi}_2$, where

$$
\widehat{\pi}_i = \{\widehat{\pi}_{i,h}\}_{1 \le h \le H}, \quad \text{with} \quad \widehat{\pi}_{i,h} = \sum_{k=1}^K \alpha_k^K \pi_{i,h}^k, \quad \forall i = 1, 2.
$$

The entire procedure is summarized in Algorithm [1,](#page-6-1) with the total number of samples being $KHS\sum_{i=1}^{m} A_i$.

3.2 Main results

In this section, we present our main theoretical results concerning the sample complexity of RMGs, which include both an upper bound for the sample complexity of the proposed Algorithm [1](#page-6-1) and an informationtheoretic lower bound.

The sample complexity of Algorithm [1](#page-6-1) is formalized in the following theorem, the proof of which is postponed to Section [4.](#page-9-0)

Theorem 1. *Consider an m-player robust general-sum Markov game with uncertainty set* U^R *defined in* [\(1\)](#page-4-0) *and uncertainty level* R*. Suppose that the step-size*

$$
\alpha_k = \frac{c_\alpha \log K}{k - 1 + c_\alpha \log K}, \quad \eta_k = \sqrt{\frac{\log K}{\alpha_k \min\left\{H, \frac{1}{R}\right\}}},\tag{14}
$$

where $c_{\alpha} > 0$ *is a constant. For any* $\varepsilon \in (0, H]$, $0 \leq R < 1$, and $0 < \delta < 1$, with probability at least $1 - \delta$, *the joint policy* $\hat{\pi}$ *returned by Algorithm [1](#page-6-1) achieves an* ε *-robust CCE* (*cf.* [\(5\)](#page-5-1))

$$
\text{gap}_{\text{CCE}}(\widehat{\pi}) \leq \varepsilon
$$

as long as the total number of samples

$$
KHS\sum_{i=1}^{m} A_i \ge \frac{CH^3 S \sum_{i=1}^{m} A_i}{\varepsilon^2} \min\left\{H, \frac{1}{R}\right\} \log^3\left(\frac{KS \sum_{i=1}^{m} A_i}{\delta}\right),\tag{15}
$$

where C > 0 *is a large enough universal constant.*

Let us consider the special case of two-player zero-sum RMGs. Under the same conditions specified in Theorem [1,](#page-8-0) Algorithm [1](#page-6-1) achieves an ε -robust NE as stated in the following corollary. Its proof is direct and is postponed to Appendix [B.](#page-25-0)

Corollary 1. Consider a two-player zero-sum robust Markov game with uncertainty set \mathcal{U}^R defined in [\(1\)](#page-4-0) *and uncertainty level* R. Suppose that the step-size is taken as [\(14\)](#page-8-2). For any $\varepsilon \in (0, H]$, $0 \leq R < 1$, and $any \ 0 < \delta < 1$ $any \ 0 < \delta < 1$, with probability at least $1 - \delta$, the product policy $\hat{\pi}_1 \times \hat{\pi}_2$ outputted by Algorithm 1 achieves *an* ε*-robust NE (cf.* [\(4\)](#page-5-2)*)*

$$
\textsf{gap}_{\textsf{NE}}(\widehat{\pi}) \leq \varepsilon
$$

as long as the total number of samples

$$
KHS(A_1 + A_2) \ge \frac{CH^3S(A_1 + A_2)}{\varepsilon^2} \min\left\{H, \frac{1}{R}\right\} \log^3\left(\frac{KS(A_1 + A_2)}{\delta}\right),
$$

where $C > 0$ *is a large enough universal constant.*

The following theorem establishes an information-theoretic lower bound for learning RMGs with a generative model. Its proof is postponed to Appendix [C.](#page-25-1)

Theorem 2. *Consider any* $m \geq 2$, $H \geq 16$, $0 < \varepsilon < c_0H$, and any $R \in [0, c_R)$, where $c_0 > 0$ is a small *enough constant and* c_R *is a constant within* $(0, 1)$ *. We can construct a collection of m-player general-sum robust Markov games — denoted by* $\{M\mathcal{G}_{\theta}\}_{\theta \in \Theta}$ *, such that for any dataset comprising* N *independent samples generated from the nominal environment for each state-action pairs* $(s, a_i) \in S \times A_i$, $1 \le i \le m$, one has

$$
\inf_{\widehat{\pi}} \max_{\theta \in \Theta} \mathbb{P}_{\theta} \left(\textsf{gap}_{\textsf{CCE}}(\widehat{\pi}) > \varepsilon \right) \ge \frac{1}{4},
$$

provided that

$$
NHS \max_{1 \le i \le m} A_i \le \frac{C_1 H^3 S \max_{1 \le i \le m} A_i}{\varepsilon^2} \min \left\{ H, \frac{1}{R} \right\}.
$$

Here, C_1 *is some small enough constant, the infimum is taken over all estimators* $\hat{\pi}$ *, and* \mathbb{P}_{θ} *denotes the probability when the game is* \mathcal{MG}_{θ} *for all* $\theta \in \Theta$ *.*

According to Theorem [1,](#page-8-0) the sample complexity of Algorithm [1](#page-6-1) is given by (up to logarithmic factors)

$$
\widetilde{O}\left(\frac{H^3 S \sum_{i=1}^m A_i}{\varepsilon^2} \min\left\{H, \frac{1}{R}\right\}\right).
$$

When compared to the information-theoretic lower bound established in Theorem [2,](#page-9-1) we observe that this complexity is minimax optimal (up to logarithmic terms), provided the number of players m remains fixed or grows logarithmically with respect to the problem parameters. To the best of our knowledge, this is the first algorithm for RMGs to achieve minimax optimal sample complexity.

Furthermore, our sample complexity holds for the entire range of $\varepsilon \in (0, H]$. This is particularly favoring for data-limited applications, as it implies that the algorithm incurs no burn-in cost, making it efficient in scenarios where collecting sample is costly.

4 Analysis

4.1 Notations and technical lemmas

We first introduce some notations. Define \overline{V} as the estimation for V by replacing all expectation operation with the empirical estimation calculated according to $(r_{i,h}^k, P_{i,h}^k)$. Specifically, define

\overline{V}_{i,h}^{*,\hat{\pi}_{-i},R}(s) = \max_{a_i \in \mathcal{A}_i} \sum_{k=1}^K \alpha_k^K \left[r_{i,h}^k(s, a_i) + (1 - R) P_{i,h}^k(s, a_i) \overline{V}_{i,h+1}^{*,\hat{\pi}_{-i},R} + R \min \overline{V}_{i,h+1}^{*,\hat{\pi}_{-i},R} \right].
$$

where $P_{i,h}^k(s, a_i) = P_{i,h}^k(\cdot | s, a_i) \in \mathbb{R}^S$ and $\overline{V}_{i,H+1}^{\hat{\pi},R} = \overline{V}_{i,H+1}^{\star,\hat{\pi}_{-i},R} = 0$. Moreover, define

and the corresponding value function estimation $\overline{V}^{\hat{\pi}_{i}^{*} \times \hat{\pi}_{-i},R}_{i,h}$ with $\overline{V}^{\hat{\pi}_{i}^{*},\hat{\pi}_{-i},R}_{i,H+1} = 0$ as

where $\hat{\pi}_{i,h,s}^{\star} = \hat{\pi}_{i,h}^{\star}(\cdot|s) \in \Delta(\mathcal{A}_i)$. Define the expected reward and the nominal transition probability matrix under policy $\hat{\pi}$ as

=\sum_{k=1}^{K} \alpha_k^K \mathbb{E}_{a_i \sim \pi_{i,h,s}^k} \left[\mathbb{E}_{a_j \sim \pi_{j,h,s}^k, j \neq i} [r_{i,h}(s, \boldsymbol{a})|a_i]\right],
$$
\n(21)

$$
P_{h,s}^{\hat{\pi}} = \mathbb{E}_{a \sim \hat{\pi}} P_{h,s,a}^0 = \sum_{k=1}^K \alpha_k^K \mathbb{E}_{a_j \sim \pi_{j,h,s}^k} P_{h,s,a}^0
$$
\n(22)

$$
=\sum_{k=1}^{K} \alpha_k^K \mathbb{E}_{a_i \sim \pi_{i,h,s}^k} \left[\mathbb{E}_{a_j \sim \pi_{j,h,s}^k, j \neq i} \left[P_{h,s,a}^0 | a_i \right] \right]. \tag{23}
$$

Similarly, the expected reward and the nominal transition probability matrix under policy $\hat{\pi}_i^* \times \hat{\pi}_{-i}$ is denoted as

r_{i,h}^{\hat{\pi}_i^* \times \hat{\pi}_{-i}}(s) = \mathbb{E}_{\mathbf{a} \sim \hat{\pi}_i^* \times \hat{\pi}_{-i}} r_{i,h}(s,\mathbf{a}),

P_h^{\hat{\pi}_s^* \times \hat{\pi}_{-i}}(s) = \mathbb{E}_{\mathbf{a} \sim \hat{\pi}_i^* \times \hat{\pi}_{-i}} P_{h,s,\mathbf{a}}^0.

In addition, we define an empirical probability transition matrix $\widehat{P}_{i,h}^{\widehat{\pi}} \in \mathbb{R}^{S \times S}$ whose s-th row is

Finally, define $P_h^{\hat{\pi}, V} \in \mathbb{R}^{S \times S}$ (resp. $P_h^{\hat{\pi}_i^* \times \hat{\pi}_{-i}, V}$, $\hat{P}_{i,h}^{\hat{\pi}, V}$) as the matrix with the s-th row

$$

which represents the probability transition kernel in the uncertainty set $\mathcal{U}^R(P_{h,s}^{\hat{\pi}})$ (resp. $P_{h,s}^{\hat{\pi}^*_{s}\times\hat{\pi}_{-i}}$, $\hat{P}_{i,h,s}^{\hat{\pi}}$) that leads to the worst-case value for vector $V \in \mathbb{R}^S$. It is obvious that the above definitions are equivalent to

where $e_i \in \mathbb{R}^S$ denotes the *i*-th standard basis vector. Then the estimation $\widehat{V}_{i,h}$ in [\(13\)](#page-7-5) and the $\overline{V}_{i,h}^{\widehat{\pi},R}$ in [\(16\)](#page-9-2) can be rewritten as

Before diving into the proof details, we first present a technical lemma that states some properties about $\widehat{V}_{i,h}$. Its proof is deferred to Appendix [A.2.](#page-14-0)

Lemma 1. For any $i \in [m], 1 \leq h \leq H$, $s \in \mathcal{S}$ and $1 \leq k \leq K$, assume that K satisfies [\(15\)](#page-8-3). We have

4.2 Proof of Theorem [1](#page-8-0)

According to the definition of $\text{gap}_{\text{CCE}}(\hat{\pi})$ in [\(5\)](#page-5-1), it suffices to prove that for all $i \in [m]$,

= $V_{i,h}^{\widehat{\pi}_{i}^{\star}\times\widehat{\pi}_{-i},R} - \overline{V}_{i,h}^{\widehat{\pi}_{i}^{\star}\times\widehat{\pi}_{-i},R} + \overline{V}_{i,h}^{\widehat{\pi}_{i}^{\star}\times\widehat{\pi}_{-i},R} - \widehat{V}_{i,h} + \widehat{V}_{i,h} - \overline{V}_{i,h}^{\widehat{\pi},R} + \overline{V}_{i,h}^{\widehat{\pi},R} - V_{i,h}^{\widehat{\pi},R},$ (32)

where we use the fact that $V_{i,h}^{\star,\hat{\pi}_{-i},R} = V_{i,h}^{\hat{\pi}_i^{\star}\times\hat{\pi}_{-i},R}$ (cf. [\(18\)](#page-9-3)).

Below we shall complete the proof of Theorem [1](#page-8-0) in four steps: we first bound each term in the RHS of [\(32\)](#page-11-0) separately, and then combine the results.

Step 1. bounding $V_{i,h}^{\hat{\pi}_i^* \times \hat{\pi}_{-i},R} - \overline{V}_{i,h}^{\hat{\pi}_i^* \times \hat{\pi}_{-i},R}$ and $\overline{V}_{i,h}^{\hat{\pi},R} - V_{i,h}^{\hat{\pi},R}$. We start from decomposing the difference term $\overline{V}_{i,h}^{\hat{\pi},R} - V_{i,h}^{\hat{\pi},R}$. According to the definition of $V_{i,h}^{\hat{\pi},R}$ and policy $\hat{\pi}$, we have

= $r_{i,h}^{\hat{\pi}}(s) + (1-R)P_{h,s}^{\hat{\pi}} V_{i,h+1}^{\hat{\pi},R} + R \min V_{i,h+1}^{\hat{\pi},R}$
= $r_{i,h}^{\hat{\pi}}(s) + P_{h,s}^{\hat{\pi},V_{i,h+1}^{\hat{\pi},R}} V_{i,h+1}^{\hat{\pi},R},$

where $r_{i,h}^{\hat{\pi}}$ and $P_{h,s}^{\hat{\pi}}$ are defined in [\(20\)](#page-9-4) and [\(22\)](#page-10-0), respectively, and $P_{h,s}^{\hat{\pi},V}$ is defined in [\(27\)](#page-10-1).

For convenience, we introduce an error term as

$$
\n
$$
= \zeta_{i,h}^{\hat{\pi},R} + P_h^{\hat{\pi},\overline{V}_{i,h+1}^{\hat{\pi},R}} \overline{V}_{i,h+1}^{\hat{\pi},R} - P_h^{\hat{\pi},V_{i,h+1}^{\hat{\pi},R}} V_{i,h+1}^{\hat{\pi},R}
$$
\n
$$
\overset{(i)}{\leq} \zeta_{i,h}^{\hat{\pi},R} + P_h^{\hat{\pi},V_{i,h+1}^{\hat{\pi},R}} \left(\overline{V}_{i,h+1}^{\hat{\pi},R} - V_{i,h+1}^{\hat{\pi},R} \right) \leq \sum_{h'=h}^{H} \prod_{j=h}^{h'-1} P_j^{\hat{\pi},V_{i,j+1}^{\hat{\pi},R}} \zeta_{i,h'}^{\hat{\pi},R},
$$

where (i) uses the fact that $P_h^{\hat{\pi},V} V \leq P_h^{\hat{\pi},V'}$ $h^{(\pi, V)}$ V for any pair of value functions V and V'. Similarly, the term $V_{i,h}^{\hat{\pi}_i^* \times \hat{\pi}_{-i},R} - \overline{V}_{i,h}^{\hat{\pi}_i^* \times \hat{\pi}_{-i},R}$ can be decomposed by introducing the error term

where $r_{i,h}^{\hat{\pi}_i^* \times \hat{\pi}_{-i}}$ and $P_h^{\hat{\pi}_i^* \times \hat{\pi}_{-i},V}$ are defined in [\(24\)](#page-10-2) and [\(25\)](#page-10-3), respectively, and $P_h^{\hat{\pi}_i^* \times \hat{\pi}_{-i},V}$ is defined in [\(27\)](#page-10-1). The the term $V^{\hat{\pi}^*_i \times \hat{\pi}_{-i},R}_{i,h} - \overline{V}^{\hat{\pi}^*_i \times \hat{\pi}_{-i},R}_{i,h}$ is decomposed as

\begin{split} V_{i,h}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}-\overline{V}_{i,h}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R} &=-\zeta_{i,h}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}+V_{i,h}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}-r_{i,h}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i}}-P_h^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},\overline{V}_{i,h+1}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}}\overline{V}_{i,h+1}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R} \\ &=-\zeta_{i,h}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}+P_h^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},V_{i,h+1}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}}V_{i,h+1}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}-P_h^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},\overline{V}_{i,h+1}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}}\overline{V}_{i,h+1}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}. \end{split}
$$

$$
\begin{split} &\leq -\zeta_{i,h}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}+P_h^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},\overline{V}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}}\left(V_{i,h+1}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}-\overline{V}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}_{i,h+1}\right)\\ &=-\sum_{h'=h}^H\prod_{j=h}^{h'-1}P_j^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},\overline{V}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}}\zeta_{i,h'}^{\widehat{\pi}^\star_i\times\widehat{\pi}_{-i},R}. \end{split}

The following lemma provides an upper bound for our decomposed terms. Its proof is deferred to Appendix [A.3.](#page-16-0)

$$
 (36)

According to Lemma [2,](#page-12-0) we have

\overline{V}_{i,1}^{\widehat{\pi},R} - V_{i,1}^{\widehat{\pi},R} \lesssim H \sqrt{\frac{\min\{H, \frac{1}{R}\} \log^3 \frac{K S \sum_{i=1}^m A_i}{\delta}}{K}},\tag{37}
$$

$$
V_{i,1}^{\hat{\pi}_i^* \times \hat{\pi}_{-i},R} - \overline{V}_{i,1}^{\hat{\pi}_i^* \times \hat{\pi}_{-i},R} \lesssim H \sqrt{\frac{\min\{H, \frac{1}{R}\} \log^3 \frac{K S \sum_{i=1}^m A_i}{\delta}}{K}}.
$$
 (38)

Step 2. bounding $\widehat{V}_{i,h} - \overline{V}_{i,h}^{\widehat{\pi},R}$. According to the expression of $\widehat{V}_{i,h}$ and $\overline{V}_{i,h}^{\widehat{\pi},R}$ in [\(29\)](#page-10-4) and [\(30\)](#page-10-5), we have

\widehat{V}_{i,h} - \overline{V}_{i,h}^{\widehat{\pi},R} \leq \widehat{P}_{i,h}^{\widehat{\pi},\widehat{V}_{i,h+1}} \widehat{V}_{i,h+1} - \widehat{P}_{i,h}^{\widehat{\pi},\overline{V}_{i,h+1}^{\widehat{\pi},R}} \overline{V}_{i,h+1}^{\widehat{\pi},R} + \beta_{i,h} \n\leq \widehat{P}_{i,h}^{\widehat{\pi},\overline{V}_{i,h+1}^{\widehat{\pi},R}} \left(\widehat{V}_{i,h+1} - \overline{V}_{i,h+1}^{\widehat{\pi},R}\right) + \beta_{i,h} \leq \sum_{h'=h}^{H} \prod_{j=h}^{h'-1} \widehat{P}_{i,j}^{\widehat{\pi},\overline{V}_{i,j+1}^{\widehat{\pi},R}} \beta_{i,h'},
$$
\n(39)

where $\widehat{P}_{i,h}^{\widehat{\pi},V}$ is defined in [\(28\)](#page-10-6).

The following lemma shows how to decompose $\beta_{i,h}$. Its proof is deferred to Appendix [A.4.](#page-20-0)

Lemma 3. Define $V_{i,h+1} = V_{i,h+1} - \min V_{i,h+1}$. For $\beta_{i,h}$ defined in [\(12\)](#page-7-6), we have

$$

$$
+ 14c_b \sqrt{\frac{\min \{H, \frac{1}{R}\} \log^3 \frac{KS \sum_{i=1}^m A_i}{\delta}}{K}}.
$$

By using Lemma [1,](#page-10-7) we have [\(41\)](#page-12-1) holds. Recalling the definition of $\widehat{P}_{i,h}^{\widehat{\pi},V}$, for any $V, V' \in \mathbb{R}^S$, we have $\widehat{P}_{i,h}^{\widehat{\pi},V} V \leq \widehat{P}_{i,h}^{\widehat{\pi},V'} V$. Thus we have

\beta_{i,h} \leq 4 c_{\mathsf{b}} \sqrt{\frac{\log^3 \frac{KS \sum_{i=1}^m A_i}{\delta}}{K \min \left\{H, \frac{1}{R}\right\}}}\left[\left(\widehat{P}_{i,h}^{\widehat{\pi}, \overline{V}_{i,h+1}^{\widehat{\pi},R}}\left(\widetilde{\widehat{V}}_{i,h+1} \circ \widetilde{\widehat{V}}_{i,h+1}\right)-\widetilde{\widehat{V}}_{i,h} \circ \widetilde{\widehat{V}}_{i,h}\right)+\frac{7}{2} \min\left\{H, \frac{1}{R}\right\}\right].

Inserting it into [\(39\)](#page-12-2), we have

Lemma 4. For $\overline{V}_{i,h}^{*,\hat{\pi}_{-i},R}$ defined in [\(17\)](#page-9-5), and K satisfying [\(15\)](#page-8-3), with probability at least $1-\delta$, we have for *all* $i \in [m]$ *and* $1 \leq h \leq H$,

as long as K satisfying (15) , where C is a sufficiently large constant. Thus we complete the proof.

5 Discussion

This paper investigates multi-player robust Markov games in a finite-horizon setting, and achieve minimax sample complexity through establishing matching upper and lower bounds. Specifically, we use an R-contamination set with uncertainty level R as uncertainty set for the transition probabilities. We then propose an algorithm for RMGs based on Q-FTRL, and demonstrate that it achieves an ε -robust CCE with a sample complexity of $H^3 S \sum_{i=1}^m A_i \min\{H, 1/R\} / \varepsilon^2$ (up to log factors), where S denotes the number of states, A_i is the number of actions for the *i*-th player, and H represents the horizon length. In addition, an ε -robust NE is achieved in the special case of two-player zero-sum RMGs with the same sample complexity. Moreover, we establish an information-theoretic lower bound that matches the sample complexity of the proposed algorithm, demonstrating its minimax optimality. Compared to previous results, our result addresses the problems of curse of multiagency and the barrier of long horizon.

Future work will focus on extending this algorithm to handle other types of uncertainty sets, such as those defined by total variation distance or Kullback-Leibler divergence. Additionally, we will investigate the possibility of developing algorithms that can achieve minimax-optimal sample complexity, as demonstrated in this paper, and meanwhile avoid relying on flexible generative models. This could include approaches based on local access models [\(Li et al.](#page-35-19), [2021](#page-35-19); [Yin et al.](#page-37-17), [2022](#page-37-17)) or online sampling protocols [\(Jin et al.](#page-35-20), [2018](#page-35-20); [Azar et al.](#page-34-16), [2017](#page-34-16)).

A Proof of technical lemmas

A.1 Preliminary lemmas

Before diving into the proof details, we first present some technical lemmas that play an important role in the proof of Theorem [1.](#page-8-0)

The following lemma states some properties about step-size α_k , which is proved in Lemma 1 in [Li et al.](#page-35-0) [\(2022\)](#page-35-0).

Lemma 5. Assume that $c_{\alpha} \geq 24$, and $K \geq c_{\alpha} \log K + 1$. For any $k \geq 1$, we have

Assume that [\(31\)](#page-10-8) holds for all $h' \geq h+1$. Now we intend to prove that (31) holds for h. To this end, we make the following observation.

Next we intend to use Freedman's inequality to bound this error term, which is stated as below (c.f. Theorem 5 in [Li et al.](#page-35-0) (2022) .

\rho_0:=c_{\mathsf b}\sqrt{\frac{\log^3\frac{K S\sum_{i=1}^m A_i}{\delta}}{K\min\left\{H,\frac1R\right\}}},\qquad \rho_1=\rho_0\min\left\{H,\frac1R\right\}.

By using these new notations, we could rewrite the definition of $\beta_{i,h}$ as

$$
\n
$$
= \left(\hat{P}_{i,h}^{\hat{\pi},\hat{V}_{i,h+1}} \hat{V}_{i,h+1} \right) \circ \left(\hat{P}_{i,h}^{\hat{\pi},\hat{V}_{i,h+1}} \hat{V}_{i,h+1} \right), \tag{66}
$$

where (i) uses the Jensen's inequality. Inserting (64) and (65) into (66) , we have

= \widehat{P}_{i,h}^{\widehat{\pi},\widehat{V}_{i,h+1}} \left(\widehat{\widetilde{V}}_{i,h+1} \circ \widehat{\widetilde{V}}_{i,h+1} \right) - \left(\widehat{P}_{i,h}^{\widehat{\pi},\widehat{V}_{i,h+1}} \widehat{\widetilde{V}}_{i,h+1} \right) \circ \left(\widehat{P}_{i,h}^{\widehat{\pi},\widehat{V}_{i,h+1}} \widehat{\widetilde{V}}_{i,h+1} \right), \tag{67}

&\leq \hat{P}_{i,h}^{\widehat{\pi},\widehat{V}_{i,h+1}}\left(\tilde{\widehat{V}}_{i,h+1}\circ\tilde{\widehat{V}}_{i,h+1}\right) - \tilde{\widehat{V}}_{i,h}\circ\tilde{\widehat{V}}_{i,h} + 2\widehat{\vartheta}_{i,h}\circ\tilde{\widehat{V}}_{i,h} \\
&\stackrel{(i)}{\leq}(1-R)\hat{P}_{i,h}^{\widehat{\pi}}\left(\tilde{\widehat{V}}_{i,h+1}\circ\tilde{\widehat{V}}_{i,h+1}\right) - \tilde{\widehat{V}}_{i,h}\circ\tilde{\widehat{V}}_{i,h} + 2(1+\beta_{i,h})\circ\tilde{\widehat{V}}_{i,h},\n\end{split}
$$

where (i) uses the definition of $\hat{P}_{i,h}^{\hat{\pi}}$ and [\(68\)](#page-22-0). Inserting it into [\(67\)](#page-21-4), we have

Inserting [\(69\)](#page-22-1) into [\(63\)](#page-21-3), and noticing that $\hat{V}_{i,h} \leq 3 \min\{H, \frac{1}{R}\}\,$, we have

Then we complete the proof of (41) .

A.5 Proof of Lemma [4](#page-13-1)

We shall prove Lemma [4](#page-13-1) by mathematical induction. For $h = H + 1$, it is obviously that $\widehat{V}_{i,H+1} = \overline{V}_{i,H+1}^{\star,\widehat{\pi}_{-i},R}$ 0. Assume that [\(43\)](#page-13-4) holds for $h + 1$, that is, $\widehat{V}_{i,h+1} \ge \overline{V}_{i,h+1}^{*,\widehat{\pi}_{-i},R}$. It suffices to prove that [\(43\)](#page-13-4) holds for h.

According to the definition of $\overline{V}_{i,h}^{*,\widehat{\pi}_{-i},R}$, we have

= \max_{a_i \in \mathcal{A}_i} \sum_{k=1}^K \alpha_k^K q_{i,h,s}^k = \max_{a_i \in \mathcal{A}_i} Q_{i,h,s}^K,
$$
\n(70)

where $Q_{i,h,s}^K = Q_{i,h}^K(s, \cdot) \in \mathbb{R}^{A_i}$, and the last equality uses the fact that $Q_{i,h,s}^K = \sum_{k=1}^K \alpha_k^K q_{i,h,s}^k$ because of $Q_{i,h,s}^0 = 0$ for all i, h, s .

Below we intend to find the upper bound of $Q_{i,h,s}^k$. Towards this, we introduce the following auxiliary lemma (c.f. Theorem 3 in [Li et al.](#page-35-0) (2022) (2022)).

Lemma 8. Suppose that $0 < \alpha_1 \leq 1$ and $\eta_1 = \eta_2(1 - \alpha_1)$. Also assume that $0 < \alpha_k < 1$ and $0 <$ $\eta_{k+1}(1-\alpha_k) \leq \eta_k$ for all $k \geq 2$. Careful readers may find that this lemma is slightly different from Theorem 3 in [Li et al.](#page-35-0) [\(2022](#page-35-0)) by replacing $||q_{i,h,s}^k$ $\Big\|_\infty$ with $\Big\| q_{i,h,s}^k - \min q_{i,h,s}^k$ with $\left\| q_{i,h,s}^k - \min q_{i,h,s}^k \right\|_{\infty}$. This can be easily verified by replacing all ℓ_k with $\ell_k - \min \ell_k$ when bounding $\langle \pi_k - \pi_{k+1}^-, \ell_k \rangle$ in the proof of [Li et al.](#page-35-0) [\(2022\)](#page-35-0). \Box

To verify that the condition in Lemma [8](#page-23-1) holds true, it suffices to prove that

Below we shall bound ξ_1 , ξ_2 , and ξ_3 separately.

$$
\n
$$
\stackrel{(ii)}{\lesssim} \sqrt{\frac{\log^{2} K}{K \min\{H, \frac{1}{R}\}} \sum_{k=1}^{K} \alpha_{k}^{K} \text{Var}_{\pi_{i,h,s}^{k}}(q_{i,h,s}^{k}) + \frac{1}{K^{3}}},

Combining [\(71\)](#page-24-3), [\(73\)](#page-24-4), and [\(77\)](#page-25-3), and notice that $K \gtrsim \min\{H, \frac{1}{R}\}\,$, we have

$$
Q^K_{i,h,s}\leq \sum_{k=1}^K\alpha^K_k \mathbb{E}_{\pi^k_{i,h,s}}q^k_{i,h,s}+c\sqrt{\frac{\log^2K}{K\min\{H, \frac{1}{R}\}}}\sum_{k=1}^K\alpha^K_k \textsf{Var}_{\pi^k_{i,h,s}}(q^k_{i,h,s})+\log A_i\sqrt{\frac{(c_\alpha+1)\min\{H, \frac{1}{R}\}}{K}}\prod_{k=1}^K\alpha^k_{i,h,k}
$$

According to the definition of $\hat{V}_{i,h}$ in [\(13\)](#page-7-5), if $\hat{V}_{i,h} = H - h + 1$, then [\(43\)](#page-13-4) holds obviously. Otherwise, we have

$$
\widehat{V}_{i,h}(s) = \sum_{k=1}^{K} \alpha_k^K \mathbb{E}_{a_i \sim \pi_{i,h,s}^k} q_{i,h,s} + \beta_{i,h}(s)
$$
\n
$$
\geq \max Q_{i,h,s}^K - c \sqrt{\frac{\log^2 K}{K \min\{H, \frac{1}{R}\}}} \sum_{k=1}^{K} \alpha_k^K \mathsf{Var}_{\pi_{i,h,s}^k}(q_{i,h,s}^k)
$$
\n
$$
- \log A_i \sqrt{\frac{(c_{\alpha} + 1) \min\{H, \frac{1}{R}\}}{K}} + \beta_{i,h}(s)
$$
\n
$$
\geq \max Q_{i,h,s}^K \geq \overline{V}_{i,h}^{\star, \widehat{\pi}_{-i}, R},
$$

where (i) holds as long as $c_b \ge c + \sqrt{c_{\alpha}+1}$, and (ii) arises from $\overline{V}_{i,h}^{*,\hat{\pi}_{-i},R} \le \max_{a_i} Q_{i,h,s}^k$ as shown in [\(70\)](#page-23-2). Thus we complete the proof.

B Proof of Corollary [1](#page-8-1)

In a two-player zero-sum RMG, it is evident that $\hat{\pi}_{-1} = \hat{\pi}_2$ and $\hat{\pi}_{-2} = \hat{\pi}_1$, where the subscript 1 and 2 indicates the index of agent. Then the conclusion in Theorem [1](#page-8-0) can be restated as

$$

=
$$
\max \left\{ V_{1,1}^{*,\widehat{\pi}_{2},R}(s) - V_{1,1}^{\widehat{\pi},R}(s), V_{2,1}^{*,\widehat{\pi}_{1},R}(s) - V_{2,1}^{\widehat{\pi},R}(s) \right\} \leq \varepsilon, \quad \forall s \in \mathcal{S}.
$$
 (78)

Noticing that $r_{1,h} = -r_{2,h}$, we have $V_{1,1}^{\pi} = -V_{2,1}^{\pi}$ for any policy π . Thus for any state $s \in \mathcal{S}$, we have

V_{1,1}^{\star,\widehat{\pi}_2,R}(s) - V_{1,1}^{\widehat{\pi}_1 \times \widehat{\pi}_2,R}(s) = V_{1,1}^{\star,\widehat{\pi}_2,R}(s) + V_{2,1}^{\widehat{\pi}_1 \times \widehat{\pi}_2,R}(s) \leq V_{1,1}^{\star,\widehat{\pi}_2,R}(s) + V_{2,1}^{\star,\widehat{\pi}_1,R}(s)
$$

$$
\stackrel{\text{(i)}}{=} V_{1,1}^{\star,\widehat{\pi}_2,R}(s) - V_{1,1}^{\widehat{\pi}_1,R}(s) + V_{2,1}^{\star,\widehat{\pi}_1,R}(s) - V_{2,1}^{\widehat{\pi}_1,R}(s) \stackrel{\text{(ii)}}{\leq} \varepsilon + \varepsilon = 2\varepsilon,
$$

where (i) arises from $V_{1,1}^{\hat{\pi},R}(s) = -V_{2,1}^{\hat{\pi},R}(s)$, and (ii) uses [\(78\)](#page-25-4). Similarly, we can prove that $V_{2,1}^{*,\hat{\pi}_1,R}(s)$ – $V_{2,1}^{\hat{\pi}_1 \times \hat{\pi}_2, R}(s) \leq 2\varepsilon$ for all $s \in \mathcal{S}$. By replacing ε with $\varepsilon/2$, we could prove Corollary [1.](#page-8-1)

C Proof of Theorem [2](#page-9-1)

According to the proof of Theorem 2 in [Shi et al.](#page-36-5) [\(2024c\)](#page-36-5), we could construct a collection of robust Markov games, such that finding a robust NE/CE/CCE of these RMGs degrades to finding the optimal policy of the first agent over a corresponding robust Markov Decision Processes. Thus the proof of Theorem [2](#page-9-1) degrades to prove that: one can construct a collection of robust Markov Decision Processes { $M_{\theta}|\theta \in \Theta$ } with S states, A actions, horizon $H \geq 16$, and the uncertanty level $R \in [0, 1-c_0)$, such that

$$
\inf_{\pi} \max_{\theta \in \Theta} \mathbb{P}_{\theta} \left(\max_{s} \left[V_1^{\star, R}(s) - V_1^{\widehat{\pi}, R}(s) \right] \geq \varepsilon \right) \geq \frac{1}{4},
$$

provided that the sample size for each state-action pair over the nominal transition kernel obeys

$$
N \leq \frac{cH^3}{\varepsilon^2} \min\left\{H,\frac{1}{R}\right\}
$$

for some sufficiently small constant $c > 0$. Here, the infimum is over all policy estimators $\hat{\pi}$, and \mathbb{P}_{θ} denotes the probability when the RMDP is \mathcal{M}_{θ} . Below we shall construct a hard instance.

C.1 Construction of the hard problem instances

Construction of the hard MDPs. To begin with, define the state space and the action space as $S =$ $\{0, 1, \dots, S-1\}$ and $\mathcal{A} = \{0, 1, \dots, A-1\}$, respectively. To construct the nominal transition probability matrix, for any integer $H \ge 16$, let us consider a set $\Theta \subset \{0,1\}^H$ of H-dimensional vectors, which we shall construct shortly. We then generate a collection of MDPs

MDP(

\Theta
$$
) = { \mathcal{M}_{θ} = ($\mathcal{S}, \mathcal{A}, P^{\theta}$ = { P_h^{θ} } $_{h=1}^H$, { r_h } $_{h=1}^H$, H) | θ = [θ_h]1 $\leq h \leq H \in \Theta$ }.

Given any state $s \in \{2, \dots, S-1\}$, the corresponding action space is $\mathcal{A} = \{0, \dots, A-1\}$. While for state $s = 0$, the action space is $\mathcal{A}' = \{0, 1\}$. For any $\theta = \{\theta_h\}_{h=1}^H \in \{0, 1\}^H$, the nominal transition kernel P^{θ} of the constructed robust MDP \mathcal{M}_ϕ is defined as

$$
P_h^{\theta}(s_{h+1}|s_h, a_h) = \begin{cases} p\mathbb{1}(s_{h+1} = 1) + (1-p)\mathbb{1}(s_{h+1} = 0), & \text{if } (s_h, a_h) = (0, \theta_h), \\ q\mathbb{1}(s_{h+1} = 1) + (1-q)\mathbb{1}(s_{h+1} = 0), & \text{if } (s_h, a_h) = (0, 1 - \theta_h), \\ \mathbb{1}(s_{h+1} = 1), & \text{if } s_h \ge 1, \end{cases}
$$

where $0 < q < p < \frac{3}{4}$ are defined as

$$
p = c \max \left\{ \frac{1}{H}, R \right\}, \quad q = p - \Delta,
$$

where

$$
\Delta := \frac{c_1 \varepsilon}{H \min\left\{H, \frac{1}{R}\right\}},\tag{79}
$$

and $c \leq 3/4$. Moreover, we assume that $\varepsilon \leq c_0H$. Here c_1 is a sufficiently large constant, c_0 is a sufficiently small constant, and meanwhile $c_0c_1 \leq c/2$. With this definition, one can easily check that $q \geq p - \frac{c_1c_0}{c} \geq \frac{p}{2}$ for any $\varepsilon \in (0, H]$.

Then, we define the reward function as

$$
r_h(s, a) = \begin{cases} 1, & \text{if } s = 1, \\ 0, & \text{otherwise.} \end{cases}
$$

Finally, let us choose the set $\Theta \subset \{0,1\}^H$. By virtue of the Gilbert-Varshamov lemma [\(Gilbert](#page-34-17), [1952\)](#page-34-17), one can construct $\Theta \subset \{0,1\}^H$ in a way that

|\Theta| \ge e^{H/8}
$$
 and $\left\|\theta - \tilde{\theta}\right\|_1 \ge \frac{H}{8}$ for any $\theta, \tilde{\theta} \in \Theta$ obeying $\theta \ne \tilde{\theta}$. (80)

Uncertainty set of the transition kernels. Recalling the uncertainty set assumed is

$$
\mathcal{U}^R(P_h^{\theta}) = \otimes \mathcal{U}^R(P_h^{\theta}(\cdot|s,a)), \quad \mathcal{U}^R(P_h^{\theta}(\cdot|s,a)) := \left\{ (1-R)P_h^{\theta}(\cdot|s,a) + RP'|P' \in \Delta(\mathcal{S}) \right\}.
$$

For any policy $\pi = {\{\pi_h\}}_{h=1}^H$, its corresponding transition probability matrix is

$$
P_h^{\theta,\pi}(s_{h+1}|s_h) = \begin{cases} z_h^{\pi} \mathbb{1}(s_{h+1} = 1) + (1 - z_h^{\pi}) \mathbb{1}(s_{h+1} = 0), & \text{if } s_h = 0, \\ \mathbb{1}(s_{h+1} = 1), & \text{if } s_h \ge 1, \end{cases}
$$

where

 $z_h^{\pi} = \pi_h(\theta_h|0)p + \pi_h(1 - \theta_h|0)q.$

We pause to show by mathematical induction that for any policy π , we always have

$$
V_h^{\pi,R}(0) = \min_s V_h^{\pi,R}(s), \quad \forall 1 \le h \le H.
$$
\n(81)

It is obvious that $V_{H+1}^{\pi,R}(0) = \min_s V_{H+1}^{\pi,R}(s) = 0$. Suppose that $V_{h+1}^{\pi,R}(0) = \min_s V_{h+1}^{\pi,R}(s)$. Then we have

$$
V_h^{\pi,R}(0) = (1 - R)z_h^{\pi} V_{h+1}^{\pi,R}(1) + (1 - R)(1 - z_h^{\pi}) V_{h+1}^{\pi,R}(0) + RV_{h+1}^{\pi,R}(0)
$$

\n
$$
\leq (1 - R) V_{h+1}^{\pi,R}(1) + RV_{h+1}^{\pi,R}(0)
$$

\n
$$
\leq (1 - R) V_{h+1}^{\pi,R}(1) + RV_{h+1}^{\pi,R}(0) = \min_{s \geq 1} V_h^{\pi,R}(s)
$$

\n
$$
\leq 1 + (1 - R) V_{h+1}^{\pi,R}(1) + RV_{h+1}^{\pi,R}(0) = V_h^{\pi,R}(1).
$$

Thus we complete the proof.

Therefore, for any policy π , the perturbed transition kernel that minimizes the expected reward is

$$
P_h^{\theta,\pi,V_{h+1}^{\pi,R}}(\cdot|s_h) = \arg \min_{P \in \mathcal{U}_h^R(P_h^{\theta,\pi}(\cdot|s_h))} PV_{h+1}^{\pi,R}
$$

=
$$
\begin{cases} (1-R)z_h^{\pi} \mathbb{1}(s_{h+1} = 1) + (1 - (1-R)z_h^{\pi}) \mathbb{1}(s_{h+1} = 0), & \text{if } s_h = 0, \\ (1-R) \mathbb{1}(s_{h+1} = 1) + R \mathbb{1}(s_{h+1} = 0), & \text{if } s_h \ge 1. \end{cases}
$$

Optimal robust policy and value function. To proceed, we are ready to identify the the optimal robust policies, and derive the corresponding robust value functions. According to [\(81\)](#page-27-0), the optimal robust policy $\pi^{\star,\theta} = {\{\pi^{\star,\theta}_h\}}_{h=1}^H$ for \mathcal{M}_{θ} is

$$
\pi_h^{\star,\theta}(\theta_h|0) = 1, \quad \pi_h^{\star,\theta}(1 - \theta_h|0) = 0.
$$
\n(82)

According to robust Bellman equation, the corresponding value function is

$$
V_h^{\star,R}(0) = \frac{\tilde{p}}{R+\tilde{p}} \left(H - h + 1 - \frac{1 - (1 - R - \tilde{p})^{H-h+1}}{R+\tilde{p}} \right)
$$

$$
V_h^{\star,R}(1) = \frac{1}{R+\tilde{p}} \left(\tilde{p}(H-h+1) + R \frac{1 - (1 - R - \tilde{p})^{H-h+1}}{R+\tilde{p}} \right),
$$
 (83)

where

$$
\widetilde{p} = (1 - R)p. \tag{84}
$$

The derivation is deferred to the end of this section. Here we remark that for all θ , RMPDs \mathcal{M}_{θ} share the same optimal value function. Thus we omit the superscript θ in $V_h^{\star,R}$.

C.2 Establishing the minimax lower bound

We are now positioned to establish our sample complexity lower bounds. It suffices to prove that

$$
\inf_{\hat{\pi}} \max_{\theta \in \Theta} \mathbb{P}_{\theta} \left(V_1^{\star, R}(0) - V_1^{\hat{\pi}, R}(0) > \varepsilon \right) \ge \frac{1}{4},\tag{85}
$$

where $\hat{\pi}$ is any policy estimator computed based on the independent samples.

Step 1: converting the goal to estimate θ . For any policy estimator $\hat{\pi} = {\hat{\pi}_h}_{h=1}^H$, We can construct a corresponding estimator $\hat{\theta} = {\hat{\theta}_h}_{h=1}^H$ for θ as

$$
\widehat{\theta} := \arg \min_{\bar{\theta} \in \Theta} \sum_{h=1}^{H} \left\| \widehat{\pi}_h(\cdot | 0) - \pi_h^{\star, \bar{\theta}}(\cdot | 0) \right\|_1, \tag{86}
$$

where $\pi_h^{*,\bar{\theta}}$ is defined in [\(82\)](#page-27-1). According to the construction of Θ in [\(80\)](#page-26-0), a good policy estimator $\hat{\pi}$ implies a correct estimator θ . Mathematically, with samples from \mathcal{M}_{θ} for $\theta \in \Theta$, we have

$$
\mathbb{P}_{\theta}\left(V_1^{\star,R}(0) - V_1^{\widehat{\pi},R}(0) < \varepsilon\right) \le \mathbb{P}_{\theta}\left(\widehat{\theta} = \theta\right),\tag{87}
$$

where \mathbb{P}_{θ} denotes the probability distribution when the MDP is \mathcal{M}_{θ} . The proof of this claim is postponed to the end of this section.

Step 2: probability of error in testing multiple hypotheses. Next, we turn attention to the hypothesis testing problem on Θ. Specifically, we focus on the minimax probability of error defined as follows:

$$
p_e := \inf_{\psi} \max_{\theta \in \Theta} \mathbb{P}_{\theta}(\psi \neq \theta), \tag{88}
$$

where the infimum is taken over all possible tests ψ constructed based on the samples from \mathcal{M}_{θ} .

Let μ_h^{θ} represent the distribution of a sample tuple (s_h, a_h, s_{h+1}) for step h under the nominal transition kernel P_h^{θ} associated with \mathcal{M}_{θ} for $1 \leq h \leq H$. Assume that we collect N independent samples for each state-action pair and each time step H. Combined with Fano's inequality from [Tsybakov](#page-36-18) (2009) (2009) (c.f. Theorem 2.2) and the additivity of the KL divergence (cf. [Tsybakov](#page-36-18) [\(2009\)](#page-36-18), Page 85), we have

$$
p_e \ge 1 - \frac{N \max_{\theta, \tilde{\theta} \in \Theta} \sum_{h=1}^H \mathsf{KL}(\mu_h^{\theta} || \mu_h^{\tilde{\theta}}) + \log 2}{\log |\Theta|}
$$

$$
\ge \frac{1}{2} - \frac{8N \max_{\theta, \tilde{\theta} \in \Theta} \sum_{h=1}^H \mathsf{KL}(\mu_h^{\theta} || \mu_h^{\tilde{\theta}})}{H},
$$
 (89)

where we use the assumption that $H \geq 16 \log 2$ and $|\Theta| \geq e^{H/8}$. Notice that

$$
\begin{split} \mathsf{KL}(\mu_{h}^{\theta}||\mu_{h}^{\tilde{\theta}}) &= \sum_{a=\{0,1\}} \mathsf{KL}\left(P_{h}^{\theta}(\cdot|0,a)||P_{h}^{\tilde{\theta}}(\cdot|0,a)\right) \\ &= \left(p\log\frac{p}{q} + (1-p)\log\frac{1-p}{1-q} + q\log\frac{q}{p} + (1-q)\log\frac{1-q}{1-p}\right) \mathbb{1}(\theta_{h} \neq \tilde{\theta}_{h}) \\ &\leq \left(\frac{p^{2}}{q} - p + \frac{(1-p)^{2}}{1-q} - 1 + p + \frac{q^{2}}{p} - 1 + \frac{(1-q)^{2}}{1-p} - 1 + q\right) \mathbb{1}(\theta_{h} \neq \tilde{\theta}_{h}) \\ &= \left(\frac{(p-q)^{2}}{p(1-p)} + \frac{(p-q)^{2}}{q(1-q)}\right) \mathbb{1}(\theta_{h} \neq \tilde{\theta}_{h}) \\ &\stackrel{(i)}{\leq} \frac{8(p-q)^{2}}{q} \mathbb{1}(\theta_{h} \neq \tilde{\theta}_{h}), \end{split}
$$

where (i) uses the fact that $p(1-p) \geq \frac{p}{4}$ and $q(1-q) \geq \frac{q}{4}$ for $q < p < \frac{3}{4}$. Inserting into [\(89\)](#page-28-0), we have

$$
p_e \ge \frac{1}{2} - \frac{8N \max_{\theta, \tilde{\theta} \in \Theta} \left\| \theta - \tilde{\theta} \right\|_1}{H} \frac{8(p - q)^2}{q}
$$

$$
\ge \frac{1}{2} - \frac{64N(p - q)^2}{q} \stackrel{(ii)}{\ge} \frac{1}{2} - \frac{128Nc_1^2 \varepsilon^2}{cH^2 \min\left\{H, \frac{1}{R}\right\}},
$$

where (i) uses the value of $p - q$ in [\(79\)](#page-26-1), and the fact that $\max_{\theta, \tilde{\theta} \in \Theta} ||\theta - \tilde{\theta}||_1 \leq H$, (ii) uses the fact that $q \geq \frac{p}{2}$. Provided that the total number of samples

$$
NHSA \leq \frac{cH^3SA}{512c_1^2\varepsilon^2}\min\left\{H,\frac{1}{R}\right\},\,
$$

we have

$$
p_e \ge \frac{1}{2} - \frac{1}{4} = \frac{1}{4}.\tag{90}
$$

Step 3: combining the above results. Combining [\(88\)](#page-28-1) and [\(90\)](#page-29-0), we have that for any estimator ψ for θ , the error probability

$$
\max_{\theta \in \Theta} \mathbb{P}_{\theta}(\psi \neq \theta) \ge \frac{1}{4}.
$$

Then for the estimator $\hat{\theta}$ constructed in [\(86\)](#page-28-2), we have

$$
\max_{\theta \in \Theta} \mathbb{P}_{\theta}(\widehat{\theta} \neq \theta) \ge \frac{1}{4}.
$$

According to [\(87\)](#page-28-3), we have for any policy estimator $\hat{\pi}$,

$$
\max_{\theta \in \Theta} \mathbb{P}_{\theta} \left(V_1^{\star, R}(0) - V_1^{\widehat{\pi}, R}(0) \ge \varepsilon \right) \ge \max_{\theta \in \Theta} \mathbb{P}_{\theta} \left(\widehat{\theta} \neq \theta \right) \ge \frac{1}{4}.
$$

Considering that this holds for arbitrary policy estimator $\hat{\pi}$, we could prove that [\(85\)](#page-27-2) holds true, and complete the proof.

Calculation of [\(83\)](#page-27-3). Considering that we only consider about the value of $V_h^{\star,R}(0)$ and $V_h^{\star,R}(1)$, we rewrite vector $V_h^{*,R} = [V_h^{*,R}(0), V_h^{*,R}(1)]^\top$ for convenience. According to robust Bellman's equation, we have

$$
V_h^{\star,R} = \begin{bmatrix} 0 \\ 1 \end{bmatrix} + \begin{bmatrix} 1 - \widetilde{p} & \widetilde{p} \\ R & 1 - R \end{bmatrix} V_{h+1}^{\star,R} =: r + P^{\star,R} V_{h+1}^{\star,R},\tag{91}
$$

with $V_{H+1}^{\star,R}=0$, where we redefine

$$
P^{\star,R} = P_h^{\star,V_{h+1}^{\star,R}}, \quad r = r_h.
$$

By eigenvalue decomposition, $P^{\star,R}$ can be decomposed as

$$
\begin{bmatrix}\n1-\tilde{p} & \tilde{p} \\
R & 1-R\n\end{bmatrix} =\n\begin{bmatrix}\n1 & \tilde{p} \\
1 & -R\n\end{bmatrix}\n\begin{bmatrix}\n1 & 0 \\
0 & 1-R-\tilde{p}\n\end{bmatrix}\n\begin{bmatrix}\n1 & \tilde{p} \\
1 & -R\n\end{bmatrix}^{-1}\n= \frac{1}{R+\tilde{p}}\n\begin{bmatrix}\n1 & \tilde{p} \\
1 & -R\n\end{bmatrix}\n\begin{bmatrix}\n1 & 0 \\
0 & 1-R-\tilde{p}\n\end{bmatrix}\n\begin{bmatrix}\nR & \tilde{p} \\
1 & -1\n\end{bmatrix}.
$$
\n(92)

Thus we have

$$
V_h^{\star,R} = \sum_{h'=h}^{H} (P^{\star,R})^{h'-h} r = \frac{1}{R+\widetilde{p}} \begin{bmatrix} 1 & \widetilde{p} \\ 1 & -R \end{bmatrix} \begin{bmatrix} \sum_{h'=h}^{H} 1 & 0 \\ 0 & \sum_{h'=h}^{H} (1-R-\widetilde{p})^{h'-h} \end{bmatrix} \begin{bmatrix} R & \widetilde{p} \\ 1 & -1 \end{bmatrix} r
$$

=
$$
\frac{1}{R+\widetilde{p}} \begin{bmatrix} \widetilde{p} \left(H-h+1-\frac{1-(1-R-\widetilde{p})^{H-h+1}}{R+\widetilde{p}} \right) \\ \widetilde{p}(H-h+1) + R\frac{1-(1-R-\widetilde{p})^{H-h+1}}{R+\widetilde{p}} \end{bmatrix}.
$$

Proof of [\(87\)](#page-28-3). It suffices to prove that for policy estimation $\hat{\pi}$ obtained from samples of \mathcal{M}_{θ} , if $V_1^{\star,R}(0)$ – $V_1^{\hat{\pi},R}(0) \leq \varepsilon$, then we have $\hat{\theta} = \theta$, where $\hat{\theta}$ is defined by [\(86\)](#page-28-2).

Towards this, we assume that $\theta \neq \theta$. Then according to the definition of Θ in [\(80\)](#page-26-0), and recalling $\theta \in \Theta$, we have $\left\|\theta - \widehat{\theta}\right\|_1 \geq H/8$, and

$$
\sum_{h=1}^{H} \left\| \hat{\pi}_{h}(\cdot|0) - \pi_{h}^{\star,\theta}(\cdot|0) \right\|_{1} \ge \sum_{h=1}^{H} \left\| \pi_{h}^{\star,\theta}(\cdot|0) - \pi_{h}^{\star,\widehat{\theta}}(\cdot|0) \right\|_{1} - \sum_{h=1}^{H} \left\| \hat{\pi}_{h}(\cdot|0) - \pi_{h}^{\star,\widehat{\theta}}(\cdot|0) \right\|_{1}
$$

$$
= 2 \left\| \theta - \widehat{\theta} \right\|_{1} - \sum_{h=1}^{H} \left\| \hat{\pi}_{h}(\cdot|0) - \pi_{h}^{\star,\widehat{\theta}}(\cdot|0) \right\|_{1}
$$

$$
\ge \frac{H}{4} - \sum_{h=1}^{H} \left\| \hat{\pi}_{h}(\cdot|0) - \pi_{h}^{\star,\widehat{\theta}}(\cdot|0) \right\|_{1}.
$$
(93)

To proceed, we claim that $V_1^{\star,R}(0) - V_1^{\hat{\pi},R}(0) < \varepsilon$ implies

$$
\sum_{h=1}^{H} \left\| \widehat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0) \right\|_1 < \frac{H}{8}.\tag{94}
$$

Then according to [\(93\)](#page-30-0), we have

$$
\sum_{h=1}^{H} \left\| \widehat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0) \right\|_1 > \frac{H}{4} - \frac{H}{8} = \frac{H}{8},
$$

which contradicts [\(94\)](#page-30-1). Thus we prove that $\hat{\theta} = \theta$.

Now it suffices to prove that the claim [\(94\)](#page-30-1) holds true. Specifically, we intend to prove that if

$$
\sum_{h=1}^H \left\| \widehat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0) \right\|_1 \ge \frac{H}{8},
$$

then one has

$$
V_1^{\star,R}(0) - V_1^{\widehat{\pi},R}(0) \ge \varepsilon.
$$

Towards this, for any policy $\hat{\pi}$, notice that $V_1^{\hat{\pi},R} = [V_1^{\hat{\pi},R}(0), V_1^{\hat{\pi},R}(1)]^{\top}$ is computed as

$$
V_1^{\hat{\pi},R} = \sum_{h=1}^{H} \prod_{j=1}^{h-1} A_j^{\hat{\pi}} r,
$$

where $A_j^{\hat{\pi}}$ is defined as

$$
A_j^{\widehat{\pi}} = \begin{bmatrix} 1 - \tilde{z}_j^{\widehat{\pi}} & \tilde{z}_j^{\widehat{\pi}} \\ R & 1 - R \end{bmatrix}, \quad r = \begin{bmatrix} 0 \\ 1 \end{bmatrix}
$$

with

$$
\tilde{z}_j^{\hat{\pi}} = (1 - R) \left(\hat{\pi}_j(\theta_j|0)p + \hat{\pi}_j(1 - \theta_j|0)q \right). \tag{95}
$$

It is obvious that $(1-R)q \leq \tilde{z}_j^{\hat{\pi}} \leq (1-R)p$. Recall that the optimal value function $V_1^{\star,R} = [V_1^{\star,R}(0), V_1^{\star,R}(1)]^{\top}$ is calculated as $(cf. (91))$ $(cf. (91))$ $(cf. (91))$

$$
V_1^{\star, R} = \sum_{h=1}^{H} \prod_{j=1}^{h-1} A_j^{\star} r,
$$

where

$$
A_j^\star = \left[\begin{array}{cc} 1-\widetilde{p} & \widetilde{p} \\ R & 1-R \end{array} \right],
$$

and \tilde{p} is defined in [\(84\)](#page-27-4). To decompose the difference between $V_1^{*,R}$ and $V_1^{\hat{\pi},R}$, we introduce a sequence of vectors V_0, V_1, \cdots, V_H defined as

$$
\widetilde{V}_h = \sum_{h'=1}^{h+1} \prod_{j=1}^{h'-1} A_j^* r + \sum_{h'=h+2}^H \prod_{j=1}^h A_j^* \prod_{j=h+1}^{h'-1} A_j^{\widehat{\pi}} r,
$$

We remark that \widetilde{V}_h is actually the value function at step 1 for the policy $\widetilde{\pi} = {\{\widetilde{\pi}_h\}}_{h=1}^H$ satisfying $\widetilde{\pi}_j = {\pi_j^{\star,\theta}}$ for $j \leq h$ and $\widetilde{\pi}_j = \widehat{\pi}_j$ for $j > h$. Moreover, we have $\widetilde{V}_H = V_1^{\star,R}$ and $\widetilde{V}_0 = V_1^{\widehat{\pi},R}$. Now we can decompose the difference between $V_1^{\star,R}$ and $V_1^{\hat{\pi},R}$ as

$$
V_1^{\star,R} - V_1^{\hat{\pi},R} = \sum_{h=1}^H \left(\widetilde{V}_h - \widetilde{V}_{h-1}\right).
$$
\n(96)

For the h -th term, we have

$$
\widetilde{V}_{h} - \widetilde{V}_{h-1} = \sum_{h'=1}^{h+1} \prod_{j=1}^{h'-1} A_{j}^{*} r + \sum_{h'=h+2}^{H} \prod_{j=1}^{h} A_{j}^{*} \prod_{j=h+1}^{h'-1} A_{j}^{\widehat{\pi}} r - \sum_{h'=1}^{h} \prod_{j=1}^{h'-1} A_{j}^{*} r - \sum_{h'=h+1}^{H} \prod_{j=1}^{h-1} A_{j}^{*} \prod_{j=h}^{h'-1} A_{j}^{\widehat{\pi}} r
$$
\n
$$
= \prod_{j=1}^{h-1} A_{j}^{*} \left(A_{h}^{*} - A_{h}^{\widehat{\pi}} \right) \left(\sum_{h'=h+1}^{H} \prod_{j=h+1}^{h'-1} A_{j}^{\widehat{\pi}} r \right),
$$

where $\prod_{j=h+1}^{h} A_j^{\hat{\pi}} r$ is defined as r. We claim that

$$
\widetilde{V}_{h} - \widetilde{V}_{h-1} \ge \prod_{j=1}^{h-1} A_{j}^{\star} \left(A_{h}^{\star} - A_{h}^{\widehat{\pi}} \right) \left(\sum_{h'=h+1}^{H} \prod_{j=h+1}^{h'-1} A_{j}^{\star} r \right)
$$
\n
$$
\stackrel{(i)}{=} \left(A^{\star} \right)^{h-1} \left(A_{h}^{\star} - A_{h}^{\widehat{\pi}} \right) \sum_{h'=0}^{H-h-1} \left(A^{\star} \right)^{h'} r,
$$
\n(97)

where in (i) we rewrite A_j^* as A^* since it does not vary with j. The proof of [\(97\)](#page-31-0) is postponed to the end of this section. According to the decomposition in (92) , we have

$$
\sum_{h'=0}^{H-h-1} (A^{\star})^{h'} r = \frac{1}{R+\widetilde{p}} \left[\begin{array}{c} \widetilde{p} \left(H-h - \frac{1-(1-R-\widetilde{p})^{H-h}}{R+\widetilde{p}} \right) \\ \widetilde{p}(H-h) + R \frac{1-(1-R-\widetilde{p})^{H-h}}{R+\widetilde{p}} \end{array} \right],
$$

$$
(A^{\star})^{h-1} = \frac{1}{R+\widetilde{p}} \left[\begin{array}{cc} 1 & \widetilde{p} \\ 1 & -R \end{array} \right] \left[\begin{array}{cc} 1 & 0 \\ 0 & (1-R-\widetilde{p})^{h-1} \end{array} \right] \left[\begin{array}{cc} R & \widetilde{p} \\ 1 & -1 \end{array} \right].
$$

by inserting them, we have

$$
\widetilde{V}_h(0) - \widetilde{V}_{h-1}(0) = \frac{\widetilde{p} - \widetilde{z}_h^{\widehat{\pi}}}{(R + \widetilde{p})^2} \left(R + \widetilde{p}(1 - R - \widetilde{p})^{h-1} \right) \left(1 - (1 - R - \widetilde{p})^{H-h} \right)
$$
\n
$$
\stackrel{(i)}{=} \frac{(1 - R)(p - q)}{2(R + \widetilde{p})^2} \left(R + \widetilde{p}(1 - R - \widetilde{p})^{h-1} \right) \left(1 - (1 - R - \widetilde{p})^{H-h} \right) \left\| \widehat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0) \right\|_1
$$
\n
$$
\geq 0,
$$
\n(98)

where (i) uses the definition of \tilde{p} and $\tilde{z}_h^{\tilde{\pi}}$ in [\(84\)](#page-27-4) and [\(95\)](#page-30-2). Below we consider the case of $h \leq 31H/32$, which gives

$$
(1 - R - \widetilde{p})^{H-h} \le (1 - R - \widetilde{p})^{\frac{H}{32}} \le (1 - p)^{\frac{H}{32}} \le 1 - \frac{c}{32},
$$

where (i) holds because $p \ge \frac{c}{H} \ge 1 - (1 - \frac{c}{32})^{\frac{32}{H}}$ for $c \le 3/4$. Thus we have

$$
\widetilde{V}_h(0) - \widetilde{V}_{h-1}(0) \ge \frac{c(1-R)(p-q)}{64(R+\widetilde{p})^2} \left(R + \widetilde{p}(1-R-\widetilde{p})^{h-1} \right) \left\| \widehat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0) \right\|_1.
$$
\n(99)

We shall proceed with a case-by-case analysis as below.

• Consider the case $R + \widetilde{p} \ge \frac{7}{8(h-1)}$. Notice that if $R \le \frac{1}{H}$, then we have

$$
R + \widetilde{p} = R + c(1 - R) \max\left\{\frac{1}{H}, R\right\} = R + \frac{c(1 - R)}{H} \stackrel{(i)}{\leq} R + \frac{3}{4H}
$$

where (i) uses the fact that $c \leq 3/4$. This can be rewritten as

$$
R \ge R + \tilde{p} - \frac{3}{4H} \ge \frac{7}{8H} - \frac{3}{4H} = \frac{1}{8H}.
$$
\n(100)

,

While if $R > \frac{1}{H}$, then $R \ge \frac{1}{8H}$ obviously. Inserting into the definition of p, we have

$$
p = c \max\left\{\frac{1}{H}, R\right\} \le c \max\left\{8R, R\right\} = 8cR.
$$

This upper bound on p implies an upper bound on the following term.

$$
\frac{(1-R)(p-q)}{(R+\tilde{p})^2} \left(R+\tilde{p}(1-R-\tilde{p})^{h-1}\right)
$$
\n
$$
\geq \frac{(1-R)(p-q)R}{(R+\tilde{p})^2} \geq \frac{(1-R)(p-q)R}{(R+8c(1-R)R)^2}
$$
\n
$$
= \frac{(1-R)(p-q)}{(1+8c(1-R))^2R} \geq \frac{(1-R)(p-q)}{49R} \geq \frac{(1-R)(p-q)}{49 \max\{\frac{1}{H}, R\}}.
$$

• Consider the case $R + \widetilde{p} < \frac{7}{8(h-1)}$. In this case, we have

$$
(1 - R - \widetilde{p})^{h-1} \ge 1 - (R + \widetilde{p})(h - 1) \ge 1 - \frac{7}{8} = \frac{1}{8}.
$$

We further have

$$
\frac{(1-R)(p-q)}{(R+\tilde{p})^2} \left(R + \tilde{p} (1 - R - \tilde{p})^{h-1} \right) \n\geq \frac{(1-R)(p-q)}{(R+\tilde{p})^2} \left(R + \frac{\tilde{p}}{8} \right) \geq \frac{(1-R)(p-q)(R+\tilde{p})}{8(R+\tilde{p})^2} \n= \frac{(1-R)(p-q)}{8(R+\tilde{p})} \geq \frac{(1-R)(p-q)}{8(1+c) \max\{\frac{1}{H}, R\}} \geq \frac{(1-R)(p-q)}{14 \max\{\frac{1}{H}, R\}}.
$$

Summarizing the two cases above, we obtain the following inequality:

$$
\frac{(1-R)(p-q)}{(R+\widetilde{p})^2} \left(R + \widetilde{p} (1 - R - \widetilde{p})^{h-1} \right) \ge \frac{(1-R)(p-q)}{50} \min \left\{ H, \frac{1}{R} \right\}.
$$

Inserting into [\(99\)](#page-32-0), we have

$$
\widetilde{V}_h(0) - \widetilde{V}_{h-1}(0) \ge \frac{c(1-R)(p-q)}{3200} \min\left\{H, \frac{1}{R}\right\} \left\|\widehat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0)\right\|_1, \quad h \le \frac{31H}{32}.
$$

Combining with [\(96\)](#page-31-1), we have

$$
V_1^{\star,R}(0) - V_1^{\hat{\pi},R}(0) \stackrel{(i)}{\geq} \sum_{h=1}^{\frac{31H}{32}} \left(\widetilde{V}_h - \widetilde{V}_{h-1} \right) \geq \frac{c(1-R)(p-q)}{3200} \min \left\{ H, \frac{1}{R} \right\} \sum_{h=1}^{\frac{31H}{32}} \left\| \widehat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0) \right\|_1
$$

$$
\stackrel{(ii)}{\geq} \frac{c(1-R)(p-q)H}{51200} \min \left\{ H, \frac{1}{R} \right\} \stackrel{(ii)}{\geq} \varepsilon.
$$
 (101)

where (i) holds because $\widetilde{V}_h - \widetilde{V}_{h-1} \geq 0$ for any h (c.f. [\(98\)](#page-31-2)), (ii) holds because $\sum_{h=1}^{\frac{31H}{32}}$ $\left\| \widehat{\pi}_h(\cdot|0) - \pi^{\star,\theta}_h(\cdot|0) \right\|_1 \geq$ $\left\|\hat{\pi}_h(\cdot|0) - \pi_h^{\star,\theta}(\cdot|0)\right\|_1 - \frac{H}{16} \ge \frac{H}{16}$, and (iii) holds as long as $c_1 \ge \frac{51200}{c(1-c_R)}$.

Proof of (97) **.** It suffices to prove that

$$
\prod_{j=1}^{h-1} A_j^{\star} \left(A_h^{\star} - A_h^{\widehat{\pi}} \right) \left(\sum_{h'=h+1}^H \prod_{j=h+1}^{h'-1} A_j^{\widehat{\pi}} r \right) \geq \prod_{j=1}^{h-1} A_j^{\star} \left(A_h^{\star} - A_h^{\widehat{\pi}} \right) \left(\sum_{h'=h+1}^H \prod_{j=h+1}^{h'-1} A_j^{\star} r \right).
$$

We remind that all entries in matrix A_j^* is positive. Thus it suffices to prove that

$$
\left(A_h^* - A_h^{\widehat{\pi}}\right) \left(\sum_{h'=h+1}^H \prod_{j=h+1}^{h'-1} A_j^{\widehat{\pi}} r\right) \ge \left(A_h^* - A_h^{\widehat{\pi}}\right) \left(\sum_{h'=h+1}^H \prod_{j=h+1}^{h'-1} A_j^* r\right). \tag{102}
$$

To proceed, we remind that

$$
A_h^* - A_h^{\hat{\pi}} = (\tilde{p} - \tilde{z}_h^{\hat{\pi}}) \begin{bmatrix} -1 & 1\\ 0 & 0 \end{bmatrix}.
$$
 (103)

For convenience, we introduce two new notations:

$$
x_k = \sum_{h'=k}^{H} \prod_{j=k}^{h'-1} A_j^* r, \quad \widehat{x}_k = \sum_{h'=k}^{H} \prod_{j=k}^{h'-1} A_j^{\widehat{\pi}} r, \quad h+1 \le k \le H.
$$

One can easily check that x_k and \hat{x}_k satisfy the following recursive formula:

$$
x_k = r + A_k^* x_{k+1}, \quad \widehat{x}_k = r + A_k^{\widehat{\pi}} \widehat{x}_{k+1}, \quad x_H = r, \quad \widehat{x}_H = r.
$$
 (104)

Combining with [\(103\)](#page-33-0), proving [\(102\)](#page-33-1) is equivalent to showing that

$$
\widehat{x}_k(1) - \widehat{x}_k(0) \ge x_k(1) - x_k(0) \ge 0, \quad \forall h + 1 \le k \le H.
$$
\n(105)

We shall establish this by mathematical induction. Notice that (105) holds for $k = H$ due to (104) . Assume that $\hat{x}_{k+1}(1) - \hat{x}_{k+1}(0) \ge x_{k+1}(1) - x_{k+1}(0)$. According to [\(104\)](#page-33-3), we have

$$
\hat{x}_k(1) - \hat{x}_k(0) = 1 + R\hat{x}_{k+1}(0) + (1 - R)\hat{x}_{k+1}(1) - (1 - \tilde{z}_k^{\pi})\hat{x}_{k+1}(0) - \tilde{z}_k^{\pi}\hat{x}_{k+1}(1)
$$

= 1 + (1 - R - \tilde{z}_k^{\pi})(\hat{x}_{k+1}(1) - \hat{x}_{k+1}(0))
\ge 1 + (1 - R - \tilde{p})(x_{k+1}(1) - x_{k+1}(0)).

Moreover, by using (105) , we have

$$
x_k(1) - x_k(0) = 1 + Rx_{k+1}(0) + (1 - R)x_{k+1}(1) - (1 - \tilde{p})x_{k+1}(0) - \tilde{p}x_{k+1}(1)
$$

= 1 + (1 - R - \tilde{p})(x_{k+1}(1) - x_{k+1}(0)) \ge 0.

In comparison, it is obvious that $\hat{x}_k(1) - \hat{x}_k(0) \ge x_k(1) - x_k(0)$. Thus we complete the proof.
