CHARACTERIZATIONS OF KNOT GROUPS AND KNOT SYMMETRIC QUANDLES OF SURFACE-LINKS

JUMPEI YASUDA

Abstract. The Artin-Alexander theorem characterizes the knot groups of classical links, providing necessary and sufficient conditions for a group to be the knot group of some classical link. This result was shown using the closed braid method. González-Acuña and Kamada independently extended this characterization to the knot groups of orientable surface-links. Kamada applied the closed 2-dimensional braid method to show this result.

In this paper, we generalize these results to characterize the knot groups of surface-links, including non-orientable ones. Our approach relies on a plat form presentation for surface-links. Furthermore, we show a similar characterization for the knot symmetric quandles of surface-links. As an application, we show that every dihedral quandle with an arbitrarily good involution can be realized as the knot symmetric quandle of a surface-link.

1. Introduction

The *knot group* is the fundamental group of the complement of a knot or a link. In knot theory, the knot group plays a crucial role in the classification and study of invariants for knots and links. This naturally leads to the following question: for a given group *G*, when is *G* the knot group of some link? The answer to this question is provided by Alexander-Artin Theorem:

Theorem 1.1 ([\[1\]](#page-10-0)). *A group G is the knot group of a link if and only if there exists an m-braid b such that G has a presentation*

$$
\langle x_1,\ldots,x_m\big| x_i=b\cdot x_i \quad (i=1,\ldots,m)\rangle.
$$

Here, $b \cdot x$ denotes the action on the free group F_m by the braid group B_m , which will be defined in Section [2.2.](#page-2-0) This theorem was shown by using the fact that every link is equivalent to the closure of some braid.

A *surface-knot* is a closed connected surface smoothly embedded in the 4-space, and a *surface-link* is a disjoint union of surface-knots. González-Acuña [\[5\]](#page-10-1) and Kamada [\[8\]](#page-11-0) independently proved a characterization of the knot groups of orientable surface-links. We recall the result due to Kamada as follows: A group presentation is called an (m, n) -presentation (associated with m-braids b_1, \ldots, b_n) if it is

$$
\langle x_1,\ldots,x_m| b_i\cdot x_1=b_i\cdot x_2 \quad (i=1,\ldots,n)\rangle.
$$

We say that an (m, n) -presentation satisfies the ∂ -condition if there exist *n* signs $\varepsilon_1, \ldots, \varepsilon_n \in \{\pm 1\}$ such that

$$
\prod_{i=1}^n b_i^{-1} \sigma_1^{\varepsilon_i} b_i = 1_m,
$$

where σ_i is Artin's generator of B_m and 1_m is the unit element of B_m .

Theorem 1.2 ([\[8\]](#page-11-0)). *A group G is the knot group of a c-component (total) genus g oriententable surface-link if and only if G satisfies the following conditions for some* $m, n \geq 0$ *:*

- (1) *G has an* (*m*, *ⁿ*)*-presentation satisfying the* ∂*-condition.*
- (2) *It holds that* $2c 2g = 2m n$.
- (3) $G/[G,G]$ *is isomorphic to* \mathbb{Z}^c *.*

In this paper, we give an analogue result for arbitrarily (unoriented) surface-links including non-orientable ones. A group presentation is called a $(2m, n)$ -presentation *with inverses* (associated with b_1, \ldots, b_n) if it is

$$
\langle x_1,\ldots,x_{2m} | b_i \cdot x_1 = b_i \cdot x_2, x_{2j-1} = x_{2j}^{-1} \quad (i = 1,\ldots,n, j = 1,\ldots,m) \rangle
$$

which is obtained from a $(2m, n)$ -presentation by adding new *m* relations $x_{2j-1} = x_{2j}^{-1}$ $(j = 1, ..., m)$. We say that an $(2m, n)$ -presentation satisfies the *weak* ∂ -*condition* if there exist *n* signs $\varepsilon_1, \ldots, \varepsilon_n \in \{1, -1\}$ such that

$$
\prod_{i=1}^n b_i^{-1} \sigma_1^{\varepsilon_i} b_i \in K_{2m},
$$

where K_{2m} is Hilden's subgroup of B_{2m} defined in Section [2.3.](#page-3-0) A surface-link *F* is called (c, d) *-component* if *F* consists of *^c* orientable surface-knots and *^d* non-orientable ones. The (non-orientable) genus of (*c*, *^d*)-component surface-link *F* means the integer *g* satisfying $\chi(F) = 2(c + d) - g$, where $\chi(F)$ is the Euler characteristic of *F*.

Theorem 1.3. *A group G is the knot group of a* (*c*, *^d*)*-component genus g surface-link if and only if G satisfies the following conditions for some m,* $n \geq 0$ *:*

- (1) *G has an* (2*m*, *ⁿ*)*-presentation with inverses satisfying the weak* ∂*-condition.*
- (2) *It holds that* $2(c + d) g = 2m n$.
- (3) $G/[G,G]$ *is isomorphic to* $\mathbb{Z}^c \oplus (\mathbb{Z}/2)^d$ *.*

We will show this theorem using the fact that every surface-link is equivalent to the plat closure of some braided surface, which is discussed in Section [2.3.](#page-3-0)

In Section [3,](#page-4-0) we extend Theorem [1.3](#page-1-0) to the knot symmetric quandles of surface-links. A *quandle* [\[7,](#page-10-2) [15\]](#page-11-1) is a set *Q* with a binary operation ∗ : $Q \times Q \rightarrow Q$ satisfying the following conditions:

- (1) For any $a \in Q$, we have $a * a = a$.
- (2) For any $a, b \in Q$, there exists a unique element $c \in Q$ such that $a * c = b$.
- (3) For any $a, b, c \in Q$, we have $(a * b) * c = (a * c) * (b * c)$.

Quandles are usefull tools in the study of oriented links and oriented surface-links. Specifically, the knot quandle is defined for oriented links and oriented surface-links (Section [3.1\)](#page-4-1). It has been shown that the knot quandle is a stronger invariant than the knot group for distinguishing surface-links ([\[18\]](#page-11-2)).

To apply quandle theory to unoriented surface-links, Kamada [\[10\]](#page-11-3) introduced symmetric quandles, which is a pair of a quandle *^Q* and a good involution ρ of *^Q*. The knot symmetric quandle is defined for an unoriented surface-links, with details provided in Section [3.2.](#page-6-0) We present an algebraic characterization of the knot symmetric quandles of surface-links:

Theorem 1.4. *A symmetric quandle* (*Q*, ρ) *is the knot symmetric quandle of a* (*c*, *^d*)*-component (non-orientable) genus g surface-link if and only if* (Q, ρ) *satisfies the following conditions for some m, n* ≥ 0 *:*

- (1) (*Q*, ρ) *has an* (2*m*, *ⁿ*)*-presentation with inverses satisfying the weak* ∂*-condition.*
- (2) *It holds that* $2(c + d) g = 2m n$.
- (3) Q consists of 2c + d connected components $X_1, \ldots, X_c, Y_1, \ldots, Y_c$ and Z_1, \ldots, Z_d such that $\rho(X_i) = Y_i$ *and* $\rho(Z_j) = Z_j$ *for each* $i \in \{1, ..., c\}$ *and* $j \in \{1, ..., d\}$ *.*

The dihedral quandle R_n is one of the most basic examples of quandles. In Section [4,](#page-8-0) we provide presentations of *Rⁿ* as symmetric quandles. Applying Theorem [1.4,](#page-1-1) we show the following result:

Theorem 1.5. *For any n* ≥ 1 *and any good involution* ρ *of R_n*, *there exists a surface-link whose knot symmetric guandle is* (R_n, ρ) *.*

In Section [5,](#page-10-3) we discuss the relationship between symmetric quandles and P^2 -irreducibility of surface-links. In particular, we construct an infinite family of 2-component P^2 -irreducible P^2 -links (Theorem [5.3\)](#page-10-4).

2. Braids and Braided surfaces

2.1. **Braids and Braided surfaces.** Let $m \ge 1$ be an integer, D^2 a 2-disk, and $p_2 : D^2 \times I \to I$ the projection of $D^2 \times I$. We fix an *m*-point subset $X_m = \{x_1, \ldots, x_m\}$ of D^2 such that x_1, \ldots, x_m lie on a line of D^2 in this order.
An *m*-braid is a curve B in $D^2 \times I$ such that An *m-braid* is a curve β in $D^2 \times I$ such that

- (1) the restriction map $p_2|_\beta : \beta \to I$ is covering map of degree *m* and
- (2) $\partial \beta = X_m \times \{0, 1\}.$

Two *m*-braids are said to be *equivalent* if they are isotopic in $D^2 \times I$ rel ∂ . The braid group B_m of degree *m* is the fundamental group of the configuration space C , of *m*-point subsets of $Int(D^2)$ with based the fundamental group of the configuration space C_m of *m*-point subsets of $Int(D^2)$ with based point X_m . Then elements of *B^m* are naturally identified with equivalence classes of *m*-braid.

Let B^2 be the unit disk on \mathbb{C} and $pr_2 : D^2 \times B^2 \to B^2$ the projection of $D^2 \times B^2$. We take a point $y_0 \in \partial B^2$ as a seed point of $B^2 \to A$ *braided surface* [17] of degree *m* is a compact surface S properly em a based point of B^2 . A *braided surface* [\[17\]](#page-11-4) of degree *m* is a compact surface *S* properly embedded in $D^2 \times B^2$ such that

- (1) the restriction map $\pi_S := \text{pr}_2|_S : S \to B^2$ is a branched covering map of degree *m* and (2) $S \cap D^2 \times \text{F}_2 = X \times \text{F}_2$
- (2) *S* ∩ *D*² × {*y*₀} = *X_m* × {*y*₀}.

A 2-dimensional braid [\[19\]](#page-11-5) of degree *m* is a braided surface *S* of degree *m* with $\partial S = X_m \times \partial B^2$. In this paper, every braided surface is assumed to be *simple*, meaning that for every $y \in B^2$, the preimage $\pi^{-1}(y)$ every braided surface is assumed to be *simple*, meaning that for every $y \in B^2$, the preimage $\pi_S^{-1}(y)$ consists of *m* or $m-1$ points. Two braided surfaces *S* and *S'* are said to be *equivalent* if there exists or *m* − 1 points. Two braided surfaces *S* and *S* ′ are said to be *equivalent* if there exists

• an isotopy $\{\Phi_t\}_{t\in[0,1]}$ of $D^2 \times B^2$ carrying *S* to *S'*, and

• an isotopy
$$

such that the following conditions hold for $t \in [0, 1]$:

- (1) $\phi_t \circ pr_2 = pr_2 \circ h_t$, and
(2) $\Phi_t \circ \Phi_t = id$
- (2) $\Phi_t|_{D^2 \times \{y_0\}} = \text{id}.$

Kamada [\[9\]](#page-11-6) showed that *S* and *S'* are equivalent if and only if there exists an isotopy $\{\Phi_t\}_{t\in[0,1]}$ of $D^2 \times B^2$ carrying *S* to *S*' such that $\Phi_t(S)$ is a simple braided surface for $t \in [0, 1]$.

2.2. **Braid systems of braided surfaces.** Let $pr_1: D^2 \times B^2 \to D^2$ be the projection and *S* a braided surface of degree *m*. The branch locus of $\pi_S : S \to B^2$ is denoted by $\Sigma(S) = \{x_1, \ldots, x_n\}$, where $n \ge 0$.
The *braid monodromy* of *S* is the homomorphism $\alpha_S : \pi_1(D^2 \setminus \Sigma(S) \setminus \mathcal{S}) \to \pi_1(C \setminus X)$

For each α_i , let γ_i be a loop $\overline{\alpha_i}^{-1} \cdot \partial N_i \cdot \overline{\alpha_i}$ in $D_2 \setminus \Sigma(S)$ with base point y_0 , where ∂N_i is oriented counter-clockwise. The *n*-tuple (γ_i, γ_j) is called a *Hurwitz loop system* in counter-clockwise. The *n*-tuple $(\gamma_1, \dots, \gamma_n)$ is called a *Hurwitz loop system* in B^2 with the base point y_0 , and $\pi_1(D_2)$ $\Sigma(S)$ y_0 is the free group generated by $[\gamma_1]$ $[\gamma_2]$ $\pi_1(D_2 \setminus \Sigma(S), y_0)$ is the free group generated by $[\gamma_1], [\gamma_2], \ldots, [\gamma_n]$.

Definition 2.1. Let γ_i as above. A *braid system* of *S* is an *n*-tuple $(\beta_1, \ldots, \beta_n)$ with $\beta_i = \rho_S(\gamma_i)$.

The choice of a braid system depends on the Hurwitz arc system. Rudolph [\[17\]](#page-11-4) showed that an *n*-tuple $(\beta_1, \ldots, \beta_n)$ of *m*-braids is a braid system of some *S* if and only if β_i is a conjugate of σ_1 or σ_1^{-1} . We notice that for $i \in \{1, \ldots, n-1\}$ and $s \in \{1+1\}$, a conjugate of σ_1^{ε} is a conjugate of for $i \in \{1, ..., n-1\}$ and $\varepsilon \in \{\pm 1\}$, a conjugate of σ_i^{ε} is a conjugate of σ_i^{ε} . Such an *n*-tuple is simply called a head system. For a braid system $h - (B, \ldots, B)$ and $i \in \{1, ..., n-1\}$ we define a new brai braid system. For a braid system $b = (\beta_1, \dots, \beta_n)$ and $i \in \{1, \dots, n-1\}$, we define a new braid system *b*' by

$$
b' = (\beta_1, ..., \beta_{i-1}, \beta_i \beta_{i+1} \beta_i^{-1}, \beta_i, \beta_{i+2}, ..., \beta_n).
$$

Then, we say that *b* ′ is obtained from *b* by a *slide action*. Two braid systems are said to be *slide equivalene* (or *Hurwitz equivalene*) if one can be obtained from the other by a finite sequance of slide actions.

Proposition 2.2 ([\[17\]](#page-11-4)). *There exists an one to one natural correspondance between the set of equivalene classes of (simple) braided surfaces degree m and the set of slide equivalene classes of braid systems of degree m:*

{*Braided surfaces*} /*equivalene* 1:1 ←→ {*braid systems*} /*slide equivalene*.

The braid group B_m acts on the free group F_m as follows: The braid group B_m is identified with the mapping class group $MCG_{\partial}(D^2, X_m)$, the group of isotopy classes of homeomorphisms $\phi : D^2 \setminus X_m \to D^2 \setminus X_m$ that fix ∂D^2 pointwise. An element $b \in R$, corresponds to an isotopy class [*b*], and the action of [*b*] on an eleme ∂D^2 pointwise. An element *b* ∈ *B_m* corresponds to an isotopy class [ϕ], and the action of [ϕ] on an element α $[\gamma] \in \pi_1(D^2 \setminus X_m)$ is defined as $[\phi \circ \gamma]$.

A Hurwitz system in D^2 with the starting point set X_m induces generators x_1, \ldots, x_m for $\pi_1(D^2 \setminus X_m)$, making the free group F on Y . The action of B on F is defined similaly via homeomorphisms ϕ as it the free group F_m on x_1, \ldots, x_m . The action of B_m on F_m is defined similaly via homeomorphisms ϕ as desctibed above. Explicitly, the images of $\sigma_i \cdot x_j$ and $\sigma_i^{-1} \cdot x_j$ are given by:

$$
\sigma_i \cdot x_j = \begin{cases} x_i x_{i+1} x_i^{-1} & (j = i), \\ x_i & (j = i + 1), \\ x_j & \text{(otherwise)}, \end{cases} \qquad \sigma_i^{-1} \cdot x_j = \begin{cases} x_{i+1} & (j = i), \\ x_{i+1}^{-1} x_i x_{i+1} & (j = i + 1), \\ x_j & \text{(otherwise)}. \end{cases}
$$

For braids $b_1, b_2 \in B_m$, the action of (b_1b_2) on $w \in F_m$ is given by $(b_1b_2) \cdot w = b_2 \cdot (b_1 \cdot w)$.

2.3. The plat closure of braided surfaces. A *wicket* [\[2\]](#page-10-5) is a semi-circle in $D^2 \times I$ that meets $D^2 \times \{0\}$ orthogonally at its endpoints in Int D^2 . A configuration of *m* wicket is a disjoint union of *m* wickets. Let w_0 be the configuration of *m* wickets such that each wicket has the boundary $\{x_{2i-1}, x_{2i}\} \subset X_m$ ($i \in \{1, \ldots, m\}$), and let \mathcal{W}_m denote the space consisting of configurations of *m*-wickets. For a loop $f : (I, \partial I) \to (\mathcal{W}_m, w_0)$, the 2*m*-braid β_f is defined as

$$
\beta_f = \bigcup_{t \in I} \partial f(t) \times \{t\} \subset (D^2 \times \{0\}) \times I = D^2 \times I.
$$

A 2*m*-braid β is *adequate* if $\beta = \beta_f$ for some loop $f : (I, \partial I) \to (\mathcal{W}_m, w_0)$.

Hilden subgroup K_{2m} of B_{2m} is the subgroup generated by σ_1 , $\sigma_2\sigma_1\sigma_3\sigma_2$ and $\sigma_{2k}\sigma_{2k-1}\sigma_{2k+1}^{-1}\sigma_{2k+1}^{-1}$ for $k \in$ $m-1$). {1, ..., *m* − 1}. We remark that σ_{2j-1} and $\sigma_{2k}\sigma_{2k-1}\sigma_{2k+1}\sigma_{2k}$ also belong to {1, . . . , *^m* [−] ¹}. Brendle-Hatcher [\[2\]](#page-10-5) proved that *^K*2*^m* is precisely the subgroup generated by adequate 2*m*-braids.

We assume $D^2 \subset \mathbb{R}^2$ and $y_0 = 1 \in \mathbb{C}$. For a braided surface *S* of degree *m*, the *m*-braid β_S are defined as follows: √

$$
\beta_S = \bigcup_{t \in I} \text{pr}_1(\pi_S^{-1}(e^{2\pi\sqrt{-1}t})) \times \{t\} \subset D^2 \times I.
$$

We call β_s the *boundary braid* of *S*. A braided surface is *adequate* if the boundary braid β_s is adequate. We remark that the degree of an adequate braided surface is even.

Let *S* be an adequate braided surface of degree 2*m*, and we define the plat closure of *S* as follows: For *t* ∈ *I* = [0, 1], we define an interval $J_t = \{re^{2\pi\sqrt{-1}t} \in \mathbb{C} \mid 1 \leq r \leq 2\}$, where $J_0 = J_1$. The union of J_t ($t \in I$) is an annulus, and ∂R^2 is contained in the boundary of the annulus. Since β_c is adeq is an annulus, and ∂B^2 is contained in the boundary of the annulus. Since β_S is adequate, there exists the loop $f: (I, \partial I) \to (W - w_0)$ such that $\beta_S = \beta_S$. Let w. $(t \in I)$ denote the configuration of m wickets $f(t)$ i $f: (I, \partial I) \to (\mathcal{W}_m, w_0)$ such that $\beta_S = \beta_f$. Let w_t $(t \in I)$ denote the configuration of m wickets $f(t)$ in $D^2 \times J_t$ such that $\partial w_t \subset D^2 \times \{e^{2\pi \sqrt{-1}t}\}\)$. Then, the union of w_t ($t \in I$), denoted by A_S , is the surface properly embedded in $(D^2 \times B^2)^c - \mathbb{R}^4$) int $(D^2 \times B^2)$ such that $\partial A_S - \partial S - S \cap A_S$ in $(D^2 \times B^2)^c$ = $\mathbb{R}^4 \setminus \text{int}(D^2 \times B^2)$ such that $\partial A_S = \partial S = S \cap A_S$.

Definition 2.3. The *plat closure* of *S* is the union of *S* and A_S , denoted by \widetilde{S} .

Proposition 2.4 ([\[20\]](#page-11-7)). *Every surface-link is ambiently isotopic to the plat closure of some braided surface.*

Proposition 2.5 ([\[21\]](#page-11-8)). *Let S be an adequate braided surface of degree* ²*m, and let* (β¹, . . . , β*ⁿ*) *a braid system of* S such that $\beta_i = b_i^{-1} \sigma_i^{\varepsilon_i} b_i$ ($\varepsilon_i \in \{1, -1\}$). Then, the knot group of the plat closure \widetilde{S} has a $(2m, n)$ -presentation with inverses associated with b. *ⁱ* σ *with inverses associated with b*¹, . . . , *^bn:*

$$
\langle x_1, \ldots, x_{2m} | b_i \cdot x_1 = b_i \cdot x_2, x_{2j-1} = x_{2j}^{-1} (i \in \{1, \ldots, n\}, j \in \{1, \ldots, m\}) \rangle.
$$

Proof. Let *^S* be an adequate braided surface of degree 2*^m* and ^β*^S* the boundary braid of *^S* . From [\[8\]](#page-11-0), the knot group $G(S) = \pi_1(D^2 \times B^2 \setminus S)$ has $(2m, n)$ -presentation

$$
G(S) = \langle x_1, \ldots, x_{2m} \mid b_i \cdot x_1 = b_i \cdot x_2 \ (i \in \{1, \ldots, n\}) \rangle
$$

Let *L* denote the intersection of *S* and A_S , which is a link in a 3-sphere $\partial(D^2 \times B^2)$ and the closure of β_S . Then, the knot group $G(I)$ has a presentation the knot group $G(L)$ has a presentation

$$
G(L) = \left\langle x_1, \ldots, x_{2m} \; | \; x_k = \beta_S \cdot x_k \; (k = 1, \ldots, 2m) \right\rangle.
$$

By applying [\[21,](#page-11-8) Lemma 4.7] for the case of groups, the knot group of $G(A_S) = \pi_1((D^2 \times B^2)^c \setminus A_S)$ has a presentation presentation

$$
G(A_S) = \left\langle x_1, \ldots, x_{2m} \mid x_k = \beta_S \cdot x_k, \quad x_{2j-1} = x_{2j}^{-1} \ (k = 1, \ldots, 2m, j = 1, \ldots, m) \right\rangle.
$$

Finally, the homomorphism $\iota_S : G(L) \to G(S)$ (or $\iota_{A_S} : G(L) \to G(A_S)$) induced from the natural inclu-
n man sends $x_i \in G(L)$ to $x_i \in G(S)$ (or $x_i \in G(A_S)$) respectively. Hence we obtain the presentation in sion map sends $x_k \in G(L)$ to $x_k \in G(S)$ (or $x_k \in G(A_S)$), respectively. Hence we obtain the presentation in Proposition [2.5](#page-3-1) by van Kampen's theorem. □

2.4. **Proof of Theorem [1.3.](#page-1-0)** We divide the proof into two parts: the "only if part" and the "if part".

(Proof of the only if part): Let $G = G(F)$ be the knot group of a (c, d) -component genus *g* surface-link *F*. From Theorem [2.4,](#page-3-2) *F* is ambiently isotopic to the plat closure of an adequate braided surface *S* of degree 2*m*. Let $(\beta_1, \ldots, \beta_n)$ be a braid system of *S* such that $\beta_i = b_i^{-1} \sigma_i^{\epsilon_i} b_i$ ($\varepsilon_i \in \{1, -1\}$). By Proposition [2.5,](#page-3-1) *G* admits a $(2m, n)$ -presentation with inverses associated with b_i . **i** σ (*p*₁, . . . , *p*_{*n*}) be a braid system of *S* such that $p_i = v_i$ o_1 v_i ($e_i \in \{1, -1\}$). By 1 toposition 2.5, O admits a (2*m*, *n*)-presentation with inverses of *G* satisfies the weak ∂ -condition. with inverses of *^G* satisfies the weak ∂-condition:

$$

= $\beta_S \in K_{2m}$,

where $(\gamma_1, \dots, \gamma_n)$ is a Hurewitz loop system in B^2 . It holds that $\chi(\overline{S}) = 2m - n$ so that *G* satisfies the condition (2) . Using the Alexander Duality Theorem we know that $H(\mathbb{R}^4 \setminus F) \approx \mathbb{Z}^c \oplus (\mathbb{Z}/2)^d$. S (2). (**Proof of the if part**): Suppse *G* is a group satisfying the conditions $(1) - (3)$ of Theorem [1.3](#page-1-0) for some $m, n \ge 0$. Specifically, *G* admits a $(2m, n)$ -presentation with inverses associated with $2m$ -braids b_1, \ldots, b_n , and there exists signs $\varepsilon_1, \ldots, \varepsilon_n$ such that

$$
\prod_{i=1}^n b_i^{-1} \sigma_1^{\varepsilon_i} b_i \in K_{2m}.
$$

Let *S* be a braided surface of degree 2*m* associated with a braid system $(\beta_1, \ldots, \beta_n)$ with $\beta_i = b_i^{-1} \sigma_i^{\varepsilon_i} b_i$. Since $\beta_i = \prod_{i=1}^n b_i^{-1} \sigma_i^{\varepsilon_i} b_i$. Since $\beta_S = \prod_{i=1}^n b_i^{-1} \sigma_i^{\epsilon_i} b_i \in K_{2m}$, *S* can be chosen as an adequate braided surface. We define the surface-link *F* as the plat closure of *S*. By Proposition 2.5, the knot group of *F* is isomorphic to *G*. By Proposition [2.5,](#page-3-1) the knot group of *F* is isomorphic to *G*. Further component and genus *g* because

$$
H_1(\mathbb{R}^4 \setminus F) \cong G/[G, G] \cong \mathbb{Z}^c \oplus (\mathbb{Z}/2)^d \quad \text{and} \quad \chi(\widetilde{S}) = 2m - n = 2(c + d) - g.
$$

This completes the proof of Theorem [1.3.](#page-1-0) □

The author [\[20\]](#page-11-7) also showed that every orientable surface-link is ambiently isotopic to the plat closure of a 2 dimensional braid. Consequently, we have a similar characterization of knot groups of orientable surface-links:

Theorem 2.6. *A group G is the knot group of a c-component genus g orientable surface-link if and only if G satisfies the following conditions for some* $m, n \geq 0$ *:*

- (1) *G has an* (2*m*, *ⁿ*)*-presentation with inverses satisfying the* ∂*-condition.*
- (2) *It holds that* $2c g = 2m n$.
- (3) $G/[G,G]$ *is isomorphic to* \mathbb{Z}^c *.*

3. Quandles and symmetric quandles

3.1. **Quandles.** A *quandle* [\[7,](#page-10-2) [15\]](#page-11-1) is a set *Q* with a binary operation $* : Q \times Q \rightarrow Q$ on *Q* satisfying the following three axioms:

- (Q1) For any $a \in Q$, we have $a * a = a$.
- (Q2) For any $a, b \in Q$, there exists a unique element $c \in Q$ such that $a * c = b$.
- (Q3) For any $a, b, c \in Q$, we have $(a * b) * c = (a * c) * (b * c)$.

A *rack* [\[4\]](#page-10-6) is a set *Q* with a binary operation on *Q* satisfying (Q2) and (Q3).

A quandle homomorphism is a map $f : Q \to Q'$ such that $f(a * b) = f(a) * f(b)$ for any $a, b \in Q$. For $b \in Q$, map $S \mapsto Q \to Q$ sending $a \in Q$ to $a * b \in Q$ is a quandle homomorphism. Moreover, $S \mapsto g$ quandle the map S_b : $Q \rightarrow Q$ sending $a \in Q$ to $a * b \in Q$ is a quandle homomorphism. Moreover, S_b is a quandle automorphism. The *inner automotphism group* of *Q*, denoted by Inn(*Q*), is the subgroup of Aut(*Q*) generated by S_h for all $b \in Q$.

A quandle *Q* is called *connected* if $\text{Inn}(Q)$ acts transitively on *Q*. Similaly, an orbit of *Q* under the action of Inn(*Q*) is called a *connected component* of *Q*.

For a quandle $(Q, *)$, we define the binary operation $\overline{*}$ on Q by $a\overline{*}b = c$, where $c \in Q$ is a unique element obtained from the axiom (Q2). Then $(Q, \overline{*})$ is again a quandle. We call $\overline{*}$ the *dual operation* of $\overline{*}$.

When expressing elements of *Q*, we sometimes use the Fenn-Rourke notation [\[4\]](#page-10-6): For $a, b \in Q$, $a * b$ is written as a^b , and for $w = b_1^{\varepsilon_1} b_2^{\varepsilon_2} \cdots b_n^{\varepsilon_n} \in F(Q), (\cdots ((a * \varepsilon_1 b_1) * \varepsilon_2 b_2) * \cdots) * \varepsilon_n b_n$ is written as a^w , where $*^1 = *$ and $*^{-1} = \overline{*}.$

Example 3.1 (Free quandle). Let *A* be an non-empty set and $F(A)$ the free group on *A*. Then $FR(A) = A \times F(A)$ is a rack by a binary operation $(x, w) * (y, u) = (x, wu^{-1}yu)$ for $(x, w), (y, u) \in \text{FR}(A)$. We call $\text{FR}(A)$ the *free rack* on A on *A*.

Let ∼*q* be the equivalence relation on FR(*A*) generated by (x, w) ∼*q* (x, xw) for $x \in A$ and $w \in F(A)$. Then the rack operation on FR(*A*) induces a quandle operation on FQ(*A*) := FR(*A*)/ \sim_q . We call FQ(*A*) the *free quandle* on *A*. We write *x^w* for (*x*, *w*) ∈ FQ(*A*) and *x* for (*x*, 1), where 1 ∈ *F*(*A*) is the unit element.
For a subset *R* of FO(*A*) × FO(*A*) the quandle (*A* | *R*) is defined in a manner similar

For a subset *R* of FQ(*A*) \times FQ(*A*), the quandle $\langle A | R \rangle_q$ is defined in a manner similar to the case of group presentations. The quandle $\langle A | R \rangle_q$ is called a *quandle presentation* of a quandle Q if Q is isomorphic to $\langle A | R \rangle_q$. (See [\[4\]](#page-10-6) for details.)

Example 3.2 (Knot quandle). Let *K* be a properly embedded oriented *n*-submanifold in a connected $(n + 2)$ manifold *M*, $N(K)$ a regular neighborhood of *K* in *M*, $E(K) = cl(M \setminus N(K))$ the exterior of *K*, and ∗ a fixed based point of *^E*(*K*). An (*unoriented*) *noose* of *^K* is a pair (*D*, α) of an (unoriented) meridional disk *^D* of *^K* and an oriented arc α in $E(K)$ connecting from a point of ∂D to $*$.

We denote by $Q(M, K, p)$ the set of homotopy classes $[(D, \alpha)]$ of all noose of *K*. The *knot quandle* (or *fundamental quandle*) of *K* is $Q(K, p)$ with the binary operation $*$ on $Q(M, K, p)$ defined by

$$
[(D,\alpha)] * [(D',\alpha')] = [(D,\alpha \cdot \alpha'^{-1}\partial D'\alpha')],
$$

where $\partial D'$ is a meridional loop starting from the initial point of α' and going along $\partial D'$ in the positive direction.
See Figure 1 for $n = 1$. Thus we denote it by $O(M, K)$ or $O(K)$ simply. We notice that the knot q See Figure [1](#page-5-0) for $n = 1$. Thus we denote it by $Q(M, K)$ or $Q(K)$ simply. We notice that the knot quandle is independent of the choice of the base point *p* since *M* is connected. It is known that the numbers of connected components of K and $Q(K)$ are equal.

Figure 1. Nooses of *K* (left) and an operation result of the knot quandle (right)

The knot quandle $Q(D^2, X_m)$ is isomorphic to the free quandle on *n* letters. By a similar way of the definition the action on the free quandle $EQ(Y)$ by *R* denoted by of the action on the free group by B_m , we can define the action on the free quandle $FQ(X_m)$ by B_m , denoted by $b \cdot x$ for $b \in B_m$ and $x \in \text{FQ}(X_m)$. Explicitly, for $i \in \{1, ..., m-1\}$ and $x_j \in X_m$, the images $\sigma_i \cdot x_j$ and $\sigma_i^{-1} \cdot x_j$

are written as

$$
\sigma_i \cdot x_j = \begin{cases} x_{i+1} \overline{*} x_i & (j = i), \\ x_i & (j = i+1), \\ x_j & \text{(otherwise).} \end{cases} \quad \sigma_i^{-1} \cdot x_j = \begin{cases} x_{i+1} & (j = i), \\ x_i * x_{i+1} & (j = i+1), \\ x_j & \text{(otherwise).} \end{cases}
$$

3.2. **Symmetric quandles.** A *good involution* of a quandle *Q* is an involution $\rho : X \to X$ (i.e., $\rho \circ \rho = \text{id}_Q$) such that for any $a, b \in Q$, we have $\rho(a * b) = \rho(a) * b$ and $a * \rho(b) = a * b$. A *symmetric quandle* is a pair $X = (Q, \rho)$ of a quandle Q and its good involution ρ . A symmetric quandle homomorphism is a quandle homomorphism $f: (Q, \rho) \to (Q', \rho')$ such that $f \circ \rho = \rho' \circ f$.

Example 3.3 (Dihedral quandles). The *dihedral quandle* R_n is $\mathbb{Z}/n\mathbb{Z}$ with $a * b = 2b - a$. Kamada and Oshiro [\[13\]](#page-11-9) classified the good involutions of dihedral quandles:

- (1) When $n \equiv 1, 3 \pmod{4}$, the idetity map id_{R_n} is the only good involution of R_n .
(2) When $n \equiv 2 \pmod{4}$ the good involution is either the idetity map id. or the
- (2) When $n \equiv 2 \pmod{4}$, the good involution is either the idetity map id_{R_n} or the *antipodal map* ρ_A which is defined by $\rho_A(a) = a + n/2$ is defined by $\rho_A(a) = a + n/2$.
- (3) When $n \equiv 0 \pmod{4}$, the good involution is either the idetity map id_{R_n} , the antipodal map ρ_A , or one of the two types of *half-antipodal maps* denoted by α_{M_n} and α' which are defined by the two types of *half-antipodal maps*, denoted by ρ_{HA} and ρ'_{HA} , which are defined by

$$
\rho_{HA}(a) = \begin{cases} a + n/2 & (a: \text{ even}) \\ a & (a: \text{ odd}) \end{cases}, \quad \rho'_{HA}(a) = \begin{cases} a & (a: \text{ even}) \\ a + n/2 & (a: \text{ odd}) \end{cases}
$$

We remark that (R_{4n}, ρ_{HA}) and (R_{4n}, ρ'_{HA}) are isomorphic as symmetric quandles.

A *kei* (or a *involutory quandle*) is a quandle *Q* such that $(a * b) * b = a$ for any $a, b \in Q$. The dihedral quandle is a kei. They also proved that *Q* is a kei if and only if the identity map id*^Q* is a good involution of *Q*.

Example 3.4. Let Q be a quandle and $\overline{Q} = {\overline{a} \mid a \in Q}$ a copy of Q. We extend the binary operation $*$ on Q into the disjoint union $D(Q) = Q \cup \overline{Q}$:

$$
a * \overline{b} := a \overline{*}b, \quad \overline{a} * b := \overline{a * b}, \quad \overline{a} * \overline{b} := \overline{a \overline{*}b}.
$$

Then $(D(Q), *)$ is a quandle. We define a good involution ρ on $D(Q)$ by $\rho(a) = \overline{a}$. The symmetric quandle $(D(Q), \rho)$ is called the *double* of *Q*.

The *free symmetric quandle* on *A*, denoted by FSQ(*A*), is the double of the free quandle FQ(*A*) on *A*. The underlying set of FSQ(*A*) is ($A \cup \overline{A}$) × $F(A)$ under the identification $\overline{a} \in \overline{A}$ with $a^{-1} \in F(A)$.

Oshiro showed [\[16\]](#page-11-10) that the double of R_{2n+1} is the dihedral quandle R_{4n+2} with the antipodal map.

Example 3.5 (Knot symmetric quandles). Let *K* be an (unoriented) properly embedded *n*-submanifold in a connected $(n + 2)$ -manifold *M*, $N(K)$ a regular neighborhood of *K* in *M*, $E(K) = cl(M \setminus N(K))$ the exterior of *K*, and $*$ a fixed based point of $E(K)$. An *oriented noose* of *K* is a pair (D, α) of an oriented meridional disk *D* of *K* and an oriented arc α in $E(K)$ connecting from a point of ∂D to $*$.

 $\widetilde{Q}(M,K)$ (or $\widetilde{Q}(K)$ simply) denotes the set of homotopy classes $[(D,\alpha)]$ of all oriented noose of *K*. We remark that $[(D, \alpha)]$ and $[(-D, \alpha)]$ are different homotopy classes if *K* is orientable, where $-D$ is *D* with the reversed orientation. The *knot full quandle* (or *fundamental full quandle*) of *K* is $\tilde{Q}(M, K)$ with the binary operation $*$ on $Q(M, K)$ defined by

$$
[(D,\alpha)] * [(D',\alpha')] = [(D,\alpha \cdot \alpha'^{-1}\partial D'\alpha')].
$$

The good involution ρ_K of $\overline{Q}(M, K)$ is defined by $\rho_K([D, \alpha)]) = [(-D, \alpha)]$. The *symmetric knot quandle* (or *fundamental symmetric quandle*) of *K* denoted by $Y(M, K)$ (or $Y(K)$ simply) is the pair of $\overline{Q}(K)$ and α *fundamental symmetric quandle*) of *K*, denoted by *X*(*M*, *K*) (or *X*(*K*) simply), is the pair of $\widetilde{Q}(K)$ and ρ_K .

When *K* is orientable, then $X(K)$ is the double of $Q(K)$. When *K* is non-oriententable and connected, then *X*(*K*) is also connected as a quandle.

The knot symmetric quandle $X(D^2, X_m)$ is isomorphic to the free symmetric quandle on *m* letters. The action the free quandle $FQ(X)$ by the braid group *R* extends the action on the free symmetric quandle $FQ(X)$ on the free quandle $FQ(X_m)$ by the braid group B_m extends the action on the free symmetric quandle $FSQ(X_m)$ by B_m defined by $b \cdot \overline{x_j} = b \cdot x_j$.

3.3. Symmetric quandle presentation. In this section, we recall the definition of presentations of symmetric quandles.

Let *A* be a non-empty set, and *R* be a subset of FSQ(*A*) \times FSQ(*A*). Then, we define a subset $\langle R \rangle_{\text{Sq}}$ of $FSQ(A) \times FSQ(A)$ by repeating the following moves:

- (E1) For every $x \in FSQ(A)$, add (x, x) to R .
- (E2) For every $(x, y) \in R$, add (y, x) to R .
- (E3) For every $(x, y), (y, z) \in R$, add (x, z) to R.
- (R1) For every $(x, y) \in R$ and $a \in A$, add (x^a, y^a) , (x^{-a}, y^{-a}) to *R*.
 $f(R^2)$ For every $(x, y) \in R$ and $t \in ESO(A)$ add (f^x, f^y) , (f^{-x}, f^{-y}) to
- (R2) For every $(x, y) \in R$ and $t \in FSQ(A)$, add $(t^x, t^y), (t^{-x}, t^{-y})$ to *R*.

(S) For every $(x, y) \in R$ add (x^{-1}, y^{-1}) to *R*.
- (S) For every $(x, y) \in R$, add (x^{-1}, y^{-1}) to *R*.

Then $\langle \langle R \rangle \rangle_{sg}$ is called the *set of symmetric quandle consequences* of *R*, which is the smallest congruence containing *R* with respect to the axioms of a symmetric quandle ([\[11\]](#page-11-11)). An element of $\langle R \rangle_{sg}$ is called a *consequence* of *R*. Let $\langle A | R \rangle_{sq}$ denote the quotient set FSQ(A)/ $\langle \langle R \rangle \rangle_{sq}$. The quandle operation and the good involution of FSQ(*A*) induce a quandle operation and a good involution on $\langle A | R \rangle_{sq}$.

Definition 3.6. The symmetric quandle ⟨*A* | *R*⟩sq is a *symmetric quandle presentation* of a symmetric quandle *X* if $\langle A | R \rangle_{\text{sq}}$ is isomorphic to *X*.

The symbol $\overline{x_i}$ denotes the image of x_i by the good involution in a symmetric quandle presentation. The notions and properties of symmetric quandle presentations are discussed in detail in [\[11,](#page-11-11) [21\]](#page-11-8).

It is known that two finite presentations of a group are related by a finite sequence of Tietze transformations. This result was extended for finite presentations of racks [\[4\]](#page-10-6) and of symmetric quandles [\[21\]](#page-11-8).

Proposition 3.7 ([\[21\]](#page-11-8)). *Any two finite presentations of a symmetric quandle are related by a finite sequence of Tietze transformations (T1) – (T4):*

- (T1) *Add a consequence* $r \in \langle \langle R \rangle \rangle_{sq}$ *to R.*
- (T2) *Delete a relator r from R, where r is a consequence of other relators in R.*
- (T3) Add a new generator x and a new relator (x, r) to A and R, respectively, where r is an element of $F(A)$.
- (T4) *Delete a generator x and a relator* (*x*,*r*) *from A and R, respectively, where* (*x*,*r*) *is a consequence of other relators and x does not occur in other relators in R.*

A symmetric quandle presentation is called a $(2m, n)$ -presentation with inverses (associated with b_1, \ldots, b_n) if it is

$$
\langle x_1, \ldots, x_{2m} | b_i \cdot x_1 = b_i \cdot x_2, x_{2j-1} = \overline{x_{2j}} \quad (i = 1, \ldots, n, j = 1, \ldots, m) \rangle_{\text{sq}}.
$$

We say that an $(2m, n)$ -presentation with inverses satisfies the *weak* ∂ -*condition* if there exist signs $\varepsilon_1, \ldots, \varepsilon_n \in$
 $\{1, -1\}$ such that $\{1, -1\}$ such that

$$
\prod_{i=1}^n b_i^{-1} \sigma_1^{\varepsilon_i} b_i \in K_{2m}.
$$

Proposition 3.8 ([\[21\]](#page-11-8)). *Let S be an adequate braided surface of degree* ²*m and* (β¹, . . . , β*ⁿ*) *be a braid system of S* such that $\beta_i = b_i^{-1} \sigma_i^{\epsilon_i} b_i$ ($\epsilon_i \in \{1, -1\}$). Then the knot symmetric quandle of the plat closure \tilde{S} has a $(2m, n)$ -presentation with inverses associated with b. (2*m*, *n*)*-presentation with inverses associated with* b_1, \ldots, b_n *.*

3.4. Proof of Theorem [1.4.](#page-1-1) We prove Theorem [1.4](#page-1-1) by rephrasing the proof of Theorem [1.3.](#page-1-0) Thus, we provide only an outline of the proof.

(Proof of the only if part): Let (Q, ρ) be the knot symmetric quandle of a (c, d) -component genus g surface-link *F*. Then, there exists an adequate braided surface *S* of degree 2*m* whose plat closure is *F*. By Proposition [3.8,](#page-7-0) (*Q*, ρ) has a (2*m*, *ⁿ*)-presentation with inverses satisfying the weak ∂-condition. Furthermore, (*Q*, ρ) satisfies the condition (2) because $\chi(\bar{S}) = 2m - n = 2(c + d) - g$.

Let F_0 be a connected component of *F*. For any $[(D, \alpha)]$, $[(D', \alpha')] \in X(F)$ with meridional disks *D* and *D'*
 F_0 either $[(D, \alpha)]$ or $[(-D, \alpha)]$ belong to the connected component of $Y(F)$ containing $[(D', \alpha')]$ Moreover of F_0 , either $[(D, \alpha)]$ or $[(-D, \alpha)]$ belong to the connected component of $X(F)$ containing $[(D', \alpha')]$. Moreover, connected components of *X*(*F*) containing $[(D, \alpha)]$ and $[(-D, \alpha)]$ are the same if and only if F_0 is non-orientable. Thus, the number of connected component of $X(F)$ is $2c + d$. Furthermore, the good involution of $X(F)$ maps $[(D, \alpha)]$ to $[(-D, \alpha)]$. Hence, (Q, ρ) satisfies the condition (3).

(Proof of the if part): Let (Q, ρ) be a symmetric quandle satisfying the conditions $(1) - (3)$ of Theorem [1.4](#page-1-1) for some $m, n \geq 0$. Then, there exists an adequate braided surface *S* of degree 2*m* such that the knot symmetric quandle of the plat closure \overline{S} is (Q, ρ) . By the condition (3), \overline{S} is (c, d) -component. Finally, the genus of \overline{S} is *g* since it holds that $\gamma(\overline{S}) = 2m - n = 2(c + d) - g$. since it holds that $\chi(\widetilde{S}) = 2m - n = 2(c + d) - g$.

4. Knot symmetric quandles and dihedral quandles

In this section, we provide symmetric quandle presentations of dihedral quandles with arbitrarily good involutions, and we show that dihedral quandles with arbitrarily good involutions can be realized as the knot symmetric quandles of surface-links. The following was provided by Taniguchi in a private communication: Let $\langle A | R \rangle_{\text{sq}}$ be a symmetric quandle presentation of (Q, ρ) . Denote $\overline{A} = {\overline{x} | x \in A}$, and assume that \overline{A} is disjoint from A. For an element $r = (x^w, y^u) \in R$, we denote $\overline{r} = (\overline{x}^w, \overline{y}^u)$, where $\overline{\overline{x}} = x$ for $x \in A$. We define $\overline{P} = (\overline{x}^u, \overline{x}^u)$ and $P_x = ((x^{\overline{y}} + x^{\overline{y}})) \times y \in A$. $\overline{R} = {\overline{r} \mid r \in R}$, and $R_0 = {(x^{\overline{y}}, x^{\overline{y}}^{-1}) \mid x, y \in A}$.

Proposition 4.1. *In the situation above, Q has a quandle presentation* $\langle A, \overline{A} | R, \overline{R}, R_0 \rangle_a$ *.*

Proof. Let Q_0 denote the quandle with $\langle A, \overline{A} | R, \overline{R}, R_0 \rangle_q$. We define the involution $\rho_0 : Q_0 \to Q_0$ by $\rho_0(x^w) = \overline{x}^w$
for $x^w \in Q$. Then we verify that \overline{Q} is a good involution of Q , as follows: Fo for $x^w \in Q_0$. Then we verify that ρ_0 is a good involution of Q_0 as follows: For any $x^w, y^u \in Q$ ($x, y \in A \cup \overline{A}$, $w, u \in F(A)$) we have $w, u \in F(A)$, we have

$$
\rho_0(x^w * y^u) = \overline{x}^{wu^{-1}yu} = \rho_0(x^w) * y^u.
$$

$$
x^w * \rho_0(y^u) = x^{wu^{-1}\overline{y}u} \stackrel{\text{(B)}}{=} x^{\overline{y}ywu^{-1}y^{-1}u} = x^{y^{-1}ywu^{-1}y^{-1}u} = x^w \overline{*} y^u.
$$

Here, the equality (♯) follows from $z^{w\overline{y}} = z^{wx^{-1}\overline{y}yxy^{-1}}$ for each $x, y, z \in A$ and $w \in F(A)$, derived from the relation $x^{\overline{y}} - x^{y^{-1}}$ in P . $x^{\overline{y}} = x^{y^{-1}}$ in *R*₀.

Let $f_1 : A \cup \overline{A} \hookrightarrow Q$ and $\iota_1 : A \cup \overline{A} \hookrightarrow Q_0$ be the natural maps. By the universality of quandle presentations (cf. [\[12,](#page-11-12) Lemma 8.6.3]), there exists a quandle homomorphism $F_1: Q_0 \to Q$ such that $f_1 = F_1 \circ \iota_1$.

Similaly, let $f_2: A \hookrightarrow Q_0$ and $\iota_2: A \hookrightarrow Q$ be the natural maps. By the universality of symmetric quandle presentation ([\[21,](#page-11-8) Lemma 3.8]), there exists a symmetric quandle homomorphism F_2 : $(Q, \rho) \rightarrow (Q_0, \rho_0)$ such that $f_2 = F_2 \circ \rho$. Finally, F_1 and F_2 are inverse maps of each other, and thus O and O₀ are isomorphic that $f_2 = F_2 \circ \iota_2$. Finally, F_1 and F_2 are inverse maps of each other, and thus *Q* and *Q*₀ are isomorphic.

Lemma 4.2 (cf. [\[3\]](#page-10-7)). *The dihedral quandle has the following quandle presentation:*

$$
R_{2n+1} = \left\langle x, y \mid x^{y^2} = x, y^{x^2} = y, x = y^{(xy)^n} \right\rangle_q.
$$

\n
$$
R_{2n} = \left\langle x, y \mid x^{y^2} = x, y^{x^2} = y, x = x^{(yx)^n}, y = y^{(xy)^n} \right\rangle_q
$$

Now, we provide symmetric quandle presentations of dihedral quandles for each good involution.

Proposition 4.3. *For n* \geq 1*, the dihedral quandle with the antipodal map has the following presentation:*

$$
(R_{4n+2}, \rho_A) = \left\langle x, y \mid \overline{x} = y^{(xy)^n}, \overline{y} = x^{(yx)^n} \right\rangle_{\text{sq}},
$$

$$
(R_{4n}, \rho_A) = \left\langle x, y \mid \overline{x} = x^{(yx)^n}, \overline{y} = y^{(xy)^n} \right\rangle_{\text{sq}}.
$$

Proof. We show the case of (R_{4n+2}, ρ_A) . Let $(Q, \rho) = \langle x, y | \overline{x} = y^{(xy)^n}, \overline{y} = x^{(yx)^n} \rangle_{sq}$ denote the symmetric quandle. By direct calculation, we obtain the equality $x * y = x * (y^{(xy)^n} x^{(yx)^n} y)$ without any additional relations:

$$
x * (y^{(xy)^n} x^{(yx)^n y}) = x * ((y^{-1} x^{-1})^n y(xy)^n y^{-1} (x^{-1} y^{-1})^n x(yx)^n y)
$$

= $x * ((y^{-1} x^{-1})^n (yx)^n y y^{-1} (x^{-1} y^{-1})^n (xy)^{n+1})$
= $x * (xy) = x * y$.

Since the relation $\bar{y} = x^{(yx)^n}$ derives the equality $\bar{y} = x^{(yx)^n y}$, we obtain a new relation $x * y = x * \bar{y}$ in the presentation. Similarly, we obtain $y * x = y * \overline{x}$. Hence, (Q, ρ) has the following presentation

(4.1)
$$
(Q, \rho) = \left\langle x, y \right| x = x^{y^2}, y = y^{x^2}, \overline{x} = y^{(xy)^n}, \overline{y} = x^{(yx)^n} \right\rangle_{\text{sq}}.
$$

By Proposition [4.1,](#page-8-1) Q has a quandle 1 presentation with four generators x, y, \overline{x} , \overline{y} , and the following twelve relations:

$$
x = x^{y^2}
$$
, $y = y^{x^2}$, $\overline{x} = y^{(xy)^n}$, $\overline{y} = x^{(yx)^n}$, $\overline{x} = \overline{x}^{y^2}$, $\overline{y} = \overline{y}^{x^2}$, $x = \overline{y}^{(xy)^n}$, $y = \overline{x}^{(yx)^n}$, $x^{\overline{x}} = x^{x^{-1}}$, $x^{\overline{y}} = x^{y^{-1}}$, $y^{\overline{x}} = y^{x^{-1}}$, $y^{\overline{y}} = y^{y^{-1}}$.

We now remove generators \overline{x} , \overline{y} with the relations $\overline{x} = y^{(xy)^n}$ and $\overline{y} = x^{(yx)^n}$ from the presentation of *Q*, resulting in the quandle *Q* being generated by *x*, *y* with the following ten relations. in the quandle Q being generated by x , y with the following ten relations:

$$
x^{y^2} = x, \quad y^{x^2} = y, \quad y^{(xy)^n y^2} = y^{(xy)^n}, \quad x^{(xy)^n x^2} = x^{(xy)^n}, \quad x = x^{(yx)^n (xy)^n}, \quad y = y^{(xy)^n (yx)^n}
$$

$$
x^{y^{(xy)^n}} = x^{x^{-1}}, \quad x^{x^{(yx)^n}} = x^{y^{-1}}, \quad y^{y^{(xy)^n}} = y^{x^{-1}}, \quad y^{x^{(yx)^n}} = y^{y^{-1}}.
$$

,

Two relations $x^{y^2} = x$ and $y^{x^2} = y$ induce the following equalities for any $z \in \{x, y\}$ and $w, u \in F(\{x, y\})$:

$$
z^{w x u} = z^{w x^{-1} u}, \quad z^{w y u} = z^{w y^{-1} u}.
$$

Therefore, all relations except for $x^{y^2} = x$, $y^{x^2} = y$, $x^{y^{(xy)^n}} = x^{x^{-1}}$, and $y^{x^{(yx)^n}} = y^{x^{-1}}$ are removable relations, so we can remove these relations from the presentation. Finally, the relations $x^{y^{(xy)^n}} = x^{x^{-1}}$ and $y^{y^{(xy)^n}} = y^{x^{-1}}$ are equivalent to $x = x^{(yx)^{2n+1}}$ and $y = y^{(xy)^{2n+1}}$, respectively. Therefore, Q is the dihedral quandle R_{2n+1} . Since the images of *x* and *y* under ρ are distinct from themselves, ρ is the antipodal map ρ_A . The case of (R_{4n}, ρ_A) can be shown by a similar way, so we leave the proof to the reader.

The proofs of the following two propositions are similar to the proof of Proposition [4.3,](#page-8-2) so we omit them.

Proposition 4.4. *The dihedral quandle with the idetity map has the following presentations:*

$$
(R_{2n+1}, id) = \left\langle x, y \mid \overline{x} = x, \overline{y} = y, x = y^{(xy)^n} \right\rangle_{\text{sq}},
$$

$$
(R_{2n}, id) = \left\langle x, y \mid \overline{x} = x, \overline{y} = y, x = x^{(yx)^n}, y = y^{(xy)^n} \right\rangle_{\text{sq}}.
$$

Proposition 4.5. *The dihedral quandle with the half-antipodal map has the following presentation:*

$$
(R_{4n}, \rho_{HA}) = \left\langle x, y \mid \overline{x} = x, \overline{x} = x^{(yx)^n}, \overline{y} = y^{(xy)^n} \right\rangle_{\text{sq}}
$$

4.1. **Proof of Thoerem [1.5.](#page-1-2)** For each good involution ρ of R_n , we construct a surface-link *F* with $X(F) \simeq$ $(R_n, \rho).$

(Case 1: $n \equiv 2 \pmod{4}$, $\rho = \rho_A$: the antipodal map) We denote $k = n/2$ and take an integer *m* such that $gcd(k, m) = 1$. Let $F = \tau^2(K(k, m))$ denote the 2-twist spun 2-knot of a 2-bridge knot $K(k, m)$. It was shown
by Inoue 161 that the knot quandle of *F* is isomorphic to the dihedral quandle *R*. Hence, the knot symmetric by Inoue [\[6\]](#page-10-8) that the knot quandle of *F* is isomorphic to the dihedral quandle *Rk*. Hence, the knot symmetric quandle *X*(*F*) is the double of R_k , which is $(R_{2k}, \rho_A) = (R_n, \rho_A)$ (see Example [3.4\)](#page-6-1).

(Case 2: $n \equiv 0 \pmod{4}$, $\rho = \rho_A$: the antipodal map) We construct a surface-link F_n as follows: Let $b = (\sigma_2^{-1})^k$
has a 4 hraid for $k = n/2$. We put $b_n = b$ and $b_n = (\sigma_1 \sigma_2 \sigma_1 \sigma_1)^{-1} b$. Then $(b^{-1} \sigma_1 b_1)(b^{-1} \sigma_1^{-1} b_1$ be a 4-braid for $k = n/2$. We put $b_1 = b$ and $b_2 = (\sigma_2 \sigma_1 \sigma_3 \sigma_2)^{-1} b$. Then, $(b_1^{-1} \sigma_1 b_1)(b_2^{-1} \sigma_1^{-1} b_2)$ is an adequate 4-braid. Hence we have a symmetric quandle *X* with a (4.2)-presentation with inverses assoc 2-braid. Hence, we have a symmetric quandle *X* with a (4, 2)-presentation with inverses associated with *b*₁, *b*₂ existing the weak ∂ -condition: satisfying the weak ∂ -condition:

$$
\langle x_1, x_2, x_3, x_4 | x_1 = x_2^{(x_3, x_2)^k}, x_3^{(x_2, x_3)^k} = x_4, x_1 = \overline{x_2}, x_3 = \overline{x_4} \rangle_{\text{sq}}.
$$

By Tietze moves, we remove generetors x_2 and x_3 with relations $x_1 = \overline{x_2}$ and $x_3 = \overline{x_4}$ from the presentation so that we have

$$
X = \left\langle x_2, x_3 \middle| \overline{x_2} = x_2^{(x_3 x_2)^k}, \overline{x_3} = x_3^{(x_2 x_3)^k} \right\rangle_{\text{sq}}
$$

,

and hence *X* is the dihedral quandle $R_{2k} = R_n$ with the antipodal map. By Theorem [1.4,](#page-1-1) *X* is the knot symmetric quandle of a surface-link F_n consisting of two projective planes.

(Case 3: $n \equiv 1, 3 \pmod{4}$, $\rho = \text{id}$) Let *F* denote a connected sum of $\tau^2(K(n, m))$ and a trivial P^2 -knot. In terms of the presentation of a symmetric quandle taking the connected sum of a trivial P^2 -knot is equival of the presentation of a symmetric quandle, taking the connected sum of a trivial $P²$ -knot is equivalent to adding relations $x = \overline{x}$, where *x* represents the meridional disk of the trivial P^2 -knot. Since *F* is connected, $x = \overline{x}$ induces the relation $y = \overline{y}$ so that *X*(*F*) has the presentation of (R_{2n+1} , id) in Proposition [4.4.](#page-9-0)

(Case 4: $n \equiv 0, 2 \pmod{4}$, $\rho = \text{id}$) Let F_n be the surface-link constructed in (Case 2). Since F_n is a 2-component surface-link, we obtain the surface-link F by taking the connected sum of trivial P^2 -knots with each component of F_n . Then, a presentation of $X(F)$ is obtained from the presentation of (R_{4n}, ρ_A) in Proposition [4.3](#page-8-2) by adding two relations $x = \overline{x}$ and $y = \overline{y}$, and hence this is the presentation of (R_{2n}, id) in Proposition [4.4.](#page-9-0)

(Case 5: $n \equiv 0 \pmod{4}$, $\rho = \rho_{HA}$) Let *F* denote a connected sum of the surface-link F_n constructed in (Case 2) and a trivial P^2 -knot. Then $X(F)$ has the presentation obtained from the presentation of (R_{4n}, ρ_A) in
Proposition 4.3 by adding the relation $x = \bar{x}$ and hence this is the presentation of (R_{4n}, ρ_A) in Prop Proposition [4.3](#page-8-2) by adding the relation $x = \overline{x}$, and hence this is the presentation of (R_{4n}, ρ_{HA}) in Proposition [4.5.](#page-9-1) \Box

5. Remarks on P^2 -irreduciblity of non-orientable surface-links

A P^2 -knot is a surface-knot homeomorphic to the projective plane $\mathbb{R}P^2$, and a P^2 -link is a disjoint union of P^2 knots. A surface-link is called P^2 -reducible if it is a connected sum of a trivial P^2 -knot and some surface-link, otherwise it is called P^2 -irreducible. The following is one of the fundamental conjectures for P^2 -knots.

Conjecture 5.1 (Kinoshita's problem [\[14\]](#page-11-13)). *Every P*² *-knot is P*² *-reducible.*

Using the knot symmetric quandle, we derive a necessary condition for the $P²$ -reduciblity of surface-knots.

Proposition 5.2. For a P^2 -reducible surface-knot F, the good involution of $X(F)$ is the identity map. In partic*ular, X*(*F*) *is a kei.*

Proof. Let *F* be a P^2 -reducible surface-knot, meaning that *F* decomposes into a surface-knot and a trivial P^2 knot P_0 . Let $x \in X(F)$ be an element representing a meridional disk of P_0 . Then the image $\rho(x)$ of *x* under the good involution ρ of $X(F)$ is the same as *x*. Since F is a surface-knot with a (0, 1)-component, $X(F)$ is a connected quandle by Theorem [1.4.](#page-1-1) Hence, for each $y \in X(F)$, there exists $z \in X(F)$ such that $y = x * z$. Therefore, we have $\rho(y) = \rho(x * z) = \rho(x) * z = x * z = y$, which implies that $\rho = id$. It was shown by Kamada-Oshiro [13] that a quandle *O* is a ket if and only if the identity map is a good involution of *O*. Kamada-Oshiro [\[13\]](#page-11-9) that a quandle Q is a kei if and only if the identity map is a good involution of Q .

We remark that this Proposition does not hold for surface-links. For instance, the surface-link constructed in (Case 5) of the proof of Theorem [1.5](#page-1-2) is P^2 -reducible even though the good involution is the half-antipodal map.

In the proof of Theorem [1.5,](#page-1-2) we construct an infinite family of 2-component P^2 -links F_n ($n \ge 1$). It follows from a direct computation that the knot group of F_n is the generalized quaternion group Q_n of order 8*n* whose group presentation is

$$
\langle a, b | a^{4k} = 1, b^2 = a^k, b^{-1}ab = a^{-1} \rangle
$$
,

where meridional loops of the components of F_n are represented by *b* and $b^{-1}a$, respectively. The orders of *b* and $b^{-1}a$ are four. It implies that F_n is P^2 -irreducible, and we have the following result:

Theorem 5.3. *There exists an infinite family of 2-component* P^2 *-irreducible* P^2 *-links.*

We notice that F_1 and F_2 are $8_1^{-1,-1}$ and $10_1^{-1,-1}$ in the list of [\[22\]](#page-11-14), respectively.
