# MONOGENIC  $S_3$ -CUBIC POLYNOMIALS AND CLASS NUMBERS OF ASSOCIATED QUADRATIC FIELDS

ABSTRACT. We say that a monic polynomial  $f(x) \in \mathbb{Z}[x]$  is monogenic if  $f(x)$ is irreducible over  $\mathbb Q$  and  $\{1,\theta,\theta^2,\ldots,\theta^{\deg f-1}\}$  is a basis for the ring of integers of  $\mathbb{Q}(\theta)$ , where  $f(\theta) = 0$ . In this article, we use a theorem due to Kishi and Miyake to give an explicit description of an infinite set  $\mathcal F$  of cubic polynomials  $f(x) \in \mathbb{Z}[x]$ , such that  $f(x)$  satisfies the three conditions:  $Gal_0(f) \simeq S_3$ , the class number of the unique quadratic subfield of the splitting field of  $f(x)$  is divisible by 3 and  $f(x)$  is monogenic. Moreover, if  $g(x)$  is any cubic polynomial satisfying these three conditions, then there exists a unique  $f(x) \in \mathcal{F}$  such that  $f(x)$  and  $g(x)$  generate the same cubic extension over  $\mathbb{Q}$ .

### <span id="page-0-0"></span>1. INTRODUCTION

We say that a monic polynomial  $f(x) \in \mathbb{Z}[x]$  is *monogenic* if  $f(x)$  is irreducible over  $\mathbb{Q}$  and  $\{1, \theta, \theta^2, \ldots, \theta^{\deg f-1}\}$  is a basis for the ring of integers of  $\mathbb{Q}(\theta)$ , where  $f(\theta) = 0$ . Hence,  $f(x)$  is monogenic if and only if  $\mathbb{Z}_K = \mathbb{Z}[\theta]$ . For the minimal polynomial  $f(x)$  of an algebraic integer  $\theta$  over Q, it is well known [\[1\]](#page-3-0) that

(1.1) 
$$
\Delta(f) = [\mathbb{Z}_K : \mathbb{Z}[\theta]]^2 \Delta(K),
$$

where  $\Delta(f)$  and  $\Delta(K)$  are the respective discriminants over  $\mathbb Q$  of  $f(x)$  and the number field K. Thus, from [\(1.1\)](#page-0-0),  $f(x)$  is monogenic if and only if  $\Delta(f) = \Delta(K)$ .

In 2000, Kishi and Miyake [\[5\]](#page-3-1) gave the following parameterization of the quadratic fields whose class numbers are divisible by 3:

<span id="page-0-1"></span>**Theorem 1.1.** Let  $u, w \in \mathbb{Z}$  with  $gcd(u, w) = 1$ , such that  $d := 4uw^3 - 27u^2$  is not *a square and one of the following sets of conditions holds:*

$$
f(x) := x^3 - uwx - u^2.
$$

*If*  $f(x)$  *is irreducible over*  $\mathbb{Q}$ *, then the roots of*  $f(x) = 0$  *generate an unramified cyclic cubic extension of the quadratic field*  $\mathbb{Q}(\sqrt{d})$ *. Conversely, every quadratic field* K *whose class number is divisible by 3 and every unramified cyclic cubic extension of* K *are given in this way by a suitable pair of integers* u *and* w*.*

In this article, we use Theorem [1.1](#page-0-1) to give an explicit description of an infinite set F of cubic polynomials  $f(x) \in \mathbb{Z}[x]$ , such that  $f(x)$  satisfies the three conditions:

f(x) \text{ is monogenic},
$$

where  $h_K$  is the class number of the unique quadratic subfield K of the splitting field of  $f(x)$ . Moreover, if  $g(x)$  is any cubic polynomial satisfying conditions [\(1.6\)](#page-1-0), then there exists a unique  $f(x) \in \mathcal{F}$  such that  $f(x)$  and  $g(x)$  generate the same cubic extension over  $\mathbb{Q}$ . Since Theorem [1.1](#page-0-1) characterizes cubic polynomials  $f(x)$ satisfying conditions (i) and (ii) of  $(1.6)$ , we can limit our search for cubic polynomials satisfying all three of the condition in  $(1.6)$  to the trinomials  $f(x)$  as defined in [\(1.5\)](#page-0-2) of Theorem [1.1.](#page-0-1) Our main theorem is as follows:

<span id="page-1-1"></span>Theorem 1.2. *Let* u*,* w *and* d *be integers that satisfy the conditions set forth in Theorem* [1.1,](#page-0-1) and let  $f(x)$  be as defined in [\(1.5\)](#page-0-2). Suppose that  $f(x)$  is irreducible *over* Q*. Then*

 is monogenic if and only if  $u = 1$  and d is squarefree.

*Furthermore, if* g(x) *is any cubic polynomial satisfying conditions* [\(1.6\)](#page-1-0)*, then there exists a unique trinomial in the infinite set*

(1.8) 
$$
\mathcal{F} = \{f(x) : u = 1 \text{ and } d \text{ is squarefree}\}
$$

*such that*  $f(x)$  *and*  $g(x)$  *generate the same cubic extension over*  $\mathbb{Q}$ .

## <span id="page-1-7"></span>2. Preliminaries

The theorem below is an adaptation of a theorem due to Jakhar, Khanduja and Sangwan [\[4,](#page-3-2) Theorem 1.1], which is used to determine the monogenicity of an irreducible trinomial, to the specific cubic trinomial  $f(x) = x^3 - uwx - u^2$ . We use the notation  $q^e \parallel W$  to mean that  $q^e$  is the exact power of the prime q that divides the integer W.

<span id="page-1-4"></span>**Theorem 2.1.** Let  $u, w \in \mathbb{Z}$  and let  $f(x) = x^3 - uwx - u^2$  be irreducible over  $\mathbb{Q}$ . *Let*  $K = \mathbb{Q}(\theta)$ *, where*  $f(\theta) = 0$ *, and let*  $\mathbb{Z}_K$  *denote the ring of integers of* K. A *prime factor*  $q$  *of*  $\Delta(f) = u^3(4w^3 - 27u)$  *does not divide*  $[\mathbb{Z}_K : \mathbb{Z}[\theta]]$  *if and only if*  $q$ *satisfies one of the following conditions:*

- <span id="page-1-5"></span><span id="page-1-3"></span>(1) when q | uw and q |  $u^2$ , then  $q^2 \nmid u^2$ ;
- (2) when  $q \mid uw$  and  $q \nmid u^2$ , then

*either*  $q | A_2 \text{ and } q \nmid B_1 \quad \text{or} \quad q \nmid A_2 \left( u^2 A_2^3 + B_1^3 \right),$ 

<span id="page-1-6"></span>*where*  $A_2 = -uw/q$  *and*  $B_1 = \frac{-u^2 + (u^2)^{qj}}{q}$  $\frac{q^{(u^2)^{q}}}{q}$  with  $q^j \mid | 3;$ (3) when  $q \nmid u^3w$ , then  $q^2 \nmid \Delta(f)$ .

# 3. Proof of Theorem [1.2](#page-1-1)

*Proof.* As previously mentioned, since  $f(x) = x^3 - uwx - u^2$  is irreducible over  $\mathbb{Q}$ , we have by Theorem [1.1](#page-0-1) that  $f(x)$  satisfies conditions (i) and (ii) of [\(1.6\)](#page-1-0). A straightforward calculation shows that

$$
\Delta(f) = 4u^3w^3 - 27u^4.
$$

We also note that replacing u with  $-u$  and w with  $-w$  in [\(1.5\)](#page-0-2) yields the same trinomial  $f(x)$ . Consequently, we can assume without loss of generality that  $u > 0$ .

We begin with the proof of  $(1.7)$ , and we assume first that  $f(x)$  is monogenic. Let q be a prime divisor of  $\Delta(f)$ , and suppose that  $f(\theta) = 0$ . If  $u > 1$ , then condition [\(1\)](#page-1-3) of Theorem [2.1](#page-1-4) is not satisfied for every prime divisor  $q$  of  $u$ ; in which case,  $q \mid [\mathbb{Z}_K : \mathbb{Z}[\theta]]$  and  $f(x)$  is not monogenic. Thus,  $u = 1$  so that

$$
f(x) = x^3 - wx - 1
$$
 and  $\Delta(f) = d = 4w^3 - 27$ .

Observe then from [\(3.1\)](#page-2-0) that  $f(x)$  is irreducible over Q if and only if  $w \notin \{0,2\}$  by the Rational Root Theorem.

If  $q = 3$ , then  $3 \mid w$  from  $(3.1)$ . From condition  $(2)$  of Theorem [2.1,](#page-1-4) we see that  $B_1 = 0$ , which implies that  $3 \nmid A_2$  since  $f(x)$  is monogenic. Hence, we have that  $w \equiv \pm 3 \pmod{9}$ . However, with  $u = 1$ , examining the two possibilities for w reveals that neither condition  $(1.3)$  nor condition  $(1.4)$  of Theorem [1.1](#page-0-1) can be satisfied. For example, if  $w \equiv -3 \pmod{9}$ , then  $uw \equiv -3 \not\equiv 3 \pmod{9}$ , but  $u - w \equiv 4 \not\equiv \pm 1 \pmod{9}$ . Thus,  $3 \nmid \Delta(f)$  and  $3 \nmid w$ , so that condition [\(1.2\)](#page-0-5) of Theorem [1.1](#page-0-1) holds. As a consequence, we have shown that no cubic trinomial  $f(x)$ of the form in  $(3.1)$  is monogenic when  $3 | w$ .

Suppose next that q is a prime divisor of d such that  $q^2 \mid d$ . By the previous discussion, we have that  $q \neq 3$  and  $q \nmid w$ . But then condition [\(3\)](#page-1-6) of Theorem [2.1](#page-1-4) is not satisfied, contradicting the fact that  $f(x)$  is monogenic. Hence, d is squarefree, which completes the proof in this direction.

Conversely, suppose that  $u = 1$  and d is squarefree. Let q be a prime divisor of  $\Delta(f)$ . Then, from [\(3.1\)](#page-2-0), conditions [\(1\)](#page-1-3) and [\(3\)](#page-1-6) of Theorem [2.1](#page-1-4) are easily seen to be satisfied. Suppose then that  $q \mid w$ . Then  $q = 3$  from [\(3.1\)](#page-2-0). Since  $q \nmid u$ , we have from condition [\(2\)](#page-1-5) of Theorem [2.1](#page-1-4) that  $A_2 = \pm w/3$ ,  $B_1 = 0$  and

$$
A_2\left(u^2A_2^3 + B_1^3\right) = \frac{w^4}{3^4} \not\equiv 0 \pmod{3},
$$

since  $d$  is squarefree, which completes the proof of  $(1.7)$ .

Next, let F be the set as defined in [\(1.8\)](#page-1-7). Then  $f(x)$  and  $\Delta(f)$  are as given in [\(3.1\)](#page-2-0). By [\(1.7\)](#page-1-2), the set  $\mathcal F$  consists of all cubic trinomials satisfying conditions [\(1.6\)](#page-1-0). We claim that this set is infinite. Let  $G(t) := 4t^3 - 27 \in \mathbb{Z}[t]$ . It is easy to verify that  $G(t)$  is irreducible over Q. Then, it follows from a result of Erdős [\[2\]](#page-3-3) that there exist infinitely many integers z such that  $G(z)$  is squarefree. (In fact, there exist infinitely many primes p such that  $G(p)$  is squarefree [\[3\]](#page-3-4).) Consequently, there exist infinitely many integers w such that d is squarefree, and hence,  $\mathcal F$  is infinite. Let

f_1(x) = x^3 - w_1x - 1
$$
 and  $f_2(x) = x^3 - w_2x - 1$ 

be elements of F such that  $f_1(x) \neq f_2(x)$  and  $K_i := \mathbb{Q}(\theta_i)$ , where  $f_i(\theta_i) = 0$ . To establish the next part of the theorem it is enough, by Theorem [1.1,](#page-0-1) to show that  $K_1 \neq K_2$ . Assume, by way of contradiction, that  $K_1 = K_2$ . Then, since  $f_i(x)$  is monogenic, we have that  $\Delta(f_i) = \Delta(K_i)$ , and so it follows from [\(1.1\)](#page-0-0) that

(3.2) 
$$
4w_1^3 - 27 = 4w_2^3 - 27.
$$

Since  $w_1 \neq w_2$ , it is easy to see that [\(3.2\)](#page-2-1) has no integer solutions, which completes the proof of the theorem. the proof of the theorem.

For  $|w| \leq 10$  $|w| \leq 10$  $|w| \leq 10$ , we give in Table 1 the values of w and d for trinomials  $f(x)$  in  $\mathcal F$  (from Theorem [1.2\)](#page-1-1), and the class numbers  $h_K$  of the unique quadratic subfield  $K = \mathbb{Q}(\sqrt{d})$  of the splitting field of  $f(x)$ .
