Structured Codes for Distributed Matrix Multiplication

Abstract

Our work addresses the well-known open problem of distributed computing of bilinear functions of two correlated sources A and B. In a setting with two nodes, with the first node having access to A and the second to B, we establish bounds on the optimal sum-rate that allows a receiver to compute an important class of non-linear functions, and in particular bilinear functions, including dot products ⟨A, B⟩, and general matrix products A⊺B over finite fields. The bounds are tight, for large field sizes, for which case we can derive the exact fundamental performance limits for all problem dimensions and a large class of sources. Our achievability scheme involves the design of non-linear transformations of A and B, which are carefully calibrated to work synergistically with the structured linear encoding scheme by Körner and Marton. The subsequent converse derived here, calibrates the Han-Kobayashi approach to yield a relatively tight converse on the sum rate. We also demonstrate unbounded compression gains over Slepian-Wolf coding, depending on the source correlations. In the end, our work derives fundamental limits for distributed computing of a crucial class of functions, succinctly capturing the computation structures and source correlations.

Our findings are subsequently applied to the practical master-workers-receiver framework, where each of N distributed workers has a bounded memory reflecting a bounded computational capability. By combining the above scheme with the polynomial code framework, we design novel structured polynomial codes for distributed matrix multiplication, and show that our codes can surpass the performance of the existing state of art, while also adapting these new codes to support chain matrix multiplications and information-theoretically secure computations.

I. INTRODUCTION

Basic functions like the dot product currently constitute the bulk of computational load in scientific computing, as they are omnipresent in applications that include convolution [\[3\]](#page-74-0), large linear transforms, matrix multiplication, Fourier transform approximations, and applications of quantum computing [\[4\]](#page-74-1) and machine learning, like linear regression and least squares models [\[3\]](#page-74-0).

With the advent of edge computing systems and massive parallelization techniques, modern distributed computing systems, e.g., MapReduce, and TeraSort, are being employed to tackle the computational demands of distributed matrix multiplication [\[5\]](#page-74-2). To minimize communication and computation costs, handle faulty nodes, and mitigate stragglers, schemes such as coded matrix

multiplication [\[6\]](#page-74-5), [\[7\]](#page-74-6), distributed gradient coding [\[8\]](#page-74-7)–[\[10\]](#page-74-8), and Lagrange coded computing [\[11\]](#page-74-9), [\[12\]](#page-74-10) have been designed. While large computational demands are distributed across multiple workers, the communication load incurred by parallel processing is indeed a big bottleneck.

A. Motivation and Overview

In this work, we solve a fundamental problem, that includes a very well-known class of nonlinear functions, particularly bilinear functions (in the type of dot products and matrix products) that are omnipresent. This problem is fundamental to many technological fields, such as edge and cloud computing [\[13\]](#page-74-11), and machine learning [\[14\]](#page-74-12). For distributed implementation, we often need prohibitive communication overhead, which is fundamentally intertwined with parallelization. Here we consider the classical problem of distributed computing of bilinear functions of two correlated sources, where we place emphasis on dot products and matrix products. We are indeed interested in structured data which are omnipresent in various applications. In this context, we consider, as in [\[15\]](#page-74-13)–[\[17\]](#page-74-14), two distributed sources, where the goal is to establish bounds on the optimal sum-rate that allows a receiver to compute these functions.

While prior works have thoroughly explored the fundamental limits of the achievable rate region for *distributed computing of linear functions* [\[16\]](#page-74-15)–[\[20\]](#page-74-16), to our knowledge, the fundamental rate limits for *distributed computing of non-linear functions*, including the special class of *bilinear functions*, remain an open problem. Furthermore, even if these limits exist for this more general problem, the required sum-rate can be as high as that needed to reliably reproduce the sources themselves [\[21\]](#page-74-17), with the achievable rate region given by Slepian-Wolf [\[17\]](#page-74-14).

The findings from the distributed computation of this class of bilinear functions can be applied to the practical master-workers-receiver framework, where each of N distributed workers has a bounded memory reflecting a bounded computational capability. To capture these constraints, most previous approaches (e.g., [\[6\]](#page-74-5), [\[7\]](#page-74-6), [\[22\]](#page-74-18)–[\[37\]](#page-75-0)) employ inner and outer product decompositions *to linearize the problem of distributed matrix multiplication*, as in the polynomial codes (Poly codes) scheme [\[6\]](#page-74-5) and its extensions (PolyDot codes) [\[7\]](#page-74-6), and *use channel coding techniques to mitigate stragglers*. Unlike [\[6\]](#page-74-5) and [\[7\]](#page-74-6), *we solve the same problem without linearizing it*, as we will detail below, as well as aiming to further reduce the communication costs of [\[6\]](#page-74-5) and [\[7\]](#page-74-6). This is possible by applying structured source coding techniques from [\[16\]](#page-74-15). To this end, we introduce structured PolyDot codes (StPolyDot codes), exploiting source coding to capture the structure of the function (that returns the matrix product) and channel coding to ensure reliable computation. However, overcoming stragglers is not the primary emphasis of our study.

B. Contributions

Our main contributions in this paper are summarized as follows:

• New structured source codes. We develop an encoding framework (Section [II\)](#page-7-0) for computing the (dot or matrix) product of two distributed source variables A and B (vectors or matrices), over finite fields. To this end, our achievability scheme involves the design of *non-linear transformations* of A and B (Section [III\)](#page-8-0), which are carefully calibrated to work synergistically with the structured linear encoding scheme by Körner and Marton [\[16\]](#page-74-15) for computing dot products (Section [III-A\)](#page-8-1), matrix-vector products (Section [III-B\)](#page-12-0), matrix products that are symmetric (Section [III-C\)](#page-13-0), and general square matrix products (Section [III-D\)](#page-14-0), all with vanishing error probability. We also explore recursive and nested applications of the dot product for distributed matrix multiplication (Section [III-E\)](#page-15-0).

Our distributed matrix multiplication scheme is flexible, adapting to any structural conditions on the source matrices. Specifically, for any given A and B, the receiver can recover the product A[⊺]B without imposing constraints on the source matrices.

- Achievable compression gains. Contrasting the achievable sum rates of structured codes in Section [III](#page-8-0) with state-of-the-art codes (e.g., [\[15\]](#page-74-13), [\[38\]](#page-75-1), [\[39\]](#page-75-2)) reveals significant gains in computing the dot product or matrix product of distributed sources A and B. These gains capture the nature of *the structure of the data* (see Corollary [1](#page-9-0) and Example [1\)](#page-14-1) and moderate under *weaker correlations* (see Corollary [2](#page-10-0) and Figure [4\)](#page-15-1).
- A converse. The lower bound derived here calibrates the Han-Kobayashi approach in [\[17\]](#page-74-14) to yield a relatively tight converse on the sum rate. We then upper bound the multiplicative gaps of our design from the optimal rates (Section [IV\)](#page-18-0), *without imposing structural assumptions on* A *and* B. We also demonstrate a matching converse for i.i.d. and uniformly distributed sources when the field size becomes large (see Propositions [11](#page-19-0) and [16](#page-21-0) in Section [IV\)](#page-18-0).
- New structured polynomial codes. Focusing on the bounded computational capabilities of distributed workers in the practical master-workers-receiver framework, we devise *structured polynomial codes* (StPolyDot codes), for distributed matrix multiplication (see Sections [V](#page-22-0) and [VI](#page-28-0) for *symmetric* and *general non-symmetric* matrix products, respectively). Unlike prior works, e.g., [\[6\]](#page-74-5) and [\[7\]](#page-74-6), which restrict preprocessing to purely linear operations on A and B, we consider carefully designed non-linear operations at the master node, which yield — without substantial additional computational load, which is indeed accounted for — a clear benefit because structured coding achieves significant savings in communication rate (over [\[6\]](#page-74-5) and [\[7\]](#page-74-6)), where the non-linear component in our approach ideally has a small dimension versus the linear one. StPolyDot codes enable *hybrid processing*, improving the tradeoff between the communication and computation costs, and revealing operating points where structured codes outperform unstructured ones. This flexibility allows designers to optimize polynomial implementations. Our design here represents the first application of structured coding from [\[16\]](#page-74-15) to solving a fundamental problem, that includes a very wellknown class of functions (in the type of dot products), a previously unexplored direction.
	- Storage. For distributed matrix multiplication, our StPolyDot encoding scheme can *reduce the required storage size per worker to half* (see Proposition [19](#page-28-1) in Section [V-D\)](#page-27-0) versus the state-of-the-art models (e.g., [\[6\]](#page-74-5) and [\[7\]](#page-74-6)) for coded distributed computation.
	- Communication cost. The StPolyDot scheme, through carefully designed non-linear operations, enables the assignment of lower dimensional polynomials to each worker, compared to linear schemes (e.g., [\[6\]](#page-74-5) and [\[7\]](#page-74-6)). *This approach can substantially lower the end-to-end communication cost — up to a factor of* 2 *— as compared to the case of linear codes* (see Proposition [20](#page-28-2) in Section [V-D\)](#page-27-0).
	- Computation cost. StPolyDot codes incur minimal computation overhead in the large memory parameter regime, as we indicate in Proposition [21](#page-28-3) in Section [V-D.](#page-27-0)
	- We similarly evaluate the complexities of StPolyDot codes for distributed computation of *general non-symmetric matrix products* (see Proposition [22](#page-28-4) in Section [VI\)](#page-28-0).
- Chain matrix multiplication. We generalize StPolyDot codes for distributed chain matrix multiplication A^TBC[™]D... involving N_c matrices (Section [VII\)](#page-29-0) using i) *a hierarchical method* that computes 2-matrix products, then hierarchically recovers the desired matrix product, and ii) *a recursive method* that allows the receiver to recover the matrix product, without revealing the intermediate 2-matrix products, providing a higher level of security.
- Secure distributed matrix multiplication. StPolyDot codes leverage structured coding (see [\[16\]](#page-74-15), [\[1\]](#page-74-3)) to enable the secure computation of A^TB at the receiver. The proposed

approach can be reinforced to meet the *information-theoretic security* constraint, i.e., without revealing anything about A and B when any up to ℓ workers collude (see Section [VIII\)](#page-31-0).

We take a non-real-time approach that relies on accumulating length n sequences of potentially correlated memoryless source matrices. Specifically, distributed sources are block-encoded with blocklength n, aiming to devise (n, ϵ) -coding schemes that approximate the desired matrix product with accuracy $1-\epsilon$, and achieve near-optimal rates, drawing on achievable rates for asymptotic lossless compression [\[16\]](#page-74-15). For practical blocklengths (e.g., [\[40\]](#page-75-3) and [\[41\]](#page-75-4)), approximate or lossy matrix multiplication can be performed by leveraging Kolmogorov complexity [\[42,](#page-75-5) Ch. 14].

We also briefly discuss some of the positive security ramifications of our structured coding approach. This feature arises directly from our structured encoding scheme, which builds on [\[16\]](#page-74-15), without imposing any structural constraints on the sources. However, this approach potentially requires a higher rate compared to [\[15\]](#page-74-13). While stragglers are not our primary focus, StPolyDot codes introduce a certain robustness to straggler effects. Further research is needed to quantify this robustness. StPolyDot codes naturally support *distributed implementations* (e.g., [\[43\]](#page-75-6)–[\[47\]](#page-75-7)), enabling the separate non-linear operations on A and B directly at distributed master nodes when the original source matrices are also distributed.

C. Related Work and Connections of Our Work to the State of the Art

We next review the current state of research on compression, coded computing, and distributed matrix multiplication schemes.

a) Coding for computing: Given two source variables X_1 and X_2 separately observed by two transmitters, Slepian and Wolf have provided an unstructured coding technique for the asymptotic lossless compression of X_1 and X_2 at the minimum rate needed, i.e., R_{SW}^{Σ} = $H_q(X_1, X_2)$ [\[15\]](#page-74-13). Han-Kobayashi [\[17\]](#page-74-14) have provided a characterization to determine whether computing a general bivariate function $f(X_1, X_2)$ of random sequences $\{X_{1i}\}\$ and $\{X_{2i}\}\$ from two correlated memoryless sources requires a smaller rate than $R_{\rm SW}^{\Sigma}$. Exploiting Körner's characteristic graph G_X and its entropy [\[48\]](#page-75-8), Orlitsky and Roche have derived a closed-form expression on the minimum number of bits at which source X has to compress for distributed computing of $f(X, Y)$ with side information Y with vanishing error at the receiver, and devised an unstructured coding scheme to achieve this minimum rate [\[49\]](#page-75-9). This scheme is equivalent to performing Slepian-Wolf encoding on the colors of the sufficiently large OR powers of G_X given Y [\[50\]](#page-75-10). Graph coloring-based techniques have extensively been devised for various computation scenarios, see e.g., [\[51\]](#page-75-11)–[\[56\]](#page-75-12). Inspired by characteristic graphs, codewords with function-dependent distances to correct computational errors have been devised in [\[57\]](#page-75-13). The general multiterminal lossy distributed source coding problem remains unsolved, despite the inner and outer bounds provided by Berger-Tung [\[58\]](#page-75-14), [\[59\]](#page-75-15). A notable special case is the lossy variant of [\[15\]](#page-74-13).

*b) Structured coding for computing: K*örner and Marton have devised a *structured encoding* strategy that minimizes the sum rate for distributed computing the modulo-two sum of doubly symmetric binary source (DSBS) sequences with a low probability of error [\[16\]](#page-74-15). Exploiting [\[16\]](#page-74-15), subspace-based lossless linear computation schemes using nested codes have been devised and shown to be sum-rate optimal for a class of source PMFs [\[20\]](#page-74-16). Ahlswede and Han showed that if the marginals are not uniform, there are achievable points outside the Körner-Marton region [\[60\]](#page-75-16), by tightening the rate region for general binary sources that embed the regions of [\[16\]](#page-74-15) and [\[15\]](#page-74-13). An outer bound which is strictly better than the cut-set bound in [\[60\]](#page-75-16) has been proposed in [\[61\]](#page-75-17). The rate region for this problem has been extended to a larger class of source PMFs beyond DSBS [\[62\]](#page-75-18), and for reconstructing the modulo-q sum $X_1 \oplus_q X_2$ [\[17,](#page-74-14) Lemma 5]. Furthermore, secure versions of Körner-Marton's scheme in [\[16\]](#page-74-15) have been contemplated in [\[63\]](#page-75-19) and [\[64\]](#page-75-20).

For possibly non-additive functions, in [\[17\]](#page-74-14), Han and Kobayashi have identified the function features that induced the difference between the Slepian-Wolf and Körner-Marton regions. For distributed source sequences (X_1^n, X_2^n) , Ahlswede and Csiszár have shown that for a decoder to determine a function $f(X_1^n, X_2^n)$ — including componentwise and binary-valued functions — for most functions, the separate encoders must have as large rates as if (X_1^n, X_2^n) were to be determined [\[21\]](#page-74-17). For a class of functions f including the joint type, the Hamming distance of X_1^n and X_2^n or just the parity of the Hamming distance, to determine $f(X_1^n, X_2^n)$ in the knowledge of X_2^n , the X_1 -encoder typically has as large a rate as for determining X_1^n itself, and that given a distortion criterion, an exact characterization of the achievable rate region for f (except for componentwise functions) may be as hard as determining the achievable rate region for reproducing X_1^n and X_2^n . For computing a non-linear function, the embedding of the function in a sufficiently large prime \mathbb{F}_q [\[38\]](#page-75-1), [\[39\]](#page-75-2), [\[65\]](#page-75-21), and finding an injective mapping between the function and $X_1 \oplus_q X_2$, known as *structured binning*, may provide savings over [\[15\]](#page-74-13). The rate-distortion characterization for structured coding has also been studied, e.g., the scenarios involving group codes (abelian or non-abelian) [\[66\]](#page-75-22)–[\[69\]](#page-75-23) that achieves a strictly bigger rate region than the Berger-Tung rate region, and lossy two-help-one distributed source coding [\[38\]](#page-75-1).

The problem of *interactive communication* with two terminals for computing has been studied in [\[70\]](#page-76-0), where interactions can exploit the structures of even non-trivial functions and data correlations, to achieve significant gains in minimum sum rate even for independent sources. Lossy interactive function computation has been studied in [\[71\]](#page-76-1). Relevant computation scenarios include interactive channel simulation [\[72\]](#page-76-2), [\[73\]](#page-76-3), common randomness generation [\[72\]](#page-76-2), interactive hypothesis testing against independence [\[74\]](#page-76-4), and distributed quantization networks [\[75\]](#page-76-5).

This paper builds on the foundational principles of structured codes and recent advances to develop distributed matrix multiplication techniques over finite fields. Building on our earlier work [\[1\]](#page-74-3), [\[2\]](#page-74-4), [\[76\]](#page-76-6), we demonstrate significant compression savings for matrix product computations compared to [\[15\]](#page-74-13). This is accomplished by applying the structured encoding scheme from [\[16\]](#page-74-15) to non-linear source mappings, utilizing a smaller field size than in [\[38\]](#page-75-1), [\[39\]](#page-75-2).

c) Coded distributed computing: Distributed computing plays an increasingly significant role in accelerating the execution of computationally challenging and complex computational tasks. This growth in influence is rooted in the innate capability of distributed computing to parallelize computational loads across multiple workers. This same parallelization renders distributed computing as an indispensable tool for addressing a wide array of complex computational challenges, spanning scientific simulations, extracting various spatial data distributions [\[77\]](#page-76-7), dataintensive analyses for cloud computing [\[13\]](#page-74-11), machine learning [\[14\]](#page-74-12), and medical applications [\[78\]](#page-76-8) to name just a few. In the center of this ever-increasing presence of parallelized computing, stand modern parallel processing techniques, such as MapReduce [\[79\]](#page-76-9), Hadoop [\[80\]](#page-76-10), and Spark [\[81\]](#page-76-11).

For distributed computing though to achieve the desirable parallelization effect, there is an undeniable need for massive information exchange from the various network nodes. Reducing this communication load is essential for scalability [\[82\]](#page-76-12)–[\[85\]](#page-76-13) in various topologies [\[86\]](#page-76-14)–[\[88\]](#page-76-15). Central to the effort to reduce communication costs, stand coding techniques such as those found in [\[7\]](#page-74-6), [\[8\]](#page-74-7), [\[11\]](#page-74-9), [\[31\]](#page-75-24), [\[89\]](#page-76-16)–[\[103\]](#page-76-17), including gradient coding [\[8\]](#page-74-7), and variants of coded distributed computing (CDC) that nicely yield gains in reliability, scalability, computation speed [\[93\]](#page-76-18), and reduce the communication load [\[96\]](#page-76-19). To that end, coded MapReduce [\[104\]](#page-76-20), and Lagrange coded computing [\[11\]](#page-74-9), [\[12\]](#page-74-10) techniques have been devised to reduce the communication cost in the presence of stragglers, and under privacy-security constraints. CDC has been applied to heterogeneous clusters [\[105\]](#page-76-21), distributed graph analytics [\[106\]](#page-77-0), federated learning scenarios [\[107\]](#page-77-1). Furthermore, coding constructions for the same tradeoff between computation and communication have been devised for a class of linear computation scenarios, including [\[108\]](#page-77-2), [\[109\]](#page-77-3), [\[110\]](#page-77-4).

d) Distributed matrix multiplication and codes: Coded matrix multiplication recasts matrix multiplication tasks on programmable processors into a computation channel. Numerous coding strategies have been developed to enhance distributed coded matrix multiplication, such as Short-Dot codes [\[111\]](#page-77-5) for distributed computing of large linear transforms, Poly codes [\[6\]](#page-74-5), PolyDot codes [\[7\]](#page-74-6), [\[22\]](#page-74-18), [\[23\]](#page-74-19), coded sparse matrix multiplication [\[24\]](#page-74-20), [\[25\]](#page-74-21). Low-weight encoding techniques have been devised in [\[28\]](#page-74-22), [\[29\]](#page-74-23) for distributed matrix-matrix multiplication with sparse input matrices, providing lower computational complexity per worker node versus the approaches, such as [\[6\]](#page-74-5), [\[27\]](#page-74-24). Extensions using algebraic function fields over finite fields (generalizing Poly and MatDot codes) have been explored in [\[26\]](#page-74-25) to improve straggler tolerance. The existing approaches transform matrix multiplication into inner or outer product computations, distributing subtasks across worker nodes. This decomposition enables efficient, linearly separable processing of rows and columns. For example, *Poly codes* [\[6\]](#page-74-5) are commonly used to mitigate stragglers and lower recovery thresholds, while *MatDot and PolyDot codes* [\[7\]](#page-74-6), [\[35\]](#page-75-25) improve security and reduce communication costs. Recent works emphasize further reductions in communication costs in distributed matrix multiplication (e.g., [\[7\]](#page-74-6), [\[31\]](#page-75-24), [\[35\]](#page-75-25), [\[37\]](#page-75-0), [\[103\]](#page-76-17), [\[108\]](#page-77-2), [\[112\]](#page-77-6)–[\[116\]](#page-77-7)).

To our knowledge, the existing techniques exploit channel coding methods to mitigate stragglers and enable security but do not incorporate coded distributed compression aspects. Structured source coding techniques*, as outlined in [\[16\]](#page-74-15), [\[38\]](#page-75-1), [\[39\]](#page-75-2), can be effectively incorporated into CDC frameworks to further reduce communication costs. These source coding techniques also enable fully distributed implementations at the master nodes with raw input matrices. In the current paper, building on [\[16\]](#page-74-15) and our preliminary work in [\[1\]](#page-74-3) that leverages the computation structure, we propose a distributed matrix multiplication framework at low communication cost.*

e) Security and privacy: In the context of distributed matrix multiplication, security and privacy are key aspects that have been extensively studied. For instance, the capacity of secure distributed matrix multiplication, which is the maximum possible ratio of the desired information and the total communication received from a set of distributed workers, has been derived in [\[30\]](#page-74-26). In [\[31\]](#page-75-24), the authors have investigated secure and private matrix multiplication, by linking privacy to the notion of private information retrieval (PIR) and perfect security to secret sharing schemes. In the presence of honest but curious workers, in [\[32\]](#page-75-26), [\[33\]](#page-75-27), Poly codes based on arithmetic progressions have been studied via building secure distributed matrix multiplication schemes. To build resilience to stragglers and enhance privacy, other approaches have considered the tradeoff between computation time and the privacy constraint [\[34\]](#page-75-28), or secure constructions for Poly and MatDot codes [\[35\]](#page-75-25), as well as for secure multi-party batch matrix multiplication [\[36\]](#page-75-29). In [\[5\]](#page-74-2), the authors have proposed an acceleration technique for generic matrix multiplication by trading off precision in a stochastic manner. Other generalizations incorporate heterogeneous systems, including flexible communication load [\[37\]](#page-75-0), multiple jobs with varying weights [\[117\]](#page-77-8), [\[118\]](#page-77-9), and queuing-based techniques for distributed function computation [\[119\]](#page-77-10), [\[120\]](#page-77-11).

We enhance our proposed distributed matrix multiplication framework to achieve informationtheoretic (perfect) security by employing a random matrix construction (see Section [VIII\)](#page-31-0). However, privacy concerns related to PIR (e.g., [\[31\]](#page-75-24)–[\[33\]](#page-75-27)) are beyond the scope of this work.

D. Organization

The rest of the paper is organized as follows. Section [II](#page-7-0) describes the distributed computation framework. Section [III](#page-8-0) details our novel *structured coding scheme for distributed matrix multiplication* that builds non-linear mappings from each source, then employs Körner and Marton's linear encoding scheme [\[16\]](#page-74-15). Exploiting this construction, we present achievable rates for computing dot products, matrix-vector products, symmetric and square matrix products, and contrast them with the existing approaches via analysis and numerical examples. We also explore recursive and nested implementations of dot products for computing general matrix products. Section [IV](#page-18-0) presents our *achievability and converse results*, and the *multiplicative gaps* over [\[17\]](#page-74-14).

Section [V](#page-22-0) describes the construction of StPolyDot codes, and analyze their end-to-end communication and computational complexities and recovery thresholds for distributed computation of symmetric matrices. Section [VI](#page-28-0) expands the StPolyDot code construction to general square matrix products. Section [VII](#page-29-0) considers *chain matrix multiplication*, using i) a hierarchical method to decompose this problem into multiple stages, where each stage focuses on pairwise matrix multiplications, and ii) a recursive approach to jointly encode all the source matrices. Section [VIII](#page-31-0) details information-theoretically secure StPolyDot codes. Section [IX](#page-32-0) contrasts StPolyDot codes with the state of the art (Poly [\[6\]](#page-74-5) and PolyDot codes [\[7\]](#page-74-6)), by numerically evaluating the tradeoff space between the communication and computational complexities and recovery thresholds. Section [X](#page-34-0) summarizes the utility of our approach, providing perspectives and future directions.

We provide the proofs of main results on distributed structured matrix multiplication in Appendices [A-A](#page-36-0)[-A-X,](#page-57-0) and a summary for various Poly code constructions and their generalizations in Appendices [B-A-](#page-60-0)[B-E.](#page-65-0) Appendices [C-](#page-66-0)[I](#page-72-0) detail the performance of StPolyDot codes.

E. Notation

We denote random variables in regular typeface, and vectors and matrices in boldface, with elements chosen from \mathbb{F}_q , where \mathbb{F}_q denotes a finite field of order $q \geq 2$. We denote the binary logarithm, and the logarithm in base $q > 2$, by log and log_q, respectively. Given variable X drawn from probability mass function (PMF) P_X , $H(X)$ and $H_q(X) = (1/\log_2 q)H(X)$ denote the entropies in binary and q-ary units, respectively. Similarly, given X_1 and X_2 , with a joint PMF P_{X_1,X_2} , $H_q(X_1, X_2)$ and $H_q(X_1 | X_2)$ denote the joint and conditional entropies, respectively. $h(\epsilon)$ denotes the binary entropy function for Bernoulli X with parameter $\epsilon \in [0, 1]$, i.e., $X \sim \text{Bern}(\epsilon)$. The PMF of a DSBS with disagreement probability $p \in (0, \frac{1}{2})$ $(\frac{1}{2})$, is denoted by $(X_1, X_2) \sim$ DSBS(p), where $X_1 \sim \text{Bern}(\frac{1}{2})$ $\frac{1}{2}$, and X_2 is the output of a binary symmetric channel with crossover probability p, i.e., BSC(p), given the input X_1 [\[121\]](#page-77-12) (see Table [I\)](#page-4-0). Notation \oplus_q denotes a modulo-q addition. $\mathbb{P}(A)$ is the probability of an event A, and $1_{x\in A} = 1$ if $x \in A$, and $1_{x\in A} = 0$ otherwise. The acronym i.i.d. stands for independent and identically distributed.

Given a random matrix $\mathbf{X} = (x_{ij})_{1 \le i \le m, 1 \le j \le l} \in \mathbb{F}_q^{m \times l}$, with elements $x_{ij} \in \mathbb{F}_q$, its *i*-th row and j-th column are given by $\mathbf{X}(i,:)$ and $\overline{\mathbf{X}}(i,j)$, respectively, and its transpose by $\overline{\mathbf{X}}^{\intercal}$. Alternatively, lowercase bold letters $\mathbf{x} = (x_i)_{1 \le i \le m} \in \mathbb{F}_q^{m \times 1}$ and $\mathbf{x} = (x_j)_{1 \le j \le l} \in \mathbb{F}_q^{1 \times l}$ denote column and row vectors, respectively. For a given $\mathbf{x} \in \mathbb{F}_q^{1 \times i}$ and for $1 \leq i < j \leq l$, $\mathbf{x}(i : j) = [x_i \quad x_{i+1} \quad \dots \quad x_j],$ and similarly for a column vector. We denote by [l] the set $\{1, \ldots, l\}$, for a given $l \in \mathbb{Z}^+$, and $[l_1, l_2]$ represents $\{l_1, \ldots, l_2\}$ for $l_1, l_2 \in \mathbb{Z}^+$ such that $l_1 \leq l_2$. The notations I_l and $0_{l \times l}$ represent $l \times l$ matrices of identity and all zeros, $\mathbf{1}_{1 \times l}$ and $\mathbf{1}_{l \times 1}$ denote length l row and column vectors of all ones, respectively, and $\mathbf{1}_l$ and $\mathbf{0}_l$ denote length l all-ones and all-zeros vectors, respectively, when the dimension is clear from the context. $X^n = (X_1, X_2, \ldots, X_n) \in \mathbb{F}_q^{n \times 1}$ denotes n independent copies of X, X^n denotes n independent copies of X, and $\mathbf{Z}^n(j) = (\mathbf{Z}_1(j), \ldots, \mathbf{Z}_n(j))$ denotes *n* independent copies of $\mathbf{Z}(j)$, where $\mathbf{Z}(j) \in \mathbb{F}_q$ is the j-th element of Z.

II. SYSTEM MODEL AND PROBLEM STATEMENT

We consider a distributed matrix multiplication system with a master node, N distributed workers, and a receiver node that seeks to compute a matrix product with the help of workers. We denote the set of workers by $\Omega = \{0, 1, \ldots, N-1\}$. The master node has access to the raw inputs (matrices) $A \in \mathbb{F}_q^{m_A \times m}$ and $B \in \mathbb{F}_q^{m_A \times m}$, where $q \ge 2$. It preprocesses A and B to obtain a collection of subfunctions, and assigns these subfunctions to the workers. The subfunctions are derived under a worker memory constraint parameter, which is expressed as $s = s_r s_c$, where s_r and s_c describe the split of input matrices in the number of rows and columns, respectively, where s specifies the storage constraint which amounts to a $\frac{1}{s}$ fraction of each input matrix **A** and B at each worker. The workers do post-processing on the subfunctions, produce computational output, and send them to the receiver node. However, the workers may struggle, and produce delayed or erroneous outputs. To determine the matrix product A[⊺]B, the receiver aggregates the outputs of a subset of successful workers. The minimum number of workers for the receiver to compute the desired computational output is known as the recovery threshold N_r .

We next describe the approach to the distributed computation of the matrix product A[⊺]B.

a) Master node: The master has access to the computational input matrices $A \in \mathbb{F}_q^{m_A \times m}$ and $\mathbf{B} \in \mathbb{F}_q^{m_A \times m}$, and performs linear preprocessing of A and B to obtain the following matrices:

$$
\tilde{\mathbf{A}}_i = f_{1i}(\mathbf{A}) \in \mathbb{F}_q^{\frac{m_A}{s_r} \times \frac{m}{s_c}}, \quad \tilde{\mathbf{B}}_i = f_{2i}(\mathbf{B}) \in \mathbb{F}_q^{\frac{m_A}{s_r} \times \frac{m}{s_c}}, \quad i \in \Omega,
$$
\n(1)

for each worker, where the linear preprocessing functions satisfy $f_{1i}: \mathbb{F}_q^{m_A \times m} \to \mathbb{F}_q^{\frac{m_A}{sr} \times \frac{m}{s_c}}$ and $f_{2i}: \mathbb{F}_q^{m_A \times m} \to \mathbb{F}_q^{\frac{m_A}{s_r} \times \frac{m}{s_c}}$, and $s_r, s_c \in \mathbb{Z}^+$ are such that $s_r s_c = s$. The entries of \tilde{A}_i and \tilde{B}_i are linear combinations of the entries of A and B, respectively, and restricted to be elements of \mathbb{F}_q . The master node then uses \tilde{A}_i and \tilde{B}_i to devise the subfunctions to be communicated to worker $i \in \Omega$, which are the following three polynomials evaluated at point x_i :

$$
\mathbf{p}_i(x_i) = \{p_i^{(1)}(x_i) \; , \; p_i^{(2)}(x_i) \; , \; p_i^{(3)}(x_i)\} \; . \tag{2}
$$

In implementations where the raw inputs A and B come from distributed master nodes, leverag-ing linear coding techniques, e.g., Körner-Marton's scheme [\[16\]](#page-74-15) and various generalizations [\[17\]](#page-74-14), [\[60\]](#page-75-16), [\[62\]](#page-75-18), to create $\{p_i(x_i)\}_{i\in\Omega}$ allows for hierarchical computations over networks. For this setup, the structured matrix multiplication model (from Section [III\)](#page-8-0), incorporating the scheme of [\[16\]](#page-74-15) to determine subfunctions, can be directly applied (as detailed in Section [V\)](#page-22-0).

b) *N worker nodes:* Worker $i \in \Omega$ receives the subfunctions [\(2\)](#page-7-1) of \tilde{A}_i and \tilde{B}_i , and performs post-processing, to produce a computational output given by

$$
p_i(x_i) = (p_i^{(1)}(x_i))^{\mathsf{T}} \cdot p_i^{(2)}(x_i) - p_i^{(3)}(x_i) \tag{3}
$$

If the worker is successful (no delay or error), it sends its computational output to the receiver.

The memory parameter s specifies a storage size constraint per worker, denoted by M_{scheme} , for a given coding scheme, e.g., M_{PolyDot} is the worker storage required for PolyDot codes [\[7\]](#page-74-6).

c) Receiver node: The receiver collects outputs from a subset of successful workers. Provided that the number of successful workers is at least N_r from the set of all workers Ω , the receiver, via post-processing, can decode the desired matrix product A^TB. Otherwise, the computation task is unsuccessful. Here we rely on a worst-case scenario such that the computational outputs from any N_r workers are sufficient to perform the desired task.

For the distributed computation framework consisting of a master node, worker nodes, and the receiver that aims to recover A[⊺]B, we first establish the theoretical foundations of the proposed structured codes (Sections [III-](#page-8-0)[IV\)](#page-18-0). We then introduce the StPolyDot coding strategy (Section [V\)](#page-22-0) and explore the tradeoffs among worker storage constraints (parameterized by s), end-to-end communication and computation costs, and the recovery threshold N_r .

III. STRUCTURED CODES FOR DISTRIBUTED MATRIX MULTIPLICATION

This section provides an overview of our structured coding approach for distributed matrix multiplication, building on [\[1\]](#page-74-3). Our approach extends the linear structured coding scheme of [\[16\]](#page-74-15), designed for asymptotic distributed lossless compression of $(X_1, X_2) \sim \text{DSBS}(p)$ to compute their modulo-two sum at the minimum sum rate, $2H(X_1 \oplus_2 X_2)$.

We consider a distributed coding scenario involving two correlated memoryless q -ary (with $q \ge 2$) sources and a receiver (shown in Figure [1\)](#page-8-2), where each source holds a matrix variable: A \in $\mathbb{F}_q^{m \times l}$ and $\mathbf{B} \in \mathbb{F}_q^{m \times l}$, respectively. These matrices represent statistically dependent finite alphabet sequences, with entries a_{ij} , b_{ij} , $i \in [m]$, $j \in [l]$. These sequences are i.i.d. across realizations, although dependence exists between corresponding elements a_{ij} and b_{ij} . The receiver's goal is to compute $\mathcal{D} = f(\mathbf{A}, \mathbf{B}) = \mathbf{A}^{\mathsf{T}} \mathbf{B} : \mathbb{F}_q^{m \times l} \times \mathbb{F}_q^{m \times l} \to \mathbb{F}_q^{l \times l}$. To accomplish this, we design a distributed encoding scheme that applies structured coding to non-linear source mappings.

Fig. 1: Distributed computation of $D = A^{\dagger}B$.

We first examine distributed dot product computation (Section [III-A\)](#page-8-1), applying the *linear structured coding* from [\[16\]](#page-74-15) to vector-wise embeddings of the sources, as well as a hybrid scheme that combines *structured coding* [\[16\]](#page-74-15) with the *unstructured coding* technique in [\[49\]](#page-75-9). In doing so, we identify regimes where the sum rate achieved is strictly below the necessary and sufficient rate to jointly recover (A, B) , given by $R_{SW}^{\Sigma} = H_q(A, B)$ [\[15\]](#page-74-13), enabling the receiver to recover their dot product without fully decoding (A, B) , thus meeting a security constraint^{[1](#page-8-3)}.

A. Distributed Computation of Dot Products of Sources

The distributed sources hold the even-length vector variables $\mathbf{A} = \begin{bmatrix} a_1 & a_2 & \dots & a_m \end{bmatrix}^\intercal \in \mathbb{F}_q^{m \times 1}$ and $\mathbf{B} = \begin{bmatrix} b_1 & b_2 & \dots & b_m \end{bmatrix}^\mathsf{T} \in \mathbb{F}_q^{m \times 1}$. We rewrite these random vectors as

$$
\mathbf{A} = \begin{bmatrix} \mathbf{A}_1 \\ \mathbf{A}_2 \end{bmatrix} \in \mathbb{F}_q^{m \times 1} \;, \quad \mathbf{B} = \begin{bmatrix} \mathbf{B}_1 \\ \mathbf{B}_2 \end{bmatrix} \in \mathbb{F}_q^{m \times 1} \;, \tag{4}
$$

with vector partitions $A_1, A_2, B_1, B_2 \in \mathbb{F}_q^{\frac{m}{2} \times 1}$. The receiver aims to compute the dot product $d = f(\mathbf{A}, \mathbf{B}) = \langle \mathbf{A}, \mathbf{B} \rangle$, a scalar map $\langle \cdot, \cdot \rangle : \mathbb{F}_q^{m \times 1} \times \mathbb{F}_q^{m \times 1} \to \mathbb{F}_q$. We next present an achievable

 $¹$ Although the security of the input matrices is partially ensured by exploiting [\[16\]](#page-74-15), information-theoretically secure distributed</sup> matrix multiplication can be realized (see Section [VIII\)](#page-31-0). However, guaranteeing such security is not the main focus of this paper.

coding scheme for distributed computing of $d = \langle \mathbf{A}, \mathbf{B} \rangle = \sum_{i=1}^{m} a_i b_i$ that applies the linear encoding scheme of Körner-Marton in $[16]$ to non-linear transformations from each source.

Proposition 1. (Distributed dot product computation.) *Given two sequences of random vectors* A and B of even length m, generated by two correlated memoryless $q \geq 2$ -ary sources, with *representations as in [\(4\)](#page-8-4), the following sum rate is achievable by the separate encoding of the sources for the receiver to recover* $d = \langle \mathbf{A}, \mathbf{B} \rangle$ *with a small probability of error:*

$$
R_{\text{KM}}^{\Sigma} = 2H_q(\mathbf{U}, \mathbf{V}, W) , \qquad (5)
$$

where $\mathbf{U} \in \mathbb{F}_q^{m/2 \times 1}$ and $\mathbf{V} \in \mathbb{F}_q^{m/2 \times 1}$ are vector variables, and $W \in \mathbb{F}_q$ is a random variable, *and they satisfy the following relations:*

$$
\mathbf{U} = \mathbf{A}_2 \oplus_q \mathbf{B}_1 ,
$$

\n
$$
\mathbf{V} = \mathbf{A}_1 \oplus_q \mathbf{B}_2 ,
$$

\n
$$
W = \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 .
$$
 (6)

Proof. See Appendix [A-A.](#page-36-0) For odd-length vectors, we refer the reader to Appendix [A-B.](#page-37-0) \Box

In the scheme of Proposition [1,](#page-9-1) the receiver, from the modulo-q additions U, V, and W, may not recover the input matrices A and B in their entirety, enabling a partially secure distributed computation of $d = \langle \mathbf{A}, \mathbf{B} \rangle$. In their seminal work [\[17\]](#page-74-14), Han and Kobayashi have provided the necessary and sufficient conditions for any achievable rate (R_1, R_2) for distributed computing of a function $f(A, B)$ to coincide with the Slepian-Wolf region [\[15\]](#page-74-13) characterized by

$$
R_1 \ge H_q(\mathbf{A} \mid \mathbf{B}), \quad R_2 \ge H_q(\mathbf{B} \mid \mathbf{A}), \quad R_1 + R_2 \ge H_q(\mathbf{A}, \mathbf{B}). \tag{7}
$$

For the distributed computation of $d = f(\mathbf{A}, \mathbf{B}) = \langle \mathbf{A}, \mathbf{B} \rangle$, conditions (3.1) and (3.11) from Lemmas 1 and 2 of Han and Kobayashi [\[17\]](#page-74-14) are satisfied, implying $R_1 \geq H_a(A | B)$ and $R_2 \geq H_q(\mathbf{B} \mid \mathbf{A})$, and thus $R_1 + R_2 \geq H_q(\mathbf{A} \mid \mathbf{B}) + H_q(\mathbf{B} \mid \mathbf{A})$. However, condition (3.13) from Lemma 3 of [\[17\]](#page-74-14) is not met. Therefore, by [\[17,](#page-74-14) Theorem 1], the minimum sum rate can be lower than that of [\[15\]](#page-74-13). We provide the relevant conditions from Han and Kobayashi [\[17\]](#page-74-14) in Lemma [5](#page-47-0) of Appendix [A-O,](#page-47-1) where the rate lower bounds are stated in [\(148\)](#page-47-2) and [\(149\)](#page-47-3).

To that end, we next provide an example under a specific PMF model for binary-valued sources (A, B) to show that our achievability result for computing $\langle A, B \rangle$ in Proposition [1](#page-9-1) does not coincide with [\(7\)](#page-9-2). We highlight that R_{KM}^{Σ} can be substantially less than R_{SW}^{Σ} .

Corollary 1. (Structured source vectors.) *Consider two sequences of two statistically dependent i.i.d. finite alphabet* $A \in \mathbb{F}_2^{m \times 1}$ *and* $B \in \mathbb{F}_2^{m \times 1}$ *with the following DSBS model (see Table [I\)](#page-4-0):*

$$
(a_{\frac{m}{2}+i}, b_i) \sim \text{DSBS}(p) , \quad (a_i, b_{\frac{m}{2}+i}) \sim \text{DSBS}(p) \text{ are } i.i.d. \text{ across } i \in \left[\frac{m}{2}\right]. \tag{8}
$$

For this asymmetric DSBS setting, the gain of the sum rate R_KM^Σ in [\(5\)](#page-9-3) for the encoding technique in Proposition [1](#page-9-1) over the sum rate $R_{\rm SW}^{\Sigma}$ for lossless compression of the sources is

$$
\eta = \frac{R_{\rm SW}^{\Sigma}}{R_{\rm KM}^{\Sigma}} = \frac{m(1 + h(p))}{2mh(p) + 2(1 - (1 - p)^m)} \ . \tag{9}
$$

Proof. See Appendix [A-C.](#page-38-0)

For the setting in Corollary [1,](#page-9-0) it is necessary from [\[17,](#page-74-14) Lemmas 1-2, and Theorem 1] that

 $R_1, R_2 \geq mh(p)$. Our scheme incurs $1 - (1 - p)^m$ additional bit per source versus this lower bound, approaching one as the length m of the dot product tends to infinity. From Corollary [1,](#page-9-0) the receiver can compute $\langle A, B \rangle$ without recovering (A, B) when $\eta > 1$. It also holds that

$$
\lim_{p \to 0} \eta = \infty , \quad \lim_{p \to 1} \eta = \frac{m}{2} , \quad \lim_{m \to \infty} \eta = \frac{1 + h(p)}{2h(p)} ,
$$
 (10)

where $\lim_{m\to\infty} \eta$ matches the gain for the model in [\[16\]](#page-74-15), which approaches infinity as $p \to \{0, 1\}$. We illustrate the gain η from Corollary [1](#page-9-0) given in [\(10\)](#page-10-1) as a function of (m, p) in Figure [2.](#page-10-2) The flat (yellow) line marks $\eta = 1$. The gain tends to infinity as $p \to 0$ and approaches $\frac{m}{2}$ as $p \to 1$, indicating that R_{KM}^{Σ} may be substantially less than the joint entropy of the sources for this special class of source PMFs. Additionally, we demonstrate that as $m \to \infty$ and $\eta \ge 1$.

Corollary [1](#page-9-0) only captures a restricted class of source vectors, with the asymmetric DSBS model in [\(8\)](#page-9-4), which is not needed to obtain $\langle A, B \rangle$. Proposition [1](#page-9-1) captures any possible correlation structure between $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times 1}$, for $q \geq 2$. When the sources lack the desired correlation, the rate required for secure product computation may approach or even exceed R_{SW}^{Σ} . To that end, now turn to a potentially more realistic scenario, where A and B exhibit elementwise correlation.

Corollary 2. (Source vectors with elementwise correlation.) *Consider two sequences of correlated source vectors* $A \in \mathbb{F}_2^{m \times 1}$ *and* $B \in \mathbb{F}_2^{m \times 1}$ *, with entries* $(a_i, b_i) \sim \text{DSBS}(p)$ *, i.i.d. across* $i \in [m]$. For this setting, the ratio of the sum rate R_{KM}^{Σ} given in [\(5\)](#page-9-3) for the encoding technique in Proposition [1](#page-9-1) over the sum rate $R_{\rm SW}^{\Sigma}$ for lossless compression of the source vectors is

$$
\eta = \frac{R_{\rm SW}^{\Sigma}}{R_{\rm KM}^{\Sigma}} \ge \frac{m(1 + h(p))}{m(1 + h(2p(1 - p))) + 2} \ . \tag{11}
$$

Proof. See Appendix [A-D.](#page-39-0)

It has been shown in [\[38\]](#page-75-1), [\[39\]](#page-75-2) that via embedding the non-linear function $d_k = a_k b_k$, where $a_k, b_k \in \mathbb{F}_q$, in a sufficiently large prime \mathbb{F}_q , the decoder can reconstruct $\tilde{\mathbf{d}}^n = \{a_k \oplus_q b_k\}_{k=1}^n$, and hence, compute $\mathbf{d}^n = \{a_k b_k\}_{k=1}^n$ with high probability. For instance, if a_k , $b_k \in \mathbb{F}_2$, we can reconstruct \mathbf{d}^n from $\tilde{\mathbf{d}}^n = \{a_k \oplus b_k\}_{k=1}^n$ using a sum rate of $R_{\rm S}^{\Sigma} = 2H(\mathbf{A} \oplus \mathbf{B})$.

Motivated by the notion of embedding in [\[38\]](#page-75-1), [\[39\]](#page-75-2), we next devise an achievability scheme for computing $\langle \mathbf{A}, \mathbf{B} \rangle$ for $q > 2$, where the key idea is to compress the vector-wise embeddings of the sources vectors A and B via employing the linear structured encoding scheme of [\[16\]](#page-74-15), in contrast to entry-wise embeddings that require a sum rate of $R_{\rm S}^{\Sigma}$ (cf. [\[38\]](#page-75-1) and [\[39\]](#page-75-2)).

Proposition 2. (Vector-wise embeddings for distributed computation of $d = \langle A, B \rangle$.) Let $\mathbf{A}, \ \mathbf{B} \in \mathbb{F}_q^{m \times 1}$ be two sequences of vectors generated by two correlated memoryless sources, *with* $q \geq 2$, and define $r = 2(q - 1)m + (m \mod 2)$. Linear distributed encoding of (possibly) *non-linear source mappings achieves the following sum rate to recover* $d = \langle A, B \rangle$ *at the receiver with a small probability of error:*

$$
R_{\rm SV}^{\Sigma} = \begin{cases} 2H\big(\{a_i \oplus_r b_i\}_{i \in [m]}, \bigoplus_{q} a_i^2 \oplus_q b_i^2\big), & q > 2, \quad m \ge 1, \\ 2H\big(\{a_i \oplus_2 b_i\}_{i \in [m]}, \sum_{i \in [m]} a_i \oplus_r b_i\big), & q = 2, \quad m > 1, \\ 2H(a \oplus_3 b) = R_{\rm S}^{\Sigma}, & q = 2, \quad m = 1. \end{cases}
$$
(12)

Proof. See Appendix [A-E.](#page-39-1)

We next describe a hybrid encoding scheme that relies on *Körner's characteristic graphs* [\[48\]](#page-75-8) for computing general bivariate functions in the presence of side information. For detailed descriptions of characteristic graphs and their entropies, we refer the reader to [\[50\]](#page-75-10), [\[52\]](#page-75-30), [\[54\]](#page-75-31).

Proposition 3. (Hybrid encoding for distributed computation of $d = \langle A, B \rangle$.) Let $A, B \in$ $\mathbb{F}_q^{m \times 1}$ be two sequences of vectors generated by correlated memoryless sources, with $q \geq 2$. *A hybrid encoding scheme combining structured coding with unstructured coding achieves the following sum rate for recovering* $d = \langle \mathbf{A}, \mathbf{B} \rangle$ *at the receiver with a small probability of error:*

$$
R_{\text{KM}-\text{OR}}^{\Sigma} = 2H_q(\mathbf{Y}) + H_{G_{\mathbf{A}}}(\mathbf{A} | \mathbf{Y}) . \tag{13}
$$

Proof. If $Y = A \oplus_q B$ is available at the receiver as side information, then $\langle A, B \rangle = A^{\dagger} (Y - A)$ mod q. Exploiting [\[48\]](#page-75-8), the minimum compression rate of A for computing $g(A, Y)$ given side information Y is equal to the *conditional characteristic graph entropy* $H_{G_{\bf A}}({\bf A} | {\bf Y})$, as established by Orlitsky and Roche [\[49\]](#page-75-9). To achieve this, we employ a hybrid coding scheme: first, the structured coding scheme of Körner-Marton [\[16\]](#page-74-15) is used to compute \bf{Y} , followed by the unstructured coding model of Orlitsky-Roche [\[49\]](#page-75-9), which utilizes orthogonal binning of vertex colorings corresponding to the source characteristic graph $G_{\mathbf{A}}$, to compute $g(\mathbf{A}, \mathbf{Y})$. This hybrid method, which facilitates non-linear encoding for non-linear source mappings, achieves [\(13\)](#page-11-0). \Box

When Y = B, the hybrid approach in Proposition [3](#page-11-1) requires a rate of $R_{\text{KM}-OR}^{\Sigma}(\mathbf{B}) = H_q(\mathbf{B}) +$ $H_{G_{\mathbf{A}}}(\mathbf{A} | \mathbf{B})$, which is smaller than R_{SW}^{Σ} because $H_{G_{\mathbf{A}}}(\mathbf{A} | \mathbf{B}) \leq H_q(\mathbf{A} | \mathbf{B})$ [\[49\]](#page-75-9).

In Figure [3,](#page-12-1) for binary source vector sequences, i.e., entries from \mathbb{F}_2 , we contrast the sum rate performance of Proposition [1,](#page-9-1) with a corresponding sum rate $R_{\text{KM}}^{\Sigma} = 2H(\mathbf{U}, \mathbf{V}, W)$, and Proposition [2,](#page-11-2) which uses vector-wise embeddings of source sequences with a sum rate $R_{\rm SV}^{\Sigma}$ given in [\(12\)](#page-11-3), for the distributed computation of dot products $\langle \mathbf{A}, \mathbf{B} \rangle$, where $\mathbf{A}, \mathbf{B} \in \mathbb{F}_2^{m \times 1}$, with a small probability of error. This comparison includes the Slepian-Wolf scheme with sum rate $R_{\text{SW}}^{\Sigma} = H(\mathbf{A}, \mathbf{B})$, and the characteristic graph-based approach with sum rate $R_{\text{KM}-OR}^{\Sigma}(\mathbf{B}) =$ $H(\mathbf{B})+H_{G_{\mathbf{A}}}(\mathbf{A} | \mathbf{B})$, assuming B is available as side information at the receiver. We also provide a lower bound for computing $\langle \mathbf{A}, \mathbf{B} \rangle$, given by $R_f = H(\langle \mathbf{A}, \mathbf{B} \rangle)$.

In Figure [3-](#page-12-1)(Left), we use the PMF in Corollary [1](#page-9-0) for $m = 2$, i.e., $(a_1, b_2) \sim \text{DSBS}(p)$, and $(a_2, b_1) \sim \text{DSBS}(p)$. We do not indicate $R^{\Sigma}_{\rm S}$ and $R^{\Sigma}_{\rm KM-OR}$, which perform poorly versus $R^{\Sigma}_{\rm SV}$. R_{KM}^{Σ} and R_{SV}^{Σ} of [\(12\)](#page-11-3) perform well at low p and high p, respectively. R_{KM}^{Σ} is small at low p, and converges to R_f at low p, and to R_{SW}^{Σ} as p tends to 1, along with other techniques shown.

In Figure [3-](#page-12-1)(Middle), we use $m = 1$, where $(a, b) \sim \text{DSBS}(p)$. We indicate $R_{\rm S}^{\Sigma} = 2H(a \oplus_3 b)$, which models the sum rate required to compute $\langle a, b \rangle = a \cdot b$ by embedding the source variables

in \mathbb{F}_3 . We also illustrate $R_{\text{KM}-OR}^{\Sigma}$ from [\(13\)](#page-11-0) that sequentially implements the linear coding scheme of Körner-Marton to recover $a \oplus_2 b$, followed by the side information scheme of Orlitsky-Roche for computing $\langle a, b \rangle = a \cdot b$. At low p values, $R_{\text{KM}-OR}^{\Sigma}$ and R_{SW}^{Σ} converge to $R_{\text{f}} = H(\langle a, b \rangle)$, whereas R_S^{Σ} performs poorly. For large values of p, structured coding yields low R_S^{Σ} and $R_{\text{KM}-\text{OR}}^{\Sigma}$.

In Figure [3-](#page-12-1)(Right), we use $m = 2$, and the pairs (a_1, b_1) and (a_2, b_2) are DSBSs, each with a crossover probability p. We also indicate $R_{\text{KM}-OR}^{\Sigma}$ given in [\(13\)](#page-11-0) that captures the sequential implementation of the scheme of [\[16\]](#page-74-15) to recover $Y = A \oplus_2 B$, followed by the side information scheme of [\[49\]](#page-75-9) for computing $\langle \mathbf{A}, \mathbf{B} \rangle$. The rate R_{KM}^{Σ} exceeds R_{SW}^{Σ} and is omitted. Building on Proposition [1,](#page-9-1) we later present another construction in Proposition [13,](#page-20-0) which achieves an improved $R_{\text{KM}_1}^{\Sigma}$ Similarly, R_{SV}^{Σ} is higher than $R_{\text{KM}-\text{OR}}^{\Sigma}$, and is not indicated. For any given p value, $R_{\rm S}^{\Sigma} < R_{\rm SW}^{\Sigma}$, and $R_{\rm KM-OR}^{\Sigma}$ approaches $R_{\rm f} = H(\langle \mathbf{A}, \mathbf{B} \rangle)$ for small and large p.

Next, we examine a specific case, namely the distributed matrix-vector multiplication problem.

B. Distributed Computation of Matrix-Vector Product

Given a setup with a matrix variable $A \in \mathbb{F}_2^{m \times l}$ and a vector variable $b \in \mathbb{F}_2^{m \times 1}$, respectively, we propose an achievable coding scheme for distributed computation of $\mathbf{d} = \mathbf{A}^\intercal \mathbf{b} \in \mathbb{F}_q^{l \times 1}$.

Proposition 4. Given two sequences of random vectors $A \in \mathbb{F}_q^{m \times l}$ and $b \in \mathbb{F}_q^{m \times 1}$ generated *by two correlated memoryless* q*-ary sources, where* q ≥ 2*, with representations for even* m and $l > 1$, with row-block matrix partitions \mathbf{A}_1 , $\mathbf{A}_2 \in \mathbb{F}_q^{\frac{m}{2} \times l}$, and row-block vector partitions **. For this scheme, the following sum rate is achievable by the separate encoding** *of the sources for the receiver to recover* $d = A^Tb$ *with a small probability of error:*

$$
R_{\text{KM}}^{\Sigma} = 2H_q(\mathbf{U}, \mathbf{V}, \mathbf{W}) \tag{14}
$$

where $\mathbf{U} = \mathbf{A}_2 \oplus_q \mathbf{b}_1 \mathbf{1}_{1 \times l} \in \mathbb{F}_q^{m/2 \times 1}$ and $\mathbf{V} = \mathbf{A}_1 \oplus_q \mathbf{b}_2 \mathbf{1}_{1 \times l} \in \mathbb{F}_q^{m/2 \times 1}$ are vector variables, and $\mathbf{W} = \mathbf{A}_{2}^{\mathsf{T}} \mathbf{A}_{1} \oplus_{q} \mathbf{1}_{l \times 1} \mathbf{b}_{1}^{\mathsf{T}} \mathbf{b}_{2} \mathbf{1}_{1 \times l} \in \mathbb{F}_{q}^{l \times l}$ is a matrix variable.

Proof. The proof follows similar lines to the Proof of Proposition [1.](#page-9-1) See Appendix [A-F.](#page-40-0) \Box

Next, we explore a particular case, where the resulting computation yields a symmetric matrix.

C. Distributed Computation of Symmetric Matrices

Symmetric matrices (e.g., adjacency, Hessian, and covariance) are fundamental, particularly in machine learning, optimization, and signal processing. Given distributed sources $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times l}$, for $q > 2$ and $l \geq 1$, we next consider distributed computing of $\mathcal{D} = A^{T}B = (d_{ij}) \in \mathbb{F}_q^{l \times l}$, which is a symmetric matrix, implying that $d_{ji} = d_{ij}$ for each $i, j \in [l]$.

Proposition 5. (Computing symmetric matrices via distributed multiplication.) *Given two sequences of random matrices* A *and* B*, with representations*

$$
\mathbf{A} = \begin{bmatrix} \mathbf{A}_1 \\ \mathbf{A}_2 \end{bmatrix} \in \mathbb{F}_q^{m \times l} \;, \quad \text{and} \quad \mathbf{B} = \begin{bmatrix} \mathbf{B}_1 \\ \mathbf{B}_2 \end{bmatrix} \in \mathbb{F}_q^{m \times l} \;, \tag{15}
$$

generated by two correlated memoryless q-ary sources, respectively, where $A_1, A_2, B_1, B_2 \in$ $\mathbb{F}_q^{m/2 \times l}$ and $q > 2$, the achievable sum rate by the separate encoding of the sources for the *receiver to recover the symmetric matrix* $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$ with vanishing error is given as

$$
R_{\text{KM}}^{\Sigma} = 2H_q(\mathbf{U}, \mathbf{V}, \mathbf{W}) \tag{16}
$$

where $\mathbf{U} \in \mathbb{F}_q^{m/2 \times l}$, $\mathbf{V} \in \mathbb{F}_q^{n/2 \times l}$, and $\mathbf{W} \in \mathbb{F}_q^{l \times l}$ are matrix variables that satisfy

$$
\mathbf{U} = \mathbf{A}_2 \oplus_q \mathbf{B}_1 \in \mathbb{F}_q^{m/2 \times l} , \quad \mathbf{V} = \mathbf{A}_1 \oplus_q \mathbf{B}_2 \in \mathbb{F}_q^{m/2 \times l} ,
$$

$$
\mathbf{W} = \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \in \mathbb{F}_q^{l \times l} .
$$
(17)

Proof. See Appendix [A-G.](#page-40-1)

In Proposition [5,](#page-13-1) as in Proposition [1,](#page-9-1) the receiver can recover only U, V, and W, but not A and B in their entirety, enabling partially secure distributed compression of the sources.

In Figure [4-](#page-15-1)(Left), we showcase the sum rates R_{KM}^{Σ} and R_{SW}^{Σ} versus p (in log scale) for distributed computing of symmetric matrices $\mathcal{D} = A^{\dagger}B = B^{\dagger}A$ for $q = 2$ under two assumptions: (a) $A_1^{\mathsf{T}}B_1 = B_1^{\mathsf{T}}A_1$, i.e., $W = 0_{l \times l}$, and (b) $A_2^{\mathsf{T}}A_1 = B_1^{\mathsf{T}}B_2$. Exploiting the symmetry,

$$
\begin{aligned} \mathbf{U}^\intercal \mathbf{V} & = (\mathbf{A}_2 \oplus_2 \mathbf{B}_1)^\intercal \cdot (\mathbf{A}_1 \oplus_2 \mathbf{B}_2) \\ & \stackrel{(a)}{=} \mathbf{A}_2^\intercal \mathbf{A}_1 \oplus_2 \mathbf{A}_2^\intercal \mathbf{B}_2 \oplus_2 \mathbf{A}_1^\intercal \mathbf{B}_1 \oplus_2 \mathbf{B}_1^\intercal \mathbf{B}_2 \stackrel{(b)}{=} \mathbf{A}_1^\intercal \mathbf{B}_1 \oplus_2 \mathbf{A}_2^\intercal \mathbf{B}_2 = \boldsymbol{\mathcal{D}} \;, \end{aligned}
$$

ensuring a rate gain of $\eta = R_{\rm SW}^{\Sigma}/R_{\rm KM}^{\Sigma}$ that grows exponentially fast, as p tends to $\{0, 1\}$. For $q > 2$, Proposition [5](#page-13-1) guarantees the recovery of A^TB without assumptions (a) and (b).

We next provide a necessary condition for the receiver to successfully recover $D = A^TB$ for symmetric $\mathcal{D} \in \mathbb{F}_q^{l \times l}$ (see Section [III-D](#page-14-0) for the non-symmetric case), failing to recover A and B in their entirety ($\eta > 1$). This is more general than the elementwise DSBS model of Corollary [2.](#page-10-0)

Proposition 6. (A necessary condition for achieving η > 1 over [\[15\]](#page-74-13).) *Given two sequences* of matrices $A, B \in \mathbb{F}_q^{m \times l}$, for distributed computation of symmetric $\mathcal{D} = A^TB$, the condition

$$
H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B}) + H_q(\mathbf{U} , \mathbf{V} | \mathbf{A}^{\mathsf{T}}\mathbf{B}) < H_q(\mathbf{A} | \mathbf{U} , \mathbf{V} , \mathbf{A}^{\mathsf{T}}\mathbf{B}) ,
$$
 (18)

where $U, V \in \mathbb{F}_q^{m/2 \times l}$ are defined in [\(6\)](#page-9-5) and [\(17\)](#page-13-2) for $l = 1$ and $l > 1$, respectively, ensures the *sum rates for distributed computation of* $\langle A, B \rangle$ *in [\(5\)](#page-9-3), given q ≥ 2, and* A^TB *in [\(16\)](#page-13-3), given* $q > 2$, to be less than the achievable sum rate R_{SW}^{Σ} of [\[15\]](#page-74-13).

Proof. [\(18\)](#page-13-4) follows from the expansions of R_{KM}^{Σ} [\(124\)](#page-42-0) and R_{SW}^{Σ} [\(125\)](#page-42-1) in Appendix [A-H.](#page-41-0) \Box

From the expansion of R_{KM}^{Σ} (provided in [\(124\)](#page-42-0) of Appendix [A-H\)](#page-41-0)), it is evident that R_{KM}^{Σ} = $2H_q(\mathbf{A}^\intercal \mathbf{B})$ is achievable when $H_q(\mathbf{U}, \mathbf{V} \mid \mathbf{A}^\intercal \mathbf{B}) = 0$ in [\(18\)](#page-13-4). This condition implies $H_q(\mathbf{A}^\intercal \mathbf{B})$ < $H_q(A | U, V, A^TB)$, making it feasible to compute the symmetric matrix product A[†]B while keeping the receiver oblivious to both A and B. However, for general and potentially non-structured input PMFs, the condition in [\(18\)](#page-13-4) may not hold. In such cases, the Körner-Marton scheme from [\[16\]](#page-74-15) might require the encoders to operate at a rate $R_{\text{KM}}^{\Sigma} > R_{\text{SW}}^{\Sigma}$ to compute $\mathbf{A}^{\dagger} \mathbf{B}$,

D. Distributed Computation of Square Matrix Products

still ensuring that A and B are not fully disclosed to the receiver.

Given distributed sources $A, B \in \mathbb{F}_q^{m \times l}$, for $q > 2$ and $l, m > 1$, we here consider an achievable distributed encoding scheme of A and B for the distributed computation of a square matrix product $\mathcal{D} = A^{\dagger}B = (\tilde{d}_{ij}) \in \mathbb{F}_q^{l \times l}$, where $\mathcal D$ is non-symmetric, generalizing Proposition [5.](#page-13-1)

Proposition 7. (Distributed computation of square matrix products.) *Given two sequences* of random matrices $A \in \mathbb{F}_q^{m \times l}$ and $B \in \mathbb{F}_q^{m \times l}$ generated by two correlated memoryless q-ary *sources, with* q > 2*, the following sum rate is achievable by the separate encoding of the sources* for the receiver to recover a general square matrix $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$ with vanishing error:

$$
R_{\text{KM}}^{\Sigma} = 2H_q(\{\mathbf{A} \oplus_q \tilde{\mathbf{B}}_j\}_{j=1}^l, \{\tilde{\mathbf{A}}_j^{\mathsf{T}}\tilde{\mathbf{A}}_j\}_{j=1}^l),
$$
\n(19)

where $\tilde{\bf A}_j^{\intercal} \tilde{\bf A}_j = {\bf A}^{\intercal} {\bf A} \oplus_q \tilde{\bf B}_j^{\intercal} \tilde{\bf B}_j$ for $j \in [l]$, where $\tilde{\bf B}_j = {\bf B}_j {\bf 1}_{1 \times l} \in \mathbb{F}_q^{m \times l}$ are matrix variables, $\mathbf{1}_{1 \times l}$ is a row vector of all ones, and $\mathbf{B} = \begin{bmatrix} \mathbf{B}_1 & \mathbf{B}_2 & \dots & \mathbf{B}_l \end{bmatrix}$ with $\mathbf{B}_j \in \mathbb{F}_q^{m \times 1}$ for $j \in [l]$.

Proof. We refer the reader to Appendix [A-I.](#page-42-2)

For distributed computation of $\mathcal{D} = f(A, B) = A^{T}B$, condition (3.1) in Lemma 1 and condition (3.11) in Lemma 2 in [\[17\]](#page-74-14) are satisfied. Hence, the following conditions must hold:

$$
R_1 \ge H_q(\mathbf{A} \mid \mathbf{B}) \;, \quad R_2 \ge H_q(\mathbf{B} \mid \mathbf{A}) \;.
$$

Viewing each element of $A^{\dagger}B$ as a dot product, it is easy to see that $A^{\dagger}B$ satisfies the same conditions of [\[17\]](#page-74-14) as a dot product does (Section [III-A\)](#page-8-1). The lower bound in [\(20\)](#page-14-2) indicates that for i.i.d. valued sources that are independent of each other, $R_1 + R_2 \ge lm + lm = 2lm = R_{SW}^{\Sigma}$. In the case of elementwise correlation where $(a_{ij}, b_{ij}) \sim \text{DSBS}(p)$, $i \in [m]$, $j \in [l]$, note that $R_1 + R_2 \geq lmh(p) + lmh(p) = 2lmh(p)$, and $R_{SW}^{\Sigma} = lm(1 + h(p))$. Therefore, from [\[17,](#page-74-14) Theorem 1], the minimum sum rate for distributed computing of $f(\mathbf{A}, \mathbf{B})$ can be less than R_{SW}^{Σ} .

To demonstrate the performance of Proposition [7,](#page-14-3) we next consider an example.

Example 1. (Computing a non-symmetric matrix product of structured sources.) *Consider matrices* **A**, **B** ∈ $\mathbb{F}_3^{m \times 2}$, where the entries of **A** are $a_{ij} \sim (\frac{1}{2} - \epsilon, 2\epsilon, \frac{1}{2} - \epsilon)$, for $i \in [m]$ and $j \in \{1,2\}$, *i.i.d.* across i for some $\epsilon \in [0, \frac{1}{2}]$ 2 *. The entries of* B *are defined such that* $b_{i1} = b_{i2} = -a_{i2}$. Furthermore, the joint PMF of (a_{i1}, b_{i1}) is given by:

$$
P_{a_{i1},b_{i1}} = \begin{bmatrix} (\frac{1}{2} - \epsilon)(1-p) & (\frac{1}{2} - \epsilon)p & 0\\ 2\epsilon p & 0 & 2\epsilon(1-p)\\ 0 & (\frac{1}{2} - \epsilon)(1-p) & (\frac{1}{2} - \epsilon)p \end{bmatrix} .
$$
 (21)

The sum rate for distributed encoding of (A, B) *is given as [\[15\]](#page-74-13)*

$$
R_{\rm SW}^{\Sigma} = m(h(2\epsilon) + (1 - 2\epsilon) + h(p)). \tag{22}
$$

$$
\Box
$$

Exploiting Proposition [7,](#page-14-3) to compute $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_3^{2 \times 2}$, we can achieve a sum rate of

$$
R_{\text{KM}}^{\Sigma} \le 2mh \left(2\left(\frac{1}{2} - \epsilon\right)(1 - p) + 2\epsilon(1 - p), \ 2\left(\frac{1}{2} - \epsilon\right)p + 2\epsilon p \right) + 2\log_2(3) \ . \tag{23}
$$

For the details of the results in Example [1,](#page-14-1) we refer the reader to Appendix [A-J.](#page-43-0)

For the joint PMF in Example [1,](#page-14-1) with $\epsilon = 0.2$, in Figure [4-](#page-15-1)(Right), we demonstrate the sum rate performance of Proposition [7](#page-14-3) (in log scale) versus p via contrasting the sum rates $R_{\text{SW}}^{\Sigma} = H(\mathbf{A}, \mathbf{B})$ and R_{KM}^{Σ} in [\(19\)](#page-14-4). The gain η increases exponentially as p approaches $\{0, 1\}$.

For the case of $q \geq 2$, we next propose two achievability schemes that rely on the recursive implementation of distributed dot product computation devised in Proposition [1.](#page-9-1) We refer the reader to Proposition [8](#page-15-2) for general non-symmetric matrices, and Proposition [10](#page-17-0) for symmetric matrices, respectively. Exploiting the schemes given in Propositions [5](#page-13-1) and [7,](#page-14-3) in Proposition [9,](#page-16-0) we recursively apply dot products to compute symmetric matrix products for $q > 2$.

E. Recursive Application of Dot Product to Distributed Computation of General Matrices

In this part, we focus on various recursive implementations of Proposition [1](#page-9-1) to be able to address the case of $q \geq 2$. To that end, we next consider *a recursive application of the distributed dot product computation technique* in Proposition [1](#page-9-1) to solve general matrix products $D = A^TB$, where \bf{A} and \bf{B} are generated by two correlated memoryless q -ary sources, respectively, with $q \geq 2$, and demonstrate the sum rate needed for this recursive approach.

Proposition 8. (Recursive application of dot products to compute general matrix products.) Given two sequences of random matrices $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times l}$ generated by correlated memoryless q -ary sources ($q \geq 2$ and even *l*), a recursive application of the distributed dot product method *in Proposition [1](#page-9-1) achieves a sum rate allowing the receiver to recover a general, possibly nonsymmetric matrix* $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$, with vanishing error, which is given as:

$$
R_{\rm KM}^{\Sigma} = 2H_q(\{\mathbf{U}_{ij}, \mathbf{V}_{ij}, W_{ij}\}_{i \in [l], j \in [l]} : i \leq j), \qquad (24)
$$

where the definitions of $\{U_{ij}, V_{ij}, W_{ij}\}$ *are given in [\(131\)](#page-44-0).*

Proof. See Appendix [A-K.](#page-43-1)

With the *recursive implementation of the dot product-based method* in Proposition [1,](#page-9-1) Propo-sition [8](#page-15-2) suggests that given $i \neq i'$ and $j \neq j'$, the knowledge of the sets $\{U_{ij}, U_{i'j}, U_{ij'}\}$, $\{ \mathbf V_{ij}^{\intercal}, \mathbf V_{i'}^{\intercal}$ $\{ \overline{V}_{i'j}, \overline{V}_{ij'}^T \}$, and $\{ W_{ij}, W_{i'j}, W_{ij'} \}$ is sufficient to derive $\{ d_{ij}, d_{i'j}, d_{ij'}, d_{ij'} \}$. In other words, Proposition [8](#page-15-2) suggests that it suffices to compute the lower triangular $(l^2-l)/2$ and the l diagonal entries of \mathcal{D} , from which the remaining $(l^2 - l)/2$ elements can be derived.

Corollary 3. *The encoding scheme outlined in Proposition [8](#page-15-2) requires the following rate per source for the lossless computation of* $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$.

$$
R_1 = R_2 = (m+1)(l^2+l)/2.
$$
 (25)

The total complexity of deriving $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$ *is*

$$
\Theta(m(l^2+l)/4) \tag{26}
$$

Proof. Rate: [\(25\)](#page-16-1) follows from incorporating the dimensions of the source vectors, and exploiting the complexity of multiplying $\mathbf{A}^{\mathsf{T}} \in \mathbb{F}_q^{l \times m}$ and $\mathbf{B} \in \mathbb{F}_q^{m \times l}$, which is expressed as $\Theta(ml^2)$.

Complexity: [\(26\)](#page-16-2) follows from using the definitions of $\{U_{ij}, V_{ij}, W_{ij}\}$ given in [\(131\)](#page-44-0) and the relation $d_{ij} = U_{ij}^{\dagger} \cdot V_{ij} - W_{ij}$ in [\(132\)](#page-44-1) from Appendix [A-K](#page-43-1) (the proof of Proposition [8\)](#page-15-2)). \Box

We next propose a further *recursive application of the dot product-based method* in Proposi-tion [1](#page-9-1) for distributed computation of a symmetric matrix $\mathcal{D} = A^{T}B$, with $q > 2$. In this approach, the diagonal entries $\{d_{ii}\}_{i\in[l]}$ are calculated first similarly as in Proposition [8.](#page-15-2) The additional rate required for computing the off-diagonal entries of $\mathcal D$ is decided using the symmetry in $\mathcal D$.

Proposition 9. (Recursive dot products to compute symmetric matrix products.) *Given two* seq *aeriences of random matrices* \overline{A} , $B \in \mathbb{F}_q^{m \times l}$ generated by correlated memoryless q-ary sources, *where* q > 2*, the separate encoding of the sources achieves a sum rate allowing the receiver to recover the symmetric matrix* $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$ with vanishing error, given as

$$
R_{\text{KM}}^{\Sigma} = 2H_q(\{\mathbf{U}_{ii}, \mathbf{V}_{ii}, W_{ii}\}_{i \in [l]}, \{\mathbf{U}_{ij}, \mathbf{V}_{ij}\}_{i \in [l], j \in [l]} : i < j \tag{27}
$$

Proof. See Appendix [A-L.](#page-44-2)

Proposition [9](#page-16-0) builds upon Proposition [1.](#page-9-1) In the sum rate R_{KM}^{Σ} presented in [\(27\)](#page-16-3) of Proposi-tion [9,](#page-16-0) we consider tuples $\{U_{ii}, V_{ii}, W_{ii}\}_{i \in [l]}$ to determine the diagonal entries $\{d_{ii}\}_{i \in [l]}$, and tuples $\{U_{ij}, V_{ij}\}_{i, j\in[l], i for a given pair $i, j \in [l]$, where noting that $\mathcal D$ is symmetric, we$ concentrate solely on the $(l^2 - l)/2$ elements in the lower triangular portion of \mathcal{D} .

Corollary 4. *The encoding scheme outlined in Proposition [9](#page-16-0) requires the following overall rate from each source for the lossless computation of* $\hat{\mathcal{D}} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$.

$$
R_1 = R_2 = \frac{ml}{2}(1+l) + l \tag{28}
$$

 \Box

The total complexity of deriving $\{d_{ij}\}_{i,j \in [l], i < j}$ *is*

$$
\Theta(m/2 \cdot l + (m/2 + m/2 + m/2 + m/2) \cdot (l^2 - l)/2) = \Theta(m(l^2 - l/2)).
$$
 (29)

Proof. **Rate:** In [\(28\)](#page-16-4), we used that in the expression of the sum rate R_{KM}^{Σ} in [\(27\)](#page-16-3), each tuple ${\bf U}_{ii}$, ${\bf V}_{ii}$, W_{ii} }_{i∈[l]} has a dimension of $m+1$, while each tuple ${\bf U}_{ij}$, ${\bf V}_{ij}$ }_{i, j∈[l], i<j has a} dimension of m, where $(l^2 - l)/2$ is the total number of such tuples.

Complexity: [\(29\)](#page-17-1) follows from employing the relation $d_{ij} = \mathbf{U}_{ij}^{\mathsf{T}} \cdot \mathbf{V}_{ij} - W_{ij} = d_{ji}$ given in [\(134\)](#page-44-3) and the relation for d_{ij} given in [\(135\)](#page-44-4) in Appendix [A-L](#page-44-2) (the proof of Proposition [9\)](#page-16-0). \Box

We next tighten the result in Proposition [9](#page-16-0) via a *nested application of the distributed dot product-based method* in Proposition [1,](#page-9-1) providing a natural generalization of the structured encoding scheme in [\[16\]](#page-74-15). In this approach, the diagonal entries $\{d_{ii}\}_{i\in[l]}$, are calculated first using the same technique as in Proposition [8,](#page-15-2) and then the additional rate required for computing the off-diagonal entries is determined as a function of $\{U_{ii}, V_{ii}, W_{ii}\}_{i\in[l]}$, as described next.

Proposition 10. (Nested dot products to compute symmetric matrix products.) *Given two* seq *uences of random matrices* $\mathbf{\hat{A}}$, $\mathbf{B} \in \mathbb{F}_q^{m \times l}$ generated by correlated memoryless q-ary sources, *where* $q \geq 2$ *, the separate encoding of the sources achieves a sum rate allowing the receiver to recover the symmetric matrix* $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$ with vanishing error, which is given as

$$
R_{\text{KM}}^{\Sigma} = 2H_q \Big(\{ \mathbf{U}_{ii}, \mathbf{V}_{ii}, W_{ii} \}_{i \in [l]} ,
$$

\n
$$
\Big\{ \mathbf{U}_{ij} \big(\frac{m}{4} + 1 : \frac{m}{2} \big) \oplus_q \mathbf{V}_{ij} \big(1 : \frac{m}{4} \big) , \mathbf{U}_{ij} \big(1 : \frac{m}{4} \big) \oplus_q \mathbf{V}_{ij} \big(\frac{m}{4} + 1 : \frac{m}{2} \big) ,
$$

\n
$$
\mathbf{U}_{ij} \big(\frac{m}{4} + 1 : \frac{m}{2} \big)^\mathsf{T} \cdot \mathbf{U}_{ij} \big(1 : \frac{m}{4} \big) \oplus_q \mathbf{V}_{ij} \big(1 : \frac{m}{4} \big)^\mathsf{T} \cdot \mathbf{V}_{ij} \big(\frac{m}{4} + 1 : \frac{m}{2} \big) - (\boldsymbol{\alpha}^\mathsf{T} (\mathbf{U}_{ii}, \mathbf{U}_{jj}) \mathbf{U}_{ij} + \boldsymbol{\beta}^\mathsf{T} (\mathbf{V}_{ii}, \mathbf{V}_{jj}) \mathbf{V}_{ij}) \Big\}_{i \in [l], j \in [l]} : i < j \Big) ,
$$
\n(30)

where the vectors $\{U_{ij}, V_{ij}, W_{ij}\}_{i, j \in [l]}$ *are defined similarly to [\(131\)](#page-44-0) in Appendix [A-K](#page-43-1)* (*Proof of Proposition [8\)](#page-15-2), and* $\alpha(\mathbf{U}_{ii}, \mathbf{U}_{jj}) \in \mathbb{F}_2^{m/2 \times 1}$ 2 *represents a coefficient matrix determined as a function of* \mathbf{U}_{ii} , \mathbf{U}_{jj} *, and similarly* $\boldsymbol{\beta}(\mathbf{V}_{ii}, \mathbf{V}_{jj}) \in \mathbb{F}_2^{m/2 \times 1}$ $n_2^{m/2\times1}$ represents the coefficient matrix as a *function of* V_{ii} , V_{jj} *, respectively, where these coefficient matrices are given in [\(142\)](#page-46-0) and [\(143\)](#page-46-1).*

Proof. See Appendix [A-M.](#page-45-0)

For the sum rate R_{KM}^{Σ} given in [\(30\)](#page-17-2) of Proposition [10,](#page-17-0) we next derive the rate and complexity of distributed lossless computation of $\mathcal{D} = \mathbf{A}^{\mathsf{T}} \mathbf{B} \in \mathbb{F}_q^{l \times l}$.

Corollary 5. *The encoding scheme outlined in Proposition [10](#page-17-0) requires the following overall rate from each source for the lossless computation of* $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$.

$$
R_1 = R_2 = ml(l+3)/4 + l(l+1)/2.
$$
 (31)

The total complexity of deriving $\{d_{ij}\}_i$, $_{j\in[l], i *is*$

$$
\Theta\left(\frac{ml}{8}(7l-3)\right)\,. \tag{32}
$$

Proof. See Appendix [A-N.](#page-46-2)

TABLE II: A comparison of the rates in [\(25\)](#page-16-1), [\(28\)](#page-16-4), [\(31\)](#page-17-3), and the complexities for deriving $\mathcal D$ in [\(26\)](#page-16-2), [\(29\)](#page-17-1), [\(32\)](#page-17-4).

Propositions [8-](#page-15-2)[10,](#page-17-0) along with our structured coding technique, help reduce the computational complexity of distributed matrix multiplication (Table [II\)](#page-18-1). While algorithms that minimize the number of multiplications necessary for matrix multiplication, like Strassen's method [\[122\]](#page-77-13), its generalizations to larger matrix sizes [\[123\]](#page-77-14), [\[124\]](#page-77-15), or learning techniques [\[115\]](#page-77-16), are out of our scope in this paper, they can be used to further reduce the complexity of matrix multiplication.

IV. MATRIX PRODUCTS: ACHIEVABILITY AND CONVERSE PARTS

In this section, we present general achievability and converse results. We begin by establishing several sufficient conditions (Lemmas [1,](#page-18-2) [2,](#page-18-3) [3\)](#page-19-1) and necessary conditions (Lemma [4,](#page-19-2) Proposi-tions [11](#page-19-0) and [12\)](#page-19-3) for any rate pair (R_1, R_2) . Next, we specialize these conditions to specific cases: symmetric matrix multiplication in Section [IV-A](#page-20-1) (Propositions [13](#page-20-0) and [14\)](#page-20-2) and general non-symmetric matrices in Section [IV-B](#page-21-1) (Propositions [15,](#page-21-2) [16,](#page-21-0) [17\)](#page-22-1), respectively.

Achievability Part. To prove our main results, we need a well-known fact of Elias [\[125\]](#page-77-17), which is that the capacity of binary symmetric channels can be attained by linear codes. Exploiting Elias' result, we will demonstrate the achievable rate region for the function $Z = f(X, Y) = X \oplus_q Y$.

Lemma 1. (Elias' result [\[125\]](#page-77-17).) Let $\{Z_i\}_{i=1}^{\infty}$ be an i.i.d. binary sequence. For fixed $\epsilon > 0$ and s *ufficiently large n, there exists a binary matrix* $C \in \mathbb{F}_2^{\kappa \times n}$ *and a function* $\psi : \mathbb{F}_2^{\kappa} \to \mathbb{F}_2^n$ *such that*

$$
\kappa < n(H(Z) + \epsilon),\tag{33}
$$

$$
\mathbb{P}(\psi(\mathcal{C}(\mathbf{Z}^n)) \neq \mathbf{Z}^n) < \epsilon \tag{34}
$$

For the proof of Elias' result (Lemma [1\)](#page-18-2), we refer the reader to the work of Shannon-Gallager-Berlekamp [\[126,](#page-77-18) p. 547]. Lemma [1](#page-18-2) was used by Wyner [\[127\]](#page-77-19) for proving the Slepian-Wolf theorem in the binary symmetric case. We next consider a generalization of Elias' lemma [\[16\]](#page-74-15). To that end, let the pair of source encoders (f_1, f_2) be an (n, ϵ, δ) -coding scheme if there exists a function $\phi : \mathcal{R}_{f_1} \times \mathcal{R}_{f_2} \to \mathcal{Z}^n$ such that by letting $\hat{\mathbf{Z}}^n \triangleq \phi(f_1(\mathbf{X}_1^n), f_2(\mathbf{X}_2^n))$, we have $\mathbb{P}(\hat{\mathbf{Z}}^n \neq \emptyset)$ \mathbf{Z}^n) < δ , generalizing the definition of an (n, ϵ) -coding scheme (see Appendix [A-A\)](#page-36-0).

Lemma 2. (Han-Kobayashi [\[17,](#page-74-14) Lemma 4].) Let Z be any random variable with values in \mathbb{F}_q . $Set \; \mathbf{Z}^n = (Z_1, Z_2, \ldots, Z_n) \in \mathbb{F}_q^{n \times 1}$. Then for any $\epsilon > 0$, $\delta > 0$, and sufficiently large n, a $\kappa \times n$ *matrix* $C \in \mathbb{F}_q^{\kappa \times n}$ and a decoding function $\psi : \mathbb{F}_q^{\kappa} \to \mathbb{F}_q^n$ exist such that

$$
\kappa < n(H_q(Z) + \epsilon) \tag{35}
$$

$$
\mathbb{P}(\psi(\mathcal{C}\mathbf{Z}^n) \neq \mathbf{Z}^n) < \delta \tag{36}
$$

The proof for Lemma [2](#page-18-3) follows from a counting argument (cf. Ahlswede-Han [\[60,](#page-75-16) p. 411]).

We next present the generalization of Körner-Marton's modulo-two sum problem in [\[16\]](#page-74-15) to modulo-q additions, studied by Han-Kobayashi [\[17\]](#page-74-14). The proof for this generalization follows from using the $\kappa \times n$ matrix C in Lemma [2](#page-18-3) as a linear encoding function.

Lemma 3. (Han-Kobayashi [\[17,](#page-74-14) Lemma 5].) *Let* X *and* Y *be any finite subsets of* \mathbb{F}_q *. Let* (X, Y) be any correlated random variables with values in X and Y , respectively, and define $Z = f(X, Y) = X \oplus_q Y$. Then, for the function Z, the following rate pair (R_1, R_2) is achievable:

$$
R_1 \ge H_q(Z) \ , \quad R_2 \ge H_q(Z) \ . \tag{37}
$$

In [\[60\]](#page-75-16), Ahlswede-Han presented an achievable region that contains the rate regions of [\[15\]](#page-74-13) and [\[16\]](#page-74-15). For this new region, described in [\[60,](#page-75-16) Theorem 10], the authors' proof [\[60,](#page-75-16) Appendix IV] combines a standard technique in source coding [\[59\]](#page-75-15) and the method of Elias [\[128\]](#page-77-20) (cf. Gallager $[125]$) for finding linear codes, which was previously used by Körner-Marton $[16]$ for proving the exact rate region for distributed computing of the modulo-two sum of a DSBS.

Converse Part. For general $A \in \mathbb{F}_q^{m \times l}$ and $B \in \mathbb{F}_q^{m \times l}$ with $m, l > 1$ and $q \geq 2$, we will determine the minimum sum rate required for distributed computing of the square matrix product $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$. A trivial lower bound to the sum rate follows from observing that

$$
R_1 + R_2 \ge H_q(f(\mathbf{A}, \mathbf{B})) = H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B}) \tag{38}
$$

We next provide a simplified version of Lemma 2 in [\[31\]](#page-75-24) for the setup we are interested in understanding the fundamental limit of compressibility for matrix multiplication.

Lemma 4. (Entropy of a square matrix product [\[31,](#page-75-24) Lemma 2].) Let $A, B \in \mathbb{F}_q^{m \times l}$ be *random matrices i.i.d. and uniformly distributed. Then, in the limit as* q *tends to infinity,*

$$
H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B}) = 2l \cdot \min\{m, l\} - \min\{m, l\}^2, q \to \infty,
$$
 (39)

$$
H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B} \mid \mathbf{A}) = H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B} \mid \mathbf{B}) = \min\{l^2, lm\}, \quad q \to \infty.
$$
 (40)

Exploiting Lemma [4,](#page-19-2) we next present a *strong converse*.

Proposition 11. (Strong converse for a general matrix product.) *Given i.i.d. uniform* A, B ∈ $\mathbb{F}_q^{m\times l}$, the rates for the distributed computation of $\mathcal{D}=\hat{\bf A}^{\intercal}{\bf B}\in\mathbb{F}_q^{l\times l}$ as $q\to\infty$ must satisfy

$$
R_1, R_2 \ge \min\{l^2, lm\} \tag{41}
$$

Proof. If one of the variables is available as side information, by the strong converse to the source coding theorem with side information [\[129\]](#page-77-21), we must have

$$
R_1 \ge H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B} | \mathbf{B}) , \quad R_2 \ge H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B} | \mathbf{A}) . \tag{42}
$$

Adapting the strong converse in Lemma [4](#page-19-2) (cf. [\(40\)](#page-19-4)) to the case where both A and B are independently and uniformly distributed over $\mathbb{F}_q^{m \times l}$, in the limit as $q \to \infty$, we obtain [\(41\)](#page-19-5).

We next show that for distributed matrix multiplication, there is a tighter rate region than (41) exploiting that the conditions of Han-Kobayashi [\[17,](#page-74-14) Lemmas 1-2] (cf. Lemma [5\)](#page-47-0) are satisfied.

Proposition 12. (A tight converse for the product of full rank matrices.) *Given* $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times l}$ *with* $m, l > 1$, the rates for the distributed computation of $D = A^TB$ *must satisfy*

$$
R_1 \ge H_q(\mathbf{A} \mid \mathbf{B}) \;, \quad R_2 \ge H_q(\mathbf{B} \mid \mathbf{A}) \;.
$$

Thus, the conditions of Han-Kobayashi [\[17,](#page-74-14) Lemmas 1-2] yield the following minimum sum rate:

$$
R_{\rm HK}^{\Sigma} = H_q(\mathbf{A} \mid \mathbf{B}) + H_q(\mathbf{B} \mid \mathbf{A}) \tag{44}
$$

When $A, B \in \mathbb{F}_q^{m \times l}$ are full rank matrices, as q tends to infinity, the tightness of [\(43\)](#page-19-6) (cf. Propo-sition [12\)](#page-19-3) over [\(41\)](#page-19-5) (cf. Proposition [11\)](#page-19-0) follows from noting that $H_q(f(\mathbf{A}, \mathbf{B})) \leq H_q(\mathbf{A}, \mathbf{B})$ for any arbitrary function $f(A, B)$. Hence, exploiting the relation $H_q(A, B) \geq H_q(A^{\dagger}B, B)$ and subtracting $H_q(\mathbf{B})$ from both sides, we infer that $H_q(\mathbf{A} | \mathbf{B}) \geq H_q(\mathbf{A}^\mathsf{T} \mathbf{B} | \mathbf{B})$. Hence, Proposition [12](#page-19-3) gives a tighter R_1 versus [\(41\)](#page-19-5). Similarly, $H_q(\mathbf{B} | \mathbf{A}) \geq H_q(\mathbf{A}^\intercal \mathbf{B} | \mathbf{A})$, and hence infer that Proposition [12](#page-19-3) also gives a tighter R_2 versus [\(41\)](#page-19-5).

In the following, we will demonstrate the achievable guarantees for various distributed multiplication scenarios using a mixture of unstructured and structured codes.

A. Square Matrix Products that are Symmetric: Achievability and Converse

Next, drawing on Lemmas [1,](#page-18-2) [2,](#page-18-3) and [3,](#page-19-1) we present an achievable region for the distributed computation of symmetric matrix products, where given two sequences of random matrices $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times l}$, the receiver aims to compute the symmetric matrix $\mathbf{D} = \mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{l \times l}$ for $q > 2$.

Proposition 13. (Achievable rate for symmetric matrix products.) *Given two sequences of random matrices* $A, B \in \mathbb{F}_q^{m \times l}$ generated by correlated memoryless q-ary sources, where $q > 2$, *the achievable sum rate by the separate encoding of the sources for the receiver to recover the symmetric matrix* $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$ with vanishing error is given as

$$
R_{\rm KM}^{\Sigma} = 2H_q(\mathbf{Z}) \tag{45}
$$

for vector $\mathbf{Z} \in \mathbb{F}_q^{(m+l)l \times 1}$ defined in [\(164\)](#page-49-0). Then for any $\epsilon > 0$, $\delta > 0$, and sufficiently large n, a $\kappa \times n$ matrix $C \in \mathbb{F}_q^{\kappa \times n}$ and decoding functions $\psi_j : \mathbb{F}_q^{\kappa_j} \to \mathbb{F}_q^n$, $j \in [(m+l)l]$ exist such that

$$
\kappa_j < n(H_q(\mathbf{Z}(j)) + \epsilon) \;, \quad j \in [(m+l)l] \;, \tag{46}
$$

$$
\kappa = \max \left\{ \sum_{j \in [ml]} \kappa_j , \sum_{j \in [ml+1, (m+l)l]} \kappa_j \right\},\tag{47}
$$

$$
\mathbb{P}(\{\psi_j(\mathbf{CZ}^n(j)) \neq \mathbf{Z}^n(j)\}_{j \in [(m+l)l]}) < \delta , \qquad (48)
$$

where $\mathbf{Z}(j)$ *, for* $j \in [(m+l)l]$ *, is the j-th element of* Z*, and* $\mathbf{Z}^n(j) = (\mathbf{Z}_1(j), \ldots, \mathbf{Z}_n(j)) \in \mathbb{F}_q^{n \times 1}$ *.*

Proof. To build our achievability result, we use a simple generalization of the lemma of Elias [\[125\]](#page-77-17) to *vector variables* and Lemma [6](#page-47-4) in Appendix [A-P.](#page-47-5) For details, see Appendix [A-P.](#page-47-5) \Box

We note that Proposition [13](#page-20-0) improves the sum rate in Proposition [5.](#page-13-1)

Proposition 14. (Multiplicative gain for binary symmetric matrix products.) *For matrices* $\mathbf{A}, \mathbf{\bar{B}} \in \mathbb{F}_2^{m \times l}$ following the elementwise DSBS model, the multiplicative gap between the scheme described in Proposition [13](#page-20-0) and the sum rate lower bound R_{HK}^{Σ} established in Proposition [12](#page-19-3) *is upper bounded as*

$$
\Gamma(m, l, p) = \frac{R_{\text{KM}}^{\Sigma}}{R_{\text{HK}}^{\Sigma}} \le \Gamma_{ub}(m, l, p) = \frac{\max\{2mh(p), l+1\}}{2(m-l+1)h(p)}.

Proof. See Appendix [A-Q.](#page-51-0)

Special cases. When $m > 1$ and $l = 1$, the resulting computation is a dot product satisfying $d = A^{\dagger}B \in \mathbb{F}_q$. We detail the proofs of achievability and the multiplicative gain for dot products in Appendices [A-R](#page-52-0) and [A-S,](#page-53-0) respectively. When $l > 1$ and $m = 1$, $\mathcal{D} = A^{T}B = B^{T}A \in \mathbb{F}_q^{l \times l}$ is an outer product. To devise an achievability scheme for the distributed computation of \mathcal{D} , we next consider the cases of $q = 2$ and $q > 2$. We detail the proofs of achievability and the multiplicative gain for symmetric outer products in Appendices [A-T](#page-53-1) and [A-U,](#page-53-2) respectively.

We next detail the most general scenario in our paper, which corresponds to the distributed computation of square matrix products (beyond symmetric).

B. General Square Matrix Products: Achievability and Converse

We next devise an achievability scheme for distributed computing of the square matrix product $\mathbf{A}^{\mathsf{T}}\mathbf{B} \in \mathbb{F}_q^{l \times l}$ for two general matrices $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times l}$ with $m, l > 1$, by combining unstructured and structured codes. Recall that in [\[60,](#page-75-16) Theorem 10], Ahlswede-Han provides a new achievable rate region for the binary modulo-two sum problem, which contains the rate regions of [\[15\]](#page-74-13) and [\[16\]](#page-74-15), and in general larger than the convex hull of both of them.

Proposition 15. (Achievable rate for square matrix products.) *Given two sequences of random matrices* $A, B \in \mathbb{F}_q^{m \times l}$ generated by correlated memoryless q-ary sources, where $q \geq 2$, the *following sum rate is achievable by the separate encoding of the sources for the receiver to recover the square matrix product* $\mathbf{D} = \mathbf{A}^T \mathbf{B} \in \mathbb{F}_q^{l \times l}$ with a small probability of error:

$$
R_{\text{AH}}^{\Sigma} = H_q(\mathbf{A}_1, \mathbf{B}_2) + 2 \max \{ H_q(\mathbf{A}_2 \oplus_q \mathbf{B}_1 | \mathbf{A}_1, \mathbf{B}_2), H_q(\mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 | \mathbf{A}_1, \mathbf{B}_2, \mathbf{A}_2 \oplus_q \mathbf{B}_1) \}.
$$
 (50)

Proof. See Appendix [A-V.](#page-54-0)

To demonstrate our achievability result, we next focus on the scenario where A and B are independent of each other and i.i.d. and uniform over $\mathbb{F}_q^{m \times l}$. For this setup, we note that in [\[31\]](#page-75-24), the authors characterized the entropy for a general possibly non-square matrix product of two random matrices as $q \to \infty$. We next exploit Lemma [4](#page-19-2) to derive our main achievability result for distributed computing of square matrix products (beyond symmetric matrices), as $q \to \infty$.

Proposition 16. (Achievable rate for a square matrix product for the setting in Lemma [4.](#page-19-2)) *Consider the setup in Lemma [4.](#page-19-2) Then any rate pair* (R_1, R_2) *such that*

R_1, R_2 \ge l \cdot \min\{l, m\} \tag{51}
$$

is achievable for the function $\mathcal{D} = f(A, B) = A^{T}B$ *. Furthermore, the minimum sum rate satisfies*

R_1 + R_2 \le 2l^2 = 2H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B}) \le R_{\text{SW}}^{\Sigma} = 2lm \ , \quad m \ge l \ , \tag{52}
$$

$$
R_1 + R_2 \le 2lm = R_{\rm SW}^{\Sigma} \le 2H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B}) = 4lm - 2m^2 \ , \quad m < l \ . \tag{53}
$$

Proof. See Appendix [A-W.](#page-55-0)

Lemma [4](#page-19-2) considers the regime $q \to \infty$ where the PMFs for A and B are i.i.d. and uniform, and similarly in Proposition [16.](#page-21-0) when q is finite or the PMFs for A and B are not i.i.d. and uniform, Lemma [4](#page-19-2) provides an upper bound to $H(A^TB)$. Proposition [11](#page-19-0) (cf. [\(41\)](#page-19-5)) proves the optimality of Proposition [16](#page-21-0) by providing the matching converse as $q \to \infty$.

 \Box

Proposition 17. (Multiplicative gain for binary square matrix products.) *For distributed computing of square matrix products, under the elementwise DSBS model, it holds that*

$$
\Gamma(m, l, p) = \frac{R_{\text{AH}}^{\Sigma}}{R_{\text{HK}}^{\Sigma}} \le \Gamma_{ub}(m, l, p) = \frac{ml(1 + h(2p(1 - p)))}{2mlh(p)} = \frac{1 + h(2p(1 - p)))}{2h(p)}, \quad (54)
$$

where the multiplicative gap in [\(54\)](#page-22-2) simplifies into $\lim_{p\to \frac{1}{2}}\Gamma_{ub}(m, l, p) = 1$, demonstrating the *tightness of [\(50\)](#page-21-3) for the dot product operation in the regime as* $p \rightarrow \frac{1}{2}$.

Proof. See Appendix [A-X.](#page-57-0)

 \Box

The multiplicative gap in [\(54\)](#page-22-2) is determined by exploiting the achievable sum rate R_{AH}^{Σ} (Appendix [A-X,](#page-57-0) [\(207\)](#page-57-1)) and the converse bound R_{HK}^{Σ} for general (non-symmetric) binary square matrix products (Appendix [A-X,](#page-57-0) [\(216\)](#page-59-0)). Moreover, applying the strong converse bound (Ap-pendix [A-X,](#page-57-0) LHS of [\(219\)](#page-60-1) yields a close approximation for R_{HK}^{Σ} in [\(216\)](#page-59-0) and provides an upper bound on the multiplicative gain for binary symmetric matrix products, as given in [\(49\)](#page-20-3).

In this section, we introduced structured coding techniques over finite fields for distributed computation of non-linear transformations, including dot products, matrix-vector products, dot product-based matrix products, and full matrix-matrix products. We analyzed specific classes of matrices, including symmetric and square matrices, while incorporating structural constraints and adopting less stringent assumptions about the correlations in the joint source PMFs. Our achievability scheme demonstrates that approximating the fundamental limits of compression requires leveraging the structural properties of the joint PMF of the distributed sources and the computation task. Recognizing these structures can further enable more efficient compression.

Next, in Section [V,](#page-22-0) we will detail our StPolyDot scheme that leverages the combined benefits of source and channel coding for distributed structured matrix multiplication.

V. STPOLYDOT CODES FOR DISTRIBUTED MATRIX MULTIPLICATION

In this section, we detail the construction for StPolyDot codes, inspired by the Poly codes [\[6\]](#page-74-5) and PolyDot codes [\[7\]](#page-74-6), which focus on *channel coding* to mitigate stragglers and enhance security. To that end, we split the two big source matrices $A \in \mathbb{F}_q^{m_A \times m}$ and $B \in \mathbb{F}_q^{m_A \times m}$, for $q \ge 2$, horizontally into s_r row-blocks and vertically into s_c column-blocks:

$$
\mathbf{A} = \begin{bmatrix} \mathbf{A}_{0,0} & \mathbf{A}_{0,1} & \cdots & \mathbf{A}_{0,s_c-1} \\ \mathbf{A}_{1,0} & \mathbf{A}_{1,1} & \cdots & \mathbf{A}_{1,s_c-1} \\ \vdots & \vdots & \ddots & \vdots \\ \mathbf{A}_{s_r-1,0} & \mathbf{A}_{s_r-1,1} & \cdots & \mathbf{A}_{s_r-1,s_c-1} \end{bmatrix}, \ \mathbf{B} = \begin{bmatrix} \mathbf{B}_{0,0} & \mathbf{B}_{0,1} & \cdots & \mathbf{B}_{0,s_c-1} \\ \mathbf{B}_{1,0} & \mathbf{B}_{1,1} & \cdots & \mathbf{B}_{1,s_c-1} \\ \vdots & \vdots & \ddots & \vdots \\ \mathbf{B}_{s_r-1,0} & \mathbf{B}_{s_r-1,1} & \cdots & \mathbf{B}_{s_r-1,s_c-1} \end{bmatrix}, \ (55)
$$

assuming that s_r divides m_A , and s_c divides m , respectively, where submatrices of A and **B** satisfy $\mathbf{A}_{j,k}$, $\mathbf{B}_{j,k} \in \mathbb{F}_q^{\frac{m_A!}{s_r} \times \frac{m}{s_c}}$ for $j \in \{0, \ldots, s_r-1\}$, $k \in \{0, \ldots, s_c-1\}$. Exploiting the representation in [\(55\)](#page-22-3), we rewrite A[⊺]B as the following linear function of the submatrix products:

$$
\mathbf{A}^{\mathsf{T}}\mathbf{B} = \begin{bmatrix} \sum_{i=0}^{s_r-1} \mathbf{A}_{i,0}^{\mathsf{T}} \mathbf{B}_{i,0} & \sum_{i=0}^{s_r-1} \mathbf{A}_{i,0}^{\mathsf{T}} \mathbf{B}_{i,1} & \dots & \sum_{i=0}^{s_r-1} \mathbf{A}_{i,0}^{\mathsf{T}} \mathbf{B}_{i,s_c-1} \\ \sum_{i=0}^{s_r-1} \mathbf{A}_{i,1}^{\mathsf{T}} \mathbf{B}_{i,0} & \sum_{i=0}^{s_r-1} \mathbf{A}_{i,1}^{\mathsf{T}} \mathbf{B}_{i,1} & \dots & \sum_{i=0}^{s_r-1} \mathbf{A}_{i,1}^{\mathsf{T}} \mathbf{B}_{i,s_c-1} \\ \vdots & \vdots & \ddots & \vdots \\ \sum_{i=0}^{s_r-1} \mathbf{A}_{i,s_c-1}^{\mathsf{T}} \mathbf{B}_{i,0} & \sum_{i=0}^{s_r-1} \mathbf{A}_{i,s_c-1}^{\mathsf{T}} \mathbf{B}_{i,1} & \dots & \sum_{i=0}^{s_r-1} \mathbf{A}_{i,s_c-1}^{\mathsf{T}} \mathbf{B}_{i,s_c-1} \end{bmatrix} \in \mathbb{F}_q^{m \times m}, \qquad (56)
$$

noting that $\mathbf{A}_{i,j}^{\mathsf{T}} \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m_A}{s_r}}$, and $\sum_{i=0}^{s_r-1} \mathbf{A}_{i,j}^{\mathsf{T}} \mathbf{B}_{i,k} \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m}{s_c}}$ for $i \in \{0,1,\ldots,s_r-1\}$ and $j,k \in \mathbb{F}_q$ $\{0, 1, \ldots, s_c - 1\}$. While StPolyDot codes are defined over \mathbb{F}_q , instead of explicitly using \oplus_q , we use + or Σ to describe the subfunctions given by the polynomial of submatrices of A, B.

To determine $\mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{m \times m}$ using [\(55\)](#page-22-3), we define the following linear preprocessing functions at the master node, where the master node chooses different coefficients x_i across workers $i \in \Omega$:

\tilde{\mathbf{B}}_{i} \triangleq \sum_{j=0}^{s_{r}-1} \sum_{k=0}^{s_{c}-1} \mathbf{B}_{j,k} x_{i}^{s_{c}(s_{r}-1-j)} x_{i}^{s_{c}(2s_{r}-1)k} \in \mathbb{F}_{q}^{\frac{m_{A}}{s_{r}} \times \frac{m}{s_{c}}}, \quad i \in \Omega.
$$
\n

(57)

We refer the reader to [\[7,](#page-74-6) Remark V.1] for alternative ways of choosing the exponents of x_i 's.

We next exploit the row-block representations of $\mathbf{\tilde{A}}_i \in \mathbb{F}_q^{\frac{m_A}{sr} \times \frac{m}{s_c}}$ and $\mathbf{\tilde{B}}_i \in \mathbb{F}_q^{\frac{m_A}{sr} \times \frac{m}{s_c}}$ detailed in Section [III,](#page-8-0) allowing us to rewrite matrices \tilde{A}_i and \tilde{B}_i as functions of submatrices as follows:

$$
\tilde{\mathbf{A}}_i = \begin{bmatrix} \tilde{\mathbf{A}}_{i1} \\ \tilde{\mathbf{A}}_{i2} \end{bmatrix}, \quad \tilde{\mathbf{B}}_i = \begin{bmatrix} \tilde{\mathbf{B}}_{i1} \\ \tilde{\mathbf{B}}_{i2} \end{bmatrix}, \quad i \in \Omega,
$$
\n(58)

where the submatrices satisfy \tilde{A}_{i1} , $\tilde{A}_{i2} \in \mathbb{F}_q^{\frac{m_A}{2s_r} \times \frac{m}{s_c}}$ and \tilde{B}_{i1} , $\tilde{B}_{i2} \in \mathbb{F}_q^{\frac{m_A}{2s_r} \times \frac{m}{s_c}}$.

Using the submatrices in [\(58\)](#page-23-0), the master node then performs an encoding process to compute the subfunctions to be communicated to worker $i \in \Omega$. These subfunctions are given by the following three polynomials $\mathbf{p}_i(x_i) = \{p_i^{(1)}\}$ $i^{(1)}(x_i), p_i^{(2)}$ $i^{(2)}(x_i), p_i^{(3)}$ $i^{(3)}(x_i)\}$:

where $p_i^{(1)}$ $i^{(1)}(x_i)$ and $p_{i_{(1)}}^{(2)}$ $\sum_{i=1}^{(2)} (x_i)$ are *linear polynomials* of the submatrices in [\(58\)](#page-23-0), while the *non-linear parity polynomial* p (3) $i^{(3)}(x_i)$ results from non-linear processing of submatrices in [\(58\)](#page-23-0). Although $p_i^{(3)}$ $\tilde{P}_i^{(3)}(x_i)$ is non-linear due to terms like $\tilde{A}_{i2}^T \tilde{A}_{i1} \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m}{s_c}}$ and $\tilde{B}_{i1}^T \tilde{B}_{i2} \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m}{s_c}}$, it remains linearly separable in terms of \tilde{A}_i and \tilde{B}_i . This linear separability is advantageous in fully distributed settings, enabling the convenient use of the Körner-Marton encoding scheme [\[16\]](#page-74-15).

Through post-processing of the received $p_i(x_i)$, worker $i \in \Omega$ computes the corresponding

computational output, as detailed in Appendix [B-E,](#page-65-0) [\(248\)](#page-65-1), and transmits it to the receiver:

$$
p_i(x_i) = (p_i^{(1)}(x_i))^{\mathsf{T}} \cdot p_i^{(2)}(x_i) - p_i^{(3)}(x_i) = \tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i.

Under the relaxed condition where $\tilde{A}_{i}^{\dagger} \tilde{B}_{i}$ is symmetric, i.e., $\tilde{A}_{i}^{\dagger} \tilde{B}_{i} = \tilde{B}_{i}^{\dagger} \tilde{A}_{i}$, for all $i \in \Omega$, the receiver can easily obtain the corresponding output, as detailed in Appendix [B-E,](#page-65-0) [\(249\)](#page-66-1):

$$
\tilde{p}_i(x_i) = \frac{p_i(x_i) + (p_i(x_i))^\mathsf{T}}{2} = \tilde{\mathbf{A}}_i^\mathsf{T} \tilde{\mathbf{B}}_i \ . \tag{61}

Figure [5](#page-24-0) illustrates our end-to-end framework with two distributed master nodes, where A and B are stored in master nodes one and two, respectively. To realize StPolyDot coding, master nodes leverage the structured linear encoding technique of Körner-Marton on submatrices $\tilde{\mathbf{A}}_{i1}, \tilde{\mathbf{A}}_{i2}, \tilde{\mathbf{B}}_{i1}, \tilde{\mathbf{B}}_{i2}$ [\[1\]](#page-74-3), [\[16\]](#page-74-15), and assign polynomials of $\tilde{\mathbf{A}}_i$ and $\tilde{\mathbf{B}}_i$, respectively, given in [\(57\)](#page-23-1), to distributed workers. Using [\(59\)](#page-23-2), the cost of sending $p_i(x_i)$ to worker $i \in \Omega$, can be made as small as $2H_q(\mathbf{p}_i(x_i))$, which is twice the optimal transmission cost for $\mathbf{p}_i(x_i)$ [\[1\]](#page-74-3), [\[16\]](#page-74-15):

H_q(\mathbf{p}_i(x_i)) \le \frac{m_A}{2s_r} \cdot \frac{m}{s_c} + \frac{m_A}{2s_r} \cdot \frac{m}{s_c} + \frac{m}{s_c} \cdot \frac{m}{s_c} = \frac{m_A m}{s_r s_c} + \frac{m^2}{s_c^2} \,. \tag{62}
$$

In the framework of [\[7\]](#page-74-6), which has one master node that stores both source matrices and a set of distributed workers, the polynomial assignments yield the following entropy:

$$
H_q(p_{\mathbf{A}}(x_i), \ p_{\mathbf{B}}(x_i)) \le \frac{m_A}{s_r} \cdot \frac{m}{s_c} + \frac{m_A}{s_r} \cdot \frac{m}{s_c} = \frac{2m_A m}{s_r s_c} \,,\tag{63}
$$

where the computation of $p_{\mathbf{A}}(x_i)$ and $p_{\mathbf{B}}(x_i)$ for MatDot codes in [\[7\]](#page-74-6) is detailed in Appendix [B-B.](#page-61-0) Contrasting $H_q(\mathbf{p}_i(x_i))$ in [\(62\)](#page-24-1) with $H_q(p_{\mathbf{A}}(x_i), p_{\mathbf{B}}(x_i))$ in [\(63\)](#page-24-2), in the regime $\frac{m}{s_c} < \frac{m_A}{s_r}$ $\frac{n_A}{s_r}$, the total communication cost of StPolyDot codes can be lower than that of [\[7\]](#page-74-6).

We next evaluate the computation and communication complexities for our framework.

A. Computation Cost of StPolyDot Codes for Distributed Matrix Multiplication

In this part, we detail the complexity of computation at the master nodes, and the worker nodes. We will detail the decoding cost at the receiver node in Section [V-C.](#page-27-1)

a) Computation cost of the master: For each $i \in \Omega$, the master first computes \tilde{A}_i and \tilde{B}_i which has a complexity of $\Theta(s_c \cdot s_r \cdot \frac{m_A}{s_r})$ $\frac{m_A}{s_r} \cdot \frac{m}{s_c}$ $\frac{m}{s_c}+s_r\cdot s_c\cdot \frac{m_A}{s_r}$ $\frac{m_A}{s_r} \cdot \frac{m}{s_c}$ sc . Using [\(59\)](#page-23-2), it next determines $\mathbf{p}_i(x_i)$ from submatrices $\tilde{\mathbf{A}}_i$ and $\tilde{\mathbf{B}}_i$. The complexities of computing $p_i^{(1)}$ $i^{(1)}(x_i)$ and $p_i^{(2)}$ $i^{(2)}(x_i)$ are $\Theta\left(\frac{m_A}{2g}\right)$ $\frac{m_A}{2s_r}\cdot\frac{m}{s_c}$ sc) each, and the complexity of computing $p_i^{(3)}$ $\binom{3}{i}(x_i)$ is $\Theta\left(\frac{m}{s_c}\right)$ $\frac{m}{s_c} \cdot \frac{m_A}{2s_r}$ $\frac{m_A}{2s_r}\cdot\frac{m}{s_c}$ $\frac{m}{s_c} + \frac{m}{s_c}$ $\frac{m}{s_c} \cdot \frac{m_A}{2s_r}$ $\frac{m_A}{2s_r}\cdot\frac{m}{s_c}$ $\frac{m}{s_c}+\frac{m^2}{s_c^2}$ s_c^2 , respectively. Aggregating these, the total computation cost of the master node is

$$
\Theta\Big(N \cdot \Big(2m_A m + \frac{m_A m}{s_r s_c} + \frac{m_A m^2}{s_r s_c^2} + \frac{m^2}{s_c^2}\Big)\Big) \ . \tag{64}
$$

b) Computation cost of a worker: [\(59\)](#page-23-2) requires each worker to have a memory given by

$$
M_{\text{StPolyDot}} = \frac{m_A}{2s_r} \cdot \frac{m}{s_c} + \frac{m_A}{2s_r} \cdot \frac{m}{s_c} + \frac{m}{s_c} \cdot \frac{m}{s_c} = \frac{m_A m}{s_r s_c} + \frac{m^2}{s_c^2} \,. \tag{65}
$$

If $\frac{m}{s_c} \leq \frac{m_A}{s_r}$ $\frac{m_A}{s_r}$, then $\frac{m^2}{s_c^2} \leq \frac{m_A m}{s_r s_c}$ $\frac{m_A m}{s_r s_c}$, and $\frac{m_A m}{s_r s_c} + \frac{m^2}{s_c^2}$ $\frac{n^2}{s_c^2} \leq \frac{2m_A m}{s_r s_c}$ $\frac{m_A m}{s_r s_c} = M_{\text{PolyDot}}$. When $\frac{m}{s_c} = 1$, we have $\tilde{A}_i^{\dagger} \tilde{B}_i = \langle \tilde{A}_i, \tilde{B}_i \rangle$, and this incurs $\frac{m_A}{s_r}$ bits in linear encoding and only one non-linear parity bit for any given length m_A and s_r , as seen from [\(65\)](#page-25-0) (cf. Proposition [1](#page-9-1) in Section [III-A\)](#page-8-1).

Via post-processing of the received $p_i(x_i)$, the worker computes $p_i(x_i)$ and transmits it to the receiver which in turn evaluates (cf. [\(61\)](#page-24-3)) the computational output:

$$
\tilde{p}_i(x_i) = \frac{p_i(x_i) + (p_i(x_i))^\mathsf{T}}{2} = \tilde{\mathbf{A}}_i^\mathsf{T} \tilde{\mathbf{B}}_i , \qquad (66)
$$

where $\tilde{A}_i^T \tilde{B}_i$ is derived in [\(61\)](#page-24-3). Exploiting [\(66\)](#page-25-1) the degree of $\tilde{p}_i(x_i) = \tilde{A}_i^T \tilde{B}_i$ is expressed as $deg(\tilde{p}_i(x_i)) = (s_c - 1) + s_c(s_r - 1 + s_r - 1) + s_c(2s_r - 1)(s_c - 1)$. Therefore, the minimum number of workers needed to successfully evaluate $\mathbf{A}^\intercal \mathbf{B}$ is given by $N_{r\text{StPolyDot}} = s_c^2(2s_r - 1)$.

We next evaluate the computation cost per worker. To evaluate the polynomial in [\(66\)](#page-25-1) at worker $i \in \Omega$, we determine the cost of multiplying $(p_i^{(1)})$ $\binom{1}{i}(x_i)$ ^T and $p_i^{(2)}$ $\sum_{i=1}^{(2)} (x_i)$ that is $\Theta\left(\frac{m}{s_c} \cdot \frac{m_A}{2s_x}\right)$ $\frac{m_A}{2s_{r_m}}\cdot\frac{m}{s_{\varsigma}}$ $\binom{m}{s_{\varsigma_n}}$, which is then followed by the addition of $(p_i^{(1)})$ $j^{(1)}(x_i))^{\mathsf{T}} p_i^{(2)}$ $\sum_{i=1}^{(n)} (x_i) \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m}{s_c}}$ and $p_i^{(3)}$ $\zeta_i^{(3)}(x_i) \in \mathbb{F}_q^{\frac{s_c}{s_c} \times \frac{s_{\kappa_i}}{s_c}}$, where the complexity is $\Theta\left(\frac{m^2}{s^2}\right)$ s_c^2). Hence, the computation cost of worker $i \in \Omega$ is

$$
\Theta\left(\frac{m}{s_c}\cdot\frac{m_A}{2s_r}\cdot\frac{m}{s_c} + \frac{m^2}{s_c^2}\right) = \Theta\left(\frac{m_A m^2}{2s_r s_c^2} + \frac{m^2}{s_c^2}\right) \,. \tag{67}
$$

Here, we neglected the additional cost of computing $\tilde{p}_i(x_i)$ from $p_i(x_i)$ due to [\(66\)](#page-25-1). The receiver can easily handle this operation via a simple linear operation.

To contrast the costs detailed above with the prior approaches, in Appendix [B,](#page-60-2) we provide a comprehensive treatment of Poly codes and their various generalizations (including [\[6\]](#page-74-5), [\[7\]](#page-74-6)), and illustrate their complexities in Tables [III](#page-26-0) and [IV.](#page-27-2) From [\(67\)](#page-25-2), we note that compared to PolyDot with a computational complexity $\Theta(\frac{m_A m^2}{s_r s_c^2})$ (see Table [III\)](#page-26-0), from [\(67\)](#page-25-2), the computation cost per worker is less for StPolyDot (see Table [IV\)](#page-27-2), which holds true when $1 < \frac{m_A}{2s_B}$ $\frac{m_A}{2s_r}$. For a fixed value of s, letting $s_r = s$ and $s_c = 1$ yields *a dot product-based computation*, where the costs are $\Theta\left(\frac{m_A m^2}{s}\right)$ for PolyDot (MatDot) (see Table [III\)](#page-26-0) versus $\Theta\left(\frac{m_A m^2}{2s} + m^2\right)$ for StPolyDot (see Table [IV\)](#page-27-2), achieving similar values when $\frac{m_A}{2s} \approx 1$. On the other hand, letting $s_c = s$ and $s_r = 1$ yields *an outer product-based computation*, where the costs are $\Theta\left(\frac{m_A m^2}{s^2}\right)$ for PolyDot (Poly) (see Table [III\)](#page-26-0) versus $\Theta\left(\frac{m_A m^2}{2s^2} + \frac{m^2}{s^2}\right)$ $\frac{m^2}{s^2}$) for StPolyDot (see Table [IV\)](#page-27-2), achieving similar values when $\frac{m_A}{2} \approx 1$. For this regime, the computation cost of StPolyDot is half versus PolyDot when $s_c = s \gg m$. For the formal result, we refer the reader to Proposition [21.](#page-28-3)

B. Communication Cost of StPolyDot Codes for Distributed Matrix Multiplication

In this part, we detail the complexity of communication from the master nodes to the worker nodes as well as from the workers to the receiver.

a) Communication cost of the master: We analyze the communication cost for a single master node scenario. In the case of two distributed master nodes (Figure [5\)](#page-24-0), the structured matrix multiplication model from Section [III,](#page-8-0) incorporating the Körner-Marton scheme for determining subfunctions, can be directly applied. Notably, *the communication cost for each distributed master node matches that of a centralized master node*. Consequently, the total communication cost for transmitting subfunctions from the distributed master nodes doubles that of the centralized approach. Specifically, the communication cost for each master node to transmit subfunctions $p_i(x_i)$ to worker $i \in \Omega$ is given by:

$$
H_q(\{\mathbf{p}_i(x_i)\}_{i\in\Omega}) = \Theta\Big(N \cdot \Big(\frac{m_A}{2s_r} \cdot \frac{m}{s_c} + \frac{m_A}{2s_r} \cdot \frac{m}{s_c} + \frac{m^2}{s_c^2}\Big)\Big) = \Theta\Big(N\Big(\frac{m_A m}{s_r s_c} + \frac{m^2}{s_c^2}\Big)\Big) ,\tag{68}
$$

exploiting the dimensions of the subfunctions $p_i^{(1)}$ $\mathbb{F}_i^{(1)}(x_i) \in \mathbb{F}_q^{\frac{m_A}{2s_r} \times \frac{m}{s_c}}, p_i^{(2)}$ $\zeta_i^{(2)}(x_i) \in \mathbb{F}_q^{\frac{m_A}{2s_r} \times \frac{m}{s_c}}$ with dimensions $\frac{m_A}{2s_r} \times \frac{m}{s_c}$ $\frac{m}{s_c}$ each, and $p_i^{(3)}$ $\mathbf{f}_{i}^{(3)}(x_{i}) \in \mathbb{F}_{q}^{\frac{m}{s_{c}} \times \frac{m}{s_{c}}}$ with a dimension $\frac{m}{s_{c}} \times \frac{m}{s_{c}}$ $\frac{m}{s_c}$, as defined in [\(59\)](#page-23-2).

b) Communication cost of a worker: Upon successfully recovering the subfunctions $\mathbf{p}_i(x_i)$ and evaluating $p_i(x_i)$ in [\(60\)](#page-24-4) (or evaluating $p_i(x_i)$ in [\(61\)](#page-24-3) when the symmetry condition $\tilde{A}_i^{\dagger} \tilde{B}_i =$ $\tilde{\mathbf{B}}_i^{\mathsf{T}}\tilde{\mathbf{A}}_i$ is satisfied), worker $i \in \Omega$ transmits the following computational output to the receiver:

$$
p_i(x_i) = \sum_{j=0}^{s_r-1} \sum_{k=0}^{s_c-1} \sum_{j'=0}^{s_r-1} \sum_{k'=0}^{s_c-1} \mathbf{A}_{j,k}^{\mathsf{T}} \mathbf{B}_{j',k'} x_i^{k+s_c(s_r-1-j'+j)+s_c(2s_r-1)k'} \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m}{s_c}}.
$$
 (69)

Therefore, the communication cost of worker $i \in \Omega$ is expressed as

$$
H_q(\tilde{\mathbf{A}}_i^{\mathsf{T}}\tilde{\mathbf{B}}_i) = \Theta\left(\frac{m^2}{s_c^2}\right) \,. \tag{70}
$$

C. Decoding Cost of StPolyDot Codes for Distributed Matrix Multiplication

This part details the complexity analysis for decoding StPolyDot codes at the receiver. Decoding of $\mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{m \times m}$ requires interpolating a subset of submatrices in the polynomial $\tilde{p}_i(x_i) = \tilde{A}_i^{\intercal} \tilde{B}_i \in \mathbb{F}_q^{\frac{m}{s} \times \frac{m}{s_c}}$ given in [\(61\)](#page-24-3), of degree $\deg(\tilde{p}_i(x_i)) = s_c^2(2s_r - 1) - 1$ for all $i \in \Omega$. To that end, we let $\tilde{p}_i(x_i) = \mathcal{D}_0 + \mathcal{D}_1 x_i + \cdots + \mathcal{D}_{|\mathcal{I}|-1} x_i^{|\mathcal{I}|-1}$ $\hat{u}_i^{L|-1}$, where $\mathcal{I} = \deg(\tilde{p}_i(x_i)) + 1$ is the number of unique values at which $\tilde{p}_i(x_i)$ is evaluated, and $\mathcal{D}_j \in \mathbb{F}_q^{\frac{m}{g} \times \frac{m}{s_c}}$, $j \in \{0, 1, ..., |\mathcal{I}|-1\}$ are the matrix coefficients that are given by the linear combinations of the submatrix products:

$$
\mathbf{A}_{j,k}^{\mathsf{T}} \mathbf{B}_{j',k'} , \quad j, j' \in \{0, \dots, s_r - 1\}, \quad k, k' \in \{0, \dots, s_c - 1\} . \tag{71}
$$

We next characterize the decoding cost at the receiver following the steps in [\[7,](#page-74-6) Section III-B].

Proposition 18. (Decoding complexity of the StPolyDot codes at the receiver.) *The total decoding complexity of the StPolyDot codes at the receiver is given as*

$$
\Theta\left(\left(\frac{m}{s_c}\right)^2 \cdot |\mathcal{I}| + |\mathcal{I}|^3\right) \,,\tag{72}
$$

where the first term dominates when $\frac{m}{s_c} \gg |\mathcal{I}| = s_c^2(2s_r - 1)$ *.*

Proof. See Appendix [C.](#page-66-0)

We next contrast our StPolyDot codes with the state-of-the-art techniques in terms of their storage, communication, and computation complexity.

D. Complexity Analysis of StPolyDot Codes for Distributed Matrix Multiplication

Given the master-worker-receiver framework, exploiting the computation and communication costs of StPolyDot codes detailed in Sections [V-A](#page-24-5) and [V-B,](#page-26-1) we first compare the storage size per worker with that of PolyDot codes in Proposition [19.](#page-28-1) Next, we contrast the costs of total communication and computation versus the state of the art in Propositions [20](#page-28-2) and [21,](#page-28-3) respectively.

 \Box

 \Box

Proposition 19. (Achievable gain in the storage size of the workers.) *For given parameters* m_A, m, s_r, s_c , the storage size per worker ratio between PolyDot and StPolyDot coding is

$$
\eta_S = \frac{2m_A}{m_A + \frac{ms_r}{s_c}} \,,\tag{73}
$$

where the ratio η_S *approaches* 2 *when* $ms_r \ll m_A s_c$.

Proof. See Appendix [D.](#page-67-0)

Proposition 20. (Achievable gain in the total communication cost.) *Given a fixed value of* $s = s_c$, *i.e.*, $s_r = 1$ and $N_{rStPolyDot} = s_c^2$, and for $\frac{Nm_A}{sm} \gg 1$, the total communication cost of *StPolyDot approaches half of the total communication cost of PolyDot, i.e.,*

$$
\eta_{\text{Comm}} \approx 2 \tag{74}
$$

Proof. See Appendix [E.](#page-68-0)

Proposition 21. (Guarantees in the total computation cost.) *The ratio of the total cost of computation of StPolyDot to the total cost of computation of PolyDot is upper bounded as*

$$
\chi_{\text{Comp}} = 1 + \frac{s_c + \frac{5}{2}m}{2ss_c + m} \tag{75}
$$

Proof. See Appendix [F.](#page-69-0)

In Section [IX,](#page-32-0) we will demonstrate the performance of StPolyDot via numerical examples. We will next generalize StPolyDot codes for distributed computing non-symmetric matrices.

VI. STPOLYDOT CODES FOR COMPUTING NON-SYMMETRIC MATRICES

For the distributed computation of general square matrix products that are not symmetric, i.e., $\mathcal{D} = A^{T}B \neq B^{T}A$, using A_i and B_i from [\(57\)](#page-23-1) and the row-block representations in [\(58\)](#page-23-0), we will now devise a distributed encoding scheme, differently from the symmetric $\mathcal D$ case in [\(59\)](#page-23-2), with subfunctions defined by four polynomials of the submatrices (cf. Appendix [B-E,](#page-65-0) [\(250\)](#page-66-2)):

$$
p_i^{(1)}(x_i) \triangleq \tilde{\mathbf{A}}_{i1} + \tilde{\mathbf{B}}_{i2} \in \mathbb{F}_q^{\frac{m_A}{2s_r} \times \frac{m}{s_c}}, \quad p_i^{(2)}(x_i) \triangleq \tilde{\mathbf{A}}_{i2} \in \mathbb{F}_q^{\frac{m_A}{2s_r} \times \frac{m}{s_c}},
$$

$$
p_i^{(3)}(x_i) \triangleq \tilde{\mathbf{B}}_{i1} \in \mathbb{F}_q^{\frac{m_A}{2s_r} \times \frac{m}{s_c}}, \quad p_i^{(4)}(x_i) \triangleq \tilde{\mathbf{A}}_{i2}^\mathsf{T} \tilde{\mathbf{A}}_{i1} + \tilde{\mathbf{B}}_{i2}^\mathsf{T} \tilde{\mathbf{B}}_{i1} \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m}{s_c}}.
$$
(76)

In the proposed master-workers-receiver framework, utilizing [\(57\)](#page-23-1), the master node constructs the linear preprocessing functions $\tilde{A}_i \in \mathbb{F}_q^{\frac{m_A}{s_r} \times \frac{m}{s_c}}$, and $\tilde{B}_i \in \mathbb{F}_q^{\frac{\delta_{m_A}}{s_r} \times \frac{m}{s_c}}$ for each worker $i \in \Omega$. Then, for the case of non-symmetric matrices, using [\(76\)](#page-28-5), by following steps similar to those in [\(60\)](#page-24-4), worker $i \in \Omega$ derives (cf. Appendix [B-E,](#page-65-0) [\(251\)](#page-66-3)):

$$
p_i(x_i) = p_i^{(2)}(x_i)^{\mathsf{T}} \cdot p_i^{(1)}(x_i) + p_i^{(1)}(x_i)^{\mathsf{T}} \cdot p_i^{(3)}(x_i) - p_i^{(4)}(x_i) = \tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i \tag{77}
$$

Proposition 22. (Complexities for 2-matrix products.) *For distributed computation of a* 2 *matrix product* A[⊺]B*, the total computation complexity of the master node, the computation complexity per worker, and the recovery threshold are as follows:*

$$
\Theta\Big(m^3 + \frac{3m^2}{2}\Big) , \quad \Theta(m^3 + 2m^2) , \quad N_{r\text{StPolyDot}} = s_c^2(2s_r - 1) . \tag{78}
$$

Proof. The computation complexity of the master is the total cost needed to determine the polynomials $\{p_i^{(1)}\}$ $i^{(1)}(x_i), p_i^{(2)}$ $\binom{2}{i}(x_i), p_i^{(3)}$ $i^{(3)}(x_i), p_i^{(4)}$ $\binom{4}{i}(x_i)$ given in [\(76\)](#page-28-5), which is expressed as

$$
\Theta\left(\frac{m}{2}\cdot m + 2\left(m\cdot\frac{m}{2}\cdot m\right) + m\cdot m\right) = \Theta\left(m^3 + \frac{3m^2}{2}\right) \,. \tag{79}
$$

The computation complexity of a worker is given by the complexity of determining $p_i(x_i)$ in [\(77\)](#page-28-6), which, by incorporating the dimensions of the four polynomials, is given as

$$
\Theta\left(m \cdot \frac{m}{2} \cdot m + m \cdot \frac{m}{2} \cdot m + 2 \cdot m \cdot m\right) = \Theta(m^3 + 2m^2) \ . \tag{80}
$$

Note that the degree of $p_i(x_i)$ in [\(77\)](#page-28-6) is $\deg(p_i(x_i)) = (s_c - 1) + s_c(s_r - 1 + s_r - 1) + s_c(2s_r - 1)$ $1)(s_c - 1)$. Hence, the recovery threshold for 2-matrix product satisfies

$$
N_{r\text{StPolyDot}} = N_{r\text{PolyDot}} = s_c^2(2s_r - 1) \tag{81}
$$

For this setup, in the special case when $s = s_r$ and $s_c = 1$, the recovery threshold of Construction VI.1 in [\[7\]](#page-74-6) is expressed as $N_{rStMatDot} = N_{rMatDot} = 2s - 1$. \Box

We next generalize StPolyDot codes for distributed chain matrix multiplication.

VII. STPOLYDOT CODES FOR DISTRIBUTED CHAIN MATRIX MULTIPLICATION

Multiplying more than two matrices, referred to as the chain matrix multiplication problem, has been extensively studied in prior works, e.g., [\[7\]](#page-74-6), [\[130\]](#page-77-22)–[\[135\]](#page-77-23). For a given $N_c > 2$, these techniques typically reduce the computation of the product $\mathbf{A}^\intercal \mathbf{B} \mathbf{C}^\intercal \mathbf{D} \dots$ involving N_c matrices into a series of 2-matrix products such as $(A^{\mathsf{T}}B)$, $(C^{\mathsf{T}}D)$, ..., which are then combined to form the final product $(A^{\dagger}B) \cdot (C^{\dagger}D) \dots$

We next detail our hierarchical technique that leverages the structure of the computation task.

A. A Hierarchical Multi-Layer Approach to Distributed Chain Matrix Multiplication

We here outline a hierarchical approach for computing A[⊤]BC[†]D. We initially assume $N_c = 4$ and $m_A = m$, and show how our approach can easily be extended to $N_c = 2^b$, for $b \in \mathbb{Z}^+$. To that end, we first compute the 2-matrix products $\mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{m \times m}$ and $\mathbf{C}^\intercal \mathbf{D} \in \mathbb{F}_q^{m \times m}$. From Table [IV,](#page-27-2) with StPolyDot codes, the cost of computing each 2-matrix product per worker is

$$
\Theta\left(\frac{m^3}{2s_r s_c^2} + \frac{m^2}{s_c^2}\right)
$$

versus from Table [III,](#page-26-0) with PolyDot codes [\[7\]](#page-74-6)

$$
\Theta\Big(\frac{m^3}{s_r s_c^2}\Big) \ .
$$

If the order of matrix multiplication is $N_c = 2^b$, for $b \in \mathbb{Z}^+$, the computation of the product of 2^b matrices is similar. With the above approach applied hierarchically, this task requires b steps. For this setting, the total computation cost (the workers and receiver) for each approach (StPolyDot or PolyDot) can be obtained by scaling the per-worker computation cost by b .

Exploiting [\(57\)](#page-23-1), we define $\tilde{\mathbf{A}}_i$, $\tilde{\mathbf{B}}_i \in \mathbb{F}_q^{\frac{m}{q_r} \times \frac{m}{s_c}}$, and similarly $\tilde{\mathbf{C}}_i$, $\tilde{\mathbf{D}}_i \in \mathbb{F}_q^{\frac{m}{s_r} \times \frac{m}{s_c}}$ for $i \in \Omega$. According to the StPolyDot rule in [\(59\)](#page-23-2), i.e., $p_i^{(1)}$ $\tilde{\mathbf{A}}_{i}^{(1)}(x_{i})\,=\,\mathbf{\tilde{A}}_{i2}\oplus_{q}\mathbf{\tilde{B}}_{i1},\;p_{i}^{(2)}$ $\tilde{A}_i^{(2)} (x_i) \, = \, \tilde{{\bf A}}_{i1} \oplus_q \, \tilde{{\bf B}}_{i2},$ and $p_i^{(3)}$ $\tilde{A}_{i}^{(3)}(x_i) = \tilde{A}_{i2}^{\mathsf{T}} \tilde{A}_{i1} \oplus_q \tilde{B}_{i1}^{\mathsf{T}} \tilde{B}_{i2}$. Analogously, we define the set of polynomials $r_i^{(1)}$ $i^{(1)}(x_i) =$

 $\tilde{\mathbf{C}}_{i2} \oplus_q \tilde{\mathbf{D}}_{i1}, \; r_i^{(2)}$ $\tilde{C}_{i}^{(2)}(x_{i}) = \tilde{C}_{i1} \oplus_{q} \tilde{D}_{i2}$ and $r_{i}^{(3)}$ $\tilde{C}_{i}^{(3)}(x_i) = \tilde{\mathbf{C}}_{i2}^{\mathsf{T}} \tilde{\mathbf{C}}_{i1} \oplus_q \tilde{\mathbf{D}}_{i1}^{\mathsf{T}} \tilde{\mathbf{D}}_{i2}$. Having recovered the subfunctions $\mathbf{p}_i(x_i) = \{p_i^{(1)}\}$ $\binom{1}{i}(x_i),\ p_i^{(2)}$ $\binom{2}{i}(x_i),\ \frac{p_i^{(3)}}{p_i^{(3)}}$ $\binom{3}{i}(x_i)$ and $\mathbf{r}_i(x_i) = \binom{r_i^{(1)}}{i}$ $i^{(1)}(x_i), r_i^{(2)}$ $i^{(2)}(x_i), r_i^{(3)}$ $i^{(3)}(x_i)\},$ the receiver can then first recover the matrix products A[⊺]B and C[⊺]D using (see Section [V\)](#page-22-0):

p_i(x_i) = (p_i^{(1)}(x_i))^{\mathsf{T}} \cdot p_i^{(2)}(x_i) - p_i^{(3)}(x_i) = \tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i , \qquad (82)
$$

$$
r_i(x_i) = (r_i^{(1)}(x_i))^{\mathsf{T}} \cdot r_i^{(2)}(x_i) - r_i^{(3)}(x_i) = \tilde{\mathbf{C}}_i^{\mathsf{T}} \tilde{\mathbf{D}}_i , \qquad (83)
$$

as well as the relations [\(56\)](#page-22-4) and [\(57\)](#page-23-1) to build A[⊺]B and C[⊺]D from [\(82\)](#page-30-0) and [\(83\)](#page-30-1). It can then multiply A[⊺]B and C[⊺]D together by exploiting the following relation:

$$
(\tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i) \cdot (\tilde{\mathbf{C}}_i^{\mathsf{T}} \tilde{\mathbf{D}}_i) = p_i(x_i) \cdot r_i(x_i) \tag{84}
$$

Instead of building [\(84\)](#page-30-2) from [\(82\)](#page-30-0) and [\(83\)](#page-30-1), an alternative approach to computing $\tilde{A}_i^{\dagger} \tilde{B}_i \tilde{C}_i^{\dagger} \tilde{D}_i$ is to exploit the encoding scheme of Körner-Marton [\[16\]](#page-74-15) for distributed computation of the set of subfunctions $p_i^{(1)}$ $i^{(1)}(x_i) \bigoplus_q r_i^{(1)}$ $j_i^{(1)}(x_i), p_i^{(1)}$ $i^{(1)}(x_i) \bigoplus_q r_i^{(2)}$ $i^{(2)}(x_i)$, and $p_i^{(2)}$ $i^{(2)}(x_i) \bigoplus_q r_i^{(1)}$ $i^{(1)}(x_i)$ at worker $i \in \Omega$, and then compute the products of the linear combinations of the subfunctions to obtain

$$
(p_i^{(1)}(x_i) \oplus_q r_i^{(1)}(x_i))^{\mathsf{T}} \cdot (p_i^{(1)}(x_i) \oplus_q r_i^{(2)}(x_i)),
$$

\n
$$
(p_i^{(1)}(x_i) \oplus_q r_i^{(1)}(x_i))^{\mathsf{T}} \cdot (p_i^{(2)}(x_i) \oplus_q r_i^{(1)}(x_i)),
$$
\n(85)

which can be interpolated to recover $(p_i^{(1)})$ $j_i^{(1)}(x_i))^{\intercal} \cdot p_i^{(2)}$ $i^{(2)}(x_i)$ and $(r_i^{(1)}$ $i^{(1)}(x_i)\big)^{\intercal} \cdot r_i^{(2)}$ $i^{(2)}(x_i)$, along with $p_i^{(3)}$ $i^{(3)}(x_i)$ and $r_i^{(3)}$ $\tilde{A}_i^{(3)}(x_i)$, to then extract $\tilde{A}_i^{\dagger} \tilde{B}_i \tilde{C}_i^{\dagger} \tilde{D}_i$. We leave this extension as future work.

The hierarchical model in [\(84\)](#page-30-2) is not secure, as the receiver first obtains individual 2-matrix products (e.g., $A^{\dagger}B$ and $C^{\dagger}D$) and then combines them for the chain matrix product. We next propose a recursive approach to prevent the receiver from fully extracting each submatrix product.

B. A Recursive Approach to Distributed Chain Matrix Multiplication

We next detail a recursive approach to distributed chain matrix multiplication $ABC \cdots$, where the matrices A, B, C \cdots have $m \times m$ entries each. Exploiting the linear preprocessing approach in [\(57\)](#page-23-1), the master node devises A_i and B_i across workers $i \in \Omega$. Here, for general $s \ge 1$, we detail our approach for $N_c = 3$ and $N_c = 4$; generalizations to odd and even N_c follow accordingly.

a) The Curious Case of $N_c = 3$. In this special case, we aim to compute $\tilde{A}_i^T \tilde{B}_i \tilde{C}_i^T$ at worker $i \in \Omega$, where the matrices assigned to the worker are given in the row-block form:

$$
\tilde{\mathbf{A}}_i = \begin{bmatrix} \tilde{\mathbf{A}}_{i1} \\ \tilde{\mathbf{A}}_{i2} \end{bmatrix} \in \mathbb{F}_q^{\frac{m}{s_r} \times \frac{m}{s_c}}, \quad \tilde{\mathbf{B}}_i = \begin{bmatrix} \tilde{\mathbf{B}}_{i1} \\ \tilde{\mathbf{B}}_{i2} \end{bmatrix} \in \mathbb{F}_q^{\frac{m}{s_r} \times \frac{m}{s_c}}, \quad \tilde{\mathbf{C}}_i = \begin{bmatrix} \tilde{\mathbf{C}}_{i1} \\ \tilde{\mathbf{C}}_{i2} \end{bmatrix} \in \mathbb{F}_q^{\frac{m}{s_r} \times \frac{m}{s_c}}, \quad (86)
$$

where submatrices have identical dimensions. We rewrite $\tilde{A}_{i}^{\dagger} \tilde{B}_{i} \tilde{C}_{i}^{\dagger}$ as

$$
\tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_i^{\mathsf{T}} = \begin{bmatrix} \tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{D}}_i & \tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{E}}_i \end{bmatrix} , \tag{87}
$$

where matrices $\tilde{\mathbf{D}}_i \in \mathbb{F}_q^{\frac{m}{s_r} \times \frac{m}{2s_r}}$ and $\tilde{\mathbf{E}}_i \in \mathbb{F}_q^{\frac{m}{s_r} \times \frac{m}{2s_r}}$ satisfy

$$
\tilde{\mathbf{D}}_i = \begin{bmatrix} \tilde{\mathbf{D}}_{i1} \\ \tilde{\mathbf{D}}_{i2} \end{bmatrix} = \tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i1}^{\mathsf{T}} = \begin{bmatrix} \tilde{\mathbf{B}}_{i1} \tilde{\mathbf{C}}_{i1}^{\mathsf{T}} \\ \tilde{\mathbf{B}}_{i2} \tilde{\mathbf{C}}_{i1}^{\mathsf{T}} \end{bmatrix} , \quad \tilde{\mathbf{E}}_i = \begin{bmatrix} \tilde{\mathbf{E}}_{i1} \\ \tilde{\mathbf{E}}_{i2} \end{bmatrix} = \tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i2}^{\mathsf{T}} = \begin{bmatrix} \tilde{\mathbf{B}}_{i1} \tilde{\mathbf{C}}_{i2}^{\mathsf{T}} \\ \tilde{\mathbf{B}}_{i2} \tilde{\mathbf{C}}_{i2}^{\mathsf{T}} \end{bmatrix} . \tag{88}
$$

We next characterize the complexities for distributed recursive 3-matrix multiplication.

Proposition 23. (Computation cost for 3-matrix products.) *For the distributed recursive computation of a* 3*-matrix product* A[⊺]BC[⊺] *, the total computation complexity of the master node, the computation complexity per worker, and the recovery threshold are as follows:*

\Theta\Big(N\big(\frac{m^3}{2s_r s_c^2} + \frac{m^3}{s_r^2 s_c} + \frac{m^3}{4s_r^3} + \frac{2m^2}{s_r s_c} + \frac{2m^2}{s_c^2}\big)\Big), \quad \Theta\Big(2\frac{m^3}{s_r s_c^2} + 4\frac{m^2}{s_c^2}\Big),
$$

$$
N_{r_{\text{StPolyDot}}} = s_c^2(2s_r - 1) + s_c(2s_r - 1)\frac{s_r}{2} \ .
$$
 (89)

Proof. See Appendix [G.](#page-69-1)

b) The Curious Case of $N_c = 4$: In this special case, we aim to compute $\tilde{A}_i^T \tilde{B}_i \tilde{C}_i^T \tilde{D}_i$ at worker $i \in \Omega$. We rewrite this matrix product as

$$
\tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_i^{\mathsf{T}} \tilde{\mathbf{D}}_i = \left[\tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i1}^{\mathsf{T}} \quad \tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i2}^{\mathsf{T}} \right] \tilde{\mathbf{D}}_i = \tilde{\mathbf{A}}_i^{\mathsf{T}} (\tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i1}^{\mathsf{T}} \tilde{\mathbf{D}}_{i1} + \tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i2}^{\mathsf{T}} \tilde{\mathbf{D}}_{i2}) = \tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{E}}_i , \qquad (90)
$$

where $\tilde{\mathbf{A}}_i$, $\tilde{\mathbf{B}}_i$, $\tilde{\mathbf{C}}_i$, $\tilde{\mathbf{D}}_i \in \mathbb{F}_q^{\frac{m}{s_r} \times \frac{m}{s_c}}$, and $\tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i1}^{\intercal}$ and $\tilde{\mathbf{B}}_i \tilde{\mathbf{C}}_{i2}^{\intercal}$ satisfy [\(88\)](#page-30-3).

We next characterize the complexities for distributed recursive 4-matrix multiplication.

Proposition 24. (Computation cost for 4-matrix products.) *For distributed recursive computation of a* 4*-matrix product* A[⊺]BC[⊺]D*, the total computation complexity of the master node, the computation complexity per worker, and the recovery threshold are as follows:*

\Theta\Big(N\big(\frac{3m^3}{s_r s_c^2} + \frac{5m^2}{2s_r s_c} + \frac{2m^2}{s_c^2}\big)\Big) , \quad \Theta\Big(\frac{m^3}{s_r s_c^2} + 2\frac{m^2}{s_c^2}\Big) , \quad N_{r\text{StPolyDot}} = 2s_c^2(2s_r - 1) . \tag{91}
$$

Proof. See Appendix [H.](#page-71-0)

Achievable communication and computation gains η_{Comm} and χ_{Comp} , as functions of m, s_r and s_c , can be analyzed similarly to Propositions [20](#page-28-2)[-21,](#page-28-3) using Tables [III](#page-26-0)[-IV.](#page-27-2) For chain matrix multiplication with $N_c > 2$, we can recursively build N_c -matrix products from 2-matrix products, as in Section [VII-A](#page-29-1) and [\[7\]](#page-74-6). Detailed analysis is deferred to future work.

We next study an information-theoretically secure construction of StPolyDot codes.

VIII. INFORMATION-THEORETICALLY SECURE STPOLYDOT CODES

The objective here is distributed computation of $\mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{m \times m}$ without revealing any information about A and B when any up to ℓ workers collude. We denote a subset of workers $\mathcal{L} = \{i_1, i_2, \ldots, i_\ell\} \subseteq [N]$ such that $|\mathcal{L}| = \ell$ and the encodings in the subset \mathcal{L} are given by $\tilde{A}_{\mathcal{L}} = \{\tilde{A}_{i_1}, \tilde{A}_{i_2}, \ldots, \tilde{A}_{i_\ell}\}\$ and $\tilde{B}_{\mathcal{L}} = \{\tilde{B}_{i_1}, \tilde{B}_{i_2}, \ldots, \tilde{B}_{i_\ell}\}\.$ This scheme is *informationtheoretically secure* if A and B are perfectly secure from any secret shares, i.e., the encoded matrices $A_{\mathcal{L}}$ and $B_{\mathcal{L}}$, for $\mathcal{L} \subseteq \Omega$, that can be accessed by a set of up to $|\mathcal{L}| = \ell_A$ and $|\mathcal{L}| = \ell_B$ colluding workers must not leak anything about A and B, respectively. In other words, this scheme satisfies the constraint:

$$
I(\mathbf{A}, \mathbf{B}; \tilde{\mathbf{A}}_{\mathcal{L}}, \tilde{\mathbf{B}}_{\mathcal{L}}) = 0 \ , \quad \forall \mathcal{L} \subseteq \Omega \ , \quad |\mathcal{L}| = \min\{\ell_{\mathbf{A}}, \ \ell_{\mathbf{B}}\} \ . \tag{92}
$$

The correct decoding constraint for the receiver to successfully recover $A^{\dagger}B$ is given by

$$
H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B} \mid \tilde{\mathbf{A}}_{\mathcal{L}}, \tilde{\mathbf{B}}_{\mathcal{L}}) = 0 \;, \quad |\mathcal{L}| \ge N_r \;, \tag{93}
$$

i.e., the receiver collects outputs from a subset of workers with a cardinality at least $|\mathcal{L}| =$ N_r [\[31\]](#page-75-24).

 \Box

To that end, we next exploit and generalize the fully secure (polynomial-based) encoding scheme of [\[30\]](#page-74-26) for matrix multiplication, by incorporating two sets of ℓ^2 random matrices, namely $\mathbf{K}_{j,k}^{\mathbf{A}} \in \mathbb{F}_q^{\frac{m_A}{s_r} \times \frac{m}{s_c}}$ and $\mathbf{K}_{j,k}^{\mathbf{B}} \in \mathbb{F}_q^{\frac{m_A}{s_r} \times \frac{m}{s_c}}$, for $j, k \in \{0, \ldots, \ell-1\}$ that are independent of A and B , and with i.i.d. entries. Given submatrices in [\(55\)](#page-22-3), exploiting the random matrix construction, we generalize the linear processing functions at the master node, given in [\(57\)](#page-23-1), as:

$$
\tilde{\mathbf{A}}_{i} \triangleq \sum_{j=0}^{\bar{s}_{r}-1} \sum_{k=0}^{\bar{s}_{r}-1} \mathbf{A}_{j,k} x_{i}^{k} x_{i}^{\bar{s}_{c}j} \n= \sum_{j=0}^{s_{r}-1} \sum_{k=0}^{s_{c}-1} \mathbf{A}_{j,k} x_{i}^{k} x_{i}^{\bar{s}_{c}j} + \sum_{j=0}^{\ell-1} \sum_{k=0}^{\ell-1} \mathbf{K}_{j,k}^{\mathbf{A}} x_{i}^{k+s} x_{i}^{\bar{s}_{c}(j+s_{r})} \in \mathbb{F}_{q}^{\frac{m_{A}}{s_{r}}} \times \frac{m}{s_{c}}, \quad i \in \Omega, \qquad (94)
$$
\n
$$
\tilde{\mathbf{B}}_{i} \triangleq \sum_{j=0}^{\bar{s}_{r}-1} \sum_{k=0}^{\bar{s}_{c}-1} \mathbf{B}_{j,k} x_{i}^{\bar{s}_{c}(\bar{s}_{r}-1-j)} x_{i}^{\bar{s}_{c}(2\bar{s}_{r}-1)k} \n= \sum_{j=0}^{s_{r}-1} \sum_{k=0}^{s_{c}-1} \mathbf{B}_{j,k} x_{i}^{\bar{s}_{c}(\bar{s}_{r}-1-j)} x_{i}^{\bar{s}_{c}(2\bar{s}_{r}-1)k} \n+ \sum_{j=0}^{\ell-1} \sum_{k=0}^{\ell-1} \mathbf{K}_{j,k}^{\mathbf{B}} x_{i}^{\bar{s}_{c}(\bar{s}_{r}-1-(j+s_{r}))} x_{i}^{\bar{s}_{c}(2\bar{s}_{r}-1)(k+s_{c})} \in \mathbb{F}_{q}^{\frac{m_{A}}{s_{r}}} \times \frac{m}{s_{c}}, \quad i \in \Omega, \qquad (95)
$$

where the notations $\mathbf{A}_{j+s_c,k+s_r} = \mathbf{K}^{\mathbf{A}}_{j,k}$ and $\mathbf{B}_{j+s_c,k+s_r} = \mathbf{K}^{\mathbf{B}}_{j,k}$, where $j, k \in \{0, \ldots, \ell-1\}$, denote the pseudo extensions for A and B, respectively. In [\(94\)](#page-32-1) and [\(95\)](#page-32-2), $\bar{s}_c = s_c + \ell$ and $\bar{s}_r = s_r + \ell$ such that $\bar{s}_c \bar{s}_r = N$. When $\bar{s}_r = \bar{s}_c = \bar{s}$, we have $\bar{s}^2 = (s + \ell)^2 |_{\ell=0} = N$.

Proposition 25. (Information-theoretic security.) *The StPolyDot construction with* A_i *and* B_i *given in [\(94\)](#page-32-1) and [\(95\)](#page-32-2), respectively, is information-theoretically secure.*

Proof. See Appendix [I.](#page-72-0)

Next, we contrast StPolyDot codes with the existing approaches, via numerical examples.

IX. NUMERICAL EVALUATIONS OF STPOLYDOT CODES

For the proposed master-workers-receiver framework, we now provide numerical evaluations to contrast StPolyDot codes with the prior work, namely [\[6\]](#page-74-5) and [\[7\]](#page-74-6). More specifically, we investigate the communication and computation costs per worker, the total costs of communication and computation, and how they behave as functions of N_r for different memory parameters s.

In Figure [6,](#page-33-0) utilizing [\(70\)](#page-26-2), we numerically evaluate the total communication cost of workers for computing an element of $\mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{m \times m}$, i.e., the total number of transmitted symbols normalized by m^2 . The curves for PolyDot and StPolyDot codes overlap because in both approaches worker $i \in \Omega$ computes and then transmits $\tilde{A}_{i}^{\dagger} \tilde{B}_{i}$. On the other hand, the total communication cost — including the cost from the master nodes — given in Figure [7](#page-33-1) showcases that for the same set of parameters, our technique, by leveraging the benefits of *structured source coding*, can significantly reduce the amount of communication from the master nodes to the workers.

In Figure [7,](#page-33-1) we demonstrate the aggregate communication cost from the master to workers and from workers to the receiver. As s_r approaches 1, as Proposition [20](#page-28-2) suggests $\eta_{\text{Comm}} = 2$. When N_r is small, the receiver can recover A^TB at a higher communication cost because the

communication cost from the master is high. Note when $\frac{m_A}{s} \approx m$ for MatDot and StMatDot, where $s = s_r$, the master communication costs are identical for both, whereas for StPolyDot the master-communication cost can be made smaller (see Table [IV\)](#page-27-2). The total communication costs for PolyDot and StPolyDot can be made equal when $\frac{m_A}{s_r} \approx \frac{m}{s_c}$ $\frac{m}{s_c}$.

In Figure [8,](#page-34-1) exploiting the computation cost of worker for StPolyDot given in [\(67\)](#page-25-2) determined

as a function of $\{m_A, m, s_r, s_c\}$, we illustrate the computation cost per worker for computing A^TB , i.e., the total number of operations is normalized by the number of workers N, and contrast with that of PolyDot codes in Table [III.](#page-26-0) With s and m_A fixed, the costs for both models scale quadratically with m, and their costs relative to N_r will appear identical.

In Figure [9,](#page-35-0) we demonstrate the total computation costs of the end-to-end framework, for PolyDot and StPolyDot codes, excluding the decoding costs, as outlined in [\(72\)](#page-27-3), required to recover A[⊤]B by interpolating submatrix products $\tilde{A}_i^T \tilde{B}_i \in \mathbb{F}_q^{\frac{m}{8c} \times \frac{m}{8c}}$ in [\(61\)](#page-24-3) (see Section [V-C\)](#page-27-1).

Our numerical results demonstrate that PolyDot codes are more powerful from a *computational complexity perspective* and StPolyDot codes are more efficient from the *standpoint of communication cost* because they can capture the benefits of structured source coding. Furthermore, at large s, the computational complexity of StPolyDot codes approaches that of PolyDot codes. The complementary nature of these two schemes allows us to provide a more general design tradeoff space between the two designs (depending on the set of parameters s, m_A, m).

X. CONCLUSIONS

We tackle the well-known open problem of distributed computing of bilinear functions, including dot products and matrix products, which form an important class of non-linear functions. Our main contributions are: i) *new structured source codes* that operate on non-linear source transformations carefully calibrated to work synergistically with the structured linear encoding scheme by Körner and Marton, and subsequently applying these findings to the practical masterworker-receiver framework by designing ii) *new structured polynomial codes (StPolyDot codes)* for distributed matrix multiplication by incorporating a small amount of non-linearity that captures the structure of the problem. Our codes can surpass the performance of the state of the art, providing savings in the communication cost up to a factor of 2, incurring minimal computation overhead in the large memory parameter regime. The proposed framework can be adapted to

support chain matrix multiplication and information-theoretically secure computations. Privacy and security-related aspects can be reinforced using PIR, secret sharing, and error correction techniques, though further research is required to quantify these ramifications.

Our results are asymptotically accurate, as they rely on distributed computing of matrix products employing lossless compression of infinite-length source realizations. For exact recovery, coding techniques, such as zero-error adaptations [\[136\]](#page-77-24) and [\[137\]](#page-77-25), could be employed. It is possible to exploit *lossy StPolyDot codes* to obtain approximate representations under distortion constraints and one-shot variants of [\[16\]](#page-74-15), e.g., [\[71\]](#page-76-1) and [\[138\]](#page-77-26) to devise codes for finite lengths. We leave these explorations for future work.

The proposed framework is not without limitations. For instance, to compute general square matrix product, the work here considers a recursive and nested application of the distributed dot product computation technique in Proposition [1](#page-9-1) (Section [III-E\)](#page-15-0) as well as a careful calibration of the Ahlswede-Han approach (Section [IV-B\)](#page-21-1). Further research is required to implement tighter achievability schemes, extend our coding constructions to general problem dimensions, general finite fields, and general class of sources, for scalable chain matrix and tensor multiplications. Computational costs can be reduced by leveraging Strassen-like algorithms, e.g., [\[115\]](#page-77-16), [\[122\]](#page-77-13)– [\[124\]](#page-77-15), that reduce the number of multiplications. Future work will focus on general matrix products, including special cases like simultaneously diagonalizable matrices, outer products, and Hadamard products, addressing the problems of distributed rank computation, matrix decomposition and low-rank matrix factorization. We will explore tighter bounds for distributed computing of a broader class of non-linear functions, using *a two-stage hybrid coding scheme* that combines Körner-Marton's structured scheme with Orlitsky-Roche's unstructured model.

APPENDIX A

PROOFS OF MAIN RESULTS ON DISTRIBUTED STRUCTURED MATRIX MULTIPLICATION

In this part, we provide the proofs for the main results on distributed structured matrix multiplication, detailed in Sections [III](#page-8-0) and [IV.](#page-18-0)

A. Proof of Proposition [1](#page-9-0)

Given two distributed even-length source vectors A and B, the receiver aims to compute the dot product $d = \langle \mathbf{A}, \mathbf{B} \rangle = \sum_{i=1}^{m} a_i b_i$, with entries from a field of characteristic $q \geq 2$. Here, we focus on $q = 2$, and the generalization to $q > 2$ is straightforward [\[17\]](#page-74-0).

Encoding: Sources devise mappings $g_1 : A \rightarrow X_1$ and $g_2 : B \rightarrow X_2$, respectively, defined below, to determine the binary-valued column vectors

$$
\mathbf{X}_1 = g_1(\mathbf{A}) = \begin{bmatrix} \mathbf{A}_2 \\ \mathbf{A}_1 \\ \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \end{bmatrix} \in \mathbb{F}_2^{(m+1)\times 1} , \quad \mathbf{X}_2 = g_2(\mathbf{B}) = \begin{bmatrix} \mathbf{B}_1 \\ \mathbf{B}_2 \\ \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \end{bmatrix} \in \mathbb{F}_2^{(m+1)\times 1} . \quad (96)
$$

The construction (for vector partitions) in [\(4\)](#page-8-1) and the non-linear transformations in [\(96\)](#page-36-0) are shown in Figure [10,](#page-36-1) where the parity bits $\mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \in \mathbb{F}_q$ and $\mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \in \mathbb{F}_q$ are indicated in green.

The non-linear mappings $X_1^n, X_2^n \in \mathbb{F}_2^{(m+1)\times n}$ $\binom{m+1}{2}$ are obtained via employing [\(96\)](#page-36-0) to the length *n* realizations of the source vectors $A \in \mathbb{F}_q^{m \times 1}$ and $B \in \mathbb{F}_q^{m \times 1}$. The encoders of the source mappings $\{X_{1i}\}\$ and $\{X_{2i}\}\$ are defined by $f_1: X_1^n \to \mathcal{R}_{f_1}$ and $f_2: X_2^n \to \mathcal{R}_{f_2}$, where \mathcal{R}_{f_1} and \mathcal{R}_{f_2} denote the ranges of f_1 and f_2 , respectively. The pair of functions (f_1, f_2) is called an (n, ϵ) -coding scheme if there exists a function $\phi : \mathcal{R}_{f_1} \times \mathcal{R}_{f_2} \to \mathcal{Z}^n$ such that by letting

$$
\hat{\mathbf{Z}}^n \triangleq \phi(f_1(\mathbf{X}_1^n), f_2(\mathbf{X}_2^n)) \tag{97}
$$

we have $\mathbb{P}(\hat{\mathbf{Z}}^n \neq \mathbf{Z}^n) < \epsilon$. Here, Z is the modulo-two sum of \mathbf{X}_1 and \mathbf{X}_2 , i.e.,

$$
\mathbf{Z} = \mathbf{X}_1 \oplus_2 \mathbf{X}_2 \in \mathbb{F}_2^{(m+1)\times 1} . \tag{98}
$$

Our encoding scheme requires a well-known lemma of Elias [\[125\]](#page-77-0), which showed that linear codes achieve the capacity of binary symmetric channels, and its adaption to the problem of

computing the modulo-two sum of DSBSs in [\[16\]](#page-74-1). Using a simple generalization of this result to vector variables, for fixed $\epsilon > 0$ and for sufficiently large n, there exists a binary matrix $\mathcal{C} \in \mathbb{F}_2^{\kappa \times n}$, where $f_1(\mathbf{X}_1^n) \triangleq \mathcal{C}(\mathbf{X}_1^n) = \mathcal{C} \cdot (\mathbf{X}_1^n)^\intercal \in \mathbb{F}_2^{\kappa \times (m+1)}$ $\mathcal{L}_2^{k \times (m+1)}$ and $f_2(\mathbf{X}_2^n) \triangleq \mathcal{C} \cdot (\mathbf{X}_2^n)^\intercal \in \mathbb{F}_2^{\kappa \times (m+1)}$ 2 denote the modulo-two product of the matrix C with the transpose of the binary vector sequences \mathbf{X}_1^n and \mathbf{X}_2^n , respectively, and a decoding function $\psi: \{0,1\}^{\kappa \times (m+1)} \to \{0,1\}^{n \times (m+1)}$ that satisfy

$$
\phi(f_1(\mathbf{X}_1^n), f_2(\mathbf{X}_2^n)) \triangleq \psi(f_1(\mathbf{X}_1^n) \oplus_2 f_2(\mathbf{X}_2^n))
$$

such that i) $\kappa < n(H(\mathbf{Z}) + \epsilon)$, and ii) $\mathbb{P}(\psi(\mathcal{C}(\mathbf{Z}^n)) \neq \mathbf{Z}^n) < \epsilon$. Hence, application of Elias's lemma [\[125\]](#page-77-0) (cf. Lemma [1\)](#page-18-1) and [\[16\]](#page-74-1) yields that (C, C) is an (n, ϵ) -coding scheme.

Decoding: Exploiting the achievability result of Körner-Marton [\[16\]](#page-74-1), the sum rate needed for the receiver to recover the vector sequence $\mathbf{Z}^n = \mathbf{X}_1^n \oplus_2 \mathbf{X}_2^n \in \mathbb{F}_2^{(m+1)\times n}$ $\binom{(m+1)\times n}{2}$, with a vanishing error probability can be determined as [\[16\]](#page-74-1):

$$
R_{\text{KM}}^{\Sigma} = 2H(\mathbf{U}, \mathbf{V}, W) \tag{99}
$$

Using ψ in ii), the receiver can recover \mathbb{Z}^n . However, lossless decoding of \mathbf{X}_1^n and \mathbf{X}_2^n is not guaranteed. This result is tight, and for any sum rate below R_{KM}^{Σ} in [\(99\)](#page-37-0), the lossless recovery of $\{U, V, W\}$ is not possible. Note that R_{KM}^{Σ} is sufficient to recover $d = \langle \mathbf{A}, \mathbf{B} \rangle$ using $\hat{\mathbf{Z}}^n$:

$$
\mathbf{U}^{\mathsf{T}}\mathbf{V} - W = (\mathbf{A}_2^{\mathsf{T}} \oplus_2 \mathbf{B}_1^{\mathsf{T}})(\mathbf{A}_1 \oplus_2 \mathbf{B}_2) - (\mathbf{A}_2^{\mathsf{T}}\mathbf{A}_1 \oplus_2 \mathbf{B}_1^{\mathsf{T}}\mathbf{B}_2)
$$

= $\mathbf{B}_1^{\mathsf{T}}\mathbf{A}_1 \oplus_2 \mathbf{A}_2^{\mathsf{T}}\mathbf{B}_2 \stackrel{(a)}{=} \mathbf{A}_1^{\mathsf{T}}\mathbf{B}_1 \oplus_2 \mathbf{A}_2^{\mathsf{T}}\mathbf{B}_2 = d$, (100)

where in (a) we used $B_1^{\dagger}A_1 = A_1^{\dagger}B_1 \in \mathbb{F}_2$. Combining [\(99\)](#page-37-0) with [\(100\)](#page-37-1) gives the achievability result we seek. The extension to $q > 2$ is derived from Han-Kobayashi [\[17,](#page-74-0) Lemma 4] and Ahlswede-Han [\[60,](#page-75-0) p. 411].

We adapt the proposed encoding to the case of odd-length vectors in Appendix [A-B.](#page-37-2) Similarly, these ideas can be generalized to distributed multiplication of matrices $A, B \in \mathbb{F}_q^{m \times l}$ (see Sections [III-C](#page-13-0) and [III-D](#page-14-0) for symmetric and general square matrices, respectively).

B. Distributed Dot Product Computation for Odd-Length Source Vectors

Given two odd-length source vectors $\mathbf{A}, \ \mathbf{B} \in \mathbb{F}_q^m$, i.e., $m \in \{2i + 1 : i \in \mathbb{Z}^{0+}\}$, where \mathbb{Z}^{0+} denotes non-negative integers, we split the source vectors A and B such that

$$
\mathbf{A}_{1}^{\mathsf{T}} = \begin{bmatrix} a_{1} & a_{2} & \dots & a_{\frac{m-1}{2}} & 0 \end{bmatrix} \in \mathbb{F}_{q}^{1 \times \frac{m+1}{2}}, \quad \mathbf{A}_{2}^{\mathsf{T}} = \begin{bmatrix} a_{\frac{m+1}{2}} & a_{\frac{m+3}{2}} & \dots & a_{m} \end{bmatrix} \in \mathbb{F}_{q}^{1 \times \frac{m+1}{2}},
$$
\n
$$
\mathbf{B}_{1}^{\mathsf{T}} = \begin{bmatrix} b_{1} & b_{2} & \dots & b_{\frac{m+1}{2}} \end{bmatrix} \in \mathbb{F}_{q}^{1 \times \frac{m+1}{2}}, \quad \mathbf{B}_{2}^{\mathsf{T}} = \begin{bmatrix} b_{\frac{m+1}{2}} & b_{\frac{m+3}{2}} & \dots & b_{m} \end{bmatrix} \in \mathbb{F}_{q}^{1 \times \frac{m+1}{2}}, \quad (101)
$$

where note that the last element of $\mathbf{A}_1 \in \mathbb{F}_q^{\frac{m+1}{2} \times 1}$ is 0, i.e., $\mathbf{A}_1(\frac{m+1}{2}) = 0$, and the last element in $\mathbf{B}_1 \in \mathbb{F}_q^{\frac{m+1}{2} \times 1}$ and the first element in $\mathbf{B}_2 \in \mathbb{F}_q^{\frac{m+1}{2} \times 1}$ are $b_{\frac{m+1}{2}}$, i.e., $\mathbf{B}_1(\frac{m+1}{2}) = \mathbf{B}_2(1) = b_{\frac{m+1}{2}}$. The sources then devise, respectively, the following non-linear mappings:

$$
\mathbf{X}_1 = \begin{bmatrix} \mathbf{A}_2 \\ \mathbf{A}_1 \\ \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \end{bmatrix} \in \mathbb{F}_q^{(m+2)\times 1} \;, \quad \mathbf{X}_2 = \begin{bmatrix} \mathbf{B}_1 \\ \mathbf{B}_2 \\ \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \end{bmatrix} \in \mathbb{F}_q^{(m+2)\times 1} \; . \tag{102}
$$

Using the Körner-Marton-based encoding approach in the proof of Proposition [1,](#page-9-0) the sum rate needed for the receiver to recover $X_1 \oplus_q X_2$ in an asymptotic lossless manner satisfies

$$
R_{\text{KM}}^{\Sigma} = 2H_q(\mathbf{A}_2 \oplus_q \mathbf{B}_1, \mathbf{A}_1 \oplus_q \mathbf{B}_2, \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2) .
$$
 (103)

 $A_1(1 : \frac{m-1}{2})$ We next show that the receiver can reconstruct $A^{\dagger}B$ using $U = A_2 \oplus_q B_1$, $V = A_1 \oplus_q B_2 =$ $\overline{0}$ 1 \oplus_q $\left[\mathbf{B}_{2}(2^{\frac{2}{2}} \frac{m+1}{2}) \right.$ 1 , and $\mathbf{W} = \mathbf{A}_{2}^{\mathsf{T}} \mathbf{A}_{1} \oplus_{q} \mathbf{B}_{1}^{\mathsf{T}} \mathbf{B}_{2}$. To that end, the receiver evaluates $\mathbf{U}^{\intercal}\cdot\mathbf{V}-\mathbf{W}=(\mathbf{A}_2\oplus_q \mathbf{B}_1)^{\intercal}\cdot(\mathbf{A}_1\oplus_q \mathbf{B}_2)-(\mathbf{A}_2^{\intercal}\mathbf{A}_1\oplus_q \mathbf{B}_1^{\intercal}\mathbf{B}_2)$ $=$ B_1^{\dagger} 1 $A_1(1:\frac{m-1}{2})$ $\overline{0}$ 1 $\oplus_q\mathbf{A}_2^\intercal$ 2 $\left[\mathbf{B}_2(2\cdot\frac{m+1}{2})\right.$ 1 $=$ \sum $i \in [\frac{m-1}{2}]$ $a_ib_i \oplus_q \quad \sum$ $i \in [\frac{m+1}{2}, m]$ $a_i b_i = \mathbf{A}^\mathsf{T} \mathbf{B}$, (104)

which gives the dot product of odd-length source vectors, complementing the discussion for the even-length source vectors (cf. Section [III-A\)](#page-8-2).

C. Proof of Corollary [1](#page-9-1)

We note from [\(8\)](#page-9-2) that $a_{\frac{m}{2}+i} \sim \text{Bern}(\frac{1}{2})$ $(\frac{1}{2})$ and $b_i \sim \text{Bern}(\frac{1}{2})$ $(\frac{1}{2})$ satisfy $(a_{\frac{m}{2}+i}, b_i) \sim \text{DSBS}(p), i \in$ [m/2], and similarly, $a_i \sim \text{Bern}(\frac{1}{2})$ $(\frac{1}{2})$ and $b_{\frac{m}{2}+i} \sim \text{Bern}(\frac{1}{2})$ $(\frac{1}{2})$ satisfy $(a_i, b_{\frac{m}{2}+i}) \sim \text{DSBS}(p)$, $i \in$ [m/2]. From [\(8\)](#page-9-2), U and V in [\(6\)](#page-9-3) have entries $u_i, v_i \sim \text{Bern}(p)$, i.i.d. across $i \in [m/2]$.

Employing the definitions of X_1 and X_2 in [\(96\)](#page-36-0), [\(5\)](#page-9-4) and [\[16\]](#page-74-1), from Proposition [1,](#page-9-0) we can determine the sum rate needed for the receiver to recover (U, V, W) in an asymptotic manner:

$$
R_{\text{KM}}^{\Sigma} = 2H(\mathbf{U}, \mathbf{V}, W)
$$

\n
$$
= 2H(\mathbf{U}) + 2H(\mathbf{V}) + 2H(\mathbf{A}_{2}^{T}\mathbf{A}_{1} \oplus_{2} \mathbf{B}_{1}^{T}\mathbf{B}_{2} | \mathbf{U}, \mathbf{V})
$$

\n
$$
\stackrel{(a)}{=} 2 \cdot \frac{m}{2} \cdot h(p) + 2 \cdot \frac{m}{2} \cdot h(p) + 2H(\mathbf{A}_{2}^{T}\mathbf{A}_{1} \oplus_{2} \mathbf{B}_{1}^{T}\mathbf{B}_{2} | \mathbf{U}, \mathbf{V})
$$

$$
\stackrel{(b)}{=} 2mh(p) + 2H(\mathbf{U}^{T}\mathbf{A}_{1} \oplus_{2} \mathbf{A}_{2}^{T}\mathbf{V} | \mathbf{U}, \mathbf{V})

where (a) follows because elements of U and V are i.i.d. \sim Bern(p), (b) follows from employing $U = A_2 \oplus_2 B_1 = \begin{bmatrix} u_1 & u_2 & \dots & u_{m/2} \end{bmatrix}^\mathsf{T}$ and $V = A_1 \oplus_2 B_2 = \begin{bmatrix} v_1 & v_2 & \dots & v_{m/2} \end{bmatrix}^\mathsf{T}$, and rewriting $\mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_2 \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2$ given U and V, (c) from using $\mathbf{Q} =$ $\sqrt{\frac{1}{2}}$ V $\begin{bmatrix} \in \mathbb{F}_2^{m \times 1} \end{bmatrix}$ and $\mathbf{A}_2^{\mathsf{T}} \mathbf{V} = \mathbf{V}^{\mathsf{T}} \mathbf{A}_2$, (d) from employing the definition of Q. Step (e) follows from using the relations $H(\mathbf{Q}^{\intercal} \mathbf{A} | \mathbf{Q}) =$ $H(\mathbf{Q}^\intercal \mathbf{A} \mid \mathbf{Q}^\intercal \mathbf{1}_m)$, and $\mathbf{Q}^\intercal \mathbf{1}_m = \sum$ $i \in [m]$ $y_i \sim B(m, p)$, and denoting the nonzero values of Q by indices $\{i_1, i_2, \ldots, i_j\}$ when $\mathbf{Q}^{\mathsf{T}} \mathbf{1}_m = j$. Hence,

H(\mathbf{Q}^{\mathsf{T}}\mathbf{A} \mid \mathbf{Q}^{\mathsf{T}}\mathbf{1}_m = j) = \begin{cases} 0, & j = 0 \\ H(\mathbf{Q}^{\mathsf{T}}\mathbf{A} \mid \mathbf{Q}^{\mathsf{T}}\mathbf{1}_m = j) & = H\Big(\sum_{i \in \{i_1, i_2, \dots, i_j\}} a_i\Big), & j \ge 1. \end{cases}
$$
(106)

Finally, step (f) holds because given $\mathbf{Q} \neq \mathbf{0}_m$, which holds with probability $1 - (1 - p)^m$, the DSBS model ensures the elements of A are uniformly distributed and independent, i.e., $a_i \stackrel{i.i.d.}{\sim} \text{Bern}(\frac{1}{2})$ $\frac{1}{2}$). Hence, incorporating $H\left(\sum_{i\in\{i_1,i_2,\ldots,i_j\}}a_i\right)=1, j\geq 1$, we obtain [\(105\)](#page-38-0).

The encoding rate for asymptotic lossless compression of A and B is given by

$$
R_{\text{SW}}^{\Sigma} = H(\mathbf{A}, \mathbf{B}) \stackrel{(a)}{=} 2H(\mathbf{A}_1, \mathbf{B}_2)
$$

= $2 \cdot \frac{m}{2} \cdot (1 + h(p)) = m(1 + h(p))$, (107)

following from the Slepian-Wolf theorem [\[15\]](#page-74-2), where (a) follows from using $H(A) = H(A_1, A_2)$ and $H(\mathbf{B}) = H(\mathbf{B}_1, \mathbf{B}_2)$, noting that $\mathbf{A}_1 \perp \mathbf{A}_2$ and $\mathbf{B}_1 \perp \mathbf{B}_2$, where A and B have i.i.d. entries.

From [\(105\)](#page-38-0) and [\(107\)](#page-39-0), it is easy to note that $\eta = R_{\text{SW}}^{\Sigma}/R_{\text{KM}}^{\Sigma}$ is given by [\(9\)](#page-9-5).

D. Proof of Corollary [2](#page-10-0)

Recall that $R_{SW}^{\Sigma} = m(1 + h(p))$, and Proposition [1](#page-9-0) yields a sum rate of

Exploiting [\(108\)](#page-39-1) yields $\lim_{m\to\infty} \eta \geq \frac{1+h(p)}{1+h(2p(1-p))}$, where the RHS is ≤ 1 due to the concavity of $h(\cdot)$, and approaches 1 in the limit as p tends to $\frac{1}{2}$.

E. Proof of Proposition [2](#page-11-0)

We first provide a proof sketch for vector-wise embedding of binary sources. In this case, letting $r = 2m$ for m even, and $r = 2m + 1$ for m odd, respectively, it is easy to verify that

$$
\langle \mathbf{A}, \mathbf{B} \rangle = \left[\frac{1}{2} \Big(\sum_{i \in [m]} a_i \oplus_r b_i - \sum_{i \in [m]} (a_i \oplus_2 b_i) \Big) \right] \mod 2 . \tag{109}
$$

Hence, the following sum rate is achievable for $q = 2$:

$$
R_{\rm SV}^{\Sigma} = 2H\Big(\{a_i \oplus_2 b_i\}_{i \in [m]}, \sum_{i \in [m]} a_i \oplus_r b_i\Big) . \tag{110}
$$

When the data is generated by two correlated memoryless $q \ge 2$ -ary sources, a sum rate of

$$
R_{\rm SV}^{\Sigma} = 2H\left(\{a_i \oplus_r b_i\}_{i \in [m]}, \bigoplus_{i \in [m]} a_i^2 \oplus_q b_i^2\right) \tag{111}
$$

is achievable, where $r = 2(q - 1)m$ and $r = 2(q - 1)m + 1$ for even and odd m, respectively. Upon receiving the symbols $\{a_i \oplus_r b_i\}_{i \in [m]}$ and \bigoplus_q $i \in [m]$ $a_i^2 \oplus_q b_i^2$, the receiver can reconstruct

$$
2c_q = qk + \left(\sum_{i \in [m]} (a_i \oplus_r b_i)^2 - \bigoplus_{i \in [m]} (a_i^2 \oplus_q b_i^2)\right) \mod q \tag{112}
$$

where there is a unique $k \in \mathbb{F}_q$ for which $c_q = \langle \mathbf{A}, \mathbf{B} \rangle \in \mathbb{F}_q$.

F. Proof of Proposition [4](#page-12-0)

The receiver aims to compute the matrix-vector product $A^{\dagger}b = d$, with entries from F with $q > 2$. We prove this result for the case of $q = 2$. The generalization to $q > 2$ is straightforward. Encoding: Sources devise the following mappings, respectively:

\mathbf{X}_1 = \begin{bmatrix} \mathbf{A}_2 \\ \mathbf{A}_1 \\ \mathbf{A}_2 \mathbf{A}_1^{\mathsf{T}} \end{bmatrix} \in \mathbb{F}_2^{(m+l) \times l} \;, \quad \mathbf{X}_2 = \begin{bmatrix} \mathbf{b}_1 \mathbf{1}_{1 \times l} \\ \mathbf{b}_2 \mathbf{1}_{1 \times l} \\ \mathbf{1}_{l \times 1} \mathbf{b}_1^{\mathsf{T}} \mathbf{b}_2 \mathbf{1}_{1 \times l} \end{bmatrix} \in \mathbb{F}_2^{(m+l) \times l} \; . \tag{113}
$$

Exploiting the structured encoding approach in Körner-Marton, the sum rate needed for the receiver to recover the matrix $X_1 \oplus_2 X_2$ with a vanishing error probability is determined as [\[16\]](#page-74-1):

R_{\rm KM}^{\Sigma} = 2H(\mathbf{U}, \mathbf{V}, \mathbf{W}) \tag{114}
$$

where U , V , and W are given as follows:

\mathbf{U} = \mathbf{A}_2 \oplus_2 \mathbf{b}_1 \mathbf{1}_{1 \times l} \in \mathbb{F}_2^{\frac{m}{2} \times l},
$$

\mathbf{V} = \mathbf{A}_1 \oplus_2 \mathbf{b}_2 \mathbf{1}_{1 \times l} \in \mathbb{F}_2^{\frac{m}{2} \times l},
$$

\n
$$
\mathbf{W} = \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_2 \mathbf{1}_{l \times 1} \mathbf{b}_1^{\mathsf{T}} \mathbf{b}_2 \mathbf{1}_{1 \times l} \in \mathbb{F}_2^{l \times l}.
$$
 (115)

We next show that the sum rate in [\(114\)](#page-40-0) is sufficient to recover $A^Tb = d$. Recovering $X_1 \oplus_2 X_2 = (U, V, W)$, the receiver computes

$$
\mathbf{U}^{\mathsf{T}} \cdot \mathbf{V} \oplus_2 \mathbf{W} = (\mathbf{A}_2 \oplus_2 \mathbf{b}_1 \mathbf{1}_{1 \times l})^{\mathsf{T}} (\mathbf{A}_1 \oplus_2 \mathbf{b}_2 \mathbf{1}_{1 \times l}) \oplus_2 (\mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_2 \mathbf{1}_{l \times 1} \mathbf{b}_1^{\mathsf{T}} \mathbf{b}_2 \mathbf{1}_{1 \times l})
$$

=
$$
\mathbf{A}_2^{\mathsf{T}} \mathbf{b}_2 \mathbf{1}_{1 \times l} \oplus_2 \mathbf{1}_{l \times 1} \mathbf{b}_1^{\mathsf{T}} \mathbf{A}_1 .
$$
 (116)

Note that the sum of $\alpha = A_1^{\dagger}b_1 \in \mathbb{F}_2^{l \times 1}$ and $\beta = A_2^{\dagger}b_2 \in \mathbb{F}_2^{l \times 1}$ yields $\alpha \oplus_2 \beta = d$. Hence,

$$
\mathbf{U}^{\mathsf{T}} \cdot \mathbf{V} \oplus_2 \mathbf{W} = \mathbf{A}_2^{\mathsf{T}} \mathbf{b}_2 \mathbf{1}_{1 \times l} \oplus_2 \mathbf{1}_{l \times 1} \mathbf{b}_1^{\mathsf{T}} \mathbf{A}_1 = (\beta_i \oplus_2 \alpha_j)_{i, j \in [l]}, \qquad (117)
$$

where it is easy to note that ${[(\mathbf{U}^{\mathsf{T}} \cdot \mathbf{V} \oplus_2 \mathbf{W})_{ii}]}_{i \in [l]} = \mathbf{d}.$

Hence, using [\(114\)](#page-40-0) and [\(116\)](#page-40-1) gives the achievability result we seek.

G. Proof of Proposition [5](#page-13-1)

Given two sequences of random matrices $A, B \in \mathbb{F}_q^{m \times l}$, the receiver aims to compute the symmetric matrix $\mathcal{D} = A^{\dagger}B = B^{\dagger}A \in \mathbb{F}_q^{l \times l}$.

Encoding: Each source uses mappings $g_1: \mathbf{A} \to \mathbf{X}'_1$ and $g_2: \mathbf{B} \to \mathbf{X}'_2$, respectively, to determine the following matrices:

\mathbf{X}'_1 = g_1(\mathbf{A}) = \begin{bmatrix} \mathbf{A}_2 \\ \mathbf{A}_1 \\ \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \end{bmatrix} \in \mathbb{F}_q^{(m+l) \times l} \;, \quad \mathbf{X}'_2 = g_2(\mathbf{B}) = \begin{bmatrix} \mathbf{B}_1 \\ \mathbf{B}_2 \\ \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \end{bmatrix} \in \mathbb{F}_q^{(m+l) \times l} \;, \tag{118}
$$

respectively. We concatenate the columns of X'_1 and X'_2 in [\(118\)](#page-40-2) to obtain the column vectors:

$$
\mathbf{X}_{1} = \begin{bmatrix} \mathbf{X}_{1}^{\prime}(:,1) \\ \mathbf{X}_{1}^{\prime}(:,2) \\ \vdots \\ \mathbf{X}_{1}^{\prime}(:,l) \end{bmatrix} \in \mathbb{F}_{q}^{(m+l)l \times 1}, \quad \mathbf{X}_{2} = \begin{bmatrix} \mathbf{X}_{2}^{\prime}(:,1) \\ \mathbf{X}_{2}^{\prime}(:,2) \\ \vdots \\ \mathbf{X}_{2}^{\prime}(:,l) \end{bmatrix} \in \mathbb{F}_{q}^{(m+l)l \times 1}. \tag{119}
$$

Following the steps of Lemma [1](#page-18-1) and the Proof of Proposition [1,](#page-9-0) we let $\mathbf{Z}(j) = \mathbf{X}_1(j) \oplus_q$ $\mathbf{X}_2(j) \in \mathbb{F}_q$ denote the j-th element of Z, and $\mathbf{Z}^n(j) \in \mathbb{F}_q^{n \times 1}$ its length n realization, where $j \in [(m + l)l]$. For fixed $\epsilon > 0$, $\delta > 0$, and sufficiently large n, we choose a q-ary matrix $\mathcal{C} \in \mathbb{F}_q^{\kappa_j \times n}$ whose elements are all i.i.d. and uniformly distributed in \mathbb{F}_q (cf. Ahlswede-Han [\[60\]](#page-75-0)), and let $f_1(\mathbf{X}_1^n(j)) \triangleq C(\mathbf{X}_1^n) = C \cdot \mathbf{X}_1^n(j) \in \mathbb{F}_q^{\kappa_j \times 1}$ and $f_2(\mathbf{X}_2^n(j)) \triangleq C \cdot \mathbf{X}_2^n(j) \in \mathbb{F}_q^{\kappa_j \times 1}$ denote the modulo-q product of the matrix C with the transpose of the q-ary vector sequences $X_1^n(j)$ and $\mathbf{X}_2^n(j)$, respectively. Then, there exists a decoding function $\psi_j : \mathbb{F}_q^{\kappa_j} \to \mathbb{F}_q^n$ that satisfies [\[60\]](#page-75-0):

\hat{\mathbf{Z}}^n(j) \triangleq \phi_j(f_1(\mathbf{X}_1^n(j)), f_2(\mathbf{X}_2^n(j))) \triangleq \psi_j(f_1(\mathbf{X}_1^n(j)) \oplus_q f_2(\mathbf{X}_2^n(j)))
$$

such that i) $\kappa_j < n(H(\mathbf{Z}(j)) + \epsilon)$, and ii) $\mathbb{P}(\psi_j(\mathcal{C}(\mathbf{Z}^n(j))) \neq \mathbf{Z}^n(j)) < \delta$. Application of Elias's lemma [\[125\]](#page-77-0) to *vector variables*, Lemma [6,](#page-47-0) and [\[16\]](#page-74-1) yields that (C, C) is an (n, ϵ, δ) -coding scheme. Hence, using $\frac{\kappa_j}{n} \approx H_q(\mathbf{Z}(j))$ for all $j \in [(m+l)l]$, and employing Lemma [6,](#page-47-0) the following rate per source can be achieved for computing the symmetric matrix product \mathcal{D} :

\frac{\kappa}{n} < \max\{H_q(\mathbf{Z}(j), j \in [ml])\},

H_q(\mathbf{Z}(j), j \in [ml+1, ml+l^2] \mid \mathbf{Z}(j), j \in [ml])\} + \epsilon \,, \tag{120}
$$

leading to

$$
\kappa = \max \left\{ \sum_{j \in [ml]} \kappa_j , \sum_{j \in [ml+1, (m+l)l]} \kappa_j \right\}.
$$
 (121)

Decoding: Exploiting the achievability result of Körner-Marton [\[16\]](#page-74-1), the sum rate needed for the receiver to recover the $\mathbf{Z}^n = \mathbf{X}_1^n \oplus_q \mathbf{X}_2^n$ with a vanishing error probability is determined as:

$$
R_{\text{KM}}^{\Sigma} = 2H(\mathbf{U}, \mathbf{V}, \mathbf{W}) \tag{122}
$$

To prove the achievability of [\(122\)](#page-41-0) we next show that using $\hat{\mathbf{Z}}^n$, the receiver computes

$$
\frac{1}{2}((\mathbf{U}^{\mathsf{T}}\cdot\mathbf{V}-\mathbf{W})\oplus_{q}(\mathbf{U}^{\mathsf{T}}\cdot\mathbf{V}-\mathbf{W})^{\mathsf{T}})\stackrel{(a)}{=} \frac{1}{2}((\mathbf{A}_{1}^{\mathsf{T}}\mathbf{B}_{1}\oplus_{q}\mathbf{A}_{2}^{\mathsf{T}}\mathbf{B}_{2})\oplus_{q}(\mathbf{A}_{1}^{\mathsf{T}}\mathbf{B}_{1}\oplus_{q}\mathbf{A}_{2}^{\mathsf{T}}\mathbf{B}_{2})^{\mathsf{T}})\stackrel{(b)}{=} \mathbf{\mathcal{D}},
$$
\n(123)

where (a) follows from a reordering of the terms, (b) from employing $\mathcal{D} = \frac{1}{2}$ $\frac{1}{2}(\boldsymbol{\mathcal{D}}\oplus_q \boldsymbol{\mathcal{D}}^{\intercal})$ that holds for symmetric matrix $\mathcal{D} = A^{\mathsf{T}}B \in \mathbb{F}_q^{l \times l}$, with $q > 2$.

H. Proof of Proposition [6](#page-13-2)

We first show that the encoding scheme of Proposition [1](#page-9-0) does not allow the recovery of $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times 1}$ by the receiver, i.e., $H_q(\mathbf{A}, \mathbf{B} \mid \mathbf{A}^{\mathsf{T}} \mathbf{B}, \mathbf{Q}) > 0$, for $m > 1$.

The receiver can recover $Q =$ $\sqrt{\frac{1}{2}}$ V $\Big] \in \mathbb{F}_q^{m \times 1}$ and $W \in \mathbb{F}_q$ with a small probability of error. The extra rate needed from the encoders for the receiver to determine A, $B \in \mathbb{F}_q^{m \times 1}$ is

H_q(\mathbf{A}, \mathbf{B} | \mathbf{A}^{\mathsf{T}} \mathbf{B}, \mathbf{Q}) \stackrel{(a)}{=} H_q(\mathbf{A}, \mathbf{B}, \mathbf{A}^{\mathsf{T}} \mathbf{B}, \mathbf{Q}) - H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B}, \mathbf{Q})
$$

$$
\stackrel{(b)}{=} H_q(\mathbf{A}, \mathbf{B}, \mathbf{Q}) - H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B}, \mathbf{Q})
$$

$$
\stackrel{(c)}{=} H_q(\mathbf{A}, \mathbf{Q}) - H_q(\mathbf{A}^{\mathsf{T}} \mathbf{Q}, \mathbf{Q}) \stackrel{(d)}{=} H_q(\mathbf{A}, \mathbf{A}^{\mathsf{T}} \mathbf{Q}, \mathbf{Q}) - H_q(\mathbf{A}^{\mathsf{T}} \mathbf{Q}, \mathbf{Q}) \stackrel{(e)}{\geq} 0,
$$

where (a) follows from using the definition of conditional entropy and rewriting A[⊤]B as U[⊤]V – W, (b) from $H_q(\mathbf{A}^\intercal \mathbf{B} | \mathbf{Q}, \mathbf{A}, \mathbf{B}) = 0$, (c) from $H_q(\mathbf{B} | \mathbf{A}, \mathbf{Q}) = 0$ and $\mathbf{A}^\intercal \mathbf{B} = \mathbf{A}^\intercal \mathbf{Q}$ given \mathbf{Q} , (d) from $H_q(\mathbf{A}^\intercal \mathbf{Q} | \mathbf{A}, \mathbf{Q}) = 0$, and (e) holds with equality if $g(\mathbf{A}, \mathbf{Q}) = \mathbf{A}^\intercal \mathbf{Q}$ is partially invertible, meaning $H_q(\mathbf{A} | g(\mathbf{A}, \mathbf{Q}), \mathbf{Q}) = 0$, which is satisfied, for example, when g is the arithmetic sum or the modulo sum of the two vectors. Hence, the inequality in (e) is strict for inferring $\mathbf{A}, \mathbf{B} \in \mathbb{F}_q^{m \times 1}$ from Q and W.

We next prove the main result of the proposition. Given matrix variables $A, B \in \mathbb{F}_q^{m \times l}$ such that $q > 2$ and $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$ is symmetric, we first expand R_{KM}^{Σ} as

We next expand the sum rate R_{SW}^{Σ} as

= H_q(\mathbf{U}, \mathbf{V}, \mathbf{A}^{\mathsf{T}} \mathbf{B}) + H_q(\mathbf{A}_1, \mathbf{B}_1, \mathbf{A}_2, \mathbf{B}_2 | \mathbf{A}_2 \oplus_q \mathbf{B}_1, \mathbf{A}_1 \oplus_q \mathbf{B}_2, \mathbf{A}_1^{\mathsf{T}} \mathbf{B}_1 \oplus_q \mathbf{A}_2^{\mathsf{T}} \mathbf{B}_2)
$$

\n
$$
= H_q(\mathbf{U}, \mathbf{V}, \mathbf{A}^{\mathsf{T}} \mathbf{B}) + H_q(\mathbf{A}_1, \mathbf{A}_2 | \mathbf{U}, \mathbf{V}, \mathbf{A}_1^{\mathsf{T}} (\mathbf{U} \oplus_q \mathbf{A}_2) \oplus_q \mathbf{A}_2^{\mathsf{T}} (\mathbf{V} \oplus_q \mathbf{A}_1))
$$

\n
$$
= H_q(\mathbf{Q}, \mathbf{A}^{\mathsf{T}} \mathbf{B}) + H_q(\mathbf{A} | \mathbf{Q}, \mathbf{A}^{\mathsf{T}} \mathbf{Q} \oplus_q \mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \oplus_q \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1)
$$

\n
$$
= H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B}) + H_q(\mathbf{Q} | \mathbf{A}^{\mathsf{T}} \mathbf{B}) + H_q(\mathbf{A} | \mathbf{Q}, \mathbf{A}^{\mathsf{T}} \mathbf{Q} \oplus_q \mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \oplus_q \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1),
$$
\n(125)

where it is easy to observe that $\mathbf{A}^\dagger \mathbf{B} = \mathbf{A}^\dagger$ $\frac{1}{1}(\mathbf{U} \oplus_q \mathbf{A}_2) \oplus_q \mathbf{A}_2^{\intercal}$ $\mathbf{Z}^\intercal(\mathbf{V}\oplus_q \mathbf{A}_1) = \mathbf{A}^\intercal\mathbf{Q} \oplus_q \mathbf{A}_1^\intercal \mathbf{A}_2 \oplus_q \mathbf{A}_2^\intercal \mathbf{A}_1.$ Similarly, via exploiting $\tilde{Q} = \begin{bmatrix} V & 0 \\ 0 & 0 \end{bmatrix}$ U 1 , we can show that

R_{\rm SW}^{\Sigma} = H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B}) + H_q(\mathbf{Q} \mid \mathbf{A}^{\mathsf{T}} \mathbf{B}) + H_q(\mathbf{B} \mid \tilde{\mathbf{Q}}, \tilde{\mathbf{Q}}^{\mathsf{T}} \mathbf{B} \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \oplus_q \mathbf{B}_2^{\mathsf{T}} \mathbf{B}_1), \qquad (126)
$$

where $\mathbf{A}^\intercal \mathbf{B} = \tilde{\mathbf{Q}}^\intercal \mathbf{B} \oplus_q \mathbf{B}_1^\intercal \mathbf{B}_2 \oplus_q \mathbf{B}_2^\intercal \mathbf{B}_1.$

From [\(125\)](#page-42-0) and [\(126\)](#page-42-1), we note that $H_q(\mathbf{A} | \mathbf{A}^\mathsf{T} \mathbf{Q}) = H_q(\mathbf{B} | \tilde{\mathbf{Q}}^\mathsf{T} \mathbf{B})$. Contrasting [\(124\)](#page-42-2) with [\(125\)](#page-42-0), the following condition ensures that $R_{\text{KM}}^{\Sigma} < R_{\text{SW}}^{\Sigma}$.

H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B}) + H_q(\mathbf{Q} \,|\, \mathbf{A}^{\mathsf{T}}\mathbf{B}) < H_q(\mathbf{A} \,|\, \mathbf{Q}, \mathbf{A}^{\mathsf{T}}\mathbf{B}) = H_q(\mathbf{B} \,|\, \tilde{\mathbf{Q}}, \mathbf{A}^{\mathsf{T}}\mathbf{B}) \tag{127}
$$

When $l = 1$, we have $\mathbf{A}_{1}^{\mathsf{T}} \mathbf{A}_{2} = \mathbf{A}_{2}^{\mathsf{T}} \mathbf{A}_{1}$ and $\mathbf{B}_{1}^{\mathsf{T}} \mathbf{B}_{2} = \mathbf{B}_{2}^{\mathsf{T}} \mathbf{B}_{1}$, hence, [\(127\)](#page-42-3) is equivalent to

H_q(\mathbf{A}^\intercal \mathbf{B}) + H_q(\mathbf{Q} \mid \mathbf{A}^\intercal \mathbf{B}) < H_q(\mathbf{A} \mid \mathbf{Q}, \mathbf{A}^\intercal \mathbf{Q}) = H_q(\mathbf{B} \mid \tilde{\mathbf{Q}}, \tilde{\mathbf{Q}}^\intercal \mathbf{B}) \ .

I. Proof of Proposition [7](#page-14-1)

Note that $\mathcal{D}_j = A^{\dagger}B_j$ for $j \in [l]$, where $\mathcal{D}_j = \begin{bmatrix} d_{1j} & d_{2j} & \dots & d_{lj} \end{bmatrix}^{\dagger} \in \mathbb{F}_q^{l \times 1}$. Following the steps of Lemma [1](#page-18-1) and the Proof of Proposition [1](#page-9-0) and Proof of Proposition [A-G,](#page-40-3) the receiver can recover $\{A \oplus_q \tilde{B}_j\}_{j=1}^l$, $\{A^{\dagger}A \oplus_q \tilde{B}_j^{\dagger} \tilde{B}_j\}_{j=1}^l$, and then compute the following $l \times l$ matrix:

$$
\n
$$
= \begin{bmatrix}\nd_{1j} & \oplus_{q} d_{1j} & d_{1j} & \oplus_{q} d_{2j} & \dots & d_{1j} & \oplus_{q} d_{lj} \\
d_{2j} & \oplus_{q} d_{1j} & d_{2j} & \oplus_{q} d_{2j} & \dots & d_{2j} & \oplus_{q} d_{lj} \\
\vdots & \vdots & \ddots & \vdots & \vdots \\
d_{lj} & \oplus_{q} d_{1j} & d_{lj} & \oplus_{q} d_{2j} & \dots & d_{lj} & \oplus_{q} d_{lj}\n\end{bmatrix},
$$

which is a symmetric matrix with l unknowns and $\frac{l(l-1)}{2} \geq l$ linearly independent equations for $l \geq 2$ and $q > 2$. Hence, \mathcal{D}_j , for each $j \in [l]$, as well as $\mathcal D$ can be recovered.

J. Example [1:](#page-14-2) Computation of a Non-Symmetric Matrix Product from Structured Sources Given the PMF in [\(21\)](#page-14-3) with $q = 3$, the sum rate for distributed encoding of (A, B) is

Exploiting Proposition [7](#page-14-1) to compute A[⊺]B, we can achieve

 $\leq 2mh \left(2(\frac{1}{2} - \epsilon) \cdot (1 - p) + 2\epsilon(1 - p), \, 2(\frac{1}{2} - \epsilon) \cdot p + 2\epsilon p \right) + 2\log_2(3)$,

where the last step follows from using that

where (a) follows from that $a_{i1}a_{i2} \oplus_3 b_{i1}^2$ can be recovered given the side information $\mathbf{A} \oplus_3 \tilde{\mathbf{B}}$ $\{$ $_1 =$ $a_{ij} \oplus_3 b_{i1} \}_{i,j}$ for $i \in [m]$ and $j \in \{1, 2\}$, and given $\left\{a_{ij}^2 \oplus_3 b_{i1}^2\right\}_j$ for $j \in \{1, 2\}$. where $\alpha(\mathbf{U}_{ii}, \mathbf{U}_{jj}) \in \mathbb{F}_q^{m/2 \times 1}$ and $\beta(\mathbf{V}_{ii}, \mathbf{V}_{jj}) \in \mathbb{F}_q^{m/2 \times 1}$ represent coefficient matrices that are determined as functions of U_{ii} , U_{jj} and V_{ii} , V_{jj} , respectively, which are given as follows:

$$
\boldsymbol{\alpha}(\mathbf{U}_{ii},\mathbf{U}_{jj}) = \frac{1}{2} \begin{bmatrix} \mathbf{U}_{ii}(\frac{m}{4}+1:\frac{m}{2}) \oplus_q \mathbf{U}_{jj}(\frac{m}{4}+1:\frac{m}{2}) \\ \mathbf{U}_{ii}(1:\frac{m}{4}) \oplus_q \mathbf{U}_{jj}(1:\frac{m}{4}) \end{bmatrix} \in \mathbb{F}_q^{m/2 \times 1} ,
$$
 (142)

and

$$
\boldsymbol{\beta}(\mathbf{V}_{ii},\mathbf{V}_{jj}) = \frac{1}{2} \begin{bmatrix} \mathbf{V}_{ii}(\frac{m}{4}+1:\frac{m}{2}) \oplus_q \mathbf{V}_{jj}(\frac{m}{4}+1:\frac{m}{2}) \\ \mathbf{V}_{ii}(1:\frac{m}{4}) \oplus_q \mathbf{V}_{jj}(1:\frac{m}{4}) \end{bmatrix} \in \mathbb{F}_q^{m/2\times 1} .
$$
 (143)

From [\(136\)](#page-45-0) and [\(141\)](#page-46-1) we obtain the desired result.

N. Proof of Corollary [5](#page-17-1)

Rate. In deriving [\(31\)](#page-17-2) we infer that the dimension of $\{U_{ii}, V_{ii}, W_{ii}\}_{i \in [l]}$ is $(m/2+m/2+1)l =$ $(m+1)l$, and using [\(141\)](#page-46-1) as described in Appendix [A-M](#page-45-4) (see the proof of Proposition [10\)](#page-17-0)), the remaining terms require a dimension of $m/4 + m/4 + 1$ for each pair $i, j \in [l]$ such that $i < j$, hence, the total number of bits needed from each source is

$$
(m+1)l + (m/2+1)(l^2-l)/2.
$$
 (144)

Complexity. We note that employing the definitions of $\{U_{ij}, V_{ij}, W_{ij}\}$ given in [\(131\)](#page-44-0) and the relation $d_{ij} = U_{ij}^\top \cdot V_{ij} - W_{ij}$ in [\(132\)](#page-44-3) from Appendix [A-K](#page-43-1) (the proof of Proposition [8\)](#page-15-0), the total complexity of deriving $d_{ii} = \mathbf{U}_{ii}^{\dagger} \cdot \mathbf{V}_{ii} - W_{ii}$ for $i \in [l]$ is

$$
\Theta(ml/2) \tag{145}
$$

Given $\{d_{ii}\}_{i\in[l]}$, and using the conditional entropy expression in [\(136\)](#page-45-0), we can reconstruct ${d_{ij}}_{i \leq j \in [l]}$ exploiting the linear terms in [\(138\)](#page-45-2) and [\(139\)](#page-45-3), and the non-linear term in [\(140\)](#page-46-0), as detailed in Appendix [A-M](#page-45-4) (the proof of Proposition [10\)](#page-17-0). The linear terms in [\(138\)](#page-45-2) and [\(139\)](#page-45-3) that do not involve any multiplicative complexity, and the non-linear term in [\(140\)](#page-46-0) contains two product terms $\bar{U}_2(ij)^{\dagger} \cdot \bar{U}_1(ij)$ and $\bar{V}_1(ij)^{\dagger} \cdot \bar{V}_2(ij)$, where each product has a complexity $\Theta(m/4)$. Furthermore, the complexity incurred via reconstructing d_{ij} from items $(i) - (iii)$ in [\(141\)](#page-46-1) is composed of determining the dot product of the two terms given in (i) and (ii) that has a complexity of $\Theta(m/4)$, plus the four dot product terms involved in (*iii*) each with a complexity $\Theta(m/4)$. Thus, the total complexity of deriving $\{d_{ij}\}_{i < j \in [l]}$ is

$$
\Theta((2 \cdot m/4 + m/4 + 4 \cdot m/4)(l^2 - l)/2) \tag{146}
$$

Integrating the complexity of deriving $\{d_{ii}\}_{i\in[l]}$ given by [\(145\)](#page-46-2), and the complexity of deriving ${d_{ij}}_{i \leq j \in [l]}$ given by [\(146\)](#page-47-1) yields the total complexity expression in [\(32\)](#page-17-3).

O. Proof of Proposition [12](#page-19-0)

We start by restating Lemmas 1 and 2 of [\[17\]](#page-74-0). To that end, let X and Y be any correlated random variables taking values in fixed finite sets $\mathcal X$ and $\mathcal Y$, respectively, with probabilities

$$
p(k, h) = \mathbb{P}(X = k, Y = h) > 0, \text{ for all } k \in \mathcal{X}, h \in \mathcal{Y}. \tag{147}
$$

Let $f(X, Y)$ be an arbitrary function of X and Y, and define the random variable Z taking finite values in Z by $Z = f(X, Y)$. For this setting, the function matrix denoted by $f(k, h)$, $k \in \mathcal{X}$, $h \in \mathcal{Y}$, is regarded as an $|\mathcal{X}| \times |\mathcal{Y}|$ matrix with the (k, h) -th component being $f(k, h)$, where the rows and columns are indicated by k and h, respectively. Let the set $\mathcal P$ of random variables (X, Y) be defined by $(X, Y) \in \mathcal{P}$ if and only if condition [\(147\)](#page-47-2) is satisfied.

Lemma 5. [\[17,](#page-74-0) Lemma 1]. Let (X, Y) be any element of P . If "any two distinct rows of the *function matrix f are different", then any achievable rate* (R_1, R_2) *for f has to satisfy*

$$
R_1 \ge H_q(X \mid Y) \tag{148}
$$

[\[17,](#page-74-0) Lemma 2]. *If "any two distinct columns of the function matrix* f *are different", then any achievable rate* (R_1, R_2) *for f has to satisfy*

$$
R_2 \ge H_q(Y \mid X) \tag{149}
$$

We next show that Lemma [5](#page-47-3) of [\[17\]](#page-74-0) holds for the distributed computing of $f(A, B) = A^TB$. To that end, pick k_1 and k_2 be two distinct rows of $f(k, h)$ corresponding to source matrices ${\bf A}^{(k_1)}$ and ${\bf A}^{(k_2)}$. Hence, $f(k_1, h) - f(k_2, h) = ({\bf A}^{(k_1)} - {\bf A}^{(k_2)}) {\bf B}^{(h)}$ varies as a function of ${\bf B}^{(h)}$, rendering the first condition of Lemma [5](#page-47-3) true. Similarly, picking h_1 and h_2 be two distinct columns of $f(k, h)$ corresponding to $\mathbf{B}^{(h_1)}$ and $\mathbf{B}^{(h_2)}$, it can be shown that the second condition of Lemma [5](#page-47-3) holds true. Hence, from Lemma [5,](#page-47-3) any achievable rate must satisfy [\(43\)](#page-19-1).

P. Proof of Proposition [13](#page-20-0)

To build our achievability result, we need the following lemma.

Lemma 6. *Consider the setting in Lemma [2.](#page-18-2) Take* $\kappa' > \kappa$ *. Then, for any* ϵ *,* $\delta > 0$ *, and sufficiently large* n, a $\kappa' \times n$ matrix $C \in \mathbb{F}_q^{\kappa' \times n}$ and a decoding function $\psi': \mathbb{F}_q^{\kappa'} \to \mathbb{F}_q^n$ exist such that

\kappa' < n(H_q(Z) + \epsilon) \tag{150}
$$

$$
\mathbb{P}(\psi'(\mathcal{C}\mathbf{Z}^n) \neq \mathbf{Z}^n) < \delta \tag{151}
$$

Proof. Denoting by $T_{\varepsilon}(Z)$ the set of all ε -typical sequences for a random variable Z, to evaluate the probability of decoding error, we need to consider the following error events:

$$
E_1: \mathbf{Z}^n \notin T_{\varepsilon}(Z) , \qquad (152)
$$

$$
E_2: f_1(\mathbf{z}) = f_1(\mathbf{Z}^n) , \quad \text{for some } \mathbf{z} \neq \mathbf{Z}^n \text{ such that } \mathbf{z} \in T_{\varepsilon}(Z) ,
$$
 (153)

to evaluate the probability of decoding error:

$$
P_e = \mathbb{P}(\mathbf{Z}^n \neq \psi(\mathbf{CZ}^n)) = \mathbb{P}(E_1, E_2).
$$
 (154)

Noting that the pair (X_1, X_2) uniquely determines the value of $Z = X_1 \oplus_q X_2$, we have

$$
\mathbb{P}(E_1) = 0 \tag{155}
$$

As all the elements of $C \in \mathbb{F}_q^{\kappa \times n}$ are independently and uniformly distributed in \mathbb{F}_q , by counting all the cases satisfying $f_1(z) = f_1(Z^n)$ it follows that for any $z \neq Z^n$

$$
\mathbb{P}(f_1(\mathbf{z}) = f_1(\mathbf{Z}^n)) = (q^{n-1}/q^n)^{\kappa} = q^{-\kappa} . \tag{156}
$$

Hence, exploiting $\kappa = n(H_q(Z) + \epsilon)$, we have

$$
\mathbb{P}(E_2) \leq |T_{\varepsilon}(Z)| \cdot q^{-\kappa}
$$

\n
$$
\leq \exp(n(H_q(Z) + \varepsilon)) \cdot q^{-\kappa} = \exp(n(\kappa/n - \varepsilon + \varepsilon) - \kappa)
$$

\n
$$
= \exp(-n(\varepsilon - \varepsilon)) \leq \delta , \qquad (157)
$$

where $\exp(\cdot) = q^{(\cdot)}$, and δ can be made arbitrarily small by choosing ε small and then n large.

Now, let us assume that we use $\kappa' = n(H_q(Z) + \epsilon) + \Delta > \kappa$ for some $\Delta > 0$. As all the elements of $C \in \mathbb{F}_q^{\kappa' \times n}$ are independently and uniformly distributed in \mathbb{F}_q , by counting all the cases satisfying $f_1(z) = f_1(\mathbf{Z}^n)$ it follows that for any $z \neq \mathbf{Z}^n$

$$
\mathbb{P}(f_1(\mathbf{z}) = f_1(\mathbf{Z}^n)) = (q^{n-1}/q^n)^{\kappa'} = q^{-\kappa'}.
$$
 (158)

Hence, exploiting $\kappa' = n(H_q(Z) + \epsilon) + \Delta$, we have

$$
\mathbb{P}(E_2) \leq |T_{\varepsilon}(Z)| \cdot q^{-\kappa'}
$$

\n
$$
\leq \exp(n(H_q(Z) + \varepsilon)) \cdot q^{-\kappa'} = \exp(n(\kappa'/n - \Delta/n - \varepsilon + \varepsilon) - \kappa')
$$

\n
$$
= \exp(-n(\varepsilon - \varepsilon) - \Delta) < \exp(-n(\varepsilon - \varepsilon)) \leq \delta.
$$
 (159)

From [\(157\)](#page-48-0) and [\(159\)](#page-48-1) we infer that $\mathbb{P}(E_2)$ satisfies

$$
P_e(\kappa') < P_e(\kappa) < \delta \;, \quad \kappa' > \kappa \; . \tag{160}
$$

Consequently, the error probability drops as κ increases.

To prove our achievability result, we exploit Lemma [6.](#page-47-0)

Encoding: Each source uses mappings $g_1: \mathbf{A} \to \mathbf{X}'_1$ and $g_2: \mathbf{B} \to \mathbf{X}'_2$, respectively, to determine the following matrices:

$$
\mathbf{X}'_1 = g_1(\mathbf{A}) = \begin{bmatrix} \mathbf{A}_2 \\ \mathbf{A}_1 \\ \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_q \mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \end{bmatrix} , \quad \mathbf{X}'_2 = g_2(\mathbf{B}) = \begin{bmatrix} \mathbf{B}_1 \\ \mathbf{B}_2 \\ \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \oplus_q \mathbf{B}_2^{\mathsf{T}} \mathbf{B}_1 \end{bmatrix} \in \mathbb{F}_q^{(m+l) \times l} , \quad (161)
$$

for sources one and two, respectively. Concatenating the columns of the matrices X'_1 and X'_2 given in [\(161\)](#page-48-2), we obtain the column vectors X_1 , and X_2 :

$$
\mathbf{X}_{1} = \begin{bmatrix} \mathbf{X}_{1}^{\prime}(:,1) \\ \mathbf{X}_{1}^{\prime}(:,2) \\ \vdots \\ \mathbf{X}_{1}^{\prime}(:,l) \end{bmatrix} \in \mathbb{F}_{q}^{(m+l)l \times 1}, \quad \mathbf{X}_{2} = \begin{bmatrix} \mathbf{X}_{2}^{\prime}(:,1) \\ \mathbf{X}_{2}^{\prime}(:,2) \\ \vdots \\ \mathbf{X}_{2}^{\prime}(:,l) \end{bmatrix} \in \mathbb{F}_{q}^{(m+l)l \times 1}. \tag{162}
$$

 \Box

The non-linear mappings $X_1^n, X_2^n \in \mathbb{F}_q^{(m+l)l \times n}$ are obtained via employing the relations [\(161\)](#page-48-2) and [\(162\)](#page-48-3) to the length *n* realizations of $A \in \mathbb{F}_q^{m \times l}$ and $B \in \mathbb{F}_q^{m \times l}$. The encoders of the source mappings $\{X_{1i}\}\$ and $\{X_{2i}\}\$ are defined by $f_1: X_1^n \to \mathcal{R}_{f_1}$ and $f_2: X_2^n \to \mathcal{R}_{f_2}$, where \mathcal{R}_{f_1} and \mathcal{R}_{f_2} denote the ranges of f_1 and f_2 , respectively. The pair (f_1, f_2) is called an (n, ϵ) -coding scheme if there exists a function $\phi : \mathcal{R}_{f_1} \times \mathcal{R}_{f_2} \to \mathcal{Z}^n$ such that by letting

$$
\hat{\mathbf{Z}}^n \triangleq \phi(f_1(\mathbf{X}_1^n), f_2(\mathbf{X}_2^n)) \tag{163}
$$

we have $\mathbb{P}(\hat{\mathbf{Z}}^n \neq \mathbf{Z}^n) < \epsilon$. Here, Z is the modulo-q sum of \mathbf{X}_1 and \mathbf{X}_2 , where $q \ge 2$, i.e.,

$$
\mathbf{Z} = \mathbf{X}_1 \oplus_q \mathbf{X}_2 \in \mathbb{F}_q^{(m+l)l \times 1} . \tag{164}
$$

Decoding: Using the achievability result of Körner-Marton [\[16\]](#page-74-1), Lemmas [1-](#page-18-1)[2,](#page-18-2) the sum rate needed for the receiver to recover the matrix sequence $\mathbf{Z}^n = \mathbf{X}_1^n \oplus_q \mathbf{X}_2^n$ with vanishing error is:

$$
R_{\text{KM}}^{\Sigma} = 2H_q(\mathbf{U}, \mathbf{V}, \mathbf{W}_S) , \qquad (165)
$$

where the matrix variables U, V, W_S are given as follows:

$$
\mathbf{U} = \mathbf{A}_2 \oplus_q \mathbf{B}_1 \in \mathbb{F}_q^{m/2 \times l} , \quad \mathbf{V} = \mathbf{A}_1 \oplus_q \mathbf{B}_2 \in \mathbb{F}_q^{m/2 \times l} ,
$$

$$
\mathbf{W}_S = \mathbf{A}_2^{\mathsf{T}} \mathbf{A}_1 \oplus_q \mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 \oplus_q \mathbf{B}_2^{\mathsf{T}} \mathbf{B}_1 \in \mathbb{F}_q^{l \times l} .
$$
(166)

We next indicate that the sum rate [\(165\)](#page-49-0) is achievable for $q > 2$. To that end, using $\hat{\mathbf{Z}}^n$ and exploiting the relations in [\(166\)](#page-49-1), the receiver computes

$$
\frac{1}{2}(\mathbf{U}^{\mathsf{T}}\cdot\mathbf{V}\oplus_{q}\mathbf{V}^{\mathsf{T}}\cdot\mathbf{U}-\mathbf{W}_{S})\stackrel{(a)}{=}\frac{1}{2}((\mathbf{A}_{1}^{\mathsf{T}}\mathbf{B}_{1}\oplus_{q}\mathbf{A}_{2}^{\mathsf{T}}\mathbf{B}_{2})\oplus_{q}(\mathbf{A}_{1}^{\mathsf{T}}\mathbf{B}_{1}\oplus_{q}\mathbf{A}_{2}^{\mathsf{T}}\mathbf{B}_{2})^{\mathsf{T}})\stackrel{(b)}{=}\mathcal{D},\qquad(167)
$$

where (*a*) follows from reordering the terms, and (*b*) from the symmetry of $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$.

We next let $\mathbf{Z}(j) = \mathbf{X}_1(j) \oplus_q \mathbf{X}_2(j) \in \mathbb{F}_q$ be the j-th element of Z, and $\mathbf{Z}^n(j) \in \mathbb{F}_q^{n \times 1}$ its length n realization, where $j \in [(\check{m}+l)l]$. For fixed $\epsilon > 0$, $\delta > 0$, and sufficiently large n, we choose a qary matrix $C \in \mathbb{F}_q^{\kappa_j \times n}$ whose elements are all i.i.d. and uniformly distributed in \mathbb{F}_q (cf. Ahlswede-Han [\[60\]](#page-75-0)), and let $f_1(\mathbf{X}_1^n(j)) \triangleq \mathcal{C}(\mathbf{X}_1^n) = \mathcal{C} \cdot \mathbf{X}_1^n(j) \in \mathbb{F}_q^{\kappa_j \times 1}$ and $f_2(\mathbf{X}_2^n(j)) \triangleq \mathcal{C} \cdot \mathbf{X}_2^n(j) \in \mathbb{F}_q^{\kappa_j \times 1}$ denote the modulo-q product of C with the transpose of the q-ary vector sequences $X_1^n(j)$ and $\mathbf{X}_2^n(j)$, respectively. Then, there exists a decoding function $\psi_j : \mathbb{F}_q^{\kappa_j} \to \mathbb{F}_q^n$ that satisfies [\[60\]](#page-75-0):

$$
\phi(f_1(\mathbf{X}_1^n(j)), f_2(\mathbf{X}_2^n(j))) \triangleq \psi_j(f_1(\mathbf{X}_1^n(j)) \oplus_q f_2(\mathbf{X}_2^n(j)))
$$

such that i) $\kappa_j < n(H(\mathbf{Z}(j)) + \epsilon)$, and ii) $\mathbb{P}(\psi_j(\mathcal{C}(\mathbf{Z}^n(j))) \neq \mathbf{Z}^n(j)) < \delta$.

Concatenating the columns of the matrix U, defined in [\(166\)](#page-49-1), we denote by

$$
\begin{bmatrix}\n\mathbf{U}(:,1) \\
\mathbf{U}(:,2) \\
\vdots \\
\mathbf{U}(:,l)\n\end{bmatrix} = \begin{bmatrix}\n\mathbf{Z}(1) \\
\mathbf{Z}(2) \\
\vdots \\
\mathbf{Z}(ml/2)\n\end{bmatrix} = \begin{bmatrix}\n\mathbf{A}_2(:,1) \\
\mathbf{A}_2(:,2) \\
\vdots \\
\mathbf{A}_2(:,l)\n\end{bmatrix} \oplus_q \begin{bmatrix}\n\mathbf{B}_1(:,1) \\
\mathbf{B}_1(:,2) \\
\vdots \\
\mathbf{B}_1(:,l)\n\end{bmatrix} \in \mathbb{F}_q^{ml/2 \times 1},

\n(168)

and similarly for V , given in [\(166\)](#page-49-1), we have that

$$
\begin{bmatrix}\n\mathbf{V}(:,1) \\
\mathbf{V}(:,2) \\
\vdots \\
\mathbf{V}(:,l)\n\end{bmatrix} = \begin{bmatrix}\n\mathbf{Z}(ml/2+1) \\
\mathbf{Z}(ml/2+2) \\
\vdots \\
\mathbf{Z}(ml)\n\end{bmatrix} = \begin{bmatrix}\n\mathbf{A}_1(:,1) \\
\mathbf{A}_1(:,2) \\
\vdots \\
\mathbf{A}_1(:,l)\n\end{bmatrix} \oplus_q \begin{bmatrix}\n\mathbf{B}_2(:,1) \\
\mathbf{B}_2(:,2) \\

\mathbf{Z}(j) = g_{1,j}(\mathbf{A}) \oplus_q g_{2,j}(\mathbf{B}), \quad j \in [ml], \qquad (171)

for some $g_{1,j}$ and $g_{2,j}$, where $\mathbf{Z}(j)$, $j \in [ml]$ are independent. Similarly, [\(170\)](#page-50-0) can be written as

where $g'_{1,j} \neq g_{1,j}$ and $g'_{2,j} \neq g_{2,j}$, which is obvious by comparing [\(168\)](#page-49-2) and [\(169\)](#page-49-3) with [\(170\)](#page-50-0).

From Lemma [2,](#page-18-2) we obtain $\kappa_j \approx n H_q(\mathbf{Z}(j))$, for $j \in [(m + l)l]$. Employing Lemma [6,](#page-47-0) the following rate per source can be achieved for computing the symmetric matrix $D = A^{\dagger}B$:

\stackrel{(b)}{=} H_q(\frac{1}{2}(\mathbf{U}^{\mathsf{T}} \cdot \mathbf{V} \oplus_q \mathbf{V}^{\mathsf{T}} \cdot \mathbf{U} - \mathbf{W}_S) | \mathbf{U}, \mathbf{V}) \stackrel{(c)}{=} H_q(\mathbf{A}^{\mathsf{T}} \mathbf{B} | \mathbf{U}, \mathbf{V}) \le l^2 , \qquad (175)
$$

where (a) is due to [\(166\)](#page-49-1), and from [\(168\)](#page-49-2), [\(169\)](#page-49-3), and [\(170\)](#page-50-0), (b) follows from employing [\(167\)](#page-49-4) as well as leveraging conditioning, and (c) from [\(167\)](#page-49-4). Hence, from [\(174\)](#page-50-1) and [\(175\)](#page-50-2), the following .

where $H(A^{T}B | U, V) = H(U, V)$ under the above DSBS model assumption, exploiting the relations $\mathbf{U} \perp (\mathbf{A}_2 , \mathbf{B}_1)$ and $\mathbf{V} \perp (\mathbf{A}_1 , \mathbf{B}_2)$. Hence, the rate $\frac{\kappa}{n} \ge \max\{ H(\mathbf{U} , \mathbf{V}) , H(\mathbf{A}^{\mathsf{T}} \mathbf{B}) \}$ per source is achievable for the receiver to successfully recover $D = A^{\dagger}B = B^{\dagger}A$.

The application of Elias's lemma [\[125\]](#page-77-0) to *vector variables*, Lemma [6,](#page-47-0) and the results of Körner-Marton [\[16\]](#page-74-1), Ahlswede-Han [\[60\]](#page-75-0), and Han-Kobayashi [\[17\]](#page-74-0) yield that if we choose $\mathcal{C} \in \mathbb{F}_q^{\kappa \times n}$ with elements being i.i.d. and uniform, and κ as in [\(47\)](#page-20-1), then (C, C) is an (n, ϵ) -coding scheme that enables the decoding of $\mathbf{Z} = \mathbf{X}_1 \oplus_q \mathbf{X}_2 \in \mathbb{F}_q^{(m+l)l \times 1}$ with a small probability of error.

Exploiting the strong converse bounds in [\(42\)](#page-19-2) of Proposition [11,](#page-19-3) we observe that for distributed computing of the symmetric matrix product $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$, the rates have to satisfy^{[2](#page-51-1)}

for sources one and two, respectively. Exploiting Proposition 12 — noting that $\mathcal D$ satisfies the conditions in Lemma [5](#page-47-3) —, we observe that for distributed computing of $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$, the rates have to satisfy $R_1 \geq H_q(\mathbf{A} | \mathbf{B})$ and $R_2 \geq H_q(\mathbf{B} | \mathbf{A})$. where (a) follows from utilizing $\mathcal{D} = \mathcal{D}^{\dagger}$, and (b) from exploiting the elementwise DSBS model, where $Y = A \oplus_2 B \in \mathbb{F}_q^{m \times l}$ such that $y_{ki} \sim \text{Bern}(p)$, and the fact that given B, the

Step (e) follows from noting that the relation $\mathcal{D} = \mathcal{D}^{\dagger}$ gives at most $l(l - 1)$ $\sum_{k\in[m]} y_{ki}b_{kj} = \sum_{k\in[m]} b_{ki}y_{kj} = \sum_{k\in\mathcal{K}_i} y_{ki}$ holds, showing no reduction in the entropy of Y. linearly independent equations of Y when $m \gg l$, where for $i = j \in [l]$, the relationship Therefore, the entropy of Y is reduced from $mlh(p)$ by up to $l(l-1)h(p)$.

where (a) follows from $d = A^{\dagger}B = U^{\dagger}V \oplus_2 W$, (b) using the symmetry for dot products, namely $\mathbf{A}_1^{\mathsf{T}}\mathbf{A}_2 = \mathbf{A}_2^{\mathsf{T}}\mathbf{A}_1 \in \mathbb{F}_2$, and (c) observing that $u_i \sim \text{Bern}(p)$, $v_j \sim \text{Bern}(p)$ which are i.i.d. across $i, j \in [m/2]$ and $\mathbf{U} \perp (\mathbf{A}_2, \mathbf{B}_1)$ and $\mathbf{V} \perp (\mathbf{A}_1, \mathbf{B}_2)$ as well as that the elements of A satisfy $a_i \sim \text{Bern}\left(\frac{1}{2}\right)$ $\frac{1}{2}$) across $i \in [m]$. Hence, the following rate per source can be achieved:

S. Multiplicative Gain for Dot Products, as Detailed in Section [IV-A](#page-20-3)

In the special case when $l = 1$, as detailed in Proposition [1,](#page-9-0) it is easy to note that the dot product function satisfies the conditions in Lemma [5.](#page-47-3) Hence, from Proposition [12,](#page-19-0) for $f(A, B) =$ $\mathbf{A}^{\mathsf{T}}\mathbf{B} = d \in \mathbb{F}_q$, it holds that $R_1 \ge H_q(\mathbf{A} \mid \mathbf{B})$ and $R_2 \ge H_q(\mathbf{B} \mid \mathbf{A})$.

Given the condition $(a_i, b_i) \sim \text{DSBS}(p)$, $i \in [m]$, we have $H(A | B) = H(B | A) = mh(p)$. Hence, the minimum sum rate for distributed computing of $\mathbf{A}^{\mathsf{T}}\mathbf{B} = d$ is given as

where (a) is due to the DSBS model, where the achievable sum rate of the scheme of [\[16\]](#page-74-1) is $2h(p)$ per element, and the equality in (b) is because $A \oplus_2 B$ is independent of A and B.

From Proposition [1,](#page-9-0) it is achievable that $R_{\text{KM}}^{\Sigma} \le m(1 + h(2p(1 - p))) + 2$ (cf. [\(108\)](#page-39-1) for the $(a_i, b_i) \sim \text{DSBS}(p)$ model). Exploiting [\(176\)](#page-51-0) and [\(177\)](#page-51-2), we know that a tighter sum rate (than Proposition [1\)](#page-9-0) is achievable and the ratio of our achievable rate to the lower bound satisfies

where $\lim_{m\to\infty} \Gamma_{ub}(m, p) = 1$, demonstrating the tightness of our achievability result given in [\(176\)](#page-51-0) versus the rate R_{HK}^{Σ} for the dot product operation in the regime when m is large.

T. Achievable Rate for Symmetric Outer Products, as Detailed in Section [IV-A](#page-20-3)

In the case $q = 2$, under the elementwise DSBS assumption, i.e., $(a_i, b_i) \sim \text{DSBS}(p)$ and i.i.d. for all $i \in [l]$, we have $d_{ij} = a_i b_j$, for all $i, j \in [l]$. When $m = 1$, we cannot exploit the relations [\(166\)](#page-49-1) and [\(167\)](#page-49-4). Instead, we consider the following approach. For a given $i \in [l]$, note that $a_i b_i \sim \text{Bern}\left(\frac{1-p}{2}\right)$ $\left(\frac{-p}{2}\right)$, for all $i \in [l]$, and $a_i b_i = 0$ if $a_i \oplus_2 b_i = 1$, implying that the *i*-th row and the *i*-th column of $\mathcal D$ is all zeros, due to the symmetry of $\mathcal D$. Furthermore, $a_i b_i \sim \text{Bern}(\frac{1}{2})$ $\frac{1}{2}$ given $a_i \oplus_2 b_i = 0$. In this case, i.e., when $a_i \oplus_2 b_i = 0$, the knowledge of a_i helps determine $a_i b_i$. Therefore, we establish that the following rate per source is achievable to reconstruct \mathcal{D} :

\frac{\kappa}{n} < \max\{H(\{a_i \oplus_2 b_i\}_{i \in [l]}), \, H(\{a_i \mid a_i \oplus_2 b_i = 0\}_{i \in [l]})\} + \epsilon \;, \tag{187}
$$

where $H(\{a_i \oplus_2 b_i\}_{i \in [l]}) = lh(p)$ and $H(\{a_i \mid a_i \oplus_2 b_i = 0\}_{i \in [l]}) = \sum$ $i \in [l]$ $\binom{l}{i}$ $\binom{l}{i}(1-p)^{i}p^{l-i}i = l.$ We

will later devise a converse bound for the elementwise DSBS model (cf. [\(190\)](#page-54-0)).

When $q > 2$, we can exploit the relation $a_i b_j = \frac{1}{2}$ $\frac{1}{2}(a_i \oplus_q b_j)^2 - \frac{1}{2}$ $\frac{1}{2}(a_i^2 \oplus_q b_j^2)$, and note that given $a_j \oplus_q b_j$, the complexity of determining $a_i^2 \oplus_q b_j^2$ is the same as the complexity of determining $a_i b_j$. Hence, the following rate per source can be achieved for computing the outer product

$$
\frac{\kappa}{n} < \max\{H_q(\{a_i \oplus_q b_j\}_{i \in [l], j \in [l]} : i \leq j), H_q(\{a_i b_j \mid a_i \oplus_q b_j\}_{i \in [l], j \in [l]} : i \leq j)\} + \epsilon \;, \tag{188}
$$

where we focus on $\{i \leq j\}$, noting that $a_j \oplus_q b_i = (a_i \oplus_q b_i) - (a_i \oplus_q b_j) \oplus_q (a_j \oplus_q b_j)$ for $q \geq 2$.

U. Multiplicative Gain for Outer Products, as Detailed in Section [IV-A](#page-20-3)

When $l > 1$ and $m = 1$, the outer product is given by $\mathcal{D} = A^{\dagger}B \in \mathbb{F}_q^{l \times l}$. Note that the outer product function satisfies the conditions in Lemma [5.](#page-47-3) Hence, from Proposition [12,](#page-19-0) the minimum sum rate for distributed computing of this dot product is given as

R_{\rm HK}^{\Sigma} = H_q(\mathbf{A} \mid \mathbf{B}) + H_q(\mathbf{B} \mid \mathbf{A}) \tag{189}
$$

For the special case of $q = 2$, when the elementwise DSBS model holds, i.e., $(a_i, b_i) \sim$ $DSBS(p)$ and i.i.d., for all $i \in [l]$, we have that

R_1 \ge H(\mathbf{A} | \mathbf{B}) = lh(p)

, $R_2 \ge H(\mathbf{B} | \mathbf{A}) = lh(p)$. (190)

Exploiting [\(187\)](#page-53-0) and [\(190\)](#page-54-0), the ratio of our achievable rate to the lower bound satisfies

demonstrating the tightness of [\(187\)](#page-53-0) for the outer product operation as $p \to \frac{1}{2}$.

Exploiting the strong converse bounds in [\(42\)](#page-19-2), we can show that

which yields the same result as [\(189\)](#page-54-1) for $q = 2$ as $l \rightarrow \infty$, demonstrating the tightness of [\(187\)](#page-53-0).

\mathbf{S}_1 - \mathbf{A} - \mathbf{B} - \mathbf{S}_2 \tag{191}
$$

Then, in the special case of $q = 2$, the achievable rate region $\mathcal{R}(S_1, S_2)$ satisfies [\[60\]](#page-75-0):

R_1 \ge I(\mathbf{S}_1; \mathbf{A} \mid \mathbf{S}_2) + H(\mathbf{A} \oplus_2 \mathbf{B} \mid \mathbf{S}_1, \mathbf{S}_2), ,

R_2 \ge I(\mathbf{S}_2; \mathbf{B} \mid \mathbf{S}_2) + H(\mathbf{A} \oplus_2 \mathbf{B} \mid \mathbf{S}_1, \mathbf{S}_2),
$$

\n

R_1 + R_2 \ge R_{\text{AH}}^{\Sigma} = I(\mathbf{S}_1, \mathbf{S}_2; \mathbf{A}, \mathbf{B}) + 2H(\mathbf{A} \oplus_2 \mathbf{B} \mid \mathbf{S}_1, \mathbf{S}_2).
$$
 (192)

In the special case when $S_1 = A$ and $S_2 = B$, [\(192\)](#page-54-2) is equivalent to the rate region of [\[15\]](#page-74-2). When $S_1 = 0$ and $S_2 = 0$, then [\(192\)](#page-54-2) is equivalent to the rate region of [\[16\]](#page-74-1). It is demonstrated in [\[60\]](#page-75-0) that the convex closure of $\bigcup_{(S_1,S_2)} \mathcal{R}(S_1, S_2)$, where the union is taken over all (S_1, S_2) satisfying [\(191\)](#page-54-3), contains the rate regions of [\[15\]](#page-74-2) and [\[16\]](#page-74-1), strictly extends the convex hull of [\[15\]](#page-74-2) and [\[16\]](#page-74-1) for general binary sources, and is in general larger than the convex hull of both.

In the more general case of $q > 2$, the square matrix product $\mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{l \times l}$ can be written as

= \mathbf{A}_1^{\mathsf{T}}(\mathbf{A}_2 \oplus_q \mathbf{B}_1) \oplus_q (\mathbf{A}_2 \oplus_q \mathbf{B}_1)^{\mathsf{T}} \mathbf{B}_2 - (\mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2) , \qquad (194)
$$

where we note that [\(193\)](#page-54-4) and [\(194\)](#page-54-5) do not require the symmetry assumption for the matrix product, unlike Proposition [13,](#page-20-0) in which the rate per source is given by [\(176\)](#page-51-0).

Exploiting the representation in [\(194\)](#page-54-5) and the sum rate R_{AH}^{Σ} given in [\(192\)](#page-54-2), letting $S_1 = A_1$ and $\mathbf{S}_2 = \mathbf{B}_2$, we can recover the matrix product $\mathbf{A}^\dagger \mathbf{B}$ at a sum rate

R_{\text{AH}}^{\Sigma} = H_q(\mathbf{A}_1, \mathbf{B}_2) + 2 \max \{ H_q(\mathbf{A}_2 \oplus_q \mathbf{B}_1 | \mathbf{A}_1, \mathbf{B}_2), H_q(\mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \oplus_q \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2 | \mathbf{A}_1, \mathbf{B}_2, \mathbf{A}_2 \oplus_q \mathbf{B}_1) \}, \qquad (195)
$$

where this rate achieves the recovery of the terms A_1 , B_2 , and $A_2 \oplus_q A_1$ and $A_1^{\dagger} A_2 \oplus_q B_1^{\dagger} B_2$, from which the desired matrix product can be reconstructed using [\(194\)](#page-54-5). We also note that the term $\max\{\cdot, \cdot\}$ follows from using the same arguments in [\(176\)](#page-51-0).

W. Proof of Proposition [16](#page-21-1)

To study the achievable region for the matrix product for the setting of Lemma [4,](#page-19-4) we focus on the cases $m < l$, and $m > l$, respectively.

Case 1. $(m < l)$ For the setting of Lemma [4,](#page-19-4) we evaluate the matrix product A^TB exploiting the relation R_{AH}^{Σ} in [\(195\)](#page-55-0), which gives

= lm + 2 \max \left\{ \frac{lm}{2}, \frac{lm}{2} \right\} = 2lm = R_{\rm SW}^{\Sigma} , \qquad (196)

where (a) follows from incorporating $U = A_2 \oplus_q B_1$, (b) from noting that $H_q(A_1^{\dagger}A_2 \oplus_q (U \mathbf{A}_2$)^T $\mathbf{B}_2 \mid \mathbf{A}_1, \mathbf{B}_2, \mathbf{U} = \mathbf{A}_2 \oplus_q \mathbf{B}_1 \leq H_q(\mathbf{A}_2)$ given the side information variables $\mathbf{A}_1, \mathbf{B}_2, \mathbf{U}$.

From Lemma [4,](#page-19-4) when $m < l$, it holds that $H_q(\mathbf{A}^\intercal \mathbf{B}) = 2lm - m^2 \overset{(a)}{\geq} lm$, where (a) follows from incorporating $m < l$, implying that $m^2 < lm$. Hence, the bound in [\(53\)](#page-21-2) follows from [\(196\)](#page-55-1):

Case 2. ($m \ge l$) For the setting of Lemma [4,](#page-19-4) we evaluate the matrix product A^TB using an inner product-based characterization exploiting the following row-block representation:

where the probability of a matrix drawn uniformly from $\mathbb{F}_q^{l \times l}$ being singular is equal to 1 – $\prod_{i=1}^{l} (1 - q^{-i})$, which goes to 0 as $q \to \infty$ [\[139\]](#page-77-1). Hence, $\mathbf{A}_F, \mathbf{B}_F \in \mathbb{F}_q^{l \times l}$ are the full rank matrices, and $\mathbf{A}_{\Delta}, \mathbf{B}_{\Delta} \in \mathbb{F}_q^{(m-l)\times l}$ correspond to the part which can be directly derived from A_F, B_F , respectively. More specifically, matrices $A_\Delta, B_\Delta \in \mathbb{F}_q^{(m-l)\times l}$ can be described by the following linear transformations:

where $G_1 \in \mathbb{F}_q^{(m-l)\times l}$ and $G_2 \in \mathbb{F}_q^{(m-l)\times l}$ are deterministic mappings known to source one and source two, respectively. Exploiting [\(199\)](#page-55-2), we can rewrite the desired matrix product A[⊤]B as

To establish our achievability result, we first compute the product $A_F^{\dagger}B_F$ in [\(200\)](#page-55-3). To that end, we evaluate [\(195\)](#page-55-0) given the setting of Lemma [4,](#page-19-4) where A and B are substituted by A_F

and \mathbf{B}_F , respectively, with row-block representations such that \mathbf{A}_{F1} , \mathbf{A}_{F2} , \mathbf{B}_{F1} , $\mathbf{B}_{F2} \in \mathbb{F}_q^{\frac{1}{2} \times l}$, and the elements of A_F and B_F are i.i.d. and uniformly distributed over $\mathbb{F}_q^{l \times l}$.

H_{q}(\mathbf{A}_{F1}^{\mathsf{T}} \mathbf{A}_{F2} \oplus_{q} \mathbf{B}_{F1}^{\mathsf{T}} \mathbf{B}_{F2} | \mathbf{A}_{F1}, \mathbf{B}_{F2}, \mathbf{A}_{F2} \oplus_{q} \mathbf{B}_{F1}) \}
$$

\n

\leq 2 \cdot \frac{l^{2}}{2} + 2 \max \left\{ \frac{l^{2}}{2}, H_{q}(\mathbf{A}_{F2}) \right\} = 2 \cdot \frac{l^{2}}{2} + 2 \max \left\{ \frac{l^{2}}{2}, \frac{l^{2}}{2} \right\} = 2l^{2}, \quad (201)
$$

where the calculation steps follow the same reasoning as in [\(196\)](#page-55-1), and the notation $R_{\text{AH}}^{\Sigma}(\mathbf{A}_F, \mathbf{B}_F)$ emphasizes that the structured coding is performed for the pair (A_F, B_F) versus (A, B) .

The remainder of the achievability result relies on exploiting [\(200\)](#page-55-3) to evaluate $\mathbf{A}^\intercal \mathbf{B}$ in [\(195\)](#page-55-0) for the setting of Lemma [4.](#page-19-4) Here, using the structured encoding scheme of [\(201\)](#page-56-0) to recover $A_F^{\dagger} B_F$, we denote the side information available to the receiver by $SI_F \triangleq \{A_{F1}, B_{F2}, U_F =$ $A_{F2}^F \oplus_q B_{F1}$, $A_{F1}^T A_{F2} \oplus_q B_{F1}^T B_{F2}$. As a result, the necessary and sufficient rate for the receiver to recover the matrices \mathbf{A}_{Δ} , \mathbf{B}_{Δ} , denoted by $R_{SW}^{\Sigma}(\mathbf{A}_{\Delta}, \mathbf{B}_{\Delta} | \text{SI}_F)$, is given as

where (*a*) follows from letting $G_1 = [G_{11} \ G_{12}]$, and $G_2 = [G_{21} \ G_{22}]$, where the submatrices satisfy $G_{11}, G_{12}, G_{21}, G_{22} \in \mathbb{F}_q^{(m-l)\times \frac{l}{2}}$. Step (b) follows from eliminating U_F from the set of conditional random variables, it is clear that $R_{\text{SW}}^{\Sigma}(\mathbf{A}_{\Delta}, \mathbf{B}_{\Delta} | \text{SI}_F \setminus {\{\mathbf{U}_F\}}) \leq H_q(\mathbf{A}_{F2}) = \frac{l^2}{2}$ $\frac{1}{2}$. In step (*c*), we note that given the set of matrices $\mathbf{A}_{F1} = (a_{ij}^{F1}) \in \mathbb{F}_q^{\frac{1}{2} \times l}$, $\mathbf{B}_{F2} = (b_{ij}^{F2}) \in \mathbb{F}_q^{\frac{1}{2} \times l}$, and $\mathbf{A}_{F1}^\intercal \mathbf{A}_{F2} - \mathbf{A}_{F2}^\intercal \mathbf{B}_{F2} = \Big(\begin{array}{c} \sum \end{array}$ $k \in [l/2]$ $a_{ki}^{F1}a_{kj}^{F2}-\sum$ $k \in [l/2]$ $a_{ki}^{F2}b_{kj}^{F2}$ $\in \mathbb{F}_q^{l \times l}$ available as side information, the

receiver has l^2 linear functions of the $\frac{l^2}{2}$ $\frac{d^{2}}{2}$ unknown variables of $\mathbf{A}_{F2} = (a_{ij}^{F2}) \in \mathbb{F}_q^{\frac{1}{2} \times l}$. Therefore, in the limit as as q tends to infinity, given the elements $a_{ij}^{F1} \in \mathbb{F}_q$ and $b_{ij}^{F2} \in \mathbb{F}_q$, and the elements a_{ij}^{F2} which are drawn i.i.d. and uniform over \mathbb{F}_q , the receiver can solve for \mathbf{A}_{F2} .

From [\(201\)](#page-56-0) and [\(202\)](#page-56-1), we infer that A[†]B in the case $m \geq l$ can be recovered at a sum rate

X. Proof of Proposition [17](#page-22-0)

We next focus on the special case when $q = 2$, and employ the elementwise DSBS model for the pair $\mathbf{A}, \ \mathbf{B} \in \mathbb{F}_2^{m \times l}$, i.e., $(a_{ij}, \ b_{ij}) \sim \text{DSBS}(p)$ for all $i \in [m]$ and $j \in [l]$. We further let

where (a) follows from noting that $Y_1 \oplus_2 Y_2 = (A_1 \oplus_2 B_2) \oplus_2 (A_2 \oplus_2 B_1)$, (b) from letting $\mathbf{Y}_s = \mathbf{Y}_1 \oplus_2 \mathbf{Y}_2$, and (c) follows from noting that $H(\mathbf{A}_1^T \mathbf{Y}_1 \oplus_2 \mathbf{Y}_1^T \mathbf{B}_2 | \mathbf{A}_1, \mathbf{B}_2, \mathbf{Y}_s) \leq H(\mathbf{Y}_1) =$ ml $\frac{n}{2}$ $\cdot h(p)$ from [\(206\)](#page-57-0) and due to the Schur concavity of $h(\cdot)$. where (a) follows from the Schur concavity of $h(\cdot)$. For this elementwise DSBS model, secure computation is ensured at a rate $R_{\text{AH}}^{\Sigma} \ge R_{\text{SW}}^{\Sigma}$, meaning it requires extra bits compared to [\[15\]](#page-74-2).

Motivated by the encoding scheme in [\[16\]](#page-74-1) and the generalization of this result to modulo-q sum [\[17,](#page-74-0) Lemma 5], we next aim to determine if $\widetilde{R}_{\rm AH}^{\Sigma} \leq 2H_q(f(\mathbf{A}, \mathbf{B})) = 2H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B})$ is achievable. To that end, as $q \to \infty$, from Proposition [16,](#page-21-1) $2H_q(\mathbf{A}^T\mathbf{B}) = 2l^2 \leq 2lm = R_{SW}^{\Sigma}$, and from [\(195\)](#page-55-0) $R_{\text{AH}}^{\Sigma} \leq 2ml$, for $m \geq l$, meaning that $R_{\text{AH}}^{\Sigma} \leq 2H_q(\mathbf{A}^{\mathsf{T}}\mathbf{B})$ when $l = m$. On the other hand, $2H_q(\mathbf{A}^T\mathbf{B}) = 4lm - 2m^2 \ge R_{SW}^{\Sigma} = 2lm \ge R_{AH}^{\Sigma}$ (cf. [\(195\)](#page-55-0)) for $m < l$.

Exploiting the concatenation arguments in the proof of Proposition [5](#page-13-1) (see Appendix [A-G\)](#page-40-3), we can concatenate the columns of A and B to obtain the column vectors X_1 , and X_2 :

Following the steps of Lemma [1](#page-18-1) and Proof of Proposition [1,](#page-9-0) we let $\mathbf{Z}(j) = \mathbf{X}_1(j) \oplus_2 \mathbf{X}_2(j) \in$

 \mathbb{F}_2 denote the j-th element of Z, and $\mathbf{Z}^n(j) \in \mathbb{F}_2^{n \times 1}$ its length n realization, where $j \in [ml]$. For fixed $\epsilon > 0$, $\delta > 0$, and for sufficiently large n, we choose a binary matrix $\mathcal{C} \in \mathbb{F}_2^{\kappa_j \times n}$ 2 whose elements are all independently and uniformly distributed in \mathbb{F}_2 (following from Ahlswede-Han [\[60\]](#page-75-0)), and let $f_1(\mathbf{X}_1^n(j)) \triangleq \mathcal{C}(\mathbf{X}_1^n) = \mathcal{C} \cdot \mathbf{X}_1^n(j) \in \mathbb{F}_2^{\kappa_j \times 1}$ $a_2^{\kappa_j \times 1}$ and $f_2(\mathbf{X}_2^n(j)) \triangleq \mathbf{C} \cdot \mathbf{X}_2^n(j) \in \mathbb{F}_2^{\kappa_j \times 1}$ 2 denote the modulo-2 product of the matrix C with the binary vector sequences $X_1^n(j)$ and $X_2^n(j)$, respectively. Then, there exists a decoding function $\psi_j : \mathbb{F}_2^{\kappa_j} \to \mathbb{F}_2^n$ that satisfy [\[60\]](#page-75-0):

Hence, application of Lemma [1](#page-18-1) to *vector variables*, Lemma [6](#page-47-0) and [\[16\]](#page-74-1) yield that (C, C) is an (n, ϵ, δ) -coding scheme.

Hence, using $\frac{\kappa_j}{n} \approx H(\mathbf{Z}(j)) = H(\mathbf{X}_1(j) \oplus_2 \mathbf{X}_2(j)) = h(p)$ for all $j \in [ml]$, and employing Lemma [6,](#page-47-0) the following rate per source can be achieved for computing $A \oplus_2 B$:

where (a) is obtained as a result of several steps. We first exploit the equivalence between A[⊤]B and [\(194\)](#page-54-5). We then observe that, performing a linear encoding of A using matrix $C \in \mathbb{F}_2^{\kappa \times n}$ and using a (n, ϵ, δ) -coding scheme to determine $\mathbf{A} \oplus_2 \mathbf{B}$ and $\mathbf{A}_1^{\mathsf{T}} \mathbf{A}_2 \oplus_2 \mathbf{B}_1^{\mathsf{T}} \mathbf{B}_2$, provides an encoding rate of $\frac{k}{n}$ for each A and B. Given [\(194\)](#page-54-5), to have the full knowledge of A₁, we require an additional rate of $H(\mathbf{A}_1) - \frac{\kappa}{2r}$ $\frac{\kappa}{2n}$, to recover A[⊤]B. Furthermore, we observe that the rate needed for $\mathbf{A} \oplus_2 \mathbf{B}$, helps the receiver recover $\mathbf{A}_2 \oplus_2 \mathbf{B}_1$ and $\mathbf{A}_1 \oplus_2 \mathbf{B}_2$. (b) follows due to conditioning, and (c) by choosing $\frac{\kappa}{n} \leq \max\{mlh(p), \frac{ml}{2}\}$ $\frac{m}{2}$. It is clear from [\(211\)](#page-58-0) that

(b) follows from letting $\mathcal{K}_i = \{k : a_{ki} = 1, k \in [m]\}$ for a given i. (c) follows from using $b_{kj} = a_{kj} \oplus_2 y_{kj} \sim \text{Bern}(\frac{1}{2})$, and (d) is because b_{kj} independent of b_{ki} for any $j \neq i$ and of y_{kj} and y_{ki} . (e) follows from utilizing $1 \oplus_2 y_{ki} \sim \text{Bern}(1 - p)$ and the following definition:

Contrasting [\(213\)](#page-59-0) with [\(211\)](#page-58-0), the necessary condition for $R_{\text{AH}}^{\Sigma} \leq 2H(f(\mathbf{A}, \mathbf{B}))$ in the special case of $p = \frac{1}{2}$ $\frac{1}{2}$ is $l \geq m/\left(1 - \frac{1}{2^n}\right)$ $\frac{1}{2^m}\Big).$

For distributed computing of square matrix products, from [\(211\)](#page-58-0) it holds that

We next consider the case of $q = 2$, where $(a_{ij}, b_{ij}) \sim \text{DSBS}(p)$, $i \in [m], j \in [l]$. The square matrix multiplication function satisfies the conditions in Lemma [5.](#page-47-3) Hence, from Proposition [12,](#page-19-0) the minimum sum rate for distributed computing of A^TB is given as

We next consider the special case when $q = 2$ and $l = m$. Using the elementwise DSBS model for matrices A, $\mathbf{B} \in \mathbb{F}_2^{m \times l}$, we derive bounds on the achievable rates for computing $f(\mathbf{A}, \mathbf{B}) = \mathbf{A}^{\mathsf{T}} \mathbf{B}$. To that end, exploiting the strong converse bounds in [\(42\)](#page-19-2), we obtain

where (a) follows from letting $\sigma = 0$ if **B** is singular, and $\sigma = 1$ otherwise, and using the fact that given a square non-singular (invertible) matrix B , the matrix A^TB is an invertible function of the matrix A^{\dagger} . Step (b) follows from exploiting [\[139\]](#page-77-1) which states that the probability of a matrix **B** drawn uniformly from $\mathbb{F}_q^{m \times m}$ being singular is exactly $1 - \prod_{i \in [m]} (1 - q^{-i})$. Furthermore, (c) follows from letting $q = 2$ and noting that $H(A^{\dagger}B | B, \sigma = 0)$ is a finite value bounded between 0 and m^2 , and (d) from using the DSBS properties. Lower bounding the product $\prod_{i \in [m]} (1 - 2^{-i})$ $i \in [m]$ as m tends to infinity, we obtain $\lim_{m\to\infty} \prod_{i\in[m]} (1-2^{-i}) = 0.289$. Similarly as above (cf. [\(217\)](#page-60-0)),

where the value of the limit in [\(220\)](#page-60-3) is larger than the multiplicative gap for symmetric square matrices, given by (49) , as m approaches infinity.

APPENDIX B

A PRIMER ON POLY CODES AND THEIR GENERALIZATIONS

Here, we first provide a recap of Poly codes in [\[6\]](#page-74-3) and MatDot codes in [\[7\]](#page-74-4) (Sections [B-A](#page-60-4) and [B-B\)](#page-61-0). We then discuss StMatDot, StPoly, and StPolyDot codes (Sections [B-C,](#page-62-0) [B-D,](#page-63-0) and [B-E\)](#page-65-0).

A. Polynomial (Poly) Codes for Outer Product-Based Computation

This part details the key properties of Poly codes introduced in [\[6\]](#page-74-3) that form a basis for StPolyDot in the current paper. To that end, we let $A = \begin{bmatrix} A_0 & A_1 & \dots & A_{m-1} \end{bmatrix} \in \mathbb{F}_q^{m_A \times m}$, and $\mathbf{B} = \begin{bmatrix} \mathbf{B}_0 & \mathbf{B}_1 & \dots & \mathbf{B}_{m_B-1} \end{bmatrix} \in \mathbb{F}_q^{m_A \times m_B}$, such that $\mathbf{A}^{\mathsf{T}} \mathbf{B} \in \mathbb{F}_q^{m \times m_B}$.

a) Computation cost of the master: The master computes, for each worker $i \in \Omega$, two polynomials as defined by the following linear combinations [\[6\]](#page-74-3):

\tilde{\mathbf{A}}_i = \sum_{j=0}^{m-1} \mathbf{A}_j x_i^j \in \mathbb{F}_q^{m_A \times 1} \ , \quad \tilde{\mathbf{B}}_i = \sum_{j=0}^{m_B - 1} \mathbf{B}_j x_i^{jm} \in \mathbb{F}_q^{m_A \times 1} \ , \tag{221}
$$

which cost $\Theta(m \cdot m_A \cdot 1)$ and $\Theta(m_A \cdot m_B \cdot 1)$, respectively. Hence, the aggregate computation cost of the master node to generate the polynomials for all N workers is

It is possible to improve the exponents in [\(221\)](#page-61-1) to have a fair comparison with the codes we proposed in the current paper [\[7\]](#page-74-4).

b) Communication cost of the master: The communication cost of the master node for sending $\tilde{A}_i \in \mathbb{F}_q^{m_A \times 1}$ and $\tilde{B}_i \in \mathbb{F}_q^{m_A \times 1}$ is given by $H_q(\{\tilde{A}_i, \tilde{B}_i\}) = \Theta(2m_A)$. Hence, the total communication cost of the master is

H_q(\left\{\tilde{\mathbf{A}}_i,\tilde{\mathbf{B}}_i\right\}_{i\in\Omega}) = \Theta(2Nm_A) \ . \tag{223}
$$

c) Computation cost of a worker: Worker $i \in \Omega$, using the assigned polynomials \tilde{A}_i and $\tilde{\mathbf{B}}_i$, computes $\tilde{\mathbf{A}}_i^{\text{T}} \tilde{\mathbf{B}}_i \in \mathbb{F}_q^{1 \times 1}$, which incurs a computation cost of $\Theta(1 \cdot m_A \cdot 1)$.

d) Communication cost of a worker: Worker $i \in \Omega$ transmits $\tilde{A}_{i}^{\dagger} \tilde{B}_{i} \in \mathbb{F}_{q}^{1 \times 1}$. Hence, the communication cost of worker $i \in \Omega$ is

H_q(\tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i) \le 1 \tag{224}
$$

The recovery threshold is $N_{r_{\text{Poly}}} = mm_B$.

B. MatDot Codes for Inner Product-based Computation

We next detail the key properties of MatDot codes introduced in [\[7\]](#page-74-4). Letting s divide m_A , the input matrices are given in row-block form:

where $\mathbf{A}_i \in \mathbb{F}_q^{\frac{m_A}{s} \times m}$ and $\mathbf{B}_i \in \mathbb{F}_q^{\frac{m_A}{s} \times m}$, $i \in \{0, \ldots, s-1\}$, and $\mathbf{A}^{\mathsf{T}} \mathbf{B} \in \mathbb{F}_q^{m \times m}$. The master node computes the following polynomials [\[7\]](#page-74-4):

Master assigns worker $i \in \Omega$ two polynomials evaluated at x_i , denoted by $p_{\mathbf{A}}(x_i) \in \mathbb{F}_q^{\frac{m_{\mathbf{A}}}{s} \times m}$ and $p_{\mathbf{B}}(x_i) \in \mathbb{F}_q^{\frac{m_A}{s} \times m}$, respectively. Hence, the memory requirement per worker is $\frac{2m_A m}{s}$.

a) Computation cost of the master: The complexity of computing $p_{\mathbf{A}}(x_i)$ and $p_{\mathbf{B}}(x_i)$ is $\Theta(s \cdot \frac{m_A}{s})$ $\frac{n_A}{s} \cdot m$) each (a linear combination of s submatrices of order $\frac{m_A}{s} \cdot m$). Master's total cost of computing $p_{\mathbf{A}}(x_i)$ and $p_{\mathbf{B}}(x_i)$ for all $i \in \Omega$ workers:

b) Communication cost of the master: The cost of communication from the master per worker is $\Theta\left(\frac{m_A}{s} \cdot m + \frac{m_A}{s}\right)$ $\frac{a_A}{s} \cdot m$). Hence, the total cost of communication from the master is

e) Computation cost of the receiver: Given $deg(p_i(x_i)) = 2s - 2$, the receiver linearly combines $N_{r\text{MatDot}} = 2s - 1$ $m \times m$ matrices to recover $\mathbf{A}^\intercal \mathbf{B}$, which costs $\Theta((2s - 1)m^2)$.

C. Structured MatDot (StMatDot) Codes

These codes constitute a special instance of StPolyDot codes where the input matrices A and B are in row-block form. We assume that the input matrices are given as in [\(225\)](#page-61-2), where we assume that s divides m_A . Hence, $\mathbf{A}^\intercal \mathbf{B} \in \mathbb{F}_q^{m \times m}$. a) Computation cost of the master: The master first computes A_i and B_i which has a cost $\Theta(s \cdot \frac{m_A}{s})$ $\frac{\tilde{u}_A}{s}\cdot m + s\cdot\frac{m_A}{s}$ $(s_i \cdot m)$. To characterize the decoding cost of the StPolyDot codes at the receiver, we assume without loss of generality that the $\deg(\tilde{p}_i(x_i)) + 1$ fastest workers that evaluate the polynomial $\tilde{p}_i(x_i)$ form the set of indices $\mathcal{I} = \{1, \ldots, \deg(\tilde{p}_i(x_i)) + 1\}$, where we denote by $|\mathcal{I}| = \deg(\tilde{p}_i(x_i)) + 1$, and $x_1, x_2, \ldots, x_{|\mathcal{I}|}$, the cardinality of indices and the $|\mathcal{I}|$ unique values of the evaluation of $\tilde{p}_i(x_i)$ at $i \in \mathcal{I}$, respectively. To that end, we denote by VM the Vandermonde matrix that is given by

The objective of the receiver is to build A^TB exploiting the relation in [\(56\)](#page-22-1). Hence, to reconstruct [\(56\)](#page-22-1), the receiver needs to perform the following s_c^2 computations:

Note that $\sum_{j=0}^{s_r-1} \mathbf{A}_{j,k}^{\mathsf{T}} \mathbf{B}_{j,k'}$ is the coefficient of $x_i^{k+s_c(s_r-1)+s_c(2s_r-1)k'}$ $i^{k+s_c(s_r-1)+s_c(2s_r-1)k'}$ in [\(61\)](#page-24-0). Here, for distinct pairs (k, k') , the exponent of x_i ranges from $s_c(s_r - 1)$ to $s_c(s_r + (2s_r - 1)(s_c - 1)) - 1$. One can readily see that for every distinct pair (k, k') , the coefficient $\sum_{j=0}^{s_r-1} \mathbf{A}_{j,k}^{\top} \mathbf{B}_{j,k'}$ has a distinct exponent. To that end, the receiver performs a linear computation to recover the relevant s_c^2 submatrices, denoted by $\mathcal{D}_0, \mathcal{D}_1, \ldots, \mathcal{D}_{s_c^2-1}$, using the corresponding s_c^2 rows of VM^{-1} , denoted as $\text{VM}^{-1}_{[s_c^2],:}$, as follows:

which will ensure the receiver to decode the desired product A[⊺]B. Determining [\(256\)](#page-67-2) has a computational complexity of $\Theta\left(\left(\frac{m}{s_c}\right)^2 \cdot |\mathcal{I}|\right)$. Therefore, the total decoding complexity along with the inversion of VM in (253) is given as

Exploiting [\(258\)](#page-68-1), the cost of communication from the master node per worker is $\Theta\left(\frac{m_A}{s_H}\right)$ $\frac{n_A}{s_r} \cdot \frac{m}{s_c}$ $\frac{m}{s_c} + \frac{m_A}{s_r}$ $\frac{n_A}{s_r} \cdot \frac{m}{s_c}$ sc . Hence, the total cost of communication from the master to all workers is

\tilde{\mathbf{A}}_{i}^{\mathsf{T}}\tilde{\mathbf{B}}_{i} = \sum_{j=0}^{s_{r}-1} \sum_{k=0}^{s_{r}-1} \sum_{j'=0}^{s_{r}-1} \sum_{k'=0}^{s_{c}-1} \mathbf{A}_{j,k}^{\mathsf{T}} \mathbf{B}_{j',k'} x_{i}^{k+\bar{s}_{c}(\bar{s}_{r}-1-j'+j+(2\bar{s}_{r}-1)k')} \n+ \sum_{j=0}^{s_{r}-1} \sum_{k=0}^{s_{c}-1} \sum_{j'=0}^{\ell-1} \sum_{k'=0}^{\ell-1} \mathbf{A}_{j,k}^{\mathsf{T}} \mathbf{K}_{j,k}^{\mathbf{B}} x_{i}^{k+\bar{s}_{c}(j-j'-1+(2\bar{s}_{r}-1)(k'+s_{c}))} \n+ \sum_{j=0}^{\ell-1} \sum_{k=0}^{\ell-1} \sum_{j'=0}^{s_{r}-1} \sum_{k'=0}^{s_{c}-1} \mathbf{K}_{j,k}^{\mathbf{A}}^{\mathsf{T}} \mathbf{B}_{j',k'} x_{i}^{k+s_{c}+\bar{s}_{c}(j+s_{r}-j'-1+\bar{s}_{r}+(2\bar{s}_{r}-1)k')}

which has four different types of terms. The receiver is interested in the first summation in [\(287\)](#page-73-0), more specifically, in terms of the form

(\mathbf{A}^{\mathsf{T}}\mathbf{B})_{kl} = \sum_{i=0}^{s_r-1} \mathbf{A}_{i,k}^{\mathsf{T}} \mathbf{B}_{i,l} \in \mathbb{F}_q^{\frac{m}{s_c} \times \frac{m}{s_c}}, \quad k, l \in \{0, \dots, s_c - 1\}.

There are $s_c^2 s_r$ such terms $A_{i,k}^{\dagger} B_{i,l}$. The term in the first line of [\(287\)](#page-73-0) describes the desired term of the computation, and the degree of which — using our notation for the recovery threshold for the non-secure matrix multiplication problem in Section $V - i$ s given as

= $\bar{s}_c(\bar{s}_c(2\bar{s}_r - 1) - 2\ell\bar{s}_r) - \ell - 1$, (289)

which gives $N_{rStPolyDot} = s_c^2(2s_r - 1)$ when $\ell = 0$, where $s_r s_c = N$.

The degree of $\tilde{A}_i^{\dagger} \tilde{B}_i$, which is expressed by the polynomial in [\(287\)](#page-73-0), equals

\deg(\tilde{\mathbf{A}}_i^{\mathsf{T}}\tilde{\mathbf{B}}_i) = k + s_c + \bar{s}_c(j - j' + \bar{s}_r - 1 + (2\bar{s}_r - 1)(k' + s_c))\Big|_{j=k=k'-\ell-1, j'=0}
$$

= $\bar{s}_c(\bar{s}_c(2\bar{s}_r - 1) - s_r) - 1$. (290)

The recovery threshold of the receiver is $deg(\tilde{A}_i^T \tilde{B}_i) + 1$. In the presence of ℓ colluders, the receiver requires $N_{rStPolyDot}(\ell)$ distinct evaluations. Hence, the achievable rate is equal to

\frac{N_{r\text{StPolyDot}}(\ell)}{\deg(\tilde{\mathbf{A}}_i^{\text{T}}\tilde{\mathbf{B}}_i) + 1} = \frac{\bar{s}_c(\bar{s}_c(2\bar{s}_r - 1) - 2\ell\bar{s}_r) - \ell}{\bar{s}_c(\bar{s}_c(2\bar{s}_r - 1) - s_r)}, \quad \ell \ge 1.
$$

Note that in the case of no colluding workers, i.e., when $\ell = 0$, the degree of [\(287\)](#page-73-0) equals

\deg(\tilde{\mathbf{A}}_i^{\mathsf{T}} \tilde{\mathbf{B}}_i) = N_r(0) - 1 \tag{292}
$$

The master node, via assigning the polynomials in [\(59\)](#page-23-0) to worker $i \in \Omega$, where it incorporates the generalized construction for \tilde{A}_i and \tilde{B}_i in [\(94\)](#page-32-1) and [\(95\)](#page-32-2), respectively, enables the computation of A[⊺]B, while simultaneously satisfying the following relation on security:

\stackrel{(a)}{=} H_q(\tilde{\mathbf{A}}_{\mathcal{L}}) - H_q(\{\mathbf{K}_{j,k}^{\mathbf{A}}\}_{j,k \in [0:\ell-1]}) + H_q(\tilde{\mathbf{B}}_{\mathcal{L}}) - H_q(\{\mathbf{K}_{j,k}^{\mathbf{B}}\}_{j,k \in [0:\ell-1]})

\stackrel{(b)}{=} H_q(\tilde{\mathbf{A}}_{\mathcal{L}}) - \frac{\ell^2 m_A m}{s_r s_c} \log_2 q + H_q(\tilde{\mathbf{B}}_{\mathcal{L}}) - \frac{\ell^2 m_A m}{s_r s_c} \cdot \log_2 q

\stackrel{(c)}{\leq} \sum_{\ell \in \mathcal{L}} H_q(\tilde{\mathbf{A}}_{\ell}) + \sum_{\ell \in \mathcal{L}} H_q(\tilde{\mathbf{B}}_{\ell}) - \frac{2\ell^2 m_A m}{s_r s_c} \cdot \log_2 q
$$
\n
$$
\stackrel{(d)}{\leq} \frac{\ell^2 m_A m}{s_r s_c} \cdot \log_2 q + \frac{\ell^2 m_A m}{s_r s_c} \cdot \log_2 q - \frac{2\ell^2 m_A m}{s_r s_c} \cdot \log_2 q = 0 , \qquad (293)
$$

where (*a*) follows from [\(287\)](#page-73-0) and that the random matrices $K_{j,k}^{A}$ and $K_{j,k}^{B}$ are independent of

the source matrices A and B, and $\tilde{A}_{\mathcal{L}}$ and $\tilde{B}_{\mathcal{L}}$ are independent, (b) from the uniform i.i.d. assumption on $K_{j,k}^{\mathbf{A}}$ and $K_{j,k}^{\mathbf{B}}$, (c) from employing the definition of the joint entropy, and (d) follows from upper bounding $H_q(\tilde{\mathbf{A}}_\ell)$, $\ell \in \mathcal{L}$ assuming that the elements of $\tilde{\mathbf{A}}_\ell \in \mathbb{F}_{q}^{\frac{m_A}{s_r} \times \frac{m}{s_c}}$ are uniformly distributed, and similarly for $H_q(\tilde{\mathbf{B}}_\ell)$, $\ell \in \mathcal{L}$. Hence, the proposed scheme is information-theoretically secure, and fully secure when no worker colludes, i.e., $\ell = 0$.
