Learning Spectral Methods by Transformers

Abstract

Transformers demonstrate significant advantages as the building block of modern LLMs. In this work, we study the capacities of Transformers in performing unsupervised learning. We show that multi-layered Transformers, given a sufficiently large set of pre-training instances, are able to learn the algorithms themselves and perform statistical estimation tasks given new instances. This learning paradigm is distinct from the in-context learning setup and is similar to the learning procedure of human brains where skills are learnt through past experience. Theoretically, we prove that pre-trained Transformers can learn the spectral methods and use the classification of bi-class Gaussian mixture model as an example. Our proof is constructive using algorithmic design techniques. Our results are built upon the similarities of multi-layered Transformer architecture with the iterative recovery algorithms used in practice. Empirically, we verify the strong capacity of the multi-layered (pre-trained) Transformer on unsupervised learning through the lens of both the PCA and the Clustering tasks performed on the synthetic and real-world datasets.

1 Introduction

Large Language Models (LLMs) demonstrate significant success in learning and performing inference on real-world high dimensional datasets. Most modern LLMs use Transformers [\[30\]](#page-75-0) as their backbones, which demonstrate significant advantages over many existing neural network models. Transformers achieve many state-of-the-art performances in learning tasks including natural language processing [\[33\]](#page-75-1) and computer vision [\[18\]](#page-74-0). However, the underlying mechanism for the success of Transformers remains largely a mystery to theoretical researchers.

It has been discussed in a line of recent works [\[2,](#page-72-0) [4,](#page-72-1) [15,](#page-73-0) [38\]](#page-76-0) that, instead of learning simple prediction rules (such as a linear model) Transformers are capable of learning to perform learning algorithms that can automatically generate new prediction rules. For instance, when a new dataset is organized as the input of a Transformer, the model can automatically perform linear regression on this new dataset to produce a newly fitted linear model, and make predictions accordingly. This idea of treating Transformers as "algorithm approximators" has provided insights into the power of large language models. However, these existing works only provide guarantees for the in-context supervised learning capacities of Transformers. It remains unclear whether Transformers are capable of handling unsupervised tasks as well. This intrigues our interest in providing theoretical foundations for such model in the *unsupervised learning* setup. Specifically, this work studies two unsupervised learning problems: Principal Component Analysis (PCA) and Clustering Mixture of Gaussians. PCA is the most fundamental data analysis method which finds the optimal low dimensional subspace that explains the most variance of the high dimensional data. PCA further gives rise to the class of spectral methods used in statistical inference, with

the Clustering Mixture of Gaussians being one of the most significant applications.

Contributions. We summarize the contributions of this work as follows.

- 1. This work provides formal theoretical guarantees for two unsupervised learning problems including the PCA and Clustering Mixture of Gaussians. Our results reveal that Transformers can learn from past experience and generalize toward unseen problems through the learning of algorithms. To the best of our knowledge, no existing works provide guarantees on un-supervised learning for pretrained Transformers, which is an important task in data analysis.
- 2. The idea of our proof draws connections between statistical guarantees with algorithmic designs. In particular, we design algorithms specifically tailored to prove the approximation guarantees of Transformers. For the PCA problem, we consider drawing connections between the Power Method and the forward propagation of multi-layered Transformers. For the Clustering Mixture of Gaussians problem we design a spectral method which can be approximated by Transformers. Moreover, our results also highlight that complicated algorithms can be dissected into multiple atomic algorithms. Then, the complete network can be decomposed into multiple sub-networks that implement individual atomic algorithms respectively.
- 3. We perform extensive simulations to demonstrate that pre-trained Transformers are able to perform unsupervised learning tasks even when the assumptions leading to the theoretical results fail to hold. Our empirical evaluations are performed for both the synthetic data and real-world datasets. Our experiments also bridge the gap between assumptions in theory and practice.

1.1 Related Works

We discuss over the related literature in this section.

In-Context Learning of Transformers. Some recent works studied the in-context learning (ICL) capacities of Transformers [\[5,](#page-72-2) [11\]](#page-73-1). In the in-context learning framework, the input is given by a sequence of token-label pairs $\{(\boldsymbol{X}_i, y_i)\}_{i \in [N]}$ where there is an implicit function f such that $y_i = f\left(\mathbf{X}_{[1:i]}\right)$. The goal is to predict y_{N+1} given the input of the complete episode. This learning setup resembles the language generating mechanism of the LLMs and differs significantly from the standard supervised learning setup. [\[5\]](#page-72-2) considered the approximation and generalization properties of Transformers on the ICL tasks, including many linear regression and logistic regression setups.

In contrast to the in-context learning setup, the problem considered in this work follows from unsupervised learning, where the predictor is constructed out of the complete episode of observations. Moreover, the unsupervised learning setup differs from the in-context learning through the lack of individual label in the input matrix. For the proof machine, this work adopts similar ideas with [\[2,](#page-72-0) [31\]](#page-75-2) who consider the approximation of transformers on gradient descent when performing ICL. However, the algorithms implemented in this work is more complicated and technical in its design.

Other related works on the more practical side of ICL can be found in [\[10\]](#page-73-2) and reference therein.

Other Theoretical Works on Transformers. This paragraph reviews other theoretical works on the approximation of Transformers. [\[37\]](#page-76-1) studied the universal approximation properties of Transformers on sequence-to-sequence functions. [\[7,](#page-72-3) [21,](#page-74-1) [26\]](#page-75-3) studied the computational power of Transformers. [\[14\]](#page-73-3) studied the limit of infinite width multi/single head

Attentions. [\[35\]](#page-76-2) showed that transformers can process bounded hierarchical languages and demonstrate better space complexity than the recurrent neural networks. After a careful review over these line of works, we find that the unsupervised learning problem considered in this work does not fall into the general framework of our previous works.

Notations In this work we follow the following notation conventions. The vector valued variable is given by boldfaced characters. We denote $[n] := \{1, \ldots, n\}$ and $[i : j] :=$ $\{i, i+1, \ldots, j\}$ for $i < j$. The universal constants are given by C and are ad hoc. For a vector v we denote $||v||_2$ as its L_2 norm. For a matrix $\mathbf{A} \in \mathbb{R}^{m \times n}$ we denote its operator norm as $||A||_2:= \sup_{v\in\mathbb{S}^{n-1}} ||Av||_2$. Given two sequences a_n and b_n , we denote $a_n \lesssim b_n$ or $a_n = O(b_n)$ if $\limsup_{n\to\infty} \left|\frac{a_n}{b_n}\right|$ $\frac{a_n}{b_n}$ | < ∞ and $a_n = o(b_n)$ if $\limsup_{n \to \infty} \left| \frac{a_n}{b_n} \right|$ $\frac{a_n}{b_n} \Big| = 0.$

Organizations The rest of the paper is organized as follows: Section [2](#page-4-0) discusses the assumptions and results for the PCA problem; Section [3](#page-13-0) provides theoretical results for Clustering Mixture of Gaussians; Section [4](#page-17-0) provides extensive experimental details and results for both the synthetic and real-world datasets; Section [5](#page-30-0) discusses the limitations and future works. The detailed proofs and additional figures in experiments are delayed to the supplementary materials.

2 Learning PCA

This section discusses how we construct a multi-layered Transformer model such that its forward propagation gives us the left principal eigenvectors of the input matrix. Our presentation is split into 4 subsections: In section [2.1](#page-5-0) we review the mathematical forms of the Transformer model in this work; In section [2.2](#page-7-0) we review the classical Power Method algorithm to perform PCA and connect it with the multi-layered Transformer design; In

section [2.3](#page-9-0) we showcase how to perform supervised pre-training to achieve a model in section [2.2;](#page-7-0) In section [2.4](#page-10-0) we present the theoretical results.

2.1 The Transformers

Tansformers

This section reviews the Transformer architecture considered in this work. We start by defining the Attention and the Fully Connected Layer (FC). Then we formally define both the architecture of the Transformers and its space of parameters. These definitions are similar to [\[5\]](#page-72-2).

def:attention

Definition 1 (Attention Layer). A self-Attention layer with M heads is denoted as $Attn_{\theta_1}(\cdot)$ with parameters $\boldsymbol{\theta}_1 = \{(\boldsymbol{V}_m, \boldsymbol{Q}_m, \boldsymbol{K}_m)\}_{m \in [M]} \subset \mathbb{R}^{D \times D}$. On an input sequence $\boldsymbol{H} \in \mathbb{R}^{D \times N}$,

Attn_{\boldsymbol{\theta}_1}(\boldsymbol{H}) = \boldsymbol{H} + \frac{1}{N} \sum_{m=1}^M (\boldsymbol{V}_m \boldsymbol{H}) \sigma \left((\boldsymbol{Q}_m \boldsymbol{H})^{\top} (\boldsymbol{K}_m \boldsymbol{H}) \right),
$$

where σ is the ReLU activation function.

Remark 1. We make the following simplification for Transformers: Instead of the concatenated feature given by multi-head Attention, we consider a simple average on the multi-head output; the activation function we considered is ReLU instead of Softmax that appears in most empirical works; we omit the layer-wise normalization used to stabilize the training procedure. We note that the approximation of Softmax function is also doable with significant complication in the parameter design, following the representation idea in [\[6\]](#page-72-4) instead of [\[3\]](#page-72-5), which we left for future work. The other adjustments are mainly due to technical reasons. Recent works including [\[28\]](#page-75-4) empirically verified that ReLU Tansformers are strong alternatives to Softmax Tansformers. In section [4](#page-17-0) we carefully evaluate the effect of these additional features.

The following defines the classical FC layers with residual connections.

Definition 2 (FC Layer). A FC layer with hidden dimension D' is denoted as $FC_{\theta}(\cdot)$ with parameter $\boldsymbol{\theta}_2 \in (\boldsymbol{W}_1, \boldsymbol{W}_2) \in \mathbb{R}^{D' \times D} \times \mathbb{R}^{D \times D'}$. On any input sequence $\boldsymbol{H} \in \mathbb{R}^{D \times N}$, we define

$$
FC_{\boldsymbol{\theta}_2}(\boldsymbol{H}):=\boldsymbol{H}+\boldsymbol{W}_2\sigma(\boldsymbol{W}_1\boldsymbol{H}).
$$

Then we use the above two definitions on the FC and the Attention layers to define the Transformers.

Definition 3 (Transformer). We define a Tansformer $TF_{\theta}(\cdot)$ as a composition of self-Attention layers with FC layers. When the output dimension is D, an L-layered Transformer is defined by

$$
TF_{\boldsymbol{\theta}}(\boldsymbol{H}):=\tilde{\boldsymbol{W}}_0\times FC_{\boldsymbol{\theta}_2^L}(Attn_{\boldsymbol{\theta}_1^L}(\cdots FC_{\boldsymbol{\theta}_2^1}(Attn_{\boldsymbol{\theta}_1^1}(\boldsymbol{H})))\times \tilde{\boldsymbol{W}}_1,
$$

where $\tilde{\mathbf{W}}_0 \in \mathbb{R}^{d_1 \times D}$ and $\tilde{\mathbf{W}}_1 \in \mathbb{R}^{N \times d_2}$.

We use θ to denote the vectorization of all the parameters in the Transformer and the super-index ℓ to denote the parameter matrix corresponds to the ℓ -th layer. Under these definitions, the parameter θ of the Transformer is given by

$$
\boldsymbol{\theta}=\{\{(\{\boldsymbol{Q}_m^{\ell},\boldsymbol{K}_m^{\ell},\boldsymbol{V}_m^{\ell}\}_{m\in[M]},\boldsymbol{W}_1^{\ell},\boldsymbol{W}_2^{\ell})\}_{\ell\in[L]},\tilde{\boldsymbol{W}}_0,\tilde{\boldsymbol{W}}_1\}.
$$

Remark 2. The model's Lipchitzness can be strictly governed by the following parameters: (1) The number of layers; (2) The number of heads; (3) The maximum operator norm of the parameters. These results further lead to an upper bound on the generalization error through the complexity of Lipschitz functions. The following defines the norm on the parameters of Transformers.

$$
\|\boldsymbol{\theta}\|_{op} := \max_{\ell \in [L]} \Big\{ \max_{m \in [M^{\ell}]} \big\{ \|\boldsymbol{Q}_m^{\ell}\|_2, \|\boldsymbol{K}_m^{\ell}\|_2 \big\} + \sum_{m=1}^{M^{\ell}} \|\boldsymbol{V}_m^{\ell}\|_2 + \|\boldsymbol{W}_1^{\ell}\|_2 + \|\boldsymbol{W}_2^{\ell}\|_2 + \|\boldsymbol{\tilde{W}}_0\|_2 + \|\boldsymbol{\tilde{W}}_1\|_2 \Big\},\
$$

where M^{ℓ} is the number of heads of the ℓ -th Attention layer.

The two additional matrices \tilde{W}_0 and \tilde{W}_1 serve for the dimension adjustment purpose such that the output of TF_{θ} () will be of dimension $\mathbb{R}^{d_1 \times d_2}$.

2.2 The Power Method

the power method To show that the pre-trained Transformers are able to perform PCA for the input data, we show that a particular parameter construction of the Transformer can approximate algorithms. In particular, the approximation part of our theorem is proved through showing that multi-layered Transformers are able to approximate the classical Power Method used for Singular Value Decomposition [\[13\]](#page-73-4). The formal algorithm is given by [1.](#page-7-1)

The algorithm first generates the symmetrized covariate matrix $\mathbf{A} = \mathbf{X} \mathbf{X}^{\top}$. Then, for each eigenvector that we hope to recover, the Power Method generates a random vector uniformly distributed on the unit sphere. Then, we iteratively take the matrix product between the symmetric matrix **A** and $v_{0,\ell}$, followed by normalizing it. Note that such an iterative matrix product can finally converge to the top-1 principal eigenvector.

Figure 1: The Constructive Proof for the Approximation of PCA. The above diagram illustrates the construction of our Transformer model in the existence proof of theorem [2.1.](#page-11-0) There are three important sub-networks in the design: (1) The Symmetrization sub-network symmetrizes X and stamp $\boldsymbol{X} \boldsymbol{X}^{\top}$ in the output, which corresponds to the first step in the Power Method. (2) The Power Iterations sub-network performs in total of τ iterations for each of the principal eigenvectors, corresponds to the iterative update step in the Power Method. (3) The Removal of principal Eigenvectors subnetwork performs the estimate of λ_{ℓ} and the update of matrix A_{ℓ} in the Power Method. Finally, we apply \tilde{W}_0 and \tilde{W}_1 to adjust the dimension of the output. The different colors in the diagram correspond to the different types of layers: (1) Yellow Blocks denote the Attention layer with 2 heads. (2) Orange Blocks denote the multihead Tansformers with larger $M \gg 2$. (3) Pink Blocks denote the FC layer. fig:diagram

The iterative structure is akin to the forward propagation of the Transformer architecture. Given such similarities, we show that there exists a parameter setup for Transformers such that the forward propagation performs PCA. The challenge is in constructing parameters that approximate the complete procedure of the Power Method.

In figure [1,](#page-8-0) we provide an approximate algorithm for the Power Method through the lens of a forward propagation on the Transformer. This algorithm dissects the approximation of the Power Method into the propagation along multiple sub-networks, each phase corresponding to a single step in the Power Method. Combining them, we show in section [2.4](#page-10-0) that Transformers achieve good approximation guarantees.

2.3 Pretraining via Supervised Learning

The standard PCA problem is unsupervised where no labels are given. However, the Transformers are usually used in the supervised learning setup. To make full use of Transformers in the PCA task, we need to perform supervised pre-training. In our theoretical analysis, we construct the input of the Transformer as a *context-augmented matrix* given by the following

pretrain

$$
\boldsymbol{H} = \begin{bmatrix} \boldsymbol{X} \\ \boldsymbol{P} \end{bmatrix} \in \mathbb{R}^{D \times N}, \qquad \boldsymbol{P} = \begin{bmatrix} \tilde{p}_{1,1}, \dots, \tilde{p}_{1,N} \\ \tilde{p}_{2,1}, \dots, \tilde{p}_{2,N} \\ \vdots \\ \tilde{p}_{\ell,1}, \dots, \tilde{p}_{\ell,N} \end{bmatrix} \in \mathbb{R}^{(D-d) \times N},

where the matrix P contains contextual information, which is specified in section [2.4.](#page-10-0) The design also makes sure P is unrelated to X . In the experiments, we show that the auxiliary matrix \boldsymbol{P} is not necessary for the pre-trained Transformer to perform PCA with high accuracy. For the output, our theoretical analysis gives the following matrix

$$
TF_{\boldsymbol{\theta}}(\boldsymbol{H}) = \begin{bmatrix} \widehat{\boldsymbol{v}}_1^{\top} & \dots & \widehat{\boldsymbol{v}}_k^{\top} \end{bmatrix}^{\top} \in \mathbb{R}^{dk}

which corresponds to the estimated principal eigenvectors of the matrix \boldsymbol{X} .

The Learning Problem. Consider a set of samples $\{X_i\}_{i\in[u]}$ i.i.d. sampled from some distribution p_X , we construct their oracle top-k principal components as $V_i =$ \lceil $\boldsymbol{v}_1^{i,\top}$ $\stackrel{i,\top}{\hspace{2.2cm} \cdot \cdot \cdot} \quad \stackrel{i,\top}{\hspace{2.2cm} \cdot \cdot \cdot \cdot \cdot}$ k ⊺⊺ and the context-augmented input matrix as H_i for each X_i . Then, the pretraining procedure is given by minimizing the following objective for some convex loss function $L(\cdot, \cdot)$: $\mathbb{R}^{dk} \times \mathbb{R}^{dk} \to \mathbb{R},$

Here we consider $\Theta(B_{\theta}) := {\theta : ||\theta|| \leq B_{\theta}, \max_{\ell} M^{\ell} \leq B_M}$ to be the space of parameters. We also consider guarantees in the L_2 norm which states that $L(\boldsymbol{x}_1, \boldsymbol{x}_2) := ||\boldsymbol{x}_1 - \boldsymbol{x}_2||_2$ in the theoretical part. Despite that the problem is non-convex and global minima is not computational feasible to achieve, the ERM solution still reveals the strong capacities of Transformers in statistical inference tasks. We further show that the local minimizers obtained through stochastic gradient descent achieve good empirical performance in section [4.](#page-17-0)

2.4 Theoretical Results

This section presents our theoretical results. Our proof goes by constructing a particular instance of the transformers and shows that the forward propagation on our constructed instance approximates the power method. For the purpose of this construction, we also carefully design the auxiliary matrix P explained as follows.

The Design of Auxillary Matrix. Our design of the matrix P consists of three parts:

- 1. Place Holder. For $\ell \in \{1\} \cup [4 : k+3]$ and $i \in [N]$, we let $\tilde{\boldsymbol{p}}_{\ell,i} = \mathbf{0} \in \mathbb{R}^{d \times 1}$. The place holders in \bf{P} record the intermediate results in the forward propagation.
- 2. Identity Matrix. We let $\begin{bmatrix} \tilde{\mathbf{p}}_{2,1} & \dots & \tilde{\mathbf{p}}_{2,N} \end{bmatrix} =$ \lceil \boldsymbol{I}_d 0 $_{d\times (N-d)}$ 1 . The identity matrix in **P** helps us screen out all the covariates \boldsymbol{X} in the forward propagation.
- 3. Random Samples on the Hypersphere. We let $\tilde{\mathbf{p}}_{3,1}, \ldots, \tilde{\mathbf{p}}_{3,k}$ be the i.i.d. samples uniformly distributed on \mathbb{S}^{d-1} . The random samples on the sphere correspond to the initial vectors $\mathbf{v}_{0,\ell}$ for $\ell \in [k]$ in algorithm [1.](#page-7-1)

The auxiliary matrix is designed for pure technical reason. Moreover, our experiments suggest that such auxiliary matrix is not necessary in the task, which is detailed in section [4.](#page-17-0) Given the above construction on the auxiliary matrix P , we are ready to state the approximation theorem, given as follows. thm3.1

Theorem 2.1 (Transformer Approximation of the Power Method). Assume that the eigenvalues of $\boldsymbol{X}\boldsymbol{X}^{\top}$ to be $\lambda_1 > \lambda_2 > \ldots > \lambda_k > \ldots$ Let $\Delta := \min_{1 \leq i < j \leq k} |\lambda_i - \lambda_j|$. Assume that the initialized vectors $\tilde{p}_{3,1}, \ldots \tilde{p}_{3,N}$ satisfy $\tilde{p}_{3,i}^{\top}$ $v_i \geq \delta$ for all $i \in [k]$ and make the rest of the vectors 0. Then, there exists a Transformer model with number of layers $L = 2\tau + 4k + 1$ and number of heads $B_M \leq \lambda_1^d \frac{C}{\epsilon^2}$ $\frac{C}{\epsilon^2}$ with $\tau \leq \frac{\log(1/\epsilon_0 \delta)}{\epsilon_0}$ $\frac{1/\epsilon_0 \delta)}{\epsilon_0}$ such that for all $\epsilon_0, \epsilon > 0$, the final output $\widehat{\mathbf{v}}_1, \ldots, \widehat{\mathbf{v}}_k$ given by the Transformer model achieve

Moreover, consider the accuracy of multiple **v**s as a whole. There exists $\boldsymbol{\theta} \in \Theta(B_{\lambda_1}, B_M)$ that satisfies

L(TF_{\theta}(\boldsymbol{H}), \boldsymbol{V}) \leq C\tau \epsilon k \lambda_1^2 + C \left(\frac{\epsilon_0 \lambda_1^2}{\Delta^2} \sum_{\eta=1}^{k-1} \prod_{i=1}^{\eta} \frac{25 \lambda_{i+1}^2}{\Delta^2}\right)^{1/2}
$$

remark3

Remark 3. The approximation error consists of two terms. The first term comes from the approximation of the Power Method iterations by Transformers. The second term comes from the error caused by finite iteration τ . To get intuition of the error terms and its order of magnitude, we consider a special case where the eigenvalues $\lambda_1 \leq \lambda_2 \leq \ldots \leq \lambda_k \leq \Delta$. Then our results boil down to

$$
\left\|TF_{\boldsymbol{\theta}}(\boldsymbol{H})-\left[\boldsymbol{v}_1^\top,\boldsymbol{v}_2^\top,\ldots,\boldsymbol{v}_k^\top\right]^\top\right\|_2 \lesssim \tau \epsilon k \lambda_1^2 + \frac{\lambda_1}{\Delta} \sqrt{k \epsilon_0}.
$$

These results hide dimension d in the universal constant. We note that the dimension significantly affects the approximation bound of Transformers. This is mainly due to the limitations given by approximating high dimensional functions by ReLU neural networks.

In the above theorem, our results rely on the random initialization of P . We show that the conditions on $\tilde{\mathbf{p}}_{3,1}, \ldots, \tilde{\mathbf{p}}_{3,N}$ can be achieved through sampling from isotropic Gaussians, given by the following lemma.

Lemma 2.1. Let $y \in \mathbb{R}^d$ be a random vector with isotropic Gaussian as its probability density. Consider $\mathbf{x} = \frac{\mathbf{y}}{\|\mathbf{x}\|}$ $\frac{y}{\|y\|_2}$. Let v be any unit length vector, then we have for all $\delta < \frac{1}{2}d^{-1}$, $\mathbb{P}\left(|\boldsymbol{v}^\top \boldsymbol{x}| \leq \delta\right) \leq \frac{1}{\sqrt{\delta}}$ π $\sqrt{\delta} + \exp\left(-C\delta^{-\frac{1}{2}}\right)$. Therefore, for all $\delta < \frac{1}{2}d^{-1}$, the event in theorem [2.1](#page-11-0) is achieved with

$$
\mathbb{P}\bigg(\exists i \in [k] \text{ such that } \mathbf{x}_i^\top \mathbf{v}_i \leq \frac{\delta}{\sqrt{d}}\bigg) \leq \frac{k\sqrt{\delta}}{\sqrt{\pi}} + k \exp(-C\delta^{-1}).
$$

Given the approximation error provided by theorem [2.1,](#page-11-0) we further provide the generalization error bound for the ERM defined by equation [1.](#page-10-1) This requires us to consider the following regularity conditions on the underlying distribution of $\boldsymbol{X}\boldsymbol{X}^\top$ (which also translates to the distribution for the pre-training instances \boldsymbol{X}).

Assumption 1 (Problems for Pre-training). The distribution of $\boldsymbol{X}\boldsymbol{X}^\top$ supports on

$$

Remark 4. The above assumption can be generalized to distribution that supports on X with high probability. Examples of such distribution include the Wishart distribution under the Gaussian design, which is elaborated in the Gaussian mixture model example in section [3.](#page-13-0)

Given the above assumption, we are ready to state the generalization bound. genbound

Proposition [1](#page-13-1). Under assumption 1 and using the notations given by theorem [2.1,](#page-11-0) with probablity at least $1 - \xi$, the ERM solution $\widehat{\boldsymbol{\theta}}$ satisfies

$$
\mathbb{E}\left[L\left(TF_{\hat{\theta}}(\boldsymbol{H}),\boldsymbol{V}\right)\big|\hat{\theta}\right] \leq \inf_{\theta \in \Theta(B_{\theta},B_M)} \mathbb{E}\left[L\left(TF_{\theta}(\boldsymbol{H}),\boldsymbol{V}\right)\right] + C\sqrt{\frac{k^3 L B_M d^2 \log(B_X + k) + \log(1/\xi)}{n}}.
$$

Corollary 2.1.1. Under assumption [1,](#page-13-1) with probability at least $1-\xi-\frac{k\sqrt{2}}{\sqrt{2}}$ $\frac{k\sqrt{\delta}}{\sqrt{\pi}}-k\exp\left(-C\delta^{-1/2}\right)$ for all $\delta < d^{-1}$ we have for all $\epsilon, \epsilon_0 > 0$,

$$
L_{PCA}(\widehat{\theta}, \mathbf{P}) := \mathbb{E}\left[L\left(TF_{\widehat{\theta}}(\mathbf{H}), \mathbf{V}\right) \Big| \widehat{\theta}, \mathbf{P}\right] \lesssim \tau \epsilon k \lambda_1^2 + \left(\frac{\epsilon_0 \lambda_1^2}{\Delta^2} \sum_{\eta=1}^{k-1} \prod_{i=1}^{\eta} \frac{25\lambda_{i+1}^2}{\Delta^2}\right)^{1/2} + \sqrt{\frac{k^3 \log(\delta/\epsilon_0) B_X^d d^2 \log(B_X + k) + \log(1/\xi)}{n \epsilon_0 \epsilon^2}}.
$$

Remark 5. If we consider optimizing the bound w.r.t. ϵ_0 and ϵ , we obtain that $L_{PCA}(\widehat{\theta}, P) \lesssim$ $n^{-1/5}$ with high probability, given that the parameters and the dimension d are of constant scales.

3 Clustering a Mixture of Gaussians

sect3.1

Based on the results obtained in section [2,](#page-4-0) this section provides theoretical results for clustering mixture of Gaussians, a problem that can be solved by spectral algorithms [\[17\]](#page-73-5)

using PCA as a sub-procedure. However, existing literature always requires additional algorithms to accomplish this task, which are not easily implementable by Transformers. To address this limitation, we design a simple spectral algorithm that is simple to implement by the Transformer infrastructure. Our results in this section demonstrate that Transformers are able to memorize a much larger class of inference algorithms with PCA used as subprocedures. In section [3.1](#page-14-0) we review the problem setup. In section [3.2](#page-15-0) we present the algorithms and theoretical results for Transformer learning.

3.1 Problem Setup

mixture

In the problem of clustering two class Gaussian mixture model, we are given in total of N i.i.d. samples $\{X_i\}_{i\in[N]}$ from a spherical Gaussian mixture model with two centers μ_0 and μ_1 . We consider the data generating procedure of X_i as first flipping a fair coin and if tail appears we assign \boldsymbol{X}_i 's cluster to be 0 and generate it from $N(\boldsymbol{\mu}_0, I_d)$. Else, we assign \mathbf{X}_i 's cluster to be 1 and generate it from $N(\boldsymbol{\mu}_1, I_d)$. Denote the cluster membership as $z \in \{0,1\}^N$. The conditional p.d.f. of \mathbf{X}_i is given as follows:

$$
\mathbb{P}(\boldsymbol{X}_i=\boldsymbol{x}|z_i=\alpha)=\frac{1}{(2\pi)^{\frac{d}{2}}}\exp\Big(-\frac{1}{2}\|\boldsymbol{x}-\boldsymbol{\mu}_{\alpha}\|_2^2\Big), \quad \alpha\in\{0,1\}.
$$

For the task of clustering mixtures of 2 GMMs, we use the following loss function

$$
L_{GMM}(\hat{z}, z) = \min_{\tilde{z} \in \{z, 1-z\}} \frac{1}{N} \sum_{i=1}^{N} ||\hat{z}_i - \tilde{z}_i||_1.
$$
gmmloss (2)

And we are interested in the statistical guarantees for the ERM solution of the above problem given in total of n pretraining instances $\{\boldsymbol{X}^{(i)}\}_{i\in[n]}$ and $\{z^{(i)}\}_{i\in[n]}$. We denote the estimator given by the Transformer as $TF_{\theta}(\boldsymbol{H}^{(i)})$ for the *i*-th pretraining instance. Then the ERM estimator is given by

$$
\widehat{\boldsymbol{\theta}}_{GMM} := \argmin_{\boldsymbol{\theta}} \sum_{i=1}^{n} L_{GMM} \left(T F_{\boldsymbol{\theta}}(\boldsymbol{H}^{(i)}), z^{(i)} \right).
$$

3.2 Theoretical Results

gmm:theoretical

We develop algorithm [2](#page-15-1) to prove the theoretical guarantees for ERM solution given by equation [3.](#page-14-1) In comparison to the algorithms proposed in the literature [\[17\]](#page-73-5), our algorithm do not require extra procedures. Instead, algorithm [2](#page-15-1) approximates the Bayes estimator in this problem, whose decision boundary is given by the hyperplane orthogonal to $\mu_1-\mu_0$ and passes through the point $\frac{1}{2}(\mu_1 + \mu_0)$. To avoid the difficulties of analyzing the performance of the post-selection estimator, we first split the data into the first N_1 columns and the rest $N - N_1$ columns. We denote the mean vector $\bar{\mathbf{X}} := \frac{1}{N_1} \sum_{i=1}^{N_1} \mathbf{X}_i$. Then we utilize the empirical estimate of the population covariance matrix given by the first N_1 columns as

$$
\widehat{\Sigma} = \frac{1}{N_1} \sum_{i=1}^{N_1} \left(\boldsymbol{X}_i - \bar{\boldsymbol{X}} \right) \left(\boldsymbol{X}_i - \bar{\boldsymbol{X}} \right)^\top.
$$
empiriclcov (4)

It is not hard to note that the principle direction of the population matrix is exactly $\mu_0-\mu_1$. We therefore project all the rest of the samples to the direction given by the first principal component \widehat{v}_1 of $\widehat{\Sigma}$ and compare it with the mid point $\boldsymbol{v}_1^{\top} \left(\frac{1}{N} \right)$ $\frac{1}{N_1}\sum_{i=1}^{N_1}\boldsymbol{X}_i \Big) = \boldsymbol{v}_1^\top \bar{\boldsymbol{X}}.$

$\text{Algorithm 2: Clustering Bi-class GMM}$

Data: Matrix $\mathbf{X} \in \mathbb{R}^{d \times N}$, Number of Iterations τ

Consider the estimated sample covariance matrix given by equation [4;](#page-15-2)

Apply algorithm [1](#page-7-1) on $\hat{\Sigma}$ and obtain its first principal component $\hat{\mathbf{v}}_1$;

Before we provide formal guarantees for the Transformer solution, we provide the following theorem for algorithm [2.](#page-15-1)

Theorem 3.1. Let
$$
N_1 \approx d^{\frac{1}{3}} N^{\frac{2}{3}} (\|\mu_1 - \mu_0\|_2 + \log N)^{\frac{2}{3}}
$$
. Assume that $\|\mu_1 - \mu_0\|_2 \gtrsim \sqrt{\log N/d}$.

Then algorithm [2](#page-15-1) achieves the following upper bound

$$
\mathbb{E}\Big[L_{GMM}\left(\widehat{z},z\right)\Big]\lesssim \bigg(\frac{d\log^{2}N}{N}\bigg)^{\frac{1}{3}}.
$$

Transformer Approximation. We construct weights for a multi-layered Transformer whose forward propagation approximates algorithm [2.](#page-15-1) Our first result demonstrates the approximation error of the Transformer model to that of algorithm [2](#page-15-1) as follows. lm:4.1

Lemma 3.1. Consider input with the auxiliary matrix defined by equation [5.](#page-16-0) There exists a Transformer with number of layers $L = 2\tau + 7$, number of heads $B_M \leq \lambda_1^d \frac{C}{\epsilon^2}$ $\frac{C}{\epsilon^2}$ and $\tau \leq$ $\log(1/\epsilon_0\delta)$ $\frac{1}{\epsilon_0}$ such that with probability at least 1 – √ $\frac{\sqrt{\delta}}{\sqrt{\pi}} - \exp(-C\delta^{-1})$ there exist parameters $\boldsymbol{\theta}$ such that the output of this Transformer satisfies

$$
TF_{\theta}(\boldsymbol{H}) = \left[\tanh\left(\beta \boldsymbol{v}_{1}^{TF,\top}(\boldsymbol{X}_{1} - \bar{\boldsymbol{X}})\right) \dots \tanh\left(\beta \boldsymbol{v}_{1}^{TF,\top}(\boldsymbol{X}_{N} - \bar{\boldsymbol{X}})\right)\right],
$$

where $\|\widehat{\boldsymbol{v}}_{1}^{TF} - \widehat{\boldsymbol{v}}_{1}\|_{2} \lesssim \frac{\log(1/\epsilon_{0}\delta)}{\epsilon_{0}} \epsilon \lambda_{1}^{2} + \frac{\lambda_{1}\sqrt{\epsilon_{0}}}{\Delta} + \epsilon_{0}.$

For technical purpose, in our proof we consider auxiliary matrix P to be designed as

$$
\boldsymbol{P}^{GMM}:=\begin{bmatrix} \boldsymbol{0}_{d\times N} \\ \tilde{p}_{1,1} & \ldots & \tilde{p}_{1,N} \\ \tilde{p}_{2,1} & \ldots & \tilde{p}_{2,N} \\ \vdots & & & \\ \tilde{p}_{\ell,1} & \ldots & \tilde{p}_{\ell,N} \end{bmatrix} . \hspace{1cm} \text{auxillarymat} \atop \text{auxillarymat}
$$

where instead of using $\tilde{p}_{1,i} \in \mathbb{R}^d$ and $\tilde{p}_{1,i,j} := \mathbb{1}_{i=j,j \leq d}$ in the proof of theorem [2.1](#page-11-0) we consider using $\tilde{\mathbf{p}}_{1,i} \in \mathbb{R}^{N_1}$ and $\tilde{\mathbf{p}}_{1,i,j} := \mathbb{1}_{i=j,j \leq N_1}$. Then we consider the following assumption characterizing the space. assump2

Assumption 2 (Problems for Pre-training). We assume that the pre-training instances ${\{\boldsymbol{\mu}_1,\boldsymbol{\mu}_0,N\}_{i\in[n]}}$ are sampled from arbitrary distribution supported on the following space

$$
\left\{\boldsymbol{\mu}_1,\boldsymbol{\mu}_0,N:\sqrt{\log(N/d)}\lesssim \|\boldsymbol{\mu}_1-\boldsymbol{\mu}_0\|_2\leq B_{\boldsymbol{\mu}},N\asymp B_N\right\}.
$$

Then, the following theorem provides a theoretical guarantee for the expected error of $\widehat{\boldsymbol{\theta}}_{GMM}.$ thm3.2

Theorem 3.2. Under assumption [2](#page-16-1) and use n i.i.d. instances $\{(\boldsymbol{X}^{(i)}z^{(i)})\}_{i\in[n]}$ to pretrain the transformer. Then we take $\epsilon_0 = \frac{1}{\sqrt{2}}$ ϵ and $\epsilon = \left(n^{-\frac{1}{2}}B^{d-2}_{\mu}d(\log B_{\mu})^{\frac{1}{2}}\right)^{\frac{4}{7}}$. The ERM solution $\widehat{\boldsymbol{\theta}}_{GMM}$ satisfies

$$
\mathbb{E}[L_{GMM}(TF_{\boldsymbol{\theta}_{GMM}}(\boldsymbol{H}),z)] \lesssim \Big(\frac{d\log^2 N}{N}\Big)^{\frac{1}{3}} + B_{\boldsymbol{\mu}}^{\frac{2d+8}{7}} d^{\frac{2}{7}} n^{-\frac{1}{7}} (\log B_{\boldsymbol{\mu}})^{\frac{1}{7}} \beta^{\frac{4}{7}}.
$$

Remark 6. Our theorem suggests that the final learning error of Transformers in clustering the mixture of Gaussians can be characterized by two terms: (1) The first term being oracle error given by theorem [3.1;](#page-15-3) (2) The second term being the error incurred by the pretraining procedure. It is also noted that for a sufficiently large pre-training set where $n \gtrsim$ $\int d\log^2 N$ $\int_{N}^{\frac{1}{2}} B^{2d+8}_{\mu} d^{2}(\log B_{\mu}) \beta^{4}$ we have the final learning bound matching that of theorem [3.1.](#page-15-3) We further discuss the improvement of the rates in section [5.](#page-30-0)

4 Simulations

sect4

This section provides simulation details and results on synthetic and real-world datasets. Our simulations are designed for three problems: (1) Prediction of eigenvalues and principal components are given by section [4.1;](#page-17-1) (2) Clustering Mixture of Gaussians is given by section [4.2.](#page-22-0)

4.1 The Prediction of Pincipal Components/Eigenvalues

In this section, we first provide a brief overview of the experimental setup. Then, we provide details on the data preparations for both the synthetic and real-world datasets, the

Experimental Setup. Our experiments for the prediction of principal components and eigenvalues goes by first constructing the training set. Using this set, we train a Transformer model by modifying the GPT-2 architecture [\[27\]](#page-75-5)into an encoder-based model with ReLU activation function. Then we evaluate the model on evaluation dataset each with 1,280 data points. Each experiment repeats this procedure with three different random seeds. We record the average performance of Transformers in the prediction tasks of both top-k eigenvalues and principal eigenvectors.

All experiments run on RTX 2080 Ti GPUs. We construct training pipeline using PyTorch library [\[24\]](#page-74-2) and generate data using the Scikit-learn library [\[25\]](#page-74-3). Training with 20k

steps takes approximately 0.5 hours for a small Transformer. Most tasks use 20k training steps with learning rates 0.001 with the exception being the multiple top-k eigenvector prediction task where we train the model for 150k steps with a learning rate of 0.0005.

Metrics. For eigenvalues, we use relative mean squared error (RMSE) as loss function L_{RMSE} and evaluation metric. For the loss of predicting top-K eigenvalue, the loss function is defined as follows

$$
L_{\text{RMSE}}(\lambda_i, \hat{\lambda}_i) \coloneqq \frac{1}{K} \sum_{i=1}^K \frac{\lambda_i - \hat{\lambda}_i}{\lambda_i + \epsilon}.
$$

The ϵ in the denominator ensures numerical stability by preventing division by zero. For eigenvectors, we use cosine similarity as loss function and evaluation metric. For predicting top-K eigenvectors, denote $V =$ $\sqrt{ }$ v_1 ... v_k $\mathcal{E} \in \mathbb{R}^{d \times k}$ be the matrix of ground truth eigenvectors and \hat{V} the predicted eigenvector matrix. When we are predicting k eigenvectors,

the loss function is defined as

$$
L_{\cos}(\boldsymbol{V},\hat{\boldsymbol{V}})\coloneqq\frac{1}{K}\sum_{i=1}^{K}1-\frac{\boldsymbol{v}_{i}\cdot\widehat{\boldsymbol{v}}_{i}}{\max(\|\boldsymbol{v}_{i}\|_{2}\cdot\|\widehat{\boldsymbol{v}}_{i}\|_{2},\epsilon)},
$$

where v_i represent the *i*-th eigenvector. It is not hard to check the relationship between these loss functions with the classical L_2 losses. In addition to cosine similarity, we also use the eigenspace distance as another training objective. The eigenspace distance is defined as the Frobenius norm of the difference between the two projection matrices:

$$
L_{\text{eig}}(\boldsymbol{V}, \hat{\boldsymbol{V}}) = \frac{1}{2} \|\boldsymbol{V} \boldsymbol{V}^{\top} - \hat{\boldsymbol{V}} \hat{\boldsymbol{V}}^{\top}\|_{\text{F}}^2,
$$

which measures how well the subspaces spanned by the eigenvectors are preserved in the prediction.

Preparation for the Synthetic Data. For synthetic data $\mathbf{X} \in \mathbb{R}^{d \times N}$, we generate each column with a randomly initialized multivariate Gaussian distribution $\mathcal{N}(\mu, \Sigma)$ where Σ is a random matrix. Specifically, for each $\mathbf{X}_i \in \mathbb{R}^d$, we sample $\mathbf{Z}_i \sim N(0, I) \in \mathbb{R}^d$. We form $\mathbf{Z} = [\mathbf{Z}_1, \cdots, \mathbf{Z}_N]$ and transform it using matrix $\mathbf{L} \sim N(0, I_{d^2}) \in \mathbb{R}^{d \times d}$, yielding the

desired training sample X. We then generate the labels as the top-k eigenvalues λ and eigenvectors V of the empirical covariance matrix $X^{\top}X/N$ via numpy.linalg.eigh.

Data Preparation for Real World Data. We choose MNIST [\[1\]](#page-72-6) and Fashion-MNIST (FMNIST) [\[34\]](#page-76-3) as our real-world datasets. The training set is constructed by applying the SVD on the samples and using them as the labels for the input. And in the testing phase we input unseen images and evaluate the result according to the different metrics for the eigenvalues and principal components.

Table 1: Multiple Principal Components Prediction. We train a large Transformer $(L = 12, Embed - Dim = 256, M = 8)$ on synthetic dataset to predict top-4 principal components, and use cosine similarity as metric. Since the task is much harder, we train the model for $150k$ steps compared to $20k$ steps for other synthetic tasks in section [4.1.](#page-17-1) For MNIST, we train the model for 500k steps.

4.2 Clustering a Mixture of Gaussians

sect42 We present here the simulation results for the problem of Clustering Mixture of Gaussians. Our results are given by plots [6](#page-23-0) and [7.](#page-24-0) The rest of the section is organized similarly to [4.1.](#page-17-1)

Experimental Overview. We verify the theoretical results by exploring the relationship between three factors versus the clustering performance: distance between two clusters $\|\boldsymbol{\mu}_1 - \boldsymbol{\mu}_0\|_2$, data dimension d, and the number of training samples N. We use the same model architecture as in the previous section with layer $L = 3$, head $M = 2$, and embedding dimension 64. We train model with 3 different random seeds and report both the mean and standard deviation. The experiments in this section run on NVIDIA A100 80G GPUs. We train the model for 300 iterations on synthetic data, and train 3500 iterations on the real-world data using stochastic gradient descent with Pytorch package. Every point in the figure is evaluated on 512 testing data points.

Metrics. The metric that we evaluate the performance of our estimated cluster assignment \hat{z} is given

where S_k denotes the set of all k! permutations. For a special case, the loss function of two-class clustering is written out as equation [2.](#page-14-2) Additionally, we use two commonly used permutation-invariant metrics to evaluate the clustering problem: Adjusted Rand Index (ARI) and Normalized Mutual Information (NMI) [\[16,](#page-73-6) [20,](#page-74-4) [22,](#page-74-5) [23,](#page-74-6) [29\]](#page-75-6).

Preparation for the Synthetic Data. We generate our synthetic data as follows: For each input $\mathbf{X} \in \mathbb{R}^{d \times N}$, we sample equal counts of data coming from the two clusters. We set $N = 200$ in both synthetic and real-world data experiments. Each sample is generated according to isotropic Gaussian with covariances $\sigma^2 I$ where $\sigma^2 \sim Uniform[0.5, 5.0]$. To generate mean vectors μ_0 and μ_1 in \mathbb{R}^d with a fixed distance $\delta = \|\mu_1 - \mu_0\|_2$, a random center point $c \in \mathbb{R}^d$ is first sampled. Then, a random vector v is drawn from $N(0, 1)^d$ and normalized to a unit vector, $u = v/||v||$. The centroids are then given by $\mu_0 = c - \delta/2 \cdot u$ and $\boldsymbol{\mu}_1 = \boldsymbol{c} + \delta/2 \cdot \boldsymbol{u}$.

Preparation for the Real-World Data. For the real-world data evaluation, we use the Covertype [\[8\]](#page-72-7) dataset, which consists of 581,012 observations with $d = 54$ and 7 different classes. The task is to predict the forest cover type with cartographic variables. For the experiment involving varying $\|\boldsymbol{\mu}_1-\boldsymbol{\mu}_0\|_2$, we select 10 different combinations of two classes. For fixed $\|\mu_1 - \mu_0\|_2$, each training sample $\boldsymbol{X} \in \mathbb{R}^{d \times N}$ is formed by randomly sampling $N/2$ points from each of the selected classes.

4.3 Additional Simulations

This section provides additional details on the simulations from three different perspectives: (1) The comparison between Transformers versus the Power Methods in solving PCA problem; (2) The comparison between the ReLU Attention and Softmax Attention in the experiments; (3) The comparison between the Concatenated multi-head Attention and the Averaged multi-head Attention in the theoretical results of this work. This section hopes to give empirical evidence bridging the assumptions of our theoretical results and the Transformer networks used in practice.

The Power Method versus Transformers. We compare the predicted eigenvector of the Transformer and the Power Method in figure [8](#page-26-0) and table [2.](#page-70-0) We want to understand the sharpness of our construction of the Transformers in the approximation of the Power Method. When choosing the number of iterations τ of the Power Method the Transformer to compare with, we use $L = 2\tau + 4(k-1)+1$ as derived in theorem [2.1,](#page-11-0) but with k replaced by $k-1$ since we only need to remove principal components when we want to predict $k \geq 2$

principal components. In the left and middle subplots of figure [8](#page-26-0) and table [2,](#page-70-0) we observe a linear relationship between the number layers of Transformers and the number of iterations of the Power Method. This verifies our theoretical result. We evaluate this correspondence on the MNIST dataset, as shown in the right plot of figure [8.](#page-26-0) Our empirical evaluation justifies the tightness of our approximation.

Softmax versus ReLU Attention. We perform experiments comparing the performance of the ReLU Attention used in the theoretical results and the Softmax Attention that is commonly used in practice. We run two different experiments on PCA and Clustering respectively to show that the choice of the ReLU Attention in our theoretical construction is equivalent to the Softmax version on the empirical performance. The first experiment is in figure [9](#page-27-0) where we report the training loss of predicting top-1 principal component with different input dimensions d. The second experiment is in figure [10](#page-28-0) where we compare between the ReLU and Softmax Attentions on the Covertype dataset experiments with different $\|\boldsymbol{\mu}_1 - \boldsymbol{\mu}_0\|_2$.

Concatenated versus Averaged Multi-head Attentions. Similar to the previous paragraph, here we hope to compare the performance between the Concatenated multihead Attention and the Averaged multi-head Attention studied in the theoretical results of this work. We compare the Averaged Attention with the Concatenated Attention [\[30\]](#page-75-0) on a two-class clustering problem using the Covtype dataset, as shown in figure [11.](#page-28-1) We observe that the difference in the clustering performance with different $||\mu_1 - \mu_0||_2$ is very small regardless of the metrics used.

5 Discussions

This section discusses the limitations in this work and potential future working directions. Our limitations in the theoretical results can be summarized as follows: (1) From the theoretical perspective, our results guarantee the performance of ERM solutions whereas the true estimator is obtained through the stochastic gradient descent method; (2) The sharpness of our results might not be easily verifiable as the approximation of the Transformer part is subject to constraints from both the network structure and the algorithms that achieve the sharp rate. We believe that future working directions include: (1) understanding the Multi-clustering Problem on Transformers; (2) replacing the ReLU Attentions with Softmax Attentions and try to obtain similar results; (3) generalizing the results in this work to other unsupervised learning problems. 2. The Power Iteration.

Then we consider constructing a single attention layer that approximates the power iteration. This step involves two important operations: (1) Obtaining the vector given by $\boldsymbol{X}\boldsymbol{X}^{\top}\boldsymbol{v}$. (2) Approximation of the value of the inverse norm given by $1/\|\boldsymbol{X}\boldsymbol{X}^{\top}\boldsymbol{v}\|_2$. We show that one can use the multihead ReLU Transformer to achieve both goals simulatenously, whose parameters are given by

(\boldsymbol{Q}_{m}^{pow,2}\tilde{\boldsymbol{H}}^{pow,1})^{\top}=\begin{bmatrix}I_{d\times d} & \boldsymbol{0}\\ \boldsymbol{0} & \boldsymbol{0}\end{bmatrix}, \qquad \boldsymbol{K}_{m}^{pow,2}\tilde{\boldsymbol{H}}^{pow,1}=\begin{bmatrix}\boldsymbol{a}_{m}^{\top}\boldsymbol{X}\boldsymbol{X}^{\top}\tilde{\boldsymbol{p}}_{3,1} & \boldsymbol{0}\\ \vdots & & \\ \boldsymbol{a}_{m}^{\top}\boldsymbol{X}\boldsymbol{X}^{\top}\tilde{\boldsymbol{p}}_{3,1} & \boldsymbol{0}\\ \boldsymbol{0}_{(D-d)\times 1} & \boldsymbol{0}\end{bmatrix}.
$$

Then, given $V_m^{pow,2}$ we can show that under the condition given by lemma [B.2,](#page-54-0) we have

\bigg\|\sum_{m=1}^M \boldsymbol{V}_{m}^{pow,2}\tilde{\boldsymbol{H}}^{pow,1}\sigma\left((\boldsymbol{Q}_m^{pow,2}\tilde{\boldsymbol{H}}^{pow,1})^\top(\boldsymbol{K}_m^{pow,2}\tilde{\boldsymbol{H}}^{pow,1})\right)-\left[\frac{\boldsymbol{0}_{4d+1}}{\|\boldsymbol{X}\boldsymbol{X}^\top\tilde{\boldsymbol{p}}_{3,1}\|_2}-\boldsymbol{X}\boldsymbol{X}^\top\tilde{\boldsymbol{p}}_{3,1},\boldsymbol{0}\right]\bigg\|_{\infty}
$$

 $< \epsilon$,

Moreover, we can further achieve that

$$
\begin{aligned} \left\| \sum_{m=1}^M V^{pow,2j}_m \tilde{H}^{pow,1} \sigma \left((Q^{pow,2}_m \tilde{H}^{pow,1})^\top (K^{pow,2}_m \tilde{H}^{pow,1}) \right) - \left[\begin{matrix} 0_{4d+1} \\ \frac{XX^\top \tilde{p}_{3,1}}{\|XX^\top \tilde{p}_{3,1}\|_2} - XX^\top \tilde{p}_{3,1}, 0 \\ 0 \end{matrix} \right] \right\|_2 \\ &\quad \ <\epsilon \|XX^\top \tilde{p}_{3,1}\|_2. \end{aligned}
$$

Hence, using the fact that $\tilde{H}^{pow,2} = \tilde{H}^{pow,1} + \sum_{i=1}^{m} V^{pow,2}_m \tilde{H}^{pow,1} \sigma\left((\boldsymbol{Q}_m^{pow,2}\tilde{\boldsymbol{H}}^{pow,1})^\top(\boldsymbol{K}_m^{pow,2}\tilde{\boldsymbol{H}}^{pow,1})\right),$ we obtain that

Then we construct another attention layer, which performs similar calculations as that of pow, 1 but switch the rows of $\tilde{p}_{3,1}$ with that of $\frac{XX^{\top} \tilde{p}_{3,1}}{\|XX^{\top} \tilde{p}_{3,1}\|_2}$. Our construction for the third layer is given by

K_1^{pow,3} = K_2^{pow,3} = \begin{bmatrix} 0_{(4d+1)\times(4d+1)} & 0 & 0 \\ 0_{d\times(4d+1)} & I_d & 0 \\ 0_{d\times(4d+1)} & I_d & 0 \\ 0 & 0 & 0 \end{bmatrix}, \quad \tilde{p}_{4,j} = 0 \text{ for all } j \in [N].
$$

Given the above construction, we can show that

\begin{aligned} \boldsymbol{Q}_{2}^{pow,3}\tilde{\boldsymbol{H}}^{pow,2} &=-\boldsymbol{Q}_{1}^{pow,3}\tilde{\boldsymbol{H}}^{pow,2}=\left[\begin{aligned} &\boldsymbol{0}_{(3d+1)\times N} \\ &\boldsymbol{X}\boldsymbol{X}^{\top} &\boldsymbol{0} \\ &\boldsymbol{0} \end{aligned}\right], \quad \boldsymbol{K}_{2}^{pow,3}\tilde{\boldsymbol{H}}^{pow,2}=\boldsymbol{K}_{1}^{pow,3}\tilde{\boldsymbol{H}}^{pow,2},\\ \left\|\boldsymbol{K}_{2}^{pow,3}\tilde{\boldsymbol{H}}^{pow,2}-\left[\begin{aligned} &\boldsymbol{0}_{(3d+1)\times N} \\\frac{\boldsymbol{X}\boldsymbol{X}^{\top}\tilde{\boldsymbol{p}}_{3,1}}{\|\boldsymbol{X}\boldsymbol{X}^{\top}\tilde{\boldsymbol{p}}_{3,1}\|_{2}},\boldsymbol{0} \\ &\boldsymbol{0} \end{aligned}\right]\left\|\underset{2}{\leq\epsilon}\|\boldsymbol{X}\boldsymbol{X}^{\top}\tilde{\boldsymbol{p}}_{3,1}\|_{2}.\end{aligned}

\begin{aligned} \left\| \sum_{m=1}^2 \mathbf{V}_m^{pow,3} \tilde{\boldsymbol{H}}^{pow,2} \sigma \left((\boldsymbol{Q}_2^{pow,3} \tilde{\boldsymbol{H}}^{pow,2})^\top \boldsymbol{K}_2^{pow,3} \tilde{\boldsymbol{H}}^{pow,2} \right) - \begin{bmatrix} \boldsymbol{0}_{(3d+1)\times N} \\ \frac{(\boldsymbol{X} \boldsymbol{X}^\top)^2 \tilde{\boldsymbol{p}}_{3,1}}{\|\boldsymbol{X} \boldsymbol{X}^\top \tilde{\boldsymbol{p}}_{3,1}\|_2} - \frac{\boldsymbol{X} \boldsymbol{X}^\top \tilde{\boldsymbol{p}}_{3,1}}{\|\boldsymbol{X} \boldsymbol{X}^\top \tilde{\boldsymbol{p}}_{3,1}\|_2}, \boldsymbol{0} \end{bmatrix} \right\|_2 \\ \leq \epsilon \| \boldsymbol{X} \boldsymbol{X}^\top \|_2 \| \boldsymbol{X} \boldsymbol{X}^\top \tilde{\boldsymbol{p}}_{3,1} \|_2 \,. \end{aligned}

\text{Henceforth, one can further show that} \left\|\tilde{\boldsymbol{H}}^{pow,3}\!-\!\left\|\begin{matrix} \boldsymbol{X} \\ \boldsymbol{\tilde{y}} \\ \boldsymbol{\tilde{p}}_{2,1},\ldots,\boldsymbol{\tilde{p}}_{2,N} \\ \boldsymbol{\tilde{p}}_{3,1},\ldots,\boldsymbol{\tilde{p}}_{3,N} \\ \vdots \\ \frac{(\boldsymbol{X}\boldsymbol{X}^\top)^2\tilde{\boldsymbol{p}}_{3,1}}{\|\boldsymbol{X}\boldsymbol{X}^\top\tilde{\boldsymbol{p}}_{3,1}\|_2},\boldsymbol{0} \\ \boldsymbol{\tilde{p}}_{5,1},\ldots,\boldsymbol{\tilde{p}}_{5,N} \\ \vdots \\ \boldsymbol{\tilde{p}}_{\ell,1},\ldots,\boldsymbol{\tilde{p}}_{\ell,N} \end{matrix}\right\|_{2} \leq \epsilon \| \boldsymbol{X}\boldsymbol{X}^\top\|_2 \| \boldsymbol{X}\boldsymbol{X}^\top\tilde{\boldsymbol{p}}_{3,1}\|_2.

Consider we are doing in total of τ power iterations, we can set for all $\tau \in \mathbb{N}^*$,

Therefore, taking another layer of normalization, we can show that

\left\|\tilde{\boldsymbol{H}}^{pow,3}-\begin{bmatrix}{\boldsymbol{X}}\\ \tilde{{\boldsymbol{y}}}\\ \tilde{{\boldsymbol{X}}}{\boldsymbol{X}}^{\top},{\boldsymbol{0}}\\ \tilde{{\boldsymbol{p}}}_{2,1},\ldots,\tilde{{\boldsymbol{p}}}_{2,N} \\ \tilde{{\boldsymbol{p}}}_{3,1},\ldots,\tilde{{\boldsymbol{p}}}_{3,N} \\ \frac{({\boldsymbol{X}}{\boldsymbol{X}}^{\top})^2\tilde{{\boldsymbol{p}}}_{3,1}}{\|{\boldsymbol{X}}{\boldsymbol{X}}^{\top}\tilde{{\boldsymbol{p}}}_{3,1}\|_2^2},{\boldsymbol{0}} \\ \tilde{{\boldsymbol{p}}}_{5,1},\ldots,\tilde{{\boldsymbol{p}}}_{5,N} \\ \vdots \\ \tilde{{\boldsymbol{p}}}_{\ell,1},\ldots,\tilde{{\boldsymbol{p}}}_{\ell,N} \end{bmatrix}\right\|_2\leq 2\epsilon\|{\boldsymbol{X}}{\boldsymbol{X}}^{\top}\|_2.
$$

Then, using the sublinearity of errors, we can show that for $\tau \in \mathbb{N}$,

\begin{array}{c} \left\|\tilde{\bm{H}}^{pow,2\tau+2}-\left|\begin{matrix} \bm{X} \\ \tilde{\bm{y}} \\ \tilde{\bm{p}}_{2,1},\ldots,\tilde{\bm{p}}_{2,N} \\ \tilde{\bm{p}}_{3,1},\ldots,\tilde{\bm{p}}_{3,N} \\ \tilde{\bm{p}}_{3,1},\ldots,\tilde{\bm{p}}_{3,N} \\ \tilde{\bm{p}}_{3,1},\bm{0} \\ \tilde{\bm{p}}_{5,1},\ldots,\tilde{\bm{p}}_{5,N} \\ \vdots \\ \tilde{\bm{p}}_{\ell,1},\ldots,\tilde{\bm{p}}_{\ell,N} \end{matrix}\right\|_{\infty} \leq \tau\epsilon\|\bm{X}\bm{X}^{\top}\|_{2}, \quad \tilde{\bm{p}}_{3,1}^{(\tau)}=\frac{\bm{X}\bm{X}^{\top}\tilde{\bm{p}}_{3,1}^{(\tau-1)}}{\left\|\bm{X}\bm{X}^{\top}\tilde{\bm{p}}_{3,1}^{(\tau-1)}\right\|_{2}}, \quad \tilde{\bm{p}}_{3,1}^{(0)}=\tilde{\bm{p}}_{3,1}. \end{array}

If we denote v_i as the eigenvector corresponds to the i th largest eigenvalue of $\boldsymbol{X}\boldsymbol{X}^\top$. Let the eigenvalues of $\boldsymbol{X}\boldsymbol{X}^{\top}$ be denoted by $\lambda_1 > \lambda_2 > \cdots > \lambda_n$. Given $|\tilde{\boldsymbol{p}}_{3,1}^{\top} \boldsymbol{v}_1| > \delta$ and | √ $\overline{\lambda_1}$ $-$ √ $\overline{\lambda_2}$ = $\Omega(1)$. Theorem 3.11 in [\[9\]](#page-73-0) page 53 shows that given $k = \frac{\log(1/\epsilon_0 \delta)}{2\epsilon_0}$ $rac{1/\epsilon_0 \delta}{2\epsilon_0}$ and $\|\tilde{\mathbf{p}}_{3,1}^{(\tau)}\|_2 = \|\mathbf{v}_1\|_2 = 1$, one immediately obtains that

And we also consider the approximation of the maximum eigenvalue. Note that using $||v_1||_2=1$, we have

3. The Removal of Principle Eigenvectors.

After τ iterates on the power method, we need to remove the principle term from the matrix $\boldsymbol{X}\boldsymbol{X}^{\top}$, achieved through two important steps: (1) The computation of the estimated eigenvalue $||XX^{\top}\tilde{p}_{3,1}||_2$. (2) The construction of the low rank update $\tilde{p}_{3,1}\tilde{p}_{3,1}^{\top}$. For step (1), we consider the following construction:

$$
\boldsymbol{V}_{1}^{rpe,1} = -\boldsymbol{V}_{2}^{rpe,1} = \begin{bmatrix} \boldsymbol{0}_{(3d+1)\times(2d+1)} & \boldsymbol{0} & \boldsymbol{0} \\ \boldsymbol{0}_{d\times(2d+1)} & I_d & \boldsymbol{0} \\ \boldsymbol{0} & \boldsymbol{0} & \boldsymbol{0} \end{bmatrix}, \quad \boldsymbol{Q}_{1}^{rpe,1} = -\boldsymbol{Q}_{2}^{rpe,1} = \begin{bmatrix} \boldsymbol{0}_{(d+1)\times(d+1)} & \boldsymbol{0} & \boldsymbol{0} \\ \boldsymbol{0}_{d\times(d+1)} & I_d & \boldsymbol{0} \\ \boldsymbol{0} & \boldsymbol{0} & \boldsymbol{0} \end{bmatrix},
$$

$$
\boldsymbol{K}_{1}^{rpe,1} = \boldsymbol{K}_{2}^{rpe,1} = \begin{bmatrix} \boldsymbol{0}_{(4d+1)\times(4d+1)} & \boldsymbol{0} & \boldsymbol{0} \\ \boldsymbol{0}_{d\times(4d+1)} & I_d & \boldsymbol{0} \\ \boldsymbol{0}_{d\times(4d+1)} & I_d & \boldsymbol{0} \\ \boldsymbol{0} & \boldsymbol{0} & \boldsymbol{0} \end{bmatrix}.
$$

Note that the above construction is similar to the first layer of the power method. Under this construction, we can show that

\tilde{\boldsymbol{H}}^{rpe,1} = \tilde{\boldsymbol{H}}^{pow,2\tau+2} + \sum_{m \in \{1,2\}} V^{rpe,1}_m \sigma((\boldsymbol{Q}_m^{rpe,1}\tilde{\boldsymbol{H}}^{pow,2\tau+2})^\top(\boldsymbol{K}_m^{rpe,1}\tilde{\boldsymbol{H}}^{pow,2\tau+2})), \\\\ \tilde{y} \\\\ \tilde{y} \\\\ \tilde{y} \\ \tilde{p}_{2,1},\ldots,\tilde{p}_{2,N} \\ \tilde{p}_{3,1},\ldots,\tilde{p}_{3,N} \\ \tilde{p}_{3,1},0 \\ \tilde{p}_{5,1},\ldots,\tilde{p}_{6,N} \\ \vdots \\ \tilde{p}_{\ell,1},\ldots,\tilde{p}_{\ell,N} \\\\ \vdots \\ \tilde{p}_{\ell,1},\ldots,\tilde{p}_{\ell,N} \\\\ \vdots \\ \tilde{p}_{\ell,1},\ldots,\tilde{p}_{\ell,N} \\\\ \vdots \\ \tilde{p}_{r^{n+1}} \end{aligned}
$$

Then, we construct the next layer, using the notations in lemma [B.2,](#page-54-0) for $M \geq \|\boldsymbol{X}\boldsymbol{X}^\top\|_2^d$ $C(d)$ ϵ^2 for all $m \in [M]$ we have

\boldsymbol{V}_{m}^{rpe,2} = \begin{bmatrix} \boldsymbol{0}_{d \times (4d+1)} & d_{m} \boldsymbol{I}_{d} & \boldsymbol{0} \\ & \boldsymbol{0} & \boldsymbol{0} & \boldsymbol{0} \end{bmatrix}, \qquad \boldsymbol{Q}_{m}^{rpe,2} = \begin{bmatrix} \boldsymbol{0}_{d \times (2d+1)} & \boldsymbol{I}_{d} & \boldsymbol{0} \\ & \boldsymbol{0} & \boldsymbol{0} & \boldsymbol{0} \end{bmatrix},
$$

$$
\boldsymbol{K}_{m}^{rpe,2} = \begin{bmatrix} \boldsymbol{0}_{1 \times (5d+1)} & \boldsymbol{b}_{m}^{\top} & \boldsymbol{0} \\ \vdots & \vdots & \vdots \\ \boldsymbol{0}_{1 \times (5d+1)} & \boldsymbol{b}_{m}^{\top} & \boldsymbol{0} \\ \boldsymbol{0}_{(D-d) \times (5d+1)} & \boldsymbol{0} & \boldsymbol{0} \end{bmatrix}.
$$

Given the above construction, we subsequently show that

(\boldsymbol{Q}_{m}^{rpe,2}\tilde{\boldsymbol{H}}^{rpe,1})^{\top}=\begin{bmatrix} I_{d\times d} & \boldsymbol{0}\\ \boldsymbol{0} & \boldsymbol{0} \end{bmatrix}, \qquad \boldsymbol{K}_{m}^{rpe,2}\tilde{\boldsymbol{H}}^{rpe,1}=\begin{bmatrix} \boldsymbol{b}_{m}^{\top}\boldsymbol{X}\boldsymbol{X}^{\top}\tilde{\boldsymbol{p}}_{3,1}^{(\tau)} & \boldsymbol{0}\\ \vdots & \vdots \\ \boldsymbol{b}_{m}^{\top}\boldsymbol{X}\boldsymbol{X}^{\top}\tilde{\boldsymbol{p}}_{3,1}^{(\tau)} & \boldsymbol{0} \\ \boldsymbol{0}_{(D-d)\times 1} & \boldsymbol{0} \end{bmatrix}.

Hence, given the construction of $V_m^{rpe,2}$, we can show that $\tilde{H}^{rpe,2}$ satisfies

\begin{aligned} \tilde{\boldsymbol{H}}^{rpe,2} &= \tilde{\boldsymbol{H}}^{rpe,1} + \sum_{m \in [M]} V^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1} \times \sigma \left((\boldsymbol{K}^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1})^\top (\boldsymbol{Q}^{rpe}_m \tilde{\boldsymbol{H}}^{rpe,1}) \right) \\ &= \boldsymbol{H}^{rpe,1} + \sum_{m \in [M]} V^{rpe,2}_m \boldsymbol{H}^{rpe,1} \times \sigma \left((\boldsymbol{K}^{rpe,2}_m \boldsymbol{H}^{rpe,1})^\top (\boldsymbol{Q}^{rpe,2}_m \boldsymbol{H}^{rpe,1}) \right) \\ &=: \widehat{\boldsymbol{H}}^{rpe,1} \\ &+ \left(\tilde{\boldsymbol{H}}^{rpe,1} - \boldsymbol{H}^{rpe,1} \right) + \sum_{m \in [M]} V^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1} \times \sigma \left((\boldsymbol{K}^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1})^\top \boldsymbol{Q}^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1} \right) \\ &- \sum_{m \in [M]} V^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1} \times \sigma \left((\boldsymbol{K}^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1})^\top \boldsymbol{Q}^{rpe,2}_m \tilde{\boldsymbol{H}}^{rpe,1} \right). \end{aligned}

We note that by lemma [B.2](#page-54-0) we can show that

\mathbb{P}(A_2) = \mathbb{P}\left(|\boldsymbol{v}^\top \boldsymbol{y}| \leq \sqrt{\epsilon}\right) = erf\left(\frac{\sqrt{\epsilon}}{\sqrt{2}}\right) = \frac{2}{\sqrt{\pi}}\left(\sqrt{\epsilon} - \frac{(\sqrt{\epsilon})^3}{3} + \frac{(\sqrt{\epsilon})^5}{10} - \frac{(\sqrt{\epsilon})^7}{42}\right) \leq \frac{\sqrt{\epsilon}}{\sqrt{\pi}}.
$$

Then we obtain that

B.6 Proof of Thereom [3.1](#page-15-0)

Our algorithm goes by first splitting the data into two parts $\{X_i\}_{i\in[N_1]}$ and $\{X_i\}_{i\in\{N_1+1,\ldots,N\}}$. And using the first part we construct an estimate for the principle direction of variance. Then we cluster the rest of the samples through projecting them to the principle direction.

We apply the matrix perturbation theory to show that the empirical covariance matrix is close to the expected one. And the principle component corresponds to the direction with the large variance. We note that the covariance matrix of the mixture model is given

\mathbb{E}\left[(\boldsymbol{X}_1 - \mathbb{E}[\boldsymbol{X}_1])(\boldsymbol{X}_1 - \mathbb{E}[\boldsymbol{X}_1])^\top \right] = \mathbb{E}[\boldsymbol{X}_1 \boldsymbol{X}_1^\top] - \mathbb{E}[\boldsymbol{X}_1] \mathbb{E}[\boldsymbol{X}_1]^\top \n= \frac{1}{2} \mathbb{E}[\boldsymbol{X}_1 \boldsymbol{X}_1^\top | z_1 = 1] + \frac{1}{2} \mathbb{E}[\boldsymbol{X}_1 \boldsymbol{X}_1^\top | z_1 = 0] - \frac{(\boldsymbol{\mu}_1 + \boldsymbol{\mu}_2)(\boldsymbol{\mu}_1 + \boldsymbol{\mu}_2)^\top}{4} \n= I_d + \frac{1}{2} (\boldsymbol{\mu}_1 \boldsymbol{\mu}_1^\top + \boldsymbol{\mu}_2 \boldsymbol{\mu}_2^\top) - \frac{(\boldsymbol{\mu}_1 + \boldsymbol{\mu}_2)(\boldsymbol{\mu}_1 + \boldsymbol{\mu}_2)^\top}{4} \n= I_d + \frac{1}{4} (\boldsymbol{\mu}_1 \boldsymbol{\mu}_1^\top + \boldsymbol{\mu}_2 \boldsymbol{\mu}_2^\top) - \frac{1}{4} \boldsymbol{\mu}_1 \boldsymbol{\mu}_2^\top - \frac{1}{4} \boldsymbol{\mu}_2 \boldsymbol{\mu}_1^\top \n= I_d + \frac{1}{4} (\boldsymbol{\mu}_1 - \boldsymbol{\mu}_2)(\boldsymbol{\mu}_1 - \boldsymbol{\mu}_2)^\top.

Therefore, it is noted that the top-1 principle eigenvector is given by $\frac{\mu_1 - \mu_2}{\|\mu_1 - \mu_2\|_2}$, corresponding to the eigenvalue of $1 + \frac{1}{4} || \mu_1 - \mu_2 ||_2^2$. We further consider the empirical covariance matrix, given by

Hence, we can additionally show that $\mathbf{X}_1 - \mathbb{E}[\mathbf{X}_1]$ is sub-Gaussian with $\sigma^2 = 1 + \frac{1}{4} ||\boldsymbol{\mu}_1 - \boldsymbol{\mu}_0||_2^2$. Then, defining $\widehat{\Sigma} = (X - \mathbb{E}[\boldsymbol{X}]) (X - \mathbb{E}[\boldsymbol{X}])^{\top}$ and $\Sigma = \mathbb{E}[\boldsymbol{X}_1 \boldsymbol{X}_1^{\top}] - \mathbb{E}[\boldsymbol{X}_1] \mathbb{E}[\boldsymbol{X}_1]^{\top}$, we can

show that

Denote $\tilde{\Sigma} := \frac{1}{N_1} \sum_{i=1}^{N_1} (\boldsymbol{X}_i - \bar{\boldsymbol{X}}) (\boldsymbol{X}_i - \bar{\boldsymbol{X}})$, we consider the difference between $\tilde{\Sigma}$ and $\widehat{\Sigma}$, it is noted that

&= \left\|2\bar{\boldsymbol{X}} \mathbb{E}[\boldsymbol{X}]^{\top} - \bar{\boldsymbol{X}} \bar{\boldsymbol{X}}^{\top} - \mathbb{E}[\boldsymbol{X}] \mathbb{E}[\boldsymbol{X}]^{\top}\right\|_2 = \left\|(\bar{\boldsymbol{X}} - \mathbb{E}[\boldsymbol{X}])(\bar{\boldsymbol{X}} - \mathbb{E}[\boldsymbol{X}])^{\top}\right\|_2 \\
&= \|\bar{\boldsymbol{X}} - \mathbb{E}[\boldsymbol{X}]\|_2^2.\n\end{aligned}
$$

To analyze the difference between $\bar{\bm{X}}$ and $\mathbb{E}[\bm{X}]$ we introduce the projection $P := \frac{(\mu_0 - \mu_1)(\mu_0 - \mu_1)^T}{\|\mu_0 - \mu_1\|^2}$ $\|\boldsymbol{\mu}_0{-}\boldsymbol{\mu}_1\|_2^2$ and $P^{\perp} = I - P$. We further notice that $P(\bar{X} - \mathbb{E}[X]) = \frac{1}{N_1} \sum_{i=1}^{N_1} P X_i - \mathbb{E}[P X_i]$ where PX_i s are i.i.d. univariate sub-Gaussian random variables with $\sigma^2 = 1 + \frac{1}{4} || \mu_1 - \mu_0 ||_2^2$. We therefore utilize Hoeffding's inequality to obtain that for all $t > 0$,

And, it is noted that the distribution of $P^{\perp}(\bar{\mathbf{X}} - \mathbb{E}[\mathbf{X}])$ is $N_1\left(0, \frac{1}{N}\right)$ $\frac{1}{N_1}I_{d-1}$. Utilizing the $\chi^2(d-1)$ tail bound given by [\[19\]](#page-74-0),

Let $a = \frac{1 + \frac{1}{4} ||\mu_1 - \mu_0||_2^2}{N_1}$ and $b = \sqrt{\frac{d-1}{N_1}}$ $\frac{d-1}{N_1}$. Then, with probability at least $1 - C\delta$, we have $\begin{aligned} \|\bar{\boldsymbol{X}}-\mathbb{E}[\boldsymbol{X}]\|_2^2 &= \|P(\bar{\boldsymbol{X}}-\mathbb{E}[\boldsymbol{X}])\|_2^2 {+} \|P^\perp(\bar{\boldsymbol{X}}-\mathbb{E}[\boldsymbol{X}])\|_2^2 \end{aligned}$ ≤ $1+\frac{1}{4}\|\bm{\mu}_1-\bm{\mu}_0\|_2^2$ N_1 $\log(1/\delta) + \frac{d-1}{\gamma}$ N_1 $^{+}$ $\log(1/\delta)$ N_1 ∨ $\sqrt{(d-1)\log(1/\delta)}$ N_1 . $diff_{[11]}$

Then, collecting equation [9,](#page-57-0) equation [10,](#page-57-1) and equation [11](#page-58-0) we can show that with probability at least $1 - C\delta$,

Denote the principle eigenvector of Σ as v_1 and the principle eigenvector of $\widehat{\Sigma}$ as \widehat{v}_1 , then we make use the handy version of the Davis-Kahan theorem provided by [\[36\]](#page-76-0) to obtain that with probability at least $1 - \delta$, we have

For the term T_2 , we can show that $(\bar{X}-\mathbb{E}[X])^{\top}v_1$ is a $\frac{1}{4}||\mu_0-\mu_1||_2^2+1$ sub-Gaussian random variable. By Hoeffding's inequality, we can show that

C.1 Model Architecture Detail for Seciton [4.1.](#page-17-1)

We use slightly different architectures to predict eigenvalues and principal components. For eigenvalues prediction, we flatten the transformer output $TF_{\theta}(X) \in \mathbb{R}^{N \times \text{embd.dim}}$ and

use a linear layer $W_{\lambda} \in \mathbb{R}^{(N \cdot \text{embd.dim}) \times k}$ to readout the top k eigenvalues. As for principal components, we use one more linear layer $W_v \in \mathbb{R}^{(N \cdot \text{embd.dim}) \times (k \cdot d)}$ to readout k eigenvectors concatenated in a 1-dimension vector.

C.2 Additional Experimental Results

sec:add_exp We provide two additional results in this section. Table [2](#page-70-0) is the detailed cosine similarity of individual principal components prediction of the right subplot in Figure [3.](#page-19-0) Figure [12](#page-71-0) illustrates the training loss from the experiments discussed in Section [4.1.](#page-17-1) These experiments explore the effects of (1) varying data dimension, (2) adjusting the number of layers for predicting eigenvalues and principal components, and (3) varying the number of principal components models are trained to predict.

Figure 12: Convergence Results on Eigenvalue, Eigenvector Prediction with Dif**ferent Parameters.** (1) Top left: Loss curve on eigenvalue prediction with different size of d (2) Top middle: Loss curve on eigenvalue prediction with different number of layers (3) Top right: Loss curve on eigenvector prediction with different size of d (4) Bottom left: Top right: Loss curve on eigenvector prediction with different number of layers (5) Bottom left: Loss curve on eigenvector prediction with different number of k_{train} For (1), we observe that smaller d is easiser for transformers as they present lower loss. For (2) , we see that with more layers, transformers are also capable of predicting eigenvalues more accurately. For (3) , transformers also predict eigenvectors better when d is small. For (4) , similar to (2), transformers with more layers shows improved performance. For (5), we want to highlight that the loss value is mainly affected by the fact that predicting 3rd or 4th eigenvectors are significantly harder, which contributes to higher loss value.
