GEOMETRIC PROPERTIES FOR A CERTAIN SUBCLASS OF NORMALIZED HARMONIC MAPPINGS

ABSTRACT. Let H be the class of harmonic functions $f = h + \overline{g}$ in the unit disk $\mathbb{D} := \{z \in \mathbb{C} : |z| < 1\}$, where h and g are analytic in \mathbb{D} with the normalization $h(0) = g(0) = h'(0) - 1 = 0$. Let $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ denote the subclass of H in D satisfying $\text{Re}\left((1-\alpha)h'(z)+\alpha zh''(z)\right) > -M + |(1-\alpha)g'(z)+\alpha zg''(z)|$ with $g'(0) = 0, M > 0$ and $\alpha \in (0, 1]$. In this paper, we investigate some fundamental properties of functions belonging to the class $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$, including coefficient bounds, growth estimates, convexity, starlikeness, convex combinations, and convolution.

1. introduction and preliminaries

The application of harmonic mappings has become a valuable tool in the study of fluid flow problems (see [\[1\]](#page-14-0)). Moreover, univalent harmonic functions that are characterized by geometric properties such as convexity, starlikeness, and close-to-convexity emerge naturally in the context of planar fluid dynamics problems. For instance, in [\[1,](#page-14-0) Theorem 4.5], Aleman and Constantin studied a fluid flow problem on a convex domain that exhibited an intriguing geometric property.

Let $f = u + iv$ be a complex-valued function of $z = x + iy$ in a simply connected domain Ω . If f satisfies the Laplace equation $\Delta f = 4f_{z\overline{z}} = 0$ in Ω , then f is said to be harmonic in Ω . Note that every harmonic mapping f has the canonical representation $f = h + \overline{g}$, where h and g are analytic in Ω , known respectively as the analytic and coanalytic parts of f, and $g(z)$ denotes the complex conjugate of $g(z)$. This representation is unique up to an additive constant (see [\[8\]](#page-14-1)). The inverse function theorem and a result of Lewy [\[12\]](#page-14-2) shows that a harmonic function f is locally univalent in Ω if, and only if, the Jacobian of f, defined by $J_f(z) := |h'(z)|^2 - |g'(z)|^2$ is non-zero in Ω . A harmonic mapping f is locally univalent and sense-preserving in Ω if, and only if, $J_f(z) > 0$ in Ω or equivalently if $h' \neq 0$ in Ω and the dilatation $\omega_f := \omega = g'/h'$ of f has the property that $|\omega_f| < 1$ in Ω (see [\[12\]](#page-14-2)). Let H denote the class of all complex-valued harmonic functions $f = h + \overline{g}$ defined in D, where h and g are analytic in D with the normalization $h(0) = h'(0) - 1 = 0$ and $g(0) = 0$. If the co-analytic part $g(z) \equiv 0$ in \mathbb{D} , then the class H reduces to the class A of analytic functions in $\mathbb D$ with $f(0) = f'(0) - 1 = 0$. Let $\mathcal{S}_{\mathcal{H}}$ denote the subclass of $\mathcal H$ that are sense-preserving and univalent in $\mathbb D$ and further let $S^0_{\mathcal{H}} = \{f = h + \overline{g} \in \mathcal{S}_{\mathcal{H}} : g'(0) = 0\}$. Thus, every $f = h + \overline{g} \in \mathcal{S}_{\mathcal{H}}^0$ has the following form

f(z) = h(z) + \overline{g(z)} = z + \sum_{n=2}^{\infty} a_n z^n + \overline{\sum_{n=2}^{\infty} b_n z^n}.

If the co-analytic parts $g(z) \equiv 0$ in \mathbb{D} , then both the classes $\mathcal{S}_{\mathcal{H}}$ and $\mathcal{S}_{\mathcal{H}}^{0}$ reduces to the class S of univalent and analytic functions in $\mathbb D$ with $f(0) = 0$ and $f'(0) = 1$. Both $\mathcal S_H$ and $S_{\mathcal{H}}^0$ are natural harmonic generalizations of S, but only $S_{\mathcal{H}}^0$ is known to be compact although both $\mathcal{S}_{\mathcal{H}}$ and $\mathcal{S}_{\mathcal{H}}^{0}$ are normal. In 1984, Clunie and Sheil-Small [\[6\]](#page-14-3) undertook a comprehensive study of the class $S_{\mathcal{H}}$ and its geometric subclasses. This study has subsequently garnered extensive attention from researchers (see [\[3,](#page-14-4) [11,](#page-14-5) [13,](#page-14-6) [18\]](#page-14-7)).

A domain Ω is called starlike with respect to a point $z_0 \in \Omega$ if the line segment joining z_0 to any point in Ω lies in Ω , *i.e.*, $(1-t)z_0 + tz \in \Omega$ for all $t \in [0,1]$ and for all $z \in \Omega$. In particular, if $z_0 = 0$, then Ω is simply called starlike. A complex-valued harmonic mapping $f \in \mathcal{H}$ is said to be starlike if $f(\mathbb{D})$ is starlike. Let $\mathcal{S}_{\mathcal{H}}^*$ denote the class of harmonic starlike functions in $\mathbb D$. A domain Ω is called convex if it is starlike with respect to any point in Ω . In other words, convexity implies starlikeness, but the converse is not necessarily true. A domain can be starlike without being convex. A function $f \in \mathcal{H}$ is said to be convex if $f(\mathbb{D})$ is convex. Let $\mathcal{K}_{\mathcal{H}}$ denote the class of harmonic convex mappings in D. Starlikeness is a hereditary property for conformal mappings. Thus, if f is analytic and univalent in $\mathbb D$ with $f(0) = 0$ and if f maps $\mathbb D$ onto a domain that is starlike with respect to the origin, then the image of every subdisk $|z| < r < 1$ is also starlike with respect to the origin. This means that every point of the range can be connected to the origin by a radial line that lies entirely in the region. This hereditary property does not extend to harmonic mappings, which is the subject of discussion in [\[5\]](#page-14-8). The following definitions are essential for a comprehensive understanding of this paper.

 \sum **Definition 1.** [\[7,](#page-14-9) [16\]](#page-14-10) Let ψ_1 and ψ_2 be two analytic functions in $\mathbb D$ given by $\psi_1(z) = \sum_{n=0}^{\infty} a_n z^n$ and $\psi_2(z) = \sum_{n=0}^{\infty} b_n z^n$. The convolution (or, Hadamard product) is de*fined by*

(\psi_1 * \psi_2)(z) = \sum_{n=0}^{\infty} a_n b_n z^n \text{ for } z \in \mathbb{D}.
$$

Definition 2. [\[10\]](#page-14-11) For harmonic functions $f_1 = h_1 + \overline{g_1}$ and $f_2 = h_2 + \overline{g_2}$ in H, the *convolution is defined as*

$$
f_1 * f_2 = h_1 * h_2 + \overline{g_1 * g_2}.
$$

Definition 3. [\[16\]](#page-14-10) A sequence $\{a_n\}$ of non-negative numbers is said to be a convex *null sequence if* $a_n \to 0$ *as* $n \to \infty$ *and*

$$
a_0 - a_1 \ge a_1 - a_2 \ge \cdots \ge a_{n-1} - a_n \ge \cdots \ge 0.
$$

In 2020, Ghosh and Allu [\[9\]](#page-14-12) considered the following subclass of $\mathcal H$ for $M > 0$ as follows:

$$
\mathcal{P}^0_{\mathcal{H}}(M) = \{ f = h + \overline{g} \in \mathcal{H} : \text{Re}\left(zh''(z)\right) > -M + |zg''(z)| \text{ with } g'(0) = 0 \text{ for } z \in \mathbb{D} \}
$$

and established the following results regarding the sharp coefficient bounds and growth results for functions in $\mathcal{P}^0_{\mathcal{H}}(M)$.

Theorem A. [\[9\]](#page-14-12) Let $f = h + \overline{g} \in \mathcal{P}_{\mathcal{H}}^0(M)$ for $M > 0$ be of the form [\(1.1\)](#page-0-0). Then, for $n \geq$ $2, |b_n| \leq 2M/(n(n-1))$. The result is sharp for the function $f(z) = \frac{z - M\overline{z}^n}{n(n-1)}$.

Theorem B. [\[9\]](#page-14-12) Let $f = h + \overline{g} \in \mathcal{P}_{\mathcal{H}}^{0}(M)$ for $M > 0$ be of the form [\(1.1\)](#page-0-0). Then, *for* $n \geq 2$, *(i)* $|a_n| + |b_n| \leq \frac{2M}{n(n-1)}$; *(ii)* $||a_n| - |b_n|| \leq \frac{2M}{n(n-1)}$; *(iii)* $|a_n| \leq \frac{2M}{n(n-1)}$. *The results are sharp for the function* f given by $f'(z) = 1 - 2M \ln(1 - z)$.

Theorem C. [\[9\]](#page-14-12) Let $f = h + \overline{g} \in \mathcal{P}_{\mathcal{H}}^0(M)$ for $M > 0$ be of the form [\(1.1\)](#page-0-0). Then

$$
|z| - 2M \sum_{n=2}^{\infty} \frac{|z|^n}{n(n-1)} \le |f(z)| \le |z| + 2M \sum_{n=2}^{\infty} \frac{|z|^n}{n(n-1)}.
$$

The right-hand inequality is sharp for the function f *given by* $f'(z) = 1-2M \ln(1-z)$ *.*

Motivated by the class $\mathcal{P}^0_{\mathcal{H}}(M)$, in this paper, we consider the following subclass of H for $M > 0$ and $\alpha \in (0, 1]$ as follows:

$$
\mathcal{P}_{\mathcal{H}}^0(\alpha, M) = \{ f = h + \overline{g} \in \mathcal{H} : \text{Re}\left((1 - \alpha)h'(z) + \alpha zh''(z) \right) > -M + |(1 - \alpha)g'(z) + \alpha zg''(z)|
$$

with $g'(0) = 0$ for $z \in \mathbb{D} \}.$

The organization of this paper is: In section 2, we establish the sharp coefficients bounds, growth results, starlikeness and convexity properties for functions in $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. In section 3, we obtain the convolution and convex combination properties of functions in $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$.

2. The coefficient bounds, growth estimate, starlikeness and convexity

Let us consider the class $\mathcal{P}(\alpha, M)$ defined by

 $\mathcal{P}(\alpha, M) := \{ \phi \in \mathcal{A} : \text{Re}\left((1-\alpha)\phi'(z) + \alpha z \phi''(z) \right) > -M \text{ for } M > 0, \alpha \in (0, 1] \text{ and } z \in \mathbb{D} \}.$ The following result provides a correlation between the functions in $\mathcal{P}(\alpha, M)$ and $\mathcal{P}^0_{\mathcal{H}}(\alpha, M).$

Theorem 2.1. *The harmonic mapping* $f = h + \overline{g}$ *belongs to* $\mathcal{P}_{\mathcal{H}}^0(\alpha, M)$ *if, and only if, the function* $F_{\varepsilon} = h + \varepsilon g \in \mathcal{P}(\alpha, M)$ *for each* ε ($|\varepsilon| = 1$).

Proof. Suppose that $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. Therefore

$$
\operatorname{Re}\left((1-\alpha)h'(z) + \alpha zh''(z)\right) > -M + \left|(1-\alpha)g'(z) + \alpha zg''(z)\right| \text{ for } z \in \mathbb{D}.\tag{2.1}
$$

Fix $|\varepsilon| = 1$. Since $F_{\varepsilon} = h + \varepsilon g$, we deduce by using [\(2.1\)](#page-2-0) that

$$
\begin{array}{rcl}\n\text{Re}\left((1-\alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z)\right) & = & \text{Re}\left(\left((1-\alpha)h'(z) + \alpha z h''(z)\right) \\
& & + \varepsilon \left((1-\alpha)g'(z) + \alpha z g''(z)\right)\right) \\
& \geq & \text{Re}\left((1-\alpha)h'(z) + \alpha z h''(z)\right) \\
& & - |(1-\alpha)g'(z) + \alpha z g''(z)| \\
& & > -M \quad \text{for} \quad z \in \mathbb{D}.\n\end{array}
$$

Therefore, $F_{\varepsilon} = h + \varepsilon g \in \mathcal{P}(\alpha, M)$ for each ε with $|\varepsilon| = 1$. Conversely, if $F_{\varepsilon} \in \mathcal{P}(\alpha, M)$, then for $z \in \mathbb{D}$, we have

$$
\operatorname{Re}\left((1-\alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z)\right) > -M,
$$
\n
$$
i.e., \operatorname{Re}\left(\left((1-\alpha)h'(z) + \alpha z h''(z)\right) + \varepsilon \left((1-\alpha)g'(z) + \alpha z g''(z)\right)\right) > -M,
$$
\n
$$
i.e., \operatorname{Re}\left((1-\alpha)h'(z) + \alpha z h''(z)\right) > -M + \operatorname{Re}\left(-\varepsilon \left[(1-\alpha)g'(z) + \alpha z g''(z)\right]\right).
$$

Since ε ($|\varepsilon| = 1$) is arbitrary, for an appropriate choice of ε , we have

Re
$$
((1 - \alpha)h'(z) + \alpha zh''(z)) > -M + |(1 - \alpha)g'(z) + \alpha zg''(z)|
$$
 for $z \in \mathbb{D}$,
which shows that $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. This completes the proof.

The following two theorems gives sharp coefficient bounds for functions in $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$.

Theorem 2.2. Let $f = h + \overline{g} \in \mathcal{P}_{\mathcal{H}}^0(\alpha, M)$ be of the form [\(1.1\)](#page-0-0) for $M > 0$, $\alpha \in (0, 1]$ *with* $M - \alpha + 1 > 0$ *. For* $n \geq 2$ *, we have*

$$
|b_n| \le \frac{M - \alpha + 1}{n + \alpha n(n-2)}.
$$

The result is sharp for the function f *given by* $f(z) = z + \frac{M-\alpha+1}{n+\alpha n(n-2)}\overline{z^n}$.

Proof. Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. Therefore,

$$
\left| (1 - \alpha)g'(z) + \alpha z g''(z) \right| < M + \text{Re} \left((1 - \alpha)h'(z) + \alpha z h''(z) \right) \text{ for } z \in \mathbb{D}. \tag{2.2}
$$

Since $(1 - \alpha)g'(z) + \alpha zg''(z) = \sum_{n=2}^{\infty} (n + \alpha n(n-2)) b_n z^{n-1}$ is analytic in \mathbb{D} , in view of the Cauchy's integral formula for derivatives, we have

$$
(n + \alpha n(n-2)) b_n = \frac{1}{2\pi i} \int_{|z|=r} \frac{(1-\alpha)g'(z) + \alpha z g''(z)}{z^n} dz.
$$

Therefore,

$$
(n + \alpha n(n-2)) |b_n| = \left| \frac{1}{2\pi i} \int_0^{2\pi} \frac{(1-\alpha)g'(re^{i\theta}) + \alpha re^{i\theta}g''(re^{i\theta})}{r^n e^{i n \theta}} ire^{i\theta} d\theta \right|
$$

$$
\leq \frac{1}{2\pi} \int_0^{2\pi} \frac{|(1-\alpha)g'(re^{i\theta}) + \alpha re^{i\theta}g''(re^{i\theta})|}{r^{n-1}} d\theta.
$$

From (2.2) , we have

$$
(n + \alpha n(n-2)) r^{n-1} |b_n| \leq \frac{1}{2\pi} \int_0^{2\pi} \left(M + \text{Re} \left((1 - \alpha) h'(re^{i\theta}) + \alpha r e^{i\theta} h''(re^{i\theta}) \right) \right) d\theta
$$

$$
= M + \frac{1}{2\pi} \int_0^{2\pi} \text{Re} \left((1 - \alpha) h'(re^{i\theta}) \right) d\theta
$$

$$
+ \frac{1}{2\pi} \int_0^{2\pi} \text{Re} \left(\alpha r e^{i\theta} h''(re^{i\theta}) \right) d\theta
$$

$$
= M + \frac{1}{2\pi} \int_0^{2\pi} \frac{(1 - \alpha) h'(re^{i\theta}) + (1 - \alpha) \overline{h'(re^{i\theta})}}{2} d\theta
$$

$$
+ \frac{1}{2\pi} \int_0^{2\pi} \frac{\alpha r e^{i\theta} h''(re^{i\theta}) + \overline{\alpha r e^{i\theta} h''(re^{i\theta})}}{2} d\theta
$$

$$
= M - \alpha + 1.
$$

Letting $r \to 1^-$ gives the desired bound. It is evident that $f(z) = z + \frac{M - \alpha + 1}{n + \alpha n (n - 2)} \overline{z^n}$ $(n \geq 2)$ belongs to $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ and $|b_n(f)| = \frac{M-\alpha+1}{n+\alpha n(n-2)}$. This completes the proof. \Box

Theorem 2.3. Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be of the form [\(1.1\)](#page-0-0) for $M > 0$ and $\alpha \in (0,1]$ *. For* $n \geq 2$ *, we have*

(i) $|a_n| + |b_n| \leq \frac{2(M-\alpha+1)}{n+\alpha n(n-2)};$ (ii) $||a_n| - |b_n|| \leq \frac{2(M-\alpha+1)}{n+\alpha n(n-2)};$ (iii) $|a_n| \leq \frac{2(M-\alpha+1)}{n+\alpha n(n-2)}$.

The results are sharp for the function f *given by* $f(z) = z + \sum_{n=2}^{\infty}$ $\frac{2(M-\alpha+1)}{n+\alpha n(n-2)}z^n.$ *Proof.* Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. In view of Theorem [2.1,](#page-2-1) we have $F_{\varepsilon} = h + \varepsilon g \in$ $\mathcal{P}(\alpha, M)$ for each ε ($|\varepsilon| = 1$). Therefore, we have

$$
((1 - \alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z) + M) > 0
$$
 for $z \in \mathbb{D}$.

This implies that there exists an analytic function p in $\mathbb D$ of the form $p(z) = 1 +$ $\sum_{n=1}^{\infty} p_n z^n$ with $p(0) = 1$ and Re $p(z) > 0$ in \mathbb{D} such that

$$
\frac{(1-\alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z) + M}{M - \alpha + 1} = p(z)
$$

\ni.e.,
$$
\frac{(M - \alpha + 1) + \sum_{n=2}^{\infty} (n + \alpha(n^2 - 2n)) (a_n + \varepsilon b_n) z^{n-1}}{M - \alpha + 1} = 1 + \sum_{n=1}^{\infty} p_n z^n
$$

\ni.e.,
$$
\sum_{n=1}^{\infty} (n + 1 + \alpha(n^2 - 1)) (a_{n+1} + \varepsilon b_{n+1}) z^n = (M - \alpha + 1) \sum_{n=1}^{\infty} p_n z^n.
$$
 (2.3)

Comparing coefficients on both sides of [\(2.3\)](#page-4-0), we have

$$
(n+1+\alpha(n^2-1))(a_{n+1}+\varepsilon b_{n+1}) = (M-\alpha+1)p_n \text{ for } n \ge 1.
$$
 (2.4)

By well-known coefficient estimates for functions with positive real parts (see $[4,17]$), we have $|p_n| \leq 2$ for $n \geq 1$. Since ε ($|\varepsilon| = 1$) is arbitrary, it follows from [\(2.4\)](#page-4-1) that

$$
(n+1+\alpha(n^2-1)) (|a_{n+1}|+|b_{n+1}|) \le 2(M-\alpha+1)
$$

and
$$
(n+1+\alpha(n^2-1)) ||a_{n+1}|-|b_{n+1}|| \le 2(M-\alpha+1).
$$

Therefore, for $n \geq 2$, we have

$$
|a_n|+|b_n| \le \frac{2(M-\alpha+1)}{n+\alpha(n^2-2n)}, ||a_n|-|b_n|| \le \frac{2(M-\alpha+1)}{n+\alpha(n^2-2n)} \text{ and } |a_n| \le \frac{2(M-\alpha+1)}{n+\alpha(n^2-2n)}.
$$

It is evident that the function f defined by $f(z) = z + \sum_{n=2}^{\infty}$ $\frac{2(M-\alpha+1)}{n+\alpha(n^2-2n)}z^n$ belongs to the class $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ and that all three inequalities are sharp. This completes the proof. \Box

In the following result, we establish the sharp growth estimates for functions in the class $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$.

Theorem 2.4. Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be of the form [\(1.1\)](#page-0-0) for $M > 0$ and $\alpha \in (0,1]$ *. Then,*

$$
|z| + 2(M - \alpha + 1) \sum_{n=2}^{\infty} \frac{(-1)^{n-1} |z|^n}{n(1 + \alpha(n-2))} \le |f(z)| \le |z| + 2(M - \alpha + 1) \sum_{n=2}^{\infty} \frac{|z|^n}{n(1 + \alpha(n-2))}.
$$
\n(2.5)

For each $z \in \mathbb{D}$, $z \neq 0$, equality occurs for the function f given by $f(z) = z + 2(M - z)$ $\alpha + 1$) $\sum_{n=2}^{\infty} \frac{z^n}{n(1+\alpha(n-2))}$ *or its suitable rotations.*

Proof. Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ for $M > 0$, $\alpha \in (0, 1]$ and $M - \alpha + 1 > 0$. Then $F_{\varepsilon} = h + \varepsilon g \in \mathcal{P}(\alpha, M)$ for each $|\varepsilon| = 1$. Thus, we have

$$
((1 - \alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z) + M) > 0
$$
 for $z \in \mathbb{D}$.

Then there exists an analytic function $\omega : \mathbb{D} \to \mathbb{D}$ with $\omega(0) = 0$ such that

$$
\frac{(1-\alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z) + M}{M - \alpha + 1} = \frac{1 + \omega(z)}{1 - \omega(z)},
$$

i.e.,
$$
(1-\alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z) = (M - \alpha + 1)\frac{1 + \omega(z)}{1 - \omega(z)} - M,
$$

i.e.,
$$
z^{\frac{1}{\alpha}-2} \left((1-\alpha) F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z) \right) = (1-\alpha) z^{\frac{1}{\alpha}-2} \frac{1+\omega(z)}{1-\omega(z)} + 2Mz^{\frac{1}{\alpha}-2} \frac{\omega(z)}{1-\omega(z)},
$$

$$
i.e., \qquad \frac{d}{dz}\left(\alpha z^{\frac{1}{\alpha}-1}F'_{\varepsilon}(z)\right)=(1-\alpha)z^{\frac{1}{\alpha}-2}\frac{1+\omega(z)}{1-\omega(z)}+2Mz^{\frac{1}{\alpha}-2}\frac{\omega(z)}{1-\omega(z)}.\tag{2.6}
$$

Note that, we can choose an analytic branch of $z^{\frac{1}{\alpha}-1}$ $(1/\alpha-1\geq 0)$ by restricting the argument of z to the range $(-\pi, \pi]$. This ensure that the function is single-valued and analytic within that range. Hence the function $z^{\frac{1}{\alpha}-1}$ is differentiable (see [\[14\]](#page-14-15)). Using the Schwarz lemma, we have $|\omega(z)| \leq |z|$ for $z \in \mathbb{D}$. We consider the following cases. **Case 1.** Let $\alpha \in (0,1)$. Using $F'_{\varepsilon}(0) = 1$, from [\(2.6\)](#page-5-0), we have

$$
\begin{split}\n&= \left| (1-\alpha) \int_0^z \xi^{\frac{1}{\alpha}-2} \frac{1+\omega(\xi)}{1-\omega(\xi)} d\xi + 2M \int_0^z \xi^{\frac{1}{\alpha}-2} \frac{\omega(\xi)}{1-\omega(\xi)} d\xi \right| \\
&= \left| (1-\alpha) \int_0^{|z|} \left(te^{i\theta} \right)^{\frac{1}{\alpha}-2} \frac{1+\omega(te^{i\theta})}{1-\omega(te^{i\theta})} e^{i\theta} dt + 2M \int_0^{|z|} \left(te^{i\theta} \right)^{\frac{1}{\alpha}-2} \frac{\omega(te^{i\theta})}{1-\omega(te^{i\theta})} e^{i\theta} dt \right| \\
&\leq (1-\alpha) \int_0^{|z|} t^{\frac{1}{\alpha}-2} \frac{1+t}{1-t} dt + 2M \int_0^{|z|} t^{\frac{1}{\alpha}-2} \frac{t}{1-t} dt \\
&\leq (1-\alpha) \int_0^{|z|} \left(t^{\frac{1}{\alpha}-2} + 2t^{\frac{1}{\alpha}-1} \sum_{n=0}^\infty t^n dt \right) + 2M \int_0^{|z|} t^{\frac{1}{\alpha}-1} \sum_{n=0}^\infty t^n dt \\
&= (1-\alpha) \frac{|z|^{\frac{1}{\alpha}-1}}{\frac{1}{\alpha}-1} + 2(M-\alpha+1) \sum_{n=0}^\infty \frac{|z|^{\frac{1}{\alpha}+n}}{\frac{1}{\alpha}+n}.\n\end{split}
$$

Therefore, we have

$$
|F'_{\varepsilon}(z)| = |h'(z) + \varepsilon g'(z)| \le 1 + 2(M - \alpha + 1) \sum_{n=0}^{\infty} \frac{|z|^{n+1}}{1 + \alpha n}
$$

= 1 + 2(M - \alpha + 1) \sum_{n=1}^{\infty} \frac{|z|^n}{1 + \alpha(n-1)}. (2.8)

Since ε ($|\varepsilon| = 1$) is arbitrary, it follows from [\(2.8\)](#page-5-1) that

$$
|h'(z)| + |g'(z)| \le 1 + 2(M - \alpha + 1) \sum_{n=1}^{\infty} \frac{|z|^n}{1 + \alpha(n-1)}.
$$

Let Γ be the radial segment from 0 to z. Therefore,

$$
|f(z)| = \left| \int_{\Gamma} \left(\frac{\partial f}{\partial \xi} d\xi + \frac{\partial f}{\partial \overline{\xi}} d\overline{\xi} \right) \right| \le \int_{\Gamma} \left(|h'(\xi)| + |g'(\xi)| \right) |d\xi|
$$

$$
\le \int_0^{|z|} \left(1 + 2(M - \alpha + 1) \sum_{n=1}^{\infty} \frac{t^n}{1 + \alpha(n-1)} \right) dt
$$

$$
= |z| + 2(M - \alpha + 1) \sum_{n=2}^{\infty} \frac{|z|^n}{n(1 + \alpha(n-2))}.
$$

Again from [\(2.7\)](#page-5-2), we have

$$
\begin{split}\n&\left|\alpha z^{\frac{1}{\alpha}-1}F'_{\varepsilon}(z)\right| \\
&= \left|(1-\alpha)\int_{0}^{|z|}\left(te^{i\theta}\right)^{\frac{1}{\alpha}-2}\frac{1+\omega(te^{i\theta})}{1-\omega(te^{i\theta})}e^{i\theta}dt + 2M\int_{0}^{|z|}\left(te^{i\theta}\right)^{\frac{1}{\alpha}-2}\frac{\omega(te^{i\theta})}{1-\omega(te^{i\theta})}e^{i\theta}dt\right| \\
&\geq (1-\alpha)\int_{0}^{|z|}t^{\frac{1}{\alpha}-2}\text{Re}\left(\frac{1+\omega(te^{i\theta})}{1-\omega(te^{i\theta})}\right)dt + 2M\int_{0}^{|z|}t^{\frac{1}{\alpha}-2}\text{Re}\left(\frac{\omega(te^{i\theta})}{1-\omega(te^{i\theta})}\right)dt.\n\end{split} \tag{2.9}
$$

It is evident that

$$
\begin{array}{rcl}\n\text{Re}\left(\frac{1+\omega(z)}{1-\omega(z)}\right) & = & \frac{1}{2}\left(\frac{1+\omega(z)}{1-\omega(z)} + \frac{1+\overline{\omega(z)}}{1-\overline{\omega(z)}}\right) \\
& = & \frac{1-|\omega(z)|^2}{|1-\omega(z)|^2} \ge \frac{(1+|\omega(z)|)(1-|\omega(z)|)}{(1+|\omega(z)|)^2} \ge \frac{1-|z|}{1+|z|}.\n\end{array} \tag{2.10}
$$

Furthermore, note that

$$
\operatorname{Re}(\omega(z)) \ge -|\omega(z)| \quad i.e., \quad \operatorname{Re}(\omega(z)) - |\omega(z)|^2 \ge -|\omega(z)|(1 + |\omega(z)|)
$$

and
$$
\frac{\operatorname{Re}(\omega(z)) - |\omega(z)|^2}{|1 - \omega(z)|^2} \ge \frac{-|\omega(z)|(1 + |\omega(z)|)}{(1 + |\omega(z)|)^2} = \frac{-|\omega(z)|}{1 + |\omega(z)|}.
$$

Thus,

$$
\operatorname{Re}\left(\frac{\omega(z)}{1-\omega(z)}\right) = \frac{\operatorname{Re}(\omega(z)) - |\omega(z)|^2}{|1-\omega(z)|^2} \ge \frac{-|z|}{1+|z|}.\tag{2.11}
$$

From [\(2.9\)](#page-6-0), [\(2.10\)](#page-6-1) and [\(2.11\)](#page-6-2), we have

$$
\begin{split}\n&|\alpha z^{\frac{1}{\alpha}-1}F'_{\varepsilon}(z)| \\
&\geq (1-\alpha)\int_{0}^{|z|}t^{\frac{1}{\alpha}-2}\frac{1-t}{1+t}dt - 2M\int_{0}^{|z|}t^{\frac{1}{\alpha}-2}\frac{t}{1+t}dt \\
&= (1-\alpha)\int_{0}^{|z|}\left(t^{\frac{1}{\alpha}-2}-2t^{\frac{1}{\alpha}-1}\sum_{n=0}^{\infty}(-1)^{n}t^{n}dt\right) - 2M\int_{0}^{|z|}t^{\frac{1}{\alpha}-1}\sum_{n=0}^{\infty}(-1)^{n}t^{n} \\
&= (1-\alpha)\frac{|z|^{\frac{1}{\alpha}-1}}{\frac{1}{\alpha}-1} - 2(M-\alpha+1)\sum_{n=0}^{\infty}(-1)^{n}\frac{|z|^{\frac{1}{\alpha}+n}}{\frac{1}{\alpha}+n}.\n\end{split}
$$

Therefore,

$$
|F'_{\varepsilon}(z)| = |h'(z) + \varepsilon g'(z)| \ge 1 - 2(M - \alpha + 1) \sum_{n=1}^{\infty} (-1)^{n-1} \frac{|z|^n}{1 + \alpha(n-1)}.
$$
 (2.12)

Since ε ($|\varepsilon| = 1$) is arbitrary, it follows from [\(2.12\)](#page-7-0) that

$$
|h'(z)| - |g'(z)| \ge 1 - 2(M - \alpha + 1) \sum_{n=1}^{\infty} (-1)^{n-1} \frac{|z|^n}{1 + \alpha(n-1)}.
$$
 (2.13)

In view of (2.13) , we have

$$
|f(z)| = \left| \int_0^z \left(\frac{\partial f}{\partial \xi} d\xi + \frac{\partial f}{\partial \overline{\xi}} d\overline{\xi} \right) \right|
$$

\n
$$
\geq \int_0^{|z|} \left(|h'(\xi)| - |g'(\xi)| \right) |d\xi|
$$

\n
$$
\geq \int_0^{|z|} \left(1 - 2(M - \alpha + 1) \sum_{n=1}^\infty (-1)^{n-1} \frac{t^n}{1 + \alpha(n-1)} \right) dt
$$

\n
$$
= |z| + 2(M - \alpha + 1) \sum_{n=2}^\infty (-1)^{n-1} \frac{|z|^n}{n(1 + \alpha(n-2))}.
$$

Case 2. Let $\alpha = 1$. From [\(2.6\)](#page-5-0), we have

$$
\frac{d}{dz}\left(F'_{\varepsilon}(z)\right) = \frac{2M\omega(z)}{z(1-\omega(z))}.
$$

Using $F'_{\varepsilon}(0) = 1$, we have

$$
|F'_{\varepsilon}(z)| = \left| 1 + 2M \int_0^{|z|} \frac{\omega(te^{i\theta})}{te^{i\theta}(1 - \omega(te^{i\theta}))} e^{i\theta} dt \right|
$$

$$
\leq 1 + 2M \int_0^{|z|} \frac{dt}{1 - t} = 1 + 2M \int_0^{|z|} \sum_{n=0}^{\infty} t^n dt = 1 + 2M \sum_{n=1}^{\infty} \frac{|z|^n}{n}.
$$

Similarly, we have

$$
|F'_{\varepsilon}(z)| \geq 1 + 2M \int_0^{|z|} \frac{1}{t} \text{Re}\left(\frac{\omega(te^{i\theta})}{1 - \omega(te^{i\theta})}\right) dt
$$

$$
\geq 1 - 2M \int_0^{|z|} \frac{dt}{1 + t} = 1 - 2M \sum_{n=1}^{\infty} \frac{(-1)^{n-1} |z|^n}{n}.
$$

Using similar argument as in Case 1, we have

$$
|z| + 2M \sum_{n=2}^{\infty} \frac{(-1)^{n-1} |z|^n}{n(n-1)} \le |f(z)| \le |z| + 2M \sum_{n=2}^{\infty} \frac{|z|^n}{n(n-1)}.
$$

Equality holds in (2.5) when f given by

$$
f(z) = z + 2(M - \alpha + 1) \sum_{n=2}^{\infty} \frac{z^n}{n(1 + \alpha(n-2))}
$$

or its suitable rotations. This completes the proof. \Box

Remark 2.1. *Setting* $\alpha = 1$ *in Theorem [2.4](#page-4-3) gives the sharp version of Theorem C.*

The following theorem gives a sufficient condition for a function to belong to $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. **Theorem 2.5.** Let $f = h + \overline{g} \in \mathcal{H}$ with $g'(0) = 0$ be given by [\(1.1\)](#page-0-0). If

$$
\sum_{n=2}^{\infty} (n + \alpha n(n-2)) (|a_n| + |b_n|) < M - \alpha + 1,
$$

then $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ *.*

Proof. Let $f = h + \overline{g} \in \mathcal{H}$ with $g'(0) = 0$. Let $h(z) = z + \sum_{n=2}^{\infty} a_n z^n$ \sum *coof.* Let $f = h + \overline{g} \in \mathcal{H}$ with $g'(0) = 0$. Let $h(z) = z + \sum_{n=2}^{\infty} a_n z^n$ and $g(z) = \sum_{n=2}^{\infty} b_n z^n$. Now,

$$
\operatorname{Re}\left((1-\alpha)h'(z) + \alpha zh''(z)\right) = \operatorname{Re}\left((1-\alpha) + \sum_{n=2}^{\infty} (n + \alpha n(n-2))a_n z^{n-1}\right)
$$

$$
\geq (1-\alpha) - \left|\sum_{n=2}^{\infty} (n + \alpha n(n-2))a_n z^{n-1}\right|
$$

$$
\geq (1-\alpha) - \sum_{n=2}^{\infty} (n + \alpha n(n-2))|a_n|.
$$

Since $\sum_{n=2}^{\infty} (n + \alpha n(n-2)) (|a_n| + |b_n|) < M - \alpha + 1$, thus, we have

$$
\begin{aligned} \operatorname{Re}\left((1-\alpha)h'(z) + \alpha zh''(z)\right) &\quad > \quad -M + \sum_{n=2}^{\infty} (n + \alpha n(n-2))|b_n| \\ &\geq \quad -M + \left|\sum_{n=2}^{\infty} (n + \alpha n(n-2))b_n z^{n-1}\right| \\ &= \quad -M + \left|(1-\alpha)g'(z) + \alpha zg''(z)\right|, \end{aligned}
$$

which shows that $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. This completes the proof.

We now recall the following well-known result.

Lemma 2.1. [\[2\]](#page-14-16) Let $f = h + \overline{g}$ be given by [\(1.1\)](#page-0-0).

- (i) *If* $\sum_{n=2}^{\infty} n (|a_n| + |b_n|) \leq 1$, then *f* is starlike in \mathbb{D} ;
- (ii) *If* $\sum_{n=2}^{\infty} n^2 (|a_n| + |b_n|) \leq 1$, then *f* is convex in \mathbb{D} .

By Theorem [2.3](#page-3-1) and Lemma [2.1,](#page-8-0) it is possible to show that each $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ is convex (resp. starlike) in some disk D , *i.e.*, $f(D)$ is a convex domain (resp. $f(D)$ is a domain starlike with respect to the origin).

Theorem 2.6. Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be given by [\(1.1\)](#page-0-0) for $M > 0$, $\alpha \in (0, 1]$ with $M - \alpha + 1 > 0$. Then, f is starlike in $|z| \leq r^*$ and convex in $|z| \leq r_c$, where $r^* \in (0,1)$ *is the smallest root of the equation*

$$
r \int_{s=0}^{1} \frac{s^{\frac{1}{\alpha} - 1}}{1 - rs} ds = \frac{\alpha}{2(M - \alpha + 1)}
$$

and $r_c \in (0, 1)$ *is the smallest root of the equation*

$$
\frac{r}{1-r} + \left(2 - \frac{1}{\alpha}\right) r \int_{s=0}^1 \frac{s^{\frac{1}{\alpha}-1}}{1-rs} ds = \frac{\alpha}{2(M-\alpha+1)}.
$$

Proof. Let $0 < r < 1$ and $f_r(z) = (1/r)f(rz) = z + \sum_{n=2}^{\infty} a_n r^{n-1}z^n + \sum_{n=2}^{\infty} b_n r^{n-1}z^n$ for $z \in \mathbb{D}$. For convenience, let

$$
S_1 = \sum_{n=2}^{\infty} n (|a_n| + |b_n|) r^{n-1} \quad \text{and} \quad S_2 = \sum_{n=2}^{\infty} n^2 (|a_n| + |b_n|) r^{n-1}.
$$

According to Lemma [2.1,](#page-8-0) it suffices to show that $S_1 \leq 1$ for $|z| = r \leq r^*$ and $S_2 \leq 1$ for $|z| = r \le r_c$. In view of Theorem [2.3,](#page-3-1) we have

$$
S_1 \le 2(M - \alpha + 1) \sum_{n=2}^{\infty} \frac{r^{n-1}}{1 + \alpha(n-2)} = \frac{2(M - \alpha + 1)}{\alpha} \sum_{n=2}^{\infty} \frac{r^{n-1}}{\frac{1}{\alpha} + n - 2}
$$

=
$$
\frac{2(M - \alpha + 1)}{\alpha} \left(r^{1 - \frac{1}{\alpha}} \sum_{n=2}^{\infty} \int_{t=0}^{r} t^{\frac{1}{\alpha} + n - 3} dt \right)
$$

=
$$
\frac{2(M - \alpha + 1)}{\alpha} \left(r^{1 - \frac{1}{\alpha}} \int_{t=0}^{r} \frac{t^{\frac{1}{\alpha} - 1}}{1 - t} dt \right)
$$

=
$$
\frac{2(M - \alpha + 1)}{\alpha} r \int_{s=0}^{1} \frac{s^{\frac{1}{\alpha} - 1}}{1 - rs} ds.
$$

Let

$$
G_1(r) := r \int_{s=0}^1 \frac{s^{\frac{1}{\alpha}-1}}{1-rs} ds - \frac{\alpha}{2(M-\alpha+1)} = 0.
$$
 (2.14)

Note that the function $G_1(r)$ is continuous in [0, 1] with $G_1(0) = -\frac{\alpha}{2(M-\alpha+1)} < 0$ and $\lim_{r\to 1^-} G_1(r) = +\infty$. In view of the Intermediate value theorem, there exists a $r_1 \in (0,1)$ such that $G_1(r_1) = 0$. Therefore, $S_1 \leq 1$ if $r \leq r^*$, where $r^* \in (0,1)$ is the smallest root of the equation (2.14) . In view of Theorem [2.3,](#page-3-1) we have

$$
S_2 \le 2(M - \alpha + 1) \sum_{n=2}^{\infty} \frac{nr^{n-1}}{1 + \alpha(n-2)} = \frac{2(M - \alpha + 1)}{\alpha} \left(\sum_{n=2}^{\infty} \frac{r^n}{\frac{1}{\alpha} + n - 2} \right)^{\prime}
$$

=
$$
\frac{2(M - \alpha + 1)}{\alpha} \left(r^{2 - \frac{1}{\alpha}} \sum_{n=2}^{\infty} \int_{t=0}^{r} t^{\frac{1}{\alpha} + n - 3} dt \right)^{\prime}
$$

=
$$
\frac{2(M - \alpha + 1)}{\alpha} \left(r^{2 - \frac{1}{\alpha}} \int_{t=0}^{r} \frac{t^{\frac{1}{\alpha} - 1}}{1 - t} dt \right)^{\prime}
$$

=
$$
\frac{2(M - \alpha + 1)}{\alpha} \left(\frac{r}{1 - r} + \left(2 - \frac{1}{\alpha} \right) r^{1 - \frac{1}{\alpha}} \int_{t=0}^{r} \frac{t^{\frac{1}{\alpha} - 1}}{1 - t} dt \right)
$$

=
$$
\frac{2(M - \alpha + 1)}{\alpha} \left(\frac{r}{1 - r} + \left(2 - \frac{1}{\alpha} \right) r \int_{s=0}^{1} \frac{s^{\frac{1}{\alpha} - 1}}{1 - rs} ds \right).
$$

Let

$$
G_2(r) := \frac{r}{1-r} + \left(2 - \frac{1}{\alpha}\right)r \int_{s=0}^1 \frac{s^{\frac{1}{\alpha}-1}}{1-rs} ds - \frac{\alpha}{2(M-\alpha+1)} = 0. \tag{2.15}
$$

Note that the function $G_2(r)$ is continuous in [0, 1) with $G_2(0) = -\frac{\alpha}{2(M-\alpha+1)} < 0$ and $\lim_{r\to 1^-} G_2(r) = +\infty$. In view of the Intermediate value theorem, there exists a $r_2 \in (0,1)$ such that $G_2(r_2) = 0$. Therefore, $S_2 \leq 1$ if $r \leq r_c$, where $r_c \in (0,1)$ is the smallest root of the equation (2.15) . This completes the proof.

Remark 2.2. For parameters $a, b, c \in \mathbb{C}$ with $c \neq -k$ $(k \in \mathbb{N} \cup \{0\})$ and $z \in \mathbb{D}$, the *Gaussian hypergeometric function is defined by*

$$
F(a, b, c, z) := {}_2F_1(a, b; c; z) = \sum_{n=0}^{\infty} \gamma_n z^n, \quad \text{where} \quad \gamma_n = \frac{(a)_n (b)_n}{(c)_n (1)_n},
$$

which converges for all $z \in \mathbb{D}$ *and converges on the circle* $|z| = 1$ *if* $Re(c - a - b) > 0$ *. Here,* $(a)_n$ *is the Pochhammer symbol defined as follows:*

$$
(a)_n := \begin{cases} 1, & \text{if } n = 0 \\ a(a+1)(a+2)\cdots(a+n-1), & \text{if } n > 0. \end{cases}
$$

It is evident that the Gaussian hypergeometric function F(a, b; c; z) *is analytic within the domain* D*, and it can also be analytically continued outside the unit circle. For further details, we refer to [\[15\]](#page-14-17) and the references cited therein. It is evident that*

$$
\int_{s=0}^1\frac{s^{\frac{1}{\alpha}-1}}{1-rs}ds=\alpha_2F_1\left(1,\frac{1}{\alpha};1+\frac{1}{\alpha};r\right).
$$

Note that ${}_2F_1(1, \frac{1}{\alpha}; 1 + \frac{1}{\alpha}; 0) = 1$ *and* ${}_2F_1(1, \frac{1}{\alpha}; 1 + \frac{1}{\alpha}; 1) = +\infty$ *. By using the Gaussian hypergeometric function with the above arguments, we can alternatively ensure the existence of positive roots of the equations [\(2.14\)](#page-9-0) and [\(2.15\)](#page-10-0) in* (0, 1)*.*

3. Convex combinations and convolutions

In the following result, we establish that the class $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ is invariant under convex combinations.

Theorem 3.1. *The class* $\mathcal{P}_{\mathcal{H}}^0(\alpha, M)$ *is closed under convex combinations.*

Proof. Let $f_i = h_i + \overline{g_i} \in \mathcal{P}_{\mathcal{H}}^0(\alpha, M)$ for $1 \leq i \leq n$ and $\sum_{i=1}^n t_i = 1$, where $0 \leq t_i \leq 1$ for each i . Thus, we have

$$
Re ((1 - \alpha)h'_i(z) + \alpha zh''_i(z)) > -M + |(1 - \alpha)h'_i(z) + \alpha zg''_i(z)|
$$

with $h_i(0) = g_i(0) = h'_i(0) - 1 = g'_i(0) = 0$ for $1 \le i \le n$ and $z \in \mathbb{D}$. The convex combination of the f_i 's can be written as

$$
f(z) = \sum_{i=1}^{n} t_i f_i(z) = h(z) + \overline{g(z)},
$$

where $h(z) = \sum_{i=1}^{n} t_i h_i(z)$ and $g(z) = \sum_{i=1}^{n} t_i g_i(z)$. It is evident that both h and g are analytic in $\overline{\mathbb{D}}$ with $h(0) = g(0) = h'(0) - 1 = g'(0) = 0$. Therefore,

$$
\begin{aligned}\n\text{Re}\left((1-\alpha)h'(z) + \alpha zh''(z)\right) &= \text{Re}\left((1-\alpha)\sum_{i=1}^n t_i h'_i(z) + \alpha z \sum_{i=1}^n t_i h''_i\right) \\
&= \text{Re}\left(\sum_{i=1}^n t_i \left((1-\alpha)h'_i(z) + \alpha zh''_i(z)\right)\right) \\
&> \sum_{i=1}^n t_i \left(-M + \left|(1-\alpha)g'_i(z) + \alpha zg''_i(z)\right|\right) \\
&= -M + \sum_{i=1}^n t_i \left|(1-\alpha)g'_i(z) + \alpha zg''_i(z)\right| \\
&\geq -M + \left|(1-\alpha)\left(\sum_{i=1}^n t_i g'_i(z)\right) + \alpha z \left(\sum_{i=1}^n t_i g''_i(z)\right)\right| \\
&= -M + \left|(1-\alpha)g'(z) + \alpha zg''(z)\right|,\n\end{aligned}
$$

which shows that $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. This completes the proof.

We need the following essential lemmas to prove our convolution results.

Lemma 3.1. *[\[16\]](#page-14-10) Let* {an} *be a convex null sequence. Then the function* p *given by* $p(z) = a_0/2 + \sum_{n=1}^{\infty} a_n z^n$ is analytic in \mathbb{D} and $Re(p(z)) > 0$.

Lemma 3.2. [\[16\]](#page-14-10) Let the function p be analytic in \mathbb{D} with $p(0) = 1$ and $Re(p(z)) > 1/2$ *in* D*. Then for any analytic function* f *in* D*, the function* p ∗ f *takes values in the convex hull of the image of* D *under* f*.*

Lemma 3.3. Let $F \in \mathcal{P}(\alpha, M)$ with $M - \alpha + 1 \leq \frac{3(1+\alpha)}{6\alpha+4}$. Then, $Re(F(z)/z) > 1/2$. *Proof.* Let $F \in \mathcal{P}(\alpha, M)$ be given by $F(z) = z + \sum_{n=2}^{\infty} A_n z^n$. Then, we have

Re
$$
((1 - \alpha)F'(z) + \alpha z F''(z)) > -M
$$
,
\ni.e., Re $((M - \alpha + 1) + \sum_{n=2}^{\infty} ((1 - \alpha)n + \alpha n(n-1))A_n z^{n-1}) > 0$,
\ni.e., Re $(1 + \frac{1}{2(M - \alpha + 1)} \sum_{n=2}^{\infty} (n + \alpha n(n-2))A_n z^{n-1}) > \frac{1}{2}$ for $z \in \mathbb{D}$.

Let $p(z) = 1 + \frac{1}{2(M-\alpha+1)} \sum_{n=2}^{\infty} (n + \alpha n(n-2)) A_n z^{n-1}$. Then, $p(0) = 1$ and $\text{Re}(p(z)) >$ 1/2 in **D**. We consider a sequence $\{c_n\}$ defined by $c_0 = 1$ and $c_{n-1} = \frac{2(M-\alpha+1)}{n+\alpha n(n-2)}$ for $n \geq 2$. It is evident that $c_n \to 0$ as $n \to \infty$. Note that, $c_0 - c_1 = 1 - (M - \alpha + 1)$, $c_1-c_2 = (M-\alpha+1)(1+3\alpha)/(3+3\alpha), c_2-c_3 = (5\alpha+1)(M-\alpha+1)/6((\alpha+1)(2\alpha+1)),$ $c_3 - c_4 = (7\alpha + 1)(M - \alpha + 1)/(10(2\alpha + 1)(3\alpha + 1))$, etc. It is evident that

$$
(c_1 - c_2) - (c_2 - c_3) = \frac{(12\alpha^2 + 5\alpha + 1)(M - \alpha + 1)}{6(\alpha + 1)(2\alpha + 1)} \ge 0,
$$

$$
(c_2 - c_3) - (c_3 - c_4) = \frac{(27\alpha^2 + 8\alpha + 1)(M - \alpha + 1)}{15(\alpha + 1)(2\alpha + 1)(3\alpha + 1)} \ge 0
$$

and so on. Thus, we have $c_{i-2} - c_{i-1} \ge c_{i-1} - c_i \ge 0$ for $i \ge 3$. Therefore,

$$
c_0 - c_1 \ge c_1 - c_2 \ge \cdots \ge c_{n-1} - c_n \ge \cdots \ge 0
$$

is possible only when $M - \alpha + 1 \leq 3(1 + \alpha)/(6\alpha + 4)$. Thus, $\{c_n\}$ is a convex null sequence. In view of Lemma [3.1,](#page-11-0) we have the function

$$
q(z) = \frac{1}{2} + \sum_{n=2}^{\infty} \frac{2(M - \alpha + 1)}{n + \alpha n(n-2)} z^{n-1},
$$

which is analytic in \mathbb{D} and $\text{Re}(q(z)) > 0$. Therefore

$$
\frac{F(z)}{z} = 1 + \sum_{n=2}^{\infty} A_n z^{n-1} = p(z) * \left(1 + \sum_{n=2}^{\infty} \frac{2(M - \alpha + 1)}{n + \alpha n(n-2)} z^{n-1} \right).
$$
 (3.1)

In view of Lemma [3.2](#page-11-1) and using [\(3.1\)](#page-12-0), we have Re $(F(z)/z) > 1/2$ for $z \in \mathbb{D}$. This completes the proof. \Box

Lemma 3.4. *Let* $F_1, F_2 \in \mathcal{P}(\alpha, M)$ *with* $M - \alpha + 1 \leq 3(1 + \alpha)/(6\alpha + 4)$ *. Then* $F_1 * F_2 \in \mathcal{P}(\alpha, M)$.

Proof. Let $F_1(z) = z + \sum_{n=2}^{\infty} A_n z^n$ and $F_2(z) = z + \sum_{n=2}^{\infty} B_n z^n$. Then the convolution of F_1 and F_2 is given by $F(z) = F_1(z) * F_2(z) = z + \sum_{n=2}^{\infty} A_n B_n z^n$. Therefore,

$$
(1 - \alpha)F'(z) + \alpha z F''(z) = (1 - \alpha) + \sum_{n=2}^{\infty} (n + \alpha n(n-2)) A_n B_n z^{n-1}
$$

$$
= \left(\frac{F_2(z)}{z}\right) * \left((1 - \alpha)F'_1(z) + \alpha z F''_1(z)\right). \tag{3.2}
$$

Since $F_1, F_2 \in \mathcal{P}(\alpha, M)$, it follows that $\text{Re}((1-\alpha)F'_1(z) + \alpha zF''_1(z)) > -M$ and in view of Lemma [3.3,](#page-11-2) we have $\text{Re}(F_2(z)/z) > 1/2$ for $z \in \mathbb{D}$. In view of Lemma [3.2](#page-11-1) and using [\(3.2\)](#page-12-1), we have Re $((1 - \alpha)F(z) + \alpha zF''(z)) > -M$ for $z \in \mathbb{D}$. Hence, $F = F_1 * F_2 \in \mathcal{P}(\alpha, M)$. This completes the proof.

In the following result, we establish that the class $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ is invariant under convolutions for some certain condition.

Theorem 3.2. Let $F_1, F_2 \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ with $M - \alpha + 1 \leq 3(1 + \alpha)/(6\alpha + 4)$. Then $F_1 * F_2 \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M).$

Proof. Let $F_1 = h_1 + \overline{g_1}$ and $F_2 = h_2 + \overline{g_2}$ be two functions in $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. The convolution of F_1 and F_2 is given by $F_1 * F_2 = h_1 * h_2 + \overline{g_1 * g_2}$. In order to show that $F_1 * F_2 \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$, it is sufficient to show that $F = h_1 * h_2 + \varepsilon (g_1 * g_2) \in \mathcal{P}(\alpha, M)$ for each ε with $|\varepsilon| = 1$. By Theorem [2.1,](#page-2-1) we have $h_1 + \varepsilon g_1, h_2 + \varepsilon g_2 \in \mathcal{P}(\alpha, M)$ for each ε with $|\varepsilon| = 1$. Now

$$
F = h_1 * h_2 + \varepsilon (g_1 * g_2) = \frac{1}{2} ((h_1 - g_1) * (h_2 - \varepsilon g_2)) + \frac{1}{2} ((h_1 + g_1) * (h_2 + \varepsilon g_2)).
$$

Using Lemma [3.4,](#page-12-2) we have $(h_1 - g_1) * (h_2 - \varepsilon g_2), (h_1 + g_1) * (h_2 + \varepsilon g_2) \in \mathcal{P}(\alpha, M)$. In view of Theorem [3.1,](#page-10-1) we have $F \in \mathcal{P}(\alpha, M)$. Thus, the class $\mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ is closed under convolution. This completes the proof.

In 2002, Goodloe [\[10\]](#page-14-11) defined the Hadamard product of a harmonic function with an analytic function as follows:

$$
f \tilde{*} \phi = h * \phi + \overline{g * \phi},
$$

where $f = h + \overline{g}$ is harmonic mapping in $\mathbb D$ and ϕ is an analytic function in $\mathbb D$.

Theorem 3.3. Let $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be given by [\(1.1\)](#page-0-0) and $\phi \in \mathcal{A}$ be such that $Re(\phi(z)/z)$ $1/2$ *for* $z \in \mathbb{D}$ *. Then* $f \ast \phi \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ *.*

Proof. Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$. In view of Theorem [2.1,](#page-2-1) we have $f_{\varepsilon} = h + \varepsilon g \in$ $\mathcal{P}(\alpha, M)$ for each ε with $|\varepsilon| = 1$. In order to prove that $f \tilde{*} \phi = h * \phi + \overline{g * \phi} \in \mathcal{P}_{\mathcal{H}}^0(\alpha, M)$, it is sufficient to show that $F_{\varepsilon}(z) = h * \phi + \varepsilon(g * \phi) \in \mathcal{P}(\alpha, M)$ for each ε ($|\varepsilon| = 1$). Since $f_{\varepsilon} \in \mathcal{P}(\alpha, M)$ and $\phi \in \mathcal{A}$, let $f_{\varepsilon}(z) = z + \sum_{n=2}^{\infty} A_n z^n$ and $\phi(z) = z + \sum_{n=2}^{\infty} B_n z^n$. Therefore, $F_{\varepsilon} = f_{\varepsilon} * \phi = z + \sum_{n=2}^{\infty} A_n B_n z^n$. Thus,

$$
(1 - \alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z) = (1 - \alpha) + \sum_{n=2}^{\infty} (n + \alpha n(n-2)) A_n B_n z^{n-1}
$$

$$
= \left(\frac{\phi(z)}{z}\right) * \left((1 - \alpha) f'_{\varepsilon}(z) + \alpha z f''_{\varepsilon}(z)\right). \tag{3.3}
$$

As Re $(\phi(z)/z) > 1/2$ for $z \in \mathbb{D}$ and $f_{\varepsilon} \in \mathcal{P}(\alpha, M)$, *i.e.*, Re $((1 - \alpha)f'_{\varepsilon}(z) + \alpha z f''_{\varepsilon}(z)) >$ $-M$, in view of Lemma [3.2](#page-11-1) and using (3.3) , we have

Re
$$
((1 - \alpha)F'_{\varepsilon}(z) + \alpha z F''_{\varepsilon}(z)) > -M
$$
 for $z \in \mathbb{D}$,

which shows that $F_{\varepsilon} \in \mathcal{P}(\alpha, M)$. This completes the proof.

Corollary 3.1. Let $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be given by (1.1) and $\phi \in \mathcal{K}$, where $\mathcal K$ denotes the *family of all convex functions in* \mathbb{D} *. Then* $f \tilde{*} \phi \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ *.*

Proof. Since $\phi \in \mathcal{K}$, it follows that Re $(\phi(z)/z) > 1/2$ for $z \in \mathbb{D}$. The result immediately follows from Theorem [3.3.](#page-13-1)

Theorem 3.4. Let $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be given by [\(1.1\)](#page-0-0) and $\phi \in \mathcal{A}$ be such that $Re(\phi(z)/z)$ $1/2$ *for* $z \in \mathbb{D}$ *. Then* $f * (\dot{\phi} + \beta \overline{\phi}) \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ *, where* $|\beta| = 1$ *.*

Proof. Let $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be of the form (1.1) , *i.e.*, $h(z) = z + \sum_{n=2}^{\infty} a_n z^n$, $g(z) = \sum_{n=2}^{\infty} b_n z^n$. Therefore,

$$
f * (\phi + \beta \overline{\phi}) = (h + \overline{g}) * (\phi + \overline{\overline{\beta}\phi}) = h * \phi + \overline{\overline{\beta}(g * \phi)}.
$$

To prove that $f * (\phi + \beta \overline{\phi}) \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$, in view of Theorem [2.1,](#page-2-1) it is sufficient to show that $f_{\varepsilon} = h * \phi + \varepsilon \overline{\beta}(g * \phi) \in \mathcal{P}(\alpha, M)$ for each ε ($|\varepsilon| = 1$). Let $\phi(z) = z + \sum_{n=2}^{\infty} C_n z^n$. For each $|\varepsilon| = 1$, we have

$$
(1 - \alpha) f'_{\varepsilon}(z) + \alpha z f''_{\varepsilon}(z) = \left(\frac{\phi(z)}{z}\right) * \left((1 - \alpha) \left(h(z) + \varepsilon \overline{\beta} g(z)\right)' + \alpha z \left(h(z) + \varepsilon \overline{\beta} g(z)\right)''\right).
$$
\n(3.4)

Since $f = h + \overline{g} \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$, in view of Theorem [2.1,](#page-2-1) we have $h + \varepsilon \overline{\beta} g \in \mathcal{P}(\alpha, M)$ for ε , β with $|\varepsilon \overline{\beta}| = 1$, *i.e.*, $|\beta| = 1$. Therefore, we have

$$
\operatorname{Re}\left(\left(1-\alpha\right)\left(h(z)+\varepsilon\overline{\beta}g(z)\right)'+\alpha z\left(h(z)+\varepsilon\overline{\beta}g(z)\right)''\right)>-M\quad\text{for}\quad z\in\mathbb{D}.
$$

Since Re $(\phi(z)/z) > 1/2$ for $z \in \mathbb{D}$, using Lemma [3.2](#page-11-1) and [\(3.4\)](#page-13-2), we have

Re
$$
((1 - \alpha)f'_{\varepsilon}(z) + \alpha z f''_{\varepsilon}(z)) > -M
$$
 for $z \in \mathbb{D}$.

Hence, $f_{\varepsilon} \in \mathcal{P}(\alpha, M)$. This completes the proof.

Corollary 3.2. Let $f \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ be given by (1.1) and $\phi \in \mathcal{K}$, where $\mathcal K$ denotes the *family of all convex functions in* \mathbb{D} *. Then* $f * (\phi + \beta \overline{\phi}) \in \mathcal{P}^0_{\mathcal{H}}(\alpha, M)$ *, where* $|\beta| = 1$ *.*

Proof. Since $\phi \in \mathcal{K}$, it follows that Re $(\phi(z)/z) > 1/2$ for $z \in \mathbb{D}$. The result immediately follows from Theorem [3.4.](#page-13-3)
