Positive determinacy of h-Shuhan matrices with $h < 2$

Abstract

In this paper, we define h-Shuhan matrix, which is the generalization of the generalized Cartan matrix, and find the h-Shuhan matrices for all positive semi-definite (or generalized positive semi-definite, virtual positive semi-definite) with $h < 2$. Furthermore, we know that the largest eigenvalue of the matrix \hat{B}_n^h increases with n, but it is always less than h plus a constant $\epsilon \approx 2.04998$.

1 Introduction

Generalized cartan matrices play a central role in the classification of finite-dimensional complex semisimple Lie algebras and in the construction of the Kac-Moody algebra. The determinants of Cartan matrices are all greater than 0. If we replace the 2's on the main diagonal of a Cartan matrix with positive real numbers respectively, what should be the smallest of these numbers? We found all these smallest positive real numbers and expressed them explicitly.

Let $\mathbb{R} := \{x | x \text{ is a real number}\}\$. $X_{\geq} := \{x | X \subset \mathbb{R}, x \in X, x \geq 0\}$. $X_{>} := X_{\geq} \setminus \{0\}$. $\mathbb{Z} :=$ ${x|x \text{ is an integer}}. \mathbb{N} =: Z_>, \mathbb{Q} := {x|x \text{ is a rational number}}. \mathbb{S}_n$ denotes symmetric group, $n \in \mathbb{N}$. Throughout this paper $H = (h_{ij})_{n \times n}$ and $h_{ij} \in \mathbb{R}, n \in \mathbb{N}$ without special announcement. For any matrix H, |H| is the determinant of H. Let H_{i_1,i_2,\dots,i_m} denotes the algebraic cofactors after removing the i_1, i_2, \cdots, i_m rows, i_1, i_2, \cdots, i_m columns of matrix $H; \tilde{H}_{i_1, i_2, \cdots, i_m}$ represents the submatrix at the intersection of rows i_1, i_2, \dots, i_m and columns i_1, i_2, \dots, i_m of matrix H, without changing their position order in H, where $1 \leq i_1 < i_2 < \cdots < i_m \leq n, m \in \mathbb{N}$. Generalized Dynkin diagrams, generalized Cartan matrix and the other notations are the same as in [\[Hu72\]](#page-10-0),[\[Ka90\]](#page-10-1). Let $\mathbb{V}_n := \{x | x$ is a column vector in \mathbb{R} of order $n\}$, $I = \{1, 2, \ldots, n\}$.

Definition 1.1. The matrix H is called virtual positive semi-definite if $|\tilde{H}_{i_1,i_2,\cdots,i_m}| \geq 0$, where $1 \leq i_1 < i_2 < \cdots < i_m \leq n, m \in \mathbb{N}$. The matrix H is called generalized positive semi-definite if $x'Hx \geq 0$ for any $x \in \mathbb{V}_n$.

The symbol \geq in the above definition is replaced by $>$, and the corresponding virtual positive semi-definite and generalized positive semi-definite are called virtual positive-definite

and generalized positive-definite, respectively. If $H' = H$, then H is virtual positive semidefinite if and only if H is generalized positive semi-definite, moreover, H is positive semidefinite. Let $\hat{H} = \frac{H + H'}{2}$ $\frac{+H'}{2}$.

Lemma 1.2. The matrix H is generalized positive semi-definite if and only if \hat{H} is positive semi-definite.

Proof. The only if part is clear, since $\hat{H}' = \hat{H}$ and $x'\hat{H}x = x'\frac{H+H'}{2}x = \frac{1}{2}$ $\frac{1}{2}(x'Hx + x'H'x) =$ 1 $\frac{1}{2}(x'Hx + (x'Hx)') \geq 0$ for any $x \in \mathbb{V}_n$. We know $\frac{H-H'}{2}$ is an anti-symmetric matrix, then $x' \frac{H-H'}{2} x = 0$ for any $x \in \mathbb{V}_n$, so $x' H x = x' \frac{H+H'}{2} x + x' \frac{H-H'}{2} x \ge 0$.

Lemma 1.3. Assume that T is an anti-symmetric matrix of order n .

(i) If H is a positive-definite matrix, then $|H + T| \geq |H|$, and $|H + T| = |H|$ if and only if $T=0.$

(ii) If H is a positive semi-definite matrix, then $|H + T| \geq |H|$.

Proof. (i) Since H is positive-definite, there exists an invertible matrix P such that $P'HP = E_n$. Clearly $P'TP$ is also an anti-symmetric matrix, so there exists an orthogonal matrix Q such that $Q'P'TPQ = diag\begin{pmatrix} 0 & t_1 \\ -t_1 & 0 \end{pmatrix}$ $-t_1$ 0 $\Big)$,..., $\Big(\begin{array}{cc} 0 & t_s \\ t & 0 \end{array} \Big)$ $-t_s$ 0 $(0, \ldots, 0)$ and $Q'P'HPQ = E_n$. We obtain $|H + T| \geq |H|$ since $|Q'P'(H + T)PQ| = |diag\left\{\begin{array}{cc} 1 & t_1 \\ -t_1 & 1 \end{array}\right\}$ $-t_1$ 1 $\Big\}$, ..., $\Big(\begin{array}{cc} 1 & t_s \\ 1 & 1 \end{array} \Big)$ $-t_s$ 1 $\Big)$, 1, $|1, \ldots, 1\rangle = (1+t_1^2)\cdots(1+t_s^2) \ge 1 = |Q'P'HPQ|$, the equal sign holds if and only if $t_1, \ldots, t_s = 0$, i.e. $T=0$.

(ii) If H is positive semi-definite, then $H + tE_n$ is positive-definite for $t \in \mathbb{R}$ and $|H +$ $tE_n + T \geq |H + tE_n|$ by (i). Let $t \to 0^+$, we obtain $|H + T| \geq |H|$.

Proposition 1.4. If H is generalized positive semi-definite, then

- (i) $\tilde{H}_{1,2,...,s}, s \in I$ are generalized positive semi-definite.
- (ii) H is virtual positive semi-definite. The reverse is not true.

Proof. (i) Let

, $H = \begin{pmatrix} \tilde{H}_{1,2,...,s} & \cdots \\ \cdots & \cdots \end{pmatrix}$, then $x'Hx = y'\tilde{H}_{1,2,...,s}y \ge 0$.

(ii) We have $\hat{H} = \frac{H+H'}{2}$ $\frac{H}{2}$ is positive semi-definite by Lemma [1.2,](#page-1-0) then $\tilde{H}_{i_1,\dots,i_{m}}$ is positive semi-definite since $\tilde{\hat{H}}_{i_1,\dots,i_m} = \frac{\tilde{H}_{i_1,\dots,i_m} + \tilde{H}'_{i_1,\dots,i_m}}{2}$ $\frac{|\tilde{H}'_{i_1,\dots,i_m}|}{2}$. Thus $|\tilde{H}_{i_1,\dots,i_m}| = |\frac{\tilde{H}_{i_1,\dots,i_m} + \tilde{H}'_{i_1,\dots,i_m}|}{2}$ $\tilde{H}_{i_1,\cdots,i_m}-\tilde{H}'_{i_1,\cdots,i_m}$ $\left|\frac{\tilde{H}_{i_1,\cdots,i_m}}{2}\right| \geq \big|\frac{\tilde{H}_{i_1,\cdots,i_m}+\tilde{H}'_{i_1,\cdots,i_m}}{2}\big|$ $|\frac{H_{i_1,\dots,i_m}}{2}| = |\tilde{T}_{i_1,\dots,i_m}| \geq 0$, where $1 \leq i_1 < i_2 < \dots < i_m \leq$ $n, m \in \mathbb{N}$. Set $H = \begin{pmatrix} 2 & -\frac{7}{2} \\ -1 & 2 \end{pmatrix}$ $\begin{pmatrix} 2 & -\frac{7}{2} \\ -1 & 2 \end{pmatrix}$, and there exists $x = \begin{pmatrix} 1 \\ 1 \end{pmatrix}$ 1 $\Big) \in \mathbb{V}_2$ such that $x' H x = -\frac{1}{2}$, but H is virtual positive-definite matrix. \Box

Remark 1.5. (i) Assume that H is generalized positive semi-definite. If T is generalized positive semi-definite, then $H + T$ is generalized positive semi-definite. Specifically, if $\lambda > 0$, then $H + \lambda E$ is generalized positive-definite.

(ii) Replacing generalized positive semi-definite with virtual positive semi-definite in (i), it is possible that the conclusion is not valid. For example, $H = \begin{pmatrix} 2 & -\frac{7}{2} \\ 1 & 2 \end{pmatrix}$ $\begin{pmatrix} 2 & -\frac{7}{2} \\ -1 & 2 \end{pmatrix}$, $T = \begin{pmatrix} 2 & -1 \\ -\frac{7}{2} & 2 \end{pmatrix}$ $-\frac{7}{2}$ $rac{1}{2}$ 2 .

Set $H_{\sigma} := (h_{\sigma(i),\sigma(j)})_{n \times n}$ and $x'_{\sigma} := (x_{\sigma(1)},\ldots,x_{\sigma(n)})$ if $\sigma \in \mathbb{S}_n$ and $x' = (x_1,\ldots,x_n)$.

Lemma 1.6. For any $\sigma \in \mathbb{S}_n$, then

(i) $|H| = |H_{\sigma}|;$

(ii) the matrix H is virtual positive semi-definite if and only if H_{σ} is virtual positive semidefinite;

(iii) the matrix H is generalized positive semi-definite if and only if H_{σ} is generalized positive semi-definite.

Proof. (i) All $\sigma \in \mathbb{S}_n$ can be written as the product of transpositions $(i, j) \in \mathbb{S}_n$. $|H_{(i,j)}|$ is obtained by swapping the *i*-th and *j*-th rows of $|H|$, as well as swapping the *i*-th and *j*-th columns, then $|H_{(i,j)}| = |H|$.

(ii) If H_{σ} is virtual positive semi-definite, then $|(\tilde{H}_{\sigma})_{j_1,j_2,\cdots,j_m}| \geq 0$ for all j_1, j_2, \cdots, j_m with $1 \leq j_1 < j_2 < \cdots < j_m \leq n, m \in I$. For $\forall i_1, i_2, \cdots, i_k$ with $1 \leq i_1 < i_2 < \cdots < i_k \leq n, k \in I$, there exists $\sigma \in \mathbb{S}_n$ and j_1, j_2, \cdots, j_k such that $|\tilde{H}_{i_1, i_2, \cdots, i_k}| = |(\tilde{H}_{\sigma})_{j_1, j_2, \cdots, j_k}|$ with $1 \leq j_1 <$ $j_2 < \cdots < j_k \leq n$. The only if part is similar.

(iii) If H is generalized positive semi-definite, then $x' H x \ge 0$ for any $x \in \mathbb{V}_n$. For any $\sigma \in \mathbb{S}_n$, we have $H_{\sigma} = T'HT$, T is a permutation matrix, and $x'H_{\sigma}x = x'T'HTx = (Tx)'H(Tx) \ge 0$ for any $x \in V_n$. The if part is similar.

Proposition 1.7. The matrix H is virtual positive semi-definite if and only if $\tilde{H}_{i_1,i_2,\dots,i_{n-1}}$, $1 \leq i_1 < i_2 < \cdots < i_{n-1} \leq n$ are virtual positive semi-definite and $|H| \geq 0$.

Proof. Since any m order submatrix of H must be an m order submatrix of some $\tilde{H}_{i_1,i_2,\dots,i_{n-1}}$ for $1 \leq m \leq n-1$, the conclusion holds.

Definition 1.8. The matrix H is called h-Shuhan matrix if it satisfies the following conditions:

- (S1) $h_{ii} = h$ for $h \in \mathbb{R}_{>}, i = 1, ..., n;$
- (S2) $h_{ij} \leq 0$ for $h_{ij} \in \mathbb{Z}, i \neq j$;
- (S3) $h_{ij} = h_{ji}$ or $h_{ij} < h_{ji} = -1$ for $i \neq j$.

If H is a h-Shuhan matrix, then $\tilde{H}_{i_1,i_2,\dots,i_m}$, H_{σ} are h-Shuhan matrices with $1 \leq i_1 < i_2 <$ $\cdots < i_m \leq n, \sigma \in \mathbb{S}_n$ and $H + (2 - h)E$ is a generalized Cartan matrix. [\[WLX22\]](#page-10-2) and [\[WZ25\]](#page-10-3) give the generalized Shuhan diagrams corresponding to all 2-Shuhan matrices that are not positive-definite, but positive semi-definite.

2 Positive-definite of h-Shuhan matrices

Lemma 2.1. (i) Set $|H_{1,2,...,n}| = 1$, then $|H + \lambda \sum_{i=1}^{n}$ k $\sum_{l=1} E_{ll} = |H| + \sum_{l=1}$ k $_{l=1}$ λ^l \sum $1 \le i_1 < i_2 < \cdots < i_l \le k$ $|H_{i_1,i_2,...,i_l}|$ for any $k \in I$.

Proof. We show this by induction on k. If $k = 1$, $|H + \lambda E_{11}| = |H| + \lambda |H_1|$. Assume $k > 1$. See $|H + \lambda \sum_{i=1}^{\infty}$ k $\sum_{l=1} E_{ll} = |H + \lambda$ \sum^{k-1} $\sum_{l=1} E_{ll}| + \lambda |H_k + \lambda$ \sum^{k-1} $\sum_{l=1} E_{ll}$

Proposition 2.2. If H is virtual positive semi-definite and λ is the eigenvalue of H, then $\lambda \geq 0$.

Proof. Assuming λ is the eigenvalue of H and $\lambda < 0$, let $\lambda_1 = -\lambda > 0$. By definition of virtual positive semi-definite, we have $|H| \geq 0$, $|H_{i_1,i_2,...,i_l}| \geq 0$ for all $i_1, i_2,...,i_l$ with $1 \leq i_1 < i_2 <$ $\cdots < i_l \leq n-1$, then $|H + \lambda_1 E| = |H| +$ \sum^{n-1} $_{l=1}$ λ_1^l \sum $1 \leq i_1 < i_2 < \cdots < i_l \leq n-1$ $|H_{i_1,i_2,...,i_l}| + \lambda_1^n > 0$ since Lemma [2.1,](#page-2-0) which contradicts to that $|H - \lambda E| = |H + \lambda_1 E| = 0$.

Lemma 2.3. (See [\[Ka90,](#page-10-1) Chapter.4]) If H is an indecomposable generalized Cartan matrix, then H is affine if and only if it is degenerate and all its principal minors are nonnegative.

Proposition 2.4. (i) Generalized Cartan matrix H is virtual positive semi-definite if and only if H is of finite and affine type.

(ii) If $\lambda > 0$ and H is virtual positive semi-definite, then $H + \lambda E$ is virtual positive-definite, furthermore, if $h < 2$ and H is virtual positive semi-definite, then $H + (2 - h)E$ is of finite type.

(iii) If $h > 2$ and $H + (2 - h)E$ is of finite or affine type, then H is virtual positive-definite.

Proof. (i) It is clear by [\[Ka90,](#page-10-1) Prop.4.7(a)(b)] and Lemma [2.3.](#page-3-0)

(ii) By definition of virtual positive semi-definite, we have $|H| \geq 0$ and $|H_{i_1,i_2,\dots,i_l}| \geq$ 0 for all i_1, i_2, \cdots, i_l with $1 \le i_1 < i_2 < \cdots < i_l \le n - 1$, then $|H + \lambda E| = |H| +$ \sum^{n-1} $_{l=1}$ λ^l \sum $1 \leq i_1 < i_2 < \cdots < i_l \leq n-1$ $|H_{i_1, i_2, ..., i_l}| + \lambda^n > 0$ since Lemma [2.1.](#page-2-0) (iii) It is clear by (ii). \Box

3 Positive semi-definite of h-Shuhan matrices with $h < 2$

In the following content of this section $H = (h_{ij})_{n \times n}, n \in \mathbb{N}$ is an indecomposable h-Shuhan matrix, $h_{ii} = h \in \mathbb{R}_{\ge}$ and $\sigma \in \mathbb{S}_n$ without special announcement.

Denote the finite or affine generalized Cartan matrices by S, respectively, and write $S^h :=$

 $S + (h-2)E, s^h := |S^h|, \hat{s}^h := |\hat{S}^h|$. Let $a_0^h := 1$, we have

Lemma 3.1. If $h \neq 2$, then $a_n^h = \frac{1}{\sqrt{h^2-4}} \left[\left(\frac{h+\sqrt{h^2-4}}{2} \right)^{n+1} - \left(\frac{h-\sqrt{h^2-4}}{2} \right)^{n+1} \right]$.

Proof. By $a_n^h = ha_{n-1}^h - a_{n-2}^h$, consider its characteristic equation $x^2 - hx + 1 = 0$, the solution is $x = \frac{h \pm \sqrt{h^2 - 4}}{2}$, then $a_n^h = k(\frac{h + \sqrt{h^2 - 4}}{2})^n + l(\frac{h - \sqrt{h^2 - 4}}{2})^n$. Substitute into $n = 1, 2$, then $k = \frac{\sqrt{h^2-4}+h}{2\sqrt{h^2-4}}, \frac{\sqrt{h^2-4}-h}{2\sqrt{h^2-4}},$ simplify and complete the proof. \square

Lemma 3.2. If $0 \le h < 2$, then (i) $a_n^h = \frac{\sin(n+1)\theta}{\sin \theta}$, $b_n^h = 2\cos n\theta$, $d_n^h = 4\cos\theta\cos(n-1)\theta$, $0 <$ $\theta \leq \frac{\pi}{2}$ $\frac{\pi}{2}$.

(ii) $a_n^h \geq 0$ if and only if $h \geq 2\cos\frac{\pi}{n+1}$, $n \geq 1$, $b_n^h \geq 0$ if and only if $h \geq 2\cos\frac{\pi}{2n}$, $n \geq 2$, $d_n^h \geq 0$ if and only if $h \geq 2cos \frac{\pi}{2(n-1)}, n \geq 4$.

Proof. (i) Since $(\frac{h}{2})^2 + (\frac{\sqrt{4-h^2}}{2})^2 = 1$ and $0 \le h < 2$, set $\cos\theta = \frac{h}{2}, \sin\theta = \frac{\sqrt{4-h^2}}{2}, 0 < \theta \le \frac{\pi}{2}$. Using the Euler formula, it is obtained that $a_n^h = \frac{1}{2 i \sin \theta} [(cos \theta + i sin \theta)^{n+1} - (cos \theta - i sin \theta)^{n+1}] =$ $\frac{1}{2i\sin\theta}[\cos(n+1)\theta + i\sin(n+1)\theta - (\cos(n+1)\theta - i\sin(n+1)\theta)] = \frac{\sin(n+1)\theta}{\sin\theta}$. $b_n^h = a_n^h - a_{n-2}^h = \frac{\sin(n+1)\theta}{\sin\theta} - \frac{\sin(n-1)\theta}{\sin\theta} = 2\cos n\theta$.

(ii) If $a_n^h \geq 0$, then $\cos\theta = \frac{h}{2} \geq \cos\frac{\pi}{n+1}$ since $0 \leq (n+1)\theta \leq \pi, 0 \leq \theta \leq \frac{\pi}{n+1}$. If $b_n^h \geq 0$, then $cos\theta = \frac{h}{2} \ge cos\frac{\pi}{2n}$ since $-\frac{\pi}{2} \le n\theta \le \frac{\pi}{2}$ $\frac{\pi}{2}, -\frac{\pi}{2n} \leq \theta \leq \frac{\pi}{2n}$ $\frac{\pi}{2n}$. If $d_n^h \geq 0$, then $d_n^h \geq 0 \Leftrightarrow b_{n-1}^h \geq 0$ by $d_n^h = h b_{n-1}^h$, and it is proved. \Box

Proposition 3.3. (i) A_n^h is positive semi-definite if and only if $h \geq 2cos \frac{\pi}{n+1}$, $n \geq 1$.

- (ii) B_n^h is virtual positive semi-definite if and only if $h \geq 2\cos \frac{\pi}{2n}$, $n \geq 2$.
- (iii) D_n^h is positive semi-definite if and only if $h \geq 2\cos \frac{\pi}{2(n-1)}$, $n \geq 4$.
- (iv) E_6^h is positive semi-definite if and only if $h \geq 2\cos{\frac{\pi}{12}}$.
- (v) E_7^h is positive semi-definite if and only if $h \geq 2\cos{\frac{\pi}{18}}$.
- (vi) E_8^h is positive semi-definite if and only if $h \geq 2\cos \frac{\pi}{30}$.
- (vii) F_4^h is virtual positive semi-definite if and only if $h \geq 2\cos{\frac{\pi}{12}}$.
- (viii) G_2^h is virtual positive semi-definite if and only if $h \geq 2\cos{\frac{\pi}{6}}$.

Proof. (i) A_n^h is positive semi-definite if and only if $a_k^h \geq 0, 1 \leq k \leq n$.

(ii) B_n^h is virtual positive semi-definite if and only if $a_{k-1}^h \geq 0, b_k^h \geq 0, 2 \leq k \leq n$, i.e. $h \geq 2\cos{\frac{\pi}{k}}$ and $h \geq 2\cos{\frac{\pi}{2k}}$, $k \geq 2$ simultaneously established. Then $h \geq 2\cos{\frac{\pi}{2n}}$, $n \geq 2$.

(iii) D_n^h is positive semi-definite if and only if $a_{k-1}^h \geq 0, d_k^h \geq 0, 4 \leq k \leq n$, i.e. $h \geq 2cos \frac{\pi}{k}$ and $h \geq 2\cos\frac{\pi}{2(k-1)}, k \geq 4$ simultaneously established. Then $h \geq 2\cos\frac{\pi}{2(n-1)}, n \geq 4$.

Then $h \geq 2cos\frac{\pi}{12}$.

(1) $\mu_n > \mu_{n-2}$: if $\mu_n \leq \mu_{n-2}$, choose $\mu_{n-2} < h < \mu_{n-1}$ such that $\hat{b}_n^h > 0$, $\hat{b}_{n-1}^h < 0$, $\hat{b}_{n-2}^h > 0$ since the induction hypothesis imply that $\mu_{n-2} < \mu_{n-1}$, in this case go on to consider the equation $\hat{b}_n^h = h\hat{b}_{n-1}^h - \hat{b}_{n-2}^h$. The left side is strictly greater than 0 and the right side is strictly less than 0, which is a contradiction.

(2) $\mu_n > \mu_{n-1}$: if $\mu_n < \mu_{n-1}$, choose $\mu_n < h < \mu_{n-1}$ such that $\hat{b}_n^h > 0$, $\hat{b}_{n-1}^h < 0$, $\hat{b}_{n-2}^h > 0$ by (1), in this case go on to consider the equation $\hat{b}_n^h = h\hat{b}_{n-1}^h - \hat{b}_{n-2}^h$, we have $0 < \hat{b}_n^h, h\hat{b}_{n-1}^h - \hat{b}_{n-2}^h <$ 0, which is a contradiction. if $\mu_n = \mu_{n-1}$, then $0 = \hat{b}_n^{\mu_n} = h \hat{b}_{n-1}^{\mu_n} - \hat{b}_{n-2}^{\mu_n} = 0 - \hat{b}_{n-2}^{\mu_n}$ $_{n-2}^{\mu_n}$, this contradicts $\hat{b}^{\mu_n}_{n-1}$ $\mu_n^{\mu_n} > 0$ since $\mu_n > \mu_{n-2}$.

Combined with the fact that μ_n is the largest eigenvalue of \hat{B}_n^0 , we know that the largest eigenvalue of the matrix \hat{B}_n^h increases with n, but it is always less than h plus a constant $\epsilon \approx 2.04998.$

Remark 3.8. We use trigonometric and inverse trigonometric functions to represent μ_6, μ_7, μ_8 because they cannot be expressed using only real radical. The fact that μ_6, μ_7, μ_8 cannot be expressed using only real radical in $[DF03, Chapter 14]$, we specifically give reasons why μ_8 cannot be expressed in this way: consider the Galois group of $f_x = x^4 - \frac{33}{4}$ $\frac{33}{4}x^3 + \frac{85}{4}$ $\frac{35}{4}x^2 - \frac{35}{2}$ $\frac{35}{2}x + \frac{9}{4}$ $\frac{9}{4}$, The discriminant $d_f = \frac{12567329}{4096} \in Q^2$, the resolvent $r(x) = x^3 - \frac{85}{4}$ $\frac{35}{4}x^2 + \frac{1083}{8}$ $\frac{183}{8}x - \frac{31861}{64}$ is irreducible over Q if and only if $64r(x)$ is irreducible over \mathbb{Z} . Verify that any $x = \frac{u}{v}$ $\frac{u}{v}, v \in$ ${1, 2, 4, 8, 16, 32, 64}, u \in {1, 211, 151, 31861}$ is not a solution of $r(x)$, then $r(x)$ is irreducible and the Galois group of f_x is $G_f = S_4$. Since $|G_f| = 24$ is not 2-group, we know that $f(x)$ has no real radicals by [\[Is85,](#page-10-5) Theorem].

Assume that $n > 4$ and $\lambda_k \leq \frac{\sqrt{17}}{2}$ $\frac{17}{2}$, $k \leq n-1$, it follows to show that $\lambda_n \leq \frac{\sqrt{17}}{2}$ $\frac{\sqrt{17}}{2}$: if $\lambda_n > \frac{\sqrt{17}}{2}$ $\frac{\sqrt{17}}{2}$, then $\hat{b}_{n-1}^{(1)\lambda_n} > 0$ since $\lambda_{n-1} \leq \frac{\sqrt{17}}{2}$ $\frac{17}{2}$ by inductive assumption. We have $\hat{b}_{n}^{\lambda n} - \hat{b}_{n-1}^{\lambda n} = (\lambda_{n} - 1)\hat{b}_{n-1}^{\lambda n} - \hat{b}_{n-2}^{\lambda n} \ge \hat{b}_{n-1}^{\lambda n} - \hat{b}_{n-2}^{\lambda n} = (\lambda_{n} - 1)\hat{b}_{n-2}^{\lambda n} - \hat{b}_{n-3}^{\lambda n} \ge \hat{b}_{n-2}^{\lambda n} - \hat{b}_{n-3}^{\lambda n}$ since $\lambda_n > \frac{\sqrt{17}}{2} > \epsilon$. Consider $0 = \hat{b}_n^{(1)\lambda_n} = \lambda_n \hat{b}_n^{\lambda_n} - \lambda_n \hat{b}_{n-2}^{\lambda_n}$, $\hat{b}_{n-1}^{(1)\lambda_n} = \lambda_n \hat{b}_{n-1}^{\lambda_n} - \lambda_n \hat{b}_{n-3}^{\lambda_n}$, $-\hat{b}_{n-1}^{(1)\lambda_n} = \lambda_n [(\hat{b}_n^{\lambda_n} - \hat{b}_{n-1}^{\lambda_n}) - (\hat{b}_{n-2}^{\lambda_n} - \hat{b}_{n-3}^{\lambda_n})],$ it is a contradiction that the left side is less than 0 and the right side is greater than 0.

(ii) The proof is divided into two steps.

Step 1. We prove by induction on $n \text{ that } \eta_n \leq \frac{9}{4}$ $\frac{9}{4}$. It is clear for $n = 2$, assume that $\eta_k \leq \frac{9}{4}$ $\frac{9}{4}, k \leq n-1$. If $\eta_n > \frac{9}{4}$ $\frac{9}{4}$, then $\hat{c}_n^{(1)}$ = $\frac{9}{4}$ $\frac{9}{4}\hat{b}_{n}^{\frac{9}{4}}-\frac{9}{4}$ $\frac{9}{4}\hat{b}_{n-1}^{\frac{9}{4}} > 0$ by Lemma [3.12.](#page-8-0) There exist $h_1 \in \{h|\hat{c}_n^{(1)h} = 0\} - \{\eta_n\}$ and $h_2 > \frac{9}{4}$ $\frac{9}{4}$ such that $h_1 > \frac{9}{4}$ $\frac{9}{4}$ and $\hat{c}_n^{(1)h_2} \leq 0$, respectively. On the other hand, $\hat{c}_n^{(1)h_2} = h_2 \hat{b}_n^{h_2} - \frac{9}{4}$ $\frac{9}{4}\hat{b}_{n-1}^{h_2} > \frac{9}{4}$ $\frac{9}{4}\hat{b}^{h_2}_n-\frac{9}{4}$ $\frac{9}{4} \hat{b}_{n-1}^{h_2} > 0$ by Lemma [3.12,](#page-8-0) it's a contradiction.

Step 2. A simple calculation gives $\hat{c}_2^{(1)h} = h(h^2 - \frac{9}{2})$ $\left(\frac{9}{2}\right), \hat{c}_3^{(1)h} = \left(h^2 - \frac{11}{4}\right)$ $\sqrt{10}$ $\frac{\sqrt{10}}{2}$) $(h^2 - \frac{11}{4} + \frac{\sqrt{10}}{2})$ $\frac{10}{2}$), then $\eta_2 = \frac{3\sqrt{2}}{2}$ $\sqrt{\frac{2}{2}}, \eta_3=\sqrt{\frac{11}{4}+\frac{\sqrt{10}}{2}}<\frac{3\sqrt{2}}{2}$ $\frac{\sqrt{2}}{2}$. Assume that $n > 3$ and $\eta_k \leq \frac{3\sqrt{2}}{2}$ $\frac{\sqrt{2}}{2}$, $k \leq n-1$, it follows to show that $\eta_n \leq \frac{3\sqrt{2}}{2}$ $\frac{\sqrt{2}}{2}$: if $\eta_n > \frac{3\sqrt{2}}{2}$ $\frac{\sqrt{2}}{2}$, then $\hat{c}_{n-1}^{(1)\eta_n} > 0$ since $\eta_{n-1} \leq \frac{\sqrt{17}}{2}$ $\frac{17}{2}$ by inductive assumption. We have $\hat{b}_{n}^{\lambda n} - \hat{b}_{n-1}^{\lambda n} = (\lambda_{n-1})\hat{b}_{n-1}^{\lambda n} - \hat{b}_{n-2}^{\lambda n} > \hat{b}_{n-1}^{\lambda n} - \hat{b}_{n-2}^{\lambda n} = (\lambda_{n-1})\hat{b}_{n-2}^{\lambda n} - \hat{b}_{n-3}^{\lambda n} > \hat{b}_{n-2}^{\lambda n} - \hat{b}_{n-3}^{\lambda n}$ since $\lambda_n > \frac{\sqrt{17}}{2} > \epsilon$. Consider $0 = \hat{c}_n^{(1)\eta_n} = \eta_n \hat{b}_n^{\eta_n} - \frac{9}{4}$ $\frac{9}{4}\hat{b}_{n-1}^{\eta_{n}}=\eta_{n}(\eta_{n}\hat{b}_{n-1}^{\eta_{n}}-\hat{b}_{n-1}^{\eta_{n}})$ $\binom{\eta_n}{n-2} - \frac{9}{4}$ $\frac{9}{4}\hat{b}_{n-1}^{\eta_n} =$ $(\eta_n^2 - \frac{9}{4})$ $\frac{9}{4}$) $\hat{b}_{n-1}^{\eta_n} - \eta_n \hat{b}_{n-1}^{\eta_n}$ $\eta_{n-1}^{\eta_n},\,\hat{c}_{n-1}^{(1)\eta_n}=\eta_n\hat{b}_{n-1}^{\eta_n}-\frac{9}{4}$ $\frac{9}{4}\hat{b}_{n-}^{\eta_n}$ $\eta_{n-2}^{\eta_n}, -\hat{c}_{n-1}^{(1)\eta_n} = (\eta_n^2 - \eta_n - \frac{9}{4})$ $\frac{9}{4}$) $\hat{b}_{n-1}^{\eta_n}$ - $(\eta_n - \frac{9}{4})$ $\frac{9}{4}$ $\hat{b}_{n-2}^{\eta_n} > 0$, then $\hat{c}_{n-1}^{(1)\eta_n} < 0$, it is a contradiction.

Remark 3.14. Replacing all positive semi-definite and \geq in Theorem [3.9,](#page-7-0) Proposition [3.10,](#page-8-1) Proposition [3.11](#page-8-2) and Proposition [3.13](#page-8-3) with positive-definite and >, the conclusion still stands.

Proposition 3.15. (1) Generalized Cartan matrix H is generalized positive semi-definite if and only if H_{σ} is one of the following: A_n^2 , $n \geq 1$; D_n^2 , $n \geq 4$; E_6^2 ; E_7^2 ; E_8^2 ; B_n^2 , $2 \leq n \leq$ $9; F_4^2; G_2^2; A_1^{(1)2}$ $I_1^{(1)2}$; $A_n^{(1)2}, n \geq 2$; $D_n^{(1)2}, n \geq 4$; $E_6^{(1)2}$ $E_6^{(1)2};E_7^{(1)2}$ $E_7^{(1)2};E_8^{(1)2}$ $8^{(1)2}$.

(2) Generalized Cartan matrix H is generalized positive-definite if and only if H_{σ} is one of the following: $A_n^2, n \geq 1; D_n^2, n \geq 4; E_6^2; E_7^2; E_8^2; B_n^2, 2 \leq n \leq 8.$

Proof. We have $\hat{b}_n^2 = 2 - \frac{1}{4}$ $\frac{1}{4}(n-1), n \ge 1$, if $n < 9$, then $\hat{b}_n^2 > 0$, if $n = 9$, then $\hat{b}_n^2 = 0$, if $n > 9$, then $\hat{b}_n^2 < 0$, $\hat{f}_4^2 = 0$, $\hat{g}_2^2 = 0$. If H is of indefinite type, then there exists $u > 0$ such that $Hu < 0$, thus $u'Hu < 0$ and H is not generalized positive semi-definite. If H is of finite (resp. affine type) with $H' = H$, then H is positive-definite (resp. positive semidefinite and not positive-definite), i.e. $A_n^2, n \geq 1; D_n^2, n \geq 4; E_6^2, E_7^2, E_8^2$ are positive-definite, $A_1^{(1)2}$ $\mathcal{L}_1^{(1)2}; A_n^{(1)2}, n \geq 2; D_n^{(1)2}, n \geq 4; E_6^{(1)2}$ $\bar{t}_6^{(1)2};E_7^{(1)2}$ $\bar{\tau}_7^{(1)2};E_8^{(1)2}$ $8^{(1)2}$ are positive semi-definite and not positivedefinite. If H is affine type with $H' \neq H$, then H is not generalized positive semi-definite by Proposition [3.11,](#page-8-2) Proposition [3.13](#page-8-3) and [\[Ka90,](#page-10-1) Theorem 4.8]. If H is finite type with $H' \neq H$, then $B_n^2, 2 \le n \le 8$ are generalized positive-definite, B_9^2, F_4^2, G_2^2 are generalized positive semi-definite and not generalized positive-definite by Proposition [3.7.](#page-6-0)
