A Frequency-aware Augmentation Network for Mental Disorders Assessment from Audio

Abstract—Depression and Attention Deficit Hyperactivity Disorder (ADHD) stand out as the common mental health challenges today. In affective computing, speech signals serve as effective biomarkers for mental disorder assessment. Current research, relying on labor-intensive hand-crafted features or simplistic timefrequency representations, often overlooks critical details by not accounting for the differential impacts of various frequency bands and temporal fluctuations. Therefore, we propose a frequencyaware augmentation network with dynamic convolution for depression and ADHD assessment. In the proposed method, the spectrogram is used as the input feature and adopts a multi-scale convolution to help the network focus on discriminative frequency bands related to mental disorders. A dynamic convolution is also designed to aggregate multiple convolution kernels dynamically based upon their attentions which are input-independent to capture dynamic information. Finally, a feature augmentation block is proposed to enhance the feature representation ability and make full use of the captured information. Experimental results on AVEC 2014 and self-recorded ADHD dataset prove the robustness of our method, an RMSE of 9.23 was attained for estimating depression severity, along with an accuracy of 89.8% in detecting ADHD.

Index Terms—Attention deficit hyperactivity disorder; Depression; deep learning; audio-based disorder assessment

I. INTRODUCTION

Mental health is crucial for effectively handling life's challenges, with depression and ADHD being notable concerns that affect millions worldwide [\[1\]](#page-4-0). These disorders are recognized by the World Health Organization (WHO) as common, yet often go underdiagnosed and under-treated due to their complex symptoms and the global shortage of specialized mental health professionals [\[2\]](#page-4-1). This situation underscores the necessity for innovative diagnostic tools to support the early detection and management of depression and ADHD. Developing such tools could alleviate the healthcare burden by complementing the expertise of clinicians, leading to faster diagnosis and tailored treatments. Ultimately, enhancing diagnostic capabilities for these mental health conditions promises to improve patient care and outcomes significantly [\[3\]](#page-4-2).

In the last decade, deep learning has driven breakthroughs in areas like speech and image recognition [\[4\]](#page-4-3)–[\[6\]](#page-4-4) and some studies suggest combining deep learning with additional data has shown promise in detecting mental conditions such as depression and ADHD [\[2\]](#page-4-1), [\[7\]](#page-4-5), [\[8\]](#page-4-6). Wang et al. [\[9\]](#page-4-7) have innovatively transformed EEG data into 2D images to train via AlexNet, enhancing the efficiency of depression diagnosis by analyzing EEG channel features and their correlation with the condition. In parallel, Zhao et al. [\[10\]](#page-4-8) developed a dynamic graph convolutional network that utilizes sparse connections between brain regions from fMRI data to aid in detecting ADHD. Despite the critical role of psychological signals in mental health diagnostics, their collection often requires costly and invasive equipment, such as MRI scanners and EEG headsets.

Speech signals, as a cost-effective, non-invasive diagnostic tool for mental health conditions, have been extensively studied. Recent research [\[11\]](#page-4-9) has explored how speech patterns correlate with depression levels indicated by the Beck Depression Inventory-II (BDI-II) score [\[12\]](#page-4-10). The main challenge is identifying speech features that signify conditions like depression. Although depressive speech may show paralinguistic markers like variability in fundamental frequency, jitter, and shimmer [\[13\]](#page-4-11), these traditional acoustic features often fail to capture specific symptoms, leading researchers to pursue extensive but less effective feature sets [\[14\]](#page-4-12).

To address these limitations, recent studies have shifted towards using time-frequency representations of speech signals such as Fourier spectrogram and mel-spectrogram to aid in the detection of mental disorders [\[15\]](#page-4-13). However, such methods treat each time and frequency component equally and the commonly used convolutional neural networks with a single convolutional kernel do not consider the temporal variations which are vital for the effect estimation [\[16\]](#page-4-14), [\[17\]](#page-4-15). Moreover, there are studies suggesting that not all frequency bands hold equal significance in mental health conditions when using speech signals [\[18\]](#page-4-16).

In this paper, we propose a frequency-aware augmentation network with dynamic convolution to aid in the assessment of depression and ADHD. Specifically, we use three parallel depth-wise convolution networks to give different attention weights to different frequency bands of the input spectrogram. Additionally, to capture temporal variation changes, the dynamic convolution (Dy-CNN) is designed by aggregating multiple kernels to capture contextual information. Finally, a feature augmentation block is designed to enhance the feature propagation and representation abilities.

In summary, the main contributions of this study can be summarized as follows:

- 1) Development of a frequency-aware augmentation network: This innovative network is tailored to emphasize the discriminate frequency bands in speech signals that are crucial for identifying the signs of depression and ADHD.
- 2) The implementation integrates dynamic convolution to allow the model to adaptively aggregate convolution kernels based on their relevance, thereby capturing essential temporal fluctuations in speech signals. Additionally, the introduction of a Feature Augmentation Block significantly enhances the network's feature representation capabilities and improves information flow efficiency.

The results from our evaluations of the Audio/Video Emotion Challenge (AVEC) 2014 [\[19\]](#page-4-17) dataset and our multi-modal ADHD dataset highlight the effectiveness of the proposed framework.

II. PROPOSED METHOD

This section details each proposed module, with Fig.1 presents the comprehensive diagram of the proposed method.

A. Frequency-aware Spectrogram Reweight

Recent studies indicate that unique local patterns in speech signals vary across frequency ranges, with lower bands effectively distinguishing normal from disordered speech [\[20\]](#page-4-18), [\[21\]](#page-4-19). This finding motivates us to adjust spectrogram weights by frequency band. To analyze these, we convert the audio signal $S(n)$ into a time-frequency domain representation using the Short-Time Fourier Transformation (STFT).

where S_r and S_i denote the real and imaginary parts of the $S(n)$, respectively. The magnitude spectrogram $\mathbf{S_m} \in \mathbb{R}^{T \times F}$, is then calculated with the real S_r and the imaginary S_i components as:

After capturing the magnitude spectrogram, it is fed to three parallel 1-D depthwise convolutions, denoted as D-Conv*k* for $k \in \{1,2,3\}$ with an additional fully connected layer designed to learn a weight vector $\mathbf{W} \in \mathbb{R}^F$, which aims to assign specific weights to each frequency bin. To apply these weights, W is broadcasted to match the dimensions of the spectrogram $\mathbf{S_m} \in \mathbb{R}^{T \times F}$, then a dot product is performed between the broadcasted W and S_m , effectively applying the weights across the spectrogram to achieve the weighting:

This procedure captures the information on mental speech disorders hidden in the spectrogram, and the re-weighted spectrogram S_m retains the same dimension as the input feature.

B. Dynamic Convolution

Traditional convolutional techniques use static kernels, limiting the extraction of sample-wise contextual data. The dynamic convolution addresses this by using multiple convolution kernels that adjust to speech changes in mental disorders through an attention mechanism. This allows for a more precise adaptation to input data, enhancing feature extraction. Fig. 2 visually contrasts conventional and dynamic convolution networks.

Specifically, we implement an attention mechanism by alternating fully connected layers and ReLU activation function to compute attention weights $\{\alpha_1, \dots, \alpha_N\}$ for N convolutional kernels, ensuring the same dimensions for both input and output. The process of dynamic convolution is:

where x and y denote the input and output features, respectively, and K_n represents the *n*-th convolutional kernel weighted by the attention weight α_n , derived from a sequence of fully connected layers applied to the input features and a softmax function is utilized to constraint the attention weights α_n sum-to-one.

C. Feature Augmentation Block

As shown in Fig. 3, the feature augmentation block is strategically designed to bolster the model's capability to represent features more effectively based on the designed Dy-CNN. Drawing inspiration from the work [\[22\]](#page-4-20), [\[23\]](#page-4-21), we incorporate the dense block and transition layer to achieve this enhancement. The dense block facilitates improved feature propagation and reuse by aggregating channel responses from various layers. Concurrently, the transition layer is tasked with streamlining the model by reducing the number of channels and applying pooling operations to isolate regions with pronounced convolution responses. This dual approach not only amplifies the model's ability to capture and utilize relevant features but also addresses the challenge of gradient vanishing, thereby making the training process more robust and efficient.

III. EXPERIMENTAL EVALUATIONS AND RESULTS

A. Datasets

We conducted experiments on one public AVEC 2014 [\[19\]](#page-4-17) depression database and one self-recorded multi-modal ADHD dataset.

The AVEC 2014 depression database specifically focuses on evaluating automatic depression detection algorithms through two human-computer interaction tasks, "Northwind" and "Freeform". It comprises 150 speech files from 84 subjects, with these files evenly divided among training, development, and test sets. Each of these sets contains 50 samples, covering a wide duration range from 6 seconds to 4 minutes. Notably, for experimental purposes, the training, development, and test sets from both tasks are merged to form a consolidated dataset,

resulting in 100 speech files per set for subsequent analyses, and each subject is labeled with BDI-II scores.

In our Intelligent Sensing ADHD Trial (ISAT) [\[24\]](#page-4-22), we developed a multimodal ADHD dataset featuring audio and video modalities, recorded in an environment simulating a quiet, interference-free medical clinic. We enrolled 22 native English speakers, dividing them into 10 ADHD-diagnosed subjects and 12 controls, verified by the Cumbria, Northumberland, Tyne and Wear National Health Service (CNTW-NHS) Foundation Trust with the ASRSv1.1 checklist [\[25\]](#page-4-23). Recruitment was through university poster advertisements. This study focuses on the audio modality, employing a DIVA instrumentderived questionnaire [\[26\]](#page-4-24) covering social interactions, selfesteem, and work life to guide participant interviews. A total of 462 audio recordings were obtained using portable microphones.

B. Evaluation Metric

For the depression assessment, which is inherently a regression task aimed at predicting the BDI-II scores, we utilize the Root Mean Square Error (RMSE) and Mean Absolute Error (MAE) as our primary evaluation metrics as popular in depression assessment. These metrics are defined as follows:

where y_i and \hat{y}_i represent the actual and predicted BDI-II scores for the i -th sample, respectively. Conversely, ADHD detection is approached as a classification task, necessitating metrics that can evaluate the model's ability to accurately categorize subjects. Therefore, we adopt accuracy (Acc.), precision (Pre.), recall (Re.), and F1-Score (F1) as the evaluation metrics for this task.

C. Experiments setup

In our study involving the AVEC 2014 corpora, following the state-of-the-art literature [\[27\]](#page-4-25), we also processed the speech signals at a sampling rate of 8 kHz and segmented them into 3-second intervals with a 50% overlap between consecutive segments. The labeling of each segment was based on the corresponding BDI-II score of the audio source. Throughout all the network layers, the ReLU served as the activation function. We chose the Root Mean Square Error (RMSE) as our loss function for this regression-focused task, aligning with Equation 6. The Adam optimization algorithm was employed to train the model, using a batch size of 32, momentum of 0.9, and a learning rate of 0.0001.

In our ADHD dataset analysis, we resampled raw audio to 16kHz, cleaned up abnormalities using Audacity [\[28\]](#page-4-26), and standardized clip lengths to 10 seconds in line with previous work [\[29\]](#page-4-27), interpolating shorter clips with silence. Spectrograms were produced using a Fast Fourier Transform (FFT) size of 1024 and a hop length of 160. We implemented a batch size of 16 and an initial learning rate of 0.0001, optimizing with Adam and cross-entropy loss.

D. Experimental Results and Discussions

1) Visualization of Frequency-aware Re-weighting: Figure 4 presents an intuitive visual comparison between the original and specifically weighted spectrograms of individuals diagnosed with depression and ADHD. By applying targeted frequency-wise weighting to the spectrograms, there's a noticeable emphasis on the lower frequency bands while simultaneously paying less attention to the higher frequency bands. This observation underscores the effectiveness of employing refined weighting strategies on spectrograms, significantly enhancing the detection and analysis of speech signal characteristics linked to mental disorders. The strategic focus on lower frequencies, crucial for conveying speech information related to mental health conditions, facilitates a more distinct recognition of patterns specific to disorders. Additionally, it may provide valuable insights into the mechanisms behind speech alterations associated with mental health issues. Thus, this approach holds significant potential for the development of diagnostic and therapeutic tools using speech signals as non-invasive biomarkers for assessing mental health.

2) Comparison of AVEC 2014 with previous methods: Table 1 showcases the comparison of the results on the AVEC 2014 database. It can be concluded that the methods rely on hand-crafted features, showing progressive improvements in RMSE and MAE values, but still exhibit higher MAE error rates. , The method in [\[15\]](#page-4-13) utilizing solely Mel-Frequency Cepstral Coefficients (MFCC), marks a shift towards automatic feature extraction with slightly better results. Besides, [\[32\]](#page-4-30) and [\[27\]](#page-4-25) employ Fourier spectrograms, indicating the effectiveness of spectral features in capturing relevant information, which is reflected in their improved accuracy. The Proposed Method, enhancing this approach by reweighting the Fourier spectrogram frequency-wise, achieves the best performance with the lowest RMSE and MAE values. This suggests that more sophisticated, tailored feature extraction methods, particularly those that emphasize frequency domain nuances, are crucial for enhancing predictive accuracy in automatic depression level detection.

3) Comparison of Multimodal ADHD Dataset with Different Network Architectures: Table 2 highlights the development of network architectures based on audio for detecting ADHD, ultimately leading to the superior performance of the newly proposed CGRU method. This method integrates the feature extraction capabilities of CNNs with the sequential processing strengths of GRUs, achieving considerable accuracy, precision, recall, and F1 scores. The advancement of the proposed method over previous widely used approaches demonstrates the effectiveness of reweighting the spectrogram and capturing dynamic information, allowing for a nuanced analysis of audio signals, significantly enhancing the model's predictive accuracy and reliability in ADHD detection tasks.

IV. CONCLUSIONS AND FUTURE WORK

In this paper, a novel framework that utilizes frequency re-weighting and dynamic convolution as well as a feature augmentation block is proposed for depression and ADHD assessment from speech signals. Experiments on AVEC 2014 and the ADHD datasets demonstrated the effectiveness of our proposed method and suggested a suitable way for speechbased mental disorder detection. In the future, we will explore the phase information to improve the intelligibility of the spectrogram and novel blocks to enhance the feature representations, besides, we will extend our work to multi-modality as well.
