# **On the components of random geometric graphs in the dense limit**

#### **Abstract**

Consider the geometric graph on *n* independent uniform random points in a connected compact region *A* of  $\mathbb{R}^d, d \geq 2$  with smooth boundary, or in the unit square, with distance parameter  $r_n$ . Let  $K_n$  be the number of components of this graph, and  $R_n$  the number of vertices not in the giant component. Let  $S_n$  be the number of isolated vertices. We show that if  $r_n$  is chosen so that  $nr_n^d$  tends to infinity but slowly enough that  $\mathbb{E}[S_n]$  also tends to infinity, then  $K_n$ ,  $R_n$  and  $S_n$  are all asymptotic to  $\mu_n$  in probability as  $n \to \infty$  where (with |A|,  $\theta_d$  and | $\partial A$ | denoting the volume of *A*, the volume of the unit *d*-ball, and the perimeter of *A* respectively)  $\mu_n := n e^{-\pi n r_n^d/|A|}$  if  $d = 2$  and  $\mu_n := n e^{-\theta_d n r_n^d/|A|} + \theta_{d-1}^{-1} |\partial A| r_n^{1-d} e^{-\theta_d n r_n^d/(2|A|)}$  if  $d \geq 3$ . We also give variance asymptotics and central limit theorems for  $K_n$  and  $R_n$ in this limiting regime when  $d \geq 3$ , and for Poisson input with  $d \geq 2$ . We extend these results (substituting  $\mathbb{E}[S_n]$  for  $\mu_n$ ) to a class of non-uniform distributions on *A*.

# <span id="page-1-0"></span>**1 Introduction**

Given a compact set A with a nice boundary in Euclidean space  $\mathbb{R}^d$ ,  $d \geq 2$ , the *random geometric graph* (RGG) based on a random point set  $\mathcal{X} \subset A$  is the graph  $G(\mathcal{X}, r)$  wth vertex set  $\mathcal X$  and edges between each pair of points distant at most  $r$  apart, in the Euclidean metric, for a specified distance parameter  $r > 0$ . Such graphs are important in a variety of applications (see [\[7\]](#page-52-0)), including modern topological data analysis (TDA), where the topological properties of the graph are used to help understand the topology of *A*.

In this paper we consider the *number of components* of the graph  $G$ , denoted  $K(G)$ , where  $G = G(\mathcal{X}, r)$  with  $\mathcal X$  a random sample of *n* points in A (denoted  $\mathcal X_n$ ) or the corresponding Poisson process (denoted  $\mathcal{P}_n$ , and defined more formally later). In particular, we investigate asymptotic properties for large *n* with  $r = r(n)$  specified and decaying to zero according to a certain limiting regime (see  $(1.1)$ ,  $(1.2)$  below). Our results add significantly to the existing literature about the limit theory of Betti numbers, an area that has received intensive recent attention in TDA. Indeed, the number of components of  $G(\mathcal{X}, r)$ is the 0-th Betti number of the occupied Boolean set  $\bigcup_{x \in \mathcal{X}} B_{r/2}(x)$ , where  $B_r(x)$  or  $B(x, r)$ denotes the closed Euclidean ball of radius  $r$  centred on  $x$ . Given the sample  $\mathcal{X}$ , keeping track of  $K(G(\mathcal{X}, r))$  while varying r corresponds to the 0-th persistent homology, which leads to sparse topological descriptors in a 2D persistence diagram. See [\[1\]](#page-52-1) for related geometric models of TDA.

We are also concerned with the *giant component* - the component of  $G(\mathcal{X}, r)$  with the largest order. For the graphs we consider, most of the vertices lie in the giant component, so for more detailed information we consider the total number of vertices  $R(G(\mathcal{X}, r))$  that are *not* in the giant component of  $G(\mathcal{X}, r)$ . To be precise, given a finite graph G of order *n*, list the orders of its components in decreasing order as  $L_1(G), L_2(G), \ldots, L_{K(G)}(G)$ . Set  $R(G) := n - L_1(G)$ .

We shall consider the limiting behaviour of  $K_n := K(G(\mathcal{X}_n, r_n)), K'_n := K(G(\mathcal{P}_n, r_n)),$  $R_n := R(G(\mathcal{X}_n, r))$  and  $R'_n := (G(\mathcal{P}_n, r_n))$  as  $n \to \infty$  with  $r_n$  specified for all  $n \geq 1$ . Let  $\theta_d$ (or *θ* for short) denote the volume of the unit radius ball in  $\mathbb{R}^d$ , i.e.  $\theta_d := \pi^{d/2}/\Gamma(1+d/2)$ . For points uniformly distributed in *A* (which we call the *uniform case*), the main limiting regime for  $r_n$  that we consider here is to assume that as  $n \to \infty$ ,

$$
\gamma_n := n(\theta/\lambda(A))r_n^d - (2 - 2/d)(\log n - \mathbf{1}_{\{d \ge 3\}} \log \log n) \to -\infty,
$$
\n(1.2)

where  $\lambda$  denotes the Lebesgue measure on  $\mathbb{R}^d$ . We call this the *intermediate* or *mildly dense* regime because the average vertex degree is of order  $\Theta(nr_n^d)$  and therefore grows to infinity as *n* becomes large, but only slowly in this regime.

Other limiting regimes of *r* are better understood. In the *thermodynamic regime* where  $nr_n^d \to a\lambda(A)$  with  $a \in (0, \infty)$  as  $n \to \infty$ , it holds as  $n \to \infty$  that

$$
\frac{K_n}{n} \xrightarrow{\mathbb{P}} c(a); \qquad \frac{R_n}{n} \xrightarrow{\mathbb{P}} c'(a), \qquad (1.3)
$$

where  $c(a) \in (0,1)$  is given explicitly in [\[7,](#page-52-0) Theorem 13.25], and  $c'(a) \in (0,1]$  is given less explicitly in [\[7,](#page-52-0) Theorem 11.9]. If *a* lies below a certain percolation threshold  $a_c$  :=  $a_c(d) \in (0,\infty)$  then  $c'(a) = 1$ . Central limit theorems for  $K_n$  and for  $R_n$  in this regime are also proved in [\[7\]](#page-52-0) (these results hold for  $K'_{n}$  and  $R'_{n}$  as well as for  $K_{n}$  and  $R_{n}$ ).

In the *sparse regime* where  $nr_n^d \to 0$ , the average vertex degree goes to 0 and we still have [\(1.3\)](#page-2-1) with  $c(0) = c'(0) = 1$ . This can be deduced from the fact that  $c(a) \to 1$  as  $a \to 0$  (which can be deduced from the formula in [\[7\]](#page-52-0)), along with coupling arguments.

On the other hand, if  $\gamma_n \to +\infty$ , and  $\partial A$  is smooth or A is a convex polygon, it follows from [\[11,](#page-52-2) Theorem 1.1] that with probability tending to 1 as  $n \to \infty$ ,  $G(\mathcal{X}_n, r_n)$  is fully connected so that  $K_n = 1$  and  $R_n = 0$ . We here call this limiting regime the *connectivity regime* (in [\[7\]](#page-52-0) this terminology was used slightly differently).

As well as the mildly dense regime [\(1.1\)](#page-2-0), [\(1.2\)](#page-2-0), in this paper we also consider the case where  $\gamma_n$  is bounded away from  $-\infty$  and  $+\infty$  as  $n \to \infty$ ; we call this the *critical regime for connectivity*. Thus we consider the whole range of possible limiting behaviours for *r* in between the thermodynamic and connectivity regimes.

In TDA one is interested in understanding (for a fixed sample  $\mathcal{X}_n$ ) the number of components of  $G(\mathcal{X}_n, r)$  in the whole range of values from  $r = 0$ , right up to the connectivity threshold (i.e. the smallest *r* such that  $G(\mathcal{X}_n, r)$  is connected). Therefore it seems well worth trying to understand  $K_n$  in the mildly dense regime, as well as in other regimes. Likewise, studying  $R_n$  in this regime helps us understand the rate at which the giant component swallows up the whole vertex set as *r* approaches the connectivity threshold.

Our main results for the uniform case refer to constants  $\mu_n$  defined by

$$
\mu_n := n e^{-n \theta r_n^d / \lambda(A)} + \theta_{d-1}^{-1} |\partial A| r_n^{1-d} e^{-n \theta r_n^d / (2\lambda(A))} \mathbf{1} \{ d \ge 3 \},\tag{1.4}
$$

where *∂A* denotes the topological boundary of *A* and |*∂A*| denotes the (*d*−1)-dimensional Hausdorff measure of  $\partial A$ . We say A has a  $C^2$  boundary (for short,  $\partial A \in C^2$ ) if for each  $x \in \partial A$  there exists a neighbourhood *U* of *x* and a real-valued function  $\phi$  that is defined on an open set in  $\mathbb{R}^{d-1}$  and twice continuously differentiable, such that  $\partial A \cap U$ , after a rotation, is the graph of the function  $\phi$ .

We can now present our main results for the uniform case. In all of our results we assume either that  $d = 2$  and  $A = [0, 1]^2$ , or that  $d \geq 2$  and  $A \subset \mathbb{R}^d$  is compact and connected, and *A* is the closure of its interior (for short:  $A = \overline{A^o}$ ), with  $\partial A \in C^2$ . Also we assume  $r_n \in (0,\infty)$  is given for all  $n \geq 1$ . Let  $N(0,1)$  denote a standard normal random variable, and for  $t \in (0, \infty)$  let  $Z_t$  be a Poisson random variable with mean t. Let  $\frac{\mathcal{D}}{\longrightarrow}$ , respectively  $\stackrel{L^1}{\longrightarrow}$ , denote convergence in distribution, respectively in the  $L^1$  norm. Define  $\sigma_A := |\partial A|/(\lambda(A)^{1-1/d})$ ; this is sometimes called the *isoperimetric ratio* of *A*.

<span id="page-3-0"></span>**Theorem 1.1** (Basic results for the uniform case). Let  $\xi_n$  denote either  $K_n - 1$  or  $R_n$ , *and let*  $\xi'_n$  *denote either*  $K'_n - 1$  *or*  $R'_n$ .

*(a) Suppose*  $(r_n)_{n\geq 1}$  *satisfy* [\(1.1\)](#page-2-0) *and* [\(1.2\)](#page-2-0)*. Then in the uniform case, as*  $n \to \infty$ *we have the convergence results:*  $\mu_n \to \infty$ , and  $(\xi_n/\mu_n) \stackrel{L^1}{\longrightarrow} 1$ , and  $(\xi'_n/\mu_n) \stackrel{L^1}{\longrightarrow} 1$ . Also  $\mu_n^{-1} \mathbb{V}\ar[\xi_n'] \to 1$ , and  $\mu_n^{-1/2}(\xi_n' - \mathbb{E}[\xi_n']) \xrightarrow{\mathcal{D}} N(0,1)$ . If  $d \geq 3$  then  $\mu_n^{-1} \mathbb{V}\ar[\xi_n] \to 1$ , and  $\mu_n^{-1/2}(\xi_n - \mathbb{E}[\xi_n]) \xrightarrow{\mathcal{D}} N(0, 1).$ 

*(b)* Suppose instead that  $\gamma_n \to \gamma \in \mathbb{R}$  as  $n \to \infty$ . Set  $c_{d,A} := \theta_{d-1}^{-1}(\theta/(2-2/d))^{1-1/d}\sigma_A$ . Then as  $n \to \infty$ ,  $\xi_n \xrightarrow{\mathcal{D}} Z_{e^{-\gamma}}$  if  $d = 2$  and  $\xi_n \xrightarrow{\mathcal{D}} Z_{c_{d,A}e^{-\gamma/2}}$  if  $d \geq 3$ , and likewise for  $\xi'_n$ .

In Section [2](#page-4-0) we shall provide a more detailed version of Theorem [1.1:](#page-3-0) we shall give estimates on the rates of convergence, and also generalize to allow for non-uniformly distributed points in *A*.

To the best of our knowledge, the only previous results on  $K_n$  and  $R_n$  in the mildly dense regime are by Ganesan [\[3\]](#page-52-3) in the special case of  $d = 2$  and  $A = [0, 1]^2$ , where he proved that there exists a constant  $c > 0$  such that as  $n \to \infty$ ,

$$
\mathbb{P}[K_n \leq n e^{-cnr_n^2}] \to 1; \qquad \mathbb{P}[R_n \leq n e^{-cnr_n^2}] \to 1. \tag{1.5}
$$

In other words, the proportionate number of components and the proportionate number of vertices not in the largest component decay exponentially in  $nr_n^2$  but the exact exponent is not identified; Ganesan's proof, while ingenious, does not provide much of a clue as to the optimal value of *c* satisfying  $(1.5)$ , or whether this optimal value is the same for  $K_n$ and for  $R_n$ . Moreover, his proof of the second part of  $(1.5)$  does not appear to generalize to higher dimensions.

One possible reason why the mildly dense limiting regime was not previously well understood is an apparently strong dependence between contributions from different regions of space; one has to look a long way from a given vertex to tell whether it lies in the giant component. A second reason is the importance of boundary effects in this regime and the necessity of dealing with the curved boundary of *A* quantitatively; note the factor of |*∂A*| in the definition of  $\mu_n$  at [\(1.4\)](#page-3-2). Another reason is that in contrast to the thermodynamic regime, it seems not to be possible to re-scale space to obtain a limiting Poisson process to work with, as was often done in previous works on these kinds of limit theorems, for example [\[9\]](#page-52-4). In Section [2.3](#page-8-0) we shall provide an overview of the methods we develop to deal with these issues.

Our results show that the phenomenon of exponential decay is common to all dimensions and more general sets *A*, and we identify the optimal value of *c* in [\(1.5\)](#page-3-1). Furthermore, we prove a central limit theorem (CLT) for the fluctuations of  $K'_n$  and  $R'_n$  (for all  $d \geq 2$ ) and for  $K_n$ ,  $R_n$  (for  $d \geq 3$ ). Our CLT is 'weakly quantitative' in the sense that we provide bounds on the rate of convergence to normal, although our bounds might not be optimal.

We expect that our approach can shed some light on the limiting behaviour of higher dimensional homology, and higher Betti numbers, of random geometric complexes in the mildly dense regime for which the correct scaling is so far not well understood; see the last paragraph of [\[1,](#page-52-1) Section 2.4.1]. This is beyond the scope of this paper and we leave it for future work.

### <span id="page-4-0"></span>**2 Statement of results**

We now describe our setup more precisely. Let  $d \geq 2$  and let  $A \subset \mathbb{R}^d$  be a compact connected set, such that  $A = \overline{A^o}$ , Assume either that  $\partial A \in C^2$  or that  $d = 2$  and  $A = [0, 1]^2$ . Let  $f : \mathbb{R}^d \to [0, \infty)$  be a probability density function with support *A*. We refer to the special case where *f* is constant on *A* as the *uniform case* but in general we allow possibly non-constant *f*. Set  $f_0 := \inf_A f(x)$ ,  $f_1 := \inf_{\partial A} f$ , and  $f_{\max} := \sup_A f(x)$ . We assume throughout that  $f_0 > 0$  and and that f is continuous on A (so in particluar  $f_{\text{max}} < \infty$ ). We use *ν* to denote the measure with density *f*, i.e.  $\nu(dx) = f(x)dx$ . Clearly in the uniform case  $f_0 = \lambda(A)^{-1}$ .

Let  $(X_1, X_2, \ldots)$  be a sequence of independent random vectors in  $\mathbb{R}^d$  with common density *f*, and for  $n \in \mathbb{N}$  set  $\mathcal{X}_n := \{X_1, \ldots, X_n\}$ , which is a binomial point process. Also let  $(Z_t)_{t>0}$  be a unit intensity Poisson counting process, independent of  $(X_1, X_2, \ldots)$ , so that for  $n \in [1, \infty)$ ,  $Z_n$  is a Poisson random variable with mean *n*, and set  $\mathcal{P}_n := \mathcal{X}_{Z_n}$ . Then  $P_n$  is a Poisson point process with intensity measure  $n\nu$ . We use *n* to denote both the number of points in  $\mathcal{X}_n$  and the average number of points in a Poisson sample  $\mathcal{P}_n$  with the convention that  $n \in [1,\infty)$  in the latter case.

We are concerned with the quantities  $K_n := K(G(\mathcal{X}_n, r_n))$  and  $R_n := R(G(\mathcal{X}_n, r_n))$ and their Poisson counterparts  $K'_n := K(G(\mathcal{P}_n, r_n))$  and  $R'_n := R(G(\mathcal{P}_n, r_n))$ , with  $r_n \in$  $(0, \infty)$  specified for each *n*.

Given  $g : (0, \infty) \to \mathbb{R}$ , and  $h : (0, \infty) \to (0, \infty)$ , we write  $g(x) = O(h(x))$  if lim sup  $|q(x)|/h(x) < \infty$ , and write  $q(x) = o(h(x))$  if  $\limsup |q(x)|/h(x) = 0$ ,  $q(x) =$  $\Omega(h(x))$  if lim inf $(g(x)/h(x)) > 0$ . We write  $g(x) = \Theta(h(x))$  if both  $g(x) = O(h(x))$  and  $g(x) = \Omega(h(x))$ , and  $g(x) \sim h(x)$  if  $\lim(g(x)/h(x)) = 1$ . Here, the limit is taken either as  $x \to 0$  or  $x \to \infty$  to be specified in each appearance.

To present quantitative CLTs, we recall that for random variables *X, Y* , the Kolmogorov distance  $d_K$  and the total variation distance  $d_{TV}$  between them are defined respectively by

$$
d_{\mathrm K}(X,Y):=\sup_{z\in\mathbb R}|\mathbb P[X\leq z]-\mathbb P[Y\leq z]|;\quad d_{\mathrm {TV}}(X,Y):=\sup_{A\in\mathcal B(\mathbb R)}|\mathbb P[X\in A]-\mathbb P[Y\in A]|,
$$

where the second supremum is taken over all Borel measurable subsets of R. Note that convergence in the Kolmogorov distance implies convergence in distribution.

#### <span id="page-5-0"></span>**2.1 Results for general** *f*

We now give our results for the component count and the number of vertices not in the giant component in the general case with *f* not assumed necessarily to be constant on *A*. For general f, instead of  $\mu_n$  defined at [\(1.4\)](#page-3-2), our results refer to constants  $I_n$  defined by

$$
I_n := n \int_A \exp(-n\nu(B_{r_n}(x))) \nu(dx).
$$
\n(2.1)

We define the *critical regime for connectivity* to be when  $r_n$  is chosen so that  $I_n = \Theta(1)$ as  $n \to \infty$ , and the *mildly dense* regime to be when  $r_n$  is chosen so that [\(1.1\)](#page-2-0) holds but also  $I_n \to \infty$  as  $n \to \infty$ . As discussed later in Remark [2.9,](#page-8-1) The latter condition turns out to be equivalent to [\(1.2\)](#page-2-0) in the uniform case.

<span id="page-5-1"></span>**Theorem 2.1** (First order moment asympototics for general *f*)**.** *Suppose f is continuous on A with*  $f_0 > 0$ *, and that*  $r_n$  *satisfies* [\(1.1\)](#page-2-0) *and also*  $I_n \to \infty$  *as*  $n \to \infty$ *. Let*  $\xi_n$  *denote* any of  $K_n-1$ ,  $R_n$ ,  $K'_n-1$  or  $R'_n$ , and let  $\zeta_n$  be either  $\xi_n$  or  $\xi_n+1$ . Then as  $n \to \infty$  we *have*

$$
\mathbb{E}[\xi_n] = I_n(1 + O((nr_n^d)^{1-d}));\tag{2.2}
$$

$$
\mathbb{E}[|(\zeta_n/I_n) - 1|] = O((nr_n^d)^{1-d} + I_n^{-1/2}).\tag{2.3}
$$

*In particular*  $(\zeta_n/I_n) \xrightarrow{L^1} 1$ .

We can use the  $L^1$  convergence in Theorem [2.1,](#page-5-1) together with an asymptotic analysis of  $I_n$ , to determine the optimal exponent c in Ganesan's result [\(1.5\)](#page-3-1). First we introduce some further notation. Given  $(r_n)_{n\geq 1}$  we define

$$
b^+ := \limsup_{n \to \infty} (n \theta r_n^d / \log n); \qquad b^- := \liminf_{n \to \infty} (n \theta r_n^d / \log n). \tag{2.4}
$$

and  $b := b^+ = b^-$  whenever  $b^+ = b^-$ . Loosely speaking, *b* is the logarithmic growth rate of the degree of a typical vertex, at least in the uniform case with  $\lambda(A) = 1$ . We identify two critical values for *b*, namely

$$
b_c := \max\left(\frac{1}{f_0}, \frac{2 - 2/d}{f_1}\right); \qquad b'_c := \begin{cases} (d(f_0 - f_1/2))^{-1} & \text{if } f_0 > f_1/2; \\ +\infty & \text{if } f_0 \le f_1/2 \end{cases} \tag{2.5}
$$

(so in the uniform case  $b_c = (2 - 2/d)/f_0$  and  $b_c' = 2/(df_0)$ , and hence  $b_c' < b_c$  if  $d \ge 3$ ). The following result shows *b<sup>c</sup>* is the critical value of the logarithmic growth rate *b* above which  $I_n \to 0$ , and below which  $I_n \to \infty$ .

<span id="page-6-4"></span>**Proposition 2.2.** *If*  $b^+ < b_c$  *then*  $I_n \to \infty$  *as*  $n \to \infty$ *. Conversely, if*  $b^- > b_c$  *then*  $I_n \to 0$  *as*  $n \to \infty$ *, and if* lim  $\inf_{n \to \infty} I_n > 0$  *then*  $b^+ \leq b_c$ *.* 

The next result arises from the fact that for  $b < b'$  the main contribution to  $I_n$ , and hence to  $K_n$  or  $R_n$ , comes from the interior of A, while for  $b'_c < b < b_c$  the main contribution to  $I_n$  comes from near the boundary of *A*. Given random variables  $(Y_n)_{n\geq 1}$ we write  $Y_n = o_{\mathbb{P}}(1)$  to mean  $Y_n \to 0$  in probability as  $n \to \infty$ .

<span id="page-6-2"></span>**Theorem 2.3.** *Under the conditions of Theorem [2.1,](#page-5-1) as*  $n \to \infty$  *we have* 

$$
\zeta_n = n \exp(-\theta f_0 n r_n^d (1 + o_\mathbb{P}(1))) \qquad \qquad \text{if} \quad b^+ \le b_c'; \qquad (2.6)
$$

$$
\zeta_n = n^{1-1/d} \exp\left(-\theta f_1 n r_n^d \left(\frac{1}{2} + o_{\mathbb{P}}(1)\right)\right) \qquad \qquad \text{if} \quad b^- \ge b_c'.
$$
 (2.7)

*In particular, if*  $b^+ = b^- = b$  *then*  $\zeta_n = n^{1 - \min(f_0 b, (1/d) + f_1 b/2) + o_P(1)}$ .

If  $d = 2$  then since  $f_1 \ge f_0$  we have  $d(f_0 - f_1/2) \le f_0$  and  $b'_c \ge f_0^{-1} = b_c$ . Thus, if  $nr_n^2 \to \infty$  and  $I_n \to \infty$ , then [\(2.6\)](#page-6-0) applies and Ganesan's result [\(1.5\)](#page-3-1) for  $A = [0, 1]^2$  holds whenever  $c < \pi f_0$ , and fails whenever  $c > \pi f_0$  (in the latter case the probabilities in [\(1.5\)](#page-3-1) tend to zero). A similar remark holds when  $d \geq 3$ , provided also  $b^+ < b'_c$ .

Next we give distributional results. The first one says that in the critical regime for connectivity, both  $K_n - 1$  and  $R_n$  (along with  $K'_n - 1$  and  $R'_n$ ) are asymptotically Poisson.

<span id="page-6-1"></span>**Theorem 2.4** (Poisson convergence in the connectivity regime for general *f*)**.** *Suppose f is continuous on A with*  $f_0 > 0$ *, and suppose that*  $I_n = \Theta(1)$  *as*  $n \to \infty$ *. Let*  $\xi_n$  *denote ay* of  $K_n-1$ ,  $R_n K'_n-1$  or  $R'_n$ . Then  $d_{TV}(\xi_n, Z_{I_n}) = O((\log n)^{1-d})$  as  $n \to \infty$ . In particular, *if*  $\lim_{n\to\infty} I_n = c$  *for some*  $c \in (0,\infty)$ *, then*  $\xi_n \xrightarrow{\mathcal{D}} Z_c$  *as*  $n \to \infty$ *.* 

Our next result demonstrates asymptotic normality of  $K'_n$  and of  $R'_n$  for  $d \geq 2$ , and of  $K_n$  and  $R_n$  for  $d \geq 3$ , in the whole of the mildly dense limiting regime for *r*.

Let*  $\xi_n$  *denote either*  $K_n - 1$  *or*  $R_n$ ; let  $\xi'_n$  denote either  $K'_n - 1$  *or*  $R'_n$ . Then as  $n \to \infty$  we have

- *Remark* 2.6. 1. In view of Theorem [2.4,](#page-6-1) our limiting regime for  $r_n$  for Theorems [2.1,](#page-5-1) [2.3](#page-6-2) and [2.5](#page-6-3) (namely,  $nr_n^d \to \infty$  and  $I_n \to \infty$ ) covers the whole range of limiting regimes between the thermodynamic regime and the critical regime for connectivity.
	- 2. We can often simplify the expression  $(1.4)$  for  $\mu_n$  depending on the logarithmic growth rate of  $nr_n^d$ . Indeed, if  $d = 2$  or  $b^+ f_0 < 2/d$  then  $\mu_n \sim n e^{-n\theta f_0 r_n^d}$ , and if  $d \geq 3$ and  $b^- f_0 > 2/d$  then  $\mu_n \sim \theta_{d-1}^{-1} |\partial A| r_n^{1-d} e^{-n\theta f_0 r_n^d/2}$ .

#### <span id="page-7-0"></span>**2.2 Results for the uniform case**

In the uniform case, we can replace  $I_n$  with the quantity  $\mu_n$  defined at [\(1.4\)](#page-3-2). Indeed, in Propositions [4.7](#page-22-0) and [4.8](#page-22-1) we shall show that in the uniform case,  $I_n = \mu_n(1+O((nr_n^2)^{-1/2}))$ as  $n \to \infty$  if  $d = 2$  and  $I_n = \mu_n \left(1 + O\left(\frac{\log(nr_n^d)}{n^d}\right)\right)$  $nr_n^d$  $\binom{2}{1}$  as  $n \to \infty$  if  $d \geq 3$ . Therefore in the convergence results arising from Theorems [2.1,](#page-5-1) [2.4](#page-6-1) and [2.5](#page-6-3) we can replace  $I_n$  with  $\mu_n$ ; this gives us Theorem [1.1.](#page-3-0) The more quantitative versions of the results in Theorem [1.1,](#page-3-0) where we keep track of rates of convergence, go as follows.

Let  $\xi_n$  denote any of  $K_n - 1$ ,  $R_n$ ,  $K'_n - 1$  or  $R'_n$ , define  $\gamma_n$  as at [\(1.2\)](#page-2-0) and define  $\mu_n$  *by* [\(1.4\)](#page-3-2).

(a) If  $(r_n)_{n\geq 1}$  satisfies  $|\gamma_n| = O(1)$  as  $n \to \infty$ , then  $d_{TV}(\xi_n, Z_{\mu_n}) = O((\log n)^{-1/2})$  if  $d = 2$  *and*  $d_{\text{TV}}(\xi_n, Z_{\mu_n}) = O\left(\frac{\log \log n}{\log n}\right)$  $\frac{\log \log n}{\log n}$ <sup>2</sup> *if*  $d \geq 3$ *.* 

*(b)* If  $\gamma_n \to \gamma \in \mathbb{R}$  as  $n \to \infty$ , then as  $n \to \infty$ ,  $\xi_n \xrightarrow{\mathcal{D}} Z_{e^{-\gamma}}$  if  $d = 2$  and  $\xi_n \stackrel{\mathcal{D}}{\longrightarrow} Z_{c_{d,A}e^{-\gamma/2}}$  if  $d \geq 3$ , where we set  $c_{d,A} := \theta_{d-1}^{-1}(\theta/(2-2/d))^{1-1/d}\sigma_A$  and  $\sigma_A :=$  $|\partial A|/(\lambda(A)^{1-1/d})$ .

*(c)* Suppose [\(1.1\)](#page-2-0) and [\(1.2\)](#page-2-0) hold. If  $d = 2$  then as  $n \to \infty$ :

<span id="page-8-1"></span>*Remark* 2.9. 1. In the uniform case, we have  $f_0 = f_1$  and  $b_c = (2 - 2/d)/f_0$ .

- 2. From Theorem [2.7](#page-7-1) we see for the uniform case that in the whole of the mildly dense regime both  $K_n$  and  $R_n$  scale like  $\mu_n$  (and if  $d = 2$  or  $f_0 b^+ < 2/d$ , like  $n \exp(-n f_0 \theta r_n^d)$  in probability, rather than like a constant times *n* as given by [\(1.3\)](#page-2-1) in the thermodnamic regime.
- 3. In the uniform case, if  $nr_n^d \to \infty$  and  $\limsup \gamma_n < \infty$ , then by Propositions [4.7](#page-22-0) and [4.8,](#page-22-1)  $I_n \sim \mu_n$  as  $n \to \infty$ . Hence by [\(5.25\)](#page-36-0), if  $\gamma_n \to \gamma \in \mathbb{R}$  as  $n \to \infty$ , then  $I_n \to e^{-\gamma}$ if  $d = 2$  and  $I_n \to c_{d,A}e^{-\gamma/2}$  if  $d \geq 3$ . Using this and the fact that  $I_n$  is decreasing in *r*<sub>*n*</sub> while  $\gamma_n$  is increasing in *r*<sub>*n*</sub> we can deduce that  $\gamma_n \to -\infty$  if and only if  $I_n \to \infty$ , as claimed earlier.

### <span id="page-8-0"></span>**2.3 Overview of proofs**

The main insight behind our results is that the dominant contribution both for  $K_n - 1$ and for  $R_n$  comes from the singletons, i.e. the isolated vertices. Let  $S_n$ , respectively  $S'_n$ , denote the number of singletons of  $G(\mathcal{X}_n, r)$ , resp.  $G(\mathcal{P}_n, r_n)$ . Our starting point for a proof of Theorem [2.5](#page-6-3) is a similar collection of results for  $S_n$  and  $S'_n$ , of interest in their own right, which go as follows:

<span id="page-8-2"></span>**Proposition 2.10** (Results on singletons). Suppose f is continuous on A with  $f_0 > 0$ , *and that*  $r_n$  *satisfies* [\(1.1\)](#page-2-0) *and also*  $I_n \to \infty$  *as*  $n \to \infty$ *. Let*  $\zeta_n$  *be either*  $S_n$  *or*  $S'_n$ *. Then there exists*  $\delta > 0$  *such that as*  $n \to \infty$  *we have*  $\mathbb{E}[\zeta_n] = I_n(1 + O(e^{-\delta n r_n^d}))$ *, and*  $\mathbb{V}\text{ar}[\zeta_n] = I_n(1 + O(e^{-\delta nr_n^d}))$ *, and also*

Proposition [2.10](#page-8-2) extends results in [\[12\]](#page-52-5), where the same conclusions are derived under the extra condition  $b^+ < 1/\max(f_0, d(f_0 - f_1/2))$  rather than the weaker condition  $I_n \to \infty$ that we consider here.

To get from Proposition [2.10](#page-8-2) to Theorem [2.5,](#page-6-3) let  $\xi_n$  be either  $K_n - 1$  or  $R_n$  and  $\xi'_n$ be either  $K'_n$  or  $R'_n$ . We show that both the mean and the variance of both  $\xi_n - S_n$  and

 $\xi_n' - S_n'$ , are asymptotically negligible relative to  $I_n$ . To do this we deal separately with the contribution to  $\xi_n - S_n$  or  $\xi'_n - S'_n$  from components with Euclidean diameters that categorized as 'small', 'medium' or 'large' compared to *rn*, using different arguments for the three different categories. This requires us to deal with a lot of different cases, as a result of which Section [6,](#page-37-0) containing the second moment estimates, is quite long (the proofs of the first order results can be read without referring to that section). Once we have the moment estimates, we can derive the 'quantitative' CLT for  $\xi_n$  or  $\xi'_n$  from the one for  $S_n$  or  $S'_n$  by using a quantitative version of Slutsky's theorem.

Our argument for small components has geometrical ingredients (presented in Section [3.1\)](#page-10-0) and takes boundary effects into account. The argument for large components involves discretization and path-counting arguments seen in continuum percolation theory. The argument for medium-sized components involves both geometry and discretization.

To derive our results with more explicit constants in the uniform case (Theorems [2.7](#page-7-1) and [2.8\)](#page-7-2) we need to demonstrate asymptotic equivalence of  $I_n$  and  $\mu_n$ . This can be done by adapting the method of polytopal approximation that was recently used for related problems in [\[4\]](#page-52-6), [\[10\]](#page-52-7) and [\[11\]](#page-52-2). We do this in Section [4.3.](#page-21-1)

The rest of the paper is organised as follows. After some preliminary lemmas in Section [3,](#page-9-0) in Section [4](#page-17-0) we give an asymptotic analysis of  $S_n$  and  $S'_n$ , and of of  $I_n$ , in particular proving Propositions [2.2](#page-6-4) and [2.10.](#page-8-2)

In Section [5](#page-28-0) we give estimates of  $\mathbb{E}[\zeta_n - S_n]$  and  $\mathbb{E}[\zeta'_n - S'_n]$ , where  $\zeta_n$  is either  $K_n - 1$ or  $R_n$ , and  $\zeta'_n$  is either  $K'_n - 1$  or  $R'_n$ , where  $\zeta_n$  is either  $K_n - 1$ , and then conclude the proof of Theorems [2.1,](#page-5-1) [2.3](#page-6-2) and [2.4.](#page-6-1) In Section [6](#page-37-0) we complete the proof of Theorems [2.5](#page-6-3) and [2.8.](#page-7-2)

## <span id="page-9-0"></span>**3 Preliminaries**

Throughout the rest of this paper we assume that the density  $f$  of the measure  $\nu$  is supported by a compact set  $A \subset \mathbb{R}^d$  with  $f_0 := \inf_A f > 0$ , and that *f* is continuous on *A*, so that  $f_{\text{max}} := \sup_A f$  is finite. Moreover we assume either that  $d = 2$  and  $A = [0, 1]^2$ , or that  $d \geq 2$  and  $A \subset \mathbb{R}^d$  is compact and connected with  $A = \overline{A^o}$  and  $\partial A \in C^2$ . Also we assume  $r_n \in (0, \infty)$  is given for all  $n \geq 1$ .

Given  $D, D' \subset \mathbb{R}^d$ , we set  $D \oplus D' := \{x + y : x \in D, y \in D'\}$ , the Minkowski sum of *D* and *D'*. Also let *D*<sup>*o*</sup> denote the interior of *D*. Let *o* denote the origin in  $\mathbb{R}^d$ . Let  $\|\cdot\|$ denote the Euclidean norm on  $\mathbb{R}^d$ . Given  $a > 0$  we set  $aD := \{ax : x \in D\}$ . Also we set *D*<sup> $(-a)$ </sup> := {*x* ∈ *D* : *B*(*x, a*) ⊂ *D*}. Given *n* ∈ N, we write [*n*] for the set {1, ..., *n*}.

We introduce an ordering  $\prec$  on *A*: for  $x, y \in A$ , if  $\partial A \in C^2$  we say  $x \prec y$  if either  $dist(x, \partial A) <$  dist $(y, \partial A)$  (using the Euclidean distance) or dist $(x, \partial A) = dist(y, \partial A)$  and *x* precedes *y* (strictly) in the lexicographic ordering. If  $A = [0, 1]^2$  we say  $x \prec y$  if the  $\ell_1$  distance from x to the nearest corner of A is less than that of y, or if these two distances are equal and *x* precedes *y* lexicographically. In either case, given  $x \in A$  we write  $A_x := \{y \in A : x \prec y\}.$ 

For non-empty  $U \subset \mathbb{R}^d$  set diam $(U) := \sup_{x,y \in U} {\{\Vert x - y \Vert\}}$ , and let  $\#(U)$  denote the number of elements of *U*.

#### <span id="page-10-0"></span>**3.1 Geometrical tools**

<span id="page-10-3"></span>**Lemma 3.1.** *There exist*  $\delta_1 > 0$  *and*  $s_0 > 0$  *depending on d and A such that* if  $s \in (0, s_0)$ *and*  $x, y \in A$  *with*  $x \prec y$ *, then*

*and if*  $\partial A \in C^2$  *then* [\(3.1\)](#page-10-1) *still holds if we drop the condition*  $x \prec y$ *.* 

Note that when  $A = [0, 1]^2$  we do require  $x \prec y$  for [\(3.1\)](#page-10-1); othewise *y* could be 'jammed into a corner' of *A*, for example when *x* is near  $(2^{-1/2}s, 2^{-1/2}s)$ .

*Proof.* Note first that it suffices to prove the second inequality [\(3.2\)](#page-10-2) for  $||y-x|| \leq s$ , since it can be proved in the case  $s \le ||x - y|| \le 3s$  by using the first inequality [\(3.1\)](#page-10-1) and changing  $\delta_1$ .

In the case with  $\partial A \in C^2$ , [\(3.1\)](#page-10-1) comes from [\[12,](#page-52-5) Lemma 5.9], which does not require the condition  $x \prec y$ , while [\(3.2\)](#page-10-2) comes from [\[4,](#page-52-6) Lemma 3.2].

Now suppose  $A = [0, 1]^2$ . Without loss of generality, the nearest corner of A to x is the origin. Writing  $x = (x_1, x_2)$  and  $y = (y_1, y_2)$ , assume also without loss of generality that  $x_2 \leq y_2$ . Also assume  $y_1 \leq x_1$  (otherwise [\(3.1\)](#page-10-1) and [\(3.2\)](#page-10-2) are easy to see).

If  $||y - x|| \geq s$  then  $y_2 \geq x_2 + 2^{-1/2}s$  (otherwise the condition  $x \prec y$  fails). Then the ball of radius 0*.*05*s* centred on  $(y_1 + 0.05s, y_2 + 0.8s)$  is contained in  $A \cap B_s(y) \setminus B_s(x)$ , and [\(3.1\)](#page-10-1) follows for this case.

For [\(3.2\)](#page-10-2), we assume without loss of generality that  $||y-x|| \leq s$ . Consider the segment *S* of  $B(x, s)$  that is cut off from  $B(x, s)$  by the line parallel to [x, y] and at a distance  $2^{-1/2}s$  from *x*, away from the origin. Then as illustrated in Figure [1,](#page-11-1)  $S \oplus \{y-x\} \subset A$ , and by Fubini's theorem there is a constant  $\delta_1 > 0$  such that  $\lambda((S \oplus \{y-x\}) \setminus S) \geq 2\delta_1 s \|y-x\|$ .  $\Box$ 

<span id="page-10-7"></span>**Lemma 3.2.** *Let*  $0 < \varepsilon < K < \infty$ *. Then there exists*  $\delta_2 = \delta_2(\varepsilon, K)$ *, s<sub>0</sub> > 0 depending on*  $\varepsilon$ , *K*, *d* and *A*, such that for all  $s \in (0, s_0)$  and all compact  $B \subset A$  with diam  $B \in [\varepsilon s, Ks]$ *and*  $x_0$  ∈ *B with*  $x_0$   $\prec$  *y for all*  $y$  ∈ *B, we have*

*Proof.* In the case with  $\partial A \in C^2$ , we can use [\[11,](#page-52-2) Lemma 2.5].

If instead  $d = 2$  and  $A = [0, 1]^2$ , we can argue similarly for *x* not close to any corner of *A*. In the other case we can use [\[7,](#page-52-0) Proposition 5.15].  $\Box$

*Proof.* See e.g. [\[7,](#page-52-0) Lemmas 1.1, 1.2 and 1.4].

Let  $\mathbf{N}(\mathbb{R}^d)$  be the space of all finite subsets of  $\mathbb{R}^d$ , equipped with the smallest  $\sigma$ algebra  $\mathcal{S}(\mathbb{R}^d)$  containing the sets  $\{\mathcal{X} \in \mathbb{N}(\mathbb{R}^d) : |\mathcal{X} \cap B| = m\}$  for all Borel  $B \subset \mathbb{R}^d$  and all  $m \in \mathbb{N} \cup \{0\}$ . Given  $F : \mathbf{N}(\mathbb{R}^d) \to \mathbb{R}$  and  $x \in \mathbb{R}^d$ , define the *add-one cost*  $D_x F(\mathcal{X}) :=$  $F(\mathcal{X} \cup \{x\}) - F(\mathcal{X})$  for all  $\mathcal{X} \in \mathbb{N}(\mathbb{R}^d)$ . Also define  $D^+F(\mathcal{X}) := \max(D_x F(\mathcal{X}), 0)$  and  $D^{-}F(\mathcal{X}) := \max(-D_{x}F(\mathcal{X}), 0)$ , the positive and negative parts of  $D_{x}F(\mathcal{X})$ .

<span id="page-11-5"></span>**Lemma 3.5** (Poincaré and Efron-Stein inequalities). Suppose  $F : \mathbb{N}(\mathbb{R}^d) \to \mathbb{R}$  is mea*surable and*  $n > 0$ *. If*  $\mathbb{E}[F(\mathcal{P}_n)^2] < \infty$  *then* 

$$
\mathbb{V}\text{ar}[F(\mathcal{P}_n)] \le n \int_A \mathbb{E}[|D_x F(\mathcal{P}_n)|^2] \nu(dx).

*Also, if*  $n \in \mathbb{N}$  *and*  $\mathbb{E}[F(\mathcal{X}_n)^2] < \infty$  *then* 

$$
\mathbb{V}\text{ar}[F(\mathcal{X}_n)] \le n \int_A \mathbb{E}[|D_x F(\mathcal{X}_{n-1})|^2] \nu(dx). \tag{3.7}
$$

*Proof.* The first assertion [\(3.6\)](#page-11-2) is the Poincaré inequality [\[5,](#page-52-8) Theorem 18.7]. For the second assertion [\(3.7\)](#page-11-3), we use Efron and Stein's jackknife estimate for the variance of functions of iid random variables. Let  $\tilde{F}_n : \mathbb{R}^{dn} \to \mathbb{R}$  be given by  $\tilde{F}_n((x_1, \ldots, x_n)) = F(\lbrace x_1, \ldots, x_n \rbrace)$ for all  $x_1, \ldots, x_n \in \mathbb{R}$ . Then  $\tilde{F}_n$  is measurable. The Efron-Stein inequality (see e.g. [\[2\]](#page-52-9)) says that

$$
\mathbb{V}\text{ar}[\tilde{F}_n(\mathbf{X}_n)] \leq \frac{1}{2} \sum_{i=1}^n \mathbb{E}[(\tilde{F}_n(\mathbf{X}_n) - \tilde{F}_n(\mathbf{X}_{n+1}^{(i)}))^2]
$$
(3.8)

where  $\mathbf{X}_n := (X_1, \ldots, X_n)$  and  $\mathbf{X}_n^{(i)} := (X_1, \ldots, X_{i-1}, X_{i+1}, \ldots, X_n)$ .

We write  $\tilde{F}_n(\mathbf{X}_n) - \tilde{F}_n(\mathbf{X}_{n+1}^{(i)}) = \tilde{F}_n(\mathbf{X}_n) - \tilde{F}_{n-1}(\mathbf{X}_n^{(i)}) - (\tilde{F}_n(\mathbf{X}_{n+1}^{(i)}) - \tilde{F}_{n-1}(\mathbf{X}_n^{(i)})).$  By the bound  $(a + b)^2 \leq 2a^2 + 2b^2$  (which comes from Jensen's inequality), and [\(3.8\)](#page-12-1), and the exchangeability of  $(X_1, \ldots, X_{n+1}),$ 

$$
\mathbb{V}\text{ar}(F(\mathcal{X}_n)) = \mathbb{V}\text{ar}[\tilde{F}_n(\mathbf{X}_n)] \leq n \mathbb{E}[(\tilde{F}_n(\mathbf{X}_n) - \tilde{F}_{n-1}(\mathbf{X}_{n-1}))^2],
$$

and [\(3.7\)](#page-11-3) follows.

<span id="page-12-2"></span>**Lemma 3.6** (Quantitative version of Slutsky's theorem)**.** *Suppose X and Y are random variables on the same probability space with*  $\mathbb{E}[Y] = 0$  *and*  $\mathbb{V}\text{ar}[Y] < \infty$ *. Then*  $d_K(X +$  $Y, N(0, 1) \leq 3(d_K(X, N(0, 1)) + (\text{Var}[Y])^{1/3}).$ 

*Proof.* Let  $t \in \mathbb{R}$  and set  $a := (\mathbb{V}ar[Y])^{1/3}$ . Then by the union bound and Chebyshev's inequality

|\mathbb{P}[X + Y \le t] - \mathbb{P}[X \le t]| \le \mathbb{P}[\{X + Y \le t\} \triangle \{X \le t\}]

\le \mathbb{P}[t - a < N(0, 1) \le t + a] + 2d_K(X, N(0, 1)) + a^{-2}\mathbb{V}\text{ar}[Y]

\le 3a + 2d_K(X, N(0, 1)),
$$

and the result follows.

#### <span id="page-12-0"></span>**3.3 Percolation type estimates**

For finite  $\mathcal{X} \subset \mathbb{R}^d$ , and  $x \in \mathcal{X}$  and  $s > 0$ , let  $\mathcal{C}_s(x, \mathcal{X})$  denote the vertex set of the component of  $G(\mathcal{X}, s)$  containing x, and  $|\mathcal{C}_s(x, \mathcal{X})|$  the number of elements of  $\mathcal{C}_s(x, \mathcal{X})$ (i.e. the order of this component).

To prove our theorems, we shall need to establish uniqueness of the giant component in  $G(\mathcal{X}_n,r)$  or  $G(\mathcal{P}_n,r)$  (with  $r=r(n)$ ). The next two lemmas help do this, and are proved using discretization and path-counting (Peierls) arguments of the sort used in the theory of continuum percolation.

The first lemma says that if  $nr_n^d \to \infty$  as  $n \to \infty$ , the existence of two components of diameter drastically larger than *r<sup>n</sup>* is extremely unlikely for *n* large. Throughout, the diameter of a component means the Euclidean (rather than graph-theoretic) diameter of its set of vertices.

Bounds of this sort also arise in the study of connectivity thresholds (which concerns the regime with  $I_n \to c \in (0,\infty)$ ; see for instance [\[8,](#page-52-10) Proposition 3.2]. In the proof, we shall invoke a topological lemma from [\[8\]](#page-52-10).

<span id="page-13-4"></span>**Lemma 3.7** (Uniqueness of the large component). Suppose  $(r_n)_{n\geq 1}$  satisfies  $nr_n^d \to \infty$ *as*  $n \to \infty$ *. Let*  $\phi_n$  *be given with*  $\phi_n \geq \log n$  *for all*  $n \geq 1$  *and assume*  $\phi_n r_n \to 0$  $as n \to \infty$ . Let  $\mathscr{U}_n$ , respectively  $\tilde{\mathscr{U}}_n$ , denote the event that there exists at most one *component of*  $G(\mathcal{P}_n, r_n)$  *(respectively*  $G(\mathcal{X}_n, r_n)$ *) with diameter larger than*  $\phi_n r_n$ *. Then there exists*  $c > 0$  *depending only on d, A and f such that for all n large enough,*

\mathbb{P}[\mathscr{U}_n^c] \le \exp(-c\phi_n nr_n^d); \qquad \mathbb{P}[\tilde{\mathscr{U}}_n^c] \le \exp(-c\phi_n nr_n^d). \tag{3.9}
$$

*Proof.* First assume that  $\partial A \in C^2$ . Let  $\varepsilon = 1/(99\sqrt{d})$ . Given *n*, partition  $\mathbb{R}^d$  into cubes  $(Q_{n,i})$  of side length  $\varepsilon r_n$  indexed by  $\mathbb{Z}^d$ . To be definite, for  $i = (i_1, \ldots, i_d) \in \mathbb{Z}^d$ , set  $Q_{n,i} := \prod_{k=1}^d ((i_k - 1)\varepsilon r_n, i_k \varepsilon r_n]$ . We say a set  $\sigma \subset \mathbb{Z}^d$  is  $*$ -connected if the closure of the union of cubes  $Q_{n,i}$ ,  $i \in \sigma$  is connected. By the deterministic topological lemma [\[8,](#page-52-10) Lemma 3.5, there exist  $\alpha, \alpha' > 0, n_1 \in \mathbb{N}$  such that for all  $n \geq n_1$  and for any finite  $\mathcal{X} \subset A$ , if *U* and *V* are the vertex sets of two components of  $G(\mathcal{X}, r_n)$ , then there exists a  $\ast$ -connected set  $\sigma \subset \mathbb{Z}^d$  enjoying the following properties:

- i)  $\mathcal{X} \cap (\cup_{i \in \sigma} Q_{n,i}) = \varnothing;$
- ii)  $|\{i \in \sigma : Q_{n,i} \subset A\}| \geq \alpha \#(\sigma);$
- iii)  $\varepsilon r_n \#(\sigma) \ge \min(d^{-1/2} \operatorname{diam}(U), d^{-1/2} \operatorname{diam}(V), \alpha').$

In (iii), the factor of  $d^{-1/2}$  arises because if diam<sub>∞</sub> denotes diameter in the  $\ell_{\infty}$  sense (as used in [\[8\]](#page-52-10)) then diam<sub>∞</sub>(·)  $\geq d^{-1/2}$  diam(·).

We shall apply this lemma to  $C_1$  and  $C_2$  which we define to be the vertex sets of the largest and second-largest component (in terms of Euclidean diameter) of  $G(\mathcal{P}_n, r_n)$ , with diameter  $\ell_1, \ell_2$  respectively (so  $\ell_1 > \ell_2$ ).

For  $n > 0, k \in \mathbb{N}$ , define

$$
\mathcal{K}_{n,k,\alpha} := \{ \sigma \subset \mathbb{Z}^d : \#(\sigma) = k, \sigma \text{ is *-connected}, \# \{ i \in \sigma : Q_{n,i} \subset A \} \ge \alpha k \},\qquad(3.10)
$$

and define the events

$$
\mathscr{G}_{n,k} := \bigcup_{\sigma \in \mathcal{K}_{n,k,\alpha}} \{ \mathcal{P}_n \cap (\bigcup_{i \in \sigma} Q_{n,i}) = \varnothing \}; \quad \tilde{\mathscr{G}}_{n,k} := \bigcup_{\sigma \in \mathcal{K}_{n,k,\alpha}} \{ \mathcal{X}_n \cap (\bigcup_{i \in \sigma} Q_{n,i}) = \varnothing \}.
$$
\n(3.11)

If event  $\mathscr{U}_n^c$  occurs, then  $\ell_2 \geq r_n \phi_n$ , so by the lemma,  $\mathscr{G}_{n,k}$  occurs for some  $k \geq$  $\varepsilon^{-1}d^{-1/2}\phi_n \geq \phi_n$ . By a Peierls argument (e.g. [\[7,](#page-52-0) Lemma 9.3]) there exists  $c = c(d, A) > 0$ such that the family of \*-connected sets  $\sigma \subset \mathbb{Z}^d$  with  $\#(\sigma) = k$  and with  $Q_{n,i} \cap A \neq \emptyset$ for some  $i \in \sigma$  has cardinality at most  $cr_n^{-d}e^{ck}$ , which is at most  $ne^{ck}$ , provided *n* is large enough, by the condition  $nr_n^d \to \infty$ . Thus by the union bound, for *n* large enough we have

\mathbb{P}[\mathcal{G}_{n,k}^c] \le n \exp(ck - k\alpha n f_0(\varepsilon r_n)^d) \le n \exp(-(\alpha f_0 \varepsilon^d / 2) k n r_n^d),\tag{3.12}
$$

where we used that  $nr_n^d \to \infty$  again for the last inequality. The same bound holds for  $\tilde{\mathscr{G}}_{n,k}$ , since the probability of a binomial random quantity taking the value zero is bounded above by the corresponding probability for a Poisson random quantity with the same mean.

By [\(3.12\)](#page-13-0), for *n* large enough

$$
\mathbb{P}[\mathscr{U}_n^c] \le \sum_{k \ge \phi_n} \mathbb{P}[\mathscr{G}_{n,k}] \le 2n \exp(-(\alpha f_0 \varepsilon^d / 2) n r_n^d \phi_n)
$$
  

$$
\le \exp(-(\alpha f_0 \varepsilon^d / 4) n r_n^d \phi_n),
$$

where we used the conditions  $nr_n^d \to \infty$  and  $\phi_n \ge \log n$ , for the last inequality. This gives us the first assertion in [\(3.9\)](#page-13-1), and the second assertion is obtained similarly using  $\tilde{\mathscr{G}}_{n,k}$ .

In the case where  $A = [0, 1]^2$ , we can argue similarly (see [\[7,](#page-52-0) Lemma 13.5]). We should now take  $\varepsilon$  so that the cubes  $Q_{n,i}$  fit exactly in the unit cube, which means  $\varepsilon$  needs to vary now take *ε* so that the cubes  $Q_{n,i}$  nt exactly in the unit cube, which means *ε* needs to vary with *n* but we can take *ε*(*n*) to satisfy this condition as well as *ε* ∈ [1/(99√*d*), 1/(98√*d*)) for all large enough *n*, and the preceding argument still works.  $\Box$ 

We next provide a bound on the probability of existence of a moderately large components of  $G(\mathcal{P}_n, r_n)$  near a given location in A, again measuring 'size' of a component C by the Euclidean diameter of its vertex set  $V(C)$ . For  $x, y, z \in \mathbb{R}^d$  and X a finite set of points in  $\mathbb{R}^d$ , we use the notation

$$
\mathcal{X}^x := \mathcal{X} \cup \{x\}; \quad \mathcal{X}^{x,y} := \mathcal{X} \cup \{x,y\}; \quad \mathcal{X}^{x,y,z} := \mathcal{X} \cup \{x,y,z\}.
$$
 (3.13)

Suppose  $0 \leq \varepsilon < K \leq \infty$ . Given  $(r_n)_{n>1}$  we define events

\mathcal{M}_{n,\varepsilon,K}(x,\mathcal{X}) := \{ \varepsilon r_n < \operatorname{diam}(\mathcal{C}_{r_n}(x,\mathcal{X}^x)) \leq Kr_n \};\tag{3.14}

\mathcal{M}_{n,\varepsilon,K}^*(x,\mathcal{X}) := \bigcup_{y \in \mathcal{X} \cap B_{r_n}(x)} \mathcal{M}_{n,\varepsilon,K}(y,\mathcal{X}).
$$
\n(3.15)

<span id="page-14-5"></span>**Lemma 3.8** (Non-existence of moderately large components near a fixed site)**.** *Suppose*  $nr_n^d \to \infty$  and  $n^{1/(2d)}r_n \to 0$  as  $n \to \infty$ . There exist  $\beta, n_1 \in (0, \infty)$  such that for all  $n \geq n_1$  *and all*  $x, y \in A$ *, all*  $\rho \in [1, n^{1/(2d)}]$ *, with*  $\xi_n$  *representing any of*  $\mathcal{P}_n$ *,*  $\mathcal{P}_n \cup \{y\}$ *,*  $\mathcal{X}_{n-1}, \mathcal{X}_{n-2} \cup \{y\}$  *or*  $\mathcal{X}_{n-3} \cup \{y\}$ *, we have*

*Proof.* Suppose  $\xi_n = \mathcal{P}_n$ . Assume for now that  $\partial A \in C^2$ . As in the previous proof, given *n* we partition  $\mathbb{R}^d$  into cubes  $Q_{n,i}$  of side  $\varepsilon r_n$  with  $\varepsilon = 1/(99\sqrt{d})$ . For  $n > 0, k \in \mathbb{N}$ , with  $n \geq 0, k \in \mathbb{N}$ , with  $\mathcal{K}_{n,k,\alpha}$  defined at [\(3.10\)](#page-13-2) define

$$
\mathcal{K}_{n,k,\alpha,x} = \{ \sigma \in \mathcal{K}_{n,k,\alpha} : \varepsilon r_n \sigma \cap B_{r_n}(x) \neq \varnothing \text{ or } \cup_{i \in \sigma} \overline{Q_{n,i}} \text{ surrounds } x \},
$$

where we say a set  $D \subset \mathbb{R}^d$  surrounds x if x lies in a bounded component of  $\mathbb{R}^d \setminus D$ , and  $a\sigma := \{az : z \in \sigma\}$  for  $a > 0$ , and  $\overline{D}$  denotes the closure of a set *D*. Define the event

$$
\mathscr{G}_{n,k,x} := \bigcup_{\sigma \in \mathcal{K}_{n,k,\alpha,x}} \{ \mathcal{P}_n \cap (\bigcup_{i \in \sigma} Q_{n,i}) = \varnothing \}.
$$

Let  $\rho > 0$ . Suppose now that  $\mathscr{M}_{n,\rho,n^{1/(2d)}}(x,\mathcal{P}_n)$  occurs, and let  $\mathcal{C} := \mathcal{C}_{r_n}(x,\mathcal{P}_n^x)$ . In this case we have to look into the proof of [\[7,](#page-52-0) Lemma 13.9] (or that of [\[8,](#page-52-10) Lemma 3.5], which is the same). There, the set we are calling A is called  $\Omega$ . In the preamble to that lemma, a sequence of sets  $\Omega_1, \Omega_2, \Omega_3$  is defined; each of these sets is a connected union of closed hypercubes, with  $\Omega_i \subset \Omega_{i+1}^o$  for  $i = 1, 2$ , with  $\Omega_3 \subset A^o$ , and also with the 'interior' set  $\Omega_I$  (defined in [\[7\]](#page-52-0)) contained in  $\Omega_1$ .

Set  $\mathcal{C}' = \mathcal{C} \oplus B_{r_n/2}(o)$ ; then  $\mathcal{C}'$  is a connected compact set. Let  $\mathcal{D}$  be the closure of the unbounded component of  $\mathbb{R}^d \setminus \mathcal{C}'$ , and let  $\partial \mathcal{C}' := \mathcal{C}' \cap \mathcal{D}$ , which is the external boundary of C'. Let  $\Sigma$  denote the collection of  $i \in \mathbb{Z}^d$  such that  $Q_{n,i} \cap \partial C' \neq \emptyset$ .

Then  $\partial C'$  is connected by the unicoherence of  $\mathbb{R}^d$  (see e.g. [\[7\]](#page-52-0)), so  $\Sigma$  is  $\ast$ -connected. Also  $\mathcal{P}_n \cap Q_{n,i} = \emptyset$  for all  $i \in \Sigma$ . Moreover, since  $\text{diam}(\mathcal{C}) \leq n^{1/(2d)}r_n$  and  $\mathcal{C} \cap B_{r_n}(x) \neq \emptyset$ , we have that  $\bigcup_{i\in\Sigma}Q_{n,i}\subset B_{2n^{1/(2d)}r_{n}}(x)$ .

We claim that  $\bigcup_{i\in \Sigma}\overline{Q_{n,i}}$  surrounds *x*. Indeed,  $x \notin \bigcup_{i\in \Sigma}\overline{Q_{n,i}}$  since  $dist(x, \partial C') \geq r_n/2$ . Since  $x \in \mathcal{C} \subset \mathcal{C}'$ , any path from x to a point in  $\mathcal{D}$  must pass through a point in  $\partial \mathcal{C}'$ , and the claim follows.

Since  $n^{1/(2d)}r_n \to 0$  as  $n \to \infty$ , if  $x \in \Omega_3$  then (provided *n* is large enough) we have  $B_{2n^{1/(2d)}r_n}(x) \subset A$  and hence  $\cup_{i\in \Sigma} Q_{n,i} \subset A$ . If  $x \notin \Omega_3$  then (provided *n* is large enough) we have  $\mathcal{C} \cap \Omega_2 = \emptyset$ , and by following the second case considered in the proof of [\[7,](#page-52-0) Lemma 13.9], we see that  $\Sigma \in \mathcal{K}_{n,k,\alpha,x}$  for some *k*. Also  $|\Sigma| \geq \varepsilon^{-1} d^{-1/2} \rho \geq \rho$ .

Thus in either case if  $\mathcal{M}_{n,\rho,n^{1/(2d)}}(x,\mathcal{P}_n)$  occurs, then event  $\mathcal{G}_{n,k}$  (defined at [\(3.11\)](#page-13-3)) occurs for some  $k \ge \rho$ . Since there are constants *c*, *c'* such that the family of \*-connected sets  $\sigma \subset \mathbb{Z}^d$  with  $\#(\sigma) = k$  and with  $\mathbb{R}^d \setminus \overline{\cup_{i \in \sigma} Q_{n,i}}$  surrounding x has cardinality at most  $c'e^{ck}$ , for *n* large enough we have

$$
\mathbb{P}[\mathscr{G}_{n,k}] \le c' \exp(ck - k\alpha n f_0(\varepsilon r_n)^d) \le c' \exp(-(\alpha f_0 \varepsilon^d / 2) k n r_n^d).
$$

By summing over  $k \geq \rho$ , we deduce that for *n* large enough,

$$
\mathbb{P}[\mathcal{M}_{n,\rho,n^{1/(2d)}}(x,\mathcal{P}_n)] \leq 2c' \exp(-(\alpha f_0 \varepsilon^d/2) \rho n r_n^d).
$$

Taking  $\beta = \alpha f_0 \varepsilon^d/4$ , we obtain [\(3.16\)](#page-14-0). Then using Markov's inequality, the Mecke formula (see e.g.  $[5]$ ) and  $(3.16)$  we can deduce that

$$
\mathbb{P}[\mathcal{M}_{n,\rho,n^{1/(2d)}}^*(x,\mathcal{P}_n)] \le n \int_{B_{r_n}(x)} \mathbb{P}[\mathcal{M}_{n,\rho,n^{1/(2d)}}(y,\mathcal{P}_n)] \nu(dy)
$$
  
=  $O(nr_n^d \exp(-\beta \rho nr_n^d)),$ 

and on taking a smaller value of  $\beta$  we obtain [\(3.17\)](#page-14-1).

In the case where  $A = [0, 1]^2$ , we can argue similarly (see [\[7,](#page-52-0) Lemma 13.5]). We should now take  $\varepsilon$  so that the cubes  $Q_{n,i}$  fit exactly in the unit cube, which means  $\varepsilon$  needs to vary now take *ε* so that the cubes  $Q_{n,i}$  nt exactly in the unit cube, which means *ε* needs to vary with *n* but we can take *ε*(*n*) to satisfy this condition as well as *ε* ∈ [1/(99√*d*), 1/(98√*d*)) for all large enough *n*, and the preceding argument still works.

We can prove the results for the other choices of  $\xi_n$  in the statement of the lemma, by similar arguments.  $\Box$ 

We shall use crossing estimates from the theory of continuum percolation. Consider a homogeneous Poisson process  $\mathcal{H}_{\alpha}$  in  $\mathbb{R}^d$  with intensity  $\alpha$ . For each  $s > 0$ , let  $\mathcal{H}_{\alpha,s} =$  $\mathcal{H}_\alpha \cap C_s$  where  $C_s := [0, s]^d$ . We say that the graph  $G(\mathcal{H}_{\alpha,s}, 1)$  crosses the cube  $C_s$  in the first coordinate (for short:  $Cross_1(s)$  occurs) if there exists a component of  $G(\mathcal{H}_{\alpha,s}, 1)$ 

such that its vertex set C satisfies  $(C \oplus B_{1/2}(o)) \cap (\{0\} \times [0, s]^{d-1}) \neq \emptyset$  and  $(C \oplus B_{1/2}(o)) \cap$  $({s} \times [0, s]^{d-1}) \neq \emptyset$ , namely, we can find a path contained in  $\mathcal{C} \oplus B_{1/2}(o)$  which connects two opposite faces of  $C_s$  along the first coordinate. Define similarly  $Cross_k(s)$  for each  $k \in \{2, \ldots, d\}$ . We say Cross(*s*) occurs if Cross<sub>k</sub>(*s*) occurs for all  $k \in [d]$ . Observe that the crossing event defined above is slightly different from the one in Meester and Roy [\[6\]](#page-52-11) where a crossing in the first coordinate is said to occur if there is a path in  $(\mathcal{H}_{\alpha} \oplus B_{1/2}(o)) \cap C_s$ connecting two opposite faces of  $C_s$  along the first coordinate. In other words, in [\[6\]](#page-52-11), one is allowed to use all the Poisson points to construct a crossing path in *Cs*, while in our setting, one is restricted to the Poisson points in *Cs*.

A fundamental fact about continuum percolation is the existence of  $\alpha_c \in (0,\infty)$  such that, as  $s \to \infty$ ,  $\mathbb{P}_{\alpha}[\text{Cross}(s)] \to 1$  for  $\alpha > \alpha_c$  and  $\mathbb{P}_{\alpha}[\text{Cross}(s)] \to 0$  for  $\alpha < \alpha_c$ . Here  $\mathbb{P}_{\alpha}$ denotes the law of  $\mathcal{H}_{\alpha}$ . For our purpose, we are concerned with the super-critical phase  $\alpha > \alpha_c$ . The following estimate taken from [\[7\]](#page-52-0) quantifies the convergence of the crossing probabilities.

<span id="page-16-0"></span>**Lemma 3.9** ([\[7,](#page-52-0) Lemma 10.5 and Proposition 10.6]). Let  $d \geq 2$  and  $\alpha > \alpha_c$ . Then there *exists a finite constant*  $c > 0$  *such that for all*  $s \geq 1$ *,* 

$$
1 - \mathbb{P}_{\alpha}[\text{Cross}_1(s)] \le e^{-cs}.
$$

From this we derive a bound for the probability of having a small giant component. Again in the next result, diam refers to the Euclidean metric diameter of the vertex set of a component.

Given finite nonempty  $\mathcal{X} \subset \mathbb{R}^d$  and  $n \geq 1$ , let  $\mathcal{L}_n(\mathcal{X})$  and  $\mathcal{L}_{n,2}(\mathcal{X})$  denote the vertex set of the component of  $G(\mathcal{X}, r_n)$  with with largest order and second largest order, respectively (setting  $\mathcal{L}_{n,2}(\mathcal{X})$  to be empty if the graph is connected). Choose the left-most one if there is a tie.

<span id="page-16-3"></span>**Lemma 3.10.** *Suppose*  $nr_n^d \to \infty$  *and*  $nr_n^d = O(\log n)$  *as*  $n \to \infty$ *. Then there exist constants*  $\delta_3, n_1 \in (0, \infty)$  *such that for all*  $n \geq n_1$ *, with*  $\xi_n$  *denoting either*  $\mathcal{P}_n$  *or*  $\mathcal{X}_n$ *,* 

<span id="page-16-2"></span>
$$
\mathbb{P}[\text{diam}(\mathcal{L}_n(\xi_n)) < (\log n)^2 r_n] \le \exp(-\delta_3 (n/\log n)^{1/d}).\tag{3.18}
$$

*Proof.* First we show there exist constants  $\delta, c' \in (0, \infty)$  such that for all large enough *n*,

<span id="page-16-1"></span>
$$
\mathbb{P}[\#(\mathcal{L}_n(\xi_n)) < \delta r_n^{-1}] \le \exp(-c'(n/\log n)^{1/d});\tag{3.19}
$$

Without loss of generality we can and do choose  $\delta > 0$  such that  $C_{2\delta} := [0, 2\delta]^d \subset A$ . Define the event

$$
\mathscr{Y}_n := \{ G(\mathcal{P}_{e^{-2}n} \cap C_{2\delta}, r_n) \text{ crosses } C_{2\delta} \text{ in the first coordinate} \}.
$$

Since  $\mathcal{P}_{e^{-2}n} \subset \mathcal{P}_n$ , we have that  $\mathscr{Y}_n \subset \{\#(\mathcal{L}_n(\mathcal{P}_n)) \geq \delta/r_n\}$  for *n* large.

Clearly the graph  $G(\mathcal{P}_{e^{-2}n} \cap C_{2\delta}, r_n)$  is isomorphic to  $G(r_n^{-1}(\mathcal{P}_{e^{-2}n} \cap C_{2\delta}), 1)$ . Also  $e^{-2}n f_0 r_n^d > \alpha_c + 1$  for all *n* large by [\(1.1\)](#page-2-0). We claim that for such *n*, we have  $\mathbb{P}[\mathscr{Y}_n] \geq$  $\mathbb{P}_{\alpha_c+1}[\text{Cross}_1(2\delta/r_n)]$ . Indeed, by the mapping theorem [\[5,](#page-52-8) Theorem 5.1],  $r_n^{-1}(\mathcal{P}_{e^{-2}n} \cap C_{2\delta})$ is a Poisson process in  $C_{2\delta/r_n}$  with intensity measure having a density bounded below by

 $e^{-2}n f_0 r_n^d$ , and hence by  $\alpha_c + 1$ . By the thinning theorem [\[5,](#page-52-8) Corollary 5.9], one can couple  $\mathcal{H}_{\alpha_c+1}$  and  $\mathcal{P}_{e^{-2}n}$  in such a way that  $\mathcal{H}_{\alpha_c+1} \cap C_{2\delta/r_n} \subset r_n^{-1}(\mathcal{P}_{e^{-2}n} \cap C_{2\delta})$ . Since the crossing event is increasing in the sense that adding more points to the Poisson process increases the chance of its occurrence, this coupling justifies the claim. Thus by Lemma [3.9,](#page-16-0)

$$
\mathbb{P}[\#(\mathcal{L}_n(\mathcal{P}_n)) \ge \delta/r_n] \ge \mathbb{P}[\mathscr{Y}_n] \ge \mathbb{P}_{\alpha_c+1}[\text{Cross}_1(2\delta/r_n)] \ge 1 - e^{-2c\delta/r_n},
$$

For the case of binomial input, note that if  $Z_{e^{-2}n} \leq n$  then  $\mathcal{P}_{e^{-2}n} \leq \mathcal{X}_n$  and hence if also  $\mathscr{Y}_n$  occurs then  $\#(\mathcal{L}_n(\mathcal{X}_n)) \geq \delta/r_n$  for *n* large. Therefore using Lemma [3.4\(](#page-11-4)iii) we have

$$
\mathbb{P}[\#(\mathcal{L}_n(\mathcal{X}_n)) < \delta/r_n] \le \mathbb{P}[\mathscr{Y}_n^c] + \mathbb{P}[Z_{e^{-2}n} > n] \le e^{-2c\delta/r_n} + e^{-n}.
$$

Thus using the assumption  $nr_n^d = O(\log n)$ , we have [\(3.19\)](#page-16-1) for both choices of  $\xi_n$ .

Now for  $n \geq 1$  let  $\rho := \rho(n) := \max((\log n)^2, 1)$ , and partition  $\mathbb{R}^d$  into cubes of side length  $r_n$ . Necessarily  $\mathcal{L}_n(\mathcal{P}_n)$  intersects one of the cubes with non-empty intersection with *A*, called *Q*, and if  $\text{diam}(\mathcal{L}_n(\mathcal{P}_n)) < \rho r_n$ , then  $\mathcal{L}_n(\mathcal{P}_n) \subset Q \oplus B_{\rho r_n}$ . If also  $\#(\mathcal{L}_n(\mathcal{P}_n)) \ge$  $\delta/r_n$ , then  $\mathcal{P}_n(Q \oplus B_{\rho r_n}) \geq \delta/r_n$ . Since  $\rho \geq 1$ , we have  $\lambda(Q \oplus B_{\rho r_n}) \leq (3\rho r_n)^d$ . By the union bound, we have

$$
\mathbb{P}[\{\text{diam}(\mathcal{L}_n(\mathcal{P}_n)) < \rho r_n\} \cap \{\#(\mathcal{L}_n(\mathcal{P}_n)) \ge \delta/r_n\}] \le cr_n^{-d} \mathbb{P}[Z_{3^d\rho^d n f_{\text{max}} r_n^d} \ge \delta/r_n].
$$

We can then apply Lemma [3.4\(](#page-11-4)iii) provided  $\delta/r_n \geq e^2(3^d \rho^d n f_{\text{max}} r_n^d)$ , or in other words  $\rho^d \leq (c'nr_n^{d+1})^{-1}$  for some constant *c*'.

By assumption  $nr_n^d = O(\log n)$  so  $\rho^d nr_n^{d+1} = O((\log n)^{2d + (d+1)/d} n^{-1/d})$ . Hence we can apply Lemma [3.4\(](#page-11-4)iii) to deduce that for *n* large

$$
\mathbb{P}[\{\text{diam}(\mathcal{L}_n(\mathcal{P}_n)) < \rho r_n\} \cap \{\#(\mathcal{L}_n(\mathcal{P}_n)) \ge \delta/r_n\}] \le cr_n^{-d} \exp(-\delta/r_n) \le \exp(-\delta/(2r_n)).
$$

Since  $r_n^d = O((\log n)/n)$ , we have  $r_n^{-1} = \Omega((\frac{n}{\log n})$  $\binom{1}{d}$  so using [\(3.19\)](#page-16-1) and the union bound we can deduce [\(3.18\)](#page-16-2) for  $\xi_n = \mathcal{P}_n$ . We can obtain (3.18) for  $\xi_n = \mathcal{X}_n$  by a similar argument, using Lemma [3.4\(](#page-11-4)i) instead of Lemma [3.4\(](#page-11-4)iii).

### <span id="page-17-0"></span>**4 The number of isolated vertices**

In this section we prove Propositions [2.2](#page-6-4) and [2.10.](#page-8-2) In the uniform case we also demonstrate the asymptotic equivalence of  $I_n$  and  $\mu_n$ , defined at [\(2.1\)](#page-5-2) and [\(1.4\)](#page-3-2) respectively.

We continue to make the assumptions on  $\nu$  and A that we set out at the start of Section [3.](#page-9-0) Also we assume  $r_n \in (0,\infty)$  is given for all  $n \geq 1$ . Recalling from [\(2.1\)](#page-5-2) that  $I_n := n \int \exp(-n\nu(B_{r_n}(x))) \nu(dx)$ , we assume throughout this section that  $r_n$  satisfies

$$
\lim_{n \to \infty} n r_n^d = \infty; \tag{4.1}
$$

<span id="page-17-2"></span><span id="page-17-1"></span>
$$
\liminf_{n \to \infty} I_n > 0. \tag{4.2}
$$

Also for  $s > 0$  we write  $A^{(-s)} := \{x \in A : B_s(x) \subset A\}.$ 

#### <span id="page-18-0"></span>**4.1 Mean and variance of the number of isolated vertices**

Let  $S_n$  (respectively  $S'_n$ ) denote the number of singletons (i.e. isolated vertices) of  $G(\mathcal{X}_n, r_n)$  (resp., of  $G(\mathcal{P}_n, r_n)$ ). That is, set

$$
S'_n = \sum_{x \in \mathcal{P}_n} \mathbf{1} \{ \mathcal{P}_n \cap B_{r_n}(x) = \{x\} \}; \qquad S_n = \sum_{x \in \mathcal{X}_n} \mathbf{1} \{ \mathcal{X}_n \cap B_{r_n}(x) = \{x\} \}. \tag{4.3}
$$

By the Mecke formula  $\mathbb{E}[S'_n] = I_n$ . Also define

$$
\tilde{I}_n := \mathbb{E}[S_n] = n \int (1 - \nu(B_{r_n}(x)))^{n-1} \nu(dx).
$$
\n(4.4)

<span id="page-18-3"></span>**Lemma 4.1** (Lower bounds on  $I_n$ ). Let  $f_0^+$ ,  $f_1^+$  be constants with  $f_0^+ > f_0$  and  $f_1^+ > f_1$ . *Then as*  $n \to \infty$ *,* 

<span id="page-18-5"></span><span id="page-18-1"></span>
$$
n \exp(-n\theta f_0^+ r_n^d) = o(I_n); \tag{4.5}
$$

$$
n^{1-1/d} \exp(-n\theta f_1^+ r_n^d/2) = o(I_n). \tag{4.6}
$$

*Proof.* Assume for now that  $\partial A \in C^2$ . See [\[12,](#page-52-5) Lemma 3.1] for a proof of [\(4.5\)](#page-18-1). For [\(4.6\)](#page-18-1), choose  $x_0 \in \partial A$  with  $f(x_0) < f_1^+$ . Using the assumed continuity of  $f$ , choose  $s_0 > 0$  and  $\delta > 0$  such that

$$
(1 + \delta)^{d+1} \sup \{ f(y) : y \in A \cap B_{2s_0}(x_0) \} \le f_1^+.
$$

By Lemma [3.3,](#page-10-6) there is a constant  $r_1 > 0$  (independent of *z*) such that  $\lambda(B_s(z) \cap A) \leq$  $(1 + \delta)\theta s^d/2$  for all  $z \in \partial A, s \in (0, r_1)$ .

Let  $y \in B_{s_0}(x_0) \cap A \setminus A^{(-\delta r_n)}$  and let *z* be the closest point of  $\partial A$  to *y*. Then  $||y - z|| \le$ *δrn*, so provided *n* is large enough

$$
\nu(B_{r_n}(y)) \le \nu(B_{(1+\delta)r_n}(z)) \le (1+\delta)^{d+1} f_1 \theta r_n^d/2 \le f_1^+ \theta r_n^d/2.
$$

Therefore since  $\lambda(B_{s_0}(x_0) \cap A \setminus A^{(-s)}) = \Omega(s)$  as  $s \downarrow 0$ ,

$$
I_n \ge n \int_{B_{s_0}(x_0) \cap A \setminus A^{(-\delta r_n)}} \exp(-n\nu(B_{r_n}(y))) \nu(dy) = \Omega(nr_n e^{-n f_1^+ \theta r_n^d/2}),
$$

and then using  $(4.1)$  we obtain  $(4.6)$ .

In the case where  $A = [0, 1]^2$  instead of  $\partial A \in C^2$ , the preceding proof still works, since we can take  $x_0$  to not be a corner of  $A$ .  $\Box$ 

<span id="page-18-4"></span>**Lemma 4.2** (Upper bound on  $I_n$ ). Suppose  $b^+ \leq (6/5)b_c$  with  $b_c$  given at [\(2.5\)](#page-5-3). Then *given*  $\varepsilon > 0$ *,* 

<span id="page-18-2"></span>
$$
I_n = O(ne^{-n\theta f_0 r_n^d} + n^{1-1/d}e^{-nr_n^d\theta f_1(\frac{1}{2} - \varepsilon)}).
$$
\n(4.7)

*Proof.* Note first that for all  $x \in A^{(-r_n)}$  we have  $\nu(B_{r_n}(x)) \geq \theta r_n^d f_0$ , so that writing  $I_n(S)$ for  $n \int_S \exp(-n\nu(B_{r_n}(x))) \nu(dx)$ , we have

$$
I_n(A^{(-r_n)}) = n \int_{A^{(-r_n)}} e^{-n\nu(B_{r_n}(x))} \nu(dx) \le n e^{-n\theta r_n^d f_0}.
$$

Let  $\varepsilon \in (0, \frac{1}{2})$  $\frac{1}{2}$ ). Suppose  $\partial A \in C^2$ . Then by Lemma [3.3](#page-10-6) and the continuity of *f*, for all large enough *n* and all  $x \in A \setminus A^{(-r_n)}$  we have  $\nu(B_{r_n}(x)) \geq (1 - \varepsilon)f_1\theta r_n^d/2$ ; hence

$$
I_n(A \setminus A^{(-r_n)}) = O(nr_ne^{-n\theta r_n^df_1(1-\varepsilon)/2}) = O(n^{1-1/d}e^{-n\theta r_n^df_1(\frac{1}{2}-\varepsilon)}).
$$

Now suppose instead that  $d = 2$  and  $A = [0, 1]^2$ . Let  $\text{Cor}_n$  denote the set of  $x \in A$  lying at an  $\ell_{\infty}$  distance at most  $r_n$  from one of the corners of A. By the same argument as above

$$
I_n(A \setminus A^{(-r_n)} \setminus \text{Cor}_n) = O(n^{1/2}e^{-n\theta r_n^2 f_1(\frac{1}{2}-\varepsilon)}).
$$

Also  $I_n(\text{Cor}_n) \leq 4f_{\text{max}}nr_n^2 \exp(-n\pi r_n^2 f_0/4)$  and using the assumption  $b^+ < (6/5)b_c =$  $6/(5f_0)$ , we obtain for large *n* that  $nf_0\pi r_n^2 \leq (5/4) \log n$  so that

$$
\frac{I_n(\text{Cor}_n)}{n e^{-n\pi r_n^2 f_0}} \le 4 f_{\text{max}} r_n^2 \exp(3n\pi r_n^2 f_0/4) = O(r_n^2 n^{15/16}) = o(1).
$$

Combining all of the preceding estimates we obtain for both cases ( $\partial A \in C^2$  or  $A = [0, 1]^2$ ) that  $(4.7)$  holds.  $\Box$ 

*Proof of Proposition [2.2.](#page-6-4)* If  $b^+ < b_c = \max(\frac{1}{f_0}, \frac{2-2}{f_1})$  $\frac{f_1 - 2}{f_1}$  then we claim that  $I_n \to \infty$ . Indeed, if  $b^+ < 1/f_0$ , choose  $f_0^+ > f_0$ ,  $\delta > 0$ , such that  $f_0^+(b^+ + \delta) < 1$ . Then for *n* large  $ne^{-n\theta f_0^+ r_n^d} > ne^{-f_0^+(b^+ + \delta) \log n}$  so  $I_n \to \infty$  by Lemma [4.1.](#page-18-3) If  $b^+ < (2 - 2/d)/f_1$  then choose  $f_1^+ > f_1$  and  $\delta > 0$  with  $f_1^+(b^+ + \delta) < 2 - 2/d$ . Then for *n* large,  $n^{1-1/d}e^{-n\theta f_1^+ r_n^d/2} >$  $n^{1-1/d}e^{-\frac{1}{2}f_1^+(b^++\delta)\log n}$  so again  $I_n \to \infty$  by Lemma [4.1,](#page-18-3) and the claim follows.

Now suppose  $b^{-} > b_c$ . We need to show  $I_n \to 0$  as  $n \to \infty$ . Since  $n \int_A e^{-n\nu(B_s(x))} \nu(dx)$ is nonincreasing in *s*, it suffices to prove this under the extra assumption  $b^+ \leq 6b_c/5$ , which makes Lemma [4.2](#page-18-4) applicable. Since  $b^{-} > b_c$  there exists  $\varepsilon > 0$  such that for *n* large enough  $\theta f_0 nr_n^d > (1+\varepsilon) \log n$  and  $nr_n^d \theta f_1(\frac{1}{2}-\varepsilon) > (1-1/d)(1+\varepsilon) \log n$ , and then we see  $I_n \rightarrow 0$  by [\(4.7\)](#page-18-2).

Finally if  $b^+ > b_c$  then by the preceding argument  $I_n \to 0$  as  $n \to \infty$  along some subsequence, so we must have  $\liminf_{n\to\infty}I_n=0$ .  $\Box$ 

<span id="page-19-0"></span>**Lemma 4.3** (Asymptotic equivalence of  $I_n$  and  $\tilde{I}_n$ ). There exists  $\delta > 0$  such that as  $n \to \infty$  *we have*  $|I_n - \tilde{I}_n| = O(e^{-\delta n r_n^d} I_n)$ *.* 

*Proof.* For  $x \in A$ , given *n* write  $p_n(x) := \nu(B_{r_n}(x))$ . By the bounds  $1 - p_n(x) \leq e^{-p_n(x)}$ , and  $1 - p_n(x) \geq 1 - f_{\text{max}} \theta r_n^d$ , and the condition [\(4.1\)](#page-17-1),

$$
\tilde{I}_n \le (1 - f_{\max} \theta r_n^d)^{-1} n \int_A e^{-n p_n(x)} \nu(dx)
$$

$$
= (1 + O(r_n^d)) I_n.
$$

Also by Taylor's theorem  $\log(1-p) \ge -p-p^2$  for  $p > 0$  close to 0, so

$$
\tilde{I}_n \ge n \int_A \exp(n \log(1 - p_n(x))) dx
$$
  
\n
$$
\ge n \int_A \exp(n(-p_n(x) - p_n(x)^2)) dx
$$
  
\n
$$
\ge e^{-n(f_{\max}\theta r_n^d)^2} I_n.
$$

Combining these two estimates and using [\(4.1\)](#page-17-1) yields  $|\tilde{I}_n - I_n| = O(nr_n^{2d}I_n)$ . Therefore Combining these two estimates and using (4.1) yields  $|I_n - I_n| = O(nI_n I_n)$ . Therefore<br>it suffices to show  $nr_n^{2d}e^{\delta n r_n^d} = O(1)$  for some  $\delta > 0$ . By [\(4.2\)](#page-17-2) and Proposition [2.2,](#page-6-4)  $nr_n^d = O(\log n)$  so for  $\delta$  small enough  $e^{\delta nr_n^d} = O(n^{1/2})$ , while  $nr_n^{2d} = O((\log n)^2 n^{-1})$  so  $nr_n^{\tilde{2}d} e^{\delta n r_n^d} = O((\log n)^2 n^{-1/2}) = o(1).$  $\Box$ 

<span id="page-20-0"></span>**Proposition 4.4** (Variance asymptotics of the number of singletons: Poisson input)**.** *There exists*  $c > 0$  *such that as*  $n \to \infty$ *,* 

$$
\mathbb{V}\text{ar}[S'_n] = I_n(1 + O(e^{-cnr_n^d})).
$$

*Proof.* This is proved in [\[12,](#page-52-5) Proposition 4.1, case  $k = 1$ ], for  $\partial A \in C^2$ , under the extra assumption [\[12,](#page-52-5) equation (3.1)] which amounts to  $b^+ < 1/\max(f_0, d(f_0 - f_1/2))$  (or  $b < 2/(df_0)$  in the uniform case). We need to relax this condition to  $\liminf_{n\to\infty} I_n > 0$  as well as  $nr_n^d \to \infty$ . Also we need to consider the case with  $d = 2$ ,  $A = [0, 1]^2$ . We find that the proof of [\[12,](#page-52-5) Proposition 4.1] still works, except for where it uses [\[12,](#page-52-5) Lemma 4.2]. The latter proof does invoke the extra assumption on  $b^+$ , so we provide a different proof of [\[12,](#page-52-5) Lemma 4.2, case  $k = 1$ ] not requiring the extra assumption on  $b^+$ , that works for  $A = [0, 1]^2$  as well as for  $\partial A \in C^2$ .

The quantity denoted  $J_{2,n}$  in [\[12\]](#page-52-5) is  $O(I_n e^{-cnr_n^d})$  as in [12]. The quantity denoted  $J_{1,n}$ in [\[12\]](#page-52-5) (when  $k = 1$ ) is given by

$$
J_{1,n} = n^2 \int_A \int_A e^{-n\nu(B_{r_n}(x)\cup B_{r_n}(y))} \mathbf{1}\{r_n < \|y - x\| \le 2r_n\} \nu(dy)\nu(dx)
$$
  

$$
\le 2n^2 \int_A \int_A e^{-n\nu(B_{r_n}(x)\cup B_{r_n}(y))} \mathbf{1}\{r_n < \|y - x\| \le 2r_n, x < y\} \nu(dy)\nu(dx).
$$

By [\(3.1\)](#page-10-1) from Lemma [3.1,](#page-10-3) there exists  $\delta_1 > 0$  such that for *n* large and  $x, y \in A$  with  $||x - y|| \ge r_n$  and  $x \lt y$  we have  $\nu(B_{r_n}(y) \setminus B_{r_n}(x)) \ge 2\delta_1 f_0 r_n^d$ . Hence

$$
J_{1,n} \le 2n^2 f_{\max} \theta(2r_n)^d \int_A e^{-n\nu(B_{r_n}(x)) - 2n\delta_1 f_0 r_n^d} \nu(dx)
$$
  

$$
\le e^{-n\delta_1 f_0 r_n^d} I_n,
$$

which gives us [\[12,](#page-52-5) Lemma 4.2, case  $k = 1$ ] and hence the result.

<span id="page-20-1"></span>**Proposition 4.5** (Variance asymptotics of the number of singletons: binomial input). *There exists*  $\delta > 0$  *such that as*  $n \to \infty$ *,* 

 $\Box$ 

$$
\mathbb{V}\text{ar}[S_n] = I_n(1 + O(e^{-\delta nr_n^d})).
$$

*Proof.* See [\[12,](#page-52-5) Proposition [4.3](#page-19-0)] and Lemma 4.3 of the present paper. In the proof of [12, Proposition 4.3] it is assumed that [\[12,](#page-52-5) equation (3.1)] holds (i.e.  $b^+ < 1/\max(f_0, d(f_0 f_1(2)$  in our notation here), but the proof carries through to the general case with  $nr_n^d \to$  $\infty$  and *I<sub>n</sub>* →  $\infty$ . Instead of [\[12,](#page-52-5) Lemma 4.2] we can use the estimate on *J*<sub>1*,n*</sub> in the proof of Proposition [4.4](#page-20-0) above.  $\Box$ 

#### <span id="page-21-0"></span>**4.2 Asymptotic distribution of the singleton count**

For both the normal and Poisson convergence results, we use the following.

<span id="page-21-4"></span>**Lemma 4.6** (Poisson approximation for  $S'_n$  and  $S_n$ ). There exists  $\delta > 0$  such that as  $n \to \infty$ ,

$$
d_{\text{TV}}(S'_n, Z_{I_n}) = O(e^{-\delta n r_n^d});\tag{4.8}
$$

if 
$$
\partial A \in C^2
$$
,  $d_{\text{TV}}(S_n, Z_{\tilde{I}_n}) = O(e^{-\delta n r_n^d}).$  (4.9)

*Proof.* The result [\(4.8\)](#page-21-2) is proved in [\[12,](#page-52-5) Proposition 5.4] (taking  $k = 1$  there), under the extra assumptions that  $\partial A \in C^2$  and that [\[12,](#page-52-5) equation (3.1)] holds, i.e.  $b^+ \leq$  $1/\max(f_0, d(f_0 - f_1/2))$  in our notation. We wish to drop this assumption on  $b^+$ , and assume only that  $nr_n^d \to \infty$  and  $\liminf_{n\to\infty}(I_n) > 0$ . Also we wish to include the case where  $A = [0, 1]^2$ .

Going through the proof of [\[12,](#page-52-5) Proposition 5.4] we find that it still works under our weaker assumptions, but that it uses [\[12,](#page-52-5) Lemma 4.2]. In the proof of Proposition [4.4](#page-20-0) we have already provided a the proof of [\[12,](#page-52-5) Lemma 4.2] under our weaker assumptions, justifying [\(4.8\)](#page-21-2).

Similarly  $(4.9)$  is proved in [\[12,](#page-52-5) Proposition 5.6], taking  $k = 1$  there, under the extra asusmption that  $b^+ \leq 1/\max(f_0, d(f_0 - f_1/2))$ , which we wish to drop. Going through the proof of [\[12,](#page-52-5) Proposition 5.6], we find that it still works without the extra assumption on  $b^+$ . Since  $k = 1$  for us, we can give a simpler proof of [\[12,](#page-52-5) Lemma 5.8] than the one given there for general *k*, as follows.

In our case  $N_6$  is the number of singletons of  $G(\mathcal{X}_{n,2}, r_n)$  within distance  $2r_n$  of  $\tilde{X}_1$ . Each vertex has probability  $O(r_n^d)$  of lying in  $B_{2r_n}(\tilde{X}_1) \setminus B_{r_n}(\tilde{X}_1)$ , and given its location and that of  $\tilde{X}_1$ , using [\(3.1\)](#page-10-1) from Lemma [3.1](#page-10-3) without assuming  $x \prec y$  there (and therefore requiring  $∂A ∈ C<sup>2</sup>$ ), it has probability at most  $e<sup>−δn r<sub>n</sub><sup>d</sup></sup>$  of being isolated, for some  $δ > 0$ . Thus we can obtain that  $\mathbb{E}[N_6] = O(nr_n^d \exp(-\delta nr_n^d))$  which is what we need.  $\Box$ 

*Proof of Proposition [2.10.](#page-8-2)* The assertion  $\mathbb{E}[\zeta_n] = I_n(1+O(e^{-\delta n r_n^d}))$  follows from the Mecke formula (in the case  $\zeta_n = S'_n$ ) and from Lemma [4.3](#page-19-0) (in the case  $\zeta_n = S_n$ ). The assertion  $\text{Var}[\zeta_n] = I_n(1+O(e^{-\delta nr_n^d}))$  follows from Proposition [4.4](#page-20-0) (if  $\zeta_n = S'_n$ ) and from Proposition [4.5](#page-20-1) (if  $\zeta_n = S_n$ ).

By the Berry-Esseen theorem  $d_K(t^{-1/2}(Z_t-t), N(0,1)) = O(t^{-1/2})$  as  $t \to \infty$ . Hence, by the triangle inequality for  $d_K$ , we have

$$
d_{\mathcal{K}}(I_n^{-1/2}(S'_n - I_n), N(0, 1)) \le d_{\mathcal{K}}(S'_n, Z_{I_n}) + O(I_n^{-1/2}). \tag{4.10}
$$

Then using [\(4.8\)](#page-21-2), and the obvious inequality  $d_K \leq d_{TV}$ , we obtain [\(2.22\)](#page-8-3). Similarly using [\(4.9\)](#page-21-2) and Lemma [4.3](#page-19-0) we obtain [\(2.23\)](#page-8-4).  $\Box$ 

#### <span id="page-21-1"></span>**4.3 Asymptotics for** *I<sup>n</sup>* **in the uniform case**

Throughout this subsection we make the additional assumption that  $f \equiv f_0 \mathbf{1}_A$ , with  $f_0 = 1/\lambda(A)$ , and assume as  $n \to \infty$  that  $r_n$  satisfy

$$
nr_n^d \to \infty;
$$
  $\limsup(nf_0\theta r_n^d - (2 - 2/d)(\log n - 1\{d \ge 3\} \log \log n)) < \infty.$  (4.11)

We shall demonstrate the asymptotic equivalence of  $I_n$  and  $\mu_n$ , defined at [\(2.1\)](#page-5-2) and [\(1.4\)](#page-3-2) respectively. Given *n*, for  $x \in A$  set  $p_n(x) := \exp(-n\nu(B_{r_n}(x)))$ . Given Borel  $S \subset A$ , let

I_n(S) := n f_0 \int_S p_n(x) dx.
$$
\n

(4.12)
$$

<span id="page-22-0"></span>**Proposition 4.7** (The case  $d = 2$ ). Suppose  $d = 2$  and either  $\partial A \in C^2$ , or  $A = [0, 1]^2$ . *Suppose* [\(4.11\)](#page-21-3) *holds. Then we have as*  $n \to \infty$  *that* 

$$
I_n = n \exp(-n f_0 \pi r_n^2)(1 + O(nr_n^2)^{-1/2}).
$$
\n(4.13)

*Proof.* **Case 1:**  $\partial A \in C^2$ . In this case the result follows from Proposition [4.8](#page-22-1) below, since the ratio between the two terms in the right hand side of [\(4.14\)](#page-22-2) is given by

$$
\frac{e^{-nf_0\theta r_n^d/2}\theta_{d-1}^{-1}r_n^{1-d}|\partial A|}{ne^{-nf_0\theta r_n^d}} = O\bigg(\exp\Big(\frac{nf_0\pi r_n^2}{2} - \frac{\log n}{2} - \frac{\log (nr_n^2)}{2}\Big)\bigg),
$$

which is  $O((nr_n^2)^{-1/2})$  by  $(4.11)$ .

**Case 2:**  $A = [0, 1]^2$ . In this case  $f_0 = 1$ . Define the 'moat'  $\mathsf{Mo}_n := A \setminus A^{(-r_n)}$ .

For  $1 \leq i \leq 4$  let  $\text{Cor}_{n,i}$  be the region of *A* within  $\ell_{\infty}$ -distance  $r_n$  of the *i*th corner of *A* (a square of side  $r_n$ ). Then  $I_n(\text{Cor}_{n,i}) \leq nr_n^2 e^{-n\pi r_n^2/4}$ .

The set  $\mathsf{Mo}_n \setminus \cup_{i=1}^4 \mathsf{Cor}_{n,i}$  is a union of rectangular regions  $\mathsf{Rec}_{n,i}, 1 \leq i \leq 4$ . For all *n* large enough,  $i \leq 4$  and  $x \in \text{Rec}_{n,i}$  we have  $\nu(B_{r_n}(x)) \geq r_n^2(\frac{\pi}{2} + a(x)/r_n)$ , where  $a(x)$ denotes the distance from *x* to *∂A*. Hence

$$
I_n(\text{Rec}_{n,i}) \leq nr_n e^{-n\pi r_n^2/2} \int_0^1 e^{-nr_n^2} da = O(nr_n e^{-\pi nr_n^2/2}(nr_n^2)^{-1}).
$$

Combined with the corner region estimate, and the bound  $\pi n r_n^2 \leq \log n + c$  from [\(4.11\)](#page-21-3), this yields

$$
I_n(\text{Mo}_n)/I_n(A^{(-r_n)}) = O(n^{-1}r_n^{-1}e^{n\pi r_n^2/2}) + O(r_n^2e^{(3/4)n\pi r_n^2})
$$
  
=  $O(n^{-1/2}r_n^{-1}) + O(((\log n)/n)n^{3/4}).$ 

Also  $I_n(A^{(-r_n)}) = ne^{-n\pi r_n^2}(1 + O(r_n))$  and  $r_n = o((nr_n^2)^{-1/2})$ . Putting together these estimates yields [\(4.13\)](#page-22-3) in Case 2.  $\Box$ 

<span id="page-22-1"></span>**Proposition 4.8** (The case  $\partial A \in C^2$ ). Suppose  $d \geq 2$  and  $\partial A \in C^2$ . Suppose  $(r_n)_{n \geq 1}$ *satisfy* [\(4.11\)](#page-21-3)*. Then as*  $n \to \infty$ *,*

$$
I_n = n e^{-n f_0 \theta r_n^d} + e^{-n f_0 \theta r_n^d / 2} \theta_{d-1}^{-1} r_n^{1-d} |\partial A| \left( 1 + O\left( \left( \frac{\log(n r_n^d)}{n r_n^d} \right)^2 \right) \right).
$$
 (4.14)

*Proof.* We shall investigate separately the contributions from different regions of the set *A*. Since the proof is quite long, we break it into steps.

*Step 1: Polytopal approximation to ∂A.* We shall approximate *A* locally by a polytope, i.e. break *∂A* into finitely many pieces and approximate each piece by a polytopal surface.

Given *x* ∈ *∂A* we can express *∂A* locally in a neighbourhood of *x*, after a rotation, as the graph of a *C* 2 function with zero derivative at *x*. We shall approximate to that function by the graph of a piecewise affine function.

Here are the details of this approximation, where we are following [\[10\]](#page-52-7) and [\[4\]](#page-52-6). For each  $x \in \partial A$ , we can find an open neighbourhood  $\mathcal{N}_x$  of  $x$ , a number  $r(x) > 0$  such that  $B(x, 3r(x)) \subset \mathcal{N}_x$  and a rotation  $\varphi_x$  about *x* such that  $\varphi_x(\partial A \cap \mathcal{N}_x)$  is the graph of a real-valued  $C^2$  function *f* defined on an open ball  $D \subset \mathbb{R}^{d-1}$ , with  $\langle f'(u), e \rangle \leq 1/(9d)$ for all  $u \in D$  and all unit vectors  $e$  in  $\mathbb{R}^{d-1}$ , where  $\langle \cdot, \cdot \rangle$  denotes the Euclidean inner product in  $\mathbb{R}^{d-1}$  and  $f'(u) := (\partial_1 f(u), \partial_2 f(u), \dots, \partial_{d-1} f(u))$  is the derivative of f at *u*. Moreover, by taking a smaller neighbourhood if necessary, we can also assume that there exists  $\varepsilon > 0$  and  $a \in \mathbb{R}$  such that  $f(u) \in [a + \varepsilon, a + 2\varepsilon]$  for all  $u \in D$  and also  $\varphi_x(A) \cap (D \times [a, a + 3\varepsilon]) = \{(u, z) : u \in D, a \le z \le f(u)\}.$ 

By a compactness argument, we can and do take a finite collection of points  $x_1, \ldots, x_J \in$ *∂A* such that

<span id="page-23-2"></span>
$$
\partial A \subset \bigcup_{j=1}^{J} B(x_j, r(x_j)).\tag{4.15}
$$

Then there are constants  $\varepsilon_j > 0$ , and rigid motions  $\varphi_j$ ,  $1 \leq j \leq J$ , such that for each *j* the set  $\varphi_j(\partial A \cap \mathcal{N}_{x_j})$  is the graph of a  $C^2$  function  $f_j$  defined on a ball  $I_j$  in  $\mathbb{R}^{d-1}$ , with  $|\langle f'_j(u), e \rangle| \leq 1/9$  for all  $u \in I_j$  and all unit vectors  $e \in \mathbb{R}^{d-1}$ , and also with  $\varepsilon_j \leq f_j(u) \leq$  $2\varepsilon_j$  for all  $u \in I_j$  and  $\varphi_j(A) \cap (I_j \times [0, 3\varepsilon_j]) = \{(u, z) : u \in I_j, 0 \le z \le f(u)\}.$ 

Let  $\Gamma \subset \partial A$  be a closed set such that  $\Gamma \subset B(x_j, r(x_j))$  for some  $j \in \{1, \ldots, J\}$ . Assume  $\Gamma$  is 'nice' in the sense that as as  $r \downarrow 0$ , the number of balls of radius r required to cover  $\partial \Gamma$ , the relative boundary of  $\Gamma$  in  $\partial A$ , is  $O(r^{2-d})$  (if  $d=2$  we can assume  $\partial \Gamma$  is finite). To simplify notation we shall assume that  $\Gamma \subset B(x_1, r(x_1))$ , and moreover that  $\varphi_1$  is the identity map. Then  $\Gamma = \{(u, f_1(u)) : u \in U\}$  for some bounded set  $U \subset \mathbb{R}^{d-1}$ . Also, writing  $\phi(\cdot)$  for  $f_1(\cdot)$  from now on, we assume

$$
\phi(U) \subset [\varepsilon_1, 2\varepsilon_1] \tag{4.16}
$$

and

$$
A \cap (U \times [0, 3\varepsilon_1]) = \{(u, z) : u \in U, 0 \le z \le \phi(u)\}.
$$
\n(4.17)

Divide  $\mathbb{R}^{d-1}$  into cubes of dimension  $d-1$  and side  $r_n^{3/4}$ , and divide each of these cubes into  $(d-1)!$  simplices (we take these simplices to be closed). Let  $U_n$  be the union of all those simplices in the resulting tessellation of  $\mathbb{R}^{d-1}$  into simplices, that are contained within *U*.

Let  $\psi_n: U_n \to \mathbb{R}$  be the function that is affine on each of the simplices making up  $U_n$ , and agrees with the function  $\phi$  on each of the vertices of these simplices. Choose  $n_0$  so that  $U_n \neq \emptyset$  for all  $n \geq n_0$ . Set

<span id="page-23-0"></span>
$$
K := \sup_{n \ge n_0, u \in U_n} (r_n^{-3/2} |\phi(u) - \psi_n(u)|). \tag{4.18}
$$

Then  $K < \infty$  by an based on Taylor expansion, similar to [\[10,](#page-52-7) Lemma 7.18] and to [\[4,](#page-52-6) eq. (5.7)].

Now define  $\phi_n(u) := \psi_n(u) - Kr_n^{3/2}$ . By [\(4.18\)](#page-23-0),  $\phi_n(u) \leq \phi(u) \leq \phi_n(u) + 2Kr_n^{3/2}$  for all  $u \in U_n$ . Our approximating surface will be defined by  $\Gamma_n := \{(x, \phi_n(x)) : x \in U_n\}$ , with the constant  $K$  given by  $(4.18)$ .

*Step 2: Decomposition of the range of integration.* We define the *moat*  $Mo_n$  by

$$
Mo_n := \{(u, z) : u \in U_n, z \le \phi_n(u), \text{dist}((u, z), \Gamma_n) \le r_n\}.
$$

This is the region within distance  $r_n$  of  $\Gamma_n$  and below  $\Gamma_n$ . We refer to Rai<sub>n</sub> := { $(u, z)$  : *u* ∈ *U<sub>n</sub>*,  $\phi_n(u)$  ≤ *z* ≤  $\phi(u)$ } as the *railing*. We refer to *A*<sup>(−2*r<sub>n</sub>*)</sup> as the *bulk*.

We further decompose  $Mo_n$  as follows. By construction, the set  $\Gamma_n$  is composed of (*d* − 1)-dimensional facets, which we denote by  $\textsf{Fac}_{n,i}$ ,  $1 \leq i \leq m(n)$ . For each  $i \leq m(n)$ let Pri<sub>n,i</sub> denote the prism with height  $r_n$  and upper  $(d-1)$ -dimensional base given by the part of  $Fac_{n,i}$  at distance at least  $4r_n$  from the set  $\partial Fac_{n,i}$ , which we define to be the union of all the  $(d-2)$ -dimensional facets bounding the facet  $\mathsf{Fac}_{n,i}$ .

We claim that the prisms  $\text{Pri}_{n,i}, 1 \leq i \leq m(n)$ , are pairwise disjoint. To see this, note that if  $u, v \in U$ , then as at equation (7.51) of [\[10\]](#page-52-7), since  $|\langle \phi'(w), e \rangle| \leq 1/9$  for all unit vectors  $w \in \mathbb{R}^{d-1}$ ,

<span id="page-24-1"></span>
$$
||(u, \phi(u)) - (v, \phi(v))|| \le ||u - v|| + |\phi(u) - \phi(v)| \le (9/8) ||u - v||. \tag{4.19}
$$

Hence  $||u - v|| \ge (8/9) ||(u, \phi(u)) - (v, \phi(v))||.$ 

Let  $\pi$ :  $\mathbb{R}^d \to \mathbb{R}^{d-1}$  denote projection onto the first  $d-1$  coordinates. If  $i \leq m(n)$ and  $x \in \text{Pri}_{n,i}$ , and  $y$  is the nearest point in  $\text{Fac}_{n,i}$  to  $x$ , then  $\text{dist}(y, \partial \text{Fac}_{n,i}) \geq 4r_n$ , and  $dist(\pi(y), \pi(\partial \mathsf{Fac}_{n,i})) \geq (8/9)(4r_n) \geq 3r_n$ . Since  $||x - y|| \leq r_n$ , also  $||\pi(y) - \pi(x)|| \leq r_n$ , and therefore  $dist(\pi(x), \pi(\partial \text{Fac}_{n,i})) \geq 2r_n$ . In particular,  $\pi(x)$  lies in  $\text{Fac}_{n,i}^o$ , the relative interior of Fac<sub>*n*,*i*</sub>. Similarly, for any  $j \neq i$  with  $j \leq m(n)$ , we have for any  $z \in \text{Pri}_{n,j}$  that  $\pi(z) \in \pi(\text{Fac}_{n,j}^o)$ , and since  $\pi(\text{Fac}_{n,j})$ ,  $\pi(\text{Fac}_{n,j})$  have disjoint interiors, this justifies the claim.

The preceding argument also shows that if  $i, j \leq m(n)$  with  $i \neq j$ , then

$$
dist(x, \mathsf{Fac}_{n,j}) \geq dist(\pi(x), \pi(\mathsf{Fac}_{n,j})) \geq 2r_n, \quad \forall \ x \in \mathsf{Pri}_{n,i}.\tag{4.20}
$$

By construction,  $\bigcup_{i=1}^{m(n)} \text{Pri}_{n,i} \subset \text{Mo}_n$ . The left-over regions in the moat near the  $(d-2)$ dimensional facets of Γ*<sup>n</sup>* (and therefore not in any prism) are called (Cor*n,i*), the *corner regions.* Notice that when  $d \geq 3$  the Cor<sub>n,i</sub>'s may overlap each other a little near the (*d*−3)-dimensional facets of Γ*n*, and they have empty intersection with any of the prisms. Partition the moat into prisms and corners

<span id="page-24-2"></span>
$$
\mathrm{Mo}_{n}=\Big(\bigcup_{i=1}^{m(n)}\mathrm{Pri}_{n,i}\Big)\cup\Big(\bigcup_{i=1}^{m(n)}\mathrm{Cor}_{n,i}\Big).
$$

*Step 3: contribution of the bulk, railing and corners.* To deal with the bulk, note that for each  $x \in A^{(-r_n)}$ , we have  $p_n(x) = e^{-nf_0\theta r_n^d}$  so that by [\(4.12\)](#page-22-4),

$$
I_n(A^{(-2r_n)}) = nf_0|A^{(-2r_n)}|e^{-nf_0\theta r_n^d} = (1 + O(r_n))ne^{-nf_0\theta r_n^d}.
$$
\n(4.21)

We deal next with the railing. Given  $\kappa < 1/2$ , for *n* large enough, we have by Lemma [3.3](#page-10-6) that  $p_n(x) \leq e^{-n f_0 \theta r_n^d \kappa}$  for  $x \in \text{Rai}_n$ . The total volume of the railing is  $O(r_n^{3/2})$ , so by  $(4.12),$  $(4.12),$ 

<span id="page-25-4"></span><span id="page-25-3"></span>
$$
I_n(\text{Rai}_n) = O(nr_n^{3/2}e^{-nf_0\theta r_n^d\kappa}).\tag{4.22}
$$

To bound the contribution from the corners, we see from Lemma [3.3](#page-10-6) that given  $\kappa < 1/2$ , for large *n* we have  $p_n(x) \leq e^{-nf_0\theta r_n^d \kappa}$  for  $x \in \bigcup_{i=1}^{m(n)} \text{Cor}_{n,i}$ , and there are in total  $O(r_n^{(1-d)3/4})$ corner regions, each of which has volume at most  $cr_n^{2+(d-2)3/4}$  for some constant *c*, yielding

$$
I_n(\cup_{i=1}^{m(n)} \text{Cor}_{n,i}) = O(nr_n^{5/4}e^{-nf_0\theta r_n^d \kappa}).\tag{4.23}
$$

*Step 4: contribution of the prisms.* For  $a > 0$  let  $g(a) := \lambda(B_1(o) \cap ([0, a] \times \mathbb{R}^{d-1}))$ , and for  $x \in \text{Pri}_{n,i}$  let  $a(x)$  be the distance from  $x$  to the face  $\text{Fac}_{n,i}$ . For each  $i \leq m(n)$ and  $x \in \text{Pri}_{n,i}$ , using [\(4.20\)](#page-24-0) we have

$$
|p_n(x) - e^{-n f_0 r_n^d (\frac{\theta}{2} + g(\frac{a(x)}{r_n}))} | \le e^{-n f_0 r_n^d (\frac{\theta}{2} + g(\frac{a(x)}{r_n}))} \times \left(1 - \exp\left(-n f_0 r_n^d (g(\frac{a(x) + 2Kr_n^{3/2}}{r_n}) - g(\frac{a(x)}{r_n}))\right)\right).
$$

Using the inequality  $1 - e^{-s} \leq s$  for  $s \in \mathbb{R}$ , and [\(4.11\)](#page-21-3), and the fact that  $g'(a) \leq \theta_{d-1}$  for all *a*, we obtain that there exists a constant *c* such that

<span id="page-25-0"></span>
$$
|p_n(x) - e^{-nf_0 r_n^d \left(\frac{\theta}{2} + g\left(\frac{a(x)}{r_n}\right)\right)}| \leq cnr_n^{d + \frac{1}{2}} e^{-nf_0 r_n^d \left(\frac{\theta}{2} + g\left(\frac{a(x)}{r_n}\right)\right)}.
$$
\n(4.24)

Define the upper base of Pri<sub>n,i</sub> by BPri<sub>n,i</sub> = Pri<sub>n,i</sub>  $\cap \Gamma_n$  (which is a part of Fac<sub>n,i</sub>), and let  $|BPr_{n,i}|$  be its  $(d-1)$ -dimensional Hausdorff measure. Then by  $(4.24)$ ,

$$
\left| nf_0 \int_{\text{Pr}_{n,i}} p_n(x) dx - nf_0 |\text{BPr}_{n,i}| r_n \int_0^1 e^{-n f_0 r_n^d (\frac{\theta}{2} + g(a))} da \right|
$$
  

$$
\leq c n^2 r_n^{d + \frac{1}{2}} |\text{BPr}_{n,i}| r_n \int_0^1 e^{-n f_0 r_n^d (\frac{\theta}{2} + g(a))} da.
$$

Hence, using [\(4.11\)](#page-21-3) and the fact that  $t \int_0^1 e^{-t g(a)} da \to \theta_{d-1}^{-1}$  as  $t \to \infty$  to handle the last factor, and summing over *i*, we deduce that

$$
\left| nf_{0} \int_{\bigcup_{i=1}^{m(n)} P_{\mathsf{ri}_{n,i}}} p_{n}(x)(dx) - \sum_{i=1}^{m(n)} |\mathsf{B} P_{\mathsf{ri}_{n,i}}| \int_{0}^{1} n f_{0} r_{n} e^{-n f_{0} r_{n}^{d}(\frac{\theta}{2} + g(a))} da \right|
$$
  
=  $O(n^{2} r_{n}^{d+3/2} e^{-n f_{0} \theta r_{n}^{d}/2} (n r_{n}^{d})^{-1})$   
=  $O(n r_{n}^{3/2} e^{-n f_{0} \theta r_{n}^{d}/2}).$  (4.25)

Next we claim that as  $n \to \infty$ ,

$$
\int_0^1 n f_0 r_n e^{-n f_0 r_n^d \left(\frac{\theta}{2} + g(a)\right)} da = e^{-n f_0 \theta r_n^d / 2} \theta_{d-1}^{-1} r_n^{1-d} \left(1 + O\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2\right),\tag{4.26}
$$

and

<span id="page-26-0"></span>
$$
\sum_{i=1}^{m(n)} |\text{BPri}_{n,i}| = |\Gamma| \left( 1 + O(r_n^{1/4}) \right),\tag{4.27}
$$

where  $|\Gamma|$  denotes the  $(d-1)$ -dimensional Hausdorff measure of  $\Gamma$ .

To prove [\(4.27\)](#page-26-0), recall that  $\Gamma$  is the graph of a  $C^2$  function  $\phi$  on some  $U \subset \mathbb{R}^{d-1}$ , and  $\Gamma_n$ is obtained by first triangulating *U* into  $(d-1)$ -dimensional simplices, denoted  $(s_{n,i})$ , then using the simplex  $\textsf{Fac}_{n,i}$  obtained as the convex hull of the set of points  $\hat{\phi}(v)$ , where *v* runs through the vertices of the simplex  $s_{n,i}$ , and for  $u \in U$  we set  $\hat{\phi}(u) = (u, \phi(u) - Kr_n^{3/2})$ .

For each  $i \leq m(n)$ , pick  $a_{n,i} \in s_{n,i}$ ; then the affine function  $h_{n,i}: s_{n,i} \to \mathbb{R}$  with graph  $\textsf{Fac}_{n,i}$  satisfies  $\nabla h_{n,i}(u) = \nabla h_{n,i}(a_{n,i})$  for all  $u \in s_{n,i}^o$ . By the Mean Value theorem, for  $u \in s_{n,i}$  and  $1 \leq j \leq d$ , we have  $\partial_j \phi(u) - \partial_j \phi(a_{n,i}) = \langle (u - a_{n,i}), \nabla \partial_j \phi(v) \rangle$ , for some  $v \in$  $[a_{n,i}, u]$ , and hence there is a constant *c* such that  $|(\|\nabla \phi(u)\|^2 - \|\nabla \phi(a_{n,i})\|^2)| \leq c\|u - a_{n,i}\|$ . Therefore with  $|\hat{\phi}(s_{n,i})|$  and  $|\textsf{Fac}_{n,i}|$  denoting the  $(d-1)$ -dimensional Hausdorff measure of  $\hat{\phi}(s_{n,i})$  and of  $\textsf{Fac}_{n,i}$ , respectively, we have for some new constants  $c, c'$  that

$$
\begin{aligned} |(|\hat{\phi}(s_{n,i})| - |\mathsf{Fac}_{n,i}|)| &= \Big| \int_{s_{n,i}} \left( \sqrt{1 + \|\nabla \phi(u)\|^2} - \sqrt{1 + \|\nabla h_{n,i}(u)\|^2} \right) du \Big| \\ &\leq c \int_{s_{n,i}} \left| \left( \|\nabla \phi(u)\|^2 - \|\nabla \phi(a_{n,i})\|^2 \right) \Big| du \leq c' r_n^{3/4} |s_{n,i}|. \end{aligned}
$$

Summing over the simplices leads to an approximation error of  $|(|\hat{\phi}(U_n)| - |\Gamma_n|)| \leq c r_n^{3/4}$ .

Next,  $|\text{BPri}_{n,i}|$  approximates  $|\text{Fac}_{n,i}|$  with an error of at most  $cr_n^{1+3(d-2)/4}$  and there are  $O(r_n^{3(1-d)/4})$  facets, so  $|\Gamma_n| - \sum_i |\text{BPri}_i| = O(r_n^{1/4})$ .

Also,  $\Gamma \setminus \hat{\phi}(U_n) = \hat{\phi}(U) \setminus \hat{\phi}(U_n)$  is a region within  $cr_n^{3/4}$  of the boundary of  $\partial \Gamma$  for a further constant *c*, so assuming  $\Gamma$  is 'nice' (in the sense described shortly before [\(4.16\)](#page-23-1)), this has  $(d-1)$ -dimensional Hausdorff measure that is  $O(r_n^{3/4})$ . Combining the last three estimates gives us [\(4.27\)](#page-26-0).

To prove [\(4.26\)](#page-25-1), we first notice that  $g(a) = \theta_{d-1} \int_0^a (1-t^2)^{(d-1)/2} dt$ ,  $0 \le a \le 1$ . Therefore, we have (i)  $g(0) = 0$ , *g* is increasing and  $g(a) \leq \theta_{d-1}a$ , (ii) for any  $\varepsilon \in (0, 1/2)$ there exists  $\delta \in (0,1)$  such that for all  $a \in (0,\delta)$ ,  $g(a) \geq (1-\varepsilon)\theta_{d-1}a$ , and (iii) upon choosing a smaller  $\delta$  in (ii), we also have  $g(a) \geq \theta_{d-1}(a - da^3)$  for  $a \in (0, \delta)$ . By item (i), we have

$$
nf_0\theta_{d-1}r_n^d \int_0^1 e^{-nf_0r_n^d g(a)}da \geq nf_0\theta_{d-1}r_n^d \int_0^1 e^{-nr_n^d f_0\theta_{d-1}a}da
$$
  
=  $1 - e^{-nf_0\theta_{d-1}r_n^d}$ .

Let  $\delta_n \in (0, \delta)$ . By item (iii), we have

$$
n f_0 \theta_{d-1} r_n^d \int_0^{\delta_n} e^{-n f_0 r_n^d g(a)} da \le n f_0 \theta_{d-1} r_n^d \int_0^{\delta_n} e^{-n f_0 \theta_{d-1} r_n^d a (1-d\delta_n^2)} da \le 1 + c \delta_n^2.
$$

By item (ii), we have

$$
nf_0\theta_{d-1}r_n^d \int_{\delta_n}^{\delta} e^{-nf_0r_n^dg(a)}da \leq nf_0\theta_{d-1}r_n^d \int_{\delta_n}^{\delta} e^{-nf_0r_n^d(1-\varepsilon)\theta_{d-1}a}da
$$
  

$$
\leq 2\exp(-nf_0r_n^d\theta_{d-1}(1-\varepsilon)\delta_n).
$$

Moreover, using  $(4.11)$  it is easy to see that for *n* large

$$
n f_0 \theta_{d-1} r_n^d \int_{\delta}^1 e^{-n f_0 r_n^d g(a)} da \le \exp(-n r_n^d f_0 g(\delta)/2)
$$

Combining these four estimates, using [\(4.11\)](#page-21-3) and choosing  $\delta_n = c(\log(n r_n^d))/(n r_n^d)$ with a big constant *c*, leads to

<span id="page-27-0"></span>
$$
nf_0\theta_{d-1}r_n^d \int_0^1 e^{-nf_0r_n^d g(a)}da = 1 + O\left(\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2\right).
$$
 (4.28)

Since the left side of [\(4.28\)](#page-27-0), multiplied by  $\theta_{d-1}^{-1} r_n^{1-d} e^{-n f_0 \theta_d r_n^d/2}$ , comes to the left side of [\(4.26\)](#page-25-1), [\(4.28\)](#page-27-0) yields [\(4.26\)](#page-25-1).

Combining [\(4.25\)](#page-25-2)–[\(4.27\)](#page-26-0), using [\(4.12\)](#page-22-4) and setting  $M_n := \bigcup_{i=1}^{m(n)} \text{Pri}_{n,i}$ , leads to

$$
I_n(M_n) = e^{-nf_0\theta r_n^d/2} \theta_{d-1}^{-1} r_n^{1-d} |\Gamma| (1 + O(r_n^{1/4})) \left(1 + O\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2\right) + O\left(nr_n^{3/2} e^{-nf_0\theta r_n^d/2}\right)
$$
  
= 
$$
e^{-nf_0\theta r_n^d/2} \theta_{d-1}^{-1} r_n^{1-d} |\Gamma| \left(1 + O\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2\right),
$$

where for the last line we used that by  $(4.11)$ ,  $\left(\frac{\log(nr_n^d)}{n^{rd}}\right)$  $nr_n^d$  $\int_0^2 = \Omega((\log n)^{-2})$  and  $nr_n^{d+1/2}$  =  $O(r_n^{1/4}) = o((\log n)^{-2}) = o\left(\left(\frac{\log n r_n^d}{(n r_n^d)}\right)\right)$  $\binom{2}{1}$ . Also by [\(4.23\)](#page-25-3), taking  $\kappa$  sufficiently close to 1/2 we have that

$$
I_n(\cup_{i=1}^{m(n)}\mathrm{Cor}_{n,i})/I_n(M_n)=O\Big(nr_n^{d+(1/4)}e^{nf_0\theta_d r_n^d(\frac{1}{2}-\kappa)}\Big)=o\Big(\Big(\frac{\log(nr_n^d)}{nr_n^d}\Big)^2\Big).
$$

Therefore

$$
I_n(\mathsf{Mo}_n) = I_n(M_n) + I_n(\cup_{i=1}^{m(n)} \mathsf{Cor}_{n,i}) = e^{-n f_0 \theta r_n^d / 2} \theta_{d-1}^{-1} r_n^{1-d} |\Gamma| \left( 1 + O\left( \left( \frac{\log(nr_n^d}{nr_n^d} \right)^2 \right) \right).
$$
\n(4.29)

*Step 5: putting together the contributions.* Recall that the set Γ was defined in Step 1, and consider now the region  $\Gamma^{(2r_n)} \cap A$ , where for  $s > 0$  we set  $\Gamma^{(s)} := \bigcup_{x \in \Gamma} B_s(x)$ . Most of this is covered by  $\mathsf{Mo}_n \cup \mathsf{Rain} \cup A^{(-r_n)}$ , the exception being a leftover region near  $\hat{\phi}(U \setminus U_n)$ , where for  $u \in U$  we set  $\hat{\phi}(u) = (u, \phi(u) - K r_n^{3/2})$  as before, that is covered by  $(\partial \Gamma)^{(9dr_n^{3/4})} \cap A$ . Using the fact that  $\Gamma$  is 'nice', it can be seen that  $|(\partial \Gamma)^{(9dr_n^{3/4})}| = O(r_n^{3/2})$ , and therefore given  $\kappa < 1/2$ , using Lemma [3.3](#page-10-6) we have

<span id="page-27-2"></span><span id="page-27-1"></span>
$$
I_n((\partial\Gamma)^{(9dr_n^{3/4})}\cap A)=O(r_n^{3/2}n\exp(-nf_0\kappa\theta r_n^d)).
$$

Hence, taking  $\kappa$  close to 1/2 and using [\(4.29\)](#page-27-1) we obtain that

$$
I_n((\partial\Gamma)^{(9dr_n^{3/4})}\cap A)/I_n(\mathsf{Mo}_n)=O(nr_n^{d+3/2}e^{f_0\theta nr_n^d((1/2)-\kappa)})=o\left(\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2\right).
$$
 (4.30)

Also by [\(4.22\)](#page-25-4),

$$
I_n(\text{Rai}_n)/I_n(\text{Mo}_n) = O(nr_n^{d+1/2}e^{nf_0\theta_d r_n^d((1/2)-\kappa)}) = o\left(\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2\right).
$$
 (4.31)

 $\text{Since } \mathsf{Mo}_n \cup \mathsf{Rai}_n \subset \Gamma^{(2r_n)} \subset \mathsf{Mo}_n \cup \mathsf{Rai}_n \cup (A^{(-r_n)} \setminus A^{(-2r_n)}) \cup ((\partial \Gamma)^{(9dr_n^{3/4})} \cap A), \text{ and since }$  $I_n(A^{(-r_n)} \setminus A^{(-2r_n)}) = O(r_n I_n(A^{(-r_n)}))$ , combining [\(4.29\)](#page-27-1), [\(4.30\)](#page-27-2) and [\(4.31\)](#page-28-1) shows that

<span id="page-28-2"></span>
$$
I_n(\Gamma^{(2r_n)}) = e^{-n f_0 \theta r_n^d/2} \theta_{d-1}^{-1} r_n^{1-d} |\Gamma| \left( 1 + O\left( \left( \frac{\log(nr_n^d)}{nr_n^d} \right)^2 \right) \right) + o(r_n I_n(A^{(-r_n)})). \tag{4.32}
$$

Now suppose  $y \in \Gamma$  and  $z \in \partial A \setminus \Gamma$  with  $||y - z|| \leq 4r_n$ . Then  $||\pi(y) - \pi(z)|| \leq 4r_n$ . Also  $\pi(y) \in U$  and  $\pi(z) \in \mathbb{R}^{d-1} \setminus U$ , and hence dist $(\pi(y), \partial U) \leq 4r_n$ . Hence using [\(4.19\)](#page-24-1) we have dist $(y, \partial \Gamma) \leq 5r_n$ .

Using [\(4.15\)](#page-23-2), we can find a finite collection of sets  $\Gamma_1, \ldots, \Gamma_J$  each having the properties of the  $\Gamma$  we have just been considering, such that  $\partial A \subset \bigcup_{i=1}^{J} \Gamma_i$  and  $\Gamma_1, \ldots, \Gamma_J$  have disjoint interiors (see [\[10\]](#page-52-7) for further details). Then for  $i \neq j$ , if  $x \in \Gamma_i^{(2r_n)} \cap \Gamma_j^{(2r_n)}$  $j^{(2r_n)}$  then there exist  $y \in \Gamma_i$  and  $z \in \Gamma_j$  with  $||y - x|| \leq 2r_n$  and  $|z - x|| \leq 2r_n$ , so  $||y - z|| \leq 4r_n$ , so that  $dist(y, \partial \Gamma_i) \leq 5r_n$  and  $dist(x, \partial \Gamma_i) \leq 7r_n$ . Hence

<span id="page-28-3"></span><span id="page-28-1"></span>
$$
\Gamma_i^{(2r_n)} \cap \Gamma_j^{(2r_n)} \subset (\partial \Gamma_i)^{(7r_n)}.
$$

Hence, using the union bound and the Bonferroni lower bound for the measure  $I_n(\cdot)$ , and [\(4.30\)](#page-27-2), we obtain that

$$
\sum_{i=1}^{J} I_n(\Gamma_i^{(2r_n)}) \geq I_n(\cup_{i=1}^{J} \Gamma_i^{(2r_n)}) \geq \sum_{i=1}^{J} I_n(\Gamma_i^{(2r_n)}) - o\left(\left(\frac{\log(nr_n^d}{nr_n^d}\right)^2 I_n(\mathsf{Mo}_n)\right).
$$

Then using [\(4.32\)](#page-28-2) we obtain that

$$
I_n(A \setminus A^{(-2r_n)}) = I_n(\bigcup_{i=1}^J \Gamma_i^{(2r_n)}) = e^{-n f_0 \theta r_n^d / 2} \theta_{d-1}^{-1} r_n^{1-d} |\partial A| \left( 1 + o\left( \left( \frac{\log(nr_n^d)}{nr_n^d} \right)^2 \right) \right) + O(r_n I_n(A^{(-r_n)})). \tag{4.33}
$$

The error term in the last expression satisfies

$$
\frac{r_n I_n(A^{(-r_n)})}{e^{-n\theta f_0 r_n^d/2} r_n^{1-d}} = O(n r_n^d e^{-n\theta f_0 r_n^d/2}) = O\left(\left(\frac{\log(n r_n^d)}{n r_n^d}\right)^2\right),
$$

Also the error term in [\(4.21\)](#page-24-2) satisfies a similar bound. Thus combining [\(4.33\)](#page-28-3) with [\(4.21\)](#page-24-2) shows that [\(4.14\)](#page-22-2) holds.  $\Box$ 

# <span id="page-28-0"></span>**5 Proof of first-order asymptotics**

Throughout this section we make the same assumptions on *ν* and *A* that we set out at the start of Section [3.](#page-9-0) We also assume that [\(4.1\)](#page-17-1) and [\(4.2\)](#page-17-2) hold, i.e. that  $nr_n^d \to \infty$  and  $\liminf(I_n) > 0$  as  $n \to \infty$ .

We shall prove that if  $\xi_n$  denotes any of  $K_n - 1, K'_n - 1, R_n$  or  $R'_n$ , then both  $\mathbb{E}[\xi_n]$ and  $\mathbb{V}\text{ar}[\xi_n]$  are asymptotic to  $I_n$  (which was defined at [\(2.1\)](#page-5-2)) as  $n \to \infty$ ; we will then be able to prove the first-order convergence results from Section [2,](#page-4-0) i.e. Theorems [2.1,](#page-5-1) [2.3,](#page-6-2) [2.4](#page-6-1) and [2.7.](#page-7-1)

To achieve this goal, we shall consider separately the contributions to  $\xi_n$  from nonsingleton components of  $G(\mathcal{X}_n, r_n)$  or  $G(\mathcal{P}_n, r_n)$  that are small, medium or large. Here, given fixed  $\rho > \varepsilon > 0$ , we say a component is *small* (respectively *medium*, *large*) if its Euclidean diameter is less than  $\varepsilon r_n$  (resp., between  $\varepsilon r_n$  and  $\rho r_n$ , greater than  $\rho r_n$ ). We shall make appropriate choices of the constants  $\varepsilon$ ,  $\rho$  as we go along.

For finite  $\mathcal{X} \subset \mathbb{R}^d$ ,  $x \in \mathcal{X}$ , and  $n \geq 1$  we let  $\mathscr{F}_n(x, \mathcal{X})$  denote the event that x is the first element of  $\mathcal{C}_{r_n}(x,\mathcal{X})$  (defined in Section [3.3\)](#page-12-0) in the  $\prec$  ordering (defined in Section [3.1\)](#page-10-0), i.e.

<span id="page-29-3"></span><span id="page-29-2"></span>
$$
\mathscr{F}_n(x,\mathcal{X}) := \{ x \prec y \ \forall \ y \in \mathcal{C}_{r_n}(x,\mathcal{X}) \setminus \{x\} \}. \tag{5.1}
$$

Given *n* and  $(r_n)_{n\geq 1}$ , for  $0 \leq \varepsilon < \rho \leq \infty$  we define  $K_{n,\varepsilon,\rho}(\mathcal{X})$  to be the number of components of  $G(\mathcal{X}, r_n)$  that have Euclidean diameter in the range  $(\varepsilon r_n, \rho r_n]$ , and  $R_{n,\varepsilon,\rho}$ to be the number of vertices in such components, that is, with event  $\mathscr{M}_{n,\varepsilon,\rho}(x,\mathcal{X})$  defined at [\(3.14\)](#page-14-2),

$$
K_{n,\varepsilon,\rho}(\mathcal{X}) := \sum_{x \in \mathcal{X}} \mathbf{1}_{\mathcal{M}_{n,\varepsilon,\rho}(\mathcal{X}) \cap \mathscr{F}_n(x,\mathcal{X})}; \qquad R_{n,\varepsilon,\rho}(\mathcal{X}) := \sum_{x \in \mathcal{X}} \mathbf{1}_{\mathcal{M}_{n,\varepsilon,\rho}(x,\mathcal{X})}.
$$
 (5.2)

We then define the random variables  $K_{n,\varepsilon,\rho} := K_{n,\varepsilon,\rho}(\mathcal{X}_n)$  and  $K'_{n,\varepsilon,\rho} := K_{n,\varepsilon,\rho}(\mathcal{P}_n)$ . Also we set  $R_{n,\varepsilon,\rho} := R_{n,\varepsilon,\rho}(\mathcal{X}_n)$  and  $R'_{n,\varepsilon,\rho} := R_{n,\varepsilon,\rho}(\mathcal{P}_n)$ .

#### <span id="page-29-0"></span>**5.1 Asymptotics of means**

We shall bound the expected number of 'small' non-singleton components,  $\mathbb{E}[K_{n,0,\varepsilon}]$ , using the following lemma.

<span id="page-29-1"></span>**Lemma 5.1.** *There exist*  $\delta_4 \in (0,1)$  *and*  $c, n_0 < \infty$  *such that for all*  $n \geq n_0$  *and any x* ∈ *A,*

$$
\mathbb{P}[\mathscr{F}_n(x,\mathcal{P}_n) \cap \{0 < \operatorname{diam}(\mathcal{C}_{r_n}(x,\mathcal{P}_n)) \le \delta_4 r_n\}] \le c(n r_n^d)^{1-d} e^{-n\nu(B_{r_n}(x))};\tag{5.3}
$$

$$
\mathbb{P}[\mathscr{F}_n(x,\mathcal{X}_{n-1}) \cap \{0 < \operatorname{diam}(\mathcal{C}_{r_n}(x,\mathcal{X}_{n-1})) \le \delta_4 r_n\}] \le c(n r_n^d)^{1-d} e^{-n\nu(B_{r_n}(x))}.\tag{5.4}
$$

*Proof.* See [\[11,](#page-52-2) Lemma 4.2(i)], taking  $k = 1$  there. Note that a 0-separating set in X (as it is called in [\[11\]](#page-52-2)) is simply a component of  $G(\mathcal{X}, r_n)$ . Note also that if  $A = [0, 1]^2$  the proof of [\[11,](#page-52-2) Lemma 4.2(i)] remains applicable, using Lemma [3.1](#page-10-3) of the present paper.  $\Box$ 

We shall bound the expected number of 'medium-sized' non-singleton components,  $\mathbb{E}[K_{n,\varepsilon,\rho}]$ , using the following two lemmas (here we use notation such as  $\mathcal{X}^x$  from [\(3.13\)](#page-14-3) and  $\mathscr{M}_{n,\varepsilon,K}(x,\mathcal{X})$  from  $(3.14)$ ).

<span id="page-30-6"></span>**Lemma 5.2.** Let  $\varepsilon, \rho \in (0, \infty)$  with  $\varepsilon < \rho$ . Then there exists  $\delta > 0$  such that for all n *large and all distinct*  $x, y, z \in A$ *, we have:* 

<span id="page-30-4"></span><span id="page-30-3"></span><span id="page-30-2"></span><span id="page-30-1"></span><span id="page-30-0"></span>
$$
\mathbb{P}[\mathscr{F}_n(x,\mathcal{P}_n^x)\cap\mathscr{M}_{n,\varepsilon,\rho}(x,\mathcal{P}_n)]\leq e^{-n\nu(B_{r_n}(x))-\delta nr_n^d};\tag{5.5}
$$

$$
\mathbb{P}[\mathcal{F}_n(x, \mathcal{P}_n^{x,y}) \cap \mathcal{M}_{n,\varepsilon,\rho}(x, \mathcal{P}_n^y)] \le e^{-n\nu(B_{r_n}(x)) - \delta n r_n^d};\tag{5.6}
$$

$$
\mathbb{P}[\mathscr{F}_n(x,\mathcal{P}_n^{x,y,z}) \cap \mathscr{M}_{n,\varepsilon,\rho}(x,\mathcal{P}_n^{y,z})] \le e^{-n\nu(B_{r_n}(x)) - \delta n r_n^d};\tag{5.7}
$$

$$
\mathbb{P}[\mathscr{F}_n(x, \mathcal{X}_{n-1}^x) \cap \mathscr{M}_{n, \varepsilon, \rho}(x, \mathcal{X}_{n-1})] \le e^{-n\nu(B_{r_n}(x)) - \delta n r_n^d};\tag{5.8}
$$

$$
\mathbb{P}[\mathcal{F}_n(x, \mathcal{X}_{n-2}^{x,y}) \cap \mathcal{M}_{n,\varepsilon,\rho}(x, \mathcal{X}_{n-2}^y)] \le e^{-n\nu(B_{r_n}(x)) - \delta n r_n^d}.
$$
\n(5.9)

*Proof.* See [\[11,](#page-52-2) Lemma 4.3], taking the parameter *k* there to be 1, for a proof of [\(5.5\)](#page-30-0) and [\(5.8\)](#page-30-1). The results [\(5.6\)](#page-30-2), [\(5.7\)](#page-30-3) and [\(5.9\)](#page-30-4) are proved similarly. In the case where  $A = [0, 1]^2$ , [\[11,](#page-52-2) Lemma 4.3] applies only when *x* is not too close to any of the corners of *A*, but the remaining cases can be proved by a similar argument using [\[7,](#page-52-0) Proposition 5.15].  $\Box$ 

<span id="page-30-5"></span>**Lemma 5.3** (Bound on means for moderately large components). There exists  $\rho_1 \in$  $(1,\infty)$  such that  $\mathbb{E}[R_{n,\rho_1,(\log n)^2}] = O(e^{-nr_n^d}I_n)$  and  $\mathbb{E}[R'_{n,\rho_1,(\log n)^2}] = O(e^{-nr_n^d}I_n)$  as  $n \to \infty$ , *where*  $I_n$  *is defined at*  $(2.1)$ *.* 

*Proof.* Let  $\rho > 4$ . Given  $i \in [n] := \{1, \ldots, n\}$ , if  $\rho r_n < \text{diam}(\mathcal{C}_{r_n}(X_i, \mathcal{X}_n)) \leq (\log n)^2 r_n$ , then there is at least one component of  $G(\mathcal{X}_{n-1}, r_n)$  with at least one vertex in  $B_{r_n}(X_i)$ and with diameter in the range  $((\rho - 4)r_n/2, (\log n)^2 r_n]$ . Hence by the definition at [\(3.15\)](#page-14-4),

$$
\mathbb{E}[R_{n,\rho,(\log n)^2}] \le n \int_A \mathbb{P}[\mathscr{M}_{n,(\rho-4)/2,(\log n)^2}^*(x,\mathcal{X}_{n-1})] \nu(dx).
$$

Hence by Lemma [3.8](#page-14-5) we can choose *ρ* such that for *n* large

$$
\mathbb{E}[R_{n,\rho,(\log n)^2}] \le n \exp(-(\theta f_0 + 2)nr_n^d),
$$

and hence using Lemma [4.1](#page-18-3) we have the result claimed for  $\mathbb{E}[R_{n,\rho,(\log n)^2}]$ . The result for  $\mathbb{E}[R'_{n,\rho,(\log n)^2}]$ , is proved similarly, using the Mecke formula.  $\Box$ 

We shall approximate  $R_n$  with  $S_n + R_{n,0,(log n)^2}$  and  $K_n$  with  $S_n + K_{n,0,(log n)^2} + 1$ .

<span id="page-30-7"></span>**Lemma 5.4.** Let  $K > 0$ . Then all of  $\mathbb{P}[R_n \neq S_n + R_{n,0,(\log n)^2}]$ ,  $\mathbb{P}[R'_n \neq S'_n + R'_{n,0,(\log n)^2}]$ ,  $\mathbb{P}[K_n \neq S_n + K_{n,0,(\log n)^2} + 1]$  and  $\mathbb{P}[K'_n \neq S'_n + K'_{n,0,(\log n)^2} + 1]$  are  $O(n^{-K}I_n e^{-nr_n^d})$  as  $n \to \infty$ *.* 

*Proof.* By the assumption  $\liminf(I_n) > 0$  and Proposition [2.2](#page-6-4) we have  $nr_n^d = O(\log n)$ as  $n \to \infty$ . Hence for some  $\alpha > 0$ , we have  $I_n e^{-n r_n^d} > n^{-\alpha}$  for all large *n*. Therefore it suffices to prove that for any  $K > 0$ , the probabilities under consideration are  $O(n^{-K})$  as  $n \to \infty$ .

Define event  $\tilde{\mathscr{U}}_n$  as in Lemma [3.7,](#page-13-4) taking  $\phi_n = (\log n)^2$ . Then recalling the definition of  $\mathcal{L}_n(\mathcal{X})$  just before Lemma [3.10,](#page-16-3) we have the event inclusion

$$
\{R_n \neq S_n + R_{n,0,(\log n)^2}\} \cup \{K_n \neq S_n + K_{n,0,(\log n)^2} + 1\} \subset \tilde{\mathscr{U}}_n^c \cup \{\text{diam}(\mathcal{L}_n(\mathcal{X}_n)) \leq (\log n)^2 r_n\}.
$$

By Lemma [3.7,](#page-13-4) there is a constant *c* such that  $\mathbb{P}[\tilde{\mathscr{U}}_n^c] \leq \exp(-c(\log n)^2 nr_n^d)$  for *n* large. Combining this with [\(3.18\)](#page-16-2) from Lemma [3.10](#page-16-3) (which is applicable because  $nr_n^d = O(\log n)$ as mentioned already) gives us the results for  $R_n$  and  $K_n$ , and the results for  $R'_n$  and  $K'_n$ are proved similarly.

<span id="page-31-4"></span>**Proposition 5.5** (Approximation of  $K_n$  by  $S_n + 1$ ,  $K'_n$  by  $S'_n + 1$ ). As  $n \to \infty$  we have

$$
\max(\mathbb{E}[|K'_n - S'_n - 1|], \mathbb{E}[|K_n - S_n - 1|]) = O((nr_n^d)^{1-d}I_n). \tag{5.10}
$$

*Proof.* Take  $\delta_4$  as in Lemma [5.1](#page-29-1) and  $\rho_1$  as in Lemma [5.3.](#page-30-5) Then  $K'_n - S'_n = K'_{n,0,\delta_4} +$  $K'_{n,\delta_4,\rho_1} + K'_{n,\rho_1,(\log n)^2} + K'_{n,(\log n)^2,\infty}$ . Taking expectations and using the Mecke formula, we obtain that

$$
\mathbb{E}[|K'_n - S'_n - 1|] \le n \int_A \mathbb{P}[\mathcal{F}_n(x, \mathcal{P}_n) \cap \{0 < \operatorname{diam}(\mathcal{C}_{r_n}(x, \mathcal{P}_n)) \le \delta_4 r_n\}] \nu(dx)
$$
  
+ 
$$
\int_A \mathbb{P}[\mathcal{F}_n(x, \mathcal{P}_n) \cap \{\delta_4 r_n < \operatorname{diam}(\mathcal{C}_{r_n}(x, \mathcal{P}_n)) \le \rho_1 r_n\}] n \nu(dx)
$$
  
+ 
$$
\mathbb{E}[K'_{n, \rho_1, (\log n)^2}] + \mathbb{E}[|K'_{n, (\log n)^2, \infty} - 1|].
$$
 (5.11)

By Lemma [5.1,](#page-29-1) the first term in the right hand side of  $(5.11)$  is  $O((nr_n^d)^{1-d}I_n)$ . By Lemma [5.2](#page-30-6) there exists  $\delta > 0$  such that the second term in the right hand side of [\(5.11\)](#page-31-0) is at most  $e^{-\delta n r_n^d} I_n$  for all large enough *n*. By Lemma [5.3,](#page-30-5) the third term in the right hand side is  $O(e^{-nr_n^d}I_n)$ . For the fourth term, recalling  $\#(\mathcal{P}_n) = Z_n$  is Poisson with mean *n*, we use the Cauchy-Schwarz inequality, and then Lemma [5.4,](#page-30-7) to deduce that

$$
\mathbb{E}[|K'_{n,(\log n)^2,\infty}-1|] \leq (\mathbb{E}[Z_n^2+1])^{1/2}(\mathbb{P}[K'_{n,(\log n)^2,\infty} \neq 1])^{1/2} = O(e^{-nr_n^d}I_n).
$$

Combining these estimates shows that  $\mathbb{E}[|K'_n - S'_n - 1|] = O((nr_n^d)^{1-d}I_n)$ . The proof that  $\mathbb{E}[|K_n - S_n - 1|] = O((nr_n^d)^{1-d}I_n)$  is similar, and thus we have [\(5.10\)](#page-31-1).

<span id="page-31-3"></span>**Lemma 5.6.** *Suppose*  $\delta_1, \delta_4$  *are as in Lemma [3.1,](#page-10-3) Lemma [5.1](#page-29-1) respectively, and*  $0 < \rho <$  $\min(\frac{1}{2}, \delta_4, (\delta_1 f_0/(f_{\text{max}}\theta))^{1/(d-1)})$ *. Then as*  $n \to \infty$ *, we have*

\max(\mathbb{E}[R_{n,0,\rho}], \mathbb{E}[R'_{n,0,\rho}]) = O((nr_n^d)^{1-d}I_n). \tag{5.12}
$$

*Proof.* If the interpoint distances of  $\mathcal{X}_n$  are all distinct and non-zero (an event of probability 1), then  $R_{n,0,\rho} = K_{n,0,\rho} + N_{n,1} + N_{n,2}$ , where we set

$$
N_{n,1} := \sum_{(i,j)\in[n]\times[n]:i\neq j} \mathbf{1}(\mathscr{F}_n(X_i,\mathcal{X}_n) \cap \{0 < \operatorname{diam}(\mathcal{C}_{r_n}(X_i,\mathcal{X}_n)) \le \rho r_n\} \cap \{X_j \in \mathcal{C}_{r_n}(X_i,\mathcal{X}_n)\}
$$

$$
\cap \{||X_j - X_i|| = \max_{x \in \mathcal{C}_{r_n}(X_i,\mathcal{X}_n)} ||x - X_i||\},
$$

and

$$
N_{n,2} := \sum_{(i,j,k)\in[n]\times[n]\times[n]:i\neq j\neq k\neq i} \mathbf{1}(\mathscr{F}_n(X_i,\mathcal{X}_n) \cap \{0 < \operatorname{diam}(\mathcal{C}_{r_n}(X_i,\mathcal{X}_n)) \leq \rho r_n\} \cap \{\{X_j,X_k\} \subset \mathcal{C}_{r_n}(X_i,\mathcal{X}_n)\} \cap \{\|X_j - X_i\| = \max_{x \in \mathcal{C}_{r_n}(X_i,\mathcal{X}_n)} \|x - X_i\|\}.
$$

Using Lemma [5.1](#page-29-1) and the Mecke formula as in [\(5.11\)](#page-31-0), we have that

$$
\mathbb{E}[K_{n,0,\rho}] = O((nr_n^d)^{1-d} I_n). \tag{5.13}
$$

Recall the notation  $A_x := \{y \in A : x \prec y\}$ . By assumption  $f_{\text{max}}\theta\rho^{d-1} < \delta_1 f_0$ , so by Lemma [3.1,](#page-10-3) for *n* large and  $x \in A, y \in B(x, \rho r_n) \cap A_x$  we have  $\nu(B_{r_n}(y) \setminus B_{r_n}(x)) \ge$  $2\delta_1 f_0 r_n^{d-1} \|y-x\|$  and  $\nu(B_{\|y-x\|}(x)) \le f_{\max}\theta \|y-x\|^d \le \delta_1 f_0 r_n^{d-1} \|y-x\|$ . Hence

$$
\mathbb{E}[N_{n,1}] \leq n^2 \int_A \int_{B(x,\rho r_n) \cap A_x} (1 - \nu[(B_{r_n}(x) \cup B_{r_n}(y)) \setminus B_{\|y-x\|}(x)])^{n-2} \nu(dy) \nu(dx)
$$
  
\n
$$
\leq 2n^2 \int_A \int_{B(x,\rho r_n) \cap A_x} e^{-n(\nu(B_{r_n}(x)) + \nu(B_{r_n}(y) \setminus B_{r_n}(x)) - \nu(B_{\|y-x\|}(x)))} \nu(dy) \nu(dx)
$$
  
\n
$$
\leq 2n \int_A \left( \int_{B(x,\rho r_n) \cap A_x} n e^{-n\nu(B_{r_n}(x)) - n\delta_1 f_0 r_n^{d-1} \|y-x\|} \nu(dy) \right) \nu(dx).
$$

In the last expression the inner integral can be bounded by

$$
ne^{-n\nu(B_{r_n}(x))}\int_{B(o,\rho r_n)} e^{-\delta_1 f_0 nr_n^{d-1}||u||} f_{\max} du = (nr_n^d)^{1-d} e^{-n\nu(B_{r_n}(x))}\int_{B(o,\rho nr_n^d)} e^{-\delta_1 f_0||v||} f_{\max} dv
$$

and therefore

$$
\mathbb{E}[N_{n,1}] = O((nr_n^d)^{1-d} I_n). \tag{5.14}
$$

Next, using Lemma [3.1](#page-10-3) and the inequality  $f_{\text{max}}\theta \rho^{d-1} < \delta_1 f_0$  again we have that

$$
\mathbb{E}[N_{n,2}] \leq n^3 \int_A \int_{B(x,\rho r_n) \cap A_x} \int_{B(x,||y-x||)} (1 - \nu[(B_{r_n}(x) \cup B_{r_n}(y)) \setminus B_{||y-x||}(x)])^{n-3} \nu(dz) \nu(dy) \nu(dx)
$$
  

$$
\leq 2n\theta_d f_{\max} \int_A \left( \int_{B(x,\rho r_n) \cap A_x} n^2 ||y-x||^d \exp(-n\nu(B_{r_n}(x)) - n\delta_1 f_0 r_n^{d-1} ||y-x||) \nu(dy) \right) \nu(dx).
$$

In the last expression the inner integral can be bounded by

$$
n^2 e^{-n\nu(B_{r_n}(x))} \int_{B(o,\rho r_n)} ||u||^d e^{-\delta_1 f_0 n r_n^{d-1} ||u||} f_{\text{max}} du
$$
  
= 
$$
(n r_n^d)^{2-2d} e^{-n\nu(B_{r_n}(x))} \int_{B(o,\rho n r_n^d)} ||v||^d e^{-\delta_1 f_0 ||v||} f_{\text{max}} dv,
$$

and therefore

$$
\mathbb{E}[N_{n,2}] = O((nr_n^d)^{2-2d}I_n).
$$

Combined with [\(5.13\)](#page-32-0) and [\(5.14\)](#page-32-1) this shows that  $\mathbb{E}[R_{n,0,\rho}] = O((nr_n^d)^{1-d}I_n)$ , which is the statement about  $\mathbb{E}[R_{n,0,\rho}]$  in [\(5.12\)](#page-31-2). The corresponding statement for  $\mathbb{E}[R'_{n,0,\rho}]$  is proved similarly using the multivariate Mecke formula.  $\Box$ 

For  $0 < \varepsilon < \rho < \infty$ , recall the definition of event  $\mathscr{M}_{n,\varepsilon,\rho}(x,\mathcal{X})$  at [\(3.14\)](#page-14-2). To deal with the medium-sized componenents, we shall use the following estimate for the integral of  $\mathbb{P}[\mathscr{M}_{n,\varepsilon,\rho}(x,\xi_n)]$  with  $\xi_n = \mathcal{P}_n$  or  $\xi_n = \mathcal{X}_{n-1}$ . We use notation  $\mathcal{X}^x$  from [\(3.13\)](#page-14-3).

<span id="page-33-3"></span>**Lemma 5.7** (Estimate on medium clusters). Let  $\rho, \varepsilon \in (0, \infty)$  with  $\rho > \varepsilon$ . Then there *exists*  $\delta = \delta(\varepsilon)$  *in*  $(0, \infty)$  *such that as*  $n \to \infty$ *, we have*

n\int_{A} \mathbb{P}[\mathcal{M}_{n,\varepsilon,\rho}(x,\mathcal{X}_{n-1})] \nu(dx) = O(e^{-\delta nr_n^d} I_n).
$$
 (5.16)

*Proof.* If  $\mathscr{M}_{n,\varepsilon,\rho}(x,\mathcal{P}_n) \setminus \mathscr{F}_n(x,\mathcal{P}_n^x)$  occurs then for at least one  $y \in \mathcal{P}_n \cap B_{\rho r_n}(x)$  we have that  $\text{diam}(\mathcal{C}_{r_n}(y,\mathcal{P}_n^{x,y})) \in (\varepsilon r_n, \rho r_n],$  and moreover  $\mathscr{F}_n(y,\mathcal{P}_n^{x,y})$  occurs and  $x \in \mathcal{C}_{r_n}(y,\mathcal{P}_n^{x,y}).$ By Markov's inequality and the Mecke formula,

$$
n\int_{A} \mathbb{P}[\mathcal{M}_{n,\varepsilon,\rho}(x,\mathcal{P}_n) \setminus \mathcal{F}_n(x,\mathcal{P}_n^x)]\nu(dx) \leq n^2 \int_{A} \int_{A \cap B_{\rho r_n}(x)} \mathbb{P}[\mathcal{M}_{n,\varepsilon,\rho}(y,\mathcal{P}_n^x) \cap \mathcal{F}_n(y,\mathcal{P}_n^{x,y})\nu(dx).
$$
  

$$
\bigcap \{x \in C_{r_n}(y,\mathcal{P}_n^{x,y})\}\big] \nu(dy)\nu(dx).
$$

By [\(5.6\)](#page-30-2) from Lemma [5.2,](#page-30-6) there exists  $\delta > 0$  such that for *n* large the probability inside the integral on the right of the last display is bounded above by  $\exp(-n\nu(B_{r_n}(y)) - 2\delta nr_n^d)$ . Then using Fubini's theorem we obtain that for *n* large

$$
n\int_{A} \mathbb{P}[\mathcal{M}_{n,\varepsilon,\rho}(x,\mathcal{P}_n) \setminus \mathcal{F}_n(x,\mathcal{P}_n^x)]\nu(dx) \leq n^2 \int_{A} \nu(B_{\rho r_n}(y)) \exp(-n\nu(B_{r_n}(y)) - 2\delta n r_n^d)\nu(dy)
$$

$$
= O(n r_n^d I_n e^{-2\delta n r_n^d}) = O(e^{-\delta n r_n^d} I_n). \tag{5.17}
$$

Also using Lemma [5.2](#page-30-6) we obtain that

$$
n\int_{A} \mathbb{P}[\mathcal{M}_{n,\varepsilon,\rho}(x,\mathcal{P}_n) \cap \mathcal{F}_n(x,\mathcal{P}_n^x)] \nu(dx) \le n \int_{A} \exp(-n\nu(B_{r_n}(x)) - \delta n r_n^d) \nu(dx)
$$
  
=  $e^{-\delta n r_n^d} I_n$ ,

and combined with [\(5.17\)](#page-33-0) this yields [\(5.15\)](#page-33-1).

The proof of [\(5.16\)](#page-33-2) is similar.

We are now ready to estimate the asymptotic expected values of  $R_n$  and  $R'_n$ .

<span id="page-33-7"></span>**Proposition 5.8** (Approximation of  $R_n$ ,  $R'_n$  by  $S_n$ ,  $S'_n$ ). As  $n \to \infty$  we have that

$$
\mathbb{E}[|R_n - S_n|] = O((nr_n^d)^{1-d} I_n); \tag{5.18}
$$

<span id="page-33-6"></span><span id="page-33-5"></span><span id="page-33-4"></span><span id="page-33-0"></span> $\Box$ 

$$
\mathbb{E}[|R'_n - S'_n|] = O((nr_n^d)^{1-d} I_n). \tag{5.19}
$$

*Proof.* Note that  $|R_n - S_n - R_{n,0,(\log n)^2}| \leq n$ . Hence by Lemma [5.4,](#page-30-7)

$$
\mathbb{E}[|R_n - S_n - R_{n,0,(\log n)^2}|] \le n \mathbb{P}[R_n \ne S_n + R_{n,0,(\log n)^2}] = O(e^{-nr_n^d}I_n). \tag{5.20}
$$

Using Lemma [5.6,](#page-31-3) choose  $\varepsilon \in (0,1)$  such that  $\mathbb{E}[R_{n,0,\varepsilon}] = O((nr_n^d)^{1-d}I_n)$ . Using Lemma [5.3,](#page-30-5) choose  $\rho \in (1, \infty)$  such that  $\mathbb{E}[R_{n,\rho,(\log n)^2}] = O(e^{-nr_n^d}I_n)$ . By Lemma [5.7,](#page-33-3) there exists  $\delta > 0$  such that

$$
\mathbb{E}[R_{n,\varepsilon,\rho}] = n \int_A \mathbb{P}[\varepsilon r < \operatorname{diam} \mathcal{C}_{r_n}(x, \mathcal{X}_{n-1}^x) \le \rho r_n] \nu(dx) = O(e^{-n\delta r_n^d} I_n).
$$

Combining these estimates shows that  $\mathbb{E}[R_{n,0,(log n)^2}] = O((nr_n^d)^{1-d}I_n)$ . Then using [\(5.20\)](#page-33-4) yields [\(5.18\)](#page-33-5).

The proof of [\(5.19\)](#page-33-6) is similar; the only difference is that in the step of the argument corresponding to [\(5.20\)](#page-33-4) we use the inequality  $|R'_n - S'_n - R'_{n,0,(log n)^2}| \le Z_n \mathbf{1}{R'_n \ne S'_n + R'_n}$  $R'_{n,0,(\log n)^2}$  and the Cauchy-Schwarz inequality.

### <span id="page-34-0"></span>**5.2 Proof of first order limit theorems**

*Proof of Theorem [2.1.](#page-5-1)* By Proposition [5.5](#page-31-4) we have

$$
\mathbb{E}[K'_n - 1] = \mathbb{E}[S'_n] + \mathbb{E}[K'_n - 1 - S'_n] = I_n(1 + O(nr_n^d)^{1-d}).
$$

By Proposition [5.5](#page-31-4) and Lemma [4.3](#page-19-0) we also have  $\mathbb{E}[K_n - 1] = I_n(1 + O(n r_n^d)^{1-d})$ . By Proposition [5.8](#page-33-7) we have  $\mathbb{E}[R'_n] = I_n(1 + O(nr_n^d)^{1-d})$ . By Proposition 5.8 and Lemma [4.3](#page-19-0) we have  $\mathbb{E}[R_n] = \mathbb{E}[S_n] + O((nr_n^d)^{1-d}I_n) = I_n(1 + O(nr_n^d)^{1-d})$ . Thus we have [\(2.2\)](#page-5-4).

For [\(2.3\)](#page-5-5), suppose for now that  $\zeta_n$  is  $K_n - 1$  or  $R_n$ . Recalling that  $\tilde{I}_n := \mathbb{E}[S_n]$ , we note that

$$
\mathbb{E}[|(\zeta_n/I_n) - 1|] \le \mathbb{E}[I_n^{-1}|\zeta_n - S_n|] + \mathbb{E}[I_n^{-1}|S_n - \tilde{I}_n|] + I_n^{-1}|\tilde{I}_n - I_n|. \tag{5.21}
$$

By Proposition [5.5](#page-31-4) (when  $\zeta_n = K_n - 1$ ) or Proposition [5.8](#page-33-7) (when  $\zeta_n = R_n$ ) we have  $\mathbb{E}[\zeta_n S_n$ <sup>[]</sup> =  $O((nr_n^d)^{1-d}I_n)$ , so the first term in the right hand side of [\(5.21\)](#page-34-1) is  $O((nr_n^d)^{1-d})$ . Moreover by the Cauchy-Schwarz inequality the second term in the right hand side of  $(5.21)$  is bounded by  $(I_n^{-2} \text{Var}(S_n))^{1/2}$ , and by Proposition [4.5](#page-20-1) this is  $O(I_n^{-1/2})$ . The third term in the right hand side of  $(5.21)$  is  $O((nr_n^d)^{1-d})$  by Lemma [4.3.](#page-19-0) Thus we have  $(2.3)$ when  $\zeta_n$  is  $K_n - 1$  or  $R_n$ , and the corresponding result when  $\zeta_n$  is  $K'_n - 1$  or  $R'_n$  can be proved similarly. Finally if we add 1 to  $\zeta_n$  then we should add a term of  $1/I_n$  on the right hand side of [\(5.21\)](#page-34-1), but this term is  $o(I_n^{-1/2})$  so we have [\(2.3\)](#page-5-5) when  $\zeta_n$  is  $K_n, R_n + 1, K'_n$ or  $R'_n + 1$  too.  $\Box$ 

*Proof of Theorem [2.3.](#page-6-2)* Since we assume  $I_n \to \infty$ , by Proposition [2.2](#page-6-4) we have  $b^+ \leq b_c$ . Suppose also  $b^+ \leq b'_c$ . Let  $\delta > 0$ . Then by Lemma [4.1,](#page-18-3)

$$
ne^{-n\theta f_0 r_n^d (1+\delta)} = o(I_n).
$$
\n(5.22)

For an upper bound on  $I_n$ , we shall use Lemma [4.2.](#page-18-4) Let  $\varepsilon > 0$  with  $f_1 \varepsilon < f_0 \delta$ . Since *b*<sup>+</sup> ≤ *b*<sup>'</sup><sub>*c*</sub> we have *b*<sup>+</sup>(*f*<sub>0</sub> − *f*<sub>1</sub>/2) ≤ 1/*d*, and hence

$$
\frac{n^{1-1/d}e^{-n\theta r_n^d f_1(\frac{1}{2}-\varepsilon)}}{n e^{-n\theta f_0 r_n^d (1-2\delta)}} = O(n^{-1/d}e^{n\theta r_n^d (f_0 - (f_1/2) - \delta)}) = O(n^{-1/d}e^{b^+(f_0 - f_1/2) - \frac{1}{2}\delta)\log n}) = o(1).
$$

Therefore both terms in the right hand side of  $(4.7)$  are  $o(ne^{-n\theta f_0 r_n^d(1-2\delta)}$ , so by Lemma [4.2,](#page-18-4)  $I_n = o(ne^{-n\theta r_n^d f_0(1-2\delta)})$ . Using this, along with [\(5.22\)](#page-34-2) and the fact that the  $L^1$  convergence in [\(2.3\)](#page-5-5) implies convergence in probability also, we obtain that with probability tending to one,  $ne^{-n\theta r_n^d f_0(1+2\delta)} < \zeta_n < ne^{-n\theta r_n^d f_0(1-2\delta)}$ , which gives us [\(2.6\)](#page-6-0).

Now suppose  $b^{-} \geq b'_{c}$ . Since also  $b^{+} \leq b_{c}$ , we have  $b'_{c} \leq b_{c} < \infty$ . Hence  $b'_{c} =$  $(d(f_0 - f_1/2))^{-1}$  so  $b^- \geq (d(f_0 - f_1/2))^{-1}$  and  $b^-((f_1/2) - f_0) \leq -1/d$ . Let  $\varepsilon > 0$ . Then

$$
\frac{ne^{-n\theta f_0 r_n^d}}{n^{1-1/d}e^{-nr_n^d\theta f_1(\frac{1}{2}-\varepsilon)}} = n^{1/d}e^{nr_n^d\theta((f_1/2) - f_0 - f_1\varepsilon)} \le n^{1/d}e^{b^{-}((f_1/2) - f_0 - f_1\varepsilon/2)\log n} = o(1),
$$

so by Lemma [4.2,](#page-18-4)  $I_n = o(n^{1-1/d}e^{-n\theta r_n^d f_1(\frac{1}{2}-2\varepsilon)})$ . Also by Lemma [4.1,](#page-18-3)  $n^{1-1/d} \exp^{-nr_n^d \theta f_1(\frac{1}{2}+\varepsilon)}$ *o*( $I_n$ ). Hence by the convergence in probability of  $\zeta_n/I_n$  to 1 which follows from [\(2.3\)](#page-5-5), with probability tending to 1 we have  $n^{1-1/d} \exp^{-nr_n^d \theta f_1(\frac{1}{2}+\varepsilon)} \leq \zeta_n \leq n^{1-1/d} e^{-n\theta r_n^d f_1(\frac{1}{2}-2\varepsilon)}$ , and [\(2.7\)](#page-6-5) follows.

Now suppose  $b^+ = b^- = b$  for some  $b \geq 0$ . Then if  $f_0 b \leq (1/d) + f_1 b/2$  we have  $(f_0 - f_1/2)b \leq 1/d$  so  $b \leq b'_c$  and [\(2.6\)](#page-6-0) applies. By (2.6) we have  $\zeta_n = n^{1-bf_0 + o_{\mathbb{P}}(1)}$ . Conversely if  $f_0b \ge (1/d) + f_1b/2$  we have  $(f_0 - f_1/2)b \ge 1/d$  and  $b \ge b_c'$  so [\(2.7\)](#page-6-5) applies and tells us that  $\zeta_n = n^{1-(1/d)-f_1b/2+o_{\mathbb{P}}(1)}$ .

*Proof of Theorem [2.4.](#page-6-1)* Here we assume as  $n \to \infty$  that  $I_n = \Theta(1)$  (which implies  $nr_n^d =$ Θ(log *n*) by Proposition [2.2](#page-6-4) and Lemma [4.1\)](#page-18-3). Then by Lemma [4.6,](#page-21-4) for some *δ >* 0 we have  $d_{\text{TV}}(S'_n, Z_{I_n}) = O(e^{-\delta n r_n^d}).$ 

By Proposition [5.5](#page-31-4) (when  $\xi_n = K'_n - 1$ ) or Proposition [5.8](#page-33-7) (when  $\xi_n = R'_n$ ) and Markov's inequality, for both those cases  $d_{TV}(\xi_n, S'_n) \leq \mathbb{P}[\xi_n \neq S'_n] \leq \mathbb{E}[|\xi_n - S'_n|] =$  $O((nr_n^d)^{1-d})$ , and therefore by Lemma [4.6](#page-21-4) and the triangle inequality,  $d_{TV}(\xi_n, Z_{I_n}) =$  $O((nr_n^d)^{1-d}) = O((\log n)^{1-d})$  in those cases.

Now suppose  $\xi_n$  is  $K_n - 1$  or  $R_n$ . By Proposition [5.5](#page-31-4) (when  $\xi_n = K_n - 1$ ) or Proposition [5.8](#page-33-7) (when  $\xi_n = R_n$ ) and Markov's inequality, for both those cases  $\mathbb{P}[\xi_n \neq S_n] \leq \mathbb{E}[\xi_n S_n$ <sup>[]</sup> =  $O((nr_n^d)^{1-d})$ , and therefore it suffices to prove that  $d_{TV}(S_n, Z_{I_n}) = O((nr_n^d)^{1-d})$ . By Lemma [4.6](#page-21-4) we have for some  $\delta > 0$  that  $d_{TV}(S'_n, Z_{I_n}) = O(e^{-\delta n r_n^d})$ , so it suffices to prove that  $\mathbb{E}[|S'_n - S_n|] = O((nr_n^d)^{1-d}).$ 

Recall that  $\mathcal{P}_n = \{X_1, \ldots, X_{Z_n}\}$ . Let  $m = m(n) = \lfloor n^{3/4} \rfloor$ . By the Cauchy-Schwarz inequality and the Chernoff bound from Lemma [3.4\(](#page-11-4)ii),

$$
\mathbb{E}[|S'_n - S_n| \mathbf{1}\{|Z_n - n| > m\} \le (\mathbb{E}[\max(Z_n, n)^2])^{1/2} (\mathbb{P}[|Z_n - n| > m])^{1/2}
$$
  

$$
\le (2n^2 + n)^{1/2} \exp(-\Omega(n^{1/2})). \tag{5.23}
$$

For  $i = 1, 2, \ldots$  write  $Y_i := X_{Z_n+i}$  and  $Y'_i := X_{n+i}$ . Then  $Y_1, Y_2, \ldots$  are *v*-distributed random vectors, independent of each other and of  $\mathcal{P}_n$ . Observe that

$$
|S'_{n} - S_{n}| \mathbf{1} \{ Z_{n} \leq n \leq Z_{n} + m \} \leq \sum_{i=1}^{m} \Big( \mathbf{1} \{ \mathcal{P}_{n} \cap B_{r_{n}}(Y_{i}) = \varnothing \} + \sum_{x \in \mathcal{P}_{n} \cap B_{r_{n}}(Y_{i})} \mathbf{1} \{ \mathcal{P}_{n} \cap B_{r_{n}}(x) = \{ x \} \} \Big).
$$

Therefore using the Mecke formula followed by Fubini's theorem we obtain that

<span id="page-36-1"></span>
$$
\mathbb{E}[|S'_n - S_n| \mathbf{1}\{Z_n \le n \le Z_n + m\}] \le m \int_A e^{-n\nu(B_{r_n}(x))} dx
$$

$$
+mn \int_A \int_{B_{r_n}(x)} e^{-n\nu(B_{r_n}(y))} \nu(dy) \nu(dx)
$$

$$
\le n^{-1/4} I_n + (n f_{\max} \theta r_n^d) n^{-1/4} I_n = O(n^{-1/4} (\log n)). \tag{5.24}
$$

Also  $Y'_1, Y'_2, \ldots$  are *v*-distributed random vectors, independent of each other and of  $\mathcal{X}_n$ . Then since  $(1 - \nu(B_{r_n}(x)))^{n-1} \leq 2e^{-n\nu(B_{r_n}(x))}$  for all large enough *n* and all  $x \in A$ ,

$$
\mathbb{E}[|S'_n - S_n| \mathbf{1}\{n \le Z_n \le n + m\}] \le \mathbb{E}\Big[\sum_{i=1}^m \Big(\mathbf{1}\{\mathcal{X}_n \cap B_{r_n}(Y'_i) = \varnothing\} + \sum_{x \in \mathcal{X}_n \cap B_{r_n}(Y'_i)} \mathbf{1}\{\mathcal{X}_n \cap B_{r_n}(x) = \{x\}\}\Big)\Big]
$$
  

$$
\le m \int_A (1 - \nu(B_{r_n}(x)))^n \nu(dx) + mn \int_A \int_{B_{r_n}(x)} (1 - \nu(B_{r_n}(y)))^{n-1} \nu(dy) \nu(dx)
$$
  

$$
= O((nr_n^d)n^{-1/4}I_n) = O(n^{-1/4}\log n).
$$

Combined with [\(5.23\)](#page-35-0) and [\(5.24\)](#page-36-1) this shows that  $\mathbb{E}[|S'_n - S_n|] = O(n^{-1/4} \log n) = O((n r_n^d)^{1-d})$ as required.

*Proof of Theorem [2.7.](#page-7-1)* Assume the uniform case applies. We first show that for any  $\gamma \in \mathbb{R}$ we have:

$$
\lim_{n \to \infty} \gamma_n = \gamma
$$
 then  $\lim_{n \to \infty} \mu_n = \begin{cases} e^{-\gamma} & \text{if } d = 2 \\ c_{d, A} e^{-\gamma/2} & \text{if } d \ge 3. \end{cases}$  (5.25)

The case  $d = 2$  of [\(5.25\)](#page-36-0) is obvious because  $\mu_n = e^{-\gamma_n}$  in this case. Suppose  $d \geq 3$ . If  $\lim_{n\to\infty}\gamma_n=\gamma$ , then as  $n\to\infty$  the second term in the right hand side of [\(1.4\)](#page-3-2) satisfies

$$
\theta_{d-1}^{-1} |\partial A| r_n^{1-d} e^{-n\theta f_0 r_n^d/2} \sim \theta_{d-1}^{-1} |\partial A| \left( \frac{(2-2/d) \log n}{n \theta f_0} \right)^{-1+1/d} e^{-\gamma/2} \left( \frac{n}{\log n} \right)^{-1+1/d}
$$

$$
= \theta_{d-1}^{-1} \sigma_A (\theta/(2-2/d))^{1-1/d} e^{-\gamma/2} = c_{d, A} e^{-\gamma/2},
$$

and moreover the ratio between the two terms in the right hand side of [\(1.4\)](#page-3-2) satisfies

$$
\frac{ne^{-n\theta f_0 r_n^d}}{\theta_{d-1}^{-1} |\partial A| r_n^{1-d} e^{-n\theta f_0 r_n^d/2}} = \theta_{d-1} |\partial A|^{-1} n r_n^{d-1} e^{-n\theta f_0 r_n^d/2}
$$

$$
= O\left( (\log n) \left( \frac{n}{\log n} \right)^{-1+2/d} \right) = o(1),
$$

and [\(5.25\)](#page-36-0) follows.

Now suppose  $|\gamma_n| = O(1)$ , which implies  $nr_n^d = \Theta(\log n)$  as  $n \to \infty$ . By [\(5.25\)](#page-36-0) and a subsequence argument we have that  $\mu_n = \Theta(1)$  as  $n \to \infty$ . Let  $\xi_n$  be any of

 $K_n - 1, R_n, K'_n - 1$  or  $R'_n$ . By a simple coupling argument for  $0 < s < t$  we have  $d_{\text{TV}}(Z_s, Z_t) \leq t - s$ . Hence by the triangle inequality

$$
d_{\text{TV}}(\xi_n, Z_{\mu_n}) \le d_{\text{TV}}(\xi_n, Z_{I_n}) + |I_n - \mu_n|.
$$

If  $d = 2$  then by Proposition [4.7](#page-22-0) and [\(1.4\)](#page-3-2)  $I_n = \mu_n (1 + O(n r_n^2)^{-1/2})$ ; hence by Theorem [2.4,](#page-6-1)

$$
d_{\mathrm{TV}}(\xi_n, Z_{\mu_n}) = O((\log n)^{-1}) + O((nr_n^2)^{-1/2}) = O((\log n)^{-1/2}).
$$

If  $d = 3$  then by Proposition [4.8](#page-22-1) and [\(1.4\)](#page-3-2),  $I_n = \mu_n \left(1 + O\left(\frac{\log(nr_n^d)}{n^d}\right)\right)$  $nr_n^d$  $\binom{2}{1}$ ; hence by Theorem [2.4,](#page-6-1)

$$
d_{\mathrm{TV}}(\xi_n, Z_{\mu_n}) = O((\log n)^{1-d}) + O\left(\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2\right) = O\left(\left(\frac{\log\log n}{\log n}\right)^2\right).
$$

Thus we have part (a). In particular, for all  $d \geq 2$  we have  $d_{TV}(\xi_n, Z_{\mu_n}) \to 0$  so that if  $\gamma_n \to \gamma$  then by [\(5.25\)](#page-36-0) we have  $\xi_n \stackrel{\mathcal{D}}{\longrightarrow} Z_{e^{-\gamma}}$  if  $d = 2$  and  $\xi_n \stackrel{\mathcal{D}}{\longrightarrow} Z_{c_{d,A}e^{-\gamma/2}}$  if  $d \geq 3$ , which is part (b).

For part (c), now assume [\(1.1\)](#page-2-0) and [\(1.2\)](#page-2-0). First suppose  $d = 2$ . By Proposition [4.7,](#page-22-0) as  $n \to \infty$  we have  $I_n = \mu_n(1 + O((nr_n^2)^{-1/2}))$  and [\(2.12\)](#page-7-3) follows from [\(2.2\)](#page-5-4). Also by [\(2.3\)](#page-5-5) from Theorem [2.1,](#page-5-1) and Proposition [4.7,](#page-22-0)

$$
\mathbb{E}\left[\left|\frac{\xi_n}{\mu_n} - 1\right|\right] \le \mathbb{E}\left[\left|\frac{\xi_n}{I_n}\left(\frac{I_n}{\mu_n} - 1\right)\right|\right] + \mathbb{E}\left[\left|\frac{\xi_n}{I_n} - 1\right|\right] = O((nr_n^2)^{-1/2} + I_n^{-1/2}),
$$

and hence [\(2.13\)](#page-7-4).

Suppose  $d \geq 3$ . By Proposition [4.8,](#page-22-1) as  $n \to \infty$  we have  $I_n = \mu_n \left(1 + O\left(\frac{\log (n r_n^d)}{n r^d}\right)\right)$ *nr<sup>d</sup> n*  $\binom{2}{ }$ . Hence using  $(2.2)$  we have  $(2.14)$ . Also by  $(2.3)$  from Theorem [2.1,](#page-5-1) and Proposition [4.8,](#page-22-1) we have

$$
\mathbb{E}\left[\left|\frac{\xi_n}{\mu_n} - 1\right|\right] \le \mathbb{E}\left[\left|\frac{\xi_n}{I_n}\left(\frac{I_n}{\mu_n} - 1\right)\right|\right] + \mathbb{E}\left[\left|\frac{\xi_n}{I_n} - 1\right|\right] = O\left(\left(\frac{\log(nr_n^d)}{nr_n^d}\right)^2 + I_n^{-1/2}\right),
$$
  
nce (2.15).

and hence [\(2.15\)](#page-7-6).

# <span id="page-37-0"></span>**6 Asymptotics of variances**

Throughout this section we make the same assumptions on *d*, *A* and *f* that were set out at the start of Section [3.](#page-9-0) We also assume that [\(4.1\)](#page-17-1) and [\(4.2\)](#page-17-2) hold, i.e. that  $nr_n^d \to \infty$ and  $\liminf(I_n) > 0$  as  $n \to \infty$ .

We shall prove that if  $\xi_n$  denotes any of  $K_n - 1, K'_n - 1, R_n$  or  $R'_n$ , then  $\mathbb{V}\text{ar}[\xi_n]$  is asymptotic to  $I_n$  (which was defined at [\(2.1\)](#page-5-2)) as  $n \to \infty$ ; in the case of  $\mathbb{V}\text{ar}[K_n - 1]$  and  $\mathbb{V}\text{ar}[R_n]$  we require the extra condition  $d \geq 3$ .

Later we shall show that the number of non-singleton components has negligible variance compared to the number of singletons. This goal will be achieved by estimating separately the variance for the number of non-singleton components of small (i.e., smaller than  $\delta r_n$ ), medium and large (i.e., larger than  $\rho r_n$ ) diameter, and showing that each of these three variances is  $o(I_n)$ ; the constants  $\delta$ ,  $\rho$  will be chosen later.

#### <span id="page-38-0"></span>**6.1 Variances for small components: Poisson input**

Next we consider for  $G(\mathcal{P}_n, r_n)$  the number of small non-singleton components  $K'_{n,0,\rho}$  and the number of vertices in such components,  $R'_{n,0,\rho}$  (as defined at  $(5.2)$ ), for suitably small (fixed)  $\rho$ .

<span id="page-38-3"></span>**Proposition 6.1.** *There exists*  $\rho_0 > 0$  *such that if*  $0 < \rho < \rho_0$  *then as*  $n \to \infty$  *we have* 

<span id="page-38-7"></span><span id="page-38-2"></span><span id="page-38-1"></span>
$$
\max(\mathbb{V}\text{ar}[K'_{n,0,\rho}], \mathbb{V}\text{ar}[R'_{n,0,\rho}]) = O((nr_n^d)^{1-d}I_n). \tag{6.1}
$$

We divide the proof of this proposition into a series of lemmas. Given  $\rho > 0$  and given *n*, for  $x, y \in A$  define the events  $\mathscr{T}_x := \mathscr{M}_{n,0,\rho}(x,\mathcal{P}_n)$  and  $\mathscr{T}_{x,y} := \mathscr{M}_{n,0,\rho}(x,\mathcal{P}_n^y)$ , where  $\mathscr{M}_{n,\varepsilon,K}(\mathcal{X})$  was defined at [\(3.14\)](#page-14-2). Also, recalling the definition of  $\mathscr{F}_n(x,\mathcal{X})$  at [\(5.1\)](#page-29-3), set  $\mathscr{E}_x := \mathscr{T}_x \cap \mathscr{F}_n(x, \mathcal{P}_n^x)$  and  $\mathscr{E}_{x,y} := \mathscr{T}_{x,y} \cap \mathscr{F}_n(x, \mathcal{P}_n^{x,y})$ . We begin with the following bound based on the Mecke formula.

<span id="page-38-6"></span>**Lemma 6.2.** *Suppose*  $\rho \in (0,1)$ *. Then* 

$$
\mathbb{V}\text{ar}[R'_{n,0,\rho}] - \mathbb{E}[R'_{n,0,\rho}] \leq n^2 \int_A \int_{A \cap B_{4r_n}(x)} \mathbb{P}[\mathcal{T}_{x,y} \cap \mathcal{T}_{y,x}] \nu(dy) \nu(dx); \tag{6.2}
$$

$$
\mathbb{V}\text{ar}[K'_{n,0,\rho}] - \mathbb{E}[K'_{n,0,\rho}] \leq n^2 \int_A \int_{A \cap B_{4r_n}(x)} \mathbb{P}[\mathscr{E}_{x,y} \cap \mathscr{E}_{y,x}] \nu(dy) \nu(dx). \tag{6.3}
$$

*Proof.* By the Mecke formula, we have  $\mathbb{E}[R'_{n,0,\rho}] = n \int_A \mathbb{P}[\mathscr{T}_x] \nu(dx)$ . Using this and the multivariate Mecke formula we obtain that

$$
\mathbb{E}[R'_{n,0,\rho}(R'_{n,0,\rho}-1)]-\mathbb{E}[R'_{n,0,\rho}]^2=n^2\int_A\int_A(\mathbb{P}[\mathscr{T}_{x,y}\cap\mathscr{T}_{y,x}]-\mathbb{P}[\mathscr{T}_x]\mathbb{P}[\mathscr{T}_y])\nu(dy)\nu(dx).
$$

For  $||y - x|| > 4r_n > 2(1 + \rho)r_n$  we have  $\mathbb{P}[\mathscr{T}_{x,y}] = \mathbb{P}[\mathscr{T}_x]\mathbb{P}[\mathscr{T}_y]$ , and [\(6.2\)](#page-38-1) follows.

The proof of [\(6.3\)](#page-38-2) is identical, with  $K'_{n,0,\rho}$  replacing  $R'_{n,0,\rho}$  and  $\mathscr{E}_{x,y}$  replacing  $\mathscr{T}_{x,y}$ throughout.

The rest of the proof of Proposition [6.1](#page-38-3) is devoted to estimating the double integral at [\(6.2\)](#page-38-1). We deal separately with the integrals over pairs  $(x, y)$  satisfying (i)  $||y - x|| > r_n$ ; (ii)  $\rho r_n < ||y - x|| \leq r_n$ , and (iii)  $||y - x|| \leq \rho r_n$ . Let  $\delta_1$  be as in Lemma [3.1.](#page-10-3)

<span id="page-38-5"></span>**Lemma 6.3.** *Suppose*  $0 < \rho < \min((f_0 \delta_1/(2 \theta f_{\max}))^{1/d}, 1)$ *. Then as*  $n \to \infty$  *we have* 

<span id="page-38-4"></span>
$$
n^2 \int_A \int_{A \cap B_{4r_n}(x) \backslash B_{r_n}(x)} \mathbb{P}[\mathcal{T}_{x,y} \cap \mathcal{T}_{y,x}] \nu(dy) \nu(dx) = O(I_n \exp(-(\delta_1 f_0/3) n r_n^d)). \tag{6.4}
$$

*Proof.* Since  $\mathbb{P}[\mathscr{T}_{x,y} \cap \mathscr{T}_{y,x}] \mathbb{1}\{r_n \leq ||y-x|| \leq 4r_n\}$  is symmetric in *x* and *y* it suffices to prove the estimate for the integral restricted to  $(x, y) \in A \times A$  with  $x \prec y$ , i.e.  $y \in A_x$ . For such  $(x, y)$ , if  $\mathscr{T}_{x,y} \cap \mathscr{T}_{y,x}$  occurs, then  $\mathcal{P}_n \cap (B_{r_n}(x) \cup B_{r_n}(y)) \setminus (B_{\rho r_n}(x) \cup B_{\rho r_n}(y)) = \varnothing$ . Hence

$$
\mathbb{P}[\mathcal{T}_{x,y} \cap \mathcal{T}_{y,x}] \le \exp(-n\nu[(B_{r_n}(x) \cup B_{r_n}(y)) \setminus (B_{\rho r_n}(x) \cup B_{\rho r_n}(y))])
$$
  

$$
\le \exp(-n\nu(B_{r_n}(x)) - n\nu(B_{r_n}(y) \setminus B_{r_n}(x)) + 2n\theta f_{\max}(\rho r_n)^d).
$$

By Lemma [3.1,](#page-10-3) if  $||x-y|| \ge r_n$  then  $\nu(B_{r_n}(y) \setminus B_{r_n}(x)) \ge 2f_0 \delta_1 r_n^d$ . Therefore if we take  $\rho$ to be so small that  $2\theta f_{\text{max}}\rho^d < f_0\delta_1$ , the third (positive) term in the exponent is less than half the second (negative) term. Hence  $\mathbb{P}[\mathscr{T}_{x,y} \cap \mathscr{T}_{y,x}] \leq e^{-n\nu(B_{r_n}(x)) - \delta_1 f_0 n r_n^d}$ . It follows that

*Proof.* The condition on  $||x - y||$  implies that  $y \in C_{r_n}(x, \mathcal{P}_n^y)$  and  $\text{diam}(\mathcal{C}_{r_n}(x, \mathcal{P}_n^y)) > \rho r_n$ , which negates the event  $\mathscr{T}_{x,y}$ .  $\Box$

\leq 2n \int_{n} f_{\max} \int_{B_{\rho r_{n}}(o)} e^{-n\delta_{1} f_{0} r_{n}^{d-1} ||u||} du

= 2n \int_{\max} I_{n} (n r_{n}^{d-1})^{-d} \int_{B_{n} \rho r_{n}^{d}(o)} e^{-n\delta_{1} f_{0} ||v||} dv = O((n r_{n}^{d})^{1-d} I_{n}). \qquad (6.8)

Next, let *z* denote the furthest point from *x* in  $\mathcal{C}_{r_n}(x, \mathcal{P}_n^{x,y})$ . If  $z = y$  then  $\mathcal{N}_{x,y}$  occurs. Thus if  $\mathscr{T}_{x,y} \setminus \mathcal{N}_{x,y}$  occurs then  $z \neq y$  and hence  $z \in \mathcal{P}_n$  with  $||y - x|| < ||z - x|| \leq \rho r_n$ , and moreover  $\mathcal{P}_n \cap (B_{r_n}(x) \cup B_{r_n}(z)) \setminus B_{\|z-x\|}(x)) = \varnothing$ . That is,

### <span id="page-40-0"></span>**6.2 Variances for small components: binomial input**

Next we consider for  $G(\mathcal{X}_n, r(n))$  the number of small non-singleton components  $K_{n,0,\rho}$ and the number of vertices in such components,  $R_{n,0,\rho}$  (as defined at  $(5.2)$ ), for suitably small (fixed) *ρ*.

While the asymptotic variance for small components in a Poisson sample was obtained above by computing the first two moments and exploiting the spatial independence of the Poisson process, we shall bound the variance for small components in a binomial sample by a very different argument, namely, the Efron-Stein inequality from Lemma [3.5.](#page-11-5) This does not work so well, in the sense that our bound does the job only in dimension  $d \geq 3$ . <span id="page-41-2"></span>**Proposition 6.6** (Variance estimates for small non-singleton components: binomial input). If  $d \geq 3$  then there exists  $\delta_5 > 0$  such that if  $0 < \rho \leq \delta_5$  then  $\text{Var}(K_{n,0,\rho}) =$  $O((nr_n^d)^{2-d}I_n)$  as  $n \to \infty$ , and  $\mathbb{V}\text{ar}(R_{n,0,\rho}) = O((nr_n^d)^{2-d}I_n)$  as  $n \to \infty$ .

*Proof.* By the Efron-Stein inequality  $(3.7)$ ,

$$
\mathbb{V}\text{ar}[R_{n,0,\rho}] \le n \int_A \mathbb{E}[(D_x R_{n,0,\rho}(\mathcal{X}_{n-1}))^2] \nu(dx)
$$
  
=  $n \int_A \mathbb{E}[(D_x^+ R_{n,0,\rho}(\mathcal{X}_{n-1}))^2] \nu(dx) + n \int_A \mathbb{E}[(D_x^- R_{n,0,\rho}(\mathcal{X}_{n-1}))^2] \nu(dx).$ 

Similarly

$$
\mathbb{V}\text{ar}[K_{n,0,\rho}] \le n \int_A \mathbb{E}[(D_x^+ K_{n,0,\rho}(\mathcal{X}_{n-1}))^2] \nu(dx) + n \int_A \mathbb{E}[(D_x^- K_{n,0,\rho}(\mathcal{X}_{n-1}))^2] \nu(dx).
$$

Moreover for all finite  $\mathcal{X} \subset \mathbb{R}^d$  and  $x \in \mathbb{R}^d \setminus \mathcal{X}$  we have  $D_x^+ K_{n,0,\rho}(\mathcal{X}) \leq D_x^+ R_{n,0,\rho}(\mathcal{X})$  and  $D_x^- K_{n,0,\rho}(\mathcal{X}) \leq D_x^- R_{n,0,\rho}(\mathcal{X})$ . Therefore the result follows from the next two lemmas.

**Lemma 6.7.** *Let*  $\rho$  *be as in Lemma [5.6.](#page-31-3) Then as*  $n \to \infty$  *we have*

**Lemma 6.8.** *Let*  $\delta_1$  *be as in Lemma [3.1](#page-10-3) and suppose*  $0 < \rho < \min((\delta_1 f_0/(2f_{\max}\theta))^{1/(d-1)}, 1)$ *. Then as*  $n \to \infty$ *, we have*

n\int_{A} \mathbb{E}[D_x^{-} R_{n,0,\rho}(\mathcal{X}_{n-1})] \nu(dx) = O((nr_n^d)^{2-d} I_n).
$$
 (6.12)

*Proof.* For  $x \in A$ , observe that  $D_x^- R_{n,0,\rho}(\mathcal{X}_{n-1})$  is bounded above by  $N_{1,x}$ , where  $N_{1,x}$  denotes the number of vertices  $y \in \mathcal{X}_{n-1}$  such that  $||y-x|| \leq 2r_n$  and  $0 < \text{diam}(\mathcal{C}_{r_n}(y, \mathcal{X}_{n-1})) \leq$ *ρrn*. Therefore

Let  $N_{3,x}$  be the number of ordered triples  $(z,u,y)$ of distinct points of  $\mathcal{X}_{n-1} \cap B_{2r_n}(x)$  such that  $0 < \text{diam}(\mathcal{C}_{r_n}(z, \mathcal{X}_{n-1})) \le \rho r_n$ , and  $z \prec v$ 

for all  $v \in \mathcal{C}_{r_n}(z, \mathcal{X}_{n-1}) \setminus \{z\}$ , and *u* is the point of  $\mathcal{C}_{r_n}(z, \mathcal{X}_{n-1})$  furthest from *z*, and *y* is another point of  $\mathcal{C}_{r_n}(z,\mathcal{X}_{n-1})$ .

Then  $N_{1,x} \leq 2N_{2,x} + N_{3,x}$ . For *n* large we have

For such  $(y, z)$  we cannot have  $\rho r_n < ||y - z|| \leq r_n$ ; we distinguish between the cases where  $||y - z|| \leq \rho r_n$  and where  $||y - z|| > r_n$ .

Let  $N_{4,x}$  be the number of ordered pairs  $(y, z)$  of distinct points of  $\mathcal{X}_{n-1} \cap B_{2r_n}(x)$  such that  $||y - z|| \le \rho r_n$  and  $\text{diam}(\mathcal{C}_{r_n}(y, \mathcal{X}_{n-1})) \le \rho r_n$ .

Let  $N_{5,x}$  be the number of ordered quadruples  $(u, v, y, z)$  of distinct points of  $\mathcal{X}_{n-1} \cap$  $B_{2r_n}(x)$  such that  $u \prec w$  for all  $w \in \mathcal{C}_{r_n}(u, \mathcal{X}_{n-1})$ , and *v* is the furthest point from *u* in  $\mathcal{C}_{r_n}(u, \mathcal{X}_{n-1})$  and  $y, z$  are two further points in  $\mathcal{C}_{r_n}(u, \mathcal{X}_{n-1})$  and  $\text{diam}(\mathcal{C}_{r_n}(u, \mathcal{X}_{n-1})) \leq \rho r_n$ . Then

$$
N_{4,x} \le 2N_{2,x} + 4N_{3,x} + N_{5,x}.
$$

For  $n \geq 4$  we have that

\nu[(B_{r_n}(y) \cup B_{r_n}(z)) \setminus (B_{\rho r_n}(y) \cup B_{\rho r_n}(z))] \ge \nu(B_{r_n}(y)) + 2\delta_1 f_0 r_n^d - 2f_{\max}\theta(\rho r_n)^d
$$
  
\n
$$
\ge \nu(B_{r_n}(y)) + \delta_1 f_0 r_n^d.
$$

Hence for *n* large,

$$
\mathbb{E}[N_{6,x}] \le 2n^2 \int_{A \cap B_{2r_n}(x)} e^{-n\nu(B_{r_n}(y)) - \delta_1 f_0 n r_n^d} f_{\max} \theta(2r_n)^d \nu(dy),
$$

so by Fubini's theorem, for *n* large

$$
n\int_{A} \mathbb{E}[N_{6,x}]\nu(dx) \le 2^{1+2d} f_{\max}^2 \theta^2 n^3 r_n^{2d} \int_{A} e^{-n\nu(B_{r_n}(y)) - \delta_1 f_0 n r_n^d} \nu(dy)

=  $O((nr_n^d)^2 e^{-\delta_1 f_0 n r_n^d} I_n) = O(e^{-(\delta_1 f_0/2) n r_n^d} I_n).$ 

Combined with [\(6.17\)](#page-43-0) this shows that

#### <span id="page-44-0"></span>**6.3 Variance estimates for medium components**

We now consider the 'medium-size' component count, denoted  $K_{n,\varepsilon,\rho}$  or  $K'_{n,\varepsilon,\rho}$  (as defined at  $(5.2)$ ) with  $0 < \varepsilon < \rho < \infty$ . We also consider the number of vertices in medium-sized components, denoted  $R_{n,\varepsilon,\rho}$  or  $R'_{n,\varepsilon,\rho}$ . We shall bound the variances of all four of these quantities using Lemma [3.5,](#page-11-5) i.e. using the Poincaré or Efron-Stein inequality.

<span id="page-44-3"></span>**Proposition 6.9** (Variance estimates for medium-sized components)**.** *Let* 0 *< ε <* 1 *<*  $\rho < \infty$ *. Let*  $\xi_n$  *stand for any of*  $R_{n,\varepsilon,\rho}$ ,  $R'_{n,\varepsilon,\rho}$ ,  $K_{n,\varepsilon,\rho}$  *or*  $K'_{n,\varepsilon,\rho}$ . Then there exists  $c > 0$ *such that*  $\mathbb{V}\text{ar}(\xi_n) = O(e^{-cn r_n^d} I_n)$  *as*  $n \to \infty$ *.* 

*Proof.* Note that  $D^+K_{n,\varepsilon,\rho}(\mathcal{X}) \leq D^+R_{n,\varepsilon,\rho}(\mathcal{X})$  and  $D^-K_{n,\varepsilon,\rho}(\mathcal{X}) \leq D^-R_{n,\varepsilon,\rho}(\mathcal{X})$ . Analogously to the proof of Proposition [6.6,](#page-41-2) but using the Poincaré inequality instead of the Efron-Stein inequality in the case of the results for  $R'_{n,\varepsilon,\rho}$  and  $K'_{n,\varepsilon,\rho}$ , we can obtain the result from the next two lemmas.  $\Box$

*Proof.* Observe that  $D_x^- R_{n,\epsilon,\rho}(\mathcal{X}_{n-1})$  is bounded above by the number of vertices  $y \in$  $\mathcal{X}_{n-1} \cap B_{2\rho r_n}(x)$  such that  $\text{diam}(\mathcal{C}_{r_n}(y,\mathcal{X}_{n-1})) \in (\varepsilon r, \rho r_n]$ . We denote this quantity by *N*7*,x*.

Let  $N_{8,x}$  be the number of ordered pairs  $(y, z)$  of distinct points of  $\mathcal{X}_{n-1} \cap B_{3\rho r_n}(x)$ such that  $\text{diam}(\mathcal{C}_{r_n}(y,\mathcal{X}_{n-1})) \in (\varepsilon_r, \rho r_n]$  and  $y \prec u$  for all  $u \in \mathcal{C}_{r_n}(y,\mathcal{X}_{n-1}) \setminus \{y\}$ . Then  $N_{7,x} \leq 2N_{8,x}$ 

Fix  $\delta > 0$  small, as in the proof of [\[12,](#page-52-5) Lemma 3.4], and discretize  $\mathbb{R}^d$  into cubes of side *δr<sub>n</sub>* as in that proof. Assume  $4\delta d^2 < \min(\delta_2/\theta, 1)$ , where  $\delta_2 = \delta_2(\epsilon, 2\rho)$  is as in Lemma [3.2](#page-10-7) of the present paper. Then

and thus there exists a constant  $c' > 0$  such that for *n* large

\mathbb{E}[N_{8,x}] \le c'n^2 \int_{B_{3\rho r_n}(x)} \int_{B_{3\rho r_n}(x)} e^{-n\nu(B_{r_n}(y)) - \delta_2 f_0 n r_n^d} \nu(dz) \nu(dy). \tag{6.20}

*Proof.* Let  $\delta_2$  and  $\delta$  be as in the previous proof. *Proof.* Analogously to Proposition [6.9](#page-44-3) the result follows from the next two lemmas.  $\Box$ **Lemma 6.13.** *There exists*  $\rho_0 > 1$  *such that for any fixed*  $\rho > \rho_0$  *we have as*  $n \to \infty$  *that*

*Proof.* Let  $\rho > 4$ . For  $y \in \mathcal{X}_{n-1}$ , adding a point at x can only increase the diameter of the component containing  $\psi$ . Therefore if adding a point at x causes  $\psi$  to be in a component of diameter in the range  $(\rho r_n, (\log n)^2 r_n]$  when it was not before, then *y* must previously have been in a component of diameter at most *ρrn*, and since also the added point at *x* affects this component we must have  $||y - x|| \leq (\rho + 1)r_n \leq 2\rho r_n$ . Also event  $\mathscr{M}_{n,\rho/4,(\log n)^2}^*(x,\mathcal{X}_{n-1}),$  defined at [\(3.15\)](#page-14-4), must occur. J_{1,x} := \int_{B_{3\rho r_n}(x)} n \mathbb{P}[\text{diam}(\mathcal{C}_{r_n}(y, \mathcal{X}_{n-2}^y)) \in (\rho r_n, (\log n)^2 r_n] ] \nu(dy)
$$
  
\n
$$
J_{2,x} := \int_{B_{2(\log n)^2 r_n}(x) \backslash B_{3\rho r_n}(x)} n \mathbb{P}[\text{diam}(\mathcal{C}_{r_n}(y, \mathcal{X}_{n-2}^y)) \in (||y - x||/2, (\log n)^2 r_n] ] \nu(dy).
$$

Let  $\beta$  be as in Lemma [3.8.](#page-14-5) By that result,

$$
J_{1,x} \le n f_{\text{max}} \theta(3\rho r_n)^d \exp(-\beta \rho n r_n^d). \tag{6.30}
$$

Also by Lemma [3.8,](#page-14-5)

$$
J_{2,x} \leq n \int_{A \setminus B_{3\rho r_n}(x)} \exp(-\beta(\|y-x\|/2)nr_n^{d-1}) \nu(dy)
$$
  
\n
$$
\leq n f_{\max} \int_{\mathbb{R}^d \setminus B_{3\rho r_n}(o)} \exp(-\beta(\|u\|/2)nr_n^{d-1}) du
$$
  
\n
$$
= n f_{\max} \int_{\{v: \|v\| > 3\rho r_n(\beta/2)nr_n^{d-1}\}} e^{-\|v\|} (\beta nr_n^{d-1}/2)^{-d} dv
$$
  
\n
$$
= (2/\beta)^d f_{\max}(nr_n^d)^{1-d} \int_{\rho \beta nr_n^d}^{\infty} e^{-t} d\theta_d t^{d-1} dt
$$
  
\n
$$
\leq c\beta^{-1} f_{\max}\rho^{d-1} e^{-\rho \beta nr_n^d},
$$

where the constant  $c$  depends only on  $d$ . Combined with  $(6.30)$ , this shows that if we take  $\rho \ge (\theta f_0 + 3)/\beta$  then for *n* large  $\mathbb{E}[N_x] \le \exp(-(\theta f_0 + 2)nr_n^d)$  for all  $x \in A$ , and then using Lemma [4.1](#page-18-3) we obtain that

n\int_{A} \mathbb{E}[N_x] \nu(dx) = O(e^{-nr_n^d} I_n). \tag{6.31}
$$

Next, observe that  $\mathbb{E}[N_x(N_x-1)] \leq J_{3,x} + 2J_{4,x}$  where we set

J_{3,x} := \int_{B_{3\rho r_n}(x)} \int_{B_{3\rho r_n}(x)} n^2 \mathbb{P}[\text{diam}(\mathcal{C}_{r_n}(y, \mathcal{X}_{n-3}^{y,z})) \in (\rho r_n, (\log n)^2 r_n] ] \nu(dz) \nu(dy);
$$
  
\n
$$
J_{4,x} := \int_{B_{(\log n)^2 r_n}(x) \setminus B_{3\rho r_n}(x)} \int_{B_{\|y-x\|}(x)} n^2 \mathbb{P}[\text{diam}(\mathcal{C}_{r_n}(y, \mathcal{X}_{n-3}^{y,z})) \in (\|y-x\|/2, (\log n)^2 r_n]]
$$
  
\n
$$
\nu(dz) \nu(dy).
$$

By Lemma [3.8,](#page-14-5)

<span id="page-48-1"></span>
$$
J_{3,x} \le n^2 (f_{\text{max}} \theta (3\rho r_n)^d)^2 e^{-\beta \rho n r_n^d}.
$$
\n(6.32)

Also by Lemma [3.8,](#page-14-5)

$$
J_{4,x} \leq n^2 \int_{A \backslash B_{3\rho r_n}(x)} \exp(-\beta(\|y-x\|/2)nr_n^{d-1})(f_{\max}\theta\|y-x\|^d)\nu(dy)
$$
  
\n
$$
\leq n^2 f_{\max}^2 \theta \int_{\mathbb{R}^d \backslash B_{3\rho r_n}(o)} \exp(-\beta(\|u\|/2)nr_n^{d-1})\|u\|^d du
$$
  
\n
$$
= n^2 f_{\max}^2 \theta \int_{\{v: \|v\| > 3\rho r_n(\beta/2)nr_n^{d-1}\}} e^{-\|v\|} \|v\|^d (\beta nr_n^{d-1}/2)^{-2d} dv
$$
  
\n
$$
= (2/\beta)^{2d} f_{\max}^2 (nr_n^d)^{2-2d} \int_{\rho\beta nr_n^d}^{\infty} e^{-t} d\theta dt^{2d-1} dt
$$
  
\n
$$
\leq c\beta^{-1} f_{\max}^2 \rho^{2d-1} nr_n^d e^{-\rho\beta nr_n^d},
$$

where the constant *c* depends only on *d*. Combined with [\(6.32\)](#page-48-1), this shows that if we take  $\rho \ge (\theta f_0 + 3)/\beta$  then for *n* large  $\mathbb{E}[N_x(N_x - 1)] \le \exp(-(\theta f_0 + 2)nr_n^d)$  for all  $x \in A$ , and then using Lemma [4.1](#page-18-3) we obtain that

$$
n\int_A \mathbb{E}[N_x(N_x-1)]\nu(dx) = O(e^{-nr_n^d}I_n).
$$

Combined with  $(6.31)$  this shows that  $(6.28)$  holds. The proof of  $(6.29)$  is similar.  $\Box$ 

#### <span id="page-49-0"></span>**6.5 Variance estimates: conclusion**

Putting together the preceding estimates, we obtain the asymptotic variance for  $K'_{n}$  and (when  $d \geq 3$ ) for  $K_n$ :

<span id="page-49-4"></span>**Proposition 6.15.** *Assume that*  $nr_n^d \to \infty$  *and*  $\liminf(I_n) > 0$  *as*  $n \to \infty$ *. Then*

\mathbb{V}\text{ar}[K'_n] = I_n(1 + O((nr_n^d)^{(1-d)/2}))\tag{6.33}

d \ge 3
$$
 then  $\mathbb{V}\text{ar}[K_n] = I_n(1 + O((nr_n^d)^{1-d/2})).$  (6.34)

*Proof.* Note  $K'_n = S'_n + K'_{n,0,\infty}$ , where  $S'_n$  and  $K'_{n,\epsilon,\rho}$  were defined at [\(4.3\)](#page-18-5), [\(5.2\)](#page-29-2).

Let  $\rho \in (4,\infty)$  be as in Proposition [6.12.](#page-47-5) Let  $\rho_0$  be as in Proposition [6.1.](#page-38-3) Let  $\varepsilon = \rho_0$ . Let  $W_n := K'_{n,(\log n)^2,\infty}$ . Since  $|W_n - 1|$  is bounded by  $Z_n + 1$  (where  $Z_n = \#(\mathcal{P}_n)$ ), the Cauchy-Schwarz inequality and Lemma [5.4](#page-30-7) yield that

$$
\mathbb{V}\text{ar}[W_n] = \mathbb{V}\text{ar}[W_n - 1] \le \mathbb{E}[(W_n - 1)^2] \le (\mathbb{E}[(Z_n + 1)^4])^{1/2} (\mathbb{P}[W_n \ne 1])^{1/2}
$$

$$
= O(e^{-\frac{1}{2}nr_n^d}I_n).
$$
(6.35)

Then  $K'_{n,0,\infty} = K'_{n,0,\varepsilon} + K'_{n,\varepsilon,\rho} + K'_{n,\rho,(\log n)^2} + W_n$ . By the estimate  $(u + v + w + x)^2 \le$  $4(u^2+v^2+w^2+x^2)$  (a consequence of Jensen's inequality), Propositions [6.1,](#page-38-3) [6.9](#page-44-3) and [6.12,](#page-47-5) along with [\(6.35\)](#page-49-1),

$$
\mathbb{V}\text{ar}[K'_{n,0,\infty}] \le 4(\mathbb{V}\text{ar}[K'_{n,0,\varepsilon}] + \mathbb{V}\text{ar}[K'_{n,\varepsilon,\rho}] + \mathbb{V}\text{ar}[K'_{n,\rho,(log n)^2}] + \mathbb{V}\text{ar}[W_n])
$$
  
=  $O((nr_n^d)^{1-d}I_n).$  (6.36)

By Proposition [4.4,](#page-20-0)  $\mathbb{V}\text{ar}[S'_n] = I_n(1 + e^{-\Omega(nr_n^d)})$ . Hence by the Cauchy-Schwarz inequality,  $Cov(S'_n, K'_{n,0,\infty}) = O((nr_n^d)^{(1-d)/2}I_n)$ , and thus

$$
\mathbb{V}\text{ar}(K'_n) = \mathbb{V}\text{ar}(S'_n) + \mathbb{V}\text{ar}(K'_{n,0,\infty}) + 2\mathbb{C}\text{ov}(S'_n, K'_{n,0,\infty}) = I_n + O((nr_n^d)^{(1-d)/2}I_n),
$$

which is  $(6.33)$ . The proof of  $(6.34)$  is similar, but now using Proposition [6.6](#page-41-2) instead of Proposition [6.1,](#page-38-3) which accounts for the different power of  $nr_n^d$  in [\(6.34\)](#page-49-3).  $\Box$ 

We can now also determine the asymptotic variance for  $R'_n$  and (if  $d \geq 3$ ) for  $R_n$ .

<span id="page-50-5"></span>**Proposition 6.16.** *Under assumptions* [\(4.1\)](#page-17-1) *and* [\(4.2\)](#page-17-2)*, as*  $n \to \infty$  *we have*

$$
\mathbb{V}\text{ar}[R'_n] = I_n(1 + O((nr_n^d)^{(1-d)/2}))\tag{6.37}
$$

if 
$$
d \ge 3
$$
,  $\operatorname{Var}[R_n] = I_n(1 + O((nr_n^d)^{1-d/2}))$ . (6.38)

*Proof.* Let  $0 < \varepsilon < \rho$  with  $\varepsilon < \rho_0$  and  $\rho_0$  as in Proposition [6.1.](#page-38-3) By Jensen's inequality and Propositions [6.1,](#page-38-3) [6.9](#page-44-3) and [6.12,](#page-47-5)

$$
\mathbb{V}\text{ar}[R'_{n,0,(\log n)^2}] \le 3(\mathbb{V}\text{ar}[R'_{n,0,\varepsilon}] + \mathbb{V}\text{ar}[R'_{n,\varepsilon,\rho}] + \mathbb{V}\text{ar}[R'_{n,\rho,(\log n)^2}])
$$
  
=  $O((nr_n^d)^{1-d}I_n).$  (6.39)

Since  $|R'_n - S'_n - R'_{n,0,(\log n)^2}| \leq Z_n$ , by the Cauchy-Schwarz inequality and Lemma [5.4,](#page-30-7)

$$
\mathbb{E}[|R'_n - S'_n - R'_{n,0,(\log n)^2}|^2] \le (\mathbb{E}[Z_n^2])^{1/2} (\mathbb{P}[R'_n \ne S'_n + R'_{n,0,(\log n)^2}])^{1/2}
$$
  
=  $O(e^{-nr_n^d/2}I_n).$ 

Then using [\(6.39\)](#page-50-1) and Jensen's inequality again yields

$$
\mathbb{V}\text{ar}[R'_n - S'_n] \le 2(\mathbb{V}\text{ar}[R'_n - S'_n - R'_{n,0,(\log n)^2}] + \mathbb{V}\text{ar}[R'_{n,0,(\log n)^2}]) = O((nr_n^d)^{1-d}I_n). \tag{6.40}
$$

By Proposition [4.4,](#page-20-0)  $\mathbb{V}\text{ar}[S'_n] = I_n(1 + e^{-\Omega(nr_n^d)})$ . Using this along with [\(6.40\)](#page-50-2) and the Cauchy-Schwarz inequality gives us [\(6.37\)](#page-50-3).

The proof of [\(6.38\)](#page-50-4) is similar. We use Proposition [6.6](#page-41-2) instead of Proposition [6.1,](#page-38-3) and Proposition [4.5](#page-20-1) instead of Proposition [4.4.](#page-20-0)  $\Box$ 

#### <span id="page-50-0"></span>**6.6 Proof of convergence in distribution results**

*Proof of Theorem [2.5.](#page-6-3)* By Proposition [6.15](#page-49-4) we have  $\mathbb{V}\text{ar}[K'_n] = I_n(1 + (nr_n^d)^{(1-d)/2})$ . By Proposition [6.16](#page-50-5) we have  $\mathbb{V}\text{ar}[R'_n] = I_n(1 + (nr_n^d)^{(1-d)/2})$ . Thus we have [\(2.8\)](#page-6-6). If  $d \geq 3$ then by Proposition [6.15](#page-49-4) we have  $\mathbb{V}\text{ar}[K_n] = I_n(1+O(n r_n^d)^{1-d/2})$ , and by Proposition [6.16](#page-50-5) we have  $\text{Var}[R_n] = I_n(1 + O((nr_n^d)^{1-d/2}))$ . Thus we have [\(2.10\)](#page-6-7).

By [\(6.36\)](#page-49-5) in the proof of Proposition [6.15](#page-49-4) if  $\xi'_n = K'_n - 1$ , or [\(6.40\)](#page-50-2) in the proof of Proposition [6.16](#page-50-5) if  $\xi'_n = R'_n$ ,

$$
\mathbb{V}\text{ar}[\xi_n' - S_n'] = O((nr_n^d)^{1-d}I_n).
$$

Hence  $\mathbb{V}\text{ar}(I_n^{-1/2}(\xi'_n - S'_n - \mathbb{E}[\xi'_n - S'_n])) = O((nr_n^d)^{1-d})$ . Hence by Lemma [3.6,](#page-12-2)

$$
d_{\mathcal{K}}(I_n^{-1/2}(\xi'_n - \mathbb{E}[\xi'_n]), N(0, 1)) = O(d_{\mathcal{K}}(I_n^{-1/2}(S'_n - I_n), N(0, 1)) + (nr_n^d)^{(1-d)/3}),
$$

and  $(2.9)$  then follows by  $(2.22)$ .

When  $d \geq 3$  we prove [\(2.11\)](#page-6-9) similarly. In the binomial setting we get  $(nr_n^d)^{2-d}$  instead of  $(nr_n^d)^{1-d}$  in [\(6.36\)](#page-49-5) or [\(6.40\)](#page-50-2), and therefore  $\text{Var}(I_n^{-1/2}(\xi_n - S_n - \mathbb{E}[\xi_n - S_n])) = O((nr_n^d)^{2-d})$ . Therefore using Lemma [3.6](#page-12-2) and [\(2.23\)](#page-8-4) we have

$$
d_{\mathcal{K}}(\tilde{I}_n^{-1/2}(\xi_n - \mathbb{E}[\xi_n]), N(0, 1)) = O(d_{\mathcal{K}}(\tilde{I}_n^{-1/2}(S_n - \tilde{I}_n), N(0, 1)) + (nr_n^d)^{(2-d)/3})
$$
  
=  $O((nr_n^d)^{(2-d)/3} + I_n^{-1/2}).$ 

Using the fact that  $\tilde{I}_n = I_n(1 + O(e^{-c'n r_n^d}))$  for some further constant *c*' by Lemma [4.3,](#page-19-0) and using Lemma [3.6](#page-12-2) again we obtain [\(2.11\)](#page-6-9).  $\Box$ 

*Proof of Theorem [2.8.](#page-7-2)* We assume [\(1.1\)](#page-2-0), [\(1.2\)](#page-2-0) and that  $\nu$  is uniform on *A*. For  $n > 1$ define  $\gamma_n$  as at [\(1.2\)](#page-2-0) and set  $a_n := -\gamma_n$ , so  $a_n := (2 - 2/d)(\log n - 1\{d \geq 3\} \log \log n)$  $n\theta f_0 r_n^d$ . By [\(1.2\)](#page-2-0),  $a_n \to \infty$  as  $n \to \infty$ . We claim  $I_n \to \infty$ . Indeed, if  $d = 2$  then

$$
ne^{-n\pi f_0 r^2} = ne^{a_n - \log n} \to \infty,
$$

so that  $I_n \to \infty$  by Proposition [4.7.](#page-22-0) If instead  $d \geq 3$  then

$$
e^{-n\theta \ln^n n/2} r_n^{1-d} = e^{a_n/2} \left(\frac{\log n}{n}\right)^{1-1/d} r_n^{1-d} = e^{a_n/2} \left(\frac{n r_n^d}{\log n}\right)^{(1/d)-1}
$$

which tends to infinity because, by [\(1.2\)](#page-2-0), for *n* large we have  $n\theta f_0 r_n^d \leq 2 \log n$ . Therefore by Proposition [4.8,](#page-22-1) we have  $I_n \to \infty$  in this case too, justifying our claim.

Suppose  $d = 2$ . By Proposition [4.7](#page-22-0) and [\(1.4\)](#page-3-2), as  $n \to \infty$  we have  $I_n = \mu_n(1 +$  $O((nr_n^2)^{-1/2})$  and then [\(2.16\)](#page-7-7) follows from [\(2.8\)](#page-6-6). Also by Lemma [3.6,](#page-12-2) (2.8) and [\(2.9\)](#page-6-8),

$$
d_{\mathcal{K}}\left(\frac{\xi_{n}^{\prime} - \mathbb{E}[\xi_{n}^{\prime}]}{\mu_{n}^{1/2}}, N(0, 1)\right) \leq d_{\mathcal{K}}\left(\frac{\xi_{n}^{\prime} - \mathbb{E}[\xi_{n}^{\prime}]}{I_{n}^{1/2}}, N(0, 1)\right) + \left(\mathbb{V}\text{ar}((\mu_{n}^{-1/2} - I_{n}^{-1/2})(\xi_{n}^{\prime} - \mathbb{E}[\xi_{n}^{\prime}]))\right)^{1/3}
$$

$$
= O((nr_{n}^{2})^{-1/3} + I_{n}^{-1/2}) + O\left(\left(\left(\frac{I_{n}}{\mu_{n}}\right)^{1/2} - 1\right)^{2/3}\right)
$$

$$
= O((nr_{n}^{2})^{-1/3} + \mu_{n}^{-1/2}), \tag{6.41}
$$

and hence [\(2.17\)](#page-7-8).

Now suppose  $d \geq 3$ . By Proposition [4.8,](#page-22-1) as  $n \to \infty$  we have  $I_n = \mu_n \left(1+O\left(\frac{\log(nr_n^d)}{n^d}\right)\right)$ *nr<sup>d</sup> n*  $\binom{2}{ }$ . Hence using  $(2.8)$  we have  $(2.18)$ , and using  $(2.10)$  we have  $(2.19)$ .

Also using Lemma [3.6,](#page-12-2) we can obtain  $(2.20)$  from  $(2.9)$  and  $(2.21)$  from  $(2.11)$ , in both cases by similar steps to those used at [\(6.41\)](#page-51-0) to derive [\(2.17\)](#page-7-8).  $\Box$
