A NEW PROOF OF THE SHARP GORDON'S LEMMA: NO EIGENVALUES FOR SCHRÖDINGER OPERATORS WITH ALMOST REPETITION POTENTIALS

Abstract. Building on the work of Jitomirskaya-Simon and Jitomirskaya-Liu, who established the absence of eigenvalues for Schrödinger operators with almost reflective repetition potentials, we provide a new proof of the sharp Gordon's lemma, which asserts the absence of eigenvalues for Schrödinger operators with almost repetition potentials.

1. Introduction

In this paper, we study one-dimensional discrete Schrödinger operators given by:

(1)
$$
(Hu)(k) = u(k+1) + u(k-1) + V(k)u(k), \quad k \in \mathbb{Z},
$$

where $V = \{V(k)\}\$ is a bounded potential.

We focus on two types of potentials: almost reflective repetition potentials and almost repetition potentials. These potentials are closely related to those studied in the context of quasi-periodic Schrödinger operators.

A potential $V = \{V(k)\}_{k \in \mathbb{Z}}$ is said to have γ -repetitions for some $\gamma > 0$ (a modification of the definition in [\[24\]](#page-6-0)) if there exists an increasing sequence $k_n \to \infty$ or $k_n \to -\infty$ such that, for all $k \in \mathbb{Z}$:

(2)
$$
|V(k_n + k) - V(k)| \le e^{-\gamma |k_n|}.
$$

Similarly, a potential $V = \{V(k)\}_{k\in\mathbb{Z}}$ is said to have γ -reflective repetitions if there exists a sequence $k_n \to \infty$ or $k_n \to -\infty$ such that, for all $k \in \mathbb{Z}$:

(3)
$$
|V(k_n - k) - V(k)| \le e^{-\gamma |k_n|}.
$$

Potentials with repetitions are often referred to as *Gordon-type potentials*, while reflective repetition potentials are also known as *palindromic potentials*.

We define one-step transfer matrices

$$
A_k(E) := \begin{pmatrix} E - V(k) & -1 \\ 1 & 0 \end{pmatrix}
$$

and the multi-step transfer matrices by

$$
A_{k,j}(E) := \begin{cases} A_{k-1}(E)A_{k-2}(E)\cdots A_j(E), & j < k; \\ A_{k,j} = I, & k = j; \\ A_{j,k}^{-1}(E), & j > k. \end{cases}
$$

Define

(4)
$$
\mathcal{L}(E) := \limsup_{k \to \infty} \sup_{j \in \mathbb{Z}} \frac{\ln ||A_{k+j,j}(E)||}{k}.
$$

It is clear that for bounded V, we have $\mathcal{L}(E) < \infty$ for every E.

The foundational work of Gordon [\[12\]](#page-5-0) and Simon [\[27\]](#page-6-1), commonly referred to as the Gordon-type argument, laid the groundwork for proving that for γ -repetition potentials, H has no eigenvalues in the regime

$$
\{E \in \mathbb{C} : \gamma > 2\mathcal{L}(E)\}.
$$

Although Gordon and Simon did not explicitly prove this exact result, it can be established by carefully analyzing their proofs. Gordon first presented his argument in the 1970s in Russian [\[12\]](#page-5-0), but it remained largely unfamiliar to the broader mathematical community until Barry Simon provided a detailed discussion of the Gordon argument in his 1982 article [\[27](#page-6-1)] (also consult with [\[2\]](#page-5-1)). For additional historical context, see [\[21\]](#page-6-2).

Recently, Avila-You-Zhou [\[1\]](#page-5-2) improved Gordon type arguments, extending the regime to

$$
\{E \in \mathbb{C} : \gamma > \mathcal{L}(E)\}.
$$

The absence of eigenvalues in the regime $\{E \in \mathbb{C} : \gamma > \mathcal{L}(E)\}\$ is sharp, as demonstrated by the example of almost Mathieu operators (see the definition later) [\[1,](#page-5-2) [14,](#page-5-3) [18\]](#page-6-3).

Over the past decades, Gordon-type arguments have been widely applied to the spectral theory of various models [\[5](#page-5-4)[–7](#page-5-5), [9](#page-5-6), [10](#page-5-7), [15](#page-5-8)[–17,](#page-6-4) [23,](#page-6-5) [25](#page-6-6), [26](#page-6-7), [28](#page-6-8), [29\]](#page-6-9).

For γ -reflective repetition potentials, Jitomirskaya and Simon [\[22\]](#page-6-10) proved that H has no eigenvalues in the regime

(5)
$$
\{E \in \mathbb{C} : \gamma > 2\mathcal{L}(E)\}.
$$

Recently, Jitomirskaya and the author improved the threshold, reducing the numerical number in [\(5\)](#page-1-0) from 2 to 1 [\[19\]](#page-6-11). This result is also sharp, as evidenced by the almost Mathieu operator [\[19\]](#page-6-11) (also see Ge-You-Zhou [\[11](#page-5-9)]). The Jitomirskaya-Simon argument has been commonly used to study Schrödinger operators with reflective repetition potentials, e.g., [\[4](#page-5-10), [8](#page-5-11), [13](#page-5-12), [20](#page-6-12)].

In the present paper, we build on the approaches developed by Jitomirskaya-Simon [\[22\]](#page-6-10) and Jitomirskaya-Liu [\[19\]](#page-6-11) to study almost reflective repetition potentials. Our methods provide a new proof of the absence of eigenvalues for almost repetition potentials.

Theorem 1.1. Assume $\gamma > \mathcal{L}(E)$. Then the eigen-equation $Hu = Eu$ has no $\ell^2(\mathbb{Z})$ solutions.

Consider the (discrete) quasi-periodic Schrödinger operator on $\ell^2(\mathbb{Z})$:

(6)
$$
(H_{v,\alpha,\theta}u)(k) = u(k+1) + u(k-1) + v(\theta + k\alpha)u(k), \quad k \in \mathbb{Z},
$$

where $v : \mathbb{T} = \mathbb{R}/\mathbb{Z} \to \mathbb{R}$ is a continuous potential, α is the frequency, and θ is the phase.

Let $L(E)$ denote the Lyapunov exponent of the operator [\(6\)](#page-2-0):

(7)
$$
L(E) = \limsup_{j \to \infty} \frac{1}{j} \int_{\mathbb{T}} \ln \|T_{j,0}(E)\| \, d\theta = \lim_{j \to \infty} \frac{1}{j} \int_{\mathbb{T}} \ln \|T_{j,0}(E)\| \, d\theta.
$$

For quasi-periodic Schrödinger operators with continuous potentials, it is known that $L(E) = \mathcal{L}(E)$ (independent of θ).

Define

$$
\beta(\alpha) = \limsup_{k \to \infty} \frac{-\ln \|k\alpha\|_{\mathbb{T}}}{k},
$$

where $||x||_T = \text{dist}(x, \mathbb{Z}).$

Corollary 1.2. *Assume* v *is* κ*-H¨older continuous. Then* H *has no eigenvalues in the regime* $\{E \in \mathbb{C} : L(E) < \kappa \beta(\alpha)\}.$

By setting $v(\theta) = 2\lambda \cos(2\pi\theta)$ in [\(6\)](#page-2-0), we obtain the almost Mathieu operator $H_{\lambda,\alpha,\theta}$. For the almost Mathieu operator, the Lyapunov exponent on the spectrum is given by $L(E) = \max{\{\ln |\lambda|, 0\}}$ [\[3\]](#page-5-13).

As a consequence, Corollary [1.2](#page-2-1) implies:

Corollary 1.3. *Assume* α *satisfies* $\beta(\alpha) > 0$ *. For the almost Mathieu operator,* $H_{\lambda,\alpha,\theta}$ has no eigenvalues when $|\lambda| < e^{\beta(\alpha)}$.

Remark 1. *As mentioned earlier, Corollary [1.3](#page-2-2) was previously proved using an improved Gordon-type argument [\[1](#page-5-2)].*

2. Proof of Theorem [1.1](#page-2-3)

Without loss of generality, assume that $k_n \to \infty$. The proof of the case $k_n \to -\infty$ is similar. Since the spectrum of $H = \Delta + V$ is bounded, we can assume E is bounded. By the definition of $\mathcal{L}(E)$, one has that

(8)
$$
||T_{m,j}(E)|| \le Ce^{(\mathcal{L}(E)+\varepsilon)|m-j|},
$$

where the constant C depends on ε and the potential V.

Lemma 2.1. *For all* $m, j \in \mathbb{Z}$ *, we have*

$$
||T_{m,j}(E) - T_{m+k_n,j+k_n}(E)|| \le Ce^{-\gamma k_n} e^{(\mathcal{L}(E) + \varepsilon)|m-j|}.
$$

Proof. By [\(8\)](#page-2-4), the proof of Lemma [2.1](#page-2-5) follows from the standard telescoping. See [\[28,](#page-6-8) Lemma 4.5] for example. \square

Proof of Theorem [1.1](#page-2-3). We prove it by contradiction. Suppose there exists E with $\mathcal{L}(E) < \gamma$ such that the eigen-equation $Hu = Eu$ has an $\ell^2(\mathbb{Z})$ solution u . Assume u is normalized, namely

$$
||u||_{\ell^2} = \sum_{k \in \mathbb{Z}} |u(k)|^2 = 1.
$$

For each $n \in \mathbb{Z}_+$, define sequences $\{u_n(k)\}_{k\in\mathbb{Z}}$ and $\{V_n(k)\}_{k\in\mathbb{Z}}$ as $u_n(k) = u(k_n + \mathbb{Z})$ k) and $V_n(k) = V(k_n + k)$, $k \in \mathbb{Z}$. Then by [\(2\)](#page-0-0), one has that

(9)
$$
|V(k) - V_n(k)| \le e^{-\gamma k_n}, \text{ for all } k \in \mathbb{Z}.
$$

We also have

(10)
$$
u(k+1) + u(k-1) + V(k)u(k) = Eu(k)
$$

and

(11)
$$
u_n(k+1) + u_n(k-1) + V_n(k)u_n(k) = Eu_n(k).
$$

Let $W(k) = W(f, g) = f(k+1)g(k) - f(k)g(k+1)$ be the Wronskian. By a standard calculation using (9) , (10) and (11) , we have

$$
|W(u, u_n)(k) - W(u, u_n)(k-1)| \leq |V(k) - V_n(k)||u(k)u_n(k)|
$$

$$
\leq e^{-\gamma k_n}|u(k)u_n(k)|.
$$

This implies for any $m \geq 0$ and k,

$$
|W(u, u_n)(k+m) - W(u, u_n)(k-1)| \leq e^{-\gamma k_n} \sum_{j=0}^{m} |u(k+j)u_n(k+j)|
$$

(12)
$$
\leq e^{-\gamma k_n},
$$

where the second inequality holds by the Cauchy–Schwarz inequality and the fact that $||u||_{\ell^2} = ||u_n||_{\ell^2} = 1$.

.

Notice that $\sum_{k} |W(u, u_n)(k)| \leq 2$. Therefore,

(13)
$$
\lim_{k \to \infty} |W(u, u_n)(k)| = 0.
$$

By [\(12\)](#page-3-3) and [\(13\)](#page-3-4), we must have that for all $k \in \mathbb{Z}$,

(14)
$$
|W(u, u_n)(k)| \le e^{-\gamma k_n}
$$

Letting $k = -1$ in [\(14\)](#page-3-5), one has that

(15)
$$
|W(u, u_n)(-1)| = \left| \det \begin{pmatrix} u(0) & u(k_n) \\ u(-1) & u(k_n-1) \end{pmatrix} \right| \le e^{-\gamma k_n}.
$$

Write $\begin{pmatrix} u(k_n) \\ u(k_n-1) \end{pmatrix}$ as the linear combination of $\begin{pmatrix} u(0) \\ u(-1) \end{pmatrix}$ and $\begin{pmatrix} -u(-1) \\ u(0) \end{pmatrix}$, namely

(16)
$$
\begin{pmatrix} u(k_n) \\ u(k_n - 1) \end{pmatrix} = a_n \begin{pmatrix} u(0) \\ u(-1) \end{pmatrix} + b_n \begin{pmatrix} -u(-1) \\ u(0) \end{pmatrix}.
$$

Since u is non-trivial, one has that

(17)
$$
|u(0)|^2 + |u(-1)|^2 > 0.
$$

By (15) , (16) and (17) , we have that

(18)
$$
b_n = O(e^{-\gamma k_n}).
$$

Since $u \in \ell^2(\mathbb{Z})$, one has that

$$
(19) \t\t\t a_n = o(1),
$$

as $n \to \infty$. By the definition of transfer matrices, one has that

(20)
$$
\begin{pmatrix} u(k) \\ u(k-1) \end{pmatrix} = T_{k,m}(E) \begin{pmatrix} u(m) \\ u(m-1) \end{pmatrix}.
$$

Multiplying T_{0,k_n} on both sides of [\(16\)](#page-4-0), we conclude that

(21)
$$
\begin{pmatrix} u(0) \\ u(-1) \end{pmatrix} = a_n T_{0,k_n}(E) \begin{pmatrix} u(0) \\ u(-1) \end{pmatrix} + b_n T_{0,k_n}(E) \begin{pmatrix} -u(-1) \\ u(0) \end{pmatrix}
$$

(22)
$$
= a_n T_{0,k_n}(E) \begin{pmatrix} u(0) \\ u(-1) \end{pmatrix} + O(e^{-(\gamma-\mathcal{L}(E)-\varepsilon)k_n})
$$

(23)
$$
= a_n T_{-k_n,0}(E) \begin{pmatrix} u(0) \\ u(-1) \end{pmatrix} + O(e^{-(\gamma - \mathcal{L}(E) - \varepsilon)k_n})
$$

(24)
$$
= a_n \begin{pmatrix} u(-k_n) \\ u(-k_n-1) \end{pmatrix} + O(e^{-(\gamma-\mathcal{L}(E)-\varepsilon)k_n}),
$$

where (21) and (24) hold by (20) , (22) holds by (8) and (18) , and (23) holds by Lemma [2.1.](#page-2-5) The equality [\(24\)](#page-4-2) can not hold since $\left(u(-k_n) \atop u(-k_n-1) \right) \Big\| = o(1)$ and $a_n = o(1)$ as $n \to \infty$. We finish the proof.
