A STRENGTHENING OF THE HARNACK INEQUALITY

Abstract. We prove the stronger version of Harnack's inequality for positive harmonic functions defined on the unit disc.

1. Introduction and the main result

Let $\mathbb{U} = \{z \in \mathbb{C} : |z| < 1\}$ be the unit disc. It is known (see e.g. [\[1,](#page-5-0) p. 47] or [\[4,](#page-5-1) p. 13]) that the harmonic function $u : \mathbb{U} \to (0, +\infty)$ satisfies Harnack's inequality

(1)
$$
\frac{1-|z|}{1+|z|} \leq \frac{u(z)}{u(0)} \leq \frac{1+|z|}{1-|z|}
$$

for all $z \in \mathbb{U}$.

In this paper we prove the following stronger version of this classical result.

Theorem 1. Let $u : \mathbb{U} \to (0, +\infty)$ be a harmonic function. Then

$$
(2)\quad \left(\frac{1+|z|^2}{1-|z|^2}+\frac{|\nabla u(0)|}{u(0)}\frac{|z|}{1-|z|^2}\right)^{-1}\leqslant \frac{u(z)}{u(0)}\leqslant \left(\frac{1+|z|^2}{1-|z|^2}+\frac{|\nabla u(0)|}{u(0)}\frac{|z|}{1-|z|^2}\right),
$$

for all $z \in \mathbb{U}$. Here $\nabla u = (u_x, u_y)$ is the gradient of the function u.

Since for harmonic function $u : \mathbb{U} \to (0, +\infty)$ we have $|\nabla u(0)| \leq 2u(0)$ (see inequality [\(12\)](#page-2-0) below), it follows that

(3)
$$
\frac{1+|z|^2}{1-|z|^2} + \frac{|\nabla u(0)|}{u(0)} \frac{|z|}{1-|z|^2} \leq \frac{1+|z|}{1-|z|}
$$

and

(4)
$$
\left(\frac{1+|z|^2}{1-|z|^2}+\frac{|\nabla u(0)|}{u(0)}\frac{|z|}{1-|z|^2}\right)^{-1}\geqslant \frac{1-|z|}{1+|z|}
$$

for all $z \in \mathbb{U}$. Therefore, the inequality [\(2\)](#page-0-0) is stronger than the inequality [\(1\)](#page-0-1).

Fix $c \in \mathbb{U}$ and denote by φ_c the mapping given by

$$
\varphi_c(z) = \frac{z+c}{1+\overline{c}z}.
$$

It is known that φ_c is a conformal isomorphism of the unit disc U onto itself. In particular, if $c = 1$, then we define $\varphi_c(z) = 1$ for all $z \in \mathbb{U}$.

The following example shows that there is function $u : \mathbb{U} \to (0, +\infty)$ and $z \in \mathbb{U}$, so that the equality in [\(1\)](#page-0-1) holds.

Example 1. Let $0 \leq c \leq 1$ and let $u_1, u_2 : \mathbb{U} \to (0, +\infty)$ be defined by

$$
u_1(z) = \text{Re}\,\frac{1 + z\varphi_c(z)}{1 - z\varphi_c(z)}.
$$

and

$$
u_2(z) = \text{Re} \frac{1 - z\varphi_c(z)}{1 + z\varphi_c(z)}.
$$

Then $u_1(0) = u_2(0) = 1$ and $|\nabla u_1(0)| = |\nabla u_2(0)| = 2c$. Further,

$$
\frac{u_1(x)}{u_1(0)} = \frac{1 + x^2}{1 - x^2} + \frac{|\nabla u_1(0)|}{u_1(0)} \frac{x}{1 - x^2}
$$

and

$$
\frac{u_2(x)}{u_2(0)} = \left(\frac{1+x^2}{1-x^2} + \frac{|\nabla u_2(0)|}{u_2(0)}\frac{x}{1-x^2}\right)^{-1},
$$

for all $x \in [0, 1)$.

To prove the Theorem [1,](#page-0-2) we use the hyperbolic densities on the unit disc U and on the right half-plane $\mathbb{K} = \{z \in \mathbb{C} : \text{Re } z > 0\}.$

The hyperbolic density on the unit disc U is defined by

$$
\rho_{\mathbb{U}}(z) = \frac{2}{1 - |z|^2}, \quad z \in \mathbb{U}.
$$

Based on Riemann's Mapping Theorem we can define the hyperbolic density on an arbitrary simply connected domain $\Omega \subset \mathbb{C}$, Ω different from \mathbb{C} (we call these domains hyperbolic), in the following way

$$
\rho_{\Omega}(z) = \rho_{\mathbb{U}}(\phi(z))|\phi'(z)|, \quad z \in \Omega,
$$

where $\phi : \Omega \to \mathbb{U}$ is a conformal isomorphism from Ω onto U. In particular, if ψ is defined by $\psi(z) = \frac{z-1}{z+1}$, then ψ is a conformal isomorphism from K onto U and by direct calculation we obtain

$$
\rho_{\mathbb{K}}(z) = \frac{1}{\text{Re } z}, \quad z \in \mathbb{K}.
$$

We define the hyperbolic distance on a hyperbolic domain Ω as follows

(5)
$$
d_{\Omega}(z_1, z_2) = \inf \int_{\gamma} \rho_{\Omega}(z) |dz|,
$$

where the infimum is taken over all C^1 curves γ that connect z_1 with z_2 in Ω . Specifically, it can be shown that

$$
d_{\mathbb{U}}(z,0) = \log \frac{1+|z|}{1-|z|} = 2 \operatorname{artanh}|z|.
$$

Let $f : \Omega_1 \to \Omega_2$ (Ω_1 and Ω_2 are hyperbolic domains in \mathbb{C}) be a holomorphic function. The famous Schwarz-Pick lemma asserts that

(6)
$$
\rho_{\Omega_2}(f(z))|f'(z)| \leq \rho_{\Omega_1}(z), \quad z \in \Omega_1.
$$

As a corollary of [\(6\)](#page-1-0) we have

(7)
$$
d_{\Omega_2}(f(z_1), f(z_2)) \leq d_{\Omega_1}(z_1, z_2)
$$
, for all $z_1, z_2 \in \Omega_1$.

Moreover, if f is a conformal isomorphism from Ω_1 onto Ω_2 , then equalities hold in [\(6\)](#page-1-0) and [\(7\)](#page-1-1). Thus, if f is a conformal isomorphism from Ω_1 onto Ω_2 , then f is an isometry from the metric space (Ω_1, d_{Ω_1}) onto the metric space (Ω_2, d_{Ω_2}) .

The hyperbolic derivative of f at $z \in \Omega_1$ (for motivation and details see section 5 in [\[3\]](#page-5-2), cf. [\[2\]](#page-5-3)) is defined as follows

$$
f^h(z) = \frac{\rho_{\Omega_2}(f(z))}{\rho_{\Omega_1}(z)} f'(z).
$$

From [\(6\)](#page-1-0) it follows immediately that $|f^h(z)| \leq 1$ for all $z \in \Omega_1$.

Using this notion, A. F. Beardon and T. K. Carne proved the following theorem, which is a strengthening of the Schwarz-Pick inequality [\(7\)](#page-1-1).

Theorem 2 ([\[2\]](#page-5-3)). Let $f : \Omega_1 \to \Omega_2$ (Ω_1 and Ω_2 are hyperbolic domains in \mathbb{C}) be a holomorphic function. Then

(8)
$$
d_{\Omega_2}(f(z_1), f(z_2)) \le \log \Big(\cosh d_{\Omega_1}(z_1, z_2) + |f^h(z)| \sinh d_{\Omega_1}(z_1, z_2) \Big).
$$

Note that in the paper [\[2\]](#page-5-3) the previous theorem was formulated and proved for the case $\Omega_1 = \Omega_2 = \mathbb{U}$. The version of this theorem that we have stated follows directly from the theorem given in [\[2\]](#page-5-3). The inequality [\(8\)](#page-2-1) plays a crucial role in the proof of the Theorem [1.](#page-0-2) In addition, the following elementary facts play an important role in this proof (for this approach see [\[6\]](#page-5-4)).

- 1) If $u : \mathbb{U} \to (0, +\infty)$ is a harmonic function, then it is known that there exists a holomorphic function $f: \mathbb{U} \to \mathbb{K}$ such that $\text{Re } f = u$ and $f(0) = u(0)$.
- 2) Using the Schwarz-Pick inequality, we obtain

(9)
$$
\rho_{\mathbb{K}}(f(z))|f'(z)| \leq \rho_{\mathbb{U}}(z), \quad z \in \mathbb{U}.
$$

3) Due to the Cauchy-Riemann equations, we have $f' = u_x - i u_y$, i.e. $f' =$ $(u_x, -u_y) = \overline{\nabla u}$. From this follows

(10)
$$
|f'(z)| = |\overline{\nabla u}(z)| = |\nabla u(z)|, \quad z \in \mathbb{U}.
$$

4) Since $\rho_{\mathbb{K}}(z) = \frac{1}{\text{Re } z}$, $z \in \mathbb{K}$ we get

(11)
$$
\rho_{\mathbb{K}}(f(z)) = \rho_{\mathbb{K}}(u(z)), \quad z \in \mathbb{U}.
$$

5) From [\(9\)](#page-2-2), [\(10\)](#page-2-3) and [\(11\)](#page-2-4) we immediately obtain the following proposition.

Proposition 1. Let $u : \mathbb{U} \to (0, +\infty)$ be a harmonic function. Then

$$
\rho_{\mathbb{K}}(u(z))|\nabla u(z)|\leqslant \rho_{\mathbb{U}}(z),
$$

i.e.

(12)
$$
|\nabla u(z)| \leqslant \frac{2u(z)}{1-|z|^2},
$$

for all $z \in \mathbb{U}$. Moreover, if u is the real part of a conformal isomorphism from \mathbb{U} onto K, then in [\(12\)](#page-2-0) equality holds for all $z \in \mathbb{U}$. On the other hand, if in (12) equality holds for some $z \in \mathbb{U}$, then u is the real part of a conformal isomorphism U onto K.

We call the facts [1](#page-2-5))-5) together with the Proposition 1 the *half-plane method*. This method can be seen as an analogous version of the strip method used in the paper $[7]$ (see also $[6]$).

Note that the following theorem can be derived as a corollary of [\(12\)](#page-2-0).

Theorem 3 ([\[5,](#page-5-6) Theorem 1.1]). Let $u : \mathbb{U} \to (0, +\infty)$ be a harmonic function. Then

(13)
$$
d_{\mathbb{K}}(u(z_1), u(z_2)) \leq d_{\mathbb{U}}(z_1, z_2),
$$

for all $z_1, z_2 \in \mathbb{U}$.

Remark 1. In [\[5\]](#page-5-6), M. Marković proved the Theorem [3](#page-3-0) for the case where the domain of the function u is $\mathbb{H} = \{z \in \mathbb{C} : \text{Im } z > 0\}$, but this is not essential since $\mathbb H$ and $\mathbb U$ are conformally equivalent.

Remark 2. Considering the proof of the Theorem [3](#page-3-0) from the paper [\[8\]](#page-5-7), it is straightforward to prove that [\(13\)](#page-3-1) is equivalent to Harnack's inequality.

For further results of this type of inequalities, we refer the reader to [\[9\]](#page-5-8) and the literature cited there.

2. Proof of the main result

First we recall another notion and prove two lemmas.

For a hyperbolic domain Ω , $a \in \Omega$ and $r > 0$ we denote by $\overline{D}_{\Omega}(a, r)$ a hyperbolic closed disc with centre a and radius r, i.e. $\overline{D}_{\Omega}(a,r) = \{z \in \Omega : d_{\Omega}(z,a) \leq r\}$. It is simply checked that

(14)
$$
\overline{D}_{\mathbb{U}}(0, 2 \arctan h r) = \{z \in \mathbb{U} : |z| \leqslant r\},
$$

for all $r \in (0,1)$.

Lemma 1. Let $b \in (0, +\infty)$ and $r \in (0, 1)$. If $z \in \overline{D}_{\mathbb{K}}(b, 2 \text{artanh } r)$ then

$$
\operatorname{Re} z \in \left[\frac{1-r}{1+r}b, \frac{1+r}{1-r}b\right]
$$

.

Proof. Recall that the mapping ψ defined by $\psi(z) = \frac{z-1}{z+1}$ is a conformal isomorphism from K onto U. Set $\kappa = \psi^{-1}$, $a = \psi(b)$ and $\kappa_b = \kappa \circ \varphi_a$. It is clear that κ_b is a conformal isomorphism from U onto K and $\kappa_b(0) = b$. Therefore, κ_b is an isometry from the metric space $(\mathbb{U}, d_{\mathbb{U}})$ onto the metric space $(\mathbb{K}, d_{\mathbb{K}})$. Therefore

$$
\kappa_b\left(\overline{D}_{\mathbb{U}}(0, 2 \operatorname{artanh} r)\right) = \overline{D}_{\mathbb{K}}(b, 2 \operatorname{artanh} r).
$$

On the other hand, taking into account [\(14\)](#page-3-2) we have

$$
\kappa_b\Big(\overline{D}_{\mathbb{U}}(0, 2 \operatorname{artanh} r)\Big) = \kappa_b\Big(\big\{z \in \mathbb{U} : |z| \leqslant r\big\}\Big).
$$

Furthermore, we obtain by straightforward calculations that $\kappa_b(\lbrace z \in \mathbb{U} : |z| \leqslant r \rbrace)$ is a closed Euclidean disc with centre $c = \frac{1+r^2}{1+r^2}$ $\frac{1+r^2}{1-r^2}b$ and radius $R=\frac{2r}{1-r^2}$ $\frac{2r}{1-r^2}b$. So, if $z \in \kappa_b(\{z \in \mathbb{U}: |z| \leqslant r\})$ then

$$
\operatorname{Re} z \in [c - R, c + R] = \left[\frac{1 - r}{1 + r}, \frac{1 + r}{1 - r}\right].
$$

Lemma 2. Let $0 \leq c \leq 1$. Then, for all $z \in \mathbb{U}$,

(15)
$$
\log(\cosh d_{\mathbb{U}}(z,0) + c \sinh d_{\mathbb{U}}(z,0)) = \log\left(\frac{1+|z|^2 + 2c|z|}{1-|z|^2}\right)
$$

$$
= d_{\mathbb{U}}(|z|\varphi_c(|z|),0).
$$

Proof. Let $z \in \mathbb{U}$ be arbitrary. The first equality in [\(15\)](#page-4-0) holds due to the fact that

$$
\cosh d_{\mathbb{U}}(z,0) = \frac{1+|z|^2}{1-|z|^2} \quad \text{ i } \quad \sinh d_{\mathbb{U}}(z,0) = \frac{2|z|}{1-|z|^2}.
$$

To prove the second equality in [\(15\)](#page-4-0), we have to determine a point $R(z) \in [0,1)$ such that

(16)
$$
d_{\mathbb{U}}(R(z),0) = \log \left(\frac{1+|z|^2 + 2c|z|}{1-|z|^2} \right).
$$

Note that the equality [\(16\)](#page-4-1) is equivalent to the equality

$$
\frac{1 + R(z)}{1 - R(z)} = \frac{1 + |z|^2 + 2c|z|}{1 - |z|^2},
$$
\nIt has we get

\n
$$
R(z) = |z| \frac{c + |z|}{1 + c|z|} = |z| \varphi_c(|z|).
$$

Proof of the Theorem [1.](#page-0-2) By using the half-plane method, we obtain that there is a unique holomorphic function $f : \mathbb{U} \to \mathbb{K}$ such that $\text{Re } f = u, f(0) = u(0),$ $|f'(0)| = |\nabla u(0)|$ and

$$
|f^h(0)| = \frac{\rho_{\mathbb{K}}(f(0))}{\rho_{\mathbb{U}}(0)} |f'(0)| = \frac{|\nabla u(0)|}{2u(0)}.
$$

Define $c = \frac{|\nabla u(0)|}{2u(0)}$. According to Theorem [2,](#page-2-6) if $\Omega_1 = \mathbb{U}$ and $\Omega_2 = \mathbb{K}$ we get

(17)
$$
d_{\mathbb{K}}(f(z), f(0)) \leq \log\left(\cosh d_{\mathbb{U}}(z, 0) + c \sinh d_{\mathbb{U}}(z, 0)\right)
$$

for all $z \in \mathbb{U}$. By Lemma [2](#page-4-2) we thus have

$$
d_{\mathbb{K}}(f(z), f(0)) \leq 2 \operatorname{artanh} (|z|\varphi_c(|z|)),
$$

i.e

and from

$$
f(z) \in \overline{D}_{\mathbb{K}}\Big(f(0), 2 \operatorname{artanh}\Big(|z|\varphi_c(|z|)\Big)\Big).
$$

Using Lemma [1](#page-3-3) (note that $f(0) = u(0)$ and $u = \text{Re } f$) we now obtain

(18)
$$
u(z) \in \left[\frac{1-|z|\varphi_c(|z|)}{1+|z|\varphi_c(|z|)}u(0), \frac{1+|z|\varphi_c(|z|)}{1-|z|\varphi_c(|z|)}u(0)\right]
$$

But since $\frac{1+|z|\varphi_c(|z|)}{1-|z|\varphi_c(|z|)} = \frac{1+|z|^2+2c|z|}{1-|z|^2}$ $\frac{|z|+|z-|z|}{1-|z|^2}$, it follows that [\(18\)](#page-4-3) is equivalent to [\(1\)](#page-0-1).
