# DETECTING FREE PRODUCTS IN THE MAPPING CLASS GROUP OF PUNCTURED DISKS VIA DYNNIKOV COORDINATES

ABSTRACT. We prove that Dehn twists about certain k curves on an n-punctured disk generate either a free group of rank k or a free product of Abelian groups, depending on the configuration of the curves. Our approach refines previously known criteria, providing a different method for detecting freeness in the mapping class group of the punctured disk. Using Dynnikov coordinates, we further present an algorithm that checks whether Dehn twists about these k curves generate a free group or a free product of Abelian groups.

# 1. INTRODUCTION

Let  $\Sigma$  be a compact, connected, orientable surface of genus g, possibly with finitely many punctures or boundary components. The mapping class group  $Mod(\Sigma)$  of  $\Sigma$  is the group of isotopy classes of orientation-preserving homeomorphisms of  $\Sigma$ . It is well known that  $Mod(\Sigma)$ is generated by Dehn twists (see, for example, [2, 4, 8, 12] for some references).

The geometric intersection number  $\iota(c_1, c_2)$  between two isotopy classes of simple closed curves  $c_1$  and  $c_2$  is the minimum number of intersection points between two representatives  $\gamma_1 \in c_1$  and  $\gamma_2 \in c_2$ . A natural question regarding the algebraic structure of the mapping class group is to understand which subgroups of  $Mod(\Sigma)$  are generated by Dehn twists along curves based on their geometric intersection number [5, 6, 7, 9, 10, 11]. In particular, in [5, 9, 10] it is shown that if  $\iota(c_1, c_2) \geq 2$  then the subgroup generated by the Dehn twists about  $c_1$  and  $c_2$  is isomorphic to a free group of rank two. Using Dynnikov coordinates [3] and so-called update rules [15, 17], a different proof for a particular case of this result is given in [1]. See also [4, 11] for the classification of groups generated by powers of two Dehn twists. The question of which groups can be generated by more than two Dehn twists has been studied only under some particular conditions [6, 7].

In this paper, we focus on subgroups of  $Mod(D_n)$  generated by Dehn twists about a certain collection of k curves on n-punctured disk  $D_n$  and we prove that Dehn twists about these curves generate a free group of rank k or a free product of Abelian groups. We use a different approach in this paper: we introduce critical definitions family of opposite curves and complete family of opposite curves in Section 3 and we use Dynnikov coordinates in  $D_n$  which give a one-to-one correspondence between the set of multicurves in  $D_n$  and  $\mathbb{Z}^{2n-4} \setminus \{0\}, n \geq 3$ .

The main contribution of this paper is given in Theorem 4.1. By making use of Dynnikov coordinates, we refine the conditions on the set of curves previously established in Theorem 2.1 of [7] and Theorem 7.2 of [6] for the special case where the surface under consideration is  $D_n$ . These refinements streamline some of the existing results and introduce new conditions on the set of curves that differ from those in the earlier theorems.

This paper is organized as follows. Section 2 revisits the theory of Dynnikov coordinates and gives preliminary definitions. Section 3 introduces necessary auxiliary definitions, and establishes a key proposition that underpins the proof of our main theorem. Section 4 states and proves our principal result, Theorem 4.1, and includes illustrative examples of particular significance to the field. Lastly, Section 5 presents the Algorithm 5.1.

### 2. Preliminaries

Here and in what follows a curve c in  $D_n$  means the isotopy class of an essential simple closed curve in  $D_n$  (i.e. c does not bound a puncture, or the boundary component). We denote by  $t_c$  the positive (right-handed) Dehn twist about the curve c.

2.1. The Dynnikov coordinate system. The Dynnikov coordinate system [3] gives, for each  $n \geq 3$ , a bijection  $\rho: S_n \to \mathbb{Z}^{2n-4} \setminus \{0\}$ , where  $S_n$  denotes the set of multicurves (collection of mutually disjoint essential simple closed curves up to isotopy) in  $D_n$ , which is defined as follows:

Construct Dynnikov arcs  $\alpha_i$   $(1 \leq i \leq 2n-4)$  and  $\beta_i$   $(1 \leq i \leq n-1)$  in  $D_n$  as depicted in Figure 1. Every multicurve  $\mathcal{L} \in \mathcal{S}_n$ , has a taut representative L of  $\mathcal{L}$  which intersects each  $\alpha_i$ and  $\beta_i$  minimally. We also write  $\alpha_i$  and  $\beta_i$  for the number of intersections of L with the arc  $\alpha_i$ and  $\beta_i$  respectively.

The Dynnikov coordinate function  $\rho: S_n \to \mathbb{Z}^{2n-4} \setminus \{0\}$  is defined by  $\rho(\mathcal{L}) = (a; b) = (a_1, \dots, a_{n-2}; b_1, \dots, b_{n-2}),$ 

(2.1) 
$$a_i = \frac{\alpha_{2i} - \alpha_{2i-1}}{2}$$
 and  $b_i = \frac{\beta_i - \beta_{i+1}}{2}$ 

for  $1 \leq i \leq n-1$ .

We would like to note that for a curve  $c \in S_n$  with  $\rho(c) = (a; b) = (a_1, \ldots, a_{n-2}; b_1, \ldots, b_{n-2})$ we denote  $b_i(c) = b_i$ .

2.2. Auxiliary Definitions. In this subsection, we introduce the notions of a family of opposite curves and a complete family of opposite curves, both determined by the configurations of curves on  $D_n$ .

Let  $\Delta_i$  be the region in  $D_n$  bounded by the arcs  $\beta_i$  and  $\beta_{i+1}$  (see Figure 1). We write  $\Delta_{i,j} = \bigcup_{k=i}^{j} \Delta_k$  (see Figure 2).

**Definition 2.1.** (Loops) Let  $c \in S_n$ . A left loop of  $c \cap \Delta_i$  has both end points on  $\beta_{i+1}$  and a right loop of  $c \cap \Delta_i$  has both end points on  $\beta_i$ . A large left loop of  $c \cap \Delta_{i,j}$  (j > i) has both end points on  $\beta_{j+1}$ , and intersects the horizontal diameter of  $D_n$  only between the punctures i and i + 1. Similarly, a large right loop of  $c \cap \Delta_{i,j}$  (j > i) has both end points on  $\beta_i$ , and intersects the horizontal diameter of  $D_n$  only between the punctures j + 1 and j + 2. We write  $L_{i,j}(c)$  and  $R_{i,j}(c)$  to denote the large left and large right loops of  $c \cap \Delta_{i,j}$  respectively (see

Figure 2). We also use the same symbols to denote the number of large and large loops of  $c \cap \Delta_{i,j}$  for convenience.

Remark 2.2. For any  $c \in S_n$ 

- $b_{i-1}(c) < 0$  if and only if c has a left loop
- $b_{i-1}(c) > 0$  if and only if c has a right loop
- $b_{i-1}(c) = 0$ , c has no loops

in  $\Delta_i$ .

**Definition 2.3.** (Opposite Loops) Let  $c_1, c_2 \in S_n$ . We say that  $c_1$  and  $c_2$  have opposite loops in  $\Delta_i$  if  $c_1 \cap \Delta_i$  is a right loop and  $c_2 \cap \Delta_i$  is a left loop in  $\Delta_i$  (or vice versa). Similarly,  $c_1 \cap \Delta_{i,j}$ and  $c_2 \cap \Delta_{i,j}$  have opposite large loops in  $\Delta_{i,j}$  if  $c_1$  has a large right loop and  $c_2$  has a large left loop in  $\Delta_{i,j}$  (or vice versa). See Figure 3.

Let  $(a; b) \in \mathbb{Z}^{2n-4} \setminus \{0\}$  and  $(a'; b') \in \mathbb{Z}^{2n-4} \setminus \{0\}$  be the Dynnikov coordinates of  $c_1$  and  $c_2$  respectively. Using Remark 2.2 we can tell whether or not  $c_1$  and  $c_2$  have opposite loops in  $\Delta_i$  from their Dynnikov coordinates. More precisely, we observe that  $c_1$  and  $c_2$  have opposite loops in  $\Delta_i$  if and only if  $b_i b'_i < 0$  and also  $c_1$  and  $c_2$  have opposite large loops in  $\Delta_{i,j}$  if and only if  $b_i b'_i < 0$  and also  $c_1$  and  $c_2$  have opposite large loops in  $\Delta_{i,j}$  if and only if  $R_{i,j}(c_1) \neq 0$  and  $L_{i,j}(c_2) \neq 0$  (or vice versa).

Remark 2.4. Note that we can interpret the numbers  $R_{i,j}$  and  $L_{i,j}$  for the case where i = j as the number of right and left loops of c in  $\Delta_i$ . That is,  $R_{i,i} \neq 0$  if and only if  $b_i(c) > 0$  and  $L_{i,i} \neq 0$  if and only if  $b_i(c) < 0$ .

# 3. Tools for the Main Theorem

3.1. Family of opposite curves. We begin by defining a well-known type of curves, called relaxed curves, which provide the foundation for our proof. We then extend these ideas to a newly introduced family of curves, referred to as the *family of opposite curves*.

**Definition 3.1.** (Relaxed Curves) A curve  $c_{i,j} \in D_n(i < j)$  is relaxed if it is isotopic to a simple closed curve which bounds a disk containing the set of punctures  $\{i, i+1, \ldots, j\}$ intersecting the horizontal diameter of the disk exactly twice (Figure 4).

**Definition 3.2.** (Opposite Curves) Let  $c_1, c_2 \in S_n$ . We call  $c_1$  and  $c_2$  opposite curves if  $c_1$ and  $c_2$  have opposite loops in some  $\Delta_{l,m}$ .

**Definition 3.3.** (Family of Opposite Curves) We say that  $\mathcal{C} = \{c_1, c_2, \ldots, c_k\}$  is a family of opposite curves if the following condition holds: if  $c_i, c_j \in \mathcal{C}$  then either  $\iota(c_i, c_j) = 0$  or  $c_i$  and  $c_i$  are opposite curves. If the latter condition holds for each pair of curves in  $\mathcal{C}$  then  $\mathcal{C}$  is called a complete family of opposite curves (see Figure 7).

Note that relaxed curves are family of opposite curves by their definition.

3.2. A crucial result. The next proposition says that if  $c_1$  and  $c_2$  are two opposite curves that have opposite loops in some region  $\Delta_{i,j}$  (or  $\Delta_i$  if the loops aren't large) then twisting  $c_1$ along  $c_2 p$  times,  $p \neq 0$ , creates a new curve  $t_{c_2}^p(c_1)$  which has the same type of loop as  $c_2$  in  $\Delta_{i,j}$ .

**Proposition 3.4.** Given  $c_1, c_2 \in S_n$ , let  $R_{i,j}(c_1) \neq 0$  and  $L_{i,j}(c_2) \neq 0$ . Then  $R_{i,j}(t_{c_1}^p(c_2)) \neq 0$ and  $L_{i,j}(t_{c_2}^p(c_1)) \neq 0$  for all  $p \neq 0$ .

*Proof.* Let  $R_{i,j}(c_1) \neq 0$  and  $L_{i,j}(c_2) \neq 0$ . Then  $c_1$  and  $c_2$  have opposite loops in  $\Delta_{i,j}$ . Applying a positive (or negative) Dehn twist  $t_{c_1}$  on  $c_2$  following the standard curve surgery illustrated in Figure 5 yields a curve  $c'_2$  which has a large right loop in  $\Delta_{i,j}$  as shown in Figure 6. Clearly, applying positive (negative) powers of  $t_{c_1}$  on  $c'_2$  increases  $\beta_{i-1}$  and leaves  $\beta_j$  invariant (see  $t^2_{c_1}(c_2)$ shown in Figure 6). Therefore,  $t_{c_1}^p(c_2)$  has a large right loop in  $\Delta_{i,j}$  that is  $R_{i,j}(t_{c_1}^p(c_2)) \neq 0$ . We prove  $L_{i,j}(t_{c_2}^p(c_1)) \neq 0$  similarly.

3.3. Complete partition and lists of loops. In this subsection we give a definition of *complete partition* which is first introduced in [7] by Humphries. Then we make some lists of loops of a curve.

**Definition 3.5.** (Complete Partition) Let  $\mathcal{C} = \{c_1, c_2, \ldots, c_k\}$  be a set curves in  $D_n$ . Then the collection  $\mathcal{P} = \{P_1, P_2, \dots, P_m\}$  (where each  $P_i \subseteq \mathcal{C}$ ) is called a complete partition of  $\mathcal{C}$ , if the following conditions are satisfied:

- (1)  $\iota(c_i, c_j) = 0$  for all  $c_i, c_j \in P_q \ (1 \le q \le m)$ .
- (2)  $\iota(c_i, c_j) \ge 2$  for all  $c_i \in P_q$  and  $c_j \in P_r$   $(q \ne r, 1 \le q, r \le m)$ . (3)  $\sum_{i=1}^m |P_i| = k$  where  $|P_i|$  denotes the the cardinality of  $P_i$ .

We call each  $P_i$  a partition set of  $\mathcal{P}$ .

Notation 1. Given  $c \in S_n$  we write List(c) for the set of all right and left loops of  $c \cap \Delta_{i,j}$   $(0 \le i \le j \le n-1)$ .

**Definition 3.6.** Let  $C = \{c_1, c_2, \ldots, c_k\}$  be a set of family of opposite curves in  $D_n$  and  $\mathcal{P} = \{P_1, P_2, \ldots, P_m\}$  be a complete partition of C. Let  $c_1$  and  $c_2$  be two curves in  $D_n$  which belong to two different partition sets. Let

(3.1)  $L_{c_2}(c_1) = \{L_{i,j} | L_{i,j} \in \text{List}(c_1) \text{ and } R_{i,j} \in \text{List}(c_2)\}$ 

(3.2)  $R_{c_2}(c_1) = \{ R_{i,j} | R_{i,j} \in \text{List}(c_1) \text{ and } L_{i,j} \in \text{List}(c_2) \}$ 

We write  $\operatorname{List}_{c_2}(c_1) = L_{c_2}(c_1) \bigcup R_{c_2}(c_1)$ . That is,  $\operatorname{List}_{c_2}(c_1)$  consists of loops of  $c_1$ , that are opposite with  $c_2$  (see Figure 7 and Example 1).

3.4. **Decisive set.** In what follows, we take union of the *opposite loops* of a curve with respect to curves in partitions that do not contain the curve itself. By virtue of Proposition 3.4, these loops can indicate on which curve the last Dehn twist is applied when we apply Dehn twists along a family of opposite curves; hence, we refer to the resulting collection as a *Decisive set*.

**Definition 3.7.** (Decisive Set) Let  $C = \{c_1, c_2, \ldots, c_k\}$  be a set of family of opposite curves in  $D_n$  and  $\mathcal{P} = \{P_1, P_2, \ldots, P_m\}$  be a complete partition of C. Let  $c_i \in P_k$ . Then a decisive set

 $Dec(c_i)$  for  $c_i$  is defined as

$$\operatorname{Dec}(c_i) = \bigcup_{c_j \notin P_k} \operatorname{List}_{c_j}(c_i) \text{ (see Example 1).}$$

3.5. The sets  $X_i$ 's. Next, for each partition  $P_i$ , we define the set  $X_i$  to be the collection of curves whose list of loops contains the decisive set of at least one curve in  $P_i$ . These sets  $X_i$  will play a crucial role in the proof of our main theorem, allowing us to invoke an argument reminiscent of the well-known Ping-Pong Lemma [13].

**Definition 3.8.** Let  $C = \{c_1, c_2, \ldots, c_k\}$  be a family of opposite curves in  $D_n$  and  $\mathcal{P} = \{P_1, P_2, \ldots, P_m\}$  be a complete partition of C. In the following definition let  $c = \alpha(c_1)$  for some freely reduced word  $\alpha \in \langle t_{c_1}, \ldots, t_{c_k} \rangle$ . We define

$$X_i = \{c | \operatorname{Dec}(c_r) \subseteq \operatorname{List}(c) \text{ for some } c_r \in P_i\}$$

(see Example 1).

*Example* 1. Let  $c_1, c_2, c_3$  and  $c_4$  be the colored curves depicted brown, purple, green and yellow in Figure 7. Then  $C = \{c_1, c_2, c_3, c_4\}$  is a complete opposite family of curves by Definition 3.3. Also, the set  $\mathcal{P} = \{P_1, P_2, P_3, P_4\}$  is a complete partition of C where  $P_1 = \{c_1\}, P_2 = \{c_2\}, P_3 = \{c_3\}$  and  $P_4 = \{c_4\}$  from Definition 3.5. Following Definition 1 we find that

$$List(c_1) = \{L_{0,1}, R_{2,2}, R_{3,4}, R_{4,4}\},\$$

$$List(c_2) = \{L_{1,1}, R_{2,2}, L_{3,4}, R_{4,5}, R_{5,5}\},\$$

$$List(c_3) = \{L_{2,2}, L_{3,3}, L_{3,4}, R_{4,5}, R_{5,5}\},\$$

$$List(c_4) = \{L_{2,2}, L_{2,3}, R_{3,4}, R_{4,4}\}.$$

Then for  $c_1$  we have:

$$\begin{split} L_{c_2}(c_1) &= \emptyset, & R_{c_2}(c_1) = \{R_{3,4}\}, & List_{c_2}(c_1) = \{R_{3,4}\} \\ L_{c_3}(c_1) &= \emptyset, & R_{c_3}(c_1) = \{R_{2,2}, R_{3,4}\}, & List_{c_3}(c_1) = \{R_{2,2}, R_{3,4}\} \\ L_{c_4}(c_1) &= \emptyset, & R_{c_4}(c_1) = \{R_{2,2}\}, & List_{c_4}(c_1) = \{R_{2,2}\} \end{split}$$

Therefore,

$$Dec(c_1) = \{R_{2,2}, R_{3,4}\}.$$
  
We similarly compute  $Dec(c_2) = \{R_{2,2}, L_{3,4}\}, Dec(c_3) = \{L_{2,2}, L_{3,4}\} \text{ and } Dec(c_4) = \{L_{2,2}, R_{3,4}\}.$ 

Next we compute the sets  $X_1, X_2, X_3, X_4$ . Let  $c = \alpha(c_1)$  for some freely reduced word  $\alpha \in \langle t_{c_1}, t_{c_2}, t_{c_3}, t_{c_4} \rangle$ . Then Definition 3.8 gives that

$$X_{1} = \{c \mid Dec(c_{1}) = \{R_{2,2}, R_{3,4}\} \subset \text{List}(c)\},\$$

$$X_{2} = \{c \mid Dec(c_{2}) = \{R_{2,2}, L_{3,4}\} \subset \text{List}(c)\},\$$

$$X_{3} = \{c \mid Dec(c_{3}) = \{L_{2,2}, L_{3,4}\} \subset \text{List}(c)\},\$$

$$X_{4} = \{c \mid Dec(c_{4}) = \{L_{2,2}, R_{3,4}\} \subset \text{List}(c)\}.\$$

$$4. \text{ MAIN THEOREM}$$

In this section, we present our main theorem and provide its proof. We then state several corollaries that follow from the theorem. Next, in Example 2, we determine the isomorphism type of the group generated by Dehn twists about the curves introduced in Example 1. To the best of the authors' knowledge, this construction differs from those previously described in the literature. Finally, Example 3 refines the conditions given in [7] by allowing existence of a disc

# **Theorem 4.1.** Let $C = \{c_1, c_2, \ldots c_k\}$ be a family of opposite curves on $D_n$ and $P_1, P_2, \ldots, P_m$ be a complete partition of C where $|P_i| = n_i$ $(1 \le i \le m)$ . Then $\langle t_{c_1}, \ldots, t_{c_k} \rangle$ is isomorphic to the free product $\mathbb{Z}^{n_1} * \mathbb{Z}^{n_2} * \cdots * \mathbb{Z}^{n_m}$ .

*Proof.* Let  $G = \langle t_{c_1}, \ldots, t_{c_k} \rangle$ . For  $1 \leq i \leq m$ , define

in the complement of the curves.

$$G_i = \left\langle t_{c_j} \mid c_j \in P_i \right\rangle \subseteq G,$$

where each  $P_i$  is one of the mutually disjoint partitions of the set  $\{c_1, \ldots, c_k\}$ . Since  $c_1 \in P_1$  by assumption and the curves in  $P_i$  are pairwise disjoint, each  $G_i$  is generated by commuting Dehn twists, implying

$$G_i \cong \mathbb{Z}^{n_i}$$
 where  $n_i = |P_i|$ .

Next, let  $\{X_i\}_{i=1}^m$  be the collection of mutually disjoint subsets of  $S_n$  as described in Definition 3.8, so that  $c_1 \in X_1$  and  $X_1 \cap X_i = \emptyset$  for  $i \neq 1$ .

To prove that

$$G \cong G_1 * G_2 * \cdots * G_m \cong \mathbb{Z}^{n_1} * \mathbb{Z}^{n_2} * \cdots * \mathbb{Z}^{n_m}$$

we use a ping-pong argument. Suppose, for contradiction, there were a nontrivial reduced word

$$\Gamma = w_1 w_2 \cdots w_s \in G$$

that represents the identity in G, subject to the following conditions:

- (i) Each  $w_i$  is nontrivial (i.e.  $w_i \neq id$ ).
- (ii)  $\Gamma$  starts and ends with an element of some fixed  $G_i$  for some  $i \neq 1$ .
- (iii) No two adjacent letters of  $\Gamma$  lie in the same subgroup  $G_{\ell}$ .

By assumption (ii) and Proposition 3.4, the action of  $\Gamma$  on the curve  $c_1$  sends  $c_1$  into  $X_i$ . However,  $c_1$  originally lies in  $X_1$ , and  $X_1 \cap X_i = \emptyset$  for  $i \neq 1$ . Hence  $\Gamma$  moves  $c_1$  to a distinct curve in  $X_i$ , and so  $\Gamma$  cannot be the identity transformation. This contradiction implies that no nontrivial reduced word in the subgroups  $G_i$  can represent the identity in G.

Finally, since any nontrivial element in G is conjugate to  $\Gamma$ , every such nontrivial element acts non-trivially by sending some curve in  $S_n$  to a disjoint set under the above partition. This verifies the *ping-pong lemma* criteria, showing that

$$G = \langle t_{c_1}, \dots, t_{c_k} \rangle \cong G_1 * G_2 * \dots * G_m \cong \mathbb{Z}^{n_1} * \mathbb{Z}^{n_2} * \dots * \mathbb{Z}^{n_m}.$$

**Corollary 4.2.** Let  $C = \{c_1, c_2, \ldots c_k\}$  be a complete family of opposite curves on  $D_n$ . Then  $\langle t_{c_1}, \ldots, t_{c_k} \rangle$  is isomorphic to the free group of rank  $k, F_k$ .

Example 2. Consider the curves  $C = \{c_1, c_2, c_3, c_4\}$  in  $D_6$  depicted in Figure 7. In this example we have a complete family of curves and  $\mathcal{P} = \{P_1, P_2, P_3, P_4\}$  a complete partition of C where  $P_1 = \{c_1\}, P_2 = \{c_2\}, P_3 = \{c_3\}$  and  $P_4 = \{c_4\}$ . Let  $G_1 = \langle t_{c_1} \rangle, G_2 = \langle t_{c_2} \rangle, G_3 = \langle t_{c_3} \rangle$  and  $G_4 = \langle t_{c_4} \rangle$ . Then by Proposition 3.4,  $t_{c_i}^p(X_j) \subset X_i$  for all  $t_{c_i} \in G_i$  for  $p \neq 0$  and  $i \neq j$ . Therefore by Theorem 4.1, we get  $\langle t_{c_1}, t_{c_2}, t_{c_3}, t_{c_4} \rangle = F_4$ .

**Corollary 4.3.** Let  $C = \{c_1, c_2, \ldots c_k\}$  be a set of relaxed curves with  $\iota(c_i, c_j) \neq 0$ , for all  $i \neq j$  on  $D_n$ . Then  $\langle t_{c_1}, \ldots, t_{c_k} \rangle$  is isomorphic to the free group of rank k,  $F_k$ .

Next, we illustrate Corollary 4.3 with Example 3.

*Example* 3. Consider the relaxed curves  $C = \{c_1, c_2, c_3\}$  in  $D_5$  depicted in Figure 8. In this example we have  $\mathcal{P} = \{P_1, P_2\}$  a complete partition of C where  $P_1 = \{c_1, c_3\}$  and  $P_2 = \{c_2\}$ . Using Definition 3.7 we obtain  $\text{Dec}(c_1) = \{R_{1,2}\}, \text{Dec}(c_2) = \{L_{1,2}, R_{3,3}\}, \text{Dec}(c_3) = \{L_{3,3}\}.$  Then, by Definition 3.8 we get:

$$X_1 = \{c \mid Dec(c_1) = \{R_{1,2}\} \subset \text{List}(c) \text{ or } Dec(c_3) = \{L_{3,3}\} \subset \text{List}(c) \}$$

$$X_2 = \{ c \mid Dec(c_2) = \{ L_{1,2}, R_{3,3} \} \subset \text{List}(c) \},\$$

where  $c = \alpha(c_1)$  for a freely reduced word  $\alpha$ , written in the generating set  $\{t_{c_1}, t_{c_2}, t_{c_3}\}$ . Let  $G_1 = \langle t_{c_1}, t_{c_3} \rangle$  and  $G_2 = \langle t_{c_2} \rangle$ . Then by Proposition 3.4,  $t_{c_q}^p(X_j) \subset X_i$  for all  $t_{c_q} \in G_i$  for  $p \neq 0$  and  $i \neq j$ . Therefore by Corollary 4.3, we get  $\langle t_{c_1}, t_{c_2}, t_{c_3} \rangle = \mathbb{Z}^2 * \mathbb{Z}$ .

### 5. Algorithm

5.1. Detecting right and left loops. We can explicitly compute the number of large right and left loops of  $c \cap \Delta_{i,j}$  [15]: Let  $c \in S_n$  with Dynnikov coordinates (a; b) and intersection numbers  $(\alpha; \beta)$ . For each i with  $1 \le i \le n$ , we write,

 $A_i = \alpha_{2i-3} - |b_{i-1}|$  and  $B_i = \alpha_{2i-2} - |b_{i-1}|$ .

For each  $\ell$  and m with  $1 \leq \ell \leq m \leq n$ , write

$$A_{\ell,m} = \min_{\ell \le k \le m} A_k$$
 and  $B_{\ell,m} = \min_{\ell \le k \le m} B_k$ 

Then,

$$R_{i,j} = \min(A_{i,j-1} - A_{i,j}, B_{i,j-1} - B_{i,j}, b_{j-1}^+), \text{ and}$$
  

$$L_{i,j} = \min(A_{i+1,j} - A_{i,j}, B_{i+1,j} - B_{i,j}, (-b_{i-1})^+),$$

where  $b_r^+$  is the number of right loops in  $\Delta_{r+1}$ .

Moreover, we can determine whether or not C is a family of opposite curves or a complete family of opposite curves from Dynnikov coordinates.

5.2. Test for opposite curves. There is an algorithm to calculate the geometric intersection number of two arbitrary curves in  $D_n$  given their Dynnikov coordinates which is stated in Algorithm 14 of [15]. Therefore, we can check whether two curves  $c_1$  and  $c_2$  are disjoint or not using Dynnikov coordinates. Furthermore, in the case where  $c_1$  and  $c_2$  intersect we can determine if  $c_1$  and  $c_2$  are opposite curves by Subsection 5.1 as follows: If  $L_{i,j}(c_1) \neq 0$  and  $R_{i,j}(c_2) \neq 0$  (or vice versa) for some i, j then  $c_1$  and  $c_2$  are opposite curves.

5.3. Statement of the algorithm. Let  $C = \{c_1, c_2, \ldots, c_k\}$  be a family of opposite curves in  $D_n$ . Then Dehn twists about the curves in C generate a free group of rank k or a free product of Abelian groups. Algorithm 5.1 computes which of these two groups  $t_{c_1}, \ldots, t_{c_k}$  generate taking as input the Dynnikov coordinates of  $c_1, c_2, \ldots, c_k$ .

Let  $P_i^{\star} = \{c_r \in \mathcal{C} : \iota(c_r, c_i) = 0\}$  and  $P_i \subseteq P_i^{\star}$  such that  $\iota(c_m, c_n) = 0$  for all  $c_m, c_n \in P_i$  $(1 \leq m, n \leq k)$ . Let  $|P_i|$  be the cardinality of  $P_i$ . For  $i \geq 2$ , let  $P_i^{\star} = \{c_r \in \mathcal{C} : \iota(c_r, c) = 0, c \in \mathcal{C} \setminus (P_1 \cup P_2 \cup \ldots \cup P_{i-1})\}$ .

Algorithm 5.1. Let  $(a^{(1)}; b^{(1)}), (a^{(2)}; b^{(2)}), \ldots, (a^{(k)}; b^{(k)})$  be the Dynnikov coordinates of the opposite curves  $c_1, c_2, \ldots, c_k$  in  $D_n$  respectively.

**Step 1:** Take  $c_1 \in C$  and construct  $P_1$  for  $c_1$ . Then construct  $P_i$  for  $c \in C \setminus (P_1 \cup P_2 \cup \ldots \cup P_n)$ 

 $P_{i-1}$ ) for  $1 < i \le m$  where  $\bigcup_{i=1}^{m} P_j = C$  and input the constructed sets  $P_1, P_2, \ldots, P_m$  to **Step 2**.

Step 2: If  $\sum_{i=1}^{m} |P_i| < k$  then  $P_1, P_2, \dots, P_m$  don't give a complete partition of C. Otherwise  $G \cong \mathbb{Z}^{|P_1|} * \mathbb{Z}^{|P_2|} * \dots * \mathbb{Z}^{|P_m|}$ .

Example 4. Let  $\rho(c_1) = (0, 0, 0; 0, 1, 0); \ \rho(c_2) = (0, 0, 0; -1, 0, 1)$  and  $\rho(c_3) = (0, 0, 0; 0, 0, -1)$ . We see that,  $\mathcal{C} = \{c_1, c_2, c_3\}$  is a set of relaxed curves and hence a family of opposite curves. We shall apply Algorithm 5.1 to check whether or not  $c_1, c_2, c_3$  give a complete partition for  $\mathcal{C}$  and hence generate a free group of rank 3 or a free product of Abelian groups.

- Step 1 We take  $c_1 \in \mathcal{C}$  and construct that  $P_1 = \{c_1, c_3\}$  since  $\iota(c_1, c_3) = 0$  and  $(c_1, c_2) \neq 0$ . Now we construct  $P_2$  for  $c \in \mathcal{C} \setminus P_1$ . Since  $c = c_2$ ,  $\iota(c_2, c_3) \neq 0$  and  $\iota(c_2, c_1) \neq 0$  we get  $P_2 = \{c_2\}$ . Since  $P_1 \cup P_2 = \mathcal{C}$  we input  $P_1, P_2$  to Step 2.
- Step 2 Since  $|P_1| + |P_2| = 3$ , we conclude that  $G \cong \mathbb{Z}^{|P_1|} * \mathbb{Z}^{|P_2|} = \mathbb{Z}^2 * \mathbb{Z}$ .
