Super-Hamiltonians for super-Macdonald polynomials

ABSTRACT

The Macdonald finite-difference Hamiltonian is lifted to a super-generalization. In addition to canonical bosonic time variables p_k new Grassmann time variables θ_k are introduced, and the Hamiltonian is represented as a differential operator acting on a space of functions of both types of variables p_k and θ_k . Eigenfunctions for this Hamiltonian are a suitable generalization of Macdonald polynomials to super-Macdonald polynomials discussed earlier in the literature. Peculiarities of the construction in comparison to the canonical bosonic case are discussed.

1 Introduction

The extension of Macdonald polynomials $[1]$ $[1]$ to the super-case $[2,3]$ $[2,3]$ $[2,3]$ $[2,3]$ and $[4,5]$ $[4,5]$ $[4,5]$ $[4,5]$ appears to be applicable to studies of super-Yangians like $Y({{\frak g} {\frak l}}_{1,1})$ [[6](#page-15-3)–[8\]](#page-15-4) and their super-DIM generalizations [[5](#page-15-2),[9](#page-15-5)[,10\]](#page-15-6). Surely, a modification (introduction of Grassmann variables) of the original Macdonald construction sheds some light on peculiarities of the original construction itself: we might try to question whether an appearance of algebraic and combinatorial structures accompanying Macdonald polynomials is accidental and may be naturally extended to other similar constructions.

In approaches used in $[2, 4, 5]$ $[2, 4, 5]$ $[2, 4, 5]$ $[2, 4, 5]$ $[2, 4, 5]$ $[2, 4, 5]$ the super-generalization was based on a variety of intuitive arguments. among which the major role was played by a generalization of Cauchy formulas and triangularity property. This is the old idea behind the definition of the far more general Kerov functions [\[11](#page-15-7) [–14\]](#page-15-8), where Macdonalds are distinguished by the independence of the ordering of Young diagrams – which makes triangularity a well-defined notion.

However, the most conventional approach defines Macdonald polynomials as eigenfunctions of Ruijsenaars Hamiltonians [\[15](#page-15-9)[–17\]](#page-15-10). In this paper we also exploit this idea and construct a set of commuting super-Hamiltonians whose eigenfunctions turn out to coincide with canonically defined

super-Macdonald polynomials. We discuss special properties of these Hamiltonians that are relevant for the representation theories of infinite dimensional algebras – such as Yangians [\[18–](#page-15-11)[22\]](#page-16-0) and DIM [\[23–](#page-16-1)[28\]](#page-16-2) algebras where these operators play a role of Cartan generators. Super-Hamiltonian approach to super-Macdonald polynomials was also considered in [\[3,](#page-15-0) [29\]](#page-16-3). Another approach to Macdonald polynomials recently discussed in [\[30\]](#page-16-4).

The paper consists of three parts.

Section [2](#page-1-0) is a brief reminder of the well-known Hamiltonians for Schur polynomials and a discussion of the "sum over boxes" property for eigenvalues and its connection to Pierri rules. In Sections [3](#page-5-0) and [4](#page-9-0) we provide basic facts about super-Schur and Macdonald cases. Section [5](#page-11-0) is devoted to super-generalizations of Macdonald Hamiltonians – the main part of this paper. Section [6](#page-13-0) contains a short conclusion and discussion of the future problems.

2 Hamiltonians for Schur polynomials

2.1 The simplest Hamiltonians

The grading (dilatation) operator is the simplest Hamiltonian for Schur polynomials:

\hat{\mathbf{G}}_{\mathbf{D}} = \sum_{k=1}^{\infty} k \, p_k \frac{\partial}{\partial p_k} \tag{1}

Its eigenvalues count the number of boxes in the Young diagram:

\hat{G}_{\Box} S_{\lambda} = \left(\sum_{\Box \in \lambda} 1\right) \cdot S_{\lambda} = |\lambda| \cdot S_{\lambda}
$$

there is a whole tower of W -operators starting with the cut-and-join operator $[31, 32]$ $[31, 32]$:

\hat{W} = \frac{1}{2} \sum_{a,b=1}^{\infty} \left(ab \cdot p_{a+b} \frac{\partial^2}{\partial p_a \partial p_b} + (a+b) \cdot p_a p_b \frac{\partial}{\partial p_{a+b}} \right)

with the eigenvalues κ_{λ} :

\hat{W} S_{\lambda} = \kappa_{\lambda} \cdot S_{\lambda} \qquad \qquad \boxed{\kappa_{\lambda} = \sum_{\Box \in \lambda} (j_{\Box} - i_{\Box})}

Note that the eigenvalues are given by the *sum over boxes* in the Young diagram. We denote by i_{\Box} and j_{\Box} the vertical and horizontal coordinates respectively of a box \square in the Young diagram. Grading operators are represented as sums of units over the boxes, and higher Hamiltonians are sums of coordinate dependent functions like ω_{D} . "Sum over boxes" property of Hamiltonians will be important in construction of higher Hamiltonians.

Another relevant for us property of Schur polynomials is the Pierri rules:

p_1 \cdot S_{\lambda} = \sum_{\mathbf{\Omega} \in \text{Add}(\lambda)} S_{\lambda + \mathbf{\Omega}} \tag{5}

Figure 1: Sets $Add(\star)$ and $Rem(\star)$.

We denote by $Add(\lambda)$ a subset of border places in diagram λ such that one can add a box to that place and the resulting diagram remains a Young diagram. Rem(λ) is the set of boxes in diagram λ that one can remove and the resulting diagram remains a Young diagram. An explanatory picture is presented on Fig[.1.](#page-2-0)

2.2 Higher Hamiltonians

By combining two properties – the sum over boxes in eigenvalues [\(4\)](#page-1-1) and Pierri rules [\(5\)](#page-1-2), (6) – we could construct a set of nontrivial commuting operators - Hamiltonians for Schur polynomials. At the first step we define the following operators, that generalize the Pierri rule:

\hat{E}_1 := \left[\hat{W}, \hat{E}_0 \right] = \sum_{a=1}^{\infty} a p_{a+1} \frac{\partial}{\partial p_a} \tag{8}

\hat{E}_k := \left[\hat{W}, \hat{E}_{k-1} \right] \tag{10}
$$

All these operators add one box to the Young diagram yet with different coefficients:

$$
\hat{E}_k S_\lambda = \sum_{\mathbf{D} \in \text{Add}(\lambda)} (\omega_{\mathbf{D}})^k \cdot S_{\lambda + \mathbf{D}}
$$
\n(11)

where we simplify the notation by introducing $\omega_{\Box} := j_{\Box} - i_{\Box}$. The above formula could be derived easily step by step in k . We demonstrate explicitly only the first step:

\hat{E}_1 S_{\lambda} = \left[\hat{W}, \hat{E}_0 \right] S_{\lambda} = \hat{W} \left(\sum_{\mathbf{D} \in \text{Add}(\lambda)} S_{\lambda + \mathbf{D}} \right) - \hat{E}_0 \left(\kappa_{\lambda} \cdot S_{\lambda} \right) =

= \sum_{\mathbf{D} \in \text{Add}(\lambda)} \kappa_{\lambda + \mathbf{D}} \cdot S_{\lambda + \mathbf{D}} - \kappa_{\lambda} \cdot \sum_{\mathbf{D} \in \text{Add}(\lambda)} S_{\lambda + \mathbf{D}} = \sum_{\mathbf{D} \in \text{Add}(\lambda)} (\kappa_{\lambda + \mathbf{D}} - \kappa_{\lambda}) \cdot S_{\lambda + \mathbf{D}} = \sum_{\mathbf{D} \in \text{Add}(\lambda)} \omega_{\mathbf{D}} \cdot S_{\lambda + \mathbf{D}} \tag{12}
$$

In the same way we define box-removing operators:

$$
\hat{F}_0 := \frac{\partial}{\partial p_1} \tag{13}
$$

$$
\hat{F}_1 := -\left[\hat{W}, \hat{F}_0\right] = \sum_{a=1}^{\infty} (a+1) \, p_a \frac{\partial}{\partial p_{a+1}} \tag{14}
$$

$$
\cdots \hspace{1.5cm} (15)
$$

$$
\hat{F}_k := -\left[\hat{W}, \hat{F}_{k-1}\right] \tag{16}
$$

Operators F_k generalize the second Pierri rule (6) :

$$
\hat{F}_k S_\lambda = \sum_{\mathbf{\Omega} \in \text{Rem}(\lambda)} (\omega_{\mathbf{\Omega}})^k \cdot S_{\lambda - \mathbf{\Omega}}
$$
\n(17)

On the second step we commute operators E_k and F_k in order to obtain Hamiltonians:

$$
\hat{H}_{a+b} := \left[\hat{E}_a, \hat{F}_b\right] \tag{18}
$$

There are two nontrivial consequences:

- operators $\left[\hat{E}_a, \hat{F}_b\right]$ depend only on the sum $a + b$
- operators \hat{H}_k commute

$$
\left[\hat{H}_k, \hat{H}_l\right] = 0\tag{19}
$$

The above properties follow directly from relations [\(11\)](#page-2-1) and [\(17\)](#page-3-0). One could easily prove both properties by showing that Schur polynomials are eigenfunctions of $\left[\hat{E}_a, \hat{F}_b\right]$.

\left[\hat{E}_a, \hat{F}_b\right] S_{\lambda} = \left(\sum_{\substack{\Box \in \text{Rem}(\lambda) \\ \Box \in \text{Mem}(\lambda)}} (\omega_{\Box})^{a+b} - \sum_{\substack{\Box \in \text{Add}(\lambda) \\ \Box \in \text{Add}(\lambda)}} (\omega_{\Box})^{a+b}\right) \cdot S_{\lambda} + \sum_{\substack{\Box \in \text{Add}(\lambda) \\ \Box \in \text{Add}(\lambda)}} \left((\omega_{\Box})^a (\omega_{\Box})^b S_{\lambda - \Box + \Box} - (\omega_{\Box})^b (\omega_{\Box})^a S_{\lambda + \Box - \Box}\right)
$$
\n(20)

For demonstrative purposes we colored the pieces into blue and red colors, if they correspond to contributions of \hat{E}_a and \hat{F}_a respectively.

The first part of the above relation represents the case when F_b removes box \Box from λ , and then E_a adds the same (already removed) box \Box to its place thus the resulting diagram remains λ as it was in the beginning. The second part is the same as the first part with the difference that E_a add a box to the λ and F_b removes it. Therefore, the first and the second parts contribute to the diagonal part of the operator $\left[\hat{E}_a, \hat{F}_b\right]$.

In contrast, the third and the fourth parts contribute to the off-diagonal part of the operator. In these cases a box is added to the diagram λ and the *other* box is removed from the other place of the diagram. In the formula we emphasized $\Box \in \text{Rem}(\lambda)$ and $\Box \in \text{Add}(\lambda)$ meaning $\Box \neq \Box$. In particular, adding and removing different boxes is a commutative operation, therefore:

\lambda - \Box + \Box = \lambda + \Box - \Box, \quad \forall \lambda \neq \varnothing, \Box \tag{21}
$$

In general situation cancellation of off-diagonal terms provided by the following condition:

$$
\left[\hat{E}_0, \hat{F}_0\right] = \text{ diagonal operator} \tag{22}
$$

In this particular case $\left[p_1, \frac{\partial}{\partial p_1} \right]$ ∂p_1 $\vert = 1$. On the other hand we have unit coefficients in Pierri rules [\(5\)](#page-1-2) and [\(6\)](#page-1-3), this fact directly explains absence of off-diagonal terms.

The above relation explains mutual cancellation of the third and fourth part of [\(20\)](#page-3-1). Finally, there is the only diagonal part that depends solely on the sum of indices $a+b$, thus Schur polynomials are the common eigenfunctions, and H_k all commute.

The subalgebra of Hamiltonians closes due to the following relations:

$$
\hat{H}_3 = -6 \cdot \hat{W} \tag{23}
$$

$$
\hat{H}_2 = -2 \cdot \hat{G}_{\mathsf{D}} \tag{24}
$$

that is provided by the peculiar properties of eigenvalues and Young diagrams:

$$
\sum_{\mathbf{D}\in\text{Rem}(\lambda)} (\omega_{\mathbf{D}})^3 - \sum_{\mathbf{D}\in\text{Add}(\lambda)} (\omega_{\mathbf{D}})^3 = -6 \cdot \sum_{\mathbf{D}\in\lambda} \omega_{\mathbf{D}}
$$
(25)

$$
\sum_{\Box \in \text{Rem}(\lambda)} (\omega_{\Box})^2 - \sum_{\Box \in \text{Add}(\lambda)} (\omega_{\Box})^2 = -2 \cdot \sum_{\Box \in \lambda} 1 \tag{26}
$$

that are valid for any Young diagram λ .

One of the main observations in this paper: the above construction of a commuting system of Hamiltonians can be applied to another family of polynomials that is enumerated by other diagrams. The minimum piece of data that we need:

- an operator that adds boxes to the diagrams (analog of (5));
- an operator that removes boxes from the diagrams (analog of (6));
- a Hamiltonian, whose eigenvalues are given by the sum over boxes (analog of [\(4\)](#page-1-1)).

2.3 Additional properties

At the end of this section we would like to mention two intriguing properties of Schur Hamiltonians:

1. Operators \hat{G}_{\Box} and \hat{W} can be considered as the first two non-trivial terms of the following expansion:

$$
\sum_{n=0}^{\infty} S_{[n]} \left\{ kp_k \right\} S_{[n]} \left\{ k^2 \frac{\partial}{\partial p_k} \right\} = 1 + \underbrace{\hat{G}_{\square}}_{\text{spin 2}} + \underbrace{\hat{W}}_{\text{spin 3}} + \dots
$$
 (27)

where the omitted terms with higher spin (in our notation spin is defined as a total degree in p_k and $\frac{\partial}{\partial p_k}$ in a normal ordered form), that are no longer made from the Hamiltonians (Schur polynomials are *not* their eigenfunctions). The powers of k in the arguments of symmetric Schur functions might seem unfamiliar, however they will become apparent after a consideration of the Macdonald deformation.

2. All the constructed Hamiltonians H_k can be expressed in terms of the Schur polynomials themselves and their conjugates:

\hat{H}_k = \sum_{|\lambda| = |\mu|} A_{\lambda,\mu} \cdot S_{\lambda} \hat{S}_{\mu}
$$
\n(28)

where we define:

$$
\hat{S}_{\mu} := S_{\mu} \left(p_k = k \frac{\partial}{\partial p_k} \right) \tag{29}
$$

There is an *intriguing* property of Hamiltonians H_k that their expansion in terms of the Schur functions include only a sector of single-hook Young diagrams [\[32\]](#page-16-6). For example, the forms of the grading operator and the cut-and-join operator read:

\hat{G}_{\Box} = \sum_{a=1}^{\infty} a p_a \frac{\partial}{\partial p_a} = \sum_{n=1}^{\infty} \sum_{i,j=0}^{n-1} (-)^{i+j} S_{[n-i,1^i]} \hat{S}_{[n-j,1^j]}
$$
(30)

$$
\hat{W} = -\frac{H_3}{6} = \frac{1}{2} \sum_{a,b=1}^{\infty} (a+b) \cdot p_a p_b \frac{\partial}{\partial p_{a+b}} + ab \cdot p_{a+b} \frac{\partial}{\partial p_a} \frac{\partial}{\partial p_b} =
$$
\n
$$
= \sum_{n=1}^{\infty} \sum_{i,j=0}^{n-1} (-)^{i+j} (n-1-i-j) S_{[n-i,1^i]} \hat{S}_{[n-j,1^j]}
$$
\n(31)

where we denoted a single hook diagram as $[n-i, 1^i]$, where i is the height of the first column and n is the total number of boxes. The higher W-operators could be obtained as proper combinations of H_k [\[32\]](#page-16-6).

3 Hamiltonians for super-Schur polynomials

Super-diagrams [\[2,](#page-14-1)[6,](#page-15-3)[9\]](#page-15-5) are half-integer partitions $\lambda = [\lambda_1, \lambda_2, \lambda_3, \ldots, \lambda_{l(\lambda)}], \lambda_k \in \mathbb{N}/2$ with decreasing rule $\lambda_1 \geq \lambda_2 \geq \lambda_3 \geq \ldots \geq \lambda_{l(\lambda)}$. If values λ_k and λ_{k+1} are both half-integer then inequality necessarily becomes strict $\lambda_k > \lambda_{k+1}$. Usual Young diagrams are the subset of super-Young diagrams. We depict super-partitions as the following diagrams:

The number of super-Young diagrams $p(n, m)$ with n full boxes and m half-boxes can be extracted from the following generating function:

\prod_{k=1} \frac{1+y x^{k-1}}{1-x^k} = \sum_{n,m=0} p(n,m) x^n y^m = 1 + y + x + 2xy + 2x^2 + xy^2 + 4x^2y + \dots
$$

If we set $y = 0$ the above generating function becomes generating function for number of usual Young diagrams $p(n)$:

$$
\prod_{k=1} \frac{1}{1-x^k} = \sum_{n=0} p(n) x^n = 1 + x + 2x^2 + 3x^3 + 5x^4 + \dots
$$

3.1 The simplest Hamiltonians

In the case of super-Schur polynomials ordinary time variables p_a are supplemented by Grassmann variables θ_a . Therefore the number of grading operators is increased. There is an operator that counts the number of fermions:

$$
\hat{\mathbf{G}}_{\boldsymbol{\mathcal{P}}-\boldsymbol{\mathcal{A}}} = \frac{1}{2} \sum_{k=1}^{\infty} \theta_k \frac{\partial}{\partial \theta_k} \tag{34}
$$

with eigenvalues that are given by the sum over half-boxes:

$$
\hat{G}_{\boldsymbol{\mathcal{P}}-\boldsymbol{\varDelta}}\mathcal{S}_{\lambda} = \left(\sum_{\boldsymbol{\mathcal{P}}\in\lambda} \frac{1}{2} - \sum_{\boldsymbol{\varDelta}\in\lambda} \frac{1}{2}\right) \cdot \mathcal{S}_{\lambda}
$$
\n(35)

Note that we treat the full box as a combination of two half-boxes:

$$
\Box = \Box = \nabla + \Delta \tag{36}
$$

Therefore the sum in (35) effectively runs over non-paired half-boxes \triangledown on the border of the diagram. Next grading operator counts half-boxes \mathbf{z} and \mathbf{z} on equal footing:

\hat{G}_{\mathbf{F}+\mathbf{A}} = \sum_{k=1}^{\infty} \left(k p_k \frac{\partial}{\partial p_k} + \left(k - \frac{1}{2} \right) \theta_k \frac{\partial}{\partial \theta_k} \right) \tag{37}

Eigenvalues of this operator have the following form:

\hat{G}_{\boldsymbol{\mathcal{P}}+\boldsymbol{\Delta}}\mathcal{S}_{\lambda} = \left(\sum_{\boldsymbol{\mathcal{P}}\in\lambda} \frac{1}{2} + \sum_{\boldsymbol{\Delta}\in\lambda} \frac{1}{2}\right) \cdot \mathcal{S}_{\lambda}
$$
\n(38)

From these operators we can construct grading operators that counts only half-boxes of particular kind:

\hat{G}_{\mathbf{F}} = \hat{G}_{\mathbf{F} + \mathbf{A}} + \hat{G}_{\mathbf{F} - \mathbf{A}} = \sum_{k=1}^{\infty} \left(k p_k \frac{\partial}{\partial p_k} + k \theta_k \frac{\partial}{\partial \theta_k} \right)
$$
(39)

$$
\hat{G}_{\mathbf{\Delta}} = \hat{G}_{\mathbf{\nabla} + \mathbf{\Delta}} - \hat{G}_{\mathbf{\nabla} - \mathbf{\Delta}} = \sum_{k=1}^{\infty} \left(k p_k \frac{\partial}{\partial p_k} + (k-1) \theta_k \frac{\partial}{\partial \theta_k} \right)
$$
(40)

where eigenvalues:

$$
\hat{\mathbf{G}}_{\boldsymbol{\varphi}} \mathcal{S}_{\lambda} = \left(\sum_{\boldsymbol{\varphi} \in \lambda} 1\right) \cdot \mathcal{S}_{\lambda} \tag{41}
$$

$$
\hat{\mathbf{G}}_{\mathbf{A}} \mathcal{S}_{\lambda} = \left(\sum_{\mathbf{A} \in \lambda} 1\right) \cdot \mathcal{S}_{\lambda} \tag{42}
$$

Next we provide an explicit form of the first few non-trivial Hamiltonians:

$$
\hat{\mathcal{W}}_{\mathbf{r}-\mathbf{a}} = \sum_{a,b=1}^{\infty} \left(a\theta_{a+b} \frac{\partial^2}{\partial p_a \partial \theta_b} + p_a \theta_b \frac{\partial}{\partial \theta_{a+b}} \right)
$$
(43)

$$
\hat{\mathcal{W}}_{\mathbf{r}} = \frac{1}{2} \sum_{a,b=1}^{\infty} \left(abp_{a+b} \frac{\partial^2}{\partial p_a \partial p_b} + (a+b)p_a p_b \frac{\partial}{\partial p_{a+b}} \right) + \sum_{a,b=1}^{\infty} b \left(a\theta_{a+b} \frac{\partial^2}{\partial p_a \partial \theta_b} + p_a \theta_b \frac{\partial}{\partial \theta_{a+b}} \right) \tag{44}
$$

with the eigenvalues

$$
\hat{\mathcal{W}}_{\boldsymbol{\nabla}-\boldsymbol{\Delta}}\mathcal{S}_{\lambda} = \left(\sum_{\boldsymbol{\nabla}\in\lambda} (j_{\boldsymbol{\nabla}} - i_{\boldsymbol{\nabla}}) - \sum_{\boldsymbol{\Delta}\in\lambda} (j_{\boldsymbol{\Delta}} - i_{\boldsymbol{\Delta}})\right) \cdot \mathcal{S}_{\lambda}
$$
\n(45)

$$
\hat{\mathcal{W}}_{\mathcal{P}} \mathcal{S}_{\lambda} = \left(\sum_{\mathcal{P} \in \lambda} (j_{\mathcal{P}} - i_{\mathcal{P}}) \right) \cdot \mathcal{S}_{\lambda} \tag{46}
$$

A construction of Hamiltonians for only lower-half-boxes is also apparent:

\hat{\mathcal{W}}_{\mathbf{a}} = \hat{\mathcal{W}}_{\mathbf{r}} - \hat{\mathcal{W}}_{\mathbf{r}-\mathbf{a}} \tag{47}
$$

\hat{\mathcal{W}}_{\mathbf{a}} \mathcal{S}_{\lambda} = \left(\sum_{\mathbf{a} \in \lambda} (j_{\mathbf{a}} - i_{\mathbf{a}}) \right) \cdot \mathcal{S}_{\lambda} \tag{48}
$$

There are similar Pierri rules for super-Schur polynomials. We define four operators

$$
\hat{E}_0^{\mathcal{P}} := \theta_1 \qquad \qquad \hat{E}_0^{\mathcal{A}} := \sum_{k=1}^{\infty} p_k \frac{\partial}{\partial \theta_k} \qquad (49)
$$

$$
\hat{F}_0^{\mathcal{P}} := \frac{\partial}{\partial \theta_1} \qquad \qquad \hat{F}_0^{\mathcal{A}} := \sum_{k=1}^{\infty} k \, \theta_k \frac{\partial}{\partial p_k} \qquad (50)
$$

that add/remove half-boxes to/from the super-diagrams:

$$
\hat{E}_0^{\nabla} S_{\lambda} = \sum_{\substack{\mathcal{V} \in \text{Add}(\lambda) \\ \mathcal{V} \in \text{Rem}(\lambda)}} C_{\lambda,\lambda+\mathcal{V}} S_{\lambda+\mathcal{V}} \qquad \hat{E}_0^{\Delta} S_{\lambda} = \sum_{\substack{\Delta \in \text{Add}(\lambda) \\ \mathcal{V} \in \text{Rem}(\lambda)}} C_{\lambda,\lambda+\Delta} S_{\lambda+\Delta} \qquad (51)
$$
\n
$$
\hat{F}_0^{\nabla} S_{\lambda} = \sum_{\substack{\mathcal{V} \in \text{Rem}(\lambda) \\ \Delta \in \text{Rem}(\lambda)}} C_{\lambda,\lambda-\mathcal{V}} S_{\lambda-\mathcal{V}} \qquad \hat{F}_0^{\Delta} S_{\lambda} = \sum_{\Delta \in \text{Rem}(\lambda)} C_{\lambda,\lambda-\Delta} S_{\lambda-\Delta} \qquad (52)
$$

Figure 2: Sets $Add(\star)$ and $Rem(\star)$.

where $C_{\lambda,\lambda,\pm}$ and $C_{\lambda,\lambda,\pm}$ are some constants. The definition of sets Add(λ) and Rem(λ) is clear from the Fig[.2.](#page-7-0)

3.2 Higher Hamiltonians

To construct higher Hamiltonians for the super-case we follow a procedure similar to the one presented in Sect[.2.](#page-1-0) At the first step we define higher operators recursively:

\hat{E}_{k}^{\mathbf{P}} := \left[\hat{\mathcal{W}}_{\mathbf{P}}, \hat{E}_{k-1}^{\mathbf{P}} \right] \qquad \hat{E}_{k}^{\mathbf{A}} := \left[\hat{\mathcal{W}}_{\mathbf{A}}, \hat{E}_{k-1}^{\mathbf{A}} \right] \qquad (53)
$$

$$
\hat{F}_{k}^{\mathcal{P}} := -\left[\hat{\mathcal{W}}_{\mathcal{P}}, \hat{F}_{k-1}^{\mathcal{P}}\right] \qquad \hat{F}_{k}^{\mathcal{A}} := -\left[\hat{\mathcal{W}}_{\mathcal{A}}, \hat{F}_{k-1}^{\mathcal{A}}\right] \qquad (54)
$$

At the second step the higher Hamiltonians are defined as follows:

$$
\hat{H}_{a+b}^{\mathbf{A}} := \left\{ \hat{E}_a^{\mathbf{F}}, \hat{F}_b^{\mathbf{F}} \right\} \qquad \hat{H}_{a+b}^{\mathbf{F}} := \left\{ \hat{E}_a^{\mathbf{A}}, \hat{F}_b^{\mathbf{A}} \right\} \tag{55}
$$

Off-diagonal terms are absent due to relations [\(22\)](#page-3-2):

$$
\left\{\hat{E}_0^{\mathbf{\mathcal{P}}}, \hat{F}_0^{\mathbf{\mathcal{P}}}\right\} = 1\tag{56}
$$

$$
\left\{\hat{E}_{0}^{\mathcal{A}},\hat{F}_{0}^{\mathcal{A}}\right\}=\sum_{k=1}^{\infty}\left(k\,p_{k}\frac{\partial}{\partial p_{k}}+k\,\theta_{k}\frac{\partial}{\partial\theta_{k}}\right)
$$
\n(57)

Here anti-commutators are implemented rather than the usual commutators due to Grassmann odd nature of $\hat{E}_k^{\pmb{V},\pmb{\Delta}}$ and $\hat{F}_k^{\pmb{V},\pmb{\Delta}}$ operators. Note that the labels of operators in the r.h.s. are different from the labels of Hamiltonians in the l.h.s. These Hamiltonians form a commuting set:

$$
\left[\hat{H}_k^{\mathbf{r}}, \hat{H}_l^{\mathbf{r}}\right] = 0\tag{58}
$$

$$
\left[\hat{H}_k^{\mathcal{A}}, \hat{H}_l^{\mathcal{A}}\right] = 0\tag{59}
$$

$$
\left[\hat{H}_k^{\mathbf{\mathcal{P}}}, \hat{H}_l^{\mathbf{\mathcal{A}}}\right] = 0\tag{60}
$$

This a bit awkwardly looking notation for Hamiltonians is determined by the following relations that make the subalgebra closed:

$$
\hat{H}_2^{\mathcal{A}} = \hat{G}_{\mathcal{A}} \qquad \qquad \hat{H}_3^{\mathcal{A}} = 2 \cdot \hat{\mathcal{W}}_{\mathcal{A}} \tag{61}
$$

$$
\hat{H}_0^{\mathcal{F}} = \hat{G}_{\mathcal{F}} \qquad \qquad \hat{H}_1^{\mathcal{F}} = 2 \cdot \hat{\mathcal{W}}_{\mathcal{F}} \tag{62}
$$

3.3 Additional properties

1. Since super-Schurs for integer diagrams (not containing unpaired upper-half-boxes) coincide with the ordinary Schurs (do not depend on θ_k) from the following combinations we obtain usual grading operator and cut-and-join operator:

$$
\sum_{n=0}^{\infty} \mathcal{S}_{[n]} \left\{ kp_k \right\} \mathcal{S}_{[n]} \left\{ k^2 \frac{\partial}{\partial p_k} \right\} = 1 + \hat{G}_{\mathbf{D}} + \hat{W} + \dots \tag{63}
$$

However, a similar combination for half-integer diagrams gives the following result:

$$
\sum_{n \text{ odd}} \mathcal{S}_{[n/2]} \left\{ kp_k, k\theta_k \right\} \mathcal{S}_{[n/2]} \left\{ k^2 \frac{\partial}{\partial p_k}, k \frac{\partial}{\partial \theta_k} \right\} = \sum_{k=1}^{\infty} k\theta_k \frac{\partial}{\partial \theta_k} + \sum_{a,b=1}^{\infty} b \left(a\theta_{a+b} \frac{\partial^2}{\partial p_a \partial \theta_b} + p_a \theta_b \frac{\partial}{\partial \theta_{a+b}} \right) + \dots \tag{64}
$$

(note that $\frac{\partial}{\partial \theta_k}$ in the argument is multiplied by k, not by k²). Operators as being split in brackets in the r.h.s. are not grading operators, and super-Schurs are not eigenfunctions of each of them separately. Yet the r.h.s. is a combination of the Hamiltonians:

$$
\sum_{n=0}^{\infty} \mathcal{S}_{[n/2]} \left\{ kp_k, k\theta_k \right\} \mathcal{S}_{[n/2]} \left\{ k^2 \frac{\partial}{\partial p_k}, k \frac{\partial}{\partial \theta_k} \right\} = 1 + \hat{G}_{\mathbf{F}} + \hat{\mathcal{W}}_{\mathbf{F}} + \dots \tag{65}
$$

Operators $\hat{G}_{\mathbf{\Delta}}$ and $\hat{W}_{\mathbf{\Delta}}$ in bilinear combination of super-Schurs remain to be found.

2. If we expand this operators in terms of super-Schur polynomials and their conjugates:

$$
\hat{\mathcal{S}}_{\lambda} := \mathcal{S}_{\lambda} \left(p_k = k \frac{\partial}{\partial p_k}, \theta_k = \frac{\partial}{\partial \theta_k} \right) \tag{66}
$$

we observe the same *miraculous* property as in (31) : only single-hook diagrams contribute.

However, in this case there are some peculiarities. We do not know yet any natural normalization conditions for the super-Schur polynomials. We choose the normalization with unit coefficients in front of monomials p_1^n and $p_1^n\theta_1$ respectively. Therefore, the orthogonality conditions have the following form:

$$
\hat{\mathcal{S}}_{\lambda} \mathcal{S}_{\mu} = \delta_{\lambda,\mu} \cdot ||\mathcal{S}_{\lambda}||^2 \tag{67}
$$

with some coefficients $||S_\lambda||^2$.

Moreover, in case of super-diagrams we have four types of single-hook diagrams. Two types on even levels $|\lambda| = 2m$ (B and F stand for boson and fermion respectively):

FF type:
$$
\left[\frac{k}{2}, 1^l, \frac{1}{2}\right]

 BB type: $[k, 1^l]$ (68)

For example, $|\lambda| = 5$:

And two types on odd levels $|\lambda| = 2m + 1$:

\text{FB type}: \left[\frac{k}{2}, 1^l\right] \qquad \qquad \text{BF type}: \left[k, 1^l, \frac{1}{2}\right] \tag{70}
$$

For example, $|\lambda| = \frac{9}{2}$ $\frac{9}{2}$:

\left[\frac{5}{2}, 1^2\right] = \boxed{\frac{1}{2}} \qquad \left[2, 1^2, \frac{1}{2}\right] = \boxed{\frac{1}{2}} \qquad (71)
$$

Finally, the following single-hook expansion holds for super-Schur Hamiltonians:

\hat{\mathcal{W}}_{\mathbf{r}} = \hat{\mathcal{W}}_{\mathbf{r}}^{(1)} + \hat{\mathcal{W}}_{\mathbf{r}}^{(2)} + \hat{\mathcal{W}}_{\mathbf{r}}^{(3)} + \hat{\mathcal{W}}_{\mathbf{r}}^{(4)} + \hat{\mathcal{W}}_{\mathbf{r}}^{(5)}
$$
(72)

 $BB \cdot \hat{BB}$:

$$
\hat{\mathcal{W}}_{\mathbf{p}}^{(1)} = \sum_{n \text{ even}} \sum_{i,j=0}^{\frac{n}{2}-1} (-)^{i+j} \left(\frac{n-2}{2} - i - j \right) \cdot \frac{C_{\frac{n-1}{2}}^j}{C_{\frac{n-1}{2}}^i} \cdot \frac{\mathcal{S}_{\left[\frac{n}{2}-i,1^i\right]} \hat{\mathcal{S}}_{\left[\frac{n}{2}-i,1^i\right]} }{\vert\vert \mathcal{S}_{\left[\frac{n}{2}-i,1^i\right]}\vert\vert^2}
$$

 $FB \cdot \hat{FB}$:

$$
\hat{\mathcal{W}}_{\mathbf{p}}^{(2)} = \sum_{n \text{ odd}} \sum_{i,j=0}^{\frac{n-3}{2}} (-i)^{i+j} \left(\frac{n-1}{2} - i - j \right) \cdot \frac{C_{\frac{n-3}{2}}^j}{C_{\frac{n-1}{2}}^i} \cdot \frac{\mathcal{S}_{\left[\frac{n}{2} - i, 1^i\right]} \hat{\mathcal{S}}_{\left[\frac{n}{2} - i, 1^i\right]} \hat{\mathcal{S}}_{\left[\frac{n}{2} - i, 1^i\right]}\nvert^{2}
$$

 $BF \cdot \hat{BF}$:

$$
\hat{\mathcal{W}}_{\mathbf{p}}^{(3)} = \sum_{n \text{ odd}} \sum_{i,j=0}^{\frac{n-3}{2}} (-i)^{i+j} \left(\frac{n-5}{2} - i - j \right) \cdot \frac{C_{\frac{n-3}{2}}^j}{C_{\frac{n-1}{2}}^{i+1}} \cdot \frac{\mathcal{S}_{\left[\frac{n-1}{2} - i, 1^i, \frac{1}{2}\right]} \hat{\mathcal{S}}_{\left[\frac{n-1}{2} - i, 1^i, \frac{1}{2}\right]} \left(73 \right)
$$

 $FB \cdot \hat{BF}$:

$$
\hat{\mathcal{W}}_{\mathbf{p}}^{(4)} = \sum_{n \text{ odd}} \sum_{i,j=0}^{\frac{n-3}{2}} (-)^{i+j+1} \left(\frac{n-3}{2} - i - j \right) \cdot \frac{C_{\frac{n-3}{2}}^j}{C_{\frac{n-1}{2}}^i} \cdot \frac{\mathcal{S}_{\left[\frac{n}{2} - i,1^i\right]} \hat{\mathcal{S}}_{\left[\frac{n-1}{2} - j,1^j\right]} }{||\mathcal{S}_{\left[\frac{n}{2} - i,1^i\right]}||^2}
$$

 $BF \cdot FB$:

$$
\hat{\mathcal{W}}^{(5)}_{\textbf{P}} = \sum_{n \text{ odd}} \sum_{i,j=0}^{\frac{n-3}{2}} (-)^{i+j+1} \left(\frac{n-3}{2}-i-j\right) \cdot \frac{C_{\frac{n-3}{2}}^j}{C_{\frac{n-1}{2}}^{i+1}} \cdot \frac{\mathcal{S}_{\left[\frac{n-1}{2}-i,1^i,\frac{1}{2}\right]} \hat{\mathcal{S}}_{\left[\frac{n}{2}-j,1^j\right]}}{||\mathcal{S}_{\left[\frac{n-1}{2}-i,1^i,\frac{1}{2}\right]}||^2}
$$

Note that for this Hamiltonian sector FF never enters. The other super-Hamiltonian $\hat{W}_{\mathbf{d}}$ for super-Schurs also have single-hook expansion, although we do not present it here. In general, higher super-Hamiltonians $\hat{H}_k^{\pmb{\nabla}, \pmb{\Delta}}$ do not have neither single-hook expansion nor "sum over boxes" property for eigenvalues. However, special combinations of $\hat{H}_k^{\nabla,\Delta}$ may have these properties, we postpone this question for future research.

4 Hamiltonians for Macdonald polynomials

4.1 Differential grading operator and finite-difference/shift cut-and-join

Now in addition to the grading operator appeared in the story of the Schur polynomials in Sec. [2,](#page-1-0) which remains a differential operator,

\hat{G}_{\mathbf{D}} = \sum_{k=1}^{\infty} k p_k \frac{\partial}{\partial p_k} \tag{74}
$$

$$
\hat{\mathbf{G}}_{\mathbf{D}} M_{\lambda}^{q,t} = \left(\sum_{\mathbf{D} \in \lambda} 1\right) \cdot M_{\lambda}^{q,t} \tag{75}
$$

we have non-local (shift) Hamiltonians [\[17\]](#page-15-10), the first and the simplest one has the following vertex operator form

$$
\hat{\mathcal{H}}_{\mathbf{G}}^{+} = \oint \frac{dz}{z} \exp\left(\sum_{k=1}^{\infty} \frac{(1 - t^{-2k})}{k} p_k z^k\right) \exp\left(\sum_{k=1}^{\infty} \frac{(q^{2k} - 1)}{z^k} \frac{\partial}{\partial p_k}\right)
$$
(76)

This single Hamiltonian turns out to be sufficient to determine all the Macdonald polynomials $M_{\lambda}^{q,t}$ as eigenfunctions with distinct eigenvalues:

$$
\hat{\mathcal{H}}_{\mathbf{\square}}^{+} M_{\lambda}^{q,t} = \mathcal{E}_{\lambda}^{q,t} M_{\lambda}^{q,t} \tag{77}
$$

An expression for eigenvalue $\mathcal{E}_{\lambda}^{q,t}$ $\lambda^{\mathcal{A},t}$ has a form of a sum over all boxes in the Young diagram:

$$
\mathcal{E}_{\lambda}^{q,t} = 1 + (q^2 - 1)(1 - t^{-2}) \cdot \sum_{\square \in \lambda} q^{2j_{\square}} t^{-2i_{\square}}
$$
\n(78)

where the coordinate of the initial box in the Young diagram reads $(i_{\Box}, j_{\Box}) = (0, 0)$ and i_{\Box}, j_{\Box} are vertical and horizontal coordinates correspondingly.

4.2 Single-hook Schur decomposition of Macdonald Hamiltonian

With the help of reduced Cauchy formula

$$
\sum_{n=0}^{\infty} S_{[n]} \{p\} \cdot z^n = \exp\left(\sum_k \frac{p_k z^k}{k}\right) \tag{79}
$$

this Hamiltonian can be rewritten as a much healthier analogue of [\(27\)](#page-4-0):

$$
\hat{\mathcal{H}}_{\mathbf{\square}}^{+} = \sum_{n=0}^{\infty} S_{[n]} \left\{ (1 - t^{-2k}) \cdot p_k \right\} \cdot S_{[n]} \left\{ k \cdot (q^{2k} - 1) \cdot \frac{\partial}{\partial p_k} \right\} \tag{80}
$$

where we can further substitute the single-hook expansion [?]

$$
S_{[n]}\left\{(1-t^{-2k})\cdot p_k\right\} = (1-t^{-2})\sum_{i=0}^{n-1}(-)^i\cdot t^{-2i}\cdot S_{[n-i,1^i]}\{p_k\} \tag{81}
$$

to arrive to the following expression:

$$
\hat{\mathcal{H}}_{\mathbf{G}}^{+} = 1 + (q^2 - 1)(1 - t^{-2}) \sum_{n=1}^{\infty} \sum_{i,j=0}^{n-1} (-)^{i+j} \cdot t^{-2i} q^{2(n-1-j)} \cdot S_{[n-i,1^i]} \cdot \hat{S}_{[n-j,1^j]} \tag{82}
$$

Note that symmetric and single-hook decompositions [\(80\)](#page-10-0) and [\(82\)](#page-10-1) are exact, all terms in the sums should be taken into account – not like it was in the case of (27) .

4.3 q, t -inversion symmetry

The Macdonald polynomials have symmetry with respect to an inversion of q and t parameters: $M_{\lambda}^{q,t} = M_{\lambda}^{q^{-1},t^{-1}}$ λ^q . Even more surprisingly, this property is not reflected by the Hamiltonian [\(76\)](#page-10-2), which implies there should be another Hamiltonian obtained by this transformation with the same eigenfunctions:

$$
\hat{\mathcal{H}}_{\mathbf{G}}^{-} = \oint \frac{dz}{z} \exp\left(\sum_{k=1} \frac{(1 - t^{2k})}{k} p_k z^k\right) \exp\left(\sum_{k=1} \frac{(q^{-2k} - 1)}{z^k} \frac{\partial}{\partial p_k}\right)
$$
(83)

$$
\hat{\mathcal{H}}_{\mathbf{Q}}^{-} M_{\lambda}^{q,t} = \tilde{\mathcal{E}}_{\lambda}^{q,t} M_{\lambda}^{q,t} \tag{84}
$$

$$
\tilde{\mathcal{E}}_{\lambda}^{q,t} = \mathcal{E}_{\lambda}^{q^{-1},t^{-1}} = 1 + (q^{-2} - 1)(1 - t^2) \cdot \sum_{\square \in \lambda} q^{-2j_{\square}} t^{2i_{\square}},\tag{85}
$$

4.4 Higher Hamiltonians

Operators p_1 and $\frac{\partial}{\partial p_1}$ add and remove boxes in Macdonald polynomials:

$$
p_1 \cdot M_{\lambda}^{q,t} = \sum_{\mathbf{D} \in \text{Add}(\lambda)} C_{\lambda,\lambda+\mathbf{D}}^{q,t} M_{\lambda+\mathbf{D}}^{q,t}
$$
(86)

$$
\frac{\partial}{\partial p_1} M_{\lambda}^{q,t} = \sum_{\mathbf{D} \in \text{Rem}(\lambda)} C_{\lambda,\lambda-\mathbf{D}}^{q,t} M_{\lambda-\mathbf{D}}^{q,t}
$$
(87)

With the help of these two Hamiltonians one can define operators \hat{E}_k , \hat{F}_k recursively for all integer values $k \in \mathbb{Z}$:

$$
\hat{E}_{k+1} := \left[\hat{\mathcal{H}}_{\mathsf{D}}^{+}, \hat{E}_{k} \right] \qquad \hat{F}_{k+1} := -\left[\hat{\mathcal{H}}_{\mathsf{D}}^{+}, \hat{F}_{k} \right] \tag{88}
$$

$$
\hat{E}_{k-1} := \left[\hat{\mathcal{H}}_{\mathbf{0}}^-, \hat{E}_k \right] \qquad \hat{F}_{k-1} := -\left[\hat{\mathcal{H}}_{\mathbf{0}}^-, \hat{F}_k \right] \tag{89}
$$

Initial conditions for these recursion $\hat{E}_0 = p_1$ and $\hat{F}_0 = \frac{\partial}{\partial p_1}$ $\frac{\partial}{\partial p_1}$. Action of these operators on Macdonald polynomials reads:

$$
\hat{E}_k \ M_\lambda^{q,t} = \sum_{\Box \in \text{Add}(\lambda)} \left(q^{2j} \Box t^{-2i} \Box \right)^k \ C_{\lambda,\lambda+ \Box}^{q,t} \ M_{\lambda+ \Box}^{q,t} \tag{90}
$$

$$
\hat{F}_k \ M_\lambda^{q,t} = \sum_{\Box \in \text{Rem}(\lambda)} \left(q^{2j} \Box t^{-2i} \Box \right)^k \ C_{\lambda,\lambda-\Box}^{q,t} \ M_{\lambda-\Box}^{q,t} \tag{91}
$$

Then Hamiltonians reads:

$$
\hat{\mathcal{H}}'_{a+b} := \left[\hat{E}_a, \hat{F}_b\right] \tag{92}
$$

that form commuting family:

$$
\left[\hat{\mathcal{H}}'_{a}, \hat{\mathcal{H}}'_{b}\right] = 0\tag{93}
$$

Higher Hamiltonians from [\[17\]](#page-15-10) should be expressed as proper combinations of our $\hat{\mathcal{H}}'_a$. We leave it question for future papers.

5 Hamiltonians for super-Macdonald polynomials

Super-Macdonald polynomials are q , t -deformations of super-Schur polynomials therefore the two grading operators are just the same:

$$
\hat{\mathbf{G}}_{\mathbf{F}} \mathcal{M}_{\lambda}^{q,t} = \left(\sum_{\mathbf{F} \in \lambda} 1\right) \cdot \mathcal{M}_{\lambda}^{q,t} \tag{94}
$$

$$
\hat{\mathbf{G}}_{\mathbf{A}}\mathcal{M}_{\lambda}^{q,t} = \left(\sum_{\mathbf{A}\in\lambda}1\right)\cdot\mathcal{M}_{\lambda}^{q,t}
$$
\n(95)

In complete analogy with the case of canonical Macdonald polynomials where the Hamiltonian [\(76\)](#page-10-2) have eigenvalues:

$$
\mathcal{E}_{\lambda}^{q,t} = 1 + (q^2 - 1)(1 - t^{-2}) \cdot \sum_{\square \in \lambda} q^{2j_{\square}} t^{-2i_{\square}}
$$
\n(96)

we define new super-Hamiltonians for super-Macdonald polynomials:

$$
\hat{\mathcal{H}}^{\mathcal{F},+}\mathcal{M}_{\lambda}^{q,t} = \left[1 + (q^2 - 1)(1 - t^{-2}) \left(\sum_{\mathcal{F} \in \lambda} q^{2j\mathcal{F}} t^{-2i\mathcal{F}}\right)\right] \mathcal{M}_{\lambda}^{q,t}
$$
\n
$$
\hat{\mathcal{H}}^{\mathcal{A},+}\mathcal{M}_{\lambda}^{q,t} = \left[1 + (q^2 - 1)(1 - t^{-2}) \left(\sum_{\mathcal{A} \in \lambda} q^{2j\mathcal{A}} t^{-2i\mathcal{A}}\right)\right] \mathcal{M}_{\lambda}^{q,t}
$$
\n
$$
\hat{\mathcal{H}}^{\mathcal{F},-}\mathcal{M}_{\lambda}^{q,t} = \left[1 + (q^{-2} - 1)(1 - t^{2}) \left(\sum_{\mathcal{F} \in \lambda} q^{-2j\mathcal{F}} t^{2i\mathcal{F}}\right)\right] \mathcal{M}_{\lambda}^{q,t}
$$
\n
$$
\hat{\mathcal{H}}^{\mathcal{A},-}\mathcal{M}_{\lambda}^{q,t} = \left[1 + (q^{-2} - 1)(1 - t^{2}) \left(\sum_{\mathcal{A} \in \lambda} t^{2x\mathcal{A}} q^{-2y\mathcal{A}}\right)\right] \mathcal{M}_{\lambda}^{q,t}
$$
\n(97)

For even (ordinary) diagrams the eigenvalues of the first two Hamiltonians coincide, whereas those of the last two are obtained by a switch $q = q^{-1}, t = t^{-1}$. However, for a generic odd diagram all the four eigenvalues are different and independent.

For the first pair of Hamiltonians we present the following closed expression:

$$
\hat{\mathcal{H}}^{\gamma,+} = \oint \frac{dw}{w} \langle \varnothing | \left[\exp \left\{ \sum_{k=1}^{\infty} \left(\frac{1-t^{-2k}}{k} p_k w^{2k} + (1-t^{-2}) t^{-2(k-1)} w^{2k-1} \theta_k \sum_{m=0}^{k-1} t^{2m} \psi_m \right) \right\} \times \exp \left\{ \sum_{k=1}^{\infty} \left((q^{2k} - 1) \frac{\partial}{\partial p_k} w^{-2k} + (q^2 - 1) q^{2(k-1)} w^{-2k+1} \frac{\partial}{\partial \theta_k} \sum_{m=0}^{k-1} q^{-2m} \psi_m^{\dagger} \right) \right\} \right] |\varnothing \rangle_F ,

\hat{\mathcal{H}}^{4,+} = \oint \frac{dw}{w} \langle \varnothing | \left[\exp \left\{ \sum_{k=1}^{\infty} \frac{1-t^{-2k}}{k} p_k w^{2k} + \sum_{k=2}^{\infty} \left((1-t^{-2}) t^{-2(k-1)} w^{2k-1} \theta_k \sum_{m=0}^{k-2} t^{2m} \psi_m \right) \right\} \times \exp \left\{ \sum_{k=1}^{\infty} (q^{2k} - 1) \frac{\partial}{\partial p_k} w^{-2k} + \sum_{k=2}^{\infty} \left((q^2 - 1) q^{2(k-2)} w^{-2k+1} \frac{\partial}{\partial \theta_k} \sum_{m=0}^{k-2} q^{-2m} \psi_m^{\dagger} \right) \right\} |\varnothing \rangle_F ,

where fermionic correlator are defined by:

\left\{\psi_i, \psi_j^{\dagger}\right\} = \delta_{ij}, \quad \psi_i \left| \emptyset \right\rangle_F = 0, \quad \langle \emptyset \left| \emptyset \right\rangle_F = 1 \tag{99}

For the second pair of Hamiltonians we propose the following expressions:

\hat{\mathcal{H}}^{\nu,-} = \oint \frac{dw}{w} \langle \varnothing | \left[\exp \left\{ \sum_{k=1}^{\infty} \left(\frac{1 - t^{2k}}{k} p_k w^{2k} s^{-k} + (1 - t^2) w^{2k-1} \theta_k \nu \right) \right\} \times \right. \times \exp \left\{ \sum_{k=1}^{\infty} \left(\frac{q^{-2k} - 1}{1} \frac{\partial}{\partial p_k} w^{-2k} + (q^{-2} - 1) w^{-2k+1} \frac{\partial}{\partial \theta_k} \nu^{\dagger} s^{k-1} \right) \right\} \right] |\varnothing\rangle_B ,
$$
\n
$$
\hat{\mathcal{H}}^{\mathcal{A},-} = \oint \frac{dw}{w} \langle \varnothing | \left[\exp \left\{ \sum_{k=1}^{\infty} \left(\frac{1 - t^{2k}}{k} p_k w^{2k} s^{-k} + (1 - t^2) w^{2k-1} \theta_k \nu \right) \right\} \times \right. \times \exp \left\{ \sum_{k=1}^{\infty} \left(\frac{q^{-2k} - 1}{1} \frac{\partial}{\partial p_k} w^{-2k} + (q^{-2} - 1) w^{-2k+1} \frac{\partial}{\partial \theta_k} \nu^{\dagger} s^{k-2} \right) \right\} \right] | |\varnothing\rangle_B
$$

where s is an ordinary number, whereas ν, ν^{\dagger} anti-commutative. For their correlators we define:

$$
\langle \varnothing | s^a | \varnothing \rangle_B = 1, \quad \langle \varnothing | \nu \nu^\dagger s^b | \varnothing \rangle_B = \begin{cases} \frac{1 - (qt)^{2b+2}}{q^{2b}(1 - (qt)^2)}, & \text{if } b \ge 0; \\ 0, & \text{otherwise} \end{cases}
$$

Note that there is a single fermionic pair ν, ν^{\dagger} , therefore these two Hamiltonians contain only terms with at most the first power of θ and θ -derivative. The primary role of s is to exclude terms like $p_{k_1}\dots p_{k_n}\frac{\partial}{\partial\theta}$ $\frac{\partial}{\partial \theta_{m-\frac{1}{2}}}$ with $\sum k_a > m-1$ from $\hat{\mathcal{H}}^{\mathcal{V},-}$ or $\sum k_a > m-2$ from $\hat{\mathcal{H}}^{\mathcal{A},-}$.

The above four Hamiltonians by the definition have "sum over boxes" property, however we observe that in the expansion in terms of super-Schurs \mathcal{S}_{λ} and conjugates $\hat{\mathcal{S}}_{\mu}$ in the spirit of [\(73\)](#page-9-1) enters diagrams with two and more hooks. We leave this intriguing observation for further investigation elsewhere.

According to the general reasoning from Section [2](#page-1-0) we can construct a set of commuting Hamiltonians. We provide the following example, that is based on the Pierri rules for super-Macdonald polynomials:

Then we define the following auxiliary operators:

$$
\hat{E}_{k\pm 1}^{\nabla} = \left[\hat{\mathcal{H}}^{\nabla,\pm}, \hat{E}_k^{\nabla} \right] \tag{104}
$$

\hat{F}_{k\pm 1}^{\nabla} = -\left[\hat{\mathcal{H}}^{\nabla,\pm}, \hat{F}_k^{\nabla}\right]

These two relations allow increase and decrease index k to define operators for any intger values of k using $\hat{E}_0^{\nabla} = \theta_1$ and $\hat{F}_0^{\nabla} = \frac{\partial}{\partial \theta}$ $\frac{\partial}{\partial \theta_1}$ as the initial conditions of this recursive procedure. Then the commuting set of Hamiltonians read:

$$
\hat{\mathcal{H}}'_{a+b} := \left\{ \hat{E}_a^{\nabla}, \hat{F}_b^{\nabla} \right\} \tag{106}
$$

\left[\hat{\mathcal{H}}'_{a}, \hat{\mathcal{H}}'_{b}\right] = 0\tag{107}
$$

We consider here only one possible commuting family of super-Hamiltonians that is related to $\hat{\mathcal{H}}^{\varphi,+}$ and $\hat{\mathcal{H}}^{\varphi,-}$. However, we need to construct a pair of operators that add and remove semi-boxes Δ for constructing the remaining commuting family, related to $\hat{\mathcal{H}}^{\Delta,+}$ and $\hat{\mathcal{H}}^{\Delta,-}$. We leave it for future research. Of course, these two commuting families commute with each other.

6 Conclusion

This paper is devoted to the analysis of Hamiltonians for polynomials of the Schur-Macdonald family and their supersymmetric extensions. These polynomials are naturally enumerated by Young-like diagrams. We argue that the "sum over boxes" property of eigenvalues equipped with the Pierri rule for adding/removing boxes provides integrability – commutativity of an infinite set of Hamiltonians.

In the case of Schur and super-Schur polynomials each box is weighted with content $\omega = j - i$ that is given by a difference of horizontal and vertical coordinates of the box. Furthermore for the Macdonald case each box is weighted with exponentiated weights $\omega^{q,t} = q^{2j}t^{-2i}$ where q, t are free parameters. Therefore our main idea in constructing super-Hamiltonians is to enforce the special form of eigenvalues: for an eigen function (i.e. a super-Macdonald polynomial) that is labeled by the super-Young diagram the corresponding eigenvalue is given by a sum over all semi-boxes of these diagram with respective exponent weights [\(97\)](#page-12-0).

Super-Hamiltonians are labeled by two indices. The first index labels two different types of semi-boxes \triangledown and \triangle according to the "sum over boxes" property of corresponding eigenvalues. The second index encodes positive or negative powers of free parameters q, t in eigenvalues. Therefore the total number of independent super-Hamiltonians is equal to four. However, only two (e.g. two positive) super-Hamiltonians are sufficient to compute all the super-Macdonald polynomials as eigen functions with distinct eigen values.

There are plenty of details to comment on in this approach – and each one raises an intriguing question:

- 1. There is spontaneous breaking of symmetry $q \rightarrow 1/q$, $t \rightarrow 1/t$. Macdonald polynomials are invariant with respect to this transformation, whereas Ruijsenaars Hamiltonians are not (this is true about the basic ones and continues to hold for the higher Hamiltonians, see [\[17\]](#page-15-10)). Surprisingly, this property disappears after super-generalization – super-Macdonalds are no longer invariant.
- 2. This symmetry violation leads to an occurrence of extra Hamiltonians what could be partly related to the apparent difference between Yangians and DIM: there are commuting rays in the former case. These rays are promoted to entire Heisenberg lines in the latter [\[33\]](#page-16-7).
- 3. As it was observed in a variety of examples the "sum over boxes" property of eigenvalues is somehow related to a single-hook expansion of the Hamiltonian in terms of eigen functions and their conjugates [\[32\]](#page-16-6). However, this connection is lost in case of the Macdonald super-Hamiltonians, since they do not have a naive single-hook expansion in terms of super-Schur polynomials.
- 4. The projections can be implemented in super-Hamiltonians with the help of additional Grassmannian variables – with their help the formulas acquire almost the same form as the Ruijsenaars finite-difference operators (vertex-form operators).
