# Solving the weighted-sum achievable rate maximization problem

*Proposition 1:* Scaling  $\mathbf{w}_{r,k_{\mathrm{U}}}$  holds the optimality of (P1).

*Proof:* It is noticed that only  $R_{U,k_U}$  term in objective function involves  $\mathbf{w}_{r,k_U}$ . Consequently, we focus on  $R_U$  and assume that the optimal solution for (P1) without (1e) is  $\tilde{\mathbf{t}}^*$ ,  $\tilde{\mathbf{r}}^*$ ,  $\mathbf{W}_t^*$ , and

 $\mathbf{W}_{r}^{\star}$  (not necessarily on the unit manifold now) and the optimal value for UL part is  $R_{\mathrm{U}}^{\star}$ ,  $R_{\mathrm{U},k_{\mathrm{U}}}^{\star}$  for every UL user respectively. For any  $t \in \mathbb{R}$ , plugging  $t\mathbf{w}_{r,k_{\mathrm{U}}}^{\star}$  into the expression of  $R_{\mathrm{U},k_{\mathrm{U}}}$ , it is easily obtained that  $R_{\mathrm{U},k_{\mathrm{U}}}\left(t\mathbf{w}_{r,k_{\mathrm{U}}}^{\star}\right) = R_{\mathrm{U},k_{\mathrm{U}}}^{\star}$ , i.e.  $R_{\mathrm{U},k_{\mathrm{U}}}$  remained its value with scaled  $\mathbf{w}_{r,k_{\mathrm{U}}}$ . Each UL user's achievable rate is invariant with respect to (w.r.t.) the scaling of beamformer and thus, the weighted-sum rate also keeps its value. In other words, scaling  $\mathbf{w}_{r,k_{\mathrm{U}}}$  holds the optimality.

Consequently, (1e) can be removed when solving (P1) and the optimal  $\mathbf{w}_{r,k_{\text{U}}}$  can be acquired by a column-wise normalization on  $\mathbf{W}_r$ .

 $\gamma$  is the introduced non-negative auxiliary variable. (P2) is convex over  $\gamma$ , thus, it is easy to show that for fixed  $\tilde{\mathbf{t}}$ ,  $\tilde{\mathbf{r}}$ ,  $\mathbf{W}_t$ ,  $\mathbf{W}_r$ , and  $\mathbf{P}_U$ ,  $\gamma$  is optimally determined as

# III. SUB-PROBLEM 1: OPTIMIZING $\mathbf{W}_t$

Given  $\mathbf{W}_r$ ,  $\mathbf{P}_U$ ,  $\tilde{\mathbf{t}}$ ,  $\tilde{\mathbf{r}}$ ,  $\mathbf{y}$ , and  $\boldsymbol{\gamma}$ , (P3) degrades to

where  $\bar{\mathbf{H}}_{\mathrm{D}} = \mathbf{H}_{\mathrm{D}}\mathbf{Y}_{\mathrm{D}}\mathbf{A}_{\mathrm{D}}$ ,  $\mathbf{Y}_{\mathrm{D}} = \mathrm{diag}\left(\{y_{i}\}_{i=1}^{K_{\mathrm{D}}}\right)$ ,  $\mathbf{A}_{\mathrm{D}} = \mathrm{diag}\left(\{\sqrt{a_{i}\left(1+\gamma_{i}\right)}\right\}_{i=1}^{K_{\mathrm{D}}}\right)$ ,  $\mathbf{H}_{t} = \mathbf{H}_{\mathrm{D}}\mathbf{Y}_{\mathrm{D}}\mathbf{Y}_{\mathrm{D}}^{H}\mathbf{H}_{\mathrm{D}}^{H} + \mathbf{H}_{\mathrm{SI}}^{H}\mathbf{W}_{r}\mathbf{Y}_{\mathrm{U}}^{H}\mathbf{Y}_{\mathrm{U}}\mathbf{W}_{r}^{H}\mathbf{H}_{\mathrm{SI}}$ , and  $\mathbf{Y}_{\mathrm{U}} = \mathrm{diag}\left(\{y_{i}\}_{i=K_{\mathrm{D}}+1}^{K_{\mathrm{D}}}\right)$ . The DL beamformers here  $(\mathbf{W}_{t})$  are not confined to be unit-power and the constraint (1d) restrict their sum-power. Consequently, (P4) is essentially a combination of beamforming and power allocation problem. From the point of view of optimization theory, (P4) is a quadratic constrained quadratic optimization (QCQP) problem with a semi-definite matrix  $\mathbf{H}_{t}$ . Consequently, (4) is convex and can be directly solve by various convenient tools, e.g. CVX toolbox in Matlab. However, for the

The Lagrangian function of (P4) is expressed as

which yields the Karush-Kuhn-Tucker (KKT) condition

where  $\mathbf{W}_{t}^{\star}$  and  $\mu^{\star}$  are the optimal solutions of (P4) and its dual problem, respectively, because of the convexity of (P4). If Tr  $(\bar{\mathbf{H}}_{\mathrm{D}}^{H}\mathbf{H}_{t}^{-2}\bar{\mathbf{H}}_{\mathrm{D}}) = p_{\mathrm{D,max}}$ , then  $\mu^{\star} = 0$  and  $\mathbf{W}_{t}^{\star} = \mathbf{H}_{t}^{-1}\bar{\mathbf{H}}_{\mathrm{D}}$ . Otherwise, using  $\mu^{\star}$  to express  $\mathbf{W}_{t}^{\star}$ , we have

$$\operatorname{Tr}\left(\left(\mathbf{W}_{t}^{\star}\left(\mu^{\star}\right)\right)^{H}\mathbf{W}_{t}^{\star}\left(\mu^{\star}\right)\right) = \operatorname{Tr}\left(\bar{\mathbf{H}}_{\mathrm{D}}^{H}(\mathbf{H}_{t}+\mu^{\star}\mathbf{I})^{-2}\bar{\mathbf{H}}_{\mathrm{D}}\right) = p_{\mathrm{D,max}}.$$

Suppose the eigenvalue decomposition of  $\mathbf{H}_t$  is  $\mathbf{H}_t = \mathbf{U}^H \Lambda \mathbf{U}$ , then

$$f(\mu^{\star}) = \operatorname{Tr}\left(\left(\mathbf{W}_{t}^{\star}(\mu^{\star})\right)^{H}\mathbf{W}_{t}^{\star}(\mu^{\star})\right) = \sum_{i=1}^{N_{t}} \frac{\left[\mathbf{U}\bar{\mathbf{H}}_{\mathrm{D}}\bar{\mathbf{H}}_{\mathrm{D}}^{H}\mathbf{U}^{H}\right]_{(i,i)}}{\left(\left[\Lambda\right]_{(i,i)} + \mu^{\star}\right)^{2}} = p_{\mathrm{D,max}},\tag{7}$$

which is a monotonically decreasing function. Since (P4) is a convex problem, it can directly be solved by off-the-shelf tools like the cvx toolbox in Matlab. Alternatively, an optimal  $\mu^*$  can also be found via a bisection method by solving  $f(\mu^*) = p_{D,max}$  and  $\mathbf{W}_t^*$  can also correspondingly obtained by (6).

#### IV. SUB-PROBLEM 2: OPTIMIZING $\mathbf{W}_r$

With fixed  $\mathbf{W}_t$ ,  $\mathbf{P}_U$ ,  $\tilde{\mathbf{t}}$ ,  $\tilde{\mathbf{r}}$ ,  $\mathbf{y}$ , and  $\boldsymbol{\gamma}$ , optimizing  $\mathbf{w}_r$  in (P3) is to operate

in which,  $\bar{\mathbf{H}}_{U} = \mathbf{H}_{U}\mathbf{A}_{U}\mathbf{P}_{U}^{1/2}$ ,  $\mathbf{A}_{U} = \operatorname{diag}\left(\left\{\sqrt{a_{i}\left(1+\gamma_{i}\right)}\right\}_{i=K_{D}+1}^{K_{D}+K_{U}}\right)$ , and  $\mathbf{H}_{r} = \mathbf{H}_{U}\mathbf{P}_{U}\mathbf{H}_{U}^{H} + \mathbf{H}_{SI}\mathbf{W}_{t}\mathbf{W}_{t}^{H}\mathbf{H}_{SI}^{H} + \sigma_{U}^{2}\mathbf{I}$ .  $\mathbf{M}^{1/2}$  here is an operation to calculate the element-wise square root of a matrix. Obviously,  $\mathbf{H}_{r}$  is a semi-definite matrix and thus, (P5) is convex on  $\mathbf{W}_{r}$ . Moreover,

there are no constraints on  $W_r$  here because (1e) has been eliminated temporarily based on the Proposition 1. By completing the square, (8) is reformulated as

$$\mathbf{W}_{r}^{\star} = \operatorname*{argmax}_{\mathbf{W}_{r}} \operatorname{Tr} \left( \bar{\mathbf{H}}_{\mathrm{U}}^{H} \mathbf{H}_{r}^{-1} \bar{\mathbf{H}}_{\mathrm{U}} \right) - \operatorname{Tr} \left[ \left( \mathbf{W}_{r} \mathbf{Y}_{\mathrm{U}}^{H} - \mathbf{H}_{r}^{-1} \bar{\mathbf{H}}_{\mathrm{U}} \right)^{H} \mathbf{H}_{r} \left( \mathbf{W}_{r} \mathbf{Y}_{\mathrm{U}}^{H} - \mathbf{H}_{r}^{-1} \bar{\mathbf{H}}_{\mathrm{U}} \right) \right].$$

We can directly obtain the closed-form optimal  $\mathbf{W}_r^{\star} = \mathbf{H}_r^{-1} \mathbf{\bar{H}}_U \mathbf{Y}_U^{-H}$  for (P5) with the optimal value Tr  $(\mathbf{\bar{H}}_U^H \mathbf{H}_r^{-1} \mathbf{\bar{H}}_U)$ .

# V. Sub-problem 3: Optimizing $\mathbf{P}_{\mathrm{U}}$

In the objective function and constraints of (P2), the expression of every UL user's transmit power is independent to each other. Consequently, the subproblem to optimize  $P_U$  can be solved individually w.r.t. every UL user. Calculating UL users' allocated power separately is natural because each device individually transmit its message and has its power constraint, i.e., from 0 to  $p_{U,max}$  (we assume each device has the same restriction here). Without loss of generality, we take the  $k_U$ th user for example

where

$$c_{1,k_{\mathrm{U}}} = 2\sqrt{a_{K_{\mathrm{D}}+k_{\mathrm{U}}}\left(1+\gamma_{K_{\mathrm{D}}+k_{\mathrm{U}}}\right)}\operatorname{Re}\left\{y_{K_{\mathrm{D}}+k_{\mathrm{U}}}^{*}\mathbf{h}_{\mathrm{U},k_{\mathrm{U}}}^{H}\left(\tilde{\mathbf{r}}\right)\mathbf{w}_{r,k_{\mathrm{U}}}\right\}$$
(11a)

$$c_{2,k_{\mathrm{U}}} = \mathbf{h}_{\mathrm{IUI},k_{\mathrm{U}}}^{H} \mathbf{Y}_{\mathrm{D}}^{H} \mathbf{Y}_{\mathrm{D}} \mathbf{h}_{\mathrm{IUI},k_{\mathrm{U}}} + \mathbf{h}_{\mathrm{U},k_{\mathrm{U}}}^{H} \mathbf{W}_{r} \mathbf{Y}_{\mathrm{U}}^{H} \mathbf{Y}_{\mathrm{U}} \mathbf{W}_{r}^{H} \mathbf{h}_{\mathrm{U},k_{\mathrm{U}}}.$$

As the combination of a  $p_{U,k_U}^{1/2}$  and an affine function, the convexity of  $(P6 - k_U)$ 's objective function depends on the sign of  $c_{1,k_U}$ .  $c_{2,k_U}$  is a semi-positive quadratic form while the sign of  $c_{1,k_U}$  is unknown. Although according to (3),  $y_{K_D+k_U}$  is a function of  $p_{U,k_U}$  and  $\mathbf{h}_{U,k_U}^H(\tilde{\mathbf{r}}) \mathbf{w}_{r,k_U}$ , however, it is calculated based on the value obtained in the last AO iteration and will be regarded as a constant in this subproblem. Consequently, the positiveness of  $c_{1,k_U}$  is theoretically not guaranteed. If  $c_{1,k_U} > 0$ , together with the convex box constraint, the objective function is convex on  $p_{U,k_U}$  and the global optimum is achieve at the stationary point or boundary of the variable. The stationary point is obtained at  $p_{U,k_U} = \frac{c_{1,k_U}^2}{4c_{2,k_U}^2} \ge 0$ . In the condition  $\frac{c_{1,k_U}^2}{4c_{2,k_U}^2}$  falls in the range between 0 and  $p_{U,\max}$ , this point is exactly the optimal power for the  $k_U$ th UL user. Otherwise,  $p_{U,k_U}^* = p_{U,\max}$ . When  $c_{1,k_U} \le 0$ , the objective function would be a monotonically decreasing function of  $p_{U,k_U}$  and hence  $p_{U,k_U}^*$  should equal to 0, which means to mute the transmission of this user. This conclusion seems contradictory for setting probably some users' power less than its maximum when maximizing the data rate, however, it is reasonable because of the existence of inter-user interference at both the UL users and BS ends. The silence of some users will improve the channel condition of other users and performance of the whole system.

# VI. Sub-problem 4: Optimizing $\mathbf{\tilde{t}}$

With given  $\mathbf{W}_t$ ,  $\mathbf{W}_r$ ,  $\mathbf{P}_U$ ,  $\tilde{\mathbf{r}}$ ,  $\mathbf{y}$ , and  $\gamma$ , maximizing the weighted-sum rate yields

(P7)

s.t. (1a), (1b).

Without loss of generality, we assume the adjustable region of MAs are a  $C_t, C_r \stackrel{\Delta}{=} A\lambda \times A\lambda$  square where  $A \in \mathbb{R}^+$  and hence, (1a) is a convex constraint on  $\tilde{t}$ . (12) is arranged in a quadratic form of  $H_D(\tilde{t})$  and  $H_{SI}(\tilde{t})$  with semi-definite coefficient matrices, however, it is still non-convex on  $\tilde{t}$  because of the exponential function and (1b) is also a non-convex constraint. To deal with (P7), we propose to adopt a block successive upper-bound minimization (BSUM) framework but with a non-convex constraint to find at least a locally optimal solution. Instead of directly solving (P7), we will successively optimize lower bounds of (12) in an antenna-by-antenna manner.

Since (12) is a differentiable and smooth function over  $\tilde{\mathbf{t}}$  and it is easy to see that the gradient function over each transmit MA  $\mathbf{t}_{n_t}$  is Lipschitz continuous, the second-order Taylor expansion is a good surrogate function to locally upper-bound (12) within a certain neighbor of a given point. Denote the value of transmit MA positions in the *m*th BSUM iteration by  $\tilde{\mathbf{t}}^m = [\mathbf{t}_1^m, \mathbf{t}_2^m, \cdots, \mathbf{t}_{N_t}^m]$ , then we define the quadratic surrogate function  $u(\mathbf{t}_{n_t}; \tilde{\mathbf{t}}^m)$  w.r.t. the

 $n_t$ th transmit MA position in the *m*th BSUM iteration as

where u(x; y) means that u is a function of x and is unfolded at y,  $\nabla_{\mathbf{t}_{n_t}} f_4(\tilde{\mathbf{t}}^m) \in \mathbb{R}^2$  and  $\nabla^2_{\mathbf{t}_{n_t}} f_4(\tilde{\mathbf{t}}^m) \in \mathbb{R}^{2 \times 2}$  are the gradient vector and Hessian matrix of  $f_4$  over  $\mathbf{t}_{n_t}$  respectively, and  $\tau_t^m$ is a positive number with  $\tau_t^m \mathbf{I} \succeq \nabla^2_{\mathbf{t}_{n_t}} f_4(\tilde{\mathbf{t}}^m)$ . The derivation of the gradient vector and Hessian matrix is provided in Appendix A. To ensure  $\tau_t^m \mathbf{I} \succeq \nabla^2_{\mathbf{t}_{n_t}} f_4(\tilde{\mathbf{t}}^m)$ , i.e.  $\tau_t^m \mathbf{I} - \nabla^2_{\mathbf{t}_{n_t}} f_4(\tilde{\mathbf{t}}^m) \succeq 0$ , we can make  $\tau_t^m$  greater than the largest eigenvalue of the Hessian matrix  $\nabla^2_{\mathbf{t}_{n_t}} f_4(\tilde{\mathbf{t}}^m)$ .

With the upper bound in (13), we propose to solve the highly non-convex subproblem (P7) in a BSUM framework. To this end, in the *m*th BSUM iteration, we solve the  $n_t$ th transmit MA position by

$$(P8 - m, n_t) \quad \min_{\mathbf{t}_{(n_t)}} \quad \frac{\tau_t^m}{2} \mathbf{t}_{(n_t)}^T \mathbf{t}_{(n_t)} + \left(\nabla_{\mathbf{t}_{(n_t)}} f_4\left(\tilde{\mathbf{t}}^m\right) - \tau_t^m \mathbf{t}_{(n_t)}^m\right)^T \mathbf{t}_{(n_t)}$$
(14)

s.t. 
$$\mathbf{t}_{(n_t)} \in \mathcal{R}_{n_t} = \{ \mathbf{t} | \| \mathbf{t} - \mathbf{t}_{(i)} \|_2 \ge D_{\min}, 1 \le i \le n_t \},$$
 (14a)  
(1a).

It is noteworthy that the  $t_{(n_t)}$  here is the  $n_t$ th MA position solved in the *m*th BSUM iteration and not necessarily the position of the  $n_t$ th MA. This is because in BSUM, the blocks, i.e. different transmit MA positions in this paper, may not be arranged in a cyclical rule. Although (14) is a convex upper bound of the primal problem, the constraint of (P8), especially the feasible movable region for antenna when  $n_t > 1$ , is still non-convex, leading to the search of the minimum of (14) intractable.

Without the constraints in (P8), we acquire the minimum of the objective function at the stationary point, i.e.  $\mathbf{t}_{(n_t)}^{\star} = \mathbf{t}_{(n_t)}^m - \frac{1}{\tau_t^m} \nabla_{\mathbf{t}_{(n_t)}} f_4\left(\tilde{\mathbf{t}}^m\right)$ . If  $\mathbf{t}_{(n_t)}^{\star}$  satisfies the constraints in (P8), it is exactly the optimal solution. Otherwise, this stationary point is invalid.

Theorem 1: If the stationary point of (P8) is outside its feasible set, the optimal solution  $t^{\star}_{(n_t)}$

lies on the boundary of the feasible set.

Proof: See Appendix B.

Existing papers mostly find optimal antenna position via iterative search algorithms, like gradient descent and particle swarm optimization, which would highly rely on initialization and easily lead to locally optimal solution. Exploiting the property of (P8) and geometry of feasible set, Theorem 1 significantly reduces the range of  $\mathbf{t}_{(n_t)}^{\star}$  and points out the analytical solution based on the location of the stationary point of (14).

The solution of (P8-m,  $n_t$ ) has been partially discussed in the proof of Theorem 1. We provide the detail about finding  $t^*_{(n_t)}$  in Algorithm 1. Firstly, we should find the antennas located in the  $D_{\min}$ -range centered on the stationary point. If there is no antenna qualified, the optimal solution is the stationary point. Otherwise, for each involved antenna, we calculate two kinds of point, i.e., the intersection of the antenna's  $D_{\min}$ -circle and the straight line connecting the antenna and stationary point (SCI), and the intersections of the antenna's and stationary point's circles (CCI). Consequently, we have three points of interest for every involved antenna and the points not inside these antennas' circles are potential optimal solutions. From the point nearest to the stationary point, we repeat this procedure until the current nearest point satisfies (14a), which is exactly the optimal solution. Appendix B is also a toy example when  $n_t = 3$  (two antennas determined) for this algorithm.

Overall, we propose a BSUM algorithm to solve (P7), in which we decompose the original non-convex problem into iterative upper bound minimization. In each iteration,  $N_t$  antenna

positions will be determined in a random rule to avoid local optimum. When solving any antenna position, the objective function is upper-bounded by its second-order Taylor expansion and the optimal position would be obtained analytically based on the geometry. The BSUM iteration would stop when some criterion meets.

Next, we will analyze the convergence of the proposed BSUM algorithm. BSUM is guaranteed to obtain at least a stationary solution under some conditions [1]. However, the constraints in our work is extremely intractable and deviates from the assumption in [1]. From the discussion in the proof of Theorem 1, it is also seen that the stationary solution sometimes outside the feasible set. We will alternatively demonstrate the convergence of this algorithm from the perspective of montonicity. We have

where  $\tilde{\mathbf{t}}_{-i}^{m+1} = \left[\mathbf{t}_{(1)}^{m+1}, \cdots, \mathbf{t}_{(i)}^{m+1}, \mathbf{t}_{(i+1)}^{m}, \cdots, \mathbf{t}_{N_{t}}^{m}\right]$ . In (15), the inequality ( $\alpha_{1}$ ) holds for the tightness of the upper bound at  $\tilde{\mathbf{t}}^{m}$ . Then, because (P8) minimizes this upper bound within the feasible set, ( $\alpha_{2}$ ) holds and the equality holds when the optimized position is identical to the previous one. As demonstrated above, the gradient function of  $f_{4}$  is Lipschitz continuous. Consequently, at  $\tilde{\mathbf{t}}_{-1}^{m+1}$ ,  $u\left(\cdot; \tilde{\mathbf{t}}^{m}\right)$  still upper-bounds  $f_{4}$  leading to ( $\alpha_{3}$ ). These inequalities ensure the descent of object's value in every single antenna position optimization process. Furthermore, after updating  $N_{t}$  positions in one iteration, the value of  $f_{4}$  keeps non-increasing. Recalling that  $f_{4}$  is a convex quadratic function of  $\mathbf{g}(\mathbf{t}_{i})$  and  $\mathbf{g}_{\mathrm{SI}}(\mathbf{t}_{i})$  and meanwhile their elements are all 1-module, it is easy to see  $f_{4}$  would have a lower bound. Overall,  $\{f_{4}(\tilde{\mathbf{t}}^{m})\}_{m=1}^{\infty}$  is a non-increasing sequence with a lower bound and the proposed BSUM algorithm is guaranteed to converge to at least a sub-optimal solution.

### VII. SUB-PROBLEM 5: OPTIMIZING $\tilde{\mathbf{r}}$

The marginal problem for  $\tilde{\mathbf{r}}$  is

Similar to sub-problem 4, (16) is a quadratic function of  $\mathbf{H}_{\mathrm{U}}(\mathbf{\tilde{r}})$  and  $\mathbf{H}_{\mathrm{SI}}(\mathbf{\tilde{r}})$  but (P9) is not convex on ( $\mathbf{\tilde{r}}$ ). We use an identical BSUM algorithm to solve (P9).

Denote the value of receive MA positions in the *m*th BSUM iteration by  $\tilde{\mathbf{r}}^m = [\mathbf{r}_1^m, \mathbf{r}_2^m, \cdots, \mathbf{r}_{N_r}^m]$ , then we define the quadratic surrogate function  $v(\mathbf{r}_{n_r}; \tilde{\mathbf{r}}^m)$  w.r.t. the  $n_r$ th receive MA position in the *m*th BSUM iteration as

where v(x; y) is defined similarly to u(x; y),  $\nabla_{\mathbf{r}_{n_r}} f_5(\mathbf{\tilde{r}}^m) \in \mathbb{R}^2$  and  $\nabla_{\mathbf{r}_{n_r}}^2 f_5(\mathbf{\tilde{r}}^m) \in \mathbb{R}^{2\times 2}$  are the gradient vector and Hessian matrix of  $f_5$  over  $\mathbf{r}_{n_r}$  respectively, and  $\tau_r^m$  is a positive number with  $\tau_r^m \mathbf{I} \succeq \nabla_{\mathbf{r}_{n_r}}^2 f_5(\mathbf{\tilde{r}}^m)$ . The derivation of the gradient vector and Hessian matrix is provided in Appendix C. To ensure  $\tau_r^m \mathbf{I} \succeq \nabla_{\mathbf{r}_{n_r}}^2 f_5(\mathbf{\tilde{r}}^m)$ , i.e.  $\tau_r^m \mathbf{I} - \nabla_{\mathbf{r}_{n_r}}^2 f_5(\mathbf{\tilde{r}}^m) \succeq 0$ , we can make  $\tau_r^m$ greater than the largest eigenvalue of the Hessian matrix  $\nabla_{\mathbf{r}_{n_r}}^2 f_5(\mathbf{\tilde{r}}^m)$ .

With the upper bound in (17), we propose to solve the highly non-convex subproblem (P9) also in a BSUM framework. To this end, in the *m*th BSUM iteration, we solve the  $n_r$ th receive MA position by

We use an approach same as sub-problem 4 to solve (P10). The Theorem 1, solution of  $\tilde{\mathbf{r}}$ , and convergence analysis are all similar to the discussion in solving sub-problem 4.

Overall, the FP-based AO algorithm for (P1) is summarized in Algorithm 2. In each step of Algorithm 2, the value of objective function increases and is upper-bounded by the power constraints guaranteeing the convergence of Algorithm 2.

## VIII. SIMULATION

### A. Simulation settings

We consider a cell that the FD BS is serving  $K_D = K_U = K$  DL and UL users simultaneously in our simulations. These users are randomly and uniformly located within a distance from 20m to 100m away from the BS, i.e.  $d_i \sim U(20, 100), i \leq i \leq K_D + K_U$ . At the BS, we assume the transmitter and receiver are equipped with equal number MAs, i.e.  $N_t = N_r = N$ . We use the finite scattering model to describe both the DL and UL channels between user and BS and SI channel between the transmitter and receiver of BS and assume each user-BS channel has the same number of transmit and receive path of L and  $L_{SI}$  for the SI channel. In this case, the path response matrices are all diagonal but note that the elevation and azimuth AoD/AoAs of each users are independently and randomly sampled from the uniform distribution between 0 and  $\pi$ . Moreover, we assume the diagonal elements of path response matrices in DL and UL channels independent identically distributed as CSCG distribution with zero mean and variance

 $\frac{\rho_0 d_i^{-\alpha}}{L}$ , i.e.  $\mathcal{CN}\left(0, \frac{\rho_0 d_i^{-\alpha}}{L}\right)$ , where  $\rho_0$  represents the path loss at the reference distance of 1m and  $\alpha$  is the path loss exponent. For the SI channel, we assume that the SI is canceled to certain degree via techniques in [2] and [3] and thus the elements in  $\Sigma_{SI}$  follow  $\mathcal{CN}\left(0, \frac{\rho_{SI}}{L}\right)$ . We further assume the background noise at DL users and the BS receiver have the same power, i.e.,  $\sigma_{D,i}^2 = \sigma_U^2 = \sigma^2$ . Simultaneously, the IUI power should be comparable to that of the background noise so that the FD communication can be conducted. Consequently, we set the IUI channel coefficient  $h_{IUI} \sim \mathcal{CN}(0, \rho_{IUI})$ . In these settings, without specific statement, essential parameters take values as provided in Tab.I.

$$\bar{w}_{r,n_r} = \sum_{i=1}^{K_{\rm U}} |y_i|^2 |w_{r,i,n_r}|^2, \bar{p}_{{\rm U},u} = \begin{cases} p_{{\rm U},u}, 1 \le u \le K_{\rm U} \\ 1, u = K_{\rm U} + 1 \end{cases}, \\ \ddot{f}_{u,n_r,m} = \sin \theta_{r,u,m}^2 \cos \phi_{r,u,m}^2 e^{j\frac{2\pi}{\lambda} \mathbf{n}_{r,u,m}^T \mathbf{r}_{n_r}}, \\ \dot{f}_{u,n_r,m}' = \sin \theta_{r,u,m}^2 \sin \phi_{r,u,m} \cos \phi_{r,u,m}^2 e^{j\frac{2\pi}{\lambda} \mathbf{n}_{r,u,m}^T \mathbf{r}_{n_r}}, \\ f''_{u,n_r,m} = \sin \phi_{r,u,m}^2 e^{j\frac{2\pi}{\lambda} \mathbf{n}_{r,u,m}^T \mathbf{r}_{n_r}} \end{cases}$$

# APPENDIX B

#### **PROOF OF THEOREM 1**

Firstly, we recast (14) by neglecting time index, adding some constants, and completing the square,

$$f(\mathbf{t}) = \frac{\tau_t^m}{2} \|\mathbf{t} - \mathbf{t}_{\rm SP}\|_2^2.$$
(27)

Consequently, solving (P8) is to find the point closest to the stationary point (SP)  $\mathbf{t}_{\text{SP}}$  in the feasible set. Without loss of generality, we consider the  $n_t = 3$  scenario. The feasible set is an  $A\lambda \times A\lambda$  square with two circles removed in this condition. Set the center of this square as the origin, we can denote the feasible set by  $\mathcal{R}_3 = \left\{ [x, y]^T | |x| \le \frac{A}{2}\lambda, |y| \le \frac{A}{2}\lambda \right\} \setminus \left\{ \mathbf{t} \left| \|\mathbf{t} - \mathbf{t}_{(1)}\|_2^2 < D_{\min}^2 \right\} \cup \left\{ \mathbf{t} \left| \|\mathbf{t} - \mathbf{t}_{(2)}\|_2^2 < D_{\min}^2 \right\}$ .  $\mathbf{t}_{(1)}$  and  $\mathbf{t}_{(2)}$  are the antenna positions determined in the previous iteration.

Firstly ,we consider the scenario the SP is outside this square. There are two possible cases: Case 1:  $|x_{SP}| \ge \frac{A}{2}\lambda$ ,  $|y_{SP}| \ge \frac{A}{2}\lambda$




Fig. 1: Illustration for different cases

In Fig. 1, possible locations of the SP and corresponding optimal solutions  $t^*$  are illustrated. The

red solid line is the contour of (27). Shown by SP1, it is easy to see that the optimal location of case 1 is exactly the vertex  $\left[-\frac{A}{2}\lambda, \frac{A}{2}\lambda\right]^T$  of the square.

Case 2:  $|x_{\rm SP}| \ge \frac{A}{2}\lambda, 0 \le |y_{\rm SP}| \le \frac{A}{2}\lambda$  or  $|y_{\rm SP}| \ge \frac{A}{2}\lambda, 0 \le |x_{\rm SP}| \le \frac{A}{2}\lambda$ 

SP2 is an example for case 2, in which the t<sup>\*</sup> would lies on one of the edges of the square. For the toy example in Fig.1, the optimal solution would be  $\left[\frac{A}{2}\lambda, y_{\rm SP}\right]^T$ . An other points inside the square cannot achieve smaller value of 27 than this point.

Then, the SP is also probably inside the square but also inside the removed circle. We assume the circles of existing antennas are separated,

Case 3: 
$$\|\mathbf{t}_{(1)} - \mathbf{t}_{(2)}\|_{2} \ge 2D_{\min} \text{ with } \|\mathbf{t}_{\mathrm{SP}} - \mathbf{t}_{(1)}\|_{2}^{2} < D_{\min}^{2}, \|\mathbf{t}_{\mathrm{SP}} - \mathbf{t}_{(2)}\|_{2}^{2} \ge D_{\min}^{2} \text{ or } \|\mathbf{t}_{\mathrm{SP}} - \mathbf{t}_{(2)}\|_{2}^{2} < D_{\min}^{2}, \|\mathbf{t}_{\mathrm{SP}} - \mathbf{t}_{(1)}\|_{2}^{2} \ge D_{\min}^{2}$$

In case 3, the SP locates only inside one circle of antennas. As shown by SP3, the contour of 27 first approaches the circle of  $t_{(1)}$  and based on geometric knowledge, the  $t^*$  is the intersection point of this circle and the straight line connecting  $t_{(1)}$  and SP3.

When the circles of two antennas overlap, we consider

Case 4: 
$$D_{\min} \leq \|\mathbf{t}_{(1)} - \mathbf{t}_{(2)}\|_2 < 2D_{\min}$$
 with  $\|\mathbf{t}_{SP} - \mathbf{t}_{(1)}\|_2^2 < D_{\min}^2$ ,  $\|\mathbf{t}_{SP} - \mathbf{t}_{(2)}\|_2^2 \geq D_{\min}^2$  or  $\|\mathbf{t}_{SP} - \mathbf{t}_{(2)}\|_2^2 < D_{\min}^2$ ,  $\|\mathbf{t}_{SP} - \mathbf{t}_{(1)}\|_2^2 \geq D_{\min}^2$ 

There are intersections between two circles in case 4, however, the SP4 is still in the  $D_{\min}$ -range of only one antenna. In this scenario, the optimal solution is the same as that of case 3, i.e. the intersection point of the  $t_{(2)}$  circle and the straight line connecting  $t_{(1)}$  and SP4.

Case 5:  $D_{\min} \le \|\mathbf{t}_{(1)} - \mathbf{t}_{(2)}\|_2 < 2D_{\min} \text{ with } \|\mathbf{t}_{SP} - \mathbf{t}_{(1)}\|_2^2 < D_{\min}^2, \|\mathbf{t}_{SP} - \mathbf{t}_{(2)}\|_2^2 < D_{\min}^2$ 

In case 5, the SP is in the  $D_{\min}$ -range of two antennas, which means that w.r.t. both two

antennas, the intersection points of the circle and straight line would fall in the other antennas' circle. To this end,  $t^*$  will be one of the intersection points of these two circle, as shown in the third part of Fig.1. The coordinates of these two intersection points are easily obtained by solving this equation group

$$\begin{cases} (x - x_{(1)})^{2} + (y - y_{(1)})^{2} = D_{\min}^{2} \\ (x - x_{(2)})^{2} + (y - y_{(2)})^{2} = D_{\min}^{2} \end{cases},$$
(28)

and  $t^*$  is the one with smallest (27) value.

For the circumstances that  $n_t$  is less than 3, only case 1, 2, and 3 exist, and the discuss about case 3, 4, and 5 can be further extended to  $n_t$  greater than 3. Overall, the optimal solution is either on the edge or the vertex of the boundary of feasible set.
