HEAT KERNELS AND GREEN FUNCTIONS FOR FRACTIONAL SCHRÖDINGER OPERATORS WITH CONFINING POTENTIALS

ABSTRACT. We give two-sided, global (in all variables) estimates of the heat kernel and the Green function of the fractional Schrödinger operator with a non-negative and locally bounded potential V such that $V(x) \to \infty$ as $|x| \to \infty$. We assume that V is comparable to a radial profile with the doubling property. Our bounds are sharp with respect to spatial variables and qualitatively sharp with respect to time. The methods we use combine probabilistic and analytic arguments. They are based on the strong Markov property and the Feynman–Kac formula.

Keywords: fractional Schrödinger operator; confining potential; heat kernel; Green function; Feynman–Kac formula; ground state

1. INTRODUCTION AND MAIN RESULTS

Let $d \in \mathbb{N} := \{1, 2, ...\}$ and $\alpha \in (0, 2)$. Let $\mathcal{L} := -(-\Delta)^{\alpha/2}$ be the fractional Laplacian of order α – the non-local, pseudo-differential operator which is defined by

$$\mathcal{L}f(x) = C_{d,\alpha} \int_{\mathbb{R}^d} \left(f(x+z) - f(x) - \langle \nabla f(x), z \rangle \rangle \mathbb{1}_{\{|z| \le 1\}} \right) \frac{1}{|z|^{d+\alpha}} \, dz, \quad f \in C_c^\infty(\mathbb{R}^d)$$

with

$$C_{d,\alpha} = \frac{\alpha 2^{\alpha-1} \Gamma((d+\alpha)/2)}{\pi^{d/2} \Gamma(1-\alpha/2)}$$

It is well known that \mathcal{L} is an infinitesimal generator of the rotationally invariant α -stable Lévy process $X := \{X_t\}_{t\geq 0}$ in \mathbb{R}^d , see e.g. [23] for various definitions of \mathcal{L} and the probabilistic background.

The main goal of the paper is to find global, two-sided estimates of the heat kernel and the Green function associated with the Schrödinger operator

(1.1)
$$\mathcal{L}^V = \mathcal{L} - V.$$

Here and in what follows, the potential $V : \mathbb{R}^d \to [0, \infty)$ is a sufficiently regular, non-negative and locally bounded function such that $V(x) \to \infty$ as $|x| \to \infty$. Therefore, \mathcal{L}^V extends to a (negative) self-adjoint operator on $L^2(\mathbb{R}^d) := L^2(\mathbb{R}^d, dx)$, see e.g. [25, Proposition 10.22].

The operator $-\mathcal{L}^V$ can be interpreted as a Hamiltonian in the fractional version of the classical model of oscillator, where \mathcal{L}^V takes the form $\Delta - V$, with Δ denoting the standard Laplacian and V being a potential as defined above. The most classical case, $V(x) = c|x|^2$ (where c > 0), corresponds to the harmonic oscillator. However, potentials exhibiting different growth rates at infinity are also of interest, such as the anharmonic (quartic) [1] or logarithmic [4] oscillators. In these models, particles are confined by forces corresponding to potentials V that grow to infinity at infinity. Such potentials are, therefore, commonly referred to as confining potentials in the literature. Fractional operators, especially in the relativistic case with $\alpha = 1$, play a significant role in contemporary mathematical physics (see, e.g., [16, 24]).

The Schrödinger semigroup corresponding to the operator \mathcal{L}^V is denoted by $\{T_t^V\}_{t\geq 0}$; it fulfills the Feynman–Kac formula

(1.2)
$$T_t^V f(x) = \mathbb{E}_x \left[\exp\left(-\int_0^t V(X_s) \, ds \right) f(X_t) \right], \quad f \in L^2(\mathbb{R}^d) \text{ or } f \in C_b(\mathbb{R}^d)$$

 $(\mathbb{P}_x \text{ and } \mathbb{E}_x \text{ denote the probability measure and the expectation with respect to starting position <math>x \in \mathbb{R}^d$, respectively). Moreover, there exists a jointly continuous and symmetric integral kernel $p: (0, \infty) \times \mathbb{R}^d \times \mathbb{R}^d \to (0, \infty)$ such that

(1.3)
$$T_t^V f(x) = \int_{\mathbb{R}^d} p(t, x, y) f(y) \, dy, \quad t > 0, \ f \in L^2(\mathbb{R}^d) \text{ or } f \in C_b(\mathbb{R}^d),$$

see e.g. the monograph by Demuth and van Casteren [15, Theorem 2.5] for a reference. Since $V \ge 0$,

$$p(t, x, y) \le q(t, x, y), \quad t > 0, \ x, y \in \mathbb{R}^d,$$

where q(t, x, y) is the heat kernel associated with the fractional Laplacian \mathcal{L} (or, equivalently, the transition density of the α -stable process X). We remark that there are constants $c_1, c_2 > 0$ such that

$$(1.4) \quad c_1\left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \le q(t,x,y) \le c_2\left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right), \quad t > 0, \ x,y \in \mathbb{R}^d,$$

see [2, Theorem 2.1] and [3, Proof of Lemma 5].

Throughout the paper we use the following assumption on the regularity and growth of V.

Assumption (H)

There exist a non-decreasing function $g: [0, \infty) \to [1, \infty)$, satisfying $\lim_{r \to \infty} g(r) = \infty$, and constants $C_1, C_2, C_3 > 0$ such that

(1.5)
$$g(2r) \le C_1 g(r), \quad r \ge 0,$$

and

(1.6)
$$C_2g(|x|) \le V(x) \le C_3g(|x|), \quad |x| \ge 1.$$

Though the theory of non-local Schrödinger operators with confining potentials and their semigroups is an active area of research, existing results are mainly focused on intrinsic contractivity properties and ground state estimates. For basic definitions, we refer the reader to Davies and Simon [14]. A sharp necessary and sufficient condition for the intrinsic ultracontractivity of the non-local Schrödinger operator \mathcal{L}^V , driven by relativistic and usual rotationally invariant α -stable processes, was provided by Kulczycki and Siudeja [20], and by Kaleta and Kulczycki [18], respectively. Later, Kaleta and Lőrinczi [19] extended these results to non-local Schrödinger operators \mathcal{L}^V associated with the class of symmetric Lévy processes possessing the direct jump property (DJP). The authors developed a new iteration technique to establish eigenfunction estimates for \mathcal{L}^V , including two-sided sharp bounds for the ground state, and characterized the asymptotic version (valid for large times) of intrinsic ultracontractivity. Chen and Wang [6] applied the intrinsic super-Poincaré inequality to establish a sharp criterion for intrinsic ultracontractivity and derived two-sided estimates for the ground state of non-local Schrödinger operators associated with general symmetric jump processes. Their analysis accounted for both finite-range and long-range jump behaviors. Furthermore, by employing a similar approach, the authors investigated various hyperboundedness properties of the associated Schrödinger semigroups [5]. More recently, Kaleta and Schilling [20] further analyzed the DJP class, providing large-time heat kernel estimates for the corresponding non-local Schrödinger operators with confining potentials. These estimates were established for $t \ge T_0$, with $T_0 > 0$ properly chosen. However, to the best of our knowledge, global estimates of the heat kernel p(t, x, y) for the full time regime, as well as estimates for the Green function G(x, y) associated with \mathcal{L}^V , remain unknown. In this paper, we address this problem comprehensively. We focus on the fractional Schrödinger operator $\hat{\mathcal{L}}^V$ and prove two-sided estimates for p(t, x, y) over the full time horizon, as well as two-sided estimates for the Green function G(x, y).

To state our first main result, we need to introduce some more notation. Define

(1.7)
$$t_0(s) := \inf\left\{t > 0 : \exp\left(-tg(s)\right) = \frac{t}{(1+s)^{\alpha}}\right\}, \quad s \ge 0.$$

Note that, for any fixed $s \ge 0$, the function $t \mapsto e^{-tg(s)}$ is strictly decreasing and onto the interval (0,1), while $t \mapsto \frac{t}{(1+s)^{\alpha}}$ is strictly increasing, onto $(0,\infty)$. Then, $t_0(s)$ is unique in the sense that for any $t < t_0(s)$, $\exp(-tg(s)) > \frac{t}{(1+s)^{\alpha}}$, and for $t > t_0(s)$, $\exp(-tg(s)) < \frac{t}{(1+s)^{\alpha}}$. See Lemma 2.3 below for further estimates of $t_0(s)$.

Also, we say that the function $t_0 : [0, \infty) \to (0, \infty)$ is almost increasing (resp. decreasing), if there exists a continuous, strictly increasing (resp. strictly decreasing) function $h : [0, \infty) \to (0, \infty)$ and constants $C_*, C_{**} \ge 1$ such that

(1.8)
$$C_*^{-1}h(s) \le t_0(s) \le C_*h(s), \quad C_{**}^{-1}h(s) \le h(2s) \le C_{**}h(s), \quad s \ge 0.$$

For any $a, b \ge 0$, $a \land b := \min\{a, b\}$ and $a \lor b := \max\{a, b\}$.

Under Assumption (**H**) it holds that $\lim_{|x|\to\infty} V(x) = \infty$. Then, according to [27, Corollary 1.3] (see also [6, Proposition 1.1] or [18, Lemma 1]), the operator $T_t^V : L^2(\mathbb{R}^d) \to L^2(\mathbb{R}^d)$ is compact for every t > 0. Hence, by general theory of semigroups of compact operators, there exists an orthonormal basis in $L^2(\mathbb{R}^d)$, consisting of eigenfunctions $\{\phi_n\}_{n\geq 1}$ of the operator $-\mathcal{L}^V$, with associated eigenvalues $\{\lambda_n\}_{n\geq 1}$ satisfying $0 < \lambda_1 < \lambda_2 \leq \lambda_3 \leq \cdots$ and $\lim_{n\to\infty} \lambda_n = \infty$. We usually call ϕ_1 the ground state of $-\mathcal{L}^V$. In particular, for all t > 0 and $x \in \mathbb{R}^d$,

(1.9)
$$T_t^V \phi_1(x) = e^{-\lambda_1 t} \phi_1(x).$$

Furthermore, it is known that $\phi_1 : \mathbb{R}^d \to \mathbb{R}_+$ has a version which is continuous and strictly positive (see e.g. [6, Proposition 1.2]). Then, by [18, Corollary 3], for all $x \in \mathbb{R}^d$,

$$c_1 H(x) \le \phi_1(x) \le c_2 H(x)$$

where

$$H(x) := \frac{1}{g(|x|)(1+|x|)^{d+\alpha}}$$

This, along with (1.9), yields that

(1.10)
$$c_3 e^{-\lambda_1 t} H(x) \le T_t^V H(x) \le c_4 e^{-\lambda_1 t} H(x), \quad x \in \mathbb{R}^d, \ t > 0.$$

The following theorem is the first main result of the paper.

Theorem 1.1. Let Assumption (H) hold. Then there are constants $C_0, \tilde{C}_0, C_1, \ldots, C_{12} > 0$ such that for every $x, y \in \mathbb{R}^d$ and t > 0 the following statements hold.

(1) If $0 < t \le C_0 t_0(|x| \land |y|)$, then

(1.11)
$$C_{1}\left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \left(\frac{1}{tg(|x| \vee |y|)} \wedge 1\right) e^{-C_{2}tg(|x| \wedge |y|)} \leq p(t,x,y) \\ \leq C_{3}\left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \left(\frac{1}{tg(|x| \vee |y|)} \wedge 1\right) e^{-C_{4}tg(|x| \wedge |y|)}.$$

(2-i) If $t_0(\cdot)$ is almost increasing, then, for $t > C_0 t_0(|x| \wedge |y|)$,

(1.12)
$$C_5 e^{-\lambda_1 t} H(x) H(y) \le p(t, x, y) \le C_6 e^{-\lambda_1 t} H(x) H(y).$$

(2-ii) If $t_0(\cdot)$ is almost decreasing, then, for $C_0t_0(|x| \wedge |y|) < t \leq \tilde{C}_0$,

(1.13)
$$C_{7}H(x)H(y)\int_{\{|z|\leq s_{0}(t)\}}e^{-C_{6}tg(|z|)}dz \leq p(t,x,y) \leq C_{8}H(x)H(y)\int_{\{|z|\leq s_{0}(C_{9}t)\}}e^{-C_{10}tg(|z|)}dz.$$

where $s_0(t) = h^{-1}(t) \vee 2$, $h^{-1}(t) := \inf\{s \ge 0 : h(s) \le t\}$ with h given in (1.8), and we use the convention that $\inf \emptyset = -\infty$; for every $t > C_0$,

(1.14)
$$C_{11}e^{-\lambda_1 t}H(x)H(y) \le p(t,x,y) \le C_{12}e^{-\lambda_1 t}H(x)H(y).$$

We now illustrate our result with the following example.

Example 1.2. Let

$$V(x) = \log^{\beta}(1 + |x|), \qquad \beta > 0.$$

Then there are constants $C_0, \ldots, C_{10} > 0$ such that for every $x, y \in \mathbb{R}^d$ with $|x| \leq |y|$ and t > 0we have the following estimates.

(1) If $0 < t \le C_0 \log^{1-\beta}(2+|x|)$, then $C_1\left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \left(\frac{1}{t\log^\beta(2+|y|)} \wedge 1\right) e^{-C_2 t\log^\beta(2+|x|)} \le p(t,x,y)$ $\leq C_3 \left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}} \right) \left(\frac{1}{t \log^\beta (2+|y|)} \wedge 1 \right) e^{-C_4 t \log^\beta (2+|x|)}.$

(2-i) If
$$t \ge C_0 \log^{1-\beta}(2+|x|)$$
 and $\beta \le 1$, then
 $C_5 e^{-\lambda_1 t} H(x) H(y) \le p(t,x,y) \le C_6 e^{-\lambda_1 t} H(x) H(y).$

Here and in what follows,

$$H(x) = \frac{1}{\log^{\beta}(2+|x|)(1+|x|)^{d+\alpha}}, \quad x \in \mathbb{R}^{d}$$

(2-ii) If
$$t \ge C_0 \log^{1-\beta}(2+|x|)$$
 and $\beta > 1$, then
 $C_7 \left(e^{C_8 t^{-1/(\beta-1)}} \mathbb{1}_{\{t\le 1\}} + e^{-\lambda_1 t} \mathbb{1}_{\{t>1\}} \right) H(x) H(y) \le p(t,x,y)$
 $\le C_9 \left(e^{C_{10} t^{-1/(\beta-1)}} \mathbb{1}_{\{t\le 1\}} + e^{-\lambda_1 t} \mathbb{1}_{\{t>1\}} \right) H(x) H(y).$

Our second main result gives estimates for the Green function $G^V(x,y) := \int_0^\infty p(t,x,y) dt$. In what follows the notation $f(x) \simeq g(x), x \in A$, means that there is a constant $c \ge 1$ such that $(1/c)g(x) \le f(x) \le cg(x), x \in A$ (we also write " $\stackrel{c}{\simeq}$ " to indicate the comparison constant c).

Theorem 1.3. Let Assumption (H) hold. If $t_0(\cdot)$ is an almost monotone function, then

$$G^{V}(x,y) \asymp \frac{1}{|x-y|^{d-\alpha}} \left(1 \wedge \frac{1}{g(|x|)|x-y|^{\alpha}} \right) \left(1 \wedge \frac{1}{g(|y|)|x-y|^{\alpha}} \right) Q(x,y), \quad x,y \in \mathbb{R}^{d}, \ x \neq y.$$
where

$$Q(x,y) := \begin{cases} 1, & \alpha < d, \\ \max\left\{\log\left(\frac{1}{|x-y|^{\alpha}g(|x| \wedge |y|)}\right), 1\right\}, & \alpha = d = 1, \\ \max\left\{\left(\frac{1}{|x-y|^{\alpha}g(|x| \wedge |y|)}\right)^{\frac{\alpha-d}{\alpha}}, 1\right\}, & \alpha > d = 1. \end{cases}$$

Next, we will make some remarks on our main results above.

(1) In order to make the presentation and proofs in this paper as clear and readable as possible, we decided to focus on the case when $X := \{X_t\}_{t \ge 0}$ is the rotationally invariant α -stable process. This choice also makes our contribution accessible to a wider audience. However, we believe that the arguments we propose apply to a large class of symmetric jump processes. In fact, it is straightforward to observe that the expression (2.27) for the heat kernel p(t, x, y) relies solely on the strong Markov property of X and the Feynman-Kac formula (1.2). Using this, along with the Lévy system (2.15) and Dirichlet heat kernel estimates for more general symmetric jump processes established in [17, 21], it is possible to apply suitable iteration arguments (by choosing an appropriate domain U when applying (2.27)) to derive two-sided estimates for the Schrödinger heat kernel p(t, x, y) associated with such processes.

- (2) As mentioned above, the expression (2.27) serves as the starting point for our proofs. It allows us to derive appropriate estimates for the kernel p(t, x, y) by investigating the probabilities that the process X visits various positions where the potential V takes specific values. In contrast to [5], where the classical Schrödinger semigroup was studied, here we apply the Lévy system formula (2.15) to estimate the joint distribution (τ_U, X_{τ_U}) in (2.27). Our approach here is different because our process X is a jump process. We also note that our argument in this paper differs significantly from that in [20], where the DJP and the estimates for harmonic functions played a crucial role.
- (3) According to Theorem 1.1, we know that there exists a threshold time $C_0t_0(|x| \wedge |y|)$ for the two-sided estimates of the heat kernel p(t, x, y). Intuitively, if $t \leq C_0t_0(|x| \wedge |y|)$, the typical path from x to y that maximizes the probability for the process X evolving in the presence of the potential V follows the path of the free process X (i.e., when V = 0), and the effect of the potential along this path is expressed only through the local values of V near x and y. When $t > C_0t_0(|x| \wedge |y|)$, the corresponding path that maximizes the probability will first travel from x to a domain near the origin, where the effect of the potential V is small, and then proceed from this domain to y, where the effect of the potential V is more significant. For example, see the integral terms in (1.13).

The rest of the paper is organized as follows. In the next section, we present some necessary preliminaries for the proof of Theorem 1.1. In particular, we establish an upper bound for $T_t^V 1(x)$ and some rough off-diagonal estimate of p(t, x, y). Section 3 is devoted to two-sided estimates of p(t, x, y) when $0 < t \leq C'_0 t_0(|x| \land |y|)$ for any $C'_0 > 0$. In Section 4, we verify two-sided estimates of p(t, x, y) when $t \geq C_0 t_0(|x| \land |y|)$ for some $C_0 > 0$. In Section 5, we provide the proof of Example 1.2. Finally, in Section 6, we present the proofs of Theorems 1.1 and 1.3, based on our findings from Sections 3 and 4.

2. Preliminaries

The following identity, called the Lévy system formula, describes the structure of jumps of the (rotationally invariant) α -stable process $X := \{X_t\}_{t \ge 0}$, see e.g. [10, Lemma 4.7].

Lemma 2.1. Suppose that $f : \mathbb{R}_+ \times \mathbb{R}^d \times \mathbb{R}^d \to [0, \infty)$ is a nonnegative measurable function so that f(s, x, x) = 0 for all $x \in \mathbb{R}^d$ and $s \in \mathbb{R}_+$. Then, for every $x \in \mathbb{R}^d$ and stopping time τ , it holds that

(2.15)
$$\mathbb{E}_x\left[\sum_{s\leq\tau} f(s, X_{s-}, X_s)\right] = \mathbb{E}_x\left[\int_0^\tau \int_{\mathbb{R}^d} f(s, X_{s-}, z) \frac{C_{d,\alpha}}{|X_{s-} - z|^{d+\alpha}} dz \, ds\right],$$

where $X_{s-} := \lim_{\substack{t \to s \\ t < s}} X_t$ denotes the left limit of X. at s.

For any open subset $D \subset \mathbb{R}^d$ and $x \in D$, we define by

$$\delta_D(x) := \inf\{|x - z| : z \in D^c\}$$

the distance from $x \in D$ to the boundary ∂D . Let $\tau_D := \inf\{t \ge 0 : X_t \notin D\}$ be the first exit time of the process X from the set D. Denote by $q_D(t, x, y)$ the transition density of X killed upon exiting D. The following two-sided estimates for $q_{B(x,R)}(t, x, y)$ essentially have been proved in [9].

Lemma 2.2. For any constant $C'_0 > 0$ there exists a positive constant C_1 such that for every $x \in \mathbb{R}^d$, R > 0, $y \in B(x, R)$ and $0 < t \le C'_0 R^{\alpha}$,

(2.16)
$$q_{B(x,R)}(t,x,y) \stackrel{C_1}{\asymp} \left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}} \right) \left(\frac{\delta_{B(x,R)}(y)^{\alpha/2}}{\sqrt{t}} \wedge 1 \right).$$

Proof. Due to the spatial homogeneity of the process X, it suffices to prove (2.16) for x = 0. According to [9, Theorem 1.1], for every $C'_0 > 0$ there exists a positive constant c_1 such that for all $0 < t \le C'_0$ and $y \in B(0, 1)$,

(2.17)
$$q_{B(0,1)}(t,0,y) \stackrel{c_1}{\approx} \left(t^{-d/\alpha} \wedge \frac{t}{|y|^{d+\alpha}} \right) \left(\frac{\delta_{B(0,1)}(y)^{\alpha/2}}{\sqrt{t}} \wedge 1 \right).$$

Furthermore, we note that $\delta_{B(0,1)}(y) = 1 - |y|$ for all $y \in B(0,1)$. Combining this and (2.17) with the scaling property

$$q_{B(0,1)}(t,0,y) = R^d q_{B(0,R)}(R^{\alpha}t,0,Ry), \quad t > 0, \ y \in B(0,1),$$

we obtain (2.16) immediately.

We also give a lemma which describes the properties of $t_0(\cdot)$ and $g(\cdot)$.

Lemma 2.3. Let $t_0(\cdot)$ be defined by (1.7) and assume that $g(\cdot)$ satisfies (1.5) and (1.6). Then there are constants $C_2, q_1 > 0$ such that for all $s \ge 0$,

(2.18)
$$g(s) \le C_2(1+s)^{q_1},$$

and

(2.19)
$$C_2^{-1}(1+s)^{-q_1} \le t_0(s) \le C_2\left(1 + \frac{\log(2+s)}{g(s)}\right)$$

Proof. If s > 1, then $s \in (2^n, 2^{n+1}]$ for some $n \in \{0, 1, 2, ...\}$. By the monotonicity of g and (1.5) (we may assume that $c_0 > 1$, where c_0 denotes the comparability constant in (1.5)),

$$g(s) \le g(2^{n+1}) \le c_0^{n+1}g(1) = c_0g(1)2^{n\log_2 c_0} \le c_1s^{q_1} \le c_1(1+s)^{q_1}$$

with $c_1 := c_0 g(1)$ and $q_1 := \log_2 c_0$. If $s \in [0, 1]$, then $g(s) \le g(1) \le c_1 \le c_1 (1+s)^{q_1}$. By all of the above estimates we obtain (2.18).

By (1.7) it holds that $\exp(-t_0(s)g(s)) = t_0(s)(1+s)^{-\alpha}$, so $t_0(s)g(s) + \log t_0(s) = \alpha \log(1+s)$. If $t_0(s) \le c_2 \log 2$ holds for some $c_2 > 0$ that satisfies $c_2 \log 2 \ge 1$, then the second inequality in (2.19) follows. If $t_0(s) \ge c_2 \log 2 (\ge 1)$, then $t_0(s) = \frac{\alpha \log(1+s) - \log t_0(s)}{g(s)} \le \frac{\alpha \log(1+s)}{g(s)}$ for s > 0. Putting both estimates above together, we prove the second inequality in (2.19).

By the fact that $g(r) \ge 1$ for all $r \ge 0$, there is $a_0 > 0$ large enough such that for all s > 0,

(2.20)
$$(a_0g(s))^{-1}(1+s)^{-\alpha} \le e^{-a_0^{-1}} = \exp\left(-(a_0g(s))^{-1}g(s)\right)$$

By (1.7) again, $t_0(s) \ge (a_0 g(s))^{-1} \ge c_3 (1+s)^{-q_1}$ for every s > 0. Then, we prove the first inequality in (2.19).

Next, we present upper bounds for $T_t^V \mathbb{1}(x)$, which will be frequently used in the paper.

Lemma 2.4. There exist positive constants C_3, C_4 such that for any t > 0 and $x \in \mathbb{R}^d$,

(2.21)
$$T_t^V 1(x) \le C_3 \left(\exp\left(-C_4 t g(|x|)\right) + \frac{t}{(1+|x|)^{\alpha}} \right)$$

Proof. Since

$$\inf_{x \in B(0,2), t > 0} \left(\exp\left(-C_4 t g(|x|) \right) + \frac{t}{(1+|x|)^{\alpha}} \right) \ge c_0,$$

(2.21) holds trivially for every $x \in \mathbb{R}^d$ with $|x| \leq 2$ by taking C_3 large enough. Then, it suffices to prove (2.21) for every $x \in \mathbb{R}^d$ with $|x| \geq 2$. Set U := B(x, |x|/2). According to (1.2),

$$T_t^V 1(x) = \mathbb{E}_x \left[\exp\left(-\int_0^t V(X_s) \, ds\right) \right]$$

= $\mathbb{E}_x \left[\exp\left(-\int_0^t V(X_s) \, ds\right) \mathbb{1}_{\{\tau_U \ge t\}} \right] + \mathbb{E}_x \left[\exp\left(-\int_0^t V(X_s) \, ds\right) \mathbb{1}_{\{\tau_U < t\}} \right]$
=: $I_1 + I_2$.

Obviously, by (1.5) and (1.6),

$$I_1 \le \exp\left(-t \inf_{z \in U} V(z)\right) \le \exp\left(-c_1 t g(|x|)\right).$$

On the other hand,

$$I_{2} = \mathbb{E}_{x} \left[\exp \left(-\int_{0}^{t} V(X_{s}) \, ds \right) \mathbb{1}_{\{\tau_{U} < t, \, X_{t} \in B(x, |x|/3)\}} \right]$$
$$+ \mathbb{E}_{x} \left[\exp \left(-\int_{0}^{t} V(X_{s}) \, ds \right) \mathbb{1}_{\{X_{t} \notin B(x, |x|/3)\}} \right]$$
$$=: I_{21} + I_{22}.$$

By the strong Markov property,

$$I_{21} \leq \mathbb{E}_{x} \left[\mathbb{P}_{X_{\tau_{U}}} (X_{t-\tau_{U}} \in B(x, |x|/3)) \mathbb{1}_{\{\tau_{U} < t\}} \right] \leq \sup_{\substack{0 \leq s \leq t \\ z \in B(x, |x|/2)^{c}}} \int_{B(x, |x|/3)} q(s, z, y) \, dy$$
$$\leq c_{2} \sup_{z \in B(x, |x|/2)^{c}} \int_{B(x, |x|/3)} t|z - y|^{-d-\alpha} \, dy \leq \frac{c_{3}t}{(1 + |x|)^{\alpha}},$$

where in the third inequality we used (1.4). Similarly, by using (1.4) once again,

$$I_{22} \le \int_{B(x,|x|/3)^c} q(t,x,y) \, dy \le \frac{c_4 t}{(1+|x|)^{\alpha}}.$$

Combining all the estimates above, we obtain the desired assertion.

Corollary 2.5. There exist positive constants C_5 , C_6 and C_7 such that for all $x \in \mathbb{R}^d$ and $t \geq C_5 t_0(|x|)$,

(2.22)
$$T_t^V 1(x) \le C_6 \log(2+|x|)(1+|x|)^{-\alpha} \le C_7 (1+|x|)^{-\alpha/2}.$$

Proof. According to (2.21), for every $\tilde{C}_0 > 0$ and $x \in \mathbb{R}^d$,

(2.23)
$$T_{\tilde{C}_0 t_0(|x|)}^V 1(x) \le c_1 \left(\exp\left(-c_2 \tilde{C}_0 t_0(|x|) g(|x|) \right) + \frac{\tilde{C}_0 t_0(|x|)}{(1+|x|)^{\alpha}} \right).$$

By (1.7) and (2.19), it holds that for all $x \in \mathbb{R}^d$,

(2.24)

$$\exp\left(-c_2\tilde{C}_0t_0(|x|)g(|x|)\right) = \left(e^{-t_0(|x|)g(|x|)}\right)^{c_2C_0} \\
= \left(\frac{t_0(|x|)}{(1+|x|)^{\alpha}}\right)^{c_2\tilde{C}_0} \le c_3[\log(2+|x|)]^{c_2\tilde{C}_0}(1+|x|)^{-c_2\tilde{C}_0\alpha}.$$

On the other hand, by (2.19) again,

$$\frac{t_0(|x|)}{(1+|x|)^{\alpha}} \le c_4 \log(2+|x|)(1+|x|)^{-\alpha}.$$

Choosing $\tilde{C}_0 > c_2^{-1}$ and putting both estimates above into (2.23) yield that

$$T^{V}_{\tilde{C}_{0}t_{0}(|x|)}1(x) \le c_{5}\log(2+|x|)(1+|x|)^{-\alpha}$$

Therefore, for every $t \geq \tilde{C}_0 t_0(|x|)$,

$$T_t^V 1(x) = T_{\tilde{C}_0 t_0(|x|)}^V \left(T_{t-\tilde{C}_0 t_0(|x|)}^V 1 \right)(x)$$

$$\leq T_{\tilde{C}_0 t_0(|x|)}^V 1(x) \leq c_5 \log(2+|x|)(1+|x|)^{-\alpha}.$$

The proof of the first inequality in the desired assertion is complete. The second assertion is a direct consequence of the first one. $\hfill \Box$

Remark 2.6. According to (1.7), for every $c_0 > 0$, $x \in \mathbb{R}^d$ and $0 < t \le c_0 t_0(|x|)$,

(2.25)
$$\frac{t}{(1+|x|)^{\alpha}} = c_0 \frac{c_0^{-1}t}{(1+|x|)^{\alpha}} \le c_0 \exp\left(-c_0^{-1}tg(|x|)\right).$$

Thus, by (2.21), for any $c_0 > 0$, there exist positive constants c_1 and c_2 (which may depend on c_0) such that for any $x \in \mathbb{R}^d$ and $0 < t \le c_0 t_0(|x|)$,

(2.26)
$$T_t^V 1(x) \le c_1 \exp(-c_2 t g(|x|)).$$

At the end of this section, we prove an upper bound for p(t, x, y) when $|x - y| \ge Ct^{1/\alpha}$. For this we need the following representation of p(t, x, y). Since the proof is almost the same as that [5, Lemma 2.1] (it only uses the strong Markov property of the process X and the Feynman–Kac formula (1.2)), we omit it here.

Lemma 2.7. Suppose U is a domain in \mathbb{R}^d . Then, for every $x \in U$ and $y \notin \overline{U}$,

(2.27)
$$p(t, x, y) = \mathbb{E}_x \left[\exp\left(-\int_0^{\tau_U} V(X_s) \, ds \right) \mathbb{1}_{\{\tau_U \le t\}} p\left(t - \tau_U, X_{\tau_U}, y \right) \right].$$

Lemma 2.8. For any $C'_0 > 0$ there is a constant $C_8 > 0$ such that for all $x, y \in \mathbb{R}^d$ and t > 0 with $|x - y| \ge 2C'_0 t^{1/\alpha}$,

(2.28)
$$p(t, x, y) \le \frac{C_8 t}{|x - y|^{d + \alpha}} \left(1 \wedge \frac{1}{t \max\{g(|x|), g(|y|)\}} \right)$$

Proof. Without loss of generality throughout the proof we assume that $|x| \leq |y|$. Fix any $C'_0 > 0$, and let $x, y \in \mathbb{R}^d$ and t > 0 be such that $|x - y| \geq 2C'_0 t^{1/\alpha}$. Define $U = B(y, c_0 t^{1/\alpha})$ with $c_0 := C'_0/6$ (in particular, $c_0 t^{1/\alpha} = (2C'_0 t^{1/\alpha})/12 \leq |x - y|/12)$.

We first consider the case that $|y| \ge 3$. Set W = B(y, |x - y|/3). Since $|x - y| \ge 12c_0t^{1/\alpha}$, it holds that $U \subset W$. Hence, by (2.27),

$$p(t, x, y) = \mathbb{E}_y \left[\exp\left(-\int_0^{\tau_U} V(X_s) \, ds\right) p(t - \tau_U, X_{\tau_U}, x) \mathbb{1}_{\{\tau_U \le t\}} \right]$$
$$= \mathbb{E}_y \left[\exp\left(-\int_0^{\tau_U} V(X_s) \, ds\right) p(t - \tau_U, X_{\tau_U}, x) \mathbb{1}_{\{\tau_U \le t, X_{\tau_U} \in W \setminus U\}} \right]$$
$$+ \mathbb{E}_y \left[\exp\left(-\int_0^{\tau_U} V(X_s) \, ds\right) p(t - \tau_U, X_{\tau_U}, x) \mathbb{1}_{\{\tau_U \le t, X_{\tau_U} \notin W\}} \right]$$
$$=: I_1 + I_2.$$

By the inclusions $U \subset W \subset B(y, 2|y|/3)$ (the second one follows from $|x - y|/3 \leq (|x| + |y|)/3 \leq 2|y|/3$), (1.5) and (1.6), we have

(2.29)
$$\inf_{v \in U} V(v) \ge \inf_{v \in W} V(v) \ge \inf_{v \in B(y, 2|y|/3)} V(v) \ge c_1 g(|y|), \quad |y| \ge 3.$$

Therefore, by the Lévy system formula (2.15), (2.29) and the estimates

$$q_U(s, y, z) \le c_2 \left(s^{-d/\alpha} \wedge \frac{s}{|y - z|^{d+\alpha}} \right) \left(\frac{\delta_U(z)^{\alpha/2}}{\sqrt{s}} \wedge 1 \right), \quad 0 < s \le t, \ z \in U,$$
$$p(t - s, u, x) \le q(t - s, u, x) \le \frac{c_3 t}{|u - x|^{d+\alpha}} \le \frac{c_4 t}{|x - y|^{d+\alpha}}, \quad 0 < s \le t, \ u \in W$$

(cf. (2.16) and (1.4)), we get

$$I_{1} \leq c_{5} \int_{0}^{t} \int_{W \setminus U} \left(\int_{U} q_{U}(s, y, z) p(t - s, u, x) \frac{1}{|z - u|^{d + \alpha}} e^{-s \inf_{v \in U} V(v)} dz \right) du ds$$

$$\leq \frac{c_{6}t}{|x - y|^{d + \alpha}} \int_{0}^{t} \int_{W \setminus U} \int_{U} \left(s^{-d/\alpha} \wedge \frac{s}{|y - z|^{d + \alpha}} \right) \left(\frac{\delta_{U}(z)^{\alpha/2}}{\sqrt{s}} \wedge 1 \right) \frac{e^{-c_{1}sg(|y|)}}{|z - u|^{d + \alpha}} dz \, du \, ds$$

$$\leq \frac{c_6 t}{|x-y|^{d+\alpha}} \int_0^t \int_U \left(s^{-d/\alpha} \wedge \frac{s}{|y-z|^{d+\alpha}} \right) \left(\frac{\delta_U(z)^{\alpha/2}}{\sqrt{s}} \wedge 1 \right) e^{-c_1 s g(|y|)} \\ \times \int_{B(z,\delta_U(z))^c} \frac{1}{|z-u|^{d+\alpha}} \, du \, dz \, ds \\ \leq \frac{c_7 t}{|x-y|^{d+\alpha}} \int_0^t \int_U \left(s^{-d/\alpha} \wedge \frac{s}{|y-z|^{d+\alpha}} \right) \delta_U^{-\alpha}(z) \left(\frac{\delta_U(z)^{\alpha/2}}{\sqrt{s}} \wedge 1 \right) e^{-c_1 s g(|y|)} \, dz \, ds.$$

Take now $c_8 := c_0/4$. In particular, $\delta_U(z) \ge c_9 t^{1/\alpha}$ for all $z \in B(y, c_8 s^{1/\alpha})$, and the expression on the right hand side above is less or equal to the sum

$$\begin{aligned} &\frac{c_{10}t}{|x-y|^{d+\alpha}} \int_0^t \int_{B(y,c_8s^{1/\alpha})} s^{-d/\alpha} t^{-1} e^{-c_1 sg(|y|)} \, dz \, ds \\ &+ \frac{c_{10}t}{|x-y|^{d+\alpha}} \int_0^t \int_{B(y,c_0t^{1/\alpha}-c_8s^{1/\alpha}) \setminus B(y,c_8s^{1/\alpha})} \frac{s}{|y-z|^{d+\alpha}} \delta_U^{-\alpha}(z) e^{-c_1 sg(|y|)} \, dz \, ds \\ &+ \frac{c_{10}t}{|x-y|^{d+\alpha}} \int_0^t \int_{B(y,c_0t^{1/\alpha}) \setminus B(y,c_0t^{1/\alpha}-c_8s^{1/\alpha})} \frac{s}{|y-z|^{d+\alpha}} \frac{\delta_U^{-\alpha/2}(z)}{\sqrt{s}} e^{-c_1 sg(|y|)} \, dz \, ds \\ &=: I_{11} + I_{12} + I_{13}. \end{aligned}$$

It is clear that

$$I_{11} \le \frac{c_{11}}{|x-y|^{d+\alpha}} \int_0^t e^{-c_1 s g(|y|)} \, ds \le \frac{c_{12} t}{|x-y|^{d+\alpha}} \left(\frac{1}{t g(|y|)} \wedge 1\right).$$

On the other hand, for every $0 \le s \le t$,

$$\begin{split} &\int_{B(y,c_0t^{1/\alpha}-c_8s^{1/\alpha})\setminus B(y,c_8s^{1/\alpha})} \frac{\delta_U^{-\alpha}(z)}{|y-z|^{d+\alpha}} \, dz \\ &\leq c_{13} \int_{c_8s^{1/\alpha}}^{c_0t^{1/\alpha}-c_8s^{1/\alpha}} r^{-1-\alpha} (c_0t^{1/\alpha}-r)^{-\alpha} \, dr \\ &\leq c_{14}t^{-1} \int_{c_8s^{1/\alpha}}^{c_0t^{1/\alpha}/3} r^{-1-\alpha} \, dr + c_{15}t^{-(1+\alpha)/\alpha} \int_{c_0t^{1/\alpha}/3}^{c_0t^{1/\alpha}-c_8s^{1/\alpha}} (c_0t^{1/\alpha}-r)^{-\alpha} \, dr \\ &\leq \frac{c_{15}}{ts} + \frac{c_{16}}{t^{(1+\alpha)/\alpha}} \left[t^{(1-\alpha)/\alpha} \mathbbm{1}_{\{\alpha\in(0,1)\}} + \log\left(1+\frac{t}{s}\right) \mathbbm{1}_{\{\alpha=1\}} + s^{(1-\alpha)/\alpha} \mathbbm{1}_{\{\alpha\in(1,2)\}} \right] \\ &\leq \frac{c_{17}}{t} \left[\frac{1}{s} + \frac{1}{t} \mathbbm{1}_{\{\alpha\in(0,1)\}} + \frac{1}{t} \log\left(1+\frac{t}{s}\right) \mathbbm{1}_{\{\alpha=1\}} + \left(\frac{s}{t}\right)^{1/\alpha} \frac{1}{s} \mathbbm{1}_{\{\alpha\in(1,2)\}} \right] \leq \frac{c_{18}}{ts}, \end{split}$$

where in the first inequality above we have used the spherical coordinates in $B(y, c_0 t^{1/\alpha})$. This yields

$$I_{12} \le \frac{c_{19}}{|x-y|^{d+\alpha}} \int_0^t e^{-c_1 s g(|y|)} \, ds \le \frac{c_{20} t}{|x-y|^{d+\alpha}} \left(1 \wedge \frac{1}{tg(|y|)} \right).$$

Furthermore, we have for every $0 \le s \le t$,

$$\int_{B(y,c_0t^{1/\alpha})\setminus B(y,c_0t^{1/\alpha}-c_8s^{1/\alpha})} \frac{\delta_U^{-\alpha/2}(z)}{|y-z|^{d+\alpha}} dz
\leq c_{21}t^{-1-d/\alpha} \int_{B(y,c_0t^{1/\alpha})\setminus B(y,c_0t^{1/\alpha}-c_8s^{1/\alpha})} \delta_U^{-\alpha/2}(z) dz
\leq c_{22}t^{-1-d/\alpha} \int_{c_0t^{1/\alpha}-c_8s^{1/\alpha}}^{c_0t^{1/\alpha}} (c_0t^{1/\alpha}-r)^{-\alpha/2}r^{d-1} dr
\leq c_{23}t^{-1-1/\alpha}s^{1/\alpha-1/2} \leq c_{23}t^{-1}s^{-1/2}.$$

This gives us that

$$I_{13} \le \frac{c_{24}}{|x-y|^{d+\alpha}} \int_0^t e^{-c_1 s g(|y|)} \, ds \le \frac{c_{25} t}{|x-y|^{d+\alpha}} \left(1 \wedge \frac{1}{tg(|y|)} \right).$$

Combining with all estimates above, we arrive at

$$I_1 \le \frac{c_{26}t}{|x-y|^{d+\alpha}} \left(1 \wedge \frac{1}{tg(|y|)}\right).$$

According to the Lévy system formula (2.15) and (2.29), we get

$$\begin{split} I_{2} &\leq \int_{0}^{t} \int_{W^{c}} \int_{U} q_{U}(s, y, z) p(t - s, u, x) \frac{1}{|z - u|^{d + \alpha}} e^{-s \inf_{U} V} \, dz \, du \, ds \\ &\leq \frac{c_{27}}{|x - y|^{d + \alpha}} \int_{0}^{t} \left(\int_{U} q_{U}(s, y, z) \, dz \right) \left(\int_{\mathbb{R}^{d}} p(t - s, u, x) \, du \right) e^{-c_{28} sg(|y|)} \, ds \\ &\leq \frac{c_{29} t}{|x - y|^{d + \alpha}} \left(1 \wedge \frac{1}{tg(|y|)} \right), \end{split}$$

where in the second inequality we used the fact that for $z \in U$ and $u \in W^c$,

$$|z - u| \ge |u - y| - |y - z| \ge |x - y|/3 - c_0 t^{1/\alpha} \ge |x - y|/3 - |x - y|/12 = |x - y|/4.$$

Therefore, we have proved (2.28) for the case $|y| \ge 3$.

When $|y| \leq 3$, the condition $|x - y| \geq 2C'_0 t^{1/\alpha}$ implies that

$$t \le \left(\frac{|x-y|}{2C'_0}\right)^{\alpha} \le c_{30}(|x|+|y|)^{\alpha} \le 2^{\alpha}c_{30}|y|^{\alpha} \le c_{31},$$

and so

$$p(t, x, y) \le q(t, x, y) \le \frac{c_{32}t}{|x - y|^{d + \alpha}} \le \frac{c_{33}t}{|x - y|^{d + \alpha}} \left(1 \land \frac{1}{tg(|y|)}\right).$$

The proof is finished.

3. Two-sided estimates when
$$0 < t \le C'_0 t_0(|x| \land |y|)$$
 for any $C'_0 > 0$

Throughout this section, without loss of generality, we assume that $x, y \in \mathbb{R}^d$ are such that $|x| \leq |y|$. We begin with the following statement for $x, y \in \mathbb{R}^d$ with $|x - y| \leq C'_1 t^{1/\alpha}$.

Lemma 3.1. For any $C'_0, C'_1 > 0$ there exist positive constants C_1, \ldots, C_4 such that for all $x, y \in \mathbb{R}^d$ and $0 < t \le C'_0 t_0(|x|)$ with $|x - y| \le C'_1 t^{1/\alpha}$,

(3.30)
$$C_1 t^{-d/\alpha} e^{-C_2 tg(|x|)} \le p(t, x, y) \le C_3 t^{-d/\alpha} e^{-C_4 tg(|x|)}.$$

Proof. Suppose that $x, y \in \mathbb{R}^d$ and $0 < t \le C'_0 t_0(|x|)$ are such that $|x - y| \le C'_1 t^{1/\alpha}$. Then,

(3.31)
$$p(t, x, y) = \int_{\mathbb{R}^d} p(t/2, x, z) p(t/2, z, y) \, dz \le c_1 t^{-d/\alpha} \int_{\mathbb{R}^d} p(t/2, x, z) \, dz$$
$$= c_1 t^{-d/\alpha} T_{t/2}^V \mathbf{1}(x) \le c_2 t^{-d/\alpha} e^{-c_3 t g(|x|)},$$

where in the last inequality we used (2.26).

On the other hand, since $|x - y| \leq C'_1 t^{1/\alpha}$, $y \in B(x, C'_1 t^{1/\alpha})$. Take $U := B(x, 3C'_1 t^{1/\alpha})$ and $f \in C_b(\mathbb{R}^d)$ with $\operatorname{supp}[f] \subset B(x, 2C'_1 t^{1/\alpha})$. We have

$$T_t^V f(x) = \mathbb{E}_x \left[f(X_t) \exp\left(-\int_0^t V(X_s) \, ds\right) \right] \ge \mathbb{E}_x \left[f(X_t) \exp\left(-\int_0^t V(X_s) \, ds\right) \mathbb{1}_{\{\tau_U > t\}} \right] \\ \ge e^{-t \sup_{z \in U} V(z)} \mathbb{E}_x \left[f(X_t) \mathbb{1}_{\{\tau_U > t\}} \right] \ge e^{-c_4 tg(|x|)} \int_{B(x, 2C_1' t^{1/\alpha})} q_U(t, x, z) f(z) \, dz \\ \ge c_5 t^{-d/\alpha} e^{-c_4 tg(|x|)} \int_{B(x, 2C_1' t^{1/\alpha})} f(z) \, dz = c_5 t^{-d/\alpha} e^{-c_4 tg(|x|)} \|f\|_1.$$

Here in the third inequality we used the fact that

(3.32)
$$\sup_{z \in B(x, 3C'_0 t^{1/\alpha})} V(z) \le \sup_{z \in B(x, c_6(1+|x|))} V(z) \le c_7 g(|x|),$$

which is due to that $0 < t \le t_0(|x|) \le c_8(1+|x|)^{\alpha}$ (that can be verified by (2.19)), and the fourth inequality follows from (2.16). Since f is arbitrary, the inequality above yields that

$$p(t, x, y) \ge c_5 t^{-d/\alpha} e^{-c_4 t g(|x|)}$$

Therefore, the proof of (3.30) is completed.

Lemma 3.2. For any $C'_0, C'_1 > 0$ there exist positive constants C_5 and C_6 such that for $x, y \in \mathbb{R}^d$ and $0 < t \leq C'_0 t_0(|x|)$ with $|x - y| > C'_1 t^{1/\alpha}$,

(3.33)
$$p(t,x,y) \ge C_5 \left(\frac{1}{tg(|y|)} \land 1\right) e^{-C_6 tg(|x|)} \frac{t}{|x-y|^{d+\alpha}}.$$

Proof. Recall that $|x| \leq |y|$. Let $U = B(y, c_0 t^{1/\alpha})$ and $W = B(x, c_0 t^{1/\alpha})$ with $c_0 := C'_1/4$. Since $C'_1 t^{1/\alpha} < |x-y| \leq 2|y|$, we have $c_0 t^{1/\alpha} < |y|/2$. Consequently,

(3.34)
$$\sup_{z \in U} V(z) \le \sup_{z \in B(y, |y|/2)} V(z) \le c_1 g(|y|).$$

According to (2.27), the Lévy system formula (2.15), (3.30), (3.34) and the fact that

$$|z - u| \le |x - y| + |z - x| + |u - y| \le |x - y| + 2c_0 t^{1/\alpha} \le c_2 |x - y|, \quad z \in W, \ u \in U,$$

we have

$$\begin{split} p(t,y,x) = & \mathbb{E}_{y} \left[p(t-\tau_{U}, X_{\tau_{U}}, x) \mathbb{1}_{\{\tau_{U} \leq t\}} \exp\left(-\int_{0}^{\tau_{U}} V(X_{s}) \, ds\right) \right] \\ \geq & \mathbb{E}_{y} \left[p(t-\tau_{U}, X_{\tau_{U}}, x) e^{-\int_{0}^{\tau_{U}} V(X_{s}) \, ds} \mathbb{1}_{\{\tau_{U} \leq t/2, X_{\tau_{U}} \in W\}} \right] \\ \geq & c_{3} \left(\inf_{\substack{t/2 \leq s \leq t \\ z \in W}} p(s, z, x) \right) \int_{0}^{t/2} \int_{U} \int_{W} q_{U}(s, y, z) \frac{1}{|z-u|^{d+\alpha}} e^{-c_{1}sg(|y|)} \, dz \, du \, ds \\ \geq & c_{4}e^{-c_{5}tg(|x|)}t^{-d/\alpha} \frac{|W|}{|x-y|^{d+\alpha}} \int_{0}^{t/2} \int_{U} q_{U}(s, y, z) \, dz e^{-c_{1}sg(|y|)} \, ds \\ \geq & c_{6}e^{-c_{5}tg(|x|)} \frac{1}{|x-y|^{d+\alpha}} \int_{0}^{t/2} \mathbb{P}_{y}(\tau_{B(y,c_{0}t^{1/\alpha})} > t/2)e^{-c_{1}sg(|y|)} \, ds \\ \geq & c_{7}e^{-c_{5}tg(|x|)} \frac{1}{|x-y|^{d+\alpha}} \left(\frac{1}{g(|y|)} \wedge t\right) \\ = & c_{7} \left(\frac{1}{tg(|y|)} \wedge 1\right) e^{-c_{5}tg(|x|)} \frac{t}{|x-y|^{d+\alpha}}. \end{split}$$

Here we also used the property

$$\mathbb{P}_{y}(\tau_{B(y,c_{0}t^{1/\alpha})} > t) = \mathbb{P}_{0}(\tau_{B(0,c_{0}t^{1/\alpha})} > t) \ge c_{8} > 0$$

which can be verified directly by (2.16). Hence, the conclusion (3.33) follows.

Lemma 3.3. For any $C'_0, C'_1 > 0$ there exist positive constants C_7, C_8 such that for $x, y \in \mathbb{R}^d$ and $0 < t \leq C'_0 t_0(|x|)$ with $|x - y| > C'_1 t^{1/\alpha}$,

(3.35)
$$p(t, x, y) \le C_7 \left(\frac{1}{tg(|y|)} \land 1\right) e^{-C_8 tg(|x|)} \frac{t}{|x - y|^{d + \alpha}}$$

Proof. Recall we assume that $|x| \le |y|$. The proof is split into two cases. **Case 1:** $|y - x| \le |y|/4$. In particular, $|x| \ge |y| - |y - x| \ge |y|/2$. We write

$$\begin{split} p(t,x,y) &= \int_{\{|z-y| \leq |x-y|/2\}} p(t/2,x,z) p(t/2,z,y) \, dz + \int_{\{|z-y| \geq |x-y|/2\}} p(t/2,x,z) p(t/2,z,y) \, dz \\ &=: I_1 + I_2. \end{split}$$

When $|y-z| \le |x-y|/2$, we have $|z-x| \ge |x-y| - |y-z| \ge |x-y|/2 \ge C'_1 t^{1/\alpha}/2$ and $|z| \ge |y| - |y-z| \ge |y| - |x-y|/2 \ge |y| - |y|/8 \ge 7|y|/8$. Then, according to (2.28) and (1.5),

$$p(t/2, x, z) \le c_1 \left(\frac{1}{t \max\{g(|x|), g(|z|)\}} \land 1 \right) \frac{t}{|x - z|^{d + \alpha}} \le c_2 \left(\frac{1}{tg(|y|)} \land 1 \right) \frac{t}{|x - y|^{d + \alpha}}$$

If any $0 \le t \le C' t_2(|x|)$ it holds that

So for any $0 < t \le C'_0 t_0(|x|)$ it holds that

$$I_{1} \leq c_{2} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} \int_{\mathbb{R}^{d}} p(t/2, z, y) dz$$
$$\leq c_{3} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} \left(e^{-c_{4}tg(|y|)} + \frac{t}{(1+|y|)^{\alpha}}\right)$$
$$\leq c_{5} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} \left(e^{-c_{6}tg(|x|)} + \frac{t}{(1+|x|)^{\alpha}}\right)$$
$$\leq c_{7} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} e^{-c_{8}tg(|x|)},$$

where the second inequality follows from (2.21), in the third inequality we have used the fact $|x| \leq |y|$, and the last inequality is due to the fact $0 < t \leq C'_0 t_0(|x|)$ and (2.25).

Similarly, by (2.28), for every $z, y \in \mathbb{R}^d$ with $|z - y| \ge |x - y|/2 \ge C'_1 t^{1/\alpha}/2$,

$$p(t/2, z, y) \le c_9 \left(\frac{1}{t \max\{g(|y|), g(|z|)\}} \land 1\right) \frac{t}{|z - y|^{d + \alpha}} \le c_{10} \left(\frac{1}{tg(|y|)} \land 1\right) \frac{t}{|x - y|^{d + \alpha}}$$

Hence, due to (2.26), it holds that for every $0 < t \le C_0 t_0(|x|)$,

$$I_2 \leq c_{10} \left(\frac{1}{tg(|y|)} \land 1\right) \frac{t}{|x-y|^{d+\alpha}} \int_{\mathbb{R}^d} p(t/2, x, z) \, dz \leq c_{11} \left(\frac{1}{tg(|y|)} \land 1\right) \frac{t}{|x-y|^{d+\alpha}} e^{-c_{12}tg(|x|)}.$$

Therefore, putting all the estimates above for I_1 and I_2 together yields

$$p(t, x, y) \le c_{13} \left(\frac{1}{tg(|y|)} \land 1 \right) \frac{t}{|x - y|^{d + \alpha}} e^{-c_{14}tg(|x|)}$$

Case 2: |y-x| > |y|/4. Since we assume that $|x| \le |y|$, it holds that $|y|/4 \le |y-x| \le |y| + |x| \le 2|y|$. Then, we set

$$p(t, x, y) = \int_{\{|z-y| \le |y|/16\}} p(t/2, x, z) p(t/2, z, y) \, dz + \int_{\{|z-y| \ge |y|/16\}} p(t/2, x, z) p(t/2, z, y) \, dz$$

=: $J_1 + J_2$.

When $|z-y| \le |y|/16$, we have $|z-x| \ge |x-y| - |y-z| \ge |x-y| - |y|/16 \ge |x-y| - |x-y|/4 \ge 3|x-y|/4 \ge 3C'_1 t^{1/\alpha}/4$ and $|z| \ge |y| - |z-y| \ge |y|/2$. Then, according to (2.28) and (1.5),

$$p(t/2, z, x) \le c_{15} \left(\frac{1}{t \max\{g(|x|), g(|z|)\}} \land 1 \right) \frac{t}{|x - z|^{d + \alpha}} \le c_{16} \left(\frac{1}{tg(|y|)} \land 1 \right) \frac{t}{|x - y|^{d + \alpha}}$$

Thus, following the argument for I_1 and using (2.26), we find that

$$J_1 \leq c_{16} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} \int_{\mathbb{R}^d} p(t/2, z, y) \, dz \leq c_{17} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} e^{-c_{18}tg(|x|)}.$$

Note that, when $|z-y| \ge |y|/16$, $|z-y| \ge |x-y|/32 \ge C'_1 t^{1/\alpha}/32$. Hence, according to (2.28), in this case we have

$$p(t/2, z, y) \le c_{19} \left(\frac{1}{t \max\{g(|z|), g(|y|)\}} \land 1 \right) \frac{t}{|z - y|^{d + \alpha}} \le c_{20} \left(\frac{1}{tg(|y|)} \land 1 \right) \frac{t}{|x - y|^{d + \alpha}}$$

Then, applying (2.26) again, we deduce that

$$J_2 \leq c_{20} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} \int_{\mathbb{R}^d} p(t/2, x, z) \, dz \leq c_{21} \left(\frac{1}{tg(|y|)} \wedge 1\right) \frac{t}{|x-y|^{d+\alpha}} e^{-c_{22}tg(|x|)}.$$

Putting the estimates for J_1 and J_2 together, we arrive at

$$p(t, x, y) \le c_{23} \left(\frac{1}{tg(|y|)} \land 1 \right) \frac{t}{|x - y|^{d + \alpha}} e^{-c_{24}tg(|x|)}$$

Therefore, the assertion follows.

Now we can summarise the results in this section as follows.

Proposition 3.4. For any $C'_0 > 0$ there exist positive constants C_9, \ldots, C_{12} such that for all $x, y \in \mathbb{R}^d$ with $0 < t \leq C'_0 t_0(|x|)$,

(3.36)
$$C_{9}\left(\frac{1}{tg(|y|)} \wedge 1\right) e^{-C_{10}tg(|x|)} \left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \leq p(t,x,y) \\ \leq C_{11}\left(\frac{1}{tg(|y|)} \wedge 1\right) e^{-C_{12}tg(|x|)} \left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right).$$

Proof. Let $C'_1 > 0$. When $x, y \in \mathbb{R}^d$ and $0 < t \leq C'_0 t_0(|x|)$ are such that $|x - y| \geq C'_1 t^{1/\alpha}$, the assertion follows directly from Lemmas 3.2 and 3.3. On the other hand, by Lemma 3.1, for all $x, y \in \mathbb{R}^d$ with $|x - y| \leq C'_1 t^{1/\alpha}$ and $0 < t \leq C'_0 t_0(|x|)$,

$$p(t, x, y) \ge c_1 e^{-c_2 t g(|x|)} t^{-d/\alpha} \ge c_1 \left(\frac{1}{tg(|y|)} \land 1\right) e^{-c_2 tg(|x|)} t^{-d/\alpha}$$

Furthermore, for all $x, y \in \mathbb{R}^d$ with $|x - y| \leq C'_1 t^{1/\alpha}$,

(3.37)
$$g(|x|) \le g(|y|) \le g(|x| + |x - y|) \le g(|x| + C_1' t^{1/\alpha}) \\ \le g(|x| + C_1' C_0'^{1/\alpha} t_0(|x|)^{1/\alpha}) \le g(c_3(1 + |x|)) \le c_4 g(|x|),$$

and so

(3.38)
$$\frac{1}{tg(|y|)} \wedge 1 \ge c_5 \left(\frac{1}{tg(|x|)} \wedge 1\right) \ge c_6 e^{-c_7 tg(|x|)},$$

where we used the monotonicity of $g(\cdot)$ and the fact that $t_0(|x|)^{1/\alpha} \leq c_8(1+|x|)$. Thus, using (3.38) and Lemma 3.1 again, we obtain that for all $x, y \in \mathbb{R}^d$ with $|x - y| \leq C'_1 t^{1/\alpha}$ and $0 < t \leq C'_0 t_0(|x|)$,

$$p(t, x, y) \le c_9 t^{-d/\alpha} e^{-c_{10} t g(|x|)} \le c_{11} t^{-d/\alpha} \left(\frac{1}{t g(|y|)} \wedge 1\right) e^{-c_{12} t g(|x|)}.$$

Putting all estimates above together yields the desired assertion (3.36).

4. Two-sided estimates when $t \ge C_0 t_0(|x| \land |y|)$ for some $C_0 > 0$

In this section, we will present two-sided estimates of p(t, x, y) when $t > C_0 t_0(|x| \wedge |y|)$ for some properly chosen constant $C_0 > 0$. The statements are split into two parts, according to two different almost monotonicity properties of $t_0(\cdot)$. Without loss of generality, we still assume that $|x| \leq |y|$. Recall that

$$H(x) := \frac{1}{g(|x|)(1+|x|)^{d+\alpha}}, \quad x \in \mathbb{R}^d.$$

We first give a lemma for a rough upper bound of the heat kernel p(t, x, y) when $t > C_0 t_0(|x|)$ for some $C_0 > 0$.

Lemma 4.1. There exist $N_1, C_1 > 0$ such that for all $z, u \in \mathbb{R}^d$ and t > 0 with $t > N_1C_5t_0(|z|)$, (4.39) $p(t, z, u) \leq C_1H(z)$,

where $C_5 > 0$ is the constant given in Corollary 2.5.

Proof. Let $R_0 > 0$. For every $|z| \leq R_0$ and $t > C_5 t_0(|z|)$, we have $t \geq c_1$ by (2.19), and so

$$p(t, z, u) \le c_2 t^{-d/\alpha} \le \frac{c_3}{g(|z|)(1+|z|)^{d+\alpha}}, \quad z, u \in \mathbb{R}^d \text{ with } |z| \le R_0, \ t > C_5 t_0(|z|).$$

Here $C_5 > 0$ is the constant from Corollary 2.5. Next, we prove (4.39) for every $|z| > R_0$ with R_0 large enough so that

$$\inf_{|z|>R_0} \left(|z|^{\alpha} - C_5 t_0(|z|) \right) > 0;$$

we note that such R_0 can be found due to (2.19).

For $C_5 t_0(|z|) \le t \le |z|^{\alpha}$,

$$p(2t, z, u) \leq \begin{cases} \int_{\mathbb{R}^d} p(t, z, w) p(t, w, u) \, dw, & |u| \geq |z|/4 \\ c_4 \left(\frac{1}{tg(|z|)} \wedge 1\right) \frac{t}{|z-u|^{d+\alpha}}, & |u| < |z|/4 \end{cases}$$

$$(4.40) \leq \begin{cases} c_5 t^{-d/\alpha} \int_{\mathbb{R}^d} p(t, z, w) \, dw, & |u| \geq |z|/4 \\ \frac{c_4}{g(|z|)(1+|z|)^{d+\alpha}}, & |u| < |z|/4 \end{cases}$$

$$\leq \begin{cases} c_6 (1+|z|)^{dq_1/\alpha} (1+|z|)^{-\alpha/2}, & |u| \geq |z|/4 \\ \frac{c_6}{g(|z|)(1+|z|)^{d+\alpha}}, & |u| < |z|/4 \end{cases}$$

$$\leq \frac{c_7}{g(|z|)(1+|z|)^{d+\alpha}} \left(1 + (1+|z|)^{dq_1/\alpha + d + \alpha + q_1 - \alpha/2}\right)$$

Here in the first inequality we have used Lemma 2.8 and the fact that $|z - u| \ge |z|/2 \ge t^{1/\alpha}/2$ for every |u| < |z|/4 and $t \le |z|^{\alpha}$, the third inequality follows from (2.22), and the fact $t > C_5 t_0(|z|) \ge c_8(1+|z|)^{-q_1}$ (which has been established by (2.19)), and the last inequality is due to (2.18).

Furthermore, according to (4.40), we get

$$\begin{split} p(3t,z,u) &\leq \begin{cases} \int_{\mathbb{R}^d} p(2t,z,w) p(t,w,u) \, dw, & |u| \geq |z|/4\\ c_9 \left(\frac{1}{tg(|z|)} \wedge 1\right) \frac{t}{|z-u|^{d+\alpha}}, & |u| < |z|/4\\ &\leq c_{10} \begin{cases} \frac{(1+(1+|z|)^{dq_1/\alpha+d+\alpha+q_1-\alpha/2})}{g(|z|)(1+|z|)^{d+\alpha}} \int_{\mathbb{R}^d} p(t,w,u) \, dw, & |u| \geq |z|/4\\ \frac{1}{g(|z|)(1+|z|)^{d+\alpha}}, & |u| < |z|/4 \end{cases} \\ &\leq c_{11} \begin{cases} \frac{1}{g(|z|)(1+|z|)^{d+\alpha}} (1+(1+|z|)^{dq_1/\alpha+d+\alpha+q_1-\alpha}), & |u| \geq |z|/4\\ \frac{1}{g(|z|)(1+|z|)^{d+\alpha}}, & |u| < |z|/4 \end{cases} \\ &\leq \frac{c_{12}}{g(|z|)(1+|z|)^{d+\alpha}} \left(1+(1+|z|)^{dq_1/\alpha+d+\alpha+q_1-\alpha}\right), \end{cases} \end{split}$$

where in the first inequality we used Lemma 2.8 (similarly as in the proof of the first inequality in (4.40)), the second inequality follows from (4.40), and the third inequality is due to the fact that for all $|u| \ge |z|/4$ and $C_5 t_0(|z|) \le t \le |z|^{\alpha}$,

$$\int_{\mathbb{R}^d} p(t, w, u) \, dw = T_t^V \mathbf{1}(u) = T_{C_5 t_0(|z|)} \left(T_{t-C_5 t_0(|z|)} \mathbf{1} \right) (u) \le T_{C_5 t_0(|z|)} \mathbf{1}(u)$$
$$\le c_{13} \left[\exp(-c_{14}C_5 t_0(|z|)g(|u|)) + \frac{C_5 t_0(|z|)}{(1+|u|)^{\alpha}} \right]$$
$$\le c_{15} \left[\exp(-c_{16}C_5 t_0(|z|)g(|z|)) + \frac{C_5 t_0(|z|)}{(1+|z|)^{\alpha}} \right] \le c_{17} (1+|z|)^{-\alpha/2}$$

thanks to (2.21) and the arguments used for (2.24) (note that one can take the constant C_5 large enough to ensure the procedure in (2.24)).

Now, by repeating the procedure above for N_1 times, where $dq_1/\alpha + d + \alpha + q_1 - (N_1 - 1)\alpha/2 < 0$, we obtain that

(4.41)
$$p(N_1t, z, u) \le \frac{c_{18}}{g(|z|)(1+|z|)^{d+\alpha}}, \quad C_5t_0(|z|) \le t \le |z|^{\alpha}.$$

Hence, for any $N_1|z|^{\alpha} \ge t \ge N_1C_5t_0(|z|)$, we can find $t_1 \in [C_5t_0(|z|), |z|^{\alpha}]$ such that $t = N_1t_1$. Then, by (4.41),

$$p(t, z, u) = p(N_1 t_1, z, u) \le \frac{c_{18}}{g(|z|)(1+|z|)^{d+\alpha}}.$$

On the other hand, for any $t > N_1 |z|^{\alpha}$,

$$p(t, z, u) = \int_{\mathbb{R}^d} p(N_1 | z|^{\alpha}, z, w) p(t - N_1 | z|^{\alpha}, w, u) \, dw$$

$$\leq \frac{c_{19}}{g(|z|)(1 + |z|)^{d + \alpha}} \cdot \int_{\mathbb{R}^d} p(t - N_1 | z|^{\alpha}, w, u) \, dw$$

$$\leq \frac{c_{20}}{g(|z|)(1 + |z|)^{d + \alpha}} = c_{20} H(z).$$

The proof is complete.

4.1. $t_0(\cdot)$ is almost decreasing. In this subsection, we always assume that $t_0(\cdot)$ is almost decreasing, i.e., there is a continuous and strictly decreasing function $h : [0, \infty) \to (0, \infty)$ such that (1.8) is satisfied. Define

$$s_0(t) = h^{-1}(t) \lor 2, \quad t \ge 0,$$

where $h^{-1}(t) := \inf\{s \ge 0 : h(s) \le t\}$ and here we use the convention that $\inf \emptyset = -\infty$. Below, set $T_0 := h(2) > 0$ and $T_{\infty} := h(\infty) = \lim_{s \to \infty} h(s) \ge 0$. As $h(\cdot)$ is continuous and strictly decreasing, it is easy to verify that

(4.42)
$$s_0(t) = h^{-1}(t) \ge 2 \text{ for } t \in (T_\infty, T_0];$$

moreover, for every $t \in (T_0, \infty)$, and for every $t \in (0, T_\infty]$ when $T_\infty > 0$, it holds that $s_0(t) = 2$.

Lemma 4.2. For every sufficiently large $C_0 > 0$ there are constants $C_2, C_3 > 0$ such that for all $x, y \in \mathbb{R}^d$ and $C_0h(|x|) < t \leq C_0T_0$, it holds that

(4.43)
$$p(t, x, y) \ge C_2 H(x) H(y) \int_{\{|z| \le s_0(t)\}} e^{-C_3 t g(|z|)} dz$$

Proof. Let $C_0 \ge C_{**}$, where C_{**} is the constant in (1.8), and assume first that $C_0h(|x|) < t \le T_0$. We have

$$T_0 = h(2) \ge t > C_0 h(|x|) \ge C_0 C_{**}^{-1} h(|x|/2) \ge h(|x|/2) > h(\infty) = T_{\infty}.$$

This, along with (4.42) and the fact that $h(\cdot)$ is continuous and strictly decreasing, yields that $|x| \ge 2h^{-1}(t) = 2s_0(t) \ge 4$ for every $C_0h(|x|) < t \le T_0$. On the other hand, for every $T_{\infty} < t \le T_0$ and $z \in \mathbb{R}^d$ with $|z| \le s_0(t)$, by (1.8) and (4.42), it holds that

(4.44)
$$t_0(|z|) \ge c_1 h(|z|) \ge c_1 h(s_0(t)) = c_1 t.$$

Hence, according to (3.36) and (4.44), for every $z \in \mathbb{R}^d$ with $|z| \leq s_0(t)$ (also by noting here that $|z| \leq |x|/2 \leq |y|/2$ since $|x| \geq 2s_0(t)$)

$$p(t/2, z, x) \ge c_2 \left(\frac{1}{tg(|x|)} \land 1\right) e^{-c_3 tg(|z|)} \frac{t}{|z - x|^{d + \alpha}} \ge \frac{c_4}{g(|x|)} e^{-c_3 tg(|z|)} \frac{1}{(1 + |x|)^{d + \alpha}},$$

where we used the facts that for all $C_0h(|x|) < t \leq T_0$,

$$c_5 t^{1/\alpha} \le 2 \le s_0(t) \le |x|/2 \le |z-x| \le c_6(1+|x|), \quad |x| \ge 2s_0(t) \text{ and } |z| \le s_0(t)$$

and

(4.45)
$$tg(|x|) \ge c_7 t_0(|x|)g(|x|) \ge c_8,$$

thanks to (1.7) (see the second to last line in the proof of Lemma 2.3).

Since $|y| \ge |x| \ge 2s_0(t)$, similarly we can obtain that for every $z \in \mathbb{R}^d$ with $|z| \le s_0(t)$,

$$p(t/2, z, y) \ge c_9 \left(\frac{1}{tg(|y|)} \land 1\right) e^{-c_{10}tg(|z|)} \frac{t}{|y-z|^{d+\alpha}} \ge \frac{c_{11}}{g(|y|)} e^{-c_{12}tg(|z|)} \frac{1}{(1+|y|)^{d+\alpha}}.$$

Therefore, for all $C_0h(|x|) \le t \le T_0$,

$$p(t, x, y) \ge \int_{\{|z| \le s_0(t)\}} p(t/2, x, z) p(t/2, z, y) dz$$
$$\ge \frac{c_{13}}{g(|x|)g(|y|)(1+|x|)^{d+\alpha}(1+|y|)^{d+\alpha}} \int_{\{|z| \le s_0(t)\}} e^{-c_{14}tg(|z|)} dz,$$

which is the claimed estimate.

Suppose now that $t > C_0h(|x|)$ and $T_0 < t \le C_0T_0$. Since $s_0(t) = 2$ for this range of t, we can follow the argument above to show the same estimate when $|y| \ge |x| \ge 4 = 2s_0(t)$. When |x| < 4 and $|y| \ge |x|$, by the fact $t \le C_0T_0 \le c_{15}t_0(|x|)$ (since |x| < 4), we can directly apply (3.36) to obtain

$$p(t, x, y) \ge c_{16} \left(\frac{1}{tg(|y|)} \wedge 1\right) e^{-c_{17}tg(|x|)} \left(t^{-d/\alpha} \wedge \frac{t}{|x - y|^{d+\alpha}}\right)$$
$$\ge \frac{c_{18}}{g(|x|)g(|y|)(1 + |x|)^{d+\alpha}(1 + |y|)^{d+\alpha}}$$
$$\ge \frac{c_{18}}{g(|x|)g(|y|)(1 + |x|)^{d+\alpha}(1 + |y|)^{d+\alpha}} \int_{\{|z| \le s_0(t)\}} e^{-c_{17}tg(|z|)} dz$$

Here in the second inequality we have used the facts

$$g(|x|) \asymp (1+|x|) \asymp 1, \quad |x| \le 4$$

and

$$\left(t^{-d/\alpha} \wedge \frac{t}{|x-y|^{d+\alpha}}\right) \ge c_{20}(1+|y|)^{-d-\alpha}, \quad T_0 < t \le C_0 T_0, \ |y| \ge |x|, \ |x| \le 4,$$

and the last inequality is due to the property

$$\int_{\{|z| \le s_0(t)\}} e^{-c_{17}tg(|z|)} dz = \int_{\{|z| \le 2\}} e^{-c_{17}tg(|z|)} dz \le c_{21}, \quad T_0 < t \le C_0 T_0.$$

By now the proof of (4.43) is complete.

Lemma 4.3. For sufficiently large $C_0 > 0$ there are constants C_4, C_5, C_6 such that for every $C_0h(|x|) < t \leq C_0T_0$,

(4.46)
$$p(t, x, y) \le C_4 H(x) H(y) \int_{\{|z| \le s_0(C_5 t)\}} e^{-C_6 t g(|z|)} dz$$

Proof. According to (1.8), (2.22) and (4.39), there exists a constant $\tilde{C}_0 > 1$ such that

(4.47)
$$T_t^V 1(z) \le c_1 (1+|z|)^{-\alpha/2}, \quad z \in \mathbb{R}^d, \ t > 0 \text{ with } t \ge \tilde{C}_0 h(|z|)$$

and

(4.48)
$$p(t,z,u) \le c_1 H(z), \quad u,z \in \mathbb{R}^d, \ t > 0 \text{ with } t \ge \tilde{C}_0 h(|z|).$$

Furthermore, by (1.8) and the fact that $h(\cdot)$ is continuous and strictly decreasing, as well as that $s_0(t) = h^{-1}(t)$ when $T_{\infty} \leq h(|x|) < t \leq T_0$, we obtain that for all $\tilde{C}_0 h(|x|) < t \leq \tilde{C}_0 T_0$ the following properties hold:

(4.49)
$$t \leq \tilde{C}_0 h(|z|), \quad z \in \mathbb{R}^d \text{ with } |z| \leq s_0 \left(\frac{t}{\tilde{C}_0}\right) =: \tilde{s}_0(t),$$
$$t > \tilde{C}_0 h(|z|), \quad z \in \mathbb{R}^d \text{ with } |z| > s_0 \left(\frac{t}{\tilde{C}_0}\right) =: \tilde{s}_0(t).$$

Now, for every $\tilde{C}_0 h(|x|) < t \leq \tilde{C}_0 T_0$ and $|z| > \tilde{s}_0(t)$,

(4.50)

$$p(2t, z, u) = \int_{\mathbb{R}^d} p(t, z, w) p(t, w, u) \, dw$$

$$\leq c_2 H(z) T_t^V 1(u)$$

$$\leq c_3 H(z) \begin{cases} e^{-c_4 tg(|u|)}, & |u| \leq \tilde{s}_0(t) \\ (1+|u|)^{-\alpha/2}, & |u| > \tilde{s}_0(t), \end{cases}$$

where we have used (2.26), (4.47), (4.48) and (4.49). In the same way, we can obtain that for every $c_5 \ge 2$, $\tilde{C}_0 h(|x|) < t \le \tilde{C}_0 T_0$, $|z| > \tilde{s}_0(t)$ and $|u| \le \tilde{s}_0(t)$,

(4.51)
$$p(c_5t, z, u) = \int_{\mathbb{R}^d} p((c_5 - 1)t, z, w) p(t, w, u) \, dw \le c_6 H(z) e^{-c_4 t g(|u|)}$$

For any $\tilde{C}_0 h(|x|) < t \leq \tilde{C}_0 T_0$ and $z, u \in \mathbb{R}^d$ with $|z| \geq \tilde{s}_0(t)$ and $|u| \geq \tilde{s}_0(t)$, we write

$$\begin{aligned} p(4t, z, u) &= \int_{\mathbb{R}^d} p(2t, z, w) p(2t, w, u) \, dw \\ &= \int_{\{|w| \le \tilde{s}_0(t)\}} + \int_{\{\tilde{s}_0(t) < |w| \le |u|\}} + \int_{\{|w| > |u|\}} p(2t, z, w) p(2t, w, u) \, dw \\ &=: I_1 + I_2 + I_3. \end{aligned}$$

According to (4.50),

$$p(2t, z, w) \le c_3 H(z) e^{-c_4 t g(|w|)}, \quad p(2t, u, w) \le c_3 H(u) e^{-c_4 t g(|w|)}$$

for all $|w| \leq \tilde{s}_0(t)$, and so

$$I_1 \le c_7 H(z) H(u) \int_{\{|w| \le \tilde{s}_0(t)\}} e^{-2c_{14} tg(|w|)} dw.$$

Similarly, by (4.50), we have

$$I_{2} \leq c_{8}H(z)H(u) \int_{\{\tilde{s}_{0}(t) < |w| \leq |u|\}} (1+|w|)^{-\alpha} dw$$

$$\leq c_{9}H(z)H(u) \max\{(1+|u|)^{d-\alpha}, 1\}(1+\log(1+|u|)\mathbb{1}_{\{d=\alpha=1\}}).$$

Furthermore, by (4.50) again, for all $|w| \ge |u| \ge \tilde{s}_0(t)$,

$$p(2t, z, w) \le c_3 H(z)(1+|w|)^{-\alpha/2}, \quad p(2t, w, u) \le c_3 H(w)(1+|u|)^{-\alpha/2}.$$

This yields (by noting that $H(w) = \frac{1}{g(|w|)(1+|w|)^{d+\alpha}}$)

$$I_{3} \leq c_{10}H(z)(1+|u|)^{-\alpha/2} \int_{\{|w|>|u|\}} (1+|w|)^{-\alpha/2}H(w) \, dw$$

$$\leq c_{11}H(z)(1+|u|)^{-2\alpha}g(|u|)^{-1} \leq c_{12}H(z)H(u)(1+|u|)^{d-\alpha}.$$

Combining with all the estimates above for I_1 , I_2 and I_3 , we get

(4.52)
$$p(4t, z, u) \leq c_{13}H(z)H(u) \max\{(1+|u|)^{d-\alpha}, 1\}(1+\log(1+|u|)\mathbb{1}_{\{d=\alpha=1\}}) \times \int_{\{|w|\leq \tilde{s}_0(t)\}} e^{-c_{14}tg(|w|)} dw$$

for all $z, u \in \mathbb{R}^d$, t > 0 with $|z| \ge \tilde{s}_0(t)$, $|u| \ge \tilde{s}_0(t)$ and $\tilde{C}_0 h(|x|) < t \le \tilde{C}_0 T_0$. When $d \ne \alpha$, this along with (4.51) yields that for all $\tilde{C}_0 h(|x|) < t \le \tilde{C}_0 T_0$ and $|z| \ge \tilde{s}_0(t)$,

$$(4.53) \quad p(4t,z,u) \le c_{15}H(z) \begin{cases} e^{-c_{16}tg(|u|)}, & |u| \le \tilde{s}_0(t), \\ (1+|u|)^{-\min\{d+\alpha,2\alpha\}} \int_{\{|w|\le \tilde{s}_0(t)\}} e^{-c_{17}tg(|w|)} dw, & |u| > \tilde{s}_0(t). \end{cases}$$

Here we have used the fact that

$$\int_{\{|w| \le \tilde{s}_0(t)\}} e^{-c_{17} tg(|w|)} dw \ge \int_{\{|w| \le c_{18}\}} e^{-c_{17} tg(|w|)} dw \ge c_{19}$$

When $d = \alpha = 1$, we can use the following estimate instead of (4.47):

$$T_t^V 1(z) \le c_{20}(1+|z|)^{-\alpha} \log(1+|z|), \quad z \in \mathbb{R}^d, \ t > 0 \text{ with } t \ge \tilde{C}_0 h(|z|),$$

thanks to (2.22). Then, by the same arguments as above, we can prove that (4.53) still holds. In the next step, we obtain the estimate of p(6t, z, u) for every $\tilde{C}_0 h(|x|) < t \leq \tilde{C}_0 T_0$ and

 $z, u \in \mathbb{R}^d$ with $|z| > \tilde{s}_0(t)$ and $|u| > \tilde{s}_0(t)$ via the iterated estimate (4.53). We have

$$\begin{split} p(6t,z,u) &= \int_{\mathbb{R}^d} p(4t,z,w) p(2t,w,u) \, dw \\ &= \int_{\{|w| \le \tilde{s}_0(t)\}} + \int_{\{\tilde{s}_0(t) < |w| \le |u|\}} + \int_{\{|w| > |u|\}} p(4t,z,w) p(2t,w,u) \, dw \\ &=: J_1 + J_2 + J_3. \end{split}$$

Applying (4.50) and (4.53) directly, we derive

$$J_1 \le c_{21} H(z) H(u) \int_{\{|w| \le \tilde{s}_0(t)\}} e^{-c_{22} tg(|w|)} dw.$$

Using (4.50) and the second inequality of (4.53) instead of the first one for the estimate of p(4t, z, w), we get

$$J_{2} \leq c_{23}H(z)H(u) \int_{\{|w| \leq \tilde{s}_{0}(t)\}} e^{-c_{24}tg(|w|)} dw \cdot \int_{\{\tilde{s}_{0}(t) < |w| \leq |u|\}} (1+|w|)^{-\min\{d+\alpha,2\alpha\}-\alpha/2} dw$$
$$\leq c_{25}H(z)H(u) \max\{(1+|u|)^{d-2\alpha},1\} \cdot \int_{\{|w| \leq \tilde{s}_{0}(t)\}} e^{-c_{24}tg(|w|)} dw$$

and

$$J_{3} \leq c_{26}H(z)(1+|u|)^{-\min\{d+\alpha,2\alpha\}} \int_{\{|w|\leq \tilde{s}_{0}(t)\}} e^{-c_{27}tg(|w|)} dw \cdot \int_{\{|w|>|u|\}} (1+|w|)^{-\alpha/2}H(w) dw$$
$$\leq c_{28}H(z)H(u)\max\{(1+|u|)^{d-2\alpha},1\} \cdot \int_{\{|w|\leq \tilde{s}_{0}(t)\}} e^{-c_{27}tg(|w|)} dw.$$

Combining with all the estimates above for J_1-J_3 yields that for all $\tilde{C}_0T_{\infty} < t \leq \tilde{C}_0T_0$ and $z, u \in \mathbb{R}^d$ with $|z| > \tilde{s}_0(t)$ and $|u| > \tilde{s}_0(t)$,

(4.54)
$$p(6t, z, u) \le c_{29}H(z)H(u)\max\{(1+|u|)^{d-2\alpha}, 1\} \cdot \int_{\{|w|\le \tilde{s}_0(t)\}} e^{-c_{30}tg(|w|)} dw.$$

Furthermore, according to the decomposition

$$p(8t, z, u) = \int_{\{|w| \le \tilde{s}_0(t)\}} + \int_{\{\tilde{s}_0(t) < |w| \le |u|\}} + \int_{\{|w| > |u|\}} p(6t, z, w) p(2t, w, u) \, dw,$$

one can apply (4.54) for the estimate of p(6t, z, w) and follow the arguments for (4.54) to prove that for every $\tilde{C}_0 h_0(|x|) < t \leq \tilde{C}_0 T_0$, $|z| > \tilde{s}_0(t)$ and $|u| > \tilde{s}_0(t)$,

$$p(8t, z, u) \le c_{31}H(z)H(u)\max\{(1+|u|)^{d-3\alpha}, 1\} \cdot \int_{\{|w|\le \tilde{s}_0(t)\}} e^{-c_{32}tg(|w|)} dw.$$

Then, following this procedure iteratively for N_2 times, where N_2 is such that $d - N_2 \alpha < 0$, we can show that for all $\tilde{C}_0 h_0(|x|) < t \leq \tilde{C}_0 T_0$, $|z| > \tilde{s}_0(t)$ and $|u| > \tilde{s}_0(t)$,

$$p(2(N_2+1)t, z, u) \le c_{33}H(z)H(u) \int_{\{|w| \le \tilde{s}_0(t)\}} e^{-c_{34}tg(|w|)} dw$$
$$= c_{33}H(z)H(u) \int_{\{|w| \le s_0(\tilde{C}_0^{-1}t)\}} e^{-c_{34}tg(|w|)} dw.$$

Combining this estimate with the fact that $\tilde{C}_0 h(|x|) < t \leq \tilde{C}_0 T_0$ implies $|y| \geq |x| > \tilde{s}_0(t)$, we prove the desired bound for $2(N_2 + 1)\tilde{C}_0 h(|x|) < t \leq 2(N_2 + 1)\tilde{C}_0 T_0$, i.e., (4.46) holds with $C_0 = 2(N_2 + 1)\tilde{C}_0$ and $C_5 = \tilde{C}_0^{-1}$.

Lemma 4.4. For sufficiently large $C_0 > 0$ there are constants $C_7, C_8 > 0$ such that for all $t > C_0T_0$,

(4.55)
$$C_7 e^{-\lambda_1 t} H(x) H(y) \le p(t, x, y) \le C_8 e^{-\lambda_1 t} H(x) H(y).$$

Proof. For every positive constants c_1, c_2 ,

$$c_3 \le \int_{\{|z|\le 2\}} e^{-c_1 g(|z|)} dz \le \int_{\{|z|\le s_0(c_2)\}} e^{-c_1 g(|z|)} dz \le c_4$$

Then, according to (4.43), (4.46) and Proposition 3.4, it holds that

(4.56)
$$c_5 H(z) H(u) \le p(C_0 T_0, z, u) \le c_6 H(z) H(u), \quad z, u \in \mathbb{R}^d.$$

Indeed, when $h(\min\{|z|, |u|\}) < T_0$ and C_0 is large enough, (4.56) follows from (4.43) and (4.46) by taking $t = C_0T_0$. On the other hand, if $h(\min\{|z|, |u|\}) \ge T_0$, then $\min\{|z|, |u|\} \le 2$, and so $C_0T_0 \le c_7t_0(\min\{|z|, |u|\})$. Thus, by Proposition 3.4, we have

$$p(C_0T_0, z, u) \asymp \left(\frac{1}{C_0T_0g(\max\{|u|, |z|\})} \land 1\right) e^{-c_7C_0T_0g(\min\{|u|, |z|\})} \left((C_0T_0)^{-d/\alpha} \land \frac{C_0T_0}{|u-z|^{d+\alpha}}\right)$$
$$\asymp \frac{1}{g(|u|)} \frac{1}{g(|z|)} \frac{1}{(1+|u|)^{d+\alpha}} \frac{1}{(1+|z|)^{d+\alpha}} = H(u)H(z).$$

Here the second step is due to the facts that for every $z, u \in \mathbb{R}^d$ with $\min\{|z|, |u|\} \le 2$,

$$g(\max\{|z|, |u|\}) \approx g(|z|)g(|u|), \quad g(\min\{|z|, |u|\}) \approx 1,$$
$$\left((C_0 T_0)^{-d/\alpha} \wedge \frac{C_0 T_0}{|u-z|^{d+\alpha}} \right) \approx (1+|u|)^{-d-\alpha} (1+|z|)^{-d-\alpha}$$

This implies that (4.56) is still true when $h(\min\{|z|, |u|\}) \ge T_0$.

Therefore, by (1.10) and (4.56), for every $t > C_0 T_0$,

$$p(t, x, y) = \int_{\mathbb{R}^d} p(t - C_0 T_0, x, w) p(C_0 T_0, w, y) \, dw$$

$$\leq c_6 H(y) \int_{\mathbb{R}^d} p(t - C_0 T_0, x, w) H(w) \, dw$$

$$= c_6 H(y) T_{t - C_0 T_0}^V H(x) \leq c_8 e^{-\lambda_1 t} H(x) H(y),$$

where in the last inequality we have used (1.10).

Applying (1.10) and (4.56) again, we derive that for every $t > C_0 T_0$,

$$p(t, x, y) = \int_{\mathbb{R}^d} p(t - C_0 T_0, x, w) p(C_0 T_0, w, y) \, dw$$

$$\geq c_5 H(y) \int_{\mathbb{R}^d} p(t - C_0 T_0, x, w) H(w) \, dw$$

$$= c_5 H(y) T_{t - C_0 T_0}^V H(x) \geq c_9 e^{-\lambda_1 t} H(x) H(y).$$

Then, we prove (4.55).

4.2. $t_0(\cdot)$ is almost increasing. In this subsection, we will assume that $t_0(\cdot)$ is almost increasing. In particular, $c_{t_0} := \inf_{z \in \mathbb{R}^d} t_0(|z|) > 0$. Set

$$s_1(t) := \inf\{s > 0 : h(s) \ge t\} \lor 2, \quad t > 0.$$

where $h(\cdot)$ is a strictly increasing and continuous function given in (1.8) and we use the convention that $\inf \emptyset = -\infty$. Recall that $T_0 = h(2) > 0$ and $T_{\infty} = h(\infty) = \lim_{s \to \infty} h(s) \in (0, \infty]$. In this part, we are looking for estimates of p(t, x, y) when $t > C_0 t_0(|x|)$. Thus, by taking C_0 large enough, we only need to consider the case that $t > T_0$. In particular, in this case we have $s_1(t) = \inf\{s > 0 : h(s) \ge t\}$.

Lemma 4.5. There exist constants $C_0, C_9 > 0$ such that for every $z, u \in \mathbb{R}^d$, t > 0 with $t \ge C_0 t_0(|z|)$,

(4.57)
$$p(t, z, u) \le C_9 H(z) H(u).$$

Proof. We first note that when $t_0(\cdot)$ is a bounded function, i.e., $T_{\infty} = h(\infty) < \infty$, $t_0(\cdot)$ is almost increasing and almost decreasing at the same time. Indeed, we can simply modify the profile $h(\cdot)$ to be a continuous and decreasing function and keep the value h(2) at the cost of comparability constants in (1.8). In this case, the estimate (4.57) follows directly from the upper bound estimate in Lemma 4.4. Therefore, for the rest of the proof we assume that $t_0(\cdot)$ is an almost increasing function and the corresponding profile h satisfies that $T_{\infty} = \infty$.

According to (1.8), (2.22) and (4.39), there is a constant $C_0 > 0$ so that

(4.58)
$$T_t^V 1(z) \le c_1 (1+|z|)^{-\alpha/2}, \quad z \in \mathbb{R}^d, \ t > 0 \text{ with } t \ge \tilde{C}_0 h(|z|),$$

and

(4.59)
$$p(t,z,u) \le c_2 H(z), \quad u,z \in \mathbb{R}^d, \ t > 0 \text{ with } t \ge \tilde{C}_0 h(|z|).$$

Without loss of generality in the following we can assume that $\tilde{C}_0 > T_0/c_{t_0} = h(2)/c_{t_0}$. On the other hand, by (1.8), the definition of $s_1(\cdot)$ and the fact that $h(\cdot)$ is continuous and strictly increasing, we know that there exists $\tilde{C}_1 > 0$ large enough such that for all $t \geq \tilde{C}_1 T_0$,

(4.60)
$$t \ge \tilde{C}_1 h(|z|/6) \ge \tilde{C}_0 h(|z|), \quad z \in \mathbb{R}^d \text{ with } |z| \le 6s_1 \left(\frac{t}{\tilde{C}_1}\right) =: 6\tilde{s}_1(t),$$
$$t \le \tilde{C}_1 h(|z|/6) \le \tilde{C}_1 h(|z|), \quad z \in \mathbb{R}^d \text{ with } |z| > 6s_1 \left(\frac{t}{\tilde{C}_1}\right) =: 6\tilde{s}_1(t).$$

The proof below is split into three steps.

Step 1: According to (4.58), (4.59) and (4.60), we obtain that for all $z, u \in \mathbb{R}^d$ and $t > \tilde{C}_1 T_0$ with $|z| \leq \tilde{s}_1(t)$ and $|u| \leq 6\tilde{s}_1(t)$,

(4.61)
$$p(2t, z, u) = \int_{\mathbb{R}^d} p(t, z, w) p(t, w, u) \, dw \le c_3 H(z) T_t^V \mathbf{1}(u) \le c_4 H(z) (1 + |u|)^{-\alpha/2}.$$

When $t > \tilde{C}_1 T_0$, $|z| \le \tilde{s}_1(t)$ and $|u| > \tilde{s}_1(t)$ with |u| > 6|z|, set

$$p(2t, z, u) = \left(\int_{\{|z-w| \le |u|/3\}} + \int_{\{|z-w| > |u|/3\}}\right) p(t, z, w) p(t, w, u) \, dw =: I_1 + I_2.$$

If $|z - w| \le |u|/3$, then $|u - w| \ge |u - z| - |z - w| \ge |u| - |z| - |u|/3 \ge |u|/2 \ge c_5 t^{1/\alpha}$, where in the last inequality we used the fact that for $t \ge \tilde{C}_1 T_0$,

$$|u| \ge \tilde{s}_1(t) \ge e^{c_6(1+t)} \ge c_7 t^{1/\alpha},$$

thanks to the fact that $h(s) \le c_8 \log(2+s)$ (which can be verified by (2.19) directly). By (2.28) and (4.58), we get

$$I_{1} \leq \int_{\{|z-w| \leq |u|/3\}} \left(\frac{c_{9}}{t \max\{g(|u|), g(|w|)\}} \wedge 1 \right) \frac{t}{|u-w|^{d+\alpha}} p(t, z, w) \, dw$$
$$\leq \frac{c_{10}}{g(|u|)(1+|u|)^{d+\alpha}} T_{t}^{V} 1(z) \leq c_{11} H(u)(1+|z|)^{-\alpha/2}.$$

Similarly, using (2.28) again we have

$$I_{2} \leq \int_{\{|z-w| > |u|/3\}} \left(\frac{c_{12}}{t \max\{g(|z|), g(|w|)\}} \wedge 1 \right) \frac{t}{|z-w|^{d+\alpha}} p(t, w, u) \, dw$$
$$\leq \frac{c_{13}}{g(|u|)(1+|u|)^{d+\alpha}} T_{t}^{V} 1(u)$$
$$\leq \frac{c_{14}}{g(|u|)(1+|u|)^{d+\alpha}} \left(e^{-c_{15} t g(|u|)} + \frac{t}{(1+|u|)^{\alpha}} \right)$$

$$\leq c_{14}H(u)\left(e^{-c_{15}tg(|z|)} + \frac{t}{(1+|z|)^{\alpha}}\right) \leq c_{16}H(u)(1+|z|)^{-\alpha/2},$$

where the second inequality follows from the fact that $g(|w|) \ge g(|z - w| - |z|) \ge g(|u|/6) \ge c_{17}g(|u|)$ for all $z, w \in \mathbb{R}^d$ with |z - w| > |u|/3 and $|z| \le |u|/6$, the third inequality is due to (2.21), the fourth inequality follows from the fact $|u| \ge 6|z|$, and in the last inequality we have used the arguments from the proof of (2.24) (by taking \tilde{C}_1 larger if necessary). Hence, by all above estimates, for every $|z| \le \tilde{s}_1(t)/6$,

$$(4.62) \qquad p(2t,z,u) \leq \begin{cases} c_{18}H(z)(1+|u|)^{-\alpha/2}, & |u| \leq \tilde{s}_1(t), \\ c_{18}H(u)(1+|z|)^{-\alpha/2}, & |u| > \tilde{s}_1(t), \end{cases}$$
$$= \begin{cases} c_{18}H(z)H(u)(1+|u|)^{d+\alpha/2}g(|u|), & |u| \leq \tilde{s}_1(t), \\ c_{18}H(z)H(u)(1+|z|)^{d+\alpha/2}g(|z|), & |u| > \tilde{s}_1(t); \end{cases}$$

and for every $\tilde{s}_1(t)/6 \le |z| \le \tilde{s}_1(t)$,

$$(4.63) \qquad p(2t, z, u) \leq \begin{cases} c_{19}H(z)H(u)(1+|u|)^{d+\alpha/2}g(|u|), & |u| \leq 6\tilde{s}_1(t), \\ c_{19}H(z)H(u)(1+|z|)^{d+\alpha/2}g(|z|), & |u| > 6\tilde{s}_1(t), \end{cases}$$
$$\leq \begin{cases} c_{20}H(z)H(u)(1+|u|)^{d+\alpha/2}g(|u|), & |u| \leq \tilde{s}_1(t), \\ c_{20}H(z)H(u)(1+|z|)^{d+\alpha/2}g(|z|), & |u| > \tilde{s}_1(t), \end{cases}$$

where the last inequality we have used the fact that $|u| \approx |z|$ and $H(u) \approx H(z)$ for every $\tilde{s}_1(t)/6 \leq |z| \leq \tilde{s}_1(t)$ and $\tilde{s}_1(t) \leq |u| \leq 6\tilde{s}_1(t)$. Then, we show that the inequality (4.62) holds for every $|z| \leq \tilde{s}_1(t)$.

Below we assume that $t > \tilde{C}_1 T_0$ and consider the case that $|z| > \tilde{s}_1(t)$. According to (4.62) (by noting that (4.62) has been verified for every $|z| \leq \tilde{s}_1(t)$ and exchanging the position of z and u),

(4.64)
$$p(2t, z, u) \le c_{21}H(z)(1+|u|)^{-\alpha/2}, \quad |z| > \tilde{s}_1(t), \ |u| \le \tilde{s}_1(t),$$

When $|z| > \tilde{s}_1(t)$ and $|u| > \tilde{s}_1(t)$, by (4.60) and its proof, there is a constant $c_{22} > 0$ such that $t \le c_{22} \min\{t_0(|z|, t_0(|u|))\}$. Thus, it follows from (3.36) that

$$p(2t, z, u) \le c_{23} \left(\frac{1}{t \max\{g(|z|), g(|u|)\}} \land 1 \right) \left(t^{-d/\alpha} \land \frac{t}{|z - u|^{d+\alpha}} \right) e^{-c_{21}t \min\{g(|z|), g(|u|)\}}.$$

Hence, for every $t > \tilde{C}_1 T_0$ and $|z| > \tilde{s}_1(t)$,

$$(4.65) \qquad (4.65) \qquad \leq \begin{cases} c_{21}H(z)(1+|u|)^{-\alpha/2}, & |u| \leq \tilde{s}_1(t), \\ c_{23}e^{-c_{21}t\min\{g(|z|),g(|u|)\}} \left(\frac{1}{t\max\{g(|z|),g(|u|)\}} \wedge 1\right) \left(t^{-d/\alpha} \wedge \frac{t}{|z-u|^{d+\alpha}}\right), & |u| > \tilde{s}_1(t). \end{cases}$$

Step 2: In what follows, we will make use of (4.62) and (4.65) to obtain some improved estimates for p(t, z, u), which will be applied to the iteration procedure later on. We always assume that $t > \tilde{C}_1 T_0$.

We first assume that $d \neq \alpha$. For every $|z| \leq \tilde{s}_1(t)$ and $|u| \leq \tilde{s}_1(t)$, let

$$p(4t, z, u) = \left(\int_{\{|w| \le |u|\}} + \int_{\{|u| \le |w| \le 6\tilde{s}_1(t)\}} \int_{\{|w| > 6\tilde{s}_1(t)\}}\right) p(2t, z, w) p(2t, w, u) dw$$

=: $J_1 + J_2 + J_3$.

By (4.62) (which has been proven for every $|z| \leq \tilde{s}_1(t)$),

$$J_{1} \leq c_{24}H(z)H(u) \int_{\{|w| \leq |u|\}} H^{2}(w)(1+|w|)^{2(d+\alpha/2)}g^{2}(|w|) dw$$

$$\leq c_{25}H(z)H(u) \max\{(1+|u|)^{d-\alpha}, 1\}.$$

According to (4.61) and the proof of (4.62),

$$J_{2} \leq c_{26}H(z)(1+|u|)^{-\alpha/2} \int_{\{|u|\leq |w|\leq 6\tilde{s}_{1}(t)\}} (1+|w|)^{-\alpha/2}H(w) dw$$
$$\leq c_{27}H(z)H(u)(1+|u|)^{d-\alpha}.$$

On the other hand, $|w| \ge 6 \max\{|z|, |u|\}$ if $|w| > 6\tilde{s}_1(t)$. Applying (4.62) again, we derive

$$J_{3} \leq c_{28}(1+|z|)^{-\alpha/2}(1+|u|)^{-\alpha/2} \int_{\{|w|>6\max\{|z|,|u|\}\}} H^{2}(w) \, dw$$

$$\leq c_{28}(1+|z|)^{-\alpha/2}(1+|u|)^{-\alpha/2}(g(|z|)g(|u|))^{-1} \int_{\{|w|>6\max\{|z|,|u|\}\}} (1+|w|)^{-2(d+\alpha)} \, dw$$

$$\leq c_{29}H(z)H(u)(1+|u|)^{d-\alpha}.$$

Hence, combining all above estimates together yields that

(4.66) $p(4t, z, u) \le c_{30}H(z)H(u)\max\{(1+|u|)^{d-\alpha}, 1\}, \quad t > \tilde{C}_1T_0, |z| \le \tilde{s}_1(t), |u| \le \tilde{s}_1(t).$ When $d = \alpha$, we can use the following estimate instead of (4.58):

 $T_t^V 1(z) \le c_{31}(1+|z|)^{-\alpha} \log(1+|z|), \quad z \in \mathbb{R}^d, \ t > 0 \text{ with } t \ge \tilde{C}_0 h(|z|),$

thanks to (2.22). Then, by the same arguments as above, we can prove that (4.66) still holds true.

On the other hand, for every $|z| \leq \tilde{s}_1(t)$ and $|u| > \tilde{s}_1(t)$, set

$$p(6t, z, u) = \left(\int_{\{|w| \le \tilde{s}_1(t)\}} + \int_{\{|w| > \tilde{s}_1(t)\}}\right) p(4t, z, w) p(2t, w, u) \, dw$$

=: $K_1 + K_2$.

Applying (4.66) and (4.64) to p(4t, z, w) and p(2t, w, u) respectively, we have

$$K_{1} \leq c_{32}H(z)H(u)\max\{(1+|z|)^{d-\alpha},1\}\int_{\{|w|\leq \tilde{s}_{1}(t)\}}(1+|w|)^{-\alpha/2}H(w)\,dw$$
$$\leq c_{33}H(z)H(u)\max\{(1+|z|)^{d-\alpha},1\}.$$

Meanwhile, by (4.60), (4.65) and both of the second inequalities in (4.62) and (4.63), we have

$$\begin{split} K_{2} &\leq \frac{c_{34}}{(1+|z|)^{\alpha/2}} \int_{\{|w|>\tilde{s}_{1}(t)\}} \frac{e^{-c_{35}t \min\{g(|w|),g(|u|)\}}H(w)}{t \max\{g(|w|),g(|u|)\}} \left(t^{-d/\alpha} \wedge \frac{t}{|w-u|^{d+\alpha}}\right) dw \\ &\leq \frac{c_{34}e^{-c_{35}tg(|z|)}}{g(|u|)(1+|z|)^{\alpha/2}} \int_{\{|w|>\tilde{s}_{1}(t)\}} H(w)t^{-1} \left(t^{-d/\alpha} \wedge \frac{t}{|w-u|^{d+\alpha}}\right) dw \\ &= \frac{c_{34}e^{-c_{35}tg(|z|)}}{g(|u|)(1+|z|)^{\alpha/2}} \cdot \left[\sum_{i=1}^{3} \int_{\{|w|>\tilde{s}_{1}(t)\}\cap A_{i}} H(w)t^{-1} \left(t^{-d/\alpha} \wedge \frac{t}{|w-u|^{d+\alpha}}\right) dw\right] \\ &=: \frac{c_{34}e^{-c_{35}tg(|z|)}}{g(|u|)(1+|z|)^{\alpha/2}} \left(K_{21} + K_{22} + K_{23}\right), \end{split}$$

where $A_1 := \{w \in \mathbb{R}^d : |w - u| \le c_{36}t^{1/\alpha}\}, A_2 := \{w \in \mathbb{R}^d : c_{36}t^{1/\alpha} < |w - u| \le |u|/2\}$ and $A_3 := \{w \in \mathbb{R}^d : |w - u| > |u|/2\}$. Here we used again the fact that

$$|u| \ge \tilde{s}_1(t) \ge e^{c_{37}(1+t)} \ge 8c_{36}t^{1/\alpha},$$

which can be verified by the property that $h(s) \leq c_{38} \log(2+s)$.

By (4.60), we know that $t \ge \tilde{C}_0 h(|z|)$ when $|z| \le \tilde{s}_1(t)$. Increasing the constant \tilde{C}_0 if necessary and following the argument for (2.24), we obtain

$$(4.67) e^{-c_{35}tg(|z|)} \le e^{-c_{35}\tilde{C}_0h_0(|z|)g(|z|)} \le c_{39}g(|z|)^{-1}(1+|z|)^{-d-\alpha/2}, \quad |z| \le \tilde{s}_1(t),$$

where in the last step we have used the lower bound of $g(\cdot)$ in (2.19). Furthermore, by direct computations we can find that

$$K_{21} \leq \sup_{w \in A_1} H(w) \cdot \left(\int_{\{|w-u| \leq c_{36}t^{1/\alpha}\}} t^{-d/\alpha - 1} \, dw \right) \leq c_{40} H(u),$$

$$K_{22} \leq \sup_{w \in A_2} H(w) \cdot \left(\int_{\{c_{36}t^{1/\alpha} < |w-u| \leq |u|/2\}} \frac{1}{|w-u|^{d+\alpha}} \, dw \right) \leq c_{40} H(u),$$

and

$$K_{23} \le \frac{c_{40}}{(1+|u|)^{d+\alpha}} \int_{\{|w-u| > |u|/2\}} H(w) \, dw \le c_{41} H(u)$$

Putting all the estimates above together yields

$$K_2 \le c_{42}H(z)H(u)$$

By combining this bound with the estimate of K_1 above, we obtain that

$$p(6t, z, u) \le c_{43}H(z)H(u)\max\{(1+|z|)^{d-\alpha}, 1\}, |z| \le \tilde{s}_1(t), |u| > \tilde{s}_1(t).$$

This, along with (4.66) (for the case that $|z| \leq \tilde{s}_1(t)$ and $|u| \leq \tilde{s}_1(t)$), yields that for every $t > \tilde{C}_1 T_0$ and $|z| \leq \tilde{s}_1(t)$,

(4.68)
$$p(6t, z, u) \leq \begin{cases} c_{44}H(z)H(u)\max\{(1+|u|)^{d-\alpha}, 1\}, & |u| \leq \tilde{s}_1(t), \\ c_{44}H(z)H(u)\max\{(1+|z|)^{d-\alpha}, 1\}, & |u| > \tilde{s}_1(t). \end{cases}$$

Indeed, by (4.66),

$$p(6t, z, u) = p\left(4 \times \frac{3t}{2}, z, u\right) \le c_{44}H(z)H(u)\max\{(1+|u|)^{d-\alpha}, 1\}$$

when $|u| \leq \tilde{s}_1(3t/2)$ and $|z| \leq \tilde{s}_1(3t/2)$. According to this and the fact that $\tilde{s}_1(3t/2) \geq \tilde{s}_1(t)$, we obtain the desired assertion in (4.68).

Step 3: Now we will apply the iteration procedure and use the improved estimate (4.68). In fact, for every $t > \tilde{C}_1 T_0$, $|z| \leq \tilde{s}_1(t)$ and $|u| \leq \tilde{s}_1(t)$, we set

$$p(8t, z, u) = \left(\int_{\{|w| \le |u|\}} + \int_{\{|u| \le |w| \le 6\tilde{s}_1(t)\}} \int_{\{|w| > 6\tilde{s}_1(t)\}}\right) p(6t, z, w) p(2t, w, u) \, dw$$

=: $L_1 + L_2 + L_3$.

Using (4.62), (4.63) and (4.68) (for the estimate of p(6t, z, w)), we obtain

$$L_{1} \leq c_{45}H(z)H(u) \int_{\{|w| \leq |u|\}} H^{2}(w)g(|w|) \max\{(1+|w|)^{2d-\alpha/2}, (1+|w|)^{d+\alpha/2}\} dw$$

$$\leq c_{46}H(z)H(u) \max\{(1+|u|)^{d-2\alpha}, 1\},$$

$$L_{2} \leq c_{47}H(z)(1+|u|)^{-\alpha/2} \int_{\{|u| \leq |w| \leq 6\tilde{s}_{1}(t)\}} H^{2}(w) \max\{(1+|w|)^{d-\alpha}, 1\} dw$$
$$\leq c_{48}H(z)H(u)(1+|u|)^{d-2\alpha}$$

and

$$L_3 \le c_{49}H(z)\max\{(1+|z|)^{d-\alpha},1\}(1+|u|)^{-\alpha/2}\int_{\{|w|>\max\{|z|,|u|\}\}}H^2(w)\,dw$$

$$\le c_{50}H(z)H(u)(1+|u|)^{d-2\alpha}.$$

Combining with all above estimates yields that

(4.69)
$$p(8t, z, u) \le c_{51}H(z)H(u)\max\{(1+|u|)^{d-2\alpha}, 1\}, |z| \le \tilde{s}_1(t), |u| \le \tilde{s}_1(t).$$

On the other hand, when $|z| \leq \tilde{s}_1(t)$ and $|u| > \tilde{s}_1(t)$,

$$p(10t, z, u) = \left(\int_{\{|w| \le \tilde{s}_1(t)\}} + \int_{\{|w| > \tilde{s}_1(t)\}} \right) p(8t, z, w) p(2t, w, u) \, dw$$

=: $M_1 + M_2$.

According to (4.69) for p(8t, z, w) and (4.62) for p(2t, w, u) respectively, we can verify directly that

$$M_{1} \leq c_{52}H(z)H(u)\max\{(1+|z|)^{d-2\alpha},1\}\int_{\{|w|\leq \tilde{s}_{1}(t)\}}(1+|w|)^{-\alpha/2}H(w)\,dw$$
$$\leq c_{53}H(z)H(u)\max\{(1+|z|)^{d-2\alpha},1\}.$$

Applying the arguments for the estimate of K_2 in **Step 2** (by choosing \tilde{C}_0 large enough if necessary), we can derive

$$M_2 \le c_{54}H(z)H(u).$$

Thus, for all $|z| \leq \tilde{s}_1(t)$ and $|u| > \tilde{s}_1(t)$,

$$p(10t, z, u) \le c_{55}H(z)H(u)\max\{(1+|z|)^{d-2\alpha}, 1\}.$$

This, along with (the proof of) (4.69), yields that for every $t > \tilde{C}_1 T_0$ and $|z| \leq \tilde{s}_1(t)$,

(4.70)
$$p(10t, z, u) \leq \begin{cases} c_{56}H(z)H(u)\max\{(1+|u|)^{d-2\alpha}, 1\}, & |u| \leq \tilde{s}_1(t), \\ c_{56}H(z)H(u)\max\{(1+|z|)^{d-2\alpha}, 1\}, & |u| > \tilde{s}_1(t). \end{cases}$$

Furthermore, by using the improved estimate (4.70) and iterating the same arguments as above for N_0 times with $N_0 \alpha > d$, we can find that

$$p((6+4N_0)t, z, u) \le c_{57}H(z)H(u), \quad z, u \in \mathbb{R}^d, \ t > \tilde{C}_1T_0 \text{ with } |z| \le \tilde{s}_1(t).$$

We can now combine this estimate with the fact that the inequalities $t \geq N_1 C_* \tilde{C}_1 t_0(|x|) \geq N_1 \tilde{C}_1 h(|x|)$ (with N_1 large enough to ensure $N_1 h(0) > T_0$) imply that $|x| \leq \tilde{s}_1(t)$. This shows that the desired bound (4.57) holds with $C_0 = N_1 C_* \tilde{C}_1(6 + 4N_0)$ since N_1 can be chosen large enough so that $C_0 t_0(|x|) > \tilde{C}_1 T_0$.

Next, we can further improve the upper estimate for p(t, x, y) when $t > C_0 t_0(|x|)$.

Lemma 4.6. There exist constants $C_0, C_{10} > 0$ such that for every $t > C_0 t_0(|x|)$,

(4.71)
$$p(t, x, y) \le C_{10} e^{-\lambda_1 t} H(x) H(y).$$

Proof. For every $z, u \in \mathbb{R}^d$ and t > 0 with $t > C_0 t_0(|z|)$,

(4.72)

$$p(t, z, u) = \int_{\mathbb{R}^d} p(t - C_0 t_0(|z|), u, w) p(C_0 t_0(|z|), w, z) dw$$

$$\leq c_1 H(z) \int_{\mathbb{R}^d} p(t - C_0 t_0(|z|), u, w) H(w) dw$$

$$= c_1 H(z) T_{t - C_0 t_0(|z|)}^V H(u)$$

$$\leq c_2 e^{-\lambda_1 t} e^{\lambda_1 C_0 t_0(|z|)} H(z) H(u).$$

Here the constant C_0 is the same as that in Lemma 4.5, the first inequality is due to (4.57), and the last inequality follows from (1.10). By (4.72), we know that for every $R_0 > 0$, (4.71) holds true for all $t > C_0 t_0(|x|)$ and $|x| \le R_0$. Hence, it suffices to show (4.71) for any $t > C_0 t_0(|x|)$ and $|x| > R_0$ with R_0 to be determined later. For every $t > 2C_0 \max\{t_0(|x|), t_0(|y|)\},\$

(4.73)
$$p(t, x, y) = \int_{\mathbb{R}^d} p(t/2, x, w) p(t/2, w, y) \, dw$$
$$\leq c_3 e^{-\lambda_1 t} H(x) H(y) \int_{\mathbb{R}^d} H^2(w) e^{c_4 t_0(|w|)} \, dw$$
$$\leq c_5 e^{-\lambda_1 t} H(x) H(y).$$

Here the first inequality follows from (4.72), and in the last inequality we have used the fact

(4.74)
$$\int_{\mathbb{R}^d} H^2(w) e^{c_4 t_0(|w|)} dw < +\infty,$$

which can be verified directly by (2.19), thanks to the fact that $g(r) \to \infty$ as $r \to \infty$. On the other hand, similarly as in (4.60), we can find $\tilde{C}_1 > 0$ large enough such that for $t \ge \tilde{C}_1 T_0$,

(4.75)
$$t \ge \tilde{C}_1 h(|z|) \ge 2C_0 t_0(|z|), \quad z \in \mathbb{R}^d \text{ with } |z| \le s_1\left(\frac{t}{\tilde{C}_1}\right) =: \tilde{s}_1(t),$$
$$t \le \tilde{C}_1 h(|z|) \le c_6 t_0(|z|), \quad z \in \mathbb{R}^d \text{ with } |z| > s_1\left(\frac{t}{\tilde{C}_1}\right) =: \tilde{s}_1(t).$$

Below we choose the constant C_0 large enough so that $C_0 \inf_{x \in \mathbb{R}^d} t_0(|x|) \ge \tilde{C}_1 T_0$. Then, according to (4.75) and (4.72), we have

(4.76)
$$p(t, z, u) \le c_7 e^{-\lambda_1 t} e^{c_8 t_0(|z|)} H(z) H(u), \quad t \ge C_0 t_0(|x|), \ |z| \le \tilde{s}_1(t);$$

by (4.75) and (4.73), we know that (4.71) is true for every $|x| \leq \tilde{s}_1(t)$ and $|y| \leq \tilde{s}_1(t)$, whenever $t > C_0 t_0(|x|)$.

Next, it remains to consider the case that $|x| \leq \tilde{s}_1(t)$, $|y| > \tilde{s}_1(t)$ and $t \geq C_0 t_0(|x|)$. Set

$$p(2t, x, y) = \left(\int_{\{|w| \le \tilde{s}_1(t)\}} + \int_{\{|w| > \tilde{s}_1(t)\}}\right) p(t, x, w) p(t, w, y) \, dw$$

=: $I_1 + I_2$.

By (4.76), it holds that

$$I_{1} \leq c_{9}e^{-2\lambda_{1}t}H(x)H(y)\int_{\{|w|\leq\tilde{s}_{1}(t)\}}H^{2}(w)e^{c_{10}t_{0}(|w|)}\,dw$$
$$\leq c_{11}e^{-2\lambda_{1}t}H(x)H(y),$$

where the last inequality is due to (4.74).

When $|w| > \tilde{s}_1(t)$ and $|y| > \tilde{s}_1(t)$, it follows from (4.75) that there is a constant $c_{12} > 0$ such that $t \le c_{12} \min\{t_0(|w|), t_0(|y|)\}$. Hence, applying (3.36), we obtain

$$p(t, w, y) \le c_{13} \left(\frac{1}{t \max\{g(|w|), g(|y|)\}} \land 1 \right) \left(t^{-d/\alpha} \land \frac{t}{|w - y|^{d+\alpha}} \right) e^{-c_{14}t \min\{g(|w|), g(|y|)\}}.$$

By (4.76) and the fact that $|x| \leq \tilde{s}_1(t) \leq \min\{|w|, |y|\},\$

$$I_{2} \leq c_{15}H(x)e^{c_{16}t_{0}(|x|)}\int_{\{|w|>\tilde{s}_{1}(t)\}}\frac{e^{-2c_{17}t\min\{g(|w|),g(|y|)\}}H(w)}{t\max\{g(|w|),g(|y|)\}}\left(t^{-d/\alpha}\wedge\frac{t}{|w-y|^{d+\alpha}}\right)dw$$
$$\leq c_{15}e^{c_{16}t_{0}(|x|)-2c_{17}tg(|x|)}H(x)g(|y|)^{-1}\cdot\int_{\{|w|>\tilde{s}_{1}(t)\}}H(w)t^{-1}\left(t^{-d/\alpha}\wedge\frac{t}{|w-y|^{d+\alpha}}\right)dw.$$

Note that

$$e^{c_{16}t_0(|x|) - 2c_{17}tg(|x|)} = e^{-c_{17}tg(|x|)}e^{c_{16}t_0(|x|) - c_{17}tg(|x|)}$$

Since $\lim_{r \uparrow \infty} g(r) = \infty$, we can find $R_0 > 0$ large enough so that for all $|x| \ge R_0$,

$$e^{-c_{17}tg(|x|)} \le e^{-2\lambda_1 t}, \quad t > 0$$

and

$$e^{c_{16}t_0(|x|) - c_{17}tg(|x|)} \le \exp\left(-t_0(|x|)\left(C_0c_{17}g(|x|) - c_{16}\right)\right) \le \exp\left(-\frac{C_0c_{17}t_0(|x|)g(|x|)}{2}\right)$$
$$\le c_{18}, \quad t > C_0t_0(|x|).$$

Putting both estimates above together, we obtain

$$e^{c_{16}t_0(|x|)-2c_{17}tg(|x|)} \le c_{19}e^{-2\lambda_1 t}, \quad t > C_0t_0(|x|), \ |z| > R_0.$$

On the other hand, according to the procedures for the estimate of the term K_2 in the proof of Lemma 4.5, we find that

$$\int_{\{|w|>\tilde{s}_1(t)\}} H(w)t^{-1}\left(t^{-d/\alpha} \wedge \frac{t}{|w-y|^{d+\alpha}}\right) dw \le c_{20}g(|y|)H(y).$$

Hence,

$$I_2 \le c_{21} e^{-2\lambda_1 t} H(x) H(y), \quad t > 2C_0 t_0(|x|), \ |x| \le \tilde{s}_1(t), \ |y| > \tilde{s}_1(t), \ |x| > R_0$$

Finally, by the estimates of I_1 and I_2 , we obtain

$$p(2t, x, y) \le c_{22} e^{-2\lambda_1 t} H(x) H(y), \quad t > 2C_0 t_0(|x|), \ |x| \le \tilde{s}_1(t), \ |y| > \tilde{s}_1(t), \ |x| > R_0$$

whenever $t > C_0 t_0(|x|)$. This implies that (4.71) holds for every $|x| \leq \tilde{s}_1(t)$ and $|y| > \tilde{s}_1(t)$, and the proof of the assertion (4.71) is finished.

Lemma 4.7. There exist constants $C_0, C_{11} > 0$ such that for every $t > C_0 t_0(|x|)$,

(4.77)
$$p(t, x, y) \ge C_{11} e^{-\lambda_1 t} H(x) H(y).$$

Proof. Since $t_0(\cdot)$ is almost increasing, we know that $\inf_{x \in \mathbb{R}^d} t_0(|x|) \ge c_1 > 0$. According to (3.36), for all $w \in B(0,2)$ and $z \in \mathbb{R}^d$,

$$p(1, z, w) \ge c_2 \left(1 \wedge \frac{1}{|w - z|^{d + \alpha}} \right) \left(\frac{1}{\max\{g(|w|), g(|z|)\}} \wedge 1 \right) e^{-c_3 \min\{g(|w|), g(|z|)\}} \\ \ge \frac{c_4}{g(|z|)(1 + |z|)^{d + \alpha}}.$$

Hence, for every $z, u \in \mathbb{R}^d$,

$$p(2, z, u) = \int_{\mathbb{R}^d} p(1, z, w) p(1, w, u) \, dw \ge \int_{B(0, 2)} p(1, z, w) p(1, w, u) \, dw \ge c_5 H(z) H(u).$$

Therefore, for every $t > C_0 t_0(|x|) > 2$ (by taking C_0 large enough),

$$p(t, x, y) = \int_{\mathbb{R}^d} p(t - 2, x, z) p(2, z, y) \, dz \ge c_5 H(y) \int_{\mathbb{R}^d} p(t - 2, x, z) H(z) \, dz$$
$$= c_5 H(y) T_{t-2}^V H(x) \ge c_6 e^{-\lambda_1 t} H(x) H(y),$$

where the last inequality follows from (1.10). So, the proof of (4.77) is finished.

We can now summarise the results in this section as follows.

Proposition 4.8. There are constants $C_0, \tilde{C}_0, C_{12}, \ldots, C_{20} > 0$ such that the following statements hold.

(1) If $t_0(\cdot)$ is almost decreasing, then, for every $C_0 t_0(|x|) < t \leq \tilde{C}_0$,

$$C_{12}H(x)H(y)\int_{\{|z|\leq s_0(t)\}} e^{-C_{13}tg(|z|)} dz \leq p(t,x,y)$$
$$\leq C_{14}H(x)H(y)\int_{\{|z|\leq s_0(C_{15}t)\}} e^{-C_{16}tg(|z|)} dz;$$

for every $t > \tilde{C}_0$,

$$C_{17}e^{-\lambda_1 t}H(x)H(y) \le p(t,x,y) \le C_{18}e^{-\lambda_1 t}H(x)H(y).$$

(2) If $t_0(\cdot)$ is almost increasing, then for every $t > C_0 t_0(|x|)$

$$C_{19}e^{-\lambda_1 t}H(x)H(y) \le p(t,x,y) \le C_{20}e^{-\lambda_1 t}H(x)H(y).$$

Remark 4.9. Note that in Proposition 3.4 the time interval can be $0 < t \leq C'_0 t_0(|x|)$ with any $C'_0 > 0$. Therefore, according to (1.8), the estimates in Proposition 4.8 still hold true for $C_0 t_0(|x|) < t \leq \tilde{C}_0$ by taking a different constant C_0 if necessary. On the other hand, by the statement (1) in Proposition 4.8, the estimates in (1) hold for any \tilde{C}_0 with $\tilde{C}_0 > C_0 t_0(|x|)$.

5. JUSTIFICATION OF EXAMPLE 1.2

By assumption we know that V satisfies (1.6) with $g(s) = \log^{\beta}(e+s)$. So, by (1.7), it is easy to check that $t_0(s)$ satisfies (1.8) with $h(s) = \log^{1-\beta}(2+s)$. Then the estimates (1) and (2-i) follow directly from Theorem 1.1.

It remains to verify (2-ii). Let $\beta > 1$. Since $h(s) = \log^{1-\beta}(2+s)$,

$$s_0(t) := h^{-1}(t) \lor 2 = \begin{cases} 2, & t \ge \log^{1-\beta} 4, \\ \exp(t^{-1/(\beta-1)}) - 2, & t \in (0, \log^{1-\beta} 4] \end{cases}$$

For every $0 < t \leq 2$, first observe that for every positive constants c_0, c_1 and c_2 ,

$$\int_{\{|z| \le c_1 s_0(c_2 t)\}} e^{-c_0 t \log^\beta (2+|z|)} dz \le c_3 (c_1 s_0(c_2 t))^d \le c_4 \exp(c_5 t^{-1/(\beta-1)})$$

On the other hand, for every $0 < t \leq 2$,

$$\int_{\{|z| \le s_0(t)\}} e^{-c_0 t \log^\beta (2+|z|)} dz \ge \int_{\{|z| \le 2\}} e^{-c_0 t \log^\beta (2+|z|)} dz \ge c_5$$

Hence, in order to get the desired lower bound it suffices to consider the time interval $0 < t \le t_0$ for some fixed $t_0 \in (0, \log^{1-\beta} 4]$. Using spherical coordinates and the substitution $s = \log^{\beta}(2+r)$, we get

$$\begin{split} \int_{\{|z| \le s_0(t)\}} e^{-c_0 t \log^\beta (2+|z|)} \, dz &= c_6 \int_0^{s_0(t)} e^{-c_0 t \log^\beta (2+r)} r^{d-1} \, dr \\ &= c_6 \beta^{-1} \int_{\log^\beta 2}^{t^{-\beta/(\beta-1)}} e^{-c_0 ts} \left(e^{s^{1/\beta}} - 2 \right)^{d-1} e^{s^{1/\beta}} s^{-(\beta-1)/\beta} \, ds. \end{split}$$

Choose $\theta \in (0, 1/2)$ and $t_0 \in (0, \log^{1-\beta} 4]$ such that

(5.78)
$$\theta t_0^{-\beta/(\beta-1)}/2 \ge \log^\beta 2, \quad d\left(\frac{\theta}{2}\right)^{1/\beta} - c_0\theta \ge c_0\theta/2;$$

this is possible because $\beta > 1$. Therefore, for every $0 < t \le t_0$,

$$\begin{split} &\int_{\{|z| \le s_0(t)\}} e^{-c_0 t \log^{\beta}(2+|z|)} dz \\ &\ge c_6 \beta^{-1} \int_{\theta t^{-\beta/(\beta-1)}/2}^{\theta t^{-\beta/(\beta-1)}} e^{-c_0 ts} \left(e^{s^{1/\beta}} - 2 \right)^{d-1} e^{s^{1/\beta}} s^{-(\beta-1)/\beta} ds \\ &\ge c_7 t \int_{\theta t^{-\beta/(\beta-1)}/2}^{\theta t^{-\beta/(\beta-1)}} \exp\left(ds^{1/\beta} - c_0 ts \right) ds \\ &\ge c_8 t^{1-\beta/(\beta-1)} \cdot \exp\left(t^{-1/(\beta-1)} \left(d\left(\frac{\theta}{2} \right)^{1/\beta} - c_0 \theta \right) \right) \\ &\ge c_9 \exp\left(c_0 \theta t^{-1/(\beta-1)}/2 \right), \end{split}$$

where the last inequality follows from (5.78). Thus, the proof is complete.

6. PROOFS OF MAIN RESULTS

Proof of Theorem 1.1. The conclusion is a direct consequence of Proposition 3.4 and Proposition 4.8. See Remark 4.9 for the additional comments. \Box

Proof of Theorem 1.3. Let $x, y \in \mathbb{R}^d$ with $|x| \leq |y|$ and $x \neq y$. We write

$$G^{V}(x,y) = \int_{0}^{C_{0}t_{0}(|x|)} p(t,x,y) dt + \int_{C_{0}t_{0}(|x|)}^{\infty} p(t,x,y) dt =: I + II,$$

where the constant $C_0 > 0$ comes from Theorem 1.1.

We first apply the estimates from Theorem 1.1(1) to estimate the integral I. An analysis is divided into three cases.

Case 1: $2|x - y|^{\alpha} \le C_0 t_0(|x|)$ and $2/g(|x|) < |x - y|^{\alpha}$. We write

$$I = \left(\int_0^{1/g(|y|)} + \int_{1/g(|y|)}^{|x-y|^{\alpha}} + \int_{|x-y|^{\alpha}}^{C_0 t_0(|x|)}\right) p(t,x,y) \, dt =: I_1 + I_2 + I_3.$$

According to (1.11), we have

$$I_1 \asymp |x-y|^{-d-\alpha} \int_0^{1/g(|y|)} t e^{-ctg(|x|)} dt \asymp |x-y|^{-d-\alpha} \int_0^{1/g(|y|)} t \, dt \asymp |x-y|^{-d-\alpha} g(|y|)^{-2}.$$

We point out that all of the comparability formulas in this proof contain the exponential terms with a generic constant c, but this is only a shorthand notation. The exponential term $e^{-ctg(|x|)}$ comes from the two-sided bound in Theorem 1.1(1) and the reader should note that we always have $c = C_2$ in lower estimates and $c = C_4$ in upper estimates, for different C_2, C_4 .

Similarly, by (1.11),

$$I_{2} \approx |x - y|^{-d - \alpha} g(|y|)^{-1} \int_{1/g(|y|)}^{|x - y|^{\alpha}} e^{-ctg(|x|)} dt$$
$$\approx |x - y|^{-d - \alpha} g(|x|)^{-1} g(|y|)^{-1} \int_{g(|x|)/g(|y|)}^{|x - y|^{\alpha}g(|x|)} e^{-cs} ds$$
$$\approx |x - y|^{-d - \alpha} g(|x|)^{-1} g(|y|)^{-1},$$

where in the third step we have used the fact that (since $g(|x|)/g(|y|) \le 1$ and $|x-y|^{\alpha}g(|x|) \ge 2$)

$$c_1 \le \int_1^2 e^{-cs} \, ds \le \int_{g(|x|)/g(|y|)}^{|x-y|^{\alpha}g(|x|)} e^{-cs} \, ds \le \int_0^\infty e^{-cs} \, ds \le c_2$$

Moreover, by applying (1.11) and using substitution $t = |x - y|^{\alpha} s$, we get

$$I_{3} \approx g(|y|)^{-1} \int_{|x-y|^{\alpha}}^{C_{0}t_{0}(|x|)} t^{-d/\alpha-1} e^{-ctg(|x|)} dt$$
$$\approx |x-y|^{-d}g(|y|)^{-1} \int_{1}^{C_{0}t_{0}(|x|)/|x-y|^{\alpha}} s^{-d/\alpha-1} e^{-c|x-y|^{\alpha}g(|x|)s} ds$$
$$\approx |x-y|^{-d}g(|y|)^{-1} e^{-c|x-y|^{\alpha}g(|x|)},$$

where the third step follows from the estimates

$$\int_{1}^{C_{0}t_{0}(|x|)/|x-y|^{\alpha}} s^{-d/\alpha-1} e^{-c|x-y|^{\alpha}g(|x|)s} \, ds \le e^{-c|x-y|^{\alpha}g(|x|)} \int_{1}^{\infty} s^{-d/\alpha-1} \, ds \le c_{3}e^{-c|x-y|^{\alpha}g(|x|)}$$

and

$$\int_{1}^{C_0 t_0(|x|)/|x-y|^{\alpha}} s^{-d/\alpha - 1} e^{-c|x-y|^{\alpha}g(|x|)s} \, ds \ge e^{-2c|x-y|^{\alpha}g(|x|)} \int_{1}^{2} s^{-d/\alpha - 1} \, ds$$

$$\geq c_4 e^{-2c|x-y|^{\alpha}g(|x|)}.$$

In particular,

$$I_3 \le c_5 |x - y|^{-d - \alpha} g(|x|)^{-1} g(|y|)^{-1}.$$

Consequently, combining all the estimates above with the facts $g(|y|) \ge g(|x|)$ and $Q(x, y) \asymp 1$ (since $2/g(|x|) < |x - y|^{\alpha}$), we have

$$I \asymp |x-y|^{-d-\alpha} g(|x|)^{-1} g(|y|)^{-1} \asymp |x-y|^{-d+\alpha} \cdot \left(\frac{1}{g(|y|)|x-y|^{\alpha}} \wedge 1\right) \left(\frac{1}{g(|x|)|x-y|^{\alpha}} \wedge 1\right) Q(x,y) = \left(\frac{1}$$

Case 2: $2|x - y|^{\alpha} \leq C_0 t_0(|x|)$ and $2/g(|x|) \geq |x - y|^{\alpha}$. In this case, we will use the simpler decomposition

$$I = \left(\int_0^{|x-y|^{\alpha}/2} + \int_{|x-y|^{\alpha}/2}^{C_0 t_0(|x|)}\right) p(t,x,y) \, dt =: J_1 + J_2.$$

Indeed, $|x - y| \leq (2/g(|x|))^{1/\alpha} \leq c_6$, so it holds that $g(|x|) \approx g(|y|)$ for this range of x and y, which implies that

(6.79)
$$(tg(|y|))^{-1} \wedge 1)e^{-ctg(|x|)} \approx e^{-tg(|x|)}, \quad 0 \le t \le C_0 t_0(|x|).$$

With this and (1.11),

$$J_1 \asymp |x-y|^{-d-\alpha} \int_0^{|x-y|^{\alpha/2}} t e^{-ctg(|x|)} dt \asymp |x-y|^{-d-\alpha} \int_0^{|x-y|^{\alpha/2}} t \, dt \asymp |x-y|^{-d+\alpha},$$

where we have used the fact that $|x - y|^{\alpha}g(|x|) \leq 2$.

Meanwhile, by (1.11), (6.79) and substitution $t = |x - y|^{\alpha} s/2$, we derive

$$J_2 \asymp \int_{|x-y|^{\alpha}/2}^{C_0 t_0(|x|)} t^{-d/\alpha} e^{-ctg(|x|)} dt \asymp |x-y|^{-d+\alpha} \int_1^{\frac{2C_0 t_0(|x|)}{|x-y|^{\alpha}}} s^{-d/\alpha} e^{-csg(|x|)|x-y|^{\alpha}} ds$$

If $\alpha < d$, then, by the fact $2|x - y|^{\alpha} \le C_0 t_0(|x|)$ and $|x - y|^{\alpha} g(|x|) \le 2$, it holds that

$$c_{7} \leq c_{8} \int_{1}^{2} s^{-d/\alpha} \, ds \leq c_{9} \int_{1}^{\frac{2C_{0}t_{0}(|x|)}{|x-y|^{\alpha}}} s^{-d/\alpha} e^{-csg(|x|)|x-y|^{\alpha}} \, ds \leq c_{10} \int_{1}^{\infty} s^{-d/\alpha} \, ds = \frac{c_{10}\alpha}{d-\alpha}.$$

If $\alpha = d = 1$, then, by noting from (1.7) and (2.20) that $2C_0 t_0(|x|) \ge c_{11}g(|x|)^{-1}$,

$$\int_{1}^{\frac{2C_0 t_0(|x|)}{|x-y|^{\alpha}}} s^{-d/\alpha} e^{-csg(|x|)|x-y|^{\alpha}} ds \ge c_{12} \int_{1}^{\max\left\{\frac{c_{11}}{g(|x|)|x-y|^{\alpha}},4\right\}} s^{-1} ds$$
$$\ge c_{13} \max\left\{\log\left(\frac{1}{|x-y|^{\alpha}g(|x|)}\right),1\right\}$$

and

$$\int_{1}^{\frac{2C_{0}t_{0}(|x|)}{|x-y|^{\alpha}}} s^{-d/\alpha} e^{-csg(|x|)|x-y|^{\alpha}} ds$$

$$\leq c_{14} \int_{1}^{\max\left\{\frac{c_{11}}{g(|x|)|x-y|^{\alpha}},1\right\}} s^{-1} ds + c_{14}g(|x|)|x-y|^{\alpha} \cdot \int_{\max\left\{\frac{c_{11}}{g(|x|)|x-y|^{\alpha}},1\right\}}^{\infty} e^{-csg(|x|)|x-y|^{\alpha}} ds$$

$$\leq c_{15} \max\left\{\log\left(\frac{c_{11}}{g(|x|)|x-y|^{\alpha}}\right),1\right\}.$$

If $\alpha > d = 1$, then

$$\int_{1}^{\frac{2C_{0}t_{0}(|x|)}{|x-y|^{\alpha}}} s^{-d/\alpha} e^{-csg(|x|)|x-y|^{\alpha}} ds \ge c_{16} \int_{1}^{\max\left\{\frac{c_{11}}{g(|x|)|x-y|^{\alpha}},4\right\}} s^{-d/\alpha} ds$$
$$\ge c_{17} \left(\frac{1}{|x-y|^{\alpha}g(|x|)}\right)^{(\alpha-d)/\alpha}$$

and

$$\begin{split} &\int_{1}^{\frac{2C_{0}t_{0}(|x|)}{|x-y|^{\alpha}}} s^{-d/\alpha} e^{-csg(|x|)|x-y|^{\alpha}} ds \\ &\leq c_{18} \int_{1}^{\max\left\{\frac{c_{11}}{g(|x|)|x-y|^{\alpha}},1\right\}} s^{-d/\alpha} ds \\ &+ c_{18} \left(g(|x|)|x-y|^{\alpha}\right)^{-d/\alpha} \cdot \int_{\max\left\{\frac{c_{11}}{g(|x|)|x-y|^{\alpha}},1\right\}}^{\infty} e^{-csg(|x|)|x-y|^{\alpha}} ds \\ &\leq c_{19} \left(\frac{1}{|x-y|^{\alpha}g(|x|)}\right)^{(\alpha-d)/\alpha} . \end{split}$$

Hence, putting all above estimates together, we obtain

$$J_2 \asymp |x-y|^{-d+\alpha}Q(x,y),$$

which implies immediately that

$$I \asymp |x-y|^{-d+\alpha}Q(x,y) \asymp |x-y|^{-d+\alpha} \cdot \left(\frac{1}{g(|y|)|x-y|^{\alpha}} \wedge 1\right) \left(\frac{1}{g(|x|)|x-y|^{\alpha}} \wedge 1\right) Q(x,y),$$

where we have used the fact that $|x - y|^{\alpha} \leq 2/g(|x|)$ and $g(|x|) \approx g(|y|)$. Case 3: $2|x - y|^{\alpha} > C_0 t_0(|x|)$.

Similarly, it follows from (1.7) and (2.20) that $C_0t_0(|x|) > 2c_{20}g(|x|)^{-1} \ge 2c_{20}g(|y|)^{-1}$. Let

$$I = \left(\int_0^{c_{20}/g(|y|)} + \int_{c_{20}/g(|y|)}^{C_0 t_0(|x|)}\right) p(t, x, y) dt =: K_1 + K_2.$$

So by (1.11), we get

$$K_1 \asymp |x - y|^{-d - \alpha} \int_0^{c_{20}/g(|y|)} t \, dt \asymp |x - y|^{-d - \alpha} g(|y|)^{-2}$$

and

$$K_{2} \approx |x - y|^{-d - \alpha} g(|y|)^{-1} \int_{c_{20}/g(|y|)}^{C_{0}t_{0}(|x|)} e^{-ctg(|x|)} dt$$
$$\approx |x - y|^{-d - \alpha} g(|x|)^{-1} g(|y|)^{-1},$$

where in the last step we have used the fact that

$$c_{21}g(|x|)^{-1} \leq \int_{c_{20}/g(|y|)}^{2c_{20}/g(x)} e^{-ctg(|x|)} dt \leq \int_{c_{20}/g(|y|)}^{C_0t_0(|x|)} e^{-ctg(|x|)} dt$$
$$\leq \int_{c_{20}/g(|y|)}^{\infty} e^{-ctg(|x|)} dt \leq c_{22}g(|x|)^{-1}.$$

Putting all the estimates above together and combining them with the facts that $g(|y|) \ge g(|x|)$ and $Q(x,y) \simeq 1$ (since $c_{20}/g(|x|) < |x-y|^{\alpha}$), we have

$$I \asymp |x-y|^{-d-\alpha} g(|x|)^{-1} g(|y|)^{-1} \asymp |x-y|^{-d+\alpha} \cdot \left(\frac{1}{g(|y|)|x-y|^{\alpha}} \wedge 1\right) \left(\frac{1}{g(|x|)|x-y|^{\alpha}} \wedge 1\right) Q(x,y) = 0$$

By now we have obtained that for all of these cases,

$$I \asymp \frac{1}{|x-y|^{d-\alpha}} \left(1 \wedge \frac{1}{g(|x|)|x-y|^{\alpha}} \right) \left(1 \wedge \frac{1}{g(|y|)|x-y|^{\alpha}} \right) Q(x,y).$$

Next, we are going to estimate the integral II. We will show that there is a constant $c_{23} > 0$ such that $II \leq c_{23}I$, which will lead us immediately to the desired conclusion. Recall we assume that $|x| \leq |y|$.

When $t_0(\cdot)$ is almost increasing, it follows directly from (1.12) that

(6.80)
$$II \le \frac{c_{24}}{g(|x|)g(|y|)(1+|x|)^{d+\alpha}(1+|y|)^{d+\alpha}}$$

Suppose that $t_0(\cdot)$ is almost decreasing. Then we set

$$II = \left(\int_{C_0 t_0(|x|)}^{\tilde{C}_0} + \int_{\tilde{C}_0}^{\infty}\right) p(t, x, y) \, dt =: L_1 + L_2,$$

where \tilde{C}_0 is the same constant in Theorem 1.1. By (1.14) it is direct to see that

$$L_2 \le \frac{c_{25}}{g(|x|)g(|y|)(1+|x|)^{d+\alpha}(1+|y|)^{d+\alpha}}.$$

By tracking the proof of Theorem 1.1(2-ii) we can take $C_0 > C_*C_{10}^{-1}$, where C_* , C_{10} are positive constants in (1.8) and (1.13), respectively. Hence, according to (1.8), for every $C_0t_0(|x|) \le t \le \tilde{C}_0$,

$$s_0(C_{10}t) \le s_0 \left(C_0 C_{10} t_0(|x|) \right) \le s_0 \left(C_0 C_{10} C_*^{-1} h(|x|) \right) \le s_0 \left(h(|x|) \right) \le (|x| \lor 2) \le 2(1+|x|).$$

Then, by (1.13),

$$L_1 \le c_{26}H(x)H(y) \int_{C_0 t_0(|x|)}^{\tilde{C}_0} \int_{\{|z| \le c_{27}s_0(C_{10}t)\}} e^{-c_{28}tg(|z|)} dz dt$$

$$\le c_{29}H(x)H(y)(1+|x|)^d.$$

Consequently, combining the estimates of L_1 and L_2 with (6.80), we can conclude that if $t_0(\cdot)$ is an almost monotone function and $C_0 t_0(|x|) \le h(2)$, then

$$II \le \frac{c_{30}}{g(|x|)g(|y|)(1+|y|)^{d+\alpha}}.$$

On the other hand, when $C_0 t_0(|x|) > h(2)$, $II \leq L_2$ and so it is clear that the inequality above holds true.

Observe now that for the **Case 1** and **Case 3** above, it holds that $|x - y|^{\alpha} > c_{31}g(|x|)^{-1} \ge c_{31}g(|y|)^{-1}$. Then, we can write

$$\begin{split} II &\leq \frac{c_{30}}{g(|x|)g(|y|)(1+|y|)^{d+\alpha}} \\ &= \frac{c_{30}|x-y|^{d+\alpha}}{|x-y|^{d-\alpha}g(|x|)|x-y|^{\alpha}g(|y|)|x-y|^{\alpha}(1+|y|)^{d+\alpha}} \\ &\leq \frac{c_{32}}{|x-y|^{d-\alpha}} \left(1 \wedge \frac{1}{g(|x|)|x-y|^{\alpha}}\right) \left(1 \wedge \frac{1}{g(|y|)|x-y|^{\alpha}}\right) \frac{|x-y|^{d+\alpha}}{(1+|y|)^{d+\alpha}} \\ &\leq \frac{c_{32}}{|x-y|^{d-\alpha}} \left(1 \wedge \frac{1}{g(|x|)|x-y|^{\alpha}}\right) \left(1 \wedge \frac{1}{g(|y|)|x-y|^{\alpha}}\right) \frac{(2|y|)^{d+\alpha}}{(1+|y|)^{d+\alpha}} \\ &\leq c_{33}I. \end{split}$$

For the remaining Case 2 above, it holds that $|x - y|^{\alpha} \leq c_{34}g(|x|)^{-1} \leq c_{35}$ and $g(|x|) \approx g(|y|)$. By this we obtain immediately that

$$II \le c_{36} \le c_{37}I.$$

So now we have finished the proof.
