C^{∞} RECTIFIABILITY OF STATIONARY VARIFOLDS

ABSTRACT. In this paper we prove that, for every integers $m \ge 2$ and $n \ge 1$, the support of any stationary *m*-dimensional integer rectifiable varifold V in an open set $U \subset \mathbb{R}^{m+n}$ is C^{∞} rectifiable, namely it can be covered, up to an \mathcal{H}^m -null set, with countably many C^{∞} *m*-dimensional graphs.

1. INTRODUCTION

Integer rectifiable *m*-dimensional varifolds, which in this note will be denoted by V, in an open set $U \subset \mathbb{R}^{m+n}$ can be defined as Radon measures

$$\Theta \mathcal{H}^m \sqcup E \,, \tag{1.1}$$

where $E \subset U$ is an *m*-dimensional rectifiable set, \mathcal{H}^m denotes the Hausdorff *m*-dimensional measure, and Θ is a Borel function taking positive integer values (\mathcal{H}^m -a.e.); cf. [7, 16]. The theory was pioneered by Almgren and especially Allard, see [1]. In the most general setting, first proposed by L.C. Young, a varifold

is a nonnegative Radon measure on the Grassmannian of unoriented *m*-dimensional planes $G_m(U) = U \times G_m(\mathbb{R}^{m+n})$: with the latter definition the varifold is rectifiable if its marginal, denoted by ||V||, on U takes the form (1.1) and its disintegration on the fibers $\{x\} \times \mathbb{R}^{m+n}$ (with $x \in E$) consists of the Dirac mass on the approximate tangent $T_x E$ to E. Since we will always consider only rectifiable varifolds, we can ignore these details; however, following the notation of Almgren and Allard, the Radon measure in (1.1) will be denoted by ||V||.

We will assume that V is stationary in U: this means that, for every given $X \in C_c^{\infty}(U, \mathbb{R}^{m+n})$, if we let Φ_t be the one-parameter family of diffeomorphisms of U generated by X, then

$$\delta V(X) \coloneqq \left. \frac{d}{dt} \right|_{t=0} \| (\Phi_t)_{\sharp} V \| (U) = 0 \,.$$

Here $\psi_{\sharp}V$ denotes the varifold $(\psi(E), \Theta \circ \psi^{-1})$ when ψ is a C^1 diffeomorphism. It follows from Allard's monotonicity formula that, since V is integral and stationary, we can assume that, without loss of generality, E is $\operatorname{spt}(||V||) \cap U$ and Θ is given pointwise by the upper semicontinuous function

$$\Theta(V, x) = \lim_{r \downarrow 0} \frac{\|V\|(B_r(x))}{\omega_m r^m}$$

This gives a "canonical pair" (E, Θ) and rids us of any tedious discussion of \mathcal{H}^m -null sets.

Allard's classical interior regularity theory, developed in the pioneering work [1], implies that a stationary (integral) varifold is always regular in a relatively dense and open subset $\operatorname{Reg}(V) \subset \operatorname{spt}(V)$. This means that for every $x \in \operatorname{Reg}(V)$ there is a ball $\mathbf{B}_r(x)$ with the property that $\operatorname{spt}(V) \cap \mathbf{B}_r(x)$ is a smooth connected submanifold Σ and $||V|| \sqcup \mathbf{B}_{\rho}(x) = \Theta_0 \mathcal{H}^m \sqcup \Sigma$ for an appropriate integer costant $\Theta_0 \ge 1$. Even though 53 years have passed since the appearance of Allard's work we still do not know whether the complement of $\operatorname{Reg}(V)$ is \mathcal{H}^m -null (a natural expectation, given the known examples and some recent partial results like [12], is in fact that such complement has Hausdorff dimension m - 1). In [5] the first two authors and Stefano Decio proposed, as a first step towards the proof of the latter result, the following conjecture (see [5, Conjecture 1.4]).

Conjecture 1.1. Assume V is a stationary m-dimensional varifold in $U \subset \mathbb{R}^{m+n}$ and let $x_0 \in U$ be a point at which spt(V) has an approximate tangent and

$$\lim_{r \downarrow 0} \frac{\|V\|(\{\Theta(V, \cdot) \neq \Theta(V, x_0)\} \cap \mathbf{B}_r(x_0))}{r^m} = 0.$$

Then there is a smooth classical minimal m-dimensional graph \mathcal{M} in some neighborhood of x_0 with the property that

$$\int_{\mathbf{B}_r(x_0)} \operatorname{dist}(x, \mathcal{M})^2 \, \mathrm{d} \|V\|(x) = o(r^N) \qquad \text{for every } N \in \mathbb{N} \,.$$

In this paper we will prove a partial result in the above direction, in fact we will first prove the following " C^{∞} rectifiability" result.

Theorem 1.2 (Smooth rectifiability). Let V be an m-dimensional stationary varifold in an open set $U \subset \mathbb{R}^{m+n}$. Then V is C^{∞} -rectifiable. Namely, there exist countably many C^{∞} maps $f_k : \mathbb{R}^m \supset B_1^m \to U$ such that

$$||V|| \left(U \setminus \bigcup_k f_k(B_1^m) \right) = 0$$

But as a consequence of our approach we can also show the following.

Theorem 1.3. Assume V and x_0 satisfy the assumptions of Conjecture 1.1. Then there is a smooth classical (not necessarily minimal) m-dimensional graph \mathcal{M} in some neighborhood of x_0 with the property that

$$\int_{\mathbf{B}_r(x_0)} \operatorname{dist}(x, \mathcal{M})^2 \, \mathrm{d} \|V\|(x) = o(r^N) \qquad \text{for every } N \in \mathbb{N} \,.$$

This can be seen as an answer to a weaker (as we are not able to prove that \mathcal{M} is minimal!) version of Conjecture 1.1.

Before coming to a description of the strategy of our proof we wish to recall what is already known in the literature. First of all, it was pointed out by Brakke in [4] that, in combination with Almgren's theory of multivalued function, Allard's approach in [1] already implies the $C^{1,\alpha}$ rectifiability for every $\alpha < 1$: the submanifolds of the covering of the rectifiable set spt(V) can actually be chosen to be $C^{1,\alpha}$. A much more interesting development, due to Menne in [14], is the C^2 -rectifiability. In fact Menne's theorem applies to varifolds with bounded mean curvature and it is thus an optimal statement in his context.

2. Strategy of the proof

The most important idea of the proof is to modify the classical Allard–De Giorgi decay lemma. The latter shows that, under the hypothesis that in a given ball \mathbf{B}_{ρ} the density is constant and the (appropriately scaled) L^2 distance of the varifold to the best approximating plane π falls below a sufficiently small threshold $\kappa > 0$, then in a smaller ball with a proportional radius the same quantity is (less than) a fraction γ of what it is in \mathbf{B}_{ρ} . This ensures that such L^2 distance decays like a power law at many points, in turn giving the $C^{1,\alpha}$ regularity of the varifold in a neighborhood of each such point. From this Allard concludes the regularity of the varifold in a dense open subset of its support. The obstruction in showing that the singular set (the complement of the regular set) is \mathcal{H}^n null is in the assumption about the density. Brakke later pointed out in [4] that the assumption on the density can be suitably weakened if Allard's strategy is combined with Almgren's theory of multivalued functions: it is possible then to reach the same decay conclusion but the nature of the "new" density assumption only allows to *cover* \mathcal{H}^m -almost all the support of the varifold with countably many $C^{1,\alpha}$ submanifolds, hence concluding its $C^{1,\alpha}$ rectifiability (see [5] for a fresh take on the latter idea).

Our main point is to substitute the "best approximating plane π " with the "best approximating classical minimal surface" in the rescaled L^2 distance. Using all minimal surfaces we are able to reach a decay parameter γ arbitrarily small, while keeping the ratio between the scales fixed. We need to lower the threshold κ depending on γ and we need to adjust accordingly the assumption on the density. The decay lemma which we are able to reach is still good enough to show that at \mathcal{H}^m -a.e. point of the support the scaled L^2 distance to the "best minimal graph" decays faster than any power. In particular classical PDE estimates on (sufficiently flat) smooth minimal surfaces and a standard decomposition trick allows us to prove Theorem 1.2.

The idea that planes can be substituted with a larger class of models to gain directly more regularity is not new in the literature. For instance it has been used by Savin in [15]: in the latter reference the best approximating plane is substituted with the "best approximating parabola", allowing him to get directly to C^2 regularity for his notion of viscosity solution of the minimal surface system. In this work we push the latter idea to the extreme, reaching directly C^{∞} regularity.

In order to implement our strategy we need two technical tools which might be of independent interest. The first is a multivalued Lipschitz approximation à la Almgren (for varifolds) on the normal bundle of a C^2 submanifold M; our argument for this is a suitable modification of the one we give in [5] for the Almgren's approximation, which is alternative to Almgren's original approach in [2], adopted subsequently in [4] and [14]. The second is a generalization of the Allard's "tilt-excess inequality", for which we refer to [1, Lemma 8.13], [16, Lemma 22.2], and [7, Proposition 4.1]. The original tilt excess inequality of Allard can be understood as the counterpart of the well-known Caccioppoli inequality for solutions of elliptic PDEs, provided we think of the varifold as a suitable measure-theoretical generalization of a classical minimal graph. Our version can then be understood as the Caccioppoli-type inequality which we would conclude if it were possible to parametrize our stationary varifold as a graph over the normal bundle of a reference minimal surface M. In the proof we take advantage of ideas in the recent work [11].

2.1. **Decay lemma.** In this section we state the decay lemma which is at the core of our work. π^{\perp} denotes the orthogonal complement of the *m*-dimensional linear subspace π , while $B_r(x,\pi) = \mathbf{B}_r(x) \cap (x+\pi)$ and $\mathbf{C}_r(x,\pi) = B_r(x,\pi) + \pi^{\perp}$. π and x will be dropped if they are (respectively) $\pi_0 = \mathbb{R}^m \times \{0\}$ and the origin. We will moreover use the shorthand notation d_E for the distance to a set E and d_V as a shorthand notation for $d_{\operatorname{spt}(V)}$.

Definition 2.1 (δ -flatness). Let M be an m-dimensional submanifold of $\mathbf{C}_r \subset \mathbb{R}^{m+n}$. We say that M is δ -flat in \mathbf{C}_r if $M \cap \mathbf{C}_r$ is the the graph of a map $g \in C^2(B_r, \mathbb{R}^n)$ that satisfies the scale-invariant estimates

$$\sup_{x \in B_r} r^{-1} |g(x)| + |Dg(x)| + r |D^2 g(x)| \le \delta$$

Lemma 2.2 (Decay lemma). For every triple of integers $m, n, Q \ge 1$ there are positive constants $\eta_0, \varepsilon_0, \delta_0$, and C with the following property. Let V be an m-dimensional stationary varifold in \mathbf{C}_{100} and M a δ -flat minimal m-dimensional submanifold in \mathbf{C}_{200} such that $\delta \le \delta_0$,

$$\operatorname{spt}(V) \cap \mathbf{C}_{100} \subset \{(x, y) : |y| \le 1\},$$
(2.1)

$$Q - \frac{1}{2} < \frac{\|V\|(\mathbf{C}_{30})}{\omega_m 30^m} < Q + \frac{1}{2},$$
(2.2)

$$\frac{\|V\|(\mathbf{C}_{100})}{\omega_m 100^m} \le Q + \frac{1}{2}, \tag{2.3}$$

$$\boldsymbol{\eta} \coloneqq \frac{\|V\|(\{\Theta_V < Q\} \cap \mathbf{C}_{100})}{\omega_m 100^m} \le \eta_0, \quad and \tag{2.4}$$

$$\boldsymbol{\varepsilon} \coloneqq \left(\frac{1}{\omega_m 100^{m+2}} \int_{\mathbf{C}_{100}} d_M^2 \,\mathrm{d} \|V\|\right)^{1/2} \le \varepsilon_0 \,. \tag{2.5}$$

Then, there exists a m-dimensional minimal surface M', δ' -flat in \mathbf{C}_2 , such that

$$\left(\frac{1}{\omega_m} \int_{\mathbf{C}_1} d_{M'}^2 \,\mathrm{d} \|V\|\right)^{1/2} \le C(\sqrt{\eta} + \sqrt{\varepsilon})\varepsilon \quad and \quad \delta' \le \delta + C\varepsilon \,. \tag{2.6}$$

The assumptions of Lemma 2.2 imply in particular the following two facts, which are not directly related with the decay of the excess. First, not only V is close to M, but also M is close to V, in the L^2 sense. In particular, V "has no holes", in an integral sense. This is stated in (2.7). Second, whenever we have another δ -flat minimal surface M'' that satisfies a property similar to the one in (2.6), we can bound the distance of M'' to M. This is (2.8) and will play a key role in the derivation of the Whitney estimates that we use to show C^{∞} -rectifiability.

Lemma 2.3. Under the assumptions of Lemma 2.2, the following holds.

• There is a constant C which depends only on m, n and Q such that

$$\left(\frac{1}{\omega_m} \int_{M \cap \mathbf{C}_1} d_V^2 \, \mathrm{d}\mathcal{H}^m\right)^{1/2} \le C\varepsilon \,. \tag{2.7}$$

• Let x with |x| < 2 and let M" be an m-dimensional minimal surface which is δ_0 -flat in $\mathbf{C}_2(x)$ and

$$\left(\frac{1}{\omega_m} \int_{\mathbf{C}_1(x)} d^2_{M''} \,\mathrm{d} \|V\|\right)^{1/2} \le \sigma \,,$$

for a $\sigma > 0$ small enough, depending on m, n and Q. If we write M as the graph of g and M'' as the graph of g'' (over B_2), then

$$\|D^{l}(g-g'')\|_{L^{\infty}(B_{1/10}(x))} \leq C_{l}(\varepsilon+\sigma) \quad \text{for every } l \geq 0,$$

$$(2.8)$$

where C_l is a constant that depends only upon m, n, Q and l.

Remark 2.4. Under the assumptions of the Decay Lemma it is also true that (2.1), (2.2), and (2.3), holds at the smaller scale, i.e.

$$spt(V) \cap \mathbf{C}_{1} \subset \{(x, y) : |y| \le 1/100\},\$$
$$Q - \frac{1}{2} < \frac{\|V\|(\mathbf{C}_{3/10})}{\omega_{m}(3/10)^{m}} < Q + \frac{1}{2},\$$
$$\frac{\|V\|(\mathbf{C}_{1})}{\omega_{m}} \le Q + \frac{1}{2}.$$

Thus the only assumption which is not "carried over at the smaller scale" is (2.4). Notie however that (2.4) is always satisfied if Q = 1.

2.2. Elliptic estimates for the distance from a minimal surface. In this section we state our generalization of Allard's Tilt-excess inequality. A key tool are some properties of the distance function to a minimal surface. We will show, in particular, that, if M is a δ -flat minimal surface, then the function d_M^2 satisfies

$$\Delta_L \frac{1}{2} d_M^2(z) + \delta^2 d_M^2(z) \ge \frac{1}{4} |L - T_{p(z)} M|^2 \,,$$

where L is any m-dimensional subspace and $z \in \mathbb{R}^{m+n}$. As it is well-known, this type of elliptic inequality implies energy estimates as well as height bounds. We state these conclusions in the following two propositions.

Proposition 2.5 (Tilt-excess inequality). There are constants C and δ_0 which depends only on m and n with the following property. Assume that:

- (i) M is an m-dimensional smooth submanifold, δ -flat in \mathbf{C}_2 with $\delta \leq \delta_0$, and denote by $p: B_1(0, \pi_0) + B_1(0, \pi_0^{\perp}) \to M$ be the closest-point projection onto M.
- (ii) V is an m-dimensional stationary varifold in \mathbf{C}_1 , with $\operatorname{spt}(V) \subset B_1(0, \pi_0) + B_1(0, \pi_0^{\perp})$.

Then, $|T_z V - T_{p(z)} M|^2 \ge |D_V d_M|^2(z)$, and

$$\int_{\mathbf{C}_{1/2}} |T_z V - T_{p(z)} M|^2 \,\mathrm{d} \|V\|(z) \le C \int_{\mathbf{C}_1} d_M^2 + d_M |H_M \circ p| \,\mathrm{d} \|V\| \,. \tag{2.9}$$

Proposition 2.6 (Height bound). Under the same assumptions of Proposition 2.5,

$$\sup_{\text{spt}(V)\cap \mathbf{C}_{1/2}} d_M^2 \le C \Big(\int_{\mathbf{C}_1} d_M^2 \, \mathrm{d} \|V\| + \|V\|(\mathbf{C}_1) \sup_{\mathbf{C}_1 \cap M} |H_M|^2 \Big) \,, \tag{2.10}$$

where C depends on m and n.

Remark 2.7. Testing the stationarity of V with the vector field $\zeta^2 |z|^{2-m} D(d^2) - d^2 D(|z|^{2-m} \zeta^2)$, one can actually replace the left-hand side of (2.9) with

$$\int_{\mathbf{C}_{1/2}} |z|^{2-m} |T_z V - T_{p(z)} M|^2 \,\mathrm{d} \|V\|(z)\|$$

2.3. Lipschitz approximation on the normal bundle. In this section we state the Lipschitz approximation theorem for stationary varifolds on the normal bundle of sufficiently flat C^2 submanifolds of the same dimension. From now on we will use the notation B_r^M for the geodesic ball of M with radius r centered at $o := M \cap (\{0\} \times \mathbb{R}^n)$.

Theorem 2.8 (Lipschitz approximation). For any triple of integers $m, n, Q \ge 1$ there are constants ε_0 , δ_0 , and C with the following properties. Assume that

(i) M is a smooth m-dimensional submanifold, δ -flat in \mathbf{C}_{10} , with $\delta \leq \delta_0$;

(ii) V is an m-dimensional stationary varifold in C_5 , with

$$\frac{\|V\|(\mathbf{C}_5)}{\omega_m 5^m} \le Q + 1\,,\tag{2.11}$$

spt
$$V \subset \{(x, y) : |x| < 5, |y| < 1\},$$
 (2.12)

$$\mathbf{E} \coloneqq \frac{1}{\omega_m 5^m} \int_{\mathbf{C}_5} |T_x V - T_{p_M(x)} M|^2 \,\mathrm{d} \|V\|(x) \le \varepsilon_0 \,, \quad and \tag{2.13}$$

$$\frac{\|V\|(\mathbf{C}_3)}{\omega_m 3^m} \in (Q - \frac{1}{2}, Q + \frac{1}{2}).$$
(2.14)

Then, for any given $\lambda \in (0,1)$, there exist a Q-valued Lipschitz function $f: B_1^M \to \mathcal{A}_Q(\mathbb{R}^{m+n})$ and a Borel set $K \subset B_1^M$ such that

(a) $f(x) \in \mathcal{A}_Q(T_x^{\perp}M)$ for every $x \in B_1^M$;

(b) The following estimates hold:

$$\operatorname{Lip}(f) \le C(\lambda + \delta^2)^{1/2m}, \qquad (2.15)$$

$$|B_1^M \setminus K| + \|V\| \left(p_M^{-1}(B_1^M \setminus K) \right) \le \frac{C}{\lambda} \mathbf{E}, \qquad (2.16)$$

$$\sup_{x \in B_1^M} \mathcal{G}(f(x), Q[[0]]) \le C \sup_{x \in p_M^{-1}(B_1^M)} d_M(x);$$
(2.17)

- (c) for every $x \in K$, if $f(x) = \sum_h Q_h \llbracket p_h \rrbracket$, then $\operatorname{spt}(V) \cap p_M^{-1}(x) = \bigcup_h \{x + p_h\}$;
- (d) for every $x \in K$ and every $z \in p_M^{-1}(x) \cap \operatorname{spt}(V)$ we have

$$\Theta(z) = \sum_{h:p_h=y} Q_h \,. \tag{2.18}$$

3. Preliminaries

In this section we collect some preliminary notions and we state some results which are going to be useful throughout the paper. Their proofs will be deferred to the Appendix.

3.1. The geometric set-up. From now on we will always assume that M is an m-dimensional submanifold (of class at least C^2), which is δ_0 -flat in \mathbf{C}_2 . We will moreover fix an orthonormal frame $\{e_i(x)\}_{i=1,\dots,m+n}$, with C^1 dependence on $x \in M$, where the first m vectors are tangent to M and the last n vectors are normal to M. Fixing such a choice is convenient even though all the quantities which we define will in fact be independent of it.

The second fundamental form of M at x is the bilinear map II: $T_x M \times T_x M \to T_x M^{\perp}$ defined by $II(e,e') = (D_e e')^{\perp}$. Moreover, if $\nu(x)$ is a vector normal to $T_x M$, we define

$$\Pi_{\nu}(e,e') \coloneqq (D_e e') \cdot \nu = -e' \cdot D_e \nu = -e \cdot D_{e'} \nu \quad \text{for } e, e' \in T_x M \text{ and } \nu \in T_x^{\perp},$$

where, for the second equality, we fix any extension of $\nu(x)$ to a neighborhood of x as normal vector field. Recall that II is a tensor in e, e' and ν , as it is apparent from the equalities above. The mean curvature vector H (or H_M) is the trace of the second fundamental form II and is the only vector normal to M such that

$$H \cdot \nu = \sum_{i=1}^{m} \operatorname{II}_{\nu}(e_i, e_i) \quad \text{for every } \nu \in T_x^{\perp} M.$$

Throughout the paper, without further mention, we will assume that the flatness parameter δ is smaller than a positive constant δ_0 , chosen in terms of m and n only. The choice must guarantee that:

- the affine planes x + T[⊥]_xM do not intersect in B^m₂ × Bⁿ₂₀₀ for distinct x's;
 any point z ∈ B^m_{1.99} × Bⁿ₂₀₀ has a unique closest point projection p(z) ∈ M ∩ C₂;
 the map p (often denoted p_M) is C¹ (and in fact C^k if M is of class C^{k+1} for k ∈ N \ {0} ∪ {∞, ω}).

It is easy to see that an homothetic rescaling around a point of M by a factor $\lambda \geq 1$ preserves the latter properties for the intersection of the rescaled M with $\mathbf{C}_2(x)$.

It is useful to compute the differential of p at a point z (which does not necessarily belong to M).

Lemma 3.1. Splitting $\mathbb{R}^{n+m} = T_{p(z)}M \times T_{p(z)}M^{\perp}$, the Jacobi matrix of Dp(z) can be written in block form as

$$Dp(z) = \begin{bmatrix} \left(\operatorname{Id}_m - \operatorname{II}_{z-p(z)} \right)^{-1} & 0\\ 0 & 0 \end{bmatrix}.$$

In particular,

$$Dp(z) = \sum_{i,j=1}^{m} \left(\delta_{ij} + \mathrm{II}_{z-p(z)}(e_i, e_j) \right) e_i \otimes e_j + O(\delta^2 |z - p(z)|^2) \,.$$

Second, we recall that d_M^2 is C^k if M is of class C^{k+1} for $k \ge \mathbb{N} \setminus \{0\} \cup \{\infty, \omega\}$) and (when the manifold is C^3) its Hessian contains information on the curvature of M.

Lemma 3.2. Assume that the frame e_1, \ldots, e_m at p(z), diagonalizes the quadratic form $\prod_{z-p(z)/|z-p(z)|}$, and let $\kappa_1, \ldots, \kappa_m$ be the respective eigenvalues. In particular, $\sum_{j=1}^m \kappa_j = H(p(z)) \cdot \frac{z-p(z)}{|z-p(z)|}$. Then, with respect to this basis, ¹

$$\frac{1}{2}D^2 d_M^2(z) = -\sum_{j=1}^m \frac{d_M(z)\kappa_j(z)}{1 - \kappa_j(z)d_M(z)} e_j \otimes e_j + \sum_{i=m+1}^{m+n} e_i \otimes e_i$$

3.2. Sections of the normal bundle of M. As we wish to approximate the varifold V with a graph over M, it is natural to recall the notion of section of the normal bundle of M. A "normal section of M" is simply a map $f: U \to \mathbb{R}^{m+n}$ such that $f(x) \in T_x M^{\perp}$ for all $x \in U$, and $U \subset M$ is some open set. We will then call the set

$$\Gamma_f \coloneqq \{x + f(x) : x \in U\}$$

the "graph of f". Whenever $e \in T_x M$ we define $D_e f$ as

$$D_e f(x) \coloneqq (D_e f_1(x), \dots, D_e f_{m+n}(x)) \in \mathbb{R}^{n+m},$$

and

$$|Df(x)|^2 := \sum_{i=1}^m \sum_{j=1}^{m+m} |D_{e_i}f_j(x)|^2.$$

While sections form a linear space, we warn the reader that $D_e f(x)$, will not be necessarily a normal section, just a map from M to \mathbb{R}^{m+n} .

With these definitions, we can naturally define function spaces of sections of M of various regularity and integrability, such as C^{α} , L^{p} , $W^{1,p}$, and so on. For instance the $C^{\alpha}(U, \nu M)$ will denote the set of functions $f: U \to \mathbb{R}^{n+m}$ which are Hölder continuous with exponent α in $U \subset M$ and whose value at x perpendicular to $T_{x}M$. More intrinsic definitions are possible, but for our purposes, since M is a perturbation of an m-dimensional plane, they are all equivalent.

3.3. The Jacobi operator. The "stability operator of M" or "Jacobi operator of M" is the linear differential operator on M obtained by linearizing the minimal surface system over the normal bundle of a fixed minimal surface M, which maps normal sections of M to normal sections of M. The operator can be written as

$$\mathcal{L}_M f = (\Delta_M f)^{\perp} + 2\Pi_f : \Pi_f$$

where, if $f = (f_1, \ldots, f_{n+m}), \Delta_M f$ is defined as²

$$\Delta_M f)^{\perp}(x) = P_{T_x^{\perp}M}(\Delta_M f_1(x), \dots, \Delta_M f_{n+m}(x)) \in T_x M^{\perp} \quad \text{for } x \in M ,$$
(3.1)

$$\int_{M} f \cdot \Delta^{\perp} \varphi = -\int_{M} (Df)^{\perp} \cdot (D\varphi)^{\perp} \quad \text{for all } f\varphi \in C_{c}^{1}(M, \nu M) \,.$$

So, in general, $\Delta^{\perp} f$ is *different* from $(\Delta_M f)^{\perp}$, which explains the factor 2 in (3.1).

¹ The fact that κ_j are the eigenvalues of $\prod_{z-p(z)/|z-p(z)|}$ was conjectured, but not proved, in [3, Remark 3.3].

² Using the intrinsic Laplacian of νM , usually denoted as Δ^{\perp} , one has instead the expression $\mathcal{L}_M f = \Delta^{\perp} f + \Pi_f$: II, which often appears in literature, see e.g. [13]. More precisely, $\Delta^{\perp} f$ is defined in such a way that

and II_f : II is the normal section given by

$$II_f : II(x) \coloneqq \sum_{i,j=1}^m II_f(e_i, e_j)II(e_i, e_j)$$

All these expressions do not depend on the choice of the orthonormal frame.

We can give a weak form of the stability operator through the bilinear operator

$$-\langle \mathcal{L}_M f, g \rangle = \int_M \left(Df : Dg - 2\mathrm{II}_f : \mathrm{II}_g \right) = \int_M \sum_{i=1}^m \left(\sum_{j=1}^{m+n} D_{e_i} f_j \cdot D_{e_i} g_j - 2\mathrm{II}_f : \mathrm{II}_g \right),$$

which is defined for $f, g \in H_0^1(B_1^M, \nu M)$. From a general standpoint, \mathcal{L}_M is a strongly elliptic operator with smooth coefficients and enjoys regularity properties analogous to the usual Δ_M . We will need some results from the theory of linear elliptic systems.

Lemma 3.3 ($W^{2,p}$ bounds). Given a section $f \in L^{\infty}(B_1^M, \nu M)$, there exists a unique section $u \in H_0^1(B_1^M, \nu M)$ such that

$$\int_{M} \left(Du : D\varphi - 2II_{u} : II_{\varphi} \right) = \int_{M} f \cdot \varphi \quad \text{for all } \varphi \in C_{c}^{1}(B_{1}^{M}, \nu M)$$

Furthermore, $u \in C^1(B_1^M, \nu M)$ and

$$||u||_{C^1(B_1^M)} \le C ||f||_{L^{\infty}(B_1^M)},$$

where C depends only on m, n and δ_0 .

Lemma 3.4 (Harmonic replacement). Given a section $v \in \text{Lip}(B_1^M, \nu M)$, there exists a unique section $w \in H^1(B_1^M, \nu M)$ such that $w - v \in H^1_0(B_1^M, \nu M)$ and

$$\int_{M} \left(Dw : D\varphi - 2\Pi_{w} : \Pi_{\varphi} \right) = 0 \quad \text{for all } \varphi \in C_{c}^{1}(B_{1}^{M}, \nu M)$$

Furthermore, $w \in C^{\infty}(B_1^M, \nu M)$ and

$$\|w\|_{C^{2,1/2}(B_1^M)} \le C \|w\|_{L^{\infty}(B_1^M)} \le C^2 \|v\|_{L^{\infty}(B_1^M)}, \qquad (3.2)$$

where C depends only on m, n and δ_0 .

This shows in particular that if $\mathcal{L}_M w = 0$ and w = 0 on the boundary, then w = 0, provided δ_0 is small.

3.4. The minimal surface system and its linearization. Given a normal section f of M, let $\Gamma_f = \{(x + f(x) : x \in M\}$ be its graph. If the size of f (in a sense which will be specified below) is a small number $\varepsilon > 0$, we will then assert the well known-expansion expansion (again in a sense which will be specified further)

$$H_{\Gamma_f} = H_M + \mathcal{L}_M f + O(\varepsilon^2), \qquad (3.3)$$

where $H_{\Gamma_f}(x) \in \mathbb{R}^{m+n}$ is the mean curvature vector of Γ_f at the point x + f(x). We will in fact need two versions of (3.3), depending on how we measure the "size" of f. The first is suited for the case when f is merely Lipschitz.

Lemma 3.5. There are constants C and $\ell > 0$, depending only on m and n such that the following holds for every δ_0 smaller than a positive geometric constant. Assume that M is a δ_0 -flat minimal surface in \mathbb{C}_2 and let $f \in \operatorname{Lip}(B_1^M, \nu M)$ with $\operatorname{Lip}(f) \leq \ell$. Then the following identity holds for every $\varphi \in C^1(B_1^M, \nu M)$

$$\operatorname{div}_{\Gamma_f}(\varphi \circ p)(x + f(x)) = \left(Df : D\varphi - 2\operatorname{II}_f : \operatorname{II}_\varphi\right)(x) + R(x) \quad \text{for } \mathcal{H}^m \text{-a.e. } x \in B_1^M,$$

where the error term R satisfies the estimate

$$|R| \le C|D\varphi| (\delta_0|f| + |Df|)^2 \qquad \mathcal{H}^m \text{-a.e. on } B_1^M$$

Moreover,

$$|Df(x)|^2 \le C(\delta_0^2 |f(x)|^2 + |T_x M - T_{x+f(x)} \Gamma_f|^2)$$
 for \mathcal{H}^m -a.e. $x \in B_1^M$.

In the second version of (3.3) we assume in addition that f is $C^{2,\alpha}$.

Lemma 3.6. There are constants C and $\ell > 0$ such that the following holds for all $\delta_0 > 0$ small enough. Assume M is a δ_0 -flat minimal surface in \mathbf{C}_2 and let $f \in C^{2,1/2}(B_1^M, \nu M)$ be such that $\|f\|_{C^1} \leq \ell$ small enough. Then

$$\|H_{\Gamma_f}(x+f(x)) - \mathcal{L}_M f(x)\|_{C^{1/2}(B_1^M)} \le C \|f\|_{C^{2,1/2}(B_1^M)}^2.$$

From (3.3) one can solve the minimal surface equation with an inverse function argument since the linearized operator \mathcal{L}_M is invertible.

Lemma 3.7 (Classical solutions to the minimal surface system). There are geometric constants $\varepsilon_0 > 0$, $\delta_0 > 0$, and C, such that the following holds. Let M be a δ -flat minimal surface in \mathbf{C}_2 with $\delta < \delta_0$ and assume that $h \in C^{2,1/2}(B_1^M, \nu M)$ satisfies

$$\mathcal{L}_M h = 0$$
 and $\boldsymbol{\varepsilon} \coloneqq \|h\|_{C^{2,1/2}(B^M_i)} \le \varepsilon_0$

Then there exists $h' \in C^{2,1/2}(B_1^M, \nu M)$ such that its graph is a classical minimal surface and

$$||h - h'||_{C^{2,1/2}(B_1^M)} \le C\varepsilon^2$$
.

In particular, $\Gamma_{h'}$ is $(\delta + C\varepsilon)$ -flat in $\mathbf{C}_{1/2}$.

3.5. Some results on stationary varifolds. We define the tilt-excess in the cylinder $C_r(x, \pi')$, with respect to π as

$$\mathbf{E}(V, \mathbf{C}_{r}(x, \pi'), \pi) \coloneqq \frac{1}{\omega_{m} r^{m}} \int_{\mathbf{C}_{r}(x, \pi')} |T_{y}V - \pi|^{2} \,\mathrm{d} \|V\|(y) \,.$$

We write $\mathbf{E}(V, \mathbf{C}_r(x, \pi))$ in place of $\mathbf{E}(V, \mathbf{C}_r(x, \pi), \pi)$ and, as usual, we omit x when it is 0 and π when it is $\pi_0 = \mathbb{R}^m \times \{0\}$.

The following two results are taken from [5], see also the references therein.

Lemma 3.8. Let V be an m-dimensional integral varifold stationary in \mathbf{C}_1 and let $Q \in \mathbb{N}$. Let $0 < r_1 < r_2 < 1$ and let $\eta \in (0, \frac{1}{2})$. Assume that $\mathbf{E}(V, \mathbf{C}_1)$ is small enough, depending on m, n, Q, r_1 , r_2 and η , and that $\frac{\|V\|(\mathbf{C}_1)}{\omega_m} \leq Q + \frac{3}{4}$. Then, there exists $Q' \in \{0, \ldots, Q\}$ such

$$\frac{\|V\|(\mathbf{C}_r(x))}{\omega_m r^m} \in (Q' - \eta, Q' + \eta) \quad \text{for any } x \in \mathbf{C}_1 \text{ and any } r > r_1 \text{ with } \mathbf{C}_r(x) \subset \mathbf{C}_{r_2}.$$

Theorem 3.9 (Height bound). Let V be an m-dimensional integral varifold stationary in \mathbf{C}_1 , let $Q \in \mathbb{N}$, and let $r \in (0,1)$. Assume that $\mathbf{E} := \mathbf{E}(V, \mathbf{C}_1)$ is small enough, depending on m, n, Q and r, and that $\frac{\|V\|(\mathbf{C}_1)}{\omega_m} \leq Q + \frac{1}{2}$. Then, there exist a constant C depending on m, n, Q and r, and points $y_1, \ldots, y_Q \in \mathbb{R}^n$ such that

$$\operatorname{spt}(V) \cap \mathbf{C}_r \subset \bigcup_{h=1,\dots,Q} \mathbb{R}^m \times B_{C\mathbf{E}^{1/(2m)}}(y_h)$$

Moreover, if $\Theta(V,0) = Q$, then

$$\operatorname{spt}(V) \cap \mathbf{C}_r \subset \mathbb{R}^m \times B_{C\mathbf{E}^{1/2}}(0)$$

4. Proof of the tilt excess inequality and of the height bound

In this section we prove the tilt-excess inequality of Proposition 2.5 and the height bound of Proposition 2.6. We will use the following well-known fact in linear algebra, of which we include the elementary proof for the reader's convenience. Given a symmetric matrix $M \in \mathbb{R}^{d \times d}$ and a linear subspace $V \subset \mathbb{R}^d$ we will use $\operatorname{tr}_V(M)$ for the trace of $p_V \cdot M$, where p_V is the orthogonal projection onto V.

Lemma 4.1. Let $M \in \mathbb{R}^{d \times d}$ be symmetric and let $\lambda_1 \leq \ldots \leq \lambda_d$ be its eigenvalues. Let V be a k-dimensional subspace of \mathbb{R}^d , with $d \geq k$. Then $\operatorname{tr}_V(M) \geq \lambda_1 + \ldots + \lambda_k$.

Proof. We choose an orthonormal basis of \mathbb{R}^d , e_1, \ldots, e_d , for which M takes the form $M = \sum_{i=1}^d \lambda_i e_i \otimes e_i$. Take also ξ_1, \ldots, ξ_k orthonormal basis for V. Therefore,

$$\operatorname{tr}_V(M) = \sum_{i=1}^d \sum_{j=1}^k \lambda_i e_i \otimes e_i : \xi_j \otimes \xi_j = \sum_{i=1}^d \sum_{j=1}^k \lambda_i (e_i \cdot \xi_j)^2.$$

Now, write $\beta_i \coloneqq \sum_{j=1}^k (e_i \cdot \xi_j)^2$. Notice that $\beta_i \in [0,1]$ with $\sum_{i=1}^d \beta_i = k$, as e_1, \ldots, e_d is an orthonormal basis. The claim then follows from the observation that

$$\sum_{i=1}^d \lambda_i \beta_i \ge \sum_{i=1}^k \lambda_i$$

which is quickly proved:

$$\sum_{i=1}^{k} (1-\beta_i)\lambda_i \le \lambda_k \sum_{i=1}^{k} (1-\beta_i) = \lambda_k \sum_{i=k+1}^{d} \beta_i \le \sum_{i=k+1}^{d} \beta_i \lambda_i.$$

4.1. Proof of Propositions 2.5. To simplify our notation we write d for d_M and p for p_M . Fix $z \in \operatorname{spt}(V)$ and let e_1, \ldots, e_m be an orthonormal basis for $T_{p(z)}M$, and let e_{m+1}, \ldots, e_{m+n} be an orthonormal basis for $T_{p(z)}^{\perp}M$ with $e_{m+1} = Dd(z) = \frac{z-p(z)}{|z-p(z)|}$. Assume that e_1, \ldots, e_m diagonalize $\operatorname{II}_{e_{m+1}}$, with eigenvalues $\kappa_1, \ldots, \kappa_m$, and recall that $\kappa_1 + \cdots + \kappa_m = H(p(z)) \cdot e_{m+1}$. Recall that by Lemma 3.2 we have

$$\frac{1}{2}D^2d^2(z) = \underbrace{\sum_{i=1}^m -\frac{d(z)\kappa_i(z)}{1-\kappa_i(z)d(z)}e_i \otimes e_i}_{=:A} + \underbrace{\sum_{i=m+1}^{m+n} e_i \otimes e_i}_{=:B}.$$

Step 1. We claim that, for each $z \in \operatorname{spt}(V) \cap C_{6/7}$,

$$\Delta_V \frac{1}{2} d^2 \ge \frac{1}{4} |T_z V - T_{p(z)} M|^2 - |H| d - 2|II| d^2.$$
(4.1)

Denote by ξ_1, \ldots, ξ_m be an orthonormal basis for $T_z V$. We compute

$$\Delta_V \frac{d^2}{2} = \sum_{j=1}^m D^2 \frac{d^2}{2}(z) : \xi_j \otimes \xi_j = \sum_{j=1}^m \left(A + \frac{1}{2}B\right) : \xi_j \otimes \xi_j + \frac{1}{2} \sum_{j=1}^m B : \xi_j \otimes \xi_j .$$

Now we deal with the first summand. The matrix $A + \frac{1}{2}B$ has eigenvalues $-\frac{d\kappa_1}{1-\kappa_1 d}, \ldots, -\frac{d\kappa_m}{1-\kappa_m d}, \frac{1}{2}, \ldots, \frac{1}{2}$; since M is sufficiently flat (depending upon a geometric quantity) and $d \leq 1$ on spt V,

$$\frac{d|\kappa_i(z)|}{|1-\kappa_i(z)d(z)|} \le \frac{1}{4} \qquad \text{for all } i=1,\ldots,m \,.$$

By Lemma 4.1 we then have the lower bound

$$\sum_{j=1}^{m} \left(A + \frac{1}{2}B\right) : \xi_j \otimes \xi_j \ge \sum_{i=1}^{m} \frac{d\kappa_i}{1 - \kappa_i d} = d H(p(z)) \cdot Dd - d^2 \sum_{i=1}^{m} \frac{\kappa_i^2}{1 - \kappa_i d}$$
$$\ge -d|H(p(z))| - 2|\mathrm{II}(p(z))|^2 d^2 \,.$$

For what concerns the second summand, clearly

$$\frac{1}{2}\sum_{j=1}^{m}B:\xi_{j}\otimes\xi_{j}=\frac{1}{2}\sum_{i=m+1}^{m+n}\sum_{j=1}^{m}(e_{i}\cdot\xi_{j})^{2}=\frac{1}{4}|T_{z}V-T_{p(z)}M|^{2}.$$

We thus conclude (4.1). Notice in passing that

$$\frac{1}{2}|T_z V - T_{p(z)}M|^2 \ge \sum_{i=m+1}^{m+n} \sum_{j=1}^m (e_i \cdot \xi_j)^2 \ge |D_V d|^2,$$
(4.2)

as $Dd \in T_{p(z)}^{\perp}M$.

Step 2. We prove (2.9). We test the first variation with $X = \zeta^2 D \frac{d^2}{2}$ and find

$$\begin{split} 0 &= \int \operatorname{div}_{V} \left(\zeta^{2} D \frac{d^{2}}{2} \right) \mathrm{d} \|V\| = 2 \int \zeta \mathrm{d} D_{V} \zeta \cdot D_{V} \mathrm{d} \, \|V\| + \int \zeta^{2} \Delta_{V} \frac{d^{2}}{2} \, \mathrm{d} \|V\| \\ &\geq -4 \int d^{2} |D_{V} \zeta|^{2} \, \mathrm{d} \|V\| - \frac{1}{4} \int \zeta^{2} |D_{V} d|^{2} \, \mathrm{d} \|V\| + \int \zeta^{2} \Delta_{V} \frac{d^{2}}{2} \, \mathrm{d} \|V\| \\ &\geq -4 \int d^{2} |D_{V} \zeta|^{2} \, \mathrm{d} \|V\| - \frac{1}{8} \int \zeta^{2} |T_{z} V - T_{p(z)} M|^{2} \, \mathrm{d} \|V\| + \frac{1}{4} \int \zeta^{2} |T_{z} V - T_{p(z)} M|^{2} \, \mathrm{d} \|V\| \\ &\quad - \int \zeta^{2} |H| d \, \mathrm{d} \|V\| - 2 \int \zeta^{2} |\mathrm{II}| d^{2} \, \mathrm{d} \|V\| \,. \end{split}$$

Rearranging terms and recalling $|II| \leq \delta_0 \leq 1$, we get (2.9). We turn to the proof of (2.10).

4.2. Proof of Proposition 2.6. We start with a computation which is well-known when V is a classical minimal surface (see e.g. [6]). Here we present a variation of the rigorous argument given in [11] when V is an integral stationary varifold. With the same definition of $g_{r,s}$ as in [11], we replace [11, (2.6)] by

$$\operatorname{div}_{V}\left(\frac{d^{2}}{2}Dg_{r,s} - g_{r,s}D\frac{d^{2}}{2}\right) = \frac{d^{2}}{2}\Delta_{V}g_{r,s} - g_{r,s}\Delta_{V}\frac{d^{2}}{2} \leq -\frac{1}{2}\frac{d^{2}\mathbf{1}_{\mathbf{B}_{r}(0)}}{\omega_{m}r^{m}} + \frac{1}{2}\frac{d^{2}\mathbf{1}_{\mathbf{B}_{s}(0)}}{\omega_{m}s^{m}} - g_{r,s}(-|H|d-2|\mathrm{II}|d^{2}),$$

$$(4.3)$$

where $\mathbf{1}_E$ is the indicator function of a E and we have used the inequality $\Delta_V g_{r,s} \leq -\frac{\mathbf{1}_{\mathbf{B}_r(0)}}{\omega_m r^m} + \frac{\mathbf{1}_{\mathbf{B}_s(0)}}{\omega_m s^m}$. Therefore, if we set

$$I(r) \coloneqq \frac{1}{\omega_m r^m} \int_{\mathbf{B}_r} \frac{d^2}{2} \,\mathrm{d} \|V\|\,,$$

we integrate the inequality (4.3) in \mathbf{B}_s to obtain

$$I(s) - I(r) \ge -\int g_{r,s} |H| d \, \mathrm{d} ||V|| - 2 \int g_{r,s} d^2 \, \mathrm{d} ||V||$$
$$\ge -\int g_{r,s} |H|^2 \, \mathrm{d} ||V|| - 4 \int g_{r,s} d^2 \, \mathrm{d} ||V||$$

where we have used that $g_{s,r}$ vanishes outside \mathbf{B}_s and $|\mathrm{II}| \leq C\delta_0 \leq 1$ (since δ_0 can be chosen sufficiently small). Recalling from [11] the bound $\left|\frac{g_{r,s}}{s-r}\right| \leq Cr^{1-m}$, we can divide the above by s-r and let $s \downarrow r$ to obtain, in the sense of distributions,

$$I'(r) \ge -\frac{Cr}{r^m} \int_{\mathbf{B}_r(0)} |H|^2 \,\mathrm{d} ||V|| - CrI(r) \ge -C ||V|| (\mathbf{B}_1(0)) r \sup_{\mathbf{C}_1 \cap M} |H|^2 - CrI(r)$$

This means that $(I(r)+C||V||(\mathbf{B}_1(0))\sup_{\mathbf{B}_1(0)\cap M}|H|^2)e^{Cr}$ is increasing. Now, $I(r) \to \Theta(V,0)\frac{1}{2}d^2(0)$ as $r \downarrow 0$. On the other hand $\Theta(V,0) \ge 1$ if $0 \in \operatorname{spt}(V)$ (because $\Theta(V,\cdot)$ is upper semicontinuous and $\Theta(V,x) \ge 1$ for \mathcal{H}^m -a.e. $x \in \operatorname{spt}(V)$). Thus we obtain that, if $0 \in \operatorname{spt}(V)$,

$$d^{2}(0) \leq C\left(\frac{1}{r^{m}} \int_{\mathbf{B}_{r}(0)} d^{2} \,\mathrm{d} \|V\| + \|V\|(\mathbf{C}_{1}) \sup_{\mathbf{C}_{1} \cap M} |H|^{2}\right) \quad \text{for every } r \in (0,1) \,.$$

We repeat the argument with $r = \frac{1}{2}$ and $x \in \operatorname{spt}(V) \cap \mathbf{C}_{1/2}$ to obtain

$$d^{2}(x) \leq C\left(2^{m} \int_{\mathbf{B}_{1/2}(x)} d^{2} \,\mathrm{d} \|V\| + \|V\|(\mathbf{C}_{1}) \sup_{\mathbf{C}_{1} \cap M} |H|^{2}\right) \leq C\left(\int_{\mathbf{B}_{1}(0)} d^{2} \,\mathrm{d} \|V\| + \|V\|(\mathbf{C}_{1}) \sup_{\mathbf{C}_{1} \cap M} |H|^{2}\right).$$

5. The Lipschitz approximation

This section is dedicated to prove Theorem 2.8.

We first notice that, without loss of generality, we can assume that λ is smaller than a positive geometric quantity, which will be chosen depending only on m, n and Q. We let $g: B_{10} \to \mathbb{R}^n$ be such that M is the graph of f and we recall that, since M is δ -flat with $\delta \leq \delta_0$, we can assume $||g||_{C^2} \leq \delta$.

We next define the "non-centered" maximal function as

$$B_3^M \ni x \mapsto \mathbf{me}(x) \coloneqq \sup_{x \in B_s^M(y) \subset B_4^M} \mathbf{E}(V, \mathbf{C}_s(y, T_yM)),$$

where we notice that, if δ is small enough and $B_s^M(y) \subset B_4^M$, then $\mathbf{C}_s(y, T_yM) \cap \operatorname{spt}(V) \subset \mathbf{C}_{9/2}$. We remark also that, if δ is small enough, then, for any $B_{2s}^M(y) \subset B_4^M$, we have the inclusions

$$\mathbf{C}_{s}(y, T_{y}M) \cap \operatorname{spt}(V) \subset p_{M}^{-1}(B_{3s/2}^{M}(y)) \cap \operatorname{spt}(V) \subset \mathbf{C}_{2s}(y, T_{y}M) \cap \operatorname{spt}(V).$$
(5.1)

The first inclusion follows because we can assume that p_M is 3/2-Lipschitz, provided δ is small enough. We next argue for the second inclusion. Take $z \in p_M^{-1}(B^M_{3s/2}(y)) \cap \operatorname{spt}(V)$ and set $z' := p_M(z) \in B^M_{3s/2}(y)$. Then,

$$|p_{T_yM}(z-z')| \le |p_{T_yM} - p_{T_{z'}M}||z-z'| + |p_{T_{z'}M}(z-z')| \le s/2,$$

again provided that δ is small enough.

For the rest of the proof we set our choice of K, which is

$$K \coloneqq \{x \in B_1^M : \mathbf{me}(x) \le \lambda + \omega_m(Q+1)1000^m \delta^2 \eqqcolon \tilde{\lambda}\}.$$

K is clearly closed and up to removal of an \mathcal{H}^m -null set we can also assume that Θ is integer-valued over $p_M^{-1}(K)$ (note that in the statement K is claimed to be just a Borel set).

Step 1. Let W be a stationary varifold in \mathbf{C}_5 , with $\frac{||W||(\mathbf{C}_5)}{\omega_m 5^m} \leq Q + 1$. Take $B_{\rho}^M(x) \subset B_4^M$ and assume the existence of a constant $\mu \in (0, 1)$ such that

$$\mathbf{E}(W, \mathbf{C}_s(y, T_y M)) \le \mu \qquad \text{for every } B^M_\rho(x) \subset B^M_s(y) \subset B^M_4 , \qquad (5.2)$$

We claim that, if μ and δ are small enough (depending upon m, n and Q), there is $Q' \in \{0, \dots, Q\}$ such that $\|W\|(\mathbf{C}_s(y, T_y M)) \in (Q' - 1, Q' + 1)$ for $M(Q) \in \mathcal{B}^M(Q) \in \mathcal{B}^M(Q)$ (5.2)

$$\frac{W \| (\mathbf{C}_s(y, T_y M))}{\omega_m s^m} \in (Q' - \frac{1}{2Q}, Q' + \frac{1}{2Q}) \quad \text{for every } B^M_\rho(x) \subset B^M_s(y) \subset B^M_{7/2}(0).$$
(5.3)

Notice that, in particular, if $x \in B_1^M$ is such that (5.2) holds for every $x \in B_s^M(y) \subset B_4^M$, then (5.3) holds for every $x \in B_s^M(y) \subset B_{7/2}^M$.

For the proof of the claim, we start from the following remark. For any $\eta_0 \in (0,1)$ there is a choice of δ and μ such that, if $B_s^M(y) \subset B_{7/2}^M$, then

$$\mathbf{C}_{s}(y,\pi_{0}) \cap \operatorname{spt}(V) \subset \mathbf{C}_{s+\eta_{0}}(y,T_{y}M) \cap \operatorname{spt}(V),$$

$$\mathbf{C}_{s}(y,T_{y}M) \cap \operatorname{spt}(V) \subset \mathbf{C}_{s+\eta_{0}}(y,\pi_{0}) \cap \operatorname{spt}(V).$$

We now notice, choosing y = 0, that

$$\mathbf{E}(W,\mathbf{C}_4) \leq \mu$$
 .

In particular, if μ is small enough, Lemma 3.8 applies with parameters $r_1 = 1/128$, $r_2 = 15/16$, and $\eta = 1/(4Q)$, yielding $Q' \in \{0, \ldots, Q\}$. Thus, for every $B_r(z, \pi_0) \subset B_{15/4}$ with $r > \frac{1}{32}$, we have that $\frac{\|W\|(\mathbf{C}_r(z,\pi_0))}{\omega_m r^m} \in (Q' - \frac{1}{4Q}, Q' + \frac{1}{4Q})$. Notice in passing that, if (2.14) holds for W for some integer Q'', then Q' = Q''. By the considerations above, for every $B_s^M(y) \subset B_{29/8}^M$ with $s \ge \frac{1}{16}$ we conclude

$$\frac{\|W\|(\mathbf{C}_s(y, T_y M))}{\omega_m s^m} \in (Q' - \frac{1}{2Q}, Q' + \frac{1}{2Q}),$$
(5.4)

provided that η_0 and δ are small enough. Take any $B_{\rho}^M(x) \subset B_s^M(y) \subset B_{7/2}^M$ as above. If $s \geq \frac{1}{16}$, then (5.3) follows from (5.4). In the case $s < \frac{1}{16}$, we argue as follows. For $l \geq 0$, consider the cylinders $\mathbf{C}^l := \mathbf{C}_{1/2^{l+3}}(y, T_y M)$, notice that $B_{1/2^{l+3}}^M(y) \subset B_{29/8}^M$. We claim that, by induction, (5.3) holds for $s = 2^{-l-3}$, for every $l \geq 1$ with $B_{\rho}^M(x) \subset B_{2^{-l-3}}^M(y)$. The base case is observed above. For the inductive step at l + 1, we use (the scale-invariant form of) Lemma 3.8 on $\mathbf{C}^{l-1}(y)$, with the inductive assumption. For general *s*, there exists a unique $l' \in \mathbb{N}$, $l' \geq 1$, with $s \in [2^{-l'-4}, 2^{-l'-3})$, then we use again Lemma 3.8 on $\mathbf{C}^{l'-1}(y)$ together with the claim for $s = 2^{-l'-3}$.

Step 2. From now on we fix a μ such that the conclusions of the previous step apply and we impose that $\tilde{\lambda} \leq \mu$. Now, since Step 1 applies, recall that the integer Q' as in (5.3) for Q = V must in fact be Q by (2.14), as we have already noticed in the arguments at Step 1.

Step 3. Now take $x \in K$ and $x \in B_s^M(y) \subset B_3^M$ and consider $B_{7s/6}^M(y) \subset B_{7/2}^M$. We can assume that $\tilde{\lambda}$ is small enough (depending upon m, n and Q) to apply Theorem 3.9 with $\bar{r} = \frac{6}{7}$. Hence, by (the scale-invariant version of) Theorem 3.9 applied to $\mathbf{C}_{7s/6}(y, T_yM)$ (recalling Step 1 for the bound on the measure), there exist $S_1^{y,s}, \ldots, S_{N^{y,s}}^{y,s}$ open and pairwise disjoint subsets of $T_y^{\perp}M$, with $\operatorname{diam}(S_h^{y,s}) \leq D\tilde{\lambda}^{1/(2m)}s$ (with $D \leq C$, but independent of y and s) and $N^{y,s} \leq Q$, such that

$$\operatorname{spt}(V) \cap \mathbf{C}_s(y, T_y M) \subset \bigcup_{h=1,\dots,N^{y,s}} B_s(y, T_y M) + S_h^{y,s} \,.$$
(5.5)

We also assume that for every h, $\operatorname{spt}(V) \cap \mathbf{C}_s(y, T_yM) \cap (B_s(y, T_yM) + S_h^{y,s}) \neq \emptyset$. Set then $V_h^{y,s} := V \sqcup (B_s(y, T_yM) + S_h^{y,s})$, notice that $V_h^{y,s}$ is a stationary varifold in $\mathbf{C}_s(y, T_yM)$. Moreover, again by (the scale-invariant version of) **Step 1** (for both V_h and V), we obtain that there exist $Q_h^{y,s} \in \{0, \ldots, Q\}$ with $\sum_h Q_h^{y,s} = Q$ and

$$\frac{|V_h^{y,s}|(\mathbf{C}_{\rho}(y',T_{y'}M))}{\omega_m \rho^m} \in (Q_h^{y,s} - \frac{1}{2Q}, Q_h^{y,s} + \frac{1}{2Q}) \quad \text{for every } B_{\rho}^M(y') \subset B_{7s/10}^M(y) \text{ intersecting } K.$$
(5.6)

Now fix $x \in K$ and let $s \in (0, 1)$. Denote by $S_1^{x,s}, \ldots, S_{N^{x,s}}^{x,s}$ the sets as for (5.5) for $\mathbf{C}_s(x, T_x M)$, and choose points $p_1^{x,s}, \ldots, p_{N^{x,s}}^{x,s} \in T_x^{\perp} M$ with $p_h^{x,s} \in S_h^{x,s}$ and such that $\operatorname{spt}(V) \cap (B_s(x, T_x M) + \{p_h^{x,s}\}) \neq \emptyset$. Now observe that, thanks to (5.6),

$$dist_H(\{p_1^{x,s},\dots,p_{N^{x,s}}^{x,s}\},\{p_1^{x,\rho},\dots,p_{N^{x,\rho}}^{x,\rho}\}) \le 2D\tilde{\lambda}^{1/(2m)}s \quad \text{for every } \rho \in (0,\frac{7s}{10}].$$

so that we have a limit set $\{p_1^x, \ldots, p_{Nx}^x\}$, where $N^x \leq Q$, and $(x, p_h^x) \in \operatorname{spt}(V)$ for every h. Here and in the rest of this step, we write often (x, y) for the point $(x + y) \in T_x M \times T_x^{\perp} M$. Later in the proof, especially in **Step 4**, we are going also to regard p_h^x as a point of \mathbb{R}^{m+n} , hence, depending on the context, we use both notations (x, p_h^x) and by $x + p_h^x$ to identify the same point.

Now take $\bar{s} \in (0,1)$ small enough so that $B_{4D\tilde{\lambda}^{1/(2m)}\bar{s}}(p_h^x)$ are pairwise disjoint. Take $s \in (0,\bar{s})$ and consider $S_1^{x,s}, \ldots, S_{N^{x,s}}^{x,s}$. Take h and consider $V_h^{x,s}$, notice that there exists a set $T_h^{x,s}$ with $\operatorname{spt}(V_h) \subset B_s(x, T_xM) + T_h^{x,s}$ and $\overline{T_h^{x,s}} \subset S_h^{x,s}$. By (5.6), and exploiting $T_h^{x,s}$, we find a point

$$(x,\bar{p}) \in (\{x\} + \overline{T_h^{x,s}}) \cap \operatorname{spt}(V_h^{x,s}) \subset \operatorname{spt}(V) \cap S_h^{x,s},$$

which forces $\bar{p} = p_{h'}^x$ for some h'. We have thus seen that, for every h, there exists a unique h' (as $|p_{h'}^x - p_{h''}^x| \ge 8D\tilde{\lambda}^{1/(2m)}\bar{s} > \operatorname{diam}(S_h^{x,s})$ for $h'' \ne h'$) such that $p_{h'}^x \in S_h^{x,s}$. Conversely, for every k, there exists a unique k' such that $p_k^x \in S_{k'}^{x,s}$, as $p_k^x \in \operatorname{spt}(V)$. Hence we have a one-to-one correspondence between the points $\{p_1^x, \ldots, p_{N^x}^x\}$ and the sets $S_1^{x,s}, \ldots, S_{N^{x,s}}^{x,s}$. Hence, to p_h^x , we associate $Q_{h'}^{x,s}$ (for $p_h^x \in S_{h'}^{x,s}$) as the relevant integer as in (5.6). Notice that (5.6) implies that this choice is well posed, i.e. independent of s, and recall that $\sum_h Q_h^{x,s} = Q$. Therefore, we can define $f(x) \coloneqq \sum_h Q_h^{x,s} [p_h^x] \in \mathcal{A}_Q(T_x^{\perp}M)$. This implies clearly statement (a) of Proposition 2.8 and the estimate (2.17) on K. Notice also that the above argument implies $\operatorname{spt}(V) \cap (\{x\} \times T_x^{\perp}M) = \bigcup_h (x, p_h^x)$, in particular we have also covered statement (c).

Step 4. In this step we show that

$$\mathcal{G}(f(x_1), f(x_2)) \le C(\tilde{\lambda}^{1/(2m)} + \delta)|x_1 - x_2| \quad \text{for every } x_1, x_2 \in K.$$

This proves, in particular, the resired Lipschitz estimate (2.15) for f on K.

Set $\bar{r} := |x_1 - x_2|$ and let \bar{x} be such that $x_1, x_2 \in B^M_{6\bar{r}/10}(\bar{x}) \subset B^M_{\bar{r}}(\bar{x}) \subset B^M_3$. We use now **Step 3**, with the same notation, for $B^M_{\bar{r}}(\bar{x})$. Notice first that

$$(B_{\bar{r}/20}(x_1, T_{x_1}M) + T_{x_1}^{\perp}M) \cap \operatorname{spt}(V) \subset B_{7/10\bar{r}}(\bar{x}, T_{\bar{x}}M) + T_{\bar{x}}^{\perp}M.$$
(5.7)

Indeed, take $z \in (B_{\bar{r}/20}(x_1, T_{x_1}M) + T_{x_1}^{\perp}M) \cap \operatorname{spt}(V)$. We compute then

$$|p_{T_{\bar{x}}M}(z-\bar{x})| \le |p_{T_{\bar{x}}M} - p_{T_{x_1}M}||z-\bar{x}| + |p_{T_{x_1}M}(z-x_1)| + |p_{T_{x_1}M}(\bar{x}-x_1)| \le \frac{7\bar{r}}{10}$$

provided that δ is small enough. Consider the stripes $(S_h^{\bar{x},\bar{r}})_h$ and the associated varifolds $(V_h^{\bar{x},\bar{r}})_h$. For any h, from (5.6) we know both that

$$\frac{|V_h^{x,s}|(\mathbf{C}_{7/10\bar{r}}(\bar{x}, T_{\bar{x}}M))}{\omega_m(7/10\bar{r})^m} \in (Q_h^{\bar{x},\bar{r}} - \frac{1}{2Q}, Q_h^{\bar{x},\bar{r}} + \frac{1}{2Q}),$$
(5.8)

$$\frac{|V_h^{x,s}|(\mathbf{C}_s(x_1, T_{x_1}M))}{\omega_m s^m} \in (Q_h^{\bar{x},\bar{r}} - \frac{1}{2Q}, Q_h^{\bar{x},\bar{r}} + \frac{1}{2Q}) \qquad \text{for every } s \in (0, \frac{\bar{r}}{20}).$$
(5.9)

Now, take any $p_k^{x_1}$. By (5.7), we know that $x_1 + p_k^{x_1} \in B_{7/10\bar{r}}(\bar{x}, T_{\bar{x}}M) + S_{h(k)}^{\bar{x},\bar{r}}$, in particular, $x_1 + p_k^{x_1} \in \operatorname{spt}(V_{h(k)}^{\bar{x},\bar{s}})$, thus defining the function $k \mapsto h(k)$. Now notice that, by the construction of **Step 3** and (5.8), (5.9), if we fix \bar{h} , then

$$\sum_{h:h(k)=\bar{h}}Q_k^{x_1}=Q_{\bar{h}}^{\bar{x},\bar{r}}$$

Of course, the same consideration holds for x_2 . Hence,

$$\mathcal{G}(f(x_1), f(x_2)) \le C \sup_{h(k_1)=h(k_2)} |p_{k_1}^{x_1} - p_{k_2}^{x_2}|$$

Take then $p_{k_1}^{x_1}, p_{k_2}^{x_2}$ such that $h(k_1) = h(k_2)$, we compute

$$\begin{split} |p_{k_1}^{x_1} - p_{k_2}^{x_2}| &\leq |p_{T_{\bar{x}}^{\perp}M}(p_{k_1}^{x_1} - p_{k_2}^{x_2})| + |p_{T_{\bar{x}}M}(p_{k_1}^{x_1} - p_{k_2}^{x_2})| \\ &\leq |p_{T_{\bar{x}}^{\perp}M}(x_1 + p_{k_1}^{x_1} - x_2 - p_{k_2}^{x_2})| + |p_{T_{\bar{x}}^{\perp}M}(x_1 - x_2)| + |p_{T_{\bar{x}}M}(p_{k_1}^{x_1})| + |p_{T_{\bar{x}}M}(p_{k_2}^{x_2})| \\ &\leq D\tilde{\lambda}^{1/(2m)}\bar{r} + C\delta\bar{r}^2 + |p_{T_{\bar{x}}M} - p_{T_{x_1}M}||p_{k_1}^{x_1}| + |p_{T_{\bar{x}}M} - p_{T_{x_2}M}||p_{k_2}^{x_2}| \\ &\leq C(\tilde{\lambda}^{1/(2m)} + \delta)\bar{r} \,. \end{split}$$

Now that we have achieved the correct bounds, we can extend the Lipschitz function to $f: B_1^M \to \mathcal{A}_Q(\mathbb{R}^{m+n})$ with $f(x) \perp T_x M$ for every x. This is done as in [10]. Notice that this extension maintains (2.15) and (2.17).

Step 5. We prove (2.16). Take $y \in B_1^M \setminus K$. Take $y \in B_{r'}^M(y') \subset B_4^M$ such that $\mathbf{E}(V, \mathbf{C}_{r'}(y', T_{y'}M)) > \tilde{\lambda}$ of almost maximal size, in the sense that

$$r' > 1/2 \sup\{r'' : y \in B^M_{r''}(y'') \subset B^M_4 : \mathbf{E}(V, \mathbf{C}_{r''}(y'', T_{y''}M)) > \tilde{\lambda}\}.$$

If $r' \geq \frac{1}{10}$, from

$$\tilde{\lambda} < \mathbf{E}(V, \mathbf{C}_{r'}(y', T_{y'}M)) \le \frac{\omega_m 5^m \mathbf{E}(V, \mathbf{C}_5, T_{y'}M)}{\omega_m(r')^m} \le 5^m \frac{\mathbf{E} + \|V\|(\mathbf{C}_5)\delta^2}{(r')^m}$$

we infer that $\lambda \mathbf{E}^{-1} \leq C$, hence (2.16) is trivial. Therefore, we can assume that $r' < \frac{1}{10}$, so that $B_{5r'}^M(y') \subset B_{7/2}^M$. This means that for every $B_t^M(z)$ with $B_{5r'}^M(y') \subset B_t^M(z) \subset B_4^M$ we have $\mathbf{E}(V, \mathbf{C}_t(z, T_z M)) \leq \tilde{\lambda}$. By **Step 1**, we have that

$$\frac{\|V\|(\mathbf{C}_{5r'}(y', T_{y'}M))}{\omega_m(5r')^m} \le Q + \frac{1}{2}.$$

In particular, for every $y \in B_1^M \setminus K$, we can find $y \in B_{r'}^M(y') \subset B_4^M$ with $\mathbf{E}(V, \mathbf{C}_{r'}(y', T_{y'}M)) > \tilde{\lambda}$ and $\|V\|(\mathbf{C}_{5r'}(y', T_{y'}M)) \le \omega_m(5r')^m(Q+1/2)$. Recalling (5.1) for the last inequality,

$$\begin{split} \tilde{\lambda} &\leq \frac{2}{\omega_m(r')^m} \int_{\mathbf{C}_{r'}(y',T_{y'}M)} |T_z - T_{p_M(z)}M|^2 \,\mathrm{d} \|V\|(z) + \frac{2}{\omega_m(r')^m} \int_{\mathbf{C}_{r'}(y',T_{y'}M)} |T_{p_M(z)}M - T_{y'}M|^2 \,\mathrm{d} \|V\|(z) \\ &\leq \frac{2}{\omega_m(r')^m} \int_{\mathbf{C}_{r'}(y',T_{y'}M)} |T_z - T_{p_M(z)}M|^2 \,\mathrm{d} \|V\|(z) + 2\omega_m(Q+1/2)5^m\delta^2 \,, \end{split}$$

so that, if we define the measure $\mu := (p_M)_* (|T_z - T_{p_M(z)}M|^2 d||V||(z)),$

$$\lambda \le C \frac{1}{\omega_m (2r')^m} \int_{p_M^{-1}(B_{2r'}^M(y'))} |T_z - T_{p_M(z)} M|^2 \,\mathrm{d} \|V\|(z) = C \frac{\mu(B_{2r'}(y'))}{\omega_m (2r')^m},$$

In particular, (2.16) follows from a standard covering argument.

Step 6. We prove (2.18). We are going to use the same notation as in **Step 3**. Take s so small that $B_{4D\tilde{\lambda}^{1/(2m)}s}(p_h^s)$ are pairwise disjoint, fix z = (x, y) and h such that $p_h^x = y$. If $s' \in (0, \frac{7s}{8})$, we have trivially

$$\frac{\|V_h^{x,s}\|(\mathbf{B}_{s'}(z))}{\omega_m(s')^m} \le \frac{\|V_h^{x,s}\|(\mathbf{C}_{s'}(x,T_xM))}{\omega_m(s')^m}$$

On the other hand, let $s' \in (0, \frac{7s}{8})$ be so small so that $\sqrt{1 + D^2 \tilde{\lambda}^{1/m}} s' < \frac{7s}{8}$. We have by **Step 3** that $\operatorname{spt}(V_h^{x,s}) \cap \mathbf{C}_{s'}(x, T_x M) \subset B_{s'}(x, T_x M) + S_{h'}^{x,s'}$, with $\operatorname{diam}(S_{h'}^{x,s'}) \leq D \tilde{\lambda}^{1/(2m)} s'$, hence

$$\frac{\|V_h^{x,s}\|(\mathbf{C}_{s'}(x,T_xM))}{\omega_m(s')^m} \le \frac{\|V_h^{x,s}\|\left(\mathbf{B}_{\sqrt{1+D^2\tilde{\lambda}^{1/m}s'}}(z)\right)}{\omega_m(s')^m} = \frac{\|V_h^{x,s}\|\left(\mathbf{B}_{\sqrt{1+D^2\tilde{\lambda}^{1/m}s'}}(z)\right)}{\omega_m(\sqrt{1+D^2\tilde{\lambda}^{1/m}s'})^m}(1+D^2\tilde{\lambda}^{1/m})^{m/2}.$$

We can let now $s' \downarrow 0$, recalling (5.6), to infer that

$$\Theta(z) \le Q_h^x + \frac{1}{2Q}$$
 and $Q_h^x - \frac{1}{2Q} \le \Theta(z)(1 + D^2\tilde{\lambda}^{1/m})^{m/2}$.

Recalling that by assumption $\Theta(z)$ is an integer, we see that $\Theta(z) = Q_h^x$, provided $\tilde{\lambda}$ is small enough (depending only upon m, n and Q).

6. Proof of the decay Lemma

This section is devoted to prove Lemma 2.2. Keeping with the notation used so far, C will denote a generic constant which depends only on m, n and Q. Note that, up to translations we can assume $0 \in M$ and keeping with the convention used so far we omit 0 when it is the center of a ball, so that in particular B_r^M denotes the geodesic ball in M of center 0 and radius r.

We collect first a couple of useful remarks. By Propositions 2.5 and 2.6, we have

$$\frac{1}{\omega_m 50^m} \int_{\mathbf{C}_{50}} |T_z V - T_{p_M(z)} M|^2 \,\mathrm{d} \|V\|(z) \le C\varepsilon^2 \quad \text{and} \quad d_M \le C\varepsilon \text{ in } \mathbf{C}_{50} \cap \operatorname{spt}(V)$$

In particular,

$$\operatorname{spt}(V) \cap \mathbf{C}_{50} \subset \{(x, y) : |x| < 50, |y| < C(\delta + \varepsilon)\}.$$

and

$$\frac{1}{\omega_m 50^m} \int_{\mathbf{C}_{50}} |T_z V - \pi_0|^2 \,\mathrm{d} \|V\|(z) \le C(\delta^2 + \varepsilon^2) \,.$$

Therefore Remark 2.4 follows from Lemma 3.8, provided that ε_0 and δ_0 are small enough.

6.1. The Lipschitz approximation and its estimates. We fix a $\lambda_0 \in (0, 1)$, whose choice will be given at the end of this step, depending only on m, n and Q. We apply the Lipschitz approximation Theorem 2.8 (in scale-invariant form) with $\lambda = \lambda_0$. We thus have a Q-valued $C(\lambda_0 + \delta^2)^{1/2m}$ -Lipschitz normal section

$$f\colon B_{10}^M\to\mathcal{A}_Q(\mathbb{R}^{n+m})$$

(in particular, for $x \in B_{10}^M$ we have $f(x) = \sum_{i=1}^Q \llbracket f_i(x) \rrbracket$, with $f_i(x) \in T_x^{\perp} M$ for every $i = 1, \ldots, Q$) and an associated Borel set $K \subset B_{10}^M$ satisfying the estimate $|B_{10}^M \setminus K| + \|V\|(p_M^{-1}(B_1^M) \setminus K) \le C\lambda_0^{-1}\varepsilon^2$. We require that δ_0 is also small enough, depending on m, n and Q, so that \overline{f} will in fact be assumed to be 1-Lipschitz (i.e. $C(\lambda_0 + \delta_0^2)^{1/2m} < 1$).

The aim of this step is to show that, for any $\varphi \in C_c^1(B_{10}^M, \nu M)$,

$$\left| \int_{B_{10}^M} \mathcal{L}_M \bar{f} \cdot \varphi \, \mathrm{d}\mathcal{H}^m \right| \le C \| D\varphi \|_{L^\infty} \varepsilon^2 \,, \tag{6.1}$$

where \bar{f} denotes the average of f ($\eta \circ f$ in the notation of [2] and [8]), namely $\bar{f}(x) \coloneqq \frac{1}{Q} \sum_{j} f_{j}(x)$. Along the way, we are going to show also that

$$\int_{B_{10}^M} |Df|^2 \,\mathrm{d}\mathcal{H}^m \le C\varepsilon^2 \,. \tag{6.2}$$

We denote by Γ_f the integral varifold given by the (multi)graph of f. As we are going to use the claim of [8, Lemma 1.1] repeatedly, we recall its statement, in our context. Namely, we have a sequence of pairwise disjoint Borel subsets of B_{10}^M , $\{E_h\}_h$, with $\mathcal{H}^m(B_{10}^M \setminus \bigcup_h E_h) = 0$, such that

- (1) for every h, $f|_{E_h} = \sum_{i=1}^Q \llbracket f_i^h \rrbracket$, with $f_i^h C(\lambda_0 + \delta^2)^{1/(2m)}$ -Lipschitz on E_h for every $i = 1, \dots, Q$, (2) for every h and $i, i' \in \{1, \dots, Q\}$, either $f_i^h = f_{i'}^h$ on E_h , or $f_i^h \neq f_{i'}^h$ for every $x \in E_h$, (3) for every h, $Df(x) = \sum_{i=1}^Q \llbracket Df_i^h \rrbracket$ for a.e. $x \in E_h$.

Now notice that for \mathcal{H}^m -a.e. $z \in \operatorname{spt}(\Gamma_f)$, if we write $f(p(z)) = \sum_i [\![p_i]\!]$, then

$$\Theta(\Gamma_f, z) = \sum_{j: p_j = z - p(z)} Q_j.$$
(6.3)

This follows from [9, Proposition 1.4] together with what remarked just after [9, Definition 1.10]. In particular, recalling also (2.18),

$$\Theta(\Gamma_f, z) = \Theta(z) \qquad \text{for } \mathcal{H}^m \text{-a.e. } z \in p^{-1}(K) \cap \operatorname{spt}(V) , \qquad (6.4)$$

and we recall also that, by differentiation of measures,

$$T_z\Gamma_f = T_z V$$
 for \mathcal{H}^m -a.e. $z \in p^{-1}(K) \cap \operatorname{spt}(V)$. (6.5)

Let now $\varphi \in C_c^1(B_{10}^M, \nu M)$. With an harmless abuse, we test the variation of V with the vector field $X(x) \coloneqq \varphi(p(z))$, so $\delta V(X) = 0$, being V stationary. Therefore,

$$\left| \int \operatorname{div}_{\Gamma_{f}}(X) \, \mathrm{d}|\Gamma_{f}| \right| \leq C \|D\varphi\|_{L^{\infty}} \left(\|V\|(p^{-1}(B_{10}^{M} \setminus K)) + Q\mathcal{H}^{m} \sqcup \Gamma_{f}(p^{-1}(B_{10}^{M} \setminus K)) \right) \\ \leq C \|D\varphi\|_{L^{\infty}} \lambda_{0}^{-1} \varepsilon^{2} \,, \tag{6.6}$$

where we used (6.4) and (6.5) to deal with the portion on $p^{-1}(K)$, and the last inequality is by (2.16).

Now, we concentrate on a set E_h , and fix $\hat{f} = f_i^h$ for some $i \in \{1, \ldots, Q\}$. We will implicitly extend \hat{f} to be defined on B_{10}^M , and still $C(\lambda_0 + \delta^2)^{1/(2m)}$ -Lipschitz. We define $\widehat{\Gamma}$ as the graph of \widehat{f} . By the area formula,

$$\int_{p^{-1}(E_h)} \operatorname{div}_{\widehat{\Gamma}}(X) \, \mathrm{d}\mathcal{H}^m \, \mathsf{L}\, \widehat{\Gamma} = \int_{E_h} \operatorname{div}_{\widehat{\Gamma}}(X)(x + \widehat{f}(x)) J\widehat{f}(x) \, \mathrm{d}\mathcal{H}^m(x) \,,$$

where $J_{\hat{f}}$ denotes the area factor of the map $x \mapsto x + \hat{f}(x)$. Now notice that

$$C\delta_0^2 \varepsilon^2 + C|T_x M - T_{x+\hat{f}(x)}\widehat{\Gamma}|^2 \ge |D\hat{f}(x)|^2 \quad \text{for } \mathcal{H}^m\text{-a.e. } x \in B_{10}^M ,$$
(6.7)

$$|Jf(x) - 1| \le C|Df(x)|^2 \quad \text{for } \mathcal{H}^m \text{-a.e. } x \in B_{10}^M , \qquad (6.8)$$

provided that λ_0 and δ_0 are small enough, depending on m and n. Indeed, (6.7) is proved in Lemma 3.5, whereas (6.8), follows from the Taylor expansion of the area factor. We thus deduce from the area formula and (6.8) that

$$\begin{split} \left| \int_{E_h} \operatorname{div}_{\widehat{\Gamma}}(X)(x+\widehat{f}(x)) \mathrm{d}\mathcal{H}^m(x) - \int_{p^{-1}(E_h)} \operatorname{div}_{\widehat{\Gamma}}(X) \mathrm{d}\mathcal{H}^m \right| \\ & \leq \left| \int_{E_h} |\operatorname{div}_{\widehat{\Gamma}}(X)(x+\widehat{f}(x))| |J\widehat{f}(x) - 1| \mathrm{d}\mathcal{H}^m(x) \right| \leq C \|D\varphi\|_{L^{\infty}} \int_{E_h} |D\widehat{f}|^2 \,. \end{split}$$

We use now Lemma 3.5 (provided that λ_0 and δ_0 are small enough, depending on m and n) to obtain that

$$\left| \int_{E_{h}} D\hat{f} : D\varphi - 2\Pi_{\varphi} : \Pi_{\hat{f}} \, \mathrm{d}\mathcal{H}^{m} - \int_{E_{h}} \operatorname{div}_{\widehat{\Gamma}}(X)(x + \hat{f}(x)) \mathrm{d}\mathcal{H}^{m}(x) \right|$$

$$\leq C \|D\varphi\|_{L^{\infty}} \int_{E_{h}} \delta_{0}^{2} |\hat{f}(x)|^{2} + |T_{x}M - T_{x + \hat{f}(x)}\widehat{\Gamma}|^{2} \, \mathrm{d}\mathcal{H}^{m}(x) \,.$$

$$(6.9)$$

Now the choice of λ_0 can be fixed. Hence, all the dependencies on λ_0 can be absorbed in the constant C.

From the two set of inequalities above, recalling that $|\hat{f}| \leq C\varepsilon$, we deduce that

$$\left| \int_{E_h} D\hat{f} : D\varphi - 2\Pi_{\varphi} : \Pi_{\hat{f}} \, \mathrm{d}\mathcal{H}^m - \int_{p^{-1}(E_h)} \operatorname{div}_{\widehat{\Gamma}}(X) \, \mathrm{d}\mathcal{H}^m \right| \\ \leq C \|D\varphi\|_{L^{\infty}} \left(\delta_0^2 \varepsilon^2 \mathcal{H}^m(E_h) + \int_{E_h} |T_x M - T_{x+\hat{f}(x)}\widehat{\Gamma}|^2 \, \mathrm{d}\mathcal{H}^m(x) + |D\hat{f}|^2 \, \mathrm{d}\mathcal{H}^m(x) \right)$$

We recall that we chose $\hat{f} = f_i^h$. We next use (6.7), the area formula (as $Jf_i^h \ge 1/2$), (6.3), (6.4), (6.5), and (2.16), to compute

$$\begin{aligned} \int_{B_{10}^{M}} |Df|^{2} \, \mathrm{d}\mathcal{H}^{m} &= \sum_{h} \sum_{i=1}^{Q} \int_{E_{h}} |Df_{i}^{h}|^{2} \, \mathrm{d}\mathcal{H}^{m} \\ &\leq \sum_{h} C \delta_{0}^{2} \varepsilon^{2} |\mathcal{H}^{m}(E_{h})| + C \sum_{h} \sum_{i=1}^{Q} \int_{E_{h}} |T_{x}M - T_{x+f_{i}^{h}(x)} \Gamma_{f_{i}^{h}}|^{2} \mathrm{d}\mathcal{H}^{m}(x) \\ &\leq C \delta_{0}^{2} \varepsilon^{2} + C \sum_{h} \sum_{i=1}^{Q} \int_{p^{-1}(E_{h})} |T_{p(z)}M - T_{z} \Gamma_{f_{i}^{h}}|^{2} \, \mathrm{d}\mathcal{H}^{m}(z) \\ &\leq C \delta_{0}^{2} \varepsilon^{2} + C \int_{p^{-1}(B_{10}^{M})} |T_{p(z)}M - T_{z} \Gamma_{f}|^{2} \, \mathrm{d}|\Gamma_{f}|(z) \\ &\leq C \delta_{0}^{2} \varepsilon^{2} + \int_{p^{-1}(B_{10}^{M} \cap K)} |T_{p(z)}M - T_{z} \Gamma_{f}|^{2} \, \mathrm{d}|\Gamma_{f}|(z) + \int_{p^{-1}(B_{10}^{M} \setminus K)} |T_{p(z)}M - T_{z} \Gamma_{f}|^{2} \, \mathrm{d}|\Gamma_{f}|(z) + \int_{p^{-1}(B_{10}^{M} \setminus K)} |T_{p(z)}M - T_{z} \Gamma_{f}|^{2} \, \mathrm{d}|\Gamma_{f}| \\ &\leq C \delta_{0}^{2} \varepsilon^{2} + \int_{p^{-1}(B_{10}^{M} \cap K)} |T_{p(z)}M - T_{z} V|^{2} \, \mathrm{d}||V||(z) + C|B_{10}^{M} \setminus K| \leq C \varepsilon^{2} \,, \end{aligned}$$

$$(6.10)$$

which proves (6.2).

We sum (6.9) for i = 1, ..., Q and then on h, using also (intermediate steps of) (6.10), to obtain that

$$\left| Q \int_{B_{10}^M} \left(D\bar{f} : D\varphi - 2\Pi_{\varphi} : \Pi_{\bar{f}} \right) \mathrm{d}\mathcal{H}^m - \int_{p^{-1}(B_{10}^M)} \mathrm{div}_{\Gamma_f}(X) \, \mathrm{d}|\Gamma_f| \right| \le C \|D\varphi\|_{L^{\infty}} \varepsilon^2 \,, \tag{6.11}$$

where we took into account (6.3). Combining the outcomes of (6.6) and (6.11), we finally prove (6.1).

6.2. Proof of Lemma 2.3. To show that (2.7) follows, we compute

$$\int_{B_{10}^M} d_{\operatorname{spt}(V)}^2 \, \mathrm{d}\mathcal{H}^m \le \int_K d_{\operatorname{spt}(V)}^2 \, \mathrm{d}\mathcal{H}^m + \int_{B_{10}^M \setminus K} d_{\operatorname{spt}(V)}^2 \, \mathrm{d}\mathcal{H}^m \le C \int_{p^{-1}(K)} d_M^2 \, \mathrm{d}\|V\| + C\varepsilon^2 \le C\varepsilon^2 \,,$$

where we used that for every $x \in K$, $d_{\operatorname{spt}(V)}(x) \leq |f(x)| \leq Cd_M(y)$ for some $y \in \operatorname{spt}(V) \cap p^{-1}(K)$, and the area formula.

Now, we use Proposition 2.6 with M'' to obtain that $\sup_{\mathbf{C}_{1/2}(y)\cap \operatorname{spt}(V)} d_{M''} \leq C\sigma$. Notice that for every $x \in K \cap \mathbf{C}_{1/3}(y)$, there exists $x' \in \operatorname{spt}(V)$ with $|x - x'| \leq C\varepsilon$ (by the L^{∞} bound for f), in particular $x' \in \operatorname{spt}(V) \cap \mathbf{C}_{1/2}(y)$ (if ε_0 is small enough), so that there exists $x'' \in M''$ with $|x' - x''| \leq C\sigma$. Therefore,

$$\int_{M\cap\mathbf{C}_{1/3}(y)} d_{M''}^2 \,\mathrm{d}\mathcal{H}^m \leq \int_{K\cap\mathbf{C}_{1/3}(y)} d_{M''}^2 \,\mathrm{d}\mathcal{H}^m + \int_{B_2^M\setminus K} d_{M''}^2 \,\mathrm{d}\mathcal{H}^m \leq C(\varepsilon+\sigma)^2 \,.$$

Now notice that

$$||g - g''||^2_{L^2(B_{1/4}(y))} \le C(\varepsilon + \sigma)^2$$

This follows from the inequality above together with Lemma 6.1 below, and the area formula. Therefore, (2.8) follows from the theory of elliptic PDEs. Indeed, g - g'' solves a linear elliptic system with smooth coefficients whose norms are bounded by functions of δ .

Lemma 6.1. Let $f: B_1 \to \mathbb{R}^n$ be a 1-Lipschitz function and let Γ be its graph. Then

$$d_{\Gamma}(z) \le |z - z_1 - f(z_1)| \le 3d_{\Gamma}(z)$$
 for all $z = (z_1, z_2) \in B_{1/4}^m + B_1^n$.

We are not going to prove Lemma 6.1, as its proof is elementary.

6.3. Elliptic regularization of the average. We proved in the previous step that the size of $\mathcal{L}_M \bar{f}$ is bounded by ε^2 in a weak norm. It is convenient to replace \bar{f} with a solution \tilde{f} of $\mathcal{L}_M \tilde{f} = 0$, which we will show to be L^2 -close to \bar{f} . Due to technical reasons, we actually get $O(\varepsilon^{3/2})$ closeness, which is still good enough for our purposes.

We in fact let $f: B_{10}^M \to \mathbb{R}^{n+m}$ as the normal section such that

$$\mathcal{L}_M \tilde{f} = 0 ext{ in } B^M_{10} ext{ and } ilde{f} = ar{f} ext{ on } \partial B^M_{10} ext{ .}$$

Applying the maximum principle to $|\tilde{f}|^2$ (see Lemma 3.4) we find $|\tilde{f}| \leq C\varepsilon$, which we claim implies

$$\|\tilde{f} - \bar{f}\|_{L^2(B_{10}^M)} \le C\varepsilon^{3/2} \,. \tag{6.12}$$

In order to prove (6.12), we test the equation with the normal section $\varphi_0 \in H_0^1(B_{10}^M, \mathbb{R}^{m+n})$ such that $\mathcal{L}_M \varphi_0 = \bar{f} - \tilde{f}$ and use (6.1) and $W^{2,p}$ estimates up to the boundary for linear elliptic systems (see Lemma 3.3). Hence,

$$\begin{split} \|\tilde{f} - \bar{f}\|_{L^2(B^M_{10})}^2 &= \langle \bar{f} - \tilde{f}, \mathcal{L}_M \varphi_0 \rangle = \langle \mathcal{L}_M \bar{f}, \varphi_0 \rangle \\ &\leq C \varepsilon^2 \|\varphi_0\|_{C^1(B^M_{10})} \leq C \varepsilon^2 \|\mathcal{L}_M \varphi_0\|_{L^{\infty}(B^M_{10})} \leq C \varepsilon^2 \|\bar{f} - \tilde{f}\|_{L^{\infty}(B^M_{10})} \leq C \varepsilon^3 \,. \end{split}$$

We denote by $\overline{\Gamma}$ the graph of \overline{f} (that is the set $\overline{\Gamma} := \{x + \overline{f}(x) : x \in B_{10}^M\}$) and similarly by $\widetilde{\Gamma}$ the graph of \widetilde{f} . Then the L^2 bound (6.12) implies that

$$\int_{\mathbf{C}_9} d_{\widetilde{\Gamma}}^2 \,\mathrm{d} \|V\| \le C \int_{\mathbf{C}_9} d_{\overline{\Gamma}}^2 \,\mathrm{d} \|V\| + C\varepsilon^3 \,. \tag{6.13}$$

Indeed, as \overline{f} is 1-Lipschitz and for all $z \in \{|x| \leq 9, |y| \leq 1\}$ one has

$$d_{\widetilde{\Gamma}}(z) \le |z - p(z) - \tilde{f}(p(z))| \le |z - p(z) - \bar{f}(p(z))| + |\tilde{f}(p(z)) - \bar{f}(p(z))| \le 3d_{\overline{\Gamma}}(z) + |\tilde{f}(p(z)) - \bar{f}(p(z))|,$$

where $|z - p(z) - \overline{f}(p(z))| \leq 3d_{\overline{\Gamma}}(z)$ follows from Lemma 6.2 below. We integrate this inequality with respect to $d\|V\|$ on $E \coloneqq \Gamma \cap \mathbb{C}_9$ and using the area formula on p, finding

$$\begin{split} \int_{\Gamma \cap \mathbf{C}_9} d_{\widetilde{\Gamma}}^2 \, \mathrm{d} \|V\| &\leq 9 \int_{\Gamma \cap \mathbf{C}_9} d_{\overline{\Gamma}}^2 \, \mathrm{d} \|V\| + 9 \int_{\Gamma \cap \mathbf{C}_9} |\tilde{f}(p(z)) - \bar{f}(p(z))|^2 \, \mathrm{d} \|V\| \\ &\leq 9 \int_{\Gamma \cap \mathbf{C}_9} d_{\overline{\Gamma}}^2 \, \mathrm{d} \|V\| + C \int_{p(\Gamma \cap \mathbf{C}_9)} |\tilde{f}(x) - \bar{f}(x)|^2 \, \mathrm{d} \mathcal{H}^m \leq 9 \int_{\Gamma \cap \operatorname{spt}(V)} d_{\overline{\Gamma}}^2 \, \mathrm{d} \|V\| + C\varepsilon^3 \,, \end{split}$$

where we used $p(\Gamma \cap \mathbf{C}_9) \subset B_{10}^M$. On the piece $(\operatorname{spt}(V) \setminus \Gamma) \cap \mathbf{C}_9$ we combine the L^{∞} estimate on $d_{\widetilde{\Gamma}}$ and the measure one:

$$\int_{\operatorname{spt}(V)\backslash\Gamma} d_{\widetilde{\Gamma}}^2 \,\mathrm{d} \|V\| \le C \varepsilon^2 \mathcal{H}^m(\operatorname{spt}(V) \setminus \Gamma) \le C \varepsilon^4.$$
(6.14)

Lemma 6.2. Let $f: B_{10}^M \to \mathbb{R}^{m+n}$ be a 1-Lipschitz normal section and let Γ be its graph. Then

$$d_{\Gamma}(z) \le |z - p(z) - f(z)| \le 3d_{\Gamma}(z)$$
 for all $z \in B_9^m + B_1^n$.

Like we did for Lemma 6.1, we leave the elementary proof of Lemma 6.2 to the reader.

6.4. Updating the minimal surface. We construct now, in the smaller cylinder C_8 a true minimal surface M' which is $O(\varepsilon^2)$ -close to $\widetilde{\Gamma}$.

By elliptic regularization, \tilde{f} has size $O(\varepsilon)$ in a strong norm in the interior of B_{10}^M , for example

$$\|\hat{f}\|_{C^{2,1/2}(B_5^M)} \le C \|\hat{f}\|_{L^{\infty}(B_{10}^M)} \le C\varepsilon$$

Since $\mathcal{L}_M \tilde{f} = 0$, we solve the minimal surface system by the inverse function theorem of Lemma 3.7 to find a normal section $f' \colon B_5^M \to \mathbb{R}^{m+n}$ of M such that its graph M' is a $(\delta + C\varepsilon)$ -flat minimal surface and

$$\|f' - \tilde{f}\|_{C^{2,1/2}(B_5^M)} \le C\varepsilon^2$$

In particular, arguing as in (6.13),

$$\left(\int_{\mathbf{C}_1} d_{M'}^2 \, d\|V\|\right)^{1/2} \le C \left(\int_{\mathbf{C}_1} d_{\widetilde{\Gamma}}^2 \, d\|V\|\right)^{1/2} + C\varepsilon^2 \, .$$

Combining this with (6.13), we find

$$\left(\int_{\mathbf{C}_1} d_{M'}^2 \,\mathrm{d} \|V\|\right)^{1/2} \le \left(\int_{\mathbf{C}_1} d_{\overline{\Gamma}}^2 \,\mathrm{d} \|V\|\right)^{1/2} + C\varepsilon^{3/2} \,. \tag{6.15}$$

6.5. Conclusion and the role of η . In order to estimate the last integral, we use that $|d_{\overline{\Gamma}}| \leq C\varepsilon$ on V and the fact that V coincides with the multigraph Γ up to a set of measure ε^2 (as in (6.14)). We find

$$\left(\int_{\mathbf{C}_1} d_{\overline{\Gamma}}^2 d\|V\|\right)^{1/2} \le C \left(\int_{\Gamma \cap \mathbf{C}_1} d_{\overline{\Gamma}}^2 d\mathcal{H}^m\right)^{1/2} + C\varepsilon^2$$

Now the parameter $\boldsymbol{\eta}$ comes into play, since $\overline{\Gamma}$ and Γ differ precisely when f is genuinely multivalued, which happens on a set of measure at most $\boldsymbol{\eta}$. Rigorously, let $F \subset B_{10}^M$ be defined as $F := \{x : f(x) \neq Q \ [\![\bar{f}(x)]\!] \}$. Then

$$\mathcal{H}^m(F) \le \mathcal{H}^m(F \cap K) + \mathcal{H}^m(F \setminus K) \le C\boldsymbol{\eta} + C\boldsymbol{\varepsilon}^2,$$

where we used (2.18) to deal with the first part and (2.16) to deal with the second. It follows that $\mathcal{H}^m(\{d_{\overline{\Gamma}} > 0\} \cap \Gamma \cap \mathbf{C}_1) \leq C \eta + C \varepsilon^2$. Hence we get

$$\left(\int_{\Gamma\cap\mathbf{C}_1} d_{\overline{\Gamma}}^2 \, d\mathcal{H}^m\right)^{1/2} \le C\sqrt{\eta}\varepsilon + C\varepsilon^2$$

which, together with (6.15), concludes the proof of (2.6).

7. Proof of smooth rectifiability

We are going to prove a stronger version of Theorem 1.2, which reads as follows.

Theorem 7.1 (Rectifiability). Let V be an m-dimensional stationary varifold in an open set U. Then, there exists a countable collection of Borel sets $(G_k)_k$ such that

$$\|V\|\Big(U\setminus \bigcup_k G_k\Big)=0\,,$$

and, for every k, $G_k \subset M_k$ for a m-dimensional C^{∞} submanifold M_k . Moreover, for every k and for every $z \in G_k$, we have

$$\sup_{\operatorname{spt}(V)\cap \mathbf{B}_r(z)} d_{M_k} = o(r^N) \qquad \text{as } r \downarrow 0, \text{ for every } N \in \mathbb{N} \,.$$

Clearly the latter theorem imples both Theorem 1.2 and Corollary 1.1.

Lemma 7.2. For every m, n, and Q positive integers there are positive constants η_1, δ_1 , and ε_1 with the following property. Let V be an m-dimensional stationary varifold in \mathbf{C}_{101} and let $Q \in \mathbb{N}$. Let $G \subset \operatorname{spt}(V) \cap \mathbf{C}_{1/20}$ be such that, for some modulus of continuity $\varpi : \mathbb{R} \to (0, \eta)$ with $\eta < \eta_1$,

$$\frac{|V||(\{\Theta_V < Q\} \cap \mathbf{C}_s(z))}{\omega_m s^m} < \varpi(s) \qquad \text{for all } s \in (0, 100] \text{ and } z \in G.$$

$$(7.1)$$

Assume moreover that, for every $z \in \mathbf{C}_{1/20} \cap \operatorname{spt}(V)$,

$$\operatorname{spt}(V) \cap \mathbf{C}_{100}(z) \subset \{(x,y) : |y| \le 1\}, \quad Q - \frac{1}{2} < \frac{\|V\|(\mathbf{C}_{30})(z)}{\omega_m(30)^m} < Q + \frac{1}{2}, \quad \frac{\|V\|(\mathbf{C}_{100}(z))}{\omega_m 100^m} \le Q + \frac{1}{2}.$$
(7.2)

Assume finally that there exists a minimal surface M such that, for every $z \in \operatorname{spt}(V) \cap \mathbf{C}_{1/20}$, M is δ -flat with $\delta < \delta_1$ in $\mathbf{C}_{200}(z)$ and

$$\boldsymbol{\varepsilon} \coloneqq \left(\frac{1}{\omega_m 100^{m+2}} \int_{\mathbf{C}_{100}} d_M^2 \,\mathrm{d} \|V\|\right)^{1/2} \le \varepsilon_1 \,. \tag{7.3}$$

Then, for every $l \in \mathbb{N}$ and for every $z = (x, y) \in G$, there exists a polynomial $p_{z,l} : \mathbb{R}^m \to \mathbb{R}^n$ of degree l with $p_{z,l}(x) = y$ satisfying the following. For every $z_1 = (x_1, y_1), z_2 = (x_2, y_2) \in G$, for every $l \in \mathbb{N}$ and multi index α with $|\alpha| \leq l$,

$$|D^{\alpha}p_{z_1,l}(x_2) - D^{\alpha}p_{z_2,l}(x_2)| \le C_{l,\varpi}|x_1 - x_2|^{l-|\alpha|+1},$$
(7.4)

where $C_{l,\varpi}$ depends on m, n, Q and ϖ . Moreover, for any $l' \leq l, p_{z,l}$ and $p_{z,l'}$ agree up to the terms of degree l'. Finally, for every $z_0 = (x_0, y_0) \in G$ and $l \in \mathbb{N}$,

$$\sup_{z=(x,y)\in \operatorname{spt}(V)\cap \mathbf{C}_r(x_0)} |y-p_{z_0,l}(x)| \le C_{l,\varpi} r^{l+1} \quad \text{for every } r \in (0,1).$$
(7.5)

Proof of Theorem 7.1. Let η_1, δ_1 , and ε_1 be the parameters given by Lemma 7.2. We recall that for ||V||-a.e. $z, \Theta_V(z) \in \mathbb{N}$ and the tangent to V is $\Theta_V(z) [\![\pi_z]\!]$, for some *m*-plane π_z . It is then enough to fix $Q \in \mathbb{N}$ and prove the claim on the set

 $G := \{z : \Theta_V(z) = Q, \exists s_0 \in (0,1) \text{ and } \varpi : \mathbb{R} \to (0,\eta) \text{ such that } (7.1) \text{ holds at } z \text{ for every } s \in (0,r_0) \}.$

Now, for a.e. $z \in G$, the tangent to V is $Q[[\pi_z]]$. Fix any such z. In particular, the rescaled varifolds V_r converge to $Q[[\pi_z]]$ (and the support of V_r converge to π_z in the Kuratowski sense). For definiteness, we assume that $\pi_z = \pi_0$. We thus see that, for r small enough, $\hat{V}_r \coloneqq V_r \sqcup \{(x, y) : |y| < 1\}$ is a stationary varifold satisfying the assumptions of Lemma 7.2 with $\hat{G} \coloneqq G \cap \mathbf{C}_{1/20}$ in place of G and π_0 in place of M. A quick way to see (7.2) is by using Lemma 3.8. Now we apply Lemma 7.2 and obtain the polynomials $p_{z,l}$. Notice that (7.4) implies in particular that the projection $\mathbf{p}_0 : \hat{G} \to \pi_0$ is injective. We then take, for $x \in \mathbf{p}_0(\hat{G})$, the unique point z_x with $z_x \in \hat{G}$ and $\mathbf{p}_0(z_x) = x$. Hence, for every $x \in \mathbf{p}_0(\hat{G})$ and $l \in \mathbb{N}$, there exists a unique polynomial $p_{x,l} \coloneqq p_{z_x,l}$. The main claim of Lemma 7.2, i.e. (7.4), implies that these polynomials satisfy the compatibility conditions required to apply the main theorem of Whitney in [17], thus obtaining a map $p \in C^{\infty}(B_1, \mathbb{R}^n)$ such that, for every $x \in \mathbf{p}_0(\hat{G})$, and α with $|\alpha| \leq l$, $D^{\alpha}p(x) = D^{\alpha}p_{x,l}(x)$, i.e. $p_{x,l}$ is the Taylor polynomial of degree l for p at x. We remark that, for $\alpha = (0, \ldots, 0)$, this reads as $(x, p(x)) = z_x$, in particular, $\hat{G} \subset \Gamma_p$ is a subset of a smooth submanifold. This proves the first part of the theorem.

Fix now $z_0 = (x_0, y_0) \in \hat{G}$ and $N \in \mathbb{N}$. Let $l \in \mathbb{N}$. Recall (7.5), i.e.

$$\sup_{\substack{x=(x,y)\in \operatorname{spt}(\hat{V})\cap \mathbf{C}_r(x_0)}} |y-p_{x_0,l}(x)| \le C_{l,\varpi}r^{l+1} \quad \text{for every } r \in (0,1).$$

Hence, for every $r \in (0, 1)$,

$$\sup_{z \in \operatorname{spt}(\hat{V}) \cap \mathbf{C}_r(x_0)} d_{\Gamma_p}(z) \le \sup_{z = (x,y) \in \operatorname{spt}(\hat{V}) \cap \mathbf{C}_r(x_0)} |y - p(x)| \le \sup_{x \in B_r(x_0)} |p(x) - p_{x_0,l}(x)| + C_{l,\varpi} r^{l+1},$$

so that the conclusion follows from Taylor's Theorem.

Proof of Lemma 7.2. The proof of this lemma is a careful iteration of Lemma 2.2. For this purpose we fix ε_0 , δ_0 , and η_0 so that the latter applies.

Step 1. Set $r_k := 100^{1-k}$, for $k \ge 0$. Set $\varepsilon(r_0) = \varepsilon$ and, for $k \ge 0$, $\varepsilon(r_{k+1}) := \overline{C}(\sqrt{\eta(r_k)} + \sqrt{\varepsilon(r_k)})\varepsilon(r_k)$. Moreover, set $\delta(r_0) = \delta$ and, for $k \ge 0$, $\delta(r_{k+1}) := \delta(r_k) + \overline{C}\varepsilon(r_k)$. Here, the geometric constant \overline{C} is the geometric constant that appears in the estimates of Lemma 2.2. Now, if $\varepsilon, \eta, \delta$ are small enough (depending also on \overline{C}), we can ensure what follows:

- $\varepsilon(r_k) \leq \varepsilon_0$ for every k,
- there exist constants $D_{l,\varpi}$ independent of k, but depending upon m, n, Q and ϖ , such that

$$\varepsilon(r_k) \leq D_{l,\varpi} r_k^l$$
 for every k ,

• $\delta(r_k) \leq \delta_0$ for every k.

We are going to exploit these relations throughout.

Step 2. Take now any $z = (x, y) \in G$ and consider the cylinders $\mathbf{C}_{r_k}(x)$. Set $M_z^0 \coloneqq M$ (which is independent of z), M_z^0 can be written as $\delta(r_0)$ -flat graph of $g_z^0 : B_{2r_0}(x) \to \mathbb{R}^n$, and has Taylor polynomial of degree l at x, say $p_{z,l}^0$. Notice that among the assumptions of the lemma, there is that V satisfies (7.2) and (7.3) on $\mathbf{C}_{100}(x) = \mathbf{C}_{r_0}(x)$. This is going to be the base step in an induction process.

For what concerns the inductive step, we argue as follows. Assume that at step $k \ge 0$, V satisfies the scaled version of (7.2) on $\mathbb{C}_{r_k}(x)$, and we have a minimal surface M_z^k , which can be written as $\delta(r_k)$ -flat graph of $g_z^k : B_{2r_k}(x) \to \mathbb{R}^n$, satisfying

$$\left(\frac{1}{\omega_m r_k^{m+2}} \int_{\mathbf{C}_{r_k}(x)} d_{M_z^k}^2 \,\mathrm{d} \|V\|\right)^{1/2} \le \varepsilon(r_k) \,. \tag{7.6}$$

We denote by $p_{z,l}^k$ the Taylor polynomial of degree l for g_z^k at x.

Then, we can recall (7.1) and apply Lemma 2.2 to $\mathbf{C}_{r_k}(x)$ and obtain a minimal surface M_z^{k+1} , which can be written as a $\delta(r_k) + \bar{C}\varepsilon(r_k) = \delta(r_{k+1}) \leq \delta_0$ -flat graph of $g_z^{k+1} : B_{2r_{k+1}}(x) \to \mathbb{R}^n$, satisfying

$$\left(\frac{1}{\omega_m r_{k+1}^{m+2}} \int_{\mathbf{C}_{r_{k+1}}(x)} d_{M_z^{k+1}}^2 \, \mathrm{d} \|V\|\right)^{1/2} \le \bar{C}(\sqrt{\eta(r_k)} + \sqrt{\varepsilon(r_k)})\varepsilon(r_k) = \varepsilon(r_{k+1}) \le \varepsilon_0 \,.$$

We denote by $p_{z,l}^{k+1}$ the Taylor polynomial of degree l for g_z^{k+1} at x. Moreover, we observe that the scaled version of (7.2) holds on $\mathbf{C}_{r_{k+1}}(x)$ by Remark 2.4. In passing, notice that Proposition 2.6 with (7.6) imply that

$$\sup_{\operatorname{spt}(V)\cap \mathbf{C}_{r_k/2}(x)} d_{M_k} \le C\varepsilon(r_k).$$
(7.7)

In particular, as $z \in \operatorname{spt}(V)$, we have

$$g_z^k(x) \to y \qquad \text{as } k \to \infty \,.$$

$$\tag{7.8}$$

We can then iterate the procedure above and have the objects defined at every step k.

Step 3. Let $z_1 = (x_1, y_1), z_2 = (x_2, y_2) \in G$. Let $k \ge 1$ be such that $|x_1 - x_2| < \frac{r_k}{10}$. We thus can apply the scale-invariant form of Lemma 2.3 to estimate

$$\begin{aligned} \|D^{\alpha}g_{z_{1}}^{k-1} - D^{\alpha}g_{z_{2}}^{k}\|_{C^{0}(B_{r_{k}/10}(x_{2}))} &\leq \|g_{z_{1}}^{k-1} - g_{z_{2}}^{k}\|_{C^{|\alpha|}(B_{r_{k}/10}(x_{2}))} \leq C_{|\alpha|}r_{k}^{1-|\alpha|}(\varepsilon(r_{k-1}) + \varepsilon(r_{k})) \\ &\leq C_{l}r_{k}^{1-|\alpha|}D_{l,\varpi}(r_{k-1}^{l} + r_{k}^{l}) \leq 200^{l}C_{l}D_{l,\varpi}r_{k}^{1-|\alpha|+l} \leq C_{l,\varpi}r_{k}^{1-|\alpha|+l}, \end{aligned}$$
(7.9)

for any multi-index α and $l \geq |\alpha|$.

Now take $z_1 = z_2 = z = (x, y) \in G$, notice that the right-hand-side of (7.9) is a convergent sum, in particular, the following holds. First,

$$\sup_{k \ge 0} \|g_z^k\|_{C^l(B_{r_k/10}(x))} \le E_l < \infty,$$
(7.10)

for constants E_l independent of z, where we used also that g_z^0 is independent of z. Also

$$|D^{\alpha}g_z^{k-1}(x) - D^{\alpha}g_z^k(x)| \le C_{l,\varpi}r_k^{1+l-|\alpha|} \quad \text{for all } |\alpha| \le l.$$

This implies, for each multi index $|\beta| \leq l$, the existence of the limit coefficients $p_z^{\beta} = \lim_k D^{\beta} g_z^k(x)/\beta!$, the fact that they do not depend on l, the fact that $p_z^0 = y$ (by (7.8)) and the bounds

$$|p_z^{\beta}| \le E_l, \qquad \left|p_z^{\beta} - \frac{D^{\beta}g_z^k(x)}{\beta!}\right| \le C_{l,\varpi}r_k^{1+l-|\beta|},$$

where we have

$$p_{z,l}^k(x') := \sum_{|\beta| \le l} \frac{D_{\beta} g_z^k(x)}{\beta!} (x' - x)^{\beta}, \qquad p_{z,l}(x') := \sum_{|\beta| \le l} p_z^{\beta} (x' - x)^{\beta}.$$

Putting things together we get the following useful bound, for all $|\alpha| \leq l$,

$$\|D^{\alpha}(p_{z,l}^{k}-p_{z,l})\|_{L^{\infty}(B_{r_{k}}(z))} \leq \sum_{|\beta|\leq l-|\alpha|,\beta\geq\alpha} c_{\alpha,\beta} \left|p_{z}^{\beta}-\frac{D^{\beta}g_{z}^{k}(x)}{\beta!}\right|r_{k}^{\beta-\alpha}$$

$$\leq C_{l,\varpi} \sum_{|\beta|\leq l-|\alpha|,\beta\geq\alpha} r_{k}^{1+l-|\beta|}r_{k}^{|\beta|-|\alpha|} \leq C_{l,\varpi}r_{k}^{1+l-|\alpha|}.$$
(7.11)

Let $z_1 = (x_1, y_1), z_2 = (x_2, y_2) \in G$ and let $k \ge 1$ denote the largest integer such that $|x_1 - x_2| < r_k/10$, this implies that $r_k \le 1000|x_1 - x_2|$. Let $l \ge 0$ and let α be a multi-index and with $|\alpha| \le l$. We then have,

$$\begin{split} |D^{\alpha}p_{z_{1},l}^{k-1}(x_{2}) - D^{\alpha}p_{z_{2},l}^{k}(x_{2})| &\leq |D^{\alpha}p_{z_{1},l}^{k-1}(x_{2}) - D^{\alpha}g_{z_{1}}^{k-1}(x_{2})| + |D^{\alpha}g_{z_{1}}^{k-1}(x_{2}) - D^{\alpha}g_{z_{2}}^{k}(x_{2})| \\ &\leq |x_{1} - x_{2}|^{l-|\alpha|+1} \|D^{\alpha}g_{z_{1}}^{k-1}\|_{C^{l-|\alpha|+1}(B_{r_{k}/10}(x_{1}))} + \|D^{\alpha}g_{z_{1}}^{k-1} - D^{\alpha}g_{z_{2}}^{k}\|_{C^{0}(B_{r_{k}/10})(x_{2})} \\ &\leq |x_{1} - x_{2}|^{l-|\alpha|+1} \|g_{z_{1}}^{k-1}\|_{C^{l+1}(B_{r_{k}/10}(x_{1}))} + \|g_{z_{1}}^{k-1} - g_{z_{2}}^{k}\|_{C^{|\alpha|}(B_{r_{k}/10})(x_{2})} \\ &\leq |x_{1} - x_{2}|^{l-|\alpha|+1}E_{l+1} + 200^{l}C_{|\alpha|}D_{l,\varpi}r_{k}^{1-|\alpha|+l} \\ &\leq (E_{l+1} + 200^{l}C_{|\alpha|}D_{l,\varpi}1000^{1-|\alpha|+l})|x_{1} - x_{2}|^{l-|\alpha|+1} \\ &\leq C_{l,\varpi}|x_{1} - x_{2}|^{l-|\alpha|+1}, \end{split}$$

where we used (7.9) and (7.10). Now we employ (7.11) which gives for i = 1, 2, 3

$$|D^{\alpha}p_{z_{i},l}^{k-1}(x_{i}) - D^{\alpha}p_{z_{i},l}(x_{i})| \leq \|D^{\alpha}(p_{z_{i},l}^{k-1} - p_{z_{i},l})\|_{L^{\infty}(B_{r_{k}}(x_{1}))} \leq C_{l,\varpi}r_{k}^{1+l-|\alpha|} \leq C_{l,\varpi}|x_{1} - x_{2}|^{l-|\alpha|+1}$$

and this concludes the proof of (7.4).

Step 4. We prove (7.5), fix $z_0 = (x_0, y_0) \in G$. Let $k \in \mathbb{N}$. First, recalling Lemma 6.1 ($g_{z_0}^k$ is δ_0 -Lipschitz), Taylor's Theorem and (7.7) imply that

$$\sup_{\substack{z=(x,y)\in \operatorname{spt}(V)\cap \mathbf{C}_{r_k/10}(x_0)}} |y-p_{z_0,l}^k(x)| \le C\varepsilon(r_k) + C \sup_{B_{r_k/10}(x_0)} |D^{l+1}g_{z_0}^k|r_k^{l+1} \le C D_{l+1,\varpi}r_k^{l+1} + C E_{l+1}r_k^{l+1} \le C_{l,\varpi}r_k^{l+1}$$

where we used also (7.10). If we now use (7.11) (with $\alpha = (0, \ldots, 0)$) we obtain

$$\sup_{z=(x,y)\in \operatorname{spt}(V)\cap \mathbf{C}_{r_k/10}(x_0)} |y-p_{z_0,l}(x)| \le C_{l,\varpi} r_k^{l+1},$$

which clearly implies (7.5).

APPENDIX A. PROOFS OF THE AUXILIARY RESULTS

A.1. Proofs of the results in Section 3.1.

Proof of Lemma 3.1. Choose a chart for M around p(z), say φ , with $\varphi(0) = p(z)$. Extend the orthonormal vectors $e_1, \ldots, e_m, e_{m+1}, \ldots, e_n$ to an adapted orthonormal frame, that is, an orthonormal frame whose first m vectors are tangent to M. Define a chart Ψ for the normal bundle νM as follows:

$$\mathbb{R}^m \times \mathbb{R}^n \ni (x, (b_{m+1}, \dots, b_{m+n})) \mapsto \left(\varphi(x), \sum_{i=m+1}^{m+n} b_i e_i(\varphi(x))\right)$$

Moreover let $F: \nu M \to \mathbb{R}^{m+n}$ be defined as $(y,\nu) \mapsto y + \nu$. We will first compute the differential of F at $(0, (\bar{b}_{m+1}, \dots, \bar{b}_{m+n}))$, where $\sum_{i=m+1}^{m+n} \bar{b}_i e_i(z) = z - p(z)$. In our chart, we take a C^1 curve $\gamma_t = (x(t), (b_{m+1}(t), \dots, b_{m+n}(t)))$ such that $\gamma_0 = (0, \bar{b}_{m+1}, \dots, \bar{b}_{m+n})$. Hence, using the short-hand notations $\bar{b} = (\bar{b}_{m+1}, \dots, \bar{b}_{m+n})$ and $\bar{b} = (\bar{b}_{m+1}, \dots, \bar{b}_{m+n})$, we have that

$$D(F \circ \Psi)(0,\bar{b})[\dot{x},\dot{b}] = \partial_t (F \circ \gamma)_{|0} = D_{\dot{x}}\varphi + \sum \dot{b}_i e_i + \sum \bar{b}_i D_{D_{\dot{x}}\varphi} e_i$$
$$= D_{\dot{x}}\varphi - \prod_{\sum \bar{b}_i e_i} (D_{\dot{x}}\varphi, \cdot) + \sum \bar{b}_i P_{T^{\perp}M} D_{D\varphi \dot{x}} e_i + \sum \dot{b}_i e_i ,$$

where all the sums are understood over i = m + 1, ..., m + n. We thus see that

$$D(F \circ \Psi)(0, \bar{b})[\dot{x}, \dot{b}] = \begin{bmatrix} D_{\dot{x}}\varphi - \prod_{z=p(z)} (D_{\dot{x}}\varphi, \cdot) & 0\\ & * & \dot{b}^T \end{bmatrix}$$

Now, notice that the map $z \mapsto (p(z), z-p(z))$ is the inverse of F, this means that, in our chart, $p(F \circ \Psi(x, b)) = \varphi(x)$ for every (x, b). Differentiating at $(0, \bar{b})$,

$$Dp(F \circ \Psi(0,\bar{b})) \left[\begin{array}{c|c} D_{\dot{x}}\varphi - \Pi_{z-p(z)}(D_{\dot{x}}\varphi, \cdot) & 0\\ \hline & \ast & \dot{b}^T \end{array} \right] = \left[\begin{array}{c|c} D_{\dot{x}}\varphi\\ \hline & 0 \end{array} \right] \,.$$

This means that, for every $v \in \mathbb{R}^m$ and $w \in \mathbb{R}^n$,

$$Dp(x) \begin{bmatrix} \operatorname{Id}_m - \operatorname{II}_{z-p(z)} & 0 \\ * & \operatorname{Id}_n \end{bmatrix} \begin{bmatrix} v \\ w \end{bmatrix} = \begin{bmatrix} v \\ 0 \end{bmatrix},$$

and thus the claim is proved.

Proof of Lemma 3.2. Since d = |z - p(z)| we use the formula for Dp(z) to compute $D\frac{1}{2}d^2 = z - p(z)$. We differentiate once again and obtain

$$D^{2}\frac{1}{2}d^{2} = D(z - p(z)) = \mathrm{Id}_{m+n} - Dp(z) = \left[\begin{array}{c|c} \mathrm{Id}_{m} - \left(\mathrm{Id}_{m} - \mathrm{II}_{z - p(z)}\right)^{-1} & 0\\ \hline 0 & \mathrm{Id}_{n} \end{array}\right],$$

where we used Lemma 3.1. Now,

$$\mathrm{Id}_m - \mathrm{II}_{z-p(z)} = \mathrm{Id}_m - |z - p(z)| \mathrm{diag}(\kappa_j)_{j=1,\dots,m} = \mathrm{diag}(1 - d(z)\kappa_j)_{j=1,\dots,m},$$

so that we have proved the claim.

A.2. Proofs of the results in Section 3.3.

Proof of Lemma 3.3. For δ_0 sufficiently small, the bilinear form $-\langle u, \mathcal{L}_M u \rangle$ is elliptic in $H_0^1(B_1^M, \nu M)$. Existence and uniqueness of energy solutions to $\mathcal{L}_M = f$, for f merely in $L^2(\nu M)$ follows by Riesz representation. Since the boundary ∂B_1^M is smooth, $W^{2,p}$ estimates hold up to the boundary:

$$\|u\|_{C^{1}(B_{1}^{M})} \leq C \|u\|_{W^{2,m+1}(B_{1}^{M})} \leq C \|f\|_{L^{\infty}(B_{1}^{M})}.$$

Proof of Lemma 3.4. The first inequality in (3.2) is the interior Schauder regularity for strongly elliptic systems. For what concerns the second inequality, we claim that

$$\Delta_M |w|^2 + C\delta_0^2 |w|^2 \ge 0 \qquad \text{weakly in } B_1^M.$$
(A.1)

Indeed, we take as test function ζw where $\zeta \in C_c^1(B_1^M)$ and $\zeta \geq 0$. On the one hand,

$$\int_{M} Dw : D(\zeta w) = 2 \int_{M} \operatorname{II}_{w} : \operatorname{II}_{\zeta w} \le C\delta^{2} \int_{M} |w|^{2} \zeta \,.$$

On the other hand,

$$\int_{M} Dw : D(\zeta w) \ge \sum_{i=1}^{m} \int_{M} (D_{e_i}w) \cdot (wD_{e_i}\zeta + \zeta D_{e_i}w)$$
$$= \sum_{i=1}^{m} \int_{M} (D_{e_i}\zeta)w \cdot D_{e_i}w + \sum_{i=1}^{m} \int_{M} \zeta |D_{e_i}w|^2 \ge \frac{1}{2} \int_{M} D\zeta \cdot D|w|^2,$$

thus (A.1) is satisfied weakly. Let $\varphi_1 > 0$ be the first eigenfunction of the Laplace-Beltrami operator

$$-\Delta_M \varphi_1 = \lambda_1 \varphi_1$$
 and $\varphi_1 = 0$ on $\partial B^M_{7/6}$.

Now, as soon as $C\delta_0^2 \leq \lambda_1$, we claim that the function $|w|^2/\varphi_1$ cannot have interior maximum points in B_1^M . This proves that

$$\sup_{B_1^M} |w|^2 \le \frac{\sup_{\partial B_1^M} \varphi_1}{\inf_{B_1^M} \varphi_1} \sup_{\partial B_1^M} |w|^2 \le C \sup_{\partial B_1^M} |w|^2.$$

Let us check the claim. Set $\psi \coloneqq |w|^2$ and compute

$$\Delta_M(\psi/\varphi_1) = \frac{\varphi_1 \Delta_M \psi - \psi \Delta_M \varphi_1}{\varphi_1^2} + 2\frac{\psi |D\varphi_1|^2 - \varphi_1 D\varphi_1 \cdot D\psi}{\varphi_1^3}.$$

Now, if $x_0 \in M \cap B_1^M$ is a putative interior maximum point for ψ/φ_1 , we have

$$\psi(x_0)D\varphi_1(x_0) = \varphi_1(x_0)D\psi(x_0)$$

so substituting

$$\Delta_{M}(\psi/\varphi_{1})(x_{0}) \geq \frac{-C\delta_{0}^{2}\psi\varphi_{1} + \lambda_{1}\psi\varphi_{1}}{\varphi_{1}^{2}} + \underbrace{2\underbrace{\frac{\psi|D\varphi_{1}|^{2} - \varphi_{1}D\varphi_{1} \cdot D\psi}{\varphi_{1}^{3}}}_{\text{vanishes at } x_{0}} \geq (\lambda_{1} - C\delta_{0}^{2})\frac{\psi(x_{0})}{\varphi_{1}(x_{0})} > 0,$$

a contradiction unless $\psi \equiv 0$. Thus the second part of (3.2) is proved.

A.3. Proofs of results in Section 3.4.

Proof of Lemma 3.5. We suppress the subscript f from Γ_f . Let e_1, \ldots, e_m be an orthonormal frame for M. Define $F: M \to \mathbb{R}^{m+n}$ as $F(x) \coloneqq x + f(x)$, then set, for a.e. $z \in \Gamma$,

$$w_i(z) \coloneqq (D_{e_i}F)(p(z)) = (e_i + D_{e_i}f)(p(z))$$

Notice that w_1, \ldots, w_m form a basis of $T_z\Gamma$ for a.e. $z \in \Gamma$, provided that $\operatorname{Lip}(f)$ is small enough. We are going to use that

$$D_{w_i}w_j(F(x)) = D_{e_i}(e_j + D_{e_j}f)(x).$$
(A.2)

Define also the matrix field $g_{i,j} \coloneqq w_i \cdot w_j$, and let $g^{i,j}$ be its inverse (which exists, if LIP(f) is small enough).

The following computations are carried for \mathcal{H}^m -a.e. $x \in M$. First, for $i, j = 1, \ldots, m$,

$$g_{i,j}(F(\cdot)) = \left(e_i \cdot e_j + D_{e_i}f \cdot D_{e_j}f + e_i \cdot D_{e_j}f + e_j \cdot D_{e_i}f\right)$$

= $\left(\delta_{i,j} + D_{e_i}f \cdot D_{e_j}f - 2\mathrm{II}_f(e_i, e_j)\right),$ (A.3)

where we used also the symmetry of the second fundamental form. Now,

We remark that by (A.3), for $i, j = 1, \ldots, m$,

$$g^{i,j} = \delta_{i,j} - D_{e_i} f \cdot D_{e_j} f + 2 \Pi_f(e_i, e_j) + O(|Df|^4 + \delta^2 |f|^2),$$

in particular,

$$g^{i,j} = \delta_{i,j} + 2\Pi_f(e_i, e_j) + O(|Df|^2 + \delta^2 |f|^2).$$

Hence,

$$\operatorname{div}_{\Gamma}(\varphi \circ p)(F(\cdot)) = \sum_{i=1}^{m} (e_i + D_{e_i}f) \cdot D_{e_i}\varphi + \sum_{i,j=1}^{m} 2\operatorname{II}_f(e_i, e_j)(e_i + D_{e_i}f) \cdot D_{e_j}\varphi + O((|Df|^2 + \delta^2 f^2)|D\varphi|).$$

Now we compute

$$\begin{split} \sum_{i=1}^{m} (e_i + D_{e_i}f) \cdot D_{e_i}\varphi + \sum_{i,j=1}^{m} 2\mathrm{II}_f(e_i, e_j)(e_i + D_{e_i}f) \cdot D_{e_j}\varphi \\ &= -H \cdot \varphi + \sum_{i=1}^{m} D_{e_i}f \cdot D_{e_j}\varphi - 2\mathrm{II}_f : \mathrm{II}_{\varphi} + 2\sum_{i,j=1}^{m} \mathrm{II}_f(e_i, e_j)D_{e_i}f \cdot D_{e_j}\varphi \\ &= \sum_{i=1}^{m} D_{e_i}f \cdot D_{e_j}\varphi - 2\mathrm{II}_f : \mathrm{II}_{\varphi} + O(\delta|D\varphi||f||Df|) \,. \end{split}$$

This concludes the proof of the first part of the lemma. We have now to estimate |Df|. Recalling that $P_{T\Gamma} = \sum_{i,j=1}^{m} g^{i,j} w_i \otimes w_j$ and $P_{TM} = \sum_{k=1}^{m} e_k \otimes e_k$,

$$\begin{split} \frac{1}{2} |T_{F(x)}\Gamma - T_x M|^2 &= \frac{1}{2} |P_{T_{F(x)}}\Gamma|^2 + \frac{1}{2} |P_{T_x M}|^2 - P_{T_{F(x)}}\Gamma : P_{T_x M} = m - \sum_{i,j,k=1}^m g^{i,j} w_i \cdot e_k w_j \cdot e_k \\ &= m - \sum_{i,j,k=1}^m g^{i,j} (\delta_{i,k} + e_k \cdot D_{e_i} f) (\delta_{j,k} + e_k \cdot D_{e_j} f) \\ &= m - \sum_{i,j=1}^m g^{i,j} (\delta_{i,j} + e_j \cdot D_{e_i} f + e_i \cdot D_{e_j} f + P_{TM} D_{e_i} f \cdot P_{TM} D_{e_j} f) \\ &= m - \sum_{i,j}^m \delta^{i,j} (\delta_{i,j} - 2 \Pi_f(e_i, e_j) + P_{TM} D_{e_i} f \cdot P_{TM} D_{e_j} f) \\ &+ \sum_{i,j}^m D_{e_i} f \cdot D_{e_j} f (\delta_{i,j} - 2 \Pi_f(e_i, e_j) + P_{TM} D_{e_i} f \cdot P_{TM} D_{e_j} f) \\ &- \sum_{i,j}^m 2 \Pi_f(e_i, e_j) (\delta_{i,j} - 2 \Pi_f(e_i, e_j) + P_{TM} D_{e_i} f \cdot P_{TM} D_{e_j} f) \\ &+ O(|Df|^4 + \delta^2 |f|^2) \\ &= - \sum_{i=1}^m |P_{TM} D_{e_i} f|^2 + |Df|^2 + O(\delta f |Df|^2 + |Df|^4 + \delta^2 f^2) \,, \end{split}$$

which proves that $|Df|^2 \leq \sum_{i=1}^m |P_{TM}D_{e_i}f|^2 + C(\delta_0^2 f^2 + |T_{F(x)}\Gamma - T_xM|^2)$. Now,

$$\sum_{i=1}^{m} |P_{TM}D_{e_i}f|^2 = \sum_{i,j=1}^{m} (D_{e_i}f \cdot e_j)^2 = \sum_{i,j=1}^{m} (D_{e_i}e_j \cdot f)^2 = |\mathrm{II}_f|^2 = O(\delta^2 |f|^2),$$

which yields the conclusion.

Proof of Lemma 3.6. We use the same notation as in the proof of Lemma 3.5. In particular, we use the map F(x) = x + f(x), the orthonormal frame e_1, \ldots, e_m for M and the basis w_1, \ldots, w_m for Γ . We define as in Lemma 3.5 the matrices $g_{i,j}$ and $g^{i,j}$, and we recall (A.3). We are also going to use (A.2). In the following computations, we will use Einstein's convention and omit to write the summation over repeated indices. We also introduce the error terms $E^{ij} \coloneqq g^{i,j} - \delta_{i,j} - 2 \Pi_f(e_i, e_j)$. Recall that we have to compute the $C^{1/2}$ norm of

$$H_{\Gamma} = P_{T^{\perp}\Gamma} g^{i,j} D_{w_i} w_j = g^{i,j} D_{w_i} w_j - P_{T\Gamma} g^{i,j} D_{w_i} w_j$$

$$= g^{i,j} D_{w_i} w_j - g^{h,k} g^{i,j} w_h w_k \cdot D_{w_i} w_j$$

$$= (\delta_{i,j} + 2\Pi_f^{i,j} + E^{i,j}) D_{e_i} (e_j + D_{e_j} f)$$

$$- (\delta_{h,k} + 2\Pi_f^{h,k} + E^{h,k}) (\delta_{i,j} + 2\Pi_f^{i,j} + E^{i,j}) (e_h + D_{e_h} f) (e_k + D_{e_k} f) \cdot D_{e_i} (e_j + D_{e_j} f)$$
(A.4)

where we used the explicit expression $P_{T\Gamma} = g^{h,k} w_h \otimes w_k$. To ease the notation, we define the vector field $v \coloneqq D_{e_i} e_i$, notice that $v \in TM$, because $H_M = 0$. Notice that $E^{i,j}$ is made of terms of order at least 2 in f. We write the term of order 0 in f of (A.4) as

$$D_{e_i}e_i - e_ke_k \cdot D_{e_i}e_i = v - P_{TM}v = P_{T^{\perp}M}v = H_M = 0.$$

We write the term of order 1 in f of (A.4) as

$$\begin{split} 2\mathrm{II}_{f}^{i,j} D_{e_{i}} e_{j} + D_{e_{i}} D_{e_{j}} f \\ &- 2\mathrm{II}_{f}^{h,k} e_{h} e_{k} \cdot D_{e_{i}} e_{i} - 2\mathrm{II}_{f}^{i,j} e_{k} e_{k} \cdot D_{e_{i}} e_{j} - D_{e_{k}} f e_{k} \cdot D_{e_{i}} e_{i} - e_{k} D_{e_{k}} f \cdot D_{e_{i}} e_{i} - e_{k} e_{k} \cdot D_{e_{i}} D_{e_{i}} f \\ &= 2\mathrm{II}_{f}^{i,j} D_{e_{i}} e_{j} - 2\mathrm{II}_{f}^{i,j} e_{k} e_{k} \cdot D_{e_{i}} e_{j} - 2\mathrm{II}_{f}^{h,k} e_{h} e_{k} \cdot v + D_{e_{i}} D_{e_{j}} f - D_{v} f - e_{k} D_{e_{k}} f \cdot v - P_{TM} D_{e_{i}} D_{e_{i}} f \\ &= 2\mathrm{II}_{f}^{i,j} (P_{T^{\perp}M} D_{e_{i}} e_{j}) + 2P_{TM} D_{v} f + P_{T^{\perp}M} D_{e_{i}} D_{e_{i}} f - D_{v} f - e_{k} D_{e_{k}} f \cdot v \\ &= 2\mathrm{II}_{f} : \mathrm{II}_{i} + 2P_{TM} D_{v} f + P_{T^{\perp}M} \Delta f + P_{T^{\perp}M} D_{v} f - D_{v} f - e_{k} D_{e_{k}} f \cdot v \\ &= \mathcal{L}_{M} f + 2P_{TM} D_{v} f + P_{T^{\perp}M} D_{v} f - D_{v} f - e_{k} D_{e_{k}} f \cdot v \\ &= \mathcal{L}_{M} f \,, \end{split}$$

where we used the symmetry of the second fundamental form twice, precisely in

$$\mathrm{II}_{f}^{h,k}e_{h}e_{k}\cdot v = \mathrm{II}_{f}^{k,h}e_{h}e_{k}\cdot v = D_{e_{k}}e_{h}\cdot fe_{h}e_{k}\cdot v = -D_{e_{k}}f\cdot e_{h}e_{h}e_{k}\cdot v = -P_{TM}D_{v}f$$

and

$$e_k D_{e_k} f \cdot v = -e_k D_{e_k} v \cdot f = -e_k II_f(e_k, v) = -e_k II_f(v, e_k) = -e_k D_v e_k \cdot f = e_k e_k \cdot D_v f = P_{TM} D_v f.$$

Hence, $H_{\Gamma}(F(x)) = \mathcal{L}_M f(x) + R(x)$, where the error therm R satisfies $\|R\|_{C^{1/2}(B_1^M)} \leq C \|f\|_{C^{2.1/2}(B_1^M)}^2.$ \Box

Proof of Lemma 3.7. Fix an orthonormal frame $\{e_1, \ldots, e_m\}$ for M. If $v: M \to \mathbb{R}^{m+n}$ is a C^2 normal section of M, we denote by Γ_v its graph, that is the manifold

$$\Gamma_v \coloneqq \{x + v(x) : x \in B_1^M\}$$

As in the previous proofs, the mean curvature vector of Γ_v is

$$H_{v} = g^{i,j} D_{w_{i}} w_{j} - g^{h,k} g^{i,j} w_{h} w_{k} \cdot D_{w_{i}} w_{j} .$$
(A.5)

We remark that $H_v(x) \in \mathbb{R}^{m+n}$ lies in fact in the subspace $T_{x+f(x)}\Gamma_v^{\perp}$. Here, $g^{ij}(x)$ are the entries of the inverse of the matrix $(w_i \cdot w_j)_{i,j}$ and $w_i(x+v(x)) \coloneqq e_i(x) + D_{e_i}f(x)$.

Consider the map

$$\Phi: X \to Y \times Z, \qquad \Phi: v \mapsto (H_v, v|_{\partial B^M_*}),$$

where X, Y and Z are the following Banach spaces

$$X \coloneqq C^{2,1/2}(B_1^M, \nu M), \quad Y \coloneqq C^{1/2}(B_1^M, \mathbb{R}^{m+n}), \quad Z \coloneqq C^{2,1/2}(\partial B_1^M, \nu M)$$

We claim that

- (1) Φ is of class $C^1(X, Y \times Z)$ around the point v = 0;
- (2) the derivative at v = 0 is the Jacobi operator of M, that is $D_u \Phi(0) = (\mathcal{L}_M u, u|_{\partial B_1^M})$, and it is invertible.

Given the claims, the lemma follows by the inverse function theorem (since $||h||_X \leq \varepsilon_0$). Set indeed

$$h' \coloneqq \Phi^{-1}(0, h|_{\partial B^M})$$

and combine Lemma 3.6 with the Lipschitz character of Φ^{-1} :

$$||h - h'||_X \le C ||H_h||_Y \le C ||h||_X^2 \le C\varepsilon^2$$
.

Now, item (1) follows inspecting the formula giving H_v , namely (A.5), which can be generally written as

$$H_v(x) = F(x, v(x), Dv(x), D^2v(x)),$$

with F smooth and all arguments ranging in a compact domain. If $\Phi = (\Phi_Y, \Phi_Z)$, then

$$D_{\varphi}\Phi_{Y}(v) = \frac{d}{dt}\Big|_{t=0} H_{v+t\varphi}(x) = \sum_{k=0}^{2} F_{k+2}(x, v(x), Dv(x), D^{2}v(x))D^{k}\varphi(x)$$

where F_j is a short-hand for derivatives of F in the *j*-th entry. Now using that $C^{1/2}$ is an algebra and that F is smooth one concludes that if $v_k \to v$ in $X = C^{2,1/2}$ and $||u_k||_X \leq 1$, then

$$||D_{u_k}\Phi_Y(v_k) - D_{u_k}\Phi_Y(v)||_{C^{1/2}} \to 0.$$

Let us prove item (2). Lemma 3.6 shows that $D_u \Phi(0) = \mathcal{L}_M u$. The maximum principle for \mathcal{L}_M (see Lemma 3.4) shows that $D\Phi(0)$ is injective. Schauder regularity and Lemma 3.3 show that $D\Phi(0)$ is surjective. \Box
