ON GENERAL VERSIONS OF THE PETTY PROJECTION INEQUALITY

ABSTRACT. The classical Petty projection inequality is an affine isoperimetric inequality which constitutes a cornerstone in the affine geometry of convex bodies. By extending the polar projection body to an interdimensional operator, Petty's inequality was generalized in [17] to the so-called (L_p, Q) setting, where Q is an *m*-dimensional compact convex set. In this work, we further extend the (L_p, Q) Petty projection inequality to the broader realm of rotationally invariant measures with concavity properties, namely, those with γ -concave density (for $\gamma \geq -1/nm$). Moreover, when p = 1, and motivated by a contemporary empirical reinterpretation of Petty's result [30], we explore empirical analogues of this inequality.

1. INTRODUCTION

The classical isoperimetric inequality in asserts that among all convex bodies (compact convex sets with non-empty interior) of a given volume, euclidean balls have the smallest surface area. More precisely, if $K \subset \mathbb{R}^n$ is a convex body and B_2^n is the euclidean unit ball in \mathbb{R}^n ,

(1.1)
$$S(K) \ge S(B_K),$$

where $S(\cdot)$ denotes the surface area and B_K is an euclidean ball with the same volume as K.

A well-known affine strengthening of (1.1) is provided by the Petty projection inequality (see [31]). This result shows that among convex bodies with prescribed volume, the polar projection body (see Section 2 for a precise definition) has maximal volume when K is an ellipsoid. In a more detailed

manner, for every convex body $K \subset \mathbb{R}^n$

(1.2) $|\Pi^{\circ}(K)| \le |\Pi^{\circ}(B_K)|,$

where $|\cdot|$ denotes the *n*-dimensional Lebesgue measure or *volume*. The projection body operator and its polar has attracted a lot of attention during decades becoming a cornerstone of the affine geometry of convex bodies and the Brunn-Minkowski theory. For context and background we refer the interested reader to the excellent books by Gardner [13], Gruber [14] and Schneider [34].

Listing all the works related to Petty's inequality (1.2) and the projection body would be out of the scope of this manuscript. Nevertheless, we would like to point out that the projection body operator was extended to the L_p setting, for p > 1, by Lutwak, Yang and Zhang in the seminal paper [23], where they continued the work of Petty extending (1.2) to this realm. Other remarkable extension of this operator is the asymmetric L_p projection body introduced by Ludwig in [20], where she gave a complete classification of it from the perspective of Minkowski valuations (see also [19] for extensive study of the classical case). An analogue of (1.2) for the latter bodies was proved, among other related results, by Haberl and Schuster in [15]. More recently, an empirical version of the classical Petty projection inequality was obtained by Paouris, Pivovarov, and Tatarko [30]; their work follows the empirical interpretation of isoperimetric inequalities initiated in [26] and further developed in [27, 10, 29].

In this work, we will be mainly concern about the (L^p, Q) polar projection body, $\Pi^{\circ}_{Q,p}(\cdot)$ (see (2.3)). This generalization was recently introduced and extensively studied by Haddad, Langharst, Putterman, Roysdon and Ye in [17], building on a previous work [16]. Among other related results, the following (L^p, Q) Petty projection inequality was established:

Theorem A ([17]). Let $m, n \in \mathbb{N}$, $K \subset \mathbb{R}^n$ and $Q \subset \mathbb{R}^m$ be convex bodies containing the origin in its interior. Then

$$|\Pi_{Q,p}^{\circ}(K)|_{nm} \leq |\Pi_{Q,p}^{\circ}(B_K)|_{nm}.$$

Equality holds for p = 1 if and only if K is an ellipsoid; if p > 1 and $n \ge 3$, then there is equality if and only if K is an origin symmetric ellipsoid. When n = 2 the equality conditions were shown in [35].

We would like to remark that the (L_p, Q) polar projection body provides an unifying framework that encompasses the aforementioned generalizations [23, 20, 15].

Our contributions are twofold. First, following the approach of [25, Section 8.2] along with a new observation from the L_p setting, we extend Theorem A to absolutely continuous rotationally invariant, convex measures (i.e., measures with a γ -concave density for $\gamma \geq -1/nm$). The result reads as follows.

Theorem 1.1. Let $K \subset \mathbb{R}^n$ and $Q \subset \mathbb{R}^m$ be convex bodies containing the origin in its interior. Then, for any absolutely continuous rotationally invariant, convex measure ν in \mathbb{R}^{nm}

$$\nu\left(\Pi_{Q,p}^{\circ}(K)\right) \leq \nu\left(\Pi_{Q,p}^{\circ}(B_K)\right).$$

Secondly, motivated by the aforementioned empirical interpretation of the Petty projection inequality, we shall study empirical versions of the previous result. To briefly introduce the setting (note that we follow the notation of [26]), for vectors $x_1, \ldots, x_N \in \mathbb{R}^n$ (with $N \ge 1$) and a convex body $C \subset \mathbb{R}^N$, we denote by $[x_1, \ldots, x_N]$ the $n \times N$ matrix with columns x_i , so that

$$[x_1, ..., x_N]C = \left\{ c^1 x_1 + \dots + c^N x_N : c = (c^1, ..., c^N) \in C \right\}.$$

Accordingly, if X_1, \ldots, X_N are random vectors in \mathbb{R}^n , then $[X_1, \ldots, X_N]C$ is a random set. The empirical version of (1.2) obtained in [30] takes the following form.

Theorem B ([30]). Let $C \in \mathbb{R}^N$ be a convex body. If $\{X_i\}_{i=1}^N$ are independent random vectors respectively distributed w.r.t the densities $\{f_i\}_{i=1}^N$, then, for any absolutely continuous rotationally invariant, log-concave measure ν in \mathbb{R}^n

$$\mathbb{E}\left[\nu\left(\Pi^{\circ}([X_1,...,X_N]C)\right)\right] \leq \mathbb{E}\left[\nu\left(\Pi^{\circ}([X_1^*,...,X_N^*]C)\right)\right],$$

where $\{X_i^*\}_{i=1}^N$ are independent random vectors respectively distributed w.r.t. the symmetric decreasing rearrangement of $\{f_i\}_{i=1}^N$.

In the spirit of [30] and building on the ideas of [25, Section 8.2], we prove the following when p = 1.

Theorem 1.2. Let $C \in \mathbb{R}^N$ be a convex body and $Q \in \mathbb{R}^m$ be a convex body containing the origin in its interior, where $m, N \in \mathbb{N}$. If $\{X_i\}_{i=1}^N$ are independent random vectors respectively distributed w.r.t the densities $\{f_i\}_{i=1}^N$, then, for any rotationally invariant, convex measure ν in \mathbb{R}^{nm}

$$\mathbb{E}\left[\nu\left(\Pi_Q^{\circ}\left([X_1,...,X_N]C\right)\right)\right] \leq \mathbb{E}\left[\nu\left(\Pi_Q^{\circ}\left([X_1^*,...,X_N^*]C\right)\right)\right],$$

where $\{X_i^*\}_{i=1}^N$ are independent random vectors respectively distributed w.r.t. the symmetric decreasing rearrangement of $\{f_i\}_{i=1}^N$.

Finally, we would like to remark that, as a byproduct of the tools developed to prove Theorem 1.1, we recover a recent result by Cao, Wang and Wang [36] concerning the L_p -analogue of the surface area measure (see Corollary 3.1).

The paper is organized as follows. In Section 2 we collect some preliminaries, background material and several tools the we shall use later on. Section 3 is devoted to the proof of Theorem 1.1 and some remarks related with L_p mixed volumes. Finally, the proof of Theorem 1.2 is provided in Section 4

2. Background material

We shall work with d-dimensional euclidean spaces \mathbb{R}^d endowed with their standard inner product $\langle \cdot, \cdot \rangle$, and x^i are used for the *i*-th coordinate of a vector in such a space. Given any set $M \subset \mathbb{R}^n$, we use χ_M to denote its characteristic function. For any given unit direction $u \in \mathbb{S}^{n-1}$, we shall use u^{\perp} , $P_{u^{\perp}}$ and R_u for a hiperplane with normal vector u, the orthogonal projection onto it, and the reflection map about it. Along the paper, the k-dimensional Lebesgue measure of a measurable set is denoted by $|\cdot|_k$ and we will omit the index k when it is equal to the dimension of the ambient space; furthermore, as usual, integrating dx will stand the integration with respect to the Lebesgue measure.

Let $K_1, ..., K_m \subset \mathbb{R}^n$ be convex bodies and $\lambda_1, ..., \lambda_n \ge 0$. The volume of their Minkowski sum is given by

$$|\lambda_1 K_1 + \dots + \lambda_m K_m| = \sum_{1 \le i_1, \dots, i_n \le m} \lambda_{i_1} \cdots \lambda_{i_n} V(K_{i_1}, \dots, K_{i_n}),$$

where the coefficient $V(K_{i_1}, ..., K_{i_n})$ is the so-called mixed volume of *n*-tuple $(K_{i_1}, ..., K_{i_n})$ (see [34, Section 5] for background and properties). We shall use the standard abbreviation V(K[n-k], L[k]) when the sets appear, respectively, n - k and k times in the mixed volume with $k \in \{1, ..., n-1\}$.

Let $K \subset \mathbb{R}^n$ be a convex body, its support function h_K and polar body K° are given by

$$h_K(x) = \max_{x \in K} \langle x, y \rangle$$
 and $K^\circ = \{ x \in \mathbb{R}^n : h_K(x) \le 1 \}.$

If K contains the origin in its interior, its minkowski functional is defined as $||x||_K = \inf\{\lambda > 0 : x \in \lambda K\}$. Note that, in this case, $K = \{x \in \mathbb{R}^n : ||x||_K \leq 1\}$ and $|| \cdot ||_{K^\circ} = h_K(\cdot)$. We shall also recall some definitions; the projection body, ΠK , of K is the centrally symmetric convex body whose support function is given by $h_{\Pi K}(u) = |P_{u^{\perp}}K|_{n-1} = nV(K[n-1], [0, u])$ where, for any given direction $u \in \mathbb{S}^{n-1}$, [0, u] is a segment joining the origin and u. Thus the polar projection body, denoted as $\Pi^\circ K$, is merely $(\Pi K)^\circ$.

2.1. The (L_p, Q) setting. Let $K, L \subset \mathbb{R}^n$ be convex bodies containing the origin in its interior. The *p*-sum of *K* and *L* (introduced by Firey [11]), $K +_p L$, is defined via its support function as

(2.1)
$$h_{K+nL}^p(u) = h_K^p(u) + h_L(u)^p,$$

with $u \in \mathbb{S}^{n-1}$ (see also [24] for a more general pointwise definition). The L^p mixed volume, introduced by Lutwak [21, 22], is defined as

(2.2)
$$V_p(K,L) = \frac{p}{n} \lim_{\varepsilon \to 0^+} \frac{|K + p\varepsilon \cdot L| - |K|}{\varepsilon}$$

In order to introduce the (L^p, Q) polar projection body, it shall be convenient to identify \mathbb{R}^n with the collection of $n \times 1$ column vectors, \mathbb{R}^m with the collection of $1 \times m$ row vectors, and \mathbb{R}^{nm} with the collection of $n \times m$

matrices. Of course, this considerations are not needed when the matrix multiplication is not involved. Fix $k, n, m \in \mathbb{N}$. Given $A \subset \mathbb{R}^{nk}, B \subset \mathbb{R}^{km}$, we have that $A^t = \{x^t : x \in A\}$ and $A.B = \{x.y : x \in A, y \in B\} \subset \mathbb{R}^{nm}$. Here, x.y means the left-to-right matrix multiplication of x and y, and x^t means the transpose of the matrix x. Given a convex bodies Q and K in \mathbb{R}^m and \mathbb{R}^n , respectively, both containing the origin in its interior. The (L_p, Q) polar projection body, introduced in [17] for $p \geq 1$, is defined via its Minkowski functional as

(2.3)
$$\|\bar{x}\|_{\Pi^{0}_{Q,p}K}^{p} = nV_{p}(K, \bar{x}.Q^{t}),$$

where $\bar{x} \in \mathbb{R}^{nm}$ is non-zero. This encapsulates several generalizations of the polar projection body operator; for instance, if $Q = -\Delta_m$ the recently introduced *m*th-order case [16] shows up. Moreover, when Q = [-1, 1], and $p \ge 1$, the L_p case by Lutwak, Yang and Zhang [23] and the Q = [0, 1] case by Haberl and Schuster [15] are also recovered.

2.2. Linear parameter systems. We shall also collect the notion of a *linear parameter system* introduced by Rogers and Shepard in [33] (see also [34, Section 10.4]). Let $K \subset \mathbb{R}^n$ be a convex body, and $u \in \mathbb{S}^{n-1}$ a unit direction. A linear parameter system is a family of convex bodies $\{K(t)\}_{t \in I}$ that can be represented as

(2.4)
$$K(t) = \operatorname{conv}\{x_j + \lambda_j tu : j \in \mathcal{J}\},\$$

where $\{x_j\}_{j\in\mathcal{J}}$ and $\{\lambda_j\}_{j\in\mathcal{J}}$ are bounded sets in \mathbb{R}^n and \mathbb{R} respectively. We shall also make use of the case in which the index set is a convex body K, i.e,

$$K(t) = \operatorname{conv}(\{x + t\alpha(x)u : x \in K\}).$$

where α is a bounded *speed function*. A fundamental property of this construction is its convexity under mixed volumes: an elegant proof can be found in [34, Theorem 10.4.1].

Theorem 2.1. Let $\{K_i(t)\}_{t\in I}$, with i = 1, ..., n, be linear parameter systems in the direction $u \in \mathbb{S}^{n-1}$. Then $t \mapsto V(K_1(t), ..., K_n(t))$ is convex.

As a corollary one obtains a classical result proved by Rogers and Shepard [32].

Corollary 2.1. Let $\{K(t)\}_{t\in I}$ a linear parameter system. Then $t \mapsto |K(t)|$ is convex.

Linear parameter system have demonstrated to be a powerful tool to prove isoperimetric type inequalities (and its reverse counterpart in the plane). To list some fundamental contributions in this regard, we would like to mention the work of Campi and Gronchi [6, 8, 7] and Campi, Colesanti and Gronchi [5]. In this work, we shall mostly use a specific linear parameter system. Let $K \subset \mathbb{R}^n$ be a convex body and $u \in \mathbb{S}^{n-1}$. Then $\{K_u(t)\}_{t \in [-1,1]}$ is the linear parameter system given by

(2.5)
$$K_u(t) = \{ y + su : y \in P_{u^{\perp}}K, \ s \in [f_u^t(y), -g_u^t(y)] \},\$$

with

$$f_u^t(y) = \frac{(1+t)f_u(y) + (1-t)g_u(y)}{2}$$

and

$$g_u^t(y) = \frac{(1-t)f_u(y) + (1+t)g_u(y)}{2},$$

where $f_u, g_u: P_{u^{\perp}} K \to \mathbb{R}$ are convex functions such that

$$K = \{y + su : y \in P_{u^{\perp}}K, \ s \in [f_u(y), -g_u(y)]\}$$

Note that $\{K_u(t)\}_{t\in[-1,1]}$ interpolates continuously between K, R_uK and S_uK $(K_u(1) = K, K_u(-1) = R_uK$ and $K_u(0) = S_uK$), and $K_u(-t) = R_uK_u(t)$. Moreover, $|K_u(t)| = |K|$ for all $t \in [-1, 1]$. In addition, for every $y \in u^{\perp}$ and $t \in [-1, 1]$

$$K_u(t)_y = \frac{1+t}{2}K_y + \frac{1-t}{2}R_uK_y,$$

where we use the notation K_y for the one dimensional fiber $K \cap (y + \mathbb{R})$. The interested reader may check [25, Lemma 2.1] for further details.

A natural question is wether linear parameter systems are "preserved" under the Minkowski addition or, more generally, for the *p*-sum (2.1) with $p \ge 1$. The following result by Bianchini and Colesanti provides an answer.

Theorem 2.2. [1] Let $\{K(t)\}_{t\in I}$ and $\{L(t)\}_{t\in I}$ be linear parameter systems along the direction $u \in \mathbb{S}^{n-1}$. Then, for every $p \ge 1$ $\{K(t) +_p L(t)\}_{t\in I}$ is also a linear parameter system along the direction $u \in \mathbb{S}^{n-1}$.

2.3. Functional results. To finish the background section, we recall some functional results and definitions that will be used later on. We say that a function $\varphi : \mathbb{R}^n \longrightarrow \mathbb{R}_{>0}$ is *p*-concave, for $p \in \mathbb{R} \cup \{\pm \infty\}$, if

$$\varphi((1-\lambda)x+\lambda y) \ge ((1-\lambda)\varphi(x)^p + \lambda\varphi(y)^p)^{1/p}$$

for all $x, y \in \mathbb{R}^n$ such that $\varphi(x)\varphi(y) > 0$ and any $\lambda \in (0, 1)$. The cases $p = 0, p = \infty$ and $p = -\infty$ follow by continuity of the *p*-means, i.e, one obtains the geometric mean, the maximum and the minimum (of $\varphi(x)$ and $\varphi(y)$), respectively. Note that if p > 0, then φ is *p*-concave if and only if φ^p is concave on its support $\{x \in \mathbb{R}^n : \varphi(x) > 0\}$. In particular, a 0-concave function is usually called *log-concave* whereas a $(-\infty)$ -concave function is referred to as *quasi-concave*. Moreover, Jensen's inequality ensures that a *q*-concave function is also *p*-concave, whenever q > p.

Let $s \in [-\infty, 1]$ and ν be a Borel measure in \mathbb{R}^n . Then ν is s-concave if

$$\nu((1-\lambda)A + \lambda B) \ge ((1-\lambda)\nu(A)^s + \lambda\nu(B)^s)^{1/s}$$

 $\mathbf{6}$

When $s = -\infty$ the measure is usually referred to as *convex*. Following Borell's characterization [2], an absolutely continuous measure ν in \mathbb{R}^n with density φ is *s*-concave if and only if φ is *p*-concave with p = s/(1-ns) (Note that Jensen's inequality implies that convex measures are the largest class among *s*-concave ones). The latter can be deduced from the following result, originally proved in [2] and [3] (see also [12] for a detailed presentation).

Theorem 2.3 (The Borell-Brascamp-Lieb inequality). Let $\lambda \in (0,1)$. Let $-1/n \leq p \leq \infty$ and let $f, g, h : \mathbb{R}^n \longrightarrow \mathbb{R}_{\geq 0}$ be measurable functions, with positive integrals, such that

$$h((1-\lambda)x + \lambda y) \ge ((1-\lambda)f(x)^p + \lambda g(y)^p)^{1/p}$$

for all $x, y \in \mathbb{R}^n$ such that f(x)g(y) > 0. Then

(2.6)
$$\int_{\mathbb{R}^n} h(x) \, \mathrm{d}x \ge \left((1-\lambda) \left(\int_{\mathbb{R}^n} f(x) \, \mathrm{d}x \right)^q + \lambda \left(\int_{\mathbb{R}^n} g(x) \, \mathrm{d}x \right)^q \right)^{1/q},$$

where $q = p/(np+1).$

Another consequence of the Borell-Brascamp-Lieb inequality is the following.

Corollary 2.2. Let $f : \mathbb{R}^n \times \mathbb{R}^d$ be a p-concave function, with $p \ge -1/n$. Then

$$F(y) = \int_{\mathbb{R}^n} f(x, y) \, \mathrm{d}x$$

is p/(np+1)-concave.

We conclude by recalling the notion of symmetric decreasing rearrangement. We essentially follow [4] (see also [18, Chapter 3]). Let $A \subset \mathbb{R}^n$ be a measurable set with finite volume. Its symmetric rearrangement A^* is an euclidean open ball with the same volume as A. Let now $f : \mathbb{R}^n \to \mathbb{R}_+$ be an integrable function. Using its *layer-cake representation*

$$f(x) = \int_0^{+\infty} \chi_{\{f(x) > t\}}(x) \, \mathrm{d}t,$$

the symmetric decreasing rearrangement of f, denoted as f^* , is given by

$$f^*(x) = \int_0^{+\infty} \chi_{\{f(x) > t\}^*}(x) \, \mathrm{d}t$$

Note that f^* is radially symmetric and decreasing. Moreover, it preserves the volume of the super level sets, i.e, $|\{f(x) > t\}| = |\{f^*(x) > t\}|$ for all t > 0.

A result involving symmetric decreasing rearrangements that will be central in this note is Chris't version [9] of Rogers-Brascamp-Lieb-Luttinger's inequality. As shown in [26] (see also [28, 30]), this theorem is a powerful tool for proving empirical type isoperimetric inequalities. We state it for reader's convenience.

Theorem 2.4 ([9]). Let $f_1, ..., f_N : \mathbb{R}^n \to \mathbb{R}_+$ be integrable functions and let $F : (\mathbb{R}^n)^N \to \mathbb{R}_+$. Suppose that F satisfies that, for any $u \in \mathbb{S}^{n-1}$ and $\bar{y} = (y_1, ..., y_N) \subset u^{\perp}$, the function $F_{u,\bar{y}}; \mathbb{R}^N \to \mathbb{R}_+$ defined by $F_{u,\bar{y}}(t_1, ..., t_N) = F(y_1 + t_1u, ..., y_N + t_Nu)$ is even and quasi-concave. Then

$$\int_{(\mathbb{R}^n)^N} F(x_1, ..., x_N) \prod_{i=1}^N f_i(x_i) \, \mathrm{d}\bar{x} \le \int_{(\mathbb{R}^n)^N} F(x_1, ..., x_N) \prod_{i=1}^N f_i^*(x_i) \, \mathrm{d}\bar{x},$$

where $d\bar{x}$ stands for $dx_1, ..., dx_N$.

3. On the (L_p, Q) Petty's projection inequality

We start this section by proving a simple observation regarding the interplay between L_p -mixed volumes (2.2) and linear parameter systems.

Lemma 3.1. Let $\{K(t)\}_{t\in I}$ and $\{L(t)\}_{t\in I}$ be linear parameter systems, both along the direction $u \in \mathbb{S}^{n-1}$ and containing the origin for all $t \in I$, such that |K(t)| does not depend on t. Then $t \mapsto V_p(K(t), L(t))$ is convex for every $p \geq 1$.

Proof. Let $\varepsilon > 0$ and $\phi_{\varepsilon} : I \to \mathbb{R}$ be the function given by

$$\phi_{\varepsilon}(t) = \frac{|K(t) +_{p} \varepsilon \cdot L(t)| - |K|}{\varepsilon}$$

Theorem 2.2 together with Corollary 2.1 imply that ϕ_{ε} is a convex function for every $\varepsilon > 0$. Moreover, using that K(t) and L(t) contain the origin for any $t \in I$, we have that $K(t) +_p \varepsilon \cdot L(t)$ is a convex body for every $t \in I$ and $\varepsilon > 0$. Hence, the limit $\lim_{\varepsilon \to 0^+} \phi_{\varepsilon}(t)$ always exists. Finally, taking into account that $V_p(K(t), L(t)) = \lim_{\varepsilon \to 0^+} \frac{p}{n} \phi_{\varepsilon}(t)$, the assertion immediately follows.

Recently, Cao, Wang and Wang [36] establish, among other related results, an L_p -analogue of the so-called Steiner inequality. Specifically, they proved that, for any convex body K containing the origin in its interior, its L_p surface area $S_p(K)$ does not increase under Steiner symmetrization. Note that $S_p(K) = V_p(K, B_2^n)$, and hence Lemma 3.1 implies the following.

Proposition 3.1. Let $\{K(t)\}_{t\in I}$ be a linear parameter system containing the origin for all $t \in I$. Then, $t \mapsto S_p(K(t))$ is convex for every $p \ge 1$.

As a consequence, we recover the result of Cao, Wang and Wang.

Corollary 3.1. Let $K \subset \mathbb{R}^n$ be a convex body containing the origin in its interior. Then, for every $u \in \mathbb{S}^{n-1}$,

$$S_p(S_uK) \le S_p(K).$$

Proof. Considering $\{K_u(t)\}_{t \in [-1,1]}$ defined in (2.5) (which contains the origin in its interior for all $t \in I$), we get that

$$S_p(S_uK) = S_p(K_u(0)) \le \frac{1}{2}S_p(K) + \frac{1}{2}S_p(R_uK) = S_p(K)$$

as desired.

We are now ready to prove the main result of the section.

Proof of Theorem 1.1. Let ν be a rotationally invariant, convex measure in \mathbb{R}^{nm} with $d\nu(\bar{x}) = \phi(\bar{x}) d\bar{x}$ (ϕ is -1/nm-concave). To make notation more compact $d\bar{x}$ stands for $dx_1 \cdots dx_m$ whereas $\bar{s} = (s_1, ..., s_m) \in \mathbb{R}^m$. For a fixed $u \in \mathbb{S}^{n-1}$ and $\bar{x} = (x_1, ..., x_m) \in \mathbb{R}^{nm}$ we will use $(y_i + s_i u)_i$ for $(y_1 + s_1 u, ..., y_m + s_m u)$, where for all $1 \leq i \leq m x_i = y_i + s_i u$. Let $\{K_u(t)\}_{t \in [-1,1]}$ be the shadow system (2.5). From (2.3) we get that

$$\begin{split} \nu\Big(\Pi_{Q,p}^{\circ}\big(K_{u}(t)\big)\Big) &= \int_{(\mathbb{R}^{n})^{m}} \chi_{\{nV_{p}(K_{u}(t),\bar{x}.Q^{t}) \leq 1\}}(\bar{x}) \,\phi(\bar{x}) \,\mathrm{d}\bar{x} \\ &= \int_{(u^{\perp})^{m}} \int_{\mathbb{R}^{m}} \chi_{\{nV_{p}(K_{u}(t),(y_{i}+s_{i}u)_{i}.Q^{t})\}}((y_{i}+s_{i}u)_{i}) \,\phi_{\bar{y}}(\bar{s}) \,\mathrm{d}\bar{y} \,\mathrm{d}\bar{s} \\ &= \int_{(u^{\perp})^{m}} F(t,\bar{y}) \,\mathrm{d}\bar{y}, \end{split}$$

where $F(t, \bar{y}) : [-1, 1] \times (u^{\perp})^m \to \mathbb{R}_+$ is the function given by

$$F(t,\bar{y}) = \int_{\mathbb{R}^m} \chi_{\{f_p(t,\bar{s}) \le 1\}}(t,\bar{s})\phi_{\bar{y}}(\bar{s}) \,\mathrm{d}\bar{s},$$

 $\phi_{\bar{y}}(\bar{s}) = \phi((y_i + s_i u)_i)$ and $f_p(t, \bar{s}) = nV_p(K_u(t), (y_i + s_i u)_i Q^t)$. On the one hand, we have that

$$f_p(-t, -\bar{s}) = nV_p(K_u(-t), (y_i - s_i u)_i.Q^t)$$

= $nV_p(R_u K_u(t), R_u((y_i + s_i u)_i.Q^t))$
= $f_p(t, \bar{s}).$

On the other hand, let $\lambda \in (0,1)$ and $(t,\bar{s}), (t',\bar{s}') \in [-1,1] \times \mathbb{R}^m$. Then,

$$f((1-\lambda)t + \lambda t', (1-\lambda)\overline{s} + \lambda \overline{s}')$$

= $nV_p(K_u((1-\lambda)t + \lambda t'), (y_i + ((1-\lambda)s_i + \lambda s'_i)u)_i.Q^t)$

Note that $\{K_u((1-\lambda)t+\lambda t')\}_{\lambda\in(0,1)} = \{K_u(\lambda)\}_{\lambda\in(0,1)}$ is also a linear parameter system. Moreover, for all $\lambda\in(0,1)$ $K_u(\lambda)$ contains the origin and $|K_u(\lambda)| = |K|$. In addition, for any $q = (q^1, ..., q^m) \in Q$ we have that $(y_i + s_i u)_i . q^t = q^1(y_1 + s_1 u) + ... + (y_m + s_m u)q^m$. Therefore,

i.e., $\left\{ \left(y_i + ((1-\lambda)s_i + \lambda s'_i)u \right)_i Q^t \right\}_{\lambda \in \{0,1\}}$ is a linear parameter system of the form (2.4), generated by the sets $\{x_q\}_{q \in Q}$ and $\{\mu_q\}_{q \in Q}$, which contains the origin for all $\lambda \in \{0,1\}$. Hence, using Lemma 3.1, we get that $\lambda \mapsto f_p((1-\lambda)t + \lambda t', (1-\lambda)\bar{s} + \lambda \bar{s}')$ is convex, which yields the joint convexity

of $f_p(t, \bar{s})$. Thus, the function $\varphi : [-1, 1] \times (u^{\perp})^m \times \mathbb{R}^m$ given by $\varphi(t, \bar{y}, \bar{s}) = \chi_{\{f_n(t, \bar{s}) \leq 1\}}(t, \bar{s})\phi_{\bar{y}}(\bar{s})$ is (-1/nm)-concave. Now since

$$F(t,\bar{y}) = \int_{\mathbb{R}^m} \varphi(t,\bar{y},\bar{s}) \,\mathrm{d}\bar{s},$$

Corollary 2.2 implies that $F(t, \bar{y})$ is α -concave, with $\alpha = \frac{1}{m(1-n)}$. Moreover, considering $F_{\bar{y}}(t) = F(t, \bar{y})$ for any fixed $\bar{y} \in (u^{\perp})^m$, by a change of variables and the evenness of $f_p(t, \bar{s})$ we get that

$$F_{\bar{y}}(-t) = \int_{\mathbb{R}^m} \chi_{\{f_p(-t,\bar{s}) \le 1\}} \phi_{\bar{y}}(\bar{s}) \, \mathrm{d}\bar{s}$$
$$= \int_{\mathbb{R}^m} \chi_{\{f_p(t,-\bar{s}) \le 1\}} \phi_{\bar{y}}(\bar{s}) \, \mathrm{d}\bar{s}$$
$$= \int_{\mathbb{R}^m} \chi_{\{f_p(t,\bar{s}) \le 1\}} \phi_{\bar{y}}(-\bar{s}) \, \mathrm{d}\bar{s}$$
$$= F_{\bar{y}}(t),$$

where in the last identity we have used the rotational invariance of the measure ν . The latter, together with the fact that $F_{\bar{y}}(t)$ is α -concave, implies that $F_{\bar{y}}(t) \leq F_{\bar{y}}(0)$ for all $t \in [-1, 1]$ and $y \in (u^{\perp})^m$. In particular,

$$\nu\left(\Pi_{Q,p}^{\circ}(K)\right) = \int_{(u^{\perp})^m} F_{\bar{y}}(1) \,\mathrm{d}\bar{y} \le \int_{(u^{\perp})^m} F_{\bar{y}}(0) \,\mathrm{d}\bar{y} = \nu\left(\Pi_{Q,p}^{\circ}(S_uK)\right).$$

The proof concludes from the following two facts; on the one hand, for any convex body K one can find a sequence of Steiner symmetrizations which converges (w.r.t. the Hausdorff metric) to an euclidean ball with same volume as K. On the other hand, the operator $\Pi_{Q,p}^{\circ}$ is continuous w.r.t. the corresponding Hausdorff metric (see [17, Proposition 3.8]). \Box

4. Empirical inequalities

This section is devoted to the proof of Theorem 1.2. Although we essentially adapt the ideas used in [30], which build on the argument developed in [25, Proposition 8.4], we include a sketch of the proof for the sake of completeness.

Proof of Theorem 1.2. Let $\bar{y} \in (u^{\perp})^N$ and denote $C_{\bar{y}}(\bar{t}) = [y_1 + t_1 u, ..., y_N + t_N u]C$. Let $f : \mathbb{R}^{n-1} \times \mathbb{R}^m \to \mathbb{R}_+$ be the function given by

$$f(\bar{t},\bar{s}) = nV(C_{\bar{y}}(\bar{t})[n-1], (w_i + s_i u)_i Q^t)$$

We have that

$$\begin{split} \nu \Big(\Pi_Q^{\circ} \big(C_{\bar{y}}(\bar{t}) \big) \Big) &= \int_{(u^{\perp})^m} \int_{\mathbb{R}^m} \chi_{\{nV(C_{\bar{y}}(\bar{t})[n-1], (w_i + s_i u)_i \cdot Q^t) \leq 1\}} \, \phi_{\bar{y}}(\bar{s}) \, \mathrm{d}\bar{w} \, \mathrm{d}\bar{s} \\ &= \int_{(u^{\perp})^m} \int_{\mathbb{R}^m} \chi_{\{f(\bar{t},\bar{s}) \leq 1\}} \, \phi_{\bar{y}}(\bar{s}) \, \mathrm{d}\bar{w} \, \mathrm{d}\bar{s} \\ &= \int_{(u^{\perp})^m} F_{\bar{w},\bar{y}}(\bar{t}) \, \mathrm{d}\bar{w}, \end{split}$$

where, fixed $\bar{w} \in (u^{\perp})^m$ and $\bar{y} \in (u^{\perp})^N$, $F_{\bar{w},\bar{y}} : \mathbb{R}^N \to \mathbb{R}_+$ is the function given by

$$F_{\bar{w},\bar{y}}(\bar{t}) = \int_{\mathbb{R}^m} \chi_{\{f(t,\bar{s}) \le 1\}} \phi_{\bar{w}}(\bar{s}) \,\mathrm{d}s$$

and $\phi_{\bar{w}}(\bar{s}) = \phi(w_1 + s_1 u, ..., w_m + s_m u)$. Hence,

$$\mathbb{E}\left[\nu\left(\Pi_Q^{\circ}\left([X_1,...,X_N]C\right)\right)\right]$$

= $\int_{(u^{\perp})^N} \int_{\mathbb{R}^N} \nu\left(\Pi_Q^{\circ}\left(C_{\bar{y}}(\bar{t})\right)\right) \prod_{i=1}^N f_i(y_i + t_i u) \,\mathrm{d}\bar{t}\mathrm{d}\bar{y}$
= $\int_{(u^{\perp})^N} \int_{\mathbb{R}^N} \int_{(u^{\perp})^m} F_{\bar{w},\bar{y}}(\bar{t}) \prod_{i=1}^N f_i(y_i + t_i u) \,\mathrm{d}\bar{w} \,\mathrm{d}\bar{t}\,\mathrm{d}\bar{y}.$

Let $\lambda \in (0,1)$ and $t, t' \in \mathbb{R}^N$. Then both

$$\left\{C_{\bar{y}}\left((1-\lambda)t+\lambda t'\right)\right\}_{\lambda\in(0,1)} \quad \text{and} \quad \left\{\left(w_i+\left((1-\lambda)s_i+\lambda s'_i\right)u\right)_i.Q^t\right\}_{\lambda\in(0,1)}\right\}$$

are linear parameter systems in the direction u. Therefore, Theorem 2.1 implies that $f(\bar{t}, \bar{s})$ is jointly convex. Moreover, since $C_{\bar{y}}(-\bar{t}) = R_u C_{\bar{y}}(\bar{t})$ and $(w_i - s_i u)_i Q^t = R_u (w_i + s_i u)_i Q^t$, it follows that $f(\bar{t}, \bar{s})$ is even. The latter two facts, together with Corollary 2.2 and the rotational invariance of the measure ν , imply that, for any $u \in \mathbb{S}^{n-1}$, $F_{\bar{w},\bar{y}}(\bar{t})$ is an α -concave (and, in particular, quasi-concave), even function for every $\bar{w} \in (u^{\perp})^m$ and $\bar{y} \in (u^{\perp})^N$. Thus, using Theorem 2.4,

$$\mathbb{E}\left[\nu\Big(\Pi_Q^{\circ}\big([X_1,...,X_N]C\big)\Big)\right] \le \mathbb{E}\left[\nu\Big(\Pi_Q^{\circ}\big([X_1^*,...,X_N^*]C\big)\Big)\right]$$

Remark 4.1. Attending to the arguments used in the proofs of the Theorems 1.1 and 1.2, it may be natural to wonder about possible empirical results in the L_p -setting. In this regard, we note that the employed strategies heavily rely on the fact that $\{C_y((1-\lambda)t + \lambda t')\}_{\lambda \in (0,1)}$ is a linear parameter system and the convexity of mixed volumes. In contrast, when dealing with L_p -mixed volumes $V_p(K,L)$, we are only able to prove the convexity of the function $t \mapsto V_p(K(t), L(t))$ when |K(t)| does not depend on t (see Lemma 3.1) which is certainly not the case of $\{C_{\bar{y}}((1-\lambda)t+\lambda t')\}_{\lambda\in(0,1)}$.
