A NOTE ON SPECTRAL VOLUME COMPARISON FOR MANIFOLDS WITH WEAKLY CONVEX BOUNDARY

ABSTRACT. We establish a new boundary version of spectral volume comparison theorem in this paper. Let $(M^n, g)(n \ge 3)$ be a connected, smooth compact ndimensional manifold with weakly convex boundary. If there exist a positive function $w \in C^{\infty}(M)$ that satisfies:

$$\begin{cases} -\frac{n-1}{n-2}\Delta w + \operatorname{Ric} w \ge (n-1)w, \\ \frac{\partial w}{\partial \eta} = 0. \end{cases}$$

then $\operatorname{Vol}(M) \leq \operatorname{Vol}(\mathbb{S}^{+}_{+})$, and equality holds if and only if M^{n} is isometric to the unit round hemisphere $\mathbb{S}^n_+ = \{x \in \mathbb{R}^{n+1} : |x| = 1, x_{n+1} \ge 0\} \subset \mathbb{R}^{n+1}.$

1. INTRODUCTION

A classical Bonnet-Myers theorem states that if a complete *n*-dimensional Riemannian manifold M has Ricci curvature Ric_M at least (n-1)K, then the diameter of M is at most $\frac{\pi}{\sqrt{K}}$, moreover, it follows from Bishop-Gromov volume comparison theorem that for a fixed $p \in M$, the ratio $\frac{\operatorname{Vol}(B_r(p))}{\operatorname{Vol}(B^K(r))}$ is nonincreasing for any $r \in (0, \infty)$. When K > 0, the equality holds if and only if M is isometric to $\mathbb{S}^n(\frac{1}{\sqrt{K}})$. S. Y. Cheng in [2] proved a rigidity theorem which states that if the diameter is equal to $\frac{\pi}{\sqrt{K}}$, then M is isometric to the *n*-sphere with constant sectional curvature K. Recently, G. Antonelli and K. Xu [1] prove a sharp and rigid spectral generalization of both Bonnet-Myers theorem and classical Bishop-Gromov volume comparison theorem, which is precisely stated as follows.

Theorem 1 ([1]). Let M^n , $n \geq 3$, be an n-dimensional compact smooth manifold with $n \geq 3$, and let $0 \leq \theta \leq \frac{n-1}{n-2}$, $\lambda > 0$. Let $\operatorname{Ric}(x) := \inf_{v \in T_p M, |v|=1} \operatorname{Ric}_x(v, v)$ be the smallest eigenvalue of the *Ricci* tensor. Assume there is a positive function $w \in C^{\infty}(M)$ such that:

$$\theta \Delta_M w \leq \operatorname{Ric} w - (n-1)\lambda w,$$

Let \tilde{M} be the universal cover of M, endowed with the pull-back metric. Then:

• A diameter bound

diam
$$(M) \le \frac{\pi}{\sqrt{\lambda}} (\frac{\max w}{\min w})^{\frac{n-3}{n-1}\theta},$$

in particular, $\pi_1(M)$ is finite.

• A sharp volume bound

$$\operatorname{Vol}(\tilde{M}) \le \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n).$$

Moreover, if equality holds, then every function w is constant, and \tilde{M} is isometric to the round sphere of radius $\lambda^{-\frac{1}{2}}$.

This theorem is intimately connected with stable Bernstein problem. In order to address the stable Bernstein problem in \mathbb{R}^5 , C. Chodosh, C. Li, P. Minter and D. Stryker [5] established a volume comparison theorem via weighted isoperimetric profile, but their method works only for 3-dimensional μ -bubbles. It is remarkable that the weakness has been overcome by the unequally weighted isoperimetric profile in [1], which pave the way to study the stable Bernstein problem. Soon, combing the strategy of [5] with the Theorem 1, L. Mazet successfully solved the stable Bernstein problem in \mathbb{R}^6 . Additionally, the spectral volume comparison theorem is also a useful tool in other aspects such as the structure of manifolds.

For compact manifold with boundary and positive Ricci curvature, F. Hang and X. Wang [8] proved a boundary rigidity result as follows:

Theorem 2. Let $(M^n, g)(n \ge 2)$ be a compact manifold with nonempty boundary $\Sigma = \partial M$. Suppose

- Ric $\geq (n-1)g$,
- $(\Sigma, g|_{\Sigma})$ is isometric to the standard sphere $\mathbb{S}^{n-1} \subset \mathbb{R}^n$,
- Σ is weakly convex in the sense that its second fundamental form A is nonnegative.

Then (M^n, g) is isometric to the hemisphere.

It is natural to investigate whether the theorem 1 can be extended to compact manifolds with boundary. Based on the method in [1], the author in [9] has obtained the spectral diameter estimate of 3-dimensional compact manifold with convex boundary, in order to prove the non-existence of weakly stable free boundary CMC hypersurfaces in 5-manifolds. For general *n*-dimensional manifold, we establish a spectral generalization of Bonnet-Myers and Bishop-Gromov volume comparison theorem for compact manifold with weakly convex boundary.

Theorem 3. Let M^n , $n \ge 3$, be a compact connected manifold with weakly convex boundary ∂M , and let $0 \le \theta \le \frac{n-1}{n-2}$, $\lambda > 0$. We denote by $\operatorname{Ric}(x) := \inf_{v \in T_p M, |v|=1} \operatorname{Ric}_x(v, v)$ the smallest eigenvalue of the Ricci tensor. Assume there is a positive function $w \in C^{\infty}(M)$ satisfying Neumann boundary condition $\frac{\partial w}{\partial \eta} = \langle \nabla^M w, \eta \rangle = 0$, and the following inequality holds:

$$\theta \Delta_M w \leq \operatorname{Ric} w - (n-1)\lambda w,$$

then we have the diameter estimate:

diam
$$(M) \le \frac{\pi}{\sqrt{\lambda}} (\frac{\max w}{\min w})^{\frac{n-3}{n-1}\theta},$$

and the volume estimate:

$$\operatorname{Vol} M \le \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n_+).$$

Moreover, if equality holds, then every function w is constant, and \tilde{M} is isometric to the round hemisphere of radius $\lambda^{-\frac{1}{2}}$.

1.1. **organization.** In section 2, we give some basic definitions and properties about isoperimetric profiles. In section 3, we will use free boundary μ -bubbles to obtain the diameter estimate of *n*-dimensional compact manifold with weakly convex boundary, which is the generalization of Theorem 32 in [9]. In section 4, we establish the unequally weighted free boundary isoperimetric profile, get a differential inequality in the barrier sense, finally we obtain the volume bound.

2. PRELIMINARIES

First, we assume all manifolds are complete in this paper. We now introduce the notions of μ -bubbles and isoperimetric profile of a Riemannian manifold. It's remarkable that it can be defined in any space with suitable notions of volume and perimeter as in metric measure spaces.

2.1. free boundary unequally warped μ -bubbles.

Definition 4. We say that a manifold $(M^n, \partial M)$ has weakly convex boundary if and only if $A \ge 0$, where A is the second fundamental form of ∂M with respect to η , and η is the co-normal of ∂M in M.

Given a compact *n*-dimensional Riemannian manifold (N^n, g) with weakly convex boundary $\partial N = \partial_0 N \cup \partial_- N \cup \partial_+ N$ ($\partial_i N$ is nonempty for $i \in \{0, -, +\}$), where $\partial_- N$ and $\partial_+ N$ are disjoint and each of them intersect with $\partial_0 N$ at angles no more than $\frac{\pi}{8}$ inside M. We fix a smooth function w > 0 on N and a smooth function h on $N \setminus (\partial_- N \cup \partial_+ N)$, with $h \to \pm \infty$ on $\partial_{\pm} N$. We pick a regular value c_0 of h on $N \setminus (\partial_- N \cup \partial_+ N)$ and take $\Omega_0 = h^{-1}((c_0, \infty))$ as the reference set, and consider the following area functional:

$$\mathcal{A}(\Omega) := \int_{\partial^*\Omega} w^{\theta} d\mathcal{H}^{n-1} - \int_N (\chi_{\Omega} - \chi_{\Omega_0}) h w^{\alpha} d\mathcal{H}^n,$$

for all Caccioppoli sets Ω with $\Omega \Delta \Omega_0 \Subset \mathring{N}$ and $k \in \mathbb{N}$, where $\theta, \alpha \ge 0$, and the reference set Ω_0 with smooth boundary satisfies

$$\partial \Omega_0 \subset N, \qquad \partial_+ N \subset \Omega_0$$

If there exist Ω can minimizes \mathcal{A} in this class, we call it a free boundary unequally warped μ -bubble.

About the existence and regularity of a minimizer of \mathcal{A} among all Caccioppoli sets, we refer to [3, 7, 13, 14] for more details. We only elaborate the conclusions and omit the detailed proof.

Proposition 5. There exists a smooth minimizer Ω for \mathcal{A} such that $\Omega \Delta \Omega_0$ is compactly contained in $\mathring{N} \cup \partial_0 N$. The minimizer has smooth boundary which intersect with $\partial_0 N$ orthogonally.

Let v_{Σ} denote by the unit normal of Σ , and let $\phi \in C^{\infty}(N)$. For an arbitrary variation $\{\Omega_t\}_{t\in(-\epsilon,\epsilon)}$ with $\Omega_0 = \Omega$ and the variational vector field $\dot{F}_t = \phi v_{\Sigma}$ at t = 0, we assume that $\Sigma = \partial \Omega$ is a critical point of the area functional and calculate its first variation and the second variation.

Lemma 6. If Ω_t is a smooth 1-parameter family of regions with $\Omega_0 = \Omega$ and the normal variational vector field \dot{F}_t at t = 0 is $\phi \nu_{\Sigma}$, then

$$\begin{aligned} \frac{d}{dt}\big|_{t=0}\mathcal{A}(\Omega_t) &= \int_{\partial\Omega_t} \theta w^{\theta-1} \left\langle \nabla^M w, \nu_{\Sigma_t} \right\rangle \phi + w^{\theta} H \phi - h w^{\alpha} \phi + \int_{\partial\Sigma_t} w^{\theta} \left\langle \dot{F}_t, \nu_{\partial\Sigma_t} \right\rangle \\ &= \int_{\Sigma} (H_{\Sigma} + \theta w^{-1} \left\langle \nabla^M w, \nu_{\Sigma} \right\rangle - h w^{\alpha-\theta}) w^{\theta} \phi \end{aligned}$$

where ν_{Σ} is the outward pointing unit normal vector field and H is the mean curvature of $\partial \Omega_t$. In particular, a μ -bubble Ω with $\partial \Omega = \Sigma$ satisfies

$$H_{\Sigma} = hw^{\alpha-\theta} - \theta w^{-1} \left\langle \nabla^{M} w, \nu_{\Sigma} \right\rangle, \quad \dot{F}_{0} \perp \nu_{\partial\Sigma} \quad for \quad x \in \partial\Sigma \subset \partial_{0}N.$$

Lemma 7. Assume Ω is a minimizer of \mathcal{A} in the settings above, then we can have the following the second variational formula:

$$\begin{split} &\frac{d^2}{dt^2}\big|_{t=0} \big(\mathcal{A}(\Omega_t)\big) \\ &= \int_{\Sigma} \left[-\Delta_{\Sigma}\phi - |\operatorname{II}_{\Sigma}|^2 \phi - \operatorname{Ric}_M(\nu_{\Sigma},\nu_{\Sigma})\phi - \theta w^{-2} \left\langle \nabla^M w,\nu_{\Sigma} \right\rangle^2 \phi \right. \\ &\quad + \theta w^{-1} \phi (\Delta_M w - \Delta_{\Sigma} w - H_{\Sigma} \left\langle \nabla^M w,\nu_{\Sigma} \right\rangle - \theta w^{-1} \left\langle \nabla^{\Sigma} w,\nabla^{\Sigma} \phi \right\rangle \\ &\quad - \phi \left\langle \nabla^M h,v_{\Sigma} \right\rangle w^{\alpha-\theta} + (\theta-\alpha) w^{\alpha-\theta-1} h\phi \left\langle \nabla^M w,\nu_{\Sigma} \right\rangle] w^{\theta} \phi + \int_{\partial\Sigma} w^{\theta} \phi \frac{\partial \phi}{\partial \nu_{\partial\Sigma}} - A_{\partial\Sigma}(\nu_{\Sigma},v_{\Sigma}) \phi^2 w^{\theta} \end{split}$$

2.2. free boundary unequally warped isoperimetric profile.

Definition 8. Let (M^n, g) be a Riemannian manifold. The isoperimetric profile of M is the function I_M that assigns, to each $v \in (0, |M|)$, the value

$$I_M(v) = \inf\{P(E) : E \text{ is measurable}, |E| = v\}.$$

The isoperimetric profile of M will be often denoted by I.

Definition 9. Let (M, g) be a Riemannian manifold. We say that a set $E \subset M$ is isoperimetric or that is an isoperimetric region if

$$P(E) = I_M(|E|)$$

If |E| = v, then we say that E is an isoperimetric region of volume v.

We notice that the isoperimetric profile can be understood as an optimal isoperimetric inequality in M, since for any subset $F \subset M$ of volume 0 < |F| < |M|, $P(F) \ge I_M(|F|)$, with equality precisely for isoperimetric sets.

Regularity results for sets minimizing perimeter under a volume constraint were obtained by F. Morgan, who proved in Corollary 3.7 and 3.8 of [6] in the following:

Theorem 10 ([6]). Let E be a measurable set of finite volume minimizing perimeter under a volume constraint in a smooth n-dimensional Riemannian manifold M. There are two kinds of conclusions depended on dimension:

- If $n \leq 7$, then the boundary S of E is a smooth hypersurface.
- If n > 7, then the boundary S of E is the union of a smooth hypersurface S and a closed singular set S_0 of Hausdorff dimension at most n-8 (i.e., $\mathcal{H}^{n-8+\gamma}(S_0) = 0$ for all $\gamma > 0$).

When trying to get geometric information the boundary of a set minimizing perimeter under a volume constraint, the following technical result proved by Sternberg and Zumbrum in Lemma 2.4 of [12] allows us to focus just on the regular part S of the boundary.

Lemma 11 ([12]). Let $E \subset M$ be a bounded minimizer of perimeter under a volume constraint in a smooth Riemannian manifold M. Let S be the regular part of the boundary of E and S_0 its singular part.

Then for every $\epsilon > 0$, there exist open sets $U' \Subset S \subset M$ with $S_0 \subset U', U \subset M$ contained in an open tubular neighborhood in M of S_0 of radius ϵ , and a smooth function $\varphi_{\epsilon} : M \to \mathbb{R}$ such that $0 \leq \varphi_{\epsilon} \leq 1$,

$$\varphi_{\epsilon}(x) = 0 \text{ in } U', \ \varphi_{\epsilon}(x) = 1 \text{ in } M \setminus U,$$

and

$$\int_{S} |\nabla_{S} \varphi_{\epsilon}|^{2} dS \le C\epsilon,$$

for some constant C > 0 depending on E but independent of ϵ .

Given an open set $\Omega \subset M$, we may consider the minimization problem

$$\inf\{P(E): E \subset \Omega, |E| = v\}.$$

We emphasize that the perimeter here is the one in M. There is a regularity result about this restricted profile, which can be found in [11].

Theorem 12. Let (M,g) be a complete Riemannian manifold and $\Omega \subset M$ be an open subset with C^2 boundary. Then for any $0 < v < |\Omega|$, there exist an isoperimetric region E of volume v in Ω . Moreover, the boundary of E satisfies the following properties:

- ∂E is of class $C^{1,1}$ near $\partial \Omega$.
- $\partial E \cap \Omega$ in the union of a smooth hypersurface S with constant mean curvature H and a closed singular set S_0 of Hausdorff dimension at most n 8.

3. DIAMETER ESTIMATES FOR MANIFOLDS WITH CONVEX BUNDARY

For now on, we always assume that $n \geq 3$ throughout the paper. We first consider *n*-dimensional compact manifold with weakly convex boundary, then we can give the diameter estimates in the sense of spectrum condition and weakly convex boundary condition.

3.1. for case $3 \le n \le 7$.

Theorem 13. Let M^n , $n \geq 3$, be a compact connected manifold with weakly convex boundary ∂M , and let $0 \leq \theta \leq \frac{n-1}{n-2}$, $\lambda > 0$. We denote by $\operatorname{Ric}(x) := \inf_{v \in T_p M, |v|=1} \operatorname{Ric}_x(v, v)$ the smallest eigenvalue of the Ricci tensor. If there exist a positive function $w \in C^{\infty}(M)$ that satisfies:

$$\begin{cases} \theta \Delta_M w \le \operatorname{Ric} w - (n-1)\lambda w, \\ \frac{\partial w}{\partial \eta} = 0. \end{cases}$$

then we have the diameter estimate: $\operatorname{diam}(M) \leq \frac{\pi}{\sqrt{\lambda}} (\frac{\max w}{\min w})^{\frac{n-3}{n-1}\theta}$.

Proof. Let $\Omega_+ \subset \Omega_- \subset M$ be two domains with nonempty boundaries, such that $\overline{\Omega}_- \backslash \Omega_+$ is compact. Suppose $h(x) \in C^{\infty}(\Omega_- \backslash \overline{\Omega_+})$ satisfies

(1)
$$\lim_{x \to \partial \Omega_+} h(x) = +\infty, \qquad \lim_{x \to \partial \Omega_-} h(x) = -\infty.$$

For an arbitrary fixed domain Ω_0 with $\Omega_+ \subset \subset \Omega_0 \subset \subset \Omega_-$, consider the functional

$$\mathcal{A}(\Omega_t) = \int_{\partial^* \Omega_t} w^{\theta} - \int_{\Omega_t} h w^{\alpha},$$

defined on sets of finite perimeter, where $\partial^* \Omega$ is the reduced boundary of Ω . According to the Lemma 6 and Lemma 7, we have the second variation formula in the following:

$$\begin{split} &\frac{d^2}{dt^2}\big|_{t=0}\mathcal{A}(\Omega_t) \\ &= \int_{\Sigma} \left[-\Delta_{\Sigma}\phi - |\operatorname{II}_{\Sigma}|^2\phi - \operatorname{Ric}_M(\nu_{\Sigma},\nu_{\Sigma})\phi - \theta w^{-2} \left\langle \nabla^M w,\nu_{\Sigma} \right\rangle^2 \phi \\ &\quad + \theta w^{-1}\phi (\Delta_M w - \Delta_{\Sigma} w - H_{\Sigma} \left\langle \nabla^M w,\nu_{\Sigma} \right\rangle - \theta w^{-1} \left\langle \nabla^{\Sigma} w,\nabla^{\Sigma}\phi \right\rangle \\ &\quad - \phi \left\langle \nabla^M h,v_{\Sigma} \right\rangle w^{\alpha-\theta} + (\theta-\alpha) w^{\alpha-\theta-1} h\phi \left\langle \nabla^M w,\nu_{\Sigma} \right\rangle] w^{\theta}\phi + \int_{\partial\Sigma} w^{\theta}\phi \frac{\partial\phi}{\partial\nu_{\partial\Sigma}} - A_{\partial\Sigma}(\nu_{\Sigma},v_{\Sigma})\phi^2 w^{\theta} \end{split}$$

We choose $\phi = w^{-\theta}$, then we have

$$\int_{\Sigma} -\Delta_{\Sigma} \phi = \theta \int_{\partial \Sigma} w^{-\theta - 1} \left\langle \nabla^{\Sigma} w, \nu_{\partial \Sigma} \right\rangle$$

Integrating by parts, we have

$$\begin{aligned} &-\theta \int_{\Sigma} w^{-1} w^{-\theta} \Delta_{\Sigma} w + w^{-1} \left\langle \nabla^{\Sigma} w, \nabla^{\Sigma} (w^{-\theta}) \right\rangle \\ &= -\theta \int_{\Sigma} w^{-\theta-1} \Delta_{\Sigma} w + w^{-1} \left\langle \nabla^{\Sigma} w, \nabla^{\Sigma} (w^{-\theta}) \right\rangle + \left\langle \nabla^{\Sigma} w, \nabla^{\Sigma} (w^{-1}) \right\rangle w^{-\theta} \\ &- \left\langle \nabla^{\Sigma} w, \nabla^{\Sigma} (w^{-1}) \right\rangle w^{-\theta} \\ &= -\theta \int_{\Sigma} w^{-\theta-1} + \left\langle \nabla^{\Sigma} w, \nabla^{\Sigma} (w^{-\theta-1}) \right\rangle + \theta \int_{\Sigma} \left\langle \nabla^{\Sigma} w, \nabla^{\Sigma} (w^{-1}) \right\rangle w^{-\theta} \\ &= -\theta \int_{\partial\Sigma} \left\langle \nabla^{\Sigma} w, \nu_{\partial\Sigma} \right\rangle w^{-\theta-1} - \theta \int_{\Sigma} |\nabla^{\Sigma} w|^2 w^{-2-\theta} \\ &\leq -\theta \int_{\partial\Sigma} \left\langle \nabla^{\Sigma} w, \nu_{\partial\Sigma} \right\rangle w^{-\theta-1}. \end{aligned}$$

On the other hand, we have

$$|\Pi_{\Sigma}|^{2} \ge \frac{1}{n-1} H_{\Sigma}^{2} = \frac{1}{n-1} (h - \frac{4}{4-k} w^{-1} \langle \nabla^{M} w, \nu_{\Sigma} \rangle)^{2},$$

and

$$\langle \nabla^{\Sigma} w, \nu_{\partial \Sigma} \rangle = \langle \nabla^{M} w, \nu_{\partial \Sigma} \rangle = 0, \ A \ge 0 \ \text{on } \partial \Sigma,$$

which is guaranteed by the weakly convexity of ∂M . Combining these consequences with nonnegativity of the second variation, we obtain that

$$0 \leq \int_{\Sigma} -|\operatorname{II}_{\Sigma}|^{2} w^{-\theta} - \operatorname{Ric}_{M}(\nu_{\Sigma}, v_{\Sigma}) w^{-\theta} - \theta w^{-2} \langle \nabla^{M} w, \nu_{\Sigma} \rangle^{2} + \theta w^{-1-\theta} (\Delta_{M} w - H_{\Sigma} \langle \nabla^{M} w, \nu_{\Sigma} \rangle) - \langle \nabla^{M} h, \nu_{\Sigma} \rangle w^{\alpha-2\theta} + (\theta - \alpha) h w^{\alpha-2\theta-1} \langle \nabla^{M} w, \nu_{\Sigma} \rangle \leq w^{-\theta} \left[-\frac{H_{\Sigma}^{2}}{n-1} - (n-1)\lambda - \theta (w^{-1} \langle \nabla^{M} w, \nu_{\Sigma} \rangle)^{2} - \theta H_{\Sigma} (w^{-1} \langle \nabla^{M} w, \nu_{\Sigma} \rangle) + |\nabla h| w^{\alpha-\theta} + (\theta - \alpha) h w^{\alpha-\theta} (w^{-1} \langle \nabla^{M} w, \nu_{\Sigma} \rangle) \right]$$

Setting $X = hw^{\alpha-\theta}$, $Y = w^{-1} \langle \nabla^M w, \nu_{\Sigma} \rangle$, then $H_{\Sigma} = X - \theta Y$, we have

$$0 \leq \int_{\Sigma} w^{-\theta} \left[-\frac{X^2}{n-1} + \frac{2\theta}{n-1} XY - \frac{\theta^2}{n-1} Y^2 - (n-1)\lambda - \theta Y^2 - \theta (X-\theta Y)Y + |\nabla h| w^{\alpha-\theta} + (\theta-\alpha) XY \right]$$

$$\leq \int_{\Sigma} w^{-\theta} \left[-\frac{X^2}{n-1} - (n-1)\lambda + |\nabla h| w^{\alpha-\theta} + (\frac{2\theta}{n-1} - \alpha) XY + (\frac{n-2}{n-1} \theta^2 - \theta) Y^2 \right]$$

If we set $\alpha = \frac{2\theta}{n-1}$, for $0 \le \theta \le \frac{n-1}{n-2}$. Additionally, if h satisfies

$$|\nabla h| w^{\alpha-\theta} < \frac{h^2 w^{2\alpha-2\theta}}{n-1} + (n-1)\lambda,$$

then we get a contradiction. Therefore, we are going to construct such h satisfying above condition. Then we get the estimate of the diameter:

diam(M)
$$\leq \frac{\pi}{\sqrt{\lambda}} \cdot \left(\frac{\sup(w)}{\inf(w)}\right)^{\frac{n-3}{n-1}\theta}$$
.

First, notice that h is a smooth function on M such that

(2)
$$|\nabla h| < \frac{\sup(w)^{2\alpha - 2\theta}}{(n-1)\inf(w)^{\alpha - \theta}}h^2 + \frac{(n-1)\lambda}{\inf(w)^{\alpha - \theta}} =: Ch^2 + D,$$

then

$$|\nabla h|w^{\alpha-\theta} \le |\nabla h|\inf(w)^{\alpha-\theta} < \frac{h^2 w^{2\alpha-2\theta}}{n-1} + (n-1)\lambda.$$

Moreover, we notice that

$$CD = \lambda \cdot \left(\frac{\sup(w)}{\inf(w)}\right)^{\frac{6-2n}{n-1}\theta}.$$

We can use the same method derived from [1]. Suppose by contradiction the above estimate does not hold, then there is a $\epsilon > 0$ such that

(3)
$$\operatorname{diam}(M) > \frac{\pi}{\sqrt{\lambda}} \cdot \left(\frac{\sup(w)}{\inf(w)}\right)^{\frac{n-3}{n-1}\theta} \cdot (1+\epsilon)^2 + 2\epsilon.$$

Let us fix a point $p \in \partial M$ and take $\Omega_+ := B_{\epsilon}(p)$, and let $d : M \setminus \Omega_+ \to \mathbb{R}$ be a smoothing of $d(\cdot, \partial \Omega_+)$ such that

$$d\big|_{\partial\Omega_+} = 0, \qquad \big|\nabla d\big| \le 1 + \epsilon, \qquad d \ge \frac{d(\cdot, \partial\Omega_+)}{1 + \epsilon}$$

We can define

$$h(x) := \sqrt{\frac{D}{C}} \cot(\frac{\sqrt{CD}}{1+\epsilon} d(x)),$$

which satisfies inequality (2). Note we have that

$$\mathcal{O} := \{d > \frac{2(1+\epsilon)\pi}{\sqrt{2\epsilon_0}}\} \supset \{d(\cdot, p) > \epsilon + \frac{2(1+\epsilon)^2\pi}{\sqrt{2\epsilon_0}}\} \neq \emptyset,$$

due to (3.1). Set $\Omega_{-} := M \setminus \overline{\mathcal{O}}$, then we have found two domains $\Omega_{+} \subset \subset \Omega_{-} \subset \subset M$ and $h(x) \in C^{\infty}(\Omega_{-} \setminus \overline{\Omega_{+}})$ which satisfies (1). Let Ω be an free boundary μ -bubble minimizing the functional, which has smooth boundary. Since the inequality (2) is in force, we get a contradiction with the minimizing property of $\mathcal{A}(\Omega_{t})$.

3.2. for case $n \ge 8$.

Remark 14. We notice that above proof works for $3 \le n \le 7$ for free boundary μ -bubble, there will exist singularity formation in higher dimensions, the diameter estimate for $n \ge 8$ can also be obtained by modifying above argument, we refer readers to [1, Appendix A].

4. Volume comparison for manifold with weakly convex boundary 4.1. for case $3 \le n \le 7$. 4.1.1. Unequally weighted isoperimetric profile. Let $n \ge 3$, and (M^n, g) be a compact manifold Riemannian manifold with weakly convex boundary. Let $0 \le \theta \le \frac{n-1}{n-2}$, and set

$$\alpha := \frac{2\theta}{n-1}.$$

For an open set $E \subset M$ with smooth boundary, we can define unequally weighted area and volume functional by

$$A(E) = \int_{\partial^* E} w^{\theta} \text{ and } V(E) = \int_E w^{\alpha},$$

where w is the smooth positive first eigenfunction of $-\Delta - \mathbf{V}$ in M. Namely, w satisfies

$$-\Delta w \ge \theta^{-1}((n-1)\lambda - \operatorname{Ric})w, \text{ and } \langle \nabla^M w, \eta \rangle = 0.$$

Let $V_0 := \int_M w^{\alpha} \in (0, \infty]$, and define the unequally weighted isoperimetric profile

(4)
$$I(v) := \inf \left\{ \int_{\partial^* E} w^{\theta} : E \subset M \text{ has finite perimeter, and } \int_E w^{\alpha} = v \right\},$$

for all $v \in [0, V_0)$.

Remark 15. We note that I is continuous. On the one hand, by the compactness theory for Caccioppoli sets and the lower semi-continuity, we have $\lim_{v\to v_0} I(v) \ge I(v_0)$. On the other hand, we will show that there exists a continuous upper barrier function for I at v_0 for any $v_0 \in (0, V)$, we also have $\lim_{v\to v_0} I(v) \le I(v_0)$.

4.1.2. First variation. We compute the first variation of the functionals A and V. Let E_t be a smooth family of open sets with sooth boundary whose variational vector field along $\Gamma = \partial E = \partial E_0$ is $\varphi \nu$, where ν is the outward pointing unit normal vector field along ∂E . We can directly compute its first variational formulas.

Proposition 16.

$$\frac{d}{dt}\Big|_{t=0}V(E_t) = \int_{\Gamma} w^{\theta}\varphi \ and \ \frac{d}{dt}\Big|_{t=0}A(E_t) = \int_{\Gamma} w^{\theta}\varphi(H + \theta w^{-1} \left\langle \nabla^M w, \nu \right\rangle).$$

4.1.3. Second variation. We proceed to compute the second variation of the functionals A and V. The process is similar to the free boundary minimal hypersurfaces.

Proposition 17.

$$\begin{split} \frac{d^2}{dt^2} \Big|_{t=0} V(E_t) &= \int_{\Gamma} (H + \alpha w^{-1} \langle \nabla^M w, \nu \rangle) w^{\alpha} \varphi^2 + w^{\alpha} \varphi \langle \nabla^M \varphi, \nu \rangle \,. \\ \frac{d^2}{dt^2} \Big|_{t=0} A(E_t) &= \int_{\Gamma} (-\Delta_{\Gamma} \varphi - \operatorname{Ric}(\nu, \nu) \varphi - |\operatorname{II}_{\Gamma}|^2 \varphi - \theta w^{-2} \langle \nabla^M w, \nu \rangle^2 \varphi) w^{\theta} \varphi \\ &\quad + [\theta w^{-1} (\Delta w - \Delta_{\Gamma} w - H \langle \nabla^M w, \nu \rangle) \varphi - \theta w^{-1} \langle \nabla_{\Gamma} w, \nabla_{\Gamma} \varphi \rangle] w^{\theta} \varphi \\ &\quad + (\theta w^{\alpha - 1} \langle \nabla^M w, \nu \rangle \varphi + w^{\alpha} \varphi \langle \nabla^M \varphi, \nu \rangle + H w^{\alpha} \varphi^2) w^{\theta - \alpha} (H + \theta w^{-1} \langle \nabla^M w, \nu \rangle) \\ &\quad + \int_{\partial \Gamma} w^{\theta} \varphi \langle \nabla^M \varphi, \nu_{\partial \Gamma} \rangle - A_{\partial \Gamma}(\nu, \nu) \varphi^2 w^{\theta} \end{split}$$

4.1.4. Differential inequality in the barrier sense. Fix a $v_0 \in (0, V_0)$. Let E be a weighted isoperimetric surface with free boundary in M for the problem $I(v_0)$. From now on, we fix $\varphi = w^{-\theta}$. We notice that $V(t) := V(E_t)$ is a smooth function. By the first variation information, we have

$$V'(0) = \frac{d}{dt}\Big|_{t=0} V(E_t) = \int_{\partial E} w^{\alpha-\theta} > 0,$$

hence V(t) is a stictly monotone in t in a neighborhood of v_0 . By the inverse function theorem, there is some small $\sigma > 0$ and a smooth function

$$t: (v_0 - \sigma, v_0 + \sigma) \longrightarrow \mathbb{R},$$

that is the inverse of V(t).

Let $u: (v_0 - \sigma, v_0 + \sigma) \to \mathbb{R}$ be defined by u(v) = A(t(v)). Note that $u(v_0) = A(E_0) = I(v_0)$. Moreover, since $V(E_{t(v)}) = v$, we have $A(v) \ge I(v)$ for all $v \in (v_0 - \sigma, v_0 + \sigma)$. Let primes denote derivatives with respect to v and dots denote derivatives with respect to t.

Lemma 18. Let $(M^n, \partial M)$ be a complete, connected compact manifold with weakly boundary. Assume $w \in C^{\infty}(M)$ satisfies $\inf(w) = 1$, $\langle \nabla^M w, \eta \rangle = 0$, and

(5)
$$\theta \Delta w \le w \operatorname{Ric} - (n-1)\lambda w.$$

Suppose for fixed $v_0 \in (0, V_0)$, there exists a bounded set E with finite perimeter, such that $\int_E w^{\alpha} = v_0$ and $\int_{\partial^* E} = I(v_0)$. Then I satisfies

$$I''I \le -\frac{(I')^2}{n-1} - (n-1)\lambda$$

in the viscosity sense at v_0 .

Proof. We first recall the formula for the first and second derivatives of an inverse function:

$$t'(v) = \frac{1}{\dot{v}}(t(v)) \text{ and } t''(v) = -\frac{\ddot{v}(t(v))}{\dot{v}(t(v))^3},$$

then we have

$$t'(v_0) = (\int_{\partial E} w^{\alpha - \theta})^{-1}$$

and

$$t''(v_0) = -\left(\int_{\partial E} w^{\alpha-\theta}\right)^{-3} \int_{\partial E} (H + \alpha w^{-1} \left\langle \nabla^M w, \nu \right\rangle w^{\alpha} \varphi^2 + w^{\alpha} \varphi \left\langle \nabla^M \varphi, \nu \right\rangle)$$

We note that

$$\frac{d}{dv}A(t(v)) = \dot{A}(t(v))t'(v)$$

and

$$\frac{d^2}{dv^2}A(t(v)) = \ddot{A}(t(v))(t'(v))^2 + \dot{A}(t(v))t''(v)$$

Since E is a volume-constrained minimizer, we can conclude that $\frac{d}{dt}|_{t=0}A(E_t) = 0$ whenever $\frac{d}{dt}|_{t=0}V(E_t) = 0$. Therefore $A'(v_0) = w^{\theta-\alpha}(H + \theta w^{-1} \langle \nabla^M w, \nu \rangle)$ is constant. By Proposition 16 and 17 with $\varphi = w^{-\theta}$, we have

$$\begin{aligned} \frac{d^2}{dt^2} \Big|_{t=0} A(E_t) &= \int_{\Gamma} (-\Delta_{\Gamma}(w^{-\theta}) - \operatorname{Ric}(\nu, \nu) w^{-\theta} - |\operatorname{II}_{\Gamma}|^2 w^{-\theta} - \theta w^{-2-\theta} \left\langle \nabla^M w, \nu \right\rangle^2 \\ &+ \theta w^{-\theta-1} (\Delta w - \Delta_{\Gamma} w - H \left\langle \nabla^M w, \nu \right\rangle) - \theta w^{-1} \left\langle \nabla_{\Gamma} w, \nabla_{\Gamma}(w^{-\theta}) \right\rangle \\ &+ (Hw^{\alpha-2\theta}) w^{\theta-\alpha} (H + \theta w^{-1} \left\langle \nabla^M w, \nu \right\rangle) \\ &+ \int_{\partial\Gamma} \left\langle \nabla^M (w^{-\theta}), \nu_{\partial\Gamma} \right\rangle - A_{\partial\Gamma}(\nu, \nu) w^{-\theta} \end{aligned}$$

Using the weakly convexity of ∂M , integrating by parts and rearranging, we obtain that

$$\frac{d^2}{dt^2}\Big|_{t=0}A(E_t) \le \int_{\Gamma} -\operatorname{Ric}(\nu,\nu)w^{-\theta} - |\operatorname{II}_{\Gamma}|^2w^{-\theta} + \theta w^{-\theta-1}\Delta w - \theta w^{-2-\theta} \left\langle \nabla^M w, \nu \right\rangle^2 - \theta H w^{-\theta-1} \left\langle \nabla^M w, \nu \right\rangle + H w^{-\theta} (H + \theta w^{-1} \left\langle \nabla^M w, \nu \right\rangle)$$

According to inequality (5) and set $X = w^{\alpha-\theta}A'(v_0)$, $Y = w^{-1} \langle \nabla^M w, \nu \rangle$, thus $H = X - \theta Y$, and use the trace inequality $| \operatorname{II}_{\Gamma} |^2 \geq H^2/(n-1)$, we have

$$\frac{d^2}{dt^2}\Big|_{t=0}A(E_t) \le \int_{\Gamma} -(n-1)\lambda w^{-\theta} + w^{-\theta} \left(-\frac{X^2}{n-1} + \frac{2\theta XY}{n-1} - \frac{\theta^2 Y^2}{n-1} - \theta Y^2 - \theta XY + \theta^2 Y^2 + X^2 - \theta XY\right).$$

Therefore, we obtain

$$\begin{split} (\int_{\Gamma} w^{\alpha-\theta})^2 \cdot A''(v_0) &= (\ddot{A}(0)(t'(v_0))^2 + \dot{A}(0)t''(v_0))(\int_{\Gamma} w^{\alpha-\theta})^2 \\ &\leq \int_{\Gamma} -(n-1)\lambda w^{-\theta} + w^{-\theta}(-\frac{X^2}{n-1} + \frac{2\theta XY}{n-1} - \frac{\theta^2 Y^2}{n-1} - \theta Y^2 \\ &\quad -\theta XY + \theta^2 Y^2 + X^2 - \theta XY) \\ &- (\int_{\Gamma} w^{\alpha-\theta})^{-1}(\int_{\Gamma} w^{\alpha-\theta} A'(v_0)) \cdot (\int_{\Gamma} (X + \alpha Y - 2\theta Y)w^{\alpha-2\theta}) \\ &= \int_{\Gamma} -(n-1)\lambda w^{-\theta} + w^{-\theta}(-\frac{X^2}{n-1} + \frac{2\theta XY}{n-1} - \frac{\theta^2 Y^2}{n-1} - \theta Y^2 \\ &\quad -\theta XY + \theta^2 Y^2 + X^2 - \theta XY - X^2 - \alpha XY + 2\theta XY) \\ &= \int_{\Gamma} w^{-\theta} [-\frac{X^2}{n-1} + (\frac{2\theta}{n-1} - \alpha)XY + (\frac{n-2}{n-1}\theta^2 - \theta)Y^2] - (n-1)\lambda w^{\theta} \\ &\leq \int_{\Gamma} -\frac{X^2}{n-1}w^{-\theta} - (n-1)\lambda w^{-\theta} \\ &= \int_{\Gamma} -\frac{A'(v_0)}{n-1}w^{2\alpha-3\theta} - (n-1)\lambda w^{-\theta}, \end{split}$$

where we used the fact that $\alpha = \frac{2\theta}{n-1}$, and $0 \le \theta \le \frac{n-1}{n-2}$. On the one hand, since $\alpha \le \theta$, $w \geq 1$. Hence we have

$$\left(\int_{\Gamma} w^{\alpha-\theta}\right)^2 \cdot A''(v_0) \le -\left(\frac{A'^2(v_0)}{n-1} + (n-1)\lambda\right) \int_{\Gamma} w^{2\alpha-3\theta}.$$

On the other hand, because $A(v_0) \int_{\Gamma} w^{\theta}$, we can conclude that

$$\left(\int_{\Gamma} w^{\alpha-\theta}\right)^2 \le A(v_0) \int_{\Gamma} w^{2\alpha-3\theta}.$$

Putting them together, we have

(6)
$$A'(v_0)A''(v_0) \le -\frac{A'^2(v_0)}{n-1} - (n-1)\lambda.$$

Therefore A(v) is an upper barrier of I(v) which satisfies the inequality (6).

We consider a power of I and A to simplify the corresponding differential inequality. Let $\mathcal{F}(v) = I(v)^{\frac{n}{n-1}}$, combined with above lemma 18, we have the following result.

Proposition 19. For any $v_0 \in (0, V)$, there is a smooth function $U : (v_0 - \sigma, v_0 + \sigma) \longrightarrow$ \mathbb{R} satisfying

- $U(v_0) = \mathcal{F}(v_0),$
- $U(v) \ge \mathcal{F}(v)$ for all $v \in (v_0 \sigma, v_0 + \sigma)$, $U''(v_0) \le -\lambda n U''(v_0)^{\frac{n}{n-1}}$.

Proof. We take $U(v) = A(v)^{\frac{n}{n-1}}$ as in 18, and compute that

$$U'(v) = \frac{n}{n-1} A(v)^{\frac{1}{n-1}} A'(v)$$

and

$$U''(v) = \frac{n}{(n-1)(n-1)} A^{\frac{2-n}{n-1}}(v) A'^{2}(v) + \frac{n}{n-1} A^{\frac{1}{n-1}}(v) A''(v)$$
$$= \frac{n}{n-1} A^{\frac{2-n}{n-1}}(v) (A'(v) A''(v) - (n-1)\lambda) + \frac{n}{n-1} A^{\frac{1}{n-1}}(v) A''(v)$$
$$= -\lambda n U^{\frac{2-n}{n}}.$$

4.1.5. Volume bound. In this section, we will estimate the volume of manifold in the spectral sense. First, We begin by establishing an asymptotic volume expansion estimate for a small geodesic ball centered at a boundary point.

Lemma 20. Suppose that M^n is a complete, connected compact manifold with weakly convex boundary, $w \in C^{\infty}(M)$ is positive. Assume $x \in \partial M$ satisfies $w(x) = \inf(w) = 1$. Then, if I is defined as in (4), we have

(7)
$$\limsup_{v \to 0} v^{-\frac{n-1}{n}} I(v) \le n \operatorname{Vol}(\mathbb{B}^n_+)^{\frac{1}{n}},$$

where \mathbb{B}^n_+ is the unit half ball in \mathbb{R}^n .

Proof. For a small r_0 , the functions $V(r) = \int_{B(x,r)} w^{\alpha}$ and $A(r) = \int_{\partial B(x,r)} w^{\theta}$ are smooth and increasing in $(0, r_0)$, where the geodesic ball of radius r is centered at $x \in \partial M$. We have the asymptotics

$$V(r) = \operatorname{Vol}(\mathbb{B}^n_+)r^n + O(r^{n+1}),$$

and

$$A(r) = n \operatorname{Vol}(\mathbb{B}^n_+) r^{n-1} + O(r^n),$$

hence the function $A \circ V^{-1}(v) = n \operatorname{Vol}(\mathbb{B}^n_+)^{\frac{1}{n}} v^{\frac{n-1}{n}} + o(v^{\frac{n-1}{n}})$, and $I(v) \le A \circ V^{-1}(v)$. \Box

Theorem 21. Let $V \in (0, \infty)$, and let $I : [0, V) \to \mathbb{R}$ be a continuous function such that I(0) = 0, and I(v) > 0 for every $v \in (0, V)$. Assume that for some $\lambda > 0$ we have

$$I''I \le -\frac{(I')^2}{n-1} - (n-1)\lambda,$$

and

$$\lim \sup_{\upsilon \to 0^+} \upsilon^{-\frac{n-1}{n}} I(\upsilon) \le n \operatorname{Vol}(\mathbb{B}^n_+)^{\frac{1}{n}}.$$

Then we have $V \leq \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n_+)$, where \mathbb{S}^n_+ denotes the unit half sphere in \mathbb{R}^{n+1} .

Proof. According to Lemma 18 and Proposition 19, we know that if we set $\mathcal{F}(v) = I(v)^{\frac{n}{n-1}}$, then $\mathcal{F}(v)$ satisfies a differential inequality in the barrier sense:

$$\mathcal{F}''(v) \leq -\lambda n \mathcal{F}^{\frac{n-2}{n}}(v).$$

We first study solutions to the ODE

(8)
$$f''(v) = -\lambda n f^{\frac{2-n}{n}}.$$

Since $-\lambda n f^{\frac{2-n}{n}}$ is increasing in f, it follows from a standard ODE comparison theorem that there no solution to (8) can touch $\mathcal{F}(v)$ from below unless they are equal. If f satisfies (8), then we obtain

$$(f'^2 + \lambda n^2 f^{\frac{2}{n}})' = 0.$$

For z > 0, let $f_z(v)$ be the solution to 8 satisfying f'(0) = 0 and $f(0) = z^{\frac{n}{n-1}}$. Then we have

(9)
$$f'_{z}(v)^{2} = \lambda n^{2} z^{\frac{2}{n-1}} - \lambda n^{2} f_{z}(v)^{\frac{2}{n}}.$$

Let $\beta(z) > 0$ be the maximal real number so that $f_z(\upsilon) > 0$ on $(-\beta(z), \beta(z))$. We see by (9) that

$$f'_{z}(v) = -\sqrt{\lambda n^{2} z^{\frac{2}{n-1}} - \lambda n^{2} f_{z}(v)^{\frac{2}{n}}} \text{ for } v > 0.$$

Therefore, we can integrate the derivative of the inverse of f_z to find

$$\begin{split} \beta(z) &= -\int_{0}^{z^{\frac{n}{n-1}}} (f_{z}^{-1})'(x) dx \\ &= \int_{0}^{z^{\frac{n}{n-1}}} \frac{1}{\sqrt{\lambda}} \frac{1}{n} (z^{\frac{2}{n-1}} - x^{\frac{2}{n}})^{-\frac{1}{2}} dx \\ &= \int_{0}^{\frac{\pi}{2}} \frac{1}{\sqrt{\lambda}} z \sin^{n-1} r dr \\ &= \frac{z}{2\sqrt{\lambda}} \frac{\sqrt{\pi} \Gamma(\frac{n}{2})}{\Gamma(\frac{n+1}{2})} \\ &= \frac{z}{2\sqrt{\lambda}} \frac{\operatorname{Vol}(\mathbb{S}^{n})}{\operatorname{Vol}(\mathbb{S}^{n-1})}, \end{split}$$

where we used the substitution $x = z^{\frac{n}{n-1}} \sin^{n-1}(r)$.

Assume for the sake of contradiction that $V_0 = \int_M w^{\alpha} > \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n_+).$

Claim. There is a $\delta > 0$, so that for $z = \xi + \delta$, where $\xi = \lambda^{-\frac{n-1}{2}} \operatorname{Vol}(\mathbb{S}^{n-1}_+)$ we have (10) $\mathcal{F}(\upsilon) \ge f_z(\upsilon - \beta(z))$

for all $v \in (0, \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n_+))$.

Proof. Let $\delta > 0$ and $\epsilon > 0$ be sufficiently small such that $2\beta(z) + \epsilon z < V$ for $z \in (0, \xi + \delta)$, which is possible since $V > \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{B}^n_+) = 2\beta(\xi)$. Consider the graph of

$$g_z(v) = f_z(v - \beta(z) - \epsilon z)$$

for $v \in [\epsilon z, 2\beta(z) + \epsilon z]$. Note that

$$g_z(\epsilon z) = g_z(2\beta(z) + \epsilon z) = 0 < \min\{\mathcal{F}(\epsilon z), \mathcal{F}(2\beta(z) + \epsilon z)\}$$

Moreover, g_z converges uniformly to zero as $z \to 0$. Hence, if $g_{z^*}(v^*) > \mathcal{F}(v^*)$ for some z^* and v^* , then there must be some $0 < z \leq z^*$ so that g_z touches \mathcal{F} from below, which contradicts Proposition 19. Therefore, we have $\mathcal{F} \geq g_z$ for every $z \in (0, \xi + \delta)$. We take z to $\xi + \delta$, and conclude the claim since ϵ can be arbitrary small.

We study the asymptotic behavior of \mathcal{F} and $f_{\xi+\delta}(v-(\xi+\delta))$ as $v \to 0$. According to (9), since $f_{\xi+\delta}(-\beta(\xi+\delta)) = 0$, we have

$$f'_{\xi+\delta}(-\beta(\xi+\delta)) = \sqrt{\lambda}n(\lambda^{-\frac{n-1}{2}}\operatorname{Vol}(\mathbb{S}^{n-1}_+))^{\frac{1}{n-1}},$$

Therefore, we have

(11)
$$f_{\xi+\delta}(\upsilon-\beta(\xi+\delta)) = \sqrt{\lambda}n(\lambda^{-\frac{n-1}{2}}\operatorname{Vol}(\mathbb{S}^{n-1}_+)+\delta)^{\frac{1}{n-1}}\upsilon+o(\upsilon), \ as \ \upsilon\to 0.$$

On the other hand, by Lemma 20, if we take x_0 such that $w(x_0) = \min w = 1$, we have the asymptotics

$$V(r) = \operatorname{Vol}(\mathbb{B}^n_+)r^n + O(r^{n+1}),$$

and

$$A(r) = n \operatorname{Vol}(\mathbb{B}^n_+) r^{n-1} + O(r^n),$$

hence $A \circ V^{-1}(v) = n \operatorname{Vol}(\mathbb{B}^n_+)^{\frac{1}{n}} v^{\frac{n-1}{n}} + o(v^{\frac{n-1}{n}})$, and we can obtain

(12)
$$\mathcal{F}(v) \le n^{\frac{n}{n-1}} \operatorname{Vol}(\mathbb{B}^n_+)^{\frac{1}{n-1}} v + o(v)$$

(13) $= n \operatorname{Vol}(\mathbb{S}^{n-1}_+) \upsilon + o(\upsilon)$

However, combing (10), (11) with (12), we conclude that $\sqrt{\lambda}n(\lambda^{-\frac{n-1}{2}}\operatorname{Vol}(\mathbb{S}^{n-1}_+) + \delta)^{\frac{1}{n-1}} \leq n\operatorname{Vol}(\mathbb{S}^{n-1}_+)$, which is a contradiction. Therefore, since we normalized so that min w = 1, we have

$$\operatorname{Vol}(M) \le \int_M w^{\alpha} = V_0 \le \lambda^{-\frac{n}{2}} \operatorname{Vol}(\mathbb{S}^n_+).$$

4.2. for case $n \geq 8$.

Remark 22. Because the minimizer E may have singularity for $n \ge 8$ as mentioned in Theorem 12, the volume estimate for $n \ge 8$ can also be obtained by modifying above argument, we refer readers to [1, Appendix A] for details.

4.3. **Rigidity result.** Finally, because M has weakly convex boundary, we can also establish a rigidity result following the method in [1]. We can assume that $\lambda = 1$ after rescaling.

Theorem 23. Let M^n , $n \ge 3$, be a compact connected manifold with weakly convex boundary ∂M , and let $0 \le \theta \le \frac{n-1}{n-2}$. Assume that there exist a positive function $w \in C^{\infty}(M)$ satisfies:

$$\begin{cases} -\theta \Delta w + \operatorname{Ric} w \ge (n-1)w, \\ \frac{\partial w}{\partial n} = 0. \end{cases}$$

If $\operatorname{Vol}(M) = \operatorname{Vol}(\mathbb{S}^n_+)$, then w must be constant, and M is isometric to the unit round hemisphere \mathbb{S}^n_+ .
