Analysis of triply charmed four-quark state in the effective Lagrangian approach

In the work we study the production and decay of triply charmed four-quark state with $J^P = 1^+$ under the phenomenological analysis and effective Lagrangian approach. On the SU(3) symmetric analysis of golden channels, we further explore the dynamics of the processes, based on the assumption of molecule $T_{\eta_c D^*}$ and $T_{J/\psi D^*}$. Our results indicate that the production branching ratio from B_c meson is sizable, it can reach the order of 10^{-4} for the molecular configuration $T_{\eta_c D^*}$, and 10^{-5} for molecule $T_{\eta_c D^*}$. In addition, we found that the decay widths of the two molecular configurations $T_{\eta_c D^*}$ and $T_{J/\psi D^*}$ are not significant, both at level of $\mathcal{O}(\text{MeV})$.

I. INTRODUCTION

Since LHCb Collaboration found the strange-charm four-quark state candidate $X_{0,(1)}(2900)$ and $T_{c\bar{s}}^{0(++)}(2900)$ [1–4], the open-charmed four-quark states have received increasing attention [5– 19]. Subsequently, a doubly charmed four-quark state candidate $T_{cc}^+(3875)$ with the mass near (D^+D^0) threshold [20, 21] was reported in 2021. Those indicate that the heaviest open-charmed four-quark state with triply charmed flavor should be possible. Although there is not yet sufficient experimental evidence for the existence, it has been many preliminary theoretical research to explore the properties of the exotic state at present [22–30]. Especially the mass spectrum of triply charmed four-quark states, Reference [27] employed a quark-based model in conjunction with the Gaussian Expansion Method (GEM) and the Complex Scaling Method (CSM) to identify a triply heavy tetraquark state within the energy range of 5.6-5.9 GeV. In Ref.[25], the authors estimated the mass of the $ccc\bar{c}\bar{q}$ tetraquark state with quantum numbers $J^P = 1^+$ to be 5.1 ± 0.2 GeV using the operator product expansion(OPE). Nevertheless, there are several studies believed that it can not form bound states for the triply-charmed four-quark system, such as studies by the relativized quark model [28], MIT bag model [23] and effective field approach [30]. Therefore, it remains an open issue which should be further validated through future experiments.

We force on the production and decay properties of the triply charmed four-quark state in the work, in the phenomenological analysis and effective Lagrangian approach. The SU(3) flavor symmetric analysis [31–38] and effective Lagrangian approach [39–43] which have been successfully applied into heavy meson and baryon system, accordingly can be used to investigate the triply

charmed four-quark state. With the assumption of molecular state, then the discussion of dynamics is possible. The hypothesis of hadronic molecule is popular, such as four-quark candidate $\psi(4040)$ is considered as D^*D^* hadronic molecule [44, 45]. As well as Y(4220), $Z_c(3900)$ and X(3872)states are interpreted as \bar{D}_1D , \bar{D}^*D and \bar{D}^*D molecular states in Ref. [46]. Consistently, we adopt the generic schemes for the molecule with $J^P = 1^+$, pseudoscalar-vector PV and vectorvector VV configurations. The work is proceed as the usual process for the effective Lagrangian approach. We firstly establish a gauge invariant phenomenological Lagrangian to describe the interactions between molecular states and their components, whose associated coupling constants can be determined by the bare compositeness condition. A direct calculation depending on the Lagrangian at the hadronic level can then be carried out.

The paper is organized as follows. In Sec. II, we concisely analyze properties of the triply charmed four-quark states under the molecular configuration $J/\psi D^*$ and $\eta_c D^*$, including the production and decay processes. The numerical results and discussions are presented in Sec. III. The final section provides a summary of the work.

II. THE TRIPLY CHARMED FOUR-QUARK STATE

According to the Pauli exclusion principle, the triply charmed four-quark state $T_{ccc\bar{q}}$ can be illuminated under the flavor \otimes color \otimes spin space. $T_{ccc\bar{q}}$ has a couple of symmetric diquarks in color subspace $|[cc]_{\bar{\mathbf{3}}}[\bar{c}\bar{q}]_{\mathbf{3}}\rangle_{color}$ and flavor-(3, $\bar{\mathbf{3}}$) diquarks in flavor subspace $|\{cc\}_{\mathbf{1}}[\bar{c}\bar{q}]_{\mathbf{3}}\rangle_{flavor}$, then the S-wave $T_{ccc\bar{q}}$ can only be spin-1 with spin-parity $J^P = 1^+$,

here the {} and [] indicate the symmetry and antisymmetry of the diquark in different spaces respectively. According to configuration of S-wave triply charmed four-quark state, the possible molecular state can be vector-vector configurations $VV(T_{J/\psi D^*})$ and vector-pseudoscalar configurations $PV(T_{\eta_c D^*})$. The effective Lagrangian describing the couplings between the molecular state and its constituents [47],

Among them, the Fourier transform of the correlation function [36, 48]

The coupling constants can be further obtained by the renormalization of mass operator, which can be described by the self-energy diagram in Fig. 1.A,

According to the Weinberg compositeness condition [49],

We determine the expressions of coupling constants $g_{T_{\eta_c D^*}}$ and $g_{T_{J/\psi D^*}}$, written in the Appendix A.

A. phenomenological analysis

In this part, we first employ a phenomenological analysis to investigate the production and decay of the triply four-quark molecular states. A convenient phenomenological tool is the SU(3) flavor symmetric analysis. In the flavor space, the triply charmed four-quark state can be represented with $T_{ccc\bar{cq}} = \left(T^0_{ccc\bar{cu}}, T^+_{ccc\bar{cd}}, T^+_{ccc\bar{cs}}\right)$. The production from B_c meson must be induced by weak transition $\bar{b} \to c\bar{cs}/d$. Within the framework of SU(3) flavor analysis, the Hamiltonian can be written directly,

here, V stands for the vector meson, coefficient a_1 parameterizes the non-perturbative effect, and $(H_3)^i$ represents the weak transition. Expanding Hamiltonian, we then achieve all possible production processes listed into Tab. V in Appendix A. Considering the CKM elements and the detection efficiency, we select three golden channels,

Without the effect of phase space, the relations between different channels can be easily reduced,

It should be noted that $T_{cc\bar{c}\bar{q}}$ can be molecule $T_{J/\psi D^*}$ and $T_{\eta_c D^*}$ for the production processes. However, in the strong decay of triply charmed four-quark state, $T_{cc\bar{c}\bar{q}}$ may be different between the two possible molecular configurations as effect of phase space. Therefore we write the Hamiltonian of two-body and three-body decays respectively,

where P denotes pseudoscalar meson. Accordingly we derive the decay processes shown in Tab. VI, as well as the decay relations between different channels in Tab. I.

B. The effective Lagrangian approach

1. Production of four-quark molecular states from B_c meson

Based on the discussion from SU(3) symmetric analysis, we further investigate the dynamics of molecular states $T_{J/\psi D^*}$ and $T_{\eta_c D^*}$ by the effective Lagrangian approach. The production processes of molecular states $T_{J/\psi D^*}$ and $T_{\eta_c D^*}$ can be pictured as triangle diagram drawn in Fig. 1.D, the expression can be written as,

here, $\langle M_1 M_2 | \mathcal{H}_{eff} | B_c \rangle$ is the weak decay matrix element, $M_1 M_2$ are the possible final states of B_c weak decay and H_{eff} is the possible weak decay Hamiltonian. In our process, W-emission diagrams shown in Fig. 1.(A,B) are dominant for the weak decay. The matrix $\langle K^* T_{J/\psi(/\eta_c)D^*} | \mathcal{H}_{\lambda} | M_1 M_2 \rangle$ indicates strong coupling process and H_{λ} is the possible strong interaction Hamiltonian. We show the weak decay Hamiltonian as,

where, G_F and $C_{1,2}(\mu)$ are the Fermi constant and Wilson coefficient respectively. The amplitude of weak decay can be further expressed as the product of Wilson coefficient, non perturbative form factor and decay constant,

 $a_{1,2}$ are the effective Wilson coefficients, with $a_1 = C_1 + C_2/N_c$, $a_2 = C_2 + C_1/N_c$. N_c denotes the total number of color. The form factors are defined as [50]

Here ε_{μ} denotes the polarization vector of J/ψ , transition momentum $k_{2\mu} \equiv (p_{B_c} - p_{J/\psi})_{\mu}$. The matrix elements between meson $D^{(*)}$ and vacuum are defined as [51]

where $f_{D^{(*)}}$ is the decay constant of $D^{(*)}$ meson, ε_{μ} represents the polarization vector of D^* meson.

To deal with the strong coupling matrix, we introduce the strong interaction effective Lagrangian [52],

where V_i and P_i denote vector and pseudoscalar meson respectively. Using the effective Lagrangian and form factors, the amplitudes of $B_c \to K^* T_{J/\psi(/\eta_c)D^*}$ in Fig. 1(D) are given as follows,

In addition, to remove the ultraviolet divergence of amplitudes, we introduce form factor $\mathcal{F}_2(k_3^2)$ [53]

where m_{D^*} and k_3 denote the mass and momentum of the exchanged meson D^* in the triangle diagrams. The cutoff parameter $\Lambda_{D^*} = m_{D^*} + \alpha_m$ (with $\alpha_m \approx 0.4$)[46] is used to suppress the contribution of hadrons at short distances.

2. Decay of four-quark molecular states $J^P = 1^+$

Using the effective Lagrangian approach, the decay processes of triply charmed four-quark states can be easily deduced, their diagram are shown in Fig. 2. In addition to the ordinary two-body decays, we also study the possible three-body decays, whose diagrams are shown in Fig. 2(c'-f'). In the work, we discuss the contribution of three-body decays under one-loop level. The decay amplitudes \mathcal{M}' of the four-quark molecular states $T_{J/\psi D^*}$ and $T_{\eta_c D^*}$ are given as follows,

the momentum definitions are drawn in Fig. 2, the momentum $p_{23} = p_2 + p_3$ and k_3 is the momentum of exchanged particle. The partial decay width for the three-body process $T_{J/\psi(/\eta_c)D^*} \rightarrow J/\psi(/\eta_c)D\pi$ can be expressed as [54]:

 \mathcal{M}' denotes the decay amplitudes, m_{12} and m_{23} represent the invariant masses of final $J/\psi \pi(/\eta_c \pi)$ and $D\pi$ system, respectively.

III. NUMERICAL ANALYSIS AND DISCUSSION

The form factors in Eq. 15 and Eq. 16 can be parameterized on the physical region,

where the fitted parameters $\alpha_{1,2,3}$ can be found in reference [55]. The decay constants, coupling constants and Wilson coefficient a_1 are collected into Tab. II, in which coupling constants $g_{T_{\eta_c D^*}}$ and $g_{T_{J/\psi D^*}}$ between triply charmed four-quark state and their constituent can be obtained by Eq. (6).

In the schemes of molecular states $T_{J/\psi D^*}$ and $T_{\eta_c D^*}$, the production branching ratios from B_c meson are shown in Tab. III, where we take cutoff parameter $\alpha_m = 0.4$ and binding energy $\epsilon = 5, 10, 20$ MeV. Besides, the decay widths are obtained in Tab. IV, in which the results not provided are mainly forbidden by the effect of phase space. We can make several analyses based on the results above.

• Generally, the production branching ratios under $T_{\eta_c D^*}$ molecular configuration are larger than those with molecule $T_{J/\psi D^*}$. Specifically, the branching ratios of two Cabibbo-allowed processes $B_c^+ \to \overline{K}^{*0} T_{J/\psi D^*}^+$ and $B_c^+ \to K^{*+} T_{J/\psi D^*}^0$, can reach the order of 10^{-4} .

• We define two ratios R_1 and R_2 for the production processes,

which are different from SU(3) symmetric prediction $R_{1,2} = |V_{cs}|^2 / |V_{cd}|^2 \approx 19.9$ in Eq. (9). These indicate that the two processes encounter significant SU(3) flavor breaking effect.

- It should be noted that the leading order contribution of some three-body processes comes from one-loop hadronic diagrams, such as processes $T^+_{J/\psi D^*} \rightarrow D^+ \eta_c \pi^0$ and $T^+_{J/\psi D^*} \rightarrow D^0 \eta_c \pi^+$, the calculations begin with triangle diagram as Fig. 2.c'.
- Summing up all possible two-body and three-body processes, we derive total decay width of the triply charmed four-quark state,

here the cutoff parameter $\alpha = 0.25$ GeV, and the binding energy $\epsilon = 5$ MeV.

IV. CONCLUSIONS

In the article, we discuss the production of four-quark molecular states $T_{J/\psi D^*}$ and $T_{\eta_c D^*}$ through B_c meson decays, as well as their two-body and three-body decays. Starting from SU(3) symmetric phenomenological analysis, we primarily choose several golden channels for the production and decay of these four-quark molecular states. Immediately after using the effective

Lagrangian approach, the exhaustive decay widths and production branching ratios are shown up, based on the effective Lagrangian approach. The branching ratio increases with the cutoff parameter α and binding energy ϵ , which can reach the order of 10^{-4} for the molecular configuration $T_{\eta_c D^*}$. Besides, it shows that the decay widths are not significant, which both at order of MeV regarding to strong decay of the two molecular configurations $T_{\eta_c D^*}$ and $T_{J/\psi D^*}$.
