Sharp multipolar L^p -Hardy-type inequalities on Riemannian manifolds

Emails: cristiciulica@yahoo.com, teorugina@yahoo.com Keywords: sharp Hardy Inequality; p-Laplacian; multipolar singular potential; Riemannian manifold; curvature. 2020 Mathematics Subject Classification: 35A23, 35B25, 53C21, 58J60. **Abstract** In this paper we prove sharp multipolar Hardy-type inequalities in the Riemannian L^p-setting for $p \ge 2$ using the method of super-solutions and fundamental results from comparison theory on manifolds, thus generalizing the work in [12], [14] for p = 2. We emphasize that when we restrict to Cartan-Hadamard manifolds, the inequalities improve in the case 2 compared to the case <math>p = 2 since we obtain positive remainder terms which are controlled by curvature estimates. In the end, we treat the cases of positive and negative constant sectional curvature. Introduction

5 fo prove multipolar Hardy-type inequalities in the setting of Riemannian manifolds and their sharp formulations, which strongly depend on the geometric and topological properties of these manifolds.

The classical Hardy inequality in Euclidean space \mathbb{R}^N , $N \ge 3$, states that for any $u \in C_c^{\infty}(\mathbb{R}^N)$:

$$\int_{\mathbb{R}^N} |\nabla u|^p \, dx \ge \left(\frac{N-p}{p}\right)^p \int_{\mathbb{R}^N} \frac{|u|^p}{|x|^p} dx,\tag{1.1}$$

where $1 and the constant in the right-hand-side is sharp and not attained in the space <math>C_c^{\infty}(\mathbb{R}^N)$. Moreover, no positive remainder terms can be added in the inequality (1.1). Hardy first proved in a discrete form in [19], while continuous analogues and improvements were developed later in [20]. This inequality is classified in the literature as a unipolar inequality due to the singularity of $\frac{1}{|x|^p}$ in x = 0. Unipolar inequalities in \mathbb{R}^N and various Hardy-type inequalities were intensively studied in the last decades in works such as [4], [8], [13], [27], [29]. In the context of Riemannian manifolds, the inequality (1.1) is generalized using the Riemannian distance function to a point in the pioneering paper [10]. Later, the subject of Hardy inequalities on Riemannian manifolds and its different forms got a lot of attention, see for example the papers: [14], [23], [24], [25] for functional inequalities and uncertainty priciples in general setting of Riemannian manifolds; [5] and [17] for results on Cartan-Hadamard

manifolds; [6] and [16] for inequalities in the hyperbolic space; [22] for a new technique to prove Hardy-type and many functional inequalities using the so-called Ricatti pairs, a generalisation of the concept of Bessel pairs introduced in [18].

It is important to mention that when we pass from the flat case of \mathbb{R}^N to Riemannian manifolds, the presence of curvature generates additional restrictions for the validity of such inequalities, as it is explained in [10]. Another effect of the curvature is that it can either strengthen or weaken the inequality, through the estimation of its terms. Thus, we may find, for example, that we obtain improved inequalities when the manifold is strongly negatively curved. We shall explore these aspects in the next sections.

Multipolar Hardy inequalities involve a singular potential defined by a locally integrable function with multiple singular points. Such inequalities were studied in the last years in [1], [7], [9], [12], [15], [21] and references within. It is worth highlighting here the work in [7] where this type of inequalities were obtained by the method of expansion of the square. Those results were improved later in [12], using the method of super-solutions to derive inequalities involving multipolar potentials of the form $W := \sum_{1 \le i < j \le n} \frac{|a_i - a_j|^2}{|x - a_i|^2 |x - a_j|^2}$, where $n \ge 2$ and $a_1, ..., a_n$ are isolated points in \mathbb{R}^N , $N \ge 3$. Their result states that for any $u \in C_c^{\infty}(\mathbb{R}^N)$:

$$\int_{\mathbb{R}^{N}} |\nabla u|^{2} dx \ge \frac{(N-2)^{2}}{n^{2}} \sum_{1 \le i < j \le n} \int_{\mathbb{R}^{N}} \frac{\left|a_{i} - a_{j}\right|^{2}}{\left|x - a_{i}\right|^{2} \left|x - a_{j}\right|^{2}} |u|^{2} dx.$$
(1.2)

Moreover, they proved that the inequality is sharp, meaning that the constant $\frac{(N-2)^2}{n^2}$ cannot be improved. This result was later generalized in two directions, which we shall explore briefly in the following lines. The first direction is the generalization to the L^p -setting of (1.2) in [11] for the bipolar case (i.e. for two singular points) where the authors proved that for any $N \ge 3$ and $u \in C_c^{\infty}(\mathbb{R}^N)$:

$$\begin{split} \int_{\mathbb{R}^{N}} |\nabla u|^{p} \, dx &\geq \frac{p-1}{4} \left(\frac{N-p}{p-1} \right)^{p} \int_{\mathbb{R}^{N}} \frac{|a_{1}-a_{2}|^{2}|x-a|^{p-2}}{|x-a_{1}|^{p}|x-a_{2}|^{p}} |u|^{p} \, dx \\ &+ \frac{p-2}{2} \left(\frac{N-p}{p-1} \right)^{p-1} \int_{\mathbb{R}^{N}} \frac{|x-a|^{p-4}}{|x-a_{1}|^{p}|x-a_{2}|^{p}} \Big[|x-a_{1}|^{2}|x-a_{2}|^{2} - \left((x-a_{1}) \cdot (x-a_{2}) \right)^{2} \Big] |u|^{p} \, dx. \end{split}$$
(1.3)

Here *a* stands for the median point of the segment $[a_1, a_2]$, precisely $a = \frac{a_1 + a_2}{2}$. For $2 \le p < N$ it is shown that the constant $\frac{p-1}{4} \left(\frac{N-p}{p-1}\right)^p$ is sharp and not achieved in the energy space $\mathcal{D}^{1,p}(\mathbb{R}^N) = \left\{ u \in \mathcal{D}'(\mathbb{R}^N) \mid \int_{\mathbb{R}^N} |\nabla u|^p \, dx < \infty \right\}$. We notice that, as an improvement to (1.2), inequality (1.3) contains a positive remainder term when p > 2 and a slightly different structure of the singular potential, which has a degeneracy in a in the first integral when p > 2 and in the second integral when p > 4, while for $p \in (2, 4)$ we have an extra singularity in a in the second integral. The second generalization of (1.2) is its extension to Riemannian manifolds, where the curvature plays a significant role. In order to state the result in this curved setting, fix $N \ge 3$, (M, g) a complete Riemannian manifold of dimension N, a set of points $\{a_1, ..., a_n\} \in M$, $n \ge 2$ and the distance functions $d(x, a_i) =: d_i(x)$, for any i = 1, ..., n. We denote by Δ_g the Laplace-Beltrami operator on M, by ∇_g the gradient operator, and by dv_g the canonical volume form on *M*. The authors in [14] proved that for any $u \in C_c^{\infty}(M)$:

$$\int_{M} \left| \nabla_{g} u \right|^{2} dv_{g} \geq \frac{(N-2)^{2}}{n^{2}} \sum_{1 \leq i < j \leq n} \int_{M} \left| \frac{\nabla_{g} d_{i}}{d_{i}} - \frac{\nabla_{g} d_{j}}{d_{j}} \right|^{2} \left| u \right|^{2} dv_{g} + \frac{N-2}{n} \sum_{i=1}^{n} \int_{M} \frac{d_{i} \Delta_{g} d_{i} - (N-1)}{d_{i}^{2}} \left| u \right|^{2} dv_{g}, \quad (1.4)$$

where the constant $\frac{(N-2)^2}{n^2}$ is sharp for n = 2. It is interesting to remark that they also obtain a remainder term which depends on the curvature, as opposed to (1.2). This is due to the presence of $\Delta_g d_i$. This remainder is shown to be

positive when M is a Cartan-Hadamard manifold. Properties of Cartan-Hadamard manifolds, which shall be useful in our analysis, will be summarised in Section 2.

Our aim is to find a generalization of (1.3) to the context of Riemannian manifolds, in the spirit of the generalisation from (1.2) to (1.4). We start in Section 2 by presenting some preliminaries on Riemannian geometry, listing some basic properties and two well-known comparison theorems. In Section 3 we state the main results, while Section 4 will be dedicated to the proofs. We will begin by identifying the structure of singularities when we pass from p = 2 to any p with $1 by employing an adaptation of the technique in [3] to Riemannian manifolds. Then we continue by analyzing the sharp constants and proposing minimizing sequences in the resulting inequalities, while also finding suitable conditions which guarantee the positivity of the remainder terms. In Section 5 we explore these inequalities in the constant curvature setting of the hyperbolic space <math>\mathbb{H}^N$ and the upper-hemisphere \mathbb{S}^N_+ .

2 Preliminaries

In this section, we recall some well-known concepts and definitions of differential operators on Riemannian manifolds. We also introduce the sectional curvature and the comparison theorems which are fundamental for the proof of the main results. For a more comprehensive understanding, one can check the books [26] or [28].

Definition 2.1. Let M be a N-differentiable manifold, $N \ge 3$. A Riemannian metric on M is a 2-tensor field g that is symmetric and positive definite.

Thus, a Riemannian metric determines an inner product on the tangent space $T_x M$, for any $x \in M$. Let $TM = \bigcup_{x \in M} T_x M$ be the tangent bundle of M and X(M) be the set of $C^{\infty}(M)$ vector fields on M (i.e. sections in the tangent bundle TM). We denote the norm of a tangent vector $X_x \in T_x M$ by $|X_x| := g(X_x, X_x)^{\frac{1}{2}}$. If (U, φ) is a chart on M, with (x_i) local coordinates, we denote by $g_{ij} = g\left(\frac{\partial}{\partial x_i}, \frac{\partial}{\partial x_j}\right)$ the local coefficients of g in U. Recall that the distance function associated to the Riemannian metric g is defined as a function $d : M \times M \to [0, \infty)$ given by

$$d(x, y) = \inf_{\gamma} \left\{ \text{lenght}(\gamma) \mid \gamma : [a, b] \to M, \text{ piecewise differentiable, } \gamma(a) = x, \ \gamma(b) = y \right\}.$$

For $a \in M$ and r > 0, we denote by $B_r(a) := \{x \in M | d(x, a) < r\}$ the ball of radius r and centered in a. Moreover, for 0 < r < R, let $A_a[r, R] := \{x \in M || r \le d(x, a) \le R\}$. Let $u : M \to \mathbb{R}$ be a function of class C^1 and du the differential of u. The gradient of u is the vector field $\nabla_g u$

Let $u: M \to \mathbb{R}$ be a function of class C^1 and du the differential of u. The gradient of u is the vector field $\nabla_g u$ defined by

$$g(\nabla_g u, X) = df(X), \ \forall X \in \mathcal{X}(M).$$
(2.2)

If the local components of the differential of *u* are denoted by $u_i = \frac{\partial u}{\partial x_i}$, then the local components of the gradient of *u* are $(\nabla_g u)^i = g^{ij}u_j$, where g^{ij} are the local coefficients of $g^{-1} = (g_{ij})^{-1}$. We recall the well known Eikonal equation: for every $x \in M$, one has

$$|\nabla_g d(x, \cdot)| = 1 \text{ a.e. on } M. \tag{2.3}$$

Denote by ∇ the Levi-Civita connection of g. We only use ∇_g (with g as an index) for the gradient, so there is no danger of confusion with the Levi-Civita connection.

The divergence of a vector field $X \in \mathcal{X}(M)$ with respect to the Riemannian metric g is defined as

$$\operatorname{div}(X) = \operatorname{tr}\left(\xi \to \nabla_{\xi} X\right), \quad \xi \in \mathcal{X}(M).$$
(2.4)

More precisely, for $X = X^i \frac{\partial}{\partial x_i} \in \mathcal{X}(M)$, the expression of div(X) in local coordinates is given by the formula

$$\operatorname{div}\left(X^{i}\frac{\partial}{\partial x_{i}}\right) = \frac{1}{\sqrt{\det g}}\frac{\partial}{\partial x_{i}}\left(X^{i}\sqrt{\det g}\right).$$
(2.5)

For later use, let us recall the next identity: for any $f \in C^{\infty}(M)$ and vector fields $X, Y \in \mathcal{X}(M)$

$$\operatorname{div}(fX) = g(\nabla_g f, X) + f\operatorname{div}(X). \tag{2.6}$$

The Hessian operator Hess u is defined as the symmetric 2-tensor

$$\operatorname{Hess}^{u}(X,Y) = g(\nabla_{X}\nabla_{g}u,Y), \ \forall X,Y \in TM.$$

$$(2.7)$$

The Laplace-Beltrami operator of u is defined as $\Delta u = \operatorname{div}(\nabla_{g} u)$, which in local coordinates is expressed as

$$\Delta_g u = \frac{1}{\sqrt{\det g}} \frac{\partial}{\partial x_i} \left(g^{ij} \sqrt{\det g} \frac{\partial u}{\partial x_j} \right).$$
(2.8)

We define the *p*-Laplacian operator for $p \in (1, \infty)$ as $\Delta_p u = \operatorname{div} \left(\left| \nabla_g u \right|^{p-2} \nabla_g u \right)$.

Since our results will depend on the sectional curvature of M, we need to recall the definition of curvature of a connection ∇ , by introducing the (1, 3)-tensor $\mathcal{R} : \mathcal{X}(M) \times \mathcal{X}(M) \times \mathcal{X}(M) \to \mathcal{X}(M)$, given by

$$\mathcal{R}(X,Y)Z = \nabla_X \nabla_Y Z - \nabla_Y \nabla_X Z - \nabla_{[X,Y]} Z, \text{ for any } X,Y,Z \in \mathcal{X}(M).$$

The well-known Riemann curvature tensor is defined as $R: \mathcal{X}(M) \times \mathcal{X}(M) \times \mathcal{X}(M) \to C^{\infty}(M)$,

$$R(X, Y, Z, W) = g(\mathcal{R}(Z, W)Y, X), \text{ for any } X, Y, Z, W \in \mathcal{X}(M).$$

Let $x \in M$, $\pi \subset T_x M$ a 2-dimensional vector subspace and $\{E_1, E_2\} \subset \pi$ an orthonormal basis. The sectional curvature of π is

$$K_{\pi} = K_{\pi}(E_1, E_2) = R(E_1, E_2, E_1, E_2).$$

We say that M has non-positive (or non-negative sectional) curvature if

$$K_{\pi} \le 0 \quad (\text{ or } K_{\pi} \ge 0), \quad \text{for any } \pi \subset T_{x}M.$$
 (2.9)

Our main tools in dealing with the extra-terms which we obtain in the Hardy inequalities will be some comparison theorems for the Laplacian and Hessian operators. For this, we first introduce a useful function. We follow the reference [26]. For any $c \in \mathbb{R}$, define the function $s_c : [0, \infty) \to \mathbb{R}$ by

$$s_{c}(r) = \begin{cases} r, & \text{if } c = 0\\ \frac{1}{\sqrt{c}} \sin(r\sqrt{c}), & \text{if } c > 0\\ \frac{1}{\sqrt{-c}} \sinh(r\sqrt{-c}), & \text{if } c < 0 \end{cases}$$
(2.10)

It is easy to see that

$$\frac{s'_{c}(r)}{s_{c}(r)} = \begin{cases} \frac{1}{r}, & \text{if } c = 0\\ \sqrt{c} \cot(r\sqrt{c}), & \text{if } c > 0\\ \sqrt{-c} \coth(r\sqrt{-c}), & \text{if } c < 0 \end{cases}$$
(2.11)

Using these notations, we state now two celebrated curvature comparison results.

Theorem 2.2 (Hessian comparison theorem, [26]). Suppose (M,g) is a N-dimensional Riemannian manifold, $x_0 \in M$, U is a neighbourhood of x_0 and d is the distance function on U. If all the sectional curvatures of M are bounded above by a constant c, then the following inequality holds in $U \setminus \{x_0\}$:

$$\operatorname{Hess}^{d} \ge \frac{s_{c}^{\prime}(d)}{s_{c}(d)}\pi_{d}, \qquad (2.12)$$

where for any $q \in U \setminus \{x_0\}, \pi_d : T_q M \to T_q M$ is the orthogonal projection onto the tangent space of the level set of d (or, equivalently, onto the orthogonal complement of $\partial_d|_q$).

Theorem 2.3 (Laplacian comparison theorem, [26]). Suppose (M,g) is a N-dimensional Riemannian manifold, $x_0 \in M$, U is a neighbourhood of x_0 and d is the distance function on U. If all the sectional curvatures of M are bounded above by a constant c, then the following inequality holds in $U \setminus \{x_0\}$:

$$\Delta d \ge (N-1)\frac{s_c'(d)}{s_c(d)},\tag{2.13}$$

where s_c is defined above.

The inequalities above are understood in the distributional sense.

Remark 2.4. 1) Notice that, since π_d is an orthogonal projection, we have:

$$g(\pi_d X, X) = g(\pi_d^2 X, X) = g(\pi_d X, \pi_d X) = |\pi_d X|^2 \ge 0, \text{ for any } X \in \mathcal{X}(M).$$

2) Moreover, we have

$$\pi_d X = X - \frac{g(X, \nabla_g d)}{g(\nabla_g d, \nabla_g d)} \nabla_g d, \text{ for any } X \in \mathcal{X}(M).$$
(2.15)

In order to find sharp estimates in our inequalities, we will address a special class of manifolds, namely Cartan-Hadamard manifolds.

Definition 2.5. *If M is a complete, simply connected Riemannian manifold with non-positive sectional curvature, then it is called a Cartan–Hadamard manifold.*

Remark 2.6. If *M* is a Cartan-Hadamard manifold and *d* is the distance function to $x_0 \in M$, since the sectional curvatures are all bounded from above by $c \leq 0$, then, by Theorems 2.2 and 2.3, we have the following comparison principles:

$$2)d\Delta_g d - (N-1) \ge 0. \tag{2.17}$$

3 Main results

Let *M* be a complete, simply connected Riemannian manifold of dimension $N \ge 3$ with Riemannian metric $g, n \ge 2$ integer, $a_1, ..., a_n$ fixed points in *M*. Denote by

$$d_i = d_i(x) := d(x, a_i)$$

the distance function from the point $x \in M$ to the fixed point a_i , for any i = 1, ..., n. The following notations will be consistently used throughout the paper:

$$v := \sum_{i=1}^{n} \frac{\nabla_g d_i}{d_i} \quad \text{and} \quad G_{ij} := g(\nabla_g d_i, \nabla_g d_j).$$
(3.1)

We introduce the following potential:

$$V_{p,a_1,\dots,a_n} := C_1(n,p) \sum_{1 \le i < j \le n} \left| \frac{\nabla_g d_i}{d_i} - \frac{\nabla_g d_j}{d_j} \right|^2 |v|^{p-2} + C_2(n,p) \left[\sum_{i=1}^n \frac{d_i \Delta_g d_i - (N-p+1)}{d_i^2} |v|^{p-2} - (p-2) \sum_{i,j,k=1}^n \frac{G_{ij}G_{ik}}{d_i^2 d_j d_k} |v|^{p-4} + (p-2) \sum_{\substack{1 \le k \le n, \\ 1 \le i < j \le n}} \frac{\operatorname{Hess}^{d_i}(\nabla_g d_k, \nabla_g d_j) + \operatorname{Hess}^{d_j}(\nabla_g d_k, \nabla_g d_i)}{d_i d_j d_k} |v|^{p-4} \right]$$
(3.2)

where

$$C_1(n,p) = \frac{(N-p)^p}{n^p(p-1)^{p-1}}$$
 and $C_2(n,p) = \frac{(N-p)^{p-1}}{n^{p-1}(p-1)^{p-1}}.$ (3.3)

We denote by

$$\widetilde{V}_{p,a_1,\dots,a_n} := \sum_{1 \le i < j \le n} \left| \frac{\nabla_g d_i}{d_i} - \frac{\nabla_g d_j}{d_j} \right|^2 |v|^{p-2}$$
(3.4)

the leading component of the potential V_{p,a_1,\ldots,a_n} . Asymptotically,

$$\widetilde{V}_{p,a_1,...,a_n} \sim d_i^{-p}$$
 when x is close to a_i , for all $i = 1, ..., n$.

It is clear that in the case p = 2, the potential $\widetilde{V}_{2,a_1,...,a_n}$ coincides with the singular potential from the right hand-side of (1.2) if we restrict it to \mathbb{R}^N , while $V_{2,a_1,...,a_n}$ coincides with the potential from the right hand-side of (1.4). Nevertheless, for any $1 , <math>V_{p,a_1,a_2}$ recovers the bipolar case n = 2 from (1.3) when restricted to \mathbb{R}^N . Our first result is the following multipolar Hardy-type inequality.

Theorem 3.1. Let (M^N, g) be a complete Riemannian manifold of dimension $N \ge 3$ and $a_1, ..., a_n$ points in M, where $n \ge 2$. Then the following inequality holds for any $1 and any <math>u \in C_c^{\infty}(M)$:

$$\int_{M} \left| \nabla_{g} u \right|^{p} dv_{g} \ge \int_{M} V_{p,a_{1},\dots,a_{n}} \left| u \right|^{p} dv_{g}.$$

$$(3.5)$$

It is not certain that V is positive for any number of points a_i and any $1 . This constrains us to consider further the case of only two points <math>a_1$ and a_2 . The next proposition gives us a better expression of the potential from (3.2) in the bipolar case.

Proposition 3.2. Let a_1, a_2 be points in M. Then

$$V_{p,a_{1},a_{2}} = C_{1}(2,p) \left| \frac{\nabla_{g} d_{1}}{d_{1}} - \frac{\nabla_{g} d_{2}}{d_{2}} \right|^{2} |v|^{p-2} + C_{2}(2,p) \left[\sum_{i=1}^{2} \frac{d_{i} \Delta_{g} d_{i} - (N-1)}{d_{i}^{2}} |v|^{p-2} + 2(p-2) \frac{1 - G_{12}^{2}}{d_{1}^{2} d_{2}^{2}} |v|^{p-4} + (p-2) \left(\frac{\operatorname{Hess}^{d_{1}}(\nabla_{g} d_{2}, \nabla_{g} d_{2})}{d_{1} d_{2}^{2}} + \frac{\operatorname{Hess}^{d_{2}}(\nabla_{g} d_{1}, \nabla_{g} d_{1})}{d_{1}^{2} d_{2}} \right) |v|^{p-4} \right]$$
(3.6)

We define the functional space $\mathcal{D}^{1,p}(M)$ as

$$\mathcal{D}^{1,p}(M) := \left\{ u \in \mathcal{D}'(M) \mid \int_{M} \left| \nabla_{g} u \right|^{p} dv_{g} < \infty \right\}.$$
(3.7)

When restricting to the bipolar case in Theorem 3.1, using Proposition 3.2 we obtain the following corollary.

Corollary 3.3. Let (M^N, g) be a complete Riemannian manifold of dimension $N \ge 3$ and a_1, a_2 points in M. Then the following inequality holds for any $1 and any <math>u \in C_c^{\infty}(M)$:

$$\int_{M} \left| \nabla_{g} u \right|^{p} dv_{g} \ge \int_{M} V_{p,a_{1},a_{2}} |u|^{p} dv_{g}.$$
(3.8)

Moreover, if *M* is a Cartan-Hadamard manifold, for any $2 \le p < N$ the right-hand side of (3.8) is positive and the constant 1 is sharp in (3.8). This constant is achieved in the energy space $\mathcal{D}^{1,p}(M)$ by the minimizers

$$\phi(x) = C \ d_1^{\frac{p-N}{2(p-1)}} d_2^{\frac{p-N}{2(p-1)}}, \quad C \in \mathbb{R},$$
(3.9)

unless the case p = 2 when the constant is not achieved.

Notice that Corollary 3.3 gives a dichotomy between the case 2 and <math>p = 2, since in [14] the sharp constant in the inequality is not achieved.

Consequently, we obtain another sharp result for Cartan-Hadamard manifolds.

Corollary 3.4. If M is a N-dimensional Cartan-Hadamard manifold with sectional curvatures bounded above by a negative constant $c = -R^2$, R > 0, then for any $2 \le p < N$ and $u \in C_c^{\infty}(M)$ it holds

$$\begin{split} \int_{M} \left| \nabla_{g} u \right|^{p} dv_{g} &\geq C_{1}(2, p) \int_{M} \widetilde{V}_{p, a_{1}, a_{2}} |u|^{p} dv_{g} + (N - 1)C_{2}(2, p) \sum_{i=1}^{2} \int_{M} \frac{3R^{2}}{\pi^{2} + R^{2}d_{i}^{2}} |v|^{p-2} |u|^{p} dv_{g} \\ &+ (p - 2)C_{2}(2, p) \sum_{i=1}^{2} \int_{M} \frac{1 - G_{12}^{2}}{d_{1}^{2}d_{2}^{2}} \left[2 + \frac{3d_{i}^{2}R^{2}}{\pi^{2} + R^{2}d_{i}^{2}} \right] |v|^{p-4} |u|^{p} dv_{g}. \end{split}$$
(3.10)

In particular,

$$\int_{M} \left| \nabla_{g} u \right|^{p} dv_{g} \ge C_{1}(2, p) \int_{M} \widetilde{V}_{p, a_{1}, a_{2}} |u|^{p} dv_{g}, \tag{3.11}$$

where the constant $C_1(2,p) = (p-1) \left(\frac{N-p}{2(p-1)}\right)^p$ is sharp and not attained in the energy space $\mathcal{D}^{1,p}(M)$.

We note that even though the inequality (3.10) is weaker than (3.8) due to the lower-bound estimates on the remainder terms, it reveals the importance of the curvature bound $c = -R^2$, which enhances the inequality as the curvature becomes more negative.

4 **Proof of Main results**

The proof of Theorem 3.1 relies on an adaptation of the method of supersolutions introduced by Allegretto and Huang in [3] to Riemannian manifolds. The proof follows the same steps as in Theorem 2.1 in [3]. Here is the adapted version in the setting of Riemannian manifolds:

Proposition 4.1. Let $N \ge 3$, $1 . If there exists a function <math>\phi > 0$ in M such that $\phi \in C_c^{\infty}(M \setminus \bigcup_{i=1}^n \{a_i\} \cup cut\{a_i\})$ and

(4.1)

where V > 0, with $V \in L^1_{loc}(M)$, is a given multi-singular potential with the poles a_1, \ldots, a_n and $\mu > 0$, then

$$\int_{M} \left| \nabla_{g} u \right|^{p} dv_{g} \ge \mu \int_{M} V |u|^{p} dv_{g}, \quad \forall u \in C_{c}^{\infty}(M).$$

Proof of Theorem 3.1. We want to find a function $\phi > 0$, a constant μ depending on N, n and p and a potential $V \in L^1_{loc}(M)$, with singularities in the points $a_1, a_2, ..., a_n$, which satisfy the identity

$$-\frac{\Delta_{p,g}\phi}{\phi^{p-1}} = \mu V, \quad a.e. \text{for } x \in M \setminus \{a_1, ..., a_n\}$$

We consider the functions

$$\phi_i = d_i^\beta, \qquad i = 1, ..., n$$

where β is negative, aimed to depend on N, n and p, that will be precised later. We introduce

$$\phi = \prod_{i=1}^{n} \phi_i = \prod_{i=1}^{n} d_i^{\beta}.$$

We compute the *p*-Laplacian of ϕ in (4.2) in several steps. First, we note that

Using the definition of the p-Laplacian operator with respect to the metric g and identity (2.6), we obtain

Hence, we denote

Next, we compute explicitly the three terms in (4.5). Taking the modulus of v, we get

where we are taking into account that, for every i = 1, ..., n, we have $g(\nabla_g d_i, \nabla_g d_i) = |\nabla_g d_i|^2 = 1$, since d_i satisfies the Eikonal equation. The second term in (4.5) yields to

$$= \frac{p-2}{2} |v|^{p-4} \sum_{i,j,k=1}^{n} g\left(-\frac{\nabla_{g}(d_{i}d_{j})G_{ij}}{d_{i}^{2}d_{j}^{2}} + \frac{\nabla_{g}(G_{ij})}{d_{i}d_{j}}, \frac{\nabla_{g}d_{k}}{d_{k}}\right)$$

$$= \frac{p-2}{2} |v|^{p-4} \sum_{i,j,k=1}^{n} \left[-\frac{G_{ij}}{d_{i}^{2}d_{j}^{2}d_{k}}g\left(d_{j}\nabla_{g}d_{i} + d_{i}\nabla_{g}d_{j}, \nabla_{g}d_{k}\right) + \frac{1}{d_{i}d_{j}d_{k}}g\left(\nabla_{g}(G_{ij}), \nabla_{g}d_{k}\right)\right]$$

$$= \frac{p-2}{2} |v|^{p-4} \sum_{i,j,k=1}^{n} \left[-\frac{G_{ij}G_{ik}}{d_{i}^{2}d_{j}d_{k}} - \frac{G_{ij}G_{jk}}{d_{i}d_{j}^{2}d_{k}} + \frac{1}{d_{i}d_{j}d_{k}}g\left(\nabla_{g}(G_{ij}), \nabla_{g}d_{k}\right)\right]$$

$$= -(p-2)|v|^{p-4} \sum_{i,j,k=1}^{n} \frac{G_{ij}G_{ik}}{d_{i}^{2}d_{j}d_{k}} + (p-2)|v|^{p-4} \sum_{\substack{1\leq k\leq n,\\ 1\leq i
(4.8)$$

Note that the last term can be written in the following way, using the definition of the gradient and the Hessian operator

Returning to V in (4.5) and using (4.7), (4.8) and (4.9), the potential reduces to

Choosing $\beta = \frac{p-N}{n(p-1)}$, we obtain

$$\begin{split} V &= \left(\frac{N-p}{n(p-1)}\right)^{p-1} |v|^{p-2} \left[\left(\frac{N-p}{n}\right) \sum_{1 \le i < j \le n} \left| \frac{\nabla_g d_i}{d_i} - \frac{\nabla_g d_j}{d_j} \right|^2 + \sum_{i=1}^n \frac{p-N}{d_i^2} + \sum_{i=1}^n \frac{d_i \Delta_g d_i - 1}{d_i^2} \right] \\ &+ (p-2) \left(\frac{N-p}{n(p-1)}\right)^{p-1} |v|^{p-4} \left[-\sum_{i,j,k=1}^n \frac{G_{ij}G_{ik}}{d_i^2 d_j d_k} + \sum_{\substack{1 \le k \le n, \\ 1 \le i < j \le n}} \frac{\text{Hess}^{d_i} (\nabla_g d_k, \nabla_g d_j) + \text{Hess}^{d_j} (\nabla_g d_k, \nabla_g d_i)}{d_i d_j d_k} \right]. \end{split}$$

The final form of V is the following

$$V = (p-1)\left(\frac{N-p}{n(p-1)}\right)^{p} \sum_{1 \le i < j \le n} \left|\frac{\nabla_{g}d_{i}}{d_{i}} - \frac{\nabla_{g}d_{j}}{d_{j}}\right|^{2} |v|^{p-2} + \left(\frac{N-p}{n(p-1)}\right)^{p-1} \sum_{i=1}^{n} \frac{d_{i}\Delta_{g}d_{i} - (N-p+1)}{d_{i}^{2}} |v|^{p-2} + (p-2)\left(\frac{N-p}{n(p-1)}\right)^{p-1} \left[-\sum_{i,j,k=1}^{n} \frac{G_{ij}G_{ik}}{d_{i}^{2}d_{j}d_{k}} + \sum_{\substack{1 \le k \le n, \\ 1 \le i < j \le n}} \frac{\operatorname{Hess}^{d_{i}}(\nabla_{g}d_{k}, \nabla_{g}d_{j}) + \operatorname{Hess}^{d_{j}}(\nabla_{g}d_{k}, \nabla_{g}d_{i})}{d_{i}d_{j}d_{k}}\right] |v|^{p-4} .$$
(4.11)

It is clear, according to (3.2) and (3.3), that

$$V = V_{p,a_1,...,a_n}.$$
 (4.12)

By Proposition 4.1, with $V = V_{p,a_1,...,a_n}$ and constant $\mu = 1$, Theorem 3.1 is proved.

We are now in the position of proving the simplified form of $V_{p,a_1,...,a_n}$ when we restrict only to two poles a_1 and a_2 . *Proof of Proposition 3.2.* We will use the notations of C_1 and C_2 from (3.3) for n = 2. The expression of V in (4.11) becomes

We look at the mixed term containing G_{ij} and G_{ik} . Recall that $G_{ij} = g(\nabla_g d_i, \nabla_g d_j)$ and $|\nabla_g d_i| = 1$ for any $i, j = \overline{1, 2}$. Then,

$$= \frac{1}{d_{1}^{4}d_{2}^{4}} \left[d_{1}^{4} + d_{2}^{4} + 2d_{1}^{3}d_{2}G_{12} + 2d_{1}d_{2}^{3}G_{12} + 2d_{1}^{2}d_{2}^{2}G_{12}^{2} \right]$$

$$= \frac{1}{d_{1}^{4}d_{2}^{4}} \left[\left(d_{1}^{2} + d_{2}^{2} \right)^{2} + 2d_{1}d_{2}G_{12} \left(d_{1}^{2} + d_{2}^{2} \right) - 2d_{1}^{2}d_{2}^{2} \left(1 - G_{12}^{2} \right) \right]$$

$$= |v|^{2} \left(\frac{1}{d_{1}^{2}} + \frac{1}{d_{2}^{2}} \right) - 2\frac{1 - G_{12}^{2}}{d_{1}^{2}d_{2}^{2}}.$$
(4.13)

We also notice that the mixed terms with Hessians will be 0, using the symmetry of the Hessian operator:

Similarly, $\text{Hess}^{d_2}(\nabla_g d_2, \nabla_g d_1) = 0$. Hence, the potential *V* becomes:

$$\begin{split} V &= C_1(2,p) \left| \frac{\nabla_g d_1}{d_1} - \frac{\nabla_g d_2}{d_2} \right|^2 |v|^{p-2} + C_2(2,p) \sum_{i=1}^2 \frac{d_i \Delta_g d_i - (N-p+1)}{d_i^2} |v|^{p-2} \\ &+ (p-2)C_2(2,p) \left[-\left(\frac{1}{d_1^2} + \frac{1}{d_2^2}\right) |v|^2 + 2\frac{1-G_{12}^2}{d_1^2 d_2^2} + \frac{\operatorname{Hess}^{d_1}(\nabla_g d_2, \nabla_g d_2)}{d_1 d_2^2} + \frac{\operatorname{Hess}^{d_2}(\nabla_g d_1, \nabla_g d_1)}{d_1 d_2^2} \right] |v|^{p-4} \\ &= C_1(2,p) \left| \frac{\nabla_g d_1}{d_1} - \frac{\nabla_g d_2}{d_2} \right|^2 |v|^{p-2} + C_2(2,p) \sum_{i=1}^2 \frac{d_i \Delta_g d_i - (N-1)}{d_i^2} |v|^{p-2} \\ &+ 2(p-2)C_2(2,p) \frac{1-G_{12}^2}{d_1^2 d_2^2} |v|^{p-4} + (p-2)C_2(2,p) \left(\frac{\operatorname{Hess}^{d_1}(\nabla_g d_2, \nabla_g d_2)}{d_1 d_2^2} + \frac{\operatorname{Hess}^{d_2}(\nabla_g d_1, \nabla_g d_1)}{d_1^2 d_2} \right) |v|^{p-4} \,. \end{split}$$

Proof of Corollary 3.3. Inequality (3.8) is a simple consequence of Theorem 3.1 and Proposition 3.2.

On Cartan-Hadamard manifolds, the positiveness of the right-hand side of (3.8) for $2 \le p < N$ is deduced by Laplacian comparison principle - Theorem 2.3 - and Hessian comparison principle - Theorem 2.2 - (see also Remark 2.6), coupled with the Cauchy-Schwarz inequality.

In order to prove that the constant 1 is sharp in (3.8) and actually attained in $\mathcal{D}^{1,p}(M)$ for 2 , we prove that

$$\int_{M} \left| \nabla_{g} \phi \right|^{p} dv_{g} = \int_{M} V_{p,a_{1},a_{2}} \phi^{p} dv_{g}, \qquad (4.15)$$

for ϕ defined in (3.9). This is done by integration by parts, but first, we need to prove that $\phi \in \mathcal{D}^{1,p}(M)$, i.e. that $\|\nabla_g \phi\|_p$ is finite. Using the definition of ϕ , for $\beta = \frac{p-N}{2(p-1)}$ and using (4.3), we get

$$\int_{M} \left| \nabla_{g} \phi \right|^{p} dv_{g} = \left| \beta \right|^{p} \int_{M} \phi^{p} \left| \sum_{i=1}^{n} \frac{\nabla_{g} d_{i}}{d_{i}} \right|^{p} dv_{g}.$$

We have to divide the integral in different regions in *M*. More precisely, let r > 0 sufficiently small, say $r < \frac{\text{dist}(a_1, a_2)}{4}$, and $R > \text{dist}(a_1, a_2)$. Fix *a* to be a point with the property that $\text{dist}(a, a_1) = \text{dist}(a, a_2)$ situated on a geodesic which connects a_1 and a_2 . We consider the balls $B_{a_i}(r)$ of radius *r* around the points a_i and the set of points $A := \{x \in M \mid \text{dist}(a, a_i) > R\}$, for any i = 1, 2. Note that from the choice of *r* and *R*, the set *A* contains both balls $B_r(a_i)$. Now, the integral above is

$$\int_{M} |\nabla_{g}\phi|^{p} dv_{g} = \int_{M\setminus A} |\nabla_{g}\phi|^{p} dv_{g} + \int_{A\setminus \cup_{i=1}^{2} B_{r}(a_{i})} |\nabla_{g}\phi|^{p} dv_{g} + \int_{\cup_{i=1}^{2} B_{r}(a_{i})} |\nabla_{g}\phi|^{p} dv_{g}$$

:= $I_{1} + I_{2} + I_{3}$. (4.16)

Since the set $A \setminus \bigcup_{i=1}^{2} B_r(a_i)$ is compact, the integral I_2 is finite. From now on, by \simeq between two quantities, we understand that we disregard the constants appearing in computations and that the asymptotic behavior of the quantities involved is the same. Now for any i = 1, 2, by the co-area formula, we have

$$\int_{B_r(a_i)} \left| \nabla_g \phi \right|^p dv_g \simeq \int_{B_r(a_i)} d_i^{p(\beta-1)} dv_g \simeq \int_0^r t^{p(\beta-1)+N-1} dt.$$

This integral is finite if

$$p(\beta - 1) + N > 0 \iff \frac{(p-2)(N-p)}{2(p-1)} > 0.$$

Hence, the integral I_3 is finite for any $2 \le p < N$. For the first integral, we need to make some estimates first. Let us notice, from the properties of the distance function and the point *a*, that for any $x \in M \setminus A$

$$d(x, a_i) \le d(x, a) + d(a, a_i) \le 2d(x, a)$$

and

$$d(x,a_i) \ge d(x,a) - d(a,a_i) \ge d(x,a) - \frac{R}{2} = \frac{d(x,a)}{2} + \frac{d(x,a) - R}{2} \ge \frac{d(x,a)}{2}$$

Hence, we conclude that

So we can estimate the integral I_1 in terms of the distance from x to a, denoted by d := d(x, a).

$$\int_{M\setminus A} \left| \nabla_g \phi \right|^p dv_g \simeq \int_{M\setminus A} d^{p(2\beta-1)} dv_g \simeq \int_R^\infty t^{p(2\beta-1)+N-1} dv_g.$$

This integral is finite if

$$p(2\beta - 1) + N < 0 \quad \Longleftrightarrow \quad \frac{p - N}{p - 1} < 0.$$

Thus, the integral I_1 is finite for p > 1. Combining the above, we obtain that for $2 \le p < N$ the integrals I_1 , I_2 and I_3 are finite, hence $\|\nabla_g \phi\|_p$ is finite. Now, using integration by parts, we get

$$\int_{M} V_{p,a_1,a_2} \left| \phi \right|^p dv_g = -\int_{M} \frac{\Delta_p \phi}{\phi^{p-1}} \left| \phi \right|^p dv_g = \int_{M} \left| \nabla_g \phi \right|^p dv_g,$$

which concludes the proof.

Now we will investigate the result on Cartan-Hadamard manifolds, where we are able to prove a sharp inequality.

Proof of Corollary 3.4. The inequality is derived from Corollary 3.3 and the following estimates. Recall that the sectional curvatures are bounded from above by a constant $c = -R^2$, where R > 0. First, by the inequality (see [25, Theorem 1.4])

and using (2.13), we have that

Next, we estimate the Hessian using (2.12) and (2.15):

$$\begin{aligned} \operatorname{Hess}^{d_{1}}(\nabla_{g}d_{2},\nabla_{g}d_{2}) &\geq d_{1}R\operatorname{coth}(d_{1}R) \ g(\pi_{d_{1}}\nabla_{g}d_{2},\nabla_{g}d_{2}) \\ &\geq \left[1 + \frac{3R^{2}d_{i}^{2}}{\pi^{2} + R^{2}d_{i}^{2}}\right]g\left(\nabla_{g}d_{2} - \frac{g(\nabla_{g}d_{2},\nabla_{g}d_{1})}{g(\nabla_{g}d_{1},\nabla_{g}d_{1})}\nabla_{g}d_{1},\nabla_{g}d_{2}\right) \\ &= \left[1 + \frac{3R^{2}d_{i}^{2}}{\pi^{2} + R^{2}d_{i}^{2}}\right]\left(1 - G_{12}^{2}\right). \end{aligned}$$
(4.19)

-	-
_	_

Combining (4.18) and (4.19), we get the desired (3.10).

It remains to prove the sharpness of the constant $C_1(2, p)$ in (3.11). Let $\varepsilon > 0$ small enough such that $B_{2\sqrt{\varepsilon}}(a_1) \cap B_{2\sqrt{\varepsilon}}(a_2) = \emptyset$. For i = 1, 2, let

$$u_{\varepsilon}(x) = \begin{cases} \frac{\log\left(\frac{d_{i}(x)}{\varepsilon^{2}}\right)}{\log\left(\frac{1}{\varepsilon}\right)} d_{i}(x)^{\frac{p-n}{2(p-1)}}, & \text{if } x \in A_{i}[\varepsilon^{2}, \varepsilon]; \\ \frac{2\log\left(\frac{\sqrt{\varepsilon}}{d_{i}(x)}\right)}{\log\left(\frac{1}{\varepsilon}\right)} d_{i}(x)^{\frac{p-n}{2(p-1)}}, & \text{if } x \in A_{i}[\varepsilon, \sqrt{\varepsilon}]; \\ 0, & \text{otherwise,} \end{cases}$$
(4.20)

Since u_{ε} has compact support for any ε , we can use it as a test function in the inequality and, since all the other terms are positive, we get that

$$C_1(2,p) \le \frac{\int_M |\nabla u_{\varepsilon}|^p \, dv_g}{\int_M |v|^{p-2} \left| \frac{\nabla_g d_1}{d_1} - \frac{\nabla_g d_2}{d_2} \right|^2 |u_{\varepsilon}|^p \, dv_g} = \frac{I_{\varepsilon}}{J_{\varepsilon} - 2K_{\varepsilon}}$$

where we denoted:

$$I_{\varepsilon} = \int_{M} \left| \nabla_{g} u_{\varepsilon} \right|^{p} dv_{g}, \quad J_{\varepsilon} = \int_{M} \left| v \right|^{p-2} \left(\frac{1}{d_{1}^{2}} + \frac{1}{d_{2}^{2}} \right) \left| u_{\varepsilon} \right|^{p} dv_{g}, \quad K_{\varepsilon} = \int_{M} \left| v \right|^{p-2} \frac{g(\nabla_{g} d_{1}, \nabla_{g} d_{2})}{d_{1} d_{2}} \left| u_{\varepsilon} \right|^{p} dv_{g}.$$

Similar to the work in [14], we can show by direct computations that

$$I_{\varepsilon} - C_1(2, p)J_{\varepsilon} = O(1), \quad K_{\varepsilon} = O(\sqrt{\varepsilon}) \text{ and } \lim_{\varepsilon \to 0} J_{\varepsilon} = +\infty.$$

Finally, we conclude that

$$C_1(2,p) \le \frac{J_{\varepsilon} + O(1)}{J_{\varepsilon} + O(\sqrt{\varepsilon})} \xrightarrow{\varepsilon \to 0} C_1(2,p),$$
(4.21)

and the proof is finished.

5 Bipolar Hardy inequalities in constant curvature setting

In this section we want to explore inequality (3.8) in the case of constant sectional curvature and see how can we make particular estimates on the operators to obtain remainders depending only on the curvature and distance functions. Mainly, we try and get rid of the second-order terms Δ_g and Hess^d.

5.1 Bipolar *L^p*-Hardy inequalities on the hyperbolic space

For the hyperbolic space, we consider the Poincaré ball model, defined as $\mathbb{H}^N = \{x \in \mathbb{R}^N : |x| < 1\}$, equipped with the Riemannian metric

$$g_{\mathbb{H}^{N}}(x) = (g_{ij}(x))_{i,j=\overline{1,N}} = \rho(x)^{2} \delta_{ij},$$
(5.1)

where $\rho(x) = \frac{2}{1-|x|^2}$. It is well established that $(\mathbb{H}^N, g_{\mathbb{H}^N})$ forms a Cartan-Hadamard manifold with a constant sectional curvature of -1.

The associated volume element is expressed as

$$dv_{\mathbb{H}^N}(x) = \rho(x)^N dx, \tag{5.2}$$

while the hyperbolic gradient and Laplace-Beltrami operator are

$$\nabla_{\mathbb{H}^N} u = \frac{\nabla u}{\rho^2}, \quad \text{and} \quad \Delta_{\mathbb{H}^N} u = \rho^{-N} \operatorname{div}(\rho^{n-2} \nabla u),$$
(5.3)

where ∇ represents the standard Euclidean gradient in \mathbb{R}^N . The hyperbolic distance between two points $x, y \in \mathbb{H}^N$ is given by

$$d_{\mathbb{H}^{N}}(x,y) = \operatorname{arcosh}\left(1 + 2\frac{|x-y|^{2}}{(1+|x|^{2})(1+|y|^{2})}\right).$$
(5.4)

Proposition 5.1. For any $2 \le p < N$ and $u \in C_c^{\infty}(\mathbb{H}^N)$:

$$\begin{split} \int_{\mathbb{H}^{N}} \left| \nabla_{\mathbb{H}^{N}} u \right|^{p} dv_{\mathbb{H}^{N}} &\geq C_{1}(2, p) \int_{\mathbb{H}^{N}} \widetilde{V}_{p, a_{1}, a_{2}} |u|^{p} dv_{\mathbb{H}^{N}} + (N - 1)C_{2}(2, p) \sum_{i=1}^{2} \int_{\mathbb{H}^{N}} \frac{3}{\pi^{2} + d_{i}^{2}} |v|^{p-2} |u|^{p} dv_{\mathbb{H}^{N}} \\ &+ (p - 2)C_{2}(2, p) \sum_{i=1}^{2} \int_{\mathbb{H}^{N}} \frac{1 - G_{12}^{2}}{d_{1}^{2} d_{2}^{2}} \left[2 + \frac{3d_{i}^{2}}{\pi^{2} + d_{i}^{2}} \right] |v|^{p-4} |u|^{p} dv_{\mathbb{H}^{N}}, \end{split}$$
(5.5)

where the constant $C_1(2, p) = (p-1) \left(\frac{N-p}{2(p-1)}\right)^p$ is sharp.

Proof. By Corollary 3.4, since the sectional curvatures of the hyperbolic space are all equal to -1, we get the inequality along with the sharpness of the constant.

5.2 Bipolar L^p -Hardy inequalities on the upper-hemisphere

By \mathbb{S}^N_+ we denote the upper-hemisphere of \mathbb{S}^N endowed with the usual Riemannian metric of \mathbb{S}^N inherited by \mathbb{R}^{N+1} . If we consider a_0 to be the north pole of \mathbb{S}^N_+ , then we define $\delta := \max(d(a_0, a_1), d(a_0, a_2))$. We have the following result:

Proposition 5.2. For any $2 \le p < N$ and $u \in C_c^{\infty}(\mathbb{S}^N_+)$:

$$\begin{split} \int_{\mathbb{S}_{+}^{N}} \left| \nabla_{g} u \right|^{p} dv_{g} &\geq C_{1}(2, p) \int_{\mathbb{S}_{+}^{N}} \left| \frac{\nabla_{g} d_{1}}{d_{1}} - \frac{\nabla_{g} d_{2}}{d_{2}} \right|^{2} |v|^{p-2} |u|^{p} dv_{g} + (N-1)C_{2}(2, p)c(\delta) \int_{\mathbb{S}_{+}^{N}} |v|^{p-2} |u|^{p} dv_{g} \\ &+ (p-2)C_{2}(2, p) \int_{\mathbb{S}_{+}^{N}} \left(4 + c(\delta)(d_{1}^{2} + d_{2}^{2}) \right) \frac{1 - G_{12}^{2}}{d_{1}^{2} d_{2}^{2}} |v|^{p-4} |u|^{p} dv_{g}, \end{split}$$
(5.6)

where $c(\delta) = \frac{7\pi^2 - 3(\delta + \frac{\pi}{2})^2}{\pi^2 ((\delta + \frac{\pi}{2})^2 - \pi^2)}$.

Proof. The inequality follows from Theorem 3.1 and certain convenient estimates arising from the influence of positive curvature of the sphere \mathbb{S}_{+}^{N} , rather than the case of Cartan-Hadamard manifolds. By [26, Proposition 11.3] and Theorem(2.2), we have that

$$\operatorname{Hess}^{d_i} = \frac{s'_c(d_i)}{s_c(d_i)} \pi_{d_i}, \text{ for any } i = 1, 2.$$

Explicitly, from (2.15), we get that

$$\operatorname{Hess}^{d_i}(\nabla_g d_j, \nabla_g d_j) = \operatorname{cot}(d_i) \left(1 - G_{ij}^2\right), \text{ for any } i, j = 1, 2, i \neq j.$$

Consequently,

$$\Delta d_i = (N - 1) \cot(d_i)$$
, for any $i = 1, 2$.

We will use the Mittag-Leffler expansion of the cotangent function (see, e.g., [2]), that is

$$\cot(t) = \frac{1}{t} + 2t \sum_{k=1}^{\infty} \frac{1}{t^2 - \pi^2 k^2}, \quad t \in (0, \pi).$$
(5.7)

Taking into account that $d_i \in (0, \pi)$ in \mathbb{S}^N_+ and that $\delta < \frac{\pi}{2}$, we get that $d_i(x) \le d(a_0, a_i) + d(a_0, x) < \delta + \frac{\pi}{2}$. Hence,

$$\begin{split} \sum_{i=1}^{2} \int_{\mathbb{S}_{+}^{N}} \frac{d_{i} \Delta d_{i} - (N-1)}{d_{i}^{2}} |v|^{p-2} |u|^{p} dv_{g} &= (N-1) \sum_{i=1}^{2} \int_{\mathbb{S}_{+}^{N}} \frac{d_{i} \cot(d_{i}) - 1}{d_{i}^{2}} |v|^{p-2} |u|^{p} dv_{g} \\ &= 2(N-1) \sum_{i=1}^{2} \int_{\mathbb{S}_{+}^{N}} \sum_{k=1}^{\infty} \frac{1}{d_{i}^{2} - \pi^{2} k^{2}} |v|^{p-2} |u|^{p} dv_{g} \\ &\geq 2(N-1) \sum_{i=1}^{2} \left(\frac{1}{(\delta + \frac{\pi}{2})^{2} - \pi^{2}} + \frac{1}{\pi^{2}} \sum_{k=2}^{\infty} \frac{1}{1 - k^{2}} \right) \int_{\mathbb{S}_{+}^{N}} |v|^{p-2} |u|^{p} dv_{g} \\ &= 4(N-1) \left(\frac{1}{(\delta + \frac{\pi}{2})^{2} - \pi^{2}} - \frac{3}{4\pi^{2}} \right) \int_{\mathbb{S}_{+}^{N}} |v|^{p-2} |u|^{p} dv_{g} \\ &= (N-1) \frac{7\pi^{2} - 3(\delta + \frac{\pi}{2})^{2}}{\pi^{2} \left((\delta + \frac{\pi}{2})^{2} - \pi^{2} \right)} \int_{\mathbb{S}_{+}^{N}} |v|^{p-2} |u|^{p} dv_{g}. \end{split}$$

Next, we turn our attention to the Hessian term in the inequality. In the same manner, we get that

$$\begin{split} \sum_{\substack{i,j=1\\i\neq j}}^{2} \int_{\mathbb{S}^{N}_{+}} \frac{\operatorname{Hess}^{d_{i}}(\nabla_{g}d_{j},\nabla_{g}d_{j})}{d_{i}d_{j}^{2}} |v|^{p-4} |u|^{p} dv_{g} &= \sum_{i=1}^{2} \int_{\mathbb{S}^{N}_{+}} d_{i} \operatorname{cot}(d_{i}) \frac{1-G_{12}^{2}}{d_{1}^{2}d_{2}^{2}} |v|^{p-4} |u|^{p} dv_{g} \\ &= \sum_{i=1}^{2} \int_{\mathbb{S}^{N}_{+}} \left(1+2d_{i}^{2} \sum_{k=1}^{\infty} \frac{1}{d_{i}^{2} - \pi^{2}k^{2}}\right) \frac{1-G_{12}^{2}}{d_{1}^{2}d_{2}^{2}} |v|^{p-4} |u|^{p} dv_{g} \\ &\geq \sum_{i=1}^{2} \int_{\mathbb{S}^{N}_{+}} \left(1+c(\delta)d_{i}^{2}\right) \frac{1-G_{12}^{2}}{d_{1}^{2}d_{2}^{2}} |v|^{p-4} |u|^{p} dv_{g} \\ &= \int_{\mathbb{S}^{N}_{+}} \left(2+c(\delta)(d_{1}^{2} + d_{2}^{2})\right) \frac{1-G_{12}^{2}}{d_{1}^{2}d_{2}^{2}} |v|^{p-4} |u|^{p} dv_{g}. \end{split}$$

From (3.8),

$$\begin{split} \int_{\mathbb{S}_{+}^{N}} \left| \nabla_{g} u \right|^{p} dv_{g} &\geq C_{1}(2, p) \int_{\mathbb{S}_{+}^{N}} \left| \frac{\nabla_{g} d_{1}}{d_{1}} - \frac{\nabla_{g} d_{2}}{d_{2}} \right|^{2} |v|^{p-2} |u|^{p} dv_{g} + (N-1)C_{2}(2, p)c(\delta) \int_{\mathbb{S}_{+}^{N}} |v|^{p-2} |u|^{p} dv_{g} \\ &+ (p-2)C_{2}(2, p) \int_{\mathbb{S}_{+}^{N}} \left(4 + c(\delta)(d_{1}^{2} + d_{2}^{2}) \right) \frac{1 - G_{12}^{2}}{d_{1}^{2} d_{2}^{2}} |v|^{p-4} |u|^{p} dv_{g}, \end{split}$$
(5.8)

which concludes the proof.
