Relative Free Splitting Complexes III: Stable Translation Lengths and Filling Paths

Abstract

This is the last of a three part work about relative free splitting complexes $\mathcal{FS}(\Gamma, \mathcal{A})$ and their actions by relative outer automorphism groups $\operatorname{Out}(\Gamma; \mathcal{A})$. We obtain quantitative relations between the stable translation length τ_{ϕ} and the relative train track dynamics of $\phi \in \operatorname{Out}(\Gamma; \mathcal{A})$. First, if ϕ has an orbit with diameter bounded below by a certain constant $\Omega(\Gamma; \mathcal{A}) \geq 1$ then ϕ has a filling attracting lamination. Also, there is a positive lower bound $\tau_{\phi} \geq A(\Gamma; \mathcal{A}) > 0$ amongst all ϕ which have a filling attracting lamination. Both proofs rely on a study of *filling paths* in a free splitting. These results are all new even for $\operatorname{Out}(F_n)$.

1 Introduction

Given a group Γ and a free factor system \mathcal{A} , the relative outer automorphism group $\operatorname{Out}(\Gamma; \mathcal{A})$ acts by isometries on the relative free splitting complex $\mathcal{FS}(\Gamma; \mathcal{A})$. That complex is hyperbolic [HM13], and so $\phi \in \operatorname{Out}(\Gamma; \mathcal{A})$ has positive stable translation length τ_{ϕ} if and only if each orbit map $n \mapsto \phi^n(T)$ is a quasigeodesic $(T \in \mathcal{FS}(\Gamma; \mathcal{A}))$, in which case ϕ is *loxodromic*. In general ϕ can also be *parabolic* meaning it has unbounded orbits but $\tau_{\phi} = 0$, or *elliptic* meaning that orbits are bounded, hence $\tau_{\phi} = 0$. The main results of these works are Theorems A, B restated below. These results, taken together with Theorem C from Part II, correlate the dynamics of ϕ acting on $\mathcal{FS}(\Gamma; \mathcal{A})$ with the "relative train track" dynamics of ϕ , particularly its attracting laminations.

Theorem A. There exist $A = A(\Gamma; A) > 0$ and $B = B(\Gamma; A) > 0$ such that for any $\phi \in Out(\Gamma; A)$, if ϕ has an attracting lamination which fills Γ rel A, with associated expansion factor λ_{ϕ} , then $A \leq \tau_{\phi} \leq B \log(\lambda_{\phi})$.

Theorem B. There exists $\Omega = \Omega(\Gamma; \mathcal{A}) > 0$ such that for any $\phi \in Out(\Gamma; \mathcal{A})$ the following are equivalent:

- (1) ϕ has an attracting lamination that fills Γ rel A;
- (2) ϕ acts loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$;
- (3) ϕ acts with unbounded orbits on $\mathcal{FS}(\Gamma; \mathcal{A})$;
- (4) Every orbit of the action of ϕ on $\mathcal{FS}(\Gamma; \mathcal{A})$ has diameter $\geq \Omega$.

As a consequence, no element of $Out(\Gamma; A)$ acts parabolically on $\mathcal{FS}(\Gamma; A)$.

In these theorems and throughout this work, notations like $C = C(\Gamma; \mathcal{A})$ mean that C is a numerical constant depending only on two non-negative, integer valued numerical invariants of Γ and \mathcal{A} , namely the cardinality $|\mathcal{A}|$ and the corank $(\mathcal{A}) = \text{corank}(\Gamma; \mathcal{A})$ (see Section 2.1.1). The constants A, B, Ω will themselves be defined by formulas involving constants drawn from [HM14, HM22].

In the foundational case where $\Gamma = F_n$ and $\mathcal{A} = \emptyset$, the equivalences (1) \iff (2) \iff (3) of Theorem B were obtained in [HM19]; the hard implication (1) \implies (2) was proved using delicate relative train track methods. The methods we use here are new even in that foundational case. The proofs here rely only the most basic relative train track methods. Also, there are powerful new conclusions of a quantitative nature, namely the additional equivalent item (4) in Theorem B, and the lower bound in Theorem A.

Part II of this work was devoted primarily to the proof and applications of the *Two Over All Theorem*, including application to the upper bound of Theorem A. Here in Part III the main results are:

Section 3: The implication $(4) \Longrightarrow (1)$ of Theorem B.

Section 4: The lower bound of Theorem A.

Applying these results, we can now complete the following:

Proof of Theorem B. The implication $(1) \Longrightarrow (2)$ is an immediate consequence of the lower bound of Theorem A. The implications $(2) \Longrightarrow (3) \Longrightarrow (4)$ are immediate consequences of the definitions. And as just said, the remaining implication $(4) \Longrightarrow (1)$ is proved in Section 3.

Methods of proof, based on filling paths in free splittings.

Concepts of "filling", and related concepts of "free factor supports", play an important role in the study of $Out(F_n)$ and its generalizations $Out(\Gamma; \mathcal{A})$.

For a simple example of filling consider any group element $\gamma \in \Gamma$. There is a unique smallest free factor F of Γ relative to A such that $\gamma \in F$, and one can say that F is the free factor support of γ rel \mathcal{A} . To say that γ fills Γ rel \mathcal{A} means that $F = \Gamma$. There is another characterization of filling of a more "concrete" nature in that that it is expressed in terms of how γ relates to each individual Grushko free splitting T of Γ rel \mathcal{A} : γ fills Γ rel \mathcal{A} if and only if the action of γ on each T has an invariant axis $L \subset T$ along which γ acts as a translation, and the set of translates $\{\delta \cdot L \mid \delta \in \Gamma\}$ covers T. More generally, given a lamination Λ of Γ relative to \mathcal{A} — meaning a closed, $Out(\Gamma; \mathcal{A})$ -invariant subset of the abstract line space $\mathcal{B}(\Gamma; \mathcal{A})$ — associated to Λ is its free factor support $\mathcal{F}\Lambda$ of Λ rel \mathcal{A} , defined to be the minimal free factor system of Γ rel \mathcal{A} that "supports" Λ [HM22, Section 4.1.2]. One says that Λ fills Γ rel \mathcal{A} if and only if $\mathcal{F}\Lambda = \{[\Gamma]\}$. This version of filling also has a more concrete version: Λ fills Γ rel \mathcal{A} if and only if for every Grushko free splitting R of Γ rel A, the tree R is covered by the set of lines in R that realize leaves of Λ ; see [HM22, Section 4.1.2] for details, in particular [HM22, Lemmas 4.2, 4.3]. Free factor supports of attracting laminations of elements of $Out(F_n)$ play a central role in relative train track theory and its applications [BFH00, HM19, HM20, HM23]. For the general case of $\operatorname{Out}(\Gamma; \mathcal{A})$, the concrete filling criterion for attracting laminations is applied here in the opening paragraphs of Section 3.7.

The germ of this work was the following question that we formulated while first pondering the existence of a lower bound as in Theorem A. Consider $\phi \in \text{Out}(\Gamma; \mathcal{A})$, and assume that ϕ has an attracting lamination Λ that fills Γ rel \mathcal{A} ; also, assume for simplicity that there exists an EG-aperiodic train track representative $F: T \to T$ of ϕ defined on a Grushko free splitting T of Γ rel \mathcal{A} (see [HM14, Section 4.3.3]). A bi-infinite line $L \subset T$ represents a generic leaf of Λ if and only if L can be written as a nested union of "natural iteration tiles" of F, meaning paths of the form $F^k(E)$ for natural edges $E \subset T$ (see [Lym22a, Section 4], or see Section 3.4 here for a quick summary). We asked ourselves:

• What properties of the tiles $F^k(E)$ follow from the hypothesis that Λ fills Γ rel \mathcal{A} ? In particular, is there some kind of useful "filling" property that is satisfied by the paths $F^k(E) \subset T$ as long as k is sufficiently large?

We found an affirmative answer to this question (see Proposition 4.4, discussed below), expressed using a property roughly modelled on the "concrete" filling criteria discussed above. Although it may not seem sensible to ask how a path $\alpha \subset T$ relates to *arbitrary* free splittings S, for those special free splittings S that are expansions of T it turns out to be very sensible:

Filling paths (Definition 2.2) In a free splitting T of Γ rel \mathcal{A} , to say that a path $\alpha \subset T$ fills T means that for any collapse map $S \mapsto T$ defined on a free splitting S of Γ rel \mathcal{A} , letting $\tilde{\alpha} \subset S$ denote the natural lift of α to S (Definition 2.1), the path $\tilde{\alpha}$ has an interior crossing of some edge in the orbit of every natural edge of S. More precisely: for every natural edge $E \subset S$ there exists $\gamma \in \Gamma$ such that $\gamma \cdot E$ is contained in the interior of α .

The earlier examples of filling concepts each had two equivalent versions: a "concrete" criterion and a "free factor system" criterion. Beside the "concrete" criterion for filling paths expressed just above (taken from Definition 2.2), in Proposition 2.9 we state a criterion expressed in terms of a certain free factor system rel \mathcal{A} denoted $\mathcal{F}[\alpha; T]$ that we call the *filling support* of α ; see just below for a brief discussion.

Our two main technical results here regarding filling paths are: the Strong Two Over All Theorem 2.4, which is applied in the proof of the implication $(4) \implies (1)$ of Theorem B; and Proposition 4.4, which is applied in finding the lower bound for Theorem A. Although as said above our first progress on this project was Proposition 4.4, in retrospect the exposition is cleaner if one leads off with the Strong Two Over All Theorem, which we do in Section 2.

The Strong Two Over All Theorem (Section 2). Recall the Two Over All Theorem of [HM22] in its uniterated form, which says that for any foldable map $f: S \to T$ between free splittings of Γ rel \mathcal{A} , if the distance $d_{\mathcal{FS}}(S,T)$ exceeds a certain constant then the free splitting S has two natural edges in distinct orbits whose f-images in T each cross a representative of every edge orbit of T. The Strong Two Over All Theorem says that if $d_{\mathcal{FS}}(S,T)$ exceeds a certain larger constant $D = D(\Gamma; \mathcal{A})$ then S has two natural edges in distinct orbits whose f-images in T each fill T; there is also an iterated form of the theorem which gives conclusions when $d_{\mathcal{FS}}(S,T)$ exceeds a multiple KD of the constant D.

In broad outline the two theorems have similar proofs: one factors f as a Stallings fold path $S = S_0 \xrightarrow{f_1} \cdots \xrightarrow{f_M} S_M = T$, and for each natural edge $E \subset S$ one studies the evolution of the natural tiles $\alpha_l = f_l^0(E) \subset S_l$ as l increases from 0 to M. In the proof of the *Two Over All Theorem*, the game was over once the "covering forest" $\beta(\alpha_l; S_l) = \bigcup_{\gamma \in \Gamma} \gamma \cdot \alpha_l$ covered the whole of S_l . But that is barely the start of the game in the *Strong Two Over All Theorem*. We study certain

decompositions of $\beta(\alpha_l; S_l)$ called "protoforests" (Definition 2.6), which are Γ -invariant collections of non-overlapping subtrees called the "protocomponents" of the protoforest. The overlap protoforest $\beta^{\circ}(\alpha_l; S_l)$ (Definition 2.7) captures patterns of overlap amongst the translates of α_l . The protocomponent stabilizers of $\beta^{\circ}(\alpha_l; S_l)$ need not be free factors of Γ rel \mathcal{A} ; see examples and counterexamples in Section 2.2. The filling support $\mathcal{F}[\alpha_l; S_l]$ is indirectly defined as the smallest free factor system rel \mathcal{A} that supports the protocomponent stabilizers of the overlap protoforest $\beta^{\circ}(\alpha_l; S_l)$ (Definition 2.8). Section 2.3 contains the proof of the filling criterion mentioned earlier. The key step occurs in Lemma 2.11 which is a delicate construction of the *filling protoforest* $\beta^{\rm f}(\alpha_l; S_l)$, whose protocomponent stabilizers do give the filling support $\mathcal{F}[\alpha_l; S_l]$, as summarized at the end of Section 2.3.2. After a further study of filling protoforests in Sections 2.3.3–2.3.4, focussing on their behavior under expansions of a free splitting, in Section 2.4 we prove the *Strong Two Over All Theorem* by studying the evolution of the filling protoforests $\beta^{\rm f}(\alpha_l; S_l)$ as lincreases.

The implication $(4) \implies (1)$ of Theorem B (Section 3). The proof will produce a certain constant $\Omega = \Omega(\Gamma; \mathcal{A})$ and then use it to show that if all orbits of $\phi \in \text{Out}(\Gamma; \mathcal{A})$ have diameter $\geq \Omega$ then ϕ has a filling lamination. Carrying this out will require tools from relative train track theory (from [Lym22a], from the prequels [HM14, HM22], and from earlier sections of this paper), and a certain amount of the work in this section is to provide justifications for applying each of these tools. These justifications depend on assuming two constraints on the value of Ω , in the form of two lower bounds Ω_1, Ω_2 . The value of Ω is then set to be the maximum of those lower bounds. Here is a brief outline of the proof; for a fuller and more formal outline see Section 3.1.

In Section 3.5 the tool we use is [HM22, Proposition 4.24]. That result, applied in conjunction with the first constraint $\Omega \geq \Omega_1$, let's us specify a train track representative $F: T \to T$ which is "EG-aperiodic" (short for "exponentially growing aperiodic"), an attracting lamination Λ of ϕ that is associated to F, and a train track axis for ϕ in $\mathcal{FS}(\Gamma; \mathcal{A})$ which is obtained by suspending F. At the free splitting occupying each position along this axis, every generic leaf of Λ is realized by a unique line in that free splitting, and that line can be written as a nested union of tiles obtained by pushing forward edges from earlier free splittings along the axis (see Conclusion (2c) of Section 3.5.2).

In Section 3.6, one tool we use is the *Strong Two Over All Theorem*. The hypothesis of that theorem is verified (uniformly along the axis) by applying the second constraint $\Omega \geq \Omega_2$. From the conclusion of that theorem we obtain (uniformly) filling tiles at every position along the axis. Using these tiles in conjunction with another tool — namely, concepts of free splitting units from [HM14, Section 4.5] — we then prove that the axis is a quasigeodesic line in $\mathcal{FS}(\Gamma; \mathcal{A})$.

The remainder of the proof is found in Section 3.7. To show that Λ fills it suffices to show that, in any Grushko free splitting R of Γ rel A and for any bi-infinite line in R that realizes a generic leaf of Λ , that line crosses a representative of every edge orbit of R (see Corollary 3.5). We do this with the aid of a tool from [HM14], namely "projection diagrams". Given R, we carefully choose a finite subpath of the fold axis; the choice is informed by the *Quasi-Closest Point Property* (a consequence of the Masur–Minsky axioms that is derived in [HM14, Section 5.1]) in conjunction with the fact that the axis is a quasigeodesic line. We then take a projection diagram from R to the chosen axis subpath, and we use filling tiles in that diagram to prove the desired crossing property for generic leaves in R.

But there is a complication. When applying [HM22, Proposition 4.24] in Section 3.5 to obtain

the train track representative $f: T \to T$ of ϕ , it may happen that the free factor system \mathcal{F} given by the vertex stabilizers of the free splitting T is strictly larger than the free factor system \mathcal{A} . In order to even apply [HM22, Proposition 4.24], we must therefore choose \mathcal{F} first, so as to be a maximal, non-filling, ϕ -invariant free factor system rel \mathcal{A} . It follows that Λ is an attracting lamination of ϕ relative to \mathcal{F} . But, what we need is an attracting lamination of ϕ relative to \mathcal{A} , and that's not what we have yet in the case that \mathcal{F} is strictly larger than \mathcal{A} . So there is still some work to do in order to somehow identify Λ with one of the attracting laminations of ϕ relative to \mathcal{A} . This work is done in Sections 3.2 and 3.3, applying work of Dowdall and Taylor [DT17, Section 3]; and then see Section 3.4 for a summary of applications to the theory of train track maps and attracting laminations.

The lower bound of Theorem A (Section 4). In Section 4 we prove the existence of the lower bound A > 0 of Theorem A: if $\phi \in \text{Out}(\Gamma; \mathcal{A})$ acts loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$ — and so, by Theorem B, ϕ has an attracting lamination Λ that fills relative to \mathcal{A} — then its translation length satisfies $\tau_{\phi} \geq A$.

Consider an EG-aperiodic train track representative $F: T \to T$ (with respect to some maximal, non-filling, ϕ -invariant \mathcal{F} rel \mathcal{A} , as explained just above), and so each generic leaf of the filling lamination Λ is represented in T as a nested union of iteration tiles of F. In Lemma 3.17 (2), by applying concepts of component free splitting units, we obtain a preliminary positive lower bound for τ_{ϕ} , one that is expressed as a simple formula with a uniform format depending only on Γ and \mathcal{A} , except for the occurrence of two numerical quantities that depend putatively on the choice of F: a *PF-exponent* κ ; and a *filling exponent* ω . The PF-exponent κ has the property that every entry of the transition matrix of F^{κ} is ≥ 4 , meaning that for any two edges $E, E' \subset T$, the tile $F^{\kappa}(E)$ crosses at least 4 different translates of the edge E'. The filling exponent ω has the property that for every edge E the tile $F^{\omega}(E)$ fills T.

The desired lower bound for Theorem A is therefore obtained if we can find a choice of representative F having a *uniform* PF exponent and a *uniform* filling exponent, independent of all choices. For this purpose we shall choose the train track representative $F: T \to T$ to be defined on a natural free splitting T. Such an F was constructed in [BH92] for the special case of $Out(F_n)$, and in [FM15] for the general case, using the Lipschitz semi-metric on the outer space of Γ rel \mathcal{A} . See Section 4.4 for details, including a further construction in the general case which mimics the special case construction of [BH92].

An elementary construction of a uniform PF-exponent $\kappa_0(\Gamma; \mathcal{A})$, for natural EG-aperiodic train track representatives of ϕ , is found in Section 4.2.

The heart of the proof is thus Proposition 4.4, proved in Section 4.3, which produces a uniform filling exponent $\omega_0 = \omega_0(\Gamma; \mathcal{A})$ for any EG-aperiodic train track representative $F: T \to T$ of ϕ (with respect to \mathcal{F}) defined on a natural free splitting T. The scheme of the proof is similar to that of the Strong Two Over All Theorem, where we studied the studied the evolution of filling support of paths under application of fold maps along a fold sequence. In Proposition 4.4, by contrast we study the evolution of filling support of paths under application of iterates of F^{κ_0} — namely, the filling supports $\mathcal{F}[\eta_m; T]$ of the sequence of paths $\eta_m = F^{m\kappa_0}(E)$, for any natural edge $E \subset T$. We first use the combinatorics of filling protoforests to prove that the sequence of free factor systems $\mathcal{F}[\eta_m; T]$ must increase strictly until, at some value m = Mhaving an upper bound $M \geq M_0$ depending only on Γ and \mathcal{A} , the sequence stabilizes, that is, $\mathcal{F}[\eta_M; T] = \mathcal{F}[\eta_{M+1}; T] = \mathcal{F}[\eta_{M+2}; T] = \cdots$. We then deduce that the stable value $\mathcal{F}[\eta_M; T]$ must be the full free factor system $[\Gamma]$, based on the fact that, up to translation, the tiles η_m may be nested so that their union is a generic leaf of the filling attracting lamination Λ . We thus obtain the uniform filing exponent $\omega_0 = M_0 \kappa_0$.

Remarks. The lower bound of Theorem A was inspired by an analogous result of Bowditch [Bow08] regarding the action of the mapping class group MCG(S) of a finite type surface S on its curve complex $\mathcal{C}(S)$. It was known from [MM99] that $\mathcal{C}(S)$ is Gromov hyperbolic and that the elements of MCG(S) acting loxodromically on $\mathcal{C}(S)$ are precisely the pseudo-Anosov mapping classes. Bowditch proved that the set of stable translation lengths τ_{ϕ} of pseudo-Anosov elements $\phi \in \mathsf{MCG}(S)$ acting on $\mathcal{C}(S)$ has a positive lower bound, and in fact he proved much more using an analysis of tight geodesics in $\mathcal{C}(S)$: there is an integer $M \geq 1$ depending only on the genus and number of punctures of S such that for each pseudo-Anosov $\phi \in MCG(S)$, its power ϕ^M has a bi-infinite geodesic axis in $\mathcal{C}(S)$ [Bow08, Theorem 1.4]; it follows that τ_{ϕ} is a positive rational number with denominator M.

Our methods in this work are somewhat softer than the methods of [Bow08], in that we use only quasigeodesics; we do not analyze geodesics in $\mathcal{FS}(\Gamma; \mathcal{A})$. This leads us to ask:

Question: Does there exist an integer $m = m(\Gamma; \mathcal{A}) \geq 1$ such that for each $\phi \in Out(\Gamma; \mathcal{A})$ having a filling lamination, the action of ϕ^m on $\mathcal{FS}(\Gamma; \mathcal{A})$ has a bi-infinite geodesic axis?

2 Filling paths and the Strong Two Over All Theorem

The Two Over All Theorem, in its "uniterated" form found in [HM22, Section 5.1], says the following. Consider a foldable map $f: S \to T$ between free splittings in $\mathcal{FS}(\Gamma; \mathcal{A})$. Assume, as a hypothesis, that the distance in $\mathcal{FS}(\Gamma; \mathcal{A})$ between S and T satisfies a certain lower bound $d_{\mathcal{FS}}(S,T) \geq \Delta = \Delta(\Gamma;\mathcal{A})$ depending as usual only on corank $(\Gamma;\mathcal{A})$ and $|\mathcal{A}|$. Under this assumption, there exist two natural edges $E_i \subset S$ (i = 1, 2) in distinct Γ orbits such for every natural edge $E' \subset T$ the path $f(E_i)$ crosses some translate $\gamma \cdot E'$ of E' $(\gamma \in \Gamma)$. For the precise definition of "crossing" see [HM22, Definition 2.20].

Question: The conclusions above control only how α crosses natural edges in T. Can one, in addition, also control how α crosses natural vertices of T?

An example. Suppose that T is a free splitting of Γ rel \mathcal{A} with a vertex v of valence 4 having trivial stabilizer. For example, with $\Gamma = F_2$ and $\mathcal{A} = \emptyset$ one can take T to be the universal cover of a rank 2 rose. Let e_1, e_2, e_3, e_4 denote the four oriented edges with initial vertex v, so in total there are six different turns at v; for example one could label the loops of the rose as a, b, and choose the labels so that e_1, e_3, e_2, e_4 are initial directions of lifts of a, \bar{a}, b and \bar{b} . Consider a path $\alpha \subset T$ and its collection of translates $\{g \cdot \alpha \mid g \in \Gamma\}$, and consider which of the six turns at v those paths take. Suppose that the only turns at v that are taken by these translates $g \cdot \alpha$ are the two turns $\{e_1, e_2\}$ and $\{e_3, e_4\}$; for example one could take α to be a lift of the path ab. Intuitively this path α fails to "fill" T in a certain visceral sense: there is an expansion $T \prec U$ in which the vertex $v \in \mathcal{V}(T)$ expands to an edge $E \in \mathcal{E}(U)$ with endpoints v', v'', such that the directions $\{e_1, e_2\}$ are attached to v' and $\{e_3, e_4\}$ are attached to v''; it follows that every translate in U of the natural lift $\tilde{\alpha} \subset U$ is disjoint from the interior of this expanded edge E. In our example, U would be the universal cover of a θ -graph expansion of the rank 2 rose, and the projection of $\tilde{\alpha} \subset U$ to the θ -graph would be a path that does not cross the expanded edge.

What is only hinted at in the above example, and what we will supply in Definition 2.2 below, is a definition of what it means for a finite path to *fill* a free splitting, which is then used to

formulate the *Strong Two Over All Theorem*. The proof of that theorem will take up the rest of Section 2.

2.1 Statement of the Strong Two Over All Theorem

2.1.1 Terminology review.

We assume that the reader is familiar with fundamental concepts regarding free factor systems, free splittings, relative free splitting complexes, and Stallings fold paths. The terminologies and notations that we use are laid out in [HM22], where one can also find more detailed references:

[HM22, Section 2.1] free factor systems, relative outer automorphism groups;

[HM22, Section 2.2] (2.2.1) graphs, the graph complement operator $G \setminus H$, maps of graphs (always assumed to be PL), paths in graphs (trivial and nontrivial); (2.2.2) trees and their paths, rays, and lines; (2.2.3) free splittings, natural vertices and edges, edgelets; (2.2.4) maps among free splittings, twisted equivariant maps, collapse maps; (2.2.5) relative free factor systems, relative free splittings, relative free factors, Kurosh rank; (2.2.6) relative free splitting complexes

[HM22, Section 2.3] foldable maps, foldable paths, folds, fold paths, Stallings fold theorem.

We quickly review a few highlights.

Free factor systems. A free factor system of Γ is a set of the form $\mathcal{A} = \{[A_1], \ldots, [A_I]\}$ (possibly empty, i.e. I = 0) such that there exists a free factorization $\Gamma = A_1 * \ldots * A_I * B$ where B is free of finite rank (possibly rank 0), each A_i is nontrivial $(1 \leq i \leq I)$, and [A] denotes the conjugacy class of A in Γ . The full free factor system, also known as the *improper* free factor system, is $\mathcal{A} = \{[\Gamma]\}$. We denote $|\mathcal{A}| = I$. We also denote corank $(\mathcal{A}) = \operatorname{rank}(B)$, which is welldefined independent of B, equal to the rank of the free group which is the quotient of Γ by the subgroup normally generated by $A_1 \cup \cdots \cup A_I$.

Inclusion of free factors induces a partial order $\mathcal{A} \sqsubset \mathcal{B}$ on the set of free factor systems of Γ . The natural action of $\operatorname{Out}(\Gamma)$ on free factor systems preserves this partial order, and the stabilizer of a free factor system \mathcal{A} under this action is a subgroup of $\operatorname{Out}(\Gamma)$ denoted $\operatorname{Out}(\Gamma; \mathcal{A})$. The preimage of $\operatorname{Out}(\Gamma; \mathcal{A})$ under the natural homomorphism $\operatorname{Aut}(\Gamma) \mapsto \operatorname{Out}(\Gamma)$ is denoted $\operatorname{Aut}(\Gamma; \mathcal{A})$, and it coincides with the subgroup of $\operatorname{Aut}(\Gamma)$ whose action on Γ that preserves the collection of subgroups $\{A \leq \Gamma \mid [A] \in \mathcal{A}\}$.

Given one free factor system \mathcal{A} of Γ , a *free factor system of* Γ *rel* \mathcal{A} is a free factor system \mathcal{F} such that $\mathcal{A} \sqsubset \mathcal{F}$. A *free factor* of Γ rel \mathcal{A} is a subgroup $F \leq \Gamma$ such that for some free factor system \mathcal{F} rel \mathcal{A} we have $[F] \in \mathcal{F}$; furthermore, we say that F and [F] are *atomic* if $[F] \in \mathcal{A}$, otherwise F and [F] are *nonatomic*. For any free factor F of Γ rel \mathcal{A} , the *restriction of* \mathcal{A} to Fis a free factor system of the group F denoted $\mathcal{A} \mid F$, consisting of the F-conjugacy classes of all free factors $A \leq F$ such that $[A] \in \mathcal{A}$; we note that the atomic/nonatomic dichotomy for F is equivalent to the filling/nonfilling dichotomy of the free factor system $\mathcal{A} \mid F$ in the group F. The action of $Out(\Gamma)$ on all free factor systems of Γ restricts to an action of $Out(\Gamma; \mathcal{A})$ on free factor systems rel \mathcal{A} .

Free splittings and their maps. A free splitting of Γ is a minimal simplicial action $\Gamma \curvearrowright S$ on a simplicial tree with finitely many vertex and edge orbits and with trivial edge stabilizers.

The given graph structure on S is a subdivision of the *natural* graph structure which has for its vertices those points having either nontrivial stabilizer or valence ≥ 3 . Sometimes the given graph structure on S is further subdivided, in which case we use the term *edgelets* to refer to the edges of the subdivided structure; proceeding from coarser to finer graph structures we thus have *natural edges*, which decompose into *edges*, and which further decompose into *edgelets*. A *nondegenerate subgraph* $\sigma \subset S$ is a proper, Γ -invariant subgraph with respect to some invariant subdivision of S, such that no component of σ is a point, equivalently σ is a union of edgelets of the subdivision; we allow σ to be empty. The "elliptic" free factor system $\mathcal{F}_{ell}S$ consists of the conjugacy classes of nontrivial vertex stabilizers for the action of Γ on S. To say that S is a *Grushko* free splitting of Γ relative to a free factor system \mathcal{A} of Γ means that $\mathcal{F}_{ell}S = \mathcal{A}$.

A map $f: S \to T$ of free splittings of Γ is Φ -twisted equivariant where $\Phi \in \operatorname{Aut}(\Gamma)$, if $f(\gamma \cdot x) = \Phi(\gamma) \cdot f(x)$ for all $x \in S, \gamma \in \Gamma$; and f is equivariant if this holds with $\Phi = \operatorname{Id}$. All maps f of free splittings are assumed to be equivariant, unless twisted equivariance is explicitly stated; and in either case f is always assumed to be PL. Equivalence of free splittings is defined by existence of an equivariant PL homeomorphism. In this section we will use a formal notation [S] for the equivalence class of S; later on we usually abuse notation and let S stand for its own equivalence class. The group $\operatorname{Out}(\Gamma)$ acts from the right on equivalence classes, with $[S] = [T] \cdot \phi$ if and only if there exists a Φ -twisted equivariant PL homeomorphism $f: S \to T$ for some $\Phi \in \operatorname{Aut}(\Gamma)$ representing $\phi \in \operatorname{Out}(\Gamma)$.

The notation $f: S \xrightarrow{\langle \sigma \rangle} T$ represents a *collapse map* with *collapse forest* σ , meaning that $\sigma \subset S$ is a subgraph of S, and f is a quotient map that collapses each component of σ to a point. The collapse map f is *trivial* if and only if σ does not contain any natural edge of S, which occurs if and only if S and T are equivalent free splittings. In general the existence of a collapse map $S \mapsto T$ defines a well-defined partial order $[S] \succ [T]$ on the set of equivalence classes of free splittings of Γ , and two free splittings S and T are equivalent if and only if $[S] \succ [T] \succ [S]$. This collapse partial order is respected by the action of $Out(\Gamma)$ on equivalence classes of free splittings.

Given a free splitting S of Γ and a Γ -invariant subforest $\sigma \subset S$, as s varies over the components of $\sigma \cup \mathcal{V}(S)$ for which the stabilizer subgroup $\operatorname{Stab}(s)$ is nontrivial, the conjugacy classes of those subgroups form a free factor system of Γ denoted $\mathcal{F}[\sigma]$; furthermore, under the associated collapse map $S \xrightarrow{\langle \sigma \rangle} T$ we have $\mathcal{F}_{ell}S \sqsubset \mathcal{F}[\sigma] = \mathcal{F}_{ell}T$ (see [HM22, Lemma 2.3 and Definition 2.4]). A free factor system \mathcal{F} of Γ is said to be *visible* in a free splitting S if $\mathcal{F} = \mathcal{F}[\sigma]$ for some Γ -invariant subforest $\sigma \subset S$ [HM22, Definition 2.5]; if \mathcal{F} is visible in S then $\mathcal{F}_{ell}S \sqsubset \mathcal{F}$. For any nested pair of free factor systems $\mathcal{A} \sqsubset \mathcal{B}$ there exists a Grushko free splitting S of Γ rel \mathcal{A} in which \mathcal{B} is visible [HM14, Lemma 3.1].

The free splitting complex. Consider a free factor system \mathcal{A} of Γ . For any free splitting T of Γ , to say that T is a free splitting relative \mathcal{A} means that $\mathcal{A} \sqsubset \mathcal{F}_{ell} T$, i.e. for every subgroup $A \leq \Gamma$ such that $[A] \in \mathcal{A}$, the restricted action of A on T fixes a vertex. The free splitting complex of Γ rel \mathcal{A} is the ordered simplicial complex that is associated to the collapse partial order on equivalence classes of free splittings rel \mathcal{A} . The action $\operatorname{Out}(\Gamma; \mathcal{A}) \curvearrowright \mathcal{FS}(\Gamma; \mathcal{A})$ is induced by the action of $\operatorname{Out}(\Gamma)$ on the collapse partial order.

Foldable maps and fold sequences. A *foldable* map $f: S \to T$ is an equivariant map of free splittings such that every point of S is contained in the interior of some embedded arc $\alpha \subset S$ for which the restriction $f \mid \alpha$ is injective. If this holds then, furthermore, f is a *fold* if it is defined by identifying initial segments of a pair of oriented natural edges having a common initial

vertex. If f is a fold map between free splittings of Γ rel \mathcal{A} then in $\mathcal{FS}(\Gamma; \mathcal{A})$ we have a distance bound $d_{\mathcal{FS}}([S], [T]) \leq 2$.

Consider a sequence of maps of the form $\cdots \xrightarrow{f_i} T_i \xrightarrow{f_{i+1}} \cdots \xrightarrow{f_j} T_j \xrightarrow{f_{j+1}} \cdots$ with compositions denoted in "index contraction" notation $f_j^i = f_j \circ \cdots \circ f_{i+1} \colon T_i \to T_j$ whenever i < j. To say this is a *foldable sequence* means that every f_j^i is foldable; and if so then furthermore it is a *fold* sequence if each f_i is a fold map. We often regard a fold sequence as a path in $\mathcal{FS}(\Gamma; \mathcal{A})$, where each step of that path consists of an edge path of length ≤ 2 .

Notational convention: In what follows we use the notation $[I, \ldots, J]$ for the *integer interval* with endpoints $I, J \in \mathbb{Z}$: if $I \leq J$ then $[I, \ldots, J] = \{i \in \mathbb{Z} \mid I \leq i \leq J\}$; and in general $[I, \ldots, J] = [J, \ldots, I]$. For example, $[I, \ldots, J]$ will be commonly used as an index set for a fold subpath $T_I \xrightarrow{f_{i+1}} \cdots \xrightarrow{f_J} T_J$ of a fold path as denoted in the previous paragraph.

2.1.2 Filling paths

Recall from [HM22, Section 2.1] that *paths* in a free splitting can be either nontrivial or trivial: a *nontrivial path* is a concatenation of one or more edges without backtracking; and a *trivial path* takes constant value at a single vertex. The unadorned terminology *path* refers to both nontrivial and trivial paths, but beware that when the "nontriviality" qualifier is clear from the context we will sometimes drop it, as in the titles of the next couple of definitions.

Definition 2.1 (Lifting paths through collapse maps). Consider two free splittings U, T of Γ relative to \mathcal{A} and a collapse map $\pi: U \xrightarrow{\langle \sigma \rangle} T$. After choosing subdivisions of U and T with respect to which σ is a subcomplex and π is simplicial, the projection map π induces a bijection denoted $\tilde{\alpha} \leftrightarrow \alpha = \pi(\tilde{\alpha})$ between the set of nontrivial edgelet paths $\tilde{\alpha} \subset U$ that begin and end with edgelets of $U \setminus \sigma$ and the set of nontrivial edgelet paths in T. We refer to $\tilde{\alpha}$ as the *lift* of α to U. Note that $\tilde{\alpha}$ is well-defined independent of the choice of subdivision: as a subset of U, it is the unique compact arc in U that projects onto α and that begins and ends with segments of $U \setminus \sigma$.

Definition 2.2 (Interior Crossings, and Filling Paths). Consider a free splitting T and a path $\alpha \subset T$. Given another path $\eta \subset T$, to say that α has an interior crossing of the orbit of η means that there exists $\gamma \in \Gamma$ such that the interior of α contains $\gamma \cdot \eta$, equivalently there exists $\delta \in \Gamma$ such that the interior of α contains $\gamma \cdot \eta$, equivalently there exists $\delta \in \Gamma$ such that the interior of $\delta \cdot \alpha$ contains η . To say that α is a filling path in T, or more briefly that α fills T, means that for every free splitting U, every simplicial collapse map $\pi \colon U \to T$, and every natural edge $E \subset U$, the lifted path $\tilde{\alpha} \subset U$ has an interior crossing of some natural edge in the orbit of E.

An invariance principle for filling paths. Filling paths are invariant under an equivariant homeomorphism of free splittings $f: S \to T$, meaning that a given path $\alpha \subset S$ fills S if and only if $f(\alpha)$ fills T: for every collapse map $U \to S$, its composition with f is a collapse map and the respective lifts of α and $f(\alpha)$ are identical in U; and similarly for every collapse map $V \to S$.

An example. Notice that if α fills T then α has an interior crossing of every natural edge E of T, otherwise U = T itself witnesses that α does not fill T. But a simple counterexample shows that the converse fails. Let U be the Cayley tree of the rank 2 free group $\langle a, b \rangle$, let $\tilde{\alpha} \subset U$ be a path consisting of three consecutive edges labelled a, and let T be obtained from U by collapsing

each b edge. The path $\tilde{\alpha} \subset U$ is the lift of a path $\alpha \subset T$ that has an interior crossing of the unique natural edge orbit of T, but U witnesses that α does not fill T.

The concept of tiles. This concept was introduced into relative train track theory in [BFH00] as a tool for constructing and applying attracting laminations (see also [HM22, Section 4.3.2]). In that context, the tiles of a relative train track map $f: G \to G$ are the (nonbacktracking) edge paths of the form $f_{\#}^k(E)$ where $E \subset G$ is an edge in a marked graph and $f_{\#}^k(E)$ is the path obtained by straightening the (possibly backtracking) edge path $f^k \mid E$.

In Part II of this work [HM22], in addition to tiles of relative train tracks, we used a more general concept of tiles of foldable maps in the *Two Over All Theorem*. The very rough idea here is to think of a tile in a free splitting T as a path which is determined by data in some far distant free splitting S, and which serves as a record in T of some modicum of information about the relation between S and T. In order to formulate, prove, and apply the *Strong Two Over All Theorem*, we now refine and formalize the concept of tiles used in [HM22].

Definition 2.3 (Tiles). Consider a foldable map $f: S \to T$. A natural f-tile in T is a path of the form f(E) where $E \subset S$ is a natural edge; an f-tile in T is a path of the form f(e) where $e \subset S$ is an edge. The "natural" qualifier may be dropped where it is understood. Also, the notation "f" may be replaced by other notations which, in context, have the effect of determining the map f; see for example "iteration tiles" in Section 3.4.

Combining Definitions 2.2 and 2.3 one obtains the concept of a *filling tile* which will play a prominent role in the statement, proof, and application of *Strong Two Over All Theorem*.

2.1.3 The statement: noniterated and iterated forms

Just as with the *Two Over All Theorem* (see [HM22, Section 5.1]), the *Strong Two Over All Theorem* comes in iterated and noniterated forms, and the latter implies the former as we shall immediately show.

Theorem 2.4 (Strong Two Over All Theorem (noniterated form)). For any group Γ and any free factor system \mathcal{A} there exists a constant $\Theta = \Theta(\Gamma; \mathcal{A})$ such that for any foldable map $f: S \to T$ of free splittings of Γ rel \mathcal{A} , if $d(S,T) \geq \Theta$ then there exist two natural edges $E_i \subset S$ (i = 1, 2) in different orbits such that each of the natural f-tiles $f(E_i) \subset T$ is a filling path.

Theorem 2.5 (Strong Two Over All Theorem (iterated form)). For any Γ and A as above, using the same value of Θ , and for any integer $N \ge 1$, if $d(S,T) \ge N\Theta$ then there exist two natural edges $E_i \subset S$ in different orbits such that each of the natural f tiles $f(E_i) \subset T$ contains 2^{N-1} nonoverlapping filling paths.

Proof of the iterated form, assuming the noniterated form. The basis step N = 1 follows immediately from the noniterated form of the theorem.

Assume by induction that the theorem holds for N, and suppose that $d(S,T) \ge (N+1)\Theta$. Choose a Stallings fold factorization of f in which each fold map has distance ≤ 1 [HM22, Theorem 2.17]. Along that fold path there exists a term U such that $d(S,U) = \Theta$. It follows that $d(U,T) \ge N\Theta$, and we have a foldable factorization of f of the form

$$S \xrightarrow{g} U \xrightarrow{h} T$$

Applying the induction hypothesis to h we obtain natural edges $E'_1, E'_2 \subset U$ in distinct orbits such that for each j = 1, 2 the path $h(E'_j)$ contains 2^{N-1} nonoverlapping filling paths. Applying the noniterated form to g we obtain natural edges $E_1, E_2 \subset S$ in distinct orbits such that for each i = 1, 2 the path $g(E_i) \subset U$ is filling, and therefore for each j = 1, 2 the path $g(E_i)$ contains some translate $\gamma_{ij} \cdot E'_j$ of $E'_j, \gamma_{ij} \in \Gamma$. Noting that $\gamma_{i1} \cdot E'_1$ and $\gamma_{i2} \cdot E'_2$ are natural edges in distinct orbits, they do not overlap. Since the factorization above is foldable, the map h is injective on $g(E_i)$. The path $f(E_i) = h \circ g(E_i)$ therefore contains two nonoverlapping paths $h(\gamma_{i1} \cdot E'_1)$ and $h(\gamma_{i2} \cdot E'_2)$, each of which contains 2^{N-1} nonoverlapping filling paths. It follows that $f(E_i)$ contains 2^N nonoverlapping filling paths.

2.2 A filling criterion for paths, expressed using protoforests

Given a free splitting T and a path $\alpha \subset T$, in order to directly verify whether α fills T according to Definition 2.2 one must search over all expansions of T. In this section we give a more intrinsic description of what it means for α to fill T, expressed without reference to any expansion of T. To motivate that description, consider $\beta(\alpha; T) = \bigcup_{q \in \Gamma} g \cdot \alpha$, called the *covering forest* in T associated to α ; see [HM22, Definition 5.6]. In the proof of Step 1 of the original Two Over All Theorem, carried out in [HM22, Section 5.4], covering forests $\beta(\alpha; T)$ played the starring role, with guest star being the free factor system $\mathcal{F}[\beta(\alpha;T)]$ formed from the stabilizers of the components of $\beta(\alpha; T)$ (see [HM22, Definition 2.4]). By studying how the translates $g \cdot \alpha$ of the path α overlap with each other in T, we shall describe the overlap protoforest of α in T, a kind of refinement of the covering forest $\beta(\alpha; T)$ that we denote $\beta^{\circ}(\alpha; T)$. From the overlap protoforest we obtain (somewhat indirectly) a free factor system rel \mathcal{A} called the filling support $\mathcal{F}[\beta^{\circ}(\alpha;T)]$, which again is a refinement of $\mathcal{F}[\beta(\alpha;T)]$ in the sense of the nesting relation on free factor systems $\mathcal{F}[\beta^{\circ}(\alpha;T)] \sqsubset \mathcal{F}[\beta(\alpha;T)]$, and the nesting might be strict. Proposition 2.9 states our criterion for α to fill T, one condition for which is that the free factor system $\mathcal{F}[\beta^{\circ}(\alpha;T)]$ must be *full*, i.e. it must equal $\{[\Gamma]\}$. The proof of that proposition will follow in Section 2.3, and its application to the Strong Two Over All Theorem is found in Section 2.4.

Definition 2.6 (Protoforests in a free splitting). Consider a tree T and two subtrees $b, b' \subset T$ (with respect to the given simplicial structure on T). To say that b and b' overlap means that their intersection $b \cap b'$ contains an edge of T; since b, b' are subtrees, it follows that b, b' do not overlap if and only if their intersection $b \cap b'$ is a single point or empty. A protoforest in T is a set δ of subtrees of T called the protocomponents of δ , such that no two distinct protocomponents overlap, and such that the collection of protocomponents is Γ -invariant in the sense that the image under any $g \in \Gamma$ of any protocomponent of δ is also a protocomponent of δ . The partial order $\beta \prec \delta$ on protoforests in T is defined by requiring that every protocomponent of β is a subset of some protocomponent of δ .

Remarks. We have built Γ -invariance into the definition of protoforests. We did *not* do that with ordinary subforests, of which there are many important non-invariant examples.

The concept of a *protoforest* is very close to the concept of a *transverse covering* which occurs in Guirardel's work [Gui04] in the broader setting of group actions on \mathbf{R} -trees.

An ordinary Γ -invariant forest is the same thing as a protoforest whose protocomponents are the same as its path components, for example $\beta(\alpha; T)$. We shall focus on two other special types of protoforests which are refinements of $\beta(\alpha; T)$: the "overlap protoforest" $\beta^{\circ}(\alpha; T)$; and the "filling protoforest" $\beta^{f}(\alpha; T)$. See Definitions 2.7 and 2.12, and see also the *Protoforest Summary* just below Definition 2.12.

Definition 2.7 (The overlap protoforest of a path in a free splitting). Consider a free splitting T of Γ rel \mathcal{A} , and a path $\alpha \subset T$ with corresponding covering forest $\beta(\alpha) = \beta(\alpha; T) = \bigcup_g g \cdot \alpha$. For each $g \in \Gamma$ we let $\beta_g(\alpha)$ denote the connected component of $\beta(\alpha)$ containing $g \cdot \alpha$. An α -connection is a sequence of paths of the form

$$g_0 \cdot \alpha, \quad g_1 \cdot \alpha, \quad \dots, \quad g_K \cdot \alpha \quad (g_0, g_1, \dots, g_K \in \Gamma)$$

such that any two consecutive terms $g_{k-1} \cdot \alpha$, $g_k \cdot \alpha$ overlap $(1 \leq k \leq K)$. If furthermore we are given edges $e, e' \subset T$ such that $e \subset g_0(\alpha)$ and $e' \subset g_K(\alpha)$ then we say this sequence is an α -connection from e to e'. Also, given a subgraph $b \subset \beta(\alpha)$, we say that this sequence is an α -connection in the subgraph b if $g_k \cdot \alpha \subset b$ for $0 \leq k \leq K$.

To say that a subgraph $b \subset \beta(\alpha)$ is α -connected means that there exists an α -connection in b from any edge of b to any other edge of b. Clearly every α -connected subgraph of $\beta(\alpha)$ is connected, i.e. it is a subtree. Also, if $b, b' \subset \beta(\alpha)$ are two α -connected subgraphs, and if boverlaps b', then $b \cup b'$ is clearly α -connected. It follows that the invariant forest $\beta(\alpha)$ has a unique decomposition into maximal α -connected subgraphs, each of which is a tree, no two of which overlap, and this decomposition is Γ -invariant. This collection of subgraphs therefore gives the covering forest $\beta(\alpha)$ the structure of a protoforest, which we call the overlap protoforest of α in T, denoted $\beta^{\circ}(\alpha; T)$. For each $g \in \Gamma$, the protocomponent of $\beta^{\circ}(\alpha; T)$ that contains $g \cdot \alpha$ is denoted $\beta^{\circ}_{g}(\alpha; T)$, and clearly $\beta^{\circ}_{g}(\alpha; T) \subset \beta_{g}(\alpha; T)$. When T and/or α are understood we often simplify the notation by writing $\beta^{\circ}(\alpha)$ or just β° , and by writing $\beta^{\circ}_{g}(\alpha)$ or just β°_{g} .

Since Γ acts transitively on the set $\{g \cdot \alpha\}$ we clearly obtain the following consequences of Definition 2.7:

Protocomponent Transitivity: Γ acts transitively on the protocomponents of $\beta^{\circ}(\alpha)$.

Protocomponent Stabilizers: The set of protocomponent stabilizers of Γ acting on $\beta^{\circ}(\alpha)$ is the conjugacy class of the subgroup $\operatorname{Stab}(\beta^{\circ}_{\operatorname{Id}}(\alpha))$.

Note that $\operatorname{Stab}(\beta^{o}_{\operatorname{Id}}(\alpha))$ need not be a free factor of Γ rel \mathcal{A} ; see "A new example" below.

Definition 2.8 (The filling support of a path in a free splitting). Continuing with the notation of Definition 2.7, we define a free factor rel \mathcal{A} denoted $F(\alpha)$, defined to be the unique minimal free factor of Γ rel \mathcal{A} containing the subgroup $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\alpha))$. The *(Kurosh) filling rank* of α is defined to be the Kurosh rank of the free factor $F_{\min}(\alpha)$ relative to \mathcal{A} , an integer denoted $\operatorname{KR}(\alpha) = \operatorname{KR}(F_{\min}(\alpha)) \geq 0$ [HM22, Definition 2.8]. Let $\mathcal{F}[\alpha]$ denote the unique smallest free factor system of Γ rel \mathcal{A} which carries the free factor $F_{\min}(\alpha)$. It follows that one of three cases holds (see the final sentence of [HM22, Definition 2.8]):

- (1) $F_{\min}(\alpha)$ is trivial, equivalently $KR(\alpha) = 0$; it follows that $\mathcal{F}[\alpha] = \mathcal{A}$.
- (2) $F_{\min}(\alpha)$ is atomic, equivalently $[F_{\min}(\alpha)] \in \mathcal{A}$; it follows that $KR(\alpha) = 1$ and $\mathcal{F}[\alpha] = \mathcal{A}$.
- (3) $F_{\min}(\alpha)$ is nontrivial and nonatomic, equivalently $\operatorname{KR}(\alpha) > 0$ and $[F_{\min}(\alpha)] \notin \mathcal{A}$. It follows that $\mathcal{F}[\alpha] \neq \mathcal{A}$; and furthermore there is a decomposition $\mathcal{A} = \mathcal{A}_{F_{\min}(\alpha)} \sqcup \overline{\mathcal{A}}_{F_{\min}(\alpha)}$ such that $\mathcal{F}[\alpha] = \{[F_{\min}(\alpha)]\} \cup \overline{\mathcal{A}}_{F_{\min}(\alpha)}$.

In particular $F_{\min}(\alpha)$ determines $\mathcal{F}[\alpha]$, and furthermore $\mathcal{F}[\alpha]$ determines $F_{\min}(\alpha)$ up to conjugacy *except* in the case that $\mathcal{F}[\alpha] = \mathcal{A}$: in that case, $F_{\min}(\alpha)$ can be either trivial or atomic. Despite this ambiguity we will refer to either the free factor $F_{\min}(\alpha)$ or the free factor system $\mathcal{F}[\alpha]$ as the *filling support* of α ; in context the exact referent should be clear.

We sometimes use the notation $\mathcal{F}[\alpha; T]$ to highlight the dependence on the free splitting T that contains α . Also, we note that $\mathcal{F}[\alpha]$ is determined by the connected subgraph $\beta_{\mathrm{Id}}^{\mathrm{o}}(\alpha)$, in that it is the unique smallest free factor system that "carries" the subgroup $\mathrm{Stab}(\beta_{\mathrm{Id}}^{\mathrm{o}}(\alpha))$. For this reason we sometimes denote $\mathcal{F}[\alpha] = \mathcal{F}[\beta^{\mathrm{o}}(\alpha; T)]$ and $\mathrm{KR}(\alpha) = \mathrm{KR}(\beta^{\mathrm{o}}(\alpha; T))$.

Remark. In the statement of Definition 2.8, Case (1) holds if and only if $\beta_{\mathrm{Id}}^{\circ}(\alpha) = \alpha$ if and only if for all $g \neq h \in \Gamma$ the translated paths $g \cdot \alpha$ and $h \cdot \alpha$ do not overlap; in this case the protocomponents of $\beta^{\circ}(\alpha)$ are precisely the translates of α . Also, Case (2) holds if and only if there exists a vertex $V \in \beta_{\mathrm{Id}}^{\circ}(\alpha)$ such that $\mathrm{Stab}(\beta_{\mathrm{Id}}^{\circ}(\alpha)) = \mathrm{Stab}(V)$ and $[\mathrm{Stab}(V)] \in \mathcal{A}$; it follows in this case that $V \in \alpha$, and that $\beta_{\mathrm{Id}}^{\circ}(\alpha) = \bigcup_{g \in \mathrm{Stab}(V)} g \cdot \alpha$.

A continued example. In the example we gave preceding the statement of Theorem 2.4, the protocomponents of $\beta_{\mathrm{Id}}^{\mathrm{o}}(\alpha)$ are the axes in T of the infinite cyclic free factor $\langle a \rangle$ of $\Gamma = \langle a, b \rangle$, and so the filling support is $\mathcal{F}[\alpha; T] = \{ [\langle a \rangle] \}$ which is a nonfull free factor system, despite the fact that the path $\alpha \subset T$ does indeed have an interior crossing of a translate of every natural edge orbit of T: the tree T has only one natural edge orbit, and α crosses three different natural edges of that orbit, the middle one of those three being an interior crossing.

A new example. This example shows that the subgroup $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\alpha))$ need not be a free factor of Γ rel \mathcal{A} , in contrast to the fact that the stabilizer of every component of the Γ -invariant subforest $\beta(\alpha) \subset T$ is a free factor of Γ rel \mathcal{A} . Consider the rank 4 free group $\Gamma = \langle a, b, c, d \rangle$. Let G be a marked graph with two vertices p, q, with the $\langle a, b \rangle$ rose attached to p, the $\langle c, d \rangle$ rose attached to q, and an edge e from p to q; we identify $\pi_1(G, p) \approx \langle a, b \rangle * \langle c, d \rangle \approx \langle a, b, c, d \rangle$ by using e as a maximal subtree of G. Let $U = \widetilde{G}$ be the universal covering with edge labels lifted from G. Choosing a lift $\widetilde{p} \in U$ of p determines the deck transformation action $\Gamma \curvearrowright U$. Let $\widetilde{\alpha} \subset U$ be the path with initial vertex \widetilde{p} that is labelled by the word $e c d \overline{c} d \overline{c} a b \overline{a} \overline{b} e$. Note that $\widetilde{\alpha}$ is contained in the U-axis of the infinite cyclic subgroup

$$C = \langle c \, d \, c^{-1} \, d^{-1} \, a \, b \, a^{-1} \, b^{-1} \rangle < \langle a, b, c, d \rangle$$

Also, $\tilde{\alpha}$ consists of one entire fundamental domain for the action of C on its U-axis, followed by the first e edge of the next fundamental domain. Let T be the free splitting obtained from Uby collapsing all edges labelled a, b, c, d, so T has a single natural edge orbit, represented by the T-image of any e-edge of U. Let $\alpha \subset T$ be the image of $\tilde{\alpha}$. Note that α crosses the unique natural edge orbit three times, the middle crossing being an interior crossing. Again α is contained in the axis of C in T, and α consists of one entire fundamental domain of that axis followed by the first edge of the next fundamental domain. Note that no two distinct translates of the axis of C in T, and that $C = \text{Stab}(\beta_{\text{Id}}^{\text{o}}(\alpha))$. But C has trivial image under abelianization of $\langle a, b, c, d \rangle$ and hence C is not a free factor of $\langle a, b, c, d \rangle$. In fact we have the equation $\mathcal{F}[\alpha; T] = \{[\langle a, b, c, d \rangle]\}$, in other words C fills the group $\langle a, b, c, d \rangle$, and hence α fills T by Proposition 2.9.

The fact that C fills $\langle a, b, c, d \rangle$ can be proved using a beautiful transversality argument that we learned from a paper of Stallings [Sta00]. Here are some details of this argument. Consider S

a compact orientable surface of genus 2 with 1 boundary component C. There is an embedding $G \hookrightarrow S$ and a deformation retraction $\rho: S \mapsto G$ such that $\rho(C)$ is the loop $aba^{-1}b^{-1}cdc^{-1}d^{-1}$. Arguing by contradiction, if C did not fill $\langle a, b, c, d \rangle$ then there would exist a homotopy equivalence $h: G \to H$ to a connected graph H such that h(C) is a circuit contained in a proper subgraph of H, thus missing the midpoint $m \in E$ of some edge $E \subset H$. After perturbing h to be transverse to m, it follows that $h^{-1}(m)$ is disjoint union of simple closed curves in the interior S. But h is a homotopy equivalence and the image of each of these curves is the point m, hence each such curve bounds a disc in S. We can then homotope h to remove these curves one-at-a-time, obtaining a homotopy equivalence $S \to H$ that misses m entirely. But this implies that $\langle a, b, c, d \rangle \approx \pi_1(S) \approx \pi_1(H)$ is contained in a proper free factor of itself, which is absurd.

We now state our combinatorial criterion for a path to fill a free splitting:

Proposition 2.9. For each free splitting T of Γ rel A and each path $\alpha \subset T$, the path α fills T if and only if the following holds:

The Filling Criterion:

- (1) α has an interior crossing of the orbit of every natural edge of T
- (2) $F_{\min}(\alpha) = \Gamma$, which holds if and only if $\mathcal{F}[\alpha; T] = \{[\Gamma]\}, \text{ which holds if and only if }$

 $\operatorname{KR}(\alpha) = \operatorname{KR}(\Gamma; \mathcal{A}) \ (= |\mathcal{A}| + \operatorname{corank}(\mathcal{A}))$

(see [HM22, Definition 2.8 and Lemma 2.9]).

A counterexample. Condition (1) of Proposition 2.9 is necessary for α to fill T, because if there is a natural edge $e \subset T$ such that α has no interior crossing of e then the trivial expansion of T, namely U = T, witnesses that α does not fill T. But one might wonder whether Condition (1) follows from Condition (2), in which case the statement of Proposition 2.9 could be simplified by eliminating any mention of Condition (1). Here is an example to dispel that wonder, in which α does *not* have an interior crossing of the orbit of every natural edge of T, and yet $F_{\min}(\alpha) = \Gamma$. Let T be the Cayley tree of $\langle a, b \rangle$. Equivariantly subdivide each a edge into three subedges $a = a_1 a_2 a_3$. Let $\alpha \subset T$ be a path labelled $a_2 a_3 b b a_1 a_2$, and note that α has no interior crossing of any natural edge of T labelled a. To prove $F_{\min}(\alpha) = \Gamma$ it suffices to show that the overlap protoforest $\beta^{\circ}(\alpha)$ has just one protocomponent, namely the entire tree T. Note first that each path in T labelled bb is contained in a single protocomponent of $\beta^{\circ}(\alpha)$, and hence each b-axis is contained in a single protocomponent. Note next that each path labelled $b a_1 a_2 a_3 b$ is contained in a single protocomponent of $\beta^{\circ}(\alpha)$, because its initial $b a_1 a_2$ subpath is a terminal subpath on one translate of α , its terminal $a_2 a_3 b$ subpath is an initial subpath of another translate of α , and those two subpaths share their a_2 edge. The unique protocomponent of $\beta^{\circ}(\alpha)$ is therefore T.

2.3 Proof of the filling criterion

In this section we prove the *Filling Criterion*, Proposition 2.9. The "if" direction is proved in Section 2.3.1.

The "only if" direction requires considerably more work. Section 2.3.2 covers some preliminary work, defining the *filling protoforest* $\beta^{f}(\alpha; T)$ of a path α in a free splitting T of Γ rel \mathcal{A} , whose protocomponent stabilizers realize the free factor system $\mathcal{F}[\alpha; T]$, and which sits between the overlap protoforest $\beta^{\circ}(\alpha)$ and the covering forest $\beta(\alpha)$ with respect to the partial order \prec . Section 2.3.3 reduces the "only if" direction to the *Protoforest Blowup Lemma* 2.13, which gives criteria under which a protoforest in T can be "lifted" to a forest in some expansion of T; the reduction is carried out by verifying that the filling protoforest $\beta^{f}(\alpha; T)$ satisfies those criteria. Section 2.3.4 contains a proof of *Protoforest Blowup Lemma*.

2.3.1 Proof of the "if" direction.

Assuming that condition (1) of Proposition 2.9 holds, but that the path α fills T, we shall prove that condition (2) does not hold. We start by deriving a consequence of condition (1).

Lemma 2.10. Consider a free splitting T and a path $\alpha \subset T$ that has an interior crossing of a translate of every natural edge of T. For any expansion $T \prec U$ with lifted path $\tilde{\alpha} \subset U$ the following holds: for every natural edge E of U, either $\tilde{\alpha}$ has an interior crossing of a translate of E, or $\tilde{\alpha}$ is disjoint from the orbit of the interior of E. It follows that the covering forest $\beta(\tilde{\alpha}; U) = \bigcup_{\alpha \in \Gamma} g \cdot \tilde{\alpha}$ is a natural (invariant) subforest of U.

Proof. Denote the collapse map $q: U \xrightarrow{\langle v \rangle} T$. Let e', e'' denote the first and last edges of $\tilde{\alpha}$, both of which are in $U \setminus v$. We prove the lemma in two cases.

Case 1: $E \not\subset v$. The image $q(E) \subset T$ is a natural edge of T and so there exists $g \in \Gamma$ such that $g \cdot \alpha$ has an interior crossing of q(E). We may decompose E as a concatenation $E = \zeta \eta \theta$ so that ζ, θ are the (possibly trivial) maximal prefix and suffix of E that are contained in v, and η is the (nontrivial) maximal subpath of E that begins and ends with edges of $U \setminus v$. Using that q(E) is contained in the interior of $g \cdot \alpha$, it follows that η is contained in the interior of $g \cdot \alpha$, and that $g \cdot e' \not\subset \eta$ and $g \cdot e'' \not\subset \eta$. Since $g \cdot e'$ and $g \cdot e''$ are the first and last edges of $g \cdot \tilde{\alpha}$, and since $g \cdot e' \not\subset \zeta \cup \theta$ and $g \cdot e'' \not\subset \zeta \cup \theta$, it follows that E is contained in the interior of $g \cdot \tilde{\alpha}$.

Case 2: $E \subset v$. If the interior of E is disjoint from the orbit of $\tilde{\alpha}$ then we are done. Otherwise, for some $g \in \Gamma$ the intersection $E \cap g \cdot \tilde{\alpha}$ contains some edge of U. Again $g \cdot e'$ and $g \cdot e''$ are the first and last edges in $g \cdot \tilde{\alpha}$, and neither is contained in v, hence neither is contained in E. It follows that E is contained in the interior of $g \cdot \tilde{\alpha}$.

Continuing now with the proof of the "if" direction, assuming that α does have an interior crossing of a translate of every natural edge orbit of T but that α does not fill T, we must prove that the free factor system $\mathcal{F}[\alpha;T]$ is not full. Using that α does not fill T, choose a free splitting and collapse map $q: U \xrightarrow{\langle v \rangle} T$, and a natural edge $E \subset U$, such that the $\tilde{\alpha} \subset U$ does not have an interior crossing of the orbit of E. Applying Lemma 2.10, the interior of E is disjoint from $\beta(\tilde{\alpha};U)$.

We may assume that q restricts to a simplicial isomorphism $\tilde{\alpha} \mapsto \alpha$, equivalently the invariant forests v and $\Gamma \cdot \tilde{\alpha}$ are edge disjoint. To justify making this assumption, we can factor q as

$$U \xrightarrow{\langle v \cap \Gamma \cdot \tilde{\alpha} \rangle} U' \xrightarrow{q'} T$$

Letting $\tilde{\alpha}' \subset U'$ be the lift of α , and so $\tilde{\alpha}$ is the lift of $\tilde{\alpha}'$, it follows that $\beta(\tilde{\alpha}'; U')$ is disjoint from the interior of the natural edge $E' \subset U'$ that is the image of E, and that the collapse map $q': U' \mapsto T$ is injective on $\tilde{\alpha}'$, and hence q' restricts to a simplicial isomorphism $\tilde{\alpha}' \to \alpha$. Replacing U by U' completes the justification. Since q restricts to a simplicial isomorphism $\tilde{\alpha} \mapsto \alpha$, also q restricts to a simplicial isomorphism $g \cdot \tilde{\alpha} \mapsto g \cdot \alpha$ for each $g \in \Gamma$. Also, since the collapse map q takes the edges of $U \setminus v$ bijectively to T, and since v is edge disjoint from $\Gamma \cdot \tilde{\alpha}$, it follows that q induces a bijection from the edges of $\beta(\tilde{\alpha}; U) = \Gamma \cdot \tilde{\alpha}$ to the edges of $\beta(\alpha; T) = \Gamma \cdot \alpha$. As a consequence, for any two edges $\tilde{e}, \tilde{e}' \subset \beta(\tilde{\alpha}; U)$ with images $e, e' \subset \beta(\alpha; T)$, each $\tilde{\alpha}$ connection from \tilde{e} to \tilde{e}' in $\beta(\tilde{\alpha}; U)$ maps to an α connection from e to e' in $\beta(\alpha; T)$, and conversely each α connection from e to e' in $\beta(\alpha; T)$ lifts to a $\tilde{\alpha}$ connection from \tilde{e} to \tilde{e}' in $\beta(\tilde{\alpha}; U)$. From this it follows that q induces a Γ -equivariant bijective correspondence between protocomponents of $\beta^{\circ}(\tilde{\alpha}; U)$ and protocomponents of $\beta^{\circ}(\alpha; T)$, restricting to a simplicial isomorphism between corresponding protocomponents. The protocomponent stabilizers of $\beta^{\circ}(\tilde{\alpha}; U)$ and of $\beta^{\circ}(\alpha; T)$ are therefore identical, and hence $\mathcal{F}[\tilde{\alpha}; U] = \mathcal{F}[\alpha; T]$. But $\beta_{\mathrm{Id}}^{\circ}(\tilde{\alpha}; U) \subset \beta^{\circ}(\tilde{\alpha}; U) \subset U \setminus (\Gamma \cdot E)$, hence $\mathcal{F}[\tilde{\alpha}; U] \sqsubset \mathcal{F}[U \setminus (\Gamma \cdot E)]$ which is a nonfilling free factor system.

2.3.2 The filling protoforest of a path.

To prepare for the proof of the "only if" direction of Proposition 2.9, and for later purposes, given a path $\alpha \subset T$ in a free splitting of Γ rel \mathcal{A} we shall describe an invariant protoforest denoted $\beta^{f}(\alpha) = \beta^{f}(\alpha; T)$, and called the *filling protoforest* of α in T; see Definition 2.12 below. In the "refinement" partial ordering, this protoforest will fit between the overlap forest and the ordinary covering forest: $\beta^{o}(\alpha) \prec \beta^{f}(\alpha) \prec \beta(\alpha)$ (see the "Protoforest Summary" at the end of Section 2.3.2).

The protoforest $\beta^{\rm f}(\alpha)$ is a little tricky to define: it will be obtained by delicately conglomerating protocomponents of the overlap protoforest $\beta^{\rm o}(\alpha;T)$. Like $\beta^{\rm o}(\alpha;T)$, the filling protoforest $\beta^{\rm f}(\alpha;T)$ will have just one orbit of protocomponents. The protocomponent stabilizers of $\beta^{\rm f}(\alpha;T)$ will be the subgroups conjugate to $F_{\rm min}(\alpha)$; recall that the protocomponent stabilizers of $\beta^{\rm o}(\alpha;T)$ do not generally fit that bill, because ${\rm Stab}(\beta^{\rm o}_{\rm Id}(\alpha;T))$ can be a proper subgroup of $F_{\rm min}(\alpha)$, as shown in the "new example" preceding Proposition 2.9.

The next lemma provides the basis for conglomerating components of the overlap protoforest $\beta^{o}(\alpha)$ to form the protocomponents of the filling protoforest $\beta^{f}(\alpha)$. For any free splitting $\Gamma \curvearrowright T$ and any nontrivial subgroup $H \leq \Gamma$, recall the notation T_{H} for the minimal *H*-invariant subtree of *T*.

Lemma 2.11. Consider a free splitting T of Γ rel A and a path $\alpha \subset T$, associated to which we have the overlap protoforest $\beta^{o}(\alpha)$ with protocomponent $\beta^{o}_{Id}(\alpha)$ containing α , and with filling support $F_{min}(\alpha)$. The following hold:

- (1) The subforest $\beta_{\mathrm{Id}}^f(\alpha) = F_{\min}(\alpha) \cdot \beta_{\mathrm{Id}}^o(\alpha) \subset T$ is an $F_{\min}(\alpha)$ -invariant subtree of T. If $F_{\min}(\alpha)$ is nontrivial with minimal subtree $T_{\alpha} = T_{F_{\min}(\alpha)}$ then it follows that $T_{\alpha} \subset \beta_{\mathrm{Id}}^f(\alpha)$.
- (2) The translates $\beta_g^f(\alpha) = g \cdot \beta_{\mathrm{Id}}^f(\alpha)$ form the protocomponents of a protoforest in T denoted $\beta^f(\alpha) = \beta^f(\alpha; T) = \{\beta_g^f(\alpha) \mid g \in \Gamma\}.$
- (3) The protoforest $\beta^{f}(\alpha)$ and the conjugacy class $[F_{\min}(\alpha)] = \{gF_{\min}(\alpha)g^{-1} \mid g \in \Gamma\}$ are related as follows:
 - (a) $\operatorname{Stab}(\beta_q^f(\alpha)) = gF_{\min}(\alpha)g^{-1};$

- (b) If $F_{\min}(\alpha)$ is not trivial then the function $\beta_g^f(\alpha) \mapsto \operatorname{Stab}(\beta_g^f(\alpha))$ is a well-defined bijection between the set $\beta^f(\alpha)$ and the set of subgroups forming the conjugacy class $[F_{\min}(\alpha)]$.
- (4) The tree $\beta_{\text{Id}}^f(\alpha)$ is characterized as the smallest subtree of T such that its stabilizer is a free factor of Γ rel A, it contains α , and it is a union of maximal α -connected subtrees (i.e. protocomponents of $\beta^o(\alpha;T)$).

Definition 2.12 (The filling protoforest of a path in a free splitting). Given a path $\alpha \subset T$ in a free splitting of Γ rel \mathcal{A} , the *filling protoforest* of α is the invariant protoforest $\beta^{\rm f}(\alpha) = \beta^{\rm f}(\alpha; T)$ defined in Lemma 2.11 (2), with protocomponents $\beta^{\rm f}_g(\alpha) = g \cdot \beta^{\rm f}_{\rm Id}(\alpha)$ where $\beta^{\rm f}_{\rm Id}(\alpha)$ is the unique protocomponent containing α .

Proof of Lemma 2.11. To start the proof we note that $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\alpha))$ is trivial if and only if $F_{\min}(\alpha)$ is trivial. If this is so then $\beta_{\operatorname{Id}}^{\mathrm{f}}(\alpha) = F_{\min}(\alpha) \cdot \beta_{\operatorname{Id}}^{\circ}(\alpha) = \beta_{\operatorname{Id}}^{\circ}(\alpha) = \alpha$ is a tree, and the rest of the proof is straightforward.

We may therefore assume that $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\alpha))$ and $F_{\min}(\alpha)$ are both nontrivial, hence the minimal subtree $T_{\alpha} = T_{F_{\min}(\alpha)} \subset T$ is defined. Assuming for the moment that (1) holds, the remaining items are proved as follows.

From (1) it follows that each translate $\beta_g^f(\alpha) = g \cdot \beta_{Id}^f(\alpha)$ is a subtree of T, and this collection of subtrees is clearly Γ -invariant. The equation $\beta_g^f(\alpha) = (gF_{\min}(\alpha)) \cdot \beta_{Id}^o(\alpha)$, together with Γ invariance of the protoforest $\beta^o(\alpha)$, shows that $\beta_g^f(\alpha)$ is a union of protocomponents of $\beta^o(\alpha)$. In order to prove (2), it suffices (by Γ -invariance of $\beta^f(\alpha)$) to consider each $g \in \Gamma$, and to assume that the trees $\beta_{Id}^f(\alpha)$ and $\beta_g^f(\alpha)$ overlap in an edge, and to prove that those trees are identical. From that assumption we obtain $h, h' \in F_{\min}(\alpha)$ such that $h \cdot \beta_{Id}^o(\alpha)$ and $gh' \cdot \beta_{Id}^o(\alpha)$ overlap in an edge. Since $\beta^o(\alpha)$ is a protoforest it follows that $h \cdot \beta_{Id}^o(\alpha) = gh' \cdot \beta_{Id}^o(\alpha)$ and therefore $h^{-1}gh' \in \text{Stab}(\beta_{Id}^o(\alpha)) \leq F_{\min}(\alpha)$, implying that $g \in F_{\min}(\alpha)$ and therefore $\beta_g^f(\alpha) = g \cdot \beta_{Id}^f(\alpha) = gF_{\min}(\alpha) \cdot \beta_{Id}^o(\alpha) = F_{\min}(\alpha) \cdot \beta_{Id}^o(\alpha) = \beta_{Id}^f(\alpha)$.

Since $\operatorname{Stab}(\beta_{\operatorname{Id}}^{o}(\alpha)) \leqslant F_{\min}(\alpha)$ we have $\operatorname{Stab}(\beta_{\operatorname{Id}}^{f}(\alpha)) = \operatorname{Stab}(F_{\min}(\alpha) \cdot \beta_{\operatorname{Id}}^{o}(\alpha)) = F_{\min}(\alpha)$, and item (3a) immediately follows. To prove (3b), for any $g, h \in \Gamma$ we have

$$\beta_g^{t}(\alpha) = \beta_h^{t}(\alpha) \iff g^{-1}h \in \operatorname{Stab}(\beta_{\operatorname{Id}}^{t}(\alpha)) = F_{\min}(\alpha)$$
$$\iff gF_{\min}(\alpha)g^{-1} = hF_{\min}(\alpha)h^{-1}$$

(using that the free factor $F_{\min}(\alpha)$ is its own normalizer)

$$\iff g \operatorname{Stab}(\beta_{\operatorname{Id}}^{\mathrm{f}}(\alpha))g^{-1} = h \operatorname{Stab}(\beta_{\operatorname{Id}}^{\mathrm{f}}(\alpha))h^{-1}$$
$$\iff \operatorname{Stab}(\beta_{a}^{\mathrm{f}}(\alpha)) = \operatorname{Stab}(\beta_{h}^{\mathrm{f}}(\alpha))$$

To prove item (4), we note first that $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ certainly does satisfy all of the properties required by (4). Since the set of protocomponents of $\beta^{\circ}(\alpha)$ whose union comprises $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ is a single $F_{\min}(\alpha)$ orbit of protocomponents of $\beta^{\circ}(\alpha)$, it follows that for any proper subtree of $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ which is a union of protocomponents of $\beta^{\circ}(\alpha)$, its stabilizer is strictly smaller than $F_{\min}(\alpha)$; but since $F_{\min}(\alpha)$ is the smallest free factor of Γ rel \mathcal{A} that contains $\mathrm{Stab}(\beta_{\mathrm{Id}}^{\circ}(\alpha))$, so the stabilizer of that subtree cannot be a free factor of Γ rel \mathcal{A} .

We turn to the proof of (1), first proving the inclusion $T_{\alpha} \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$. If $T_{\alpha} = \{V\}$ is a single vertex then it is the unique point fixed by each nontrivial element of $F_{\min}(\alpha)$, including

each nontrivial element of $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\alpha))$. Therefore T_{α} is also the minimal invariant subtree for $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\alpha))$, and so $T_{\alpha} \subset \beta_{\operatorname{Id}}^{\circ}(\alpha) \subset F_{\min}(\alpha) \cdot \beta_{\operatorname{Id}}^{\circ}(\alpha) = \beta_{\operatorname{Id}}^{\operatorname{f}}(\alpha)$.

We may therefore assume that T_{α} contains at least one edge; it follows that $F_{\min}(\alpha)$ is nontrivial and nonatomic (Definition 2.8 (3)). Recall the decomposition $\mathcal{A} = \mathcal{A}_{F_{\min}(\alpha)} \cup \overline{\mathcal{A}}_{F_{\min}(\alpha)}$ from [HM22, Lemma 2.7]. Recall also from that lemma that $\mathcal{A}_{F_{\min}(\alpha)}$ "restricts to" a free factor system of the group $F_{\min}(\alpha)$, in the sense that there is a free factorization $F_{\min}(\alpha) = A_1 * \cdots * A_K * B$ such that $\mathcal{A}_{F_{\min}(\alpha)} = \{[A_1], \ldots, [A_K]\}$ (where $[A_k]$ is the Γ -conjugacy class of A_k). In this situation the action $F_{\min}(\alpha) \curvearrowright T_{\alpha}$ is clearly a free splitting of $F_{\min}(\alpha)$ relative to $\mathcal{A}_{F_{\min}(\alpha)}$. Let \mathcal{H} denote the convex hull of $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$, meaning the smallest subtree of T containing $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$. By $F_{\min}(\alpha)$ invariance of $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ it follows that the tree \mathcal{H} is also $F_{\min}(\alpha)$ -invariant. By minimality of T_{α} we have $T_{\alpha} \subset \mathcal{H}$. Assuming by contradiction that $T_{\alpha} \not\subset \mathcal{H}$ restricts to the following inclusion of $F_{\min}(\alpha)$ -invariant subforests of T:

$$T_{\alpha} \setminus (F_{\min}(\alpha) \cdot e) \subset \mathcal{H} \setminus (F_{\min}(\alpha) \cdot e)$$

This inclusion induces an $F_{\min}(\alpha)$ -equivariant bijection between the components on either side of the inclusion, hence corresponding components have the same stabilizer subgroup with respect to the $F_{\min}(\alpha)$ action. From the left hand side of that inclusion, the stabilizer of each component is a proper free factor of $F_{\min}(\alpha)$ rel $\mathcal{A}_{F_{\min}(\alpha)}$, and is therefore a free factor of Γ rel \mathcal{A} that is properly contained in $F_{\min}(\alpha)$. By construction $\beta_{\mathrm{Id}}^{\circ}(\alpha)$ is contained in some component of $\mathcal{H} \setminus (F_{\min}(\alpha) \cdot e)$, and therefore $\mathrm{Stab}(\beta_{\mathrm{Id}}^{\circ})(\alpha)$ is contained in some free factor of Γ rel \mathcal{A} that is properly contained in $F_{\min}(\alpha)$. But this contradicts the definition of $F_{\min}(\alpha)$ as the smallest such free factor (see Definition 2.8). From this contradiction, the desired inclusion $T_{\alpha} \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ follows. Using the inclusion $T_{\alpha} \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ we now prove that the forest $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha) = F_{\min}(\alpha) \cdot \beta_{\mathrm{Id}}^{\circ}(\alpha)$ is

Using the inclusion $T_{\alpha} \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ we now prove that the forest $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha) = F_{\min}(\alpha) \cdot \beta_{\mathrm{Id}}^{\mathrm{o}}(\alpha)$ is connected, i.e. it is a tree, which will complete the proof of (1). Clearly $F_{\min}(\alpha)$ acts transitively on the components of $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$. Knowing that $T_{\alpha} \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$, it follows that some component of $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ intersects T_{α} . By $F_{\min}(\alpha)$ -invariance it follows that every component of $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ intersects T_{α} . But T_{α} is a connected subset of $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ hence $\beta_{\mathrm{Id}}^{\mathrm{f}}(\alpha)$ is connected. \diamondsuit

Protoforest summary. To summarize Definitions 2.7, 2.8 and 2.12, associated to any path $\alpha \subset T$ we have a nested sequence of three protoforests, namely the overlap protoforest, the filling protoforest, and the ordinary covering forest:

$$\beta^{\mathrm{o}}(\alpha) \prec \beta^{\mathrm{t}}(\alpha) \prec \beta(\alpha)$$

For each $g \in \Gamma$ the associated protocomponents containing $g \cdot \alpha$ are denoted

$$\beta_g^{\mathrm{o}}(\alpha) \subset \beta_g^{\mathrm{f}}(\alpha) \subset \beta_g(\alpha) \quad g \in \Gamma$$

We have a corresponding nested sequence of stabilizer subgroups, which in the case g = Id takes the form

$$\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\alpha)) \leqslant \underbrace{\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{f}}(\alpha))}_{F_{\min}(\alpha)} \leqslant \operatorname{Stab}(\beta_{\operatorname{Id}}(\alpha))$$

We note that only $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\mathrm{f}}(\alpha))$ and $\operatorname{Stab}(\beta_{\operatorname{Id}}(\alpha))$ are guaranteed to be free factors rel \mathcal{A} .

The filling support of α , denoted $\mathcal{F}[\alpha; T]$, is the free factor system rel \mathcal{A} whose unique nonatomic component is $[F_{\min}(\alpha)]$, if the free factor $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\mathrm{f}}(\alpha; T)) = F_{\min}(\alpha)$ is nontrivial and nonatomic rel \mathcal{A} ; otherwise $\mathcal{F}[\alpha; T]$ is just \mathcal{A} itself.

2.3.3 Blowing up the filling protoforest to prove the "only if" direction.

Given a protoforest δ in a free splitting T of Γ rel \mathcal{A} , its protocomponent stabilizers need not be free factors rel \mathcal{A} (see the "new example" preceding Proposition 2.9). But the filling protoforest $\beta^{f}(\alpha)$ of a path $\alpha \subset T$ has been constructed so that its protocomponent stabilizers $\operatorname{Stab}(\beta_{g}^{f}(\alpha)) = gF_{\min}(\alpha)g^{-1}$ are indeed free factors rel \mathcal{A} , and furthermore so that one of two alternatives holds: those stabilizers are all trivial or atomic, in which case the filling support is $\mathcal{F}[\alpha; T] = \mathcal{A}$; or they are all nontrivial, in which case they form a single conjugacy class $[F_{\min}(\alpha)]$, and that class is the unique non-atomic element of the filling support $\mathcal{F}[\alpha; T]$ (see Definition 2.8 and Lemma 2.11 (3)). Furthermore, in the nontrivial case we get extra information about the individual protocomponent stabilizers, allowing us to conclude that $\beta^{f}(\alpha)$ satisfies the following *Tame Stabilizer Hypothesis*. We state this hypothesis in a general manner, allowing it to be tested on protoforests in any free splitting, not just filling protoforests of paths:

Tame Stabilizer Hypothesis (for a protoforest δ in a free splitting T of Γ rel A)

- (1) Either all protocomponents of δ have trivial stabilizer, or any two distinct protocomponents have distinct stabilizers.
- (2) There is a free factor system $\mathcal{F}[\delta]$ of Γ rel \mathcal{A} , and a decomposition $\mathcal{F}[\delta] = \mathcal{F}_0[\delta] \sqcup \mathcal{F}_1[\delta]$ such that $\mathcal{F}_1[\delta] \subset \mathcal{A}$ and $\mathcal{F}_0[\delta]$ consists of those nontrivial, nonatomic conjugacy classes of the form $[\operatorname{Stab}(\delta_i)]$ as δ_i varies over the protocomponents of δ .
- (3) For any two distinct protocomponents of δ , the intersection of their stabilizers is trivial.

In fact item (3) follows from (1) and (2): item (1) reduces to the case that the two stabilizers are distinct nontrivial subgroups; and that case is covered by applying item (2) together with [HM14, Lemma 2.1] which says that the collection of subgroups representing elements of a free factor system is mutually malnormal.

As alluded to above, by applying Definition 2.8 and Lemma 2.11 (3), it follows that the *Tame* Stabilizer Hypothesis holds for the filling protoforest $\beta^{f}(\alpha)$ associated to any path $\alpha \subset T$ in any free splitting T of Γ rel \mathcal{A} , with the filling support $\mathcal{F}[\alpha; T]$ playing the role of $\mathcal{F}[\delta]$. Furthermore, in the nontrivial/nonatomic case there are corresponding decompositions using the notation of Definition 2.8 (3):

$$\underbrace{\mathcal{F}[\alpha;T]}_{\mathcal{F}[\delta]} = \underbrace{\{[F_{\min}(\alpha)]\}}_{\mathcal{F}_{0}[\delta]} \cup \underbrace{\overline{\mathcal{A}}_{F_{\min}(\alpha)}}_{\mathcal{F}_{1}[\delta]}$$

Given any protoforest δ in T, a sufficient condition for the *Tame Stabilizer Hypothesis* to hold is that there exists a simplicial collapse map $q: U \xrightarrow{\upsilon} T$ defined on a free splitting U of Γ rel \mathcal{A} , and there exists an invariant subforest $\tilde{\delta} \subset U$ (with respect to the given simplicial structure on U), such that the forests υ and $\tilde{\delta}$ have no edge in common, the map q induces a bijection between connected components of $\tilde{\delta}$ and protocomponents of δ , and q takes each connected component of $\tilde{\delta}$ to its associated protocomponent of δ by a simplicial isomorphism. The following lemma says that this condition is also necessary:

Lemma 2.13 (The Protoforest Blowup Lemma). Consider a free splitting T of Γ rel A and a protoforest $\delta = {\delta_i}_{i \in I}$ in T. If δ satisfies the Tame Stabilizer Hypothesis, then there exists a free splitting U of Γ rel A, a simplicial collapse map $q: U \xrightarrow{v} T$, and an invariant subforest $\tilde{\delta} \subset U$ with connected components $\tilde{\delta} = \bigsqcup_{i \in I} \tilde{\delta}_i$ (with the same index set I), such that the following hold:

- (1) For each $i \in I$ the projection q restricts to a simplicial isomorphism $q: \tilde{\delta}_i \to \delta_i$.
- (2) $\mathcal{F}[\delta] = \mathcal{F}[\tilde{\delta}]$, hence the free factor system $\mathcal{F}[\delta]$ is visible in U as witnessed by $\tilde{\delta} \subset U$.

Before proving this lemma in Section 2.3.4 to follow, we first apply it:

Proof of Proposition 2.9: The "only if" direction. Consider an arc $\alpha \subset T$ in a free splitting T of Γ rel \mathcal{A} , with filling support $\mathcal{F}[\alpha; T]$ (Definition 2.8). We must prove that α does not fill T if either of the following two cases holds:

Case 1: There exists a natural edge E of T such that α does not have an interior crossing of the orbit of E; or

Case 2: $\mathcal{F}[\alpha; T]$ is not filling.

In Case 1, the trivial expansion $U = T \xrightarrow{\text{Id}} T$ witnesses that α does not fill T.

In Case 2, consider the filling protoforest $\beta^{f}(\alpha)$ in T, which as we have seen satisfies the *Tame Stabilizer Hypothesis* and has associated free factor system $\mathcal{F}[\beta^{f}(\alpha)] = \mathcal{F}[\alpha;T]$. Applying Lemma 2.13 we obtain an expansion $U \mapsto T$ and for each $g \in \Gamma$ a simplicially isomorphic lift $\tilde{\beta}_{g} \subset U$ of $\beta_{g}^{f}(\alpha)$, such that these lifts are the connected components of a proper, invariant subforest $\tilde{\beta} \subset U$ whose component stabilizers form the free factor system $\mathcal{F}[\alpha;T]$. From the Case 2 hypothesis, $\tilde{\beta}$ is a proper subforest of U. Since the lift $\tilde{\alpha} \subset U$ of α is contained in the component $\tilde{\beta}_{Id}$, the translates of $\tilde{\alpha}$ are contained in the proper subforest $\tilde{\beta}$ and hence do not cover U. The expansion $U \mapsto T$ thus witnesses that α does not fill T.

2.3.4 Proof of the Protoforest Blowup Lemma

The last remaining piece of the proof of Proposition 2.9, the Filling Criterion, is the following:

Proof of the Blowup Lemma 2.13. Let T and $\delta = {\delta_i}_{i \in}$ be given. For all $i \neq j \in I$, the protocomponent intersection $\delta_i \cap \delta_j$ is either empty or a single vertex of T. Let $W \subset \mathcal{V}T$ denote those vertices $w \in \mathcal{V}T$ for which there exist $i \neq j \in I$ such that $w = \delta_i \cap \delta_j$; clearly W is Γ -invariant. If W is empty then distinct protocomponents of δ are disjoint, hence δ is a true subforest of T, and the conclusions of the lemma are true with the trivial expansion $U = T \xrightarrow{\mathrm{Id}} T$. Henceforth we assume that W is not empty.

We have two actions $\Gamma \curvearrowright I$ and $\Gamma \curvearrowright W$, the former induced by the action $\Gamma \curvearrowright \{\delta_i\}_{i \in I}$ on the protocomponents of δ . Consider the diagonal action $\Gamma \curvearrowright I \times W$. For each $(i, w) \in I \times W$ let $C_{iw} = \operatorname{Stab}(\delta_i) \cap \operatorname{Stab}(w)$. Since T is a free splitting of Γ , the following implication holds: if C_{iw} is nontrivial then $w \in \delta_i$.

We would like that the converse implication holds as well:

(*) For all $(i,k) \in I \times K$, C_{ik} is nontrivial if and only if $w_k \in \delta_i$.

While statement (*) may fail to be true, we shall reduce the proof of Lemma 2.13 to the case that (*) is true, repairing its failure by constructing an intermediate expansion $T' \mapsto T$ as follows.

Consider the following Γ -set that witnesses the falsity of (*):

$$Z = \{(i, w) \in I \times W \mid w \in \delta_i \text{ and } C_{iw} \text{ is trivial}\}$$

Let $W^f \subset W$ be the image of the restricted projection map $Z \subset I \times W \mapsto W$ — that is, W^f is the set of all $w \in W$ for which there exists $i \in I$ such that $w \in \delta_i$ and C_{iw} is trivial. Note that W^f is Γ -invariant. We construct T' from T in two stages, first detaching from each $w \in W^f$ those δ_i for which $(i, w) \in Z$, and then attaching new edges to T'' to fill the gaps created by these detachments, thus constructing the free splitting T'.

In more detail, the forest T'' is constructed from T as follows. First, remove each $w \in W^f$ from the vertex set of T and replace it by a subset $\hat{w} = \{w'\} \cup \{w''_i \mid (i, w) \in Z\}$ of vertices of T'' (all vertices of $T - W^f$ remain as vertices of T''). For any edge $e \subset T$ that was attached to $w \in W^f$, we re-attach e to an appropriate point of \hat{w} as follows: if there exists $i \in I$ such that $(i, w) \in Z$ and $e \subset \delta_i$, re-attach e to w''_i ; otherwise, reattach e to w'. There is a quotient map $T'' \mapsto T$ obtained by collapsing each $\hat{w} \subset T''$ to the corresponding point $w \in T$ (for $k \in K'$). That quotient map induces a bijection of edges, and each protocomponent $\delta_i \subset T$ of the protoforest δ lifts by a simplicial isomorphism to a subtree $\delta''_i \subset T''$. Intuitively, we think of w''_i as a new, special copy of w to which δ''_i is attached if it so happens that C_{iw} is trivial; and we think of w'as the "original" copy of w to which everything else stays attached.

For use below we record that for all $w \in W$ and for all $i \neq j \in I$ such that $w = \delta_i \cap \delta_j$, the following dichotomy holds in T'':

- **Case 1:** $\delta_i'' \cap \delta_j'' = \emptyset \iff$ at least one of (i, w) or (j, w) is in $Z \iff$ at least one of C_{iw} or C_{jw} is trivial.
- **Case 2:** $\delta''_i \cap \delta''_j = \{w'\} \neq \emptyset \iff$ neither (i, w) nor (j, w) is in $Z \iff$ both C_{iw} and C_{jw} are nontrivial.

We note that if $w \in W - W^f$ then Case 2 must hold; whereas if $w \in W^f$ then either of Case 1 or Case 2 could hold.

We next attach to the forest T'' a new edge e_{iw} with endpoints w' and w''_i , for all $(i, w) \in Z$. The overall result of this detachment-attachment operation is a new tree T'. The actions of Γ on T, I, W and Z induce an action $\Gamma \curvearrowright T'$. This action is a free splitting of Γ rel A because Stab $(e_{iw}) = C_{iw}$ is trivial for each $(i, w) \in Z$. There is a collapse map $T' \mapsto T$ under which the vertices of T with nontrivial preimage are precisely the points $w \in W^f$, and the preimage of each such w is a star graph with star vertex w', consisting of the union of those new edges $e_{iw} \subset T'$ for which $(i, w) \in Z$. By construction we obtain a protoforest $\delta' = \delta''$ in $T' \supset T''$ with protocomponents $\delta'_i = \delta''_i \subset T'$, and the collapse map $T' \to T$ induces a Γ -invariant bijection of protocomponents, mapping corresponding protocomponents by simplicial isomorphism. The *Tame Stabilizer Hypothesis* therefore still holds with respect to T' and δ' . Also, as an immediate consequence of the dichotomy recorded above, condition (*) now holds in T', which completes the reduction argument.

It remains to establish the conclusions of the lemma for given T and δ under the additional assumption that condition (*) holds, which we restate here:

(*) For all $w \in W$ and all δ_i we have $w \in \delta_i \iff C_{iw} = \operatorname{Stab}(w) \cap \operatorname{Stab}(\delta_i) \neq \{\operatorname{Id}\}.$

Denote $I_w = \{i \in I \mid w \in \delta_i\}$. By definition each $w \in W$ is contained in more than one protocomponent δ_i , and so $|I_w| \ge 2$. Combining this with (*) it follows that

(**) For all $w \in W$ we have $\operatorname{Stab}(w) \neq {\operatorname{Id}}$, and so $[\operatorname{Stab}(w)]$ is an element of the free factor system $\mathcal{F}_{ell} T$.

Note that $[\operatorname{Stab}(w)] \in \mathcal{F}_{ell} T$ depends only on the orbit of w under the action $\Gamma \curvearrowright W$, and distinct orbits produce distinct elements of $\mathcal{F}_{ell} T$.

Since $\mathcal{F}[\delta]$ and $\mathcal{F}_{ell} T$ are both free factor systems of Γ rel \mathcal{A} , their meet $\mathcal{B} = \mathcal{F}[\delta] \wedge \mathcal{F}_{ell} T$ is also a free factor system of Γ rel \mathcal{A} , and clearly $\mathcal{B} \sqsubset \mathcal{F}_{ell} T$ (see [HM14, Section 2.2] for discussion of the meet). For each $w \in W$ we have $[\operatorname{Stab}(w)] \in \mathcal{F}_{ell} T$, and so $\operatorname{Stab}(w)$ is a free factor rel \mathcal{B} . Applying [HM22, Lemma/Definition 2.7] together with (*) and the definition of the meet, in the group $\operatorname{Stab}(w)$ we have a free factor system $\mathcal{B} \mid \operatorname{Stab}(w)$ of the following form:

$$\mathcal{B} \mid \operatorname{Stab}(w) = \left\{ [\operatorname{Stab}(w) \cap \operatorname{Stab}(\delta_i)]^w \mid i \in I_w \right\}$$

where we use the notation $[\cdot]^w$ to refer to conjugacy classes within the group $\operatorname{Stab}(w)$.

Note that $\mathcal{B} \mid \operatorname{Stab}(w)$ is a nonfull free factor system of the group $\operatorname{Stab}(w)$, for otherwise there would exist $i \in I_w$ such that $\operatorname{Stab}(w) = \operatorname{Stab}(w) \cap \operatorname{Stab}(\delta_i)$, and by choosing $j \neq i \in I_w$ it would follow that

$$\operatorname{Stab}(w) \cap \operatorname{Stab}(\delta_i) = \operatorname{Stab}(w) \cap \operatorname{Stab}(\delta_i) \cap \operatorname{Stab}(\delta_i)$$

But $\operatorname{Stab}(\delta_i) \cap \operatorname{Stab}(\delta_j)$ is trivial (by item (3) of the *Tame Stabilizer Hypothesis*) whereas $\operatorname{Stab}(w) \cap \operatorname{Stab}(\delta_j)$ is nontrivial (by (*)), which is a contradiction.

For each $w \in W$ choose $\operatorname{Stab}(w) \curvearrowright U_w$ to be a (nontrivial) Grushko free splitting of the group $\operatorname{Stab}(w)$ relative to its (nonfull) free factor system $\mathcal{B} \mid \operatorname{Stab}(w)$. We may make these choices in a Γ -equivariant manner, meaning that the individual actions $\operatorname{Stab}(w) \curvearrowright U_w$ extend to a Γ -action on the forest $\sqcup_{w \in W} U_w$, and that the stabilizer of U_w is $\operatorname{Stab}(w)$: for each orbit of the action $\Gamma \curvearrowright W$ one first chooses a single orbit representative w and a Grushko free splitting $\operatorname{Stab}(w) \curvearrowright U_w$ relative to $\mathcal{B} \mid \operatorname{Stab}(w)$; and then one extends that to a diagonal action $\Gamma \curvearrowright (\Gamma/\operatorname{Stab}(w)) \times U_w$ using the natural left action of Γ on the set of left cosets $\Gamma/\operatorname{Stab}(w)$.

For each $w \in W$ and $i \in I_w$ consider the subgroup $C_{iw} = \operatorname{Stab}(\delta_i) \cap \operatorname{Stab}(w)$. Since $[C_{iw}]^w \in \mathcal{B} | \operatorname{Stab}(w)$, and since C_{iw} is nontrivial, it follows that C_{iw} fixes a unique point $u_{iw} \in U_w$ and that $C_{iw} = \operatorname{Stab}(u_{iw})$. Note that if $i \neq j \in I_w$ then $u_{iw} \neq u_{jw}$, because C_{iw}, C_{jw} are nontrivial subgroups of $\operatorname{Stab}(w)$ whose intersection $C_{iw} \cap C_{jw}$ is a subgroup of $\operatorname{Stab}(\delta_i) \cap \operatorname{Stab}(\delta_j) = \{\operatorname{Id}\}$ and is therefore trivial.

For the remainder of the proof we shall construct the desired free splitting $\Gamma \curvearrowright U$ from the actions $\Gamma \curvearrowright T$ and $\Gamma \curvearrowright \sqcup_w U_w$ using a detachment/re-attachment procedure carried out at each $w \in W$. Recall the direction set $D_w T$ consisting of all oriented edges E with initial vertex w. The set $D_w T$ subdivides as follows: one subset $D_w \delta_i$ for each $i \in I_w$; and a single *leftover* direction for each $E \in D_w T - \bigsqcup_{i \in I_w} D_w \delta_i$ that we denote $D_w E$.

Starting with the free splitting action of Γ on the tree T:

Protoforest detachments: For each $w \in W$ and each $i \in I_w$, detach the entire set $D_w \delta_i$ from $w \in T$, and let $x_{iw} \in \delta_i$ denote the point that was formerly attached to w. We may thus identifying $D_{x_{iw}} \delta_i$ with $D_w \delta_i$. The points x_{wi} , one for each $w \in E$ and $i \in I_w$, are called protoforest detachment points.

Leftover detachments: For each $w \in W$ and each leftover oriented edge $E \subset T$ with initial vertex w, detach E from w, and let $y_{Ew} \in E$ be the initial vertex that was formerly attached to w. The points $\{y_{Ew}\}$, one for each $w \in W$ and each leftover oriented edge E with initial vertex w, are called *leftover detachment points*.

The detachment forest Δ : The result of these detachments is a forest denoted Δ on which Γ acts, together with a Γ -equivariant quotient map $\Delta \mapsto T$: the action of Γ on detachment points is given by

$$\gamma \cdot x_{iw} = x_{\gamma \cdot i, \gamma \cdot w}$$
 and $\gamma \cdot y_{Ew} = y_{\gamma \cdot E, \gamma \cdot w}$

and the quotient map takes x_{iw} and each y_{Ew} to w. This quotient map is a bijection on edges, and so the Γ stabilizer of every edge of Δ is trivial. Note that each protocomponent $\delta_i \subset T$ lifts to Δ by simplicial isomorphism, we identify δ_i with its lift, and we note that the protocomponents are *pairwise disjoint* in Δ .

Re-attachments: Consider the disjoint union of the forest Δ and the forest $\sqcup_w U_w$, with the induced Γ action on this disjoint union.

Protoforest re-attachments: Noting that both of the sets $\{x_{iw}\}$ and $\{u_{iw}\}$ are bijectively indexed by the set $\{(i, w) \mid w \in W, i \in I_w\}$, we may re-attach x_{iw} to u_{iw} in a well-defined manner, and these re-attachments are automatically Γ -equivariant.

Leftover re-attachments: Re-attach each leftover detachment point $y_{Ew} \in \Delta$ to some point $z_{Ew} \in U_w$. The reattachment map $y_{Ew} \mapsto z_{Ew}$ is not automatically Γ -equivariant. However, since each of the actions $\Gamma \curvearrowright \Delta$ has trivial edge stabilizers, and since each leftover detachment point is incident to a unique edge of Δ , the restricted action of Γ on the set of leftover detachment points is a free action, and so we can force these reattachments to be Γ -equivariant in the usual manner: choose one representative y_{Ew} of each Γ -orbit of leftover detachment points, choose $z_{Ew} \in U_w$ arbitrarily and reattach y_{Ew} to z_{Ew} , and then for each $\gamma \in \Gamma - {\text{Id}}$, the leftover detachment point $y_{\gamma \cdot E, \gamma \cdot w} = \gamma \cdot y_{Ew}$ is re-attached to the point $z_{\gamma \cdot E, \gamma \cdot w} := \gamma \cdot z_{Ew}$.

Let U be the quotient of the disjoint union of Δ and $\sqcup_w U_w$ under the reattachments just described. By construction the Γ actions on Δ and on $\sqcup_w U_w$ induce an action $\Gamma \curvearrowright U$. Since Γ acts on each of Δ and $\sqcup_w U_w$ with trivial edge stabilizers, and since no edges are identified under the quotient map from their disjoint union to U, the Γ -stabilizer of each edge of U is trivial. We have two Γ -equivariant quotient maps $\Delta \mapsto T$ and $\sqcup_w U_w \mapsto T$ (the latter defined by $U_w \mapsto w$), and these maps agree where points of Δ are identified with points of $\sqcup_w U_w$, hence we have an induced equivariant quotient map $U \mapsto T$. The only points of T that have nontrivial pre-image under this quotient map are the points $w \in W$, and for each such point its pre-image is the tree U_w ; furthermore, the collapse map $U \mapsto T$ takes the edges in U that are incident to but not contained in the tree U_w to the edges of T that are incident to w. It follows that U is a tree, and furthermore that $\Gamma \cap U$ is a free splitting action and $U \mapsto T$ is a collapse map. Because the protocomponents are pairwise disjoint in Δ , and because of the inequality $u_{iw} \neq u_{jw}$ for each $i \neq j \in I_w$, the protocomponents remain pairwise disjoint in U. This completes the proof of the Protoforest Blowup Lemma 2.13.

2.4 Proof of the Strong Two Over All Theorem

We have already proved, in Section 2.1.3, that the uniterated form of the Strong Two Over All Theorem 2.4 quickly implies the iterated form. The hard work left is to prove the uniterated form, which we do here in Section 2.4.3, by giving a formula for $\Theta = \Theta(\Gamma; \mathcal{A}) \geq 1$ and using it to prove that for any foldable map $f: S \to T$, if $d(S,T) \geq \Theta$ then S has two natural edges in different Γ orbits each of whose f-images fills T. The proof will share certain strategies of the proof of the original *Two Over All Theorem*, with filling protoforests taking over the job of covering forests. Starting with a Stallings fold factorization $f: S = S_0 \xrightarrow{f_1} S_1 \xrightarrow{f_2} \cdots \xrightarrow{f_M} S_M = T$, the rough idea is to consider a natural edge $E_0 \subset S_0$ and its corresponding sequence of natural tiles

$$\alpha_0 = E_0 \subset S_0 \qquad \alpha_1 = f_1(\alpha_0) \subset S_1 \qquad \cdots \qquad \alpha_M = f_M(\alpha_{M-1}) \subset S_M$$

and to study the evolution of the filling rank $\operatorname{KR}(\alpha_i)$: recall from Definition 2.8 and Lemma 2.11 that $\operatorname{KR}(\alpha_i) = \operatorname{KR}(F(\alpha_i))$ where $F(\alpha_i)$, a free factor of Γ rel \mathcal{A} , is the stabilizer of the protocomponent $\beta_{\operatorname{Id}}^{\mathrm{f}}(\alpha)$ of the filling protoforest $\beta^{\mathrm{f}}(\alpha)$. We describe the evolution of the sequence $\operatorname{KR}(\alpha_i)$ in two lemmas. Section 2.4.1 contains Lemma 2.15, a monotonicity property saying that the sequence $\operatorname{KR}(\alpha_i)$ is nondecreasing. Section 2.4.2 contains Lemma 2.18 which gives a distance bound while Kurosh rank is constant: a universal upper bound (namely 6) for the diameter of any fold subsequence $\operatorname{KR}(\alpha_i) = |\mathcal{A}| + \operatorname{corank}(\mathcal{A})$ for Kurosh ranks.

2.4.1 Monotonicity of filling ranks along fold paths.

To set up Lemma 2.15, consider a single fold map $h: S \to S'$ between free splittings of Γ rel \mathcal{A} , and paths $\alpha \subset S$, $\alpha' \subset S'$ such that $h \mid \alpha$ is a homeomorphism onto α' . Consider also the following associated objects:

- (Definition 2.7) The overlap protoforests $\beta^{\circ}(\alpha; S)$ and $\beta^{\circ}(\alpha'; S')$ with protocomponents $\beta^{\circ}_{a}(\alpha; S)$ and $\beta^{\circ}_{a}(\alpha'; S')$ containing $g \cdot \alpha$ and $g \cdot \alpha'$ respectively;
- (Definition 2.8) The filling supports $F = F_{\min}(\alpha)$ and $F' = F_{\min}(\alpha')$, which are the smallest free factors of Γ rel \mathcal{A} containing $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\alpha; S))$ and $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\alpha'; S'))$ respectively;
- (Definition 2.12) The filling protoforests $\beta^{f}(\alpha; S)$ and $\beta^{f}(\alpha'; S')$, with protocomponents containing $g \cdot \alpha, g \cdot \alpha'$ respectively:

$$\beta_g^{\mathrm{t}}(\alpha; S) = gF \cdot \beta_{\mathrm{Id}}^{\mathrm{o}}(\alpha; S) = gFg^{-1} \cdot \beta_g^{\mathrm{o}}(\alpha; S)$$
$$\beta_g^{\mathrm{f}}(\alpha; S') = gF' \cdot \beta_{\mathrm{Id}}^{\mathrm{o}}(\alpha'; S') = gF'g^{-1} \cdot \beta_g^{\mathrm{o}}(\alpha'; S')$$

Definition 2.14. Using the above notation, to say that *h* preserves filling protocomponents (with respect to α and α') means:

- (1) $h(\beta_q^{\mathrm{f}}(\alpha; S)) = \beta_q^{\mathrm{f}}(\alpha'; S')$ for each $g \in \Gamma$.
- (2) For each $g_1, g_2 \in \Gamma$, we have $\beta_{q_1}^{f}(\alpha; S) = \beta_{q_2}^{f}(\alpha; S)$ if and only if $\beta_{q_1}^{f}(\alpha; S') = \beta_{q_2}^{f}(\alpha'; S')$.

In applying this definition one should keep in mind that two protocomponents of the same protoforest are distinct if and only if they are edge disjoint.

Lemma 2.15. For any fold map $h: S \to S'$ and any paths $\alpha \subset S$ and $\alpha' \subset S'$, if $h \mid \alpha$ is a homeomorphism onto α' then (with notations as above including respective filling supports F and F') we have:

(1) $F \leq F'$ and $h(\beta_a^f(\alpha; S)) \subset \beta_a^f(\alpha; S')$ for all $g \in \Gamma$.

- (2) F = F' if and only if h preserves filling protocomponents.
- (3) $\operatorname{KR}(\alpha) \leq \operatorname{KR}(\alpha')$, with equality if and only if h preserves filling protocomponents.

As a consequence, if α fills S then α' fills S'.

Proof. For the proof we abbreviate protoforest notations by dropping the argument $(\alpha; S)$, for example $\beta_{Id}^{o} = \beta_{Id}^{o}(\alpha; S)$. We also drop $(\alpha'; S')$ but in its place we add a "prime" symbol, for example $\beta'_{Id}^{o} = \beta_{Id}^{o}(\alpha'; S')$.

Item (3) follows immediately from (1) and (2) together with [HM22, Lemma 2.9] and the equations $KR(\alpha) = KR(F)$ and $KR(\alpha') = KR(F')$.

Since $\beta_{\mathrm{Id}}^{\circ}$ is α -connected and contains α , and since $\alpha' = h(\alpha)$, it follows that $h(\beta_{\mathrm{Id}}^{\circ})$ is α' connected and contains α' . But $\beta'_{\mathrm{Id}}^{\circ}$ is union of all α' connected subgraphs of S' that contain α' ,
hence $h(\beta_{\mathrm{Id}}^{\circ}) \subset \beta'_{\mathrm{Id}}^{\circ}$. For each $g \in \mathrm{Stab}(\beta_{\mathrm{Id}}^{\circ})$ it follows that $(g \cdot \beta'_{\mathrm{Id}}^{\circ}) \cap \beta'_{\mathrm{Id}}^{\circ}$ contains $h(\beta_{\mathrm{Id}}^{\circ})$ and so
the two protocomponents $g \cdot \beta'_{\mathrm{Id}}^{\circ}$ and $\beta'_{\mathrm{Id}}^{\circ}$ of $\beta(\delta'; S')$ are not edge disjoint, hence they are equal,
and therefore $g \in \mathrm{Stab}(\beta'_{\mathrm{Id}}^{\circ})$, proving that $\mathrm{Stab}(\beta'_{\mathrm{Id}}) \leq \mathrm{Stab}(\beta'_{\mathrm{Id}})$. Since F, F' are the smallest
free factors of Γ rel \mathcal{A} that contain the respective subgroups $\mathrm{Stab}(\beta'_{\mathrm{Id}})$ and $\mathrm{Stab}(\beta'_{\mathrm{Id}})$, it follows
that $F \leq F'$. It follows furthermore that

$$h(\beta_{\mathrm{Id}}^{\mathrm{t}}) = h(F \cdot \beta_{\mathrm{Id}}^{\mathrm{o}}) = F \cdot h(\beta_{\mathrm{Id}}^{\mathrm{o}}) \subset F' \cdot \beta'_{\mathrm{Id}}^{\mathrm{o}} = \beta'_{\mathrm{Id}}^{\mathrm{t}}$$

which completes the proof of item (1) in the special case g = Id; the general case follows by Γ -invariance of protoforest components and the identities $g \cdot \beta_{\text{Id}}^{\text{f}} = \beta_g^{\text{f}}$ and $g \cdot \beta'_{\text{Id}}^{f} = \beta'_g^{f}$.

If h preserves filling protocomponents then it immediately follows that $F = \operatorname{Stab}(\beta_{\mathrm{Id}}^{\mathrm{f}}) = \operatorname{Stab}(\beta_{\mathrm{Id}}^{\mathrm{f}}) = F'$. For the other direction, suppose that F = F'. Letting g vary over a set of left coset representatives in Γ of the subgroup $\operatorname{Stab}(\beta_{\mathrm{Id}}^{\mathrm{f}}) = F = F' = \operatorname{Stab}(\beta_{\mathrm{Id}}'_{\mathrm{Id}})$, the trees $g \cdot \beta_{\mathrm{Id}}^{\mathrm{f}}$ form an edge disjoint cover of $\beta^{\mathrm{f}}(\alpha; S)$ and the trees $g \cdot \beta_{\mathrm{Id}}'_{\mathrm{Id}}$ form an edge disjoint cover of $\beta^{\mathrm{f}}(\alpha; S')$; but from (1) we also have $h(\beta_{\mathrm{Id}}^{\mathrm{f}}) \subset \beta'_{\mathrm{Id}}'_{\mathrm{Id}}$, and by equivariance it follows that $h(g \cdot \beta_{\mathrm{Id}}^{\mathrm{f}}) \subset g \cdot \beta'_{\mathrm{Id}}'_{\mathrm{Id}}$. These facts taken together imply that $h(g \cdot \beta_{\mathrm{Id}}^{\mathrm{f}}) = g \cdot \beta'_{\mathrm{Id}}'_{\mathrm{Id}}$ for all $g \in \Gamma$, and the following chain of equivalences for each $g_1, g_2 \in \Gamma$ completes the proof that h preserves protocomponents equivariantly:

2.4.2 A distance bound while Kurosh rank is constant

In Lemma 2.18 to follow, we will be concerned with finding an upper bound on the diameter of a fold sequence along which there is a "fold-invariant path sequence" of constant filling complexity; but the lemma does have an additional hypothesis requiring that each relevant path has interior crossings of translates of every natural edge.

The proof of the lemma will require the concept of *combing rectangles* which we quickly review before stating the lemma (see from [HM14, Section 4.3]; we will also need this concept later, in Section 3.7, when reviewing *projection diagrams*).

Recall the concept of a "nondegenerate subgraph" of a free splitting, in Section 2.1.1 under the heading *Free splittings and their maps*.

Definition 2.16 (Pullbacks). Consider a foldable map $g: V' \to V$ of free splittings and a nondegenerate subgraph $\sigma \subset V$ (with respect to some subdivision of V). The *pullback* of σ (with respect to g, in V') is the nondegenerate subgraph $g^*(\sigma) \subset V'$ that is obtained from $g^{-1}(\sigma)$ by removing any single point component of $g^{-1}(\sigma)$. When working with pullbacks we generally use "edgelet" terminology, because one cannot generally say that $g^*(\sigma) \subset V'$ is a subforest with respect to the given simplicial structure on V'; at best it is a subforest with respect to a subdivisions of V' and V such that g is simplicial and $\sigma \subset V$ is a simplicial subforest.

Along any foldable sequence $V_I \xrightarrow{g_{I+1}} \cdots \xrightarrow{g_J} V_J$, a *pullback sequence* consists of nondegenerate subgraphs $\beta_i \subset V_i$, one for each $i \in [I, \ldots, J]$, such that β_i is the pullback of β_j under $f_j^i \colon V_i \mapsto V_j$ for all $i \leq j \in [I, \ldots, J]$. A pullback sequence determines and is determined by its final term: for any nonempty, nondegenerate subgraph $\beta_J \subset V_J$, by pulling back one map at a time we obtain the unique pullback sequence with final term β_J .

Definition 2.17. ([HM14, Section 4.3]) A *combing rectangle* is a commutative diagram of free splittings and equivariant maps of the form

$$V_{I} \xrightarrow{g_{I+1}} \cdots \xrightarrow{g_{i-1}} V_{i-1} \xrightarrow{g_{i}} V_{i} \xrightarrow{g_{i+1}} \cdots \xrightarrow{g_{J}} V_{J}$$

$$\langle \sigma_{I} \rangle \Big| \pi_{I} \qquad \langle \sigma_{i-1} \rangle \Big| \pi_{i-1} \quad \langle \sigma_{i} \rangle \Big| \pi_{i} \qquad \langle \sigma_{J} \rangle \Big| \pi_{i}$$

$$U_{I} \xrightarrow{f_{I+1}} \cdots \xrightarrow{f_{i-1}} U_{i-1} \xrightarrow{f_{i}} U_{i} \xrightarrow{f_{i+1}} \cdots \xrightarrow{f_{J}} U_{J}$$

such that the following hold:

- (1) Each row is a foldable sequence.
- (2) Each vertical arrow is a collapse map $\pi_i \colon V_i \to U_i$ with indicated collapse subforest $\sigma_i \subset V_i$.
- (3) The σ_i 's form a pullback sequence along the V-row.

We recall the Combing By Expansion Lemma, [HM14, Lemma 4.9] which, starting with any foldable sequence $U_I \mapsto \cdots \mapsto U_J$ and any collapse map $V_J \xrightarrow{\langle \sigma_J \rangle} U_J$, produces a combing rectangle as denoted above. In addition, from the proof of that lemma we extract the following property which we add to the previous three properties to define a combing by expansion rectangle:

(4) For each $I < i \leq J$ the i^{th} square in the diagram is a fiber product diagram in the category of minimal Γ trees, meaning that V_{i-1} is the unique minimal Γ -invariant subtree of the Γ -forest

$$\{(x, y) \in U_{i-1} \times V_i \mid f_i(x) = \pi_i(y)\}$$

If desired, after possibly subdividing each tree in the above combing diagram, we may assume that each map depicted is a simplicial map, so each horizontal arrow therefore takes each edgelet (of its domain) to an edgelet (of its range), and each vertical arrow takes each edgelet to either an edgelet or a vertex. Assuming that holds then, as with any simplicial collapse map, for each $I \leq i \leq J$ we have:

(5) The map $\pi_i: V_i \to U_i$ induces an edgelet bijection $\mathcal{E}(V_i \setminus \sigma_i) \leftrightarrow \mathcal{E}(U_i)$.

This completes Definition 2.17.

Fix a fold sequence in $\mathcal{FS}(\Gamma; \mathcal{A})$ of the form

$$U_I \xrightarrow{f_{I+1}} U_{I+1} \xrightarrow{f_{I+2}} \cdots \xrightarrow{f_J} U_J$$

and a sequence of paths $\alpha_i \in U_i$, such that $f_i \mid \alpha_{i-1}$ is a homeomorphism onto α_i (for $I < i \leq J$). Let $F_i \leq \Gamma$ denote the filling support of α_i (Definition 2.8), and $K_i = \text{KR}(\alpha_i) = \text{KR}(F_i)$ the filling rank. Applying Lemma 2.15 we have subgroup inclusions and numerical inequalities

$$F_I \leqslant F_{I+1} \leqslant \cdots \leqslant F_J$$
 and $K_I \le K_{I+1} \le \cdots \le K_J$

Lemma 2.18. If α_i has an interior crossing of a translate of each natural edge of U_i (for $I \leq i \leq J$), and if the sequence of Kurosh ranks $K_i = K$ is a constant independent of $I \leq i \leq J$, and if the strict inequality $K < \operatorname{KR}(\Gamma; \mathcal{A}) = |\mathcal{A}| + \operatorname{corank} \mathcal{A}$ holds, then the diameter in $\mathcal{FS}(\Gamma; \mathcal{A})$ of the fold sequence $U_I \mapsto \cdots \mapsto U_J$ is ≤ 6 .

Proof. For the proof we use abbreviated "filling protoforest" notation $\beta_i^{\rm f} = \beta^{\rm f}(\alpha_i, U_i)$ and $\beta_{i,g}^{\rm f} = g \cdot \beta_{i,{\rm Id}}^{\rm f} = \beta_q^{\rm f}(\alpha_i; U_i)$.

To set up the proof of Lemma 2.18, since $K = \text{KR}(F_i)$ is constant for $I \leq i \leq J$, it follows that $F = F_i$ is also constant ([HM22, Lemma 2.9]). Applying Lemma 2.15 it follows that fold map $f_i: U_{i-1} \to U_i$ preserves filling protocomponents (with respect to α_{i-1} and α_i).

We note that F is not the trivial subgroup. To see why, by hypothesis there is a subset $\hat{\alpha}$ of the interior of α_i consisting of a union of exactly one representative of each natural edge orbit of U_i . It follows that $\alpha_i \setminus \hat{\alpha}$ contains some edgelet e of U_i , and it also follows that $g \cdot e \subset \hat{\alpha}$ for some $g \neq \mathrm{Id} \in \Gamma$. The paths α_i and $g^{-1} \cdot \alpha_i$ therefore overlap, and so $g^{-1} \in \mathrm{Stab}(\beta_{i,\mathrm{Id}}^{\mathrm{o}}) \leq F$.

For the rest of the proof we index the protocomponents of each protoforest $\beta_i^{\rm f}$ by choosing a set of left coset representatives of Γ modulo F that includes the identity element Id. For notating these coset representatives and their associated protocomponents we use κ instead of g, writing $\beta_{i,\kappa}^{\rm f} = \kappa \cdot \beta_{i,\rm Id}^{\rm f}$.

As seen in Section 2.3.3, the protoforest β_J^f satisfies the Distinct Stabilizer Hypothesis. We may therefore apply the Proforest Blowup Lemma 2.13, obtaining an expansion $\pi_J : V_J \xrightarrow{\langle \sigma_J \rangle} U_J$ that satisfies the following property (A_J) and a quick consequence (B_J) :

- (A_J) There is an invariant subforest $\tilde{\beta}_J \subset V_J$ with component decomposition $\tilde{\beta}_J = \bigsqcup_{\kappa} \tilde{\beta}_{J,\kappa}$, such that π_J restricts to a simplicial isomorphism $\tilde{\beta}_{J,\kappa} \to \beta_{J,\kappa}^{\rm f}$ for each κ ; in particular $\operatorname{Stab}(\tilde{\beta}_{J,\mathrm{Id}}) = \operatorname{Stab}(\beta_{J,\mathrm{Id}}^{\rm f}) = F_J = F$.
- (B_J) $\tilde{\beta}_J \subset V_J$ is a proper subforest, equal to the uncollapsed subforest $V_J \setminus \sigma_J$.

Property (B_J) is a consequence of (A_J) which, together with the fact that $\beta_J^{\rm f}$ covers U_J , implies the equation $\tilde{\beta}_J = V_J \setminus \sigma_J$; also properness of $\tilde{\beta}_J$ follows from the equation $\mathcal{F}[\tilde{\beta}_J] = \mathcal{F}[\beta_J^{\rm f}]$ (Lemma 2.13 (1)) and the strict inequality $\operatorname{KR}(F_J) = K < \operatorname{KR}(\Gamma; \mathcal{A})$.

Applying the statement and the proof of the *Combing By Expansion Lemma*, [HM14, Lemma 4.9] as indicated in Definition 2.17, choose a combing-by-expansion rectangle with notation as in

that definition. By downward induction we shall extend properties (A_J) , (B_J) to a sequence of properties (A_i) , (B_i) , and add a new sequence of properties (C_i) , all defined for $I \leq i \leq J$, as follows:

- (A_i) There is an invariant subforest $\tilde{\beta}_i \subset V_i$ with component decomposition $\tilde{\beta}_i = \bigsqcup_{\kappa} \tilde{\beta}_{i,\kappa}$ such that π_i restricts to a simplicial isomorphism $\tilde{\beta}_{i,\kappa} \to \beta_{i,\kappa}^{\mathrm{f}}$ for each κ ; in particular $\mathrm{Stab}(\tilde{\beta}_{i,\mathrm{Id}}) = \mathrm{Stab}(\beta_{i,\mathrm{Id}}^{\mathrm{f}}) = F_i = F.$
- (B_i) $\tilde{\beta}_i \subset V_i$ is a proper subforest, equal to the uncollapsed subforest $V_i \setminus \sigma_i$.
- (C_i) If $i \ge 1$, the foldable map g_i restricts to a map $g_i : \tilde{\beta}_{i-1} \to \tilde{\beta}_i$ that induces a component bijection $g_i(\tilde{\beta}_{i-1,\kappa}) = \tilde{\beta}_{i,\kappa}$.

To start the proof, we know already that (A_J) and (B_J) are true. For each $i \ge 1$ assuming by downward induction that (A_i) and (B_i) are true, we shall prove that (C_i) and (A_{i-1}) are true; and then (B_{i-1}) is a consequence of (A_{i-1}) for the same reasons that (B_J) is a consequence of (A_J) .

To prove (A_{i-1}) , from the inductive assumption that (A_i) holds we get a restricted simplicial isomorphism $\pi_i \colon \tilde{\beta}_{i,\kappa} \to \beta_{i,\kappa}^{\mathrm{f}}$ for each κ . Knowing that f_i preserves protocomponents, we obtain a restricted simplicial map $f_i \colon \beta_{i-1,\kappa}^{\mathrm{f}} \to \beta_{i,\kappa}^{\mathrm{f}}$. Let $\tilde{\beta}_{i-1,\kappa} \subset V_{i-1}$ be the subforest of all edges $e \subset V_{i-1}$ for which $\pi_{i-1}(e) \subset \beta_{i-1,\kappa}^{\mathrm{f}}$ and $g_i(e) \subset \tilde{\beta}_{i,\kappa}$. By applying Definition (2.17) item (4) and using that $\pi_i \colon \tilde{\beta}_{i,\kappa} \to \beta_{i,\kappa}^{\mathrm{f}}$ is a simplicial isomorphism, the restricted map $\pi_{i-1} \colon \tilde{\beta}_{i-1,\kappa} \to \beta_{i-1,\kappa}^{\mathrm{f}}$ is a simplicial isomorphism, and in particular $\tilde{\beta}_{i-1,\kappa}$ is connected. Since $g_i(\tilde{\beta}_{i-1,\kappa}) \subset \tilde{\beta}_{i,\kappa}$, it follows that as κ varies the trees $\tilde{\beta}_{i-1,\kappa}$ are pairwise disjoint, and hence $\tilde{\beta}_{i-1} = \bigsqcup_{\kappa} \tilde{\beta}_{i-1,\kappa}$ is the component decomposition, which proves (A_{i-1}) .

To prove (C_i) , by definition of $\tilde{\beta}_{i-1}$ we have $g(\tilde{\beta}_{i-1,\kappa}) \subset \tilde{\beta}_{i,\kappa}$. As κ varies, we know that the components $\tilde{\beta}_{i,\kappa}$ of $\tilde{\beta}_i$ are pairwise disjoint. The trees $\tilde{\beta}_{i-1,\kappa}$ are therefore pairwise disjoint, hence they are indeed the components of the forest $\tilde{\beta}_{i-1}$, proving (C_i) .

For each $I \leq i < j \leq J$ we must prove the distance bound $d(U_i, U_j) \leq 6$, which we do using methods of [HM22, Section 5] that go back to the proof of [HM13, Lemma 5.2]. Since each vertical arrow is a collapse map we have $d(V_i, U_i)$, $d(V_j, U_j) \leq 1$, and we shall prove $d(V_i, V_j) \leq 4$. Consider the foldable map

$$h = g_i^i \colon V_i \to V_j$$

Combining properties $(C_{i+1}), \ldots, (C_j)$, the restricted map $h: \tilde{\beta}_i \to \tilde{\beta}_j$ induces a component bijection $\tilde{\beta}_{i,\kappa} \to \tilde{\beta}_{j,\kappa}$. Applying [HM22, Lemma/Definition 5.2] together with [HM22, Propositions 5.3, 5.4], by prioritizing folding the subforest $\tilde{\beta}_i \subset V_i$ we obtain a fold factorization of h of the form

$$V_i = W_0 \xrightarrow{h_1} \cdots \xrightarrow{h_K} W_K \xrightarrow{h_{K+1}} \cdots \xrightarrow{h_L} W_L = V_j$$

such that the following hold, with foldable maps denoted $h_l^k = h_l \circ \cdots \circ h_{k+1} \colon W_k \to W_l$ and invariant subforests denoted $\delta_k = h_k^0(\tilde{\beta}_i) \subset W_k$:

- (1) Each fold map $h_k \colon W_{k-1} \to W_k$ with $0 < k \le K$ is defined by folding two edges of δ_{k-1} .
- (2) $d(W_0, W_K) \leq 2$ (by combining (1) with [HM22, Proposition 5.4]).

(3) The foldable map $h_L^K \colon W_K \to W_L$ restricts to an injection on each component of δ_K .

Since the map $h = g_j^i$ induces a bijection from components of $\delta_0 = \tilde{\beta}_i$ to components of $\delta_L = \tilde{\beta}_j = \delta_L$, it follows for each $0 \le k < l \le L$ that the map h_l^k induces a bijection from components of δ_k to components of δ_l . Using this for the case k = K and l = L, and combining it with item (3) above, it follows that h_L^K restricts to an equivariant homeomorphism $\delta_K \mapsto \delta_L$. Finally, since h does not identify any edgelet of $\tilde{\beta}_i$ with an edgelet of $V_i \setminus \tilde{\beta}_i$, it follows that h_L^K does not identify any edgelet of $\mathcal{K}_K \setminus \delta_K$. In summary, the remainder of the fold sequence $W_K \mapsto \cdots \mapsto W_L$ prioritizes folding of the subforest $W_K \setminus \delta_K$. Again applying [HM22, Proposition 5.4], we obtain

(4) $d(W_K, W_L) \le 2$.

Combining (2) and (4) we get $d(V_i, V_j) = d(W_0, W_L) \le d(W_0, W_K) + d(W_K, W_L) \le 2 + 2 = 4$ which completes the proof of Lemma 2.18.

2.4.3 Proof of the Strong Two Over All Theorem

Consider a foldable map $f: S \to T$ between free splittings $S, T \in \mathcal{FS}(\Gamma; \mathcal{A})$. Choose a Stallings fold factorization of f with folds of length ≤ 1 (see [HM22, Theorem 2.17 (4)]), denoted

$$f: S = S_0 \xrightarrow{f_1} S_1 \xrightarrow{f_2} \cdots \xrightarrow{f_M} S_M = T$$

Using the constant $\Delta = \Delta(\Gamma; \mathcal{A}) \geq 1$ from the *Two Over All Theorem* [HM22], we assume a preliminary lower bound

$$d(S,T) \ge 3\Delta$$

Using the fact that each fold has length ≤ 1 , we can choose L so that $0 < L \leq M$ and so that $d(S, S_L) = d(S_0, S_L) = 3\Delta$. Applying the *Two Over All Theorem* to the foldable map f_L^0 we obtain two natural edges $E_0, E'_0 \subset S_0$ in distinct orbits such that each of the natural tiles $f_L^0(E_0), f_L^0(E'_0) \subset S_L$ contains $2^{3-1} = 4$ nonoverlapping subpaths each of which crosses a translate of every natural edge of S_L . Choose $\alpha_L \subset S_L$ to be either of the paths $f_L^0(E_0)$ or $f_L^0(E'_0)$, and then for each l such that $l \leq l \leq M$, let $\alpha_l = f_l^L(\alpha_L)$. The path α_M is thus either of $f_M^0(E_0)$ or $f_M^0(E'_0)$, and our goal has become:

- To find some lower bound $d(S,T) = d(S_0, S_M) \ge \Theta = \Theta(\Gamma; \mathcal{A})$ (with $\Theta \ge 3\Delta$) which implies that α_M satisfies the *Filling Criterion* of Proposition 2.9:
 - (1)_M: α_M has an interior crossing of some translate of every natural edge of S_M ;
 - (2): $\operatorname{KR}(\alpha_M) = \operatorname{KR}(\Gamma; \mathcal{A}).$

Once that goal is achieved, by applying Proposition 2.9 it will then follow that α_M fills $S_M = T$, and the proof is done.

For purposes of verifying $(1)_M$, and for the broader purposes of applying Lemma 2.18 along the fold sequence from S_L to S_M , for each $L \leq l \leq M$ we first verify:

(1)_l: α_l has an interior crossing of some translate of every natural edge of S_l

We start with the fact that the path $\alpha_L (= f_L^0(E_0) \text{ or } f_L^0(E'_0))$ contains 4 nonoverlapping subpaths of S_L each of which crosses a translate of every natural edge of S_L . We next distill that fact down to the statement that $\alpha_L \subset S_L$ contains 3 nonoverlapping subpaths each of which crosses a translate of every edge of S_L . That property is inherited by $\alpha_l \subset S_l$ for each $L \leq l \leq M$, and so we obtain a decomposition of the form

such that each of μ_1, μ_2, μ_3 crosses a translate of every edge of S_l ; the ν_i subpaths are allowed to be empty. Each μ_i must contain a natural vertex of S_l , for otherwise μ_i is a proper subpath of some natural edge $E \subset S_l$, contradicting that μ_i crosses a translate of every edge of S_l . Also, the subpath μ_1 must contain a natural vertex w_1 of S_l which is contained in the interior of α_l : otherwise no point of μ_1 except possibly its left endpoint is a natural vertex, implying that μ_1 is a proper subpath of some natural edge of S_l , again a contradiction. The subpath μ_3 must similarly contain a natural vertex w_3 of S_l which is in the interior of α_l . It follows that $\overline{w_1w_3}$ is a natural path in S_l , it is an interior subpath of α_l , and it contains the path μ_2 . Consider any natural edge $E \subset S_l$. Choosing any edge $e \subset E$ we obtain $\gamma \in \Gamma$ such that $\gamma \cdot e \subset \mu_2$. The natural edge $\gamma \cdot E$ therefore overlaps the natural path $\overline{w_1w_3}$, implying that $\gamma \cdot E \subset \overline{w_1w_3}$, and hence $\gamma \cdot E$ is contained in the interior of α_l , completing the proof of $(1)_l$.

We turn now to verifying (2), starting with a formula for Θ . For $L \leq l \leq M$ consider the filling protoforest $\beta_l^{\rm f} = \beta^{\rm f}(\alpha_l; S_l)$, with protocomponent $\beta_{l, {\rm Id}}^{\rm f} = \beta_{{\rm Id}}^{\rm f}(\alpha_l; S_l)$ containing α_l , and with filling support $F_l = {\rm Stab}(\beta_{l, {\rm Id}}^{\rm f}) \leq \Gamma$ of Kurosh rank ${\rm KR}(\alpha_l) = {\rm KR}(F_l)$. By applying Lemma 2.15 we have subgroup inclusions $F_L \leq \cdots \leq F_M$ and integer inequalities ${\rm KR}(\alpha_L) \leq \cdots \leq {\rm KR}(\alpha_M)$, and furthermore for each $L < l \leq M$ we have $F_{l-1} = F_l$ if and only if ${\rm KR}(\alpha_{l-1}) = {\rm KR}(\alpha_l)$. We may therefore decompose the fold sequence $S_L \mapsto \cdots \mapsto S_M$ into maximal fold subsequences along which Lemma 2.18 may be applied to obtain constant Kurosh rank along each fold subsequence:

$$\underbrace{S_L = S_{M_0} \mapsto \dots \mapsto S_{M_1-1}}_{\mathrm{KR}_1} \xrightarrow{J_{M_1}} \underbrace{S_{M_1} \mapsto \dots \mapsto S_{M_2-1}}_{\mathrm{KR}_2} \xrightarrow{J_{M_2}} \dots \\ \cdots \xrightarrow{f_{M_{N-1}}} \underbrace{S_{M_{L-1}} \mapsto \dots \mapsto S_{M_{N-1}} = S_M}_{\mathrm{KR}_N}$$
$$\operatorname{KR}_n = \mathrm{KR}(\alpha_{M_{n-1}}) = \dots = \mathrm{KR}(\alpha_{M_n-1}) \quad \text{for } 1 \le n \le N$$
$$\operatorname{KR}_{n-1} < \mathrm{KR}_n \quad \text{for } 1 < n \le N$$

Suppose now that:

(#) α_M does not fill S_M , equivalently $\mathrm{KR}_N = \mathrm{KR}(\alpha_M) < \mathrm{KR}(\Gamma; \mathcal{A})$

For each $1 \leq n \leq N$ it follows that $\operatorname{KR}_n \leq \operatorname{KR}_N < \operatorname{KR}(\Gamma; \mathcal{A})$ and so we can apply Lemma 2.18 to each fold subsequence, with the conclusion that the diameter in $\mathcal{FS}(\Gamma; \mathcal{A})$ of each fold subsequence is ≤ 6 . From the sequence of strict integer inequalities $0 \leq \operatorname{KR}_1 < \cdots < \operatorname{KR}_N < \operatorname{KR}(\Gamma; \mathcal{A})$ we obtain $N \leq \operatorname{KR}(\Gamma; \mathcal{A})$. Taking into account the diameter bound of 1 for each of the individual folds $f_{M_l}: S_{M_l-1} \to S_{M_l}$, the fold subsequence $S_L \mapsto \cdots \mapsto S_M$ therefore has diameter bounded above by the constant $7 \cdot \operatorname{KR}(\Gamma; \mathcal{A}) - 1$. Combining this with the previously obtained distance equation $d(S_0, S_L) = 3\Delta$, under the supposition (#) we obtain the bound

$$d(S,T) = d(S_0, S_M) \le d(S_0, S_L) + d(S_L, S_M)$$
$$\le 3\Delta + 7 \operatorname{KR}(\Gamma; \mathcal{A}) - 1$$

Adding 1 to the above constant, if

$$d(S,T) \ge \Theta(\Gamma;\mathcal{A}) = 3\Delta + 7 \operatorname{KR}(\Gamma;\mathcal{A})$$

then the filling rank of α_M must equal KR($\Gamma; \mathcal{A}$). This holds for each choice of $\alpha_M = f(E_0)$ or $f(E'_0)$ as noted earlier. To summarize: having also proved that the natural tile α_M has an interior crossing of each natural edge orbit of S_M , by applying Proposition 2.9 it follows that α_M fills S_M , completing the proof of the Strong Two-Over-All Theorem 2.4.

2.5 Comparing filling supports of nested paths

The proof of the *Strong Two Over All Theorem*, carried out in the previous section, was based on a study of the evolution of filling support as a path is pushed forward along a fold sequence (see Lemma 2.15 and its application in Lemma 2.18).

For application in Section 4.3, here we study a different evolution of filling support, namely evolution under nesting of paths within a single free splitting. To review protoforest concepts and notations see Definitions 2.7, 2.8 and 2.12, and the *Protoforest Summary* that follows Definition 2.12.

Lemma 2.19. For any free splitting S of Γ rel A and any paths $\eta, \eta' \subset S$ the following hold:

- (1) If $\eta \subseteq \eta'$ then $\eta \subseteq \beta_{\mathrm{Id}}^f(\eta')$.
- (2) If $\eta \subseteq \beta_{\mathrm{Id}}^f(\eta')$ then
 - (a) $\beta_{\mathrm{Id}}^f(\eta) \subseteq \beta_{\mathrm{Id}}^f(\eta')$ and $\beta^f(\eta) \preceq \beta^f(\eta')$ and $F_{\min}(\eta) \subseteq F_{\min}(\eta')$ and $\mathrm{KR}(\eta) \leq \mathrm{KR}(\eta')$.
 - (b) If furthermore $\beta(\eta) = \beta(\eta') = S$ then the following are equivalent:
 - i. One of the four relations in (2a) is an equality
 - ii. All of the four relations in (2a) are equalities.

As a consequence of (1) and (2a), if $\eta \subseteq \eta'$ and if η fills S then η' fills S.

Remark. Regarding item (2b) of this lemma, without the hypothesis $\beta(\eta) = \beta(\eta') = S$ there are counterexamples. For a simple one, let S be the universal cover of the rank 2 rose with edges labelled a, b, let $\eta' \subset S$ be an ab path, let $\eta \subset \eta'$ be the a subpath; then $\beta(\eta) \neq S = \beta(\eta')$ and so $\beta^{\rm f}(\eta) \neq \beta^{\rm f}(\eta')$ and yet $F_{\min}(\eta) = F_{\min}(\eta')$ is the trivial free factor.

Proof. Item (1) follows immediately from $\eta' \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$. Assuming that $\eta \subseteq \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$, we prove item (2a) in a few steps.

Step 1: For all $g, h \in \Gamma$, if $g \cdot \eta \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$, and if $h \cdot \eta$ overlaps $g \cdot \eta$, then $h \cdot \eta \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$.

For the proof, choose an edge $e' \subset h \cdot \eta \cap g \cdot \eta$, and so $e' \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$. It also follows that $gh^{-1} \cdot e' \subset gh^{-1}h \cdot \eta = g \cdot \eta \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$. Since $\beta^{\mathrm{f}}(\eta')$ is a protoforest, and since its protocomponent $\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$ contains both e' and $gh^{-1} \cdot e'$, it follows that $gh^{-1} \in \mathrm{Stab}(\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta'))$. Also, therefore, $hg^{-1} \in \mathrm{Stab}(\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta'))$. It follows that $h \cdot \eta = hg^{-1} \cdot (g \cdot \eta) \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$.

Step 2: $\beta_{\mathrm{Id}}^{\mathrm{o}}(\eta) \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta').$

Choose an edge $e \subset \beta_{\mathrm{Id}}^{\mathrm{o}}(\eta)$. The conclusion that $e \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$ follows by induction on the length of an η -connection between an edge of η and the edge e: use the hypothesis $\eta \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$ as the basis step where that length equals 0; and use Step 1 as the induction step.

Step 3: $F_{\min}(\eta) \leq F_{\min}(\eta')$ and hence $\operatorname{KR}(\eta) \leq \operatorname{KR}(\eta')$.

Combining Step 2 with the fact that $\beta_{Id}^f(\eta')$ is a protoforest, it follows that $Stab(\beta_{Id}^o(\eta))$ stabilizes $\beta_{Id}^f(\eta')$, and so

$$\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\eta)) \leq \operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{f}}(\eta')) = F_{\min}(\eta')$$

But $F_{\min}(\eta)$ is the smallest free factor containing $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\eta))$, by application of Definition 2.8, and so $F_{\min}(\eta) \leq F_{\min}(\eta')$.

Step 4: $\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta) \subseteq \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$ and hence $\beta^{\mathrm{f}}(\eta) \preceq \beta^{\mathrm{f}}(\eta')$.

$$\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta) = F_{\min}(\eta) \cdot \beta_{\mathrm{Id}}^{\mathrm{o}}(\eta) \underbrace{\subseteq}_{\mathrm{Step 2}} F_{\min}(\eta) \cdot \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta') \underbrace{\subseteq}_{\mathrm{Step 3}} F_{\min}(\eta') \cdot \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta') = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$$

This completes the proof of (2a).

We prove (2b). First, from the definition of protoforests it follows that $\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta) = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$ if and only if $\beta^{\mathrm{f}}(\eta) = \beta^{\mathrm{f}}(\eta')$. Next, a nested pair of free factors of Γ rel \mathcal{A} are equal to each other if and only if their Kurosh ranks are equal [HM22, Lemma 2.9]. Next, since $F_{\min}(\eta) = \mathrm{Stab}(\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta))$ and similarly for η' , the equation $\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta) = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$ implies $F_{\min}(\eta) = F_{\min}(\eta')$. Finally, assuming that $\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta) \neq \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta')$, we prove that $F_{\min}(\eta) \neq F_{\min}(\eta')$. This is where we

Finally, assuming that $\beta_{Id}^{f}(\eta) \neq \beta_{Id}^{f}(\eta')$, we prove that $F_{\min}(\eta) \neq F_{\min}(\eta')$. This is where we use the hypothesis of (2b) saying that $\beta(\eta) = S$: the protoforest $\beta^{f}(\eta)$ being a refinement of $\beta(\eta)$, it follows that $\beta^{f}(\eta)$ covers S. Knowing also that $\beta^{f}(\eta) \preceq \beta^{f}(\eta')$ and that $\beta_{Id}^{f}(\eta) \neq \beta_{Id}^{f}(\eta')$, it follows that $\beta^{f}(\eta)$ has a protocomponent $\beta_{g}^{f}(\eta)$ for some $g \in \Gamma$, such that $\beta_{g}^{f}(\eta)$ does not overlap $\beta_{Id}^{f}(\eta)$, and such that $\beta_{g}^{f}(\eta) \subseteq \beta_{Id}^{f}(\eta')$. It follows that $g \notin F_{\min}(\eta) = \operatorname{Stab}(\beta_{Id}^{f}(\eta))$. It also follows that $\beta_{Id}^{f}(\eta')$ and $g \cdot \beta_{Id}^{f}(\eta')$ overlap along edges of $\beta_{g}^{f}(\eta)$, and so from the definition of a protoforest we obtain $g(\beta_{Id}^{f}(\eta')) = \beta_{Id}^{f}(\eta')$ which implies that $g \in F_{\min}(\eta') = \operatorname{Stab}(\beta_{Id}^{f}(\eta'))$.

3 Large orbits in $\mathcal{FS}(\Gamma; \mathcal{A})$: The implication (4) \implies (1) of Theorem B

Given $\phi \in \text{Out}(\Gamma; \mathcal{A})$, with a value of $\Omega = \Omega(\Gamma; \mathcal{A})$ as yet unspecified we are assuming:

Large Orbit Hypothesis (Theorem B (4)): Every ϕ -orbit in $\mathcal{FS}(\Gamma; \mathcal{A})$ has diameter $\geq \Omega$.

and we must prove

Conclusion (Theorem B (1)): ϕ has an attracting lamination that fills Γ rel A.

In Section 3.1 we outline how to find Ω and how to use it prove the conclusion. That outline will motivate reviews and preliminary materials contained in Sections 3.2–3.4; in particular for a very quick review of attracting laminations see Section 3.4. The steps of the outline are then carried out in Sections 3.5–3.7.

3.1 An outline: Finding Ω and proving the implication

After some significant preliminary work in Sections 3.2–3.4, starting in Section 3.5 we will find Ω by formulating two constraints on its value in the form of two lower bounds Ω_1 , Ω_2 , each chosen to enable application of different tools and methods (see also the parallel discussion in the Introduction). To get the proof off the ground, one starts by choosing a maximal, nonfull, ϕ -invariant free factor system \mathcal{F} of Γ rel \mathcal{A} .

In Section 3.5, the first constraint $\Omega \geq \Omega_1 = 5$ is chosen to enable application of [HM22, Proposition 4.24], the conclusion of which describes a dichotomy between two different types of train track representative. The first case of this dichotomy can be avoided by applying the constraint $\Omega \geq \Omega_1$. The other case of this dichotomy therefore applies, providing us with a unique attracting lamination Λ of ϕ relative to \mathcal{F} . Furthermore, there is an EG-aperiodic train track axis for ϕ in the outer space of Γ rel \mathcal{F} which we may include into the free splitting complex $\mathcal{FS}(\Gamma; \mathcal{A})$, each position T_i along that axis is a free splitting rel \mathcal{F} supporting an EG-aperiodic train track representative $T_i \to T_i$ of ϕ , and the generic leaves of Λ are realized by lines in T_i that are exhausted by iteration tiles of that train track map. The hard work that remains is to prove that Λ fills Γ rel \mathcal{A} .

In Section 3.6, the second constraint $\Omega \geq \Omega_2 = \Omega_2(\Gamma; \mathcal{A})$ is chosen to enable application of the *Strong Two Over All Theorem* to the train track axis. The hypothesis of that theorem can be verified *uniformly* at every position along the train track axis for ϕ , by applying the lower diameter bound $\Omega \geq \Omega_2$ to orbits along the axis. We can then apply the conclusion of the *Strong Two Over All Theorem* to show that at each position T_i along the fold axis, sufficiently high iteration tiles are filling tiles in the sense of Definition 2.3. We then prove that the train track axis is a bi-infinite, quasigeodesic line in $\mathcal{FS}(\Gamma; \mathcal{A})$, by applying those filling tiles in conjunction with concepts of free splitting units from [HM14, Section 4.5].

In Section 3.7, the proof is completed by applying concepts of projection diagrams that were developed in [HM14, Section 5.2] and were used there to define a Masur–Minsky projection function from $\mathcal{FS}(\Gamma; \mathcal{A})$ to any finite fold path in $\mathcal{FS}(\Gamma; \mathcal{A})$. To show that Λ fills, by applying Corollary 3.5 it suffices to find a "witness path" in any given Grushko free splitting R of Γ relative to \mathcal{A} , meaning a path in R that crosses a representative of every edge orbit of R and is contained in a bi-infinite line of R that realizes a generic leaf of Λ . We do this with the aid of a projection diagram from R to a very carefully chosen finite subpath of the fold axis. This axis subpath is chosen with the aid of the Quasi-Closest Point Property, a consequence of the Masur–Minsky axioms that is derived in [HM14, Section 5.1], and which gives some control on the distance within the axis subpath between the projection of R to that subpath and the point on that subpath which minimizes distance to R. The choice of axis subpath enables us to identify a free splitting T_i at a certain location along that subpath, and to take a line ℓ in T_i which represents a generic leaf of Λ , and then to find a "multi-filling" tile in that line, meaning a tile that contains multiple nonoverlapping subpaths each of which fills T_i . That "multi-filling" property then lets us set up a bounded cancellation argument for pushing that tile to the desired witness path in R.

In order to carry out the above outline one needs some preliminary work, carried out in Sections 3.2 — 3.4, regarding how to compare attracting laminations of ϕ relative to \mathcal{F} with attracting laminations of ϕ relative to \mathcal{A} , whenever one is given a nested pair of ϕ -invariant free factor systems $\mathcal{A} \sqsubset \mathcal{F}$ of Γ . The summary result that we will need is found in Section 3.5 under the heading "Conclusion (2)". Here is a simplified version:

• ϕ has a unique attracting lamination relative to \mathcal{A} that is not supported by \mathcal{F} if and only if ϕ has a unique attracting lamination relative to \mathcal{F} , and furthermore there is a natural equivariant bijection between the generic leaves of these attracting laminations.

The "natural equivariant bijection" in this statement comes by combining some elements of relative train track theory (see Section 3.4) with a relation between the line spaces $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A})$ and $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{F})$ (see Section 3.3). That relation between line spaces is itself described using a relation between the canonical boundaries $\partial_{\infty}(\Gamma; \mathcal{A})$ and $\partial_{\infty}(\Gamma; \mathcal{F})$ which was first worked out carefully by Dowdall and Taylor [DT17] (see Section 3.2): there is a natural Γ -equivariant homeomorphism between $\partial_{\infty}(\Gamma; \mathcal{A})$ and a dense subset $\partial_{\mathcal{F}}(\Gamma; \mathcal{A}) \subset \partial_{\infty}(\Gamma; \mathcal{A})$ called the \mathcal{F} sub-boundary of Γ rel \mathcal{A} .

3.2 Boundaries under collapse: the Dowdall Taylor correspondence

For recalling notations and concepts regarding ends of free splittings and boundaries of groups relative to free factor systems: see [HM22, Section 4.1.1], much of which follows [GH19]. In particular we recall: the end space $\partial_{\infty} T$ of a free splitting T of Γ , consisting of asymptotic classes of rays in T; the action $\Gamma \curvearrowright \partial_{\infty} T$ that is naturally induced by the free splitting action $\Gamma \curvearrowright T$; and the unique action $\operatorname{Aut}(\Gamma; \mathcal{A}) \curvearrowright \partial_{\infty} T$ that extends the free splitting action $\Gamma \curvearrowright T$ with respect to the natural monomorphism $\Gamma \approx \operatorname{Inn}(\Gamma) \leq \operatorname{Aut}(\Gamma; \mathcal{A})$. Recall also the canonical boundary $\partial_{\infty}(\Gamma; \mathcal{A})$ on which Γ acts with unique extended action by $\operatorname{Aut}(\Gamma; \mathcal{A})$, together with equivariant identifications $I_T: \partial_{\infty}(\Gamma; \mathcal{A}) \to \partial_{\infty} T$ which commute with the equivariant map $\partial_{\infty} S \mapsto \partial_{\infty} T$ induced by any equivariant simplicial map $S \mapsto T$ (between two Grushko free splittings rel \mathcal{A}). Also, for each nonatomic free factor $F \leq \Gamma$ rel \mathcal{A} with restricted free factor system $\mathcal{A} \mid F$ there is an F-equivariant embedding $\partial_{\infty}(F; \mathcal{A} \mid F) \hookrightarrow \partial_{\infty}(\Gamma; \mathcal{A})$ which, for any free splitting $T \in \mathcal{FS}(\Gamma; \mathcal{A})$, is induced by the inclusion $T_F \hookrightarrow T$ of the minimal subtree for the restricted action $F \curvearrowright T$. The action of $\Phi \in \operatorname{Aut}(\Gamma; \mathcal{A})$ on $\partial_{\infty}(\Gamma; \mathcal{A})$ is denoted $\partial_{\infty}\Phi: \partial_{\infty}(\Gamma; \mathcal{A}) \to \partial_{\infty}(\Gamma; \mathcal{A})$ and may regarded as the unique Φ -twisted equivariant homeomorphism of $\partial_{\infty}(\Gamma; \mathcal{A})$ with respect to the action $\Gamma \curvearrowright \partial_{\infty}(\Gamma; \mathcal{A})$ (see [HM22, Lemma 4.1]).

Consider a nested pair of free factor systems $\mathcal{A} \sqsubset \mathcal{F}$ of Γ . Consider also two Grushko free splittings S and T of Γ relative to \mathcal{A} and \mathcal{F} respectively, with end spaces $\partial_{\infty}S$ and $\partial_{\infty}T$. Consider, finally, a choice of equivariant simplicial map $f: S \to T^*$. As recalled above, if $\mathcal{A} = \mathcal{F}$ then f naturally induces an equivariant homeomorphism $\partial_{\infty}S \to \partial_{\infty}T$. But when $\mathcal{A} \neq \mathcal{F}$, one would not expect f to induce a natural equivariant homeomorphism. Nonetheless Dowdall and Taylor discovered that f induces a natural equivariant subboundary correspondence in the form of an equivariant homeomorphism with codomain $\partial_{\infty}T$, the domain of which is a certain Γ invariant subspace of $\partial_{\infty}S$ called the T-subboundary of S, denoted $\partial_T S$ (see [DT17, Section 3]). In Lemma 3.1 we review this subboundary correspondence, emphasizing its connection with bounded

^{*}Some such f always exists: for $v \in S$ such that $\operatorname{Stab}(v)$ is nontrivial we have $[\operatorname{Stab}(v)] \in A$, and so $\operatorname{Stab}(v)$ is a subgroup of a unique F such that $[F] \in \mathcal{F}$; let $f(v) \in T$ be the unique point stabilized by F. One then chooses the value of f arbitrarily on a single representative of each vertex orbit, extending over that orbit by equivariance, and then extending equivariantly over all edges.

cancellation concepts. In Lemma 3.3 we then translate the subboundary correspondence into the language of the canonical boundaries $\partial_{\infty}(\Gamma; \mathcal{A})$ and $\partial_{\infty}(\Gamma; \mathcal{F})$, producing an " \mathcal{F} -subboundary" $\partial_{\mathcal{F}}(\Gamma; \mathcal{A}) \subset \partial_{\infty}(\Gamma; \mathcal{A})$ and a homeomorphism $\partial_{\mathcal{F}}(\Gamma; \mathcal{A}) \mapsto \partial_{\infty}(\Gamma; \mathcal{F})$, all of which are well-defined independent of the choice of S, T and f; this homeomorphism is equivariant not just with respect to the actions of Γ but also with respect to the extended actions of the subgroup

$$\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F}) = \operatorname{Aut}(\Gamma; \mathcal{A}) \cap \operatorname{Aut}(\Gamma; \mathcal{F}) \leqslant \operatorname{Aut}(\Gamma)$$

which contains the inner automorphism group $\operatorname{Inn}(\Gamma) \approx \Gamma$.

Examples of the subboundary correspondence. Here are some simple examples that can be understood using collapse maps, without bounded cancellation. Consider the rank 3 free group $\Gamma = \langle a, b, c \rangle$ and the free factor system $\mathcal{F} = \{\langle a \rangle\}$. The Cayley tree *S* of the generating set $\{a, b, c\}$ is a free splitting of Γ rel $\mathcal{A} = \emptyset$, and by collapsing every *a*-edge of *S* one obtains a Grushko free splitting *T* of Γ relative to \mathcal{F} with corresponding collapse map $S \xrightarrow{[\alpha]} T$ where $\alpha \subset S$ is the subforest of edges labelled *a*; the components of α are precisely the axes of subgroups conjugate to $\langle a \rangle$. There is no equivariant homeomorphism $\partial_{\infty}S \to \partial_{\infty}T$. Nonetheless, after removing from $\partial_{\infty}S$ the ideal endpoints of components of α we obtain the subboundary ∂_TS and a natural induced bijection $\partial_T S \to \partial S$, and this bijection is an equivariant homeomorphism with respect to the subspace topology on $\partial_T S$ that is induced by the end topology on ∂S .

One can continue onto another example using the free factor systems $\mathcal{A}' = \mathcal{F}$ and $\mathcal{F}' = \{\langle a, b \rangle\}$ of Γ : from a collapse map $S' = T \xrightarrow{[\beta]} T'$ where β is the subforest of (the images in T of) edges labelled b, one obtains a Grushko free splitting T' of Γ relative to \mathcal{F}' , a subboundary $\partial_{T'}S' \subset \partial_{\infty}S'$ by removing the ideal endpoints of each component of β , and an equivariant subboundary homeomorphism $\partial_{T'}S' \approx \partial_{\infty}T'$.

Defining the subboundary correspondence. Consider now a nested pair of free factor systems $\mathcal{A} \sqsubset \mathcal{F}$ of Γ , a Grushko free splitting S of Γ rel \mathcal{A} , a Grushko free splitting T of Γ rel \mathcal{F} , and an equivariant map $f: S \to T$. Recall that each $\xi \in \partial_{\infty}S$ is represented by an asymptotic family of rays $[v,\xi) \subset S$, one for each $v \in S$. One may consider the image $f[v,\xi) \subset T$ and ask whether $f[v,\xi)$ has finite or infinite diameter in T. This property of ξ is well-defined independent of v, because for any two $v_1, v_2 \in S$, the symmetric difference closure $[v_1, \xi) \Delta[v_2; \xi]$ is identical to the line segment $[v_1, v_2]$, the f-image of which is the finite diameter subset $f[v_1, v_2] \subset T$, hence $f[v_1,\xi)$ and $f[v_2,\xi)$ have finite Hausdorff distance in T. The T-subboundary of S is defined as the subspace $\partial_T S \subset \partial_\infty S$ consisting of those $\xi \in \partial_\infty S$ for which $f[v,\xi)$ has infinite diameter in T. The subset $\partial_T S$ is well-defined independent of the choice of f, because any two equivariant maps $f, f': S \mapsto T$ are boundedly equivalent, meaning that $\max_{x \in S} d_T(f(x), f'(x)) < \infty$ (the maximum is achieved on any finite subtree of S whose Γ -orbit covers S), and therefore $f[v,\xi)$, $f'[v,\xi)$ have finite Hausdorff distance in T for all $v \in T$ and all $\xi \in \partial T$. Note that the subset $\partial_T S$ is invariant under the action of Γ on ∂S , for the following reasons. For any $\xi \in S - \partial_T S$ and any $v \in S$ the set $f[v,\xi)$ has finite diameter in T, and it follows for each $\gamma \in \Gamma$ that the set $f[\gamma \cdot v, \gamma \cdot \xi) = f(\gamma \cdot [v, \xi)) = \gamma \cdot f[v, \xi)$ has finite diameter in T, hence $\gamma \cdot \xi \in S - \partial_T S$.

In the following lemma we apply the bounded cancellation lemma for finite paths; see [HM22, Section 4.1.4] for a discussion the origins of this lemma in [Coo87] and in [BFH97, Section 3], and see [HM22, Lemma 4.14] for the specific version we will be applying together with elements of its proof.
Lemma 3.1. For any free factor systems $\mathcal{A} \sqsubset \mathcal{F}$ of Γ , any equivariant map $f: S \to T$ from a Grushko free splitting S of Γ rel \mathcal{A} to a Grushko free splitting T of Γ rel \mathcal{F} induces a map $\partial f: \partial_T S \to \partial_{\infty} T$ that satisfies the following properties:

(1) ∂f is a homeomorphism, and is characterized by the following property: for each $\xi \in \partial_T S$ its image $\partial f(\xi) \in \partial_{\infty} T$ is the unique point satisfying the following (with constant C depending only on f and on chosen equivariant geodesic metrics on S and T):

Bounded Cancellation for Rays: For each $p \in S$ we have

$$[f(p), \partial f(\xi)) \subset f[p,\xi) \subset N_C[f(p), \partial f(\xi))$$

- (2) $f \cup \partial f \colon S \cup \partial_T S \to T \cup \partial_\infty T$ is continuous with respect to end topologies.
- (3) ∂f is well-defined independent of the choice of f.
- (4) If f is a collapse map then $[f(p), \partial f(\xi)) = f[p, \xi)$ for all $p \in S$ and $\xi \in \partial_T S$.
- (5) The subset $\partial_T S \subset \partial_{\infty} S$ is invariant under the action $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F}) \curvearrowright \partial_{\infty} S$, and the map ∂f is equivariant with respect to the actions of $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F})$ on $\partial_T S$ and on $\partial_{\infty} T$.

Proof of Lemma 3.1. We wish to apply [DT17, Theorem 3.2], so we start by verifying the hypotheses of that theorem. One hypothesis is that f is surjective, which follows by continuity of f and minimality of the Γ action on T. Another is that f is Lipschitz, which follows from existence of a finite subtree of S whose Γ -orbit covers S. The remaining hypothesis says that f is alignment preserving, meaning that there exists a constant $D \ge 0$ such that for all $x, y, z \in S$ the following implication holds:

$$d_S(x,y) + d_S(y,z) = d_S(x,z) \implies d_T(f(x), f(y)) + d_T(f(y), f(x)) \le d_T(f(x), f(z)) + D$$

We prove this by applying bounded cancellation to the path $[x, z] \subset S$, as follows. As in any tree equipped with a geodesic metric, from the equation $d_S(x, y) + d_S(y, z) = d_S(x, z)$ it follows that $y \in [x, z]$. Let p be the unique point of [f(x), f(z)] closest to f(y). We may now the bounded cancellation lemma for finite paths in S, namely [HM22, Lemma 4.14 (1)] (which applies even when $\mathcal{A} \neq \mathcal{F}$). From that lemma we obtain $f[x, z] \subset N_C[f(x), f(z)]$ with cancellation constant Cdepending only on f, and hence $d_T(p, f(y)) \leq C$. Noting that $p \in [f(x), f(y)]$ and $p \in [f(y), f(z)]$, we have

$$d_T(f(x), f(y)) + d_T(f(y), f(z)) = \left(d_T(f(x), p) + d_T(p, f(y)) \right) + \left(d_T(f(y), p) + d_T(p, f(z)) \right)$$

= $\left(d_T(f(x), p) + d_T(p, f(z)) \right) + 2d_T(p, f(y))$
 $\leq d_T(f(x), f(z)) + 2C$

With D = 2C, this completes verification of the hypotheses of [DT17, Theorem 3.2].

Applying [DT17, Theorem 3.2] and its proof, we obtain the homeomorphism $\partial f: \partial_T S \to \partial T$, and the extension $f \cup \partial f$ satisfies all the conclusions of (2). To complete the proof of (1), consider any $p \in S$ and $\xi \in \partial_T S$, and let $\eta = \partial f(\xi) \in \partial_{\infty} T$. The following statement may be found in the proof of [DT17, Theorem 3.2]:

(*) There exists a sequence (w_i) in $f[p,\xi)$ that converges to η in $\overline{T} = T \cup \partial_{\infty} T$.

We now apply the proof of [HM22, Lemma 4.14 (2)], where it is shown that statement (*) implies bounded cancellation for rays and the uniqueness of $\eta = \partial f(\xi)$.[†]

Conclusion (3) follows, as in earlier arguments, using that any two equivariant maps $S \mapsto T$ are boundedly equivalent. To prove conclusion (4), assume that $f[v,\xi) \not\subset [f(v),\partial f(\xi))$, choose $y \in [v,\xi)$ such that $f(y) \not\in [f(v),\partial f(\xi))$, and let $p \in [f(v),\partial f(\xi))$ be the point closest to f(y). The segment [f(v), y] and the ray $[f(y), \partial f(\xi))$ both contain the point p; choose $x \in [v, y)$ and $z \in (y, \partial \xi)$ such that f(x) = f(z) = p. Since $y \in [x, z]$ and $f(y) = p \notin f[x, z]$, the set $f^{-1}(p)$ is disconnected, contradicting the definition of a collapse map.

It remains to prove conclusion (5). We have seen already that $\partial_T S$ is invariant under the action $\Gamma \curvearrowright \partial_{\infty} S$, and we next show that the map $\partial f: \partial_T S \to \partial_{\infty} T$ is Γ -equivariant with respect to the action of Γ . Consider any $\xi \in \partial_T S$ and $\gamma \in \Gamma$, let $\rho = [v, \xi) \subset S$ be a ray representing ξ , and so $\gamma \cdot \rho = [\gamma \cdot v, \gamma \cdot \xi) \subset S$ is a ray representing $\gamma \cdot \xi \in \partial_T S$. By bounded cancellation for rays it follows that $f(\gamma \cdot \rho) = f[\gamma \cdot v, \gamma \cdot \xi)$ has finite Hausdorff distance in T from the ray $[f(\gamma \cdot v), \partial f(\gamma \cdot \xi))$ representing $f(\gamma \cdot \xi) \in \partial_{\infty} T$. Also by bounded cancellation for rays, it follows that $f[v, \xi)$ has finite Hausdorff distance in T from the ray $[f(\gamma), \partial f(\xi))$ representing $\partial f(\xi) \in \partial_{\infty} T$. The point $\gamma \cdot \partial f(\xi) \in \partial_{\infty} T$, which is represented by the ray

$$[f(\gamma \cdot v), \gamma \cdot \partial f(\xi)) = [\gamma \cdot f(v), \gamma \cdot \partial f(\xi)) = \gamma \cdot [f(v), \partial f(\xi))$$

therefore has finite Hausdorff distance in T from the ray $\gamma \cdot f[v,\xi) = f(\gamma \cdot [v,\xi)) = f(\gamma \cdot \rho)$ which, as we have seen, has finite Hausdorff distance in T from a ray representing $f(\gamma \cdot \xi)$. It follows that $\gamma \cdot \partial f(\xi) = f(\gamma \cdot \xi)$.

We next prove that $\partial_T S$ is invariant under the action $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F}) \curvearrowright \partial_{\infty} S$. The given action $\Gamma \cap \partial_{\infty} S$ extends to an action $\operatorname{Aut}(\Gamma; \mathcal{A}) \cap \partial_{\infty} S$ such that each element $\Phi \in \operatorname{Aut}(\Gamma; \mathcal{A})$ acts by the unique Φ -twisted equivariant homeomorphism of $\partial_{\infty}S$, by applying [HM22, Lemma 4.1]. Also applying the same lemma, for each $\Phi \in Aut(\Gamma; \mathcal{A}, \mathcal{F})$ there exist Φ^{-1} -twisted equivariant maps $h: S \to S$ and $k: T \to T$ inducing maps $\partial_{\infty} h: \partial_{\infty} S \to \partial_{\infty} S$ and $\partial_{\infty} k: \partial_{\infty} T \to \partial_{\infty} T$, each of which, on its respective domains, is the unique Φ^{-1} -twisted equivariant homeomorphisms. In particular we have the identity $\partial_{\infty} h(\eta) = \Phi^{-1} \cdot \eta$ for each $\eta \in \partial_{\infty} S$. The two maps $f \circ h$, $k \circ f \colon S \to T$ are both Φ^{-1} -twisted equivariant, each being a composition (in one order or another) of a Φ^{-1} -twisted equivariant map and an (Id-twisted) equivariant map. It follows that $f \circ h$ and $k \circ f$ are boundedly equivalent: the distance between the values of two Φ^{-1} -twisted equivariant simplifical maps of S is bounded by the maximum distance over a finite subtree of S whose translates cover S. Consider now $\xi \in \partial_T S$ and $\Phi \cdot \xi \in \partial_\infty S$, hence $\partial_\infty h(\Phi \cdot \xi) = \Phi^{-1} \cdot \Phi \cdot \xi = \xi$. Choose any $p \in S$ and consider the ray $[p, \Phi \cdot \xi) \subset S$. Its image $h[p, \Phi \cdot \xi)$ is Hausdorff close to $[h(p),\xi)$. Since $\xi \in \partial_T S$ it follows that $f[h(p),\xi) \subset T$ has infinite diameter in T; therefore $f(h[p, \Phi \cdot \xi)) = (f \circ h)[p, \Phi \cdot \xi)$ also has infinite diameter in T. By bounded equivalence of $f \circ h$ and $k \circ f$, it follows that $(k \circ f)[p, \Phi \cdot \xi) = k(f[p, \Phi \cdot \xi))$ has infinite diameter in T. Since k is Lipschitz, it follows that $f[p, \Phi \cdot \xi)$ has infinite diameter in T, proving that $\Phi \cdot \xi \in \partial_T S$. Since this holds for any $\Phi \in \operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F})$ and any $\xi \in \partial_T S$, the proof of $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F})$ -invariance of $\partial_T S$ is complete.

Restricting the action $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F}) \curvearrowright \partial S$ to $\partial_T S$, each $\Phi \in \operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F})$ acts by a Φ -twisted equivariant homeomorphism of $\partial_T S$. Conjugating via the equivariant homeomorphism ∂f we

[†]In [HM22, Lemma 4.14 (2)] where bounded cancellation for rays is proved under the stronger hypothesis $\mathcal{A} = \mathcal{F}$, that hypothesis was used to derive statement (*); the remainder of the proof did not depend on that hypothesis, it used only statement (*).

obtain a Φ -twisted equivariant homeomorphism of $\partial_{\infty}T$. But [HM22, Lemma 4.1] tells us that there is a unique Φ -twisted equivariant homeomorphism of $\partial_{\infty}T$, namely, the action of $\Phi \in$ $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F}) \leq \operatorname{Aut}(\Gamma; \mathcal{F})$ as an element of the unique action $\operatorname{Aut}(\Gamma; \mathcal{F}) \curvearrowright \partial_{\infty}T$ that extends the given action $\Gamma \curvearrowright \partial_{\infty}T$. Putting this altogether, we have shown that ∂f is $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F})$ equivariant. \diamondsuit

Remark. Regarding conclusion (4) of Lemma 3.1, one can observe that an equivariant simplicial map $f: S \to T$ of free splittings is a collapse map if and only if C = 0 is a cancellation constant for f.

A canonical version of the subboundary correspondence. Consider again a nested pair $\mathcal{A} \sqsubset \mathcal{F}$ of free factor systems of Γ . Define the \mathcal{F} -subboundary of Γ rel \mathcal{A} to be

$$\partial_{\mathcal{F}}(\Gamma; \mathcal{A}) = \partial_{\infty}(\Gamma; \mathcal{A}) - \bigcup_{F} \partial_{\infty}(F; \mathcal{A} \mid F)$$

where the union is taken over all nonatomic free factors F of Γ rel \mathcal{A} such that $[F] \in \mathcal{F}$ (c.f. the earlier *Examples of the subboundary correspondence*).

In Lemma 3.3 below we recast the subboundary correspondence in the language of the canonical boundaries $\partial_{\infty}(\Gamma; \mathcal{A})$: in brief, the lemma says that the inclusion map $\partial_{\mathcal{F}}(\Gamma; \mathcal{A}) \hookrightarrow \partial_{\infty}(\Gamma; \mathcal{A})$ corresponds to the subboundary homeomorphism $\partial_T S \mapsto \partial T$ for any Γ -equivariant map $f: T \to S$ from a Grushko free splitting rel \mathcal{A} to a Grushko free splitting rel \mathcal{F} .

Our statement of Lemma 3.3 is expressed in terms of the bounded distance category of free splittings of Γ , which has for its objects the class of free splittings of Γ , and for its morphisms the bounded equivalence classes of the set of equivariant simplicial maps $S \mapsto T$ from one free splitting S to another T. But of course any two such maps are boundedly equivalent, hence there is either no morphism at all from S to T or there is a unique morphism; furthermore, a morphism exists if and only if $\mathcal{F}_{ell}S \sqsubset \mathcal{F}_{ell}T$ (see the opening passages of Section 3.2). Together with the fact that every nonfull free factor system \mathcal{A} of Γ can indeed be realized as $\mathcal{A} = \mathcal{F}_{ell}S$ for some free splitting S of Γ [HM14, Lemma 3.1], we summarize as follows:

Lemma 3.2. The bounded distance category of free splittings of Γ is equivalent, as a category, to the poset of nonfull free factor systems of Γ with respect to the partial ordering $\mathcal{A} \sqsubset \mathcal{B}$.

Here is our "canonical" version of the subboundary correspondence:

Lemma 3.3. There is a contravariant functor from the poset of free factor systems of Γ to the category of topological spaces equipped with a Γ -action, which assigns to each nonfilling free factor system \mathcal{A} of Γ the space $\partial_{\infty}(\Gamma; \mathcal{A})$, and to each nested pair of nonfilling free factor systems $\mathcal{A} \sqsubset \mathcal{F}$ a Γ -equivariant embedding $I_{\mathcal{A}}^{\mathcal{F}} : \partial_{\infty}(\Gamma; \mathcal{F}) \to \partial_{\infty}(\Gamma; \mathcal{A})$, such that the following hold:

- (1) $image(I_{\mathcal{A}}^{\mathcal{F}}) = \partial_{\mathcal{F}}(\Gamma; \mathcal{A}),$
- (2) $I_{\mathcal{A}}^{\mathfrak{F}}$ is equivariant with respect to the actions on its domain and range of the group Aut $(\Gamma; \mathcal{A}, \mathfrak{F}) = \operatorname{Aut}(\Gamma; \mathcal{A}) \cap \operatorname{Aut}(\Gamma; \mathfrak{F})$
- (3) For any equivariant map $f: S \to T$ from a Grushko free splitting S rel A to a Grushko free splitting T rel \mathcal{F} we have the following Γ -equivariant commutative diagram of homeomorphims, injections, and the embedding $I_{\mathcal{A}}^{\mathcal{F}}$, and hence $\partial_T S = I_S(\partial_{\mathcal{F}}(\Gamma; \mathcal{A}))$:



Proof. In the commutative diagram shown we have already defined all spaces and their Γ -actions, and we have defined all arrows *except* for the blue ones, namely: the black arrows \hookrightarrow denoting equivariant injections; and the black arrows $\approx >$ denoting equivariant homeomorphisms. The blue embedding arrow $I_{\mathcal{A}}^{\mathcal{F}}$ is uniquely determined by the commutativity requirement:

$$I_{\mathcal{A}}^{\mathcal{F}} = (I_S)^{-1} \circ j \circ (\partial f)^{-1} \circ I_T$$

As for equivariance properties: the I_T and I_S homeomorphism arrows are Aut(Γ ; \mathcal{F})-equivariant (see the passages following [HM22, Lemma 4.1]); the ∂f homeomorphism arrow and its inverse are Aut(Γ ; \mathcal{A} , \mathcal{F})-equivariant (by Lemma 3.1 (5)); the subset $\partial_T S$ of $\partial_{\infty} S$ is invariant under the action of Aut(Γ ; \mathcal{A} , \mathcal{F}) (by Lemma 3.1 (5)) and so the j inclusion arrow is Aut(Γ ; \mathcal{A} , \mathcal{F})-equivariant. It follows that $I_{\mathcal{A}}^{\mathcal{F}}$ is Aut(Γ ; \mathcal{A} , \mathcal{F}) equivariant, and in particular is Γ -equivariant.

The main steps that remain to be shown are:

Step 1: $I_{\mathcal{A}}^{\mathcal{F}}$ is well-defined independent of the choice of $f: S \to T$,

- **Step 2:** image $(I_{\mathcal{A}}^{\mathcal{F}}) = \partial_{\mathcal{F}}(\Gamma; \mathcal{A})$, verifying conclusion (1).
- **Step 3:** Contravariance: for any triple of nonfilling free factor systems $\mathcal{A} \sqsubset \mathcal{B} \sqsubset \mathcal{F}$ of Γ we have $I_{\mathcal{A}}^{\mathcal{B}} \circ I_{\mathcal{B}}^{\mathcal{F}} = I_{B}^{\mathcal{F}} : \partial_{\infty}(\Gamma; \mathcal{F}) \to \partial_{\infty}(\Gamma; \mathcal{A}).$

Once Steps 1 and 2 are complete, the remaining blue equivariant homeomorphism arrows $\approx >$ are uniquely determined by the commutativity requirement, verifying conclusion (3).

Step 1: Consider two equivariant maps $f: S \to T$ and $f': S' \to T'$ from Grushko free splittings S, S' rel \mathcal{A} to Grushko free splittings T, T' rel \mathcal{F} . Choosing equivariant maps $h: T \to T'$ and $g: S \to S'$, the first diagram below coarsely commutes. By chasing around that first diagram we obtain (the black portion of) the second diagram, a commutative diagram of Γ -equivariant homeomorphisms and inclusions:



In that second diagram, the two (partially red) triangles involving homeomorphisms from $\partial_{\infty}(\Gamma; \mathcal{F})$ and from $\partial_{\infty}(\Gamma; \mathcal{A})$ are already known to commute. It follows that $I_{\mathcal{A}}^{\mathcal{F}}$ is well-defined.

It remains to verify the diagram chase; here are a few details. Given $\xi \in \partial_T S$ and any representative ray $[v,\xi) \subset S$, the T image $f[v,\xi)$ has infinite diameter and has finite Hausdorff distance from the ray $[f(v), \partial f(\xi))$ (Lemma 3.1). Since h is a quasi-isometry, the T' images $h[f(v), \partial f(\xi))$ and $h \circ f[v,\xi)$ have finite Hausdorff distance from each other and from the ray $[h(f(v)), \partial h(\partial f(\xi)))$. Since g is a quasi-isometry, the S' image $g[v,\xi)$ has finite Hausdorff distance from the ray $[g(v), \partial g(\xi))$, and so their T' images $f' \circ g[v,\xi)$ and $f'[g(v), \partial g(\xi))$ have finite Hausdorff distance from each other; by coarse commutativity, they also have finite Hausdorff distance from $h \circ f[v,\xi)$ and hence also from the ray $[h(f(v)), \partial h(\partial f(\xi)))$. It follows that $f'[g(v), \partial g(\xi))$ has infinite diameter, proving that $\partial g(\xi) \in \partial_{T'}(S')$. This argument proves that the inclusion $\partial g(\partial_T S) \subset \partial_{T'}(S')$ holds, as does the commutativity relation $\partial h \circ \partial f = \partial f' \circ (\partial g \mid \partial_T S)$. The reverse inclusion $\partial_{T'}(S') \subset \partial g(\partial_T S)$ follows by a similar diagram chase using equivariant coarse inverses of g and h, hence the restriction $\partial g \mid \partial_T S$ is a homeomorphism $\partial_T S \approx \partial_{T'} S'$.

Step 2: Applying Step 1, to prove the equation $I_S(\partial_{\mathcal{F}}(\Gamma; \mathcal{A})) = \partial_T S$ for every equivariant map $f: S \to T$ from a Grushko free splitting S rel \mathcal{A} to a Grushko free splitting T rel \mathcal{F} , it suffices to prove that equation for just one choice of such a map. We choose S to be a free splitting of Γ rel \mathcal{A} in which the free factor system \mathcal{F} is visible (see Section 2.1). It follows that there is a Γ -invariant subforest $\sigma \subset S$ such that $\mathcal{F}\sigma = \mathcal{F}$ (see the earlier *Examples of the subboundary* correspondence). We may assume that the components of σ are precisely the minimal subtrees $S_F \subset S$ for the actions of those free factors $F \leq \Gamma$ such that $[F] \in \mathcal{F}$: we first replace σ by its union with the set of vertices of S having nontrivial stabilizer; we then discard components of σ having trivial stabilizer; and finally we replace each component of σ obtained by collapsing each component of σ to a point, and we choose $f: S \xrightarrow{\langle \sigma \rangle} T$ to be the collapse map.

Given an end $\xi \in \partial_{\infty}S$ with corresponding point $I_S^{-1}(\xi) \in \partial_{\infty}(\Gamma; \mathcal{A})$, we must prove the

following equivalence:

$$\xi \in \partial_T S \iff I_S^{-1}(\xi) \in \partial_{\mathcal{F}}(\Gamma; \mathcal{A})$$

Pick a vertex $v \in S$.

Case 1: The ray $[v,\xi)$ contains only finitely many edges of $S \setminus \sigma$. In this case we prove both sides of the equivalence are false. First, clearly the T image $f[v,\xi)$ consists of finitely many edges and hence has finite diameter in T, implying that $\xi \notin \partial_T S$. Also, choosing a vertex $w \in [v,\xi)$ beyond the finitely many edges of the intersection $[v,\xi) \cap \sigma$, it follows that the $[w,\xi) \subset \sigma$. By connectivity, $[w,\xi)$ lies entirely in some component S_F of σ . It follows that $\xi \in \partial_{\infty} S_F$, hence $I_S^{-1}(\xi) \in \partial(F; \Gamma \mid A)$, and therefore $I_S^{-1}(\xi)\xi \notin \partial_T(\Gamma; A)$.

Case 2: $[v,\xi)$ contains infinitely many edge of $S \setminus \sigma$. In this case we prove both sides of the equivalence are true. Enumerate the edges of $[v,\xi) \cap (S \setminus \sigma)$, in order along $[v,\xi) \cap (S \setminus \sigma)$ in order along $[v,\xi)$, as E_1, E_2, E_3, \ldots . It follows that $f[v,\xi) = f(E_1)f(E_2)f(E_3)\cdots$ is an infinite ray in T and hence has infinite diameter, proving that $\xi \in \partial_T S$. Also, consider any nonatomic free factor $F \leq \Gamma$ representing an element $[F] \in \mathcal{F}_A$, and consider the corresponding component S_F of σ . The intersection $[v,\xi) \cap S_F$ is connected, and if it were infinite then it would be a ray comprising all but finitely many edges of $[v,\xi)$, contradicting that $[v,\xi)$ has infinitely many edges not in σ . It follows that $[v,\xi) \cap S_F$ is finite, hence $\xi \notin \partial_\infty S_F$ and $I_S^{-1}(\xi) \notin \partial(F;\Gamma \mid A)$. Since this holds for any F, it follows that $I_S^{-1}(\xi) \in \partial_F(\Gamma; A)$.

Step 3: Applying Lemma 3.1 and the earlier steps, it suffices to consider Γ -equivariant maps $S \xrightarrow{f} T \xrightarrow{g} U$ where S, T, U are Grushko free splittings with respect to \mathcal{A} , \mathcal{B} and \mathcal{F} respectively, and to prove that for all $\xi \in \partial_T S$, $\eta \in \partial_U T$ and $\zeta \in \partial_\infty U$, if $\partial f(\xi) = \eta$ and $\partial g(\eta) = \zeta$ then $\xi \in \partial_U S$ and $\partial(g \circ f)(\xi) = \zeta$. This is again a diagram chase argument. Picking $v \in S$, applying Lemma 3.1 it follows first that $f[v,\xi)$ has infinite diameter and is Hausdorff close to $[f(v), \eta)$. Applying that lemma again it follows that $g[f(v), \eta)$ has infinite diameter and is Hausdorff close to $[g(f(v)), \zeta)$. But $g \circ f[v, \xi)$ is Hausdorff close to $g[f(v), \eta)$ and hence $g \circ f[v, \xi)$ has infinite diameter, proving that $\xi \in \partial_U S$; and furthermore $g \circ f[v, \xi)$ is Hausdorff close to $[g(f(v)), \zeta)$ proving that $\partial(g \circ f)(\xi) = \zeta$.

3.3 Line spaces under collapse.

We first recollect notations and concepts regarding line spaces of a group Γ relative to a free factor system \mathcal{A} (see [HM22, Section 4.1.2] which follows [GH19] and [Lym22a]). Then, in Lemma/Definition 3.4, we describe a correspondence of bi-infinite lines spaces that is induced by the Dowdall–Taylor correspondence of end spaces.

By combining the double space construction [HM22, Section 4.1.1], the boundary identifications $I_T: \partial(\Gamma; \mathcal{A}) \approx \partial T$, and the end subspace identifications $I_T: \partial_{\infty}(\Gamma; \mathcal{A}) \approx \partial_{\infty} T$ (as Tvaries over free splittings of Γ rel \mathcal{A}), one obtains line spaces and bi-infinite line subspaces with identifications and inclusions as follows:

$$\widetilde{\mathcal{B}}(\Gamma;\mathcal{A}) = \partial(\Gamma;\mathcal{A})^{\{2\}} \approx \partial T^{\{2\}} = \widetilde{\mathcal{B}}T$$

$$\int \int \int \int \int \int \mathcal{B}_{\infty}(\Gamma;\mathcal{A}) = \partial_{\infty}(\Gamma;\mathcal{A})^{\{2\}} \approx \partial_{\infty}T^{\{2\}} = \widetilde{\mathcal{B}}_{\infty}T$$

All arrows in this diagram are equivariant with respect to the action of Γ and the extended action of Aut($\Gamma; \mathcal{A}$). The group Out($\Gamma; \mathcal{A}$) acts on Γ -invariant subsets of each space in this diagram, and we obtain an induced Out($\Gamma; \mathcal{A}$)-equivariant diagram of sets of Γ -invariant subsets.

After some further notation review, for the remainder of the section we will mostly focus on the second line of the diagram above, for purposes of applying the Dowdall–Taylor correspondence on the level of bi-infinite lines.

Given $\ell \in \mathcal{B}(\Gamma; \mathcal{A})$ and a free factor system \mathcal{F} , to say that ℓ is carried by or supported by \mathcal{F} means that there exists $F \leq \Gamma$ such that $[F] \in \mathcal{F}$ and $\xi, \eta \in \partial(F; \mathcal{A} \mid F) \subset \partial(\Gamma; \mathcal{A})$. Given any subset $L \subset \widetilde{\mathcal{B}}(\Gamma; \mathcal{A})$, to say that a free factor system \mathcal{F} supports L means that for each $\ell = \{\xi, \eta\} \in L$ there exists $F \leq \Gamma$ such that $[F] \in \mathcal{F}$ and $\xi, \eta \in \partial(F; \mathcal{A} \mid F) \subset \partial(\Gamma; \mathcal{A})$. The unique free factor system that supports L and is minimal with respect to the partial order \sqsubset is called the *free factor support* of L; for the proof of existence and uniqueness see [HM22, Lemma 4.2] following [Lym22a, Corollary 4.12]. To say that L fills Γ rel \mathcal{A} means that its free factor support equals $\{[\Gamma]\}$, equivalently L is not supported by any nonfull free factor system rel \mathcal{A} .

An individual element $\ell = \{\xi, \eta\} \in \mathfrak{B}_{\infty}(\Gamma; \mathcal{A})$ is called a *bi-infinite line* of Γ rel \mathcal{A} with *ideal* endpoints $\xi, \eta \in \partial_{\infty}(\Gamma; \mathcal{A})$. For any Grushko free splitting T of Γ rel \mathcal{A} the concrete realization of ℓ in T, denoted either $\ell_T \subset T$ or $\ell(T)$, is the unique line in T whose closure in $\overline{T} = T \cup \partial_{\infty} T$ is $T \cup \{\xi, \eta\}$ (using I_T to identify $\xi, \eta \in \partial_{\infty} T$). Given a bi-infinite line $\ell \in \mathfrak{B}_{\infty}(\Gamma; \mathcal{A})$ and a Grushko free splitting T of Γ rel \mathcal{A} , to say that the concrete realization $\ell_T \subset T$ is birecurrent in T means that for any finite path $\alpha \subset \ell_T$ and any subray $\rho \subset \ell_T$ there exists $\gamma \in \Gamma$ such that $\gamma \cdot \alpha \subset \rho$. As shown in [Lym22a, Lemma 4.1], *birecurrence of* $\ell \in \widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A})$ is well-defined, independent of the choice of Grushko free splitting T rel \mathcal{A} , by requiring that its concrete realization ℓ_T be birecurrent.

For any nested pair of free factor systems $\mathcal{A} \sqsubset \mathcal{F}$, the boundary embedding $I_{\mathcal{A}}^{\mathcal{F}} : \partial_{\infty}(\Gamma; \mathcal{F}) \approx \partial_{\mathcal{F}}(\Gamma; \mathcal{A}) \hookrightarrow \partial_{\infty}(\Gamma; \mathcal{A})$ given by Lemma 3.3 induces an embedding of line spaces

$$\underbrace{\widetilde{\mathcal{B}}_{\infty}(\Gamma;\mathcal{F})}_{\partial_{\infty}(\Gamma;\mathcal{F})^{\{2\}}} \approx \underbrace{\widetilde{\mathcal{B}}_{\mathcal{F}}(\Gamma;\mathcal{A})}_{\partial_{\mathcal{F}}(\Gamma;\mathcal{A})^{\{2\}}} \hookrightarrow \underbrace{\widetilde{\mathcal{B}}_{\infty}(\Gamma;\mathcal{A})}_{\partial_{\infty}(\Gamma;\mathcal{A})^{\{2\}}}$$

and this embedding is equivariant with respect to the action of $\operatorname{Aut}(\Gamma; \mathcal{A}, \mathcal{F})$.

In our next result we take advantage of the embedding above in order to extend the concept of "concrete realization" of an abstract line in $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A})$ beyond the case of Grushko free splittings rel \mathcal{A} , making that concept apply to all free splittings rel \mathcal{A} , but we do this at some cost: we require that the given line be birecurrent; and the "concrete realization" will not always be a concrete line, it could also be a point.

In the statement and later applications of the following lemma, for each nonfull free factor system \mathcal{F} of Γ rel \mathcal{A} we identify $\widetilde{\mathcal{B}}_{\mathcal{F}}(\Gamma; \mathcal{A})$ with its embedded image in $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A})$. Also, for each proper free factor $F \leq \Gamma$ rel \mathcal{A} we identify $\partial_{\infty}(F; \mathcal{A} \mid F)$ with its embedded image in $\partial_{\infty}(\Gamma; \mathcal{A})$, and then in turn we identify $\widetilde{\mathcal{B}}_{\infty}(F; \mathcal{A} \mid F) = \partial_{\infty}(F; \mathcal{A} \mid F)^{\{2\}}$ with its image under the induced embedding in $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A}) = \partial_{\infty}(\Gamma; \mathcal{A})^{\{2\}}$.

Lemma/Definition 3.4. For any nonfull free factor system \mathcal{F} of Γ rel \mathcal{A} and any birecurrent abstract line $\ell = \{\xi, \eta\} \in \widetilde{\mathbb{B}}_{\infty}(\Gamma; \mathcal{A})$ exactly one of the following holds:

Case 1: $\ell \in \widetilde{\mathcal{B}}_{\mathcal{F}}(\Gamma; \mathcal{A}); or$

Case 2: There exists a unique proper free factor $F_{\ell} \subset \Gamma$ rel \mathcal{A} such that $[F_{\ell}] \in \mathcal{F}$ and such that $\ell \in \widetilde{\mathcal{B}}_{\infty}(F_{\ell}; \mathcal{A} \mid F_{\ell})$.

For any Grushko free splitting T of Γ rel \mathcal{F} the concrete realization of ℓ in T, a subset denoted $\ell_T \subset T$, is defined as follows:

Case 1 realization, a line: $\ell_T \subset T$ is the concrete realization of the abstract line $\ell_{\mathcal{F}} \in \widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{F}) \approx \widetilde{\mathcal{B}}_{\infty}T$ that is identified with ℓ under the homeomorphism $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{F}) \approx \widetilde{\mathcal{B}}_{\mathcal{F}}(\Gamma; \mathcal{A}).$

Case 2 realization, a point: ℓ_T is a singleton, namely the unique point of T fixed by F_{ℓ} .

Furthermore, using this definition of ℓ_T we have:

Bounded Cancellation for lines: For any Grushko free splitting S of Γ rel A and any map $f: S \to T$ with cancellation constant C:

$$\ell_T \subset f(\ell_S) \subset N_C(\ell_T)$$

If in addition f is a collapse map then $f(\ell_S) = \ell_T$.

Proof. We first verify the case analysis. Because the subsets $\widetilde{\mathcal{B}}_{\mathcal{F}}(\Gamma; \mathcal{A})$ and $\widetilde{\mathcal{B}}_{\infty}(F; \mathcal{A} \mid F)$ form a pairwise disjoint collection in $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A})$ as F varies, clearly cases 1 and 2 are mutually exclusive, and the free factor F in case 2 is unique, if it exists. To prove that one of cases 1 or 2 actually occurs, choose S to be a free splitting rel \mathcal{A} in which the free factor system \mathcal{F} is visible. For each free factor $F \subset \Gamma$ rel \mathcal{A} , consider the minimal subtree S_F for the restricted action $F \curvearrowright S$, and so the inclusion $S_F \hookrightarrow S$ induces the embedding $\partial_{\infty}(F; \mathcal{A} \mid F) \approx \partial_{\infty}S_F \hookrightarrow \partial_{\infty}S \approx \partial_{\infty}(\Gamma; \mathcal{A})$. Because of the visibility assumption, as F varies the subtrees S_F are pairwise disjoint, and we have a Γ -invariant subforest with component decomposition $\bigsqcup_F S_F \subset S$. We break into two cases depending on the relation in S between that subforest and the concrete realization $\ell_S \subset S$ of ℓ .

Case 1 Hypothesis: $\ell_S \not\subset \bigsqcup_F S_F$. We shall prove that

$$\ell \in \widetilde{\mathcal{B}}_{\mathcal{F}}(\Gamma; \mathcal{A}) = \widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A}) - \bigsqcup_{F} \partial(F; \mathcal{A} \mid F) \approx \partial_{\infty}S - \bigsqcup_{F} \partial_{\infty}S_{F}$$

Given any F and any ray in S, that ray represents a point of $\partial_{\infty}S_F$ if and only if one of its subrays is contained in S_F . It therefore suffices to choose any ray $\rho \subset \ell_S$ and prove that $\rho \not\subset \bigsqcup_F \partial_{\infty}S_F$. Using the case hypothesis, there exists an edge $e \subset \ell_S$ such that $e \not\subset \bigsqcup_F S_F$. Since $\bigsqcup_F S_F$ is Γ invariant, it follows for all $\gamma \in \Gamma$ that $\gamma \cdot e \not\subset \bigsqcup_F S_F$. Using birecurrence of ℓ , there exists $\gamma \in \Gamma$ such that $\gamma \cdot e \subset \rho$, and therefore $\rho \not\subset \bigsqcup_F S_F$.

Case 2 Hypothesis: $\ell_T \subset \bigsqcup_F S_F$. Using that ℓ_T is connected and that $\bigsqcup_F S_F$ is the decomposition into components, there exists F such that $\ell_T \subset S_F$. It follows that both ideal endpoints of the concrete line ℓ_T are in $\partial_{\infty}S_F$ and hence $\ell \in \widetilde{\mathbb{B}}_{\infty}(S_F) \approx \widetilde{\mathbb{B}}_{\infty}(F; \mathcal{A} \mid F)$.

We turn now to the proof of Bounded Cancellation for Lines. Let $\ell = \{\xi, \eta\} \in \mathcal{B}_{\mathcal{F}}(\Gamma; \mathcal{A})$, and so $\xi, \eta \in \partial_{\mathcal{F}}(\Gamma; \mathcal{A})$. Choose a map $f: S \to T$ from a Grushko free splitting S rel \mathcal{A} to a Grushko free splitting T rel \mathcal{F} . Let C be a cancellation constant for f with respect to finite paths (for example, the one specified in [HM22, Lemma 4.14]).

Case 1: Let $\ell_T \subset T$ be the line as described under *Case 1 realization*. We proceed as in the proof of Lemma 3.1 (1): by applying the proof of [DT17, Theorem 3.2] to each of two subrays of ℓ_T , one with end ξ and the other with end η , we obtain a bi-infinite sequence $(w_i)_{i \in \mathbb{Z}}$ of points in $f(\ell)$ such that in T we have $w_i \to \xi$ as $i \to -\infty$ and $w_i \to \eta$ as $i \to +\infty$; using that sequence (w_i) we may then apply the argument of [HM22, Lemma 4.14 (3)], leading to the conclusions of *Bounded Cancellation for Lines*. The final sentence, for the case when f is a collapse map, is a consequence of Lemma 3.1 (4), which tells us in this case that $[q, \xi(T)) = f[p, \xi(S))$ and $[q, \eta(T)) = f[p, \eta(S))$ hence $\ell_T = f(\ell_S)$.

Case 2: Let $\ell_T \in T$ be as described under *Case 2 realization*, namely, the point fixed by the action of F_{ℓ} . Let $S_F \subset S$ be the minimal subtree for the action of F. We have $\ell_S \subset S_F$, hence $F \cdot \ell_S \subset S_F$, and so by minimality of S_F this inclusion is an equation: $F \cdot \ell_S = S_F$. Since $f(S_F) \subset T$ is an F-invariant subtree of T and ℓ_T is the minimal such subtree, we have $\ell_T \in f(S_F) = f(F \cdot \ell_S)$. Pick $p' \in S_F$ such that $f(p') = \ell_T$, and then pick $p \in \ell_S$ and $g \in F$ such that $p = g \cdot p'$, hence

$$\ell_T = g \cdot \ell_T = g \cdot f(p') = f(g \cdot p') = f(p) \in f(\ell_S)$$

which is the first part of the Bounded Cancellation conclusion. For the second part, since $f(\ell_S) \subset f(S_F)$, the inclusion $f(\ell_S) \subset N_C(\ell_T)$ will follow from the more general inclusion $f(S_F) \subset N_C(\ell_T)$

that we now verify. The union of the subsegments $[\gamma \cdot p, \delta \cdot p] \subset S_F$, taken over all $\gamma, \delta \in F$, is a F-invariant subtree of S_F and hence is equal to S_F . Applying [HM22, Lemma 4.14 (1)], namely Bounded Cancellation for Paths, since $f(\gamma \cdot p) = f(\delta \cdot p) = \ell_T$ it follows that $f[\gamma \cdot p, \delta \cdot p] \subset N_C(\ell_T)$. Since this holds for all $\gamma, \delta \in F$, we obtain $f(S_F) \subset N_C(\ell_T)$. If in addition $f: S \xrightarrow{\langle \sigma \rangle} T$ is a collapse map then S_F is contained in the component of σ stabilized by F, but that component collapses to the point ℓ_T , hence $f(S_F) = \ell_T$ which is the minimal subtree for F acting on T.

Remark. There is a version of the Lemma 3.4 which drops the birecurrence hypothesis at the cost of more possibilities for the concrete realization; here is a brief description. As F varies over all free factors such that $[F] \in \mathcal{F}$, the subsets $\partial_{\infty}(F; \mathcal{A} \mid F)$ and $\partial_{\mathcal{F}}(\Gamma; \mathcal{A})$ of $\partial_{\infty}(\Gamma; \mathcal{A})$ form a pairwise disjoint decomposition. And while the subsets $\widetilde{\mathcal{B}}_{\infty}(F; \mathcal{A} \mid F) = \widetilde{\mathcal{B}}_{\infty}(F; \mathcal{A} \mid F)^{\{2\}}$ and $\partial_{\mathcal{F}}(\Gamma; \mathcal{A})^{\{2\}}$ of $\partial_{\infty}(\Gamma; \mathcal{A})$ are pairwise disjoint, they do not form a decomposition, because the two ideal endpoints ξ, η of an abstract line $\{\xi, \eta\} \in \widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A})$ can lie in two different members of the decomposition of $\partial_{\infty}(\Gamma; \mathcal{A})$, leading to two other types of realizations: a ray, when one of ξ, η lies in $\partial_{\mathcal{F}}(\Gamma; \mathcal{A})$ and the other lies in some set of type $\partial_{\infty}(F; \mathcal{A} \mid F)$; or a finite path, when ξ, η lie im two different sets of type $\partial_{\infty}(F; \mathcal{A} \mid F)$. One could express this succinctly in the language of the Bowditch boundary $\partial(\Gamma; \mathcal{F})$ and its abstract line space $\partial(\Gamma; \mathcal{F})^{\{2\}}$ by saying that there is a natural projection $\widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A}) \mapsto \partial(\Gamma; \mathcal{F})^{\{2\}} \sqcup \partial(\Gamma; \mathcal{F})$. This is closely related to Lyman's treatment of attracting laminations *including* their nongeneric leaves [Lym22a, Section 4].

For stating the following corollary, consider a birecurrent abstract line $\ell \in \mathcal{B}_{\infty}(\Gamma; \mathcal{A})$ and a free splitting $S \in \mathcal{FS}(\Gamma; \mathcal{A})$, and let $\ell_S \subset S$ be the concrete realization of ℓ in S as specified by Lemma/Definition 3.4. To say that ℓ fills S means that $\Gamma \cdot \ell_S = S$, where of course $\Gamma \cdot \ell_S = \bigcup_{\gamma \in \Gamma} \gamma \cdot \ell_S$. For example, if ℓ_S falls into Case 1 of Lemma/Definition 3.4 — meaning that ℓ_S is supported by a nontrivial free factor that stabilizes a vertex of S — then ℓ_S is a point and so ℓ does not fill S.

Corollary 3.5. For each birecurrent abstract line $\ell \in \widetilde{B}_{\infty}(\Gamma; \mathcal{A})$ the following are equivalent:

- (1) ℓ fills Γ rel \mathcal{A} .
- (2) ℓ fills every Grushko free splitting $S \in \mathcal{FS}(\Gamma; \mathcal{A})$.
- (3) ℓ fills every free splitting $S \in \mathcal{FS}(\Gamma; \mathcal{A})$.

Proof. To prove the implication $(1) \Longrightarrow (2)$, suppose that (2) fails as witnessed by S. Since S is Grushko, the realization ℓ_S is a concrete line in S, and so the invariant subforest $\sigma = \Gamma \cdot \ell_S \subset S$ is proper (by failure of (2)). It follows that $\mathcal{F}\sigma$ is a nonfull free factor system rel \mathcal{A} that supports ℓ , hence (1) fails.

To prove the implication $(2) \Longrightarrow (3)$, consider any free splitting S of Γ rel \mathcal{A} . We may choose a collapse map $f: U \mapsto S$ defined on a Grushko free splitting U of Γ rel \mathcal{A} [HM14, Lemma 3.2 (3)]. If ℓ is supported by $\mathcal{F}_{ell}S$ then (1) fails. Otherwise the realizations $\ell_U \subset U$ and $\ell_S \subset S$ are both lines, and $f(\ell_U) = \ell_S$ (by Lemma/Definition 3.4). Since (2) holds we have $\Gamma \cdot \ell_U = U$, and hence $\Gamma \cdot \ell_S = S$.

To prove the implication $(3) \Longrightarrow (1)$, suppose that (1) fails, and hence ℓ is supported by some nonfull free factor system \mathcal{F} rel \mathcal{A} . Letting S be a free splitting rel \mathcal{A} such that $\mathcal{F}_{ell}S = \mathcal{F}$. It follows from Lemma/Definition 3.4 that ℓ_S is a point in S hence hence (3) fails.

3.4 EG-aperiodic train track maps and their attracting laminations

The theory of relative train track representatives and attracting laminations for elements of $Out(\Gamma; \mathcal{A})$ was developed by Lyman in [Lym22b, Lym22a], adapting the methods of [BFH00] to make them work in the context of the Bowditch boundary that was introduced in [GH19]. For a full review see the following material in Part II:

- [HM22, Section 4.1.2] Attracting laminations and their free factor supports; filling laminations.
- [HM22, Section 4.3.1] Relative train track representatives;
- [HM22, Section 4.3.3] Train track representatives;
- [HM22, Theorem 4.17, in Section 4.3.2] A summary statement of the natural bijection between the finite set $\mathcal{L}(\phi)$ of attracting laminations of $\phi \in \text{Out}(\Gamma; \mathcal{A})$ and the set of EG-aperiodic substrata of a relative train track representative of ϕ .

Everything we need about attracting laminations here in Part III is found in Theorem 3.6 below, which is the result of further whittling down the summary statement [HM22, Theorem 4.17], itself whittled down from [Lym22a]. Namely, Theorem 3.6 focusses on the special case of a unique attracting lamination and the expression of its generic leaves using tiles of an EG-aperiodic train track representative.

Train track representatives. For the statement of Theorem 3.6 and its various supporting definitions, we switch to the notation \mathcal{F} for our given free factor system of Γ , in order to prepare for later applications where \mathcal{F} will be some ϕ -invariant free factor system rel \mathcal{A} .

Consider any free factor system \mathcal{F} of Γ and any $\phi \in \text{Out}(\Gamma; \mathcal{F})$. As said in [HM22] just preceding Section 4.1, we work entirely upstairs in trees and in $\widetilde{\mathcal{B}}(\Gamma; \mathcal{F})$ (rather than mostly downstairs in graphs of groups and in $\mathcal{B}(\Gamma; \mathcal{F}) = \widetilde{\mathcal{B}}(\Gamma; \mathcal{F})/\Gamma$ as is done in [Lym22a]).

Recall from [HM14, Section 4.3.3] that a train track representative of ϕ rel \mathcal{F} is a map $F: T \to T$ defined on a Grushko free splitting T rel \mathcal{F} such that the following hold: F is Φ twisted equivariant with respect to some $\Phi \in \operatorname{Aut}(\Gamma; \mathcal{F})$ representing ϕ ; the map F takes vertices to vertices; and each point of T is contained in the interior of some edge path η without backtracking such each restricted iterate $F^k \mid \eta$ is injective $(k \ge 0)$. It follows that the restrictions $f^k \mid e$ and $f^k \mid E$ are injective for each edge $e \subset T$ and each natural edge $E \subset T$; the image path $F^k(e)$ is referred to as a k-tile of F or an iteration tile when the value of k is unimportant, and $F^{k}(E)$ is similarly referred to as a natural k-tile of F or a natural iteration tile. Fixing $e_1,\ldots,e_n \subset T_l$ to be an enumerated set of representatives of the Γ -orbits of edges of T, the transition matrix of F is the $n \times n$ matrix \mathcal{M} whose entry \mathcal{M}_{ij} counts how many times the 1-tile $F(e_j) \subset T$ crosses translates of the edge e_i . It follows that for any $k \ge 1$ the map F^k is a train track representative of ϕ^k with transition matrix \mathcal{M}^k , and so \mathcal{M}^k_{ij} counts how many times the k-tile $F^k(e_j)$ crosses translates of e_i . To say that F is EG-aperiodic means that there exists an exponent $k \geq 1$ such that each entry of \mathcal{M}^k is positive (equivalently, each k-tile crosses at least one translate of each edge); and in this case \mathcal{M} has Perron-Frobenius eigenvalue denoted $\lambda > 1$ and called the *expansion factor* of f.

To say that a concrete line $L \subset T$ is *exhausted by iteration tiles (of F)* means that every finite subpath of L is contained in some iteration tile.

Theorem 3.6 (The special case of [HM22, Theorem 4.17]). For any free factor system \mathfrak{F} of Γ and any $\phi \in \operatorname{Out}(\Gamma; \mathfrak{F})$, if ϕ has an EG-aperiodic train track representative $F: T \to T$ rel \mathfrak{F} then ϕ has exactly one attracting lamination $\Lambda \subset \widetilde{\mathfrak{B}}(\Gamma; \mathfrak{F})$ relative to \mathfrak{F} . Furthermore, a concrete line $L \subset T$ is the realization of a generic leaf of Λ if and only if L is exhausted by iteration tiles of F.

3.5 The first constraint on Ω : The lamination and the fold axis

We are ready to start executing the outline laid out in Section 3.1.

3.5.1 Finding the attracting lamination.

Consider any $\phi \in \text{Out}(\Gamma; \mathcal{A})$ satisfying the *Large Orbit Hypothesis*, with a value of Ω yet to be specified: Every ϕ -orbit in $\mathcal{FS}(\Gamma; \mathcal{A})$ has diameter $\geq \Omega$. Among all ϕ -invariant, non-filling free factor systems of Γ rel \mathcal{A} , choose \mathcal{F} to be one which is maximal with respect to \Box . Let $m \geq 0$ be the number of attracting laminations of ϕ rel \mathcal{A} that are not supported by \mathcal{F} .

We now apply [HM22, Proposition 4.24]. That proposition has two possible conclusions depending on whether m = 1. Conclusion (2) uses "fold axes" which will be reviewed immediately in Section 3.5.2 immediately, where we will augment conclusion (2) with an additional subconclusion.

Here are the two conclusions of [HM22, Proposition 4.24]:

Conclusion (1) (when $m \neq 1$): There exists a Grushko free splitting T of Γ rel \mathcal{F} such that the diameter in $\mathcal{FS}(\Gamma; \mathcal{A})$ of the orbit $\{T \cdot \phi^k\}_{k \in \mathbb{Z}}$ is ≤ 4 .

We immediately rule out Conclusion (1) by combining our *Hypothesis* with the following:

Constraint #1: $\Omega \ge \Omega_1 = 5$.

Conclusion (1) and Constraint #1 together imply that m = 1. The other conclusion of [HM22, Proposition 4.24] must therefore hold:

- **Conclusion (2) (when** m = 1): Letting Λ denote the unique attracting lamination of ϕ rel \mathcal{A} that is not carried by \mathcal{F} , there exists a fold axis of ϕ with respect to \mathcal{F} , such that the following hold:
 - **Conclusion (2a):** The first return map $F_0: T_0 \to T_0$ for that axis is an EG-aperiodic train track representative of ϕ rel \mathcal{F} . Let $\Lambda_{\mathcal{F}}$ be the unique attracting lamination of ϕ rel \mathcal{F} (see Theorem 3.6).
 - **Conclusion (2b):** There exists a collapse map $\mu: U \to T_0$ defined on some Grushko free splitting U of Γ rel \mathcal{A} , such that μ induces a bijection between concrete lines in U realizing generic leaves of Λ and concrete lines in T_0 realizing generic leaves of $\Lambda_{\mathcal{F}}$.

3.5.2 Fold axes and tiles: a review.

We review here notation for fold axes taken from [HM22, Definition 4.8], for use in the setting of Conclusion (2) above, and in settings to recur throughout this work.

An EG-aperiodic fold axis of ϕ with respect to \mathcal{F} is a bi-infinite fold path of Grushko free splittings rel \mathcal{F} , which fits into both the top and bottom rows of a bi-infinite commutative diagram shown just below, and which satisfies further properties to be described:



In this diagram, as said T_i is a Grushko free splitting with respect to \mathcal{F} , and is thus equipped with some simplicial structure. The integer $p \geq 1$ is the *period* of the axis. There exists a representative $\Phi \in \operatorname{Aut}(\Gamma; \mathcal{F})$ of $\phi \in \operatorname{Out}(\Gamma; \mathcal{F})$, such that each map $h_{l-p}^l: T_l \to T_{l-p}$ is a Φ twisted equivariant simplicial isomorphism $(l \in \mathbb{Z})$. Each of the foldable maps f_l is, of course, Γ -equivariant. It follows that $T_l \cdot \phi = T_{l+p}$ for each $l \in \mathbb{Z}$, hence the ϕ -orbit of T_l can be expressed as $\{T_l \cdot \phi^k\}_{k \in \mathbb{Z}} = \{T_{l+kp}\}_{k \in \mathbb{Z}}$. For each i < j we denote an equivariant map

$$f_j^i = f_j \circ \cdots \circ f_{i+1} \colon T_i \to T_j$$

For each $l \in \mathbf{Z}$ the first return map $F_l: T_l \to T_l$ is the unique Φ -twisted equivariant topological representative of ϕ rel \mathcal{F} that makes the following diagram commute:



Finally (as required in Conclusion (2)), the topological representative $F_0: T_0 \to T_0$ is an EGaperiodic train track representative of ϕ rel \mathcal{F} .

For each $l \in \mathbf{Z}$, $k \ge 1$ and i < j we denote a Φ^k -twisted equivariant simplicial isomorphism

$$h_{l-kp}^{l} = h_{l-kp}^{l-(k-1)p} \circ \cdots \circ h_{l-p}^{l} : T_{l} \to T_{l-kp}$$

and its Φ^{-k} -twisted equivariant inverse

$$h_l^{l-kp} = (h_{l-kp}^l)^{-1} \colon T_{l-kp} \to T_l$$

For each $l \in \mathbf{Z}$ and $k \ge 1$ we also have a commutative diagram for $(F_l)^k : T_l \to T_l$, the k^{th} return map, which is a train track representative of ϕ^k :



From the previous diagram and the fact that h_{l-kp}^{l} is a simplicial isomorphism one sees by inspection that in the free splitting T_{l} , an $(F_{l})^{k}$ (natural) tile is the same thing as an f_{l}^{l-kp} (natural) tile. These are referred to as (natural) k-tiles (in T_{l}) or as (natural) iteration tiles when the value of k is not important.

Recall from [HM14, Lemma 4.10] that when the edge orbits of each T_l are enumerated so that each simplicial isomorphism h_{l-p}^l respects enumerations, the transition matrix \mathcal{M}_l of the first return map $F_l: T_l \to T_l$ is equal to the transition matrix $\mathcal{M}f_l^{l-p}$ of the foldable map f_l^{l-p} . More generally the matrix power $(\mathcal{M}_l)^k$ is equal to the transition matrix $\mathcal{M}f_l^{l-kp}$, the i, j entry of which counts how many times the path $f_l^{l-kp}(e)$ crosses edges in the orbit of e', where $e \subset T_{l-kp}$ represents the j^{th} edge orbit, and $e' \subset T_l$ represents the i^{th} edge orbit.

This completes our review of fold axes. See also [HM22, Lemma 4.22] which gives a general construction for a fold axis having a given EG-irreducible train track representative as its first return map.

Fixing notation for a fold axis of ϕ with respect to \mathcal{F} satisfying Conclusion (2) above, we add another subconclusion regarding the behavior of generic leaves along the fold axis:

- **Conclusion (2c):** For every $i \in \mathbb{Z}$, for every collapse map $\mu: V \to T_i$ defined on a Grushko free splitting V rel A, and for every birecurrent line $\ell \in \widetilde{\mathcal{B}}_{\infty}(\Gamma; \mathcal{A})$ with concrete realizations $\ell_V \subset V$ and $\ell_i \subset T_i$, we have $\mu(\ell_V) = \ell_i$. Furthermore, the following properties of ℓ are equivalent:
 - (A): ℓ is a generic leaf of Λ ,
 - (B): ℓ_i is a line in T_i that is exhausted by iteration tiles in T_i .
 - (C): ℓ_i is the concrete realization in T_i of a generic leaf of $\Lambda_{\mathcal{F}}$.

Remark: The main difference between Conclusions (2b) and (2c) is how $i \in \mathbb{Z}$ and $\mu: U \to T_i$ are quantified: (2b) is an existence statement; whereas (2c) is a universal statement.

Proof. In the case that ℓ is supported by \mathcal{F} , it follows that ℓ is not a generic leaf of Λ , and that $\ell_l \subset T_l$ is a point instead of a line (by Lemma 3.4 Case 1); each of (A), (B), (C) is therefore false in this case.

Consider now the case that ℓ is not supported by \mathcal{F} . By Lemma 3.4 Case 2 it follows that $\ell \in \mathcal{B}_{\mathcal{F}}(\Gamma; \mathcal{A})$ and that ℓ_i is a line in T_i . Note that the formulations of statements (B) and (C) depend on the choices of $i \in \mathbb{Z}$ and $\mu: V \to T_i$, but on the other hand (A) is independent of those choices. Applying Conclusion (2) it follows that statement (B), formulated with *one particular* set of choices, is equivalent to statement (A). But by applying [HM22, Proposition 4.25 (2b)] it follows that statements (B) and (C) are all equivalent to each as one varies over all of the choices made in their formulations. Statement (A) is therefore equivalent to all of those statements. \diamond

3.5.3 PF-exponents and a uniform crossing property.

The "Two-over-all" theorems — weak and strong — establish certain *distances* along Stallings fold paths for which corresponding tiles satisfy strong properties.

In this section (and in Section 4), one of our strategies is to establish certain *exponents* along fold axes for which corresponding tiles satisfy strong properties: see Definition 3.7 just below; and see also various properties to follow in Section 3, particularly Definition 3.10 of Section 3.6.1.

We begin by observing that for every EG-aperiodic train track map $F: T \to T$ with transition matrix \mathcal{M} , there exists an integer $\kappa \geq 1$ such that every entry of \mathcal{M}^k is ≥ 4 : this follows because \mathcal{M} has *some* positive power, and it has Perron-Frobenius eigenvalue $\lambda > 1$. In the language of our next definition one says that κ is a *PF-exponent* of *F*:

Definition 3.7 (PF-exponents). To say that an integer $\kappa \geq 1$ is a *PF-exponent* of an EGaperiodic train track map $F: T \to T$ means that every F^{κ} tile in T crosses at least 4 translates of every edge of T; equivalently, every entry of the transition matrix of F is ≥ 4 . Also, given $\phi \in \text{Out}(\Gamma; \mathcal{A})$ and an EG-aperiodic fold axis of ϕ relative to a ϕ -invariant free factor system \mathcal{F} rel \mathcal{A} (denoted as in Section 3.5.2), to say that κ is a PF-exponent of the fold axis means that it is a PF-exponent of every train track map $F_l: T_l \to T_l$ ($l \in \mathbf{Z}$); equivalently, every κp tile $f_l^{l-\kappa p}(e) \subset T_l$ crosses at least 4 translates of every edge of T_l (for edges $e \subset T_{l-\kappa p}$).

Note that every EG-aperiodic fold axis of ϕ does indeed have a PF exponent: letting p be the period, simply take the maximum of the PF exponents of $F_i: T_i \to T_i$ for $0 \le i < p$.

Remark. While the choice of "4" in Definition 3.7 may seem arbitrary, its utility should become apparent in the following lemma.

Lemma 3.8 (Uniform Crossing Property for Tiles). Given an EG-aperiodic train track map $F: T \to T$ with PF-exponent κ , for every edge $e \subset T$ and for every natural edge $E \subset T$, the tile $F^{\kappa}(e)$ crosses at least 2 translates of E. It follows that given any EG-aperiodic fold axis with period p and PF-exponent κ , and given any T_i along that axis, every κp tile in T_i crosses at least 2 translates of T_i .

Proof. Since the tile $F^{\kappa}(e) \subset T$ crosses 4 translates of every edge of T, it is not contained in any natural edge of T. For each natural edge $\eta \subset T$ it follows that one of three alternatives holds: $F^{\kappa}(e)$ crosses η ; or $F^{\kappa}(e)$ is disjoint from the interior of η ; or the subpath $F^{\kappa}(e) \cap \eta$ has one endpoint in common with an endpoint of η , and opposite endpoint in common with an endpoint of $F^{\kappa}(e)$.

Since distinct natural edges of T have disjoint interiors, and since $F^{\kappa}(e)$ has exactly two endpoints, it follows that the set of translates of the natural edge E whose interior is not disjoint from $F^{\kappa}(e)$ may be listed in order (and with disjoint interiors) as E_1, \ldots, E_m , such that the subpath $F^{\kappa}(e) \cap E_1$ contains one endpoint of $F^{\kappa}(e)$, and $E_i \subset F^{\kappa}(e)$ for $2 \leq i \leq m-1$, and the subpath $F^{\kappa}(e) \cap E_m$ contains the opposite endpoint of $F^{\kappa}(e)$. The tile $F^{\kappa}(e)$ therefore crosses at least m-2 translates of E.

Choose an edge e' of T such $e' \subset E$. Using that κ is a PF-exponent for F, the path $F^{\kappa}(e)$ crosses 4 or more distinct translates of e'. Any two of these translates are contained in two distinct translates of E, because each natural edge has trivial stabilizer. It follows that $m \geq 4$, and so $m-2 \geq 2$.

For the concept of "pullback" referred to in the following lemma, see Definition 2.16.

Lemma 3.9 (Trivial Collapse Property). Let κ be a PF-exponent for the fold axis. Consider any $i, \ell \in \mathbb{Z}$ such that $i \leq \ell - \kappa p$. For any proper subforest $\mathfrak{T}_{\ell} \subset T_{\ell}$, consider the pullback subforest $\mathfrak{T}_i = (f_{\ell}^i)^*(\tau_i)$ and its corresponding collapse map $q_i: T_i \xrightarrow{\langle \mathfrak{T}_i \rangle} S_i$. The following hold:

- (1) For any edge $e \subset T_i$, we have $e \not\subset \mathfrak{T}_i$. The collapse map q_i is therefore injective on the set of vertices of T.
- (2) The collapse map $q_i: T_i \to S_i$ is trivial. More precisely, the restrictions of q_i to the edges of T_i can be equivariantly tightened to produce an equivariant homeomorphism $\hat{q}_i: T_i \to S_i$ (see [HM22, Section 2.2.4]). As a consequence, the restrictions of q_i and \hat{q}_i to the vertex set of T_i are identical, and for every path $\alpha \subset T_i$ we have $q_i(\alpha) = \hat{q}_i(\alpha)$.
- (3) $\mathcal{F}_{ell}S_i = \mathcal{F}_{ell}T_i = \mathcal{F}.$
- (4) For every path $\alpha \subset T_i$, α fills T_i if and only if $q_i(\alpha)$ fills S_i .

Remark: In this statement one should keep in mind the following somewhat tautological but nonetheless important statement: \mathcal{T}_i is a subforest of T_i with respect to the subdivision of T_i for which the map $T_i \mapsto T_\ell$ is simplicial. An edge $e \subset T_i$ is typically a concatenation of many edgelets of this subdivision. The statement $e \not\subset \mathcal{T}_i$ is equivalent to saying that at least one edgelet of e is not in the subforest \mathcal{T}_i , and to saying that e does not collapse to a single point of S_i .

Proof. Conclusions (2) and (3) are both immediate consequences of Conclusion (1). Conclusion (4) then follows by combining the invariance principle stated after Definition 2.2 with the conclusions stated in (2) that \hat{q}_i is an equivariant homeomrophism and that $q_i(\alpha) = \hat{q}_i(\alpha)$.

To prove Conclusion (1) we start with the special case $i = \ell - \kappa p$. Using that κ is a PFexponent, for any edge $e \subset T_{\ell-\kappa p}$ the image κ -tile $f_{\ell}^{\ell-\kappa p}(e) \subset T_{\ell}$ crosses a translate of every edge of T_{ℓ} . Since the subforest $\mathfrak{T}_{\ell} \subset T_{\ell}$ is proper, it follows that $f_{\ell}^{\ell-\kappa p}(e) \not\subset \mathfrak{T}_{l}$, and therefore $e \not\subset \mathfrak{T}_{\ell-\kappa p}$. The general case $i \leq \ell - \kappa p$ reduces to the special case as follows. For each edge $e \subset T_{i}$, its image $f_{\ell-\kappa p}^{i}(e) \subset T_{\ell-\kappa p}$ crosses some edge $e' \subset T_{\ell-\kappa p}$. Knowing from the special case that $e' \not\subset \mathfrak{T}_{\ell-\kappa p}$, it follows that $f_{\ell-\kappa p}^{i}(e) \not\subset \mathfrak{T}_{\ell-\kappa p}$ and hence $e \not\subset \mathfrak{T}_{i} = (f_{\ell-\kappa p}^{i})^{*}(T_{\ell-\kappa p})$.

3.6 The second constraint on Ω : The fold axis is quasigeodesic

Notation Overview: In this and later subsections of Section 3, we continue with the objects and their notations and various properties that were established in Section 3.5 as a consequence of Constraint #1 on the value of Ω , in particular: an element $\phi \in \text{Out}(\Gamma; \mathcal{A})$ satisfying the Large Orbit Hypothesis; a choice of maximal, proper, ϕ -invariant free factor system \mathcal{F} rel \mathcal{A} ; the unique attracting lamination Λ for ϕ rel \mathcal{A} that is not carried by \mathcal{F} ; and a choice of fold axis for ϕ with respect to \mathcal{F} .

Our next constraint on Ω is expressed using the constant $\Theta = \Theta(\Gamma; \mathcal{A})$ from the Strong Two Over All Theorem:

Constraint #2: $\Omega \ge \Omega_2 = \Theta$

Using this, the remainder of Section 3.6 is dedicated to proving the following:

Quasigeodesic Axis Property (nonquantitative version): The fold axis of ϕ is a bi-infinite quasigeodesic in $\mathcal{FS}(\Gamma; \mathcal{A})$

Remark This property is equivalent to saying that ϕ acts loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$, which is item (2) of Theorem B. Perhaps one could think about breaking the proof of the implication (4) \Longrightarrow (1) into two implications (4) \Longrightarrow (2) \Longrightarrow (1), but just setting up the proof of the latter implication would already require much of the rigamarole of axes and tiles that is already needed for the full implication.

3.6.1 Filling exponents and uniform filling properties.

The proof of the Quasigeodesic Axis Property will use two filling properties that are developed here in Section 3.6.1 as consequences of Constraint #2: the Uniform Filling Property in Lemma 3.11; and the Uniform Crossing Filling Property in Lemma 3.12.

Definition 3.10 (Filling exponents). To say that an integer $\omega \geq 1$ is a *filling exponent* of an EG-aperiodic train track map $F: T \to T$ means that every F^{ω} tile in T fills T. Also, given $\phi \in \operatorname{Out}(\Gamma; \mathcal{A})$ and an EG-aperiodic fold axis of ϕ relative to a ϕ -invariant free factor system \mathcal{F} rel \mathcal{A} (denoted as in Section 3.5.2), to say that ω is a filling exponent of the fold axis means that ω is a filling exponent of every train track map $F_l: T_l \to T_l$ ($l \in \mathbb{Z}$); equivalently, every ωp tile $f_l^{l-\omega p}(e) \subset T_l$ fills T_l (for edges $e \subset T_{l-\omega p}$).

Along the ϕ -orbit $\{T_0 \cdot \phi^k = T_{kp}\}_{k \in \mathbb{Z}}$, applying the Large Orbit Hypothesis we obtain integers I < J such that $d_{\mathcal{FS}}(T_{Ip}, T_{Jp}) \geq \Omega$. Denoting $\delta = J - I$, and using that the cyclic subgroup $\langle \phi \rangle \leq \operatorname{Out}(\Gamma; \mathcal{A})$ acts by isometries on the orbit of T_0 , we have:

$$d_{\mathcal{FS}}(T_{(m-\delta)p}, T_{mp}) = d_{\mathcal{FS}}(T_{mp} \cdot \phi^{-\delta}, T_{mp}) \ge \Omega$$
 for each $m \in \mathbb{Z}$

Any δ with the property is called a *large orbit exponent* for the orbit $T_0 \cdot \phi^k$.

Using Constraint #2 we shall prove:

Lemma 3.11 (Uniform Filling Property for Tiles). If κ is a PF-exponent for the fold axis, and if δ is a large orbit exponent for the orbit $\{T_0 \cdot \phi^k\}$, then $\omega = \kappa + \delta + 1$ is a filling exponent for the fold axis.

Proof. Let $m \in \mathbb{Z}$ be the least integer such that $\ell - \omega p \leq mp$. It follows that $(m + \omega - 1)p < \ell$, and so we have the following foldable decomposition of $f_{\ell}^{\ell - \omega p} : T_{\ell - \omega p} \to T_{\ell}$:

$$T_{\ell-\omega p} \xrightarrow{f_{mp}^{\ell-\omega p}} T_{mp} \xrightarrow{f_{(m+\kappa)p}^{m}} T_{(m+\kappa)p} \xrightarrow{f_{(m+\kappa+\delta)p}^{(m+\kappa)p}} T_{(m+\kappa+\delta)p} = T_{(m+\omega-1)p} \xrightarrow{f_{\ell}^{(m+\omega-1)p}} T_{\ell}$$

Consider an arbitrary edge $e
ightarrow T_{\ell-\omega p}$ with image tiles denoted $\tau_i = f_i^{\ell-\omega p}(e)
ightarrow T_i$ $(i \ge \ell - \omega p)$. We must prove that the tile τ_ℓ fills T_ℓ . The tile $\tau_{mp}
ightarrow T_{mp}$ contains some edge of T_{mp} , so the tile $\tau_{(m+\kappa)p}$ contains some κ -tile of $T_{(m+\kappa)p}$. Applying the Uniform Crossing Property for Tiles to that κ -tile, it follows that the tile $\tau_{(m+\kappa)p}$ crosses a translate of every natural edge $E
ightarrow T_{(m+\kappa)p}$. Applying Constraint #2 together with the Strong Two Over All Theorem, we may choose the natural edge E so that the natural tile $f_{(m+\kappa)p}^{(m+\kappa)p}(E)$ fills $T_{(m+\kappa+\delta)p} = T_{(m+\omega-1)p}$. Since that natural tile is contained in $\tau_{(m+\omega-1)p}$ it follows that $\tau_{(m+\omega-1)p}$ also fills $T_{(m+\omega-1)p}$. Applying Lemma 2.15 it follows that τ_l fills T_l .

By combining the concepts of PF-exponents and filling exponents we obtain:

Lemma 3.12 (Uniform Crossing–Filling Property). Let κ, ω be a PF-exponent and a filling exponent for the fold axis, respectively. For all $\ell, m \in \mathbb{Z}$ such that $m \geq 0$, every $(m\kappa + \omega)p$ tile in T_{ℓ} crosses 4^m nonoverlapping natural ωp -tiles each of which fills T_{ℓ} .

Proof. We use the following foldable factorization of the map $f_{\ell}^{\ell-(m\kappa+\omega)p}: T_{\ell-(m\kappa+\omega)p} \to T_{\ell}$, in which all arrows are maps of the form f_i^i :

$$T_{\ell-(m\kappa+\omega)p} \longrightarrow T_{\ell-((m-1)\kappa+\omega)p} \longrightarrow \cdots \longrightarrow T_{\ell-(\kappa+\omega)p} \longrightarrow T_{\ell-\omega p} \xrightarrow{f_{\ell}^{\ell-\omega p}} T_{\ell}$$

Consider any edge of $T_{\ell-(m\kappa+\omega)p}$ with image tiles denoted $\tau_i \subset T_i$ (for $i \geq \ell - (m\kappa+\omega)p$), and so in particular $\tau_\ell \subset T_\ell$ is an $(m\kappa+\omega)p$ tile. By *m* successive applications of the definition of PF-exponent, the tile $\tau_{\ell-\omega p}$ crosses 4^m distinct edges of $T_{\ell-\omega p}$. The images of those edges in τ_ℓ give 4^m nonoverlapping ωp tiles in T_ℓ , and by definition of a filling exponent each of those tiles fills T_ℓ .

Remarks on uniformity of PF-exponents and of filling exponents. In Section 4 we shall describe a *uniform* PF-exponent $\kappa = \kappa(\Gamma; \mathcal{A})$ and a *uniform* filling exponent $\omega = \omega(\Gamma; \mathcal{A})$ for the fold axis currently under discussion, under the additional assumption that T_0 is a natural free splitting. While that kind of uniformity is not needed in our current setting here in Section 3, it could be applied to further uniformize other constructions found here in Section 3 which rely on unspecified values of κ and ω . For example Lemma 3.17 (2) will be applied in Section 4, in conjunction with uniform values of κ and ω also described in Section 4, im order to obtain the lower bound on positive translation lengths needed for Theorem A.

3.6.2 Component free splitting units.

The proof of the Quasigeodesic Axis Property uses concepts of free splitting units and associated distance estimates along fold paths in $\mathcal{FS}(\Gamma; \mathcal{A})$, taken from [HM14], and applied here to our fold axis for ϕ . There are two different flavors of free splitting units: "ordinary" free splitting units; and component free splitting units [HM14, Section 4.5]. These two definitions are founded on two respective concepts of the complexity of a nondegenerate subgraph of a free splitting: "ordinary" complexity; and component complexity [HM14, Section 4.4]. Ordinary free splitting units have important internal applications in [HM14], but outside of that context component free splitting units seem generally easier to apply. Here we shall only review component complexity and component free splitting units (outside of brief remarks comparing "component" free splitting units to "ordinary" free splitting units).

Recall from Section 2.1.1 the concept of a nondegenerate subgraph of a free splitting, namely a Γ -invariant subgraph no component of which is a point.

For any free splitting R and any nonempty, nondegenerate subgraph $\beta \subset R$, the *component* complexity $C_1(\beta)$ is a positive integer equal to the number of Γ -orbits of components of β ; equivalently, $C_1(\beta) = |\pi_0(\beta/\Gamma)|$ where $\pi_0(\beta/\Gamma)$ denotes the set of components of the orbit subspace $\beta/\Gamma \subset R/\Gamma$.

Lemma 3.13 (Monotonicity of component complexity). For any foldable map $f: R' \to R$ of free splittings and any nonempty, nondegenerate subgraph $\beta_R \subset R$ with pullback $\beta_{R'} = f^*(\beta_R) \subset$ R', the map f induces a surjection $\pi_0(\beta_{R'}/\Gamma) \mapsto \pi_0(\beta_R/\Gamma)$. It follows that $C_1(\beta_{R'}) \ge C_1(\beta_R)$, and equality holds if and only if that surjection is a bijection. *Proof.* This follows immediately using that f restricts to a continuous, equivariant surjection $\beta_{R'} \mapsto \beta_R$, and that the component sets $\pi_0(\beta_{R'}/\Gamma)$ and $\pi_0(\beta_R/\Gamma)$ are finite.

Recall from Definition 2.16 the pullback operator on nondegenerate subgraphs with respect to foldable maps, and the concept of a pullback sequence along a foldable sequence.

Definition 3.14 (Collapse expand diagrams). Consider any fold subpath $T_I \mapsto \cdots \mapsto T_J$ in our given axis. A *collapse-expand diagram* over that subpath is a commutative diagram of two combing rectangles (see Definition 2.17) having the following form, with collapse forests as indicated

$$\begin{array}{c|c} R_{I} \longrightarrow R_{I+1} \longrightarrow \cdots \longrightarrow R_{J-1} \longrightarrow R_{J} \\ [\mathfrak{R}_{i}] & [\mathfrak{R}_{i+1}] & [\mathfrak{R}_{j-1}] & [\mathfrak{R}_{j}] \\ S_{I} \longrightarrow S_{I+1} \longrightarrow \cdots \longrightarrow S_{J-1} \longrightarrow S_{J} \\ [\mathfrak{I}_{i}] & [\mathfrak{I}_{i+1}] & [\mathfrak{I}_{j-1}] & [\mathfrak{I}_{j}] \\ T_{I} \longrightarrow T_{I+1} \longrightarrow \cdots \longrightarrow T_{J-1} \longrightarrow T_{J} \end{array}$$

Combining Definition 2.17 with the discussion preceding Lemma 3.13, in this diagram we see two pullback sequences: the \mathcal{R}_i 's form a pullback sequence along the *R*-row; and the \mathcal{T}_i 's form a pullback sequence along the *T*-row. An *edgelet subdivision* of this diagram is choice of subdivision of each free splitting in the diagram such that all arrows are simplicial maps, all collapse forests \mathcal{R}_i , \mathcal{T}_i are subcomplexes, and Γ acts by simplicial isomorphisms. For example, an edgelet subdivision of the diagram is determined by each subdivision of S_J by pulling back vertices throughout the diagram. We use "edgelet" terminology to refer to 1-simplices of an edgelet subdivision, and "edge" terminology to refer to 1-simplices of the simplicial structures on each T_i that were already given (in our review of fold axes in Section 3.5.2).

Definition 3.15 (Component free splitting units). For any fold subpath $T_I \mapsto \cdots \mapsto T_J$ in our given axis, to say that T_I and T_J differ by < 1 component free splitting unit means that there exists a collapse–expand diagram as denoted in Definition 3.14, such that in the *R*-row there there exists a pullback sequence $\beta_i \subset R_i$ $(i \in [I, \ldots, J])$ having constant component complexity, equivalently (by Lemma 3.13) each foldable map $R_i \mapsto R_j$ (for $i < j \in [I, \ldots, J]$) induces a bijection $\pi_0(\beta_i/\Gamma) \approx \pi_0(\beta_j/\Gamma)$. In this context, after further equivariant subdivisions we may assume that β_i is an edgelet subcomplex of R_i for each $i \in [I, \ldots, J]$; and since β_i is nondegenerate, it is a union of edgelets.

More generally, the number of component free splitting units between T_I and T_J is an integer $\Upsilon = \Upsilon_{IJ} \ge 0$ equal to the maximum length of a sequence $i(0) < \cdots < i(\Upsilon)$ in $[I, \ldots, J]$ such that if $1 \le u \le \Upsilon$ then $T_{i(u-1)}$ and $T_{i(u)}$ do not differ by < 1 component free splitting unit along the axis.

Assuming that T_I and T_J differ by < 1 free splitting unit, any collapse-expand diagram and pullback sequence which witnesses that fact can be restricted to the fold subsequence $T_i \mapsto \cdots \mapsto T_j$ for any $i \leq j \in [I, \ldots, J]$, and those restrictions witness that T_i, T_j also differ by < 1 free splitting unit. It follows that the phrase " T_I and T_J differ by < 1 component free splitting unit" is equivalent to the equation $\Upsilon(T_I, T_J) = 0$. Also, the complementary phrase " T_I and T_J do not differ by < 1 component free splitting unit" is equivalent to the inequality $\Upsilon(T_I, T_J) \ge 1$. Combining this with Definition 3.14, for all $i \le j \in [I, \ldots, J]$ we have implications $\Upsilon(T_I, T_J) = 0 \implies \Upsilon(T_i, T_j) = 0$ and $\Upsilon(T_i, T_j) \ge 1 \implies \Upsilon(T_I, T_J) \ge 1$.

Here is the main feature of free splitting units that we shall be applying:

[HM14, Corollary 5.5]: Along any fold subpath $T_I \mapsto \cdots \mapsto T_J$, component free splitting units are quasicomparable to distance: for any $i < j \in [I, \ldots, J]$ we have

$$\frac{1}{\nu}\Upsilon_{ij} - \xi \le d_{\mathcal{FS}}(T_i, T_j) \le \nu\Upsilon_{ij} + \xi$$

with quasicomparability constants $\nu = \nu(\Gamma; \mathcal{A}) \ge 1$ and $\xi = \xi(\Gamma; \mathcal{A}) \ge 0$.

Remark. The "ordinary" complexity $C(\beta)$ of [HM14] is the sum of "component" complexity $C_1(\beta)$ plus three more uniformly bounded and non-negative terms $C_i(\beta)$ (i = 2, 3, 4) measuring various other aspects of complexity of β . Corollary 5.5 of [HM14] is derived from a corresponding result about ordinary complexity; uniform boundedness of the non-negative quantity $C(\beta) - C_1(\beta)$ is of key importance in that derivation.

We next record a simple "diagram chasing" result in any collapse-expand diagram:

Lemma 3.16 (Tiles throughout a collapse–expand diagram). Consider a collapse–expand diagram over fold subpath $T_I \mapsto \cdots \mapsto T_J$ as denoted in Diagram 3.14. For each edge $\theta \subset T_I$ such that $\theta \not\subset \mathfrak{T}_I$ there is a unique function which associates to each free splitting U in the diagram a nontrivial path $\theta(U) \subset U$ called the θ -tile in U, such that $\theta(T_I) = \theta$, and such that the following properties hold (for $I \leq i \leq j \leq J$):

- (1) In the T-row: The foldable map $T_i \mapsto T_j$ takes $\theta(T_i)$ homeomorphically to $\theta(T_j)$.
- (2) Between the T and S rows: The collapse map $T_i \mapsto S_i$ takes $\theta(T_i)$ onto $\theta(S_i)$.
- (3) In the S-row: The foldable map $S_i \mapsto S_j$ takes $\theta(S_i)$ homemorphically to $\theta(S_j)$. Also, $\theta(S_I)$ is contained in a natural edge of S_I .
- (4) Between the R and S rows: The θ -tile $\theta(R_i)$ is the lift of $\theta(S_i)$ with respect to the collapse map $R_i \mapsto S_i$ (thus $\theta(R_i)$ begins and ends with edgelets of $R_i \setminus \mathcal{R}_i$).
- (5) In the R row: The map $R_i \mapsto R_j$ takes $\theta(R_i)$ homeomorphically to $\theta(R_j)$. Also, $\theta(R_I)$ is contained in a natural edge of R_I .

Proof. In the *T*-row we define $\theta(T_i)$ inductively: we already have $\theta(T_I) = \theta$; and $\theta(T_i)$ is the image of $\theta(T_{i-1})$ under the fold map $T_{i-1} \mapsto T_i$. Since all maps in the *T*-row are foldable, and since $\theta(T_I)$ is a subset of some natural edge $E \subset T_i$, the map $T_I \mapsto T_i$ takes $\theta(T_I)$ homeomorphically onto $\theta(T_i)$. Each path $\theta(T_i)$ is therefore nontrivial; item (1) also follows.

We turn to items (2) and (3). Since $\theta = \theta(T_I) \not\subset \mathcal{T}_I$, its image $\theta(S_I) \subset S_I$ is a nontrivial path contained in a natural edge of S_I , namely the image of E under the collapse map $T_I \mapsto S_I$. Defining $\theta(S_i)$ inductively to be the image of $\theta(S_{i-1})$ under the foldable map $S_{i-1} \mapsto S_i$, the same argument as in the T row proves item (3) and shows that each $\theta(S_i)$ is nontrivial. Using commutativity of the diagram, together with the fact that θ -tiles within the S and T rows are mapped homeomorphically amongst themselves by the foldable maps in those rows, it follows that each collapse map $T_i \mapsto S_i$ takes $\theta(T_i)$ onto $\theta(S_i)$, proving item (2).

 \diamond

We may use the first sentence of item (4) (in conjunction with Definition 2.1) to define the path $\theta(R_i)$. Nontriviality of $\theta(R_i)$ follows from nontriviality of $\theta(S_i)$, and the second sentence follows from Definition 2.1.

The second sentence of item (5) follows from the second sentence of item (3), using the consequence of Definition 2.1 that the collapse map $R_i \mapsto S_i$ takes the natural edges of R_i not contained in \mathcal{R}_i bijectively to the natural edges of S_i . Regarding the first sentence of (5), for each $i \in [I, \ldots, J]$ we have the commutativity relation saying that the compositions $R_I \mapsto S_I \mapsto S_i$ and $R_I \mapsto R_i \mapsto S_i$ are the same, hence $\theta(R_i)$ maps onto $\theta(S_i)$. Furthermore, since \mathcal{R}_I is the pullback of \mathcal{R}_i , and since $\theta(R_I)$ begins and ends with edgelets of $R_I \setminus \mathcal{R}_I$, it follows that $\theta(R_i)$ begins and ends with edgelets of $R_i \setminus \mathcal{R}_i$. But these properties characterize the lift of $\theta(S_i)$ through the collapse map $R_i \mapsto S_i$, hence $\theta(R_i)$ is the lift of $\theta(S_i)$.

3.6.3 A quantitative quasigeodesic axis property

In this section we complete the proof of the quasigeodesic axis property, deriving it quickly from Lemma 3.17 just below, which expresses a quantitative version of the lower bound needed for the quasigeodesic axis property. The lemma also contains information about translation lengths that will be applied later in Section 4, to produce the uniform lower bound on positive translation lengths needed for Theorem A.

For purposes of application in Section 4, the statement of the lemma is formulated so that it does not require the Notation Overview established at the beginning of Section 3.6.

Lemma 3.17 (Quasigeodesic Axis Property (quantitative version)). Consider any $\phi \in \text{Out}(\mathcal{F}; \mathcal{A})$, any ϕ -invariant free factor system \mathcal{F} rel \mathcal{A} , and any EG-aperiodic fold axis for ϕ with respect to \mathcal{F} . If $\kappa \geq 1$ is a PF-exponent and if $\omega \geq 1$ is a filling exponent for the fold axis then, denoting $\mu = 3\kappa + \omega$, and using the constants $\nu = \nu(\Gamma; \mathcal{A})$ and $\xi = \xi(\Gamma; \mathcal{A})$ from [HM14, Corollary 5.5], the following hold:

- (1) For any $I \in \mathbf{Z}$ and any integer $m \geq 1$,
 - (a) Along the fold axis between T_I and $T_{I+m\mu p} = T_I \cdot \phi^{m\mu}$, the number of component free splitting units is $\geq m$.
 - (b) The distance in $\mathcal{FS}(\Gamma; \mathcal{A})$ between T_I and $T_I \cdot \phi^{m\mu}$ is $\geq \frac{m}{\nu} \xi$.
- (2) The stable translation length τ_{ϕ} satisfies the lower bound $\tau_{\phi} \ge \frac{1}{\nu\mu} = \frac{1}{\nu(3\kappa + \omega)}$.

Before embarking on the proof of this lemma, we first apply it:

Proof of the Quasigeodesic Axis Property (nonquantitative version): For the fold axis established in the Notation Overview established at the beginning of Section 3.6, we obtain a PF exponent κ from the paragraph of Section 3.5.3 surrounding Definition 3.7. Also, we obtain a filling exponent ω from Lemma 3.11 (which uses Constraint #2 on the value of Ω). Using these exponents in combination with Lemma 3.17 (1b), with the fact that $d(T_{i-1}, T_i) \leq 2$ for all *i*, and with the fact that ϕ acts isometrically on the ϕ -orbit of T_0 , we obtain

$$\frac{1}{\nu} |m - n| - \xi \le d(T_0 \phi^m, T_0 \phi^n) \le 2p |m - n| \quad \text{for all } m, n \in \mathbf{Z}.$$

This proves that ϕ acts loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$, and so the fold axis is quasigeodesic. \diamond

Proof of the Quasigeodesic Axis Property (quantitative version). The implication $(1a) \Longrightarrow (1b)$ comes directly from [HM14, Corollary 5.5] cited earlier. Next, by applying (1b) with I = 0 it follows that

$$\frac{1}{m}d(T_0, T_0 \cdot (\phi^{\mu})^m) \ge \frac{1}{\nu} - \frac{\xi}{m}$$

Letting $m \to \infty$ we have $\tau_{\phi^{\mu}} \ge \frac{1}{\nu}$ and so $\tau_{\phi} = \frac{1}{\mu} \tau_{\phi^{\mu}} \ge \frac{1}{\nu \mu}$, thus proving (1b) \Longrightarrow (2).

Next we reduce the general case of item (1a) to its special case where m = 1, by considering the following *m*-term foldable factorization of the map $f_{I+m\mu p}^{I}: T_{I} \to T_{I+m\mu p}$:

$$T_{I} \xrightarrow{f_{I+\mu p}^{I}} T_{I+\mu p} \to \dots \to T_{I+(j-1)\mu p} \xrightarrow{f_{I+j\mu p}^{I+(j-1)\mu p}} T_{I+j\mu p} \to \dots \to T_{I+(m-1)\mu p} \xrightarrow{f_{I+m\mu p}^{I+(m-1)\mu p}} T_{I+m\mu p}$$

Applying the special case to each arrow in this factorization, there is ≥ 1 component free splitting unit between $T_{I+(j-1)\mu p}$ and $T_{I+j\mu p}$ for each $1 \leq j \leq m$. From Definition 3.15 it then follows that there are $\geq m$ component free splitting units between T_I and $T_{I+m\mu p}$, which proves the general case.

It remains to prove item (1a) in the special case m = 1. Arguing by contradiction, suppose that there exists $I \in \mathbb{Z}$ such that along the axis between $T_{I-\mu p}$ and T_I there is < 1 component free splitting unit (here we are shifting the value of I by one unit of μp). By applying Definition 3.15 we obtain a collapse expand diagram over the portion of the axis between $T_{I-\mu p} = T_{I-(3\kappa+\omega)p}$ and T_I , as depicted in Figure 1, such that along the R-row of the diagram there is a pullback sequence $\beta_i \subset R_i$ of constant component complexity $|\pi_0(\beta_i/\Gamma)|$. Each foldable map $R_i \mapsto R_j$ in the R-row therefore induces a bijection $\pi_0(\beta_i/\Gamma) \approx \pi_0(\beta_j/\Gamma)$ (for $i < j \in [I_2, \ldots, I_0]$). We may assume, after further subdivisions, that each β_i is a union of edgelets of R_i .



Figure 1: Letting $\mu = 3\kappa + \omega$, assuming < 1 free splitting unit between $T_{I-\mu p}$ and T_I , and setting $I = I_0$, $I_1 = I - \kappa p$, and $I_2 = I - \mu p = I_1 - (2\kappa + \omega)p$, there is a collapse expand diagram as depicted with a pullback sequence $\beta_i \subset R_i$ of constant component complexity.

Since $I_1 = I_0 - \kappa p$, we can apply the *Trivial Collapse Property*, Lemma 3.9, to conclude that for each $i \in [I_2, I_1] = [I_1 - (2\kappa + \omega)p, I_1]$ the collapse map $q_i: T_i \to S_i$ can be equivariantly tightened, relative to the vertex set of T_i , to obtain an equivariant homeomorphism $\hat{q}_i: T_i \to S_i$, and the following hold:

Persistence of Filling and Crossing under Collapse: For every $i \in [I_2, I_1]$ and every path $\alpha \subset T_i$ the following hold:

- (1) α fills T_i if and only if $q_i(\alpha) = \hat{q}_i(\alpha)$ fills S_i .
- (2) For every natural edge $E \subset T_i$, the path α has an interior crossing of E if and only if $q_i(\alpha)$ has an interior crossing of $q_i(E) = \hat{q}_i(E)$.

Consider now an arbitrary edge θ of T_{I_2} and its associated θ -tiles throughout the diagram as defined for all $i \in [I_2, \ldots, I_0]$ in Lemma 3.16, denoted $\theta(T_i) \subset T_i$, $\theta(S_i) \subset S_i$, $\theta(R_i) \subset R_i$, and so $\theta(R_{I_2})$ is contained in some natural edge $E \subset R_{I_2}$. Since $I_2 = I_1 - (2\kappa + \omega)p$, we can apply Lemma 3.12, the Uniform Crossing-Filling Property of Section 3.6.1, using the values $\ell = I_1$ and m = 2; from the conclusion of that lemma it follows that the tile $\theta(T_{I_1})$ has $4^2 = 16$ nonoverlapping paths each of which fills T_{I_1} . Applying Persistence of Filling and Crossing under Collapse, the tile $\theta(S_{I_1})$ also has 16 non-overlapping paths each of which fills S_{I_1} . Lifting to R_{I_1} , we conclude that the tile $\theta(R_{I_1})$ has 16 non-overlapping subpaths each of which has an interior crossing of a natural edge in every orbit of natural edges of R_{I_1} . What we need from the latter conclusion is only 5 of those 16 subpaths, and we need only edgelet crossings: there is a subdivision into edgelet subpaths

$$\nu_0 \,\mu_1 \,\nu_1 \,\mu_2 \,\nu_2 \,\mu_3 \,\nu_3 \,\mu_4 \,\nu_4 \,\mu_5 \,\nu_5 = \theta(R_{I_1})$$

such that for each i = 1, 2, 3, 4, 5, the path μ_i crosses some edgelet in every orbit of edgelets of R_{I_1} ; the subpaths ν_i are allowed to be trivial. By pulling back to the tile $\theta(R_{I_2})$ we obtain a subdivision into edgelet paths

$$\nu_0' \,\mu_1' \,\nu_1' \,\mu_2' \,\nu_2' \,\mu_3' \,\nu_3' \,\mu_4' \,\nu_4' \,\mu_5' \,\nu_5' = \theta(R_{I_2}) \subset E$$

Choose any edgelet $\eta \subset \beta_{I_1}$. Choose edgelets $\eta_2 \subset \mu_2$ and $\eta_4 \subset \mu_4$ in the orbit of η . Pull back to get edgelets $\eta'_2 \subset \mu'_2 \subset \beta_{I_2}$ and $\eta'_4 \subset \mu'_4 \subset \beta_{I_2}$ that map to η_2 and η_4 respectively. Let b_2, b_4 denote the components of β_{I_2} containing η'_2, η'_4 respectively. Since each of μ_1, μ_3, μ_5 contains an edgelet of $R_{I_I} \setminus \beta_{I_I}$, it follows that that each of μ'_1, μ'_3, μ'_5 contains an edgelet of $R_{I_2} \setminus \beta_{I_2}$. From this it follows that b_2, b_4 are both contained in the interior of the natural edge E and that they are *distinct* components of β_{I_2} . Since the stabilizer of E with respect to the action of Γ on R_{I_2} is trivial, it follows that b_2 and b_4 are in distinct orbits of components of R_{I_2} . However, the images of b_2, b_4 under the foldable map $R_{I_2} \mapsto R_{I_1}$ both contain edgelets in the orbit of η , and so b_2, b_4 map to components of β_{I_1} that are contained in the same orbit of components of β_{I_1} . This contradicts the fact that the induced map $\pi_0(\beta_{I_2}/\Gamma) \mapsto \pi_0(\beta_{I_1}/\Gamma)$ is a bijection, thus completing the proof of the quantitative version of (1a).

We extract from the above proof the following statement that will be useful in Section 3.7:

Lemma 3.18 (Uniform Lifting–Crossing Property). Fix a PF-exponent κ and a filling exponent ω for the fold axis, and let $\mu = 3\kappa + \omega$. Consider any $I \in \mathbb{Z}$ and any collapse expand diagram over the fold subpath going from T_{I_2} through T_{I_1} to T_{I_0} , where $I_2 = I - \mu p$ and $I_1 = I - \kappa p$ and $I_0 = I$ (see Figure 1). Letting $\theta \subset T_{I_2}$ be any edge, with tiles throughout the diagram denoted as in Lemma 3.16, the tile $\theta(R_{I_1})$ contains sixteen non-overlapping subpaths each of which has an interior crossing of a natural edge in every natural edge orbit of R_{I_1} .

3.7 Finishing the proof: Projection diagrams and bounded cancellation

In this section we complete the proof of the implication $(4) \implies (1)$ of Theorem B. Besides applying many tools from previous sections, additional tools that we bring to bear in this section include: projection diagrams from [HM14]; and bounded cancellation.

We continue with the Notation Overview established at the beginning of Section 3.6.

Let $\Omega = \max\{\Omega_1, \Omega_2\}$ using the constants $\Omega_1 = 5$ as chosen in Section 3.5, and $\Omega_2 = \Theta$ from the Strong Two Over All Theorem as chosen in Section 3.6. Given $\phi \in \operatorname{Out}(\Gamma; \mathcal{A})$, we assume that all orbits of the action of ϕ on $\mathcal{FS}(\Gamma; \mathcal{A})$ have diameter $\geq \Omega$. To review the proof so far, in Section 3.5 we chose a maximal proper ϕ -invariant free factor system \mathcal{F} rel \mathcal{A} , and we used the constraint $\Omega \geq \Omega_1$ to produce a unique attracting lamination Λ for ϕ rel \mathcal{A} that is not supported by \mathcal{F} , together with a fold axis for ϕ relative to \mathcal{F} with an EG-aperiodic train track map for its first return. In each free splitting T_i along that axis, the lines of T_i that realize generic leaves of Λ are precisely those lines that are exhausted by tiles. In Section 3.6 we used the constraint $\Omega \geq \Omega_2$ to prove that the fold axis is quasigeodesic.

Let κ be any PF-exponent and ω any filling exponent of the fold axis; for example κ could be chosen as in the paragraph surrounding Definition 3.7; and ω as in Lemma 3.11. We also let $\mu = 3\kappa + \omega$, for purposes of applying Lemma 3.18, the Uniform Lifting-Crossing Property.

Our goal is to prove that Λ fills Γ rel \mathcal{A} , by showing that a generic leaf $\ell \in \Lambda$ fills Γ rel \mathcal{A} ([Lym22a, Lemma 4.11], and see [HM22, Lemma 4.6]). We do this by applying Corollary 3.5: for an arbitrary Grushko free splitting R of Γ rel \mathcal{A} , letting $\ell_R \subset R$ be the concrete line realizing ℓ , we must prove that the orbit of ℓ covers R, that is, $\Gamma \cdot \ell_R = R$. To put this another way, we must prove that ℓ_R crosses some translate of every edge of R.

In order to relate a general Grushko free splitting R of Γ rel A to the free splittings T_i in the given axis for ϕ , we shall apply the methods of projection diagrams that were introduced in [HM14] and were used there to define projection maps to fold paths for purposes of verifying the Masur–Minsky axioms.

Let $\mathcal{FS}^{(0)}(\Gamma; \mathcal{A})$ denote the 0-skeleton of the simplicial complex $\mathcal{FS}(\Gamma; \mathcal{A})$.

Definition 3.19 (Projection Diagrams and Projection Functions). ([HM14, Sections 4.3, 5.2]) Consider a (finite) fold path $T_I \mapsto \cdots \mapsto T_J$ in $\mathcal{FS}(\Gamma; \mathcal{A})$. For any free splitting R of Γ rel \mathcal{A} and any integer $\Delta \in [I, \ldots, J]$, a projection diagram from R to $T_I \mapsto \cdots \mapsto T_J$ of depth Δ is a diagram of the form



such that the bottom row is the given fold path, the R and S rows are both foldable sequences (see Section 2.1.1), and the two rectangles depicted are combing rectangles (see Definition 2.17) and hence those two rectangles taken together form a collapse expand rectangle (see Section 3.6).

Associated to the fold path $T_I \mapsto \cdots \mapsto T_J$ is its projection function

$$\Delta \colon \mathcal{FS}^{(0)}(\Gamma;\mathcal{A}) \to [I,\ldots,J]$$

which assigns to each free splitting $R \in \mathcal{FS}^{(0)}(\Gamma; \mathcal{A})$ the maximum value $\Delta(R)$ of the depths Δ of all projection diagrams from R to $T_I \mapsto \cdots \mapsto T_J$. A maximal depth projection diagram from R to $T_I \mapsto \cdots \mapsto T_J$ is one of depth $\Delta = \Delta(R)$.

In the context of Definition 3.19, we shall silently use the fact that for $\Delta \leq \Delta' \in [I, \ldots, J]$, if there exists a projection diagram of depth Δ' then there exists one of depth Δ : remove $S_{\Delta+1}, \ldots, S_{\Delta'}$ and all incident arrows from the diagram of depth Δ ; and compose the sequence of maps

$$R_{\Delta} \mapsto \ldots \mapsto R_{\Delta'} \mapsto R$$

from the depth Δ' diagram to form the single map $R_{\Delta} \mapsto R$ needed for the depth Δ diagram.

In [HM14], the way that hyperbolicity of $\mathcal{FS}(\Gamma; \mathcal{A})$ was proved was to show that the collection of fold paths and their projection functions satisfy the Masur–Minsky axioms with respect to constants $A = A(\Gamma; \mathcal{A})$, $a = a(\Gamma; \mathcal{A})$, $b = b(\Gamma; \mathcal{A})$, and $c = c(\Gamma; \mathcal{A})$. We shall need a further property that follows from the Masur–Minsky axioms, as shown in [HM14, Section 5.1]. Here we state that property only in the context of Definition 3.19:

Quasi-Closest Point Property: For any finite fold path $T_I \mapsto \cdots \mapsto T_J$ and any $R \in \mathcal{FS}(\Gamma; \mathcal{A})$ with projection $\Delta(R) \in [I, \ldots, J]$, choosing $M \in [I, \ldots, J]$ so that $D = d(R, T_M)$ minimizes the distances $d(R, T_i)$ over all $i \in [I, \ldots, J]$, it follows that

$$\operatorname{diam}\left\{T_i \mid i \in [\Delta(R), \dots, M]\right\} \le K \log D + C$$

with constants $K = K(\Gamma; \mathcal{A}), C = C(\Gamma; \mathcal{A}) \ge 0$ depending only on the constants a, b, c mentioned in the previous paragraph.

For the rest of this section we fix $R \in \mathcal{FS}(\Gamma; \mathcal{A})$. Let $M_R \in \mathbb{Z}$ be chosen so that $D_R = d(R, T_{M_R})$ minimizes the distances $d(R, T_i)$ over all $i \in \mathbb{Z}$, hence also D_R minimizes distances over all i in any integer interval containing M_R .

Projection diagrams from R are only defined to *finite* fold paths. In order to effectively apply projection diagrams along our fold axis, depending on R we need to carefully choose indices $I \leq J$ for the endpoints of a fold subpath $T_I \mapsto \cdots \mapsto T_J$ to which we shall project R. Our first strategy is to choose I, J so that we obtain some kind of "global control" over the projection of R to the subpath. First we constrain I and J so that $I \leq M_R \leq J$; it follows D_R minimizes $d(R, T_i)$ over all $i \in [I, \ldots, J]$. Our next constraint is a certain upper bound I_0 for I and a lower bound J_0 for J which we may choose as follows, using that the fold axis is a bi-infinite quasigeodesic:

(1)
$$I_0 \leq M_R \leq J_0$$

(2) If $i \in \mathbf{Z} - [I_0, \dots, J_0]$ then $d(T_i, T_{M_R}) > K \log D_R + C$.

By combining (1) and (2) with the *Quasi-Closest Point Property* we obtain the desired global control on the projection of R:

Restricted Projection Property: If $I \leq I_0 \leq J_0 \leq J$ then, letting $\Delta_{IJ}(R) \in [I, \ldots, J]$ denote the projection of R to $T_I \mapsto \cdots \mapsto T_J$, we have $I_0 \leq \Delta_{IJ}(R) \leq J_0$.



Figure 2: The Main Projection Diagram. This is a projection diagram from R to $T_{I_2} \mapsto \cdots \mapsto T_{J_0}$ of maximal depth Δ satisfying $I_0 \leq \Delta \leq J_0$ (by the *Restricted Projection Property*). The portion of this diagram between column I_2 and column I_0 is a collapse expand diagram to which Lemma 3.18 may be applied. The diagram also depicts the map g_{I_0} , which is one of the foldable maps $g_i \colon R_i \to R$ obtained by composing arrows in the *R*-row.

Further remarks on "Quasi-Closest" versus "Almost Closest": For most of the long lifetime of the composition of this work, our proof of the implication $(4) \implies (1)$ of Theorem B had applied the "Almost Closest Point Property", a stronger version of the Quasi-Closest Point Property in which the upper bound $K \log d + C$ is replaced by a constant C. The way that stronger property had been applied was to choose $I_0 \leq M_R \leq J_0$ so as to have a sufficiently large but fixed radius $M_R - I_0 = J_0 - M_R$, so large that we could deduce the Restricted Projection Property from the "Almost Closest Point Property" and from a certain constraint on Ω . Only in a very late draft did we realize that this choice was impossible, because the "Almost Closest Point Property" is generally false (see remarks found at the end of [HM14, Section 5.1]). But two further realizations saved the proof: that the "Almost Closest Point" property could be replaced by the Quasi-Closest Point Property; and the value Ω_2 of the second constraint on Ω could be chosen so as to force the Quasigeodesic Axis Property to hold. These, taken together, allowed us to recover the Restricted Projection Property with a more realistic allowance for the positions of I_0 and J_0 , one that allow the radius to enlarge as the free splitting R retreats further from the fold axis.

The next step of our strategy is to choose an integer interval that contains $[I_0, \ldots, J_0]$ and that extends far enough to allow application of Lemma 3.18, the Uniform Lifting-Crossing Property of Section 3.6.3, (there is no need to extend any further to the right). We use again the notation from Section 3.6.3, namely $\mu = 3\kappa + \omega$, and $I_1 = I_0 - \kappa p$, and $I_2 = I_0 - \mu p = I_1 - (2\kappa + \omega)p$. Working with the fold subpath $T_{I_2} \mapsto \cdots \mapsto T_{J_0}$, let $\Delta = \Delta_{I_2J_0}(R)$ denote the projection of R to that subpath. By applying the *Restricted Projection Property* we have $I_0 \leq \Delta \leq J_0$ and so we can depict a maximal depth projection diagram as shown in Figure 2, which we refer to as the Main Projection Diagram.

Next we state facts about realizations of generic leaves of Λ in the *Main Projection Diagram* that parallel facts about θ -tiles described in Lemma 3.16.

Lemma 3.20 (Generic leaves throughout the Main Projection Diagram). Any generic leaf $\ell \in \Lambda$ is realized as a concrete line in every free splitting of the Main Projection Diagram. Furthermore, the following hold for all $I_2 \leq i \leq j \leq I_0$:

- (1) In the T row: The foldable map $T_i \mapsto T_j$ takes $\ell(T_i)$ homeomorphically to $\ell(T_j)$.
- (2) Between the T and S rows: The collapse map $T_i \to S_i$ takes $\ell(T_i)$ onto $\ell(S_i)$.
- (3) In the S-row: The foldable map $S_i \mapsto S_j$ takes $\ell(S_i)$ homeomorphically to $\ell(S_j)$.
- (4) Between the S and R rows: The collapse map $R_i \to S_i$ takes $\ell(R_i)$ onto $\ell(S_i)$.
- (5) In the *R*-row: For each $I_2 \leq i \leq I_0$, letting *C* be a bounded cancellation constant for $g_i \colon R_i \to R$, we have $\ell(R) \subset g_i(\ell(R_i)) \subset N_C(\ell(R))$.

Proof. We start by proving the opening sentence of the lemma, and item (2), and item (4). In the T row which is a fold subpath of the axis, we may apply Conclusion (2c) of Section 3.5.2: for any choice of collapse map $V \mapsto T_i$ defined on any Grushko free splitting V of Γ rel \mathcal{A} , the line $\ell(V)$ is mapped onto the concrete realization $\ell(T_i)$, and the latter is a bi-infinite line that is exhausted by iteration tiles. Since $\ell(T_i)$ contains a κ -tile of T_i , and since each κ -tile crosses a translate of every edge (by Definition 3.7), it follows that $\ell(T_i) \not\subset T_i$. In the S row, the image of $\ell(T_i)$ under the collapse map $T_i \mapsto S_i$ is therefore not a point. That image is equal to the image of $\ell(V)$ under the composed collapse map $V \mapsto T_i \mapsto S_i$. Since $\ell(V)$ is birecurrent, by application of Lemma 3.4 that image is a concrete line in S_i equal to the realization $\ell(S_i)$; this proves (2).

In the R row, since the free splitting R itself is a Grushko free splitting rel \mathcal{A} , the realization $\ell(R)$ is a concrete line. Also, by equivariance of each map $g_i \colon R_i \to R$ it follows that each R_i is also a Grushko free splitting rel \mathcal{A} . The line ℓ is therefore realized as a concrete line $\ell(R_i) \subset R_i$, and (4) holds again by Lemma 3.4.

We next prove (1). By foldability along the axis, it follows that the map $T_i \mapsto T_j$ restricts to an injection on each edgelet tile in $\ell(T_i)$. Using that $\ell(T_i)$ is exhausted by edgelet iteration tiles of T_i , each the image of an edgelet somewhere earlier in the fold axis, it follows that the map $T_i \mapsto T_j$ restricts to an injection on all of $\ell(T_i)$, and the image line in T_j is clearly $\ell(T_j)$.

To prove item (3), in the Main Projection Diagram consider the commuting square with S_i, S_j, T_i, T_j at the corners. We use the edgelet subdivisions under which the subforests $\mathcal{T}_i \subset T_i$ and $\mathcal{T}_j \subset T_j$ are subcomplexes and all four maps in that square are simplicial. Let $h_j^i : S_i \to S_j$ and $f_j^i : T_i \to T_j$ denote the foldable maps in the S-row and T rows. It suffices to show for that any two distinct 1-simplices $e \neq e' \subset \ell(S_i)$ we have $h_j^i(e) \neq h_j^i(e')$. Lifting e, e' we get distinct 1-simplices $\tilde{e} \neq \tilde{e}' \subset \ell(T_i) \setminus \mathcal{T}_i$, and by (1) we have distinct 1-simplices $f_j^i(\tilde{e}) \neq f_j^i(\tilde{e}') \subset \ell(T_j) \setminus \mathcal{T}_j$, which therefore project to distinct 1-simplices in S_j ; the latter, by commutativity, are identified with $h_j^i(e), h_j^i(e')$ respectively.

Item (5) follows from Lemma 3.4.

 \diamond

We turn now to the proof, using bounded cancellation, that $\ell(R)$ crosses a translate of every edgelet of R. Fix any edge $\theta \in T_{I_2}$, and consider the θ -tiles throughout the portion of the Main Projection Diagram between columns I_2 and I_0 . By applying Lemma 3.18, the Uniform Lifting– Crossing Property, we conclude that $\theta(R_{I_1})$ contains sixteen nonoverlapping subpaths each of which has an interior crossing of a representative of every natural edge orbit of R_{I_1} . We need only three of those sixteen subpaths, using which we obtain a decomposition of the form

$$\theta(R_{I_1}) = \alpha_0 \,\beta_1 \,\alpha_1 \,\beta_2 \,\alpha_2 \,\beta_3 \,\alpha_3$$

in which the α 's are possibly trivial subpaths, and each subpath β_j $(1 \le j \le 3)$ has an interior crossing of a representative of every natural edge orbit of R_{I_1} . We will need only the weaker property that each β_j crosses a representative of every edgelet orbit of R_j .

By Conclusion (5) of Lemma 3.16, $\theta(R_{I_2})$ is contained in a natural edge of R_{I_2} , and so the foldable map $g_{I_2} : R_{I_2} \to R$ restricts to an injection on $\theta(R_{I_2})$. Also by that same conclusion, the map $R_{I_2} \mapsto R_{I_1}$ takes $\theta(R_{I_2})$ homeomorphically to $\theta(R_{I_1})$. Since g_{I_2} factors as $R_{I_2} \mapsto R_{I_1} \xrightarrow{g_{I_1}} R$, it follows that the map $R_{I_1} \mapsto R$ restricts to an injection on $\theta(R_{I_1})$. Denoting the image of this injection as $\theta(R)$, we obtain a decomposition

$$\theta(R) = A_0 B_1 A_1 B_2 A_2 B_3 A_3$$

where A_i , B_i are the images of the α_i , β_i respectively. Since each β_i crosses a representative of every edgelet orbit of R_{I_1} , it follows that each B_i crosses a representative of every edgelet orbit of R.

Consider a generic leaf $\ell \in \Lambda$. Since its realization $\ell(T_{I_2})$ crosses a translate of every edge of T_{I_2} , we may rechoose ℓ in its orbit so that in T_{I_2} , the line $\ell(T_{I_2})$ crosses the edge $\theta = \theta(T_{I_2})$. Combining Lemma 3.20 (1) with Lemma 3.16 (1) it follows that in T_{I_1} , the line $\ell(T_{I_1})$ crosses the tile $\theta(T_{I_1})$. Combining Lemma 3.20 (2) with Lemma 3.16 (2) it follows in S_{I_1} , the line $\ell(S_{I_1})$ crosses the tile $\theta(S_{I_1})$. Combining Lemma 3.20 (4) with Lemma 3.16 (4) it follows that in R_{I_1} , the line $\ell(R_{I_1})$ crosses the tile $\theta(R_{I_1})$.

We shall finish the proof by applying bounded cancellation of the foldable map $g_{I_1} : R_{I_1} \mapsto R$, using the concrete lines $\ell(R_{I_1})$ in R_{I_1} and $\ell(R)$ in R. Since R_{I_1} and R are both Grushko free splittings rel A, one can use the form of bounded cancellation stated in [HM22, Lemma 4.14 (3)]: using the edgelet subdivisions of R_{I_1} and R with respect to which the map g_{I_1} is simplicial, and assigning length 1 to all edgelets so that g_{I_1} restricts to an isometry from each edgelet of R_{I_1} to an edgelet of R, it follows that the map g_{I_1} has bounded cancellation constant

$$C = \text{Length}(R_{I_1}) - \text{Length}(R) = \#\text{edges}(R_{I_1}) - \#\text{edges}(R)$$

and that

$$g_{I_1}(\ell(R_{I_1})) \subset N_C(\ell(R))$$

Restricting to the subpath $\theta(R_{I_1}) \subset \ell(R_{I_1})$ we therefore have

$$(\#) \qquad \underbrace{g_{I_1}(\theta(R_{I_1}))}_{\theta(R)} \subset N_C(\ell(R))$$

Consider the decomposition $\theta(R) = \nu_{-} \nu_{0} \nu_{+}$ where $\nu_{0} = \theta(R) \cap \ell(R)$ is the maximal common subpath of $\theta(R)$ and $\ell(R)$. The initial path ν_{-} meets the line $\ell(R)$ only in the terminal endpoint of ν_{-} , and so the initial endpoint of ν_{-} achieves the maximum distance to $\ell(R)$ amongst all points on ν_{-} , that maximal distance being equal to Length(ν_{-}); applying (#) it follows that Length $(\nu_{-}) \leq C$. By a similar argument we have Length $(\nu_{+}) \leq C$. Since β_1 crosses a translate of every edge of R_{I_1} , it follows that

$$\operatorname{Length}(A_0 B_1) = \operatorname{Length}(\alpha_0 \beta_1) \ge C$$

and similarly

$$\operatorname{Length}(B_3 A_3) = \operatorname{Length}(\beta_3 \alpha_3) \ge C$$

thus ν_{-} is a subpath of A_0B_1 , and ν_{+} is a subpath of B_3A_3 . It then follows that $A_1B_2A_2$ is a subpath of ν_0 and hence of $\ell(R)$. Since B_2 crosses a translate of every edgelet of R, so does $\ell(R)$. This completes the proof that Λ fills Γ rel \mathcal{A} , and hence the proof of the implication $(4) \Longrightarrow (1)$ of Theorem B.

4 The lower bound in Theorem A.

Consider an outer automorphism $\phi \in \text{Out}(\Gamma; \mathcal{A})$ which has a filling attracting lamination rel \mathcal{A} . Having proved Theorem B (in Part II [HM22] and in previous sections here in Part III), this is equivalent to saying that ϕ acts loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$, with stable translation length $\tau_{\phi} > 0$. In this section we find a constant $A = A(\Gamma; \mathcal{A}) > 0$ independent of ϕ such that $\tau_{\phi} \geq A$.

The proof was outlined in the introduction, and a more detailed outline is found in Section 4.1. The proof applies tools from Section 3, namely PF-exponents (Definition 3.7) and filling exponents (Definition 3.10), and Lemma 3.17 (2) which gives a positive lower bound for τ_{ϕ} expressed as a function of a PF-exponent κ and a filling exponent ω of an EG-aperiodic train track axis for ϕ , the form of that function depending only on corank($\Gamma; \mathcal{A}$) and $|\mathcal{A}|$. This reduces the problem to finding uniform values of κ and ω , depending only on corank($\Gamma; \mathcal{A}$) and $|\mathcal{A}|$. We describe such values for the special class of EG-aperiodic train track axes obtained by suspending a train track representative defined on a natural free splitting. For such axes, a uniform PF-exponent is described in Proposition 4.3 proved in Section 4.3, and a uniform filling exponent is described in Proposition 4.4 proved in Section 4.4. Proposition 4.1 produces the axes that we need for these applications.

4.1 Finding the lower bound.

Here is the description of the strong class of EG-aperiodic fold axes that will be used in the proof:

Proposition 4.1. For any $\phi \in \text{Out}(\Gamma; \mathcal{A})$ acting loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$, and for any maximal, proper, ϕ -invariant free factor system \mathcal{F} , in the relative free splitting complex $\mathcal{FS}(\Gamma; \mathcal{A})$ there exists an EG-aperiodic fold axis for ϕ such that T_0 is a natural, Grushko free splitting with respect to \mathcal{F} .

Proof. First we apply the following:

Theorem 4.2 ([FM15, Theorem 8.24]). There exists an irreducible train track representative $f: T \to T$ with respect to \mathcal{F} where T is a natural Grushko free splitting relative to \mathcal{F} .

See Section 4.4 for a further discussion of this theorem, including: some details of translation between the language of [FM15] and our language here, in order to aid the citation; and a different proof of the theorem, adapting the original construction for $Out(F_n)$ found in [BH92].

To finish the proof, by applying Conclusion (2c) of Section 3.5.2 it follows that Λ — the unique filling lamination for ϕ rel \mathcal{A} — is identified with the unique filling lamination for ϕ rel \mathcal{F} , under any collapse map to T defined on a Grushko free splitting rel \mathcal{A} . Applying relative train track methods as summarized in [HM22, Theorem 4.17], it follows that the train track representative $f: T \to T$ given in Theorem 4.2 is EG-aperiodic. Applying [HM22, Proposition 4.22] we obtain an EG-aperiodic fold axis for ϕ with respect to \mathcal{F} such that $T = T_0$ and such that its first return map is $f: T \to T$.

We next state propositions regarding a uniform PF-exponent (Definition 3.7) and a uniform filling exponent (Definition 3.10):

Proposition 4.3 (Uniform PF exponents for natural iteration tiles). There exist an integer $\kappa_0 = \kappa_0(\Gamma; \mathcal{A}) \geq 1$ such that for any $\phi \in \text{Out}(\Gamma; \mathcal{A})$ that acts loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$, for any maximal, proper, ϕ -invariant free factor system \mathcal{F} , and for any EG-aperiodic fold axis of ϕ relative to \mathcal{F} such that T_0 is a natural free splitting, κ_0 is a PF exponent.

Proposition 4.4 (Uniform filling exponents for natural iteration tiles). There exist an integer $\omega_0 = \omega_0(\Gamma; \mathcal{A}) \geq 1$ such that for any $\phi \in \text{Out}(\Gamma; \mathcal{A})$ that acts loxodromically on $\mathcal{FS}(\Gamma; \mathcal{A})$, for any maximal, proper, ϕ -invariant free factor system \mathcal{F} , and for any EG-aperiodic fold axis of ϕ relative to \mathcal{F} such that T_0 is a natural free splitting, ω_0 is a filling exponent.

The proofs of these two propositions are found in Sections 4.2 and 4.3 respectively. Here we quickly apply them:

Proof of the lower bound for Theorem A. Using the constants $\kappa_0(\Gamma; \mathcal{A}) \geq 1$ and $\omega_0(\Gamma; \mathcal{A}) \geq 1$ from Propositions 4.3 and 4.4, and the constant $\nu = \nu(\Gamma; \mathcal{A}) \geq 1$ from Proposition 3.17 (which ultimately derives from [HM14, Corollary 5.5]), by applying that proposition we obtain the inequality $\tau_{\phi} \geq \frac{1}{\nu(3\kappa_0 + \omega_0)}$.

4.2 Finding a uniform PF exponent: Proof of Proposition 4.3

First we show that if κ is a PF exponent for for $F_0: T_0 \to T_0$ then $\kappa + 1$ is a PF exponent for each $F_j: T_j \to T_j$. By periodicity, κ is also a PF-exponent for every $F_{ip}: T_{ip} \to T_{ip}$ $(i \in \mathbb{Z})$. Using the notation of Section 3.5.2, we have a factorization $F_{ip}^{\kappa} = f_{ip}^{(i-\kappa)p} \circ h_{(i-\kappa)p}^{ip}$. Recalling that the *h*-maps are all simplicial isomorphisms, the transition matrix of the map $f_{ip}^{(i-\kappa)p}$ has all entries ≥ 4 . Next we show that $\kappa + 1$ is a PF exponent for every F_j $(j \in \mathbb{Z})$. By periodicity it suffices to show this for 0 < j < p. Noting that $j - (\kappa + 1)p \leq -\kappa p$, consider the map $F_j^{\kappa+1}: T_j \to T_j$ which factors as

$$F_j^{\kappa+1} \colon T_j \xrightarrow{h_{j-(\kappa+1)p}^j} T_{j-(\kappa+1)p} \xrightarrow{f_{-\kappa p}^{j-(\kappa+1)p}} T_{-\kappa p} \xrightarrow{f_0^{-\kappa p}} T_0 \xrightarrow{f_j^0} T_j$$

Since the transition matrix for the map $f_0^{-\kappa p}$ has all entries ≥ 4 , it follows that the transition matrix for $F_j^{\kappa+1}$ has all entries ≥ 4 .

Using that T_0 is a natural free splitting, what remains is to prove that there is a uniform PF-exponent $\kappa_1 = \kappa_1(\Gamma; \mathcal{A})$ for all EG-aperiodic train track maps $F: T \to T$ defined on natural free splittings T of Γ rel \mathcal{A} , for then we can take $\kappa_0 = \kappa_1 + 1$. The number of natural edge orbits

of T is bounded above by $m_1 = 3 \operatorname{corank}(\mathcal{A}) + 2 |\mathcal{A}| - 3$, and so transition matrix M for F is an $m \times m$ matrix of non-negative integers with $m \leq m_1$. Consider the $m \times m$ Boolean matrix \widehat{M} that is obtained from M by replacing every positive entry with a 1. For each $i \geq 1$, note that the Boolean power \widehat{M}^i is obtained from the ordinary power M^i in a similar fashion, by replacing every positive entry with a 1. There are only finitely many $m \times m$ Boolean matrices such that $m \leq m_1$, and so amongst those that have a Boolean power with all positive entries, there is a uniform exponent $\kappa_2 = \kappa_2(\Gamma; \mathcal{A})$ achieving that power. The matrix M^{κ_2} therefore has all positive entries. It follows that every entry of $M^{3\kappa_2}$ is ≥ 4 , hence $\kappa_1 = 3\kappa_2$ is a PF-exponent for F.

4.3 Finding a uniform filling exponent: Proof of Proposition 4.4

As in the proof of Proposition 4.3, first we show that if ω is a filling exponent for F_0 then $\omega + 1$ is a filling exponent for each $F_j: T_j \to T_j$. And again, we may assume 0 < j < p, hence $j - (\omega + 1)p \leq -\omega p$, and we consider the factorization of $F_j^{\omega+1}: T_j \to T_j$ depicted in the top line of the following diagram:

In this diagram we choose an arbitrary edge of T_j , whose image under the simplicial isomorphism $h_{j-(\omega+1)p}^j$ is an edge of $T_{j-(\omega+1)p}$ denoted $E = \eta$, with images η', η'', η''' (along the foldable path from $T_{j-(\omega+1)p}$ to T_j) as depicted in the bottom line of the diagram. What we have to prove is that η''' fills T_j . Each map takes vertices to vertices, and so η' is a nontrivial path in $T_{-\omega p}$ which crosses at least one whole edge E' of $T_{-\omega p}$. Since ω is a filling exponent for F, in T_0 it follows that the path $f_0^{-\omega p}(E')$ fills T_0 , but that is a subpath of η'' and so η'' itself fills T_0 . Then, applying Lemma 2.15, it follows that the path $\eta''' = f_j^0(\eta'')$ fills T_j .

What remains is to find a uniform constant $\omega = \omega(\Gamma; \mathcal{A})$ which is a filling exponent for the first return map $F_0: T_0 \to T_0$ of the axis. Henceforth we drop the subscript 0 and write this map as $F: T \to T$. Since T is a natural free splitting, applying Proposition 4.3 we obtain a uniform PF exponent $\kappa = \kappa(\Gamma; \mathcal{A})$ for F. The map $G = F^{\kappa}: T \to T$ is an EG-aperiodic train track representative of ϕ^{κ} , it has filling exponent 1, and the outer automorphisms ϕ and $\phi^{\kappa} \in \text{Out}(\Gamma; \mathcal{A})$ share the same filling lamination Λ . It suffices to show that the uniform constant $\text{KR}(\Gamma; \mathcal{A}) = |\mathcal{A}| + \text{corank}(\mathcal{A})$ is a filling exponent for G, because then the uniform constant $\omega = \kappa \cdot \text{KR}(\Gamma; \mathcal{A})$ is a filling exponent for F.

Fix an arbitrary edge $E \subset T$. Since G has filling exponent 1, the tile G(E) has four crossings of translates of E, and hence G(E) has an interior crossing of some translate of E. After replacing G with $\gamma \cdot G$ for an appropriately chosen $\gamma \in \Gamma$, we may assume that G(E) has an interior crossing of E itself. Iterating G, we obtain the following monotonically nested sequence of iteration tiles

$$\underbrace{E}_{\eta_0} \subset \underbrace{G(E)}_{\eta_1} \subset \underbrace{G^2(E)}_{\eta_2} \subset \underbrace{G^3(E)}_{\eta_3} \subset \cdots \subset \underbrace{G^m(E)}_{\eta_m} \subset \cdots$$

such that each tile in this sequence has an interior crossing of every previous tile. For later use we choose $\Psi \in \operatorname{Aut}(\Gamma; \mathcal{A})$ representing ϕ^{κ} so that $G = F^{\kappa}$ is Ψ -twisted equivariant.

Figure 3: Associated to the monotonically nested tile sequence $\eta_0 \subset \ldots \subset \eta_m \subset \ldots$ is this matrix of monotonic relation sequences, such that in each column of relations *one* equation holds if and only if *all* equations hold (see Lemma 2.19). In the final row, the upper bound $\operatorname{KR}(\Gamma; \mathcal{A}) = |\mathcal{A}| + \operatorname{corank}(\mathcal{A})$ on relative Kurosh ranks $\operatorname{KR}(\eta_i) = \operatorname{KR}(F_{\min}(\eta_i))$ is found in [HM22, Lemma 2.9].

For the remainder of the proof we shall show, using $\mu = \text{KR}(\Gamma; \mathcal{A})$, that the tile η_{μ} fills T. Since $\eta_{\mu} = G^{\mu}(E) = F^{\kappa\mu}(E)$, this shows that the uniform constant $\omega = \kappa \mu = \kappa \cdot \text{KR}(\Gamma; \mathcal{A})$ is a filling exponent for F.

Since each tile η_m has an interior crossing of a translate of every edge of T, the covering forest of η_m is the full tree $\beta(\eta_m) = T$ ([HM22, Definition 5.6]). Recall from Definition 2.8, from Lemma 2.11 and from Definition 2.12 the following objects associated to η_m : its filling protoforest $\beta^{\rm f}(\eta_m)$; the unique protocomponent $\beta^{\rm f}_{\rm Id}(\eta_m)$ of $\beta^{\rm f}(\eta_m)$ that contains η_m ; the associated filling support $F_{\rm min}(\eta_m) = {\rm Stab}(\beta^{\rm f}_{\rm Id}(\eta_m))$ which is a free factor of Γ rel \mathcal{A} , and which has Kurosh rank rel \mathcal{A} denoted ${\rm KR}(\eta_m) = {\rm KR}(F_{\rm min}(\eta_m))$; and the associated free factor system denoted $\mathcal{F}[\eta_m] = \mathcal{F}[\eta_m; T]$. By applying Lemma 2.19 to the monotonic sequence of paths above, these objects may all be arranged in the matrix with monotonic rows depicted in Figure 3.

For each column of relations in Figure 3, (i.e. for each $m \ge 0$), since $\beta(\eta_m) = \beta(\eta_{m+1}) = T$ we may apply Lemma 2.19 to conclude that the following two statements are equivalent:

(i) One of these four equations holds:

$$\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_m) = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_{m+1}), \quad \beta^{\mathrm{f}}(\eta_m) = \beta^{\mathrm{f}}(\eta_{m+1}), \quad F_{\min}(\eta_m) = F_{\min}(\eta_{m+1}), \quad \mathrm{KR}(\eta_m) = \mathrm{KR}(\eta_{m+1})$$

(ii) All four of those equations hold.

Applying monotonicity and boundedness of the Kurosh ranks in the fourth row of matrix in Figure 3, it follows that there exists an integer M with $1 \leq M \leq \text{KR}(\Gamma; \mathcal{A})$ such that $\text{KR}(\eta_M) = \text{KR}(\eta_{M+1})$. Applying equivalence of (i) and (ii) in the case m = M we get the following statement:

(iii) All relations in the matrix between columns M and M + 1 are equations:

 $\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M) = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_{M+1}), \quad \beta^{\mathrm{f}}(\eta_M) = \beta^{\mathrm{f}}(\eta_{M+1}), \quad F_{\min}(\eta_M) = F_{\min}(\eta_{M+1}), \quad \mathrm{KR}(\eta_M) = \mathrm{KR}(\eta_{M+1})$ Using this statement we now prove:

(iv) $G(\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M)) = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M)$

To start the proof choose $\Psi \in \operatorname{Aut}(\Gamma; \mathcal{A})$ representing ϕ^{κ} so that $G = F^{\kappa}$ is Ψ -twisted equivariant:

$$G(\gamma \cdot x) = \Psi(\gamma) \cdot G(x)$$
 for all $x \in S$

Knowing that G restricts to a homeomorphism $\eta_M \mapsto \eta_{M+1}$, it follows for each $\gamma \in \Gamma$ that G restricts to a homeomorphism $\gamma \cdot \eta_M \mapsto \Psi(\gamma) \cdot \eta_{M+1}$. And from this it follows that G maps each η_M -connection of the form

(*)
$$\eta_M, \quad g_1 \cdot \eta_M, \quad \dots, \quad g_I \cdot \eta_M$$

to an η_{M+1} connection of the form

$$(**) \qquad \underbrace{\eta_{M+1}}_{G(\eta_M)}, \underbrace{\Psi(g_1) \cdot \eta_{M+1}}_{G(g_1 \cdot \eta_M)}, \ldots, \underbrace{\Psi(g_I) \cdot \eta_{M+1}}_{G(g_I \cdot \eta_M)}$$

We use this to prove that for any edge $e \subset G(\beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M))$ we have $e \subset \beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_{M+1})$. Choosing any $e' \subset \eta_M \subset \eta_{M+1} = G(\eta_M)$, it suffices to construct an η_{M+1} connection from e' to e. Since $e \subset G(\beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M))$, we may choose an edge $e'' \subset \beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M)$ such that $e \subset G(e'')$. By definition of $\beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M)$, there is an η_M -connection from e' to e'' as shown in (*) above; in particular $e'' \subset g_I \cdot \eta_M$. Its G image, shown in (**), is the desired η_{M+1} -connection from $e' \subset \eta_{M+1}$ to $e \subset G(e'') \subset G(g_I \cdot \eta_M)$. We have proved that

$$G(\beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M)) \subset \beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_{M+1})$$

We now consider the stabilizer subgroup $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\eta_M))$ and its Ψ image $\Psi(\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\eta_M)))$. For all $g \in \operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\eta_M))$ we have

$$\Psi(g) \cdot G(\beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M)) = G(g \cdot \beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M)) = G(\beta_{\mathrm{Id}}^{\mathrm{o}}(\eta_M))$$

The subgroup $\Psi(\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\eta_M)))$ therefore stabilizes the tree $G(\beta_{\operatorname{Id}}^{\circ}(\eta_M))$. Since $G(\beta_{\operatorname{Id}}^{\circ}(\eta_M))$ is a subtree of $\beta_{\operatorname{Id}}^{\circ}(\eta_{M+1})$, and since $\beta_{\operatorname{Id}}^{\circ}(\eta_{M+1})$ is a protocomponent of the protoforest $\beta^{\circ}(\eta_{M+1})$, it follows that the subgroup $\Psi(\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\eta_M)))$ stabilizes $\beta_{\operatorname{Id}}^{\circ}(\eta_{M+1})$:

$$\Psi(\operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\eta_M))) \leqslant \operatorname{Stab}(\beta_{\operatorname{Id}}^{\operatorname{o}}(\eta_{M+1})) \leqslant F_{\min}(\eta_{M+1}) = F_{\min}(\eta_M)$$

where the last equation $F_{\min}(\eta_{M+1}) = F_{\min}(\eta_M)$ comes from item (iii) above.

By definition $F_{\min}(\eta_M)$ is the minimal free factor of Γ rel \mathcal{A} containing $\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\eta_M))$. Since $\Psi \in \operatorname{Aut}(\Gamma; \mathcal{A})$, it follows that the minimum free factor of Γ rel \mathcal{A} containing $\Psi(\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\eta_M)))$ is $\Psi(F_{\min}(\eta_M))$. So we have two free factors of Γ rel \mathcal{A} of equal Kurosh ranks, namely $F_{\min}(\eta_M)$ and $\Psi(F_{\min}(\eta_M))$, each containing the subgroup $\Psi(\operatorname{Stab}(\beta_{\operatorname{Id}}^{\circ}(\eta_M)))$; and it is known that one of these two, namely $\Psi(F_{\min}(\eta_M))$, is the unique minimal such free factor of Γ rel \mathcal{A} . These two free factors are therefore equal:

$$\Psi(F_{\min}(\eta_M)) = F_{\min}(\eta_M)$$

It follows that

$$G(\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_{M})) = G(F_{\min}(\eta_{M}) \cdot \eta_{M}) = \Psi(F_{\min}(\eta_{M})) \cdot G(\eta_{M})$$
$$= F_{\min}(\eta_{M}) \cdot \eta_{M+1} = F_{\min}(\eta_{M+1}) \cdot \eta_{M+1} = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_{M+1})$$
$$= \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_{M})$$

where, again, the last equation $\beta_{\text{Id}}^{\text{f}}(\eta_{M+1}) = \beta_{\text{Id}}^{\text{f}}(\eta_M)$ comes from item (iii). This completes the proof of (iv).

Next we prove:

(v) $F_{\min}(\eta_M) = \Gamma$, hence the tile η_M fills S.

Since $G(\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M)) = \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M)$, starting from $\eta_M \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M)$ and using that $G(\eta_m) = \eta_{m+1}$ for all m it follows by induction that $\eta_m \subset \beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M)$ for all $m \geq M$. The generic leaf $\ell = \bigcup_{m\geq 0} \eta_m$ is therefore contained in $\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M)$. Since $F_{\min}(\eta_M) = \mathrm{Stab}(\beta_{\mathrm{Id}}^{\mathrm{f}}(\eta_M))$, and since $\mathcal{F}[\eta_M]$ is the smallest free factor system having $[F_{\min}(\eta_M)]$ as a component, it follows that ℓ is supported by $\mathcal{F}[\eta_M]$. But ℓ is a generic leaf of the attracting lamination Λ , and hence Λ is supported by $\mathcal{F}[\eta_M]$. Since Λ fills Γ rel \mathcal{A} , it follows that $\mathcal{F}[\eta_M] = \{[\Gamma]\}$, equivalently $F_{\min}(\eta_M) = \Gamma$, equivalently η_M fills S.

Since $\eta_M \subset \eta_\mu$, and since η_M fills T, it follows from Proposition 2.19 that η_μ also fills T.

4.4 Finding a natural train track representative

In this section we discuss the following result:

Theorem. [FM15, Theorem 8.24] For any $\phi \in \text{Out}(\Gamma; \mathcal{A})$ and a maximal, ϕ -invariant, proper free factor system \mathcal{F} of ϕ rel \mathcal{A} , there exists an irreducible train track representative $f: T \to T$ of ϕ with respect to \mathcal{F} defined on a natural free splitting T.

Translating the theorem. The statement above is not an exact statement of [FM15, Theorem 8.24]; it is instead a significant translation of that theorem into our language. Some remarks are therefore in order to aid the translation. In the notation of [FM15], consider a group equipped with a free factorization $G = G_1 * \cdots * G_p * F_k$; we use the notations $\Gamma = G$ and $\mathcal{F} = \{[G_i]\}_{i=1}^p$. Our group $\operatorname{Aut}(\Gamma; \mathcal{F})$ is identified with the group denoted $\operatorname{Aut}(G, \mathcal{O})$ in [FM15, Definition 3.2] (the "Out" notation is rarely used in [FM15]). Note that \mathcal{O} represents the unprojectivized outer space of Γ rel \mathcal{F} ; projectivized outer space $P\mathcal{O}$ may be identified with the open subset of the relative free splitting complex $\mathcal{FS}(\Gamma; \mathcal{F})$ represented by Grushko free splittings of Γ rel \mathcal{F} . Every free splitting in [FM15] is a natural free splitting in our language: see properties (C0)–(C3) in [FM15, Section 3], particularly (C0) which is equivalent to naturality. Our concept of a " Φ -twisted equivariant" map $f: T \to T$ is generally referred to in [FM15] as a map "representing Φ " (see [FM15, Definition 8.1] and the preceding paragraph). Given $\phi \in \operatorname{Out}(\Gamma; \mathcal{F})$, for any representative to the the statement in [FM15] that Φ is irreducible. The exact statement of Theorem 8.24 is this (using our notation for $\operatorname{Aut}(\Gamma; \mathcal{F}) = \operatorname{Aut}(G, \mathcal{O})$):

Theorem. [FM15, Theorem 8.24] Let Φ be an irreducible element of Aut(Γ ; \mathfrak{F}). Then there exists a simplicial optimal train track map representing Φ .

Here are a few more remarks on translation. Regarding equivalence of two definitions of train track maps, see the discussion in [HM22, Section 4.3.3]. Let $f: T \to T$ be the "simplicial, optimal train track map" of the conclusion. The meaning of "simplicial" in this statement is not the one we use — a map in the category of simplicial complexes — but instead is simply the statement that vertices go to vertices (see the paragraph preceding Theorem 8.24). "Optimality" is a property that we do not need. But we do need for $f: T \to T$ to be irreducible. If not then there is a proper subforest $\tau \subset T$ invariant under Γ and f, with a corresponding collapse map $T \xrightarrow{\langle \tau \rangle} T'$; by maximality of \mathcal{F} , each component of τ has trivial stabilizer, and so T' is still a Grushko free splitting of Γ rel \mathcal{F} . Under the collapse map $T \to T'$, the map f on T induces a map on T', and by tightening we obtain a train track representative $f': T' \to T'$ of ϕ . Proceeding by induction on the number of edge orbits, we obtain an irreducible train track representative of ϕ . Another proof. Consider any $\phi \in \text{Out}(\Gamma; \mathcal{A})$ and any maximal, ϕ -invariant, non-filling free factor system \mathcal{F} of ϕ rel \mathcal{A} . We may think of ϕ as an irreducible element of the relative outer automorphism group $\text{Out}(\Gamma; \mathcal{F})$. For the foundational special case of $\text{Out}(F_n)$ — where $\Gamma = F_n$ and $\mathcal{F} = \emptyset$ — an algorithmic construction of an irreducible natural train track representative can be found in [BH92, Section 1]. We give a straightforward adaptation of that construction to our present circumstances, aided by applying tools of [Lym22b].

We review concepts of topological representatives needed for this proof (see [HM22, Section 4.3.1]). Consider the class C_{ϕ}^{irr} of irreducible topological representatives $F: T \to T$ of ϕ defined on a Grushko free splitting T of Γ rel \mathcal{F} . To see that this class is nonempty, start from an arbitrary topological representative $G: U \to U$ defined on a Grushko free splitting rel \mathcal{F} . From irreducibility of ϕ it follows that for every Γ -invariant subforest of U that is either G-pretrivial or G-invariant, each component of that subforest has trivial stabilizer. So by repeatedly collapsing such forests one eventually arrives at a Grushko free splitting rel \mathcal{F} on which G induces a topological representative having no pretrivial or F-invariant subforests, and any such representative is irreducible.

Each $F \in \mathcal{C}_{\phi}^{\text{irr}}$ is Φ -twisted equivariant with respect to some $\Phi \in \operatorname{Aut}(\Gamma; \mathcal{A})$ representing ϕ . Also, F takes each vertex to a vertex and each edge to a nontrivial edge path without backtracking. There is an $n \times n$ transition matrix M for F, meaning that for some enumerated set of edgelet orbit representatives $e_1, \ldots, e_n \subset S$, each matrix entry M_{ij} counts the number of times that $F(e_j)$ crosses translates of e_i (for $1 \leq i, j \leq n$). Irreducibility of F means that for each i, j there exists $k \geq 1$ such that $M_{ij}^k \neq 0$. We let $\lambda \geq 1$ denote the Perron-Frobenius eigenvalue, and we let \vec{w} denote a Perron-Frobenius column eigenvector of M, and so $\sum_j M_{ij} w_j = \lambda w_i$.

If there exists $F \in \mathcal{C}_{\phi}^{\text{irr}}$ which is NEG — meaning that $\lambda = 1$ — then F is automatically a train track representative of ϕ . In this case F is also a PL homeomorphism, and so we can replace the given simplicial structure on S by a natural simplicial structure, completing the proof.

We may therefore assume that $\lambda > 1$ for every F — that is, every $F \in C^{\text{irr}}$ is EG. Amongst all members of C_{ϕ}^{irr} there exists one for which λ is minimal, and furthermore any member with minimal λ is a train track representative: for $\text{Out}(F_n)$ see [BH92, Theorem 1.7] and its proof; and for $\text{Out}(\Gamma; \mathcal{A})$ see [Lym22b, Theorem 3.2] and its proof.

Consider the subclass $C_{\phi}^{\min} \subset C_{\phi}^{\inf}$ of representatives $F: S \to S$ for which λ is minimal, so every member of C_{ϕ}^{\min} is a train track representative of ϕ . Let |S| denote the number of orbits of valence 2 vertices of S with trivial stabilizer, and note that if |S| = 0 then S is a natural free splitting. It therefore suffices to choose any $F: S \to S$ in the class C_{ϕ}^{\min} and to prove, using concepts of "valence 2 homotopy", that if |S| > 0 then there is another member $F': S' \to S'$ of C_{ϕ}^{\min} such that |S'| < |S|.

Using the assumption |S| > 0, choose $v \in S$ to be a vertex of valence 2 with trivial stabilizer. The two edgelets of S incident to v lie in the same natural edge of S and they lie in different edgelet orbits. We may assume those two edgelets are the chosen representatives of their orbits, denoted e_i and e_j . By permutating the notation we may assume $w_i \ge w_j$. Let u be the vertex of e_j opposite v. Since edge stabilizers of S are trivial, the vertex v is "nonproblematic" in the sense of [Lym22b, Remark 3.6] (strictly speaking, the projection of v to the quotient graph of groups S/Γ is nonproblematic). We may therefore apply [Lym22b, Lemma 3.5] to obtain a new irreducible topological representative $F_1: S_1 \to S_1$ by the operation of "valence-two homotopy of v across e_j "; this is a multistep operation, described as follows. Let $\pi: S \to S$ be the equivariant map that collapses e_j to w, stretches e_i over $e_i \cup e_j$, and is the identity outside of the orbits of e_i and e_j . Let $F': S \to S$ be obtained by equivariantly tightening $\pi \circ F$. Let S' be obtained from S by equivariantly removing v from the set of vertices and joining $e_i \cup e_j$ into a single edgelet e'_i ; no vertex of S is mapped to v by F', and so F' takes each vertex to a vertex. Let $F'': S' \to S'$ be obtained from F' by equivariantly tightening, so F'' takes each edge to an edge path, possibly trivial. Finally, let $F_1: S_1 \to S_1$ be obtained from F'' by collapsing a maximal pretrivial forest and equivariantly tightening, so $F_1: S_1 \to S_1$ is a topological representative. From the assumption that $\mu_i \ge \mu_j$, the conclusion of [Lym22b, Lemma 3.5] tells us that the Perron-Frobenius eigenvalue of F_1 satisfies $\lambda_1 \le \lambda$; by minimality of λ it follows that $\lambda_1 = \lambda$. But the number $|S_1|$ of vertex orbits of S_1 is strictly fewer vertex than the number |S| of vertex orbits of S.
