Optical conductivity of charge carriers interacting with a two-level systems reservoir

Using the functional-integral method we investigate the effective dynamics of a charged particle coupled to a set of two-level systems as a function of temperature and external electric field. The opti
al ondu
tivity and the dire
t urrent (d
) resistivity indu
ed by the reservoir are omputed. Three different regimes are found depending on the two-level system spectral function, which may lead to a non-Drude optical conductivity in a certain range of parameters. Our results contrast to the behavior found when considering the usual bath of harmonic oscillators which we are able to recover in the limit of very low temperatures.

I. INTRODUCTION

The possibility of manipulating physi
al systems at length scales where quantum effects become important has attracted much attention over the last years. This scenario has stimulated considerable effort in the study of quantum open systems, firstly because of its relevance to the phenomenon of quantum coherence and secondly be
ause it might not be entirely obvious the way in whi
h we can obtain information about the quantum dynami
s of the system of interest oupled to its environment. One of the strategies broadly used in solving this problem onsists in the repla
ement of the environment by an approximate model. This must be done in su
h a way that after tra
ing the environment oordinates out, the problem an be formulated only in terms of the variables of the system of interest. It is remarkable that most of the environments an be represented either in terms of a path of oscillators^{-, w}hen the physics is dominated by the delocalized modes, or by an spin bath , when the localized modes play the major role. In this paper we will be interested in another type of thermal bath that can be thought of as the projection of the usual oscillator modes onto their two lowest lying levels. At very low temperatures, these trun
ated two-level systems (TLSs) have the same properties as the usual harmonic oscillators, that is, the two baths exhibit the same quantum limit. However, as we will show, they strongly differ in the lassi
al regime, at high temperatures.

It is now well known that when the oscillator model with linear spectral density is used to mimic a thermal bath intera
ting with a quantum parti
le, the wave pa
ket asso
iated with the latter undergoes a damped motion, exa
tly as in the lassi
al problem.2 In this situation, and within the long time approximation, the average over the environment variables results in an equation of motion for the particle without memory effects. Therefore, it directly follows that the transport properties of the quantum particle can be simply described in terms of the damping and diffusion coefficients. As a consequence, the optical conductivity $\sigma(\omega)$ of a single particle coupled to an os
illator bath has, in the soalled ohmi ase, only an in
oherent part, whi
h has a Drude-like form. In this case the Lorentzian width is determined by a *temperature* independent damping onstant.

The phenomenologi
al approa
h of representing the environment by an oscillator bath was successfully used in the study of dissipative effects in macroscopic quantum conerence (the spin-boson model) and macroscopic quantum tunneling . Moreover, there are particular sit-uations, see [\[6](#page-12-3)] for instance, in which the oscillator model an be derived from mi
ros
opi theories just following the prescriptions of Feynman and Vernon⁻. That is also the ase of solitons, whose transport properties an be investigated using the olle
tive oordinate quantization scheme???? In those cases the effective equation of motion for the enter of mass of the soliton leads, in the long time regime, to a temperature dependent damping onstant. The form of the damping onstant is su
h that the optical conductivity of a system of non-interacting solitons has again a Drude-like form, and in the low temperature limit correctly reproduces the finite free particle Drude weight at zero frequency. This behavior is ompletely general for solitons and therefore independent of the non-linear field theory that supports these localized solutions. From $[2]$ and $[7-9]$ $[7-9]$ $[7-9]$ we can conclude that, within the long time regime, the optical properties of quasi-parti
les oupled to an os
illator bath have always the trivial Drude form. Therefore, if results at variance with the latter are obtained in $\sigma(\omega)$ measurements, they can not be attributed solely to the abovementioned parti
le-reservoir intera
tion. In those ases more complicated models are required¹⁰ or alternative thermal bath descriptions should be employed.⁴

In this paper, our main goal is to present a different kind of thermal reservoir whi
h, in addition to a dissipative dynami
s for the harge arriers, indu
es a nontrivial opti
al ondu
tivity. Our starting point will be the problem of a single parti
le sub je
t to a omplex potential which can be represented as a distribution of local twolevel systems. Using the well known Feynman-Vernon formalism¹ we are able to tra
ed out the environment modes and obtain the redu
ed density operator of the parti
les. This operator will be expressed in terms of an effective action containing all the information about the oupling of the arriers to the reservoir and provides us with an equation of motion for the particles from which the transport properties an be omputed. In this way it will be shown that the optical conductivity of this system has a temperature dependent non-Drude behavior with a very rich structure which contrasts with the oscillator bath transport properties.

This paper will be divided as follows. In Se
. II we present a model des
ribing a single parti
le intera
ting with a set of TLSs. In Sec. III an effective equation of motion des
ribing the parti
le dynami
s will be derived and in Sec. IV the optical conductivity of the system is calculated considering different characteristics of the thermal reservoir. Finally, in Sec. V, we discuss our results and present the conclusions.

II. THE MODEL

As it was already mentioned, we will be interested in the transport properties of a single particle coupled to a generi TLSs reservoir. This problem an be ompletely des
ribed by the hamiltonian

where H_0 stands for a particle placed in an external electric field, and it is given by

The distribution of TLSs playing the role of thermal reservoir in [\(1\)](#page-1-0) is denoted by H_r and may be expressed in the k−spa
e as

where $\sigma_{z\kappa}$ is the z-Pauli matrix. Finally, the interaction between the particle of interest and the thermal bath H_i

will be taken in such a way to induce transitions between the states of each TLS. A suitable choice is

$$
H_i = -x \sum_{k=1}^{N} J_k \sigma_{xk}, \qquad (4)

where J_k and σ_{x_k} are, respectively, the coupling constant and the x-Pauli matrix.

Although the problem defined by Eqs. $(1)-(4)$ $(1)-(4)$ $(1)-(4)$ was not derived from a microscopic description of a concrete physi
al system, it is still very useful be
ause there are many systems which, under certain circumstances, behave as a truncated TLS. Indeed, in the process of modeling defects in rystalline solids or amorphous materials, one has to deal with a distribution of locally quadratic-plus-quartic potentials, as it is shown in Fig. [1.](#page-1-2) In fact, if each local double-well in the distribution has fairly separated minima, and the typical energy scale $\hbar\omega_c$ (obtained by the harmoni approximation about ea
h minimum and assuming they do not differ much) is such that $\hbar\omega_c >> kT$ (see Refs. $\left[3\right]$ and $\left[11\right]$ $\left[11\right]$ $\left[11\right]$ for details) all the locally quartic potentials at positions l can be effectively described as two-level systems and

where Δ_l is a typical matrix element for the tunneling ${\rm process\ between\ the\ two\ minima\ and\ }\varepsilon_l\ {\rm is\ the\ ``detuning''}$ between the ground states in the two wells. This fa
t suggests a possible phenomenologi
al des
ription for a parti
le moving in a omplex potential as shown in Fig. 1, where the source of dissipation is the induced transition between the states of the TLSs ensemble and may have the form [\(4\)](#page-1-1). However, in the course of this procedure one should keep in mind that although the rate ε_l/kT may have any value, the TLSs representation is valid only if $\hbar\omega_c >> kT \sim (\hbar\Delta_l, \varepsilon_l)$. Therefore the high temperature limit should be understood as $\hbar\omega_c >> kT > \hbar\Omega$ where

 Ω is the cutoff frequency of the system, which can be assumed to be of the order of $\max(\hbar\Delta_l, \varepsilon_l)$.

Knowing the details of the model des
ribing the TLSs array we an go further and study the dynami
s of a parti
le oupled to this environment.

III. EFFECTIVE PARTICLE DYNAMICS

A. The Influence Functional

This section is devoted to investigating the effective dynami
s of a parti
le intera
ting with the TLS thermal reservoir. We will use the Feynman-Vernon functional integral approach, which begins with the calculation of the redu
ed density operator of the parti
le of interest, namely

where we are using the coordinate representation for the particle states, Tr denotes the trace over the bath modes and H is the Hamiltonian of the total system given by [\(1\)](#page-1-0).

The density operator of the whole system at time $t = 0$ will be assumed to be separable, $\rho(0) = \rho_p(0)\rho_r(0)$, where p and r denote the particle and the reservoir, respectively. The redu
ed density operator [\(6\)](#page-2-0) an be written as

where the superpropagator $\mathcal J$ has the form

orresponds to the a
tion of a free parti
le in the presen
e of an electric field and $\mathcal F$ denotes the influence functional, which is given by

where T indicates time-ordered product and

The central quantity in this method is the influence functional defined in Eq. [\(7\)](#page-2-1). Our next step is to derive an explicit expression for it. Although this quantity has already been evaluated through different approaches for interactions of the form [\(4\)](#page-1-1)⁻⁻, nere we will sketch its derivation for the sake of ompleteness.

In order to proceed, we will assume that the interaction strength is weak enough, su
h that we may expand Eq. (8) in powers of J_k and retain only terms up to second order. We then obtain

After tracing the reservoir degrees of freedom from Eq. [\(9\)](#page-2-3), the influence functional acquires the form,

Equation [\(10\)](#page-2-4) may be simplified by introducing a set of coordinates corresponding to the particle center of mass q and relative coordinate ξ . Therefore, $x = q + \xi/2$, $y = q - \xi/2$, and the influence functional reads

In the majority of cases considered we do not have enough information about the system which would allow us to perform the above summation in k . In order to overcome this difficulty, one usually introduces a phenomenological spectral density function, which correctly describes the bath in some well-known limit. Decause we intend to follow this strategy, we will first calculate the form of the spectral density function associated to the two-level system reservoir and will repla
e it by some phenomenologi
al guess afterwards.

The spe
tral fun
tion an be obtained from

where $F(t)$ is the force produced by the particle over the thermal bath, $\Theta(t)$ is the usual step function, and $\mathfrak F$ stands for the Fourier transform. From Eq. [\(4\)](#page-1-1) it is straightforward to demonstrate that $F(t) = \sum_{k} J_k \sigma_{xk}$. Substituting then the expression for the force into Eq. (12) and using Eq. (3) we obtain

Notice that the above expression is completely different from the oscillator spectral function. Here, all modes with energy well below $k_B T$ contribute less effectively to the spectral density than the "unoccupied" modes above the thermal energy. Therefore, any attempt to repla
e [\(13\)](#page-3-1) by a phenomenologi
al guess should preserve this property.

If we now replace Eq. (13) into Eq. (11) , we obtain the influence functional

where we have re-exponentiated the second order expansion used in [\(9\)](#page-2-3).

Next, we substitute Eq. (14) into Eq. (7) to obtain the superpropagator for the parti
le of interest, namely

After having tra
ed the environment oordinates, we can derive from the effective action [\(15\)](#page-3-4) an equation of motion for the time evolution of the particle center of mass q and for the width ξ of the wave packet associated to it,

where we have performed an integration by parts in order to explicitly show the viscous force of the TLSs reservoir a
ting on the parti
le and

The last step onsists in solving Eqs. [\(16\)](#page-3-5) and [\(17\)](#page-3-6). However, we must first specify the form of the spectral density. Because we intend to keep the problem as general as possible, we will choose a form for the spectral density which retains the functional T -dependence given by Eq. [\(13\)](#page-3-1). We then assume that

where Ω is the cutoff frequency already introduced in the discussion of the model, $\overline{\gamma}$ is a constant defining the particle coupling strength to the TLSs and s is a c-number. The reader must be warned that $\overline{\gamma}$ used in this paper is actually $4\gamma/\pi$ where γ is the usual relaxation constant of the parti
le motion.

Expression [\(19\)](#page-4-0) retains the main properties of the functional form (13) , namely the fact that the temperature determines whi
h are the statisti
ally relevant modes. Therefore, for a given value of Ω and depending on the temperature, the particle may simply have no interaction, on average, with the reservoir. Noti
e that this hoi
e is at variance with the one employed in Ref. [13] whre the author maps the system onto a bath of os
illators.

By replacing Eqs. (18) and (19) into (16) , we obtain the following equation for the velocity of the particle center of mass:

As it can be observed from Eq. (20) , after tracing the two-level system reservoir oordinates, we have obtained an equation of motion for the parti
le enter of mass in which the thermal bath has the same effect as that of a *viscous fluid*. It should be noticed that for $s = 1$ and zero temperature, Eq. [\(21\)](#page-4-2) redu
es to the os
illatorbath damping fun
tion, whi
h is memoryless in the limit $\Omega \rightarrow \infty$ or, in other words, in the long time regime. Indeed, in this ase

indi
ating that the damping is a purely instantaneous function.

However, if $s \neq 1$ we realize that even at zero temperature and with the cutoff frequency going to infinity, it is impossible to obtain a damping function without memory. In this situation the problem becomes non-Markovian and the particle dynamics can not be described in terms of damping and diffusion coefficients. In the following, we will investigate the transport properties of a system of non-interacting particles described by Eqs. [\(20\)](#page-4-1) and [\(21\)](#page-4-2) through the evaluation of its opti
al ondu
tivity.

IV. THE OPTICAL CONDUCTIVITY

The urrent asso
iated to distinguishable nonintera
ting parti
les des
ribed by the equation of motion [\(20\)](#page-4-1) reads $j = ev(t)$, where j satisfy

This equation may be solved by the well-known method of the Lapla
e transform. If we assume that initially there is no urrent in the system, Eq. [\(22\)](#page-4-3) may be written as $j(z) = \sigma(z)E(z)$, with

where $\Gamma(z)$ is the Laplace transform of $\Gamma(t-t')$. For all allowed values of s, $\Gamma(z)$ can be written as (see appendix)

where F denotes hyper-geometric functions given by $F(s,x) = {}_{2}F_{1}(1, \frac{1+s}{2}, \frac{3+s}{2}, x)$ and $\lambda_{n} = (2n-1)\pi k_{B}T/\hbar$, with $n \in \mathbb{N}$.

The optical conductivity may now be promptly obtained by substituting [\(23\)](#page-4-4) into

Although Eqs. [\(23\)](#page-4-4)-[\(24\)](#page-4-5) allow us to compute $\sigma(\omega)$ for any $s \geq 0$, it may be enlightening to consider the problem for specific values of s , for which the hyper-geometric series in (23) converge to simple functions. In this way we will be able to proceed analytically in the investigation of the opti
al ondu
tivity and obtain, if there are su
h ontributions, the temperature dependen
e of the Drude weight and the incoherent conductivity in the whole frequency range. In the following we will focus on particular cases illustrating the super-ohmic $(s > 1)$, ohmic $(s = 1)$ and sub-ohmic $(s < 1)$ situations.

1. Super-ohmic case, $s = 2$

In this specific case, the hyper-geometric functions involved in Eq. [\(23\)](#page-4-4) a
quire a simple form

Substituting then Eq. [\(25\)](#page-5-0) into [\(24\)](#page-4-5), we obtain the following form for the optical conductivity:

$$
\sigma(\omega) = \sigma^{DW}(T) \,\delta(\omega) + \sigma^{inc}(\omega, T),\tag{26}
$$

where $\sigma^{DW}(T)$ represents the Drude weight, whereas $\sigma^{inc}(\omega,T)$ stands for the incoherent contribution. Let us first analyze $\sigma^{DW}(T)$, which is given by

\sigma^{DW}(T) = \sigma_0 \left[1 + \frac{4\overline{\gamma}}{\pi} \sum_{n=1}^{\infty} \frac{\arctan\left[\frac{\hbar\Omega}{\pi k_B T (2n-1)}\right]}{(2n-1)} \right]^{-1}.
$$
\n(27)

where $\sigma_0 = \pi e^2/M$ is the Drude weight of the free particle. Although this sum can not be performed exactly for all temperatures, we may derive an analyti
al expression for it in the regime $k_BT \gg \hbar \Omega$. We then find

$$
\sigma^{DW}(T) = \frac{\sigma_0}{1 + \frac{4\overline{\gamma}\hbar\Omega}{\pi^2 k_B T} \sum_{n=1}^{\infty} \frac{1}{(2n-1)^2}} = \frac{\sigma_0}{(1 + \overline{\gamma}\frac{\hbar\Omega}{2k_B T})}, \tag{28}
$$

where the damping term provides a small correction to the particle mass. Notice that Eq. [\(28\)](#page-5-1) correctly reprodu
es the free parti
le behavior at high temperatures. This result is in agreement with the fact that as the temperature is raised the high frequen
y TLSs will play a major role in the composition of the spectral function which justifies the mass correction as due to the adiabatic approximation. In other words, the high frequency TLSs adiabati
ally dress the moving parti
le.

A numeri
al evaluation of the sum involved in Eq. [\(27\)](#page-5-2) yields the general behavior of the Drude weight as a fun
- tion of temperature (see Fig. [2\(](#page-5-3)a)). Observe that the ondu
tivity grows with temperature until it saturates at the value of a free particle in the $T \to \infty$ limit. In order to investigate the functional growth of the conductivity with temperature, we have plotted $-1/\ln\sigma^{DW}(T)$ vs T in Fig. [2\(](#page-5-3)b). The plot is linear in T , except in the low temperature region. We may therefore conclude that for high temperatures the Drude weight behaves as $\sigma^{DW} \propto \exp[-1/(\alpha + \beta T)],$ where the constants α and β can be determined from the plots and depend on the values of Ω and $\overline{\gamma}$. On the other hand, the vanishing of $\sigma^{DW}(T)$ as the temperature is lowered was already expe
ted from [\(27\)](#page-5-2), be
ause for stri
tly zero temperature the sum to be performed is positive and divergent.

The functional reduction of the conductivity as the temperature de
reases may be determined by onsidering a certain $\overline{N} = 2\overline{n} - 1$ such that $\hbar\Omega/\pi k_BT \overline{N} \gg 1$. In the limit of $T \to 0$ the value of \overline{N} will be of the order of $\hbar\Omega/k_BT$. In this situation Eq. [\(27\)](#page-5-2) may be approximately written as

$$
\sigma^{DW}(T) \sim \sigma_0 \left[2\overline{\gamma} \mathcal{S} + \frac{4\overline{\gamma}}{\pi} \sum_{n=\overline{n}}^{\infty} \frac{\arctan\left[\frac{\hbar\Omega}{\pi k_B T (2n-1)}\right]}{(2n-1)}\right]^{-1},
$$
\n(29)

where

$$
S = \sum_{n=1}^{\overline{n}} \frac{1}{2n-1} = \alpha + \frac{1}{2} \psi^{(0)}(\overline{n} + 1/2), \qquad (30)

with $\alpha = (C + \ln 4)/2$,

$$
C = \lim_{m \to \infty} \sum_{k=1}^{m} \frac{1}{k} - \ln m,
$$

and $\psi^{(0)}$ denote the polygamma function of zeroth order given by $\psi^{(0)}(x) = \partial_x \ln \Gamma(x)$. In the zero temperature limit the sum given by Eq. [\(30\)](#page-5-4) dominates the behavior of Eq. [\(29\)](#page-5-5). Using then the Stirling expansion and assuming that \bar{n} is of the order of $\hbar\Omega/k_BT$, we finally obtain that the Drude weight in the low temperature limit behaves as

$$
\sigma^{DW}(T \to 0) \sim \frac{e^2}{M\left[\frac{\overline{\gamma}\alpha}{\pi} + \ln\left(\frac{k_BT}{\hbar\Omega}\right)^{-\varepsilon\overline{\gamma}}\right]}.
$$
(31)

In the expression above ε is a numerical factor that can determined from the plot of $1/\sigma^{DW}$ vs $-1/\ln T$ for low temperatures. Inspection of Fig. $2(c)$ $2(c)$ indicates that the value of ε is approximately 1. Therefore we can conclude that the Drude weight for low temperatures behaves as

$$
\sigma^{DW}(T \to 0) \sim \frac{1}{\ln\left(\frac{\hbar\Omega}{k_BT}\right)^{\gamma}}.\tag{32}
$$

Actually the effect of finite $\overline{\gamma}$ can even wash the Drude weight out as in the naïve Drude model for electric conductivity of metals. Nevertheless, in our specific model, although σ^{DW} is reduced, it is still finite even in the presence of damping for finite T . Moreover, as the ratio $\hbar\Omega/k_BT$ is directly proportional to the number of TLSs in the lowest energy state, it is expe
ted that as the temperature is lowered this number rises, in
reasing the ability of the particle to lose energy and consequently leading to a smaller value of σ^{DW} .

Now we turn our attention to the behavior of the in coherent part of the optical conductivity, which is given by

$$
\sigma^{inc}(\omega) = \sigma_0 \frac{\overline{\gamma} \tanh\left(\frac{\hbar \omega}{2k_B T}\right) \Theta(\Omega - \omega)}{2\omega \left\{\mathcal{Q}^2(\omega, T) + \left[\frac{\pi \overline{\gamma}}{2} \tanh\left(\frac{\hbar \omega}{2k_B T}\right)\right]^2\right\}},\tag{33}
$$

with

$$
Q = 1 + \frac{4\overline{\gamma}}{\pi} \sum_{n=1}^{\infty} \frac{(2n-1)\arctan\left[\frac{\hbar\Omega}{\pi k_B T (2n-1)}\right]}{(2n-1)^2 + (\hbar\omega/\pi k_B T)^2}
$$
(34)

$$
-\frac{\overline{\gamma}}{2} \tanh\left(\frac{\hbar\omega}{2k_B T}\right) \ln\frac{|\Omega + \omega|}{|\Omega - \omega|}.
$$

The presen
e of the step fun
tion in Eq. [\(33\)](#page-6-0) ensures that $\sigma^{inc}(\omega)$ is exactly zero above the cutoff frequency. Although for frequencies of the order of Ω our approach may provide non accurate results, the zero conductivity in the $\omega > \Omega$ region agrees with the fact that all particle transitions between states with energy difference larger than $\hbar\Omega$ are forbidden. This effect is a consequence of having limited the thermal bath phase spa
e by an abrupt cutoff frequency.

In order to discuss the main features of the incoherent part of the opti
al ondu
tivity given by Eqs. [\(33\)](#page-6-0)-[\(34\)](#page-6-1) we begin by calculating the temperature dependence of the dc conductivity $\sigma_{dc} = \sigma^{inc}(\omega = 0)$, namely

The high temperature limit of this expression an be written as

which correctly goes to zero as the temperature increses in agreement with the free parti
le behavior. The interesting point omes from the divergen
e at zero temperature. This singular behavior has been observed in classical non-integrable nonlinear systems where the current orrelation de
ays to zero in the long time limit, but so slowly, that the integral over time, whi
h yields the d conductivity, diverges.¹⁴ In the present case this result an be understood by realizing that the long time behav-ior of the damping function [\(21\)](#page-4-2) involves low frequency modes, but the latter do not have enough spectral weight for the $s = 2$ case to make the current decay.

A further understanding of the problem an be a
hieved after the analysis of Fig. [3,](#page-6-2) where the frequency dependence of $\sigma^{inc}(\omega)$ is plotted for some particular cases. Notice in Fig. $3(a)$ $3(a)$ that as the temperature increases, the conductivity is reduced in the entire frequency range. This is in agreement with the fact that as one moves toward the limit in which $k_B T \gg \hbar \Omega$ the parti
le approa
hes the free behavior and eventually the incoherent conductivity vanishes, see Eqs. (33) and (34) , retrieving the free parti
le result.

Let us now inspect the behavior of $\sigma^{inc}(\omega)$ when $\omega \rightarrow$ Ω . Fig. [3\(](#page-6-2)b) shows a zoom of Fig. 3(a) for ω around Ω . Near the cutoff frequency the conductivity reaches a maximum and then ontinuously falls to zero as one approaches Ω from below. This non-monotonic behavior of the opti
al ondu
tivity as a fun
tion of the frequency can be basically attributed to memory effects of the damping function (21) . This effect is responsible for the dephasing of the different contributions of the bath reaction over the particle. As a matter of fact, if we reanalyze Eq. [\(33\)](#page-6-0), we observe that the lassi
al impedan
e $Z(\omega,T)$ of the reservoir (for $\omega < \Omega$) corresponds to

$$
Z = \sigma_0^{-1} \left[\frac{2\omega Q^2(\omega, T)}{\overline{\gamma} \tanh\left(\frac{\hbar \omega}{2k_B T}\right)} + \frac{\pi^2 \overline{\gamma} \omega}{2} \tanh\left(\frac{\hbar \omega}{2k_B T}\right) \right].
$$

Although this expression an not be learly separated into reactive and resistive contributions, one of the components of the former will be

$$
\mathcal{X}(\omega, T) \propto \frac{2\omega \mathcal{Q}^2(\omega, T)}{\overline{\gamma} \tanh\left(\frac{\hbar \omega}{2k_B T}\right)},
$$

where $\mathcal{Q}(\omega, T)$ is given by [\(34\)](#page-6-1). From the definition of $\mathcal{Q}(\omega,T)$, we observe that part of the reaction of the bath over the parti
le is nothing but a ompetition of terms with a π phase difference between them, which causes this kind of resonance-like behavior. The effect described above does not appear in the os
illator model, where the bath rea
ts as a pure resistan
e due to its memoryless character, and leads to a monotonic behavior of $\sigma^{inc}(\omega)$. It is also expe
ted that as the oupling strength of the particle-reservoir interaction increases, the conductivity will decrease. This effect is illustrated in Fig. $3(c)$ $3(c)$, where it an be seen also that for strong enough oupling the opti
al ondu
tivity be
omes a monotoni fun
tion. It remains to mention that for a fixed value of the temperature, an increase in the value of the frequency cutoff leads to a displa
ement of the ondu
tivity edge to higher frequencies and to a decrease of σ^{inc} in the whole frequency range. This effect is illustrated in Fig. $3(d)$ $3(d)$ and it is a onsequen
e of the higher number of states to s
atter the particle, as the value of the cutoff frequency is increased at a given temperature.

All the previous analysis developed for the $s = 2$ specific case illustrates to some extent the transport properties of the system in the super-ohmic regime $(s > 1)$. However, it is worth mentioning that there are significant differences in the low frequency region of the optical conductivity as one moves from $1 < s < 2$ to $s > 2$ sit-uation - see Fig. [4](#page-7-0) for instance. The divergence in the dc conductivity is suppressed for $s > 2$ while it persists for $s < 2$. This is again a consequence of the different spectral weights for the low frequency modes as the value of s is hanged.

To conclude this part of the analysis we summarize our main findings. In the specific case of $s = 2$ the system behaves as a perfect conductor at $T=0$ because of the infinite σ_{dc} conductivity. However, this fact is not reflected in the value of the Drude weight, which goes to zero as T decreases. This contradiction in the classification into metallic or insulator states according to the

value of the Drude weight is only apparent. This is so be
ause the urrent arriers in our approa
h are not in an eigenstate of the system invalidating the characterization of ondu
tors and insulators in terms of the behavior of σ^{DW} . Another point to be mentioned is the fact that for $s \neq 2$ the dc conductivity, at $T = 0$, strongly depends on the s value, see Fig. [4.](#page-7-0) Finally, above the cutoff Ω , the opti
al ondu
tivity is always zero at any temperature, independent of the s value.

Ohmic case, $s = 1$

This ase is of parti
ular importan
e be
ause it allows us to explicitly show the differences with the oscillator model discussed in Refs. $[2]$ and $[5]$ $[5]$. In this specific situation it is useful to notice that

By substituting [\(35\)](#page-7-1) into [\(24\)](#page-4-5), we obtain the opti al ondu
tivity as a sum of a oherent part given by $\sigma^{DW}(T) \delta(\omega)$, where

\frac{\sigma_0}{\sigma^{DW}} = 1 + \frac{\hbar \overline{\gamma}}{k_B T} \left(\sum_{n=1}^{\infty} \frac{\ln \left\{ 1 + \left[\frac{\hbar \Omega}{(2n-1)\pi k_B T} \right]^2 \right\}}{(2n-1)^2} + \frac{1}{2} \right),\tag{36}
$$

and an incoherent contribution of the form

$$
\sigma^{inc}(\omega) = \frac{(\overline{\gamma}\pi/2) \tanh\left(\frac{\hbar\omega}{2k_BT}\right)\sigma_0\Theta(\Omega-\omega)}{\left[\overline{\gamma}\pi \tanh\left(\frac{\hbar\omega}{2k_BT}\right)/2\right]^2 + \mathcal{R}^2(\omega,T)},\qquad(37)
$$

where

$$
\mathcal{R} = \omega + \frac{\overline{\gamma}}{2} \tanh\left(\frac{\hbar\omega}{2k_BT}\right) \ln\left(\frac{\Omega^2 - \omega^2}{\omega^2}\right) \qquad (38)

Once again the Drude weight can not be obtained exactly for all temperatures, except for $k_B T \gg \hbar \Omega$. In this limit we find

$$
\sigma^{DW}(T) = \sigma_0 \left[1 + \frac{\pi^2 \overline{\gamma}}{96\Omega} \left(\frac{\hbar \Omega}{k_B T} \right)^3 \right]^{-1}, \quad (39)
$$

which correctly reproduces the expected free particle conductivity in the infinite temperature regime, where the incoherent contribution goes to zero [see Eqs. (37) and (38) . If one compares Eqs. (28) and (39) , one realizes that for the same temperature the Drude weight in the $s = 2$ case is lower than in the $s = 1$. This is nothing but the effect of the stronger coupling between the particle and the reservoir modes as value of s -characterizing the thermal bath- is increased.

The low temperature properties of the Drude weight can be derived from (36) by considering a value of $n = \overline{n}$ such that $\hbar\Omega/k_BT \gg \overline{n}$. In this case the sum involved in (36) can be written approximately as

$$
S = \ln\left(\frac{\hbar\Omega}{k_BT}\right) \sum_{n=1}^{\overline{n}} \frac{1}{(2n-1)^2} - \sum_{n=1}^{\overline{n}} \frac{\ln\pi(2n-1)}{(2n-1)^2} + \sum_{n=\overline{n}}^{\infty} \frac{\ln\left\{1 + \left[\frac{\hbar\Omega}{(2n-1)\pi k_BT}\right]^2\right\}}{(2n-1)^2}.
$$
 (40)

Notice that for $T \to 0$ the value of \overline{n} goes to infinity and therefore the first term in the rhs of (40) dominates the sum. Substituting this result into (36) we obtain that for low temperatures the Drude weight goes to zero as

$$
\sigma^{DW}(T \to 0) \propto \frac{k_B T}{\hbar \overline{\gamma} \ln \left[\frac{\hbar \Omega}{k_B T}\right]}.\tag{41}
$$

This expression correctly reproduces the well known result for the oscillator model,⁵ namely there is no coherent contribution to the conductivity when Ω goes to infinity. This result could have been foreseen from the analysis of the particle dynamics [see Eq. (21) for $s = 1$ and $T \rightarrow 0$].
It should be stressed that for $s = 1$ σ^{DW} goes to zero faster than for $s = 2$ [see Eq. (32)], as a consequence of the stronger interaction of the particle with the low energy modes.

After having examined the temperature dependence of the Drude weight for ohmic dissipation in the analytically accessible limits, we proceed to a numerical evaluation of Eq. (36) . Fig. 5(a) shows the behavior of the Drude weight as a function of temperature for different coupling strength values. Observe that for any given temperature σ^{DW} decreases as the interaction strength becomes stronger. Indeed, for stronger interactions the momentum transferred to the reservoir is larger and consequently the conductivity is reduced. This also implies that the free particle behavior will be reached at higher temperatures as $\overline{\gamma}$ increases.

Our next step is the analysis of the incoherent part of the optical conductivity. The first point to be mentioned is the infinite dc conductivity of the system at any finite temperature. This result is obtained taking the limit of zero frequency in the expressions (37) and (38) and can be explained by the fact that the dc conductivity is determined by the low frequency modes in the damping function (21) . We have plotted in Fig. $5(b)$ σ^{inc} vs ω for different temperatures with a finite cutoff frequency $\Omega = 1$. The forbidden particle transitions involving energy exchange above $\hbar\Omega$ leads to zero conductivity for $\omega > \Omega$, as already obtained in the $s = 2$ case. One may also notice that as the temperature increases the conductivity grows for small values of ω . This can be understood by recalling that as the temperature rises, the particle-reservoir interaction - which can actually change the particle momentum - is less effective for the low energy modes and consequently the conductivity also rises for su
h frequen
ies. It should be also mentioned that as the temperature is lowered, $\sigma^{inc}(\omega)$ a
quires a Lorentzian form. This behavior be
omes evident in Fig. $5(c)$ $5(c)$, in which we considered $\Omega = 100$. At lower temperatures one approaches the oscillator model. Indeed, taking the limits $\Omega \to \infty$ and $T \to 0$, we obtain

$$
\sigma^{inc}(\omega) = \frac{\pi \overline{\gamma}/2}{\omega^2 + (\pi \overline{\gamma}/2)^2} \,\sigma_0
$$

which is the well known result for the oscillator model. Finally, Fig. $5(d)$ $5(d)$ shows the effect of varying the coupling strength. The main feature to be observed is the reduction of the conductivity as $\overline{\gamma}$ increases, consistent with the fact that it is then easier for the particle to transfer momentum to the reservoir.

3. Sub-ohmic case, $s = 0$

Another interesting result, which differs considerably from the cases already discussed, arises when $s = 0$. In this ase, the hyper-geometri fun
tion reads

$$

and the Laplace transform of the damping function given by Eq. [\(23\)](#page-4-4) a
quires the form

$$
\Gamma(z) = \frac{4k_B T z}{\hbar} \sum_{n=1}^{\infty} \frac{1}{\lambda_n^2 - z^2} \left[\frac{\arctan\left(\frac{\Omega}{z}\right)}{z} - \frac{\arctan\left(\frac{\Omega}{\lambda_n}\right)}{\lambda_n} \right],\tag{42}
$$

where we have used that $\lambda_n = (2n-1)k_BT\pi/\hbar$ with n integer.

Substituting now Eq. (42) into (24) , we obtain an expression for the optical conductivity which has zero Drude weight at all temperatures and an in
oherent part of the form

$$
\sigma^{inc}(\omega) = \sigma_0 \frac{2\overline{\gamma}\omega \tanh\left(\frac{\hbar\omega}{2k_BT}\right) \Theta(\Omega - \omega)}{\mathcal{G}^2(\omega, T) + \left[\pi\overline{\gamma} \tanh\left(\hbar\omega/2k_BT\right)\right]^2}, \quad (43)
$$

with

$$
\mathcal{G} = 2\omega^2 - \frac{8\hbar^2 \overline{\gamma} \omega^2}{\pi^3 k^2 T^2} \sum_{n=1}^{\infty} \frac{\arctan\left(\hbar \Omega / N \pi k_B T\right)}{N \left[N^2 + \left(\hbar \omega / \pi k_B T\right)^2\right]} + \overline{\gamma} \tanh\left(\frac{\hbar \omega}{2k_B T}\right) \ln \frac{|\Omega - \omega|}{|\Omega + \omega|}. \tag{44}
$$

The dc conductivity, obtained by taking the $\omega \to 0$ limit in Eqs. [\(43\)](#page-9-1)-[\(44\)](#page-9-2), may be written as σ_{dc}/σ_0 = $4k_BT/\pi^2\hbar\overline{\gamma}$. From this result we conclude that the system behaves as an insulator with zero de conductivity at $T=0.$

Inspe
tion of Eq. [\(43\)](#page-9-1) yields that the in
oherent part of the conductivity is finite only below the cutoff frequency, just as in the cases discussed previously. Another important feature is the way in which one may recover the free parti
le behavior. In order to analyze this limit it should be noti
ed that at high temperatures Eqs. [\(43\)](#page-9-1) and [\(44\)](#page-9-2) may be written as

$$
\sigma^{inc}(\omega) = \frac{e^2}{M} \frac{\zeta}{\omega^2 + \zeta^2},\tag{45}
$$

where $\zeta = \pi \hbar \overline{\gamma}/4k_BT$. In the limit $\zeta \to 0$, which corresponds to infinite temperature or zero coupling strength, Eq. [\(45\)](#page-9-3) goes to $(\pi e^2/M)\delta(\omega)$, correctly reproducing the opti
al ondu
tivity of a free parti
le.

The general behavior of $\sigma^{inc}(\omega)$ is displayed in Fig. [6](#page-9-4) for different values of temperature, coupling strength and cutoff frequency. Fig. $6(a)$ $6(a)$ shows that as the temperature increases, one approaches the frequency dependence given by Eq. [\(45\)](#page-9-3), which has a maximum at $\omega = 0$. In this regime, the lassi
al impedan
e of the reservoir is purely resistive, analogous to the os
illator-bath model. However, as the temperature decreases, the value of $Z(\omega)$ is determined by a ompetition between terms ompletely out of phase, see Eq. [\(44\)](#page-9-2), rea
hing the maximum value for $\omega \neq 0$. For $T \rightarrow 0$, the frequency at which the ondu
tivity exhibits a maximum be
omes loser to the cutoff frequency, characterizing an extreme non-Drude behavior. As one approaches Ω from below, no matter

the value of the temperature, the conductivity smoothly falls to zero. This effect, which is related to the lack of available states in the reservoir to s
atter the parti cle, is shown in Fig. $6(b)$ $6(b)$. It is also worth mentioning the small variations of the maximum conductivity as the cutoff frequency is changed, as illustrated in Fig. $6(c)$ $6(c)$. Finally, Fig. $6(d)$ $6(d)$ shows the effect of varying the value of the coupling strength $\overline{\gamma}$ for a given temperature and cutoff frequency. An increase in the interaction strength leads to a reduction of the conductivity. This is an expected result because for larger values of $\overline{\gamma}$, the particle can transfer momentum to the reservoir in an effective way, and as a onsequen
e, the ondu
tivity is redu
ed.

At this point we can conclude the $s = 0$ analysis pointing out that in this situation the conductivity is always incoherent and non zero just below the cut off frequency with a dc value that vanishes as T goes to zero. In order to verify if those features are ommon to the entire subohmic regime, we have numerically evaluated the com-bined Eqs. [\(42\)](#page-9-0) and [\(24\)](#page-4-5) for different values of $s < 1$, see Fig. $7(a)$ $7(a)$. As it can be observed, the general behavior of the conductivity resembles the $s = 0$ case (see Fig. 6), ex
ept in the low frequen
y region. This fundamental difference is illustrated in Fig. [7\(](#page-10-0)b) showing that σ^{inc} is singular at $\omega = 0$, although our numerical calculation indicates that the Drude weight remains zero at any finite temperature and value of s. In order to investigate in more detail the general behavior of σ^{inc} in the low frequency region, it is useful to notice that near $\omega = 0$ the opti
al ondu
tivity does not depend on the value of the cut off frequency, see Fig. $7(c)$ $7(c)$. Therefore, we may simply take the limit $\Omega \to \infty$ in the Laplace transform of the damping fun
tion given by expression [\(23\)](#page-4-4) and obtain an expression for $\Gamma(z)$ for any $0 < s < 1$, namely

$$
\Gamma(z) = \frac{2\pi k_B T z}{\hbar \cos(\pi s/2)} \sum_{n=1}^{\infty} \frac{z^{s-1} - \lambda_n^{s-1}}{\lambda_n^2 - z^2}.
$$
 (46)

Substituting the expression above in [\(24\)](#page-4-5) we obtain the optical conductivity, which has a zero Drude weight, besides an in
oherent ontribution given by

$$
\frac{\sigma^{inc}(\omega)}{\sigma_0} = \frac{2\overline{\gamma}\omega^{s-3}\tanh(\frac{\hbar\omega}{2k_BT})}{4\mathcal{K}^2(\omega,s) + \left(\pi\overline{\gamma}\omega^{s-1}\tanh(\frac{\hbar\omega}{2k_BT})\right)^2},\quad(47)
$$

where

$$
\mathcal{K} = 1 + \frac{\pi \overline{\gamma}}{2} \tan\left(\frac{s\pi}{2}\right) \omega^{s-2} \tanh\left(\frac{\hbar \omega}{2k_B T}\right)
$$

$$
- \frac{2\overline{\gamma} (\pi k_B T)^2}{\hbar^2 \cos\left(\frac{s\pi}{2}\right)} \sum_{n=1}^{\infty} \frac{(2n-1)^{s-1}}{(2n-1)^2 + \left(\frac{\hbar \omega}{2k_B T}\right)^2} . \tag{48}
$$

This result is in omplete agreement with the previous numerical analysis for finite cutoff frequency and promptly allows us to derive the way in whi
h the onductivity diverges as one approaches $\omega = 0$,

$$
\frac{\sigma^{inc}(\omega \sim 0)}{\sigma_0} = \frac{4k_BT \cos^2(\pi s/2)}{\pi^2 \hbar \overline{\gamma}} \omega^{-s}.
$$

It is worth mentioning that this expression is also valid for the $s = 0$ case (see Eq. [\(42\)](#page-9-0), for instance), correctly reproducing the finite $\sigma_{dc}(T)$ value already found.

With the analysis of the $\Omega \to \infty$ limit we conclude that the finite dc conductivity obtained for the $s = 0$ case is an exception within the sub-ohmic regime, in which the de conductivity is, in general, divergent. This discussion summarizes our main findings in the study of the optical conductivity for cases in which $0 \leq s < 1$.

V. CONCLUSIONS

We have studied the transport properties of nonintera
ting parti
les oupled to a set of two-level systems described by a temperature-dependent spectral function. Our approa
h was based on the Feynman-Vernon fun
tional-integral formalism whi
h allows us to tra
e out the two-level system coordinates and obtain an effective equation of motion for the parti
le in terms of the phenomenological TLSs spectral function.

The evaluation of the transport properties were performed considering different values of the power s of the generic spectral function, which is proportional to ω^s . Two different regimes were found; the super-ohmic $(s > 1)$ and ohmic $(s = 1)$ in which the optical conductivity has both, oherent and in
oherent ontributions and the sub-ohmic $(s < 1)$ where the conductivity is strictly

incoherent. In the first case the Drude weight goes to zero as the temperature decreases in a logarithmic fashion and the in
oherent part shows a strong non-Drude behavior with a divergent dc conductivity for $T = 0$, except for the ohmic case in which the zero temperature de conductivity is finite. In the entire sub-ohmic regime, the Drude weight is always zero at all temperatures. In contrast, the dc conductivity is only finite in the $s = 0$ specific case, going linearly to zero as the temperature decreases, whereas in general it is divergent at all temperatures. It should be mentioned that in this regime, the general behavior of $\sigma(\omega)$ is strongly non-Drude, with the highest conductivity arising at finite values of ω . All these properties strongly differ from the simple behavior indu
ed by an os
illator thermal bath on a system of non-intera
ting parti
les. The latter exhibits no temperature dependence and zero Drude weight with a finite

Appendix

In order to calculate the Laplace transform of $\Gamma(t)$ we will use the expansion 15

$$
\tanh\left(\frac{\pi x}{2}\right) = \frac{4x}{\pi} \sum_{n=1}^{\infty} \frac{1}{(2n-1)^2 + x^2}.
$$

which allows us to rewrite $\Gamma(z)$ as

$$
\Gamma(z) = \frac{4k_B T z}{\hbar} \sum_{n=0}^{\infty} \mathbb{I}(n, \Omega),\tag{49}
$$

de conductivity. All this results are summarized in the table above. Con
erning the limitation of the approa
h employed here, it is important to stress that it is accurate for long times (or low frequencies) compared with the response time of the system, which is basically Ω^{-1} . Therefore in all cases where the cutoff frequency was assumed to be finite, the values of the optical conductivity near $\omega = \Omega$ should be interpreted carefully.

Finally, it is worth pointing out that the model analyzed here ould be relevant for the study of the dynami
s of a parti
le in the presen
e of a distribution of locally quartic plus quadratic potentials. We expect that this simple model may ontribute to the understanding of the transport properties of low dimensional systems at low temperatures, where the physi
s is often dominated by defe
ts and impurities.

where

$$
\mathbb{I}(n,\Omega) = \int_0^{\Omega} \frac{\omega'^s d\omega'}{(\omega'^2 + z^2)(\omega'^2 + \lambda_n^2)},
$$

with $\lambda_n = (2n-1)\pi k_B T/\hbar$ and $n \in \mathbb{N}$. This integral can be split into two terms,

$$
\mathbb{I} = \frac{1}{z^2 - \lambda_n^2} \left[z^2 \int_0^{\Omega} \frac{\omega'^{s-2} d\omega'}{(\omega'^2 + z^2)} - \lambda_n^2 \int_0^{\Omega} \frac{\omega'^{s-2} d\omega'}{(\omega'^2 + \lambda_n^2)} \right].
$$

The new integrals are easily performed, yielding

$$
\int_0^{\Omega} \frac{\omega'^{s-2} d\omega'}{(\omega'^2 + \nu^2)} = \frac{\Omega^{s-1}}{\nu^2} \sum_{m=0}^{\infty} \frac{(-1)^m}{2m + s - 1} \left(\frac{\Omega}{\nu}\right)^{2m}.
$$

We now rewrite the expression for $\mathbb{I}(n,\Omega)$ as

$$
\mathbb{I}(n,\Omega) = \frac{\Omega^{s+1}}{(\lambda_n^2 - z^2)} \left[\frac{1}{z^2} \sum_{m=1}^{\infty} \frac{(-1)^{m-1}}{2m+s-1} \left(\frac{\Omega}{z} \right)^{2m-2} - \frac{1}{\lambda_n^2} \sum_{m=1}^{\infty} \frac{(-1)^{m-1}}{2m+s-1} \left(\frac{\Omega}{\lambda_n} \right)^{2m-2} \right].
$$
 (50)

Substituting this equation into [\(49\)](#page-11-0) and expressing the sums involved in [\(50\)](#page-11-1) in terms of the hyper-geometric functions we obtain

$$
\Gamma(z) = \frac{4k_B T z}{\hbar(s+1)} \sum_{n=1}^{\infty} \frac{\Omega^{s+1}}{\lambda_n^2 - z^2} \left[\frac{{}_2F_1(1, \frac{1+s}{2}, \frac{3+s}{2}, -\frac{\Omega^2}{z^2})}{z^2} - \frac{{}_2F_1(1, \frac{1+s}{2}, \frac{3+s}{2}, -\frac{\Omega^2}{\lambda_n^2})}{\lambda_n^2} \right].
$$
