N on-Linear Relativity in Position Space

We propose two methods for obtaining the dual of non-linear relativity as previously form ulated in momentum space. In the rst we allow for the (dual) position space to acquire a non-linear representation of the Lorentz group independently of the chosen representation in momentum space. This requires a non-linear de nition for the invariant contraction between momentum and position spaces. The second approach, instead, respects the linearity of the invariant contraction. This fully xes the dual of momentum space and dictates a set of energy-dependent space-time Lorentz transformations. We discuss a variety of physical implications that would distinguish these two strategies. We also show how they point to two rather distinct form ulations of theories of gravity with an invariant energy and/or length scale.

I. IN TRODUCTION

A number of problems and paradoxes in cosmology (e.g. [1]) and in quantum gravity (e.g. [2]) suggest that it may be desirable to relax the postulate of the constancy of the speed of light. The question then arises as to what the fate of the other basic idea behind special relativity { the relativity of inertialmotion { is. Perhaps a preferred frame is to be introduced in these theories. But, it is also possible that the principle of relativity is honoured even if the speed of light is no longer a constant (see [3] for a discussion of all options).

A n example of the latter view point is the work of [4{6], who have derived a group of transform ations in position space (sometimes called the Fock-Lorentz transform ations) which incorporate the principle of relativity into a theory that does not assume a constant c. Later it was shown in [2] that such a construction is a non-linear representation of the Lorentz group, and a similar set up was found in momentum space. Given that deformed dispersion relations (i.e. departures from $E^2 \quad p^2 = m^2$) provide for observational input into these theories, a momentum space formulation seems preferable. It was shown in [7] that it is possible to set up non-linear realizations of the Lorentz group in plementing a general deformed dispersion relation. Thus for any energy dependence of c it is possible to fully preserve the Lorentz algebra.

However, a major drawback of the momentum space approach is that recovering a position space description is highly non-trivial. With loss of linearity, duals no longer min ic one another. That is, vectors no longer transform according to the inverse linear transform ation of ∞ -vectors.

This is not merely a form al annoyance, as the physical interpretation of many results obtained in momentum space can only be fully assessed when the relation to position space is clari ed. For instance, as recently discussed [8{10}, one may have trouble de ning physical velocity in these theories. The primary de nition of velocity should be the \space-time" velocity:

which is the relevant quantity in gam m a-ray tim ing experim ents [11]. It has been argued that the H am iltonian expression for velocity,

should be preserved, as this is the group velocity in normal circum stances. However, this has never been generally proved (with [8] even claiming that this leads to contradictions; see also [10]). Clearly this matter can only be settled when one rediscovers position space from the usualmomentum space formulation, and the answer will depend on the particular construction of position space employed.

In this paper we propose two possible approaches to form ulating a position space for non-linear relativity. A lthough they m ay be mutually exclusive and lead to different physicale ects, they are viable realizations within the current experimental bounds.

In the stapproach we propose a particular transformation map, V, which acts directly on space-time coordinates, generating a non-linear representation of the Lorentz G roup in position space. Physical implications come not only from the analysis of this non-linear representation, but also from comparing and combining it with an analogous representation in momentum space derived previously [2]. The crucial idea in this approach is that position and momentum spaces are essentially independent and may realize whichever non-linear representation of the Lorentz group one chooses to impose. To accom m odate this freedom, whilst preserving invariance, the contraction between position and momenta coordinates m ust assume a non-linear form.

The second approach imposes a strong physical requirem ent capable of fully xing position space (X) from m om entum space (P), namely that eld theories should have plane wave solutions with m om enta satisfying a given set of deform ed dispersion relations (such as the ones proposed in [2]). This is equivalent to requiring that the contraction between m om enta and positions rem ains linear. It is found that this requirem ent leads to Lorentz transform ations in position space that are energy and m om entum dependent. That is, the transform ations cannot be realized purely in space-time, but rather in 8-dim ensional phase space (X P).

The simplicity of the rst approach is attractive and less of a mental hurdle, since it keeps the dimensionality of our physical space to four and maintains that either position or momentum coordinates can be used to describe it. However, the 8-dimensional phase space realization seems more elegant, as it is dressed with the familiar linear scalar product, and in all circum stances reduces, at low energies and large distances (as compared to the P lanck scale), to the comfort of Einstein's Special Theory of Relativity. It is only near the tum ultuous P lanck scale that a 'mixing' of coordinates, due to the energy dependent space-time Lorentz transform ations, occurs. This should hardly be suprising since at these scales our physical theories have proved inadequate.

II.CONSTRUCTING NON-LINEAR SPECIAL RELATIVITY IN POSITION SPACE

It was shown in [7] how to introduce a general nonlinear representation of the action of the Lorentz group in m om entum space, corresponding to given deform ed dispersion relations. A form ally identical procedure can be applied in position space. The non-linearity that arises in doing so destroys translational invariance. Thus, all considerations in this section are to be seen as statem ents m ade in reference to small displacements about any point, in the same sense that free falling fram es in general relativity correspond to local neighbourhoods. The position space in this section is thus comprised of a set of coordinates dx^a rather than global coordinates x^a .

The fact that in our construction lengths or durations smaller that l_{P} or t_{P} (the P lanck length and time) will be removed (thus leading to a quantized space and time) makes a further qualication necessary. The volume im – mediately around the origin may not exist, so that conventional concepts of dimensional events in the set of the second ordinates are to be seen as distances referring to a generic point of origin. In order to make this clear the coordinates x^{a} will at times be written as x^{a} (instead of dx^a) as they refer to small but not in nitesimal dimensions with respect to the origin.

In the ensuing discussion we shall set c'' (the low – energy/ long-distance lim it of the speed of light) equal to one and the metric signature (;+;+;+) is used.

A. The Non-linear Lorentz Transform ations

In analogy with [7] we may adapt non-linear realizations of the Lorentz group to position space by m eans of a transformation V such that the new generators of the Lorentz group with respect to space-time coordinates are

are the standard Lorentz generators. Exponentiation of these generators reveals a non-linear realization of the group.

An application of this procedure is demonstrated in the transformations proposed by Fock, Manida, and Stepanov [4{6]. They may be obtained from

leading to a non-linear representation of the Lorentz group given by

G iven that the invariant length R is large instead of sm all these transform ations don't seem to play a role in quantum gravity. We now discuss conditions upon V leading to m ore interesting transform ations.

r

W hereas the pure momentum space formulation of Non-Linear Special Relativity treats, in addition to the speed of light, the P lanck energy, E p, as an invariant, we now require that the P lanck time, to, be an invariant instead. The only invariant times in linear relativity occur at zero and in nity, which im plies for the non-linear case that V (t_P) = 0 and V (t_P) = 1 should hold. However, we want the range of the transform ed tim e coordinates, V (t), to cover the dom ain of the boost transform ations for all values of the boost parameter v (with v < 1, in accordance with the existence of the speed of light as the maximal velocity). That is, the range of V (t) should be [0;1]. In addition we need V 1 in the t t lim it such that the ordinary Lorentz transform ations are recovered for large t. C om bining these conditions in plies that $V(t_P) = 0$ is the correct condition. Note that in momentum space, on the other hand, the appropriate condition was $U(E_P) = 1$.

The simplest theory we found with these properties is generated by the transform ation

which can be written as the exponential operator

where $D = x^a \mathcal{Q}_a$ is a dilatation. The boost generators then take the form

which, in turn, induce a non-linear representation of a Lorentz boost in the x^i -direction given by

Note that the deformation of the Lorentz boosts has caused the loss of CPT -symmetry. If, however, we wish to enforce time reversal symmetry (t ! t), we may replace $t_p = t$ by $t_p = j$; without a coting the arguments posited in this paper. In either case we see that durations smaller than t_p have been removed from the theory.

R ecalling that these coordinates are to be seen as sm all but nite di erences referred to the origin (so that t is really a t), one may now set $x^i = x^i = 1$ (some xed distance from the origin) in (12), to nd the time dilation form ula:

It follows directly that the Planck time is an invariant duration (for all l). Time durations smaller than t_P are non-physical, hence the concept of exact simultaneity has becom e m eaningless. Concom itantly, lengths (which are spatial separations evaluated at the same time) depend on how we de ne simultaneity. Thus, instead of deriving the Lorentz contraction formula with respect to exact simultaneity, we let trepresent a xed course-grained duration T, to which we refer length m easures. The resulting Lorentz contraction form ula, obtained from (12) and (13) with this prescription, does not have a simple analytic form, but is straightforward to implement num erically. Naturally T lbut T t, so that lengths 1 smaller than $\frac{1}{2}$ also become unphysical in this theory.

Finally note that the nite space-time invariant is now

so that P lanck durations becom e null.

B.The contraction between Position and M om entum

In constructing this space-time realization we have not made any connection, beyond analogy, between the V-transform ation acting in space-time and the Utransform ation acting on energy and momentum [2]. Indeed, in this approach, we assume that U and V are independent non-linear transform ations. Naturally this requires that the contraction between in nitesimal displacements (position) and momentum be non-linear, for it to remain invariant. The contraction should be de ned as

for a non-linear action in m om entum space generated by

where $L_{ab} = p_a \frac{\theta}{\theta_p^b}$ $p_b \frac{\theta}{\theta_p^a}$ are the standard Lorentz generators. The invariance of the contraction (16) can then be derived from (3) and (17).

W e illustrate this point with a particular choice of U, previously proposed in [2]:

where l_p is the P lanck length, the inverse of the P lanck energy E_p . W e will use l_p and E_p^{-1} interchangeably throughout the paper. Note that U can be written as the exponential operator $U = e^{l_p p_0 D}$ for the dilatation $D = p^a e_a$. With this choice of U and the proposed V the invariant contraction is:

C.Som e physical im plications

W e start by deriving the counterpart of the usual relation

C lose to the origin (which is a general assumption) we have

which is equivalent to replacing c in the usual form ulae of linear special relativity by

For $t = t_p$ we have an in nite speed of light, consistent with the Galilean invariance of time.

However, this is a form al speed of light (i.e. the c'' to be put in the usual dynam ical equations in order to reproduce the new ones). The space-time speed of light should be obtained by setting d² = 0 in (22). This only depends on the V transform ation and therefore can never depend on the energy. In particular for the choices (9) or (5) the speed of light is always a constant. In general the speed of light can only depend on the length or time scale, but not on the energy orm on entum. C onsequently in this approach the H am iltonian relation (2) can never be true except in the trivial case of constant c.

Note that the results in this subsection con m and generalize previous work. By setting V to (5) one obtains the form ulae in [5]. By setting V = 1 and U to (18) we get $\mathbf{v} = \mathbf{v}$, so that

III. CONSTRUCTING NON-LINEAR POSITION SPACE UN IQUELY FROM MOMENTUM SPACE

As an alternative to the above treatment, we can use the momentum space formulation to uniquely x the transformation laws in position space by imposing appropriately strong physical requirements.

O ne such physical criterium is that there be plane wave solutions to eld theories based upon non-linear relativity. That is, solutions of the form

where the energy and momentum p_a satisfy deformed dispersion relations. This is equivalent to requiring that the eld theory be set up by stating that the dynamical eld equations may be obtained by the replacement

applied to the dispersion relations. For example, if the momentum space formulation is based upon the invariant:

A nother example is the U chosen in [2]. In this case the K lein-G ordon equation is

Thus, this eld theory realizes the deform ed dispersion relations proposed for relativistic particles.

A . Energy dependent Lorentz transform ations for space-tim e

This criterium is su cient to x the transformation laws of space-time from those of momentum space because for this construction to be invariant the contraction between momenta p_a and displacements around the origin dx^a must remain linear, such that $p_a dx^a$ remains a scalar. Indeed, if there are plane wave solutions for scalar elds then the linear contraction must be an invariant.

The fact that the contraction remains linear fully xes the form of the space-time Lorentz transform ations. But now the space-time Lorentz transform ations are energy dependent. Let us consider the general dispersion relation [7]:

Once we have the linearm ap U acting in position space (as in (40)), we know that the deform ed Lorentz transform ations acting upon dx can be obtained from linear transform ations acting upon U (dx). Thus we nd:

where E $^{\rm 0}$ is the Lorentz boosted energy. Hence the spacetime Lorentz transform ations now depend upon the energy, and spacetime has become intrinsically mixed with energy-momentum.

These transform ations have the invariant:

Notice that in the low energy lim it (E \downarrow 1) we have g and g .

B.Som e physical im plications

We now consider some physical implications that unambiguously distinguish this approach from the one in the previous Section. Eqn. (21) (with V = 1) still leads to (23) and (24) but now the \velocity" to be used is

This is energy-dependent, in contrast with the result of the previous section. However when f = g, we have $v^i = v^i$, so that once again expressions (29) and (30) are correct for the U proposed in [2].

W e next note that for light rays we have in general an energy-dependent speed (in contrast with the previous section). We can set $ds^2 = 0$ in Eq. (46) to do nd that the coordinate speed of light is

Thus, in this form alism we have an energy-dependent speed of light, but its speed is given by E =p, not dE =dp. Finally from (42) one may easily read o a form ula for the tim e dilation:

These are quite distinct from the form use derived in the previous section. Obviously no length or time period is invariant in this form ulation.

C.An exam ple

As an application of this formalism we now consider the form of U chosen in [2]. In this case it was found that energy and momentum boosts in the x-direction assume the form

which approach in nity faster than regular Lorentz boosts by a factor of as $v \, ! \, c$. Note also the presence of a transverse e ect, absent in the usual theory, and that we don't see the emergence of an invariant time scale in this form alism, even though the energy E_P is indeed an invariant. This is to be contrasted with the approach in the previous section.

The form ula for time dilation in this example is:

IV.W EIGHING THE OPTIONS

We presented two distinct ways to de neposition space in non-linear special relativity. They contradict each other, and are by no means exhaustive. The rst construction allows for any non-linear representation of the Lorentz group to be introduced independently in position and momentum space. A non-linear contraction then carries the burden of enforcing invariance. In the second construction, on the contrary, we let the non-linear realization of the Lorentz group in momentum space fully

x space-time by requiring that the contraction remain linear. The result is an energy-dependent space-time.

M ore general constructions can also be used. For instance we could set up non-linear transform ations using a position and m om entum dependent generating function U (x;p) acting on the full eight-dim ensional phase space. W e feel that it is up to experim ent to decide which, if any, of these constructions has been chosen by nature. To this end, we have derived distinguishing physical im plications for our constructions, namely the e ect upon tim e dilation and speed of light (de ned as a space-tim e quantity). In a future paper [15] we shall explore further physical im plications of these opposite approaches, nam ely the law of addition of velocities and the issue of the existence of a m axim al acceleration. In closing we remark that the second approach proposed in this paper simpli es enormously the de nition of a theory of gravity based on non-linear special relativity. None of the \doubly special" theories have so far been formulated to incorporate space-time curvature, and thus gravitation. A related issue is the fate of the metric structure of space-time in these theories, and by extension, in quantum gravity.

It has been suggested [2] that non-linear realizations of the Lorentz group (in real space) have no quadratic invariant, and thus no metric. At high energy (or at sm all distances) the concept of metric simply disintegrates. However, given that the structure constants of the symmetry algebra are left unchanged (we are merely changing representation), it could be that much of the usual connection-based construction of general relativity could still be salvaged. This program to the rst of our constructions, but it has not, so far, been accom plished.

Curiously, a much simpler program emerges if we adopt the second of our constructions. In that case, the space-time transform ations remain linear, albeit energydependent, and so retain a quadratic invariant. An energy-dependent metric can still be de ned, such that in some sense, the metric \runs" with the energy. This approach leads to a very simple extension of general relativity, capable of accomm odating doubly special relativity, and is explored further in [14].
