A bstract

W e propose an extended BRST invariant Lagrangian quantization schem e of general gauge theories based on explicit realization of "m odi ed triplectic algebra" in general coordinates. A ll the know n Lagrangian quantization schem es based on the extended BR ST sym m etry are obtained by specifying the (free) param eters of that m ethod.

1 Introduction

M odern covariant quantization m ethods of general gauge theories are based on the principle of the BR ST $[1]$ or the extended BR ST $[2,3,4,5,6,7]$ $[2,3,4,5,6,7]$ $[2,3,4,5,6,7]$ $[2,3,4,5,6,7]$ $[2,3,4,5,6,7]$ invariance. Consideration of these m ethods in general coordinates seem s to be a very im portant task for understanding the geom etricalsense ofm ain objects, like (extended) antibracket(s), generating second-order operator(s) and so on, underlying these schem es.

Investigations of the well-known Batalin-V ilkovisky (BV) m ethod $[1]$ in general coordinates were initiated by E.W itten $[8]$ and A . Schwarz $[9]$ $[9]$. It was found that the geom etry ofthe BV form alism is the geom etry ofa superspace equipped with an odd sym plectic structure ! and a density function $[10]$ $[10]$. It will be shown below that the realization of such a program m e for the quantization m ethods, based on the extended BR ST sym m etry, s eem s to be m ore com plicated and, in addition, requires to use not only an even Poisson structure and a density function but also a at symplectic connection and a symmetric structure (like a m etric tensor).

2 Q uantization m ethods in D arboux coordinates

Let us present the basic ingredients of extended BR ST invariant Lagrangian quantization schem es, thereby following the original papers $[2, 3, 4, 7]$ $[2, 3, 4, 7]$ $[2, 3, 4, 7]$ $[2, 3, 4, 7]$. Am ong them the rst was the so-called $Sp(2)$ -covariant quantization proposed in papers $[2]$. The form ulation of that method includes the introduction of a con guration space of elds $^{-{\rm A}}$ with G rassmann parity ($^{\text{A}}$) = $_{\text{A}}$ which contains the elds of the initial classical theory, ghost and antighost elds, auxiliary elds and so on. For the purpose of the present investigation the explicit structure of the conguration space is not in portant and will not be discussed furtherm ore. To each eld A it is necessary to introduce three kinds of antields, namely, a Sp(2){doublet $_{Aa}$ (($_{Aa}$) = $_{A}$ + 1) where a = 1;2 is the index of the group Sp(2), and a singlet $_{A}$ (($_{A}$) = $_{A}$). The antields $_{A}$ can be considered as sources of BRST and ant $\mathbb B$ RST transform ations while the anti elds $_A$ are sources of the m ixed BRSTantiBR ST transform ations. Furtherm ore, the set of auxiliary $Sp(2)$ {doublet elds A^a

($({a}^{Aa}) = A + 1$) and singlet eld A ($({a}^{A}) = A$) is introduced. On the superspace of elds A and antields A _a the extended antibrackets (;)^a are de ned for any two functionalsF and G by the rule

U sually, allderivatives are considered as left derivatives; right derivatives are labelled by a specialm ark "r". Am ong the properties of the extended antibrackets there exist non-trivial relations,

which can be considered as generalized Jacobiidentities. Here and below curly brackets denote symmetrization with respect to the enclosed Sp(2) indices a and b F fa G bg $F^aG^b + F^bG^a$. Then, the generating operators a^a and V^a are introduced,

where a^{ab} is the antisymm etric tensor of the Sp(2) group. The operators a^{a} and V a^{b} form the algebra of nilpotent and anticom muting operators,

The vacuum functional within the $Sp(2)$ approach is constructed as the following functional integral,

thereby the functional $G = G$ () de nes a speci c choice of the gauge. The vacuum functional (2.5) is invariant under the extended BR ST transform ations

with a Sp(2)-doublet of constant G rassm ann param eters, α , and it is gauge independent, $Z_{G+ G} = Z_G$.

A nother version of the Sp(2) form alism , suggested in β], considers the auxiliary elds a^A as canonically conjugate with respect to the elds α_A with the following re-de nitions ofthe extended antibrackets,

N otice that by the explicit realization of the vector $\,$ elds V $^{\rm a}$ in the form $\,$ (2.10) the last relations in (2.11) in com parison with (2.4) hold without symmetrization of the indices a and b.

The vacuum functional is constructed in the following form,

where the bosonic functional $S = S(z)$ (z = (;;;)) sati es equations like [\(2.6\)](#page-1-0) and the gauge xing functional $X = X$ (z;) is required to satisfy the following m aster equations: $(\begin{bmatrix} a \\ \end{bmatrix}$ (i=h)V a) expf(i=h)X g = 0. The vacuum functional (2.12) is invariant under the extended BRST transform ations $= (7 \times 10^{-4} \text{ s})^2 \text{ s} + 2 \text{ s}^2 \text{ V}^2 \text{ (} = (z;))$, and \pm is gauge independent, $Z_{X + X} = Z_X$.

Let us notice that due to the special structure of the operators V $^{\rm a}$, (2.10), it is not possible, in contrast to all previously known schem es of Lagrangian quantization, to consider the initial classical action as a natural boundary condition to the solution of the quantum m aster equations, since $(1=2)(S_{c1};S_{c1})^a + V^aS_{c1}$ ih ${}^aS_{c1}$ \in 0. This was the m ain reason in Ref. [\[7\]](#page-6-0) to reform ulate the original triplectic scheme by a m odied one.

Rem aining in the same con quration space of elds and antields $z = ($; ;;), it was proposed to change from the beginning the triplectic algebra and the generating m aster equations by introducing an additional set of Sp(2) doublets of operators U $^{\rm a}$, $(U^a) = 1$, by requiring

This algebra can be considered as an extension of the triplectic algebra (2.11) and is refered to as the "modied triplectic algebra". An explicit realization of the operators m ay be given by a and V a as introduced in Eq. (2.9) and the second of Eqs. [\(2.3](#page-1-0)), respectively, and U^a in the form

The vacuum functional within this approach form ally coincides with Eq. (2.5) (2.5) when S = S(z) and X = X(z;) satisfy the quantum m aster equations ($a + (i=h)V^a$) expf($i=h$) Sq =

0 and (a (i=h)U^a)expf(i=h)X g = 0, respectively, and the functional S₀ was de ned in (2.7) (2.7) . Now one can use the standard boundary condition for S in the form of an initial classical action S_{cl} when $h =$ = $= 0$.

This vacuum functional is also invariant under extended BR ST transform ations (;X S)^a $_{a}$ + $_{a}$ (V^a + U^a) and it is gauge independent.

3 (M odi ed) triplectic algebra in general coordinates

N ow, we consider an explicit realization of the (m odied) triplectic algebra. O ur starting point is an even superspace M $_0$ described by local coordinates x^i ((x^i) = $_{i}$), which in D arboux coordinates will be identifed as $x^i = (A; A)$. The superspace M $_0$ is equipped with a Poisson structure $!\begin{bmatrix} i & i \end{bmatrix}$ ($(!^{i j}) = \begin{bmatrix} 1 & i \end{bmatrix}$ with the following properties $i^{ij} = (1)^{i}i^{ji}$ and $(1)^{i}k!^{kl}$ $q_1!^{ij}$ + cyclperm $(ijk) = 0$.

In the following, for the sake of simplicity of all expressions and relations, we restrict ourselves to the case when all coordinates x^i are even, $i = 0$, although in the context of quantum eld theory am ong x^i also odd variables (ghost elds) always are present.

M $_0$ is also equipped with a symmetric connection $k_j = -\frac{k}{ji}$ (or a covariant derivative r i) respecting the Poisson structure $\theta_i!^{k}j + |k^l|^{j}_{li}$ $\theta_i^{k}j + |k^r|^{j}_{li}$ = 0, as well as a scalar (density) function = (x) . W hen the Poisson structure is nondegenerate $\frac{k}{ij}$ coincides, in fact, with the Fedosov connection [\[11](#page-6-0)] and $(M_0;!;r)$ is referred to as the Fedosov space [\[12](#page-6-0)]. The curvature tensor R $_{\rm ijk}^{\rm l}$ of this (Fedosov) connection has the standard form and properties:

Then we consider the superspace M param etrized by the coordinates $z = (x^i; u_a)$, $(y_{ia}) = 1 + 1$, where y_{ia} ("antields") are transform ed as $\theta_i = 0 = 0$ and x^i under reparam etrizations of M₀. N otice that the variables \overline{a} in the D arboux coordinates can be identi ed as $_{ia} = (a_{ab} \cdot A^{aa})$.

U sing the Fedosov connection, we can de ne on the superspace M the dierential operators corresponding to the covariant derivative on M $_0$:

To geta realization ofthe triplectic algebra in generalcoordinates,one can considera m inim algeneralization by replacing in the antibrackets [\(2.8\)](#page-1-0) the usual derivative, \mathfrak{g}_i , by the covariant one, r_i , nam ely

On the superspace M there exists a naturally de ned object being a $Sp(2)$ irreducible second rank tensor, nam ely $S_{ab} = (1=6)_{ia}! i j(x)_{ab}$, $S_{ab} = S_{ba}$. This tensor is covariantly constant $r_iS_{ab} = 0$. W ith the help of this tensor we introduce the vector elds V^a in an \exp licitly Sp(2) symmetric way $V_a = (S_{ab}; \quad b = (1=2)_{ia}!^{ij}r_j$.

For these objects to be antibrackets, the operations [\(3.18\)](#page-3-0) m ust satisfy the Jacobi identities [\(2.2\)](#page-1-0). This requirem ent has the consequence for k_{ij} to be a at connection, R_{ijm}^k = 0. The existence of such at connections directly follows from the D arboux theorem . N am ely, in D arboux coordinates one can choose the trivial connection which is obviously
at.N ote thatevery non-linearcanonicaltransform ation transform sthe trivial connection into a non-zero one. Such at connection, respecting the Poisson bracket, was used in Ref. [\[13\]](#page-6-0) for the form ulation of a coordinate-free scheme of deform ation quantization.

Therefore we arrive at an explicit realization of the triplectic algebra on M with an arbitrary at Poisson space M₀.

To nd an explicit realization of the m odi ed triplectic algebra we need an additional structure. Let us equip M $_0$ by a symmetric tensor $q_{ij}(x) = q_{ij}(x)$. When this tensor is nondegenerate it can be considered as a m etric tensor on M $_0$. Now we can construct the Sp(2) scalar function S₀ which is de ned on the superspace M as follows: S₀ = (1=2) $_{ia}g^{ij}$ $_{jb}^{mab}$, $(S_0) = 0$, $g^{ij} = !^{im} g_{mn} !^{nj}$. It generates the vector elds U^a = $(S_0;)^a$. R equiring the conditions [\(2.14\)](#page-2-0) yields the following equations for S_0

where N $_{\rm ij}^{\rm k}$ is the N ijenhuis tensor. W hen these equations are ful lled the set of operators a , V a and U a form the modied triplectic algebra [\(2.13\)](#page-2-0), [\(2.14\)](#page-2-0).

4 Q uantization

The superspace M can be equipped with an even symplectic structure. Indeed, we can construct an even closed two-form, which is non-degenerated on the anti elds (compare $Ref. [14]$ $Ref. [14]$:

where D $_{ia}$ = d $_{ia}$ $_{ij}$ $_{ka}dx^{j}$, and $_{ij}$ is some Fedosov connection (not necessarily at). Requiring the connection to be at , we can equip the superspace M, in addition to the triplectic algebra,by the even sym plectic structure

where is an arbitrary constant. Using this even sym<u>plectic</u> structure we can de ne on M the analogue of the Liouville measure 15] D₀ = \overline{Ber} = (det !_{ij})³⁼².

Let us construct the vacuum functional and the generating m aster equations for a quantum action $S = S(z)$ and a gauge xing functional $X = X(z; z)$ using the basic operators $a_i V^a U^a$ and the function S_0 introduced above. We deene the vacuum functional Z asthe following path integral,

where D₀ is the integration m easure and is a constant. We suggest the following form of generating m aster equations for S and X

where V^a;U^a are rstorder dierential operators constructed from V^a;U^a. Let us consider the m ore general transform ations of coordinates z, $z = (z;F)^a$ $a + aV^a z + aU$ $_{a}U^{a}Z_{I}$ generated by the antibrackets (;)^a and operators V^a; U^a, where ; are some constants, $_{a}$ is a Sp(2) doublet of anticom m uting constant param eters and F = F (z;) is a bosonic functional. Choosing $F = X$ S and

we obtain the invariance of vacuum functional (4.24) (4.24) under the BR ST-antiBR ST transform ations de ned by the generators $a = (X - S;)^a + V^a - U^a$.

Evidently for arbitrary constants $\;$; the operators V^a; U^a obey the properties $V^{\text{fa}}V^{\text{bg}} = 0$, $U^{\text{fa}}U^{\text{bg}} = 0$, $V^{\text{fa}}U^{\text{bg}} + U^{\text{fa}}V^{\text{bg}} = 0$. Therefore the operators $A = (3.19)$ $A = (3.19)$ and V^a ; U^a (4.26) realize the modied triplectic algebra.

That construction, which we derived here, includes all the canonical $Sp(2)$ covariant quantization schem es listed in Section 2:

= 0: The operators V^a ; U^a are linear dependent U^a = V^a . In this case there exists only one set of the vector elds V^a and the modied triplectic algebra is reduced to the triplectic one.

= 0; = 2; = 0: In this case one obtains $V^a = V^a$. In fact, this is representation ofvectoreldswhich wasused in constructing the triplectic quantization in general coordinates [\[4\]](#page-6-0). In D arboux coordinates the vector elds V^a , $U^a = V^a$ coincide w ith the ones used in original version of the triplectic quantization [\[3\]](#page-6-0).

 $= 1; = 2; = 0$: In the D arboux coordinates we reproduce the vector elds $V^a = V^a$, $U^a = U^a$ being used in [\[2](#page-6-0)] as well as in the modi ed triplectic quantization [\[7\]](#page-6-0). In this case = const, $S_0 = A_a$ and the vacuum functional [\(4.24](#page-4-0)) coincides w ith one within the m odi ed triplectic quantization.

5 C onclusions

W e developed (sec [\[16](#page-6-0)]) the extended BR ST invariant quantization schem e in Lagrangian form alism which includes allthe ingredients appeared in the realization ofthe m odied triplectic algebra. The form ulation exactly uses the integration m easure extracted from the even sym plectic structure on the whole space of elds and antields. It allows to consider all existing covariant quantization schem es with extended BR ST symmetry as speciallim its.
