A derivative expansion of the e ective average action beyond rst order yields renorm alization group functional ow equations which are used for the computation of critical exponents of the Ising universality class. The critical exponent in D = 3 is consistent with high-precision m ethods.

The e ective average action

Derivative expansion beyond st order

The ective average action $_{k}$ [] (see [1] and [2,3,4,5]) is a functional of the elds '. It interpolates between the classical action S at some m icroscopic ultraviolet scale and the elds ective action : = S, $\lim_{k \ge 0} k = .$ Its dependence on the momentum scale k is described by an exact renorm alization group functional ow equation:

where $_{k}^{(2)}$ is the second functional derivative of $_{k}$ with respect to the elds and R_k denotes a momentum cuto function with the properties $\lim_{k! 0} R_{k} = 0$, $\lim_{k!} R_{k} ! 1$ and $\lim_{q^{2}! 0} R_{k} (q^{2}) > 0$ ensuring the above $\lim_{k} i properties of _{k} Universal properties of the renormalization group ow, how ever, are independent of the actual choice of R_k.$

The ow of $\binom{(2)}{k}$ and higher n-point-functions can be derived from the ow of $_k$ by functional derivation, e.g.

where the ow of ${}^{(3)}_{k}$ would involve ${}^{(4)}_{k}$ and ${}^{(5)}_{k}$ and so on. In order to end up with a closed system of functional ow equations one needs to do a nite truncation of ${}_{k}$.

In the following we concentrate on a one-component real scalar eld ': R^{D} ! R. There are the invariants $=\frac{1}{2}$ ' and $q^{2}=\frac{1}{2}$ @ ' @ ' featuring the O (1) symmetry of the Ising universality class. Here the lowest order truncation of the elective average action reads

in terms of the elective average potential U $_{\rm k}$ () and a eld independent wave function renorm alization Z $_{\rm k}$. The elective average propagator

gives the ow of the e ective average potential

and $\mathfrak{Q}_k \mathbb{Z}_k$ can be determined from $\mathfrak{Q}_{q^2} \mathfrak{Q}_k \stackrel{(2)}{\underset{k}{\overset{(2)}{\underset{k}{\overset{(2)}{\atop}}}} q^2$) $\dot{I}_{q^2=0}$.

Such lowest order expansions and more elaborate rst order expansions have been successful in the quantitative description of critical phenomena. As the ow equation for the elective average action is exact one may hope that results from expansions to higher order will converge to the correct properties of the theory. One such expansion is exam ined in the following.

In a second order derivative expansion of the e ective average action there are contributions from up to four nonvanishing momenta:

A ssum ing vanishing elds and momenta at the border of space one may absorb $Z_{B\,;k}$, $Z_{D\,;k}$, $Z_{F\,;k}$ and $Z_{G\,;k}$ by integration by parts into $Z_{A\,;k}$, $Z_{C\,;k}$ and $Z_{E\,;k}$.

W hile $Z_{A,k}$ and $Z_{E,k}$ directly contribute to $\binom{(2)}{k}$ and thus enter all ow equations as q^2 and q^4 terms in the denominators of the integrands, $Z_{C,k}$ only gives an additive contribution to the four-point-vertex.

A lso, its ow requires $\mathbb{G}_k \stackrel{(4)}{k}$. This is why we neglect $\mathbb{Z}_{\mathbb{C},k}$ in this paper which corresponds to a truncation beyond rst and below second order only taking contributions to the four-point-vertex with at most two nonvanishing momenta into account.

Substituting $U \coloneqq U_k$, $Z_0 \coloneqq Z_{A,k}$ and $Z_1 \coloneqq \frac{2!}{4!}$, $Z_{E,k}$ the truncation thus reads:

In order to be able to perform the q^2 -derivatives one has to expand the denom inator containing $(p+q)^2$. Let N = ⁽²⁾ $(p^2) + R (p^2)$ and M = ⁽²⁾ $((p+q)^2) + R ((p+q)^2)$:

As we are interested in critical phenomena of second order phase transitions corresponding to x points in the renormalization group ow, we write the ow equations in explicitly scale invariant form.

To this end one substitutes $z_0() = Z_0() = Z_0(k)$ (where k is the running m inim um of U()), $= Z_0(k)k^{2D}$, $u = k^{d}U$, t = Lnk, $= Q_L Ln Z_0(k)$ etc. such that

with $v_D = (2^{D+1} D^{-2} (D=2))^1$, a = m + D=2 1, $b = (1 z_0) = (1 + w)$ and $c = z_1 = (1 + w)$. The series expansion and reordering is valid and convergent as long as 1 bx $cx^2 \in 0$ for all $x \ge [0;1]$, i.e. if the integrand of H has no singularities. This is ensured as the elective average propagator stays nite at all times.

C ritical exponents

Starting with a quartic potential $u = \frac{1}{2}$ ($)^2$ the ow equations are discretized on a grid and num erically solved for di erent values of . During the evolution towards k ! 0, the running m in im um of the potential $(u^0) = 0$ may either end up in the massless spontaneously broken phase (m = 0, ! 1) or in the massive symmetric phase (m² $k^2 u^0(0)$, = 0). The critical $_{\rm c}$ leads to a second order phase transition characterized by x points of all couplings and vanishing m asses. Fine around c then yields the critical exponent tuning through the scaling law $m = T_c j$ and the established proportionality j cj j T_cj. The critical exponent may be identied with the x point of the anom alous dimension. It can therefore be directly obtained from the critical trajectory.

The critical exponents for the universality class of the three dimensional Ising model obtained in this way are compared in Table 1 to values obtained in rst order $(z_1 = 0)$ and lowest order $(z_0^0 = z_0^{00} = :::= 0)$. For comparison we also give results from literature. An extensive review of dimension techniques and recent results can be found in [7]. We adopt their overall estimates of exponents and errors. In addition we quote some of the new est and precisest results from high temperature expansions, perturbation series at xed dimension, -expansions and M onte C arbo simulations plus som e additional references.

Conclusion and outlook

W e have presented the rst calculation of a derivative expansion beyond rst order of the e ective average action. C onsidering form er results from low est and rst order expansions we notice that the critical exponents calculated in this way seem to converge to the values suggested by literature. This observation is very encouraging and the next step will be the inclusion of the third wave function renorm alization which will correspond to a calculation in full second order.
