A nti-de Sitter black holes, perfect uids, and holography

We consider asymptotically anti-de Sitter black holes in d-spacetimed in ensions in the thermodynamically stable regime. We show that the Bekenstein-Hawking entropy and its leading order corrections due to thermal uctuations can be reproduced by a weakly interacting uid of bosons and fermions (holographic gas') in $= (d \ 2) + 1$ spacetimed in ensions, where the energymomentum dispersion relation for the constituents of the uid is assumed to be $= p \cdot W e$ exam ine implications of this result for entropy bounds and the holographic hypothesis.

I. IN TRODUCTION

It is believed that black holes are therm odynam ical objects with entropy given by one-quarter their horizon areas A_H (in P lanck units) [1]

where $'_{Pl} = (Gh=c^3)^{1=(d-2)}$ is the P lanck length and G_d the Newton's constant in d-spacetime dimensions. They satisfy the two laws of black hole therm odynam ics'

where T_H is the Hawking temperature. These laws are semi-classical, and apply to large black holes with $A_H = \frac{v^{d-2}}{p_1}$.

The idea that black holes are therm odynam ic system s in equilibrium has led to two related areas of study. The rst constitutes suggestions for the underlying m icroscopic degrees of freedom. These are postulated based on one's views of what are the fundam ental degrees of freedom arising from a quantum theory of gravity. The goal is to reproduce the entropy formula (1) by tracing a density m atrix describing a black hole over unobserved quantum degrees of freedom. A related approach involves calculating the num ber of m icrostates associated with m acroscopic param eters of a black hole, such as its m ass and charge [2{4].

The second area of study arises from the observation that the entropy of a con ned non-black hole system is proportional to spatial volum e, rather than bounding area. Reconciling this with the fact that black holes are believed to be the most entropic system s leads to a view – point know n as the holographic hypothesis. This hypothesis states that a d dim ensional theory m ay be encoded exactly in a (d 1) dim ensional theory. W hat rem ains is the signi cant task of providing the details of the encoding, the \holographic m ap." A part of this m ap consists in matching the therm odynam ics of black holes with a suitable system in one lower dim ension. In this paper we consider the second question regarding holography in detail. Speci cally we focus on the AdS-Schwarzschild black hole because it is therm odynam ically stable, and because of its role in the AdS/CFT correspondence. We show that therm odynam ic properties of this black hole can be encoded in a holographic gas of free bosons and ferm ions. The dimension of the gas depends on the dimension of the black hole, as well as the dispersion relation of its constituents.

In the next section, we review recent work on therm al uctuation corrections to entropy and its application to black holes. In section (III) we discuss the therm odynam ics of asym ptotically anti-de Sitter black holes and therm al uctuation corrections to entropy. In section (IV), we show that a perfect uid of bosons and ferm ions captures the entire therm odynam ics of these black holes, including therm al uctuation corrections. We exam ine the implications of our results for entropy bounds [5{8] in section (V), and nally conclude in section (VI) with a sum mary and list of open questions.

II. THERMAL FLUCTUATIONS AND ENTROPY

B efore we give a system atic derivation of leading order corrections to entropy of a system due to sm all therm al uctuations, we present a heuristic argument showing how logarithm ic corrections to entropy arise for a black hole.

Consider W heeler's \it from bit" idea, which ascribes one bit of information (equivalently a spin 1/2) to each P lanck area on the black hole's horizon [5,9]. This idea also incorporates \holography" in that degrees of freedom are associated with area rather than volum e. If the area of the black hole horizon is A, the number of microstates is $= 2^{n}$, with $n = A = 1_{p}^{2}$, so that entropy $S_{BH} = ln$ is proportional to horizon area. This model may be obviously generalised to associate a spin s with each P lanck area without changing the basic result. The number of microstates is now $= (2s + 1)^{n}$, which gives entropy proportional to area with a di erent coe cient. C onnections to entropy arise in this picture if the component of total spin along a given axis is xed. Let x^i of the n spins have a state s^i chosen from the (2s + 1) projections along a xed axis. (The total spin component along that axis is then $_i$ [x_i(2s=(2s+_p1))s_i s].) The number of possible states N subject to $_i$ x_i = n is given by the multinom ial distribution function (assum-ing that the probability for nding any spin in state i is independent of i, and equal to 1=(2s + 1)):

The entropy $S = \ln N$ may be evaluated using Stirling's form ula, assuming $x^i >> 1$ to give

where $S_{BH} = A \ln (2s + 1) = \frac{1}{p}^2$ is the entropy with no restriction on total spin component, a P_{i}^{P} k_i ln k_i¹ and b = a = ln (2s + 1) are of order unity, and k_i x = n. This is a generalisation of the s = 1=2 case considered in [10]. Thus, the leading corrections are logarithm ic, with the exact coe cient depending on the spin of the building blocks of the black hole.

We now discuss some generalities of therm odynamic systems in equilibrium and their thermal uctuations, before proceeding to AdS black holes and the free boson/ferm ion gas. This is a review of work [11{14] which shows that logarithm ic corrections to entropy arise from quite general considerations.

The canonical partition function for any thermodynamic system in equilibrium is

is the 'entropy function'. A saddle-point approximation of S () around the equilibrium temperature $_0{}^1$ gives

This form ula is applicable to all therm odynam ic system s. In particular it m ay be applied to black holes by setting $S_0 = S_{B\,H}$, $T = T_{B\,H}$ and $C = C_{B\,H}$ for the speci c black hole under consideration. It is understood that the quantity within the logarithm is divided by k_B^2 , the square of the Boltzm ann constant.

The application of (17) to black holes was considered in detail in [13,14], where it was shown that it provides a general approach to understanding corrections to black hole entropy computed in various models in the literature. For related and other approaches, see [15{30]. For other applications of (17), see [31].

III.A SYM PTOTICALLY ANTIĐE SITTER BLACK HOLES

We review therm odynamic properties of BTZ and A dS-Schwarzschild black holes, and compute entropy corrections using the method discussed above. Note that this method does not apply to Schwarzschild black holes which have negative specic heat.

For the BTZ black holes

This agrees with correction computed using conformal eld theory by Carlip [20], including the coe cient 3=2 in front of the logarithm.

It is curious to note that on substituting d = 3 in the above, the BTZ result (22) is recovered, although the metric of the latter is not a special case of (23).

We now attempt to model the therm odynamic properties of asymptotically AdS black holes using a perfect uid of free bosons and fermions at temperature T in spacetime dimension, and with dispersion relation

W e compute the equation of state, free energy and entropy using standard m ethods.

The therm odynam ic potential is [32]

Thus, given an anti-de Sitter Schwarzschild black hole in d-spacetime dimensions, there will be a holographic gas in -spacetime dimensions capturing all therm odynamic information of the black hole.

Using (37), this may be written as

The last equation shows that the uid is physical, in the sense of causality, for all cases: the dom inant energy condition (positive energy, and null or lightlike uxes) gives the condition 0 k 1, which is satistic ed for d 3 (the cases of interest here).

Next we compare the coe cients of the power of tem – perature in (42). There are two ways to do this depending on the point of view taken on holography: (i) the holographic degrees of freedom associated with a black hole reside on a surface $r = r_0$ in the black hole spacetime, or (ii) the holographic degrees of freedom do not reside on any bounding surface in the black hole background, but rather are de ned on their own at background spacetime.

According to (i), the temperature T of the gas must be taken as the red-shifted black hole temperature

where we have used the fact that the gas lives in a subspace of the surface $r = r_0$ so that its volume is $V_1 = {}_1r_0^{-1}$.

W e point out that a special case of the relation (47) arises in the context of the AdS/CFT conjecture. For d = 5, = 1, = 4 and $n_B = n_F = 8 (N^2 - 1)$, it was shown [33,34], with the additionalAdS/CFT relation

that Eq.(47) is satis ed up to a factor of 4=3.

A coording to the point of view (ii), the tem perature of the gas is equated to the black hole tem perature w ithout any red-shift factors. This leads to the following relation between coe cients:

Note that in either case (i) or (ii), the holographic dimension is given by Eq.(43).

which is norm ally assumed in the context of holography [5,6]. Another indication that = 1 m ay be 'preferred' lies in the fact that the r_0 -dependence drops out of the relation (47) only for this value of .

It is interesting to note that for near-extrem al stringy black holes, the near horizon geometry is BTZ [35]. Thus, to describe the thermodynamics of these black holes, one substitutes d = 3 in (49). This gives a (1 + 1) dimensional holographic gas. Such a gas has been shown to reproduce the entropy and H aw king radiation rates of near extrem al black holes in string theory [36].

We now compare the leading order entropy corrections of the black hole and gas. Using $C_{gas} = d(F_{gas} + TS_{gas})=dT$, the dimension matching equation (43) and Eq.(17), the corrected entropy of the gas is

M atching the uncorrected entropies $S_{BH} = S_{gas}$ in this equation, we see that the leading logarithm ic term agrees precisely with that on the black hole side, Eq.(27), for all spacetime dimensions, and for any value of in the dispersion relation (31). The last term in (50) depends on the volume of the gas, as well the number of species, and can be interpreted as a nite size e ect. These are considered sub-dom inant so long as the entropy S_{BH} remains large. Thus, the exact details of the boundary theory are seen to be irrelevant for all for the leading order corrections to m atch. (F inite size e ects were also considered in [37].)

The issue of log corrections for d = 5 and = 1 were rst analysed in [38]. However, there the authors had ignored the factor of T_H^2 in (17), by setting the 'scale' of the logarithm to T_H itself. This scale is actually the Boltzm ann constant k_B , which has been set to unity here. Consequently, the coe cient in front of the log term was incorrect there, both for the black hole and the gas. In addition, the nite-size e ect term s were missed.

For $AdS_5=C F T_4$ correspondence, when d = 5; = 1; = 4; $n_b = n_F = 8 (N^2 - 1)$, the coe cient of the log corrections is 5=6, agreeing perfectly with its black hole counterpart, Eq.(27).

V.ENTROPY BOUNDS W ITH ADS BLACK HOLES

In this section we consider the Bekenstein and sphericalbounds for asymptotically anti-de Sitter black holes, and exam ine the e ects of entropy corrections on these bounds. The Bekenstein bound states that the entropy of matter in a closed region of linear dimension R and energy E is bounded above by the inequality [7,8]

O ne way to arrive at this result is to consider a G eroch process,' in which a matter system in a box is low ered slow ly from an asymptotically at region, and then dropped into the black hole where the box just touches the horizon. The argument assumes that the energy of a oating box near the horizon is added to the black hole, which increases its entropy. The generalised second law $S_{Tot} = S_{BH}^{final}$ ($S_{BH}^{initial} + S_{matter}$) 0 then leads to the desired inequality. The drop o point occurs where the center of mass of the matter system is a distance R from the horizon, where the energy of the matter acquires a factor g_{00} relative to its energy at in nity.

This argument may be applied to an AdS-Schwarzschild black hole background, where the energy of the system is assumed to be E at a large radius $r>>r_{\!+}$. The energy of the matter a proper distance R from the horizon is

Notice that the leading term is identical to the Schwarzschild case [8]. The correction, which depends on the horizon radius, reduces the bound. The correction term attains its maximum when the radius is of the order of P lanck length, which gives

This equation may be regarded as the modi ed Bekenstein bound. (Corrections to the Bekenstein bound from nite volume corrections were analyzed in [39].)

It is interesting to see what happens to this bound at the expected saturation point where the system (E;R) is an AdS-Schwarzschild black hole. The entropy bound becomes

Since $r_{+} = `$ 1, the right side is much larger than the black hole entropy. That is, the black hole entropy is far from saturating the Bekenstein bound, im plying that the latter is rather weak in this case. This is a signi – cant departure from the asymptotically at case where the upper limit is provided by the black hole entropy.

The spherical entropy bound similarly undergoes the $\ensuremath{\mathtt{m}}$ odi cation

Of course in this case, the black hole saturates this bound, by de nition. From (59) and (60) it follows that the two bounds are not of the same order for asym ptotically anti-de Sitter black holes, and that the Bekenstein bound is much weaker than the spherical bound. (A fier this work was done, we became aware of a recent paper where corrections to Bekenstein and spherical entropy bounds have been proposed [40]. The correction to the sphericalbound proposed in that paper agrees with our's, while that to the Bekenstein bound does not).

Finally we point out the AdS black hole analogues of two related entropy bounds previously discussed for Schwarzschild black holes [5]. These are bounds on the entropy of a collection of black holes, and on the entropy of matter contained in a closed spatial region.

W e ask if the spherical entropy bound is satis ed for a collection of A dS-Schwarzschild black holes with m asses M_i in a bounded region of area A. To do so let us nst compare the sum of the entropies $S_{total} = S_i$ of a collection of black holes with the entropy S_M of a black hole of m ass M = M_i:

This is the opposite of the Schwarzschild black hole result, and indicates that if A is taken to be the horizon area of the composite black hole, then $S_{total} > A = 4 \frac{vd}{p} \frac{2}{l}$. Thus an upper bound on the entropy of a collection of AdS black holes cannot be derived form this argument.

To obtain a specic example of an entropy bound on a matter system derived using AdS black holes, we use the gas discussed in the last section. The energy and entropy of the gas, consisting of Z species, and with the dispersion relation (31), follows from Eq.(39), with the replacement ! d (also see [5,8,41]):

An entropy bound arises by requiring that the gas is outside its A dS-Schwarzschild radius. This is obtained from the expression for the mass of the Schwarzschild-A dS black hole in the r ' lim it:

Note that the exponent of A in (69) is greater than unity, unlike the asymptotically at case, again resulting in a weaker bound. Eq.(69) can be written as:

VI.DISCUSSIONS

W e have shown that the therm odynam ics of black holes can be reproduced by a holographic gas with a generalised dispersion relation. Speci cally we have the general result that for AdS-Schwarzschild black holes in dspacetime dimensions, the therm odynamics can be encoded in a gas of free bosons and fermions in =

 $(d \ 1) + 1$ spacetime dimensions. Thus for a given d, a variety of can serve our purpose, depending on . We have also seen that some results in the A dS/CFT context arise as special cases of the therm odynamic matching we have used.

W e have also derived corrections to entropy bounds, and discussed specic examples of the bounds, using Schwarzschild-AdS black holes. An interesting result here is the lack of a spherical bound for a collection of these black holes.

Particles with = 1 do not seem to be necessary in the holographic mapping, although they are su cient. It is interesting to note how ever, that for = 1, the relations that m ap the entropies of the black hole and gas become e independent of r_0 , the 'location' of the holographic gas in the black hole spacetime. Thus, this may be an additional reason to attach a preferred status to particles satisfying the relativistic dispersion relation.

There are several open questions which would be interesting to pursue. From the integral in (9), it is clear that the next-to-leading-order corrections are di cult, if not im possible to compute analytically. It may be possible to do this num erically to nd the dependence of the corrections on horizon area. As noted earlier, the corrected entropy is always less than the uncorrected one, signifying a reduction in the number of accessible states, when uctuations are taken into account. It may be useful to nd an interpretation of this result from the point of view of information theory, in which decrease of entropy is associated with an increase in information [42,43].

An important generalisation of the current form alism would be to calculate entropy corrections for asymptotically at black holes. One way would be to consider these black holes in a nite box, whose size can be adjusted such that the speci c heat of the resultant system is positive [44]. It would also be interesting to compare these corrections with those coming from other sources, such as quantum spacetime uctuations [45].

A related problem concerns de-Sitter black holes. Here the tem perature and speci c heat can be obtained from the corresponding expressions for asym ptotically anti-de Sitter black holes Eqs.(25-26)], by substituting ² ! ²:

Here in the regime in which Hawking temperature is positive, the speci c heat is negative, again signaling an apparent breakdown of the approach. However, since the energy of the black holes is negative, one may use a modi ed de nition of speci c heat, namely C = d(E)=dT. This gives a positive C and permits some calculations [46{48]. Corrections to entropy would be identical to that for the AdS case, Eq.(27), and it appears that the m apping of therm odynam ics can also be done.
