# R ecom bination of Intersecting D -branes by LocalTachyon C ondensation

### A bstract

W e provide a sim ple low energy description of recom bination of intersecting  $D$ branes using super Yang-M ills theory. The recom bination is realized by condensation of an o-diagonal tachyonic uctuation localized at the intersecting point. The recom bination process is equivalent to brane-antibrane annihilation, thus our result con m s Sen's conjecture on tachyon condensation, although we work in the super Yang-M ills theory whose energy scale is much lower than  $0$ . We also discuss the decay width of non-parallelly separated D -branes.

#### $\mathbf{1}$ Introduction

The signi cance of D -brane dynam ics in string theories has been widely recognized, and for uni ed form ulation of nonperturbative string/M theory it is believed to be promising to adopt D -branes as fundam ental objects. Low dimensional D -branes, such as D -particles and D-instantons, have been utilized along this direction [1], while higher dim ensional D-branes have relative di culty due to the complicated interaction of the extended worldvolumes. One of such interaction is the recombination, or equivalently reconnection, of intersecting D -branes (especially D-strings). For fundam ental strings, the recombination e ect has been introduced as an essential interaction in an open string eld theory [2]. It strongly suggests that the recombination is one of the most important mechanisms to be claried, for formulating any eld theory of interacting D-branes. On the other hand, recombination of D-branes tumed out to be an intriguing realization of H iggs phenom ena in Standard M odel on intersecting branes [3] and in ation in braneworld scenario [4]. The recombination appears as an essential dynam ics in these recent developm ents in string phenom enology, hence its precise form ulation in string theory is required.

It is well-known [5] that the recombination is due to the tachyon mode appearing as the lowest m ode of a string connecting the intersecting  $D$  -branes (see Fig. 1), although the mechanism has not been shown explicitly so far. As seen below, this is related to Sen's conjectures [6] stating that tachyon condensation on brane-antibrane is equivalent to the disappearance of them. W hen the intersection angle is, the intersecting  $D$  -branes are just a parallel brane-antibrane pair. The relevant tachyon m ode appears in excitation of a string connecting the two. If we decrease a little, then this tachyonic mode is localized near the intersection point. P rovided the tachyon condensation m akes the branes disappear, it a ects them only locally and the branes are recombined (See Fig. 4). The veri cation of the Sen's conjectures, especially on the disappearance of open string degrees of freedom, has not been shown in a complete form yet. So it would be possible to say that showing the D -brane recombination explicitly is qualitatively equivalent to the veri cation of the Sen's conjectures. In addition, the system of intersecting D-branes includes the parallel braneantibrane system as a special lim  $\pm$  = , and naively  $\pm$  is expected that any multi-body system s of D -branes are involved w ith intersecting branes generically, rather than its special of the parallel brane-antibrane. This leads us to motivate the study of the local  $\case =$ tachyon condensation on the intersecting branes, which is the recombination process.

In this paper, we provide a very simple description of the recombination of intersecting D -branes by analysing corresponding background in super Y ang-M ills theories which are low energy e ective theories of D-branes. We identify one of the uctuation eigen modes with the

tachyon state concerning the annihilation of branes, and show that the condensation of this m ode exactly gives the recombination of the intersecting branes. Our description provides a geom etrical realization of the open string tachyon condensation.

In Ref. [7], uctuation spectra of Yang-M ills theory have been studied for a T-dualized con quration of the intersecting branes wound on a torus. The authors of Ref. [7] showed the agreem ent between the Yang-M ills uctuation spectra and string theory spectra, while due to the T-duality geom etrical picture of the recombination was di cult to be seen. Our work does not involve the T-duality and lls the gap.

In Section 2 we study a  $1+1$  dim ensional SU (2) super Y ang  $M$  ills theory which is induced on parallel D-strings at bw energy. We turn on a linear H iggs background in the diagonal com ponent, which am ounts to turning on the intersecting angle . The uctuation analysis around this background shows that there appears a tachyonic mode whose mass squared (and its dependence on ) coincides with the worldsheet result of Ref.  $\beta$ ], for small . A fler diagonalizing the uctuation, we see that the tachyonic mode is exactly associated with the brane recombination. A ll the computations are carried out in the low energy approximation of string theory whose energy scale is much lower than the string scale  $\degree$ . This is possible since at sm all the tachyon becomes alm ost m assless.

We also attempt to analyse the behavior of , in Section 3. In the  $\lim$  it = , the brane con quration becom es a parallel coincident D 1-antiD 1 pair. We rst clarify the relation between the D-brane recombination and the Sen's conjectures on the tachyon condensation on brane-antibrane. W ith naturalansatz from string scattering am plitudes, we adopt a tachyon action and its coupling to the gauge elds living on the D-branes. This natural tachyon action is used to show that the worldsheet spectrum near  $\qquad$  = is precisely reproduced in the uctuation analysis. Furtherm ore, the geom etrical recombination is shown also in this by analysing the backreaction to the transverse scalar eld. system

In Section 4, we describe dynam ical aspects of the recombination by evaluating the decay w idth of non-parallelly separated D -branes. We show that for sm aller intersection angle  $\,$ , the decay probability gets sm aller and the system approaches a supersymm etric system of parallel D -branes. We speculate on how the recombination process proceeds.

The low energy Y ang-M ills approxim ation in Section 2 is valid for sm all intersection angle ゙゙゙゙゙゙゙゙゙゙゙゙ 1, so in Appendix A we include the non-Abelian Bom-Infeld (NBI) corrections to  $\pm$ , to see how the string spectrum with the higher order in is reproduced in the uctuation spectrum. We use  $(0)^2F^4$  corrections in the NBI [9] and follow the techniques developed in

H igher dim ensional D -branes intersecting with a single angular param eter can be treated with a trivial generalization of our work.

Ref. [7], to nd complete agreement in the spectra to the order  $3$ .

#### D -brane recom bination realized in Y ang-M ills 2

Parallelly placed multiple D-branes in type II superstring theories have super Yang-Mills theory as their low energy description [10]. The non-A belian structure stem s from excitations of strings connecting dierent D -branes (see Fig. 1). When an intersection angle  $(0 <$ ) is turned on, these strings get con ned to the intersection point so that the energy coming from the tension times its length is minimized. A part of the spectrum of the Neveu-Schwarz sector of this localized open strings was studied in Ref.  $[8, 11]$  giving

where n (0) is an integer, and is the intersection angle (= 0 corresponds to a coincident parallel D -branes, see F iq. 1). In this paper we treat the simplest case of turning on only a single intersection angle, while generically with higher dim ensionalD -branes wem ay consider m ore param eters for the angles.

 $Y$ Ref. [8] studied also the Y ang-M ills view point.

The important observation of Eq. (2.1) is that for  $n = 0$  the m ass squared becomes negative, and this is the tachyonic mode of our concern. Since naively the intersecting branes can be recombined and lower the total energy by shortening their lengths, it has been expected that the tachyonic mode  $n = 0$  is an indication of this recombination [5]. To show this mechanism explicitly is our aim of this paper.

#### F luctuation analysis of Y ang-M ills  $2.1$

In this expression we om it fem ions. The indices  $\;$  = 0;1 are worldvolume coordinates ;9 is for transverse directions in the bulk. This action describes the low while  $i = 2;3;$ energy dynamics of parallel two D-strings. The elds are decomposed into components by Paulim atrices as A =  $(1=2)^aA^a$  and a similar expression for ;, with the dention of the covariant derivative as

The boations of the D-strings  $Y^i$  are specied by the eigenvalues of the H iggs eld with the rescaling 2  $\degree$  i = Y<sup>i</sup>. In the following we turn on only Y<sup>9</sup> and om it the transverse index i.

The background representing the intersecting D-strings should be

Here x denotes  $x^1$ . It is obvious that this is a solution of the equations of motion for the action  $(2.2)$ . This solution breaks all the supersymm etries. Taking into account the rescaling factor 2  $\degree$ , one nds that the constant slope q is related to the intersection angle as

The brane con quration is shown in  $F$  ig. 1.

Let us proceed to the analysis of the uctuations around this background  $(2.4)$ . We tum on only  $A_1^2$  a and  $1$  'since other uctuation elds decouple from these, at the

We shall see that in each sector a tachyonic mode appears which is combined into a complex tachyon eld.

. Substituting the relation (into the m ass formula  $(2.11)$ , we nd that for  $n = 3; 5;$ it agrees with the string worldsheet spectrum (2.1) up to 0 ( $3$ ) ambiguity. In order to m atch two results to higher order in , we should have to adopt the non-A belian Bom-Infeld Lagrangian as a starting point. In appendix A, we include the rst nontrivial  $\degree$  corrections of order ( $^{0}$ )<sup>2</sup>F<sup>4</sup> from string theory, and showed that the uctuation spectrum agrees with the worldsheet result up to 0 ( $^5$ ) am biquity.

Our concem is the lowest mode  $n = 0$  which is tachyonic. Surprisingly, the eigen functions for this lowest mode is quite simple,

<span id="page-6-0"></span>The uctuation modes are localized at  $x = 0$  which is the intersection point, which agrees again with the worldsheet perspective. If is sm all enough, the above uctuation mode does not invalidate the low energy approximation of the D-brane action as Y ang-M ills theory, since the derivatives (involved with the string  $\degree$  corrections) acting on the uctuation give only sm all contributions. In this respect, the approximation is invalid for exceeding  $=2$ .

The fact that the eigen functions are G aussian is consistent with the T-dual results in Ref. [7] where the eigen functions are functions. The functions are roughly a sum m ation of periodically placed G aussian functions, and Ref. [7] considered D -branes w rapping a torus for the T-duality so the above localized eigenfunctions should appear periodically there.

#### $2.2.$ Realization of D-string recombination

Let us nd the constraint on the magnitude C  $C_0$  (t) of the tachyonic uctuation (2.12) rst. This is derived by requiring that the quadratic approximation is valid, that is, the term s quartic in uctuations are much smaller than quadratic terms. Straightforward calculation shows that in the original Yang-M ills Lagrangian the quadratic terms with eigen functions  $(2.12)$  are

This is the condition for that the approximation we adopted for the uctuation analysis is valid. The free eld equation (2.9) for C (t) is solved with an exponentially grow ing function

and our approximation is valid until this C (t) reaches the critical value  $P\frac{1}{q}$  as seen in  $Eq. (2.15).$ 

K eeping this condition in m ind, let us study the geom etric picture of the condensation of the tachyonic uctuation. The locations of the D-strings are specied by the eigenvalues of the H iggs eld  $\prime$ . We diagonalize the whole H iggs eld including the uctuation (2.12), as<sup>(</sup>

This con quration of D-strings is shown in Fig. 2. The intersecting D-strings are recombined! N aively it m ight have been expected that the recombination m ight be di cult to be realized in Yang-M ills theory since the boations of the D-strings are represented by the eigen values

and the recombination process must interchange two eigenvalues only in a half of the worldvolume  $(x < 0)$ . However this is possible, as seen in the above diagonalization, due to the gauge transform ation which was singular at  $x = 0$  originally before the tachyon condensation (the  $\text{Im } \pm C$  ! 0). So essentially the tachyon condensation resolves the singularity of the gauge transform ation and enables the interchange of the left \halves" of the D-strings (the  $x < 0$  region).

The intriguing point here is that the magnitude of the tachyon mode C corresponds just to the interbrane separation. This can be easily seen in Eq.  $(2.18)$  with  $x = 0$ . Therefore, in the D -brane recombination, the tachyon condensation is geometrically realized.

It is interesting to note that the condition  $(2.15)$  has the following geometrical meaning. From the expression (2.18) of the transverse displacement, we observe that when the tachyon develops the condensation and C becomes large enough, the D-string worldvolume em bedding is \waving" in the bulk (See Fig. 3). This situation is quite strange in the naive view of the energy m inimization in which the D-string energy would be given mostly as a tension times its length. The \wave" should be smeared. The requirement that this \wave" does not appear is equivalent to the condition that the function Y  $(x)$  (2.18) has only a single extrem um. This condition is easily evaluated as  $q > C^2$  which is satis ed by (2.15).

Before the con guration reaches this form, the nonlinear e ect of uctuations becom es important.

## 3 Large intersection angle and Sen's conjecture

In the previous section we showed that the recombination of the intersecting D-strings is realized in Yang-M ills theory, the low energy schem e of string theory. H owever as m entioned in the introduction, this phenom enon of recom bination should be related to the tachyon condensation of brane-antibrane system . The worldsheet picture  $(2.1)$  tells us that when = , the tachyon m ass squared reaches its lower bound  $\mathfrak{m}^2$  =  $\quad$  1=2  $^0$  which is well-known as that of tachyons whose condensation is conjectured to m ake the brane-antibrane disappear (the Sen's conjecture, see R ef.  $[6]$ ).

Then, how the disappearance of the brane-antibrane is related to the recom bination? The answer is found when we consider D-strings intersecting at large  $\,$ ,  $\,$  . For this large , the worldvolum e param etrization with x (the horizontalaxis) is not appropriate. Instead, we exchange the roles of x and Y  $(x)$ : now let us param etrize the worldvolum e of D-strings by  $y$ , the vertical axis. Then the displacem ent of the D-strings from this axis is measured by a scalar eld X (y) which was originally x (See the left of Fig. 4). One notices that in this param etrization, two D -strings becom e a pair of a D -string and an anti-D -string, since the orientation of one D-string is reversed com pared to the other, as is obvious in Fig.  $4$ .

The tachyonic m ode  $n = 0$  of [\(2.1\)](#page-3-1) rem ains at the origin and tends to be condensed. Since we have explicitly shown in the previous section that the condensation of thism ode is

equivalent to the D-string recombination, so assuming that even with large this equivalence is m aintained, the condensation of this tachyonic mode for large should provide again the recombination depicted in the right of  $F$  ig. 4. Rem inding of the fact that the natural parametrization of the work volume is y, we observe from this quie that around  $y = 0$ where the tachyon is localized the brane-antibrane has disappeared! We regard this as a qualitative veri cation of the Sen's conjecture on the tachyon condensation.

The single assum ption which we m ade in the argum ent above was that the identi cation of the uctuation mode  $(2.12)$  with the lowest mode of the worldsheet spectrum  $(2.1)$  is valid also for large  $\cdot$ . A lihough it is hard to in agine that this is violated, in the following we provide another evidence that the identication for large is valid.

For larger  $\,$ , the approximation adopted in the previous section is getting worse, and so we cannot use the Y ang-M ills approach. Hence we necessarily have to use alternative picture m entioned above, the worldvolume parametrization in term s of y. This brane-antibrane picture is di cult to be analysed since it needs stringy description with the energy scale  $\theta$ , such as string eld theories. However, we shall see that a very simple tachyon action derived from string scattering am plitudes turns out to be useful for our purpose. The tachyon two point function on a D p-antiD p pair is reproduced by the free theory

Here the tachyon eld is complex since the strings joining the D-strings are orientable. This tachyon is charged under a combination of the gauge elds,  $A$   $A^{(1)}$   $A^{(2)}$  where  $A^{(i)}$  is the U (1) gauge eld on the i-th D p-brane (i=  $1,2$ ). Taking this into account, the above action is generalized to be gauge-invariant,

For describing the nontrivial transverse displacement X (y) from the y axis, we make a  $T$ duality (dimensional reduction) in which X (y) is identi ed as a gauge eld, 2X (y) = 2  $\beta$ <sub>1</sub>. The resultant action is

This solution [\(3.5\)](#page-11-0) is expected to m odify the tachyon m ass squared and give the localization of the tachyon around  $y = 0$ . Let us check these. The realpart of the tachyon uctuation T around the solution [\(3.5\)](#page-11-0) is decoupled from other uctuations, and the Lagrangian for this uctuation is given by  $y$

which is localized at  $y = 0$ . Interestingly, this wave function of the tachyonic mode is precisely the sam e as that of the lowest uctuation of the Yang-M ills analysis  $(2.12)$ . This strongly suggests that the wave function of the tachyonic uctuation mode obtained in Yang-M ills schem e  $(2.12)$  is not deformed even for large. In addition, the tachyon condensation param eter  $\mathfrak E$  is expected to be proportional to C.

As we mentioned, other uctuations such as the scalar uctuation  $X(y)$  $X(y)$  $2 \tan (-2)$ y is decoupled from the tachyon uctuation. But once the tachyonic uctuation is condensed as  $(3.8)$  with nonzero  $\mathfrak{E}$ , this induces nontriviale ect on X. O ne can solve this backreaction to X (y) provided the tachyon condensation  $(3.8)$ . This gives some information on the brane disappearance around  $y = 0$ . The result is

Surprisingly, this form coincides with the Yang-M ills result  $(2.18)$  for large x as seen below. We expand  $(2.18)$  for large x as

The second term in Eq. (3.15) is of order C<sup>2</sup> due to the diagonalization  $(2.18)$ . To compare this with the tachyon picture, we had to consider the backreaction which is higher order in  $\mathfrak{E}.$ 

W ith the simple tachyon action  $(3.4)$  employed, we have shown various coincidence with the uctuation analysis of the previous section. It would be interesting to study this tachyon system more carefully, for example with use of the boundary string eld theory for braneantibranes. A trial along this direction is presented in Appendix B.

#### D ynam ical aspects of recombination: decay width 4

We have identied the tachyoniam odes which triggers the D-brane recombination and showed its signi cance in relation to the Sen's conjectures. In application to D -brane cosm ology for example, it is in portant to study how the time-dependent recombination process proceeds. This question is related to the recent developm ent on rolling tachyons [13], however our privilege is that we can use low energy description instead of fully following the worldsheet string theory. The recombination process itself is just the vacuum condensation of the tachyonic m ode  $(2.12)$ , however once the tachyon expectation value C (t) reaches its critical value  $\frac{p}{q}$ , the nonlinear e ect (or equivalently, higher order term s of uctuations) becomes in portant. A fler a while, the o -diagonalm odes of the stretched open string will decouple and the system will be dictated by a N am bu-G oto action for a D-string. The relative velocity between D-strings leaving each other will soon reach the speed of light (in our approximation of decoupling  $\lim$  in  $\lim$  of closed strings), as discussed in Ref. [14]. This is a geom etrical realization of rolling tachyon [13], since in the present case the m agnitude of the tachyon m ode is identical with the interbrane separation, as seen in Section 2.

In the argum ent above we started from intersecting  $D$  -strings, however this con quration is of course unstable and it is another question whether this is a reasonable initial condition to be started w ith or not. In the context of string cosm ology, it is expected that rstm any  $D$ branes are created in a hot universe and then they interact with each other by recombination. Therefore m ore physical initial condition m ight be non-parallelly separated D-branes.

In this section we present a naive estimation of the decay width of the non-parallelly separated D -branes. In fact the following process might be physically plausible: two  $D$ strings which are not parallel approach each other by gravitational and R am ond-R am ond forces, and just at the time when they intersect, the tachyon eld at the intersection point starts rolling down the potential hill and condenses to provide the recombination. However, as discussed in Ref.  $[14, 15]$ , before they intersect there should be a sm all probability for quantum tunnelling directly into the recombined nal state. For analysing this process, we place two D-strings apart from each other so that the open string connecting the two does not yet have any tachyonic excitation. We x the distance between the branes as in Fig. 5 for sin plicity. In this situation, the branes cannot approach each other and thus the decay

m ode is due to the quantum tunnelling  $e$  ect. W e generalize the com putation in Ref. [\[14\]](#page-23-4) to the case of the branes not only separated anti-parallelly but also tilted against each other. The intersection angle will appear in the decay width.

The quantum tunnelling isdictated by a bounce solution whose geom etric interpretation is the Euclidean worldvolum e deform ation of the D-string, that is, a form ation of a throat connecting the two D-strings. W hen =  $0$ , the D-strings are placed anti-parallelly, and the decay width can be evaluated in the following way: First, the decay width is the exponential ofthe on-shellEuclidean action,

where  $S_E$  is the action into which the throat (volcano) solution of the worldvolume eld theory is substituted (see R ef.  $[16]$  for this type of solutions). The throat action is evaluated easily as

where d is the distance between the branes, and R is the radius of the throat. The rst term is from the area of the cylinder (throat), and the second term is from the areas of the cap and the bottom of the throat which are holes and thus give a negative contribution. The throat radius R can be determ ined by extrem ization of the action  $S_{E}$  as

Thus a trivial result is that when the distance between the two becom es large, the decay width by a form ation of a throat is exponentially dum ping, as  $exp(-\frac{\pi}{4}d^{p+1})$ .

Now let us introduce the intersection angle to the system. It is expected that the location of the throat form ed by the tunnele ect is unique, at the intersection point. One way to explain this is that, from the geometrical point of view,  $\ddot{\mathbf{r}}$  is unlikely for the throat to be form ed far from the intersection point since it needs extra energy to create it (in other words, the potential barrier is higher). A nother way to explain this is that the string connecting the two is boalized around the intersection point, as seen from both the Yang-M ills picture and the tachyon picture studied in the previous sections.

So here we simply assume that the throat is formed at the intersection point (though they are not actually intersecting but separated by d). Further assumption is that the cylinder is squeezed and become elliptic due to the boalization of the string. We assume that the horizontal section of this cylinder which was a circle for  $= 0$  is deformed to be an ellipse,

This result shows that a larger gives a sm aller probability of the throat form ation.<sup>x</sup> This result is consistent with the observation that, a system closer to a supersymmetric con quration of parallel parallel two D -strings  $( = )$  is m ore stable so the m ost unstable system should be the parallel D 1-antiD 1 con guration  $($  = 0). A s increases, the tachyonic instability of the system decreases and thus the throat nucleation probability should decrease accordingly.

W enote here that we cannot com pare the above result with the case with exactly vanishing , since  $= 0$  case gives a probability per a unit world volum e of D-strings while in our

present case the form ation occurs only at the intersection point. So the physicalm eaning of the resultant decay width is dierent from the  $= 0$  case.

The width we have found here is very an all, since we are working in the decoupling lim it  $q_{\text{string}}$ ! 0. This is potentially due to the fact that the distance between the D-strings is xed. O ne of the other possibilities of the initial conditions is to consider D-strings approaching each other with a constant relative velocity  $v$ . If this  $v$  is small enough, there should be enough long period for the D-strings to be recombined by developing the tachyon condensation. The period during which the tachyonic mode is present is evaluated as  $\frac{1}{2}$ <sub>ring</sub>=v. The condensation should start by a quantum uctuation studied in Ref. [17], whose characteristic time is roughly  $\frac{1}{2}$  hence we expect that the D-strings recombination occurs when  $2 > V$ .

#### 5 Future directions

The mechanism of the recombination of the intersecting D-branes provided in this paper is quite simple, basically due to the fact that we can employ low energy approximation of the D -brane dynam ics which is the super Y ang-M ills theory. Therefore we expect that it is possible to apply the recombination mechanism presented in this paper in many directions which include (i) study for form ulating string/M-theory in term s of higher dimensional Dbranes as fundam entalob jects, (ii) veri cation of the Sen's conjectures using various schem es, and (iii) string phenom enology based on intersecting branes, and brane cosm ology.

As for (i), the rst step m ight be to generalize the present analysis to higher dimensional D -branes.<sup>{</sup> For exam p.le, D 2-branes intersecting in  $T^4$  can be supersymm etric with a certain relation of two intersection angles  $[8]$ . It is interesting to see this phenom ena in term s of low energy Yang-M ills theory.

Regarding (ii), since there has been vast am ount of literature concerning the Sen's conjectures, the relation between those and our mechanism should be explored further. We may tum on the intersection angle for example in the scheme of cubic string eld theories or boundary string eld theories, which will help to clarify the relation. On the other hand, our analysis shows that the tachyon condensation of brane-antibrane can be seen by the Yang-M ills theories, which suggests that they can describe various phenom ena associated with the tachyon condensation, such as the brane descent relations and creation of lower-dimensional D -branes. Furtherm ore, it m ight be possible even to describe all the tachyon condensation processes by (generalizations of) Y ang-M ills theories. For example, non-BPS branes de ned

as unstable defects in tachyon condensation of brane-antibrane can also be described in our Yang-M ills scheme, and this m ight be the case also for the rolling tachyons [13] and associated S (pacelike)-branes [19] whose deform ations describe creation of lower dimensional defects [20]. In our realization, the rolling tachyon is realized geom etrically as recombined D -branes leaving each other. The rolling tachyon in the present case should be described by a D irac-Born-Infeld action in which the scalar eld is identi ed with the tachyon, as seen in Section 2. This m ight give a path to justify the tachyon action of Ref.  $[13]$ .

F inally, there should be much possibilities for application to phenom enology and cosm ology (iii) since now adays intersecting branes are considered to be an e ective way of realizing ourworld on branes. Recombination of topological defects has been largely studied especially in the context of cosm ic string network form ation in cosm ology [21]. In string theory, BPS D -branes can be realized as topological solitons in unstable D -branes with tachyons, based on the Sen's conjectures [6] on tachyon condensation. This view point realizes the form ation and time evolution of D -brane networks in the early universe, and the clari cation of the recom bination mechanism in this paper will help analysing phenom enological parameters. We hope that our research m ay be the rst step to mediate between the string phenomenology and the tachyon condensation in string theory.

### H igher order in and N B I corrections A

Here we discuss how the higher order terms in in the string theory spectrum  $(2.1)$  can be reproduced from the non-Abelian Bom-Infeld action. The rst nontrivial corrections to the Y ang-M ills theory appear as F<sup>4</sup> term s in a symmetrized trace  $[9]$ ,

The Lagrangian with the transverse scalar elds can be obtained simply by T-dualities (dim ensional reductions). So, up to the overall factor which is irrelevant for the uctuation analysis, the di erence between the present corrected Lagrangian and  $(2.6)$  is only that the m ass squared will be multiplied by a factor appearing in the second line of Eq.  $(A, 9)$ . This coincides with the worldsheet result  $(2.1)$ , up to 0 ( $^5$ ) am biquity.

If we assum e that the action is given by the symm etrized trace at order  $F^6$ , we can soon nd that them ass spectrum is incorrect as was shown in Ref. [7]. The non-A belian BI action at order  $F^6$  was proposed in some articles [22] and we can use our uctuation analysis for the rst nontrivial check of their  $F^6$  term s [23].

#### Tachyon m ass squared to higher order in  $\overline{B}$

In this appendix, we present a trial to obtain higher order corrections to the tachyon m ass eigen values obtained in Section 3. To proceed, we somehow assume the form of the higher order coupling in the tachyon-gauge system of the brane-antibrane. A trial is the following action with the higher correction of gauge elds,

This action is the generalization of a non-BPSD-brane action to the brane-antibrane system. The antisym m etric part of D  $_{a}$ T D  $_{b}$ T is dropped by the reality condition.
