Boundary States for D-branes with Traveling W aves

Abstract

We construct boundary states for D-branes which carry traveling waves in the covariant form align. We compute their vacuum amplitudes to investigate their interactions. In non-compact space, the vacuum amplitudes become trivial as is common in plane wave geometries. However, we found that if they are compactied in the traveling direction, then the amplitudes are a ected by non-trivial time dependent e ects. The interaction between D-branes with waves traveling in the opposite directions (bulse-antipulse scattering') are also computed. Furtherm ore, we apply these ideas to open string tachyon condensation with traveling waves.

1 Introduction

String theory on plane wave geom etries [1] has many interesting features. In particular, the maxim ally supersymmetric plane wave solution to type IIB supergravity is found in [2], and superstrings on this background can be exactly solved in the light-cone G reen-Schwarz formalism even in the presence of RR - eld [3]. This background attracts much attention also because we can discuss its Y ang-M ills theory dual [4].

A plane wave in D dimensional spacetime is generally de ned by the metric (in the Brinkman coordinate)

and it is time dependent via the term $h_{ij}(x^+)$. Physically, this term represents the traveling gravitational waves. Furtherm ore, the background preserves at least a half of supersymmetries. Thus, it may lead to a solvable time dependent model with supersymmetry [5]. (Refer to [6, 7] for null orbifolds, which have similar properties.)

However, we have also a disadvantage that we do not know well how to quantize covariantly string theory in general plane waves¹. For example, it is not completely unambiguous how to compute even the cosm ological constant (i.e., vacuum amplitude).

M otivated by these observations, we would like to discuss the open string analogue of strings on plane waves. In particular, we consider the D-branes with traveling waves in at space; either waves of gauge elds Aⁱ(x^+ ; x^i) or transverse scalar elds ^I(x^+ ; x^i), which are related to each other by T-duality. Indeed, we can show that open string m etric on a D-brane with such gauge elds leads to a metric of a pp-wave (or plane wave if we choose the speci c pro les of Aⁱ(x^+ ; x^i)) and that it is a 1/4 BPS state. We can choose any functions of x^+ as gauge elds or scalar elds while preserving boundary conform al symmetry as noticed in [11, 12]; for instance, we can consider a D-brane with a pulselike world-volum e. Recently, this con guration was examined in the nice paper [13] (see also [14] for more generalized models) in the light-cone gauge of open string, where the world-sheet theory is manifestly time dependent. There are also some earlier discussions on the related or analogous backgrounds, see [15, 16] for strings with traveling waves, and [11, 17, 18] for null intersection of D-branes.

It is useful to apply the covariant quantization in order to extract inform ation intrinsic to the time dependent physics, and hence we construct the boundary states representing

the D-branes with traveling waves in the covariant form alism and exam ine their properties. These are new type of boundary states in at spacetim e with in nite parameters. Furtherm ore, we compute vacuum amplitudes in non-compact and compactified at spacetime, where the closed string theory is very simple. In the non-compact case we indicate trivial result and indeed it is the same as that of usual D-brane. This means that the interaction between the D-branes is the same as the usual D-branes, which is consistent with the fact that there is no vacuum polarization in plane wave background [19, 20]. On the other hand, if we compactify the traveling direction, then we obtain a very non-trivial amplitude, which rejects the time dependence of traveling waves. We also compute the interaction between two waves (or pulses) traveling in the opposite directions. It is possible to calculate it only in the covariant form alism. We argue that the collision m ight lead to open string pair creation like [21] as well as open string tachyonic modes. Finally, we apply these methods to the open string tachyon condensation [22]. A con guration with traveling open string tachyon is considered, and the corresponding boundary state is constructed.

The organization of this paper is as follows. In section 2 we construct the boundary state for the D-brane with traveling waves and compute the vacuum amplitude. By using this boundary state, we also compute the energy momentum tensor. In section 3 we consider the D-branes with traveling waves wrapped on a circle and compute the vacuum amplitude. In section 4 we discuss more general con guration with traveling waves depending also on the other world-volum e coordinates. In section 5 we consider the interaction between two waves traveling in the opposite directions. In section 6 we discuss the application to open string tachyon condensation. In section 7 we give a brief summary of our results and draw conclusions.

2 Boundary States for D-branes with Traveling W aves

There are gauge elds A^{i} and transverse scalar elds ^I on D-branes as massless bosonic elds. The tim e dependent expectation values of these elds give interesting time dependent D-brane backgrounds. Since there is a duality among open string and closed string in string theory, this will also lead to an intriguing in uence on closed strings. We would like to investigate this issue in simple examples of D-branes with traveling waves. In this background, gauge elds or transverse scalar elds depend only on x^{+} and describes waves on D-branes which are traveling at the speed of light. Interestingly the pro les of waves can be chosen arbitrarily as we explain in the boundary state form alism. Intuitively we can understand this by the fact that the operators included in $A^{i}(X^{+})$ and ^I(X^{+}) (or $\frac{1}{n}$) have no non-trivial commutation relations with each other [11, 13]. Below we construct boundary states for D-branes with gauge eld waves Aⁱ(x⁺) and discuss their physical properties. The results for D-branes with transverse scalar waves can be obtained by T-duality. More general forms of gauge elds will be considered in section 4.

2.1 Preparations and Conventions

In this paper we de ne the mode expansion of closed string in non-compact spacetime as

where the closed string X (;) has the periodicity under ! + . The commutation relations are

and the other commutators vanish. In compactined cases (on a rectangular torus with radii R) we should add winding term $2R \approx 10^{-10}$ to the mode expansion (2.2).

We de ne the coherent state jki (including only massive modes [23]), which is useful to construct the boundary state with non-zero gauge ux, as follows (here we suppress the index in $_{n}$)

Then the D irichlet boundary state \hat{D} ; xi located at x is simply given by $\dot{\mathbf{x}} = 0$ i $\dot{\mathbf{x}} \mathbf{i}_{(0)}$. The state $\dot{\mathbf{x}}\mathbf{i}_{(0)}$ m eans the zero-m ode part of the boundary state and it is norm alized such that $h\mathbf{x}\mathbf{j}\mathbf{x}^{0}\mathbf{i}_{(0)} = (\mathbf{x} \quad \mathbf{x}^{0})$. The N eum ann boundary state, i.e., D 25-brane, is given by the integral

where the norm alization constant T_p (for the D p-brane) is given by $T_p = 2^{7 p} \frac{23}{2} p \frac{011 p}{2}$. The norm alization T_p is xed by making use of the open-closed duality (C ardy's condition [24]). In other words, we have²

where H_{o} is the open string ham iltonian. In the compacti ed case we only have to replace $\dot{\mathbf{y}}_{i(0)}$ with $\begin{bmatrix} P & 1 \\ w = & 1 \end{bmatrix}$; $\dot{\mathbf{y}}_{i(0)}$, where w is the winding number of the compacti ed direction.

We should mention that even though in this paper we always use boundary states in the (Lorentz) covariant form alism (for a review, see [25]), we suppress the ghost part because it has the usual form

The generalizations to the sim ilar boundary states in superstring theory are also possible in a rather straightforward way (see, e.g., [23, 26, 27, 25]). A lthough in this paper we will mainly show the calculations in bosonic string theory, most of the results can be easily extended to the superstring cases (as we will mention later)³. Thus we om it the details of boundary states in superstring theory for simple expressions.

2.2 Construction of Boundary States

Now we would like to construct the boundary states for D-branes with traveling waves. For simplicity we will mainly consider the spacetime lling D-brane (D 25-brane) with gauge elds $A_i(X^+)$ (i = 1;2; ;24) in our arguments below. The corresponding boundary state, which is denoted as P i, satis as the following boundary conditions⁴

N aively, we can construct the boundary state \mathcal{P} i by multiplying the Neum ann boundary state \mathcal{N} i by the W ilson line, i.e.,

where P denotes the path ordering.

The boundary state must satisfy the boundary conform al invariance

where L_n and L_n are V irasoro generators on the at background. Form ally it is easy to show that \mathcal{P} is satisfies eq.(2.11). However, we should take a great care since the naive expression (2.10) would be divergent. We can avoid the divergence by using the renormalization scheme, however it breaks boundary conformal symmetry in general.

Therefore, we should check whether there are divergences or not in the form al expression (2.10), and we can easily exam ine it by using the boundary state in the path integral form alism [23]. Expanding the gauge eld as⁵

Since $A^{i}(X^{+})$ does not depend on x_{m} , we can integrate over x_{m} and obtain the delta functions (x_{m}^{+}) . Therefore we get the nite result after the integration over x_{m}^{+} (or equally only zero-mode integral dx_{0}^{+}). Then we not that the state (2.10) satisfies the boundary conform all invariance (2.11) including renorm alization. We can also understand it in the context of the boundary conform all eld theory (see appendix A). It is also straightforward to construct the sim ilar boundary state in superstring theory.

2.3 Energy-M om entum Tensor from Boundary State

In this subsection, we compute the energy-momentum tensor and B - eld charge from our boundary state and compare them with the results obtained in [13] as a consistency check. As discussed in [28] if we expand a boundary state β i for D p-brane as

Let us apply this method to our boundary state (2.13). It is convenient to use the oscillator representation of \mathcal{P} i obtained by performing integral in eq.(2.13); that is

where we set K = 1 such that the value of energy m om entum tensor with $A^{i} = 0$ agrees with that on the at background. Performing T-duality, we can show that the results reproduce the ones in [13] computed by using DBI action.

2.4 Vacuum Amplitude in Non-compact Space

O ne of the most interesting physical properties we can read from the boundary states is the interaction between these D -branes. This can be computed as the vacuum amplitude, which can be directly calculated in our boundary state form alism. A swe will see below the result turns out to be rather trivial in the non-compact spacetime.

Let us consider the amplitude between two spacetime lling D-branes with traveling waves of gauge elds $A_i^{(1)}(x^+)$ and $A_i^{(2)}(x^+)$. We only have to evaluate the cylinder amplitude

where $\mathcal{P}^{(1)}$ i and $\mathcal{P}^{(2)}$ i represent the boundary states of the form (2.13) for two di erent D-branes. We have also de ned the propagator of closed string as

where H_{cl} denotes the closed string ham iltonian. Then it is easy to see that the massive oscillators ${}^{+}_{n}$ (n 1) included in Aⁱ(X⁺) do not contribute to the amplitude since they cannot be contracted with ${}_{n}$. This makes the calculation very simple and indeed we nd that the amplitude is the same as that of usual D-brane in the at space. To see this, note that there is no zero-m ode contribution to A_{m}^{i} (m \notin 0) in (2.17). A lm ost the same result can also be obtained for traveling waves of transverse scalar elds ${}_{i}^{(1)}(x^{+})$ and ${}_{i}^{(2)}(x^{+})$. The only di erence is that we have an additional factor exp[$\frac{2 \cdot 2 \cdot 0}{s} ({}_{i}^{(1)}(x^{+}) - {}_{i}^{(2)}(x^{+}))^{2}$], which represents the time dependent winding energy between the two di erent D-branes (for details, see (3.21) in section 3.3).

These simple results (and their analogous results of closed strings in plane wave backgrounds⁶) correspond to the stringy version of the known fact that there are no particle creations and vacuum polarization in Yang-M ills or gravitational plane wave background [20, 19]. However, things will be di erent due to winding modes if we com pactify a spatial coordinate in the light-cone direction on a circle as we will see in the next section.

For the plane wave background with RR- eld §], a similar result seems to be di cult to show since there is no solvable covariant form alism (see [31] for a relevant discussion in the operator form alism in the light-cone gauge). Nevertheless, there are some evidences for the triviality of partition function constant [32, 33]. On the other hand, after we com pactify a spatial coordinate $y (= \frac{1}{2}x^+ - x^-)$, the partition function can be non-trivial as known in the NSNS plane wave [30] (see also [34] for DLCQ com pactic cation of plane wave). Indeed our results of open string analogue of plane waves have a similar property as we will show later.

3 D-brane with Com pacti ed Traveling W aves

A swe have seen above, the vacuum amplitude between D-branes with traveling waves in at space turns out to be trivial. On the other hand, if we study the open string spectrum in the light-cone gauge [13], then we get the non-trivial time dependent worldsheet dynamics. This is because the boundary interaction R d Aⁱ (X ⁺)@ X_i becomes time dependent linear interaction after we impose the light-cone gauge X ⁺ = x⁺ + 2 ${}^{0}p^{+}$ with non-zero p⁺. W hy is there such a di erence between these two analyses of the same system? The answer is that the state with non-zero p⁺ cannot be (easily) expressed in the boundary state form alism since in the closed string channel the non-zero p⁺ sector corresponds to the non-zero winding sector, which does not exist in our non-com pact space analysis.

In order to see the time dependent e ects from the closed string view point, we compactify the y direction (here we assume the coordinates $x^+ = t + y$ and x = (t - y)=2) and study the corresponding boundary state. Mainly we consider the traveling waves of gauge elds on the spacetime lling brane (D 25-brane) in bosonic string theory. Later we will also give the results in the transverse scalar case and superstring case brie y. We assume that the gauge eld $A_i(X^+)$ obeys the periodicity

3.1 Vacuum Amplitude

Let us consider the vacuum amplitude between two such spacetime lling D-branes. Since the operators $_{n}^{+}$ (n \in 0) commute with each other, we again conclude that only zero-modes on A_{m}^{i} in the boundary state (2.17) contribute to the vacuum amplitude. By dividing (3.2) into zero-modes x^{+} ; w and massive modes $_{n}^{+}$, we obtain

In the non-compact case (i.e., w = 0), it is easy to see that the zero-m ode term in A_m^i is zero except form = 0 as we have seen in the previous section. Thus we could e ectively regard the boundary state as the usual one N i in the computation of vacuum amplitude.

However, in the compacti ed case an interesting thing does happen. The zero-mode term s in A_m^i are given by

Thus in the computation of vacuum amplitude we electively obtain a novel form of boundary state, neglecting the massive modes $\frac{1}{n}$ (n \in 0),

which gives a di erent weight to each winding sector. (Notice that the sum over w is implicitly hidden in N i.) The presence of the exponential factor $\exp(jwj)$ leads to the suppression for the sectors with large winding number. This will be interpreted as the damping behavior of open string in the time dependent background. The second term in the exponential in (3.5) represents the linear interaction of open string, which is obvious from the form of the boundary interaction.

Now let us compute the amplitude between a D 25-brane with gauge $ux A^{(1)}(x^+)$ and another with $A^{(2)}(x^+)$. Employing the form ula

It is also possible to generalize these results to the vacuum amplitude between two such D-branes in superstring theory. We can employ a similar argument on decoupling of massive modes, and in conclusion we only have to replace the modular function $\frac{e^{2s}}{e^{1} e^{2m} s^{24}}$ (is=)²⁴ in (3.7) by the familiar term s with theta-functions

Therefore the vacuum amplitude vanish due to the supersymmetry. This is consistent with the fact that each of the D-branes with traveling waves preserve the same eight supersymmetries. If one wants to see a similar non-trivial time dependent e ect even in superstring theory, he or she should consider a brane-antibrane system. The vacuum amplitude can be obtained by just changing the sign in front of $_2$ (is=)⁴ in (3.10). In this case the amplitude does not vanish and a non-trivial interaction is left.

3.2 Physical Interpretation of Vacuum Amplitude

Now let us consider the physical interpretations of our vacuum amplitude (3.7), which represents the interaction between two D-branes with traveling waves. In many familiar examples, we can perform modular transformation s = -t and express the amplitude in the open string channel (see also (2.7)). In our case, how ever, the modular transformation seem s very di cult to perform. A ctually, this is natural because we know that the world-sheet theory is time dependent (for non-zero p^+) in the open string side, and the open string cylinder amplitude should become complicated. Nevertheless, we can extract some information from our amplitude computed in the boundary state formalism by taking the IR limits ! 0 of the open string (on the other hand, s ! 1 corresponds to the IR limit of closed string).

First let us consider the IR limits ! 1 of closed string (UV limit t ! 0 in open string side). In this case the important exponential factor becomes

Thus we have no interaction between the two waves of gauge elds A ⁽¹⁾ and A ⁽²⁾ since there is no mixing term like $c_n^{(1)i}c_n^{(2)i}$. This is natural because the closed string propagates for a long distance. Note also that the interaction for the winding sectors is suppressed by the presence of the waves on D-branes. In the case with a strong pulse $P_{n=1}^{1} n j c_n f_{n}^{2}$ (⁰) ¹, no winding mode will propagate between the D-branes.

On the other hand, in the UV limits ! 0 of closed string (IR limit t ! 1 of open string), the interaction of two waves becomes strong as can be seen from the non-trivial factor (for $w \in 0$)

This means that the interaction is suppressed for the winding sectors except for the case $c_n^{(1)i} = c_n^{(2)i}$ (the interaction between the same D-brane). This is much like a mass shift $m^2 = 2 \begin{bmatrix} 1 & 1 \\ n=1 \end{bmatrix} \frac{1}{2} \begin{bmatrix} c_n^{(1)i} & c_n^{(2)i} \end{bmatrix}$ due to the time dependent W ilson-lines.

Consider the interaction between the same D-brane. Then, the contribution from the leading order (3.12) vanishes and the rst non-trivial correction to (3.12) is given at the order $0 \ (w^2 s)$. Combining the rst factor in (3.7), this correction can be regarded as the shift of radius

It would also be interesting to ask what will happen if we take R ! 0 lim it. For the usual D 25-brane (i.e., $c_n = 0$), we will obtain a D 24-brane by T-duality, under which the

winding mode is identified with the momentum such that $P_y = wR$. The momentum P_y could be nite under the limit R ! 0 by taking w ! 1 with keeping the combination wR nite. On the other hand, if we naively T-dualize our D 25-brane with traveling waves in the limit, then we get a 'exotic' D 24-brane with only $P_y = 0$ sector in the boundary state since the contributions from the large w sectors are suppressed as mentioned around eq.(3.5). This means that the D-brane conguration is smeared along the y direction (this might be natural since the pulse originally runs in the y direction). However, in a physical theory, only nite energy congurations of gauge elds are allowed. This condition is estimated (assuming a weak gauge eld) as follows⁸ (for a nite gauge coupling)

Therefore we can see that a D 25-brane with a nite energy pulse becomes an ordinary D 24-brane after T-duality transform ation.

5 Interaction of Pulse and Anti-Pulse

Next let us proceed to a more com plicated and intriguing example, i.e., the interaction between two waves of gauge eld $A^{i}(X^{+})$ and $A^{i}(X^{-})$ traveling in the opposite directions (see g.1). In contrast with the previous exam ples, we expect non-trivial particle creation

in this example since there is no symmetry in the null direction. Thus this conguration leads to a more interesting time dependent elect.

Since we can use any form of gauge elds $A^{i}(X^{+})$ and $A^{i}(X^{-})$, we choose the ones of pulse-like form. In this case we can regard this physical setup as a collision between pulse P⁺ and anti-pulse P . In superstring theory, P⁺ and P preserve di erent types of eight supersymmetries, and hence the presence of both leads to a non-supersymmetric system. Thus this system is expected to be unstable and will tend to decay when the two pulses are approaching. If the decay occurs completely, it will eventually becomes the supersymmetric system of two overlapped D-branes with no gauge ux. However, we cannot deny the possibility that the annihilation of the pulse and anti-pulse takes place partially and smaller pulses remain.

The vacuum amplitude of this system can be computed in our boundary state form alism and is non-trivial even in non-compact space as we will see below. A notherm otivation to study this system is that the system is the open string analogue of collision of planewaves as it is di cult to compute in closed string. A loo it seems impossible to compute it in open string in the light-cone gauge. Thus this example is an interesting application of our boundary state form ulation.

5.1 D-branes with Constant NullFlux

Before we discuss the general system, we would like to exam ine a 'toy model', i.e., two (spacetime lling) D-branes $f^{+}i$ and $f^{-}i$ with constant gauge ux F_{+i} and F_{-i} , respectively (or $A_{i}(X_{-}) = F_{-i}X_{-}$). Essentially cylinder amplitude has already been computed in [37] by using the analytic continuation of the light-cone boundary state (see also [38] for open string spectrum and refer to [39] for an earlier literature) in the context of BPS brane-antibrane system [40]. Here we will exam ine it by using the covariant boundary state and clarify the physical phenom ena especially for non-supersymm etric cases.

Note that we cannot reduce this system to well-known case of (purely) magnetic or electric ux [36, 21] by Lorentz transformation. For simplicity we assume that only $f_{+} = 2 \quad F_{+1}$ and $f_{-} = 2 \quad F_{-1}$ are non-zero. Then, the boundary states F_{-} i should satisfy the boundary conditions

We can see from (5.6) and (5.7) that there are in nite number of poles from the factor $\sin (2 \ i \ t)$ for in aginary values of $((f, f \ 1)^2 > 1)$. This is very similar to the physics on D-branes with (purely) electric-eld [21]. Thus, for in aginary , the integration over t leads to the in aginary part of the amplitude, and hence open string pair creations should occur. Notice that takes an in aginary value when $f_t f < 0$. This is intuitively natural because the electric elds on two D-branes have the opposite sign. On the other hand,

takes a real value for $0 < f_+ f < 2$ and the spectrum includes open string tachyons induced by the gauge ux. Thus open string tachyon condensation should occur in this case. In the other case $f_+ f > 2$, becomes in aginary and we observe pair creations.

At the one critical point $f_+ f = 0$ (= 0) the spectrum is the same as the usual D-brane since the gauge eld F_{+i} (or F_{-i}) does not polarize the vacuum as we have seen above. We also have the simplified spectrum at the other critical point $f_+ f = 2$ (= 1). The amplitude (5.7) between branes (= 0) is the same as that of a brane-antibrane without gauge ux, while that between brane and antibrane (= 1) is the same as the usual supersymmetric amplitude between branes. The latter corresponds to (a generalization of) the fact found in [40] that a brane-antibrane system with the critical electric ux and opposite sign of magnetic ux becomes supersymmetric.

In sum m ary, the system of two D-branes with constant $ux f_+$ and f is unstable in general and should decay via either open string pair productions or open string tachyon

condensation¹¹.

5.2 Pulse and Anti-Pulse Scattering

Now let us turn to the main issue of computing the interaction (or equally vacuum amplitude) of pulse and anti-pulse. For simplicity we show only the result in bosonic strings. The result is not changed substantially even in superstring theory. The boundary state for a pulse \mathcal{P}^+ i is given by (2.13) and that for an anti-pulse \mathcal{P}^- i is simply given by replacing $\frac{1}{n}$ in (2.13) with $_n$. For anti-pulse, we denote the integration as dy_m dy m to avoid a confusion. Then, the vacuum amplitude is de ned as

In the large s lim it we can regard this as the closed string exchange between two D -branes. For example, the contribution from m = 1 or n = 1 part in (5.11) represents a massless eld exchange.

Furtherm one, we can also get the fullorder result with respect to $\sqrt[12]{2} + A_i(x^+) + A_i(y)$ by neglecting higher derivatives, and the result is simply given by the previous form ula (5.5). We should note that the value of depends on x^+ , y via $F_{+i}(x^+)$, $F_i(y)$ and we should also make the integration $dx^+ dy$ explicit. Thus, in this approximation, the previous result of toy model (with only constant ux) can be utilized. Since the pulses, in general, have both positive and negative values of gauge ux depending on the time e and position, the collision of pulse and anti-pulse may lead to both open string creation and open string tachyon condensation. These phenom ena happen when the pulses approach, and the both e ects should cause the decay of the system at least partially. A part of the energy may be carried out by the radiations (closed strings). It is an interesting future problem to not the exact end point of this unstable system for arbitrary pulses.

6 Traveling Tachyonic W aves

In a brane-antibrane system, there is an open string tachyon eld and we can consider D-brane con guration with a non-trivial tachyon pro le [22]. It was shown in [42] that a non-BPS D-brane can be described by a tachyonic kink on a brane-antibrane pair by using conform all eld theory and later it was con med in [43] by using boundary state form alism ¹². In the previous analysis, we only include the non-trivial gauge elds depending on one of the light-cone directions x^+ . The con guration with x^+ dependent tachyon is also an interesting system, which we analyze in this section. As the S-brane [47] or rolling tachyon [48, 28] gives an important time dependent system in string theory, our traveling tachyonic wave (or 'hull tachyon') may lead to another one.

Let us consider D 9-brane and anti-D 9-brane wrapped on a torus with radii R for y direction and R^1 for x^1 direction and include Z_2 W ilson line on the anti-D 9-brane. In this con guration the tachyon on a open string stretched between two branes has an anti-periodic boundary condition and an mode expansion

We have assumed that the tachyon has no dependence of x (and also the transverse directions except for x^1 direction). When we restrict the radius to $R^1 = p - \frac{p}{-2}$, the tachyon of the form

It is known that when $t(x^+) = 1=2$ and $Y^1(x^+) = 0$, the D9-brane anti-D9-brane pair with the tachyonic kink is equivalent to a non-BPS D8-brane [42]. The position of the non-BPS D8-brane corresponds to the point of $T(x^+;x^1) = 0$, thus, in particular, the con guration with $t(x^1) = 1=2$ and non-zero $Y^1(x^+)$ describes non-BPS D8-brane at $x^1 = Y^1(x^+)$ just like the D-strings in subsection 3.3. From now on we set $Y^1(x^+) = 0$ for simplicity.

The D 9-branes on a torus with radii R and R 1 in the type IIB superstring theory can be described by the boundary states

Therefore, we conclude that the conguration with a traveling open string tachyon can be analyzed in the way similar to the ones with traveling gauge elds. For example, the amplitudes between these boundary states can be calculated as we have done in (3.7).

7 Summary and Conclusions

In this paper we have investigated several properties of D-branes with traveling waves in the covariant boundary state form alism. The traveling waves are carried by gauge elds or transverse scaler elds. Interestingly, the boundary states have a novel feature that they have in nitely many parameters, which describe every form s of traveling waves.

Employing the boundary states and computing their vacuum amplitudes, we analyzed the interactions between these D-branes. We found that in non-compact spacetime the interactions are the same as those between usual D-branes. However, in the compactied case the interactions turn out to be very non-trivial and they depend on the form of the waves explicitly. The non-trivial contribution comes from winding modes of closed strings in the compact space, as we can see it directly in the boundary state. In this way we found that the time dependence a ects the interaction between D-branes with traveling waves if we compactify the space in the traveling direction.

We also generalized the form of waves such that the waves depend on the spatial coordinate other than x^+ , and obtained the vacuum amplitude in a simpli ed case. In the example, the open string metric on the D-brane becomes that of a plane-wave not of a general pp-wave.

By using our form alism it is also possible to compute the interaction between two D-branes with waves traveling in the opposite direction; the conguration seems dicult to analyze in the light-cone gauge. This leads to an interesting non-supersymmetric time dependent system in superstring theory. In particular, we can choose the form of wave such that it represents the collision of pulse and anti-pulse. We obtained the integral form ula of the vacuum amplitude and argued that the open string creation or tachyon condensation may occur and it may lead to a (partial) decay of this unstable system.

Finally we considered the application of these traveling wave con gurations to the open string tachyon condensation. We obtained a new boundary state which represents the traveling tachyonic waves.
