# SO(4) Monopole As A New Topological Invariant And Its Topological Structure

By making use of the decomposition theory of gauge potential, the inner structure of SU(2) and SO(4) gauge theory is discussed in detail. We find the SO(4) monopole can be given via projecting the SO(4) gauge field onto an antisymmetric tensor. This projection fix the coset  $SU(2)/U(1) \otimes SU(2)/U(1)$ of SO(4) gauge group. The generalized Hopf map is given via a Dirac spinor. Further we prove that this monopole can be consider as a new topological invariant. Which is composed of two monopole structures. Local topological structure of the SO(4) monopole is discussed in detail, which is quantized by winding number. The Hopf indices and Brouwer degree labels the local property of the monopoles.

#### I. INTRODUCTION

It is generally believed, as conjectured by Mandelstam [1] and 't Hooft, that magnetic monopoles are essential for confinement in QCD and related gauge theories. For example, compact QED with a lattice cut off is known to be exactly dual to a Coulomb gas of monopoles, which upon condensation causes confinement via a dual Meisner effect [3]. Similarly there is evidence for the role of monopole condensation in the 3-d Yang-Mills-Higgs (or Georgi-Glashow) model [4] and in 4-d N=2 supersymmetric Yang-Mills theory [5].

Magnetic monopoles arise when the Higgs configuration has non-trivial topology at spatial infinity. For a theory with gauge group G broken into residue group H, topologically non-trivial configurations are possible when the second homotopy group of vacuum manifold, namely  $\Pi_2(G/H)$ , is non-trivial. Lots of works are done to understand the structure and the metric properties of monopole solitons. In order to search for a so-called non-propagating gauge condition in the non-Abelian theory, 't Hooft [2] suggest that one should use some tensor X, that transforms covariantly under a gauge transformation  $\Omega$ :

$$X' = \Omega X \Omega^{-1}.$$

The eigenvalues of X are gauge invariant. One can search a gauge in which X is diagonal

$$X = \begin{pmatrix} \lambda_1 & 0 \\ & \ddots & \\ 0 & & \lambda_N \end{pmatrix}.$$

This gauge condition produces singularities. The singularities occur when two or more eigenvalues coincide. The nature of these singularities depend on the gauge group. When the gauge group is SU(N) in the gauge (2) there are singularities, namely if two eigenvalues  $\lambda$  of X coincide, which form isolated points in 3-space. However, if the gauge group is an orthogonal group SO(N), then at non-singular points (2) fixes the gauge completely, and the singular points, with two coinciding eigenvalues, form strings in 3-space. These represent Nielson-Olesen vortices [6]. So the point like singularities in 3-space or monopole of the group SO(N) can not be gotten under this gauge. Therefore finding gauge condition with only point-like singularities for SO(N) is crucial.

In this paper, we find the gauge condition for SO(4) monopole can be gotten via projecting the SO(4) gauge field onto an antisymmetric tensor in close analogy to isospin breaking in the 't Hooft-Polyakov monopole construction [7,8]. This projection fix the coset  $SU(2)/U(1) \otimes SU(2)/U(1)$  of SO(4) gauge group. The SO(4) monopole obtained is found composed of left and right monopoles, each of which has the similar structure as that of SU(2) monopole. In the discussion, the decomposition theory of gauge potential plays an important role. This theory has been effectively used to study the magnetic monopole problem in SU(2) gauge theory [9], the topological gauge theory of dislocation and disclination in condensed matter physics [10], the topological structure of space-time defect [11] and the Gauss-Bonnet-Chern(GBC) theorem [12,13]. The inner structure of SU(2) and SO(4)gauge field in terms of vectors or tensors gives a deep understanding of construction of the monopoles. By making use of a Dirac spinor, the SO(4) monopole is proved to be  $U(1) \times U(1)$  invariant via a generalized Hopf map  $S^3 \times S^3 \to S^2 \times S^2$ . Further we show that the SO(4) monopole can be considered as a new topological invariant. Using the so-called  $\phi$ -mapping method, it is verified that the monopole density take the form of a generalized function  $\delta(\phi)$ . The positions of the monopoles are determined by the zeroes of the self-dual or anti-self-dual part of an antisymmetric tensor. The monopole density is further found as multi-monopoles system by detailed the structure of delta function, which is labeled by the Hopf index the Brouwer degree of the antisymmetric tensor field. Moreover, the direct connection between monopole charges and Winding number is obtained. In this construction the SO(4) monopole charge density current is proved taken the same form as the current density of a system of multi classical point particles.

The organization of the present paper is as follows: In section 2 we start from the decomposition theory of SU(2) gauge potential and the construction of SU(2) magnetic monopole for the convenience of the later discussion of SO(4) monopole. In section 3, the decomposition theory of SO(4) gauge potential is given. Using the inner structure of SO(4) gauge field, we give the construction of the SO(4) monopole. Then in section 4, we show the SO(4) monopole can be consider as a new topological invariant. A detailed discussion of the topological structure of the monopole is given in Section 5. At last, we give a short summary and some concluding remarks in section 6.

# II. DECOMPOSITION THEORY OF SU(2) GAUGE POTENTIAL AND MAGNETIC MONOPOLE

Now we firstly give the decomposition theory of SU(2) gauge potential for the convenience of further discussion of the SO(4) monopoles. The decomposition theory of gauge potential is a powerful tool in the research of the topology of gauge field theory. One of the essential features of this theory is the gauge potential and gauge field possess inner structure, or in other words, they can be composed of some element fields. For the vector fields and tensor fields carry important information of topology, the inner structure of the gauge field in terms of vector fields or tensor fields can reveal the topological properties of the gauge theory more deeply and directly. In this section, it will be seen that the SU(2) magnetic monopole can be induced from decomposition theory naturally.

Let n be an unit SU(2) Lie algebra vector

$$n = n^A I_A , \qquad A = 1, 2, 3 ;$$
 (3)

and

$$n^A n^A = 1, (4)$$

in which  $I_A$  is the generator of the group SU(2), which satisfies the commutation relation

$$[I_A, I_B] = -\epsilon^{ABC} I_C. \tag{5}$$

The covariant derivative 1-form of n is given by

$$D_{SU(2)}n = dn - [\omega_{SU(2)}, n], \tag{6}$$

where  $\omega_{SU(2)}$  is the SU(2) gauge potential 1-form:

$$\omega_{SU(2)} = \omega_{SU(2)}^A I_A , \qquad (7)$$

and

$$\omega_{SU(2)}^{A} = \omega_{SU(2)\mu}^{A} dx^{\mu} \qquad \mu = 0, 1, 2, 3.$$

The gauge field 2-form is

$$F_{SU(2)} = F_{SU(2)}^{A} I_{A} = d\omega_{SU(2)} - \omega_{SU(2)} \wedge \omega_{SU(2)}, \tag{9}$$

and

$$F_{SU(2)}^{A} = \frac{1}{2} F_{SU(2)\mu\nu}^{A} dx^{\mu} \wedge dx^{\nu} = d\omega_{SU(2)}^{A} + \frac{1}{2} \epsilon^{ABC} \omega_{SU(2)}^{B} \wedge \omega_{SU(2)}^{C}.$$

Let  $m = m^A I_A$ ,  $l = l^A I_A$  be another two unit SU(2) vectors orthonormal to n and satisfy

$$n^A = \epsilon^{ABC} m^B l^C, \tag{11}$$

i.e. n, m, l are orthonormal to each other. It can be proved that the SU(2) gauge potential can be decomposed by n, m, l as

$$\omega_{SU(2)}^{A} = \epsilon^{ABC} (dn^{B} n^{C} - D_{SU(2)} n^{B} n^{C}) - n^{A} A,$$
(12)

where

$$A = dm^{A}l^{A} - D_{SU(2)}m^{A}l^{A}.$$
 (13)

From simple caculus, the curvature (gauge field) 2-form  $F_{SU(2)}^A$  becomes

$$F_{SU(2)}^{A} = n^{A} dA + dn^{A} \wedge A + \epsilon^{ABC} n^{B} dD_{SU(2)} n^{C} -\frac{1}{2} \epsilon^{ABC} dn^{B} \wedge dn^{C} + \frac{1}{2} \epsilon^{ABC} D_{SU(2)} n^{B} \wedge D_{SU(2)} n^{C}.$$
(14)

For  $n^A$ ,  $m^A$ ,  $l^A$  form a basis of the vector space. We have

$$F_{SU(2)}^{A} = (F_{SU(2)}^{B}n^{B})n^{A} + (F_{SU(2)}^{B}m^{B})m^{A} + (F_{SU(2)}^{B}l^{B})l^{A}.$$
(15)

Substituting (14) into (15),  $F_{SU(2)}^B$  is expressed as

$$F_{SU(2)}^{A} = (dA(n) - \frac{1}{2}\epsilon^{DBC}n^{D}dn^{B} \wedge dn^{C} + \frac{1}{2}\epsilon^{DBC}n^{D}D_{SU(2)}n^{B} \wedge D_{SU(2)}n^{C})n^{A} + (dA(m) - \frac{1}{2}\epsilon^{DBC}m^{D}dm^{B} \wedge dm^{C} + \frac{1}{2}\epsilon^{DBC}m^{D}D_{SU(2)}m^{B} \wedge D_{SU(2)}m^{C})m^{A} + (dA(l) - \frac{1}{2}\epsilon^{DBC}l^{D}dl^{B} \wedge dl^{C} + \frac{1}{2}\epsilon^{DBC}l^{D}D_{SU(2)}l^{B} \wedge D_{SU(2)}l^{C})l^{A}.$$

The above decomposition and inner structure of the SU(2) gauge field is strict and without any gauge condition. It can be proved this inner structure has global properties [13], which is independent of the choice of coordinate. From the formula (16), it's clear that the SU(2)gauge field is composed of three monopoles on three orthonormal directions. Therefore, arbitrary direction projection of the gauge field will give a monopole structure.

In general, the gauge field of SU(2) magnetic monopole can be defined as

$$\tilde{F} = F_{SU(2)}^A n^A - \frac{1}{2} \epsilon^{ABC} n^A D_{SU(2)} n^B \wedge D_{SU(2)} n^C$$
$$= n^A dA - \frac{1}{2} \epsilon^{ABC} n^A dn^B \wedge dn^C.$$

This projection can be considered as a gauge condition which fix the gauge field on a given direction  $n^A$ . In this form, the maximal abelian projection is given. Use the first pair of Maxwell's equation

$$\partial_{\nu}F^{\mu\nu} = -4\pi j^{\mu}; \tag{18}$$

$$F^{\mu\nu} = \frac{1}{2} \varepsilon^{\mu\nu\lambda\rho} F_{\lambda\rho}.$$
 (19)

The magnetic charge current is defined as

$$j^{\mu} = \frac{1}{8\pi} \varepsilon^{\mu\nu\lambda\rho} \varepsilon^{ABC} \partial_{\nu} n^{A} \partial_{\lambda} n^{B} \partial_{\rho} n^{C}.$$
 (20)

This expression is of a topological nature since it is conserved automatically

$$\partial_{\mu}j^{\mu} = \frac{1}{8\pi} \varepsilon^{\mu\nu\lambda\rho} \varepsilon^{ABC} \partial_{\mu} (\partial_{\nu} n^{A} \partial_{\lambda} n^{B} \partial_{\rho} n^{C}) \equiv 0$$
(21)

due to a complete antisymmetricity of the Levi-Cività symbol. Hence the total magnetic charge  $Q_m$ 

$$Q_m = \int j^\mu dV_\mu \tag{22}$$

is a purely topological quantity.

Now we see the decomposition theory of SU(2) gauge potential gives the construction of magnetic monopole in a nature way. In next section we will show how to construct the SO(4) monopole using the decomposition theory of SO(4) gauge potential.

### III. INNER STRUCTURE OF SO(4) GAUGE FIELD AND SO(4) MONOPOLE

Now let us consider the SO(4) gauge theory. Let the 4-dimensional Dirac matrix  $\gamma_a$  (a = 1, 2, 3, 4) be the basis of the Clifford algebra which satisfies

$$\gamma_a \gamma_b + \gamma_b \gamma_a = 2\delta_{ab}.$$
(23)

The antisymmetric tensor field  $\phi^{ab}$  on **M** can be expressed in the following matrix form

$$\phi = \frac{1}{2} \phi^{ab} I_{ab},\tag{24}$$

in which  $I_{ab}$  is the generator of the group SO(4)

$$I_{ab} = \frac{1}{4} [\gamma_a, \gamma_b]. \tag{25}$$

Similarly, the spin connection (gauge potential) 1-form and curvature (gage field) 2-form can be expressed as

$$\omega = \frac{1}{2}\omega^{ab}I_{ab}, \qquad F = \frac{1}{2}F^{ab}I_{ab}.$$

It is well known that the spin representation of SO(4) group is hormorphic to the direct product of the representations of two SU(2) group

$$so(4) \cong su_L(2) \otimes su_R(2).$$
 (27)

Therefore we can get SO(4) monopole via fixing the coset  $SU_L(2)/U_L(1) \otimes SU_R(2)/U_R(1)$ which should be composed of the left and right monopoles

$$\tilde{F} = \tilde{F}_L + \tilde{F}_R. \tag{28}$$

In the following, we will show how to achieve this goal.

The generators of SO(4) group can be divided into two terms. Each term is a generator of SU(2) group. Define

$$I_L^1 = \frac{1}{2} I_{23}(1 - \gamma_5) \qquad I_R^1 = \frac{1}{2} I_{23}(1 + \gamma_5); \tag{29}$$

$$I_L^2 = \frac{1}{2} I_{31}(1 - \gamma_5) \qquad I_R^2 = \frac{1}{2} I_{31}(1 + \gamma_5); \tag{30}$$

$$I_R^3 = \frac{1}{2}I_{12}(1-\gamma_5) \qquad I_R^3 = \frac{1}{2}I_{12}(1+\gamma_5), \tag{31}$$

in which  $\gamma_5 = \gamma_1 \gamma_2 \gamma_3 \gamma_4$ . It can be proved  $I^A_{L(R)}(A = 1, 2, 3)$  satisfy the commutation relation of group SU(2)

$$I_{L(R)}^{A} = -\epsilon^{ABC} [I_{L(R)}^{B}, I_{L(R)}^{C}], \qquad (32)$$

and

$$[I_L^A, I_R^B] = 0. (33)$$

Therefore  $I_{L(R)}^A$  are the generators of the groups  $SU(2)_{L(R)}$ , and they are the basis of  $SU(2)_{L(R)}$  Lie algebra spaces.

Arbitrary antisymmetric tensor field  $\phi^{ab}$  can be decomposed as

$$\phi^{ab} = \phi_L^{ab} + \phi_R^{ab},\tag{34}$$

where

$$\phi_L^{ab} = \frac{1}{2}(\phi^{ab} + \frac{1}{2}\epsilon^{abcd}\phi^{cd}) \qquad \phi_R^{ab} = \frac{1}{2}(\phi^{ab} - \frac{1}{2}\epsilon^{abcd}\phi^{cd})$$
(35)

are the self-dual and anti-self-dual parts of 
$$\phi^{ab}$$
. Define

$$\phi_L^1 = \phi^{23} + \phi^{14}, \quad \phi_L^2 = \phi^{31} + \phi^{24}, \quad \phi_L^3 = \phi^{12} + \phi^{34};$$
 (36)

$$\phi_R^1 = \phi^{23} - \phi^{14}, \quad \phi_R^2 = \phi^{31} - \phi^{24}, \quad \phi_R^3 = \phi^{12} - \phi^{34}.$$
 (37)

We can rewrite  $\phi$  as

$$\phi = \frac{1}{2}\phi^{ab}I_{ab} = \phi_L + \phi_R,\tag{38}$$

and

$$||\phi_{L(R)}|| = \phi_{L(R)}^{A} \phi_{L(R)}^{A} = \phi_{L(R)}^{ab} \phi_{L(R)}^{ab},$$
(39)

in which  $\phi_L$  and  $\phi_R$  are just the components of  $\phi$  correspond to  $SU_L(2)$  and  $SU_R(2)$  Lie algebra

$$\phi_L = \frac{1}{2}\phi(1 - \gamma_5) = \phi_L^A I_L^A, \tag{40}$$

$$\phi_R = \frac{1}{2}\phi(1+\gamma_5) = \phi_R^A I_R^A.$$
(41)

With the similar decomposition as above it can be verified that

$$D\phi = D\phi_L + D\phi_R = d\phi_L - [\omega_L, \phi_L] + d\phi_R - [\omega_R, \phi_R].$$
(42)

For the independence of  $I_L$  and  $I_R$  we have

$$D\phi_{L(R)} = d\phi_{L(R)} - [\omega_{L(R)}, \phi_{L(R)}],$$
(43)

or in components representation

$$D_{L(R)}\phi^{A}_{L(R)} = d\phi^{A}_{L(R)} - \epsilon^{ABC}\omega^{B}_{L(R)}\phi^{C}_{L(R)}.$$
(44)

in which

$$\omega_L = \omega_L^A I_L^A \qquad \omega_R = \omega_R^A I_R^A \tag{45}$$

is the gauge potential of  $SU(2)_{L(R)}$  gauge field.

Similarly the curvature 2-form can be decomposed as

$$F = F_L + F_R,\tag{46}$$

and

$$F_L = d\omega_L - \omega_L \wedge \omega_L \qquad F_R = d\omega_R - \omega_R \wedge \omega_R. \tag{47}$$

 $F_{L(R)}=F^A_{L(R)}I^A_{L(R)}$  are the curvature 2-forms of  $SU(2)_{L(R)}$  gauge field. Define an antisymmetric tensor

$$n^{ab} = \frac{\phi_L^{ab}}{||\phi_L||} + \frac{\phi_R^{ab}}{||\phi_R||},\tag{48}$$

i.e.

$$n_L^{ab} = \frac{\phi_L^{ab}}{||\phi_L||}, \qquad n_R^{ab} = \frac{\phi_R^{ab}}{||\phi_R||}.$$
(49)

which has the properties

$$n^{ab}n^{ab} = 2 \qquad \varepsilon^{abcd}n^{ab}n^{cd} = 0. \tag{50}$$

Then

$$n = \frac{1}{2}n^{ab}I_{ab} = n_L + n_R \tag{51}$$

and

$$n_L = \frac{1}{2||\phi_L||} \phi(1 - \gamma_5) = n_L^A I_L^A,$$
(52)

$$n_R = \frac{1}{2||\phi_R||}\phi(1+\gamma_5) = n_R^A I_R^A.$$

It naturally guarantees the constraint

$$n_{L(R)}^{A} n_{L(R)}^{A} = 1. (54)$$

i.e.  $n_{L(R)}^A$  are the  $SU(2)_{L(R)}$  unit vectors. From the decomposition formula of SU(2) gauge potential (14) we get

$$F_{L(R)}^{A} = n_{L(R)}^{A} dA_{L(R)} + dn_{L(R)}^{A} \wedge A + \epsilon^{ABC} n_{L(R)}^{B} dD_{L(R)} n_{L(R)}^{C} -\frac{1}{2} \epsilon^{ABC} dn_{L(R)}^{B} \wedge dn_{L(R)}^{C} + \frac{1}{2} \epsilon^{ABC} D_{L(R)} n_{L(R)}^{B} \wedge D_{L(R)} n_{L(R)}^{C}.$$
(55)

Now we can define the left and right SO(4) monopoles as

$$\tilde{F}_{L(R)} = F_{L(R)}^{A} n_{L(R)}^{A} - \frac{1}{2} \epsilon^{ABC} n_{L(R)}^{A} D_{L(R)} n_{L(R)}^{B} \wedge D_{L(R)} n_{L(R)}^{C}$$
$$= n_{L(R)}^{A} dA_{L(R)} - \frac{1}{2} \epsilon^{ABC} n_{L(R)}^{A} dn_{L(R)}^{B} \wedge dn_{L(R)}^{C}.$$
(56)

Through simple computation, we can get the gauge field of SO(4) monopole

$$\tilde{F} = \tilde{F}_L + \tilde{F}_R 
= F^{ab} n^{ab} + n^{ab} D n^{ac} \wedge D n^{cb} 
= n^{ab} d n^{ac} \wedge d n^{cb} + d (A_L + A_R).$$
(57)

In this way the coset  $SU(2)_L/U(1)_L \otimes SU(2)_R/U(1)_R$  of SO(4) group is fixed. The corresponding monopole charge current is

$$j^{\mu} = -\frac{1}{8\pi} \varepsilon^{\mu\nu\lambda\rho} \partial_{\nu} \tilde{F}_{\lambda\rho}$$
  
=  $-\frac{1}{4\pi} \varepsilon^{\mu\nu\lambda\rho} \partial_{\nu} n^{ab} \partial_{\lambda} n^{ac} \partial_{\rho} n^{cb},$  (58)

which is also conserved automatically

$$\partial_{\mu}j^{\mu} = -\frac{1}{4\pi} \varepsilon^{\mu\nu\lambda\rho} \partial_{\mu} (\partial_{\nu} n^{ab} \partial_{\lambda} n^{ac} \partial_{\rho} n^{cb}) \equiv 0$$
(59)

The total monopole charge

$$Q_m = \int j^{\mu} dV_{\mu} = -\frac{1}{4\pi} \int dn^{ab} \wedge dn^{ac} \wedge dn^{cb}$$
(60)

is a purely topological quantity.

On another hand, the inner structure of SO(4) gauge field can be gotten from the decomposition theory of gauge potential as

$$F^{ab} = dn^{ac} \wedge dn^{cb} - Dn^{ac} \wedge Dn^{cb} - n^{ac} dDn^{cb} + n^{bc} dDn^{ca} + dA_L n_L^{ab} + dA_R n_R^{ab} - A_L \wedge Dn_L^{ab} - A_R \wedge Dn_R^{ab}.$$
(61)

Then use three antisymmetric orthogonal antisymmetric tensors  $n^{ab}$ ,  $m^{ab}$ ,  $l^{ab}$ 

$$n^{ab}m^{ab} = n^{ab}l^{ab} = m^{ab}l^{ab} = 0,$$
  

$$\varepsilon^{abcd}n^{ab}m^{cd} = \varepsilon^{abcd}n^{ab}l^{cd} = \varepsilon^{abcd}m^{ab}l^{cd} = 0$$
(62)

and

$$n^{ab}n^{ab} = m^{ab}m^{ab} = l^{ab}l^{ab} = 2,$$
  

$$\varepsilon^{abcd}n^{ab}n^{cd} = \varepsilon^{abcd}m^{ab}m^{cd} = \varepsilon^{abcd}l^{ab}l^{cd} = 0,$$
(63)

we have

$$F^{ab} = \frac{1}{2} (F^{cd} n^{cd}) n^{ab} + \frac{1}{2} (F^{cd} m^{cd}) m^{ab} + \frac{1}{2} (F^{cd} l^{cd}) l^{ab} + \frac{1}{2} (F^{cd} n^{*cd}) n^{*ab} + \frac{1}{2} (F^{cd} n^{*cd}) n^{*ab} + \frac{1}{2} (F^{cd} l^{*cd}) l^{*ab},$$
(64)

in which  $n^{*ab}$ ,  $m^{*ab}$  and  $l^{*ab}$  are the dual tensors of  $n^{ab}$ ,  $m^{ab}$ ,  $l^{ab}$ 

$$n^{*ab} = \frac{1}{2} \varepsilon^{abcd} n^{cd} \quad m^{*ab} = \frac{1}{2} \varepsilon^{abcd} m^{cd} \quad l^{*ab} = \frac{1}{2} \varepsilon^{abcd} l^{cd}.$$
 (65)

Substituting the inner structure (61) into (64), we get

$$F^{ab} = \frac{1}{2} (n^{dc} dn^{de} \wedge dn^{ec} - n^{dc} Dn^{de} \wedge Dn^{ec} + dA_L(n) + dA_R(n)) n^{ab} + \frac{1}{2} (m^{dc} dm^{de} \wedge dm^{ec} - m^{dc} Dm^{de} \wedge Dm^{ec} + dA_L(m) + dA_R(m)) m^{ab} + \frac{1}{2} (l^{dc} dl^{de} \wedge dl^{ec} - l^{dc} Dl^{de} \wedge Dl^{ec} + dA_L(l) + dA_R(l)) l^{ab} + \frac{1}{2} (n^{*dc} dn^{*de} \wedge dn^{*ec} - n^{*dc} Dn^{*de} \wedge Dn^{*ec} + dA_L(n^*) + dA_R(n^*)) n^{*ab} + \frac{1}{2} (m^{*dc} dm^{*de} \wedge dm^{*ec} - m^{*dc} Dm^{*de} \wedge Dm^{*ec} + dA_L(m^*) + dA_R(m^*)) m^{*ab} + \frac{1}{2} (l^{*dc} dl^{*de} \wedge dl^{*ec} - l^{*dc} Dl^{*de} \wedge Dl^{*ec} + dA_{L^*}(l^*) + dA_R(l^*)) l^{*ab}.$$
(66)

So we see from the above formula the gauge field is composed of six SO(4) monopoles in three orthogornal tensor directions and their dual directions. The monopole projection onto the dual tensor of  $n^{ab}$  is just the difference of the left and right monopole projection onto  $n^{ab}$ 

$$\tilde{F}(n^*) = \tilde{F}(n)_L - \tilde{F}(n)_R.$$
(67)

Given a Dirac spinor

$$\psi = \begin{pmatrix} \psi_L \\ \psi_R \end{pmatrix}. \tag{68}$$

Satisfying

$$\psi_L^{\dagger}\psi_L = 1 \qquad \psi_R^{\dagger}\psi_R = 1.$$
(69)

Define the antisymmetric tensor  $n^{ab}$  by

$$n^{ab} = \psi^{\dagger} I_{ab} \psi. \tag{70}$$

It is easy to prove  $n^{ab}$  can be regard as the antisymmetric tensor defined in (48) satisfying

$$n^{ab}n^{ab} = 2 \qquad \varepsilon^{abcd}n^{ab}n^{cd} = 0. \tag{71}$$

The self-dual part of  $n^{ab}$  is

$$n_L^{ab} = \frac{1}{2} (\psi^{\dagger} I_{ab} \psi + \frac{1}{2} \varepsilon^{abcd} \psi^{\dagger} I_{cd} \psi).$$
(72)

It's easy to prove the above equation can be rewritten as

$$n_L^{ab} = \frac{1}{2} \psi^{\dagger} I_{ab} (1 - \gamma^5) \psi$$
$$= \frac{1}{2} \left( \begin{array}{c} \psi_L \\ 0 \end{array} \right)^{\dagger} I_{ab} (1 - \gamma^5) \left( \begin{array}{c} \psi_L \\ 0 \end{array} \right).$$
(73)

Similarly we have

$$n_R^{ab} = \frac{1}{2} \begin{pmatrix} 0\\\psi_R \end{pmatrix}^{\dagger} I_{ab} (1+\gamma^5) \begin{pmatrix} 0\\\psi_R \end{pmatrix}.$$
(74)

The SO(4) monopole gauge field  $\tilde{F}$  (57) becomes

$$\tilde{F} = id\psi^{\dagger}d\psi + d(A_L + A_R) = id\psi_L^{\dagger}d\psi_L + id\psi_R^{\dagger}d\psi_R + d(A_L + A_R).$$
(75)

Therefore, given a transformation

$$\psi' = \begin{pmatrix} e^{i\theta}I & 0\\ 0 & e^{i\varphi}I \end{pmatrix} \psi.$$
(76)

It is easy to prove the gauge field 2-form  $\tilde{F}$  is invariant under this transformation, therefore  $\tilde{F}$  given here is  $U(1) \times U(1)$  invariant.

The condition (69) give a direct product of two  $S^3$  sphere

$$S^3 \times S^3, \tag{77}$$

and the condition (54) gives a product of two  $S^2$  sphere

$$S^2 \times S^2. \tag{78}$$

The definition (70) actually gives a generalized Hopf map [15,16]

$$S^3 \times S^3 \to S^2 \times S^2. \tag{79}$$

#### IV. SO(4) MONOPOLE AS A NEW TOPOLOGICAL INVARIANT

A topological invariant should has two properties. First, it has to be gauge invariant. And second, it should be gauge independent, or in other words, it has the same value under arbitrary gauge conditions. In the follows we will prove the gauge field of SO(4) monopole indeed possess these two properties.

Firstly, under arbitrary gauge transformation, the curvature 2-form  $F^{ab}$  transform covariantly as

$$F'^{ab} = S^{ac} F^{cd} S^{db} \tag{80}$$

and the covariant derivative 1-form of the antisymmetric tensor  $n^{ab}$  transform covariantly also

$$D'n'^{ab} = S^{ac} D n^{cd} S^{cb},\tag{81}$$

where  $S^{ab}$  is the element of the SO(4) gauge group satisfying

$$S^{ac}S^{cb} = \delta^{ab}.$$
(82)

Hence we can prove the new topological invariant  $\tilde{F}$  is SO(4) gauge invariant, i.e.

$$\tilde{F}' = \tilde{F}.\tag{83}$$

Then let us prove the gauge independence property of  $\tilde{F}$ . Given two SO(4) spin connection  $\omega_0$  and  $\omega_1$ , the corresponding monopole gauge field 2-forms are

$$\tilde{F}(\omega_0) = n^{ab} dn^{ac} \wedge dn^{cb} + dA_L(\omega_0) + dA_R(\omega_0)$$
(84)

and

$$\tilde{F}(\omega_1) = n^{ab} dn^{ac} \wedge dn^{cb} + dA_L(\omega_1) + dA_R(\omega_1).$$
(85)

Then the difference between  $\tilde{F}(\omega_0)$  and  $\tilde{F}(\omega_1)$  is just a exact 2-form

$$\tilde{F}(\omega_1) - \tilde{F}(\omega_0) = d(A_L(\omega_1) + A_R(\omega_1) - A_L(\omega_0) - A_R(\omega_0)).$$
(86)

Thus the integrals of  $\tilde{F}(\omega_0)$  and  $\tilde{F}(\omega_1)$  over a closed 2-dimensional surface give the same results and hence we prove  $\tilde{F}$  is independent of the gauge potential. The above two properties, i.e. gauge invariance and independence of gauge potential, make the integral of our monopole gauge field 2-form over a closed 2-dimensional surface to a topological invariant.

At last we get the new topological invariant Q

$$Q = \frac{1}{4\pi} \int_{\Sigma^2} \tilde{F} = \frac{1}{4\pi} \int_{V^3} d\tilde{F} = \frac{1}{4\pi} \int_{V^3} dn^{ab} \wedge dn^{ac} \wedge dn^{cb},$$
(87)

in which  $\Sigma^2 = \partial V^3$ .

In another hand the monopole charge is given by integral

$$Q_{m} = \int_{V} j^{\mu} dV_{\mu}$$
  
=  $-\frac{1}{8\pi} \int_{V} \varepsilon^{\mu\nu\lambda\rho} \partial_{\nu} \tilde{F}_{\lambda\rho} dV_{\mu}$   
=  $-\frac{1}{4\pi} \int_{V} d\tilde{F}.$  (88)

Now we see the monopole charge and the new topological invariant is the same in fact but a minus sign

$$Q_m = -Q. \tag{89}$$

## V. THE LOCAL TOPOLOGICAL STRUCTURE OF THE SO(4) MONOPOLE

Define left and right monpole charges as

$$Q_{mL(R)} = \int_{V} j^{\mu}_{L(R)} dV_{\mu} = \frac{1}{8\pi} \int_{V} \epsilon^{ABC} dn^{A}_{L(R)} \wedge dn^{B}_{L(R)} \wedge dn^{C}_{L(R)}.$$
(90)

The total monpole charge is

$$Q_m = Q_{mL} + Q_{mR}. (91)$$

Let  $y = (u^1, u^2, u^3, \tau)$  be another term of the coordinate of M and  $u = (u^1, u^2, u^3)$  be the intrinsic coordinate of V. For the coordinate component v does not belong to V. Then

$$\Omega_{mL(R)} = \frac{1}{8\pi} \int_{V} \epsilon^{ABC} \partial_{i} n^{A}_{L(R)} \partial_{j} n^{B}_{L(R)} \partial_{k} n^{C}_{L(R)} du^{i} \wedge du^{j} \wedge du^{k}$$
$$= \frac{1}{8\pi} \int_{V} \epsilon^{ijk} \epsilon^{ABC} \partial_{i} n^{A}_{L(R)} \partial_{j} n^{B}_{L(R)} \partial_{k} n^{C}_{L(R)} d^{3}u, \qquad (92)$$

where i, j, k = 1, 2, 3 and  $\partial_i = \partial/\partial u^i$ . Then the monpole charge densities can be defined as

$$\rho_{L(R)} = \frac{1}{8\pi} \epsilon^{ijk} \epsilon^{ABC} \partial_i n^A_{L(R)} \partial_j n^B_{L(R)} \partial_k n^C_{L(R)}.$$
(93)

We get

$$Q_{mL(R)} = \int_V \rho_{L(R)} d^3 u. \tag{94}$$

For the equation (52), the unit vectors  $n_{L(R)}^A(x)$  can expressed as follows:

$$n_{L(R)}^{A} = \frac{\phi_{L(R)}^{A}}{||\phi_{L(R)}||}.$$
(95)

Hence

$$dn_{L(R)}^{A} = \frac{1}{||\phi_{L(R)}||} d\phi_{L(R)}^{A} + \phi_{L(R)}^{A} d(\frac{1}{||\phi_{L(R)}||}),$$
(96)

and

$$\frac{\partial}{\partial \phi_{L(R)}^{A}} (\frac{1}{||\phi_{L(R)}||}) = -\frac{\phi_{L(R)}^{A}}{||\phi_{L(R)}||^{3}}.$$
(97)

Substituting above equations into the monopole charge density (93) we obtain

$$\rho = \frac{1}{8\pi} \epsilon^{ABC} \epsilon^{ijk} \partial_i (n^A_{L(R)} \partial_j n^B_{L(R)} \partial_k n^C_{L(R)})$$

$$= \frac{1}{8\pi} \epsilon^{ABC} \epsilon^{ijk} \partial_i \frac{\phi^A_{L(R)}}{||\phi_{L(R)}||^3} \partial_j \phi^B_{L(R)} \partial_k \phi^C_{L(R)}$$

$$= -\frac{1}{8\pi} \epsilon^{ABC} \epsilon^{ijk} \frac{\partial}{\partial \phi^D_{L(R)}} \frac{\partial}{\partial \phi^A_{L(R)}} (\frac{1}{||\phi_{L(R)}||}) \partial_i \phi^D_{L(R)} \partial_j \phi^B_{L(R)} \partial_k \phi^C_{L(R)}.$$
(98)

Define the Jacobian  $D(\frac{\phi_{L(R)}}{u})$  as

$$\epsilon^{ABC} D(\frac{\phi_{L(R)}}{u}) = \epsilon^{ijk} \partial_i \phi^A_{L(R)} \partial_j \phi^B_{L(R)} \partial_k \phi^C_{L(R)}.$$
<sup>(99)</sup>

By making use of the Laplacian relation in  $\phi$ -space

$$\partial_A \partial_A \frac{1}{||\phi_{L(R)}||} = -4\pi \delta^3(\phi_{L(R)}), \quad \partial_A = \frac{\partial}{\partial \phi^A_{L(R)}}, \tag{100}$$

we can write the monopole charge density as the  $\delta$ -like expression

$$\rho_{L(R)} = \delta^3(\phi_{L(R)}) D(\frac{\phi_{L(R)}}{u})$$
(101)

and

$$Q_{mL(R)} = \int_{V} \delta^{3}(\phi_{L(R)}) D(\frac{\phi_{L(R)}}{u}) d^{3}u.$$
(102)

It obvious that  $\rho_{L(R)}$  are non-zero only when  $\phi_{L(R)} = 0$ . Suppose that  $\phi^A_{L(R)}(x)$  (A = 1, 2, 3) possess  $K_{L(R)}$  isolated zeros, according to the implicit function theorem, the solutions of  $\phi_{L(R)}(u^1, u^2, u^3, \tau) = 0$  can be expressed in terms of  $u = (u^1, u^2, u^3)$  as

$$u^{i} = z^{i}_{L(R)}(\tau), \qquad i = 1, 2, 3$$
 (103)

and

$$\phi_{L(R)}^{A}(z_{l}^{1}(\tau), z_{l}^{2}(\tau), z_{l}^{3}(\tau), \tau) \equiv 0, \qquad (104)$$

where the subscript  $l = 1, 2, \dots, K_{L(R)}$  represents the *l*th zero of  $\phi_{L(R)}^A$ , i.e.

$$\phi^A_{L(R)}(z^i_{L(R)l}) = 0, \qquad l = 1, 2, \cdots, K_{L(R)}.$$
 (105)

It is easy to get the following formula from the ordinary theory of  $\delta$ -function that

$$\delta^{3}(\phi_{L(R)})D(\frac{\phi_{L(R)}}{u}) = \sum_{i=1}^{K_{L(R)}} \beta_{L(R)l} \eta_{L(R)l} \delta^{3}(u - z_{L(R)l})$$
(106)

in which

$$\eta_{L(R)l} = signD(\frac{\phi_{L(R)}}{u})|_{x=z_{L(R)l}} = \pm 1,$$
(107)

is the Brouwer degree of  $\phi$ -mapping and  $\beta_{L(R)l}$  are positive integers called the Hopf index of map  $\phi_{L(R)}$  which means while the point x covers the region neighboring the zero  $x = z_{L(R)l}$  once,  $\phi_{L(R)}$  covers the corresponding region  $\beta_{L(R)l}$  times. Therefore the slid angle density becomes

$$\rho_{L(R)} = \sum_{l=1}^{K_{L(R)}} \beta_{L(R)l} \eta_{L(R)l} \delta^3(u - z_{L(R)l})$$
(108)

and

$$Q_{mL(R)} = \sum_{l=1}^{K_{L(R)}} \beta_{L(R)l} \eta_{L(R)l} \int_{V} \delta^{3} (u - z_{L(R)l}) d^{3}u = \sum_{l=1}^{K_{L(R)}} \beta_{L(R)l} \eta_{L(R)l}.$$
 (109)

Therefore the total SO(4) monopole charge is

$$Q_m = \sum_{l=1}^{K_L} \beta_{Ll} \eta_{Ll} + \sum_{l=1}^{K_R} \beta_{Rl} \eta_{Rl}.$$
 (110)

We find that (108) is the exact density of a system of  $K_L$  and  $K_R$  classical point-like objects with "charge"  $\beta_{Ll}\eta_{Ll}$  and  $\beta_{Rl}\eta_{Rl}$  in space-time, i.e. the topological structure of SO(4)monopole charge density formally corresponds to a point-like system. These point objects may be called topological particles which are identified with the isolated zero points of vector field  $\phi_{L(R)}^A(x)$ .

Using similar way it can be proved the monopole charge current density can be expressed as

$$j^{\mu} = \sum_{l=1}^{K_L} \beta_{Ll} \eta_{Ll} \delta^3(u - z_{Ll}) \frac{D^{\mu}(\frac{\phi_L}{x})}{D(\frac{\phi_L}{u})} + \sum_{l=1}^{K_R} \beta_{Rl} \eta_{Rl} \delta^3(u - z_{Rl}) \frac{D^{\mu}(\frac{\phi_R}{x})}{D(\frac{\phi_R}{u})},$$
(111)

where the  $D^{\mu}(\frac{\phi_{L(R)}}{x})$  is the Jacobian vector

$$\epsilon^{ABC} D^{\mu} \left(\frac{\phi_{L(R)}}{u}\right) = \epsilon^{\mu\nu\lambda\rho} \partial_{\nu} \phi^{A}_{L(R)} \partial_{\lambda} \phi^{B}_{L(R)} \partial_{\rho} \phi^{C}_{L(R)}.$$
(112)

It can be proved the general velocity of the ith zero is

$$V_l^{\mu} = \left. \frac{dx^{\mu}}{d\tau} \right|_{x=z_l} = \left. \frac{D^{\mu}(\frac{\phi}{x})}{D(\frac{\phi}{u})} \right|_{x=z_l},\tag{113}$$

then

$$j^{\mu} = \sum_{l=1}^{K_L} \beta_{Ll} \eta_{Ll} \delta^3 (u - z_{Ll}) \frac{dx^{\mu}}{d\tau} + \sum_{l=1}^{K_R} \beta_{Rl} \eta_{Rl} \delta^3 (u - z_{Rl}) \frac{dx^{\mu}}{d\tau}.$$
(114)

which is in the same form as the classical current density of the system of  $K_L + K_R$  point particles moving in the space-time.

On another hand, the winding number of the surface  $\Sigma$  and the mapping  $n_{L(R)}$  is defined as [14]

$$W_{L(R)} = \oint_{\Sigma} \frac{1}{8\pi} \epsilon^{ABC} \frac{\phi_{L(R)}^{A}}{||\phi_{L(R)}||^{3}} d\phi_{L(R)}^{B} \wedge d\phi_{L(R)}^{C}, \qquad (115)$$

which is equal to the number of times  $\Sigma$  encloses (or, wraps around) the point  $\phi_{L(R)} = 0$ . Hence, the monopole charge is quantized by the winding numbers

$$Q_{mL(R)} = W_{L(R)}.$$
 (116)

The winding number  $W_{L(R)}$  of the surface  $\Sigma$  can be interpreted or, indeed, defined as the degree of the mappings  $\phi_{L(R)}$  onto  $\Sigma$ . By (102) and (101) we have

$$Q_{mL(R)} = \int_{V} \delta(\phi_{L(R)}) \rho_{L(R)}(\frac{\phi_{L(R)}}{u}) d^{3}u$$
  
= deg  $\phi_{L(R)} \int_{\phi_{L(R)}(V)} \delta(\phi_{L(R)}) d^{3}\phi_{L(R)}$   
= deg  $\phi_{L(R)},$  (117)

where deg  $\phi_{L(R)}$  are the degrees of map  $\phi_{L(R)} : V \to \phi_{L(R)}(V)$ . Compared above equation with (116), it shows the degrees of map  $\phi_{L(R)} : V \to \phi_{L(R)}(V)$  is just the winding number  $W_{L(R)}$  of surface  $\Sigma$  and map  $\phi_{L(R)}$ , i.e.

$$\deg \phi_{L(R)} = W_{L(R)}(\Sigma, \phi_{L(R)}). \tag{118}$$

Then the total SO(4) monopole charge is

$$Q_m = \deg \phi_L + \deg \phi_R = W_L + W_R. \tag{119}$$

Divide V by

$$V = \sum_{l=1}^{K_{L(R)}} V_{L(R)l}$$
(120)

so that  $V_{L(R)l}$  includes only one zero  $z_{L(R)l}$  of  $\phi_{L(R)}$ , i.e.  $z_{L(R)l} \in V_{L(R)l}$ . The winding number of the surface  $\Sigma_{L(R)l} = \partial V_{L(R)l}$  and the mapping  $n_{L(R)}$  is defined as

$$W_{L(R)l} = \oint_{\Sigma_{L(R)l}} \frac{1}{8\pi} \epsilon^{ABC} \frac{\phi_{L(R)}^{A}}{||\phi_{L(R)}||^{3}} d\phi_{L(R)}^{B} \wedge d\phi_{L(R)}^{C}, \qquad (121)$$

which is equal to the number of times  $\Sigma_{L(R)l}$  encloses (or, wraps around) the point  $\phi_{L(R)} = 0$ . It is easy to see that

$$W_{L(R)} = \sum_{l=1}^{K_{L(R)}} W_{L(R)l}$$
(122)

and

$$|W_{L(R)l}| = \beta_{L(R)l}.\tag{123}$$

Then

$$Q_m = \sum_{l=1}^{K_L} W_{Ll} + \sum_{l=1}^{K_L} W_{Rl}.$$
 (124)

Also we can write

$$Q_m = (N_L^+ + N_R^+) - (N_L^- + N_R^-), \tag{125}$$

in which  $N_{L(R)}^{\pm}$  are the sums of the Hopf indexes with respect to  $\eta_{L(R)} = \pm 1$ . We see that while x covers V once,  $\phi_{L(R)}^{A}$  must cover  $\phi_{L(R)}(V)$   $N_{L(R)}^{+}$  times with  $\eta = 1$  and  $N_{L(R)}^{-}$  times with  $\eta = -1$ .

#### VI. CONCLUSION

In this paper we have provide a gauge condition via projecting the SO(4) gauge field onto an antisymmetric tensor field to fix the coset  $SU(2)_L/U(1)_L \otimes SU(2)_R/U(1)_R$  of SO(4)group. Under this gauge condition the SO(4) monopole is constructed which is composed of two monopoles, namely left and right monopoles. Each of these monopoles has the similar structure as that of the SU(2) magnetic monopoles. We also discussed the topological properties of this monopole and find it can be consider as a new topological invariant. Using a Dirac spinor, we give a generalized Hopf map  $S^3 \times S^3 \to S^2 \times S^2$ . The detailed local topological structure is given. It's the monopole charge is quantized topologically by winding number. The Hopf indices and Brouwer degree characterize the monopoles.

The decomposition theory of gauge potential play an important role in the discussion. The monopole structure can be induced from the inner structure of the gauge field easily. It is again a proof the success of the decomposition theory. We assume that the SO(N)(N > 4) monopole structure may be induced by making use of this theory in analogous way.
