# DATA-DRIVEN RATE-OPTIMAL SPECIFICATION TESTING IN REGRESSION MODELS ${ }^{1}$

We propose new data-driven smooth tests for a parametric regression function. The smoothing parameter is selected through a new criterion that favors a large smoothing parameter under the null hypothesis. The resulting test is adaptive rate-optimal and consistent against Pitman local alternatives approaching the parametric model at a rate arbitrarily close to $1 / \sqrt{n}$. Asymptotic critical values come from the standard normal distribution and the bootstrap can be used in small samples. A general formalization allows one to consider a large class of linear smoothing methods, which can be tailored for detection of additive alternatives.

1. Introduction. Consider $n$ observations $\left(Y_{i}, X_{i}\right)$ in $\mathbb{R} \times \mathbb{R}^{p}$ and the heteroscedastic regression model with unknown mean $m(\cdot)$ and variance $\sigma^{2}(\cdot)$,

$$
Y_{i}=m\left(X_{i}\right)+\varepsilon_{i}, \quad \mathbb{E}\left[\varepsilon_{i} \mid X_{i}\right]=0 \quad \text { and } \quad \operatorname{Var}\left[\varepsilon_{i} \mid X_{i}\right]=\sigma^{2}\left(X_{i}\right) .
$$

We want to test the hypothesis that the regression belongs to some parametric family $\{\mu(\cdot ; \theta) ; \theta \in \Theta\}$, that is,

$$
\begin{equation*}
H_{0}: m(\cdot)=\mu(\cdot ; \theta) \quad \text { for some } \theta \in \Theta . \tag{1.1}
\end{equation*}

Tests of $H_{0}$ are called lack-of-fit tests or specification tests. Based on smoothing techniques, many consistent tests of $H_{0}$ have been proposed, the so-called smooth tests; see Hart (1997) for a review. A fundamental issue is the choice of the smoothing parameter. Since this is a model selection problem, Eubank and Hart (1992), Ledwina (1994), Hart [(1997), Chapter 7] and Aerts, Claeskens and Hart (1999, 2000), among others, have proposed use of criteria developed by Akaike (1973) and Schwarz (1978). However, these criteria

[^0]are tailored for estimation but not for testing purposes. Hence, they do not yield adaptive rate-optimal tests, that is, tests that detect alternatives of unknown smoothness approaching the null hypothesis at the fastest possible rate when the sample size grows; see Spokoiny (1996).

Many adaptive rate-optimal specification tests are based on the maximum approach, which consists of choosing as a test statistic the maximum of Studentized statistics associated with a sequence of smoothing parameters. This approach is used for testing the white noise model with normal errors by Fan (1996) and for testing a linear regression model with normal errors by Fan and Huang (2001) and Baraud, Huet and Laurent (2003), who extend the maximum approach. Further work on the linear model includes Spokoiny (2001) under homoscedastic errors and Zhang (2003) under heteroscedastic errors. Finally, Horowitz and Spokoiny (2001) deal with the general case of a nonlinear model with heteroscedastic errors.

We reconsider the model selection approach to propose a new test with some distinctive features. First, our data-driven choice of the smoothing parameter relies on a specific criterion tailored for testing purposes. This yields an adaptive rate-optimal test. Second, the criterion favors a baseline statistic under the null hypothesis. This results in a simple asymptotic distribution for our statistic and in bounded critical values for our test. By contrast, in the maximum approach, critical values diverge and must practically be evaluated by simulation for any sample size. The computational burden of this task can be heavy for a large sample size and a large number of statistics. Moreover, diverging critical values are expected to yield some loss of power compared to our test. In particular, from an asymptotic viewpoint, our test detects local Pitman alternatives converging to the null at a faster rate than the ones detected by a maximum test. In small samples, our simulations show that our test has better power than a maximum test against irregular alternatives.

In our work we allow for a nonlinear parametric regression model with mutidimensional covariates, nonnormal errors and heteroscedasticity of unknown form. In Section 2 we describe the specific aspects of our testing procedure. In Section 3 we detail the practical construction of the test statistic for three types of smoothing procedures. Then we give our assumptions and main results, which concern the null asymptotic behavior of the test, adaptive rate-optimality, and detection of Pitman local alternatives. In Section 4 we prove the validity of a bootstrap method and compare the small sample performances of our test with a maximum test through a simulation experiment. In Section 5 we extend our results to general linear smoothing methods. Finally, we propose a test whose power against additive alternatives is not affected by the curse of dimensionality. Proofs are given in Section 6.
2. Description of the procedure. Consider a collection $\left\{\widehat{T}_{h}, h \in \mathcal{H}_{n}\right\}$ of asymptotically centered statistics which measures the lack-of-fit of the null parametric model. The index $h$ is a smoothing parameter, chosen in a discrete grid whose cardinality grows with the sample size $n$; see our examples in the next section. A maximum test rejects $H_{0}$ when $\max _{h \in \mathcal{H}_{n}} \widehat{T}_{h} / \widehat{v}_{h} \geq z_{\alpha}^{\max }$, where $\widehat{v}_{h}$ estimates the asymptotic null standard deviation of $\widehat{T}_{h}$. A test in the spirit of Baraud, Huet and Laurent (2003) rejects the null if $\widehat{T}_{h} \geq \widehat{v}_{h} z_{\alpha}(h)$ for some $h$ in $\mathcal{H}_{n}$ or, equivalently, if $\max _{h \in \mathcal{H}_{n}}\left(\widehat{T}_{h} / \widehat{v}_{h}-z_{\alpha}(h)\right)>0$, where the critical values are chosen to get an asymptotic $\alpha$-level test, a difficult issue in practice. Setting $z_{\alpha}(h)=z_{\alpha}^{\max }$ yields a maximum test. Because the number $h$ increases with $n, z_{\alpha}^{\max }$ diverges.

On an informal basis, our approach favors a baseline statistic $\widehat{T}_{h_{0}}$ with lowest variance among the $\widehat{T}_{h}$. In practice, $\widehat{T}_{h_{0}}$ can be designed to yield high power against parametric or regular alternatives that are of primary interest for the statistician. However, this statistic may not be powerful enough against nonparametric or irregular alternatives. We then propose to combine this baseline statistic with the other statistics $\widehat{T}_{h}$ in the following way. Let $\widehat{v}_{h, h_{0}}$ be some positive estimators of the asymptotic null standard deviation of $\widehat{T}_{h}-\widehat{T}_{h_{0}}$. We select $h$ as

\widetilde{h} & =\arg \max _{h \in \mathcal{H}_{n}}\left\{\widehat{T}_{h}-\gamma_{\widehat{v}} \widehat{v}_{h, h_{0}}\right\} \\
& =\arg \max _{h \in \mathcal{H}_{n}}\left\{\widehat{T}_{h}-\widehat{T}_{h_{0}}-\gamma_{n} \widehat{v}_{h, h_{0}}\right\} \quad \text { where } \gamma_{n}>0 . \tag{2.1}
\end{align*}

Our test is

$$
\begin{equation*}
\text { Reject } H_{0} \text { when } \widehat{T}_{\overparen{h}} / \widehat{v}_{h_{0}} \geq z_{\alpha}, \tag{2.2}
\end{equation*}
$$

where $z_{\alpha}$ is the quantile of order $(1-\alpha)$ of a standard normal.
The distinctive features of our approach are as follows. First, our criterion penalizes each statistic by a quantity proportional to its standard deviation, while the criteria reviewed in Hart (1997) use a larger penalty proportional to the variance. Second, the data-driven choice of the smoothing parameter favors $h_{0}$ under the null hypothesis. Indeed, since $\widehat{T}_{h}-\widehat{T}_{h_{0}}$ is of order $\widehat{v}_{h, h_{0}}$ under $H_{0}, \widetilde{h}=h_{0}$ asymptotically under $H_{0}$ if $\gamma_{n}$ diverges fast enough; see Theorem 1 below. Hence, the null limit distribution of the test statistic is the one of $\widehat{T}_{h_{0}} / \widehat{v}_{h_{0}}$, that is, the standard normal, and the resulting test has bounded critical values. Third, our selection procedure allows us to choose the standardization $\widehat{v}_{h_{0}}$. We could use $\widehat{v}_{\overparen{h}}$ instead, which also gives an asymptotic $\alpha$-level test since $\tilde{h}=h_{0}$ asymptotically under $H_{0}$. But, because $\widehat{v}_{h} \geq \widehat{v}_{h_{0}}$ asymptotically for any admissible $h$, our standardization gives a larger critical region under the alternative. This increases power at no cost from an asymptotic viewpoint; see Fan (1996) for a similar device in wavelet thresholding tests. Our simulation results show that this effect is already
large in small samples. By contrast, the maximum approach systematically downweights the statistic $\widehat{T}_{h}$ with its standard deviation.

Third, compared to a test using a single statistic, our test inherits the power properties of each of the $\widehat{T}_{h}$, up to a term $\gamma_{n} \widehat{v}_{h, h_{0}}$. Indeed, the definition of $\widetilde{h}$ yields

\widehat{T}_{\widetilde{h}}=\max _{h \in \mathcal{H}_{n}}\left(\widehat{T}_{h}-\gamma_{n} \widehat{v}_{h, h_{0}}\right)+\gamma_{n} \widehat{v}_{\widetilde{h}_{, h_{0}}} \geq \widehat{T}_{h}-\gamma_{n} \widehat{v}_{h, h_{0}} \quad \text { for any } h \in \mathcal{H}_{n}
$$

As a consequence, a lower bound for the power of the test is

$$
\begin{equation*}
\mathbb{P}\left(\widehat{T}_{\widehat{h}} \geq \widehat{v}_{h_{0}} z_{\alpha}\right) \geq \mathbb{P}\left(\widehat{T}_{h} \geq \widehat{v}_{h_{0}} z_{\alpha}+\gamma_{n} \widehat{v}_{h, h_{0}}\right) \quad \text { for any } h \text { in } \mathcal{H}_{n} \tag{2.3}
\end{equation*}
$$

Using a penalty proportional to a standard deviation yields a better power bound than the selection criteria reviewed in Hart (1997). A suitable choice of the smoothing parameter in the latter power bound allows us to establish the adaptive rate-optimality of the test; see Theorem 2 below and the following discussion. Fourth, combining the $\widehat{T}_{h}$ with our selection procedure gives a more powerful test than using the baseline statistic $\widehat{T}_{h_{0}}$. Indeed, since $\widehat{v}_{h_{0}, h_{0}}=0$, a noteworthy implication of (2.3) is

\mathbb{P}\left(\widehat{T}_{\widetilde{h}} \geq \widehat{v}_{h_{0}} z_{\alpha}\right) \geq \mathbb{P}\left(\widehat{T}_{h_{0}} \geq \widehat{v}_{h_{0}} z_{\alpha}\right) \tag{2.4}
\end{equation*}

Theorem 3 below uses the latter inequality to study detection of Pitman local alternatives approaching the null at a faster rate than in Horowitz and Spokoiny (2001).
3. Main results. For any integer $q$ and any $x \in \mathbb{R}^{q},|x|=\max _{1 \leq i \leq q}\left|x_{i}\right|$. For real deterministic sequences, $a_{n} \asymp b_{n}$ means that $a_{n}$ and $b_{n}$ have the same exact order, that is, there is a $C>1$ with $1 / C \leq a_{n} / b_{n} \leq C$ for $n$ large enough. For real random variables, $A_{n} \asymp \mathbb{P} B_{n}$ means that $\mathbb{P}\left(1 / C \leq A_{n} / B_{n} \leq\right.$ $C$ ) goes to 1 when $n$ grows. In such statements, uniformity with respect to a variable means that $C$ can be chosen independently of it. A sequence $\left\{m_{n}(\cdot)\right\}_{n \geq 1}$ is equicontinuous if, for any $\epsilon>0$, there is an $\eta>0$ such that $\sup _{n \geq 1}\left|m_{n}(x)-m_{n}\left(x^{\prime}\right)\right| \leq \epsilon$ for all $x, x^{\prime}$ with $\left|x-x^{\prime}\right| \leq \eta$.
3.1. Construction of the statistics and assumptions. Let $\hat{\theta}_{n}$ be the nonlinear least-squares estimator of $\theta$ in model (1.1), that is,

\widehat{\theta}_{n}=\arg \min _{\theta \in \Theta} \sum_{i=1}^{n}\left(Y_{i}-\mu\left(X_{i} ; \theta\right)\right)^{2} \tag{3.1}
\end{equation*}
$$

with an appropriate convention in case of ties. A typical statistic $\widehat{T}_{h}$ is an estimator of the mean-squared distance of the regression function from the parametric model

$$
\begin{equation*}
\min _{\theta \in \Theta} \sum_{i=1}^{n}\left(m_{n}\left(X_{i}\right)-\mu\left(X_{i} ; \theta\right)\right)^{2} \tag{3.2}
\end{equation*}
$$

From the estimated parametric residuals $\widehat{U}_{i}=Y_{i}-\mu\left(X_{i} ; \widehat{\theta}_{n}\right)=m\left(X_{i}\right)-$ $\mu\left(X_{i} ; \widehat{\theta}_{n}\right)+\varepsilon_{i}, i=1, \ldots, n$, we can estimate the departure from the parametric regression using a leave-one-out linear nonparametric estimator $\widehat{\delta}_{h}\left(X_{i}\right)=$ $\sum_{j=1, j \neq i}^{n} \nu_{i j}(h) \widehat{U}_{j}$ based on some weights $\nu_{i j}(h)$ with smoothing parameter $h$. Then (3.2) can be estimated as

\begin{equation*}
\widehat{T}_{h}=\sum_{i=1}^{n} \widehat{U}_{i} \widehat{\delta}_{h}\left(X_{i}\right)=\sum_{1 \leq i \neq j \leq n} \frac{\nu_{i j}(h)+\nu_{j i}(h)}{2} \widehat{U}_{i} \widehat{U}_{j}=\widehat{U}^{\prime} W_{h} \widehat{U}, \tag{3.3}
\end{equation*}
$$

where $\widehat{U}=\left[\widehat{U}_{1}, \ldots, \widehat{U}_{n}\right]^{\prime}$ and the generic element of $W_{h}$ is $w_{i j}(h)=\left(\nu_{i j}(h)+\right.$ $\left.\nu_{j i}(h)\right) / 2$ for $i \neq j$ and $w_{i i}(h)=0$. Such a $\widehat{T}_{h}$ is asymptotically normal under $H_{0}$; see, for example, de Jong (1987). Examples 1a and 1b come from projection methods, while Example 2 builds on kernel smoothing.

Example 1a (Regression on multivariate polynomial functions). Let $\psi_{k}(x)=\prod_{\ell=1}^{p} x_{\ell}^{k_{\ell}}$, for $k \in \mathbb{N}^{p}$ with $|k|=\max _{l=1, \ldots, p} k_{l} \leq 1 / h$. Let $\Psi_{h}=\left[\psi_{k}\left(X_{i}\right),|k| \leq\right.$ $1 / h, i=1, \ldots, n]$ and $P_{h}=\Psi_{h}\left(\Psi_{h}^{\prime} \Psi_{h}\right)^{-1} \Psi_{h}^{\prime}$ be the $n \times n$ orthogonal projection matrix onto the linear subspace of $\mathbb{R}^{n}$ spanned by $\Psi_{h}$. The matrix $W_{h}$ is obtained from $P_{h}$ by setting its diagonal elements to zero.

Example 1B (Regression on piecewise polynomial functions). Under the assumption that the support of $X$ is $[0,1]^{p}$, we consider piecewise polynomial functions of fixed order $\bar{q}$ over bins $I_{k}(h)=\prod_{\ell=1}^{p}\left[k_{\ell} h,\left(k_{\ell}+1\right) h\right)$, $k=\left(k_{1}, \ldots, k_{p}\right), k_{\ell}=0, \ldots,(1 / h)-1$. These functions write

\begin{aligned}
\psi_{q k h}(x) & =\prod_{\ell=1}^{p} x_{\ell}^{q_{\ell}} \mathbb{I}\left(x \in I_{k}(h)\right) \\
0 & \leq|q|=\max _{1 \leq \ell \leq p} q_{\ell} \leq \bar{q}, 1 \leq|k|=\max _{1 \leq \ell \leq p} k_{\ell} \leq 1 / h .
\end{aligned}
$$

The particular choice $\bar{q}=0$ corresponds to the regressogram. The matrix $W_{h}$ is constructed as in Example 1a.

Example 2 (Kernel smoothing). Consider a continuous, nonnegative, symmetric and bounded kernel $K(\cdot)$ from $\mathbb{R}^{p}$ that integrates to 1 and has a positive integrable Fourier transform. These conditions hold for products of the triangular, normal, Laplace or Cauchy kernels. Define $K_{h}(x)=$ $K\left(x_{1} / h, \ldots, x_{p} / h\right)$. We consider

\begin{aligned}
& \widehat{T}_{h}=\sum_{1 \leq i \neq j \leq n} \frac{1}{(n-1) h^{p}} \widehat{U}_{i} \frac{K_{h}\left(X_{i}-X_{j}\right)}{\sqrt{\widehat{f}_{h}\left(X_{i}\right) \widehat{f}_{h}\left(X_{j}\right)}} \widehat{U}_{j} \\
& \text { with } \widehat{f}_{h}\left(X_{i}\right)=\frac{1}{(n-1) h^{p}} \sum_{j \neq i} K_{h}\left(X_{j}-X_{i}\right) .
\end{aligned}
$$

We now turn to variance estimation. The leave-one-out construction of the $\widehat{T}_{h}$ gives that the asymptotic conditional variances $v_{h}^{2}$ and $v_{h, h_{0}}^{2}$ of $\widehat{T}_{h}$ and $\widehat{T}_{h}-\widehat{T}_{h_{0}}$ under $H_{0}$ are

v_{h}^{2} & =2 \sum_{1 \leq i, j \leq n} w_{i j}^{2}(h) \sigma^{2}\left(X_{i}\right) \sigma^{2}\left(X_{j}\right), \\
v_{h, h_{0}}^{2} & =2 \sum_{1 \leq i, j \leq n}\left(w_{i j}(h)-w_{i j}\left(h_{0}\right)\right)^{2} \sigma^{2}\left(X_{i}\right) \sigma^{2}\left(X_{j}\right) . \tag{3.4}
\end{align*}
$$

For our main examples,

$$
v_{h_{0}}^{2} \asymp_{\mathbb{P}} h_{0}^{-p} \quad \text { and } \quad v_{h, h_{0}}^{2} \asymp_{\mathbb{P}} h^{-p}-h_{0}^{-p} ;
$$

see Proposition 2 in Section 6. Let $\sigma^{2}(\cdot)$ be a nonparametric estimator of $\widehat{\sigma}^{2}(\cdot)$ such that

\max _{1 \leq i \leq n}\left|\frac{\widehat{\sigma}_{n}^{2}\left(X_{i}\right)}{\sigma^{2}\left(X_{i}\right)}-1\right|=o_{\mathbb{P}}(1) \tag{3.5}
\end{equation*}

for any equicontinuous sequence of regression functions. For instance, let

\begin{align*}
\hat{\sigma}_{n}^{2}\left(X_{i}\right)= & \frac{\sum_{j=1}^{n} Y_{j}^{2} \mathbb{I}\left(\left|X_{j}-X_{i}\right| \leq b_{n}\right)}{\sum_{j=1}^{n} \mathbb{I}\left(\left|X_{j}-X_{i}\right| \leq b_{n}\right)} \\
& -\left(\frac{\sum_{j=1}^{n} Y_{j} \mathbb{I}\left(\left|X_{j}-X_{i}\right| \leq b_{n}\right)}{\sum_{j=1}^{n} \mathbb{I}\left(\left|X_{j}-X_{i}\right| \leq b_{n}\right)}\right)^{2}, \tag{3.6}
\end{align*}
$$

where $b_{n}$ is a bandwidth parameter chosen independently of $\mathcal{H}_{n}$ such that $n^{1-4 / d^{\prime}} b_{n}^{p}$ diverges; see Proposition 3 in Section 6. Consistent estimators of the variances in (3.4) are

\widehat{v}_{h_{0}}^{2} & =2 \sum_{1 \leq i, j \leq n} w_{i j}^{2}\left(h_{0}\right) \widehat{\sigma}_{n}^{2}\left(X_{i}\right) \widehat{\sigma}_{n}^{2}\left(X_{j}\right), \\
\widehat{v}_{h, h_{0}}^{2} & =2 \sum_{1 \leq i, j \leq n}\left(w_{i j}(h)-w_{i j}\left(h_{0}\right)\right)^{2} \widehat{\sigma}_{n}^{2}\left(X_{i}\right) \widehat{\sigma}_{n}^{2}\left(X_{j}\right) .
\end{aligned}
$$

Finally, for the sake of parsimony, and following Horowitz and Spokoiny (2001), Lepski, Mammen and Spokoiny (1997) and Spokoiny (2001), the set $\mathcal{H}_{n}$ of admissible smoothing parameters is a geometric grid of $J_{n}+1$ smoothing parameters,

\mathcal{H}_{n}=\left\{h_{j}=h_{0} a^{-j}, j=0, \ldots, J_{n}\right\} \quad \text { for some } a>1, J_{n} \rightarrow+\infty . \tag{3.7}
\end{equation*}

Note that $h_{0}$ can depend on an empirical measure of the dispersion of the $X_{i}$, as in Zhang (2003), and can converge to zero very slowly, say, as $1 / \ln n$. We assume the following:

Assumption D. The i.i.d. $X_{i} \in[0,1]^{p}$ have a strictly positive continuous density over $[0,1]^{p}$.

Assumption M. The function $\mu(x ; \theta)$ is continuous with respect to $x$ in $[0,1]^{p}$ and $\theta$ in $\Theta$, where $\Theta$ is a compact subset of $\mathbb{R}^{d}$. There is a constant $\dot{\mu}$ such that for all $\theta, \theta^{\prime}$ in $\Theta$ and for all $x$ in $[0,1]^{p},\left|\mu(x ; \theta)-\mu\left(x ; \theta^{\prime}\right)\right| \leq \dot{\mu}\left|\theta-\theta^{\prime}\right|$.

Assumption E. The $\varepsilon_{i}$ are independent given $X_{1}, \ldots, X_{n}$. For each $i$, the distribution of $\varepsilon_{i}$, given the design, depends only on $X_{i}, \mathbb{E}\left[\varepsilon_{i} \mid X_{i}\right]=0$ and $\operatorname{Var}\left[\varepsilon_{i} \mid X_{i}\right]=\sigma^{2}\left(X_{i}\right)$, where the unknown variance function $\sigma^{2}(\cdot)$ is continuous and bounded away from 0 . For some $d^{\prime}>\max (d, 4), \mathbb{E}^{1 / d^{\prime}}\left[\left|\varepsilon_{i}\right|^{d^{\prime}} \mid X_{i}\right]<C_{1}$ for all $i$.

Assumption W. (i) For any $h$, the matrix $W_{h}$ is one from Example 1a, 1b or 2. (ii) The set $\mathcal{H}_{n}$ is as in (3.7) with $h_{J_{n}} \asymp(\ln n)^{C_{2} / p} n^{-2 /(4 \underline{s}+p)}$, for some $C_{2}>1$, with $\underline{s}=5 p / 4$ in Example 1a and $\underline{s}=p / 4$ in Examples 1 b and 2. The number $a$ is an integer for Example 1b.

Under Assumption M, the value of the parameter $\theta$ may not be identified, as in mixture or multiple index models. The restriction on $h_{J_{n}}$, together with the definition of $\mathcal{H}_{n}$, implies that the number $J_{n}+1$ of smoothing parameters is of order $\ln n$ at most. Assumption $\mathrm{W}(\mathrm{i})$, which considers specific nonparametric methods, will be relaxed in Section 5.1, allowing us, in particular, to consider a baseline statistic $\widehat{T}_{h_{0}}$ designed for specific parametric alternatives.
3.2. Limit behavior of the test under the null hypothesis. The next theorem allows for a penalty sequence $\gamma_{n}$ of exact order $\sqrt{2 \ln \ln n}$, as $J_{n}$ is of order $\ln n$.

Theorem 1. Consider a sequence $\left\{\mu\left(\cdot, \theta_{n}\right), \theta_{n} \in \Theta\right\}_{n \geq 1}$ in $H_{0}$. Let Assumptions $\mathrm{D}, \mathrm{M}, \mathrm{E}$ and W hold and assume that the variance estimator satisfies (3.5). If $h_{0} \rightarrow 0$ and $\gamma_{n} \rightarrow \infty$ with

the test (2.2) has level $\alpha$ asymptotically given the design, that is,

Theorem 1 is proved in two main steps. The first step consists in showing that

goes to zero. This is done by first proving that $\left(\widehat{T}_{h}-\widehat{T}_{h_{0}}\right) / \widehat{v}_{h, h_{0}}$ asymptotically behaves at first-order as $\varepsilon^{\prime}\left(W_{h}-W_{h_{0}}\right) \varepsilon / v_{h, h_{0}}$ uniformly for $h$ in
$\mathcal{H}_{n} \backslash\left\{h_{0}\right\}$, where $\varepsilon=\left[\varepsilon_{1}, \ldots, \varepsilon_{n}\right]^{\prime}$, and second by bounding the distribution tails of $\max _{h \in \mathcal{H}_{n} \backslash\left\{h_{0}\right\}} \varepsilon^{\prime}\left(W_{h}-W_{h_{0}}\right) \varepsilon / v_{h, h_{0}}$. Then we show that the limit distribution of $\widehat{T}_{h_{0}} / \widehat{v}_{h_{0}}$ is that of $\varepsilon^{\prime} W_{h_{0}} \varepsilon / v_{h_{0}}$, which converges to a standard normal when $h_{0}$ goes to 0 .

As done by Horowitz and Spokoiny (2001), Theorem 1 imposes that $h_{0}$ asymptotically vanishes. This condition yields a pivotal limit distribution for our test statistic. As shown by Hart [(1997), page 220] under stronger regularity conditions on the parametric model, considering a fixed $h_{0}$ generally yields a nonpivotal limit distribution because the estimation error $\mu\left(\cdot ; \hat{\theta}_{n}\right)-\mu(\cdot ; \theta)$ cannot be neglected. Hart (1997) then recommends the use of a double bootstrap procedure to estimate the critical values of the test.
3.3. Consistency of the test. Theorem 2 below considers general alternatives with unknown smoothness. Theorem 3 considers Pitman local alternatives. For any real $s$, let $\lfloor s\rfloor$ be the lower integer part of $s$, that is, $\lfloor s\rfloor<s \leq\lfloor s\rfloor+1$. Let the Hölder class $C_{p}(L, s)$ be the set of maps $m(\cdot)$ from $[0,1]^{p}$ to $\mathbb{R}$ with

THEOREM 2. Consider a sequence of equicontinuous regression functions $\left\{m_{n}(\cdot)\right\}_{n \geq 1}$ such that for some unknown $s>\underline{s}$ and $L>0, m_{n}(\cdot)-\mu(\cdot ; \theta) \in$ $C_{p}(L, s)$ for all $\theta$ in $\Theta$ and all $n$. Let Assumptions $\mathrm{D}, \mathrm{M}, \mathrm{E}$ and W hold. Assume that the variance estimator satisfies (3.5), that $1 /\left(C_{0} \ln n\right) \leq h_{0} \leq$ $C_{0}$ for some $C_{0}>0$ and that $\gamma_{n} \leq n^{\gamma}$ for some $\gamma$ in $(0,1)$. If

the test (2.2) is consistent given the design, that is,

provided $\kappa_{1}=\kappa_{1}(s)>0$ is large enough.
The proof is based upon the power bound (2.3). From this inequality, the test is consistent if $\widehat{T}_{h}-z_{\alpha} \widehat{v}_{h_{0}}-\gamma_{n} \widehat{v}_{h, h_{0}}$ diverges in probability for a suitable
choice of the smoothing parameter $h$ adapted to the unknown smoothness of the departure from the parametric model. Thus, combining several statistics in the procedure is crucial to detecting alternatives of unknown smoothness. A sketch of the proof is as follows. For a departure from the parametric model in $C_{p}(L, s), \widehat{T}_{h}$ estimates $\min _{\theta \in \Theta} \sum_{i=1}^{n}\left(m_{n}\left(X_{i}\right)-\mu\left(X_{i} ; \theta\right)\right)^{2}$ up to a multiplicative constant with a bias of order $n L^{2} h^{2 s}$. The standard deviation of $\widehat{T}_{h}$ is of order $h^{-p / 2}$ and the order of $\widehat{v}_{h_{0}} z_{\alpha}+\gamma_{n} \widehat{v}_{h, h_{0}}$ is $\gamma_{n} h^{-p / 2} \sup _{x \in[0,1]^{p}} \sigma^{2}(x)$. Collecting the leading terms shows that $\widehat{T}_{h}-\widehat{v}_{h_{0}} z_{\alpha}-\gamma_{n} \widehat{v}_{h, h_{0}}$ diverges if

Finding the minimum of this quantity with respect to $h$ gives the rate of (3.10). The rate of the optimal $h$ is $\left(\gamma_{n} \inf _{x \in[0,1]^{p}} \sigma^{2}(x) / L^{2} n\right)^{2 /(4 s+p)}$. The parsimonious set $\mathcal{H}_{n}$ is rich enough to contain an $h$ of this order. Our proof can be easily modified to study the selection procedures considered in Hart (1997), which use $\gamma_{n} \widehat{v}_{h}^{2}$ in (2.1) instead of $\gamma_{n} \widehat{v}_{h, h_{0}}$. This would give the worst detection rate $\left(\gamma_{n} / n\right)^{s /(2 s+p)}$.

For $\gamma_{n}$ of order $\sqrt{\ln \ln n}$, the smallest order compatible with Theorem 1, the test detects alternatives (3.10) with rate $(\sqrt{\ln \ln n} / n)^{2 s /(4 s+p)}$ for any $s>\underline{s}$. This rate is the optimal adaptive minimax one for the idealistic white noise model; see Spokoiny (1996). Horowitz and Spokoiny (2001) obtain the same rate for their kernel-based test but with minimal smoothness index $\underline{s}=\max (2, p / 4)$, while we achieve $\underline{s}=p / 4$ for our piecewise polynomial or kernel-based tests. The value $p / 4$ is critical for the smoothness index $s$, as previously noted by Guerre and Lavergne (2002) and Baraud, Huet and Laurent (2003).

Theorem 3. Let $\theta_{0}$ be an inner point of $\Theta$ and consider a sequence of local alternatives $m_{n}(\cdot)=\mu\left(\cdot ; \theta_{0}\right)+r_{n} \delta_{n}(\cdot)$, where $\left\{\delta_{n}(\cdot)\right\}_{n \geq 1}$ is an equicontinuous sequence from $C_{p}(L, s)$ for some unknown $s>\underline{s}$ and $L>0$, with

Assume that for each $x$ in $[0,1]^{p}, \mu(x ; \theta)$ is twice differentiable with respect to $\theta$ in $\Theta$ with second-order derivatives continuous in $x$ and $\theta$ and that, for
some $C_{3}>0$,

Let Assumptions D, M, E and W hold and assume that the variance estimator satisfies (3.5). If $h_{0} \rightarrow 0, r_{n} \rightarrow 0$ and $\sqrt{n h_{0}^{p / 2}} r_{n} \rightarrow \infty$, the test is consistent given the design.

The rate $r_{n}$ of Theorem 3 can be made arbitrarily close to $1 / \sqrt{n}$ by a proper choice of $h_{0}$. This improves upon Horowitz and Spokoiny (2001), who obtain the rate $\sqrt{\ln \ln n} / \sqrt{n}$.

As stated in Lemma 5 of Section 6, conditions (3.11) and the identification condition (3.12) ensure that

As the minimum of (3.13) is achieved for $\theta=\theta_{0}$ at first-order, $r_{n} \delta_{n}(\cdot)$ is asymptotically the departure from $\mu\left(\cdot ; \theta_{0}\right)$. When $r_{n}$ converges to zero, this departure becomes smoother as it belongs to the smoothness class $C_{p}\left(L r_{n}, s\right)$. This sharply contrasts with the departures from the parametric model in Theorem 2, which can be much more irregular. The proof of Theorem 3 follows from (2.4). The test is consistent as soon as $\widehat{T}_{h_{0}}-\widehat{v}_{h_{0}} z_{\alpha}$ diverges in probability. We show that $\widehat{T}_{h_{0}}$ is, up to a multiplicative constant, an estimate of $r_{n}^{2} \sum_{i=1}^{n} \delta_{n}^{2}\left(X_{i}\right)$ with a negligible bias and a standard deviation of order $h_{0}^{-p / 2}$. As $\widehat{v}_{h_{0}}$ is of order $h_{0}^{-p / 2}, \widehat{T}_{h_{0}}-\widehat{v}_{h_{0}} z_{\alpha}$ diverges to infinity as soon as $n r_{n}^{2}$ diverges faster than $h_{0}^{-p / 2}$ as required.

## 4. Bootstrap implementation and small sample behavior.

4.1. Bootstrap critical values. The wild bootstrap, initially proposed by Wu (1986), is often used in smooth lack-of-fit tests to compute small sample critical values; see, for example, Härdle and Mammen (1993). Here we use a generalization of this method, the smooth conditional moments bootstrap introduced by Gozalo (1997). It consists of drawing $n$ i.i.d. random variables $\omega_{i}$ independently from the original sample with $\mathbb{E} \omega_{i}=0$, $\mathbb{E} \omega_{i}^{2}=1$ and $\mathbb{E}\left|\omega_{i}\right|^{d^{\prime}}<\infty$, and generating bootstrap observations of $Y_{i}$ as $Y_{i}^{*}=\mu\left(X_{i}, \widehat{\theta}_{n}\right)+\widehat{\sigma}_{n}\left(X_{i}\right) \omega_{i}, i=1, \ldots, n$. A bootstrap test statistic $\widehat{T}_{\tilde{h}^{*}}^{*} / \widehat{v}_{h_{0}}^{*}$ is built from the bootstrap sample, as was the original test statistic. When this scheme is repeated many times, the bootstrap critical value $z_{\alpha, n}^{*}$ at level $\alpha$ is the empirical $1-\alpha$ quantile of the bootstrapped test statistics. This critical
value is then compared to the initial test statistic. The following theorem establishes the first-order consistency of this procedure.

Theorem 4. Let $Y_{i}=m_{n}\left(X_{i}\right)+\varepsilon_{i}, i=1, \ldots, n$, be the initial model, where $\left\{m_{n}(\cdot)\right\}_{n \geq 1}$ is any equicontinuous sequence of functions. Under the assumptions of Theorem 1 and for the variance estimator $\widehat{\sigma}_{n}^{2}\left(X_{i}\right)$ of (3.6),

4.2. Small sample behavior. We investigated the small sample behavior of our bootstrap test. We generated samples of 150 observations through the model

$$
\begin{equation*}
Y=\theta_{1}+\theta_{2} X+r \cos (2 \pi t X)+\varepsilon, \quad r \in\left\{0, \sqrt{\frac{2}{3}}\right\}, t \in\{2,5,10\} \tag{4.1}
\end{equation*}
$$

where $X$ is distributed as $U[-1,1]$. The null hypothesis corresponds to $r=$ 0 , while under the alternatives $r^{2}=2 / 3$ and $\mathbb{E}\left[r^{2} \cos ^{2}(2 \pi t X)\right] / \mathbb{E} \varepsilon^{2}=1 / 3$ for any integer $t$, a quite small signal-to-noise ratio. When $t$ increases, the deviation from the linear model becomes more oscillating and irregular, and then more difficult to detect.

To compute our test statistic, we used the regressogram method of Example 1 b with half-binwidths in

The smallest binwidth thus defines 128 cells, which is sufficient for 150 observations. The $\gamma_{n}$ was set to $c \sqrt{2 \ln J_{n}}$, where $c=1,1.5,2$. For each experiment we ran 5000 replications under the null and 1000 under the alternative. For each replication the bootstrap critical values were computed from 199 bootstrap samples. For $\omega_{i}$ we used the two-point distribution

$$

$$

which verifies the required conditions.
In a first stage we set $\left(\theta_{1}, \theta_{2}\right)=(0,0)$ and performed a test for white noise, that is, $H_{0}: m(\cdot)=0$, with homoscedastic errors following a standard normal distribution (Table 1). We estimated the variance under homoscedasticity by

\widehat{\sigma}_{n}^{2}=\frac{1}{2(n-1)} \sum_{i=1}^{n-1}\left(Y_{(i+1)}-Y_{(i)}\right)^{2},
$$

where $Y_{(i)}$ denote observations ordered according to the order of the $X_{i}$. This estimate is consistent under the null and the alternative; see Rice (1984).

In each cell of the tables, the first and second rows give empirical percentages of rejections at $2 \%$ and $5 \%$ nominal levels. We compare our test to (i) simple benchmark tests based on fixed bandwidths $h_{0}$ and $h_{5}$, to evaluate the effect of a data-driven bandwidth, (ii) the maximum test based on $\operatorname{MAX}=\max _{h \in \mathcal{H}_{n}} \widehat{T}_{h} / \widehat{v}_{h}$, to evaluate the gain of our approach and (iii) a test based on $\widehat{T}_{\tilde{h}} / \widehat{v}_{\tilde{h}}$, to evaluate the effect of our standardization. For each test, we computed bootstrap critical values as for our test.

Under the null hypothesis, the bootstrap leads to accurate rejection probabilities for all tests. Under the considered alternatives, empirical power decreases for all tests when the frequency increases from $t=2$ to $t=10$. The data-driven tests always dominate the tests based on the fixed parameter $h_{0}$, which behaves poorly. For the low frequency alternatives, data-driven tests perform very well with power greater than $90 \%$ and $95 \%$ at a $2 \%$ and $5 \%$ nominal level, respectively, and there are no significant differences between them. For higher frequency alternatives, differences are significant. Our test has quite high power and rejects the null hypothesis at more than $85 \%$ and $60 \%$ at a $5 \%$ level when $t=5$ and 10 , respectively. It performs better than or as well as does the test based on $h_{5}$ designed for irregular alternatives, except for $c=2$ and $t=10$. It always dominates Max with differences ranging from $7.1 \%$ to $18.3 \%$, depending on the level. The test based on $\widehat{T}_{\tilde{h}} / \widehat{v}_{\tilde{h}}$ behaves as the Max test. This suggests that the high performances of our test are mainly explained by our standardization choice, which is made possible by our selection procedure.

To check whether these conclusions are affected by the details of the experiments, we consider errors following a centered and standardized exponential

(Table 2), a standardized Student with five degrees of freedom (Table 3), a normal distribution with conditional variance $\sigma^{2}(X)=\left(1+3 X^{2}\right) / 3$ using our estimator (3.6) with $b_{n}=1 / 8$ (Table 4) and a linear model with homoscedastic normal errors and $\left(\theta_{1}, \theta_{2}\right)=(1,3)$ (Table 5). As results for $\widehat{T}_{\tilde{h}} / \widehat{v}_{\tilde{h}}$ are very similar to the ones for Max, we do not report them. For exponential errors, there is a slight tendency to overrejection. It is likely that matching thirdorder moments in the bootstrap sample generation as proposed by Gozalo (1997) would lead to more accurate critical values. Heteroscedasticity does not adversely affect the behavior of the tests. For the linear model, there is some gain in power for the Max test compared with Table 1, but differences with our test remain significant for the two high-frequency alternatives.

## 5. Extensions to general nonparametric methods and additive alterna-

 tives.5.1. General nonparametric methods. We give here some general sufficient conditions ensuring the validity of our results. These conditions could be checked for other smoothing methods or other designs than the ones considered here. Indeed, different smoothing methods can be used for specification testing; see, for example, Chen (1994) for spline smoothing, Fan, Zhang and Zhang (2001) for local polynomials and Spokoiny (1996) for wavelets. Also, our conditions allow for various constructions of the quadratic forms $\widehat{T}_{h}$; see, for example, Dette (1999) and Härdle and Mammen (1993).

For an $n \times n$ matrix $W$, let $\mathrm{Sp}_{n}[W]$ be its spectral radius and $N_{n}^{2}[W]=$ $\operatorname{Tr}\left[W^{\prime} W\right]=\sum_{i, j} w_{i j}^{2}$. For $W$ symmetric, the former is its largest eigenvalue in absolute value and the latter is the sum of its squared eigenvalues.

a set $\Pi_{s, n}$ of functions from $[0,1]^{p}$ to $\mathbb{R}$ such that for any $L>0$ and any $\delta(\cdot)$ in $C_{p}(L, s)$, there is a $\pi(\cdot)$ in $\Pi_{s, n}$ with $\sup _{x \in[0,1]^{p}}|\delta(x)-\pi(x)| \leq C_{4} L h_{n}^{s}$ for some $C_{4}=C_{4}(s)>0$. (iii) Let $\Lambda_{n}^{2}=\Lambda_{n}^{2}\left(s, h_{n}\right)=\inf _{\pi \in \Pi_{s, n}} \sum_{1 \leq i, j \leq n} \pi\left(X_{i}\right) p_{i j}\left(h_{n}\right) \pi\left(X_{j}\right) / \sum_{i=1}^{n} \pi\left(X_{i}\right)^{2}$, where $p_{i j}\left(h_{n}\right)$ is the generic element of $P_{h_{n}}$. For any $s>\underline{s}$, there is a constant $C_{5}=C_{5}(s)>0$ such that $\mathbb{P}\left(\Lambda_{n}>C_{5}\right) \rightarrow 1$.

Assumption W1 describes the approximation properties of the nonparametric method used to build the $W_{h}$ and allows us to extend a result of Ingster [(1993), page 253 and following]; see Lemma 6 in Section 6. The next proposition shows that our main examples satisfy Assumptions W0 and W1 under a regular i.i.d. random design.

Proposition 1. Assume that Assumption D holds, and let $\underline{s}$ be as in Assumption W. Then Examples 1a, 1b and 2 satisfy Assumptions W0 and W1.

The next theorem extends our main results under Assumptions W0 and W1. In Section 6 we actually show Theorems $1-4$ by proving Theorem 5 and Proposition 1.

Theorem 5. Theorems 1 and 4 hold under Assumption W0 in place of Assumptions D and W. Theorems 2 and 3 hold under Assumptions W0 and W1 in place of Assumptions D and W .
5.2. Additive alternatives. Our general framework easily adapts to detection of specific alternatives. We focus here on additive nonparametric
regressions $m(x)=m_{1}\left(x_{1}\right)+\cdots+m_{p}\left(x_{p}\right)$. The null hypothesis is

For ease of notation, we consider a modification of Example 1a where we remove cross-products of polynomial functions. Let $X_{i}=\left[X_{1 i}, \ldots, X_{p i}\right]^{\prime}$ and consider the $(p / h) \times n$ matrix $\Psi_{h}=\left[X_{1 i}^{k}, \ldots, X_{p i}^{k}, i=1, \ldots, n, k=0, \ldots, 1 / h\right]$. Let $W_{h}$ be the matrix obtained from $\Psi_{h}\left(\Psi_{h}^{\prime} \Psi_{h}\right)^{-1} \Psi_{h}^{\prime}$ by setting the diagonal entries to 0 and $\widehat{T}_{h}$ defined as in (3.3).

Theorem 6. Let the matrices $W_{h}$ be as above and $\mathcal{H}_{n}$ be as in (3.7), with $h_{J_{n}} \asymp(\ln n)^{C_{6}} / n^{1 / 3}$ for some $C_{6}>1$. Let Assumptions D, E and M hold. Consider a sequence of additive equicontinuous regression functions $\left\{m_{n}(\cdot)\right\}_{n \geq 1}$ and assume that the variance estimator satisfies (3.5).
(i) For $h_{0}$ and $\gamma_{n}$ as in Theorem 1, the test is asymptotically of level $\alpha$ given the design.
(ii) Assume that for some unknown $s>5 / 4$ and $L>0, m_{n}(\cdot)-\mu(\cdot ; \theta)$ is in $C_{p}(L, s)$ for all $\theta$ in $\Theta$ and all $n$. For $h_{0}$ and $\gamma_{n}$ as in Theorem 2 and

the test is consistent given the design provided $\kappa_{2}=\kappa_{2}(s)$ is large enough.
Proof of Theorem 6 repeats the proofs of Theorems 1 and 2 with $v_{h, h_{0}}^{2}$ of order $\left(h^{-1}-h_{0}^{-1}\right)$ instead of $\left(h^{-p}-h_{0}^{-p}\right)$ and is therefore omitted. One can also show consistency of the test against Pitman additive alternatives that approach the parametric model at rate $o\left(1 / \sqrt{n h_{0}^{1 / 2}}\right)$. The bootstrap procedure described in Section 4.1 also remains valid.
6. Proofs. This section is organized as follows. In Section 6.1 we study the quadratic forms $\varepsilon^{\prime}\left(W_{h}-W_{h_{0}}\right) \varepsilon$ and $\varepsilon^{\prime} W_{h} \varepsilon$ under $H_{0}$. Section 6.2 recalls some results related to variance estimation. In Section 6.3 we gather preliminary results on the parametric estimation error $m_{n}(\cdot)-\mu\left(\cdot ; \hat{\theta}_{n}\right)$. In Sections 6.4 and 6.5 we establish Theorems 1 and 4 under Assumption W0. In Sections 6.6 and 6.7 we establish Theorems 2 and 3 under Assumptions W0 and W1. Thus, Theorem 5 is a direct consequence of Sections 6.4-6.7. Section 6.8 deals with Proposition 1.

We denote $Y=\left[Y_{1}, \ldots, Y_{n}\right]^{\prime}$ and $\varepsilon=\left[\varepsilon_{1}, \ldots, \varepsilon_{n}\right]^{\prime}$. For any $\delta(\cdot)$ from $\mathbb{R}^{p}$ to $\mathbb{R}, \delta=\delta(X)=\left[\delta\left(X_{1}\right), \ldots, \delta\left(X_{n}\right)\right]^{\prime}$ and $D_{n}(\delta)$ is the $n \times n$ diagonal matrix with entries $\delta\left(X_{i}\right)$. Let $\|\cdot\|_{n}^{2}$ and $(\cdot, \cdot)_{n}$ be the Euclidean norm and inner product on $\mathbb{R}^{n}$ divided by $n$, respectively, that is,

This gives $\operatorname{Sp}_{n}[W]=\max _{\|u\|_{n}=1}\|W u\|_{n}=\max _{\|u\|_{n}=1}\left|u^{\prime} W u\right| / n$ for a symmetric $W$. Recall that $\operatorname{Sp}_{n}[A B] \leq \operatorname{Sp}_{n}[A] \operatorname{Sp}_{n}[B]$. Let $\theta_{n}=\theta_{n, m}$ be such that

We use the notation $\mathbb{P}_{n}(A)$ for $\mathbb{P}\left(A \mid X_{1}, \ldots, X_{n}\right), \mathbb{E}_{n}[\cdot]$ and $\operatorname{Var}_{n}[\cdot]$ being the associated conditional mean and variance. In what follows, $C$ and $C^{\prime}$ are positive constants that may vary from line to line. An absolute constant depends neither on the design nor on the distribution of the $\varepsilon_{i}$ given the design.
6.1. Study of quadratic forms. The proof of Lemma 1 is omitted.

Lemma 2. Let $\underline{\sigma}=\inf _{x \in[0,1]^{p}} \sigma(x)>0, \bar{\sigma}=\sup _{x \in[0,1]^{p}} \sigma(x)<\infty$ and $\nu \in$ $(0,1 / 2)$. Under Assumption E, there is an absolute constant $C=C_{\nu}>0$ such that:
(i) If $\left(\bar{\sigma}^{4} \mathrm{Sp}_{n}^{2}\left[W_{h}\right]\right) /\left(\underline{\sigma}^{4} N_{n}^{2}\left[W_{h}\right]\right) \leq \nu$,

Let $\lambda_{1}, \ldots, \lambda_{n}$ be the real eigenvalues of $W$,

Consider a vector $g$ of $n$ independent $N(0,1)$ variables, independent of the $X_{i}$. Theorem 3 of Rotar' and Shervashidze (1985) says that there is an absolute constant $C>0$ such that

& \quad \leq C\left[1-\ln \left(1-2 \Delta_{n}\right)\right]^{3 / 4} \mathcal{L}_{n}^{1 / 4} \quad \text { if } \Delta_{n}<1 / 2 .
\end{aligned}

Let $\left\{b_{i} \in \mathbb{R}^{n}\right\}_{1 \leq i \leq n}$ be an orthonormal system of eigenvectors of $W$ associated with the eigenvalues $\lambda_{i}$. As $\mathbb{E}_{n}\left[g^{\prime} W g\right]=0$ by Lemma $1, g^{\prime} W g=$ $\sum_{i=1}^{n} \lambda_{i}\left(b_{i}^{\prime} g\right)^{2}=\sum_{i=1}^{n} \lambda_{i}\left[\left(b_{i}^{\prime} g\right)^{2}-\mathbb{E}_{n}\left[\left(b_{i}^{\prime} g\right)^{2}\right]\right]$. Hence, $g^{\prime} W g$ has the same conditional distribution as $\sum_{i=1}^{n} \lambda_{i} \zeta_{i}$, where the $\zeta_{i}$ are centered Chi-squared variables with one degree of freedom, independent among themselves and of the $X_{i}$. The Berry-Esseen bound of Chow and Teicher [(1988), Theorem 3, page 304] yields that there is an absolute constant $C>0$ such that

This gives $n^{-1} \Phi_{h_{J_{n}}}^{\prime} \Phi_{h_{J_{n}}}=n^{-1} \mathbb{E} \Phi_{h_{J_{n}}}^{\prime} \Phi_{h_{J_{n}}}+R_{h_{J_{n}}}$, where $R_{h_{J_{n}}}$ is a $d_{h_{J_{n}}} \times$ $d_{h_{J_{n}}}$ matrix whose elements are uniformly $O_{\mathbb{P}}\left(\sqrt{\ln n / n h_{J_{n}}^{p}}\right)$. Thus,

$$
\operatorname{Sp}_{d_{J_{J_{n}}}}\left[R_{h_{J_{n}}}\right] \leq N_{d_{h_{J_{n}}}}\left[R_{h_{J_{n}}}\right]=O_{\mathbb{P}}\left(\frac{1}{h_{J_{n}}^{p}} \sqrt{\frac{\ln n}{n h_{J_{n}}^{p}}}\right)=o_{\mathbb{P}}(1),
$$

as $h_{J_{n}}^{-p}=o(n / \ln n)^{1 / 3}$. Hence, the eigenvalues of $n^{-1} \Phi_{h_{J_{n}}}^{\prime} \Phi_{h_{J_{n}}}$ are between the smallest and largest eigenvalues of $n^{-1} \mathbb{E} \Phi_{h_{J_{n}}}^{\prime} \Phi_{h_{J_{n}}}$, with probability tending to one. But, for any $a \in \mathbb{R}^{d_{h_{J_{n}}}}$,

$$
\begin{aligned}
n^{-1} a^{\prime} \mathbb{E} \Phi_{h_{J_{n}}}^{\prime} \Phi_{h_{J_{n}}} a & =\mathbb{E}\left(\sum_{0 \leq|k| \leq 1 / h_{J_{n}}} a_{k} \phi_{k}(X)\right)^{2} \\
& \asymp \int_{[0,1]^{p}}\left(\sum_{0 \leq|k| \leq 1 / h_{J_{n}}} a_{k} \phi_{k}(x)\right)^{2} d x=a^{\prime} a,
\end{aligned}
$$

since the $\phi_{k}(\cdot)$ are orthonormal in $L_{2}\left([0,1]^{p}, d x\right)$. Therefore, the eigenvalues of the symmetric matrix $n^{-1} \mathbb{E} \Phi_{h_{J_{n}}}^{\prime} \Phi_{h_{J_{n}}}$ are bounded away from 0 and infinity when $n$ grows. Example 1b is studied in Baraud (2002) and follows from similar arguments.

We now return to the proof of Proposition 1 for Example 1. Lemma 7 implies that, for some $C>1$,

$$
\frac{1}{C n} \Phi_{h} \Phi_{h}^{\prime} \prec P_{h}=\frac{1}{n} \Phi_{h}\left(\frac{1}{n} \Phi_{h}^{\prime} \Phi_{h}\right)^{-1} \Phi_{h}^{\prime} \prec \frac{C}{n} \Phi_{h} \Phi_{h}^{\prime},
$$

with probability tending to 1 , where $\prec$ is the ordering of symmetric matrices. Because $p_{i i}(h)=e_{i}^{\prime} P_{h} e_{i}$, where $\left\{e_{i}\right\}_{1 \leq i \leq n}$ is the canonical basis of $\mathbb{R}^{n}$, this gives

$$
\left|p_{i i}(h)\right| \leq \begin{cases}\frac{C}{n} \sum_{|k| \leq 1 / h} \phi_{k}^{2}\left(X_{i}\right) \leq C /\left(n h^{2 p}\right), & \text { for Example 1a }  \tag{6.11}\\ \frac{C}{n} \sum_{|k| \leq 1 / h, q \leq \bar{q}} \phi_{q k h}^{2}\left(X_{i}\right) \leq C /\left(n h^{p}\right), & \text { for Example 1b }\end{cases}
$$

with probability going to 1 and uniformly in $i=1, \ldots, n$ and $h \in \mathcal{H}_{n}$. Indeed, $\phi_{k}^{2}(\cdot) \leq C h^{-p}$ for all $k \leq 1 / h$ for Example 1a, while $\phi_{q k h}^{2}\left(X_{i}\right)$ vanishes except for exactly one index $k$ with $\phi_{q k h}^{2}\left(X_{i}\right) \leq C h^{-p}$ for Example 1b.

To prove Assumption W0(ii), note that $\mathrm{Sp}_{n}\left[P_{h}\right]=1$ since $P_{h}$ is an orthogonal projection. The triangular inequality gives $\max _{h \in \mathcal{H}_{n}} \operatorname{Sp}_{n}\left[W_{h}\right] \leq$ $1+\max _{h \in \mathcal{H}_{n}} \max _{1 \leq i \leq n}\left|p_{i i}(h)\right|=O_{\mathbb{P}}(1)$ by (6.11) and the restriction on $h_{J_{n}}$ which gives $h_{J_{n}}^{-2 p}=o(n)$ for Example 1a and $h_{J_{n}}^{-p}=o(n)$ for Example 1b. For Assumption W0(iii), we have

$$
\begin{aligned}
N_{n}^{2}\left[W_{h}\right] & =N_{n}^{2}\left[P_{h}\right]-N_{n}^{2}\left[W_{h}-P_{h}\right], \\
N_{n}^{2}\left[W_{h}-W_{h_{0}}\right] & =N_{n}^{2}\left[P_{h}-P_{h_{0}}\right]-N_{n}^{2}\left[\left(W_{h}-P_{h}\right)-\left(W_{h_{0}}-P_{h_{0}}\right)\right] .
\end{aligned}
$$

Now $N_{n}^{2}\left[P_{h}\right]=\operatorname{Rank}\left[P_{h}\right]$ and $N_{n}^{2}\left[P_{h}-P_{h_{0}}\right]=\operatorname{Rank}\left[P_{h}-P_{h_{0}}\right]$, since $P_{h}$ and $P_{h}-P_{h_{0}}$ are orthogonal projections. This gives $N_{n}^{2}\left[P_{h}\right] \asymp h^{-p}$ and $N_{n}^{2}\left[P_{h}-\right.$ $\left.P_{h_{0}}\right] \asymp_{\mathbb{P}} h^{-p}-h_{0}^{-p}$ almost surely for Example 1a, and for Example 1b, using the Bernstein inequality with $h_{J_{n}}^{-p}=o(n / \ln n)$, ensuring that the number of $X_{i}$ in each bin $I_{k}(h)$ diverges. Then, since $N_{n}^{2}\left[W_{h}-P_{h}\right]=\sum_{i=1}^{n} p_{i i}^{2}(h)$, Assumption W0(iii) holds if

$$
\max _{h \in \mathcal{H}_{n}} h^{p} \sum_{i=1}^{n} p_{i i}^{2}(h)=o_{\mathbb{P}}(1)
$$

and

$$
\max _{h \in \mathcal{H}_{n} \backslash h_{0}}\left(h^{-p}-h_{0}^{-p}\right)^{-1} \sum_{i=1}^{n}\left(p_{i i}(h)-p_{i i}\left(h_{0}\right)\right)^{2}=o_{\mathbb{P}}(1),
$$

which is a consequence of (6.11), together with $h_{J_{n}}^{-3 p}=o(n / \ln n)$ for Example 1a and $h_{J_{n}}^{-p}=o(n / \ln n)$ for Example 1b. To show Assumption W1(i), note that the $P_{h}$ are symmetric positive semidefinite with $\max _{h \in \mathcal{H}_{n}} \mathrm{Sp}_{n}\left[W_{h}-\right.$ $\left.P_{h}\right]=o_{\mathbb{P}}(1)$, as shown when establishing Assumption W0(ii). For Assumption W1(ii), (iii), consider first Example 1a. Let $\Pi_{s, h}$ be the set of polynomial functions with order $1 / h$ which are such that Assumption W1(ii) holds by the multivariate Jackson theorem; see, for example, Lorentz (1966). This choice of $\Pi_{s, h}$ gives $\Lambda_{n}^{2}=1$ almost surely by definition of the $P_{h}$ with
$h_{J_{n}}^{-p}=o(n)$ and Assumption D. For Example 1b, the proof of Assumtion W1(ii) uses the same Taylor expansion as in Guerre and Lavergne (2002) to build the $\Pi_{s, h}$. Assumption W1(iii), for any given $\bar{q}$, is a consequence of Assumption W1(iii) for $\bar{q}=1$. This can be shown using Guerre and Lavergne (2002) and establishing convergence of local empirical moments with repeated applications of the Bernstein inequality.
