Gin AND Lex OF CERTAIN MONOMIAL IDEALS

ABSTRACT. Let $A = K[x_1, \ldots, x_n]$ denote the polynomial ring in n variables over a field K of characteristic 0 with each deg $x_i = 1$. Given arbitrary integers i and j with $2 \leq i \leq n$ and $3 \leq j \leq n$, we will construct a monomial ideal $I \subset A$ such that (i) $\beta_k(I) < \beta_k(\operatorname{Gin}(I))$ for all k < i, (ii) $\beta_i(I) = \beta_i(\operatorname{Gin}(I))$, (iii) $\beta_\ell(\operatorname{Gin}(I)) < \beta_\ell(\operatorname{Lex}(I))$ for all $\ell < j$ and (iv) $\beta_j(\operatorname{Gin}(I)) = \beta_j(\operatorname{Lex}(I))$, where $\operatorname{Gin}(I)$ is the generic initial ideal of I with respect to the reverse lexicographic order induced by $x_1 > \cdots > x_n$ and where $\operatorname{Lex}(I)$ is the lexsegment ideal with the same Hilbert function as I.

INTRODUCTION

Let $A = K[x_1, \ldots, x_n]$ denote the polynomial ring in n variables over a field K of characteristic 0 with each deg $x_i = 1$. Let $<_{\text{lex}}$ (resp. $<_{\text{rev}}$) denote the lexicographic (resp. reverse lexicographic) order on A induced by the ordering $x_1 > \cdots > x_n$ of the variables. Given a homogeneous ideal I of A, we write Gin(I) for the generic initial ideal ([6, p. 348]) of I with respect to $<_{\text{rev}}$ and Lex(I) for the lexsegment ideal ([2] and [11]) with the same Hilbert function as I. Let $\beta_i(I) = \dim_K \text{Tor}_i^A(K, I)$ denote the *i*th Betti number of I over A. It is known that

$$\beta_i(I) \le \beta_i(\operatorname{Gin}(I)) \le \beta_i(\operatorname{Lex}(I))$$

for all $i \ge 0$. One has $\beta_i(I) = \beta_i(\operatorname{Gin}(I))$ for all i if and only if I is componentwise linear ([1]). One has $\beta_i(I) = \beta_i(\operatorname{Lex}(I))$ for all i if and only if I is Gotzmann ([10]). On the other hand, the following facts are due to [5, Corollary 2.7]:

- (i) If $\beta_i(I) = \beta_i(\operatorname{Gin}(I))$ for some *i*, then $\beta_k(I) = \beta_k(\operatorname{Gin}(I))$ for all $k \ge i$;
- (ii) If $\beta_i(I) = \beta_i(\text{Lex}(I))$ for some *i*, then $\beta_k(I) = \beta_k(\text{Lex}(I))$ for all $k \ge i$.

These behaviors of Betti numbers of Gin(I) and Lex(I) would naturally lead us to present the following

Question 0.1. Given arbitrary integers $1 \le i \le j \le n$, does there exist a monomial ideal I of $A = K[x_1, \ldots, x_n]$ with the properties that

(i)
$$\beta_k(I) < \beta_k(\operatorname{Gin}(I))$$
 for all $k < i$;

- (ii) $\beta_i(I) = \beta_i(\operatorname{Gin}(I));$
- (ii) $\beta_{\ell}(I) < \beta_{\ell}(\text{Lex}(I))$ for all $\ell < j$;
- (ii) $\beta_i(I) = \beta_i(\text{Lex}(I))$?

The above question 0.1 does ask the relation between the Betti numbers of I and Gin(I) together with the relation between the Betti numbers of I and Lex(I). In the present paper, however, the study of the relation among the Betti numbers of I, Gin(I) and Lex(I) will be achieved. Our goal is to show the following

Theorem 0.2. Let $A = K[x_1, \ldots, x_n]$ denote the polynomial ring in n variables over a field K of characteristic 0 with each deg $x_i = 1$. Given arbitrary integers iand j with $2 \le i \le n$ and $3 \le j \le n$, there exists a monomial ideal $I \subset A$ such that

(i) $\beta_k(I) < \beta_k(\operatorname{Gin}(I))$ for all k < i; (ii) $\beta_i(I) = \beta_i(\operatorname{Gin}(I))$; (iii) $\beta_\ell(\operatorname{Gin}(I)) < \beta_\ell(\operatorname{Lex}(I))$ for all $\ell < j$; (iv) $\beta_j(\operatorname{Gin}(I)) = \beta_j(\operatorname{Lex}(I))$.

A monomial ideal required in Theorem 0.2 will be given in Section 2 in case of $2 \le i < j \le n$ and in Section 3 in case of $3 \le j \le i \le n$. On the other hand, in Section 1, the reason why the assumption $3 \le j$ is indispensable in Theorem 0.2 will be explained.

1. Betti numbers of strongly stable ideals

Let $A = K[x_1, \ldots, x_n]$ denote the polynomial ring in n variables over a field K of characteristic 0 with each deg $x_i = 1$. Recall that a monomial ideal I of A is strongly stable if u is a monomial belonging to I and if u is divided by x_p , then $x_q u/x_p \in I$ for all q < p. Since the base field K is of characteristic 0, the generic initial ideal Gin(I) of an arbitrary homogeneous ideal of A is strongly stable ([6, Theorem 15.23]).

Lemma 1.1 below explains the reason why the assumption $3 \le j$ is indispensable in Theorem 0.2.

Lemma 1.1. Let $I \subset A$ be a strongly stable monomial ideal and suppose that $\beta_i(I) = \beta_i(\text{Lex}(I))$ for all $i \geq 2$. Then $\beta_i(I) = \beta_i(\text{Lex}(I))$ for all $i \geq 0$.

Proof. Let I be a strongly stable ideal. We write $m_{\leq k}(I, j)$ for the number of those monomials $u \in I$ of degree j with $m(u) \leq k$, where m(u) is the largest integer q for which x_q divides u. The computation of the Betti numbers of a strongly stable ideal can be done by using the formura [2, Proposition 2.3] which says that

$$\beta_{i,i+j}(I) = C - D,\tag{1}$$

where

$$C = m_{\leq n}(I,j) \binom{n-1}{i},$$

$$D = \sum_{k=i}^{n-1} m_{\leq k}(I,j) \binom{k-1}{i-1} + \sum_{k=i+1}^{n} m_{\leq k}(I,j-1) \binom{k-1}{i}.$$

Since Lex(I) and I have the same Hilbert function, one has $m_{\leq n}(\text{Lex}(I), j) = m_{\leq n}(I, j)$ for all j. In addition, it is known [2, Theorem 2.1] that $m_{\leq k}(\text{Lex}(I), j) \leq m_{\leq k}(I, j)$ for all j and k. Thus, since $\beta_{i,i+j}(I) = \beta_{i,i+j}(\text{Lex}(I))$ for all $i \geq 2$ and for all j, it follows that $m_{\leq k}(\text{Lex}(I), j) = m_{\leq k}(I, j)$ for all j and for all $k \geq 2$. On the other hand, since I is strongly stable, one has $m_{\leq 1}(I, j) = 1$ unless $I_j = (0)$, where I_j is the jth graded component of I. Hence $m_{\leq 1}(\text{Lex}(I), j) = m_{\leq 1}(I, j)$ for all j. Thus $m_{\leq k}(\text{Lex}(I), j) \leq m_{\leq k}(I, j)$ for all j and for all k. \Box

On the other hand, the reason why the assumption $2 \leq i$ is indispensable in Theorem 0.2 is clear. In fact, if $\beta_1(I) = \beta_1(\operatorname{Gin}(I))$, then $\beta_i(I) = \beta_i(\operatorname{Gin}(I))$ for all $i \geq 0$. To see why this is true, suppose that $\beta_1(I) = \beta_1(\operatorname{Gin}(I))$. Then $\beta_i(I) = \beta_i(\operatorname{Gin}(I))$ for all $i \geq 1$. Since $\beta_{i,i+j}(I) \leq \beta_{i,i+j}(\operatorname{Gin}(I))$ for all i and for all j, one has $\beta_{i,i+j}(I) = \beta_{i,i+j}(\operatorname{Gin}(I))$ for all $i \geq 1$ and for all j. Since both I and $\operatorname{Gin}(I)$ have the same Hilbert function, it follows that $\beta_{0,j}(I) = \beta_{0,j}(\operatorname{Gin}(I))$ for all j. Thus in particular $\beta_0(I) = \beta_0(\operatorname{Gin}(I))$, as desired.

2. Construction in the case of $2 \le i < j \le n$

Theorem 0.2 is divided into Theorem 2.1 and Theorem 3.1. A desired monomial ideal in the case of $2 \le i < j \le n$ will be given in Theorem 2.1 and that in the case of $3 \le j \le i \le n$ will be given in Theorem 3.1.

Theorem 2.1. Let $A = K[x_1, \ldots, x_n]$ denote the polynomial ring in n variables over a field K of characteristic 0 with each deg $x_i = 1$. Fix arbitrary integers i and j with $1 < i < j \le n$ and J the monomial ideal of A which is generated by those quadratic monomials $x_p x_q$, $1 \le p \le q \le n$, with $x_{i-1} x_j <_{\text{lex}} x_p x_q$. Suppose that I is the monomial ideal

$$I = (x_1, \dots, x_n)^3 + J + (x_n^2)$$

of A. Then one has

- (i) $\beta_k(I) < \beta_k(\operatorname{Gin}(I))$ for all k < i; (ii) $\beta_i(I) = \beta_i(\operatorname{Gin}(I))$;
- (iii) $\beta_{\ell}(\operatorname{Gin}(I)) < \beta_{\ell}(\operatorname{Lex}(I))$ for all $\ell < j$;
- (iv) $\beta_j(\operatorname{Gin}(I)) = \beta_j(\operatorname{Lex}(I)).$

Proof. (*First Step*) Given a monomial ideal L of $A = K[x_1, \ldots, x_n]$ generated by quadratic monomials, we introduce a finite graph $\Gamma(L)$ on the vertex set

$$V = \{1, \dots, n, 1', \dots, n'\}$$

whose edge set $E(\Gamma(L))$ consists of those edges

- (i) $\{p,q\}$ with $1 \le p < q \le n$ such that $x_p x_q \notin L$;
- (ii) $\{p,q'\}$ with $1 \le p \le n, 1 \le q \le n$ and $p \ne q$;
- (iii) $\{p, p'\}$ with $1 \le p \le n$ such that $x_p^2 \notin L$.

If $W \subset V$, then we write $\Gamma(L)_W$ for the induced subgraph of $\Gamma(L)$ on W. Let $\delta(\Gamma(L)_W)$ denote the number of connected component of $\Gamma(L)_W$.

By using Hochster's formula [3, Theorem 5.1.1] together with the polarization technique [3, Lemma 4.2.16], it follows that the Betti number $\beta_{k,k+2}(L) = \dim_K[\operatorname{Tor}_k^A(K,I)]_{k+2}$ can be computed by the formula

$$\beta_{k,k+2}(L) = \sum_{W \subset V, \ |W|=k+2} (\delta(\Gamma(L)_W) - 1).$$
(2)

(Second Step) Let $Gin_{\leq_{lex}}(I)$ denote the generic initial ideal of I with respect to the lexicographic order \leq_{lex} . We claim

$$Gin(I) = (x_1, \dots, x_n)^3 + J + (x_i^2);$$

$$Lex(I) = Gin_{<_{lex}}(I) = (x_1, \dots, x_n)^3 + J + (x_{i-1}x_j).$$

Assume that the general linear group $\operatorname{GL}(n; K)$ acts linearly on A. Let $\psi \in \operatorname{GL}(n; K)$. Then $\operatorname{Gin}(\psi(I)) = \operatorname{Gin}(I)$ and $\operatorname{Gin}_{\leq_{\operatorname{lex}}}(\psi(I)) = \operatorname{Gin}_{\leq_{\operatorname{lex}}}(I)$.

- Let $\varphi \in \operatorname{GL}(n; K)$ be defined by $\varphi(x_i) = x_i$ for all $i \neq n$ and $\varphi(x_n) = x_i + x_n$. Then the initial ideal $\operatorname{in}_{<_{\operatorname{rev}}}(\varphi(I))$ of $\varphi(I)$ with respect to $<_{\operatorname{rev}}$ coincides with the strongly stable ideal $(x_1, \ldots, x_n)^3 + J + (x_i^2)$. Hence $\operatorname{Gin}(\operatorname{in}_{<_{\operatorname{rev}}}(\varphi(I))) = (x_1, \ldots, x_n)^3 + J + (x_i^2)$. Since $\operatorname{in}_{<_{\operatorname{rev}}}(\varphi(I))$ contains all monomials $x_p x_q$, $1 \leq p \leq q \leq n$, with $x_i^2 \leq_{\operatorname{rev}} x_p x_q$, it follows from [4, Corollary 1.6] that $x_i^2 \in \operatorname{Gin}(\varphi(I))$. Moreover, since J is strongly stable and $J \subset \varphi(I)$, one has $J = \operatorname{Gin}(J) \subset \operatorname{Gin}(\varphi(I))$. Thus $(x_1, \ldots, x_n)^3 + J + (x_i^2) \subset \operatorname{Gin}(\varphi(I)) = \operatorname{Gin}(I)$. Hence $\operatorname{Gin}(I) = (x_1, \ldots, x_n)^3 + J + (x_i^2)$, as desired.
- Let $\varphi \in \operatorname{GL}(n; K)$ be defined by $\varphi(x_i) = x_i$ for all $i \neq n$ and $\varphi(x_n) = x_{i-1} + x_j + x_n$. Then the initial ideal $\operatorname{in}_{<_{\operatorname{lex}}}(\varphi(I))$ of $\varphi(I)$ with respect to $<_{\operatorname{lex}}$ coincides with the strongly stable ideal $(x_1, \ldots, x_n)^3 + J + (x_{i-1}x_j)$. Hence $\operatorname{Gin}_{<_{\operatorname{lex}}}(\operatorname{in}_{<_{\operatorname{lex}}}(\varphi(I))) = (x_1, \ldots, x_n)^3 + J + (x_{i-1}x_j)$. Since $\operatorname{in}_{<_{\operatorname{lex}}}(\varphi(I))$ contains all monomials $x_p x_q$, $1 \leq p \leq q \leq n$, with $x_{i-1} x_j \leq_{\operatorname{lex}} x_p x_q$, it follows from [4, Corollary 1.6] that $x_{i-1} x_j \in \operatorname{Gin}_{<_{\operatorname{lex}}}(\varphi(I))$. Moreover, since J is strongly stable and $J \subset \varphi(I)$, one has $J = \operatorname{Gin}_{<_{\operatorname{lex}}}(J) \subset \operatorname{Gin}_{<_{\operatorname{lex}}}(\varphi(I))$. Thus $(x_1, \ldots, x_n)^3 + J + (x_{i-1}x_j) \subset \operatorname{Gin}_{<_{\operatorname{lex}}}(\varphi(I)) = \operatorname{Gin}_{<_{\operatorname{lex}}}(I)$. Hence $\operatorname{Gin}_{<_{\operatorname{lex}}}(I) = (x_1, \ldots, x_n)^3 + J + (x_{i-1}x_j)$. Since the ideal $J + (x_{i-1}x_j)$ is lexsegment, one has $\operatorname{Lex}(I) = (x_1, \ldots, x_n)^3 + J + (x_{i-1}x_j)$. Hence $\operatorname{Lex}(I) = \operatorname{Gin}_{<_{\operatorname{lex}}}(I) = (x_1, \ldots, x_n)^3 + J + (x_{i-1}x_j)$, as desired.

(*Third Step*) We compute

$$\beta_{k,k+2}(I) = \beta_{k,k+2}(J + (x_n^2));$$

$$\beta_{k,k+2}(Gin(I)) = \beta_{k,k+2}(J + (x_i^2));$$

$$\beta_{k,k+2}(Lex(I)) = \beta_{k,k+2}(J + (x_{i-1}x_j)),$$

based on the formula (1) together with the combinatorics on the finite graphs $\Gamma(J), \Gamma(J + (x_n^2)), \Gamma(J + (x_i^2))$ and $\Gamma(J + (x_{i-1}x_j))$ with

$$E(\Gamma(J + (x_n^2))) = E(\Gamma(J)) \setminus \{\{n, n'\}\}; E(\Gamma(J + (x_i^2))) = E(\Gamma(J)) \setminus \{\{i, i'\}\}; E(\Gamma(J + (x_{i-1}x_j))) = E(\Gamma(J)) \setminus \{\{i - 1, j\}\}$$

- Let $W \subset V$ with |W| = k+2 and suppose that $\delta(\Gamma(J+(x_n^2))_W) > \delta(\Gamma(J)_W)$. Then (i) both n and n' belong to W, (ii) no connected component of $\Gamma(J+(x_n^2))_W$ contains both n and n', and (iii) $\delta(\Gamma(J+(x_n^2))_W) = \delta(\Gamma(J)_W) + 1$. Since $\{\alpha, n'\}$ is an edge of $\Gamma(J)$ for all $\alpha \in V$ with $\alpha \neq n'$ and since $\{\beta, n\}$ is an edge of $\Gamma(J)$ if and only if $\beta \in V \setminus \{1, 2, \ldots, i-2\}$, it follows that $W \setminus \{n, n'\} \subset \{1, 2, \ldots, i-2\}$. Hence the number of subsets $W \subset V$ with |W| = k+2 such that $\delta(\Gamma(J+(x_n^2))_W) > \delta(\Gamma(J)_W)$ is $\binom{i-2}{k}$.
- Let $W \subset V$ with |W| = k+2 and suppose that $\delta(\Gamma(J+(x_i^2))_W) > \delta(\Gamma(J)_W)$. Then (i) both *i* and *i'* belong to *W*, (ii) no connected component of $\Gamma(J + (x_n^2))_W$ contains both *i* and *i'*, and (iii) $\delta(\Gamma(J+(x_i^2))_W) = \delta(\Gamma(J)_W) + 1$. Since $\{\alpha, i'\}$ is an edge of $\Gamma(J)$ for all $\alpha \in V$ with $\alpha \neq i'$ and since $\{\beta, i\}$

is an edge of $\Gamma(J)$ if and only if $\beta \in V \setminus \{1, 2, \dots, i-1\}$, it follows that $W \setminus \{i, i'\} \subset \{1, 2, \dots, i-1\}$. Hence the number of subsets $W \subset V$ with |W| = k + 2 such that $\delta(\Gamma(J + (x_i^2))_W) > \delta(\Gamma(J)_W)$ is $\binom{i-1}{k}$.

• Let $W \subset V$ with |W| = k + 2 and suppose that $\delta(\Gamma(J + (x_{i-1}x_j))_W) > \delta(\Gamma(J)_W)$. Then (i) both i - 1 and j belong to W, (ii) no connected component of $\Gamma(J + (x_{i-1}x_j))_W$ contains both i - 1 and j, and (iii) $\delta(\Gamma(J + (x_{i-1}x_j))_W) = \delta(\Gamma(J)_W) + 1$. Since $\{\alpha, i - 1\}$ is an edge of $\Gamma(J)$ if and only if

$$\alpha \in \{j, j+1, \dots, n\} \bigcup (\{1', 2', \dots, n'\} \setminus \{(i-1)'\})$$

and since $\{\beta, j\}$ is an edge of $\Gamma(J)$ if and only if

$$\beta \in (\{i-1, i, \dots, n\} \setminus \{j-1\}) \bigcup \{1', 2', \dots, n'\},\$$

it follows that

$$W \setminus \{i, i'\} \subset \{1, 2, \dots, i - 2, (i - 1)', i, i + 1, \dots, j - 1\}.$$

Hence the number of subsets $W \subset V$ with |W| = k + 2 such that $\delta(\Gamma(J + (x_{i-1}x_j))_W) > \delta(\Gamma(J)_W)$ is $\binom{j-1}{k}$.

Hence

$$\beta_{k,k+2}(I) = \beta_{k,k+2}(J) + \binom{i-2}{k};$$

$$\beta_{k,k+2}(\operatorname{Gin}(I)) = \beta_{k,k+2}(J) + \binom{i-1}{k};$$

$$\beta_{k,k+2}(\operatorname{Lex}(I)) = \beta_{k,k+2}(J) + \binom{j-1}{k}.$$

Thus in particular

- (i) $\beta_{k,k+2}(I) < \beta_{k,k+2}(\operatorname{Gin}(I))$ for all k < i; (ii) $\beta_{k,k+2}(I) = \beta_{k,k+2}(\operatorname{Gin}(I))$ for all $k \ge i$; (iii) $\beta_{\ell,\ell+2}(\operatorname{Gin}(I)) < \beta_{\ell,\ell+2}(\operatorname{Lex}(I))$ for all $\ell < j$; (iv) $\beta_{\ell,\ell+2}(\operatorname{Gin}(I)) = \beta_{\ell,\ell+2}(\operatorname{Lex}(I))$ for all $\ell > i$.
- (iv) $\beta_{\ell,\ell+2}(\operatorname{Gin}(I)) = \beta_{\ell,\ell+2}(\operatorname{Lex}(I))$ for all $\ell \ge j$.

(*Fourth Step*) Since the regularity of each of I, Gin(I) and Lex(I) is 3, it follows that

$$\beta_{p,p+q}(I) = \beta_{p,p+q}(\operatorname{Gin}(I)) = \beta_{p,p+q}(\operatorname{Lex}(I)) = 0$$

for all q > 3. The cancellation principle [8, Corollary 1.21] now guarantees that

$$\beta_{k,k+2}(\operatorname{Gin}(I)) - \beta_{k,k+2}(I) = \beta_{(k-1),(k-1)+3}(\operatorname{Gin}(I)) - \beta_{(k-1),(k-1)+3}(I)$$

for all k. Since $\beta_{k,k+2}(I) = \beta_{k,k+2}(\operatorname{Gin}(I))$ for all $k \ge i$, one has

$$\beta_{(k-1),(k-1)+3}(I) = \beta_{(k-1),(k-1)+3}(\operatorname{Gin}(I))$$

for all $k-1 \ge i-1$. Hence $\beta_k(I) = \beta_k(\operatorname{Gin}(I))$ for all $k \ge i$. Similarly, since $\operatorname{Lex}(I) = \operatorname{Gin}_{\leq_{\operatorname{lex}}}(I)$, by using the cancellation principle to $\operatorname{Gin}_{\leq_{\operatorname{lex}}}(I)$, one has $\beta_\ell(I) = \beta_\ell(\operatorname{Lex}(I))$ for all $\ell \ge j$, as reqired. \Box

3. Construction in the case of $3 \le j \le i \le n$

A monomial ideal in the case of $3 \le j \le i \le n$ in Theorem 0.2 will be given in Theorem 3.1. Note that in Theorem 3.1 we use i + 1 and j + 1 instead of i and j, so that we work with fixing arbitrary integers i and j with $2 \le j \le i < n$.

Theorem 3.1. Let $A = K[x_1, \ldots, x_n]$ denote the polynomial ring in n variables over a field K of characteristic 0 with each deg $x_i = 1$. Fix arbitrary integers i and j with $2 \leq j \leq i < n$. Let H denote the monomial ideal of A which is generated by those quadratic monomials $x_p x_q$, $1 \leq p \leq q \leq n$, with $x_{j-1} x_j \leq_{\text{lex}} x_p x_q$. Let Gdenote the monomial ideal of A which is generated by those quadratic monomials $x_p x_q$, $2 \leq p \leq q \leq n$, with $x_i^2 \leq_{\text{lex}} x_p x_q$. Suppose that I is the monomial ideal

$$I = x_1(H + (x_n^2)) + x_1(x_1, \dots, x_n)^3 + x_2^2(G + (x_n^2)) + (x_1, \dots, x_n)^5$$

of A. Then one has

(i) $\beta_k(I) < \beta_k(\operatorname{Gin}(I))$ for all $k \le i$; (ii) $\beta_{i+1}(I) = \beta_{i+1}(\operatorname{Gin}(I))$; (iii) $\beta_\ell(\operatorname{Gin}(I)) < \beta_\ell(\operatorname{Lex}(I))$ for all $\ell \le j$; (iv) $\beta_{i+1}(\operatorname{Gin}(I)) = \beta_{i+1}(\operatorname{Lex}(I))$.

Proof. (*First Step*) First, we discuss the relation between $\beta_k(\text{Gin}(I))$ and $\beta_k(\text{Lex}(I))$. The same techniques as in Second Step of the proof of Theorem 2.1 yields that

$$Gin(I) = x_1(H + (x_j^2)) + x_1(x_1, \dots, x_n)^3 + x_2^2(G + (x_i x_{i+1})) + (x_1, \dots, x_n)^5;$$

$$Lex(I) = x_1(H + (x_{j-1} x_{j+1})) + x_1(x_1, \dots, x_n)^3 + x_2^2(G + (x_i x_{i+1})) + (x_1, \dots, x_n)^5.$$

Since $\operatorname{Gin}(I)_d = \operatorname{Lex}(I)_d$ for all $d \ge 4$, one has $m_{\le k}(\operatorname{Gin}(I), d) = m_{\le k}(\operatorname{Lex}(I), d)$ for all k and for all $d \ge 4$. In addition, $m_{\le k}(\operatorname{Gin}(I), 3) = m_{\le k}(\operatorname{Lex}(I), 3)$ for all $k \ne j$ and $m_{\le j}(\operatorname{Gin}(I), 3) < m_{\le j}(\operatorname{Lex}(I), 3)$. It then follows from the formula (2) that

$$\begin{aligned} \beta_{j+1}(\operatorname{Gin}(I)) &= \beta_{j+1}(\operatorname{Lex}(I)); \\ \beta_k(\operatorname{Gin}(I)) &< \beta_k(\operatorname{Lex}(I)) \quad \text{for all} \quad k \le j. \end{aligned}$$

(Second Step) Let $\tilde{I} = x_1 H$. We claim that

$$\beta_{k,k+3}(I) = \beta_{k,k+3}(\tilde{I}) + \binom{j-2}{k};$$

$$\beta_{k,k+3}(\operatorname{Gin}(I)) = \beta_{k,k+3}(\tilde{I}) + \binom{j-1}{k}.$$

Let $I_{\leq d}$ denote the ideal generated by those monomials $u \in I$ with deg $u \leq d$. Recall that $\beta_{i,i+d}(I) = \beta_{i,i+d}(I_{\leq d})$ ([10, Lemma 1.2]). Thus $\beta_{k,k+3}(I) = \beta_{k,k+3}(I_{\leq 3})$ and $\beta_{k,k+3}(\operatorname{Gin}(I)) = \beta_{k,k+3}(\operatorname{Gin}(I)_{\leq 3})$. Since $I_{\leq 3} = x_1(H + (x_n^2))$ and $\operatorname{Gin}(I)_{\leq 3} = x_1(H + (x_j^2))$, one has $\beta_{k,k+3}(I_{\leq 3}) = \beta_{k,k+2}((H + (x_n^2)))$ and $\beta_{k,k+3}(\operatorname{Gin}(I)_{\leq 3}) = \beta_{k,k+2}((H + (x_j^2)))$. It follows from the same computation as in Third Step of the proof of Thorem 2.1 that

$$\beta_{k,k+3}(I) = \beta_{k,k+2}((H + (x_n^2))) = \beta_{k,k+2}(H) + \binom{j-2}{k} = \beta_{k,k+3}(\tilde{I}) + \binom{j-2}{k};$$

$$\beta_{k,k+3}(\operatorname{Gin}(I)) = \beta_{k,k+2}((H + (x_j^2))) = \beta_{k,k+2}(H) + \binom{j-1}{k} = \beta_{k,k+3}(\tilde{I}) + \binom{j-1}{k}.$$

(*Third Step*) We now turn to the computation of $\beta_{k,k+4}(I)$ and $\beta_{k,k+4}(Gin(I))$. Let

$$J = x_1(H + (x_j^2)) + x_1(x_1, \dots, x_n)^3 + x_2^2G;$$

$$\tilde{J} = x_1(H + (x_n^2)) + x_1(x_1, \dots, x_n)^3 + x_2^2G.$$

We claim that

$$\beta_{k,k+4}(I) = \beta_{k,k+4}(J) + \binom{i-1}{k} - \binom{j-1}{k+1} + \binom{j-2}{k+1};$$
(3)

$$\beta_{k,k+4}(\operatorname{Gin}(I)) = \beta_{k,k+4}(J) + \binom{i}{k}.$$
(4)

(3.1) Since $J_{\leq 3} = \operatorname{Gin}(I)_{\leq 3}$ and $\tilde{J}_{\leq 3} = I_{\leq 3}$, one has $\beta_{k,k+3}(J) = \beta_{k,k+3}(\operatorname{Gin}(I))$ and $\beta_{k,k+3}(\tilde{J}) = \beta_{k,k+3}(I)$. Let $J_{\geq d}$ denote the ideal generated by those monomials $u \in J$ with deg $u \geq d$. Since $J_{\geq 4}$ and $\tilde{J}_{\geq 4}$ are strongly stable, the regularity of each of J and \tilde{J} is 4. Thus, since $\operatorname{Gin}(\tilde{J}) = J$, the cancellation principle [8, Corollary 1.21] yields that

$$\beta_{k,k+4}(J) - \beta_{k,k+4}(\tilde{J}) = \beta_{k+1,k+1+3}(J) - \beta_{k+1,k+1+3}(\tilde{J}).$$
(5)

By virtue of Second Step the right-hand side of (5) is equal to $\binom{j-1}{k+1} - \binom{j-2}{k+1}$. Thus

$$\beta_{k,k+4}(J) = \beta_{k,k+4}(\tilde{J}) + {\binom{j-1}{k+1}} - {\binom{j-2}{k+1}}.$$
(6)

(3.2) We now show the equality

$$\beta_{k,k+4}(I) = \beta_{k,k+4}(\tilde{J}) + \binom{i-1}{k}.$$
(7)

Since $I_{\leq 4} = \tilde{J} + (x_2^2 x_n^2)$, the shot exact sequence

$$0 \longrightarrow \tilde{J} \longrightarrow I_{\leq 4} = \tilde{J} + (x_2^2 x_n^2) \longrightarrow (\tilde{J} + (x_2^2 x_n^2))/\tilde{J} \longrightarrow 0$$

yields the long exact sequence

$$\cdots \longrightarrow [\operatorname{Tor}_{k+1}^{A}(K, (\tilde{J} + (x_{2}^{2}x_{n}^{2}))/\tilde{J})]_{k+1+3}$$
$$\longrightarrow [\operatorname{Tor}_{k}^{A}(K, \tilde{J})]_{k+4} \longrightarrow [\operatorname{Tor}_{k}^{A}(K, I_{\leq 4})]_{k+4} \longrightarrow [\operatorname{Tor}_{k}^{A}(K, (\tilde{J} + (x_{2}^{2}x_{n}^{2}))/\tilde{J})]_{k+4}$$
$$\longrightarrow [\operatorname{Tor}_{k-1}^{A}(K, \tilde{J})]_{k-1+5} \longrightarrow \cdots$$

Since $((\tilde{J} + (x_2^2 x_n^2))/\tilde{J})_3 = 0$, one has $[\operatorname{Tor}_{k+1}^A(K, (\tilde{J} + (x_2^2 x_n^2))/\tilde{J})]_{k+1+3} = 0$. Since the regularity of \tilde{J} is 4, one has $[\operatorname{Tor}_{k-1}^A(K, \tilde{J})]_{k-1+5} = 0$. Thus the above long exact sequence turns out to be

 $0 \longrightarrow [\operatorname{Tor}_{k}^{A}(K,\tilde{J})]_{k+4} \longrightarrow [\operatorname{Tor}_{k}^{A}(K,I_{\leq 4})]_{k+4} \longrightarrow [\operatorname{Tor}_{k}^{A}(K,(\tilde{J}+(x_{2}^{2}x_{n}^{2}))/\tilde{J})]_{k+4} \longrightarrow 0.$ In particular

$$\beta_{k,k+4}(I_{\leq 4})) = \beta_{k,k+4}(\tilde{J}) + \beta_{k,k+4}((\tilde{J} + (x_2^2 x_n^2))/\tilde{J}).$$

Since $\beta_{k,k+4}(I) = \beta_{k,k+4}(I_{\leq 4})$, to show the equality (7), what we must prove is

$$\beta_{k,k+4}((\tilde{J} + (x_2^2 x_n^2))/\tilde{J}) = \binom{i-1}{k}.$$
(8)

Let \tilde{G} denote the ideal generated by those quadratic monomials $x_p x_q$, $1 \le p < q \le n$, with $x_i^2 \le_{\text{lex}} x_p x_q$. A routine computation shows that

$$(\tilde{J} + (x_2^2 x_n^2)) / \tilde{J} \cong x_2^2((\tilde{G} + (x_n^2)) / \tilde{G}).$$

Thus in particular

$$\beta_{k,k+4}((\tilde{J} + (x_2^2 x_n^2))/\tilde{J}) = \beta_{k,k+2}((\tilde{G} + (x_n^2))/\tilde{G}).$$
(9)

Again, the short exact sequence

$$0 \longrightarrow \tilde{G} \longrightarrow \tilde{G} + (x_n^2) \longrightarrow (\tilde{G} + (x_n^2))/\tilde{G} \longrightarrow 0$$

yields the long exact sequence

$$\cdots \longrightarrow [\operatorname{Tor}_{k+1}^{A}(K, (\tilde{G} + (x_{n}^{2}))/\tilde{G})]_{k+1+1}$$

$$\longrightarrow [\operatorname{Tor}_{k}^{A}(K, \tilde{G})]_{k+2} \longrightarrow [\operatorname{Tor}_{k}^{A}(K, (\tilde{G} + (x_{n}^{2}))]_{k+2} \longrightarrow [\operatorname{Tor}_{k-1}^{A}(K, (\tilde{G} + (x_{n}^{2}))/\tilde{G})]_{k+2}$$

$$\longrightarrow [\operatorname{Tor}_{k-1}^{A}(K, \tilde{G})]_{k-1+3} \longrightarrow \cdots .$$

Since $(\tilde{G} + (x_n^2))/\tilde{G})_1 = 0$, one has $[\operatorname{Tor}_{k+1}^A(K, (\tilde{G} + (x_n^2))/\tilde{G})]_{k+1+1} = 0$. Since the regularity of \tilde{G} is 2, one has $[\operatorname{Tor}_{k-1}^A(K, \tilde{G})]_{k-1+3} = 0$. Thus

$$\beta_{k,k+2}((\tilde{G} + (x_n^2))/\tilde{G}) = \beta_{k,k+2}(\tilde{G} + (x_n^2)) - \beta_{k,k+2}(\tilde{G}).$$
(10)

Again, the same computation as in Third Step of the proof of Theorem 2.1 says that

$$\beta_{k,k+2}(\tilde{G} + (x_n^2)) - \beta_{k,k+2}(\tilde{G}) = \binom{i-1}{k}.$$
(11)

The equalities (9) and (10) together with (11) now yield the desired equality (8).

(3.3) The first equality (3) in our claim follows from the equalities (6) and (7). On the other hand, since Gin(I) and J are strongly stable, the second equality (4) in our claim follows from the formula [9, Corollary 3.6 (a)] obtained by Eliahou and Kervaire [7].

(Fourth Step) By virtue of Second Step and Third Step, it follows that

$$\beta_{k,k+3}(I) = \beta_{k,k+3}(\operatorname{Gin}(I)) \quad \text{for all} \quad k \ge j;$$

$$\beta_{k,k+4}(I) = \beta_{k,k+4}(\operatorname{Gin}(I)) \quad \text{for all} \quad k \ge i+1.$$

The cancellation principle [8, Corollary 1.21] then guarantees that

$$\beta_{k,k+5}(I) = \beta_{k,k+5}(\operatorname{Gin}(I)) \quad \text{for all} \quad k \ge i.$$

Since the regularity of each of I and Gin(I) is 5, one has $\beta_k(I) = \beta_k(Gin(I))$ for all $k \ge i + 1$. Again, by virtue of Third Step, it follows that

$$\beta_{i,i+4}(I) = \beta_{i,i+4}(J) < \beta_{i,i+4}(J) + 1 = \beta_{i,i+4}(\operatorname{Gin}(I)).$$

In particular $\beta_i(I) < \beta_i(\operatorname{Gin}(I))$. Hence $\beta_k(I) < \beta_k(\operatorname{Gin}(I))$ for all $k \leq i$.
