# LARGE AND MODERATE DEVIATIONS PRINCIPLES FOR RECURSIVE KERNEL ESTIMATORS OF A MULTIVARIATE DENSITY AND ITS PARTIAL DERIVATIVES

#### Abstract

In this paper we prove large and moderate deviations principles for the recursive kernel estimator of a probability density function and its partial derivatives. Unlike the density estimator, the derivatives estimators exhibit a quadratic behaviour not only for the moderate deviations scale but also for the large deviations one. We provide results both for the pointwise and the uniform deviations.

## 1 Introduction

Let $X_{1}, \ldots, X_{n}$ be a sequence of independent and identically distributed $\mathbb{R}^{d}$-valued random vectors with bounded probability density $f$. Let $\left(h_{n}\right)$ be a positive sequence such that $\lim _{n \rightarrow \infty} h_{n}=0$ and $\sum_{n} h_{n}^{d}=\infty$; the recursive kernel estimator of $f$ is defined as

$$
\begin{equation*}
f_{n}(x)=\frac{1}{n} \sum_{i=1}^{n} \frac{1}{h_{i}^{d}} K\left(\frac{x-X_{i}}{h_{i}}\right) \tag{1}
\end{equation*}
$$

where the kernel $K$ is a continuous function such that $\lim _{\|x\| \rightarrow+\infty} K(x)=0$ and $\int_{\mathbb{R}^{d}} K(x) d x=$ 1. The estimate (1) is a recursive version of the well-known Rosenblatt kernel estimate (see Rosenblatt (1956) and Parzen (1962)); it was first discussed by Wolverton and Wagner (1969), Yamato (1971), and Davies (1973). The estimator (1) is easily updated each time an additionnal observation becomes available without resorting to past data, through the recursive relationship

$$
f_{n}(x)=\frac{n-1}{n} f_{n-1}(x)+\frac{1}{n h_{n}^{d}} K\left(\frac{x-X_{n}}{h_{n}}\right) .
$$

The weak and strong consistency of the recursive estimator of the density was studied by many authors; let us cite, among many others, Devroye (1979), Menon, Prasad and Singh (1984), and Wertz (1985). The law of the iterated logarithm of the recursive density estimator was established by Wegman and Davies (1979) and Roussas (1992). For other works on recursive density estimation, the reader is referred to the papers of Wegman (1972), Ahmad and Lin (1976), and Carroll (1976).

Recently, large and moderate deviations results have been proved for the Rosenblatt density estimator and its derivatives. The large deviations principle has been studied by Louani (1998) and Worms (2001). Gao (2003) and Mokkadem, Pelletier and Worms (2005) extend these results and provide moderate deviations principles. The large and moderate deviations of the derivatives of the Rosenblatt density estimator are given in Mokkadem, Pelletier and Worms (2005). The purpose of this paper is to establish large and moderate deviations principles for the recursive density estimator $f_{n}$ and its derivatives.

Let us recall that a $\mathbb{R}^{m}$-valued sequence $\left(Z_{n}\right)_{n \geq 1}$ satisfies a large deviations principle (LDP) with speed $\left(\nu_{n}\right)$ and good rate function $I$ if:
(a) $\left(\nu_{n}\right)$ is a positive sequence such that $\left(\nu_{n}\right) \uparrow \infty$;
(b) $I: \mathbb{R}^{m} \rightarrow[0, \infty]$ has compact level sets;
(c) for every borel set $B \subset \mathbb{R}^{m}$,

$$
\begin{aligned}
-\inf _{x \in \stackrel{\circ}{B}} I(x) & \leq \liminf _{n \rightarrow \infty} \nu_{n}^{-1} \log \mathbb{P}\left[Z_{n} \in B\right] \\
& \leq \limsup _{n \rightarrow \infty} \nu_{n}^{-1} \log \mathbb{P}\left[Z_{n} \in B\right] \leq-\inf _{x \in \bar{B}} I(x)
\end{aligned}
$$

where $\stackrel{\circ}{B}$ and $\bar{B}$ denote the interior and the closure of $B$ respectively. Moreover, let $\left(v_{n}\right)$ be a nonrandom sequence that goes to infinity; if $\left(v_{n} Z_{n}\right)$ satisfies a LDP, then $\left(Z_{n}\right)$ is said to satisfy a moderate deviations principle (MDP).

For any $d$-uplet $[\alpha]=\left(\alpha_{1}, \ldots, \alpha_{d}\right) \in \mathbb{N}^{d}$, set $|\alpha|=\alpha_{1}+\cdots+\alpha_{d}$, let

$$
\partial^{[\alpha]} f(x)=\frac{\partial^{|\alpha|} f}{\partial x_{1}^{\alpha_{1}} \ldots \partial x_{d}^{\alpha_{d}}}(x)
$$

denote the $[\alpha]$-th partial derivative of $f$ (if $|\alpha|=0$, then $\partial^{[\alpha]} f \equiv f$ ) and, for any $j \in \mathbb{N}$, let $D^{(j)} f$ denote the $j$-th differential of $f$. The recursive kernel estimator of the $[\alpha]$-th partial derivative of $f$ is defined as

$$
\partial^{[\alpha]} f_{n}(x)=\frac{1}{n} \sum_{i=1}^{n} \frac{1}{h_{i}^{d+|\alpha|}} \partial^{[\alpha]} K\left(\frac{x-X_{i}}{h_{i}}\right),
$$

where the kernel $K$ is chosen such that $\partial^{[\alpha]} K \not \equiv 0$ and the bandwidth such that $\sum_{n} h_{n}^{d+2|\alpha|}=$ $\infty$.

Our first aim is to establish pointwise LDP for the recursive kernel density estimator $f_{n}$. It turns out that expliciting the rate function in this case is more complex than either for the Rosenblatt kernel estimator, or for the derivatives estimators. That is the reason why, in this particular framework, we only consider bandwidths defined as $\left(h_{n}\right) \equiv\left(c n^{-a}\right)$ with $c>0$ and $a \in] 0,1 / d\left[\right.$. We then prove that the sequence $\left(f_{n}(x)-f(x)\right)$ satisfies a LDP with speed $\left(\sum_{i=1}^{n} h_{i}^{d}\right)$ and rate function

$$
I_{x}: t \mapsto f(x)(1-a d) I\left(\frac{t}{f(x)(1-a d)}+\frac{1}{1-a d}\right)
$$

where $I(t)$ is the Fenchel-Legendre transform of the function $\psi$ defined as follows:

$$
\psi(u)=\int_{[0,1] \times \mathbb{R}^{d}} s^{-a d}\left(e^{s^{a d} \frac{u}{1-a d} K(z)}-1\right) d s d z
$$

Our second aim is to provide pointwise LDP for the derivative estimators $\partial^{[\alpha]} f_{n}$ (with $|\alpha| \geq 1)$. In this case, we consider more general bandwidths defined as $h_{n}=h(n)$ for all $n$, where $h$ is a regularly varying function with exponent $(-a), a \in] 0,1 /(d+2|\alpha|)[$. We prove that the sequence

$$
\left(\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right)
$$

satisfies a LDP of speed $\left(\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}\right)$ and quadratic rate function $J_{[\alpha]}: \mathbb{R} \rightarrow \mathbb{R}$ defined by

$$
\begin{cases}\text { if } & f(x) \neq 0, \quad J_{[\alpha], x}: t \mapsto \frac{t^{2}\left(1-a^{2}(d+2|\alpha|)^{2}\right)}{2 f(x) \int_{\mathbb{R}^{d}}\left[\partial^{[\alpha]} K(z)\right]^{2} d z}  \tag{2}\\ \text { if } & f(x)=0, \quad J_{[\alpha], x}(0)=0 \quad \text { and } \quad J_{[\alpha], x}(t)=\infty \quad \text { for } \quad t \neq 0 .\end{cases}
$$

Our third aim is to prove pointwise MDP for the density estimator and for its derivatives. For any $d$-uplet $[\alpha]$ such that $|\alpha| \geq 0$, any positive sequence $\left(v_{n}\right)$ satisfying

$$
\lim _{n \rightarrow \infty} v_{n}=\infty \quad \text { and } \quad \lim _{n \rightarrow \infty} \frac{v_{n}^{2}}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}}=0
$$

and general bandwidths $\left(h_{n}\right)$, we prove that the random sequence

$$
v_{n}\left(\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right)
$$

satisfies a LDP of speed $\left(\sum_{i=1}^{n} h_{i}^{d+2|\alpha|} / v_{n}^{2}\right)$ and rate function $J_{[\alpha], x}(\cdot)$ defined by Equation (2).
Finally, we give a uniform version of the previous results. More precisely, let $U$ be a subset of $\mathbb{R}^{d}$; we establish large and moderate deviations principles for the sequence $\left(\sup _{x \in U}\left|\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right|\right)$ in the case either $U$ is bounded or all the moments of $f$ are finite.

## 2 Assumptions and Results

### 2.1 Pointwise LDP for the density estimator

The assumptions required on the kernel $K$ and the bandwidth $\left(h_{n}\right)$ are the following.
(H1) $K: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is a bounded and integrable function, $\int_{\mathbb{R}^{d}} K(z) d z=1$ and $\lim _{\|z\| \rightarrow \infty} K(z)=$ 0.
(H2) $h_{n}=c n^{-a}$ with $0<a<1 / d$ and $c>0$.
Before stating our results, we need to introduce the rate function for the LDP of the density estimator. Let $\psi: \mathbb{R} \rightarrow \mathbb{R}$ and $I: \mathbb{R} \rightarrow \mathbb{R}$ be the functions defined as:

$$
\psi(u)=\int_{[0,1] \times \mathbb{R}^{d}} s^{-a d}\left(e^{s^{a d} \frac{u}{1-a d} K(z)}-1\right) d s d z \quad \text { and } \quad I(t)=\sup _{u \in \mathbb{R}}\{u t-\psi(u)\}
$$

(where $s \in[0,1], z \in \mathbb{R}^{d}$ ) and set

$$
S_{+}=\left\{x \in \mathbb{R}^{d} ; K(x)>0\right\} \quad \text { and } \quad S_{-}=\left\{x \in \mathbb{R}^{d} ; K(x)<0\right\}
$$

The following proposition gives the properties of the functions $\psi$ and $I$; in particular, the behaviour of the rate function $I$, which differs depending on whether $K$ is non-negative or not, is explicited.

Proposition 1 Let $\lambda$ be the Lebesgue measure on $\mathbb{R}^{d}$ and let Assumption (H1) hold.
(i) $\psi$ is strictly convex, twice continuously differentiable on $\mathbb{R}$, and I is a good rate function on $\mathbb{R}$.
(ii) If $\lambda\left(S_{-}\right)=0$, then $I(t)=+\infty$ when $t<0, I(0)=\lambda\left(S_{+}\right) /(1-a d)$, I is strictly convex on $\mathbb{R}$ and continuous on $] 0,+\infty[$, and for any $t>0$

$$
\begin{equation*}
I(t)=t\left(\psi^{\prime}\right)^{-1}(t)-\psi\left(\left(\psi^{\prime}\right)^{-1}(t)\right) \tag{3}
\end{equation*}
$$

(iii) If $\lambda\left(S_{-}\right)>0$, then $I$ is finite and strictly convex on $\mathbb{R}$ and (3) holds for any $t \in \mathbb{R}$.
(iv) In both cases, the strict minimum of $I$ is achieved by $I(1 /(1-a d))=0$.

Remark The following relations are straightforward, and will be used in the sequel:

$$
I(t)=\left\{\begin{array}{lll}
\sup _{u>0}\{u t-\psi(u)\} & \text { if } \quad t>1 /(1-a d)  \tag{4}\\
\sup _{u<0}\{u t-\psi(u)\} & \text { if } t<1 /(1-a d)
\end{array}\right.
$$

We can now state the LDP for the density estimator.

## Theorem 1 (Pointwise LDP for the density estimator)

Let Hypotheses (H1)-(H2) hold and assume that $f$ is continuous at $x$. Then, the sequence $\left(f_{n}(x)-f(x)\right)$ satisfies a LDP with speed $\left(\sum_{i=1}^{n} h_{i}^{d}\right)$ and rate function defined as follows:

### 2.2 Pointwise LDP for the derivatives estimators

Let $[\alpha]$ be a $d$-uplet such that $|\alpha| \geq 1$. To establish pointwise LDP for $\partial^{[\alpha]} f_{n}$, we need the following assumptions.
(H3) $h_{n}=h(n)$ where the function $h$ is locally bounded and varies regularly with exponent $(-a), 0<a<1 /(d+2|\alpha|)$.
(H4) i) $K$ is $|\alpha|$-times differentiable on $\mathbb{R}^{d}$ and $\lim _{\|x\| \rightarrow \infty}\left\|D^{(j)} K(x)\right\|=0$ for any $j \in$ $\{0, \ldots,|\alpha|-1\}$.
ii) $\partial^{[\alpha]} K: \mathbb{R}^{d} \rightarrow \mathbb{R}$ is a bounded and integrable function and $\int_{\mathbb{R}^{d}}\left[\partial^{[\alpha]} K(x)\right]^{2} d x \neq 0$.
(H5) $f$ is $|\alpha|$-times differentiable on $\mathbb{R}^{d}$ and its $j$-th differentials $D^{(j)} f$ are bounded on $\mathbb{R}^{d}$ for any $j \in\{0, \ldots,|\alpha|-1\}$.

Remark A positive (not necessarily monotone) function $L$ defined on $] 0, \infty[$ is slowly varying if $\lim _{t \rightarrow \infty} L(t x) / L(t)=1$; a function $G$ is said to vary regularly with exponent $\rho$, $\rho \in \mathbb{R}$, if and only if there exists a slowly varying function $L$ such that $G(x)=x^{\rho} L(x)$ (see, for example, Feller (1970) page 275). Typical examples of regularly varying functions with exponent $\rho$ are $x^{\rho}, x^{\rho} \log x, x^{\rho} \log \log x, x^{\rho} \log x / \log \log x$, and so on. An important consequence of (H3) which will be used in the sequel is:

$$
\begin{equation*}
\text { if } \beta a<1, \quad \text { then } \quad \lim _{n \rightarrow \infty} \frac{1}{n h_{n}^{\beta}} \sum_{i=1}^{n} h_{i}^{\beta}=\frac{1}{1-a \beta} . \tag{5}
\end{equation*}
$$

Theorem 2 (Pointwise LDP for the derivatives estimators)
Let $|\alpha| \geq 1$ and assume that (H1), (H3)-(H5) hold and that $\partial^{[\alpha]} f$ is continuous at $x$. Then, the sequence $\left(\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right)$ satisfies a LDP with speed $\left(\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}\right)$ and rate function $J_{[\alpha], x}$ defined by (2).

### 2.3 Pointwise MDP for the density estimator and its derivatives

Let $\left(v_{n}\right)$ be a positive sequence; we assume that
(H6) $\lim _{n \rightarrow \infty} v_{n}=\infty$ and $\lim _{n \rightarrow \infty} \frac{v_{n}^{2}}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}}=0$.
(H7) i) There exists an integer $q \geq 2$ such that $\forall s \in\{1, \ldots, q-1\}, \forall j \in\{1, \ldots, d\}$, $\int_{\mathbb{R}^{d}} y_{j}^{s} K(y) d y_{j}=0$, and $\int_{\mathbb{R}^{d}}\left|y_{j}^{q} K(y)\right| d y<\infty$.
ii) $\lim _{n \rightarrow \infty} \frac{v_{n}}{n} \sum_{i=1}^{n} h_{i}^{q}=0$.
iii) $\partial^{[\alpha]} f$ is $q$-times differentiable on $\mathbb{R}^{d}$ and $M_{q}=\sup _{x \in \mathbb{R}^{d}}\left\|D^{q} \partial^{[\alpha]} f(x)\right\|<+\infty$.

Remark When $h_{n}=O\left(n^{-a}\right)$, with $0<a<1 /(d+2|\alpha|)$, (H6) and (H7)ii) hold for instance for $\left(v_{n}\right) \equiv\left(n^{b}\right)$ for any $\left.b \in\right] 0, \min \{a q ;(1-a(d+2|\alpha|)) / 2\}[$.
The following theorem gives the MDP for the density estimator and its derivatives.
Theorem 3 (Pointwise MDP)
When $|\alpha|=0$, let Assumptions (H1), (H2), (H6) and (H7) hold; when $|\alpha| \geq 1$, let (H1), (H3)-(H7) hold. If $\partial^{[\alpha]} f$ is $q$-times differentiable at $x$, then the sequence $\left(v_{n}\left(\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right)\right)$ satisfies a LDP with speed $\left(\sum_{i=1}^{n} h_{i}^{d+2|\alpha|} / v_{n}^{2}\right)$ and good rate function $J_{[\alpha], x}$ defined in (2).

### 2.4 Uniform LDP and MDP for the density estimator and its derivatives

To establish uniform large deviations principles for the density estimator and its derivatives, we need the following additionnal assumptions:
(H8) i) There exists $\xi>0$ such that $\int_{\mathbb{R}^{d}}\|x\|^{\xi} f(x) d x<\infty$.
ii) $f$ is uniformly continuous.
(H9) i) $\partial^{[\alpha]} K$ is Hölder continuous.
ii) There exists $\gamma>0$ such that $z \mapsto\|z\|^{\gamma} \partial^{[\alpha]} K(z)$ is a bounded function.
(H10) $\lim _{n \rightarrow \infty} \frac{v_{n}^{2} \log \left(1 / h_{n}\right)}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}}=0$ and $\lim _{n \rightarrow \infty} \frac{v_{n}^{2} \log v_{n}}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}}=0$.
(H11) i) There exists $\zeta>0$ such that $\int_{\mathbb{R}^{d}}\|z\|^{\zeta}|K(z)| d z<\infty$.
ii) There exists $\eta>0$ such that $z \mapsto\|z\|^{\eta} \partial^{[\alpha]} f(z)$ is a bounded function.

Remark When $h_{n}=O\left(n^{-a}\right)$ with $\left.a \in\right] 0,1 /(d+2|\alpha|)[$, (H10) holds for instance with $\left(v_{n}\right) \equiv\left(n^{b}\right)$ for any $\left.b \in\right] 0,(1-a(d+2|\alpha|)) / 2[$.

Set $U \subseteq \mathbb{R}^{d}$; in order to state in a compact form the uniform large and moderate deviations principles for the density estimator and its derivatives on $U$, we consider the large deviations case as the special case $\left(v_{n}\right) \equiv 1$ and we set:

$$
\begin{aligned}
& g_{U}(\delta)= \begin{cases}\|f\|_{U, \infty}(1-a d) I\left(\frac{1}{1-a d}+\frac{\delta}{\|f\|_{U, \infty}(1-a d)}\right) & \text { if } \quad|\alpha|=0 \quad \text { and } \quad\left(v_{n}\right) \equiv 1 \\
\left.\frac{\delta^{2}\left(1-a^{2}(d+2|\alpha|)^{2}\right)}{2\|f\|_{U, \infty} \int_{\mathbb{R}^{d}}[\partial[\alpha]}\right]^{2}(z) d z & \text { otherwise, }\end{cases} \\
& \tilde{g}_{U}(\delta)=\min \left\{g_{U}(\delta), g_{U}(-\delta)\right\},
\end{aligned}
$$

where $\|f\|_{U, \infty}=\sup _{x \in U}|f(x)|$.

Remark The functions $g_{U}(\cdot)$ and $\tilde{g}_{U}(\cdot)$ are non-negative, continuous, increasing on $] 0,+\infty[$ and decreasing on $]-\infty, 0\left[\right.$, with a unique global minimum in $0\left(\tilde{g}_{U}(0)=g_{U}(0)=0\right)$. They are thus good rate functions (and $g_{U}(\cdot)$ is strictly convex).

Theorem 4 below states uniform LDP and MDP for $\left(\partial^{[\alpha]} f_{n}-\partial^{[\alpha]} f\right)$ on $U$ in the case $U$ is bounded, and Theorem 5 in the case $U$ is unbounded.

## Theorem 4 (Uniform deviations on a bounded set)

In the case $|\alpha|=0$, let (H1), (H2), (H7), (H9)i), and (H10) hold. In the case $|\alpha| \geq 1$, let (H3)-(H5), (H7), (H9)i) and (H10) hold. Moreover, assume either that $\left(v_{n}\right) \equiv 1$ or that $\left(v_{n}\right)$ satisfies (H6). Then for any bounded subset $U$ of $\mathbb{R}^{d}$ and for all $\delta>0$,

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \frac{v_{n}^{2}}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}} \log \mathbb{P}\left[\sup _{x \in U} v_{n}\left|\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right| \geq \delta\right]=-\tilde{g}_{U}(\delta) \tag{6}
\end{equation*}
$$

Theorem 5 (Uniform deviations on an unbounded set)
Let Assumptions (H1), (H7)-(H11) hold. Moreover,

- in the case $|\alpha|=0$ and $\left(v_{n}\right) \equiv 1$, let (H2) hold;
- in the case $|\alpha| \geq 1$ and $\left(v_{n}\right) \equiv 1$, or $|\alpha| \geq 0$ and ( $v_{n}$ ) satisfies (H6), let (H3)-(H5) hold.

Then for any subset $U$ of $\mathbb{R}^{d}$ and for all $\delta>0$,

$$
\begin{aligned}
-\tilde{g}_{U}(\delta) & \leq \liminf _{n \rightarrow \infty} \frac{v_{n}^{2}}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}} \log \mathbb{P}\left[\sup _{x \in U} v_{n}\left|\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right| \geq \delta\right] \\
& \leq \limsup _{n \rightarrow \infty} \frac{v_{n}^{2}}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}} \log \mathbb{P}\left[\sup _{x \in U} v_{n}\left|\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right| \geq \delta\right] \leq-\frac{\xi}{\xi+d} \tilde{g}_{U}(\delta)
\end{aligned}
$$

The following corollary is a straightforward consequence of Theorem 5.

## Corollary 1

Under the assumptions of Theorem 5, if $\int_{\mathbb{R}^{d}}\|x\|^{\xi} f(x) d x<\infty \forall \xi \in \mathbb{R}$, then for any subset $U$ of $\mathbb{R}^{d}$,

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \frac{v_{n}^{2}}{\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}} \log \mathbb{P}\left[\sup _{x \in U} v_{n}\left|\partial^{[\alpha]} f_{n}(x)-\partial^{[\alpha]} f(x)\right| \geq \delta\right]=-\tilde{g}_{U}(\delta) \tag{7}
\end{equation*}
$$

Comment Theorem 4 and Corollary 1 are LDP for the sequence $\left(\sup _{x \in U}\left|f_{n}(x)-f(x)\right|\right)$. As a matter of fact, since the sequence $\left(\sup _{x \in U}\left|f_{n}(x)-f(x)\right|\right)$ is positive and since $\tilde{g}_{U}$ is continuous on $[0,+\infty$ [, increasing and goes to infinity as $\delta \rightarrow \infty$, the application of Lemma 5 in Worms (2001) allows to deduce from (6) or (7) that $\left(\sup _{x \in U}\left|f_{n}(x)-f(x)\right|\right)$ satisfies a LDP with speed $\left(\sum_{i=1}^{n} h_{i}^{d}\right)$ and good rate function $\tilde{g}_{U}$ on $\mathbb{R}_{+}$.

## 3 Proofs

Let $\left(\Psi_{n}^{[\alpha]}\right)$ and $\left(B_{n}^{[\alpha]}\right)$ be the sequences defined as

Theorems 1, 2 and 3 are consequences of (8) and the following propositions.

2. Let $|\alpha| \geq 1$ and assume that (H3), (H4) hold, then the sequence $\left(\Psi_{n}^{[\alpha]}(x)\right)$ satisfies a LDP with speed $\left(\sum_{i=1}^{n} h_{i}^{d+2|\alpha|}\right)$ and rate function $J_{[\alpha], x}$.
3. When $|\alpha|=0$, let Assumptions (H1), (H2) and (H6) hold and when $|\alpha| \geq 1$, let (H3), (H4) and (H6) hold, then the sequence $\left(v_{n} \Psi_{n}^{[\alpha]}(x)\right)$ satisfies a LDP with speed $\left(\sum_{i=1}^{n} h_{i}^{d+2|\alpha|} / v_{n}^{2}\right)$ and rate function $J_{[\alpha], x}$.

## Proposition 3 (Uniform LDP and MDP for $\left(\Psi_{n}^{[\alpha]}\right)$ )

Set $x \in \mathbb{R}^{d}$; since the assumptions of Theorems 1 and 2 guarantee that $\lim _{n \rightarrow \infty} B_{n}^{[\alpha]}(x)=0$, Theorem 1 (respectively Theorem 2) is a straightforward consequence of the application of Part 1 (respectively of Part 2) of Proposition 2. Moreover, under the assumptions of Theorem 3, we have, by application of Part 1 of Proposition $4, \lim _{n \rightarrow \infty} v_{n} B_{n}^{[\alpha]}(x)=0$; Theorem 3 thus straightfully follows from the application of Part 3 of Proposition 2. Finally, Theorems 4 and 5 are obtained by applying Proposition 3 together with the second part of Proposition 4.

We now state a preliminary lemma, which will be used in the proof of Propositions 2 and 3. For any $u \in \mathbb{R}$, set

## 2. (Uniform convergence)

If $f$ is uniformly continuous, then the convergence (9) holds uniformly in $x \in U$.
Our proofs are now organized as follows: Lemma 1 is proved in Section 3.1, Proposition 2 in Section 3.2, Proposition 3 in Section 3.3 and Proposition 4 in Section 3.4. Section 3.5 is devoted to the proof of Proposition 1 on the rate function $I$.

In the case $f$ is continuous, we have $\lim _{n \rightarrow \infty} R_{n, x}^{(4)}(u)=0$ by the dominated convergence theorem.
In the case $f$ is uniformly continuous, set $\varepsilon>0$ and let $M>0$ such that $2\|f\|_{\infty} \int_{\|z\| \geq M}|K(z)| d z<$ $\varepsilon / 2$. We need to prove that for $n$ sufficiently large

Lemma 2 Let $\left(Z_{n}\right)$ be a sequence of real random variables, $\left(\nu_{n}\right)$ a positive sequence satisfying $\lim _{n \rightarrow \infty} \nu_{n}=+\infty$, and suppose that there exists some convex non-negative function $\Gamma$ defined (i.e. finite) on $\mathbb{R}$ such that

If the Legendre transform $\tilde{\Gamma}$ of $\Gamma$ is a strictly convex function, then the sequence $\left(Z_{n}\right)$ satisfies a LDP of speed $\left(\nu_{n}\right)$ and good rate function $\tilde{\Gamma}$.

In our framework, when $|\alpha|=0$ and $v_{n} \equiv 1$, we take $Z_{n}=f_{n}(x)-\mathbb{E}\left(f_{n}(x)\right), \nu_{n}=\sum_{i=1}^{n} h_{i}^{d}$ with $h_{n}=c n^{-a}$ where $0<a<1 / d$ and $\Gamma=\Lambda_{x}^{L}$. In this case, the Legendre transform of $\Gamma=$ $\Lambda_{x}^{L}$ is the rate function $I_{x}: t \mapsto f(x)(1-a d) I\left(\frac{t}{f(x)(1-a d)}+\frac{1}{1-a d}\right)$ which is strictly convex by Proposition 1. Otherwise, we take $Z_{n}=v_{n}\left(\partial^{[\alpha]} f_{n}(x)-\mathbb{E}\left(\partial^{[\alpha]} f_{n}(x)\right)\right), \nu_{n}=\sum_{i=1}^{n} h_{i}^{d+2|\alpha|} / v_{n}^{2}$ and $\Gamma=\Lambda_{x}^{M} ; \tilde{\Gamma}$ is then the quadratic rate function $J_{[\alpha], x}$ defined in (2) and thus Proposition 2 follows.

### 3.3 Proof of Proposition 3

In order to prove Proposition 3, we first establish some lemmas.
Lemma 3 Let $\phi: \mathbb{R}+\rightarrow \mathbb{R}$ be the function defined for $\delta>0$ as

1. $\sup _{u \in \mathbb{R}}\left\{u \delta-\sup _{x \in U} \Lambda_{x}(u)\right\}$ equals $g_{U}(\delta)$ and is achieved for $u=\phi(\delta)>0$.
2. $\sup _{u \in \mathbb{R}}\left\{-u \delta-\sup _{x \in U} \Lambda_{x}(u)\right\}$ equals $g_{U}(-\delta)$ and is achieved for $u=\phi(-\delta)<0$.

## Proof of Lemma 3

We just prove the first part, the proof of the second one being similar. First, let us consider the case $\left(v_{n}\right) \equiv 1$ and $|\alpha|=0$. Since $e^{t} \geq 1+t(\forall t)$, we have $\psi(u) \geq u /(1-a d)$ and therefore,

- In the case either $|\alpha| \geq 1$ and $\left(v_{n}\right) \equiv 1$, or $|\alpha| \geq 0$ and ( $v_{n}$ ) satisfies (H6), let (H1), (H3) and (H4) hold.

Then for any $\delta>0$,

\end{aligned}

Lemma 5 Let Assumptions (H1), (H3), (H4)i), (H9)i) and (H10) hold and assume that either $\left(v_{n}\right) \equiv 1$ or (H6) holds.

1. If $U$ is a bounded set, then, for any $\delta>0$, we have

$B_{i}^{(n)}=\left\{x \in \mathbb{R}^{d} ;\left\|x-y_{i}^{(n)}\right\| \leq R_{n}\right\}$ and such that $N^{\prime}(n) \leq 2\left(\frac{2 w_{n}}{R_{n}}\right)$. Considering only the $N(n)$ balls that intersect $\left\{x \in U ;\|x\| \leq w_{n}\right\}$, we can write

Since this inequality holds for any $\rho \in] 0, \delta[$, Part 2 of Lemma 5 thus follows from the continuity of $\tilde{g}_{U}$.

& +\frac{v_{n}}{n} \sum_{i=1}^{n} \int_{\|z\|>w_{n} / 2} K(z) \partial^{[\alpha]} f\left(x-h_{i} z\right) d z .
\end{aligned}
$$

Set $\rho>0$; on the one hand, we have

\|x\| \geq w_{n} \quad \text { and } \quad\|z\| \leq w_{n} / 2 & \Rightarrow\left\|x-h_{i} z\right\| \geq w_{n}\left(1-h_{i} / 2\right) \\
& \Rightarrow\left\|x-h_{i} z\right\| \geq w_{n} / 2 \text { for } n \text { large enough. }
\end{aligned}

Set $M_{f}=\sup _{x \in \mathbb{R}^{d}}\|x\|^{\eta} \partial^{[\alpha]} f(x)$. Assumption (H11)ii) implies that, for $n$ sufficiently large,

& \leq \frac{\rho}{2}

On the other hand, we note that, in view of assumptions (H10) and (H11)i),

$\Rightarrow\left\|s_{n}\right\| \geq w_{n}$ and $\exists i \in\{1, \ldots, n\}$ such that $\left|\left\|s_{n}\right\|-\left\|X_{i}\right\|\right| \leq\left[\frac{\kappa v_{n} h_{i}^{\gamma-d-|\alpha|}}{\delta-\rho}\right]^{\frac{1}{\gamma}}$

\end{aligned}

and, thanks to assumption (H10), it follows that

& =\frac{1}{n} \sum_{i=1}^{n} h_{i}^{q} \int_{\mathbb{R}^{d}} K(y)\left[\frac{g\left(x-h_{i} y\right)-g(x)-\sum_{j=1}^{q-1} \frac{(-1)^{j}}{j!} h_{i}^{j} D^{j} g(x)\left(y^{(j)}\right)}{h_{i}^{q}}\right] d y . \tag{21}
\end{align*}

Let us set

U_{\infty}(x) & =\frac{(-1)^{q}}{q!} \int_{\mathbb{R}^{d}} D^{q} g(x)\left(y^{(q)}\right) K(y) d y .
\end{aligned}

& \leq 2 \varepsilon .

Since the bracketed term in (21) is bounded by $\sup _{x \in \mathbb{R}^{d}}\left\|D^{q} g(x)\right\|=M_{q}$ (see Assumption (H7)iii)), Part 2 follows.

Since $\psi^{\prime}$ is increasing with range $] 0,+\infty\left[\right.$, when $t>0, \sup _{u}(u t-\psi(u))$ is reached for $u_{0}(t)$ such that $\psi^{\prime}\left(u_{0}(t)\right)=t$, i.e. for $u_{0}(t)=\left(\psi^{\prime}\right)^{-1}(t)$; this prove (3). (Note that, since $\psi^{\prime \prime}(t)>0$, the function $t \mapsto u_{0}(t)$ is differentiable on $] 0,+\infty[$ ). Now, differentiating (3), we have

& =\left(\psi^{\prime}\right)^{-1}(t)+t u_{0}^{\prime}(t)-t u_{0}^{\prime}(t) \\
& =\left(\psi^{\prime}\right)^{-1}(t) .
\end{aligned}
$$

Since $\left(\psi^{\prime}\right)^{-1}$ is an increasing function on $] 0,+\infty[$, it follows that $I$ is strictly convex on ] $0,+\infty$ [ (and differentiable). Thus ( $i i$ ) is proved.
Now, since $\lambda\left(S_{-}\right)=0, \psi^{\prime}(0)=1 /(1-a d)>0$; we have

$$
I^{\prime}(t)=0 \quad \Leftrightarrow \quad\left(\psi^{\prime}\right)^{-1}(t)=0 \quad \Leftrightarrow \quad \psi^{\prime}(0)=t \quad \Leftrightarrow \quad t=1 /(1-a d)
$$

Then $I^{\prime}(1 /(1-a d))=0$, and $I(1 /(1-a d))=0$ is the unique global minimum of $I$ on $] 0,+\infty\left[\right.$. This proves $(i v)$ when $\lambda\left(S_{-}\right)=0$.

- Assume that $\lambda\left(S_{-}\right)>0$. In this case, $\psi^{\prime}$ can be rewritten as

$$
\begin{aligned}
\psi^{\prime}(u)= & \frac{1}{1-a d} \int_{[0,1] \times\left(\mathbb{R}^{d} \cap S_{+}\right)} K(z) e^{s^{a d} \frac{u}{1-a d} K(z)} d s d z \\
& +\frac{1}{1-a d} \int_{[0,1] \times\left(\mathbb{R}^{d} \cap S_{-}\right)} K(z) e^{s^{a d} \frac{u}{1-a d} K(z)} d s d z
\end{aligned}
$$

and we have

$$
\lim _{u \rightarrow-\infty} \psi^{\prime}(u)=-\infty \quad \text { and } \quad \lim _{u \rightarrow+\infty} \psi^{\prime}(u)=+\infty
$$

so that the range of $\psi^{\prime}$ is $\mathbb{R}$ in this case. The proof of (iii) and the case $\lambda\left(S_{-}\right)>0$ of (iv) follows the same lines as previously, except that, in the present case, $\left(\psi^{\prime}\right)^{-1}$ is defined on $\mathbb{R}$, and not only on $] 0,+\infty[$.
